# HÖLDER REGULARITY OF HAMILTON-JACOBI EQUATIONS WITH STOCHASTIC FORCING 

PIERRE CARDALIAGUET ${ }^{1,2}$ AND BENJAMIN SEEGER ${ }^{1,3,4}$


#### Abstract

We obtain space-time Hölder regularity estimates for solutions of first- and second-order HamiltonJacobi equations perturbed with an additive stochastic forcing term. The bounds depend only on the growth of the Hamiltonian in the gradient and on the regularity of the stochastic coefficients, in a way that is invariant with respect to a hyperbolic scaling.


## 1. Introduction

The objective of this paper is to study the Hölder regularity of stochastically perturbed equations of the form

d u+H(D u, x, t) d t=f(x) \cdot d B \tag{1.1}
\end{equation*}
$$

and

$$
\begin{equation*}
d u+F\left(D^{2} u, D u, x, t\right) d t=f(x) \cdot d B \tag{1.2}
\end{equation*}
$$

where $H: \mathbb{R}^{d} \times \mathbb{R}^{d} \times \mathbb{R} \rightarrow \mathbb{R}$ and $F: \mathbb{S}^{d} \times \mathbb{R}^{d} \times \mathbb{R}^{d} \times \mathbb{R} \rightarrow \mathbb{R}$ are coercive in $D u, F$ is degenerate elliptic in $D^{2} u \in \mathbb{S}^{d}, \mathbb{S}^{d}$ is the space of symmetric $d \times d$ matrices, $f \in C_{b}^{2}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right)$, and $B$ is an $m$-dimensional Brownian motion defined over a fixed probability space ( $\Omega, \mathbf{F}, \mathbf{P}$ ).

More precisely, we are interested in the regularizing effect that comes about from the coercivity in the Duvariable. The goal is to show that bounded solutions of (1.1) and (1.2) are locally Hölder continuous with high probability, with a Hölder bound and exponent that are independent of the regularity of $H$ or $F$ in $(x, t)$, or the ellipticity in the $D^{2} u$-variable.

A major motivation for this paper is to study the average long-time, long-range behavior of solutions of (1.1) and (1.2) with the theory of homogenization. Specifically, if $u^{\varepsilon}(x, t):=\varepsilon u(x / \varepsilon, t / \varepsilon)$ for $\varepsilon>0$ and $(x, t) \in \mathbb{R}^{d} \times \mathbb{R}$, then $u^{\varepsilon}$ solves

d u^{\varepsilon}+H\left(D u^{\varepsilon}, \frac{x}{\varepsilon}, \frac{t}{\varepsilon}\right) d t=\varepsilon^{1 / 2} f\left(\frac{x}{\varepsilon}\right) \cdot d B^{\varepsilon} \tag{1.3}
\end{equation*}
$$

or

$$
\begin{equation*}
d u^{\varepsilon}+F\left(\varepsilon D^{2} u^{\varepsilon}, D u^{\varepsilon}, \frac{x}{\varepsilon}, \frac{t}{\varepsilon}\right) d t=\varepsilon^{1 / 2} f\left(\frac{x}{\varepsilon}\right) \cdot d B^{\varepsilon} \tag{1.4}
\end{equation*}
$$

where $B^{\varepsilon}(t):=\varepsilon^{1 / 2} B(t / \varepsilon)$ has the same law as $B$. Observe that the new coefficients

$$
f^{\varepsilon}(x):=\varepsilon^{1 / 2} f(x / \varepsilon)
$$

[^0]which are required to be continuously differentiable in order to make sense of the equation (twice in the case of (1.4) , blow up in $C^{1}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right)$ and $C^{2}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right)$ as $\varepsilon \rightarrow 0$. A major contribution of this paper is to obtain estimates that, although they depend on $\|D f\|_{\infty}$ and $\left\|D^{2} f\right\|_{\infty}$, are bounded independently of $\varepsilon$, and, in fact, the probability tails of the Hölder semi-norms converge to 0 as $\varepsilon \rightarrow 0$.
1.1. Main results. We give two types of results, for both first and second order equations. The first is an interior Hölder estimate for bounded solutions on space-time cylinders. We then use this result to prove an instantaneous Hölder regularization effect for initial value problems with bounded initial data.

For $u$ defined on the cylinder

$$
Q_{1}:=\overline{B_{1}} \times[-1,0]:=\left\{(x, t) \in \mathbb{R}^{d} \times \mathbb{R}:|x| \leq 1,-1 \leq t \leq 0\right\}
$$

we show that $u$ is Hölder continuous on the cylinder $B_{1 / 2} \times[-1 / 2,0]$, given that $u$ is a solution of the appropriate equation, and is nonnegative and has a random upper bound, that is, for some $\mathcal{S}: \Omega \rightarrow[0, \infty)$,

$$
\begin{equation*}
0 \leq u \leq \mathcal{S} \quad \text { in } Q_{1} \tag{1.5}
\end{equation*}
$$

Theorem 1.1. Assume, for some $A>1, q>1$, and $K>0$, that

$$
\begin{gather*}
\frac{1}{A}|p|^{q}-A \leq H(p, x, t) \leq A|p|^{q}+A \quad \text { for all }(p, x, t) \in \mathbb{R}^{d} \times \mathbb{R}^{d} \times[-1,0]  \tag{1.6}\\
f \in C^{1}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right), \quad\|f\|_{\infty}+\|f\|_{\infty} \cdot\|D f\|_{\infty} \leq K \tag{1.7}
\end{gather*}
$$

and $u$ solves (1.1) in $Q_{1}$ and satisfies (1.5). Fix $M>0$ and $p \geq 1$. Then there exist $\alpha=\alpha(A, q)>0$, $\sigma=\sigma(A, q)>0, \lambda_{0}=\lambda_{0}(A, K, M, q)>0$, and $C=C(A, K, M, p, q)>0$ such that, for all $\lambda \geq \lambda_{0}$,

$$
\mathbf{P}\left(\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{1 / 2} \times[-1 / 2,0]} \frac{|u(x, t)-u(\tilde{x}, \tilde{t})|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha /(q-\alpha(q-1))}}>\lambda\right) \leq \mathbf{P}\left((\mathcal{S}-M)_{+}>\lambda^{\sigma}\right)+\frac{C\|f\|_{\infty}^{p}}{\lambda^{\sigma p}}
$$

To state the assumptions for the regularity results for (1.2), we introduce the notation, for any $X \in \mathbb{S}^{d}$,

$$
m_{+}(X):=\max _{|v| \leq 1} v \cdot X v \quad \text { and } \quad m_{-}(X):=\min _{|v| \leq 1} v \cdot X v
$$

That is, $m_{+}(X)$ and $m_{-}(X)$ are, respectively, the largest nonnegative and lowest nonpositive eigenvalue of $X$. Note that, if $F: \mathbb{S}^{d} \rightarrow \mathbb{R}$ is uniformly continuous and degenerate elliptic, then, for some constants $\nu>0$ and $A>0$ and for all $X \in \mathbb{S}^{d}$,

-\nu m_{+}(X)-A \leq F(X) \leq-\nu m_{-}(X)+A
$$

In order for the coercivity in the gradient to dominate the second-order dependence of $F$ at small scales, it is necessary to assume that the growth of $F$ in $D u$ is super-quadratic.

Theorem 1.2. Assume that, for some $A>1, q>2, \nu>0$, and $K>0$,

\begin{gather*}
\left\{\begin{array}{l}
-\nu m_{+}(X)+\frac{1}{A}|p|^{q}-A \leq F(X, p, x, t) \leq-\nu m_{-}(X)+A|p|^{q}+A \\
\text { for all }(X, p, x, t) \in \mathbb{S}^{d} \times \mathbb{R}^{d} \times \mathbb{R}^{d} \times[-1,0],
\end{array}\right.  \tag{1.8}\\
f \in C^{2}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right), \quad \nu+\|f\|_{\infty}+\|f\|_{\infty} \cdot\|D f\|_{\infty}+\nu\|f\|_{\infty}\left\|D^{2} f\right\|_{\infty} \leq K, \tag{1.9}
\end{gather*}
$$

and $u$ solves (1.2) in $Q_{1}$ and satisfies (1.5). Fix $M>0$ and $p \geq 1$. Then there exist $\alpha=\alpha(A, q)>0$, $\sigma=\sigma(A, q)>0, \lambda_{0}=\lambda_{0}(A, K, M, q)>0$, and $C=C(A, K, M, p, q)>0$ such that, for all $\lambda \geq \lambda_{0}$,

$$
\mathbf{P}\left(\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{1 / 2} \times[-1 / 2,0]} \frac{|u(x, t)-u(\tilde{x}, \tilde{t})|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha /(q-\alpha(q-1))}}>\lambda\right) \leq \mathbf{P}\left((\mathcal{S}-M)_{+}>\lambda^{\sigma}\right)+\frac{C\|f\|_{\infty}^{p}}{\lambda^{\sigma p}}
$$

Although the bounds in Theorem 1.1 and 1.2 do depend on the regularity of $f$, the important point is that the dependence is scale-invariant. Indeed, the function $f^{\varepsilon}$ defined by $f^{\varepsilon}(x):=\varepsilon^{1 / 2} f(x / \varepsilon)$ satisfies

$$
\left\|f^{\varepsilon}\right\|_{\infty}=\varepsilon^{1 / 2}\|f\|_{\infty}, \quad\left\|D f^{\varepsilon}\right\|_{\infty}:=\frac{1}{\varepsilon^{1 / 2}}\|D f\|_{\infty}, \quad \text { and } \quad\left\|D^{2} f^{\varepsilon}\right\|_{\infty}=\frac{1}{\varepsilon^{3 / 2}}\left\|D^{2} f\right\|_{\infty}
$$

As a consequence, $f^{\varepsilon}$ satisfies (1.7) and (1.9) with some $K>0$ independent of $\varepsilon$ (the latter because, in (1.8), $\nu$ is replaced with $\varepsilon \nu$ ). This leads to the following scale-invariant estimates for the regularizing effect of (1.3) and (1.4).
Theorem 1.3. For $A>1, M>0$, and $q>1$, assume that

$$
\frac{1}{A}|p|^{q}-A \leq H(p, x, t) \leq A|p|^{q}+A
$$

and $f \in C_{b}^{1}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right)$, and, for $0<\varepsilon<1$, let $u^{\varepsilon}$ be the solution of (1.3) with $\left\|u^{\varepsilon}(\cdot, 0)\right\|_{\infty} \leq M$. Fix $\tau>0, R>0$, and $T>0$. Then there exist $C=C\left(R, \tau, T, A,\|f\|_{C^{1}}, M, q\right)>0, \alpha=\alpha(A, q)>0$, and $\sigma=\sigma(A, q)>0$ such that, for all $\lambda>0$,

$$
\mathbf{P}\left(\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{R} \times[\tau, T]} \frac{\left|u^{\varepsilon}(x, t)-u^{\varepsilon}(\tilde{x}, \tilde{t})\right|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha /(q-\alpha(q-1))}}>C+\lambda\right) \leq \frac{C \varepsilon^{p / 2}}{\lambda^{\sigma p}}
$$

Theorem 1.4. For $A>1, \nu>0, M>0$, and $q>2$, assume that

$$
-\nu m_{+}(X)+\frac{1}{A}|p|^{q}-A \leq F(X, p, x, t) \leq-\nu m_{-}(X)+A|p|^{q}+A
$$

and $f \in C_{b}^{2}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right)$, and, for $0<\varepsilon<1$, let $u^{\varepsilon}$ be the solution of (1.4) with $\left\|u^{\varepsilon}(\cdot, 0)\right\|_{\infty} \leq M$. Fix $\tau>0, R>0$, and $T>0$. Then there exist $C=C\left(\nu, R, \tau, T, A,\|f\|_{C^{2}}, M, q\right)>0, \alpha=\alpha(A, q)>0$, and $\sigma=\sigma(A, q)>0$ such that, for all $\lambda>0$,

$$
\mathbf{P}\left(\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{R} \times[\tau, T]} \frac{\left|u^{\varepsilon}(x, t)-u^{\varepsilon}(\tilde{x}, \tilde{t})\right|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha /(q-\alpha(q-1))}}>C+\lambda\right) \leq \frac{C \varepsilon^{p / 2}}{\lambda^{\sigma p}}
$$

A natural question is whether the methods and results of this paper can be generalized to treat a fixed, deterministic path $B$ that is, say, $\kappa$-Hölder continuous for some $\kappa \in(0,1)$. We strongly suspect that Theorems 1.1 and 1.2 can be adapted to such a setting in a straightforward manner and, in this case, the bounds in (1.7) and (1.9) are replaced by, respectively,

$$
\|f\|_{\infty}+\|f\|_{\infty}^{\kappa}\|D f\|_{\infty}^{1-\kappa} \leq K \quad \text { and } \quad \nu+\|f\|_{\infty}+\|f\|_{\infty}^{\kappa}\|D f\|_{\infty}^{1-\kappa}+\|f\|_{\infty}^{\kappa}\left(\nu\left\|D^{2} f\right\|_{\infty}\right)^{1-\kappa} \leq K
$$

with constants depending additionally on the Hölder semi-norm of $B$. However, our Theorems 1.3 and 1.4 regarding Brownian motion do not immediately follow from such a statement. Indeed, with probability one, Brownian paths are $\kappa$-Hölder continuous if and only if $\kappa<1 / 2$. The function $f^{\varepsilon}(x)=\varepsilon^{1 / 2} f(x / \varepsilon)$, which arises due to the hyperbolic scaling in (1.3) and (1.4) as well as the self-similarity of Brownian motion, then satisfies

$$
\left\|f^{\varepsilon}\right\|_{\infty}^{\kappa}\left\|D f^{\varepsilon}\right\|_{\infty}^{1-\kappa}=\varepsilon^{-(1 / 2-\kappa)}\|f\|_{\infty}\|D f\|_{\infty}
$$

This quantity blows up as $\varepsilon \rightarrow 0$ if $\kappa<1 / 2$. We therefore emphasize that the methods used to prove Theorems 1.1 - 1.4 are really probabilistic in nature, and use features of Brownian paths beyond their almost-sure regularity, in particular, the independence and scaling properties of increments (see Lemmas A. 1 and A. 2 in the appendix).
1.2. Background. The regularizing effects of Hamilton-Jacobi-Bellman equations like

$$
\begin{equation*}
\partial_{t} u+F\left(D^{2} u, D u, x, t\right)=0 \tag{1.10}
\end{equation*}
$$

have been studied by many authors, including Cardaliaguet [2], Cannarsa and Cardaliaguet [1], and Cardaliaguet and Silvestre [3], Chan and Vasseur [4] and Stockols and Vasseur [16]. In these works, under a coercivity assumption on $F$ in the gradient variable (but no regularity condition on $F$ ), bounded solutions are seen
to be Hölder continuous, with estimate and exponents depending only on the growth of the $F$ in $D u$. These results were used to obtain homogenization results for problems set on periodic or stationary-ergodic spatio-temporal media; see, for instance, Schwab [13] and Jing, Souganidis, and Tran [6].

The equations (1.1) and (1.2) do not fit into this framework, due to the singular term on the right-hand side, which is nowhere pointwise-defined. A simple transformation (see Definition 2.1 below) leads to a random equation that is everywhere pointwise-defined of the form (1.10). More precisely, if $u$ solves (1.2) and

$$
\tilde{u}(x, t)=u(x, t)-f(x) \cdot B(t)
$$

then

$$
\partial_{t} \tilde{u}+F\left(D^{2} \tilde{u}+D^{2} f(x) \cdot B(t), D \tilde{u}+D f(x) \cdot B(t), x, t\right)=0
$$

However, this strategy does not immediately yield scale-invariant estimates. Indeed, the transformed equation corresponding to (1.4) is, for $\varepsilon>0$,

$$
\partial_{t} \tilde{u}^{\varepsilon}+F\left(\varepsilon D^{2} \tilde{u}^{\varepsilon}+\frac{1}{\varepsilon^{1 / 2}} D^{2} f\left(\frac{x}{\varepsilon}\right) B^{\varepsilon}(t), D \tilde{u}^{\varepsilon}+\frac{1}{\varepsilon^{1 / 2}} D f\left(\frac{x}{\varepsilon}\right) B^{\varepsilon}(t), \frac{x}{\varepsilon}, \frac{t}{\varepsilon}\right)=0
$$

for which the results in the above references yield estimates that depend on $\varepsilon$.
These issues were considered by Seeger [14] for the equation (1.1) with $H$ independent of $(x, t)$ and convex in $p$. In this paper, we further extend the regularity results from 14 to apply also to second-order equations and with more complicated $(x, t)$-dependence for $F$ and $H$. To do so, we follow [3] and prove that the equations exhibit an improvement of oscillation effect at all sufficiently small scales, which is a consequence only of the structure of the equation. The main difference with [3] is the addition of the random forcing term $f(x) \cdot d B(t)$ which obliges to revisit the analysis of [3] in a substantial way.
1.3. Organization of the paper. In Section 2 we discuss the notion of pathwise viscosity solutions of equations like (1.1) and (1.2), and we present a number of lemmas needed throughout the paper. The interior estimates are proved in Sections 3 and 4 and the results for initial value problems are presented in Section 5. Finally, in Appendix A] we prove some results on controlling certain stochastic integrals.
1.4. Notation. If $a$ and $b$ are real numbers, then we set $a \vee b=\max \{a, b\}, a \wedge b=\min \{a, b\}$ and denote by $\lceil a\rceil$ the smallest integer greater than or equal to $a$. We let $\mathbb{S}^{d}$ be the set of symmetric real matrices of size $d \times d$. We say that a map $F: \mathbb{S}^{d} \rightarrow \mathbb{R}$ is degenerate elliptic if, for $X, Y \in \mathbb{S}^{d}$ with $X \leq Y$, we have $F(X) \geq F(Y)$. Given $H: \mathbb{R}^{d} \rightarrow \mathbb{R}, H^{*}$ is defined for $\alpha \in \mathbb{R}^{d}$ by $H^{*}(\alpha)=\sup _{p \in \mathbb{R}^{d}}\{\alpha \cdot p-\bar{H}(p)\}$. Given a subset $C$ of $\mathbb{R}^{d}$ and $-\infty<t_{0}<t_{1}<\infty, \partial^{*}\left(C \times\left(t_{0}, t_{1}\right)\right)$ denotes the parabolic boundary of $C \times\left(t_{0}, t_{1}\right)$, namely

$$
\partial^{*}\left(C \times\left(t_{0}, t_{1}\right)\right)=\left(C \times\left\{t_{0}\right\}\right) \cup\left(\partial C \times\left(t_{0}, t_{1}\right)\right)
$$

For an open domain $U \subset \mathbb{R}^{N}, U S C(U)$ (respectively $L S C(U)$ ) denotes the space of upper- (respectively lower-) semicontinuous functions on $U$, and $B U C(U)$ is the space of bounded and uniformly continuous functions on $U$. For a bounded function $u: U \rightarrow \mathbb{R}$, we define $\operatorname{osc}_{U} u:=\sup _{U} u-\inf _{U} u$.

## 2. Preliminaries

2.1. Pathwise viscosity solutions. Fix $-\infty<t_{0}<t_{1}<\infty$ and let $U \subset \mathbb{R}^{d} \times\left(t_{0}, t_{1}\right)$ be an open set. For $\zeta \in C\left(\left(t_{0}, t_{1}\right), \mathbb{R}^{m}\right)$, a degenerate elliptic $F \in C\left(\mathbb{S}^{d} \times \mathbb{R}^{d} \times U \times\left(t_{0}, t_{1}\right), \mathbb{R}\right)$, and $f \in C^{2}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right)$, we discuss the meaning of viscosity sub- and super-solutions of the equation

$$
\begin{equation*}
d u+F\left(D^{2} u, D u, x, t\right) d t=f(x) \cdot d \zeta, \quad(x, t) \in U \tag{2.1}
\end{equation*}
$$

The general theory of pathwise viscosity solutions, initiated by Lions and Souganidis [9, 12, 15, covers a wide variety of equations for which $f$ may also depend on $u$ or $D u$. In the case of (2.1), the theory is much more tractable, and solutions are defined through a simple transformation.

Definition 2.1. A function $u \in U S C(U)$ (resp. $u \in L S C(U)$ ) is a sub- (resp. super-) solution of (2.1) if the function $\tilde{u}$ defined, for $(x, t) \in U$, by

$$
\tilde{u}(x, t)=u(x, t)-f(x) \cdot \zeta(t)
$$

is a sub- (resp. super-) solution of the equation

$$
\partial_{t} \tilde{u}+F\left(D^{2} \tilde{u}+D^{2} f(x) \zeta(t), D \tilde{u}+D f(x) \zeta(t), x, t\right)=0, \quad(x, t) \in U .
$$

A solution $u \in C(U)$ is both a sub- and super-solution.

We remark that, if $F$ is independent of $D^{2} u$, then we may take $f \in C^{1}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right)$.
We will often denote the fact that $u$ is a sub- (resp. super-) solution of (2.1), by writing

$$
d u+F\left(D^{2} u, D u, x, t\right) d t \leq f(x) \cdot d \zeta \quad\left(\text { resp. } d u+F\left(D^{2} u, D u, x, t\right) d t \geq f(x) \cdot d \zeta\right)
$$

At times, when it does not cause confusion, we also use the notation

$$
\partial_{t} u+F\left(D^{2} u, D u, x, t\right)=f(x) \cdot \dot{\zeta}(t)
$$

even when $\zeta$ is not continuously differentiable. This will become particularly useful in proofs that involve scaling, in which case the argument of $\dot{\zeta}$ may change.
2.2. Control and differential games formulae. Just as for classical viscosity solutions, some equations allow for representation formulae with the use of the theories of optimal control or differential games. Before we explain this, we give meaning to certain pathwise integrals that come up in the formulae.
Lemma 2.1. Assume that $s<t$ and $f \in C^{0,1}\left([s, t], \mathbb{R}^{m}\right)$. Then the map

$$
C^{1}\left([s, t], \mathbb{R}^{m}\right) \ni \zeta \mapsto \int_{s}^{t} f(r) \cdot \dot{\zeta}(r) d r=\sum_{i=1}^{m} \int_{s}^{t} f^{i}(r) \cdot \dot{\zeta}^{i}(r) d r
$$

extends continuously to $\zeta \in C\left([s, t], \mathbb{R}^{m}\right)$.

Proof. The result is immediate upon integrating by parts, which yields, for $\zeta \in C^{1}\left([s, t], \mathbb{R}^{m}\right)$,

\int_{s}^{t} f(r) \dot{\zeta}(r) d r=f(t) \zeta(t)-f(s) \zeta(s)-\int_{s}^{t} \dot{f}(r) \zeta(r) d r
$$

Lemma 2.2. Assume that $s<t, f \in C_{b}^{1}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right), W:[s, t] \times \mathcal{A} \rightarrow \mathbb{R}$ is a Brownian motion on some probability space $(\mathcal{A}, \mathcal{F}, \mathbb{P}), \alpha, \sigma:[s, t] \times \mathcal{A} \rightarrow \mathbb{R}^{d}$ are bounded and progressively measurable with respect to the filtration of $W, \tau \in[s, t]$ is a $W$-stopping time, and

$$
d X_{r}=\alpha_{r} d r+\sigma_{r} d W \quad \text { for } r \in[s, t]
$$

Then the map

$$

extends continuously to $\zeta \in C\left([s, t], \mathbb{R}^{m}\right)$, and, moreover,

The Itô isometry property implies that

The result follows from the fact that the other terms on the right-hand side of (2.2) are continuous with respect to $\zeta^{i} \in C([s, t])$. The final claim follows upon taking the expectation of both sides of (2.2) and appealing to the optional stopping theorem.

For arbitrary continuous $\zeta$, we freely interchange notations such as

Throughout the paper, $\zeta$ is often taken to be a Brownian motion, defined on a probability space that is independent of $W$.

We now consider some equations for which sub- and super-solutions can be compared from above or below with particular formulae. For convenience, we write the equations backward in time.

We next give formulae for solutions of some Hamilton-Jacobi-Bellman and Hamilton-Jacobi-Isaacs equations.

2.3. Comparison with homogenous equations. We now take $\zeta$ to be a Brownian motion, and we assume that

cannot be used in comparison principle arguments, as would be the case if $B$ belonged to $C^{1}$.
The results given below provide another way to compare solutions of (1.1) and (1.2) with equation that are independent of $x$ and $t$. In the new equations, the forcing term is replaced with a random constant that depends on $f$ only through quantities as in (1.7) and (1.9), at the expense of slightly weakening the coercivity bounds in the gradient variable. The main tool is to use Lemmas A. 1 and A. 2 to control the stochastic integrals that arise from the representation formulae in Lemmas 2.3 and 2.4 .

&\left.+\left(\frac{\varepsilon_{2}}{\varepsilon_{1}}\right)^{q^{\prime}} \int_{-t_{0}}^{\tau} f\left(\varepsilon_{1} X_{r}\right) \cdot \dot{\tilde{B}}\left(-r_{0}+\varepsilon_{2} r\right) d r\right]
\end{align*}
$$

where, as in that lemma, for fixed $(\alpha, \sigma) \in \mathscr{C} \times \mathscr{C}_{\varepsilon_{1}^{-1} \sqrt{2 \varepsilon_{2} \nu}}, X=X^{\alpha, \sigma}$ and $\tau=\tau^{\alpha, \sigma}$ satisfy (2.18) $d X_{r}=\alpha_{r} d r+\sigma_{r} d W_{r} \quad$ for $r \in\left[-t_{0},-t_{1}\right], \quad X_{-t_{0}}=x_{0}, \quad$ and $\quad \tau:=\inf \left\{t \in\left[-t_{0},-t_{1}\right]: X_{\tau} \in \partial \mathcal{C}\right\}$.

We now set

\end{aligned}

The inequality (2.17) now becomes

\geq & \tilde{w}_{-}\left(x_{0},-t_{0}\right)-\frac{\varepsilon_{2}^{q^{\prime}-1+\kappa}}{\varepsilon_{1}^{q^{\prime}}} A\left(1+C_{q} \mathcal{E}\right) .
\end{aligned}
$$

Step 4. We next obtain the upper bound. Lemma 2.4(b) gives

& \left.+\left(\frac{\varepsilon_{2}}{\varepsilon_{1}}\right)^{q^{\prime}} \int_{-t_{0}}^{\tau} f\left(\varepsilon_{1} X_{r}\right) \cdot \dot{\tilde{B}}\left(-r_{0}+\varepsilon_{2} r\right) d r\right]
\end{align*}
$$

where, as in that lemma, for fixed $\alpha \in \mathscr{C}$ and $\beta \in \mathscr{S}_{\varepsilon_{1}^{-1} \sqrt{2 \varepsilon_{2} \nu}}$ with $\sigma=\beta(\alpha), X=X^{\alpha, \sigma}$ and $\tau=\tau^{\alpha, \sigma}$ are as in (2.18). The inequality (2.16) then implies that, for all $\delta \in(0,1)$,

& =\tilde{w}_{+}\left(x_{0},-t_{0}\right)+\frac{\varepsilon_{2}^{q^{\prime}-1+\kappa}}{\varepsilon_{1}^{q^{\prime}}} A\left(1+C_{q}^{\prime} \mathcal{E}\right) .
\end{aligned}
$$

The claimed upper bound for $w$ now follows from another time reversal.

We now introduce some smooth sub- and super-solutions of the homogenous second order equations that arise in the previous result, which will be used in Section 4. The following lemma is proved in [3], in particular, as Lemmas 4.2 and 4.6 and Corollary 4.3.

Lemma 2.7. Let $q>2$ and $A>1$. Then there exist $C=C(q, A, d)>0$ (which can be chosen arbitrarily large), $\nu_{0}=\nu_{0}(q, A, d)>0$ (which can be chosen arbitrarily small), and $\theta_{0}=\theta_{0}(q, A, d)>0$ such that the following hold:
(a) If $\eta>0$,

2.4. Improvement of oscillation. The main tool used in this paper is to establish an improvement of oscillation of solutions on all small scales. The next result explains how this leads to Hölder regularity estimates.

Lemma 2.8. Let $R, \tau, c>0$, assume that $u: B_{R} \times[-\tau, 0]$ satisfies

Proof. Choose $\left(x_{0}, t_{0}\right) \in B_{R-a} \times[-\tau+b, 0]$ and define $v$ as in the statement of the lemma. Then $\operatorname{osc}_{B_{1} \times[-1,0]} v \leq$ 1 , and so an inductive argument implies that

In this section, we prove the regularity results for first order equations. We assume that

Theorem 3.1. Assume (3.1) - (3.4), and let $0<\kappa<1 / 2$ and $M \geq 1$. Then there exists $\alpha=\alpha(\kappa, A, q) \in$ $(0,1), c=c(\kappa, \alpha, q)>0, \lambda_{0}=\lambda_{0}(\kappa, A, K, M, q)>0$ and, for all $p \geq 1, C=C(\kappa, A, K, M, p, q)>0$ such that, for all $\lambda \geq \lambda_{0}$,
$\mathbf{P}\left(\sup _{(x, s),(y, t) \in B_{1 / 2} \times[-1 / 2,0]} \frac{|u(x, s)-u(y, t)|}{|x-y|^{\alpha}+|s-t|^{\alpha /(q-\alpha(q-1))}}>\lambda\right) \leq \mathbf{P}\left((\mathcal{S}-M)_{+}>c \lambda^{1-\alpha / q^{\prime}}\right)+\frac{C\|f\|_{\infty}^{p}}{\lambda^{\kappa(q-\alpha(q-1)) p}}$
Proof. We first specify the parameters that determine the Hölder exponents, which depend only on $\kappa$, $A$, and $q$. Choose $\mu$ so that

Note that $\beta-\alpha=q(1-\alpha)>0$, and (3.7) and (3.8) together imply that $\beta \kappa-\alpha>0$.
We next identify a random scale $\rho$ at which the improvement of oscillation effect is seen. Let $\mathcal{D}$ be the random variable as in Lemma 2.5, set

0 \leq v \leq 1 \text { in } B_{1} \times[-1,0]
\end{array}\right.
$$

Step 2: Induction step. We next show that

\partial_{t} w+A|D w|^{q}+\left(\frac{\varepsilon_{2}}{\varepsilon_{1}}\right)^{q^{\prime}} A \geq\left(\frac{\varepsilon_{2}}{\varepsilon_{1}}\right)^{q^{\prime}} f\left(x_{0}+\varepsilon_{1} x\right) \cdot \dot{B}\left(t_{0}+\varepsilon_{2} t\right), \text { and } \\
0 \leq w \leq 1 \text { in } B_{1} \times[-1,0]
\end{array}\right.
$$

where $\varepsilon_{1}:=\hat{\mathcal{S}} \rho r$ and $\varepsilon_{2}:=\hat{\mathcal{S}} \rho^{q} r^{\beta}$. As a consequence of (3.9), the random variables $\varepsilon_{1}$ and $\varepsilon_{2}$ take values in $(0,1 / 2]$, so that the hypotheses in part (b) of Lemma 2.5 are satisfied. We also compute, using (3.7) and (3.8),

and so, by (3.6),

$$
\begin{aligned}
w_{+}(x, t) & \leq \inf _{y \in B_{2 \mu}}\left\{w(y,-1)+c_{q}(2 A)^{q^{\prime}-1} \frac{|x-y|^{q^{\prime}}}{(t+1)^{q^{\prime}-1}}\right\} \\
& \leq 6^{q^{\prime}} c_{q}(2 A)^{q^{\prime}-1} \mu^{q^{\prime}}+\inf _{y \in B_{2 \mu}} w(y,-1) \\
& \leq 1-4 \theta+2 \theta=1-2 \theta .
\end{aligned}
$$

It follows that $w(x, t) \leq 1-2 \theta+\theta=1-\theta$, and so (3.12) holds in this case.
Case 2. Assume now that

Let $(x, t) \in B_{\mu} \times\left[-\mu^{\beta}, 0\right]$. Then, similarly as in Step 1, Lemma 2.5 gives

If $y \in B_{2 \mu}$ and $s=-1$, then (3.15) implies that

w(y, s)+c_{q}(2 A)^{1-q^{\prime}} \frac{|y-x|^{q^{\prime}}}{(t-s)^{q^{\prime}-1}}-\theta \geq 2 \theta-\theta=\theta
$$

while, if $s \in[-1, t]$ and $y \in \partial B_{2 \mu}$, then $|y-x| \geq \mu$, and so, using (3.6) and the fact that $w \geq 0$,

$$
w(y, s)+c_{q}(2 A)^{1-q^{\prime}} \frac{|y-x|^{q^{\prime}}}{(t-s)^{q^{\prime}-1}}-\theta \geq-\theta+c_{q}(2 A)^{1-q^{\prime}} \mu^{q^{\prime}} \geq \theta
$$

Either way, it is evident that (3.13) holds.
Combining (3.12) and (3.13) with the definition of $\alpha$ in (3.7), we obtain

$$
\underset{Q_{\mu}}{\operatorname{osc}} w \leq 1-\theta \leq \mu^{\alpha},
$$

which, after rescaling back to $v$, yields

$$
\underset{Q_{\mu r}}{\operatorname{osc} v \leq(\mu r)^{\alpha} .}
$$

Step 3: the Hölder estimate. We now invoke Lemma 2.8 with the values

a:=\rho \hat{\mathcal{S}}, \quad b:=\rho^{q} \hat{\mathcal{S}}, \quad \text { and } \quad c:=\hat{\mathcal{S}}
$$

and, using (3.5) and (3.9), we get, for some constant $C_{1}=C_{1}(\kappa, A, q)>0$,

$$
\begin{aligned}
\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{1 / 2} \times[-1 / 2,0]} \frac{|u(x, t)-u(\tilde{x}, \tilde{t})|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha / \beta}} & \leq \frac{c}{\mu^{\alpha}}\left(\frac{1}{a^{\alpha}} \vee \frac{1}{b^{\alpha / \beta}}\right)=\frac{1}{\mu^{\alpha}}\left(\frac{\hat{\mathcal{S}}^{1-\alpha}}{\rho^{\alpha}} \vee \frac{\hat{\mathcal{S}}^{1-\alpha / \beta}}{\rho^{q \alpha / \beta}}\right) \\
& \leq \frac{1}{\mu^{\alpha}}\left(\frac{1}{2^{1-\alpha} \rho} \vee \frac{1}{2^{1-\alpha / \beta} \rho^{1+(q-1) \alpha / \beta}}\right) \leq C_{1} \rho^{-q / \beta}
\end{aligned}
$$

In view of (3.6) and (3.9), for some $C_{2}=C_{2}(\kappa, A, q)>0$,

$$
\rho^{-q / \beta}=(2 \hat{\mathcal{S}})^{q / \beta} \vee\left(\frac{A \mathcal{D}}{\theta}\right)^{\frac{1}{\kappa \beta}} \leq C_{2}\left(\hat{\mathcal{S}}^{q / \beta}+\mathcal{D}^{\frac{1}{\kappa \beta}}\right)
$$

Since $M$ is chosen to be larger than 1 , we have $(\hat{\mathcal{S}}-M)_{+}=(\mathcal{S}-M)_{+}$, and so, for some $C_{3}=C_{3}(\kappa, A, q)>0$,

$$
\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{1 / 2} \times[-1 / 2,0]} \frac{|u(x, t)-u(\tilde{x}, \tilde{t})|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha / \beta}} \leq C_{3}\left(M^{q / \beta}+(\mathcal{S}-M)_{+}^{q / \beta}+\mathcal{D}^{\frac{1}{\kappa \beta}}\right) .
$$

Therefore, for any $\lambda>0$,

$$
\begin{aligned}
& \mathbf{P}\left(\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{1 / 2} \times[-1 / 2,0]} \frac{|u(x, t)-u(\tilde{x}, \tilde{t})|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha / \beta}}>\lambda\right) \\
& \quad \leq \mathbf{P}\left((\mathcal{S}-M)_{+}^{q / \beta}+\mathcal{D}^{\frac{1}{\kappa \beta}}>\frac{\lambda-C_{3} M^{q / \beta}}{C_{3}}\right) \\
& \quad \leq \mathbf{P}\left((\mathcal{S}-M)_{+}^{q / \beta}>\frac{\lambda-C_{3} M^{q / \beta}}{2 C_{3}}\right)+\mathbf{P}\left(\mathcal{D}^{\frac{1}{\kappa \beta}}>\frac{\lambda-C_{3} M^{q / \beta}}{2 C_{3}}\right) .
\end{aligned}
$$

Taking $\lambda>2 C_{3} M^{q / \beta}$ yields

$$
\frac{\lambda-C_{3} M^{q / \beta}}{2 C_{3}}>\frac{\lambda}{4 C_{3}}
$$

so that

$$
\mathbf{P}\left(\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{1 / 2} \times[-1 / 2,0]} \frac{\mid u(x, t)-u(\tilde{x}, \tilde{t} \mid}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha / \beta}}>\lambda\right) \leq \mathbf{P}\left((\mathcal{S}-M)_{+}^{q / \beta}>\frac{\lambda}{4 C_{3}}\right)+\mathbf{P}\left(\mathcal{D}^{\frac{1}{\kappa \beta}}>\frac{\lambda}{4 C_{3}}\right) .
$$

Finally, if $\lambda_{0}$ is as in Lemma 2.5, then further taking $\lambda>4 C_{3} \lambda_{0}^{1 /(\kappa \beta)}$ yields the claim in view of the properties of $\mathcal{D}$.

## 4. Second order equations

We now turn to the case of second order equations. We let $B$ be a Brownian motion as in (3.1), and, for fixed

f \in C^{2}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right) \quad \text { and } \quad \nu+\|f\|_{\infty}+\|f\|_{\infty}\|D f\|_{\infty}+\nu\|f\|_{\infty}\left\|D^{2} f\right\|_{\infty} \leq K \tag{4.2}
\end{equation*}
$$

and

$$
\left\{\begin{array}{l}
d u+\left[-\nu m_{+}\left(D^{2} u\right)+\frac{1}{A}|D u|^{q}-A\right] d t \leq \sum_{i=1}^{m} f^{i}(x) \cdot d B^{i}(t),  \tag{4.3}\\
d u+\left[-\nu m_{-}\left(D^{2} u\right)+A|D u|^{q}+A\right] d t \geq \sum_{i=1}^{m} f^{i}(x) \cdot d B^{i}(t), \quad \text { and } \\
0 \leq u \leq \mathcal{S} \quad \text { in } B_{1} \times[-1,0] .
\end{array}\right.
$$

Theorem 4.1. Assume (3.1) and (4.1) - (4.3), and let $0<\kappa<1 / 2$ and $M \geq 1$. Then there exists $\alpha=\alpha(\kappa, A, q) \in(0,1), c=c(\kappa, \alpha, q)>0, \lambda_{0}=\lambda_{0}(\kappa, A, K, M, q)>0$, and, for all $p \geq 1, C=$ $C(\kappa, A, K, M, p, q)>0$ such that, for all $\lambda \geq \lambda_{0}$,

$$
\begin{aligned}
& \mathbf{P}\left(\sup _{(x, s),(y, t) \in B_{1 / 2} \times[-1 / 2,0]} \frac{|u(x, s)-u(y, t)|}{|x-y|^{\alpha}+|s-t| \alpha^{\alpha /(q-\alpha(q-1))}}>\lambda\right) \\
& \quad \leq \mathbf{P}\left((\mathcal{S}-M)_{+}>c \lambda^{1-\alpha / q^{\prime}}\right)+C \frac{\|f\|_{\infty}^{p}}{\lambda^{\kappa(q-\alpha(q-1)) p}} .
\end{aligned}
$$

Proof. We set up the various parameters similarly as in the proof of Theorem 3.1 with a few changes to account for the second order terms.

We first choose $\mu$ such that

where $\theta_{0}=\theta_{0}(q, A, d)>0$ is as in Lemma 2.7
Set

$$
\begin{equation*}
\alpha:=\min \left\{\frac{q-2}{q-1}, \frac{\log (1-\theta)}{\log \mu}, \frac{\kappa q}{\kappa q+1-\kappa}\right\} \tag{4.6}
\end{equation*}
$$

and

$$
\begin{equation*}
\beta=q-\alpha(q-1) . \tag{4.7}
\end{equation*}
$$

Observe that (4.6) and (4.7) together imply that

1-\theta \leq \mu^{\alpha}, \quad \beta-\alpha=q(1-\alpha), \quad \beta \kappa-\alpha \geq 0, \quad \text { and } \quad \beta \geq 2
$$

As in the proof of Theorem 3.1, we define, for $\left(x_{0}, t_{0}\right) \in \mathbb{R}^{d} \times \mathbb{R}$,

Q_{r}\left(x_{0}, t_{0}\right):=B_{r}\left(x_{0}\right) \times\left[t_{0}-r^{\beta}, t_{0}\right] \quad \text { and } \quad Q_{r}:=Q_{r}(0,0)
$$

We now set

\hat{\mathcal{S}}:=\mathcal{S} \vee 1,
$$

and, for $\mathcal{E}$ the random variable from Lemma 2.6, and $C$ and $\nu_{0}$ the values from Lemma 2.7 the random variable $\rho$ is the largest value such that

$$
\left\{\begin{array}{l}
(a) \quad 0<\rho \leq \frac{1}{2 \hat{\mathcal{S}}}  \tag{4.8}\\
\text { (b) } \rho^{\kappa q} A \mathcal{E} \leq \theta, \\
(c) \quad 2^{q^{\prime}-1} C K^{q^{\prime} / 2} \nu_{0}^{-q^{\prime} / 2} \rho^{q^{\prime}(q-2) / 2} \leq \theta, \text { and } \\
(d) \quad C \rho^{q-2} \leq 4 \mu^{2}
\end{array}\right.
$$

Step 1: The initial zoom-in. Fix $\left(x_{0}, t_{0}\right) \in B_{1 / 2} \times[-1 / 2,0]$ and set

v(x, t):=\frac{u\left(x_{0}+\rho \hat{\mathcal{S}} x, t_{0}+\rho^{q} \hat{\mathcal{S}} t\right)}{\hat{\mathcal{S}}}
$$

which is well-defined for $(x, t) \in B_{1} \times[-1,0]$ in view of (4.8)(a). Then $v$ satisfies

\left\{\begin{array}{l}
\partial_{t} v-\frac{\nu \rho^{q-2}}{\hat{\mathcal{S}}} m_{-}\left(D^{2} v\right)+A|D v|^{q}+\rho^{q} A \geq \rho^{q} f\left(x_{0}+\rho \hat{\mathcal{S}} x\right) \cdot \dot{B}\left(t_{0}+\rho^{q} \hat{\mathcal{S}} t\right)  \tag{4.9}\\
\partial_{t} v-\frac{\nu \rho^{q-2}}{\hat{\mathcal{S}}} m_{+}\left(D^{2} v\right)+\frac{1}{A}|D v|^{q}-\rho^{q} A \leq \rho^{q} f\left(x_{0}+\rho \hat{\mathcal{S}} x\right) \cdot \dot{B}\left(t_{0}+\rho^{q} \hat{\mathcal{S}} t\right), \quad \text { and } \\
0 \leq v \leq 1 \text { in } B_{1} \times[-1,0]
\end{array}\right.
$$

Step 2: Induction step. We next show that

$$
\begin{equation*}
\text { if } 0<r \leq 1 \quad \text { and } \quad \underset{Q_{r}}{\operatorname{osc} v} \leq r^{\alpha}, \quad \text { then } \quad \underset{Q_{\mu r}}{\operatorname{OSc} v} \leq(\mu r)^{\alpha} . \tag{4.10}
\end{equation*}
$$

Let $r \in(0,1]$ be such that $\operatorname{osc}_{Q_{r}} v \leq r^{\alpha}$. We then set

w(x, t):=\frac{v\left(r x, r^{\beta} t\right)-\inf _{Q_{r}} v}{r^{\alpha}} \quad \text { for }(x, t) \in B_{1} \times[-1,0]
$$

which satisfies

$$
\left\{\begin{array}{l}
\partial_{t} w-\frac{\varepsilon_{2}}{\varepsilon_{1}^{2}} \nu m_{+}\left(D^{2} w\right)+\frac{1}{A}|D w|^{q}-\left(\frac{\varepsilon_{2}}{\varepsilon_{1}}\right)^{q^{\prime}} A \leq\left(\frac{\varepsilon_{2}}{\varepsilon_{1}}\right)^{q^{\prime}} f\left(x_{0}+\varepsilon_{1} x\right) \cdot \dot{B}\left(t_{0}+\varepsilon_{2} t\right) \\
\partial_{t} w-\frac{\varepsilon_{2}}{\varepsilon_{1}^{2}} \nu m_{-}\left(D^{2} w\right)+A|D w|^{q}+\left(\frac{\varepsilon_{2}}{\varepsilon_{1}}\right)^{q^{\prime}} A \geq\left(\frac{\varepsilon_{2}}{\varepsilon_{1}}\right)^{q^{\prime}} f\left(x_{0}+\varepsilon_{1} x\right) \cdot \dot{B}\left(t_{0}+\varepsilon_{2} t\right), \text { and } \\
0 \leq w \leq 1 \text { in } B_{1} \times[-1,0]
\end{array}\right.
$$

where $\varepsilon_{1}:=\hat{\mathcal{S}} \rho r$ and $\varepsilon_{2}:=\hat{\mathcal{S}} \rho^{q} r^{\beta}$. It is a consequence of (4.8)(a) that $\varepsilon_{1}, \varepsilon_{2} \in(0,1 / 2]$, and, moreover, just as in the proof of Theorem 3.1] using the fact that $\beta \kappa \geq \alpha$,

\frac{\varepsilon_{2}^{q^{\prime}-1+\kappa}}{\varepsilon_{1}^{q^{\prime}}} \leq \rho^{\kappa q}
$$

To prove (4.10), we show that either

We consider the two following cases:
Case 1. Assume first that

$$

where

$$
\begin{cases}\partial_{t} w_{+}-\frac{\varepsilon_{2}}{\varepsilon_{1}^{2}} \nu m_{+}\left(D^{2} w_{+}\right)+\frac{1}{2 A}\left|D w_{+}\right|^{q}=0 & \text { in } B_{2 \mu} \times(-1,0] \text { and }  \tag{4.13}\\ w_{+}=w & \text { on } \partial^{*}\left(B_{2 \mu} \times[-1,0]\right)\end{cases}
$$

Note that, by the maximum principle, we have $0 \leq w_{+} \leq 1$. Let $C \geq 4^{q^{\prime}}$ and $\nu_{0}$ be as in Lemma 2.7. and, for $y \in B_{2 \mu}$ and $(x, t) \in B_{2 \mu} \times[-1,0]$, set

w_{y}(x, t):=w(y,-1)+\frac{C}{(t+1)^{q^{\prime}-1}}\left(|x-y|^{2}+\frac{K \rho^{q-2}}{\nu_{0}}(t+1)\right)^{q^{\prime} / 2}
$$

We compute

\frac{\varepsilon_{2}}{\varepsilon_{1}^{2}} \nu=\frac{\rho^{q-2} r^{\beta-2} \nu}{\hat{\mathcal{S}}} \leq \nu \rho^{q-2} \leq\left(\frac{K \rho^{q-2}}{\nu_{0}}\right) \nu_{0}
$$

and therefore, by Lemma 2.7(a), $w_{y}$ is a super-solution of (4.13). In addition,

w_{y}(x,-1)= \begin{cases}+\infty & \text { if } x \neq y \\ w(y,-1) & \text { if } x=y\end{cases}
$$

and, for any $(x, t) \in \partial B_{1} \times[-1,0]$,

w_{y}(x, t) \geq C\left((1-2 \mu)^{2}\right)^{\frac{q^{\prime}}{2}} \geq C 4^{-q^{\prime}} \geq 1 \geq w_{+}(x, t)
$$

in view of the choice of $C \geq 4^{q^{\prime}}$ and of $\mu<1 / 4$. So $w_{y} \geq w_{+}$in $B_{1} \times[-1,0]$ by the comparison principle. Because $\hat{t} \in\left[-\mu^{\beta}, 0\right]$, it follows that $1+\hat{t}>1-\mu^{\beta}>\frac{1}{2}$, and so, by (4.5) and (4.8) (c),

w_{+}(\hat{x}, \hat{t}) & \leq \inf _{y \in B_{2 \mu}}\left\{w(y,-1)+\frac{C}{(\hat{t}+1)^{q^{\prime}-1}}\left(|\hat{x}-y|^{2}+\frac{K \rho^{q-2}}{\nu_{0}}(\hat{t}+1)\right)^{q^{\prime} / 2}\right\} \\
& \leq \frac{1}{2} 6^{q^{\prime}} C \mu^{q^{\prime}}+2^{q^{\prime}-1} C K^{q^{\prime} / 2} \nu_{0}^{-q^{\prime} / 2} \rho^{q^{\prime}(q-2) / 2}+\inf _{y \in B_{2 \mu}} w(y,-1) \\
& \leq 1-5 \theta+\theta+2 \theta=1-2 \theta
\end{aligned}
$$

We conclude that $w(\hat{x}, \hat{t}) \leq 1-2 \theta+\theta=1-\theta$, so that (4.11) holds in this case.
Case 2. We now assume that

\inf _{y \in B_{2 \mu}} w(y,-1)>2 \theta
$$

Fix $(\hat{x}, \hat{t}) \in B_{\mu} \times\left[-\mu^{\beta}, 0\right]$. As in Step 1, Lemma 2.6 gives

w(\hat{x}, \hat{t}) \geq w_{-}(\hat{x}, \hat{t})-\theta
$$

where

$$
\begin{cases}\partial_{t} w_{-}-\frac{\varepsilon_{2}}{\varepsilon_{1}^{2}} \nu m_{-}\left(D^{2} w_{-}\right)+2 A\left|D w_{-}\right|^{q}=0 & \text { in } B_{2 \mu} \times(-1,0] \text { and }  \tag{4.14}\\ w_{-}=w & \text { on } \partial^{*}\left(B_{2 \mu} \times[-1,0]\right)\end{cases}
$$

For $(x, t) \in B_{2 \mu} \times[-1,0]$ and for $b$ and $C$ as in Lemma 2.7(b), define

$$
V(x, t)=3 \theta b\left(\frac{|x|}{2 \mu}+\frac{t+1}{4}\right)-\frac{C \rho^{q-2} \theta}{4 \mu^{2}}(t+1)
$$

Then, by (4.5) and Lemma 2.7(b), $V$ is a sub-solution of (4.14). In addition,

$$
V \leq 0 \quad \text { on } \partial B_{2 \mu} \times[-1,0] \quad \text { and } \quad V \leq 2 \theta \quad \text { on } B_{2 \mu} \times\{-1\}
$$

and so $V \leq w_{-}$on $\partial^{*}\left(B_{2 \mu} \times[-1,0]\right)$. The comparison principle now implies that $V \leq w_{-}$in all of $B_{2 \mu} \times[-1,0]$, and, in particular, using (4.8) (d) and the fact that $b(3 / 4)=1$ and $b$ is nonincreasing,

$$

Thus, in this case, (4.12) holds.
Whether (4.11) or (4.12) is satisfied, we have

Step 3: the Hölder estimate. As in the proof of Theorem 3.1. we use Lemma 2.8 and (4.8) (a) to conclude that, for some $C_{1}=C_{1}(\kappa, A, q)>0$,

\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{1 / 2} \times[-1 / 2,0]} \frac{|u(x, t)-u(\tilde{x}, \tilde{t})|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha / \beta}} \leq C_{1} \rho^{-q / \beta}
$$

All of the parts of (4.8) imply that, for some $C_{2}=C_{2}(\kappa, A, q)>0$ and $C_{3}=C_{3}(\kappa, A, K, q)>0$,

$$
\rho^{-q / \beta} \leq \tilde{C}_{2}\left(\hat{\mathcal{S}}^{q / \beta}+\mathcal{E}^{1 /(\kappa \beta)}\right)+C_{3}
$$

and the rest of the proof follows as in the proof of Theorem 3.1 and the properties of $\mathcal{E}$ outlined in Lemma 2.6

## 5. Applications

In this section, we show how Theorems 3.1 and 4.1 can be used to prove a regularizing effect for certain initial value problems. Moreover, the regularity estimates are independent of a certain large-range, long-time scaling, which is useful in the theory of homogenization.

We fix a finite time horizon $T>0$ and an initial condition

$$
\begin{equation*}
u_{0} \in B U C\left(\mathbb{R}^{d}\right) \tag{5.1}
\end{equation*}
$$

The uniform continuity of $u_{0}$ ensures the well-posedness of the equations below, but we note that the regularizing effects we prove depend only on $\left\|u_{0}\right\|_{\infty}$.

Throughout,

$$
\begin{equation*}
B:[0, T] \times \Omega \rightarrow \mathbb{R}^{m} \quad \text { is a Brownian motion over a probability space }(\Omega, \mathbf{F}, \mathbf{P}) \tag{5.2}
\end{equation*}
$$

We first consider equations of first order, and we assume that, for some $A>1$ and $q>1$,

$$
\left\{\begin{array}{l}
H \in C\left(\mathbb{R}^{d} \times \mathbb{R}^{d} \times[0, \infty)\right) \text { satisfies }  \tag{5.3}\\
\frac{1}{A}|p|^{q}-A \leq H(p, x, t) \leq A|p|^{q}+A \quad \text { for all }(p, x, t) \in \mathbb{R}^{d} \times \mathbb{R}^{d} \times[0, T],
\end{array}\right.
$$

and

$$
\begin{equation*}
f \in C_{b}^{1}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right) \tag{5.4}
\end{equation*}
$$

For $0<\varepsilon<1$, we consider solutions of the scaled, forced equation

$$
\begin{equation*}
d u^{\varepsilon}+H\left(D u^{\varepsilon}, \frac{x}{\varepsilon}, \frac{t}{\varepsilon}\right) d t=\varepsilon^{1 / 2} \sum_{i=1}^{m} f^{i}\left(\frac{x}{\varepsilon}\right) \cdot d B^{i}(t) \quad \text { in } \mathbb{R}^{d} \times(0, T] \quad \text { and } \quad u^{\varepsilon}(\cdot, 0)=u_{0} \quad \text { on } \mathbb{R}^{d}, \tag{5.5}
\end{equation*}
$$

and we prove the following result:
Theorem 5.1. Assume (5.1) - (5.4), and, for $0<\varepsilon \leq 1$, let $u^{\varepsilon}$ be the solution of (5.5). Fix $p \geq 1, \tau>0$ and $R>0$. Then there exist $C=C\left(R, \tau, T, A,\|f\|_{C^{1}},\|u\|_{\infty}, p, q\right)>0, \alpha=\alpha(A, q)>0$, and $\sigma=\sigma(A, q)>0$ such that, for all $\lambda>0$,

$$
\mathbf{P}\left(\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{R} \times[\tau, T]} \frac{\left|u^{\varepsilon}(x, t)-u^{\varepsilon}(\tilde{x}, \tilde{t})\right|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha /(q-\alpha(q-1))}}>C+\lambda\right) \leq \frac{C \varepsilon^{p / 2}}{\lambda^{\sigma p}} .
$$

Proof. We first note that we can assume, without loss of generality, that $\tau>1 / 2$. Indeed, otherwise, we consider the function

$$
\tilde{u}^{\varepsilon}(x, t):=\frac{1}{2 \tau} u^{\varepsilon}(2 \tau x, 2 \tau t) \quad \text { for }(x, t) \in \mathbb{R}^{d} \times\left[0, \frac{T}{2 \tau}\right],

which solves

d \tilde{u}^{\varepsilon}+\tilde{H}\left(D \tilde{u}^{\varepsilon}, \frac{x}{\varepsilon}, \frac{t}{\varepsilon}\right) d t=\varepsilon^{1 / 2} \sum_{i=1}^{m} \tilde{f}^{i}\left(\frac{x}{\varepsilon}\right) \cdot d \tilde{B}^{i}(t) \quad \text { in } \mathbb{R}^{d} \times\left(0, \frac{T}{2 \tau}\right) \quad \text { and } \quad \tilde{u}^{\varepsilon}(\cdot, 0)=\tilde{u}_{0} \quad \text { on } \mathbb{R}^{d},
$$

where, for $(p, x, t) \in \mathbb{R}^{d} \times \mathbb{R}^{d} \times\left[0, \frac{T}{2 \tau}\right]$,

$$
\tilde{H}(p, x, t):=H(p, 2 \tau x, 2 \tau t), \quad \tilde{u}_{0}(x)=\frac{1}{2 \tau} u_{0}(2 \tau x), \quad \tilde{f}(x)=\frac{1}{\sqrt{2 \tau}} f(2 \tau x), \quad \text { and } \quad \tilde{B}(t)=\frac{1}{\sqrt{2 \tau}} B(2 \tau t) .
$$

Then $\tilde{H}$ satisfies (5.3) with $A$ and $q$ unchanged, and $\tilde{B}$ is a Brownian motion on $[0,2 \tau T]$. As a consequence, $\alpha=\alpha(A, q)>0$ remains unchanged, and the $\tau$-dependence can be absorbed into $R, T,\|f\|_{C^{1}}$, and $\left\|u_{0}\right\|_{\infty}$.

Crucially, if $f^{\varepsilon}(x):=\varepsilon^{1 / 2} f(x / \varepsilon)$, then

$$
\left\|f^{\varepsilon}\right\|_{\infty}=\varepsilon^{1 / 2}\|f\|_{\infty} \quad \text { and } \quad\left\|f^{\varepsilon}\right\|_{\infty}\left\|D f^{\varepsilon}\right\|_{\infty}=\|f\|_{\infty}\|D f\|_{\infty}
$$

As a consequence, we may choose a fixed constant $K>0$ such that the conclusions of Lemma 2.5 and Theorem 3.1 hold with the function $f^{\varepsilon}$, for all $\varepsilon \in(0,1]$.
In what follows, we fix $0<\kappa<\frac{1}{2}$.
Step 1: $u$ is bounded. We first use Lemma [2.5 to describe the $L^{\infty}$-bound for $u$ on $\mathbb{R}^{d} \times[0, T]$. In view of (5.3), Lemma 2.5) with $\varepsilon_{1}=\varepsilon_{2}=1, R=+\infty$, and $\mathcal{C}=\mathbb{R}^{d}$ gives

u^{\varepsilon}(x, t) \leq u_{+}(x, t)+A \mathcal{D}_{1} \quad \text { on } \mathbb{R}^{d} \times[0,1],

where, for some $\lambda_{1}=\lambda_{1}\left(\kappa,\|f\|_{C^{1}}, q\right)>0$ and, given $p \geq 1$, some $C=C\left(\kappa,\|f\|_{C^{1}}, p, q\right)>0$,

$$
\mathbf{P}\left(D_{1}>\lambda\right) \leq \frac{C \varepsilon^{p / 2}}{\lambda^{p}} \quad \text { for all } \lambda \geq \lambda_{1}
$$

and

$$
\partial_{t} u_{+}+\frac{1}{2 A}\left|D u_{+}\right|^{q}=0 \quad \text { on } \mathbb{R}^{d} \times[0,1], \quad \text { and } u_{+}(\cdot, 0)=u_{0} \quad \text { on } \mathbb{R}^{d} .
$$

The comparison principle yields $u_{+}(x, t) \leq\left\|u_{0}\right\|_{\infty}$. It follows that

u^{\varepsilon}(x, t) \leq\left\|u_{0}\right\|_{\infty}+C\left(1+\mathcal{D}_{1}\right) \quad \text { on } \mathbb{R}^{d} \times[0,1]
$$

Set $N:=\lceil T\rceil$. An inductive argument then gives random variables $\mathcal{D}_{2}, \mathcal{D}_{3}, \ldots, \mathcal{D}_{N}: \Omega \rightarrow \mathbb{R}_{+}$and $\lambda_{2}, \lambda_{2}, \ldots, \lambda_{N}$ depending on $\kappa,\|f\|_{C^{1}}$, and $q$ such that

$$
u^{\varepsilon}(x, t) \leq\left\|u_{0}\right\|_{\infty}+A \sum_{k=1}^{N} \mathcal{D}_{n} \quad \text { on } \mathbb{R}^{d} \times[0, T]
$$

and, for all $k=1,2, \ldots, N, p \geq 1$, and some $C=C\left(\kappa,\|f\|_{C^{1}}, p, q\right)>0$,

$$
\mathbf{P}\left(D_{k}>\lambda\right) \leq \frac{C \varepsilon^{p / 2}}{\lambda^{p}} \quad \text { for all } \lambda \geq \lambda_{k}
$$

A similar argument, using the lower bound of Lemma 2.5. gives

$$
u^{\varepsilon}(x, t) \geq-\left\|u_{0}\right\|_{\infty}-A \sum_{k=1}^{N} \mathcal{D}_{n} \quad \text { on } \mathbb{R}^{d} \times[0, T]
$$

Adding a random constant to $u^{\varepsilon}$, which does not affect the equation solved by $u^{\varepsilon}$, we may then write

0 \leq u^{\varepsilon} \leq \mathcal{S} \quad \text { on } \mathbb{R}^{d} \times[0, T]
$$

where

\mathcal{S}:=2\left\|u^{\varepsilon}\right\|_{\infty}+2 A \sum_{k=1}^{N} \mathcal{D}_{k}
$$

Setting $M:=1 \vee\left(2\left\|u_{0}\right\|_{\infty}\right)$, we then have, for all $p \geq 1, \lambda \geq \lambda_{1} \vee \lambda_{2} \vee \cdots \vee \lambda_{N}$, and some constant $C=C\left(\kappa,\|f\|_{C^{1}}, A, p, q, T\right)>0$,

$$
\begin{equation*}
\mathbf{P}\left((\mathcal{S}-M)_{+}>\lambda\right) \leq \mathbf{P}\left(\sum_{k=1}^{N} \mathcal{D}_{k}>\frac{\lambda}{2 A}\right) \leq \frac{C \varepsilon^{p / 2}}{\lambda^{p}} \tag{5.6}
\end{equation*}
$$

Step 2: the Hölder estimate. Because $\tau>1 / 2$, we can cover $B_{R} \times[\tau, T]$ with cylinders on which, by Theorem 3.1, $u$ is Hölder continuous. More precisely, there exists $\alpha, \lambda_{0}$ and $C$ as in the statement of the current theorem, and $c=c(\kappa, \alpha, q)>0$, such that, for all $p \geq 1$ and $\lambda \geq \lambda_{0}$,

$$
\mathbf{P}\left(\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{R} \times[\tau, T]} \frac{\left|u^{\varepsilon}(x, t)-u^{\varepsilon}(\tilde{x}, \tilde{t})\right|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha /(q-\alpha(q-1))}}>\lambda\right) \leq \mathbf{P}\left((\mathcal{S}-M)_{+}>c \lambda^{1-\alpha / q^{\prime}}\right)+\frac{C \varepsilon^{p / 2}}{\lambda^{\kappa(q-\alpha(q-1)) p}}
$$

Making $\lambda_{0}$ larger if necessary, depending on $\kappa,\|f\|_{C^{1}}$, and $q$, we invoke (5.6) and obtain the result with

$$
\sigma=\left(1-\frac{\alpha}{q^{\prime}}\right) \wedge(\kappa(q-\alpha(q-1)))=(q-\alpha(q-1))\left(\frac{1}{q} \wedge \kappa\right)
$$

The next result is for the second-order case. Assume that, for some $A>1, \nu>0$, and $q>2$,

\left\{\begin{array}{l}
F \in C\left(\mathbb{S}^{d} \times \mathbb{R}^{d} \times \mathbb{R}^{d} \times[0, \infty)\right) \text { satisfies }  \tag{5.7}\\
-\nu m_{+}(X)+\frac{1}{A}|p|^{q}-A \leq F(X, p, x, t) \leq-\nu m_{-}(X)+A|p|^{q}+A \\
\quad \text { for all }(X, p, x, t) \in \mathbb{S}^{d} \times \mathbb{R}^{d} \times \mathbb{R}^{d} \times[0, T],
\end{array}\right.
$$

and

$$
\begin{equation*}
f \in C_{b}^{2}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right) \tag{5.8}
\end{equation*}
$$

For $0<\varepsilon<1$, the scaled equation we consider is

$$
\begin{equation*}
d u^{\varepsilon}+F\left(\varepsilon D^{2} u^{\varepsilon}, D u^{\varepsilon}, \frac{x}{\varepsilon}, \frac{t}{\varepsilon}\right) d t=\varepsilon^{1 / 2} \sum_{i=1}^{m} f^{i}\left(\frac{x}{\varepsilon}\right) \cdot d B^{i}(t) \quad \text { in } \mathbb{R}^{d} \times(0, T] \quad \text { and } \quad u^{\varepsilon}(\cdot, 0)=u_{0} \quad \text { on } \mathbb{R}^{d} \tag{5.9}
\end{equation*}
$$

and we prove the following result:
Theorem 5.2. Assume (5.1), (5.2), (5.7), and (5.8), and, for $0<\varepsilon \leq 1$, let $u^{\varepsilon}$ be the solution of (5.9). Fix $p \geq 1, \tau>0$ and $R>0$. Then there exists a constant $C=C\left(R, \tau, T, A,\|f\|_{C^{2}},\left\|u_{0}\right\|_{\infty}, p, q\right)>0$, $\alpha=\alpha(A, q)>0$, and $\sigma=\sigma(A, q)>0$ such that

$$
\mathbf{P}\left(\sup _{(x, t),(\tilde{x}, \tilde{t}) \in B_{R} \times[\tau, T]} \frac{\left|u^{\varepsilon}(x, t)-u^{\varepsilon}(\tilde{x}, \tilde{t})\right|}{|x-\tilde{x}|^{\alpha}+|t-\tilde{t}|^{\alpha /(q-\alpha(q-1))}}>C+\lambda\right) \leq \frac{C \varepsilon^{p / 2}}{\lambda^{\sigma p}}
$$

Proof. Arguing as in the proof of Theorem [5.1] we may assume without loss of generality that $\tau>1 / 2$. Notice also that

F^{\varepsilon}(X, p, x, t):=F\left(\varepsilon X, p, \frac{x}{\varepsilon}, \frac{t}{\varepsilon}\right) \quad \text { for }(X, p, x, t) \in \mathbb{S}^{d} \times \mathbb{R}^{d} \times \mathbb{R}^{d} \times[0, T]
$$

satisfies (5.3) with $\varepsilon \nu$ replacing $\nu$, and, therefore, if we define $f^{\varepsilon}(x):=\varepsilon^{1 / 2} f(x / \varepsilon)$, we have $\left\|f^{\varepsilon}\right\|_{\infty}=$ $\varepsilon^{1 / 2}\|f\|_{\infty}$ and

\varepsilon \nu+\left\|f^{\varepsilon}\right\|_{\infty}\left\|D f^{\varepsilon}\right\|_{\infty}+\varepsilon \nu\left\|f^{\varepsilon}\right\|_{\infty}\left\|D^{2} f^{\varepsilon}\right\|_{\infty} \leq \nu+\|f\|_{\infty}\|D f\|_{\infty}+\|f\|_{\infty}\left\|D^{2} f\right\|_{\infty}
$$

As a consequence, we may choose a constant $K>0$ independently of $\varepsilon>0$ for which the conclusions of Lemma 2.6 and Theorem 4.1] hold with the function $f^{\varepsilon}$. The rest of the proof then follows exactly as in the proof of Theorem 5.1.

## Appendix A. Controlling stochastic integrals

Throughout the paper, we use the following results that give uniform control over certain stochastic integrals. Assume below that

Lemma A.1. Let $m>0, K>0, q>1$, and $\kappa \in(0,1 / 2)$. Then there exists a random variable $\mathcal{D}: \Omega \rightarrow \mathbb{R}_{+}$ and $\lambda_{0}=\lambda_{0}(\kappa, K, q)>0$ such that
(a) for any $p \geq 1$ and some constant $C=C(\kappa, K, p, q)>0$,

\mathbf{P}(\mathcal{D}>\lambda) \leq \frac{C m^{p}}{\lambda^{p}} \quad \text { for all } \lambda \geq \lambda_{0}
$$

and
(b) for all $\gamma \in W^{1, \infty}\left([-1,0], \mathbb{R}^{d}\right), \delta \in(0,1],-1 \leq s \leq t \leq 0$, and $f$ satisfying

$$

Assume now that

W:[-1,0] \times \mathcal{A} \rightarrow \mathbb{R} \quad \text { is a Brownian motion defined over a probability space }(\mathcal{A}, \mathcal{F}, \mathbb{P})
$$

The probability space $\mathcal{A}$ is independent of $\Omega$. Below, we prove a statement that is true for $\mathbf{P}$-almost every sample path $B$ of the Brownian motion from (A.1), which involves taking the expectation with respect to the Brownian motion $W$. Effectively, $B$ and $W$ are independent Brownian motions, and $\mathbb{E}$ can be interpreted as the expectation conditioned with respect to $B$.
Lemma A.2. Let $q>1,0<\kappa<\frac{1}{2}, m>0$, and $K>0$. Then there exist a random variable $\mathcal{E}: \Omega \rightarrow \mathbb{R}_{+}$ and $\lambda_{0}:=\lambda_{0}(\kappa, K, q)>0$ such that
(a) for any $p \geq 1$ and some constant $C=C(\kappa, K, p, q)>0$,

\mathbf{P}(\mathcal{E}>\lambda) \leq \frac{C m^{p}}{\lambda^{p}} \quad \text { for all } \lambda \geq \lambda_{0}
$$

and
(b) for all $0<\delta \leq 1$; processes $(\alpha, \sigma, X):[-1,0] \times \mathcal{A} \rightarrow \mathbb{R}^{d} \times \mathbb{R}^{d} \times \mathbb{R}^{d}$ that are $W$-adapted such that

$W$-stopping times $-1 \leq s \leq t \leq 0$; and $f \in C^{1}\left(\mathbb{R}^{d}, \mathbb{R}^{m}\right)$ satisfying

\|f\|_{\infty} \leq m \quad \text { and } \quad\|f\|_{\infty}\left(1+\|D f\|_{\infty}+\left\|\sigma \sigma^{t}\right\|_{\infty}\left\|D^{2} f\right\|_{\infty}\right) \leq K \tag{A.3}
\end{equation*}
$$

we have

\left|\mathbb{E}\left[\int_{s}^{t} f\left(X_{r}\right) \cdot d B_{r}\right]\right| \leq \delta^{q^{\prime}} \mathbb{E} \int_{s}^{t}\left|\alpha_{r}\right|^{q^{\prime}} d r+\frac{\mathcal{E}}{\delta^{q}}(t-s)^{\kappa}
$$

We note that the integrals against $d B$ appearing in Lemmas A. 1 and A. 2 are interpreted as in Section 2. and, in particular, subsection 2.2

The proof of Lemma A.1 can be found in [14. The arguments for Lemma A.2 are similar, but some further details are needed to account for the use of Itô's formula and the interaction between $B$ and $W$.

We first give a parameter-dependent variant of Kolmogorov's continuity criterion. Its statement and proof are very similar to that in [14].

Lemma A.3. Define $\triangle:=\{(s, t) \in[-1,0], s \leq t\}$ and fix a parameter set $\mathcal{M}$. Let $\left(M_{\mu}\right)_{\mu \in \mathcal{M}}: \Omega \rightarrow \mathbb{R}_{+}$ and $\left(Z_{\mu}\right)_{\mu \in \mathcal{M}}: \triangle \times \Omega \rightarrow \mathbb{R}_{+}$be such that

Then, for all $0<\kappa<\beta$, there exist $C_{1}=C_{1}(\kappa)>0$ and $C_{2}=C_{2}(p, \kappa, \beta)>0$ such that, for all $\lambda \geq 1$,

\mathbf{P}\left(\sup _{\mu \in \mathcal{M}} \sup _{(s, t) \in \Delta}\left(\frac{Z_{\mu}(s, t)}{(t-s)^{\kappa}}-C_{1} M_{\mu}\right)>\lambda\right) \leq \frac{C_{2} a}{\lambda^{p}}
$$

The next result gives an estimate for moments of sums of certain centered and independent random variables.
Lemma A.4. Let $\left(Y_{k}\right)_{k=1}^{n}: \Omega \rightarrow \mathbb{R}$ be a sequence of centered and independent random variables such that, for all $p \geq 1$ and for some $\mu>0$ and $C=C(p)>0$,

Then there exists a constant $\tilde{C}=\tilde{C}(p)>0$ such that

Proof. Let $\left(\varepsilon_{k}\right)_{k=1}^{n}$ be a sequence of independent Rademacher random variables, that is,

Therefore, upon replacing $Y_{k}$ with $\varepsilon_{k} Y_{k}$, we may assume without loss of generality that each $Y_{k}$ is symmetric, that is, $Y_{k}$ and $-Y_{k}$ are identically distributed.

Observe next that if the result holds for some $p \geq 1$, then, for any $q<p$, by Hölder's inequality,

$$
\mathbf{E}\left|\sum_{k=1}^{n} Y_{k}\right|^{q} \leq\left(\mathbf{E}\left|\sum_{k=1}^{n} Y_{k}\right|^{p}\right)^{q / p} \leq\left(\tilde{C} n^{p / 2} \mu^{p}\right)^{q / p} \leq \tilde{C}^{q / p} n^{q / 2} \mu^{q}
$$

Therefore, it suffices to prove the result for $p=2 m$ with $m \in \mathbb{N}$.
We compute

$$
\left|\sum_{k=1}^{n} Y_{k}\right|^{2 m}=\sum Y_{k_{1}}^{j_{1}} Y_{k_{2}}^{j_{2}} \cdots Y_{k_{\ell}}^{j_{\ell}}
$$

where the sum is taken over $1 \leq k_{1}<k_{2}<\cdots<k_{\ell} \leq n$ and $j_{1}+j_{2}+\cdots+j_{\ell}=2 m$. In view of the symmetry and independence of the $Y_{k}$, all summands for which one or more of the $j_{i}$ values is odd have zero expectation. Thus,

$$
\mathbf{E}\left|\sum_{k=1}^{n} Y_{k}\right|^{2 m}=\sum \mathbf{E} Y_{k_{1}}^{2 i_{1}} Y_{k_{2}}^{2 i_{2}} \cdots Y_{k_{\ell}}^{2 i_{\ell}}
$$

where the sum is taken over $1 \leq k_{1}<k_{2}<\cdots<k_{\ell} \leq n$ and $i_{1}+i_{2}+\cdots+i_{\ell}=m$. A combinatorial argument implies that the cardinality of such terms is equal to $\binom{m+n-1}{n-1}$, while Hölder's inequality gives

$$
\mathbf{E} Y_{k_{1}}^{2 i_{1}} Y_{k_{2}}^{2 i_{2}} \cdots Y_{k_{\ell}}^{2 i_{\ell}} \leq\left(\mathbf{E} Y_{k_{1}}^{2 m}\right)^{i_{1} / m}\left(\mathbf{E} Y_{k_{2}}^{2 m}\right)^{i_{2} / m} \cdots\left(\mathbf{E} Y_{k_{\ell}}^{2 m}\right)^{i_{\ell} / m} \leq C \mu^{2 m}
$$

and, therefore,

$$
\mathbf{E}\left|\sum_{k=1}^{n} Y_{k}\right|^{2 m} \leq C\binom{m+n-1}{n-1} \mu^{2 m} \leq C n^{m} \mu^{2 m}
$$

Finally, we turn to the proof of Lemma A. 2

Proof of Lemma A.2. Let $\mathscr{C}_{m, K}$ be the space consisting of $(\alpha, \sigma, X, f)$ satisfying (A.2) and A.3), define the parameter set

$$
\mathcal{M}:=(0,1) \times \mathscr{C}_{m, K}
$$

and, for each $\mu=(\delta, \alpha, \sigma, X, f) \in \mathcal{M}$ and $(s, t) \in \triangle$, the stochastic process

$$
\begin{equation*}
Z_{\mu}(s, t):=\left(\left|\mathbb{E}\left[\delta^{q} \int_{s}^{t} f\left(X_{r}\right) \cdot d B_{r}\right]\right|-\delta^{q+q^{\prime}} \mathbb{E} \int_{s}^{t}\left|\alpha_{r}\right|^{q^{\prime}} d r\right)_{+} \tag{A.5}
\end{equation*}
$$

which can easily be seen to satisfy (A.4).
We first show that there exist constants $M_{1}=M_{1}(K, q)>0$ and $M_{2}=M_{2}(K, p, q)>0$ such that

$$
\begin{equation*}
\sup _{-1 \leq s \leq t \leq 0} \mathbf{E}\left[\sup _{\mu \in \mathcal{M}}\left(\frac{Z_{\mu}(s, t)}{(t-s)^{1 / 2}}-M_{1}\right)_{+}^{p}\right] \leq M_{2} m^{p} . \tag{A.6}
\end{equation*}
$$

Fix $s, t \in[-1,0]$ with $s \leq t$. We split into two cases, depending on the size of the interval $[s, t]$.
Case 1. Assume first that

$$
\begin{equation*}
t-s \leq \frac{\|f\|_{\infty}^{q}}{\|D f\|_{\infty}^{q}} \wedge \frac{\|f\|_{\infty}}{\left\|\sigma \sigma^{t}\right\|_{\infty,[-1,0]}\left\|D^{2} f\right\|_{\infty}} \tag{A.7}
\end{equation*}
$$

By Lemma 2.2,

$$
\begin{aligned}
\mathbb{E}\left[\int_{s}^{t} f\left(X_{r}\right) \cdot d B_{r}\right] & =\mathbb{E}\left[f\left(X_{t}\right) \cdot\left(B_{t}-B_{s}\right)\right] \\
& -\mathbb{E}\left[\int_{s}^{t}\left(D f\left(\gamma_{r}\right) \cdot \alpha_{r}+\frac{1}{2} \operatorname{tr}\left(\sigma_{r} \sigma_{r}^{t} D^{2} f\left(X_{r}\right)\right)\right) \cdot\left(B_{r}-B_{s}\right) d r\right]
\end{aligned}
$$

Setting

$$
\Delta:=\max _{r_{1}, r_{2} \in[s, t]}\left|B_{r_{1}}-B_{r_{2}}\right|
$$

and invoking (A.7) and the Young and Hölder inequalities then gives, for some constant $C=C(K, q)>0$,

$$
\begin{aligned}
& \left|\mathbb{E}\left[\int_{s}^{t} f\left(X_{r}\right) \cdot d B_{r}\right]\right| \\
& \leq\|f\|_{\infty} \Delta+\|D f\|_{\infty} \Delta \mathbb{E} \int_{s}^{t}\left|\alpha_{r}\right| d r+\frac{1}{2}\left\|\sigma \sigma^{t}\right\|_{\infty}\left\|D^{2} f\right\|_{\infty} \Delta(t-s) \\
& \leq\|f\|_{\infty}\left(\frac{3}{2} \Delta+\Delta\left(\mathbb{E} \int_{s}^{t}\left|\alpha_{r}\right|^{q^{\prime}} d r\right)^{1 / q^{\prime}}\right) \\
& \leq\|f\|_{\infty}\left(\frac{3}{2} \Delta+\frac{C \Delta^{q}}{\delta^{q}}\right)+\delta^{q^{\prime}} \mathbb{E} \int_{s}^{t}\left|\alpha_{r}\right|^{q^{\prime}} d r,
\end{aligned}
$$

and so

$$
\sup _{\mu \in \mathcal{M}} Z_{\mu}(s, t) \leq m\left(\frac{3}{2} \Delta+C \Delta^{q}\right)
$$

Raising both sides to the power $p$, taking the expectation $\mathbf{E}$ over $\Omega$, and invoking the scaling properties of Brownian motion yield, for some constant $C=C(K, p, q)>0$ that changes from line to line,

$$
\begin{aligned}
\mathbf{E}\left[\sup _{\mu \in \mathcal{M}} Z_{\mu}(s, t)^{p}\right] & \leq C m^{p}\left(\mathbf{E} \Delta^{p}+\mathbf{E} \Delta^{p q}\right) \\
& \leq C m^{p}(t-s)^{p / 2}
\end{aligned}
$$

and (A.6) then follows in this case.
Case 2. Assume now that

$$
\begin{equation*}
t-s>\frac{\|f\|_{\infty}^{q}}{\|D f\|_{\infty}^{q}} \wedge \frac{\|f\|_{\infty}}{\left\|\sigma \sigma^{t}\right\|_{\infty,[-1,0]}\left\|D^{2} f\right\|_{\infty}} \tag{A.8}
\end{equation*}
$$

Set

$$
\begin{equation*}
h:=\left[\frac{\|f\|_{\infty}}{\|D f\|_{\infty}}(t-s)^{1 / q^{\prime}}\right] \wedge \frac{\|f\|_{\infty}}{\left\|\sigma \sigma^{t}\right\|_{\infty}\left\|D^{2} f\right\|_{\infty}} \tag{A.9}
\end{equation*}
$$

and let $N \in \mathbb{N}$ be such that

$$
\frac{t-s}{h} \leq N<\frac{t-s}{h}+1
$$

Note that (A.8) implies that $h \leq t-s$, and so

$$
\begin{equation*}
t-s \leq N h<2(t-s) \tag{A.10}
\end{equation*}
$$

For $k=0,1,2, \ldots, N-1$, set $\tau_{k}:=s+k h$ and $\tau_{N}=t$, and, for $k=1,2, \ldots, N$, define

$$
\Delta_{k}=\max _{u, v \in\left[\tau_{k-1}, \tau_{k}\right]}\left|B_{u}-B_{v}\right|
$$

Using Lemma 2.2, we write

$$
\begin{aligned}
\mathbb{E}\left[\int_{s}^{t} f\left(X_{r}\right) \cdot d B_{r}\right] & =\sum_{k=1}^{N} \mathbb{E}\left[\int_{\tau_{k-1}}^{\tau_{k}} f\left(X_{r}\right) \cdot d B_{r}\right] \\
& =\mathrm{I}-\mathrm{II}-\mathrm{III}
\end{aligned}
$$

where

$$
\begin{gathered}
\mathrm{I}:=\sum_{k=1}^{N} \mathbb{E}\left[f\left(X_{\tau_{k}}\right) \cdot\left(B_{\tau_{k}}-B_{\tau_{k-1}}\right)\right], \\
\mathrm{II}:=\sum_{k=1}^{N} \mathbb{E}\left[\int_{\tau_{k-1}}^{\tau_{k}} D f\left(X_{r}\right) \alpha_{r} \cdot\left(B_{r}-B_{\tau_{k-1}}\right) d r\right],
\end{gathered}
$$

and

$$
\text { III }:=\frac{1}{2} \sum_{k=1}^{N} \mathbb{E}\left[\int_{\tau_{k-1}}^{\tau_{k}} \operatorname{tr}\left(\sigma_{r} \sigma_{r}^{t} D^{2} f\left(X_{r}\right)\right) \cdot\left(B_{r}-B_{\tau_{k-1}}\right) d r\right]
$$

We estimate

$$
|\mathrm{I}| \leq\|f\|_{\infty} \sum_{k=1}^{N} \Delta_{k} \quad \text { and } \quad|\mathrm{III}| \leq \frac{h}{2}\left\|\sigma \sigma^{t}\right\|_{\infty}\left\|D^{2} f\right\|_{\infty} \sum_{k=1}^{N} \Delta_{k}
$$

and, for all $\varepsilon>0$, Young's inequality yields

$$
\begin{aligned}
|\mathrm{II}| & \leq\|D f\|_{\infty} \sum_{k=1}^{N} \Delta_{k} \mathbb{E} \int_{\tau_{k-1}}^{\tau_{k}}\left|\alpha_{r}\right| d r \\
& \leq\|D f\|_{\infty} h^{1 / q} \sum_{k=1}^{N} \Delta_{k}\left(\mathbb{E} \int_{\tau_{k-1}}^{\tau_{k}}\left|\alpha_{r}\right|^{q^{\prime}} d r\right)^{1 / q^{\prime}} \\
& \leq\|D f\|_{\infty} h^{1 / q}\left(\frac{1}{q \varepsilon^{q}} \sum_{k=1}^{N} \Delta_{k}^{q}+\frac{\varepsilon^{q^{\prime}}}{q^{\prime}} \mathbb{E} \int_{s}^{t}\left|\alpha_{r}\right|^{q^{\prime}} d r\right)
\end{aligned}
$$

Combining the three estimates gives

$$
\begin{align*}
\left|\mathbb{E}\left[\int_{s}^{t} f\left(X_{r}\right) \cdot d B_{r}\right]\right| & \leq\left(\|f\|_{\infty}+\frac{h}{2}\left\|\sigma \sigma^{t}\right\|_{\infty}\left\|D^{2} f\right\|_{\infty}\right) \sum_{k=1}^{N} \Delta_{k} \\
& +\|D f\|_{\infty} h^{1 / q}\left(\frac{1}{q \varepsilon^{q}} \sum_{k=1}^{N} \Delta_{k}^{q}+\left.\frac{\varepsilon^{q^{\prime}}}{q^{\prime}} \mathbb{E} \int_{s}^{t}\left|\alpha_{r}\right|\right|^{q^{\prime}} d r\right) . \tag{A.11}
\end{align*}
$$

We now set

$$
\varepsilon:=\delta\left(\frac{q^{\prime}}{\|D f\|_{\infty} h^{1 / q}}\right)^{1 / q^{\prime}}
$$

In particular,

$$
\varepsilon^{q^{\prime}}=\frac{q^{\prime} \delta^{q^{\prime}}}{\|D f\|_{\infty} h^{1 / q}} \quad \text { and } \quad \varepsilon^{q}=\frac{\left(q^{\prime}\right)^{q-1} \delta^{q}}{\|D f\|_{\infty}^{q-1} h^{1 / q^{\prime}}}
$$

so that A.11) becomes, for some $C=C(q)>0$,

$$
\begin{aligned}
\left|\mathbb{E}\left[\int_{s}^{t} f\left(X_{r}\right) \cdot d B_{r}\right]\right| & \leq\left(\|f\|_{\infty}+\frac{h}{2}\left\|\sigma \sigma^{t}\right\|_{\infty}\left\|D^{2} f\right\|_{\infty}\right) \sum_{k=1}^{N} \Delta_{k} \\
& +\frac{C}{\delta^{q}}\|D f\|_{\infty}^{q} h \sum_{k=1}^{N} \Delta_{k}^{q}+\delta^{q^{\prime}} \mathbb{E} \int_{s}^{t}\left|\alpha_{r}\right|^{q^{\prime}} d r .
\end{aligned}
$$

For $k=1,2, \ldots, N$, the constants

$$
a_{k}:=\mathbf{E} \Delta_{k} \quad \text { and } \quad b_{k}:=\mathbf{E} \Delta_{k}^{q}
$$

satisfy, for some $a>0$ and $b=b(q)>0$,

$$
a_{k} \leq a h^{1 / 2} \quad \text { and } \quad b_{k} \leq b h^{q / 2}
$$

Then (A.9) and (A.10) give

$$
\begin{aligned}
\left(\|f\|_{\infty}+\frac{h}{2}\left\|\sigma \sigma^{t}\right\|_{\infty}\left\|D^{2} f\right\|_{\infty}\right) \sum_{k=1}^{N} a_{k} & \leq \frac{3}{2}\|f\|_{\infty} N h^{1 / 2} a \leq 3 a\|f\|_{\infty}(t-s) h^{-1 / 2} \\
& \leq 3 a(t-s)\|f\|_{\infty}^{1 / 2}\left(\left[\|D f\|_{\infty}^{1 / 2}(t-s)^{-1 /\left(2 q^{\prime}\right)}\right] \vee\left[\left\|\sigma \sigma^{t}\right\|_{\infty}^{1 / 2}\left\|D^{2} f\right\|_{\infty}^{1 / 2}\right]\right) \\
& \leq 3 a K^{1 / 2}(t-s)^{1 / 2}
\end{aligned}
$$

and

$$
\begin{aligned}
\|D f\|_{\infty}^{q} h \sum_{k=1}^{N} b_{k} & \leq b\|D f\|_{\infty}^{q} N h^{1+q / 2} \leq 2 b(t-s)\|D f\|_{\infty}^{q} h^{q / 2} \\
& \leq 2 b(t-s)\|f\|_{\infty}^{q / 2}\|D f\|_{\infty}^{q / 2}(t-s)^{\frac{q}{2 q^{\prime}}} \leq 2 b K^{\frac{q}{2}}(t-s)^{\frac{q+1}{2}}
\end{aligned}
$$

Therefore, because $0<\delta \leq 1$, we find that, for some constant $M_{1}=M_{1}(K, q, m)>0$,

$$
\begin{align*}
& \left(Z_{\mu}(s, t)-M_{1}(t-s)^{1 / 2}\right)_{+} \\
& \quad \leq M_{1}\left(\|f\|_{\infty}\left|\sum_{k=1}^{N}\left(\Delta_{k}-a_{k}\right)\right|+C\|D f\|_{\infty}^{q} h\left|\sum_{k=1}^{N}\left(\Delta_{k}^{q}-b_{k}\right)\right|\right) \tag{A.12}
\end{align*}
$$

The collections $\left(\Delta_{k}-a_{k}\right)_{k=1}^{N}$ and $\left(\Delta_{k}^{q}-b_{k}\right)_{k=1}^{N}$ consist of independent and centered random variables. The scaling properties of Brownian motion yield, for any $k=1,2, \ldots, N$ and $p_{0}>0$ and constants $A_{1}=A_{1}\left(p_{0}\right)>$ 0 and $A_{2}=A_{2}\left(p_{0}, q\right)>0$,

$$
\mathbf{E}\left|\Delta_{k}-a_{k}\right|^{p_{0}} \leq A_{1} h^{p_{0} / 2} \quad \text { and } \quad \mathbf{E}\left|\Delta_{k}^{q}-b_{k}\right|^{p_{0}} \leq A_{2} h^{p_{0} q / 2}
$$

It is then a consequence of A.10 and Lemma A.4 that, for some constants $\tilde{A}_{1}=\tilde{A}_{1}(p)>0$ and $\tilde{A}_{2}=$ $\tilde{A}_{2}(p, q)>0$,

$$
\mathbf{E}\left|\sum_{k=1}^{N}\left(\Delta_{k}-a_{k}\right)\right|^{p} \leq \tilde{A}_{1} N^{p / 2} h^{p / 2} \leq 2^{p / 2} \tilde{A}_{1}(t-s)^{p / 2}
$$

and

$$
\mathbf{E}\left|\sum_{k=1}^{N}\left(\Delta_{k}^{q}-b_{k}\right)\right|^{p} \leq \tilde{A}_{2} N^{p / 2} h^{p q / 2} \leq 2^{p / 2} \tilde{A}_{2}(t-s)^{p / 2} h^{p(q-1) / 2}
$$

The latter estimate and (A.9) give

$$
\begin{aligned}
\|D f\|_{\infty}^{p q} h^{p} \mathbf{E}\left|\sum_{k=1}^{N}\left(\Delta_{k}^{q}-b_{k}\right)\right|^{p} & \leq 2^{p / 2} \tilde{A}_{2}\|D f\|_{\infty}^{p q}(t-s)^{p / 2} h^{p(q+1) / 2} \\
& \leq 2^{p / 2} \tilde{A}_{2}\|f\|_{\infty}^{p(q+1) / 2}\|D f\|_{\infty}^{p(q-1) / 2}(t-s)^{p\left(\frac{1}{2}+\frac{q+1}{2 q^{\prime}}\right)} \\
& \leq 2^{p / 2} \tilde{A}_{2} K^{p(q-1) / 2}\|f\|_{\infty}^{p}(t-s)^{p / 2}
\end{aligned}
$$

and so, raising (A.12) to the power $p$ and taking the expectation gives, for some $M_{2}=M_{2}(m, K, p, q)>0$,

$$
\mathbf{E}\left[\sup _{\mu \in \mathcal{M}}\left(Z_{\mu}(s, t)-M_{1}(t-s)^{1 / 2}\right)_{+}^{p}\right] \leq M_{2}(t-s)^{p / 2}
$$

Dividing by $(t-s)^{p / 2}$ leads to A.6).
We now take $p$ large enough that

$$
\kappa<\frac{1}{2}-\frac{1}{p} .
$$

Then (A.6) and Lemma A.3 imply that, for some $C=C(\kappa, m, K, p, q)>0$ and $M=M(\kappa, m, K, q)>0$, and for all $\lambda \geq 1$ and

$$
p>\frac{2}{1-2 \kappa}
$$

we have

$$
\mathbf{P}\left(\sup _{\mu \in \mathcal{M}} \sup _{-1 \leq s \leq t \leq 0} \frac{Z_{\mu}(s, t)}{(t-s)^{\kappa}}>M+\lambda\right) \leq \frac{C m^{p}}{\lambda^{p}}
$$

By changing $C$ in a way that depends only on $m$ and $p$, the same can be accomplished for all $p \geq 1$. The proof is finished upon setting

$$
\lambda_{0}:=2 M, \quad \mathcal{E}:=\sup _{\mu \in \mathcal{M}} \sup _{-1 \leq s \leq t \leq 0} \frac{Z_{\mu}(s, t)}{(t-s)^{\kappa}}
$$

and replacing $C$ with $2^{p} C$.
