# NONLINEAR SCALAR FIELD EQUATION WITH COMPETING NONLOCAL TERMS

Abstract. We find radial and nonradial solutions to the following nonlocal problem

$$
-\Delta u+\omega u=\left(I_{\alpha} * F(u)\right) f(u)-\left(I_{\beta} * G(u)\right) g(u) \text { in } \mathbb{R}^{N}
$$

under general assumptions, in the spirit of Berestycki and Lions, imposed on $f$ and $g$, where $N \geq 3$, $0 \leq \beta \leq \alpha<N, \omega \geq 0, f, g: \mathbb{R} \rightarrow \mathbb{R}$ are continuous functions with corresponding primitives $F, G$, and $I_{\alpha}, I_{\beta}$ are the Riesz potentials. If $\beta>0$, then we deal with two competing nonlocal terms modelling attractive and repulsive interaction potentials.

## 1. Introduction

This paper mainly deals with the following problem

$$
\begin{equation*}
-\Delta u=\left(I_{\alpha} * F(u)\right) f(u)-\left(I_{\beta} * G(u)\right) g(u) \quad \text { in } \mathbb{R}^{N} \tag{1.1}
\end{equation*}
$$

where $N \geq 3,0 \leq \beta \leq \alpha<N, f, g: \mathbb{R} \rightarrow \mathbb{R}$ are continuous functions with corresponding primitives

$$
F(s)=\int_{0}^{s} f(t) d t, \quad G(s)=\int_{0}^{s} g(t) d t .
$$

Moreover $I_{\gamma}: \mathbb{R}^{N} \rightarrow \mathbb{R}$ is the Riesz potential

$$
I_{\gamma}(x):=\frac{\Gamma\left(\frac{N-\gamma}{2}\right)}{\Gamma\left(\frac{\gamma}{2}\right) \pi^{N / 2} 2^{\gamma}|x|^{N-\gamma}} \quad \text { for } x \in \mathbb{R}^{N} \backslash\{0\} \text { and } \gamma \in(0, N),
$$

while we set $I_{0}=\delta_{0}$, namely the identity for the convolution, where $\delta_{0}$ is the Dirac delta at zero.
If $N=3, \alpha=2, \beta=0, F(s)=\frac{1}{\sqrt{2}}|s|^{2}$ and $G(s)=s$, then (1.1) is the well-known Choquard, or Choquard-Pekar equation

$$
-\Delta u+u=\left(I_{2} *|u|^{2}\right) u \quad \text { in } \mathbb{R}^{N} .
$$

This equation comes, for instance, from an approximation to the Hartree-Fock theory of a plasma $[14,25]$ or it can be also derived in the framework of the Schrödinger-Newton system, (see [21]). A variational approach for this case was presented by Lieb [14] and Lions [16].

More generally, if $N \geq 3, F(s)=\frac{1}{\sqrt{p}}|s|^{p}$, for suitable $p, \alpha>0$ and $G(s)=s$, then weak solutions to (1.1) can be obtained by means of critical points of the associated functional. If, for instance, $\frac{N+\alpha}{N}<p<\frac{N+\alpha}{N-2}$ and $\beta=0$, then, according to the work of Moroz and Van Schaftingen [22], the Hardy-Littlewood-Sobolev inequality implies that $\left(I_{\alpha} * F(u)\right) F(u) \in L^{1}\left(\mathbb{R}^{N}\right)$ for $u \in H^{1}\left(\mathbb{R}^{N}\right)$.

[^0]Moreover the associated functional is well-defined and of class $\mathcal{C}^{1}$ on $H^{1}\left(\mathbb{R}^{N}\right)$, and its critical points correspond to solutions to

$$
\begin{equation*}
-\Delta u+u=\left(I_{\alpha} * F(u)\right) f(u) \quad \text { in } \mathbb{R}^{N} . \tag{1.2}
\end{equation*}
$$

A ground state solution and its properties were obtained in [22]. The same authors in [23] also studied the existence of solutions with a general nonlinearity $F$ in the spirit of the classical result of Berestycki and Lions [6], namely

$$
\begin{equation*}
|s f(s)| \leq C\left(|s|^{\frac{N+\alpha}{N}}+|s|^{\frac{N+\alpha}{N-2}}\right), \quad \lim _{s \rightarrow 0} F(s) /|s|^{\frac{N+\alpha}{N}}=\lim _{|s| \rightarrow+\infty} F(s) /|s|^{\frac{N+\alpha}{N-2}}=0, \quad F\left(s_{0}\right) \neq 0, \tag{1.3}
\end{equation*}
$$

for some $s_{0} \neq 0$ and $C>0$, see also the survey [24] and the references therein. Note that, if $\alpha=0$ in (1.2), since $I_{0} * F(u)=F(u)$, (1.3) covers the Berestycki-Lions growth assumptions only for the nonnegative (attractive) nonlinearity $F^{2}(s) \geq 0$ of the corresponding energy functional (see (3.3) of [6]).

On the other hand, as for instance in the Hartree-Fock theory, the interaction potential could be also repulsive [5,17], i.e. with $\beta>0$ and a non-trivial $G(s) \geq 0$. Moreover problems similar to (1.1) may admit some local terms as well, see also [24] and the references therein.

Our aim is to investigate both nonlinear phenomena with both nonlocal terms ( $0<\beta \leq \alpha$ ) in (1.1), since, in the limiting case $\alpha=\beta=0$, we can fully cover the Berestycki and Lions assumptions [6].

We impose the following assumptions on $f$ and $g$ :
$\left(H_{1}\right)$ there is a constant $C>0$ and $p \in\left(\frac{2 \beta}{N-2}, \frac{N+\beta}{N-2}\right]$ such that $|s f(s)| \leq C|s|^{\frac{N+\alpha}{N-2}}$ and $0 \leq$ $g(s) s \leq C\left(|s|^{p}+|s|^{\frac{N+\beta}{N-2}}\right)$ for $s \in \mathbb{R} ;$
$\left(H_{2}\right) \lim _{s \rightarrow 0} \frac{F(s)}{|s|^{\frac{N+\alpha}{N-2}}}=\lim _{|s| \rightarrow+\infty} \frac{F(s)}{|s|^{\frac{N+\alpha}{N-2}}}=0 ;$
$\left(H_{3}\right)$ there is $s_{0}>0$ such that $F\left(s_{0}\right) \neq 0$; if $\alpha=\beta$, then we assume also $F\left(s_{0}\right)>G\left(s_{0}\right)$.
Observe that, if $0 \leq \beta<\frac{N-2}{2}$, then, due to the continuity of $g$, we can take $p=1 \in\left(\frac{2 \beta}{N-2}, \frac{N+\beta}{N-2}\right]$.
We remark that these kinds of assumptions follow naturally from the local case, namely when $\alpha=\beta=0$, and equation (1.1) becomes simply

$$
\begin{equation*}
-\Delta u=h(u) \quad \text { in } \mathbb{R}^{N} \tag{1.4}
\end{equation*}
$$

This problem has been studied in [6] and [26,27], under general assumptions. In particular, in [26,27] Struwe considered a continuous and odd function $h: \mathbb{R} \rightarrow \mathbb{R}$ with primitive $H(s)=\int_{0}^{s} h(t) d t$ such that
(i) $-\infty \leq \lim \sup _{s \rightarrow 0} h(s) s /|s|^{\frac{2 N}{N-2}} \leq 0$;
(ii) $-\infty \leq \lim \sup _{|s| \rightarrow+\infty} h(s) s /|s|^{\frac{2 N}{N-2}} \leq 0$;
(iii) there is $s_{0}>0$ such that $H\left(s_{0}\right)>0$.

Observe that the above assumptions contain those in [6]. As usual, by the maximum principle, it is enough to solve (1.4) when $\lim \sup _{|s| \rightarrow+\infty} h(s) s /|s|^{\frac{2 N}{N-2}}=0$. Now, taking $F$ and $G$ even functions such that

$$
F^{2}(s)=\int_{0}^{s} \max \{h(t), 0\} d t \quad \text { and } \quad G^{2}(s)=\int_{0}^{s} \max \{-h(t), 0\} d t, \quad \text { for } s \geq 0
$$

we get $H(s)=F^{2}(s)-G^{2}(s)$ and, in the local case $\alpha=\beta=0$, assumptions $\left(H_{2}\right)$ and $\left(H_{3}\right)$ are clearly satisfied. Moreover $F$ and $G$ satisfy the following condition
$\left(H_{1}^{*}\right)$ there is a constant $C>0$ such that $\left|\left(F^{2}\right)^{\prime}(s) s\right| \leq C|s|^{\frac{2 N}{N-2}}$ and $0 \leq\left(G^{2}\right)^{\prime}(s) s \leq C\left(|s|^{2}+\right.$ $\left.|s|^{\frac{2 N}{N-2}}\right)$ for $s \in \mathbb{R}$.

This is a slightly weaker variant of $\left(H_{1}\right)$, which is essentially designed for the nonlocal problem. In fact, with our argument, one can provide a different proof of the existence of a radial solution under assumptions (i)-(iii) from [26, 27].
Further progress on the Berestycki-Lions problem (1.4) has been made in $[12,18,19]$; see also the references therein.

We look for a weak solution $u \in \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ to (1.1), i.e.

$$
\int_{\mathbb{R}^{N}} \nabla u \cdot \nabla \psi d x=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F(u)\right) f(u) \psi d x-\int_{\mathbb{R}^{N}}\left(I_{\beta} * G(u)\right) g(u) \psi d x
$$

for any $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, where $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ stands for the completion of $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ with respect to the norm $\|\nabla \cdot\|_{2}$.

At least formally solutions of (1.1) are critical points of the functional $\mathcal{I}: \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right) \rightarrow \mathbb{R} \cup\{+\infty\}$ defined as

$$
\mathcal{I}(u)=\int_{\mathbb{R}^{N}}|\nabla u|^{2} d x-\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F(u)\right) F(u) d x+\int_{\mathbb{R}^{N}}\left(I_{\beta} * G(u)\right) G(u) d x
$$

where $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$. Since $|F(s)| \leq C|s|^{\frac{N+\alpha}{N-2}}$ for some constant $C>0$, we have that $\left(I_{\alpha} * F(u)\right) F(u) \in$ $L^{1}\left(\mathbb{R}^{N}\right)$. On the other hand $\left(I_{\beta} * G(u)\right) G(u) \in L_{\mathrm{loc}}^{1}\left(\mathbb{R}^{N}\right)$ and need not be integrable in $\mathbb{R}^{N}$. Therefore $\mathcal{I}$ may be infinite on a dense subset of $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ and, thus, cannot be Fréchet-differentiable.

We remark also that scaling properties of the problem play a crucial role, but, in our case, seem to be difficult to apply. Indeed, if $\alpha \neq \beta$, then the nonlinear terms

$$
\begin{aligned}
\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F(u(\lambda \cdot))\right) F(u(\lambda \cdot)) d x & =\lambda^{-(N+\alpha)} \int_{\mathbb{R}^{N}}\left(I_{\beta} * F(u)\right) F(u) d x \\
\int_{\mathbb{R}^{N}}\left(I_{\beta} * G(u(\lambda \cdot))\right) G(u(\lambda \cdot)) d x & =\lambda^{-(N+\beta)} \int_{\mathbb{R}^{N}}\left(I_{\beta} * G(u)\right) G(u) d x
\end{aligned}
$$

have different scaling coefficients and, in particular, one cannot employ Lagrange multipliers as in [6], rescaling as in [26], or Pohozaev constraint approach as in [18, 19].

Moreover, to recover the lack of compactness due to the fact that we are working in the whole $\mathbb{R}^{N}$, we start using the invariance of the functional $\mathcal{I}$ with respect to the orthogonal group action $\mathcal{O}(N)$. Hence we may restrict our considerations to the subspace of radial function $\mathcal{D}_{\mathcal{O}(N)}^{1,2}\left(\mathbb{R}^{N}\right)$, however $\left.\mathcal{I}\right|_{\mathcal{D}_{\mathcal{O}(N)}^{1,2}\left(\mathbb{R}^{N}\right)}$ still preserves the above difficulties and may be infinite.

In this setting, our main result reads as follows.
Theorem 1.1. Assume that $\left(H_{1}\right)-\left(H_{3}\right)$ hold. Then, there is a nontrivial and radial solution $u \in \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ to (1.1) such that $\left(I_{\beta} * G(u)\right) G(u) \in L^{1}\left(\mathbb{R}^{N}\right)$.

Let us describe our variational approach.
We observe that

$$
\begin{equation*}
\mathcal{F}(u):=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F(u)\right) F(u) d x \tag{1.5}
\end{equation*}
$$

is well-defined on $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$, however $\mathcal{I}$ may be infinite. Therefore we replace

$$
\begin{equation*}
\mathcal{G}(u):=\int_{\mathbb{R}^{N}}\left(I_{\beta} * G(u)\right) G(u) d x \tag{1.6}
\end{equation*}
$$

with

$$
\begin{equation*}
\mathcal{G}_{n}(u):=\int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G(u)\right) G(u) d x \tag{1.7}
\end{equation*}
$$

where $\left\{\varphi_{n}\right\}_{n \geq 1}$ is a sequence of $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ radial functions, decreasing with respect to the radius, such that, for every $n \geq 1, \varphi_{n}(x)=1$ for $x \in B_{n}, \varphi_{n}(x)=0$ for $x \in \mathbb{R}^{N} \backslash B_{2 n}, 0 \leq \varphi_{n}(x) \leq$
$1,|x|\left|\nabla \varphi_{n}(x)\right| \leq c$, and $\varphi_{n}(x) \leq \varphi_{n+1}(x)$ for $n \geq 1$ and $x \in \mathbb{R}^{N}\left(B_{n}\right.$ stands for the ball of radius $n$ centred at 0$)$. Then $\mathcal{G}_{n}$ is well-defined on $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ and

$$
\begin{equation*}
\mathcal{I}_{n}(u):=\int_{\mathbb{R}^{N}}|\nabla u|^{2} d x-\mathcal{F}(u)+\mathcal{G}_{n}(u) \tag{1.8}
\end{equation*}
$$

is of class $\mathcal{C}^{1}$.
The functional $\mathcal{I}_{n}$ does not satisfy any variant of Ambrosetti-Rabinowitz condition [1], hence it is difficult to find a bounded Palais-Smale sequence on a positive level. Inspired by [10,11] we apply the variational method in [28, Theorem 2.8] to the functional

$$
\mathcal{J}_{n}:=(\sigma, u) \in \mathbb{R} \times \mathcal{D}_{\mathcal{O}(N)}^{1,2}\left(\mathbb{R}^{N}\right) \mapsto \mathcal{I}_{n}\left(u\left(e^{\sigma} \cdot\right)\right) \in \mathbb{R}
$$

We require a new nonlocal variant of the Brezis-Lieb Lemma for a general nonlinearity, see Lemma 2.1, and further compactness properties of $\mathcal{F}(u)$ on $\mathcal{D}_{\mathcal{O}(N)}^{1,2}\left(\mathbb{R}^{N}\right)$ demonstrated in Section 2. Then, letting $n \rightarrow+\infty$, the careful analysis of the Mountain Pass levels provides a nontrivial radial solution to (1.1). This approach provides also an alternative proof of the existence of a radial solution in the local case considered in $[26,27]$. We would like to point out that, contrary to [6,26,27], we no longer use the uniform decay at infinity of radial functions from $\mathcal{D}_{\mathcal{O}(N)}^{1,2}\left(\mathbb{R}^{N}\right)$ (see [6, Radial Lemma A.III]) and the compactness lemma due to Strauss [6, Lemma A.I].

Therefore more can be said in higher dimensions. Let $N \geq 4, N \neq 5$ and similarly as Bartsch and Willem in [3] (cf. [12, 18, 19]), let us fix $\tau \in \mathcal{O}(N)$ such that $\tau\left(x_{1}, x_{2}, x_{3}\right)=\left(x_{2}, x_{1}, x_{3}\right)$ for $x_{1}, x_{2} \in \mathbb{R}^{M}$ and $x_{3} \in \mathbb{R}^{N-2 M}$, where $x=\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{N}=\mathbb{R}^{M} \times \mathbb{R}^{M} \times \mathbb{R}^{N-2 M}$ and $2 \leq M \leq N / 2$, with $N-2 M \neq 1$. We define

$$
X_{\tau}:=\left\{u \in \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right): u(x)=-u(\tau x) \text { for all } x \in \mathbb{R}^{N}\right\}
$$

Clearly, if $u \in X_{\tau}$ is radial, then $u=0$. Hence $X_{\tau}$ does not contain nontrivial radial functions. Then let us consider $\mathcal{O}:=\mathcal{O}(M) \times \mathcal{O}(M) \times \mathcal{O}(N-2 M) \subset \mathcal{O}(N)$ acting isometrically on $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ with the subspace of invariant function denoted by $\mathcal{D}_{\mathcal{O}}^{1,2}\left(\mathbb{R}^{N}\right)$. Moreover our functionals are invariant under this action whenever $f$ and $g$ are odd or even.

Our result, in this setting, is
Theorem 1.2. Assume that $\left(H_{1}\right)-\left(H_{3}\right)$ hold, $f$ and $g$ are odd, $N \geq 4$ and $N \neq 5$. Then, there is a nontrivial and nonradial solution $u \in \mathcal{D}_{\mathcal{O}}^{1,2}\left(\mathbb{R}^{N}\right) \cap X_{\tau}$ to (1.1) such that $\left(I_{\beta} * G(u)\right) G(u) \in L^{1}\left(\mathbb{R}^{N}\right)$.

Observe that in Theorem 1.1 and Theorem 1.2 we can take $G(s)=s$ and $\beta=0$ and we obtain solutions in $H^{1}\left(\mathbb{R}^{N}\right)$ solving the Choquard problem (1.2). In fact, dealing with the operator $-\Delta u+u$, more general assumptions imposed on $F$ can be considered, which fully cover situation in [23].

Actually, our argument can be, quite easily, adapted to the following problem

$$
\begin{equation*}
-\Delta u+\omega u=\left(I_{\alpha} * F(u)\right) f(u)-\left(I_{\beta} * G(u)\right) g(u) \quad \text { in } \mathbb{R}^{N} \tag{1.9}
\end{equation*}
$$

where $\omega>0$, assuming that
$\left(H_{1}^{\prime}\right)$ there is a constant $C>0$ and $p \in\left(\frac{2 \beta}{N-2}, \frac{N+\beta}{N-2}\right]$ such that $|s f(s)| \leq C\left(|s|^{\frac{N+\alpha}{N}}+|s|^{\frac{N+\alpha}{N-2}}\right)$ and

$$
\begin{aligned}
& 0 \leq g(s) s \leq C\left(|s|^{p}+|s|^{\frac{N+\beta}{N-2}}\right) \text { for } s \in \mathbb{R} \\
\left(H_{2}^{\prime}\right) & \lim _{s \rightarrow 0} \frac{F(s)}{|s|^{\frac{N+\alpha}{N}}}=\lim _{|s|^{\rightarrow+\infty}} \frac{F(s)}{|s|^{\frac{N+\alpha}{N-2}}}=0
\end{aligned}
$$

$\left(H_{3}^{\prime}\right)$ there is $s_{0}>0$ such that $F\left(s_{0}\right) \neq 0$; we assume also $F\left(s_{0}\right)>G\left(s_{0}\right)$, if $\alpha=\beta>0$, and $F^{2}\left(s_{0}\right)>G^{2}\left(s_{0}\right)+\omega s_{0}^{2}$, if $\alpha=\beta=0$.

Observe that the energy functional associated with (1.9) is given by

$$
\mathcal{K}_{\omega}(u):=\mathcal{I}(u)+\omega \int_{\mathbb{R}^{N}}|u|^{2} d x, \quad u \in H^{1}\left(\mathbb{R}^{N}\right)
$$

and may be also infinite due to the possible nonintegrable term $\left(I_{\beta} * G(u)\right) G(u)$.
Our results for equation (1.9) read as follows.
Theorem 1.3. Assume that $\left(H_{1}^{\prime}\right)-\left(H_{3}^{\prime}\right)$ hold. Then, there is a nontrivial and radial solution $u$ to (1.9) in $H^{1}\left(\mathbb{R}^{N}\right)$ such that $\left(I_{\beta} * G(u)\right) G(u) \in L^{1}\left(\mathbb{R}^{N}\right)$. Moreover, if $f$ and $g$ are odd, $N \geq 4$ and $N \neq 5$, there is also a nontrivial and nonradial solution $v$ to (1.9) in $H^{1}\left(\mathbb{R}^{N}\right) \cap X_{\tau}$ such that $\left(I_{\beta} * G(v)\right) G(v) \in L^{1}\left(\mathbb{R}^{N}\right)$.

In particular, if

$$
\begin{equation*}
F(s):=\frac{1}{\sqrt{q}}|s|^{q} \text { with } 1<q<\frac{N+\alpha}{N-2}, \text { and } G(s):=\sqrt{\frac{N-2}{N+\beta}}|s|^{\frac{N+\beta}{N-2}}, \tag{1.10}
\end{equation*}
$$

then $F$ and $G$ satisfy $\left(H_{1}^{\prime}\right)-\left(H_{3}^{\prime}\right)$ if and only if $\omega \in\left(0, \omega_{0}\right)$, where

$$
\omega_{0}:= \begin{cases}\frac{2^{*}-2 q}{2^{*}(q-1)}\left(\frac{N(q-1)}{2 q}\right)^{\frac{2^{*}-2}{2^{*}-2 q}} & \text { if } \alpha=\beta=0 \\ +\infty & \text { if } \alpha>0\end{cases}
$$

Then, finally, we obtain the following corollary.
Corollary 1.4. Suppose that $F$ and $G$ are given by (1.10).
(a) For any $\omega \in\left(0, \omega_{0}\right)$ there is a radially symmetric symmetric solution in $H^{1}\left(\mathbb{R}^{N}\right)$ and a nonradial solution in $H^{1}\left(\mathbb{R}^{N}\right) \cap X_{\tau}$ to (1.9).
(b) If $\omega \notin\left(0, \omega_{0}\right)$, then (1.9) has only trivial finite energy solution.

Corollary 1.4 has been known only in the local case $\alpha=\beta=0$ and the problem appears in nonlinear optics as well as in the the study of Bose-Einstein condensates [9, 20]. Note that solutions exist only for $0<\omega<\omega_{0}<+\infty$, see e.g. [6,13,19]. In the nonlocal case, for instance if $N=3, q=2$ and $\alpha>\beta=0$, we solve the nonlocal cubic-quintic problem of the nonlinear optics for all $\omega>0$, where $I_{\alpha}$ is a nonlocal response function determined by the details of the physical process responsible for the nonlocality [8].

Through the paper we use the following notation.
We denote by $\|\cdot\|_{k}$ the usual norm in $L^{k}\left(\mathbb{R}^{N}\right)$, for $k \geq 1$, and by $B_{R}$ the ball centered in 0 with radius $R>0$ in $\mathbb{R}^{N}$. Recall that $2^{*}=\frac{2 N}{N-2}$. Finally $C$ is a generic positive constant which may vary from line to line.

## 2. Functional setting and compactness properties

We prove our results for $\beta>0$, the most difficult and fully nonlocal situation. Thus, from now on, we assume that $0<\beta \leq \alpha<N$ and $\left(H_{1}\right)-\left(H_{3}\right)$ hold, with $p=1$ when $0<\beta<\frac{N-2}{2}$. The proofs of the paper are simplified when $\beta=0$ or $\alpha=\beta=0$ and we skip these cases.

It is standard to see that the functional $\mathcal{F}: L^{2^{*}}\left(\mathbb{R}^{N}\right) \rightarrow \mathbb{R}$, defined in (1.5) is of class $\mathcal{C}^{1}$, cf. [23].
In order to control the convergence of $\mathcal{F}$, we need the following nonlocal variant of the BrezisLieb Lemma [7] for the general nonlinarity. Note that nonlocal variants for particular nonlinearities have already appeared in [4, Lemma 2.2], [22, Lemma 2.4]. The proofs of [4,22] seem to be difficult to adapt to the general nonlinear term. We provide an independent proof for any continuous $f$ satisfying $\left(H_{1}\right)$ and $\left(H_{2}\right)$.

Lemma 2.1. Let $u_{n} \rightharpoonup u_{0}$ in $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$. Then

& \lim _{n}\left(\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}\right) f\left(u_{n}\right) u_{n} d x-\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}-u_{0}\right)\right) f\left(u_{n}\right) u_{n} d x\right)\right. \\
& \quad=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) u_{0} d x .
\end{aligned}
$$

Proof. We claim that, passing to a subsequence, for any $s \in[0,1]$,

\lim _{n} \int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{n}\right) u_{n}\right)\right) f\left(u_{n}-s u_{0}\right) u_{0} d x=\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{0}\right) u_{0}\right)\right) f\left(u_{0}-s u_{0}\right) u_{0} d x \tag{2.1}
\end{equation*}
$$

Let $\varepsilon>0$ and $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ such that $\left\|u_{0}-\psi\right\|_{2^{*}}<\varepsilon$. We have

\begin{aligned}
&\left|\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{n}\right) u_{n}\right)\right) f\left(u_{n}-s u_{0}\right) u_{0} d x-\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{0}\right) u_{0}\right)\right) f\left(u_{0}-s u_{0}\right) u_{0} d x\right| \\
& \leq \underbrace{\left|\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{n}\right) u_{n}\right)\right) f\left(u_{n}-s u_{0}\right)\left(u_{0}-\psi\right) d x\right|}_{(A)} \\
&+\underbrace{\left|\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{n}\right) u_{n}\right)\right)\left(f\left(u_{n}-s u_{0}\right)-f\left(u_{0}-s u_{0}\right)\right) \psi d x\right|}_{(B)} \\
&+\underbrace{\left|\int_{\mathbb{R}^{N}}\left(\left(I_{\alpha} *\left(f\left(u_{n}\right) u_{n}\right)\right)-\left(I_{\alpha} *\left(f\left(u_{0}\right) u_{0}\right)\right)\right) f\left(u_{0}-s u_{0}\right) \psi d x\right|}_{(D)} \\
&+\underbrace{\left|\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{0}\right) u_{0}\right)\right) f\left(u_{0}-s u_{0}\right)\left(\psi-u_{0}\right) d x\right|}_{\mathbb{R}^{N}}
\end{aligned}
$$

Since $\left\{u_{n}\right\}$ is a bounded sequence in $L^{2^{*}}\left(\mathbb{R}^{N}\right)$, we deduce by $\left(H_{1}\right)$ that $\left\{f\left(u_{n}\right) u_{n}\right\}$ is bounded in $L^{\frac{2 N}{N+\alpha}}\left(\mathbb{R}^{N}\right)$. Moreover, by the continuity, we deduce that $f\left(u_{n}\right) u_{n}$ converges to $f\left(u_{0}\right) u_{0}$ a.e. on $\mathbb{R}^{N}$ along a subsequence. Therefore $f\left(u_{n}\right) u_{n}$ tends weakly to $f\left(u_{0}\right) u_{0}$ in $L^{\frac{2 N}{N+\alpha}}\left(\mathbb{R}^{N}\right)$. As the Riesz potential defines a linear and continuous map from $L^{\frac{2 N}{N+\alpha}}\left(\mathbb{R}^{N}\right)$ to $L^{\frac{2 N}{N-\alpha}}\left(\mathbb{R}^{N}\right)$, we obtain that $I_{\alpha} *\left(f\left(u_{n}\right) u_{n}\right)$ tends weakly to $I_{\alpha} *\left(f\left(u_{0}\right) u_{0}\right)$ in $L^{\frac{2 N}{N-\alpha}}\left(\mathbb{R}^{N}\right)$. Moreover, since $u_{n}-s u_{0}$ converges to $u_{0}-s u_{0}$ in $L_{\mathrm{loc}}^{q}\left(\mathbb{R}^{N}\right)$, for $1 \leq q<2^{*}$, by $\left(H_{1}\right)$ we infer that $f\left(u_{n}-s u_{0}\right)$ converges to $f\left(u_{0}-s u_{0}\right)$ in $L_{\mathrm{loc}}^{q}\left(\mathbb{R}^{N}\right)$, for $1 \leq q<2 N /(\alpha+2)$.
Then, by the Hardy-Littlewood-Sobolev inequality and since $\left\{f\left(u_{n}-s u_{0}\right)\right\}$ is bounded in $L^{\frac{2 N}{\alpha+2}}\left(\mathbb{R}^{N}\right)$ we obtain

$$
(A) \leq C\left\|f\left(u_{n}\right) u_{n}\right\|_{\frac{2 N}{N+\alpha}}\left\|f\left(u_{n}-s u_{0}\right)\right\|_{\frac{2 N}{\alpha+2}}\left\|u_{0}-\psi\right\|_{2^{*}} \leq C \varepsilon
$$

and analogously, $(D) \leq C \varepsilon$.
Moreover, denoting by $K:=\operatorname{supp}(\psi)$, we have

(B) \leq C\left\|f\left(u_{n}\right) u_{n}\right\|_{\frac{2 N}{N+\alpha}}\left\|f\left(u_{n}-s u_{0}\right)-f\left(u_{0}-s u_{0}\right)\right\|_{L^{\frac{N(N+2 \alpha+2)}{(N+\alpha)(\alpha+2)}(K)}}\|\psi\|_{\frac{2 N(N+2 \alpha+2)}{(N+\alpha)(N-2)}}=o_{n}(1) .
$$

Finally, also $(C)=o_{n}(1)$, since $f\left(u_{0}-s u_{0}\right) \psi$ belongs to $L^{\frac{2 N}{N+\alpha}}\left(\mathbb{R}^{N}\right)$, namely the dual space of $L^{\frac{2 N}{N-\alpha}}\left(\mathbb{R}^{N}\right)$.

Therefore (2.1) is proved.
Now, for any $n \in \mathbb{N}$, we set $\phi_{n}(s)=\left(I_{\alpha} * F\left(u_{n}-s u_{0}\right)\right) f\left(u_{n}\right) u_{n}$, for $s \in[0,1]$, and we obtain

\int_{\mathbb{R}^{N}} & \left(I_{\alpha} * F\left(u_{n}\right) f\left(u_{n}\right) u_{n} d x-\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}-u_{0}\right)\right) f\left(u_{n}\right) u_{n} d x\right. \\
& =\int_{\mathbb{R}^{N}}\left(\phi_{n}(0)-\phi_{n}(1)\right) d x=-\int_{0}^{1}\left(\int_{\mathbb{R}^{N}} \phi_{n}^{\prime}(s) d x\right) d s \\
& =\int_{0}^{1}\left(\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{n}-s u_{0}\right) u_{0}\right)\right) f\left(u_{n}\right) u_{n} d x\right) d s \\
& =\int_{0}^{1}\left(\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{n}\right) u_{n}\right)\right) f\left(u_{n}-s u_{0}\right) u_{0} d x\right) d s .
\end{aligned}
$$

Hence, by (2.1), taking into account the Lebesgue Dominated Convergence Theorem

\lim _{n} & \left(\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}\right) f\left(u_{n}\right) u_{n} d x-\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}-u_{0}\right)\right) f\left(u_{n}\right) u_{n} d x\right)\right. \\
& =\lim _{n} \int_{0}^{1}\left(\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{n}\right) u_{n}\right)\right) f\left(u_{n}-s u_{0}\right) u_{0} d x\right) d s \\
& =\int_{0}^{1}\left(\lim _{n} \int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{n}\right) u_{n}\right)\right) f\left(u_{n}-s u_{0}\right) u_{0} d x\right) d s \\
& =\int_{0}^{1}\left(\int_{\mathbb{R}^{N}}\left(I_{\alpha} *\left(f\left(u_{0}\right) u_{0}\right)\right) f\left(u_{0}-s u_{0}\right) u_{0} d x\right) d s \\
& =-\int_{0}^{1}\left(\int_{\mathbb{R}^{N}} \phi_{0}^{\prime}(s) d x\right) d s=-\int_{\mathbb{R}^{N}}\left(\int_{0}^{1} \phi_{0}^{\prime}(s) d s\right) d x \\
& =\int_{\mathbb{R}^{N}}\left(\phi_{0}(0)-\phi_{0}(1)\right) d x=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) u_{0} d x .
\end{aligned}
$$

Now, let $\mathcal{O}^{\prime}=\mathcal{O}(N)$, or $\mathcal{O}^{\prime}=\mathcal{O}=\mathcal{O}(M) \times \mathcal{O}(M) \times \mathcal{O}(N-2 M) \subset \mathcal{O}(N)$ provided that $N \geq 4$ and $N \neq 5$ with $2 \leq M \leq N / 2$ and $N-2 M \neq 1$. Let $\mathcal{D}_{\mathcal{O}^{\prime}}^{1,2}\left(\mathbb{R}^{N}\right)$ be the subspace of $\mathcal{O}^{\prime}$-invariant functions. Below we demonstrate the compactness properties in the following lemmas.
Lemma 2.2. Let $u_{n} \rightharpoonup u_{0}$ in $\mathcal{D}_{\mathcal{O}^{\prime}}^{1,2}\left(\mathbb{R}^{N}\right)$. Then

\lim _{n} \int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}\right)\right) f\left(u_{n}\right) u_{n} d x=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) u_{0} d x .
$$

Proof. By Lemma 2.1, we conclude if we prove that

\lim _{n} \int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}-u_{0}\right)\right) f\left(u_{n}\right) u_{n} d x=0
$$

Indeed, by the Hardy-Littlewood-Sobolev inequality and $\left(H_{1}\right)$, we have

\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}-u_{0}\right)\right) f\left(u_{n}\right) u_{n} d x \leq C\left\|F\left(u_{n}-u_{0}\right)\right\|_{\frac{2 N}{N+\alpha}}\left\|f\left(u_{n}\right) u_{n}\right\|_{\frac{2 N}{N+\alpha}} \leq C\left\|F\left(u_{n}-u_{0}\right)\right\|_{\frac{2 N}{N+\alpha}} .
$$

The fact that $\left\|F\left(u_{n}-u_{0}\right)\right\|_{2 N /(N+\alpha)} \rightarrow 0$ is a consequence of $\left(H_{2}\right)$ and [19, Lemma A.1], where the symmetry $\mathcal{O}^{\prime}$ plays a crucial rôle.
Lemma 2.3. Let $u_{n} \rightharpoonup u_{0}$ in $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$. Then, for any $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$,

$$
\begin{equation*}
\lim _{n} \int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}\right)\right) f\left(u_{n}\right) \psi d x=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) \psi d x \tag{2.2}
\end{equation*}
$$

Proof. Arguing as in the proof of Lemma 2.1 and passing to a subsequence, we have that $f\left(u_{n}\right) \rightarrow$ $f\left(u_{0}\right)$ in $L_{\mathrm{loc}}^{q}\left(\mathbb{R}^{N}\right)$, for $1 \leq q<2 N /(\alpha+2)$, and $\left\{I_{\alpha} * F\left(u_{n}\right)\right\}$ is bounded in $L^{\frac{2 N}{N-\alpha}}\left(\mathbb{R}^{N}\right)$ and tends weakly to $I_{\alpha} * F\left(u_{0}\right)$ in $L^{\frac{2 N}{N-\alpha}}\left(\mathbb{R}^{N}\right)$. Thus, since

\begin{aligned}
& \left|\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}\right)\right) f\left(u_{n}\right) \psi d x-\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) \psi d x\right| \\
& \quad \leq \int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}\right)\right)\left|f\left(u_{n}\right)-f\left(u_{0}\right)\right||\psi| d x+\left|\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}\right)-I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) \psi d x\right|,
\end{aligned}
$$

using the same arguments as in (B) and (C) in the proof of Lemma 2.1, we get (2.2).
For what concerns the term with $G$, at least formally, we define the functional $\mathcal{G}$ as in (1.6). However, if in $\left(H_{1}\right), p<\frac{N+\beta}{N-2}$, the situation is quite different from $\mathcal{F}$ and $\mathcal{G}$ need not be finite. Indeed, in such a case, let us consider the Banach spaces

L^{\mu}(\Omega)+L^{\nu}(\Omega):=\left\{u \in \mathcal{M}(\Omega): u=u_{1}+u_{2}, u_{1} \in L^{\mu}(\Omega), u_{2} \in L^{\nu}(\Omega)\right\}

where $1 \leq \mu \leq \nu<+\infty, \Omega$ is an arbitrary subset of $\mathbb{R}^{N}$, and $\mathcal{M}(\Omega)$ is the set of the real measurable functions defined on $\Omega$, equipped with the norm

$$
\|u\|_{\mu, \nu}:=\inf _{u=u_{1}+u_{2}}\left(\left\|u_{1}\right\|_{L^{\mu}(\Omega)}+\left\|u_{2}\right\|_{L^{\nu}(\Omega)}\right)
$$

(see e.g. [2, Section 2] for more details about these spaces).
Observe that if $u \in \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right) \subset L^{2^{*}}\left(\mathbb{R}^{N}\right)$, since $|u|^{p} \in L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$ and $|u|^{\frac{N+\beta}{N-2}} \in L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)$, by [2, Proposition 2.3] and $\left(H_{1}\right)$, we get

G(u) \in L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right) \tag{2.3}
\end{equation*}
$$

Moreover, since

I_{\beta} * G(u) \leq C\left(I_{\beta} *\left(|u|^{p}+|u|^{\frac{N+\beta}{N-2}}\right)\right),
$$

by [15, Inequality (9), page 107] and [2, Proposition 2.3] we have

$$
\begin{equation*}
I_{\beta} * G(u) \in L^{\frac{2 N}{N-\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2 N}{(N-2) p-2 \beta}}\left(\mathbb{R}^{N}\right) \tag{2.4}
\end{equation*}
$$

However, this does not seem enough to assure that $\mathcal{G}(u)<+\infty$ for any $u \in \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$, and so we need a different approach. We replace $\mathcal{G}(u)$ with $\mathcal{G}_{n}(u)$ given by (1.7) together with the sequence $\left\{\varphi_{n}\right\}$ defined there.

We prove the following lemma.
Lemma 2.4. For every $n \in \mathbb{N}, \mathcal{G}_{n} \in \mathcal{C}^{1}\left(\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right), \mathbb{R}\right)$.
Proof. We divide the proof in five steps.
Step 1: $\mathcal{G}_{n}$ is well defined.
Observe that

$$
0 \leq \mathcal{G}_{n}(u) \leq \int_{B_{2 n}}\left(I_{\beta} * G(u)\right) G(u) d x
$$

and, by (2.3) and $(2.4), I_{\beta} * G(u) \in L^{\frac{2 N}{N-\beta}}\left(B_{2 n}\right)+L^{\frac{2 N}{(N-2) p-2 \beta}}\left(B_{2 n}\right) \subset L^{\frac{2 N}{N-\beta}}\left(B_{2 n}\right)$ and $G(u) \in$ $L^{\frac{2 N}{N+\beta}}\left(B_{2 n}\right)+L^{\frac{2^{*}}{p}}\left(B_{2 n}\right) \subset L^{\frac{2 N}{N+\beta}}\left(B_{2 n}\right)$. Thus, the Hölder inequality allows us to conclude.
Step 2: if $\left\{u_{m}\right\} \subset L^{2^{*}}\left(\mathbb{R}^{N}\right)$ and $u_{m} \rightarrow u$ in $L^{2^{*}}\left(\mathbb{R}^{N}\right)$, then, up to a subsequence, $I_{\beta} * G\left(u_{m}\right) \rightarrow$ $I_{\beta} * G(u)$ a.e. in $\mathbb{R}^{N}$, as $m \rightarrow+\infty$.
Since $u_{m} \rightarrow u$ in $L^{2^{*}}\left(\mathbb{R}^{N}\right)$, then, up to a subsequence, there exist $\Omega_{1} \subset \mathbb{R}^{N}$ with $\left|\Omega_{1}\right|=0$ and $w \in L^{2^{*}}\left(\mathbb{R}^{N}\right)$ such that $\left|u_{m}\right| \leq w$ and $u_{m} \rightarrow u$ in $\mathbb{R}^{N} \backslash \Omega_{1}$.
Since $w^{p}+w^{\frac{N+\beta}{N-2}} \in L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$, by [15, Inequality (9), page 107], we have that $I_{\beta} *$
$\left(w^{p}+w^{\frac{N+\beta}{N-2}}\right) \in L^{\frac{2 N}{N-\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2 N}{(N-2) p-2 \beta}}\left(\mathbb{R}^{N}\right)$ and so, there exists $\Omega_{2} \subset \mathbb{R}^{N}$, with $\left|\Omega_{2}\right|=0$, such that

$$
\frac{w^{p}(y)+w^{\frac{N+\beta}{N-2}}(y)}{|x-y|^{N-\beta}} \in L^{1}\left(\mathbb{R}^{N}\right), \quad \text { for all } x \in \mathbb{R}^{N} \backslash \Omega_{2}
$$

Thus, if we fix $x \in \mathbb{R}^{N} \backslash \Omega_{2}$, we have that

$$
\frac{G\left(u_{m}(y)\right)}{|x-y|^{N-\beta}} \rightarrow \frac{G(u(y))}{|x-y|^{N-\beta}}, \quad \text { for all } y \in \mathbb{R}^{N} \backslash \Omega_{1}
$$

and

$$
\frac{G\left(u_{m}(y)\right)}{|x-y|^{N-\beta}} \leq C \frac{\left|u_{m}(y)\right|^{p}+\left|u_{m}(y)\right|^{\frac{N+\beta}{N-2}}}{|x-y|^{N-\beta}} \leq C \frac{w^{p}(y)+w^{\frac{N+\beta}{N-2}}(y)}{|x-y|^{N-\beta}} \in L^{1}\left(\mathbb{R}^{N}\right)
$$

Hence, by the Lebesgue Dominated Convergence Theorem we can conclude.
Step 3: $\mathcal{G}_{n}$ is continuous.
Let $\left\{u_{m}\right\} \subset \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ be such that $u_{m} \rightarrow u$ in $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ as $m \rightarrow+\infty$. Up to a subsequence we have that $u_{m} \rightarrow u$ in $L^{2^{*}}\left(\mathbb{R}^{N}\right)$, $u_{m} \rightarrow u$ a.e. in $\mathbb{R}^{N}$, and there exists $w \in L^{2^{*}}\left(\mathbb{R}^{N}\right)$ such that $\left|u_{m}\right| \leq w$ a.e. in $\mathbb{R}^{N}$. Thus, since $G$ is continuous, $G\left(u_{m}\right) \rightarrow G(u)$ a.e. in $\mathbb{R}^{N}$ and, by Step 2 , $I_{\beta} * G\left(u_{m}\right) \rightarrow I_{\beta} * G(u)$ a.e. in $\mathbb{R}^{N}$. Hence

$$
\varphi_{n}(x)\left(I_{\beta} * G\left(u_{m}\right)\right) G\left(u_{m}\right) \rightarrow \varphi_{n}(x)\left(I_{\beta} * G(u)\right) G(u) \text { a.e. in } \mathbb{R}^{N}, \text { as } m \rightarrow+\infty
$$

Moreover,

$$
0 \leq \varphi_{n}(x)\left(I_{\beta} * G\left(u_{m}\right)\right) G\left(u_{m}\right) \leq C \varphi_{n}(x)\left(I_{\beta} *\left(w^{p}+w^{\frac{N+\beta}{N-2}}\right)\right)\left(w^{p}+w^{\frac{N+\beta}{N-2}}\right) \in L^{1}\left(\mathbb{R}^{N}\right)
$$

since, arguing as before, $I_{\beta} *\left(w^{p}+w^{\frac{N+\beta}{N-2}}\right) \in L^{\frac{2 N}{N-\beta}}\left(B_{2 n}\right)$ and $w^{p}+w^{\frac{N+\beta}{N-2}} \in L^{\frac{2 N}{N+\beta}}\left(B_{2 n}\right)$. Thus, the Lebesgue Dominated Convergence Theorem allows us to conclude.
Step 4: $\mathcal{G}_{n}$ is differentiable and, for any $v \in \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$,

$$
\mathcal{G}_{n}^{\prime}(u)[v]=2 \int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G(u)\right) g(u) v d x
$$

First we prove that

$$
\left|\int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G(u)\right) g(u) v d x\right|<+\infty
$$

Observe that

$$
\left|\int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G(u)\right) g(u) v d x\right| \leq \int_{B_{2 n}}\left(I_{\beta} * G(u)\right)|g(u)||v| d x
$$

and, by assumptions on $g$,

$$
|g(u)| \leq C\left(|u|^{p-1}+|u|^{\frac{\beta+2}{N-2}}\right) \in \begin{cases}L^{\frac{2 N}{\beta+2}}\left(\mathbb{R}^{N}\right)+L^{\infty}\left(\mathbb{R}^{N}\right), & \text { if } 0<\beta<\frac{N-2}{2}  \tag{2.5}\\ L^{\frac{2 N}{\beta+2}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p-1}}\left(\mathbb{R}^{N}\right), & \text { if } \frac{N-2}{2} \leq \beta<N\end{cases}
$$

In any case we have that $I_{\beta} * G(u) \in L^{\frac{2 N}{N-\beta}}\left(B_{2 n}\right)$ and, by $(2.5), g(u) \in L^{\frac{2 N}{\beta+2}}\left(B_{2 n}\right)$. Thus, the Hölder inequality allows us to conclude.
Finally, arguing as before, we prove that the map

$$
v \in \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right) \longmapsto \int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G(u)\right) g(u) v d x
$$

is continuous and this implies also the claim.
Step 5: $\mathcal{G}_{n}^{\prime}$ is continuous.
Let $v \in \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$, with $\|\nabla v\|_{2} \leq 1$ and $\left\{u_{m}\right\} \subset \mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ be such that $u_{m} \rightarrow u$ in $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ as
$m \rightarrow+\infty$. Up to a subsequence we have that $u_{m} \rightarrow u$ in $L^{2^{*}}\left(\mathbb{R}^{N}\right), u_{m} \rightarrow u$ a.e. in $\mathbb{R}^{N}$, and there exists $w \in L^{2^{*}}\left(\mathbb{R}^{N}\right)$ such that $\left|u_{m}\right| \leq w$ a.e. in $\mathbb{R}^{N}$. Moreover

$$
\begin{aligned}
\left|\mathcal{G}_{n}^{\prime}\left(u_{m}\right)[v]-\mathcal{G}_{n}^{\prime}(u)[v]\right| & \leq \int_{B_{2 n}}\left|\left(I_{\beta} * G\left(u_{m}\right)\right) g\left(u_{m}\right)-\left(I_{\beta} * G(u)\right) g(u)\right||v| d x \\
& \leq C\left(\int_{B_{2 n}}\left|\left(I_{\beta} * G\left(u_{m}\right)\right) g\left(u_{m}\right)-\left(I_{\beta} * G(u)\right) g(u)\right|^{\frac{2 N}{N+2}} d x\right)^{\frac{N+2}{2 N}} .
\end{aligned}
$$

Using also Step 2, we have that $\left(I_{\beta} * G\left(u_{m}\right)\right) g\left(u_{m}\right) \rightarrow\left[I_{\beta} * G(u)\right] g(u)$ a.e. in $\mathbb{R}^{N}$, and so, observing that, by $\left(H_{1}\right)$,

$$
\begin{aligned}
0 & \leq I_{\beta} * G\left(u_{m}\right) \leq C I_{\beta} *\left(w^{p}+w^{\frac{N+\beta}{N-2}}\right) \in L^{\frac{2 N}{N-\beta}}\left(B_{2 n}\right), \\
0 & \leq I_{\beta} * G(u) \leq C I_{\beta} *\left(|u|^{p}+|u|^{\frac{N+\beta}{N-2}}\right) \in L^{\frac{2 N}{N-\beta}}\left(B_{2 n}\right),
\end{aligned}
$$

and

$$
\begin{aligned}
\left|g\left(u_{m}\right)\right| & \leq C\left(w^{p-1}+w^{\frac{\beta+2}{N-2}}\right) \in L^{\frac{2 N}{\beta+2}}\left(B_{2 n}\right), \\
|g(u)| & \leq C\left(|u|^{p-1}+|u|^{\frac{\beta+2}{N-2}}\right) \in L^{\frac{2 N}{\beta+2}}\left(B_{2 n}\right),
\end{aligned}
$$

we can conclude by the Lebesgue Dominated Convergence Theorem.
Now we prove this further compactness result.
Lemma 2.5. Let $u_{n} \rightharpoonup u_{0}$ in $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$. Then, for any $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$,

$$
\lim _{n} \int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G\left(u_{n}\right)\right) g\left(u_{n}\right) \psi d x=\int_{\mathbb{R}^{N}}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) \psi d x .
$$

Proof. Of course it is enough to show that

$$
\lim _{n} \int_{\operatorname{supp}(\psi)}\left(I_{\beta} * G\left(u_{n}\right)\right) g\left(u_{n}\right) \psi d x=\int_{\operatorname{supp}(\psi)}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) \psi d x
$$

recalling that $\operatorname{supp}(\psi)$ is compact and then, for $n$ large enough, $\operatorname{supp}(\psi) \subset B_{n}$.
Since $u_{n} \rightarrow u_{0}$ weakly in $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$, up to a subsequence, $u_{n} \rightarrow u_{0}$ a.e. in $\mathbb{R}^{N}$ and so $G\left(u_{n}\right) \rightarrow G\left(u_{0}\right)$ a.e. in $\mathbb{R}^{N}$, as $n \rightarrow+\infty$.

Moreover $\left\{G\left(u_{n}\right)\right\}$ is bounded in $L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$. Indeed, by the assumptions on $g$, the definition of the norm in $L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2}{}^{\beta}}\left(\mathbb{R}^{N}\right)$, and [2, Corollary 2.12], we have

$$
\left\|G\left(u_{n}\right)\right\|_{\frac{2 N}{N+\beta}, \frac{2^{*}}{p}} \leq C\left(\left\|u_{n}\right\|_{2^{*}}^{p}+\left\|u_{n}\right\|_{2^{*}}^{\frac{N+\beta}{N-2}}\right) \leq C .
$$

Thus, the reflexivity of $L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$ (see [2, Corollary 2.11]) implies that there exists $\tilde{u} \in L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$ such that, up to a subsequence, $G\left(u_{n}\right) \rightharpoonup \tilde{u}$ in $L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$. We claim that $\tilde{u}=G\left(u_{0}\right)$.
Indeed, using a classical argument, (see e.g. [7, Exercise 3.4]), the weak convergence $G\left(u_{n}\right) \rightharpoonup \tilde{u}$ in $L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$ implies that there exists a sequence $\left\{z_{n}\right\} \subset L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$ such that, for all $n \in \mathbb{N}$,

$$
z_{n} \in \operatorname{conv}\left(\bigcup_{i=1}^{n}\left\{G\left(u_{i}\right)\right\}\right)
$$

and $z_{n} \rightarrow \tilde{u}$ in $L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$. Thus, by [2, Proposition 2.8$]$, up to a subsequence, we get that $z_{n} \rightarrow \tilde{u}$ a.e. in $\mathbb{R}^{N}$, that allows us to conclude.
About the sequence $\left\{I_{\beta} * G\left(u_{n}\right)\right\}$, since by $\left(H_{1}\right)$

$$
0 \leq I_{\beta} * G\left(u_{n}\right) \leq C\left(I_{\beta} *\left|u_{n}\right|^{p}+I_{\beta} *\left|u_{n}\right|^{\frac{N+\beta}{N-2}}\right) \in L^{\frac{2 N}{N-\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2 N}{(N-2) p-2 \beta}}\left(\mathbb{R}^{N}\right)
$$

using [2, Corollary 2.12], we have

$$
\begin{aligned}
\left\|I_{\beta} * G\left(u_{n}\right)\right\|_{\frac{2 N}{N-\beta}, \frac{2 N}{(N-2) p-2 \beta}} & \leq C\left(\left\|I_{\beta} *\left|u_{n}\right|^{\frac{N+\beta}{N-2}}\right\|_{\frac{2 N}{N-\beta}}+\left\|I_{\beta} *\left|u_{n}\right|^{p}\right\|_{\frac{2 N}{(N-2) p-2 \beta}}\right) \\
& \leq C\left(\left\|u_{n}\right\|_{2^{*}}^{N+2}+\left\|u_{n}\right\|_{2^{*}}^{p}\right) \leq C .
\end{aligned}
$$

Moreover, observe that the linear functional

$$
w \in L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right) \mapsto I_{\beta} * w \in L^{\frac{2 N}{N-\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2 N}{(N-2) p-2 \beta}}\left(\mathbb{R}^{N}\right)
$$

is continuous. Indeed, if $w \in L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right), w=w_{1}+w_{2}$ with $w_{1} \in L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)$ and $w_{2} \in L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$, by [15, Inequality (9), page 107] we get

$$
\left\|I_{\beta} * w\right\|_{\frac{2 N}{N-\beta}, \frac{2 N}{(N-2) p-2 \beta}} \leq\left\|I_{\beta} * w_{1}\right\|_{\frac{2 N}{N-\beta}}^{N-}+\left\|I_{\beta} * w_{2}\right\|_{\frac{2 N}{(N-2) p-2 \beta}} \leq C\left(\left\|w_{1}\right\|_{\frac{2 N}{N+\beta}}+\left\|w_{2}\right\|_{\frac{2 *}{p}}^{p}\right)
$$

and, passing to the infimum on $w_{1} \in L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)$ and $w_{2} \in L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$, we conclude.
This, combined with the weak convergence $G\left(u_{n}\right) \rightharpoonup G\left(u_{0}\right)$ in $L^{\frac{2 N}{N+\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2^{*}}{p}}\left(\mathbb{R}^{N}\right)$, implies that $I_{\beta} * G\left(u_{n}\right) \rightharpoonup I_{\beta} * G\left(u_{0}\right)$ in $L^{\frac{2 N}{N-\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2 N}{(N-2) p-2 \beta}}\left(\mathbb{R}^{N}\right)$.
Hence, as done for $f$ in Lemma 2.3, we have that

$$
\begin{aligned}
& \left|\int_{\operatorname{supp}(\psi)}\left(I_{\beta} * G\left(u_{n}\right)\right) g\left(u_{n}\right) \psi d x-\int_{\operatorname{supp}(\psi)}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) \psi d x\right| \\
& \quad \leq \int_{\operatorname{supp}(\psi)}\left(I_{\beta} * G\left(u_{n}\right)\right)\left|g\left(u_{n}\right)-g\left(u_{0}\right)\right||\psi| d x+\left|\int_{\mathbb{R}^{N}}\left(I_{\beta} * G\left(u_{n}\right)-I_{\alpha} * G\left(u_{0}\right)\right) g\left(u_{0}\right) \psi d x\right| .
\end{aligned}
$$

About the first integral, observe that, the boundedness of $\left\{u_{n}\right\}$ in $\mathcal{D}^{1,2}\left(\mathbb{R}^{N}\right)$ implies also that $u_{n} \rightarrow u_{0}$ in $L_{\mathrm{loc}}^{\tau}\left(\mathbb{R}^{N}\right)$, for all $1 \leq \tau<2^{*}$ and so, for any fixed $1 \leq \tau<2^{*}$ and $K \subset \subset \mathbb{R}^{N}$, up to a subsequence, there exists $w_{K} \in L^{\tau}(K)$ such that $\left|u_{n}\right| \leq w_{K}$ a.e. in $K$. Thus, denoting for simplicity $w:=w_{\operatorname{supp}(\psi)}$ and taking for instance

$$
\tau=\frac{N(N+2 \beta+2)}{(N-2)(N+\beta)}
$$

by the assumptions on $g$ we have

$$
\begin{gathered}
g\left(u_{n}\right) \rightarrow g\left(u_{0}\right) \text { a.e. in } \operatorname{supp}(\psi), \\
\left|g\left(u_{n}\right)\right| \leq C\left(\left|u_{n}\right|^{p-1}+\left|u_{n}\right|^{\frac{\beta+2}{N-2}}\right) \leq C\left(w^{p-1}+w^{\frac{\beta+2}{N-2}}\right) \in L^{\frac{N(N+2 \beta+2)}{(N+\beta)(\beta+2)}}(\operatorname{supp}(\psi)), \\
\left|g\left(u_{0}\right)\right| \leq C\left(\left|u_{0}\right|^{p-1}+\left|u_{0}\right|^{\frac{\beta+2}{N-2}}\right) \in L^{\frac{N(N+2 \beta+2)}{(N+\beta)(\beta+2)}}(\operatorname{supp}(\psi)) .
\end{gathered}
$$

Moreover, the boundedness of $\left\{I_{\beta} * G\left(u_{n}\right)\right\}$ in $L^{\frac{2 N}{N-\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2 N}{(N-2) p-2 \beta}}\left(\mathbb{R}^{N}\right)$ implies its boundedness in $L^{\frac{2 N}{N-\beta}}(\operatorname{supp}(\psi))+L^{\frac{2 N}{(N-2) p-2 \beta}}(\operatorname{supp}(\psi))=L^{\frac{2 N}{N-\beta}}(\operatorname{supp}(\psi))$.
Thus, by the Hölder inequality and the Lebesgue Dominated Convergence Theorem, we have
$\int_{\operatorname{supp}(\psi)}\left(I_{\beta} * G\left(u_{n}\right)\right)\left|g\left(u_{n}\right)-g\left(u_{0}\right)\right||\psi| d x \leq C\left(\int_{\operatorname{supp}(\psi)}\left|g\left(u_{n}\right)-g\left(u_{0}\right)\right|^{\frac{2 N}{N+\beta}}|\psi|^{\frac{2 N}{N+\beta}} d x\right)^{\frac{N+\beta}{2 N}}$

$$
\leq C\left(\int_{\operatorname{supp}(\psi)}\left|g\left(u_{n}\right)-g\left(u_{0}\right)\right|^{\frac{N(N+2 \beta+2)}{(N+\beta)(\beta+2)}} d x\right)^{\frac{(N+\beta)(\beta+2)}{N(N+2 \beta+2)}}=o_{n}(1) .
$$

Finally the second integral goes to 0 due to the weak convergence $I_{\beta} * G\left(u_{n}\right) \rightharpoonup I_{\beta} * G\left(u_{0}\right)$ in $L^{\frac{2 N}{N-\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2 N}{(N-2) p-2 \beta}}\left(\mathbb{R}^{N}\right)$, since $g\left(u_{0}\right) \psi \in L^{\frac{2 N}{N+\beta}}(\operatorname{supp}(\psi)) \subset\left[L^{\frac{2 N}{N-\beta}}\left(\mathbb{R}^{N}\right)+L^{\frac{2 N}{(N-2) p-2 \beta}}\left(\mathbb{R}^{N}\right)\right]^{\prime}$, being

$$
\begin{aligned}
\int_{\operatorname{supp}(\psi)}\left|g\left(u_{0}\right) \psi\right|^{\frac{2 N}{N+\beta}} d x & \leq C \int_{\operatorname{supp}(\psi)}\left(\left|u_{0}\right|^{p-1}+\left|u_{0}\right|^{\left.\frac{\beta+2}{N-2}\right)^{\frac{2 N}{N+\beta}}|\psi|^{\frac{2 N}{N+\beta}} d x}\right. \\
& \leq C\left(\int_{\operatorname{supp}(\psi)}\left(\left|u_{0}\right|^{p-1}+\left|u_{0}\right|^{\frac{\beta+2}{N-2}}\right)^{\frac{N(N+2 \beta+2)}{N+\beta)(\beta+2)}} d x\right)^{\frac{2(\beta+2)}{N+2 \beta+2}}<+\infty .
\end{aligned}
$$

## 3. Proofs of our main results

Let $X:=\mathcal{D}_{\mathcal{O}(N)}^{1,2}\left(\mathbb{R}^{N}\right)$, or $X:=\mathcal{D}_{\mathcal{O}}^{1,2}\left(\mathbb{R}^{N}\right) \cap X_{\tau}$ provided that $N \geq 4$ and $N \neq 5$. As observed before, the functional $\mathcal{I}$ could be also $+\infty$ on $X$. To avoid this problem, for every $n \geq 1$, we introduce the truncated $\mathcal{C}^{1}$-functionals $\mathcal{I}_{n}: X \rightarrow \mathbb{R}$ defined by (1.8).

The functionals $\mathcal{I}$ and $\mathcal{I}_{n}, n \geq 1$, satisfy the geometrical assumptions of the Mountain Pass Theorem. Indeed, we prove the following lemma.

Lemma 3.1. We have:
(i) there exist $\rho, c>0$ such that $\mathcal{I}(u) \geq c$ and, for every $n \geq 1, \mathcal{I}_{n}(u) \geq c$ for all $u \in X$ such that $\|\nabla u\|_{2}=\rho$;
(ii) there exists $v_{0} \in X$ with $\left\|\nabla v_{0}\right\|_{2}>\rho$ such that $\mathcal{I}\left(v_{0}\right)<0$ and, for every $n \geq 1, \mathcal{I}_{n}\left(v_{0}\right)<0$.

Proof. We prove this lemma only for $\mathcal{I}_{n}$ since similar and easier arguments hold also for $\mathcal{I}$.
The positivity of $G$ and $\varphi_{n},\left(H_{1}\right)$ and $\left(H_{2}\right)$, the Hardy-Littlewood-Sobolev and Sobolev inequalities imply
$\mathcal{I}_{n}(u) \geq\|\nabla u\|_{2}^{2}-C \int_{\mathbb{R}^{N}}\left(I_{\alpha} *|u|^{\frac{N+\alpha}{N-2}}\right)|u|^{\frac{N+\alpha}{N-2}} d x \geq\|\nabla u\|_{2}^{2}-C\|u\|_{2^{*}}^{\frac{2(N+\alpha)}{N-2}} \geq\|\nabla u\|_{2}^{2}-C\|\nabla u\|_{2}^{\frac{2(N+\alpha)}{N-2}}$.
Since $2<\frac{2(N+\alpha)}{N-2}$, we get (i).
Now let us prove (ii).
Case $X=\mathcal{D}_{\mathcal{O}(N)}^{1,2}\left(\mathbb{R}^{N}\right)$. Let $w=s_{0} \chi_{B_{1}}$, where $s_{0}$ is defined in $\left(H_{3}\right)$, then

$$
\mathcal{F}(w)=F^{2}\left(s_{0}\right) \iint_{B_{1} \times B_{1}} I_{\alpha}(x-y) d x d y>0 .
$$

We take now $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ radial, non-negative, non-increasing with respect to $|x|$, and such that $\psi(x)=s_{0}$, for $|x| \leq 1$, and $\psi(x)=0$, for $|x| \geq \bar{r}$, with $\bar{r}>1$. If $\bar{r}$ is sufficiently close to 1 , using the continuity of $\mathcal{F}$ in $L^{2^{*}}\left(\mathbb{R}^{N}\right)$, we get also

$$
\begin{equation*}
\mathcal{F}(\psi)>0 \tag{3.1}
\end{equation*}
$$

We consider first the case $\alpha>\beta$.
If we set $\psi_{\lambda}(x):=\psi(x / \lambda), \lambda>0$ and since $0 \leq \varphi_{n} \leq 1$ we have

$$
\int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G\left(\psi_{\lambda}\right)\right) G\left(\psi_{\lambda}\right) d x \leq \lambda^{N+\beta} \int_{\mathbb{R}^{N}}\left(I_{\beta} * G(\psi)\right) G(\psi) d x<+\infty
$$

So we infer that

$$
\mathcal{I}_{n}\left(\psi_{\lambda}\right) \leq \lambda^{N-2}\|\nabla \psi\|_{2}^{2}-\lambda^{N+\alpha} \mathcal{F}(\psi)+\lambda^{N+\beta} \mathcal{G}(\psi)
$$

and we can conclude considering $v_{0}:=\psi_{\lambda}$ with $\lambda$ large enough, by (3.1).
We now study the case $\alpha=\beta$.
If $G\left(s_{0}\right)=0$, being, by $\left(H_{1}\right), G$ non-decreasing on $\mathbb{R}_{+}$, then $G(\psi(x))=0$ in $\mathbb{R}^{N}$ and so we can conclude easily as before.
If, instead, $G\left(s_{0}\right) \neq 0$, by $\left(H_{3}\right)$ we can find $\varepsilon>0$ sufficiently small such that $(1-\varepsilon) F^{2}\left(s_{0}\right)>$ $G^{2}\left(s_{0}\right)>0$. Moreover there exists $\bar{r}>1$ sufficiently close to 1 such that

$$
1<\frac{\iint_{B_{\bar{r}} \times B_{\bar{r}}} I_{\alpha}(x-y) d x d y}{\iint_{B_{1} \times B_{1}} I_{\alpha}(x-y) d x d y}<\frac{(1-\varepsilon) F^{2}\left(s_{0}\right)}{G^{2}\left(s_{0}\right)}
$$

and, again by the continuity of $\mathcal{F}$ in $L^{2^{*}}\left(\mathbb{R}^{N}\right)$,

$$
\mathcal{F}(\psi) \geq(1-\varepsilon) F^{2}\left(s_{0}\right) \iint_{B_{1} \times B_{1}} I_{\alpha}(x-y) d x d y>0 .
$$

Therefore, by the positivity of $G$, we deduce that

$$
\mathcal{F}(\psi)-\mathcal{G}(\psi) \geq(1-\varepsilon) F^{2}\left(s_{0}\right) \iint_{B_{1} \times B_{1}} I_{\alpha}(x-y) d x d y-G^{2}\left(s_{0}\right) \iint_{B_{\bar{r}} \times B_{\bar{r}}} I_{\alpha}(x-y) d x d y>0 .
$$

Thus we get

$$
\mathcal{I}_{n}\left(\psi_{\lambda}\right) \leq \lambda^{N-2}\|\nabla \psi\|_{2}^{2}-\lambda^{N+\alpha}[\mathcal{F}(\psi)-\mathcal{G}(\psi)],
$$

we can conclude again considering $v_{0}:=\psi_{\lambda}$ with $\lambda$ large enough.
Case $X=\mathcal{D}_{\mathcal{O}}^{1,2}\left(\mathbb{R}^{N}\right) \cap X_{\tau}$.
We take $\varepsilon \in(0,1 / 2)$ and any odd and smooth function $\eta: \mathbb{R} \rightarrow[-1,1]$ such that $\eta(s)=1$ for $s \geq 1 / 2$ and $\eta(s)=0$ for $s \leq 1 / 2-\varepsilon$. Then we define $\widetilde{\psi}(x)=\eta\left(\left|x_{1}\right|-\left|x_{2}\right|\right) \psi(x)$ for $x=\left(x_{1}, x_{2}, x_{3}\right) \in$ $\mathbb{R}^{M} \times \mathbb{R}^{M} \times \mathbb{R}^{N-2 M}$, with the same $\psi$ as before. Observe that $\widetilde{\psi} \in X$. Moreover, arguing as in the previous case, we can find $\bar{r}>1$, sufficiently close to 1 , and $\varepsilon>0$, sufficiently close to 0 , such that, using the continuity of $\mathcal{F}$ in $L^{2^{*}}\left(\mathbb{R}^{N}\right)$,

$$
\mathcal{F}(\widetilde{\psi}) \geq \frac{1}{2} F^{2}\left(s_{0}\right) \iint_{B_{1} \times B_{1} \cap\left\{\left|x_{1}\right| \geq\left|x_{2}\right|+1 / 2,\left|y_{1}\right| \geq\left|y_{2}\right|+1 / 2\right\}} I_{\alpha}(x-y) d x d y>0 .
$$

Then we argue similarly as in case $X=\mathcal{D}_{\mathcal{O}(N)}^{1,2}\left(\mathbb{R}^{N}\right)$.
Let

$$
\Gamma:=\left\{\gamma \in \mathcal{C}([0,1], X): \gamma(0)=0 \text { and } \gamma(1)=v_{0}\right\}
$$

and

$$
c_{\mathcal{I}_{n}}:=\inf _{\gamma \in \Gamma} \sup _{t \in[0,1]} \mathcal{I}_{n}(\gamma(t)), \quad c_{\mathcal{I}}:=\inf _{\gamma \in \Gamma} \sup _{t \in[0,1]} \mathcal{I}(\gamma(t)) .
$$

Our aim is to find a sequence $\left\{u_{n}\right\} \subset X$ such that $\mathcal{I}_{n}\left(u_{n}\right)=c_{\mathcal{I}_{n}}$ and $\mathcal{I}_{n}^{\prime}\left(u_{n}\right) \rightarrow 0$, as $n \rightarrow+\infty$. However, due to the general assumptions on $F$ and $G$, it is not easy to prove the boundedness of such sequence. Therefore, inspired by [10,11], we introduce the functional $\mathcal{J}: \mathbb{R} \times X \rightarrow \mathbb{R} \cup\{+\infty\}$

$$
\mathcal{J}(\sigma, u):=\mathcal{I}\left(u\left(e^{-\sigma} \cdot\right)\right)=e^{(N-2) \sigma}\|\nabla u\|_{2}^{2}-e^{(N+\alpha) \sigma} \mathcal{F}(u)+e^{(N+\beta) \sigma} \mathcal{G}(u),
$$

and, for every $n \geq 1$, the $\mathcal{C}^{1}$-functionals $\mathcal{J}_{n}: \mathbb{R} \times X \rightarrow \mathbb{R}$
$\mathcal{J}_{n}(\sigma, u):=\mathcal{I}_{n}\left(u\left(e^{-\sigma} \cdot\right)\right)=e^{(N-2) \sigma}\|\nabla u\|_{2}^{2}-e^{(N+\alpha) \sigma} \mathcal{F}(u)+e^{(N+\beta) \sigma} \int_{\mathbb{R}^{N}} \varphi_{n}\left(e^{\sigma} x\right)\left(I_{\beta} * G(u)\right) G(u) d x$.
Since the functional $\mathcal{J}_{n}$ is non-autonomous, contrary to $[10,11]$, we have to deal with an additional term which appears in the calculus of the gradient of $\mathcal{J}_{n}$, see Proposition 3.2 below.

Let

$$
\Sigma:=\left\{(\sigma, \gamma) \in \mathcal{C}([0,1], \mathbb{R} \times X):(\sigma(0), \gamma(0))=(0,0) \text { and }(\sigma(1), \gamma(1))=\left(0, v_{0}\right)\right\}
$$

and

$$
c_{\mathcal{J}_{n}}:=\inf _{(\sigma, \gamma) \in \Sigma} \sup _{t \in[0,1]} \mathcal{J}_{n}(\sigma(t), \gamma(t)), \quad c_{\mathcal{J}}:=\inf _{(\sigma, \gamma) \in \Sigma} \sup _{t \in[0,1]} \mathcal{J}(\sigma(t), \gamma(t))
$$

As observed in [10, Lemma 4.1], using the relation, respectively, between $\mathcal{I}$ and $\mathcal{J}$ and $\mathcal{I}_{n}$ and $\mathcal{J}_{n}$, we have that

$$
\begin{equation*}
c_{\mathcal{I}}=c_{\mathcal{J}}, \quad c_{\mathcal{I}_{n}}=c_{\mathcal{J}_{n}} \tag{3.2}
\end{equation*}
$$

Since, for any $n \in \mathbb{N}, \mathcal{J}_{n} \leq \mathcal{J}_{n+1} \leq \mathcal{J}$, we have that the sequence $\left\{c_{\mathcal{J}_{n}}\right\}$ is increasing and bounded from above by $c_{\mathcal{J}}$, and so there exists $\bar{c}>0$ such that $c_{\mathcal{J}_{n}} \rightarrow \bar{c}$, as $n \rightarrow+\infty$.

Proposition 3.2. There is a sequence $\left\{\left(\sigma_{n}, u_{n}\right)\right\}$ in $\mathbb{R} \times X$ such that
(i) $\left|\mathcal{J}_{n}\left(\sigma_{n}, u_{n}\right)-\bar{c}\right|=o_{n}(1)$;
(ii) $\left|\sigma_{n}\right|=o_{n}(1)$;
(iii) $\left\|\nabla \mathcal{J}_{n}\left(\sigma_{n}, u_{n}\right)\right\|=o_{n}(1)$;
(iv) $\left\{u_{n}\right\}$ is bounded in $X$.

Proof. In view of (3.2), for any $n \geq 1$ we find $\gamma_{k, n} \in \Gamma$ such that

$$
\sup _{t \in[0,1]} \mathcal{I}_{k}\left(\gamma_{k, n}(t)\right) \leq c_{\mathcal{J}_{k}}+\frac{1}{n}
$$

and, for sufficiently large $k$,

$$
\left|c_{\mathcal{J}_{k}}-\bar{c}\right| \leq \frac{1}{n}
$$

also holds. Therefore, passing to a subsequence with a diagonalization argument, we may assume that there exists $\gamma_{n} \in \Gamma$ (hence $\left.\left(0, \gamma_{n}\right) \in \Sigma\right)$ such that

$$
\sup _{t \in[0,1]} \mathcal{J}_{n}\left(0, \gamma_{n}(t)\right) \leq c_{\mathcal{J}_{n}}+o_{n}(1) \quad \text { and } \quad\left|c_{\mathcal{J}_{n}}-\bar{c}\right| \leq o_{n}(1)
$$

Thus, by [28, Theorem 2.8], for any $n \geq 1$ there is $\left(\sigma_{n}, u_{n}\right) \in \mathbb{R} \times X$ such that (i)-(iii) hold.
Since $\mathcal{J}_{n}\left(\sigma_{n}, u_{n}\right)=\bar{c}+o_{n}(1)$ and $\partial_{\sigma} \mathcal{J}_{n}\left(\sigma_{n}, u_{n}\right)=o_{n}(1)$, we have

$$
\begin{aligned}
&\left(1-\frac{N-2}{N+\alpha}\right) e^{(N-2) \sigma_{n}} \int_{\mathbb{R}^{N}}\left|\nabla u_{n}\right|^{2} d x+\left(1-\frac{N+\beta}{N+\alpha}\right) e^{(N+\beta) \sigma_{n}} \int_{\mathbb{R}^{N}} \varphi_{n}\left(e^{\sigma_{n}} x\right)\left(I_{\beta} * G\left(u_{n}\right)\right) G\left(u_{n}\right) d x \\
&-\frac{1}{N+\alpha} e^{(N+\beta) \sigma_{n}} \int_{\mathbb{R}^{N}}\left(\nabla \varphi_{n}\left(e^{\sigma_{n}} x\right) \cdot e^{\sigma_{n}} x\right)\left(I_{\beta} * G\left(u_{n}\right)\right) G\left(u_{n}\right) d x=\bar{c}+o_{n}(1)
\end{aligned}
$$

Since the cut-off functions $\varphi_{n}$ are decreasing with respect to the radius, we have that $\nabla \varphi_{n}(x) \cdot x \leq 0$, for any $x \in \mathbb{R}^{N}$ and so, being $\alpha \geq \beta$, we infer that $\left\{u_{n}\right\}$ is a bounded sequence in $X$.

We can now conclude the proof of our main theorems.
Proof of Theorems 1.1 and 1.2. Let $\left\{\left(\sigma_{n}, u_{n}\right)\right\}$ in $\mathbb{R} \times X$ be the sequence found in Proposition 3.2. Then there exists $u_{0} \in X$ such that $u_{n} \rightharpoonup u_{0}$ weakly in $X$ and a.e. on $\mathbb{R}^{N}$. By Lemma 2.3 and Lemma 2.5, for any $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, we have that

$$
\int_{\mathbb{R}^{N}} \nabla u_{0} \cdot \nabla \psi d x=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) \psi d x-\int_{\mathbb{R}^{N}}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) \psi d x
$$

So we have that $u_{0}$ is a weak solution of (1.1). We will prove that $u_{0} \neq 0$.
Observe that, by Proposition 3.2, since $\left\{u_{n}\right\}$ is bounded in $X$ and $\partial_{u} \mathcal{J}_{n}\left(\sigma_{n}, u_{n}\right)\left[u_{n}\right]=o_{n}(1)$, we deduce that there exists $C>0$ such that, for any $n \geq 1$,

$$
\int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G\left(u_{n}\right)\right) g\left(u_{n}\right) u_{n} d x \leq C .
$$

Therefore, by Fatou's Lemma

$$
\begin{equation*}
\int_{\mathbb{R}^{N}}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) u_{0} d x \leq \liminf _{n} \int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G\left(u_{n}\right)\right) g\left(u_{n}\right) u_{n} d x \leq C . \tag{3.3}
\end{equation*}
$$

For any $m \geq 1$, let

$$
\psi_{m}(x)= \begin{cases}1 & \text { if }|x| \leq m \\ \frac{2 m-|x|}{m} & \text { if } m \leq|x| \leq 2 m \\ 0 & \text { if }|x| \geq 2 m\end{cases}
$$

Observe that, for any $m \geq 1$, we have that $\psi_{m} u_{0}$ belongs to $X$. Note that $\psi_{m} u_{0}$ has a compact support and $\partial_{u} \mathcal{J}_{n}\left(\sigma_{n}, u_{n}\right)\left[\psi_{m} u_{0}\right]=o_{n}(1)$. Therefore, arguing as in Lemma 2.3 and in Lemma 2.5, passing to the limit as $n \rightarrow+\infty$, we have that for any $m \geq 1$

$$
\begin{equation*}
\int_{\mathbb{R}^{N}} \nabla u_{0} \cdot \nabla\left(\psi_{m} u_{0}\right) d x=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) \psi_{m} u_{0} d x-\int_{\mathbb{R}^{N}}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) \psi_{m} u_{0} d x \tag{3.4}
\end{equation*}
$$

Being $u_{0} \in X$, we have

$$
\begin{align*}
& \left.\left|\int_{\mathbb{R}^{N}} \quad \nabla u_{0} \cdot \nabla\left(\psi_{m} u_{0}\right) d x-\int_{\mathbb{R}^{N}}\right| \nabla u_{0}\right|^{2} d x \mid \\
& \\
& \quad \leq \int_{\mathbb{R}^{N}}\left|\nabla u_{0}\right|^{2}\left|\psi_{m}-1\right| d x+\int_{\mathbb{R}^{N}}\left|\nabla u_{0}\right|\left|u_{0}\right|\left|\nabla \psi_{m}\right| d x  \tag{3.5}\\
& \\
& \quad \leq \int_{B_{m}^{c}}\left|\nabla u_{0}\right|^{2} d x+\left(\int_{A_{m}}\left|\nabla u_{0}\right|^{2} d x\right)^{\frac{1}{2}}\left(\int_{A_{m}}\left|u_{0}\right|^{2^{*}} d x\right)^{\frac{1}{2^{*}}}\left(\int_{A_{m}}\left|\nabla \psi_{m}\right|^{N} d x\right)^{\frac{1}{N}} \\
& \\
& \quad \leq \int_{B_{m}^{c}}\left|\nabla u_{0}\right|^{2} d x+C\left(\int_{B_{m}^{c}}\left|\nabla u_{0}\right|^{2} d x\right)^{\frac{1}{2}}\left(\int_{B_{m}^{c}}\left|u_{0}\right|^{2^{*}} d x\right)^{\frac{1}{2^{*}}} \\
& \\
& \quad=o_{m}(1),
\end{align*}
$$

where $A_{m}:=B_{2 m} \backslash B_{m}$.
Moreover, observe that

$$
\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) \psi_{m} u_{0} \rightarrow\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) u_{0}, \quad \text { a.e. in } \mathbb{R}^{N}, \text { as } m \rightarrow+\infty,
$$

and

$$
\left|\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) \psi_{m} u_{0}\right| \leq\left|\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) u_{0}\right| \in L^{1}\left(\mathbb{R}^{N}\right) .
$$

Thus, by the Dominated Convergence Theorem, we have that

$$
\begin{equation*}
\lim _{m} \int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) \psi_{m} u_{0} d x=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) u_{0} d x . \tag{3.6}
\end{equation*}
$$

Analogously, we have also that

$$
\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) \psi_{m} u_{0} \rightarrow\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) u_{0}, \quad \text { a.e. in } \mathbb{R}^{N}, \text { as } m \rightarrow+\infty,
$$

and, using (3.3),

$$
0 \leq\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) \psi_{m} u_{0} \leq\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) u_{0} \in L^{1}\left(\mathbb{R}^{N}\right)
$$

Again the Dominated Convergence Theorem implies

$$
\begin{equation*}
\lim _{m} \int_{\mathbb{R}^{N}}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) \psi_{m} u_{0} d x=\int_{\mathbb{R}^{N}}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) u_{0} d x . \tag{3.7}
\end{equation*}
$$

Therefore, by (3.4), (3.5), (3.6) and (3.7), we have

$$
\int_{\mathbb{R}^{N}}\left|\nabla u_{0}\right|^{2} d x=\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) u_{0} d x-\int_{\mathbb{R}^{N}}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) u_{0} d x .
$$

By Lemma 2.2 and (3.3), since $\partial_{u} \mathcal{J}_{n}\left(\sigma_{n}, u_{n}\right)\left[u_{n}\right]=o_{n}(1)$, we infer that

$$
\begin{aligned}
\limsup _{n} \int_{\mathbb{R}^{N}}\left|\nabla u_{n}\right|^{2} d x & =\underset{n}{\limsup }\left[\int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{n}\right)\right) f\left(u_{n}\right) u_{n} d x-\int_{\mathbb{R}^{N}} \varphi_{n}(x)\left(I_{\beta} * G\left(u_{n}\right)\right) g\left(u_{n}\right) u_{n} d x\right] \\
& \leq \int_{\mathbb{R}^{N}}\left(I_{\alpha} * F\left(u_{0}\right)\right) f\left(u_{0}\right) u_{0} d x-\int_{\mathbb{R}^{N}}\left(I_{\beta} * G\left(u_{0}\right)\right) g\left(u_{0}\right) u_{0} d x=\int_{\mathbb{R}^{N}}\left|\nabla u_{0}\right|^{2} d x .
\end{aligned}
$$

This implies that $u_{n} \rightarrow u_{0}$ strongly in $X$. Thus, since $\mathcal{J}_{n}\left(\sigma_{n}, u_{n}\right) \rightarrow \mathcal{I}\left(u_{0}\right)$, we have that $\mathcal{I}\left(u_{0}\right)=$ $\bar{c}>0$ and so $u_{0}$ is a nontrivial weak solution of (1.1).
Remark 3.3. By the inspection of the proof of Theorems 1.1 and 1.2, we deduce that $c_{\mathcal{I}_{n}}=c_{\mathcal{J}_{n}}$ are attained, for any $n \geq 1$.

Proof of Theorem 1.3. The proof is a slight modification of our previous arguments. Here we just want to comment $\left(H_{3}^{\prime}\right)$. The change of assumption in the different cases is due to the scaling properties of the functional $\mathcal{K}_{\omega}$. Indeed, setting $u_{\lambda}(x):=u(x / \lambda)$, for $\lambda>0$, when $\alpha=\beta$ we have

$$
\mathcal{K}_{\omega}\left(u_{\lambda}\right)=\lambda^{N-2}\|\nabla u\|_{2}^{2}+\omega \lambda^{N}\|u\|_{2}^{2}-\lambda^{N+\alpha}(\mathcal{F}(u)-\mathcal{G}(u)) .
$$

Thus, to show the Mountain Pass geometry, if $\alpha=\beta>0$, we can proceed as in Lemma 3.1, but if $\alpha=\beta=0$ (the local case), we need a stronger condition, namely we need to take into account the term $\omega s_{0}^{2}$ in order to show that $\mathcal{K}_{\omega}\left(u_{\lambda}\right)<0$ for large $\lambda$ (see also [6]).

Proof of Corollary 1.4. Item (a) follows from Theorem 1.3.
To prove (b), observe that, only in the local case $\alpha=\beta=0, \omega_{0}$ is finite. Thus, in such a case, if $\omega \geq \omega_{0}$, then $F^{2}(s)-G^{2}(s)-\omega_{0} s^{2} \leq 0$ for $s \in \mathbb{R}$ and there are no nontrivial solutions (see e.g. [6]). If, instead, $\omega \leq 0$, similarly as in [23, Theorem 3], if $u \in H^{1}\left(\mathbb{R}^{N}\right)$ solves (1.9) with (1.10), then we obtain the following Pohozaev identity

$$
\|\nabla u\|_{2}^{2}=-\omega \frac{N}{N-2}\|u\|_{2}^{2}+\frac{N+\alpha}{q(N-2)} \int_{\mathbb{R}^{N}}\left(I_{\alpha} *|u|^{q}\right)|u|^{q} d x-\int_{\mathbb{R}^{N}}\left(I_{\beta} *|u|^{\frac{N+\beta}{N-2}}\right)|u|^{\frac{N+\beta}{N-2}} d x
$$

and, taking into account $\mathcal{K}_{\omega}^{\prime}(u)[u]=0$, i.e.

$$
\|\nabla u\|_{2}^{2}=-\omega\|u\|_{2}^{2}+\int_{\mathbb{R}^{N}}\left(I_{\alpha} *|u|^{q}\right)|u|^{q} d x-\int_{\mathbb{R}^{N}}\left(I_{\beta} *|u|^{\frac{N+\beta}{N-2}}\right)|u|^{\frac{N+\beta}{N-2}} d x,
$$

we infer that $u=0$.
