# Singularities in the weak turbulence regime for the quintic Schrödinger equation

#### Abstract

In this paper, we discuss the problem of derivation of kinetic equations from the theory of weak turbulence for the quintic Schrödinger equation. We study the quintic Schrödinger equation on $L \mathbb{T}$, with $L \gg 1$ and with a non-linearity of size $\varepsilon \ll 1$. We consider the correlations $f(T)$ of the Fourier coefficients of the solution at times $t=T \varepsilon^{-2}$ when $\varepsilon \rightarrow 0$ and $L \rightarrow \infty$. Our results can be summed up in the following way: there exists a regime for $\varepsilon$ and $L$ such that for $T$ dyadic, $f(T)$ has the form expected from the physics literature, but such that $f$ has an infinite number of discontinuity points.

## 1 Introduction

In this paper, we discuss the problem of derivation of kinetic equations from the theory of weak turbulence for the quintic Schrödinger equation.

Weak turbulence has been introduced by Zakharov, see for example [17], and an extensive literature has been developed in Physics, as it is reviewed in the book by Nazarenko, [16].

We first describe the expected result before describing our framework and results.
Consider the quintic Schrödinger Cauchy problem :

\left\{\begin{array}{c}
i \partial_{t} u_{\varepsilon, L}=-\Delta u_{\varepsilon, L}+\varepsilon\left|u_{\varepsilon, L}\right|^{4} u_{\varepsilon, L}  \tag{1}\\
u_{\varepsilon, L}(t=0)=a_{L}
\end{array}\right.
$$

on the torus $L \mathbb{T}, L \gg 1$, with $\varepsilon \ll 1$ and with initial datum

$$
a_{L}=\sum_{k \in \mathbb{Z}} a(k / L) \frac{e^{i k x / L}}{\sqrt{2 \pi L}} g_{k}
$$

where $\left(g_{k}\right)_{k}$ is a sequence of independent centered and normalized Gaussian variables, and $a$ is a smooth, compactly supported map.

The map $u_{\varepsilon, L}$ is a map from $\mathbb{R} \times(L \mathbb{T}) \times \Omega$ where $\Omega$ is a probability space supporting the $\left(g_{k}\right)_{k}$, and $\Delta$ is the Laplace-Beltrami operator on $L \mathbb{T}$.

The issue at stake is the description of the dynamics of

$$
\mathbb{E}\left(\left|\hat{u}_{\varepsilon, L}(t, k)\right|^{2}\right)
$$

as $\varepsilon$ goes to 0 and $L$ goes to $\infty$, for any $k \in \frac{1}{L} \mathbb{Z}$, where

$$
\hat{u}_{\varepsilon, L}(t, k):=\frac{1}{\sqrt{2 \pi L}} \int_{L \mathbb{T}} e^{-i k x} u_{\varepsilon, L}(t, x) d x
$$

is the Fourier transform of $u_{\varepsilon, L}$.
Note that because the law of the initial datum $a_{L}$ and the equation are invariant under the action of space translations, we have

$$
\left.\mathbb{E}\left(\overline{\hat{u}_{\varepsilon, L}\left(t, k^{\prime}\right)}\right) \hat{u}_{\varepsilon, L}(t, k)\right)=0
$$

at all times $t \in \mathbb{R}$, if $k \neq k^{\prime}$.
The ersatz is the following. Approaching $u_{\varepsilon, L}$ by its 0 -th, first and second Picard iterates, we get up to second order in $\varepsilon$,

$$
u_{\varepsilon, L}(t) \sim e^{i t \Delta} a_{L}+\varepsilon b_{L}(t)+\varepsilon^{2} c_{L}(t)
$$

where $b_{L}$ and $c_{L}$ are solutions to the equations

$$
\left\{\begin{array}{c}
i \partial_{t} b_{L}=-\Delta b_{L}+\left|e^{i t \Delta} a_{L}\right|^{4}\left(e^{i t \Delta} a_{L}\right) \\
i \partial_{t} c_{L}=-\Delta c_{L}+3\left|e^{i t \Delta} a_{L}\right|^{4} b_{L}+2 b_{L}\left|e^{i \Delta \Delta} a_{L}\right|^{2}\left(e^{i t \Delta} a_{L}\right)^{2}
\end{array}\right.
$$

with initial datum $b_{L}(t=0)=c_{L}(t=0)=0$.
Up to second order, we thus get

$$
\partial_{t} \mathbb{E}\left(\left|\hat{u}_{\varepsilon, L}(t, k)\right|^{2}\right) \sim 2 \varepsilon \operatorname{Re}\left(\overline{e^{i t \Delta} a_{L}}(t, k) \partial_{t} \hat{b}_{L}(t, k)\right)+2 \varepsilon^{2} \operatorname{Re}\left(\overline{\left(\overline{e^{i t \Delta} a_{L}}(t, k)\right.} \partial_{t} \hat{c}_{L}(t, k)+\overline{\hat{b}_{L}(t, k)} \partial_{t} \hat{b}_{L}(t, k)\right)
$$

Because of probabilistic cancellations due to the law of the initial datum $a_{L}$, the term

$$
\left.\operatorname{Re} \overline{\left(\overline{e^{i t \Delta} a_{L}}(t, k)\right.} \partial_{t} \hat{b}_{L}(t, k)\right)
$$

involves only first order trivial resonances, which can be removed from the solution by multiplicating y a phase, see [6, 15] for a discussion in different contexts.

This suggests that the right scale of time is $\varepsilon^{-2}$, and thus we consider the quantity

$$
U_{\varepsilon, L}(t, k)=\mathbb{E}\left(\left|\hat{u}_{\varepsilon, L}\left(t \varepsilon^{-2}, k\right)\right|^{2}\right)
$$

with

$$
\left.\partial_{t} U_{\varepsilon, L}(t, k) \sim 2 \operatorname{Re} \overline{\left(e^{i t \varepsilon^{-2} \Delta} a_{L}(k)\right.} \partial_{t} \hat{c}_{L}\left(t \varepsilon^{-2}, k\right)+\overline{\hat{b}_{L}\left(t \varepsilon^{-2}, k\right)} \partial_{t} \hat{b}_{L}\left(t \varepsilon^{-2}, k\right)\right)
$$

This is valid only if the right hand side is not null.
By taking $L \rightarrow \infty$ and $\varepsilon \rightarrow 0$, we expect to get

$$
\begin{equation*}
U_{\varepsilon, L}(t, k)=\frac{3}{2 \pi^{3}} \int_{\mathbb{R}^{5}} \delta\left(k+\sum_{j=1}^{5}(-1)^{j} k_{j}\right) \delta(\Delta(k, \vec{k})) \frac{1}{k-k_{1}+k_{2}-k_{3}}|a(k)|^{2} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} F_{a}(k, \vec{k}) d \vec{k} \tag{2}
\end{equation*}
$$

where $\vec{k}=\left(k_{1}, \ldots, k_{5}\right)$, where

$$
F_{a}(k, \vec{k})=\left(\frac{1}{|a(k)|^{2}}-\frac{1}{\left|a\left(k_{1}\right)\right|^{2}}+\frac{1}{\left|a\left(k_{2}\right)\right|^{2}}-\frac{1}{\left|a\left(k_{3}\right)\right|^{2}}+\frac{1}{\left|a\left(k_{4}\right)\right|^{2}}-\frac{1}{\left|a\left(k_{5}\right)\right|^{2}}\right),
$$

where $\Delta(k, \vec{k})=k^{2}-k_{1}^{2}+k_{2}^{2}-k_{3}^{2}+k_{4}^{2}-k_{5}^{2}$ and where the $\delta$ s are Dirac deltas. The integral converges.
The aim of this paper is to illustrate the fact that this limit is far from being obvious. The reason is that the Picard expansion does not uniformly converge in $L$ for times of order $\varepsilon^{-2}$, the $L^{2}$ Lebesgue norm of the initial datum $a_{L}$ growing with $L$. The series of paper [1, 2, 3, 6] have reached larger and larger times by developing fine analytic estimates for the cubic Schrödinger equation due to the algebraic structure of the non-linearity. In particular, they estimate so-called Dyson series. In the series of papers [8, 9, 10], Dymov and Kuksin reach a satisfying result at times of order $\varepsilon^{-1}$, by using quasi-solutions for the cubic Schrödinger equation, a notion coming from the Physics literature. We take here an approach closer to their point of view. We also mention the works [15] on cubic equations on nets, and [4, 5] on quadratic equations coming fluid mechanics. For a general bibliographical review on connected subjects, we refer to [3] and references therein.

Apart from the model (quintic Vs cubic or quadratic equations), chosen to get a nontrivial manifold for the first order resonances, even when the dimension is 1 , the main differences with the above literature are threefold. One important aspect of this work is that, to justify the use of quasisolutions, we use the stochastic tool of Wick products. A side advantage of this is that we avoid
certain possible correlations, that would diverge at times of order $\varepsilon^{-2}$. Another main difference is that, in order to reach times of order $\varepsilon^{-2}$, we prepare the approximation of the equation in $L \mathbb{T}$. We justify this approximation in the next subsections. It allows to reach very large times. Finally, we exhibit a regime for $\varepsilon$ and $L$ such that depending on the time $t \in \mathbb{R}$, we can get different behaviors for the sequence $U_{\varepsilon, L}(t, k)$.

We now describe our framework and results.

### 1.1 Framework

Let $\left(\xi_{k}\right)_{k \in \mathbb{Z}}$ be a sequence of real, independent, centered and normalized Gaussian variables. We write $(\Omega, \mathcal{F}, \mathbb{P})$ their underlying probability space and $\mathcal{A}$ the $\sigma$-algebra generated by the $\left(\xi_{k}\right)_{k}$. Given a well-chosen sequence $\left(q_{k}\right)_{k \in \mathbb{Z}}$ of positive real numbers, we define $\mathcal{S}_{-1}\left(H^{s}(L \mathbb{T})\right), s>\frac{1}{2}$ the space of Kondratiev's distributions of $(\Omega, \mathcal{A}, \mathbb{P})$ on $H^{s}(L \mathbb{T})$. For the exact definition of Kondratiev's distributions, we refer to Subsection 2.1. Here, we use the terminology of [12, [14], and for the general definition of Kondratiev's distributions, we refer to the original work [13]. The Wick product (see again Subsection 2.1) is well-defined on $\mathcal{S}_{-1}\left(H^{s}(L \mathbb{T})\right.$ ), we denote it $\diamond$.

Let $F_{L}$ be the map defined on Fourier mode by, for all $k \in \frac{1}{L} \mathbb{Z}$,

\widehat{F_{L}}(\alpha, \beta, \gamma, \delta, \eta)(k)=\frac{1}{(2 \pi L)} \sum_{C_{L}(k)} \hat{\alpha}\left(k_{1}\right) \diamond \overline{\hat{\beta}\left(k_{2}\right)} \diamond \gamma\left(k_{3}\right) \diamond \bar{\delta}\left(k_{4}\right) \diamond \eta\left(k_{5}\right)
$$

where

$$
\begin{align*}
& C_{L}(k)=\left\{\left.\left(k_{1}, k_{2}, k_{3}, k_{4}, k_{5}\right) \in\left(\frac{1}{L} \mathbb{Z}\right)^{5} \right\rvert\, k_{1}-k_{2}+k_{3}-k_{4}+k_{5}=k,\right. \\
& \left.\quad\left|k-k_{1}+k_{2}-k_{3}\right| \geq \mu^{-1}(L), \quad\left|k^{2}-k_{1}^{2}+k_{2}^{2}-k_{3}^{2}+k_{4}^{2}-k_{5}^{2}\right| \geq v^{-1}(L)\right\} \tag{3}
\end{align*}
$$

and where we used the abuse of notation

$$
\hat{\alpha}\left(k_{1}\right) \diamond \hat{\beta}\left(k_{2}\right)=\left(\left(\hat{\alpha}\left(k_{1}\right) e^{i k_{1} x}\right) \diamond\left(\hat{\beta}\left(k_{2}\right) e^{i k_{2} x}\right)\right) e^{-i\left(k_{1}+k_{2}\right) x} .
$$

Note that taking $\left(u_{L}\right)$ a sequence of maps such that $u_{L} \in \mathcal{S}^{-1}\left(H^{s}(L \mathbb{T})\right)$ and such that for any $\alpha \in \mathbb{N}_{f}^{Z}$, the sequence $\left\|\left(u_{L}\right)_{\alpha}\right\|_{H^{s}(L T)}$ is uniformly bounded in $L$ (see Remark 3.1 for the relevance of this property), then we have that for all smooth and compactly supported map $f$, and all $\alpha \in \mathbb{N}_{f}^{\mathbb{Z}}$,

$$
\left\langle f, F_{L}(u, u, u, u, u)_{\alpha}-(u \diamond \bar{u} \diamond u \diamond \bar{u} \diamond u)_{\alpha}\right\rangle \underset{L \rightarrow \infty}{\rightarrow} 0
$$

where $\langle\cdot, \cdot\rangle$ is the inner product in $\mathbb{R}$, as soon as $v$ goes to $\infty$ with $L$.
We consider the Cauchy problem

$$
\left\{\begin{array}{c}
i \partial_{t} u_{\varepsilon, L}=-\Delta u_{\varepsilon, L}+\varepsilon F_{L}(u, u, u, u, u)  \tag{4}\\
u_{\varepsilon, L}(t=0)=a_{L}
\end{array}\right.
$$

where $a_{L}$ is given by

$$
a_{L}=\sum_{k \in \mathbb{Z}} a(k / L) \frac{e^{i k x / L}}{\sqrt{2 \pi L}} g_{k}
$$

where $g_{k}=\frac{1}{\sqrt{2}}\left(\xi_{\varphi(0, k)}+i \xi_{\varphi(1, k)}\right)$ with $\varphi$ a bijection from $\{0\} \times \mathbb{Z} \sqcup\{1\} \times \mathbb{Z}$ to $\mathbb{Z}$. The sequence $\left(g_{k}\right)_{k}$ is a sequence of independent, centered, normalized complex Gaussian variables. This is the classical way of extending real Gaussian Hilbert spaces to complex ones.

We call $P_{N}$ the projection onto the Wiener chaos of degree at most $N$.
We are now ready to state the results.

### 1.2 Results

Theorem 1.1. For any $L \in \mathbb{N}^{*}$, there exists a Banach algebra $X \subseteq \mathcal{S}_{-1}\left(H^{s}(L \mathbb{T})\right)$ into which the Cauchy problem (4) is globally well-posed and such that $a_{L} \in X$. Set $N \in \mathbb{N}^{*}, M \geq N$, and set $f$ and $g$ two smooth compactly supported maps of $\mathbb{R}$.

Assume that $\varepsilon$ writes

$$
\varepsilon^{-2}=2 \pi L^{2} 2^{L}+\rho(L)
$$

that $\rho, \nu$ and $\mu$ satisfy the following relationships :

$$
\left\{\begin{align*}
& \exists \alpha>0, v(L)^{1+\alpha}=o\left(L^{1 / 2}\right)  \tag{5}\\
& \rho(L)=o(\mu(L)) \\
& \rho(L) \mu(L)=o(v(L)) \\
& \ln ^{2}(\mu(L))=o\left(\rho^{1 / 4}\right) \\
& \mu(L) \rightarrow \infty \\
& \rho(L) \rightarrow \infty
\end{align*}\right.
$$

and finally assume that $t$ is dyadic.
Then, we have

$$
\begin{aligned}
& \lim _{L \rightarrow \infty} \partial_{t} \mathbb{E}\left(\left\langle P_{N} U_{L}, f\right\rangle\left\langle g, P_{M} U_{L}\right\rangle\right)(t)= \\
& \quad \frac{3}{4 \pi^{4}} \int_{\mathbb{R}^{6}} \delta\left(k+\sum_{j=1}^{5}(-1)^{j} k_{j}\right) \delta(\Delta(\vec{k})) \frac{1}{k-k_{1}+k_{2}-k_{3}} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \hat{g}(k) d k \prod_{j=1}^{5} d k_{j}
\end{aligned}
$$

and besides the integral converges.
Above, we have $U_{L}=u_{\varepsilon, L}\left(t \varepsilon^{-2}\right), \Delta(\vec{k})=k^{2}-k_{1}^{2}+k_{2}^{2}-k_{3}^{2}+k_{4}^{2}-k_{5}^{2}$ and the $\delta s$ are Dirac deltas.
Remark 1.1. The regime $v=L^{\alpha}, \mu=L^{\beta}, \rho=L^{\gamma}$ with $0<\gamma<\beta<\alpha<\frac{1}{2}$ and $\beta+\gamma<\alpha$ satisfies the assumptions (5).

Remark 1.2. On the one hand, this theorem applies to a class of times that are dense in $\mathbb{R}$. If the dyadic numbers are not satisfying, they can be changed to rational numbers by choosing the regime

\varepsilon^{-2}=2 \pi L^{2} L!+\rho(L)
$$

However, this will serve us to prove that

$$
t \mapsto \lim _{L \rightarrow \infty} \partial_{t} \mathbb{E}\left(\left\langle P_{N} U_{L}, f\right\rangle\left\langle g, P_{M} U_{L}\right\rangle\right)(t)
$$

has a chaotic behavior.
Theorem 1.2. With the same notations as in Theorem 1.1 assuming that $\varepsilon$ writes

$$
\varepsilon^{-2}=2 \pi L^{2} 2^{L}+\rho(L)
$$

that $\rho, v$ and $\mu$ satisfy (5) and that $t \in \frac{1}{3}+\mathbb{D}, \mathbb{D}$ being the set of dyadic numbers, we have

$$
\begin{aligned}
& \lim _{L \rightarrow \infty} \partial_{t} \mathbb{E}\left(\left\langle P_{N} U_{L}, f\right\rangle\left\langle g, P_{M} U_{L}\right\rangle\right)(t)= \\
& \quad \frac{1}{12 \pi^{4}} \int_{\mathbb{R}^{6}} \delta\left(k+\sum_{j=1}^{5}(-1)^{j} k_{j}\right) \delta(\Delta(\vec{k})) \frac{1}{k-k_{1}+k_{2}-k_{3}} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} d k \prod_{j=1}^{5} d k_{j}
\end{aligned}
$$

and besides the integral converges.

Remark 1.3. The difference is in the constant in front of the integral.
Remark 1.4. The behavior on the sequence $\partial_{t} \mathbb{E}\left(\left\langle P_{N} U_{L}, f\right\rangle\left\langle g, P_{M} U_{L}\right\rangle\right)$ depends mainly on the behavior of the sequence

$$
2^{L} t-\left\lfloor 2^{L} t\right\rfloor .
$$

In the case when $t$ is rational, because the sequence $2^{L} t-\left\lfloor 2^{L} t\right\rfloor$ is pre-periodic, we believe that

$$
\begin{aligned}
& \lim _{L \rightarrow \infty} \partial_{t} \mathbb{E}\left(\left\langle P_{N} U_{L}, f\right\rangle\left\langle g, P_{M} U_{L}\right\rangle\right)(t)= \\
& \quad C(t) \int_{\mathbb{R}^{6}} \delta\left(k+\sum_{j=1}^{5}(-1)^{j} k_{j}\right) \delta(\Delta(\vec{k})) \frac{1}{k-k_{1}+k_{2}-k_{3}} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} d k \prod_{j=1}^{5} d k_{j}
\end{aligned}
$$

or at least that the sequence admits a finite number of adherence values of this form.
The behavior of $2^{L} t-\left\lfloor 2^{L} t\right\rfloor$ when $t$ is irrational is not so obvious. We recall that the closure of

$$
\left\{2^{L} t-\left\lfloor 2^{L} t\right\rfloor \mid L \in \mathbb{N}\right\}
$$

is either the torus $\mathbb{R} / \mathbb{Z}$ or a subset of null Haar measure, but that it is almost surely the torus. When $\left(2^{L} t-\left\lfloor 2^{L} t\right\rfloor\right)_{L}$ is dense in the torus, we believe that the sequence

$$
\left(\partial_{t} \mathbb{E}\left(\left\langle P_{N} U_{L}, f\right\rangle\left\langle g, P_{M} U_{L}\right\rangle\right)(t)\right)_{L}
$$

has at least an infinite number of adherence values.
For a complete description of the behavior of the sequence $2^{L} t-\left\lfloor 2^{L} t\right\rfloor$, we refer to [7].
Remark 1.5. Given a fixed $t$, a similar argument to ours will yield that there exists a regime $\varepsilon(t, L)$ such that

\begin{aligned}
& \lim _{L \rightarrow \infty} \partial_{t} \mathbb{E}\left(\left\langle P_{N} U_{L}, f\right\rangle\left\langle g, P_{M} U_{L}\right\rangle\right)(t)= \\
& \quad \frac{3}{4 \pi^{4}} \int_{\mathbb{R}^{6}} \delta\left(k+\sum_{j=1}^{5}(-1)^{j} k_{j}\right) \delta(\Delta(\vec{k})) \frac{1}{k-k_{1}+k_{2}-k_{3}} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} d k \prod_{j=1}^{5} d k_{j}
\end{aligned}
$$

or written differently that

$$
\begin{aligned}
& \liminf _{\varepsilon \rightarrow 0, L \rightarrow \infty} \mid \partial_{t} \mathbb{E}\left(\left\langle P_{N} U_{\varepsilon, L}, f\right\rangle\left\langle g, P_{M} U_{\varepsilon, L}\right\rangle\right)(t) \\
& \left.\quad-\frac{3}{4 \pi^{4}} \int_{\mathbb{R}^{6}} \delta\left(k+\sum_{j=1}^{5}(-1)^{j} k_{j}\right) \delta(\Delta(\vec{k})) \frac{1}{k-k_{1}+k_{2}-k_{3}} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} d k \prod_{j=1}^{5} d k_{j} \right\rvert\,=0 .
\end{aligned}
$$

This should be compared with the result of [15]].
Remark 1.6. This result of discontinuity tends to argue in favor of the fact that the results achieved in [1] [2] (3) 6] are probably the best one can hope for. In particular, this goes well with the fact that the Dyson series does not converge in the cubic Schrödinger case, as proved in [3].

Remark 1.7. We restricted ourselves to the dimension 1 for seek of clarity but the techniques used do not depend on dimension, except when the dimension plays a role in the structure of first order resonances. The results could be carefully extended to higher dimension with some adaptation.

The proof relies on the following strategy. We first describe solutions $u_{\varepsilon, L}$ as a series (converging in Kondratiev's distributions) where each term corresponds to a certain degree in terms of Wiener chaos decomposition. Then, we describe each term of the series thanks to trees, or so-called Feynman diagrams. Finally, we analyze each of these trees and decide which of them are contributing to the considered limit.

The relevant trees are the ones with only one node, or of Wiener chaos of degree 1 . The others are irrelevant for mainly two reasons : either they give a contribution of size $\varepsilon^{n} t^{2 n} f(L)$ with $f(L) \rightarrow 0$, which gives, taking time $t$ of order $\varepsilon^{-2}$ something that goes to 0 when $L$ goes to $\infty$; or they give a contribution of size $\varepsilon^{2 n} t^{m} g(L)$ with $m<n$, in which case, taking as time scale $\varepsilon^{-2}$, we get a contribution of size $\varepsilon^{2(n-m)} g(L)$ and we use that $\varepsilon^{2(n-m)}$ can compensate the potentially disastrous behavior of $g(L)$.

The first case arises when, in the history of interactions between the different wavelengths, special resonances occurs. This translates as constraint equations on the wavelengths and is explained in Subsection 4.2.

The second case arises in a more general context, which is explained in Subsection 4.1.
The reason we ask in $C_{L}(k)$ (and thus in the non-linearity) that $|\Delta(\vec{k})| \geq v^{-1}(L)$ and then, in Assumptions (5), $v^{1+\alpha}=O\left(L^{1 / 2}\right)$ is to deal with the trees presenting constraint estimates. It is probably not optimal, as explained in Remark 4.1 but the proof suggests that the optimal assumption is $v^{1+\alpha}=o(L)$. The issue is that simply assuming $\Delta(\vec{k})=0$ ensures only that $|\Delta(\vec{k})| \geq L^{-2}$. Hence, we need the condition on $v$ to be far enough from first order resonances.

We now explain the special regime for $\varepsilon$. If

$$

we need $\rho_{t}(L)=o(L)$ while $\rho_{t}(L)$ goes to $\infty$ to get the result. But if

then $\varepsilon(L)$ cannot be small enough to close the argument. So, we decided to use the degree of freedom in $2 \pi L^{2} \mathbb{Z}$. To include the dyadic numbers, we chose

$$
\varepsilon^{-2}=2 \pi L^{2} 2^{L}+\rho(L)
$$

and thus $\varepsilon$ was small enough to be able to be far from optimality regarding the trees contributing as $\varepsilon^{2 n} t^{m} g(L)$.

Finally, the reason we ask $\left|k-k_{1}+k_{2}-k_{3}\right| \geq \mu^{-1}(L)$ is to be able to manipulate integrals when passing from sum to integral or when getting Dirac deltas.

### 1.3 Organization of the paper

In Section 2, we review the definitions of Kondratiev's distributions and Wick's product. We prove global well-posedness of Equation (4).

In Section 3, we define quintic trees and ordered quintic trees, that we use to describe the solution $u_{\varepsilon, L}$ as a sum indexed by these trees.

In Section 4, we estimates the different contributions of the trees.
In Section5, we take the final limits that yield to our result.
Finally, for the rest of the paper, we write $\mathbb{Z} / L=\frac{1}{L} \mathbb{Z}$ to lighten notations.

## 2 Wick's product, well-posedness of the equation

### 2.1 Wick's product, Kondratiev's distributions

Let $\Omega, \mathcal{A}, \mathbb{P}$ be a probability onto which one can define $\left(\xi_{k}\right)_{k \in \mathbb{Z}}$ a sequence of independent Gaussian variables centered and normalized. For any $\alpha \in \mathbb{N}^{Z}$ with finite support, we define

where $H_{\alpha_{k}}$ is the $\alpha_{k}$-th Hermite polynomial. It is a well-known fact that $\prod_{k} \sqrt{\alpha_{k}!} \xi_{\alpha}$ is the orthogonal (in $L^{2}$ ) projection of

Let $\mathcal{F}$ be the sigma-algebra generated by the sequence $\left(\xi_{k}\right)_{k}$. We recall that for any $\phi \in$ $L^{2}\left((\Omega, \mathcal{F}, \mathbb{P}), H^{s}(L \mathbb{T})\right)$, we have the decomposition (called Wiener chaos decomposition)

Let $q=\left(q_{k}\right)_{k \in \mathbb{Z}} \in \mathbb{C}^{\mathbb{Z}}, \alpha, \beta \in \mathbb{N}_{f}^{\mathbb{Z}}$, we introduce the notations

We recall that the space of Kondratiev distributions $S_{-1}\left(H^{s}\right)$ is defined as the inductive limit of spaces $\left(S_{-1,-l}\left(H^{s}\right)\right)_{l \in \mathbb{N}}$ where $S_{-1,-l}\left(H^{s}\right)$ is the closure of $L^{2}\left(\Omega, H^{s}\right)$ with regards to the norm

For any $\phi \in S_{-1}\left(H^{s}\right)$, we have the chaos expansion

therefore, we can define the Wick's product of two elements of $S_{-1}\left(H^{s}\right), \phi$ and $\psi$ by

Partial proof. We prove that $X(D)$ is complete. Let $\phi^{n}$ be a Cauchy sequence in $X(D)$. We have that by definition of $X(D)$, at $\alpha$ fixed, the sequence $\phi_{\alpha}^{n}$ is Cauchy in $H^{s}$ and thus converges towards some $\phi_{\alpha}$ in $H^{s}$. By the usual arguments, we have

\left\|F_{L}(\phi)_{\alpha}\right\|_{H^{s}} \lesssim \sum_{\alpha_{1}+\alpha_{2}+\alpha_{3}+\alpha_{4}+\alpha_{5}=\alpha} \frac{\sqrt{\alpha!}}{\sqrt{\alpha_{1}!\alpha_{2}!\alpha_{3}!\alpha_{4}!\alpha_{5}!}}\left\|\phi_{\alpha_{1}}\right\|_{H^{s}}\left\|\phi_{\alpha_{2}}\right\|_{H^{s}}\left\|\phi_{\alpha_{3}}\right\|_{H^{s}}\left\|\phi_{\alpha_{4}}\right\|_{H^{s}}\left\|\phi_{\alpha_{5}}\right\|_{H^{s}}
$$

We have using the norm of $\phi$, for some constant $C_{s}$ depending on the Sobolev regularity,

$$
\left\|F_{L}(\phi)_{\alpha}(\tau)\right\|_{H^{s}} \leq C_{s} \sqrt{\alpha!\left(\langle\tau\rangle^{1 / 4} D\right)^{|\alpha|} C_{\alpha}\|\phi\|_{X\left(\langle\tau)^{1 / 4} D\right)}^{5}, ~, ~ . ~}
$$

that is

$$
\left\|F_{L}(\phi)_{\alpha}(\tau)\right\|_{H^{s}} \leq C_{s} \sqrt{\alpha!}\left(\langle\tau\rangle^{1 / 4} D\right)^{|\alpha|} C_{\alpha} \eta^{5}\langle\tau\rangle^{-5 / 4} .
$$

Note that this $C_{s}$ does not depend on (or is uniformly bounded in) $L \in \mathbb{N}^{*}$ as its dependence in $L$ is characterized by the value of

$$
\frac{1}{L} \sum_{k \in \mathbb{Z} / L}\langle k\rangle^{-2 s} \leq \frac{1}{L}+2 \int d x\langle x\rangle^{-2 s}
$$

Because $|\alpha| \geq 5$, and $\langle\tau\rangle \leq\langle t\rangle$, we have

$$
\left\|F_{L}(\phi)_{\alpha}(\tau)\right\|_{H^{s}} \leq C_{s}\left(\langle t\rangle^{1 / 4} D\right)^{|\alpha|} C_{\alpha} \eta^{5}\langle t\rangle^{-5 / 4}
$$

We deduce

$$
\left\|F_{L}(\phi)(\tau)\right\|_{X(D\langle t))} \leq C_{s}\langle t\rangle^{-5 / 4} \eta^{5} .
$$

Taking $\eta$ such that $C_{s} \eta^{4} \varepsilon \leq \frac{1}{2}$, we get

\|A(\phi)\|_{X_{t}(D)} \leq \frac{D_{0}}{D}\left\|\phi_{0}\right\|_{X\left(D_{0}\right)}+\frac{1}{2} \eta .
$$

Taking $D$ such that

\frac{D_{0}}{D} \leq \frac{1}{2} \eta
$$

we get that the ball of $X_{t}(D)$ of radius $\eta$ is stable under $A$. A similar argument yields that $A$ is contracting for $\eta$ such that

\tilde{C}_{s} \varepsilon \eta^{4} \leq \frac{1}{2}
$$

where $\tilde{C}_{s}$ is a constant independent from $L$ but depending on the Sobolev regularity $s$.

## 3 Trees, description of the solution

### 3.1 Picard expansion

Let $\varphi$ be a bijection from $\{0,1\} \times \mathbb{Z}$ to $\mathbb{Z}$. We call, by abuse of notation,

\xi_{\iota, k}=\xi_{\varphi(k)} .
$$

We set

$$
g_{k}=\xi_{0, k}+i \xi_{1, k} .
$$

Let, for all $x \in(L \mathbb{T})^{2}$,

$$
a_{L}(x)=\sum_{k \in \mathbb{Z}} g_{k} \frac{e^{i k x / L}}{\sqrt{2 \pi}} a\left(\frac{k}{L}\right)
$$

where $a$ is a smooth function with compact support. We call

$$
u_{\varepsilon, L}
$$

the solution to

$$
i \partial_{t} u_{\varepsilon, L}=-\Delta u_{\varepsilon, L}+\varepsilon F_{L}\left(u_{\varepsilon, L}\right)
$$

with initial datum $a_{L}$ in $X_{t}(D)$ for some $D$ big enough.
First, note that

$$
\left(a_{L}\right)_{\alpha}=\left\{\begin{array}{cc}
\frac{e^{i k x / L}}{\frac{1}{\sqrt{L}}} a(k / L) & \text { if }|\alpha|=1 \text { and } \operatorname{Supp}(\alpha)=\varphi(0, k) \\
i \frac{i^{i k \times L}}{\sqrt{L}} a(k / L) & \text { if }|\alpha|=1 \text { and } \operatorname{Supp}(\alpha)=\varphi(1, k) \\
0 & \text { otherwise. }
\end{array} .\right.
$$

Hence

$$
\left\|\left(a_{L}\right)_{\alpha}\right\|_{H^{s}} \leq \sup _{x \in \mathbb{R}}\langle x\rangle^{s}|a(x)|
$$

and therefore $a_{L}$ is in the unit ball of $X\left(D_{0}\right)$ for any $D_{0} \geq\left\|\langle x\rangle^{s} a\right\|_{L^{\infty}}$. Hence $u_{\varepsilon, L}$ is well-defined.
Remark 3.1. We have that $a_{L}$ belongs to some $X\left(D_{0}\right)$ with $D_{0}$ uniformly bounded in $L$. According to the proof of Proposition 2.5, we have that the solution

$$
u_{\varepsilon, L}
$$

belongs to $X_{t}(D)$ with

$$
D=c_{s} D_{0} \varepsilon^{1 / 4}
$$

where $c_{s}$ is a constant depending only on the Sobolev regularity s and thus $D$ is uniformly bounded in $L$.

Finally, we have

$$
\left.\left\|\left(u_{\varepsilon, L}(t)\right)_{\alpha}\right\|_{H^{s}(L T)} \leq \sqrt{\alpha!} C_{\alpha} D^{|\alpha|}\langle t\rangle^{\frac{1}{4}}|\alpha|-1\right)
$$

and thus for all $\alpha \in \mathbb{N}_{f}^{\mathbb{Z}}$ and all $t \in \mathbb{R}$, we have that

$$
\left\|\left(u_{\varepsilon, L}(t)\right)_{\alpha}\right\|_{H^{s}(L \mathbb{T})}
$$

is uniformly bounded in $L$.

Proposition 3.1. The solution $u$ hence defined is, in terms of Kondratiev distributions

$$
u_{\varepsilon, L}=\sum_{n=0}^{\infty} \varepsilon^{n} u_{n, L}
$$

where $u_{0, L}$ is $S(t) a_{L}:=e^{i t \Delta} a_{L}$ and the sequence is defined by induction by

$$
i \partial_{t} u_{n+1, L}=-\Delta u_{n+1, L}+\sum_{n_{1}+n_{2}+n_{3}+n_{4}+n_{5}=n} F_{L}\left(u_{n_{1}, L}, u_{n_{2}, L}, u_{n_{3}, L}, u_{n_{4}, L}, u_{n_{5}, L}\right)
$$

with initial datum 0 .
What is more, setting that $P_{N}$ is the projection over chaos of degree at most $N$, we have

$$
P_{N} u_{\varepsilon, L}=\sum_{n=0}^{M} \varepsilon^{n} u_{n, L}
$$

with $M=\left\lfloor\frac{N-1}{4}\right\rfloor$.
Proof. We prove that the series

$$
\sum_{n=0}^{\infty} \varepsilon^{n} u_{n, L}
$$

converges in $X_{t}(D)$ for $D$ big enough.
We prove that $u_{n, L}$ is either 0 or a Wiener chaos of exact degree $4 n+1$ (by which we mean a sum of monomials of exact degree $4 n+1$ ) and that there exists $D$ big enough and $\eta$ small enough such that $\left\|u_{n, L}\right\|_{X_{t}(D)} \leq \eta \leq 1$. This is true for $u_{0, L}$, we have for any $\eta>0$,

$$
\left\|u_{0, L}\right\|_{X_{t}\left(\frac{\|(x))^{2} \|_{L^{\infty}}}{\eta}\right)} \leq \eta .
$$

We prove that this is true for any $n$ by induction.
We have

$$
u_{n+1, L}(t)=-i \int_{0}^{t} S(t-\tau) \sum_{n_{1}+n_{2}+n_{3}+n_{4}+n_{5}=n} F_{L}\left(u_{n_{1}}, u_{n_{2}}, u_{n_{3}}, u_{n_{4}}, u_{n_{5}}\right)
$$

where we recall that $S(t)$ is the linear flow $e^{i t \Delta}$. Since $u_{n_{j}}$ is of exact degree $4 n_{j}+1$, we get that

$$
F_{L}\left(u_{n_{1}}, u_{n_{2}}, u_{n_{3}}, u_{n_{4}}, u_{n_{5}}\right)
$$

is of degree $4\left(n_{1}+n_{2}+n_{3}+n_{4}+n_{5}\right)+5=4 n+5=4(n+1)+1$ or null. Besides, for any $\alpha$, we have

$$
\left\|u_{n+1, L}(t)_{\alpha}\right\|_{H^{s}} \leq C(\alpha!)^{1 / 2}|t| \sum_{n_{1}+n_{2}+n_{3}+n_{4}+n_{5}=n} \sum_{\alpha_{1}+\alpha_{2}+\alpha_{3}+\alpha_{4}+\alpha_{5}=\alpha} \sup _{\tau \leq t} \prod_{j}\left\|u_{n_{j}}(\tau)_{\alpha_{j}}\right\|_{H^{s}}\left(\alpha_{j}!\right)^{-1 / 2}
$$

Using that

$$
\left\|u_{n_{j}}(\tau)_{\alpha_{j}}\right\|_{H^{s}}\left(\alpha_{j}!\right)^{-1 / 2}
$$

is 0 if $\left|\alpha_{j}\right| \neq 4 n_{j}+1$ and is less that

$$
D^{4 n_{j}+1}\langle\tau\rangle^{n_{j}} C_{\alpha_{j}} \sqrt{\alpha_{j}!v}
$$

we get, if $|\alpha|=4 n+5$,

$$
\left\|u_{n+1, L}(t)_{\alpha}\right\|_{H^{s}} \leq C v^{5}(\alpha!)^{1 / 2}|t| \sum_{\alpha_{1}+\alpha_{2}+\alpha_{3}+\alpha_{4}+\alpha_{5}=\alpha} \prod_{j} C_{\alpha_{j}} D^{4(n+1)+1}\langle t\rangle^{n}=C v^{5} C_{\alpha} D^{4(n+1)+1}\langle t\rangle^{n+1}
$$

and is 0 if $|\alpha| \neq 4 n+5$.
Hence

$$
\left\|u_{n+1, L}\right\|_{X_{t}(D)} \leq C v^{5} .
$$

For $v$ small enough such that $C v^{4} \leq 1$, we have indeed $\left\|u_{n+1, L}\right\|_{X_{t}(D)} \leq v$. Therefore, since $v \leq 1$ and $\varepsilon<1$, the series

$$
\sum_{n} \varepsilon u_{n, L}
$$

converges in $X_{t}(D)$ for $D=\frac{\| x\rangle^{s} a \|_{L^{\infty}}}{v}$.
Since this series satisfies equation

$$
i \partial_{t} u=-\Delta u+\varepsilon F_{L}(u)
$$

with initial datum $u_{0, L}$, we have

$$
u_{\varepsilon, L}=\sum_{n} \varepsilon^{n} u_{n, L}
$$

What is more,

$$
P_{N} u_{\varepsilon, L}=\sum_{n} \varepsilon^{n} P_{N} u_{n, L}
$$

and because $u_{n, L}$ is of degree $4 n+1$, we get $P_{N} u_{n, L}=u_{n, L}$ if $4 n+1 \leq N$ and is 0 otherwise.
We set

$$
\hat{u}_{n, L}(k, t)=\frac{1}{2 \pi L} \int_{\mathbb{T} L} u_{n, L}(x, t) e^{-i k x} d x .
$$

We get that $\hat{u}_{n, L}(k)$ satisfies for $n \geq 1$,

$$
i \partial_{t} \hat{u}_{n, L}=k^{2} \hat{u}_{n, L}(k)+\frac{1}{(2 \pi L)^{2}} \sum_{n_{1}+n_{2}+n_{3}+n_{4}+n_{5}=n-1} \quad \sum_{C_{L}(k)} \hat{u}_{n_{1}, L}\left(k_{1}\right) \diamond \overline{\hat{u}_{n_{2}, L}\left(k_{2}\right)} \diamond \hat{u}_{n_{3}, L}\left(k_{3}\right) \diamond \overline{\hat{u}_{n_{4}, L}\left(k_{4}\right)} \diamond \hat{u}_{n_{5}, L}\left(k_{5}\right) .
$$

We set $v_{n, L}(k, t)=e^{i k^{2} t} \hat{u}_{n, L}(k, t)$ and get the equation

$$
v_{0, L}(k, t)=a(k)
$$

and

$$
\begin{align*}
i \partial_{t} v_{n, L}(k)=\frac{1}{(2 \pi L)^{2}} & \sum_{n_{1}+n_{2}+n_{3}+n_{4}+n_{5}=n-1} \\
& \sum_{C_{L}(k)} e^{i \Delta(\vec{k}) t} v_{n_{1}, L}\left(k_{1}\right) \diamond \overline{v_{n_{2}, L}\left(k_{2}\right)} \diamond v_{n_{3}, L}\left(k_{3}\right) \diamond \overline{v_{n_{4}, L}\left(k_{4}\right)} \diamond v_{n_{5}, L}\left(k_{5}\right) . \tag{7}
\end{align*}
$$

### 3.2 Quintic trees

All the definitions in this subsection and the next one have examples in Appendix A.
Definition 3.2. Let $k \in \mathbb{Z} / L$. We define by induction the set $\mathcal{T}_{n}[k]$ of quintic trees with $n$ nodes by

& \left.\qquad \sum n_{j}=n,\left(k_{1}, \ldots, k_{5}\right) \in C_{L}(k)\right\} .
\end{aligned}
$$

We set

$$
\mathcal{T}_{n}=\bigcup_{k \in \mathbb{Z} / L} \mathcal{T}_{n}[k] .
$$

Definition 3.3. For any tree we define the following functions or random variables. First, we set

$$
F_{(k)}(t)=1, g_{(k)}=g_{L k}, A_{(k)}=a(k),
$$

and if $T=\left(T_{1}, T_{2}, T_{3}, T_{4}, T_{5}, k\right)$ with $T_{j} \in \mathcal{T}_{n_{j}}\left[k_{j}\right]$, we set

$$
F_{T}(t)=-i \int_{0}^{t} e^{i \Delta \tau} F_{T_{1}}(\tau) \overline{F_{T_{2}}(\tau)} F_{T_{3}}(\tau) \overline{F_{T_{4}}(\tau)} F_{T_{5}}(\tau) d \tau
$$

and

$$
g_{T}=g_{T_{1}} \diamond \overline{g_{T_{2}}} \diamond g_{T_{3}} \diamond \overline{g_{T_{4}}} \diamond g_{T_{5}}, A_{T}=A_{T_{1}} \overline{A_{T_{2}}} A_{T_{3}} \overline{A_{T_{4}}} A_{T_{5}}
$$

Definition 3.4. Finally, we define the labels $\vec{T}$ of the leaves of a tree $T$ in the following way

$$
(\vec{k})=k \in \mathbb{Z} / L
$$

and for $T=\left(T_{1}, T_{2}, T_{3}, T_{4}, T_{5}, k\right)$ writing $\left(k_{j, 1}, \ldots, k_{j, 4 n_{j}+1}\right)=\vec{T}_{j}$ with $T_{j} \in \mathcal{T}_{n_{j}}\left[l_{j}\right]$, we set

$$
\vec{T}=\left(k_{1,1}, \ldots, k_{1,4 n_{1}+1}, k_{2,1}, \ldots, k_{2,4 n_{2}+1}, k_{3,1}, \ldots, k_{3,4 n_{3}+1}, k_{4,1}, \ldots, k_{4,4 n_{4}+1}, k_{5,1}, \ldots, k_{5,4 n_{5}+1}\right) .
$$

Remark 3.2. The definition is consistent as $\vec{T} \in \mathbb{R}^{4 n+1}$ for any $T \in \mathcal{T}_{n}$.
Proposition 3.5. Let $T \in \mathcal{T}_{n}[k]$ and $\vec{T}=\left(k_{1}, \ldots, k_{4 n+1}\right)$, we have

$$
k=\sum_{j=1}^{4 n+1}(-1)^{j+1} k_{j}, A_{T}=\prod_{j=1}^{4 n+1} a\left(k_{j},(-1)^{j+1}\right), g_{T}=\stackrel{4 n+1}{\diamond} g_{j=1} g_{j,(-1))^{j+1}} .
$$

We used the notation

$$
\begin{array}{rll}
a\left(k_{j}, 1\right)=a\left(k_{j}\right) & \text { and } & a\left(k_{j},-1\right)=\overline{a\left(k_{j}\right)} \\
g_{k_{j}, 1}=g_{k_{j} L} & \text { and } & g_{k_{j},-1}=\overline{g_{k_{j} L} L}
\end{array}
$$

Proof. By induction starting from Equation (7).

Proposition 3.6. We have for all $(n, k, t) \in \mathbb{N} \times \mathbb{Z} / L \times \mathbb{R}$,

v_{n, L}(k, t)=\left[\frac{1}{(2 \pi L)^{2}}\right]^{n} \sum_{T \in \mathcal{T}_{n}[k]} F_{T}(t) A_{T} g_{T} .
$$

Proof. By induction.
We introduce unlabelled quintic trees.
Definition 3.7. Let $\mathcal{T}_{n}$ defined by induction by

\mathcal{T}_{0}=\{\perp\}
$$

and

\mathcal{T}_{n+1}=\left\{\left(T_{1}, T_{2}, T_{3}, T_{4}, T_{5}\right) \mid \forall j=1, \ldots, 5, T_{j} \in \mathcal{T}_{n_{j}} \sum_{j=1}^{5} n_{j}=n\right\} .
$$

Given $\vec{k}=\left(k_{1}, \ldots, k_{4 n+1}\right) \in(\mathbb{Z} / L)^{4 n+1}$, we write

\perp(\vec{k})=\left(k_{1}\right)
$$

and

$$
\left(T_{1}, T_{2}, T_{3}, T_{4}, T_{5}\right)(\vec{k})=\left(T_{1}\left(\vec{k}_{1}\right), T_{2}\left(\vec{k}_{2}\right), T_{3}\left(\vec{k}_{3}\right), T_{4}\left(\vec{k}_{4}\right), T_{5}\left(\vec{k}_{5}\right), k\right)
$$

with $T_{j} \in \mathcal{T}_{n_{j}}$ and $\vec{k}_{j}=\left(k_{n_{j}+1}, \ldots, k_{\tilde{n}_{j}+4 n_{j}+1}\right)$ with

$$
\tilde{n}_{j}=\sum_{l=1}^{j-1}\left(4 n_{l}+1\right) \quad \text { and } \quad k=-\sum_{j=1}^{4 n+1}(-1)^{j} k_{n} .
$$

We now give a definition of labels for the nodes and the leaves that helps seeing the "history" of the tree, as the paternity of nodes.

$$

and

$$
\tilde{N}(T)=\{0\} \sqcup\left(\{1\} \times \tilde{N}\left(T_{1}\right)\right) \sqcup\left(\{2\} \times \tilde{N}\left(T_{2}\right)\right) \sqcup\left(\{3\} \times \tilde{N}\left(T_{3}\right)\right) \sqcup\left(\{4\} \times \tilde{N}\left(T_{4}\right)\right) \sqcup\left(\{5\} \times \tilde{N}\left(T_{5}\right)\right) .
$$

Definition 3.9. Let $\vec{k}=\left(k_{1}, \ldots, k_{4 n+1}\right) \in(\mathbb{Z} / L)^{4 n+1}$. We define

k_{T, \vec{k}}: \tilde{N}(T) \rightarrow \mathbb{Z} / L
$$

such that $k_{\perp, \vec{k}}(0)=k_{1}$ and if $T=\left(T_{1}, T_{2}, T_{3}, T_{4}, T_{5}\right)$ with $T_{j} \in \mathcal{T}_{n_{j}}$ and $\vec{k}_{j}=\left(k_{n_{j}+1}, \ldots, k_{\tilde{n}_{j}+4 n_{j}+1}\right)$ with

$$
\tilde{n}_{j}=\sum_{l=1}^{j-1}\left(4 n_{l}+1\right)
$$

we define

$$
k_{T, \vec{k}}(0)=\sum_{j=1}^{4 n+1}(-1)^{j+1} k_{j} \quad \text { and } \quad k_{T, \vec{k}}((j, m))=k_{T_{j}, \vec{k}_{j}}(m) .
$$

We define also

$$
\Omega_{T, \vec{k}}: N(T) \rightarrow \mathbb{R}
$$

such that

$$
\Omega_{T, \vec{k}}(0)=k_{T, \vec{k}}^{2}(0)-k_{T, \vec{k}}^{2}((1,0))+k_{T, \vec{k}}^{2}((2,0))-k_{T, \vec{k}}^{2}((3,0))+k_{T, \vec{k}}^{2}((4,0))-k_{T, \vec{k}}^{2}((5,0))
$$

and

$$
\Omega_{T}((j, l))=(-1)^{j+1} \Omega_{T_{j}}(l)
$$

We use the notation $\Omega$ instead of $\Delta$ because of the discussion of the sign.
Finally, we define a condition on $\vec{k}$ such that $T(\vec{k}) \in \mathcal{T}_{n}[k]$.
Definition 3.10. We define by induction $C_{T}(k)$ by

\left|\Omega_{T, \vec{k}}(0)\right| \geq v^{-1}, \quad \forall j=1, \ldots, 5, \vec{k}_{j} \in C_{T_{j}}\left(k_{T, \vec{k}}(j, 0)\right)
$$

with $T=\left(T_{1}, \ldots, T_{5}\right), T_{j} \in \mathcal{T}_{n_{j}}$ and

$$
\vec{k}_{j}=\left(k_{\tilde{n}_{j}+1, \ldots, k_{\tilde{n}_{j}+4 n_{j}+1}}\right)
$$

with $\tilde{n}_{j}=\sum_{l<j}\left(4 n_{l}+1\right)$.
Proposition 3.11. We have

$$
\mathcal{T}_{n}[k]=\left\{T(\vec{k}) \mid T \in \mathcal{T}_{n} \text { and } \vec{k} \in C_{T}(k)\right\} .
$$

Proof. By induction using Definition 3.7 .
Proposition 3.12. We have for all $(n, k, t) \in \mathbb{N} \times \mathbb{Z} / L \times \mathbb{R}$,

$$
v_{n, L}(k, t)=\left[\frac{1}{(2 \pi L)^{2}}\right]^{n} \sum_{T \in \mathcal{T}_{n}} \sum_{\vec{k} \in C_{T}(k)} F_{T(\vec{k})}(t) A_{\vec{k}} g_{\vec{k}}
$$

where

$$

Proof. Direct consequence of Propositions 3.6, 3.11, and 3.5.

### 3.3 Ordered trees

Definition 3.13. We define on $N(T)$ the partial order relation $R_{T}$ such that for all $l \in N(T)$,

Proof. We recall that 0 is bigger than any other element of $N(T)$ and that if $j_{1}$ is different from $j_{2}$, ( $j_{1}, m_{1}$ ) and ( $j_{2}, m_{2}$ ) are not comparable while $\left(j, m_{1}\right) R\left(j, m_{2}\right)$ iff $m_{1} R_{T_{j}} m_{2}$.

Proof of Proposition 3.14 From Lemma 3.15, the induction follows almost directly, it remains to see is that

not to be zero, one needs the existence of a bijection from $\left[1,4 n_{2}+1\right] \cap \mathbb{N}$ to $\left[1,4 n_{1}+1\right] \cap \mathbb{N}$ such that

Otherwise, let $j_{0}$ such that $j_{0}+\sigma\left(j_{0}\right)$ is odd. For any $\iota$, we write $\iota^{\prime}$ such that $\iota^{\prime}\left(j_{0}\right)=-\iota\left(j_{0}\right)$ and $\iota^{\prime}(j)=\iota(j)$ for all $j \neq j_{0}$. Since $\iota \mapsto \iota^{\prime}$ is a bijection of

\end{aligned}

## 4 Analysis

### 4.1 Time estimates

$$

Since $M-1$ is even, we have

\frac{e^{i\left(\Omega_{M+1}+\Omega_{M}\right) t}}{-\left(\Omega_{M+1}+\Omega_{M}\right) \Omega_{M+1}} e^{i \Omega_{M-1} \tau} G_{M-2}(\tau)=O_{M}\left(L^{4} L^{2(M-2)} t^{(M-3) / 2}\right)
$$

hence

G_{M+1}(t)=O_{M}\left(L^{2(M+1)} t^{(M-1) / 2}\right)
$$

If $\Omega_{M+1}+\Omega_{M}=0$, either at least $\Omega_{2 j-1}+\Omega_{2 j} \neq 0$ for one $j=1$ to $(M-1) / 2$, in which case

or $\Omega_{2 j-1}+\Omega_{2 j}=0$ for all $j=1$ to $(M-1) / 2$ (which includes $M=1$ ), in which case

3. we are not in cases 1 or $2, \forall j=1, \ldots, \frac{M-1}{2}, \Omega_{2 j}+\Omega_{2 j-1}=0$ then

G_{M}(t)=(-1)^{(M-1) / 2} \prod_{j=0}^{(M-1) / 2} \frac{1}{i \Omega_{2 j+1}} e^{i \Omega_{M} t} \frac{t^{(M-1) / 2}}{(M-1) / 2!}+O\left(L^{2 M} t^{(M-3) / 2}\right)
$$

4. we are not in cases 1,2 , or $3, \forall j=1, \ldots, \frac{M-1}{2}, \Omega_{2 j}+\Omega_{2 j+1}=0$ then

G_{M}(t)=(-1)^{(M+1) / 2} \prod_{j=0}^{(M-1) / 2} \frac{1}{i \Omega_{2 j+1}} \frac{t^{(M-1) / 2}}{(M-1) / 2!}+O\left(L^{2 M} t^{(M-3) / 2}\right)
$$

5. we are not in cases 1, 2, 3 or 4 , there exists $j_{0} \in\left[1, \frac{M-1}{2}\right] \cap \mathbb{N}$ such that $\Omega_{2 j_{0}+1}+\Omega_{2 j_{0}}+$ $\Omega_{2 j_{0}-1}=0$ and $\forall j>j_{0}, \Omega_{2 j+1}+\Omega_{2 j}=0$ and $\forall j<j_{0}, \Omega_{2 j}+\Omega_{2 j-1}=0$ then

G_{M}(t)=(-1)^{(M-1) / 2} \prod_{j=0}^{(M-1) / 2} \frac{1}{i \Omega_{2 j+1}} \frac{t^{(M-1) / 2}}{(M-1) / 2!}+O\left(L^{2 M} t^{(M-3) / 2}\right)

6. we are not in cases 1, 2, 3, 4, or 5, then

If $M=1$, we are in case 1 .
We assume that the proposition is true up to $M-2$, and we prove it for $M$.
Case 2 We have by definition

$$

Because of the hypothesis on the $\Omega_{n}$, we have

G_{M}(t)=\int_{0}^{t} d t_{M} e^{i \Omega_{M} t_{M}} \int_{0 \leq t_{1} \leq \ldots \leq t_{M-1} \leq t_{M}} \prod_{n=1}^{(M-1) / 2} e^{i \Omega_{M\left(t_{2 n-1}-t_{2 n}\right)} d t_{2 n-1} d t_{2 n} . . . . . . .}
$$

By integration by parts, we get

G_{M}(t)=\frac{e^{i \Omega_{M} t}}{i \Omega_{M}} G_{M-1}(t)-\int_{0}^{t} \frac{1}{i \Omega_{M}} G_{M-2(\tau)} d \tau .

\end{aligned}
$$

We have that $G_{M-2}$ is either in case 1,2 or 3 . If it is in case 1 or 2 , then $\Omega_{M}+\Omega_{M-1} \neq 0$ otherwise $G_{M}$ is in case 2 and $\Omega_{M}+\Omega_{M-1}+\Omega_{M-2}=\Omega_{M} \neq 0$, therefore,

if $G_{M-2}$ is in case 1 and

G_{M}(t)=e^{i \Omega_{M} t} & \prod_{j=0}^{(M-1) / 2} \frac{1}{i \Omega_{2 j+1}} \frac{t^{(M-1) / 2}}{(M-1) / 2!} \\
& -\int_{0}^{t} \frac{e^{i\left(\Omega_{M}+\Omega_{M-1}\right) \tau}}{i \Omega_{M}}(-1)^{(M-3) / 2} \frac{e^{i \Omega_{M-2} \tau}-1}{\left(i \Omega_{M-2}\right)^{(M-1) / 2}} \frac{\tau^{(M-3) / 2}}{(M-3) / 2!} d \tau+O\left(t^{(M-3) / 2} L^{2 M}\right)
\end{aligned}
$$

if $G_{M-2}$ is in case 2 . In both cases, by (8), we get

If $G_{M-2}$ is in case 5 , then $\Omega_{M}+\Omega_{M-1} \neq 0$ otherwise $G_{M}$ is in case 5 and we conclude by the usual strategy.

If $G_{M-2}$ is in case 6, then

G_{M-2}(\tau)=O\left(\tau^{(M-5) / 2} L^{2(M-2)}\right)
$$

and we can conclude.

and let us prove that it yields to a contradiction.

The situation for the other term in $\partial_{t} G$ is symmetric.
Lower orders are

O\left(L^{4 n-2} t^{n-2}\right)
$$

For $F_{T_{2}, \vec{k}_{\sigma}}^{\varphi_{2}}$ to be of order $\frac{n}{2}$ in $t$, one needs to be in the situation that for $j=1$ to $\frac{n}{2}$,

\Omega_{T_{2}, \vec{k}_{\sigma}}\left(\varphi_{2}(2 j-1)\right)+\Omega_{T_{2}, \vec{k}_{\sigma}}\left(\varphi_{2}(2 j)\right)=0 .

$$

We have for all $\alpha>0$,

V\left(T_{1}, T_{2}, \sigma, k, \varphi_{1}, \varphi_{2}\right)=O_{a, T_{1}, T_{2}, \varphi_{1}, \varphi_{2}, \sigma, \alpha}\left[t^{n-1} v^{(1+\alpha) n / 2} L^{-(n-1) / 2}\right]+O_{a, n}\left(L^{4 n-2} t^{n-2}\right) .
$$

Proof. In all the proof, we omit the dependence in $T_{1}, T_{2}, \sigma, k, \varphi_{1}, \varphi_{2}$.

W^{\prime}=\frac{1}{(4 \pi L)^{n}} \sum_{\vec{k} \in \tilde{C}} \overline{F_{T_{1}, \vec{k}}^{\varphi_{1}}} \partial_{t} F_{T_{2}, \overrightarrow{k_{\sigma}}}^{\varphi_{2}} \overline{A_{\vec{k}}} A_{\vec{k}_{\sigma}} \mathbb{E}\left(\overline{g_{\vec{k}}} g_{\vec{k}_{\sigma}}\right)

What is more, $\vec{k}$ belongs to $\underline{C}^{2} \cap \underline{C}^{1}$ with

Indeed, if $\left(\left(l_{1}(j), l_{2}(j), l_{3}(j), l_{4}(j)\right)_{1 \leq j \leq n}\right.$ is fixed, then, since $l(n)=k_{T_{2}, \vec{k}_{\sigma}}(0)=k$, we get that $l_{5}(n)$ is fixed. Now, since $l(n-1)$ is one of the $l_{m}(n)$ for $m=1$ to 5 , we get that $l_{5}(n-1)$ is fixed. By going down the tree, we get to know the full $\left(l_{m}(j)\right)_{m, j}$ for $m=1$ to 5 and $j=1$ to $n$. In particular we know the labels of the leaves for all the nodes at the bottom of the tree. We know the labels of the leaves, in other words, $\vec{k}_{\sigma}$ and knowing $\sigma$, we know $\vec{k}$.

We set $\Omega_{j}(\vec{l})=\Omega_{T_{2}, \vec{k}_{\sigma}}\left(\varphi_{2}(j)\right)$.

The image of $\underline{C}^{2}$ by $S_{T_{2}, \sigma, \varphi_{2}}$ is included in

We then fix arbitrarily $l_{1}(n-1), l_{2}(n-1)$ and $l_{3}(n-1)$, which fixes automatically $\bar{l}(n-1)$. We recall that $\Omega_{n-1}(\vec{l})$ is fixed and that

For $W_{1}$, there are $\frac{n-1}{2}|\Omega|^{-2}$ to integrate and $\frac{n-1}{2}$ constraints estimates. Hence,

\left|A_{=}\right| \leq 5!v \sum_{\sigma \in \mathscr{Z}} \sum_{\vec{k} \in C_{\sigma,=}(k)} \frac{2}{(2 \pi L)^{4}} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} .
$$

Because satisfying " $\exists j \neq l$ such that $k_{j}=k_{l}$ " is a constraint independent from $\sum_{j=1}^{5}(-1)^{j} k_{j}+k=0$, we get that

A_{=}=O_{a}\left(L^{-1} v\right)
$$

We estimate $B$, we recall that if $\sigma$ does not conserve parity and $\vec{k} \in C_{\sigma}(k)$ then $\mathbb{E}\left(g_{\vec{k}} \overline{{ }_{\overrightarrow{k_{\sigma}}}}\right) \neq 0$ implies $\vec{k} \in C_{\sigma,=}(k)$. Therefore

B=2 \operatorname{Re}\left[\sum_{\sigma \in \mathfrak{B}} \sum_{\vec{k} \in C_{\sigma,=}=(k)} \frac{1}{(2 \pi L)^{4}} \frac{e^{i \Delta(\vec{k}) t}-1}{i \Delta(\vec{k})} e^{-i \Delta\left(\overrightarrow{k_{\sigma}}\right) t} A_{\vec{k}} \overline{A_{\overrightarrow{k_{\sigma}}}} \mathbb{E}\left(g_{\vec{k}} \overline{g_{\overrightarrow{k_{\sigma}}}}\right]\right.
$$

Since $\left|\mathbb{E}\left(g_{\vec{k}} \overline{\bar{g}_{\vec{k}_{\sigma}}}\right)\right| \leq 5$ ! and since

Because belonging to $C_{\sigma,=}(k)$ implies two independent linear constraint on $\vec{k}$, we get

## 5 Final limits and proof of the result

We sum up quickly what we have done so far. Since for all $n>1, T_{1}, T_{2} \in \mathcal{T}_{n}, \sigma \in \mathbb{S}_{4 n+1}, k \in \mathbb{Z} / L$ and $t \in \mathbb{R}$, we have thanks to Proposition 4.5

$$

we get

\partial_{t} \mathbb{E}\left(\left|v_{n, L}(k, t)\right|^{2}\right)=O_{n, \alpha, a}\left(t^{n-1} v^{(1+\alpha) n / 2} L^{-(n-1) / 2}\right)+O_{n, a}\left(t^{n-2} L^{4 n-2}\right),
$$

We deduce that for all $t \in \mathbb{R}$, we have that

therefore

\sum_{n=2}^{N} \varepsilon^{2(n-1)} \partial_{t} \mathbb{E}\left(\left|v_{n, L}\left(k, t \varepsilon^{-2}\right)\right|^{2}\right)=O_{N, a, t}\left(\frac{v^{1+\alpha}}{L^{1 / 2}}\right)+O_{N, a, t}\left(\varepsilon^{2} L^{4 N-2}\right) .
$$

We recall that thanks to Proposition 4.6, we have

\partial_{t} \mathbb{E}\left(\left|v_{1}(t, k)\right|^{2}\right)=\sum_{\sigma \in \mathscr{I}} \sum_{\vec{k} \in C_{\sigma}(k)} \frac{2}{(2 \pi L)^{4}} \frac{\sin (\Delta(\vec{k}) t)}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2}+O_{a}\left(L^{-1} v\right) .
$$

We set

I_{\varepsilon, L}(k, t)=\sum_{\sigma \in \mathfrak{I}} \sum_{\vec{k} \in C_{\sigma}(k)} \frac{2}{(2 \pi L)^{4}} \frac{\sin \left(\Delta(\vec{k}) t \varepsilon^{-2}\right)}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} .
$$

We introduce test functions.
Proposition 5.1. Let $f, g$ be two smooth, compactly supported functions on $\mathbb{R}$. Let $M \geq N \in \mathbb{N}^{*}$. We have

Proof. Set $n_{0}=\left\lfloor\frac{N-1}{4}\right\rfloor$. We have

$$

and we recall that because the support of $a$ is compact, the sum over $k$ is finite. Hence

$$

For the same reasons

\left\langle g, P_{M} U_{L}(t)\right\rangle=\frac{1}{\sqrt{2 \pi L}} \sum_{k^{\prime} \in \mathbb{Z} / L} \sum_{m=0}^{m_{0}} \varepsilon^{m} \hat{u}_{m, L}\left(t \varepsilon^{-2}, k^{\prime}\right) \overline{\hat{g}\left(k^{\prime}\right)}
$$

where $m_{0}=\left\lfloor\frac{M-1}{4}\right\rfloor$.
Therefore,

\mathbb{E}\left(\left\langle P_{N} U_{L}, f\right\rangle\left\langle g, P_{M} U_{L}\right\rangle\right)=\frac{1}{2 \pi L} \sum_{k, k^{\prime}} \hat{f}(k) \overline{\hat{g}\left(k^{\prime}\right)} \sum_{n, m} \varepsilon^{n+m} \mathbb{E}\left(\overline{\hat{u}_{n, L}\left(t \varepsilon^{-2}, k\right)} \hat{u}_{m, L}\left(t \varepsilon^{-2}, k^{\prime}\right)\right) .
$$

We recall that

We recall

\sum_{n=2}^{n_{0}} \varepsilon^{2(n-1)} \partial_{t} \mathbb{E}\left(\left|v_{n, L}(k)\right|^{2}\right)\left(t \varepsilon^{-2}\right)=O_{n_{0}, a, t}\left(\frac{v}{L^{1 / 2}}+\varepsilon^{2} L^{4 n_{0}-2}\right)

$$

which concludes the proof.
We set

where $B=\left\{\left(k, k_{1}, k_{2}, k_{3}, k_{4}, k_{5}\right) \in \mathbb{R}^{6}| | k-k_{1}+k_{2}-k_{3} \left\lvert\, \geq \frac{1}{\mu}\right.\right\}$, where

$$
\Delta(\vec{k})=k^{2}+\sum_{j=1}^{5}(-1)^{j} k_{j}^{2}
$$

and $d \vec{k}=d k \prod_{j=1}^{5} d k_{j}$.
Proof. Let $\vec{k} \in C_{\sigma}:=\left\{\left(k, \vec{k}^{\prime}\right) \mid \vec{k}^{\prime} \in C_{\sigma}(k)\right\}$, we have

$$

where

J_{L}^{4}\left(t, k, k_{1}, k_{2}, k_{3}\right)=\int d k_{4} \frac{\sin (D(\vec{k}) t \rho)}{D(\vec{k})}\left|a\left(k_{4}\right)\right|^{2}\left|a\left(k+\sum_{j=1}^{4}(-1)^{j} k_{j}\right)\right|^{2} .
$$

Given a fixed $k, k_{1}, k_{2}, k_{3} \in C$, the derivative of $k_{4} \mapsto D(\vec{k})$ being

& \qquad \int d k_{4} \frac{1-\cos (D(\vec{k}) t \rho)}{\bar{k} D(\vec{k}) t \rho} \operatorname{Re}\left(a^{\prime}\left(k_{4}\right) \bar{a}\left(k_{4}\right)\left|a\left(\bar{k}+k_{4}\right)\right|^{2}+\left|a\left(k_{4}\right)\right|^{2} a^{\prime}\left(\bar{k}+k_{4}\right) \bar{a}\left(\bar{k}+k_{4}\right)\right) .
\end{aligned}
$$

For $j=1,2$, write

We divide the domain of integration of $J_{L, 2}$ in three parts as

J_{L, 4}(t, k)= & \frac{3}{4 \pi^{5}} \int_{C \cap\{\bar{D}>\tilde{D} / 2, D \leq \bar{D} / 2\}} d k d k_{1} d k_{2} d k_{3}\left|\hat{f}(k) \hat{g}(k) \| a\left(k_{1}\right)\right|^{2}\left|a\left(k_{2}\right)\right|^{2}\left|a\left(k_{3}\right)\right|^{2} J_{L, 2}^{4}\left(t, k_{1}, k_{2}, k_{3}\right)
\end{aligned}
$$

and

For $K_{L, 4}$ we use the inequalities on $\bar{k}$ and $\bar{D}$ to get

&=\frac{3}{4 \pi^{4}} \int d k_{1} d k_{2} d k_{3} \frac{1}{|\bar{k}|}\left|a\left(\frac{\bar{D}}{2 \bar{k}}\right)\right|^{2}\left|a\left(\bar{k}+\frac{\bar{D}}{2 \bar{k}}\right)\right|^{2}\left|a\left(k_{1}\right)\right|^{2}\left|a\left(k_{2}\right)\right|^{2}\left|a\left(k_{3}\right)\right|^{2}
\end{aligned}
$$

and the map below the integral is integrable.

### 5.2 Case $t=\frac{1}{3}$

Proposition 5.4. Assume that $\varepsilon^{-2}=2 \pi 2^{L} L^{2}+\rho(L)$ and that $t=\frac{1}{3}$. We have

$$

where $B=\left\{\left(k, k_{1}, k_{2}, k_{3}, k_{4}, k_{5}\right) \in \mathbb{R}^{6}| | k-k_{1}+k_{2}-k_{3} \left\lvert\, \geq \frac{1}{\mu}\right.\right\}$, where

$$
\Delta(\vec{k})=k^{2}+\sum_{j=1}^{5}(-1)^{j} k_{j}^{2}
$$

and $d \vec{k}=d k \prod_{j=1}^{5} d k_{j}$.
Proof. First, we see that

t=\frac{1}{3}=\sum_{n \geq 1} \frac{1}{2^{2 n}}
$$

and therefore

where $x_{L}=1$ if $L$ is even and $x_{L}=2$ if $L$ is odd. We deduce that

\Delta(\vec{k}) \varepsilon^{-2} t \in \Delta(\vec{k}) t \rho+\frac{2 \pi x_{L}}{3}\left[(k L)^{2}+\sum_{j=1}^{5}(-1)^{j}\left(L k_{j}\right)^{2}\right]+2 \pi \mathbb{Z}
$$

And therefore, we get

& \sin (\Delta(\vec{k}) \rho t) \cos \left(\frac{2 \pi x_{L}}{3}\left[(k L)^{2}+\sum_{j=1}^{5}(-1)^{j}\left(L k_{j}\right)^{2}\right]\right)+\cos (\Delta(\vec{k}) \rho t) \sin \left(\frac{2 \pi x_{L}}{3}\left[(k L)^{2}+\sum_{j=1}^{5}(-1)^{j}\left(L k_{j}\right)^{2}\right]\right) .
\end{aligned}
$$

To know the values of

\cos \left(\frac{2 \pi x_{L}}{3}\left[(k L)^{2}+\sum_{j=1}^{5}(-1)^{j}\left(L k_{j}\right)^{2}\right]\right)
$$

and

\sin \left(\frac{2 \pi x_{L}}{3}\left[(k L)^{2}+\sum_{j=1}^{5}(-1)^{j}\left(L k_{j}\right)^{2}\right]\right)
$$

it is sufficient to know the congruence of $L k, L k_{j}$ modulo 3. Therefore, we write

I_{\kappa, L}(t)=\sum_{\sigma \in \mathscr{I}} \frac{1}{L^{5}} \sum_{\vec{k} \in C_{\sigma, k}} \frac{\sin (\Delta(\vec{k}) t \rho) b_{\kappa, L}+\cos (\Delta(\vec{k}) t \rho) c_{\kappa, L}}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)}
$$

where

$$
C_{\sigma, \kappa}=\left\{\left(k, k_{1}, k_{2}, k_{3}, k_{4}, k_{5}\right) \in C_{\sigma} \mid L k \in \kappa(0)+3 \mathbb{Z}, \quad \forall j, \quad L k_{j} \in \kappa(j)+3 \mathbb{Z}\right\}
$$

and

$$
b_{\kappa, L}=\cos \left(\frac{2 \pi x_{L}}{3} \sum_{j=0}^{5}(-1)^{j} \kappa(j)^{2}\right)
$$

and

$$
c_{\kappa, L}=\sin \left(\frac{2 \pi x_{L}}{3} \sum_{j=0}^{5}(-1)^{j} \kappa(j)^{2}\right) .
$$

We divide $I_{\kappa, L}$ in two as

with

$$

and

K_{\kappa, L}=c_{\kappa, L} \sum_{\sigma \in \mathscr{I}} \frac{1}{L^{5}} \sum_{\vec{k} \in C_{\sigma, k}} \frac{\cos (\Delta(\vec{k}) t \rho)}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} .

With the same strategy as in the proof of Proposition 5.2, we have

$$

According to the program set in Appendix B, $b_{\kappa, L}=1$ in 99 cases and is equal to

\cos \left(\frac{2 \pi}{3}\right)=\cos \left(-\frac{2 \pi}{3}\right)=-\frac{1}{2}
$$

in 144 cases. Therefore,

\sum_{k} J_{K, L}=12 \frac{99-72}{3^{5}} \int_{\vec{k} \in B} \frac{\sin (\Delta(\vec{k}) t \rho)}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} d \vec{k}+O_{a, f, g}\left(\frac{\rho^{2}}{L}+\frac{\rho \mu}{v}+\frac{\rho}{\mu}\right) .
$$

Still according to the program in Appendix B, $c_{\kappa, L}=0$ in 99 cases, is equal to $\frac{\sqrt{3}}{2}$ in 72 cases and is equal to $-\frac{\sqrt{3}}{2}$ in 72 cases. We fix an involution $\kappa \mapsto \bar{\kappa}$ such that $c_{\bar{\kappa}, L}=-c_{\kappa, L}$. We get

& \quad-c_{\kappa, L} \sum_{\sigma \in \mathscr{I}} \frac{1}{L^{5}} \sum_{\vec{k} \in C_{\sigma, \bar{k}}} \frac{\cos (\Delta(\vec{k}) t \rho)-1}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} \\
&+c_{\kappa, L} \sum_{\sigma \in \mathscr{I}} \frac{1}{L^{5}} \sum_{\vec{k} \in C_{\sigma, k}} \frac{1}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} \\

& \frac{12}{3^{5}} \int_{\vec{k} \in B} \frac{\cos (\Delta(\vec{k}) t \rho)-1}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)}+O_{a, f, g}\left(\frac{\rho^{2}}{L}+\frac{\rho \mu}{v}+\frac{\rho}{\mu}\right)
\end{aligned}
$$

the key points being that $\frac{\cos (\Delta(\vec{k} t \rho)-1}{\Delta(\vec{k})} \leq t \rho$ and that the derivative of $\frac{\cos x-1}{x}$ is continuous and bounded.

This erases the first two lines in (9) as in

We deal with the remainder, we set

K_{\kappa, L, 2}=\frac{1}{L^{5}} \sum_{\vec{k} \in C_{\sigma, K}} \frac{1}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)}-\frac{1}{L^{5}} \sum_{\vec{k} \in C_{\sigma, \bar{k}}} \frac{1}{\Delta(\vec{k})} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)}
$$

Writing $C_{\kappa}=\left\{\vec{k} \mid L k \in \kappa(0)+3 \mathbb{Z}, \forall j, L k_{j} \in \kappa(j)+3 \mathbb{Z}\right\}$ and $\vec{j}=\vec{k}+\frac{\bar{k}-\kappa}{L}$, we get

& K_{\kappa, L, 2}=\frac{1}{L^{5}} \sum_{\vec{k} \in C_{k}}\left[\frac{\mathbf{1}_{\vec{k} \in C_{\sigma}}-\mathbf{1}_{\vec{j} \in C_{\sigma}}}{\Delta(\vec{k})}+\mathbf{1}_{\vec{j} \in C_{\sigma}}\left(\frac{1}{\Delta(\vec{k})}-\frac{1}{\Delta(\vec{j})}\right)\right] \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} \\
&+\frac{1}{L^{5}} \sum_{\vec{k} \in C_{k}} \frac{\mathbf{1}_{\vec{j} \in C_{\sigma}}}{\Delta(\vec{j})}\left(\prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)}-\prod_{j=1}^{5}\left|a\left(j_{j}\right)\right|^{2} \hat{f}(j) \overline{\hat{g}(j)}\right)
\end{aligned}
$$

We divide again $K_{\kappa, L, 2}$ into three parts as

K_{\kappa, L, 4}=\frac{1}{L^{5}} \sum_{\vec{k} \in C_{k}} \mathbf{1}_{\vec{j} \in C_{\sigma}}\left(\frac{1}{\Delta(\vec{k})}-\frac{1}{\Delta(\vec{j})}\right) \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)}
\end{gathered}
$$

and

$$
K_{\kappa, L, 5}=\frac{1}{L^{5}} \sum_{\vec{k} \in C_{k}} \frac{\mathbf{1}_{\vec{j} \in C_{\sigma}}}{\Delta(\vec{j})}\left(\prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)}-\prod_{j=1}^{5}\left|a\left(j_{j}\right)\right|^{2} \hat{f}(j) \overline{\hat{g}(j)}\right) .

We first deal with $K_{\kappa, L, 5}$. We have $|\vec{k}-\vec{j}| \leq \frac{2}{L}$. Hence,

$$

Besides $a$ has compact support hence there exists $M>0$ such that

\left|K_{\kappa, L, 5}\right| \lesssim a, f, g \frac{1}{L^{5}} \sum_{\vec{k} \in C_{\kappa} \cap[-M, M]^{6}} \frac{\mathbf{1}_{\vec{j} \in C_{\sigma}}{ }^{v}}{L} \lesssim a, f, g \frac{v}{L} .
$$

We turn to $K_{\kappa, L, 4}$. Given again the fact that $a$ has compact support, we get on the support of $\prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2}$ remembering that $k=-\sum_{j=1}^{5}(-1)^{j} k_{j}$,

Since $|\Delta(\vec{k})| \geq|\Delta(\vec{j})|-|\Delta(\vec{j})-\Delta(\vec{k})|$ and since $|\Delta(\vec{j})-\Delta(\vec{k})| \lesssim a L^{-1}$ we get that above a certain rank, since $v=o(\sqrt{L})$,

We now turn to $K_{\kappa, L, 3}$ and estimate the numbers of $\vec{k}$ such that

is not null. We assume without loss of generality that $\vec{k} \in C_{\sigma}$ but that $\vec{j} \notin C_{\sigma}$.
First Case : $|\Delta(\vec{j})|<v^{-1}$. We have

We recall that $\Delta(\vec{k})=\bar{D}\left(k, k_{1}, k_{2}, k_{3}\right)-2 \bar{k} k_{4}$ and thus

\frac{1}{v|\bar{k}|} \leq\left|k_{4}-\frac{\bar{D}}{2 \bar{k}}\right| \leq \frac{1}{v|\overline{\bar{k}}|}+C_{a} \frac{\mu}{v} .
$$

Hence $k_{4}$ belongs to the reunion of two intervals of size $C_{a} \frac{\mu}{L}$.
Second case: $|\bar{j}|<\mu^{-1}$. We have

$$
\mu^{-1} \leq|\bar{k}| \leq|\bar{j}|+|\bar{j}-\bar{k}| \leq \mu^{-1}+\frac{2}{L} .
$$

Therefore, $k_{3}$ belongs to the reunion of two intervals of size $\frac{2}{L}$.
Third case : $\left|\bar{j}_{\sigma}\right|<\mu^{-1}$. Similar to second case.
Therefore,

$$
\left|K_{\kappa, L, 3}\right| \lesssim a, f, g \frac{\mu \nu}{L}+\frac{v}{L}
$$

and we can conclude.

From Proposition 5.3, we therefore get

\lim _{L \rightarrow \infty} I_{L}(t)=\frac{1}{12 \pi^{4}} \int_{\mathbb{R}^{6}} \delta\left(k+\sum_{j=1}^{5}(-1)^{j} k_{j}\right) \delta(\Delta(\vec{k})) \frac{1}{k-k_{1}+k_{2}-k_{3}} \prod_{j=1}^{5}\left|a\left(k_{j}\right)\right|^{2} \hat{f}(k) \overline{\hat{g}(k)} d \vec{k}
$$

and get Theorem 1.2 .

We fix $\Delta=\Delta_{1}=k^{2}-k_{1}^{2}+k_{2}^{2}-k_{3}^{2}+k_{4}^{2}-k_{5}^{2}$, and $\Delta_{2}=k_{1}^{2}-j_{1}^{2}+j_{2}^{2}-j_{3}^{2}+j_{4}^{2}-j_{5}^{2}$. $$

## A. 2 Unlabeled trees

We draw a picture corresponding to Definition 3.7 in Figure 3. In mathematical writing, we have $\mathrm{t}_{0}=\perp, \mathrm{t}_{1}=(\perp, \perp, \perp, \perp, \perp)$ and $\mathrm{t}_{2}=((\perp, \perp, \perp, \perp, \perp), \perp, \perp, \perp, \perp)$. We also have $T_{0}=\mathrm{t}_{0}(k)$, $T_{1}=\mathrm{t}_{1}\left(\left(k_{1}, k_{2}, k_{3}, k_{4}, k_{5}\right)\right)$ and

$$
T_{2}=\mathrm{t}_{2}\left(\left(j_{1}, j_{2}, j_{3}, j_{4}, j_{5}, k_{2}, k_{3}, k_{4}, k_{5}\right)\right) .
$$

We draw a picture corresponding to Definition 3.8 in Figure 4 . We forgot some parenthesis as they were redundant.

Corresponding to Definition 3.9, we have

0 \mapsto k \\
(l, 0) \mapsto k_{l}

with $k=\sum_{l=1}^{5}(-1)^{l+1} k_{l}$ and

0 \mapsto k \\
(l, 0) \mapsto k_{l} \\
(1, l, 0) \mapsto j_{l}
\end{gathered}

(1,0) \mapsto \Delta_{2}
\end{gathered} .
$$

## A. 3 Node ordering

Finally, corresponding to Definition 3.13, we write explicitly the partial order $R_{\mathrm{t}_{4}}$ on the tree with four nodes of Figure 5. We have

$$
(1,4,0) R_{\mathrm{t}_{4}}(1,0) R_{\mathrm{t}_{4}} 0 \quad \text { and } \quad(5,0) R_{\mathrm{t}_{4}} 0
$$

and the other nodes are not comparable. In other words, $(1,0)$ is not comparable to $(5,0)$ but also $(1,4,0)$ is not comparable to $(5,0)$.
