# ASYMPTOTIC BEHAVIOR OF MULTISCALE STOCHASTIC PARTIAL DIFFERENTIAL EQUATIONS

#### Abstract

In this paper, we study the asymptotic behavior of a semi-linear slowfast stochastic partial differential equation with singular coefficients. Using the Poisson equation in Hilbert space, we first establish the strong convergence in the averaging principe, which can be viewed as a functional law of large numbers. Then we study the stochastic fluctuations between the original system and its averaged equation. We show that the normalized difference converges weakly to an OrnsteinUhlenbeck type process, which can be viewed as a functional central limit theorem. Furthermore, rates of convergence both for the strong convergence and the normal deviation are obtained, and these convergence are shown not to depend on the regularity of the coefficients in the equation for the fast variable, which coincides with the intuition, since in the limit systems the fast component has been totally averaged or homogenized out.

## 1. Introduction

Consider the following fully coupled slow-fast stochastic partial differential equation (SPDE for short) in $H_{1} \times H_{2}$ :

\begin{cases}\mathrm{d} X_{t}^{\varepsilon}=A X_{t}^{\varepsilon} \mathrm{d} t+F\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right) \mathrm{d} t+\mathrm{d} W_{t}^{1}, & X_{0}^{\varepsilon}=x \in H_{1}  \tag{1.1}\\ \mathrm{~d} Y_{t}^{\varepsilon}=\varepsilon^{-1} B Y_{t}^{\varepsilon} \mathrm{d} t+\varepsilon^{-1} G\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right) \mathrm{d} t+\varepsilon^{-1 / 2} \mathrm{~d} W_{t}^{2}, & Y_{0}^{\varepsilon}=y \in H_{2}\end{cases}
$$

where $H_{1}, H_{2}$ are two Hilbert spaces, $A: \mathcal{D}(A) \subset H_{1} \rightarrow H_{1}$ and $B: \mathcal{D}(B) \subset H_{2} \rightarrow H_{2}$ are linear operators, $F: H_{1} \times H_{2} \rightarrow H_{1}$ and $G: H_{1} \times H_{2} \rightarrow H_{2}$ are reaction coefficients, $W_{t}^{1}$ and $W_{t}^{2}$ are mutually independent $H_{1^{-}}$and $H_{2}$-valued $\left(\mathscr{F}_{t}\right)$-Wiener processes both defined on some probability space $(\Omega, \mathscr{F}, \mathbb{P})$ with a normal filtration $\left(\mathscr{F}_{t}\right)_{t \geqslant 0}$, and the small parameter $0<\varepsilon \ll 1$ represents the separation of time scales between the slow process $X_{t}^{\varepsilon}$ (which can be thought of as the mathematical model for a phenomenon appearing at the natural time scale) and the fast motion $Y_{t}^{\varepsilon}$ (with time order $1 / \varepsilon$, which can be interpreted as the fast environment). Such multi-scale models appear frequently in many real-world dynamical systems. Typical examples include climate weather interactions (see e.g. [32, 34]), macro-molecules (see e.g. [3, 29]), geophysical fluid flows (see e.g. [22]), stochastic volatility in finance (see e.g. [19]), etc. However, it is often too difficult to analyze or simulate the underlying system (1.1) directly due to the two widely separated time scales and the cross interactions between the slow and fast modes. Thus a simplified equation which governs the evolution of the system over a long time scale is highly desirable and is quite important for applications.

It is known that under suitable regularity assumptions on the coefficients, the slow process $X_{t}^{\varepsilon}$ will converge strongly (in the $L^{2}(\Omega)$-sense) to the solution of the following reduced equation:

where the averaged coefficient is given by

\bar{F}(x):=\int_{H_{2}} F(x, y) \mu^{x}(\mathrm{~d} y) \tag{1.3}
\end{equation*}

and $\mu^{x}(\mathrm{~d} y)$ is the unique invariant measure of the process $Y_{t}^{x}$, which is the solution of the frozen equation

\begin{equation*}
\mathrm{d} Y_{t}^{x}=B Y_{t}^{x} \mathrm{~d} t+G\left(x, Y_{t}^{x}\right) \mathrm{d} t+\mathrm{d} W_{t}^{2}, \quad Y_{0}^{x}=y \in H_{2} \tag{1.4}
\end{equation*}

The effective system (1.2) then captures the essential dynamics of the system (1.1), which does not depend on the fast variable any more and thus is much simpler than SPDE (1.1). This theory, known as the averaging principle, was first developed for deterministic systems by Bogoliubov [7], and extended to stochastic differential equations (SDEs for short) by Khasminskii [30]. In the past decades, the averaging principle for systems with a finite number of degrees of freedom has been intensively studied, see e.g. $[2,24,25,31,41]$ and the references therein. Passing from the finite dimensional to the infinite dimensional setting is more difficult, and the existing results in the literature are relatively few. In [12], Cerrai and Freidlin proved the averaging principle for slow-fast stochastic reaction-diffusion system where there is no noise in the slow equation. Later, Cerrai $[9,11]$ generalized this result to general reaction-diffusion equations with multiplicative noise and coefficients of polynomial growth, see also $[13,17,21]$ for further developments. We also mention that in these results, no rates of convergence in terms of $\varepsilon \rightarrow 0$ are provided. But for numerical purposes, it is important to know the rate of convergence of the slow variable to the effective dynamic. The main motivation comes from the well-known Heterogeneous Multi-scale Methods used to approximate the slow component in system (1.1), see e.g. [18, 33]. In this direction, Bréhier [4] first studied the rates of strong convergence for the averaging principle of SPDEs with noise only in the fast motion, and ( $\frac{1}{2}$-)order of convergence is obtained. Extensions to general stochastic reaction-diffusion equations are made in [42], and $\frac{1}{2}$-order of convergence is obtained. For more recent results, we refer the interested readers to the work [6] and the references therein.

The strong convergence in the averaging principle can be viewed as a functional law of large numbers. Once we obtain the validity of the averaging principle, it is natural to go one step further to consider the functional central limit theorem. Namely, to study the small fluctuations of the original system (1.1) around its averaged equation (1.2). To leading order, these fluctuations can be captured by characterizing the asymptotic behavior of the normalized difference

as $\varepsilon$ tends to 0 . Under extra regularity assumptions on the coefficients, the deviation process $Z_{t}^{\varepsilon}$ is known to converge weakly (in the distribution sense) towards a Gaussian process $\bar{Z}_{t}$, whose covariance can be described explicitly. Such result, also known as the Gaussian approximation, is closely related to the homogenization for solutions of partial differential equations with singularly perturbed terms, which has its own
interest in the theory of PDEs, see e.g. [26, 27] and [20, Chapter IV]. For the study of normal deviations of multi-scale SDEs, we refer the readers to the fundamental paper by Khasminskii [30], see also [36, 37, 40] for further developments. In the infinite dimensional situation, as far as we know, there exist only two papers. Cerrai [10] studied the normal deviations for slow-fast SPDEs in a special case, i.e., a deterministic reaction-diffusion equation with one dimensional space variable perturbed by a fast motion. Later, this was generalized to general stochastic reaction-diffusion equations by Wang and Roberts [42]. In both papers the methods of proof are based on the time discretisation procedure which involve some complicated tightness arguments. We point out that besides having intrinsic interest, the functional central limit theorem is also useful in applications. In particular, we can get the formal asymptotic expansion

X_{t}^{\varepsilon} \stackrel{\mathcal{D}}{\approx} \bar{X}_{t}+\sqrt{\varepsilon} \bar{Z}_{t}
$$

where $\underset{\sim}{\mathcal{D}}$ means approximate equality of probability distributions. Such expansion has been introduced in the context of stochastic climate models. In physics this is also called the Van Kampen's scheme (see e.g. [1, 28]), which provides better approximations for the original system (1.1).

In the present paper, we shall first establish a stronger convergence result in the averaging principle for $\operatorname{SPDE}$ (1.1). More precisely, we show that for any $T>0, q \geqslant 1$ and $\gamma \in[0,1 / 2)$, there exists a constant $C_{T}>0$ such that

\sup _{t \in[0, T]} \mathbb{E}\left\|(-A)^{\gamma}\left(X_{t}^{\varepsilon}-\bar{X}_{t}\right)\right\|^{q} \leqslant C_{T} \varepsilon^{\frac{q}{2}},
$$

see Theorem 2.2 below. Compared with the existing results in the literature, we assume that the coefficients are only Hölder continuous with respect to the fast variable, and we obtain not only the strong convergence in $L^{q}(\Omega)$-sense with any $q \geqslant 1$, but also in $\|\cdot\|_{(-A)^{\gamma}}$ norm with any $\gamma \in[0,1 / 2)$, which is particularly interesting for SPDEs in comparison with the finite dimensional setting since $A$ is an unbounded operator and seems to have never been obtained before. Moreover, the $\frac{1}{2}$-order rate of convergence is also obtained, which is known to be optimal (when $\gamma=0$ ). In particular, we show that the convergence in the averaging principle does not depend on the regularity of the coefficients with respect to the fast variable. This coincides with the intuition, since in the limit equation the fast component has been totally averaged out. We point out that the strong convergence of $(-A)^{\gamma} X_{t}^{\varepsilon}$ to $(-A)^{\gamma} \bar{X}_{t}$ will play an important role below in our study of the homogenization for the normalized difference $Z_{t}^{\varepsilon}$. Furthermore, the index $\gamma<1 / 2$ should be the best possible, see Remark 2.3 for more detailed explanations.

The argument we shall use to establish the above strong convergence is different from those in $[4,9,11,12,13,17,21,42]$, where the classical Khasminskii's time
discretisation procedure is used. Our method is based on the Poisson equation. More precisely, consider the following Poisson equation in the Hilbert space $H_{1} \times H_{2}$ :

where $\mathcal{L}_{2}(x, y)$ is an ergodic elliptic operator with respect to the $y$ variable (see (2.7) below), $x \in H_{1}$ is regarded as a parameter, and $\phi: H_{1} \times H_{2} \rightarrow \mathbb{R}$ is a measurable function. Such kind of equation, i.e., with a parameter and in the whole space (without boundary condition), has been studied only relatively recently and is now realized to be very important in the theory of limit theorems in probability theory and numerical approximation for time-averaging estimators and invariant measures, see e.g. [35, 39]. In the finite dimensional situation, equations of the form (1.6) have been studied in a series of papers by Pardoux and Veretennikov [36, 37, 38], see also [40] and the references therein for further developments. Undoubtedly, extension to the infinite dimensional setting will be more difficult due to the unboundedness of the involved operators. In the recent work [6], the author studies the rate of convergence in the averaging principle for slow-fast SPDEs with regular coefficients by assuming the solvability of the corresponding Poisson equation as well as regularity properties of the solutions. In addition, the SPDE considered therein is not fully coupled, i.e., the fast component $Y_{t}^{\varepsilon}$ does not depend on the slow process $X_{t}^{\varepsilon}$, and the two Hilbert spaces $H_{1}, H_{2}$ and the unbounded operators $A, B$ are assumed to be the same, which are used in the whole proof in an essential way. Here, we shall establish the well-posedness of the Poisson equation (1.6) with only Hölder coefficients and in general Hilbert spaces $H_{1} \times H_{2}$, and study the regularity properties of the unique solution with respect to both the $y$-variable and the parameter $x$, see Theorem 3.2 below, which should be of independent interest. Then, we use the Poisson equation to derive a strong fluctuation estimate (see Lemma 4.2) for an integral functional of the slow-fast SPDE (1.1). The strong convergence in the averaging principle with optimal rate of convergence then follows directly. In addition, we also provide a simple way to verify the regularity of the averaged coefficients by using Theorem 3.2 (see Lemma 3.7 below), which is a separate problem that one always encounters in the study of averaging principles, central limit theorems, homogenization and other limit theorems.

Next, we proceed to study the small fluctuations of the slow process $X_{t}^{\varepsilon}$ around its average $\bar{X}_{t}$, i.e., we are interested in the homogenization behavior for $Z_{t}^{\varepsilon}$ which is defined by (1.5). In view of (1.1) and (1.2), we have

\mathrm{d} Z_{t}^{\varepsilon} & =A Z_{t}^{\varepsilon} \mathrm{d} t+\frac{1}{\sqrt{\varepsilon}}\left[F\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right)-\bar{F}\left(\bar{X}_{t}\right)\right] \mathrm{d} t \\
& =A Z_{t}^{\varepsilon} \mathrm{d} t+\frac{1}{\sqrt{\varepsilon}}\left[\bar{F}\left(X_{t}^{\varepsilon}\right)-\bar{F}\left(\bar{X}_{t}\right)\right] \mathrm{d} t+\frac{1}{\sqrt{\varepsilon}} \delta F\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right) \mathrm{d} t \tag{1.7}
\end{align*}
$$

where

$$
\begin{equation*}
\delta F(x, y):=F(x, y)-\bar{F}(x) . \tag{1.8}
\end{equation*}
$$

We demonstrate that $Z_{t}^{\varepsilon}$ converges weakly to an Ornstein-Uhlenbeck type process $\bar{Z}_{t}$ which satisfies the following linear SPDE:

$$
\mathrm{d} \bar{Z}_{t}=A \bar{Z}_{t} \mathrm{~d} t+D_{x} \bar{F}\left(\bar{X}_{t}\right) \cdot \bar{Z}_{t} \mathrm{~d} t+\sigma\left(\bar{X}_{t}\right) \mathrm{d} \tilde{W}_{t}
$$

where $\tilde{W}_{t}$ is another cylindrical Wiener process which is independent of $W_{t}^{1}$, and the diffusion coefficient $\sigma$ is Hilbert-Schmidt operator valued and given by (2.9), see Theorem 2.4 below. Compared with [10, 42], our system (1.1) is more general, and the coefficients are assumed to be only Hölder continuous with respect to the fast variable, and we provide a more precise formula for the new diffusion coefficient $\sigma$. Moreover, the arguments we use to prove the above convergence is different from [10, 42], and in addition the rate of convergence is obtained, which does not depends on the regularity of the coefficients with respect to the fast variable.

It turns out that our method to prove the above functional central limit theorem is closely and universally connected with the proof of the strong convergence in the averaging principle. Namely, we shall first use the result on the Poisson equation (1.6) established in Theorem 3.2 to derive some weak fluctuation estimates (see Lemma 5.5) for an integral functional involving the processes $\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right)$ and $Z_{t}^{\varepsilon}$. Combining with the Kolmogorov equation associated with the process $\left(\bar{X}_{t}, \bar{Z}_{t}\right)$, we prove the weak convergence of $Z_{t}^{\varepsilon}$ to $\bar{Z}_{t}$ directly, and rate of convergence is obtained as easy by-product. In addition, it will be quite easy to capture the structure of the homogenization limit $\bar{Z}_{t}$ from our arguments. Here, we note that the whole system of equations satisfied by $\left(\bar{X}_{t}, \bar{Z}_{t}\right)$ is an SPDE with multiplicative noise. Even though infinite dimensional Kolmogorov equations with nonlinear diffusion coefficients have been studied very recently in [5], the regularity of the solutions obtained therein are not sufficient for our purpose. Thus, we derive some new regularity for the solution with respect to the $z$ variable (see Theorem 5.1 below), and develop a trick in the proof of Theorem 2.4 to avoid using the regularity for the solution with respect to the $x$ variable. Our approach can also be adapted to study the normal deviations for other classes of multi-scale SPDEs. We shall address these problems in future works.

The rest of this paper is organized as follows. In Section 2, we introduce some assumptions and state our main results. Section 3 is devoted to study the Poisson equation in Hilbert spaces. Then, we prove the strong convergence result, Theorem 2.2 , and the normal deviation result, Theorem 2.4, in Section 4 and Section 5, respectively. Finally, in the Appendix we prove some necessary estimates for the solution of the multiscale system (1.1), which are slight generalizations of the existing results in the literature. Throughout this paper, the letter $C$ with or without subscripts will
denote a positive constant, whose value may change in different places, and whose dependence on parameters can be traced from the calculations.

Notations: To end this section, we introduce some notations, which will be used throughout this paper. Let $H_{1}, H_{2}$ and $H$ be three Hilbert spaces endowed with the scalar products $\langle\cdot, \cdot\rangle_{1},\langle\cdot, \cdot\rangle_{2}$ and $\langle\cdot, \cdot\rangle_{H}$, respectively. The corresponding norms will be denoted by $\|\cdot\|_{1},\|\cdot\|_{2}$ and $\|\cdot\|_{H}$. We use $\mathscr{L}\left(H_{1}, H_{2}\right)$ to denote the space of all linear and bounded operators from $H_{1}$ to $H_{2}$. If $H_{1}=H_{2}$, we write $\mathscr{L}\left(H_{1}\right)=\mathscr{L}\left(H_{1}, H_{1}\right)$ for simplicity. Recall that an operator $Q \in \mathscr{L}(H)$ is called Hilbert-Schmidt if

We shall denote the space of all Hilbert-Schmidt operators on $H$ by $\mathscr{L}_{2}(H)$.
For any $x \in H_{1}, y \in H_{2}$ and $\phi: H_{1} \times H_{2} \rightarrow H$, we say that $\phi$ is Gâteaux differentiable at $x$ if there exists a $D_{x} \phi(x, y) \in \mathscr{L}\left(H_{1}, H\right)$ such that for all $h_{1} \in H_{1}$,

\lim _{\tau \rightarrow 0} \frac{\phi\left(x+\tau h_{1}, y\right)-\phi(x, y)}{\tau}=D_{x} \phi(x, y) \cdot h_{1} .

If in addition

\lim _{\left\|h_{1}\right\|_{1} \rightarrow 0} \frac{\left\|\phi\left(x+h_{1}, y\right)-\phi(x, y)-D_{x} \phi(x, y) \cdot h_{1}\right\|_{H}}{\left\|h_{1}\right\|_{1}}=0

$\phi$ is called Fréchet differentiable at $x$. Similarly, for any $k \geqslant 2$ we can define the $k$ times Gâteaux and Fréchet derivative of $\phi$ at $x$, and we will identify the higher order derivative $D_{x}^{k} \phi(x, y)$ with a linear operator in $\mathscr{L}^{k}\left(H_{1}, H\right):=\mathscr{L}\left(H_{1}, \mathscr{L}^{(k-1)}\left(H_{1}, H\right)\right)$, endowed with the operator norm

\left\|D_{x}^{k} \phi(x, y)\right\|_{\mathscr{L}^{k}\left(H_{1}, H\right)}:=\sup _{\left\|h_{1}\right\|_{1},\left\|h_{2}\right\|_{1}, \cdots,\left\|h_{k}\right\|_{1},\|h\|_{H} \leqslant 1}\left\langle D_{x}^{k} \phi(x, y) .\left(h_{1}, h_{2}, \cdots, h_{k}\right), h\right\rangle_{H} .

In the same way, we define the Gâteaux and Fréchet derivatives of $\phi$ with respect to the $y$ variable, and we have $D_{y} \phi(x, y) \in \mathscr{L}\left(H_{2}, H\right)$, and for $k \geqslant 2, D_{y}^{k} \phi(x, y) \in$ $\mathscr{L}^{k}\left(H_{2}, H\right):=\mathscr{L}\left(H_{2}, \mathscr{L}^{(k-1)}\left(H_{2}, H\right)\right)$.

We will denote by $L_{p}^{\infty}\left(H_{1} \times H_{2}, H\right)$ the space of all measurable maps $\phi: H_{1} \times H_{2} \rightarrow$ $H$ with linear growth in $x$ and polynomial growth in $y$, i.e., there exists a constant $p \geqslant 1$ such that

\|\phi\|_{L_{p}^{\infty}(H)}:=\sup _{(x, y) \in H_{1} \times H_{2}} \frac{\|\phi(x, y)\|_{H}}{1+\|x\|_{1}+\|y\|_{2}^{p}}<\infty .

For $k \in \mathbb{N}$, the space $C_{p}^{k, 0}\left(H_{1} \times H_{2}, H\right)$ contains all maps $\phi \in L_{p}^{\infty}\left(H_{1} \times H_{2}, H\right)$ which are $k$ times Gâteaux differentiable at any $x \in H_{1}$ and

\|\phi\|_{C_{p}^{k, 0}(H)}:=\sup _{(x, y) \in H_{1} \times H_{2}} \frac{\sum_{\ell=1}^{k}\left\|D_{x}^{\ell} \phi(x, y)\right\|_{\mathscr{L}^{\ell}\left(H_{1}, H\right)}}{1+\|y\|_{2}^{p}}<\infty .

Similarly, the space $C_{p}^{0, k}\left(H_{1} \times H_{2}, H\right)$ consists of all maps $\phi \in L_{p}^{\infty}\left(H_{1} \times H_{2}, H\right)$ which are $k$ times Gâteaux differentiable at any $y \in H_{2}$ and

\|\phi\|_{C_{p}^{0, k}(H)}:=\sup _{(x, y) \in H_{1} \times H_{2}} \frac{\sum_{\ell=1}^{k}\left\|D_{y}^{\ell} \phi(x, y)\right\|_{\mathscr{L}^{\ell}\left(H_{2}, H\right)}}{1+\|x\|_{1}+\|y\|_{2}^{p}}<\infty . \tag{1.9}

We also introduce the space $\mathbb{C}_{p}^{0, k}\left(H_{1} \times H_{2}, H\right)$ consisting of all maps which are $k$ times Fréchet differentiable at any $y \in H_{2}$ and satisfies (1.9). For $k, \ell \in \mathbb{N}$, let $C_{p}^{k, \ell}\left(H_{1} \times H_{2}, H\right)$ be the space of all maps satisfying

and for $\eta \in(0,1)$, we use $C_{p}^{k, \eta}\left(H_{1} \times H_{2}, H\right)$ to denote the subspace of $C_{p}^{k, 0}\left(H_{1} \times H_{2}, H\right)$ consisting of all maps such that

\left\|\phi\left(x, y_{1}\right)-\phi\left(x, y_{2}\right)\right\|_{H} \leqslant C_{0}\left\|y_{1}-y_{2}\right\|_{2}^{\eta}\left(1+\|x\|_{1}+\left\|y_{1}\right\|_{2}^{p}+\left\|y_{2}\right\|_{2}^{p}\right)
$$

When the subscript $p$ is replaced by $b$ in the notations for above spaces, we mean that the map itself and its derivatives are all bounded. When $H=\mathbb{R}$, we will omit the letter $H$ in the above notations for simplicity.

## 2. Statement of the main results

2.1. Assumptions and preliminaries. For $i=1,2$, let $\left\{e_{i, n}\right\}_{n \in \mathbb{N}}$ be a complete orthonormal basis of $H_{i}$. We assume that the two unbounded linear operators $A$ and $B$, with domains $\mathcal{D}(A)$ and $\mathcal{D}(B)$, satisfy the following condition:
(A1): There exist non-decreasing sequences of real positive numbers $\left\{\alpha_{n}\right\}_{n \in \mathbb{N}}$ and $\left\{\beta_{n}\right\}_{n \in \mathbb{N}}$ such that

$$
\begin{equation*}
A e_{1, n}=-\alpha_{n} e_{1, n}, \quad B e_{2, n}=-\beta_{n} e_{2, n}, \quad \forall n \in \mathbb{N} \tag{2.1}
\end{equation*}
$$

In this setting, the powers of $-A$ and $-B$ can be easily defined as follows: for any $\theta \in[0,1]$,

$$
(-A)^{\theta} x:=\sum_{n \in \mathbb{N}} \alpha_{n}^{\theta}\left\langle x, e_{1, n}\right\rangle_{1} e_{1, n} \quad \text { and } \quad(-B)^{\theta} y:=\sum_{n \in \mathbb{N}} \beta_{n}^{\theta}\left\langle y, e_{2, n}\right\rangle_{2} e_{2, n}
$$

with domains

$$
\mathcal{D}\left((-A)^{\theta}\right):=\left\{x \in H_{1}:\|x\|_{(-A)^{\theta}}^{2}:=\sum_{n \in \mathbb{N}} \alpha_{n}^{2 \theta}\left\langle x, e_{1, n}\right\rangle_{1}^{2}<\infty\right\}
$$

and

$$
\mathcal{D}\left((-B)^{\theta}\right):=\left\{y \in H_{2}:\|y\|_{(-B)^{\theta}}^{2}:=\sum_{n \in \mathbb{N}} \beta_{n}^{2 \theta}\left\langle y, e_{2, n}\right\rangle_{2}^{2}<\infty\right\} .
$$

Moreover, the corresponding semigroups $\left\{e^{t A}\right\}_{t \geqslant 0}$ and $\left\{e^{t B}\right\}_{t \geqslant 0}$ can be defined through the following spectral formulas: for any $t \geqslant 0, x \in H_{1}$ and $y \in H_{2}$,

$$
e^{t A} x:=\sum_{n \in \mathbb{N}} e^{-\alpha_{n} t}\left\langle x, e_{1, n}\right\rangle_{1} e_{1, n} \quad \text { and } \quad e^{t B} y:=\sum_{n \in \mathbb{N}} e^{-\beta_{n} t}\left\langle y, e_{2, n}\right\rangle_{2} e_{2, n}
$$

The following regularization properties for these semigroups are more or less standard. We write them for $e^{t A}$, but they also hold for $e^{t B}$.

Proposition 2.1. Let $\gamma \in[0,1]$ and $\theta \in[0, \gamma]$. We have:
(i) For any $t>0$ and $x \in \mathcal{D}\left((-A)^{\theta}\right)$,

$$
\begin{equation*}
\left\|e^{t A} x\right\|_{(-A)^{\gamma}} \leqslant C_{\gamma, \theta} t^{-\gamma+\theta} e^{-\frac{\alpha_{1}}{2} t}\|x\|_{(-A)^{\theta}} \tag{2.2}
\end{equation*}
$$

(ii) For any $0 \leqslant s \leqslant t$ and $x \in H_{1}$,

$$
\begin{equation*}
\left\|e^{t A} x-e^{s A} x\right\|_{1} \leqslant C_{\gamma}(t-s)^{\gamma}\left\|e^{s A} x\right\|_{(-A)^{\gamma}} \tag{2.3}
\end{equation*}
$$

(iii) For any $0<s \leqslant t$ and $x \in \mathcal{D}\left((-A)^{\theta}\right)$,

$$
\begin{equation*}
\left\|e^{t A} x-e^{s A} x\right\|_{1} \leqslant C_{\gamma, \theta} \frac{(t-s)^{\gamma}}{s^{\gamma-\theta}} e^{-\frac{\alpha_{1}}{2} s}\|x\|_{(-A)^{\theta}} \tag{2.4}
\end{equation*}
$$

where $\alpha_{1}$ is the smallest eigenvalue of $A$, and $C_{\gamma}, C_{\gamma, \theta}>0$ are constants.
Proof. For any $t>0$ and $x \in \mathcal{D}\left((-A)^{\theta}\right)$, we have

$$
\begin{aligned}
& \left\|(-A)^{\gamma} e^{t A} x\right\|_{1}^{2}=\left\|\sum_{n \in \mathbb{N}} \alpha_{n}^{\gamma} e^{-\alpha_{n} t}\left\langle x, e_{1, n}\right\rangle_{1} e_{1, n}\right\|_{1}^{2} \\
& =\sum_{n \in \mathbb{N}} \alpha_{n}^{2(\gamma-\theta)} e^{-2 \alpha_{n} t} \alpha_{n}^{2 \theta}\left|\left\langle x, e_{1, n}\right\rangle_{1}\right|^{2} \\
& \leqslant C_{\gamma, \theta} t^{-2(\gamma-\theta)} e^{-\alpha_{1} t / 2} \sum_{n \in \mathbb{N}} \alpha_{n}^{2 \theta}\left|\left\langle x, e_{1, n}\right\rangle_{1}\right|^{2}=C_{\theta, \gamma} t^{-2(\gamma-\theta)} e^{-\alpha_{1} t / 2}\|x\|_{(-A)^{\theta}}^{2},
\end{aligned}
$$

which yields (2.2). To show estimate (2.3), by the basic inequality that $1-e^{-\alpha t} \leqslant$ $C_{\alpha, \gamma} t^{\gamma}$ with $\gamma \in[0,1], \alpha>0$, we deduce that for any $0 \leqslant s \leqslant t$ and $x \in H_{1}$,

$$
\left\|e^{t A} x-e^{s A} x\right\|_{1}^{2}=\left\|\sum_{n \in \mathbb{N}}\left(e^{-\alpha_{n} t}-e^{-\alpha_{n} s}\right)\left\langle x, e_{1, n}\right\rangle_{1} e_{1, n}\right\|_{1}^{2}
$$

$$
\begin{aligned}
& \leqslant C_{\gamma} \sum_{n \in \mathbb{N}} \alpha_{n}^{2 \gamma}(t-s)^{2 \gamma} e^{-2 \alpha_{n} s}\left|\left\langle x, e_{1, n}\right\rangle_{1}\right|^{2} \\
& =C_{\gamma}(t-s)^{2 \gamma}\left|\left\langle(-A)^{\gamma} e^{s A} x, e_{1, n}\right\rangle_{1}\right|^{2} \\
& =C_{\gamma}(t-s)^{2 \gamma}\left\|e^{s A} x\right\|_{(-A)^{\gamma}}^{2} .
\end{aligned}
$$

Combining (2.2) and (2.3), we immediately get (2.4).
For $i=1,2$, let $Q_{i}$ be two linear self-adjoint operators on $H_{i}$ with positive eigenvalues $\left\{\lambda_{i, n}\right\}_{n \in \mathbb{N}}$, i.e.,

$$
Q_{i} e_{i, n}=\lambda_{i, n} e_{i, n}, \quad \forall n \in \mathbb{N} .
$$

Let $W_{t}^{i}, i=1,2$, be $H_{i}$-valued $Q_{i}$-Wiener processes both defined on a complete filtered probability space $\left(\Omega, \mathscr{F}, \mathscr{F}_{t}, \mathbb{P}\right)$. Then it is known that $W_{t}^{i}$ can be written as

$$
W_{t}^{i}=\sum_{n \in \mathbb{N}} \sqrt{\lambda_{i, n}} \beta_{i, n}(t) e_{i, n}
$$

where $\left\{\beta_{i, n}\right\}_{n \in \mathbb{N}}$ are mutual independent real-valued Brownian motions. Note that $W_{t}^{i}(i=1,2)$ are non-degenerate. We shall further assume that:
(A2): For $i=1,2$,

$$
\operatorname{Tr}\left(Q_{i}\right):=\sum_{n \in \mathbb{N}} \lambda_{i, n}<+\infty \quad \text { and } \quad \operatorname{Tr}\left((-A) Q_{1}\right)<+\infty
$$

and for any $T>0$,

$$
\int_{0}^{T} \Upsilon_{t}^{\frac{1+\theta}{2}} \mathrm{~d} t<\infty
$$

where

$$
\Upsilon_{t}:=\sup _{n \geqslant 1} \frac{2 \beta_{n}}{\lambda_{2, n}\left(e^{2 \beta_{n} t}-1\right)}<\infty
$$

$\beta_{n}$ is given by (2.1), and $\theta \geqslant \max (\eta, 1-\eta)$ with $\eta$ being the Hölder regularity of the coefficients in the assumptions of Theorem 2.2 below (see [16, Lemma 9] for this condition).
2.2. Main results. The first main result of this paper is about the strong convergence in the averaging principle for SPDE (1.1).

Theorem 2.2 (Strong convergence). Let $T>0, x \in \mathcal{D}\left((-A)^{\theta}\right)$ and $y \in \mathcal{D}\left((-B)^{\theta}\right)$ with $\theta>0$. Assume that (A1) and (A2) hold, $F \in C_{p}^{2, \eta}\left(H_{1} \times H_{2}, H_{1}\right)$ and $G \in$ $C_{b}^{2, \eta}\left(H_{1} \times H_{2}, H_{2}\right)$ with $\eta>0$. Then for any $q \geqslant 1$ and $\gamma \in[0, \theta \wedge 1 / 2)$, we have

$$
\begin{equation*}
\sup _{t \in[0, T]} \mathbb{E}\left\|X_{t}^{\varepsilon}-\bar{X}_{t}\right\|_{(-A)^{\gamma}}^{q} \leqslant C_{1} \varepsilon^{\frac{q}{2}}, \tag{2.5}
\end{equation*}
$$

where $\bar{X}_{t}$ solves equation (1.2), and $C_{1}=C(T, x, y)>0$ is a constant independent of $\eta$ and $\varepsilon$.

To compare our result with previous work in the literature, we make the following comments:

Remark 2.3. (i) When $\gamma=0$ in (2.5), the $1 / 2$-order rate of convergence in the $L^{2}(\Omega)$-sense is known to be optimal, which is the same as in the SDE case. However, the convergence in $\|\cdot\|_{(-A)^{\gamma}}$ norm seems to have never been studied before. This is particularly interesting for SPDEs since $A$ is in general an unbounded operator, and will play an important role below to study the homogenization for $Z_{t}^{\varepsilon}$.
(ii) Note that the coefficients are assumed to be only $\eta$-Hölder continuous with respect to the fast variable, and the convergence rate does not dependent on $\eta$. This indicates that the convergence in the averaging principle does not depend on the regularity of the coefficients with respect to the fast variable, which coincides with the intuition, since in the limit equation the fast component has been totally averaged out.
(iii) Let us explain why $\gamma<1 / 2$ should be the best possible. In fact, the main reason is that the processes $X_{t}^{\varepsilon}$ and $Y_{t}^{\varepsilon}$ are only $\gamma$-Hölder continuous with respect to the time variable with $\gamma<1 / 2$. From another point of view, for $Z_{t}^{\varepsilon}$ given by (1.5), estimate (2.5) means that for every $t \geqslant 0$, we have

$$
\sup _{\varepsilon \in(0,1)} \mathbb{E}\left\|(-A)^{\gamma} Z_{t}^{\varepsilon}\right\|_{1}^{2}<\infty
$$

But by Theorem 2.4 below, we have that $Z_{t}^{\varepsilon}$ converges to $\bar{Z}_{t}$ with $\bar{Z}_{t}$ satisfying (2.8). Through straightforward computations we find that $\mathbb{E}\left\|(-A)^{\gamma} \bar{Z}_{t}\right\|_{1}^{2}<\infty$ only when $\gamma<1 / 2$.

Recall that $Z_{t}^{\varepsilon}$ is defined by (1.5). To study the homogenization for $Z_{t}^{\varepsilon}$, we need to consider the following Poisson equation:

$$
\begin{equation*}
\mathcal{L}_{2}(x, y) \Psi(x, y)=-\delta F(x, y) \tag{2.6}
\end{equation*}
$$

where $\delta F$ is given by (1.8), and $\mathcal{L}_{2}(x, y)$ is defined by

$$
\begin{align*}
\mathcal{L}_{2} \varphi(x, y):= & \mathcal{L}_{2}(x, y) \varphi(x, y):=\left\langle B y+G(x, y), D_{y} \varphi(x, y)\right\rangle_{2} \\
& +\frac{1}{2} \operatorname{Tr}\left[D_{y}^{2} \varphi(x, y) Q_{2}\right], \quad \forall \varphi \in C_{p}^{0,2}\left(H_{1} \times H_{2}\right) . \tag{2.7}
\end{align*}
$$

According to Theorem 3.2 and Remark 3.3 below, there exists a unique solution $\Psi$ to equation (2.6). It turns out that the limit $\bar{Z}_{t}$ of $Z_{t}^{\varepsilon}$ satisfies the following linear equation:

$$
\begin{equation*}
\mathrm{d} \bar{Z}_{t}=A \bar{Z}_{t} \mathrm{~d} t+D_{x} \bar{F}\left(\bar{X}_{t}\right) \cdot \bar{Z}_{t} \mathrm{~d} t+\sigma\left(\bar{X}_{t}\right) \mathrm{d} \tilde{W}_{t}, \quad \bar{Z}_{0}=0 \tag{2.8}
\end{equation*}
$$

where $\tilde{W}_{t}$ is a cylindrical Wiener process in $H_{1}$ which is independent of $W_{t}^{1}$, and $\sigma: H_{1} \rightarrow \mathscr{L}\left(H_{1}\right)$ satisfies

$$
\begin{equation*}
\frac{1}{2} \sigma(x) \sigma^{*}(x)=\overline{\delta F \otimes \Psi}(x):=\int_{H_{2}}[\delta F(x, y) \otimes \Psi(x, y)] \mu^{x}(\mathrm{~d} y) \tag{2.9}
\end{equation*}
$$

The following is the second main result of this paper.
Theorem 2.4 (Normal deviations). Let $T>0, x \in \mathcal{D}\left((-A)^{\theta}\right)$ and $y \in \mathcal{D}\left((-B)^{\theta}\right)$ with $\theta>0$. Assume that (A1) and (A2) hold, $F \in C_{p}^{2, \eta}\left(H_{1} \times H_{2}, H_{1}\right)$ and $G \in$ $C_{b}^{2, \eta}\left(H_{1} \times H_{2}, H_{2}\right)$ with $\eta>0$. Then for any $\gamma \in(0,1 / 2)$ and $\varphi \in \mathbb{C}_{b}^{4}\left(H_{1}\right)$, we have

$$
\sup _{t \in[0, T]}\left|\mathbb{E}\left[\varphi\left(Z_{t}^{\varepsilon}\right)\right]-\mathbb{E}\left[\varphi\left(\bar{Z}_{t}\right)\right]\right| \leqslant C_{2} \varepsilon^{\frac{1}{2}-\gamma}
$$

where $C_{2}=C(T, x, y, \varphi)>0$ is a constant independent of $\eta$ and $\varepsilon$.
Remark 2.5. Note that we claim that $\tilde{W}_{t}$ in (2.8) is independent of $W_{t}^{1}$. The advantage of formula (2.9) is that we can study the regularity properties of $\sigma$ directly by using the result of the Poisson equation established in Theorem 3.2 below. Furthermore, one can check that $\sigma(x)$ is a Hilbert-Schmidt operator. In fact, by Theorem 3.2 we have

$$
\begin{aligned}
\|\sigma(x)\|_{\mathscr{L}_{2}\left(H_{1}\right)}^{2} & =\sum_{n \in \mathbb{N}}\left\langle\sigma(x) \sigma^{*}(x) e_{1, n}, e_{1, n}\right\rangle_{1} \\
& =2 \sum_{n \in \mathbb{N}}\left\langle\int_{H_{2}}[\delta F(x, y) \otimes \Psi(x, y)] \mu^{x}(\mathrm{~d} y) e_{1, n}, e_{1, n}\right\rangle_{1} \\
& =2 \int_{H_{2}}\langle\delta F(x, y), \Psi(x, y)\rangle_{1} \mu^{x}(\mathrm{~d} y) \\
& \leqslant C_{0} \int_{H_{2}}\left(1+\|y\|_{2}^{2 p}\right) \mu^{x}(\mathrm{~d} y)<\infty .
\end{aligned}
$$

Thus, the stochastic integral part in (2.8) is well-defined.

## 3. Poisson Equation in Hilbert space

Consider the following Poisson equation in the infinite dimensional Hilbert space $\mathrm{H}_{2}$ :

$$
\begin{equation*}
\mathcal{L}_{2}(x, y) \psi(x, y)=-\phi(x, y) \tag{3.1}
\end{equation*}
$$

where $\mathcal{L}_{2}(x, y)$ is defined by (2.7), $x \in H_{1}$ is regarded as a parameter, and $\phi$ : $H_{1} \times H_{2} \rightarrow \mathbb{R}$ is a Borel-measurable function. Recall that $Y_{t}^{x}(y)$ satisfies the frozen equation (1.4) and $\mu^{x}(\mathrm{~d} y)$ is the invariant measure of $Y_{t}^{x}(y)$ (see Lemma 3.4 below).

Since we are considering (3.1) on the whole space and not on a compact subset, it is necessary to make the following "centering" assumption on $\phi$ :

$$
\begin{equation*}
\int_{H_{2}} \phi(x, y) \mu^{x}(\mathrm{~d} y)=0, \quad \forall x \in H_{1} . \tag{3.2}
\end{equation*}
$$

Such kind of assumption is also natural and analogous to the centering condition in the standard central limit theorem, see e.g. [36, 37].

We first introduce the following definition of solutions for equation (3.1).
Definition 3.1. A measurable function $\psi: H_{1} \times H_{2} \rightarrow \mathbb{R}$ is said to be a classical solution to equation (3.1) if:
(i) the function $\psi(x, y) \in C_{p}^{0,2}\left(H_{1} \times H_{2}\right)$ and for any $(x, y) \in H_{1} \times H_{2}$, the operator $D_{y}^{2} \psi(x, y) \in \mathscr{L}\left(H_{2}\right)$;
(ii) for any $x \in H_{1}$ and $y \in \mathcal{D}(B)$, the function $\psi$ satisfies equation (3.1).

The main aim of this section is to prove the following result.
Theorem 3.2. Let $\eta>0$ and $k=0,1,2$. Assume that (A1) and (A2) hold, and $G \in C_{b}^{k, \eta}\left(H_{1} \times H_{2}, H_{2}\right)$. Then for every $\phi \in C_{p}^{k, \eta}\left(H_{1} \times H_{2}\right)$ satisfying (3.2), there exists a unique classical solution $\psi \in C_{p}^{k, 0}\left(H_{1} \times H_{2}\right) \cap \mathbb{C}_{p}^{0,2}\left(H_{1} \times H_{2}\right)$ to equation (3.1) satisfying (3.2), which is given by

$$
\begin{equation*}
\psi(x, y)=\int_{0}^{\infty} \mathbb{E}\left[\phi\left(x, Y_{t}^{x}(y)\right)\right] \mathrm{d} t \tag{3.3}
\end{equation*}
$$

where $Y_{t}^{x}(y)$ satisfies the frozen equation (1.4).
Remark 3.3. We can also solve the Poisson equation (3.1) for Hilbert space valued function $\tilde{\phi}$, i.e., $\tilde{\phi}: H_{1} \times H_{2} \rightarrow H$ with $H$ being another Hilbert space. In fact, let $\left\{e_{n}\right\}_{n \in \mathbb{N}}$ be the orthonormal basis of $H$, and define

$$
\phi_{n}(x, y):=\left\langle\tilde{\phi}(x, y), e_{n}\right\rangle_{H} .
$$

Then for each $n \in \mathbb{N}$, we have $\phi_{n}: H_{1} \times H_{2} \rightarrow \mathbb{R}$, and thus there exists a solution $\psi_{n}: H_{1} \times H_{2} \rightarrow \mathbb{R}$ to the equation (3.1) with $\phi$ replaced by $\phi_{n}$. Define a $H$-valued function by

$$
\tilde{\psi}(x, y):=\sum_{n \in \mathbb{N}} \psi_{n}(x, y) e_{n}=\int_{0}^{\infty} \mathbb{E}\left[\tilde{\phi}\left(x, Y_{t}^{x}(y)\right)\right] \mathrm{d} t
$$

Then $\tilde{\psi}$ solves

$$
\mathcal{L}_{2}(x, y) \tilde{\psi}(x, y)=-\tilde{\phi}(x, y) .
$$

### 3.1. Properties of the frozen transition semigroup. Given $\phi: H_{1} \times H_{2} \rightarrow \mathbb{R}$,

 let$$
T_{t} \phi(x, y):=\mathbb{E}\left[\phi\left(x, Y_{t}^{x}(y)\right)\right],
$$

In view of (3.3), we need to study the behavior of $T_{t} \phi$ as well as its first and second order derivatives with respect to the $y$ variable both near $t=0$ and as $t \rightarrow \infty$. Let us first collect the following estimates for $Y_{t}^{x}(y)$.

Lemma 3.4. Assume (A1) and (A2) hold, and that $G \in C_{b}^{0, \eta}\left(H_{1} \times H_{2}, H_{2}\right)$. Then there exists a unique mild solution $Y_{t}^{x}(y)$ to the equation (1.4). Moreover, we have:
(i) For any $t \geqslant 0$ and $q \geqslant 1$, there exist constants $C_{q}, \lambda>0$ such that

$$
\begin{equation*}
\mathbb{E}\left\|Y_{t}^{x}(y)\right\|_{2}^{q} \leqslant C_{q}\left(1+e^{-\lambda t}\|y\|_{2}^{q}\right) ; \tag{3.4}
\end{equation*}
$$

(ii) $Y_{t}^{x}(y)$ is strong Feller and irreducible;
(iii) There exist constants $C_{0}, \lambda>0$ such that for any $t \geqslant 0$ and every $\phi \in L_{p}^{\infty}\left(H_{1} \times\right.$ $H_{2}$ ),

$$
\begin{equation*}
\left|T_{t} \phi(x, y)-\int_{H_{2}} \phi(x, z) \mu^{x}(\mathrm{~d} z)\right| \leqslant C_{0}\|\phi\|_{L_{p}^{\infty}}\left(1+\|x\|_{1}+\|y\|_{2}^{p}\right) e^{-\lambda t} . \tag{3.5}
\end{equation*}
$$

Proof. The existence and uniqueness of solutions to SPDE (1.4) with Hölder continuous coefficients follows from [16, Theorem 7]. We only need to verify that the assumptions 4, 5, 6 in [16] hold. To this end, let

$$
Q_{t}:=\int_{0}^{t} e^{s B} Q_{2} e^{s B^{*}} \mathrm{~d} s \quad \text { and } \quad \Lambda_{t}=Q_{t}^{-1 / 2} e^{t B}
$$

Then under the assumption (A2) we have

$$
\operatorname{Tr}\left(Q_{t}\right)=\sum_{n \in \mathbb{N}} \frac{\lambda_{2, n}}{2 \beta_{n}}\left(1-e^{-2 \beta_{n} t}\right) \leqslant \sum_{n \in \mathbb{N}} \frac{\lambda_{2, n}}{2 \beta_{1}} \leqslant C_{0} \operatorname{Tr}\left(Q_{2}\right)<+\infty .
$$

Note that

$$
\left\|\Lambda_{t}\right\|_{\mathscr{L}\left(H_{2}\right)}^{2}=\sup _{n \in \mathbb{N}} \frac{2 \beta_{n}}{\lambda_{2, n}\left(e^{2 \beta_{n} t}-1\right)}
$$

Thus, we have

$$
\int_{0}^{T}\left\|\Lambda_{t}\right\|_{\mathscr{L}\left(H_{2}\right)}^{1+\theta} \mathrm{d} t<\infty, \quad \text { for some } \theta \geqslant \max (\eta, 1-\eta)
$$

which implies the desired result. Meanwhile, estimate (3.4) can be proved by following the same argument as in [8, Theorem 7.3], and the conclusions in (ii) follow by [14, Theorem 4 and Proposition 4]. Furthermore, for any $t \in[0, T]$ one can check that there exists a $\theta>0$ such that

Thus, estimate (3.5) follows by [23, Theorem 2.5].

By the assumption that $G \in C_{b}^{2,0}\left(H_{1} \times H_{2}\right)$ and (3.23), we get

& +2\left|D_{y} D_{x} \psi(x, y) \cdot\left(h_{2}, D_{x} G(x, y) \cdot h_{1}\right)\right| \\
& +\left|\left\langle D_{x}^{2} G(x, y) \cdot\left(h_{1}, h_{2}\right), D_{y} \psi(x, y)\right\rangle_{2}\right| \\
\leqslant & C_{6}\left(1+\|x\|_{1}+\|y\|_{2}^{p}\right)\left\|h_{1}\right\|_{1}\left\|h_{2}\right\|_{1} .
\end{aligned}
$$

Furthermore, by using [40, Lemma 3.2] again and the same approximation argument as in Step 2, we have that $\phi_{h_{1}, h_{2}}(x, y)$ satisfies the centering condition

& \leqslant C_{7}\left(1+\|x\|_{1}+\|y\|_{2}^{p}\right)\left\|h_{1}\right\|_{1}\left\|h_{2}\right\|_{1} .
\end{aligned}
$$

The proof is finished.
Given a function $F(x, y)$, recall that $\bar{F}$ is defined by (1.3). Usually, it is not so easy to study the regularity of the averaged function, which contains a separate problem connected with the smoothness of the invariant measure $\mu^{x}(\mathrm{~d} y)$. Here, we provide a simple method by using Theorem 3.2.

Lemma 3.7. Assume that $F \in C_{p}^{1, \eta}\left(H_{1} \times H_{2}\right)$ with $\eta>0$, and let $\Psi(x, y)$ solve the Poisson equation (2.6). Then for any $h_{1} \in H_{1}$, we have

Furthermore, assume that $F \in C_{p}^{2, \eta}\left(H_{1} \times H_{2}\right)$, then we have for any $h_{1}, h_{2} \in H_{1}$,

& \left.+\left\langle D_{x}^{2} G(x, y) \cdot\left(h_{1}, h_{2}\right), D_{y} \Psi(x, y)\right\rangle_{2}\right] \mu^{x}(\mathrm{~d} y) \tag{3.27}
\end{align*}
$$

In particular, we have

\left\|D_{x} \bar{F}(x) \cdot h_{1}\right\|_{1} \leqslant C_{0}\left\|h_{1}\right\|_{1}, \quad\left\|D_{x}^{2} \bar{F}(x) \cdot\left(h_{1}, h_{2}\right)\right\|_{1} \leqslant C_{0}\left\|h_{1}\right\|_{1}\left\|h_{2}\right\|_{1}, \tag{3.28}
\end{equation*}
$$

where $C_{0}>0$ is a constant.
Remark 3.8. The interesting point in formula (3.26) (and also in (3.27)) lies in that the regularity of the averaged function $\bar{F}$ with respect to the $x$-variable is transferred to the regularity of the solution $\Psi$ with respect to the $y$-variable. Since $\Psi$ is the solution to the corresponding Poisson equation, we can get the required regularity for free by the uniform ellipticity property of the generator $\mathcal{L}_{2}(x, y)$ as been proven in Theorem 3.2.

Proof. Recall that

\end{gathered}
$$

which in turn yields (3.27). Finally, due to the fact that for any $p \geqslant 1$,

we get estimate (3.28).

## 4. Strong convergence in the averaging principle

4.1. Galerkin approximation. Itô's formula will be used frequently below in the proof of the main result. However, due to the presence of unbounded operators in the equation, we can not apply Itô's formula for SPDE (1.1) directly. For this reason, we introduce the following Galerkin approximation scheme.

For $n \in \mathbb{N}$, let $H_{1}^{n}:=\operatorname{span}\left\{e_{1, k} ; 1 \leqslant k \leqslant n\right\}$ and denote the orthogonal projection of $H_{1}$ onto $H_{1}^{n}$ by $P_{1}^{n}$. Recall that $G_{n}(x, y)$ is defined by (3.20), and for $(x, y) \in H_{1}^{n} \times H_{2}^{n}$, define $F_{n}(x, y):=P_{1}^{n} F(x, y)$. We reduce the infinite dimensional system (1.1) to the following finite dimensional system in $H_{1}^{n} \times H_{2}^{n}$ :

\mathrm{d} X_{t}^{n, \varepsilon}=A X_{t}^{n, \varepsilon} \mathrm{~d} t+F_{n}\left(X_{t}^{n, \varepsilon}, Y_{t}^{n, \varepsilon}\right) \mathrm{d} t+P_{1}^{n} \mathrm{~d} W_{t}^{1}  \tag{4.1}\\
\mathrm{~d} Y_{t}^{n, \varepsilon}=\varepsilon^{-1} B Y_{t}^{n, \varepsilon} \mathrm{~d} t+\varepsilon^{-1} G_{n}\left(X_{t}^{n, \varepsilon}, Y_{t}^{n, \varepsilon}\right) \mathrm{d} t+\varepsilon^{-1 / 2} P_{2}^{n} \mathrm{~d} W_{t}^{2}
\end{array}\right.
$$

with initial values $X_{0}^{n, \varepsilon}=x^{n}:=P_{1}^{n} x \in H_{1}^{n}$ and $Y_{0}^{n, \varepsilon}=y^{n}:=P_{2}^{n} y \in H_{2}^{n}$. It is easy to check that $F_{n}$ and $G_{n}$ satisfy the same conditions as $F$ and $G$ with bounds which are uniform with respect to $n$. Thus the equation (4.1) is well-posed in $H_{1}^{n} \times H_{2}^{n}$. The corresponding averaged equation for system (4.1) can be formulated as

where $\bar{F}_{n}(x)$ is defined by

\bar{F}_{n}(x):=\int_{H_{2}^{n}} F_{n}(x, y) \mu_{n}^{x}(\mathrm{~d} y) \tag{4.3}
\end{equation*}
$$

Note that $\bar{X}_{t}^{n}$ is not the Galerkin approximation of $\bar{X}_{t}$.
The following result states the convergence of the finite dimensional system (4.1) to the initial equation (1.1).

Lemma 4.1. Let $T>0, x \in \mathcal{D}\left((-A)^{\theta}\right)$ and $y \in \mathcal{D}\left((-B)^{\theta}\right)$ with $\theta \in[0,1]$. Then for every $q \geqslant 1$ and $\gamma \in[0, \theta]$, we have for every $t \in[0, T]$,

& \left.+\mathbb{E}\left\|(-A)^{\gamma}\left(\bar{X}_{t}-\bar{X}_{t}^{n}\right)\right\|_{1}^{q}\right)=0 . \tag{4.4}
\end{align*}
$$

Proof. When $\theta=0$ (and thus $\gamma=0$ ), (4.4) was proven in [4, Lemma 4.2]. For general $\gamma \in(0, \theta]$, by Lemma 6.4 we know that $X_{t}^{\varepsilon} \in \mathcal{D}\left((-A)^{\gamma}\right)$. As a result, we have

Furthermore, by Lemma 6.5 we deduce that

& +\mathbb{E}\left\|\int_{0}^{t}(-A)^{\gamma} e^{(t-s) A}\left(I-P_{1}^{n}\right) \mathrm{d} W_{s}\right\|_{1}^{q} \\
& +\mathbb{E}\left(\int_{0}^{t}\left\|(-A)^{\gamma} e^{(t-s) A}\left[\bar{F}_{n}\left(\bar{X}_{s}\right)-\bar{F}_{n}\left(\bar{X}_{s}^{n}\right)\right]\right\|_{1} \mathrm{~d} s\right)^{q} .
\end{aligned}
$$

Since $\left\|\bar{F}_{n}-\bar{F}\right\|_{1} \rightarrow 0$ as $n \rightarrow \infty$ (see e.g. [4, (4.4)]), the first two terms go to 0 as $n \rightarrow \infty$ by the dominated convergence theorem. For the last term, we have

& \leqslant \lim _{n \rightarrow \infty} C_{1} \mathbb{E}\left(\int_{0}^{t}(t-s)^{-\gamma}\left\|\bar{X}_{s}-\bar{X}_{s}^{n}\right\|_{1} \mathrm{~d} s\right)^{q}=0
\end{aligned}
$$

which in turn yields the desired result.
4.2. Proof of Theorem 2.2. Let $T>0, x \in \mathcal{D}\left((-A)^{\theta}\right)$ and $y \in \mathcal{D}\left((-B)^{\theta}\right)$ with $\theta \in[0,1]$. Note that for any $t \in[0, T], q \geqslant 1$ and $\gamma \in[0, \theta \wedge 1 / 2)$, we have

\end{aligned}

By Lemma 4.1, the first and the last terms on the right-hand side of the above inequality converge to 0 as $n \rightarrow \infty$. Therefore, in order to prove Theorem 2.2, we only need to show that

where $C_{T}>0$ is a constant independent of $n$. In the following subsection, we shall only work with the approximation system (4.1), and prove bounds that are uniform with respect to the dimension. But in order to simplify the notations, we omit the index $n$. In particular, for $i=1,2$, the spaces $H_{i}^{n}$ are denoted by $H_{i}$.

Define

We first establish the following strong fluctuation estimate for an appropriate integral functional of $\left(X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right)$ over the time interval $[s, t]$, which will play an important role in proving (4.5).
Lemma 4.2 (Strong fluctuation estimate). Let $T, \theta>0, x \in \mathcal{D}\left((-A)^{\theta}\right)$ and $y \in$ $\mathcal{D}\left((-B)^{\theta}\right)$. Assume that (A1) and (A2) hold, $F \in C_{p}^{2, \eta}\left(H_{1} \times H_{2}, H_{1}\right)$ and $G \in$ $C_{b}^{2, \eta}\left(H_{1} \times H_{2}, H_{2}\right)$ with $\eta>0$. Then for any $\gamma \in[0, \theta \wedge 1 / 2), q \geqslant 1,0 \leqslant s \leqslant t \leqslant T$ and $\tilde{\phi} \in C_{p}^{2, \eta}\left(H_{1} \times H_{2}, H_{1}\right)$ satisfying (3.2), we have

where $C_{q, \gamma, T}>0$ is a constant.

According to Theorem 3.2, we know that $\tilde{\psi} \in C_{p}^{2,0}\left(H_{1} \times H_{2}, H_{1}\right) \cap \mathbb{C}_{p}^{0,2}\left(H_{1} \times H_{2}, H_{1}\right)$. Applying Itô's formula to $\tilde{\psi}_{t, \gamma}\left(t, X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right)$ we get

& +\frac{1}{\varepsilon} \int_{s}^{t} \mathcal{L}_{2} \tilde{\psi}_{t, \gamma}\left(r, X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right) \mathrm{d} r+M_{t, s}^{1}+\frac{1}{\sqrt{\varepsilon}} M_{t, s}^{2} \tag{4.10}
\end{align*}
$$

where $M_{t, s}^{1}$ and $M_{t, s}^{2}$ are defined by

\end{aligned}
$$

+\varepsilon \int_{s}^{t}\left(\partial_{r}+\mathcal{L}_{1}\right) \tilde{\psi}_{t, \gamma}\left(r, X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right) \mathrm{d} r+\varepsilon M_{t, s}^{1}+\sqrt{\varepsilon} M_{t, s}^{2}
$$

Note that

\int_{s}^{t} \partial_{r} \tilde{\psi}_{t, \gamma}\left(r, X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right) \mathrm{d} r= & \int_{s}^{t} \partial_{r} \tilde{\psi}_{t, \gamma}\left(r, X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right) \mathrm{d} r \\
& +\int_{s}^{t} \partial_{r}\left[\tilde{\psi}_{t, \gamma}\left(r, X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right)-\tilde{\psi}_{t, \gamma}\left(r, X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right)\right] \mathrm{d} r \\
= & \tilde{\psi}_{t, \gamma}\left(t, X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right)-\tilde{\psi}_{t, \gamma}\left(s, X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right) \\
& +\int_{s}^{t} \partial_{r}\left[\tilde{\psi}_{t, \gamma}\left(r, X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right)-\tilde{\psi}_{t, \gamma}\left(r, X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right)\right] \mathrm{d} r
\end{aligned}
$$

and that

& +\varepsilon \int_{s}^{t} \mathcal{L}_{1} \tilde{\psi}_{t, \gamma}\left(r, X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right) \mathrm{d} r+\varepsilon M_{t, s}^{1}+\sqrt{\varepsilon} M_{t, s}^{2} .
\end{aligned}
$$

Thus for any $0 \leqslant s \leqslant t \leqslant T$ and $q \geqslant 1$, we deduce that

& +\varepsilon^{q} \mathbb{E}\left\|\int_{s}^{t}(-A)^{1+\gamma} e^{(t-r) A}\left(\tilde{\psi}\left(X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right)-\tilde{\psi}\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right)\right) \mathrm{d} r\right\|_{1}^{q} \\
& \left.+\varepsilon^{q} \mathbb{E}\left\|\int_{s}^{t} \mathcal{L}_{1} \tilde{\psi}_{t, \gamma}\left(r, X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right) \mathrm{d} r\right\|_{1}^{q}+\varepsilon^{q} \mathbb{E}\left\|M_{t, s}^{1}\right\|_{1}^{q}+\varepsilon^{q / 2} \mathbb{E}\left\|M_{t, s}^{2}\right\|_{1}^{q}\right) \\

\leqslant C_{1}(t-s)^{(\theta-\gamma) q} \varepsilon^{(1-\theta) q} \leqslant C_{1}(t-s)^{(\theta-\gamma) q} \varepsilon^{q / 2}
\end{gathered}

Similarly, by Minkowski's inequality we also have

& \leqslant C_{4} \varepsilon^{q}\left(\int_{s}^{t}\left(1+\mathbb{E}\left\|X_{r}^{\varepsilon}\right\|_{1}^{2}+\mathbb{E}\left\|Y_{r}^{\varepsilon}\right\|_{2}^{2 p}\right)\left\|(-A)^{\gamma} e^{(t-r) A} Q_{1}^{1 / 2}\right\|_{\mathscr{L}_{2}\left(H_{1}\right)}^{2} \mathrm{~d} r\right)^{q / 2} \\
& \leqslant C_{4}(t-s)^{(1 / 2-\gamma) q} \varepsilon^{q} \leqslant C_{4}(t-s)^{(\theta-\gamma) q} \varepsilon^{q},
\end{aligned}

= & \mathscr{I}_{1}(t, \varepsilon)+\mathscr{I}_{2}(t, \varepsilon) .

By Lemma 3.7 and Minkowski's inequality, we deduce that

## 5. Normal deviations

5.1. Kolmogorov equation. Recall that $\bar{X}_{t}$ and $\bar{Z}_{t}$ satisfy the equations (1.2) and (2.8), respectively. We write a system of equations for the process $\left(\bar{X}_{t}, \bar{Z}_{t}\right)$ as follows:

\end{array}\right.

Note that the processes $\bar{X}_{t}$ and $\bar{Z}_{t}$ depend on the initial value $x$. Below, we shall write $\bar{X}_{t}(x)$ when we want to stress its dependence on the initial value, and use $\bar{Z}_{t}(x, z)$ to denote the process $\bar{Z}_{t}$ with initial point $\bar{Z}_{0}=z \in H_{1}$. Let $\overline{\mathcal{L}}$ be the formal infinitesimal generator of the Markov process $\left(\bar{X}_{t}, \bar{Z}_{t}\right)$, i.e.,

where $C_{i}, i=1, \cdots, 5$, are positive constants.
Remark 5.2. The estimates in (i)-(iii) have been studied in [6, Proposition 7.1] when the diffusion coefficient is a constant and in [5, Theorem 4.2, Theorem 4.3 and Proposition 4.5] for general nonlinear diffusion coefficients. However, the index $\beta$ in (5.5), (5.7) and (5.9), $\beta_{1}, \beta_{2}, \beta_{3}$ in (5.6) and (5.8) are restricted to $[0,1$ ), which is not sufficient for us to use below. The key observation here is that the equation (2.8) satisfied by $\bar{Z}_{t}$ is a linear one, and we do not involve estimates for $D_{x} \bar{u}$ and $D_{x}^{2} \bar{u}$. Thus some new techniques are needed in the proof of Theorem 2.4 to avoid using these estimates.

Proof. (i)-(iii). By using the same argument as in [15, Theorem 13], we can prove that $\bar{u}$ defined by (5.4) is a solution to the equation (5.3). Moreover, $\bar{u}$ has bounded Gatêaux derivatives with respect to the $x$-variable up to order 2 and with respect to the $z$-variable up to order 4 , see also [ 6, Section 7] and [5, Section 4]. Furthermore, in view of (5.4) we deduce that for any $\beta \in[0,1]$,

& +D_{z}^{2} \bar{u}(t, x, z) \cdot\left(A z+D_{x} \bar{F}(x) \cdot z, h\right) \\
& +\frac{1}{2} \sum_{n=1}^{\infty} D_{z}^{3} \bar{u}(t, x, z) \cdot\left(\sigma(x) e_{1, n}, \sigma(x) e_{1, n}, h\right), \tag{5.16}
\end{align*}
$$

which together with (5.5) and (5.6) yields that

& +\left(e^{(t-s) A}-I\right) \frac{1}{\sqrt{\varepsilon}} \int_{0}^{s} e^{(s-r) A} \delta F\left(X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right) \mathrm{d} r=: \sum_{i=1}^{4} \mathscr{Z}_{i}(t, s) .

& +C_{1} \int_{0}^{t}\left(\mathbb{E}\left\|\bar{X}_{s}-\bar{X}_{s}^{n}\right\|_{1}^{2}+\left\|D_{x} \bar{F}-D_{x} \bar{F}_{n}\right\|_{\mathscr{L}\left(H_{1}\right)}^{2}\right) \mathrm{d} s+C_{1} \int_{0}^{t} \mathbb{E}\left\|\bar{Z}_{s}-\bar{Z}_{s}^{n}\right\|_{1}^{2} \mathrm{~d} s .

The following weak fluctuation estimates for an integral functional of process ( $X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}, \bar{X}_{t}, Z_{t}^{\varepsilon}$ ) will play an important role in proving (5.23). Compared with Lemma 4.2, extra efforts are needed to control the time singularity in the integral.

& +\left[\mathbb{E}\left(\frac{1}{\sqrt{\varepsilon}} \int_{0}^{T}\left\langle\delta F\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right), D_{z} \tilde{u}\left(t, \bar{X}_{t}, Z_{t}^{\varepsilon}\right)\right)\right\rangle_{1} \mathrm{~d} t\right) \\
& \left.-\frac{1}{2} \mathbb{E}\left(\int_{0}^{T} \operatorname{Tr}\left(D_{z}^{2} \tilde{u}\left(t, \bar{X}_{t}, Z_{t}^{\varepsilon}\right) \sigma\left(X_{t}^{\varepsilon}\right) \sigma^{*}\left(X_{t}^{\varepsilon}\right)\right) \mathrm{d} t\right)\right]=: \sum_{i=1}^{3} \mathscr{N}_{i}(T, \varepsilon) .
\end{aligned}
$$

By the mean value theorem, Hölder's inequality, (5.5), (5.19) and Theorem 2.2, we deduce that for some $\vartheta \in(0,1)$,

\left.\left.\left.-D_{x} \bar{F}\left(\bar{X}_{t}\right)\right] \cdot Z_{t}^{\varepsilon}, D_{z} \tilde{u}\left(t, \bar{X}_{t}, Z_{t}^{\varepsilon}\right)\right\rangle_{1} \mid \mathrm{d} t\right) \\
\leqslant C_{1} \int_{0}^{T}\left(\mathbb{E}\left\|X_{t}^{\varepsilon}-\bar{X}_{t}\right\|_{1}^{2}\right)^{1 / 2}\left(\mathbb{E}\left\|Z_{t}^{\varepsilon}\right\|_{1}^{2}\right)^{1 / 2} \mathrm{~d} t \leqslant C_{1} \varepsilon^{1 / 2} .
\end{array}
$$

Furthermore, let $\mathscr{U}_{t, \bar{x}, z}(x):=\operatorname{Tr}\left(D_{z}^{2} \tilde{u}(t, \bar{x}, z) \sigma(x) \sigma^{*}(x)\right)$. Then we have that for every $h \in H_{1}$,

It remains to control the last term $\mathscr{N}_{3}(T, \varepsilon)$. For this purpose, recall that $\Psi$ solves the Poisson equation (2.6), and define

It is obvious that $\phi$ satisfies the centering condition (5.25). Furthermore, in view of (5.6), (5.10), (5.11) and (5.12), we have that for any $t \in[0, T), x, z \in H_{1}, y \in H_{2}$, $\bar{x} \in \mathcal{D}(-A)$ and $h_{1}, h_{2} \in H_{1}$,

& \leqslant\left|\left\langle\delta F(x, y), \partial_{t} D_{z} \bar{u}(T-t, \bar{x}, z)\right\rangle_{1}\right|+\left|\left\langle D_{x} \delta F(x, y) \cdot h_{1}, \partial_{t} D_{z} \bar{u}(T-t, \bar{x}, z)\right\rangle_{1}\right| \\
& \quad+\left|\partial_{t} D_{z}^{2} \bar{u}(T-t, \bar{x}, z) \cdot\left(\delta F(x, y), h_{2}\right)\right| \\
& \leqslant C_{3}(T-t)^{-1}\left(\left\|h_{1}\right\|_{1}+\left\|h_{2}\right\|_{1}\right)\left(1+\|A \bar{x}\|_{1}+\|\bar{x}\|_{1}^{2}+\|z\|_{1}\right)\left(1+\|x\|_{1}+\|y\|_{2}^{p}\right)
\end{aligned}
$$

and for any $h_{3} \in \mathcal{D}(-A)$,

\begin{aligned}
& \left|D_{\bar{x}} \partial_{t} \phi(t, x, y, \bar{x}, z) \cdot h_{3}\right|=\partial_{t} D_{\bar{x}} D_{z} \bar{u}(T-t, \bar{x}, z) \cdot\left(\delta F(x, y), h_{3}\right) \\
& \leqslant C_{3}\left((T-t)^{-1}\left(1+\|A \bar{x}\|_{1}+\|\bar{x}\|_{1}^{2}+\|z\|_{1}\right)\left\|h_{3}\right\|_{1}+\left\|A h_{3}\right\|_{1}\right) \\
& \quad \times\left(1+\|x\|_{1}+\|y\|_{2}^{p}\right),
\end{aligned}
$$

and for any $h \in \mathcal{D}\left((-A)^{\vartheta}\right)$ with $\vartheta \in[0,1]$,

\begin{aligned}
\left|D_{z} \phi(t, x, y, \bar{x}, z) \cdot(-A)^{\vartheta} h\right| & =D_{z}^{2} \bar{u}(T-t, \bar{x}, z) \cdot\left(\delta F(x, y),(-A)^{\vartheta} h\right) \\
& \leqslant C_{3}(T-t)^{-\vartheta}\left(1+\|x\|_{1}+\|y\|_{2}^{p}\right)\|h\|_{1}
\end{aligned}
$$

Furthermore, by the definition of $\sigma$ in (2.9), we have

& =\int_{H_{2}} D_{z}^{2} \tilde{u}(t, \bar{x}, z) \cdot(\Psi(x, y), \delta F(x, y)) \mu^{x}(\mathrm{~d} y) \\
& =\frac{1}{2} \operatorname{Tr}\left(D_{z}^{2} \tilde{u}(t, \bar{x}, z) \sigma(x) \sigma^{*}(x)\right) .
\end{aligned}

Thus, it follows by (5.31) directly that for any $\gamma \in(0,1 / 2)$,

## 6. Appendix

Throughout this section, we assume that (A1) and (A2) hold, $F \in C_{p}^{1, \eta}\left(H_{1} \times\right.$ $\left.H_{2}, H_{1}\right)$ and $G \in C_{b}^{1, \eta}\left(H_{1} \times H_{2}, H_{2}\right)$ with $\eta>0$. We have the following result.

Lemma 6.1. For any $(x, y) \in H_{1} \times H_{2}$, there exists a unique mild solution for the equation (1.1), i.e., for every $t \geqslant 0$,

Y_{t}^{\varepsilon}=e^{\frac{t}{\varepsilon} B} y+\varepsilon^{-1} \int_{0}^{t} e^{\frac{t-s}{\varepsilon} B} G\left(X_{s}^{\varepsilon}, Y_{s}^{\varepsilon}\right) \mathrm{d} s+\varepsilon^{-1 / 2} \int_{0}^{t} e^{\frac{t-s}{\varepsilon} B} \mathrm{~d} W_{s}^{2}
\end{array}\right.
$$

Moreover, for any $T>0, q \geqslant 1$ and $x \in \mathcal{D}\left((-A)^{\theta}\right)$ with $\theta \in[0,1)$, we have

\sup _{\varepsilon \in(0,1)} \sup _{t \in[0, T]} \mathbb{E}\left\|(-A)^{\theta} X_{t}^{\varepsilon}\right\|_{1}^{q} \leqslant C_{\theta, q, T}\left(1+\|x\|_{(-A)^{\theta}}^{q}+\|y\|_{2}^{p q}\right) \tag{6.2}
\end{equation*}

and

\sup _{\varepsilon \in(0,1)} \sup _{t \in[0, T]} \mathbb{E}\left\|Y_{t}^{\varepsilon}\right\|_{2}^{q} \leqslant C_{q, T}\left(1+\|y\|_{2}^{q}\right), \tag{6.3}
\end{equation*}
$$

where $C_{\theta, q, T}, C_{q, T}>0$ are constants.
Proof. The well-posedness of SPDE (1.1) with Hölder continuous coefficients follows from [16, Theorem 7]. Furthermore, estimate (6.2) can be proved similarly as in [6, Proposition 2.10] or [9, Proposition 4.3], and estimate (6.3) can be proved as in [9, Proposition 4.2]. We omit the details here.

Note that estimate (6.2) holds only for $\theta<1$. In order to get the estimate for $\theta=1$, we need some extra regularity results for $X_{t}^{\varepsilon}$ and $Y_{t}^{\varepsilon}$ with respect to the time variable. The following two results extend [9, Proposition 4.4] and [4, Proposition A.4], respectively.

Lemma 6.2. Let $T>0, \gamma \in[0,1], x \in \mathcal{D}\left((-A)^{\theta}\right)$ with $\theta \in[0, \gamma]$ and $y \in H_{2}$. Then for every $q \geqslant 1$ and $0<s \leqslant t \leqslant T$, we have

where $C_{\theta, \gamma, q, T}>0$ is a constant.
Proof. In view of (6.1), we have

& +\int_{0}^{s}\left(e^{(t-r) A}-e^{(s-r) A}\right) \mathrm{d} W_{r}^{1}=: \sum_{i=1}^{5} \mathscr{X}_{i}(t, s) \tag{6.4}
\end{align*}
$$

Below, we estimate each term on the right hand side of (6.4) separately. For the first term, by Proposition 2.1 (iii) we easily get

& \leqslant C_{2}(t-s)^{q}\left(1+\|x\|_{1}^{q}+\|y\|_{2}^{p q}\right)
\end{aligned}
$$

Similarly, using Proposition 2.1 (ii), Lemma 6.1 and Minkowski's inequality again, we have

& \leqslant C_{3}(t-s)^{q / 2}\left(\int_{0}^{s}\left(\mathbb{E}\left\|(-A)^{1 / 2} e^{(s-r) A} F\left(X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right)\right\|_{1}^{q}\right)^{1 / q} \mathrm{~d} r\right)^{q} \\
& \leqslant C_{3}(t-s)^{q / 2}\left(1+\|x\|_{1}^{q}+\|y\|_{2}^{p q}\right)
\end{aligned}
$$

Using Burkholder-Davis-Gundy's inequality and the assumption (A2), we further get

\mathbb{E}\left\|\mathscr{X}_{5}(t, s)\right\|_{1}^{q} & \leqslant C_{5}(t-s)^{q / 2}\left(\int_{0}^{s}\left\|(-A)^{1 / 2} e^{(s-r) A} Q_{1}^{1 / 2}\right\|_{\mathscr{L}_{2}\left(H_{1}\right)}^{2} \mathrm{~d} r\right)^{q / 2} \\
& \leqslant C_{5}(t-s)^{q / 2}
\end{aligned}
$$

Combining the above computations, we get the desired result.
Lemma 6.3. Let $T>0, \gamma \in[0,1 / 2], x \in H_{1}$ and $y \in \mathcal{D}\left((-B)^{\theta}\right)$ with $\theta \in[0, \gamma]$.
Then for every $q \geqslant 1$ and $0<s \leqslant t \leqslant T$, we have

& +\frac{1}{\sqrt{\varepsilon}} \int_{0}^{s}\left(e^{\frac{(t-r)}{\varepsilon} B}-e^{\frac{(s-r)}{\varepsilon} B}\right) \mathrm{d} W_{r}^{2}=: \sum_{i=1}^{5} \mathscr{Y}_{i}(t, s)
\end{aligned}
$$

In exactly the same way as in the proof of Lemma 6.2, we deduce that

$$

and

\begin{aligned}
\mathbb{E}\left\|\mathscr{Y}_{3}(t, s)\right\|_{1}^{q} & \leqslant\left(\frac{1}{\varepsilon} \int_{0}^{s}\left(\mathbb{E}\left\|\left(e^{\left.\frac{(t-s)}{\varepsilon} B\right)}-I\right) e^{\frac{(s-r)}{\varepsilon} B} G\left(X_{r}^{\varepsilon}, Y_{r}^{\varepsilon}\right)\right\|_{2}^{q}\right)^{1 / q} \mathrm{~d} r\right)^{q} \\
& \leqslant C_{3} \frac{(t-s)^{\gamma q}}{\varepsilon^{\gamma q}}\left(\int_{0}^{s / \varepsilon}\left\|(-B)^{\gamma} e^{r B}\right\|_{\mathscr{L}\left(H_{2}\right)} \mathrm{d} r\right)^{q}
\end{aligned}
$$

$$
\leqslant C_{3} \frac{(t-s)^{\gamma q}}{\varepsilon^{\gamma q}}\left(\int_{0}^{s / \varepsilon} r^{-\gamma} e^{\frac{-\mu_{1}}{2} r} \mathrm{~d} r\right)^{q} \leqslant C_{3} \frac{(t-s)^{\gamma q}}{\varepsilon^{\gamma q}}
$$

To control the last two terms, by Burkholder-Davis-Gundy's inequality and the assumption (A2), we deduce that for any $\gamma \in[0,1]$,

& \leqslant C_{4}\left(\sum_{n=1}^{\infty} \lambda_{2, n} \mu_{n}^{\gamma-1} \frac{(t-s)^{\gamma}}{\varepsilon^{\gamma}}\right)^{q / 2} \leqslant C_{4} \frac{(t-s)^{\frac{\gamma q}{2}}}{\varepsilon^{\frac{\gamma q}{2}}}
\end{aligned}
$$

and for $\gamma \in[0,1 / 2]$,

\begin{aligned}
\mathbb{E}\left\|\mathscr{Y}_{5}(t, s)\right\|_{1}^{q} & \leqslant C_{5} \frac{(t-s)^{\gamma q}}{\varepsilon^{\gamma q}}\left(\frac{1}{\varepsilon} \int_{0}^{s}\left\|(-B)^{\gamma} e^{\frac{(s-r)}{\varepsilon} B} Q_{2}^{1 / 2}\right\|_{\mathscr{L}_{2}\left(H_{2}\right)}^{2} \mathrm{~d} r\right)^{q / 2} \\
& \leqslant C_{5} \frac{(t-s)^{\gamma q}}{\varepsilon^{\gamma q}}\left(\sum_{n=1}^{\infty} \lambda_{2, n} \mu_{n}^{2 \gamma-1}\right)^{q / 2} \leqslant C_{5} \frac{(t-s)^{\gamma q}}{\varepsilon^{\gamma q}}
\end{aligned}
$$

Combining the above computations, we get the desired result.
Now we can prove the following moment estimate.
Lemma 6.4. Let $T>0, x \in \mathcal{D}\left((-A)^{\theta}\right)$ with $\theta \in[0,1]$ and $y \in H_{2}$. Then for any $q \geqslant 1, \gamma>0$ and $0 \leqslant t \leqslant T$, we have

By Proposition 2.1 (i), we easily see that

\left\|\mathscr{X}_{1}(t, \varepsilon)\right\|_{1} \leqslant C_{14} t^{(\theta-1)}\|x\|_{(-A)^{\theta}} .
$$

For the second term, note that

$$
\begin{aligned}
\int_{0}^{t} A e^{(t-s) A} F\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right) \mathrm{d} s & =\int_{0}^{t} \partial_{t} e^{(t-s) A} F\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right) \mathrm{d} s \\
& =-\left(e^{t A}-I\right) F\left(X_{t}^{\varepsilon}, Y_{t}^{\varepsilon}\right)
\end{aligned}
$$

hence we deduce that

$$
\mathbb{E}\left\|\mathscr{X}_{2}(t, \varepsilon)\right\|_{1}^{q} \leqslant C_{2}\left(1+\mathbb{E}\left\|X_{t}^{\varepsilon}\right\|_{1}^{q}+\mathbb{E}\left\|Y_{t}^{\varepsilon}\right\|_{2}^{p q}\right) \leqslant C_{2}\left(1+\|x\|_{1}^{q}+\|y\|_{2}^{p q}\right)
$$

Furthermore, by applying Lemmas 6.2 and 6.3 with $\theta=0$, we get that for any $\gamma \in(0,1 / 2]$,

$$
\begin{aligned}
\mathbb{E}\left\|\mathscr{X}_{3}(t, \varepsilon)\right\|_{1}^{q} \leqslant & C_{3}\left(1+\|x\|_{1}^{q}+\|y\|_{2}^{p q}\right)\left(\int _ { 0 } ^ { t } ( t - s ) ^ { - 1 } \left[\left(\mathbb{E}\left[\left\|X_{t}^{\varepsilon}-X_{s}^{\varepsilon}\right\|_{1}^{2 q}\right]\right)^{1 / 2 q}\right.\right. \\
& \left.\left.+\left(\mathbb{E}\left[\left\|Y_{t}^{\varepsilon}-Y_{s}^{\varepsilon}\right\|_{2}^{2 q q}\right]\right)^{1 / 2 q}\right] \mathrm{~d} s\right)^{q} \\
\leqslant & C_{3}\left(1+\|x\|_{1}^{2 q}+\|y\|_{2}^{2 p q}\right)\left(\int_{0}^{t}(t-s)^{\eta \gamma-1}\left(\frac{1}{s^{\eta \gamma}}+\frac{1}{\varepsilon^{\eta \gamma}}\right) \mathrm{d} s\right)^{q} \\
\leqslant & C_{3} \varepsilon^{-\gamma q}\left(1+\|x\|_{1}^{2 q}+\|y\|_{2}^{2 p q}\right)
\end{aligned}
$$

Finally, by Burkholder-Davis-Gundy's inequality and assumption (A2), we have

$$
\mathbb{E}\left\|\mathscr{X}_{4}(t, \varepsilon)\right\|_{1}^{q} \leqslant C_{4}\left(\int_{0}^{t}\left\|A e^{(t-s) A} Q_{1}^{1 / 2}\right\|_{\mathscr{L}_{2}\left(H_{1}\right)}^{2} \mathrm{~d} s\right)^{q / 2} \leqslant C_{4}
$$

The conclusion follows by the above estimates.
The following results for the averaged equation can be proved as in Lemmas 6.1, 6.2 and 6.4 , so we omit the details here.

Lemma 6.5. For $x \in H_{1}$, the averaged equation (1.2) has a unique mild solution, i.e., for all $t>0$,

$$
\begin{equation*}
\bar{X}_{t}=e^{t A} x+\int_{0}^{t} e^{(t-s) A} \bar{F}\left(\bar{X}_{s}\right) \mathrm{d} s+\int_{0}^{t} e^{(t-s) A} \mathrm{~d} W_{s}^{1} \tag{6.5}
\end{equation*}
$$

In addition, we have:
(i) For any $q \geqslant 1$ and $x \in \mathcal{D}(-A)^{\theta}$ with $\theta \in[0,1)$,

$$
\sup _{t \in[0, T]} \mathbb{E}\left\|(-A)^{\theta} \bar{X}_{t}\right\|_{1}^{q} \leqslant C_{\theta, q, T}\left(1+\|x\|_{(-A)^{\theta}}^{q}\right)
$$

(ii) For any $q \geqslant 1, \theta \in[0,1]$ and $0 \leqslant t \leqslant T$,

$$
\left(\mathbb{E}\left\|A \bar{X}_{t}\right\|_{1}^{q}\right)^{1 / q} \leqslant C_{\theta, q, T}\left(1+t^{\theta-1}\|x\|_{(-A)^{\theta}}\right)
$$

(iii) For any $q \geqslant 1, \gamma \in[0,1], x \in \mathcal{D}\left((-A)^{\theta}\right)$ with $\theta \in[0, \gamma]$ and $0<s \leqslant t \leqslant T$,

$$
\left(\mathbb{E}\left\|\bar{X}_{t}-\bar{X}_{s}\right\|_{1}^{q}\right)^{\frac{1}{q}} \leqslant C_{\theta, \gamma, q, T}\left(\frac{(t-s)^{\gamma}}{s^{\gamma-\theta}} e^{-\frac{\alpha_{1}}{2} s}\|x\|_{(-A)^{\theta}}+(t-s)^{\frac{1}{2}}\left(1+\|x\|_{1}\right)\right),
$$

where $C_{\theta, q, T}, C_{\theta, \gamma, q, T}>0$ are constants.
