# On Computing Stable Extensions of Abstract Argumentation Frameworks

#### Abstract

An abstract argumentation framework (AF for short) is a directed graph $(A, R)$ where $A$ is a set of abstract arguments and $R \subseteq A \times A$ is the attack relation. Let $H=(A, R)$ be an AF, $S \subseteq A$ be a set of arguments and $S^{+}=\{y \mid \exists x \in$ $S$ with $(x, y) \in R\}$. Then, $S$ is a stable extension in $H$ if and only if $S^{+}=A \backslash S$. In this paper, we present a thorough, formal validation of a known backtracking algorithm for listing all stable extensions in a given AF.


Keywords: directed graph, backtracking algorithm, stable argumentation

## 1. Introduction

An abstract argumentation framework (AF for short) is a directed graph $(A, R)$ where $A$ is a set of abstract arguments and $R \subseteq A \times A$ is the attack relation between them. Let $H=(A, R)$ be an AF, $S \subseteq A$ be a subset of arguments and $S^{+}=\{y \mid \exists x \in S$ with $(x, y) \in R\}$. Then, $S$ is a stable extension in $H$ if and only if $S^{+}=A \backslash S$.

Since introduced in [9], AFs have attracted a substantial body of research (see e.g. [1, 14, 2]). Stable extension enumeration is a fundamental computational problem within the context of AFs. Listing all stable extensions in an AF is an NP-hard problem, see for example the complexity results presented in [10, 11]. In the literature one can find different proposed methods for listing all stable extensions in a given AF, such as dynamic programming and reduction-based methods, see for example [6, 5] for a fuller review. However, this paper is centered around backtracking algorithms for listing stable extensions in an AF.

In related work, backtracking algorithms are often called labelling algorithms. The work of [7] proposed a backtracking algorithm that can be used for generating stable extensions of AFs. Later, the work of [16] enhanced the algorithm of [7] by a look-ahead mechanism. Most recently, the system of [13] implemented a backtracking algorithm that is similar to the essence of the algorithm of [16]; however, [13] made use of heuristics to examine their effects on the practical efficiency of listing stable extensions. All these works (i.e. [7, 16, 13) presented experimental backtracking algorithms.

Generally, there are several empirical studies on algorithmic methods in abstract argumentation research, see e.g. [18, 12, 3]. However, to the best of our knowledge, we do not find in the literature a comprehensive, formal demonstration of a backtracking algorithm for listing stable extensions in a given AF. Therefore, in the present paper we give a rigorous, formal validation of a backtracking algorithm (which is comparable to the core structure of the algorithm of [16]) for listing all stable extensions in an AF.

In section 2, we validate a first version of the algorithm, which is a formulation that naturally builds on the definition of stable extensions. In section 3 , we prove a second version of the algorithm, which is a development of the first version. As the first version of the algorithm subsumes (somewhat) high-level operations, the second version comes to specify how these operations are implemented efficiently. We believe that proving first the algorithm in a high-level form enables the reader to follow easily the validation of the implementation given in the second version. The second version is the ultimate construct that one needs to realize the algorithm in any prospective application. In section 4, we close the paper with some concluding remarks.

## 2. Validation of an algorithm for listing stable extensions

Let $H=(A, R)$ be an AF and $T \subseteq A$ be a subset of arguments. Then,

$$
\begin{aligned}
& T^{+} \stackrel{\text { def }}{=}\{y \mid \exists x \in T \text { with }(x, y) \in R\}, \\
& T^{-} \stackrel{\text { def }}{=}\{y \mid \exists x \in T \text { with }(y, x) \in R\} .
\end{aligned}
$$

For the purpose of enumerating all stable extensions in $H$, let $S$ denote an under-construction stable extension of $H$. Thus, we start with $S=\emptyset$ and then let $S$ grow to a stable extension (if any exists) incrementally by choosing arguments from $A$ to join $S$. For this, we denote by choice a set of arguments eligible to join $S$. More precisely, take $S \subseteq A$ such that $S \cap S^{+}=\emptyset$, then choice $\subseteq A \backslash\left(S \cup S^{-} \cup S^{+}\right)$. Additionally, we denote by tabu the arguments that do not belong to $S \cup S^{+} \cup$ choice. More specifically, take $S \subseteq A$ such that $S \cap S^{+}=\emptyset$, and choice $\subseteq A \backslash\left(S \cup S^{-} \cup S^{+}\right)$. Then, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$. The next example shows these structures in action.

Example 1. To list the stable extensions in the AF $H_{1}$ depicted in Figure 1, apply the following steps:

1. Initially, $S=\emptyset, S^{+}=\emptyset$, choice $=\{a, b, c, d, e, f\}$, and tabu $=\emptyset$.
2. Select an argument, say $a$, to join $S$. Then, $S=\{a\}, S^{+}=\{b\}$, choice $=$ $\{c, d\}$ and $t a b u=\{e, f\}$.
3. As $\{c, d\}^{-} \subseteq S^{+} \cup$ tabu, $\{c, d\}$ must join $S$. Otherwise, $S=\{a\}$ without $\{c, d\}$ will never expand to a stable extension since $c$ and $d$ never join $S^{+}$. Thus, $S=\{a, c, d\}, S^{+}=\{b, e, f\}$, choice $=\emptyset$ and tabu $=\emptyset$. As $S^{+}=A \backslash S, S$ is stable.

4. To find another stable extension, backtrack to the state of step 1 and then try to build a stable extension without $a$. Hence, $S=\emptyset, S^{+}=\emptyset$, choice $=\{b, c, d, e, f\}$ and tabu $=\{a\}$.
5. Select an argument, say $b$, to join $S$. Then, $S=\{b\}, S^{+}=\{c, d\}$, choice $=$ $\{e, f\}$ and $t a b u=\{a\}$.
6. As $\{e\}^{-} \subseteq S^{+}, e$ must join $S$. Otherwise, $S=\{b\}$ without $e$ will not grow to a stable extension since $e$ never joins $S^{+}$. Hence, $S=\{b, e\}$, $S^{+}=\{a, c, d, f\}$, choice $=\emptyset$ and $t a b u=\emptyset$. Since $S^{+}=A \backslash S, S$ is stable.
7. Backtrack to the state of step 4 and then attempt to build a stable extension excluding $b$. Thus, $S=\emptyset, S^{+}=\emptyset$, choice $=\{c, d, e, f\}$ and $t a b u=\{a, b\}$.
8. Since $\{d\}^{-} \subseteq t a b u$, $d$ must join $S$. Otherwise, $S=\emptyset$ without $d$ will never grow to a stable extension because $d$ never joins $S^{+}$. Subsequently, $S=\{d\}, S^{+}=\{b, e, f\}$, choice $=\{c\}$ and tabu $=\{a\}$.
9. As $\{a\}^{-} \subseteq S^{+}$and $a \in t a b u, a$ will never join $S^{+}$and so $S=\{d\}$ will never grow to a stable extension.
10. At this point, we confirm that there are no more stable extensions to find. This is because the state of step 7 , being analyzed in steps $8 \& 9$, an assertion is concluded that trying to build a stable extension from choice $=\{c, d, e, f\}$ (i.e. excluding tabu $=\{a, b\}$ ) will never be successful. Note, we already tried to build a stable extension including a (step 2), and later (step 5) we tried to construct a stable extension including $b$ but without $a$.

Our first proposition captures stable extensions when choice $=t a b u=\emptyset$.
Proposition 1. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$. Then, $S$ is a stable extension in $H$ if and only if choice $=\emptyset$ and tabu $=\emptyset$.

Proof. If tabu $=\emptyset$ and choice $=\emptyset$, then $\emptyset=A \backslash\left(S \cup S^{+} \cup \emptyset\right)$ because tabu $=$ $A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$. Thus, $S \cup S^{+}=A$. As $S \cap S^{+}=\emptyset$, then $S^{+}=A \backslash S$. On the other hand, if $S$ is stable, then $S^{+}=A \backslash S$ and so $S \cup S^{+}=A$. Thus, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)=A \backslash(A \cup$ choice $)=\emptyset$. Further, choice $=\emptyset$ since choice $\subseteq A \backslash\left(S \cup S^{+} \cup S^{-}\right)$and $S \cup S^{+}=A$.

Now, we present three propositions that are essential for efficiently listing stable extensions. These propositions are inspired by the excellent work of [8],
which presented a backtracking algorithm for solving a different computational problem in AFs.

Proposition 2. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup c h o i c e\right)$, and $x \in$ choice be an argument with $\{x\}^{-} \subseteq S^{+} \cup t a b u$. If there is a stable extension $T \supseteq S$ such that $T \backslash S \subseteq$ choice, then $x \in T$.

Proof. Suppose $x \notin T$. Then, $x \in T^{+}$because $T$ is stable. Thus,

$$
\begin{equation*}
\exists y \in\{x\}^{-} \text {such that } y \in T \tag{2.1}
\end{equation*}
$$

As $\{x\}^{-} \subseteq S^{+} \cup t a b u$,

$$
\begin{equation*}
\forall y \in\{x\}^{-} \text {it is the case that } y \in S^{+} \cup t a b u \tag{2.2}
\end{equation*}
$$

Hence, (2.1) together with (2.2) imply that

$$
\begin{equation*}
T \cap\left(S^{+} \cup t a b u\right) \neq \emptyset \tag{2.3}
\end{equation*}
$$

Observe, $T \subseteq S \cup$ choice since $T \supseteq S$ and $T \backslash S \subseteq$ choice. As $S \cap\left(S^{+} \cup t a b u\right)=\emptyset$ and choice $\cap\left(S^{+} \cup t a b u\right)=\emptyset$, it holds that

$$
\begin{equation*}
T \cap\left(S^{+} \cup t a b u\right)=\emptyset \tag{2.4}
\end{equation*}
$$

Note the contradiction between (2.3) and (2.4).
Proposition 3. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, and $x \in$ choice be an argument such that for some $y \in$ tabu it is the case that $\{y\}^{-} \cap$ choice $=\{x\}$. If there is a stable extension $T \supseteq S$ such that $T \backslash S \subseteq$ choice, then $x \in T$.

Proof. Suppose $x \notin T$. As $x \in$ choice,

$$
\begin{equation*}
T \backslash S \subseteq \text { choice } \backslash\{x\} \tag{3.1}
\end{equation*}
$$

As $T \supseteq S$ and $T \backslash S \subseteq$ choice, it is the case that $T \subseteq S \cup$ choice. Because tabu $\cap(S \cup$ choice $)=\emptyset$, it holds that

$$
\begin{equation*}
T \cap t a b u=\emptyset \tag{3.2}
\end{equation*}
$$

Referring to the premise of this proposition, as $y \in t a b u, y \notin T$. Subsequently, $y \in T^{+}$since $T$ is stable. Thus,

$$
\begin{equation*}
\{y\}^{-} \cap T \neq \emptyset \tag{3.3}
\end{equation*}
$$

Since $y \in t a b u$ and $t a b u \cap S^{+}=\emptyset, y \notin S^{+}$. Thus,

$$
\begin{equation*}
\{y\}^{-} \cap S=\emptyset \tag{3.4}
\end{equation*}
$$

Due to (3.1), (3.3), and (3.4), it holds that $\{y\}^{-} \cap($ choice $\backslash\{x\}) \neq \emptyset$, which is a contradiction with $\{y\}^{-} \cap$ choice $=\{x\}$, see the premise of this proposition.

Proposition 4. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, and $x \in$ tabu be an argument with $\{x\}^{-} \subseteq S^{+} \cup$ tabu. Then, there does not exist a stable extension $T \supseteq S$ such that $T \backslash S \subseteq$ choice.

Proof. Assume there exists a stable extension $T \supseteq S$ with $T \backslash S \subseteq$ choice. Since $(S \cup$ choice $) \cap\left(S^{+} \cup t a b u\right)=\emptyset$,

$$
\begin{equation*}
T \cap\left(S^{+} \cup t a b u\right)=\emptyset \tag{4.1}
\end{equation*}
$$

As $x \in$ tabu and due to (4.1), $x \notin T$. Thus, $x \in T^{+}$because $T$ is stable. Subsequently,

$$
\begin{equation*}
T \cap\{x\}^{-} \neq \emptyset . \tag{4.2}
\end{equation*}
$$

Because $\{x\}^{-} \subseteq S^{+} \cup t a b u$,

$$
\begin{equation*}
T \cap\left(S^{+} \cup t a b u\right) \neq \emptyset \tag{4.3}
\end{equation*}
$$

Note the contradiction between (4.1) and (4.3).
We now give Algorithm 1 for listing all stable extensions in a given AF. Before presenting its proof, we demonstrate an execution of Algorithm 1.

Example 2. Apply Algorithm 1 to list the stable extensions in $H_{1}$ :

1. Initially, call $\operatorname{stb}(\emptyset,\{a, b, c, d, e, f\}, \emptyset)$.
2. Perform the repeat-until block of Algorithm 1 to get $S=\emptyset$, choice $=$ $\{a, b, c, d, e, f\}$, and $t a b u=\emptyset$.
3. Call $\operatorname{stb}(\{a\},\{c, d\},\{e, f\})$, see line 16 in the algorithm.
4. Now, execute the repeat-until block to get $S=\{a, c, d\}$, choice $=\emptyset$, and $t a b u=\emptyset$. Applying line $14, S$ is stable. Now, apply line 15 and return to the state: $S=\emptyset$, choice $=\{a, b, c, d, e, f\}$, and tabu $=\emptyset$.
5. Call $\operatorname{stb}(\emptyset,\{b, c, d, e, f\},\{a\})$, see line 17 in the algorithm.
6. After performing the repeat-until block, $S=\emptyset$, choice $=\{b, c, d, e, f\}$, and $t a b u=\{a\}$.
7. Call $\operatorname{stb}(\{b\},\{e, f\},\{a\})$, see line 16 .
8. Apply the repeat-until block to get $S=\{b, e\}$, choice $=\emptyset$, and tabu $=\emptyset$. Performing line 14 , we find $S$ stable. Now apply line 15 , and so return to the state: $S=\emptyset$, choice $=\{b, c, d, e, f\}$, and tabu $=\{a\}$.
9. Call $\operatorname{stb}(\emptyset,\{c, d, e, f\},\{a, b\})$, see line 17 .
10. Perform a first round of the repeat-until block. Thus, $S=\{d\}$, choice $=$ $\{c\}$, and $t a b u=\{a\}$. In a second round of the repeat-until block, the algorithm returns (see line 2), and eventually the algorithm halts.

In what follows we give another set of propositions that together with the previous ones will establish the validity of Algorithm 1 . Thus, we denote by $T_{i}$ the elements of a set $T$ at the algorithm's state $i$. The algorithm enters a new state whenever $S$ is updated. In other words, the algorithm enters a new state whenever line $4,9,16$, or 17 are executed. Focusing on the under-construction stable extension $S$ and consistently with the algorithm's actions, in the initial state of the algorithm we let

\begin{equation*}
S_{1}=\emptyset, \tag{1}
\end{equation*}
$$

and for every state $i$ it is the case that

$$
\begin{align*}
& S_{i+1}=S_{i}, \text { or } \\
& S_{i+1}=S_{i} \cup \delta_{i} \text { with } \delta_{i} \in\left\{\alpha_{i}, \beta_{i},\{x\}_{i}\right\} \tag{2}
\end{align*}
$$

see respectively lines $17,4,9$, and 16 in the algorithm.
Proposition 5. Let $H=(A, R)$ be an AF and Algorithm 1 be started with

$$
\operatorname{stb}(\emptyset, A \backslash\{x \mid(x, x) \in R\},\{x \mid(x, x) \in R\})
$$

For every state $i, S_{i} \cap S_{i}^{+}=\emptyset$.
Proof. As $S_{1}=\emptyset, S_{1} \cap S_{1}^{+}=\emptyset$. We now show that for every state $i$

$$
\begin{equation*}
S_{i} \cap S_{i}^{+}=\emptyset \Longrightarrow S_{i+1} \cap S_{i+1}^{+}=\emptyset . \tag{5.1}
\end{equation*}
$$

Suppose $S_{i} \cap S_{i}^{+}=\emptyset$. Using (2) we write

$$
\begin{align*}
S_{i+1} \cap S_{i+1}^{+} & =\left(S_{i} \cup \delta_{i}\right) \cap\left(S_{i}^{+} \cup \delta_{i}^{+}\right)  \tag{5.2}\\
& =\left(S_{i} \cap S_{i}^{+}\right) \cup\left(S_{i} \cap \delta_{i}^{+}\right) \cup\left(S_{i}^{+} \cap \delta_{i}\right) \cup\left(\delta_{i} \cap \delta_{i}^{+}\right) .
\end{align*}
$$

In fact, $\delta_{i} \subseteq$ choice $_{i}$, recall (2) and lines 3, 7, and 16. Considering (5.2), we proceed the proof by showing that

$$
\begin{equation*}
\left(S_{i} \cap S_{i}^{+}\right) \cup\left(S_{i} \cap \text { choice }_{i}^{+}\right) \cup\left(S_{i}^{+} \cap \text { choice }_{i}\right) \cup\left(\delta_{i} \cap \delta_{i}^{+}\right)=\emptyset . \tag{5.3}
\end{equation*}
$$

In other words, we need to prove that for every state $i$

$$
\begin{gather*}
S_{i} \cap \text { choice }_{i}^{+}=\emptyset,  \tag{5.4}\\
S_{i}^{+} \cap \text { choice }_{i}=\emptyset  \tag{5.5}\\
\delta_{i} \cap \delta_{i}^{+}=\emptyset \tag{5.6}
\end{gather*}
$$

Now we prove (5.4). For $i=1, S_{1} \cap$ choice ${ }_{1}^{+}=\emptyset$ since $S_{1}=\emptyset$. Then, we will show that

$$
\begin{equation*}
\forall i\left(S_{i} \cap \text { choice }_{i}^{+}=\emptyset \Longrightarrow S_{i+1} \cap \text { choice }_{i+1}^{+}=\emptyset\right) \tag{5.7}
\end{equation*}
$$

Suppose $S_{i} \cap$ choice $_{i}^{+}=\emptyset$. Referring to lines 5,10 and 16 , it holds that choice $_{i+1}=$ choice $_{i} \backslash\left(\delta_{i} \cup \delta_{i}^{-} \cup \delta_{i}^{+}\right)$. And using (2), we note that

$$
\begin{equation*}
S_{i+1} \cap \text { choice }_{i+1}^{+}=\left(S_{i} \cup \delta_{i}\right) \cap\left(\text { choice }_{i} \backslash\left(\delta_{i} \cup \delta_{i}^{-} \cup \delta_{i}^{+}\right)\right)^{+} \tag{5.8}
\end{equation*}
$$

Since $S_{i} \cap$ choice $_{i}^{+}=\emptyset$, it holds that $S_{i} \cap\left(\text { choice }_{i} \backslash\left(\delta_{i} \cup \delta_{i}^{-} \cup \delta_{i}^{+}\right)\right)^{+}=\emptyset$. Additionally, we note that

$$
\begin{equation*}
\delta_{i} \cap\left(\text { choice }_{i} \backslash\left(\delta_{i} \cup \delta_{i}^{-} \cup \delta_{i}^{+}\right)\right)^{+}=\emptyset \Longleftrightarrow \delta_{i}^{-} \cap\left(\text { choice }_{i} \backslash\left(\delta_{i} \cup \delta_{i}^{-} \cup \delta_{i}^{+}\right)\right)=\emptyset \tag{5.9}
\end{equation*}
$$

As $\delta_{i}^{-} \cap\left(\right.$ choice $\left._{i} \backslash\left(\delta_{i} \cup \delta_{i}^{-} \cup \delta_{i}^{+}\right)\right)=\emptyset$, (5.8) holds. For the case of line 17 in the algorithm, where $S_{i+1}=S_{i}$, note that

$$
\begin{equation*}
S_{i+1} \cap \text { choice }_{i+1}^{+}=S_{i} \cap\left(\text { choice }_{i} \backslash\{x\}_{i}\right)^{+}=\emptyset \tag{5.10}
\end{equation*}
$$

since $S_{i} \cap$ choice $_{i}^{+}=\emptyset$. That concludes the proof of (5.4). Now we prove (5.5). For $i=1$, it holds that choice ${ }_{1} \cap S_{1}^{+}=\emptyset$ since $S_{1}=\emptyset$. Then, we need to show that for every state $i$

$$
\begin{equation*}
\text { choice }_{i} \cap S_{i}^{+}=\emptyset \Longrightarrow \text { choice }_{i+1} \cap S_{i+1}^{+}=\emptyset . \tag{5.11}
\end{equation*}
$$

Referring to line 5,10 , and 16 , it is the case that choice $_{i+1}=$ choice $_{i} \backslash\left(\delta_{i} \cup\right.$ $\left.\delta_{i}^{+} \cup \delta_{i}^{-}\right)$. Considering (2), observe that

$$
\begin{align*}
\text { choice }_{i+1} \cap S_{i+1}^{+} & =\left(\text {choice }_{i} \backslash\left(\delta_{i} \cup \delta_{i}^{+} \cup \delta_{i}^{-}\right)\right) \cap\left(S_{i} \cup \delta_{i}\right)^{+}  \tag{5.12}\\
& =\left(\text {choice }_{i} \backslash\left(\delta_{i} \cup \delta_{i}^{+} \cup \delta_{i}^{-}\right)\right) \cap\left(S_{i}^{+} \cup \delta_{i}^{+}\right) .
\end{align*}
$$

Thus, (5.11) holds. Likewise, for the case of line 17 in the algorithm,

that $\delta_{i} \in\left\{\alpha_{i}, \beta_{i},\{x\}_{i}\right\}$. Considering the algorithm's actions (lines 3, 7 and 16), $\delta_{i} \subseteq$ choice $_{i}$. If $\delta_{i} \in\left\{\beta_{i},\{x\}_{i}\right\}$, then $\left|\delta_{i}\right|=1$, and so $\delta_{i} \cap \delta_{i}^{+}=\emptyset$ holds since $\{x \mid(x, x) \in R\} \nsubseteq$ choice $_{i}$. If $\delta_{i}=\alpha_{i}$, then from line 3 in the algorithm we note that

choice $_{i+1} \cap$ tabu $_{i+1}=\left(\right.$ choice $\left._{i} \backslash\left(\delta_{i} \cup \delta_{i}^{-} \cup \delta_{i}^{+}\right)\right) \cap\left(\left(\right.\right.$ tabu $\left.\left._{i} \cup \delta_{i}^{-}\right) \backslash\left(S_{i}^{+} \cup \delta_{i}^{+}\right)\right)=\emptyset$.
For the case of line 17 , observe that

& =\left(\left(A \backslash\left(S_{i} \cup S_{i}^{+} \cup \text { choice }_{i}\right)\right) \cup \delta_{i c}^{-}\right) \backslash\left(S_{i}^{+} \cup \delta_{i c}^{+} \cup \delta_{i t}^{+}\right) \\
& =\left(\left(A \backslash\left(S_{i} \cup S_{i}^{+} \cup \text { choice }_{i}\right)\right) \cup \delta_{i c}^{-}\right) \backslash\left(\delta_{i c}^{+} \cup \delta_{i t}^{+}\right) \\
& =\left(\left(A \backslash\left(S_{i} \cup S_{i}^{+} \cup \text { choice }_{i+1} \cup \delta_{i} \cup \delta_{i c}^{+} \cup \delta_{i c}^{-}\right)\right) \cup \delta_{i c}^{-}\right) \backslash\left(\delta_{i c}^{+} \cup \delta_{i t}^{+}\right) \\
& =\left(A \backslash\left(S_{i} \cup S_{i}^{+} \cup \text { choice }_{i+1} \cup \delta_{i} \cup \delta_{i c}^{+}\right)\right) \backslash\left(\delta_{i c}^{+} \cup \delta_{i t}^{+}\right) \\
& =\left(A \backslash\left(S_{i} \cup S_{i}^{+} \cup \text { choice }_{i+1} \cup \delta_{i} \cup \delta_{i c}^{+}\right)\right) \backslash \delta_{i t}^{+} \\
& =A \backslash\left(S_{i} \cup S_{i}^{+} \cup \text { choice }_{i+1} \cup \delta_{i} \cup \delta_{i c}^{+} \cup \delta_{i t}^{+}\right) \\

This concludes our proof of Proposition 7.
Proposition 8. Let $H=(A, R)$ be an AF and Algorithm 1 be started with

The algorithm computes exactly the stable extensions of $H$.
Proof. We will show that the following two statements (P1 \& P2) hold.
$P 1$. For every set, $S_{i}$, reported by Algorithm 1 at line 14 at some state $i, S_{i}$ is a stable extension in $H$.
P2. For all $Q$, if $Q$ is a stable extension in $H$ and Algorithm 1 is sound (i.e. $P 1$ is established), then there is a stable extension $S_{i}$, reported by the algorithm at line 14 at some state $i$, such that $S_{i}=Q$.
Regarding P1, to show that $S_{i}^{+}=A \backslash S_{i}$ we need to prove that

$$
\begin{equation*}
S_{i} \cap S_{i}^{+}=\emptyset \tag{8.1}
\end{equation*}
$$

and

$$
\begin{equation*}
S_{i} \cup S_{i}^{+}=A \tag{8.2}
\end{equation*}
$$

Note, (8.1) is proved in Proposition 5. For (8.2), it can be easily established by using Proposition 1 if we prove that for every state $i$

However, (8.3) and (8.4) are proved in Proposition 6 and 7 respectively. Thus, referring to line 14 in the algorithm, we note that $S_{i}$ is reported stable if and only if $t a b u_{i}=$ choice $_{i}=\emptyset$. Considering (8.4), we note that $\emptyset=A \backslash\left(S_{i} \cup S_{i}^{+} \cup \emptyset\right)$, and hence (8.2) holds. The proof of P1 is complete.

Regarding P2, we rewrite P2 (by modifying the consequence) into Ṕ2.
Ṕ2: For all $Q$, if $Q$ is a stable extension in $H$ and Algorithm 1 is sound, then there is a stable extension $S_{i}$, reported by the algorithm at line 14 at some state $i$, such that for all $a \in Q$ it holds that $a \in S_{i}$.

We establish Ṕ2 by contradiction. Later, we show that the consequence of $P{ }^{2} 2$ is equivalent to the consequence of $P 2$. Now, assume that $P 2$ is false.

Negation of Ṕ2: There is $Q$ such that $Q$ is a stable extension in $H$, Algorithm 1 is sound, and for every $S_{i}$ reported by the algorithm at line 14 at some state $i$, there is $a \in Q$ such that $a \notin S_{i}$.

We identify four cases.
Case 1. For $a \in$ choice $_{1}$, if the algorithm terminates at line 2 during the very first execution of the repeat-until block (but not necessarily from the first round), then, since the algorithm is sound, $H$ has no stable extensions. This contradicts the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Hence, Ṕ2 holds.

Case 2. If $(a, a) \in R$, then this is a contradiction with the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Hence, $P$ Ṕ2 holds.

Case 3. With $a \in$ choice $_{1}$, assume that after the very first execution of the repeat-until block (i.e. including one or more rounds), $a \in$ choice $_{k}$ for some state $k \geq 1$. Then, for a state $i \geq k$, let $x=a$ (see line 16 in Algorithm 1). If for all subsequent states $j>i$, the set $S_{j} \supseteq\{a\}$ is not reported stable by the algorithm, then, since the algorithm is sound, $a$ does not belong to any stable extension. This contradicts the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Hence, $P$ Ṕ2 holds.

Case 4. With $a \in$ choice $_{1}$, assume that after the very first execution of the repeat-until block (i.e. including one or more rounds), $a \notin$ choice $_{i}$ for some state $i>1$. This implies, according to the repeat-until block's actions, that $\{a\} \subseteq S_{i} \cup S_{i}^{+} \cup t a b u_{i}$. For $\{a\} \subseteq S_{i}$, if for all subsequent states $j>i$, the set $S_{j} \supseteq\{a\}$ is not reported stable by the algorithm, then, since the algorithm is sound, $a$ does not belong to any stable extension. This contradicts the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Likewise, for $\{a\} \subseteq S_{i}^{+} \cup t a b u_{i}$, since the algorithm's actions are sound, this implies that $a$ does not belong to any stable extension. This contradicts the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Hence, $P 2$ holds.
Now we rewrite the consequence of $P$ P 2 .
The consequence of Ṕ2: There is a stable extension $S_{i}$, reported by the algorithm at line 14 at some state $i$, such that $Q \subseteq S_{i}$.
$Q$ being a proper subset of $S_{i}$ is impossible because otherwise it contradicts that the algorithm is sound or that $Q$ is stable. Therefore, the consequence of $P$ ' 2 can be rewritten as next.
The consequence of Ṕ2: There is a stable extension $S_{i}$, reported by the algorithm at line 14 at some state $i$, such that $Q=S_{i}$.
This is exactly the consequence of $P 2$.

## 3. Validation of a finer-level implementation of the algorithm

Recall that Algorithm 1 includes set operations substantially. So far, it is left unspecified how to mechanize these operations. In this section, we will develop a new version that implements Algorithm 1. In other words, we will define at a finer level the underlying actions of Algorithm 1. To this end, we employ a total mapping to indicate the status of an argument in a given AF with respect to $S, S^{+}$, choice, and tabu.

Definition 1. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq A \backslash(S \cup$ $\left.S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, and $\mu: A \rightarrow\{$ blank, in, out, must-out $\}$ be a total mapping. Then, $\mu$ is a labelling of $H$ with respect to $S$ if and only if for all $x \in A$ it is the case that

$$
\begin{aligned}
& x \in S \Longleftrightarrow \mu(x)=\text { in } \\
& x \in S^{+} \Longleftrightarrow \mu(x)=\text { out }, \\
& x \in \text { choice } \Longleftrightarrow \mu(x)=\text { blank, and } \\
& x \in \text { tabu } \Longleftrightarrow \mu(x)=\text { must-out }
\end{aligned}
$$

Note that our labelling mechanism is used here as an ad hoc algorithmic vehicle. For the widely-known labelling-based argumentation semantics, we refer the reader to 4, 2] for example. Now, we specify the labellings that correspond to stable extensions.

Proposition 9. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, and $\mu$ be a labelling of $H$ with respect to $S$. Then, $\{x \mid \mu(x)=i n\}$ is a stable extension in $H$ if and only if $\{x \mid \mu(x)=$ blank $\}=\emptyset$ and $\{x \mid \mu(x)=$ must-out $\}=\emptyset$.

Proof. We prove $\Longrightarrow$ firstly. Considering Definition $1, S=\{x \mid \mu(x)=i n\}$ and $S^{+}=\{x \mid \mu(x)=o u t\}$. Suppose $\{x \mid \mu(x)=$ in $\}$ is stable. Then,

$$
\begin{equation*}
\{x \mid \mu(x)=\text { out }\}=A \backslash\{x \mid \mu(x)=\text { in }\} \tag{9.1}
\end{equation*}
$$

Thus,

$$
\begin{equation*}
\{x \mid \mu(x)=\text { in }\} \cup\{x \mid \mu(x)=\text { out }\}=A \tag{9.2}
\end{equation*}
$$

By Definition 1, observe that

$$
\begin{align*}
\text { tabu } & =\{x \mid \mu(x)=\text { must-out }\} \\
& =A \backslash(\{x \mid \mu(x)=\text { in }\} \cup\{x \mid \mu(x)=\text { out }\} \cup\{x \mid \mu(x)=\text { blank }\}) \tag{9.3}
\end{align*}
$$

Given (9.2), rewrite (9.3) as

$$
\begin{equation*}
\{x \mid \mu(x)=\text { must-out }\}=A \backslash(A \cup\{x \mid \mu(x)=\text { blan } k\})=\emptyset \tag{9.4}
\end{equation*}
$$

Likewise, as Definition 1 states that choice $=\{x \mid \mu(x)=$ blank $\}$,

$$
\begin{equation*}
\{x \mid \mu(x)=\text { blank }\} \subseteq A \backslash\left(\{x \mid \mu(x)=\text { in }\} \cup\{x \mid \mu(x)=\text { out }\} \cup S^{-}\right) \tag{9.5}
\end{equation*}
$$

Given (9.2), we rewrite (9.5) as

$$
\begin{equation*}
\{x \mid \mu(x)=\text { blank }\} \subseteq A \backslash\left(A \cup S^{-}\right) \tag{9.6}
\end{equation*}
$$

Hence, $\{x \mid \mu(x)=$ blank $\}=\emptyset$.
Now we prove $\Longleftarrow$. Suppose $\{x \mid \mu(x)=$ blank $\}=\emptyset$ and $\{x \mid \mu(x)=$ must-out $\}=\emptyset$. Note that

$$
\begin{align*}
\text { tabu } & =\{x \mid \mu(x)=\text { must-out }\}= \\
& =A \backslash(\{x \mid \mu(x)=\text { in }\} \cup\{x \mid \mu(x)=\text { out }\} \cup\{x \mid \mu(x)=\text { blan } k), \tag{9.7}
\end{align*}
$$

which can be rewritten as

$$
\begin{equation*}
\emptyset=A \backslash(\{x \mid \mu(x)=\text { in }\} \cup\{x \mid \mu(x)=\text { out }\} \cup \emptyset) \tag{9.8}
\end{equation*}
$$

And subsequently,

$$
\begin{equation*}
A=\{x \mid \mu(x)=\text { in }\} \cup\{x \mid \mu(x)=\text { out }\} . \tag{9.9}
\end{equation*}
$$

Given (9.9), and since $\{x \mid \mu(x)=$ in $\} \cap\{x \mid \mu(x)=$ out $\}=\emptyset$, we note that $\{x \mid \mu(x)=$ out $\}=A \backslash\{x \mid \mu(x)=$ in $\}$. Consequently, $\{x \mid \mu(x)=i n\}$ is a stable extension in $H$. $\square$

Using the labelling notion introduced in Definition 1, next we discuss three propositions that are analogous to Proposition 2, 3 and 4, and which are crucial for efficient enumeration of stable extensions.

Proposition 10. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, $\mu$ be a labelling of $H$ with respect to $S$, and $v$ be an argument with $\mu(v)=$ blank such that for all $y \in\{v\}^{-}$it holds that $\mu(y) \in\{$ out, must-out $\}$. If there is a stable extension $T \supseteq\{x \mid \mu(x)=i n\}$ such that $T \backslash\{x \mid \mu(x)=i n\} \subseteq\{x \mid \mu(x)=$ blank $\}$, then $v \in T$.

Proof. Suppose $v \notin T$. Then, $v \in T^{+}$because $T$ is stable. Thus,

$$
\begin{equation*}
\exists y \in\{v\}^{-} \text {such that } y \in T \tag{10.1}
\end{equation*}
$$

However, consistently with the premise of Proposition 10,

$$
\begin{equation*}
\forall y \in\{v\}^{-} \mu(y) \in\{\text { out }, \text { must-out }\} . \tag{10.2}
\end{equation*}
$$

Therefore, (10.1) and (10.2) imply

$$
\begin{equation*}
T \cap(\{x \mid \mu(x)=\text { out }\} \cup\{x \mid \mu(x)=\text { must-out }\}) \neq \emptyset \tag{10.3}
\end{equation*}
$$

According to the premise of this proposition, we note that

$$
\begin{equation*}
S \cap\left(S^{+} \cup t a b u\right)=\emptyset \text { and choice } \cap\left(S^{+} \cup t a b u\right)=\emptyset \tag{10.4}
\end{equation*}
$$

Applying Definition 1, (10.4) can be rewritten respectively as

$$
\begin{align*}
& \{x \mid \mu(x)=\text { in }\} \cap(\{x \mid \mu(x)=\text { out }\} \cup\{x \mid \mu(x)=\text { must-out }\})=\emptyset, \text { and } \\
& \{x \mid \mu(x)=\text { blank }\} \cap(\{x \mid \mu(x)=\text { out }\} \cup\{x \mid \mu(x)=\text { must-out }\})=\emptyset . \tag{10.5}
\end{align*}
$$

Given the premise of this proposition, note that

$$
\begin{equation*}
T \supseteq\{x \mid \mu(x)=i n\}, \text { and } T \backslash\{x \mid \mu(x)=i n\} \subseteq\{x \mid \mu(x)=\text { blank }\} . \tag{10.6}
\end{equation*}
$$

Thus, (10.5) and (10.6) imply that

T \cap(\{x \mid \mu(x)=o u t\} \cup\{x \mid \mu(x)=\text { must-out }\})=\emptyset . \tag{10.7}
\end{equation*}
$$

Observe the contradiction between (10.3) and (10.7).
Proposition 11. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, $\mu$ be a labelling of $H$ with respect to $S$, and $v$ be an argument with $\mu(v)=$ blank such that for some $y$ with $\mu(y)=$ must-out it is the case that $\left\{x \in\{y\}^{-} \mid \mu(x)=\right.$ blank $\}=\{v\}$. If there is a stable extension $T \supseteq\{x \mid \mu(x)=$ in $\}$ such that $T \backslash\{x \mid \mu(x)=$ in $\} \subseteq\{x \mid$ $\mu(x)=$ blank $\}$, then $v \in T$.
Proof. Suppose $v \notin T$. Then,

$$
\begin{equation*}
T \backslash\{x \mid \mu(x)=i n\} \subseteq\{x \mid \mu(x)=\text { blank }\} \backslash\{v\} \tag{11.1}
\end{equation*}
$$

Due to $t a b u=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, and according to Definition 1 it holds that

$$
\begin{align*}
\text { tabu } & =\{x \mid \mu(x)=\text { must-out }\} \\
& =A \backslash(\{x \mid \mu(x)=\text { in }\} \cup\{x \mid \mu(x)=\text { out }\} \cup\{x \mid \mu(x)=\text { blank }\}) \tag{11.2}
\end{align*}
$$

Since $T \supseteq\{x \mid \mu(x)=i n\}$ such that $T \backslash\{x \mid \mu(x)=i n\} \subseteq\{x \mid \mu(x)=$ blank $\}$,

$$
\begin{equation*}
T \subseteq\{x \mid \mu(x)=\operatorname{in}\} \cup\{x \mid \mu(x)=\text { blank }\} \tag{11.3}
\end{equation*}
$$

Referring to the premise of this proposition, as $y \in\{x \mid \mu(x)=$ must-out $\}$, $y \in t a b u$ (recall Definition 1) and so $y \notin T$. However, since $T$ is stable, $y \in T^{+}$. Thus,

$$
\begin{equation*}
\{y\}^{-} \cap T \neq \emptyset \tag{11.4}
\end{equation*}
$$

Given (11.2) and because $y \in\{x \mid \mu(x)=$ must-out $\}$, it holds that $y \notin\{x \mid$ $\mu(x)=o u t\}$; hence $y \notin S^{+}$consistently with Definition 1 . Therefore,

$$
\begin{equation*}
\{y\}^{-} \cap\{x \mid \mu(x)=i n\}=\emptyset \tag{11.5}
\end{equation*}
$$

Thereby, (11.1), (11.4) and (11.5) together imply that

$$
\begin{equation*}
\{y\}^{-} \cap(\{x \mid \mu(x)=\text { blank }\} \backslash\{v\}) \neq \emptyset \tag{11.6}
\end{equation*}
$$

From the premise of this proposition, it is the case that $\left\{x \in\{y\}^{-} \mid \mu(x)=\right.$ blank $\}=\{v\}$. Thus,

$$
\begin{equation*}
\{y\}^{-} \cap\{x \mid \mu(x)=\text { blank }\}=\{v\} . \tag{11.7}
\end{equation*}
$$

See the contradiction between (11.6) and (11.7).

Proposition 12. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, $\mu$ be a labelling of $H$ with respect to $S$, and $x$ be an argument with $\mu(x)=$ must-out such that for all $y \in\{x\}^{-}$it is the case that $\mu(y) \in\{o u t$, must_out $\}$. There does not exist a stable extension $Q \supseteq\{v \mid \mu(v)=i n\}$ such that $Q \backslash\{v \mid \mu(v)=i n\} \subseteq\{v \mid \mu(v)=$ blank $\}$.
Proof. Consider Definition 1 during the proof. As $x \in\{v \mid \mu(v)=$ must-out $\}$ and tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$,

$$
\begin{equation*}
x \notin\{v \mid \mu(v)=\text { in }\} \cup\{v \mid \mu(v)=\text { out }\} \cup\{v \mid \mu(v)=\text { blank }\} . \tag{12.1}
\end{equation*}
$$

Subsequently,

$$
\begin{align*}
& \forall T \supseteq\{v \mid \mu(v)=i n\} \text { such that } T \backslash\{v \mid \mu(v)=i n\} \subseteq\{v \mid \mu(v)=\text { blank }\}, \\
& x \notin T . \tag{12.2}
\end{align*}
$$

Since for all $y \in\{x\}^{-}$it holds that $\mu(y) \in\{$ out, must_out $\}$,

$$
\begin{equation*}
\{x\}^{-} \subseteq\{v \mid \mu(v)=o u t\} \cup\{v \mid \mu(v)=\text { must-out }\} \tag{12.3}
\end{equation*}
$$

Hence,

$$
\begin{equation*}
\{x\}^{-} \cap(\{v \mid \mu(v)=i n\} \cup\{v \mid \mu(v)=\text { blank }\})=\emptyset \tag{12.4}
\end{equation*}
$$

Therefore,

$$
\begin{align*}
& \forall T \supseteq\{v \mid \mu(v)=i n\} \text { such that } T \backslash\{v \mid \mu(v)=i n\} \subseteq\{v \mid \mu(v)=\text { blan } k\}, \\
& \{x\}^{-} \cap T=\emptyset \tag{12.5}
\end{align*}
$$

Thus,
$\forall T \supseteq\{v \mid \mu(v)=i n\}$ such that $T \backslash\{v \mid \mu(v)=i n\} \subseteq\{v \mid \mu(v)=$ blank $\}$, $x \notin T^{+}$.

Given (12.2) and (12.6),
$\forall T \supseteq\{v \mid \mu(v)=i n\}$ such that $T \backslash\{v \mid \mu(v)=i n\} \subseteq\{v \mid \mu(v)=$ blank $\}$, $T^{+} \neq A \backslash T$.

Consequently,
$\forall T \supseteq\{v \mid \mu(v)=i n\}$ such that $T \backslash\{v \mid \mu(v)=i n\} \subseteq\{v \mid \mu(v)=$ blank $\}$, $T$ is not stable.

That completes the proof of Proposition 12.
Now, we turn to the lines 2,3 and 7 in Algorithm 1. Recall, by applying these lines it is required to search (respectively) for an argument $x$ such that

$$
\begin{aligned}
& x \in \text { tabu with }\{x\}^{-} \subseteq S^{+} \cup \text { tabu, or } \\
& x \in \text { choice with }\{x\}^{-} \subseteq S^{+} \cup \text { tabu, or } \\
& x \in \text { tabu with } \mid\{x\}^{-} \cap \text { choice } \mid=1
\end{aligned}
$$

To implement these lines (i.e. 2, 3, and 7) efficiently, we define the following construct (inspired by a hint given in [15] and already utilized in [17]).

Definition 2. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, and $\mu$ be a labelling of $H$ with respect to $S$. For all $x \in A$, if $\mu(x) \in\{$ blank, must-out $\}$, then $\pi(x) \stackrel{\text { def }}{=} \mid\{y \in$ $\{x\}^{-}: \mu(y)=$ blank $\} \mid$.

The intuition behind Definition 2 is that instead of checking (recurrently over and over) the whole set of attackers, $\{x\}^{-}$, of a given argument $x$, to see whether $\{x\}^{-}$is contained in $S^{+} \cup t a b u$, one might hold a counter of the attackers of $x$ that are currently in choice. Whenever an attacker of $x$ is being moved from choice, we decrease the counter. So, for checking whether $\{x\}^{-} \subseteq S^{+} \cup t a b u$ all we need to do is to test if the counter is equal to zero. In the following proposition, we prove the usage of this notion (i.e. counting attackers).

Proposition 13. Let $H=(A, R)$ be an AF, $S \subseteq A, S \cap S^{+}=\emptyset$, choice $\subseteq$ $A \backslash\left(S \cup S^{+} \cup S^{-}\right)$, tabu $=A \backslash\left(S \cup S^{+} \cup\right.$ choice $)$, and $\mu$ be a labelling of $H$ with respect to $S$. Then, for all $x \in A$ it holds that

$$
\begin{array}{r}
x \in \text { tabu } \wedge\{x\}^{-} \subseteq S^{+} \cup \text { tabu } \Longleftrightarrow \mu(x)=\text { must-out } \wedge \pi(x)=0, \\
x \in \text { choice } \wedge\{x\}^{-} \subseteq S^{+} \cup t a b u \Longleftrightarrow \mu(x)=\text { blank } \wedge \pi(x)=0 \\
x \in \text { tabu } \wedge \mid\{x\}^{-} \cap \text { choice } \mid=1 \Longleftrightarrow \mu(x)=\text { must-out } \wedge \pi(x)=1 \tag{13.3}
\end{array}
$$

Proof. Consider Definition 1 and 2 throughout this proof. From the premise of this proposition, note that $S \cup S^{+} \cup$ choice $\cup t a b u=A$. Additionally, the sets: $S, S^{+}, t a b u$, and choice are pairwise disjoint. Thus, for all $x$

$$
\begin{aligned}
& x \in \text { tabu } \wedge\{x\}^{-} \subseteq S^{+} \cup \text { tabu } \Longleftrightarrow \\
& x \in \text { tabu } \wedge\{x\}^{-} \cap(S \cup \text { choice })=\emptyset \Longleftrightarrow \\
& x \in \text { tabu } \wedge x \notin S^{+} \wedge\left\{y \in\{x\}^{-} \mid y \in \text { choice }\right\}=\emptyset \Longleftrightarrow \\
& \mu(x)=\text { must-out } \wedge\left\{y \in\{x\}^{-} \mid \mu(y)=\text { blank }\right\}=\emptyset \Longleftrightarrow \\
& \mu(x)=\text { must-out } \wedge \pi(x)=0 .
\end{aligned}
$$

That completes the proof of (13.1). Likewise, (13.2) is true since for all $x$ it holds that

$$
\begin{aligned}
& x \in \text { choice } \wedge\{x\}^{-} \subseteq S^{+} \cup \text { tabu } \Longleftrightarrow \\
& x \in \text { choice } \wedge\{x\}^{-} \cap(S \cup \text { choice })=\emptyset \Longleftrightarrow \\
& x \in \text { choice } \wedge x \notin S^{+} \wedge\left\{y \in\{x\}^{-} \mid y \in \text { choice }\right\}=\emptyset \Longleftrightarrow \\
& \mu(x)=\text { blank } \wedge\left\{y \in\{x\}^{-} \mid \mu(y)=\text { blank }\right\}=\emptyset \Longleftrightarrow \\
& \mu(x)=\text { blank } \wedge \pi(x)=0 .
\end{aligned}
$$

As to (13.3), for all $x$ it is the case that

$$
\begin{aligned}
& x \in \text { tabu } \wedge \mid\{x\}^{-} \cap \text { choice } \mid=1 \Longleftrightarrow \\
& \mu(x)=\text { must-out } \wedge \mid\left\{y \in\{x\}^{-}: y \in \text { choice }\right\} \mid=1 \Longleftrightarrow \\
& \mu(x)=\text { must-out } \wedge \mid\left\{y \in\{x\}^{-}: \mu(y)=\text { blank }\right\} \mid=1 \Longleftrightarrow \\
& \mu(x)=\text { must-out } \wedge \pi(x)=1 .
\end{aligned}
$$

Making use of the structures $\mu$ and $\pi$ specified in Definition $1 \& 2$ respectively, we give Algorithm 2. Let $H=(A, R)$ be an AF, $\mu: A \rightarrow$ $\{$ in, out, must-out, blank $\}$ be a total mapping such that for all $x \in A$,

$$
\mu(x)= \begin{cases}\text { must-out, } & \text { if }(x, x) \in R \\ \text { blank }, & \text { otherwise }\end{cases}
$$

And let $\pi: A \rightarrow\{0,1,2, \ldots,|A|\}$ be a total mapping such that for all $x \in A$, $\pi(x)=\mid\left\{y \in\{x\}^{-}: \mu(y)=\right.$ blank $\} \mid$. By invoking Algorithm 2 with list-stb$\operatorname{ext}(\mu, \pi,\{x \mid \mu(x)=$ blank $\wedge \pi(x)=0\})$, the algorithm computes all stable extensions in $H$.

Example 3. Using Algorithm 2, we list the stable extensions of $H_{1}$ (see Figure 1). So, we start the algorithm with list-stb-ext $(\mu, \pi, \gamma)$ such that

& \mu=\{(a, \text { blank }),(b, \text { blank }),(c, \text { blank }),(d, \text { blank }),(e, \text { blank }),(f, \text { blank })\}, \\
& \pi=\{(a, 2),(b, 2),(c, 2),(d, 1),(e, 1),(f, 2)\},  \tag{3.1}\\
& \gamma=\emptyset .
\end{align*}
$$

Referring to line 15 in Algorithm 2, let $x$ be the argument $a$. Then, invoke list-stb-ext $(\mu, \pi, \gamma)$ with

\begin{align*}
& \mu=\{(a, \text { blank }),(b, \text { blank }),(c, \text { blank }),(d, \text { blank }),(e, \text { blan }),(f, \text { blank })\}, \\
& \pi=\{(a, 2),(b, 2),(c, 2),(d, 1),(e, 1),(f, 2)\},  \tag{3.2}\\
& \gamma=\{a\}
\end{align*}
$$

Apply a first round of the while loop of the algorithm. Therefore,

$$
\begin{align*}
& \mu=\{(a, \text { in }),(b, \text { out }),(c, \text { blank }),(d, \text { blank }),(e, \text { must-out }),(f, \text { must-out })\}, \\
& \pi=\{(a, 0),(b, 2),(c, 0),(d, 0),(e, 1),(f, 1)\} \\
& \gamma=\{c, d\} \tag{3.3}
\end{align*}
$$

After a second and third round of the while loop,

$$
\begin{align*}
& \mu=\{(a, \text { in }),(b, \text { out }),(c, \text { in }),(d, \text { in }),(e, \text { out }),(f, \text { out })\}, \\

Now, $\{a, c, d\}$ is stable, see line 13 in Algorithm 2. Applying line 14, backtrack to state (3.1). Perform the actions at lines 16-21, and then invoke list-stb-ext ( $\mu$, $\pi, \gamma$ ) (line 22) such that

As $\gamma \neq \emptyset$, apply a second round of the while loop. Thus,

Referring to line 13 in Algorithm 2, $\{b, e\}$ is stable. Applying line 14, backtrack to state (3.5). Afterwards, apply the lines 16-21 and then invoke list-stb-ext ( $\mu$, $\pi, \gamma$ ) (line 22) with

Next, we will give four more propositions that (along with Proposition 9, 10, 11, 12, and 13) will establish the correctness of Algorithm 2. To this end, we denote by $T_{i}$ the elements of a set $T$ at the algorithm's state $i$. Algorithm 2 enters a new state whenever line 2 or line 16 are executed. Note that lines 2 and 16 are sensible to be selected to designate a beginning of a new state of the algorithm since they include a decision to re-map an argument to in or must_out rather than an imposed re-mapping under some conditions, such as those conditions in the lines $3-5$. Focusing on the arguments that are mapped to $i n$, in the initial state of the algorithm, we let

And let $\mu: A \rightarrow\{$ in, out, must-out, blank $\}$ be a total mapping such that for all $x \in A$,

Assuming the premise of (14.1), (14.3) follows immediately.
As to (14.4), note that $\mu_{i}(q)=b l a n k$ for all states $i$, see (4)-(7). Now, suppose that (14.4) is false. Thus,
at some state $i, \exists x$ with $\mu_{i}(x)=i n$ such that $(q, x) \in R$ and $\mu_{i}(q)=$ blank.
This means
at some state $i, \exists x$ with $\mu_{i}(x)=i n$ such that $\exists y \in\{x\}^{-}$with $\mu_{i}(y)=$ blank.
This contradicts the actions of Algorithm 2 (lines 2-5) that indicate
for all states $i, \forall x$ with $\mu_{i}(x)=i n, \forall y \in\{x\}^{-}, \mu_{i}(y) \in\{o u t$, must_out $\}$.
Therefore, (14.4) holds.

Proposition 16. Let $H=(A, R)$ be an AF and $\pi: A \rightarrow\{0,1,2, \ldots,|A|\}$ be a total mapping such that for all $x \in A, \pi_{1}(x)=\left|\{x\}^{-} \backslash\{y:(y, y) \in R\}\right|$. And let $\mu: A \rightarrow\{$ in, out, must-out, blank $\}$ be a total mapping such that for all $x \in A$,

\mu_{1}(x)= \begin{cases}\text { must-out }, & \text { if }(x, x) \in R ;  \tag{16.1}\\ \text { blank }, & \text { otherwise } .\end{cases}

And let $\mu: A \rightarrow\{$ in, out, must-out, blank $\}$ be a total mapping such that for all $x \in A$,

Assume that Algorithm 2 is started with list-stb-ext $\left(\mu_{1}, \pi_{1},\left\{x \mid \mu_{1}(x)=\right.\right.$ blank $\wedge$ $\left.\left.\pi_{1}(x)=0\right\}\right)$. Then, the algorithm computes exactly the stable extensions in $H$.

Proof. The proof is composed of two parts:
P1. At some state $i$, let $\left\{x \mid \mu_{i}(x)=i n\right\}$ be the set reported by Algorithm 2 at line 13. Then, we need to prove that $\left\{x \mid \mu_{i}(x)=i n\right\}$ is a stable extension in $H$.

P2. For all $Q$, if $Q$ is a stable extension in $H$ and Algorithm 2 is sound (i.e. P1 is established), then there is a stable extension $\left\{x \mid \mu_{i}(x)=i n\right\}$, reported by the algorithm at line 13 at some state $i$, such that $\left\{x \mid \mu_{i}(x)=i n\right\}=Q$.

To establish $P 1$, it suffices to show that $\left\{x \mid \mu_{i}(x)=i n\right\}=A \backslash\left\{x \mid \mu_{i}(x)=i n\right\}^{+}$, which means it is required to prove that

Ṕ2: For all $Q$, if $Q$ is a stable extension in $H$ and Algorithm 2 is sound, then there is a stable extension $\left\{x \mid \mu_{i}(x)=i n\right\}$, reported by the algorithm at line 13 at some state $i$, such that for all $a \in Q$ it holds that $\mu_{i}(a)=i n$.

We establish Ṕq by contradiction. Later, we show that the consequence of $P \mathscr{2} 2$ is equivalent to the consequence of $P 2$. Now, assume that $P 2 \mathscr{2}$ is false.

Negation of Ṕ2: There is $Q$ such that $Q$ is a stable extension in $H$, Algorithm 2 is sound, and for every $\left\{x \mid \mu_{i}(x)=i n\right\}$ reported by the algorithm at line 13 at some state $i$, there is $a \in Q$ such that $\mu_{i}(a) \neq i n$.

We identify four cases.

Case 1. For $\mu_{1}(a)=b l a n k$, if the algorithm terminates at line 8 during the very first execution of the while block (but not necessarily from the first round), then, since the algorithm is sound, $H$ has no stable extensions. This contradicts the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Hence, $P$ Ṕ2 holds.

Case 2. If $(a, a) \in R$, then $\mu_{1}(a)=$ must_out, which contradicts the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Hence, $P$ Ṕz holds.

Case 3. With $\mu_{1}(a)=$ blank, assume that after the very first execution of the while block (i.e. including one or more rounds), $\mu_{k}(a)=$ blank for some state $k \geq 1$. Then, for a state $i \geq k$, let $x=a$ (see line 15 in Algorithm 2). If for all subsequent states $j>i$, the set $\left\{x \mid \mu_{j}(x)=i n\right\} \supseteq\{a\}$ is not reported stable by the algorithm, then, since the algorithm is sound, $a$ does not belong to any stable extension. This contradicts the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Hence, $P$ Ṕ2 holds.

Case 4. With $\mu_{1}(a)=$ blank, assume that after the very first execution of the while block (i.e. including one or more rounds), $\mu_{i}(a) \neq b l a n k$ for some state $i>1$. This implies, according to the while block's actions, that $\mu_{i}(a) \in\{$ in, out, must_out $\}$. For $\mu_{i}(a)=i n$, if for all subsequent states $j>i$, the set $\left\{x \mid \mu_{j}(x)=i n\right\} \supseteq\{a\}$ is not reported stable by the algorithm, then, since the algorithm is sound, $a$ does not belong to any stable extension. This contradicts the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Likewise, for $\mu_{i}(a) \in\{o u t$, must_out $\}$, since the algorithm's actions are sound, this implies that $a$ does not belong to any stable extension. This contradicts the assumption that $Q \supseteq\{a\}$ is a stable extension in $H$. Hence, $P$ Ṕ2 holds.
Now we rewrite the consequence of $P$ P 2 .
The consequence of Ṕ2: There is a stable extension $\left\{x \mid \mu_{i}(x)=i n\right\}$, reported by the algorithm at line 13 at some state $i$, such that $Q \subseteq\left\{x \mid \mu_{i}(x)=i n\right\}$.
$Q$ being a proper subset of $\left\{x \mid \mu_{i}(x)=i n\right\}$ is impossible because otherwise it contradicts that the algorithm is sound or that $Q$ is stable. Therefore, the consequence of $P$ P2 can be rewritten as next.
The consequence of Ṕ2: There is a stable extension $\left\{x \mid \mu_{i}(x)=i n\right\}$, reported by the algorithm at line 13 at some state $i$, such that $Q=\left\{x \mid \mu_{i}(x)=i n\right\}$.
This is exactly the consequence of $P 2 . \quad \square$

## 4. Conclusion

We presented formal validation of a known labeling algorithm for listing all stable extensions in a given abstract argumentation framework. Our validation process given in this paper encourages more investigations in the research arena of abstract argumentation. Despite being experimentally verified, several existing labeling algorithms for abstract argumentation lack formal validation, which can be done in the spirit of this article. Moreover, since the core of labeling algorithms is backtracking, this paper might stimulate further work to validate backtracking procedures in some other application domains.
