# WEAK SOLUTIONS TO THE TIME-FRACTIONAL $g$-BÉNARD EQUATIONS

#### Abstract

In this paper, we introduce the $g$-Bénard equations with timefractional derivative of order $\alpha \in(0,1)$ in domains of $\mathbb{R}^{2}$. This equations model, the memory-dependent heat conduction of liquids in fractal media considered in $g$-framework. We aim to study the existence and uniqueness of weak solutions by means of standard techniques from Navier-Stokes equations theory and fractional calculus theory.


## 1. Introduction

Let $\Omega_{g}=\Omega_{2} \times(0, g)$ where $\Omega_{2}$ is a bounded domain in $\mathbb{R}^{2}$ and $g$ is some scalar nonnegative function. We introduce the following time-fractional $g$-Bénard equations of the following form:

where $u$ is the fluid velocity, $p$ is the pressure, $\theta$ is the temperature, $f_{1}$ is the external force function, $f_{2}$ is the heat source function, $\xi \in \mathbb{R}^{3}$ is a constant vector, $\nu$ the kinematic viscosity and $\kappa$ the thermal diffusivity are positive constants. The derivative of order $\alpha$ is considered in the Caputo sense. The time-fractional $g$ Bénard problem consists in a system that couples time-fractional Navier-Stokes equations and time-fractional advection-diffusion heat equation in order to model a memory-dependent convection in a fluid considered in a fractal media.

The introduction of time-fractional derivative in fluid dynamics goes back to Lions in 17 but for order less than $\frac{1}{4}$ provided the space dimension is not further than 4. In recent works of Zhou and Peng [29, 30, the question of weak solutions and optimal control problem of time-fractional Navier-Stokes equations in fractal media was considered. Numerical results regarding such problems was treated firstly in [16] and constitute an emerging field of research. More recently, time-fractional $g$ -Navier-Stokes problem was introduced and results regarding existence, uniqueness of solutions and optimal control are proved [5].

The theory of $g$-Navier-Stokes equations started with the works of Hale and Raugel [10, 11], Raugel and Sell [22] who studied 3d nonlinear equations and NavierStokes equations in thin domains. J. Roh[23], a student of Sell, generalized the previous works to thin domains of the form $\Omega_{g}=\Omega \times(0, g)$, where $g$ is some smooth

[^0]scalar function. The derived equations are called the $g$-Navier-Stokes equations. This theory have interested many researchers in recent years, see [4, 3, 13] and references therein.

On the other hand, heat conduction based on the classical Fourier law, which relates the heat flux vector and the temperature gradient, has shown its limits. The time-fractional heat conduction model can be seen as a good alternative [18, 8, 24], and references therein. Boussinesq(or Bénard) model is a combination of the heat conduction model and Navier-Stokes equations and is a well developed subject in modelling heat conducting fluids [27, 28, (9, 6]. The aim of this paper is to generalize the setting in [20, 21], where $g$-Bénard equations was considered, to time-fractional $g$-Bénard equations.

This paper is organized as follows: In the first section, we will recall some concept and notations related to fractional calculus. Section 2, is devoted to the problem statement. Section 3 will be dedicated to the proof of the existence and uniqueness of weak solutions to time-fractional $g$-Navier-Stokes equations.

## 2. Preliminaries on fractional calculus

In this section, we provide some notations and preliminary results concerning fractional calculus. For this purpose, assume $X$ to be a Banach space. Let $\alpha \in(0,1]$ and let $k_{\alpha}$ denote the Riemann-Liouville kernel

For a function $v:[0, T] \rightarrow X$, we give the following definitions of derivatives and integrals:
(1) The left Riemann-Liouville integral of $v$ is defined by

provided the integral is point-wise defined on $[0,+\infty[$
(2) The right Riemann-Liouville integral of $v$ is defined by

I_{t, T}^{\alpha} v(t)=\int_{t}^{T} k_{\alpha}(t-s) v(s) d s, \quad t>0
$$

provided the integral is point-wise defined on $[0,+\infty[$
(3) The left Caputo fractional derivative of order $\alpha$ of $v$, is defined by

$$

(4) The right Riemann-Liouville fractional derivative of order $\alpha$ of $v$ is defined by

D_{t, T}^{\alpha} v(t)=-\frac{d}{d t} \int_{t}^{T} k_{1-\alpha}(t-s) v(s) d s
$$

(5) The Liouville-Weyl fractional integral on the real axis for functions $v: \mathbb{R} \rightarrow$ $X$ is defined as follows

(6) The Caputo fractional derivative on the real axis for functions $v: \mathbb{R} \rightarrow X$ is defined as follows

D_{-, t}^{\alpha} v(t)=I_{-, t}^{1-\alpha} \frac{d}{d t} v(t)
$$

Note that the notation $\partial_{t}^{\alpha}$ stands for Caputo fractional partial derivative, i.e. when functions have another argument than time. We have the following fractional integration by parts formula; see, e.g. [1]

since for $\psi \in C_{0}^{\infty}([0, T], X)$ one have $\lim _{t \rightarrow T} I_{t, T}^{1-\alpha} \psi(t)=0$.
To pass from weak convergence to strong convergence we will need a compactness result. Let $X_{0}, X, X_{1}$ be Hilbert spaces with $X_{0} \hookrightarrow X \hookrightarrow X_{1}$ being continuous and $X_{0} \hookrightarrow X$ being compact. Assume that $v: \mathbb{R} \rightarrow X_{1}$ and denote by $\widehat{v}$ its Fourier transform

We have for $\gamma>0$

For a given $0<\gamma<1$, we introduce the following space

Clearly, it is a Hilbert space for the norm

For any set $K \subset \mathbb{R}$, we associate with it the subspace $W_{K}^{\gamma} \subset W^{\gamma}$ defined as

By similar discussion as in the proof of Theorem 2.2 in Temam [25] (see also Theorem 2.1 in [29]), it is clear that $W_{K}^{\gamma}\left(\mathbb{R}, X_{0}, X_{1}\right) \hookrightarrow L^{2}(\mathbb{R}, X)$ is compact for any bounded set $K$ and any $\gamma>0$.

As a particular situation of the compactness result discussed above, let $H, V$ be two Hilbert spaces endowed with the scalar product $(., .)_{H}$ and $(., .)_{V}$ and the norms
 dual of $V$. Moreover assume that $V \hookrightarrow H \hookrightarrow V^{\prime}$ continuously and compactly and note that the space

is compactly embedded in $L^{2}(0, T ; H)$. Similarly to Lemma 2.1 in [29], we have

for $u \in W^{\gamma}\left(0, T ; V, V^{\prime}\right)$ and $v \in H$. Moreover, for a derivable function $v:[0, T] \rightarrow V$ we have from [2] that

We end this section by the following important result
Lemma 2.1. Suppose that a nonnegative function satisfies

for $c_{1}>0$ and $c_{2}$ a nonnegative integrable function for $t \in[0, T]$. Then

For more details about fractional calculus we refer to the monographs [15, 31, 32].

## 3. Problem Statement

We introduce the usual notation used in the context of the mathematical theory of Navier-Stokes equations [25]. Let $\Omega_{g}=\Omega_{2} \times(0, g)=(0,1) \times(0,1) \times(0, g)$ where $g=g\left(y_{1}, y_{2}\right)$ is a smooth function defined on $\Omega_{2}$. In addition we assume that

Let $L^{2}(\Omega, g)$ denotes the Hilbert space, of weighted Sobolev spaces type, with the inner product

and the induced norm $|u|_{g}^{2}=\langle u, u\rangle_{g}$. Similarly, we can define the weithed Sobolev space $H^{1}(\Omega, g)$ equipped with the norm

Moreover, we will need the following spaces:

where $H_{g}$ is endowed with the inner product and the norm in $L^{2}(\Omega g)$. In addition, the spaces $V_{g}$ and $W g$ are endowed with the inner product and the norm in $H^{1}(\Omega, g)$. Let us also remark that the inclusions

are dense and continuous [19, 23. By the Riesz representation theorem, it is possible to write

Let us now define the orthogonal projection $P_{g}$ as $P_{g}: L_{p e r}^{2}(\Omega, g) \rightarrow H_{g}$. It is clear that $Q \subseteq H_{g}^{\perp}$. Similarly, we define $\widetilde{P}_{g}$ as $\widetilde{P}_{g}: L_{p e r}^{2}(\Omega, g) \rightarrow W_{g}$. By taking into account the following equality [23]:

we define the $g$-Laplace operator and $g$-Stokes operator as follows

respectively. We have the following result [23]:
Proposition 3.1. For the $g$-Stokes operator $A_{g}$, the followings hold:
(1) The $g$-Stokes operator $A_{g}$ is a positive, self-adjoint operator with compact inverse, where the domain of $A_{g}$ is $D\left(A_{g}\right)=V_{g} \cap H^{2}(\Omega, g)$.
(2) There exist countable eigenvalues of $A_{g}$ satisfying

where $\lambda_{1}$ is the smallest eigenvalue of $A_{g}$. In addition, there exist the corresponding collection of eigenfunctions $\left\{w_{i}\right\}_{i \in \mathbb{N}}$ forms an orthonormal basis for $H_{g}$.

The operators $A_{g}$ and $P_{g}$ are clearly self-adjoint, then by using integration by parts we have:

It then follows that for $u \in V_{g}$ we can write $\left|A^{1 / 2} u\right|_{g}=|\nabla u|_{g}=\|u\|_{g}$. On the other hand, since the functional

is a continuous linear mapping on $W_{g}$, we can define a continuous linear mapping $\widetilde{A}_{g}$ on $W_{g}^{\prime}$ such that

for all $\theta \in W_{g}$. For $u, v$ and $w$ laying in an appropriate subspaces of $L_{p e r}^{2}(\Omega, g)$, we can define the bilinear operator

As a consequence, one obtains $b_{g}(u, v, w)=-b_{g}(u, w, v)$ which implies that $b_{g}(u, v, v)=$ 0 . MOreover, we have the following inequality satisfied by $b_{g}$ (see [25, 26]),

We denote the operators $C_{g} u=P_{g}\left[\frac{1}{g}(\nabla g \cdot \nabla) u\right]$ and $\widetilde{C}_{g} \theta=\widetilde{P}_{g}\left[\frac{1}{g}(\nabla g \cdot \nabla) \theta\right]$ such that

We can now rewrite the system of $g$-Bénard equations in the following abstract time-fractional evolutionary equations

We give the following two lemmas and for the proofs of these lemmas we refer to [4, ?].
Lemma 3.2. For $n=2$ there exists a positive constant $c$ such that

## 4. Existence of weak solutions

Definition 4.1. A pair of functions $\{u, \theta\}$ is called a weak solution of the system (3.3) if $u \in L^{2}\left(0, T ; V_{g}\right)$ and $\theta \in L^{2}\left(0, T ; W_{g}\right)$ satisfy the following equations

\partial_{t}^{\alpha}(\theta, \tau)_{g}+\widetilde{b}_{g}(u, \theta, \tau)+\kappa(\nabla \theta, \nabla \tau)_{g}+\kappa \widetilde{b}_{g}\left(\frac{\nabla g}{g}, \tau, \theta\right)=\left(f_{2}, v\right)_{g} \tag{4.1}

for all $v_{2} \in V_{g}$ and $\tau \in W_{g}$.
Theorem 4.2. If $f_{1} \in L^{\frac{2}{\alpha_{1}}}\left(0, T ; L^{2}(\Omega, g)\right)$ and $f_{2} \in L^{\frac{2}{\alpha_{2}}}\left(0, T ; L^{2}(\Omega, g)\right)\left(\alpha_{1}, \alpha_{2}<\right.$ $\alpha), u_{0} \in H_{g}, \theta_{0} \in L^{2}(\Omega, g)$ and $g$ is a smooth function satisfying the conditions given in (3.1) defined on $\Omega_{2}$ then, there exist a unique weak solution $\{u, \theta\}$ of the system (3.3) satisfying the periodic boundary conditions.

For the proof of the theorem, we shall use the standard Feado- Galerkin method.
Proof. Since $V_{g}$ is separable and $\mathcal{V}_{1}$ is dense in $V_{g}$, there exists a sequence $\left\{u_{i}\right\}_{i \in \mathbb{N}}$ which forms a complete orthonormal system in $H_{g}$ and a base for $V_{g}$. Similarly, there exists a sequence $\left\{\theta_{i}\right\}_{i \in \mathbb{N}}$ which forms a complete orthonormal system in $L^{2}(\Omega, g)$ and a base for $W_{g}$. Let $m$ be an arbitrary but fixed positive integer. For each $m$, we define an approximate solution $\left\{u^{(m)}(t), \theta^{(m)}(t)\right\}$ of (3.3) for $1 \leq k \leq m$ and $t \in[0, T]$ in the form,

\int_{0}^{T}\left\|F_{m}^{u}(t)\right\|_{V_{g}^{\prime}} d t \leq \int_{0}^{T} c\left(|\xi|_{\infty}\left\|\theta^{(m)}(t)\right\|_{g}+\left\|f_{1}(t)\right\|_{V_{g}^{\prime}}+\left|u^{(m)}(t)\right|_{g}\left\|u^{(m)}\right\|_{g}\right. \\
\left.+\left\|u^{(m)}(t)\right\|_{g}+|\nabla g|_{\infty}\left\|u^{(m)}(t)\right\|_{g}\right) d t \\
\int_{0}^{T}\left\|F_{m}^{\theta}(t)\right\|_{W_{g}^{\prime}} d t \leq \int_{0}^{T} c^{\prime}\left(\left\|f_{2}(t)\right\|_{W_{g}^{\prime}}+\left|u^{(m)}(T)\right|_{g}\left\|\theta^{(m)}(t)\right\|_{g}+\left\|\theta^{(m)}(t)\right\|_{g}\right.  \tag{4.37}\\
\left.+|\nabla g|_{\infty}\left\|\theta^{(m)}(t)\right\|_{g}+|\Delta g|_{\infty}\left\|\theta^{(m)}(t)\right\|_{g}\right) d t

remains bounded, $\left\|F_{1}(t)\right\|_{V_{g}^{\prime}}$ and $\left\|F_{2}(t)\right\|_{W_{g}^{\prime}}$ are bounded in $L^{1}\left(0, T ; V_{g}^{\prime}\right)$ and $L^{1}\left(0, T ; W_{g}^{\prime}\right)$ respectively. Therefore, for all $m$

Moreover, since $u^{(m)}(0), u^{(m)}(T), \theta^{(m)}(0)$ and $\theta^{(m)}(T)$ are bounded, we get

For $\gamma$ fixed, $\gamma<\alpha / 4$, we observe that

& \quad+c_{7}(\gamma) \int_{-\infty}^{+\infty} \frac{|\tau|^{\alpha-1}}{1+|\tau|^{\alpha-2 \gamma}}\left\|\widehat{u}^{(m)}(\tau)\right\|_{V_{g}}^{2} d \tau \\

By Parseval inequality, the first integral is bounded as $m \rightarrow \infty$. Applying the Schwartz inequality, the second integrals yield to

The first integrals are finite due to $\gamma<\alpha / 4$. On the other hand, it follows from the Parseval equality that

& \leq\left(\frac{T^{1-\alpha}}{\Gamma(2-\alpha)}\right)^{2} \int_{0}^{T}\left\|u^{(m)}(t)\right\|_{V_{g}}^{2} d t \\
\int_{-\infty}^{+\infty}|\tau|^{2 \alpha-2}\left\|\widehat{\theta}^{(m)}(\tau)\right\|_{g}^{2} d \tau & \leq\left(\frac{T^{1-\alpha}}{\Gamma(2-\alpha)}\right)^{2} \int_{0}^{T}\left\|\theta^{(m)}(t)\right\|_{W_{g}}^{2} d t
\end{aligned}

Which implies that (4.19) and (4.20) holds. We know that subsequence of $\left\{u^{(m)}\right\}_{m}$ and $\left\{\theta^{(m)}\right\}_{m}$ (which we will denote with the same symbol) converge to some $u$ weakly in $L^{2}\left(0, T ; V_{g}\right)$ and weak-star in $L^{\infty}\left(0, T ; H_{g}\right)$ with $u \in L^{2}\left(0, T ; V_{g}\right) \cap$ $L^{\infty}\left(0, T ; H_{g}\right)$. Similarly there exists a subsequence of $\left\{\theta^{(m)}\right\}_{m}$ (which we will denote with the same symbol) converge to some $\theta$ weakly in $L^{2}\left(0, T ; W_{g}\right)$ and weak-star in $L^{\infty}\left(0, T ; L^{2}(\Omega, g)\right)$ with $\theta \in L^{2}\left(0, T ; W_{g}\right) \cap L^{\infty}\left(0, T ; L^{2}(\Omega, g)\right)$. As $W^{\gamma}\left(0, T, V_{g} ; H_{g}\right)$ is compactly embedded in $L^{2}\left(0, T ; H_{g}\right)$ and $W^{\gamma}\left(\mathbb{R}, W_{g}, L^{2}(\Omega, g)\right)$ in $L^{2}\left(0, T ; L^{2}(\Omega, g)\right)$ then $\left\{u^{(m)}\right\}_{m}$ strongly converges in $L^{2}\left(0, T ; H_{g}\right)$ and $\left\{\theta^{(m)}\right\}_{m}$ in $L^{2}\left(0, T ; L^{2}(\Omega, g)\right)$ respectively.

In order to pass to the limit, we consider the scalar functions $\Psi_{1}(t)$ and $\Psi_{2}(t)$ continuously differentiable on $[0, T]$ and such that $\Psi_{1}(T)=0$ ve $\Psi_{2}(T)=0$. We multiply (4.3) and (4.4) by $\Psi_{1}(t)$ and $\Psi_{2}(t)$ respectively and then integrate by
parts. This leads to the equations

& \quad+\nu \int_{0}^{T}\left(\left(u^{(m)}(t), \Psi_{1} u_{k}\right)\right)_{g}+\nu \int_{0}^{T} b_{g}\left(\frac{\nabla g}{g}, u^{(m)}(t), \Psi_{1} u_{k}\right) d t=\left(u_{0 m}, \mathrm{I}_{0, T}^{1-\alpha} \Psi_{2}(t) u_{k}\right)_{g} \\
& \quad+\int_{0}^{T}\left(\xi \theta^{(m)}(t), \Psi_{1} u_{k}\right)_{g} d t+\int_{0}^{T}\left(f_{1}(t), u_{k}\right)_{g} d t \\
& \int_{0}^{T}\left(\theta^{(m)}(t), \mathrm{D}_{t, T}^{\alpha} \Psi_{2}(t) \theta_{k}\right)_{g} d t+\int_{0}^{T} \widetilde{b}_{g}\left(u^{(m)}(t), \theta^{(m)}(t), \Psi_{2} \theta_{k}\right) d t \\
& \quad+\kappa \int_{0}^{T}\left(\left(\theta^{(m)}(t), \Psi_{2} \theta_{k}\right)\right)_{g} d t+\kappa \int_{0}^{T} \widetilde{b}_{g}\left(\frac{\nabla g}{g}, \theta_{k}, \Psi_{2} \theta^{(m)}(t)\right) d t=\left(\theta_{0 m}, \mathrm{I}_{0, T}^{1-\alpha} \Psi_{2}(t) \theta_{k}\right)_{g} \\
& \quad+\int_{0}^{T}\left(f_{2}(t), \Psi_{2} \theta_{k}\right)_{g} d t
\end{aligned}

Following the technique given in [7, 25, as $m \rightarrow \infty$ we obtain

& \quad+\nu \int_{0}^{T} b_{g}\left(\frac{\nabla g}{g}, u(t), \Psi_{1} u_{k}\right) d t=\left(u_{0}, \mathrm{I}_{0, T}^{1-\alpha} \Psi_{1} u_{k}\right)_{g}+\int_{0}^{T}\left(\xi \theta(t), \Psi_{1} v\right)_{g} d t+\int_{0}^{T}\left(f_{1}(t), u_{k}\right)_{g} d t  \tag{4.45}\\
& \quad \int_{0}^{T}\left(\theta(t), \mathrm{D}_{t, T}^{\alpha} \Psi_{2}(t) \theta_{k}\right)_{g} d t+\int_{0}^{T} \widetilde{b}_{g}\left(u(t), \theta(t), \Psi_{2} \theta_{k}\right) d t  \tag{4.46}\\
& \quad+\kappa \int_{0}^{T}\left(\left(\theta(t), \Psi_{2} \theta_{k}\right)\right)_{g} d t+\kappa \int_{0}^{T} \widetilde{b}_{g}\left(\frac{\nabla g}{g}, \theta_{k}, \Psi_{2} \theta(t)\right) d t=\left(\theta_{0}, I_{0, T}^{1-\alpha} \Psi_{2}(t) \theta_{k}\right)_{g} \\
& \quad+\int_{0}^{T}\left(f_{2}(t), \Psi_{2} \theta_{k}\right)_{g} d t
\end{align*}

This equations hold for $v$ and $\tau$ which are finite linear combination of $u_{k}$ and $\theta_{k}$, $k=1, \ldots, m$ and by continuity it holds for any $v$ in $V_{g}$ and $\tau \in H_{g}$. It then follows that $\{u, \theta\}$ satisfies the two first equations (3.3). To end the proof it still to check that $\{u, \theta\}$ satisfies the initial conditions $u(0)=u_{0}$ and $\theta(0)=\theta_{0}$. To do so it suffices to multiply the two first equations in (3.3) by $\Psi_{1}$ and (??) by $\Psi_{2}$ respectively and then integrate. By making use of the integration by parts and comparing with (4.44) and (4.46), one can find that

\left(u_{0}-u(0), v\right)_{g} \mathrm{I}_{0, T}^{1-\alpha} \Psi_{2}(t)=0, \quad \text { and } \quad\left(\theta_{0}-\theta(0), \tau\right)_{g} \mathrm{I}_{0, T}^{1-\alpha} \Psi_{2}(t)=0
$$

which lead to the desired result by taking a particular choice of $\Psi_{1}$ and $\psi_{2}$.
For the uniqueness of the weak solutions let $\left(u_{1}, \theta_{1}\right)$ and $\left(u_{2}, \theta_{2}\right)$ be two weak solutions with the same initial condition. Let $w=u_{1}-u_{2}$ and $\widetilde{w}=\theta_{1}-\theta_{2}$. Then we have

D_{t}^{\alpha}(\widetilde{w}, \tau)_{g}+\widetilde{b}_{g}\left(u_{1}, \theta_{1}, \tau\right)-\widetilde{b}_{g}\left(u_{2}, \theta_{2}, \tau\right)+\kappa(\nabla \widetilde{w}, \nabla \tau)_{g}+\kappa \widetilde{b}_{g}\left(\frac{\nabla g}{g}, \tau, \widetilde{w}\right)=0
\end{array}
$$

Taking $v=w(t)$ and $\tau=\widetilde{w}(t)$ one obtains,

D_{t}^{\alpha}(\widetilde{w}, \widetilde{w})_{g}+\widetilde{b}_{g}\left(u_{1}, \theta_{1}, \widetilde{w}\right)-\widetilde{b}_{g}\left(u_{2}, \theta_{2}, \widetilde{w}\right)+\kappa\left|\widetilde{A}_{g}^{1 / 2} \widetilde{w}\right|_{g}^{2}+\kappa \widetilde{b}_{g}\left(\frac{\nabla g}{g}, \widetilde{w}, \widetilde{w}\right)=0 .
\end{gathered}
$$

By applying the bounds on the terms $b_{g}, \widetilde{b}_{g}$ it then follows by Cauchy-Schwarz inequality and Gronwall like inequality that $w(t)=0$ and $\widetilde{w}(t)=0$ for all $t \geq 0$ since we have $w(0)=0$ and $\widetilde{w}(0)=0$. Thus the Theorem is proved.
