Fredholm property and essential spectrum of 3 - D Dirac operators with regular and singular potentials

Abstract

We consider the 3 - D Dirac operator with variable regular magnetic and electrostatic potentials, and singular potentials

$$\mathfrak{D}_{\boldsymbol{A},\Phi,Q_{\sin}}\boldsymbol{u}(x) = (\mathfrak{D}_{\boldsymbol{A},\Phi} + Q_{\sin})\,\boldsymbol{u}(x), x \in \mathbb{R}^3$$

where

$$\mathfrak{D}_{\boldsymbol{A},\Phi} = \sum_{j=1}^{3} \alpha_j \left(i\partial_{x_j} + A_j(x) \right) + \alpha_0 m + \Phi(x) I_4, \tag{2}$$

 $Q_{\sin} = \Gamma(s)\delta_{\Sigma}$ is the singular potential with $\Gamma(s) = (\Gamma_{ij}(s))_{i,j=1}^4$ being a 4×4 matrix and δ_{Σ} is the delta-function with support on a surface $\Sigma \subset \mathbb{R}^3$ which divides \mathbb{R}^3 on two open domains Ω_{\pm} with the common boundary Σ , \boldsymbol{u} is a vector-function on \mathbb{R}^3 with values in $\mathbb{C}^4, \alpha_j, j = 0, 1, 2, 3$ are the standard 4×4 Dirac matrices. We associate with the formal Dirac operator $\mathfrak{D}_{\boldsymbol{A},\Phi,Q_{\sin}}$ an unbounded operator $\mathcal{D}_{\boldsymbol{A},\Phi,Q_{\sin}}$ in $L^2(\mathbb{R}^3,\mathbb{C}^4)$ generated by $\mathfrak{D}_{\boldsymbol{A},\Phi}$ with domain in $H^1(\Omega_+,\mathbb{C}^4) \oplus H^1(\Omega_-,\mathbb{C}^4)$ consisting of functions satisfying transmission conditions on Σ . We consider the self-adjointness of operator $\mathcal{D}_{\boldsymbol{A},\Phi,Q_{\sin}}$ for unbounded C^2 -uniformly regular surfaces Σ , and the essential spectrum of $\mathcal{D}_{\boldsymbol{A},\Phi,Q_{\sin}}$ if Σ is a C^2 -surfaces with conic exits to infinity. As application we consider the electrostatic and Lorentz scalar δ_{Σ} -shell interactions on unbounded surfaces Σ .

Key words: Dirac operators, singular potentials, self-adjointness, essential spectrum.

1 Introduction

The Schrödinger operators with singular potentials supported on surfaces have attracted a lot of attention: for instance they are used for a description of quantum particles interacting with charged surfaces, in approximations of Hamiltonians of the propagation of electrons through thin barriers. The mathematical problems connected with formal Schrödinger operators with singular potentials

$$\mathbb{S} = -\Delta + a\delta_{\Sigma}$$

where Σ is the set of Lebesgue measure 0 in \mathbb{R}^n include the realization of the formal Schrödinger operator \mathbb{S} as an unbounded operator \mathcal{S} in the Hilbert space $L^2(\mathbb{R}^n)$ and the study of the spectral properties of \mathcal{S} .

Over the past two decades, this topic has been intensively studied and there is extensive literature devoted to this problem [3], [4], [13], [14], [16], [10], [11], [12], [9], [16], [15], [29]).

The investigation of the 3D-Dirac operators with singular potentials supported on compact closed surfaces in \mathbb{R}^3 was initiated only recently in the pioneering paper [5], where a new approach to extension theory of symmetric operators was employed. This research was continued in the papers:[23], [21], [22]. A different approach using the abstract theory of quasi-boundary triples and their Weyl functions was proposed in [13] [14].

In contrast to the indicated papers, we consider singular potentials with supports on both bounded and unbounded surfaces in \mathbb{R}^3 . Our approach to the self-adjointness of Dirac operators is based on the study of transmission problems with parameter associated with the Dirac operators. We introduce the Lopatinsky-Shapiro conditions for their invertibility for large values of the parameter, and for the a priori estimates of solutions of associated transmission problems.

Moreover we study the Fredholm properties and the essential spectrum of transmission problems associated with the Dirac operators with singular potentials with supports on compact surfaces and non-compact surfaces with conical exits to infinity. For this aim we apply the local principle [30], [31] and the limit operators method, see for instance [25], [24], [26], [27].

We consider in the paper the Dirac operators

$$\mathfrak{D}_{\boldsymbol{A},\Phi,Q_{\sin}}\boldsymbol{u}(x) = (\mathfrak{D}_{\boldsymbol{A},\Phi} + Q_{\sin})\,\boldsymbol{u}(x), x \in \mathbb{R}^3,\tag{3}$$

where \boldsymbol{u} is a vector-function on \mathbb{R}^3 with values in \mathbb{C}^4 ,

$$\mathfrak{D}_{\boldsymbol{A},\Phi}\boldsymbol{u}(x) = \left(\sum_{j=1}^{3} \alpha_j \left(i\partial_{x_j} + A_j(x)\right) + \alpha_0 m + \Phi(x)\right) \boldsymbol{u}(x), x \in \mathbb{R}^3 \qquad (4)$$

is the 3D-Dirac operator with variable regular magnetic and electrostatic potentials, $\alpha_j, j = 0, 1, 2, 3$ are the 4×4 Dirac matrices satisfying the relations

$$\alpha_j \alpha_k + \alpha_k \alpha_j = 2\delta_{jk} I_4 (j, k = 0, 1, 2, 3),$$

 I_4 is the 4×4 unit matrix, $\mathbf{A} = (A_1, A_2, A_3)$ is the variable vector-valued potential of the magnetic field \mathbf{H} , that is $\mathbf{H} = \nabla \times \mathbf{A}$, Φ is the variable electrostatic potential of the electric field \mathbf{E} , that is $\mathbf{E} = \nabla \Phi$, m is the mass of electron. We use the system of coordinates for which the Planck constant $\mathfrak{h} = 1$, the light speed c = 1, and the charge of electron e = 1. We assume that the functions $A_j, j = 1, 2, 3$, and Φ belong to $L^{\infty}(\mathbb{R}^3)$. The singular potential Q_{\sin} in (3) is $Q_{\sin} = \Gamma \delta_{\Sigma}$ where $\Gamma = (\Gamma_{ij})_{i,j=1}^4$ is a 4×4 matrix-valued function with Γ_{ij} belonging to the class $C_b^1(\Sigma)$ of continuous bounded with the first derivatives functions on Σ and δ_{Σ} is the delta-function with support on C^2 -surface $\Sigma \subset \mathbb{R}^3$ which divides \mathbb{R}^3 on two open domains Ω_{\pm} with the common boundary Σ . We assume that either Σ is a C^2 -connected compact surface or Σ is a C^2 -unbounded connected surface regular at infinity.

Let $H^1(\mathbb{R}^3, \mathbb{C}^4)$ be the Sobolev space of 4-dimensional vector-valued functions \boldsymbol{u} on \mathbb{R}^3 . We denote by $H^1(\Omega_{\pm}, \mathbb{C}^4)$ the spaces of restrictions on Ω_{\pm} functions in $H^1(\mathbb{R}^3, \mathbb{C}^4)$ and $H^1(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4) = H^1(\Omega_+, \mathbb{C}^4) \oplus H^1(\Omega_-, \mathbb{C}^4)$. We associate with the formal Dirac operator $\mathfrak{D}_{\boldsymbol{A}, \Phi, Q_{\sin}}$ an unbounded in $L^2(\mathbb{R}^3, \mathbb{C}^4)$ operator $\mathcal{D}_{\boldsymbol{A}, \Phi, a_+, a_-}$ defined by the Dirac operator $\mathfrak{D}_{\boldsymbol{A}, \Phi}$ with domain

$$dom \mathcal{D}_{\boldsymbol{A},\Phi,a_+,a_-} = H^1_{a_+,a_-}(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4)$$

$$= \left\{ \boldsymbol{u} \in H^1(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4) : a_+(s)\boldsymbol{u}_+(s) + a_-(s)\boldsymbol{u}_-(s) = 0, s \in \Sigma \right\},$$

where $\boldsymbol{u}_{\pm} = \gamma_{\Sigma}^{\pm} \boldsymbol{u}$ and $\gamma_{\Sigma}^{\pm} : H^1(\Omega_{\pm}, \mathbb{C}^4) \to H^{1/2}(\Sigma, \mathbb{C}^4)$ are the trace operators, $a_{\pm}(s)$ are 4×4 matrices defined as

$$a_{+}(s) = \frac{1}{2}\Gamma(s) - i\boldsymbol{\alpha} \cdot \boldsymbol{\nu}(s), a_{-}(s) = \frac{1}{2}\Gamma(s) + i\boldsymbol{\alpha} \cdot \boldsymbol{\nu}(s)$$
(6)

where $\boldsymbol{\alpha} \cdot \boldsymbol{\nu}(s) = \sum_{j=1}^{3} \alpha_j \nu_j(s)$, and $\boldsymbol{\nu}(s) = (\nu_1(s), \nu_2(s), \nu_3(s)), s \in \Sigma$ is the normal vector to Σ directed into Ω_- .

We associate also with the formal Dirac operator $\mathfrak{D}_{A,\Phi,Q_s}$ the operator $\mathbb{D}_{A,\Phi,a_+,a_-}$ of the transmission problem

$$\mathbb{D}_{\boldsymbol{A},\Phi,a_{+},a_{-}}\boldsymbol{u}(x) = \begin{cases} \boldsymbol{\mathfrak{D}}_{\boldsymbol{A},\Phi}\boldsymbol{u}(x), x \in \mathbb{R}^{3} \boldsymbol{\Sigma} \\ a_{+}(s)\boldsymbol{u}_{+}(s) + a_{-}(s)\boldsymbol{u}_{-}(s) = \boldsymbol{0}, s \in \boldsymbol{\Sigma} \end{cases}$$

acting from $H^1(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4)$ into $L^2(\mathbb{R}^3, \mathbb{C}^4)$.

We study in the paper the self-adjointness in $L^2(\mathbb{R}^3, \mathbb{C}^4)$ of unbounded operators $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$, the Fredholm properties of the operators $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$: $H^1(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4) \to L^2(\mathbb{R}^3, \mathbb{C}^4)$, and the essential spectra of operators $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$.

The paper is organized as follows. In Sec.2 we introduce the necessary notations and definitions. In Sec.3 we describe the realization of formal Dirac operators with singular potentials as unbounded operators $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ in $L^2(\mathbb{R}^3,\mathbb{C}^4)$ and also as bounded operators $\mathfrak{D}_{\mathbf{A},\Phi,a_+,a_-}$ of transmission problems (7), and we study the conditions of self-adjointness of $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$. Our approach is closed to the classical approach to proof of self-adjointness of realizations of boundary value problems in Hilbert space (see for instance [1], [20]). We introduced an analogue of the Lopatinsky-Shapiro condition on Σ for the operator $\mathfrak{D}_{\mathbf{A},\Phi,a_+,a_-}$, which yields the a priori estimate

$$\|u\|_{H^1(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4)} \le C\left(\|\mathfrak{D}_{\boldsymbol{A}, \Phi} u\|_{L^2(\mathbb{R}^3, \mathbb{C}^4)} + \|u\|_{L^2(\mathbb{R}^3, \mathbb{C}^4)}\right)$$
(8)

for compact C^2 -surfaces and noncompact C^2 -surfaces with regular boundary. It should be noted that the estimate (8) yields the closedness of $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ in $L^2(\mathbb{R}^n,\mathbb{C}^4)$. We also consider the parameter dependent operator

$$\mathbb{D}_{\boldsymbol{A},\Phi,a_{+},a_{-}}(\mu) = \begin{cases} (\mathfrak{D}_{\boldsymbol{A},\Phi} - i\mu I_{4}) \boldsymbol{u}(x), x \in \mathbb{R}^{3} \setminus \Sigma, \mu \in \mathbb{R} \\ a_{+}(s)\boldsymbol{u}_{+}(s) + a_{-}(s)\boldsymbol{u}_{-}(s) = \boldsymbol{0}, s \in \Sigma \end{cases},$$
(9)

and give the uniform Lopatinsky-Shapiro conditions of the invertibility of

$$\mathbb{D}_{\boldsymbol{A},\Phi,a_+,a_-}(\mu):H^1(\mathbb{R}^3\diagdown\Sigma,\mathbb{C}^4)\to L^2(\mathbb{R}^3,\mathbb{C}^4)$$

for $|\mu|$ large enough. This conditions are applied for the study of self-adjointness of $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$.

As the example we consider the operator $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ associated with the singular potential describing the electrostatic and Lorentz shall interactions. The uniform Lopatinsky-Shapiro condition for $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ is satisfied if

$$\inf_{s \in \Sigma} \left| \eta^2(s) - \tau^2(s) - 4 \right| > 0.$$

Note that the unbounded operator $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ associated with the potential (??) has been considered earlier in the paper [14] for compact closed surface and real constants η, τ . In this paper the authors proved that the condition $\eta^2 - \tau^2 \neq 4$ is sufficient for self-adjointness of $\mathcal{D}_{\mathbf{0},0,a_+,a_-}$. They also considered the degenerated case $\eta^2 - \tau^2 = 4$.

In Sec. 4 we study the essential spectrum of the operator $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ for the cases: Σ is either a C^2 -compact surface or a C^2 -surface with conic structure at infinity. This problem is closely connected with the Fredholm properties of the operator $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ of transmission problem acting from $H^1(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4) \to L^2(\mathbb{R}^3, \mathbb{C}^4)$. Our approach to the investigation of Fredholmness is based on the local principle see (see for instance [30], [31]) and the limit operators method (see for instance [28], [29], [27]).

As the corollary, we obtain the descriptions of the essential spectra of unbounded operators $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ as the union of spectra of all limit operators. It should be noted that the conditions of the Fredholmness of $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ and the location of the essential spectrum of $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ substantial depend on the behavior at infinity of the regular potentials \mathbf{A},Φ , the surface Σ , and the matrix Γ .

2 Notations

- If X, Y are Banach spaces then we denote by $\mathcal{B}(X, Y)$ the space of bounded linear operators acting from X into Y with the uniform operator topology, and by $\mathcal{K}(X, Y)$ the subspace of $\mathcal{B}(X, Y)$ of all compact operators. In the case X = Y we write shortly $\mathcal{B}(X)$ and $\mathcal{K}(X)$.
- An operator $A \in \mathcal{B}(X, Y)$ is called a Fredholm operator if $kerA = \{x \in X : Ax = 0\}$, and $cokerA = Y/\operatorname{Im} A$ are finite dimensional spaces. Let \mathcal{A} be a closed unbounded operator in a Hilbert space \mathcal{H} with a dense in \mathcal{H} domain $dom\mathcal{A}$. Then \mathcal{A} is called a Fredholm operator if $ker\mathcal{A} = \{x \in dom\mathcal{A} : \mathcal{A}x = 0\}$ and $coker\mathcal{A} = \mathcal{H}/\operatorname{Im} \mathcal{A}$ where $\operatorname{Im} \mathcal{A} = \{y \in \mathcal{H} : y = \mathcal{A}x, x \in \mathcal{D}_{\mathcal{A}}\}$ are finite-dimensional spaces. Note that \mathcal{A} is a Fredholm operator as unbounded operator in \mathcal{H} if and only if $\mathcal{A} : \mathcal{D}_{\mathcal{A}} \to \mathcal{H}$ is a Fredholm operator

as a bounded operator where $dom \mathcal{A}$ is equipped by the graph norm

$$\left\|u\right\|_{dom\mathcal{A}} = \left(\left\|u\right\|_{\mathcal{H}}^{2} + \left\|\mathcal{A}u\right\|_{\mathcal{H}}^{2}\right)^{1/2}, u \in dom\mathcal{A}$$

(see for instance [1]).

- The essential spectrum $sp_{ess}\mathcal{A}$ of an unbounded operator \mathcal{A} is a set of $\lambda \in \mathbb{C}$ such that $\mathcal{A} \lambda I$ is not Fredholm operator as unbounded operator, and the discrete spectrum $sp_{dis}\mathcal{A}$ of \mathcal{A} is a set of isolated eigenvalues of finite multiplicity. It is well known that if \mathcal{A} is a self-adjoint operator then $sp_{dis}\mathcal{A}=sp\mathcal{A} \setminus sp_{ess}\mathcal{A}$.
- We denote by $L^2(\mathbb{R}^3, \mathbb{C}^4)$ the Hilbert space of 4-dimensional vectorfunctions $\boldsymbol{u}(x) = (u^1(x), u^2(x), u^3(x), u^4(x)), x \in \mathbb{R}^3$ with the scalar product

$$\langle u, v \rangle = \int_{\mathbb{R}^3} \boldsymbol{u}(x) \cdot \boldsymbol{v}(x) dx$$

where $\boldsymbol{u} \cdot \boldsymbol{v} = \sum_{j=1}^{4} u_j \bar{v}_j$.

• We denote by $H^s(\mathbb{R}^3, \mathbb{C}^4)$ the Sobolev space on \mathbb{R}^3 of 4-dimensional vector-valued functions, that is the space of distributions $u \in \mathcal{D}'(\mathbb{R}^3, \mathbb{C}^4)$ such that

$$\|\boldsymbol{u}\|_{H^{s}(\mathbb{R}^{3},\mathbb{C}^{4})} = \left(\int_{\mathbb{R}^{3}} (1+|\xi|^{2})^{s} \|\hat{\boldsymbol{u}}(\xi)\|_{\mathbb{C}^{4}}^{2} d\xi\right)^{1/2} < \infty, s \in \mathbb{R}$$

where $\hat{\boldsymbol{u}}$ is the Fourier transform of \boldsymbol{u} . If Ω is a domain in \mathbb{R}^3 then $H^s(\Omega, \mathbb{C}^4)$ is the space of restrictions of $\boldsymbol{u} \in H^s(\mathbb{R}^3, \mathbb{C}^4)$ on Ω with the norm

$$\|\boldsymbol{u}\|_{H^{s}(\Omega,\mathbb{C}^{4})} = \inf_{l\boldsymbol{u}\in H^{s}(\mathbb{R}^{3},\mathbb{C}^{4})} \|l\boldsymbol{u}\|_{H^{s}(\mathbb{R}^{3},\mathbb{C}^{4})}$$

where $l\boldsymbol{u}$ is an extension of \boldsymbol{u} on \mathbb{R}^3 .

- We denote by $C_b(\mathbb{R}^3), C_b(\Sigma)$ the classes of bounded continuous functions on \mathbb{R}^3, Σ , and by $C_b^m(\mathbb{R}^3), C_b^m(\Sigma)$ the classes of functions a on \mathbb{R}^3 such that $\partial^{\alpha} a \in C_b(\mathbb{R}^3), C_b(\Sigma)$ for all multiindices $\alpha : |\alpha| \leq m$.
- Let Ω_{\pm} be domains in \mathbb{R}^3 and Σ be a C^2 surface being their common boundary. We say that Σ is *uniformly regular* if : (i) There exists r > 0 such that for every point $x_0 \in S$ there exists a ball $B_r(x_0) = \{x \in \mathbb{R}^3 : |x x_0| < r\}$ and the diffeomorphism $\varphi_{x_0} : B_r(x_0) \to B_1(0)$ such that

$$\varphi_{x_0} \left(B_r(x_0) \cap \Omega_{\pm} \right) = B_1(0) \cap \mathbb{R}^3_{\pm}, \mathbb{R}^3_{\pm} = \left\{ y = (y', y_3) \in \mathbb{R}^3 : y_3 \ge 0 \right\}, \varphi_{x_0} \left(B_r(x_0) \cap \Sigma \right) = B_1(0) \cap \mathbb{R}^2_{y'}, \mathbb{R}^2_{y'} = \left\{ y = (y', y_3) \in \mathbb{R}^3 : y_3 = 0 \right\};$$

(ii) Let $\varphi^i_{x_0}, i=1,2,3$ be the coordinate functions of the mappings $\varphi.$ Then

$$\sup_{x_0 \in S} \sup_{|\alpha| \le 2, x \in B_r(x_0)} \left| \partial^{\alpha} \varphi^i_{x_0}(x) \right| < \infty, i = 1, 2, 3.$$

Note that compact closed C^2 -surfaces are uniformly regular automatically.

• Let

$$\mathfrak{D}_0 = \boldsymbol{\alpha} \cdot \boldsymbol{D}_x + \alpha_0 m = \sum_{j=1}^3 \alpha_j D_{x_j} + \alpha_0 m, D_{x_j} = i \partial_{x_j}$$

be the free Dirac operator (see for instance [17], [?], [32], [7]) where $\boldsymbol{\alpha} = (\alpha_1, \alpha_2, \alpha_3), \alpha_j, j = 0, 1, 2, 3$ are the 4 × 4 Dirac matrices

$$\alpha_0 = \begin{pmatrix} I_2 & 0\\ 0 & -I_2 \end{pmatrix}, \alpha_j = \begin{pmatrix} 0 & \sigma_j\\ \sigma_j & 0 \end{pmatrix}, j = 1, 2, 3, \tag{11}$$

$$\sigma_1 = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}, \sigma_2 = \begin{pmatrix} 0 & -i \\ i & 0 \end{pmatrix}, \sigma_3 = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}$$
(12)

are the 2×2 Pauli matrices satisfying the relations

$$\sigma_j \sigma_k + \sigma_k \sigma_j = 2\delta_{jk} I_2, j, k = 1, 2, 3.$$

$$(13)$$

Relations (13) yield that

$$\alpha_j \alpha_k + \alpha_k \alpha_j = 2\delta_{jk} I_4, j, k = 0, 1, 2, 3, \tag{14}$$

where I_n is the $n \times n$ unit matrix. Equality (14) implies that

$$\left(\boldsymbol{\alpha}\cdot\boldsymbol{D}_{x}\right)^{2}=-\Delta I_{4}$$

where Δ is 3D-Laplacian. Moreover

$$\mathfrak{D}_0^2 = \left(-\Delta + m^2\right) I_4.$$

It is well-known that the unbounded operator \mathfrak{D}_0 with domain $H^1(\mathbb{R}^3, \mathbb{C}^4)$ is self-adjoint in $L^2(\mathbb{R}^3, \mathbb{C}^4)$ (see for instance [32]), and

$$sp\mathfrak{D}_0 = sp_{ess}\mathfrak{D}_0 = (-\infty, -|m|] \bigcup [|m|, +\infty).$$

3 Realization of Dirac operators with singular potentials as unbounded operators in $L^2(\mathbb{R}^3, \mathbb{C}^4)$

Let $\mathfrak{D}_{\boldsymbol{A},\Phi,Q_{\sin}} = \mathfrak{D}_{\boldsymbol{A},\Phi} + Q_{\sin}$ be the Dirac operator given by formulas (3),(4). We define the product $Q_{\sin}\boldsymbol{u}$ where $Q_{\sin} = \Gamma \delta_{\Sigma}$ and $\boldsymbol{u} \in H^1(\mathbb{R}^3 \backslash \Sigma, \mathbb{C}^4)$ as a distribution in $\mathcal{D}'(\mathbb{R}^3, \mathbb{C}^4) = \mathcal{D}'(\mathbb{R}^3) \otimes \mathbb{C}^4$ acting on the test functions $\varphi \in C_0^{\infty}(\mathbb{R}^3, \mathbb{C}^4)$ as (see [19])

3.1 Lopatinsky-Shapiro conditions

We consider the Lopatisky condition for the transmission operator $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ at the points $x \in \Sigma$ which provides the local a priory estimates on Σ for the operator $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ This condition is an analogue of the Lopatinsky-Shapiro condition for elliptic boundary value problems (see for instance [1],[20]).

Invariance of the Dirac operator with respect to the orthogonal transformations of the coordinate systems in \mathbb{R}^3 allows us to consider $\mathfrak{D}_{A,\Phi,a_+,a_-}$ in the local system of coordinates $y = (y_1, y_2, y_3)$ where the axis y_1, y_2 belong to tangent plane to Σ at the point x_0 and the axis $y_3 = z$ is directed along the normal vector $\boldsymbol{\nu}$ to Σ at the point $x_0 \in \Sigma$.

After to passing to the local system of coordinates and taking into account the main part of the operator $\mathfrak{D}_{A,\Phi}^{0}$ we obtain the operator $\mathbb{D}_{a_{+}(x_{0}),a_{-}(x_{0})}^{0}$ of the transmission problem for the half-spaces $\mathbb{R}^{3}_{\pm} = \{y = (y', y_{3}) \in \mathbb{R}^{3} : y_{3} \geq 0\}$

Proof. The proof of the a priori estimate (45) is based on the local a priori estimates following from the uniform ellipticity on \mathbb{R}^3 of Dirac operator $\mathfrak{D}_{A,\Phi}$ and the uniform Lopatinsky-Shapiro conditions. For the gluing of local estimates we use a countable partition of the unity of finite multiplicity. The uniform ellipticity of $\mathfrak{D}_{A,\Phi}$ yields that there exists a small enough r > 0 such that for every point $x_0 \in \mathbb{R}^3 \setminus \Sigma$ there exists a ball $B_r(x_0) = \{x \in \mathbb{R}^3 : |x - x_0| < r\}$ such that the local a priory estimate

holds for every $u \in H^1(B_r(x_0), \mathbb{C}^4)$ with a constant C > 0 independent of $x_0 \in \mathbb{R}^3 \setminus \Sigma$. The uniform Lopatinsky-Shapiro condition yields that for small enough r > 0 independent of $x_0 \in \Sigma$ there exists the local a priori estimates at every point $x_0 \in \Sigma$

subordinated to the countable covering $\bigcup_{j=1}^{\infty} B_r(x_j)$ of finite multiplicity such that a priori estimates (46) or (47) hold for all points $x_0 = x_j$ with a constant C > 0 independent of $j \in \mathbb{N}$. We obtain a priori estimate (45) gluing these estimates by means of partition of unity (48).

3.4 Parameter-dependent transmission problems associated with Dirac operators with singular potentials

We consider the invertibility of the parameter-dependent operator

acting from $H^1(\mathbb{R}^3 \setminus \Gamma, \mathbb{C}^4)$ in $L^2(\mathbb{R}^3, \mathbb{C}^2)$ for large value of $|\mu|$. We will apply the local approach following to the well-known paper [2]). Let $\mathfrak{D}^0_{\boldsymbol{A},\Phi}(\mu) = \boldsymbol{\sigma} \cdot \boldsymbol{D} - i\mu I_4$ is the main part of the parameter-dependent operator $\mathfrak{D}_{\boldsymbol{A},\Phi} - i\mu I_2$. For the local estimates at the points $x_0 \in \Sigma$ we use the local system of orthogonal coordinates $y = (y_1, y_2)$ where the axis y_1 is directed along the tangent to Σ at the point $x_0 \in \Sigma$ and the axis $y_3 = z$ is directed along the normal vector $\boldsymbol{\nu}_{x_0}$ to Σ at the point $x_0 \in \Sigma$, and we take the main part of $\mathfrak{D}_{\boldsymbol{A},\Phi}(\mu)$. Then we obtain the operator

We investigate the invertibility of $\mathbb{D}^0_{a_+(x_0),a_-(x_0)}(\mu)$ acting from $H^1(\mathbb{R}^3_+, \mathbb{C}^4) \oplus$ $H^1(\mathbb{R}^3_-, \mathbb{C}^4)$ into $L^2(\mathbb{R}^3, \mathbb{C}^4)$. Applying the Fourier transform with respect to $\mathbf{y}' = (y_1, y_2) \in \mathbb{R}^2$ we obtain the family of 1 - D parameter-dependent transmission problems on $\mathbb{R} \setminus \{0\}$

Hence $\mathbb{D}^{0}_{a_{+}(x_{0}),a_{-}(x_{0})}(\xi',\mu)$ is invertible if and only if ker $\mathfrak{B}_{a_{+}(x_{0}),a_{-}(x_{0})}(\xi',\mu) = 0$ for all $(\xi',\mu): |\xi'|^{2} + \mu^{2} > 0$. We consider solutions of the equation

Theorem 3 Let $\Sigma \subset \mathbb{R}^3$ be a C^2 -uniformly regular surface, the magnetic potential $\mathbf{A} = (A_1, A_2, A_3) \in L^{\infty}(\mathbb{R}^3, \mathbb{C}^3)$, the electrostatic potential $\Phi \in L^{\infty}(\mathbb{R})$, $\Gamma \in C_b^1(\Sigma, \mathcal{B}(\mathbb{C}^4))$, and the uniformly Lopatinsky-Shapiro condition (63) for parameter-dependent operator $\mathbb{D}_{\mathbf{A}, \Phi, a_+, a_-}(\mu), \mu \in \mathbb{R}$ be satisfied. Then there exists $\mu_0 > 0$ such that the operator $\mathbb{D}_{\mathbf{A}, \Phi, a_+, a_-}(\mu) : H^1(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4) \to L^2(\mathbb{R}^3, \mathbb{C}^4)$ is invertible for every $\mu \in \mathbb{R} : |\mu| > \mu_0$.

Proof. The proof is similar to the proof of invertibility of elliptic parameterdependent boundary value problems (see for instance [2],[1], Sec.3). However, we consider the parameter-dependent transmission problems for unbounded domains, and therefore we need an infinite partition of unity and estimates associated with this fact. Note that the Dirac operator $\mathfrak{D}_{\mathbf{A},\Phi}(i\mu)$ is a uniformly elliptic parameter-depending operator on \mathbb{R}^3 . Moreover, the Lopatinsky-Shapiro condition (64) are satisfied uniformly for every point $x \in \Sigma$. It yields that there exists r > 0 and $\mu_0 > 0$ such that there exists a countable covering $\cup_{j \in \mathbb{N}} B_r(x_j)$ of the finite multiplicity $N \geq 1$ such that for every x_j there exist operators

is invertible for large values of $|\mu|$.

3.5 Self-adjointness of the operator $\mathcal{D}_{A,\Phi,a_+,a_{h-}}$

Now we consider the self-adjointness of the unbounded operator $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ in $L^2(\mathbb{R}^3,\mathbb{C}^4)$ defined by the Dirac operator

are the scalar products in $L^2(\mathbb{R}^3, \mathbb{C}^4), L^2(\Sigma, \mathbb{C}^4)$, respectively.

Theorem 5 Let $\Sigma \subset \mathbb{R}^3$ be the C^2 -uniformly regular surface, the vector potential $\mathbf{A} \in L^{\infty}(\mathbb{R}^3, \mathbb{R}^4)$ and the scalar potential $\Phi \in L^{\infty}(\mathbb{R}^3)$ be real-valued, and $\Gamma = (\Gamma_{ij})_{i,j=1}^4$ be the Hermitian matrix with elements $\Gamma_{ij} \in C_b^1(\Sigma)$. We assume that the uniform Lopatinsky-Shapiro conditions (63) for the parameterdependent problem holds. Then the operator $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ with domain $H^1_{a_+,a_-}(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4)$ is self-adjoint in $L^2(\mathbb{R}^3, \mathbb{C}^4)$.

Proof. At first, we prove that the operator $\mathcal{D}_{A,\Phi,a_+,a_-}$ is symmetric. Let $u, v \in H^1_{a_+,a_-}(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4)$. Integrating by parts we obtain

Thaking into account equality (18) we obtain that

$$= -\frac{1}{4} \langle \Gamma \left(\boldsymbol{u}_{+} + \boldsymbol{u}_{-} \right), \boldsymbol{v}_{+} - \boldsymbol{v}_{-} \rangle_{L^{2}(\Sigma, \mathbb{C}^{4})} + \frac{1}{4} \langle \boldsymbol{u}_{+} + \boldsymbol{u}_{-}, \Gamma \left(\boldsymbol{v}_{+} - \boldsymbol{v}_{-} \rangle_{L^{2}(\Sigma, \mathbb{C}^{4})} \right).$$

Since the matrix Γ is Hermitian for every $s \in \Sigma$ the right part side in (73) is 0. Hence

for every $\boldsymbol{u}, \boldsymbol{v} \in H^1_{a_+,a_-}(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4)$. The uniform Lopatinsky-Shapiro condition (63) yields a priori estimate (45) which implies that the operator $\mathcal{D}_{\boldsymbol{A},\Phi,a_+,a_-}$ is closed. Moreover, Theorem 3 yields that the deficiency indices of $\mathcal{D}_{\boldsymbol{A},\Phi,a_+,a_-}$ are equal 0. Hence (see for instance [6], page 100) the operator $\mathcal{D}_{\boldsymbol{A},\Phi,a_+,a_-}$ is self-adjoint.

3.5.1 Self-adjointness of Dirac operator with electrostatic and Lorentz $\delta-{\rm shell}$ interactions

As application of Theorem 5 we consider the Dirac operator with singular potential

of the electrostatic and Lorentz δ -shell interactions.

Theorem 6 Let Σ be a uniformly regular C^2 -surface. We assume that the vector potential $\mathbf{A} \in L^{\infty}(\mathbb{R}^3, \mathbb{R}^4)$, the scalar potential $\Phi \in L^{\infty}(\mathbb{R}^3)$ and real-valued, the function $\eta(s), \tau(s) (\in C_b^1(\Sigma))$ are real valued. Moreover, we assume that

$$\inf_{s \in S} \left| \eta^2(s) - \tau^2(s) - 4 \right| > 0.$$
(74)

Then the unbounded operator $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ defined by the Dirac operator $\mathfrak{D}_{\mathbf{A},\Phi}$ with domain $H^1_{a_+,a_-}(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4)$ where $a_{\pm}(s) = \eta(s)I_4 + \tau(s)\alpha_0 \mp i \boldsymbol{\alpha} \cdot \boldsymbol{\nu}(s), s \in \Sigma$ is self-adjoint in $L^2(\mathbb{R}^3, \mathbb{C}^4)$.

Proof. We set in Example $4 \gamma = \eta + \tau, \kappa = \eta - \tau$. Applying condition (72) we obtain that (74) is the uniform Lopatinsky-Shapiro condition $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$. It should be noted that condition (74) ensures the fulfillment of the uniform Lopatinsky-Shapiro condition for the operator $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}(\mu)$ of parameter-dependent transmission problem associated with potential $Q_{\sin}(s) = (\eta(s) + \tau(s))\delta_{\Sigma}$. Moreover, the unbounded operator $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ with domain $H^1_{a_+,a_-}(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4)$ is symmetric in $L^2(\mathbb{R}^3, \mathbb{C}^4)$. Hence Theorem 6 yields that $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ is a self-adjoint operator.

4 Fredholm theory of transmission problems associated with Dirac operator with singular potentials

We consider the Fredholm property of the transmission operator

$$\mathbb{D}_{\boldsymbol{A},\Phi,a_{+},a_{-}}\boldsymbol{u}(x) = \begin{cases} \boldsymbol{\mathfrak{D}}_{\boldsymbol{A},\Phi}\boldsymbol{u}(x), x \in \mathbb{R}^{3} \boldsymbol{\Sigma}, \\ a_{+}(s)\boldsymbol{u}_{+}(s) + a_{-}(s)\boldsymbol{u}_{-}(s) = \boldsymbol{0}, s \in \boldsymbol{\Sigma}; \end{cases}$$
(75)

associated with the Dirac operator with singular potential $\mathfrak{D}_{A,\Phi,Q_{\sin}} = \mathfrak{D}_{A,\Phi} + Q_{\sin}$ where

$$\mathfrak{D}_{\boldsymbol{A},\Phi}\boldsymbol{u}(\boldsymbol{x}) = \left(\boldsymbol{\alpha} \cdot \left(\boldsymbol{D}_{\boldsymbol{x}} + \boldsymbol{A}(\boldsymbol{x})\right) + \alpha_0 m + \Phi(\boldsymbol{x})\right) \boldsymbol{u}(\boldsymbol{x}), \boldsymbol{x} \in \mathbb{R}^3 \backslash \Sigma \qquad (76)$$

and $Q_{\sin} = \Gamma \delta_S$. We assume that Σ is a connected C^2 -surface being the common boundary of the domains Ω_{\pm} . Moreover, Σ is a closed compact surface or unbounded uniformly regular surface.

4.1 Simonenko's local principle

- Let $\chi \in C_0^{\infty}(\mathbb{R}^n)$ be such that $0 \leq \chi(x) \leq 1, \chi(x) = 1$ for $|x| \leq 1$, and $\chi(x) = 0$ for $|x| \geq 2$, and $\chi_R(x) = \chi(\frac{x}{R}), \ \psi_R(x) = 1 - \chi_R(x)$. The function ψ_R is called the cut-off function of infinity. Let $B_{\varepsilon}(x_0) = \{x \in \mathbb{R}^n : |x - x_0| < \varepsilon\}$. We say that φ_{x_0} is a cut-off function of $B_{\varepsilon}(x_0)$ if $\varphi_{x_0} \in C_0^{\infty}(B_{\varepsilon}(x_0)), 0 \leq \varphi_{x_0}(x) \leq 1$ and $\varphi_{x_0}(x) = 1$ if $x \in B_{\varepsilon/2}(x_0)$.
- We denote by $\widetilde{\mathbb{R}^3}$ the compactification of \mathbb{R}^3 obtained by the adjoint to every ray $l_{\omega} = \left\{ x \in \mathbb{R}^3 : x = t\omega, t > 0, \omega \in S^2 \right\}$ the infinitely distant point ϑ_{ω} . The topology in $\widetilde{\mathbb{R}^3}$ is introduced such that $\widetilde{\mathbb{R}^3}$ becomes homeomorphic to the unit closed ball $\overline{B}_1(0)$. The fundamental system of neighborhoods of the point ϑ_{ω_0} is formed by the conical sets $U_{\omega_0,R} = F_{\omega_0} \times (R, +\infty)$ where R > 0 and F_{ω_0} is a neighborhood of the point ω_0 on the unit sphere S^2 . We define the cut-off function φ_{x_0} of the infinitely distant point $x_0 = \vartheta_{\omega_9}$ as $\varphi_{x_0} = \varphi_{\omega_0}(\frac{x}{|x|})\psi_R(x)$ where $\varphi_{\omega_0}(\omega) \in C_0^{\infty}(F_{\omega_0})$ and $\varphi_{\omega_0}(\omega) = 1$ in a neighborhood F'_{ω_0} such that $\overline{F'_{\omega_0}} \subset F_{\omega_0}$.

Definition 7 We say that the operator

$$\mathbb{D}_{\boldsymbol{A},\Phi,a_+,a_-}:H^1(\mathbb{R}^3 \backslash S, \mathbb{C}^4) \to L^2(\mathbb{R}^3, \mathbb{C}^4)$$

is locally invertible at the point $x_0 \in \widetilde{\mathbb{R}^3}$ if there exists a neighborhood U_{x_0} of the point x_0 and the operators

$$\mathcal{L}_{x_0}, \mathcal{R}_{x_0} \in \mathcal{B}(L^2(\mathbb{R}^3, \mathbb{C}^4), H^1(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4))$$

such that

$$\mathcal{L}_{x_0} \mathbb{D}_{\mathbf{A}, \Phi, a_+, a_-} \varphi_{x_0} I = \varphi_{x_0} I, \varphi_{x_0} \mathbb{D}_{\mathbf{A}, \Phi, a_+, a_-} \mathcal{R}_{x_0} = \varphi_{x_0} I,$$
(77)

where φ_{x_0} is the cut-off function of the point x_0 .

Proposition 8 ([31], [30]) The operator

$$\mathbb{D}_{\boldsymbol{A},\Phi,a_+,a_-}: H^1(\mathbb{R}^3 \backslash \Sigma, \mathbb{C}^4) \to L^2(\mathbb{R}^3, \mathbb{C}^4)$$

is Fredholm if and only if $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ is locally invertible at every point $x \in \widetilde{\mathbb{R}^3}$.

4.2 Transmission on compact closed surfaces

We consider the Fredholm property of the operator $\mathbb{D}_{A,\Phi,a_+,a_-}$ if Σ is a compact closed C^2 -surface.

We assume that the vector-valued potential $\mathbf{A} = (A_1, A_2, A_3)$ and the electric potentials Φ are such that

$$A_j, \Phi \in C_b^1(\mathbb{R}^3), \tag{78}$$

$$\Gamma = (\Gamma_{ij})_{i,j=1}^4, \Gamma_{ij} \in C_b^1(\Sigma).$$

Let $f \in C_b^1(\mathbb{R}^3), \mathbb{R}^3 \ni g_m \to \infty$. We consider the functional sequence $\{f(x + g_m)\}$. This sequence is uniformly bounded and eqicontinuous on every compact set $K \subset \mathbb{R}^3$. By the Arzelà–Ascoli Theorem there exists a subsequence h_m of g_m and the limit function $f^h \in C_b(\mathbb{R}^3)$ such that

$$\lim_{h_m \to \infty} \sup_{x \in K} \left| f(x+h_m) - f^h(x) \right| = 0 \tag{80}$$

for every compact set $K \subset \mathbb{R}^3$.

Since $A_j, \Phi \in C_b^1(\mathbb{R}^3)$, for every sequence $\mathbb{R}^3 \ni g_m \to \vartheta_\omega$ there exists a subsequence h_m and limit functions $A_j^h, j = 1, 2, 3, \Phi^h$ belonging to $C_b(\mathbb{R}^n)$ defined by formula (80). The operator $\mathfrak{D}_{A,\Phi}^h = \mathfrak{D}_{A^h,\Phi^h}$ is called the *limit* operator of $\mathfrak{D}_{A,\Phi}$. We denote by $Lim_{\vartheta_\omega}\mathfrak{D}_{A,\Phi}$ the set of all limit operators of $\mathfrak{D}_{A,\Phi}$ defined by sequences $h_m \to \vartheta_\omega$, and we set

$$Lim\mathfrak{D}_{\boldsymbol{A},\Phi} = \bigcup_{\vartheta_{\omega} \in \mathbb{R}^{3}_{\infty}} Lim_{\vartheta_{\omega}}\mathfrak{D}_{\boldsymbol{A},\Phi}.$$
(81)

Theorem 9 Let condition (78) hold, Σ be a C^2 -compact closed surface dividing Ω_+ and Ω_- , and Lopatinsky-Shapiro condition (35) hold at every point $s \in \Sigma$. Then $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-} : H^1(\mathbb{R}^3/\Sigma, \mathbb{C}^4) \to L^2(\mathbb{R}^3, \mathbb{C}^4)$ is the Fredholm operator if and only if all limit operators $\mathfrak{D}^h_{\mathbf{A},\Phi} \in Lim\mathfrak{D}_{\mathbf{A},\Phi}$ are invertible from $H^1(\mathbb{R}, \mathbb{C}^4)$ into $L^2(\mathbb{R}^3, \mathbb{C}^4)$.

Proof. Note that $\mathbb{D}_{A,\Phi,a_+,a_-}$ locally coinsides with $\mathfrak{D}_{A,\Phi}$ outside Σ . Because $\mathfrak{D}_{A,\Phi}$ is the elliptic operator on \mathbb{R}^3 , $\mathfrak{D}_{A,\Phi}$ is a locally invertible operator at every point $x \in \mathbb{R}^3 \setminus \Sigma$. According to the Lopatinsky-Shapiro condition (35) $\mathbb{D}_{A,\Phi,a_+,a_-}$ is a locally invertible operator at every point $x \in \Sigma$. Proposition 8 yields that $\mathbb{D}_{A,\Phi,a_+,a_-}$ is a Fredholm operator if and only if $\mathbb{D}_{A,\Phi,a_+,a_-}$ is locally invertible at every infinitely distant point $\vartheta_{\omega} \in \mathbb{R}^3_{\infty}$. The operator $\mathbb{D}_{A,\Phi,a_+,a_-}$ coincides with the operator $\mathfrak{D}_{A,\Phi}$ near every point ϑ_{ω} . Applying the results of book [25] and paper [26] we obtain that $\mathfrak{D}_{A,\Phi}$ is locally invertible at infinity if and only if all limit operators $\mathfrak{D}_{A^h,\Phi^h} \in Lim\mathfrak{D}_{A,\Phi}$ are invertible.

Corollary 10 Let conditions of Theorem 9 hold. Then

$$sp_{ess}\mathcal{D}_{\boldsymbol{A},\Phi,a_{+},a_{-}} = \bigcup_{\mathfrak{D}_{\boldsymbol{A}^{h},\Phi^{h}} \in Lim\mathfrak{D}_{\boldsymbol{A},\Phi}} sp\mathcal{D}_{\boldsymbol{A}^{h},\Phi^{h}}$$
(82)

where $\mathcal{D}_{\mathbf{A}^{h},\Phi^{h}}$ is unbounded in $L^{2}(\mathbb{R}^{3},\mathbb{C}^{4})$ generated by $\mathfrak{D}_{\mathbf{A}^{h},\Phi^{h}}$.

4.3 Slowly oscillating at infinity potentials

We say that a function $f \in C_b^1(\mathbb{R}^3)$ is slowly oscillating at infinity if

$$\lim_{x \to \infty} \partial_{x_j} f(x) = 0, j = 1, 2, 3$$

We denote the class of slowly oscillating at infinity functions by $SO^1(\mathbb{R}^3)$. Note that if $f \in SO_{\infty}(\mathbb{R}^3)$ and $\mathbb{R}^3 \ni h_m \to \infty$ is such that there exists a limit function f^h in the sense of formula (80). Then the function f^h is a constant.

We consider the operator $\mathbb{D}_{A,\Phi,a_+,a_-}$ for $A_j, \Phi \in SO^1(\mathbb{R}^3)$, and we assume that A_j, Φ are real-valued functions, Σ is the compact closed C^2 -surface, and the interaction matrix $\Gamma = (\Gamma_{ij})_{i,j=1}^4$ is such that $\Gamma_{ij} \in C^1(\Sigma)$ and real-valued functions.

Then the limit operators are of the form:

$$\mathbb{D}^{h}_{\boldsymbol{A},\Phi,a_{+},a_{-}} = \mathfrak{D}_{A^{h},\Phi^{h}} = \alpha \cdot (\boldsymbol{D} + \boldsymbol{A}^{h}) + \alpha_{0}m + \Phi^{h}I_{4}$$
(83)

where $\mathbf{A}^h \in \mathbb{R}^3, \Phi^h \in \mathbb{R}$. Note that

$$sp\mathfrak{D}_{A^{h},\Phi^{h}} = (-\infty, \Phi^{h} - |m|] \bigcup [\Phi^{h} + |m|, +\infty)$$
(84)

Then according formula (82) we obtain that

$$sp_{ess}\mathcal{D}_{\boldsymbol{A},\Phi,,a_+,a_-} = (-\infty, M_{\Phi}^{\mathrm{sup}} - |m|] \bigcup [M_{\Phi}^{\mathrm{inf}} + |m|, +\infty)$$
(85)

where

$$M_{\Phi}^{\sup} = \limsup_{x \to \infty} \Phi(x), M_{\Phi}^{\inf} = \liminf_{x \to \infty} \Phi(x).$$

Formula (85) yields that $sp_{ess}\mathcal{D}_{\mathbf{A},\Phi,,a_+,a_-}$ is independent from the slowly oscillating at infinity magnetic potential \mathbf{A} . Moreover, if |m| > 0 and $M_{\Phi}^{\text{sup}} - M_{\Phi}^{\text{inf}} < 2 |m|$, then $sp_{ess}\mathcal{D}_{\mathbf{A},\Phi,,a_+,a_-}$ has a gap $(M_{\Phi}^{\text{sup}} - |m|, M_{\Phi}^{\text{inf}} + |m|)$ which could contain the discrete spectrum of $\mathcal{D}_{\mathbf{A},\Phi,,a_+,a_-}$. In the opposite case $M_{\Phi}^{\text{sup}} - M_{\Phi}^{\text{inf}} \ge 2 |m|$

$$sp_{ess}\mathcal{D}_{\boldsymbol{A},\Phi,a_+,a_-} = (-\infty,+\infty).$$

Formula (85) yields that $sp_{ess}\mathcal{D}_{\boldsymbol{A},\Phi,,a_+,a_-}$ is independent from the slowly oscillating at infinity magnetic potential \boldsymbol{A} . Moreover, if $|m| \geq 0$ and $M_{\Phi}^{\sup} - M_{\Phi}^{\inf f} < 2|m|$, then $sp_{ess}\mathcal{D}_{\boldsymbol{A},\Phi,,a_+,a_-}$ has a gap $(M_{\Phi}^{\sup} - |m|, M_{\Phi}^{\inf} + |m|)$ in the essential spectrum which could contain the discrete spectrum of $\mathcal{D}_{\boldsymbol{A},\Phi,,a_+,a_-}$. In the opposite case: $M_{\Phi}^{\sup} - M_{\Phi}^{\inf f} \geq 2|m|$

$$sp_{ess}\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-} = (-\infty,+\infty).$$

4.4 Transmission on unbounded surfaces with conic structure at infinity

Let $\Omega_+ \subset \mathbb{R}^3$ be an connected open domain with a C^2 -boundary Σ , $\Omega_- = \mathbb{R}^3 \setminus \Omega_+, \Sigma$ has the conic structure at infinity, that is there exists R > 0 such that if $x_0 \in \Sigma$ and $x_0 > R$ the ray $\{x \in \mathbb{R}^3 : x = tx_0, t > 0\} \subset \Sigma$. Let $\tilde{\Omega}_{\pm}, \tilde{\Sigma}$ be the compactifications of the sets Ω_{\pm}, Σ in the topology of \mathbb{R}^3 .

We consider the operator $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ for $A_j, \Phi \in SO^1(\mathbb{R}^3)$ and for the interaction matrix $\Gamma = (\Gamma_{ij})_{i,j=1}^4$ with $\Gamma_{ij} \in C(\tilde{\Sigma}) \cap C^1(\Sigma)$.

We define the limit operators of the operator $\mathcal{D}_{A,\Phi,a_+,a_-}$ as follows:

- If $\vartheta_{\omega} \notin \Sigma_{\infty} = \tilde{\Sigma} \setminus \Sigma$, then the limit operators defined by the sequence $h_m \to \vartheta_{\omega}$ are of the form (83) with the spectrum given by formula (84).
- Let $\vartheta_{\omega} \in \Sigma_{\infty} = \tilde{\Sigma} \setminus \Sigma$, $l_{\omega}^{R} = \{x \in \mathbb{R}^{3} : x = t\omega, t > R\}$ and $T_{\vartheta_{\omega}}$ be the tangent plane to Σ at the ray l_{ω}^{R} and $\nu(\omega)$ is the outgoing normal vector to Ω_{+} at the points of the ray l_{ω}^{R} . We denote by $\mathbb{R}^{3}_{\pm,\vartheta_{\omega}}$ the half-spaces in \mathbb{R}^{3} with common boundary $T_{\vartheta_{\omega}}$. Then following to the paper [27] the limit operators defined by the sequences $h_{m} \to \vartheta_{\omega}$ are of the form

$$\mathbb{D}^{h}_{\boldsymbol{A},\Phi,a_{+}(\vartheta_{\omega}),a_{-}(\vartheta_{\omega})}u(x) = \begin{cases} \mathfrak{D}_{\boldsymbol{A}^{h},\Phi^{h}}\boldsymbol{u}(x), x \in \mathbb{R}^{3} \setminus T_{\vartheta_{\omega}}, \\ a_{+}(\vartheta_{\omega})\boldsymbol{u}_{+}(s) + a_{-}(\vartheta_{\omega})\boldsymbol{u}_{-}(s) = 0, s \in T_{\vartheta_{\omega}}, \end{cases}$$
(86)

where

$$\begin{aligned} a_{+}(\vartheta_{\omega}) &= \frac{1}{2}\Gamma(\vartheta_{\omega}) - i\alpha \cdot \boldsymbol{\nu}(\omega), a_{-}(\vartheta_{\omega}) = \frac{1}{2}\Gamma(\vartheta_{\omega}) + i\alpha \cdot \boldsymbol{\nu}(\omega), \\ \Gamma(\vartheta_{\omega}) &= \lim_{\Sigma \ni s \to \vartheta_{\omega}} \Gamma(s). \end{aligned}$$

Theorem 11 Let Σ be a C^2 -surface with conical structure at infinity, $A_j, \Phi \in SO^1(\mathbb{R}^3)$ be real-valued functions and the interaction matrix $\Gamma = (\Gamma_{i,j})_{i,j=1}^4$ be Hermitian with $\Gamma_{i,j} \in C\left(\tilde{\Sigma}\right) \cap C_b^1(\Sigma)$, and the uniform Lopatinsky-Shapiro condition be satisfied. Then: (i) the operator $\mathcal{D}_{A,\Phi,a_+,a_-}$ is self-adjoint, (ii) $\mathcal{D}_{A,\Phi,a_+,a_-}$ is a Fredholm operator if and only if: (a) for every $\vartheta_\omega \notin \Sigma_\infty$ all limit operators $\mathfrak{D}_{A,\Phi}^h$ defined by the sequences $h_m \to \vartheta_\omega$ are invertible from $H^1(\mathbb{R}^3, \mathbb{C}^4) \to L^2(\mathbb{R}^3, \mathbb{C}^4)$; (b) for every $\vartheta_\omega \in \Sigma_\infty$ all limit operators $\mathbb{D}_{A^h,\Phi^h,a_+(\vartheta_\omega),a_-(\vartheta_\omega)}$ $\in Lim_{\vartheta_\omega} \mathfrak{D}_{A,\Phi,a_+,a_-}$ are invertible from $H^1(\mathbb{R}^3 \setminus \Sigma, \mathbb{C}^4) \to L^2(\mathbb{R}^3, \mathbb{C}^4)$.

Proof. The self-adjointness of operator $\mathcal{D}_{\mathbf{A},\Phi,a_+,a_-}$ follows from Theorem ??. The operator $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ is locally invertible at every point $x \in \mathbb{R}^3$ because the Dirac operator $\mathfrak{D}_{\mathbf{A},\Phi}$ is elliptic and the Lopatinsky-Shapiro condition holds at every point $x \in \Sigma$. Hence according Proposition 8 $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ is a Fredholm operator if and only if $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ is locally invertible at every infinitely distant point $\vartheta_{\omega} \in \mathbb{R}^3_{\infty}$. Following to the monograph [25], the papers [26], [27] we obtain that conditions (a) and (b) are necessary and sufficient for the local invertibility of $\mathbb{D}_{\mathbf{A},\Phi,a_+,a_-}$ at every infinitely distant point.

Corollary 12 Let the conditions of Theorem 11 hold. Then

$$sp_{ess}\mathcal{D}_{\boldsymbol{A},\Phi,a_{+},a_{-}} = \bigcup_{\mathcal{D}^{h}_{\boldsymbol{A},\Phi,a_{+},a_{-}} \in Lim\mathcal{D}_{\boldsymbol{A},\Phi,a_{+},a_{-}}} sp\mathcal{D}^{h}_{\boldsymbol{A},\Phi,a_{+},a_{-}}$$
(87)

where $\mathcal{D}^{h}_{\mathbf{A},\Phi,a_{+},a_{-}}$ are unbounded operators associated with the above defined transmission operators $\mathbb{D}^{h}_{\mathbf{A},\Phi,a_{+},a_{-}}$.

Note that

$$sp\mathcal{D}^{h}_{\boldsymbol{A},\Phi,a_{+},a_{-}} = sp\mathfrak{D}_{\boldsymbol{A}^{h},\Phi^{h}} = sp\mathfrak{D}_{\boldsymbol{0},\Phi^{h}} = \left(-\infty,\Phi^{h}-|m|\right] \bigcup \left[\Phi^{h}+|m|,+\infty\right)$$
(88)

for the sequences $h_m \to \vartheta_\omega \in \mathbb{R}^3_\infty \setminus \Sigma_\infty$.

We consider now the spectrum of operators $\mathbb{D}_{A^h,\Phi^h,a_+(\vartheta_\omega),a_-(\vartheta_\omega)}$ defined by the sequences $h_m \to \vartheta_\omega \in \Sigma_\infty$. Note that

$$sp\mathbb{D}_{\mathbf{A}^{h},\Phi^{h},a_{+}(\vartheta_{\omega}),a_{-}(\vartheta_{\omega})} = sp\mathbb{D}_{\mathbf{0},\Phi^{h},a_{+}(\vartheta_{\omega}),a_{-}(\vartheta_{\omega})}$$

where

$$\mathbb{D}_{\mathbf{0},\Phi^{h},a_{+}(\vartheta_{\omega}),a_{-}(\vartheta_{\omega})}\boldsymbol{u}(x) = \begin{cases} \left(\alpha \cdot \boldsymbol{D} + \alpha_{0}m + \Phi^{h}\right)\boldsymbol{u}(x), x \in \mathbb{R}^{3} \setminus \mathbb{T}_{\vartheta_{\omega}}, \\ a_{+}(\vartheta_{\omega})\boldsymbol{u}_{+}(s) + a_{-}(\vartheta_{\omega})\boldsymbol{u}_{-}(s) = 0, s \in \mathbb{T}_{\vartheta_{\omega}}. \end{cases}$$

Without loss of generality we assume that $\mathbb{T}_{\vartheta_{\omega}} = \mathbb{R}^2_{x'} = \{x = (x', x_3) : x_3 = 0\}$. Then after the Fourier transform with respect to $x' \in \mathbb{R}^2$ we obtain the family of one-dimensional Dirac operators depended on the parameter $\xi' \in \mathbb{R}^2$

$$\overset{\tilde{\mathbb{D}}_{\mathbf{0},\Phi^{h},a_{+}(\vartheta_{\omega}),a_{-}(\vartheta_{\omega})}(\xi')\,\hat{\boldsymbol{u}}(\xi',z) \qquad (89)$$

$$= \begin{cases} \left(\alpha' \cdot \xi' + i\alpha_{3}\frac{d}{dz} + \alpha_{0}m + \Phi^{h}\right)\,\hat{\boldsymbol{u}}(\xi',z), z \in \mathbb{R} \setminus \{0\}, \xi' \in \mathbb{R}^{2} \\ a_{+}(\vartheta_{\omega})\hat{\boldsymbol{u}}_{+}(\xi',0) + a_{-}(\vartheta_{\omega})\boldsymbol{u}_{-}(\xi',0) = 0, \xi' \in \mathbb{R}^{2}. \end{cases}$$

The 1 - D Dirac operator

$$\hat{\mathbb{D}}_{\mathbf{0},\Phi^{h},a_{+}(\vartheta_{\omega}),a_{-}(\vartheta_{\omega})}\left(\xi'\right)\varphi(z) = \begin{cases} \left(\alpha'\cdot\xi'+i\alpha_{3}\frac{d}{dz}+\alpha_{0}m+\Phi^{h}\right)\varphi(z), z \in \mathbb{R}\setminus\{0\}\\ a_{+}(\vartheta_{\omega})\varphi_{+}(0)+a_{-}(\vartheta_{\omega})\varphi_{-}(0)=0 \end{cases}$$
(90)

has the essential spectrum

$$sp_{ess}\hat{\mathbb{D}}_{\mathbf{0},\Phi^{h},a_{+}(\vartheta_{\omega}),a_{-}(\vartheta_{\omega})}(\xi') = \left(-\infty,\Phi^{h}-\sqrt{|\xi'|^{2}+|m|^{2}}\right] \bigcup \left[\Phi^{h}+\sqrt{|\xi'|^{2}+|m|^{2}},+\infty\right)$$

and a possible finite discrete spectrum on the interval $\left(\Phi^h - \sqrt{|\xi'|^2 + m^2}, \Phi^h + \sqrt{|\xi'|^2 + m^2}\right)$. Hence

$$sp\mathbb{D}_{\mathbf{0},\Phi^{h},a_{+}(\vartheta_{\omega}),a_{-}(\vartheta_{\omega})} == \left(-\infty,-|m|+\Phi^{h}\right] \bigcup \left[|m|+\Phi^{h},+\infty\right)$$
$$\bigcup_{\xi'\in\mathbb{R}^{2}} sp_{dis}\hat{\mathbb{D}}_{\mathbf{0},\Phi^{h},a_{+}^{\vartheta_{\omega}},a_{-}^{\vartheta_{\omega}}}(\xi') \bigcap (-|m|+\Phi^{h},|m|+\Phi^{h})$$

Applying Corollary 12 we obtain the following result.

Theorem 13 Let the conditions of Theorem 11 hold. Then

$$sp_{ess}\mathcal{D}_{\mathbf{A},\Phi,a_{+},a_{-}} = (-\infty, M_{\Phi}^{\mathrm{sup}} - |m|] \bigcup [M_{\Phi}^{\mathrm{inf}} + |m|, +\infty)$$
$$\bigcup_{\xi' \in \mathbb{R}^{2} \vartheta_{\omega} \in \Sigma_{\infty}} \bigcup_{h_{m} \to \vartheta_{\omega}} sp_{dis} \hat{\mathbb{D}}_{\mathbf{0},\Phi^{h},a_{+}^{\vartheta_{\omega}},a_{-}^{\vartheta_{\omega}}}(\xi') \bigcap (-|m| + \Phi^{h}, |m| + \Phi^{h})$$

Remark 14 The calculation of the essential spectrum of $\mathcal{D}_{A,\Phi,a_+,a_-}$ is simplified if

$$\lim_{s \to \infty} \Gamma(s) = 0.$$

In this case, the limit operators defined by the sequences $h_m \to \vartheta_\omega$ are of the form

$$\mathbb{D}_{\mathbf{0},\Phi^{h},a_{+}^{\vartheta_{\omega}},a_{-}^{\vartheta_{\omega}}}\boldsymbol{u}(x) = \begin{cases} \left(\boldsymbol{\alpha}\cdot\boldsymbol{D}_{x}+\alpha_{0}m+\Phi^{h}\right)\boldsymbol{u}(x), x\in\mathbb{R}^{3}\backslash\mathbb{T}_{\vartheta_{\omega}}\\ \boldsymbol{u}_{+}(s)=\boldsymbol{u}_{-}(s), s\in\mathbb{T}_{\vartheta_{\omega}}. \end{cases}$$
(91)

It yields that $sp_{dis}\mathbb{D}_{0,\Phi^{h},a^{\vartheta_{\omega}}_{+},a^{\vartheta_{\omega}}_{-}} = \emptyset$ and if conditions of Theorem 11 impliy formula (87).

4.5 Electrostatic and Lorentz scalar δ -shell interaction for conic at infinity interaction surfaces

Let Σ be a conic at infinity C^2 -surface. We consider the operator $\mathcal{D}_{A,\Phi,a_+,a_-}$, where $A_j, \Phi \in SO^1(\mathbb{R}^3)$ are real-valued functions. The singular potential

$$Q_{\sin} = \Gamma \delta_{\Sigma} = (\eta I_4 + \tau \alpha_4) \delta_{\Sigma} \tag{92}$$

where $\eta, \tau \in C_b^1(\Sigma)$ and $\lim_{\Sigma \ni s \to \infty} f(s) = 0$. Moreover, we assume that η, τ are real-valued functions and the Lopatinsky-Shapiro condition

$$\eta^2(s) - \tau^2(s) \neq 4$$
 (93)

be satisfied for every point $s \in \Sigma$. Then the operator $\mathcal{D}_{A,\Phi,a_+,a_-}$ is self-adjoint in $L^2(\mathbb{R}^3, \mathbb{C}^4)$ and $sp_{ess}\mathcal{D}_{A,\Phi,a_+,a_-}$ is given by formula (87).
