# ON A VARIATIONAL APPROACH TO THE NAVIER-STOKES EQUATIONS

## 1. Introduction

Let $\Omega \subset \mathbb{R}^{N}$ be a domain. The initial-boundary value problem for the incompressible Navier-Stokes Equations is the following one,

\text { (i) } \frac{\partial v}{\partial t}+d i v_{x}(v \otimes v)+\nabla_{x} p=\nu \Delta_{x} v+f \quad \forall(x, t) \in \Omega \times(0, T),  \tag{1.1}\\
\text { (ii) } d i v_{x} v=0 \quad \forall(x, t) \in \Omega \times(0, T), \\
\text { (iii) } v=0 \quad \forall(x, t) \in \partial \Omega \times(0, T), \\
(i v) \quad v(x, 0)=v_{0}(x) \quad \forall x \in \Omega .
\end{array}\right.
$$

Here $v=v(x, t): \Omega \times(0, T) \rightarrow \mathbb{R}^{N}$ is an unknown velocity, $p=p(x, t): \Omega \times(0, T) \rightarrow \mathbb{R}$ is an unknown pressure, associated with $v, \nu>0$ is a given constant viscosity, $f$ : $\Omega \times(0, T) \rightarrow \mathbb{R}^{N}$ is a given force field and $v_{0}: \Omega \rightarrow \mathbb{R}^{N}$ is a given initial velocity. The existence of weak solution to (1.1) satisfying the Energy inequality was first proved in the celebrating works of Leray (1934). There are many different procedures for constructing weak solutions (see Leray [9], [10] (1934); Kiselev and Ladyzhenskaya [8] (1957); Shinbrot [12] (1973)). The most common methods are based on the so called Faedo-Galerkin approximation process. Application of Faedo-Galerkin method for (1.1) was first considered by Hopf in [7]. We also refer to Masuda [11] for the problem in higher dimension. In this paper we present a variational method to investigate the Navier-Stokes equations that we thought to be completely new, see however the remarks below. As an application of this method we give a relatively simple proof of the existence of weak solutions to the problem (1.1).

Let us briefly describe our method. Consider for simplicity $f=0$ in (1.1). For every smooth $u: \bar{\Omega} \times[0, T] \rightarrow \mathbb{R}^{N}$ satisfying conditions (ii) - (iv) of (1.1) define the

energy functional

$$
\begin{equation*}
E(u):=\frac{1}{2} \int_{0}^{T} \int_{\Omega}\left(\nu\left|\nabla_{x} u\right|^{2}+\frac{1}{\nu}\left|\nabla_{x} \bar{H}_{u}\right|^{2}\right) d x d t+\frac{1}{2} \int_{\Omega}|u(x, T)|^{2} d x \tag{1.2}
\end{equation*}
$$

where $\bar{H}_{u}(x, t)$ solves the following Stokes system for every $t \in(0, T)$,

$$
\left\{\begin{array}{l}
\Delta_{x} \bar{H}_{u}=\left(\frac{\partial u}{\partial t}+\operatorname{div}_{x}(u \otimes u)\right)+\nabla_{x} p \quad x \in \Omega  \tag{1.3}\\
\operatorname{div}_{x} \bar{H}_{u}=0 \quad x \in \Omega \\
\bar{H}_{u}=0 \quad \forall x \in \partial \Omega
\end{array}\right.
$$

A simple integration by parts gives

$$
\begin{equation*}
E(u)=\frac{1}{2 \nu} \int_{0}^{T} \int_{\Omega}\left(\left|\nu \nabla_{x} u-\nabla_{x} \bar{H}_{u}\right|^{2}\right) d x d t+\frac{1}{2} \int_{\Omega}\left|v_{0}(x)\right|^{2} d x \tag{1.4}
\end{equation*}
$$

Therefore, if there exists at least a smooth solution to (1.1) (with $f=0$ ) then a smooth function $u: \Omega \times(0, T) \rightarrow \mathbb{R}^{N}$ will be a solution to (1.1) (with $f=0$ ) if and only if it is a minimizer of the functional in (1.2) among all smooth divergence free vector fields satisfying the boundary and the initial value conditions of (1.1). For the rigorous formulations and statements, see Section 5. This remark relates the problem of existence of solutions of the Navier-Stokes equations to that of minimizing the energy $E(u)$.

Unfortunately, when applying this method to the Navier-Stokes Equation one meets certain difficulties, for example in proving the existence of minimizers to $E$. But we can apply this method to a suitable approximation of problem (1.1). We approximate (1.1) by replacing the nonlinear term $\operatorname{div}_{x}(v \otimes v)$ with the terms $\operatorname{div}_{x}\left\{f_{n}\left(|v|^{2}\right)(v \otimes v)\right\}$, where $f_{n}: \mathbb{R}^{+} \rightarrow \mathbb{R}^{+}$are regular cutoff functions satisfying $f_{n}(s)=1$ for $s \leq n$ and $f_{n}(s)=0$ for $s>2 n$. The approximating problems are simpler than (1.1), since the nonlinear term has higher integrability. Next we consider the energies $E_{n}$ corresponding to the approximating problems and investigate the Euler-Lagrange equations of $E_{n}$ and the existence of minimizers. In this way we get solutions to the approximating problems which satisfy the energy equality (in fact these solutions will be regular if the initial data and the domain are). Next we pass to the limit for $n \rightarrow \infty$ and obtain a weak solution to (1.1). For the details see Section 3,

After completing the first version of this paper I learned that an energy-functional, very similar to (1.2), was used by Ghoussoub and his coauthors, see [3, 4, 5, 6], to prove existence of weak solutions for (1.1) and to study many other evolution equations. The basic variational principle behind this approach was first introduced
by Brezis and Ekeland, see [1] (I wasn't aware of this article as well). The main new feature of our method is that, unlike the previous works mentioned above, we menage to deduce directly from the Euler-Lagrange equation associated with (1.2) that the minimizer is a solution of the original problem (1.1).

We shall now demonstrate our method in the simple example of the heat equation. In this case, the energy-functional takes the form

\bar{E}(u):=\frac{1}{2} \int_{0}^{T} \int_{\Omega}\left(\left|\nabla_{x} u\right|^{2}+\left|\nabla_{x}\left\{\Delta_{x}^{-1}\left(\partial_{t} u\right)\right\}\right|^{2}\right) d x d t+\frac{1}{2} \int_{\Omega}|u(x, T)|^{2} d x \tag{1.5}
\end{equation*}
$$

where $\Delta^{-1} f$ is the solution of

$$
\left\{\begin{array}{l}
\Delta y=f \quad x \in \Omega \\
y=0
\end{array} \quad \forall x \in \partial \Omega .\right.
$$

The variational functional of type (1.5) was first considered by Brezis and Ekeland [1] in the more general case of gradient flows. Let us investigate the Euler-Lagrange equation for (1.5). If $u$ satisfies $u(x, t)=0$ for every $(x, t) \in \partial \Omega \times(0, T)$ and $u(x, 0)=$ $v_{0}(x)$, then, as before,

\bar{E}(u):=\frac{1}{2} \int_{0}^{T} \int_{\Omega}\left(\left|\nabla_{x}\left\{u-\Delta_{x}^{-1}\left(\partial_{t} u\right)\right\}\right|^{2}\right) d x d t+\frac{1}{2} \int_{\Omega} v_{0}^{2}(x) d x
$$

Set $W_{u}:=u-\Delta_{x}^{-1}\left(\partial_{t} u\right)$. Then, for every minimizer $u$ and for every smooth test function $\delta(x, t)$ satisfying $\delta(x, t)=0$ for every $(x, t) \in \partial \Omega \times(0, T)$ and $\delta(x, 0)=0$, we obtain

$$
\begin{aligned}
& 0=\left.\frac{d \bar{E}(u+s \delta)}{d s}\right|_{(s=0)}=\lim _{s \rightarrow 0} \frac{1}{2 s} \int_{0}^{T} \int_{\Omega}\left(\left|\nabla_{x} W_{(u+s \delta)}\right|^{2}-\left|\nabla_{x} W_{u}\right|^{2}\right)= \\
& \quad-\lim _{s \rightarrow 0} \frac{1}{2 s} \int_{0}^{T} \int_{\Omega}\left(\Delta_{x} W_{(u+s \delta)}-\Delta_{x} W_{u}\right) \cdot\left(W_{(u+s \delta)}+W_{u}\right)= \\
& \lim _{s \rightarrow 0} \frac{1}{2} \int_{0}^{T} \int_{\Omega}\left(-\Delta_{x} \delta+\partial_{t} \delta\right) \cdot\left(W_{(u+s \delta)}+W_{u}\right)=\int_{0}^{T} \int_{\Omega}\left(\nabla W_{u} \cdot \nabla_{x} \delta+W_{u} \cdot \partial_{t} \delta\right) .
\end{aligned}
$$

Since $\delta$ was arbitrary (in particular $\delta(x, T)$ is free) we deduce that $\Delta_{x} W_{u}+\partial_{t} W_{u}=0$, $W_{u}(x, T)=0$ and $W_{u}=0$ if $x \in \partial \Omega$. Changing variables $\tau:=T-t$ gives

$$
\begin{cases}\partial_{\tau} W_{u}=\Delta_{x} W_{u} & \forall(x, \tau) \in \Omega \times(0, T) \\ W_{u}(x, 0)=0, & \\ W_{u}(x, \tau)=0 & \forall(x, \tau) \in \partial \Omega \times(0, T)\end{cases}
$$

Therefore $W_{u}=0$ and then $\Delta_{x} u=\partial_{t} u$, i.e., $u$ is the solution of the heat equation.

## 2. Preliminaries

For two matrices $A, B \in \mathbb{R}^{p \times q}$ with $i j$-th entries $a_{i j}$ and $b_{i j}$ respectively, we write $A: B:=\sum_{i=1}^{p} \sum_{j=1}^{q} a_{i j} b_{i j}$.
Given a vector valued function $f(x)=\left(f_{1}(x), \ldots, f_{k}(x)\right): \Omega \rightarrow \mathbb{R}^{k}\left(\Omega \subset \mathbb{R}^{N}\right)$ we denote by $\nabla_{x} f$ the $k \times N$ matrix with $i j$-th entry $\frac{\partial f_{i}}{\partial x_{j}}$.
For a matrix valued function $F(x):=\left\{F_{i j}(x)\right\}: \mathbb{R}^{N} \rightarrow \mathbb{R}^{k \times N}$ we denote by div $F$ the $\mathbb{R}^{k}$-valued vector field defined by $\operatorname{div} F:=\left(l_{1}, \ldots, l_{k}\right)$ where $l_{i}=\sum_{j=1}^{N} \frac{\partial F_{i j}}{\partial x_{j}}$. Throughout the rest of the paper we assume that $\Omega$ is domain in $\mathbb{R}^{N}$.

Definition 2.1. We denote:

- By $\mathcal{V}_{N}$ the space $\left\{\varphi \in C_{c}^{\infty}\left(\Omega, \mathbb{R}^{N}\right): \operatorname{div} \varphi=0\right\}$ and by $L_{N}$ the space, which is the closure of $\mathcal{V}_{N}$ in the space $L^{2}\left(\Omega, \mathbb{R}^{N}\right)$, endowed with the norm $\|\varphi\|:=$ $\left(\int_{\Omega}|\varphi|^{2} d x\right)^{1 / 2}$.
- By $\bar{H}_{0}^{1}\left(\Omega, \mathbb{R}^{N}\right)$ the closure of $C_{c}^{\infty}\left(\Omega, \mathbb{R}^{N}\right)$ with respect to the norm $\|\mid \varphi\| \|:=$ $\left(\int_{\Omega}|\nabla \varphi|^{2} d x\right)^{1 / 2}$. This space differ from $H_{0}^{1}\left(\Omega, \mathbb{R}^{N}\right)$ only in the case of unbounded domain.
- By $V_{N}$ the closure of $\mathcal{V}_{N}$ in $\bar{H}_{0}^{1}\left(\Omega, \mathbb{R}^{N}\right)$.
- By $V_{N}^{-1}$ the space dual to $V_{N}$.
- By $\mathcal{Y}$ the space

\mathcal{Y}:=\left\{\varphi(x, t) \in C_{c}^{\infty}\left(\Omega \times[0, T], \mathbb{R}^{N}\right): \operatorname{div}_{x} \varphi=0\right\}
$$

Remark 2.1. It is obvious that $u \in \mathcal{D}^{\prime}\left(\Omega, \mathbb{R}^{N}\right)$ (rigorously the equivalence class of $u$, up to gradients) belongs to $V_{N}^{-1}$ if and only if there exists $w \in V_{N}$ such that

\int_{\Omega} \nabla w: \nabla \delta d x=-<u, \delta>\quad \forall \delta \in V_{N}
$$

In particular $\Delta w=u+\nabla p$ as a distribution and

$$
\|\mid w\|\left\|=\sup _{\delta \in V_{N},\| \| \delta \| \leq 1}<u, \delta>=\right\|\|u\|_{-1}
$$

Definition 2.2. We will say that the distribution $l \in \mathcal{D}^{\prime}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$ belongs to $L^{2}\left(0, T ; V_{N}^{-1}\right)$, if there exists $v(\cdot, t) \in L^{2}\left(0, T ; V_{N}^{-1}\right)$, such that for every $\psi(x, t) \in$ $C_{c}^{\infty}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$, satisfying $\operatorname{div}_{x} \psi=0$, we have

$$
<l(\cdot, \cdot), \psi(\cdot, \cdot)>=\int_{0_{4}}^{T}<v(\cdot, t), \psi(\cdot, t)>d t
$$

Remark 2.2. Let $v(\cdot, t) \in L^{2}\left(0, T ; V_{N}^{-1}\right)$. For a.e. $t \in[0, T]$ consider $V_{v}(\cdot, t)$ as in Remark 2.1, corresponding to $v(\cdot, t)$, i.e.

$$
\int_{\Omega} \nabla_{x} V_{v}(x, t): \nabla_{x} \delta(x) d x=-<v(\cdot, t), \delta(\cdot)>\quad \forall \delta \in V_{N}
$$

Then it is clear that $V_{v}(\cdot, t) \in L^{2}\left(0, T ; V_{N}\right)$ and

$$
\left\|V_{v}\right\|_{L^{2}\left(0, T ; V_{N}\right)}=\|v\|_{L^{2}\left(0, T ; V_{N}^{-1}\right)}
$$

In the sequel we will need several lemmas. In all of them $\Omega \subset \mathbb{R}^{N}$ is a bounded domain. The following Lemma can be proved in the same way as Lemmas 2.1 and 2.2 in [2].

Lemma 2.1. Let $u \in L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$ be such that $\partial_{t} u \in L^{2}\left(0, T ; V_{N}^{-1}\right)$. Consider $V_{0}(\cdot, t) \in L^{2}\left(0, T ; V_{N}\right)$ as in Remark 2.2, corresponding to $\partial_{t} u$. Then we can redefine $u$ on a subset of $[0, T]$ of Lebesgue measure zero, so that $u(\cdot, t)$ will be $L_{N}$-weakly continuous in $t$ on $[0, T]$. Moreover, for every $0 \leq a<b \leq T$ and for every $\psi(x, t) \in \mathcal{Y}$ (see Definition [2.1) we will have

\begin{align*}
\int_{a}^{b} \int_{\Omega} \nabla_{x} V_{0}: \nabla_{x} \psi d x d t-\int_{a}^{b} & \int_{\Omega} u \cdot \partial_{t} \psi d x d t  \tag{2.1}\\
& =\int_{\Omega} u(x, a) \cdot \psi(x, a) d x-\int_{\Omega} u(x, b) \cdot \psi(x, b) d x
\end{align*}
$$

Remark 2.3. Let $F \in \operatorname{Lip}\left(\mathbb{R}^{N}, \mathbb{R}^{N \times N}\right)$ satisfying $F(0)=0$. Then for every $u \in$ $L^{\infty}\left(0, T ; L_{N}\right)$ we have $F(u) \in L^{\infty}\left(0, T ; L^{2}\left(\Omega, \mathbb{R}^{N \times N}\right)\right)$ and therefore $\operatorname{div}_{x} F(u) \in$ $L^{2}\left(0, T ; V_{N}^{-1}\right)$. If in addition $\partial_{t} u \in L^{2}\left(0, T ; V_{N}^{-1}\right)$ then we obtain $\partial_{t} u+\operatorname{div}_{x} F(u) \in$ $L^{2}\left(0, T ; V_{N}^{-1}\right)$.

We have then the following Corollary to Lemma 2.1.

Corollary 2.1. Let $u$ be as in Lemma 2.1 and let $F \in \operatorname{Lip}\left(\mathbb{R}^{N}, \mathbb{R}^{N \times N}\right)$ satisfying $F(0)=0$. Assume, in addition, that $u(\cdot, t)$ is $L_{N}$-weakly continuous in $t$ on $[0, T]$ (see Lemma 2.1). Consider $V(\cdot, t) \in L^{2}\left(0, T ; V_{N}\right)$ as in Remark 2.2, corresponding to $\partial_{t} u+\operatorname{div}_{x} F(u)$. Then for every $0 \leq a<b \leq T$ and for every $\psi(x, t) \in \mathcal{Y}$ we have

$$
\begin{align*}
\int_{a}^{b} \int_{\Omega} \nabla_{x} V: \nabla_{x} \psi d x d t-\int_{a}^{b} & \int_{\Omega}\left(u \cdot \partial_{t} \psi+F(u): \nabla_{x} \psi\right) d x d t  \tag{2.2}\\
& =\int_{\Omega} u(x, a) \cdot \psi(x, a) d x-\int_{\Omega} u(x, b) \cdot \psi(x, b) d x
\end{align*}
$$

We will need in the sequel the following compactness result.

Lemma 2.2. Let $\left\{u_{n}\right\} \subset L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$ be a subsequence, bounded in $L^{\infty}\left(0, T ; L_{N}\right)$ and such that

$$
\begin{equation*}
u_{n} \rightharpoonup u_{0} \quad \text { weakly in } L^{2}\left(0, T ; V_{N}\right), \tag{2.3}
\end{equation*}
$$

and

$$
\begin{equation*}
u_{n}(\cdot, t) \rightharpoonup u_{0}(\cdot, t) \quad \text { weakly in } L_{N} \quad \forall t \in(0, T) . \tag{2.4}
\end{equation*}
$$

Then

$$
\begin{equation*}
u_{n} \rightarrow u_{0} \quad \text { strongly in } L^{2}\left(0, T ; L_{N}\right) . \tag{2.5}
\end{equation*}
$$

We will give the proof of this Lemma in the Appendix.

## 3. Existence of the weak solution to the Navier-Stokes Equations

Throughout this section we assume that $\Omega \subset \mathbb{R}^{N}$ is a bounded domain.
Definition 3.1. Let $F(v)=\left\{F_{i j}(v)\right\} \in C^{1}\left(\mathbb{R}^{N}, \mathbb{R}^{N \times N}\right) \cap$ Lip satisfy $F(0)=0$ and $\frac{\partial F_{i j}}{\partial v_{m}}(v)=\frac{\partial F_{m j}}{\partial v_{i}}(v)$ for all $v \in \mathbb{R}^{N}$ and $m, i, j \in\{1, \ldots, N\}$. Denote the class of all such $F$ by $\mathfrak{F}$.

Remark 3.1. Let $F \in \mathfrak{F}$. Then it is clear that there exists $G(v)=\left(G_{1}(v), \ldots, G_{N}(v)\right) \in$ $C^{2}\left(\mathbb{R}^{N}, \mathbb{R}^{N}\right)$, such that $\frac{\partial G_{j}}{\partial v_{i}}(v)=F_{i j}(v)$ i.e. $\nabla_{v} G(v)=(F(v))^{T}$.

Using our variational approach, we will prove in the sequel the existence of a solution of the following problem

$$
\left\{\begin{array}{l}
\frac{\partial v}{\partial t}+d i v_{x} F(v)+\nabla_{x} p=\Delta_{x} v \quad \forall(x, t) \in \Omega \times(0, T),  \tag{3.1}\\
d i v_{x} v=0 \quad \forall(x, t) \in \Omega \times(0, T) \\
v=0 \quad \forall(x, t) \in \partial \Omega \times(0, T) \\
v(x, 0)=v_{0}(x) \quad \forall x \in \Omega
\end{array}\right.
$$

for every $F \in \mathfrak{F}$, which in addition satisfies the Energy Equality (see Theorem 4.1). But first of all, in the proof of the following theorem we would like to explain how this fact implies the existence of weak solution to the Navier-Stokes Equation.

Theorem 3.1. Let $v_{0}(x) \in L_{N}$. Then there exists $u \in L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$ satisfying

$$
\begin{equation*}
\int_{\Omega} v_{0}(x) \cdot \psi(x, 0) d x+\int_{0}^{T} \int_{\Omega}\left(u \cdot \partial_{t} \psi+(u \otimes u): \nabla_{x} \psi\right)=\int_{0}^{T} \int_{\Omega} \nabla_{x} u: \nabla_{x} \psi \tag{3.2}
\end{equation*}
$$

for every $\psi(x, t) \in C_{c}^{\infty}\left(\Omega \times[0, T), \mathbb{R}^{N}\right)$ such that div $\psi=0$, i.e.

$$
\Delta_{x} u=\partial_{t} u+d i v_{x}(u \otimes u)+\nabla_{x} p, \quad \text { and } u(x, 0)=v_{0}(x) .
$$

Moreover, for a.e. $\tau \in[0, T]$ we have

$$
\begin{equation*}
\int_{0}^{\tau} \int_{\Omega}\left|\nabla_{x} u\right|^{2} d x d t \leq \frac{1}{2}\left(\int_{\Omega} v_{0}^{2}(x) d x-\int_{\Omega} u^{2}(x, \tau) d x\right) . \tag{3.3}
\end{equation*}
$$

Proof. Fix some $h(s) \in C^{\infty}(\mathbb{R},[0,1])$, satisfying $h(s)=1 \forall s \leq 1$ and $h(s)=0 \forall s \geq 2$. For every $n \in \mathbb{N}$ define $f_{n}(s):=h(s / n)$. Consider

$$
\begin{equation*}
F_{n}(v):=f_{n}\left(|v|^{2}\right)(v \otimes v)+g_{n}\left(|v|^{2}\right) I_{N}, \tag{3.4}
\end{equation*}
$$

where $I_{N}$ is a $N \times N$-unit matrix and $g_{n}(r):=\frac{1}{2} \int_{0}^{r} f_{n}(s) d s$. Then for every $n$ we have $F_{n} \in \mathfrak{F}$ and there exists $A>0$ such that $\left|F_{n}(v)\right| \leq A|v|^{2}$ for every $v$ and $n$. Fix also some sequence $\left\{v_{0}^{(n)}\right\}_{n=1}^{\infty} \subset \mathcal{V}_{N}$ such that $v_{0}^{(n)} \rightarrow v_{0}$ strongly in $L_{N}$ as $n \rightarrow \infty$. By Theorem 4.1, bellow, for every $n$ there exist a function $u_{n} \in$ $L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$, such that $\partial_{t} u_{n} \in L^{2}\left(0, T ; V_{N}^{-1}\right)$ and $u_{n}(\cdot, t)$ is $L_{N}$-weakly continuous in $t$ on $[0, T]$, which satisfy

$$
\begin{equation*}
\int_{\Omega} v_{0}^{(n)}(x) \cdot \psi(x, 0)+\int_{0}^{T} \int_{\Omega}\left(u_{n} \cdot \partial_{t} \psi+F_{n}\left(u_{n}\right): \nabla_{x} \psi\right)=\int_{0}^{T} \int_{\Omega} \nabla_{x} u_{n}: \nabla_{x} \psi \tag{3.5}
\end{equation*}
$$

for every $\psi(x, t) \in C_{c}^{\infty}\left(\Omega \times[0, T), \mathbb{R}^{N}\right)$, such that $\operatorname{div}_{x} \psi=0$. Moreover, by the same Theorem, for every $\tau \in[0, T]$ we obtain

\frac{1}{2} \int_{\Omega} u_{n}^{2}(x, \tau) d x+\int_{0}^{\tau} \int_{\Omega}\left|\nabla_{x} u_{n}\right|^{2} d x d t=\frac{1}{2} \int_{\Omega}\left(v_{0}^{(n)}\right)^{2}(x) d x . \tag{3.6}
\end{equation*}
$$

Therefore, since $v_{0}^{(n)}$ is bounded in $L_{N}$ we obtain that there exists $C>0$ independent of $n$ and $t$ such that

Since $\left|F_{n}\left(u_{n}\right)\right| \leq C\left|u_{n}\right|^{2}$, by (3.7),

In particular $\left\{F_{n}\left(u_{n}\right)\right\}$ is bounded in $L^{1}\left(\Omega \times(0, T), \mathbb{R}^{N \times N}\right)$. Therefore, there exists a finite Radon measure $\mu \in \mathcal{M}\left(\Omega \times(0, T), \mathbb{R}^{N \times N}\right)$, such that, up to a subsequence, $F_{n}\left(u_{n}\right) \rightharpoonup \mu$ weakly as a sequence of finite Radon measures. Then for every $\psi \in$ $C_{0}^{\infty}\left(\Omega \times(0, T), \mathbb{R}^{N \times N}\right)$ we have

But since $u_{n}$ is bounded in $L^{2}\left(0, T ; V_{N}\right)$, up to a subsequence, it converge weakly in $L^{2}\left(0, T ; V_{N}\right)$ to the limit $u_{0}$. We also know that $u_{n}(\cdot, 0) \rightharpoonup v_{0}(\cdot)$ weakly in $L_{N}$. Plugging these facts and (3.12) into (3.8), for every $t \in[0, T]$ and every $\phi \in \mathcal{V}_{N}$ we infer

Since $\mathcal{V}_{N}$ is dense in $L_{N}$, by (3.7), and (3.13), for every $t \in[0, T]$ there exists $u(\cdot, t) \in$ $L_{N}$ such that

Moreover, $\|u(\cdot, t)\|_{L_{N}} \leq C$. But we have $u_{n} \rightharpoonup u_{0}$ in $L^{2}\left(0, T ; V_{N}\right)$, therefore $u=u_{0}$ and so $u \in L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$. Then we can use (3.7), (3.14) and Lemma 2.2, to deduce that $u_{n} \rightarrow u$ strongly in $L^{2}\left(0, T ; L_{N}\right)$. Then, up to a subsequence, we have $u_{n}(x, t) \rightarrow u(x, t)$ almost everywhere in $\Omega \times(0, T)$. In particular $f_{n}\left(\left|u_{n}(x, t)\right|^{2}\right) \rightarrow 1$ almost everywhere in $\Omega \times(0, T)$. Then,

\end{aligned}
$$

Therefore, letting $n$ tend to $\infty$ in (3.5), we obtain (3.2). Moreover, by (3.6), for a.e. $t \in[0, T]$ we obtain (3.3). This completes the proof.

## 4. Proof of the existence of solutions to (3.1)

Throughout this section we assume that $\Omega \subset \mathbb{R}^{N}$ is a bounded domain. The following Lemma can be proved in the same way as Theorem 4.1 in [2].

Lemma 4.1. Let $u \in L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$ be such that $\partial_{t} u \in L^{2}\left(0, T ; V_{N}^{-1}\right)$ and let $u(\cdot, t)$ be $L_{N}$-weakly continuous in $t$ on $[0, T]$ (see Lemma 2.1). Consider $V_{0}(\cdot, t) \in L^{2}\left(0, T ; V_{N}\right)$ as in Remark [2.2, corresponding to $\partial_{t} u$. Then for every $\tau \in$ $[0, T]$ we have

Corollary 4.1. Let $u \in L^{2}\left(0, T ; V_{N}\right)$ be such that $\partial_{t} u \in L^{2}\left(0, T ; V_{N}^{-1}\right)$. Then $u \in$ $L^{\infty}\left(0, T ; L_{N}\right)$.

We will give the proof of this Corollary in the Appendix.
Next we have the second Corollary to Lemma 4.1.

Corollary 4.2. Let $F \in \mathfrak{F}$ and let $u \in L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$ be such that $\partial_{t} u \in$ $L^{2}\left(0, T ; V_{N}^{-1}\right)$ and let $u(\cdot, t)$ be $L_{N}$-weakly continuous in $t$ on $[0, T]$ (see Lemma 2.1). Consider $V(\cdot, t) \in L^{2}\left(0, T ; V_{N}\right)$ as in Remark 2.2. corresponding to $\partial_{t} u+\operatorname{div}_{x} F(u)$ (see Remark 2.3). Then for every $\tau \in[0, T]$ we have

But for almost every $t \in[0, T] u(\cdot, t) \in V_{N}$, therefore, for every such fixed $t$ there exists a sequence $\left\{\delta_{n}(\cdot)\right\}_{n=1}^{\infty} \in \mathcal{V}_{N}$, such that $\delta_{n}(\cdot) \rightarrow u(\cdot, t)$ in $V_{N}$. But for every $\delta \in \mathcal{V}_{N}$ we obtain

where $G$ is as in Remark 3.1. Therefore, since $F$ is Lipshitz function, we obtain

Definition 4.1. Let $u \in L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$ be such that $\partial_{t} u \in L^{2}\left(0, T ; V_{N}^{-1}\right)$ and such that $u(\cdot, t)$ is $L_{N}$-weakly continuous in $t$ on $[0, T]$. Denote the set of all such functions $u$ by $\mathcal{R}$. For a fixed $F \in \mathfrak{F}$ and for every $u \in \mathcal{R}$ let $H_{u}(\cdot, t) \in L^{2}\left(0, T ; V_{N}\right)$ be as in Remark [2.2, corresponding to $\partial_{t} u+d i v_{x} F(u)$. That is for every $\psi(x, t) \in$ $C_{c}^{\infty}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$ such that $\operatorname{div}_{x} \psi=0$ we have

\int_{0}^{T} \int_{\Omega}\left(u \cdot \partial_{t} \psi+F(u): \nabla_{x} \psi\right) d x d t=\int_{0}^{T} \int_{\Omega} \nabla_{x} H_{u}: \nabla_{x} \psi d x d t

Define a functional $I_{F}(u): \mathcal{R} \rightarrow \mathbb{R}$ by

and for every $v_{0} \in V_{N}$ consider the minimization problem

Remark 4.1. Since by Corollary 4.2 we have

where we denote $W_{u}:=u-H_{u}$.

& =\int_{0}^{T} \int_{\Omega}\left\{\frac{1}{2}\left(\nabla_{x} W_{(u+s \delta)}+\nabla_{x} W_{u}\right): \nabla_{x} \delta+\partial_{t} \delta(x, t) \cdot \frac{1}{2}\left(W_{(u+s \delta)}(x, t)+W_{u}(x, t)\right)\right\} \\

Since $F$ is Lipschitz and $C^{1}$, we obtain

On the other hand, for every $h(x, t) \in L^{2}\left(0, T ; V_{N}\right)$ we obtain

In particular $W_{(u+s \delta)}$ remains bounded in $L^{2}\left(0, T ; V_{N}\right)$ as $s \rightarrow 0$. Therefore, by (4.7), we obtain

\end{align*}

So, by (4.5) and (4.12), we obtain that for every $\delta(x, t) \in \mathcal{Y}$, such that $\delta(x, 0)=0$, we must have (4.6).

Lemma 4.3. Let $u \in \mathcal{R}$ be a minimizer to (4.4). Then $H_{u}=u$, i.e.

where $W_{u} \in L^{2}\left(0, T ; V_{N}\right)$ defined by $W_{u}=u-H_{u}$. Since $\frac{\partial F}{\partial u_{j}} \in L^{\infty}$, we obtain that the functional $L(\phi): V_{N} \rightarrow \mathbb{R}$ defined by

belongs to $V_{N}^{-1}$ for a.e. $t \in(0, T)$. Moreover there exists $Q(x, t) \in L^{2}\left(0, T ; V_{N}\right)$ such that for a.e. $t \in(0, T)$ we have

Therefore, by Corollary $4.1 W_{u} \in L^{\infty}\left(0, T ; L_{N}\right)$ and by Lemma 2.1 we can redefine $W_{u}(\cdot, t)$ on a set of Lebesgue measure zero on $[0, T]$ so that $W_{u}(\cdot, t)$ be $L_{N}$-weakly continuous in $t$ on $[0, T]$. From now we consider such $W_{u}$. Moreover, by (2.2) and (4.15), for every $\delta \in \mathcal{Y}$, such that $\delta(x, 0)=0$, we obtain

\int_{t}^{T} \int_{\Omega}\left|\nabla_{x} W_{u}\right|^{2} d x d s+\frac{1}{2} \int_{\Omega} W_{u}^{2}(x, t) d x=\int_{t}^{T} \int_{\Omega}\left(\sum_{j=1}^{N}\left(W_{u}\right)_{j} \frac{\partial F}{\partial u_{j}}(u)\right): \nabla_{x} W_{u} d x d s \tag{4.17}
\end{equation*}
$$

In particular there exists $C>0$, independent of $t$, such that

$$
\begin{aligned}
\int_{t}^{T} \int_{\Omega}\left|\nabla_{x} W_{u}\right|^{2} d x d s \leq \int_{t}^{T} & \int_{\Omega}\left(\sum_{j=1}^{N}\left(W_{u}\right)_{j} \frac{\partial F}{\partial u_{j}}(u)\right): \nabla_{x} W_{u} d x d s \\
& \leq C\left(\int_{t}^{T} \int_{\Omega}\left|\nabla_{x} W_{u}\right|^{2} d x d s \cdot \int_{t}^{T} \int_{\Omega}\left|W_{u}\right|^{2} d x d s\right)^{1 / 2}
\end{aligned}
$$

So

$$
\begin{equation*}
\int_{t}^{T} \int_{\Omega}\left|\nabla_{x} W_{u}\right|^{2} d x d s \leq C^{2} \int_{t}^{T} \int_{\Omega}\left|W_{u}\right|^{2} d x d s \tag{4.18}
\end{equation*}
$$

Then, using (4.17) and (4.18) we obtain

\begin{align*}
& \frac{1}{2} \int_{\Omega} W_{u}^{2}(x, t) d x \leq \int_{t}^{T} \int_{\Omega}\left(\sum_{j=1}^{N}\left(W_{u}\right)_{j} \frac{\partial F}{\partial u_{j}}(u)\right): \nabla_{x} W_{u} d x d s  \tag{4.19}\\
\leq & C\left(\int_{t}^{T} \int_{\Omega}\left|\nabla_{x} W_{u}\right|^{2} d x d s \cdot \int_{t}^{T} \int_{\Omega}\left|W_{u}\right|^{2} d x d s\right)^{1 / 2} \leq C^{2} \int_{t}^{T} \int_{\Omega}\left|W_{u}\right|^{2} d x d s
\end{align*}
$$

Then by Gronwall's Lemma $\int_{\Omega} W_{u}^{2}(x, t) d x=0$. So, by definition of $W_{u}$ we obtain $H_{u}=u$. This completes the proof.

Theorem 4.1. For every $v_{0}(\cdot) \in V_{N}$ there exists a minimizer $u$ to (4.4). It satisfies $H_{u}=u$, i.e.

\Delta_{x} u=\partial_{t} u+\operatorname{div}_{x} F(u)+\nabla_{x} p
$$

$u(x, 0)=v_{0}(x)$ and

$$
\begin{equation*}
\frac{1}{2} \int_{\Omega} u^{2}(x, \tau) d x+\int_{0}^{\tau} \int_{\Omega}\left|\nabla_{x} u\right|^{2} d x d t=\frac{1}{2} \int_{\Omega} v_{0}^{2}(x) d x \quad \forall \tau \in[0, T] \tag{4.20}
\end{equation*}
$$

Moreover if $v \in \mathcal{R}$ satisfy $v(\cdot, 0)=v_{0}(\cdot)$ and $H_{v}=v$, i.e. $\Delta_{x} v=\partial_{t} v+\operatorname{div} v_{x} F(v)+\nabla_{x} p$, then $v$ is a minimizer to (4.4).

Proof. First of all we want to note that the set $A_{v_{0}}:=\left\{u \in \mathcal{R}: u(\cdot, 0)=v_{0}(\cdot)\right\}$ is not empty. In particular the function $u_{0}(\cdot, t):=v_{0}(\cdot)$ belongs to $A_{v_{0}}$. Let

K:=\inf _{u \in A_{v_{0}}} I_{F}(u)
$$

Then $K \geq 0$. Consider the minimizing sequence $\left\{u_{n}\right\} \subset A_{v_{0}}$, i.e. the sequence such that $\lim _{n \rightarrow \infty} I_{F}\left(u_{n}\right)=K$. Then, by the definition of $I_{F}$ in (4.3), we obtain that there exists $C>0$, independent of $n$, such that

\int_{0}^{T} \int_{\Omega}\left(\left|\nabla_{x} u_{n}\right|^{2}+\left|\nabla_{x} H_{u_{n}}\right|^{2}\right) d x d t \leq C \tag{4.21}

Then up to a subsequence,
(4.22) $\quad u_{n} \rightharpoonup u_{0} \quad$ weakly in $L^{2}\left(0, T ; V_{N}\right) \quad$ and $H_{u_{n}} \rightharpoonup \bar{H} \quad$ weakly in $L^{2}\left(0, T ; V_{N}\right)$.

From the other hand, by Corollary 4.2, for every $t \in[0, T]$ we have

Therefore, since, $u_{n}$ and $H_{u_{n}}$ are bounded in $L^{2}\left(0, T ; V_{N}\right)$ by (4.21) and $u_{n}(\cdot, 0)=v_{0}(\cdot)$ we obtain that there exists $C>0$ independent of $n$ and $t$ such that

In particular, up to a further subsequence $F\left(u_{n}\right) \rightharpoonup \bar{F}$ weakly in $L^{2}\left(\Omega \times(0, T), \mathbb{R}^{N \times N}\right)$. Then by (4.22) and (2.2), for every $t \in[0, T]$ and for every $\phi \in \mathcal{V}_{N}$, we have

& \lim _{n \rightarrow \infty}\left(\int_{\Omega} u_{n}(x, 0) \cdot \phi(x) d x-\int_{0}^{t} \int_{\Omega} \nabla_{x} H_{u_{n}}: \nabla_{x} \phi+\int_{0}^{t} \int_{\Omega} F\left(u_{n}\right): \nabla_{x} \phi\right) \\
& \quad=\int_{\Omega} v_{0}(x) \cdot \phi(x) d x-\int_{0}^{t} \int_{\Omega} \nabla_{x} \bar{H}: \nabla_{x} \phi+\int_{0}^{t} \int_{\Omega} \bar{F}: \nabla_{x} \phi .
\end{align*}
$$

Since $\mathcal{V}_{N}$ is dense in $L_{N}$, by (4.23), and (4.24), for every $t \in[0, T]$ there exists $u(\cdot, t) \in L_{N}$ such that

u_{n}(\cdot, t) \rightharpoonup u(\cdot, t) \quad \text { weakly in } L_{N} \quad \forall t \in[0, T] . \tag{4.25}

Moreover, $\|u(\cdot, t)\|_{L_{N}} \leq C$. But we have $u_{n} \rightharpoonup u_{0}$ weakly in $L^{2}\left(0, T ; L_{N}\right)$, therefore $u=u_{0}$ a.e. and so $u \in L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$. Then using (4.23), (4.22), (4.25) and Lemma 2.2 we deduce that

Moreover, by (4.24) we obtain that $u(\cdot, t)$ is $L_{N}$-weakly continuous in $t$ on $[0, T]$. Therefore, by (4.25) and (4.22),

\int_{0}^{T} \int_{\Omega}\left|\nabla_{x} u\right|^{2} d x d t+\int_{\Omega}|u(x, T)|^{2} d x \leq \lim _{n \rightarrow \infty}\left(\int_{0}^{T} \int_{\Omega}\left|\nabla_{x} u_{n}\right|^{2} d x d t+\int_{\Omega}\left|u_{n}(x, T)\right|^{2} d x\right) . \tag{4.27}
\end{equation*}
$$

Next for every $\psi(x, t) \in C_{c}^{\infty}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$ such that $\operatorname{div}_{x} \psi=0$ we obtain

\begin{align*}
& \lim _{n \rightarrow \infty} \int_{0}^{T} \int_{\Omega}\left(u_{n} \cdot \partial_{t} \psi+F\left(u_{n}\right): \nabla_{x} \psi\right) d x d t=  \tag{4.28}\\
& \lim _{n \rightarrow \infty} \int_{0}^{T} \int_{\Omega} \nabla_{x} H_{u_{n}}: \nabla_{x} \psi d x d t=\int_{0}^{T} \int_{\Omega} \nabla_{x} \bar{H}: \nabla_{x} \psi d x d t
\end{align*}
$$

But since $F$ is a Lipschitz function, by (4.26) we obtain

\lim _{n \rightarrow \infty} \int_{0}^{T} \int_{\Omega}\left(u_{n} \cdot \partial_{t} \psi+F\left(u_{n}\right): \nabla_{x} \psi\right) d x d t=\int_{0}^{T} \int_{\Omega}\left(u \cdot \partial_{t} \psi+F(u): \nabla_{x} \psi\right) d x d t
$$

So, by (4.28), for every $\psi(x, t) \in C_{c}^{\infty}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$ such that $d i v_{x} \psi=0$ we deduce

\int_{0}^{T} \int_{\Omega}\left(u \cdot \partial_{t} \psi+F(u): \nabla_{x} \psi\right) d x d t=\int_{0}^{T} \int_{\Omega} \nabla_{x} \bar{H}: \nabla_{x} \psi d x d t \tag{4.29}
\end{equation*}
$$

In particular $\partial_{t} u+\operatorname{div}_{x} F(u) \in L^{2}\left(0, T ; V_{N}^{-1}\right)$. Therefore $\partial_{t} u \in L^{2}\left(0, T ; V_{N}^{-1}\right)$ and then $u \in A_{v_{0}}=\left\{u \in \mathcal{R}: u(\cdot, 0)=v_{0}(\cdot)\right\}$. Moreover, by (4.29), we obtain that $H_{u}=\bar{H}$.
So, as before,

\int_{0}^{T} \int_{\Omega}\left|\nabla_{x} H_{u}\right|^{2} d x d t \leq \lim _{n \rightarrow \infty} \int_{0}^{T} \int_{\Omega}\left|\nabla_{x} H_{u_{n}}\right|^{2} d x d t \tag{4.30}
\end{equation*}
$$

Combining (4.30) with (4.27), we infer

I_{F}(u) \leq \lim _{n \rightarrow \infty} I_{F}\left(u_{n}\right)=K
$$

Therefore, $u$ is a minimizer to (4.4). By Lemma 4.3 it satisfies $H_{u}=u$, i.e.

$$

Moreover, by Lemma 4.1, for every $t \in[0, T]$ we have

\int_{0}^{t} \int_{\Omega} \nabla_{x} u: \nabla_{x} H_{u}=\frac{1}{2}\left(\int_{\Omega} v_{0}^{2}(x) d x-\int_{\Omega} u^{2}(x, t) d x\right) .
$$

Therefore we obtain (4.20). Moreover, $I_{F}(u)=\frac{1}{2} \int_{\Omega} v_{0}^{2}(x) d x$. Finally if $v \in \mathcal{R}$ satisfy $v(\cdot, 0)=v_{0}(\cdot)$ and $H_{v}=v$ then by (4.5) we have $I_{F}(v)=\frac{1}{2} \int_{\Omega} v_{0}^{2}(x) d x=I_{F}(u)$. So $v$ is a minimizer to (4.4).

Remark 4.2. For a fixed $r(x, t) \in L^{2}\left(0, T ; V_{N}\right)$ we can define a functional $\bar{I}_{\{F, r\}}(u)$ : $\mathcal{R} \rightarrow \mathbb{R}$ by

\bar{I}_{\{F, r\}}(u):=\frac{1}{2}\left(\int_{0}^{T} \int_{\Omega}\left(\left|\nabla_{x} u+\nabla_{x} r\right|^{2}+\left|\nabla_{x} H_{u}-\nabla_{x} r\right|^{2}\right) d x d t+\int_{\Omega}|u(x, T)|^{2} d x\right) \tag{4.31}
\end{equation*}
$$

and for every $v_{0} \in V_{N}$ we can consider the minimization problem

$$
\begin{equation*}
\inf \left\{\bar{I}_{\{F, r\}}(u): u \in \mathcal{R}, u(\cdot, 0)=v_{0}(\cdot)\right\} \tag{4.32}
\end{equation*}
$$

Then similarly to the proof of Theorem 4.1 we can prove that there exists a minimizer $u$ to (4.32) and it satisfies $H_{u}=u+r$, i.e.

\Delta_{x} u+\Delta_{x} r=\partial_{t} u+d i v_{x} F(u)+\nabla_{x} p .
$$

Then, using this fact, as in the proof of Theorem 3.1 we can deduce the existence of a weak solution to (1.1) with $f \in L^{2}\left(0, T ; V_{N}^{-1}\right)$.

Remark 4.3. Similar method as in the proof of Theorem 3.1 we can apply to the unbounded domain $\Omega$. In this case we consider a sequence of smooth bounded domains $\left\{\Omega_{n}\right\}$, such that $\Omega_{n} \subset \Omega_{n+1}$ and $\bigcup_{n=1}^{\infty} \Omega_{n}=\Omega$, and a sequence $v_{0}^{(n)} \rightarrow v_{0}$ in $L_{N}$, such that supp $v_{0}^{(n)} \subset \Omega_{n}$. Consider $u_{n}(x, t) \in \mathcal{R}\left(\Omega_{n}\right)$, such that $u_{n}(\cdot, 0)=v_{0}^{(n)}(\cdot)$ and for every $\psi(x, t) \in C_{c}^{\infty}\left(\Omega_{n} \times(0, T), \mathbb{R}^{N}\right)$, satisfying $\operatorname{div}_{x} \psi=0$, we have (3.5), where $F_{n}$ is defined by (3.4). Then we can deduce that there exists $u \in L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$ such that, up to a subsequence, $u_{n} \rightarrow u$ strongly in $L_{l o c}^{2}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$. Then $u$ will satisfy conditions of Theorem 3.1.

## 5. Variational principle for more regular solutions of the Navier-Stokes Equations

Let $\Omega \subset \mathbb{R}^{N}$ be a domain with Lipschitz boundary (not necessarily bounded). We denote by $H_{N}$ the closure of $\mathcal{V}_{N}$ in $H_{0}^{1}\left(\Omega, \mathbb{R}^{N}\right)$ (the spaces $H_{N}$ and $V_{N}$ differ only in the case of unbounded domain). For every $u \in L^{4}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$ we have
$(u \otimes u) \in L^{2}\left(0, T ; L^{2}\left(\Omega, \mathbb{R}^{N \times N}\right)\right)$ and therefore $\operatorname{div}_{x}(u \otimes u) \in L^{2}\left(0, T ; V_{N}^{-1}\right)$. If in addition $\partial_{t} u \in L^{2}\left(0, T ; V_{N}^{-1}\right)$ then we obtain $\partial_{t} u+\operatorname{div}_{x}(u \otimes u) \in L^{2}\left(0, T ; V_{N}^{-1}\right)$.

Definition 5.1. Let $u \in L^{2}\left(0, T ; H_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$ be such that $\partial_{t} u \in L^{2}\left(0, T ; V_{N}^{-1}\right)$ and such that $u(\cdot, t)$ is $L_{N}$-weakly continuous in $t$ on $[0, T]$. Denote the set of all such functions $u$ by $\mathcal{R}^{\prime}$. Denote the set $\mathcal{R}^{\prime} \cap L^{4}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$ by $\mathcal{P}$. For every $u \in \mathcal{P}$ let $\bar{H}_{u}(\cdot, t) \in L^{2}\left(0, T ; V_{N}\right)$ be as in Remark 2.2, corresponding to $\partial_{t} u+\operatorname{div}_{x}(u \otimes u)$. That is for every $\psi(x, t) \in C_{c}^{\infty}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$ such that $\operatorname{div}_{x} \psi=0$ we have

$$
\int_{0}^{T} \int_{\Omega}\left(u \cdot \partial_{t} \psi+(u \otimes u): \nabla_{x} \psi\right) d x d t=\int_{0}^{T} \int_{\Omega} \nabla_{x} \bar{H}_{u}: \nabla_{x} \psi d x d t
$$

For a fixed $r(x, t) \in L^{2}\left(0, T ; V_{N}\right)$ define a functional $J_{\{\varphi, r\}}(u): \mathcal{P} \rightarrow \mathbb{R}$ by

$$
\begin{equation*}
J_{\{\varphi, r\}}(u):=\frac{1}{2}\left(\int_{0}^{T} \int_{\Omega}\left(\left|\nabla_{x} u+\nabla_{x} r\right|^{2}+\left|\nabla_{x} \bar{H}_{u}-\nabla_{x} r\right|^{2}\right) d x d t+\int_{\Omega}|u(x, T)|^{2} d x\right) . \tag{5.1}
\end{equation*}
$$

Theorem 5.1. Let $v_{0} \in L_{N}$ and $r(x, t) \in L^{2}\left(0, T ; V_{N}\right)$. Assume that there exists $u \in \mathcal{P}$ which satisfies $u(x, 0)=v_{0}(x)$, and

$$
\begin{equation*}
\int_{0}^{T} \int_{\Omega}\left(u \cdot \partial_{t} \psi+(u \otimes u): \nabla_{x} \psi\right) d x d t=\int_{0}^{T} \int_{\Omega}\left(\nabla_{x} u+\nabla_{x} r\right): \nabla_{x} \psi d x d t \tag{5.2}
\end{equation*}
$$

for every $\psi(x, t) \in C_{c}^{\infty}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$, such that div$x_{x} \psi=0$, i.e.

$$
\Delta_{x} u=\partial_{t} u+\operatorname{div}_{x}(u \otimes u)+\nabla_{x} p-\Delta_{x} r .
$$

Then $u$ is a minimizer of the following problem

$$
\begin{equation*}
\inf \left\{J_{\{\varphi, r\}}(u): u \in \mathcal{P}, u(\cdot, 0)=v_{0}(\cdot)\right\} . \tag{5.3}
\end{equation*}
$$

Moreover if $\bar{u}$ is a minimizer to (5.3), then $\bar{u}$ is a solution to (5.2).

Proof. In the same way as in the proof of Theorem 4.1 in [2] we obtain that for every $\bar{u} \in \mathcal{P}$ we must have

$$
\begin{equation*}
\int_{0}^{T} \int_{\Omega} \nabla_{x} \bar{u}: \nabla_{x} H_{\bar{u}} d x d t=\frac{1}{2}\left(\int_{\Omega} \bar{u}^{2}(x, 0) d x-\int_{\Omega} \bar{u}^{2}(x, T) d x\right) . \tag{5.4}
\end{equation*}
$$

Therefore,

$$
\begin{equation*}
J_{\{\varphi, r\}}(\bar{u})=\frac{1}{2} \int_{0}^{T} \int_{\Omega}\left(\left|\nabla_{x} \bar{u}+\nabla_{x} r-\nabla_{x} H_{\bar{u}}\right|^{2}+\left|\nabla_{x} r\right|^{2}\right) d x d t+\frac{1}{2} \int_{\Omega} \bar{u}^{2}(x, 0) d x . \tag{5.5}
\end{equation*}
$$

Therefore, $u \in \mathcal{P}$ which satisfy $u(x, 0)=v_{0}(x)$ and $\nabla_{x} u+\nabla_{x} r=\nabla_{x} H_{u}$ will be the minimizer to (5.3). Then also every minimizer $\bar{u}$ will satisfy $\nabla_{x} \bar{u}+\nabla_{x} r=\nabla_{x} H_{\bar{u}}$, i.e. will satisfy (5.2).

## Appendix A.

Proof of Lemma 2.2. Since for every $n=0,1, \ldots$ and every $t \in(0, T)$ the functional $l_{n, t}(\phi):=\int_{\Omega} u_{n}(x, t) \cdot \phi(x) d x$ is bounded in $H_{0}^{1}\left(\Omega, \mathbb{R}^{N}\right)$, by Rietz Representation Theorem for every $n=0,1, \ldots$ and every $t \in[0, T]$ there exists $w_{n}(\cdot, t) \in H_{0}^{1}\left(\Omega, \mathbb{R}^{N}\right)$ such that

l_{n, t}(\phi)=\int_{\Omega} u_{n}(x, t) \cdot \phi(x) d x=\int_{\Omega} \nabla_{x} w_{n}(x, t): \nabla_{x} \phi(x) d x \quad \forall \phi \in H_{0}^{1}\left(\Omega, \mathbb{R}^{N}\right) \tag{A.1}
\end{equation*}
$$

Equation (A.1) gives in particular

\int_{\Omega} u_{n}(x, t) \cdot w_{n}(x, t) d x=\int_{\Omega}\left|\nabla_{x} w_{n}(x, t)\right|^{2} d x \tag{A.2}
\end{equation*}
$$

Then we obtain that there exist $C_{0}, C>0$, independent of $n$ and $t$, such that

\int_{\Omega}\left|\nabla_{x} w_{n}(x, t)\right|^{2} d x \leq C_{0} \int_{\Omega}\left|u_{n}(x, t)\right|^{2} d x \leq C \tag{A.3}
\end{equation*}

Moreover, using (2.4), (A.2) and the compact embedding of $H_{0}^{1}\left(\Omega, \mathbb{R}^{N}\right)$ into $L^{2}\left(\Omega, \mathbb{R}^{N}\right)$, we obtain

We have $w_{n}(\cdot, \cdot) \in L^{2}\left(0, T ; H_{0}^{1}\left(\Omega, \mathbb{R}^{N}\right)\right)$ and moreover, by (A.4) and (A.3), we obtain

& \lim _{n \rightarrow \infty} \int_{0}^{T} \int_{\Omega}\left|u_{n}(x, t)\right|^{2} d x d t=\lim _{n \rightarrow \infty} \int_{0}^{T} \int_{\Omega} \nabla_{x} w_{n}(x, t): \nabla_{x} u_{n}(x, t) d x d t  \tag{A.7}\\
&=\int_{0}^{T} \int_{\Omega} \nabla_{x} w_{0}(x, t): \nabla_{x} u_{0}(x, t) d x d t=\int_{0}^{T} \int_{\Omega}\left|u_{0}(x, t)\right|^{2} d x d t
\end{align*}
$$

But by (2.3) we have

$$
\begin{equation*}
u_{n} \rightharpoonup u_{0} \quad \text { weakly in } L^{2}\left(0, T ; L_{N}\right) . \tag{A.8}
\end{equation*}
$$

Therefore, by (A.8) and (A.7) we obtain (2.5).

Proof of Corollary 4.1. Let $\eta \in C_{c}^{\infty}(\mathbb{R}, \mathbb{R})$ be a mollifying kernel, satisfying $\eta \geq 0$, $\int_{\mathbb{R}} \eta(t) d t=1, \operatorname{supp} \eta \subset[-1,1]$ and $\eta(-t)=\eta(t) \forall t$. Given small $\varepsilon>0$ and $\psi(x, t) \in$ $C_{c}^{\infty}\left(\Omega \times(2 \varepsilon, T-2 \varepsilon), \mathbb{R}^{N}\right)$ such that $\operatorname{div}_{x} \psi=0$, define

$$
\begin{equation*}
\psi_{\varepsilon}(x, t):=\frac{1}{\varepsilon} \int_{0}^{T} \eta\left(\frac{s-t}{\varepsilon}\right) \psi(x, s) d s \tag{A.9}
\end{equation*}
$$

Then $\psi_{\varepsilon}(x, t) \in C_{c}^{\infty}\left(\Omega \times(0, T), \mathbb{R}^{N}\right)$ and satisfies $\operatorname{div}_{x} \psi_{\varepsilon}=0$. Therefore we obtain

$$
\begin{equation*}
\int_{0}^{T} \int_{\Omega} u \cdot \partial_{t} \psi_{\varepsilon} d x d t=\int_{0}^{T} \int_{\Omega} \nabla_{x} V_{u}: \nabla_{x} \psi_{\varepsilon} d x d t \tag{A.10}
\end{equation*}
$$

where $V_{u}(\cdot, t) \in L^{2}\left(0, T ; V_{N}\right)$ is as in Remark 2.2, corresponding to $\partial_{t} u$. But

$$
\begin{aligned}
& \quad \int_{0}^{T} \int_{\Omega} u \cdot \partial_{t} \psi_{\varepsilon} d x d t=\int_{0}^{T} \int_{\Omega} u(x, t) \cdot\left(\frac{1}{\varepsilon} \int_{0}^{T} \eta\left(\frac{s-t}{\varepsilon}\right) \partial_{s} \psi(x, s) d s\right) d x d t= \\
& \int_{0}^{T} \int_{\Omega} \partial_{t} \psi(x, t) \cdot\left(\frac{1}{\varepsilon} \int_{0}^{T} \eta\left(\frac{s-t}{\varepsilon}\right) u(x, s) d s\right) d x d t=\int_{0}^{T} \int_{\Omega} \partial_{t} \psi(x, t) \cdot u_{\varepsilon}(x, t) d x d t
\end{aligned}
$$

where $u_{\varepsilon}(x, t)=\frac{1}{\varepsilon} \int_{0}^{T} \eta((s-t) / \varepsilon) u(x, s) d s$. By the other hand

$$
\begin{array}{r}
\int_{0}^{T} \int_{\Omega} \nabla_{x} V_{u}: \nabla_{x} \psi_{\varepsilon} d x d t=\int_{0}^{T} \int_{\Omega} \nabla_{x} V_{u}(x, t):\left(\frac{1}{\varepsilon} \int_{0}^{T} \eta\left(\frac{s-t}{\varepsilon}\right) \nabla_{x} \psi(x, s) d s\right) d x d t \\
=\int_{0}^{T} \int_{\Omega} \nabla_{x} \psi(x, t): \nabla_{x}\left(\frac{1}{\varepsilon} \int_{0}^{T} \eta\left(\frac{s-t}{\varepsilon}\right) V_{u}(x, s) d s\right) d x d t \\
=\int_{0}^{T} \int_{\Omega} \nabla_{x} \psi(x, t): \nabla_{x}\left(V_{u}\right)_{\varepsilon}(x, t) d x d t
\end{array}
$$

where $\left(V_{u}\right)_{\varepsilon}(x, t)=\frac{1}{\varepsilon} \int_{0}^{T} \eta((s-t) / \varepsilon) V_{u}(x, s) d s$. Therefore, by (A.10), we infer

$$
\begin{equation*}
\int_{0}^{T} \int_{\Omega} u_{\varepsilon} \cdot \partial_{t} \psi d x d t=\int_{0}^{T} \int_{\Omega} \nabla_{x}\left(V_{u}\right)_{\varepsilon}: \nabla_{x} \psi d x d t \tag{A.11}
\end{equation*}
$$

So $\partial_{t} u_{\varepsilon} \in L^{2}\left(2 \varepsilon, T-2 \varepsilon ; V_{N}^{-1}\right)$. Moreover $u_{\varepsilon} \in L^{2}\left(0, T ; V_{N}\right) \cap L^{\infty}\left(0, T ; L_{N}\right)$. We have $u_{\varepsilon} \rightarrow u$ and $\left(V_{u}\right)_{\varepsilon} \rightarrow V_{u}$ strongly in $L^{2}\left(0, T ; V_{N}\right)$ as $\varepsilon \rightarrow 0$. Moreover, up to a subsequence $\varepsilon_{n} \rightarrow 0$, we have $u_{\varepsilon_{n}}(\cdot, t) \rightarrow u(\cdot, t)$ strongly in $L_{N}$ a.e. in $[0, T]$. In addition, by Lemma 4.1, for every $a, b \in[2 \varepsilon, T-2 \varepsilon]$ we have

$$
\begin{equation*}
\int_{a}^{b} \int_{\Omega} \nabla_{x} u_{\varepsilon}: \nabla_{x}\left(V_{u}\right)_{\varepsilon} d x d t=\frac{1}{2}\left(\int_{\Omega} u_{\varepsilon}^{2}(x, a) d x-\int_{\Omega} u_{\varepsilon}^{2}(x, b) d x\right) . \tag{A.12}
\end{equation*}
$$

Then letting $\varepsilon \rightarrow 0$ in (A.12), we obtain that for almost every $a$ and $b$ in $(0, T)$ we have

$$
\int_{a}^{b} \int_{\Omega} \nabla_{x} u: \nabla_{x} V_{u} d x d t=\frac{1}{2}\left(\int_{\Omega} u^{2}(x, a) d x-\int_{\Omega} u^{2}(x, b) d x\right) .
$$

So $u \in L^{\infty}\left(0, T ; L_{N}\right)$.
