# Nichols algebras over classical Weyl groups(II)

#### Abstract

It is shown that except in three cases conjugacy classes of classical Weyl groups $W\left(B_{n}\right)$ and $W\left(D_{n}\right)$ are of type D . This proves that Nichols algebras of irreducible Yetter-Drinfeld modules over the classical Weyl groups $\mathbb{W}_{n}\left(\right.$ i.e. $H_{n} \rtimes \mathbb{S}_{n}$ ) are infinite dimensional, except the class of type $(2,3),\left(1^{2}, 3\right)$ in $\mathbb{S}_{5}$, and $\left(1^{n-2}, 2\right)$ in $\mathbb{S}_{n}$ for $n>5$.

## 1 Introduction

This work contributes to the classification of finite-dimensional pointed Hopf algebras over an algebraically closed field of characteristic 0 . Those over finite abelian groups are relatively clear due to the work of Andruskiewitsch, Schneider, Heckenberger,see [4], [7, [8], etc. However not much is known about those over nonabelian groups. Given a group $G$, an important step to classify all finite-dimensional pointed Hopf algebras $H$ with group-like $G(H)=G$ is to determine all the pairs $(\mathcal{O}, \rho)$ such that the associated Nichols algebra $\mathfrak{B}(\mathcal{O}, \rho)$ is finite-dimensional. In general, it is often useful to discard those pairs such that $\operatorname{dim} \mathfrak{B}(\mathcal{O}, \rho)=\infty$. There are properties of the conjugacy class $\mathcal{O}$ that imply that $\operatorname{dim} \mathfrak{B}(\mathcal{O}, \rho)=\infty$ for any $\rho$, one of which is the property of being of type D . This is useful since it reduces the computations to operations inside the group and avoids hard calculations of generators and relations of the corresponding Nichols algebra.

Nichols algebras of braided vector spaces $\left(\mathbb{C} X, c_{q}\right)$, where $X$ is a rack and $q$ is a 2cocycle in $X$, were studied in [3]. It was shown [1, 2, 5] that Nichols algebras $\mathfrak{B}\left(\mathcal{O}_{\sigma}, \rho\right)$ over symmetry groups are infinite dimensional, except in a number of remarkable cases
corresponding to $\mathcal{O}_{\sigma}$. The present paper aims to classify finite-dimensional Nichols algebra over the classical Weyl groups. Obviously, $S_{n}$ is isomorphic to Weyl group of $A_{n-1}$ for $n>1$. We give the following result for completeness.

Theorem ([1, Th. 1.1]) Let $n \geq 5$. Let $\sigma \in \mathbb{S}_{n}$ be of type $\left(1^{m_{1}}, 2^{m_{2}}, \ldots, n^{m_{n}}\right)$, let $\mathcal{O}_{\sigma}$ be the conjugacy class of $\sigma$ and let $\rho=(\rho, V) \in \widehat{S_{n}{ }^{\sigma}}$. If $\operatorname{dim} \mathfrak{B}\left(\mathcal{O}_{\sigma}, \rho\right)<\infty$, then the type of $\sigma$ and $\rho$ are in the following list:
(i) $\left(1^{n_{1}}, 2\right), \rho_{1}=\operatorname{sgn}$ or $\epsilon, \rho_{2}=\operatorname{sgn}$.
(ii) $(2,3)$ in $\mathbb{S}_{5}, \rho_{2}=\operatorname{sgn}, \rho_{3}=\overrightarrow{\chi_{0}}$.
(iii) $\left(2^{3}\right)$ in $\mathbb{S}_{6}, \rho_{2}=\overrightarrow{\chi_{1}} \otimes \epsilon$ or $\overrightarrow{\chi_{1}} \otimes \operatorname{sgn}$.

In [10] they showed that except in several cases Nichols algebras of irreducible YetterDrinfeld (YD in short) modules over classical Weyl groups $A \rtimes \mathbb{S}_{n}$ supported by $\mathbb{S}_{n}$ are infinite dimensional. One of the present author [11] showed that except in several cases conjugacy classes of classical Weyl groups $W\left(B_{n}\right)$ and $W\left(D_{n}\right)$ are of type D , they prove that except in several cases Nichols algebras of irreducible Yetter-Drinfeld modules over the classical Weyl groups are infinite dimensional. However, the classification has not been completed for Nichols algebras over classic Weyl groups $W\left(B_{n}\right)$ and $W\left(D_{n}\right)$.

Note that $\mathbb{Z}_{2}^{n} \rtimes \mathbb{S}_{n}$ is isomorphic to Weyl groups $W\left(B_{n}\right)$ and $W\left(C_{n}\right)$ of $B_{n}$ and $C_{n}$ for $n>2$. If $K_{n}=\left\{a \in \mathbb{Z}_{2}^{n} \mid a=\left(a_{1}, a_{2}, \cdots, a_{n}\right)\right.$ with $\left.a_{1}+a_{2}+\cdots+a_{n} \equiv 0(\bmod 2)\right\}$, then $K_{n} \rtimes \mathbb{S}_{n}$ is isomorphic to Weyl group $W\left(D_{n}\right)$ of $D_{n}$ for $n>3$ and $K_{n} \rtimes \mathbb{S}_{n}$ is a subgroup of $\mathbb{Z}_{2}^{n} \rtimes \mathbb{S}_{n}$. Let $\mathbb{W}_{n}$ denote $H_{n} \rtimes \mathbb{S}_{n}$ throughout this paper, where $H_{n}:=K_{n}$ or $\mathbb{Z}_{2}^{n}$. Here is our main result.

Theorem 4.3 Assume $n \geq 5$. Let $\sigma \in \mathbb{S}_{n}$ be of type ( $1^{m_{1}}, 2^{m_{2}}, \ldots, n^{m_{n}}$ ) and $a \in H_{n}$ with $a \sigma \in \mathbb{W}_{n}$ and $\sigma \neq 1$. If $\operatorname{dim} \mathfrak{B}\left(\mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}, \rho\right)<\infty$, then the type of $\sigma$ belongs to one in the following list:
(i) $(2,3)$;
(ii) $\left(1^{2}, 3\right)$;
(iii) $\left(1^{n-2}, 2\right)$ for $n>5$ with $a_{i}=a_{j}$ when $\sigma(i)=i$ and $\sigma(j)=j$.

Note that $\mathbb{S}_{n}$ acts on $H_{n}$ as follows: for any $a \in H_{n}$ with $a=\left(a_{1}, a_{2}, \cdots, a_{n}\right)$ and $\sigma, \tau \in \mathbb{S}_{n}, \sigma(a):=\left(a_{\sigma^{-1}(1)}, a_{\sigma^{-1}(2)}, \cdots, a_{\sigma^{-1}(n)}\right)$.

It is clear that

& (a, \sigma)^{-1}=\left(-\left(a_{\sigma(1)}, a_{\sigma(2)}, \cdots, a_{\sigma(n)}\right), \sigma^{-1}\right)=\left(-\sigma^{-1}(a), \sigma^{-1}\right), \\
& (b, \tau)(a, \sigma)(b, \tau)^{-1}=\left(b+\tau(a)-\tau \sigma \tau^{-1}(b), \tau \sigma \tau^{-1}\right)
\end{aligned}
$$

Let $a \sigma$ denote $(a, \sigma)$ in short, sometimes. When we say type D we mean a rack or conjugacy class of type D and not a Weyl group of type $D_{n}$. The other notations are the same as in [11.

In this paper we prove that except in three cases conjugacy classes of classical Weyl groups $W\left(B_{n}\right)$ and $W\left(D_{n}\right)$ are of type D. This proves that Nichols algebras of irreducible Yetter-Drinfeld modules over the classical Weyl groups $\mathbb{W}_{n}$ are infinite dimensional, except the class of type $(2,3),\left(1^{2}, 3\right)$ in $\mathbb{S}_{5}$, and $\left(1^{n-2}, 2\right)$ with $a_{i}=a_{j}$ when $\sigma(i)=i$ and $\sigma(j)=j$ in $\mathbb{S}_{n}$ for $n>5$.

The work is organized as follows. In Section 2 we provide some preliminaries and set our notations. In Section 3 we examine the rack and conjugacy classes of $\mathbb{W}_{n}$. In Section 4 we classify Nichols algebras of irreducible YD modules over the classical Weyl groups, finally we give a Conjecture: Assume $n \geq 5$. then $\operatorname{dim} \mathfrak{B}\left(\mathcal{O}_{a \sigma}^{W_{n}}, \rho\right)=\infty$ for $a \sigma \in \mathbb{W}_{n}$ with $\sigma \in \mathbb{S}_{n}, \sigma \neq 1$ and $a \in H_{n}$.

## 2 Preliminaries

Let $\mathbb{K}$ be an algebraically closed field of characteristic zero and $(V, C)$ a braided vector space, i.e. $V$ is a vector space over $\mathbb{K}$ and $C \in \operatorname{Aut}(V \otimes V)$ is a solution of the braid equation $\left(\mathrm{id} \otimes C_{V, V}\right)\left(C_{V, V} \otimes \mathrm{id}\right)\left(\mathrm{id} \otimes C_{V, V}\right)=\left(C_{V, V} \otimes \mathrm{id}\right)\left(\mathrm{id} \otimes C_{V, V}\right)\left(C_{V, V} \otimes \mathrm{id}\right) . C_{i, i+1}:=$ $\mathrm{id}^{\otimes i-1} \otimes C_{V, V} \otimes \mathrm{id}^{\otimes n-i-1}$. Let $S_{m} \in \operatorname{End}_{\mathbb{K}}\left(V^{\otimes m}\right)$ and $S_{1, j} \in \operatorname{End}_{\mathbb{K}}\left(V^{\otimes(j+1)}\right)$ denote the maps $S_{m}=\prod_{j=1}^{m-1}\left(\mathrm{id}^{\otimes-j-1} \otimes S_{1, j}\right), S_{1, j}=\mathrm{id}+C_{12}^{-1}+C_{12}^{-1} C_{23}^{-1}+\cdots+C_{12}^{-1} C_{23}^{-1} \cdots C_{j, j+1}^{-1}$ (in leg notation) for $m \geq 2$ and $j \in \mathbb{N}$. Then the subspace $S=\bigoplus_{m=2}^{\infty} \operatorname{ker} S_{m}$ of the tensor $T(V)=\bigoplus_{m=0}^{\infty} V^{\otimes m}$ is a two-sided ideal, and algebra $\mathfrak{B}(V)=T(V) / S$ is termed the Nichols algebra associated to $(V, C)$.

For $s \in G$ and $(\rho, V) \in \widehat{G^{s}}$, here is a precise description of the YD module $M\left(\mathcal{O}_{s}, \rho\right)$, introduced in [6]. Let $t_{1}=s, t_{2}, \cdots, t_{m}$ be a numeration of $\mathcal{O}_{s}$, which is a conjugacy class containing $s$, and let $g_{i} \in G$ such that $g_{i} \triangleright s:=g_{i} s g_{i}^{-1}=t_{i}$ for all $1 \leq i \leq m$. Then $M\left(\mathcal{O}_{s}, \rho\right)=\oplus_{1 \leq i \leq m} g_{i} \otimes V$. Let $g_{i} v:=g_{i} \otimes v \in M\left(\mathcal{O}_{s}, \rho\right), 1 \leq i \leq m, v \in V$. If $v \in V$ and $1 \leq i \leq m$, then the action of $h \in G$ and the coaction are given by

where $h g_{i}=g_{j} \nu_{i}(h)$, for unique $1 \leq j \leq m$ and $\nu_{i}(h) \in G^{s}$. The explicit formula for the braiding is then given by

for any $1 \leq i, j \leq m, v, w \in V$, where $t_{i} g_{j}=g_{j^{\prime}} \nu_{j}\left(t_{i}\right)$ for unique $j^{\prime}, 1 \leq j^{\prime} \leq m$ and
$\nu_{j}\left(t_{i}\right) \in G^{s}$. Let $\mathfrak{B}\left(\mathcal{O}_{s}, \rho\right)$ denote $\mathfrak{B}\left(M\left(\mathcal{O}_{s}, \rho\right)\right) . M\left(\mathcal{O}_{s}, \rho\right)$ is a simple YD module (see [5]).

We briefly recall the definition and main properties of racks; see [3] for details, more information and bibliographical references. $A$ rack is a pair $(X, \triangleright)$, where $X$ is a nonempty set and $\triangleright: X \times X \rightarrow X$ is an operation such that $x \triangleright x=x, x \triangleright(y \triangleright z)=$ $(x \triangleright y) \triangleright(x \triangleright z)$ and $\phi_{x}$ is invertible for any $x, y, z \in X$, where $\phi_{x}$ is a map from $X$ to $X$ sending $y$ to $x \triangleright y$ for any $x, y \in X$. For example, $\left(\mathcal{O}_{s}^{G}, \triangleright\right)$ is a rack with $x \triangleright y:=x y x^{-1}$.

If $R$ and $S$ are two subracks of $X$ with $R \cup S=X, R \cap S=\emptyset, x \triangleright y \in S, y \triangleright x \in R$, for any $x \in R, y \in S$, then $R \cup S$ is called a decomposition of subracks of $X$. Furthermore, if there exist $a \in R, b \in S$ such that $\operatorname{sq}(a, b):=a \triangleright(b \triangleright(a \triangleright b)) \neq b$, then $X$ is called to be of type $D$. Notice that if a rack $Y$ contains a subrack $X$ of type D , then $Y$ is also of type D (see [1]).

## 3 Conjugacy classes of $\mathbb{W}_{n}$

In this section we prove that except in three cases conjugacy classes of classical Weyl groups $\mathbb{W}_{n}$ are of type $D$.

Lemma 3.1. ([11, Lem. 3.1(iii)]) Let $G=\mathbb{W}_{n}$ and $a \sigma, b \tau \in G$. If $\tau \sigma=\sigma \tau$, then $\mathrm{sq}(a \sigma, b \tau)=b \tau$ if and only if

furthermore, If $\tau \sigma=\sigma \tau$ and $\sigma^{2}=\tau^{2}=1$, then $\mathrm{sq}(a \sigma, b \tau)=b \tau$ if and only if

a+\sigma \tau(a)+\sigma(a)+\tau(a)=b+\sigma(b)+\tau(b)+\sigma \tau(b) . \tag{4}

Lemma 3.2. Let $a=\left(a_{1}, \ldots, a_{n}\right), b=\left(b_{1}, \ldots, b_{n}\right)$ and $\sum_{i=1}^{n} a_{i} \equiv \sum_{i=1}^{n} b_{i}(\bmod 2)$. Assume $a \sigma=\left(a^{(1)} \sigma_{1}\right)\left(a^{(2)} \sigma_{2}\right) \cdots\left(a^{(r)} \sigma_{r}\right)$ and $b \tau=\left(b^{(1)} \tau_{1}\right)\left(b^{(2)} \tau_{2}\right) \cdots\left(b^{(r)} \tau_{r}\right)$ are independent sign cycle decomposition (see [10, Theo. 5.4]) of $a \sigma, b \tau \in \mathbb{W}_{n}$, respectively. If the lengths of $\sigma_{i}, \tau_{i}$ are the same for all $1 \leq i \leq r$, then a $\sigma$ and $b \tau$ are conjugate in $\mathbb{W}_{n}$.
Proof. Assume $\mathbb{W}_{n}:=\mathbb{Z}_{2}^{n} \rtimes \mathbb{S}_{n}$. By $\sum_{i=1}^{n} a_{i} \equiv \sum_{i=1}^{n} b_{i}(\bmod 2)$, we have $\sum_{i=1}^{n}\left(a_{i}^{(1)}+a_{i}^{(2)}+\cdots+\right.$ $\left.a_{i}^{(r)}\right) \equiv \sum_{i=1}^{n}\left(b_{i}^{(1)}+b_{i}^{(2)}+\cdots+b_{i}^{(r)}\right)(\bmod 2)$. It is enough to show that $\sum_{i=1}^{n} a_{i}^{(j)} \equiv \sum_{i=1}^{n} b_{i}^{(j)}(\bmod 2)$ for $\forall 1 \leq j \leq r$ after rearranging. Then we know $a^{(j)} \sigma_{j}$ and $b^{(j)} \tau_{j}$ are conjugate for $\forall 1 \leq j \leq r$ by [10, Lemm. 5.3] since the lengths of $\sigma_{i}, \tau_{i}$ are the same for all $1 \leq i \leq r$. Consequently, $a \sigma$ and $b \tau$ are conjugate by [10, Theo. 5.4].

Assume $\mathbb{W}_{n}:=K_{n} \rtimes \mathbb{S}_{n}$, it is clear by [10, Lemm. 5.6].
Proposition 3.3. If $\sigma$ is of type $\left(1,2^{2}\right)$, then $\mathcal{O}_{a \sigma}^{W_{5}}$ is of type D for all $a \in H_{5}$.

Proof. Let $\sigma=\left(\begin{array}{ll}1 & 2\end{array}\right)(34)$ without lost generality, take $\tau=\left(\begin{array}{ll}1 & 3\end{array}\right)(24)$.
(i) Assume $\mathbb{W}_{5}:=\mathbb{Z}_{2}^{5} \rtimes \mathbb{S}_{5}$. If $a=\left(a_{1}, a_{2}, a_{3}, a_{4}, 1\right)$ and $\sum_{i=1}^{4} a_{i} \equiv 0$ or $1(\bmod 2)$, let $b=\left(b_{1}, b_{2}, b_{3}, b_{4}, 0\right)$ and $\sum_{i=1}^{4} b_{i} \equiv 1$ or $0(\bmod 2)$, respectively; if $a=\left(a_{1}, a_{2}, a_{3}, a_{4}, 0\right)$ and $\sum_{i=1}^{4} a_{i} \equiv 0$ or $1(\bmod 2)$, let $b=\left(b_{1}, b_{2}, b_{3}, b_{4}, 1\right)$ and $\sum_{i=1}^{4} b_{i} \equiv 1$ or $0(\bmod 2)$, respectively. Let $R:=\mathbb{Z}_{2}^{5} \rtimes \sigma \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{5}}$ and $S:=\mathbb{Z}_{2}^{5} \rtimes \tau \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{5}}$.
(ii) Assume $\mathbb{W}_{5}:=K_{5} \rtimes \mathbb{S}_{5}$. If $a=\left(a_{1}, a_{2}, a_{3}, a_{4}, 1\right)$ and $\sum_{i=1}^{4} a_{i} \equiv 1(\bmod 2)$, let $b=\left(b_{1}, b_{2}, b_{3}, b_{4}, 0\right)$ and $\sum_{i=1}^{4} b_{i} \equiv 0(\bmod 2)$; if $a=\left(a_{1}, a_{2}, a_{3}, a_{4}, 0\right)$ and $\sum_{i=1}^{4} a_{i} \equiv 0(\bmod 2)$, let $b=\left(b_{1}, b_{2}, b_{3}, b_{4}, 1\right)$ and $\sum_{i=1}^{4} b_{i} \equiv 1(\bmod 2)$. Let $R:=K_{5} \rtimes \sigma \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{5}}$ and $S:=K_{5} \rtimes \tau \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{5}}$.

Thus $a \sigma$ and $b \tau$ are conjugate by lemma [3.2. Obviously, $\sum_{i=1}^{4} a_{i} \neq \sum_{i=1}^{4} b_{i}$ implies $\mathrm{sq}(a \sigma, b \tau) \neq b \tau$ by [11, Exam.4.1]. It is clear that $R \cup S$ is a subrack decomposition of $\mathcal{O}_{a \sigma}^{\mathbb{W}_{5}}$, hence it is of type D.

Proposition 3.4. If $\sigma$ is of type $\left(1^{2}, 2^{2}\right)$, then $\mathcal{O}_{a \sigma}^{\mathbb{W}_{6}}$ is of type D for all $a \in H_{6}$.
Proof. Let $\sigma=\left(\begin{array}{ll}1 & 2\end{array}\right)(34)$ without lost generality, take $\tau=\left(\begin{array}{ll}1 & 3\end{array}\right)(24)$. Asuume $a=$ $\left(a_{1}, a_{2}, a_{3}, a_{4}, a_{5}, a_{6}\right), b=\left(b_{1}, b_{2}, b_{3}, b_{4}, b_{5}, b_{6}\right)$.
(i) Assume $\mathbb{W}_{6}:=\mathbb{Z}_{2}^{6} \rtimes \mathbb{S}_{6}$. If $\sum_{i=1}^{4} a_{i} \equiv 0(\bmod 2), a_{5}+a_{6} \equiv 0$ or $1(\bmod 2)$, let $\sum_{i=1}^{4} b_{i} \equiv 1(\bmod 2), b_{5}+b_{6} \equiv 1$ or $0(\bmod 2)$, respectively; if $\sum_{i=1}^{4} a_{i} \equiv 1(\bmod 2), a_{5}+$ $a_{6} \equiv 0$ or $1(\bmod 2)$, let $\sum_{i=1}^{4} b_{i} \equiv 0(\bmod 2), b_{5}+b_{6} \equiv 1$ or $0(\bmod 2)$, respectively. Let $R:=\mathbb{Z}_{2}^{6} \rtimes \sigma \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{6}}$ and $S:=\mathbb{Z}_{2}^{6} \rtimes \tau \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{6}}$.
(ii) Assume $\mathbb{W}_{6}:=K_{6} \rtimes \mathbb{S}_{6}$. If $\sum_{i=1}^{4} a_{i} \equiv 0(\bmod 2), a_{5}+a_{6} \equiv 0(\bmod 2)$, let $\sum_{i=1}^{4} b_{i} \equiv$ $1(\bmod 2), b_{5}+b_{6} \equiv 1(\bmod 2)$; if $\sum_{i=1}^{4} a_{i} \equiv 1(\bmod 2), a_{5}+a_{6} \equiv 1(\bmod 2)$, let $\sum_{i=1}^{4} b_{i} \equiv$ $0(\bmod 2), b_{5}+b_{6} \equiv 0(\bmod 2)$. Let $R:=K_{6} \rtimes \sigma \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{6}}$ and $S:=K_{6} \rtimes \tau \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{6}}$.

Thus $a \sigma$ and $b \tau$ are conjugate by lemma 3.2. Obviously, $\sum_{i=1}^{4} a_{i} \neq \sum_{i=1}^{4} b_{i}$ implies $\operatorname{sq}(a \sigma, b \tau) \neq b \tau$ by [11, Exam.4.1]. It is clear that $R \cup S$ is a subrack decomposition of $\mathcal{O}_{a \sigma}^{W_{6}}$, hence it is of type D .

Proposition 3.5. (i) If $\sigma$ is of type $\left(2^{3}\right)$, then $\mathcal{O}_{a \sigma}^{\mathbb{W}_{6}}$ is of type D for all $a \in H_{6}$.
(ii) If $\sigma$ is of type $\left(2^{4}\right)$, then $\mathcal{O}_{a \sigma}^{W_{8}}$ is of type D for all $a \in H_{8}$.

Proof. Similarly to lemma 3.4. (i) Let $\sigma=(12)(34)(56)$, take $\tau=(13)(24)(56)$. (ii) Let $\sigma=(12)(34)(56)(78)$, take $\tau=(13)(24)(56)(78)$.

Proposition 3.6. If $\sigma$ is of type $\left(1^{n-3}, 3\right)$ for $n>5$, then $\mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}$ is of type D for all $a \in H_{n}$ with $n>5$.

Proof. Let $\sigma=\left(\begin{array}{ll}1 & 2\end{array}\right), \tau=\left(\begin{array}{ll}4 & 5\end{array}\right)$. We have that the 1 -th, 2 -th , 3 -th, 4 -th, 5 -th and 6 -th components of (3) are

$$
\begin{equation*}
\left(0,0,0, a_{4}+a_{6}, a_{4}+a_{5}, a_{5}+a_{6}\right)=\left(b_{1}+b_{3}, b_{1}+b_{2}, b_{2}+b_{3}, 0,0,0\right) \tag{5}
\end{equation*}
$$

(1) Assume $\mathbb{W}_{n}:=\mathbb{Z}_{2}^{n} \rtimes \mathbb{S}_{n}$.
(i) If 4 -th, 5 -th, 6 -th components of $a$ are $(0,0,0)$ and $\sum_{i \neq 4,5,6} a_{i} \equiv 0$ or $1(\bmod 2)$, let 1-th, 2-th, 3-th components of $b$ are $(1,0,0)$ and $\sum_{i=4}^{n} b_{i} \equiv 1$ or $0(\bmod 2)$, respectively, then (5) does not hold.
(ii) If 4 -th, 5 -th, 6 -th components of $a$ are $(1,0,0)$ and $\sum_{i \neq 4,5,6} a_{i} \equiv 0$ or $1(\bmod 2)$, let 1 -th, 2 -th, 3 -th components of $b$ are $(0,0,0)$ and $\sum_{i=4}^{n} b_{i} \equiv 1$ or $0(\bmod 2)$, respectively, then (5) does not hold.
(iii) If 4 -th, 5 -th, 6 -th components of $a$ are $(1,1,0)$ and $\sum_{i \neq 4,5,6} a_{i} \equiv 0$ or $1(\bmod 2)$, let 1-th, 2-th, 3 -th components of $b$ are $(1,0,0)$ and $\sum_{i=4}^{n} b_{i} \equiv 1$ or $0(\bmod 2)$, respectively, then (5) does not hold.
(iv) If 4 -th, 5 -th, 6 -th components of $a$ are $(1,1,1)$ and $\sum_{i \neq 4,5,6} a_{i} \equiv 0$ or $1(\bmod 2)$, let 1-th, 2-th, 3 -th components of $b$ are $(1,1,0)$ and $\sum_{i=4}^{n} b_{i} \equiv 1$ or $0(\bmod 2)$, respectively, then (5) does not hold. Let $R:=\mathbb{Z}_{2}^{n} \rtimes \sigma \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}$ and $S:=\mathbb{Z}_{2}^{n} \rtimes \tau \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}$.
(2) Assume $\mathbb{W}_{n}:=K_{n} \rtimes \mathbb{S}_{n}$.
(i) If 4 -th, 5 -th, 6 -th components of $a$ are $(0,0,0)$ and $\sum_{i \neq 4,5,6} a_{i} \equiv 0(\bmod 2)$, let 1 -th, 2-th, 3-th components of $b$ are $(1,0,0)$ and $\sum_{i=4}^{n} b_{i} \equiv 1(\bmod 2)$, then (5) does not hold.
(ii) If 4 -th, 5 -th, 6 -th components of $a$ are $(1,0,0)$ and $\sum_{i \neq 4,5,6} a_{i} \equiv 1(\bmod 2)$, let 1-th, 2-th, 3-th components of $b$ are $(0,0,0)$ and $\sum_{i=4}^{n} b_{i} \equiv 0(\bmod 2)$, then (5) does not hold.
(iii) If 4 -th, 5 -th, 6 -th components of $a$ are $(1,1,0)$ and $\sum_{i \neq 4,5,6} a_{i} \equiv 0(\bmod 2)$, let 1 -th, 2-th, 3-th components of $b$ are $(1,0,0)$ and $\sum_{i=4}^{n} b_{i} \equiv 1(\bmod 2)$, then (5) does not hold.
(iv) If 4-th, 5 -th, 6 -th components of $a$ are $(1,1,1)$ and $\sum_{i \neq 4,5,6} a_{i} \equiv 1(\bmod 2)$, let 1 -th, 2-th, 3 -th components of $b$ are $(1,1,0)$ and $\sum_{i=4}^{n} b_{i} \equiv 0(\bmod 2)$, then (5) does not hold. Let $R:=K_{n} \rtimes \sigma \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}$ and $S:=K_{n} \rtimes \tau \cap \mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}$.

Thus $a \sigma$ and $b \tau$ are conjugate by [10, Lemm. 5.3]. Obviously, (5) does not hold implies $\operatorname{sq}(a \sigma, b \tau) \neq b \tau$. It is clear that $R \cup S$ is a subrack decomposition of $\mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}$, hence it is of type D.

Theorem 3.7. Let $n>4$. Let $\sigma \in \mathbb{S}_{n}$ be of type $\left(1^{m_{1}}, 2^{m_{2}}, \ldots, n^{m_{n}}\right)$ and $a \in H_{n}$ with $a \sigma \in W_{n}$ and $\sigma \neq 1$. If $\mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}$ is not of type D , then the type of $\sigma$ belongs to one in the following list:
(i) $(2,3)$;
(ii) $\left(1^{2}, 3\right)$;
(iii) $\left(1^{n-2}, 2\right)$ for $n>5$ with $a_{i}=a_{j}$ when $\sigma(i)=i$ and $\sigma(j)=j$.
proof. It follows from Proposition 3.3, Proposition 3.4, Proposition 3.5, Proposition 3.6 and [11, Theorem 4.1].

## 4 Nichols algebras of irreducible YD module over $\mathbb{W}_{n}$

In this section we show that except in three cases Nichols algebras of irreducible YD modules over classical Weyl groups $\mathbb{W}_{n}$ are infinite dimensional.

We shall use the following facts:
Lemma 4.1. ( $[\underline{9}$, Cor. 8.4]) Let $n \in \mathbb{N}, n \geq 3$, and assume $U$ be a YD module over symmetric group $\mathbb{S}_{n}$. If $\mathfrak{B}(U)$ is finite dimensional, then $U$ is an irreducible YD module over $\mathbb{S}_{n}$.

Proposition 4.2. (See [1, Theorem 3.6] or [11, Theorem 5.3]) If $G$ is a finite group and $\mathcal{O}_{\sigma}^{G}$ is of type D , then $\operatorname{dim} \mathfrak{B}\left(\mathcal{O}_{\sigma}^{G}, \rho\right)=\infty$ for any $\rho \in \widehat{G^{\sigma}}$.

Theorem 4.3. Assume $n \geq 5$. Let $\sigma \in \mathbb{S}_{n}$ be of type ( $1^{m_{1}}, 2^{m_{2}}, \ldots, n^{m_{n}}$ ) and $a \in H_{n}$ with $a \sigma \in \mathbb{W}_{n}$ and $\sigma \neq 1$. If $\operatorname{dim} \mathfrak{B}\left(\mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}, \rho\right)<\infty$, then the type of $\sigma$ belongs to one in the following list:
(i) $(2,3)$;
(ii) $\left(1^{2}, 3\right)$;
(iii) $\left(1^{n-2}, 2\right)$ for $n>5$ with $a_{i}=a_{j}$ when $\sigma(i)=i$ and $\sigma(j)=j$.
proof. It follows from Theorem 3.7 and Proposition 4.2.
Moreover, we give the following conjecture:
Conjecture 4.4. Assume $n \geq 5$. Let $a \sigma \in \mathbb{W}_{n}$ with $\sigma \in \mathbb{S}_{n}, \sigma \neq 1$ and $a \in H_{n}$, then $\operatorname{dim}$ $\mathfrak{B}\left(\mathcal{O}_{a \sigma}^{\mathbb{W}_{n}}, \rho\right)=\infty$.
