# A NOTE IN ALGEBRAS WITH LAURENT POLYNOMIAL IDENTITY 

CLAUDENIR FREIRE RODRIGUES


#### Abstract

In this article we extend some results about algebra $A$ with the group of units $U(A)$ having special polynomial identity, Laurent polynomial. And we presents a new version of B. Hartley Conjecture with these identities.


## 1. Introduction

A Laurent polynomial $P=P\left(x_{1}, \ldots, x_{l}\right)$ in the noncommutative variables $x_{i}, i=$ $1, \ldots, l$ is an element non-zero in the group algebra $R F_{l}$ over a ring $R$ with free group $F_{l}=<x_{1}, \ldots, x_{l}>. P$ in $R F_{l}$ is said a Laurent Polynomial Identity (LPI) for a $R$ algebra $A$ (respc. for $U(A)$ the group of units in A) if $P\left(c_{1}, \ldots, c_{l}\right)=0$ for all sequence $c_{1}, \ldots, c_{l}$ in $A$ (respc. in $\mathrm{U}(\mathrm{A})$ ).
A word $w$ in a free group is a group identity $(G I)$ for a group $G$ if $w\left(c_{1}, \ldots, c_{l}\right)=1$ ( $w=1$ for short) for all $c_{1}, \ldots, c_{l}$ in $G$ and $\sum \exp _{x} w$ denotes the sum of exponents of $w$ in the variable $x$. And we say that a nil ideal $I$ has a bounded exponent if there exists a integer $m$ such that for all $a$ in $I, a^{i}=0$ for some $i \leq m$.

The following conjecture was introduced by B. Hartley [10],
Conjecture: Let $G$ be a torsion group and $K$ a field. If the group of units $U(K G)$ of $K G$ satisfies a group identity $w=1$, then KG satisfies a polynomial identity.

In [2] A. Giambruno, E.Sehgal e A.Valenti settled the conjecture when $K$ is an infinite field, while in [5], D.S. Passman gave a necessary and sufficient condition for it to be true and in [8] C-H. Liu removed the condition that $K$ is infinite. It is natural to think about extending the conjecture of B . Hartley by considering Laurent identities instead of group identities because $w=1$ is a particular case of $L P I P=1-w$. In this sense in [6] M. A. Dokuchaev and J. Z. Gonçalves investigate when the group of units $U(A)$ of an algebraic algebra $A$ over an infinite field $K$, satisfies a Laurent polynomial, showing that if this holds, then $A$ has a polynomial identity. And in [3] O. Broche, J. Z. Gonçalves, and Á. Del Río gave a characterization of group algebras with $L P I$ for the group of units, satisfying a polynomial identity. Prior to these results in [1] A. Giambruno, E.Jespers and

[^0]A.Valenti show that the B. Hartley's Conjecture is true for a group algebra $R G$ over an infinite commutative domain $R$ when $\operatorname{char} R=0$ and when $G$ does not contain elements of order $p$ where char $R=p$ ( $G$ is a p'- group for short). For this and other purposes, the latter authors proved the following crucial result.

Proposition 1.1. Let $A$ be an algebra over an infinite commutative domain $R$ and suppose that $U(A)$ satisfies a group identity $w=1$. There exists a positive $m$ such that if $a, b, c$ in $A$ and $a^{2}=b c=0$, then $b a c A$ is a nil right ideal of bounded exponent less or equal than $m$.

This note is structured in the following way. In Section 2 a generalization (Theorem 2.1) of Proposition 1.1 is made considering the case $P=a_{1}+a_{2} w_{2}+\cdots+$ $a_{n} w_{n}$ is a $L P I$ for $U(A)$ (the $w_{i}^{\prime} s, i \geq 2$ are the words non-constant in $P$ ) with sum of exponents non-zero in at least one of the variables in every word non-constant and without restrictions about the ring $R$. Notice that the restriction about the exponents is necessary because according to Remark 3.11 without this assumption the result not hold. As a consequence we prove the result of Proposition 1.1 (Corollary 2.2) with a $L P I$ for $U(A)$ and we extend [8, Lemma 3.2] (Corollary 2.3).

In Section 3 we extend [2, Corollary 2.2], Corollary 3.3, which will be used to obtain a $L P I$ version for the conjecture of B. Hartley in the terms of the first part of $[1$, Theorem 6] from which we remove the condition of infinity in the second part (Theorem 3.10). In this article, we always adopt $L P I$ with the foregoing restriction about the exponents. Also, replacing $x_{i}$ with $x^{-i} y x^{i}$ we may assume $L P I$ is in two variables.

## 2. Main Results

In this section we will demonstrate our main results.
Theorem 2.1. Let $A$ be an algebra whose group of units $U(A)$ admits a LPI P over a ring $R$ whith unit and non-constants words $w_{i}$ in $P$ has the sum of exponents non-zero in at least one of the variables. Then there exists a polynomial $f \in R[X]$ with degree $d$ determined by $l=\min \left\{\sum \exp w_{i}\right\}$ and $r=\max \left\{\sum \exp w_{i}\right\}$ such that for all $a, b, c, u$ in $A$ with $a^{2}=b c=0, f(b a c u)=0$. Thus, bacA has $a$ polynomial identity.

Proof. Let $P=a_{1}+a_{2} w_{2}+\cdots+a_{t} w_{t}$ the LPI with $w_{i}$ in the form

$$
w_{i}=x_{1}^{r_{1}} x_{2}^{s_{2}} \cdots x_{1}^{r_{k}} x_{2}^{s_{k}}
$$

with $k \geq 1, r_{i}, s_{i}$ integers. We assume that the words are arranged in $P$ so that $\sum \exp w_{i} \leq \sum \exp w_{i+1}$.

If $\sum \exp w_{i}=\sum \exp _{x_{1}} w_{i}+\sum \exp _{x_{2}} w_{i}=0$ then we substitute $x_{1}=x_{1}^{k}$ or $x_{2}=x_{2}^{k}$ with $k>1$ big enough. We get a new LPI in the form $P=a_{1}+a_{2} w^{\prime}{ }_{2}+$ $\cdots+a_{r} w^{\prime}{ }_{r}$, where

$$
\sum \exp w_{i}^{\prime}=\sum \exp _{x_{1}} w_{i}^{\prime}+\sum \exp _{x_{2}} w_{i}^{\prime}=k \sum \exp _{x_{1}} w_{i}+\sum e x p_{x_{2}} w_{i}
$$

or

$$
\sum e x p w_{i}^{\prime}=\sum e x p_{x_{1}} w_{i}+k \sum e x p_{x_{2}} w_{i}
$$

In any case that is not zero. So we suppose $\sum \exp w_{i}$ not zero for all $i=2, \ldots, t$.
From this

$$
P(\alpha, \alpha)=a_{1}+a_{2} \alpha^{l}+\cdots+a_{i} \alpha^{\sum \exp w_{i}}+\cdots+a_{t} \alpha^{r}=0
$$

with all powers of $\alpha$ not zero for all $\alpha \in U(A)$ and $l$ and $r$ are respectively the minimum and maximum of the sum of the exponents of the $w_{i}^{\prime} s$.

After organizing the common powers we will have a polynomial expression of the form

$$
f_{0}(\alpha)=a_{1}+b_{l} \alpha^{l}+\cdots+b_{r} \alpha^{r}=0
$$

where $b_{j}^{\prime} s$ are parcials sums of $a_{i}^{\prime} s, i=2, \ldots, t$.
In general, $P(1,1)=a_{1}+a_{2}+\cdots+a_{t}=0$, so $a_{2}+\cdots+a_{t} \neq 0$, because $a_{1} \neq 0$. So we can not have all $b_{i}^{\prime} s=0$ because in this case $a_{2}+\cdots+a_{r}=b_{l}+\cdots+b_{r}=0$. Follows that $f_{0}$ is a non zero polynomial over $R$ with integers exponents not all necessarily positives.

If $l<0$ we have that $\alpha^{-l} f_{0}(\alpha)=f_{1}(\alpha)=0$, where $f_{1} \neq 0$ is a polynomial identity for $U(A)$ over $R$ of degree at most $r-l$. We can then assume $l>0$ and $f_{0}$ is a polynomial identity (of degree at most $r$ ) for $U(A)$. Now, we are going to use this polynomial with special units in $U(A)$.

First let $b=c$ be, so $a^{2}=b^{2}=0$. Then we have $(1+a u a),(1+b a u a b) \in U(A)$, for all $u \in A$..

Thus $\alpha=(1+a u a) \cdot(1+b a u a b) \in U(A)$ and for every power in $f_{0}$,

$$
\alpha^{h}=1+a u a+b a u a b+\sum \text { products in } a u a \text { and } b a u a b+(a u a b a u a b)^{h}
$$

for all $h=l, \ldots, r$.
As $a^{2}=b^{2}=0$ and $a b(a u a b a u a b)^{h} a u=(a b a u)^{2 h+1}$,

$$
a b b_{i} \alpha^{h} a u=b_{i} a b a u+g_{h}(a b a u)+b_{i}(a b a u)^{2 h+1}
$$

where $g_{h}$ is a polynomial over $R$ with degree $<2 h+1$.
It follows that

$$
\begin{align*}
a b f_{0}(\alpha) a u & =a b a_{1} a u+a b b_{l} \alpha^{l} a u+\cdots+a b b_{r} \alpha^{r} a u \\
& =\left(a_{1}+b_{l}+\cdots+b_{r}\right) a b a u+\sum g_{h}(a b a u)+\sum b_{h}(a b a u)^{2 h+1} \\
& =\left(a_{1}+a_{2}+\cdots+a_{t}\right) a b a u+\sum g_{h}(a b a u)+\sum b_{h}(a b a u)^{2 h+1}  \tag{1}\\
& =\sum g_{h}(a b a u)+\sum b_{h}(a b a u)^{2 h+1} \\
& =f_{2}(a b a u)=0,
\end{align*}
$$

with $h=l, \ldots, r$ and $f_{2}$ is a non zero polynomial over $R$ of degree $\leq 2 r+1$. This finish the $b=c$ case.

In general, if $a, \alpha, \beta \in A$ and $a^{2}=\alpha \beta=0$, then we have $(\beta u \alpha)^{2}=0$, for all $u \in A$. As we saw $f_{2}$ is a polynomial identity for $(\beta u \alpha) a(\beta u \alpha) A$. Then, $\alpha a f_{1}((\beta u \alpha) a(\beta u \alpha) a) \beta u=f(\alpha a \beta u)=0$ where $f$ (with zero constant term) is a non zero polynomial over $R$ with degree $\leq 2(2 r+1)+1=4 r+3$ and thus an identity for $\alpha a \beta A$.

As a consequence we prove the following.
Corollary 2.2. Let $A$ be an algebra over an infinite commutative domain $R$ whose group of units $U(A)$ has a LPI. Then, for all $a, b, c \in A$ with $a^{2}=b c=0, b a c A$ is a nil right ideal with bounded exponent.
Proof. By Theorem 2.1, there exists $f \in R[X] \backslash\{0\}$ with degree $d$, such that $f(b a c \lambda u)=0$ for all $\lambda \in R, u \in A$. That is, $\lambda p_{1}+\lambda^{2} p_{2}+\cdots+\lambda^{d} p_{d}=0$ where $p_{i}$ is polynomial on bacu with $p_{d}=b_{d}(b a c u)^{d}$. Now, by the Vandermond argument [9, Proposition 2.3.27 p. 130 ], $p_{1}=\cdots=p_{d}=0$, so $(b a c u)^{d}=0$.

In the last proof we see that the application of the Vandermonde argument applies with $|R|>d$. We fix notation with $f(x)$ and $d$ as in Theorem 2.1.

As another small application, we extend Lemma 3.2 in [8] in the context of LPI.
Corollary 2.3. Let $A$ be an algebra over a field $K$ with $U(A)$ satisfying a LPI, and $a, b \in A$ such that $a^{2}=b^{2}=0$.

1. If $|K|>2 d$, then $(a b)^{2 d}=0$.
2. If $a b$ is nilpotent, then $(a b)^{2 d}=0$.

Proof. Arguing as in the proof of Corollary 2.2, with $b=c$, we deduce that $(a b a u)^{d}=0$ for all $u \in A$ and with $u=b,(a b)^{2 d}=0$. Now suppose $a b$ nilpotent, by Theorem 2.1 with $(b=c)$ there exists a polynomial $f$ over K of degree $d$ such that $f(a b a u)=0$ for all $u \in A$. Thus $f(a b a . b)=f_{1}(a b)=0$ where $f_{1}$ is a polynomial of degree $2 d$. The minimal polynomial of $a b$ is $g=x^{i}, i>0$, because $a b$ is nilpotent. As $g$ divides $f_{1}$ implies $i \leq 2 d$ and since $g(a b)=(a b)^{i}=0$, $(a b)^{2 d}=0$.

## 3. A PLI version for the B. Hartley conjecture

First we shall need the following two results.
Lemma 3.1. Let $A$ be an algebra over a commutative domain $R$. Suppose that for all $a, b, c \in A$ such that $a^{2}=b c=0$ we have $b a c=0$. Then every idempotent of $R^{-1} A$ is central.

Proof. See [1, Lemma 2.]

Lemma 3.2. [2] Let $A$ be a semiprime ring and let $S=\{a \in A:$ for all $b, c \in$ $A, b c=0$ implies bac $=0\}$. If $S$ contains all square-zero elements of $A$, then $S$ contains all nilpotent elements of $A$.

Proof. See [2, Lemma 2.1.]

Let $R$ be a commutative domain and $A$ a $R$-algebra. $R^{-1} A$ is the ring of fractions of $A$ with respect to the non-zero elements of $R$.

In the following a $L P I$ version of Corollary 2.2 of [2].
Corollary 3.3. Let $A$ be a semiprime algebra over an infinite commutative domain $R$. If $U(A)$ satisfies a LPI, then every idempotent element of $R^{-1} A$ is central and for all $b, c \in A$ such that $b c=0$ we have bac $=0$ for every a nilpotent in $A$.

Proof. By Corollary 2.2 for all $a, b, c \in A$ with $a^{2}=b c=0, b a c A$ is a nil right ideal of bounded exponent. If $b a c \neq 0$, by Levitzki's theorem (see [9] 1.6.26, p.46) A has a non zero nilpotent ideal, against the semiprimeness of A. Thus bac $=0$. Now the result follows from Lemmas 3.1 and 3.2.

In the sequel the others classical results we need.
The $F C$-subgroup of a group $G$ is given by
$\phi(G)=\{g \in G: g$ has a finite number os conjugates in $G\}$. Let $A$ be a $R$-algebra. We say that $g$ is a multilinear generalized polynomial of degree $n$ if

$$
g\left(x_{1}, \ldots, x_{n}\right)=\sum_{\sigma \in \text { Sym }_{n}} g^{\sigma}\left(x_{1}, \ldots, x_{n}\right)
$$

with

$$
g^{\sigma}\left(x_{1}, \ldots, x_{n}\right)=\sum_{j=1}^{a_{\sigma}} \alpha_{0, \sigma, j} x_{\sigma(1)} \alpha_{1, \sigma, j} x_{\sigma_{(2)}} \cdots \alpha_{n-1, \sigma, j} x_{\sigma(n)} \alpha_{n, \sigma, j}
$$

where $\alpha_{i, \sigma, j} \in R$ and $a_{\sigma}$ is some positive number. The foregoing $g$ is said to be nondegenerate if for some $\sigma \in S y m_{n}, g^{\sigma}$ is not a generalized polynomial identity for $A$. $A$ is said to satisfy a GPI if $A$ satisfies a nondegenerate multilinear generalized polynomial identity.

At next lemmas $K$ is a field and $G$ is a group.
Lemma 3.4. $K[G]$ satisfies a GPI if and only if $[G: \phi(G)]<\infty$ and $\left|\phi^{\prime}(G)\right|<\infty$.
Proof. See [4, p. 202]
For any integer $n$, the standar polynomial of degree $n$ is given by

$$
S_{n}\left(x_{1}, \ldots, x_{n}\right)=\sum_{\sigma \in \text { Sym }_{n}}(\operatorname{sgn} \sigma) x_{\sigma(1)}, \ldots, x_{\sigma(n)}
$$

Lemma 3.5 (Amitsur-Levitzki). If $K$ is a field. Then $M_{m}(K)$ satisfies the standar polynomial identity $S_{2 m}$.

Proof. See [4, Theorem 1.9, p. 175]
A result well-known is the lemma:

Lemma 3.6. Let $A$ be a $R$-algebra and let $I$ a right ideal of $R$. If I satisfies a polynomial identity of degree $k$ and $I^{k} \neq 0$, then $A$ satisfies a GPI.

Lemma 3.7. Suppose that char $K=p>0$. Then $K[G]$ is semiprime if and only if $\phi(G)$ is a $p^{\prime}$-group.

Proof. See [4, p. 131]
Lemma 3.8. If char $K=0$, then $K[G]$ is semiprime.
Proof. See [4, p.130]
Lemma 3.9. Let $A$ be an algebraic algebra over an infinite field $K$. If $U(A)$ is LPI then $A$ is a PI-ring. Moreover, if $A$ is non-commutative then $A$ is PI-ring, provided that the non-central units of $A$ satisfy an LPI.
Proof. See [6, Theorem 5]
Now we are ready to do our adaptations to the LPI case of the Conjecture of B.Hartley.

Theorem 3.10. Let $G$ be a torsion group, $R$ a commutative domain and $U(R G)$ satisfies a Laurent polynomial identity.

1. If either char $R=0$ or char $R=p>0$ with $G$ a $p^{\prime}-$ group and $R$ infinite, then $R G$ satisfies $S_{4}$, the standard identity of degree four;
2. If $G$ is any group, then either there exists a integer $d>0$ such that for all $a, b, c \in R G$ with $a^{2}=b c=0$, we have that bacR $G$ is a nilpotent ideal of exponent less than $d$ or $\phi(G)$ is of finite index in $G$ and $\phi(G)^{\prime}$ is a finite group. In the latter case, with $G$ a torsion group and $R$ an infinite field, $R G$ has a polynomial indentity.

Proof. By Lemmas 3.7 and $3.8 K G$ is a semiprime $K$-algebra and by Lema 3.3 for all $g \in G$ with order $n$, the idempotent $n^{-1}\left(1+g+g^{2}+\ldots+g^{n-1}\right)$ is central in $K G, K$ is the field of fractions of R . From this $\langle g\rangle$ is a normal cyclic group in $G$. Thus $G$ is an abelian or Hamiltonian group. With $G$ Hamiltonian, $G=Q_{8} \times E \times A$, where $Q_{8}$ is the quarternion group of order $8, E$ is an elementary Abelian 2-group and $A$ is abelian with elements of odd order. Thus $G$ has an abelian subgroup $S$ of index 2. And by [4, Lemma V.1.10] $K G$ embeds in $M_{2}(K S)$ and by Lemma $3.5, K G$ and so, $R G$ satisfies $S_{4}$.

For the second part if $a, b, c \in R G$ with $a^{2}=b c=0$. By Theorem $2.1 b a c R G$ has a polynomial identity of degree $d$. If $(\operatorname{bacRG})^{d} \neq 0$, then by Lemma 3.6 $R G$ satisfies a GPI and from this $K G$ satisfies a GPI. By Lemma $3.4[G: \phi(G)]<\infty$ and $\left|\phi^{\prime}(G)\right|<\infty$. In this case with $G$ a torsion group $\phi(G)$ is locally finite. Follows that $G$ is locally finite and, so, $R G$ is algebraic. With R an infinite field by Lemma $3.9 R G$ has a polynomial identity.

Remark 3.11. In general, Theorem 2.1 not hold without the restrictions about exponents. For example, let $A=M_{n}(R), n>1$ and $R$ an infinite commutative domain. By Lemma 3.5 $U(A)$ satisfies the $L P I$

$$
f\left(x_{1}, \ldots, x_{2 n}\right)=S_{2 n} \cdot\left(x_{1} \cdots x_{2 n}\right)^{-1}
$$

where $S_{2 n}$ is the standard identity and $f$ is a $L P I$ with all words non-constant having sum of exponents zero at every variable. Admitting the Theorem 2.1, bacu is algebraic for all $u \in A$, in particular, for $c=b$ and $u=a, b a$ is algebraic. It follows that by Vandermonde augument $b a$ is nilpotent. In general, $b a$ is not a nilpotent element. We can see this with $a=e_{21}$ and $b=e_{12}, b a=e_{11}$ is not nilpotent.

Still considering $A=M_{n}(R), R$ a infinite commutative domain, $a=e_{21}$ and $b=e_{12}$ by Proposition $1.1 U(A)$ does not admit group identity. This show that there are algebras with $L P I$ without $G I$.
