# Applications of $\beta$-Nijenhuis-Richardson bracket to cohomology of Hom-algebras

#### Abstract

In this paper, we mean by Hom-algebras a triple ( $M, d, \beta$ ) in which $M$ is a vector space, $d$ a bilinear map on $M$ and $\beta: M \rightarrow M$ (the twisting map). In this work we define the left, right and Lie $\beta$ -Nijenhuis-Richardson bracket associated to a vector space $M$. We use these brackets to construct, in a canonical way, cohomology and deformations of each Hom-algebra structure of $M$. Next, we use these chomologies to define the representation and extensions of Homalgebra $(L, \delta, \alpha)$ by a Hom-algebra $\left(V, \mu, \alpha_{V}\right)$.


Keywords: $\beta$-Nijenhuis-Richardson bracket; Left Hom-Leibniz algebra; Right Hom-Leibniz algebra; Symmetric Hom-Leibniz algebra; Hom-Lie algebra; Representaions; Deformations; Extensions.

## Introduction

The Nijenhuis-Richardson bracket is defined as follows: For each integer $k \geq$ -1 , we define $A l t^{k}(M)$ to be the vector space of all alternating $(k+1)$-linear maps of $M$ into itself. We denote by $\operatorname{Alt}(M)$ the direct sum $\oplus_{k \geq-1} A l t^{k}(M)$. For $f \in A l t^{k}(M), g \in A l t^{l}(M)$ and $n=k+l-1$, we define $f \circ g \in A l t^{n}(M)$ by

[^0]where $\operatorname{Sh}(l, k-1)$ is the sum of all permutation $\sigma$ of $\{1, \cdots, n\}$ such that $\sigma(1)<\sigma(2)<\cdots<\sigma(l)$ and $\sigma(l+1)<\cdots<\sigma(n)$. We now define the Nijenhuis-Richardson bracket $[f, g] \in C^{n}(M)$ by

The set of Lie algebras structures on a vector space $M$ is the set of such that $[d, d]=0$ (see ).

In this paper, we define two types of Nijenhuis-Richardson bracket:

1. The bracket $[\cdot, \cdot]_{l}: C_{\beta}(M) \times C_{\beta}(M) \rightarrow C_{\beta}(M)$ gives the set of left HomLeibniz strucures and the space symmetric Hom-Leibniz.
2. The bracket $[\cdot, \cdot]_{r}: C_{\beta}(M) \times C_{\beta}(M) \rightarrow C_{\beta}(M)$ gives the set of right Hom-Leibniz strucures.

Where $C_{\beta}(M)$ is the space of Hom-cochain of left and right-Leibniz algebras. Suppose that $\xi^{\prime}$ (resp. $\xi$ ) is the set of symmetric Hom-Leibniz (resp. Hom-Lie) algebras stuctures. Then there exists a $\mathbb{Z}$-graded Lie alge$\operatorname{bra}\left(A l t^{\prime}(M)=\oplus_{k \geq 0} A l t^{k}(M),[\cdot, \cdot]_{l}\right)\left(\right.$ resp. $\left.\left(\operatorname{Alt}(M)=\oplus_{k \geq 0} A l t^{k}(M),[\cdot, \cdot]_{l}\right)\right)$ such that $d \in \xi^{\prime}($ resp. $d \in \xi)$ if and only if $d \in A l t^{\prime 1}(M)$ (resp. $\left.d \in A l t^{1}(M)\right)$ such that $[d, d]_{l}=0$.

Makhlouf and Silvestrov introduced the notion of a Hom-Leibniz algebra $(L,[\cdot, \cdot], \alpha)$ in [22], which is a natural generalization of Leibniz algebras and Hom-Lie algebras. Later, Yong Sheng Cheng (resp. Yunhe Sheng) studied the representation and the cohomology of right Hom-Leibniz (resp. HomLie) algebras in [8] (resp. in [25]). With the trivial representation we define the central extension of Hom-Lie algebras [6].

The previous cohomolgy are fefined with the Chevalley-Eilenberg coboundary operator $\delta_{k}$ of a representation of a Hom-algeras $(M, d, \beta)$. In this paper, representations, cohomology extensions and deformation are defined with the $\beta$-NR-brackets.

The structure of this paper is as follows. After some preliminary definitions and notations in Section 2, we define the left (resp. right) $\beta$-RichardsonNijenhuis bracket. With this bracket we redefine the left (resp.right) HomLeibniz algebra and their cohomology and we define the symmetric HomLeibniz and their cohomology. In section 3 we define and study the deformation of Hom-Leibniz and Hom-Lie algebras with the $\beta$-RichardsonNijenhuis bracket. In section 4, we will recall classical definition of a HomLeibniz algebra extension and we recognize it and the representation, cocycles, cobords...with the action of the $\beta$-Richardson-Nijenhuis bracket to a
structure $d \in C^{2}(M)$ and we study the split extension of Hom-algebras.
In this paper, $\mathbb{K}$ always denotes any field of characteristic $\neq 2$.

## 1 Preliminaries and Notations

In this section we briefly recall some of the definitions on Hom-Leibniz and we give the notations that we will need in the remainder of the paper.
Definition 1.1. A Hom-algebra is a triple $(L,[\cdot, \cdot], \alpha)$ in which $L$ is a vector space, $[\cdot, \cdot]$ a bilinear map on $L$ and $\alpha: L \rightarrow L$ (the twisting map).
A Hom-algebra $(L,[\cdot, \cdot], \alpha)$ is said to be multiplicative if $\alpha([x, y])=[\alpha(x), \alpha(y)]$ for all $x, y$ in $L$.
By a homomorphism of Hom algebras $f:(L,[\cdot, \cdot], \alpha) \rightarrow\left(L^{\prime},[\cdot, \cdot]^{\prime}, \alpha^{\prime}\right)$ we mean a linear map from $L$ to $L^{\prime}$ such that

If $f$ is bijective we say that $L$ and $L^{\prime}$ are isomorphic.
Definition 1.2. (i) The Hom-algebra $(L,[\cdot, \cdot], \alpha)$ is called a left Hom-Leibniz if it satisfy the equation

[\alpha(x),[y, z]]=[[x, y], \alpha(z)]+[\alpha(y),[x, z]]

for all $x, y, z \in L$. (see [国).
(ii) The Hom-algebra $(L,[\cdot, \cdot], \alpha)$ is called a right Hom-Leibniz algebra if it satisfy the equation

for all $x, y, z \in L$. (see [22] ).
(iii) A triple $(L,[\cdot, \cdot], \alpha)$ is called a symmetric Hom-Leibniz algebra if it is a left and a right Hom-Leibniz algebra.

Definition 1.3. [17, 3, [22] A Hom-Lie algebra is a triple ( $L,[\cdot, \cdot], \alpha)$ consisting of $a \mathbb{K}$ vector space $L$, a bilinear map $[\cdot, \cdot]: L \times L \rightarrow L$ and a $\mathbb{K}$-linear map $\alpha: L \rightarrow L$ satisfying

for all $x, y, z \in L$.

Clearly Hom-Lie algebras is example of Hom-Leibniz algebras.
We recall that, in this paper we mean by Hom-algebra a left or right or symmetric Hom-Leibniz algebra or a Hom-Lie algebra. In general, a Homalgebra is denoted $(M, d, \beta)$ or $(L, \delta, \alpha)$ if $L$ is a subspace of $M$.

Definition 1.4. [8] A representation (module) of the right Hom-Leibniz algebra $(L,[\cdot, \cdot], \alpha)$ on the vector space $V$ with respect to $\alpha_{V} \in \mathfrak{g l}(V)$, is defined with two actions (left and right) on $L$. These actions are denoted by the following brackets as well

satisfying the following five axioms,

for any $v \in V$ and $x, y \in L$.

In this paper, $[\cdot, \cdot]_{V}: L \times V \rightarrow V\left(\right.$ resp. $\left.[\cdot, \cdot]_{V}: V \times L \rightarrow V\right)$ is denoted $\lambda_{l}\left(\right.$ resp. $\left.\lambda_{r}\right)$.

Definition 1.5. [25, 8] Let $V$ a representation of Hom-Lie (resp. Leibniz) algebra $L$. The set of $k$-cochains on $L$ with values in $V$, which we denote by $\mathrm{Alt}^{k}(L, V)$ (resp. $C^{k}(L, V)$ ), is the set of skew-symmetric $k$-linear maps from $\underbrace{L \times L \cdots \times L}_{k-\text { times }}$ to $V$.
A $k$-Hom-cochain on $L$ with values in $V$ is defined to be a $k$-cochain $f \in$ Alt ${ }^{k}(L, V)$ satisfies

for all $x_{1}, \cdots, x_{k} \in L$. In this paper, we denote by $\operatorname{Alt}_{\alpha}^{k}(L, V)\left(\right.$ resp. $\left.C_{\alpha}^{k}(L, V)\right)$ the set of all $k$-Hom-cochains of $L$. The set of Hom-cochain of symmetric Hom-Leibniz algebra $L$ is denoted by $\operatorname{Alt}_{\alpha}^{\prime k}(L, V)$.
We denote by $\chi_{\alpha}(L, V)$ the set of Hom-cochains of Hom- algebra L. Hence,
if $L$ is a left (or right) Hom-Leibniz algebra $\chi_{\alpha}(L, V)=C_{\alpha}^{k}(L, V)$. if $L$ is a symmetrc Hom-Leibniz algebra, $\chi_{\alpha}(L, V)=C_{\alpha}^{\prime}(L, V)$. If $L$ is a Hom-Lie algebra $\chi_{\alpha}(L, V)=A l t_{\alpha}^{k}(L, V)$.
In this paper, the equation (1.6) is denoted $\alpha_{V} \circ f=f \star \alpha$.
Definition 1.6. [8] Define a $\mathbb{K}$-Linear map $\delta^{k}: C_{\alpha}^{k}(L, V) \rightarrow C_{\alpha}^{k+1}(L, V)$ by

For $k=0$, for any $x \in L$, we take

Definition 1.8. [6, 8] An extension of a Hom-Leibniz algebra $(L,[\cdot, \cdot], \alpha)$ by Hom-module $\left(V,[\cdot, \cdot]_{V}, \alpha_{V}\right)$ is an exact sequence

0 \longrightarrow\left(V, \alpha_{V}\right) \xrightarrow{i}(\widetilde{L}, \widetilde{\alpha}) \xrightarrow{\pi}(L, \alpha) \longrightarrow 0

satisfying $\widetilde{\alpha} \circ i=i \circ \alpha_{V}$ and $\alpha \circ \pi=\pi \circ \widetilde{\alpha}$.
Two extensions

0 \longrightarrow\left(V, \alpha_{V}\right) \xrightarrow{i_{k}}\left(L_{k}, \alpha_{k}\right) \xrightarrow{\pi_{k}}(L, \alpha) \longrightarrow 0 \quad(k=1,2)

are equivalent if there is an isomorpism $\varphi:\left(L_{1}, \alpha_{1}\right) \rightarrow\left(L_{2}, \alpha_{2}\right)$ such that $\varphi \circ i_{1}=i_{2}$ and $\pi_{2} \circ \varphi=\pi_{1}$.

## $2 \beta$-Nijenhuis-Richardson brackets

In this section, we define the space $C_{\beta}(M)$ of $\beta$-cohains, the left (resp. right) $\beta$-Nijenhuis-Richardson bracket $[\cdot, \cdot]_{l}$ (resp. $[\cdot, \cdot]_{r}$ ). We show that $\left(C_{\beta}(M),[\cdot, \cdot]_{l}\right)\left(\operatorname{resp} .\left(C_{\beta}(M),[\cdot, \cdot]_{r}\right)\right)$ is a graded Lie algebra. These graded Lie algebras provide groups of cohomolgy of Hom-algebras ( $M, d, \beta$ ) on itself.

Let $\beta: M \rightarrow M$ a linear map and let $C^{k}(M)=\operatorname{Hom}\left(M^{k}, M\right)$.

Definition 2.1. A $k-\beta$-cochain is a map $f \in C^{k}(M)$ satisfying $f \star \beta=\beta \circ f$ where

f \star \beta\left(a_{1}, \cdots, a_{k}\right)=f\left(\beta\left(a_{1}\right), \cdots, \beta\left(a_{m}\right)\right)
$$

for all $a_{1}, \cdots, a_{k} \in M$.
We denote by $C_{\beta}(M)=\oplus_{k \geq 0} C_{\beta}^{k}(M)$ where $C_{\beta}^{k}(M)$ is the set of all $k-\beta$ cochain of $M$. The space $C_{\beta}(M)$ has a $\mathbb{Z}$-grading, where the degree of an element in $C_{\beta}^{k}(M)$ is $k-1$.

The following result is a $\beta$-version of that obtained in [24].
Definition 2.2. Let $[\cdot, \cdot]: C_{\beta}(M) \times C_{\beta}(M) \rightarrow C_{\beta}(M)$ be a bilinear map. $A$ couple $\left(C_{\beta}(M),[\cdot, \cdot]\right)$ is a graded Lie algebra (or a color Lie algebra) if for any $f \in C_{\beta}^{m}(M), g \in C_{\beta}^{n}(M)$ and $h \in C_{\beta}^{p}(M)(i . e \operatorname{deg}(f)=m-1, \operatorname{deg}(g)=n-1$, $\operatorname{deg}(h)=p-1)$, we have
(i) $\operatorname{deg}([f, g])=\operatorname{deg}(f)+\operatorname{deg}(g)$;
(ii) $[f, g]=-(-1)^{\operatorname{deg}(f) \operatorname{deg}(g)}[g, f]$;
(iii) $(-1)^{\operatorname{deg}(f) \operatorname{deg}(h)}[f,[g, h]]+(-1)^{\operatorname{deg}(f) \operatorname{deg}(g)}[g,[h, f]]+(-1)^{\operatorname{deg}(g) \operatorname{deg}(h)}[h,[f, g]]=$ 0 (graded Jacobi indentity).
Proposition 2.3. If $\circ: C_{\beta}(M) \times C_{\beta}(M) \rightarrow C_{\beta}(M)$ is a bilinear map and the space $\left(C_{\beta}(M), \circ\right)$ is a graded pre-Lie algebra, i.e.

for all $f \in C_{\beta}^{m}(M), g \in C_{\beta}^{n}(M), h \in \mathbb{C}_{\beta}^{p}(M)$. The bracket

$$

make $C_{\beta}(M)$ a graded Lie algebra.

Proof. Similar to [23, 24].
Now, we construct an example of a bracket that makes a graded Liealgebra, which we will call $\beta$-NR-bracket.
Define a map $l: S h(p, q) \rightarrow\{1, \cdots, q-1\}$ by $l(\sigma)=1$ if $\sigma(p)<\sigma(p+1)$ and $l(\sigma)=i$ if $\sigma(p+1)<\cdots<\sigma(p+i-1)<\sigma(p)<\sigma(p+i)<\cdots<\sigma(p+q)$. Let $M$ be a vector space and let $\beta: M \rightarrow M$ a linear map. For $f \in C^{m}(M)$ and $g \in C^{n}(M)$, we define $f \circ_{l} g \in C^{m+n-1}(M)$ by

\left.\beta^{n-1}\left(a_{\sigma(n+i)}\right), g\left(a_{\sigma(1)}, \cdots, a_{\sigma(n)}\right), \beta^{n-1}\left(a_{\sigma(n+i+1)}\right), \cdots, \beta^{n-1}\left(a_{\sigma(n+m-1)}\right)\right) \quad(i=l(\sigma)) \tag{2.3}

and $[f, g]_{l} \in C^{m+n-1}(M)$ by

$[\cdot, \cdot]_{l}$ is called the left $\beta$-Nijenhuis-Richardson bracket ( NR for short).
For $d \in C^{2}(M)$ we have

$$
\frac{1}{2}[d, d]_{l}(a, b, c)=d(d(a, b), \beta(c))+d(\beta(b), d(a, c))-d(\beta(a), d(b, c))
$$

Hence, If $[d, d]_{l}=0$ then $(M, d, \beta)$ is left Hom-Leibniz algebra. Let $(M, d, \beta)$ a left Hom-Leibniz algebra. Define $D_{k}: C_{\beta}^{k}(M) \rightarrow C_{\beta}^{k+1}(M)$ by setting $D_{k}(f)=[d, f]_{l}$. Let $f \in C_{\beta}^{n}(M)$ and $g \in C_{\beta}^{m}(M)$. Direct calculations show that $f \circ_{l} g$ is a $(n+m-1)$ - $\beta$-cochain. Hence, $D_{k}(f) \in C_{\beta}^{m+1}(M)(n=2)$.
Proposition 2.4. The map $D_{k}$ is a $k$-coboundary operator, i.e $D_{k+1} \circ_{l} D_{k}=$ 0. Thus, we have a well-defined cohomological complex $\left(\bigoplus_{k>0} C_{\beta}^{k}(M), D_{k}\right)$.

Proof. First we show that $\left(M,[\cdot, \cdot]_{l}\right)$ is a graded Lie algebra. We use $\operatorname{Sh}(p, q, r)$ to denote the set of all ( $p, q, r$ )- unshuffles, that is, an element $\sigma$ in the permutation group $S_{p, q, r}$ satisfying $\sigma(1)<\sigma(2)<\cdots<\sigma(p) ; \sigma(p+1)<\sigma(p+2)<$ $\cdots<\sigma(p+q)$ and $\sigma(p+q+1)<\sigma(p+q+2)<\cdots<\sigma(p+q+s)$. We define the maps $l^{\prime}: \operatorname{Sh}(p, q, r) \rightarrow\{1, \cdots p+q-1\}$ by $l^{\prime}(\sigma)=1$ if $\sigma(p+1)<\sigma(p) ; l^{\prime}(\sigma)=i$ if $\sigma(p+1)<\cdots<\sigma(p+i-1)<\sigma(p)<\sigma(p+i) ;$ and $l ": S h(p, q, r) \rightarrow\{1, \cdots p-1\}$ by $l "(\sigma)=1$ if $\sigma(p+q)<\sigma(p+q+1)$; $l "(\sigma)=j$ if $\sigma(p+q+1)<\cdots<\sigma(p+q+j-1)<\sigma(p+q)<\sigma(p+q+j)$.

We compute $f \in C^{k}(M), g \in C^{l}(M)$ and $h \in C^{r}(M)$ :

A $k$ - $\beta$-cochain $f \in C_{\beta}^{k}(M)$ is called a $k$-cocycle if $D_{k}(f)=0 . k$ - $\beta$ cochain $f \in C_{\beta}^{k}(M)$ is called a $k$-coboundary if $f=D_{k}(g)$ for some $g \in$ $C_{\beta}^{k-1}(M)$. Denote by $Z_{\beta}^{k}(M)$ and $B_{\beta}^{k}(M)$ the sets of $k$-cocycles and $k$ coboundaries respectively. We define the $k$ th cohomology group $H_{\beta}^{k}(M)$ to be $Z_{\beta}^{k}(M) / B_{\beta}^{k}(M)$.
Now, we give the explicit description of the $k$-coboundary operator $D_{k}^{l}$.

+\sum_{1 \leq s<t \leq k+1} f\left(\beta\left(a_{1}\right), \cdots, \widehat{a_{s}}, \cdots, d\left(a_{s}, a_{t}\right), \beta\left(a_{t+1}\right), \cdots, \beta\left(a_{k+1}\right)\right) .

We thus find the expression of coboundary operator given in [8]. $Z_{\beta}^{k}(M)=$ $\operatorname{ker}\left(D_{k}\right)$ and $B_{\beta}^{k}(M)=\operatorname{Im}\left(D_{k}\right)$ and $H_{\beta}^{k}(M)=Z_{\beta}^{k}(M) / B_{\beta}^{k}(M)$.

### 2.1 Cohomology of right Hom-Leibniz algebras

In this subsection, we construct an example of a bracket that makes a graded algebra, which we will call right- $\beta$ NR bracket.
Define a map $r: S h(p, q) \rightarrow\{1, \cdots, q-1\}$ by $r(\sigma)=1$ if $\sigma(p)<\sigma(p+1)$ and $r(\sigma)=i$ if $\sigma(p+1)<\cdots \sigma(p+i-1)<\sigma(1)<\sigma(p+i)<\sigma(p+q)$.

Let $f \in C_{\beta}^{m}(M)$ and $g \in C_{\beta}^{n}(M)$. The right Hom-NR bracket is an element of $C_{\beta}^{m+n-1}(M)$ given by

for all $a_{1}, \cdots, a_{m+n-1}$.
For any $d \in \operatorname{Hom}\left(M^{2}, M\right)$, we have

Then, the triple $(M, d, \beta)$ is a right Hom-Leibniz algebra if and only if $[d, d]_{r}=0$.

Similar to left case we have
Proposition 2.5. The cohomology of a right $\operatorname{Hom-Leibniz}(M, d, \beta)$ algebra is determined by $D_{k}: C_{\beta}^{k}(M) \rightarrow C_{\beta}^{k+1}(M)$, given by $D_{k}(f)=[d, f]_{r}$

Then, $Z_{\beta}^{k}(M)=\operatorname{ker}\left(D_{k}\right), B_{\beta}^{k}(M)=\operatorname{Im}\left(D_{k}\right)$ and $H_{\beta}^{k}(M)=Z_{\beta}^{k}(M) / B_{\beta}^{k}(M)$.

### 2.2 Cohomology of symmetric Hom-Leibniz algebras

In this section, by the left $\beta$-NR bracket, we define the symmetric HomLeibniz algebras generalizing the well known Leibniz algebras given in [4, 16].

A $(m, n)-\beta$-cochain is a pair $(f, g)$ where $f \in C_{\beta}^{m}(M)$ and $g \in C_{\beta}^{n}(M)$ such that

for all $i, j \in\{1, \cdots, m+n-1\}, a_{1}, \cdots, a_{n+m-1} \in M$.
Definition 2.6. Let $d$ a (2,2)-beta-cochain. The triple $(M, d, \beta)$ is called a symmetric Hom-Leibniz algebra if $[d, d]_{l}=0$. i.e

\begin{aligned}
& d(\beta(a), d(b, c))=-d(d(b, c), \beta(a)) \\
& d(\beta(a), d(b, c))=d(d(a, b), \beta(c))+d(\beta(b), d(a, c))
\end{aligned}
$$

for all $a, b, c \in M$.
Clearly, the triple $(M, d, \beta)$ is symmetric Hom-Leibniz algebra if and only if it is a left and right Hom-Leibniz algebra.

Definition 2.7. A $k$-Hom cochain of the symmetric Hom-Leibniz algebra $(M, d, \beta)$ is a $k$-linear map $f$ such that the pair $(f, d)$ is a $(k, 2)-\beta$-cochain. We denote by $\operatorname{Alt}_{\beta}^{\prime k}(M)$ the set of all $k$-Hom cochain of the symmetric HomLeibniz algebra $M$.

Define $D_{k}^{\prime}: A l t_{\beta}^{\prime k}(M) \rightarrow A l t_{\beta}^{\prime k+1}(M)$ by setting

& D_{k}^{\prime}(f)\left(a_{1}, \cdots, a_{k+1}\right)=\sum_{s=1}^{k+1}(-1)^{k-s} d\left(\beta^{k-1}\left(a_{s}\right), f\left(a_{1}, \cdots, \widehat{a_{s}}, \cdots, a_{k+1}\right)\right. \\
& \quad+\sum_{1 \leq s<t \leq k+1} f\left(\beta\left(a_{1}\right), \cdots, \widehat{a_{s}}, \cdots, d\left(a_{s}, a_{t}\right), \beta\left(a_{t+1}\right), \cdots, \beta\left(a_{k+1}\right)\right)
\end{aligned}
$$

Proposition 2.8. The map $D_{k}^{\prime}$ is a coboundary operator, i.e. $D_{k+1} \circ D_{k}=0$.
Proof. Since $f$ is a $k$-Hom cochain of the symmetric Hom-Leibniz algebra ( $M, d, \beta$ ), we have

+d\left(\beta^{k-1}\left(a_{k+1}\right), f\left(a_{1}, \cdots, a_{k}\right)\right) \\
+\sum_{1 \leq s<t \leq k+1} f\left(\beta\left(a_{1}\right), \cdots, \widehat{a_{s}}, \cdots, d\left(a_{s}, a_{t}\right), \beta\left(a_{t+1}\right), \cdots, \beta\left(a_{k+1}\right)\right) .
\end{gathered}
$$

Therefore, by (2.9) we obtain $D_{k}^{\prime}(f)=[d, f]_{l}=D_{k}(f)$. Hence, from the Proposition 2.4 it follows that, $D_{k}^{\prime}$ is a coboundary operator and $Z_{\beta}^{k}(M)=$ $\operatorname{ker}\left(D_{k}^{\prime}\right), B_{\beta}^{k}(M)=\operatorname{Im}\left(D_{k}^{\prime}\right)$ and $H_{\beta}^{k}(M)=Z_{\beta}^{k}(M) / B_{\beta}^{k}(M)$.

### 2.3 Cohomology of Hom-Lie algebras

Let $(M, d, \beta)$ be a Hom-Lie algebra. The set of $k$-Hom-cochains $A l t_{\beta}^{k}(M)$ of a Hom-Lie algebra $M$ with values in itself, is defined to be the vector space of all alternating $k$-linear map $f \in C_{\beta}^{k}(M)$ and $\operatorname{Alt}_{\beta}(M)$ denotes the direct sum $\oplus_{k \geq 0} A l t^{k}(M)$. Clearly $d$ is a 2-Hom-cochains of Hom-Lie algebra $(M, d, \beta)$. Moreover, by the Jacobi identity, we have

d(\beta(a), d(b, c))+d(\beta(b), d(c, a))+d(\beta(c), d(a, b))=0 .
$$

Since $d$ is a alternating 2-linear map, one can deduce $[d, d]_{l}=0$.
Let $f, g \in A l t_{\beta}^{k}(M)$. Then, the definition (2) of "ol" becomes

Hence, the $\beta$-NR bracket for Hom-Lie algebra is given by

where $\circ_{L}$ is defined in (2.13). Define $D_{k}^{L}: \operatorname{Alt}_{\beta}^{k}(M) \rightarrow A l t_{\beta}^{k+1}(M)$ by setting $D_{k}^{L}(f)=[d, f]_{L}$.
Proposition 2.9. The map $D_{k}$ is a coboundary operator, i.e. $D_{k+1} \circ D_{k}=0$.
Proof. Since $D_{k}^{L}$ is the restriction of $D_{k}^{l}$ to $A l t_{\beta}^{k+1}(M)$ and $D_{k}^{l}$ is a coboundary operator, it suffices to show that $D_{k}^{L}(f) \in A l t_{\beta}^{k+1}(M)$. Let $i, j \in\{1, \cdots, l+$ $k-1\}$. If $i \in\{1, \cdots, l\}$ and $j \in\{l+1, \cdots, l+k-1\}$, we denote $S h^{\prime}(l, k-1)$ is the set of all permutation $\sigma^{\prime}$ of $\{1, \cdots, l+k-1\}$ such that

Define the permutation $\sigma=\tau \sigma^{\prime}$ where $\tau$ is the permutation $\tau=(i j)$. Then, (2.15), (2.14) can be re-expressed in the following way

=-\sum_{\sigma^{\prime} \in S h^{\prime}(l, k-1)} \epsilon\left(\sigma^{\prime}\right) f\left(g\left(a_{\sigma^{\prime}(1)}, \cdots, a_{\sigma^{\prime}(j)}, \cdots, a_{\sigma^{\prime}(l)}\right),\right. \\
\left.\beta^{l-1}\left(a_{\sigma^{\prime}(l+1)}\right), \cdots, \beta^{l-1}\left(a_{\sigma^{\prime}(i)}\right), \cdots, \cdots, \beta^{n-1}\left(a_{\sigma(n+m-1)}\right)\right) . \\
=-\sum_{\tau \sigma \in S h^{\prime}(l, k-1)} \epsilon(\tau \sigma) f\left(g\left(a_{\tau \sigma(1)}, \cdots, a_{\tau \sigma(j)}, \cdots, a_{\tau \sigma^{\prime}(l)}\right),\right. \\
\left.\beta^{l-1}\left(a_{\tau \sigma(l+1)}\right), \cdots, \beta^{l-1}\left(a_{\tau \sigma(i)}\right), \cdots, \cdots, \beta^{n-1}\left(a_{\tau \sigma(l+k-1)}\right)\right) . \\
=\sum_{\sigma \in S h(l, k-1)} \epsilon(\sigma) f\left(g\left(a_{\sigma(1)}, \cdots, a_{\sigma(i)}, \cdots, a_{\sigma(l)}\right),\right. \\
\left.\beta^{l-1}\left(a_{\sigma(l+1)}\right), \cdots, \beta^{l-1}\left(a_{\sigma(i)}\right), \cdots, \cdots, \beta^{l-1}\left(a_{\sigma(l+k-1)}\right)\right) . \\
=f \circ_{L} g\left(a_{1}, \cdots, a_{i}, \cdots, a_{j}, \cdots, a_{k+l-1}\right) .
\end{gathered}
$$

Then,
$D_{k}^{L}(f)\left(a_{1}, \cdots, a_{j}, \cdots, a_{l}, \cdots, a_{i}, \cdots, a_{l+1}\right)=-D_{k}^{L}(f)\left(a_{1}, \cdots, a_{i}, \cdots, a_{l}, \cdots, a_{j}, \cdots, a_{l+1}\right)$.
The cases $i, j \in\{1, \cdots, l\}$ and $i, j \in\{l+1, \cdots, l+k-1\}$ are easly. Therefore, $D_{k}^{L}(f) \in A l t_{\beta}^{k+1}(M)$.

Finally, we end this paragraph by the explicit description of the $k$-coboundary operator $D_{k}^{L}$ :

+\sum_{1 \leq s<t \leq k+1}(-1)^{s+t} f\left(d\left(a_{s}, a_{t}\right), \beta\left(a_{1}\right), \cdots, \widehat{a_{s}}, \cdots, \widehat{a_{t}}, \beta\left(a_{t+1}\right), \cdots, \beta\left(a_{k+1}\right)\right) . \\
Z_{\beta}^{k}(M)=\operatorname{ker}\left(D_{k}^{L}\right), B_{\beta}^{k}(M)=\operatorname{Im}\left(D_{k}^{L}\right) \text { and } H_{\beta}^{k}(M)=Z_{\beta}^{k}(M) / B_{\beta}^{k}(M) .
\end{gathered}
$$

Remark 2.10. If $\beta=i d_{M}$, whe have $A l t_{i d_{M}}^{k}(M)=\operatorname{Alt}^{k-1}(M)$ where $A l t^{k-1}(M)$ is the space of alternating maps defined in introduction of this paper.

## 3 Deformations of Hom-algebras

Recall that we mean by a Hom-algebra a left or right or symmetric HomLeibniz algebra or Hom-Lie algebra. If ( $M, d, \beta$ ) is a left (or right) HomLeibniz algebra $\chi_{\beta}(M)=C_{\alpha}^{k}(M)$. If $(M, d, \beta)$ is a symmetric Hom-Leibniz algebra, $\chi_{\beta}(M)=A l t_{\beta}^{\prime}(M)$. If $(M, d, \beta)$ is a Hom-Lie algebra $\chi_{\beta}(M)=$ $\operatorname{Alt}_{\beta}(M)$.

Let $\left(M, d_{0}, \beta\right)$ be a Hom-algebra and $[\cdot, \cdot]$ the $\beta_{0}$-NR bracket. A oneparameter formal Hom-algebra deformation of $M$ is given by the $\mathbb{K}[[t]]$ bilinear $d_{t}=\sum_{i \geq 0} t^{i} d_{i}\left(\right.$ where each $\left.d_{i} \in \chi_{\beta}^{2}(M)\right)$ satisfies $\left[d_{t}, d_{t}\right]=0$ which is equivalent to the follwing infinite system

$$
\begin{equation*}
\sum_{0 \leq i \leq s}\left[d_{i}, d_{s-i}\right]=0, \text { for } s=0,1,2, \cdots \tag{3.1}
\end{equation*}
$$

In particular, For $s=0$ we have $\left[d_{0}, d_{0}\right]$ wich is the Hom-Jacobie identity of $M$.
The equation for $s=1$, leads to

$$
\begin{equation*}
\left[d_{0}, d_{1}\right]=0 \tag{3.2}
\end{equation*}
$$

Then $d_{1}$ is a 2 -cocycle.
For $s=2$, we obtain

$$
\begin{equation*}
\left[d_{0}, d_{2}\right]+\frac{1}{2}\left[d_{1}, d_{1}\right]=0 \tag{3.3}
\end{equation*}
$$

Hence $\left[d_{1}, d_{1}\right]$ is a 3 -cobord (i.e $\left[d_{1}, d_{1}\right] \in B^{3}(M)$ ). So it is a trivial 3-cocycle. For $s>2$ we have

a_{s}=2\left[d_{0}, d_{s}\right]+\Psi\left(d_{1}, \cdots, d_{s-1}\right)=0
$$

where $\Psi\left(d_{1}, \cdots, d_{s-1}\right)=\sum_{i=1}^{s-1}\left[d_{i}, d_{s-i}\right]$. Clearly $\Psi\left(d_{1}, \cdots, d_{s-1}\right)$ is a 3 -cobord on $M$.
Conversely, let $d_{t}=\sum_{i \geq 0} t^{i} d_{i}$. Hence $\left[d_{t}, d_{t}\right]=\sum_{i \geq 0} a_{s} t^{s}$ where $a_{1}=2\left[d_{0}, d_{1}\right]$ and

$$
a_{s}=2\left[d_{0}, d_{s}\right]+\Psi\left(d_{1}, \cdots, d_{s-1}\right), \text { where } s \geq 2 .
$$

We assume that $\Psi\left(d_{1}, \cdots, d_{s-1}\right)$ is a 3 -coboundary, then there a exists $d_{s}^{\prime} \in$ $\chi(M)$ such that $\Psi\left(d_{1}, \cdots, d_{s-1}\right)=\left[d_{0}, d_{s}^{\prime}\right]$. Hence $a_{s}=\left[d_{0}, 2 d_{s}+d_{s}^{\prime}\right]$ for all $s>1$.

Consequently, we have proved the following Proposition.

Proposition 3.1. Let $\left(d_{i}\right)_{i \in \mathbb{N}}$ a set of 2-Hom-cohain in $\left(M, d_{0}, \beta\right)$. Then $d_{t}=\sum_{i \geq 0} t^{i} d_{i}$ is a one-parameter formal Hom-Leibniz algebra deformation of $M$ if and only if the following statements are satisfies:
(i) $d_{1}$ is a 2-cocycle on $M$;
(ii) for all $s>1$ it exists a $d_{s}^{\prime} \in \chi(M)$ such that $\Psi\left(d_{1}, \cdots, d_{s-1}\right)=\left[d_{0}, d_{s}^{\prime}\right]$ and $2 d_{s}+d_{s}^{\prime}$ is a 2 -cocycle on $M$.
Definition 3.2. The deformation is said to be of order $k$ if $d_{t}=\sum_{i=0}^{k} d_{i} t^{i}$.
Now, we assume that the deformation is of order $k-1$ and let $d_{t}^{\prime}=d_{t}+d_{k} t^{k}$ and $\left[d_{t}^{\prime}, d_{t}^{\prime}\right]=\sum_{i=0}^{k-1} a_{i} t^{i}$. Then $a_{k}=2\left[d_{0}, d_{k}\right]+\Psi\left(d_{1}, \cdots, d_{k-1}\right)$. Hence, if $a_{k}=0$, $\Psi\left(d_{1}, \cdots, d_{k-1}\right)$ is a 3 -cobord in $M$.
Conversely, we assume that $\Psi\left(d_{1}, \cdots, d_{k-1}\right)$ is a 3 -cobord in $M$. Then there exists a $d_{k} \in \chi_{\beta}^{2}(M)$ satisfies $\Psi\left(d_{1}, \cdots, d_{k-1}\right)=-2\left[d_{0}, d_{k}\right]$. Hence $a_{k}=0$. Then we get the following result.
Proposition 3.3. Let $\left(M, d_{0}, \beta_{0}\right)$ be a Hom-algebra and $M_{t}=\left(M, d_{t}, \beta_{0}\right)$ be $a(k-1)$-order one-parameter formal deformation of $M$, where $d_{t}=\sum_{i=0}^{k-1} d_{i} t^{i}$. Then

$$
\Psi\left(d_{1}, \cdots, d_{k-1}\right)=\sum_{i=1}^{k-1}\left[d_{i}, d_{k-i}\right] .
$$

is a 3-cocycle of $M$. Therefore the deformation extends to a deformation of order $k$ if and only if $\Psi\left(d_{1}, \cdots, d_{k-1}\right)$ is a 3 -coboundary.

Definition 3.4. Let $\left(L, d_{0}, \beta\right)$ be a Hom-algebra. Given two deformation $M_{t}=\left(M, d_{t}, \beta\right)$ and $M_{t}^{\prime}=\left(M, d_{t}^{\prime}, \beta\right)$ of $M$ where $d_{t}=\sum_{i \geq 0} t^{i} d_{i}, d_{t}^{\prime}=\sum_{i \geq 0} t^{i} d_{i}^{\prime}$.
We say that they are equivalent if there exists a formal automorphism $\phi_{t}=$ $\exp (t \phi)$ where $\phi \in \operatorname{End}(M)$ such that

$$
\begin{equation*}
\phi_{t} \circ d_{t}=d_{t}^{\prime} \star \phi_{t} \tag{3.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\phi_{t} \circ \beta=\beta^{\prime} \circ \phi_{t} . \tag{3.5}
\end{equation*}
$$

A deformation $M_{t}$ is said to be trivial if and only if $M_{t}$ is equivalent to $M$ (viewed as an algebra on $M[[t]]$ ).

The equation (3.4) is equivalent to

$$
\begin{equation*}
\sum_{i, j \geq 0} \phi_{i}\left(d_{j}\right) t^{i+j}=\sum_{i, j, k \geq 0} d_{i}^{\prime} \star\left(\phi_{j}, \phi_{k}\right) t^{i+j+k} \tag{3.6}
\end{equation*}
$$

By identification of coefficients, one obtain that the constant coefficients are identical, i.e.

d_{0}=d_{0}^{\prime} \text { because } \Phi_{0}=I d
$$

For coefficients of $t$ one has

Hence $d_{1}^{\prime}=d_{1}+\left[d_{0}, \phi_{1}\right]$.
The condition on homomorphisms (3.5) implies that $\beta=\beta^{\prime} \bmod t$ and that

Then $\beta_{1}=\beta_{1}^{\prime}$.
Consequently the following Proposition holds.
Proposition 3.5. Let $\left(M, d_{0}, \beta_{0}\right)$ be a Hom-Leibniz algebra. There is, over $\mathbb{K}[[t]] / t^{2}$, a one-to-one correspondence between the elements of $H^{2}(M)$ and the infinitesimal deformation defined by

$$
d_{t}=d_{0}+d_{1} t
$$

Hence, if the Hom-Leibniz algebra $M$ is rigid then every formal deformation is equivalent to a trivial deformation.

Remark 3.6. If $\left(M, d_{0}, \beta_{0}\right)$ is a symmetric Hom-Leibniz algebra. Then, $\chi_{\beta}^{2}(M)=A l t_{\beta}^{\prime 2}$. Hence, the condition $d_{t} \in \chi_{\beta}^{2}(M)$ is equivalent to $d_{i}\left(\beta(a), d_{i}(b, c)\right)=$ $-d_{i}\left(d_{i}(b, c), \beta(a)\right)$ for all $a, b, c \in M$.

Remark 3.7. If $\left(M, d_{0}, \beta_{0}\right)$ is a Hom-Lie algebra. Then, $\chi_{\beta}^{2}(M)=\operatorname{Alt}_{\beta}^{2}(M)$. Hence, the condition $d_{t} \in \chi_{\beta}^{2}(M)$ is equivalent to $d_{i}(a, b)=-d_{i}(b, a)$ for all $a, b \in M$.

## 4 Extension and representation of Hom-algebras

The principal aim of this section is to extend some notions and results about extension of Lie algebras [15] to more generalized cases: Hom-Leibniz algebras and Hom-Lie algebras.

Definition 4.1. Let $(L, \delta, \alpha)$, $\left(V, \mu, \alpha_{V}\right)$, and $\left(M, d, \alpha_{M}\right)$ be Hom-algebras and $i: V \rightarrow M, \pi: M \rightarrow L$ be morphisms of Hom-algebras. The following sequence of Hom- algebra is a short exact sequence if $\operatorname{Im}(i)=\operatorname{ker}(\pi), i$ is injective and $\pi$ is surjective:

$$
0 \longrightarrow\left(V, \mu, \alpha_{V}\right) \xrightarrow{i}\left(M, d, \alpha_{M}\right) \xrightarrow{\pi}(L, \delta, \alpha) \longrightarrow 0,
$$

where

$$
\begin{equation*}
\alpha_{M} \circ i=i \circ \alpha_{V} \text { and } \alpha \circ \pi=\pi \circ \alpha_{M} . \tag{4.1}
\end{equation*}
$$

In this case, we call $\left(M, d, \alpha_{M}\right)$ an extension of $(L, \delta, \alpha)$ by $\left(V, \mu, \alpha_{V}\right)$.
An extension $0 \longrightarrow\left(V, \mu, \alpha_{V}\right) \xrightarrow{i}\left(M, d, \alpha_{M}\right) \xrightarrow{\pi}(L, \delta, \alpha) \longrightarrow 0$ is called:
(1) trivial if there exists an ideal I complementary to ker $\pi$,
(2) split if there exists a Hom-subalgebra $S \subset M$ complementary to $\operatorname{ker} \pi$,
(3) central if the $\operatorname{ker} \pi$ is contained in the center $Z(M)$ of $M$. That is $d(i(V), M)=0$.
(4) abelian if $\mu=0$.

The standard split extension $E_{0}$ of $L$ by $V$ is given by

$$
E_{0}: 0 \longrightarrow\left(V, \mu, \alpha_{V}\right) \xrightarrow{i_{0}}\left(L \oplus V, d, \alpha+\alpha_{V}\right) \xrightarrow{\pi_{0}}(L, \delta, \alpha) \longrightarrow 0,
$$

where $i_{0}(v)=v, \pi_{0}(x+v)=x$.

### 4.1 Representation and cohomology of Hom-algebras

In Section 2 we have defined the cohomology of a Hom-algebra on it self (adjoint representation). In this section we define, starting with a split extension of Hom- algebra a representation and cohomology of Hom-algebras $L$ on a Hom-algebras $V$.

Let $(L, \delta, \alpha)$ and $\left(V, \mu, \alpha_{V}\right)$ be two Left Hom-algebras over $\mathbb{K}$ such that $0 \longrightarrow\left(V, \mu, \alpha_{V}\right) \xrightarrow{i}\left(L \oplus V, d, \alpha+\alpha_{V}\right) \xrightarrow{\pi}(L, \delta, \alpha) \longrightarrow 0$ be a split extension of $L$ by $V$. For convenience, we introduce the following notation for certain spaces of cochains on $M=L \oplus V: C^{n}(M)=\operatorname{Hom}\left(M^{n}, M\right), C^{n}(L)=$ $\operatorname{Hom}\left(L^{n}, L\right)$ and $C^{k, l}(L V, V)=\operatorname{Hom}\left(L^{k} V^{l}, V\right)$, where $L^{k} V^{l}$ is the subspace of $C^{k+l}(M)$ consisting by products of $k$ elements from $L$ and $l$ elements from $V$ ordered by $\sigma \in \operatorname{Sh}(l, k-1)$. Let $\beta=\alpha+\alpha_{V},[\cdot, \cdot]$ be a $\beta$-NR bracket (left or right) and $d \in C^{2}(M)$. We want to determine the conditions under
which $(L \oplus V, d, \beta)$ is a Hom algebra and $V$ is an ideal of $M=L \oplus V$. For all $f \in C^{2}(M), u, v \in C^{1}(M)$, denote

$$
f \star(u, v)(a, b)=f(u(a), v(b))
$$

and if $u=v$ we denote $f \star u(a, b)=f(u(a), u(b))$ for all $a, b \in M$. If $V$ is an ideal of Hom algebra $L \oplus V$, then $[d, d]=0$ and there exists $\delta \in C^{2}(L), \lambda_{l} \in C^{1,1}(L V, V), \lambda_{r} \in C^{1,1}(V L, V), \theta \in C^{2,0}(L, V), \mu \in C^{2}(V)$ such that $d=\delta+\lambda_{r}+\lambda_{l}+\mu+\theta$. Hence

$$
\left[\delta+\lambda_{r}+\lambda_{l}+\mu+\theta, \delta+\lambda_{r}+\lambda_{l}+\mu+\theta\right]=0
$$

Therefore
$\underbrace{[\delta, \delta]}_{=0}+\underbrace{2\left[\delta, \lambda_{r}+\lambda_{l}\right]+\left[\lambda_{r}+\lambda_{l}, \lambda_{r}+\lambda_{l}\right]+2[\mu, \theta]}_{\in C^{2,1}}+\underbrace{2\left[\mu, \lambda_{r}+\lambda_{l}\right]}_{\in C^{1,2}}+\underbrace{\left[\delta+\lambda_{r}+\lambda_{l}, \theta\right]}_{\in C^{3,0}}+\underbrace{[\mu, \mu]}_{=0}=0$.
Then we can deduce that
$2\left[\delta, \lambda_{r}+\lambda_{l}\right]+\left[\lambda_{r}+\lambda_{l}, \lambda_{r}+\lambda_{l}\right]+2[\mu, \theta]:$ The "module" or "representation" relation
$\left[\mu, \lambda_{r}+\lambda_{l}\right]=0$ : The module-algebra structures are compatible
$\left[\delta+\lambda_{r}+\lambda_{l}, \theta\right]=0: \theta$ is a 2 -cocycle with values in $V$.
By $d$ is a $2-\beta$ cochain, we have

$$
\left(\delta+\lambda_{r}+\lambda_{l}+\mu+\theta\right) \star\left(\alpha+\alpha_{V}\right)=\left(\alpha+\alpha_{V}\right) \circ\left(\delta+\lambda_{r}+\lambda_{l}+\mu+\theta\right) .
$$

Then

$$
\begin{align*}
\delta \star \alpha & =\alpha \circ \delta  \tag{4.5}\\
\lambda_{r} \star\left(\alpha_{V}, \alpha\right) & =\alpha_{V} \circ \lambda_{r}  \tag{4.6}\\
\lambda_{l} \star\left(\alpha, \alpha_{V}\right) & =\alpha_{V} \circ \lambda_{l}  \tag{4.7}\\
\mu \star \alpha_{V} & =\alpha_{V} \circ \mu  \tag{4.8}\\
\theta \star \alpha & =\alpha_{V} \circ \theta . \tag{4.9}
\end{align*}
$$

By (4.6),(4.7) and (4.2) we have:
Definition 4.2. A representation (module) of the Hom-Leibniz algebra (L, $\delta, \alpha$ ) is a Hom-module $\left(V, \mu, \alpha_{V}\right)$ equiped with two $L$-actions (left and right) $\lambda_{l}: L \times$
$V \rightarrow V, \lambda_{r}: V \times L \rightarrow V$ and a bilinear map $\theta \in C^{2,0}(L, V)$ satisfying the following axioms,

$$
\begin{aligned}
& \lambda_{r} \star\left(\alpha_{V}, \alpha\right)=\alpha_{V} \circ \lambda_{r} \\
& \lambda_{l} \star\left(\alpha, \alpha_{V}\right)=\alpha_{V} \circ \lambda_{l} \\
& {\left[\delta, \lambda_{r}+\lambda_{l}\right]+\frac{1}{2}\left[\lambda_{r}+\lambda_{l}, \lambda_{r}+\lambda_{l}\right]+[\mu, \theta]=0}
\end{aligned}
$$

For the case of left Leibniz algebra, the previous definition can be written as follows:

Definition 4.3. A representation (module) of the left Hom-Leibniz algebra $(L, \delta, \alpha)$ is a Hom-module ( $V, \mu, \alpha_{V}$ ) equiped with two L-actions (left and right) $\lambda_{l}: L \times V \rightarrow V, \lambda_{r}: V \times L \rightarrow V$ and a bilinear map $\theta \in C^{2,0}$ satisfying the following axioms,

$$
\begin{aligned}
\lambda_{r}\left(\alpha_{V}(v), \alpha(x)\right) & =\alpha_{V}\left(\lambda_{r}(v, x)\right) \\
\lambda_{l}\left(\alpha(x), \alpha_{V}(v)\right) & =\alpha_{V}\left(\lambda_{l}(x, v)\right) \\
\lambda_{l}\left(\alpha(x), \lambda_{l}(y, v)\right) & =\lambda_{l}\left(\delta(x, y), \alpha_{V}(v)\right)+\lambda_{l}\left(\alpha(y), \lambda_{l}(x, v)\right)+\mu\left(\theta(x, y), \alpha_{V}(v)\right) ; \\
\lambda_{l}\left(\alpha(x), \lambda_{r}(v, y)\right) & =\lambda_{r}\left(\lambda_{l}(x, v), \alpha(y)\right)+\lambda_{r}\left(\alpha_{V}(v), \delta(x, y)\right)+\mu\left(\alpha_{V}(v), \theta(x, y)\right) \\
\lambda_{r}\left(\alpha_{V}(v), \delta(x, y)\right) & =\lambda_{r}\left(\lambda_{r}(v, x), \alpha(y)\right)+\lambda_{l}\left(\alpha(x), \lambda_{r}(v, y)\right)-\mu\left(\alpha_{V}(v), \theta(x, y)\right) .
\end{aligned}
$$

for any $x, y \in L$ and $v \in V$.
Remark 4.4. (1) If $L$ and $V$ be right Hom-Leibniz algebras and $\mu=0$ (or $\theta=0), \lambda=\lambda_{r}+\lambda_{l}$ is the representation of $L$ on $V$ defined in (1.4).
(2) If $L$ and $V$ be Hom-Lie algebras. Then $A l t^{k}(M)$ is the set of $k$-cochains. Hence, by $d \in A_{t}{ }^{2}(M)$ we obtain $\lambda_{l}(x, v)=-\lambda_{r}(v, x)$. Therefore $\lambda=$ $\lambda_{r}+\lambda_{l} \in$ Alt $^{2}(M)$ and $\lambda$ is the representation of $L$ on $V$ defined in [25].
(3) If $L$ and $V$ be symmetric Hom-Leibniz algebras. Then $C_{\beta}^{\prime k}(M)$ is the set of $k$-cochains. Hence, by $d \in C_{\beta}^{\prime 2}(M)$ we have

$$
\begin{aligned}
\lambda_{l}\left(\alpha(x), \lambda_{l}(y, v)\right) & =-\lambda_{r}\left(\lambda_{l}(y, v), \alpha(x)\right) \\
\lambda_{l}\left(\alpha(x), \lambda_{r}(v, y)\right) & =-\lambda_{r}\left(\lambda_{r}(v, y), \alpha(x)\right) \\
\lambda_{r}\left(\alpha_{V}(v), \delta(x, y)\right) & =-\lambda_{l}\left(\delta(x, y), \alpha_{V}(v)\right) \\
\mu\left(\alpha_{V}(u), \lambda_{r}(v, x)\right) & =-\mu\left(\lambda_{r}(v, x), \alpha_{V}(u)\right) \\
\mu\left(\alpha_{V}(u), \lambda_{l}(x, v)\right) & =-\mu\left(\lambda_{l}(x, v), \alpha_{V}(u)\right) \\
\lambda_{l}(\alpha(x), \mu(u, v)) & =-\lambda_{r}(\mu(u, v), \alpha(x))
\end{aligned}
$$

for all $x, y \in L, u, v \in V$. That is

$$
\begin{equation*}
\lambda,(\lambda, \delta),(\mu, \lambda),(\lambda, \mu) \in C_{\beta}^{\prime 2}(M) \tag{4.10}
\end{equation*}
$$

Now, by (4.1) and (4.9) we define the 2 cocycle as follow.
Definition 4.5. Let $(L, \delta, \alpha)$ be a Hom algebra and $\left(V, \mu, \alpha_{V}\right)$ be a representation of L. If the bilinear map $\theta$ satisfies

$$
\begin{align*}
& \theta \star \alpha=\alpha_{V} \circ \theta  \tag{4.11}\\
& {\left[\delta+\lambda_{r}+\lambda_{l}, \theta\right]=0 .} \tag{4.12}
\end{align*}
$$

Then $\theta$ is called a 2- cocycle of the Hom algebra $(L, \delta, \alpha)$ related to the representation $\left(V, \mu, \alpha_{V}\right)$, or simply a 2 -cocycle of $L$ on $V$. The set of all 2 -cocycles on $V$ is denoted $Z^{2}(L, V)$ or $Z^{2}\left(L, V, \lambda_{r}+\lambda_{l}\right)$.

For example for the left Hom-Leibniz case, the equalities (4.11) and (4.12) are equivalent to

$$
\begin{gathered}
\theta(\alpha(x), \alpha(y))=\alpha_{V}(\theta(x, y)) ; \\
\theta(\delta(x, y), \alpha(z))+\theta(\alpha(y), \delta(x, z))-\theta(\alpha(x), \delta(y, z)) \\
+\lambda_{r}(\theta(x, y), \alpha(z))+\lambda_{l}(\alpha(y), \theta(x, z))-\lambda_{l}(\alpha(x), \theta(y, z))=0
\end{gathered}
$$

(i.e $[d, \theta]=0$ ).

Since $[\mu, \mu]=0, \mu \star\left(\alpha+\alpha_{V}\right)=\left(\alpha+\alpha_{V}\right) \circ \mu$ and $\left[\mu, \lambda_{r}+\lambda_{l}\right]=0$, then by section 2, $\lambda_{r}+\lambda_{l}$ is a 2-cocycle of Hom-Leibniz algebra $\left(M, \mu, \alpha+\alpha_{V}\right)$.

We summarize the main facts in the theorem below.
Theorem 4.6. $0 \longrightarrow\left(V, \mu, \alpha_{V}\right) \xrightarrow{i}\left(L \oplus V, d, \alpha+\alpha_{V}\right) \xrightarrow{\pi}(L, \delta, \alpha) \longrightarrow 0$ is a split extension of $L$ by $V$ if and only if $d=\delta+\lambda_{r}+\lambda_{l}+\mu+\theta$, where $\lambda=\lambda_{r}+\lambda_{l}$ is a representation of $L$ on $V$ also it is a representation of $\left(M, \mu, \alpha+\alpha_{V}\right)$ and $\theta$ is a 2-cocycle of $L$ on $V$. Precisely when the six conditions below hold:

$$
\begin{align*}
\lambda_{r} \star\left(\alpha_{V}, \alpha\right) & =\alpha_{V} \circ \lambda_{r}  \tag{4.13}\\

Theorem 4.7. Let $(L, \delta, \alpha)$ and $\left(V, \mu, \alpha_{V}\right)$ be symmetric Hom-Leibniz algebras. Then, $0 \longrightarrow\left(V, \mu, \alpha_{V}\right) \xrightarrow{i}\left(L \oplus V, d, \alpha+\alpha_{V}\right) \xrightarrow{\pi}(L, \delta, \alpha) \longrightarrow 0$ is a split extension of $L$ by $V$ if and only if there exists $d=\delta+\lambda_{r}+\lambda_{l}+\mu+\theta$, where $\lambda_{r}, \lambda_{l}$ and $\theta$ satisfies the equations (4.10), (4.13), (4.14), (4.15), (4.16), (4.17) and (4.18).

Definition 4.8. Let $(L, \delta, \alpha)$ be a Hom-Leibniz algebra, and let $\left(V, \mu, \alpha_{V}\right)$ be a $(\lambda, \theta)$-representation of $(L, \delta, \alpha)$. Then for every linear map $h: L \rightarrow V$ satisfying $h \circ \alpha=\alpha_{V} \circ h$, the bilinear map $[d, h]_{l}: L \times L \rightarrow V$ is called a 2 -coboundary on $V$. The set of all 2 -coboundaries on $V$ is denoted $B^{2}(L, V)$. The quotient vector space $H^{2}(L, V)=Z^{2}(L, V) / B^{2}(L, V)$ is called the second cohomology group of $L$ on $V$.

Let $(L \oplus V, d, \alpha+\beta)$ an extension of Hom-Leibniz algebra $(L, \delta, \alpha)$. Define the operator $D^{k}: C^{k}(L, V) \rightarrow C^{k+1}(L, V)$ by

+\sum_{s=1}^{k}(-1)^{k-s} \lambda_{l}\left(\alpha\left(x_{s}\right), g\left(x_{1}, \cdots, \widehat{x_{s}}, \ldots, x_{k+1}\right)\right)+\lambda_{r}\left(g\left(x_{1}, \cdots, x_{k}\right), \alpha\left(x_{k+1}\right)\right)
\end{gathered}

where $x_{1}, \cdots, x_{k+1} \in L$ and $\widehat{x}_{s}$ means that $x_{s}$ is omitted.
Proposition 4.9. The map $D$ is a coboundary operator, i.e. $D^{2}=0$.
Proof. This is a direct result of Proposition 2.4 (2.5) for the right case, 2.8 for the symmetric case).

### 4.2 Equivalence of extensions of Hom-algebras

be a split extension of $L$ by $V$. Then there exist bilinear map $d=\delta+\lambda_{l}+$ $\lambda_{r}+\theta+\mu$ such that $\left(\lambda_{l}, \lambda_{r}\right)$ is a representation of $L, \theta$ is a 2 -cocycle and the short exact sequence

The map $\pi_{/ H}: H \rightarrow L(\operatorname{resp} k: V \rightarrow i(V))$ defined by $\pi_{/ H}(x)=\pi(x)$ (resp. $k(v)=i(v))$ is bijective, its inverse $s$ (resp. $l$ ). Considering the map $\Phi: L \oplus$ $V \rightarrow M$ defined by $\Phi(x+v)=s(x)+i(v)$, it is easy to verify that $\Phi$ is an isomorphism, $i(V)$ is an ideal of $M$ and $M=s(L) \oplus i(V)$. Then (by the provious section ), $d^{\prime}=\delta^{\prime}+\lambda_{r}^{\prime}+\lambda_{l}^{\prime}+\theta^{\prime}+\mu^{\prime}$ where $\left(\lambda_{r}^{\prime}, \lambda_{l}^{\prime}\right)$ is a representation of $s(L)$ on $i(V)$ also it is a representation of $\left(M, \mu, \alpha+\alpha_{V}\right)$ and $\theta^{\prime}$ is a 2 -cocycle of $s(L)$ on $i(V)$.

Define a bilinear map $d: L \oplus V \rightarrow L \oplus V$ by

By (4.19) we have $\delta=\pi \circ\left(\delta^{\prime} \star s\right), \theta=k \circ\left(\theta^{\prime} \star s\right), \lambda_{l}=k \circ\left(\lambda_{l}^{\prime} \star(s, i)\right), \lambda_{r}=k \circ\left(\lambda_{r}^{\prime} \star(i, s)\right), \mu=k \circ(\mu \star i)$ and $d=\delta+\theta+\lambda_{l}+\lambda_{r}+\mu$.

We deduce from the last theorem that any split extension of $M$ by $V$ is equivalent to

Let h be a 1 -Hom cochain of $L$ on $V$ and $d^{\prime}=$ $d+[d, h]$. Then, the extensions $\left(L \oplus V, d, \alpha+\alpha_{V}\right)$ and $\left(L \oplus V, d^{\prime}, \alpha+\alpha_{V}\right)$ are equivalents.

Proof. We have $d=\delta+\lambda_{r}+\lambda_{l}+\theta(\mu=0)$ and

Proposition 4.13. Let $\left(M, d^{\prime}, \beta\right)$ a split extension of a Hom-algebra $(L, \delta, \alpha)$ by $\left(V, \mu, \alpha_{V}\right)$. Then there it equivalent to $\left(L \oplus V, d, \alpha+\alpha_{V}\right)$ where $d=\delta+$ $\lambda_{r}+\lambda_{l}+\theta+\mu$. This extension is
(i) trivial if and only if $d=\delta+\mu$.
(ii) central if and only if $d=\delta+\theta+\mu$

Proof. (i) Let $\left(L \oplus V, d, \alpha+\alpha_{V}\right)$ be a trivial extension of a Hom-algebra $(L, \delta, \alpha)$ by $\left(V, \mu, \alpha_{V}\right)$. that is, there exists an ideal $I$ complementary to ker $\pi_{0}$. So $L \oplus V=I \oplus V$. Let $x \in L$ then one can write it as $x=i+v$ where $i \in I$ and $v \in V$. Hence, $\lambda_{r}(w, x)=\lambda_{r}(w, i+v)=\lambda_{r}(w, i)$ which implies that $\lambda_{r}(w, x) \in I \cap V$. Therefore $\lambda_{r}(w, x)=0$. Similarly, we can obtain $\lambda_{l}(x, w)=0$ for all $x \in L, w \in V$. Moreover, we have $\theta(i+v, j+w)=\theta(i, j) \in I \cap V$ so $\theta=0$.
Conversely, suppose that $\lambda_{r}=\lambda_{l}=\theta=0$. Then $d(L, V) \subset L$. Moreover, we have $\left(\alpha+\alpha_{V}\right)(L) \subset L$. Hence, $L$ is an ideal of $L \oplus V$.
(ii) Let $\left(L \oplus V, d, \alpha+\alpha_{V}\right)$ be a central extension of a Hom-algebra $(L, \delta, \alpha)$ by $\left(V, \mu, \alpha_{V}\right)$. Then $d(V, M)=d(M, V)=0$. Hence, $\left(\delta+\lambda_{r}+\lambda_{l}+\right.$ $\theta+\mu)(v, x+w)=0$. Therefore, $\lambda_{r}(v, x)+\mu(v, w)=0$. So $x=0$ gives $\mu=0$ and $w=0$ gives $\lambda_{r}=0$. Similarly, we obtain $\lambda_{l}=0$. Conversely, suppose that $d=\delta+\theta$. Then, $d(V, M)=0$.

Now, we extend the definition of the semidirect sum of Lie-algebras given in [13] to any Hom case.

Definition 4.14. An extension $(L \oplus V, d, \beta)$ is called semidirect sum of Homalgebras $L$ and $V$ if and only if

An element $d \in C^{2}(M)$ is called an $\alpha_{V}^{k}$-quasiderivation of $V$, if there exist $d^{\prime} \in C^{2}(M)$ such that $\mu \star$ $\left(d, \beta^{k}\right)+\mu \star\left(\beta^{k}, d\right)=d^{\prime} \circ \mu$. Denote by $Q D e r_{\alpha_{V}^{k}}$ the set of $\alpha_{V}^{k}$-quasiderivation.

Proposition 4.16. An extension $(L \oplus V, d, \beta)$ is a semidirect sum of HomLie algebras $(L, \delta, \alpha)$ and $\left(V, \mu, \alpha_{V}\right)$ if and only if

Define a linear maps $\lambda: L \rightarrow \operatorname{End}(V)$ by $\lambda(x)=\lambda_{l}(x, \cdot)$ and $d: L \rightarrow \operatorname{End}(V)$ by $d(x)=\lambda_{l}(\alpha(x), \cdot)$, for all $x \in L$. By (4.3), we obtain

We have $i(v)=\Phi(v)=\Phi\left(i_{0}(v)\right)=i^{\prime}(\varphi(v))=\varphi(v)$ or $\varphi(v) \in V^{\prime}$. Then $s_{2}=0$. We will search relationship between $\left(\lambda_{r}, \lambda_{l}\right)$ and $\left(\lambda_{r}^{\prime}, \lambda_{l}^{\prime}\right), \theta$ and $\theta^{\prime}, \mu$ and $\mu^{\prime}$.

An extension $\left(L^{\prime} \oplus V^{\prime}, d^{\prime}, \alpha^{\prime}+\alpha_{V^{\prime}}\right)$ is equivalent to $(L \oplus V, d, \beta)$ if and only if there exists isomorphism of Hom-algebras $\varphi: V \rightarrow V^{\prime}, \psi: L \rightarrow L^{\prime}$ and a linear map $h: L \rightarrow V$ such that

$$
d^{\prime} \star(\psi, \varphi)=\psi \circ \delta+\varphi \circ \lambda_{r}+\varphi \circ \lambda_{l}+\varphi \circ \theta+\left[d^{\prime}, h\right] \star(\psi, \psi)
$$

where $d=\delta+\lambda_{r}+\lambda_{l}+\theta$.
Corollary 4.18. The set $\operatorname{Ext}\left(L, V, \lambda_{r}+\lambda_{l}\right)$ of equivalence classes of split extensions of $(L, \delta, \alpha)$ by an abelian Hom-algebra $\left(V, \alpha_{V}\right)$ is one-to-one correspondence with $Z^{2}\left(L, V, \lambda_{r}+\lambda_{l}\right) / B^{2}\left(L, V, \lambda_{r}+\lambda_{l}\right)$, that is

$$
\operatorname{Ext}\left(L, V, \lambda_{r}+\lambda_{l}\right) \cong Z^{2}\left(L, V, \lambda_{r}+\lambda_{l}\right) / B^{2}\left(L, V, \lambda_{r}+\lambda_{l}\right)
$$
