# Global solvability, stability and oscillation criteria for systems of two first-order pseudo linear ordinary differential equations

#### Abstract

In this paper we use the Riccati equation method with other ones to establish global solvability, stability and oscillation criteria for a class of two dimensional nonlinear systems of ordinary differential equations, which is a generalization of wide classes of second order nonlinear ordinary differential equations, studied by many authors. The applicability of some of these criteria are illustrated by examples.


Key words: the system of pseudo linear equations, the Riccati equation, global solvability, the van der Pol's equation, the Duffing's equation, the equation of Emden-Fowler.

1. Introduction. Let $P(t, u, v), Q(t, u, v), R(t, u, v), S(t, u, v), F(t, u, v)$ and $G(t, u, v)$ be real-valued locally integrable by $t$ and continuous by $u$ and $v$ functions on $\left[t_{0},+\infty\right) \times(\mathbb{R} \backslash\{0\}) \times(\mathbb{R} \backslash\{0\})$, where $\mathbb{R} \equiv(-\infty,+\infty)$. Consider the system of two first-order pseudo linear (i.e. like of linear) ordinary differential equations

In the particular case, when $F(t, u, v)=G(t, u, v) \equiv 0$ we have a "pseudo homogeneous" case of (1.1):

By a solution of the system (1.1) (of the system (1.2)) on $\left[t_{1}, t_{2}\right)\left(t_{0} \leq t_{1}<t_{2} \leq+\infty\right)$ we mean an ordered pair $(\phi(t), \psi(t))$ of absolutely continuous on $\left[t_{1}, t_{2}\right)$ functions $\phi(t)$ and $\psi(t)$, satisfying (1.1) ((1.2)) almost everywhere on $\left[t_{1}, t_{2}\right)$. According to the general theory
of normal systems of ordinary differential equations for every $\alpha, \beta \in \mathbb{R} \backslash\{0\}$ and $t_{1} \geq t_{0}$ there exists $t_{2}>t_{1}\left(t_{2} \leq+\infty\right)$ and a solution $(\phi(t), \psi(t))$ of the system (1.1) ((1.2)) on $\left[t_{1}, t_{2}\right)$ with $\phi\left(t_{1}\right)=\alpha, \psi\left(t_{1}\right)=\beta$. A great interest from the point of view of qualitative theory of differential equations represents the case $t_{2}=+\infty$. In this case we say that the system (1.1) ((1.2)) is global solvable. Indicate some well (and not so well) known non linear second order ordinary differential equations, which are reducible to the systems of type (1.1) or (1.2):

1. the van der Pol equation with parametric excitation (see [1], p. 333):

In this paper we prove global solvability, stability and oscillation criteria for the systems (1.1) and (1.2). We illustrate the applicability of some of these criteria by examples.
2. Auxiliary propositions. Let $(\phi(t), \psi(t))$ be a solution of the system (1.1) on $\left[t_{0}, t_{1}\right)\left(t_{1} \leq+\infty\right)$. We can interpret $\phi(t)$ as a solution of the linear equation

where $W(t) \equiv P(t, \phi(t), \psi(t)), U(t)=G(t, \phi(t), \psi(t)) \psi(t)+F(t, \phi(t), \psi(t)) \psi(t))$, $t \in\left[t_{0}, t_{1}\right)$. Then by Cauchi formula we have

Let $f_{k}(t), g_{k}(t), \quad h_{k}(t), \quad k=1,2$ be real-valued locally integrable functions on $\left[t_{0},+\infty\right)$. Consider the Riccati equations

By a solution of Eq. $\left(2.5_{k}\right)$ (of inequality $\left.\left(2.6_{k}\right)\right)$ on $\left[t_{1}, t_{2}\right)\left(t_{0} \leq t_{1}<t_{2} \leq+\infty\right)$ we mean an absolutely continuous function $y(t)(\eta(t))$ on $\left[t_{1}, t_{2}\right)$, satisfying $\left(2.5_{k}\right)\left(\left(2.6_{k}\right)\right)$ almost everywhere on $\left[t_{1}, t_{2}\right), \quad k=1,2$..

Remark 2.1. Every solution of Eq. $\left(2.5_{2}\right)$ on $\left[t_{0}, t_{1}\right)$ is also a solution of the inequality $\left(2.6_{2}\right)$ on $\left[t_{0}, t_{1}\right)$.

Remark 2.2. If $f_{1}(t) \geq 0, t \in\left[t_{0}, t_{1}\right)$, then every solution of the linear equation

is also a solution of the inequality $\left(2.6_{1}\right)$ on $\left[t_{0}, t_{1}\right)$.
Theorem 2.1. Let $y_{2}(t)$ be a solution of Eq. (2.52) on $\left[t_{0}, \tau_{0}\right)\left(t_{0}<\tau_{0} \leq+\infty\right)$ and let $\eta_{1}(t)$ and $\eta_{2}(t)$ be solutions of the inequalities $\left(2.6_{1}\right)$ and $\left(2.6_{2}\right)$ respectively on $\left[t_{0}, \tau_{0}\right)$ such that $y_{2}\left(t_{0}\right) \leq \eta_{k}\left(t_{0}\right) k=1,2$. In addition let the following conditions be satisfied: $f_{1}(t) \geq 0, \quad \gamma-y_{2}\left(t_{0}\right)+\int_{t_{0}}^{t} \exp \left\{\int_{t_{0}}^{\tau}\left[f_{1}(s)\left(\eta_{1}(s)+\eta_{2}(s)\right)+g_{1}(s)\right] d s\right\}\left[\left(f_{2}(\tau)-f_{1}(\tau)\right)^{2} y_{2}^{2}(\tau)+\right.$

Proof. By analogy of the proof of Theorem 3.1 from [7].
In the system (1.2) substitute

Lemma 2.1. Let $(\phi(t), \psi(t))$ be a solution of the system (1.2) on $\left[t_{0}, t_{1}\right)$. If $Q(t, \phi(t), \psi(t)) \geq 0, R(t, \phi(t), \psi(t)) \geq 0, t \in\left[t_{0}, t_{1}\right)$, then for every $\gamma \geq 0$ Eq. (2.7) (Eq. (2.9)) has a non negative solution $y(t)(z(t))$ on $\left[t_{0}, t_{1}\right)$.

Proof. Let us prove the existence of $y(t)$. Consider the Riccati equation

Then since $Q(t, \phi(t), \psi(t)) \geq 0$, $R(t, \phi(t), \psi(t)) \geq 0, t \in\left[t_{0}, t_{1}\right)$, using Theorem 2.1 to the pair of equations (2.7) and (2.13) we conclude that for every $\gamma \geq 0$ Eq. (2.7) has a non negative solution $y(t)$ on $\left[t_{0}, t_{1}\right)$ with $y\left(t_{0}\right)=\gamma$. The proof of existence of $z(t)$ can be made by analogy using Eq. (2.9) instead of Eq. (2.7). The lemma is proved.

Definition 2.1. An interval $\left[t_{0}, T\right)$ is called the maximum existence interval for a solution $(\phi(t), \psi(t))$ of the system (1.1), if $(\phi(t), \psi(t))$ satisfies (1.1) almost everywhere on $\left[t_{0}, T\right)$ and cannot be continued to the right from $T$ as a solution of Eq. (1.1).

Lemma 2.2. Assume $P(t, u, v), Q(t, u, v), R(t, u, v), S(t, u, v), F(t, u, v)$ and $G(t, u, v)$ are locally integrable and locally bounded by $t$ and continuous by $u$ and $v$ on $\left[t_{0},+\infty\right) \times \mathbb{R} \times \mathbb{R}$. If $(\phi(t), \psi(t))$ is a bounded solution of the system (1.1) on $\left[t_{0}, T\right)$ and $T<+\infty$, then $\left[t_{0}, T\right)$ cannot be the maximum existence interval for $(\phi(t), \psi(t))$.

Proof. To prove the lemma it is enough to show that $(\phi(t), \psi(t))$ has a finite limit when $t \rightarrow T-0$. By (1.1) we have

Hence by (2.14) $\left|\phi\left(t_{m}\right)-\phi\left(t_{n}\right)\right| \leq M\left|t_{m}-t_{n}\right|$, i. e. the sequence $\left\{\phi\left(t_{k}\right)\right\}_{k=1}^{+\infty}$ is fundamental, which
proves that $\phi(t)$ has a finite limit when $t \rightarrow T-0$. By analogy it can be proved the existence of the finite limit $\lim _{t \rightarrow T-0} \psi(t)$. The lemma is proved.

## 3. Global solvability, stability and oscillation criteria.

Definition 3.1. A solution $\left(\phi_{0}(t), \psi_{0}(t)\right)$ of the system (1.1) ((1.2)) is called Lyapunov (asymptotically) stable if for every $\varepsilon>0$ there exists $\delta>0$ such that for every solution $(\phi(t), \psi(t))$ of the system (1.1) ((1.2)) with $\left|\phi\left(t_{0}\right)-\phi_{0}\left(t_{0}\right)\right| \leq \delta,\left|\psi\left(t_{0}\right)-\psi_{0}\left(t_{0}\right)\right| \leq \delta$ the inequalities

Definition 3.2. A solution $\left(\phi_{0}(t), \psi_{0}(t)\right)$ of the system (1.1) ((1.2)) is called global asymptotically stable if for every its solution $(\phi(t), \psi(t))$ the functions $\phi(t)-\phi_{0}(t)$ and $\psi(t)-\psi_{0}(t)$ vanish at $+\infty$.

Let $P_{0}(t), Q_{0}(t), R_{0}(t), S_{0}(t), F_{0}(t)$ and $G_{0}(t)$ be real-valued locally integrable functions on $\left[t_{0},+\infty\right)$. Consider the linear system of ordinary differential equations

Assume $P(t, u, v), Q(t, u, v), R(t, u, v), S(t, u, v), F(t, u, v)$ and $G(t, u, v)$ are locally integrable and locally bounded by $t$ and continuous by $u$ and $v$ on $\left[t_{0},+\infty\right) \times \mathbb{R} \times \mathbb{R}$. Moreover assume $P(t, u, v) \leq P_{0}(t),|Q(t, u, v)| \leq Q_{0}(t)$, $|R(t, u, v)| \leq R_{0}(t), S(t, u, v) \leq S_{0}(t),|F(t, u, v)| \leq F_{0}(t),|G(t, u, v)| \leq G_{0}(t)$, $t \geq t_{0}, u, v \in \mathbb{R}$. Then the following statements are valid.
I) For every $\alpha, \beta \in \mathbb{R}$ the solution $\left(\phi(t), \psi(t)\right.$ ) of the system (1.1) with $\phi\left(t_{0}\right)=\alpha$, $\psi\left(t_{0}\right)=\beta$ exists on $\left.] t_{0},+\infty\right)$.
II) If a solution $\left(\phi_{0}(t), \psi_{0}(t)\right)$ of the system (3.1) with $\phi_{0}\left(t_{0}\right)>0, \psi_{0}\left(t_{0}\right)>0$ is bounden on $\left[t_{0},+\infty\right)$ (vanish at $\left.+\infty\right)$, then every solution $(\phi(t), \psi(t))$ of the system (1.1) with $\left|\phi\left(t_{0}\right)\right| \leq \phi_{0}\left(t_{0}\right), \quad\left|\psi\left(t_{0}\right)\right| \leq \psi_{0}\left(t_{0}\right)$ is also bounded on $\left[t_{0},+\infty\right)$ (vanish at $\left.+\infty\right)$.
III) If the system (3.2) is Lyapunov (asymptotically) stable then the null solution $(0,0)$ of the system (1.2) is Lyapunov (global asymptotically) stable.

Proof. Let us prove the statement I). Let $\left(\phi_{0}(t), \psi_{0}(t)\right)$ be a solution of the system (1.1) with $\phi_{0}\left(t_{0}\right)=\alpha, \psi_{0}\left(t_{0}\right)=\beta$. Suppose this solutions does not exist on $\left[t_{0},+\infty\right)$. Let then $\left[t_{0}, T\right)$ be the maximum existence interval for this solution. Remark 3.1. From the proof of Theorem 3.1 is seen that it remains valid if we generalize its conditions assuming that $P(t, u, v), Q(t, u, v), R(t, u, v), S(t, u, v), F(t, u, v)$ and $G(t, u, v)$ are complex-valued locally integrable and locally bounded by $t$ and continuous by $u$ and $v$ functions on $\left[t_{0},+\infty\right) \times(\mathbb{C}) \times(\mathbb{C})$ and replace $\alpha, \beta \in \mathbb{R}$ by $\alpha, \beta \in \mathbb{C}$ and the conditions $P(t, u, v) \leq P_{0}(t), S(t, u, v) \leq S_{0}(t)$ by $\operatorname{Re} P(t, u, v) \leq P_{0}(t)$, $\operatorname{Re} S(t, u, v) \leq S_{0}(t)$.

Example 3.1. Eq. (1.3) is equivalent to the system

In contrast to the conditions of Theorem 3.2, the conditions of Theorem 3.3 admit that the functions $Q$ and $R$ have singularities for $u=0$ and $v=0$, which, at part, is illustrated in the following example.

Whereas, in Example 3.2 has been established the existence of two-parameter families of global solutions of Eq. (3.27) for certain parameters $\rho, \sigma, n$.

Remark 3.3. The Wintner's theorem (see [9], pp. 29,30, Theorem 5.1) is not applicable neither to the van der Pol's nor to the Emden-Fowler's equations. Therefore on the basis of examples 3.1 and 3.2 we conclude that Theorem 3.1 and Theorem 3.2 are not consequences of the Wintner's theorem.

Theorem 3.5 as well as Corollary 3.2 are hypothetic (conditional) in the sense that the existence of solutions of the system (1.2) on appropriate intervals $[a, b]$ and $[a,+\infty)$ respectively is only assumed but not proved. In the regular case, when the "coefficients" $P, Q, R, S$ have no singularities, this conditionality is omitted by Theorem 3.1. The next theorem weakens the hypothetic character of Theorem 3.5 and Corollary 3.2 (to some extent) in the singular case (when the "coefficients" $P, Q, \quad R, S$ may have singularities).

\left.-\int_{t_{1}}^{t}\left(\exp \left\{-\int_{t_{1}}^{\tau} P(s, \phi(s), \psi(s)) d s\right\}\right)^{\prime} \frac{Q(\tau, \phi(\tau), \psi(\tau))}{P(\tau, \phi(\tau), \psi(\tau))} d \tau \exp \left\{\int_{t_{1}}^{t} P(\tau, \phi(\tau), \psi(\tau)) d \tau\right\} \right\rvert\, \leq \\
\leq M\left|\phi\left(t_{1}\right)\right| \exp \left\{\int_{t_{1}}^{t} P(\tau, \phi(\tau), \psi(\tau)) d \tau\right\}\left(\exp \left\{\int_{t_{1}}^{t}-P(\tau, \phi(\tau), \psi(\tau)) d \tau\right\}-1\right) \leq M\left|\phi\left(t_{1}\right)\right|, \\
|\psi(t)| \leq\left|\psi\left(t_{1}\right)\right|, \quad t \in\left[t_{1}, T\right) .
\end{gathered}
$$

Hence $(\phi(t), \psi(t))$ is bounded on $\left[t_{0}, T\right)$ provided $T<+\infty$. By similar way it can be shown the boundedness of $(\phi(t), \psi(t))$ on $\left[t_{0}, T\right)$ for $T<+\infty$ in the remaining subcases: $\begin{array}{ll}\phi\left(t_{1}\right)>0, & \psi\left(t_{1}\right)<0 ; \\ \phi\left(t_{1}\right)<0, & \psi\left(t_{1}\right)>0 ; \\ \phi\left(t_{1}\right)<0, & \psi\left(t_{1}\right)<0 .\end{array}$
Thus by Lemma 2.2 in the case $I^{0}$ ) for $T<+\infty$ the interval $\left[t_{0}, T\right)$ cannot be the maximum existence interval for $(\phi(t), \psi(t))$. In the case $I I^{0}$ ) using relations (2.1)and (2.2) on the basis of the conditions of the theorem we obtain

$$
\begin{aligned}
& |\phi(t)| \leq\left|\phi\left(t_{1}\right)\right|, \quad t \in\left[t_{1}, t_{2}\right) \\
& |\psi(t)| \leq \mid \exp \left\{\int_{t_{1}}^{t} S(\tau, \phi(\tau), \psi(\tau)) d \tau\right\} \times \\
& \left.\times \int_{t_{1}}^{t}\left(\exp \left\{-\int_{t_{1}}^{\tau} S(s, \phi(s), \psi(s)) d s\right\}\right)^{\prime} \frac{R(\tau, \phi(\tau), \psi(\tau))}{S(\tau, \phi(\tau), \psi(\tau))} \phi(\tau) d \tau \right\rvert\, \leq \frac{\left|\phi\left(t_{1}\right)\right|}{M}, \quad t \in\left[t_{1}, t_{2}\right) .
\end{aligned}
$$

Using these estimates by similar way we can obtain successively

$$
|\phi(t)| \leq\left|\phi\left(t_{1}\right)\right|, \quad|\psi(t)| \leq \frac{\left|\phi\left(t_{1}\right)\right|}{M}, \quad t \in\left[t_{k}, t_{k+1}\right), \quad k=2,3, \ldots .
$$

It follows from here that $(\phi(t), \psi(t))$ is bounded on $\left[t_{0}, T\right)$ provided $T<+\infty$. Therefore in the case $I I^{0}$ ) for $T+\infty$ the interval $\left[t_{0}, T\right)$ cannot be the maximum existence interval of $(\phi(t), \psi(t))$. If $\alpha=\beta=0$ then either $\phi(t)=\psi(t) \equiv 0$ form a solution of the system, or $\phi^{2}\left(t_{1}\right)+\psi^{2}\left(t_{1}\right) \neq 0$ for some $t_{1}>t_{0}$. In the last case by already proven $(\phi(t), \psi(t))$ exists on $\left[t_{1},+\infty\right)$. Hence $(\phi(t), \psi(t))$ exists on $\left[t_{0},+\infty\right)$. The theorem is proved.

Remark 3.5. Theorem 3.6 remains valid if we replace in its conditions the relations

$$
\frac{Q(t, u, v)}{P(t, u, v)} \leq M, \quad \frac{R(t, u, v)}{S(t, u, v)} \leq \frac{1}{M}
$$

by the following ones

$$
\frac{Q(t, u, v)}{S(t, u, v)} \leq M, \quad \frac{R(t, u, v)}{P(t, u, v)} \leq \frac{1}{M}
$$

This can be substantiated by using in the proof of Theorem 3.6 the relations (2.3) and (2.4) instead of (2.1) and (2.2) respectively.
