# A TRUNCATED MINIMAL FREE RESOLUTION OF THE RESIDUE FIELD

#### Abstract

In a paper in 1962, Golod proved that the Betti sequence of the residue field of a local ring attains an upper bound given by Serre if and only if the homology algebra of the Koszul complex of the ring has trivial multiplications and trivial Massey operations. This is the origin of the notion of Golod ring. Using the Koszul complex components he also constructed a minimal free resolution of the residue field. In this article, we extend this construction up to degree five for any local ring. We describe how the multiplicative structure and the triple Massey products of the homology of the Koszul algebra are involved in this construction. As a consequence, we provide explicit formulas for the first six terms of a sequence that measures how far the ring is from being Golod.


## 1. Introduction

Throughout the paper, $(R, \mathfrak{m}, \mathrm{k})$ is a local noetherian ring with maximal ideal $\mathfrak{m}$ and residue field k , of embedding dimension $n$ and codepth $c=n-\operatorname{depth} R$. Let $K^{R}$ be the Koszul complex of $R$ on a minimal set of generators of $\mathfrak{m}$. Serre pointed out that there is always a coefficient-wise inequality between the Poincaré series of the $R$-module k and a series of rational form involving the ranks of the homologies of $K^{R}$ :

\mathrm{P}_{\mathrm{k}}^{R}(t):=\sum_{i=0}^{\infty} \operatorname{rank}_{\mathrm{k}} \operatorname{Tor}_{i}^{R}(\mathrm{k}, \mathrm{k}) t^{i} \preccurlyeq \frac{(1+t)^{n}}{1-\sum_{i=1}^{c} \operatorname{rank}_{\mathrm{k}} \mathrm{H}_{i}\left(K^{R}\right) t^{i+1}} . \tag{1.0.1}
\end{equation*}

In [8, Golod proved that a ring $R$ attains this upper bound if and only if the graded-commutative algebra $\mathrm{H}\left(K^{R}\right)$ has trivial multiplications and trivial Massey operations; such a ring is now called a Golod ring. In the same paper, he also constructed the minimal free resolution of the $R$-module k in terms of $K^{R}$.

In [2, Corollary 5.10], Avramov proved that the Poincaré series $\mathrm{P}_{\mathrm{k}}^{R}(t)$ is completely determined by the structure of the Koszul homology algebra $A:=\mathrm{H}\left(K^{R}\right)$ as an algebra with Massey operations. One can now ask the following question:
Question 1.1. For any local ring ( $R, \mathfrak{m}, \mathrm{k}$ ), given the knowledge of its Koszul homology algebra $A$, with its products and Massey operations, how does one construct a minimal free resolution of the residue field k ?

In this paper, we answer this question explicitly up to degree five. For any local ring $R$, using the Koszul complex $K^{R}$ as building blocks and the graded-commutative structure of its homology $A$, we construct a minimal free resolution of the $R$-module k , up to degree five, see Construction 3.1 and Theorem 3.2

F: \quad F_{5} \xrightarrow{\partial_{5}^{F}} F_{4} \xrightarrow{\partial_{4}^{F}} F_{3} \xrightarrow{\partial_{3}^{F}} F_{2} \xrightarrow{\partial_{2}^{F}} F_{1} \xrightarrow{\partial_{1}^{F}} F_{0} \rightarrow \mathrm{k} \rightarrow 0 .
$$

The higher degrees of the resolution can be extended similarly for some special cases of $R$, but in general it requires an understanding of higher Massey products, which remains elusive and is left for future projects. Indeed, Massey operations can be represented by using the $A_{\infty}$-algebra structure, which the Koszul homology algebra $A$ possesses, see for example, 12 by Lu, Palmieri, Wu, and Zhang. Moreover, the $A_{\infty}$-structure was also used by Burke in [6] to construct certain projective resolutions. These connections suggest that perhaps the $A_{\infty}$-algebra structure of $A$ may play a role in giving a complete answer to Question 1.1 from this perspective.

To prepare for Construction 3.1 in Section 2 we analyze in detail the multiplicative structure of the algebra $A$, up to degree four, in terms of bases of $A_{i}$ and $A_{i} \cdot A_{j}$, and necessary maps. Moreover, in degree four the Massey products appear for the first time, as ternary Massey products $\left\langle A_{1}, A_{1}, A_{1}\right\rangle$; we give a description of the elements of this set in Proposition 2.11.

[^0]In Section 4 we obtain several direct applications of Theorem 3.2. In Corollary 4.1 we explicitly describe the Betti numbers $\beta_{i}:=\operatorname{rank}_{\mathrm{k}} \operatorname{Tor}_{i}^{R}(\mathrm{k}, \mathrm{k})$, up to degree five, in terms of the multiplicative invariants of the Koszul homology algebra $A$. Let $a_{i}:=\operatorname{rank}_{\mathrm{k}} A_{i}$ and consider the difference of series

\mathcal{P}(t):=\frac{(1+t)^{n}}{1-\sum_{i=1}^{c} a_{i} t^{i+1}}-\mathrm{P}_{\mathrm{k}}^{R}(t)
$$

that measures how far the ring $R$ is from being Golod, that is, how far the Betti numbers of $R$ are from their maximum possible values. In Proposition 4.2, we compute the first six coefficients of $\mathcal{P}(t)$ in terms of multiplicative invariants of $A$ :

\mathcal{P}_{0}=\mathcal{P}_{1}=\mathcal{P}_{2}=0, \quad \mathcal{P}_{3}=q_{11}, \quad \mathcal{P}_{4}=(n+1) q_{11}+q_{12}, \quad \mathcal{P}_{5}=\left(\binom{n+1}{2}+2 a_{1}\right) q_{11}+(n+1) q_{12}+a-b
$$

where $q_{i j}=\operatorname{rank}_{\mathrm{k}}\left(A_{i} \cdot A_{j}\right)$, and $a, b$ are described in Summary 2.13. For any local ring $R$ of embedding dimension $n$ with rational Poincaré series of the form $\mathrm{P}_{\mathrm{k}}^{R}(t)=(1+t)^{n} / d(t)$, we express the denominator, up to degree five, as follows:

$$
d(t)=\left(1-\sum_{i=1}^{c} a_{i} t^{i+1}\right)+q_{11} t^{3}+\left(q_{11}+q_{12}\right) t^{4}+\left(q_{12}-b+a\right) t^{5}+f(t) t^{6}
$$

for some $f(t) \in \mathbb{Z}[t]$, see Proposition 4.5. We consider a few classes of rings with such rational Poincaré series, see Corollary 4.10 and Examples 4.11 and 4.12 and using the coefficients of the denominator we obtain algebraic invariants of their Koszul homology algebra $A$. The Poincaré series $\mathrm{P}_{\mathrm{k}}^{R}(t)$ can be described by using the deviations $\varepsilon_{i}$ 's, see for example [4]. In Corollary 4.13] we give a description of the first five deviations in terms of the algebraic invariants of $A$.

In Section 5, we illustrate Construction 3.1 through an example of a ring of codepth 4 examined by Avramov in [2]. In that example, Avramov provided a nontrivial indecomposable Massey product element in $\left\langle A_{1}, A_{1}, A_{1}\right\rangle$ that does not come from multiplications of the homology. Using Proposition [2.11] we prove that, up to a scalar, this is the only element with this property, modulo the products in homology.

## 2. Multiplicative structure on the homology of the Koszul algebra

Let $(R, \mathfrak{m}, \mathrm{k})$ be a local ring of embedding dimension $n$ and codepth $c$. The differential graded algebra structure on the Koszul complex $K=K^{R}$ on a minimal set of generators of the maximal ideal $\mathfrak{m}$ induces a graded-commutative algebra structure on the homology of $K$ :

A:=\mathrm{H}(K)=A_{0} \oplus A_{1} \oplus A_{2} \oplus \cdots \oplus A_{c} .
$$

In this section we discuss this multiplicative structure up to degree four. We will use this structure extensively in constructing a truncated minimal free resolution of the residue field over $R$ in the next section.

The following notation is used throughout the paper: the differential map on $K$ is denoted by $\partial^{K}$, a homogeneous element of degree $i$ in the Koszul complex $K$ is denoted by $\pi^{i}$, a representative in $K_{i}$ of an element in the homology $A_{i}$ is denoted by $p^{i}$, and elements of $R$ are denoted by $\alpha$ 's, $\beta$ 's, and $\gamma$ 's. The subscript of a homogeneous element indicates its index in a tuple and the superscript indicates its homological degree. Set

a_{i}:=\operatorname{rank}_{\mathrm{k}}\left(A_{i}\right) \quad \text { and } \quad q_{i j}:=\operatorname{rank}_{\mathrm{k}}\left(A_{i} \cdot A_{j}\right), \text { for all } 0 \leq i, j \leq c \tag{2.0.1}
\end{equation*}
$$

It is clear that $A_{0}=\mathrm{k}$. For each $1 \leq i \leq a_{1}$ we consider $z_{i}^{1} \in \operatorname{Ker} \partial_{1}^{K}$ such that

\left\{\left[z_{i}^{1}\right]\right\}_{i=1, \ldots, a_{1}} \quad \text { is a basis of } A_{1} . \tag{2.0.2}
\end{equation*}

In particular, every element in $\operatorname{Ker} \partial_{1}^{K}$ can be written as a sum of elements in $\operatorname{Im} \partial_{2}^{K}$ and a linear combination of $\left\{z_{i}^{1}\right\}_{i=1, \ldots, a_{1}}$.
2.1. Products in degree two. Let $\overline{A_{2}}$ be a k-subspace of $A_{2}$ such that

A_{2}=\left(A_{1} \cdot A_{1}\right) \oplus \overline{A_{2}}
$$

For each $1 \leq \ell \leq a_{2}-q_{11}$, we consider $z_{\ell}^{2} \in \operatorname{Ker} \partial_{2}^{K}$ such that

\begin{equation*}
\left\{\left[z_{\ell}^{2}\right]\right\}_{\ell=1, \ldots, a_{2}-q_{11}} \quad \text { is a basis of } \overline{A_{2}} \tag{2.1.1}
\end{equation*}
$$

In particular, every element in $\operatorname{Ker} \partial_{2}^{K}$ can be written as a sum of elements in $\operatorname{Im} \partial_{3}^{K}$, a linear combination of $\left\{z_{i}^{1} \wedge z_{j}^{1}\right\}_{i, j=1, \ldots, a_{1}}$, and a linear combination of $\left\{z_{\ell}^{2}\right\}_{\ell=1, \ldots, a_{2}-q_{11}}$.

Consider the multiplication map:

\phi_{1}: A_{1} \otimes A_{1} \rightarrow A_{2}, \quad \text { defined by } \quad \phi_{1}([x] \otimes[y])=[x] \wedge[y] . \tag{2.1.2}
\end{equation*}
$$

As $\operatorname{Im} \phi_{1}=A_{1} \cdot A_{1}$, we have $\operatorname{rank}_{\mathrm{k}}\left(\operatorname{Ker} \phi_{1}\right)=a_{1}^{2}-q_{11}$. For all $1 \leq i \leq a_{1}$ and $1 \leq s \leq a_{1}^{2}-q_{11}$, we choose $\widetilde{p}_{s i}^{1} \in \operatorname{Ker} \partial_{1}^{K}$ such that

\left\{\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[\tilde{p}_{s i}^{1}\right]\right\}_{s=1, \ldots, a_{1}^{2}-q_{11}} \quad \text { is a basis of } \operatorname{Ker} \phi_{1} . \tag{2.1.3}
\end{equation*}
$$

For each $s$, we have $\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left[\widetilde{p}_{s i}^{1}\right]=0$, so there exists $\widetilde{\pi}_{s}^{3} \in K_{3}$ such that

\begin{equation*}
\partial_{3}^{K}\left(\widetilde{\pi}_{s}^{3}\right)=\sum_{i=1}^{a_{1}} z_{i}^{1} \wedge \widetilde{p}_{s i}^{1} . \tag{2.1.4}
\end{equation*}
$$

Lemma 2.2. Let $\widetilde{p}_{s i}^{1} \in \operatorname{Ker} \partial_{1}^{K}$ be as in (2.1.3). Then the vectors $\left\{\left(\left[\widetilde{p}_{s 1}^{1}\right], \ldots,\left[\widetilde{p}_{s a_{1}}^{1}\right]\right)\right\}_{s=1, \ldots, a_{1}^{2}-q_{11}}$ in $A_{1}^{a_{1}}$ are linearly independent.

Proof. If $\alpha_{s}$ is in $R$ such that $\sum_{s=1}^{a_{1}^{2}-q_{11}}\left(\left[\tilde{p}_{s 1}^{1}\right], \ldots,\left[\tilde{p}_{s a_{1}}^{1}\right]\right) \wedge\left[\alpha_{s}\right]=0$, then

$$
\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[\alpha_{s}\right]=0, \quad \text { for all } 1 \leq i \leq a_{1} .
$$

By tensoring with $\left[z_{i}^{1}\right]$ and taking the sum over $i$ we get

$$
\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes \sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[\alpha_{s}\right]=\sum_{s=1}^{a_{1}^{2}-q_{11}}\left(\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[\widetilde{p}_{s i}^{1}\right]\right) \wedge\left[\alpha_{s}\right]=0 .
$$

The desired conclusion now follows from (2.1.3).
Proposition 2.3. Let $\left\{\left[z_{i}^{1}\right]\right\}_{i=1, \ldots, a_{1}}$ and $\left\{\left[z_{\ell}^{2}\right]\right\}_{\ell=1, \ldots, a_{2}-q_{11}}$ be as in (2.0.2) and (2.1.1), respectively. If $\beta_{i j}$ and $\alpha_{\ell}$ are in $R$ such that

\sum_{i, j=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left[z_{j}^{1}\right] \wedge\left[\beta_{i j}\right]+\sum_{\ell=1}^{a_{2}-q_{11}}\left[z_{\ell}^{2}\right] \wedge\left[\alpha_{\ell}\right]=0
$$

then the following hold:
(a) $\left[\alpha_{\ell}\right]=0$ for all $1 \leq \ell \leq a_{2}-q_{11}$;
(b) There exist $\gamma_{s}$ in $R$ such that for all $1 \leq i \leq a_{1}$

\sum_{j=1}^{a_{1}}\left[z_{j}^{1}\right] \wedge\left[\beta_{i j}\right]=\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\tilde{p}_{s i}^{1}\right] \wedge\left[\gamma_{s}\right],
$$

where $\widetilde{p}_{s i}^{1}$ is as in (2.1.3).
Proof. (a): The first sum in the hypothesized equality is in $A_{1} \cdot A_{1}$. The elements $\left\{\left[z_{\ell}^{2}\right]\right\}_{\ell=1, \ldots, a_{2}-q_{11}}$ form a basis in $A_{2}$ that completes a basis of $A_{1} \cdot A_{1}$, thus $\left[\alpha_{\ell}\right]=0$ for all $1 \leq \ell \leq a_{2}-q_{11}$.
(b): By (a) it follows that $0=\sum_{i, j=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left[z_{j}^{1}\right] \wedge\left[\beta_{i j}\right]=\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left(\sum_{j=1}^{a_{1}}\left[z_{j}^{1}\right] \wedge\left[\beta_{i j}\right]\right)$, which implies that $\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left(\sum_{j=1}^{a_{1}}\left[z_{j}^{1}\right] \wedge\left[\beta_{i j}\right]\right)$ is in $\operatorname{Ker} \phi_{1}$. The desired conclusion now follows from (2.1.3).
2.4. Products in degree three. Let $\overline{A_{3}}$ be a $k$-subspace of $A_{3}$ such that

A_{3}=\left(A_{1} \cdot A_{2}\right) \oplus \overline{A_{3}}=\left(A_{1} \cdot A_{1} \cdot A_{1}+A_{1} \cdot \overline{A_{2}}\right) \oplus \overline{A_{3}} .
$$

For each $1 \leq t \leq a_{3}-q_{12}$, we consider $z_{t}^{3} \in \operatorname{Ker} \partial_{3}^{K}$ such that

\begin{equation*}
\left\{\left[z_{t}^{3}\right]\right\}_{t=1, \ldots, a_{3}-q_{12}} \quad \text { is basis of } \overline{A_{3}} . \tag{2.4.1}
\end{equation*}
$$

In particular, every element in $\operatorname{Ker} \partial_{3}^{K}$ can be written as a sum of elements in $\operatorname{Im} \partial_{4}^{K}$, a linear combination of $\left\{z_{i}^{1} \wedge z_{j}^{1} \wedge z_{k}^{1}\right\}_{i, j, k=1, \ldots, a_{1}}$, a linear combination of $\left\{z_{i}^{1} \wedge z_{\ell}^{2}\right\}_{\substack{i=1, \ldots, a_{1} \\ \ell=1, \ldots, a_{2}-q_{11}}}^{\substack{\text {, }}}$, and a linear combination of
$\left\{z_{t}^{3}\right\}_{t=1, \ldots, a_{3}-q_{12} .}$
Consider the map:

$$
\begin{equation*}
\psi: A_{1} \otimes A_{1} \otimes A_{1} \rightarrow\left(\left(A_{1} \cdot A_{1}\right) \otimes A_{1}\right) \oplus\left(A_{1} \otimes\left(A_{1} \cdot A_{1}\right)\right) \tag{2.4.2}
\end{equation*}
$$

defined by

$$
\psi([x] \otimes[y] \otimes[z])=([x] \wedge[y] \otimes[z],[x] \otimes[y] \wedge[z])
$$

for all $[x],[y],[z] \in A_{1}$ and set

$$
\begin{equation*}
b=\operatorname{rank}_{\mathrm{k}}(\operatorname{Coker} \psi) . \tag{2.4.3}
\end{equation*}
$$

Remark that $b=0$ if and only if $\psi$ is surjective. If $q_{11}=0$, then $A_{1} \cdot A_{1}=0$ and hence $b=0$.
Lemma 2.5. Let $a_{i}, q_{i j}$ be as in (2.0.1) and $b$ be as in (2.4.3). The sequence

A_{1} \otimes A_{1} \otimes A_{1} \xrightarrow{\bar{\psi}}\left(\left(A_{1} \cdot A_{1}\right) \otimes A_{1}\right) \oplus\left(A_{1} \otimes A_{2}\right) \xrightarrow{\mu} A_{3},
$$

where

\begin{aligned}
\bar{\psi}([x] \otimes[y] \otimes[z]) & =([x] \wedge[y] \otimes[z],[x] \otimes[y] \wedge[z]), \text { and } \\
\mu(([u] \otimes[x],[y] \otimes[v])) & =[u] \wedge[x]-[y] \wedge[v],
\end{aligned}
$$

for all $[x],[y],[z] \in A_{1},[u] \in\left(A_{1} \cdot A_{1}\right)$ and $[v] \in A_{2}$, is a complex whose homology has rank

a_{1} a_{2}-a_{1} q_{11}-q_{12}+b
$$

Proof. We first show that $\mu \circ \bar{\psi}=0$.

\mu(\bar{\psi}([x] \otimes[y] \otimes[z]))=\mu(([x] \wedge[y] \otimes[z],[x] \otimes[y] \wedge[z]))=[x] \wedge[y] \wedge[z]-[x] \wedge[y] \wedge[z]=0
$$

Hence, the sequence in the statement of the lemma is a complex. The homology of this complex has

\operatorname{rank}_{\mathrm{k}}\left(\frac{\operatorname{Ker} \mu}{\operatorname{Im} \bar{\psi}}\right) & =\operatorname{rank}_{\mathrm{k}}(\operatorname{Ker} \mu)-\operatorname{rank}_{\mathrm{k}}(\operatorname{Im} \bar{\psi}) \\
& =\operatorname{rank}_{\mathrm{k}}\left(\left(\left(A_{1} \cdot A_{1}\right) \otimes A_{1}\right) \oplus\left(A_{1} \otimes A_{2}\right)\right)-\operatorname{rank}_{\mathrm{k}}(\operatorname{Im} \mu)-\operatorname{rank}_{\mathrm{k}}(\operatorname{Im} \psi) \\
& =a_{1} q_{11}+a_{1} a_{2}-q_{12}-\operatorname{rank}_{\mathrm{k}}\left(\left(\left(A_{1} \cdot A_{1}\right) \otimes A_{1}\right) \oplus\left(A_{1} \otimes\left(A_{1} \cdot A_{1}\right)\right)\right)+b \\
& =a_{1} q_{11}+a_{1} a_{2}-q_{12}-2 a_{1} q_{11}+b \\
& =a_{1} a_{2}-a_{1} q_{11}-q_{12}+b
\end{aligned}
$$

To describe a basis of the homology of the complex in Lemma 2.5 it is enough to observe that $\operatorname{Im} \bar{\psi}$ is generated by elements of the form $\left(\left[z_{i}^{1}\right] \wedge\left[z_{j}^{1}\right] \otimes\left[z_{k}^{1}\right],\left[z_{i}^{1}\right] \otimes\left[z_{j}^{1}\right] \wedge\left[z_{k}^{1}\right]\right)$ for $1 \leq i, j, k \leq a_{1}$ and that in Ker $\mu / \operatorname{Im} \bar{\psi}$ we have $\left[\left(\left[z_{i}^{1}\right] \wedge\left[z_{j}^{1}\right] \otimes\left[z_{k}^{1}\right], 0\right)\right]=-\left[\left(0,\left[z_{i}^{1}\right] \otimes\left[z_{j}^{1}\right] \wedge\left[z_{k}^{1}\right]\right)\right]$, as $\left[\left(\left[z_{i}^{1}\right] \wedge\left[z_{j}^{1}\right] \otimes\left[z_{k}^{1}\right],\left[z_{i}^{1}\right] \otimes\left[z_{j}^{1}\right] \wedge\left[z_{k}^{1}\right]\right)\right]=0$. We choose $\widetilde{p}_{u i} \in \operatorname{Ker} \partial_{2}^{K}$ such that

is a basis of the homology of the complex defined in Lemma 2.5. By definition of $\mu$, for each $u$ we have $\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left[\widetilde{p}_{u i}^{2}\right]=0$ in $A_{3}$. Therefore, for each $u$ there exists $\widetilde{\pi}_{u}^{4} \in K_{4}$ such that

\partial_{4}^{K}\left(\widetilde{\pi}_{u}^{4}\right)=\sum_{i=1}^{a_{1}} z_{i}^{1} \wedge \widetilde{p}_{u i}^{2} \tag{2.5.2}
\end{equation*}

The following result gives a method for finding $\widetilde{p}_{u i}^{2}$ from (2.5.1).

Proposition 2.6. Consider the map $\phi_{2}: A_{1} \otimes A_{2} \rightarrow A_{3}$, defined by $\phi_{2}([x] \otimes[v])=[x] \wedge[v]$, and set

& \mathcal{A}=\left\{\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[z_{j}^{1}\right] \mid 1 \leq j \leq a_{1} \text { and } 1 \leq s \leq a_{1}^{2}-q_{11}\right\} \quad \text { and } \\
& \mathcal{B}=\left\{\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[\widetilde{p}_{u i}^{2}\right] \mid 1 \leq u \leq a_{1} a_{2}-a_{1} q_{11}-q_{12}+b\right\},
\end{aligned}
$$

where $\widetilde{p}_{s i}^{1}$ and $\widetilde{p}_{u i}^{2}$ are as in (2.1.3) and (2.5.1) respectively. Then, the following hold:
(a) The set $\mathcal{B}$ is linearly independent and

$$
\text { Ker } \phi_{2}=\left(\operatorname{Span}_{\mathrm{k}} \mathcal{A}\right) \oplus\left(\operatorname{Span}_{\mathrm{k}} \mathcal{B}\right)
$$

(b) $\operatorname{Span}_{\mathrm{k}} \mathcal{A} \subseteq A_{1} \otimes\left(A_{1} \cdot A_{1}\right)$ and for $b$ defined in (2.4.3),

$$
b=a_{1} q_{11}-\operatorname{rank}_{\mathrm{k}}\left(\operatorname{Span}_{\mathrm{k}} \mathcal{A}\right) .
$$

(c) If $B$ is a k -subspace of $\operatorname{Ker} \phi_{2}$ such that

$$
\operatorname{Ker} \phi_{2}=\left(\operatorname{Span}_{\mathrm{k}} \mathcal{A}\right) \oplus B
$$

then for every basis $\mathcal{B}^{\prime}$ of $B$ the set $\left[\left(0, \mathcal{B}^{\prime}\right)\right]$ is a basis of the homology of the complex in Lemma 2.5.
Proof. (a): The linear independence of $\mathcal{B}$ follows from (2.5.1). Next, we show that the elements of $\mathcal{A}$ and $\mathcal{B}$ generate the kernel of $\phi_{2}$. By definitions of $\widetilde{p}_{s i}^{1}$ and $\widetilde{p}_{u i}^{2}$, it is clear that the listed elements are in the kernel of $\phi_{2}$. Let $\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[p_{i}^{2}\right] \in \operatorname{Ker} \phi_{2}$, for some $\left[p_{i}^{2}\right] \in A_{2}$. Then $\left[\left(0, \sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[p_{i}^{2}\right]\right)\right] \in \operatorname{Ker} \mu$, and thus by definition (2.5.1) for all $u, i, j$ there exist $\delta_{u} \in R$ and $p_{i j}^{1} \in \operatorname{Ker} \partial_{1}^{K}$ such that

$$
\begin{equation*}
\left(0, \sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[p_{i}^{2}\right]\right)=\sum_{u=1}^{\substack{a_{1} a_{2}-a_{1} q_{11} \\-q_{12}+b}}\left(0, \sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[\widetilde{p}_{u i}^{2}\right] \wedge\left[\delta_{u}\right]\right)+\sum_{i, j=1}^{a_{1}}\left(\left[z_{i}^{1}\right] \wedge\left[p_{i j}^{1}\right] \otimes\left[z_{j}^{1}\right],\left[z_{i}^{1}\right] \otimes\left[p_{i j}^{1}\right] \wedge\left[z_{j}^{1}\right]\right) \tag{2.6.1}
\end{equation*}
$$

Comparing the first components of both sides of (2.6.1), for each $j$ we have:

$$
0=\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left[p_{i j}^{1}\right]
$$

By (2.1.3), there exist $\varepsilon_{j s}$ in $R$ such that for all $1 \leq i, j \leq a_{1}$ we can write:

$$
\left[p_{i j}^{1}\right]=\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[\varepsilon_{j s}\right]
$$

Comparing the second components of both sides of (2.6.1), and using the above expression for $\left[p_{i j}^{1}\right]$, for each $i$ we have:

$$
\left[p_{i}^{2}\right]=\sum_{u=1}^{\substack{a_{1} a_{2}-a_{1} q_{11} \\-q_{12}+b}}\left[\widetilde{p}_{u i}^{2}\right] \wedge\left[\delta_{u}\right]+\sum_{j=1}^{a_{1}}\left[p_{i j}^{1}\right] \wedge\left[z_{j}^{1}\right]=\sum_{u=1}^{\substack{a_{1} a_{2}-a_{1} q_{11} \\-q_{12}+b}}\left[\widetilde{p}_{u i}^{2}\right] \wedge\left[\delta_{u}\right]+\sum_{s=1}^{a_{1}^{2}-q_{11}} \sum_{j=1}^{a_{1}}\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[z_{j}^{1}\right] \wedge\left[\varepsilon_{j s}\right]
$$

Thus, $\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[p_{i}^{2}\right] \in \operatorname{Ker} \phi_{2}$ is a linear combination of elements of $\mathcal{A}$ and $\mathcal{B}$. Next, we show that $\operatorname{Span}_{\mathrm{k}} \mathcal{A} \cap \operatorname{Span}_{\mathrm{k}} \mathcal{B}=\{0\}$. By definition of $\widetilde{p}_{s i}^{1}$ we have $\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left[\widetilde{p}_{s i}^{1}\right]=0$ for all $1 \leq s \leq a_{1}^{2}-q_{11}$. By definition of $\bar{\psi}$, for all $s$ and $j$ we obtain

$$
\begin{equation*}
\bar{\psi}\left(\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[\widetilde{p}_{s i}^{1}\right] \otimes\left[z_{j}^{1}\right]\right)=\left(0, \sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[z_{j}^{1}\right]\right) \tag{2.6.2}
\end{equation*}
$$

hence $(0, \mathcal{A}) \subseteq \operatorname{Im} \bar{\psi}$. On the other hand by (2.5.1), $[(0, \mathcal{B})]$ is a basis of the homology of the complex in Lemma 2.5. Therefore, $\operatorname{Span}_{\mathrm{k}} \mathcal{A}$ and $\operatorname{Span}_{\mathrm{k}} \mathcal{B}$ have no nontrivial elements in common, and part (a) holds.
(b): The inclusion follows from the definition of $\mathcal{A}$. Observe that $\operatorname{rank}_{\mathrm{k}}\left(\operatorname{Ker} \phi_{2}\right)=a_{1} a_{2}-q_{12}$, and by the linear independence of $\mathcal{B}$ from part (a), $\operatorname{rank}_{\mathrm{k}}\left(\operatorname{Span}_{\mathrm{k}} \mathcal{B}\right)=a_{1} a_{2}-q_{12}-\left(a_{1} q_{11}-b\right)$. Therefore, by part (a), $\operatorname{rank}_{\mathrm{k}}\left(\operatorname{Span}_{\mathrm{k}} \mathcal{A}\right)=a_{1} q_{11}-b$.
(c): By parts (a) and (b), every basis $\mathcal{B}^{\prime}$ of $B$ has $a_{1} a_{2}-a_{1} q_{11}-q_{12}+b$ elements. It is clear that $\left(0, \mathcal{B}^{\prime}\right) \subseteq$ Ker $\mu$, with $\mu$ as in Lemma 2.5 and that the set $\left[\left(0, \mathcal{B}^{\prime}\right)\right]$ has at most $a_{1} a_{2}-a_{1} q_{11}-q_{12}+b$ elements. It is enough to show that it is a generating set for the homology of the complex in Lemma 2.5 to conclude that $\left[\left(0, \mathcal{B}^{\prime}\right)\right]$ has exactly $a_{1} a_{2}-a_{1} q_{11}-q_{12}+b$ elements, hence it forms a basis for the homology. Since $\mathcal{B} \subseteq \operatorname{Ker} \phi_{2}$, every element of $\mathcal{B}$ can be written as a linear combination of elements of $\mathcal{A}$ and $\mathcal{B}^{\prime}$. In particular, every basis element in $[(0, \mathcal{B})]$ can be written as a linear combination of elements in $[(0, \mathcal{A})]$ and $\left[\left(0, \mathcal{B}^{\prime}\right)\right]$. However, each element in $[(0, \mathcal{A})]$ is zero in the homology, as remarked in (2.6.2), thus $\left[\left(0, \mathcal{B}^{\prime}\right)\right]$ is a generating set. Part (c) now holds.

Remark 2.7. In practice, one can apply Proposition 2.6(b) to compute the value $b$, instead of using definition (2.4.3). Similarly, instead of using definition (2.5.1) for $\tilde{p}_{u i}^{2}$, by Proposition 2.6(c), one can find first $\widetilde{p}_{s i}^{1}$ as defined in (2.1.3), and then find a basis of a space complementary to

$$
\operatorname{Span}_{\mathrm{k}} \mathcal{A}=\operatorname{Span}_{\mathrm{k}}\left\{\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[z_{j}^{1}\right]\right\}_{1 \leq j \leq a_{1}, 1 \leq s \leq a_{1}^{2}-q_{11}}
$$

in the kernel of the multiplication map $\phi_{2}$, of the form

$$
\left\{\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left[\widehat{p}_{u i}^{2}\right]\right\}_{1 \leq u \leq a_{1} a_{2}-a_{1} q_{11}-q_{12}+b}
$$

Proposition 2.8. Let $\left\{\left[z_{i}^{1}\right]\right\}_{i=1, \ldots, a_{1}},\left\{\left[z_{\ell}^{2}\right]\right\}_{\ell=1, \ldots, a_{2}-q_{11}}$, and $\left\{\left[z_{t}^{3}\right]\right\}_{t=1, \ldots, a_{3}-q_{12}}$ be as in (2.0.2), (2.1.1), and (2.4.1), respectively. If $\gamma_{i j k}, \beta_{i \ell}$, and $\alpha_{t}$ are in $R$ such that

$$
\sum_{i, j, k=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left[z_{j}^{1}\right] \wedge\left[z_{k}^{1}\right] \wedge\left[\gamma_{i j k}\right]+\sum_{i=1}^{a_{1}} \sum_{\ell=1}^{a_{2}-q_{11}}\left[z_{i}^{1}\right] \wedge\left[z_{\ell}^{2}\right] \wedge\left[\beta_{i \ell}\right]+\sum_{t=1}^{a_{3}-q_{12}}\left[z_{t}^{3}\right] \wedge\left[\alpha_{t}\right]=0
$$

then the following hold:
(a) $\left[\alpha_{t}\right]=0$ for all $1 \leq t \leq a_{3}-q_{12}$;
(b) There exist $\delta_{u}$ and $\varepsilon_{j s}$ in $R$ such that

$$
\sum_{j, k=1}^{a_{1}}\left[z_{j}^{1}\right] \wedge\left[z_{k}^{1}\right] \wedge\left[\gamma_{i j k}\right]+\sum_{\ell=1}^{a_{2}-q_{11}}\left[z_{\ell}^{2}\right] \wedge\left[\beta_{i \ell}\right]=\sum_{j=1}^{a_{1}} \sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[z_{j}^{1}\right] \wedge\left[\varepsilon_{j s}\right]+\sum_{u=1}^{\substack{a_{1} a_{2}-a_{1} q_{11} \\-q_{12}+b}}\left[\widetilde{p}_{u i}^{2}\right] \wedge\left[\delta_{u}\right]
$$

where $\widetilde{p}_{s i}^{1}$ and $\widetilde{p}_{u i}^{2}$ are as in (2.1.3) and (2.5.1) respectively.
Proof. (a): The first two sums in the hypothesized equality are in $A_{1} \cdot A_{2}$. As $\left\{\left[z_{t}^{3}\right]\right\}_{t=1, \ldots, a_{3}-q_{12}}$ is a basis in $A_{3}$ that completes a basis of $A_{1} \cdot A_{2}$, this implies $\left[\alpha_{t}\right]=0$ for all $1 \leq t \leq a_{3}-q_{12}$.
(b): By (a) it follows that

$$
\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left(\sum_{j, k=1}^{a_{1}}\left[z_{j}^{1}\right] \wedge\left[z_{k}^{1}\right] \wedge\left[\gamma_{i j k}\right]+\sum_{\ell=1}^{a_{2}-q_{11}}\left[z_{\ell}^{2}\right] \wedge\left[\beta_{i \ell}\right]\right)=0
$$

hence $\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes\left(\sum_{j, k=1}^{a_{1}}\left[z_{j}^{1}\right] \wedge\left[z_{k}^{1}\right] \wedge\left[\gamma_{i j k}\right]+\sum_{\ell=1}^{a_{2}-q_{11}}\left[z_{\ell}^{2}\right] \wedge\left[\beta_{i \ell}\right]\right)$ is in Ker $\phi_{2}$. The desired assertion now follows from Proposition 2.6(a).
2.9. Massey products in degree four. Massey products occur in degrees four and higher. In degree four, one may obtain only triple Massey products of elements of degree one. The Massey product of a triplet $[x],[y],[z] \in A_{1}$ satisfying

$$
[x] \wedge[y]=0 \quad \text { and } \quad[y] \wedge[z]=0
$$

is a subset of $A_{4}$, defined as follows:

$$
\langle[x],[y],[z]\rangle=\left\{\left[\pi_{x y}^{3} \wedge z+x \wedge \pi_{y z}^{3}\right] \mid \partial_{3}^{K}\left(\pi_{x y}^{3}\right)=x \wedge y \text { and } \partial_{3}^{K}\left(\pi_{y z}^{3}\right)=y \wedge z\right\}
$$

for some $\pi_{x y}^{3}, \pi_{y z}^{3} \in K_{3}$.

Remark 2.10. Let $[x],[y],[z] \in A_{1}$ with $[x] \wedge[y]=0$ and $[y] \wedge[z]=0$. Choose $\pi_{x y}^{3}$ and $\pi_{y z}^{3}$ in $K_{3}$ such that $\partial_{3}^{K}\left(\pi_{x y}^{3}\right)=x \wedge y$ and $\partial_{3}^{K}\left(\pi_{y z}^{3}\right)=y \wedge z$. Then, every element of $\langle[x],[y],[z]\rangle$ is of the form

$$
\left[\left(\pi_{x y}^{3}+p_{x y}^{3}\right) \wedge z+x \wedge\left(\pi_{y z}^{3}+p_{y z}^{3}\right)\right]=\left[\pi_{x y}^{3} \wedge z+x \wedge \pi_{y z}^{3}\right]+\left[p_{x y}^{3}\right] \wedge[z]+[x] \wedge\left[p_{y z}^{3}\right]
$$

for some $p_{x y}^{3}$ and $p_{y z}^{3} \in \operatorname{Ker} \partial_{3}^{K}$. Therefore,

$$
\langle[x],[y],[z]\rangle=\left[\pi_{x y}^{3} \wedge z+x \wedge \pi_{y z}^{3}\right]+\left(A_{3} \cdot[z]\right)+\left([x] \cdot A_{3}\right)
$$

The element $\pi_{x y}^{3} \wedge z+x \wedge \pi_{y z}^{3}$ is called a representative of the triple Massey product $\langle[x],[y],[z]\rangle$. Here, $\left(A_{3} \cdot[z]+[x] \cdot A_{3}\right)$ is called the indeterminacy of the Massey operation, see e.g., May [14] and [2, Section 7].

Let $\left\langle A_{1}, A_{1}, A_{1}\right\rangle$ denote the set of elements in $A_{4}$ which are Massey products of triplets in $A_{1}$. The next result describes the elements of this set.

Proposition 2.11. Each element in $\left\langle A_{1}, A_{1}, A_{1}\right\rangle \subseteq A_{4}$ has a representative

$$
\sum_{s=1}^{a_{1}^{2}-q_{11}} \widetilde{\pi}_{s}^{3} \wedge p_{s}^{1} \quad \text { such that } \sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1} \wedge p_{s}^{1}\right]=0, \text { for all } i=1 \ldots, a_{1}
$$

where $p_{s}^{1} \in \operatorname{Ker} \partial_{1}^{K}$, and $\widetilde{p}_{s i}^{1}$ and $\widetilde{\pi}_{s}^{3}$ are defined in (2.1.3) and (2.1.4) respectively.
Proof. Let $[x],[y],[z] \in A_{1}$ such that $[x] \wedge[y]=0$ and $[y] \wedge[z]=0$. We write $[y]=\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge\left[\alpha_{i}\right]$ for some $\alpha_{i} \in R$. Since $[x] \wedge[y]=\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \wedge[x] \wedge\left[-\alpha_{i}\right]=0$, we have $\sum_{i=1}^{a_{1}}\left[z_{i}^{1}\right] \otimes[x] \wedge\left[-\alpha_{i}\right] \in \operatorname{Ker} \phi_{1}$. Hence, by (2.1.3) there exist $\beta_{s} \in R$ such that $[x] \wedge\left[-\alpha_{i}\right]=\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[\beta_{s}\right]$ for all $i$, so

$$
[x] \wedge[y]=\sum_{s=1}^{a_{1}^{2}-q_{11}}\left(\sum_{i=1}^{a_{1}}\left[z_{i}^{1} \wedge \tilde{p}_{s i}\right]\right) \wedge\left[\beta_{s}\right]=\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\partial_{3}^{K}\left(\widetilde{\pi}_{s}^{3}\right)\right] \wedge\left[\beta_{s}\right]=\left[\partial_{3}^{K}\left(\sum_{s=1}^{a_{1}^{2}-q_{11}} \widetilde{\pi}_{s}^{3} \wedge \beta_{s}\right)\right]
$$

Therefore, we may choose $\pi_{x y}^{3}=\sum_{s=1}^{a_{1}^{2}-q_{11}} \widetilde{\pi}_{s}^{3} \wedge \beta_{s}$. Similarly, using the equality $[y] \wedge[z]=0$, we may choose $\pi_{y z}^{3}=\sum_{s=1}^{a_{1}^{2}-q_{11}} \widetilde{\pi}_{s}^{3} \wedge \gamma_{s}$, for some $\gamma_{s} \in R$, where $[z] \wedge\left[\alpha_{i}\right]=\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[\gamma_{s}\right]$ for all $i$.

It follows that any element in $\left\langle A_{1}, A_{1}, A_{1}\right\rangle$ has a representative

$$
\pi_{x y}^{3} \wedge z+x \wedge \pi_{y z}^{3}=\sum_{s=1}^{a_{1}^{2}-q_{11}} \widetilde{\pi}_{s}^{3} \wedge\left(z \wedge \beta_{s}-x \wedge \gamma_{s}\right)
$$

If we set $p_{s}^{1}=z \wedge \beta_{s}-x \wedge \gamma_{s}$, then for each $1 \leq i \leq a_{1}$ we have

$$
\begin{aligned}
\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1} \wedge p_{s}^{1}\right] & =\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1}\right] \wedge\left[z \wedge \beta_{s}-x \wedge \gamma_{s}\right]=\left(\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1} \wedge \beta_{s}\right]\right) \wedge[z]+[x] \wedge\left(\sum_{s=1}^{a_{1}^{2}-q_{11}}\left[\widetilde{p}_{s i}^{1} \wedge \gamma_{s}\right]\right) \\
& =-[x] \wedge[z] \wedge\left[\alpha_{i}\right]+[x] \wedge[z] \wedge\left[\alpha_{i}\right]=0
\end{aligned}
$$

2.12. Products in degree four. Let $\overline{A_{4}}$ be a k -subspace of $A_{4}$ such that

$$
A_{4}=\left(A_{1} \cdot A_{3}+A_{2} \cdot A_{2}+\operatorname{Span}_{\mathrm{k}}\left\langle A_{1}, A_{1}, A_{1}\right\rangle\right) \oplus \overline{A_{4}}
$$

and set

$$
\begin{equation*}
a=\operatorname{rank}_{\mathrm{k}}\left(A_{1} \cdot A_{3}+A_{2} \cdot A_{2}+\operatorname{Span}_{\mathrm{k}}\left\langle A_{1}, A_{1}, A_{1}\right\rangle\right) . \tag{2.12.1}
\end{equation*}
$$

For some choice of $z_{r}^{4} \in \operatorname{Ker} \partial_{4}^{K}$, let

$$
\begin{equation*}
\left\{\left[z_{r}^{4}\right]\right\}_{r=1, \ldots, a_{4}-a} \quad \text { be a basis of } \overline{A_{4}} \tag{2.12.2}
\end{equation*}
$$

In particular, every element in $\operatorname{Ker} \partial_{4}^{K}$ can be written as a sum of elements in $\operatorname{Im} \partial_{5}^{K}$, a linear combination of $\left\{z_{i}^{1} \wedge p_{i}^{3}\right\}_{i=1, \ldots, a_{1}}$, a linear combination of $\left\{z_{\ell}^{2} \wedge p_{\ell}^{2}\right\}_{\ell=1, \ldots, a_{2}-q_{11}}$, a linear combination of $\left\{\widetilde{\pi}_{s}^{3} \wedge p_{s}^{1}\right\}_{s=1, \ldots, a_{1}^{2}-q_{11}}$, and a linear combination of $\left\{z_{r}^{4}\right\}_{r=1, \ldots, a_{4}-a}$, where $p_{i}^{3} \in \operatorname{Ker} \partial_{3}^{K}, p_{\ell}^{2} \in \operatorname{Ker} \partial_{2}^{K}$ and $p_{s}^{1} \in \operatorname{Ker} \partial_{1}^{K}$, such that $p_{s}^{1}$ is as in Proposition 2.11 and $\widetilde{\pi}_{s}^{3}$ as in (2.1.4).

Summary 2.13. We summarize here all notations, introduced in this section, to be referred to throughout the rest of the paper:

Lemma 2.14. All the elements $z_{i}^{1}, z_{\ell}^{2}, z_{t}^{3}, z_{r}^{4}, \widetilde{p}_{s i}^{1}, \widetilde{\pi}_{s}^{3}, \widetilde{p}_{u i}^{2}$, and $\widetilde{\pi}_{u}^{4}$, as in Summary 2.13, are in $\mathfrak{m} K$.

## 3. Truncated minimal free resolution of the residue field

In this section, we construct the beginning of the minimal free resolution of the residue field $k$ over the local ring $(R, \mathfrak{m}, \mathrm{k})$, by using the Koszul complex $K$ of $R$ and the graded-commutative structure of the algebra $A=\mathrm{H}(K)$ described in Section 2 ,
Construction 3.1. We consider the following sequence of free $R$-modules:

Theorem 3.2. Let $(R, \mathfrak{m}, \mathfrak{k})$ be a local ring. The sequence $F$ constructed in 3.1 is a truncated minimal free resolution of k over $R$, up to homological degree five.

Remark 3.3. If all multiplications on the algebra $A$ are trivial, that is, $q_{i j}=0$ for all $i, j \geq 1$, and all Massey operations are zero, Golod's construction in [8] gives a minimal free resolution of the residue field k of a local ring $R$ in terms of the Koszul complex $K$ of $R$. Without these assumptions, our complex $F$ in Construction 3.1 generalizes Golod's resolution up to degree five.

## 4. Applications of the Construction

For a local ring $R$ of embedding dimension $n$ and codepth $c$, set $\beta_{i}:=\operatorname{rank}_{\mathrm{k}} \operatorname{Tor}_{i}^{R}(\mathrm{k}, \mathrm{k})$ for $i \geq 0$ for the Betti numbers of k over $R$. Let $\sum_{i=0}^{\infty} b_{i} t^{i}$ denote the series on the right hand side of the inequality (1.0.1). The sequence $\mathcal{P}:=\left\{\mathcal{P}_{i}\right\}_{i \geq 0}$ defined by:

\mathcal{P}_{i}:=b_{i}-\beta_{i}, \quad \text { for all } i \geq 0 \tag{4.0.1}
\end{equation*}
$$

gives the coefficients of the series $\mathcal{P}(t)$ defined in the Introduction. The ring $R$ is Golod if and only if $\mathcal{P}_{i}=0$ for all $i \geq 0$. Our goal in this section is to give a description of the sequence $\left\{\mathcal{P}_{i}\right\}_{0 \leq i \leq 5}$ in terms of the invariants of the multiplicative structure of the algebra $A=\mathrm{H}\left(K^{R}\right)$ and discuss various consequences of Theorem 3.2, First, using Theorem 3.2, we explicitly describe the Betti numbers $\beta_{i}$ in terms of those invariants, up to degree five.

Corollary 4.1. Let $R$ be a local ring of embedding dimension $n$. Let $a_{i}, q_{i j}$, a and $b$ be as in Summary 2.13 , Then the following equalities hold:

\beta_{3}=\binom{n}{3}+n a_{1}+a_{2}-q_{11}, \quad \beta_{4}=\binom{n}{4}+\binom{n}{2} a_{1}+n a_{2}+a_{3}+a_{1}^{2}-(n+1) q_{11}-q_{12} \\
\beta_{5}=\binom{n}{5}+\binom{n}{3} a_{1}+\binom{n}{2} a_{2}+n a_{3}+a_{4}+n a_{1}^{2}+2 a_{1} a_{2}-\left(\binom{n+1}{2}+2 a_{1}\right) q_{11}-(n+1) q_{12}+b-a .
\end{gathered}
$$

Proof. This is a direct consequence of Theorem 3.2. The formulas for $\beta_{0}, \ldots, \beta_{3}$ are clear, and we simplify the following expressions for $\beta_{4}$ and $\beta_{5}$ to obtain the ones in the statement:

Proposition 4.2. Let $R$ be a local ring of embedding dimension $n$ and codepth $c$. Let $a_{i}, q_{i j}$, $a$, and $b$ be as in Summary 2.13. The sequence $\mathcal{P}$ from (4.0.1) satisfies the following equalities:

\mathcal{P}_{0}=\mathcal{P}_{1}=\mathcal{P}_{2}=0, \quad \mathcal{P}_{3}=q_{11}, \quad \mathcal{P}_{4}=(n+1) q_{11}+q_{12}, \quad \text { and }
$$

\mathcal{P}_{5}=\left(\binom{n+1}{2}+2 a_{1}\right) q_{11}+(n+1) q_{12}+a-b
$$

Proof. Recall that the right hand side of the inequality (1.0.1) is $\sum_{i=1}^{\infty} b_{i} t^{i}=\frac{(1+t)^{n}}{1-\sum_{i=1}^{c} a_{i} t^{i+1}}$. Comparing the coefficients on both sides of (1.0.1) we have the following recursive formulas for $b_{i}$ :

In particular, we obtain:

Now, the expression for $\mathcal{P}_{i}=b_{i}-\beta_{i}$ for $0 \leq i \leq 5$ follows from Corollary 4.1.
Alternatively, assume $q_{i j}=0$ for all $1 \leq i+j \leq 4$, and Massey products are also trivial, we have $a=b=0$. In Construction [3.1] we obtain the maximum possible values of the Betti numbers, so the differences between the actual Betti numbers and these maximum values are exactly the $\mathcal{P}_{i}$ 's in the proposition.

Corollary 4.3. Let $R$ be a local ring, $a_{i}, q_{i j}$, $a$, and $b$ be as in Summary 2.13 and $\mathcal{P}$ as in (4.0.1).
(a) If $q_{11}=q_{12}=0$, then $\mathcal{P}_{i}=0$ for all $0 \leq i \leq 4$ and $\mathcal{P}_{5}=a$.
(b) If $q_{11}=q_{12}=q_{13}=q_{22}=0$, then $\mathcal{P}_{5}=\operatorname{rank}_{\mathrm{k}}\left(\operatorname{Span}_{\mathrm{k}}\left\langle A_{1}, A_{1}, A_{1}\right\rangle\right)$.
(c) If codepth $R=4$, then $R$ is Golod if and only if $\mathcal{P}_{i}=0$ for all $1 \leq i \leq 5$.

Proof. (a) and (b) are straightforward from Proposition 4.2, For (c), result in [8] showed that $R$ is Golod if and only if all products on $A$ and all ternary Massey products are trivial. If codepth $R=4$, then the $r$-ary Massey products are trivial for all $r \geq 4$. Thus, part (c) follows from Proposition 4.2

Remark 4.4. A result of Burke [6, Corollary 6.10] implies that for a local ring $R$ of codepth $c$ the following implication holds:

\text { If } \mathcal{P}_{i}=0 \text { for all } 0 \leq i \leq c+1, \text { then } \mathcal{P}_{i}=0 \text { for all } i \geq 0
$$

Thus, Corollary 4.3(c) is a consequence of this result as well.
We now examine some local rings with rational Poincaré series of certain forms and describe $\mathrm{P}_{\mathrm{k}}^{R}(t)$ in terms of the algebraic invariants of $A$.

Proposition 4.5. Let $(R, \mathfrak{m}, \mathrm{k})$ be a local ring of embedding dimension $n$ and codepth $c$. Let $a_{i}, q_{i j}, a$, and $b$ be as in Summary 2.13. If the Poincaré series of $R$ is rational of the form $\mathrm{P}_{\mathrm{k}}^{R}(t)=(1+t)^{n} / d(t)$, then

d(t)=\left(1-\sum_{i=1}^{c} a_{i} t^{i+1}\right)+q_{11} t^{3}+\left(q_{11}+q_{12}\right) t^{4}+\left(q_{12}-b+a\right) t^{5}+f(t) t^{6}

for some $f(t) \in \mathbb{Z}[t]$.
Proof. Let $\mathcal{P}_{i}$ be as in (4.0.1). Set

\frac{\gamma(t)}{\alpha(t)+\gamma(t)}=\frac{\mathcal{P}(t) \cdot \alpha(t)}{(1+t)^{n}} \Longleftrightarrow \frac{\gamma(t)}{\alpha(t)}=\frac{\mathcal{P}(t) \cdot \alpha(t)}{(1+t)^{n}-\mathcal{P}(t) \cdot \alpha(t)} \Longleftrightarrow \gamma(t)=\frac{\mathcal{P}(t) \cdot(\alpha(t))^{2}}{(1+t)^{n}-\mathcal{P}(t) \cdot \alpha(t)} .

We compare the coefficients of $t^{i}$ for all $0 \leq i \leq 5$ on both sides of the following equality

It is clear that $\gamma_{0}=\gamma_{1}=\gamma_{2}=0$ and comparing the coefficients of $t^{3}$ we get: $\gamma_{3}=\mathcal{P}_{3}=q_{11}$. Comparing the coefficients of $t^{4}$ and by Proposition 4.2 we get:

Therefore, the expression for $d(t)=\alpha(t)+\gamma(t)$ in the statement holds.
There are many classes of local rings for which the Poincaré series is rational of the form $\mathrm{P}_{\mathrm{k}}^{R}(t)=$ $(1+t)^{n} / d(t)$. In light of Proposition 4.5, we write the coefficients of the polynomial $d(t)$ in terms of the invariants $a_{i}, q_{i j}, b$ and $a$ for some special cases and provide a uniform expression of the Poincaré series in these cases.

Corollary 4.6. If $(R, \mathfrak{m}, \mathrm{k})$ is a local ring of embedding dimension $n$ and codepth at most 3 , and $a_{i}, q_{i j}, b$ are as in Summary 2.13, then

$$
\mathrm{P}_{\mathrm{k}}^{R}(t)=\frac{(1+t)^{n-1}}{1-t-\left(a_{1}-1\right) t^{2}-\left(a_{3}-q_{11}\right) t^{3}+q_{12} t^{4}-b t^{5}}
$$

Proof. By [3, Theorem 3.5] the Poincaré series of the ring $R$ is rational given by $\mathrm{P}_{\mathrm{k}}^{R}(t)=(1+t)^{n} / d(t)$ with $\operatorname{deg} d(t) \leq 6$ and $d(-1)=0$. Since codepth $R \leq 3$ we have $a_{4}=0$ and $a=0$. Thus, Proposition 4.5 gives:

$$
P_{\mathrm{k}}^{R}(t)=\frac{(1+t)^{n}}{1-a_{1} t^{2}-\left(a_{2}-q_{11}\right) t^{3}-\left(a_{3}-q_{11}-q_{12}\right) t^{4}-\left(b-q_{12}\right) t^{5}-b t^{6}} .
$$

Simplifying the fraction by the common factor $(1+t)$, we get the desired conclusion.
Remark 4.7. In [5, Lemma 3.6] Avramov defined the invariant $\tau$ for non-Gorenstein ring $R$ of codepth 3 as follows: $\tau=1$ if $R$ is of class $\mathbf{T}$, and $\tau=0$ otherwise. By comparing [5], (3.6.2)] and the Poincaré expression in Corollary 4.6 we see that $\tau$ is our $b=\operatorname{rank}_{\mathrm{k}}(\operatorname{Coker} \psi)$ in (2.4.3), which is a multiplicative invariant of the homology algebra $A$. It follows from [3, Theorem 3.5] that $b=1$ for a ring of class $\mathbf{C}(3)$ or $\mathbf{T}$, and $b=0$ for rings of class $\mathbf{C}(1), \mathbf{C}(2), \mathbf{S}, \mathbf{B}, \mathbf{G}(r)$, and $\mathbf{H}\left(q_{11}, q_{12}\right)$.

Corollary 4.8. If $(R, \mathfrak{m}, \mathfrak{k})$ is a Gorenstein local ring, not a complete intersection, of embedding dimension $n$ and codepth 4, and and $a_{i}, q_{i j}, a, b$ are as in Summary 2.13, then

$$
\mathrm{P}_{\mathrm{k}}^{R}(t)=\frac{(1+t)^{n-2}}{1-2 t-\left(a_{1}-3\right) t^{2}+\left(q_{11}-2\right) t^{3}+\left(-q_{11}+q_{12}-1\right) t^{4}-\left(q_{11}-q_{12}-b+a-1\right) t^{5}}
$$

Proof. Since $R$ is Gorenstein we have $a_{2}=2 a_{1}-2, a_{3}=a_{1}$, and $a_{4}=1$. The statement follows from (3) Theorem 3.5] and Proposition 4.5.

Remark 4.9. Using the Avramov's notation from [3] for the classification of Gorenstein local rings $R$ of codepth 4 given by Kustin and Miller [11] and comparing the Poincaré expressions from [3, Theorem 3.5] and Corollary 4.8, we obtain the following table of algebra invariants of a Gorenstein local ring $R$ :

| Class | $q_{11}$ | $q_{12}$ | $q_{22}$ | $q_{13}$ | $a$ | $b$ |
| ---: | :---: | :---: | :---: | :---: | :---: | :---: |
| $\mathbf{C}(4)$ | 6 | 4 | 1 | 1 | 1 | 4 |
| $\mathbf{G T}$ | 3 | 3 | 1 | 1 | 1 | 1 |
| $\mathbf{G S}$ | 0 | 0 | 1 | 1 | 1 | 0 |
| $\mathbf{G H}(p)$ | $p$ | $p+1$ | 1 | 1 | 1 | 0 |

We provide more examples of rings for which we can calculate the multiplicative invariants $q_{i j}, a, b$ from the Poincaré series of the ring.
Corollary 4.10. Let k be a field, $I$ be an ideal of $\mathrm{k}[x, y, z, w]$ such that $(x, y, z, w)^{3} \subseteq I \subseteq(x, y, z, w)^{2}$, and set $R=\mathrm{k}[x, y, z, w] / I$. Let $a_{i}, q_{i j}, a, b$ be as in Summary 2.13. If $R$ has $a_{4}=3$ and its Poincaré series is of the form $\mathrm{P}_{\mathrm{k}}^{R}(t)=\frac{1}{(1-t)(1-3 t)}$, then

$$
q_{11}=a_{2}-8, \quad q_{12}=8, \quad a=3, \quad \text { and } \quad b=0
$$

Proof. By hypothesis,

$$
\mathrm{P}_{\mathrm{k}}^{R}(t)=\frac{(1+t)^{4}}{(1-t)(1-3 t)(1+t)^{4}}=\frac{(1+t)^{4}}{1-7 t^{2}-8 t^{3}+3 t^{4}+8 t^{5}+3 t^{6}}
$$

Proposition 4.5 thus gives:

$$
\begin{equation*}
a_{1}=7, \quad a_{2}-q_{11}=8, \quad a_{3}-q_{11}-q_{12}=-3, \quad \text { and } \quad a_{4}-q_{12}+b-a=-8 . \tag{4.10.1}
\end{equation*}
$$

From the second equality we obtain $q_{11}=a_{2}-8$ and from the third we get $q_{12}=a_{3}-a_{2}+11$. Since $a_{4}=3$ and $a_{1}=7$, we get $a_{2}=a_{3}+3$ and thus $q_{12}=8$. The last equality in 4.10.1) becomes $a-b=3$. By the definitions of $a$ and $b$ we have $0 \leq a \leq a_{4}=3$ and $b \geq 0$, thus $a=3$ and $b=0$.

Examples 4.11. Rings satisfying the hypotheses of Corollary 4.10 are discussed by Yoshino in 17 and Christensen and Veliche in [7]. For examples, consider the following ideals in $Q=\mathbb{Q}[x, y, z, w]$ :

$$
\begin{aligned}
& I_{1}=\left(y w, x w+z w+w^{2}, z^{2}+w^{2}, x z+z w+w^{2}, y^{2}+y z, x y+z w, x^{2}+z w\right), \\
& I_{2}=\left(z w+w^{2}, y w, z^{2}+w^{2}, y z+x w+w^{2}, x z+w^{2}, x y+y^{2}+x w+w^{2}, x^{2}+x w+w^{2}\right), \\
& I_{3}=\left(z w, y w, x w-w^{2}, y z, x z, x y-z^{2}, x^{2}-y^{2}\right) \\
& I_{4}=\left(w^{2}, y w+z w, x w, y z+z^{2}, y^{2}+z w, x y+x z, x^{2}+z w\right) .
\end{aligned}
$$

The rings $Q / I_{i}$ satisfy the hypotheses of Corollary 4.10 and have $a_{2}=10+i$, for $1 \leq i \leq 4$.
Examples 4.12. In an unpublished note, Roos [16], inspired by a paper of Katthän [10, constructed several examples of non-Golod rings $R$ of codepth 4 with trivial algebra multiplications on $A$. We provide here two of them. For each one, there exists a Golod homomorphism from a complete intersection ring, hence it has rational Poincaré series. The algebra multiplication on $A$ was checked using the DGAlgebras package [15] of Macaulay2 [13]. Proposition 4.5 confirms that indeed $q_{11}=q_{12}=0$, and moreover it gives us the exact size of the space generated by the triple Massey products $\left\langle A_{1}, A_{1}, A_{1}\right\rangle$, known to be nonzero.

Consider the following ideals in $Q=\mathbb{Q}[x, y, z, w]$ :

$$
\begin{aligned}
& J_{1}=\left(w^{3}, x y^{2}, x z^{2}+y z^{2}, x^{2} w, x^{2} y+y^{2} w, y^{2} z+z^{2} w\right) \\
& J_{2}=\left(w^{3}, x y^{2}, x z^{2}+y z^{2}, x^{2} w+z w^{2}, y^{2} w+x z w, y^{2} z+y z^{2}\right)
\end{aligned}
$$

The rings $Q / J_{i}$ with $i=1,2$ are non-Artinian of codepth 4 with

$$
\begin{aligned}
\mathrm{P}_{Q / J_{i}}^{Q}(t) & =1+6 t+(10+i) t^{2}+(7+i) t^{3}+2 t^{4} \\
\mathrm{P}_{\mathrm{k}}^{Q / J_{i}}(t) & =\frac{(1+t)^{4}}{1-6 t^{2}-(10+i) t^{3}-(7+i) t^{4}-t^{5}+t^{6}}
\end{aligned}
$$

For both rings $Q / J_{i}, q_{11}=0=q_{12}$ by Proposition 4.5, hence $b=0$ and $a=1$. Since $q_{22}=q_{13}=0$, the space spanned by the ternary Massey products $\left\langle A_{1}, A_{1}, A_{1}\right\rangle$ has rank one.

By [1, Example 7.1], not all local rings have rational Poincaré series. However, for every local ring $R$ with residue field k , there exists a unique sequence of integers $\left\{\varepsilon_{i}\right\}_{i \geq 0}$ such that the Poincaré series of $R$ can be expressed as

$$
P_{\mathrm{k}}^{R}(t)=\frac{\prod_{i=1}^{\infty}\left(1+t^{2 i-1}\right)^{\varepsilon_{2 i-1}}}{\prod_{i=1}^{\infty}\left(1-t^{2 i}\right)^{\varepsilon_{2 i}}}
$$

and $\varepsilon_{i}$ is called the $i$-th deviation of $R$; see for example [4, Remark 7.1.1]. Theorem 3.2 allows us to describe the first five deviations in terms of the algebraic invariants of $A$.

Corollary 4.13. Let $R$ be a local ring of embedding dimension $n$ and $a_{i}, q_{i j}$ be as in Summary 2.13. Then the first five deviations of $R$ are

$$
\begin{aligned}
& \varepsilon_{1}=n, \quad \varepsilon_{2}=a_{1}, \quad \varepsilon_{3}=a_{2}-q_{11} \\
& \varepsilon_{4}=a_{3}-q_{12}+\binom{a_{1}}{2}-q_{11} \\
& \varepsilon_{5}=a_{4}+a_{1} a_{2}-a_{1} q_{11}-q_{12}+b-a
\end{aligned}
$$

Proof. By comparing the coefficients on the left and right sides of the equality

$$
\prod_{i=1}^{\infty}\left(1+t^{2 i-1}\right)^{\varepsilon_{2 i-1}}=\prod_{i=1}^{\infty}\left(1-t^{2 i}\right)^{\varepsilon_{2 i}} \cdot\left(\beta_{0}+\beta_{1} t+\beta_{2} t^{2}+\beta_{3} t^{3}+\beta_{4} t^{4}+\beta_{5} t^{5}+\cdots\right)
$$

one obtains the following relations between the Betti numbers $\left\{\beta_{i}\right\}_{1 \leq i \leq 5}$ and the deviations $\left\{\varepsilon_{i}\right\}_{1 \leq i \leq 5}$ :

$$
\begin{aligned}
& \beta_{1}=\varepsilon_{1}, \quad \beta_{2}=\varepsilon_{2}+\binom{\varepsilon_{1}}{2}, \quad \beta_{3}=\varepsilon_{3}+\varepsilon_{2} \varepsilon_{1}+\binom{\varepsilon_{1}}{3}, \\
& \beta_{4}=\varepsilon_{4}+\varepsilon_{3} \varepsilon_{1}+\binom{1+\varepsilon_{2}}{2}+\varepsilon_{2}\binom{\varepsilon_{1}}{2}+\binom{\varepsilon_{1}}{4}, \\
& \beta_{5}=\varepsilon_{5}+\varepsilon_{4} \varepsilon_{1}+\varepsilon_{3} \varepsilon_{2}+\varepsilon_{3}\binom{\varepsilon_{1}}{2}+\varepsilon_{2}^{2} \varepsilon_{1}-\varepsilon_{1}\binom{\varepsilon_{2}}{2}+\varepsilon_{2}\binom{\varepsilon_{1}}{3}+\binom{\varepsilon_{1}}{5} .
\end{aligned}
$$

The first four relations were also given by Avramov [4, page 62] and Gulliksen and Levin 9, Proposition 3.3.4, Theorem 4.4.3]. Note that we have corrected the expression for $\beta_{4}$, compared to that given in [4, page 62]. The expressions for $\varepsilon_{i}$ described in the statement follow from these relations and Corollary 4.1,

Remark 4.14. The formulas for $\varepsilon_{2}, \varepsilon_{3}, \varepsilon_{4}$ in Corollary 4.13 were previously given in [2, Corollary 6.2] and [9, Proposition 3.3.4]. The expression for $\varepsilon_{5}$ obtained by Avramov in [2, Corollary 6.2] is, in our notations:

$$
\varepsilon_{5}=a_{4}+a_{1} a_{2}+a_{1} q_{11}-q_{12}-a_{1}^{3}+b^{\prime}-a,
$$

where $b^{\prime}:=\operatorname{rank}_{\mathrm{k}}(\operatorname{Ker} \Gamma)$ with

$$
\begin{aligned}
& \Gamma: A_{1} \otimes A_{1} \otimes A_{1} \rightarrow A_{2} \otimes A_{1} \oplus A_{1} \otimes A_{2}, \quad \text { defined by } \\
& \Gamma([x],[y],[z])=([x] \wedge[y],[y] \wedge[z]), \quad \text { for all }[x],[y],[z] \in A_{1} .
\end{aligned}
$$

The map $\psi$ in (2.4.2), that defines our invariant $b=\operatorname{rank}_{\mathrm{k}}(\operatorname{Coker} \psi)$, differs from $\Gamma$ just by its codomain. Thus, one can relate $b^{\prime}$ in [2] and our $b$ by:

$$
b^{\prime}=\operatorname{rank}_{\mathrm{k}}(\operatorname{Ker} \psi)=a_{1}^{3}-2 a_{1} q_{11}+b
$$

Note that in both references [2] and [9] there is a shift in the indexing of the deviations, their $\varepsilon_{i}$ is our $\varepsilon_{i+1}$.

## 5. An example illustrating the Construction

In this section we consider the codepth 4 artinian local ring

$$
R=\mathbb{Q}[x, y, z, w] /\left(x^{3}, y^{3}, z^{3}-x y^{2}, x^{2} z^{2}, x y z^{2}, y^{2} w, w^{2}\right)
$$

from [2, Section 7]. This ring is of a particular interest to us, since its Koszul homology algebra $A=$ $\mathrm{H}\left(K^{R}\right)$ has nontrivial multiplication and a nontrivial ternary Massey product that does not come from this multiplication. The free modules $\left\{F_{i}\right\}_{i=0, \ldots, 5}$ are given in terms of the Koszul algebra components $\left\{K_{i}\right\}_{i=0, \ldots, 5}$, the ranks $a_{i}$ of $A_{i}$, and the multiplicative invariants $q_{i j}, a$ and $b$. The differential maps of the complex $F$ in Construction 3.1 are given in terms of elements $z_{i}^{1}, z_{\ell}^{2}, z_{t}^{3}, z_{r}^{4}, \widetilde{p}_{s i}^{1}, \widetilde{\pi}_{s}^{3}, \widetilde{p}_{u i}^{2}$, and $\widetilde{\pi}_{u}^{4}$, see

Summary 2.13. We explicitly describe them all for this ring. The bases of $A_{i}=\mathrm{H}_{i}(K)$ are computed with Macaulay2 [13]. We use our results from Section 2 to obtain the other elements needed in Construction 3.1,
5.1. The ring $R$ is graded artinian with $R_{i}=0$ for all $i \geq 6$. The other graded components have the following basis elements:

$$
\begin{aligned}
& R_{0}: 1 \\
& R_{1}: \quad x, y, z, w \\
& R_{2}: x^{2}, x y, x z, x w, y^{2}, y z, y w, z^{2}, z w \\
& R_{3}: \\
& x^{2} y, x^{2} z, x^{2} w, x y z, x y w, x z^{2}, x z w, y^{2} z, y z^{2}, y z w, z^{3}, z^{2} w \\
& R_{4}: \\
& R_{5}: x^{2} y z, x^{2} y w, x^{2} z w, x y z w, x z^{3}, x z^{2} w, y^{2} z^{2}, y z^{2} w, z^{4} \\
& R_{5} y z w, x z^{4} .
\end{aligned}
$$

5.2. The Koszul algebra of $R$ has the form $K=\bigwedge\left(R^{4}\right) \cong R \oplus R^{4} \oplus R^{6} \oplus R^{4} \oplus R$. Let $\left\{T_{1}, T_{2}, T_{3}, T_{4}\right\}$ be the standard ordered vector basis of the free module $K_{1}=R^{4}$. Set $T_{i j}=T_{i} \wedge T_{j}$ and consider the ordered basis $\left\{T_{12}, T_{13}, T_{23}, T_{14}, T_{24}, T_{34}\right\}$ for the free module $K_{2}=\bigwedge^{2}\left(R^{4}\right) \cong R^{6}$. Set $T_{i j k}=T_{i} \wedge T_{j} \wedge T_{k}$ and consider the ordered basis $\left\{T_{123}, T_{124}, T_{134}, T_{234}\right\}$ for the free module $K_{3}=\bigwedge^{3}\left(R^{4}\right) \cong R^{4}$. Set $T_{1234}=T_{1} \wedge T_{2} \wedge T_{3} \wedge T_{4}$ and consider the basis $\left\{T_{1234}\right\}$ for the free module $K_{4}=\bigwedge^{4}\left(R^{4}\right) \cong R$. By Macaulay2, we obtain bases of $A_{i}=\mathrm{H}_{i}(K)$ and ranks

$$
a_{1}=7, \quad a_{2}=15, \quad a_{3}=14, \quad a_{4}=5
$$

5.3. A basis of $A_{1}$ is $\left\{\left[z_{i}^{1}\right]\right\}_{i=1, \ldots, 7}$ where:

$$
\begin{array}{lll}
z_{1}^{1}=w T_{4}, & z_{2}^{1}=x^{2} T_{1}, & z_{3}^{1}=y w T_{2}, \\
z_{5}^{1}=y^{2} T_{1}-z^{2} T_{3}, & z_{6}^{1}=y z^{2} T_{1}, & z_{7}^{1}=x z^{2} T_{1}
\end{array}
$$

5.4. Using Koszul and ring relations, we obtain that the space $A_{1} \cdot A_{1}$ has rank $q_{11}=7$ and its basis is given by the classes of

$$
\begin{array}{lll}
z_{1}^{1} \wedge z_{2}^{1}=-x^{2} w T_{14}, & z_{1}^{1} \wedge z_{5}^{1}=z^{2} w T_{34}, & z_{1}^{1} \wedge z_{6}^{1}=-y z^{2} w T_{14}, \\
z_{2}^{1} \wedge z_{3}^{1}=x^{2} y w T_{12}, & z_{3}^{1} \wedge z_{5}^{1}=-y z^{2} w T_{23}, & z_{4}^{1} \wedge z_{5}^{1}=-y^{2} z^{2} T_{23}
\end{array}
$$

Therefore, a basis of $\overline{A_{2}}$ is $\left\{\left[z_{\ell}^{2}\right]\right\}_{\ell=1, \ldots, 8}$, where

$$
\begin{array}{lll}
z_{1}^{2}=y w T_{24}, & z_{2}^{2}=y^{2} T_{24}, & z_{3}^{2}=x z^{2} T_{12}, \\
z_{5}^{2}=x^{2} y T_{12}-x z^{2} T_{13}, & z_{6}^{2}=x^{2} z T_{13}, & z_{7}^{2}=y z^{2} w T_{12},
\end{array} \quad z_{8}^{2}=z^{2} T_{13}, ~ T_{23}
$$

5.5. All other products among the basis elements of $A_{1}$ are zero in $A_{2}$, except for the Koszul relations of the nonzero products $A_{1} \cdot A_{1}$ above. It follows that the kernel of the multiplication map $\phi_{1}: A_{1} \otimes A_{1} \rightarrow A_{2}$ is generated by $a_{1}^{2}-q_{11}=42$ elements. We record the indices of basis elements of $A_{1} \cdot A_{1}$ by the set

$$
S=\{(1,2),(1,5),(1,6),(1,7),(2,3),(3,5),(4,5)\}
$$

A basis of $\operatorname{Ker} \phi_{1}$, as defined in (2.1.3), is given by elements of two types:
(1) $\left[z_{i}^{1}\right] \otimes\left[z_{j}^{1}\right], \quad$ for $1 \leq i, j \leq 7, \quad(i, j) \notin S \quad$ and $\quad(j, i) \notin S$;
(2) $\left[z_{i}^{1}\right] \otimes\left[z_{j}^{1}\right]+\left[z_{j}^{1}\right] \otimes\left[z_{i}^{1}\right], \quad$ for $\quad(i, j) \in S$.

Therefore, according to the types above, one defines $\widetilde{p}_{s_{(i, j)}}^{1}=\left(\widetilde{p}_{s_{(i, j)}}^{1}\right)_{k=1, \ldots, 7}$ as:
(1) $\widetilde{p}_{s_{(i, j)}}^{1}=\left\{\begin{array}{lll}z_{j}^{1} & \text { if } & k=i \\ 0 & \text { if } & k \neq i,\end{array} \quad\right.$ for all $1 \leq i, j \leq 7, \quad(i, j) \notin S \quad$ and $\quad(j, i) \notin S$;
(2) $\widetilde{p}_{s_{(i, j)} k}^{1}=\left\{\begin{array}{lll}z_{j}^{1} & \text { if } & k=i \\ z_{i}^{1} & \text { if } & k=j \\ 0 & \text { if } & k \neq i, j,\end{array} \quad\right.$ for all $(i, j) \in S$.
5.6. Next, we find the nonzero elements $\widetilde{\pi}_{s}^{3} \in K_{3}$ defined in (2.1.4) as follows. For the elements coming from Koszul relations in $K$, we choose $\widetilde{\pi}_{s}^{3}=0$ for those elements. The only nonzero products in $K_{2}$ come from elements of type (1) and they are

$$
z_{2}^{1} \wedge z_{4}^{1}=x^{2} y^{2} T_{12}=-z_{4}^{1} \wedge z_{2}^{1} \quad \text { and } \quad z_{5}^{1} \wedge z_{7}^{1}=x z^{4} T_{13}=-z_{7}^{1} \wedge z_{5}^{1}
$$

Therefore, we choose the following nontrivial liftings in $K_{3}$ :

$$
\widetilde{\pi}_{s_{(2,4)}}^{3}=x z^{2} T_{123}=-\widetilde{\pi}_{s_{(4,2)}}^{3} \quad \text { and } \quad \widetilde{\pi}_{s_{(5,7)}}^{3}=-x^{2} y z T_{123}=-\widetilde{\pi}_{s_{(7,5)}}^{3}
$$

5.7. We describe next the elements of $A_{3}$.

Claim 1. All the products in $A_{1} \cdot A_{1} \cdot A_{1}$ are zero.
Proof of Claim 1. First, all the products in $A_{1} \cdot A_{1} \cdot A_{1}$ not involving $\left[z_{1}^{1}\right]$ have the coefficients of $\left[T_{i j k}\right]$ of degree six, and $R_{6}=0$. Thus, all such products are zero. Second, the only pairs $(i, j)$ with $1<i<j \leq 7$ such that $\left[z_{i}^{1}\right] \wedge\left[z_{j}^{1}\right]$ is nonzero in $A_{1} \cdot A_{1}$ are in the set $\{(2,3),(3,5),(4,5)\}$, but $\left[z_{1}^{1} \wedge z_{3}^{1}\right]=\left[z_{1}^{1} \wedge z_{4}^{1}\right]=0$. Hence, all products involving $\left[z_{1}^{1}\right]$ at least once are zero. The claim now follows.

Therefore, $A_{1} \cdot A_{2}=A_{1} \cdot \overline{A_{2}}$, it has rank $q_{12}=10$, and its basis is given by the classes of

$$
\begin{array}{lll}
z_{1}^{1} \wedge z_{3}^{2}=x z^{2} w T_{124}, & z_{1}^{1} \wedge z_{4}^{2}=y z^{2} w T_{134}, & z_{1}^{1} \wedge z_{5}^{2}=x^{2} y w T_{124}-x z^{2} w T_{134}, \\
z_{1}^{1} \wedge z_{6}^{2}=x^{2} z w T_{134}, & z_{2}^{1} \wedge z_{1}^{2}=x^{2} y w T_{124}, & z_{2}^{1} \wedge z_{2}^{2}=x^{2} y^{2} T_{124} \\
z_{3}^{1} \wedge z_{6}^{2}=-x^{2} y z w T_{123}, & z_{5}^{1} \wedge z_{1}^{2}=y z^{2} w T_{234}, & z_{5}^{1} \wedge z_{2}^{2}=y^{2} z^{2} T_{234}, \\
z_{5}^{1} \wedge z_{3}^{2}=-x z^{4} T_{123}=z_{4}^{1} \wedge z_{6}^{2} . & &
\end{array}
$$

A basis of $\overline{A_{3}}$ is $\left\{\left[z_{t}^{3}\right]\right\}_{t=1, \ldots, 4}$, where

$$
z_{1}^{3}=y z^{2} w T_{123}, \quad z_{2}^{3}=y^{2} z^{2} T_{123}, \quad z_{3}^{3}=y z^{2} w T_{124}, \quad z_{4}^{3}=z^{4} T_{234}
$$

5.8. Using Proposition 2.6, we describe the elements $\widetilde{p}_{u i}^{2}$, for $1 \leq u \leq a_{1} a_{2}-a_{1} q_{11}-q_{12}+b=46+b$ and $1 \leq i \leq 7$, as defined in (2.5.1).

Claim 2. Let $\mathcal{A}, \mathcal{B}$ be as in Proposition 2.6 and let $b$ be as in Summary 2.13. Then

$$
\operatorname{Span}_{\mathrm{k}} \mathcal{A}=A_{1} \otimes\left(A_{1} \cdot A_{1}\right) \quad \text { and } \quad b=0
$$

Proof of Claim 2. It is clear that $\operatorname{Span}_{\mathrm{k}} \mathcal{A} \subseteq A_{1} \otimes\left(A_{1} \cdot A_{1}\right)$. For $1 \leq i, j, h \leq 7$, any nonzero element $\left[z_{i}^{1}\right] \otimes\left[z_{j}^{1}\right] \wedge\left[z_{h}^{1}\right]$ in $A_{1} \otimes\left(A_{1} \cdot A_{1}\right)$ has $(j, h) \in S$ or $(h, j) \in S$. We show that each such element is in $\operatorname{Span}_{\mathrm{k}} \mathcal{A}$.

In the case $\{(i, j),(i, h)\} \nsubseteq S$ we have

$$
\left[z_{i}^{1}\right] \otimes\left[z_{j}^{1}\right] \wedge\left[z_{h}^{1}\right]=\sum_{k=1}^{7}\left[z_{k}^{1}\right] \otimes\left[\widetilde{p}_{s_{(i, j)}}^{1}\right] \wedge\left[z_{h}^{1}\right]
$$

as in case (1) of 5.5
By Koszul relation, the case $(i, h) \in S$ reduces to the case $(i, j) \in S$ in which we have

$$
\left[z_{i}^{1}\right] \otimes\left[z_{j}^{1}\right] \wedge\left[z_{h}^{1}\right]=\left[z_{i}^{1}\right] \otimes\left[z_{j}^{1}\right] \wedge\left[z_{h}^{1}\right]+\left[z_{j}^{1}\right] \otimes\left[z_{i}^{1}\right] \wedge\left[z_{h}^{1}\right]=\sum_{k=1}^{7}\left[z_{k}^{1}\right] \otimes\left[\tilde{p}_{s_{(i, j)}}^{1}\right] \wedge\left[z_{h}^{1}\right]
$$

as in case (2) of 5.5. The first equality above follows from the proof of Claim 1. This implies $\operatorname{Span}_{\mathrm{k}} \mathcal{A}=$ $A_{1} \otimes\left(A_{1} \cdot A_{1}\right)$, so $\operatorname{rank}_{\mathrm{k}}\left(\operatorname{Span}_{\mathrm{k}} \mathcal{A}\right)=a_{1} q_{11}$. By Proposition 2.6(b) we get $b=0$.

Remark that Claim 2 implies Claim 1, since $\operatorname{Span}_{\mathrm{k}} \mathcal{A} \subseteq \operatorname{Ker} \phi_{2}$.
By definition of $\overline{A_{2}}$ as in Summary 2.13 and respectively Claim 2, the following equalities hold:

$$
A_{1} \otimes A_{2}=\left(A_{1} \otimes\left(A_{1} \cdot A_{1}\right)\right) \oplus\left(A_{1} \otimes \overline{A_{2}}\right)=\left(\operatorname{Span}_{\mathrm{k}} \mathcal{A}\right) \oplus\left(A_{1} \otimes \overline{A_{2}}\right)
$$

By Proposition 2.6, $\operatorname{Ker} \phi_{2}=\left(\operatorname{Span}_{\mathrm{k}} \mathcal{A}\right) \oplus B$, where $B=\left(\operatorname{Ker} \phi_{2}\right) \cap\left(A_{1} \otimes \overline{A_{2}}\right)$. In order to find a basis for $B$, we record the indices of basis elements of $A_{1} \cdot \overline{A_{2}}$ by the set

$$
U=\{(1,3),(1,4),(1,5),(1,6),(2,1),(2,2),(3,6),(5,1),(5,2),(5,3),(4,6)\}
$$

A basis of $B$ is given by elements of two types:
$\left(1^{\prime}\right)\left[z_{i}^{1}\right] \otimes\left[z_{\ell}^{2}\right]$ for all $1 \leq i \leq 7$ and $1 \leq \ell \leq 8$ such that $(i, \ell) \notin U$;
$\left(2^{\prime}\right)\left[z_{4}^{1}\right] \otimes\left[z_{6}^{2}\right]-\left[z_{5}^{1}\right] \otimes\left[z_{3}^{2}\right]$.
Therefore, according to the types above, one defines $\widetilde{p}_{u_{(i, \ell)}}^{2}=\left(\widetilde{p}_{u_{(i, \ell)} k}^{2}\right)_{k=1, \ldots, 7}$ as:
$\left(1^{\prime}\right) \widetilde{p}_{u_{(i, \ell)} k}^{2}=\left\{\begin{array}{ll}z_{\ell}^{2} & \text { if } k=i \\ 0 & \text { if } k \neq i,\end{array}\right.$ for all $1 \leq i \leq 7$ and $1 \leq \ell \leq 8$ such that $(i, \ell) \notin U ;$
$\left(2^{\prime}\right) \widetilde{p}_{u_{(4,6)} k}^{2}= \begin{cases}z_{6}^{2} & \text { if } k=4 \\ -z_{3}^{2} & \text { if } k=5 \\ 0 & \text { if } k \neq 4,5 .\end{cases}$
5.9. It is easy to check that in $K_{3}$ we have the equalities:
$\left(1^{\prime}\right) z_{i}^{1} \wedge z_{\ell}^{2}=0$ for all $1 \leq i \leq 7$ and $1 \leq \ell \leq 8$ such that $(i, \ell) \notin U ;$
$\left(2^{\prime}\right) z_{4}^{1} \wedge z_{6}^{2}-z_{5}^{1} \wedge z_{3}^{2}=0$.
Therefore, we may choose $\widetilde{\pi}_{u}^{4}=0$ for all $1 \leq u \leq 46$.
5.10. A similar argument as in the proof of Claim 1 gives $A_{1} \cdot A_{3}=0$, and hence $q_{13}=0$. Moreover, $A_{2} \cdot A_{2}$ has rank $q_{22}=2$ and its basis is given by the classes of

$$
z_{1}^{2} \wedge z_{6}^{2}=-x^{2} y z w T_{1234} \quad \text { and } \quad z_{2}^{2} \wedge z_{6}^{2}=-x z^{4} T_{1234}
$$

As $A_{1} \cdot A_{3}=0$, any element in $\left\langle A_{1}, A_{1}, A_{1}\right\rangle \subseteq A_{4}$ has a representative in $K_{4}$ given by

$$
\begin{equation*}
\sum_{s=1}^{42} \widetilde{\pi}_{s}^{3} \wedge p_{s}^{1} \quad \text { such that } \quad \sum_{s=1}^{42}\left[\widetilde{p}_{s k}^{1} \wedge p_{s}^{1}\right]=0, \text { for all } 1 \leq k \leq 7 \tag{5.10.1}
\end{equation*}
$$

where $p_{s}^{1} \in \operatorname{Ker} \partial_{1}^{K}$ is as in Proposition 2.11, and $\widetilde{p}_{s i}^{1}$ and $\widetilde{\pi}_{s}^{3}$ are defined in (2.1.3) and (2.1.4) respectively. As described above, the only nontrivial lifting elements $\widetilde{\pi}_{s}^{3} \in K_{3}$ are $\widetilde{\pi}_{s_{(2,4)}}^{3}=-\widetilde{\pi}_{s_{(4,2)}}^{3}$ and $\widetilde{\pi}_{s_{(5,7)}}^{3}=-\widetilde{\pi}_{s_{(7,5)}}^{3}$. Since all of them contain $T_{123}$, only the component of $p_{s}^{1}$ that contains $z_{1}^{1}=w T_{4}$ contributes to a nonzero Massey product. Thus, there exist $\alpha, \beta \in R$ such that

$$
\begin{aligned}
\sum_{s=1}^{42}\left[\widetilde{\pi}_{s}^{3} \wedge p_{s}^{1}\right] & =\left[\widetilde{\pi}_{s_{(2,4)}}^{3} \wedge p_{s_{(2,4)}}^{1}\right]+\left[\widetilde{\pi}_{s_{(5,7)}}^{3} \wedge p_{s_{(5,7)}}^{1}\right] \\
& =\left[\widetilde{\pi}_{s_{(2,4)}}^{3} \wedge z_{1}^{1}\right] \wedge[\alpha]+\left[\widetilde{\pi}_{s_{(5,7)}}^{3} \wedge z_{1}^{1}\right] \wedge[\beta] \\
& =\left[x z^{2} w T_{1234}\right] \wedge[\alpha]+\left[x^{2} y z w T_{1234}\right] \wedge[\beta] \\
& =\left\langle\left[z_{2}^{1}\right],\left[z_{4}^{1}\right],\left[z_{1}^{1}\right]\right\rangle \wedge[\alpha]-\left[z_{1}^{2} \wedge z_{6}^{2}\right] \wedge[\beta]
\end{aligned}
$$

The last equality follows from the following computation:

$$
\begin{aligned}
\left\langle\left[z_{2}^{1}\right],\left[z_{4}^{1}\right],\left[z_{1}^{1}\right]\right\rangle & =\left\{\left[\left(\partial_{3}^{K}\right)^{-1}\left(z_{2}^{1} \wedge z_{4}^{1}\right) \wedge z_{1}^{1}+z_{2}^{1} \wedge\left(\partial_{3}^{K}\right)^{-1}\left(z_{4}^{1} \wedge z_{1}^{1}\right)\right]\right\} \\
& =\left\{\left[\widetilde{\pi}_{s_{(2,4)}}^{3} \wedge z_{1}^{1}+z_{2}^{1} \wedge \widetilde{\pi}_{s_{(4,1)}}^{3}\right]\right\} \\
& =\left\{\left[x z^{2} w T_{1234}\right]\right\}
\end{aligned}
$$

By abusing notation, we write $\left\langle\left[z_{2}^{1}\right],\left[z_{4}^{1}\right],\left[z_{1}^{1}\right]\right\rangle=\left[x z^{2} w T_{1234}\right]$, which is not in $A_{1} \cdot A_{3}+A_{2} \cdot A_{2}$, as showed in [2. Section 7]. It is clear now that the rank of the $k$-vector space

$$
A_{1} \cdot A_{3}+A_{2} \cdot A_{2}+\operatorname{Span}_{\mathrm{k}}\left\langle A_{1} \cdot A_{1} \cdot A_{1}\right\rangle
$$

is $a=3$ and its basis is given by

$$
\left[z_{1}^{2}\right] \wedge\left[z_{6}^{2}\right], \quad\left[z_{2}^{2}\right] \wedge\left[z_{6}^{2}\right], \quad \text { and } \quad\left\langle\left[z_{2}^{1}\right],\left[z_{4}^{1}\right],\left[z_{1}^{1}\right]\right\rangle
$$

Thus, a basis of $\overline{A_{4}}$ is $\left\{\left[z_{r}^{4}\right]\right\}_{r=1,2}$ where

$$
z_{1}^{4}=y z^{2} w T_{1234} \quad \text { and } \quad z_{2}^{4}=y^{2} z^{2} T_{1234}
$$

5.11. We conclude that for the ring $R$ discussed in this section, and by Proposition 4.2 we have:

$$
\begin{aligned}
& a_{1}=7, \\
& a_{2}=15 \text {, } \\
& a_{3}=14 \text {, } \\
& a_{4}=5 \text {, } \\
& q_{11}=7 \text {, } \\
& q_{12}=10 \text {, } \\
& q_{13}=0 \text {, } \\
& q_{22}=2 \text {, } \\
& a=3 \text {, } \\
& b=0, \\
& \mathcal{P}_{3}=7, \\
& \mathcal{P}_{4}=45, \\
& \mathcal{P}_{5}=221 .
\end{aligned}
$$
