# DUAL VARIABLES FOR M-BRANES 

JENS HOPPE


#### Abstract

Motivated in parts by [1, relativistic extended objects will be described by an (over-complete) set of generalized coordinates and momenta that in some sense are 'dual' to each other.


$M$-dimensional extended objects in $D$-dimensional Minkowski-space (see e.g. 2] for a review) are describable by a Hamiltonian whose potential is a homogenous polynomial of degree $2 M$ in the derivative of the coordinate fields. As always with nonlinear theories, understanding their classical dynamics and possible quantization rests on finding suitable variables. Hence, partly motivated by [1], let us consider

& =: \int\left(P_{\alpha}^{\beta}+Q_{\alpha}^{\beta}\right) \theta_{\alpha}  \tag{1}\\
A & =-\frac{1}{(M-1)!} \frac{1}{2} \int \gamma_{\alpha \varepsilon}^{i_{2} \ldots i_{M}} \theta_{\alpha}\left\{\theta_{\varepsilon}, x_{i_{2}} \ldots x_{i_{M}}\right\} \rho d^{M} \varphi
\end{align*}

where the (canonically conjugate, classical) variables/fields, $x_{i=1 \ldots d}$ and $p_{j / \rho}$, are functions on a compact $M$-dimensional manifold $\mathbb{M}$, the $\theta_{\alpha}(\varphi)$ non-dynamical 'book-keeping' fermionic variables, satisfying

\left\{f_{1} \ldots f_{M}\right\}:=\frac{1}{\rho} \varepsilon^{r_{1} \ldots r_{M}} \partial_{r_{1}} f_{1} \ldots \partial_{r_{M}} f_{M}
\end{array}

(for any functions $f_{r}$ on $\mathbb{M}$; the density $\rho$, which according to [6] can effectively be thought of as a constant, will for notational convenience be put $=1$ ), and the $\gamma^{i}$,

assumed to be (constant) real symmetric $s \times s$ matrices, with $\gamma^{i_{1} \ldots i_{M}}$ their standard fully antisymmetrized products $\left(=\gamma^{i_{1}} \ldots \gamma^{i_{M}}\right.$, if all $i_{r}$ different).

Using (2) one has

= & \int\left(p_{i} \gamma_{\beta \alpha}^{i}+\frac{1}{M!}\left\{x_{i_{1}} \ldots x_{i_{M}}\right\} \gamma_{\beta \alpha}^{i_{1} \ldots i_{M}}\right)\left(p_{k} \gamma_{\beta^{\prime} \alpha}^{k}+\frac{1}{M!}\left\{x_{k_{1}} \ldots x_{k_{M}}\right\} \gamma_{\beta^{\prime} \alpha}^{k_{1} \ldots k_{M}}\right) \\
= & \delta_{\beta \beta^{\prime}} \int \vec{p}^{2}+\int \frac{1}{M!}\left\{x_{i_{1}} \ldots x_{i_{M}}\right\}\left\{x_{k_{1}} \ldots x_{k_{M}}\right\}\left(\frac{1}{M!} \gamma_{\beta \alpha}^{i_{1} \ldots i_{M}} \gamma_{\beta^{\prime} \alpha}^{k_{1} \ldots k_{M}}+\beta \leftrightarrow \beta^{\prime}\right) \\
& +\int p_{k}\left\{x_{i_{1}} \ldots x_{i_{M}}\right\} \frac{1}{M!}\left(\gamma^{i_{1} \ldots i_{M}} \gamma^{k}\right)_{\beta \beta^{\prime}+\beta^{\prime} \beta} \\
\cong & \delta_{\beta \beta^{\prime}} 2(H=T+V)
\end{aligned}

Due to the antisymmetrization $\left\{x\left[i_{1} \ldots x_{i_{M}}\right\}\left\{x_{k_{1}}\right] \ldots x_{k_{M}}\right\}$ giving zero [3, 4] the second term on the rhs of (5) gives $\delta_{\beta \beta^{\prime}} \frac{1}{M!} \int \sum_{i_{1} \ldots i_{M}}\left\{x_{i_{1}} \ldots x_{i_{M}}\right\}^{2}$, as $\frac{1}{M!}\left(\gamma^{i_{1}} \ldots \gamma^{i_{M}} \gamma^{i_{M}} \ldots \gamma^{i_{1}}\right)=\mathbf{1}$, and the last term being zero on the reduced phase space of volume preserving (cp. [3]) functionals of $x$ and $p$ if $\gamma^{i_{1} \ldots i_{M} k}$ is antisymmetric, i.e. if $\frac{M(M+1)}{2}$ is odd resp. $M=1,2(\bmod 4)$.
On the other hand

= & +\frac{1}{(M-1)!} \int \theta_{\varepsilon}\left\{p_{i}, x_{k_{2}} \ldots x_{k_{M}}\right\}\left(\gamma^{i} \gamma^{k_{2} \ldots k_{M}}\right)_{\beta \varepsilon} \\
& +\frac{1}{(M-1)!}\left\{\left\{x_{i_{1}} \ldots x_{i_{M}}\right\}, x_{k_{1}} \ldots x_{k_{M}}\right\} \frac{1}{M!}\left(\gamma^{i_{1} \ldots i_{M}} \gamma^{k_{2} \ldots k_{M}}\right)_{\beta \varepsilon} \\
\cong & \int\left(\dot{Q}_{\beta \alpha}+\dot{P}_{\beta \alpha}\right) \theta_{\alpha} \\
= & \dot{L}_{\beta},

where the first term in the middle of (6) is zero on the reduced (volumepreserving) phase space whenever $i=k_{r}$ for some $r$ (in the first term) and in the second term due to the $\}$-identities ([3, 4]) unless $\left\{k_{2} \ldots k_{M}\right\} \subset\left\{i_{1} \ldots i_{M}\right\},($ for which there are $M(M-1) \ldots 2=M$ ! possibilities).
Note that the equations of motion can be put into the form $\dot{Q}=\Omega P$,
$\dot{P}=\Omega Q$,

\Omega_{\alpha \alpha^{\prime}}^{r} & :=\frac{1}{(M-1)!} \varepsilon^{r r_{2} \ldots r_{M}} \partial_{r_{2}} x_{i_{2}} \ldots \partial_{r_{M}} x_{i_{M}} \gamma_{\alpha \alpha^{\prime}}^{i_{2} \ldots i_{M}},

with the 'matrix-vectorfield' $\Omega=\left(\Omega^{r} \partial_{r}\right)=\left(\Omega_{\alpha \alpha^{\prime}}\right)$ being divergencefree, and independent of $\beta$, and the $+\operatorname{sign}$ applying to $M=(1) 2,5(\bmod 4)$, the $-\operatorname{sign}$ to $M=3,4(\bmod 4)$ :

& \quad=\frac{1}{(M-1)!}\left\{\left\{x_{k_{1}} \ldots x_{k_{M}}\right\}, x_{i_{2}} \ldots x_{i_{M}}\right\}\left(\frac{1}{M!} \gamma^{i_{1} \ldots i_{M}} \gamma^{k_{M} \ldots k_{1}}\right)_{\alpha \beta} \\
& \quad=\frac{1}{(M-1)!}\left\{\left\{x_{k_{1}} \ldots x_{k_{M}}\right\}, x_{k_{2}} \ldots x_{k_{M}}\right\} \gamma_{\alpha \beta}^{k_{1}} \\
& \quad=\dot{p}_{k} \gamma_{\beta \alpha}^{k} \\
& \quad=\dot{P}_{\alpha}^{\beta}
\end{align*}

and

\Omega_{\alpha \alpha^{\prime}}^{r} \partial_{r} P_{\alpha^{\prime}}^{\beta} & =\partial_{r} p_{i} \gamma_{\beta \alpha^{\prime}}^{i} \frac{1}{(M-1)!} \varepsilon^{r r_{2} \ldots r_{M}} \partial_{r_{2}} x_{i_{2}} \ldots \partial_{r_{M}} x_{i_{M}} \gamma_{\alpha \alpha^{\prime}}^{i_{2} \ldots . i_{M}}  \tag{9}\\
& =(-)^{\frac{(M-1)(M-2)}{2}}\left\{p_{i}, x_{i_{2}} \ldots x_{i_{M}}\right\}\left(\gamma^{i i_{2} \ldots i_{M}}\right)_{\beta \alpha} .
\end{align*}

It is then natural to look for 'self-dual' solutions of the form

$$
\begin{equation*}
P_{\alpha}^{\beta}=A_{\alpha \alpha^{\prime}} Q_{\alpha^{\prime}}^{\beta} \tag{10}
\end{equation*}
$$

with (if $A$ is constant)

$$
\begin{equation*}
A \gamma^{i_{2} \ldots i_{M}} A=(-)^{\frac{(M-1)(M-2)}{2}} \gamma^{i_{2} \ldots i_{M}} \tag{11}
\end{equation*}
$$

choosing $A=\gamma:=\gamma^{1} \gamma^{2} \ldots \gamma^{d}, \gamma^{2}=(-)^{d \frac{(d-1)}{2}}, \gamma^{T}=(-)^{d \frac{(d-1)}{2}} \gamma$, $\gamma \gamma^{i}=(-)^{(d-1)} \gamma^{i} \gamma$ (hence $\gamma \gamma^{i_{2} \ldots i_{M}} \gamma=(-)^{(M-1)(d-1)+d \frac{(d-1)}{2}} \gamma^{i_{2} \ldots i_{M}}$ ) one gets a condition on pairs $(M, d)$ which for $M=2$ is satisfied by $d=2,5,6,9,10, \ldots$ while for $d=3,6,7,10,11, \ldots$ if $M=3$. There is however no guarantee that (10) is consistent for these allowed pairs $(M, d)$; e.g., for $d=2, M=2, \gamma^{1}=\sigma_{3}, \gamma^{2}=\sigma_{1},\left(P_{\alpha}^{\beta}\right)=\left(p_{i} \gamma_{\beta \alpha}^{i}\right)=$
$\left(\begin{array}{cc}p_{1} & p_{2} \\ p_{2} & -p_{1}\end{array}\right),\left(Q_{\alpha}^{\beta}\right)=\left(\left\{x_{1}, x_{2}\right\} \gamma_{\beta \alpha}^{12}\right)=\left(\begin{array}{cc}0 & x_{12} \\ -x_{12} & 0\end{array}\right), P_{\alpha}^{1}=\varepsilon_{\alpha^{\prime} \alpha} Q_{\alpha^{\prime}}^{1}$ gives $p_{1}=x_{12}, p_{2}=-Q_{1}^{1}=0$, while $P_{\alpha}^{2}=\varepsilon_{\alpha \alpha^{\prime}} Q_{\alpha^{\prime}}^{2}$ implies $p_{2}=Q_{2}^{2}=0$, $-p_{1}=-Q_{1}^{2}=x_{12}$. While, related to quaternions and octonions, several special time-dependent solutions (see e.g. [5] and references therein) are known for the opposite (Euclidean) sign, which allows $d=3,4,7,8, \ldots$ for $M=2$ and $d=4,5,8,9$ for $M=3$ it is important to notice the generally significant structure of the equations of motion (77), when written in the over-complete set of variables $Q$ and $P$ (with respect to which the Hamiltonian is quadratic, i.e. -was it not for the nontrivial symplectic form reflected by $\Omega-$ a set of harmonic oscillators).
Finally, let me note that (11), and the few lines following it, has to hold only modulo terms that vanish when inserted in the context of (7); even in the case of the few already known self-dual solutions (with the 'wrong/euclidean' sign), which are not necessarily of the form (10), as generally mixing the $\beta$-indices, $P_{\alpha}^{\beta}=M_{\beta \alpha, \beta^{\prime} \alpha^{\prime}} Q_{\alpha}^{\beta^{\prime}}$ the corresponding consistency equation $M \Omega^{r} M= \pm \Omega^{r}$ has to (and will) hold only up to terms vanishing when acting on $\partial_{r} Q$. That the over-complete variables $Q$ and $P$ have relevant orthogonal subspaces plays a role already for finite degrees of freedom; comparing the time evolution of $V_{\alpha a}^{\beta}=P_{\alpha a}^{\beta}+Q_{\alpha a}^{\beta}$ (see eq. (2), (6) of [1]) with calculating the classical dynamical Poisson-brackets,

& =: z_{\alpha a, \alpha^{\prime} a^{\prime}}^{\beta \beta^{\prime}}, \tag{12}
\end{align*}
$$

hence

$$
\begin{aligned}
\dot{V}_{\alpha a}^{\beta} & =\left\{V_{\alpha a}^{\beta}, H=\frac{1}{2} V_{\alpha^{\prime} a^{\prime}}^{\beta} V_{\alpha^{\prime} a^{\prime}}^{\beta}-\gamma_{\beta \beta}^{t} x_{t e} J_{e}\right\} \\
& =z_{\alpha a, \alpha^{\prime} a^{\prime}}^{\beta \beta} V_{\alpha^{\prime} a^{\prime}}^{\beta}-\gamma_{\beta \beta}^{t} x_{t e} f_{a e b} V_{\alpha b}^{\beta}
\end{aligned}
$$

implies e.g. that (for the fuzzy membrane in $d+2$ space-time dimensions [7], resp. $d+1$ Yang-Mills systems, e.g. [8] for $d=3, N=2$ )

$$
f_{a b a^{\prime}} x_{s b}\left(\gamma_{\beta \alpha}^{s t} \gamma_{\beta \alpha^{\prime}}^{t}+\gamma_{\beta \alpha^{\prime}}^{s t} \gamma_{\beta \alpha}^{t}+\gamma_{\alpha \alpha^{\prime}}^{s}-\gamma_{\beta \beta}^{s} \delta_{\alpha^{\prime} \alpha}\right) V_{\alpha^{\prime} a^{\prime}}^{\beta}=0 .
$$
