# Optimal Clustering in Anisotropic Gaussian Mixture Models

#### Abstract

We study the clustering task under anisotropic Gaussian Mixture Models where the covariance matrices from different clusters are unknown and are not necessarily the identical matrix. We characterize the dependence of signal-to-noise ratios on the cluster centers and covariance matrices and obtain the minimax lower bound for the clustering problem. In addition, we propose a computationally feasible procedure and prove it achieves the optimal rate within a few iterations. The proposed procedure is a hard EM type algorithm, and it can also be seen as a variant of the Lloyd's algorithm that is adjusted to the anisotropic covariance matrices.


## 1 Introduction

Clustering is a fundamentally important task in statistics and machine learning [7, 2]. The most popular and studied model for clustering is the Gaussian Mixture Model (GMM) [18, 20] which can be written as

$$
Y_{j}=\theta_{z_{j}^{*}}^{*}+\epsilon_{j}, \text { where } \epsilon_{j} \stackrel{i n d}{\sim} \mathcal{N}\left(0, \Sigma_{z_{j}^{*}}^{*}\right), \forall j \in[n] .
$$

Here $Y=\left(Y_{1}, \ldots, Y_{n}\right)$ are the observations with $n$ being the sample size. Let $k$ be the number of clusters that is assumed to be known. Denote $\left\{\theta_{a}^{*}\right\}_{a \in[k]}$ to be unknown centers and $\left\{\Sigma_{a}^{*}\right\}$ to be unknown covariance matrices for the $k$ clusters. Let $z^{*} \in[k]^{n}$ be the cluster structure such that for each index $j \in[n]$, the value of $z_{j}^{*}$ indicates which cluster the $j$ th data point belongs to. The goal is to recover $z^{*}$ from $Y$. For any estimator $\hat{z}$, its clustering performance is measured by a misclustering error rate $h\left(\hat{z}, z^{*}\right)$ which will be introduced later in (4).

There have been increasing interests in the theoretical and algorithmic analysis of clustering under GMMs. When the GMM is isotropic (that is, all the covariance matrices $\left\{\Sigma_{a}^{*}\right\}_{a \in[k]}$ are equal to the same identity matrix), [15] obtains the minimax rate for clustering which takes a form of $\exp \left(-(1+o(1))\left(\min _{a \neq b}\left\|\theta_{a}^{*}-\theta_{b}^{*}\right\|\right)^{2} / 8\right)$ under the loss $h\left(\hat{z}, z^{*}\right)$. Various methods have been studied in the isotropic setting. $k$-means clustering [16] might be the most natural choice but it is NP-hard [4]. As a local approach to optimize the $k$-mean objects, Lloyd's algorithm [13] is one of the most popular clustering algorithms and has achieved many successes in different disciplines [24]. [15, 8] establishes computational and statistical guarantees for the Lloyd's algorithm by showing it achieves the optimal rates after a few iterations provided with some decent initialization. Another popular approach to clustering especially for high-dimensional data is spectral clustering [22, 19, 21], which is an umbrella term for clustering after a dimension reduction through a spectral decomposition. $[14,17,1]$ proves the spectral clustering also achieves the optimality under the isotropic GMM. Another line of work is to consider semidefinite programming (SDP) as a convex relaxation of the $k$-means objective. Its statistical properties have been studied in $[6,9]$.

In spite of all the exciting results, most of the existing literature focuses on isotropic GMMs, and clustering under the anisotropic case where the covariance matrices are not necessarily the identity matrix is not well-understood. The results of some papers $[15,6]$ hold under sub-Gaussian mixture models, where the errors $\epsilon_{j}$ are assumed to follow some sub-Gaussian distribution with variance proxy $\sigma^{2}$. It seems that their result already covers the anisotropic case, as $\left\{\mathcal{N}\left(0, \Sigma_{a}^{*}\right)\right\}_{a \in[k]}$ are indeed sub-Gaussian distributions. However, from a minimax point of view, among all the subGaussian distributions with variance proxy $\sigma^{2}$, the least favorable case (the case where clustering is the most difficult) is when the errors are $\mathcal{N}\left(0, \sigma^{2}\right)$. Therefore, the minimax rates for clustering under the sub-Gaussian mixture model is essentially the one under isotropic GMMs, and methods such as the Lloyd's algorithm that requires no covariance matrix information can be rate-optimal. As a result, the aforementioned results are all for isotropic GMMs.

A few papers have explored the direction of clustering under anisotropic GMMs. [3] gives a polynomial-time clustering algorithm that provably works well when the Gaussian distributions are well separated by hyperplanes. Their idea is further developed in [11] which allows the Gaussians to be overlapped with each other but only for two-cluster cases. A recent paper [23] proposes another method for clustering under a balanced mixture of two elliptical distributions. They give a provable upper bound of their clustering performance with respect to an excess risk. Nevertheless, it remains unknown what is the fundamental limit of clustering under the anisotropic GMMs and whether there is any polynomial-time procedure that achieves it.

In this paper, we will investigate the optimal rates of the clustering task under two anisotropic GMMs. Model 1 is when the covariance matrices are all equal to each other (i.e., homogeneous) and are equal to some unknown matrix $\Sigma^{*}$. Model 2 is more flexible, where the covariance matrices are unknown and are not necessarily equal to each other (i.e., heterogeneous). The contribution of this paper is two-fold, summarized as follows.

Our first contribution is on the fundamental limits. We obtain the minimax lower bound for clustering under the anisotropic GMMs with respect to the loss $h\left(\hat{z}, z^{*}\right)$. We show it takes the form

$$
\inf _{\hat{z}} \sup _{z^{*} \in[k]^{n}} \mathbb{E} h\left(z, z^{*}\right) \geq \exp \left(-(1+o(1)) \frac{(\text { signal-to-noise ratio })^{2}}{8}\right)
$$

where the signal-to-noise ratio under Model 1 is equal to $\min _{a, b \in[k]: a \neq b}\left\|\left(\theta_{a}^{*}-\theta_{b}^{*}\right)^{T} \Sigma^{*-\frac{1}{2}}\right\|$ and the one for Model 2 is more complicated. For both models, we can see the minimax rates depend not only on the centers but also the covariance matrices. This is different from the isotropic case whose signal-to-noise ratio is $\min _{a \neq b}\left\|\theta_{a}^{*}-\theta_{b}^{*}\right\|$. Our results precisely capture the role the covariance matrices play in the clustering problem. It shows covariance matrices impact the fundamental limits of the clustering problem through complicated interaction with the centers especially in Model 2. The minimax lower bounds are obtained by establishing connections with Linear Discriminant Analysis (LDA) and Quadratic Discriminant Analysis (QDA).

Our second and more important contribution is on the computational side. We propose a computationally feasible and rate-optimal algorithm for the anisotropic GMM. Popular methods including the Lloyd's algorithm and the spectral clustering no longer work well as they are developed under the isotropic case and only consider the distances among the centers [3]. We study an adjusted Lloyd's algorithm which estimates the covariance matrices in each iteration and recovers the clusters using the covariance matrix information. It can also be seen as a hard EM algorithm [5]. As an iterative algorithm, we give a statistical and computational guarantee and guidance to practitioners by showing that it obtains the minimax lower bound within $\log n$ iterations. That is, let $z^{(t)}$ be the
output of the algorithm after $t$ iterations, we have with high probability,

$$
h\left(z^{(t)}, z^{*}\right) \leq \exp \left(-(1+o(1)) \frac{(\text { signal-to-noise ratio })^{2}}{8}\right)
$$

holds for all $t \geq \log n$. The algorithm can be initialized by popular methods such as the spectral clustering or the Lloyd's algorithm. In numeric studies, we show the proposed algorithm improves greatly from the two aforementioned methods under anisotropic GMMs, and matches the optimal exponent given in the minimax lower bound.

Paper Organization. The remaining paper is organized as follows. In Section 2, we study Model 1 where the covariance matrices are unknown but homogeneous. In Section 3, we consider Model 2 where covariance matrices are unknown and heterogeneous. For both cases, we obtain the minimax lower bound for clustering and study the adjusted Lloyd's algorithm. In Section 4, we provide a numeric comparison with other popular methods. The proofs of theorems in Section 2 are given in Section 5 and the proofs for Section 3 are included in Section 6. All the technical lemmas are included in Section 7.

Notation. Let $[m]=\{1,2, \ldots, m\}$ for any positive integer $m$. For any set $S$, we denote $|S|$ for its cardinality. For any matrix $X \in \mathbb{R}^{d \times d}$, we denote $\lambda_{1}(X)$ to be its smallest eigenvalue and $\lambda_{d}(X)$ to be its largest eigenvalue. In addition, we denote $\|X\|$ to be its operator norm. For any two vectors $u, v$ of the same dimension, we denote $\langle u, v\rangle=u^{T} v$ to be its inner product. For any positive integer $d$, we denote $I_{d}$ to be the $d \times d$ identity matrix. We denote $\mathcal{N}(\mu, \Sigma)$ to be the normal distribution with mean $\mu$ and covariance matrix $\Sigma$. We denote $\mathbb{I}\{\cdot\}$ to be the indicator function. Given two positive sequences $a_{n}, b_{n}$, we denote $a_{n}=o\left(b_{n}\right)$ if $a_{n} / b_{n}=o(1)$ when $n \rightarrow \infty$. We write $a_{n} \lesssim b_{n}$ if there exists a constant $C>0$ independent of $n$ such that $a_{n} \leq C b_{n}$ for all $n$.

## 2 GMM with Unknown but Homogeneous Covariance Matrices

### 2.1 Model

We first consider a GMM where covariance matrices of different clusters are unknown but are assumed to be equal to each other. The data generating progress can be displayed as follow:

Model 1:

$$
\begin{equation*}
Y_{j}=\theta_{z_{j}^{*}}^{*}+\epsilon_{j}, \text { where } \epsilon_{j} \stackrel{i n d}{\sim} \mathcal{N}\left(0, \Sigma^{*}\right), \forall j \in[n] . \tag{1}
\end{equation*}
$$

It is called Stretched Mixture Model in [23] as the density of $Y_{j}$ is elliptical. Throughout the paper, we call it Model 1 for simplicity and to distinguish it from a more complicated model that will be introduced in Section 3. The goal is to recover the underlying cluster assignment vector $z^{*}$ from $Y$.

Signal-to-noise Ratio. Define the signal-to-noise ratio

$$
\begin{equation*}
\mathrm{SNR}=\min _{a, b \in[k]: a \neq b}\left\|\left(\theta_{a}^{*}-\theta_{b}^{*}\right)^{T} \Sigma^{*-\frac{1}{2}}\right\| \tag{2}
\end{equation*}
$$

which is a function of all the centers $\left\{\theta_{a}^{*}\right\}_{a \in[k]}$ and the covariance matrix $\Sigma^{*}$. As we will show later in Theorem 2.1, SNR captures the difficulty of the clustering problem and determines the minimax rate. For the geometric interpretation of SNR, we defer it after presenting Theorem 2.2.

A quantity closely related to SNR is the minimum distance among the centers. Define $\Delta$ as

$$
\begin{equation*}
\Delta=\min _{a, b \in[k]: a \neq b}\left\|\theta_{a}^{*}-\theta_{b}^{*}\right\| . \tag{3}
\end{equation*}
$$

Then we can see SNR and $\Delta$ are in the same order if all eigenvalues of the covariance matrix $\Sigma^{*}$ is assumed to be constants. If $\Sigma^{*}$ is further assumed to be an identical matrix, then we have SNR equal to $\Delta$. As a result, in $[15,8,14]$ where isotropic GMMs are studied, $\Delta$ plays the role of signal-to-noise ratio and appears in the minimax rates.

Loss Function. To measure the clustering performance, we consider the misclustering error rate defined as follows. For any $z, z^{*} \in[k]^{n}$, we define

$$
\begin{equation*}
h\left(z, z^{*}\right)=\min _{\psi \in \Psi} \frac{1}{n} \sum_{j=1}^{n} \mathbb{I}\left\{\psi\left(z_{j}\right) \neq z_{j}^{*}\right\}, \tag{4}
\end{equation*}
$$

where $\Psi=\{\psi: \psi$ is a bijection from $[k]$ to $[k]\}$. Here the minimum is over all the permutations over $[k]$ due to the identifiability issue of the labels $1,2, \ldots, k$. Another loss that will be used is $\ell\left(z, z^{*}\right)$ defined as

$$
\begin{equation*}
\ell\left(z, z^{*}\right)=\sum_{j=1}^{n}\left\|\theta_{z_{j}}^{*}-\theta_{z_{j}^{*}}^{*}\right\|^{2} . \tag{5}
\end{equation*}
$$

It also measures the clustering performance of $z$ considering the distances among the true centers. It is related to $h\left(z, z^{*}\right)$ as $h\left(z, z^{*}\right) \leq \ell\left(z, z^{*}\right) /\left(n \Delta^{2}\right)$ and hence provides more information than $h\left(z, z^{*}\right)$. We will mainly use $\ell\left(z, z^{*}\right)$ in the technical analysis but will eventually present the results using $h\left(z, z^{*}\right)$ which is more interpretable.

### 2.2 Minimax Lower Bound

We first establish the minimax lower bound for the clustering problem under Model 1.
Theorem 2.1. Under the assumption $\frac{S N R}{\sqrt{\log k}} \rightarrow \infty$, we have

$$
\begin{equation*}
\inf _{\hat{z}} \sup _{z^{*} \in[k]^{n}} \mathbb{E} h\left(z, z^{*}\right) \geq \exp \left(-(1+o(1)) \frac{S N R^{2}}{8}\right) . \tag{6}
\end{equation*}
$$

If $S N R=O(1)$ instead, we have $\inf _{\hat{z}} \sup _{z^{*} \in[k]^{n}} \mathbb{E} h\left(z, z^{*}\right) \geq c$ for some constant $c>0$.
Theorem 2.1 allows the cluster numbers $k$ to grow with $n$ and shows that SNR $\rightarrow \infty$ is a necessary condition to have a consistent clustering if $k$ is a constant. Theorem 2.1 holds for any arbitrary $\left\{\theta_{a}^{*}\right\}_{a \in[k]}$ and $\Sigma^{*}$, and the minimax lower bound depend on them through SNR. The parameter space is only for $z^{*}$ while $\left\{\theta_{a}^{*}\right\}_{a \in[k]}$ and $\Sigma^{*}$ are fixed. Hence, (6) can be interpreted as a pointwise result, and it captures precisely the explicit dependence of the minimaxity on $\left\{\theta_{a}^{*}\right\}_{a \in[k]}$ and $\Sigma^{*}$.

Theorem 2.1 is closely related to the Linear Discriminant Analysis (LDA). If there are only two clusters, and if the centers and the covariance matrix are known, then estimating each $z_{j}^{*}$ is exactly the task of LDA: we want to figure out which normal distribution an observation $Y_{j}$ is generated from, where the two normal distributions have different means but the same covariance matrix. In fact, this is also how Theorem 2.1 is proved: we will first reduce the estimation problem of $z^{*}$ into
a two-point hypothesis testing problem for each individual $z_{j}^{*}$, the error of which is given in Lemma 2.1 by the analysis of LDA, and then aggregate all the testing errors together.

In the following lemma, we give a sharp and explicit formula for the testing error of the LDA. Here we have two normal distributions $\mathcal{N}\left(\theta_{1}^{*}, \Sigma^{*}\right)$ and $\mathcal{N}\left(\theta_{2}^{*}, \Sigma^{*}\right)$ and an observation $X$ that is generated from one of them. We are interested in estimating which distribution it is from. By NeymanPearson lemma, it is known that the likelihood ratio test $\mathbb{I}\left\{2\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-1} X \geq \theta_{2}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{2}^{*}-\theta_{1}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{1}^{*}\right\}$ is the optimal testing procedure. Then by using the Gaussian tail probability, we are able to obtain the optimal testing error, the lower bound of which is given in Lemma 2.1.
Lemma 2.1 (Testing Error for Linear Discriminant Analysis). Consider two hypotheses $\mathbb{H}_{0}: X \sim$ $\mathcal{N}\left(\theta_{1}^{*}, \Sigma^{*}\right)$ and $\mathbb{H}_{1}: X \sim \mathcal{N}\left(\theta_{2}^{*}, \Sigma^{*}\right)$. Define a testing procedure

$$
\phi=\mathbb{I}\left\{2\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-1} X \geq \theta_{2}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{2}^{*}-\theta_{1}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{1}^{*}\right\} .
$$

Then we have $\inf _{\hat{\phi}}\left(\mathbb{P}_{\mathbb{H}_{0}}(\hat{\phi}=1)+\mathbb{P}_{\mathbb{H}_{1}}(\hat{\phi}=0)\right)=\mathbb{P}_{\mathbb{H}_{0}}(\phi=1)+\mathbb{P}_{\mathbb{H}_{1}}(\phi=0) . I f\left\|\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-\frac{1}{2}}\right\| \rightarrow$ $\infty$, we have

$$
\inf _{\hat{\phi}}\left(\mathbb{P}_{\mathbb{H}_{0}}(\hat{\phi}=1)+\mathbb{P}_{\mathbb{H}_{1}}(\hat{\phi}=0)\right) \geq \exp \left(-(1+o(1)) \frac{\left\|\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-\frac{1}{2}}\right\|^{2}}{8}\right)
$$

Otherwise, $\inf _{\hat{\phi}}\left(\mathbb{P}_{\mathbb{H}_{0}}(\hat{\phi}=1)+\mathbb{P}_{\mathbb{H}_{1}}(\hat{\phi}=0)\right) \geq c$ for some constant $c>0$.


Figure 1: A geometric interpretation of SNR.
With the help of Lemma 2.1, we have a geometric interpretation of SNR. In the left panel of Figure 1, we have two normal distributions $\mathcal{N}\left(\theta_{1}^{*}, \Sigma^{*}\right)$ and $\mathcal{N}\left(\theta_{2}^{*}, \Sigma^{*}\right)$ for $X$ to be generated from. The black line represents the optimal testing procedure $\phi$ displayed in Lemma 2.1 that divides the space into two half-spaces. To calculate the testing error, we can make a transformation $X^{\prime}=$ $\left(\Sigma^{*}\right)^{-\frac{1}{2}}\left(X-\theta_{1}^{*}\right)$ so that the two normal distributions become isotropic: $\mathcal{N}\left(0, I_{d}\right)$ and $\mathcal{N}\left(\left(\Sigma^{*}\right)^{-\frac{1}{2}}\left(\theta_{2}^{*}-\right.\right.$ $\left.\left.\theta_{1}^{*}\right), I_{d}\right)$ as displayed in the right panel. Then the distance between the two centers are $\|\left(\Sigma^{*}\right)^{-\frac{1}{2}}\left(\theta_{2}^{*}-\right.$ $\left.\theta_{1}^{*}\right) \|$, and the distance between a center and the black curve is half of it. Then $\mathbb{P}_{H_{0}}(\hat{\phi}=1)$ is the probability of $\mathcal{N}\left(0, I_{d}\right)$ in the grayed area, which is equal to $\exp \left(-(1+o(1))\left\|\left(\Sigma^{*}\right)^{-\frac{1}{2}}\left(\theta_{2}^{*}-\theta_{1}^{*}\right)\right\|^{2} / 8\right)$ by Gaussian tail probability. As a result, $\left\|\left(\Sigma^{*}\right)^{-\frac{1}{2}}\left(\theta_{2}^{*}-\theta_{1}^{*}\right)\right\|$ is the effective distance between the two centers of $\mathcal{N}\left(\theta_{1}^{*}, \Sigma^{*}\right)$ and $\mathcal{N}\left(\theta_{2}^{*}, \Sigma^{*}\right)$ for the clustering problem, considering the geometry of the covariance matrix. Since we have multiple clusters, SNR defined in (2) can be interpreted as the minimum effective distances among the centers $\left\{\theta_{a}^{*}\right\}_{a \in[k]}$ considering the anisotropic structure of $\Sigma^{*}$ and it captures the intrinsic difficulty of the clustering problem.

### 2.3 Rate-Optimal Adaptive Procedure

In this section, we will propose a computationally feasible and rate-optimal procedure for clustering under Model 1. Summarized in Algorithm 1, the proposed algorithm is a variant of the Lloyd algorithm. Starting from some initialization, it updates the estimation of the centers $\left\{\theta_{a}^{*}\right\}_{a \in[k]}$ (in (7)), the covariance matrix $\Sigma^{*}$ (in (8)), and the cluster assignment vector $z^{*}$ (in (9)) iteratively. It differs from the Lloyd's algorithm in the sense that Lloyd's algorithm is for isotropic GMMs without the covariance matrix update (8). In addition, in (9) it updates the estimation of $z_{j}^{*}$ by $\operatorname{argmin}_{a \in[k]}\left(Y_{j}-\theta_{a}^{(t)}\right)^{T}\left(Y_{j}-\theta_{a}^{(t)}\right)$ instead. To distinguish them from each other, we call the classical Lloyd's algorithm as the vanilla Lloyd's algorithm, and name Algorithm 1 as the adjusted Lloyd's algorithm, as it is adjusted to the unknown and anisotropic covariance matrix.

Algorithm 1 can also be interpreted as a hard EM algorithm. If we apply the Expectation Maximization (EM) for Model 1, we will have an M step for estimating parameters $\left\{\theta_{a}^{*}\right\}_{a \in[k]}$ and $\Sigma^{*}$ and an E step for estimating $z^{*}$. It turns out the updates on the parameters (7) - (8) are exactly the same as the updates of EM (M step). However, the update on $z^{*}$ in Algorithm 1 is different from that in the EM. Instead of taking a conditional expectation (E step), we also take a maximization in (9). As a result, Algorithm 1 consists solely of M steps for both the parameters and $z^{*}$, which is known as a hard EM algorithm.

Update the cluster estimations:
\[
\begin{equation*}
z_{j}^{(t)}=\underset{a \in[k]}{\operatorname{argmin}}\left(Y_{j}-\theta_{a}^{(t)}\right)^{T}\left(\Sigma^{(t)}\right)^{-1}\left(Y_{j}-\theta_{a}^{(t)}\right), \quad j \in[n] . \tag{9}
\end{equation*}

In Theorem 2.2, we give a computational and statistical guarantee of the proposed Algorithm 1. We show that starting from a decent initialization, within \(\log n\) iterations, Algorithm 1 achieves an error rate \(\exp \left(-(1+o(1))\right.\) SNR \(\left.^{2} / 8\right)\) which matches with the minimax lower bound given in Theorem 2.1. As a result, Algorithm 1 is a rate-optimal procedure. In addition, the algorithm is fully adaptive to the unknown \(\left\{\theta_{a}^{*}\right\}_{a \in[k]}\) and \(\Sigma^{*}\). The only information assumed to be known is \(k\) the number of clusters, which is commonly assumed to be known in clustering literature [ \(15,8,14]\). The theorem also shows that the number of iterations to achieve the optimal rate is at most \(\log n\),
which provides implementation guidance to practitioners.
Theorem 2.2. Assume \(k d=O(\sqrt{n})\) and \(\min _{a \in k} \sum_{j=1}^{n} \mathbb{I}\left\{z_{j}^{*}=a\right\} \geq \frac{\alpha n}{k}\) for some constant \(\alpha>0\). Assume \(\frac{S N R}{k} \rightarrow \infty\) and \(\lambda_{d}\left(\Sigma^{*}\right) / \lambda_{1}\left(\Sigma^{*}\right)=O(1)\). For Algorithm 1, suppose \(z^{(0)}\) satisfies \(\ell\left(z^{(0)}, z^{*}\right)=\) \(o(n / k)\) with probability at least \(1-\eta\). Then with probability at least \(1-\eta-n^{-1}-\exp (-S N R)\), we have
\[
h\left(z^{(t)}, z^{*}\right) \leq \exp \left(-(1+o(1)) \frac{S N R^{2}}{8}\right), \quad \text { for all } t \geq \log n .
\]

We have remarks on the assumptions of Theorem 2.2. We allow the number of clusters \(k\) to grow with \(n\). When \(k\) is a constant, the assumption on SNR \(\rightarrow \infty\) is the necessary condition to have a consistent recovery of \(z^{*}\) according to the minimax lower bound presented in Theorem 2.1. The assumption on \(\Sigma^{*}\) is to make sure the covariance matrix is well-conditioned. The dimensionality \(d\) is assumed to be at most \(O(\sqrt{n})\), an assumption that is stronger than that in [15, 8, 14] which only needs \(d=O(n)\). This is due to that compared to these papers, we need to estimate the covariance matrix \(\Sigma^{*}\) and to have a control on the estimation error \(\left\|\Sigma^{(t)}-\Sigma^{*}\right\|\).

The requirement for the initialization \(\ell\left(z^{(0)}, z^{*}\right)=o(n / k)\) can be fulfilled by simple procedures. A popular choice is the vanilla Lloyd's algorithm the performance of which is studied in [15, 8]. Since \(\epsilon_{j}\) are sub-Gaussian random variables with proxy variance \(\lambda_{\text {max }},[8]\) implies the vanilla Lloyd's algorithm output \(\hat{z}\) satisfies \(\ell\left(\hat{z}, z^{*}\right) \leq n \exp \left(-(1+o(1)) \Delta^{2} /\left(8 \lambda_{\max }\right)\right)\) with probability at least \(1-\exp (-\Delta)-n^{-1}\), under the assumption that \(\mathrm{SNR} / k \rightarrow \infty\). Note that \([8]\) is for isotropic GMMs, but its results can be extended to sub-Gaussian mixture models with nearly identical proof. Then we have \(\ell\left(\hat{z}, z^{*}\right)=o(n / k)\), as \(\Delta^{2} / \lambda_{\max }\) and \(\mathrm{SNR}^{2}\) are both in the same order under the assumption SNR/k \(/ k \infty\). As a result, we immediately have the following corollary.

Corollary 2.1. Assume \(k d=O(\sqrt{n})\) and \(\min _{a \in k} \sum_{j=1}^{n} \mathbb{I}\left\{z_{j}^{*}=a\right\} \geq \frac{\alpha n}{k}\) for some constant \(\alpha>\) 0. Assume \(\frac{S N R}{k} \rightarrow \infty\) and \(\lambda_{d}\left(\Sigma^{*}\right) / \lambda_{1}\left(\Sigma^{*}\right)=O(1)\). Using the vanilla Lloyd's algorithm as the initialization \(z^{(0)}\) in Algorithm 1, we have with probability at least \(1-n^{-1}-\exp (-S N R)-\exp (-\Delta)\),
\[
h\left(z^{(t)}, z^{*}\right) \leq \exp \left(-(1+o(1)) \frac{S N R^{2}}{8}\right), \quad \text { for all } t \geq \log n .
\]

\section*{3 GMM with Unknown and Heterogeneous Covariance Matrices}

\subsection*{3.1 Model}

In this section, we study the GMM with covariance matrices from each cluster unknown and not necessarily equal to each other. The data generation process can be displayed as follow,

Model 2:
\[
\begin{equation*}
Y_{j}=\theta_{z_{j}^{*}}^{*}+\epsilon_{j}, \text { where } \epsilon_{j} \stackrel{\text { ind }}{\sim} \mathcal{N}\left(0, \Sigma_{z_{j}^{*}}^{*}\right), \forall j \in[n] . \tag{10}
\end{equation*}
\]

We call it Model 2 throughout the paper to distinguish it from Model 1 studied in Section 2. The difference between (10) and (1) is that we now have \(\left\{\Sigma_{a}^{*}\right\}_{a \in[k]}\) instead of a shared \(\Sigma^{*}\). We consider the same loss functions as in (4) and (5).

Signal-to-noise Ratio. The signal-to-noise ratio for Model 2 is defined as follows. We use the notation \(S N R^{\prime}\) to distinguish it from SNR for Model 1. Compared to SNR, SNR \({ }^{\prime}\) is much more
complicated and does not have an explicit formula. We first define a space \(\mathcal{B}_{a, b} \in \mathbb{R}^{d}\) for any \(a, b \in[k]\) such that \(a \neq b\) :

& \mathcal{B}_{a, b}=\left\{x \in \mathbb{R}^{d}: x^{T} \Sigma_{a}^{* \frac{1}{2}} \Sigma_{b}^{*-1}\left(\theta_{a}^{*}-\theta_{b}^{*}\right)+\frac{1}{2} x^{T}\left(\Sigma_{a}^{* \frac{1}{2}} \Sigma_{b}^{*-1} \Sigma_{a}^{* \frac{1}{2}}-I_{d}\right) x\right. \\
&\left.\leq-\frac{1}{2}\left(\theta_{a}^{*}-\theta_{b}^{*}\right)^{T} \Sigma_{b}^{*-1}\left(\theta_{a}^{*}-\theta_{b}^{*}\right)+\frac{1}{2} \log \left|\Sigma_{a}^{*}\right|-\frac{1}{2} \log \left|\Sigma_{b}^{*}\right|\right\}
\end{aligned}
\]

We then define \(\mathrm{SNR}_{a, b}^{\prime}=2 \min _{x \in \mathcal{B}_{a, b}}\|x\|\) and
\[
\begin{equation*}
\mathrm{SNR}^{\prime}=\min _{a, b \in[n]: a \neq b} \mathrm{SNR}_{a, b}^{\prime} \tag{11}
\end{equation*}
\]

The from of SNR' is closely connected to the testing error of the Quadratic Discriminant Analysis (QDA), which we will give in Lemma 3.1. For the interpretation of the SNR (especially from a geometric point of view), we defer it after presenting Lemma 3.1. Here let us consider a few special cases where we are able to simplify \(\mathrm{SNR}^{\prime}\) : (1) When \(\Sigma_{a}^{*}=\Sigma^{*}\) for all \(a \in[k]\), by simple algebra, we have \(\mathrm{SNR}_{a, b}^{\prime}=\left\|\left(\theta_{a}^{*}-\theta_{b}^{*}\right)^{T} \Sigma^{*-\frac{1}{2}}\right\|\) for any \(a, b \in[k]\) such that \(a \neq b\). Hence, \(\mathrm{SNR}^{\prime}=\) SNR and Model 2 is reduced to the Model 1. (2) When \(\Sigma^{*}=\sigma_{a}^{2} I_{d}\) for any \(a \in[k]\) where \(\sigma_{1}, \ldots, \sigma_{k}>0\) are large constants, we have \(\mathrm{SNR}_{a, b}^{\prime}, \mathrm{SNR}_{b, a}^{\prime}\) both close to \(2\left\|\theta_{a}^{*}-\theta_{b}^{*}\right\| /\left(\sigma_{a}+\sigma_{b}\right)\). From these examples, we can see SNR \(^{\prime}\) is determined by both the centers \(\left\{\theta_{a}^{*}\right\}_{a \in[k]}\) and the covariance matrices \(\left\{\Sigma_{a}^{*}\right\}_{a \in[k]}\).

\subsection*{3.2 Minimax Lower Bound}

We first establish the minimax lower bound for the clustering problem under Model 2.
Theorem 3.1. Under the assumption \(\frac{S N R^{\prime}}{\sqrt{\log k}} \rightarrow \infty\), we have
\[
\inf _{\hat{z}} \sup _{z^{*} \in[k]^{n}} \mathbb{E} h\left(z, z^{*}\right) \geq \exp \left(-(1+o(1)) \frac{S N R^{\prime 2}}{8}\right) .
\]

If \(\operatorname{SNR}=O(1)\) instead, we have \(\inf _{\hat{z}} \sup _{z^{*} \in[k]^{n}} \mathbb{E} h\left(z, z^{*}\right) \geq c\) for some constant \(c>0\).
Despite that the statement of Theorem 3.1 looks similar to that of Theorem 2.1, the two minimax lower bounds are different from each other due to the discrepancy in the dependence of the centers and the covariance matrices in SNR \({ }^{\prime}\) and SNR. By the same argument as in Section 2.2, the minimax lower bound established in Theorem 3.1 is closely related to the Quadratic Discriminant Analysis (QDA) between two normal distributions with different means and different covariance matrices.

Lemma 3.1 (Testing Error for Quadratic Discriminant Analysis). Consider two hypotheses \(\mathbb{H}_{0}\) : \(X \sim \mathcal{N}\left(\theta_{1}^{*}, \Sigma_{1}^{*}\right)\) and \(\mathbb{H}_{1}: X \sim \mathcal{N}\left(\theta_{2}^{*}, \Sigma_{2}^{*}\right)\). Define a testing procedure
\[
\phi=\mathbb{I}\left\{\log \left|\Sigma_{1}^{*}\right|+\left(x-\theta_{1}^{*}\right)^{T} \Sigma_{1}^{*}\left(x-\theta_{1}^{*}\right) \geq \log \left|\Sigma_{2}^{*}\right|+\left(x-\theta_{2}^{*}\right)^{T} \Sigma_{2}^{*}\left(x-\theta_{2}^{*}\right)\right\} .
\]

Then we have \(\inf _{\hat{\phi}}\left(\mathbb{P}_{\mathbb{H}_{0}}(\hat{\phi}=1)+\mathbb{P}_{\mathbb{H}_{1}}(\hat{\phi}=0)\right)=\mathbb{P}_{\mathbb{H}_{0}}(\phi=1)+\mathbb{P}_{\mathbb{H}_{1}}(\phi=0)\). If \(\min \left\{\operatorname{SNR}_{1,2}^{\prime}, S N R_{2,1}^{\prime}\right\} \rightarrow\) \(\infty\), we have
\[
\inf _{\hat{\phi}}\left(\mathbb{P}_{H_{0}}(\hat{\phi}=1)+\mathbb{P}_{H_{1}}(\hat{\phi}=0)\right) \geq \exp \left(-(1+o(1)) \frac{\min \left\{S N R_{1,2}^{\prime}, S N R_{2,1}^{\prime}\right\}^{2}}{8}\right)
\]

Otherwise, \(\inf _{\hat{\phi}}\left(\mathbb{P}_{H_{0}}(\hat{\phi}=1)+\mathbb{P}_{H_{1}}(\hat{\phi}=0)\right) \geq c\) for some constant \(c>0\).


Figure 2: A geometric interpretation of \(\mathrm{SNR}^{\prime}\).

From Lemma 3.1, we can have a geometric interpretation of SNR'. In the left panel of Figure 2, we have two normal distributions \(\mathcal{N}\left(\theta_{1}^{*}, \Sigma_{1}^{*}\right)\) and \(\mathcal{N}\left(\theta_{2}^{*}, \Sigma_{2}^{*}\right)\) where \(X\) can be generated from. The black curve represents the optimal testing procedure \(\phi\) displayed in Lemma 3.1. Since \(\Sigma_{1}^{*}\) is not necessarily equal to \(\Sigma_{2}^{*}\), the black curve is not necessarily a straight line. If \(\mathbb{H}_{0}\) is true, then the probability for \(X\) to be incorrectly classified is when \(X\) falls in the gray area, which is \(\mathbb{P}_{H_{0}}(\hat{\phi}=1)\). To calculate it, we can make a transformation \(X^{\prime}=\left(\Sigma_{1}^{*}\right)^{-\frac{1}{2}}\left(X-\theta_{1}^{*}\right)\). Then displayed in the right panel of Figure 2, the two distributions become \(\mathcal{N}\left(0, I_{d}\right)\) and \(\mathcal{N}\left(\left(\Sigma_{1}^{*}\right)^{-\frac{1}{2}}\left(\theta_{2}^{*}-\theta_{1}^{*}\right),\left(\Sigma_{1}^{*}\right)^{-\frac{1}{2}} \Sigma_{2}^{*}\left(\Sigma_{1}^{*}\right)^{-\frac{1}{2}}\right)\), and the optimal testing procedure \(\mathbb{I}\left\{X^{\prime} \in \mathcal{B}_{1,2}\right\}\). As a result, in the right panel of Figure \(2, \mathcal{B}_{1,2}\) represents the space colored by gray, and the black curve is its boundary. Then \(\mathbb{P}_{H_{0}}(\hat{\phi}=1)\) is equal to \(\mathbb{P}\left(\mathcal{N}\left(0, I_{d}\right) \in \mathcal{B}_{1,2}\right)\), which can be shown to be determined by the minimum distance between the center of \(\mathcal{N}\left(0, I_{d}\right)\) and the space \(\mathcal{B}_{1,2}\). Denote the minimum distance by \(\operatorname{SNR}_{1,2}^{\prime} / 2\), by Lemmas 7.10 and Lemma 7.11, we can show \(\mathbb{P}\left(\mathcal{N}\left(0, I_{d}\right) \in \mathcal{B}_{1,2}\right)=\exp \left(-(1+o(1)) \operatorname{SNR}_{1,2}^{\prime 2} / 8\right)\). As a result, the SNR \({ }^{\prime}\) can be interpreted as the minimum effective distance among the centers \(\left\{\theta_{a}^{*}\right\}_{a \in[k]}\) considering the anisotropic and heterogeneous structure of \(\left\{\Sigma_{a}^{*}\right\}_{a \in[k]}\) and it captures the intrinsic difficulty of the clustering problem under Model 2.

\subsection*{3.3 Optimal Adaptive Procedure}

In this section, we will propose a computationally feasible and rate-optimal procedure for clustering under Model 2. Similar to Algorithm 1, the proposed Algorithm 2 can be seen as a variant of the Lloyd's algorithm that is adjusted to the unknown and heterogeneous covariance matrices. It can also be interpreted as a hard EM algorithm under Model 2. Algorithm 2 differs from Algorithm 1 in (13) and (14), as now there are \(k\) covariance matrices to be estimated.

In Theorem 3.2, we give a computational and statistical guarantee of the proposed Algorithm 2. We show that provided with some decent initialization, Algorithm 2 is able to achieve the minimax lower bound within \(\log n\) iterations. The assumptions needed in Theorem 3.2 are similar to those in Theorem 3.2, except that we require stronger assumptions on \(k\) and the dimensionality \(d\) since now we have \(k\) (instead of one) covariance matrices to be estimated. In addition, by \(\max _{a, b \in[k]} \lambda_{d}\left(\Sigma_{a}^{*}\right) / \lambda_{1}\left(\Sigma_{b}^{*}\right)=O(1)\) we not only assume each of the \(k\) covariance matrices is wellconditioned, but also assume they are comparable to each other.

Theorem 3.2. Assume \(k, d=O(1)\) and \(\min _{a \in k} \sum_{j=1}^{n} \mathbb{I}\left\{z_{j}^{*}=a\right\} \geq \frac{\alpha n}{k}\) for some constant \(\alpha>0\). Assume \(S N R^{\prime} \rightarrow \infty\) and \(\max _{a, b \in[k]} \lambda_{d}\left(\Sigma_{a}^{*}\right) / \lambda_{1}\left(\Sigma_{b}^{*}\right)=O(1)\). For Algorithm 2, suppose \(z^{(0)}\) satisfies

\(\ell\left(z^{(0)}, z^{*}\right)=o(n / k)\) with probability at least \(1-\eta\). Then with probability at least \(1-\eta-n^{-1}-\) \(\exp \left(-S N R^{\prime}\right)\), we have
\[
h\left(z^{(t)}, z^{*}\right) \leq \exp \left(-(1+o(1)) \frac{S N R^{\prime 2}}{8}\right), \quad \text { for all } t \geq \log n
\]

The vanilla Lloyd's algorithm can be used as the initialization for Algorithm 2. Under the assumption that \(\lambda_{d}\left(\Sigma^{*}\right) / \lambda_{1}\left(\Sigma^{*}\right)=O(1)\), Model 2 is also a sub-Gaussian mixture model. By the same argument as in Section 2.3 we have the following corollary.

Corollary 3.1. Assume \(k, d=O(1)\) and \(\min _{a \in k} \sum_{j=1}^{n} \mathbb{I}\left\{z_{j}^{*}=a\right\} \geq \frac{\alpha n}{k}\) for some constant \(\alpha>\) 0. Assume SNR \(\rightarrow \infty\) and \(\lambda_{d}\left(\Sigma^{*}\right) / \lambda_{1}\left(\Sigma^{*}\right)=O(1)\). Using the vanilla Lloyd's algorithm as the initialization \(z^{(0)}\) in Algorithm 2, we have with probability at least \(1-n^{-1}-\exp (-S N R)\),
\[
h\left(z^{(t)}, z^{*}\right) \leq \exp \left(-(1+o(1)) \frac{S N R^{\prime 2}}{8}\right), \quad \text { for all } t \geq \log n
\]

\section*{4 Numerical Studies}

In this section, we compare the performance of the proposed methods with other popular clustering methods on synthetic datasets under different settings.

Model 1. The first simulation is designed for the GMM with unknown but homogeneous covariance matrices (i.e., Model 1). We independently generate \(n=1200\) samples with dimension

\(d=50\) from \(k=30\) clusters. Each cluster has 40 samples. We set \(\Sigma^{*}=U^{T} \Lambda U\), where \(\Lambda\) is a \(50 \times 50\) diagonal matrix with diagonal elements selected from 0.5 to 8 with equal space and \(U\) is a randomly generated orthogonal matrix. The centers \(\left\{\theta_{a}^{*}\right\}_{a \in[n]}\) are orthogonal or each other with \(\left\|\theta_{1}^{*}\right\|=\ldots=\left\|\theta_{30}^{*}\right\|=9\). We consider four popular clustering methods: (1) the spectral clustering method [14] (denoted as "spectral"), (2) the vanilla Lloyd's algorithm [15] (denoted as "vanilla Lloyd"), (3) the proposed Algorithm 1 initialized by the spectral clustering (denoted as "spectral + Alg 1 "), and (4) Algorithm 1 initialized by the vanilla Lloyd (denoted as "vanilla Lloyd + Alg 1 "). The comparison is presented in the left panel of Figure 3.

In the plot, the \(x\)-axis is the number of iterations and the \(y\)-axis is the logarithm of the misclustering error rate, i.e., \(\log (h)\). Each of the curves plotted is an average of 100 independent trials. We can see the proposed Algorithm 1 outperforms the spectral clustering and the vanilla Lloyd's algorithm significantly. What is more, the dashed line represents the optimal exponent \(-\mathrm{SNR}^{2} / 8\) of the minimax lower bound given in Section 2.1. Then we can see Algorithm 1 achieves it after 3 iterations. This justifies the conclusion established in Theorem 2.2 that Algorithm 1 is rate-optimal.

Model 2. We also compare the performances of four methods (spectral, vanilla Lloyd, spectral + Alg 2, and vanilla Lloyd \(+\operatorname{Alg} 2\) ) for the GMM with unknown and heterogeneous covariance matrices (i.e., Model 2). In this case, we take \(n=1200, k=3\) and \(d=5\). We set \(\Sigma_{1}^{*}=I\), \(\Sigma_{2}^{*}=\Lambda_{2}\) which is a \(5 \times 5\) diagonal matrix with elements generated from 0.5 to 8 with equal space and \(\Sigma_{3}^{*}=U^{T} \Lambda_{3} U\), where \(\Lambda_{3}\) is a diagonal matrix with elements selected uniformly from 0.5 to 2 and \(U\) is a randomly generated orthogonal matrix. To simplify the calculation of \(\mathrm{SNR}^{\prime}\), we take \(\theta_{1}^{*}\) as a randomly selected unit vector, \(\theta_{2}^{*}=\theta_{1}^{*}+5 e_{1}\) with \(e_{1}\) denoting the vector with a 1 in the first coordinate and 0 's elsewhere and \(\theta_{3}^{*}=\theta_{2}^{*}+v_{1}\) with \(v_{1}\) randomly selected satisfying \(\left\|v_{1}\right\|=10\). The comparison is presented in the right panel of Figure 3 where each curve plotted is an average of 100 independent trials.

From the plot, we can clearly see the proposed Algorithm 2 improves greatly the spectral clustering and the vanilla Lloyd algorithm. The dashed line represents the optimal exponent \(-\mathrm{SNR}^{2} / 8\) of the minimax lower bound given in Section 3.1, which is achieved by Algorithm 2. Hence, this numerically justifies Theorem 3.2 that Algorithm 1 is rate-optimal for clustering under Model 2.

\section*{5 Proofs in Section 2}

\subsection*{5.1 Proofs for The Lower Bound}

Proof of Lemma 2.1. Note that \(\phi\) is the likelihood ratio test. Hence by the Neyman-Pearson lemma, it is the optimal procedure. Let \(\epsilon \sim \mathcal{N}\left(0, I_{d}\right)\). By Gaussian tail probability, we have
\[
\begin{aligned}
\mathbb{P}_{\mathbb{H}_{0}}(\phi=1)+\mathbb{P}_{\mathbb{H}_{1}}(\phi=0)= & \mathbb{P}\left(2\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-1}\left(\theta_{1}+\epsilon\right) \geq \theta_{2}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{2}^{*}-\theta_{1}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{1}^{*}\right) \\
& +\mathbb{P}\left(2\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-1}\left(\theta_{2}+\epsilon\right)<\theta_{2}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{2}^{*}-\theta_{1}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{1}^{*}\right) \\
= & 2 \mathbb{P}\left(2\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-1}\left(\theta_{1}+\epsilon\right) \geq \theta_{2}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{2}^{*}-\theta_{1}^{* T}\left(\Sigma^{*}\right)^{-1} \theta_{1}^{*}\right) \\
= & 2 \mathbb{P}\left(\epsilon>\frac{1}{2}\left\|\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-\frac{1}{2}}\right\|\right) \\
\geq & C \min \left\{1, \frac{1}{\left\|\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-\frac{1}{2}}\right\|} \exp \left(-\frac{\left\|\left(\theta_{2}^{*}-\theta_{1}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-\frac{1}{2}}\right\|^{2}}{8}\right)\right\},
\end{aligned}
\]
for some constant \(C>0\). The proof is complete.
Proof of Theorem 2.1. We adopt the idea from [15]. Without loss of generality, assume the minimum in (2) is achieved at \(a=1, b=2\) so that \(\operatorname{SNR}=\left(\theta_{1}^{*}-\theta_{2}^{*}\right)^{T}\left(\Sigma^{*}\right)^{-1}\left(\theta_{1}^{*}-\theta_{2}^{*}\right)\). Consider an arbitrary \(\bar{z} \in[k]^{n}\) such that \(\left|\left\{i \in[n]: \bar{z}_{i}=a\right\}\right| \geq\left\lceil\frac{n}{k}-\frac{n}{8 k^{2}}\right\rceil\) for any \(a \in[k]\). Then for each \(a \in[k]\), we can choose a subset of \(\left\{i \in[n]: \bar{z}_{i}=a\right\}\) with cardinality \(\left\lceil\frac{n}{k}-\frac{n}{8 k^{2}}\right\rceil\), denoted by \(T_{a}\). Let \(T=\cup_{a \in[k]} T_{a}\). Then we can define a parameter space

Notice that for any \(z \neq \tilde{z} \in \mathcal{Z}\), we have \(\frac{1}{n} \sum_{i=1}^{n} \mathbb{I}\left\{z_{i} \neq \tilde{z}_{i}\right\} \leq \frac{k}{n} \frac{n}{8 k^{2}}=\frac{1}{8 k}\) and \(\frac{1}{n} \sum_{i=1}^{n} \mathbb{I}\left\{\psi\left(z_{i}\right) \neq\right.\) \(\left.\tilde{z}_{i}\right\} \geq \frac{1}{n}\left(\frac{n}{2 k}-\frac{n}{8 k^{2}}\right) \geq \frac{1}{4 k}\) for any permutation \(\psi\) on \([k]\). Thus we can conclude

h(z, \tilde{z})=\frac{1}{n} \sum_{i=1}^{n} \mathbb{I}\left\{z_{i} \neq \tilde{z}_{i}\right\}, \quad \text { for all } z, \tilde{z} \in \mathcal{Z} .

& \geq \inf _{\hat{z}} \frac{1}{|\mathcal{Z}|} \sum_{z^{*} \in \mathcal{Z}} \mathbb{E} h\left(\hat{z}, z^{*}\right) \\
& \geq \frac{1}{n} \sum_{i \in T^{c}} \inf _{\hat{z}_{i}} \frac{1}{|\mathcal{Z}|} \sum_{z^{*} \in \mathcal{Z}} \mathbb{P}_{z^{*}}\left(\hat{z}_{i} \neq z_{i}\right) .
\end{aligned}

Now consider a fixed \(i \in T^{c}\). Define \(\mathcal{Z}_{a}=\left\{z \in \mathcal{Z}: z_{i}=a\right\}\) for \(a=1,2\). Then we can see \(\mathcal{Z}=\mathcal{Z}_{1} \cup \mathcal{Z}_{2}\) and \(\mathcal{Z}_{1} \cap \mathcal{Z}_{2}=\emptyset\). What is more, there exists a one-to-one mapping \(f(\cdot)\) between \(\mathcal{Z}_{1}\) and \(\mathcal{Z}_{2}\), such that for any \(z \in \mathcal{Z}_{1}\), we have \(f(z) \in \mathcal{Z}_{2}\) with \([f(z)]_{j}=z_{j}\) for any \(j \neq i\) and \([f(z)]_{i}=2\). Hence, we can reduce the problem into a two-point testing probe and then apply Lemma 2.1. We
first consider the case that SNR \(\rightarrow \infty\). We have

& \geq \frac{1}{|\mathcal{Z}|} \sum_{z^{*} \in \mathcal{Z}_{1}} \inf _{\hat{z}_{i}}\left(\mathbb{P}_{z^{*}}\left(\hat{z}_{i} \neq 1\right)+\mathbb{P}_{f\left(z^{*}\right)}\left(\hat{z}_{i} \neq 2\right)\right) \\
& \geq \frac{\left|\mathcal{Z}_{1}\right|}{\mathcal{Z}} \exp \left(-(1+\eta) \frac{\text { SNR }^{2}}{8}\right) \\
& \geq \frac{1}{2} \exp \left(-(1+\eta) \frac{\mathrm{SNR}^{2}}{8}\right)
\end{aligned}

for some \(\eta=o(1)\). Here the second inequality is due to Lemma 2.1. Then,

& =\exp \left(-\left(1+\eta^{\prime}\right) \frac{\mathrm{SNR}^{2}}{8}\right)
\end{aligned}

for some other \(\eta^{\prime}=o(1)\), where we use \(\mathrm{SNR}^{2} / \log k \rightarrow \infty\).
The proof for the case \(\mathrm{SNR}=O(1)\) is similar and hence is omitted here.

\subsection*{5.2 Proofs for The Upper Bound}

In this section, we will prove Theorem 2.2 using the framework developed in [8] for analyzing iterative algorithms. The key idea to establish statistical guarantees of the proposed iterative algorithm (i.e., Algorithm 1) is to perform a "one-step" analysis. That is, assume we have an estimation \(z\) for \(z^{*}\). Then we can apply (7), (8), and (9) on \(z\) to obtain \(\left\{\hat{\theta}_{a}(z)\right\}_{a \in[k]}, \hat{\Sigma}(z)\), and \(\hat{z}(z)\) sequentially, which all depend on \(z\). Then \(\hat{z}(z)\) can be seen as a refined estimation of \(z^{*}\). We will first build the connection between \(\ell\left(z, z^{*}\right)\) with \(\ell\left(\hat{z}(z), z^{*}\right)\) as in Lemma 5.1. To establish the connection, we will decompose the loss \(\ell\left(\hat{z}(z), z^{*}\right)\) into several errors according to the difference in their behaviors. Then we will give conditions (Condition 5.2.1-5.2.3), under which we will show these errors are either negligible or well controlled by \(\ell\left(z, z^{*}\right)\). With Lemma 5.1 established, in Lemma 5.2 we will show the connection can be extended to multiple iterations, under two more conditions (Condition 5.2.4-5.2.5). Last, we will show all these conditions hold with high probability, and hence prove Theorem 2.2.

In the statement of Theorem 2.2, the covariance matrix \(\Sigma^{*}\) is assumed to satisfy \(\lambda_{d}\left(\Sigma^{*}\right) / \lambda_{1}\left(\Sigma^{*}\right)=\) \(O(1)\). Without loss of generality, we can replace it by assuming \(\Sigma^{*}\) satisfies

where \(\lambda_{\text {min }}, \lambda_{\max }>0\) are two constants. This is due to the following simple argument using the scaling properties of normal distributions. Let \(\left\{Y_{j}\right\}\) be some dataset generated according to Model 1 with parameters \(\left\{\theta_{a}^{*}\right\}_{a \in[k]}, \Sigma^{*}\), and \(z^{*}\). The assumption \(\lambda_{d}\left(\Sigma^{*}\right) / \lambda_{1}\left(\Sigma^{*}\right)=O(1)\) is equivalent to assume there exist some constants \(\lambda_{\text {min }}, \lambda_{\max }>0\) and some quantity \(\sigma>0\) that may depend on \(n\) such that \(\lambda_{\min } \sigma^{2} \leq \lambda_{1}\left(\Sigma^{*}\right) \leq \lambda_{d}\left(\Sigma^{*}\right) \leq \lambda_{\max } \sigma^{2}\). Then performing a scaling transformation we obtain another dataset \(Y_{j}^{\prime}=Y_{j} / \sigma\). Note that: 1) \(\left\{Y_{j}^{\prime}\right\}\) can be seen to be generated from Model 1 with parameters \(\left\{\theta_{a}^{*} / \sigma\right\}_{a \in[k]}, \Sigma^{*} / \sigma^{2}\), and \(z^{*}, 2\) ) clustering on \(\left\{Y_{j}\right\}\) is equivalent to clustering on \(\left\{Y_{j}^{\prime}\right\}\), 3) by the definition in (2), the SNRs that are associated with the data generating processes of \(\left\{Y_{j}^{\prime}\right\}\)
and \(\left\{Y_{j}\right\}\) are exactly equal to each other, and 4) we have \(\lambda_{\min } \leq \lambda_{1}\left(\Sigma^{*} / \sigma^{2}\right) \leq \lambda_{d}\left(\Sigma^{*} / \sigma^{2}\right) \leq \lambda_{\max }\). Hence, in this section, we will assume (15) holds and it will not lose any generality.

In the proof, we will mainly use the loss \(\ell(\cdot, \cdot)\) for convenience. Recall \(\Delta\) is defined as the minimum distance among centers in (3). We have

The algorithmic guarantees Lemma 5.1 and Lemma 5.2 are established with respect to the \(\ell(\cdot, \cdot)\) loss. But eventually we will use (16) to convert it into a result with respect to \(h(\cdot, \cdot)\) in the proof of Theorem 2.2.

Error Decomposition for the One-step Analysis: Consider an arbitrary \(z \in[k]^{n}\). Apply (7), (8), and (9) on \(z\) to obtain \(\left\{\hat{\theta}_{a}(z)\right\}_{a \in[k]}, \hat{\Sigma}(z)\), and \(\hat{z}(z)\) :

For simplicity we use \(\hat{z}\) that is short for \(\hat{z}(z)\). Let \(j \in[n]\) be an arbitrary index with \(z_{j}^{*}=a\). According to (9), \(z_{j}^{*}\) will be incorrectly estimated after on iteration in \(\hat{z}_{j}\) if \(a \neq \operatorname{argmin}_{a \in[k]}\left(Y_{j}-\right.\) \(\left.\hat{\theta}_{a}(z)\right)^{T}(\hat{\Sigma}(z))^{-1}\left(Y_{j}-\hat{\theta}_{a}(z)\right)\). That is, it is important to analyze the event

Here \(\left\langle\epsilon_{j},\left(\hat{\Sigma}\left(z^{*}\right)\right)^{-1}\left(\hat{\theta}_{a}\left(z^{*}\right)-\hat{\theta}_{b}\left(z^{*}\right)\right)\right\rangle \leq-\frac{1}{2}\left\langle\theta_{a}^{*}-\theta_{b}^{*},\left(\Sigma^{*}\right)^{-1}\left(\theta_{a}^{*}-\theta_{b}^{*}\right)\right\rangle\) is the main term that will lead to the optimal rate. Among all the remaining terms, \(F_{j}(a, b, z)\) includes all terms involving \(\epsilon_{j} . G_{j}(a, b, z)\) includes all terms related to \(z\) and \(H_{j}(a, b, z)\) consists of terms that only involves \(z^{*}\). Readers can refer [8] for more information about the decomposition.

Conditions and Guarantees for One-step Analysis. To establish the guarantee for the onestep analysis, we first give several conditions on the error terms \(F_{j}(a, b ; z), G_{j}(a, b ; z)\) and \(H_{j}(a, b ; z)\).

Conditions and Guarantees for Multiple Iterations. In the above we establish a statistical guarantee for the one-step analysis. Now we will extend the result to multiple iterations. That is, starting from some initialization \(z^{(0)}\), we will characterize how the losses \(\ell\left(z^{(0)}, z^{*}\right), \ell\left(z^{(1)}, z^{*}\right)\), \(\ell\left(z^{(2)}, z^{*}\right), \ldots\), decay. We impose a condition on \(\xi_{\text {ideal }}(\delta)\) and a condition for \(z^{(0)}\).

Recall that in (15) we assume \(\lambda_{\min } \leq \lambda_{1}\left(\Sigma^{*}\right) \leq \lambda_{d}\left(\Sigma^{*}\right) \leq\) \(\lambda_{\max }\) for two constants \(\lambda_{\min }, \lambda_{\max }>0\). Hence we have \(\Delta\) is in the same order of SNR. Specifically, we have

-\left\langle\theta_{a}^{*}-\theta_{b}^{*},\left(\hat{\Sigma}\left(z^{*}\right)\right)^{-1}\left(\theta_{a}^{*}-\theta_{b}^{*}\right)\right\rangle+\left\langle\theta_{a}^{*}-\theta_{b}^{*},\left(\Sigma^{*}\right)^{-1}\left(\theta_{a}^{*}-\theta_{b}^{*}\right)\right\rangle \lesssim \sqrt{\frac{k(d+\log n)}{n}}\left\|\theta_{a}^{*}-\theta_{b}^{*}\right\|^{2}
\]

Using the results above we can get (19).
Finally we are going to establish (21). Recall the definition of \(G_{j}(a, b, z)\) which has four terms. For the third and fourth terms, we have

Proof. Under the conditions of Theorem 2.2, the inequalities (33)-(38) hold with probability at least \(1-n^{-C^{\prime}}\). In the remaining proof, we will work on the event these inequalities hold. Recall the definition of \(\xi_{\text {ideal }}\), we can write

& \leq \sum_{j=1}^{n} \sum_{b \in[k] \backslash\left\{z_{j}^{*}\right\}}\left\|\theta_{z_{j}^{*}}^{*}-\theta_{b}^{*}\right\|^{2} \mathbb{I}\left\{C \bar{\delta}\left\|\theta_{z_{j}^{*}}^{*}-\theta_{b}^{*}\right\| \sqrt{\frac{n}{d+\log n}} \leq\left\|w_{j}\right\|\right\} \\

where \(C\) is a constant which may differ line by line. \leq & \exp \left(-\frac{(1-\delta-\bar{\delta})^{2}}{8}\left\langle\theta_{a}^{*}-\theta_{b}^{*},\left(\Sigma^{*}\right)^{-1}\left(\theta_{a}^{*}-\theta_{b}^{*}\right)\right\rangle\right) .

& \leq n \exp \left(-(1+o(1)) \frac{\mathrm{SNR}^{2}}{8}\right) .
\end{aligned}

Overall, we have \(\mathbb{E} \xi_{\text {ideal }} \lesssim n \exp \left(-(1+o(1)) \frac{\text { SNR }^{2}}{8}\right)\). By the Markov's inequality, we have

Notice that \(h\left(z, z^{*}\right)\) takes value in the set \(\{j / n: j \in[n] \cup\{0\}\}\), the term \(4^{-t}\) in the above inequality should be negligible as long as \(4^{-t}=o\left(n^{-1}\right)\). Thus, we can claim

\section*{6 Proofs in Section 3}

\subsection*{6.1 Proofs for The Lower Bound}

Proof of Lemma 3.1. The Neyman-Pearson lemma tells us the likelihood ratio test \(\phi\) is the optimal procedure. Following the proof of Lemma 2.1, we have
\[

& \geq \exp \left(-\frac{1+o(1)}{8} \operatorname{SNR}_{1,2}^{\prime 2}\right)+\exp \left(-\frac{1+o(1)}{8} \operatorname{SNR}_{2,1}^{\prime 2}\right),
\end{aligned}
\]
where the last inequality is by Lemma 7.11.
Proof of Theorem 3.1. The proof is identical to the proof of Theorem 2.1 and is omitted here.

\subsection*{6.2 Proofs for The Upper Bound}

We adopt a similar proof idea as in Section 5.2. We first present an error decomposition for one-step analysis for Algorithm 2. In Lemma 6.1, we show the loss decays after a one-step iteration under Conditions 6.2.1-6.2.6. Then in Lemma 6.2 we extend the result to multiple iterations, under two extra Conditions 6.2.7-6.2.8. Last we show all the conditions are satisfied with high probability and thus prove Theorem 3.2.

In the statement of Theorem 3.2, we assume \(\max _{a, b \in[k]} \lambda_{d}\left(\Sigma_{a}^{*}\right) / \lambda_{1}\left(\Sigma_{b}^{*}\right)=O(1)\) for the covariance matrix \(\left\{\Sigma_{a}^{*}\right\}_{a \in[k]}\). Without loss of generality, we can replace it by assuming \(\Sigma^{*}\) satisfies
\[

\lambda_{\min } \leq \min _{a \in[k]} \lambda_{1}\left(\Sigma_{a}^{*}\right) \leq \max _{a \in[k]} \lambda_{d}\left(\Sigma_{a}^{*}\right) \leq \lambda_{\max } \tag{24}
\end{equation*}
\]
where \(\lambda_{\min }, \lambda_{\max }>0\) are two constants. The is due to the scaling properties of the normal distributions. The reasoning is the same as that of (15) for Model 1 and hence is omitted here. In the remaining of this section, we will assume (24) holds for the covariance matrices.

Error Decomposition for the One-step Analysis: Consider an arbitrary \(z \in[k]^{n}\). Apply (12), (13), and (14) on \(z\) to obtain \(\left\{\hat{\theta}_{a}(z)\right\}_{a \in[k]},\left\{\hat{\Sigma}_{a}(z)\right\}_{a \in[k]}\), and \(\hat{z}(z)\) :

For simplicity we denote \(\hat{z}\) short for \(\hat{z}(z)\). Let \(j \in[n]\) be an arbitrary index with \(z_{j}^{*}=a\). According to (9), \(z_{j}^{*}\) will be incorrectly estimated after on iteration in \(\hat{z}\) if \(a \neq \operatorname{argmin}_{a \in[k]}\left(Y_{j}-\right.\) \(\left.\hat{\theta}_{a}(z)\right)^{T}\left(\hat{\Sigma}_{a}(a)\right)^{-1}\left(Y_{j}-\hat{\theta}_{a}(z)\right)+\log \left|\hat{\Sigma}_{a}(z)\right|\), That is, it is important to analyze the event \(\left\langle Y_{j}-\hat{\theta}_{b}(z),\left(\hat{\Sigma}_{b}(z)\right)^{-1}\left(Y_{j}-\hat{\theta}_{b}(z)\right)\right\rangle+\log \left|\hat{\Sigma}_{b}(z)\right| \leq\left\langle Y_{j}-\hat{\theta}_{a}(z),\left(\hat{\Sigma}_{a}(z)\right)^{-1}\left(Y_{j}-\hat{\theta}_{a}(z)\right)\right\rangle+\log \left|\hat{\Sigma}_{a}(z)\right|\),

Among these terms, \(F_{j}, G_{j}, H_{j}\) are nearly identical to their counterparts in Section 5.2 with \(\hat{\Sigma}(z)\) replaced by \(\hat{\Sigma}_{a}(z)\) or \(\hat{\Sigma}_{b}(z)\). There are three extra terms not appearing in Section 5.2: \(Q_{j}\) is a quadratic term of \(\epsilon_{j}\) and \(K_{j}, L_{j}\) are terms involving matrix determinants.

Conditions and Guarantees for One-step Analysis. To establish the guarantee for the onestep analysis, we first give several conditions on the error terms.

That is, starting from some initialization \(z^{(0)}\), we will characterize how the losses \(\ell\left(z^{(0)}, z^{*}\right), \ell\left(z^{(1)}, z^{*}\right)\), \(\ell\left(z^{(2)}, z^{*}\right), \ldots\), decay. We impose a condition on \(\xi_{\text {ideal }}(\delta)\) and a condition for \(z^{(0)}\).

Since \(a=o(n)\), there exists a constant \(C_{0}\) such that \(2 a \leq C_{0} a \log \frac{n}{a}\). We can take \(t=\tilde{C}\left(a \log \frac{n}{a}+d\right)\) with \(\tilde{C}=\frac{C}{16}-\frac{C_{0}}{4}\), then \(a+2 \sqrt{a t}+2 t \leq \frac{C}{4}\left(a \log \frac{n}{a}+d\right)\). Thus,

& \leq \sum_{a=1}^{s}\binom{n}{a} 9^{d} \exp \left(-\tilde{C}\left(a \log \frac{n}{a}+d\right)\right)

Lemma 7.8. Under the same assumption as in Lemma 7.7, if additional we assume \(k d=O(\sqrt{n})\) and \(\tau=o(n / k)\), there exists some constant \(C>0\) only depending on \(\alpha, \lambda_{\min }, \lambda_{\max }, C^{\prime}\) such that

Proof. By (43) we have \(\max _{a \in[k]}\left\|\hat{\Sigma}_{a}\left(z^{*}\right)\right\|, \max _{a \in[k]}\left\|\left(\hat{\Sigma}_{a}\left(z^{*}\right)\right)^{-1}\right\| \lesssim 1\). By (44) we also have \(\max _{a \in[k]}\left\|\hat{\Sigma}_{a}(z)\right\|, \max _{a \in[k]}\left\|\left(\hat{\Sigma}_{a}(z)\right)^{-1}\right\| \lesssim 1\). Hence,

\max _{a \in[k]}\left\|\left(\hat{\Sigma}_{a}(z)\right)^{-1}-\left(\hat{\Sigma}_{a}\left(z^{*}\right)\right)^{-1}\right\| & \leq \max _{a \in[k]}\left\|\left(\hat{\Sigma}_{a}\left(z^{*}\right)\right)^{-1}\right\|\left\|\hat{\Sigma}_{a}(z)-\hat{\Sigma}_{a}\left(z^{*}\right)\right\|\left\|\left(\hat{\Sigma}_{a}(z)\right)^{-1}\right\| \\
& \lesssim \frac{k \sqrt{n \ell\left(z, z^{*}\right)}}{n \Delta}+\frac{k}{n} \ell\left(z, z^{*}\right)+\frac{k d}{n \Delta} \sqrt{\ell\left(z, z^{*}\right)} . \tag{54}
\end{align*}
\]

Lemma 7.9. Let \(W_{i} \stackrel{i i d}{\sim} \chi_{d}^{2}\) for any \(i \in[n]\) where \(n, d\) are positive integers. Then we have

\mathbb{P}\left(\sum_{i=1}^{n} W_{i}^{2} \geq 3 n d^{2}\right) \leq \frac{4}{n d} .

Proof. We have \(\mathbb{E} \sum_{i=1}^{n} W_{i}^{2}=n d(d+2)\) and \(\mathbb{E} \sum_{i=1}^{n} W_{i}^{4}=n d(d+2)(d+4)(d+6)\). Then we have \(\operatorname{Var}\left(\sum_{i=1}^{n} W_{i}^{2}\right)=8 n d(d+2)(d+3)\). Then we obtain the desired result by Chebyshev's inequality.

We first prove the upper bound. Denote \(\Xi_{a, b}=\theta_{a}^{*}-\theta_{b}^{*}\). Since we have assumed SNR \(^{\prime} \rightarrow \infty\), we have that \(0 \notin \mathcal{B}_{a, b}\). Note that we have an equivalent expression of \(\mathcal{B}_{a, b}\) :

We consider the following scenarios.
(1). If \(\lambda_{1}\left(\Sigma_{a}^{* \frac{1}{2}} \Sigma_{b}^{*-1} \Sigma_{a}^{* \frac{1}{2}}-I\right) \geq 0\), we have \(\left|\Sigma_{a}^{*}\right| \geq\left|\Sigma_{b}^{*}\right|\). Let \(y=0\), we can know \(-\left(\Sigma_{a}^{*}\right)^{-\frac{1}{2}} \Xi_{a, b} \in\) \(\mathcal{B}_{a, b}\). This tells us \(\operatorname{SNR}_{a, b}^{\prime} \leq\left\|-\left(\Sigma_{a}^{*}\right)^{-\frac{1}{2}} \Xi_{a, b}\right\| \leq \lambda_{\text {min }}^{-1 / 2}\left\|\Xi_{a, b}\right\|\).
(2). If \(\lambda_{1}\left(\Sigma_{a}^{* \frac{1}{2}} \Sigma_{b}^{*-1} \Sigma_{a}^{* \frac{1}{2}}-I\right) \leq-1\), let \(A:=\Sigma_{a}^{* \frac{1}{2}} \Sigma_{b}^{*-1} \Sigma_{a}^{* \frac{1}{2}}-I\) and assume \(U^{T} A U=V\), where \(U\) is an orthogonal matrix and \(V:=\operatorname{diag}\left\{v_{1}, \cdots, v_{d}\right\}\) is a diagonal matrix with diagonal elements \(v_{1} \leq v_{2} \leq \cdots \leq v_{d}\) and \(v_{1} \leq-1\). = & 2 z_{1} \tau_{1}+v_{1} z_{1}^{2}-\log \left|\Sigma_{a}^{*}\right|+\log \left|\Sigma_{b}^{*}\right|-\Xi_{a, b}^{T}\left(\Sigma_{a}^{*}\right)^{-1} \Xi_{a, b} \\
\leq & -2 \sqrt{d \log \frac{\lambda_{\max }}{\lambda_{\min }}}\left|\tau_{1}\right|-d \log \frac{\lambda_{\max }}{\lambda_{\min }}-\log \left|\Sigma_{a}^{*}\right|+\log \left|\Sigma_{b}^{*}\right|-\Xi_{a, b}^{T}\left(\Sigma_{a}^{*}\right)^{-1} \Xi_{a, b} \\
\leq & 0 .
\end{aligned}
\]

It means \(-\left(\Sigma_{a}^{*}\right)^{-\frac{1}{2}} \Xi_{a, b}+y \notin \mathcal{B}_{a, b}\) and hence \(\operatorname{SNR}_{a, b}^{\prime} \leq\left\|-\left(\Sigma_{a}^{*}\right)^{-\frac{1}{2}} \Xi_{a, b}\right\|+\|y\|\). Then Thus we have \(\mathrm{SNR}_{a, b}^{\prime} \leq\left\|-\left(\Sigma_{a}^{*}\right)^{-\frac{1}{2}} \Xi_{a, b}\right\|+\sqrt{d \log \frac{\lambda_{\text {max }}}{\lambda_{\text {min }}}} \leq \lambda_{\text {min }}^{-1 / 2}\left\|\Xi_{a, b}\right\|+\sqrt{d \log \frac{\lambda_{\text {max }}}{\lambda_{\text {min }}}}\).
(3). If \(-1<\lambda_{1}\left(\Sigma_{a}^{* \frac{1}{2}} \Sigma_{b}^{*-1} \Sigma_{a}^{* \frac{1}{2}}-I\right)<0\), we still use the notations in scenario (2). Notice that \(\Sigma_{a}^{* \frac{1}{2}} \Sigma_{b}^{*-1} \Sigma_{a}^{* \frac{1}{2}}=A+I\), we have

Now we take \(z_{1}=-\operatorname{sign}\left(\tau_{1}\right) \sqrt{\frac{3}{2} d}\) and \(z_{i}=0\) for \(i \geq 2\), then we have

& 2 y^{T}\left(\Sigma_{a}^{*}\right)^{-\frac{1}{2}} \Xi_{a, b}+y^{T}\left(\Sigma_{a}^{* \frac{1}{2}} \Sigma_{b}^{*-1} \Sigma_{a}^{* \frac{1}{2}}-I\right) y-\log \left|\Sigma_{a}^{*}\right|+\log \left|\Sigma_{b}^{*}\right|-\Xi_{a, b}^{T}\left(\Sigma_{a}^{*}\right)^{-1} \Xi_{a, b} \\
= & 2 z_{1} \tau_{1}+v_{1} z_{1}^{2}-\log \left|\Sigma_{a}^{*}\right|+\log \left|\Sigma_{b}^{*}\right|-\Xi_{a, b}^{T}\left(\Sigma_{a}^{*}\right)^{-1} \Xi_{a, b} \\
\leq & -2\left|\tau_{1}\right| \sqrt{\frac{3}{2}} d-\Xi_{a, b}^{T}\left(\Sigma_{a}^{*}\right)^{-1} \Xi_{a, b} \\
\leq & 0 .
\end{aligned}
\]

Thus we have \(\operatorname{SNR}_{a, b}^{\prime} \leq\left\|-\left(\Sigma_{a}^{*}\right)^{-\frac{1}{2}} \Xi_{a, b}\right\|+\sqrt{\frac{3}{2} d} \leq \lambda_{\text {min }}^{-1 / 2}\left\|\Xi_{a, b}\right\|+\sqrt{\frac{3}{2} d}\).
Overall, we have \(\operatorname{SNR}_{a, b}^{\prime} \leq \lambda_{\text {min }}^{-1 / 2}\left\|\Xi_{a, b}\right\|+\sqrt{\frac{3}{2}} d+\sqrt{d \log \frac{\lambda_{\max }}{\lambda_{\text {min }}}}\) for all the three scenarios.
To prove the lower bound, we have

& \geq-\frac{\sqrt{\lambda_{\max }}}{\lambda_{\min }}\|x\|\left\|\Xi_{a, b}\right\|-\frac{1}{2}\left(\frac{\lambda_{\max }}{\lambda_{\min }}+1\right)\|x\|^{2} .

In the following lemmas, we are going to establish connections between testing errors and \(\left\{\operatorname{SNR}_{a, b}^{\prime}\right\}_{a \neq b}\). Consider any \(a, b \in[k]\) such that \(a \neq b\). Let \(\eta \sim \mathcal{N}\left(0, I_{d}\right), \Xi_{a, b}=\theta_{a}^{*}-\theta_{b}^{*}\), and \(\Delta_{a, b}=\left\|\Xi_{a, b}\right\|\). & \left.\leq-\frac{1-\delta}{2} \Xi_{a, b}^{T}\left(\Sigma_{b}^{*}\right)^{-1} \Xi_{a, b}+\frac{1}{2} \log \left|\Sigma_{a}^{*}\right|-\frac{1}{2} \log \left|\Sigma_{b}^{*}\right|\right\}
\end{aligned}

for any \(\delta \in \mathbb{R}\). In addition, we define

Recall the definitions of \(\mathcal{B}_{a, b}\) and \(\operatorname{SNR}_{a, b}^{\prime}\) in Section 3. Then they are a special case of \(\mathcal{B}_{a, b}(\delta)\) and \(\operatorname{SNR}_{a, b}^{\prime}(\delta)\) with \(\delta=0\). That is, we have \(\mathcal{B}_{a, b}=\mathcal{B}_{a, b}(0)\) and \(\operatorname{SNR}_{a, b}^{\prime}=\operatorname{SNR}_{a, b}^{\prime}(0)\).
Lemma 7.10. Assume \(d=O(1)\) and \(\lambda_{\min } \leq \lambda_{1}\left(\Sigma_{a}^{*}\right), \lambda_{1}\left(\Sigma_{b}^{*}\right) \leq \lambda_{d}\left(\Sigma_{a}^{*}\right), \lambda_{d}\left(\Sigma_{b}^{*}\right) \leq \lambda_{\max }\) where \(\lambda_{\min }, \lambda_{\max }>0\) are constants. Under the condition \(S N R_{a, b}^{\prime} \rightarrow \infty\), for any positive sequence \(\delta=o(1)\), there exists a \(\tilde{\delta}=o(1)\) that depends on \(\delta, d, \Delta_{a, b}, \lambda_{\min }, \lambda_{\max }\) such that

P_{a, b}(\delta) \leq \exp \left(-\frac{1-\tilde{\delta}}{8} S N R_{a, b}^{\prime 2}\right)
\]

Proof. For convenience and conciseness, we will use the notation \(\theta_{a}, \theta_{b}, \Sigma_{a}, \Sigma_{b}\) instead of \(\theta_{a}^{*}, \theta_{b}^{*}, \Sigma_{a}^{*}, \Sigma_{b}^{*}\) throughout the proof. By Lemma 6.3, we have \(\mathrm{SNR}_{a, b}^{\prime}\) in the same order of \(\Delta_{a, b}\), which means \(\Delta_{a, b} \rightarrow \infty\).

Assume we had obtained \(\operatorname{SNR}_{a, b}^{\prime}(\delta) \geq(1-o(1)) \operatorname{SNR}_{a, b}^{\prime}\). Then by Lemma 6.3, we have \(\operatorname{SNR}_{a, b}^{\prime}(\delta)\) in the same order of \(\Delta_{a, b}\) which is far bigger than \(d\) by assumption. Since \(\|\eta\|^{2} \sim \chi_{d}^{2}\), using Lemma 7.1, we have

which is the desired result. Hence, the proof of this lemma is all about establishing \(\operatorname{SNR}_{a, b}^{\prime}(\delta) \geq\) ( \(1-o(1)) \mathrm{SNR}_{a, b}^{\prime}\).

To prove it, we first simplify \(\operatorname{SNR}_{a, b}^{\prime}(\delta)\). In spite of some abuse of notation, denote \(\lambda_{1} \leq \ldots \leq \lambda_{d}\) to be the eigenvalues of \(\Sigma_{a}^{\frac{1}{2}}\left(\Sigma_{b}\right)^{-1} \Sigma_{a}^{\frac{1}{2}}-I_{d}\) such that its eigen-decomposition can be written as \(\Sigma_{a}^{\frac{1}{2}}\left(\Sigma_{b}\right)^{-1} \Sigma_{a}^{\frac{1}{2}}-I_{d}=\sum_{i=1}^{d} \lambda_{i} u_{i} u_{i}^{T}\), where \(\left\{u_{i}\right\}\) are orthogonal vectors. Denote \(U=\left(u_{1}, \ldots, u_{d}\right)\) and

v=U^{T} \Sigma_{a}^{\frac{1}{2}} \Sigma_{b}^{-1} \Xi_{a, b}
\]
and
\[
\mathcal{B}_{a, b}^{\prime}(\delta)=\left\{y \in \mathbb{R}^{d}: \sum_{i} y_{i} v_{i}+\frac{1}{2} \sum_{i} \lambda_{i} y_{i}^{2} \leq-\frac{1-\delta}{2} \Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b}+\frac{1}{2} \log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|}\right\} .
\]

Then \(\mathcal{B}_{a, b}^{\prime}(\delta)\) can be seen a reflection-rotation of \(\mathcal{B}_{a, b}(\delta)\) by the transformation \(y=U^{t} x\). Hence we have \(\operatorname{SNR}_{a, b}^{\prime}(\delta)=\min _{y \in \mathcal{B}_{a, b}^{\prime}(\delta)} 2\|y\|\) for any \(\delta\). What is more, let \(\overline{\mathcal{B}}_{a, b}^{\prime}(\delta)\) to be its boundary, i.e.,

Since \(0 \notin \mathcal{B}_{a, b}^{\prime}(\delta)\), we have \(\operatorname{SNR}_{a, b}^{\prime}(\delta)=2 \min _{y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta)}\|y\|\) As a result, we only need to work on \(\overline{\mathcal{B}}_{a, b}^{\prime}(\delta)\) instead of \(\mathcal{B}_{a, b}(\delta)\). Denote \(\overline{\mathcal{B}}_{a, b}^{\prime}\) to be \(\overline{\mathcal{B}}_{a, b}^{\prime}(0)\) for simplicity.

We then give an equivalent expression of \(\mathcal{B}_{a, b}^{\prime}(\delta)\). From (55), we have an upper bound of \(\operatorname{SNR}_{a, b}^{\prime}\) : \(\operatorname{SNR}_{a, b}^{\prime} \leq 2 \lambda_{\text {min }}^{-1 / 2} \Delta_{a, b}\) where we use \(\Delta_{a, b} \gg \lambda_{\text {min }}, \lambda_{\text {max }}, d\). The same upper bound actually holds for \(\mathcal{B}_{a, b}^{\prime}(\delta)\) for any \(\delta=o(1)\) following the same proof. Define \(S=\left\{y \in \mathbb{R}^{d}:\|y\| \leq 2 \lambda_{\text {min }}^{-1 / 2} \Delta_{a, b}\right\}\). We then have

\operatorname{SNR}_{a, b}^{\prime}(\delta)=2 \min _{y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta) \cap S}\|y\| .
\]

We have the following inequality. Let \(g(y): \overline{\mathcal{B}}_{a, b}(\delta) \rightarrow \overline{\mathcal{B}}_{a, b}(0)\) be any mapping. By the triangle inequality, we have \(\|y\| \geq\|g(y)\|-\|y-g(y)\|\). We have

& \geq \min _{y \in \overline{\mathcal{B}_{a, b}^{\prime}}(\delta) \cap S}(\|g(y)\|-\|y-g(y)\|) \\
& \geq \min _{y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta) \cap S}\|g(y)\|-\max _{y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta) \cap S}\|y-g(y)\| \\
& \geq \min _{y \in \overline{\mathcal{B}}_{a, b}^{\prime}(0)}\|y\|-\max _{y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta) \cap S}\|y-g(y)\| \\
& \geq \operatorname{SNR}_{a, b}^{\prime}-\max _{y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta) \cap S}\|y-g(y)\| . \tag{56}
\end{align*}
\]

As a result, if we are able to find some \(g\) such that \(\max _{y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta) \cap S}\|y-g(y)\|=o(1) \mathrm{SNR}_{a, b}^{\prime}\), we will immediately have \(\operatorname{SNR}_{a, b}^{\prime}(\delta) \geq(1-o(1)) \mathrm{SNR}_{a, b}^{\prime}\) and the proof will be complete.

Let \(w \in \mathbb{R}^{d}\) be some vector. Define \(g(y)=y+w \operatorname{argmin}_{t \in \mathbb{R}: y+t w \in \overline{\mathcal{B}}_{a, b}^{\prime}}|t|\). If \(g(y)\) is a well-defined mapping, we have

However, to make \(g(y)\) well-defined, we need for any \(y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta) \cap S\), there exits some \(t \in \mathbb{R}\) such that \(y+t w \in \overline{\mathcal{B}}_{a, b}^{\prime}\). This means we have the following two equations:

& \text { and } \sum_{i}\left(y_{i}+t w_{i}\right) v_{i}+\frac{1}{2} \sum_{i} \lambda_{i}\left(y_{i}+t w_{i}\right)^{2}=-\frac{1}{2} \Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b}+\frac{1}{2} \log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|} .
\end{align*}

It is equivalent to require \(t\) to satisfy

t \sum_{i}\left(w_{i} v_{i}+\lambda_{i} y_{i} w_{i}\right)+\frac{t^{2}}{2} \sum_{i} \lambda_{i} w_{i}^{2}=-\frac{\delta}{2} \Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b} . \tag{59}
\end{equation*}
\]

Hence, all we need is to find a decent vector \(w\) such that: for any \(y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta) \cap S\) there exists a \(t\) satisfying (59), and we can obtain the desired upper bound for (57).

In the following, we will consider four different scenarios according to the spectral \(\left\{\lambda_{i}\right\}\). For each scenario, we will construct a \(w\) with decent bounds for (57). Denote \(\delta^{\prime}=\sqrt{\delta}\).

Scenario 1: \(\left|\lambda_{1}\right|,\left|\lambda_{d}\right| \leq \delta^{\prime}\). We choose \(w=v /\|v\|\). Note that we have \(\|v\|\) in the same order of \(\Delta_{a, b}\) and \(\left\|\Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b}\right\|\) in the same order of \(\Delta_{a, b}^{2}\). Note that we have

t \sum_{i}\left(w_{i} v_{i}+\lambda_{i} y_{i} w_{i}\right)+\frac{t^{2}}{2} \sum_{i} \lambda_{i} w_{i}^{2} & \leq t\|v\|+|t|\|y\| \sqrt{\sum_{i} \lambda_{i}^{2} w_{i}^{2}}+\frac{t^{2}}{2} \sum_{i} \lambda_{i} w_{i}^{2} \\
& \leq t\|v\|+|t| \delta^{\prime}\|y\|+\frac{t^{2} \delta^{\prime}}{2} \\
& \leq t\|v\|+2|t| \delta^{\prime} \lambda_{\min }^{-1 / 2} \Delta_{a, b}+\frac{t^{2} \delta^{\prime}}{2}
\end{aligned}
\]
where in the last inequality we use \(y \in S\). Define \(t_{0}=-\delta^{1 / 2} \Delta_{a, b}\). Then we have

Hence for any \(y \in S\) there exists a \(t \in\left(t_{0}, 0\right)\) such that (59) is satisfied. Hence, \(\left|t_{0}\right|=\delta^{1 / 2} \Delta_{a, b}\) is an upper bound for (57).

Scenario 2: \(\lambda_{1}<-\delta^{\prime}\). We choose \(w=e_{1}\) which is the first standard basis of \(\mathbb{R}^{d}\). Then, (59) can be written as

Scenario 3: \(\lambda_{1} \geq-\delta^{\prime}\) and there exists a \(j \in[d]\) such that \(\lambda_{j} \leq \delta^{\prime}\) and \(\left|v_{j}\right| \geq \sqrt{\delta^{\prime}} \Delta_{a, b}\). We choose \(w=e_{j}\). Then (59) can be written as

Note that for any \(y \in S\), we have \(\left|v_{j}+\lambda_{j} y_{j}\right| \geq\left|v_{j}\right|-\left|\lambda_{j} y_{j}\right| \geq \sqrt{\delta^{\prime}} \Delta_{a, b}-\delta^{\prime}\left(2 \lambda_{\text {min }}^{-1 / 2} \Delta_{a, b}\right) \geq \sqrt{\delta^{\prime}} \Delta_{a, b} / 2\). Denote \(t_{0}=-\operatorname{sign}\left(v_{j}+\lambda_{j} y_{j}\right) \sqrt{\delta^{\prime}} \Delta_{a, b}\). Then we have

\lambda_{j} t_{0}^{2}+2\left(v_{j}+\lambda_{j} y_{j}\right) t_{0}+\delta \Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b} & =\lambda_{j} \delta^{\prime} \Delta_{a, b}^{2}-\left|v_{j}+\lambda_{j} y_{j}\right| \sqrt{\delta^{\prime}} \Delta_{a, b}+\delta \Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b} \\
& \leq-\left(\frac{\delta^{\prime}}{2}-\delta^{\prime 2}\right) \Delta_{a, b}^{2}+\delta O\left(\Delta_{a, b}^{2}\right) \\
& \leq 0
\end{aligned}
\]

As a result, there exists some \(t \in\left(t_{0}, 0\right)\) satisfying (59). Hence, \(\left|t_{0}\right|=\delta^{\prime 1 / 2} \Delta_{a, b}\) is an upper bound for (57).

Scenario 4: \(\lambda_{1} \geq-\delta^{\prime}\) and \(\left|v_{j}\right|<\sqrt{\delta^{\prime}} \Delta_{a, b}\) for all \(j \in[d]\) such that \(\lambda_{j} \leq \delta^{\prime}\). This scenario is slightly more complicated as we need \(w\) to be dependent on \(y\). Denote it as \(w(y)\). Then (56) still holds and (57) can be changed into

Denote \(m \in[d]\) to be the integer such that \(\lambda_{j} \leq \delta^{\prime}\) for all \(j \leq m\) and \(\lambda_{j}>\delta^{\prime}\) for all \(j>m\). We can have \(m<d\) otherwise this scenario can be reduced to Scenario 1. Define

Note that we have \(\left(y_{i}+v_{i} / \lambda_{i}\right)(1-t)=[g(y)]_{i}+v_{i} / \lambda_{i}\) for \(i>m\) and \([g(y)]_{i}=y_{i}\) for \(i \leq m\). Then the above display can be written as

\end{equation*}

then there definitely exists some \(0<t<t_{0}\) satisfying (62).

We are going to give a lower bound for the right hand side of (63). Particularly, we need to lower bound \(\sum_{i>m} \frac{v_{i}^{2}}{\lambda_{i}}-\Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b}\). Denote \(\tilde{y}=U^{T}\left(-\Sigma_{a}^{-1 / 2} \Xi_{a, b}\right)\). Then using the definition of \(v\) and \(\left\{\lambda_{i}\right\}\), we have

& \geq \Xi_{a, b}^{T} \Sigma_{a}^{-1} \Xi_{a, b}+\log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|}-8\left(\sqrt{\delta^{\prime}} \sqrt{d} \lambda_{\min }^{-\frac{1}{2}} \Delta_{a, b}^{2}+\delta^{\prime} \lambda_{\min }^{-1} \Delta_{a, b}^{2}\right) \\
& \geq \Xi_{a, b}^{T} \Sigma_{a}^{-1} \Xi_{a, b}+\log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|}-16 \sqrt{\delta^{\prime} d} \lambda_{\min }^{-\frac{1}{2}} \Delta_{a, b}^{2}, \tag{65}

where we use both \(\tilde{y}, y \in S\) and the assumption that \(\left|v_{i}\right| \leq \sqrt{\delta^{\prime}} \Delta_{a, b}\) and \(\left|\lambda_{i}\right| \leq \delta^{\prime}\) for any \(i \leq m\). Then a sufficient condition for (63) is \(t_{0}\) satisfies

Since \(\Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b}\) is in the same order of \(\Delta_{a, b}^{2}\) and \(\log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|} \lesssim d=O(1)\), it can be achieved by \(t_{0}=\sqrt{\delta}\).

Combining the above four scenarios, we can see we all have \(\max _{y \in \overline{\mathcal{B}}_{a, b}^{\prime}(\delta) \cap S}\|y-g(y)\| \lesssim \delta^{\frac{1}{4}} \Delta_{a, b}\) which is \(o(1) \mathrm{SNR}_{a, b}^{\prime}\). By the argument before the discussion of the four scenarios, we have \(\operatorname{SNR}_{a, b}^{\prime}(\delta) \geq\) \((1-o(1)) \mathrm{SNR}_{a, b}^{\prime}\) and the proof is complete.

Under the condition \(S N R_{a, b}^{\prime} \rightarrow \infty\), for any positive sequence \(\delta=o(1)\), there exists a \(\tilde{\delta}=o(1)\) that depends on \(d, \Delta_{a, b}, \lambda_{\min }, \lambda_{\max }\) such that

Similar to the proof of Lemma 7.10 , denote \(\lambda_{1} \leq \ldots \leq \lambda_{d}\) to be the eigenvalues of \(\Sigma_{a}^{\frac{1}{2}}\left(\Sigma_{b}\right)^{-1} \Sigma_{a}^{\frac{1}{2}}-I_{d}\) such that its eigen-decomposition can be written as \(\Sigma_{a}^{\frac{1}{2}}\left(\Sigma_{b}\right)^{-1} \Sigma_{a}^{\frac{1}{2}}-I_{d}=\) \(\sum_{i=1}^{d} \lambda_{i} u_{i} u_{i}^{T}\), where \(\left\{u_{i}\right\}\) are orthogonal vectors. Denote \(U=\left(u_{1}, \ldots, u_{d}\right), v=U^{T} \Sigma_{a}^{\frac{1}{2}} \Sigma_{b}^{-1} \Xi_{a, b}\). Then denote

\overline{\mathcal{B}}_{a, b}^{\prime}=\left\{y \in \mathbb{R}^{d}: \sum_{i} y_{i} v_{i}+\frac{1}{2} \sum_{i} \lambda_{i} y_{i}^{2}=-\frac{1}{2} \Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b}+\frac{1}{2} \log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|}\right\} .
\]

By the same argument as in the proof of Lemma \(7.10, \mathcal{B}_{a, b}^{\prime}\) can be seen a reflection-rotation of \(\mathcal{B}_{a, b}\) by the transformation \(y=U^{t} x\). Hence we have \(\operatorname{SNR}_{a, b}^{\prime}=\min _{y \in \mathcal{B}_{a, b}^{\prime}} 2\|y\|\) and we can work on \(\mathcal{B}_{a, b}^{\prime}\) instead of \(\mathcal{B}_{a, b}\). Denote \(\bar{y} \in \mathcal{B}_{a, b}^{\prime}\) to be the one such that \(2\|\bar{y}\|=\operatorname{SNR}_{a, b}^{\prime}\). From the proof of Lemma 7.10 we also know \(\bar{y} \in S\) which is defined as \(S=\left\{y \in \mathbb{R}^{d}:\|y\| \leq 2 \lambda_{\min }^{-1 / 2} \Delta_{a, b}\right\}\). In addition, we know \(\bar{y} \in \overline{\mathcal{B}}_{a, b}^{\prime}\).

We first give the main idea of the remaining proof. Denote \(p(y)\) to be the density function of \(y \sim \mathcal{N}\left(0, I_{d}\right)\) We will construct a set \(T \subset \mathbb{R}^{d}\) around \(\bar{y}\) such that for any \(y \in T\) we have \(y \in \mathcal{B}_{a, b}^{\prime}\) and \(\|y-\bar{y}\|=o\left(\Delta_{a, b}\right)\). Then we have
\[
\begin{align*}
P_{1,2}(0) & \geq|T| \inf _{y \in T} p(y)=|T| \frac{1}{(2 \pi)^{\frac{d}{2}}} \exp \left(-\frac{1}{2} \max _{y \in T}\|y\|^{2}\right) \\
& =|T| \frac{1}{(2 \pi)^{\frac{d}{2}}} \exp \left(-(1+o(1)) \frac{\operatorname{SNR}_{a, b}^{\prime 2}}{8}\right) . \tag{66}
\end{align*}
\]

Hence if \(\log |T|=o\left(\mathrm{SNR}_{a, b}^{\prime}\right)\) then the proof will be complete. So it is all about constructing such \(T\). We will consider four scenarios same as in the proof of Lemma 7.10. Let \(\delta=o(1)\) be some positive sequence going to 0 very slowly and denote \(\delta^{\prime}=\sqrt{\delta}\).

Scenario 1: \(\left|\lambda_{1}\right|,\left|\lambda_{d}\right| \leq \delta^{\prime}\). Define \(w=v /\|v\|\). We define \(T\) as follows:
\[
T=\left\{y=\bar{y}+s:\left\|\left(I_{d}-w w^{T}\right) s\right\| \leq \delta^{\prime}\left|w^{T} s\right|, w^{T} s \in\left[-\delta \Delta_{a, b}, 0\right]\right\} .
\]

Since \(\bar{y} \in \overline{\mathcal{B}}_{a, b}^{\prime}\), we have
\[
\begin{equation*}
\sum_{i} \bar{y}_{i} v_{i}+\frac{1}{2} \sum_{i} \lambda_{i} \bar{y}_{i}^{2}=-\frac{1}{2} \Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b}+\frac{1}{2} \log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|} . \tag{67}
\end{equation*}
\]

It is obvious \(\max _{y \in T}\|y-\bar{y}\| \leq 2 \delta \Delta_{a, b}\). Hence we only need to show that for any \(y \in T, y \in \mathcal{B}_{a, b}^{\prime}\), i.e.,
\[
\begin{equation*}
\sum_{i}\left(\bar{y}_{i}+s_{i}\right) v_{i}+\frac{1}{2} \sum_{i} \lambda_{i}\left(\bar{y}_{i}+s_{i}\right)^{2} \leq-\frac{1}{2} \Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b}+\frac{1}{2} \log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|} \tag{68}
\end{equation*}
\]

From the above two displays, we need to show
\[
\begin{equation*}
2 \sum_{i} s_{i} v_{i}+\sum_{i} \lambda_{i} s_{i}^{2}+2 \sum_{i} \lambda_{i} \bar{y}_{i} s_{i} \leq 0 \tag{69}
\end{equation*}
\]

Note that \(s\) satisfies \(\|s\| \leq 2\left|w^{T} s\right|\).
\[
\begin{aligned}
2 \sum_{i} s_{i} v_{i}+\sum_{i} \lambda_{i} s_{i}^{2}+2 \sum_{i} \lambda_{i} \bar{y}_{i} s_{i} & \leq 2\|v\| w^{T} s+\delta^{\prime}\|s\|^{2}+\delta^{\prime}\|\bar{y}\|\|s\| \\
& \leq 2\|v\| w^{T} s+\delta^{\prime}\left|w^{T} s\right|^{2}+\delta^{\prime}\|\bar{y}\|\left|w^{T} s\right| \\
& =\left|w^{T} s\right|\left(-2\|v\|+\delta^{\prime}\left|w^{T} s\right|+\delta^{\prime}\|\bar{y}\|\right) \\
& \leq 0
\end{aligned}
\]
where we use the fact that \(\|v\|,\|\bar{y}\|\) are in the order of \(\Delta_{a, b}\). Hence, for any \(y \in T\), we have shown \(y \in \mathcal{B}_{a, b}^{\prime}\). From Lemma 7.12, we have \(|T| \geq \exp \left(d \log \frac{\delta \delta^{\prime} \Delta_{a, b}}{4}-\frac{d}{2} \log d\right)\). Since \(d=O(1), \Delta_{a, b} \rightarrow \infty\), and \(\delta\) goes to 0 slowly, (66) leads to \(P_{1,2}(0) \geq \exp \left(-(1+o(1)) \frac{\mathrm{SNR}_{a, b}^{\prime 2}}{8}\right)\).
Scenario 2: \(\lambda_{1}<-\delta^{\prime}\). Denote \(e_{1}\) the first standard basis in \(\mathbb{R}^{d}\). Define \(T\) as
\[
T=\left\{y=\bar{y}+s:\left\|\left(I_{d}-e_{1} e_{1}^{T}\right) s\right\| \leq \delta\left|e_{1}^{T} s\right|, \operatorname{sign}\left(v_{1}+\lambda_{1} \bar{y}_{1}\right) e_{1}^{T} s \in\left[-2 \delta^{\frac{1}{4}} \Delta_{a, b},-\delta^{\frac{1}{4}} \Delta_{a, b}\right]\right\}
\]

Here for the sign function we define \(\operatorname{sign}(0)=1\). It is obvious \(\max _{y \in T}\|y-\bar{y}\| \leq 2 \delta \Delta_{a, b}\). Hence we only need to establish (69) to show that for any \(y \in T, y \in \mathcal{B}_{a, b}^{\prime}\). Note that
\[
\begin{aligned}
2 \sum_{i} s_{i} v_{i} & +\sum_{i} \lambda_{i} s_{i}^{2}+2 \sum_{i} \lambda_{i} \bar{y}_{i} s_{i}=2 s_{1}\left(v_{1}+\lambda_{1} \bar{y}_{1}\right)+\lambda_{1} s^{2}+2 \sum_{i \geq 2} s_{i}\left(v_{i}+\lambda_{i} \bar{y}_{i}\right)+2 \sum_{i \geq 2} \lambda_{i} s_{i}^{2} \\
& \leq 2 s_{1}\left(v_{1}+\lambda_{1} \bar{y}_{1}\right)+\lambda_{1} s^{2}+2\left\|\left(I-e_{1} e_{1}^{T}\right) s\right\|\left(\|v\|+\max _{j}\left|\lambda_{j}\right|\|\bar{y}\|\right)+2 \max _{j}\left|\lambda_{j}\right|\left\|\left(I-e_{1} e_{1}^{T}\right) s\right\|^{2} \\
& \leq\left(\lambda_{1}+\delta^{2} \max _{j}\left|\lambda_{j}\right|\right) s_{1}^{2}-2\left|v_{1}+\lambda_{1} \bar{y}_{1}\right|\left|s_{1}\right|+2\left(\|v\|+\max _{j}\left|\lambda_{j}\right|\|\bar{y}\|\right) \delta\left|s_{1}\right| \\
& \leq-\frac{\delta^{\prime}}{2} s_{1}^{2}+O\left(\Delta_{a, b}\right) \delta\left|s_{1}\right|
\end{aligned}
\]
where we use \(\max _{j}\left|\lambda_{j}\right|=O(1)\) and \(\|v\|,\|\bar{y}\|\) are in the order of \(\Delta_{a, b}\). It is easy to verify the right hand side is negative when \(s_{1} \in\left[-2 \delta^{\frac{1}{4}} \Delta_{a, b},-\delta^{\frac{1}{4}} \Delta_{a, b}\right]\). From Lemma 7.12 , we have \(|T| \geq\) \(\exp \left(d \log \frac{\delta^{\frac{5}{4}} \Delta_{a, b}}{4}-\frac{d}{2} \log d\right)\). Then (66) leads to the desired result.
Scenario 3: \(\lambda_{1} \geq-\delta^{\prime}\) and there exists a \(j \in[d]\) such that \(\lambda_{j} \leq \delta^{\prime}\) and \(\left|v_{j}\right| \geq \sqrt{\delta^{\prime}} \Delta_{a, b}\). Denote \(e_{j}\) the \(j\) th standard basis in \(\mathbb{R}^{d}\). Define \(T\) as
\[
T=\left\{y=\bar{y}+s:\left\|\left(I_{d}-e_{j} e_{j}^{T}\right) s\right\| \leq \delta^{\prime}\left|e_{j}^{T} s\right|, \operatorname{sign}\left(v_{j}+\lambda_{j} \bar{y}_{j}\right) e_{j}^{T} s \in\left[-\delta \Delta_{a, b}, 0\right]\right\}
\]

Again define \(\operatorname{sign}(0)=1\) and it is obvious \(\max _{y \in T}\|y-\bar{y}\| \leq 2 \delta \Delta_{a, b}\). Now we are going to verify (69), i.e., to show \(\lambda_{j} s_{j}^{2}+2 s_{j}\left(v_{j}+\lambda_{j} \bar{y}_{j}\right) \leq-\sum_{i \neq j} \lambda_{i} s_{i}^{2}-2 \sum_{i \neq j} s_{i}\left(v_{i}+\lambda_{i} \bar{y}_{i}\right)\). On one hand, we have
\[
\begin{aligned}
\lambda_{j} s_{j}^{2}+2 s_{j}\left(v_{j}+\lambda_{j} \bar{y}_{j}\right) & =\lambda_{j} s_{j}^{2}-2\left|s_{j}\right|\left|v_{j}+\lambda_{j} \bar{y}_{j}\right| \\
& \leq-\delta^{\prime} \delta \Delta_{a, b}\left|s_{j}\right|-2\left(\sqrt{\delta^{\prime}} \Delta_{a, b}-\delta^{\prime} O\left(\Delta_{a, b}\right)\right)\left|s_{j}\right| \\
& \leq-\sqrt{\delta^{\prime}} \Delta_{a, b}\left|s_{j}\right|
\end{aligned}
\]

One the other hand, we have
\[
\begin{aligned}
-\sum_{i \neq j} \lambda_{i} s_{i}^{2}-2 \sum_{i \neq j} s_{i}\left(v_{i}+\lambda_{i} \bar{y}_{i}\right) & \geq-\max _{j}\left|\lambda_{j}\right|\left\|\left(I-e_{j} e_{j}^{T}\right) s\right\|^{2}-2\left\|\left(I-e_{j} e_{j}^{T}\right) s\right\|\left(\|v\|+\max _{j}\left|\lambda_{j}\right|\|\bar{y}\|\right) \\
& \geq-\max _{j}\left|\lambda_{j}\right| \delta^{\prime} 2\left|s_{j}\right|^{2}-2 \delta^{\prime}\left|s_{j}\right|\left(\|v\|+\max _{j}\left|\lambda_{j}\right|\|\bar{y}\|\right) \\
& \geq-2 \delta^{\prime}\left(\delta \Delta_{a, b} \max _{j}\left|\lambda_{j}\right|+\|v\|+\max _{j}\left|\lambda_{j}\right|\|\bar{y}\|\right)\left|s_{j}\right| \\
& \geq-2 \delta^{\prime} O\left(\Delta_{a, b}\right)\left|s_{j}\right| \\
& \geq-\sqrt{\delta^{\prime}} \Delta_{a, b}\left|s_{j}\right|
\end{aligned}
\]
we use \(\max _{j}\left|\lambda_{j}\right|=O(1)\) and \(\|v\|,\|\bar{y}\|\) are in the order of \(\Delta_{a, b}\). Hence (69) is established. From Lemma 7.12, we have \(|T| \geq \exp \left(d \log \frac{\delta \delta^{\prime} \Delta_{a, b}}{4}-\frac{d}{2} \log d\right)\). Then (66) leads to the desired result.

Scenario 4: \(\lambda_{1} \geq-\delta^{\prime}\) and \(\left|v_{j}\right|<\sqrt{\delta^{\prime}} \Delta_{a, b}\) for all \(j \in[d]\) such that \(\lambda_{j} \leq \delta^{\prime}\). Denote \(m \in[d]\) to be the integer such that \(\lambda_{j} \leq \delta^{\prime}\) for all \(j \leq m\) and \(\lambda_{j}>\delta^{\prime}\) for all \(j>m\). We can have \(m<k\) otherwise this scenario can be reduced to Scenario 1.

Define \(w \in \mathbb{R}^{d}\) to be unit vector such that
\[
w_{i}=\left\{\begin{array}{l}
\frac{\lambda_{i} \bar{y}_{i}+v_{i}}{\sqrt{\sum_{j>m}\left(\lambda_{j} \bar{y}_{j}+v_{j}\right)^{2}}}, \text { for all } i>m \\
0, \text { o.w.. }
\end{array}\right.
\]

Define
\[
T=\left\{y=\bar{y}+s:\left\|\left(I_{d}-w w^{T}\right) s\right\| \leq \delta^{\prime}\left|w^{T} s\right|, w^{T} s \in\left[-\delta \Delta_{a, b}, 0\right]\right\}
\]

Now we are going to verify (69), i.e., to show \(2 \sum_{i>m} s_{i}\left(v_{i}+\lambda_{i} \bar{y}_{i}\right)+\sum_{i} \lambda_{i} s_{i}^{2}+2 \sum_{i \leq m} s_{i}\left(v_{i}+\lambda_{i} \bar{y}_{i}\right) \leq 0\). On one hand, we have
\[
\begin{aligned}
2 \sum_{i>m} s_{i}\left(v_{i}+\lambda_{i} \bar{y}_{i}\right) & =2 \sqrt{\sum_{j>m}\left(v_{j}+\lambda_{j} \bar{y}_{j}\right)^{2}} \sum_{i>m} s_{i} w_{i}=-2 \sqrt{\sum_{j>m}\left(v_{j}+\lambda_{j} \bar{y}_{j}\right)^{2}}\left|w^{T} s\right| \\
& \leq-2 \sqrt{\delta^{\prime}} \sqrt{\sum_{j>m}\left(\bar{y}_{j}+\frac{v_{j}}{\lambda_{j}}\right)^{2}}\left|w^{T} s\right| .
\end{aligned}
\]

We are going to give a lower bound for \(\sum_{j>m}\left(\bar{y}_{j}+\frac{v_{j}}{\lambda_{j}}\right)^{2}\). Note that (67) can be written as
\[
\sum_{i>m} \lambda_{i}\left(\bar{y}_{i}+\frac{v_{i}}{\lambda_{i}}\right)^{2}=\sum_{i>m} \frac{v_{i}^{2}}{\lambda_{i}}-\Xi_{a, b}^{T} \Sigma_{b}^{-1} \Xi_{a, b}+\log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|}-\left(2 \sum_{i \leq m} \bar{y}_{i} v_{i}+\sum_{i \leq m} \lambda_{i} \bar{y}_{i}^{2}\right) .
\]

Denote \(\tilde{y}=U^{T}\left(-\Sigma_{a}^{-1 / 2} \Xi_{a, b}\right)\). Using (64), we have
\[
\begin{aligned}
\sum_{i>m} \lambda_{i}\left(\bar{y}_{i}+\frac{v_{i}}{\lambda_{i}}\right)^{2} & \geq \Xi_{a, b}^{T} \Sigma_{a}^{-1} \Xi_{a, b}+\left(2 \sum_{i \leq m} \tilde{y}_{i} v_{i}+\sum_{i \leq m} \lambda_{i} \tilde{y}_{i}^{2}\right)+\log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|}-\left(2 \sum_{i \leq m} \bar{y}_{i} v_{i}+\sum_{i \leq m} \lambda_{i} \bar{y}_{i}^{2}\right) \\
& \geq \Xi_{a, b}^{T} \Sigma_{a}^{-1} \Xi_{a, b}+\log \frac{\left|\Sigma_{a}\right|}{\left|\Sigma_{b}\right|}-16 \sqrt{\delta^{\prime} d} \lambda_{\min }^{-\frac{1}{2}} \Delta_{a, b}^{2}, \\
& \geq C \Delta_{a, b}^{2},
\end{aligned}
\]
for some constant \(C>0\). Here the second inequality is by the same argument as (65) and the last inequality uses the fact that \(\Xi_{a, b}^{T} \Sigma_{a}^{-1} \Xi_{a, b}\) is in the order of \(\Delta_{a, b}^{2}\) and \(d=O(1)\). Hence,
\[
\sum_{i>m} \lambda_{i}\left(\bar{y}_{i}+\frac{v_{i}}{\lambda_{i}}\right)^{2} \leq-2 \sqrt{C \delta^{\prime}} \Delta_{a, b}\left|w^{T} s\right|
\]

On the other hand, we have
\[
\begin{aligned}
\sum_{i} \lambda_{i} s_{i}^{2}+2 \sum_{i \leq m} s_{i}\left(v_{i}+\lambda_{i} \bar{y}_{i}\right) & \leq \max _{j}\left|\lambda_{j}\right|\|s\|^{2}+2 \sqrt{\sum_{i \leq m} s_{i}^{2}}\left(\|v\|+\max _{j}\left|\lambda_{j}\right|\|\bar{y}\|\right) \\
& \leq 2 \max _{j}\left|\lambda_{j}\right|\left|w^{T} s\right|^{2}+2\left(\|v\|+\max _{j}\left|\lambda_{j}\right|\|\bar{y}\|\right)\left\|\left(I-w w^{T}\right) s\right\| \\
& \leq 2\left(\max _{j}\left|\lambda_{j}\right| \delta \Delta_{a, b}+\delta^{\prime}\left(\|v\|+\max _{j}\left|\lambda_{j}\right|\|\bar{y}\|\right)\right)\left|w^{T} s\right| \\
& \leq O\left(\delta^{\prime} \Delta_{a, b}\right)\left|w^{T} s\right|,
\end{aligned}
\]
where we use the properties of \(s\) as \(y \in T\). Summing the above two displays together, we have (69) satisfied. From Lemma 7.12, we have \(|T| \geq \exp \left(d \log \frac{\delta \delta^{\prime} \Delta_{a, b}}{4}-\frac{d}{2} \log d\right)\). Then (66) leads to the desired result.

Lemma 7.12. Consider any positive integer \(d\) and any \(0<r<1, t>0\). Define a set \(T=\) \(\left\{y \in \mathbb{R}^{d}:\left(\sum_{i \geq 2} y_{i}^{2}\right)^{1 / 2} \leq r\left|y_{1}\right|, y_{1} \in[-2 t,-t]\right\}\). Then we have
\[
|T| \geq \exp \left(d \log \frac{r t}{2}-\frac{d}{2} \log d\right) .
\]

Proof. Define a \(d\)-dimensional ball \(B=\left\{y \in \mathbb{R}^{d}:\left(y_{1}+1.5 t\right)^{2}+\sum_{i \geq 2} y_{i}^{2} \leq(r t / 2)^{2}\right\}\). We can easily verify that \(B \in T\). First, for all \(y \in B\), we have \(y_{1} \in[-2 t,-t]\) as \(r \in(0,1)\). Then, we have \(\left(\sum_{i \geq 2} y_{i}^{2}\right)^{1 / 2} \leq r t / 2 \leq r\left|y_{1}\right|\). As a result, by the expression of the volume of a \(d\)-dimensional ball, we have
\[
|T| \geq|B|=\frac{\pi^{\frac{d}{2}}}{\Gamma\left(\frac{d}{2}+1\right)}\left(\frac{r t}{2}\right)^{d} \geq \frac{1}{d^{\frac{d}{2}}}\left(\frac{r t}{2}\right)^{d}=\exp \left(d \log \frac{r t}{2}-\frac{d}{2} \log d\right)
\]
where \(\Gamma(\cdot)\) is the Gamma function.
