# Gauge Symmetry Origin of Bäcklund Transformations for Painlevé Equations

#### Abstract

We identify the self-similarity limit of the second flow of $\operatorname{sl}(N) \mathrm{mKdV}$ hierarchy with the periodic dressing chain thus establishing a connection to $A_{N-1}^{(1)}$ invariant Painlevé equations. The $A_{N-1}^{(1)}$ Bäcklund symmetries of dressing equations and Painlevé equations are obtained in the self-similarity limit of gauge transformations of the mKdV hierarchy realized as zero-curvature equations on the loop algebra $\widehat{s l}(N)$ endowed with a principal gradation.


## 1 Introduction

We study the integrable mKdV hierarchy on the loop algebra of $s l(N)=A_{N-1}$ endowed with a principal gradation. We show that the second $t=t_{2}$ flow of this hierarchy realized as a zero-curvature equation becomes in the self-similarity limit the dressing chain invariant under the extended affine Weyl group $A_{N-1}^{(1)}$ that gives rise to $A_{N-1}^{(1)}$ invariant Painlevé equations for all $N$ after imposing the periodicity condition. For $N=3$ and $N=4$ cases the corresponding Painlevé equations are well-known as Painlevé IV and V equations and their relations to the self-similarity limit of the $s l(N) \mathrm{mKdV}$ equation was established in [17.

In this paper we present an explicit and straightforward construction of the dressing chain and Painlevé equations in terms of $m K d V$ objects in the self-similarity limit. One advantage of the zero-curvature approach is that it naturally allows for formulation of the Bäcklund symmetries as gauge transformations that preserve the algebraic structure of the gauge potentials, see [9] and references therein. Here we utilize gauge symmetries of the zero-curvature equations defined on the loop algebra of $s l(N)$ to derive the Bäcklund symmetries of the extended affine Weyl group $A_{N-1}^{(1)}$ in the context of Painlevé equations including higher-order Painlevé equations that follow from the associated integrable structure.

In order to obtain our results we connect several observations made by various researchers coincidentally around the same time. In 1993, the periodic dressing chain and its Hamilton formalism appeared as the main focus of study [21] in the context of the spectral theory of the Schrödinger operators. Its symmetry group was shown in [1 to be isomorphic to the extended affine Weyl group $A_{N-1}^{(1)}$ thus clearing the way to establishing
equivalence of periodic dressing chains [19, 22, 20, 18] with the corresponding Painlevé systems invariant under the same $A_{N-1}^{(1)}$ symmetry groups [16]. There were other contemporary observations that now can be understood as related to these breakthroughs and remarkably made in the same year. In [17] the first non-trivial equation of $\operatorname{sl}(N)$ mKdV model was given and shown to give rise to Painlevé equations for $N=3,4$ in the self-similarity limit. In the very same year some of the authors of this paper pointed out the existence of discrete Bäcklund transformations leading to Hirota type equations for the Toda chain of tau-functions [8]. Generalization of this construction [7] to generalized Volterra lattice of symmetry transformation gave rise to an alternative construction of $A_{N}^{(1)}$ invariant Painlevé systems [6] defined for integrable systems with a different gradation than the principal gradation used throughout this paper.

Here we are able to explicitly tie several of these observations into an unified approach by realizing the self-similarity limit of the second flow of $\operatorname{sl}(N) \mathrm{mKdV}$ hierarchy as $N$ periodic dressing chain with its parameter $\alpha=\sum_{i=1}^{N} \alpha_{i}$ taking values $N / 2$ or zero, and derive the extended affine Weyl group $A_{N-1}^{(1)}$ from gauge symmetry of the second flow in the self-similarity limit.

The paper is organized as follows. In Section 2 we present the zero curvature approach to the $\operatorname{sl}(N) \mathrm{mKdV}$ hierarchy and use it to explicitly derive its second flow that is identified in Section 3 with the dressing chain and $A_{N-1}^{(1)}$ invariant Painlevé equations in the selfsimilarity limit. In Section 4 we formulate the Bäcklund symmetries of hierarchy equations as a class of gauge transformations that maintain the matrix form of the potentials $A_{\mu}, \mu=$ $x, t$ that enter the zero-curvature equations of the integrable hierarchy. In Subsection 4.2 these gauge transformations are shown to give rise to the extended affine Weyl symmetry of Painlevé equations. The class of gauge symmetry generators we are working with is such that each such generator can be factorized into a product of maximum $N-1$ matrices depending on only one single parameter. Such one-parameter gauge matrix can in turn be identified with a generator of the extended affine Weyl group $A_{N-1}^{(1)}$. As discussed in the next section 5 such construction further extends explicit invariance under $A_{N-1}^{(1)}$ obtained from Bäcklund gauge symmetries to all higher-order Painlevé equations [10] that appear in the self-similarity limits of higher flows of the mKdV integrable hierarchy. These flows are conveniently labeled as $t_{n N+k}$ with $k=1, \ldots, N-1$ and $n=0,1, \ldots$ (see formula (A.9) for an underlying graded structure behing this labeling). We illustrate this invariance for the mKdV hierarchy with flows $t_{2 n+1}$ for $N=2, k=1$ and $n=1,2,3$. Explicitly we will work with $t_{3}, t_{5}$ and $t_{7}$ flows of the mKdV hierarchy and the associated Painlevé equations of order order 2,4 and 6 that are all invariant under the same $A_{1}^{(1)}$ Weyl group symmetry as consequence of invariance of zero curvature representation under Bäcklund gauge transformation.

In Section 6, that provides an outlook, we discuss the modification of the dressing chain that maintains the Kovalevskaya-Painlevé property together with the part of its Bäcklund symmetry. This relates to the program that we have pursued in several papers [3, 4, 5] attempting to connect integrability to the remaining symmetry of Painlevé models that survives the partial breaking of the extended affine Weyl group $A_{N-1}^{(1)}$ by deformation terms that preserve some notion of integrability.

Some background material on the $\operatorname{sl}(N)$ algebra and technical details of deriving the Painlevé equations out of the dressing chain are given in the two appendices to ensure the paper being self-contained.

## 2 Zero-Curvature approach to mKdV equations

We will be working with a loop algebra of $\operatorname{sl}(N)$ endowed with a principal gradation as defined in (A.7) of Appendix A, where we provide brief account of $\operatorname{sl}(N)$ Lie algebra, its roots, fundamental weights, and its loop algebra $\widehat{s l}(N)$ generalization, that all constitute
algebraic foundation of zero-curvature formulation of the $s l(N) \mathrm{mKdV}$ flows. The starting point of the zero-curvature construction is the semi-simple $\widehat{s l}(N)$ element of grade one

We refer the reader to Appendix for definitions of basic matrices $E_{\alpha_{a}}, \ldots, E_{\alpha_{a}+\ldots+\alpha_{b}}, a, b=$ $1, \ldots, N-1$.

The $t_{m}$ flow of $s l(N) \mathrm{mKdV}$ hierarchy is given by solving the following zero-curvature equation:

where $D^{(i)} \in \mathcal{G}_{i}$ (see Appendix $\mathbb{A}$ for definition of $\mathcal{G}_{i}$ ) are to be solved for. Further

is a diagonal element of grade zero that satisfies the trace zero condition $\sum_{k=1}^{N} J_{k}=0$. The elements $h_{\alpha_{k}}$ of the Cartan subalgebra are defined in Appendix A. The following relations:

hold between $v_{k}, k=1, \ldots, N-1$ and $J_{i}, i=1, \ldots, N$. The relation $v_{i}=\sum_{j=1}^{i} J_{j}$ follows from (2.3) and is highly reminiscent of relation (A.5) between fundamental weights $\Lambda^{i}$ and $e_{j}$ vectors.

With $\widehat{s l}(N)$ being endowed with the grading structure (A.8) the zero-curvature equation (2.2) can be decomposed into separate equations according to their grade. The highest grade component of equation (2.2), $\left[E^{(1)}, D^{(m)}\right]=0$, is solved by the grade $m$ element $D^{(m)}$ in the kernel of $E^{(1)}$. From now on we will focus on the case of $m=2$ for which it follows that,

The lower grade matrices $D^{(i)}, i=0,1$ can be solved recursively from the appropriate grade projections of the zero-curvature equation (2.2). For example, the grade one element,

has coefficients $F_{N}, F_{i}, i=1, \ldots, N-1$ :

as determined by the grade 2 component of the zero-curvature equation (2.2):

The grade 1 projection of the zero-curvature equation (2.2):

with $D^{(0)}=\sum_{a=1}^{N-1} d_{a} h_{\alpha_{a}}$, can be cast as a vector equation

representing key objects as $N-1$ vectors. In addition $\mathbf{V}$ denotes the diagonal matrix

and $\mathbf{K}$ is the $(N-1) \times(N-1)$ Cartan matrix given in (A.4).
Solving (2.7) and inserting it into the grade 0 projection of the zero-curvature equation (2.2) determines the flow of the model through equation $\partial_{t} A_{0}=\partial_{x} D^{(0)}$, with $t \equiv t_{2}$, that reads in vector notation as :

After multiplying both sides of relation (2.9) by the Cartan matrix $\mathbf{K}$ and making use of relation (2.7) we obtain:

Recalling the identities (2.6) and (2.8) the above equation (2.10) can be rewritten as:

that defines $t_{2}$ flows of $s l(N) \mathrm{mKdV}$ hierarchy in agreement with the result given earlier in [17]. From equation (2.11) one can derive a flow for an individual $J_{m}$ as

## 3 Self-similarity limit and $A_{N-1}^{(1)}$ Painlevé Equations

Introducing the self-similarity limit through relations

\end{equation*}

one obtains in such limit from equations (2.11) after an integration :

with $\gamma_{i}$ being integration constants that satisfy $\sum_{i=1}^{N} \gamma_{i}=0$ and where we introduced the periodicity condition $J_{N+i}=J_{i}$.

Define now:

with the zero trace condition $\sum_{k=1}^{N} J_{k}=0$ replaced by

and impose periodicity condition:

In this notation and with $\alpha_{i}=\gamma_{i}+\frac{1}{2}$, such that $\sum_{i=1}^{N} \alpha_{i}=N / 2$, equations (3.2) simplify to:

in which we recognize the dressing chain equation 21].
There is also an alternative way of obtaining the dressing chain equation (3.6) from the $t_{2}$-flow (2.11) of the $s l(N) \mathrm{mKdV}$ hierarchy that employs the traveling wave reduction:

Here $C$ is a constant representing speed of a wave. We find that such reduction yields the same differential system (3.6), but with the major difference being that the summation of $j_{i}$ now yields a constant:

and therefore the sum of all $N$ equations (3.6) is:

This is the case of $\alpha \equiv \sum_{i=1}^{N} \alpha_{i}=0$ for which the periodic dressing chain admits a parametric dependent Lax representation [21]. Equation (3.6) with condition (3.9) for $N=3$ yields $I_{30}$ (denoted as equation XXX in [15]) as shown in [3]. See reference [2] for relation between equation (3.6) with condition (3.9) for $N=4$ and $I_{38}$ (equation XXXVIII in (15).

Define now

then due to identities shown in Appendix B it follows that equation (3.6) becomes in this new notation

for $N=2 k+1$ odd and with conditions $\sum_{i=1}^{N} f_{i}=N z / 2$ and $\sum_{i=1}^{N} \alpha_{i}=N / 2$. Equation (3.11) reproduces $A_{N-1}^{(1)}$ Painlevé equations for $N$ odd. For even $N=2 n$ we obtain from (3.6)

reproducing $A_{2 n-1}^{(1)}=A_{N-1}^{(1)}$ Painlevé equations with conditions

\sum_{r=1}^{n} f_{i+2 r}=\sum_{r=1}^{n} f_{i+2 r+1}=\frac{n}{2} z . \tag{3.13}

We notice that equations (3.6) are manifestly invariant under order- $N$ automorphisms:

In the next section we will obtain the remaining Bäcklund symmetries by employing the gauge transformations of the zero-curvature equations.

## 4 Gauge transformations of $\operatorname{sl}(N) \mathbf{m K d V}$ zerocurvature equations

### 4.1 Introducing the gauge transformation, its basic properties and parameters

Below we will discuss symmetries of equations (3.6) derived from gauge transformation of the $\widehat{s l}(N)$ zero-curvature equation (2.2) compactly rewritten as

The term $D^{(2)}$ is given in (2.4), $D^{(1)}$ in (2.5) and $D^{(0)}=\sum_{a=1}^{N-1} d_{a} h_{\alpha_{a}}$ is such that its matrix elements satisfy the second-flow equation $\partial_{t} v_{i}=\partial_{x} d_{i}$. We will now discuss the gauge symmetries of equation (4.1) that preserve the matrix form of potentials $A_{x}, A_{t}$ and will be shown to reproduce the Bäcklund symmetries of Painlevé equations in the self-similarity limit. In the setting of (4.1) we will explore invariance of (2.11) under the gauge transformation

or

where $U=U(\tilde{J}, J)$ maps from $J_{i}$ configuration to another one denoted by $\tilde{J}_{i}$, while preserving the zero-curvature equation.

We will work with the gauge transformations that has been previously constructed to produce Bäcklund transformations in the context of $s l(N) m K d V$ hierarchy [9] (see also [14] for the associated relativistic Toda model) to be of the form, $U=I+U_{-1}$, where $I$ is the identity matrix and $U_{-1}$ is a grade -1 element of $\widehat{s l}(N)$ :

where $\beta_{i}(x, t), i=1, \ldots, N$ are coefficients parameterizing grade -1 component of $\widehat{s l}(N)$ and will be determined by imposing (4.3) as a graded equation.

For convenience we employed above a notation that expresses explicitly the dependence of gauge transformation $U$ on the parameters $\beta_{i}$ which in turn, depend upon the original and the transformed configurations, $\{J\}$ and $\{\tilde{J}\}$ respectively.

We now consider matrix elements of both sides of relation (4.3) and derive differential equations for the gauge parameters $\beta_{i}$ that follow from them. Plugging expression for the matrix $U$ into equation (4.3) with $\mu=x$ and considering its diagonal ( $i, i$ ) element we obtain an expression :

for the transformed configuration of $\tilde{J}_{i}$ in terms of $J_{i}$ and the $\beta_{i}$ coefficients of $U\left(\beta_{1}, \ldots, \beta_{N}\right)$. The $(i+1, i)$ element of (4.3) with $\mu=x$ is given by

Integrating (4.6) yields :

\beta_{1}=B_{1}(t) e^{\int\left(J_{1}-\tilde{J}_{2}\right) d x}, \cdots, \beta_{i}=B_{i}(t) e^{\int\left(J_{i}-\tilde{J}_{i+1}\right) d x}, \cdots, \beta_{N}=B_{N}(t) e^{\int J_{N}-\tilde{J}_{1} d x} \tag{4.7}
\end{equation*}
$$

where we indicated explicitly that $B_{i}$-coefficients do not depend on $x$ but may depend on the $t$ variable. However considering the $(i+1, i)$ element of (4.3) with $\mu=t$ we obtain :
$(i+1, i): \quad \partial_{t} \partial_{x} \ln \beta_{i}=\partial_{t}\left(J_{i}-\tilde{J}_{i+1}\right) \rightarrow \beta_{i}=B_{i}(x) \exp \int\left(J_{i}-\tilde{J}_{i+1}\right) d x, i=1, \ldots, N-1$
We thus conclude that all coefficients $B_{i}$ are constants as is consequently the product of all $\beta_{i}$ :

which shows that there are in fact only $N-1$ independent $\beta$-parameters.
For diagonal elements of (4.3) for $\mu=t$ we obtain :

d_{1}-\tilde{d}_{1}+\beta_{N} F_{N}-\beta_{1} \tilde{F}_{1} & =0  \tag{4.10}\\
d_{N-1}-\tilde{d}_{N-1}+\beta_{N} \tilde{F}_{N}-\beta_{N-1} F_{N-1} & =0
\end{align*}
$$

Next we use that $\partial_{x} d_{i}=\partial_{t} v_{i}$ and $\tilde{v}_{i}=v_{i}+\beta_{N}-\beta_{i}$ with $F_{i}, F_{N}$ defined in (2.6) and accordingly transforming as $\tilde{F}_{i}=F_{i}+\beta_{i-1}-\beta_{i+1}$, to obtain from (4.10) that the quantities

are always equal to each other:

A composition law may be derived by acting successively with $U(\tilde{J}, J)$ to transform from $J$ to $\tilde{J}$, followed by $\tilde{J} \rightarrow \tilde{\tilde{J}}$ transformation, $U(\tilde{\tilde{J}}, \tilde{J})$. It therefore follows the composite gauge transformation

U(\tilde{\tilde{J}}, J)=U(\tilde{\tilde{J}}, \tilde{J}) U(\tilde{J}, J) \tag{4.13}
\end{equation*}

We start by making a remark concerning matrix

with one parameter $\beta_{i}=0$ being zero. As a matrix it can be represented by an ordered product of matrices $U_{i}$ with only one non-zero parameter $\beta_{i}$ :

In order to maintain the form of the gauge matrix as in equation (4.4) the product must be ordered starting from the right with $U_{i+1}$ ending at $U_{i-1}$ as can be explicitly verified to be,

\end{equation*}

In the next subsection it will be explained that the gauge matrices considered in this section must, in the self-similarity limit, have at least one parameter equal to zero. They all can be represented by an ordered matrix composition in terms of a basis of single gauge matrices $U_{j}$ since the right hand side of equation (4.15) only involves the matrix multiplication of single $U_{i}$ matrices. However each gauge transformation not only acts as a matrix but also as a transformation that obeys the composition rule (4.13). To take into consideration those two actions we will introduce below a "star"-product of two gauge matrices (4.27).

A basis for the Bäcklund transformation can be proposed to consist of generators with only one non-zero coefficient, $\beta_{i} \neq 0, \quad i=1, \cdots N-1$, it holds from the transformation rule (4.5) that $U_{i}$ from (4.14) generates:

U_{i}: \quad J_{i} \rightarrow J_{i}-\beta_{i}, \quad J_{i+1} \rightarrow J_{i+1}+\beta_{i}, \quad J_{j} \rightarrow J_{j}, j \neq i, i+1 \tag{4.16}

with $\beta_{i}$ that satisfies differential equations:

\end{equation*}

due to relations (4.6) and (4.12). Similar relations were derived in [17] by a different method.

### 4.2 Gauge transformations in the self-similarity limit as the extended affine Weyl group symmetries

Recall now the self-similarity limit (3.1) that in accordance with equations (4.5) and (4.6) needs to be augmented by

The self-similarity limit can not be applied consistently to the constant in (4.9) as long it is different from zero since the self-similarity limits of the right and left hand side of equations

will lead to inconsistent limits if all $\beta_{i}(x, t) \neq 0$. Thus at least one of the $B_{i}$ constants will need to vanish for us to be able to take the self-similarity limit. Clearly in such case $\Gamma_{i}=0$ in (4.12) and this equation yields in the scaling limit the following algebraic relations:

where $\kappa_{i}$ are integration constants. Furthermore equation (4.5) becomes in the selfsimilarity limit

\end{equation*}

In the self-similarity limit the choice (4.14) results in constants $b_{i}^{(0)} \neq 0$ and $b_{j}^{(0)}=0, j \neq i$, and we obtain from relations (4.20) that

Let us recall equation (4.18) describing the time flow of $\beta_{i}$ parameter. According to the self-similarity limits (3.1) and (4.19) we obtain from (4.18) :

where we have chosen the integration constant $\kappa_{i}$ to be in agreement with (4.23). We now turn our attention to equation (4.17) that becomes in the self-similarity limit

Plugging relation $b_{i}=\kappa_{i} / f_{i}$ from equation (4.24) into equation (4.25) one obtains

that agrees with the dressing equation (3.6) for $\kappa_{i}=\alpha_{i}$. Indeed it is easy to explicitly verify that the dressing chain equation is invariant under the symmetry operations

& j_{i} \xrightarrow{U_{i}} \tilde{j}_{i}=j_{i}-b_{i}=j_{i}-\frac{\kappa_{i}}{j_{i}+j_{i+1}}, \quad j_{i+1} \xrightarrow{U_{i}} \tilde{j}_{i+1}=j_{i+1}+b_{i}=j_{i+1}+\frac{\kappa_{i}}{j_{i}+j_{i+1}}, \\
& j_{k} \xrightarrow{U_{i}} j_{k}, k \neq i, k \neq i+1 \tag{4.26}
\end{align*}
$$

generated according to transformation rule (4.16) by self-similarity limit counterpart of quantity defined in (4.14) for $\kappa_{i}=\alpha_{i}$, when it is accompanied by transformations of coefficients $\alpha_{i} \rightarrow-\alpha_{i}, \alpha_{i \pm 1} \rightarrow \alpha_{i \pm 1}+\alpha_{i}$. We will derive below these transformations directly from actions of $U_{i}$ matrices (see equations (4.33) and (4.37)). Thus the above transformation induced by the gauge matrix $U_{i}$ from relation (4.14) agrees with known Bäcklund transformations of $A_{N-1}^{(1)}$ Painlevé equations [1].

We will need to define the composition laws for the gauge transformations that will hold when acting with an additional gauge transformation $U(\tilde{\tilde{J}}, \tilde{J})$ following $U(\tilde{J}, J)$ as shown in (4.13). The ordering of equation (4.13) will be important when defining below products of $U_{i}$ from equation (4.14). We now define a "star"-product of two single $U_{i}$ and $U_{k}$ matrices that follows the composition rule (4.13) :

Note that in addition to matrix multiplication between $U_{i}$ and $U_{k}$ (on the right hand side of the above equation), $U_{k}$ simultaneously acts through transformation of all the quantities $b_{i}, j_{i}$ to $\tilde{b}_{i}, \tilde{j}_{i}$ according to

where we used transformation rule (4.21). The following commutation relation follows from (4.28) and from the corresponding rules of matrix multiplication for matrices $U_{i}$ and $U_{k}$ that do not have any neighboring matrix element $b_{i}, b_{k}$ :

We now consider the "star"-product (4.27) with $k=i$ meaning we let $U_{i}\left(b_{i}\right)$ act twice with each $U_{i}$ acting simultaneously through matrix multiplication and through transformation of all the quantities $b_{k}, j_{k}$ to $\tilde{b}_{k}, \tilde{j}_{k}$. Thus the result of performing the gauge transformation twice is $U_{i}\left(b_{i}\right) \star U_{i}\left(b_{i}\right)$ or explicitly :

where $\tilde{b}_{i}=U_{i}\left(b_{i}\right)$ must satisfy equation

\end{equation*}

obtained from equation (4.25) by acting with $U_{i}$. Plugging in the above expression equation (4.25) that amounts to setting $j_{i}-j_{i+1}=\partial_{z} \ln b_{i}+b_{i}$ we get:

Since $\frac{\tilde{b}_{i}}{b_{i}}=\frac{\tilde{\kappa}_{i}}{\kappa_{i}}$ because $\tilde{f}_{i}=f_{i}$, the left hand side of the last equation in (4.31) is zero and consequently

and $\tilde{\kappa}_{i}=-\kappa_{i}$ or $\tilde{\alpha}_{i}=-\alpha_{i}$. It follows now by simple multiplication

with the identity matrix on the right hand side of the above equation. We thus obtain that $U_{i} \star U_{i}=1$ for all $i=1,2, \ldots, N$. We also learn that

\alpha_{i} \xrightarrow{U_{i}}-\alpha_{i} \tag{4.33}
\end{equation*}
$$

Next we will verify that

$$
\begin{equation*}
U_{i i+1} \equiv U\left(0, \ldots, 0, b_{i}, b_{i+1}, 0, \ldots 0\right)=U\left(b_{i}\right) \star U\left(b_{i+1}\right) \tag{4.34}
\end{equation*}
$$

according to the definition given in relations (4.27) and (4.28). Therefore we now consider the $U$-matrix from (4.4) with two neighboring $\beta_{i}, \beta_{i+1}$ that are different from zero and all the other $\beta_{j}=0$. The following equations hold for $\beta$ 's and their self-similarity limits :

\beta_{i, x} & =\beta_{i}\left(-\beta_{i}+\beta_{i+1}+J_{i}-J_{i+1}\right) \quad \rightarrow \quad \partial_{z} \ln b_{i}+b_{i}=b_{i+1}+j_{i}-j_{i+1}, \\
\beta_{i+1, x} & =\beta_{i+1}\left(-\beta_{i+1}+J_{i+1}-J_{i+2}\right) \quad \rightarrow \quad \partial_{z} \ln b_{i+1}+b_{i+1}=j_{i+1}-j_{i+2} \\
\partial_{t} \beta_{i} & =\left(\beta_{i} F_{i}-\beta_{i} \beta_{i+1}\right)_{x} \quad \rightarrow \quad b_{i}=\frac{\kappa_{i}}{f_{i}-\kappa_{i+1} / f_{i+1}},  \tag{4.35}\\
\partial_{t} \beta_{i+1} & =\left(\beta_{i+1} F_{i+1}\right)_{x} \quad \rightarrow \quad b_{i+1}=\frac{\kappa_{i+1}}{f_{i+1}},
\end{align*}
$$

which agree with the dressing equations (3.6) for $f_{i}, f_{i+1}$ for $\kappa_{i+1}=\alpha_{i+1}, \kappa_{i}=\alpha_{i}+\alpha_{i+1}$. Comparing expression for $b_{i}$ given in (4.35) with those in (4.28) that define the $\star$-product (4.27) we find that the relation (4.34) holds.

Further it follows that $U_{i+1}$, as defined in (4.34), with the non-zero neighboring $U$ matrix elements $b_{i}, b_{i+1}$ will induce the following non-zero transformations

f_{i} & \rightarrow \tilde{f}_{i}=f_{i}+b_{i}-1-b_{i+1}=f_{i}-\frac{\alpha_{i+1}}{f_{i+1}} \\
f_{i+1} & \rightarrow \tilde{f}_{i+1}=f_{i+1}+b_{i}-b_{i+2}=f_{i+1}+\frac{\alpha_{i}+\alpha_{i+1}}{f_{i}-\frac{\alpha_{i+1}}{f_{i+1}}} \\
f_{i+2} & \rightarrow \tilde{f}_{i+2}=f_{i+2}+b_{i+1}-b_{i+3}=f_{i+2}+\frac{\alpha_{i+1}}{f_{i+1}}  \tag{4.36}\\
f_{i-1} & \rightarrow \tilde{f}_{i-1}=f_{i-1}+b_{i-2}-b_{i}=f_{i-1}-\frac{\alpha_{i}+\alpha_{i+1}}{f_{i}-\frac{\alpha_{i+1}}{f_{i+1}}}
\end{align*}
$$

where we crossed out those coefficients $b_{i}$ 's that are absent in the $U_{i i+1}$ matrix.
If we now define the $s_{i+1}$ transformation as:

\end{equation*}

together with $s_{i+1}: \alpha_{i} \rightarrow \tilde{\alpha}_{i}=\alpha_{i}+\alpha_{i+1}$, then we can represent the transformation (4.36) as a result of action of $s_{i+1}$ followed by $s_{i}$ transformation:

\tilde{f}_{i+2} & \rightarrow \tilde{f}_{i+2}=f_{i+2}+\frac{\alpha_{i+1}}{f_{i+1}}, \tilde{f}_{i-1} \rightarrow \tilde{f}_{i-1}-\frac{\tilde{\alpha}_{i}}{\tilde{f}_{i}}=f_{i-1}-\frac{\alpha_{i}+\alpha_{i+1}}{f_{i}-\frac{\alpha_{i+1}}{f_{i+1}}}
\end{aligned}
$$

Note also that as follows from relation (4.33) $s_{i}\left(\alpha_{i}\right)=-\alpha_{i}$. Thus the gauge transformation $U_{i i+1}$ agrees with the composite $s_{i} s_{i+1}$ Bäcklund transformation and it follows from this identification by repetitive action with $s_{i} s_{i+1}$ that

More generally the gauge transformation $U\left(0, \ldots, 0, b_{i}, b_{i+1}, \ldots, b_{i+k}, 0, \ldots, 0\right)$ can be factorized into a star-product of one parameter gauge transformations $U_{i}$ that corresponds to the composite $s_{i} s_{i+1} \ldots s_{i+k}$ Bäcklund transformation with relations between $b_{i}$ 's being of the form (for $k=3$ ):

b_{i}=\frac{\kappa_{i}}{\frac{\kappa_{i+1}}{\frac{\kappa_{i+3}}{\overline{k i}_{i}-j_{i} j_{i+3}}-j_{i+2}-j_{i+3}}-j_{i+1}-j_{i+2}}-j_{i}-j_{i+1}

and so on for higher $k$.
The gauge matrices $U\left(0, \ldots, b_{i}, b_{i+1}, \ldots, b_{i+n}, \ldots, 0\right)$ and $U\left(0, \ldots, b_{j}, b_{j+1}, \ldots, b_{j+m}, \ldots, 0\right)$ such that $j+m<i-1$ or $i+n<j-1$ will commute leading to commutation of the Bäcklund transformations $s_{i} \cdots s_{i+n}$ with $s_{j} \cdots s_{j+m}$ under the same conditions.

The key conclusion of this section is that the identities (4.29), (4.38) and (4.32) establish equivalence of the group of gauge transformation endowed with the $\star$-product to the extended affine Weyl group $A_{N-1}^{(1)}$ with its fundamental relations

s_{i}^{2}=1,\left(s_{i} s_{i+1}\right)^{3}=1, s_{i} s_{k}=s_{k} s_{i}, k \neq i \pm 1
$$

that agree with (4.29), (4.38) and (4.32) .
For the remaining part of this subsection we will discuss how that gauge transformations will function in case of the traveling wave limit (3.7). In this limit we obtain

\partial_{x}\left(\beta_{1} \cdots \beta_{N}\right) \rightarrow \partial_{z}\left(b_{1} \cdots b_{N}\right)  \tag{4.39}\\
\partial_{t}\left(\beta_{1} \cdots \beta_{N}\right) \rightarrow-C \partial_{z}\left(b_{1} \cdots b_{N}\right) \tag{4.40}
\end{gather*}
$$

and we conclude that

\partial_{z}\left(b_{1} \cdots b_{N}\right)=0 \tag{4.41}
\end{equation*}
$$

Contrary to the case of the self-similarity limit, the condition $b_{1} \cdots b_{N}=0$ is no longer the only remaining option. From equations (4.17) we find

and combined with relation (4.20) we find that the condition (4.41) has another valid solution apart from $b_{1} \cdots b_{N}=0$, namely that $\kappa_{1} \cdots \kappa_{N}=0$ while $b_{i} \neq 0, i=1, \ldots, N$. Let us set $\kappa_{i-1}=0$, then from relations (4.20) we find a solution:

b_{i-1}=f_{i-1}, b_{i+1}=f_{i}-\frac{\kappa_{i}}{f_{i-1}}, b_{i+2}=f_{i+1}-\frac{\kappa_{i+1}}{f_{i}-\frac{\kappa_{i}}{f_{i-1}}}
$$

etc. Thus in this case we can obtain a solution that has all the coefficients $b_{i} \neq 0$. Will such transformation still be equivalent to a finite product of Bäcklund transformations $s_{i}$ ? To answer this question let us consider for illustration the case of $N=3$ and set $\kappa_{1}=0$. Then the relevant $3 \times 3$ matrix $U\left(b_{1}, b_{2}, b_{3}\right)$ has arguments:

b_{2}=f_{1}, \quad b_{3}=\frac{\kappa_{2}}{f_{1}}+f_{2}, \quad b_{1}=\frac{\kappa_{3}}{\frac{\kappa_{2}}{f_{1}}+f_{2}}+f_{3} \tag{4.43}
\end{equation*}
$$

Recalling that the $b_{i}$ transform the $j_{i}$ according to relation (4.21) we find

\tilde{f}_{1}=\pi\left(f_{1}+\frac{\alpha_{3}}{f_{3}}\right), \tilde{f}_{2}=\pi\left(f_{2}-\frac{\alpha_{3}}{f_{3}}+\frac{\alpha_{1}+\alpha_{2}}{\frac{\alpha_{3}}{f_{3}}+f_{1}}\right), \tilde{f}_{3}=\pi\left(f_{3}-+\frac{\alpha_{1}+\alpha_{2}}{\frac{\alpha_{3}}{f_{3}}+f_{1}}\right), \tag{4.44}
\end{equation*}
$$

using that

$$
\begin{equation*}
\kappa_{2}=\alpha_{1}, \quad \kappa_{3}=\alpha_{1}+\alpha_{2} \tag{4.45}
\end{equation*}
$$

as obtained from plugging the above relations directly back into (3.6). We also get the transformation on the constants $\alpha_{i}$ of (3.6)

$$
\begin{equation*}
\alpha_{1} \rightarrow-\alpha_{1}-\alpha_{2}, \quad \alpha_{2} \rightarrow 2 \alpha_{1}+\alpha_{2}+\alpha_{3}, \quad \alpha_{3} \rightarrow \alpha_{2} \tag{4.46}
\end{equation*}
$$

We see that despite of having all the three $b_{i}$-coefficients different from zero that the transformation $U\left(b_{1}, b_{2}, b_{3}\right)$ obtained in the traveling wave reduction is equivalent to the composition of Bäcklund transformations $\pi s_{3} s_{1}$ that this time involves the automorphism $\pi$ in addition to transformations $s_{i}$. Thus this example confirms that the conclusions obtained in our study of gauge transformations in the self-similarity limit extend mutatis mutandis to the traveling wave reduction.

## 5 Bäcklund transformations for higher flows

In references [12, 13 it was observed that the Bäcklund symmetries obtained out of the gauge symmetries of the zero-curvature equations will hold for all flows of the integrable model. We can here extend this observation to all higher-order Painlevé equations that are derived from these flows. The point we are making here is that the affine extended $A_{N-1}^{(1)}$ Weyl group is the symmetry group for all Painlevé equations that are derived by appropriate similarity transformations from the higher flows of soliton equations. For simplicity we will illustrate this point for $N=2 \mathrm{mKdV}$ hierarchy with the commuting flows $t_{2 n+1}, n=1,2,3, \ldots$. Here we focus at the first three higher times $t_{3}, t_{5}, t_{7}$. For all the flows the $A_{x}$ matrix remains defined by:

A_{x}=\left(\begin{array}{cc}
v & \lambda  \tag{5.1}\\
1 & -v
\end{array}\right)
$$

The gauge matrix $U$ that interpolates between two solutions of the same mKdV model is given by

$$
U=\left(\begin{array}{cc}
1 & \frac{\beta_{2}}{\lambda}  \tag{5.2}\\
\beta_{1} & 1
\end{array}\right)
$$

In the self-similarity limit $U$ generates Bäcklund transformations as described in the previous section.

Following the steps similar to those taken in Section 2 we obtain in the zero-curvature framework the corresponding mKdV equations for the flows $t_{3}, t_{5}, t_{7}$ :

4 v_{t_{3}} & =v_{3 x}-6 v^{2} v_{x}  \tag{5.3}\\
16 v_{t_{5}} & =30 v^{4} v_{x}-10 v^{2} v_{3 x}-40 v v_{x} v_{2 x}-10 v_{x}^{3}+v_{5 x}  \tag{5.4}\\
64 v_{t_{7}}= & -140 v^{6} v_{x}+70 v^{4} v_{3 x}+560 v^{3} v_{x} v_{2 x}+420 v^{2} v_{x}^{3}-14 v^{2} v_{5 x}  \tag{5.5}\\
& -140 v v_{2 x} v_{3 x}-84 v v_{x} v_{4 x}-182 v_{x} v_{2 x}^{2}-126 v_{x}^{2} v_{3 x}+v_{7 x}
\end{align*}
$$

The usual dimensional considerations [11] lead to the following self-similarity limits for $t_{j}=t_{3}, t_{5}, t_{7}:$

\begin{equation*}
v(x, t)=\frac{v(z)}{t_{j}^{1 / j}}, \quad \beta_{i}=\frac{b_{i}(z)}{t_{j}^{1 / j}}, \quad z=\frac{x}{t_{j}^{1 / j}}, \quad j=3,5,7 \tag{5.6}
\end{equation*}
$$

Taking such limit of equation (5.3) (and integrating once) we get the $P_{I I}$ equation:

\begin{equation*}
v_{2 z}(z)=\alpha+2 v^{3}(z)-\frac{4}{3} z v(z), \tag{5.7}
\end{equation*}
$$

where $v_{i z}$ denotes the $i$-th derivative with respect to the argument $z$. From the gauge transformation $U$ we inherit two Bäcklund transformations. The first is given by

v \rightarrow v+b, \quad b=\frac{2-3 \alpha}{-3 v_{z}(z)-3 v^{2}(z)+2 z}, \quad \alpha \rightarrow \frac{4}{3}-\alpha, \tag{5.8}

and squares to identity as follows by inspection.
Since

v \rightarrow-v, \quad \alpha \rightarrow-\alpha, \tag{5.9}
\end{equation*}
$$

is an obvious symmetry of $P_{I I}$ (and mKdV ) one easily sees that $\bar{b}(v, \alpha)=b(-v,-\alpha)$ will be the second Bäcklund transformation of $P_{I I}$ as can also be derived directly from the gauge symmetry argument involving the matrix $U$ (5.2). Such symmetry (5.9) is also present for all higher times $t_{n}$, therefore it will suffice for us to show from now on only one of the two Bäcklund transformations.

For the $t=t_{5} \mathrm{mKdV}$ equation (5.4) after imposing the appropriate similarity limit from (5.6) and performing an integration, we obtain:

v_{4 z}=10 v^{2} v_{2 z}+10 v v_{z}^{2}-6 v^{5}-\frac{16}{5} z v+\sigma \tag{5.10}
\end{equation*}
$$

This equation can be identified with the F-XVII equation of reference [10] for the parameters

\delta=0, \quad \lambda=-\frac{16}{5}, \quad \mu=0 .
$$

As before we are able to derive two Bäcklund transformations from the gauge symmetry argument that are related by the symmetry operation (5.9). We show one of them here:

v \rightarrow v+b, \quad b=\frac{8-5 \alpha}{15 v^{4}-5 v_{3 z}-10 v v_{2 z}+5 v_{z}^{2}+30 v^{2} v_{z}+8 z}, \quad \alpha \rightarrow \frac{16}{5}-\alpha . \tag{5.11}
\end{equation*}
$$

Finally for the $t=t_{7}$ and the corresponding mKdV flow (5.5) the appropriate selfsimilarity limit from (5.6) yields

v_{6 z} & =\alpha+20 v^{7}+42 v v_{2 z}^{2}-70 v^{4} v_{2 z}+14 v_{4 z} v^{2}-140 v^{3} v_{z}^{2}+56 v_{3 z} v_{z} v \\
& +70 v_{z}^{2} v_{2 z}-\frac{64 z v}{7}, \tag{5.12}
\end{align*}
$$

after performing an integration. One of the two Bäcklund transformations we find in this case is :

v \rightarrow v+b, \quad b=\frac{32-7 \alpha}{\text { denom }}, \quad \alpha \rightarrow \frac{64}{7}-\alpha, \tag{5.13}
\end{equation*}
$$

where

$$
\begin{aligned}
\text { denom }= & -70 v^{6}-7 v_{5 z}-7 v_{2 z}^{2}+70 v_{z}^{3}-210 v^{4} v_{z}+140 v^{3} v_{2 z}+ \\
& +14 v_{3 z} v_{z}+14 v\left(20 v_{z} v_{2 z}-v_{4 z}\right)+70 v^{2}\left(v_{3 z}+v_{z}^{2}\right)+32 z .
\end{aligned}
$$

Common for all these higher-order Painlevé equations derived from higher mKdV equations is invariance under the extended affine Weyl group obtained from the Bäcklund gauge symmetries in the self-similarity limit.

## 6 Outlook

In the recent publications [3, 4, 54 we advanced a notion of symmetry being a relevant measure of integrability by proposing models that only kept a part of the affine extended Weyl group symmetry while maintaining (not violating) the Painlevé property. Along the
same line of the investigation as presented in [3] we can here propose a deformation of the dressing chain (3.6) given for $N=3$ by

$$
\begin{align*}
& \left(j_{1}+j_{2}\right)_{z}=-\left(j_{1}-j_{2}\right)\left(j_{1}+j_{2}\right)+\alpha_{1}+\eta\left(j_{1}+j_{3}\right) \\
& \left(j_{2}+j_{3}\right)_{z}=-\left(j_{2}-j_{3}\right)\left(j_{2}+j_{3}\right)+\alpha_{2}-\eta\left(j_{1}+j_{3}\right)  \tag{6.1}\\
& \left(j_{1}+j_{3}\right)_{z}=-\left(j_{3}-j_{1}\right)\left(j_{1}+j_{3}\right)+\alpha_{3}
\end{align*}
$$

This model is still manifestly invariant under the transformation generated by $U_{3}$ from equation (4.26) such that

$$
\begin{equation*}
j_{3} \rightarrow j_{3}+\frac{\kappa}{j_{1}+j_{3}}, \quad j_{1} \rightarrow j_{1}-\frac{\kappa}{j_{1}+j_{3}}, \quad j_{2} \rightarrow j_{2}, \tag{6.2}
\end{equation*}
$$

with $\kappa=-\alpha_{3}$ and $\alpha_{i} \rightarrow \alpha_{i}+\alpha_{3}, i=1,2$ although no longer invariant under $U_{i}, i=$ 1,2 from (4.26). Also, the automorphism $\pi$ does not keep the equations (6.1) invariant anymore. Instead equations (6.1) are invariant under a new $\pi_{2}$ automorphism [3]

$$
\pi_{2}: j_{1} \rightarrow-j_{3}, j_{3} \rightarrow-j_{1}, j_{2} \rightarrow-j_{2}, \alpha_{1} \rightarrow-\alpha_{3}, \alpha_{3} \rightarrow-\alpha_{1}, \alpha_{2} \rightarrow-\alpha_{2}, \eta \rightarrow-\eta,
$$

with the transformed $j_{i}, \alpha_{i}, i=1,2,3$ now satisfying the conditions $\sum_{i=1}^{3} j_{i}=-3 z / 4$, $\sum_{i=1}^{3} \alpha_{i}=-3 / 2$ that differ from the condition (3.4) by the minus sign.

We can also run Kovalevskaya-Painlevé test as in references [21, 3] by first assuming that solutions of (6.1) equations have to be of the form

\begin{equation*}
j_{i}=\frac{a_{i}}{z}+b_{i}+c_{i} z+d_{i} z^{2}+e_{i} z^{3}+\cdots, \quad i=1,2,3, \tag{6.3}
\end{equation*}

with the pole chosen at 0 . After substituting the above equation back into equations (6.1) we find that coefficients of the first term must satisfy relations $a_{i}+a_{i+1}-a_{i}^{2}+a_{i+1}^{2}=$ $0, i=1,2,3$. For the solution $a_{1}=1, a_{2}=0, a_{3}=-1$ and any value of $\eta$ we find that $b_{2}$ and $d_{2}$ (or $d_{1}$ ) will remain undetermined while all the other coefficients will be fixed. This is a general feature which occurs independently of whether the $\eta$ terms are present. Thus the pole solutions of the type shown in (6.3) will depend on three parameters ( $b_{2}, d_{2}$ and position of the pole). This agrees with integrability property derived from the Kovalevskaya-Painlevé test of the $N=3$ dressing chain and shows that the $\eta$-deformation preserving the symmetry (6.2) also results in passing the integrability test.

The issue of finding an underlying integrable model behind the deformed dressing chain (6.1) remains under investigation.

## A Basic facts about $s l(N)$ algebra

Since $s l(N)$ Lie algebra is isomorphic to the algebra of trace-less $N \times N$ matrices, we find it convenient to work with a matrix representation of $\operatorname{sl}(N)$ with basic matrices being unit upper diagonal matrices $E_{\alpha_{a}}, E_{\alpha_{a}+\alpha_{a+1}}, \ldots, E_{\alpha_{a}+\ldots+\alpha_{b}}, a, b=1, \ldots, N-1$ defined by their non-vanishing unit matrix elements :

\left(E_{\alpha_{a}}\right)_{i j}=\delta_{i, a} \delta_{j, a+1}, \quad\left(E_{\alpha_{a}+\alpha_{a+1}}\right)_{i j}=\delta_{i, a} \delta_{j, a+2}, \ldots,\left(E_{\alpha_{a}+\ldots+\alpha_{b}}\right)_{i j}=\delta_{i, a} \delta_{j, b+1} \tag{A.1}
\end{equation*}
$$

and their corresponding lower diagonal conjugated matrices $E_{-\alpha_{a}}=E_{\alpha_{a}}^{\dagger}$ etc, with $i, j=$ $1, \ldots, N$. The so-called Cartan subalgebra of $\mathcal{G}$ is generated by trace-less combinations of the $N \times N$ diagonal matrices $h_{\alpha_{a}}=h_{e_{a}}-h_{e_{a+1}}, a=1, \ldots, N-1$ with :

$$

It is often convenient to relate the eigenvalues of Cartan subalgebra matrices $h_{\alpha_{a}}$ obtained when acting on $E_{\alpha_{a}}$ matrices to $N-1$ simple roots of $s l(N)$. This is facilitated
by introducing $N$ vectors $e_{a}$ obtained as follows. Let $\left\{\hat{e}_{1}, \ldots, \hat{e}_{N}\right\}$ be an orthonormal basis in $\mathbb{R}^{N}$. Define $N$ vectors

e_{i}=\hat{e}_{i}-\frac{1}{N} \sum_{j=1}^{N} \hat{e}_{j}

that by definition satisfy

and have inner product

Define now $N-1$ simple roots of $\operatorname{sl}(N)$ as

Due to the inner product $(\underline{\text { A.2 }})$ we obtain the $(N-1) \times(N-1)$ Cartan matrix $K_{i j}$ :

-1 & i=j \pm 1 \\
0 & \text { otherwise }

for products of simple roots defined in (A.3).
For fundamental weights defined as

\end{equation*}

it holds that

\left\langle\Lambda^{i}, \alpha_{j}\right\rangle=\delta_{i j}
$$

The Cartan matrix transforms the basis given in term of fundamental weights to the basis given in terms of roots according to:

\sum_{j=1}^{N-1} K_{i j} \Lambda^{j}=e_{i}-e_{i+1}=\alpha_{i}
$$

The Weyl group of $\operatorname{sl}(\mathrm{N})$ is a permutation of $N$ vectors $e_{i}$.
We are interested in generalizing the above structure to the loop algebra $\widehat{\operatorname{sl}}(N)$ spanned by $\lambda^{n} E_{ \pm\left(\alpha_{a}+\ldots+\alpha_{b}\right)}, \lambda^{n} h_{\alpha_{a}}$ on which we define the principal gradation operator:

This gives for $N=3,4,5$

N=4: & \Lambda^{1}+\Lambda^{2}+\Lambda^{3}=3 e_{1}+2 e_{2}+e_{3}=3 \alpha_{1}+4 \alpha_{2}+3 \alpha_{3} \\
N=5: & \Lambda^{1}+\Lambda^{2}+\Lambda^{3}+\Lambda^{4}=4 e_{1}+3 e_{2}+2 e_{3}+e_{4} \\
& =2 \alpha_{1}+3 \alpha_{2}+3 \alpha_{3}+2 \alpha_{4}
\end{array}
$$

The above expression allows an alternative simple expression for $Q$ as:

Q=N \lambda \frac{d}{d \lambda}+(N-1) h_{e_{1}}+(N-2) h_{e_{2}}+\ldots+(N-i) h_{e_{i}}+\ldots+h_{e_{N-1}}, \tag{A.7}

with

Q_{N=3}=3 \lambda \frac{d}{d \lambda}+h_{\alpha_{1}}+h_{\alpha_{2}}, \quad Q_{N=4}=4 \lambda \frac{d}{d \lambda}+3 h_{\alpha_{1}}+4 h_{\alpha_{2}}+3 h_{\alpha_{3}},
$$

etc. One fundamental feature that is of great relevance for the formalism we present is the fact that loop algebra $\widehat{s l}(N)$ decomposes into different grade sectors according to their eigenvalues under $Q$ :

This property provides foundation for the zero-curvature approach of section 2 used to determine flows of an integrable hierarchy.

The operator $Q$ in (A.7) induces the following graded subspaces:

\mathcal{G}_{n N+1} & =\left\{E_{\alpha_{1}}^{(n)}, \cdots, E_{\alpha_{N-1}}^{(n)}, E_{-\alpha_{1} \cdots-\alpha_{N-1}}^{(n+1)}\right\}, \\
\mathcal{G}_{n N+2} & =\left\{E_{\alpha_{1}+\alpha_{2}}^{(n)}, E_{\alpha_{2}+\alpha_{3}}^{(n)}, \cdots, E_{\alpha_{N-2}+\alpha_{N-1}}^{(n)}, E_{-\alpha_{1} \cdots-\alpha_{N-2}}^{(n+1)}, E_{-\alpha_{2} \cdots-\alpha_{N-1}}^{(n+1)}\right\},  \tag{A.9}\\
\vdots & =\vdots \\
\mathcal{G}_{n N+N-1} & =\left\{E_{-\alpha_{1}}^{(n+1)}, \cdots, E_{-\alpha_{N-1}}^{(n+1)}, E_{\alpha_{1}+\cdots+\alpha_{N-1}}^{(n)}\right\} .
\end{align*}
$$

with each subspace $\mathcal{G}_{m}$ of grade $m \in Z$ containing generators of grade $m$.

## B From periodic dressing chain to Painlevé equations

For completeness and notational consistency we will provide here a number of useful identities to prove that the periodic dressing equation (3.6) can be rewritten as higher Painlevé equations (3.11) and (3.12) for $N$ odd and even, respectively.

Under substitution (3.10) the dressing equation (3.6) can be rewritten as $f_{i z}=f_{i}\left[f_{i-1}+\ldots-(-1)^{k} f_{i-k}+(-1)^{k} j_{i-k}-f_{i+1}+\ldots+(-1)^{k} f_{i+k}+(-1)^{k+1} j_{i+k+1}\right]+\alpha_{i}$,
after replacing $j_{i-1}=f_{i-2}-j_{i-2}$ and $j_{i+2}=f_{i+2}-j_{i+3}$ etc.
For $N$ odd using the periodicity condition (3.5) we conclude that

j_{i-k}-j_{i+k+1}=0 \text { for } 2 k+1=N \tag{B.2}
\end{equation*}
$$

and therefore equation (B.1) becomes for $2 k+1=N$ :

Due to periodicity, $f_{i-m}=f_{i-m+N}$ and we can rewrite (B.3) in a standard from :

Thus it follows that the dressing chain equation (3.6) gives $A_{2 k}^{(1)}=A_{N-1}^{(1)}$ Painlevé equations for $N$ odd with $\sum_{i=1}^{N} f_{i}=N z / 2$ and $\sum_{i=1}^{N} \alpha_{i}=N / 2$ for $\alpha_{i}=\beta_{i}+\frac{1}{2}$.

For $N$ even the condition (3.4) can now be cast as

The squared terms can be eliminated due to relation

leaving :

\sum_{r=1}^{n}\left(\frac{1}{2}-\alpha_{i+2 r}\right)=2 \sum_{r=1}^{n} f_{i+2 r} j_{i+2 r+1}-\sum_{r=1}^{n} f_{i+2 r}\left(\sum_{s=1}^{n} f_{i+2 r+2 s \pm 1}-\sum_{s=1}^{n-1} f_{i+2 r+2 s}\right) \tag{B.9}
\end{equation*}
$$

To rewrite terms explicitly depending on $j_{i+2 r+1}$ we use the formula:

$$
\begin{equation*}
j_{i+1+2 r}-j_{i+1}=\sum_{s=r}^{n-1} f_{i+2 s+1}-\sum_{s=r}^{n-1} f_{i+2 s+2} \tag{B.10}
\end{equation*}
$$

that follows from expansion $j_{i+1+2 r}=f_{i+2 r+1}-f_{i+2 r+2} \ldots$ carried until we reach $+f_{i+2 n-1}-$ $f_{i+2 n}$.

In this way we obtain :

$$
\begin{align*}
n z j_{i+1}= & \frac{f_{i}}{2}(n z)-2 \sum_{r=1}^{n-1} f_{i+2 r}\left(\sum_{s=r}^{n-1} f_{i+2 s+1}\right)+2 \sum_{r=1}^{n-1} f_{i+2 r}\left(\sum_{s=r}^{n-1} f_{i+2 s+2}\right) \\
& +\sum_{r=1}^{n-1} f_{i+2 r}\left(\sum_{s=1}^{n} f_{i+2 r+2 s \pm 1}\right)-\sum_{r=1}^{n} f_{i+2 r}\left(\sum_{s=1}^{n-1} f_{i+2 r+2 s}\right)+\sum_{r=1}^{n}\left(\frac{1}{2}-\alpha_{i+2 r}\right) \tag{B.11}
\end{align*}
$$

One can show that the second and the fourth summation terms on the right hand side of (B.11) cancel each other while the difference of the first and the third summation terms on the right hand side of (B.11) combine to yield :

$$
\begin{align*}
& \left(\sum_{r=1}^{n-1} \sum_{s=1}^{r} f_{i+2 s-1} f_{i+2 r}-\sum_{r=1}^{n-1} f_{i+2 r}\left(\sum_{s=r}^{n-1} f_{i+2 s+1}\right)\right)  \tag{B.12a}\\
& =\left(\sum_{1 \leq s \leq r \leq n-1} f_{i+2 s-1} f_{i+2 r}-\sum_{1 \leq r \leq s \leq n-1} f_{i+2 r} f_{i+2 s+1}\right) \tag{B.12b}
\end{align*}
$$

To summarize we obtain an expression for $j_{i+1}, i=1, \ldots, N$ :

$$
\begin{equation*}
j_{i+1}=\frac{1}{n z}\left(\frac{f_{i}}{2}(n z)+\left(\sum_{1 \leq r \leq s \leq n-1} f_{i+2 r-1} f_{i+2 s}-\sum_{1 \leq r \leq s \leq n-1} f_{i+2 r} f_{i+2 s+1}\right)+\sum_{r=1}^{n}\left(\frac{1}{2}-\alpha_{i+2 r}\right)\right) \tag{B.13}
\end{equation*}
$$

Plugging it back into (B.7) yields:

$$
\begin{align*}
n z f_{i z}= & f_{i}\left(\sum_{1 \leq r \leq s \leq n-1} f_{i+2 r-1} f_{i+2 s}-\sum_{1 \leq r \leq s \leq n-1} f_{i+2 r} f_{i+2 s+1}+\sum_{r=1}^{n}\left(1-2 \alpha_{i+2 r}\right)\right) \\
& +n z \alpha_{i}, \quad i=1, \ldots, N, \tag{B.14}
\end{align*}
$$

reproducing $A_{2 n-1}^{(1)}=A_{N-1}^{(1)}$ invariant Painlevé equations for even $N=2 n$ with conditions (B.6).
