# Geometry of bifurcation sets of generic unfoldings of corank two functions

#### Abstract

We study the geometry of bifurcation sets of generic unfoldings of $D_{4}^{ \pm}$-functions. Taking blow-ups, we show each of the bifurcation sets of $D_{4}^{ \pm}$-functions admit a parametrization as a surface in $\boldsymbol{R}^{3}$. Using this parametrization, we investigate the behavior of the Gaussian curvature and the principal curvatures. Furthermore, we investigate the number of ridge curves and subparabolic curves near their singular point.


## 1 Introduction

In recent decades, the differential geometry of fronts (wave fronts) has been studied by many authors. In the Euclidean space, the set consists of the collection of singular values of a front and its parallel surfaces is called the caustic. Front and caustics are both fundamental objects in Lagrangian and Legendrian singularity theory, and they are closely related (see [2, 7, 8, 15], and also [6].9]). A front is a projection of the wave front set of an unfolding of a function, and a caustic is the bifurcation set of an unfolding of a function. Although sometimes a singular point of a bifurcation set is a singular point of a front, the bifurcation sets of the versal unfolding of $D_{4}^{ \pm}$-functions do not appear as fronts. In this case, a parametrization of the bifurcation set has not been given in the literature to the best knowledge of the authors. In this paper, to see the geometry of the bifurcation set, we simplify a versal unfolding $\left(\boldsymbol{R}^{2} \times \boldsymbol{R}^{3}, 0\right) \rightarrow(\boldsymbol{R}, 0)$ of a function $\left(\boldsymbol{R}^{2}, 0\right) \rightarrow(\boldsymbol{R}, 0)$ which is $\mathcal{R}$-equivalent to the $D_{4}^{ \pm}$-function

[^0]by using a coordinate change on $\boldsymbol{R}^{2}$ and an isometry on $\boldsymbol{R}^{3}$. By using the blow-up method, we give a parametrization of a generic versal unfolding of such a function, and we show that the parametrization is a front, and investigate its geometry. For fronts, one can define classical differential geometric invariants (Gaussian, mean and principal curvatures) even though they diverge on the set of singular points. We show:

Theorem A. One of the two principal curvatures of the parametrization of the bifurcation set of a versal unfolding of a $D_{4}^{ \pm}$-singularity $C^{\infty}$-extends across the set of singular points, and the other is unbounded near the singular point of the bifurcation set. Moreover, the principal directions of these principal curvatures $C^{\infty}$-extend across the set of singular points.

By using the asymptotic behavior of the Gaussian curvature, we obtain the behavior of parabolic curves (the curves consisting of Gaussian curvature zero points) in Theorems 4.3 and 4.5. Moreover, by Theorem A, we can discuss the conditions for ridges and subparabolic curves near the singular point. Let $g$ be an umbilic free regular surface, and let $\kappa_{i}(i=1,2)$ be the principal curvatures, and $V_{i}$ the principal vector fields corresponding to $\kappa_{i}$. A point $p$ on $g$ is called a ridge point with respect to $\kappa_{i}$ if $V_{i} \kappa_{i}(p)=0$. A point $p$ on $g$ is called a subparabolic point with respect to $\kappa_{i}$ if $V_{j} \kappa_{i}(p)=0$, where $j=1,2$ and $j \neq i$. A curve on $g$ is called a ridge curve (respectively, subparabolic curve) if it consists of ridge points (respectively, subparabolic points). We show the following theorem under the assumption that the set of ridge points and the set of subparabolic points are curves. See Section 4.5 and Proposition 4.2 for the concrete conditions.

Theorem B. We assume that the set of ridge points and the set of subparabolic points are curves. Then the number of ridge curves with respect to the unbounded principal curvature emanating from the singular point is at most 18; the number of ridge curves with respect to the bounded principal curvature emanating from the singular point is at most 18; there are no subparabolic points with respect to the unbounded principal curvature near the singular point; the number of subparabolic curves with respect to the bounded principal curvature emanating from the singular point is at most 10.

## 2 Preliminaries

### 2.1 Unfoldings and bifurcation sets

Let $f:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow \boldsymbol{R}$ be a function. A function $F:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r}, 0\right) \rightarrow \boldsymbol{R}$ is called an unfolding of $f$ if $F(\boldsymbol{u}, 0)=f(\boldsymbol{u})$. The catastrophe set $C_{F}$ of the unfolding $F$ of $f$ is

$$

where $\boldsymbol{u}=\left(u_{1}, \ldots, u_{m}\right)$. An unfolding $F:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r}, 0\right) \rightarrow \boldsymbol{R}$ of $f:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow \boldsymbol{R}$ is a Morse family of $f$ if $0 \in \boldsymbol{R}^{m}$ is a critical point of $f$ and

at 0 holds, where $\boldsymbol{x}=\left(x_{1}, \ldots, x_{r}\right)$. By the implicit function theorem, if $F$ is a Morse family, then $C_{F}$ is an $r$-dimensional submanifold of $\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r}, 0\right)$. We set its parametrization $B_{1}: C_{F} \rightarrow$ $\boldsymbol{R}^{m} \times \boldsymbol{R}^{3}$ as an inclusion. Let $\pi: \boldsymbol{R}^{m} \times \boldsymbol{R}^{3} \rightarrow \boldsymbol{R}^{3}$ be the projection, and set $B_{F}=\pi \circ B_{1}$. The singular set of $B_{F}$ is $S\left(B_{F}\right)=\left\{(\boldsymbol{u}, \boldsymbol{x}) \in C_{F} \mid \operatorname{rank} H_{F}(\boldsymbol{u}, \boldsymbol{x})<m\right\}$, where

The image $B_{F}\left(S\left(B_{F}\right)\right)$ is called the bifurcation set, and denoted by $\mathcal{B}_{F}$ :

\mathcal{B}_{F}=\left\{\boldsymbol{x} \in \boldsymbol{R}^{3} \mid \text { there exists }(\boldsymbol{u}, \boldsymbol{x}) \in C_{F} \text { such that rank } H_{F}(\boldsymbol{u}, \boldsymbol{x})<m\right\} .
$$

The following $P-\mathcal{R}^{+}$equivalence plays a fundamental role in investigating bifurcation sets (see [2, Chapter 8], [8, Chapter 5] for details).
Definition 2.1. Let $F_{i}:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r}, 0\right) \rightarrow \boldsymbol{R}$ be Morse families of functions $f_{i}:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow \boldsymbol{R}$ $(i=1,2)$. They are said to be $P-\mathcal{R}^{+}$equivalent if there exists a triple $(g(\boldsymbol{u}, \boldsymbol{x}), G(\boldsymbol{x}), h(\boldsymbol{x}))$, where $g:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r}, 0\right) \rightarrow\left(\boldsymbol{R}^{m}, 0\right), G:\left(\boldsymbol{R}^{r}, 0\right) \rightarrow\left(\boldsymbol{R}^{r}, 0\right)$ is a diffeomorphism-germ, and $h:\left(\boldsymbol{R}^{r}, 0\right) \rightarrow(\boldsymbol{R}, 0)$ such that

The following lemma is well-known (see [8, Proposition 3.1] and its proof):
Lemma 2.2. Let $F_{i}:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r}, 0\right) \rightarrow \boldsymbol{R}$ be Morse families of $f_{i}:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow \boldsymbol{R}(i=1,2)$. If $F_{1}, F_{2}$ are $P-\mathcal{R}^{+}$-equivalent as in (2.2), then $G\left(\mathcal{B}_{F_{1}}\right)=\mathcal{B}_{F_{2}}$ as set germs at 0 .

By this lemma, to investigate the geometry of bifurcation sets, with respect to Euclidean geometry in $\boldsymbol{R}^{3}$, we introduce the following $P-\mathcal{R}^{+}$-isometricity:

Definition 2.3. Let $F_{i}:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r}, 0\right) \rightarrow \boldsymbol{R}$ be Morse families of functions $f_{i}:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow$ $\boldsymbol{R}(i=1,2)$. They are said to be $P-\mathcal{R}^{+}$-isometric if they are $P-\mathcal{R}^{+}$-equivalent, and the diffeomorphism-germ $G:\left(\boldsymbol{R}^{r}, 0\right) \rightarrow\left(\boldsymbol{R}^{r}, 0\right)$ in the triple $(g(\boldsymbol{u}, \boldsymbol{x}), G(\boldsymbol{x}), h(\boldsymbol{x}))$ which gives $P-\mathcal{R}^{+}$-equivalence is an isometry-germ.

We may simplify the functions $f$ and $F$ by $P$ - $\mathcal{R}^{+}$-isometry. Two functions $f_{i}:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow \boldsymbol{R}$ $(i=1,2)$ are $\mathcal{R}$-equivalent if there exists a diffeomorphism-germ $\varphi:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow\left(\boldsymbol{R}^{m}, 0\right)$ such that $f_{1}=f_{2} \circ \varphi$. A function-germ $f$ at 0 of two variables is a $D_{4}^{ \pm}$-germ if it is $\mathcal{R}$-equivalent to $f(u, v)=u^{3} / 3!\pm u v^{2} / 2$, where $\left(u_{1}, u_{2}\right)$ is denoted by $(u, v)$. Let $\varphi:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow\left(\boldsymbol{R}^{m}, 0\right)$ be a diffeomorphism-germ. Then a Morse family $F:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r}, 0\right) \rightarrow \boldsymbol{R}$ of $f:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow \boldsymbol{R}$ is $P-\mathcal{R}^{+}$-equivalent to the unfolding $F(\varphi(\boldsymbol{u}), \boldsymbol{x})$. Since we study the geometry of the bifurcation set of a $D_{4}^{ \pm}$-germ $f$, under the $P-\mathcal{R}^{+}$-isometricity, we may assume $f=u^{3} / 3!\pm u v^{2} / 2$ without loss of generality.

### 2.2 Simplification of an unfolding by $P-\mathcal{R}^{+}$-equivalence

Definition 2.4. Let $F_{i}:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r_{i}}, 0\right) \rightarrow \boldsymbol{R}(i=1,2)$ be two unfoldings of $f:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow \boldsymbol{R}$. An $\mathcal{R}^{+}$-f-morphism from $F_{2}$ to $F_{1}$ is a triple $(g(\boldsymbol{u}, \boldsymbol{x}), G(\boldsymbol{x}), h(\boldsymbol{x}))$, where $g:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r_{2}}, 0\right) \rightarrow$ $\left(\boldsymbol{R}^{m}, 0\right), G:\left(\boldsymbol{R}^{r_{2}}, 0\right) \rightarrow\left(\boldsymbol{R}^{r_{1}}, 0\right), h:\left(\boldsymbol{R}^{r_{2}}, 0\right) \rightarrow(\boldsymbol{R}, 0)$, and they satisfy $g(\boldsymbol{u}, 0)=\boldsymbol{u}$ and

Definition 2.5. An unfolding $F_{1}:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r_{1}}, 0\right) \rightarrow \boldsymbol{R}$ of $f:\left(\boldsymbol{R}^{m}, 0\right) \rightarrow \boldsymbol{R}$ is an $\mathcal{R}^{+}$-versal unfolding if for any unfolding $F_{2}:\left(\boldsymbol{R}^{m} \times \boldsymbol{R}^{r_{2}}, 0\right) \rightarrow \boldsymbol{R}$ of $f$, there exists an $\mathcal{R}^{+}$- $f$-morphism from $F_{2}$ to $F_{1}$.

It is known that the function $F_{0, \varepsilon_{1}}(u, v, x, y, z)=u^{3} / 3!+\varepsilon_{1} u v^{2} / 2+x u+y v+z\left(u^{2}-\varepsilon_{1} v^{2}\right) / 2$ is an $\mathcal{R}^{+}$-versal unfolding of $u^{3} / 3!+\varepsilon_{1} u v^{2} / 2$, where $\varepsilon_{1}= \pm 1$ ([2, Chapter 8], [8, Chapter 5]). We call the bifurcation set of an $\mathcal{R}^{+}$-versal unfolding of $u^{3} / 3!\pm u v^{2} / 2$ a $D_{4}^{ \pm}$-singularity. The bifurcation set of $F_{0, \varepsilon_{1}}$ is the set

B_{0, \varepsilon_{1}}=\left\{\left(-u^{2} / 2-\varepsilon_{1} v^{2} / 2-z u,-\varepsilon_{1} u v+\varepsilon_{1} z v, z\right) \mid \varepsilon_{1}\left(u^{2}-z^{2}\right)-v^{2}=0\right\} .
$$

We can observe that $B_{0,1}$ consists of two sheets and they have intersection curves $c(t)=$ $\{(-t, \pm t, 0) \mid t>0\}$. All $D_{4}^{+}$-singularities are locally diffeomorphic to $B_{0,1}$, we call the corresponding curves to $c(t)$ the intersection curve. See Figure 2.1 for the bifurcation sets of $F_{0, \varepsilon_{1}}$.


Figure 2.1: The bifurcation sets of $F_{0,-1}$ and $F_{0,1}$
We remark that $\mathcal{R}^{+}$-versal unfolding $\left(\boldsymbol{R}^{2} \times \boldsymbol{R}^{3}, 0\right) \rightarrow(\boldsymbol{R}, 0)$ of the $D_{4}^{ \pm}$-germ is unique ([2, Chapter 8], [8, Chapter 5]).

Let $f:\left(\boldsymbol{R}^{2}, 0\right) \rightarrow \boldsymbol{R}$ be $f(u, v)=u^{3} / 3!+\varepsilon_{1} u v^{2} / 2\left(\varepsilon_{1}= \pm 1\right)$ and let $F:\left(\boldsymbol{R}^{2} \times \boldsymbol{R}^{3}, 0\right) \rightarrow \boldsymbol{R}$ be an $\mathcal{R}^{+}$-versal unfolding of $f$. We have the following:

Proposition 2.6. The function $F$ is $P-\mathcal{R}^{+}$-isometric to

Proof. Since $F_{0, \varepsilon_{1}}$ is a versal unfolding, there exist $g:\left(\boldsymbol{R}^{2} \times \boldsymbol{R}^{3}, 0\right) \rightarrow\left(\boldsymbol{R}^{2}, 0\right), G:\left(\boldsymbol{R}^{3}, 0\right) \rightarrow$ $\left(\boldsymbol{R}^{3}, 0\right), h:\left(\boldsymbol{R}^{3}, 0\right) \rightarrow(\boldsymbol{R}, 0)$, and they satisfy $g(\boldsymbol{u}, 0)=\boldsymbol{u}$ and $F(\boldsymbol{u}, \boldsymbol{x})=F_{0}(g(\boldsymbol{u}, \boldsymbol{x}), G(\boldsymbol{x}))+$
$h(\boldsymbol{x})$. By the triple $(g(\boldsymbol{u}, \boldsymbol{x}), \boldsymbol{x}, h(\boldsymbol{x}))$, we see $F$ is $P-\mathcal{R}^{+}$-isometric to $F_{0}(u, G(\boldsymbol{x}))$ as in (2.4). Let us set

where ${ }^{t}()$ stands for matrix transposition. Then $M$ is an orthonormal matrix, and is identified with a linear map. By the triple (id, $M, 0$ ), we see the first condition of (2.5) can be satisfied. By the versality, $g_{1,100} g_{2,010} g_{3,001} \neq 0$. The second condition of (2.5) can be satisfied by the linear map defined by the orthonormal matrix

Geometric meanings of coefficients of $G_{1}, G_{2}, G_{3}$ are discussed in Section 4 .

### 2.3 Fronts

Since we shall show the bifurcation sets are fronts, we give a fundamental definition of fronts. Let $f:\left(\boldsymbol{R}^{2}, 0\right) \rightarrow\left(\boldsymbol{R}^{3}, 0\right)$ be a map-germ. The map $f$ is a frontal if there exists a unit normal vector field $\nu$ along $f$ such that $\left\langle d f_{p}(X), \nu(p)\right\rangle=0$ for any $X \in T_{p}\left(\boldsymbol{R}^{2}, 0\right)$. A frontal $f$ with a unit normal vector $\nu$ is a front if the pair $(f, \nu)$ is an immersion. Let $f$ be a frontal. A function $\lambda:\left(\boldsymbol{R}^{2}, 0\right) \rightarrow \boldsymbol{R}$ is called an identifier of singularities if it is a non-zero multiple of the function $\operatorname{det}\left(f_{u}, f_{v}, \nu\right)$. If a function is an identifier of singularities, then the set of singular points $S(f)$ satisfies $S(f)=\lambda^{-1}(0)$. Since the unit normal vector field is well-defined for frontals, one can define the Gaussian, mean and principal curvatures in a natural way. However, it may diverge on the set of singular points. See [10-14] for differential geometric study of these curvatures. Let $f:\left(\boldsymbol{R}^{2}, 0\right) \rightarrow\left(\boldsymbol{R}^{3}, 0\right)$ be a front with a unit normal vector field $\nu$, which is a cuspidal edge (by coordinate transformations on the source and the target space, it can be written as $\left.(u, v) \mapsto\left(u, v^{2}, v^{3}\right)\right)$. Let $\gamma:(J, 0) \rightarrow\left(\boldsymbol{R}^{3}, 0\right)$ be a parametrization of the set of singular points of $f$, where $J$ is an open interval containing 0 . We set $\hat{\gamma}(t)=f \circ \gamma(t)$ and $\hat{\nu}(t)=\nu \circ \gamma(t)$. The singular curvature $\kappa_{s}$ and the (limiting) normal curvature $\kappa_{n}$ are defined by

## 3 Description of bifurcation sets

We assume $f(u, v)=u^{3} / 3!+\varepsilon_{1} u v^{2} / 2$ and $F$ is written as (2.4) with the conditions (2.5). Then by the implicit function theorem, there exist two functions $x(u, v, z), y(u, v, z)$ such that

## $3.1 \quad D_{4}^{-}$singularity

We give a parametrization of the bifurcation set by using the blow-up method at a singular point [3] (see also [5, Example (a) in p. 221]). Let $S^{1}=\boldsymbol{R} / 2 \pi \boldsymbol{Z}$ be a circle, and let $I=(-\varepsilon, \varepsilon)$ be an open interval. Two points $\left(\theta_{i}, r_{i}\right) \in S^{1} \times I(i=1,2)$ are equivalent $(\sim)$ if $\left(\theta_{2}, r_{2}\right)=\left(\theta_{1}+\pi, r_{1}\right)$. The quotient space $\mathcal{M}=S^{1} \times I / \sim$ is topologically a Möbius strip. There is a natural map $\pi: \mathcal{M} \rightarrow \boldsymbol{R}^{2}$, where $\pi([(\theta, r)])=(r \cos \theta, r \sin \theta)$. This is usually called a blow-up. Furthermore, we take a double cover $\hat{\mathcal{M}}$ of $\mathcal{M}$, and consider a natural map $\hat{\pi}: \hat{\mathcal{M}} \rightarrow \boldsymbol{R}^{2}$, where $\hat{\pi}([(\theta, r)])=(r \cos 2 \theta, r \sin 2 \theta)$. Then $\hat{\mathcal{M}}$ is topologically an annulus. We assume $\varepsilon_{1}=-1$ in (2.4). Then $\operatorname{det} H_{F}=-u^{2}-v^{2}+R(x, y, z)^{2}$. We set

By the condition (2.5), there exist functions $x_{-1, \varepsilon_{2}}(\theta, z), y_{-1, \varepsilon_{2}}(\theta, z)$ such that $X_{-1, \varepsilon_{2}}\left(\theta, x_{-1, \varepsilon_{2}}\right.$ $\left.(\theta, z), y_{-1, \varepsilon_{2}}(\theta, z), z\right)=Y_{-1, \varepsilon_{2}}\left(\theta, x_{-1, \varepsilon_{2}}(\theta, z), y_{-1, \varepsilon_{2}}(\theta, z), z\right)=0$ holds identically. In this setting, we have:

On the other hand, since $P(0,0,0)=Q(0,0,0)=0$, the equality $X_{-1, \varepsilon_{2}}(\theta, 0,0,0)=Y_{-1, \varepsilon_{2}}(\theta, 0,0,0)=0$ is satisfied. Thus $\bar{x}_{-1, \varepsilon_{2}}(\theta)=\bar{y}_{-1, \varepsilon_{2}}(\theta)=0$ is a solution of $X_{-1, \varepsilon_{2}}(\theta, x, y, 0)=Y_{-1, \varepsilon_{2}}(\theta, x, y, 0)=$ 0 . By the uniqueness, $\bar{x}_{-1, \varepsilon_{2}}(\theta)=\bar{y}_{-1, \varepsilon_{2}}(\theta)=0$ holds. By the definition of the functions $\bar{x}_{-1, \varepsilon_{2}}(\theta), \bar{y}_{-1, \varepsilon_{2}}(\theta)$, it holds that $\bar{x}_{-1, \varepsilon_{2}}(\theta)=x_{-1, \varepsilon_{2}}(\theta, 0), \bar{y}_{-1, \varepsilon_{2}}(\theta)=y_{-1, \varepsilon_{2}}(\theta, 0)$. This shows $x_{-1, \varepsilon_{2}}(\theta, 0)=0$ and $y_{-1, \varepsilon_{2}}(\theta, 0)=0$. Moreover, by (3.7) and (2.5), it holds that $\left(x_{-1, \varepsilon_{2}}\right)_{z}(\theta, 0)=$ $\left(y_{-1, \varepsilon_{2}}\right)_{z}(\theta, 0)=0$. The equation (3.9) is obvious by (3.8).

Thus a double cover of the bifurcation set can be parameterized by

It is easy to see by $d X$ and $d Y$ are linearly independent at $(\theta, 0)$. This shows the assertion.

We assume $\varepsilon_{1}=1$ in (2.4). Then $\operatorname{det} H_{F}=u^{2}-v^{2}+R(x, y, z)^{2}$. We set

## 4 Geometry of bifurction sets

### 4.1 Asymptotic behavior of parametrization near singular points

Let $b=b_{\varepsilon_{1}, \varepsilon_{2}}$ be the parametrization of the bifurcation set as in Sections 3.1 and 3.2, and $\nu=\nu_{\varepsilon_{1}, \varepsilon_{2}}$ its unit normal vector field. We set the coefficients of the first and second fundamental forms as follows:

L=L_{\varepsilon_{1}, \varepsilon_{2}}=-b_{\theta} \cdot \nu_{\theta}, & M=M_{\varepsilon_{1}, \varepsilon_{2}}=-b_{\theta} \cdot \nu_{z}, & N=N_{\varepsilon_{1}, \varepsilon_{2}}=-b_{z} \cdot \nu_{z} .
\end{array}
$$

We have the following lemma.

Lemma 4.1. The coefficients of the first and second fundamental forms satisfy

M & =z^{2} \lambda(\theta) a(\theta, z)|\tilde{\nu}|^{-1}\left(M_{0}(\theta)+z M_{1}(\theta, z)\right),  \tag{4.5}\\
N & =|\tilde{\nu}|^{-1}\left(N_{0}(\theta)+z N_{1}(\theta)+z^{2} N_{2}(\theta, z)\right), \tag{4.6}

where $E_{i}, F_{i}, G_{i}, L_{i}, M_{i}, G_{i}(i=0,1, \ldots, 4)$ are functions of variables $\theta$ or $(\theta, z)$ as indicated, and $a(\theta, z)=a_{\varepsilon_{1}, \varepsilon_{2}}(\theta, z), \lambda(\theta)=\lambda_{\varepsilon_{1}, \varepsilon_{2}}(\theta), \tilde{\nu}(\theta, z)=\tilde{\nu}_{\varepsilon_{1}, \varepsilon_{2}}(\theta, z)$ are defined in (3.14), (3.15), (3.16), (3.21), (3.22), (3.23) respectively. Moreover, $E_{0}(\theta)>0$ and $L_{0}$ is a non-zero constant.

Proof. By (3.12) and (3.24), it holds that the first two components of $b_{\theta}$ are $z^{2} a \lambda A V$, and the third component of $b_{\theta}$ is zero, where $A=A_{\varepsilon_{1}, \varepsilon_{2}}, V=V_{\varepsilon_{1}, \varepsilon_{2}}$. Then we see (4.1), (4.4), (4.5) and $E_{0}>0$. By $x_{z}(\theta, 0)=y_{z}(\theta, 0)=0$, it holds that $b_{z}(\theta, 0)=(0,0,1)$, and this shows (4.3). To show (4.2), since the third component of $b_{\theta}$ is zero, and $b_{z}(\theta, 0)=(0,0,1)$, we see (4.2). We show $L_{0}$ is a non-zero constant in the case of $\varepsilon_{2}=1$. It is sufficient to show

Since $X_{x \theta}=Y_{x \theta}=X_{y \theta}=Y_{y \theta}=0$ on $z=0$, the right-hand side of (4.7) is

on $\{z=0\}$. Thus this is a non-zero constant, and the other cases can be shown by the same calculation. Finally, (4.6) is clear.

### 4.2 Principal curvatures and principal directions

In this section, we first show Theorem A.
Proof of Theorem A. Let $K$ and $H$ be the Gaussian curvature and the mean curvature. By Lemma4.1, one can see $z^{2} \lambda(\theta) K(\theta, z)$ and $z^{2} \lambda(\theta) H(\theta, z)$ are $C^{\infty}$ functions. We define $\tilde{K}, \tilde{H}, \tilde{I}$ by

where we include the variables $(\theta)$ and $(\theta, z)$ in the notation for functions, when it is clear. Here,

where the term $z^{i} O(0)$ stands for a function of the form $z^{i} h(\theta, z)$. Then

We note that the function $f(x)=\sqrt{b_{1}(\theta, z)^{2}-4 x b_{2}(\theta, z)}$ of the variable $x\left(b_{1} \neq 0\right)$ satisfies that $f(0)=\left|b_{1}(\theta, z)\right|$. Thus there exists a function $\tilde{f}(\theta, z, x)$ such that

Substituting $x=z^{2} \lambda(\theta)$ into (4.10), there exists a function $\tilde{h}(\theta, z)$ such that

We see $\tilde{H}(\theta, 0) \neq 0$ and $|a||\tilde{\nu}| \tilde{I}(\theta, 0) \neq 0$. This implies that one of the principal curvatures of $f$ is unbounded near $z=0$ and $S(f)$, and the other is bounded. This proves the assertion.

By (4.9), we see that there are no vanishing mean curvature points, no umbilic points, and no points with zero unbounded principal curvature near the singular point. We call the unbounded principal curvature the unbounded one, and the bounded principal curvature the bounded one. We give evaluation formulas for these principal curvatures, such as $\tilde{h}(\theta, z)$ when $\tilde{H}(0)>0$. By the square root function $\left(b_{0} \neq 0\right)$ is expanded as

we have

& \left.-a E_{1} \lambda N_{0}-N_{0} E_{0} \lambda(a) z\right) z^{3}+z^{4} O(0) .

Hence

Thus the unbounded principal curvature $\kappa_{1}$ and the bounded principal curvature $\kappa_{2}$ can be written as

By a direct calculation, the principal directions with respect to $\kappa_{1}$ and $\kappa_{2}$ are

& V_{2}=\frac{|\tilde{\nu}|}{z^{2} \lambda a}\left(-M+\kappa_{2} F, L-\kappa_{2} E\right)=\left(-M_{0}+z O(0), L_{0}+z O(0)\right), \tag{4.14}

respectively, under the identification $\partial_{\theta}=(1,0)$ and $\partial_{z}=(0,1)$. Since the zero set of a function $\delta(\theta, z)$ is a regular curve and is transverse to the $\theta$-axis if $\delta_{\theta}(\theta, 0) \neq 0$ at $(\theta, 0)$ which satisfies $\delta(\theta, 0)=0$, setting ' $=\partial / \partial \theta$, the following proposition holds:
Proposition 4.2. The ridge curve with respect to the unbounded principal curvature emanates from the direction $\theta$ satisfying $a(\theta, 0)\left(2 \lambda^{\prime} E_{0}+3 \lambda E_{0}^{\prime}\right)+2 \lambda E_{0} a^{\prime}(\theta, 0)=0$ under the condition $\left(a(\theta, 0)\left(2 E_{0} \lambda^{\prime}+3 E_{0}^{\prime} \lambda\right)+2 E_{0} \lambda a^{\prime}(\theta, 0)\right)^{\prime} \neq 0$. The ridge curve with respect to the bounded principal curvature emanates from the direction $\theta$ satisfying $-E_{1} L_{0} N_{0}+E_{0}^{\prime} M_{0} N_{0}+2 E_{0}\left(L_{0} N_{1}-\right.$ $\left.M_{0} N_{0}^{\prime}\right)=0$ under the condition $\left(-E_{1} L_{0} N_{0}+E_{0}^{\prime} M_{0} N_{0}+2 E_{0}\left(L_{0} N_{1}-M_{0} N_{0}^{\prime}\right)\right)^{\prime} \neq 0$. There are no subparabolic curves with respect to the unbounded principal curvature. The subparabolic curve with respect to the bounded principal curvature emanates from the direction $\theta$ satisfying $2 E_{0} N_{0}^{\prime}-E_{0}^{\prime} N_{0}=0$ under the condition $\left(2 E_{0} N_{0}^{\prime}-E_{0}^{\prime} N_{0}\right)^{\prime} \neq 0$.

Proof. Using (4.12), (4.13) and (4.14), we have the assertions by direct calculations. We note that $\tilde{\nu} \cdot \tilde{\nu}=E_{0},(\tilde{\nu} \cdot \tilde{\nu})^{\prime}=E_{0}^{\prime},(\tilde{\nu} \cdot \tilde{\nu})_{z}=E_{1}$ at $(\theta, 0)$.

### 4.3 Singular curvature and limiting normal curvature

As the set of singular points near the singular point consists of a cuspidal edge, we calculate the singular curvature and limiting normal curvature. For simplicity, we just give conditions for whether their limits vanish or not. By (2.7), $\kappa_{n}$ vanishes if and only if $N_{0}$ vanishes. Thus if $\varepsilon_{1}=-1$, then $\kappa_{n}=0$ at $(0,0)$ (respectively, $\left.(\pi / 3,0),(2 \pi / 3,0)\right)$ if and only if $g_{2,002}=0$ (respectively, $-\sqrt{3} g_{1,002}-g_{2,002}=0,-\sqrt{3} g_{1,002}+g_{2,002}=0$ ). These will appear as conditions for the configurations of parabolic curves in Section 4.4. Furthermore, if $\varepsilon_{1}=1$, then $\kappa_{n}=0$ at $(0,0)$ if and only if $g_{2,002}=0$. On the other hand, by (2.7), (3.17), (3.25) and ${ }^{t}\left(x_{z z}, y_{z z}\right)=$ $\operatorname{det} A_{\varepsilon_{1}, \varepsilon_{2}}{ }^{t}\left(X_{z z}, X_{z z}\right)$ at $z=0$, we obtain that $\kappa_{s}=0$ at ( 0,0 ) (respectively, $(\pi / 3,0),(2 \pi / 3,0)$ ) if and only if $K_{1}=0$ (respectively, $K_{2}+2 \sqrt{3} K_{3}=0,-K_{2}+2 \sqrt{3} K_{3}=0$ ), where

Furthermore, if $\varepsilon_{1}=1$, then $\kappa_{n}=0$ at $(0,0)$ if and only if $K_{1}=0$.

### 4.4 Configurations of parabolic curves emanating from $D_{4}^{ \pm}$-singularities

In this section, we consider configurations of parabolic curves emanating from $D_{4}^{ \pm}$-singularities. By (4.8) and (4.9), and the same reason just before Proposition 4.2, if $N_{0}^{\prime}(\theta) \neq 0$ for any $\theta$ satisfying $N_{0}(\theta)=0$, then the parabolic curve emanating out at the singular point emanates in the direction $\theta$ satisfying $N_{0}(\theta)=0$ at $(\theta, 0)$ in $\hat{M}_{\varepsilon_{2}}$ or $\mathcal{D}_{\varepsilon_{2}}$. We set $\xi=g_{2,002}, \eta=g_{1,002}$ and $\zeta=g_{3,001}$. We assume $\xi \neq 0$ and $\eta-\zeta^{2} \neq 0$. Moreover, we assume $N_{0}^{\prime}(\theta) \neq 0$ for any $\theta$ such that $N_{0}(\theta)=0$. By $b_{z}(\theta, 0)=(0,0,1)$, (3.13) and (3.17), we see that $N_{0}(\theta)=0$ is equivalent to

-\xi \sin \theta+\eta \cos \theta-\zeta^{2} \cos 3 \theta=0 & \left(\varepsilon_{1}=-1, \varepsilon_{2}=-1\right)  \tag{4.16}\\
-\xi \cosh \theta+\eta \sinh \theta+\zeta^{2} \sinh 3 \theta=0 & \left(\varepsilon_{1}=1, \varepsilon_{2}=1\right)  \tag{4.17}\\
-\xi \sinh \theta+\eta \cosh \theta-\zeta^{2} \cosh 3 \theta=0 & \left(\varepsilon_{1}=1, \varepsilon_{2}=-1\right) \tag{4.18}
\end{align*}

by the assumption $\xi \neq 0$ and $\eta-\zeta^{2} \neq 0$, and we see $\cos \theta=0, \sin \theta=0$ are not the solutions of (4.15), (4.16), and also $\sinh \theta=0$ is not the solution of (4.17), (4.18).

### 4.4.1 The case of $D_{4}^{-}$-singularities

Setting $\varepsilon_{2}=1$ and $t=\cot \theta$, the equation (4.15) is equivalent to

\end{equation*}

Thus the number of asymptotic curves emanating from the singular point is generically 3 or 1 . In this case, the singular set is $t= \pm 1 / \sqrt{3}$. We consider where the solutions $t$ of (4.19) are in $(-\infty,-1 / \sqrt{3}),(-1 / \sqrt{3}, 1 / \sqrt{3})$ or $(1 / \sqrt{3}, \infty)$. Let $D_{-1}$ be the cubic discriminant of (4.19):

We set the following notation for the direction of the parabolic curves. We dividing $\hat{\mathcal{M}}_{1}$ into $\Omega_{1}=\left\{(\theta, r) \in \hat{\mathcal{M}}_{1} \mid \cot \theta<-1 / \sqrt{3}\right\}, \Omega_{2}=\left\{(\theta, r) \in \hat{\mathcal{M}}_{1} \mid-1 / \sqrt{3}<\cot \theta<1 / \sqrt{3}\right\}$, $\Omega_{3}=\left\{(\theta, r) \in \hat{\mathcal{M}}_{1} \mid \cot \theta>1 / \sqrt{3}\right\}$. For the case of $\varepsilon_{2}=-1$, setting $t=\tan \theta$, the equation (4.16) is equivalent to $p(-t)=0$. Thus the cubic discriminant is the same as $D_{-1}$. We also divide $\hat{\mathcal{M}}_{-1}$ into $\tilde{\Omega}_{1}=\left\{(\theta, r) \in \hat{\mathcal{M}}_{-1} \mid \tan \theta<-1 / \sqrt{3}\right\}, \tilde{\Omega}_{2}=\left\{(\theta, r) \in \hat{\mathcal{M}}_{-1} \mid-1 / \sqrt{3}<\right.$ $\tan \theta<1 / \sqrt{3}\}, \tilde{\Omega}_{3}=\left\{(\theta, r) \in \hat{\mathcal{M}}_{-1} \mid \tan \theta>1 / \sqrt{3}\right\}$. By (3.17) and (3.18), the directions defined by $\tilde{\nu}_{-1,1}(0, z)$ and $\tilde{\nu}_{-1,-1}(\pi / 2, z)$ (respectively, $\tilde{\nu}_{-1,1}(\pi / 3, z)$ and $\tilde{\nu}_{-1,-1}(\pi / 2+\pi / 3, z)$, $\tilde{\nu}_{-1,1}(2 \pi / 3, z)$ and $\left.\tilde{\nu}_{-1,-1}(\pi / 2+2 \pi / 3, z)\right)$ are continuously connected across $\{z=0\}$. Thus, the region $\Omega_{1}$ corresponds to $\tilde{\Omega}_{3}, \Omega_{3}$ corresponds to $\tilde{\Omega}_{1}$, and $\Omega_{2}$ corresponds to $\tilde{\Omega}_{2}$. The notation $(i j k \mid l m n),(i, j, k, l, m, n \in\{1,2,3\})$ stands for three parabolic curves of $b_{1,1}$ emanating from the singular point, as they emanate into the regions $\Omega_{i}, \Omega_{j}, \Omega_{k}$, and three parabolic curves of $b_{1,-1}$ emanating from the singular point, as they emanate into the regions $\tilde{\Omega}_{l}, \tilde{\Omega}_{m}, \tilde{\Omega}_{n}$, respectively. We set $c_{1}=\sqrt{3} \xi+\eta+3 \zeta^{2}, c_{2}=\sqrt{3} \xi-\eta-3 \zeta^{2}$. We have the following theorem:

Theorem 4.3. The regions $\Omega_{1}, \Omega_{2}, \Omega_{3}, \tilde{\Omega}_{1}, \tilde{\Omega}_{2}, \tilde{\Omega}_{3}$ that the parabolic curves emanating from the singular point which emanate into are summarized as in the "configurations" column of Table 4.1 according to the sign of $D_{-1}$.

Needless to say, geometrically, all of the cases $(i i j)(i \neq j)$ are the same. Thus we can draw the pictures of the configurations of parabolic curves in Figure 4.2, We draw "open" pictures instead of the usual pictures as in Figure 4.1, with the parabolic curves drawn as thick lines, the set of singular points drawn thin as lines, and the intersection curves drawn as thin dotted lines. To show the theorem, we use the following fact, known as Budan's theorem or Descartes' rule of signs (see [1], for example):

Fact 4.4. Let $p(t)$ be a polynomial in $t$. Then the number of roots of $p(t)$ that are greater than $\alpha$ is the same or less than the number of sign changes in the sequence of the coefficients of $p(t+\alpha)$, and their difference is an even number. Furthermore, the number of roots of $p(t)$ that are less than $\alpha$ is the same or less than the number of sign changes in the sequence of the coefficients of $p(-t+\alpha)$, and their difference is an even number.

Proof of Theorem 4.3. We assume $\varepsilon_{2}=1$. Using Fact 4.4, to study the numbers of roots of $p(t)=0$ in each interval $(-\infty,-1 / \sqrt{3}),(-1 / \sqrt{3}, 1 / \sqrt{3}),(1 / \sqrt{3}, \infty)$, we look at the numbers of sign changes of

$$
\begin{gathered}
p_{1}(t)=9 p(t+1 / \sqrt{3})=9 \xi t^{3}+9 c_{1} t^{2}+6 \sqrt{3} c_{1} t+4 \sqrt{3}(\xi+\sqrt{3} \eta), \\
p_{2}(t)=9 p(t-1 / \sqrt{3})=9 \xi t^{3}-9 c_{2} t^{2}+6 \sqrt{3} c_{2} t+4 \sqrt{3}(-\xi+\sqrt{3} \eta), \\
p_{3}(t)=9 p(-t+1 / \sqrt{3})=-9 \xi t^{3}+9 c_{1} t^{2}-6 \sqrt{3} c_{1} t+4 \sqrt{3}(\xi+\sqrt{3} \eta), \\
p_{4}(t)=9(-t-1 / \sqrt{3})=-9 \xi t^{3}-9 c_{2} t^{2}-6 \sqrt{3} c_{2} t+4 \sqrt{3}(-\xi+\sqrt{3} \eta) .
\end{gathered}

We look at the number of sign changes of these polynomials under the conditions of each case. It is summarized in Table 4.2.

We first consider the case (I): $\xi>0$. We assume (I-1): $-\xi+\sqrt{3} \eta>0$. Then $\eta>0$, $\xi+\sqrt{3} \eta>0$ and $c_{1}>0$ hold. Since the number of sign changes in the sequence $\xi, c_{1}, c_{1}, \xi+\sqrt{3} \eta$ of the coefficients of $p_{1}$ (the number of sign changes in $p_{1}$ ) is zero, there are no roots in $(1 / \sqrt{3}, \infty)$, since the number of sign changes in $p_{4}$ i.e., the number of sign changes in $-\xi,-c_{2},-c_{2},-\xi+\sqrt{3} \eta$ is one for any of the cases of $c_{2}$, thus the configuration of the roots is (223) or (3) according to the sign of $D_{-1}$. We assume (I-2): $-\xi+\sqrt{3} \eta<0$. We consider the case (I-2-1): $\xi+\sqrt{3} \eta>0$. Then $\sqrt{3} c_{1}=2 \xi+\xi+\sqrt{3} \eta+3 \sqrt{3} \zeta^{2}>0$. Since the number of sign changes in $p_{1}$ is zero, there are no roots in $(1 / \sqrt{3}, \infty)$. If $c_{2}>0$, then the number of sign changes in $p_{4}$ is 0 . So, in this

case we have the configuration is (222) or (2). If $c_{2}<0$, then the number of sign changes in $p_{2}$ is 1 . So, in this case we have (233) or (2). We consider the case ( $\mathrm{I}-2-2$ ): $\xi+\sqrt{3} \eta<0$. Then the number of sign changes in $p_{1}$ is 1 . If $c_{2}>0$, then the number of sign changes in $p_{4}$ is 0 . So, in this case we have (122) or (1). If $c_{2}<0$, then the number of sign changes in $p_{2}$ is 1 . So, in this case we have (133) or (1). We second consider the case (II): $\xi<0$. We assume (II-1): $-\xi+\sqrt{3} \eta>0$. We consider the case (II-1-1): $\xi+\sqrt{3} \eta>0$. Then $\eta>0$ and $c_{2}<0$. The number of sign changes in $p_{1}$ is 1 for any $c_{1}$, and there are no sign changes in $p_{4}$. So, in this case we have (122) or (1). We consider the case (II-1-2): $\xi+\sqrt{3} \eta<0$. Then $c_{2}<0$ holds. If $c_{1}>0$ (II-1-2-1), then the number of sign changes in $p_{3}$ is 1 , and that in $p_{4}$ is zero. So, in this case we have (112) or (2). If $c_{1}<0$ (II-1-2-2), then the number of sign changes in $p_{1}$ and $p_{3}$ are both 0 . So, in this case we have (222) or (2). We assume (II-2): $-\xi+\sqrt{3} \eta<0$. Then $\eta>0$ and $\xi+\sqrt{3} \eta<0$. If $c_{1}>0$, then the number of sign changes in $p_{3}$ and $p_{4}$ are both 1 for any $c_{2}$. So this case (113), (3). If $c_{1}<0$, then there is no sign changes in $p_{1}$ and the number of sign changes in $p_{4}$ is 1 . So this case (223), (3). Since the above takes all the possibilities of signs of $\xi,-\xi+\sqrt{3} \eta, \xi+\sqrt{3} \eta, c_{1}$ and $c_{2}$, we see the assertion. For the case of $b_{-1,-1}$, since the equation which we have to consider is $p(-t)$, the configurations of this case can be obtained by interchanging $\Omega_{1}$ with $\tilde{\Omega}_{3}, \Omega_{2}$ with $\tilde{\Omega}_{2}$ and $\Omega_{3}$ with $\tilde{\Omega}_{1}$.

### 4.4.2 The case of $D_{4}^{+}$-singularity

Setting $t=\operatorname{coth} \theta$, the equation (4.17) is equivalent to

$$
\begin{equation*}
q(t)=-\xi t^{3}+\left(\eta+3 \zeta^{2}\right) t^{2}+\xi t-\eta+\zeta^{2}=0 \tag{4.20}
\end{equation*}
$$

and setting $t=\tanh \theta$, the equation (4.18) is equivalent to $q(t)=0$. Thus the number of asymptotic curves emanating from the singular point in $\left(\mathcal{D}_{1} \cup \mathcal{D}_{-1}\right) \cap\{r>0\}$ is generically 3 or 1 according to the cubic discriminant $D_{1}$ of $q(t)=0$ :

D_{1} / 4=\xi^{4}-2 \xi^{2} \eta^{2}+\eta^{4}+24 \xi^{2} \eta \zeta^{2}+8 \eta^{3} \zeta^{2}-18 \xi^{2} \zeta^{4}+18 \eta^{2} \zeta^{4}-27 \zeta^{8}
$$

We divide $\mathcal{D}_{1}$ and $\mathcal{D}_{-1}$ into the regions $\Omega_{1}=\left\{(\theta, r) \in \mathcal{D}_{1} \mid r>0\right.$, $\left.\operatorname{coth} \theta<-1\right\}, \Omega_{2}=\{(\theta, r) \in$ $\left.\mathcal{D}_{-1} \mid r>0\right\}, \Omega_{3}=\left\{(\theta, r) \in \mathcal{D}_{1} \mid r>0, \operatorname{coth} \theta>1\right\}, \tilde{\Omega}_{1}=\left\{(\theta, r) \in \mathcal{D}_{1} \mid r<0, \operatorname{coth} \theta<-1\right\}$, $\tilde{\Omega}_{2}=\left\{(\theta, r) \in \mathcal{D}_{-1} \mid r<0\right\}, \tilde{\Omega}_{3}=\left\{(\theta, r) \in \mathcal{D}_{1} \mid r<0, \operatorname{coth} \theta>1\right\}$. The notation (ijk|lmn), $(i, j, k, l, m, n \in\{1,2,3\})$ stands for three parabolic curves of $\left.b_{1,1}\right|_{\mathcal{D}_{1} \cap\{r>0\}}$ (if $i, j, k$ is 1 or 3 ) or $\left.b_{1,-1}\right|_{\mathcal{D}_{-1} \cap\{r>0\}}$ (if $i, j, k$ is 2 ) emanating from the singular point, as they emanate into the regions $\Omega_{i}, \Omega_{j}, \Omega_{k}$, and three parabolic curves of $\left.b_{1,1}\right|_{\mathcal{D}_{1} \cap\{r<0\}}$ (if $l, m, n$ is 1 or 3 ) or $\left.b_{1,-1}\right|_{\mathcal{D}_{1} \cap\{r<0\}}$ (if $l, m, n$ is 2 ) emanating from the singular point, as they emanate into the regions $\tilde{\Omega}_{l}, \tilde{\Omega}_{m}, \tilde{\Omega}_{n}$. We set $c_{3}=\eta+3 \zeta^{2}, c_{4}=-\eta+\zeta^{2}$. We have the following theorem:

Theorem 4.5. The regions $\Omega_{1}, \Omega_{2}, \Omega_{3}, \tilde{\Omega}_{1}, \tilde{\Omega}_{2}, \tilde{\Omega}_{3}$ that the way how the parabolic curves emanate from the singular point to the regions are summarized as in the "configurations" columns in the Tables 4.3, 4.4, 4.5 and 4.6 according to the sign of $D_{1}$.

Proof. We show the assertion by the same method as in the proof of Theorem 4.3. Since the method is completely the same, we state here just the information about sign changes. We set

$q_{1}(t)=q(t)$ as in (4.20), $q_{2}(t)=q_{1}(-t), q_{3}(t)=q_{1}(t+1), q_{4}(t)=q_{1}(t-1), q_{5}(t)=q_{1}(-t+1)$ and $q_{6}(t)=q_{1}(-t-1)$. Then each coefficient of these polynomials is one of $\xi, c_{3}, 3 \xi+c_{3}, 3 \xi-$ $c_{3}, \xi+c_{3}, \xi-c_{3}$ and $c_{4}$. The necessary number of sign changes of these polynomials under the conditions of each case are given in Table 4.7, and it takes all the possibilities of signs of $\xi$, $c_{3}, 3 \xi+c_{3}, 3 \xi-c_{3}, \xi+c_{3}, \xi-c_{3}$ and $c_{4}$, the assertion for the case of $r>0$ is proven. Since

$(-r \cosh \theta,-r \sinh \theta)$ is a $\pi$-rotation of $(r \cosh \theta, r \sinh \theta)$, the configurations of the case $r<0$ can be obtained by interchanging $\Omega_{1}$ with $\tilde{\Omega}_{3}, \Omega_{2}$ with $\tilde{\Omega}_{2}$ and $\Omega_{3}$ with $\tilde{\Omega}_{1}$.

### 4.5 Number of ridges and subparabolic curves

Here we show Theorem B. A pair of two hyperbolic-trigonometric polynomials

$$
g_{n}(s)=\sum_{1 \leq i+j \leq n} a_{i, j} \cosh ^{i} s \sinh ^{j} s \text { and } h_{n}(s)=\sum_{1 \leq i+j \leq n} b_{i, j} \cosh ^{j} s \sinh ^{i} s,
$$

satisfying $a_{i, j}=b_{i, j}=0$ for any odd $i+j$, or $a_{i, j}=b_{i, j}=0$ for any even $i+j$, are said to be adapted if by setting $\cosh s=1 /\left(1-t^{2}\right)^{1 / 2}, \sinh s=t /\left(1-t^{2}\right)^{1 / 2},(t=\tanh s)$, the polynomial $\left(1-t^{2}\right)^{n / 2} g_{n}(s)$ with respect to $t$, and the polynomial $\left(1-t^{2}\right)^{n / 2} h_{n}(s) / t^{n}$ with respect to $1 / t$, are the same. For example, since $\cosh 3 s=\left(1-t^{2}\right)^{-3 / 2}\left(1+3 t^{2}\right), \sinh 3 s=\left(1-t^{2}\right)^{-3 / 2} t^{3}\left(1+3 t^{-2}\right)$, the pair $\cosh 3 s$ and $\sinh 3 s$ is adapted.
Lemma 4.6. (1) The number of roots of $f_{n}(s)=\sum_{i+j=1}^{n} a_{i, j} \cos ^{i} s \sin ^{j} s$ is at most $n$ for $s \in$ $[0, \pi)$ if $d\left(f_{n}\right) / d s(s) \neq 0$ for all s satisfying $f_{n}(s)=0$. (2) We assume that the pair of two

hyperbolic-trigonometric polynomials $g_{n}(s)$ and $h_{n}(s)$ is adapted. Then the sum of the numbers of roots $s \in \boldsymbol{R}$ of $g_{n}(s)=0$ and $h_{n}(s)=0$ is at most $n$ under the condition $d\left(g_{n}\right) / d s(s) \neq 0$ (respectively, $\left.d\left(h_{n}\right) / d s(s) \neq 0\right)$ for all s satisfying $g_{n}(s)=0\left(\right.$ respectively, $\left.h_{n}(s)=0\right)$.

Proof. If $s= \pm \pi / 2$ are solutions, factoring out $\cos s$ from $f_{n}(s)$, and we may assume $s= \pm \pi / 2$ are not solutions of $f_{n}(s)=0$. Setting $\cos s= \pm 1 /\left(1+\tan ^{2} s\right)^{1 / 2}$ and $\sin s= \pm \tan s /(1+$ $\left.\tan ^{2} s\right)^{1 / 2}$, twice the number of roots of the equation $f_{n}(s)=0$ can be reduced to a polynomial equation with respect to $\tan s$ with degree $2 n$. This shows (1). See [4, Lemma 2] for a detailed proof. For a proof of (2), setting $\cosh s=1 /(1-t)^{1 / 2}$ and $\sinh s=t /(1-t)^{1 / 2},(t=\tanh s)$, since $g_{n}$ and $h_{n}$ consist only of the terms where $i+j$ is odd or even, and the equations $g_{n}(s)=0$, $h_{n}(s)=0$ are reduced to the same polynomial equations with respect to $t$ and $1 / t$, respectively, with degree $n$. Since tanh $s$ takes value in $(-1,1)$, we see the assertion.

The number $n$ of the above $f_{n}$ (respectively, $g_{n}, h_{n}$ ), is called the degree, and it is denoted by $\operatorname{deg}\left(f_{n}\right)$ (respectively, $\operatorname{deg}\left(g_{n}\right), \operatorname{deg}\left(h_{n}\right)$ ). We give a proof of Theorem B under the same assumption as in Proposition 4.2.

Proof of Theorem (B. We see the degrees of

$$
\begin{aligned}
& C_{1}(\theta)=a(\theta, 0)\left(2 \lambda^{\prime} E_{0}+3 \lambda E_{0}^{\prime}\right)+2 \lambda E_{0} a_{z}(\theta, 0), \\

These appear as the conditions of Proposition 4.2. We easily see $\operatorname{deg}\left(L_{0}\right)=\operatorname{deg}(a)=0$, $\operatorname{deg}(\lambda)=\operatorname{deg}\left(\lambda^{\prime}\right)=3$, and $\lambda, \lambda^{\prime}$ have only odd degree terms. Furthermore, we see $\operatorname{deg}\left(E_{0}\right)=$ $\operatorname{deg}\left(E_{0}^{\prime}\right)=2, \operatorname{deg}\left(E_{1}\right)=4$ and these have only even degree terms. For the degree of $a_{z}$, by (3.16) and (3.23), the degrres of $a_{z}$ is the same as that of $\alpha$ and $\beta$. Thus $\operatorname{deg}\left(a_{z}\right)=4$, and it has only even degree terms. We now consider the degrees of $M_{0}, N_{0}, N_{0}^{\prime}, N_{1}$. We assume $\varepsilon_{1}=\varepsilon_{2}=1$. Since $M_{0}=\left\langle\tilde{A} V, \tilde{\nu}_{z}\right\rangle(\theta, 0)$, and

$$
\begin{aligned}
\tilde{\nu}_{z} & =(-\cosh \theta d Y+\sinh \theta d X)_{z} \\
& =-\cosh \theta\left(d Y_{x} x_{z}+d Y_{y} y_{z}+d Y_{z}\right)+\sinh \theta\left(d X_{x} x_{z}+d X_{y} y_{z}+d X_{z}\right)
\end{aligned}
$$

at $(\theta, 0)$ which has degree 3 , together with $\operatorname{deg}(V)=1$, $\operatorname{deg}\left(d Y_{z}\right)=\operatorname{deg}\left(d X_{z}\right)=2$, we have $\operatorname{deg}\left(M_{0}\right)=4$. Moreover, we see $M_{0}$ has only even degree terms. Similarly, we see $\operatorname{deg}\left(N_{0}\right)=$ $\operatorname{deg}\left(N_{0}^{\prime}\right)=3$ and they have only odd degree terms. Since $\operatorname{deg}(\alpha)=\operatorname{deg}(\beta)=4$, it holds
that $\operatorname{deg}\left(x_{z z}\right)=\operatorname{deg}\left(y_{z z}\right)=\operatorname{deg}\left(X_{z z}\right)=\operatorname{deg}\left(Y_{z z}\right)=4$ and they have only even degree terms. Furthermore, since $b_{z}(\theta, 0)=(0,0,1), b_{z z}=\left(x_{z z}, y_{z z}, 0\right)$,

$$
\tilde{\nu}_{z z}=-\cosh \theta\left(d Y_{x} x_{z z}+d Y_{y} y_{z z}+d Y_{z z}\right)+\sinh \theta\left(d X_{x} x_{z z}+d X_{y} y_{z z}+d X_{z z}\right)
$$

at $(\theta, 0)$ and $2(\alpha \sinh \theta-\beta \cosh \theta)=\sinh 3 \theta$, we have $\operatorname{deg}\left(N_{1}\right)=7$, and has only odd degree terms. Thus $\operatorname{deg}\left(C_{1}\right)=\operatorname{deg}\left(C_{2}\right)=9$ and $\operatorname{deg}\left(C_{3}\right)=5$. On the other hand, by (3.20), (3.21) and (3.22), the degrees of $C_{i}(i=1,2,3)$ in the case of $\varepsilon_{2}=-1$ are the same as the case of $\varepsilon_{2}=1$. Moreover, for each $i=1,2,3$, the pair $C_{i}\left(\varepsilon_{2}= \pm 1\right)$ of hyperbolic-trigonometric polynomial is adapted, so we have the assertion. For the case of $\varepsilon_{1}=-1$, we can obtain the degrees by similar calculations. Summarizing up these degrees, Proposition 4.2 and the fact that each $D_{4}^{ \pm}$singularity consists of two sheets which correspond to $\varepsilon_{2}= \pm 1$ respectively, we have the assertion.
