# ON THE INHOMOGENEOUS NLS WITH INVERSE-SQUARE POTENTIAL

#### Abstract

We consider the inhomogeneous nonlinear Schrödinger equation with inverse-square potential in $\mathbb{R}^{N}$ $$
i u_{t}+\mathcal{L}_{a} u+\lambda|x|^{-b}|u|^{\alpha} u=0, \quad \mathcal{L}_{a}=\Delta-\frac{a}{|x|^{2}}
$$ where $\lambda= \pm 1, \alpha, b>0$ and $a>-\frac{(N-2)^{2}}{4}$. We first establish sufficient conditions for global existence and blow-up in $H_{a}^{1}\left(\mathbb{R}^{N}\right)$ for $\lambda=1$, using a Gagliardo-Nirenberg-type estimate. In the sequel, we study local and global well-posedness in $H_{a}^{1}\left(\mathbb{R}^{N}\right)$ in the $H^{1}$-subcritical case, applying the standard Strichartz estimates combined with the fixed point argument. The key to do that is to establish good estimates on the nonlinearity. Making use of these estimates, we also show a scattering criterion and construct a wave operator in $H_{a}^{1}\left(\mathbb{R}^{N}\right)$, for the mass-supercritical and energy-subcritical case.


## 1. Introduction

In this paper, we study the initial value problem (IVP) associated to the inhomogeneous nonlinear Schrödinger equation ( $\mathrm{INLS}_{a}$ for short)

\left\{\begin{array}{l}
i \partial_{t} u-\mathcal{L}_{a} u+\lambda|x|^{-b}|u|^{\alpha} u=0, \quad t \in \mathbb{R}, x \in \mathbb{R}^{N}  \tag{1.1}\\
u(0, x)=u_{0}(x)
\end{array}\right.
$$

where $N \geq 3, \mathcal{L}_{a}=-\Delta+\frac{a}{|x|^{2}}$ with $a>-\frac{(N-2)^{2}}{4}$ and $\alpha, b>0$. The equation is called "focusing $\operatorname{INLS}_{a}$ " when $\lambda=+1$ and "defocusing $\operatorname{INLS}_{a}$ " when $\lambda=-1$. The restriction on $a$ comes from the sharp Hardy inequality, namely

\frac{(N-2)^{2}}{4} \int|x|^{-2}|u(x)|^{2} d x \leq \int|\nabla u(x)| d x, \quad \forall u \in H^{1}
$$

which guarantees that $\mathcal{L}_{a}$ is a positive operator. It is a model from various physical contexts, for example, in nonlinear optical systems with spatially dependent interactions (see e.g. [1 and the references therein). In particular, when $a=0$, it can be thought of as modeling inhomogeneities in the medium in which the wave propagates (see for instance [18]). When $b=0$, the equation (1.1) appears in several physical settings, such a quantum field equations or black hole solutions of the Einstein's equations (see e.g. [17]).

The $\mathrm{INLS}_{a}$ model can be seen as an extension to the Schrödinger equation. For instance, when $a=b=0$ we have the classical nonlinear Schrödinger (denoted by NLS) equation, extensively studied over the three decades. (see [2], [6, [20], [26] and the references therein). The case $b=0$ and $a \neq 0$ is known as the NLS equation with inverse square potential, denoted by $\operatorname{NLS}_{a}$ equation, that is,

i \partial_{t} u-\mathcal{L}_{a} u+|u|^{\alpha} u=0
$$

This equation has also been intensively studied in recent years (see for instance, [3], 21], [22], [23], [27). Moreover, when $a=0$ and $b \neq 0$ we have the inhomogeneous NLS equation, denoted by (INLS), i.e.,

$$
\begin{equation*}
i \partial_{t} u+\Delta u+|x|^{-b}|u|^{\alpha} u=0 \tag{1.2}
\end{equation*}
$$

which also has received substantial attention recently (see e.g. [16], [11], [12], [4], [8, [21]).

[^0]Similarly to the INLS, the $\operatorname{INLS}_{a}$ equation is invariant under the scaling, $u_{\mu}(t, x)=\mu^{\frac{2-b}{\alpha}} u\left(\mu^{2} t, \mu x\right)$ for $\mu>0$. A straightforward computation yields

$$
\left\|u_{0, \mu}\right\|_{\dot{H}^{s}}=\mu^{s-\frac{N}{2}+\frac{2-b}{\alpha}}\left\|u_{0}\right\|_{\dot{H}^{s}}
$$

implying that the scale-invariant Sobolev space is $\dot{H}^{s_{c}}\left(\mathbb{R}^{N}\right)$, with $s_{c}=\frac{N}{2}-\frac{2-b}{\alpha}$, the so called critical Sobolev index. If $s_{c}=0$ (or $\alpha=\frac{4-2 b}{N}$ ) the (IVP) is known as mass-critical or $L^{2}$-critical; if $s_{c}<0$ (or $0<\alpha<\frac{4-2 b}{N}$ ) it is called mass-subcritical or $L^{2}$-subcritical; if $0<s_{c}<2$, (1.1) is known as mass-supercritical and energy-subcritical (or intercritical). In additional, solutions to (1.1) conserve their mass and energy, defined respectively by

M[u(t)]=\int_{\mathbb{R}^{N}}|u(t, x)|^{2} d x=M\left[u_{0}\right] \\
E_{a}[u(t)]=\frac{1}{2} \int_{\mathbb{R}^{N}}|\nabla u(t, x)|^{2} d x+\frac{a}{2} \int_{\mathbb{R}^{N}}|x|^{-2}|u(t, x)|^{2} d x+\frac{\lambda}{\alpha+2} \int_{\mathbb{R}^{N}}|u|^{\alpha+2} d x=E_{a}\left[u_{0}\right] .
\end{gathered}
$$

When $a=0$, we denote $E_{a}$ by $E_{0}$.
We review now some recent developments in $H^{1}\left(\mathbb{R}^{N}\right)$, for the particular cases, i.e., $\mathrm{NLS}_{a}$ and INLS models, starting with the $\mathrm{NLS}_{a}$ equation. Okazawa-Suzuki-Yokota [23], by the energy method, showed local well-posedness in the energy-subcritical case, for $N \geq 3$ and $a>-\frac{(N-2)^{2}}{4}$. They also proved that the solutions are global if $\lambda=-1$ or $0<\alpha<\frac{4}{N}$ and $\lambda=1$. Zhang-Zheng [27] studied the defocusing case, establishing well posedness and scattering for $\frac{4}{N}<\alpha<\frac{4}{N-2}$, assuming $a \geq 0$ and $N=3$, or $a \geq-\frac{(N-2)^{2}}{4}+\frac{4}{(\alpha+2)^{2}}$ and $N \geq 4$. Recently, Killip-Murphy-Visan-Zheng in 21 considered the focusing $3 D$ cubic $\mathrm{NLS}_{a}$. They established well-posedness and scattering in $H^{1}\left(\mathbb{R}^{N}\right)$ if $a>-\frac{1}{4}$. Later, Lu-Miao-Murphy [22] extended the result of [21] to all $L^{2}$-supercritical, energy subcritical nonlinearities, in dimensions, $3 \leq N \leq 6$, with

$$
\begin{cases}a>-\frac{1}{4} & \text { if } N=3, \quad \frac{4}{3}<\alpha \leq 2  \tag{1.3}\\ a>-\frac{(N-2)^{2}}{4}+\left(\frac{N-2}{2}-\frac{1}{\alpha}\right)^{2} & \text { if } 3 \leq N \leq 6, \quad \max \left\{\frac{2}{N-2}, \frac{4}{N}\right\}<\alpha<\frac{4}{N-2}\end{cases}
$$

On the other hand, the INLS equation was first studied by Genoud-Stuart [15] via the energy method. For $N \geq 1$ and $0<b<\min \{N, 2\}$, they showed local well posedness in $H^{1}\left(\mathbb{R}^{N}\right)$ for the $H^{1}$-subcritical case and global well possedness in the mass-subcritical case. In the mass-critical case, Genoud in [14] established global well-posedness in $H^{1}\left(\mathbb{R}^{N}\right)$, provided that the mass of the initial data is below that of the associated ground state. This result was extended in the intercritical case by Farah [10] and he also showed that the solution blows-up in finite time (see also [9]). The second author in [16], using Kato's method, proved local well-posedness in $H^{1}\left(\mathbb{R}^{N}\right)$, for the energy subcritical case in dimensions $N \geq 4$ and $0<b<2$. Cho-Lee [7] treated the case $N=3$ for $0<b<\frac{3}{2}$ and Dinh [8] the case $N=2$ for $0<b<1$. Furthermore, in the intercritical case, the second author in [16] also established a small data global theory in $H^{1}\left(\mathbb{R}^{N}\right)$ for $N \geq 4$, the first author [4] treated the case $N=3$ and Cardoso-Farah-Guzmán [5] the case $N=2$. In all these works the range of $b$ is the same one where local well-posedness was obtained.

Motivated by the aforementioned papers, our main interest in this paper is to prove similar results for the $\operatorname{INLS}_{a}$ equation in $H_{a}^{1}\left(\mathbb{R}^{N}\right)$. The well-posedness theory was already studied by Suzuki [25]. Using the energy method, the author showed that, i-1

\begin{equation*}
N \geq 3, \quad 0<\alpha<\frac{4-2 b}{N-2} \quad a>-\frac{(N-2)^{2}}{4}, \quad \text { and } \quad 0<b<2 \tag{1.4}
\end{equation*}
$$

then (1.1) is locally well-posed in $H_{a}^{1}\left(\mathbb{R}^{N}\right)$ satisfying $u \in C\left([0, T) ; H^{1}\left(\mathbb{R}^{N}\right)\right) \cap C^{1}\left([0, T) ; H^{-1}\left(\mathbb{R}^{N}\right)\right)$ for some $T>0$. It was also proved that any local solution of the IVP (1.1) with $u_{0} \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$ extends globally in time if either $\lambda=-1$ (defocusing case) or $0<\alpha<\frac{4-2 b}{N}$ for $\lambda=1$ (focusing, $L^{2}$-subcritical case).

[^1]Our first goal here is to study global existence and blow-up in $H^{1}\left(\mathbb{R}^{N}\right)$ for $\lambda=1$ for both the $L^{2}$-critical and the intercritical ( $L^{2}$-supercriticial and $H^{1}$-subcritical) case. For that, we apply a sharp Gagliardo-Nirenberg type estimate. In order to do so, we prove the existence of a ground state.

Proposition 1.1. Let $N \geq 3$ and $\alpha, a, b$ as in (1.4) and $\lambda=1$. There exists a positive solution to the elliptic equation

$$
\mathcal{L}_{a} Q+Q-|x|^{-b}|Q|^{\alpha} Q=0
$$

in $H_{a}^{1}\left(\mathbb{R}^{N}\right)$. Moreover, all possible solutions have the same mass, the same $\dot{H}_{a}^{1}$ norm and the same energy.

Using the variational analysis associated to Proposition 1.1, we have thresholds for global existence and blow-up.

Theorem $1.2\left(L^{2}\right.$-critical case). Let $N, a, b$ as in (1.4), $\lambda=1$ and $\alpha=\frac{4-2 b}{N}$. Suppose that $u$ is the solution to (1.1) with initial data $u_{0} \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$. If
a) (Global existence) $\left\|u_{0}\right\|_{L^{2}}<\|Q\|_{L^{2}}$, then the solution is uniformly bounded in $H_{a}^{1}$, and therefore extends globally in time;
b) (Blow-up) $E\left[u_{0}\right]<0$ and either $|x| u_{0} \in L^{2}\left(\mathbb{R}^{N}\right)$ or $u_{0}$ is radial, then $u$ blows-up in finite positive and negative times.

Theorem 1.3 (Intercritical case). Let $N, a, b$ as in (1.4), $\lambda=1$ and $\frac{4-2 b}{N}<\alpha<\frac{4-2 b}{N-2}$. Suppose that $u$ is the solution of (1.1) with initial data $u_{0} \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$. Assume

$$
M\left(u_{0}\right)^{1-s_{c}} E_{a}\left(u_{0}\right)^{s_{c}}<M(Q)^{1-s_{c}} E_{a}(Q)^{s_{c}}
$$

If
a) (Global existence)

$$
\left\|u_{0}\right\|_{L^{2}}^{1-s_{c}}\left\|\sqrt{\mathcal{L}_{a}} u_{0}\right\|_{L^{2}}^{s_{c}}<\|Q\|_{L^{2}}^{1-s_{c}}\left\|\sqrt{\mathcal{L}_{a}} Q\right\|_{L^{2}}^{s_{c}},
$$

then the solution is uniformly bounded in $H_{a}^{1}$, and therefore extends globally in time;
b) (Blow-up)

$$
\left\|u_{0}\right\|_{L^{2}}^{\frac{1-s_{c}}{s_{c}}}\left\|\sqrt{\mathcal{L}_{a}} u(t)\right\|_{L^{2}}>\|Q\|_{L^{2}}^{1-s_{c}}\left\|\sqrt{\mathcal{L}_{a}} Q\right\|_{L^{2}}^{s_{c}}
$$

and, in addition, if $|x| u_{0} \in L^{2}\left(\mathbb{R}^{N}\right)$ or $u_{0}$ is radial, then $u$ blows-up in finite positive and negative times.

The main tools for proving Theorems 1.2 and 1.3 are the coercivity given by the variational analysis, and the virial identities. The main difficulty is to appropriately control the error terms appearing when one truncates the virial identity in the radial case. The $L^{2}$-critical case is especially delicate, since the criticality gives us less room for error terms.

Note that the local well-posedness showed in [25] as well as the global results, Theorems [1.2 a ) and 1.3 a ) ensure the existence of solutions to (1.1). However we do not know whether or not the solutions satisfy $u \in L^{q}\left(I ; H_{a}^{1, r}\right)$ for any $L^{2}$-admissible pair $(q, r)$, which is a key property to study other problems such as scattering for example. To obtain this extra information and working towards the proof of scattering in a next work, we establish the local and global well-posedness for (1.1) via Kato's method, which is based on the contraction mapping principle and the Strichartz estimates. We start with the local theory for the energy-subcritical case.

Theorem 1.4. Assume that $N \geq 3$ and $0 \leq b<\min \left\{\frac{N}{2}, 2\right\}$. If $u_{0} \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$ and

$$
\begin{cases}a>-\frac{(N-2)^{2}}{4} & \text { if } \quad \frac{2-2 b}{N}<\alpha \leq \frac{2-2 b}{N-2} \quad \text { and } 0 \leq b<1,  \tag{1.5}\\ a>-\frac{(N-2)^{2}}{4}+\left(\frac{\alpha(N-2)-(2-2 b)}{2(\alpha+1)}\right)^{2} & \text { if } \max \left\{0, \frac{2-2 b}{N-2}\right\}<\alpha<\frac{4-2 b}{N-2} .\end{cases}
$$

Then there exists $T=T\left(\left\|u_{0}\right\|_{H_{a}^{1}}, N, \alpha, b\right)$ and a unique solution of (1.1) satisfying

$$
u \in C\left([0, T] ; H_{a}^{1}\left(\mathbb{R}^{N}\right)\right) \cap L^{q}\left([0, T] ; H_{a}^{1, r}\left(\mathbb{R}^{N}\right)\right)
$$

where $(q, r)$ is any $L^{2}$-admissible pair.
New challenges and technical obstructions appear with the presence of the functions $|x|^{-2}$ and $|x|^{-b}$ in $\left(\operatorname{INLS}_{a}\right)$, related especially to the problem of equivalence of Sobolev spaces. This leads us to impose some technical restrictions on the parameters $\alpha, b$ and $a$, given in (1.5).

Remark 1.5. Observe that Theorem 1.1 also holds for $b=0$, thus we have that ( $N L S_{a}$ ) is locally well-posed in $H^{1}\left(\mathbb{R}^{N}\right)$. In this particular case, we have a local result a little diferent from Luo-MiaoMurphy in [22], they showed local well posedness for $3 \leq N \leq 6$, assuming (1.3). Our result holds for any dimensions $N \geq 3$, however the condition on a is weaker than Luo-Miao-Murphy'result. Note also that we improve the range of the parameter $\alpha$ th $\alpha \geq \frac{N}{2}$. On the other hand, if $b<1$ then we have a lower bound for the parameter $\alpha$ in Theorem 1.4 and if $b \geq 1$ we then need $\alpha>0$.

As an immediately consequence we obtain the following result.
Corollary 1.6. Assume one of the following conditions:
(i) $N \geq 3,1 \leq b<\min \left\{\frac{N}{2}, 4\right\}, 0<\alpha<\frac{4-2 b}{N-2}$ and $a>-\frac{(N-2)^{2}}{4}+\left(\frac{\alpha(N-2)-(2-2 b)}{2(\alpha+1)}\right)^{2}$;
(ii) $N=3, \alpha=2,0<b<1$ and $a>-\frac{1}{4}+\frac{b^{2}}{9}$.

If $u_{0} \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$, then the same result of Theorem 1.4 holds.
It is worth mentioning that Corollary 1.6 (ii) can be seen as an extension of a local result by Killip-Murphy-Visan-Zheng [21] to the INLS $_{a}$ model.

Remark 1.7. The range of the parameters $b$ and $a$ in Theorem 1.4 are more restricted than in [25]. That is, applying the energy method we obtain a better result than using the Kato method, however in Theorem 1.4 we obtain an extra information on the solution.

In the sequel we establish small data global results in $H_{a}^{1}\left(\mathbb{R}^{N}\right)$, for $N \geq 3$ and $\frac{4-2 b}{N}<\alpha<\frac{4-2 b}{N-2}$. Since we use the Strichartz estimates (see Section 2) we show global well-posedness for radial and non-radial initial data. Here, $e^{-i t \mathcal{L}_{a}} u_{0}$ denotes the solution to the linear problem associated to (1.1) and the Strichartz norm $\|\cdot\|_{S\left(\dot{H}^{s_{c}}\right)}$ is defined in Section 2.1.

Theorem 1.8 (Radial small data theory). Let $a>0,0<b<\min \left\{0, \frac{N}{2}\right\}$ and $\frac{4-2 b}{N}<\alpha<\frac{4-2 b}{N-2}$ $(\alpha<3-2 b$ if $N=3)$. If $u_{0} \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$ radial with $\left\|u_{0}\right\|_{H^{1}} \leq M$ then there exists a unique global solution $u$ of (1.1) such that if $\left\|e^{-i t \mathcal{L}_{a}} u_{0}\right\|_{S\left(\dot{H}^{\left.s_{c}\right)}\right.}<\delta_{s d}$, there exists a unique global solution $u$ of (1.1) such that

$$
\|u\|_{S\left(\dot{H}^{s_{c}}\right)} \leq 2\left\|e^{-i t \mathcal{L}_{a}} u_{0}\right\|_{S\left(\dot{H}^{s_{c}}\right)} \quad \text { and } \quad\|u\|_{S\left(L^{2}\right)}+\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2}\right)} \leq 2 c\left\|u_{0}\right\|_{H_{a}^{1}}
$$

for some universal constant $c>0$.
In Theorem 1.8 when $N=3$, we have an extra restriction on $\alpha$, namely $\alpha<3-2 b$. To reach $\alpha<4-2 b$, we need to restrict the parameter $b$. This restriction comes from the need of $\alpha>1$ in the fixed point argument. To this end, we use the norm $\|u\|_{L_{t}^{\bar{a}} L_{x}^{\bar{c}}}$ denoted by

$$
\begin{equation*}
\|u\|_{\widetilde{S}\left(\dot{H}^{s_{c}}\right)}=\|u\|_{L_{t}^{\bar{a}} L_{x}^{\bar{r}}}, \tag{1.6}
\end{equation*}
$$

where $(\bar{a}, \bar{r})$ only satisfies $\bar{r} \geq 2$ and the relation of $\dot{H}^{s_{c}}$-admissible pair, i.e., $\frac{2}{\bar{a}}=\frac{N}{2}-\frac{N}{\bar{r}}-s_{c}$ and not the remaining conditions (see Section (2).
Theorem 1.9. Let $N=3, a>0$ and $0<b<\frac{3}{2}$. Assume $u_{0} \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$ and one of the following conditions:
(i) $\max \left\{1, \frac{4-2 b}{N}\right\}<\alpha<4-2 b$;
(ii) $\frac{4-2 b}{N}<\alpha<4-2 b$ and $0<b<\frac{1}{2}$;
(iii) $3-2 b \leq \alpha<4-2 b$ and $0<b<1$,

[^2]then the same result as in Theorem 1.8 holds, replacing $\|\cdot\|_{S\left(\dot{H}^{s_{c}}\right)}$ by $\|\cdot\|_{\widetilde{S}_{\left(\dot{H}^{\left.s_{c}\right)}\right.}}$.
We remark that Theorem 1.9 holds for general initial data. On the other hand, Theorem 1.9 (ii) shows global well posedness in the full intercritical regime, however with $b<\frac{1}{2}$. The gap $\frac{1}{2} \leq b<\frac{3}{2}$ is still an open problem. Moreover, in the particular cass $3-2 b \leq \alpha<4-2 b$, we have a better range for $b$ than in (ii).

The next result holds for non-radial data and $a<0$, however only for dimensions $N=3,4,5$. Here, we also use the norm $\|\cdot\|_{\widetilde{S}\left(\dot{H}^{s_{c}}\right)}$.

Theorem 1.10 (Small data theory). Let $0<b<\frac{6-N}{2}$ and $u_{0} \in H_{a}^{1}$ with $\left\|u_{0}\right\|_{H_{a}^{1}} \leq M$, for some $M>0$. Assume that $(N, a, \alpha)$ satisfy

$$
\begin{cases}a>-\frac{1}{4} & \text { if } N=3, \quad \frac{4-2 b}{3}<\alpha \leq 2-2 b \quad \text { and } 0 \leq b<\frac{1}{2} \\ a>-\frac{(N-2)^{2}}{4}+\left(\frac{\alpha(N-2)-(2-2 b)}{2(\alpha+1)}\right)^{2} & \text { if } 3 \leq N \leq 5, \quad \max \left\{\frac{4-2 b}{N}, \frac{2-2 b}{N-2}, 1\right\}<\alpha<\frac{4-2 b}{N-2}\end{cases}
$$

Then there exists $\delta_{s d}=\delta_{s d}(M)>0$ such that if $\left\|e^{-i t \mathcal{L}_{a}} u_{0}\right\|_{\widetilde{S}_{\left(\dot{H}^{s_{c}}\right)}}<\delta_{s d}$, then there exists a unique global solution $u$ of (1.1) such that

$$
\|u\|_{\widetilde{S}_{\left(\dot{H}^{s_{c}}\right)}} \leq 2\left\|e^{-i t \mathcal{L}_{a}} u_{0}\right\|_{\widetilde{S}_{\left(\dot{H}^{s_{c}}\right)}} \quad \text { and } \quad\|u\|_{S\left(L^{2}\right)}+\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2}\right)} \leq 2 c\left\|u_{0}\right\|_{H_{a}^{1}}
$$

for some universal constant $c>0$.
Remark 1.11. The results above still hold, with the same proof, if one restricts the time interval to $\left[t_{0},+\infty\right)$ or $\left(-\infty, t_{0}\right]$, instead of $\mathbb{R}$, where $u\left(t_{0}\right)=u_{0}$. By time-translation invariance, we assume $t_{0}=0$ in Theorem 1.10.

As mentioned above the main tool to show the local and global well-posedness is the Fixed Point Theorem, which is based on the Strichartz estimates. Similarly as in the local theory the main difficulty here is to look for admissible pairs to establish the equivalence of Sobolev spaces, mainly when $a<0$.

Once global results are proved, the natural route is to study the asymptotic behavior of such global solutions as $t \rightarrow \pm \infty$. We show that our solutions scatter to a solution of the linear problem in $H_{a}^{1}\left(\mathbb{R}^{N}\right)$. In addition, we construct the wave operator associated to eq. (1.1). This is the reciprocal problem of the scattering theory, which consists in constructing a solution with a prescribed scattering state.

Theorem 1.12. Assume the assumptions in Theorems 1.8, 1.9 and 1.10.
(i) Let $u(t)$ be a global solution of (1.1) with initial data $u_{0} \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$. If $\sup _{t \in \mathbb{R}}\|u(t)\|_{H_{a}^{1}} \leq M$ and $\|u\|_{S\left(\dot{H}^{s_{c}}\right)}<+\infty\left(\right.$ or $\left.\|u\|_{\widetilde{S}_{\left(\dot{H}^{s_{c}}\right)}}<+\infty\right)$, then $u(t)$ scatters in $H_{a}^{1}$, that is, there exists $\phi^{ \pm} \in H_{a}^{1}$ such that

$$
\lim _{t \rightarrow \pm \infty}\left\|u(t)-e^{-i t \mathcal{L}_{a}} \phi^{ \pm}\right\|_{H_{a}^{1}}=0
$$

(ii) For any $\phi \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$, there exist $T_{0}>0$ and $u \in C\left(\left[T_{0}, \infty\right): H_{a}^{1}\left(\mathbb{R}^{N}\right)\right)$ solution of (1.1) satisfying

$$
\lim _{t \rightarrow \infty}\left\|u(t)-e^{-i t \mathcal{L}_{a}} \phi\right\|_{H_{a}^{1}}=0
$$

The analogous statement holds backward in time.
The rest of the paper is organized as follows. In Section2, we introduce some notations and give a review of the Strichartz estimates. In Section 3 we discuss the existence of a ground state and establish global existence as well as blow up in $H_{a}^{1}\left(\mathbb{R}^{N}\right)$, for $L^{2}$-critical and intercritical cases. In Section 4 we study the local and global well-posedness applying the contraction mapping principle. Finally, in Section 5we prove Theorem 1.12

## 2. Notation and Preliminaries

In this section, we introduce the notation used throughout the paper and list some useful results. We use $C$ to denote various constants that may vary line by line. If $a$ and $b$ be positive real numbers, the notation $a \lesssim b$ means that there exists a positive constant $C>0$ such that $a \leq C b$. The notation $a \sim b$ means $a \lesssim b$ and $b \lesssim a$. Given a real number $r$, we use $r^{ \pm}$to denote $r \pm \varepsilon$ for some $\varepsilon>0$ sufficiently small. For a subset $A \subset \mathbb{R}^{N}$, its complement is denoted by $A^{C}=\mathbb{R}^{N} \backslash A$ and the characteristic function $\chi_{A}$ denotes the function that has value 1 at points of $A$ and 0 at points of $A^{C}$. Given $x, y \in \mathbb{R}^{N}, x \cdot y$ denotes the usual inner product of $x$ and $y$ in $\mathbb{R}^{N}$.

The norm in the Sobolev spaces $\dot{H}^{s, r}=\dot{H}^{s, r}\left(\mathbb{R}^{N}\right)$ and $H^{s, r}=H^{s, r}\left(\mathbb{R}^{N}\right)$, are defined by

$$
\|f\|_{\dot{H}^{s, r}}:=\left\|D^{s} f\right\|_{L^{r}} \quad \text { and } \quad\|f\|_{H^{s, r}}:=\left\|\langle D\rangle^{s} f\right\|_{L^{r}}
$$

where $D^{s} f:=\sqrt{-\Delta}^{s} f=\left(|\xi|^{s} \widehat{f}\right)^{\vee}$ and $\langle\cdot\rangle=\left(1+|\cdot|^{2}\right)^{\frac{1}{2}}$. If $r=2$ we denote $H^{s, 2}$ and $\dot{H}^{s, 2}$ simply by $H^{s}$ and $\dot{H}^{s}$, respectively. Similarly, we define Sobolev spaces $\dot{H}_{a}^{s, r}$ and $H_{a}^{s, r}$ associated to $\mathcal{L}_{a}$ by the closure of $\mathbb{C}_{0}^{\infty}\left(\mathbb{R}^{N} \backslash\{0\}\right)$ under the norms

$$
\|u\|_{\dot{H}_{a}^{s, r}}:=\left\|{\sqrt{\mathcal{L}_{a}}}^{s} u\right\|_{L^{r}} \quad \text { and } \quad\|u\|_{H_{a}^{s, r}}:=\|\left\langle{\left.\sqrt{\mathcal{L}_{a}}\right\rangle^{s} u \|_{L^{r}} .}\right.
$$

We abbreviate $\left.\dot{H}_{a}^{s}\left(\mathbb{R}^{N}\right)=\dot{H}_{a}^{s, 2}\left(\mathbb{R}^{N}\right)\right)$ and $H_{a}^{s}\left(\mathbb{R}^{N}\right)=H_{a}^{s, 2}\left(\mathbb{R}^{N}\right)$. Note that, by the sharp Hardy inequality, one has

$$
\|u\|_{\dot{H}_{a}^{1}} \sim\|u\|_{\dot{H}^{1}} \quad \text { for } \quad a>-\left(\frac{N-2}{2}\right)^{2} .
$$

We also define, for $1 \leq p<\infty$, the weighted Sobolev space $L_{b}^{p}=L_{b}^{p}\left(\mathbb{R}^{N}\right)=\left\{f:\|f\|_{p, b}<+\infty\right\}$, where

$$
\|f\|_{p, b}=\left[\int|x|^{-b}|f(x)|^{p} d x\right]^{\frac{1}{p}}
$$

Let $q, r>0, s \in \mathbb{R}$, and $I \subset \mathbb{R}$ an interval; the mixed norms in the spaces $L_{I}^{q} L_{x}^{r}$ and $L_{I}^{q} H_{x}^{s}$ of a function $f=f(t, x)$ are defined as

$$
\|f\|_{L_{I}^{q} L_{x}^{r}}=\left(\int_{I}\|f(t, \cdot)\|_{L_{x}^{r}}^{q} d t\right)^{\frac{1}{q}} \quad \text { and } \quad\|f\|_{L_{I}^{q} H_{x}^{s}}=\left(\int_{I}\|f(t, \cdot)\|_{H_{x}^{s}}^{q} d t\right)^{\frac{1}{q}}
$$

with the usual modifications if either $q=\infty$ or $r=\infty$. When the space $99+-6$ integration is restricted to a subset $A \subset \mathbb{R}^{N}$ then the mixed norm will be denoted by $\|f\|_{L_{I}^{q} L_{x}^{r}(A)}$. Moreover, if $I=\mathbb{R}$ we shall use the notations $\|f\|_{L_{t}^{q} L_{x}^{r}}$ and $\|f\|_{L_{t}^{q} H_{x}^{s}}$.

Next, we recall some important inequalities. To state the estimates below, it is useful to introduce the parameter

\rho=\frac{(N-2)-\sqrt{(N-2)^{2}+4 a}}{2} . \tag{2.1}
\end{equation*}

Lemma 2.1 (Equivalence of Sobolev spaces). Fix $N \geq 3$, $a \geq-\left(\frac{N-2}{2}\right)^{2}$, and $0<s<2$. If $1<p<\infty$ satisfies $\frac{s+\rho}{N}<\frac{1}{p}<\min \left\{1, \frac{N-\rho}{N}\right\}$, then

$$
\left\|D^{s} f\right\|_{L^{p}} \lesssim\left\|\mathcal{L}_{a}^{\frac{s}{2}} f\right\|_{L^{p}} \text { for all } f \in \mathbb{C}_{0}^{\infty}\left(\mathbb{R}^{N} \backslash\{0\}\right)
$$

If $\max \left\{\frac{s}{N}, \frac{\rho}{N}\right\}<\frac{1}{p}<\min \left\{1, \frac{N-\rho}{N}\right\}$, then

$$
\left\|\mathcal{L}_{a}^{\frac{s}{2}} f\right\|_{L^{p}} \lesssim\left\|D^{s} f\right\|_{L^{p}} \text { for all } f \in \mathbb{C}_{0}^{\infty}\left(\mathbb{R}^{N} \backslash\{0\}\right)
$$

Proof. See 19
Remark 2.2. Let $0<s<2$. It is easy to see that, if $a>0$ then $\|f\|_{H_{a}^{s, r}} \sim\|f\|_{H^{s, r}}$, provided that $1<r<\frac{N}{s}$. When $-\frac{(N-2)^{2}}{4} \leq a<0$ we have $0<\rho<\frac{(N-2)}{2}$ and so $\|f\|_{H_{a}^{s, r}} \sim\|f\|_{H^{s, r}}$ if $\frac{N}{N-\rho}<r<\frac{N^{s}}{s+\rho}$.

[^4]Lemma 2.3. If $f \in H^{1}\left(\mathbb{R}^{N}\right)$ is radial, $N \geq 2$, then, for any $R>0$,

$$
\|f\|_{L_{\{|x| \geq R\}}^{\infty}} \lesssim R^{-\frac{N-1}{2}}\|f\|_{L^{2}}^{\frac{1}{2}}\|\nabla f\|_{L^{2}}^{\frac{1}{2}} .

Proof. See Strauss [24].
The next lemma implies that the Strichartz estimates (Lemma 2.6) hold.
Lemma 2.4 (Dispersive estimate). Let $f$ be a radial function.
(i) If $a \geq 0$, then we have

\left\|e^{i t \mathcal{L}_{a}} f\right\|_{L^{\infty}} \lesssim|t|^{-\frac{N}{2}}\|f\|_{L^{1}}
$$

(ii) If $-\frac{(N-2)^{2}}{4}<a<0$, then

\left\|\left(1+|x|^{-\rho}\right)^{-1} e^{i t \mathcal{L}_{a}} f\right\|_{L^{\infty}} \lesssim \frac{1+|t|^{\rho}}{|t|^{\frac{N}{2}}}\left\|\left(1+|x|^{-\rho}\right) f\right\|_{L^{1}}
$$

with $\rho$ being as in (2.1).
Proof. See Zheng [29].
2.1. Strichartz-Type Estimates. Before stating the Strichartz estimates, we need the following definitions.

We say the pair ( $q, r$ ) is Schrödinger admissible (S-admissible or $L^{2}$-admissible for short) if it satisfies

\frac{2}{q}=\frac{N}{2}-\frac{N}{r}
$$

where

$$
\left\{\begin{array}{l}
2 \leq r \leq \frac{2 N}{N-2} \quad \text { if } \quad N \geq 3  \tag{2.2}\\
2 \leq r<+\infty \quad \text { if } \quad N=1,2
\end{array}\right.
$$

Also, given a real number $s>0$, the pair $(q, r)$ is called $\dot{H}^{s}$-admissible in

$$
\begin{equation*}
\frac{2}{q}=\frac{N}{2}-\frac{N}{r}-s \tag{2.3}
\end{equation*}
$$

with

$$
\left\{\begin{array}{l}
\frac{2 N}{N-2 s} \leq r<\frac{2 N}{N-2} \text { if } \quad N \geq 3  \tag{2.4}\\
\frac{2 N}{N-2 s} \leq r<+\infty \text { if } \quad N=1,2
\end{array}\right.
$$

We set ${ }^{[6]} \mathcal{A}_{s}:=\left\{(q, r) ;(q, r)\right.$ is $\dot{H}^{s}$-admissible $\}$. Also, given $(q, r) \in \mathcal{A}_{s}$, by $\left(q^{\prime}, r^{\prime}\right)$ we denote its dual pair, that is, $\frac{1}{q}+\frac{1}{q^{\prime}}=1$ and $\frac{1}{r}+\frac{1}{r^{\prime}}=1$. We define the Strichartz norm by

$$
\|u\|_{S\left(\dot{H}^{s}\right)}=\sup _{(q, r) \in \mathcal{A}_{s}}\|u\|_{L_{t}^{q} L_{x}^{r}}
$$

and the dual Strichartz norm by

$$
\|u\|_{S^{\prime}\left(\dot{H}^{-s}\right)}=\inf _{(q, r) \in \mathcal{A}_{-s}}\|u\|_{L_{t}^{q^{\prime}} L_{x}^{r^{\prime}}} .
$$

If $s=0$ then $\mathcal{A}_{0}$ is the set of all $S$-admissible pairs. We denote $S\left(\dot{H}^{0}\right)$ by $S\left(L^{2}\right)$. We write $S\left(\dot{H}^{s}\right)$ or $S^{\prime}\left(\dot{H}^{-s}\right)$ if the mixed norm is evaluated over $\mathbb{R} \times \mathbb{R}^{N}$. To indicate the restriction to a time interval $I \subset(-\infty, \infty)$ or a subset $A \subset \mathbb{R}^{N}$, we will use the notations $S\left(\dot{H}^{s}(A) ; I\right)$ and $S^{\prime}\left(\dot{H}^{-s}(A) ; I\right)$.

[^5]Finally, we define the norm $\sqrt{7}\|u\|_{\widetilde{S}_{\left(\dot{H}^{\left.s_{c}\right)}\right.}}=\|u\|_{L_{t}^{\bar{a}} L_{x}^{\bar{x}}}$, where $(\bar{a}, \bar{r})$ only satisfies $\bar{r} \geq 2$ and the relation (2.3) but not necessarily (2.4). Specifically, the number $\bar{r}$ does not need to satisfy the condition $\bar{r}<\frac{2 N}{N-2}$.

We end this section by recalling the Strichartz estimates for the linear flow $e^{-i t \mathcal{L}_{a}}$. They were first proved by Burq-Planchon-Stalker-Tahvildar-Zadeh in [3]. Zhang-Zheng [28] confirmed the double endpoint case.
Lemma 2.5. If $N \geq 3$ and $a>-\frac{(N-2)^{2}}{4}$. Then,

\begin{aligned}
\left\|e^{-i t \mathcal{L}_{a}} f\right\|_{S\left(L^{2} ; I\right)} & \lesssim\|f\|_{L^{2}} \\
\left\|e^{-i t \mathcal{L}_{a}} f\right\|_{S\left(\dot{H}^{s} ; I\right)} & \lesssim\|f\|_{\dot{H}_{a}^{s}} \\
\left\|\int_{t_{0}}^{t} e^{-i\left(t-t^{\prime}\right) \mathcal{L}_{a}} g\left(\cdot, t^{\prime}\right) d t^{\prime}\right\|_{S\left(L^{2} ; I\right)} & \lesssim\|g\|_{S^{\prime}\left(L^{2} ; I\right)}
\end{aligned}
$$

Proof. See 3] and [27].
Lemma 2.6. If $N \geq 3, a \geq 0$ and $g$ a radial function. Then,

$$
\begin{equation*}
\left\|\int_{t_{0}}^{t} e^{-i\left(t-t^{\prime}\right) \mathcal{L}_{a}} g\left(\cdot, t^{\prime}\right) d t^{\prime}\right\|_{S\left(\dot{H}^{s} ; I\right)} \lesssim\|g\|_{S^{\prime}\left(\dot{H}^{-s} ; I\right)}, \tag{2.8}
\end{equation*}
$$

where $I \subset \mathbb{R}$ be an interval and $t_{0} \in I$.
Proof. The estimate is readily obtained from the main result in Foschi [13], given the $L^{1} \rightarrow L^{\infty}$ estimate in Lemma 2.4 and the invariance of the $L^{2}$ norm by $e^{-i t \mathcal{L}_{a}}$.
Remark 2.7. As usual, if $I=(T,+\infty)$ then in Lemma 2.6 one may replace the integral $\int_{t_{0}}^{t}$ by $\int_{t}^{+\infty}$. A similar statement holds if $I=(-\infty, T)$.
Remark 2.8. In the case, when $s=0$, we have the norms $\|u\|_{S\left(L^{2}\right)}=\sup _{(q, r) \in \mathcal{A}_{0}}\|u\|_{L_{t}^{q} L_{x}^{r}}$ and $\|u\|_{S^{\prime}\left(L^{2}\right)}=\inf _{(q, r) \in \mathcal{A}_{0}}\|u\|_{L_{t}^{q^{\prime}} L_{x}^{r^{\prime}}}$.

## 3. GLobal WELL-POSEDNESS AND BLOW-UP IN $H_{a}^{1}$

In this section, we prove results about the ground state $Q$, together with a dichotomy between global existence and finite-time blow-up below a mass-energy threshold. We first show the existence of a ground state (Proposition 1.1).
3.1. Existence of a ground state. We start by proving a compact embedding result.

Lemma 3.1 (Compactness of an immersion). If $N \geq 3, a>-\frac{(N-2)^{2}}{4}, 0<b<2$ and $0<\alpha<$ $\frac{4-2 b}{N-2}$, then $H_{a}^{1}\left(\mathbb{R}^{N}\right)$ is compactly embedded in $L_{b}^{\alpha+2}\left(\mathbb{R}^{N}\right)$.

Proof. Let $\left\{f_{n}\right\}_{n}$ be a bounded sequence in $H_{a}^{1}$. Since $a>-\frac{(N-2)^{2}}{4}$, Hardy's inequality yields that $\left\{f_{n}\right\}_{n}$ is also bounded in the standard space $H^{1}$, so we may assume that $f_{n} \rightharpoonup f \in H^{1}$ weakly in $H^{1}$. Now, for $R, \epsilon>0$,

$$
\int|x|^{-b}\left|f_{n}-f\right|^{\alpha+2} d x \lesssim\left(\int_{|x| \leq R}|x|^{-\frac{b N}{b+\epsilon}} d x\right)^{\frac{b+\epsilon}{N}}\left\|f_{n}-f\right\|_{L^{\frac{N(\alpha+2)}{N-b-\epsilon}}}^{\alpha+2}+\frac{1}{R^{b}}\left(\left\|f_{n}\right\|_{L^{\alpha+2}}+\|f\|_{L^{\alpha+2}}\right)^{\alpha+2}
$$

Thus, by Sobolev and Rellich-Kondrachov, since

$$
2<\alpha+2<\frac{N(\alpha+2)}{N-b-\epsilon}<\frac{2 N}{N-2}
$$

[^6]if $0<\alpha<\frac{4-2 b}{N-2}$ and $\epsilon$ is small, the result follows.
Lemma 3.2 (Adapted Gagliardo-Nirenberg inequality). Let $N \geq 3$. If $f \in H_{a}^{1}, 0<b<2$ and $0<\alpha<\frac{4-2 b}{N-2}$, then
\[

$$
\begin{equation*}
\int|x|^{-b}|f|^{\alpha+2} d x \leq C_{a}\left\|\sqrt{\mathcal{L}_{a}} f\right\|_{L^{2}}^{\frac{N \alpha+2 b}{2}}\|f\|_{L^{2}}^{\frac{4-2 b-\alpha(N-2)}{2}} \tag{3.1}
\end{equation*}
$$

\]

Equality in the bound above is attained by a function $Q \in H_{a}^{1}$, which is a positive solution to the elliptic equation

$$
\begin{equation*}
\mathcal{L}_{a} Q-Q+|x|^{-b}|Q|^{\alpha} Q=0 \tag{3.2}
\end{equation*}
$$

Proof. We mimic the classic proof for $a=b=0$, and exploit the compactness given by the immersion $H_{a}^{1} \hookrightarrow L_{b}^{\alpha+2}$. Let $\left\{f_{n}\right\}_{n} \subset H_{a}^{1}$ be a minimizing sequence for the Weinstein functional

By choosing $\lambda_{n}>0$ and $\mu_{n}>0$ such that $g_{n}(x)=\lambda_{n} f_{n}\left(\mu_{n} x\right)$ satisfy $\left\|\sqrt{\mathcal{L}_{a}} g_{n}\right\|_{L^{2}}=\left\|g_{n}\right\|_{L^{2}}=1$, and noting that $J_{a}\left(f_{n}\right)=J_{a}\left(g_{n}\right)$ for all $n$, we may assume, by compactness, that $\left\{g_{n}\right\}_{n}$ converges strongly to $g$ in $L_{b}^{\alpha+2}$ (see Lemma 3.1) and by reflexiveness, weakly in $H_{a}^{1}$. Moreover, since $|\nabla| f\left|\left|\leq|\nabla f|\right.\right.$ for all $f \in H_{a}^{1}$, we can assume that $g \geq 0$. Furthermore, by Hölder, Hardy and Sobolev, we see that $J_{a}^{*}=\inf _{f \in H_{a}^{1} \backslash\{0\}} J(f)>0$, and since $\left\{g_{n}\right\}_{n}$ is a minimizing sequence,

$$
\int|x|^{-b}|g(x)|^{\alpha+2} d x=\frac{1}{J_{a}^{*}} \in(0,+\infty)
$$

This shows that $g \neq 0$. Now note that $\left\|\sqrt{\mathcal{L}_{a}} g\right\|_{L}^{2}=\|g\|_{L}^{2}=1$, since otherwise it would contradict the minimality of $J_{a}(g)=J_{a}^{*}$. Defining $C_{a}:=\left(J_{a}^{*}\right)^{-1}$, one sees that (3.1) holds.

The Euler-Lagrange equation for $g$ gives

$$
J_{a}^{*} \frac{N \alpha+2 b}{2} \mathcal{L}_{a} g+J_{a}^{*}\left[\frac{4-2 b-\alpha(N-2)}{2}\right] g-(\alpha+2) g^{\alpha+1}=0 .
$$

Finally, defining $g(x)=\lambda Q(\mu x)$, with

$$
\lambda=\left\{\frac{[4-2 b-\alpha(N-2)] J_{a}^{*}}{2(\alpha+2)}\right\}^{\frac{1}{\alpha}}
$$

and

$$
\mu=\frac{4-2 b-\alpha(N-2)}{N \alpha+2 b},
$$

one sees that $Q$ solves (3.2).
In the following lemma we obtain Pohozaev-type identities which are satisfied by any solution of (3.2). The proof follows multiplying (3.2) by Q and $x \cdot \nabla Q$ and using integration by parts. We omit the details.

Lemma 3.3 (Pohozaev identities). If $Q \in H_{a}^{1}$ is a solution to (3.2), then the following identities hold

$$
\begin{align*}
& \int\left|\sqrt{\mathcal{L}_{a}} Q\right|^{2} d x=\left(\frac{N \alpha+2 b}{4-2 b-\alpha(N-2)}\right)\|Q\|_{L^{2}}^{2}  \tag{3.3}\\
& \int|x|^{-b}|Q|^{\alpha+2} d x=\left(\frac{2(\alpha+2)}{4-2 b-\alpha(N-2)}\right)\|Q\|_{L^{2}}^{2} \tag{3.4}
\end{align*}
$$

In particular, one can write the mass (and therefore the quantities in (3.3) and (3.4)) in terms of the sharp constant $C_{a}$. Namely,

$$
M[Q]=\left\{\frac{2(\alpha+2)}{N \alpha+2 b} \frac{[4-2 b-\alpha(N-2)] \frac{N \alpha-(4-2 b)}{4}}{C_{a}}\right\}^{\frac{1}{\alpha+2}}
$$

With the previous results we show Proposition 1.1
Proof of Proposition 1.1. The existence part of Proposition 1.1 follows from Lemma 3.2, and the uniqueness of the mass, $\dot{H}_{a}^{1}$ and energy follows from Lemma 3.3.
3.2. Global behavior in the mass-critical case. We now study the global existence and blowup in $H_{a}^{1}$ of (1.1), when $\alpha=\frac{4-2 b}{N}$ and $\lambda=1$. We start by proving the global well-posedness.

### 3.2.1. Global well-posedness.

Proof of Theorem 1.2 a ). We make use here of the sharp Gagliardo-Nirenberg-type inequality (Lemma 3.2) in the case $\alpha=\frac{4-2 b}{N}$ :

$$
\int|x|^{-b}|f|^{\frac{4-2 b}{N}+2} d x \leq \frac{2-2 b+N}{N}\left\|\sqrt{\mathcal{L}_{a}} f\right\|_{L^{2}}^{2}\left(\frac{\|f\|_{L^{2}}}{\|Q\|_{L^{2}}}\right)^{\frac{4-2 b}{N}}
$$

By energy conservation:

$$
\begin{aligned}
E\left[u_{0}\right] & =\frac{1}{2}\left\|\sqrt{\mathcal{L}_{a}} u(t)\right\|_{L^{2}}^{2}-\frac{N}{4-2 b+2 N} \int|x|^{-b}|u(t)|^{\frac{4-2 b}{N}+2} d x \\
& \geq \frac{1}{2}\left\|\sqrt{\mathcal{L}_{a}} u(t)\right\|_{L^{2}}^{2}\left[1-\left(\frac{\left\|u_{0}\right\|_{L^{2}}}{\|Q\|_{L^{2}}}\right)^{\frac{4-2 b}{N}}\right]
\end{aligned}
$$

Therefore, if $\left\|u_{0}\right\|_{L^{2}}<\|Q\|_{L^{2}}$, the corresponding solution $u$ extends globally in time.
3.2 .2 . Blow-up. The main tool to prove the blow-up results is the Virial identity.

Lemma 3.4 (Virial identity). Let $\varphi: \mathbb{R}^{N} \rightarrow \mathbb{R}$ be a real weight. Define

&+4 \operatorname{Re} \sum_{i, j} \int \varphi_{i j} \bar{u}_{i} u_{j} d x+4 a \int \frac{x \cdot \nabla \varphi}{|x|^{4}}|u|^{2} d x \\
&-\int|u|^{2} \Delta \Delta \varphi d x .
\end{aligned}
$$

Proof. The proof is considered standard, see for instance [12, 21].
Proof of Theorem 1.2b). The blow-up for fast-decaying, negative-energy solutions is proved using Glassey's argument, with the Virial identity by taking $\phi=|x|^{2}$. It means,

We now show for radial solutions. Define $\psi:(0,+\infty) \rightarrow \mathbb{R}$ as

& -4 \int\left(2-\psi^{\prime \prime}(|x| / R)\right)|\nabla u|^{2} d x-4 a \int\left(2-\frac{x \cdot \nabla \phi_{R}}{|x|^{2}}\right) \frac{1}{|x|^{2}}|u|^{2} d x-\int \Delta \Delta \phi_{R}|u|^{2} d x \\
\leq & 16 E\left[u_{0}\right]-4 \int\left(2-\psi^{\prime \prime}(|x| / R)\right)|\nabla u|^{2} d x+O\left(\frac{1}{R^{b}} \int_{|x| \geq R}\left[\eta_{R}(x)|u| \frac{4-2 b}{N}|u|^{2} d x\right)+O\left(\frac{1}{R^{2}} \int|u|^{2} d x\right),\right.
\end{aligned}
$$

where

\eta_{R}(x)=\left\{\frac{1}{2-b+N}\left[(4-2 b)\left(2 N-\Delta \phi_{R}(x)\right)+2 N b\left(2-\frac{x \cdot \nabla \phi_{R}(x)}{|x|^{2}}\right)\right]\right\}^{\frac{N}{4-2 b}}

By mass conservation, we are left to control the third term in the last inequality, if $R>0$ is large enough. We use Strauss and Young inequalities:

### 3.3. Global behavior for the intercritical case.

We now state some coercivity-type (also known as energy-trapping) results for the $\mathrm{INLS}_{a}$, which are necessary for Theorem 1.3
Lemma 3.5. Let $N \geq 3$, $a, \alpha$ and $b$ as in Theorem 1.3, and $f \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$. Assume that, for some $\delta_{0}>0$,

\end{equation*}

In particular, if

& \geq \frac{1}{2}\left(\|f\|_{L^{\frac{1-s_{c}}{s_{c}}}}^{s^{2}}\left\|\sqrt{\mathcal{L}_{a}} f\right\|_{L^{2}}\right)^{2}-\frac{C_{a}}{\alpha+2}\left(\|f\|_{L^{\frac{1-s_{c}}{s_{c}}}}\left\|\sqrt{\mathcal{L}_{a}} f\right\|_{L^{2}}\right)^{\frac{N \alpha+2 b}{2}} .
\end{aligned}
$$

Let $P(y)=\frac{1}{2} y^{2}-\frac{C_{a}}{\alpha+2} y^{\frac{N \alpha+2 b}{2}}$ and $y(f)=\|f\|_{L^{2}}^{\frac{1-s_{c}}{s_{c}}}\left\|\sqrt{\mathcal{L}_{a}} f\right\|_{L^{2}}$. By Lemmas 3.2 and 3.3, we see that, if $f=Q$, then $y^{*}:=y(Q)$ satisfies $P\left(y^{*}\right)=M[Q]^{\frac{1-s_{c}}{s_{c}}} E_{a}[Q]$. Since $P$ is continuous, increasing if $y<y^{*}$, and decreasing if $y>y^{*}$, we conclude that there exists $\delta_{0}>0$ such that.

(1+\epsilon) \int\left|\sqrt{\mathcal{L}_{a}} f\right|^{2}+ & \left(\frac{N-b}{\alpha+2}-\frac{N}{2}\right) \int|x|^{-b}|f|^{\alpha+2} \\
= & \frac{N \alpha+2 b}{2} E_{a}[f]-\left[\frac{N}{2}\left(\alpha-\frac{4-2 b}{N}\right)-\epsilon\right] \int\left|\sqrt{\mathcal{L}_{a}} f\right|^{2} \\
\leq & \left(1-\delta_{0}\right) \frac{N \alpha+2 b}{2} M[f]^{-\frac{1-s_{c}}{s_{c}}} M[Q]^{\frac{1-s_{c}}{s_{c}}} E_{a}[Q] \\
& -\left[\frac{N}{2}\left(\alpha-\frac{4-2 b}{N}\right)-\epsilon\right] M[f]^{-\frac{1-s_{c}}{s_{c}}}\left(y^{*}\right)^{2} \\
= & M[f]^{-\frac{1-s_{c}}{s_{c}}} M[Q]^{\frac{1-s_{c}}{s_{c}}} \underbrace{\left(\int\left|\sqrt{\mathcal{L}_{a}} Q\right|^{2}+\left(\frac{N-b}{\alpha+2}-\frac{N}{2}\right) \int|x|^{-b}|Q|^{\alpha+2}\right)}_{=0} \\
& -M[f]^{-\frac{1-s_{c}}{s_{c}}}\left(\frac{N \alpha+2 b}{2} \delta_{0} M[Q]^{\frac{1-s_{c}}{s_{c}}} E_{a}[Q]-\epsilon\left(y^{*}\right)^{2}\right) .
\end{aligned}
$$

Hence, by taking, say,

An immediate consequence of Lemma 3.5 and mass and energy conservation we obtain the following.

Lemma 3.7. Let $N \geq 3$, $a, \alpha$ and $b$ as in Theorem 1.3, and $u_{0} \in H^{1}\left(\mathbb{R}^{N}\right)$. Denote by $I$ the maximal time of existence of the corresponding solution $u$ to (1.1). If $u_{0}$ satisfies (3.5) and (3.6), then

In particular, $\sup _{t \in I}\|u(t)\|_{H_{a}^{1}}<+\infty$, which implies $I=(-\infty,+\infty)$. Alternatively, if $u_{0}$ satisfies (3.5) and (3.7), then for all $t \in I$,

Proof of Theorem [1.3. Theorem [1.3 a ) follows directly from Lemma 3.7.
Now we prove Theorem 1.3 b). Given Lemmas 3.6 and 3.7, the result for $|x| u_{0} \in L^{2}$ follows from Lemma 3.4. which gives, in this context:

which shows that $u$ blows up in both finite positive and negative times.
To prove blow-up in the radial case, we employ Lemma 3.4 again. Define $\psi:(0,+\infty) \rightarrow \mathbb{R}$ as a smooth function satisfying

By Lemma 3.4. the non-negativity of $\psi^{\prime \prime}$ and the radiality of $u$,

& -\left(\frac{4}{\alpha+2}-2\right) \int_{R \leq|x| \leq 2 R} \Delta \phi_{R}|x|^{-b}|u|^{\alpha+2} d x+\frac{4 b}{\alpha+2} \int_{R \leq|x| \leq 2 R} x \cdot \nabla \phi_{R}|x|^{-b-2}|u|^{\alpha+2} d x \\
& -4 \int_{R \leq|x| \leq 2 R} \psi^{\prime \prime}(|x| / R)|\nabla u|^{2} d x-4 a \int_{R \leq|x| \leq 2 R} \frac{x \cdot \nabla \phi_{R}}{|x|^{4}}|u|^{2}-\int \Delta \Delta \phi_{R}|u|^{2} d x \\
& \leq 8\left[\int\left|\sqrt{\mathcal{L}_{a}} f\right|^{2} d x+\left(\frac{N-b}{\alpha+2}-\frac{N}{2}\right) \int|x|^{-b}|f|^{\alpha+2} d x\right]+O\left(\frac{1}{R^{b}} \int_{|x| \geq R}|u|^{\alpha+2}\right)+O\left(\frac{1}{R^{2}} \int|u|^{2}\right)
\end{aligned}
$$

By the coercivity lemmas and mass conservation, we are left to control the middle term in the last inequality, if $R>0$ is large enough. We use Strauss and Young inequalities:

& \lesssim \epsilon\|\nabla u\|_{L^{2}}^{2}+C(\epsilon)\left(\frac{1}{R^{\frac{\alpha(N-1)+2 b}{2}}}\|u\|_{L^{2}}^{2+\frac{\alpha}{2}} d x\right)^{\frac{4}{4-\alpha}}
\end{aligned}

Thus, by Lemma 3.6, by choosing $R>0$ depending only on the mass of $u$, we have, for all times

## 4. Well-posedness theory via Kato's method

In this section we prove the well-posedness results using the Kato method. The proofs follow from a contraction mapping argument based on the Strichartz estimates. In view of the singular factor $|x|^{-b}$ in the nonlinearity, we will divide our analysis in two regions. Indeed, consider a unit ball, $B=\left\{x \in \mathbb{R}^{N} ;|x| \leq 1\right\}$. A simple computation reveals that

\left\||x|^{-b}\right\|_{L^{\gamma}(B)}<+\infty \quad \text { if } \quad \frac{N}{\gamma}-b>0 \quad \text { and } \quad\left\||x|^{-b}\right\|_{L^{\gamma}\left(B^{C}\right)}<+\infty \quad \text { if } \quad \frac{N}{\gamma}-b<0 \tag{4.1}
\end{equation*}
$$

Moreover, if $F(x, z)=|x|^{-b}|z|^{\alpha} z$, then

$$
\begin{equation*}
|F(x, z)-F(x, w)| \lesssim|x|^{-b}\left(|z|^{\alpha}+|w|^{\alpha}\right)|z-w| \tag{4.2}
\end{equation*}
$$

Before stating the lemmas, we define the norm

\end{equation*}

where $J \subseteq \mathbb{R}$. For this norms, it is worth mentioning the following:
Remark 4.1. Since we use the equivalence of Sobolev spaces in $\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2}\right)}$, for these terms we only employ $S$-admissible pairs which satisfy the conditions of Remark 2.2. that is, $1<r<\frac{N}{s}$ if $a>0$ and $\frac{N}{N-\rho}<r<\frac{N}{s+\rho}$ if $a<0$. We do the same with $\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S^{\prime}\left(L^{2}\right)}$.
4.1. Local Theory. First, we establish good estimates for the nonlinearity in the Strichartz spaces.

Lemma 4.2. Let $N \geq 3,0<b<\min \left\{\frac{N}{2}, 2\right\}$ and $a>-\frac{(N-2)^{2}}{4}+\left(\frac{\alpha(N-2)-(2-2 b)}{2(\alpha+1)}\right)^{2}$. If $\max \left\{0, \frac{2-2 b}{N-2}\right\}<\alpha<\frac{4-2 b}{N-2}$, then the following statement holds
(i) $\left\||x|^{-b}|u|^{\alpha} v\right\|_{L_{I}^{2} L_{x}^{\frac{2 N}{N+2}}} \leq c\left(T^{\theta_{1}}+T^{\theta_{2}}\right)\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2} ; I\right)}^{\alpha}\|v\|_{S\left(L^{2} ; I\right)}$
(ii) $\left\|\sqrt{\mathcal{L}_{a}}\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{L_{I}^{2} L_{x}^{\frac{2 N}{N+2}}} \leq c\left(T^{\theta_{1}}+T^{\theta_{2}}\right)\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2} ; I\right)}^{\alpha+1}$,
where $c, \theta_{1}, \theta_{2}>0$ and $I=[0, T]$.
Proof. We start with (ii). By using the equivalence of Sobolev spaces (Remark 2.2) and dividing the estimate in $B$ and $B^{C}$, we have

\left\|\sqrt{\mathcal{L}_{a}}\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{L_{I}^{2} L_{x}^{\frac{2 N}{N+2}}} & \lesssim\left\|\nabla\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{L_{I}^{2} L_{x}^{\frac{2 N}{N+2}}} \\
& \leq\left\|\nabla\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{L_{I}^{2} L_{x}^{\frac{2 N}{x+2}}\left(B^{C}\right)}+\left\|\nabla\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{L_{I}^{2} L_{x}^{\frac{2 N}{x+2}}(B)}
\end{aligned}
$$

Let $A \subset \mathbb{R}^{N}$ denotes either $B$ or $B^{C}$. Applying Hölder's inequality first in space and then in time, we deduce

& \lesssim\left\|\left\||x|^{-b}\right\|_{L^{\gamma}(A)}\right\| u\left\|_{L_{x}^{\alpha r_{1}}}^{\alpha}\right\| \nabla u\left\|_{L_{x}^{r}}+\right\||x|^{-b-1}\left\|_{L^{d}(A)}\right\| \nabla u\left\|_{L_{x}^{r}}^{\alpha+1}\right\|_{L_{I}^{2}}  \tag{4.5}\\
& \lesssim T^{\frac{1}{q^{*}}}\left(\left\||x|^{-b}\right\|_{L^{\gamma}(A)}\|\nabla u\|_{L_{I}^{q} L_{x}^{r}}^{\alpha+1}+\left\||x|^{-b-1}\right\|_{L^{d}(A)}\|\nabla u\|_{L_{I}^{q} L_{x}^{r}}^{\alpha+1}\right.

where we also have used the Sobolev inequality. Here, we must have the relations

Our goal is to find a pair $(q, r) L^{2}$-admissible such that $\left\||x|^{-b}\right\|_{L^{\gamma}(B)}$ and $\left\||x|^{-b-1}\right\|_{L^{d}(B)}$ are finite (see (4.1)), $r<N$ and $\frac{1}{q^{*}}>0$. Let $\left(q_{ \pm}, r_{ \pm}\right)$defined by ${ }^{9}$

On the other hand, if $A=B$ we choose the pair $(q, r)=\left(q_{-}, r_{-}\right)$and $\theta_{2}=\frac{1}{q_{-}^{*}}$, sc 10 we also get $\left\||x|^{-b}\right\|_{L^{\gamma}(B)},\left\||x|^{-b-1}\right\|_{L^{d}(B)}<\infty$. Hence, the relations (4.4) and (4.5) implies that

In addition, $r<\frac{N}{1+\rho}$ is equivalent to $2 \rho(\alpha+1)<N-2 b$ with $b<\frac{N}{2}$, which is true assuming our hypothesis on $a$.

We need to show that $H^{1} \hookrightarrow L^{\alpha r_{1}}$ and $\frac{N}{\gamma}-b=\frac{N}{d}-b-1<0$. To this end, we choose $r_{1}=\frac{N}{1-b+\varepsilon}$ for $\varepsilon>0$ small, we have $2<\alpha r_{1}<\frac{2 N}{N-2}$ by hypothesis $\frac{2(1-b)}{N}<\alpha \leq \frac{2(1-b)}{N-2}$.

To show (i) is only replace $|x|^{-b}|u|^{\alpha} \nabla u$ by $|x|^{-b}|u|^{\alpha} v$ in the proof of (ii). This completes the proof of Lemma 4.3

Now, with the previous lemmas in hand we are in a position to prove Theorem 1.4 .
Proof of Theorem 1.4. We use the contraction mapping principle. To do so, we define

where $I=[0 . T]$ and $\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S^{2}\left(L^{2} ; I\right)}$ is defined in (4.3).
Let us first show that $G$ is well defined from $S(m, T)$ to $S(m, T)$. Indeed, it follows from the Strichartz inequalities in Lemma 2.5 together with Lemmas 4.2 and 4.3 that

[^9]4.2. Small Global Theory. In this subsection, we turn our attention to prove the small data global results. Similarly as in the local theory, we establish suitable estimates on the nonlinearity 14 $F(x, u, v)=|x|^{-b}|u|^{\alpha} v$. It is worth mentioning that, since (2.8) holds for radial data, we obtain global results for radial initial data and also nonradial data. To this end, we use the norms $\|u\|_{S\left(\dot{H}^{s_{c}}\right)}$ and $\|u\|_{\tilde{S}_{\left(\dot{H}^{s_{c}}\right)}}$, respectively.

We first obatin estimates for $a>0$ and in the sequel for $a<0$. For $a>0$, we use the results obtained by the second author [16]. Recalling the numbers used in [16].

The first lemma will be used to prove the global well posedness in the radial case.
Lemma 4.4. Let $N \geq 3, \frac{4-2 b}{N}<\alpha<\frac{4-2 b}{N-2}$ and $0<b<\min \left\{\frac{N}{2}, 2\right\}$. If $a>0$, then there exists $\theta \in(0, \alpha)$ sufficiently small such that
(i) $\|F(x, u, v)\|_{S^{\prime}\left(\dot{H}^{-s_{c}}\right)} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{S\left(\dot{H}^{s c}\right)}^{\alpha-\theta}\|v\|_{S\left(\dot{H}^{s_{c}}\right)}$
(ii) $\|F(x, u, v)\|_{S^{\prime}\left(L^{2}\right)} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{S\left(\dot{H}^{s}\right)}^{\alpha-\theta}\|v\|_{S\left(L^{2}\right)}$
(iii) $\left\|\sqrt{\mathcal{L}_{a}} F(x, u)\right\|_{L_{t}^{\hat{q}^{\prime}} L_{x}^{\hat{\gamma}^{\prime}}} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{S\left(\dot{H}^{s_{c}}\right)}^{\alpha-\theta}\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2}\right)} \quad$ if $N \geq 4$
(iv) $\left\|\sqrt{\mathcal{L}_{a}} F(x, u)\right\|_{L_{t}^{2} L_{x}^{\frac{6}{5}}} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{S\left(\dot{H}^{s}\right)}^{\alpha-\theta}\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2}\right)} \quad$ if $N=3$ and $\alpha<3-2 b$.

Proof. See [16, Lemmas 4.1 and 4.2, with $s=1$ ] to show (i) and (ii), respectively ${ }^{15}$. To show (iii) we used the estimate used in [16, Lemma 4.3] with $s=1$, i.e.,

We notice that, if $N \geq 4$ then $\widehat{r}<N$ and $\widehat{r}^{\prime}<N$, so the equivalence of Sobolev spaces (Remark 2.2 with $s=1$ ) implies (iii). Finally, we consider (iv). To this end, we use the following numbers.

\frac{3}{d}=\frac{3}{2}+1-\frac{3}{r_{1}}-\frac{3(\alpha-\theta)}{r}-\frac{3}{e}=\frac{3}{2}+1-\frac{3}{r_{1}}-\frac{3(\alpha-\theta)}{r}-\left(\frac{3}{r_{\varepsilon}}-1\right)
\end{array}\right.
$$

[^10]which implies using the definition of the numbers $r$ and $r_{\varepsilon}$ (see (4.8)-(4.9) ) that

If $A=B$ we choose $\theta r_{1}=\frac{2 N}{N-2}$, so that $\frac{N}{\gamma}-b=\theta\left(1-s_{c}\right)>0$ (recall that $s_{c}<1$ ). On the other hand, if $A=B^{C}$ we choose $\theta r_{1}=2$, so that $\frac{N}{\gamma}-b=-\theta s_{c}<0$. Thus, the quantities $\left\||x|^{-b}\right\|_{L^{\gamma}(A)}$, $\left\||x|^{-b-1}\right\|_{L^{d}(A)}<\infty$ and $H_{x}^{1} \hookrightarrow L^{\theta r_{1}}$. Therefore, since $\frac{1}{2}=\frac{\alpha-\theta}{a}+\frac{1}{q_{\varepsilon}}$ one has

Our goal now is to show the radial small data result (Theorem 1.8).
Proof of Theorem 1.8. As usual, our proof is based on the contraction mapping principle. Indeed, define

\|G(u)\|_{S\left(L^{2}\right)} \leq c\left\|u_{0}\right\|_{L^{2}}+c\|F(x, u)\|_{S^{\prime}\left(L^{2}\right)}
\end{gathered}
$$

and

$$
\left\|\sqrt{\mathcal{L}_{a}} G(u)\right\|_{S\left(L^{2}\right)} \leq c\left\|\sqrt{\mathcal{L}_{a}} u_{0}\right\|_{L^{2}}+c\left\|\sqrt{\mathcal{L}_{a}} F(x, u)\right\|_{S^{\prime}\left(L^{2}\right)}
$$

where $F(x, u)=|x|^{-b}|u|^{\alpha} u$. On the other hand, it follows from Lemma 4.4 and the three last inequalities that, for $u \in S$

& \leq\left\|e^{-i t \mathcal{L}_{a}} u_{0}\right\|_{S\left(\dot{H}^{s_{c}}\right)}+2^{\alpha+1} c^{\theta+1} M^{\theta}\left\|e^{-i t \mathcal{L}_{a}} u_{0}\right\|_{S\left(\dot{H}^{s_{c}}\right)}^{\alpha-\theta+1}
\end{aligned}
$$

and

\begin{aligned}
\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle G(u)\right\|_{S\left(L^{2}\right)} & \leq c\left\|u_{0}\right\|_{H_{a}^{1}}+c\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{S\left(\dot{H}^{s}\right)}^{\alpha-\theta}\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2}\right)} \\
& \leq c\left\|u_{0}\right\|_{H_{a}^{1}}+c^{\theta+2} 2^{\alpha+1} M^{\theta}\left\|e^{-i t \mathcal{L}_{a}} u_{0}\right\|_{S\left(\dot{H}^{s}\right)}^{\alpha-\theta}\left\|u_{0}\right\|_{H_{a}^{1}} .
\end{aligned}
$$

Now if $\left\|U(t) u_{0}\right\|_{S\left(\dot{H}^{s_{c}}\right)}<\delta$ with

that is $G(u) \in S$.
To prove that $G$ is a contraction on $S$, we repeat the above computations. Indeed, taking $u, v \in S$

By using the last inequalities and (4.11) we obtain

Therefore, by the Banach Fixed Point Theorem, $G$ has a unique fixed point $u \in S$, which is a global solution of (1.1).

Remark 4.5. Observe that Theorem 1.4 (when $N=3$ ) shows global well posedness with an extra condition on $\alpha$, i.e., $\alpha<3-2 b$. We now establish suitable estimates on $F(x, u, v)$ for the full intercritical regime, that is, $\frac{4-2 b}{3}<\alpha<4-2 b$.

Before stating the lemma, we first define the following numbers

Lemma 4.6. Let $N=3$ and $a>0$. If $0<b<\frac{3}{2}$ and $\max \left\{\frac{4-2 b}{3}, 1\right\}<\alpha<4-2 b$, then the following statements hold

(ii) $\left\|\sqrt{\mathcal{L}_{a}} F(x, u)\right\|_{L_{t}^{2} L_{x}^{\frac{6}{5}}} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{L_{t}^{\bar{a}} L_{x}^{\overline{5}}}^{\alpha-\theta}\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2}\right)}$
(iii) $\left\|{\sqrt{\mathcal{L}_{a}}}^{s_{c}} F(x, u)\right\|_{L_{t}^{2} L_{x}^{\frac{6}{5}}} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{L_{t}^{\bar{a}} L_{x}^{\tilde{r}}}^{\alpha-\theta}\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2}\right)}$,
where $\theta$ is sufficiently small.

Hence, in view of $(q, r)$ is $S$-admissible we obatin (i). We now consider (ii). The equivalence of Sobolev spaces implies that

The derivate of $F$ leads to two terms, one of the form $|x|^{-b}|u|^{\alpha} \nabla u$ and one of the form $|x|^{-b-1}|u|^{\alpha} u$, so for estimating the first one we replace $v$ by $\nabla u$ in (i). Thus,

& \lesssim\|u\|_{L_{t}^{\infty} H_{x}^{1}}^{\theta}\|u\|_{L_{t}^{\bar{a}} L_{x}^{\bar{x}}}^{\alpha-\theta}\|\nabla\|_{L_{t}^{q} L_{x}^{r}},
\end{aligned}
$$

where $\frac{3}{d}-b-1=\frac{\theta(2-b)}{\alpha}-\frac{3}{r_{1}}$. Again the last relation is the same relation as in (4.10). Therefore, applying the equivalence of Sobolev spaces (since $r<3$ ) together with (4.14), one has

& \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{L_{t}^{\bar{a}} L_{x}^{\bar{x}}}^{\alpha-\theta}\|u\|_{S\left(L^{2}\right)}^{1-s_{c}}\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2}\right)}^{s_{c}} .
\end{aligned}

This completes the proof of the lemma.
Remark 4.7. Note that, in Lemma 4.6 the pair $(\bar{a}, \bar{r})$ is not $S\left(\dot{H}^{s_{c}}\right)$-admissible due to $\bar{r}<6$ not being true for $\alpha \geq 3-2 b$. However, we obtain a small data global result assuming $\left\|e^{-i t \mathcal{L}_{a}} u_{0}\right\|_{L_{t}^{\bar{a}} L_{x}^{\overline{\bar{x}}}}$ sufficiently small. For the proof of this result (Theorem [1.9) we do not use the Strichartz estimate (2.8) in view of $(\bar{a}, \bar{r})$ not being $\dot{H}^{s_{c}}$-admissible. Instead, use the Sobolev embedding and apply the Strichartz estimate (2.7). This is possible since the $S$-admissible pair used satisfies the conditions (2.2). It is also worth mentioning that, since we do not use (2.8) then the result holds for nonradial data.

Proof of Theorem 1.9, We only show (i) since (ii) and (ii) are immediate consequences. As before, define

& \leq\left\|e^{-i t \mathcal{L}_{a}} u_{0}\right\|_{\tilde{S}\left(\dot{H}^{s_{c}}\right)}+c \|{\sqrt{\mathcal{L}_{a}}{ }^{s_{c}} F(x, u) \|_{L_{t}^{2} L_{x}^{2 N}},}^{\frac{2 N}{N+2}}
\end{aligned}
$$

wher 18

which implies that $G$ is also a contraction. Therefore, by the contraction mapping principle, $G$ has a unique fixed point $u \in S$.

We end this section with the proof of Theorem 1.10. To this end, we establish good estimates on the nonlinearity, for negative values of $a$.
Lemma 4.8. Let $0<b<\frac{6-N}{2}$. Assume that ( $N, a, \alpha$ ) satisfy

$$
\begin{cases}a>-\frac{(N-2)^{2}}{4} & \text { if } N=3, \quad \frac{4-2 b}{3}<\alpha \leq 2-2 b \quad \text { and } 0 \leq b<\frac{1}{2}  \tag{4.16}\\ a>-\frac{(N-2)^{2}}{4}+\left(\frac{\alpha(N-2)-(2-2 b)}{2(\alpha+1)}\right)^{2} & \text { if } 3 \leq N \leq 5, \quad \max \left\{\frac{4-2 b}{N}, \frac{2-2 b}{N-2}, 1\right\}<\alpha<\frac{4-2 b}{N-2}\end{cases}
$$

Then the following statements hold
(i) $\|F(x, u, v)\|_{L_{t}^{2} L_{x}^{\frac{2 N}{N+2}}} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{L_{t}^{\bar{a}} L_{x}^{\bar{x}}}^{\alpha-\theta}\|v\|_{S\left(L^{2}\right)}$
(ii) $\left\|\sqrt{\mathcal{L}_{a}} F(x, u)\right\|_{L_{t}^{2} L_{x}^{\frac{2 N}{N+2}}} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{L_{t}^{\bar{a}} L_{x}^{\bar{F}}}^{\alpha-\theta}\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2}\right)}$
(iii) $\left\|{\sqrt{\mathcal{L}_{a}}}^{{ }^{c}} F(x, u)\right\|_{L_{t}^{2} L_{x}^{\frac{2 N}{N+2}}} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{L_{t}^{\bar{a}} L_{x}^{\bar{\sigma}}}^{\alpha-\theta}\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2}\right)}$,
where $\theta$ is sufficiently small.
Proof. In view of (4.16) we have two cases:
Case 1. For $N=3, \frac{4-2 b}{N}<\alpha \leq 2-2 b$ and $0 \leq b<\frac{1}{2}$, we define

$$
\bar{a}=\frac{2(\alpha-\theta)}{1-\theta}, \quad \bar{r}=\frac{3 \alpha(\alpha-\theta)}{\alpha(1-b)-\theta(2-b-\alpha)}, \quad q=\frac{2}{\theta} \quad \text { and } \quad r=\frac{6}{3-2 \theta} .
$$

Case 2. For $3 \leq N \leq 5$ and $\max \left\{\frac{2-2 b}{N-2}, \frac{4-2 b}{N}, 1\right\}<\alpha<\frac{4-2 b}{N-2}$, define

\bar{a}=\frac{4(\alpha+1)(\alpha-\theta)}{4-2 b-\alpha(N-4)} \quad \bar{r}=\frac{2 N \alpha(\alpha+1)(\alpha-\theta)}{\alpha^{2}(N-2 b)-\theta(4-2 b)(\alpha+1)}
$$

and

$$
q=\frac{4(\alpha+1)}{\alpha(N-2)-2+2 b} \quad r=\frac{2 N(\alpha+1)}{2(\alpha+1)+N-2 b} .
$$

Note that, the hypothesis (4.16) yields $\frac{N}{N-\rho}<r<\frac{N}{1+\rho}$ and $(q, r)$ is S-admissible. Moreover, since $\theta$ is small, $b<\frac{N}{2}$ and $\alpha>\frac{2-2 b}{N-2}$, we get $2<r<N$.

[^12]The proof is similar as in Lemma 4.6. We first consider (i). Let $A=\left\{B, B^{C}\right\}$. It follows that (using $\frac{1}{2}=\frac{\alpha-\theta}{\bar{a}}+\frac{1}{q}$ )

where $\frac{N}{\gamma}=\frac{N+2}{2}-\frac{N}{r_{1}}-\frac{N(\alpha-\theta)}{\bar{r}}-\frac{N}{r}$. Hence, the values of $\bar{r}$ and $r$ imply

$$
\frac{N}{\gamma}-b=\frac{\theta(2-b)}{\alpha}-\frac{N}{r_{1}}
$$

which is the same relation as in (4.10), so arguing as in Lemma 4.6 and since $(q, r)$ is $S$-admissible we deduce (i). Let us prove (ii). From the equivalence of Sobolev spaces we know that

$$
\begin{equation*}
\left\|\sqrt{\mathcal{L}_{a}}\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{L_{t}^{2} L_{x}^{\frac{2 N}{+2}}} \leq\left\|\nabla\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{L_{t}^{2} L_{x}^{\frac{2 N}{N+2}}} \tag{4.17}
\end{equation*}
$$

We only estimate $|x|^{b-1}|u|^{\alpha} u$. We deduce that (using $1=\frac{N}{r}-\frac{N}{r_{3}}$, with $r<N$ )

\begin{aligned}
\left\||x|^{-b-1}|u|^{\alpha} u\right\|_{L_{t}^{2} L_{x}^{\frac{2 N}{N+2}}(A)} & \leq\| \||x|^{-b-1}\left\|_{L^{d}(A)}\right\| u\left\|_{L_{x}^{\theta r_{1}}}^{\theta}\right\| u\left\|_{L_{x}^{(\alpha-\theta) r_{2}}}^{\alpha-\theta}\right\| u\left\|_{L_{x}^{r_{3}}}\right\|_{L_{t}^{2}} \\
& \lesssim\|u\|_{L_{t}^{\infty} H_{x}^{1}}^{\theta}\|u\|_{L_{t}^{\bar{a}} L_{x}^{\tilde{r}}}^{\alpha-\theta}\|\nabla u\|_{L_{t}^{q} L_{x}^{r}},
\end{aligned}
$$

where we get the same relation as in (4.10), i.e., $\frac{N}{d}-b-1=\frac{\theta(2-b)}{\alpha}-\frac{N}{r_{1}}$. Therefore, again the equivalence of Sobolev spaces together with (4.17) lead to

In addition, applying the interpolation inequality and (i) - (ii) we have (iii), that is

\left\|{\sqrt{\mathcal{L}_{a}}}^{s_{c}} F(x, u)\right\|_{L_{t}^{2} L_{x}^{\frac{2 N}{N+2}}} \lesssim\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{L_{t}^{\bar{a}} L_{x}^{\bar{x}}}^{\alpha-\theta}\|u\|_{S\left(L^{2}\right)}^{1-s_{c}}\left\|\sqrt{\mathcal{L}_{a}} u\right\|_{S\left(L^{2}\right)}^{s_{c}}
$$

Proof of Theorem 1.10. First, we define

$$
\bar{p}=\frac{N \alpha(\alpha-\theta)}{\alpha s_{c}(\alpha-\theta)+\alpha(1-b)-\theta(2-b-\alpha)},
$$

if Case 1 of Lemma 4.8 holds and

$$
\bar{p}=\frac{2 N \alpha(\alpha+1)(\alpha-\theta)}{2 \alpha s_{c}(\alpha+1)(\alpha-\theta)+\alpha^{2}(N-2 b)-\theta(4-2 b)(\alpha+1)},
$$

if Case 2 of Lemma 4.8 holds. Note that, One has that $(\bar{a}, \bar{p})$ is $S$-admissible and $s_{c}=\frac{N}{\bar{p}}-\frac{N}{\bar{r}}$. Moreover, $\bar{p}<\frac{N}{s_{c}}$, for $\theta$ small enough and $2<\bar{p}<\frac{2 N}{N-2}$. Hence, applying Sobolev embedding we get

\left\|\int_{0}^{t} e^{-i(t-s) \mathcal{L}_{a}} F(x, u) d s\right\|_{L_{t}^{\bar{a}} L_{x}^{\bar{x}}} \leq\left\|D^{s_{c}} \int_{0}^{t} e^{-i(t-s) \mathcal{L}_{a}} F(x, u) d s\right\|_{L_{t}^{\bar{a}} L_{x}^{\bar{p}}}
$$

where ${ }^{21} \bar{a}$ and $\bar{r}$ are defined in Lemma 4.8. Thus, with the previous lemma in hand the rest the proof is exactly the same as in Theorem 1.9 ,

## 5. Scattering and existence of wave operator

Our goal here is to show Theorem 1.12 It gives us a criterion to establish scattering and the existence of wave operator. To this end, we use the estimates on the nonlinearity obtained in Section 4. Before proving the theorem itself, we must point out that our estimates in Lemmas 4.4. 4.12 and 4.16 also hold if we replace the norms (in time) on the whole $\mathbb{R}$ by a interval $I \subset \mathbb{R}$. To see this it is sufficient to observe that in all results the only estimates in time we used was the Hölder inequality. We will only prove the result by assuming the assumptions of Theorem 1.8 holds. The other cases are dealt with similarly.

## Proof of Theorem 1.12,

Let's first prove show (i). We claim that if $\|u\|_{S\left(\dot{H}^{s_{c}}\right)}<+\infty$, then

$$
\begin{equation*}
\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2}\right)}<+\infty \tag{5.1}
\end{equation*}
$$

Indeed, we only show $\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2} ;[0, \infty)\right)}<+\infty$. A similar analysis may be performed to see that $\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2} ;(\infty, 0]\right)}<+\infty$. Given $\delta>0$ we decompose the interval $[0, \infty)$ into $n$ intervals $I_{j}=\left[t_{j}, t_{j+1}\right)$ such that $\|u\|_{S\left(\dot{H}^{s_{c} ; I_{j}}\right)}<\delta$, for all $j=1, \ldots, n$. On the time interval $I_{j}$ we consider the integral equation

$$
u(t)=e^{-i\left(t-t_{j}\right) \mathcal{L}_{a}} u\left(t_{j}\right)+i \lambda \int_{t_{j}}^{t} e^{-i(t-s) \mathcal{L}_{a}}\left(|x|^{-b}|u|^{\alpha} u\right)(s) d s
$$

Combining the Strichartz estimates (2.5) and (2.7) together with Lemma 4.4, it follows that

$$
\begin{aligned}
\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2} ; I_{j}\right)} & \leq c\left\|u\left(t_{j}\right)\right\|_{H_{a}^{1}}+c\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{L_{I_{j}}^{2} L_{x}^{\frac{2 N}{N+2}}} \\
& \leq c\left\|u\left(t_{j}\right)\right\|_{H_{a}^{1}}+c\|u\|_{L_{I_{j}}^{\infty} H_{x}^{2}}^{\theta}\|u\|_{S\left(\dot{H}^{s_{c} ; I_{j}}\right)}^{\alpha-\theta} u u \|_{S\left(L^{2} ; I_{j}\right)} \\
& \leq c\left\|u\left(t_{j}\right)\right\|_{H_{a}^{1}}+c M^{\theta} \delta^{\alpha-\theta}\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2} ; I_{j}\right)}
\end{aligned}
$$

where we have used the assumption $\sup _{t \in I_{j}}\|u(t)\|_{H_{a}^{1}} \leq M$. Taking $\delta>0$ such that $\eta^{\theta} \delta^{\alpha-\theta}<\frac{1}{2 c}$ we obtain that $\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2} ; I_{j}\right)} \leq 2 c M$, and by summing over the n intervals, we conclude the proof of (5.1).

Returning to the proof of the theorem, define

$$
\phi^{+}=u_{0}+i \lambda \int_{0}^{+\infty} e^{i(s) \mathcal{L}_{a}}\left(|x|^{-b}|u|^{\alpha} u\right)(s) d s
$$

Note that $\phi^{+} \in H_{a}^{1}\left(\mathbb{R}^{N}\right)$. Following the above steps, one has

$$
\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle \phi^{+}\right\|_{L^{2}} \leq c\left\|u_{0}\right\|_{H_{a}^{1}}+c\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{S\left(\dot{\left.H^{s} c\right)}\right.}^{\alpha-\theta}\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2}\right)}
$$

Hence, applying (5.1) we get the desired result.
Since $u$ is a solution of (1.1), a simple inspection gives

$$
u(t)-e^{-i t \mathcal{L}_{a}} \phi^{+}=-i \lambda \int_{t}^{+\infty} e^{-i(t-s) \mathcal{L}_{a}}|x|^{-b}\left(|u|^{\alpha} u\right)(s) d s
$$

thus as before

$$
\left\|u(t)-e^{-i t \mathcal{L}_{a}} \phi^{+}\right\|_{H_{a}^{1}} \leq c\|u\|_{L_{t}^{\infty} H_{a}^{1}}^{\theta}\|u\|_{S\left(\dot{H}^{s} ;[t, \infty)\right)}^{\alpha-\theta}\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle u\right\|_{S\left(L^{2}\right)} .
$$

By using (5.1) we get $\|u\|_{S\left(\dot{H}^{\left.s_{c} ;[t, \infty)\right)}\right.} \rightarrow 0$ as $t \rightarrow+\infty$, this implies that

In the same way, let $\phi^{-}=u_{0}+i \lambda \int_{0}^{-\infty} e^{i(s) \mathcal{L}_{a}}\left(|x|^{-b}|u|^{\alpha} u\right)(s) d s$, so that we obtain $\phi^{-} \in H_{a}^{1}$ and $\left\|u(t)-e^{-i t \mathcal{L}_{a}} \phi^{+}\right\|_{H_{a}^{1}} \rightarrow 0$, as $t \rightarrow-\infty$. This completes the proof of (i).

We now consider (ii). We will divide the proof in two parts. We first look for a fixed point for the operator

is a solution of (1.1). To this end, let us start by proving that $G$ has a fixed point in $S(T, \rho)$ given by

The Strichartz estimates (2.7), (2.8) and Lemmas 4.4 yield

\|G(w)\|_{S\left(\dot{H}^{\left.s_{c} ; I_{T}\right)}\right.} \lesssim\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{L_{T}^{\infty} H_{a}^{1}}^{\theta}\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{s} ; I_{T}\right)}^{\alpha-\theta}\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{s_{c} ; I_{T}}\right)} \tag{5.2}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle G(w)\right\|_{S\left(L^{2} ; I_{T}\right)} \lesssim\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{L_{T}^{\infty} H_{a}^{1}}^{\theta}\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{\left.s_{c} ; I_{T}\right)}\right.}^{\alpha-\theta}\left\|\left\langle\sqrt{\mathcal{L}_{a}}\right\rangle\left(w+e^{-i t \mathcal{L}_{a}} \phi\right)\right\|_{S\left(L^{2} ; I_{T}\right)} . \tag{5.3}

\|G(w)\|_{T} \lesssim\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{L_{T}^{\infty} H_{x}^{1}}^{\theta}\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{\left.s^{c} ; I_{T}\right)}\right.}^{\alpha-\theta}\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{T}
$$

In view on

$$
\begin{equation*}
\left\|e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{\left.s_{c} ; I_{T}\right)}\right.} \rightarrow 0 \tag{5.4}
\end{equation*}
$$

as $T \rightarrow+\infty$, we can find $T_{0}>0$ large enough and $\rho>0$ small enough such that $G$ is well defined on $S\left(T_{0}, \rho\right)$. In the same way, we show that $G$ is a contraction on $B\left(T_{0}, \rho\right)$. Therefore, there exists a unique $w \in S\left(T_{0}, \rho\right)$ such that $G(w)=w$.

On the other hand, by using the fact that $\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{L_{T}^{\infty} H_{a}^{1}} \leq\|w\|_{H^{1}}+\|\phi\|_{H^{1}}<+\infty$ and (5.2) we deduce

$$
\begin{aligned}
\|w\|_{S\left(\dot{H}^{s_{c}} ; I_{T}\right)} & \lesssim\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{\left.s_{c} ; I_{T}\right)}\right.}^{\alpha-\theta}\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{s_{c}} ; I_{T}\right)} \\
& \lesssim A\|w\|_{S\left(\dot{H}^{\left.s_{c} ; I_{T}\right)}\right.}+A\left\|e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{\left.s_{c} ; I_{T}\right)}\right.},
\end{aligned}
$$

where $A=\left\|w+e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{\left.s_{c} ; I_{T}\right)}\right.}^{\alpha-\theta}$. Observe that, if $\rho$ has been chosen small enough and since $\left\|e^{-i t \mathcal{L}_{a}} \phi\right\|_{S\left(\dot{H}^{\left.s_{c} ; I_{T}\right)}\right.}$ is also sufficiently small for $T$ large, it follows that

& =i \lambda \int_{T_{0}}^{t} e^{-i\left(T_{0}-s\right) \mathcal{L}_{a}}|x|^{-b}\left|w+e^{-i t \mathcal{L}_{a}} \phi\right|^{\alpha}\left(w+e^{-i t \mathcal{L}_{a}} \phi\right)(s) d s+w\left(T_{0}\right)
\end{aligned}
$$

and so applying $e^{-i\left(t-T_{0}\right) \mathcal{L}_{a}}$ and adding $e^{-i t \mathcal{L}_{a}} \phi$ on both sides, we obtain (5.7). Finally, adding $e^{-i t \mathcal{L}_{a}} \phi$ to both sides of the last equation, we deduce (5.7).

Finally, since $u(t)=e^{-i t \mathcal{L}_{a}} \phi+w$ and applying (5.6), we conclude that

$$
\left\|u(t)-e^{-i t \mathcal{L}_{a}} \phi\right\|_{L_{T}^{\infty} H_{x}^{1}}=\|w\|_{L_{T}^{\infty} H_{x}^{1}} \leq c\|w\|_{S\left(L^{2} ; I_{T}\right)}+c\|\nabla w\|_{S\left(L^{2} ; I_{T}\right)} \leq c\|w\|_{T} \rightarrow 0 \text { as } T \rightarrow \infty
$$

which completes the proof.
