# COUNTING CENTRALIZERS OF A FINITE GROUP WITH AN APPLICATION IN CONSTRUCTING THE COMMUTING CONJUGACY CLASS GRAPH

#### Abstract

The set of all centralizers of elements in a finite group $G$ is denoted by $\operatorname{Cent}(G)$ and $G$ is called $n$-centralizer if $|\operatorname{Cent}(G)|=n$. In this paper, the structure of centralizers in a non-abelian finite group $G$ with this property that $\frac{G}{Z(G)} \cong Z_{p^{2}} \rtimes Z_{p^{2}}$ is obtained. As a consequence, it is proved that such a group has exactly $\left[(p+1)^{2}+1\right]$ element centralizers and the structure of the commuting conjugacy class graph of $G$ is completely determined.

## 1. InTRODUCTION

Throughout this paper all groups are assumed to be finite and $C_{G}(x)$ denotes the centralizer of an element $x$ in $G$. If $G$ is a group containing two subgroups $H$ and $N$ such that $N \triangleleft G, H \cap N=1$ and $G=H N$ then $G$ is said to be the semi-direct product of $H$ by $N$ and we write $G=N \rtimes H$. The group $G$ is called capable if there exists another group $H$ such that $G \cong \frac{H}{Z(H)}$. Our other notations are standard and taken mainly from [9] and our calculations are done with the aid of GAP [12].

The center of $G$ is denoted by $Z(G)$ and $\operatorname{Cent}(G)=\left\{C_{G}(x) \mid x \in G\right\}$. The group $G$ is called $n$-centralizer if $n=|\operatorname{Cent}(G)|$ [1]. The study of finite groups with respect to the number of distinct element centralizers was started by Belcastro and Sherman [3]. It is clear that $|\operatorname{Cent}(G)|=1$ if and only if $G$ is abelian and there is no finite group with exactly two or three element centralizers. They proved that if $\frac{G}{Z(G)} \cong \mathbb{Z}_{p} \times \mathbb{Z}_{p}$ then $|\operatorname{Cent}(G)|=p+2$ [3, Theorem 5].

Let $H$ be a graph with vertex set $\{1,2, \cdots, k\}$ and $G_{i}{ }^{\prime}$ s, $1 \leq i \leq k$, are disjoint graphs of order $n_{i}$. Following Sabidussi [10], the graph $H\left[G_{1}, G_{2}, \cdots, G_{k}\right]$ is formed by taking the graphs $G_{1}, G_{2}, \cdots, G_{k}$ and connect a vertex of $G_{i}$ to another vertex in $G_{j}$ whenever

[^0]$i$ is adjacent to $j$ in $H$. The graph $H\left[G_{1}, G_{2}, \cdots, G_{k}\right]$ is called the $H$-join of the graphs $G_{1}, \cdots, G_{k}$.

The notion of commuting conjugacy class graph of a non-abelian group $G, \Gamma(G)$, was introduced by Mohammadian et al. [8]. This is a simple graph with non-central conjugacy classes of $G$ as its vertex set and two distinct vertices $A$ and $B$ are adjacent if and only if there are $x \in A$ and $y \in B$ such that $x y=y x$. In such a case, we also say that two conjugacy classes commute to each other. The authors of the mentioned paper obtained some interesting properties of this graph among them a classification of triangle-free commuting conjugacy class graph of a finite groups is given.

A CA-group is a group in which every noncentral element has an abelian centralizer. The present authors [11], obtained the structure of the commuting conjugacy class graph of finite CA-groups. They proved that this graph is a union of some complete graphs. As a consequence of this work, the commuting conjugacy class graph of dihedral, semi-dihedral, dicyclic and three other families of meta-cyclic groups were constructed.

The following two theorems are the main results of this paper:
Theorem 1.1. Suppose $p$ is a prime number and $G$ is a group with center $Z$ such that $\frac{G}{Z} \cong \mathbb{Z}_{p^{2}} \rtimes \mathbb{Z}_{p^{2}}$. Then $G$ has exactly $\left[(p+1)^{2}+1\right]$ element centralizers.

Theorem 1.2. Suppose $p$ is a prime number and $G$ is a group with center $Z$ such that $\frac{G}{Z} \cong \mathbb{Z}_{p^{2}} \rtimes \mathbb{Z}_{p^{2}}$. The commuting conjugacy class graph of $G$ has one of the following types:
(1) $\frac{G}{Z}$ is abelian. In this case, $\frac{G}{Z} \cong \mathbb{Z}_{p^{2}} \times \mathbb{Z}_{p^{2}}$ and the commuting conjugacy class graph of $G$ is isomorphic to $\mathcal{M}_{1}\left[K_{n(p-1)}, \cdots, K_{n(p-1)}, K_{m\left(p^{2}-p\right)}, \cdots, K_{m\left(p^{2}-p\right)}\right]$, where there are $p+1$ copies of $K_{n(p-1)}, p^{2}+p$ copies of $K_{m\left(p^{2}-p\right)}$ and $\mathcal{M}_{1}$ is the graph depicted in Figure 1a. Here, $m=\frac{|Z|}{p^{2}}$ and $n=\frac{|Z|}{p}$.
(2) $\frac{G}{Z}$ is not abelian. In this case, the commuting conjugacy class graph of $G$ is isomorphic to $\mathcal{M}_{2}\left[K_{n(p-1)}, \cdots, K_{n(p-1)}, K_{n\left(p^{2}-p\right)}\right]$, where there are $p^{2}+p+1$ copies of $K_{n(p-1)}$, a copy of $K_{n\left(p^{2}-p\right)}$ and $\mathcal{M}_{2}$ is depicted in Figure 16. Here, $p$ is an odd prime and $n=\frac{|Z|}{p}$.

## 2. Preliminary Results

The aim of this section is to prove some preliminary results which are crucial in next sections. The greatest common divisor of positive integers $r$ and $s$ is denoted by $(r, s)$. We start this section by the following simple lemma:

Lemma 2.1. Let $p$ be a prime number and $G$ be a group with center $Z$ such that $x^{p^{2}}, y^{p} \in$ $Z$. Then, for each positive integer $m$ with this condition that $m \not \equiv 0(\bmod p)$, we have $C_{G}\left(x^{m}\right)=C_{G}(x)$ and $C_{G}\left(y^{m}\right)=C_{G}(y)$.

Proof. By our assumption, $\left(m, p^{2}\right)=1$ and there are $n$ and $k$ such that $m n+k p^{2}=1$. Since $x^{p^{2}} \in Z, C_{G}\left(x^{m}\right) \subseteq C_{G}\left(x^{m n}\right)=C_{G}\left(x^{1-k p^{2}}\right)=C_{G}(x z)=C_{G}(x)$, as desired. The proof of second one is similar and so it is omitted.

Lemma 2.2. Let $G$ be a finite group with center $Z, p| | G \mid$ and $a, b \in G \backslash Z$ such that $o(a Z)=o(b Z)=p^{2}$ and $G=\left\{a^{i} b^{j} z \mid z \in Z\right\}$. Then the following hold:
(a) Suppose $1 \leq i, j \leq p^{2}-1$ and at least one of $i, j$ is not divisible by $p$. Then $a^{i} b^{j} \neq b^{j} a^{i}$.
(b) $C_{G}\left(a^{s} b\right)=C_{G}\left(a^{t} b\right), 1 \leq s, t \leq p^{2}-1$, if and only if $s=t$.

Proof. Our argument consists in showing:
(a) Suppose $1 \leq i, j \leq p^{2}-1$, $a^{i} b^{j}=b^{j} a^{i}$ and at least one of $i, j$ is not divisible by $p$. Without loss of generality we can assume that $j \not \equiv 0(\bmod p)$. Then $\left(j, p^{2}\right)=1$ and so there are integers $m$ and $n$ such that $m j+n p^{2}=1$. Since $b^{p^{2}} \in Z, a^{i} b=b a^{i}$ which means that $a^{i} \in Z$. This implies that $p^{2}=o(a Z) \mid i$, contradict by our condition that $1 \leq i \leq p^{2}-1$.
(b) If $s \neq t$ and $C_{G}\left(a^{s} b\right)=C_{G}\left(a^{t} b\right)$ then $a^{s} b \in C_{G}\left(a^{t} b\right)$ and so $a^{s-t} b=b a^{s-t}$. Again $p^{2}=o(a Z) \mid s-t$ which is impossible.

Hence the result.
The following result is a particular case of [7, Theorem 8.1(c)].

## Theorem 2.3. The non-abelian split extension $\mathbb{Z}_{4} \rtimes \mathbb{Z}_{4}$ is not capable.

Suppose $p$ is a prime number. Then it is easy to see that there are only two groups of order $p^{4}$ that can be written as a semidirect product of two cyclic groups of order $p^{2}$. One of these groups is the abelian group $L_{1}=\mathbb{Z}_{p^{2}} \times \mathbb{Z}_{p^{2}}$ and another one is a group presented as $L_{2}=\left\langle x, y \mid x^{p^{2}}=y^{p^{2}}=1, y x=x^{p+1} y\right\rangle$., see [5, pp. 145,146] for details. For simplicity of our argument, it is useful to write the presentations of $L_{1}$ and $L_{2}$ in the form $\left\langle x, y \mid x^{p^{2}}=y^{p^{2}}=1, y x=x^{r p+1} y\right\rangle$, where $r=0,1$.

Lemma 2.4. Suppose $G=L_{1}$ or $L_{2}$. Then for every $i, j, 0 \leq i, j \leq p^{2}-1$, which are not simultaneously zero, we have:

p & p \mid(i, j) \\
p^{2} & \text { Otherwise }
\end{array} .\right.
$$

Proof. The result is trivial for $L_{1}$. So, it is enough to assume that $r=1$. By definition, for every integers $i$ and $j, 0 \leq i, j \leq p^{2}-1$, such that $i, j$ are not simultaneously zero, we have

& =\left(x^{p+1} y\right) x=x^{p+1}(y x) \\
& =x^{p+1}\left(x^{p+1} y\right) \\
& =x^{2(p+1)} y .
\end{aligned}
$$

By the same way for each $i, y x^{i}=x^{i(p+1)} y$ and so

\begin{aligned}
y^{2} x^{i} & =y\left(y x^{i}\right) \\
& =y\left(x^{i(p+1)} y\right)=\left(y x^{i(p+1)}\right) y \\
& =\left(x^{i(p+1)^{2}} y\right) y=x^{i(p+1)^{2}} y^{2}
\end{aligned}
$$

On the other hand, $y^{j} x^{i}=x^{i(p+1)^{j}} y^{j}$. Since $x^{p^{2}}=1$ and $(p+1)^{j}=p^{j}+j p^{j-1}+$ $\cdots+\frac{j(j-1)}{2} p^{2}+j p+1$. So,

This shows that

\left(x^{i} y^{j}\right)^{2} & =\left(x^{i} y^{j}\right)\left(x^{i} y^{j}\right)=x^{i}\left(y^{j} x^{i}\right) y^{j} \\
& =x^{i}\left(x^{i j p+i} y^{j}\right) y^{j} \\
& =x^{i j p} x^{2 i} y^{2 j}
\end{aligned}
$$

An inductive argument now proves that, for each $k$,

\begin{equation*}
\left(x^{i} y^{j}\right)^{k}=x^{\frac{k(k-1)}{2} i j p} x^{k i} y^{k j} . \tag{2.2}
\end{equation*}
$$

Therefore, for every $i, j$ with $0 \leq i, j \leq p^{2}-1$ and $i, j$ are not simultaneously zero, we have:

$$
o\left(x^{i} y^{j}\right)=\left\{\begin{array}{ll}
p & p \mid(i, j) \\
p^{2} & \text { otherwise }
\end{array} .\right.
$$

This completes the proof.

## 3. Proof of Theorem 1.1

In this section, the proof of our first main result will be presented. To do this, we need some information about a group $G$ with this property that $\left|\frac{G}{Z(G)}\right|=p^{4}, p$ is prime, and $\frac{G}{Z(G)}$ can be generated by two elements of order $p^{2}$.

Lemma 3.1. Let $G$ be a finite group with center $Z, p$ be prime and $a, b \in G \backslash Z$. Moreover, we assume that $a^{p^{2}}, b^{p^{2}} \in Z$ and $\left(a^{i} b^{j}\right)^{k}=a^{\frac{k(k-1)}{2} i j r p} a^{k i} b^{k j} z$ where $z \in Z, r=0,1$ and $i, j, k$ are positive integers. The following statements hold:
i) If $1 \leq i, j \leq p-1$, then there are $n_{j}$ and $s$ such that $a^{i p} b^{j p}=\left(a^{s p} b^{p}\right)^{n_{j}} z$, where $n_{j} \not \equiv 0(\operatorname{mid} p), 1 \leq s \leq p-1$ and $z \in Z$.
ii) If $1 \leq i \leq p-1,1 \leq j \leq p^{2}-1$ and $j \not \equiv 0(\bmod p)$, then there are $n_{j}$ and $s$ such that $a^{i p} b^{j}=\left(a^{s p} b\right)^{n_{j}} z$, where $n_{j} \not \equiv 0(\bmod p), 1 \leq s \leq p-1$ and $z \in Z$.
iii) If $1 \leq j \leq p-1,1 \leq i \leq p^{2}-1$ and $i \not \equiv 0(\bmod p)$, then there are $n_{i}$ and $s$ such that $a^{i} b^{j p}=\left(a b^{s p}\right)^{n_{i}} z$, where $n_{i} \not \equiv 0(\bmod p), 1 \leq s \leq p-1$ and $z \in Z$.
iv) If $1 \leq i, j \leq p^{2}-1, i \not \equiv 0(\bmod p)$ and $j \not \equiv 0(\bmod p)$, then for there are $n_{j}$ and $s$ such that $a^{i} b^{j}=\left(a^{s} b\right)^{n_{j}} z$, where $n_{j} \not \equiv 0(\bmod p)$, $s \not \equiv 0(\bmod p), 1 \leq s \leq p^{2}-1$ and $z \in Z$.
v) If $1 \leq i, j \leq p^{2}-1, i \not \equiv 0(\bmod p)$ and $j \not \equiv 0(\bmod p)$, then there are $n_{i}$ and $s$ such that $a^{i} b^{j}=\left(a b^{s}\right)^{n_{i}} z$, where $n_{i} \not \equiv 0(\bmod p), s \not \equiv 0(\bmod p), 1 \leq s \leq p^{2}-1$ and $z \in Z$.

Proof. By assumption, $\left(a^{i} b^{j}\right)^{k}=a^{\frac{k(k-1)}{2} i j r p} a^{k i} b^{k j} z$. In this equality, we assume that $i=$ $k=p$ and $j=1$. Since $a^{p^{2}} \in Z,\left(a^{p} b\right)^{p}=b^{p} z^{\prime}$ in which $z^{\prime} \in Z$. Also $\left(a^{p} b\right)^{p}\left(a^{p} b\right)=$ $\left(a^{p} b\right)\left(a^{p} b\right)^{p}$ then $\left(b^{p} z^{\prime}\right)\left(a^{p} b\right)=\left(a^{p} b\right)\left(b^{p} z^{\prime}\right)$ so $a^{p} b^{p}=b^{p} a^{p}$. Since $a^{p^{2}}, a^{p^{2}} \in Z$,

$$
\left(a^{i p} b^{j p}\right)^{p}=a^{\frac{p(p-1)}{2} i j r p^{3}} a^{i p^{2}} b^{j p^{2}} z \in Z
$$

then $\left(a^{i p} b^{j p}\right)^{p} \in Z$. Also we can show that $\left(a^{i p} b^{j}\right)^{p^{2}},\left(a^{i} b^{j}\right)^{p^{2}} \in Z$. Now, each part of the lemma will be proved separately.
i) In this case $(j, p)=1$ and so there are integers $m_{j}$ and $k$ such that $m_{j} j+k p=1$. By our assumption, $a^{p} b^{p}=b^{p} a^{p}$ and $b^{p^{2}} \in Z$ and hence,

\begin{aligned}
\left(a^{i p} b^{j p}\right)^{m_{j}} & =a^{i m_{j} p} b^{j m_{j} p} \\
& =a^{i m_{j} p} b^{(1-k p) p} \\
& =a^{i m_{j} p} b^{p} z_{1} .
\end{aligned}
$$

Since $\left(a^{i p} b^{j p}\right)^{p} \in Z, a^{i p} b^{j p}=\left(a^{i m_{j} p} b^{p}\right)^{n_{j}} z_{3}$. It is clear that $p \nmid i m_{j}$ and so there are integers $s$ and $k$ such that $i m_{j}=k p+s$. It is now easy to see that for a fixed positive integer $j, i_{1}=i_{2}$ if and only if $s_{1}=s_{2}$. Since $1 \leq i \leq p-1,1 \leq s \leq p-1$. So, by above discussion and this fact that $a^{p^{2}} \in Z$,

a^{i p} b^{j p}=\left(a^{i m_{j} p} b^{p}\right)^{n_{j}} z_{3}=\left(a^{k p^{2}+s p} b^{p}\right)^{n_{j}} z_{3}=\left(a^{s p} b^{p}\right)^{n_{j}} z
$$

as desired.
ii) Since $p \nmid j,\left(j, p^{2}\right)=1$. So, there are $m_{j}$ and $k$ such that $m_{j} j+k p^{2}=1$ in which $\left(m_{j}, p\right)=1$. By our assumption $a^{p^{2}}, b^{p^{2}} \in Z$ and $\left(a^{i} b^{j}\right)^{k}=a^{\frac{k(k-1)}{2} i j t p} a^{k i} b^{k j}$. Thus,

$$
\begin{aligned}
\left(a^{i p} b^{j}\right)^{m_{j}} & =a^{\frac{m_{j}\left(m_{j}-1\right)}{2} i j t p^{2}} a^{i m_{j} p} b^{j m_{j}} z_{1} \\
& =a^{i m_{j} p} b^{1-k p^{2}} z_{2} \\
& =a^{i m_{j} p} b z_{3} .
\end{aligned}
$$

Again since $\left(m_{j}, p\right)=1,\left(m_{j}, p^{2}\right)=1$ and so there are $n_{j}$ and $t$ such that $n_{j} m_{j}+t p^{2}=$ 1 in which $p \nmid n_{j}$. We now apply above discussion and this fact that $\left(a^{i p} b^{j}\right)^{p^{2}} \in Z$ to derive the equality $a^{i p} b^{j}=\left(a^{i m_{j} p} b\right)^{n_{j}} z_{5}$. A similar argument shows that there exists an integer $s$ such that $1 \leq s \leq p-1$ and $a^{i p} b^{j}=\left(a^{s p} b\right)^{n_{j}} z$ which completes our argument.
iii) The proof is similar to (ii) and so it is omitted.
iv) Since $p \nmid j,\left(j, p^{2}\right)=1$. So there are $m_{j}$ and $k$ such that $m_{j} j+k p^{2}=1$ in which $\left(m_{j}, p\right)=1$. By our assumption $b^{p^{2}} \in Z$ and $\left(a^{i} b^{j}\right)^{k}=a^{\frac{k(k-1)}{2} i j t p} a^{k i} b^{k j}$. Therefore,

\left(a^{i} b^{j}\right)^{m_{j}} & =a^{\frac{m_{j}\left(m_{j}-1\right)}{2} i j t p} a^{i m_{j}} b^{j m_{j}} z_{1} \\
& =a^{\frac{m_{j}\left(m_{j}-1\right)}{2} i j t p+i m_{j}} b^{1-k p^{2}} z_{1} \\
& =a^{u} b z_{2}
\end{aligned}
$$

where

$$
\begin{equation*}
u=\frac{m_{j}\left(m_{j}-1\right)}{2} i j t p+i m_{j}=i\left(\frac{m_{j}\left(m_{j}-1\right)}{2} j t p+m_{j}\right) . \tag{3.1}
\end{equation*}
$$

Since $\left(m_{j}, p\right)=1,\left(m_{j}, p^{2}\right)=1$ and again there are $n_{j}$ and $t$ such that $m_{j} n_{j}+t p^{2}=1$ in which $p \nmid n_{j}$. By above discussion and this fact that $\left(a^{i} b^{j}\right)^{p^{2}} \in Z, a^{i} b^{j}=\left(a^{u} b\right)^{n_{j}} z_{4}$. It is now clear that $p \nmid u$ and so $p^{2} \nmid u$. Choose integers $s$ and $k$ such that $u=k p^{2}+s$ and $p \nmid s$. By Equation 3.1, $j$ is fixed, one can see that $i_{1}=i_{2}$ if and only if $u_{1}=u_{2}$ if and only if $s_{1}=s_{2}$. Since $1 \leq i \leq p^{2}-1,1 \leq s \leq p^{2}-1$ and by above discussion and the fact that $a^{p^{2}} \in Z, a^{i} b^{j}=\left(a^{u} b\right)^{n_{j}} z_{4}=\left(a^{k p^{2}+s} b\right)^{n_{j}} z_{4}=\left(a^{s} b\right)^{n_{j}} z$ which completes the proof of this part.
$v)$ The proof is similar to $i v$ and so it is omitted.
Hence the result.
Suppose $p$ is a prime number. By a result of Baer [2], the abelian group $\mathbb{Z}_{p^{2}} \times \mathbb{Z}_{p^{2}}$ is capable. If $p$ is an odd prime, then the non-abelian group $\mathbb{Z}_{p^{2}} \rtimes \mathbb{Z}_{p^{2}}$ is also capable [13]. This means that there exists a group $G$ such that $\frac{G}{Z(G)} \cong \mathbb{Z}_{p^{2}} \times \mathbb{Z}_{p^{2}}$ or $\mathbb{Z}_{p^{2}} \rtimes \mathbb{Z}_{p^{2}}$. In the next theorem, we obtain the number and structure of the centralizers of $G$. We also proved in Theorem 2.3 that the non-abelian group $\mathbb{Z}_{4} \rtimes \mathbb{Z}_{4}$ is not capable. In the next theorem, if $p=2$, then we will assume that $\frac{G}{Z} \cong \mathbb{Z}_{4} \times \mathbb{Z}_{4}$.

Theorem 3.2. Suppose $p$ is a prime number and $G$ is a group with center $Z$ such that $\frac{G}{Z} \cong \mathbb{Z}_{p^{2}} \rtimes \mathbb{Z}_{p^{2}}$. Then the number of centralizers of $G$ is $(p+1)^{2}+1$.

Proof. By our assumption, it is enough to assume that $G$ is non-abelian and $Z \neq 1$. By our discussion before Lemma 2.4, we can see that

\frac{G}{Z} \cong Z_{p^{2}} \rtimes Z_{p^{2}}=\left\langle x, y \mid x^{p^{2}}=y^{p^{2}}=1, y x=x^{r p+1} y\right\rangle
$$

Thus, there are $a, b \in G \backslash Z$ such that

\frac{G}{Z}=\left\langle a Z, b Z \mid(a Z)^{p^{2}}=(b Z)^{p^{2}}=1,(b Z)(a Z)=(a Z)^{r p+1}(b Z)\right\rangle
$$

and so

$$
G=\left\{a^{i} b^{j} z \mid 0 \leq i, j \leq p^{2}-1, b a=a^{r p+1} b z^{\prime}, z, z^{\prime}, a^{p^{2}}, b^{p^{2}} \in Z\right\}
$$

We now apply Equation 2.2 to prove that

\begin{equation*}
\left(a^{i} b^{j}\right)^{k}=a^{\frac{k(k-1)}{2} i j r p} a^{k i} b^{k j} z, \tag{3.2}
\end{equation*}
$$

where $z \in Z$. In Equation 3.2, set $i=k=p$ and $j=1$. Since $a^{p^{2}} \in Z$, there exists $z \in Z$ such that $\left(a^{p} b\right)^{p}=b^{p} z$. Therefore,

a^{p} b^{p}=b^{p} a^{p} \tag{3.3}
\end{equation*}
$$

So, for every $0 \leq i, j \leq p-1$,

$$
\begin{equation*}
\left\{a^{s p} b^{t p} z \mid 0 \leq s, t \leq p-1, z \in Z\right\} \subseteq C_{G}\left(a^{i p} b^{j p} z\right) \tag{3.4}
\end{equation*}
$$

Note that $|G|=p^{4}|Z|$ and for each $x \in G \backslash Z, Z \supsetneqq C_{G}(x) \supsetneqq G$. So,

$$
\begin{equation*}
\left|C_{G}(x)\right|=p|Z| \quad \text { or } \quad p^{2}|Z| \quad \text { or } \quad p^{3}|Z| . \tag{3.5}
\end{equation*}
$$

Suppose $i$ and $j$ are fixed and $0 \leq i, j \leq p^{2}-1$. By Equation 3.2, $\left(a^{i} b^{j}\right)^{p^{2}} \in Z$. Thus,

$$
\begin{equation*}
\left\{\left(a^{i} b^{j}\right)^{k} z \mid 0 \leq k \leq p^{2}-1, z \in Z\right\} \subseteq C_{G}\left(a^{i} b^{j}\right) \tag{3.6}
\end{equation*}
$$

Next we partition the elements of $G$ into the following eight parts:

$$
\begin{aligned}
& V_{1}=\left\{a^{i} z|p| i \& z \in Z\right\}, \\
& V_{2}=\left\{a^{i} z \mid p \nmid i \& z \in Z\right\}, \\
& V_{3}=\left\{b^{j} z|p| j \& z \in Z\right\}, \\
& V_{4}=\left\{b^{j} z \mid p \nmid j \& z \in Z\right\}, \\
& V_{5}=\left\{a^{i} b^{j} z|p|(i, j) \& z \in Z\right\}, \\
& V_{6}=\left\{a^{i} b^{j} z|p| i, p \nmid j \& z \in Z\right\}, \\
& V_{7}=\left\{a^{i} b^{j} z|p \nmid i, p| j \& z \in Z\right\}, \\
& V_{8}=\left\{a^{i} b^{j} z \mid p \nmid i, p \nmid j \& z \in Z\right\} .
\end{aligned}
$$

To compute the centralizer of non-central elements of $G$, the following cases will be considered:
a) $i \neq 0$ and $j=0$. Then for every $1 \leq i \leq p^{2}-1$,

$$
\begin{equation*}
\left\{a^{k} z \mid 0 \leq k \leq p^{2}-1, z \in Z\right\} \subseteq C\left(a^{i}\right) \tag{3.7}
\end{equation*}
$$

1) $p \mid i$. Suppose $i=s p$ such that $1 \leq s \leq p-1$. By Equation 3.4,

$$
A=\left\{a^{k} b^{t p} z \mid 0 \leq k \leq p^{2}-1,0 \leq t \leq p-1, z \in Z\right\} \subseteq C_{G}\left(a^{i}\right)=C_{G}\left(a^{s p}\right)
$$

Since $|A|=p^{3}|Z|$, by Equation 3.5 and Lemma 2.1,

$$
C_{G}\left(a^{p}\right)=C_{G}\left(a^{s p}\right)=\left\{a^{k} b^{t p} z \mid 0 \leq k \leq p^{2}-1,0 \leq t \leq p-1, z \in Z\right\}
$$

2) $p \nmid i$. By Lemma $2.2(a)$, the element $a$ commutes only with elements of $V_{1} \cup V_{2}$ and by Equations 3.7, 3.5 and Lemma 2.1,

$$
C_{G}(a)=C_{G}\left(a^{i}\right)=\left\{a^{k} z \mid 0 \leq k \leq p^{2}-1, z \in Z\right\} \leq C\left(a^{p}\right)
$$

b) $j \neq 0$ and $i=0$. Apply a similar argument as the case of (1). To do this, we consider two cases that $p \mid j$ or $p \nmid j$.
3) $p \mid j$. Suppose $j=t p, 1 \leq t \leq p-1$. Then,

$$
C_{G}\left(b^{p}\right)=C_{G}\left(b^{t p}\right)=\left\{a^{s p} b^{k} z \mid 0 \leq k \leq p^{2}-1,0 \leq s \leq p-1, z \in Z\right\} .
$$

4) $p \nmid j$. In this case, we can easily see that,

$$
C_{G}(b)=C_{G}\left(b^{j}\right)=\left\{b^{k} z \mid 0 \leq k \leq p^{2}-1, z \in Z\right\} \leq C\left(b^{p}\right) .
$$

c) $i \neq 0$ and $j \neq 0$. The following four subcases are considered into account.
5) $p \mid i$ and $p \mid j$. Suppose $i=i_{1} p$ and $j=j_{1} p$ in which $1 \leq i_{1}, j_{1} \leq p-1$. By Lemma 3.1(I), there are $n_{j_{1}}$ and $s$ such that $a^{i_{1} p} b^{j_{1} p}=\left(a^{s p} b^{p}\right)^{n_{j_{1}}} z$, where $p \nmid n_{j_{1}}$, $1 \leq s \leq p-1$ and $z \in Z$. By Equation 3.2, $\left(a^{s p} b^{p}\right)^{p} \in Z$ and by Lemma (2.1),

$$
C_{G}\left(a^{i_{1} p} b^{j_{1} p}\right)=C_{G}\left(\left(a^{s p} b^{p}\right)^{n_{j_{1}}} z\right)=C_{G}\left(\left(a^{s p} b^{p}\right)^{n_{j_{1}}}\right)=C_{G}\left(a^{s p} b^{p}\right) .
$$

Since $1 \leq s \leq p-1$, the number of distinct proper centralizers constructed from the elements of $V_{5}$ is at most $p-1$. We now obtain the structures of these centralizers. In Equation 3.2, we put $i=s, j=1$ and $k=p$. Then $\left(a^{s} b\right)^{p}=a^{s p} b^{p} z$ in which $z \in Z$. Thus, $\left(a^{s p} b^{p}\right)\left(a^{s} b\right)=\left(a^{s} b\right)\left(a^{s p} b^{p}\right)$ and by Equation 3.4,

$$
A=\left\{a^{i p}\left(a^{s} b\right)^{k} b^{j p} z \mid 0 \leq i, j, k \leq p-1, z \in Z\right\} \subseteq C_{G}\left(a^{s p} b^{p}\right)
$$

It can easily see that $|A|=p^{3}|Z|$ and by applying Equations 3.2 and 3.5.

$$
\begin{equation*}
C_{G}\left(a^{s p} b^{p}\right)=\left\{a^{i p} a^{s k} b^{k} b^{j p} z \mid 0 \leq i, j, k \leq p-1, z \in Z\right\} \tag{3.8}
\end{equation*}
$$

Suppose $1 \leq t \leq p-1$. By Equation 3.8,

$$
\begin{equation*}
a^{t} b \in C_{G}\left(a^{s p} b^{p}\right) \text { if and only if } t=s \tag{3.9}
\end{equation*}
$$

Therefore, $C_{G}\left(a^{t p} b^{p}\right)=C_{G}\left(a^{s p} b^{p}\right), 1 \leq s, t \leq p-1$, if and only if $t=s$. This shows that the number of distinct proper centralizers is exactly $p-1$.
6) $p \mid i$ and $p \nmid j$. Suppose $i=i_{1} p$, where $1 \leq i_{1} \leq p-1$. By Lemma 3.1(II), there are $n_{j}$ and $s$ such that $a^{i_{1} p} b^{j}=\left(a^{s p} b\right)^{n_{j}} z$ in which $p \nmid n_{j}, 1 \leq s \leq p-1$ and $z \in Z$. Now by Equation 3.2, $\left(a^{s p} b\right)^{p^{2}} \in Z$. Hence by Lemma 2.1, $C_{G}\left(a^{i_{1} p} b^{j}\right)=C_{G}\left(\left(a^{s p} b\right)^{n_{j}} z\right)$ $=C_{G}\left(\left(a^{s p} b\right)^{n_{j}}\right)=C_{G}\left(a^{s p} b\right)$. Since $1 \leq s \leq p-1$, by Lemma 2.2(b), the number of distinct proper centralizers is exactly $p-1$. To obtain the structures of these centralizers, it is enough to apply Equation 3.6. This implies that

$$
A=\left\{\left(a^{s p} b\right)^{k} z \mid 0 \leq k \leq p^{2}-1, z \in Z\right\} \subseteq C\left(a^{s p} b\right)
$$

On the other hand, by Equation 3.2, $\left(a^{s p} b\right)^{k}=a^{s p k} b^{k} z^{\prime}$ in which $z^{\prime} \in Z$. We assume that $k=t p+k_{1}$ in which $0 \leq t, k_{1} \leq p-1$. Thus, $\left(a^{s p} b\right)^{k}=a^{s p k} b^{k} z^{\prime}=a^{s p k_{1}} b^{k_{1}} b^{t p} z^{\prime \prime}$, where $z^{\prime \prime} \in Z$. So,

$$
A=\left\{a^{s p k_{1}} b^{k_{1}} b^{t p} z \mid 0 \leq k_{1}, t \leq p-1, z \in Z\right\} \subseteq C\left(a^{s p} b\right)
$$

By Lemma 2.2(a), $a^{s p} b$ cannot commute with an element of $V_{1} \cup V_{2} \cup V_{4} \cup V_{5} \cup V_{7}$. Furthermore, it is easy to see that $V_{3} \subseteq A$. We claim that there are no elements $x \in V_{6}$ and $y \in V_{8}$ such that $x y=y x$. To see this, we assume that $x=a^{i_{1} p} b^{j_{1}} \in V_{6}$ and $y=a^{i_{2}} b^{j_{2}} \in V_{8}$ are arbitrary. By Lemma 3.1( $(i i i, i v)$, $a^{i_{1} p} b^{j_{1}}=\left(a^{s p} b\right)^{n_{j_{1}}} z_{1}$ and $a^{i_{2}} b^{j_{2}}=\left(a^{t} b\right)^{n_{j_{2}}} z_{2}$, where $p \nmid n_{j_{1}}, p \nmid n_{j_{2}}, p \nmid s$ and $p \nmid t$. By Equation 3.2, $\left(a^{s p} b\right)^{p^{2}},\left(a^{t} b\right)^{p^{2}} \in Z$ and by Lemma 2.1, $C_{G}\left(a^{i_{1} p} b^{j_{1}}\right)=C_{G}\left(a^{s p} b\right)$ and $C_{G}\left(a^{i_{2}} b^{j_{2}}\right)=C_{G}\left(a^{t} b\right)$. Thus, $\left(a^{i_{1} p} b^{j_{1}}\right)\left(a^{i_{2}} b^{j_{2}}\right)=\left(a^{i_{2}} b^{j_{2}}\right)\left(a^{i_{1} p} b^{j_{1}}\right)$ if and only if $\left(a^{s p} b\right)\left(a^{t} b\right)=\left(a^{t} b\right)\left(a^{s p} b\right)$ if and only if $a^{s p} b a^{t}=a^{t} b a^{s p}$ if and only if $a^{s p-t} b=b a^{s p-t}$. We now apply Lemma 2.2(a) to deduce that $p \mid t$ which is impossible. Next we prove that $C\left(a^{s p} b\right)=A$. Choose $x \in C\left(a^{s p} b\right) \backslash A$. By above discussion, $x \in V_{6}$ and so we can write $x=a^{i p} b^{j}$, where $1 \leq i \leq p-1$. By Lemma 3.1( $\left.i i\right)$, there are $n_{j}$ and $m$ such that $a^{i p} b^{j}=\left(a^{m p} b\right)^{n_{j}} z$ with this condition that $p \nmid n_{j}, 1 \leq m \leq p-1$, and $z \in Z$. On the other hand, By Equation [3.2, $\left(a^{m p} b\right)^{p^{2}} \in Z$. So, by Lemma 2.1, $C\left(a^{i p} b^{j}\right)=C\left(a^{m p} b\right)$. Since $x \in C\left(a^{s p} b\right), a^{s p} b \in C_{G}(x)=C\left(a^{m p} b\right)$. Hence, $a^{(s-m) p} b$ $=b a^{(s-m) p}$. Again by Lemma 2.2(a), $p \mid s-m$ and since $1 \leq s, m \leq p-1, s=m$. This proves that $C\left(a^{s p} b\right)=A$. Therefore,

$$
C\left(a^{s p} b\right)=\left\{a^{s p k} b^{k} b^{t p} z \mid 0 \leq k, t \leq p-1, z \in Z\right\}
$$

7) $p \mid j$ and $p \nmid i$. A similar argument as Case (6) shows that the number of distinct proper centralizers of $G$ is equal to $p-1$ and

$$
C_{G}\left(a b^{t p}\right)=\left\{a^{s p} a^{k} b^{t p k} z \mid 1 \leq k, s \leq p-1, z \in Z\right\}
$$

8) $p \nmid i$ and $p \nmid j$. By Lemma 3.1( $(i v)$, there are $n_{j}$ and $s$ such that $a^{i} b^{j}=\left(a^{s} b\right)^{n_{j}} z$ in which $p \nmid n_{j}, p \nmid s, 1 \leq s \leq p^{2}-1$ and $z \in Z$. By Equation 3.2, $\left(a^{s} b\right)^{p^{2}} \in Z$.

Thus, by Lemma 2.1, $C_{G}\left(a^{i} b^{j}\right)=C_{G}\left(\left(a^{s} b\right)^{n_{j}} z\right)=C_{G}\left(\left(a^{s} b\right)^{n_{j}}\right)=C_{G}\left(a^{s} b\right)$. Since $p \nmid s, 1 \leq s \leq p^{2}-1$ and Lemma $2.2(b)$, the number of distinct proper centralizers contained in $V_{8}$ is equal to $p^{2}-p$. We now obtain the structure of centralizers. By Equations 3.6 and (3.2),

$$
\begin{align*}
A & =\left\{\left(a^{s} b\right)^{k} z \mid 0 \leq k \leq p^{2}-1, z \in Z\right\} \subseteq C\left(a^{s} b\right) \\
& =\left\{\left.a^{\frac{k(k-1)}{2} s p+s k} b^{k} z \right\rvert\, 0 \leq k \leq p^{2}-1, z \in Z\right\} . \tag{3.10}
\end{align*}
$$

By Lemma 2.2(a) and definition of $V_{7}$, one can see that $a^{s} b$ cannot be commuted with an elements in $V_{1} \cup V_{2} \cup V_{3} \cup V_{4} \cup V_{6} \cup V_{7}$. We claim that $C\left(a^{s p} b\right)=A$. To prove, we assume that $x \in C_{G}\left(a^{s} b\right) \backslash A$. By above discussion, $x \in V_{5} \cup V_{8}$. If $x \in V_{8}$, then $x=a^{i^{\prime}} b^{j^{\prime}}$ and by Lemma 3.1 $(i v)$, there are $n_{j^{\prime}}$ and $t$ such that $a^{i^{\prime}} b^{j^{\prime}}=\left(a^{t} b\right)^{n_{j^{\prime}}} z$ in which $p \nmid n_{j^{\prime}}, p \nmid t$ and $z \in Z$. Hence by Equation [3.2, $\left(a^{t} b\right)^{p^{2}} \in Z$ and by Lemma 2.1, we have $C_{G}\left(a^{i^{\prime}} b^{j^{\prime}}\right)=C_{G}\left(a^{t} b\right)$. Since $x \in C_{G}\left(a^{s} b\right), a^{s} b \in C_{G}(x)=C_{G}\left(a^{t} b\right)$ and so $a^{s-t} b=b a^{s-t}$. Apply Lemma 2.2(a) to deduce that $p^{2} \mid s-t$. Since $1 \leq s, t \leq p^{2}-1, s=t$ and $x=a^{i^{\prime}} b^{j^{\prime}}=\left(a^{s} b\right)^{n_{j}} z \in A$. If $x \in V_{5}$, then $x=a^{i^{\prime} p} b^{j^{\prime} p}$
 $p \nmid n_{j^{\prime}}, p \nmid t$ and $z \in Z$. Next by Equation 3.2, $\left(a^{t p} b^{p}\right)^{p} \in Z$ and Lemma 2.1 implies that $C_{G}\left(a^{i^{\prime} p} b^{j^{\prime} p}\right)=C_{G}\left(a^{t p} b^{p}\right)$. Since $x \in C_{G}\left(a^{s} b\right), a^{s} b \in C_{G}(x)=C_{G}\left(a^{t p} b^{p}\right)$ and by Equation 3.9, one can see that $t=s$. Hence Equation 3.2 shows that $x=a^{i^{\prime} p} b^{j^{\prime} p}=$ $\left(a^{s p} b^{p}\right)^{n_{j^{\prime}}} z=\left(a^{s} b\right)^{n_{j^{\prime}} p} z \in A$. Therefore, in both cases $x \in A$ which means that

$$
C_{G}\left(a^{s} b\right)=A=\left\{\left(a^{s} b\right)^{k} z \quad \mid \quad 0 \leq k \leq p^{2}-1, z \in Z\right\} .
$$

In addition, by Equations 3.8 and 3.10, we can see that $C_{G}\left(a^{s} b\right) \leq C_{G}\left(a^{s p} b^{p}\right)$.
Therefore, the structure of non-trivial proper centralizers of $G$ is as follows:

$$
\begin{aligned}
C_{G}\left(a^{p}\right) & =\left\{a^{k} b^{j p} z \mid 0 \leq j \leq p-1,0 \leq k \leq p^{2}-1, z \in Z\right\} \\
C_{G}(a) & =\left\{a^{k} z \mid 0 \leq k \leq p^{2}-1\right\} \leq C_{G}\left(a^{p}\right) \\
C_{G}\left(b^{p}\right) & =\left\{a^{i p} b^{k} z \mid 0 \leq i \leq p-1,0 \leq k \leq p^{2}-1, z \in Z\right\} \\
C_{G}(b) & =\left\{b^{k} z \mid 0 \leq k \leq p^{2}-1\right\} \leq C_{G}\left(b^{p}\right), \\
C_{G}\left(a^{s p} b^{p}\right) & =\left\{a^{i p} a^{s k} b^{k} b^{j p} z \mid 0 \leq i, j, k \leq p-1, z \in Z\right\}, 1 \leq s \leq p-1 \\
C_{G}\left(a b^{s p}\right) & =\left\{a^{i p} a^{k} b^{s p k} z \mid 0 \leq i, k \leq p-1, z \in Z\right\} \leq C_{G}\left(a^{p}\right), 1 \leq s \leq p-1 \\
C_{G}\left(a^{s p} b\right) & =\left\{a^{s p k} b^{k} b^{j p} z \mid 0 \leq j, k \leq p-1, z \in Z\right\} \leq C_{G}\left(b^{p}\right), 1 \leq s \leq p-1 \\
C_{G}\left(a^{s} b\right) & =\left\{\left(a^{s} b\right)^{k} a^{i s p} b^{i p} z \mid 0 \leq i, k \leq p-1, z \in Z\right\} \leq C_{G}\left(a^{s p} b^{p}\right), 1 \leq s \leq p^{2}-1, p \nmid s
\end{aligned}
$$

So, the number of distinct proper centralizers of $G$ is $\left(p^{2}-p\right)+3(p-1)+4=p^{2}+2 p+1=$ $(p+1)^{2}$ and therefore $|\operatorname{Cent}(G)|=(p+1)^{2}+1$. This completes the proof.

We end this section by the following conjecture:
Conjecture 3.3. Suppose $p$ is a prime number, $n$ is a positive integer and $G$ is a group with center $Z$ such that $\frac{G}{Z} \cong \mathbb{Z}_{p^{n}} \rtimes \mathbb{Z}_{p^{n}}$. Then $|\operatorname{Cent}(G)|=(p+1)^{n}+1$.

## 4. Proof of Theorem 1.2

In this section, we apply the results of Section 3 to obtain the structure of the commuting conjugacy class graph of $G$ when $\frac{G}{Z(G)} \cong \mathbb{Z}_{p^{2}} \rtimes \mathbb{Z}_{p^{2}}$.

Theorem 4.1. Suppose $p$ is a prime and $G$ is a group with center $Z$ such that $\frac{G}{Z} \cong$ $\mathbb{Z}_{p^{2}} \times \mathbb{Z}_{p^{2}}$. Then the commuting conjugacy classes graph of $G$ has the graph structure

$$
\mathcal{M}_{1} \overbrace{K_{n(p-1)}, \cdots, K_{n(p-1)}}^{p+1}, \overbrace{K_{m\left(p^{2}-p\right)}, \cdots, K_{m\left(p^{2}-p\right)}}^{p^{2}+p}],
$$

where $\mathcal{M}_{1}$ is the graph depicted in Figure 图. Here, $m=\frac{|Z|}{p^{2}}$ and $n=\frac{|Z|}{p}$.


Figure 2. The Graph $\mathcal{M}_{1}$.

Proof. Since $\frac{G}{Z}$ is abelian, $x g Z=x Z g Z=g Z x Z=g x Z$, where $x, g \in G \backslash Z$ are arbitrary. Hence there exists $z \in Z$ such $x g=g x z$ and so for every $x \in G \backslash Z$,

$$
\begin{equation*}
x^{G}=\left\{g^{-1} x g \mid g \in G\right\}=\left\{g^{-1} g x z \mid z \in Z\right\}=\{x z \mid z \in Z\} . \tag{4.1}
\end{equation*}
$$

We now apply Theorem 3.2 to prove that the group $G$ has the following structure:

$$
G=\left\{a^{i} b^{j} z \mid 0 \leq i, j \leq p_{12}^{2}-1, b a=a b z_{t}, z, z_{t} \in Z\right\}
$$

Hence for each $x \in G \backslash Z, x=a^{i} b^{j} z$, where $0 \leq i, j \leq p^{2}-1$ and $i, j$ are not simultaneously zero. To obtain the non-central conjugacy classes of $G$, the following have to be investigated:
a) $i \neq 0$ and $j=0$. We will consider two cases that $p \mid i$ and $p \nmid i$.

1) $p \mid i$. In this case, $i=s p$, where $1 \leq s \leq p-1$. By Theorem 3.2, $\left|C_{G}\left(a^{s p}\right)\right|=p^{3}|Z|$ and so $\left|\left(a^{s p}\right)^{G}\right|=p$. By Equation 4.1, $\left(a^{s p}\right)^{G}=\left\{a^{s p} z_{1}, a^{s p} z_{2}, \cdots, a^{s p} z_{p}\right\}=a^{s p} H$, where $H=\left\{z_{1}, z_{2}, \cdots, z_{p}\right\} \subseteq Z$. Suppose $|Z|>p$ and choose $z_{r_{1}} \in Z \backslash H$. It is easy to see that $a^{s p} z_{r_{1}} \notin\left(a^{s p}\right)^{G}$ and so $\left(a^{s p} z_{r_{1}}\right)^{G} \neq\left(a^{s p}\right)^{G}$. Since $C_{G}\left(a^{s p} z_{r_{1}}\right)=C_{G}\left(a^{s p}\right)$, $\left|\left(a^{s p} z_{r_{1}}\right)^{G}\right|=\left|\left(a^{s p}\right)^{G}\right|=p$. Also, $\left(a^{s p} z_{r_{1}}\right)^{G}=\left(a^{s p}\right)^{G} z_{r_{1}}=a^{s p} H z_{r_{1}}$. Since $\left(a^{s p}\right)^{G} \cap$ $\left(a^{s p} z_{r_{1}}\right)^{G}=\emptyset, H \cap H z_{r_{1}}=\emptyset$ and $H \cup H z_{r_{1}} \subseteq Z$. We now choose an element $z_{r_{2}} \in$ $Z \backslash\left(H \cup H z_{r_{1}}\right)$ and by above method we will see that $p\left||Z|\right.$. Suppose $n=\frac{|Z|}{p}$. Thus, there are $n$ distinct conjugacy classes of the form $\left(a^{s p} z_{r_{1}}\right)^{G},\left(a^{s p} z_{r_{2}}\right)^{G}, \ldots,\left(a^{s p} z_{r_{n}}\right)^{G}$. Since $1 \leq s \leq p-1$, there are $n(p-1)$ distinct conjugacy classes with $n=\frac{|Z|}{p}$ and each of which has $p$ elements.
2) $p \nmid i$. Then by Theorem [3.2, $\left|C_{G}\left(a^{i}\right)\right|=p^{2}|Z|$ and so $\left|\left(a^{i}\right)^{G}\right|=p^{2}$. Also, by Equation 4.1, $\left(a^{i}\right)^{G}=\left\{a^{i} z_{1}, a^{i} z_{2}, \cdots, a^{i} z_{p^{2}}\right\}=a^{i} H$, where $H=\left\{z_{1}, z_{2}, \cdots, z_{p^{2}}\right\} \subseteq$ $Z$. Suppose that $|Z|>p^{2}$ and choose $z_{r_{1}} \in Z \backslash H$. It is easy to see that $a^{i} z_{r_{1}} \notin\left(a^{i}\right)^{G}$ and hence $\left(a^{i} z_{r_{1}}\right)^{G} \neq\left(a^{i}\right)^{G}$. Since $C_{G}\left(a^{i} z_{r_{1}}\right)=C_{G}\left(a^{i}\right),\left|\left(a^{i} z_{r_{1}}\right)^{G}\right|=\left|\left(a^{i}\right)^{G}\right|=$ $p^{2}$. Also, $\left(a^{i} z_{r_{1}}\right)^{G}=\left(a^{i}\right)^{G} z_{r_{1}}=a^{i} H z_{r_{1}}$. Note that $\left(a^{i}\right)^{G} \cap\left(a^{i} z_{r_{1}}\right)^{G}=\emptyset$. Thus, $H \cap H z_{r_{1}}=\emptyset$ and $H \cup H z_{r_{1}} \subseteq Z$. Choose the element $z_{r_{2}} \in Z \backslash\left(H \cup H z_{r_{1}}\right)$. By repeated applications of above method we can see that $p^{2}| | Z \mid$. Define $m=$ $\frac{|Z|}{p^{2}}$. Then for constant $i$, there are $m$ distinct conjugacy classes in the form of $\left(a^{i} z_{r_{1}}\right)^{G},\left(a^{i} z_{r_{2}}\right)^{G}, \ldots,\left(a^{i} z_{r_{m}}\right)^{G}$. Since $1 \leq i \leq p^{2}-1$ and $p \nmid i$, there are $m\left(p^{2}-p\right)$ distinct conjugacy classes, where $m=\frac{|Z|}{p^{2}}$ and each of which has $p^{2}$ elements.
b) $i=0$ and $j \neq 0$.
3) If $p \mid j$, then $j=t p$, where $1 \leq t \leq p-1$. By Theorem 3.2, $\left|C_{G}\left(b^{t p}\right)\right|=p^{3}|Z|$ and so $\left|\left(b^{t p}\right)^{G}\right|=p$. Then by Equation 4.1 and a similar argument as (1), for each $t$ there are $n$ distinct conjugacy classes of the form $\left(b^{t p} z_{r_{1}}\right)^{G},\left(b^{t p} z_{r_{2}}\right)^{G}, \ldots,\left(b^{t p} z_{r_{n}}\right)^{G}$, where $n=\frac{|Z|}{p}$. Since $1 \leq t \leq p-1$, there are $n(p-1)$ distinct conjugacy classes with $n=\frac{|Z|}{p}$ and each class has $p$ elements.
4) If $p \nmid j$, then by Theorem 3.2, $\left|C_{G}\left(b^{j}\right)\right|=p^{2}|Z|$ and so $\left|\left(b^{j}\right)^{G}\right|=p^{2}$. Apply again Equation 4.1 and a similar argument as (2) to result that for each constant $j$, there are $m$ distinct conjugacy classes of the form $\left(b^{j} z_{r_{1}}\right)^{G},\left(b^{j} z_{r_{2}}\right)^{G}, \ldots,\left(b^{j} z_{r_{m}}\right)^{G}$, where $m=\frac{|Z|}{p^{2}}$. Since $1 \leq j \leq p^{2}-1$ and $p \nmid j$, there are $m\left(p^{2}-p\right)$ distinct conjugacy classes with $m=\frac{|Z|}{p^{2}}$ and each class has $p^{2}$ elements.
c) $i \neq 0$ and $j \neq 0$. This case can be separated into the following four cases:
5) $p \mid i$ and $p \mid j$. In this case, $i=s p$ and $j=t p$ in which $1 \leq s, t \leq p-1$. By Theorem 3.2, $\left|C_{G}\left(a^{s p} b^{t p}\right)\right|=p^{3}|Z|$ and so $\left|\left(a^{s p} b^{t p}\right)^{G}\right|=p$. We now apply Equation 4.1 and a similar argument as (1) for constants $s$ and $t$ to deduce that there are $n$ distinct conjugacy classes of the form $\left(a^{s p} b^{t p} z_{r_{1}}\right)^{G},\left(a^{s p} b^{t p} z_{r_{2}}\right)^{G}, \ldots,\left(a^{s p} b^{t p} z_{r_{n}}\right)^{G}$, where $n=\frac{|Z|}{p}$. Since $1 \leq s, t \leq p-1$, there are $n(p-1)^{2}$ distinct conjugacy classes with $n=\frac{|Z|}{p}$ and each class has $p$ members.
6) $p \nmid i$ and $p \mid j$. Clearly $j=t p, 1 \leq t \leq p-1$. By Theorem 3.2, $\left|C_{G}\left(a^{i} b^{t p}\right)\right|=p^{2}|Z|$ and hence $\left|\left(a^{i} b^{t p}\right)^{G}\right|=p^{2}$. On the other hand, Equation 4.1 and a similar argument as (2) for constants $i$ and $t$, show that there are $m$ distinct conjugacy classes of the form $\left(a^{i} b^{t p} z_{r_{1}}\right)^{G},\left(a^{i} b^{t p} z_{r_{2}}\right)^{G}, \ldots,\left(a^{i} b^{t p} z_{r_{m}}\right)^{G}$, where $m=\frac{|Z|}{p^{2}}$. Since $1 \leq t \leq p-1$, $1 \leq i \leq p^{2}-1$ and $p \nmid i$, there are $m p(p-1)^{2}$ distinct conjugacy classes with $m=\frac{|Z|}{p^{2}}$ and each class has $p^{2}$ members.
7) $p \mid i$ and $p \nmid j$. In this case $i=s p$, for some integer $s$ such that $1 \leq s \leq p-1$. By Theorem [3.2, $\left|C_{G}\left(a^{s p} b^{j}\right)\right|=p^{2}|Z|$ and so $\left|\left(a^{s p} b^{j}\right)^{G}\right|=p^{2}$. Then by Equation 4.1 and a similar argument as (2) for constants $s$ and $j$, one can prove that there are $m$ distinct conjugacy classes of the form $\left(a^{s p} b^{j} z_{r_{1}}\right)^{G},\left(a^{s p} b^{j} z_{r_{2}}\right)^{G}, \ldots,\left(a^{s p} b^{j} z_{r_{m}}\right)^{G}$, where $m=\frac{|Z|}{p^{2}}$. Since $1 \leq s \leq p-1,1 \leq j \leq p^{2}-1$ and $p \nmid j$, there are $m p(p-1)^{2}$ distinct conjugacy classes with $m=\frac{|Z|}{p^{2}}$ and each class has $p^{2}$ members.
8) $p \nmid i$ and $p \nmid j$. By Theorem [3.2, $\left|C_{G}\left(a^{i} b^{j}\right)\right|=p^{2}|Z|$ and so $\left|\left(a^{i} b^{j}\right)^{G}\right|=p^{2}$. On the other hand, by Equation 4.1 and applying a similar argument as (2) for constants $i$ and $j$, one can see that there are $m$ distinct conjugacy classes of the form $\left(a^{i} b^{j} z_{r_{1}}\right)^{G},\left(a^{i} b^{j} z_{r_{2}}\right)^{G}, \ldots,\left(a^{i} b^{j} z_{r_{m}}\right)^{G}$, where $m=\frac{|Z|}{p^{2}}$. Since $1 \leq i, j \leq p^{2}-1$ and $p \nmid i, j$, there are $m p^{2}(p-1)^{2}$ distinct conjugacy classes with $m=\frac{|Z|}{p^{2}}$ and each class has length $p^{2}$.

The above discussion are summarized in Table 1 .
We now obtain the commuting conjugacy class graph of $G$. To do this, we consider the following cases:
(1) Suppose $a^{s_{1} p}$ and $a^{s_{2} p}$ are representatives of two conjugacy classes of Type 1 in Table 1. It is clear that $a^{s_{1} p} a^{s_{2} p}=a^{s_{2} p} a^{s_{1} p}$ and so all such classes are commuting together. Hence, the commuting conjugacy class graph has a subgraph isomorphic to the complete graph $K_{n(p-1)}$. We now assume that $a^{s p}$ is a representative of a conjugacy class of Type 1 and $a^{u} b^{v} z$ is an arbitrary element of $G$ such that $\left(a^{s p}\right)\left(a^{u} b^{v} z\right)=\left(a^{u} b^{v} z\right)\left(a^{s p}\right)$. Thus $a^{s p} b^{v}=b^{v} a^{s p}$ and by Lemma 2.2(a),

$v \equiv 0(\bmod p)$ or $v=t p$ in which $0 \leq t \leq p-1$. Hence $a^{s p}$ commutes with all elements in the form $a^{u} b^{t p} z$. Now the following cases can be occurred:
(a) If $t=0$, then the conjugacy classes of Types 1 and 2 in Table 1 are commuting to each other.
(b) If $t \neq 0$ and $u=0$, then the conjugacy classes of Types 1 and 3 in Table 1 are commuting to each other.
(c) If $u, t \neq 0$ and $p \mid u$, then the conjugacy classes of Types 1 and 5 in Table 1 can be commuted to each other.
(d) If $t \neq 0$ and $p \nmid u$, then the conjugacy classes of Types 1 and 6 in Table 1 are commuting together.
(2) It is clear that two conjugacy classes of Type 2 are commuted to each other and so the commuting conjugacy class graph has a subgraph isomorphic to $K_{m p(p-1)}$. We now determine the relationship between conjugacy classes of this and other types. To do this, we assume that $a^{i}$ is a representatives of a conjugacy class of Type 2 and $a^{u} b^{v} z$ is an arbitrary element of $G$ such that $\left(a^{i}\right)\left(a^{u} b^{v} z\right)=\left(a^{u} b^{v} z\right)\left(a^{i}\right)$. So $a^{i} b^{v}=b^{v} a^{i}$ and since $p \nmid i$, by Lemma 2.2(a) the latter is true if and only if $v=0$. Therefore, $a^{i}$ commutes with all elements in the form $a^{u} z$. This shows that the conjugacy classes of Type 2 are commuted only with the conjugacy classes of Type 1.
(3) Suppose $b^{t_{1} p}$ and $b^{t_{2} p}$ are the representative of two conjugacy classes of Type 3. It is clear that $b^{t_{1} p} b^{t_{2} p}=b^{t_{2} p} b^{t_{1} p}$ and so all conjugacy classes of Type 3 are commuting together in the graph. Hence by Table 1, the graph has a subgraph isomorphic
to $K_{n(p-1)}$. To determine the relationship between conjugacy classes of this and other types, we choose $b^{t p}$ to be a representative of a conjugacy class of Type 3 and $a^{u} b^{v} z$ as an arbitrary element of $G$ such that $\left(b^{t p}\right)\left(a^{u} b^{v} z\right)=\left(a^{u} b^{v} z\right)\left(b^{t p}\right)$. Thus, $b^{t p} a^{u}=a^{u} b^{t p}$ and by Lemma2.2(a), the later is true if and only if $u \equiv 0(\bmod p)$ or $u=s p$ in which $0 \leq s \leq p-1$. Therefore, $b^{t p}$ can be commuted with all elements in the form $a^{s p} b^{v} z$. Hence, the following are satisfied:
(a) If $s=0$, then the conjugacy classes of Types 3 and 4 are commuting together.
(b) If $s \neq 0$ and $v=0$, then the conjugacy classes of Types 3 and 1 are commuting to each other.
(c) If $v, s \neq 0$ and $p \mid v$, then the conjugacy classes of Types 3 and 5 are commuting together.
(d) If $s \neq 0$ and $p \nmid v$, then the conjugacy classes of Types 3 and 7 are commuting to each other.
(4) Suppose $b^{j_{1}}$ and $b^{j_{2}}$ are the representatives of two conjugacy classes of Type 4. It is obvious that $b^{j_{1}} b^{j_{2}}=b^{j_{2}} b^{j_{1}}$ which shows that all conjugacy classes of Type 4 are commuted to each other. So, the commuting conjugacy class graph has a subgraph isomorphic to $K_{m p(p-1)}$. To determine the relationship between this and other types in Table 1, we assume that $b^{j}$ is a representative of a conjugacy class of type 4 and $a^{u} b^{v} z$ is an arbitrary element of $G$ such that $\left(b^{j}\right)\left(a^{u} b^{v} z\right)=\left(a^{u} b^{v} z\right)\left(b^{j}\right)$. Thus, $b^{j} a^{u}=a^{u} b^{j}$ and since $p \nmid j$, by Lemma 2.2(a), the latter is true if and only if $u=0$. Therefore, $b^{j}$ commutes with all elements in the form $b^{v} z$ and hence the conjugacy classes of Type 4 can be commuted only with the conjugacy classes of Type 3.
(5) Suppose $a^{s_{1} p} b^{t_{1} p}$ and $a^{s_{2} p} b^{t_{2} p}$ are the representatives of two conjugacy classes of Type 5. By Equation 3.3, $\left(a^{s_{1} p} b^{t_{1} p}\right)\left(a^{s_{2} p} b^{t_{1} p}\right)=\left(a^{s_{2} p} b^{t_{2} p}\right)\left(a^{s_{1} p} b^{t_{2} p}\right)$ and so all conjugacy classes of Type 5 are commuted to each other. This gives us the complete graph $K_{n(p-1)^{2}}$ as a subgraph of the commuting conjugacy class graph. Hence, it is enough to determine the relationship between this and conjugacy classes of Types 6,7 and 8. Suppose $a^{s p} b^{t p}$ and $a^{u} b^{v p}$ are the representatives of the conjugacy classes of Types 5 and 6 , respectively, such that they are commuting together. By Lemma 3.1, $a^{s p} b^{t p}=\left(a^{i p} b^{p}\right)^{n_{t}} z_{1}$ and $a^{u} b^{v p}=\left(a b^{j p}\right)^{n_{u}} z_{2}$ and so by Lemma 2.1, $C_{G}\left(a^{s p} b^{t p}\right)=C_{G}\left(a^{i p} b^{p}\right)$ and $C_{G}\left(a^{u} b^{v p}\right)=C_{G}\left(a b^{j p}\right)$. It is now easy to prove that $\left(a^{s p} b^{t p}\right)\left(a^{u} b^{v p}\right)=\left(a^{u} b^{v p}\right)\left(a^{s p} b^{t p}\right)$ if and only if $\left(a^{i p} b^{p}\right)\left(a b^{j p}\right)=\left(a b^{j p}\right)\left(a^{i p} b^{p}\right)$ if and only if $b^{p} a=a b^{p}$ which is a contradiction with Lemma 2.2(a). Therefore, a conjugacy class of Type 5 is not adjacent with a conjugacy class of Type 6. Similarly,
a conjugacy class of Type 5 is not adjacent to another one of Type 7. We now assume that $a^{s p} i s b^{t p}$ and $a^{u} b^{v}$ are representatives of the conjugacy classes of Types 5 and 8 , respectively. By Lemma 3.1, $a^{s p} b^{t p}=\left(a^{i p} b^{p}\right)^{n_{t}} z_{1}$ and $a^{u} b^{v}=\left(a^{j} b\right)^{n_{v}} z_{2}$. On the other hand, By Lemma 2.1, $C_{G}\left(a^{s p} b^{t p}\right)=C_{G}\left(a^{i p} b^{p}\right)$ and $C_{G}\left(a^{u} b^{v}\right)=C_{G}\left(a^{j} b\right)$ and by Equation 3.9, we can see $\left(a^{s p} b^{t p}\right)\left(a^{u} b^{v}\right)=\left(a^{u} b^{v}\right)\left(a^{s p} b^{t p}\right)$ if and only if $\left(a^{i p} b^{p}\right)\left(a^{j} b\right)=\left(a^{j} b\right)\left(a^{i p} b^{p}\right)$ if and only if $j \equiv i(\bmod p)$. Since $1 \leq i \leq p-1$, the conjugacy classes of Types 5 and 8 can be divided into $p-1$ parts. Moreover, this process constructs a complete subgraph of size $n(p-1)$ in the commuting conjugacy class graph.
(6) Suppose $a^{i_{1}} b^{t_{1} p}$ and $a^{i_{2}} b^{t_{2} p}$ are the representative of two conjugacy classes of Types 6 such that they are commute to each other. By Lemma 3.1, $a^{i_{1}} b^{t_{1} p}=\left(a b^{s_{1} p}\right)^{n_{i_{1}}} z_{1}$ and $a^{i_{2}} b^{t_{2} p}=\left(a b^{s_{2} p}\right)^{n_{i_{2}}} z_{2}$. On the other hand, by Lemma (2.1), $C_{G}\left(a^{i_{1}} b^{t_{1} p}\right)=$ $C_{G}\left(a b^{s_{1} p}\right)$ and $C_{G}\left(a^{i_{2}} b^{t_{2} p}\right)=C_{G}\left(a b^{s_{2} p}\right)$. Therefore, $\left(a^{i_{1}} b^{t_{1} p}\right)\left(a^{i_{2}} b^{t_{2} p}\right)=\left(a^{i_{2}} b^{t_{2} p}\right)\left(a^{i_{1}} b^{t_{1} p}\right)$ if and only if $\left(a b^{s_{1} p}\right)\left(a b^{s_{2} p}\right)=\left(a b^{s_{2} p}\right)\left(a b^{s_{1} p}\right)$ if and only if $a b^{\left(s_{2}-s_{1}\right) p}=b^{\left(s_{2}-s_{1}\right) p} a$. By Lemma 2.2(a), the last equality is satisfied if and only if $s_{1}=s_{2}$. This proves that in the commuting conjugacy class graph, two conjugacy classes of Type 6 are adjacent, when the centralizers of their representatives is equal. By Theorem 3.2, the number of centralizer of Types 6 is $p-1$ and so the conjugacy classes of this type can be divided into $p-1$ parts. On the other hand, by Table 1, the number of conjugacy classes of Type 6 is $m p(p-1)^{2}$. Hence, each part of Type 6 is a clique of size $m p(p-1)$. Now it is enough to determine the relationship between conjugacy classes of Type 6 with other conjugacy classes of Types 7 and 8. To do this, we assume that $a^{i} b^{t p}$ and $a^{s p} b^{j}$ are the representatives of conjugacy classes of Types 6 and 7 , respectively, such that they are commute to each other. By Equation 3.3, $\left(a^{i} b^{t p}\right)\left(a^{s p} b^{j}\right)=\left(a^{s p} b^{j}\right)\left(a^{i} b^{t p}\right)$ if and only if $a^{i} b^{j}=b^{j} a^{i}$. Since $p \nmid i, j$, Lemma 2.2(a) implies that the last equality cannot be occurred. This means that a conjugacy class of Type 6 is not adjacent with another one of Type 7 in the commuting conjugacy class graph. Next, we assume that $a^{i} b^{t p}$ and $a^{u} b^{v}$ are the representatives of two conjugacy classes of Types 6 and 8 , respectively and they are commute to each other. By Lemma 3.1, $a^{i} b^{t p}=\left(a b^{s p}\right)^{n_{i}} z_{1}$ and $a^{u} b^{v}=\left(a b^{j}\right)^{n_{u}} z_{2}$ and by Lemma 2.1, $C_{G}\left(a^{i} b^{t p}\right)=C_{G}\left(a b^{s p}\right)$ and $C_{G}\left(a^{u} b^{v}\right)=C_{G}\left(a b^{j}\right)$. Therefore, $\left(a^{i} b^{t p}\right)\left(a^{u} b^{v}\right)=\left(a^{u} b^{v}\right)\left(a^{i} b^{t p}\right)$ if an only if $\left(a b^{s p}\right)\left(a b^{j}\right)=\left(a b^{j}\right)\left(a b^{s p}\right)$ if and only if $b^{s p-j} a=a b^{s p-j}$. We now apply Lemma 2.2(a) to prove that the last equality is satisfied if and only if $p^{2} \mid(s p-j)$ or $p \mid j$ which is a contradiction. Since $p \nmid j$,
the conjugacy classes of Type 6 is not adjacent with another one of Type 8 in the commuting conjugacy class graph.
(7) Suppose that $a^{s_{1} p} b^{j_{1}}$ and $a^{s_{2} p} b^{j_{2}}$ are representatives of two conjugacy classes of Type 7 such that they are commuting to each other. By Lemma 3.1, $a^{s_{1} p} b^{j_{1}}=$ $\left(a^{t_{1} p} b\right)^{n_{j_{1}}} z_{1}$ and $a^{s_{2} p} b^{j_{2}}=\left(a^{t_{2} p} b\right)^{n_{j_{2}}} z_{2}$ and by Lemma 2.1, $C_{G}\left(a^{s_{1} p} b^{j_{1}}\right)=C_{G}\left(a^{t_{1} p} b\right)$ and $C_{G}\left(a^{s_{2} p} b^{j_{2}}\right)=C_{G}\left(a^{t_{2} p} b\right)$. Therefore, $\left(a^{s_{1} p} b^{j_{1}}\right)\left(a^{s_{2} p} b^{j_{2}}\right)=\left(a^{s_{2} p} b^{j_{2}}\right)\left(a^{s_{1} p} b^{j_{1}}\right)$ if and only if $\left(a^{t_{1} p} b\right)\left(a^{t_{2} p} b\right)=\left(a^{t_{2} p} b\right)\left(a^{t_{1} p} b\right)$ if and only if $b a^{\left(t_{2}-t_{1}\right) p}=a^{\left(t_{2}-t_{1}\right) p} b$. By Lemma 2.2(a), the last equality is satisfied if and only if $t_{1}=t_{2}$. This means that two conjugacy classes of Types 7 are adjacent in the commuting conjugacy class graph, when their centralizers is equal. Also, by Theorem 3.2, the number of centralizers of Type 7 is $p-1$. So, the conjugacy classes of this type can be divided into $p-1$ parts. Now by Table [1, the number of conjugacy classes of Type 7 is equal to $m p(p-1)^{2}$ and the graph structure of each part of Type 7 gives a complete subgraph of size $m p(p-1)$. It is enough to find the relationship between this and other conjugacy classes of Type 8 . To do this, we assume that $a^{s p} b^{j}$ and $a^{u} b^{v}$ are representatives of two conjugacy classes of Types 7 and 8, respectively such that they are commute to each other. By Lemma 3.1, $a^{s p} b^{j}=\left(a^{t p} b\right)^{n_{j}} z_{1}$ and $a^{u} b^{v}=\left(a^{i} b\right)^{n_{v}} z_{2}$. On the other hand, by Lemma 2.1, $C_{G}\left(a^{s p} b^{j}\right)=C_{G}\left(a^{t p} b\right)$ and $C_{G}\left(a^{u} b^{v}\right)=C_{G}\left(a^{i} b\right)$. Therefore, $\left(a^{s p} b^{j}\right)\left(a^{u} b^{v}\right)=\left(a^{u} b^{v}\right)\left(a^{s p} b^{j}\right)$ if and only if $\left(a^{t p} b\right)\left(a^{i} b\right)=\left(a^{i} b\right)\left(a^{t p} b\right)$ if and only if $a^{t p-i} b=b a^{t p-i}$. By Lemma 2.2(a), the last equality is satisfied if and only if $p^{2} \mid(t p-i)$ or $p \mid i$ which is a contradiction. Thus, the conjugacy classes of Type 7 is not adjacent with a conjugacy class of Type 8 in the commuting conjugacy class graph.
(8) Suppose $a^{i_{1}} b^{j_{1}}$ and $a^{i_{2}} b^{j_{2}}$ are the representatives of two conjugacy classes of Type 8 such that they are commuting together. By Lemma 3.1, $a^{i_{1}} b^{j_{1}}=\left(a^{s} b\right)^{n_{j_{1}}} z_{1}$ and $a^{i_{2}} b^{j_{2}}=\left(a^{t} b\right)^{n_{j_{2}}} z_{2}$ and by Lemma 2.1, $C_{G}\left(a^{i_{1}} b^{j_{1}}\right)=C_{G}\left(a^{s} b\right)$ and $C_{G}\left(a^{i_{2}} b^{j_{2}}\right)=$ $C_{G}\left(a^{t} b\right)$. Therefore, $\left(a^{i_{1}} b^{j_{1}}\right)\left(a^{i_{2}} b^{j_{2}}\right)=\left(a^{i_{2}} b^{j_{2}}\right)\left(a^{i_{1}} b^{j_{1}}\right)$ if and only if $\left(a^{s} b\right)\left(a^{t} b\right)=$ $\left(a^{t} b\right)\left(a^{s} b\right)$ if and only if $a^{s-t} b=b a^{s-t}$. By Lemma 2.2(a), the last equality is satisfied if and only if $s=t$. This means that two conjugacy classes of Type 8 are adjacent in the commuting conjugacy class graph, when their centralizers is equal. Also, by Theorem 3.2, the number of centralizers of Type 8 is $p(p-1)$ and so the conjugacy classes of this type can be divided into $p(p-1)$ parts. On the other hand, by Table 1, the number of conjugacy classes of Type 8 is $m p^{2}(p-1)^{2}$ which proves that each part of Type 8 gives a clique of size $m p(p-1)$ in the commuting conjugacy class graph. By our discussion in Case 5 , all conjugacy classes of Type

8 are adjacent only with conjugacy classes of Type 5 . Since the conjugacy classes of Types 5 and 8 can be divided into $p-1$ and $p(p-1)$ parts, every part of Type 5 is adjacent with $p$ parts of Type 8.
By above discussion in eight parts, the commuting conjugacy class graph of $G$ is a connected graph with $n\left(p^{2}-1\right)+m\left(p^{4}-p^{2}\right)$ vertices. Suppose $\mathcal{M}_{1}$ is a graph depicted in Figure 2. Therefore, the commuting conjugacy class graph of $G$ is a $\mathcal{M}_{1}$-join of graphs as follows:

$$
\Gamma(G)=\mathcal{M}_{1}[\overbrace{K_{n(p-1)}, \cdots, K_{n(p-1)}}^{p+1}, \overbrace{\left.K_{m\left(p^{2}-p\right)}, \cdots, K_{m\left(p^{2}-p\right)}\right]}^{p^{2}+p}],
$$

where $n=\frac{|Z|}{p}$ and $m=\frac{|Z|}{p^{2}}$. The graph $\Gamma(G)$ is depicted in Figure 3,


Figure 3. The Commuting Conjugacy Class Graph of $G$ with $\frac{G}{Z(G)} \cong$ $\mathbb{Z}_{p^{2}} \times \mathbb{Z}_{p^{2}}$.

In the following theorem, we study the commuting conjugacy class graph of $G$ with this condition that $\frac{G}{Z(G)} \cong \mathbb{Z}_{p^{2}} \rtimes \mathbb{Z}_{p^{2}}$, when the semidirect product is non-abelian. We recall that by Theorem [2.3, $p$ is an odd prime number.

Theorem 4.2. Suppose $p$ is an odd prime number and $G$ is a group with center $Z$ such that $\frac{G}{Z} \cong \mathbb{Z}_{p^{2}} \rtimes \mathbb{Z}_{p^{2}}$ and $\frac{G}{Z}$ is non-abelian. Then the commuting conjugacy classes of $G$ is as follows:

$$
\mathcal{M}_{2}[\overbrace{K_{n(p-1)}, \cdots, K_{n(p-1)}}^{p^{2}+p+1}, K_{n p(p-1)}],
$$

where $\mathcal{M}_{2}$ is depicted in Figure 4. Here, $n=\frac{|Z|}{p}$.


Figure 4. The Graph $\mathcal{M}_{2}$.

Proof. We first apply Equation 2.1 to deduce that

a^{i} Z b^{j} Z & =\left(a^{p} Z\right)^{-i j} b^{j} Z a^{i} Z \tag{4.4}
\end{align*}
$$

Choose elements $x$ and $g$ in $G \backslash Z$. By the proof of Theorem 3.2, $x=a^{i} b^{j} z_{1}$ and $g=a^{u} b^{v} z_{2}$, where $z_{1}, z_{2} \in Z, 0 \leq i, j, u, v \leq p^{2}-1$ and $i, j$, as well as $u, v$, are not simultaneously zero. In Equation 4.2, we put $i=p$ and $j=1$. Since $a^{p^{2}} \in Z, b Z a^{p} Z=$ $a^{p} Z b Z$. Thus $a^{p} Z \in Z\left(\frac{G}{Z}\right)$ and by Equations 4.3 and 4.4,

& =\left(a^{u} b^{v}\right)^{-1} Z\left(a^{i} b^{j}\right) Z\left(a^{u} b^{v}\right) Z \\
& =\left(a^{u} b^{v}\right)^{-1} Z a^{i} Z b^{j} Z a^{u} Z b^{v} Z \\
& =\left(a^{u} b^{v}\right)^{-1} Z a^{i} Z\left(a^{p} Z\right)^{u j} a^{u} Z b^{j} Z b^{v} Z \\
& =\left(a^{p} Z\right)^{u j}\left(a^{u} b^{v}\right)^{-1} Z a^{u} Z a^{i} Z b^{v} Z b^{j} Z \\
& =\left(a^{p} Z\right)^{u j}\left(a^{u} b^{v}\right)^{-1} Z a^{u} Z\left(a^{p} Z\right)^{-v i} b^{v} Z a^{i} Z b^{j} Z \\
& =\left(a^{p} Z\right)^{u j}\left(a^{p} Z\right)^{-v i}\left(a^{u} b^{v}\right)^{-1} Z a^{u} Z b^{v} Z a^{i} Z b^{j} Z \\
& =\left(a^{p} Z\right)^{u j-v i}\left(a^{u} b^{v}\right)^{-1} Z\left(a^{u} b^{v}\right) Z\left(a^{i} b^{j}\right) Z \\
& =\left(a^{(u j-v i) p} Z\right)\left(a^{i} b^{j}\right) Z \\
& =\left(a^{(u j-v i) p} a^{i} b^{j}\right) Z .
\end{aligned}

So, there exists $z \in Z$ such that

Suppose that $x=a^{i} b^{j} z$ is an arbitrary element of $G$ such that $0 \leq i, j \leq p^{2}-1$ and $i, j$ are not simultaneously zero. To compute the number of non-central conjugacy classes of $G$ and obtain their structure, we will consider three separate cases that all together can be divided into eight subcases:
a) $i \neq 0$ and $j=0$. This case is separated into two subcases that $p \mid i$ and $p \nmid i$ as follows:

1) $p \mid i$. Suppose $i=s p$, where $1 \leq s \leq p-1$. By Equation 4.5 and this fact that $a^{p^{2}} \in Z,\left(a^{u} b^{v}\right)^{-1}\left(a^{s p}\right)\left(a^{u} b^{v}\right)=a^{-v s p^{2}} a^{s p} z_{1}=a^{s p} z_{2}$ and so $\left(a^{s p}\right)^{G}=\left\{a^{s p} z \mid z \in Z\right\}$. On the other hand, by Theorem 3.2, $\left|C_{G}\left(a^{s p}\right)\right|=p^{3}|Z|$ and $\left|\left(a^{s p}\right)^{G}\right|=p$. Thus, $\left(a^{s p}\right)^{G}=\left\{a^{s p} z_{1}, \cdots, a^{s p} z_{p}\right\}=a^{s p} H$ in which $H=\left\{z_{1}, \cdots, z_{p}\right\} \subseteq Z$. Suppose $|Z|>p$ and choose the elements $z_{r} \in Z \backslash H$ and an element in the form $a^{s p} z_{r}$. It is easy to see that $a^{s p} z_{r} \notin\left(a^{s p}\right)^{G}$ and hence $\left(a^{s p} z_{r}\right)^{G} \neq\left(a^{s p}\right)^{G}$. Furthermore, $C\left(a^{s p} z_{r}\right)=C\left(a^{s p}\right)$ and so $\left|\left(a^{s p} z_{r}\right)^{G}\right|=\left|\left(a^{s p}\right)^{G}\right|=p$. Also, $\left(a^{s p} z_{r_{1}}\right)^{G}=\left(a^{s p}\right)^{G} z_{r_{1}}=$ $a^{s p} H z_{r_{1}}$. Since $\left(a^{s p}\right)^{G} \cap\left(a^{s p} z_{r_{1}}\right)^{G}=\emptyset, H \cap H z_{r_{1}}=\emptyset$ and $H \cup H z_{r_{1}} \subseteq Z$. We now choose the element $z_{r_{2}} \in Z \backslash\left(H \cup H z_{r_{1}}\right)$ and continue this process to prove that $p\left||Z|\right.$. If $n=\frac{|Z|}{p}$ then there are $n$ distinct conjugacy classes in the form of $\left(a^{s p} z_{r_{1}}\right)^{G},\left(a^{s p} z_{r_{2}}\right)^{G} \cdots\left(a^{s p} z_{r_{n}}\right)^{G}$. Since $1 \leq s \leq p-1$, there are $n(p-1)$ distinct conjugacy classes with $n=\frac{|Z|}{p}$ and each conjugacy class has $p$ elements.
2) $p \nmid i$. By Equation 4.5,

$$
\begin{equation*}
\left(a^{u} b^{v}\right)^{-1}\left(a^{i}\right)\left(a^{u} b^{v}\right)=a^{-v i p} a^{i} z \tag{4.6}
\end{equation*}
$$

By Theorem 3.2, $\left|C_{G}\left(a^{i}\right)\right|=p^{2}|Z|$ and so $\left|\left(a^{i}\right)^{G}\right|=p^{2}$. Note that $0 \leq v \leq p^{2}-1$ and so there are $v^{\prime}$ and $k$ such that $-v i=v^{\prime} p+k$ and $0 \leq k \leq p-1$. By Equation 4.6 and the fact that $a^{p^{2}} \in Z$,

$$
\begin{equation*}
\left(a^{i}\right)^{G}=\left\{a^{k p} a^{i} z_{(k, l)} \mid 0 \leq k, l \leq p-1, z_{(k, l)} \in Z\right\} . \tag{4.7}
\end{equation*}
$$

Set $A_{i}=\left\{a^{k p} a^{i} z \mid 0 \leq k \leq p-1, z \in Z\right\}$ and $H=\left\{z_{(0, l)} \mid 0 \leq l \leq p-1\right\}$. Obviously, $\left|A_{i}\right|=p|Z|,\left(a^{i}\right)^{G} \subseteq A_{i}$ and $H \subseteq Z$. If $|Z|>p$, then we choose an element $z_{r} \in Z \backslash H$ and an element $a^{i} z_{r} \in A_{i}$. It can be easily seen that $a^{i} z_{r} \notin\left(a^{i}\right)^{G}$ and $\left(a^{i} z_{r}\right)^{G} \neq\left(a^{i}\right)^{G}$. Since $C\left(a^{i} z_{r}\right)=C\left(a^{i}\right),\left|\left(a^{i} z_{r}\right)^{G}\right|=\left|\left(a^{i}\right)^{G}\right|=p^{2}$ and $\left(a^{i} z_{r_{1}}\right)^{G}=\left(a^{i}\right)^{G} z_{r_{1}}$. On the other hand, since $\left(a^{i}\right)^{G} \cap\left(a^{i} z_{r_{1}}\right)^{G}=\emptyset, H \cap H z_{r_{1}}=\emptyset$ and $H \cup H z_{r_{1}} \subseteq Z$. We now choose an element $z_{r_{2}} \in Z \backslash\left(H \cup H z_{r_{1}}\right)$ and continue this process to prove that $\left(a^{i} z_{r_{2}}\right)^{G} \subseteq A_{i}$. This shows that $p^{2}| | A_{i} \mid$. Put $n=\frac{\left|A_{i}\right|}{p^{2}}=\frac{|Z|}{p}$. Then, for each $i$ there are $n$ distinct conjugacy classes as $\left(a^{i} z_{r_{1}}\right)^{G}, \cdots,\left(a^{i} z_{r_{n}}\right)^{G}$. Again since $1 \leq i \leq p^{2}-1$ and $p \nmid i$, there are non-negative integers $k^{\prime}$ and $i^{\prime}$ such that $i=k^{\prime} p+i^{\prime}$ and $1 \leq i^{\prime} \leq p-1$. By Equation 4.7,

$$
\begin{aligned}
\left(a^{i}\right)^{G} & =\left(a^{k^{\prime} p+i^{\prime}}\right)^{G} \\
& =\left\{a^{k p} a^{k^{\prime} p+i^{\prime}} z_{(k, l)} \mid 0 \leq k, l \leq p-1, z_{(k, l)} \in Z\right\} \\
& =\left\{a^{\left(k+k^{\prime}\right) p} a^{i^{\prime}} z_{(k, l)} \mid 0 \leq k, l \leq p-1, z_{(k, l)} \in Z\right\} .
\end{aligned}
$$

Therefore, there exists $z_{i^{\prime}} \in Z$ such that $\left(a^{i}\right)^{G}=\left(a^{i^{\prime}} z_{i^{\prime}}\right)^{G}$. This proves that the number of distinct conjugacy classes is equal to $n(p-1)$ in which $n=\frac{|Z|}{p}$ and each class has $p^{2}$ elements.
b) $i=0$ and $j \neq 0$. Again there are two cases that $p \mid j$ and $p \nmid j$.
3) $p \mid j$. Suppose $j=t p$, where $1 \leq t \leq p-1$. By Equation 4.5 and the fact that $a^{p^{2}}$ is an element of $Z$, we can conclude that $\left(a^{u} b^{v}\right)^{-1}\left(b^{t p}\right)\left(a^{u} b^{v}\right)=a^{u t p^{2}} b^{t p} z_{1}=b^{t p} z_{2}$ and so $\left(b^{t p}\right)^{G}=\left\{b^{t p} z \mid z \in Z\right\}$. By Theorem 3.2, $\left|C_{G}\left(b^{t p}\right)\right|=p^{3}|Z|$ and hence $\left|\left(b^{t p}\right)^{G}\right|=p$. Therefore, similar to the Case 1 , there are $n$ distinct conjugacy classes $\left(b^{t p} z_{r_{1}}\right)^{G}, \cdots,\left(b^{t p} z_{r_{n}}\right)^{G}$, where $n=\frac{|Z|}{p}$. So, the number of distinct conjugacy classes is equal to $n(p-1)$ and each class has $p$ elements.
4) $p \nmid j$. Then by Equation 4.5, $\left(a^{u} b^{v}\right)^{-1}\left(b^{j}\right)\left(a^{u} b^{v}\right)=a^{u j p} b^{j} z$. By Theorem 3.2, $\left|C_{G}\left(b^{j}\right)\right|=p^{2}|Z|$ and so $\left|\left(b^{j}\right)^{G}\right|=p^{2}$. A similar argument as in the Case 2 shows that $\left(b^{j}\right)^{G}=\left\{a^{k p} b^{j} z_{(k, l)} \mid 0 \leq k, l \leq p-1, z_{(k, l)} \in Z\right\}$. Thus, there are $n$ distinct conjugacy classes $\left(b^{j} z_{r_{1}}\right)^{G}, \cdots,\left(b^{j} z_{r_{n}}\right)^{G}$, when $j$ is a fixed number and $n=\frac{|Z|}{p}$.

Since $1 \leq j \leq p^{2}-1$ and $p \nmid j$, the number of distinct conjugacy classes is equal to $n\left(p^{2}-p\right)$ and each class has $p^{2}$ elements.
c) $i \neq 0$ and $j \neq 0$. We have four subcases as follows:
5) $p \mid i$ and $p \mid j$. Suppose $i=s p$ and $j=t p$ such that $1 \leq s, t \leq p-1$. By Equation 4.5 and the fact that $a^{p^{2}} \in Z,\left(a^{u} b^{v}\right)^{-1}\left(a^{s p} b^{t p}\right)\left(a^{u} b^{v}\right)=a^{(u t p-v s p) p} a^{s p} b^{t p} z_{1}$ $=a^{(u t-v s) p^{2}} a^{s p} b^{t p} z_{1}=a^{s p} b^{t p} z_{2}$. Thus, $\left(a^{s p} b^{t p}\right)^{G}=\left\{a^{s p} b^{t p} z \mid z \in Z\right\}$. Apply Theorem 3.2 to deduce that $\left|C_{G}\left(a^{s p} b^{t p}\right)\right|=p^{3}|Z|$ which implies that $\left|\left(a^{s p} b^{t p}\right)^{G}\right|=p$. Similar to the Case 1, for fixed non-negative integers $s$ and $t$, there are $n$ distinct conjugacy classes as $\left(a^{s p} b^{t p} z_{r_{1}}\right)^{G}, \ldots,\left(a^{s p} b^{t p} z_{r_{n}}\right)^{G}$ in which $n=\frac{|Z|}{p}$. By above discussion, we result that the number of the distinct conjugacy classes is equal to $n(p-1)^{2}$ and each class has $p$ elements.
6) $p \nmid i$ and $p \mid j$. Suppose $j=t p$, where $1 \leq t \leq p-1$. By Equation 4.5 and the fact that $a^{p^{2}} \in Z,\left(a^{u} b^{v}\right)^{-1}\left(a^{i} b^{t p}\right)\left(a^{u} b^{v}\right)=a^{(u t p-v i) p} a^{i} b^{t p} z_{1}=a^{-v i p} a^{i} b^{t p} z_{2}$. By Theorem 3.2, $\left|C_{G}\left(a^{i} b^{t p}\right)\right|=p^{2}|Z|$ and so $\left|\left(a^{i} b^{t p}\right)^{G}\right|=p^{2}$. Now a similar argument as the Case 2 ,

$$
\begin{equation*}
\left(a^{i} b^{t p}\right)^{G}=\left\{a^{k p} a^{i} b^{t p} z_{(k, l)} \mid 0 \leq k, l \leq p-1, z_{(k, l)} \in Z\right\} . \tag{4.8}
\end{equation*}
$$

Hence, for fixed positive integers $i$ and $t$, there are $n$ distinct conjugacy classes as $\left(a^{i} b^{t p} z_{r_{1}}\right)^{G}, \ldots,\left(a^{i} b^{t p} z_{r_{n}}\right)^{G}$ in which $n=\frac{|Z|}{p}$. Since $1 \leq i \leq p^{2}-1$ and $p \nmid i$, there are integers $k^{\prime}$ and $i^{\prime}$ such that $i=k^{\prime} p+i^{\prime}$ and $1 \leq i^{\prime} \leq p-1$. By Equation 4.8,

$$
\begin{aligned}
\left(a^{i} b^{t p}\right)^{G} & =\left(a^{k^{\prime} p+i^{\prime}} b^{t p}\right)^{G} \\
& =\left\{a^{k p} a^{k^{\prime} p+i^{\prime}} b^{t p} z_{(k, l)} \mid 0 \leq k, l \leq p-1, z_{(k, l)} \in Z\right\} \\
& =\left\{a^{\left(k+k^{\prime}\right) p} a^{i^{\prime}} b^{t p} z_{(k, l)} \mid 0 \leq k, l \leq p-1, z_{(k, l)} \in Z\right\} .
\end{aligned}
$$

This shows that there exists $z_{\left(i^{\prime}, t\right)} \in Z$ such that $\left(a^{i} b^{t p}\right)^{G}=\left(a^{i^{\prime}} b^{t p} z_{\left(i^{\prime}, t\right)}\right)^{G}$. Since $1 \leq i^{\prime}, t \leq p-1$, the number of the distinct conjugacy classes is equal to $n(p-1)^{2}$ and each class has $p^{2}$ elements.
7) $p \mid i$ and $p \nmid j$. Suppose $i=s p$ such that $1 \leq s \leq p-1$. By Equation 4.5 and the fact that $a^{p^{2}} \in Z$, we have $\left(a^{u} b^{v}\right)^{-1}\left(a^{s p} b^{j}\right)\left(a^{u} b^{v}\right)=a^{(u j-v s p) p} a^{s p} b^{j} z_{1}=a^{u j p} a^{s p} b^{j} z_{2}$ $=a^{(u j+s) p} b^{j} z_{2}$. In this case, there is no new conjugacy class and the argument is similar to the Case 4.
8) $p \nmid i$ and $p \nmid j$. By Equation 4.5, $\left(a^{u} b^{v}\right)^{-1}\left(a^{i} b^{j}\right)\left(a^{u} b^{v}\right)=a^{(u j-v i) p} a^{i} b^{j} z$. By Theorem 3.2, $\left|C_{G}\left(a^{i} b^{j}\right)\right|=p^{2}|Z|$ and so $\left|\left(a^{i} b^{j}\right)^{G}\right|=p^{2}$. Now by a similar argument as in the Case 2, we can see that

$$
\begin{equation*}
\left(a^{i} b^{j}\right)^{G}=\left\{a^{k p} a^{i} b^{j} z_{(k, l)} \mid \underset{23}{\left.0 \leq k, l \leq p-1, z_{(k, l)} \in Z\right\} . . . ~}\right. \tag{4.9}
\end{equation*}
$$

Hence, for fixed positive integers $i$ and $j$, there are $n$ distinct conjugacy classes $\left(a^{i} b^{j} z_{r_{1}}\right)^{G}, \cdots,\left(a^{i} b^{j} z_{r_{n}}\right)^{G}$, where $n=\frac{|Z|}{p}$. Since $1 \leq i \leq p^{2}-1$ and $p \nmid i$, there are integers $k^{\prime}$ and $i^{\prime}$ such that $i=k^{\prime} p+i^{\prime}$ and $1 \leq i^{\prime} \leq p-1$. Therefore, by Equation 4.9 .

& =\left\{a^{\left(k+k^{\prime}\right) p} a^{i^{\prime}} b^{j} z_{(k, l)} \mid 0 \leq k, l \leq p-1, z_{(k, l)} \in Z\right\} .

Thus, there exists $z_{\left(i^{\prime}, j\right)} \in Z$ such that $\left(a^{i} b^{j}\right)^{G}=\left(a^{i^{\prime}} b^{j} z_{\left(i^{\prime}, j\right)}\right)^{G}$. Since $1 \leq i^{\prime} \leq p-1$, $1 \leq j \leq p^{2}-1$ and $p \nmid j$, the number of distinct conjugacy classes is equal to $n p(p-1)^{2}$ and each class has $p^{2}$ elements.

We now investigate the commuting conjugacy class graph of $G$. To do this, it is enough to determine the relationship between conjugacy classes in Table 2. We consider the following cases:
(1) Suppose $a^{s_{1} p}$ and $a^{s_{2} p}$ are the representatives of two classes of Type 1 in Table 2. It is clear that $a^{s_{1} p} a^{s_{2} p}=a^{s_{2} p} a^{s_{1} p}$ and so all conjugacy classes of Type 1 are commuting together. Hence, the commuting conjugacy class graph has a subgraph isomorphic to $K_{n(p-1)}$. We now determine the relationship between conjugacy classes of this and another types. For this purpose, we suppose $a^{s p}$ is a representative of a conjugacy class of Type 1 and $a^{u} b^{v} z$ is an arbitrary element of $G$ such that they are commuted to each other. This means that $\left(a^{s p}\right)\left(a^{u} b^{v} z\right)=$ 24
$\left(a^{u} b^{v} z\right)\left(a^{s p}\right)$ and hence $a^{s p} b^{v}=b^{v} a^{s p}$. By Lemma 2.2(a), the last equality is true if and only if $p \mid v$ or $v=t p$ in which $0 \leq t \leq p-1$. Then $a^{s p}$ commutes with all elements of the form $a^{u} b^{t p} z$. Therefore, the following cases can be occurred:
(a) $t=0$. Then the conjugacy classes of Types 1 and 2 in Table 2 are commuting together.
(b) $t \neq 0$ and $u=0$. In this case, the conjugacy classes of Types 1 and 3 in Table 2 are commuting to each other.
(c) $u, t \neq 0$ and $p \mid u$. Then the conjugacy classes of Types 1 and 5 in Table 2 are commuting together.
(d) $t \neq 0$ and $p \nmid u$. By this condition, the conjugacy classes of Types 1 and 6 are commuting together.
(2) Suppose $a^{i_{1}}$ and $a^{i_{2}}$ are the representatives of two conjugacy classes of Type 2. Obviously, $a^{i_{1}} a^{i_{2}}=a^{i_{2}} a^{i_{1}}$ and so all conjugacy classes of Type 2 are commuted to each other in the group. Hence, the commuting conjugacy class graph has a clique of size $n(p-1)$. We now determine the relation between this and another types. To do this, we suppose that $a^{i}$ is a representative of a conjugacy class of Type 2 and $a^{u} b^{v} z$ is an arbitrary element of $G$ such that $\left(a^{i}\right)\left(a^{u} b^{v} z\right)=\left(a^{u} b^{v} z\right)\left(a^{i}\right)$. Thus, $a^{i} b^{v}=b^{v} a^{i}$. Since $p \nmid i$, then By Lemma (2.2) (a) the last equality is satisfied if and only if $v=0$. Then $a^{i}$ commutes with all elements of the form $a^{u} z$ which shows that the conjugacy classes of Type 2 are commuting only with conjugacy classes of Type 1.
(3) Suppose $b^{t_{1} p}$ and $b^{t_{2} p}$ are representatives of two conjugacy classes of Type 3. It is clear that $b^{t_{1} p} b^{t_{2} p}=b^{t_{2} p} b^{t_{1} p}$. This shows that all conjugacy classes of Type 3 are commuting together and hence the commuting conjugacy class graph has a subgraph isomorphic to $K_{n(p-1)}$. We now determine the relation between this and another types. Suppose $b^{t p}$ is a representatives of a conjugacy class of Type 3 and $a^{u} b^{v} z$ is an arbitrary element of $G$ such that $\left(b^{t p}\right)\left(a^{u} b^{v} z\right)=\left(a^{u} b^{v} z\right)\left(b^{t p}\right)$. Thus, $b^{t p} a^{u}=a^{u} b^{t p}$. By Lemma 2.2(a), the last equality is satisfied if and only if $p \mid u$ or $u=s p$ in which $0 \leq s \leq p-1$. Then $b^{t p}$ commutes with all elements in the form of $a^{s p} b^{v} z$. Again, the following cases can be occurred:
(a) $s=0$. Then the conjugacy classes of Types 3 and 4 in Table 2 are commuting together.
(b) $s \neq 0$ and $v=0$. Under this condition, the conjugacy classes of Types 3 and 1 in Table 2 are commuting together.
(c) $v, s \neq 0$ and $p \mid v$. In this case, the conjugacy classes of Types 3 and 5 in Table 2 are commuting to each other.
(d) $s \neq 0$ and $p \nmid v$. The classes classes of Types 3 and 7 in Table 2 are commuting together.
(4) Suppose $b^{j_{1}}$ and $b^{j_{2}}$ are representatives of two conjugacy classes of Type 4. Since $b^{j_{1}} b^{j_{2}}=b^{j_{2}} b^{j_{1}}$, all conjugacy classes of Type 4 are commuting together and hence the commuting conjugacy class graph has a clique of size $n p(p-1)$. We now determine the relationship between this and another types. To do this, we assume that $b^{j}$ is a representative of a conjugacy class of Type 4 and $a^{u} b^{v} z$ is an arbitrary element of $G$ such that $\left(b^{j}\right)\left(a^{u} b^{v} z\right)=\left(a^{u} b^{v} z\right)\left(b^{j}\right)$. Thus, $b^{j} a^{u}=a^{u} b^{j}$. Since $p \nmid j$, by Lemma 2.2(a) the last equality is satisfied if and only if $u=0$. Then $b^{j}$ commutes with all elements in the form of $b^{v} z$. So, the conjugacy classes of Type 4 are commuting only with the conjugacy classes of Type 3.
(5) Suppose $a^{s_{1} p} b^{t_{1} p}$ and $a^{s_{2} p} b^{t_{2} p}$ are representatives of two conjugacy classes of Type 5. By Equation 3.3, $\left(a^{s_{1} p} b^{t_{1} p}\right)\left(a^{s_{2} p} b^{t_{1} p}\right)=\left(a^{s_{2} p} b^{t_{2} p}\right)\left(a^{s_{1} p} b^{t_{2} p}\right)$. This proves that all conjugacy classes of Type 5 are commuting to each other and hence the commuting conjugacy class graph has a clique of size $n(p-1)^{2}$. It is now enough to determine the relationship between this and conjugacy classes of types 6, 7 and 8. Suppose $a^{s p} b^{t p}$ and $a^{u} b^{v p}$ are representatives of conjugacy classes of Types 5 and 6, respectively, which are commuting together. By Lemma 3.1, $a^{s p} b^{t p}=\left(a^{i p} b^{p}\right)^{n_{t}} z_{1}$ and $a^{u} b^{v p}=\left(a b^{j p}\right)^{n_{u}} z_{2}$. On the other hand, By Lemma 2.1, $C_{G}\left(a^{s p} b^{t p}\right)=C_{G}\left(a^{i p} b^{p}\right)$ and $C_{G}\left(a^{u} b^{v p}\right)=C_{G}\left(a b^{j p}\right)$. We note that $\left(a^{s p} b^{t p}\right)\left(a^{u} b^{v p}\right)=\left(a^{u} b^{v p}\right)\left(a^{s p} b^{t p}\right)$ if and only if $\left(a^{i p} b^{p}\right)\left(a b^{j p}\right)=\left(a b^{j p}\right)\left(a^{i p} b^{p}\right)$ if and only if $b^{p} a=a b^{p}$, contradicts by Lemma 2.2(a). Therefore, a conjugacy class of Type 5 is not adjacent with a conjugacy class of Type 6. We now assume that $a^{s p} b^{t p}$ and $a^{u} b^{v}$ are representatives of the conjugacy classes of Types 5 and 8 , respectively, which are commute to each other. By Lemma 3.1, $a^{s p} b^{t p}=\left(a^{i p} b^{p}\right)^{n_{t}} z_{1}$ and $a^{u} b^{v}=\left(a^{j} b\right)^{n_{v}} z_{2}$. On the other hand, By Lemma [2.1, $C_{G}\left(a^{s p} b^{t p}\right)=C_{G}\left(a^{i p} b^{p}\right)$ and $C_{G}\left(a^{u} b^{v}\right)=C_{G}\left(a^{j} b\right)$. By Equation 3.9, $\left(a^{s p} b^{t p}\right)\left(a^{u} b^{v}\right)=\left(a^{u} b^{v}\right)\left(a^{s p} b^{t p}\right)$ if and only if $\left(a^{i p} b^{p}\right)\left(a^{j} b\right)=\left(a^{j} b\right)\left(a^{i p} b^{p}\right)$ if and only if $j \equiv i(\bmod p)$. Since $1 \leq i \leq p-1$, the conjugacy classes of Types 5 and 8 can be divided into $p-1$ parts and hence each part of Type 5 gives a complete subgraph of size $n(p-1)$.
(6) Suppose $a^{i_{1}} b^{t_{1} p}$ and $a^{i_{2}} b^{t_{2} p}$ are representatives of two commuting conjugacy classes of Type 6. By Lemma 3.1, $a^{i_{1}} b^{t_{1} p}=\left(a b^{s_{1} p}\right)^{n_{i_{1}}} z_{1}$ and $a^{i_{2}} b^{t_{2} p}=\left(a b^{s_{2} p}\right)^{n_{i_{2}}} z_{2}$. On the other hand, by Lemma 2.1, $C_{G}\left(a^{i_{1}} b^{t_{1} p}\right)=C_{G}\left(a b^{s_{1} p}\right)$ and $C_{G}\left(a^{i_{2}} b^{t_{2} p}\right)=C_{G}\left(a b^{s_{2} p}\right)$.

This proves that $\left(a^{i_{1}} b^{t_{1} p}\right)\left(a^{i_{2}} b^{t_{2} p}\right)=\left(a^{i_{2}} b^{t_{2} p}\right)\left(a^{i_{1}} b^{t_{1} p}\right)$ if and only if $\left(a b^{s_{1} p}\right)\left(a b^{s_{2} p}\right)=$ $\left(a b^{s_{2} p}\right)\left(a b^{s_{1} p}\right)$ if and only if $a b^{\left(s_{2}-s_{1}\right) p}=b^{\left(s_{2}-s_{1}\right) p} a$. By Lemma 2.2(a), the last equality is satisfied if and only if $s_{1}=s_{2}$ and so in the commuting conjugacy class graph two conjugacy classes of Type 6 are adjacent, when their centralizers is equal. Also, by Theorem 3.2, the number of centralizers of Type 6 is $p-1$. So, the conjugacy classes of this type can be divided into $p-1$ parts. On the other hand, by Table 2, the number of conjugacy classes of Type 6 are $n(p-1)^{2}$. Hence, each part of Type 6 gives a complete subgraph isomorphic to $K_{n(p-1)}$. It is now enough to find the relationship between conjugacy classes of Types 6 and 8. To see this, we assume that $a^{i} b^{t p}$ and $a^{u} b^{v}$ are representatives of conjugacy classes of Types 6 and 8 , respectively, such that they are commuting together. By Lemma 3.1) $a^{i} b^{t p}=\left(a b^{s p}\right)^{n_{i}} z_{1}$ and $a^{u} b^{v}=\left(a b^{j}\right)^{n_{u}} z_{2}$. On the other hand, by Lemma 2.1. $C_{G}\left(a^{i} b^{t p}\right)=C_{G}\left(a b^{s p}\right)$ and $C_{G}\left(a^{u} b^{v}\right)=C_{G}\left(a b^{j}\right)$. Therefore, $\left(a^{i} b^{t p}\right)\left(a^{u} b^{v}\right)=$ $\left(a^{u} b^{v}\right)\left(a^{i} b^{t p}\right)$ if and only if $\left(a b^{s p}\right)\left(a b^{j}\right)=\left(a b^{j}\right)\left(a b^{s p}\right)$ if and only if $b^{s p-j} a=a b^{s p-j}$. By Lemma 2.2(a), the last equality is satisfied if and only if $p^{2} \mid(s p-j)$ or $p \mid j$ which is impossible. This shows that in the commuting conjugacy class graph, the conjugacy classes of Type 6 is not adjacent with any conjugacy classes of Type 8.
(7) Suppose $a^{i_{1}} b^{j_{1}}$ and $a^{i_{2}} b^{j_{2}}$ are representatives of two commuting conjugacy classes of Type 8 such that they are commuting together. By Lemma 3.1, $a^{i_{1}} b^{j_{1}}=\left(a^{s} b\right)^{n_{j_{1}}} z_{1}$ and $a^{i_{2}} b^{j_{2}}=\left(a^{t} b\right)^{n_{j_{2}}} z_{2}$. On the other hand, by Lemma 2.1, $C_{G}\left(a^{i_{1}} b^{j_{1}}\right)=C_{G}\left(a^{s} b\right)$ and $C_{G}\left(a^{i_{2}} b^{j_{2}}\right)=C_{G}\left(a^{t} b\right)$. Therefore, $\left(a^{i_{1}} b^{j_{1}}\right)\left(a^{i_{2}} b^{j_{2}}\right)=\left(a^{i_{2}} b^{j_{2}}\right)\left(a^{i_{1}} b^{j_{1}}\right)$ if and only if $\left(a^{s} b\right)\left(a^{t} b\right)=\left(a^{t} b\right)\left(a^{s} b\right)$ if and only if $a^{s-t} b=b a^{s-t}$. By Lemma 2.2(a), the last equality is satisfied if and only if $s=t$ and so in the commuting conjugacy class graph two conjugacy classes of Type 8 are adjacent, when their centralizers is equal. Also, by Theorem [3.2, the number of centralizers of Type 8 is equal to $p(p-1)$ and so the conjugacy classes of this type can be divided into $p(p-1)$ parts. By Table 1, the number of conjugacy classes of Type 8 is $n p(p-1)^{2}$ and hence each part of Type 8 gives a complete subgraph of size $n(p-1)$. Therefore, we can see that in commuting conjugacy class graph of $G$, the conjugacy classes of Type 8 are adjacent only with conjugacy classes of Type 5 . Finally, we know that the conjugacy classes of Types 5 and 8 can be divided into $p-1$ and $p(p-1)$ parts, respectively. Therefore, every conjugacy class of Type 5 is adjacent with $p$ conjugacy classes of Type 8 .

By above discussion, the commuting conjugacy class graph of $G$ is a connected graph with $n(p-1)(p+1)^{2}$ vertices. Suppose $\mathcal{M}_{2}$ is the graph depicted in Figure 3. Then the
commuting conjugacy class graph of $G$ can be written as a $\mathcal{M}_{2}$-join, i.e.

$$
\Gamma(G)=\mathcal{M}_{2}[\overbrace{K_{n(p-1)}, \cdots, K_{n(p-1)}}^{p^{2}+p+1}, K_{n p(p-1)}] .
$$

The graph $\Gamma(G)$ is depicted in Figure 5 .
