# ON A CONJECTURE OF BAHRI-XU 

HONG CHEN, JIANQUAN GE, KAI JIA, AND ZHIQIN LU


#### Abstract

In order to study the Yamabe changing-sign problem, Bahri and Xu proposed a conjecture which is a universal inequality for $p$ points in $\mathbb{R}^{m}$. They have verified the conjecture for $p \leq 3$. In this paper, we first simplify this conjecture by giving two sufficient and necessary conditions inductively. Then we prove the conjecture for the basic case $m=1$ with arbitrary $p$. In addition, for the cases when $p=4,5$ and $m \geq 2$, we manage to reduce them to the basic case $m=1$ and thus prove them as well.


## 1. Introduction

In the study of Yamabe problem on $S^{3}$, we consider a semi-linear equation

$$
\begin{equation*}
\Delta_{\mathbb{R}^{3}} u+u^{5}=0, \quad u>0 \tag{1.1}
\end{equation*}
$$

It is well known that

$$
\delta(a, \lambda)=\frac{c \sqrt{\lambda}}{\left(1+\lambda^{2}|x-a|^{2}\right)^{1 / 2}}
$$

for any real number $\lambda$ and vector $a \in \mathbb{R}^{3}$ (with appropriate constant $c$ ) is a solution to the above equation. Moreover, for $\lambda_{i}$ large enough, the combinations $\sum_{i=1}^{p} \delta\left(a_{i}, \lambda_{i}\right)$ are almost solutions to the equation.

From PDE point of view, it would be interesting to study Equation (1.1) without the positivity assumption on $u$ as well. In the book [1], Bahri and Xu introduced the problem of studying the Morse Lemma at infinity. Morse Lemma is interesting in this situation because even for positive solutions, Equation (1.1) is a variational problem with defects. In order to study these defects, in [1], the following question was introduced.

We consider the functional $J(u)$ defined by

J(u)=\left(\int_{\mathbb{R}^{3}} u^{6} \mathrm{~d} x\right)^{-1}
$$

$$
\Sigma=\left\{\left.w\left|\int_{\mathbb{R}^{3}}\left(|\nabla w|^{2}+w^{6}\right) d x<\infty, \int_{\mathbb{R}^{3}}\right| \nabla w\right|^{2} d x=1\right\} .
$$

Let $\bar{w}_{1}, \cdots, \bar{w}_{p}$ be $p$ (possibly sign changing) solutions of (1.1). Let $a_{1}, \cdots, a_{p} \in \mathbb{R}^{3}$ be $p$ points. Let $\lambda_{1}, \cdots, \lambda_{p}>0$ be very large numbers. We wish to establish a formula for the functional $J$ that corresponds to the following linear combination

$$
\sum_{i=1}^{p} \alpha_{i} \sqrt{\lambda_{i}} \bar{w}_{i}\left(\lambda_{i}\left(x-a_{i}\right)\right)
$$

of solutions. More precisely, we wish to establish an asymptotic expansion of the following

$$
J\left(\sum_{i=1}^{p} \alpha_{i} \sqrt{\lambda_{i}} \bar{w}_{i}\left(\lambda_{i}\left(x-a_{i}\right)\right)+v\right),
$$

where $\alpha_{i}$ are constants and $v$ is a function satisfying Condition (Vo) in [1, Page 3].
In order to establish such an asymptotic expansion, Bahri and Xu made two additional assumptions (conjectures), one of which is purely linear algebraic, and can be stated as follows

Conjecture 1.1. Let $x_{1}, \ldots, x_{p}(p \geq 2)$ be distinct vectors in $\mathbb{R}^{m}$. Then there is a positive constant $c=c(p, m)$ depending only on $p$ and $m$, such that

|A U|^{2}+\sup _{1 \leq i \leq p}\left|U^{T}\left(\frac{\partial A}{\partial x_{i}}\right) U\right| \geq c(p, m) \sum_{\substack{i, j \\ j \neq i}} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \tag{1.2}
\end{equation*}
$$

for any $U=\left(u_{1}, \ldots, u_{p}\right)^{\mathrm{T}} \in \mathbb{R}^{p}$, where $A=\left(a_{i j}\right)_{1 \leq i, j \leq p}$ is a $p \times p$ matrix with entries

$$
a_{i j}= \begin{cases}0, & i=j \\ \frac{1}{\mid x_{i}-x_{j}}, & i \neq j\end{cases}
$$

that is,

$$
A=\left(\begin{array}{cccc}
0 & \frac{1}{\left|x_{1}-x_{2}\right|} & \cdots & \frac{1}{\left|x_{1}-x_{p}\right|} \\
\frac{1}{\left|x_{2}-x_{1}\right|} & 0 & \cdots & \frac{1}{\left|x_{2}-x_{p}\right|} \\
\vdots & \vdots & \ddots & \vdots \\
\frac{1}{\left|x_{p}-x_{1}\right|} & \frac{1}{\left|x_{p}-x_{2}\right|} & \cdots & 0
\end{array}\right),
$$

and

$$
\frac{\partial A}{\partial x_{k}}=\left(\frac{\partial a_{i j}}{\partial x_{k}}\right)_{1 \leq i, j \leq p}
$$

is a vector-valued $p \times p$ matrix.

Equivalently, (1.2) can be rewritten as

$$

\sum_{1 \leq i \leq p}\left|\sum_{j \neq i} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2}+2 \sup _{1 \leq i \leq p}\left|\sum_{j \neq i} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| \geq c(p, m) \sum_{\substack{i, j \\ j \neq i}} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \tag{1.3}
\end{equation*}
$$

Let $I_{1}, I_{2}$ denote the two hands of (1.3):

I_{1} & =\sum_{1 \leq i \leq p}\left|\sum_{j \neq i} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2}+2 \sup _{1 \leq i \leq p}\left|\sum_{j \neq i} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| \\
I_{2} & =\sum_{\substack{i, j \\
j \neq i}} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}
\end{aligned}
$$

Remark 1. The conjecture was stated in [1, page 4, Conjecture 2], where $m=3$. We extend the conjecture from 3 dimensional to arbitrary dimensional. We found that even in the case $m=1$, that is, when all $x_{i}$ are real numbers instead of vectors, the conjecture is still interesting and open.

Remark 2. Due to the symmetries of (1.3), we only need to consider the conjecture for $m \leq p-1$. In fact, if $m \geq p$, we may assume that $x_{1}, \ldots, x_{p}$ lie in $\mathbb{R}^{p-1} \hookrightarrow \mathbb{R}^{m}$ since any $p$ points in $\mathbb{R}^{m}$ must lie in some affine subspace of dimension $p-1$ and (1.3) is invariant under ambient similarities of $\mathbb{R}^{m}$.

The main purpose of this paper is to study Conjecture 1.1. If $p=2$, then $|A U|^{2}=$ $\frac{u_{1}^{2}+u_{2}^{2}}{\left|x_{1}-x_{2}\right|^{2}}=I_{2}$, and thus the conjecture is valid for $c(p, m)=1$.

In [2], Xu proved the case $p=m=3$. By the above remark, Xu's result actually implies the cases of $p=3$ with arbitrary $m$.

From now on, we are only concerned with $p \geq 4$.
In this paper, we shall prove some equivalent conditions for Conjecture 1.1, see Theorems 1.1 and 1.2. In addition, we shall prove the conjecture in some special cases, namely, the basic case $m=1$ with arbitrary $p$; and $p=4,5$ with arbitrary $m$.

In Section 2 we give the following equivalent characterization for Conjecture 1.1,
Theorem 1.1. Let $p_{0} \geq 4$. Conjecture 1.1 holds for any $4 \leq p \leq p_{0}$, if and only if for any $4 \leq p \leq p_{0}$ and distinct $x_{1}, \ldots, x_{p} \in \mathbb{R}^{m}$, the equations

\sum_{j \neq i} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}=0, \quad 1 \leq i \leq p \tag{1.4}
\end{equation*}
$$

and,

$$
\begin{equation*}
u_{i} \sum_{j \neq i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}=0, \quad 1 \leq i \leq p \tag{1.5}
\end{equation*}
$$

about $u_{1}, \ldots, u_{p}$ have NO non-zero solution.

In Section 3 we firstly prove the following simplified equivalent conditions, using which we then prove the special cases mentioned before.

Theorem 1.2. Let $p_{0} \geq 4$. Conjecture 1.1 holds for $4 \leq p \leq p_{0}$, if and only if for $4 \leq p \leq p_{0}$, given any distinct $y_{1}, \ldots, y_{p} \in \mathbb{S}^{m}$, the equations

\begin{equation*}
\sum_{j \neq i} \frac{y_{i}-y_{j}}{\left|y_{i}-y_{j}\right|^{3}} v_{j}=0, \quad 1 \leq i \leq p \tag{1.6}
\end{equation*}
$$

for $v_{1}, \ldots, v_{p}$ have NO non-zero solution.

## 2. Proof of Theorem 1.1

In this section, we prove Theorem 1.1 by induction on $p_{0}$. Assuming that Conjecture 1.1 holds for $p \leq p_{0}-1\left(p_{0} \geq 4\right)$, we shall consider the equivalence when $p=p_{0}$. The difficulty lies in the analysis when there are singularities, namely, one or more pairs of vectors with distance $\left|x_{i}-x_{j}\right|$ going to zero or infinity. This would be also an obstacle if one tried to prove the equivalence by contradiction. Hence from the inductive viewpoint, we treat with these two cases of singularities in Lemmas 2.2 and 2.1 separately.

First, observe that the inequality is homogeneous with respect to $x_{1}, \ldots, x_{p}$. Thus, without loss of generality, we may assume that $\left|x_{1}-x_{2}\right|=\min _{i \neq j}\left|x_{i}-x_{j}\right|=1$, and

$$
1=\left|x_{1}-x_{2}\right| \leq\left|x_{1}-x_{3}\right| \leq \cdots \leq\left|x_{1}-x_{p}\right| .
$$

The following Lemma 2.1 deals with unbounded cases.
Lemma 2.1. Assume that Conjecture 1.1 holds for $p \leq p_{0}-1$. When $p=p_{0} \geq 4$, let $2 \leq s \leq p-2$. For any $\beta_{1}, \ldots, \beta_{s-1} \geq 1$, there exists $M_{s}>0$, such that for any $x_{1}, \ldots, x_{s}$ satisfying

\begin{equation*}
\left|x_{1}-x_{i+1}\right| \leq \beta_{i}, \quad 1 \leq i \leq s-1, \tag{*}
\end{equation*}
$$

Conjecture 1.1 holds if $\left|x_{1}-x_{s+1}\right|>M_{s}$.

Proof. Fix any $\beta_{1}, \ldots, \beta_{s-1} \geq 1$, then $\left|x_{1}-x_{i+1}\right| \leq \beta_{i}$, for $i=1,2, \ldots, s-1$. Let $\alpha=$ $\beta_{s-1}$, then $1 \leq\left|x_{1}-x_{s}\right| \leq \alpha$. In this proof, we consider only the case $\left|x_{1}-x_{s+1}\right| \geq 2 \alpha$.

Firstly, we give some important inequalities that would be useful in the following proof. For $j \leq s, i \geq s+1$,

\left|x_{i}-x_{j}\right| & \geq\left|x_{1}-x_{i}\right|-\left|x_{1}-x_{j}\right| \\
& \geq 2 \alpha-\left|x_{1}-x_{j}\right| \\
& \geq 2\left|x_{1}-x_{j}\right|-\left|x_{1}-x_{j}\right| \\
& =\left|x_{1}-x_{j}\right|  \tag{2.1}\\
\left|x_{i}-x_{s+1}\right| & \leq\left|x_{i}-x_{1}\right|+\left|x_{1}-x_{s+1}\right| \\
& \leq 2\left|x_{i}-x_{1}\right| \\
& \leq 2\left|x_{i}-x_{j}\right|+2\left|x_{j}-x_{1}\right| \\
& \leq 4\left|x_{i}-x_{j}\right|  \tag{2.2}\\
\mid x_{j} & -x_{s+1}|\leq 5| x_{i}-x_{j} \mid \tag{2.3}
\end{align*}
$$

Now, we deal with $I_{1}$. Since $(a+2 b)^{2}=a^{2}+4 a b+4 b^{2}=2\left[(a+b)^{2}-\left(a^{2} / 2-b^{2}\right)\right] \geq 0$, we have

\sum_{1 \leq i \leq p}\left|\sum_{j \neq i} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2} \geq \sum_{i \leq s+1}\left|\sum_{j \neq i} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2}
$$

$$
\begin{equation*}
\geq \frac{1}{2} \sum_{i \leq s+1}\left|\sum_{j \neq i, j \leq s+1} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2}-\sum_{i \leq s+1}\left|\sum_{j>s+1} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2} \tag{2.4}
\end{equation*}
$$

Since

$$
\sup _{i \leq s+1}\left|a_{i}+b_{i}\right| \geq\left|a_{k}+b_{k}\right| \geq\left|a_{k}\right|-\left|b_{k}\right| \geq\left|a_{k}\right|-\sup _{i \leq s+1}\left|b_{i}\right|, \quad \forall k \leq s+1
$$

we have

$$
\sup _{i \leq s+1}\left|a_{i}+b_{i}\right| \geq \sup _{i \leq s+1}\left|a_{i}\right|-\sup _{i \leq s+1}\left|b_{i}\right|
$$

Thus,

$$
\begin{align*}
& 2 \sup _{1 \leq i \leq p}\left|\sum_{j \neq i} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| \\
& \geq 2 \sup _{1 \leq i \leq s+1}\left|\sum_{j \neq i} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| \\
& \geq 2 \sup _{1 \leq i \leq s+1}\left|\sum_{j \neq i, j \leq s+1} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right|-2 \sup _{1 \leq i \leq s+1}\left|\sum_{j \neq i, j>s+1} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| \tag{2.5}
\end{align*}
$$

By (2.4) and (2.5), we have

$$
\begin{aligned}
& I_{1} \geq \frac{1}{2} \sum_{i \leq s+1}\left|\sum_{j \neq i, j \leq s+1} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2}+2 \sup _{1 \leq i \leq s+1}\left|\sum_{j \neq i, j \leq s+1} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| \\
& \quad-\sum_{i \leq s+1}\left|\sum_{j>s+1} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2}-2 \sup _{1 \leq i \leq s+1}\left|\sum_{j \neq i, j>s+1} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| .
\end{aligned}
$$

Since $s+1 \leq p-1$, by the inductive assumption, there exists constant $c_{1}=$ $c_{1}(p, m)>0$, such that

\begin{align*}
& I_{1} \geq c_{1} \sum_{i, j \leq s+1, j \neq i} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \\
& -\sum_{i \leq s+1}\left|\sum_{j>s+1} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2}-2 \sup _{1 \leq i \leq s+1}\left|\sum_{j \neq i, j>s+1} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| . \tag{2.6}
\end{align*}
$$

Consider the middle term in (2.6), by the special case of the power means inequality, we have

\frac{1}{p-s-1} \sum_{j>s+1} \frac{u_{j}}{\left|x_{i}-x_{j}\right|} \leq \sqrt{\frac{1}{p-s-1} \sum_{j>s+1} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}}
$$

thus,

$$
\begin{equation*}
\sum_{i \leq s+1}\left|\sum_{j>s+1} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}\right|^{2} \leq(p-s-1) \sum_{j>s+1, i \leq s+1} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \tag{2.7}
\end{equation*}
$$

Consider the last term in (2.6). When $i=s+1$, then

$$
\begin{align*}
2\left|\sum_{j>s+1} u_{s+1} \frac{x_{s+1}-x_{j}}{\left|x_{s+1}-x_{j}\right|^{3}} u_{j}\right| & \leq \sum_{j>s+1} \frac{2\left|u_{s+1} u_{j}\right|}{\left|x_{s+1}-x_{j}\right|^{2}} \\
& \leq \sum_{j>s+1} \frac{u_{s+1}^{2}}{\left|x_{s+1}-x_{j}\right|^{2}}+\sum_{j>s+1} \frac{u_{j}^{2}}{\left|x_{s+1}-x_{j}\right|^{2}} . \tag{2.8}
\end{align*}
$$

When $i \leq s$, since $\left|x_{i}-x_{j}\right| \geq 1$,

$$
\begin{equation*}
2\left|\sum_{j>s+1} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| \leq \sum_{j>s+1} \frac{2\left|u_{i} u_{j}\right|}{\left|x_{i}-x_{j}\right|^{2}} \leq \sum_{j>s+1} \frac{2\left|u_{i}\right|\left|u_{j}\right|}{\left|x_{i}-x_{j}\right|} . \tag{2.9}
\end{equation*}
$$

By the inequality of arithmetic and geometric means,

$$
\frac{1}{a}\left|u_{i}\right|^{2}+a \frac{\left|u_{j}\right|^{2}}{\left|x_{i}-x_{j}\right|^{2}} \geq \frac{2\left|u_{i}\right|\left|u_{j}\right|}{\left|x_{i}-x_{j}\right|},
$$

taking $a=(p-s-1) \frac{2 \alpha^{2}}{c_{1}}>0$, we get

$$
\begin{equation*}
\sum_{j>s+1} \frac{2\left|u_{i}\right|\left|u_{j}\right|}{\left|x_{i}-x_{j}\right|} \leq \sum_{j>s+1} \frac{1}{a} u_{i}^{2}+\sum_{j>s+1} a \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \leq \frac{c_{1}}{2 \alpha^{2}} u_{i}^{2}+a \sum_{j>s+1, i \leq s} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \tag{2.10}
\end{equation*}
$$

Now take $i_{0}: 1 \leq i_{0} \leq s$, such that $u_{i_{0}}^{2}=\max _{1 \leq i \leq s} u_{i}^{2}$. If $i_{0}=1$, we take the term $i=2, j=1$ in the sum $\frac{1}{2} c_{1} \sum_{i, j \leq s+1, j \neq i} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}$, then

\frac{1}{2} c_{1} \sum_{i, j \leq s+1, j \neq i} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \geq \frac{c_{1} u_{1}^{2}}{2\left|x_{2}-x_{1}\right|^{2}} \geq \frac{c_{1}}{2 \alpha^{2}} u_{i_{0}}^{2}
$$

If $2 \leq i_{0} \leq s$, we take the term $i=1, j=i_{0}$, then

$$
\frac{1}{2} c_{1} \sum_{i, j \leq s+1, j \neq i} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \geq \frac{c_{1} u_{i_{0}}^{2}}{2\left|x_{i_{0}}-x_{1}\right|^{2}} \geq \frac{c_{1}}{2 \alpha^{2}} u_{i_{0}}^{2}
$$

In either case, we have

$$
\begin{equation*}
\frac{c_{1}}{2 \alpha^{2}} u_{i_{0}}^{2} \leq \frac{1}{2} c_{1} \sum_{i, j \leq s+1, j \neq i} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \tag{2.11}
\end{equation*}
$$

By (2.8), (2.9), (2.10) and (2.11), the last term in (2.6) has the following upper bound:

& 2 \sup _{1 \leq i \leq s+1}\left|\sum_{j \neq i, j>s+1} u_{i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}\right| \\
& \leq \frac{1}{2} c_{1} \sum_{i, j \leq s+1, j \neq i} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}+c_{2} \sum_{j>s+1, i \leq s+1} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}+\sum_{j>s+1} \frac{u_{s+1}^{2}}{\left|x_{s+1}-x_{j}\right|^{2}}, \tag{2.12}
\end{align*}
$$

where $c_{2}=\max \{1, a\}>0$.
By (2.6), (2.7) and (2.12), we have

\begin{aligned}
I_{1} & \geq \frac{c_{1}}{2} \sum_{i, j \leq s+1, j \neq i} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}} \\
& -\left(\left(p-s-1+c_{2}\right) \sum_{j>s+1, i \leq s+1} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}+\sum_{j>s+1} \frac{\left|u_{s+1}\right|^{2}}{\left|x_{s+1}-x_{j}\right|^{2}}\right)
\end{aligned}
$$

$$
\begin{equation*}
\geq \frac{c_{1}}{2} \sum_{i, j \leq s+1, j \neq i} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}-c_{3}\left(\sum_{j>s+1, i \leq s+1} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}+\sum_{j>s+1} \frac{u_{s+1}^{2}}{\left|x_{s+1}-x_{j}\right|^{2}}\right) \tag{2.13}
\end{equation*}
$$

where $c_{3}=\max \left\{p-s-1+c_{2}, 1\right\}=p-s-1+c_{2} \geq 2$.

Now, consider the minus term in (2.13). Rewrite and then use inequalities (2.1), (2.2) and (2.3):

& \sum_{j>s+1, i \leq s+1} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}+\sum_{j>s+1} \frac{u_{s+1}^{2}}{\left|x_{s+1}-x_{j}\right|^{2}} \\

& \left((p-1){\tilde{u_{p}}}^{2}+\sum_{2 \leq j \leq p-1} \frac{u_{j}^{2}}{\left|x_{1}-x_{j}\right|^{2}}+\frac{u_{1}^{2}}{\left|x_{1}-x_{2}\right|^{2}}\right) \\
\leq & \frac{c_{1}(p, m)}{2 p}\left((p-1) \tilde{u}_{p}^{2}+\sum_{i, j \leq p-1, i \neq j} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}\right) \\
\leq & \frac{c_{1}(p, m)}{2}\left(\tilde{u}_{p}^{2}+\sum_{i, j \leq p-1, i \neq j} \frac{u_{j}^{2}}{\left|x_{i}-x_{j}\right|^{2}}\right)
\end{aligned}
$$

By (2.23) and (2.25),

$\sum_{1 \leq j \leq p-1, j \neq i} \frac{1}{\left|y_{i 0}-y_{j 0}\right|} v_{j 0}+v_{p 0}=0, \quad v_{i 0} \sum_{1 \leq j \leq p-1, j \neq i} \frac{y_{i 0}-y_{j 0}}{\left|y_{i 0}-y_{j 0}\right|^{3}} v_{j 0}=0, \quad 1 \leq i \leq p-1$.
By Corollary [2.4, there exist $x_{10}, \ldots, x_{p 0} \in \mathbb{R}^{m}$, such that the equations (1.4) and (1.5) have non-zero solutions.

Now, we may prove Theorem 1.1.
Proof of Theorem 1.1. We argue by induction on $p_{0}$.
When $p \leq 3$, Conjecture 1.1 holds due to Xu [2, so we may apply Theorem 2.5 for $p_{0}=4$. Then we see that Conjecture 1.1 holds for $p=4$ if and only if (1.4) and (1.5) have no non-zero solution for $p=4$. This proves Theorem 1.1 for $p_{0}=4$.

Now assume the equivalence of Theorem 1.1 holds for $4 \leq p \leq p_{0}-1$. We want to show that Conjecture 1.1 holds for $4 \leq p \leq p_{0}$ is equivalent to that (1.4) and (1.5) have no non-zero solution for $4 \leq p \leq p_{0}$.

The necessity is obvious due to the positivity of $I_{2}$. It is left to consider the sufficiency. By the given condition for $4 \leq p \leq p_{0}-1$ and the induction hypothesis, Conjecture 1.1 holds for $4 \leq p \leq p_{0}-1$. Applying Theorem [2.5, by the given condition for $p=p_{0}$, we see that Conjecture 1.1 holds for $p=p_{0}$, hence for $p \leq p_{0}$.

Note that equations (1.4) and (1.5) can be written in matrix form, i.e.,

$$
\begin{equation*}
A U=0, \quad U^{\mathrm{T}} \frac{\partial A}{\partial x_{i}} U=0, \quad i=1, \ldots, p \tag{2.48}
\end{equation*}
$$

Let $1 \leq \alpha \leq p$ be a natural number, and denote by $U_{\alpha}$ the column vector obtained by crossing out the $\alpha$-th row of $U$, and $A_{\alpha}$ the $(p-1) \times(p-1)$ matrix obtained by crossing out the $\alpha$-th row and $\alpha$-th column of $A$.

To prove Conjecture 1.1 inductively by contradiction, one needs only to verify whether there is a non-zero solution $U=\left(u_{1}, \ldots, u_{p}\right)^{\mathrm{T}}$ of equation (2.48) with $u_{i} \neq 0$ for all $i=1, \cdots, p$. Since if $u_{\alpha}=0$ for some $1 \leq \alpha \leq p$, then (2.48) yields

$$
A_{\alpha} U_{\alpha}=0, \quad U_{\alpha}^{\mathrm{T}} \frac{\partial A_{\alpha}}{\partial x_{i}} U_{\alpha}=0, \quad 1 \leq i \neq \alpha \leq p
$$

which has the same form as (2.48). By the inductive assumption that the conjecture holds for $p \leq p_{0}-1$ and Theorem [2.5, we have $U_{\alpha}=0$, hence $U=0$. The claim follows from the contradiction.

In summary, we have the following corollary.
Corollary 2.6. If the conjecture holds for $p \leq p_{0}-1$ and does not hold for $p=p_{0}$, then any component of a non-zero solution to (2.48) is non-zero.

## 3. Further equivalent conditions and partial results

In this section, we shall continue to use Kelvin transform to simplify the conjecture even further and prove it for the basic case $m=1$ with arbitrary $p$, and $p=4,5$ with arbitrary $m$. Again, assuming that the conjecture holds for $p \leq p_{0}-1\left(p_{0} \geq 4\right)$, we shall consider the case when $p=p_{0}$.

Note that we can always embed the ambient Euclidean space $\mathbb{R}^{m}$, where the $p$ points $x_{1}, \ldots, x_{p}$ lie in, into the first $m$-components of a larger space $\mathbb{R}^{m+1}$. Then we apply the Kelvin transform about the point $N=(0, \ldots, 0,1) \in \mathbb{R}^{m+1} \backslash \mathbb{R}^{m}$. Note that, this map is, in fact, a stereographic projection. The image of $\mathbb{R}^{m} \hookrightarrow \mathbb{R}^{m+1}$ is an $m$-sphere centered at $\frac{1}{2} N=\left(0, \ldots, 0, \frac{1}{2}\right)$ with radius $\frac{1}{2}$ in $\mathbb{R}^{m+1}$.

Let $y=\mathcal{K}_{N}(x)$ denote the image of $x$. By Proposition [2.3, equations (1.4) and (1.5) become equations (2.41) and (2.42):
(2.41)
(2.42)

$$
\begin{array}{r}
\sum_{j \neq i} \frac{1}{\left|y_{i}-y_{j}\right|} v_{j}=0, \quad 1 \leq i \leq p, \\
v_{i} \sum_{j \neq i} \frac{y_{i}-y_{j}}{\left|y_{i}-y_{j}\right|^{3}} v_{j}=0, \quad 1 \leq i \leq p .
\end{array}
$$

Since these equations are invariant under translation and scaling of $y_{1}, \ldots, y_{n}$, we may assume that $y_{1}, \ldots, y_{p}$ lie on the unit $m$-sphere $\mathbb{S}^{m}$.

Now, we prove the following theorem.
Theorem 3.1. Let $p_{0} \geq 4$. If the conjecture holds for $p \leq p_{0}-1$, then when $p=p_{0}$, the conjecture is valid if and only if given any distinct $y_{1}, \ldots, y_{p} \in \mathbb{S}^{m}$, the equations
(1.6)

$$
\sum_{j \neq i} \frac{y_{i}-y_{j}}{\left|y_{i}-y_{j}\right|^{3}} v_{j}=0, \quad 1 \leq i \leq p
$$

for $v_{1}, \ldots, v_{p}$ have only zero solution.
Proof. Assume that the conjecture is false when $p=p_{0}$, then by Theorem 2.5, equations (1.4) and (1.5) have a non-zero solution, say $U=\left(u_{1}, \ldots, u_{p}\right)^{\mathrm{T}}$. By Corollary 2.6, each component of $U$ is non-zero. By Proposition [2.3, equations (2.41) and (2.42) have a non-zero solution $V=\left(v_{1}, \ldots, v_{p}\right)^{\mathrm{T}}$, and each component $v_{i}$ is also non-zero. Thus we
can derive equation (1.6) from (2.42) by dividing $v_{i}$ on both sides of the $i$-th equation for $1 \leq i \leq p$. Therefore, equation (1.6) have a non-zero solution.

Conversely, assume that equation (1.6) have a non-zero solution, say $V=\left(v_{1}, \ldots, v_{p}\right)^{\mathrm{T}}$, we are going to show that the conjecture is false when $p=p_{0}$ by showing the existence of non-zero solutions for equations (2.41) and (2.42). In fact, $V$ clearly satisfies equation (2.42). For (2.41), note that

$$
\left|y_{i}-y_{j}\right|^{2}=\left\langle y_{i}-y_{j}, y_{i}-y_{j}\right\rangle=2-2\left\langle y_{i}, y_{j}\right\rangle .
$$

Taking inner product of (1.6) with $2 y_{i}$, we get

$$
0=\sum_{j \neq i} \frac{2-2\left\langle y_{i}, y_{j}\right\rangle}{\left|y_{i}-y_{j}\right|^{3}} v_{j}=\sum_{j \neq i} \frac{\left|y_{i}-y_{j}\right|^{2}}{\left|y_{i}-y_{j}\right|^{3}} v_{j}=\sum_{j \neq i} \frac{1}{\left|y_{i}-y_{j}\right|} v_{j}, \quad 1 \leq i \leq p
$$

Thus, $V$ satisfies (2.41) as well. In conclusion, $V$ is also non-zero a solution for equations (2.41) and (2.42).

Proof of Theorem 1.2. The proof is similar to that of Theorem 1.1 and thus left to the reader.
3.1. Case 1. $m=1$. In this subsection, we prove Conjecture 1.1 when $m=1$ using Theorem 3.1.

Theorem 3.2. Conjecture 1.1 is valid for $m=1$ and arbitrary $p$.

Proof. It suffices to prove the case $p=p_{0} \geq 4$, under the assumption that the cases $p \leq p_{0}-1$ hold.

Without lost of generality, we may assume $y_{k}=\mathrm{e}^{\mathrm{i} \alpha_{k}} \in \mathbb{S}^{1} \hookrightarrow \mathbb{C}$ for $1 \leq k \leq p$ with

$$
0 \leq \alpha_{1}<\alpha_{2}<\cdots<\alpha_{p}<2 \pi .
$$

We shall prove, the equations

$$
\begin{equation*}
\sum_{j \neq k} \frac{y_{k}-y_{j}}{\left|y_{k}-y_{j}\right|^{3}} v_{j}=0, \quad 1 \leq k \leq p \tag{3.1}
\end{equation*}
$$

for $v_{1}, \ldots, v_{p}$ have only zero solution. We prove this by contradiction.
Assume that $V=\left(v_{1}, \ldots, v_{p}\right)^{\mathrm{T}}$ is a non-zero solution for equation (3.1), then each component of $V$ is non-zero by a similar argument as in Corollary 2.6. Notice the
following identities:

$$
\begin{aligned}
y_{k}-y_{j}=\mathrm{e}^{\mathrm{i} \alpha_{k}}-\mathrm{e}^{\mathrm{i} \alpha_{j}} & =\left(\cos \alpha_{k}-\cos \alpha_{j}\right)+\mathrm{i}\left(\sin \alpha_{k}-\sin \alpha_{j}\right) \\
& =-2 \sin \frac{\alpha_{k}+\alpha_{j}}{2} \sin \frac{\alpha_{k}-\alpha_{j}}{2}+2 \mathrm{i} \cos \frac{\alpha_{k}+\alpha_{j}}{2} \sin \frac{\alpha_{k}-\alpha_{j}}{2} \\
& =2 \sin \frac{\alpha_{k}-\alpha_{j}}{2}\left(-\sin \frac{\alpha_{k}+\alpha_{j}}{2}+\mathrm{i} \cos \frac{\alpha_{k}+\alpha_{j}}{2}\right) \\
& =2 \sin \frac{\alpha_{k}-\alpha_{j}}{2} \mathrm{e}^{\mathrm{i} \frac{\alpha_{k}+\alpha_{j}+\pi}{2}}, \\
\left|y_{k}-y_{j}\right|=\left|\mathrm{e}^{\mathrm{i} \alpha_{k}}-\mathrm{e}^{\mathrm{i} \alpha_{j}}\right| & =2 \operatorname{sgn}(k-j) \sin \frac{\alpha_{k}-\alpha_{j}}{2}>0 .
\end{aligned}
$$

Substituting the identities above in (3.1), we obtain:

$$
\sum_{j \neq k} \operatorname{sgn}(k-j) \frac{\mathrm{e}^{\mathrm{i} \frac{\alpha_{j}}{2}}}{\left(\sin \frac{\alpha_{k}-\alpha_{j}}{2}\right)^{2}} v_{j}=0, \quad 1 \leq k \leq p
$$

For each $1 \leq s \leq p$, multiplying $\mathrm{e}^{\mathrm{i} \frac{-\alpha_{s}}{2}}$ on both sides of all equations but the $s$-th one, we have

$$
\operatorname{sgn}(k-s) \frac{1}{\left(\sin \frac{\alpha_{k}-\alpha_{s}}{2}\right)^{2}} v_{s}+\sum_{j \neq k, s} \operatorname{sgn}(k-j) \frac{\mathrm{e}^{\mathrm{i} \frac{\alpha_{j}-\alpha_{s}}{2}}}{\left(\sin \frac{\alpha_{k}-\alpha_{j}}{2}\right)^{2}} v_{j}=0, \quad 1 \leq k \neq s \leq p
$$

Taking the imaginary part, we get:

$$
\begin{equation*}
\sum_{j \neq k, s} \operatorname{sgn}(k-j) \frac{\sin \frac{\alpha_{j}-\alpha_{s}}{2}}{\left(\sin \frac{\alpha_{k}-\alpha_{j}}{2}\right)^{2}} v_{j}=0, \quad 1 \leq k \neq s \leq p \tag{3.2}
\end{equation*}
$$

Note that (3.1) is also equivalent to

$$
\sum_{j \neq k} \operatorname{sgn}(k-j) \frac{\mathrm{e}^{\mathrm{i} \alpha_{k}}-\mathrm{e}^{\mathrm{i} \alpha_{j}}}{\left(\sin \frac{\alpha_{k}-\alpha_{j}}{2}\right)^{3}} v_{j}=0, \quad 1 \leq k \leq p
$$

Multiplying $v_{k} \sin \frac{\alpha_{k}-\alpha_{s}}{2} \mathrm{e}^{-\mathrm{i} \frac{\alpha_{k}}{2}}$ on the equation above, and setting

$$
w_{k}=\mathrm{e}^{-\mathrm{i} \frac{\alpha_{k}}{2}} v_{k}, \quad 1 \leq k \leq p
$$

we get:
$\operatorname{sgn}(k-s) \frac{\mathrm{e}^{\mathrm{i} \alpha_{k}}-\mathrm{e}^{\mathrm{i} \alpha_{s}}}{\left(\sin \frac{\alpha_{k}-\alpha_{s}}{2}\right)^{2}} v_{s} w_{k}+\sum_{j \neq k, s} \operatorname{sgn}(k-j) \frac{\sin \frac{\alpha_{k}-\alpha_{s}}{2}}{\left(\sin \frac{\alpha_{k}-\alpha_{j}}{2}\right)^{2}} 2 \mathrm{ie}^{\mathrm{i} \frac{\alpha_{j}}{2}} v_{j} v_{k}=0, \quad 1 \leq k \neq s \leq p$.

Taking sum over $k$, we get

$$
\begin{aligned}
0 & =\sum_{k \neq s} \operatorname{sgn}(k-s) \frac{\mathrm{e}^{\mathrm{i} \alpha_{k}}-\mathrm{e}^{\mathrm{i} \alpha_{s}}}{\left(\sin \frac{\alpha_{k}-\alpha_{s}}{2}\right)^{2}} v_{s} w_{k}+\sum_{k \neq s} \sum_{j \neq k, s} \operatorname{sgn}(k-j) \frac{\sin \frac{\alpha_{k}-\alpha_{s}}{2}}{\left(\sin \frac{\alpha_{k}-\alpha_{j}}{2}\right)^{2}} 2 \mathrm{ie}^{\mathrm{i} \frac{\alpha_{j}}{2}} v_{j} v_{k} \\
& \xlongequal{\text { Exchange the order }} v_{s} \sum_{k \neq s} \operatorname{sgn}(k-s) \frac{\mathrm{e}^{\mathrm{i} \alpha_{k}}-\mathrm{e}^{\mathrm{i} \alpha_{s}}}{\left(\sin \frac{\alpha_{k}-\alpha_{s}}{2}\right)^{2}} w_{k}+\sum_{j \neq s} \sum_{k \neq j, s} \operatorname{sgn}(k-j) \frac{\sin \frac{\alpha_{k}-\alpha_{s}}{2}}{\left(\sin \frac{\alpha_{k}-\alpha_{j}}{2}\right)^{2}} 2 \mathrm{ie}^{\mathrm{i} \frac{\alpha_{j}}{2}} v_{j} v_{k} \\
& =v_{s} \sum_{k \neq s} \operatorname{sgn}(k-s) \frac{\mathrm{e}^{\mathrm{i} \alpha_{k}}-\mathrm{e}^{\mathrm{i} \alpha_{s}}}{\left(\sin \frac{\alpha_{k}-\alpha_{s}}{2}\right)^{2}} w_{k}+\sum_{j \neq s} 2 \mathrm{ie}^{\mathrm{i} \frac{\alpha_{j}}{2}} v_{j} \sum_{k \neq j, s} \operatorname{sgn}(k-j) \frac{\sin \frac{\alpha_{k}-\alpha_{s}}{2}}{\left(\sin \frac{\alpha_{k}-\alpha_{j}}{2}\right)^{2}} v_{k} \\
& \xlongequal{\underline{(3.2)}} v_{s} \sum_{k \neq s} \operatorname{sgn}(k-s) \frac{\mathrm{e}^{\mathrm{i} \alpha_{k}-\mathrm{e}^{\mathrm{i} \alpha_{s}}}}{\left(\sin \frac{\alpha_{k}-\alpha_{s}}{2}\right)^{2}} w_{k}
\end{aligned}
$$

That is,

$$
v_{s} \sum_{k \neq s} \operatorname{sgn}(k-s) \frac{\mathrm{e}^{\mathrm{i} \alpha_{k}}-\mathrm{e}^{\mathrm{i} \alpha_{s}}}{\left(\sin \frac{\alpha_{k}-\alpha_{s}}{2}\right)^{2}} w_{k}=0, \quad 1 \leq s \leq p
$$

or equivalently,

$$
\sum_{k \neq s} \operatorname{sgn}(k-s) \frac{y_{k}-y_{s}}{\left|y_{k}-y_{s}\right|^{2}} w_{k}=0, \quad 1 \leq s \leq p
$$

Taking inner product with $2 y_{s}$ gives

$$
\begin{equation*}
\sum_{k \neq s} \operatorname{sgn}(k-s) w_{k}=0, \quad 1 \leq s \leq p \tag{3.3}
\end{equation*}
$$

In other words, setting

$$
C=(\operatorname{sgn}(k-s))_{k, s}=\left(\begin{array}{ccccc}
0 & 1 & 1 & \ldots & 1 \\
-1 & 0 & 1 & \ldots & 1 \\
-1 & -1 & 0 & \ldots & 1 \\
\vdots & \vdots & \vdots & \ddots & \vdots \\
-1 & -1 & -1 & \ldots & 0
\end{array}\right), \quad W=\left(w_{1}, w_{2}, \ldots, w_{p}\right)^{\mathrm{T}} \in \mathbb{C}^{p}
$$

we have $C W=0$ by (3.3).
When $p$ is even, one easily sees that $\operatorname{det} C=1$ by expanding the determinant, thus $W=0$, and hence $V=0$, a contradiction.

When $p$ is odd, $\operatorname{det} C=0$. Evidently, we can find a non-zero $(p-1) \times(p-1)$ minor, and thus rank $C=p-1$. We have

$$
C W=C\left(\begin{array}{c}
\mathrm{e}^{\mathrm{i} \frac{\alpha_{1}}{2} v_{1}} \\
\mathrm{e}^{\mathrm{i} \frac{\alpha_{2}}{2} v_{2}} \\
\vdots \\
\mathrm{e}^{\mathrm{i} \frac{\alpha_{p}}{2} v_{p}}
\end{array}\right)=0,
$$

in this case. Consider the real and imaginary parts of $W$ :

$$
C\left(\begin{array}{c}
\cos \frac{\alpha_{1}}{2} v_{1} \\
\cos \frac{\alpha_{2}}{2} v_{2} \\
\vdots \\
\cos \frac{\alpha_{p}}{2} v_{p}
\end{array}\right)=0, \quad C\left(\begin{array}{c}
\sin \frac{\alpha_{1}}{2} v_{1} \\
\sin \frac{\alpha}{2} v_{2} \\
\vdots \\
\sin \frac{\alpha_{p}}{2} v_{p}
\end{array}\right)=0 .
$$

Since $V \neq 0$,

$$
\left(\begin{array}{c}
\cos \frac{\alpha_{1}}{2} v_{1} \\
\cos \frac{\alpha_{2}}{2} v_{2} \\
\vdots \\
\cos \frac{\alpha_{p}}{2} v_{p}
\end{array}\right), \quad \text { and } \quad\left(\begin{array}{c}
\sin \frac{\alpha_{1}}{2} v_{1} \\
\sin \frac{\frac{\alpha}{2}}{2} v_{2} \\
\vdots \\
\sin \frac{\alpha_{p}}{2} v_{p}
\end{array}\right)
$$

are two solutions for $C Z=0$, where $Z=\left(z_{1}, \ldots, z_{p}\right)$ is a real variable. But since

$$
\left|\begin{array}{cc}
\cos \frac{\alpha_{1}}{2} v_{1} & \cos \frac{\alpha_{2}}{2} v_{2} \\
\sin \frac{\alpha_{1}}{2} v_{1} & \sin \frac{\alpha_{2}}{2} v_{2}
\end{array}\right|=\sin \frac{\alpha_{2}-\alpha_{1}}{2} v_{1} v_{2} \neq 0,
$$

the two solutions are linearly independent, which is contradictory to the previous conclusion that $\operatorname{rank} C=p-1$.

In either case, we yield a contradiction, which shows that the assumption that $V=$ $\left(v_{1}, \ldots, v_{p}\right)^{\mathrm{T}}$ is a non-zero solution for equation (3.1) is false, proving the conjecture.
3.2. Case 2. $p=4,5$. In this subsection, we deal with the cases $p=4,5$. We manage to reduce them down to $m=1$.

Theorem 3.3. Conjecture 1.1 is valid for $p=4,5$ and arbitrary $m$.
Proof. Assume that $U=\left(u_{1}, \ldots, u_{p}\right)^{\mathrm{T}}$ is a non-zero solution for equations (1.4) and (1.5) for some $x_{1}, \ldots, x_{p} \in \mathbb{R}^{m}$. It suffices to transform $x_{1}, \ldots, x_{p}$ to lie on the same line, yielding a contradiction by Theorems 1.1 and 3.2 .
3.2.1. $p=4$. We may assume that $m=3$ by Remark 2 and that each component of $U$ is non-zero by Corollary [2.6. Thus, we have

$$
\begin{align*}
& \sum_{j \neq i} \frac{u_{j}}{\left|x_{i}-x_{j}\right|}=0, \quad 1 \leq i \leq p  \tag{3.4}\\
& \sum_{j \neq i} \frac{x_{i}-x_{j}}{\left|x_{i}-x_{j}\right|^{3}} u_{j}=0, \quad 1 \leq i \leq p . \tag{3.5}
\end{align*}
$$

Choose the $x$-axis of $\mathbb{R}^{3}$ as the line passing $x_{1}$ and $x_{2}$. If $x_{3}$ and $x_{4}$ are on $x$-axis, then we have completed the proof by contradiction.

If $x_{3}, x_{4}$ are not on the $x$-axis, then from (3.5), we claim that $x_{1}, \ldots, x_{4}$ must be on the same 2-dimensional plane. Otherwise, if $x_{4}$ is outside the plane defined by $x_{1}, x_{2}, x_{3}$, then $u_{4}$ must be zero by equation (3.5) when $i=1$, a contradiction.

Since equations (3.4) and (3.5) are invariant under the Kelvin transform by Proposition 2.3, we can make $x_{1}, x_{2}, x_{3}$ co-line by transforming the circle through them into a line. If $x_{4}$ is not on the line of $x_{1}, x_{2}, x_{3}$, then $u_{4}=0$ in the above equation for $i=4$, a contradiction again. Finally we still come to the co-line case and thus complete the proof for $p=4$.
3.2.2. $p=5$. We may assume that $m \leq 4$. Since the case $p=4$ has been verified, we may assume that $U \in \mathbb{R}^{p}\left(u_{i} \neq 0\right)$ is a solution to equations (3.4) and (3.5) again.

Denote $E_{0}:=\operatorname{Span}\left\{x_{1}-x_{i} \mid i=2,3,4,5\right\}$.
If $\operatorname{dim} E_{0}=4$, i.e., $x_{1}-x_{5} \notin E_{1}:=\operatorname{Span}\left\{x_{1}-x_{i} \mid i=2,3,4\right\}$, then $\operatorname{dist}\left(x_{1}-x_{5}, E_{1}\right):=$ $\inf _{y \in E_{1}}\left|y-\left(x_{1}-x_{5}\right)\right|$ can be achieved at some point $y_{0} \in E_{1}$. So $y_{0}-\left(x_{1}-x_{5}\right) \perp E_{1}$. Let $i=1$ in (3.5), and make inner product between it and $y_{0}-\left(x_{1}-x_{5}\right)$, we have $u_{5}=0$, a contradiction. So $x_{1}-x_{5} \in E_{1}$, and thus $E_{0}=E_{1}, \operatorname{dim} E_{0} \leq 3$.

Now if $\operatorname{dim} E_{0}=3$, then we can assume the 5 points are in the same 3 -dimensional subspace and we can pick up 3 points such that the other 2 locate at the same side of the plane determined by the 3 points. Suppose $x_{1}-x_{4}$ and $x_{1}-x_{5}$ are on the same side of the plane $E_{2}:=\operatorname{Span}\left\{x_{1}-x_{2}, x_{1}-x_{3}\right\}$. We can write

$$
x_{1}-x_{5}=c\left(x_{1}-x_{4}\right)+a\left(x_{1}-x_{2}\right)+b\left(x_{1}-x_{3}\right)
$$

for constants $a, b$ and $c>0$. And we can find $y_{1} \in E_{2}$ such that $\alpha:=y_{1}-\left(x_{1}-x_{4}\right) \perp E_{2}$. Let $i=1,2,3$ in (3.5), and make inner products between each of them and $\alpha$, then

$$
\begin{aligned}
& \frac{\left\langle\alpha, x_{1}-x_{4}\right\rangle}{\left|x_{1}-x_{4}\right|^{3}} u_{4}+\frac{\left\langle\alpha, x_{1}-x_{5}\right\rangle}{\left|x_{1}-x_{5}\right|^{3}} u_{5}=0, \\
& \frac{\left\langle\alpha, x_{1}-x_{4}\right\rangle}{\left|x_{2}-x_{4}\right|^{3}} u_{4}+\frac{\left\langle\alpha, x_{1}-x_{5}\right\rangle}{\left|x_{2}-x_{5}\right|^{3}} u_{5}=0, \\
& \frac{\left\langle\alpha, x_{1}-x_{4}\right\rangle}{\left|x_{3}-x_{4}\right|^{3}} u_{4}+\frac{\left\langle\alpha, x_{1}-x_{5}\right\rangle}{\left|x_{3}-x_{5}\right|^{3}} u_{5}=0 .
\end{aligned}
$$

Note that $\left\langle\alpha, x_{1}-x_{5}\right\rangle=c\left\langle\alpha, x_{1}-x_{4}\right\rangle<0$, thus we have

$$
\frac{\left|x_{1}-x_{5}\right|}{\left|x_{1}-x_{4}\right|}=\frac{\left|x_{2}-x_{5}\right|}{\left|x_{2}-x_{4}\right|}=\frac{\left|x_{3}-x_{5}\right|}{\left|x_{3}-x_{4}\right|}:=K, \quad u_{5}=-\frac{1}{c} K^{3} u_{4} .
$$

Let $i=4,5$ in (3.4), then

$$
\begin{array}{r}
\frac{u_{1}}{\left|x_{4}-x_{1}\right|}+\frac{u_{2}}{\left|x_{4}-x_{2}\right|}+\frac{u_{3}}{\left|x_{4}-x_{3}\right|}-\frac{K^{3} u_{4}}{c\left|x_{4}-x_{5}\right|}=0, \\
\frac{u_{1}}{K\left|x_{4}-x_{1}\right|}+\frac{u_{2}}{K\left|x_{4}-x_{2}\right|}+\frac{u_{3}}{K\left|x_{4}-x_{3}\right|}+\frac{u_{4}}{\left|x_{4}-x_{5}\right|}=0 .
\end{array}
$$

Then we have $c=-K^{2}<0$, a contradiction. This shows that $x_{1}-x_{4} \in E_{2}$, i.e., $E_{0}=E_{1}=E_{2}$. So $\operatorname{dim} E_{0} \leq 2$.

Now, we have all the five points on a 2 -dimensional plane. Pick up 3 of them such that the circle they form enclose the other 2 points. Under a proper Kelvin transform, we may assume that the 3 lie on a line, and the other 2 lie in the same side of the line. By similar contradiction argument as above, we conclude that all the 5 points lie on the same line and thus $U=0$ by Theorem 3.2, hence a contradiction to Theorem 1.1, This completes the proof for $p=5$.
