# ON THE FUNCTIONAL EQUATION FOR CLASSICAL ORTHOGONAL POLYNOMIALS ON LATTICES 

K. CASTILLO, D. MBOUNA, AND J. PETRONILHO


#### Abstract

Necessary and sufficient conditions for the regularity of solutions of the functional equation appearing in the theory of classical orthogonal polynomials on lattices are stated. Moreover, the functional Rodrigues formula and a closed formula for the recurrence coefficients are presented.


## 1. Introduction

Let $\mathcal{P}$ be the vector space of all polynomials with complex coefficients and let $\mathcal{P}^{*}$ be its algebraic dual. $\mathcal{P}_{n}$ denotes the space of all polynomials with degree less than or equal to $n$. Define $\mathcal{P}_{-1}:=\{0\}$. A simple set in $\mathcal{P}$ is a sequence $\left(P_{n}\right)_{n \geq 0}$ such that $P_{n} \in \mathcal{P}_{n} \backslash \mathcal{P}_{n-1}$ for each $n$. A simple set $\left(P_{n}\right)_{n \geq 0}$ is called an orthogonal polynomial sequence (OPS) with respect to $\mathbf{u} \in \mathcal{P}^{*}$ if

$$
\left\langle\mathbf{u}, P_{n} P_{k}\right\rangle=h_{n} \delta_{n, k} \quad\left(n, k=0,1, \ldots ; h_{n} \in \mathbb{C} \backslash\{0\}\right),
$$

where $\langle\mathbf{u}, f\rangle$ is the action of $\mathbf{u}$ on $f \in \mathcal{P} . \mathbf{u}$ is called regular, or quasi-definite, if there exists an OPS with respect to it. It is well known that $\mathbf{u}$ is regular if and only if $\operatorname{det}\left[u_{i+j}\right]_{i, j=0}^{n} \neq 0$ for each $n=0,1, \ldots$, where $u_{n}:=\left\langle\mathbf{u}, z^{n}\right\rangle$. In 1940 Ya. L. Geronimus proved the following result [7, Theorem II]:

A sequence of polynomials and the sequence of its derivatives are orthogonal with respect to sequences of moment $\mathbb{I}^{1}\left(u_{n}\right)_{n \geq 0}$ and $\left(v_{n}\right)_{n \geq 0}$, respectively, if and only if

(n a+d) u_{n+1}+(n b+e) u_{n}+n c u_{n-1}=0 \tag{1.1}
\end{equation*}

for each $n$, where $a, b, c, d, e$ are complex numbers such that $n a+d \neq 0$ and $\operatorname{det}\left[u_{i+j}\right]_{i, j=0}^{n} \neq 0$, and

$$
\begin{equation*}
v_{n}=a u_{n+2}+b u_{n+1}+c u_{n} \tag{1.2}
\end{equation*}
$$

${ }^{1}$ Recall that given a sequence of complex numbers $\left(u_{n}\right)_{n \geq 0},\left(P_{n}\right)_{n \geq 0}$ is said to be orthogonal with respect to $\left(u_{n}\right)_{n \geq 0}$ if it is an OPS with respect to the functional $\mathbf{u} \in \mathcal{P}^{*}$ defined by

Given $\mathbf{u} \in \mathcal{P}^{*}$ and $g \in \mathcal{P}$, the derivative of $\mathbf{u}$ and the left multiplication of $\mathbf{u}$ by $g$ are the functionals $\mathbf{D u} \in \mathcal{P}^{*}$ and $g \mathbf{u} \in \mathcal{P}^{*}$ defined by

$$
\langle\mathbf{D} \mathbf{u}, f\rangle:=-\left\langle\mathbf{u}, f^{\prime}\right\rangle, \quad\langle g \mathbf{u}, f\rangle:=\langle\mathbf{u}, f g\rangle \quad(f \in \mathcal{P}) .
$$

This allows us to rewrite the difference equation (1.1) as a functional equation ${ }^{2}$

$$
\begin{equation*}
\mathbf{D}(\phi \mathbf{u})=\psi \mathbf{u} \tag{1.3}
\end{equation*}
$$

where $\phi(z)=a z^{2}+b z+c$ and $\psi(z)=d z+e$, and (1.2) as $\mathbf{v}=\phi \mathbf{u}$, being $\mathbf{u}$ and $\mathbf{v}$ the linear functionals on $\mathcal{P}$ given by $\left\langle\mathbf{u}, z^{n}\right\rangle=u_{n}$ and $\left\langle\mathbf{v}, z^{n}\right\rangle=v_{n}$. It is worth mentioning that Geronimus' result was motivated by Hahn's characterization of the classical OPS ${ }^{3}$ of Hermite, Laguerre, Jacobi, and Bessel - the only OPS such that their sequences of derivatives are also OPS [8]. We call a functional $\mathbf{u} \in \mathcal{P}^{*}$ classical in Hahn's sense, or, simply, D-classical, if the corresponding OPS is such that the associated sequence of derivatives is also an OPS. Accordingly, Geronimus' theorem can be rewritten as follow $\sqrt[4]{4}$ :
Theorem A. $\mathbf{u} \in \mathcal{P}^{*}$ is D -classical if and only if there exist $\phi \in \mathcal{P}_{2}$ and $\psi \in \mathcal{P}_{1}$ such that $\mathbf{u}$ satisfies (1.3) and the conditions

\begin{equation*}
n a+d \neq 0, \quad H_{n}:=\operatorname{det}\left[u_{i+j}\right]_{i, j=0}^{n} \neq 0 \quad(n=0,1,2, \ldots) \tag{1.4}
\end{equation*}
$$

hold, where $a:=\phi^{\prime \prime} / 2, d:=\psi^{\prime}$, and $u_{n}:=\left\langle\mathbf{u}, z^{n}\right\rangle$.
The condition $n a+d \neq 0$ for every $n$ means that $(\phi, \psi)$ is an admissible pair [16]. Note that, concerning the applicability of Theorem A, although it is trivial to check the admissibility condition for a given pair $(\phi, \psi) \in \mathcal{P}_{2} \times \mathcal{P}_{1}$, the same does not holds (in general) for the regularity condition $H_{n} \neq 0$, because the order of $H_{n}$ grows with $n$. Theorem B in bellow improves Theorem A, showing that conditions (1.4) may be replaced by rather simple ones - see (1.6) in bellow-, as well as how to compute the monic OPS $\left(P_{n}\right)_{n \geq 0}$ with respect to $\mathbf{u} u s i n g$ only the pair $(\phi, \psi)$. This is achieved from the explicit formulas for the coefficients $B_{n}$ and $C_{n}$ appearing in the three-term recurrence relation (TTRR) for $\left(P_{n}\right)_{n \geq 0}$, namely
(1.5) $z P_{n}(z)=P_{n+1}(z)+B_{n} P_{n}(z)+C_{n} P_{n-1}(z) \quad(n=0,1, \ldots), \quad P_{-1}(z)=0$.

Theorem B. $\mathbf{u} \in \mathcal{P}^{*} \backslash\{\mathbf{0}\}$ is D -classical if and only if there exist polynomials $\phi(z):=a z^{2}+b z+c$ and $\psi(z):=d z+e$ such that (1.3) holds and

$$
\begin{equation*}
n a+d \neq 0, \quad \phi\left(-\frac{n b+e}{2 n a+d}\right) \neq 0 \quad(n=0,1, \ldots) \tag{1.6}
\end{equation*}
$$

Under such conditions, the monic OPS $\left(P_{n}\right)_{n \geq 0}$ with respect to $\mathbf{u}$ fulfils (1.5) with

$$
\begin{equation*}
B_{n}=\frac{n e_{n-1}}{d_{2 n-2}}-\frac{(n+1) e_{n}}{d_{2 n}}, C_{n+1}=-\frac{(n+1) d_{n-1}}{d_{2 n-1} d_{2 n+1}} \phi\left(-\frac{e_{n}}{d_{2 n}}\right)(n=0,1, \ldots) \tag{1.7}
\end{equation*}
$$

[^0]where $d_{n}:=n a+d$ and $e_{n}:=n b+e$. Moreover, the following functional Rodrigues formula holds:
$$
P_{n} \mathbf{u}=k_{n} \mathbf{D}^{n}\left(\phi^{n} \mathbf{u}\right), \quad k_{n}:=\prod_{j=0}^{n-1} d_{n+j-1}^{-1} \quad(n=0,1, \ldots)
$$

Theorem B was stated in [13] 5 Observe that conditions (1.6) mean that $(\phi, \psi)$ is an admissible pair and $\psi+n \phi^{\prime} \nmid \phi$ for each $n=0,1, \ldots$. It is well known that if there exist $\mathbf{u} \in \mathcal{P}^{*}$ and nonzero polynomials $\phi \in \mathcal{P}_{2}$ and $\psi \in \mathcal{P}_{1}$ such that (1.3) holds, then the regularity of $\mathbf{u}$ implies that $(\phi, \psi)$ is an admissible pair (see e.g. [16, 13). Therefore, the above definition of D -classical functional is equivalent to the following statement: $\mathbf{u} \in \mathcal{P}^{*} \backslash\{\mathbf{0}\}$ is D -classical if and only if it is regular and there exist nonzero polynomials $\phi \in \mathcal{P}_{2}$ and $\psi \in \mathcal{P}_{1}$ such that $\mathbf{u}$ satisfies (1.3). This statement is indeed the definition of D -classical functional adopted nowadays within the algebraic theory of orthogonal polynomials, developed by Maroni [14, [15, 16] (see also [20]).

Recently, an analogue of Theorem B in the framework of OPS with respect to the discrete Hahn operator has been proved in [2]. In order to give here the statement of this analogue, we need to recall several definitions. Given complex numbers $q$ and $\omega$ subject to the conditions

the (ordinary) Hahn operator $D_{q, \omega}: \mathcal{P} \rightarrow \mathcal{P}$, studied by W. Hahn in [9], is

$$
D_{q, \omega} f(x):=\frac{f(q x+\omega)-f(x)}{(q-1) x+\omega} \quad(f \in \mathcal{P})
$$

$D_{q, \omega}$ induces an operator on the dual space, $\mathbf{D}_{q, \omega}: \mathcal{P}^{*} \rightarrow \mathcal{P}^{*}$, given by (see [5])

$$
\left\langle\mathbf{D}_{q, \omega} \mathbf{u}, f\right\rangle:=-q^{-1}\left\langle\mathbf{u}, D_{q, \omega}^{*} f\right\rangle \quad\left(\mathbf{u} \in \mathcal{P}^{*}, f \in \mathcal{P}\right)
$$

where $D_{q, \omega}^{*}:=D_{1 / q,-\omega / q}$. These definitions are on the basis of the following notion of classical OPS: $\mathbf{u} \in \mathcal{P}^{*}$ is $(q, \omega)$-classical if it is regular and there exist nonzero polynomials $\phi \in \mathcal{P}_{2}$ and $\psi \in \mathcal{P}_{1}$, such that

$$
\begin{equation*}
\mathbf{D}_{q, \omega}(\phi \mathbf{u})=\psi \mathbf{u} \tag{1.9}
\end{equation*}
$$

Define also operators $L_{q, \omega}: \mathcal{P} \rightarrow \mathcal{P}$ and $\mathbf{L}_{q, \omega}: \mathcal{P}^{*} \rightarrow \mathcal{P}^{*}$ by (see [5])

$$
L_{q, \omega} f(x):=f(q x+\omega), \quad\left\langle\mathbf{L}_{q, \omega} \mathbf{u}, f\right\rangle:=q^{-1}\left\langle\mathbf{u}, L_{q, \omega}^{*} f\right\rangle \quad\left(f \in \mathcal{P}, \mathbf{u} \in \mathcal{P}^{*}\right),
$$

where $L_{q, \omega}^{*}:=L_{1 / q,-\omega / q}$. Finally, recall the definition of the $q$-bracket:

$$
[\alpha]_{q}:=\left\{\begin{array}{ccc}
\frac{q^{\alpha}-1}{q-1}, & \text { if } \quad q \neq 1 \\
\alpha, & \text { if } \quad q=1
\end{array} \quad(\alpha, q \in \mathbb{C})\right.
$$

The $(q, \omega)$-analogue of Theorem B, stated in [2, Theorem 1.2], reads as follows:

[^1]Theorem C. Fix $q, \omega \in \mathbb{C}$ fulfilling (1.8). u $\in \mathcal{P}^{*} \backslash\{\mathbf{0}\}$ is $(q, \omega)$-classical if and only if there exist polynomials $\phi(z):=a z^{2}+b z+c$ and $\psi(z):=d z+e$ such that $\mathbf{u}$ satisfies the functional equation (1.9) and the conditions

$$
d_{n} \neq 0, \quad \phi\left(-\frac{e_{n}}{d_{2 n}}\right) \neq 0 \quad(n=0,1,2, \ldots)
$$

hold, where $d_{n} \equiv d_{n}(q):=d q^{n}+a[n]_{q}$ and $e_{n} \equiv e_{n}(q, \omega):=e q^{n}+\left(\omega d_{n}+b\right)[n]_{q}$. Under these conditions, the monic OPS $\left(P_{n}\right)_{n \geq 0} \equiv\left(P_{n}(\cdot ; q, \omega)\right)_{n \geq 0}$ with respect to $\mathbf{u}$ satisfies the TTRR (1.5), where

$$
B_{n}=\omega[n]_{q}+\frac{[n]_{q} e_{n-1}}{d_{2 n-2}}-\frac{[n+1]_{q} e_{n}}{d_{2 n}}, \quad C_{n+1}:=-\frac{q^{n}[n+1]_{q} d_{n-1}}{d_{2 n-1} d_{2 n+1}} \phi\left(-\frac{e_{n}}{d_{2 n}}\right)
$$

$(n=0,1, \ldots)$. In addition, the Rodrigues formula

$$
P_{n} \mathbf{u}=k_{n} \mathbf{D}_{1 / q,-\omega / q}^{n}\left(\Phi(\cdot ; n) \mathbf{L}_{q, \omega}^{n} \mathbf{u}\right) \quad(n=0,1, \ldots)
$$

holds in $\mathcal{P}^{*}$, where

$$
k_{n}:=q^{n(n-3) / 2} \prod_{j=0}^{n-1} d_{n+j-1}^{-1}, \quad \Phi(x ; n):=\prod_{j=1}^{n} \phi\left(q^{j} x+\omega[j]_{q}\right)
$$

At this stage, a natural question arises, asking for analogues of theorems B and C for OPS on lattices in the sense of Nikiforov, Suslov, and Uvarov [18] (see also [3, 10, 11, 1]). The aim of this work is answering to this question. The structure of the paper is the following. In Section 2 we review some basic definitions and results focusing on the theory of OPS on lattices. Section 3 contains a functional Rodrigues formula for classical OPS on lattices. In Section 4 we state our main results, giving the analogues of theorems B and C for OPS on lattices (for linear, $q$-linear, quadratic, and $q$-quadratic lattices). Finally, as a straightforward application of the main results, in Section 5 we revisit the Racah polynomials and the Askey-Wilson polynomials, computing their recurrence coefficients directly from the functional equation fulfilled by the associated regular functional.

## 2. Preliminary Results on lattices

In this section we review the definition of lattice. In addition, we derive a Leibniz formula (on lattices) for the left multiplication of a functional by a polynomial, as well as some preliminary results needed.
2.1. Definitions and basic properties. A lattice is a mapping $x(s)$ given by

x(s):=\left\{\begin{array}{ccc}
\mathfrak{c}_{1} q^{-s}+\mathfrak{c}_{2} q^{s}+\mathfrak{c}_{3} & \text { if } & q \neq 1  \tag{2.1}\\
\mathfrak{c}_{4} s^{2}+\mathfrak{c}_{5} s+\mathfrak{c}_{6} & \text { if } & q=1
\end{array}\right.
$$

$(s \in \mathbb{C})$, where $q>0$ (fixed) and $\mathfrak{c}_{j}(1 \leq j \leq 6)$ are (complex) constants, that may depend on $q$, such that $\left(\mathfrak{c}_{1}, \mathfrak{c}_{2}\right) \neq(0,0)$ if $q \neq 1$, and $\left(\mathfrak{c}_{4}, \mathfrak{c}_{5}, \mathfrak{c}_{6}\right) \neq(0,0,0)$ if $q=1$. In the case $q=1$, the lattice is called quadratic if $\mathfrak{c}_{4} \neq 0$, and linear if $\mathfrak{c}_{4}=0$; and in the case $q \neq 1$, it is called $q$-quadratic if $\mathfrak{c}_{1} \mathfrak{c}_{2} \neq 0$, and $q$-linear if $\mathfrak{c}_{1} \mathfrak{c}_{2}=0$ (cf. (3). Notice that

$$
\frac{x\left(s+\frac{1}{2}\right)+x\left(s-\frac{1}{2}\right)}{2}=\alpha x(s)+\beta
$$

where $\alpha$ and $\beta$ are given by

$$
\alpha:=\frac{q^{1 / 2}+q^{-1 / 2}}{2}, \quad \beta:=\left\{\begin{array}{ccc}
(1-\alpha) \mathfrak{c}_{3} & \text { if } & q \neq 1  \tag{2.2}\\
\mathfrak{c}_{4} / 4 & \text { if } & q=1
\end{array}\right.
$$

The lattice $x(s)$ fulfills (cf. 3) :

$$
\begin{aligned}
& \frac{x(s+n)+x(s)}{2}=\alpha_{n} x_{n}(s)+\beta_{n} \\
& x(s+n)-x(s)=\gamma_{n} \nabla x_{n+1}(s)
\end{aligned}
$$

$(n=0,1, \ldots)$, where $x_{\mu}(s):=x\left(s+\frac{\mu}{2}\right), \nabla f(s):=f(s)-f(s-1)$, and $\left(\alpha_{n}\right)_{n \geq 0}$, $\left(\beta_{n}\right)_{n \geq 0}$, and $\left(\gamma_{n}\right)_{n \geq 0}$ are sequences of numbers generated by the following system of difference equations

\alpha_{0}=1, & \alpha_{1}=\alpha, \\
\beta_{0}=0, & \alpha_{n+1}-2 \alpha \alpha_{n}+\alpha_{n-1}=0 \\
\gamma_{0}=0, & \beta_{n+1}-2 \beta_{n}+\beta_{n-1}=2 \beta \alpha_{n}  \tag{2.5}\\
\gamma_{1}, & \gamma_{n+1}-\gamma_{n-1}=2 \alpha_{n}
\end{array}
$$

$(n=1,2, \ldots)$. The explicit solutions of these difference equations are

$$
\begin{align*}
& \alpha_{n}=\frac{q^{n / 2}+q^{-n / 2}}{2},  \tag{2.6}\\
& \beta_{n}=\left\{\begin{array}{cc}
\beta\left(\frac{q^{n / 4}-q^{-n / 4}}{q^{1 / 4}-q^{-1 / 4}}\right)^{2} & \text { if } \quad q \neq 1 \\
\beta n^{2} & \text { if } q=1,
\end{array}\right.  \tag{2.7}\\
& \gamma_{n}=\left\{\begin{array}{cc}
\frac{q^{n / 2}-q^{-n / 2}}{q^{1 / 2}-q^{-1 / 2}} & \text { if } \\
n & \text { if } \quad q=1 .
\end{array}\right. \tag{2.8}
\end{align*}

These formulas may be easily checked (alternatively, see [3). We point out the following relations:

& \gamma_{2 n}=2 \alpha_{n} \gamma_{n}  \tag{2.12}\\
& \alpha_{n}^{2}+\left(\alpha^{2}-1\right) \gamma_{n}^{2}=\alpha_{2 n}=2 \alpha_{n}^{2}-1  \tag{2.13}\\
& \alpha_{n-1}-\alpha \alpha_{n}=\left(1-\alpha^{2}\right) \gamma_{n}  \tag{2.14}\\
& \alpha+\alpha_{n} \gamma_{n}=\alpha_{n-1} \gamma_{n+1}  \tag{2.15}\\
& 1+\alpha_{n+1} \gamma_{n}=\alpha_{n} \gamma_{n+1} \tag{2.16}

$(n=0,1, \ldots)$, with the conventions $\alpha_{-1}:=\alpha$ and $\gamma_{-1}:=-1$, consistently with (2.6) and (2.8).

Definition 2.1. Let $x(s)$ be a lattice given by (2.1). The $x$-derivative operator on $\mathcal{P}, \mathrm{D}_{x}$, and the $x$-average operator on $\mathcal{P}, \mathrm{S}_{x}$, are the operators on $\mathcal{P}$ defined for
each $f \in \mathcal{P}$ so that $\operatorname{deg}\left(\mathrm{D}_{x} f\right)=\operatorname{deg} f-1, \operatorname{deg}\left(\mathrm{~S}_{x} f\right)=\operatorname{deg} f$, and

$$
\begin{align*}
\mathrm{D}_{x} f(x(s)) & =\frac{f\left(x\left(s+\frac{1}{2}\right)\right)-f\left(x\left(s-\frac{1}{2}\right)\right)}{x\left(s+\frac{1}{2}\right)-x\left(s-\frac{1}{2}\right)}  \tag{2.17}\\
\mathrm{S}_{x} f(x(s)) & =\frac{f\left(x\left(s+\frac{1}{2}\right)\right)+f\left(x\left(s-\frac{1}{2}\right)\right)}{2} \tag{2.18}
\end{align*}
$$

The relations (2.17) and (2.18) appear in [18, (3.2.4)-(3.2.5)] up to a shift in the variable $s$. The operators $\mathrm{D}_{x}$ and $\mathrm{S}_{x}$ on $\mathcal{P}$ induce two operators on the dual space $\mathcal{P}^{*}$, namely $\mathbf{D}_{x}: \mathcal{P}^{*} \rightarrow \mathcal{P}^{*}$ and $\mathbf{S}_{x}: \mathcal{P}^{*} \rightarrow \mathcal{P}^{*}$, via the following definition (cf. [6]):

Definition 2.2. Let $x(s)$ be a lattice given by (2.1). For each $\mathbf{u} \in \mathcal{P}^{*}$, the functionals $\mathbf{D}_{x} \mathbf{u} \in \mathcal{P}^{*}$ and $\mathbf{S}_{x} \mathbf{u} \in \mathcal{P}^{*}$ are defined by

$$
\begin{equation*}
\left\langle\mathbf{D}_{x} \mathbf{u}, f\right\rangle:=-\left\langle\mathbf{u}, \mathrm{D}_{x} f\right\rangle, \quad\left\langle\mathbf{S}_{x} \mathbf{u}, f\right\rangle:=\left\langle\mathbf{u}, \mathrm{S}_{x} f\right\rangle \quad(f \in \mathcal{P}) . \tag{2.19}
\end{equation*}
$$

We call $\mathbf{D}_{x} \mathbf{u}$ the $x$-derivative of $\mathbf{u}$ and $\mathbf{S}_{x} \mathbf{u}$ the $x$-average of $\mathbf{u}$.
Hereafter, $z:=x(s)$ being a lattice given by (2.1), we consider two fundamental polynomials, $\mathrm{U}_{1}$ and $\mathrm{U}_{2}$, introduced in [6], defined by

& \mathrm{U}_{1}(z):=\left(\alpha^{2}-1\right) z+\beta(\alpha+1)  \tag{2.20}\\
& \mathrm{U}_{2}(z):=\left(\alpha^{2}-1\right) z^{2}+2 \beta(\alpha+1) z+\delta \tag{2.21}
\end{align*}
$$

where $\delta \equiv \delta_{x}$ is a constant with respect to the lattice, given by ${ }^{6}$

$$

2.3. A Leibniz formula. Here we state a useful version of the Leibniz formula, involving the $x$-derivative operator, for the left multiplication of a functional by a polynomial. We need to state some preliminary results.

& =\alpha_{n}\left(\alpha \mathrm{~S}_{x} \mathrm{D}_{x}^{n+1} f+\mathrm{U}_{1} \mathrm{D}_{x}^{n+2} f\right)+\gamma_{n}\left(\left(\alpha^{2}-1\right) \mathrm{S}_{x} \mathrm{D}_{x}^{n+1} f+\alpha \mathrm{U}_{1} \mathrm{D}_{x}^{n+2} f\right) \\

Substituting this expression in the right-hand side of (2.54) and then applying the method of telescoping sums, we get

Finally, since $\mathrm{T}_{n,-1} f=0$ and $\frac{1}{\alpha_{1}} \mathbf{D}_{x} \mathrm{~T}_{n, n} f=\mathrm{T}_{n+1, n+1} f$ (this last equality follows from (2.52) taking therein $k=n$ and then in the resulting expression shifting $n$ into $n+1$ ), we obtain (2.53) with $n$ replaced by $n+1$. Thus (2.53) is proved.

Corollary 2.1. Consider the lattice $x(s):=\mathfrak{c}_{1} q^{-s}+\mathfrak{c}_{2} q^{s}+\mathfrak{c}_{3}$. Let $\mathbf{u} \in \mathcal{P}^{*}$ and $f \in \mathcal{P}_{2}$. Write $f(z)=a z^{2}+b z+c$, with $a, b, c \in \mathbb{C}$. Then

Hence (2.59) holds for $n=0,1, \ldots$.. Finally, from (2.64) it is obvious that (2.60) holds with $n$ replaced by $n+1$ and, consequently, it holds for all $n$. Therefore (2.58) -(2.60) hold and so (2.56) is proved.

## 3. Classical OPS and Rodrigues formula

This section concerns classical OPS on lattices and their associated regular functionals. We start by reviewing some basic definitions and then we derive a functional version of the Rodrigues formula.

Definition 3.1. Let $x(s)$ be a lattice given by (2.1). $\mathbf{u} \in \mathcal{P}^{*}$ is called $x$-classical if it is regular and there exist nonzero polynomials $\phi \in \mathcal{P}_{2}$ and $\psi \in \mathcal{P}_{1}$ such that

An OPS with respect to a $x$-classical functional will be called a $x$-classical OPS (or a classical OPS on the lattice $x$ ).

Definition 3.1] appears in [6, and extends the definition of D-classical functional

on the lattice $x$, or, simply, $x-G P$ functional equation. As mentioned in the introductory section, our principal goal in this work is to state necessary and sufficient conditions, involving only $\phi$ and $\psi$ (or, equivalently, their coefficients), such that a given functional $\mathbf{u} \in \mathcal{P}^{*}$ satisfying the $x$-GP functional equation (3.1) becomes regular. In order to move on we need to introduce some notation and to prove some preliminary properties.

We denote by $P_{n}^{[k]}$ the monic polynomial of degree $n$ defined by

This is an analogous for lattices of the corresponding definitions for the D -classical and $(q, \omega)$-classical cases (cf. [16, 13, 2]).
3.1. Preliminary properties. Following [6], given $\mathbf{u} \in \mathcal{P}^{*}, \phi \in \mathcal{P}_{2}$, and $\psi \in \mathcal{P}_{1}$, we define recursively polynomials $\phi^{[k]} \in \mathcal{P}_{2}$ and $\psi^{[k]} \in \mathcal{P}_{1}$ by

$(k=0,1, \ldots) . \mathbf{u}^{[k]}$ may be seen as the higher order $x$-derivative of $\mathbf{u}$. Next, we provide explicit representations for the polynomials $\phi^{[k]}$ and $\psi^{[k]}$.
Proposition 3.1. Consider the lattice $x(s):=\mathfrak{c}_{1} q^{-s}+\mathfrak{c}_{2} q^{s}+\mathfrak{c}_{3}$. Let $\phi \in \mathcal{P}_{2}$ and $\psi \in \mathcal{P}_{1}$, so there are $a, b, c, d, e \in \mathbb{C}$ such that

$\phi^{[k]}, \phi^{[k+1]}, \psi^{[k]}$, and $\psi^{[k+1]}$ given by (3.9); and then, in the two resulting identities, using (2.40) together with (2.20) and (2.21), after identification of the coefficients of the polynomials appearing in both sides of each of those identities, we obtain a system with five difference equations, namely

Lemma 3.1 in bellow is proved in [6. We point out that the statement of the result given in [6] assumes a priori that $\mathbf{u}$ is a regular functional. However, inspection of the proof given therein shows that the result remains unchanged without such assumption.
Lemma 3.1. Let $\mathbf{u} \in \mathcal{P}^{*}$. Suppose that there exist $\phi \in \mathcal{P}_{2}$ and $\psi \in \mathcal{P}_{1}$ such that (3.1) holds. Then $\mathbf{u}^{[k]}$ satisfies the functional equation

hold for each $k=0,1, \ldots$.
Proof. Using (2.38) and (3.20), we deduce

& =\left(2 \alpha-\alpha^{-1}\right) \mathbf{S}_{x} \mathbf{D}_{x}\left(\phi^{[k]} \mathbf{u}^{[k]}\right)+\alpha^{-1} \mathrm{U}_{1} \mathbf{D}_{x}^{2}\left(\phi^{[k]} \mathbf{u}^{[k]}\right)-\alpha \psi^{[k]} \mathbf{u}^{[k]} \\
& =\mathbf{D}_{x} \mathbf{S}_{x}\left(\phi^{[k]} \mathbf{u}^{[k]}\right)-\alpha \psi^{[k]} \mathbf{u}^{[k]},
\end{aligned}

where the last equality follows from (2.47) for $n=1$ and taking into account that $\alpha_{2}=2 \alpha^{2}-1$ and $\gamma_{1}=1$. Therefore, by the definition of $\mathbf{u}^{[k+1]}$, we obtain

3.2. A functional Rodrigues formula. Here we prove a functional version of the Rodrigues formula on lattices, extending results stated in [13, 2].

3.3. Regularity of $\mathbf{u}^{[k]}$. The next result is virtually proved in [13, Theorem 2].

Lemma 3.3. Let $\mathbf{u} \in \mathcal{P}^{*}$ be regular. Suppose that there is $(\phi, \psi) \in \mathcal{P}_{2} \times \mathcal{P}_{1} \backslash\{(0,0)\}$ so that (3.1) holds. Then neither $\phi$ nor $\psi$ is the zero polynomial, and $\operatorname{deg} \psi=1$.

Lemma 3.4 in bellow gives the regularity of $\mathbf{u}^{[k]}$. The result appears in [6, Proposition 4]. However the proof of the $x$-admissibility condition given therein is incorrect. We present a proof following ideas presented in [13, 2,

Lemma 3.4. Let $\mathbf{u} \in \mathcal{P}^{*}$. Suppose that $\mathbf{u}$ is regular and satisfies (3.1), where $(\phi, \psi) \in \mathcal{P}_{2} \times \mathcal{P}_{1} \backslash\{(0,0)\}$. Then $(\phi, \psi)$ is a $x$-admissible pair and $\mathbf{u}^{[k]}$ is regular for each $k=1,2, \ldots$ Moreover, if $\left(P_{n}\right)_{n \geq 0}$ is the monic OPS with respect to $\mathbf{u}$, then $\left(P_{n}^{[k]}\right)_{n \geq 0}$ is the monic OPS with respect to $\mathbf{u}^{[k]}$.

Proof. Set $\phi(z)=a z^{2}+b z+c$ and $\psi(z)=d z+e$. By Lemma 3.3, both $\phi$ and $\psi$ are nonzero polynomials, and $d \neq 0$. If $\operatorname{deg} \phi \in\{0,1\}$ then $d_{n}=d \alpha_{n} \neq 0$ for each $n=0,1, \ldots$, and so the pair $(\phi, \psi)$ is $x$-admissible. Assume now that $\operatorname{deg} \phi=2$. Then $d_{n}=a \gamma_{n}+d \alpha_{n}$, with $a \neq 0$. To prove that $d_{n} \neq 0$, we start by showing that

& +\left\langle\phi \mathbf{u}, \mathrm{S}_{x}\left(\left(\mathrm{~S}_{x} P_{n+2}-\alpha^{-1} \mathrm{U}_{1} \mathrm{D}_{x} P_{n+2}\right) P_{n}^{[1]}\right)-\alpha^{-1} \mathrm{U}_{2} \mathrm{D}_{x}\left(P_{n}^{[1]} \mathrm{D}_{x} P_{n+2}\right)\right\rangle \\

Now, on the one hand, $\mathrm{U}_{2} \psi \mathrm{D}_{x} P_{n}^{[1]}+\phi \mathrm{S}_{x} P_{n}^{[1]}$ is a polynomial of degree at most $n+2$, being the coefficient of $z^{n+2}$ equal to $\left(\alpha^{2}-1\right) d \gamma_{n}+a \alpha_{n}$. Hence, since the relations

Consequently, by (3.60) for $k=1,\left(P_{n}^{[1]}\right)_{n \geq 0}$ is the monic OPS with respect to $\mathbf{u}^{[1]}$. This proves the last statement in the lemma for $k=1$. Since $d_{n}^{[k]}=a^{[k]} \gamma_{n}+\alpha_{n} d^{[k]}(n, k=0,1, \ldots)$, it is easy to see, using (3.15)-(3.18), that $d_{n}^{[k]}=d_{n+2 k}$ for all $n, k=0,1, \ldots$. Thus the last sentence in the lemma follows from (3.60).

## 4. Main Results: Regularity conditions

In this section we state our main results, giving the analogues of Theorems B and C for OPS on lattices. Thus, once a lattice as in (2.1) is fixed, we state necessary and sufficient conditions so that a functional $\mathbf{u} \in \mathcal{P}^{*}$ satisfying (3.1) is regular. Furthermore, the monic OPS with respect to $\mathbf{u}$ is described.
4.1. The lattice $x(s)=\mathfrak{c}_{1} q^{-s}+\mathfrak{c}_{2} q^{s}+\mathfrak{c}_{3}$. We start by considering a lattice $x(s)$ with $q \neq 1$, so that $x(s)$ is a $q$-quadratic or a $q$-linear lattice.

Theorem 4.1. Consider the lattice

x(s)=\mathfrak{c}_{1} q^{-s}+\mathfrak{c}_{2} q^{s}+\mathfrak{c}_{3} .

Let $\mathbf{u} \in \mathcal{P}^{*} \backslash\{\mathbf{0}\}$ and suppose that there exist $(\phi, \psi) \in \mathcal{P}_{2} \times \mathcal{P}_{1} \backslash\{(0,0)\}$ such that

Set $\phi(z)=a z^{2}+b z+c$ and $\psi(z)=d z+e(a, b, c, d, e \in \mathbb{C})$, and let $d_{n}$ and $e_{n}$ be defined by (3.27), and $\phi^{[n]}$ and $\psi^{[n]}$ be given by (3.7) -(3.8). Then, $\mathbf{u}$ is regular if and only if $(\phi, \psi)$ is a $x$-admissible pair and $\psi^{[n]} \nmid \phi^{[n]}$ for each $n=0,1, \ldots$; that is to say, $\mathbf{u}$ is regular if and only if the following conditions hold:

Proof. Suppose that $\mathbf{u}$ is regular. By Lemma 3.4. $(\phi, \psi)$ is a $x$-admissible pair, meaning that the first condition in (4.2) holds, and $\left(P_{j}^{[n]}\right)_{j \geq 0}$ is the monic OPS with respect to $\mathbf{u}^{[n]}$, for each fixed $n$. Write the TTRR for $\left(P_{j}^{[n]}\right)_{j \geq 0}$ as

We first show that (for $n=0$ ) the coefficient $C_{1} \equiv C_{1}^{[0]}$, appearing in the TTRR for $\left(P_{j}\right)_{j \geq 0}$, is given by

Indeed, taking $k=0$ and $k=1$ in the relation $\left\langle\mathbf{D}_{x}(\phi \mathbf{u}), z^{k}\right\rangle=\left\langle\mathbf{S}_{x}(\psi \mathbf{u}), z^{k}\right\rangle$, we obtain $0=d u_{1}+e u_{0}$ and $a u_{2}+b u_{1}+c u_{0}=-d \alpha u_{2}-(e \alpha+d \beta) u_{1}-e \beta u_{0}$, where $u_{k}:=\left\langle\mathbf{u}, z^{k}\right\rangle(k=0,1, \ldots)$. Therefore,

Since equation (3.20) fulfilled by $\mathbf{u}^{[n]}$ is of the same type as (4.1) fulfilled by $\mathbf{u}$, with the polynomials $\phi^{[n]}$ and $\psi^{[n]}$ in (3.20) playing the roles of $\phi$ and $\psi$ in (4.1), $C_{1}^{[n]}$ may be obtained replacing in (4.8) $\phi$ and $\psi(z)=d z+e$ by $\phi^{[n]}$ and $\psi^{[n]}(z)=d_{2 n}\left(z-\mathfrak{c}_{3}\right)+e_{n}$, respectively. Hence,

Conversely, suppose that conditions (4.2) hold. Define a sequence of polynomials, $\left(P_{n}\right)_{n \geq 0}$, by the TTRR (4.3)-4.5), with $P_{-1}(z):=0$. According to the hypothesis (4.2), $C_{n+1} \neq 0$ for each $n=0,1, \ldots$ Therefore, Favard's theorem ensures that $\left(P_{n}\right)_{n \geq 0}$ is a monic OPS. To prove that $\mathbf{u}$ is regular we will show that $\left(P_{n}\right)_{n \geq 0}$ is the monic OPS with respect to $\mathbf{u}$. For that we only need to prove that

$$
u_{0} \neq 0, \quad\left\langle\mathbf{u}, P_{n}\right\rangle=0 \quad(n=1,2, \ldots)
$$

We start by showing that $u_{0} \neq 0$. Indeed, suppose that $u_{0}=0$. Since (4.1) holds, then $\left\langle\mathbf{D}_{x}(\phi \mathbf{u})-\mathbf{S}_{x}(\psi \mathbf{u}), z^{n}\right\rangle=0(n=0,1, \ldots)$. This implies

$$
\begin{equation*}
d_{n} u_{n+1}+\sum_{j=0}^{n} a_{n, j} u_{j}=0 \quad(n=0,1, \ldots) \tag{4.12}
\end{equation*}
$$

for some complex numbers $a_{n, j}(j=0,1, \ldots, n)$. Since $u_{0}=0$ and $d_{n} \neq 0$ for all $n=0,1, \ldots$, from (4.12) we deduce $u_{n}=0$ for each $n=0,1, \ldots$. This implies $\mathbf{u}=\mathbf{0}$, contrary to the hypothesis. Therefore $u_{0} \neq 0$. Next, notice that $P_{n}(z)=k_{n} R_{n}(z)$
$(n=0,1, \ldots)$, where $R_{n}$ is defined by (3.29) and $k_{n}^{-1}:=(-\alpha)^{n} \prod_{j=1}^{n} d_{n+j-2}$. Therefore, by the Rodrigues formula (3.28) given in Theorem 3.1, we obtain

$$
\left\langle\mathbf{u}, P_{n}\right\rangle=k_{n}\left\langle\mathbf{u}, R_{n}\right\rangle=k_{n}\left\langle R_{n} \mathbf{u}, 1\right\rangle=k_{n}\left\langle\mathrm{D}_{x}^{n} \mathbf{u}^{[n]}, 1\right\rangle=(-1)^{n} k_{n}\left\langle\mathbf{u}^{[n]}, \mathrm{D}_{x}^{n} 1\right\rangle=0
$$

for each $n=1,2, \ldots$ Hence $\mathbf{u}$ is regular. The remaining statements in the theorem follow from Theorem 3.1.

Remark 4.1. It is important to highlight that the Rodrigues formula holds for a functional $\mathbf{u}$ satisfying a $x-G P$ functional equation, even if $\mathbf{u}$ is not regular, provided that the pair $(\phi, \psi)$ appearing in that $x-G P$ functional equation forms $a$ $x$-admissible pair. This fact is a consequence of Theorem 3.1.
4.2. The lattice $x(s)=\mathfrak{c}_{4} s^{2}+\mathfrak{c}_{5} s+\mathfrak{c}_{6}$. We consider now a lattice $x(s)$ for $q=1$, so that $x(s)$ is a quadratic or a linear lattice. Recall that, here, $\mathfrak{c}_{4}=4 \beta$. We just give the results for this situation, since the techniques and computations are very similar to the ones presented for the case $q \neq 1$. For the lattice $x(s)=\mathfrak{c}_{4} s^{2}+\mathfrak{c}_{5} s+\mathfrak{c}_{6}$ the system of difference equations (3.10)-(3.14) becomes

$$
\begin{aligned}
& a^{[n+1]}=a^{[n]} \\
& d^{[n+1]}=2 a^{[n]}+d^{[n]} \\
& b^{[n+1]}=b^{[n]}+6 \beta\left(a^{[n]}+d^{[n]}\right) \\
& e^{[n+1]}=e^{[n]}+b^{[n]}+\beta\left(2 a^{[n]}+3 d^{[n]}\right) \\
& c^{[n+1]}=c^{[n]}+\beta\left(b^{[n]}+2 e^{[n]}\right)+\beta^{2} d^{[n]}+\left(\beta^{2}-4 \beta \mathfrak{c}_{6}+\frac{\mathfrak{c}_{5}^{2}}{4}\right)\left(a^{[n]}+d^{[n]}\right)
\end{aligned}
$$

with the initial conditions $a^{[0]}=a, b^{[0]}=b, c^{[0]}=c, d^{[0]}=d$ and $e^{[0]}=e$. The solution of this system is

$$
\begin{aligned}
& a^{[n]}=a, \quad b^{[n]}=b+6 \beta n(a n+d), \quad d^{[n]}=2 a n+d, \\
& e^{[n]}=b n+e+2 d \beta n^{2}+\beta n^{2}(2 a n+d) \\
& c^{[n]}=\phi\left(\beta n^{2}\right)+2 \beta n \psi\left(\beta n^{2}\right)-n\left(4 \beta \mathfrak{c}_{6}-\frac{\mathfrak{c}_{5}^{2}}{4}\right)(a n+d)
\end{aligned}
$$

$(n=0,1, \ldots)$. Thus, applying a limiting process (as $q \rightarrow 1$ ) on Theorem 4.1. we may infer and then to prove rigorously the following

Theorem 4.2. Consider the lattice

$$
x(s)=\mathfrak{c}_{4} s^{2}+\mathfrak{c}_{5} s+\mathfrak{c}_{6}
$$

Let $\mathbf{u} \in \mathcal{P}^{*} \backslash\{\mathbf{0}\}$ and suppose that there exist $(\phi, \psi) \in \mathcal{P}_{2} \times \mathcal{P}_{1} \backslash\{(0,0)\}$ such that

$$
\begin{equation*}
\mathbf{D}_{x}(\phi \mathbf{u})=\mathbf{S}_{x}(\psi \mathbf{u}) \tag{4.13}
\end{equation*}
$$

Set $\phi(z):=a z^{2}+b z+c$ and $\psi(z):=d z+e$. Then $\mathbf{u}$ is regular if and only if

$$
\begin{equation*}
d_{n} \neq 0, \quad \phi^{[n]}\left(-\beta n^{2}-\frac{e_{n}}{d_{2 n}}\right) \neq 0 \quad(n=0,1, \ldots), \tag{4.14}
\end{equation*}
$$

where $d_{n}:=a n+d, e_{n}:=b n+e+2 \beta d n^{2}$, and

$$
\phi^{[n]}(z)=a z^{2}+\left(b+6 \beta n d_{n}\right) z+\phi\left(\beta n^{2}\right)+2 \beta n \psi\left(\beta n^{2}\right)-\frac{n}{4}\left(16 \beta \mathfrak{c}_{6}-\mathfrak{c}_{5}^{2}\right) d_{n}
$$

Under these conditions, the monic $\operatorname{OPS}\left(P_{n}\right)_{n \geq 0}$ with respect to $\mathbf{u}$ satisfies (4.3) with

$$
\begin{align*}
B_{n} & =\frac{n e_{n-1}}{d_{2 n-2}}-\frac{(n+1) e_{n}}{d_{2 n}}-2 \beta n(n-1),  \tag{4.15}\\
C_{n+1} & =-\frac{(n+1) d_{n-1}}{d_{2 n-1} d_{2 n+1}} \phi^{[n]}\left(-\beta n^{2}-\frac{e_{n}}{d_{2 n}}\right) \tag{4.16}
\end{align*}
$$

$(n=0,1, \ldots)$. Moreover, the following functional Rodrigues formula holds:

$$
\begin{equation*}
P_{n} \mathbf{u}=k_{n} \mathbf{D}_{x}^{n} \mathbf{u}^{[n]}, \quad k_{n}:=(-1)^{n} \prod_{j=1}^{n} d_{n+j-2}^{-1} \quad(n=0,1, \ldots) \tag{4.17}
\end{equation*}
$$

Remark 4.2. For $x(s)=\mathfrak{c}_{6}$ we immediately recover Theorem B.

## 5. Two examples: Racah and Askey-Wilson polynomials

In this section we derive the recurrence coefficients for the Racah and the AskeyWilson polynomials, using as departure point their associated $x$-GP functional equations. It is worth mentioning that Theorem 4.1 allow us also to answer positively to a conjecture posed by Ismail [10, Conjecture 24.7.8]. Since the proof of this conjecture is rather technique and involves long computations, it will be presented in a different work [4].
5.1. The Racah polynomials. Consider the quadratic lattice

$$
x(s)=s(s+a+b+1)
$$

where $a, b, c, d \in \mathbb{C}$. Let $\mathbf{u} \in \mathcal{P}^{*}$ be a functional satisfying (4.13), where

$$
\begin{aligned}
\phi(z):= & 2 z^{2}+[(a+b+2 c+3) d+c(a-b+3)+2(a+b+a b+2)] z \\
& +(1+a)(1+d)(a+b+1)(b+c+1) \\
\psi(z):= & 2(d+c+2) z+2(1+a)(1+d)(b+c+1)
\end{aligned}
$$

According to (4.14) in Theorem 4.2, $\mathbf{u}$ is regular if and only if

$$
\{a, c, d, d+c-1, b+c, c+d-a, d-b\} \cap \mathbb{Z}^{-}=\emptyset
$$

where $\mathbb{Z}^{-}:=\{-1,-2, \ldots\}$. Under these conditions, by (4.15)-4.16), the recurrence coefficients for the monic $\operatorname{OPS}\left(P_{n}\right)_{n \geq 0}$ with respect to $\mathbf{u}$ are given by

$$
\begin{aligned}
B_{n}=- & \frac{(n+a+1)(n+d+1)(n+b+c+1)(n+d+c+1)}{(2 n+d+c+1)(2 n+d+c+2)} \\
& -\frac{n(n+c)(n+d+c-a)(n+d-b)}{(2 n+d+c)(2 n+d+c+1)}, \\
C_{n+1}= & (n+1)(n+a+1)(n+c+1)(n+d+1) \\
& \times \frac{(n+d+c+1)(n+b+c+1)(n+c+d-a+1)(n+d-b+1)}{(2 n+d+c+1)(2 n+d+c+2)^{2}(2 n+d+c+3)}
\end{aligned}
$$

$(n=0,1, \ldots)$. Therefore,

$$
P_{n}(z)=R_{n}(z ; d, c, a, b) \quad(n=0,1, \ldots)
$$

$\left(R_{n}(. ; d, c, a, b)\right)_{n \geq 0}$ being the sequence of the monic Racah polynomials [11, p.190].
5.2. The Askey-Wilson polynomials. Consider the $q$-quadratic lattice

$$
x(s)=\mathfrak{c}_{1} q^{-s}+\mathfrak{c}_{2} q^{s}+\mathfrak{c}_{3} .
$$

Let $\mathbf{u}$ be a linear functional on $\mathcal{P}$ satisfying (4.1), where $\phi$ and $\psi$ are given by

$$
\begin{aligned}
\phi(z)= & 2(1+a b c d)\left(z-\mathfrak{c}_{3}\right)^{2} \\
& -2 \sqrt{\mathfrak{c}_{1} \mathfrak{c}_{2}}(a+b+c+d+a b c+a b d+a c d+b c d)\left(z-\mathfrak{c}_{3}\right) \\
& +4 \mathfrak{c}_{1} \mathfrak{c}_{2}(a b+a c+a d+b c+b d+c d-a b c d-1) \\
\psi(z)= & \frac{4 q^{1 / 2}}{q-1}\left((a b c d-1)\left(z-\mathfrak{c}_{3}\right)\right. \\
& \left.+\sqrt{\mathfrak{c}_{1} \mathfrak{c}_{2}}(a+b+c+d-a b c-a b d-a c d-b c d)\right),
\end{aligned}
$$

with $a, b, c, d \in \mathbb{C}$. The parameter $d_{n}$ given by (3.27) reads as

$$
d_{n}=-\left(\frac{q^{1 / 2}-q^{-1 / 2}}{2}\right)^{-1} q^{-n / 2}\left(1-a b c d q^{n}\right) .
$$

By Theorem 4.1 $\mathbf{u}$ is regular if and only if

$$
\begin{aligned}
& \mathfrak{c}_{1} \mathfrak{c}_{2}\left(1-a b c d q^{n}\right)\left(1-a b q^{n}\right)\left(1-a c q^{n}\right) \\
& \quad \times\left(1-a d q^{n}\right)\left(1-b c q^{n}\right)\left(1-b d q^{n}\right)\left(1-c d q^{n}\right) \neq 0 \quad(n=0,1, \ldots) .
\end{aligned}
$$

Under these conditions, using formulas (4.4) (4.5) in Theorem 4.1 we obtain the recurrence coefficients for the monic OPS $\left(P_{n}\right)_{n \geq 0}$ with respect to $\mathbf{u}$ :

$$
\begin{aligned}
B_{n}=\mathfrak{c}_{3}+2 \sqrt{\mathfrak{c}_{1} \mathfrak{c}_{2}}\left[a+\frac{1}{a}\right. & -\frac{\left(1-a b q^{n}\right)\left(1-a c q^{n}\right)\left(1-a d q^{n}\right)\left(1-a b c d q^{n-1}\right)}{a\left(1-a b c d q^{2 n-1}\right)\left(1-a b c d q^{2 n}\right)} \\
& \left.-\frac{a\left(1-q^{n}\right)\left(1-b c q^{n-1}\right)\left(1-b d q^{n-1}\right)\left(1-c d q^{n-1}\right)}{\left(1-a b c d q^{2 n-1}\right)\left(1-a b c d q^{2 n-2}\right)}\right]
\end{aligned}
$$

(if $a=0$, define $B_{n}$ by continuity, taking $a \rightarrow 0$ in the preceding expression), and

$$
\begin{aligned}
C_{n+1}= & \mathfrak{c}_{1} \mathfrak{c}_{2}\left(1-q^{n+1}\right)\left(1-a b c d q^{n-1}\right) \\
& \times \frac{\left(1-a b q^{n}\right)\left(1-a c q^{n}\right)\left(1-a d q^{n}\right)\left(1-b c q^{n}\right)\left(1-b d q^{n}\right)\left(1-c d q^{n}\right)}{\left(1-a b c d q^{2 n-1}\right)\left(1-a b c d q^{2 n}\right)^{2}\left(1-a b c d q^{2 n+1}\right)}
\end{aligned}
$$

$(n=0,1,2, \ldots)$. Hence

$$
P_{n}(z)=2^{n}\left(\mathfrak{c}_{1} \mathfrak{c}_{2}\right)^{n / 2} Q_{n}\left(\frac{z-\mathfrak{c}_{3}}{2 \sqrt{\mathfrak{c}_{1} \mathfrak{c}_{2}}} ; a, b, c, d \mid q\right) \quad(n=0,1, \ldots),
$$

where $\left(Q_{n}(\cdot ; a, b, c, d \mid q)\right)_{n \geq 0}$ is the monic OPS of the Askey-Wilson polynomials (see [11, (14.1.5)]).

[^0]:    ${ }^{2}$ Usually (1.3) is called Pearson (or Pearson-type) functional (or distributional) equation. Without wanting to get into nitpicking about the nature of the name, it seems appropriate to call (1.3) Geronimus-Pearson (functional) equation.
    ${ }^{3}$ As pointed out in [3], this characterization was indeed stated before by Sonine [21].
    ${ }^{4}$ As an application of this result, Geronimus also proved that a monic OPS $\left(P_{n}\right)_{n \geq 0}$ is D-classical if

    $$
    P_{n}=\frac{1}{n+1} P_{n+1}^{\prime}+b_{n} P_{n}^{\prime}+c_{n} P_{n-1}^{\prime} \quad(n=0,1, \ldots), \quad P_{-1}=0
    $$

    where $b_{n}$ and $c_{n}$ are complex numbers (see [7 (42)]). Of course, the converse of this sentence was known long before.

[^1]:    ${ }^{5}$ The explicit formulas (1.7) appeared earlier in Suslov's article 22, where they have been derived by a different method, although the regularity conditions for $\mathbf{u}$ had not been discussed therein.

[^2]:    ${ }^{6}$ The constant $\delta_{x}$ appears in [6] without an explicit expression; a full expression, different from the ones provided here, is given in 12 .
