# COUNTING ELLIPTIC FIBRATIONS ON K3 SURFACES

#### Abstract

We solve the problem of counting jacobian elliptic fibrations on an arbitrary complex projective K3 surface up to automorphisms. We then illustrate our method with several explicit examples.


## 1. Introduction

An elliptic pencil on a complex projective K 3 surface $X$ is a complete linear system of divisors whose general member is a smooth elliptic curve E. An elliptic pencil corresponds to an elliptic fibration $\pi: X \rightarrow \mathbb{P}^{1}$, which is said to be jacobian if it admits a section $O$. We denote by $\mathcal{J}_{X}$ the set of all jacobian elliptic fibrations on $X$. The automorphism group $\operatorname{Aut}(X)$ acts on $\mathcal{J}_{X}$ with a finite number of orbits according to a result by Sterk [47, Cor. 2.7]. The aim of this paper is to determine the number of orbits

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right| .
$$

Let $\pi: X \rightarrow \mathbb{P}^{1}$ be a fixed jacobian filtration and denote by $E$ its generic fiber. Once an arbitrary section $O$ is chosen as neutral element, the set of sections of $\pi$ acquires the structure of a group called the Mordell-Weil group of the fibration $\pi$. The classes of $E$ and $O$ in the Néron-Severi lattice $S_{X}$ induce an embedding $\iota$ : $\mathbf{U} \hookrightarrow S_{X}$, where $\mathbf{U}$ denotes the hyperbolic unimodular even lattice of rank 2. The orthogonal complement

$$
W:=\iota(\mathbf{U})^{\perp} \subset S_{X},
$$

is called the frame of the fibration $\pi$. The frame $W$ encodes virtually all geometrical information about the fibration $\pi$. Indeed, the dual graph of the components of the reducible fibers can be inferred from its root sublattice $W_{\text {root }}$, and the Mordell-Weil group is isomorphic to $W / W_{\text {root }}$ (see for instance the survey by Schütt and Shioda [41]). All frames have the same signature and discriminant form, so they belong to the same lattice genus $\mathcal{W}_{X}$, which we call the frame genus of $X$ (Definition 2.5).

Although several works have been dedicated to the classification of jacobian elliptic fibrations on a given K 3 surface $[2,4,6,7,9,12,19,23,25,31,32,43]$, in very few of them the number $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|$ has been explicitly determined. The various approaches were clarified in an unpublished paper by Braun, Kimura and Watari [6], where the following distinctions were introduced:

- the " $\mathcal{J}^{(\text {type })}(X)$ classification" is the problem of determining the pairs ( $W_{\text {root }}, W / W_{\text {root }}$ ) for $W \in \mathcal{W}_{X}$;
- the " $\mathcal{J}_{2}(X)$ classification" is the problem of determining the frame genus $\mathcal{W}_{X}$;
- the " $\mathcal{J}_{1}(X)$ classification" is the problem of determining the orbits $\mathcal{J}_{X} / \operatorname{Aut}(X)$.

[^0]- the " $\mathcal{J}_{0}(X)$ classification" is the problem of determining $\mathcal{J}_{X}$.

In general, each classification is coarser than the next one. For most geometrical applications, the " $\mathcal{J}^{\text {(type })}(X)$ classification" suffices. Very few authors went as far as the " $\mathcal{J}_{1}(X)$ classification". As for the " $\mathcal{J}_{0}(X)$ classification", Nikulin [30, Theorem 5.1] proved that the set $\mathcal{J}_{X}$ is finite if and only if $S_{X}$ belongs to a certain finite set of lattices.

In a remarkable exception dating back to more than 30 years ago, Oguiso [32] proved that

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right| \in\{16,23,38,59\}
$$

when $X$ is the Kummer surface associated to the product $E \times F$ of two non-isogenous elliptic curves or, equivalently, when it holds $T_{X} \cong \mathbf{U}(2)^{2}$. Oguiso's arguments are based on a deep understanding of the geometry of such Kummer surfaces and cannot be generalized to other K3 surfaces.

In the same unpublished paper [6], Braun, Kimura and Watari also found a sufficient condition for $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=\left|\mathcal{W}_{X}\right|$ to hold (which can be seen as a direct corollary of our main theorem, see Corollary 2.10), and listed a few cases where this condition is true. One of these cases, namely the singular K3 surface $X$ with transcendental lattice $T_{X} \cong[2] \oplus[6]$, was later completely worked out by Bertin et al. [2, 3], who found that

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=\left|\mathcal{W}_{X}\right|=53
$$

The same sufficient condition was independently found by Mezzedimi [25], who also proved that a K3 surface with Néron-Severi lattice $S_{X} \cong \mathbf{U} \oplus[-2 d]$ satisfies $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=1$ if $d=1$ and

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=2^{k-1}
$$

if $d \geq 2$, where $k$ is the number of prime divisors of $d$ [25, Proposition 4.4]. Moreover, he showed that $\left|\mathcal{J}_{X}\right|=1$ if $S_{X}$ belongs to a certain explicit list of 32 lattices [25, Thm. 6.14].

We are not aware of other cases in the literature where $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|$ is explicitly known.
Our main result, namely Theorem 2.8, is a formula for the number of jacobian fibrations up to automorphisms with the same frame $W \in \mathcal{W}_{X}$, which we call the multiplicity of the frame $W$. The multiplicity of $W$ turns out to be equal to the number of certain double cosets

$$
|H \backslash G / K|
$$

in the orthogonal group $G=\mathrm{O}\left(T_{X}^{\sharp}\right)$, where $T_{X}^{\sharp}$ is the discriminant group of the transcendental lattice $T_{X}$. The subgroup $H$ is related to the Hodge isometries of $T_{X}$, while the subgroup $K$ depends on $W$. Quite interestingly, this pattern is shared by many other enumerative problems such as counting Kummer structures on $X$ (cf. [13]), counting Fourier-Mukai partners of $X$ (cf. [14]), or counting Enriques surfaces covered by $X$ (cf. [44]).

The advantage of our algebraic method is that it can be implemented as soon as the transcendental lattice $T_{X}$ is known. We compute $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|$ explicitly in the following cases:

- K3 surfaces belonging to the Barth-Peters family (see Theorem 3.4);
- Kummer surfaces associated to the product of non-isogenous elliptic curves, confirming Oguiso's results [32] (see Theorem 3.13);
- Kummer surfaces associated to Jacobian of a very general curve of genus 2, refining a work by Kumar [23] (see Theorem 3.18);
- generic double covers of $\mathbb{P}^{2}$ ramified over 6 lines, refining a work by Kloosterman [19] (see Theorem 3.27);
- K3 surfaces belonging to the Apéry-Fermi pencil, refining a work by Bertin and Lecacheux [4] (see Theorem 3.30).

In each case, all Gram matrices of the lattices in the frame genus are contained in the respective arXiv ancillary file. Computations were carried out with GAP [10], Magma [5] and Sage [46].
Contents of the paper. The paper is divided into two sections.
The theoretical part is contained in §2: it comprises the proof of our main theorem and general guidelines on how to implement our method.

All explicit examples are contained in $\S 3$.

## 2. Main theorem

Throughout this section we let $X$ be a complex projective K3 surface with Néron-Severi lattice $S_{X}$ and transcendental lattice $T_{X}$.

After fixing notation and conventions on lattices in $\S 2.1$ and recalling or proving some preliminary results in $\S 2.2$, we state the main theorem of the paper, namely Theorem 2.8, together with its immediate corollaries in $\S 2.3$. A proof of the theorem is given in $\S 2.4$. Finally, in $\S 2.5$ we provide general guidelines on how to compute $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|$ in explicit cases applying the formula of the theorem.
2.1. Lattices. A lattice $L$ of $\operatorname{rank} r$ is a free, finitely generated $\mathbb{Z}$-module $L \cong \mathbb{Z}^{r}$ endowed with a symmetric bilinear form

$$
L \times L \rightarrow \mathbb{Z}, \quad(v, w) \mapsto v \cdot w
$$

The dual of $L$ is the set

$$
L^{\vee}:=\{x \in L \otimes \mathbb{Q} \mid x \cdot v \in \mathbb{Z} \text { for all } v \in L\}
$$

and the discriminant group is the finite abelian group

$$
L^{\sharp}:=L^{\vee} / L
$$

If the lattice $L$ is even, meaning that $v^{2}:=v \cdot v \in 2 \mathbb{Z}$ for all $v \in L$, then the form on $L$ induces a finite quadratic form $L^{\sharp} \rightarrow \mathbb{Q} / 2 \mathbb{Z}$. We write $\mathrm{O}(L)$ and $\mathrm{O}\left(L^{\sharp}\right)$ for the groups of isomorphisms of $L$ and $L^{\sharp}$ respecting the corresponding bilinear or quadratic forms. There is a natural homomorphism

$$
\mathrm{O}(L) \rightarrow \mathrm{O}\left(L^{\sharp}\right), \quad \gamma \mapsto \gamma^{\sharp},
$$

whose image is denoted $\mathrm{O}^{\sharp}(L)$.
An embedding $\iota: M \hookrightarrow L$ of lattices is called primitive if $L / \iota(M)$ is a free group. A vector $v \in L$ is called primitive if $\mathbb{Z} v \hookrightarrow L$ is a primitive embedding.

A vector $v$ in an even negative definite lattice $L$ is called a root if $v^{2}=-2$. The set of roots is denoted $\Delta(L)$. The sublattice generated by all roots is denoted $L_{\text {root }}$. A root $v$ induces a reflection $\rho_{v} \in \mathrm{O}(L)$ defined by

$$
\rho_{v}(w):=w+(v \cdot w) v .
$$

The subgroup of $\mathrm{O}(L)$ generated by all reflections $\rho_{v}$, denoted $\mathrm{W}(L)$, is called the Weyl group of $L$. From the definition of $\rho_{v}$ it follows that $\mathrm{W}(L)$ is always contained in the kernel of $\mathrm{O}(L) \rightarrow \mathrm{O}\left(L^{\sharp}\right)$.

We write $L(n)$ for the lattice with the same underlying $\mathbb{Z}$-module whose Gram matrix is $n A$, where $A$ is any Gram matrix of $L$. The standard negative definite ADE lattices are denoted $\mathbf{A}_{n}, \mathbf{D}_{n}, \mathbf{E}_{n}$.

A genus is the set of isomorphism classes of all lattices of fixed signature and discriminant form. A genus is always a finite set (see for instance [20, Kapitel VII, Satz (21.3)]).
2.2. Preliminary results. Note any embedding $\iota: \mathbf{U} \hookrightarrow L$ is primitive, because the the lattice $(\iota(\mathbf{U}) \otimes \mathbb{Q}) \cap L$ is an overlattice of $\mathbf{U}$ and each overlattice of $\mathbf{U}$ is trivial (cf. [29, Prop. 1.4.1]).

Let $e, f$ be a fixed basis of $\mathbf{U}$ such that $e^{2}=f^{2}=0$ and $e \cdot f=1$.
Definition 2.1. We say that an embedding $\iota: \mathbf{U} \hookrightarrow S_{X}$ is geometric if $\iota(e)$ is the class of an elliptic curve $E$ and and $\iota(f-e)$ is the class of a smooth rational curve $O$ with $E \cdot O=1$. (Such embeddings were called "canonical" by Bertin et al. [2], but we believe this word to be slightly misleading.)

Let $\mathcal{E}_{X}$ denote the set of geometric embeddings of $\mathbf{U}$ into $S_{X}$ and let aut $(X)$ be the image of the homomorphism $\operatorname{Aut}(X) \rightarrow \mathrm{O}\left(S_{X}\right)$.

Lemma 2.2. The map

$$
\mathcal{E}_{X} / \operatorname{aut}(X) \rightarrow \mathcal{J}_{X} / \operatorname{Aut}(X)
$$

defined by sending a geometric embedding $\iota: \mathbf{U} \hookrightarrow S_{X}$ to the fibration induced by the elliptic curve $E:=\iota(e)$ is a bijection.

Proof. The map is clearly well defined and surjective. Consider now two geometric embeddings $\iota_{1}, \iota_{2}$ such that $\iota_{1}(e)=\iota_{2}(e)$ is the class of $E$ and suppose that $\iota_{1}(f-e), \iota_{2}(f-e)$ are the classes of the curves $O_{1}, O_{2}$. Then, translation by a suitable section induces an automorphism $\alpha \in \operatorname{Aut}(X)$ such that $\alpha(E)=E$ and $\alpha\left(O_{1}\right)=O_{2}$ (cf. for instance [41, §7.6]). Therefore, $\iota_{1}$ and $\iota_{2}$ belong to the same $\operatorname{aut}(X)$-orbit, so the map is also injective.

The positive cone $P_{X}$ is the connected component of

$$
\left\{x \in S_{X} \otimes \mathbb{R} \mid x^{2}>0\right\}
$$

that contains one ample class. The nef cone $N_{X}$ is defined as

$$
N_{X}:=\left\{x \in S_{X} \otimes \mathbb{R} \mid x \cdot C \geq 0 \text { for all curves } C \subset X\right\}
$$

Furthermore, we set

$$
\begin{aligned}
\mathrm{O}\left(S_{X}, P_{X}\right) & :=\left\{\gamma \in \mathrm{O}\left(S_{X}\right) \mid \gamma\left(P_{X}\right) \subseteq P_{X}\right\} \\
\mathrm{O}\left(S_{X}, N_{X}\right) & :=\left\{\gamma \in \mathrm{O}\left(S_{X}\right) \mid \gamma\left(N_{X}\right) \subseteq N_{X}\right\}
\end{aligned}
$$

Lemma 2.3. If $\mathcal{J}_{X} \neq \emptyset$, then the Néron-Severi lattice $S_{X}$ is unique in its genus and the restriction of the natural homomorphism $\mathrm{O}\left(S_{X}\right) \rightarrow \mathrm{O}\left(S_{X}^{\sharp}\right)$ to $\mathrm{O}\left(S_{X}, N_{X}\right)$ is surjective.

Proof. If $\mathcal{J}_{X} \neq \emptyset$, then there exists a (geometric) embedding $\mathbf{U} \hookrightarrow S_{X}$, hence $S_{X} \cong \mathbf{U} \oplus W$ for some lattice $W$. From Nikulin's [29, Thm. 1.14.2] we infer that $S_{X}$ is unique in its genus and that the natural homomorphism $\mathrm{O}\left(S_{X}\right) \rightarrow \mathrm{O}\left(S_{X}^{\sharp}\right)$ is surjective.

The isometry $\gamma \in \mathrm{O}\left(S_{X}\right)$ defined as $\left(-\mathrm{id}_{\mathbf{U}}, \mathrm{id}_{W}\right)$ on the decomposition $S_{X} \cong \mathbf{U} \oplus W$ does not belong to $\mathrm{O}\left(S_{X}, P_{X}\right)$. Hence, $\mathrm{O}\left(S_{X}\right)$ is generated by $\mathrm{O}\left(S_{X}, P_{X}\right)$ and $\gamma$. Since $\gamma$ is contained in the kernel of $\mathrm{O}\left(S_{X}\right) \rightarrow \mathrm{O}\left(S_{X}^{\sharp}\right)$, the restriction of $\mathrm{O}\left(S_{X}\right) \rightarrow \mathrm{O}\left(S_{X}^{\sharp}\right)$ to $\mathrm{O}\left(S_{X}, P_{X}\right)$ is surjective.

Moreover, it holds $\mathrm{O}\left(S_{X}, P_{X}\right) \cong \mathrm{W}\left(S_{X}\right) \rtimes \mathrm{O}\left(S_{X}, N_{X}\right)$ (see for instance [34, Prop. 1.3]) and since $\mathrm{W}\left(S_{X}\right)$ is contained in the kernel of $\mathrm{O}\left(S_{X}\right) \rightarrow \mathrm{O}\left(S_{X}^{\sharp}\right)$, the claim follows.

Proposition 2.4. Let $X \rightarrow \mathbb{P}^{1}$ be an elliptic fibration with fiber $E$. If $D$ is a divisor such that $D \cdot E=1$ and $D^{2}=-2$, then there exists a section $O$ and an element of the Weyl group $\rho \in \mathrm{W}\left(S_{X}\right)$ such that

$$
\rho(E)=E \quad \text { and } \quad \rho(D)=O .
$$

Proof. Imitating Kondō's proof of [21, Lemma 2.1], we can show that there exist a section $O$ and $m_{0}, m_{1}, \ldots, m_{n} \in \mathbb{Z}$ such that

$$
\begin{equation*}
D=O+m_{0} E+\sum_{i=1}^{n} m_{i} C_{i} \tag{1}
\end{equation*}
$$

where $C_{1}, \ldots, C_{n}$ are the irreducible fiber components such that $O \cdot C_{i}=0$ and $C_{i}^{2}=-2$.
From $D^{2}=-2$ it follows that

$$
\begin{equation*}
m_{0}=-\frac{1}{2}\left(\sum_{i=1}^{n} m_{i} C_{i}\right)^{2} \tag{2}
\end{equation*}
$$

As $C_{1}, \ldots, C_{n}$ generate a negative definite lattice, it holds $m_{0} \geq 0$. Moreover, $m_{0}=0$ if and only if $m_{1}=\ldots=m_{n}=0$. We claim that whenever $m_{0}>0$ we can find $\rho^{\prime} \in \mathrm{W}\left(S_{X}\right)$ such that $\rho^{\prime}(E)=E$ and

$$
\rho^{\prime}(D)=O+m_{0}^{\prime} E+\sum_{i=1}^{n} m_{i}^{\prime} C_{i}
$$

with $m_{0}^{\prime}<m_{0}$. In a finite number of steps we obtain $\rho=\ldots \circ \rho^{\prime \prime} \circ \rho^{\prime} \in \mathrm{W}\left(S_{X}\right)$ with $\rho(E)=E$ and $\rho(D)=O$, thus proving the theorem. From now on, we assume that $m_{0}>0$.

Without loss of generality, we can assume that $C_{1}, \ldots, C_{n}$ are all components of the same fiber (otherwise we apply the following procedure on each fiber). Let $C_{0}$ be the fiber component with $O \cdot C_{0}=1$ and let $\rho_{i} \in \mathrm{~W}\left(S_{X}\right)$ be the involution induced by the class of $C_{i}$, for $i=0,1, \ldots, n$.

Note that by applying $\rho_{i}$ to $D$, with $i \in\{1, \ldots, n\}$, only the coefficient of $C_{i}$ in (1) changes. In particular, the coefficients of $O$ and $E$ remain equal to 1 and $m_{0}$, respectively. Since $C_{1}, \ldots, C_{n}$ generate a negative definite lattice, there exist only a finite number of $n$-tuples ( $m_{1}, \ldots, m_{n}$ ) such that (2) holds. If the $n$-tuple $\left(m_{1}, \ldots, m_{j-1}, m_{j}^{\prime}, m_{j+1}, \ldots, m_{n}\right)$ corresponding to $\rho_{j}(D)$ satisfies $m_{j}^{\prime}<m_{j}$, we substitute $D$ with $\rho_{j}(D)$. Repeating this process in a finite number of steps, we can assume (up to substituting $D$ with $\tilde{\rho}(D)$ for some $\tilde{\rho} \in \mathrm{W}\left(S_{X}\right)$ contained in the subgroup generated by $\rho_{1}, \ldots, \rho_{n}$ ) that $D$ satisfies the following minimality property: for each $j=1, \ldots, n$ it holds

$$
\begin{equation*}
\rho_{j}(D)=O+m_{0} E+\sum_{i=1}^{j-1} m_{i} C_{i}+m_{j}^{\prime} C_{j}+\sum_{i=j+1}^{n} m_{i} C_{i}, \quad \text { with } m_{j}^{\prime} \geq m_{j} \tag{3}
\end{equation*}
$$

We claim now that the coefficient $m_{0}^{\prime}$ of $\rho_{0}(D)$ satisfies $m_{0}^{\prime}<m_{0}$, thus concluding the proof. We need to divide the proof according to the dual graph of $C_{1}, \ldots, C_{n}$.

Assume first that $n=1$, so that the dual graph of $C_{1}, \ldots, C_{n}$ is $\mathbf{A}_{1}$. From the minimality property (3) and the assumption $m_{0}>0$ it follows that $m_{1}<0$. Using $C_{0}=E-C_{1}$ and $C_{0} \cdot C_{1}=2$ we obtain

$$
\rho_{0}(D)=\left(O+C_{0}\right)+m_{0} E+m_{1}\left(2 C_{0}-C_{1}\right)=O+m_{0}^{\prime} E+m_{1}^{\prime} C_{1}
$$

with $m_{0}^{\prime}=m_{0}+1+2 m_{1}<m_{0}$, as wished.
Assume now that the dual graph of $C_{1}, \ldots, C_{n}$ is $\mathbf{A}_{n}$, with $n \geq 2$.


From the minimality property (3) it follows that

$$
2 m_{1} \leq m_{2}, \quad 2 m_{i} \leq m_{i-1}+m_{i+1}, \quad \text { for } i=2, \ldots, n-1, \quad 2 m_{n} \leq m_{n-1}
$$

It holds $i m_{i-1} \leq(i-1) m_{i}$ for $i=2, \ldots, n$. Indeed, this is clear for $i=2$ and it follows by induction from

$$
2 i m_{i} \leq i m_{i-1}+i m_{i+1} \leq(i-1) m_{i}+i m_{i+1}
$$

From $n m_{n-1} \leq(n-1) m_{n}$ and $2 m_{n} \leq m_{n-1}$ we infer that $m_{n} \leq 0$. It cannot be $m_{n}=0$ because it implies $m_{n-1}=\ldots=m_{1}=0$, contradicting the fact that $m_{0}>0$. Therefore, it holds $m_{n}<0$ and, symmetrically, $m_{1}<0$. Using $C_{0}=E-C_{1}-\ldots-C_{n}, C_{0} \cdot C_{1}=C_{0} \cdot C_{n}=1$ and $C_{0} \cdot C_{i}=0$ for $i=2, \ldots, n-1$ we obtain

$$
\rho_{0}(D)=\left(O+C_{0}\right)+m_{0} E+m_{1}\left(C_{0}-C_{1}\right)+\sum_{i=2}^{n-1} m_{i} C_{i}+m_{n}\left(C_{0}-C_{n}\right)=O+m_{0}^{\prime} E+\sum_{i=2}^{n-1} m_{i}^{\prime} C_{i}
$$

with $m_{0}^{\prime}=m_{0}+1+m_{1}+m_{n}<m_{0}$, as wished.
Assume now that the dual graph of $C_{1}, \ldots, C_{n}$ is $\mathbf{D}_{n}(n \geq 4)$.


From the minimality property (3) it follows that

$$
\begin{array}{rlrl}
2 m_{1} & \leq m_{2}, & 2 m_{i} & \leq m_{i-1}+m_{i+1}, \\
2 m_{n-2} & \leq m_{n-3}+m_{n-1}+m_{n} & 2 m_{n-1} & \leq m_{n-2}, \quad 2 m_{n} \leq m_{n-2} .
\end{array}
$$

It holds $m_{n-i} \leq m_{n-i-1}$ for all $i=2, \ldots, n-2$. Indeed, this follows from the last three inequalities for $i=2$ and then by induction from

$$
2 m_{n-i-1} \leq m_{n-i-2}+m_{n-i} \leq m_{n-i-2}+m_{n-i-1}
$$

In particular $m_{2} \leq m_{1}$, so from $2 m_{1} \leq m_{2}$ we infer that $m_{2} \leq 0$. It cannot be $m_{2}=0$ because it implies $m_{1}=\ldots=m_{n}=0$, contradicting the fact that $m_{0}>0$. Moreover, it cannot be $m_{2}=-1$, because (recalling that $m_{i} \in \mathbb{Z}$ ) it implies $m_{1}=\cdots=m_{n-2}=-1, m_{n-1} \leq-1, m_{n} \leq-1$, leading to the contradiction

$$
-2=2 m_{n-2} \leq m_{n-3}+m_{n-1}+m_{n} \leq-3 .
$$

Therefore, it holds $m_{2}<-1$. Using $C_{0}=E-C_{1}-2 C_{2}-\ldots-2 C_{n-2}-C_{n-1}-C_{n}, C_{0} \cdot C_{2}=1$ and $C_{0} \cdot C_{i}=0$ for $i=1,3,4, \ldots, n$, we obtain

$$
\rho_{0}(D)=\left(O+C_{0}\right)+m_{0} E+m_{1} C_{1}+m_{2}\left(C_{0}-C_{2}\right)+\sum_{i=3}^{n} m_{i} C_{i}=O+m_{0}^{\prime} E+\sum_{i=1}^{n} m_{i}^{\prime} C_{i}
$$

with $m_{0}^{\prime}=m_{0}+1+m_{2}<m_{0}$, as wished.
Assume now that the dual graph of $C_{1}, \ldots, C_{n}$ is $\mathbf{E}_{6}$.


From the minimality property (3) it follows that

$$
\begin{array}{lll}
2 m_{1} \leq m_{3}, & 2 m_{2} \leq m_{4}, & 2 m_{3} \leq m_{1}+m_{4}, \\
2 m_{4} \leq m_{2}+m_{3}+m_{5}, & 2 m_{5} \leq m_{4}+m_{6}, & 2 m_{6} \leq m_{5} .
\end{array}
$$

From the first and third inequality we obtain $3 m_{1} \leq m_{4}$ and from

$$
6 m_{3} \leq 3 m_{1}+3 m_{4} \leq 4 m_{4}
$$

we get $3 m_{3} \leq 2 m_{4}$. Symmetrically, it holds $3 m_{5} \leq 2 m_{4}$. Then, from

$$
6 m_{4} \leq 3 m_{2}+3 m_{3}+3 m_{5} \leq 3 m_{2}+4 m_{4}
$$

we infer $2 m_{4} \leq 3 m_{2}$. Together with $2 m_{2} \leq m_{4}$, this implies $m_{2} \leq 0$. It cannot be $m_{2}=0$, because it implies $m_{1}=\ldots=m_{n}=0$, contradicting the fact that $m_{0}>0$. Moreover, it cannot be $m_{2}=-1$, because (always recalling that $m_{i} \in \mathbb{Z}$ ) it implies $m_{4}=-2, m_{3} \leq-2$ and $m_{5} \leq-2$, leading to the contradiction

$$
-4=2 m_{4} \leq m_{2}+m_{3}+m_{5} \leq-1-2-2=-5
$$

Therefore, it holds $m_{2}<-1$. Using $C_{0}=E-C_{1}-2 C_{2}-2 C_{3}-3 C_{4}-2 C_{5}-C_{6}, C_{0} \cdot C_{2}=1$ and $C_{0} \cdot C_{i}=0$ for $i=1,3, \ldots, 6$, we obtain

$$
\rho_{0}(D)=\left(O+C_{0}\right)+m_{0} E+m_{1} C_{1}+m_{2}\left(C_{0}-C_{2}\right)+\sum_{i=3}^{6} m_{i} C_{i}=O+m_{0}^{\prime} E+\sum_{i=1}^{6} m_{i}^{\prime} C_{i}
$$

with $m_{0}^{\prime}=m_{0}+1+m_{2}<m_{0}$, as wished.
Assume now that the dual graph of $C_{1}, \ldots, C_{n}$ is $\mathbf{E}_{7}$.


From the minimality property (3) it follows that

$$
\begin{array}{lll}
2 m_{1} \leq m_{3}, & 2 m_{2} \leq m_{4}, & 2 m_{3} \leq m_{1}+m_{4},
\end{array} \quad 2 m_{4} \leq m_{2}+m_{3}+m_{5},
$$

From the last three inequalities we obtain $3 m_{6} \leq 2 m_{5}$ and $4 m_{5} \leq 3 m_{4}$. From

$$
8 m_{4} \leq 4 m_{2}+4 m_{3}+4 m_{5} \leq 2 m_{4}+4 m_{3}+3 m_{4}
$$

we get $3 m_{4} \leq 4 m_{3}$. Then, from

$$
6 m_{3} \leq 3 m_{1}+3 m_{4} \leq 3 m_{1}+4 m_{3}
$$

we infer $2 m_{3} \leq 3 m_{1}$. Together with $2 m_{1} \leq m_{3}$, this implies $m_{1} \leq 0$. It cannot be $m_{1}=0$, because it implies $m_{2}=\ldots=m_{7}=0$, contradicting the fact that $m_{0}>0$. Moreover, it cannot be $m_{1}=-1$, because (recalling that $m_{i} \in \mathbb{Z}$ ) it implies $m_{3}=-2, m_{4}=-3, m_{2} \leq-2, m_{5} \leq-3$, and $m_{5} \leq-2$, leading to the contradiction

$$
-6=2 m_{4} \leq m_{2}+m_{3}+m_{5} \leq-2-2-3=-7
$$

Therefore, it holds $m_{1}<-1$. Using $C_{0}=E-2 C_{1}-2 C_{2}-3 C_{3}-4 C_{4}-3 C_{5}-2 C_{6}-C_{7}, C_{0} \cdot C_{1}=1$ and $C_{0} \cdot C_{i}=0$ for $i=2, \ldots, 7$, we obtain

$$
\rho_{0}(D)=\left(O+C_{0}\right)+m_{0} E+m_{1}\left(C_{0}-C_{1}\right)+\sum_{i=1}^{7} m_{i} C_{i}=O+m_{0}^{\prime} E+\sum_{i=2}^{6} m_{i}^{\prime} C_{i}
$$

with $m_{0}^{\prime}=m_{0}+1+m_{1}<m_{0}$, as wished.
Finally, assume that the dual graph of $C_{1}, \ldots, C_{n}$ is $\mathbf{E}_{8}$.


From the minimality property (3) it follows that

$$
\begin{array}{llll}
2 m_{1} \leq m_{3}, & 2 m_{2} \leq m_{4}, & 2 m_{3} \leq m_{1}+m_{4}, & 2 m_{4} \leq m_{2}+m_{3}+m_{5}, \\
2 m_{5} \leq m_{4}+m_{6}, & 2 m_{6} \leq m_{5}+m_{7}, & 2 m_{7} \leq m_{6}+m_{8}, & 2 m_{8} \leq m_{7}
\end{array}
$$

As in the $\mathbf{E}_{6}$ case, we obtain $3 m_{3} \leq 2 m_{4}$. From

$$
12 m_{4} \leq 6 m_{2}+6 m_{3}+6 m_{5} \leq 3 m_{4}+4 m_{3}+6 m_{5}
$$

we get $5 m_{4} \leq 6 m_{5}$. Then, from

$$
10 m_{5} \leq 5 m_{4}+5 m_{6} \leq 6 m_{5}+5 m_{6}
$$

we get $4 m_{5} \leq 5 m_{6}$. Similarly, we infer $3 m_{6} \leq 4 m_{7}$ and $2 m_{7} \leq 3 m_{8}$. Together with $2 m_{8} \leq m_{7}$, this implies $m_{8} \leq 0$. It cannot be $m_{8}=0$, because it implies $m_{7}=\ldots=m_{1}=0$, contradicting the fact that $m_{0}>0$. Moreover, it cannot be $m_{8}=-1$, because (recalling that $m_{i} \in \mathbb{Z}$ ) it implies $m_{7}=-2$, $m_{6}=-3, m_{5}=-4, m_{4}=-5, m_{3} \leq-4$ and $m_{2} \leq-3$, leading to the contradiction

$$
-10=2 m_{4} \leq m_{2}+m_{3}+m_{5} \leq-3-4-4=-11
$$

Therefore, it holds $m_{8}<-1$. Using $C_{0}=E-2 C_{1}-3 C_{2}-4 C_{3}-6 C_{4}-5 C_{5}-4 C_{6}-3 C_{7}-2 C_{8}$, $C_{0} \cdot C_{8}=1$ and $C_{0} \cdot C_{i}=0$ for $i=1, \ldots, 7$, we obtain

$$
\rho_{0}(D)=\left(O+C_{0}\right)+m_{0} E+\sum_{i=1}^{7} m_{i} C_{i}+m_{8}\left(C_{0}-C_{8}\right)=O+m_{0}^{\prime} E+\sum_{i=1}^{8} m_{i}^{\prime} C_{i}
$$

with $m_{0}^{\prime}=m_{0}+1+m_{8}<m_{0}$, as wished.
Definition 2.5. The frame genus of $X$ is the genus $\mathcal{W}_{X}$ of negative definite lattices $W$ such that

$$
\operatorname{rk}(W)=\operatorname{rk}\left(S_{X}\right)-2 \quad \text { and } \quad W^{\sharp} \cong S_{X}^{\sharp} .
$$

We define the frame map $\mathrm{fr}_{X}$ as follows:

$$
\operatorname{fr}_{X}: \mathcal{E}_{X} / \operatorname{aut}(X) \rightarrow \mathcal{W}_{X}, \quad \iota \mapsto \iota(\mathbf{U})^{\perp}
$$

The number $\left|\operatorname{fr}_{X}^{-1}(W)\right|$ is called the multiplicity of the frame $W \in \mathcal{W}_{X}$.
Corollary 2.6. For each frame $W \in \mathcal{W}_{X}$ there exists a geometric embedding $\iota: \mathbf{U} \hookrightarrow S_{X}$ such that $\iota(\mathbf{U})^{\perp} \cong W$. In particular, the frame map $\mathrm{fr}_{X}$ is surjective and it holds

$$
\begin{equation*}
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=\sum_{W \in \mathcal{W}_{X}}\left|\mathrm{fr}_{X}^{-1}(W)\right| \tag{4}
\end{equation*}
$$

Proof. Fix a frame $W \in \mathcal{W}_{X}$. The lattices $S_{X}$ and $\mathbf{U} \oplus W$ belong to the same genus. Since $S_{X}$ is unique in its genus by Lemma 2.3, it holds $S_{X} \cong \mathbf{U} \oplus W$, i.e. there exists an embedding $\iota$ : $\mathbf{U} \hookrightarrow S_{X}$ with $\iota(\mathbf{U})^{\perp} \cong W$.

Since $\mathrm{W}\left(S_{X}\right)$ acts transitively on the chambers of the positive cone, we find $\rho^{\prime} \in \mathrm{W}\left(S_{X}\right)$ such that $\rho^{\prime} \circ \iota(e) \in N_{X}$, hence $\rho^{\prime} \circ \iota(e)$ is the class of an elliptic curve $E$ (see [36, §3, proof of Cor. 3] or [16, Ch. 2, Prop. 3.10]). Then, $D=\rho^{\prime} \circ \iota(f-e)$ satisfies the hypothesis of Proposition 2.4, so there exists $\rho \in \mathrm{W}\left(S_{X}\right)$ such that $\rho \circ \rho^{\prime} \circ \iota$ is a geometric embedding. Clearly, it holds $\left(\rho \circ \rho^{\prime} \circ \iota(\mathbf{U})\right)^{\perp} \cong$ $\iota(\mathbf{U})^{\perp} \cong W$.

By Lemma 2.2 we have $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=\left|\mathcal{E}_{X} / \operatorname{aut}(X)\right|$, from which we infer equation (4).
Proposition 2.7. Let $\pi: X \rightarrow \mathbb{P}^{1}$ be an elliptic fibration with fiber $E$ and section $O$. If $C_{1}, \ldots, C_{n}$ are the components of the reducible fibers not intersecting $O$, then there exist $n_{0}, m_{0}, \ldots, m_{n} \in \mathbb{Z}$ such that $D=n_{0} O+m_{0} E+\sum_{i=1}^{n} m_{i} C_{i}$ is an ample divisor.

Proof. For the sake of simplicity, we assume that there is only one reducible fiber, but the same argument works if there is more than one. Let $C_{0}$ be the rational fiber component with $O \cdot C_{0}=1$. The sublattice generated by $C_{1}, \ldots, C_{n}$ is of ADE type, so we can find $R:=\sum_{i=1}^{n} m_{i} C_{i}$ in the suitable Weyl chamber in such a way that

$$
R \cdot C_{i}>0 \quad \text { for each } i=1, \ldots n .
$$

Fix a positive $n_{0} \in \mathbb{Z}$ such that $n_{0}>-R \cdot C_{0}$. Since $E$ is linearly equivalent to a certain combination of $C_{0}, \ldots, C_{n}$ with positive coefficients, taking $m_{0}$ large enough we can suppose that $D=n_{0} O+m_{0} E+R$ is linearly equivalent to

$$
n_{0} O+m_{0} C_{0}+\sum m_{i}^{\prime} C_{i} \quad \text { with } m_{i}^{\prime}>0
$$

Let $C$ be a smooth rational curve on $X$. If $C \neq O$ and $C \neq C_{i}$ for each $i=0, \ldots, n$, then $D \cdot C>0$ because $C$ must intersect one of the components $C_{i}$.

If $C=C_{i}$ for some $i \in\{1, \ldots, n\}$, then

$$
D \cdot C=R \cdot C_{i}>0
$$

If $C=C_{0}$, then

$$
D \cdot C=n_{0}+R \cdot C_{0}>0
$$

If $C=O$, then

$$
D \cdot C=-2 n_{0}+m_{0}
$$

which is positive if $m_{0}$ is large enough. Finally, it holds

$$
D^{2}=-2 n_{0}^{2}+2 n_{0} m_{0}+R^{2}
$$

Therefore, if $m_{0}$ is large enough, then $D^{2}>0$ and $D \cdot C>0$ for every smooth rational curve on $X$, proving that $D$ is ample (cf. for instance [16, Ch. 8, Cor. 1.6]).
2.3. Statement and corollaries. The Hodge decomposition on $H^{2}(X, \mathbb{Z})$ induces a Hodge decomposition on the transcendental lattice $T_{X}$. The group of Hodge isometries of $T_{X}$ is denoted $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$. If $\sigma_{X}$ is a generator of the subspace $\mathrm{H}^{2,0}(X) \subset T_{X} \otimes \mathbb{C}$, we have

$$
\mathrm{O}_{\mathrm{h}}\left(T_{X}\right):=\left\{\eta \in \mathrm{O}\left(T_{X}\right) \mid \eta\left(\sigma_{X}\right) \in \mathbb{C} \sigma_{X}\right\}
$$

The image of the natural homomorphism

$$
\mathrm{O}_{\mathrm{h}}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)
$$

is denoted $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$. We are now able to state the main theorem, whose proof is contained in $\S 2.4$.
Theorem 2.8. Let $X$ be a complex projective $K 3$ surface with frame genus $\mathcal{W}_{X}$ (Definition 2.5). Then, the multiplicity of a frame $W \in \mathcal{W}_{X}$ is given by

$$
\left|\mathrm{fr}_{X}^{-1}(W)\right|=\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right) \backslash \mathrm{O}\left(T_{X}^{\sharp}\right) / \mathrm{O}^{\sharp}(W)\right| .
$$

Remark 2.9. By Definition 2.5 it holds $W^{\sharp} \cong S_{X}^{\sharp} \cong T_{X}(-1)^{\sharp}$ for each $W \in \mathcal{W}_{X}$, so the group $\mathrm{O}^{\sharp}(W)$ can be considered as a subgroup of $\mathrm{O}\left(T_{X}^{\sharp}\right)$ thanks to the (non-canonical) isomorphisms

$$
\mathrm{O}\left(W^{\sharp}\right) \cong \mathrm{O}\left(S_{X}^{\sharp}\right) \cong \mathrm{O}\left(T_{X}^{\sharp}\right)
$$

which we fix once and for all. The subgroup $\mathrm{O}^{\sharp}(W)$, therefore, is only well-defined up to conjugation. Still, the formula of Theorem 2.8 makes sense because the number of double cosets $|H \backslash G / K|$ for
any subgroups $H, K$ of a group $G$ only depends on the conjugacy class of $H$ and $K$. Indeed, we have the following formula due to Cauchy and Frobenius:

$$
\begin{equation*}
|H \backslash G / K|=\frac{1}{|H||K|} \sum_{(h, k) \in H \times K}|\{g \in G \mid h g k=g\}| \tag{5}
\end{equation*}
$$

The following corollary providing uniform bounds on the number of orbits $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|$ already appears in previous literature under various forms, cf. for instance [6, Prop. C'] and [25, Thm 3.10].
Corollary 2.10. It always holds

$$
\left|\mathcal{W}_{X}\right| \leq\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right| \leq\left|\mathcal{W}_{X}\right| \cdot\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right) \backslash \mathrm{O}\left(T_{X}^{\sharp}\right)\right|
$$

In particular, $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=\left|\mathcal{W}_{X}\right|$ when the map $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)$ is surjective.
Proof. The map $\mathrm{fr}_{X}$ is surjective by Corollary 2.6, hence $\left|\operatorname{fr}_{X}^{-1}(W)\right| \geq 1$ for each $W \in \mathcal{W}_{X}$. By (4),

$$
\left|\mathcal{W}_{X}\right| \leq \sum_{W \in \mathcal{W}_{X}}\left|\mathrm{fr}_{X}^{-1}(W)\right|=\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|
$$

proving the first inequality. Moreover, it holds trivially

$$
\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right) \backslash \mathrm{O}\left(T_{X}^{\sharp}\right) / \mathrm{O}^{\sharp}(W)\right| \leq\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right) \backslash \mathrm{O}\left(T_{X}^{\sharp}\right)\right| .
$$

By Theorem 2.8 and again equation (4) we obtain therefore

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=\sum_{W \in \mathcal{W}_{X}}\left|\mathrm{fr}_{X}^{-1}(W)\right| \leq \sum_{W \in \mathcal{W}_{X}}\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right) \backslash \mathrm{O}\left(T_{X}^{\sharp}\right)\right|=\left|\mathcal{W}_{X}\right| \cdot\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right) \backslash \mathrm{O}\left(T_{X}^{\sharp}\right)\right| .
$$

2.4. Proof of Theorem 2.8. Let $G:=\mathrm{O}\left(T_{X}^{\sharp}\right)$ and $H:=\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$. Fix a frame $W \in \mathcal{W}_{X}$ and a geometric embedding $\iota_{0} \in \operatorname{fr}_{X}^{-1}(W)$ (Definition 2.1), which exists by Corollary 2.6. Since $\mathbf{U}$ is unimodular, we have a decomposition

$$
S_{X} \cong \iota_{0}(\mathbf{U}) \oplus \iota_{0}(\mathbf{U})^{\perp} \cong \mathbf{U} \oplus W
$$

Consider the group $\mathrm{O}\left(S_{X}, \iota_{0}\right)$ of isometries $S_{X}$ preserving this decomposition:

$$
\mathrm{O}\left(S_{X}, \iota_{0}\right):=\left\{\gamma \in \mathrm{O}\left(S_{X}\right) \mid \gamma \circ \iota_{0}(\mathbf{U})=\iota_{0}(\mathbf{U})\right\}
$$

Let $K$ be the image of $\mathrm{O}\left(S_{X}, \iota_{0}\right)$ in $G$. Using the isomorphism $S_{X}^{\sharp} \cong \mathbf{U}^{\sharp} \oplus W^{\sharp} \cong W^{\sharp}$ induced by this decomposition, the subgroup $K$ can be identified with $\mathrm{O}^{\sharp}(W)$ (cf. Remark 2.9).

Recall that the Torelli theorem for K3 surfaces [36] asserts that

$$
\begin{equation*}
\operatorname{aut}(X)=\left\{\gamma \in \mathrm{O}\left(S_{X}\right) \mid \gamma \in \mathrm{O}\left(S_{X}, N_{X}\right) \text { and } \gamma^{\sharp} \in H\right\} \tag{6}
\end{equation*}
$$

We define a map

$$
\mathrm{dc}: \mathrm{fr}_{X}^{-1}(W) \rightarrow H \backslash G / K
$$

in the following way. Take a geometric embedding $\iota \in \operatorname{fr}_{X}^{-1}(W)$. Recalling that $S_{X}$ is unique in its genus by Lemma 2.3, we see that the embedding is unique up to isometries of $S_{X}$ thanks to Nikulin's [29, Prop. 1.15.1]. This means that there exists $\gamma \in \mathrm{O}\left(S_{X}\right)$ such that $\iota=\gamma \circ \iota_{0}$. Using the identification $\mathrm{O}\left(T_{X}^{\sharp}\right) \cong \mathrm{O}\left(S_{X}^{\sharp}\right)$, we set

$$
\operatorname{dc}(\iota):=H \gamma^{\sharp} K
$$

We claim that the map dc is well defined. Indeed, take two geometric embeddings $\iota_{1}, \iota_{2} \in \operatorname{fr}_{X}^{-1}(W)$ such that $\iota_{2}=\alpha \circ \iota_{1}$ for some $\alpha \in \operatorname{aut}(X)$. Let $\iota_{1}=\gamma_{1} \circ \iota_{0}$ and $\iota_{2}=\gamma_{2} \circ \iota_{0}$ for some $\gamma_{1}, \gamma_{2} \in \mathrm{O}\left(S_{X}\right)$. The isometry $\kappa:=\gamma_{1}^{-1} \circ \alpha^{-1} \circ \gamma_{2}$ belongs to $\mathrm{O}\left(S_{X}, \iota_{0}\right)$ because

$$
\kappa \circ \iota_{0}=\gamma_{1}^{-1} \circ \alpha^{-1} \circ\left(\gamma_{2} \circ \iota_{0}\right)=\gamma_{1}^{-1} \circ\left(\alpha^{-1} \circ \iota_{2}\right)=\gamma_{1}^{-1} \circ \iota_{1}=\iota_{0}
$$

In particular, it holds $\kappa^{\sharp} \in K$. Since $\gamma_{2}=\alpha \circ \gamma_{1} \circ \kappa$ and $\alpha^{\sharp} \in H$ by (6), the elements $\gamma_{1}^{\sharp}, \gamma_{2}^{\sharp} \in G$ belong to the same $(H, K)$-double coset.

Next we claim that the map dc is injective. Indeed, take two geometric embeddings $\iota_{1}=\gamma_{1} \circ \iota_{0}$, $\iota_{2}=\gamma_{2} \circ \iota_{0}$, with $\gamma_{1}, \gamma_{2} \in \mathrm{O}\left(S_{X}\right)$, such that $\gamma_{1}^{\sharp}, \gamma_{2}^{\sharp}$ belong to the same $(H, K)$-double coset. By definition of $H$ and $K$, this means that there exist $\eta \in \mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$ and $\kappa \in \mathrm{O}\left(S_{X}, \iota_{0}\right)$ such that $\gamma_{2}^{\sharp}=\eta^{\sharp} \gamma_{1}^{\sharp} \kappa^{\sharp}$. We need to show that there exists $\alpha \in \operatorname{aut}(X)$ such that $\iota_{2}=\alpha \circ \iota_{1}$.

We define $\alpha_{U}:=\gamma_{2} \circ \gamma_{1}^{-1}$ on $\iota_{1}(\mathbf{U})$ and $\alpha_{W}:=\gamma_{2} \circ \kappa^{-1} \circ \gamma_{1}^{-1}$ on $\iota_{1}(\mathbf{U})^{\perp}$. As $\mathbf{U}$ is unimodular, $\alpha_{U}$ and $\alpha_{W}$ glue well together on $\iota_{1}(\mathbf{U}) \oplus \iota_{1}(\mathbf{U})^{\perp} \cong S_{X}$, defining an element $\alpha \in \mathrm{O}\left(S_{X}\right)$. From the definition, it immediately follows that

$$
\iota_{2}=\gamma_{2} \circ \iota_{0}=\alpha \circ \gamma_{1} \circ \iota_{0}=\alpha \circ \iota_{1} \quad \text { and } \quad \alpha^{\sharp}=\left(\gamma_{2} \circ \kappa^{-1} \circ \gamma_{1}^{-1}\right)^{\sharp}=\eta^{\sharp} \in H .
$$

For $i=1,2$ consider the fibrations $\pi_{i}: X \rightarrow \mathbb{P}^{1}$ corresponding to $\iota_{i}$. Write $E_{i}:=\iota_{i}(e), O_{i}:=$ $\iota_{i}(f-e)$ and let $C_{i 1}, \ldots, C_{i n}$ be the irreducible components of the reducible fibers of $\pi_{i}$. Thanks to Proposition 2.7 we know that there exist $n_{0}, m_{0}, \ldots, m_{n}$ such that $D=n_{0} O_{1}+m_{0} E_{1}+\sum_{i=1}^{n} m_{i} C_{1 i}$ is an ample divisor. Set

$$
R:=\alpha(D)-n_{0} O_{2}-m_{0} E_{2}=\sum_{i=1}^{n} m_{i} \alpha\left(C_{1 i}\right)
$$

As each $\alpha\left(C_{1 i}\right)$ is a vector of square -2 in $\iota_{2}(\mathbf{U})^{\perp}$, there exist $m_{1}^{\prime}, \ldots, m_{n}^{\prime} \in \mathbb{Z}$ such that

$$
R=\sum_{i=1}^{n} m_{i}^{\prime} C_{2 i}
$$

Since the Weyl group of the ADE lattices acts transitively on the Weyl chambers (see for instance [11]), we can find $\rho \in \mathrm{W}\left(\left(\iota_{2}(\mathbf{U})^{\perp}\right)_{\text {root }}\right)$ such that $\rho(R) \cdot C_{2 i}>0$ for every $i=1, \ldots, n$. As $\rho$ acts trivially on the discriminant group of $\left(\iota_{2}(\mathbf{U})^{\perp}\right)_{\text {root }}$, we can extend it to an isometry $\tilde{\rho} \in \mathrm{O}\left(\iota_{2}(\mathbf{U})^{\perp}\right)$ with $\tilde{\rho}^{\sharp}=1$. Therefore, up to substituting $\alpha$ with $\tilde{\rho} \circ \alpha$, we can suppose that $\alpha(D)$ is an ample divisor by the same arguments as in Proposition 2.7. In this way, $\alpha$ sends an ample divisor to an ample divisor, so $\alpha \in \mathrm{O}\left(S_{X}, N_{X}\right)$ because the ample cone is the interior of $N_{X}$ (see for instance [16, Ch. 8, Cor. 1.4]). The Torelli Theorem (6) implies that $\alpha \in \operatorname{aut}(X)$, as wished.

Finally, we claim that the map dc is surjective. Indeed, for every double coset $H g K, g \in G$, we can assume that $g=\gamma^{\sharp}$ for some $\gamma \in \mathrm{O}\left(S_{X}, N_{X}\right)$ thanks to Lemma 2.3. As $\iota_{0}(e) \in N_{X}$, it follows that $\gamma \circ \iota_{0}(e)$ is a primitive nef class of square 0 , hence $\gamma \circ \iota_{0}(e)$ is the class of some elliptic curve $E$. The class $D=\gamma \circ \iota_{0}(f-e)$ then satisfies the assumptions of Proposition 2.4. Therefore, there exists $\rho \in \mathrm{W}\left(S_{X}\right)$ and a section $O$ such that $\rho(D)=O$, which means that the embedding $\iota=\rho \circ \gamma \circ \iota_{0}$ is geometric and satisfies

$$
\operatorname{dc}(\iota)=H(\rho \circ \gamma)^{\sharp} K=H \gamma^{\sharp} K=H g K .
$$

Therefore, the map dc is a bijection and the theorem follows.
2.5. Guidelines. We now would like to explain how to compute $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|$ in explicit cases. According to Theorem 2.8, the first ingredient to be computed is the image $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ of the natural homomorphism $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)$. The following proposition summarizes the main properties of the group $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$.
Proposition 2.11 (see [28, Thm. 3.1] or [14, Prop. B.1]). If $T_{X}$ is the transcendental lattice of a projective K3 surface $X$, then the group $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$ is a finite cyclic group of even order containing -id such that

$$
\varphi\left(\left|\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)\right|\right) \mid \operatorname{rk}\left(T_{X}\right)
$$

where $\varphi$ denotes Euler's totient function. The action of $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$ on $\mathbb{C} \sigma_{X}$ is faithful.
The last assertion means that if $\gamma \in \mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$ has order $m$, then $\gamma\left(\sigma_{X}\right)=\zeta_{m} \sigma_{X}$, where $\zeta_{m}$ is a primitive $m$ th root of unity.
Remark 2.12. If $\operatorname{rk}\left(T_{X}\right)$ is odd, Proposition 2.11 implies that $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)=\{ \pm \mathrm{id}\}$. Therefore, $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)=\{ \pm \mathrm{id}\}$. The subgroup $\mathrm{O}^{\sharp}(W)$ always contains $\{ \pm \mathrm{id}\}$, so by Theorem 2.8 we have

$$
\left|\mathrm{fr}_{X}^{-1}(W)\right|=\left|\mathrm{O}\left(T_{X}^{\sharp}\right) / \mathrm{O}^{\sharp}(W)\right|=\left|\mathrm{O}\left(T_{X}^{\sharp}\right)\right| /\left|\mathrm{O}^{\sharp}(W)\right|
$$

for every $W \in \mathcal{W}_{X}$.
A direct consequence of Proposition 2.11 is that the image subgroup $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ is also a finite cyclic subgroup. In all explicit examples we will be interested in determining the conjugacy class of one of its generators. Clearly, the order of a generator depends on the size of the kernel of the map $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)$. The following lemma was already stated without proof in [44, Rmk. 2.13].

Lemma 2.13. The kernel of the map $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)$ is isomorphic to the kernel of the map $\operatorname{Aut}(X) \rightarrow \mathrm{O}\left(S_{X}\right)$.

Proof. Indeed, every element in the kernel of $\operatorname{Aut}(X) \rightarrow \mathrm{O}\left(S_{X}\right)$ induces a Hodge isometry of $T_{X}$ acting trivially on $S_{X}^{\sharp} \cong T_{X}^{\sharp}$ and, conversely, every element in the kernel of $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)$ can be extended to a Hodge isometry $\gamma$ of $\mathrm{H}^{2}(X, \mathbb{Z})$ by the identity on $S_{X}$. As $\gamma$ obviously acts trivially on the nef cone, $\gamma$ is the pullback of an automorphism of $X$ by the Torelli Thm. (6).

Lemma 2.13 will prove very useful, as the classification of the possible kernels of the map $\operatorname{Aut}(X) \rightarrow \mathrm{O}\left(S_{X}\right)$ was started by Vorontsov [49], followed by Kondō [21], Oguiso and Zhang [33], Schütt [40] and finally completed by Taki [48].

The second and last ingredient to be computed is a list of the groups $\mathrm{O}^{\sharp}(W)$ for $W \in \mathcal{W}_{X}$. Therefore, one first needs to determine the genus $\mathcal{W}_{X}$.

Nishiyama introduced a method to compute $\mathcal{W}_{X}$ using a negative definite lattice $T_{0}$ such that

$$
\operatorname{rk}\left(T_{0}\right)=\operatorname{rk}\left(T_{X}\right)+4 \quad \text { and } \quad T_{0}^{\sharp} \cong T_{X}^{\sharp} .
$$

The method is usually known as the "Kneser-Nishiyama method" and consists in finding all primitive embeddings of $T_{0}$ up to isometries into the 24 Niemeier lattices $N$. The orthogonal complements $W=T_{0}^{\perp} \subset N$ run over all $W \in \mathcal{W}_{X}$ by [29, Prop. 1.15.1]. We refer to the original paper by Nishiyama [31] and to the surveys by Schütt and Shioda [41], [42, §12.3] for further details.

Still, since we are interested in obtaining an explicit Gram matrix of each frame $W \in \mathcal{W}_{X}$, we point out the following algorithm. Let $N$ be a Niemeier lattice such that there exists a primitive embedding $T_{0} \hookrightarrow N_{\text {root }}$.

- Let the primitive embedding $T_{0} \hookrightarrow N_{\text {root }}$ be given by a matrix $D$.
- Find the isotropic subgroup $H \subset N_{\text {root }}^{\sharp}$ corresponding to $N_{\text {root }} \hookrightarrow N$ (cf. [29, Prop. 1.4.1]).
- Starting from $H$, find a matrix $C$ with rational coefficients such that $N=C N_{\text {root }} C^{\top}$.
- The embedding $T_{0} \hookrightarrow N$ is then given by the matrix $D C^{-1}$.
- In this way we can compute the Gram matrix $W$ of the orthogonal complement of $T_{0}$ in $N$, using for instance the command orthogonal_complement of the class IntegralLattice in Sage.
Once a Gram matrix is given, efficient methods to find a set of generators of $\mathrm{O}(W)$ are well known (see for instance the work by Plesken and Souvignier [37]). It is then elementary to compute the image group $\mathrm{O}^{\sharp}(W)$.

Remark 2.14. Another efficient method to compute a genus is Kneser's neighbor method. It has been implemented in several computer algebra systems (for instance, in the Magma function GenusRepresentatives), see the work by Scharlau and Hemkemeier [39].
Remark 2.15. The order $|\mathrm{O}(W)|$ and the mass of $\mathcal{W}_{X}$ (for the definition of mass see the work by Conway and Sloane [8]) can be efficiently computed using the commands number_of_automorphisms and conway_mass of the QuadraticForm class in Sage. Once a list of lattices $W \in \mathcal{W}_{X}$ is obtained, one can verify a posteriori that the Smith-Minkowski-Siegel mass formula holds in order to check that the list is complete.

## 3. Examples

In this section we show how to apply Theorem 2.8 in order to compute $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|$ in various explicit examples. We first consider K3 surfaces with transcendental lattice $T_{X} \cong \mathbf{U}(2)^{2}$ in §3.1, then with $T_{X} \cong \mathbf{U}(2)^{2}$ in $\S 3.2$, with $T_{X} \cong \mathbf{U}(2)^{2} \oplus[-4]$ in $\S 3.3$, with $T_{X} \cong \mathbf{U}(2)^{2} \oplus[-2]^{2}$ in $\S 3.4$ and finally with $T_{X} \cong \mathbf{U} \oplus[12]$ in $\S 3.5$.
3.1. Barth-Peters family. Let $X$ be a K3 surface with transcendental lattice

$$
T_{X} \cong \mathbf{U} \oplus \mathbf{U}(2)
$$

Remark 3.1. The surface $X$ is the generic element of a 2-dimensional family introduced by Barth and Peters [1] in order to construct Enriques surfaces with an involution acting trivially on cohomology. Elliptic fibrations on this family were also studied by Hulek and Schütt [15].

Lemma 3.2. It holds $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)=\{\mathrm{id}\}$.
Proof. We choose a basis $t_{1}, \ldots, t_{4} \in T_{X}$ so that the corresponding Gram matrix is

$$
T=\left(\begin{array}{cccc}
0 & 1 & 0 & 0 \\
1 & 0 & 0 & 0 \\
0 & 0 & 0 & 2 \\
0 & 0 & 2 & 0
\end{array}\right)
$$

The discriminant group $T_{X}^{\sharp}$ is generated by the classes of $\frac{1}{2} t_{3}$ and $\frac{1}{2} t_{4}$. The involution exchanging these two classes generates the group $\mathrm{O}\left(T_{X}^{\sharp}\right)$.

By [28, Theorem 3.1] or [14, Proposition B.1], it holds $\varphi\left(\left|\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)\right|\right) \mid \operatorname{rk}\left(T_{X}\right)=4$, therefore $\left|\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)\right| \in\{2,4,6,8,10,12\}$. Since $\left|\mathrm{O}\left(T_{X}^{\sharp}\right)\right|=2$, we only need to check that any isometry $\eta \in$ $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$ of order $2^{k}, k>0$, acts trivially on $T_{X}^{\sharp}$.

If $\eta$ has order 2 , then $\eta=-\mathrm{id}$ by [14, Proposition B.1], so $\eta^{\sharp}=\mathrm{id}$. Moreover, by Lemma 2.13 and Taki's [48, Main theorem on page 18], $\eta$ cannot have order 8 .

Hence, suppose that $\eta$ has order 4 . We can assume that $\eta$ is represented by a matrix $A$ with $A T A^{\top}=T$ and $A^{2}=-I$, such that the generator $\sigma=\sigma_{X}$ of the subspace $\mathrm{H}^{2,0}(X) \subset T_{X} \otimes \mathbb{C}$ is contained in the 2-dimensional, totally isotropic eigenspace $V \subset T_{X} \otimes \mathbb{C}$ associated with $\mathrm{i}=\sqrt{-1}$. Let $\tau \in V$ be linearly independent from $\sigma$ and let us write

$$
\begin{aligned}
\sigma & =\sigma_{1} t_{1}+\sigma_{2} t_{2}+\sigma_{3} t_{3}+\sigma_{4} t_{4}, \quad \sigma_{i} \in \mathbb{C} \\
\tau & =\tau_{1} t_{1}+\tau_{2} t_{2}+\tau_{3} t_{3}+\tau_{4} t_{4} \in V, \quad \tau_{i} \in \mathbb{C}
\end{aligned}
$$

It holds $\sigma_{1} \neq 0$, otherwise $t_{2} \in T_{X}^{\perp}$, so we can rescale $\sigma_{1}=1$. Up to substituting $\tau$ with a linear combination of $\sigma$ and $\tau$ we can suppose $\tau_{1}=0$. In addition, using the relations $\sigma^{2}=\tau^{2}=\sigma \cdot \tau=0$, up to substituting $t_{3}$ with $t_{4}$ we can assume that

$$
\sigma_{2}=-2 \sigma_{3} \sigma_{4}, \quad \tau_{2}=-2 \sigma_{3} \tau_{4}, \quad \tau_{3}=0, \quad \tau_{4}=1
$$

Note that $\Im\left(\sigma_{3}\right) \neq 0$ because $\sigma \cdot \bar{\sigma}>0$. Imposing that $\sigma, \tau \in V$ and $\bar{\sigma}, \bar{\tau} \in \bar{V}$, we infer that there exist $m_{1}, m_{2} \in \mathbb{Z}$ such that

$$
A=\left(\begin{array}{cccc}
m_{1} & 0 & \left(m_{1}^{2}+1\right) /\left(2 m_{2}\right) & 0 \\
0 & -m_{1} & 0 & m_{2} \\
-2 m_{2} & 0 & -m_{1} & 0 \\
0 & -\left(m_{1}^{2}+1\right) / m_{2} & 0 & m_{1}
\end{array}\right), \quad m_{1}=-\frac{\Re\left(\sigma_{3}\right)}{\Im\left(\sigma_{3}\right)}, \quad m_{2}=-\frac{1}{2 \Im\left(\sigma_{3}\right)} .
$$

Therefore, $A$ acts trivially on the classes of $\frac{1}{2} t_{3}$ and $\frac{1}{2} t_{4}$, so $\eta^{\sharp}=\mathrm{id}$.
Proposition 3.3. The frame genus $\mathcal{W}_{X}$ contains exactly 6 isomorphism classes, listed in Table 1, whose Gram matrices are contained in the arXiv ancillary file genus_Barth_Peters.sage.

Proof. We computed the frame genus $\mathcal{W}_{X}$ using the command GenusRepresentatives in Magma (Remark 2.14). Alternatively, one could have applied the Kneser-Nishiyama method with $T_{0}=\mathbf{D}_{8}$. The list is complete because the mass formula holds

$$
\sum_{i=1}^{6} \frac{1}{\left|\mathrm{O}\left(W_{i}\right)\right|}=\frac{505121}{12340763622899712000}=\operatorname{mass}\left(\mathcal{W}_{X}\right)
$$

Theorem 3.4. If $X$ is a K3 surface with transcendental lattice $T_{X} \cong \mathbf{U} \oplus \mathbf{U}(2)$, then

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=7
$$

Proof. By Lemma 3.2, the subgroup $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ is trivial, so by Theorem 2.8 the multiplicity of a frame $W \in \mathcal{W}_{X}$ is equal to the index of $\mathrm{O}^{\sharp}(W)$ in $\mathrm{O}\left(T_{X}^{\sharp}\right)$. A finite set of generators of $\mathrm{O}(W)$ can be computed with the command orthogonal_group of the Sage class QuadraticForm. Their images generate the subgroups $\mathrm{O}^{\sharp}(W)$.
3.2. Kummer surfaces associated to a product of elliptic curves. Let now $X$ denote a K3 surface with transcendental lattice

$$
T_{X} \cong \mathbf{U}(2)^{2}
$$

Remark 3.5. By results of Nikulin [27, Rmk. 2] and Morrison [26, Prop. 4.3(i)], $X$ is the Kummer surface associated to an abelian surface $A$ with transcendental lattice $T_{A} \cong \mathbf{U}^{2}$. Consequently, the Néron-Severi lattice of $A$ is isomorphic to $\mathbf{U}$, so $A$ is isomorphic to the product of two nonisogenous elliptic curves, according to Ruppert's criterion [38]. Therefore, the number of orbits $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|$ has already been computed geometrically by Oguiso [32]. Here we verify his results using our algebraic approach.

Table 1. Lattices in the frame genus $\mathcal{W}_{X}$ of a K 3 surface $X$ with transcendental lattice $T_{X} \cong \mathbf{U} \oplus \mathbf{U}(2)$.

We fix a basis $t_{1}, \ldots, t_{4} \in T_{X}$ so that the corresponding Gram matrix is

$$
T:=\left(\begin{array}{llll}
0 & 2 & 0 & 0 \\
2 & 0 & 0 & 0 \\
0 & 0 & 0 & 2 \\
0 & 0 & 2 & 0
\end{array}\right)
$$

We make the following identification:

$$
\begin{equation*}
\mathrm{O}\left(T_{X}\right) \cong\left\{A \in \mathrm{GL}_{4}(\mathbb{Z}) \mid A T A^{\top}=T\right\} \tag{7}
\end{equation*}
$$

The classes modulo $T_{X}$ of $\frac{1}{2} t_{1}, \ldots, \frac{1}{2} t_{4}$ form a basis over $\mathbb{F}_{2}$ for $T_{X}^{\sharp}$. A computation shows that the group $\mathrm{O}\left(T_{X}^{\sharp}\right)$ contains 72 elements and can be identified with the following subgroup of $\mathrm{GL}_{4}\left(\mathbb{F}_{2}\right)$ :

$$
\mathrm{O}\left(T_{X}^{\sharp}\right) \cong\left\langle\left(\begin{array}{llll}
1 & 0 & 0 & 0  \tag{8}\\
0 & 1 & 0 & 0 \\
0 & 0 & 0 & 1 \\
0 & 0 & 1 & 0
\end{array}\right),\left(\begin{array}{llll}
0 & 1 & 0 & 1 \\
1 & 0 & 0 & 0 \\
0 & 0 & 0 & 1 \\
1 & 0 & 1 & 0
\end{array}\right)\right\rangle
$$

Under identifications (7) and (8), the natural homomorphism $\mathrm{O}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)$ is given by $A \mapsto(A \bmod 2)$. We now consider its restriction to the subgroup of Hodge isometries $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$.
Lemma 3.6. The kernel of $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)$ is equal to $\{ \pm \mathrm{id}\}$.
Proof. Clearly, $\{ \pm \mathrm{id}\}$ is contained in the kernel. By Lemma 2.13 and [21, Thm. 6.1], it suffices to show that there is no automorphism of $X$ of order 4 acting trivially on $S_{X}$. This follows from [40, Thm. 1].

A computation with the GAP command ConjugacyClasses shows that the group $\mathrm{O}\left(T_{X}^{\sharp}\right)$ contains exactly 9 conjugacy classes. Let us define the following elements of $\mathrm{O}\left(T_{X}^{\sharp}\right)$ :

$$
h_{1}:=\left(\begin{array}{llll}
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 \\
0 & 0 & 1 & 0 \\
0 & 0 & 0 & 1
\end{array}\right), \quad h_{2}:=\left(\begin{array}{cccc}
0 & 0 & 1 & 0 \\
0 & 0 & 0 & 1 \\
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0
\end{array}\right), \quad h_{3}:=\left(\begin{array}{cccc}
0 & 0 & 1 & 0 \\
0 & 1 & 0 & 1 \\
1 & 0 & 1 & 0 \\
0 & 1 & 0 & 0
\end{array}\right), \quad h_{6}:=\left(\begin{array}{llll}
0 & 0 & 0 & 1 \\
1 & 1 & 1 & 1 \\
0 & 1 & 0 & 1 \\
1 & 0 & 0 & 1
\end{array}\right) .
$$

Lemma 3.7. An element $h \in \mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ of order 2 belongs to the conjugacy class of $h_{2}$.
Proof. By Proposition 2.11 and Lemma 3.6 we can suppose that $h$ is the image of an element $\eta \in \mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$ represented by a matrix $A \in \mathrm{GL}_{4}(\mathbb{Z})$ of order 4 such that

$$
A T A^{\top}=T, \quad A^{2}=-I
$$

Since $A$ has finite order, it is diagonalizable over $\mathbb{C}$ with eigenvalues $\mathrm{i}=\sqrt{-1}$ and -i .
Let $V \subset T_{X} \otimes \mathbb{C}$ be the eigenspace of $A$ associated with i. Then $V$ has dimension 2 and its complex conjugate $\bar{V}$ is the eigenspace of $A$ associated with -i . As $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$ acts faithfully on $\mathbb{C} \sigma_{X}$, we can assume that $\sigma:=\sigma_{X} \in V$. Let us write

$$
\sigma=\sigma_{1} t_{1}+\sigma_{2} t_{2}+\sigma_{3} t_{3}+\sigma_{4} t_{4}, \quad \sigma_{i} \in \mathbb{C}
$$

Certainly $\sigma_{1} \neq 0$ otherwise $t_{2} \in \sigma_{X}^{\perp}=S_{X}$, so we are free to rescale $\sigma_{1}=1$. Moreover, from the relations $\sigma^{2}=0$ and $\sigma \cdot \bar{\sigma}>0$ we obtain

$$
2\left(\sigma_{1} \sigma_{2}+\sigma_{3} \sigma_{4}\right)=0, \quad \sigma_{1} \bar{\sigma}_{2}+\sigma_{2} \bar{\sigma}_{1}+\sigma_{3} \bar{\sigma}_{4}+\sigma_{4} \bar{\sigma}_{3}>0
$$

substituting $\sigma_{1}=1$ and $\sigma_{2}=-\sigma_{3} \sigma_{4}$ we get $\Im\left(\sigma_{3}\right) \Im\left(\sigma_{4}\right)>0$ (in particular, $\Im\left(\sigma_{3}\right) \neq 0$ ).
Let

$$
\tau=\tau_{1} t_{1}+\tau_{2} t_{2}+\tau_{3} t_{3}+\tau_{4} t_{4} \in V, \quad \tau_{i} \in \mathbb{C}
$$

be an eigenvector of $A$ linearly independent from $\sigma$. Without loss of generality, we can substitute $\tau$ with a linear combination of $\sigma$ and $\tau$ and suppose that $\tau_{1}=0$

Note that $V$ is a totally isotropic subspace of $T_{X} \otimes \mathbb{C}$, as

$$
x \cdot y=\eta(x) \cdot \eta(y)=(\mathrm{i} x) \cdot(\mathrm{i} y)=-x \cdot y, \quad \text { for all } x, y \in V
$$

From $\tau^{2}=0$ it follows that $2 \tau_{3} \tau_{4}=0$. Up to exchanging $t_{3}$ with $t_{4}$ we can suppose that $\tau_{3}=0$. From the relation $\sigma \cdot \tau=0$ we obtain $\tau_{2}=-\sigma_{3} \tau_{4}$. Again without loss of generality, we can rescale $\tau_{4}=1$.

Imposing that $\sigma, \tau \in V$ and $\bar{\sigma}, \bar{\tau} \in \bar{V}$ and recalling that $A$ has integer coefficients, we infer with elementary but rather tedious computations that there exist $m_{1}, m_{2} \in \mathbb{Z}$ such that

$$
A=\left(\begin{array}{cccc}
m_{1} & 0 & -\left(m_{1}^{2}+1\right) / m_{2} & 0 \\
0 & -m_{1} & 0 & -m_{2} \\
m_{2} & 0 & -m_{1} & 0 \\
0 & \left(m_{1}^{2}+1\right) / m_{2} & 0 & m_{1}
\end{array}\right), \quad m_{1}:=-\frac{\Re\left(\sigma_{3}\right)}{\Im\left(\sigma_{3}\right)}, \quad m_{2}:=\frac{1}{\Im\left(\sigma_{3}\right)} .
$$

Note that $m_{1}, m_{2}$ cannot be both even because $h=(A \bmod 2)$ is an invertible matrix. Looking at the possible parities of $m_{1}, m_{2}$, we see that $h$ is equal to one of the following elements:

$$
h_{2}:=\left(\begin{array}{llll}
0 & 0 & 1 & 0 \\
0 & 0 & 0 & 1 \\
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0
\end{array}\right), \quad\left(\begin{array}{llll}
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 1 \\
1 & 0 & 1 & 0 \\
0 & 0 & 0 & 1
\end{array}\right), \quad\left(\begin{array}{llll}
1 & 0 & 1 & 0 \\
0 & 1 & 0 & 0 \\
0 & 0 & 1 & 0 \\
0 & 1 & 0 & 1
\end{array}\right),
$$

which all belong to the same conjugacy class.
Lemma 3.8. An element $h \in \mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ of order 3 belongs to the conjugacy class of $h_{3}$.
Proof. By Lemma 3.6, we can suppose that $h$ is the image of an element in $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)$ represented by a matrix $A \in \mathrm{GL}_{4}(\mathbb{Z})$ such that

$$
A T A^{\top}=T, \quad A^{3}=I
$$

Since $A$ has finite order 3 , it is diagonalizable over $\mathbb{C}$ with eigenvalues $1, \omega, \bar{\omega}$, where $\omega$ denotes a third root of unity. Let $\zeta$ be a primitve 12 th root of unity such that $\zeta^{4}=\omega$ and $\zeta^{3}=\mathrm{i}$.

Let $W \subset T_{X} \otimes \mathbb{C}$ be the eigenspace of $A$ associated with $\omega$. We can suppose that $\sigma:=\sigma_{X} \in W$. We must differentiate two cases: either $\operatorname{dim}(W)=1$ or $\operatorname{dim}(W)=2$.

Suppose first that $\operatorname{dim}(W)=2$, let $\tau \in W$ be linearly independent from $\sigma$. Without loss of generality we can suppose as in the proof Lemma 3.7 that $\sigma_{1}=1, \sigma_{2}=-\sigma_{3} \sigma_{4}, \tau_{1}=\tau_{3}=0$, $\tau_{2}=-\sigma_{3} \tau_{4}, \tau_{4}=1$.

Imposing that $\sigma, \tau \in W$ and $\bar{\sigma}, \bar{\tau} \in \bar{W}$ we find (again after some tedious computations) that

$$
A=\left(\begin{array}{cccc}
m_{1} & 0 & -\left(m_{1}^{2}+m_{1}+1\right) / m_{2} & 0 \\
0 & -m_{1}-1 & 0 & -m_{2} \\
m_{2} & 0 & -m_{1}-1 & 0 \\
0 & \left(m_{1}^{2}+m_{1}+1\right) / m_{2} & 0 & m_{1}
\end{array}\right),
$$

where

$$
m_{1}:=\frac{\left(\zeta^{3}-2 \zeta\right) \Re\left(\sigma_{3}\right)-4 \Im\left(\sigma_{3}\right)}{4 \Im\left(\sigma_{3}\right)}, \quad m_{2}:=\frac{2 \zeta-\zeta^{3}}{2 \Im\left(\sigma_{3}\right)}
$$

Looking at the possible parities of $m_{1}, m_{2}$, we see that $h$ is equal to one of the following elements:

$$
h_{3}:=\left(\begin{array}{llll}
0 & 0 & 1 & 0 \\
0 & 1 & 0 & 1 \\
1 & 0 & 1 & 0 \\
0 & 1 & 0 & 0
\end{array}\right), \quad\left(\begin{array}{llll}
1 & 0 & 1 & 0 \\
0 & 0 & 0 & 1 \\
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 1
\end{array}\right)
$$

which are conjugate to each other.
In the case that $\operatorname{dim}(W)=1$ we can assume that $W$ is generated by $\sigma$ and that the eigenspace $U$ associated with 1 is generated by $\tau$ and $v$. We note that $W$ and $U$ are orthogonal to each other, as

$$
w \cdot u=\eta(w) \cdot \eta(u)=\omega w \cdot u, \quad \text { for all } u \in U, w \in W
$$

(Note, though, that $U$ is not necessarily a totally isotropic subspace.) With similar computations we see that the matrix $A$ is forced to have non-integral coefficients. Thus, this case is impossible.

Lemma 3.9. The group $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ contains no element of order 4.
Proof. By inspection of the conjugacy classes of $\mathrm{O}\left(T_{X}^{\sharp}\right)$, we see that there is only one class containing elements of order 4, namely the class of

$$
h_{4}:=\left(\begin{array}{llll}
0 & 0 & 0 & 1 \\
0 & 0 & 1 & 0 \\
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0
\end{array}\right)
$$

We see, though, that $h_{4}^{2}$ is not conjugate to $h_{2}$, so we conclude by Lemma 3.7.
Proposition 3.10. The subgroup $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ is a cyclic group of order $1,2,3$ or 6 , in which case it is generated by a conjugate of $h_{1}, h_{2}, h_{3}$ or $h_{6}$, respectively.

Proof. Let $h$ be a generator of $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ and let $m$ be its order.
By Proposition 2.11 it holds $\varphi\left(\left|\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)\right|\right) \mid \operatorname{rk}\left(T_{X}\right)=4$, therefore $\left|\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)\right| \in\{2,4,6,8,10,12\}$. It follows from Lemma 3.6 that $m=\left|\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)\right| / 2 \in\{1,2,3,4,5,6\}$.

We can exclude $m=5$ because $5 \nmid\left|\mathrm{O}\left(T_{X}^{\sharp}\right)\right|=72$ and we can exclude $m=4$ because of Lemma 3.9. All in all, $m \in\{1,2,3,6\}$ as claimed.

If $m=1$, then obviously $h=h_{1}$. If $m=2$, then $h$ is conjugate to $h_{2}$ by Lemma 3.7. If $m=3$, then $h$ is conjugate to $h_{3}$ by Lemma 3.8. Finally, if $m=6$, then by inspection of the conjugacy classes we see that $h$ is conjugate to either $h_{6}$ or

$$
h_{6}^{\prime}:=\left(\begin{array}{cccc}
0 & 0 & 0 & 1 \\
0 & 1 & 1 & 0 \\
1 & 0 & 0 & 1 \\
0 & 1 & 0 & 0
\end{array}\right)
$$

Thanks to Lemma 3.7, we can exclude $h_{6}^{\prime}$, because $\left(h_{6}^{\prime}\right)^{3}$ is not conjugate to $h_{2}$.
Proposition 3.11. The frame genus $\mathcal{W}_{X}$ contains exactly 11 isomorphism classes, listed in Table 2, whose Gram matrices are contained in the arXiv ancillary file genus_Oguiso.sage.

Proof. We apply the Kneser-Nishiyama method with $T_{0}=\mathbf{D}_{4}^{2}$. Thanks to [31, Lemma 41(i) and Corollary 4.6(i)] we find exatly 10 Niemeier lattices $N$ such that there exists a primitive embedding $T_{0} \hookrightarrow N_{\text {root }}$. All primitive embeddings are unique, except when $N_{\text {root }}=\mathbf{D}_{10} \mathbf{E}_{7}^{2}$, in which case there are two primitive embeddings (corresponding to $W_{5}$ and $W_{8}$ in Table 2). Therefore, we obtain 11 different frames: $\mathcal{W}_{X}=\left\{W_{1}, \ldots, W_{11}\right\}$. The list is complete because the mass formula holds (see Remark 2.15):

$$
\sum_{i=1}^{11} \frac{1}{\left|\mathrm{O}\left(W_{i}\right)\right|}=\frac{64150367}{1708721117016883200}=\operatorname{mass}\left(\mathcal{W}_{X}\right)
$$

We introduce the following subgroups of $G$ :

$$
\begin{aligned}
K_{8} & :=\left\langle\left(\begin{array}{llll}
1 & 0 & 0 & 1 \\
0 & 1 & 0 & 0 \\
0 & 1 & 1 & 0 \\
0 & 0 & 0 & 1
\end{array}\right),\left(\begin{array}{llll}
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 \\
0 & 0 & 0 & 1 \\
0 & 0 & 1 & 0
\end{array}\right)\right\rangle, \\
K_{12} & :=\left\langle\left(\begin{array}{llll}
1 & 1 & 1 & 1 \\
1 & 0 & 0 & 0 \\
1 & 0 & 0 & 1 \\
1 & 0 & 1 & 0
\end{array}\right),\left(\begin{array}{llll}
1 & 0 & 0 & 0 \\
1 & 1 & 1 & 1 \\
1 & 0 & 0 & 1 \\
1 & 0 & 1 & 0
\end{array}\right),\left(\begin{array}{llll}
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 \\
0 & 0 & 0 & 1 \\
0 & 0 & 1 & 0
\end{array}\right)\right\rangle, \\
K_{36} & :=\left\langle\left(\begin{array}{llll}
1 & 0 & 0 & 0 \\
1 & 1 & 1 & 1 \\
1 & 0 & 1 & 0 \\
1 & 0 & 0 & 1
\end{array}\right),\left(\begin{array}{llll}
0 & 1 & 1 & 0 \\
0 & 0 & 0 & 1 \\
1 & 0 & 0 & 1 \\
0 & 1 & 0 & 0
\end{array}\right),\left(\begin{array}{llll}
1 & 0 & 0 & 1 \\
0 & 1 & 0 & 0 \\
0 & 1 & 1 & 0 \\
0 & 0 & 0 & 1
\end{array}\right)\right\rangle .
\end{aligned}
$$

The subgroups $K_{8}, K_{12}, K_{36}$ contain respectively $8,12,36$ elements. Note that neither $K_{8}$ nor $K_{12}$ are normal subgroups of $G$, but $K_{36}$ is, as it has index 2 .
Proposition 3.12. The subgroup $\mathrm{O}^{\sharp}(W) \subset \mathrm{O}\left(T_{X}^{\sharp}\right)$ is conjugate to $K_{8}$ if $W \in\left\{W_{1}, W_{6}, W_{7}, W_{11}\right\}$, to $K_{12}$ if $W \in\left\{W_{2}, W_{8}, W_{10}\right\}$, to $K_{36}$ if $W=W_{4}$, and to $G$ if $W \in\left\{W_{3}, W_{5}, W_{9}\right\}$.
Proof. A finite set of generators of $\mathrm{O}(W)$ can be computed with the command orthogonal_group of the Sage class QuadraticForm. Their images generate the subgroups $\mathrm{O}^{\sharp}(W)$.

We now have all ingredients to compute the multiplicities of the frames $W \in \mathcal{W}_{X}$.
Theorem 3.13. If $X$ is a K3 surface with transcendental lattice $T_{X} \cong \mathbf{U}(2)^{2}$, then one of the following cases holds:

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|= \begin{cases}59 & \text { if }\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)\right|=1, \\ 38 & \text { if }\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)\right|=2, \\ 23 & \text { if }\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)\right|=3, \\ 16 & \text { if }\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)\right|=6 .\end{cases}
$$

Proof. We apply Theorem 2.8 to compute the multiplicities of the frames $W \in \mathcal{W}_{X}$ using either formula (5) or the GAP function DoubleCosets. Thanks to Proposition 3.10 and Proposition 3.12, the multiplicities are given by $|H \backslash G / K|$, where $G$ is the group defined in (8), $H$ is the cyclic subgroup generated by $h_{1}, h_{2}, h_{3}$ or $h_{6}$ and $K \in\left\{K_{8}, K_{12}, K_{36}\right\}$. Our results are listed in Table 3.

Table 2. Lattices in the frame genus $\mathcal{W}_{X}$ of a K3 surface $X$ with transcendental lattice $T_{X} \cong \mathbf{U}(2)^{2}$, numbered according to Oguiso (cf. [32, Table 2]).

Remark 3.14. With Theorem 3.13 we confirm independently Oguiso's results [32]. Following his notation, we denote by $E_{\tau}$ the elliptic curve with period $\tau$. Comparing Table 3 with [32, Table B], we find a geometrical interpretation of the order of $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$. Indeed, it holds

$$
\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)\right|= \begin{cases}1 & \text { if } X \cong \operatorname{Km}\left(E_{\rho} \times E_{\rho^{\prime}}\right) \\ 2 & \text { if } X \cong \operatorname{Km}\left(E_{\sqrt{-1}} \times E_{\rho^{\prime}}\right), \\ 3 & \text { if } X \cong \operatorname{Km}\left(E_{\rho} \times E_{(-1+\sqrt{-3}) / 2}\right), \\ 6 & \text { if } X \cong \operatorname{Km}\left(E_{\sqrt{-1}} \times E_{(-1+\sqrt{-3}) / 2}\right)\end{cases}
$$

where $E_{\rho}, E_{\rho^{\prime}}$ are non-isogenous elliptic curves without complex multiplication.
3.3. Jacobian Kummer surfaces. Here let $X$ denote a K3 surface with transcendental lattice

$$
T_{X} \cong \mathbf{U}(2)^{2} \oplus[-4] .
$$

Remark 3.15. By results of Kumar [23], the Kummer surface $X$ of the Jacobian of a curve $C$ of genus 2 without extra endomorphisms satisfies $T_{X} \cong \mathbf{U}(2)^{2} \oplus[-4]$. In the same paper, he classified the elliptic fibrations up to the action of $\operatorname{Aut}(X)$ and the permutations of the Weierstrass points of $C$, establishing that $\left|\mathcal{W}_{X}\right|=25$ and finding all pairs $\left(W_{\text {root }}, W / W_{\text {root }}\right), W \in \mathcal{W}_{X}$ (cf. [23, Thm. 2]). Before Kumar's work, some special elliptic fibrations had been found by Keum [17, 18], Shioda [45] and Kumar himself [22].

Proposition 3.16. The frame genus $\mathcal{W}_{X}$ contains exactly 25 isomorphism classes, listed in Table 4, whose Gram matrices are contained in the arXiv ancillary file genus_Kumar.sage.
Proof. We computed $\mathcal{W}_{X}$ using Kneser's neighbor method (Remark 2.14).
Remark 3.17. Alternatively, one could compute $\mathcal{W}_{X}$ applying the Kneser-Nishiyama method with $T_{0}=\mathbf{D}_{4} \oplus \mathbf{D}_{4} \oplus[-4]$. This lattice, though, is not generated by its roots, so one cannot use Nishiyama's results [31].
Theorem 3.18. If $X$ is a K3 surface with transcendental lattice $T_{X} \cong \mathbf{U}(2)^{2} \oplus[-4]$, then

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=491
$$

Proof. It holds $\left|\mathrm{O}\left(T_{X}^{\sharp}\right)\right|=1440$. Since $\operatorname{rk}\left(T_{X}\right)$ is odd, $\left|\mathrm{fr}_{X}^{-1}(W)\right|$ is equal to the index of $\mathrm{O}^{\sharp}(W)$ in $\mathrm{O}\left(T_{X}^{\sharp}\right)$ (Remark 2.12). A finite set of generators of $\mathrm{O}(W)$ can be computed using the command orthogonal_group of the Sage class QuadraticForm. Their images generate $\mathrm{O}^{\sharp}(W)$.
3.4. Double covers of the plane ramified over six lines. Here let $X$ denote a K3 surface with transcendental lattice

$$
T_{X} \cong \mathbf{U}(2)^{2} \oplus[-2]^{2}
$$

Remark 3.19. By results of Matsumoto, Sasaki and Yoshida [24], $X$ is the minimal resolution of the double cover of $\mathbb{P}^{2}$ ramified over 6 lines, and, conversely, such a resolution satisfies $T_{X} \cong \mathbf{U}(2)^{2} \oplus$ $[-2]^{2}$, provided that $\operatorname{rk}\left(S_{X}\right)=16$. Kloosterman [19] classified the fiber types and the Mordell-Weil groups of all jacobian elliptic fibrations on $X$. Here we refine Kloosterman's classification and compute the number of orbits $\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|$.

We fix a basis $t_{1}, \ldots, t_{6} \in T_{X}$ so that the corresponding Gram matrix is

$$
T:=\left(\begin{array}{cccccc}
0 & 2 & 0 & 0 & 0 & 0 \\
2 & 0 & 0 & 0 & 0 & 0 \\
0 & 0 & 0 & 2 & 0 & 0 \\
0 & 0 & 2 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 & -2 & 0 \\
0 & 0 & 0 & 0 & 0 & -2
\end{array}\right) .
$$

We make the following identification:

$$
\begin{equation*}
\mathrm{O}\left(T_{X}\right) \cong\left\{A \in \mathrm{GL}_{6}(\mathbb{Z}) \mid A T A^{\top}=T\right\} \tag{9}
\end{equation*}
$$

The classes modulo $T_{X}$ of $\frac{1}{2} t_{1}, \ldots \frac{1}{2} t_{6}$ form a basis over $\mathbb{F}_{2}$ for $T_{X}^{\sharp}$. A computation shows that the group $\mathrm{O}\left(T_{X}^{\sharp}\right)$ contains $1440=2^{5} \cdot 3^{2} \cdot 5$ elements and can be identified with the following subgroup of $\mathrm{GL}_{6}\left(\mathbb{F}_{2}\right)$ :

$$
\mathrm{O}\left(T_{X}^{\sharp}\right) \cong\left\langle\left(\begin{array}{llllll}
0 & 0 & 1 & 1 & 1 & 1  \tag{10}\\
1 & 0 & 1 & 0 & 0 & 0 \\
1 & 1 & 1 & 1 & 0 & 0 \\
0 & 1 & 1 & 1 & 1 & 1 \\
0 & 1 & 0 & 1 & 1 & 0 \\
0 & 1 & 0 & 1 & 0 & 1
\end{array}\right),\left(\begin{array}{llllll}
0 & 0 & 0 & 1 & 0 & 0 \\
0 & 0 & 1 & 0 & 0 & 0 \\
1 & 0 & 0 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 & 1 & 0 \\
0 & 0 & 0 & 0 & 0 & 1
\end{array}\right),\left(\begin{array}{llllll}
1 & 0 & 0 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 & 0 & 0 \\
0 & 0 & 1 & 0 & 0 & 0 \\
0 & 0 & 0 & 1 & 0 & 0 \\
0 & 0 & 0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0 & 1 & 0
\end{array}\right)\right\rangle .
$$

Under identifications (9) and (10), the natural homomorphism $\mathrm{O}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)$ is given by $A \mapsto A \bmod 2$.
Lemma 3.20. The kernel of $\mathrm{O}_{\mathrm{h}}\left(T_{X}\right) \rightarrow \mathrm{O}\left(T_{X}^{\sharp}\right)$ is equal to $\{ \pm \mathrm{id}\}$.

Proof. Clearly, $\{ \pm \mathrm{id}\}$ is contained in the kernel. By Lemma 2.13 and [21, Thm. 6.1], it suffices to show that there is no automorphism of $X$ of order 4 acting trivially on $S_{X}$. This follows from [48, Main theorem on p. 18], noticing that in our case it holds $\delta_{S_{X}}=1$ (cf. [48, Definition 2.2]), as $\left(t_{6} / 2\right)^{2}=-1 / 2$.

A computation with the GAP command ConjugacyClasses shows that the group $\mathrm{O}\left(T_{X}^{\sharp}\right)$ contains exactly 22 conjugacy classes. Let us define the following elements of $\mathrm{O}\left(T_{X}^{\sharp}\right)$ :

$$
h_{1}:=\left(\begin{array}{cccccc}
1 & 0 & 0 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 & 0 & 0 \\
0 & 0 & 1 & 0 & 0 & 0 \\
0 & 0 & 0 & 1 & 0 & 0 \\
0 & 0 & 0 & 0 & 1 & 0 \\
0 & 0 & 0 & 0 & 0 & 1
\end{array}\right), \quad h_{2}:=\left(\begin{array}{cccccc}
0 & 0 & 0 & 1 & 0 & 0 \\
0 & 0 & 1 & 1 & 1 & 1 \\
1 & 1 & 0 & 0 & 1 & 1 \\
1 & 0 & 0 & 0 & 0 & 0 \\
1 & 0 & 0 & 1 & 0 & 1 \\
1 & 0 & 0 & 1 & 1 & 0
\end{array}\right), \quad h_{3}:=\left(\begin{array}{cccccc}
0 & 0 & 1 & 0 & 0 & 0 \\
0 & 1 & 0 & 1 & 0 & 0 \\
1 & 0 & 1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 & 1 & 0 \\
0 & 0 & 0 & 0 & 0 & 1
\end{array}\right) .
$$

Lemma 3.21. An element $h \in \mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ of order 2 belongs to the conjugacy class of $h_{2}$.
Proof. As in Lemma 3.7, thanks to Lemma 3.20 we can suppose that $h=(A \bmod 2)$, where $A \in \mathrm{GL}_{6}(\mathbb{Z})$ satisfies $A T A^{\top}=T$ and $A^{2}=-I$.

Let $V \subset T_{X} \otimes \mathbb{C}$ be the eigenspace of $A$ associated with i. Necessarily, $\operatorname{dim}(V)=3$ and we can suppose that $\sigma:=\sigma_{X} \in V$. Let $\sigma, \tau, v$ be a basis of $V$ over $\mathbb{C}$. We write

$$
\begin{aligned}
& \sigma=\sigma_{1} t_{1}+\sigma_{2} t_{2}+\sigma_{3} t_{3}+\sigma_{4} t_{4}+\sigma_{5} t_{5}+\sigma_{6} t_{6}, \quad \sigma_{i} \in \mathbb{C}, \\
& \tau=\tau_{1} t_{1}+\tau_{2} t_{2}+\tau_{3} t_{3}+\tau_{4} t_{4}+\tau_{5} t_{5}+\tau_{6} t_{6}, \quad \tau_{i} \in \mathbb{C} \\
& v=v_{1} t_{1}+v_{2} t_{2}+v_{3} t_{3}+v_{4} t_{4}+v_{5} t_{5}+v_{6} t_{6}, \quad v_{i} \in \mathbb{C} .
\end{aligned}
$$

Again, $V$ is a totally isotropic subspace with respect to the bilinear form induced by $T_{X}$. Therefore, upon substituting $t_{3}$ with $t_{4}$, or $\tau$ and $v$ with linear combinations of $\sigma, \tau, v$, we can make the following assumptions:

$$
\begin{array}{llll}
\sigma_{1}=1, & v_{1}=0 & \sigma_{2}=\sigma_{3} \sigma_{4}+\frac{1}{2} \sigma_{5}^{2}+\frac{1}{2} \sigma_{6}^{2}, & v_{2}=-\sigma_{4} v_{3}-\sigma_{3} v_{4}+\sigma_{5} v_{5}+\sigma_{6} v_{6}, \\
\tau_{1}=0, & \tau_{5}=0, & \tau_{2}=-\sigma_{4} \tau_{3}-\sigma_{3} \tau_{4}+\sigma_{6} \tau_{6}, & \\
v_{6}=\tau_{6} v_{3}+\mathrm{i} v_{5} .
\end{array}
$$

Imposing that $\sigma, \tau, v \in V$ and $\bar{\sigma}, \bar{\tau}, \bar{v} \in \bar{V}$ and recalling that $A$ has integer coefficients, we get with elementary but rather tedious computations that there exist $m_{1}, \ldots, m_{6} \in \mathbb{Z}$ such that

$$
A=\left(\begin{array}{cccccc}
m_{1} & 0 & * & * & * & * \\
0 & -m_{1} & * & -m_{2} & m_{3} & m_{4} \\
m_{2} & * & m_{5} & 0 & * & * \\
* & * & 0 & -m_{5} & * & m_{6} \\
m_{3} & * & * & * & 0 & * \\
m_{4} & * & m_{6} & * & * & 0
\end{array}\right)
$$

where the symbol $*$ denotes other integral coefficients (not necessarily equal to 0 or $m_{1} \ldots, m_{6}$ ). Looking at the possible parities of $m_{1}, \ldots, m_{6}$, we see that $h=(A \bmod 2)$ is conjugate to $h_{2}$ in all possible cases.

Lemma 3.22. An element $h \in \mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ of order 3 belongs to the conjugacy class of $h_{3}$.
Proof. Similarly as in Lemma 3.8, we can assume that $h=(A \bmod 2)$ for some matrix $A \in \mathrm{GL}_{6}(\mathbb{Z})$ such that $A T A^{\top}=T$ and $A^{3}=I$. Again, we let $U$ and $W$ be the eigenspace associated with 1 and $\omega$, respectively. It holds $\operatorname{dim}(U)+2 \operatorname{dim}(W)=6$. Moreover, $U$ is orthogonal to $W$.

Investigating all cases with similar computations, we see that it must be $\operatorname{dim}(U)=\operatorname{dim}(W)=2$, otherwise $A$ is forced to have non-integral coefficients.

Looking at the possible parities of the entries of $A$, we see that $h=(A \bmod 2)$ is always contained in the conjugacy class of $h_{3}$.

Proposition 3.23. The subgroup $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ is is a cyclic group of order 1,2 or 3 , in which case it is generated by a conjugate of $h_{1}, h_{2}$ or $h_{3}$, respectively.

Proof. Let $h$ be a generator of $\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)$ and let $m$ be its order.
By Proposition 2.11 it holds $\varphi\left(\left|\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)\right|\right) \mid \operatorname{rk}\left(T_{X}\right)=6$, therefore $\left|\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)\right| \in\{2,4,6,14,18\}$. It follows from Lemma 3.20 that $m=\left|\mathrm{O}_{\mathrm{h}}\left(T_{X}\right)\right| / 2 \in\{1,2,3,7,9\}$.

We can exclude $m=7$ because $7 \nmid\left|\mathrm{O}\left(T_{X}^{\sharp}\right)\right|=1440$ and we can exclude $m=9$ because we can verify by inspection that $\mathrm{O}\left(T_{X}^{\sharp}\right)$ contains no elements of order 9 . All in all, $m \in\{1,2,3\}$ as claimed.

If $m=1$, then obviously $h=h_{1}$. If $m=2$, then $h$ is conjugate to $h_{2}$ by Lemma 3.21 . If $m=3$, then $h$ is conjugate to $h_{3}$ by Lemma 3.22.

Proposition 3.24. The frame genus $\mathcal{W}_{X}$ contains exactly 18 isomorphism classes, listed in Table 5, whose Gram matrices are contained in the arXiv ancillary file genus_Kloosterman. sage.

Proof. We compute $\mathcal{W}_{X}$ using Kneser's neighbor method (see Remark 2.14). One could also have applied the Kneser-Nishiyama method with either $T_{0}=\mathbf{A}_{1}^{2} \mathbf{D}_{4}^{2}$ or $T_{0}=\mathbf{A}_{1}^{4} \mathbf{D}_{6}$. (There is a third lattice in the same genus which is not generated by its roots, but this choice makes computations much more difficult, as one cannot use Nishiyama's results [31]). The list of lattices found is complete because the mass formula holds (see Remark 2.15):

$$
\sum_{i=1}^{18} \frac{1}{\left|\mathrm{O}\left(W_{i}\right)\right|}=\frac{1306681}{64210599936000}=\operatorname{mass}\left(\mathcal{W}_{X}\right)
$$

Remark 3.25. As a corollary of Proposition 3.24 , one can easily derive Kloosterman's classification [19, Thm. 1.1 and Thm. 1.3] of the pairs $\left(W_{\text {root }}, W / W_{\text {root }}\right)$. Note that $\left(W_{8}, W_{9}\right)$ and $\left(W_{10}, W_{11}\right)$ correspond to the same pair $\left(W_{\text {root }}, W / W_{\text {root }}\right)$. In Kloosterman's paper these cases are not distinguished. In the language of Braun, Kimura and Watari [6], in this situation the " $\mathcal{J}_{2}(X)$ classification" is strictly finer than the " $\mathcal{J}^{(\text {type })}(X)$ classification". For this reason we decided not to follow Kloosterman's numeration.

The arXiv ancillary file groups_K_Kloosterman.gap contains the definition of the subgroups

$$
K_{12}, K_{24}, K_{36}, K_{48}, K_{96}^{\prime}, K_{96}^{\prime \prime}, K_{120}, K_{144}, K_{240}, K_{720} \subset G
$$

With the same proof as for Proposition 3.12 we obtain the following proposition.
Proposition 3.26. The subgroup $\mathrm{O}^{\sharp}(W) \subset G$ is conjugate to $K_{12}$ if $W=W_{9}$, to $K_{16}$ if $W=W_{2}$, to $K_{24}$ if $W=W_{3}$, to $K_{36}$ if $W=W_{4}$, to $K_{48}$ if $W \in\left\{W_{5}, W_{11}\right\}$, to $K_{96}^{\prime}$ if $W \in\left\{W_{7}, W_{13}\right\}$, to $K_{96}^{\prime \prime}$ if $W \in\left\{W_{8}, W_{16}\right\}$, to $K_{120}$ if $W=W_{17}$, to $K_{144}$ if $W \in\left\{W_{1}, W_{14}, W_{15}\right\}$, to $K_{240}$ if $W=W_{12}$, to $K_{720}$ if $W=W_{6}$, and to $G$ if $W \in\left\{W_{10}, W_{18}\right\}$.

We now have all ingredients to compute the multiplicities of the frames $W \in \mathcal{W}_{X}$.
Theorem 3.27. If $X$ is a K3 surface with transcendental lattice $T_{X} \cong \mathbf{U}(2)^{2} \oplus[-2]^{2}$, then one of the following cases holds:

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|= \begin{cases}482 & \text { if }\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)\right|=1 \\ 274 & \text { if }\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)\right|=2 \\ 172 & \text { if }\left|\mathrm{O}_{\mathrm{h}}^{\sharp}\left(T_{X}\right)\right|=3\end{cases}
$$

Proof. We apply Theorem 2.8 to compute the multiplicities of the frames $W \in \mathcal{W}_{X}$ using either formula (5) or the GAP function DoubleCosets. Thanks to Proposition 3.23 and Proposition 3.26, the multiplicities are given by $|H \backslash G / K|$, where $G$ is the group defined in (10), $H$ is the cyclic subgroup generated by $h_{1}, h_{2}$ or $h_{3}$ and $K \in\left\{K_{12}, K_{24}, K_{36}, K_{48}, K_{96}^{\prime}, K_{96}^{\prime \prime}, K_{120}, K_{144}, K_{240}, K_{720}\right\}$. Our results are listed in Table 6.

3.5. Apéry-Fermi pencil. Let $X$ be a K3 surface with transcendental lattice

$$
T_{X} \cong \mathbf{U} \oplus[-12] .
$$

Remark 3.28. The surface $X$ is the generic element of a pencil of K3 surfaces studied by Peters and Stienstra [35]. Elliptic fibrations on this pencil were already classified by Bertin and Lecacheux [4], who in particular determined all pairs $\left(W_{\text {root }}, W / W_{\text {root }}\right), W \in \mathcal{W}_{X}$.

Proposition 3.29. The frame genus $\mathcal{W}_{X}$ contains exactly 27 isomorphism classes, listed in Table 7, whose Gram matrices are contained in the arXiv ancillary file genus_Apery_Fermi.sage.

Proof. The list found by Bertin and Lecacheux [4] applying the Kneser-Nishiyama method with $T_{0}=\mathbf{A}_{2} \mathbf{D}_{5}$ is complete because the mass formula holds:

$$
\sum_{i=1}^{27} \frac{1}{\left|\mathrm{O}\left(W_{i}\right)\right|}=\frac{123970110547}{1110668726060974080000}=\operatorname{mass}\left(\mathcal{W}_{X}\right)
$$

Theorem 3.30. If $X$ is a K3 surface with transcendental lattice $T_{X} \cong \mathbf{U} \oplus[-12]$, then

$$
\left|\mathcal{J}_{X} / \operatorname{Aut}(X)\right|=32
$$

Proof. It holds $\left|\mathrm{O}\left(T_{X}^{\sharp}\right)\right|=4$. Since $\operatorname{rk}\left(T_{X}\right)$ is odd, $\left|\mathrm{fr}_{X}^{-1}(W)\right|$ is equal to the index of $\mathrm{O}^{\sharp}(W)$ in $\mathrm{O}\left(T_{X}^{\sharp}\right)$ (Remark 2.12). A finite set of generators of $\mathrm{O}(W)$ can be computed using the command orthogonal_group of the Sage class QuadraticForm. Their images generate $\mathrm{O}^{\sharp}(W)$.
