# Stochastic logarithmic Schrödinger equations: energy regularized approach

#### Abstract

In this paper, we prove the global existence and uniqueness of the solution of the stochastic logarithmic Schrödinger (SlogS) equation driven by additive noise or multiplicative noise. The key ingredient lies on the regularized stochastic logarithmic Schrödinger (RSlogS) equation with regularized energy and the strong convergence analysis of the solutions of (RSlogS) equations. In addition, temporal Hölder regularity estimates and uniform estimates in energy space $\mathbb{H}^{1}(\mathcal{O})$ and weighted Sobolev space $L_{\alpha}^{2}(\mathcal{O})$ of the solutions for both SlogS equation and RSlogS equation are also obtained.

## 1. Introduction

The deterministic logarithmic Schrödinger equation has wide applications in quantum mechanics, quantum optics, nuclear physics, transport and diffusion phenomena, open quantum system, Bose-Einstein condensations and so on (see e.g. [1, 6, 14, 16, 19, 20]). It takes the form of

u(0, x) & =u_{0}(x), \quad x \in \mathbb{R}^{d}
\end{aligned}
$$

where $\Delta$ is the Laplacian operator on $\mathcal{O} \subset \mathbb{R}^{d}$ with $\mathcal{O}$ being either $\mathbb{R}^{d}$ or a bounded domain with homogeneous Dirichlet or periodic boundary condition, $t$ is time, $x$ is spatial coordinate, $\lambda \in \mathbb{R} /\{0\}$ characterizes the force of nonlinear interaction, and $V$ is a real-valued function. While retaining many of the known features of the linear Schrödinger equation, Bialynicki-Birula and Mycielski show that only such a logarithmic nonlinearity satisfies the condition of separability of noninteracting systems (see [6]). The logarithmic nonlinearity makes the logarithmic Schrödinger equation unique among nonlinear wave equations. For instance, the longtime dynamics of the logarithmic Schrödinger equation is essentially different from the Schrödinger equation. There is

[^0]a faster dispersive phenomenon when $\lambda<0$ and the convergence of the modulus of the solution to a universal Gaussian profile (see [7]), and no dispersive phenomenon when $\lambda>0$ (see [8]).

In this paper, we are mainly focus on the well-posedness of the following stochastic logarithmic Schrödinger (SlogS) equation,

u(0) & =u_{0}

where $W(t)=\sum_{k \in \mathbb{N}^{+}} Q^{\frac{1}{2}} e_{k} \beta_{k}(t),\left\{e_{k}\right\}_{k \in \mathbb{N}^{+}}$is an orthonormal basis of $L^{2}(\mathcal{O} ; \mathbb{C})$ with $\left\{\beta_{k}\right\}_{k \in \mathbb{N}^{+}}$ being a sequence of independent Brownian motions on a probability space $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{t \geq 0}, \mathbb{P}\right)$. Here $\widetilde{g}$ is a continuous function and $\widetilde{g}(u) \star d W(t)$ is defined by

if $\widetilde{g}(x)=\mathbf{i} g\left(|x|^{2}\right) x$, and by

$$
\widetilde{g}(u) \star d W(t)=d W(t)
$$

if $\widetilde{g}=1$. We would like to remark that when $W$ is $L^{2}(\mathcal{O} ; \mathbb{R})$-valued and $\widetilde{g}(x)=\mathbf{i} g\left(|x|^{2}\right) x$, $\widetilde{g}(u) \star d W(t)$ is just the classical Stratonovich integral.

The SlogS equation (1) could be derived from the deterministic model by using Nelson's mechanics [18]. Applying the Madlung transformation $u(t, x)=\sqrt{\rho(t, x)} e^{\mathrm{i} S(t, x)}$, 17] obtains a fluid expression of the solution as follows,

\end{aligned}

where $I(\rho)=\int_{\mathcal{O}}|\nabla \log (\rho)|^{2} \rho d x$ is the Fisher information. If $V$ is random and fluctuates rapidly, the term $\mathbf{i} V u$ can be approximated by some multiplicative Gaussian noise $\widetilde{g}(u) \dot{W}$, which plays an important role in the theory of measurements continuous in time in open quantum systems (see e.g. [5]). Then we could use the inverse of Madlung transformation and formally obtain the stochastic logarithmic Schrödinger equation

u(0, x) & =u_{0}(x), \quad x \in \overline{\mathcal{O}}
\end{aligned}
$$

The main assumption on $W$ and $\widetilde{g}$ is stated as follows.
Assumption 1. The diffusion operator is the Nemystkii operator of $\widetilde{g}$. Wiener process $W$ and $\widetilde{g}$ satisfies one of the following condition,
Case 1. $\{W(t)\}_{t \geq 0}$ is $L^{2}(\mathcal{O} ; \mathbb{C})$-valued and $\widetilde{g}=1$;
Case 2. $\{W(t)\}_{t \geq 0}$ is $L^{2}(\mathcal{O} ; \mathbb{C})$-valued, $\widetilde{g}(x)=\mathbf{i} g\left(|x|^{2}\right) x, g \in \mathcal{C}_{b}^{2}(\mathbb{R})$ and satisfies the growth condition

Case 3. $\{W(t)\}_{t \geq 0}$ is $L^{2}(\mathcal{O} ; \mathbb{R})$-valued, $\widetilde{g}(x)=\mathbf{i} g\left(|x|^{2}\right) x, g \in \mathcal{C}_{b}^{1}(\mathbb{R})$ and satisfies the growth condi-

Assumption 2. Assume that $g$ satisfies

When $W(t)$ is $L^{2}(\mathcal{O} ; \mathbb{C})$-valued, we in addition assume that $g$ satisfies following one-side Lipschitz continuity

\left|(\bar{y}-\bar{x})\left(g^{\prime}\left(|x|^{2}\right) g\left(|x|^{2}\right)|x|^{2} x-g^{\prime}\left(|y|^{2}\right) g\left(|y|^{2}\right)|y|^{2} y\right)\right| \leq C_{g}|x-y|^{2}, \quad x, y \in \mathbb{C} \tag{3}
\end{equation*}

A typical example is $\widetilde{g}(u)=u$, and then Eq. (1) becomes the SlogS equation driven by linear multiplicative noise in (4].

There are two main difficulties in proving the well-posedness of the SlogS equation. On one hand, the random perturbation in SlogS equation destroys a lot of physical conservation laws, like the mass and energy conservation laws in Case 1 and Case 2, and the energy conservation law in Case 3. Similar phenomenon has been observed in stochastic nonlinear Schrödinger equation with polynomial nonlinearity (see [13]). On the other hand, the logarithmic nonlinearity in SlogS equation is not locally Lipschitz continuous. The contraction mapping arguments via Strichartz estimates (see e.g. 3, 13, 15]) for stochastic nonlinear Schrödinger equation with smooth nonlinearity are not applicable here. We only realize that in Case 2, when the driving noise is a linear multiplicative noise $(\widetilde{g}(u)=\mathbf{i} u)$, 4] uses a rescaling technique, together with maximal monotone operator theory to obtain a unique global mild solution in some Orlicz space. As far as we know, there has no results concerning the well-posedness of the SlogS equation driven by additive noise or general multiplicative noise.

To show the well-posedness of the considered model, we introduce an energy regularized problem inspired by [2] where the authors use the regularized problem to study error estimates of numerical methods for deterministic logarithmic Schrödinger equation. The main idea is firstly constructing a proper approximation of $\log \left(|x|^{2}\right)$ denoted by $f_{\epsilon}\left(|x|^{2}\right)$. Then it induces the regularized entropy $F_{\epsilon}$ which is an approximation of the entropy $F(\rho)=\int_{\mathcal{O}}(\rho \log (\rho)-\rho) d x$, where $\rho=|u|^{2}$. The RSlogS equation is defined by

d u^{\epsilon}=\mathbf{i} \Delta u^{\epsilon} d t+\mathbf{i} u^{\epsilon} f_{\epsilon}\left(\left|u^{\epsilon}\right|^{2}\right) d t+\widetilde{g}\left(u^{\epsilon}\right) \star d W(t) \tag{4}
\end{equation*}
$$

whose regularized energy is $\frac{1}{2}\|\nabla u\|^{2}+\frac{\lambda}{2} F_{\epsilon}(u)$. Denoting $\mathbb{H}:=L^{2}=L^{2}(\mathcal{O} ; \mathbb{C})$ with the product $\langle u, v\rangle:=\int_{\mathbb{R}^{d}} \operatorname{Re}(u \bar{v}) d x$, for $u, v \in \mathbb{H}$, we obtain the existence and uniqueness of the solution of regularized $\operatorname{SlogS}$ equation by proving $\epsilon$-independent estimate in $\mathbb{H}^{1}:=W^{1,2}$ and the weighted $L^{2}$-space $L_{\alpha}^{2}:=\left\{v \in L^{2} \left\lvert\, x \mapsto\left(1+|x|^{2}\right)^{\frac{\alpha}{2}} v(x) \in L^{2}\right.\right\}$ with the norm $\|v\|_{L_{\alpha}^{2}\left(\mathbb{R}^{d}\right)}:=\|(1+$ $\left.|x|^{2}\right)^{\frac{\alpha}{2}} v(x) \|_{L^{2}\left(\mathbb{R}^{d}\right)}$. Then we are able to prove that the limit of $\left\{u^{\epsilon}\right\}_{\epsilon>0}$ is convergent to a unique stochastic process $u$ which is shown to be the unique mild solution of (11). Meanwhile, the sharp convergence rate of $\left\{u^{\epsilon}\right\}_{\epsilon>0}$ is given when $\mathcal{O}=\mathbb{R}^{d}$, or $\mathcal{O}$ is a bounded domain in $\mathbb{R}^{d}$ equipped with homogenous Dirichlet or periodic boundary condition. Our main result is formulated as follows.

Theorem 1. Let $T>0$, Assumptions 1 and 圆 hold, $u_{0} \in \mathbb{H}^{1} \cap L_{\alpha}^{2}, \alpha \in(0,1]$, be $\mathcal{F}_{0}$ measurable and has any finite pth moment. Assume that $\sum_{i \in \mathbb{N}^{+}}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{L_{\alpha}^{2}}^{2}+\left\|Q^{\frac{1}{2}} e_{i}\right\|_{\mathbb{H}^{1}}^{2}<\infty$ when $\widetilde{g}=1$ and that $\sum_{i \in \mathbb{N}^{+}}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{\mathbb{H}^{1}}^{2}+\left\|Q^{\frac{1}{2}} e_{i}\right\|_{W^{1, \infty}}^{2}<\infty$ when $\widetilde{g}(x)=\mathbf{i} g\left(|x|^{2}\right) x$. Then there exists a unique
mild solution $u \in C([0, T] ; \mathbb{H})$ of Eq. (11). Moreover, for $p \geq 2$, there exists $C\left(Q, T, \lambda, p, u_{0}\right)>0$ such that

\mathbb{E}\left[\sup _{t \in[0, T]}\|u(t)\|_{\mathbb{H}^{1}}^{p}\right]+\mathbb{E}\left[\sup _{t \in[0, T]}\|u(t)\|_{L_{\alpha}^{2}}^{p}\right] \leq C\left(Q, T, \lambda, p, u_{0}\right) .
$$

When $W(t)$ is $L^{2}(\mathcal{O} ; \mathbb{R})$-valued, the well-posedness of SlogS equation with a super-linearly growing diffusion coefficient is also proven (see Theorem 2).

The reminder of this article is organized as follows. In section 2, we introduce the RSlogS equation and show the local well-posedness of RSlogS equation driven by both additive and multiplicative noise. Section 3 is devoted to $\epsilon$-independent estimate of the mild solution in $\mathbb{H}^{1}$ and $L_{\alpha}^{2}$ of the RSlogS equation. In section 4, we prove the main result by passing the limit of the sequence of the regularized mild solutions and providing the sharp strong convergence rate. Several technique details are postponed to the Appendix. Throughout this article, $C$ denotes various constants which may change from line to line.

## 2. Regularized SLogS equation

In this section, we show the well-posedness of the solution for Eq. (4) (see Appendix for the definition of the solution). We would like to remark that there are several choices of the regularization function $f_{\epsilon}\left(|x|^{2}\right)$. For instance, one may take $f_{\epsilon}\left(|x|^{2}\right)=\log \left(\frac{|x|^{2}+\epsilon}{1+\epsilon|x|^{2}}\right)$ (see Lemma 8 in Appendix for the necessary properties) or $f_{\epsilon}\left(|x|^{2}\right)=\log \left(|x|^{2}+\epsilon\right)$ (see e.g. [2] and references therein for more choices of regularization functions). If the regularization function $f_{\epsilon}$ enjoys the same properties of $\log \left(\frac{|x|^{2}+\epsilon}{1+\epsilon|x|^{2}}\right)$, then one can follow our approach to obtain the well-posedness of Eq. (4). In the following, we first present the local well-posedness of Eq. (4), and then derive global existence and uniform estimate of its solution. For simplicity, we always assume that $0<\epsilon \ll 1$.

### 2.1. Local well-posedness of Regularized SLogS equation

In this part, we give the detailed estimates to get the local well-posedness in $\mathbb{H}^{2}$ of Eq. (4) if $d \leq 3$ via the regularization function $f_{\epsilon}\left(|x|^{2}\right)=\log \left(|x|^{2}+\epsilon\right)$. In the case of $d \geq 3$, one could use the regularization function like $f_{\epsilon}\left(|x|^{2}\right)=\log \left(\frac{|x|^{2}+\epsilon}{1+\epsilon|x|^{2}}\right)$ to get the local well-posedness in $\mathbb{H}^{1}$. Assume that $u_{0} \in \mathbb{H}^{2}$ when using the regularization $\log \left(|x|^{2}+\epsilon\right)$ and that $u_{0} \in \mathbb{H}^{1}$ when applying the regularization $\log \left(\frac{|x|^{2}+\epsilon}{1+\epsilon|x|^{2}}\right)$.

Denote by $\mathbb{M}_{\mathcal{F}}^{p}\left(\Omega ; C\left([0, T] ; \mathbb{H}^{2}\right)\right)$ with $p \in[1, \infty)$ the space of process $v:[0, T] \times \Omega \rightarrow \mathbb{H}^{2}$ with continuous paths in $\mathbb{H}^{2}$ which is $\mathcal{F}_{t^{-}}$-adapted and satisfies

\|v\|_{\mathbb{M}_{\mathcal{F}}^{p}\left(\Omega ; C\left([0, T] ; \mathbb{H}^{2}\right)\right)}^{p}:=\mathbb{E}\left[\sup _{t \in[0, T]}\|u(t)\|_{\mathbb{H}^{2}}^{p}\right]<\infty
$$

Let $\tau \leq T$ be an $\mathcal{F}_{t}$-stopping time. And we call $v \in \mathbb{M}_{\mathcal{F}}^{p}\left(\Omega ; C\left([0, \tau) ; \mathbb{H}^{2}\right)\right)$, if there exists $\left\{\tau_{n}\right\}_{n \in \mathbb{N}^{+}}$ with $\tau_{n} \nearrow \tau$ as $n \rightarrow \infty$ a.s., such that $v \in \mathbb{M}_{\mathcal{F}}^{p}\left(\Omega ; C\left(\left[0, \tau_{n}\right] ; \mathbb{H}^{2}\right)\right)$ for $n \in \mathbb{N}^{+}$. Next we show the existence and uniqueness of the local mild solution (see Definition 1 in Appendix).

For the sake of simplicity, let us ignore the dependence on $\epsilon$ and write $u_{R}:=u_{R}^{\epsilon}$, where $u_{R}$ is the solution of the truncated equation

& -\mathbf{i} \Theta_{R}\left(u_{R}, t\right) \sum_{k \in \mathbb{N}^{+}} g\left(\left|u_{R}\right|^{2}\right) g^{\prime}\left(\left|u_{R}\right|^{2}\right)\left|u_{R}\right|^{2} u_{R} \operatorname{Im}\left(Q^{\frac{1}{2}} e_{k}\right) Q^{\frac{1}{2}} e_{k} d t \\
& +\Theta_{R}\left(u_{R}, t\right) \mathbf{i} g\left(\left|u_{R}\right|^{2}\right) u_{R} d W(t)

Here, $\Theta_{R}(u, t):=\theta_{R}\left(\|u\|_{\mathcal{C}\left([0, t] ; \mathbb{H}^{2}\right)}\right), R>0$, with a cut-off function $\theta_{R}$, that is, a positive $C^{\infty}$ function on $\mathbb{R}^{+}$which has a compact support, and

\theta_{R}(x)= \begin{cases}0, & \text { for } \quad x \geq 2 R \\ 1, & \text { for } \quad x \in[0,1]\end{cases}

Lemma 1. Let Assumption 1 hold, $d \leq 3$, and $f_{\epsilon}\left(|x|^{2}\right)=\log \left(|x|^{2}+\epsilon\right)$. Assume in addition that $g \in \mathcal{C}_{b}^{3}(\mathbb{R})$ when $W(t)$ is $L^{2}(\mathcal{O} ; \mathbb{C})$-valued and that $g \in \mathcal{C}_{b}^{2}(\mathbb{R})$ when $W(t)$ is $L^{2}(\mathcal{O} ; \mathbb{R})$-valued. Suppose that the $Q$-Wiener process $W(t)$ satisfies $\sum_{i \in \mathbb{N}^{+}}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{\mathbb{H}^{2}}^{2}<\infty$, and $u_{0} \in \mathbb{H}^{2}$ is $\mathcal{F}_{0}{ }^{-}$ measurable and has any finite pth moment. Then there exists a unique global solution to (5) with continuous $\mathbb{H}^{2}$-valued path.

Proof Let $S(t)=\exp (\mathbf{i} \Delta t)$ be the $C_{0}$-group generated by $\mathbf{i} \Delta$. For fixed $R>0$, we use the following notations, for $t \in[0, T]$,

& \Gamma_{S t o}^{R} u(t):=\mathbf{i} \int_{0}^{t} S(t-s)\left(\Theta_{R}(u, s) g\left(|u(s)|^{2}\right) u(s)\right) d W(s) .

We look for a fixed point of the following operator given by

where $r$ will be chosen later. The unitary property of $S(\cdot)$ yields that

Now, we define a stopping time $\tau=\inf \left\{t \in[0, T]:\|u\|_{C\left([0, t] ; \mathbb{H}^{2}\right)} \geq 2 R\right\} \wedge r$. By using the properties of $\log (\cdot)$ and the Sobolev embedding $\mathbb{H}^{2} \hookrightarrow L^{\infty}(\mathcal{O})$, we have

For a fixed $\omega$, let us assume that $\tau_{1} \leq \tau_{2}$ without the loss of generality. Then direct calculation leads to

Now, we define a process $u^{R}$ as $u^{R}(t):=u^{R, k}(t)$ for $t \in[0, k r]$ and $u^{R}(t):=u^{R, k+1}(t)$ for $t \in[k r, k r+1]$. It can be checked that $u^{R}$ satisfies (5) by the induction assumption and the definition of $\Gamma^{R}$. Meanwhile, the uniqueness of the mild solution can be obtained by repeating the previous arguments.

Proposition 1. Let the condition of Lemma $\square$ hold. There exists a unique local mild solution to (44) with continuous $\mathbb{H}^{2}$-valued path. And the solution is defined on a random interval $\left[0, \tau_{\epsilon}^{*}\left(u_{0}, \epsilon\right)\right)$, where $\tau_{\epsilon}^{*}\left(u_{0}, \epsilon, \omega\right)$ is a stopping time such that $\tau_{\epsilon}^{*}\left(u_{0}, \epsilon, \omega\right)=+\infty$ or $\lim _{t \rightarrow \tau_{\epsilon}^{*}}\left\|u^{\epsilon}(t)\right\|_{\mathbb{H}^{2}}=$ $+\infty$.

Proof When $\widetilde{g}=1$, one can follow the same steps in the proof of 13, Theorem 3.1] to complete the proof. It suffices to consider the multiplicative noise case. Let $\left\{u^{R}\right\}_{R \in \mathbb{N}^{+}} \in \mathbb{M}_{\mathcal{F}}\left(\Omega ; C\left([0, T] ; \mathbb{H}^{2}\right)\right)$ be a sequence of solution constructed in Lemma 1. And define a stopping time sequence $\tau_{R}:=$ $\inf \left\{t \in[0, T]:\left\|u^{R}\right\|_{C\left([0, t] ; \mathbb{H}^{2}\right)} \geq R\right\} \wedge T$. Then $\tau_{R}>0$ is well-defined since $\left\|u^{R}\right\|_{C\left([0, t] ; \mathbb{H}^{2}\right)}$ is an increasing, continuous and $\mathcal{F}_{t}$-adapted process. We claim that if $R_{1} \leq R_{2}$, then $\tau_{R_{1}} \leq \tau_{R_{2}}$ and $u^{R_{1}}=u^{R_{2}}$, a.s. on $\left[0, \tau_{R_{1}}\right]$. Let $\tau_{R_{2}, R_{1}}:=\inf \left\{t \in[0, T]:\left\|u^{R_{2}}\right\|_{C\left([0, t] ; \mathbb{H}^{2}\right)} \geq R_{1}\right\} \wedge T$. Then it holds that $\tau_{R_{2}, R_{1}} \leq \tau_{R_{2}}$ and $\Theta_{R_{2}}\left(u^{R_{2}}, t\right)=\Theta_{R_{1}}\left(u^{R_{2}}, t\right)$ on $t \in\left[0, \tau_{R_{2}, R_{1}}\right]$. This implies that $\left\{\left(u^{R_{2}}, \tau_{R_{2}, R_{1}}\right)\right\}$ is a solution of (5) and that $u^{R_{1}}=u^{R_{2}}$, a.s. on $\left\{t \leq \tau_{R_{2}, R_{1}}\right\}$. Thus we conclude that $\tau_{R_{1}}=\tau_{R_{2}, R_{1}}$, a.s. and that $u^{R_{1}}=u^{R_{2}}$ for $\left\{t \leq \tau_{R_{1}}\right\}$.

Now consider the triple $\left\{u,\left(\tau_{R}\right)_{R \in \mathbb{N}^{+}}, \tau_{\infty}\right\}$ defined by $u(t):=u^{R}(t)$ for $t \in\left[0, \tau^{R}\right]$ and $\tau_{\infty}=$ $\sup _{R \in \mathbb{N}^{+}} \tau_{R}$ ．From Lemma 1 ，we know that $u \in \mathbb{M}_{\mathcal{F}}^{p}\left(\Omega, C\left([0, \tau] ; \mathbb{H}^{2}\right)\right)$ satisfies（4）for $t \leq \tau_{R}$ ．The uniqueness of the local solution also holds．If we assume that $(u, \tau)$ and $(v, \sigma)$ are local mild solutions of（4），then $u(t)=v(t)$ ，a．s．on $\{t<\sigma \wedge \tau\}$ ．Let $R_{1}, R_{2} \in \mathbb{N}^{+}$．Set $\tau_{R_{1}, R_{2}}:=\inf \{t \in$ $\left.[0, T]: \max \left(\|u\|_{C\left([0, t] ; \mathbb{H}^{2}\right)},\|v\|_{C\left([0, t] ; \mathbb{H}^{2}\right)}\right) \geq R_{1}\right\} \wedge \sigma_{R_{2}} \wedge \sigma_{R_{2}}$ ．Then we have on $\left\{t \leq \tau_{R_{1}, R_{2}}\right\}$, $\left(u, \tau_{R_{1}, R_{2}}\right),\left(v, \tau_{R_{1}, R_{2}}\right)$ are local mild solutions of（4）．The uniqueness in Lemma leads to $u=v$ on $\left\{t \leq \tau_{R_{1}, R_{2}}\right\}$ ．Letting $R_{1}, R_{2} \rightarrow \infty$ ，we complete the proof．

If we assume that $g \in \mathcal{C}_{p}^{\mathbf{s}}(\mathbb{R}), u_{0} \in \mathbb{H}^{\mathbf{s}}, \mathbf{s} \geq 2$ ，following the same procedures，we can also obtain the local existence of the solution $u_{\epsilon}$ in $\mathcal{C}\left(\left[0, \tau_{\epsilon}^{*}\right] ; \mathbb{H}^{\mathbf{s}}\right)$ when $d \leq 3$ ．When $d \geq 3$ ，one needs to use another regularization function $\log \left(\frac{|x|^{2}+\epsilon}{1+\epsilon|x|^{2}}\right)$ and additional assumption on $g$ ．In this case， we can get the local well－posedness in $\mathbb{M}_{\mathcal{F}}^{p}\left(\Omega ; C\left([0, r] ; \mathbb{H}^{1}\right)\right)$ based on Lemma 8 in Appendix and previous arguments．Since its proof is similar to that in Proposition 1 we omit these details here and leave them to readers．

Proposition 2．Let Assumption $⿴ 囗 十 ⺝$ hold，and $f_{\epsilon}\left(|x|^{2}\right)=\log \left(\frac{|x|^{2}+\epsilon}{1+\epsilon|x|^{2}}\right)$ ．Suppose that $d \in \mathbb{N}^{+}, u_{0} \in$ $\mathbb{H}^{2}$ is $\mathcal{F}_{0}$－measurable and has any finite pth moment for $p \geq 1$ ．Assume in addition that $Q$－Wiener process $W$ satisfies $\sum_{k \in \mathbb{N}^{+}}\left\|Q^{\frac{1}{2}} e_{k}\right\|_{L_{\alpha}^{2}}^{2}+\left\|Q^{\frac{1}{2}} e_{k}\right\|_{\mathbb{H}^{1}}^{2}<\infty$ when $\widetilde{g}=1$ ，and $\sum_{k \in \mathbb{N}^{+}}\left\|Q^{\frac{1}{2}} e_{k}\right\|_{W^{1, \infty}}^{2}+$ $\left\|Q^{\frac{1}{2}} e_{k}\right\|_{\mathbb{H}^{1}}^{2}<\infty$ when $\widetilde{g}(x)=\mathbf{i} g\left(|x|^{2}\right) x$ ．Then there exists a unique local mild solution to（4）with continuous $\mathbb{H}^{1}$－valued path．And the solution is defined on a random interval $\left[0, \tau_{\epsilon}^{*}\left(u_{0}, \epsilon, \omega\right)\right)$ ， where $\tau_{\epsilon}^{*}\left(u_{0}, \epsilon, \omega\right)$ is a stopping time such that $\tau^{*}\left(u_{0}, \epsilon, \omega\right)=+\infty$ or $\lim _{t \rightarrow \tau_{\epsilon}^{*}}\left\|u^{\epsilon}(t)\right\|_{\mathbb{H}^{1}}=+\infty$ ．

## 2．2．Global existence and uniform estimate of regularized SlogS equation

Due to the blow－up alternative results in section 2 it suffices to prove that $\sup _{t \in\left[0, \tau_{\epsilon}^{*}\right)}\left\|u^{\epsilon}(t)\right\|_{\mathbb{H}^{2}}<$ $\infty$ ，or $\sup _{t \in\left[0, \tau_{\epsilon}^{*}\right)}\left\|u^{\epsilon}(t)\right\|_{\mathcal{H}^{1}}<\infty$ ，a．s．under corresponding assumptions．In the following，we present several a priori estimates in strong sense to achieve our goal．To simplify the presenta－ tion，we omit some procedures like mollifying the unbounded operator $\Delta$ and taking the limit on the regularization parameter．More precisely，the mollifier $\widetilde{\Theta}_{m}, m \in \mathbb{N}^{+}$may be defined by the Fourier transformation（see e．g．13］）

where $\widetilde{\theta}$ is a positive $\mathcal{C}^{\infty}$ function on $\mathbb{R}^{+}$，has a compact support satisfying $\theta(x)=0$ ，for $x \geq 2$ and $\theta(x)=1$ ，for $0 \leq x \leq 1$ ．Another choice of mollifier is via Yosida approximation $\Theta_{m}:=$ $m(m-\Delta)^{-1}$ for $m \in \mathbb{N}^{+}$（see e．g．［15］）．This kind of procedure is introduced to make that the Itô formula can be applied rigorously to deducing several a priori estimates．If $\mathcal{O}$ becomes a bounded domain equipped with periodic or homogenous Dirichlet boundary condition，the mollifier can be chosen as the Galerkin projection，and the approximated equation becomes the Galerkin approximation（see e．g．［9，10，11，12］）．

In this section，we assume that $u_{0}$ has finite $p$－moment for all $p \geq 1$ for simplicity．We will also use Assumption to obtain the global existence of the mild solution of the regularized SlogS equation．When $d \leq 3$ and $f_{\epsilon}(x)=\log (x+\epsilon)$ ，we assume that $\sum_{k}\left\|Q^{\frac{1}{2}} e_{k}\right\|_{\mathbb{H}^{2}}^{2}<\infty$ ．When $d \in \mathbb{N}^{+}$ and $f_{\epsilon}(x)=\log \left(\frac{x+\epsilon}{1+\epsilon x}\right)$ ，we assume that $Q^{\frac{1}{2}} \in \mathbb{L}_{2}^{1}$ for the additive noise and $\sum_{k}\left\|Q^{\frac{1}{2}} e_{k}\right\|_{W^{1, \infty}}^{2}<\infty$ for the multiplicative noise．

## 2．3．A priori estimates in $L^{2}$ and $\mathbb{H}^{1}$

Lemma 2．Let $T>0$ ．Under the condition of Proposition 1 or Proposition 图，assume that $\left(u^{\epsilon}, \tau_{\epsilon}^{*}\right)$ be a local mild solution in $\mathbb{H}^{1}$ ．Then for any $p \geq 2$ ，there exists a positive constant
$C\left(Q, T, \lambda, p, u_{0}\right)>0$ such that

From the above proofs of Lemmas 2and 3 it is not hard to see that to obtain $\epsilon$-independent estimates, the boundedness restriction $\sup _{x \geq 0}|g(x)|<\infty$ may be not necessary in the case that $W(t, x)$ is real-valued. We present such result in the following which is the key of the global well-posedness of an SlogS equation with super-linear growth diffusion in next section.

Applying the embedding condition on $g$, mass conservation law and the procedures in the proof of Proposition 3, we complete the proof by taking $p=2 k$ and Gronwall's inequality.

The embedding condition is depending on the assumption on $Q$ and $d$. One example which satisfies the embedding condition on $g$ and is not bounded is $g(x)=\log (c+x)$, for $x \geq 0$ and $c>0$. Let us verify this example on $\mathcal{O}=\mathbb{R}^{d}$. If the domain $\mathcal{O}$ is bounded, one can obtain the similar estimate. We apply the Gagliardo-Nirenberg interpolation inequality and get that for $q>2$ and small enough $\eta>0$,

& \leq C\left(\|\nabla v\|^{q \alpha_{0}}+\|\nabla v\|^{(q+q \eta) \alpha_{1}}+\|\nabla v\|^{(q-q \eta) \alpha_{2}}\right)
\end{aligned}
$$

where $\alpha_{0}=\frac{d(q-2)}{2 q}, \alpha_{1}=\frac{d(q(1+\eta)-2)}{2 q(1+\eta)}$ and $\alpha_{2}=\frac{d(q(1-\eta)-2)}{2 q(1-\eta)}$ satisfies $\alpha_{i} \in(0,1), i=0,1,2$. When $q=2$, similar calculations, together with the interpolation inequality in Lemma 5 yield that

where $\alpha_{1}=\frac{d(2(1+\eta)-2)}{4(1+\eta)} \in(0,1)$ and $\alpha_{2} \in\left(\frac{d \eta}{2-2 \eta}, 1\right)$.

## 2.4. $L_{\alpha}^{2}$-estimate and modified energy

Beyond the $L^{2}$ and $\mathbb{H}^{1}$ estimates, we also need the uniform boundedness in $L_{\alpha}^{2}, \alpha>0$ to show the strong convergence of $\left\{u^{\epsilon}\right\}_{\epsilon>0}$ when $\mathcal{O}=\mathbb{R}^{d}$. We would like to mention that when $\mathcal{O}$
is a bounded domain, such estimate in $L_{\alpha}^{2}, \alpha>0$ is not necessary. To this end, the following useful weighted interpolation inequality is introduced.

Lemma 5. Let $d \in \mathbb{N}^{+}$and $\eta \in(0,1)$. Then for $\alpha>\frac{d \eta}{2-2 \eta}$, it holds that for some $C=C(d)>0$,

Let $r=\left(\frac{\|v\|_{L_{\alpha}^{2}}}{\|v\|}\right)^{\frac{1}{\alpha}}$, we complete the proof.
Proposition 3. Let $T>0, \mathcal{O}=\mathbb{R}^{d}, d \in \mathbb{N}^{+}$. Under the condition of Proposition 1 or Proposition圆, let $\left(u^{\epsilon}, \tau_{\epsilon}^{*}\right)$ be a local mild solution in $\mathbb{H}^{\mathbf{s}}, \mathbf{s} \geq 1$ for any $p \geq 1$. Let $u_{0} \in L_{\alpha}^{2} \cap \mathbb{H}^{1}$, for some $\alpha \in(0,1]$, have any finite pth moment. Then the solution $u^{\epsilon}$ of regularized problem satisfies for $\alpha \in(0,1]$,

After taking $R \rightarrow \infty$, we get $\tau_{R}=\tau_{\epsilon}^{*}$, a.s. For simplicity, we only prove uniform upper bound when $p=1$.

Taking $0<t \leq t_{1} \leq \tau_{R}$, and applying the Itô formula to $\left\|u^{\epsilon}\right\|_{L_{\alpha}^{2}}^{2}=\int_{\mathbb{R}^{d}}\left(1+|x|^{2}\right)^{\alpha}\left|u^{\epsilon}\right|^{2} d x$, we get

for additive noise case, and

& \left.-\left.\int_{0}^{t}\left\langle\left(1+|x|^{2}\right)^{\alpha} u^{\epsilon}(s)(s),\left(g\left(\left|u^{\epsilon}(s)\right|^{2}\right)\right)^{2} u^{\epsilon}(s) \sum_{i}\right| Q^{\frac{1}{2}} e_{i}\right|^{2}\right\rangle d s

for multiplicative noise case. Using integration by parts, then taking supreme over $t \in\left[0, t_{1}\right]$ and applying the Burkerholder inequality, we deduce

& +C\left(\mathbb{E}\left[\int_{0}^{t_{1}} \sum_{i \in \mathbb{N}^{+}}\left\|\left(1+|x|^{2}\right)^{\frac{\alpha}{2}} u^{\epsilon}(s)\right\|^{2}\left\|\left(1+|x|^{2}\right)^{\frac{\alpha}{2}} Q^{\frac{1}{2}} e_{i}\right\|^{2} d s\right]\right)^{\frac{1}{2}}
\end{aligned}
$$

for additive noise case, and

\mathbb{E}\left[\sup _{t \in\left[0, t_{1}\right]}\left\|u^{\epsilon}(t)\right\|_{L_{\alpha}^{2}}^{2}\right] \leq & \mathbb{E}\left[\left\|u_{0}^{\epsilon}\right\|_{L_{\alpha}^{2}}^{2}\right]+C_{\alpha} \mathbb{E}\left[\int_{0}^{T}\left|\left\langle\left(1+|x|^{2}\right)^{\alpha-1} x u^{\epsilon}(s), \nabla u^{\epsilon}(s)\right\rangle\right| d s\right] \\
& +C\left(\mathbb{E}\left[\int_{0}^{t_{1}} \sum_{i \in \mathbb{N}^{+}}\left\|\left(1+|x|^{2}\right)^{\frac{\alpha}{2}} u^{\epsilon}(s)\right\|^{4}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{L^{\infty}}^{2} d s\right]\right)^{\frac{1}{2}}

for multiplicative noise case. Then Young's and Gronwall's inequalities, together with a priori estimate of $u^{\epsilon}$ in $\mathbb{H}^{1}$, lead to the desired result.

Corollary 1. Under the condition of Lemma 4, the solution $u^{\epsilon}$ of regularized problem satisfies for $\alpha \in(0,1]$,

It is not possible to obtain the uniform bound of the exact solution in $L_{\alpha}^{2}$ for $\alpha \in(1,2]$ like the deterministic case. The main reason is that the rough driving noise leads to low Hölder regularity in time and loss of uniform estimate in $\mathbb{H}^{2}$ for the mild solution. We can not expect that the mild solution of (4) enjoys $\epsilon$-independent estimate in $\mathbb{H}^{2}$. More precisely, we prove that applying the regularization $f_{\epsilon}\left(|x|^{2}\right)=\log \left(|x|^{2}+\epsilon\right)$ in Proposition 1 one can only expect $\epsilon$-dependent estimate in $\mathbb{H}^{2}$. We omit the tedious calculation and procedures, and present a sketch of the proof for Lemma 6 and Propostion 4 in Appendix.

Lemma 6. Let $T>0$ and $d=1$. Under the condition of Proposition 1, assume that $\left(u^{\epsilon}, \tau_{\epsilon}^{*}\right)$ is the local mild solution in $\mathbb{H}^{1}$. In addition assume that $\sum_{i \in \mathbb{N}^{+}}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{W^{2, \infty}}^{2}<\infty$ for the multiplicative noise. Then for any $p \geq 2$, there exists a positive $C\left(Q, T, \lambda, p, u_{0}\right)$ such that

\mathbb{E}\left[\sup _{t \in\left[0, \tau_{\epsilon}^{*} \wedge T\right)}\left\|u^{\epsilon}(t)\right\|_{\mathbb{H}^{2}}^{2 p}\right] \leq C\left(Q, T, \lambda, p, u_{0}\right)\left(1+\epsilon^{-2 p}\right)
$$

Proposition 4. Assume that $\mathcal{O}=\mathbb{R}^{d}$. Let $T>0$ and $d=1$. Under the condition of Proposition 11, assume that $\left(u^{\epsilon}, \tau_{\epsilon}^{*}\right)$ is the local mild solution in $\mathbb{H}^{1}$. Let $u_{0} \in L_{\alpha}^{2}$, for some $\alpha \in(1,2]$. In addition assume that $\sum_{i}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{L_{\alpha}^{2}}^{2}<\infty$ in the additive noise case and that $\sum_{i \in \mathbb{N}^{+}}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{W^{2, \infty}}^{2}<\infty$ for the multiplicative noise. Then the solution $u^{\epsilon}(t)$ of regularized problem satisfies for $\alpha \in(1,2]$,

The above results indicate that both spatial and temporal regularity for SLogS equation are rougher than deterministic LogS equation.

In the following, we present the behavior of the regularized energy for the RSlogS equation. When applying $f_{\epsilon}\left(|x|^{2}\right)=\log \left(|x|^{2}+\epsilon\right)$, the modified energy of (4) becomes

with $F_{\epsilon}\left(\left|u^{\epsilon}\right|^{2}\right)=\int_{\mathcal{O}}\left(\left(\epsilon+\left|u^{\epsilon}\right|^{2}\right) \log \left(\epsilon+\left|u^{\epsilon}\right|^{2}\right)-\left|u^{\epsilon}\right|^{2}-\epsilon \log \epsilon\right) d x$. When using another regularization function $f_{\epsilon}\left(|u|^{2}\right)=\log \left(\frac{\epsilon+|u|^{2}}{1+\epsilon|u|^{2}}\right)$, its regularized entropy in the modified energy $H_{\epsilon}$ becomes

F_{\epsilon}\left(\left|u^{\epsilon}\right|^{2}\right)=\int_{\mathcal{O}}\left(\left|u^{\epsilon}\right|^{2} \log \left(\frac{\left|u^{\epsilon}\right|^{2}+\epsilon}{1+\left|u^{\epsilon}\right|^{2} \epsilon}\right)+\epsilon \log \left(\left|u^{\epsilon}\right|^{2}+\epsilon\right)-\frac{1}{\epsilon} \log \left(\epsilon\left|u^{\epsilon}\right|^{2}+1\right)-\epsilon \log (\epsilon)\right) d x
$$

In general, the modified energy is defined by the regularized entropy $\widetilde{F}(\rho)=\int_{\mathcal{O}} \int_{0}^{\rho} f_{\epsilon}(s) d s d x$, where $f_{\epsilon}(\cdot)$ is a suitable approximation of $\log (\cdot)$. We remark that the regularized energy is welldefined when $\mathcal{O}$ is a bounded domain. The additional constant term $\epsilon \log (\epsilon)$ ensures that the regularized energy is still well-defined when $\mathcal{O}=\mathbb{R}^{d}$. We leave the proof of Proposition 5 in Appendix.

Proposition 5. Let $T>0$. Under the condition of Proposition 1 or Proposition 圆, assume that $\left(u^{\epsilon}, \tau_{\epsilon}^{*}\right)$ is the local mild solution in $\mathbb{H}^{1}$. Then for any $p \geq 2$, there exists a positive constant $C\left(Q, T, \lambda, p, u_{0}\right)$ such that

\mathbb{E}\left[\sup _{t \in\left[0, \tau_{\epsilon} \wedge T\right)}\left|H_{\epsilon}\left(u^{\epsilon}(t)\right)\right|^{p}\right] \leq C\left(Q, T, \lambda, p, u_{0}\right)

Below, we present the global existence of the unique mild solution for Eq. (4) in $\mathbb{H}^{2}$ based on Proposition [1 Lemma 6roposition 2 and Lemma 3] as well as a standard argument in [13].

Proposition 6. Let Assumption 1 hold and $\left(u^{\epsilon}, \tau_{\epsilon}^{*}\right)$ be the local mild solution in Proposition 1 or Proposition 2. Then the mild solution $u^{\epsilon}$ in $\mathbb{H}^{1}$ is global, i.e., $\tau_{\epsilon}^{*}=+\infty$, a.s. In addition assume that $d=1$ in Proposition 1, the mild solution $u^{\epsilon}$ in $\mathbb{H}^{2}$ is global.

## 3. Well-posedness for SLogS equation

Based on the a priori estimates of the regularized problem, we are going to prove the strong convergence of any sequence of the solutions of the regularized problem. This immediately implies that the existence and uniqueness of the mild solution in $L^{2}$ for SLogS equation.

### 3.1. Well-posedness for SLogS equation via strong convergence approximation

In this part, we not only show the strong convergence of a sequence of solutidregularized problems, but also give the explicit strong convergence rate. The strong convergence rate of the regularized SLogS equation will make a great contribution to the numerical analysis of numerical schemes for the SLogS equation. And this topic will be studied in a companion paper. For the strong convergence result, we only present the mean square convergence rate result since the proof of the strong convergence rate in $L^{q}(\Omega), q \geq 2$ is similar. In this section, the properties of regularization function $f_{\epsilon}$ in Lemmas 7 and 8 will be frequently used.

In the multiplicative noise case, Assumption 2 is needed to obtain the strong convergence rate of the solution of Eq. (4). We remark that the assumption can be weaken if one only wants to obtain the strong convergence instead of deriving a convergence rate. Some sufficient condition for (3) in Assumption 2 is

Functions like $1, \frac{1}{c+x}, \frac{x}{c+x}, \frac{x}{c+x^{2}}, \log \left(\frac{c+|x|^{2}}{1+c|x|^{2}}\right)$ with $c>0$, etc., will satisfy Assumption 2,
The main idea of the proof lies on showing that for a decreasing sequence $\left\{\epsilon_{n}\right\}_{n \in \mathbb{N}^{+}}$satisfying $\lim _{n \rightarrow \infty} \epsilon_{n}=0,\left\{u^{\epsilon_{n}}\right\}_{n \in \mathbb{N}^{+}}$must be a Cauchy sequence in $C\left([0, T] ; L^{p}(\Omega ; \mathbb{H})\right), p \geq 2$. As a consequence, we obtain that there exists a limit process $u$ in $C\left([0, T] ; L^{p}(\Omega ; \mathbb{H})\right)$ which is shown to be independent of the sequence $\left\{u^{\epsilon_{n}}\right\}_{n \in \mathbb{N}^{+}}$and is the unique mild solution of the mild form of (11).
[Proof of Theorem [1] Based on Proposition6] we can construct a sequence of mild solutions $\left\{u^{\epsilon_{n}}\right\}_{n \in \mathbb{N}^{+}}$of Eq. (44) with $f_{\epsilon^{n}}\left(|x|^{2}\right)=\log \left(\frac{\epsilon_{n}+|x|^{2}}{1+\epsilon_{n}|x|^{2}}\right)$. Here the decreasing sequence $\left\{\epsilon_{n}\right\}_{n \in \mathbb{N}^{+}}$ satisfies $\lim _{n \rightarrow \infty} \epsilon_{n}=0$. We use the following steps to complete the proof. For simplicity, we only present the details for $p=2$ since the procedures for $p>2$ are similar.

Step 1: $\left\{u^{\epsilon_{n}}\right\}_{n \in \mathbb{N}^{+}}$is a Cauchy sequence in $L^{2}(\Omega ; C([0, T] ; \mathbb{H}))$.
Fix different $n, m \in \mathbb{N}^{+}$such that $n<m$. Subtracting the equation of $u^{\epsilon_{n}}$ from the equation of $u^{\epsilon_{m}}$, we have that

Then by step 2, they both satisfies Eq. (1). By repeating the procedures in step 1, it is not hard to obtain that $\widetilde{u}=u$.

The procedures in the above proof immediately yield the following convergence rate result for $u^{\epsilon}$ in the regularized problem (4) and the Hölder regularity estimate of $u^{\epsilon}$ and $u^{0}$.

### 3.2. Well-posedness of SlogS equation with super-linearly growing diffusion coefficients

In this part, we extends the scope of $\widetilde{g}$, which allows the diffusion with super-linear growth, for the well-posedness of SlogS equation driven by conservative multiplicative noise. For instance, it includes the example $\widetilde{g}(x)=\mathbf{i} g\left(|x|^{2}\right) x=\mathbf{i} x \log \left(c+|x|^{2}\right)$, for $c>0$.

for some $q \geq 2, \alpha \in[0,1]$, where $C_{g}>0$ depends on $g, C_{d}>0$ depends on $\mathcal{O}, d,\|v\|$ and $v \in$ $\mathbb{H}^{1} \cap L_{\alpha}^{2}$. Assume that $d=1, u_{0} \in \mathbb{H}^{1} \cap L_{\alpha}^{2}, \alpha \in(0,1]$, and $\sum_{i \in \mathbb{N}^{+}}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{\mathbb{H}^{1}}^{2}+\left\|Q^{\frac{1}{2}} e_{i}\right\|_{W^{1, \infty}}^{2}<\infty$. Then there exists a unique mild solution $u$ in $C([0, T] ; \mathbb{H})$ for Eq. (11) satisfying

Proof By Proposition 6 and Lemma 3 we can introduce the truncated sample space

where $n \leq m$. The Gagliardo-Nirenberg interpolation inequality in $d=1$, the priori estimate in $\mathbb{H}^{1}$ and the continuity in $L^{2}$ of $u^{\epsilon_{n}}$ imply that $u^{\epsilon_{n}}$ are continuous in $L^{\infty}$ a.s. Define a stopping time

Then on $\Omega_{R}(T)$, we have $\tau_{R}=T$. Let us take $f_{\epsilon}(x)=\log (x+\epsilon), x>0$ for convenience. It is obvious that $\Omega_{R}(t) \rightarrow \Omega$ as $R \rightarrow \infty$ and that for any $p \geq 1$,

\leq C \frac{1}{R^{p}}\left(\mathbb{E}\left[\sup _{t \in[0, T]}\left\|u^{\epsilon_{m}}(t)\right\|_{L^{\infty}}^{p}\right]+\sup _{t \in[0, T]} \mathbb{E}\left[\left\|u^{\epsilon_{m}}(t)\right\|_{L^{\infty}}^{p}\right]\right) .
\end{gathered}
$$

Step 1: $\left\{u^{\epsilon_{n}}\right\}_{n \in \mathbb{N}^{+}}$forms a Cauchy sequence in $\mathbb{M}_{\mathcal{F}}^{2}\left(\Omega ; C\left([0, T] ; \mathbb{H}^{2}\right)\right)$. Following the same steps like the proof of Theorem applying the Itô formula on $\Omega_{R}(t)$ for $t \in\left(0, \tau_{R}\right)$ yields that

\leq & \int_{0}^{t} 4|\lambda|\left\|u^{\epsilon_{m}}(s)-u^{\epsilon_{n}}(s)\right\|^{2} d s+4|\lambda| \epsilon_{n}^{\frac{1}{2}} \int_{0}^{t}\left\|u^{\epsilon_{m}}(s)-u^{\epsilon_{n}}(s)\right\|_{L^{1}} d s \\
& \left.+\left.\int_{0}^{t} \sum_{k \in \mathbb{N}^{+}}\langle | Q^{\frac{1}{2}} e_{k}\right|^{2}\left(g\left(\left|u^{\epsilon_{n}}\right|^{2}\right)-g\left(\left|u^{\epsilon_{m}}\right|^{2}\right)\right) u^{\epsilon_{m}},\left(g\left(\left|u^{\epsilon_{n}}\right|^{2}\right)-g\left(\left|u^{\epsilon_{m}}\right|^{2}\right)\right) u^{\epsilon_{n}}\right\rangle d s \\
& +\int_{0}^{t}\left\langle u^{\epsilon_{m}}-u^{\epsilon_{n}}, \mathbf{i}\left(g\left(\left|u^{\epsilon_{m}}\right|^{2}\right) u^{\epsilon_{m}}-g\left(\left|u^{\epsilon_{n}}\right|^{2}\right) u^{\epsilon_{n}}\right) d W(s)\right\rangle .
\end{aligned}

Taking expectation on $\Omega_{R}(t)$ yields that

\leq & \int_{0}^{t} 4|\lambda| \mathbb{E}\left[\mathbb{I}_{\Omega_{R}(t)}\left\|u^{\epsilon_{m}}(s)-u^{\epsilon_{n}}(s)\right\|^{2}\right] d s+4|\lambda| \epsilon_{n}^{\frac{1}{2}} \int_{0}^{t} \mathbb{E}\left[\mathbb{I}_{\Omega_{R}(t)}\left\|u^{\epsilon_{m}}(s)-u^{\epsilon_{n}}(s)\right\|_{L^{1}}\right] d s \\
& +\int_{0}^{t} \sum_{k \in \mathbb{N}^{+}}\left|Q^{\frac{1}{2}} e_{k}\right|_{L^{\infty}}^{2} \mathbb{E}\left[\mathbb{I}_{\Omega_{R}(t)}\left\langle\left(g\left(\left|u^{\epsilon_{n}}\right|^{2}\right)-g\left(\left|u^{\epsilon_{m}}\right|^{2}\right)\right) u^{\epsilon_{m}},\left(g\left(\left|u^{\epsilon_{n}}\right|^{2}\right)-g\left(\left|u^{\epsilon_{m}}\right|^{2}\right)\right) u^{\epsilon_{n}}\right\rangle\right] d s .
\end{aligned}

Making use of the assumptions on $g$, we get

& +C(Q) \int_{0}^{t} \mathbb{E}\left[\mathbb{I}_{\Omega_{R}(t)} \int_{\mathcal{O}}\left(\left|u^{\epsilon_{m}}\right|^{2}+\left|u^{\epsilon_{n}}\right|^{2}\right)\left|u^{\epsilon_{n}}\left\|u^{\epsilon_{m}}\right\| u^{\epsilon_{m}}(t)-u^{\epsilon_{n}}(t)\right|^{2} d x\right] d s \\
\leq & \int_{0}^{t} 4|\lambda| \mathbb{E}\left[\mathbb{I}_{\Omega_{R}(t)}\left\|u^{\epsilon_{m}}(s)-u^{\epsilon_{n}}(s)\right\|^{2}\right] d s+4|\lambda| \epsilon_{n}^{\frac{1}{2}} \int_{0}^{t} \mathbb{E}\left[\mathbb{I}_{\Omega_{R}(t)}\left\|u^{\epsilon_{m}}(s)-u^{\epsilon_{n}}(s)\right\|_{L^{1}}\right] d s \\
& +C(Q) \int_{0}^{t} \mathbb{E}\left[\left(1+R^{4}\right) \mathbb{I}_{\Omega_{R}(t)}\left\|u^{\epsilon_{m}}(t)-u^{\epsilon_{n}}(t)\right\|^{2}\right] d s .

If $\mathcal{O}$ is bounded, then Hölder inequality and Gronwall's inequality yield that

On the other hand, the Chebyshev inequality and the a priori estimate lead to

where $\frac{1}{p_{1}}+\frac{1}{q_{1}}=1$. From the above estimate, choosing $p \gg p_{1}$ and denote by $\kappa=\frac{p}{p_{1}}$, we conclude that

When $\mathcal{O}=\mathbb{R}^{d}$, we just repeat the procedures in the proof of the case that $g$ is bounded and obtain that for $\eta \in\left(0, \frac{2 \alpha}{2 \alpha+d}\right]$ and $\alpha \in(0,1]$,

\leq & \int_{0}^{t} 4|\lambda| \mathbb{E}\left[\mathbb{I}_{\Omega_{R}(t)}\left\|u^{\epsilon_{m}}(s)-u^{\epsilon_{n}}(s)\right\|^{2}\right] d s+C \epsilon_{m}^{\eta} \int_{0}^{t} \mathbb{E}\left[\mathbb{I}_{\Omega_{R}(t)}\left\|u^{\epsilon_{n}}\right\|_{L_{\alpha}^{2}}^{\frac{d \eta}{\alpha}}\left\|u^{\epsilon_{n}}\right\|^{2-2 \eta-\frac{d \eta}{\alpha}}\right] d s \\
& +C(Q) \int_{0}^{t} \mathbb{E}\left[\left(1+R^{4}\right) \mathbb{I}_{\Omega_{R}(t)}\left\|u^{\epsilon_{m}}(t)-u^{\epsilon_{n}}(t)\right\|^{2}\right] d s
\end{aligned}
$$

By using Gronwall's inequality and the estimate of $\mathbb{P}\left(\mathbb{I}_{\Omega_{R}(t)}^{c}\right)$, we immediately have that for $\eta \in\left(0, \frac{2 \alpha}{2 \alpha+d}\right), \alpha \in(0,1]$ and any $\kappa>0$,

$$

Taking $R=\left(\frac{\eta c}{T}\left|\log \left(\epsilon_{n}\right)\right|\right)^{\frac{1}{4}}$ for $c \eta \in(0,1)$ and using the Burkerholder inequality, we have for $\eta \in\left(0, \frac{2 \alpha}{2 \alpha+d}\right), \alpha \in(0,1]$ and any $\kappa>0$,

Step 2. $u$ is the mild solution.
Let us use the same notations and procedures as in step 2 of the proof in Theorem To show that the mild form $u^{\epsilon_{n}}$ converges to $S(t) u_{0}+V_{1}+V_{2}+V_{3}+V_{4}$. We only need to estimate $V_{2}$ and $V_{4}$ since $V_{3}=0$. Define

Then on $\Omega_{R_{1}}(T)$, we have $\tau_{R_{1}}=T$. The Minkowski inequality and the properties of $g$ yield that on $\Omega_{R_{1}}(t)$, for a small enough $\eta_{1}>0$,

\leq & \left.\left.\sum_{k}\left|Q^{\frac{1}{2}} e_{k}\right|_{L^{\infty}}^{2} \int_{0}^{T} \| g\left(\left|u^{\epsilon_{n}}\right|^{2}\right)\right)^{2} u^{\epsilon_{n}}-g\left(|u|^{2}\right)\right)^{2} u \| d s \\
\leq & C_{g} T \sum_{k}\left|Q^{\frac{1}{2}} e_{k}\right|_{L^{\infty}}^{2}\left(1+R_{1}^{2}\right) \sup _{t \in[0, T]}\left\|u^{\epsilon_{n}}-u\right\| .
\end{aligned}
$$

On the other hand, for any $p_{2}>0$,

$$
\mathbb{E}\left[\mathbb{I}_{\Omega_{R_{1}}^{c}(t)}\left\|-\frac{1}{2} \int_{0}^{t} S(t-s)\left(g\left(\left|u^{\epsilon_{n}}\right|^{2}\right)\right)^{2} u^{\epsilon_{n}} \sum_{k}\left|Q^{\frac{1}{2}} e_{k}\right|^{2} d s-V_{2}\right\|^{2}\right] \leq C\left(u_{0}, Q, T, p_{2}\right) R_{1}^{-p_{2}} .
$$

Taking $R_{1}=\mathscr{O}\left(\left|\log \left(\epsilon_{n}\right)\right|^{\frac{\kappa_{1}}{4\left(4+p_{2}\right)}}\right), \kappa_{1}<\kappa$, we have that

$$
\lim _{n \rightarrow \infty} \sup _{t \in[0, T]} \mathbb{E}\left[\left\|\int_{0}^{t}-\frac{1}{2} S(t-s)\left(g\left(\left|u^{\epsilon_{n}}\right|^{2}\right)\right)^{2} u^{\epsilon_{n}} \sum_{k}\left|Q^{\frac{1}{2}} e_{k}\right|^{2} d s-V_{2}\right\|^{2}\right]=0
$$

which immediately implies that

\lim _{n \rightarrow \infty} \mathbb{E}\left[\sup _{t \in[0, T]}\left\|-\frac{1}{2} \int_{0}^{t} S(t-s)\left(g\left(\left|u^{\epsilon_{n}}\right|^{2}\right)\right)^{2} u^{\epsilon_{n}} \sum_{k}\left|Q^{\frac{1}{2}} e_{k}\right|^{2} d s-V_{2}\right\|^{2}\right]=0
$$

The Burkerholder inequality and the unitary property of $S(\cdot)$ yield that

\begin{aligned}
& \mathbb{E}\left[\sup _{t \in\left[0, \tau_{R}\right]}\left\|\int_{0}^{t} \mathbf{i} S(t-s) g\left(\left|u^{\epsilon_{n}}\right|^{2}\right) u^{\epsilon_{n}} d W(s)-V_{4}\right\|^{2}\right] \\
\leq & C \mathbb{E}\left[\int_{0}^{T} \sum_{k}\left\|Q^{\frac{1}{2}} e_{k}\right\|_{L^{\infty}}^{2}\left\|g\left(\left|u^{\epsilon_{n}}\right|^{2}\right) u^{\epsilon_{n}}-g\left(|u|^{2}\right) u\right\|^{2} d s\right] \\
\leq & C\left(1+R_{1}^{2}\right) \mathbb{E}\left[\sup _{t \in[0, T]}\left\|u^{\epsilon_{n}}(t)-u(t)\right\|^{2}\right] .
\end{aligned}
$$

On the other hand, the Chebyshev inequality, together with the a priori estimate of $u^{\epsilon_{n}}$, implies that

$$
\begin{aligned}
& \mathbb{E}\left[\sup _{t \geq \tau_{R_{1}}}\left\|\int_{0}^{t} \mathrm{i} S(t-s) g\left(\left|u^{\epsilon_{n}}\right|^{2}\right) u^{\epsilon_{n}} d W(s)-V_{4}\right\|^{2}\right] \\
= & \mathbb{E}\left[\sup _{t \in[0, T]} \mathbb{I}_{\Omega_{R_{1}}^{c}}\left\|\int_{0}^{t} S(t-s) g\left(\left|u^{\epsilon_{n}}\right|^{2}\right) u^{\epsilon_{n}} d W(s)-V_{4}\right\|^{2}\right] \leq C\left(u_{0}, Q, T, p\right) R_{1}^{-p_{2}} .
\end{aligned}
$$

Taking $R_{1}=\mathscr{O}\left(\left|\log \left(\epsilon_{n}\right)\right|^{\frac{\kappa_{1}}{4\left(2+p_{2}\right)}}\right), \kappa_{1}<\kappa$, we have that

$$
\lim _{n \rightarrow \infty} \mathbb{E}\left[\sup _{t \in[0, T]}\left\|\int_{0}^{t} \mathbf{i} S(t-s) g\left(\left|u^{\epsilon_{n}}\right|^{2}\right) u^{\epsilon_{n}} d W(s)-V_{4}\right\|^{2}\right]=0
$$

Combining the above estimates and the strong convergence of $u^{\epsilon_{n}}$, we complete the proof.
Remark 1. One may extend the scope of $\widetilde{g}$ to an abstract framework by similar arguments. Here the assumption $d=1$ lies on the fact that in $\mathbb{H}^{1}$ is an algebra by Sololev embedding theorem. When considering the case $d \geq 2$, one may use $\mathbb{H}^{\mathbf{s}}, \mathbf{s}>\frac{d}{2}$ as the underlying space for the local well-posedness. However, as stated in Lemma 6, it seems impossible to get the uniform bound of $u^{\epsilon}$ in $\mathbb{H}^{\mathbf{s}}$ for $\mathbf{s} \geq 2$.

## 4. Appendix

The original problem and regularized problem can be rewritten into the equivalent evolution forms

$$

where $A=\mathbf{i} \Delta, F$ is the Nemystkii operator of drift coefficient function, and $G$ are the Nemystkii operator of diffusion coefficient function. Then the mild solution of the above evolution is defined as follows.

Definition 1. A continuous $\mathbb{H}$-valued $\mathcal{F}_{t}$ adapted process $u$ is a solution to (9) if it satisfies $\mathbb{P}$-a.s for all $t \in[0, T]$,

$$

where $S(t)$ is the $C_{0}$-group generated by $A$.
Definition 2. A local mild solution of (9) is $(u, \tau):=\left(u, \tau_{n}, \tau\right)$ satisfying $\tau_{n} \nearrow \tau$, a.s., as $n \rightarrow \infty, u \in \mathbb{M}_{\mathcal{F}}^{p}\left(\Omega ; C\left([0, \tau) ; \mathbb{H}^{\mathbf{s}}\right), \mathbf{s}>0, p \geq 1\right.$ and that

u(t) & =S(t) u_{0}+\int_{0}^{t} S(t-s) F(u(s)) d s \\
& +\int_{0}^{t} S(t-s) G(u(s)) d W(s), \text { a.s. }
\end{aligned}

for $t \leq \tau_{n}$ in $\mathbb{H}^{2}$ for $n \in \mathbb{N}^{+}$. Solutions of (9) are called unique, if

for all local mild solution $\left(u_{1}, \sigma_{1}\right)$ and $\left(u_{2}, \sigma_{2}\right)$. The local solution $(u, \tau)$ is called a global mild solution if $\tau=T$, a.s. and $u \in \mathbb{M}_{\mathcal{F}}^{p}\left(\Omega ; C\left([0, T] ; \mathbb{H}^{\mathbf{s}}\right)\right.$.

Lemma 7. Let $\epsilon \in(0,1)$. Then $f_{\epsilon}(x)=\log \left(|x|^{2}+\epsilon\right), x \in \mathbb{C}$, satisfies

[Sketch Proof of Lemma 6] Due to the loss of the regularity of the solution in time, we can not establish the bound in $\mathbb{H}^{2}$ through $\frac{\partial u^{\epsilon}}{\partial t}$ like in the deterministic case. According to

Lemma 3, it suffices to bound $\left\|\Delta u^{\epsilon}\right\|^{2}$. We present the procedures of the estimation of $\mathbb{E}\left[\|\Delta u\|^{2}\right]$ for the conservative multiplicative noise case. One can easily follow the procedures to obtain the estimate of $\mathbb{E}\left[\sup _{t \in[0, \tau]}\|\Delta u(t)\|^{2}\right]$ for both additive and multiplicative noises.

& \left.+\left\|g^{\prime \prime}\left(\left|u^{\epsilon}\right|^{2}\right)\left|u^{\epsilon}\right|^{3}\right\|_{L^{\infty}}^{2}\left\|\nabla u^{\epsilon}\right\|_{L^{4}}^{4}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{L^{\infty}}^{2}+\left\|g^{\prime}\left(\left|u^{\epsilon}\right|^{2}\right) u^{\epsilon}\right\|_{L^{\infty}}^{2}\left\|\nabla u^{\epsilon}\right\|_{L^{4}}^{4}\left\|Q^{\frac{1}{2}} e_{i}\right\|_{L^{\infty}}^{2}\right) \\
& \leq C \sum_{i}\left(\left\|\nabla Q^{\frac{1}{2}} e_{i}\right\|_{L^{4}}^{2}+\left\|\nabla Q^{\frac{1}{2}} e_{i}\right\|_{L^{\infty}}^{2}+\left\|\Delta Q^{\frac{1}{2}} e_{i}\right\|^{2}+\left\|Q^{\frac{1}{2}} e_{i}\right\|_{L^{\infty}}^{2}\right)\left(1+\left\|\nabla u^{\epsilon}\right\|_{L^{4}}^{4}\right)
\end{aligned}
$$

Combining the above estimates, and using the Young inequality and Gronwall inequality imply that

$$
\mathbb{E}\left[\left\|\Delta u^{\epsilon}(t)\right\|^{2}\right] \leq C\left(u_{0}, T, Q, p, \eta\right)\left(1+\epsilon^{-2}\right)
$$

Now, taking supreme over $t$, then taking expectation, and applying the Burkerholder inequality to the $I I I_{\text {sto }} d W(t)$, we achieve that for sufficient small $\eta>0$,

$$
\mathbb{E}\left[\sup _{t \in[0, \tau]}\left\|\Delta u^{\epsilon}(t)\right\|^{2}\right] \leq C\left(u_{0}, T, Q, \eta\right)\left(1+\epsilon^{-2}\right)
$$

[Proof of Proposition 4] We follow the steps in the proof of Proposition 3 to present the proof in the case of $p=2$. For convenience, we present the proof for the multiplicative noise
case. Applying the Itô formula to $\left\|u^{\epsilon}\right\|_{L_{\alpha}^{2}}^{2}=\int_{\mathbb{R}^{d}}\left(1+|x|^{2}\right)^{\alpha}\left|u^{\epsilon}\right|^{2} d x$, using integration by parts, then taking supreme over $t$, and applying Burkerholder inequality, we deduce that

$$
\begin{aligned}
\mathbb{E}\left[\sup _{t \in[0, T]}\left\|u^{\epsilon}(t)\right\|_{L_{\alpha}^{2}}^{2}\right] & \leq \mathbb{E}\left[\left\|u_{0}\right\|_{L_{\alpha}^{2}}^{2}\right]+2 \alpha \mathbb{E}\left[\int_{0}^{T}\left|\left\langle\left(1+|x|^{2}\right)^{\alpha-1} x u^{\epsilon}(s), \nabla u^{\epsilon}\right\rangle\right| d s\right] \\
& +\mathbb{E}\left[\sup _{t \in[0, T]}\left|\int_{0}^{t}\left\langle\left(1+|x|^{2}\right)^{\alpha} u^{\epsilon}(s), \mathbf{i} g\left(\left|u^{\epsilon}(s)\right|^{2}\right) u^{\epsilon}(s) d W(s)\right\rangle\right|\right] \\
& \leq \mathbb{E}\left[\left\|u_{0}\right\|_{L_{\alpha}^{2}}^{2}\right]+C_{\alpha} \mathbb{E}\left[\int_{0}^{T}\left|\left\langle\left(1+|x|^{2}\right)^{\alpha-1} x u^{\epsilon}(s), \nabla u^{\epsilon}\right\rangle\right| d s\right] \\
& +C \mathbb{E}\left[\left.\int_{0}^{T} \sum_{i \in \mathbb{N}^{+}}\left|\left\langle\left(1+|x|^{2}\right)^{\alpha} u^{\epsilon}(s), \mathbf{i} g\left(\left|u^{\epsilon}(s)\right|^{2}\right) u^{\epsilon}(s) Q^{\frac{1}{2}} e_{i}\right\rangle\right|^{2} \right\rvert\, d s\right]
\end{aligned}
$$

By Hölder's inequality, for $\alpha \in(1,2]$, we have that

$$
\left|\left\langle\left(1+|x|^{2}\right)^{\alpha-1} x u^{\epsilon}, \nabla u^{\epsilon}\right\rangle\right| \leq C\left\|u^{\epsilon}\right\|_{L_{\alpha}^{2}}\left\|\left(1+|x|^{2}\right)^{\frac{\alpha}{2}-\frac{1}{2}} \nabla u^{\epsilon}\right\| .
$$

Integration by parts and Hölder's inequality yield that for some small $\eta>0$,

$$
\begin{aligned}
& \left\|\left(1+|x|^{2}\right)^{\frac{\alpha}{2}-\frac{1}{2}} \nabla u^{\epsilon}\right\|^{2}=\left\langle\left(1+|x|^{2}\right)^{\alpha-1} \nabla u^{\epsilon}, \nabla u^{\epsilon}\right\rangle \\
& =-\left\langle\left(1+|x|^{2}\right)^{\alpha-1} u^{\epsilon}, \Delta u^{\epsilon}\right\rangle-2(\alpha-1)\left\langle\left(1+|x|^{2}\right)^{\alpha-2} x \nabla u^{\epsilon}, u^{\epsilon}\right\rangle \\
& \leq\left\|u^{\epsilon}\right\|_{L_{\max (2 \alpha-2,0)}^{2}}\left\|\Delta u^{\epsilon}\right\|+C(\eta)|\alpha-1|\left\|u^{\epsilon}\right\|_{L_{\alpha}^{2}}^{2}+\eta|\alpha-1|\left\|\nabla u^{\epsilon}\right\|_{L_{\max (\alpha-3,0)}^{2}}^{2}
\end{aligned}
$$

Combining the above estimates in Proposition 3 and using Young's inequality, we achieve that

$$
\begin{aligned}
& \mathbb{E}\left[\sup _{t \in[0, T]}\left\|u^{\epsilon}(t)\right\|_{L_{\alpha}^{2}}^{2}\right] \leq e^{C T}\left(1+\epsilon^{-1}\right), \text { if } \alpha \in\left(1, \frac{3}{2}\right], \\
& \mathbb{E}\left[\sup _{t \in[0, T]}\left\|u^{\epsilon}(t)\right\|_{L_{\alpha}^{2}}^{2}\right] \leq e^{C T}\left(1+\epsilon^{-\frac{3}{2}}\right), \text { if } \alpha \in\left[\frac{3}{2}, 2\right), \\
& \mathbb{E}\left[\sup _{t \in[0, T]}\left\|u^{\epsilon}(t)\right\|_{L_{\alpha}^{2}}^{2}\right] \leq e^{C T}\left(1+\epsilon^{-2}\right), \text { if } \alpha=2 .
\end{aligned}
$$
