# Similar transformation of one class of correct restrictions

Key words: maximal (minimal) operator, correct restriction, correct extension, similar operators, singular coefficients, Riesz basis with brackets.
AMS Mathematics Subject Classification: 47A05, 47A10.
Abstract. The description of all correct restrictions of the maximal operator are considered in a Hilbert space. A class of correct restrictions are obtained for which a similar transformation has the domain of the fixed correct restriction. The resulting theorem is applied to the study of $n$-order differentiation operator with singular coefficients.

## 1 Introduction

Let a closed linear operator $L$ be given in a Hilbert space $H$. The linear equation

$$
\begin{equation*}
L u=f \tag{1.1}
\end{equation*}
$$

is said to be correctly solvable on $R(L)$ if $\|u\| \leq C\|L u\|$ for all $u \in D(L)$ (where $C>0$ does not depend on $u$ ) and everywhere solvable if $R(L)=H$. If (1.1) is simultaneously correct and solvable everywhere, then we say that $L$ is a correct operator. A correctly solvable operator $L_{0}$ is said to be minimal if $R\left(L_{0}\right) \neq H$. A closed operator $\widehat{L}$ is called a maximal operator if $R(\widehat{L})=H$ and $\operatorname{Ker} \widehat{L} \neq\{0\}$. An operator $A$ is called a restriction of an operator $B$ and $B$ is said to be an extension of $A$ if $D(A) \subset D(B)$ and $A u=B u$ for all $u \in D(A)$.

Note that if one of the correct restriction $L$ of a maximal operator $\widehat{L}$ is known, then the inverses of all correct restrictions of $\widehat{L}$ have in the form [1]

\begin{equation*}
L_{K}^{-1} f=L^{-1} f+K f \tag{1.2}
\end{equation*}
$$

where $K$ is an arbitrary bounded linear operator in $H$ such that $R(K) \subset \operatorname{Ker} \widehat{L}$.
Let $L_{0}$ be some minimal operator, and let $M_{0}$ be another minimal operator related to $L_{0}$ by the equation $\left(L_{0} u, v\right)=\left(u, M_{0} v\right)$ for all $u \in D\left(L_{0}\right)$ and $v \in D\left(M_{0}\right)$. Then $\widehat{L}=M_{0}^{*}$ and $\widehat{M}=L_{0}^{*}$ are maximal operators such that $L_{0} \subset \widehat{L}$ and $M_{0} \subset \widehat{M}$. A correct
restriction $L$ of a maximal operator $\widehat{L}$ such that $L$ is simultaneously a correct extension of the minimal operator $L_{0}$ is called a boundary correct extension. The existence of at least one boundary correct extension $L$ was proved by Vishik in [2], that is, $L_{0} \subset L \subset \widehat{L}$.

The inverse operators to all possible correct restrictions $L_{K}$ of the maximal operator $\widehat{L}$ have the form (1.2), then

$$
D\left(L_{K}\right)=\{u \in D(\widehat{L}):(I-K \widehat{L}) u \in D(L)\}
$$

is dense in $H$ if and only if $\operatorname{Ker}\left(I+K^{*} L^{*}\right)=\{0\}$. All possible correct extensions $M_{K}$ of $M_{0}$ have inverses of the form

$$
M_{K}^{-1} f=\left(L_{K}^{*}\right)^{-1} f=\left(L^{*}\right)^{-1} f+K^{*} f
$$

where $K$ is an arbitrary bounded linear operator in $H$ with $R(K) \subset \operatorname{Ker} \widehat{L}$ such that

$$
\operatorname{Ker}\left(I+K^{*} L^{*}\right)=\{0\} .
$$

The main result of this work is the following
Theorem 1.1. Let $L$ be boundary correct extension of $L_{0}$, that is, $L_{0} \subset L \subset \widehat{L}$. If $L_{K}$ is densely defined in $H$ and

$$
R\left(K^{*}\right) \subset D\left(L^{*}\right) \cap D\left(L_{K}^{*}\right)
$$

where $K$ and $L$ are the operators in representation (1.2), then $\overline{K L}_{K}$ is bounded in $H$ and a correct restriction $L_{K}$ of the maximal operator $\widehat{L}$ is similar to the correct operator

$$
A_{K}=L-\overline{K L}_{K} L \text { on } D\left(A_{K}\right)=D(L)
$$

## 2 Preliminaries

In this section, we present some results for correct restrictions and extensions 3] which are used in Section 3,

Let $A$ and $B$ be bounded operators in a Hilbert space $H$. An operators $A$ and $B$ are said to be similar if there exist an invertible operator $P$ such that $P^{-1} A P=B$. Similar operators have the same spectrum. If at least one of two operators $A$ and $B$ is invertible, then the operators $A B$ and $B A$ are similar.

Lemma 2.1. Let $L$ be a densely defined correct restriction of the maximal operator $\widehat{L}$ in a Hilbert space $H$. Then the operator $K L$ is bounded on $D(L)$ (that is, $\overline{K L}$ is bounded in H) if and only if

$$
R\left(K^{*}\right) \subset D\left(L^{*}\right)
$$

Proof. Let $R\left(K^{*}\right) \subset D\left(L^{*}\right)$. Then, by virtue of $(K L)^{*}=L^{*} K^{*}$, we have that $\overline{K L}$ is bounded in $H$, where $\overline{K L}$ is the closure of the operator $K L$ in $H$. Here we have used the boundedness of the operator $L^{*} K^{*}$. Then the operator $K L$ is bounded on $D(L)$. Conversely, let $K L$ be bounded on $D(L)$. Then $\overline{K L}$ is bounded on $H$, by virtue of
$(K L)^{*}=(\overline{K L})^{*}$ and that $(K L)^{*}$ is defined on the whole space $H$. Then the operator $K^{*}$ transfers any element $f$ in $H$ to $D\left(L^{*}\right)$. Indeed, for any element $g$ of $D(L)$ we have

$$
\left(L g, K^{*} f\right)=(K L g, f)=\left(g,(K L)^{*} f\right)
$$

Therefore, $K^{*} f$ belongs to the domain $D\left(L^{*}\right)$.
Lemma 2.2. Let $L_{K}$ be a densely defined correct restriction of the maximal operator $\widehat{L}$ in a Hilbert space $H$. Then $D\left(L^{*}\right)=D\left(L_{K}^{*}\right)$ if and only if $R\left(K^{*}\right) \subset D\left(L^{*}\right) \cap D\left(L_{K}^{*}\right)$, where $L$ and $K$ are the operators from representation (1.2).

Proof. If $D\left(L^{*}\right)=D\left(L_{K}^{*}\right)$, then from representation (1.2) we easily get

$$
R\left(K^{*}\right) \subset D\left(L^{*}\right) \cap D\left(L_{K}^{*}\right)=D\left(L^{*}\right)=D\left(L_{K}^{*}\right)
$$

Let us prove the converse. If

$$
R\left(K^{*}\right) \subset D\left(L^{*}\right) \cap D\left(L_{K}^{*}\right)
$$

then we obtain

$$
\begin{gather*}
\left(L_{K}^{*}\right)^{-1} f=\left(L^{*}\right)^{-1} f+K^{*} f=\left(L^{*}\right)^{-1}\left(I+L^{*} K^{*}\right) f,  \tag{2.1}\\
\left(L^{*}\right)^{-1} f=\left(L_{K}^{*}\right)^{-1} f-K^{*} f=\left(L_{K}^{*}\right)^{-1}\left(I-L_{K}^{*} K^{*}\right) f, \tag{2.2}
\end{gather*}
$$

for all $f$ in $H$. It follows from (2.1) that $D\left(L_{K}^{*}\right) \subset D\left(L^{*}\right)$, and taking into account (2.2) this implies that $D\left(L^{*}\right) \subset D\left(L_{K}^{*}\right)$. Thus $D\left(L^{*}\right)=D\left(L_{K}^{*}\right)$.

Corollary 2.1. Let $L_{K}$ be any densely defined correct restriction of the maximal operator $\widehat{L}$ in a Hilbert space $H$. If $R\left(K^{*}\right) \subset D\left(L^{*}\right)$ and $\overline{K L}$ is a compact operator in $H$, then

$$
D\left(L^{*}\right)=D\left(L_{K}^{*}\right) .
$$

Proof. Compactness of $\overline{K L}$ implies compactness of $L^{*} K^{*}$. Then $R\left(I+L^{*} K^{*}\right)$ is a closed subspace in $H$. It follows from the dense definiteness of $L_{K}$ that $R\left(I+L^{*} K^{*}\right)$ is a dense set in $H$. Hence $R\left(I+L^{*} K^{*}\right)=H$. Then from equality (2.1) we get $D\left(L^{*}\right)=D\left(L_{K}^{*}\right)$.

Lemma 2.3. If $R\left(K^{*}\right) \subset D\left(L^{*}\right) \cap D\left(L_{K}^{*}\right)$, then bounded operators $I+L^{*} K^{*}$ and $I-L_{K}^{*} K^{*}$ from (2.1) and (2.2), respectively, have a bounded inverse defined on $H$.

Proof. By virtue of the density of the domains of the operators $L_{K}^{*}$ and $L^{*}$ it follows that the operators $I+L^{*} K^{*}$ and $I-L_{K}^{*} K^{*}$ are invertible. Since from (2.1) and (2.2) we have $\operatorname{Ker}\left(I+L^{*} K^{*}\right)=\{0\}$ and $\operatorname{Ker}\left(I-L_{K}^{*} K^{*}\right)=\{0\}$, respectively. From representations (2.1) and (2.2) we also note that $R\left(I+L^{*} K^{*}\right)=H$ and $R\left(I-L_{K}^{*} K^{*}\right)=H$, since $D\left(L^{*}\right)=D\left(L_{K}^{*}\right)$. The inverse operators $\left(I+L^{*} K^{*}\right)^{-1}$ and $\left(I-L_{K}^{*} K^{*}\right)^{-1}$ of the closed operators $I-L_{K}^{*} K^{*}$ and $I+L^{*} K^{*}$, respectively, are closed. Then the closed operators $\left(I+L^{*} K^{*}\right)^{-1}$ and $\left(I-L_{K}^{*} K^{*}\right)^{-1}$, defined on the whole of $H$, are bounded.

Under the assumptions of Lemma 2.3 the operators $K L$ and $K L_{K}$ will be (see [4) restrictions of the bounded operators $\overline{K L}$ and $\overline{K L}_{K}$, respectively, where the bar denotes the closure of operators in $H$. Thus $\left(I-L_{K}^{*} K^{*}\right)^{-1}=I+L^{*} K^{*}$ and $\left(I-\overline{K L}_{K}\right)^{-1}=$ $I+\overline{K L}$.

In what follows, we need the following theorem
Theorem 2.1 (Theorem 1.1 [5, p. 307]). The sequence $\left\{\psi_{j}\right\}_{j=1}^{\infty}$ biorthogonal to a basis $\left\{\phi_{j}\right\}_{j=1}^{\infty}$ of a Hilbert space $H$ is also a basis of $H$.

## 3 Proof of Theorem 1.1

In this section we prove our main result Theorem 1.1 ,
Proof. We transform (1.2) to the form

$$
\begin{equation*}
L_{K}^{-1}=L^{-1}+K=(I+K L) L^{-1} . \tag{3.1}
\end{equation*}
$$

By Lemma 2.1 and Lemma 2.3 the operators $K L$ and $K L_{K}$ are bounded and $I+K L$ is invertible with

$$
(I+K L)^{-1}=I-K L_{K}
$$

Then we have

$$
\begin{aligned}
A_{K}^{-1} & =(I+K L)^{-1} L_{K}^{-1}(I+K L) \\
& =(I+K L)^{-1}(I+K L) L^{-1}(I+K L)=L^{-1}(I+K L) .
\end{aligned}
$$

Hence, by Corollary 1 [6, p. 259] we have $D\left(A_{K}\right)=D(L)$ and

$$
A_{K}=\left(I-K L_{K}\right) L=L-K L_{K} L
$$

Corollary 3.1. Suppose the hypothesis of Theorem 1.1 is satisfied. Then a correct extension $L_{K}^{*}$ of a minimal operator $M_{0}$ is similar to the correct operator

$$
A_{K}^{*}=L^{*}\left(I-L_{K}^{*} K^{*}\right)
$$

on

$$
D\left(A_{K}^{*}\right)=\left\{v \in H:\left(I-L_{K}^{*} K^{*}\right) v \in D\left(L^{*}\right)\right\}
$$

## 4 An application of Theorem 1.1 to n-order differentiation operator

In this section, we give some applications of the main result to differential operators.
As a maximal operator $\widehat{L}$ in $L^{2}(0,1)$, we consider

$$
\widehat{L} y=y^{n}
$$

with domain $D(\widehat{L})=W_{2}^{n}(0,1), n \in \mathbb{N}$. Then the minimal operator $L_{0}$ is the restriction of $\widehat{L}$ on $D\left(L_{0}\right)=W_{2}^{n}(0,1)$. As a fixed boundary correct extension $L$ of the minimal operator $L_{0}$, we take the restriction of $\widehat{L}$ on

$$
D(L)=\left\{y \in W_{2}^{n}(0,1): y^{(i)}(0)+y^{(i)}(1)=0, i=1,2, \ldots, n-1\right\} .
$$

We find the inverse to all correct restrictions of $L_{K} \subset \widehat{L}$

$$
L_{K}^{-1}=L^{-1}+K
$$

where

$$
K f=\sum_{i=1}^{n} w_{i}(x) \int_{0}^{1} f(t) \bar{\sigma}_{i}(t) d t, \quad \sigma_{i} \in L^{2}(0,1)
$$

and $w_{i} \in \operatorname{Ker} \widehat{L}, i=1,2, \ldots, n$ are linearly independent functions with the properties

$$
w_{i}^{(k-1)}=\left\{\begin{array}{ll}
1, & i=k, \\
0, & i \neq k,
\end{array} \quad i, k=1,2, \ldots, n .\right.
$$

Then the operator $L_{K}$ is the restriction of $\widehat{L}$ on

$$
D\left(L_{K}\right)=\left\{u \in W_{2}^{n}(0,1): u^{(k-1)}(0)+u^{(k-1)}(1)=\int_{0}^{1} u^{(n)}(t) \bar{\sigma}_{k}(t) d t, k=1,2, \ldots, n\right\}
$$

We will consider restrictions of $L_{K}$ with dense domains in $L^{2}(0,1)$, that is,

$$
\overline{D\left(L_{K}\right)}=L^{2}(0,1)
$$

If $R\left(K^{*}\right) \subset D\left(L^{*}\right)$, then by Corollary 3.1 the operators $\overline{K L}$ and $\overline{K L}_{K}$ will be bounded in $L^{2}(0,1)$ (where bar denotes closure). Since $\overline{K L}$ is a compact operator, then by Lemma [2.3 the operator $I+K L$ is invertible and $(I+K L)^{-1}=I-K L_{K}$. The operator $\overline{K L}$ is bounded if and only if

$$
\sigma_{i} \in D\left(L^{*}\right)=\left\{\sigma_{i} \in W_{2}^{n}(0,1): \sigma_{i}^{(k-1)}(0)+\sigma_{i}^{(k-1)}(1)=0, \quad i, k=1,2, \ldots, n\right\}
$$

Hence, we have

$$
K L y=\sum_{i=1}^{n} w_{i}(x) \int_{0}^{1} y^{(n)}(t) \bar{\sigma}_{i}(t) d t=(-1)^{n} \sum_{i=1}^{n} w_{i}(x) \int_{0}^{1} y(t) \bar{\sigma}_{i}^{(n)}(t) d t
$$

We find the operator $K L_{K}$. For this, we invert the operator

$$
(I+K L) y=y+(-1)^{n} \sum_{i=1}^{n} w_{i}(x) \int_{0}^{1} y(t) \bar{\sigma}_{i}^{(n)}(t) d t=u
$$

where $y \in D(L), u \in D\left(L_{K}\right)$. Then we can write

$$
y=\left(I-K L_{K}\right) u=u-(-1)^{n} \sum_{i=1}^{n} w_{i}(x) \sum_{j=1}^{n} \beta_{i j} \int_{0}^{1} u(t) \bar{\sigma}_{j}^{(n)}(t) d t
$$

where $\beta_{i j}, \quad i, j=1,2, \ldots, n$ is an elements of the inverse matrix $U^{-1}$ of a matrix $U$.

$$
U=\left(\begin{array}{cccccc}
1+(-1)^{n-1} \bar{\sigma}_{1}^{(n-1)}(0) & (-1)^{n-2} \bar{\sigma}_{1}^{(n-2)}(0) & \cdots & \bar{\sigma}_{1}^{(2)}(0) & -\bar{\sigma}_{1}^{(1)}(0) & \bar{\sigma}_{1}(0) \\
(-1)^{n-1} \bar{\sigma}_{2}^{(n-1)}(0) & 1+(-1)^{n-2} \bar{\sigma}_{2}^{(n-2)}(0) & \cdots & \bar{\sigma}_{2}^{(2)}(0) & -\bar{\sigma}_{2}^{(1)}(0) & \bar{\sigma}_{2}(0) \\
\vdots & \vdots & \ddots & \vdots & \vdots & \vdots \\
(-1)^{n-1} \bar{\sigma}_{n}^{(n-1)}(0) & (-1)^{n-2} \bar{\sigma}_{n}^{(n-2)}(0) & \cdots & \bar{\sigma}_{n}^{(2)}(0) & -\bar{\sigma}_{n}^{(1)}(0) & 1+\bar{\sigma}_{n}(0)
\end{array}\right)
$$

Note that the conditions $R\left(K^{*}\right) \subset D\left(L^{*}\right)$ and $\overline{D\left(L_{K}\right)}=L^{2}(0,1)$ imply that $\operatorname{det} U \neq 0$. Thereby, the operator

$$
K L_{K} u=(-1)^{n} \sum_{i=1}^{n} w_{i}(x) \sum_{j=1}^{n} \beta_{i j} \int_{0}^{1} u(t) \bar{\sigma}_{j}^{(n)}(t) d t
$$

is a bounded operator in $L^{2}(0,1)$. Then the operator $A_{K}$ has the form

$$
A_{K} v=L v-\overline{K L}_{K} L v=v^{(n)}-(-1)^{n} \sum_{i=1}^{n} w_{i}(x) \sum_{j=1}^{n} \beta_{i j} \int_{0}^{1} v^{(n)}(t) \bar{\sigma}_{j}^{(n)}(t) d t
$$

on

$$
D\left(A_{K}\right)=D(L)=\left\{v \in W_{2}^{n}(0,1): v^{(k-1)}(0)+v^{(k-1)}(1)=0, \quad k=1,2, \ldots, n\right\}
$$

The operator $A_{K}$ can be written as

$$
A_{K} v=v^{(n)}-(-1)^{n} \sum_{i=1}^{n} w_{i}(x) \sum_{j=1}^{n} \beta_{i j} F_{j}(v)
$$

where

$$
F_{j}(v)=<F_{j}, v>=\int_{0}^{1} v^{(n)}(t) \bar{\sigma}_{j}^{(n)}(t) d t, \quad j=1,2, \ldots, n
$$

It can be seen that $F_{j} \in W_{2}^{-n}(0,1)$ in the sense of Lions-Margins (see [7]).
We transform the boundary conditions of $L_{K}$ to the form

$$
U\left(\begin{array}{c}
u(0)+u(1) \\
u^{(1)}(0)+u^{(1)}(1) \\
\vdots \\
u^{(n-1)}(0)+u^{(n-1)}(1)
\end{array}\right)=\left(\begin{array}{c}
\int_{0}^{1} u(t) \bar{\sigma}_{1}^{(n)}(t) d t \\
\int_{0}^{1} u(t) \bar{\sigma}_{2}^{(n)}(t) d t \\
\vdots \\
\int_{0}^{1} u(t) \bar{\sigma}_{n}^{(n)}(t) d t
\end{array}\right)
$$

Then we get

$$
\begin{equation*}
u^{(i-1)}(0)+u^{(i-1)}(1)=\sum_{j=1}^{n} \beta_{i j} \int_{0}^{1} u(t) \bar{\sigma}_{j}^{(n)}(t) d t, \quad i=1,2, \ldots, n \tag{4.1}
\end{equation*}
$$

where $u \in D\left(L_{K}\right), \quad \sigma_{j}^{(n)} \in L^{2}(0,1), j=1,2, \ldots, n$. The boundary condition (4.1) is regular in Shkalikov sense (see [8]). Then, by virtue of [8], the operator $L_{K}$ has a
system of root vectors forming a Riesz basis with brackets in $L^{2}(0,1)$. Thereby the operator $A_{K}$, being similar to the operator $L_{K}$, also has a basis with brackets property. The eigenvalues of these operators coincide. If $\left\{u_{k}\right\}_{1}^{\infty}$ are eigenfunctions of the operator $L_{K}$, then the eigenfunctions $v_{k}$ of the operator $A_{K}$ are related to them by the relations

$$
u_{k}=(I+K L) v_{k}=v_{k}+(-1)^{n} \sum_{i=1}^{n} w_{i}(x) \int_{0}^{1} v_{k}(t) \bar{\sigma}_{i}^{(n)}(t) d t, \quad k=1,2, \ldots, n
$$

If, in particular, we take

$$
\sigma_{i}^{(n)}(x)=\operatorname{sign}\left(x-x_{i}\right), \quad 0<x_{i}<1, \quad i=1,2, \ldots, n,
$$

then we get

$$
F_{i}(v)=-2 v^{(n-1)}\left(x_{i}\right), \quad i=1,2, \ldots, n .
$$

By Corollary 3.1, Theorem [2.1, and [9, p.928], we can assert that the system of root vectors of the adjoint operator

$$
A_{K}^{*} v=(-1)^{n} \frac{d^{n}}{d x^{n}}\left[v(x)-(-1)^{n} \sum_{i, j=1}^{n} \bar{\beta}_{i j} \sigma_{j}^{(n)}(x) \int_{0}^{1} v(t) w_{i}(t) d t\right],
$$

on

$$
D\left(A_{K}^{*}\right)=\left\{v \in L^{2}(0,1): v(x)-(-1)^{n} \sum_{i, j=1}^{n} \bar{\beta}_{i j} \sigma_{j}^{(n)}(x) \int_{0}^{1} v(t) w_{i}(t) d t \in D(L)\right\}
$$

form a Riesz basis with brackets in $L^{2}(0,1)$.

## 5 Example in case $n=2$

If the maximal operator $\widehat{L}$ acts as

$$
\widehat{L} y=-y^{\prime \prime}
$$

on the domain $D(\widehat{L})=W_{2}^{2}(0,1)$, then the minimal operator $L_{0}$ is the restriction of $\widehat{L}$ on $D\left(L_{0}\right)=\stackrel{\circ}{W}_{2}^{2}(0,1)$. As a fixed operator $L$ we take the restriction of $\widehat{L}$ on

$$
D(L)=\left\{y \in W_{2}^{2}(0,1): y(0)=y(1)=0\right\} .
$$

Then

$$
\begin{aligned}
L_{K}^{-1} f=L^{-1} f+K f= & -\int_{0}^{x}(x-t) f(t) d t+x \int_{0}^{1}(1-t) f(t) d t \\
& +(1-x) \int_{0}^{1} f(t) \bar{\sigma}_{1}(t) d t+x \int_{0}^{1} f(t) \bar{\sigma}_{2}(t) d t \\
K f= & (1-x) \int_{0}^{1} f(t) \bar{\sigma}_{1}(t) d t+x \int_{0}^{1} f(t) \bar{\sigma}_{2}(t) d t
\end{aligned}
$$

$K L$ is bounded in $L^{2}(0,1)$, if $R\left(K^{*}\right) \subset D\left(L^{*}\right)=D(L)$, that is,

$$
\sigma_{1}, \sigma_{2} \in D(L)=\left\{\sigma_{1}, \sigma_{2} \in W_{2}^{2}(0,1): \sigma_{1}(0)=\sigma_{1}(1)=\sigma_{2}(0)=\sigma_{2}(1)=0\right\}
$$

and has the form

$$
K L y=-(1-x) \int_{0}^{1} y(t) \bar{\sigma}_{1}^{\prime \prime}(t) d t-x \int_{0}^{1} y(t) \bar{\sigma}_{2}^{\prime \prime}(t) d t
$$

The operator $K L_{K}$ is also bounded in $L^{2}(0,1)$ and

$$
\begin{aligned}
K L_{K} u= & -\frac{1-x}{\Delta}\left[\left(1-\bar{\sigma}_{2}^{\prime}(1)\right) \int_{0}^{1} u(t) \bar{\sigma}_{1}^{\prime \prime}(t) d t+\bar{\sigma}_{1}^{\prime}(1) \int_{0}^{1} u(t) \bar{\sigma}_{2}^{\prime \prime}(t) d t\right] \\
& +\frac{x}{\Delta}\left[\left(1+\bar{\sigma}_{1}^{\prime}(0)\right) \int_{0}^{1} u(t) \bar{\sigma}_{2}^{\prime \prime}(t) d t-\bar{\sigma}_{2}^{\prime}(0) \int_{0}^{1} u(t) \bar{\sigma}_{1}^{\prime \prime}(t) d t\right]
\end{aligned}
$$

where

$$
\Delta=\left(1+\bar{\sigma}_{1}^{\prime}(0)\right)\left(1-\bar{\sigma}_{2}^{\prime}(1)\right)+\bar{\sigma}_{2}^{\prime}(0) \bar{\sigma}_{1}^{\prime}(1)
$$

Then the operator $A_{K}$ has the form

A_{K} v= & -v^{\prime \prime}-\frac{1}{\Delta}\left[\left((1-x)\left(1-\bar{\sigma}_{2}^{\prime}(1)\right)-x \bar{\sigma}_{2}^{\prime}(0)\right) \int_{0}^{1} v^{\prime \prime}(t) \bar{\sigma}_{1}^{\prime \prime}(t) d t\right. \\
& \left.+\left((1-x) \bar{\sigma}_{1}^{\prime}(1)+x\left(1+\bar{\sigma}_{1}^{\prime}(0)\right)\right) \int_{0}^{1} v^{\prime \prime}(t) \bar{\sigma}_{2}^{\prime \prime}(t) d t\right]
\end{aligned}

on

D\left(A_{K}\right)=D(L)=\left\{v \in W_{2}^{2}(0,1): v(0)=v(1)=0\right\}
$$

where $\sigma_{1}^{\prime \prime}, \sigma_{2}^{\prime \prime} \in L^{2}(0,1)$.
We rewrite the operator $A_{K}$ in the form

a(x)=-\frac{1}{\Delta}\left((1-x)\left(1-\bar{\sigma}_{2}^{\prime}(1)\right)-x \bar{\sigma}_{2}^{\prime}(0)\right), \quad F_{1}(v)=\int_{0}^{1} v^{\prime \prime}(t) \bar{\sigma}_{1}^{\prime \prime}(t) d t \\
b(x)=-\frac{1}{\Delta}\left((1-x) \bar{\sigma}_{1}^{\prime}(1)+x\left(1+\bar{\sigma}_{1}^{\prime}(0)\right), \quad F_{2}(v)=\right) \int_{0}^{1} v^{\prime \prime}(t) \bar{\sigma}_{2}^{\prime \prime}(t) d t
\end{array}
$$

Note that $F_{1}, F_{2} \in W_{2}^{-2}(0,1)$ in the sense of Lions-Margins (see [7]).
Further, we see that the operator $L_{K}$ acts as $\widehat{L}$ on the domain

\end{array}\right)=\binom{-\int_{0}^{1} u(t) \bar{\sigma}_{1}^{\prime \prime}(t) d t}{-\int_{0}^{1} u(t) \bar{\sigma}_{2}^{\prime \prime}(t) d t}\right\}
$$

and

J_{13}=\left(1+\bar{\sigma}_{1}^{\prime}(0)\right)\left(1-\bar{\sigma}_{2}^{\prime}(1)\right)+\bar{\sigma}_{2}^{\prime}(0) \bar{\sigma}_{1}^{\prime}(1)=\Delta \neq 0
$$

since $R\left(K^{*}\right) \subset D\left(L^{*}\right)$ and $\overline{D\left(L_{K}\right)}=L^{2}(0,1)$. Then the left hand of this boundary condition is non-degenerate according to Marchenko [10], hence regularly according to Birkhoff (see [8]). By virtue of Theorem (see [8, p. 15]), the system of root vectors of the operator $L_{K}$ form a Riesz basis with brackets in $L^{2}(0,1)$. Thus, by virtue of Theorem (1.1) the system of root vectors of $A_{K}$ also form a Riesz basis with brackets and the eigenvalues of $L_{K}$ and $A_{K}$ coincide, and the eigenfunctions are related to each other as follows

If in the particular case we take

& \bar{\sigma}_{2}^{\prime \prime}(x)=x\left[\operatorname{sign}\left(x-x_{1}\right)-\operatorname{sign}\left(x-x_{2}\right)\right], \tag{5.2}
\end{align*}

where $0<x_{1}<x_{2}<1$, then we get

& F_{2}(v)=2 x_{2} v^{\prime}\left(x_{2}\right)-2 x_{1} v^{\prime}\left(x_{1}\right)-2 v\left(x_{2}\right)+2 v\left(x_{1}\right)
\end{aligned}
$$

in (5.1).
In the case $n=2$, by Corollary 3.1, Theorem 2.1, and [9, p. 928], we can assert that the system of root vectors of the operator

A_{K}^{*} v=(-1)^{2} \frac{d^{2}}{d x^{2}}\left[v(x)-c(x) \int_{0}^{1}(1-t) v(t) d t-d(x) \int_{0}^{1} t v(t) d t\right]
$$

on

D\left(A_{K}^{*}\right)=\left\{v \in L^{2}(0,1): v(x)-c(x) \int_{0}^{1}(1-t) v(t) d t-d(x) \int_{0}^{1} t v(t) d t \in D(L)\right\},
$$

form a Riesz basis with brackets in $L^{2}(0,1)$, where

& c(x)=-\frac{1}{\Delta}\left[\left(1-\sigma_{2}^{\prime}(1)\right) \sigma_{1}^{\prime \prime}(x)+\sigma_{1}^{\prime}(1) \sigma_{2}^{\prime \prime}(x)\right], \\
& d(x)=\frac{1}{\Delta}\left[\left(1+\sigma_{1}^{\prime}(0)\right) \sigma_{2}^{\prime \prime}(x)-\sigma_{2}^{\prime}(0) \sigma_{1}^{\prime \prime}(x)\right] .
\end{aligned}
$$

Note that

\sigma_{1}^{\prime \prime}, \sigma_{2}^{\prime \prime} \in L^{2}(0,1), \quad D(L)=\left\{y \in W_{2}^{2}(0,1): y(0)=y(1)=0\right\} .
$$

For clarity, we consider the special case (5.2), then we have

& d(x)=\frac{\operatorname{sign}\left(x-x_{1}\right)-\operatorname{sign}\left(x-x_{2}\right)}{\Delta}\left[\left(1+x_{2}-x_{1}-\frac{x_{2}^{2}-x_{1}^{2}}{2}\right) x-\frac{x_{2}^{2}-x_{1}^{2}}{2}+\frac{x_{2}^{3}-x_{1}^{3}}{3}\right] .
\end{aligned}

The domain of $A_{K}^{*}$ will have the form

v\left(x_{1}-0\right)-v\left(x_{1}+0\right)=-c\left(x_{1}+0\right) \int_{0}^{1}(1-t) v(t) d t-d\left(x_{1}+0\right) \int_{0}^{1} t v(t) d t \\
v\left(x_{2}+0\right)-v\left(x_{2}-0\right)=-c\left(x_{2}-0\right) \int_{0}^{1}(1-t) v(t) d t-d\left(x_{2}-0\right) \int_{0}^{1} t v(t) d t \\
v^{\prime}\left(x_{1}-0\right)-v^{\prime}\left(x_{1}+0\right)=-c^{\prime}\left(x_{1}+0\right) \int_{0}^{1}(1-t) v(t) d t-d^{\prime}\left(x_{1}+0\right) \int_{0}^{1} t v(t) d t \\
\left.v^{\prime}\left(x_{2}+0\right)-v^{\prime}\left(x_{2}-0\right)=-c^{\prime}\left(x_{2}-0\right) \int_{0}^{1}(1-t) v(t) d t-d^{\prime}\left(x_{2}-0\right) \int_{0}^{1} t v(t) d t\right\}

& c\left(x_{1}+0\right)=\frac{2}{\Delta}\left(1+\frac{x_{2}^{3}-x_{1}^{3}}{3}-\frac{x_{2}^{2}-x_{1}^{2}}{2} x_{1}\right), \\
& d\left(x_{1}+0\right)=-\frac{2}{\Delta}\left(\left(1+x_{2}-x_{1}-\frac{x_{2}^{2}-x_{1}^{2}}{2}\right) x_{1}-\frac{x_{2}^{2}-x_{1}^{2}}{2}+\frac{x_{2}^{3}-x_{1}^{3}}{3}\right), \\
& c\left(x_{2}-0\right)=\frac{2}{\Delta}\left(1+\frac{x_{2}^{3}-x_{1}^{3}}{3}-\frac{x_{2}^{2}-x_{1}^{2}}{2} x_{2}\right), \\
& d\left(x_{2}-0\right)=-\frac{2}{\Delta}\left(\left(1+x_{2}-x_{1}-\frac{x_{2}^{2}-x_{1}^{2}}{2}\right) x_{2}-\frac{x_{2}^{2}-x_{1}^{2}}{2}+\frac{x_{2}^{3}-x_{1}^{3}}{3}\right), \\
& c^{\prime}\left(x_{1}+0\right)=-\frac{1}{\Delta}\left(x_{2}^{2}-x_{1}^{2}\right), \\
& d^{\prime}\left(x_{1}+0\right)=\frac{2}{\Delta}\left(1+x_{1}-x_{2}+\frac{x_{2}^{2}-x_{1}^{2}}{2}\right), \\
& c^{\prime}\left(x_{2}-0\right)=c^{\prime}\left(x_{1}+0\right), \quad d^{\prime}\left(x_{2}-0\right)=d^{\prime}\left(x_{1}+0\right), \\
& \Delta=1+x_{2}-x_{1}-\frac{x_{2}^{2}-x_{1}^{2}}{2}+\frac{x_{2}^{3}-x_{1}^{3}}{3}+\frac{x_{2}-x_{1}}{12}\left(\left(x_{2}-x_{1}\right)^{3}+6 x_{1} x_{2}\right) \neq 0,
\end{aligned}

since $x_{1}, x_{2} \in(0,1)$.
And the operator $A_{K}^{*}$ acts as follows

c^{\prime \prime}(x)=\frac{2}{\Delta} & {\left[1+\frac{x_{2}^{3}-x_{1}^{3}}{3}+\frac{x_{2}^{2}-x_{1}^{2}}{2}\left(x_{2}-x_{1}\right)\right]\left(\delta^{\prime}\left(x-x_{1}\right)-\delta^{\prime}\left(x-x_{2}\right)\right) } \\
& -\frac{1}{\Delta}\left(x_{2}^{2}-x_{1}^{2}\right)\left(\delta\left(x-x_{1}\right)-\delta\left(x-x_{2}\right)\right) \\
d^{\prime \prime}(x)=\frac{2}{\Delta} & {\left[\left(1+x_{2}-x_{1}-\frac{x_{2}^{2}-x_{1}^{2}}{2}\right)\left(x_{1}-x_{2}\right)-\frac{x_{2}^{2}-x_{1}^{2}}{2}+\frac{x_{2}^{3}-x_{1}^{3}}{3}\right] } \\
& \times\left(\delta^{\prime}\left(x-x_{1}\right)-\delta^{\prime}\left(x-x_{2}\right)\right) \\
& -\frac{1}{\Delta}\left(1+x_{2}-x_{1}+\frac{x_{2}^{2}-x_{1}^{2}}{2}\right)\left(\delta\left(x-x_{1}\right)-\delta\left(x-x_{2}\right)\right)
\end{aligned}
$$

here $\delta$ is the Dirac delta function.
