# Rate of convergence for particle approximation of PDEs in Wasserstein space *

#### Abstract

We prove a rate of convergence for the $N$-particle approximation of a second-order partial differential equation in the space of probability measures, like the Master equation or Bellman equation of mean-field control problem under common noise. The rate is of order $1 / N$ for the pathwise error on the solution $v$ and of order $1 / \sqrt{N}$ for the $L^{2}$-error on its $L$-derivative $\partial_{\mu} v$. The proof relies on backward stochastic differential equations techniques.


## 1 Introduction

Let us consider the second-order parabolic partial differential equation (PDE) on the Wasserstein space $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ of square-integrable probability measures on $\mathbb{R}^{d}$, in the form:

Here, $\partial_{\mu} v(t, \mu)$ is the $L$-derivative on $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ (see CD18a]) of $\mu \mapsto v(t, \mu)$, and it is a function from $\mathbb{R}^{d}$ into $\mathbb{R}^{d}, \partial_{x} \partial_{\mu} v(t, \mu)$ is the usual derivative on $\mathbb{R}^{d}$ of $x \in \mathbb{R}^{d} \mapsto \partial_{\mu} v(t, \mu)(x) \in \mathbb{R}^{d}$, hence valued in $\mathbb{R}^{d \times d}$ the set of $d \times d$-matrices with real coefficients, and $\partial_{\mu}^{2} v(t, \mu)$ is the $L$-derivative of $\mu \mapsto \partial_{\mu} v(t, \mu)($.$) , hence a function from \mathbb{R}^{d} \times \mathbb{R}^{d}$ into $\mathbb{R}^{d \times d}$. The terminal condition is given by a real-valued function $G$ on $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$, and the Hamiltonian $\mathcal{H}$ of this PDE is assumed to be in semi-linear (non linear w.r.t. $v, \partial_{\mu} v$, and linear w.r.t. $\partial_{x} \partial_{\mu}, \partial_{\mu}^{2} v$ ) expectation form:

& +\frac{1}{2} \int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \operatorname{tr}\left(\sigma_{0}(t, x, \mu) \sigma_{0}^{\top}\left(t, x^{\prime}, \mu\right) \gamma_{0}\left(x, x^{\prime}\right)\right) \mu(\mathrm{d} x) \mu\left(\mathrm{d} x^{\prime}\right),

for some real-valued measurable function $H$ defined on $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R} \times \mathbb{R}^{d}$, and where $\sigma, \sigma_{0}$ are measurable functions on $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$, valued respectively in $\mathbb{R}^{d \times n}$, and $\mathbb{R}^{d \times m}$. Here $\operatorname{tr}(M)$ denotes the trace of a square matrix $M$, while $M^{\top}$ is its transpose, and . is the scalar product.

PDEs in Wasserstein space have been largely studied in the literature over the last years, notably with the emergence of the mean-field game theory, and we mention among others the

[^0]papers BFY15], GS15], PW18], Car+19], SZ19], Bur+20], and other references in the twovolume monographs [CD18a]-[CD18b].

An important application concerns mean-field type control problems with common noise. The controlled stochastic McKean-Vlasov dynamics is given by

where $W$ is a $n$-dimensional Brownian motion, independent of a $m$-dimensional Brownian motion $W^{0}$ (representing the common noise) on a filtered probability space $\left(\Omega, \mathcal{F}, \mathbb{F}=\left(\mathcal{F}_{t}\right)_{0 \leq t \leq T}, \mathbb{P}\right)$, the control process $\alpha$ is $\mathbb{F}$-adapted valued in some Polish space $A$, and here $\mathbb{P}^{0}$ denotes the conditional law given $W^{0}$. The value function defined on $[0, T] \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ by

(here $\mathbb{E}_{t, \mu}[\cdot]$ is the conditional expectation given that the law at time $t$ of $X$ solution to (1.3) is equal to $\mu$ ) is shown to satisfy the Bellman equation (1.1)-(1.2) (see [BFY13], [CP19], [DPT19]) with $G(\mu)=\int g(x, \mu) \mu(d x), \sigma, \sigma_{0}$ as in (1.3) and

We now consider a finite-dimensional approximation of the PDE (1.1)-(1.2) in the Wasserstein space. This can be derived formally by looking at the PDE for $\mu$ to averages of Dirac masses, and it turns out that the corresponding PDE takes the form

where $\bar{\mu}($.$) is the empirical measure function defined by \bar{\mu}(\boldsymbol{x})=\frac{1}{N} \sum_{i=1}^{N} \delta_{x_{i}}$, for any $\boldsymbol{x}=\left(x_{1}, \ldots\right.$, $\left.x_{N}\right), N \in \mathbb{N}^{*}$, and $\Sigma_{N}=\left(\Sigma_{N}^{i j}\right)_{i, j \in \llbracket 1, N \rrbracket}$ is the $\mathbb{R}^{N d \times N d}$-valued function with block matrices $\Sigma_{N}^{i j}(t, \boldsymbol{x})$ $=\sigma\left(t, x_{i}, \bar{\mu}(\boldsymbol{x})\right) \sigma^{\top}\left(t, x_{j}, \bar{\mu}(\boldsymbol{x})\right) \delta_{i j}+\sigma_{0}\left(t, x_{i}, \bar{\mu}(\boldsymbol{x})\right) \sigma_{0}^{\top}\left(t, x_{j}, \bar{\mu}(\boldsymbol{x})\right) \in \mathbb{R}^{d \times d}$. In the special case where $H$ has the form (1.4), we notice that (1.5) is the Bellman equation for the $N$-cooperative problem, whose convergence to the mean-field control problem has been studied in Lac17], CD18b], LT19; LT20], when $\sigma_{0} \equiv 0$ (no common noise), and recently by [Dje20] in the common noise case. We point out that these works do not consider the same master equation. In particular their master equation is stated on $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ and is linear in $\partial_{\mu} u$ whereas we allow a non-linear dependence in this derivative. Moreover our master equation is in expectation form. In [LT20] the master equation is approached by a system of $N$ coupled PDEs on $[0, T] \times\left(\mathbb{R}^{d}\right)^{N}$ whereas we consider a single approximating PDE on $[0, T] \times\left(\mathbb{R}^{d}\right)^{N}$. For more general Hamiltonian functions $H$, it has been recently proved in GMS21] that the sequence of viscosity solutions $\left(v^{N}\right)_{N}$ to (1.5) converge locally uniformly to the viscosity solution $v$ to (1.1) when $\sigma=0$ and $\sigma_{0}$ does not depend on space and measure arguments. For a detailed comparison between this work and ours, we refer to Remark 2.9.

In this paper, we adopt a probabilistic approach by considering a backward stochastic differential equation (BSDE) representation for the finite-dimensional PDE (1.5) according to the classical work [PP90]. The solution $\left(Y^{N}, \boldsymbol{Z}^{N}=\left(Z^{i, N}\right)_{1 \leq i \leq N}\right)$ to this BSDE is written with an underlying forward particle system $\boldsymbol{X}^{N}=\left(X^{i, N}\right)_{1 \leq i \leq N}$ of a McKean-Vlasov SDE, and connected to the PDE (1.5) via the Feynman-Kac formula: $Y_{t}^{N}=v^{N}\left(t, \boldsymbol{X}_{t}^{N}\right), Z_{t}^{i, N}=D_{x_{i}} v^{N}\left(t, \boldsymbol{X}_{t}^{i, N}\right)$,
$0 \leq t \leq T$. By using BSDE techniques, our main contribution is to show a rate of convergence of order $1 / N$ of $\left|Y_{t}^{N}-v\left(t, \bar{\mu}\left(\boldsymbol{X}_{t}^{N}\right)\right)\right|$, and also of $\left|N Z_{t}^{i, N}-\partial_{\mu} v\left(t, \bar{\mu}\left(\boldsymbol{X}_{t}^{N}\right)\right)\left(X_{t}^{i, N}\right)\right|^{2}, i=1, \ldots, N$, for suitable norms, and under some regularity conditions on $v$ (see Theorem 2.6 and Theorem 2.7). This rate of convergence on the particles approximation of $v$ and its $L$-derivative is new to the best of our knowledge. We point out that classical BSDE arguments for proving the rate of convergence do not apply directly due to the presence of the factor $N$ in front of $D_{x_{i}} v^{N}$ in the generator $H$, and we rather use linearization arguments and change of probability measures to overcome these issues. Another issue is due to the fact that the BSDE dimension $d \times N$ is exploding with the number of particles therefore we have to track down the influence of the dimension in the estimations, whereas classical BSDE works usually consider a fixed dimension $d$ which is incorporated into constants.

The outline of the paper is organized as follows. In Section 2, we formulate the particle approximation of the PDE and its BSDE representation, and state the rate of convergence for $v$ and its $L$-derivative. Section 3 is devoted to the proof of these results.

## 2 Particles approximation of Wasserstein PDEs

The formal derivation of the finite-dimensional approximation PDE is obtained as follows. We look at the PDE (1.1)-(1.2) for $\mu=\bar{\mu}(\boldsymbol{x})=\frac{1}{N} \sum_{i=1}^{N} \delta_{x_{i}} \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$, when $\boldsymbol{x}=\left(x_{i}\right)_{i \in \llbracket 1, N \rrbracket}$ runs over $\left(\mathbb{R}^{d}\right)^{N}$. By setting $\tilde{v}^{N}(t, \boldsymbol{x})=v(t, \bar{\mu}(\boldsymbol{x}))$, and assuming that $v$ is smooth, we have for all $(i, j) \in$ $\llbracket 1, N \rrbracket$ (see Proposition 5.35 and Proposition 5.91 in [D18a]):

By substituting into the $\operatorname{PDE}(1.1)-(1.2)$ for $\mu=\bar{\mu}(\boldsymbol{x})$, and using (2.1), we then see that $\tilde{v}^{N}$ satisfies the relation:

+\frac{1}{2} \sum_{i \neq j \in \llbracket 1, N \rrbracket} \operatorname{tr}\left(\sigma_{0}\left(t, x_{i}, \bar{\mu}(\boldsymbol{x})\right) \sigma_{0}^{\top}\left(t, x_{j}, \bar{\mu}(\boldsymbol{x})\right) D_{x_{i} x_{j}}^{2} \tilde{v}^{N}\right) \\
+\frac{1}{2 N^{2}} \sum_{i=1}^{N} \operatorname{tr}\left(\sigma_{0} \sigma_{0}^{\top}\left(t, x_{i}, \bar{\mu}(\boldsymbol{x})\right) \partial_{\mu}^{2} v(t, \bar{\mu}(\boldsymbol{x}))\left(x_{i}, x_{i}\right)\right)=0

for $\left(t, \boldsymbol{x}=\left(x_{i}\right)_{i \in \llbracket 1, N \rrbracket}\right) \in[0, T) \times\left(\mathbb{R}^{d}\right)^{N}$, together with the terminal condition $\tilde{v}^{N}(t, \boldsymbol{x})=G(\bar{\mu}(\boldsymbol{x}))$. By neglecting the terms $\partial_{\mu}^{2} v / N^{2}$ in the above relation, we obtain the PDE (1.5) for $v^{N} \simeq \tilde{v}^{N}$. The purpose of this section is to rigorously justify this approximation and state a rate of convergence for $v^{N}$ towards $v$, as well as a convergence for their gradients.

### 2.1 Particles BSDE approximation

Let us introduce an arbitrary measurable $\mathbb{R}^{d}$-valued function $b$ on $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$, and set $B_{N}$ the $\left(\mathbb{R}^{d}\right)^{N}$-valued function defined on $[0, T] \times\left(\mathbb{R}^{d}\right)^{N}$ by $B_{N}(t, \boldsymbol{x})=\left(b\left(t, x_{i}, \bar{\mu}(\boldsymbol{x})\right)_{i \in \llbracket 1, N \rrbracket}\right.$ for
$\left(t, \boldsymbol{x}=\left(x_{i}\right)_{i \in \llbracket 1, N \rrbracket}\right) \in[0, T) \times\left(\mathbb{R}^{d}\right)^{N}$. The finite-dimensional PDE (1.5) may then be written as

\quad+\frac{1}{N} \sum_{i=1}^{N} H_{b}\left(t, x_{i}, \bar{\mu}(\boldsymbol{x}), v^{N}, N D_{x_{i}} v^{N}\right)=0, \quad \text { on }[0, T) \times\left(\mathbb{R}^{d}\right)^{N}, \\
v^{N}(T, \boldsymbol{x})=G(\bar{\mu}(\boldsymbol{x})), \quad \boldsymbol{x}=\left(x_{i}\right)_{i \in \llbracket 1, N \rrbracket} \in\left(\mathbb{R}^{d}\right)^{N},
\end{array}\right.
$$

where $H_{b}(t, x, \mu, y, z):=H(t, x, \mu, y, z)-b(t, x, \mu) . z$. For error analysis purpose, the function $b$ can be simply taken to be zero. The introduction of the function $b$ is actually motivated by numerical purpose. It corresponds indeed to the drift of training simulations for approximating the function $v^{N}$, notably by machine learning methods, and should be chosen for suitable exploration of the state space, see a detailed discussion in our companion paper Ger+21]. In this paper, we fix an arbitrary function $b$ (satisfying Lipschitz condition to be precised later).

Following PP90], it is well-known that the semi-linear PDE (2.3) admits a probabilistic representation in terms of forward backward SDE. The forward component is defined by the process $\boldsymbol{X}^{N}=\left(X^{i, N}\right)_{i \in \llbracket 1, N \rrbracket}$ valued in $\left(\mathbb{R}^{d}\right)^{N}$, solution to the SDE:

where $\sigma_{N}$ is the block diagonal matrix with block diagonals $\sigma_{N}^{i i}(t, \boldsymbol{x})=\sigma\left(t, x_{i}, \bar{\mu}(\boldsymbol{x})\right), \boldsymbol{\sigma}_{0}=$ $\left(\sigma_{0}^{i}\right)_{i \in \llbracket 1, N \rrbracket}$ is the $\left(\mathbb{R}^{d \times m}\right)^{N}$-valued function with $\boldsymbol{\sigma}_{0}^{i}(t, \boldsymbol{x})=\sigma_{0}\left(t, x_{i}, \bar{\mu}(\boldsymbol{x})\right)$, for $\boldsymbol{x}=\left(x_{i}\right)_{i \in \llbracket 1, N \rrbracket}$, $\boldsymbol{W}=\left(W^{1}, \ldots, W^{N}\right)$ where $W^{i}, i=1, \ldots, N$, are independent $n$-dimensional Brownian motions, independent of a $m$-dimensional Brownian motion $W^{0}$ on a filtered probability space $(\Omega, \mathcal{F}, \mathbb{F}=$ $\left.\left(\mathcal{F}_{t}\right)_{0 \leq t \leq T}, \mathbb{P}\right)$. Notice that $\Sigma_{N}=\sigma_{N} \sigma_{N}^{\top}+\sigma_{0} \boldsymbol{\sigma}_{0}^{\top}$, and $\boldsymbol{X}^{N}$ is the particles system of the McKeanVlasov SDE:

where $W$ is an $n$-dimensional Brownian motion independent of $W^{0}$. The backward component is defined by the pair process $\left(Y^{N}, \boldsymbol{Z}^{N}=\left(Z^{i, N}\right)_{i \in \llbracket 1, N \rrbracket}\right)$ valued in $\mathbb{R} \times\left(\mathbb{R}^{d}\right)^{N}$, solution to

& -\sum_{i=1}^{N} \int_{t}^{T}\left(Z_{s}^{i, N}\right)^{\top} \sigma_{0}\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \mathrm{d} W_{s}^{0}, \quad 0 \leq t \leq T .

We shall assume that the measurable functions $(t, x, \mu) \mapsto b(t, x, \mu), \sigma(t, x, \mu)$ satisfy a Lipschitz condition in $(x, \mu) \in \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ uniformly w.r.t. $t \in[0, T]$, which ensures the existence and uniqueness of a strong solution $\boldsymbol{X}^{N} \in \mathcal{S}_{\mathbb{F}}^{2}\left(\left(\mathbb{R}^{d}\right)^{N}\right)$ to (2.4) given an initial condition. Here, $\mathcal{S}_{\mathbb{F}}^{2}\left(\mathbb{R}^{q}\right)$ is the set of $\mathbb{F}$-adapted process $\left(V_{t}\right)_{t}$ valued in $\mathbb{R}^{q}$ s.t. $\mathbb{E}\left[\sup _{0 \leq t \leq T}\left|V_{t}\right|^{2}\right]<\infty,(|$.$| is the Euclidian$ norm on $\mathbb{R}^{q}$, and for a matrix $M$, we choose the Frobenius norm $\left.|M|=\sqrt{\operatorname{tr}\left(M M^{\top}\right)}\right)$ and the Wasserstein space $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ is endowed with the Wasserstein distance

Assuming also that the measurable function $(t, x, \mu, y, z) \mapsto H_{b}(t, x, \mu, y, z)$ is Lipschitz in $(y, z) \in \mathbb{R} \times \mathbb{R}^{d}$ uniformly with respect to $(t, x, \mu)$
$\in[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$, and the measurable function $G$ satisfies a quadratic growth condition on $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$, we have the existence and uniqueness of a solution $\left(Y^{N}, \boldsymbol{Z}^{N}=\left(Z^{i, N}\right)_{i \in \llbracket 1, N \rrbracket}\right) \in$ $\mathcal{S}_{\mathbb{F}}^{2}(\mathbb{R}) \times \mathbb{H}_{\mathbb{F}}^{2}\left(\left(\mathbb{R}^{d}\right)^{N}\right)$ to (2.6), and the connection with the PDE (2.3) (satisfied in general in the viscosity sense) via the (non linear) Feynman-Kac formula:

(when $v^{N}$ is smooth for the last relation). Here, $\mathbb{H}_{\mathbb{F}}^{2}\left(\mathbb{R}^{q}\right)$ is the set of $\mathbb{F}$-adapted process $\left(V_{t}\right)_{t}$ valued in $\mathbb{R}^{q}$ s.t. $\mathbb{E}\left[\int_{0}^{T}\left|V_{t}\right|^{2} \mathrm{~d} t\right]<\infty$.

### 2.2 Main results

We aim to analyze the particles approximation error on the solution $v$ to the PDE (1.1), and its $L$-derivative $\partial_{\mu} v$ by considering the pathwise error on $v$ :

where the initial conditions of the particles system, $X_{0}^{i, N}, i=1, \ldots, N$, are i.i.d. with distribution $\mu_{0}$.

Here, it is assumed that we have the existence and uniqueness of a classical solution $v$ to the PDE (1.1)-(1.2). More precisely, we make the following assumption:

Assumption 2.1 (Smooth solution to the Master Bellman PDE). There exists a unique solution $v$ to (1.1), which lies in $C_{b}^{1,2}\left([0, T] \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$ that is:

- $v(., \mu) \in C^{1}([0, T))$, and continuous on $[0, T]$, for any $\mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$,
- $v(t,$.$) is fully C^{2}$ on $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$, for any $t \in[0, T]$ in the sense that: $(x, \mu) \in \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \mapsto$ $\partial_{\mu} v(t, \mu)(x) \in \mathbb{R}^{d},(x, \mu) \in \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \mapsto \partial_{x} \partial_{\mu} v(t, \mu)(x) \in \mathbb{M}^{d}$, and $\left(x, x^{\prime}, \mu\right) \in \mathbb{R}^{d} \times \mathbb{R}^{d}$ $\times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \mapsto \partial_{\mu}^{2} v(t, \mu)\left(x, x^{\prime}\right) \in \mathbb{M}^{d}$, are well-defined and jointly continuous,
- there exists some constant $L>0$ s.t. for all $(t, x, \mu) \in[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$

The existence of classical solutions to mean-field PDE in Wasserstein space is a challenging problem, and beyond the scope of this paper. We refer to [Buc+17], CCD15], [SZ19], [WZ20] for conditions ensuring regularity results of some Master PDEs. Notice also that linear-quadratic mean-field control problems have explicit smooth solutions as in Assumption [2.1, see e.g. [PW18].

We also make some rather standard assumptions on the coefficients of the forward backward SDE:

Assumption 2.2 (Lipschitz condition on the coefficients of the forward backward SDE).

Remark 2.4. The Lipschitz condition on $b, \sigma$ in Assumption 2.2(i) implies that the functions $\boldsymbol{x}$ $\in\left(\mathbb{R}^{d}\right)^{N} \mapsto B_{N}(t, \boldsymbol{x})$, resp. $\sigma_{N}(t, \boldsymbol{x})$ and $\boldsymbol{\sigma}_{0}(t, \boldsymbol{x})$, defined in (2.4), are Lipschitz (with Lipschitz constant $2[b]$, resp. $2[\sigma]$ and $2\left[\sigma_{0}\right]$ ). Indeed, we have

Remark 2.5. Assumption 2.1 is verified in the case of linear quadratic control problems for which explicit smooth solutions are found in [PW18; PW1 ] respectively without and with common noise. These papers prove that the second order Lions derivative $\partial_{\mu}^{2}$ is a continuous function of time which does not depend on the $\mu, x$ arguments hence is bounded whereas $\partial_{\mu}$ is affine in both the state and the first moment of the measure thus satisfies linear growth. Notice that in general,

Assumptions 2.2 and 2.3 are not satisfied due to the quadratic nature of $H_{b}$ in the $z$. However, in the uncontrolled case

Theorem 2.7. Under Assumptions 2.1, 2.2 and [2.3, we have

Remark 2.8. Let us consider the global weak errors on $v$ and its L-derivative $\partial_{\mu} v$ along the limiting McKean-Vlasov SDE, and defined by

where $X^{i}$ has the same law than $X$, and with McKean-Vlasov dynamics as in (2.5) but driven by $W^{i}, i=1, \ldots, N$. Then, they can be decomposed as

From the conditional propagation of chaos result, which states that for any fixed $k \geq 1$, the law of $\left(X_{t}^{i, N}\right)_{\tilde{t} \in[0, T]}^{i \in \llbracket 1, k \rrbracket}$ converges toward the conditional law of $\left(X_{t}^{i}\right)_{t \in[0, T]}^{i \in \llbracket 1, k \rrbracket}$, as $N$ goes to infinity, we deduce that $\tilde{E}_{N}^{\mathrm{y}}, \tilde{E}_{N}^{\mathrm{z}} \rightarrow 0$. Furthermore, under additional assumptions on $v$, we can obtain a rate of convergence. Namely, if $v(t,$.$) is Lipschitz uniformly in t \in[0, T]$, with Lipschitz constant $[v]$, we have

where we use the rate of convergence of empirical measures in Wasserstein distance stated in [FG15] (see also Theorem 2.12 in [CD18b]), and since we have the standard estimate $\mathbb{E}\left[\sup _{0 \leq t \leq T}\left|X_{t}\right|^{4 q}\right] \leq C\left(1+\left\|\mu_{0}\right\|_{2 q}^{4 q}\right)$ by Assumption 2.2(iii). The rate of convergence in (2.10) is consistent with the one found in Theorem 6.17 [CD18b] for mean-field control problem. Furthermore, if the function $\partial_{\mu} v(t,).($.$) is Lipschitz in (x, \mu)$ uniformly in $t$, then by the rate of convergence in Theorem 2.12 of [CD18b], we have

Remark 2.9 (Comparison with GMS21]). In the related paper [GMS21] the authors consider a pure common noise case, that is $\sigma=0$ and restrict themselves to $\sigma_{0}\left(t, x_{i}, \bar{\mu}(\boldsymbol{x})\right)=\kappa I_{d}$ for $\kappa \in \mathbb{R}$. If we consider these assumptions in our smooth setting, we directly see that $\Delta Y_{s}^{N}=0$ and $\Delta Z_{s}^{N}=0 \mathbb{P}$ a.s. Indeed by (2.6) and (3.2) we notice that $\left(Y_{t}^{N}, Z_{t}^{N}\right)$ and

solve the same BSDE therefore by existence and pathwise uniqueness for Lipschitz BSDEs the result follows. Moreover, [GMS21] does not allow $H$ to depend on $y$. Our approach allows to extend their findings to the case of idiosyncratic noises and in contrast to them we are able to choose a state-dependent volatility coefficient. Moreover we provide a convergence rate for the solution. However, we have to assume existence of a smooth solution for the master equation which is a restrictive assumption.

## 3 Proof of main results

### 3.1 Proof of Theorem 2.6

Step 1. Under the smoothness condition on $v$ in Assumption 2.1, one can apply the standard Itô's $\overline{\text { formula }}$ in $\left(\mathbb{R}^{d}\right)^{N}$ to the process $\tilde{v}^{N}\left(t, \boldsymbol{X}_{t}^{N}\right)=v\left(t, \bar{\mu}\left(\boldsymbol{X}_{t}^{N}\right)\right)$, and get

which is finite by (2.8), and since $\lambda$ is bounded. This shows the square-integrable martingale property of $\int \tilde{\mathcal{Z}}_{s}^{0, i, N} . \mathrm{d} W_{s}^{0}$ under $\mathbb{P}^{\lambda}$. By the same arguments, we get the square-integrable martingale property of $\int \tilde{\mathcal{Z}}_{s}^{i, N} \cdot \mathrm{~d} \tilde{W}_{s}^{i}$ under $\mathbb{P}^{\lambda}$
Step 4: Estimation of $\mathcal{E}_{N}^{\mathrm{y}}$. By taking the $\mathbb{P}^{\lambda}$ conditional expectation in (3.6), we obtain

$$
\Delta Y_{t}^{N}=\frac{1}{2 N^{2}} \sum_{i=1}^{N} \mathbb{E}^{\mathbb{P}^{\lambda}}\left[\int_{t}^{T} e^{\int_{t}^{s} \alpha_{u} \mathrm{~d} u} \operatorname{tr}\left(\Sigma\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \partial_{\mu}^{2} v\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right)\left(X_{s}^{i, N}, X_{s}^{i, N}\right)\right) \mathrm{d} s \mid \mathcal{F}_{t}\right]
$$

for all $t \in[0, T]$. Under the boundedness condition on $\Sigma=\sigma \sigma^{\top}$ in Assumption 2.2(ii), and on $\partial_{\mu}^{2} v$ in Assumption 2.1, it follows immediately that

$$
\mathcal{E}_{N}^{\mathrm{y}}=\sup _{0 \leq t \leq T}\left|\Delta Y_{t}^{N}\right| \leq \frac{C_{y}}{N}, \quad \text { a.s. }
$$

where $C_{y}=\frac{T}{2} e^{\left[H_{b}\right]_{1} T} L\|\sigma\|_{\infty}^{2}$, with $\|\sigma\|_{\infty}=\sup _{(t, x, \mu) \in[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)}|\sigma(t, x, \mu)|$.

### 3.2 Proof of Theorem 2.7

From (3.5), and under Assumption 2.3(i) and (iii), we see that

$$
\begin{align*}
\alpha_{s}= & \frac{1}{N} \sum_{i=1}^{N} \frac{H_{b}\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), Y_{s}^{N}, N \tilde{Z}_{s}^{i, N}\right)-H_{b}\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), \tilde{Y}_{s}^{N}, N \tilde{Z}_{s}^{i, N}\right)}{\Delta Y_{s}^{N}} \mathbb{1}_{\Delta Y_{s}^{N} \neq 0} \\
= & \frac{1}{N} \sum_{i=1}^{N} \frac{H_{1}\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), Y_{s}^{N}\right)-H_{1}\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), \tilde{Y}_{s}^{N}\right)}{\Delta Y_{s}^{N}} \mathbb{1}_{\Delta Y_{s}^{N} \neq 0} \\
& +\frac{1}{N} \sum_{i=1}^{N} N \tilde{Z}_{s}^{i, N} \cdot \frac{H_{2}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), Y_{s}^{N}\right)-H_{2}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), \tilde{Y}_{s}^{N}\right)}{\Delta Y_{s}^{N}} \mathbb{1}_{\Delta Y_{s}^{N} \neq 0}, \tag{3.7}
\end{align*}
$$

is bounded by $\left[H_{1}\right]_{1}+\left[H_{2}\right]_{1} L$, recalling $N \tilde{Z}_{s}^{i, N}=\partial_{\mu} v\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right)\left(X_{s}^{i, N}\right)$. As a consequence, the proof of Theorem 2.6 still applies. Then by (3.3)

\begin{aligned}
\Delta Y_{t}^{N}= & \int_{t}^{T} \alpha_{s} \Delta Y_{s}^{N} \mathrm{~d} s+\frac{1}{N} \sum_{i=1}^{N} \int_{t}^{T} H_{2}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), Y_{s}^{N}\right) \cdot \Delta Z_{s}^{i, N} \mathrm{~d} s \\
& -\frac{1}{N} \sum_{i=1}^{N} \int_{t}^{T}\left(\Delta Z_{s}^{i, N}\right)^{\top} \sigma\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \mathrm{d} W_{s}^{i} \\
& -\frac{1}{N} \sum_{i=1}^{N} \int_{t}^{T}\left(\Delta Z_{s}^{i, N}\right)^{\top} \sigma_{0}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \mathrm{d} W_{s}^{0} \\
& +\frac{1}{2 N^{2}} \sum_{i=1}^{N} \int_{t}^{T} \operatorname{tr}\left(\Sigma\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \partial_{\mu}^{2} v\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right)\left(X_{s}^{i, N}, X_{s}^{i, N}\right)\right) \mathrm{d} s .
\end{aligned}
$$

By applying Itô's formula to $\left|\Delta Y_{t}^{N}\right|^{2}$ in (3.4) under $\mathbb{P}$

$$
\begin{aligned}
& \left|\Delta Y_{0}^{N}\right|^{2}+\frac{1}{N^{2}} \int_{0}^{T} \sum_{i=1}^{N}\left|\sigma^{\top}\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \Delta Z_{s}^{i, N}\right|^{2} \mathrm{~d} s+\left|\sigma_{0}^{\top}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \sum_{j=1}^{N} \Delta Z_{s}^{j, N}\right|^{2} \mathrm{~d} s \\
& =2 \int_{0}^{T} \alpha_{s}\left|\Delta Y_{s}^{N}\right|^{2} \mathrm{~d} s+\frac{2}{N} \sum_{i=1}^{N} \int_{0}^{T} \Delta Y_{s}^{N} H_{2}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), Y_{s}^{N}\right) \cdot \Delta Z_{s}^{i, N} \mathrm{~d} s \\
& \quad-\frac{2}{N} \sum_{i=1}^{N} \int_{0}^{T} \Delta Y_{s}^{N}\left(\Delta Z_{s}^{i, N}\right)^{\top} \sigma\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \mathrm{d} W_{s}^{i} \\
& \quad-\frac{2}{N} \sum_{i=1}^{N} \int_{0}^{T} \Delta Y_{s}^{N}\left(\Delta Z_{s}^{i, N}\right)^{\top} \sigma_{0}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \mathrm{d} W_{s}^{0} \\
& \quad+\frac{1}{N^{2}} \sum_{i=1}^{N} \int_{0}^{T} \Delta Y_{s}^{N} \operatorname{tr}\left(\Sigma\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \partial_{\mu}^{2} v\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right)\left(X_{s}^{i, N}, X_{s}^{i, N}\right)\right) \mathrm{d} s
\end{aligned}
$$

so by taking expectation under $\mathbb{P}$, and using the Cauchy-Schwarz inequality in $\mathbb{R}^{d}$

\begin{aligned}
\frac{1}{N^{2}} & \int_{0}^{T} \sum_{i=1}^{N} \mathbb{E}\left[\left|\sigma^{\top}\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \Delta Z_{s}^{i, N}\right|^{2}+\left|\sigma_{0}^{\top}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \sum_{j=1}^{N} \Delta Z_{s}^{j, N}\right|^{2}\right] \mathrm{d} s \\
\leq & \mathbb{E}\left[2 \int_{0}^{T}\left|\alpha_{s}\right|\left|\Delta Y_{s}^{N}\right|^{2} \mathrm{~d} s+2 \int_{0}^{T}\left|\Delta Y_{s}^{N} H_{2}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), Y_{s}^{N}\right) \cdot \sum_{i=1}^{N} \frac{\Delta Z_{s}^{i, N}}{N}\right| \mathrm{d} s\right] \\
& +\frac{1}{N^{2}} \sum_{i=1}^{N} \int_{0}^{T} \mathbb{E}\left|\Delta Y_{s}^{N} \operatorname{tr}\left(\Sigma\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \partial_{\mu}^{2} v\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right)\left(X_{s}^{i, N}, X_{s}^{i, N}\right)\right)\right| \mathrm{d} s, \\
\leq & \mathbb{E}\left[2 \int_{0}^{T}\left|\alpha_{s}\right|\left|\Delta Y_{s}^{N}\right|^{2} \mathrm{~d} s+2 \int_{0}^{T}\left|\Delta Y_{s}^{N} H_{2}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), Y_{s}^{N}\right)\right|\left|\sum_{i=1}^{N} \frac{\Delta Z_{s}^{i, N}}{N}\right| \mathrm{d} s\right] \\
& +\frac{1}{N^{2}} \sum_{i=1}^{N} \int_{0}^{T} \mathbb{E}\left|\Delta Y_{s}^{N} \operatorname{tr}\left(\Sigma\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \partial_{\mu}^{2} v\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right)\left(X_{s}^{i, N}, X_{s}^{i, N}\right)\right)\right| \mathrm{d} s, \\
\leq & \mathbb{E}\left[\vartheta \int_{0}^{T}\left|\Delta Y_{s}^{N} H_{2}\left(s, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right), Y_{s}^{N}\right)\right|^{2} \mathrm{~d} s+\frac{1}{\vartheta N^{2}} \int_{0}^{T}\left|\sum_{i=1}^{N} \Delta Z_{s}^{i, N}\right|^{2} \mathrm{~d} s\right]+\frac{\tilde{C}_{z}}{N^{2}},
\end{aligned}
$$

by Young inequality for any $\vartheta>0$, boundedness of $\alpha$ (see (3.7)), $\Sigma, \partial_{\mu}^{2} v$ and Theorem 2.6, where $\tilde{C}_{z}=2 T\left(\left[H_{1}\right]_{1}+\left[H_{2}\right]_{1} L\right) \bar{C}_{y}^{2}+\bar{C}_{y} T\|\sigma\|_{\infty}^{2} L$ and $\bar{C}_{y}=\frac{T}{2} e^{\left(\left[H_{1}\right]_{1}+\left[H_{2}\right]_{1} L\right) T} L\|\sigma\|_{\infty}^{2}$. Thus, by Assumption [2.3(ii), and by choosing $\vartheta=\frac{2}{c_{0}}$, it follows from the boundedness of $H_{2}$, and Theorem 2.6 that

$$
\mathbb{E}\left[\frac{1}{N} \sum_{i=1}^{N} \int_{0}^{T}\left|\sigma^{\top}\left(s, X_{s}^{i, N}, \bar{\mu}\left(\boldsymbol{X}_{s}^{N}\right)\right) \Delta Z_{s}^{i, N}\right|^{2} \mathrm{~d} s\right] \leq \frac{\tilde{C}_{z}+\frac{2}{c_{0}} \bar{C}_{y}^{2} T\left\|H_{2}\right\|_{\infty}^{2}}{N}
$$

which ends the proof by recalling that $\left\|\sigma^{+}\right\|_{\infty}<+\infty$, using Cauchy-Schwarz inequality in $\mathbb{R}^{N}$ (in the form $\frac{1}{N} \sum_{i}^{N} \sqrt{\left|a_{i}\right|} \leq \sqrt{\frac{1}{N} \sum_{i}^{N}\left|a_{i}\right|}$ ) and Jensen inequality (in the form $\mathbb{E}[\sqrt{|X|]} \leq \sqrt{\mathbb{E}[|X|]}$ ).
