ON THE NON-CHIRAL INTERMEDIATE LONG WAVE EQUATION II: PERIODIC CASE

ABSTRACT. We study integrability properties of the non-chiral intermediate long wave (ncILW) equation with periodic boundary conditions. The ncILW equation was recently introduced by the authors as a parity-invariant relative of the intermediate long wave equation. For this new equation we: (a) derive a Lax pair, (b) derive a Hirota bilinear form, (c) use the Hirota method to construct the periodic multi-soliton solutions, (d) derive a Bäcklund transformation, (e) use the Bäcklund transformation to obtain an infinite number of conservation laws.

1. Introduction

The introduction of the inverse scattering transform for the solution of equations such as the Korteweg-de Vries (KdV), nonlinear Schrödinger (NLS), and sine-Gordon equations was a major development in the field of nonlinear PDEs in the 20th century. This development, which began in the late 1960s [1], made it clear that certain nonlinear equations, called *inte-grable*, possess unique properties which allow them to be solved exactly, at least in appropriate circumstances. Two classes of solutions of integrable equations are particularly well-studied: (a) the class of solutions on the real line with decay at spatial infinity and (b) the class of (spatially) periodic solutions. These two classes are superficially similar, but they are very different when it comes to details. In fact, throughout the history of integrable PDEs, there has been a fruitful interplay between the theories for these two classes. For example, one of

the main tools in the study of solutions on the line is the inverse scattering transform, which provides a way to solve the initial value problem via a sequence of linear operations [2]. The search for a generalization of this approach to the periodic setting led to the introduction of the so-called finite-gap integration method, a development which has in turn influenced the evolution of diverse branches of mathematics as well as theoretical physics; see [3] for a review.

In this paper, we consider the periodic version of an integrable equation introduced in [4]. This equation is referred to as the non-chiral intermediate long-wave (ncILW) equation, because it involves the same integral operator that appears in the standard intermediate long-wave equation [5, 6]. However, whereas the latter is chiral in the sense that it only allows for solitons moving in one direction, left or right, the ncILW equation supports solitons moving in both directions. While the ncILW equation was discovered in the context of a quantum field theory describing fractional quantum Hall effect systems [4], we expect that it will find applications also in the theory of nonlinear waves and other areas of theoretical physics; see [7, Sections 1.1–1.3] for a more detailed discussion of the physics behind the ncILW equation.

The periodic ncILW equation is given by

$$u_t + 2uu_x + Tu_{xx} + \tilde{T}v_{xx} = 0, v_t - 2vv_x - Tv_{xx} - \tilde{T}u_{xx} = 0,$$
(1.1)

where u = u(x,t) and v = v(x,t) are real- or complex-valued functions of a space variable $x \in \mathbb{R}$ and a time variable $t \in \mathbb{R}$. The integral operators T and \tilde{T} in (1.1) are defined by

$$(Tf)(x) = \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta_1(x' - x|L/2, i\delta) f(x') dx',$$

$$(\tilde{T}f)(x) = \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta_1(x' - x + i\delta|L/2, i\delta) f(x') dx',$$
(1.2)

where

$$\zeta_1(z|L/2, i\delta) = \frac{\pi}{L} \lim_{M \to \infty} \sum_{n=-M}^{M} \cot\left(\frac{\pi}{L}(z - 2in\delta)\right)$$
 (1.3)

is equal, up to a term linear in z, to the Weierstrass ζ -function with periods L>0 and $2\mathrm{i}\delta$, $\delta>0$; see Appendix A for the precise relation. We are interested in L-periodic solutions of this equation, i.e., solutions such that u(x+L,t)=u(x,t) and v(x+L,t)=v(x,t). The non-chirality of the ncILW equation corresponds to the invariance of (1.1) under the parity transformation which maps x to -x and interchanges u and v [4].

The limiting case $L \to \infty$ where

$$\zeta_1(z|L/2, i\delta) \to \frac{\pi}{2\delta} \coth\left(\frac{\pi}{2\delta}z\right), \qquad \zeta_1(z+i\delta|L/2, i\delta) \to \frac{\pi}{2\delta} \tanh\left(\frac{\pi}{2\delta}z\right)$$

corresponds to the ncILW equation on the real line, i.e., (1.1) with the integral operators

$$(T_{\mathbb{R}}f)(x) = \frac{1}{2\delta} \int_{\mathbb{R}} \coth\left(\frac{\pi}{2\delta}(x'-x)\right) f(x') dx',$$

$$(\tilde{T}_{\mathbb{R}}f)(x) = \frac{1}{2\delta} \int_{\mathbb{R}} \tanh\left(\frac{\pi}{2\delta}(x'-x)\right) f(x') dx'.$$
(1.4)

Conversely, to recover (1.2) from (1.4), it is convenient to work in Fourier space; here, the operators in (1.4) have the representation [4, Eq. A3]

$$(\widehat{T_{\mathbb{R}}f})(k) = i \coth(k\delta)\widehat{f}(k), \qquad (\widehat{\widetilde{T}_{\mathbb{R}}f})(k) = i \operatorname{csch}(k\delta)\widehat{f}(k),$$
 (1.5)

where $\operatorname{csch}(z) := 1/\sinh(z)$. We assume f(x) is a zero-mean L-periodic function with the Fourier transform pair:

$$f(x) = \sum_{n \in \mathbb{Z} \setminus \{0\}} \hat{f}_n e^{2i\pi nx/L}, \qquad \hat{f}(k) = 2\pi \sum_{n \in \mathbb{Z} \setminus \{0\}} \hat{f}_n \delta(k - 2\pi n/L). \tag{1.6}$$

It follows that

$$(T_{\mathbb{R}}f)(x) = i \sum_{n \in \mathbb{Z} \setminus \{0\}} \coth\left(\frac{2n\pi\delta}{L}\right) \hat{f}_n e^{2i\pi nx/L},$$

$$(\tilde{T}_{\mathbb{R}}f)(x) = i \sum_{n \in \mathbb{Z} \setminus \{0\}} \operatorname{csch}\left(\frac{2n\pi\delta}{L}\right) \hat{f}_n e^{2i\pi nx/L}.$$

$$(1.7)$$

Comparing (1.7) with the Fourier series for the functions $\zeta_1(z)$ and $\zeta_1(z+i\delta)$ [8, Eq. 23.8.2] appearing in (1.4), it is straightforward to show (at least formally) [9] that $T_{\mathbb{R}} = T$ and $\tilde{T}_{\mathbb{R}} = \tilde{T}$ on such functions (1.6) (the functions u_{xx}, v_{xx} appearing as arguments of T, \tilde{T} in (1.1) are in this class).

In a recent paper [7], we obtained a Lax pair, a Hirota form, a Bäcklund transformations and an infinite number of conservation laws for the ncILW equation on the real line. In this paper, we present corresponding results in the periodic case. We show that, even though several steps are significantly more complicated in the periodic setting, it is nevertheless possible to prove results which parallel those obtained in [7]. We also provide an alternative derivation based on the Hirota method of the multi-soliton solutions of the periodic ncILW equation; the multi-solitons were previously obtained by a different method in [4]. More precisely, we show that the multi-solitons can be obtained via a pole ansatz in terms of a Weierstrass ζ -function, where the poles evolve according to the elliptic Calogero-Moser (CM) system; see Proposition 4.1 for the precise formulation.

In the limit $L \to \infty$, the results we obtain here for the periodic problem reduce (at least formally) to analogous results for the problem on the line. However, we emphasize that only a subset of the results of [7] can be obtained in this way: proving the results directly on the real line is not only technically simpler but also leads to more general results.

It is important to note that the non-chiral ILW equation (1.1) is an *elliptic* integrable systems. This is clear already from the definition of the operators T and \tilde{T} in (1.2): while the ncILW equation on the line involves integral operators whose kernels are given in terms of the hyperbolic tangent, the kernels in (1.2) involve a Weierstrass ζ -function. The fact that (1.1) is an elliptic system is also evident from the relation to the elliptic CM system mentioned above. In fact, the periodic ncILW equation is related to the elliptic CM system in the same way as the ncILW equation on the line is related to the hyperbolic CM system [4].

The plan of this paper is as follows. In Section 2, we derive a Lax pair for (1.1). A Hirota bilinear form is presented in Section 3, where we additionally prove that the Hirota bilinear form is equivalent to (1.1) by constructing explicit transformations from (u, v) to the Hirota variables (F, G) and vice-versa. We use the Hirota bilinear form to construct N-periodic soliton solutions via a pole ansatz in Section 4. A Bäcklund transformation is constructed from the Hirota bilinear form in Section 5. Definitions and basic properties of certain elliptic functions are collected in Appendix A. Some properties of the operators T and \tilde{T} defined in (1.2) are established in Appendix B.

In what follows we assume that the arguments of T and \tilde{T} are sufficiently regular to justify our arguments. We occasionally comment on specific necessary or sufficient conditions for clarity.

2. Lax pair

We will obtain a Lax pair for (1.1) with (1.2) via a Riemann-Hilbert (RH) problem with two jumps on a torus. We construct this torus as $\Pi = \mathbb{C}/\Lambda$, where $\Lambda := L\mathbb{Z} + 2i\delta\mathbb{Z}$. Let $\pi : \mathbb{C} \to \Pi$ be the natural projection; we identify Π with the parallelogram

$$\Pi \cong \{(L/2)r + i\delta s : -1 < r, s \le 1\}.$$

A function $f: \Pi \to \mathbb{C}$ can be viewed as a function $f: \mathbb{C} \to \mathbb{C}$ which is doubly periodic with periods L and $2i\delta$, i.e.

$$f(z + mL + 2in\delta) = f(z), \qquad m, n \in \mathbb{Z}.$$

Let Π_0 and Π_δ denote the images of the lines $\operatorname{Im} z = 0$ and $\operatorname{Im} z = \delta$, respectively, under π . We consider an eigenfunction $\psi(z,t;k)$; for each $t \in \mathbb{R}$ and $k \in \mathbb{C}$, $\psi(z) := \psi(z,t;k)$ is an analytic function $\Pi \setminus (\Pi_0 \cup \Pi_\delta)$ with jumps across Π_0 and Π_δ . The boundary values of the eigenfunction are functions $\Pi_0 \cup \Pi_\delta \to \mathbb{C}$ defined by

$$\psi^{\pm}(x,t;k) := \lim_{\epsilon \downarrow 0} \psi(x \pm i\epsilon,t;k), \qquad \psi^{\pm}(x + i\delta,t;k) := \lim_{\epsilon \downarrow 0} \psi(x + i\delta \pm i\epsilon,t;k). \tag{2.1}$$

We take the following ansatz for the Lax pair:

$$\begin{cases}
i\psi_{x}^{-} + (-u - \mu_{1})\psi^{-} = \nu_{1}\psi^{+} & \text{for } z \in \Pi_{0}, \\
i\psi_{x}^{+} + (v - \mu_{2})\psi^{+} = \nu_{2}\psi^{-} & \text{for } z \in \Pi_{\delta}, \\
\psi_{t} + i\psi_{xx} - iA(z, t; k)\psi - iB(z, t; k)\psi_{x} = 0 & \text{for } z \in \Pi \setminus (\Pi_{0} \cup \Pi_{\delta}).
\end{cases} (2.2)$$

Here, μ_1 , μ_2 , ν_1 , and ν_2 are complex-valued functions of the spectral parameter; A(z,t;k) and B(z,t;k) are analytic functions on $\Pi \setminus (\Pi_0 \cup \Pi_\delta)$ to be determined. To obtain the compatibility conditions for (2.2), we write the boundary values of the t-part of the Lax pair:

$$\psi_t^{\pm} + i\psi_{xx}^{\pm} - iA^{\pm}(z,t;k)\psi - iB^{\pm}(z,t;k)\psi_x^{\pm} = 0,$$
 for $z \in \Pi_0 \cup \Pi_{\delta}$.

This equation and its x-derivative can be used to eliminate ψ_t^{\pm} and ψ_{tx}^{\pm} from the t-derivative of the x-part of (2.2), leading to

$$i\nu_1(B^+ - B^-)\psi_x^+ + i\nu_1(A^- - A^+ + B_x^- + 2iu_x)\psi^+ + \left[-u_t - A_x^- + i(\mu_1 + u)B_x^- - 2\mu_1u_x + iB^-u_x - 2uu_x - iu_{xx} \right]\psi^+ = 0, \quad \text{on } \Pi_{0}$$

and

$$i\nu_2(B^+ - B^-)\psi_x^+ + i\nu_2(A^+ - A^- + B_x^+ - 2iv_x)\psi^+ + \left[v_t - A_x^+ + i(\mu_2 - v)B_x^+ + 2\mu_2v_x - iB^+v_x - 2vv_x + iv_{xx}\right]\psi^+ = 0, \quad \text{on } \Pi_{\delta}.$$

Setting the coefficients of ψ_x^{\pm} and ψ^{\pm} to zero, we find the equations

$$B^{+} - B^{-} = 0 \qquad \text{on } \Pi_0 \cup \Pi_{\delta}, \tag{2.3a}$$

$$A^{+} - A^{-} - B_{x}^{-} - 2iu_{x} = 0$$
 on Π_{0} , (2.3b)

$$A^{+} - A^{-} + B_{x}^{+} - 2iv_{x} = 0$$
 on Π_{δ} , (2.3c)

$$u_t + A_x^- - i(\lambda_1 + u)B_x^- + 2\mu_1 u_x - iB^- u_x + 2uu_x + iu_{xx} = 0 \quad \text{on } \Pi_0,$$
 (2.3d)

$$v_t - A_x^+ + i(\lambda_2 - v)B_x^+ + 2\mu_2 v_x - iB^+ v_x - 2vv_x + iv_{xx} = 0$$
 on Π_δ . (2.3e)

From (2.3b), we see that B(z) is an analytic function on Π and so must be constant: $B(z) = B_0$. Then (2.3c-2.3d) shows that A is a solution of the following RH problem on Π :

- $A: \Pi \setminus (\Pi_0 \cup \Pi_\delta) \to \mathbb{C}$ is an analytic function,
- across $\Pi_0 \cup \Pi_\delta$, A satisfies the jump condition

$$A^{+}(z) - A^{-}(z) = \begin{cases} 2iu_{x}(x), & z = x \in \Pi_{0}, \\ 2iv_{x}(x), & z = x + i\delta \in \Pi_{\delta}. \end{cases}$$

Lemma 2.1 (RH problem on Π with a jump across $\Pi_0 \cup \Pi_\delta$). Let $J_0 : \Pi_0 \to \mathbb{C}$ and $J_1 : \Pi_\delta \to \mathbb{C}$ be continuous functions satisfying

$$\int_{-L/2}^{L/2} J_0(x) \, \mathrm{d}x = \int_{-L/2}^{L/2} J_1(x) \, \mathrm{d}x = 0.$$

Define $J:\Pi_0\cup\Pi_\delta\to\mathbb{C}$ by

$$J(z) = \begin{cases} J_0(x), & z \in \Pi_0, \\ J_1(x), & z \in \Pi_\delta. \end{cases}$$

Then the scalar RH problem:

- $A: \Pi \setminus (\Pi_0 \cup \Pi_\delta)$ is analytic,
- $across \Pi_0 \cup \Pi_{\delta}$, A satisfies the jump condition,

$$A^{+}(z) - A^{-}(z) = J(z), \qquad z \in \Pi_{0} \cup \Pi_{\delta}$$

has the general solution

$$A(z) = \frac{1}{2\pi i} \int_{\Pi_0 \cup \Pi_\delta} \zeta_1(z' - z | L/2, i\delta) J(z') dz' + A_0, \qquad z \in \Pi \setminus (\Pi_0 \cup \Pi_\delta), \tag{2.4}$$

where A_0 is an arbitrary complex constant and both Π_0 and Π_δ are oriented from Im z = -L/2 to Im z = L/2. Moreover, this solution satisfies

$$A^{\pm}(z) = \begin{cases} \frac{(TJ_0)(x) + (\tilde{T}J_1)(x)}{2i} \pm \frac{1}{2}J_0(x), & z = x \in \Pi_0, \\ \frac{(\tilde{T}J_0)(x) + (TJ_1)(x)}{2i} \pm \frac{1}{2}J_1(x), & z = x + i\delta \in \Pi_\delta. \end{cases}$$
(2.5)

Proof. If A_1 and A_2 are two different solutions, then $A_1 - A_2$ is analytic on Π and hence constant. Let A be given by (2.4). Using periodicity properties of ζ_1 , we observe that A(z+L) = A(z) and

$$A(z+2\mathrm{i}\delta) = A(z) - \frac{1}{2L} \int_{\Pi_0 \cup \Pi_\delta} J(z) \,\mathrm{d}z,\tag{2.6}$$

where the integral vanishes by assumption. Hence A descends to a well-defined function $A: \Pi \setminus (\Pi_0 \cup \Pi_\delta) \to \mathbb{C}$.

For $x \in \Pi_0$, the Plemelj formula gives (we suppress the second and third arguments of ζ_1)

$$A^{\pm}(x) - A_0 = \frac{1}{2\pi i} \left\{ \int_{\Pi_0} \zeta_1(z' - x) J(z') dz' + \int_{\Pi_\delta} \zeta_1(z' - x) J(z') dz' \right.$$

$$\pm \pi i \operatorname{Res}_{z' = x} \zeta_1(z' - x) J_0(x) \right\}$$

$$= \frac{1}{2i} (TJ_0)(x) + \frac{1}{2\pi i} \int_{\Pi_0} \zeta_1(x' - x + i\delta) J_1(x') dx' \pm \frac{1}{2} J_0(x)$$

$$= \frac{1}{2i} (TJ_0)(x) + \frac{1}{2i} (\tilde{T}J_1)(x) \pm \frac{1}{2} J_0(x).$$

Similarly, for $x + i\delta \in \Pi_{\delta}$,

$$A^{\pm}(x+i\delta) - A_0 = \frac{1}{2\pi i} \left\{ \int_{\Pi_0} \zeta_1(z'-x-i\delta)J(z') dz' + \int_{\Pi_\delta} \zeta_1(z'-x-i\delta)J(z') dz' \right.$$

$$\pm \pi i \underset{z'=x+i\delta}{\text{Res}} \zeta_1(z'-x-i\delta)J(z') \right\}$$

$$= \frac{1}{2i} (\tilde{T}J_0)(x) + \frac{1}{2\pi i} \int_{\Pi_0} \zeta_1(x'-x)J_1(x') dx' \pm \frac{1}{2}J_1(x)$$

$$= \frac{1}{2i} (\tilde{T}J_0)(x) + \frac{1}{2i} (TJ_1)(x) \pm \frac{1}{2}J_1(x).$$

This proves the expressions for the boundary values and shows that A satisfies the correct jump condition.

Using (2.4), we see that

$$A(z,t;k) = \frac{1}{\pi} \int_{\Pi_0} \zeta_1(z' - z | L/2, i\delta) J_0(z') dz'$$

$$+ \frac{1}{\pi} \int_{\Pi_\delta} \zeta_1(z' - z | L/2, i\delta) J_1(z') dz' + A_0(k), \qquad z \in \Pi \setminus (\Pi_0 \cup \Pi_\delta),$$
(2.7)

and

$$A^{\pm}(z,t;k) = \begin{cases} (TJ_0)(x) + (\tilde{T}J_1)(x) \pm iu(x) + A_0(k), & z = x \in \Pi_0, \\ (\tilde{T}J_0)(x) + (TJ_1)(x) \pm iv(x) + A_0(k), & z = x + i\delta \in \Pi_\delta. \end{cases}$$
(2.8)

Substituting these expressions for A^{\pm} into (2.3e) and (2.3d) and using that T and \tilde{T} commute with ∂_x from Proposition B.1, we arrive at the two-component equation

$$u_t + Tu_{xx} + \tilde{T}v_{xx} + 2\mu_1 u_x - iB_0 u_x + 2uu_x = 0,$$

$$v_t - Tv_{xx} - \tilde{T}u_{xx} + 2\mu_2 v_x - iB_0 v_x - 2vv_x = 0.$$

Choosing $\mu_1 = \mu_2 = \mu$ and $B_0 = -2i\mu$, this becomes the non-chiral ILW equation (1.1). We summarize the results above in a theorem.

Theorem 1 (Lax pair for the periodic ncILW equation). The periodic ncILW equation is the compatibility condition of the Lax pair

$$\begin{cases} i\psi_{x}^{-} + (-u - \mu)\psi^{-} = \nu_{1}\psi^{+} & on \ \Pi_{0}, \\ i\psi_{x}^{+} + (v - \mu)\psi^{+} = \nu_{2}\psi^{-} & on \ \Pi_{\delta}, \\ \psi_{t}^{\pm} + i\psi_{xx}^{\pm} - 2\mu\psi_{x}^{\pm} - i(Tu_{x} + \tilde{T}v_{x} \pm iu_{x} + A_{0})\psi^{\pm} = 0 & on \ \Pi_{0}, \\ \psi_{t}^{\pm} + i\psi_{xx}^{\pm} - 2\mu\psi_{x}^{\pm} - i(Tv_{x} + \tilde{T}u_{x} \pm iv_{x} + A_{0})\psi^{\pm} = 0 & on \ \Pi_{\delta}, \end{cases}$$

$$(2.9)$$

where $\mu = \mu(k)$, $\nu_1 = \nu_1(k)$, $\nu_2 = \nu_2(k)$, and $A_0 = A_0(k)$ are complex parameters which may depend on the spectral parameter k.

Remark 2.2. The t-parts of (2.9) have an analytic continuation to $\Pi \setminus (\Pi_0 \cup \Pi_{\delta})$ and can be alternatively written as

$$\psi_t + i\psi_{zz} - 2\mu\psi_z - iA\psi = 0, \qquad z \in \Pi \setminus (\Pi_0 \cup \Pi_\delta),$$

where A = A(z, t; k) is given by (2.7).

3. HIROTA BILINEAR FORM

In the periodic setting, the Hirota bilinear form of (1.1) is

$$(iD_t - D_x^2 + 2i\bar{u}D_x - \lambda_1(t) + \bar{u}^2)F^- \cdot G^+ = 0,$$
(3.1a)

$$(iD_t - D_x^2 - 2i\bar{v}D_x - \lambda_2(t) + \bar{v}^2)F^+ \cdot G^- = 0,$$
(3.1b)

where \bar{u} and \bar{v} are the spatial means of u(x,t) and v(x,t), respectively and $\lambda_1(t)$ and $\lambda_2(t)$ are complex functions. By the following lemma, we may take \bar{u} and \bar{v} to be constants.

Lemma 3.1. The means of u and v in (1.1) are independent of time.

Proof. Starting from the definition of the mean

$$\bar{u}(t) := \frac{1}{L} \int_{-L/2}^{L/2} u(x, t) \, \mathrm{d}x,$$

we compute

$$\begin{split} \bar{u}_t = & \frac{1}{L} \int_{-L/2}^{L/2} u_t \, \mathrm{d}x = -\frac{1}{L} \int_{-L/2}^{L/2} (2uu_x + Tu_{xx} - \tilde{T}v_{xx}) \, \mathrm{d}x \\ = & -\frac{1}{L} \left[u^2 + Tu_x - \tilde{T}v_x \right]_{-L/2}^{L/2} = 0. \end{split}$$

The proof for \bar{v} is similar.

A bilinear form similar to (3.1) was used in [10] to construct periodic solutions of the standard ILW equation. We show that (3.1) is equivalent to (1.1) in the sense of the following theorem.

Theorem 2 (Hirota bilinear form of periodic non-chiral ILW).

A. Let F(z,t) and G(z,t) be L-periodic functions of $z \in \mathbb{C}$ and $t \in \mathbb{R}$ such that $\log F(z,t)$ and $\log G(z,t)$ are analytic for $-\delta/2 < \operatorname{Im} z < \delta/2$ and continuous for $-\delta/2 \leq \operatorname{Im} z \leq \delta/2$. Then F,G satisfy the bilinear system (3.1) for some $\bar{u}, \bar{v} \in \mathbb{C}$ and complex-valued functions $\lambda_1(t)$ and $\lambda_2(t)$ if and only if

$$u = \bar{u} + i\partial_x \log \frac{F^-}{G^+}, \qquad v = \bar{v} + i\partial_x \log \frac{G^-}{F^+}. \tag{3.2}$$

satisfy (1.1).

B. Suppose u(x,t), v(x,t) are L-periodic solutions of (1.1) with means \bar{u} and \bar{v} , respectively. Then F(x,t), G(x,t), defined up to multiplication by an arbitrary function of t by

$$\begin{cases} i\partial_z \log F(z,t) = \frac{1}{i\pi} \int_{-L/2}^{L/2} \zeta_1(x'-z|L/2,i\delta/2)(u_+(x')+v_+(x')) dx', \\ i\partial_z \log G(z,t) = \frac{1}{i\pi} \int_{-L/2}^{L/2} \zeta_1(x'-z|L/2,i\delta/2)(u_-(x')+v_-(x')) dx', \end{cases}$$
(3.3)

where

$$\begin{cases}
 u_{\pm} \coloneqq \frac{1}{2}(u - \bar{u}) \mp \frac{\mathrm{i}}{2} \left(T(u - \bar{u}) + \tilde{T}(v - \bar{v}) \right) \\
 v_{\pm} \coloneqq \frac{1}{2}(v - \bar{v}) \pm \frac{\mathrm{i}}{2} \left(T(v - \bar{v}) + \tilde{T}(u - \bar{u}) \right)
\end{cases}, \quad x, t \in \mathbb{R}, \tag{3.4}$$

are analytic for $-\delta/2 < \operatorname{Im} z < \delta/2$, continuous for $-\delta/2 \leq \operatorname{Im} z \leq \delta/2$, and satisfy the Hirota equations (3.1) with

$$\begin{cases} \lambda_1 = i(\log F^-/G^+)_t + u^2 + i(u_+ - u_-)_x, \\ \lambda_2 = i(\log F^+/G^-)_t + v^2 - i(v_+ - v_-)_x. \end{cases}$$
(3.5)

3.1. **Proof of Theorem 2A.** Suppose (F,G) and (u,v) are related as in (3.2). We write

$$u = \bar{u} + u_{+} + u_{-}, \qquad v = \bar{v} + v_{+} + v_{-},$$

where u_{\pm} and v_{\pm} are defined by

$$u_{+}(z,t) := i\partial_{z} \log F(z - i\delta/2, t), \qquad u_{-}(z,t) := -i\partial_{z} \log G(z + i\delta/2, t),$$

$$v_{+}(z,t) := -i\partial_{z} \log F(z + i\delta/2, t), \qquad v_{-}(z,t) := i\partial_{z} \log G(z - i\delta/2, t).$$

$$(3.6)$$

Each of these functions has zero mean by L-periodicity of F and G. By our assumptions on the analyticity of $\log F$ and $\log G$, we see that u_+ and v_- are analytic in the strip $0 < \operatorname{Im} z < \delta$, u_- and v_+ are analytic in the strip $-\delta < \operatorname{Im} z < 0$. Additionally, we observe that

$$v_{+}(z,t) = -u_{+}(z+i\delta,t), \qquad v_{-}(z,t) = -u_{-}(z-i\delta,t).$$
 (3.7)

Lemma 3.2. If $g^+(z)$ is L-periodic, analytic in the strip $0 < \text{Im } z < \delta$, and continuous in the strip $0 \le \text{Im } z \le \delta$, then,

$$(Tg^+)(x) - (\tilde{T}[g^+(\cdot + i\delta)])(x) = ig^+(x), \qquad x \in \mathbb{R}.$$
(3.8)

Similarly, if $g^-(z)$ is L-periodic, analytic in the strip $-\delta < \text{Im } z < 0$, and continuous in the strip $-\delta \leq \text{Im } z \leq 0$, then

$$(Tg^{-})(x) - (\tilde{T}[g^{-}(\cdot - i\delta)])(x) = -ig^{-}(x) + \frac{2i}{L} \int_{-L/2}^{L/2} g^{-}(x' - i\delta) dx', \qquad x \in \mathbb{R}.$$
 (3.9)

Proof. Suppose $g^+(z)$ is an L-periodic function which is analytic in $0 < \text{Im } z < \delta$, and continuous in $0 \le \text{Im } z \le \delta$. Using the definition of \tilde{T} (1.2) and then changing variables to $z' = x' + \mathrm{i}\delta$, we find

$$(\tilde{T}[g^{+}(\cdot + i\delta)])(x) = \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta_{1}(x' - x + i\delta)g^{+}(x' + i\delta) dx'$$
$$= \frac{1}{\pi} \int_{-L/2 + i\delta}^{L/2 + i\delta} \zeta_{1}(z' - x)g^{+}(z') dz'.$$

We deform the contour down towards the real axis. Utilizing the Plemelj formula to evaluate the contribution from the simple pole at z' = x, we obtain

$$(\tilde{T}[g^{+}(\cdot + i\delta)])(x) = \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta_{1}(z' - x)g^{+}(z') dz'$$
$$-i \operatorname{Res}_{z'=x} \zeta_{1}(z' - x)g^{+}(z') + E(x), \tag{3.10}$$

where

$$E(x) := \frac{1}{\pi} \left(\int_{-L/2 + i\delta}^{-L/2} + \int_{L/2}^{L/2 + i\delta} \right) \zeta_1(z' - x) g^+(z') dz'.$$

Because the integrand of E is L-periodic, we have E = 0. Thus, using that $\underset{z'=x}{\text{Res }} \zeta_1(z'-x) = 1$, equation (3.10) reduces to

$$(\tilde{T}[g^+(\cdot + i\delta)])(x) = (Tg^+)(x) - ig^+(x),$$

which is (3.8).

The proof of (3.9) is similar, but there is a correction term due to the non-2i δ -periodicity of ζ_1 . Suppose $g^-(z)$ is an L-periodic function which is analytic in $-\delta < \text{Im } z < 0$ and continuous in $-\delta \leq \text{Im } z \leq 0$. Using the definition of \tilde{T} , changing variables to $z' = x' + \mathrm{i}\delta$, and using the identity $\zeta_1(z-2\omega_2) = \zeta_1(z) + \mathrm{i}\pi/\omega_1$ from Proposition B.1, we find

$$\begin{split} (\tilde{T}[g^{-}(\cdot - \mathrm{i}\delta)])(x) &= \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta_{1}(x' - x + \mathrm{i}\delta)g^{-}(x' - \mathrm{i}\delta) \,\mathrm{d}x' \\ &= \frac{1}{\pi} \int_{-L/2 - \mathrm{i}\delta}^{L/2 - \mathrm{i}\delta} \zeta_{1}(z' - x - 2\mathrm{i}\delta)g^{-}(z') \,\mathrm{d}z' \\ &= \frac{1}{\pi} \int_{-L/2 - \mathrm{i}\delta}^{L/2 - \mathrm{i}\delta} \zeta_{1}(z' - x)g^{-}(z') \,\mathrm{d}z' - \frac{2\mathrm{i}}{L} \int_{-L/2 - \mathrm{i}\delta}^{L/2 - \mathrm{i}\delta} g^{-}(z') \,\mathrm{d}z' \\ &= \frac{1}{\pi} \int_{-L/2 - \mathrm{i}\delta}^{L/2 - \mathrm{i}\delta} \zeta_{1}(z' - x)g^{-}(z') \,\mathrm{d}z' - \frac{2\mathrm{i}}{L} \int_{-L/2}^{L/2} g^{-}(x' - \mathrm{i}\delta) \,\mathrm{d}x'. \end{split}$$

We deform the contour up towards the real axis. Utilizing the Plemelj formula to evaluate the contribution from the simple pole at z' = x, we obtain

$$(\tilde{T}[g^{-}(\cdot - i\delta)])(x) = \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta_{1}(z' - x)g^{-}(z') dz'$$

$$+ i \operatorname{Res}_{z'=x} \zeta_{1}(z' - x)g^{-}(z')$$

$$- \frac{2i}{L} \int_{-L/2}^{L/2} g^{-}(x' - i\delta) dx' + E(x)$$
(3.11)

where

$$E(x) := \frac{1}{\pi} \left(\int_{-L/2 - i\delta}^{-L/2} + \int_{L/2}^{L/2 - i\delta} \right) \zeta_1(z' - x) g^-(z') dz'.$$

Because the integrand of E is L-periodic, we have E = 0. Thus, using that $\underset{z'=x}{\text{Res }} \zeta_1(z'-x) = 1$, equation (3.11) reduces to

$$(\tilde{T}[g^{-}(\cdot + i\delta)])(x) = (Tg^{-})(x) + ig^{-}(x) - \frac{2i}{L} \int_{-L/2}^{L/2} g^{-}(x' - i\delta) dx',$$

which is (3.9).

Lemma 3.3. The functions u and v obey the identities

$$\begin{cases} Tu + \tilde{T}v = i(\bar{v} + u_+ - u_-), \\ Tv + \tilde{T}u = i(\bar{u} - v_+ + v_-). \end{cases} x, t \in \mathbb{R}.$$

Proof. By (3.7) and the identities T[1] = 0 and $\tilde{T}[1] = -i$ from Proposition B.1, we have

$$Tu + \tilde{T}v = T(\bar{u} + u_{+} + u_{-}) + \tilde{T}(\bar{v} + v_{+} + v_{-})$$

$$= Tu_{+} - \tilde{T}[u_{+}(\cdot + i\delta)] + Tu_{-} - \tilde{T}[u_{-}(\cdot - i\delta)] + T\bar{u} - \tilde{T}\bar{v}$$

$$= Tu_{+} - \tilde{T}[u_{+}(\cdot + i\delta)] + Tu_{-} - \tilde{T}[u_{-}(\cdot - i\delta)] + i\bar{v}.$$
(3.12)

We see from (3.6) that u_+ is L-periodic, analytic for $0 < \operatorname{Im} z < \delta$, and continuous for $0 \le \operatorname{Im} z \le \delta$, so that $Tu_+ - \tilde{T}[u_+(\cdot + \mathrm{i}\delta)] = \mathrm{i}u_+$ by Lemma 3.2. Similarly, u_- is L-periodic, analytic for $-\delta < \operatorname{Im} z < 0$, continuous for $-\delta \le \operatorname{Im} z \le 0$, and has zero mean, so that $Tu_- - \tilde{T}[u_-(\cdot - \mathrm{i}\delta)] = -\mathrm{i}u_-$. Hence, the identity $Tu + \tilde{T}v = \mathrm{i}(\bar{v} + u_+ - u_-)$ follows from (3.12) and Lemma 3.2.

The proof of the identity $Tv + \tilde{T}u = i(\bar{u} - v_+ + v_-)$ is similar. Indeed, by (3.7) and (B.5-B.6), we have

$$Tv + \tilde{T}u = T(v_{+} + v_{-}) + \tilde{T}(u_{+} + u_{-})$$

$$= Tv_{+} - \tilde{T}[v_{+}(\cdot - i\delta)] + Tv_{-} - \tilde{T}[v_{-}(\cdot + i\delta)] + T\bar{v} - \tilde{T}\bar{u}$$

$$= Tv_{+} - \tilde{T}[v_{+}(\cdot - i\delta)] + Tv_{-} - \tilde{T}[v_{-}(\cdot + i\delta)] + i\bar{u}.$$

By our analyticity assumptions on F, G, we see from (3.6) that v_- is analytic for $0 < \text{Im } z < \delta$, and continuous for $0 \le \text{Im } z \le \delta$, so that $Tv_- - \tilde{T}[v_-(\cdot + \mathrm{i}\delta)] = \mathrm{i}v_-$ by Lemma 3.2. Similarly, v_+ is analytic for $-\delta < \text{Im } z < 0$, continuous for $-\delta \le \text{Im } z \le 0$, and has zero mean, so that $Tv_+ - \tilde{T}[v_+(\cdot - \mathrm{i}\delta)] = -\mathrm{i}v_+$. Hence, the identity $Tv + \tilde{T}u = \mathrm{i}(\bar{u} - v_+ + v_-)$ follows from (3.12) and Lemma 3.2.

Proof of Theorem 2A. According to Lemma 3.3, the non-chiral ILW equation (1.1) can be written as

$$\begin{cases} u_t + 2uu_x + i(u_+ - u_-)_{xx} = 0, \\ v_t - 2vv_x + i(v_+ - v_-)_{xx} = 0. \end{cases}$$
(3.13)

Since $u_t = i(\log F^-/G^+)_{xt}$ and $v_t = i(\log G^-/F^+)_{xt}$, integration of (3.13) with respect to x gives

$$\begin{cases} i(\log F^{-}/G^{+})_{t} + u^{2} + i(u_{+} - u_{-})_{x} = \lambda_{1}(t), \\ i(\log G^{-}/F^{+})_{t} - v^{2} + i(v_{+} - v_{-})_{x} = -\lambda_{2}(t), \end{cases}$$
(3.14)

where $\lambda_1(t)$ and $\lambda_2(t)$ are arbitrary complex functions.

Rewriting the system in terms of F and G, we obtain

$$\begin{cases} \mathrm{i} \left(\frac{F_t^-}{F^-} - \frac{G_t^+}{G^+} \right) + \left(\bar{u}(t) + \mathrm{i} \frac{F_x^-}{F^-} - \mathrm{i} \frac{G_x^+}{G^+} \right)^2 - \left(\frac{F_x^-}{F^-} + \frac{G_x^+}{G^+} \right)_x = \lambda_1(t), \\ -\mathrm{i} \left(\frac{F_t^+}{F^+} - \frac{G_t^-}{F^-} \right) - \left(\bar{v} + \mathrm{i} \frac{G_x^-}{G^-} - \mathrm{i} \frac{F_x^+}{F^+} \right)^2 + \left(\frac{F_x^+}{F^+} + \frac{G_x^-}{G^-} \right)_x = -\lambda_2(t). \end{cases}$$

Simplification shows that the first equation can be rewritten as

$$i\left(\frac{F_t^-}{F^-} - \frac{G_t^+}{G^+}\right) + 2i\bar{u}\left(\frac{F_x^-}{F^-} - \frac{G_x^+}{G^+}\right) - \left(\frac{F_{xx}^-}{F^-} + \frac{2F_x^-G_x^+}{F^-G^+} - \frac{G_{xx}^+}{G^+}\right) = \lambda_1 - \bar{u}^2$$

i.e.,

$$\frac{(iD_t + 2i\bar{u}D_x - D_x^2)F^- \cdot G^+}{F^-G^+} = \lambda_1 - \bar{u}^2.$$
 (3.15a)

In the same way, the second equation can be written as

$$\frac{(-iD_t + 2i\bar{v}D_x + D_x^2)F^+ \cdot G^-}{F^+G^-} = -\lambda_2 + \bar{v}^2.$$
 (3.15b)

Multiplying (3.15a) and (3.15b) by F^-G^+ and F^+G^- , respectively, we conclude that (1.1) is equivalent to the bilinear system (3.1). This completes the proof.

3.2. Proof of Theorem 2B.

Proof. We decompose the *L*-periodic solution u, v of (1.1) as $u = \bar{u} + u_+ + u_-$, $v = \bar{v} + v_+ + v_-$, with u_{\pm} , v_{\pm} as in (3.4). We view (3.2) as a pair of differential-difference equations for F, G and seek solutions satisfying

$$i\partial_z \log F(x - i\delta/2, t) = u_+(x, t), \qquad i\partial_z \log F(x + i\delta/2, t) = -v_+(x, t),$$

$$i\partial_z \log G(x - i\delta/2, t) = v_-(x, t), \qquad i\partial_z \log G(x + i\delta/2, t) = -u_-(x, t),$$
(3.16)

so that

$$i\partial_z \log F(x - i\delta/2, t) - i\partial_z \log F(x - i\delta/2, t) = u_+(x, t) + v_+(x, t)$$

$$i\partial_z \log G(x - i\delta/2, t) - i\partial_z \log G(x + i\delta/2, t) = v_-(x, t) + u_-(x, t).$$
(3.17)

Let $\tilde{\Pi}$ denote the torus $\mathbb{C}/\tilde{\Lambda}$, where $\tilde{\Lambda} := L\mathbb{Z} + i\delta\mathbb{Z}$, $\tilde{\pi}$ the natural projection $\mathbb{C} \to \tilde{\Pi}$, and $\tilde{\Pi}_0$ the image of $\operatorname{Im} z = 0$ under $\tilde{\pi}$. Then (3.17) defines a pair of RH problems for the functions $\partial_z \log F$ and $\partial_z \log G$ on $\tilde{\Pi}$. The following lemma can be proved similarly to Lemma 2.1.

Lemma 3.4 (RH problem on $\tilde{\Pi}$ with a jump across $\tilde{\Pi}_0$). Let $J:\tilde{\Pi}_0\to\mathbb{C}$ be a continuous function such that

$$\int_{-L/2}^{L/2} J(x) \, \mathrm{d}x = 0.$$

Then the scalar RH problem:

• $A: \Pi \setminus \Pi_0$ is analytic,

• across $\tilde{\Pi}_0$, A satisfies the jump condition

$$A^{+}(x) - A^{-}(x) = J(x), \qquad x \in [-L/2, L/2),$$

has the general solution

$$A(z) = \frac{1}{2\pi i} \int_{-L/2}^{L/2} \zeta_1(x' - z|L/2, i\delta/2) J(x') dx' + A_0, \qquad z \in \tilde{\Pi} \setminus \tilde{\Pi}_0,$$
 (3.18)

where A_0 is an arbitrary complex constant. Moreover, this solution satisfies

$$A^{\pm}(x) = \frac{(T_{\frac{\delta}{2}}J)(x)}{2i} \pm \frac{1}{2}J(x), \qquad x \in [-L/2, L/2),$$

where

$$(T_{\frac{\delta}{2}}f)(x) := \frac{1}{\pi} \int_{\mathbb{R}} \zeta_1(x' - x|L/2, i\delta/2) f(x') dx'. \tag{3.19}$$

Remark 3.5. Note that $T_{\frac{\delta}{2}}$ is the operator T but with δ replaced by $\frac{\delta}{2}$: $T_{\frac{\delta}{2}} = T|_{\delta \to \frac{\delta}{2}}$.

It follows from (3.4) and the anti-self-adjointness of T and \tilde{T} from Proposition B.1, that the functions u_{\pm} , v_{\pm} and hence $u_{\pm} + v_{\pm}$ have zero mean. Then, Lemma 3.4 shows that the general solution to the scalar RH problem:

- $A: \tilde{\Pi} \setminus \tilde{\Pi}_0$ is analytic,
- across Π_0 , A satisfies the jump condition

$$A^{+}(x) - A^{-}(x) = u_{\pm} + v_{\pm}, \qquad x \in [-L/2, L/2),$$

is given by

$$A(z) = \frac{1}{2\pi i} \int_{-L/2}^{L/2} \zeta_1(z - x|L/2, i\delta/2) \left(u_{\pm,x}(x') + v_{\pm,x}(x')\right) dx' + A_0$$
 (3.20)

with boundary values

$$A^{\pm}(x) = \frac{T_{\frac{\delta}{2}}[u_{\pm} + v_{\pm}](x)}{2i} \pm \frac{1}{2}(u_{\pm}(x) + v_{\pm}(x)) + A_0.$$
 (3.21)

Hence we find

$$\begin{cases} i\partial_z \log F(z,t) = \frac{1}{2\pi i} \int_{-L/2}^{L/2} \zeta_1(x'-z|L/2,i\delta/2) \left(u_+(x') + v_+(x')\right) dx' + F_0(t), \\ i\partial_z \log G(z,t) = \frac{1}{2\pi i} \int_{-L/2}^{L/2} \zeta_1(x'-z|L/2,i\delta/2) \left(u_-(x') + v_-(x')\right) dx' + G_0(t), \end{cases}$$

with corresponding boundary values

$$\begin{cases} i\partial_z \log F(x \pm i\delta/2, t) = \frac{T_{\frac{\delta}{2}} [u_+ + v_+](x)}{2i} \pm \frac{1}{2} (u_+(x) + v_+(x)) + F_0(t), \\ i\partial_z \log G(x \pm i\delta/2, t) = \frac{T_{\frac{\delta}{2}} [u_- + v_-](x)}{2i} \pm \frac{1}{2} (u_-(x) + v_-(x)) + G_0(t), \end{cases}$$

where F_0 and G_0 are arbitrary complex functions of t.

Lemma 3.6. The functions u_{\pm} and v_{\pm} defined in (3.4) satisfy

$$T_{\frac{\delta}{2}}(u_{\pm} + v_{\pm}) = \pm i(u_{\pm} - v_{\pm}).$$
 (3.22)

Proof. We begin by considering the function

$$g(z) := \wp(z|L/2, i\delta/2) - \wp(z|L/2, i\delta) - \wp(z + i\delta|L/2, i\delta). \tag{3.23}$$

We note that g(z) is doubly-periodic with periods L and i δ and bounded. Hence, by Liouville's theorem, g(z) is constant. Integrating (3.23) and using the definition of the Weierstrass ζ_1 -function (A.5), we see that

$$\zeta_1(z|L/2, i\delta/2) - \zeta_1(z|L/2, i\delta) - \zeta_1(z+i\delta|L/2, i\delta) = \alpha + \beta z,$$
 (3.24)

for some constants $\alpha, \beta \in \mathbb{C}$, but L-periodicity implies $\beta = 0$. It follows from (3.19) that $T_{\frac{\delta}{2}}$ can be written as $T_{\frac{\delta}{2}} = T + \tilde{T}$ on zero-mean functions. Using (3.4), we write

$$T_{\frac{\delta}{2}}(u_{\pm} + v_{\pm}) = \frac{1}{2}(T + \tilde{T})(u + v - (\bar{u} + \bar{v}) \mp iT(u - v - (\bar{u} - \bar{v})) \pm i\tilde{T}(u - v - (\bar{u} - \bar{v})))$$
$$= \frac{1}{2}(T + \tilde{T})(u + v - (\bar{u} + \bar{v})) \mp \frac{i}{2}(T + \tilde{T})(T - \tilde{T})(u - v - (\bar{u} - \bar{v})).$$

The identities $\tilde{T}Tf = T\tilde{T}f$ and $\tilde{T}\tilde{T}f = TTf + f - 2\bar{f}$ from Proposition B.1 imply the identity

$$(T + \tilde{T})(T - \tilde{T})f = -f + 2\bar{f}.$$

Thus,

$$T_{\frac{\delta}{2}}(u_{\pm} + v_{\pm}) = \frac{1}{2}(T + \tilde{T})(u + v - (\bar{u} + \bar{v})) \pm \frac{i}{2}(u - v - (\bar{u} - \bar{v}))$$
$$= \pm i(u_{+} - v_{+}),$$

which is (3.22).

Using Lemma 3.6, we see that (3.16) is satisfied when $F_0(t) = 0$ and $G_0(t) = 0$, which gives (3.3). Thus, (3.2) holds and Theorem 2A shows that (3.1) with (3.5) is satisfied.

4. Periodic solitons

We construct the N-periodic soliton solutions of (1.1) via an ansatz for the Hirota form (3.1). The ansatz

$$F(x,t) = \prod_{j=1}^{N} e^{-i\pi x/L} \sigma_1(x - z_j(t)|L/2, i\delta), \qquad G(x,t) = \prod_{j=1}^{N} e^{2i\pi x/L} \sigma_1(x - w_j(t)|L/2, i\delta),$$
(4.1)

for (3.1), together with Theorem 2A, leads to an alternative proof of the following result in [4]. The naïve ansatz

$$F(x,t) = \prod_{j=1}^{N} \sigma_2(x - z_j(t)|L/2, i\delta), \qquad G(x,t) = \prod_{j=1}^{N} \sigma_2(x - w_j(t)|L/2, i\delta),$$

fails to satisfy the conditions of Theorem 2A; the ansatz in (4.1) is a minor modification of the latter one which satisfies those conditions.

Proposition 4.1 (Soliton solutions of the periodic non-chiral ILW equation). For an arbitrary non-negative integer N and complex parameters a_j, b_j (j = 1, ..., N) satisfying

Our result is obtained by the observation that the equations in (4.5) are a Bäcklund transformations for the elliptic CM system, i.e., if (4.5) is fulfilled, then (4.3) is implied; to keep this paper self-contained, we also give the proof of this known fact [11].

The second term vanishes by periodicity. Using (5.3) we obtain (5.4). It remains to show that I_2 is a conservation law. This is verified by a calculation analogous to the direct verification of I_2 in [7, Section 5.3], using the anti-self-adjointness of T and \tilde{T} from Proposition B.1.

Lemma 5.2 motivates the definition of the t-potential functions

$$\Lambda_1 := \frac{2}{L} \int_{-L/2}^{L/2} u^2 \, \mathrm{d}x + \frac{1}{L} \int_{L/2}^{L/2} U \, \mathrm{d}x, \qquad \Lambda_2 := \frac{2}{L} \int_{-L/2}^{L/2} v^2 \, \mathrm{d}x - \frac{1}{L} \int_{L/2}^{L/2} V \, \mathrm{d}x, \qquad (5.6a)$$

$$\tilde{\Lambda}_1 := \frac{2}{L} \int_{-L/2}^{L/2} \tilde{u}^2 \, dx + \frac{2}{L} \int_{L/2}^{L/2} \tilde{U} \, dx, \qquad \tilde{\Lambda}_2 := \frac{1}{L} \int_{-L/2}^{L/2} \tilde{v}^2 \, dx - \frac{1}{L} \int_{L/2}^{L/2} \tilde{V} \, dx, \qquad (5.6b)$$

so that $(\Lambda_1 - \Lambda_2)_t = \lambda_1 - \lambda_2$ and $(\tilde{\Lambda}_1 - \tilde{\Lambda}_2)_t = \tilde{\lambda}_1 - \tilde{\lambda}_2$.

Theorem 3 (Bäcklund transformation for the periodic non-chiral ILW equation). Suppose the following relations hold:

$$Z_{t} = -\frac{2}{\epsilon} (1 - e^{Z}) Z_{x} + T Z_{xx} + \tilde{T} W_{xx} + Z_{x} T Z_{x} + Z_{x} \tilde{T} W_{x},$$
 (5.7d)

where

$$W = i(U - \tilde{U} - (\Lambda_1 - \tilde{\Lambda}_1)), \qquad Z = i(V - \tilde{V} + (\Lambda_2 - \tilde{\Lambda}_2)), \tag{5.8}$$

and

$$P_{\pm} := -\frac{1}{2}(iT \pm 1).$$
 (5.9)

Then (u,v) satisfy the periodic non-chiral ILW equation (1.1) if and only if (\tilde{u},\tilde{v}) do.

Proof. Let us first rewrite (5.2c). Dividing (5.2c) by $G^+\tilde{F}^-$ yields

where u_{\pm} , v_{\pm} are defined in (3.6) and \tilde{u}_{\pm} , \tilde{v}_{\pm} are defined analogously.

Lemma 5.3. The following identities hold:

\end{cases}$$

$$\begin{cases}
 \tilde{u}_{+} = P_{-}\tilde{u} - \frac{1}{2}\tilde{T}\tilde{v} - \frac{1}{2}(\bar{u} - \bar{v}), \\
 \tilde{u}_{-} = -P_{-}\tilde{u} + \frac{1}{2}\tilde{T}\tilde{v} + \tilde{u} - \frac{1}{2}(\bar{u} + \bar{v}).
\end{cases}$$
(5.11)

Proof. By Lemma 3.3.

$$Tu + \tilde{T}v + iu - i(\bar{u} - \bar{v}) = 2iu_+$$

and the expression for u_+ follows after simplification. The expression for u_- then follows because $u = \bar{u} + u_+ + u_-$. The expressions for \tilde{u}_{\pm} follow in the same way.

Utilizing Lemma 5.3, equation (5.10) can be rewritten as

$$-P_{-}(u-\tilde{u}) + \frac{i}{2}\tilde{T}(v-\tilde{v}) + u = \bar{u} - \alpha_1 + \beta_1 e^{-i(U-\tilde{U})}.$$

Recalling (5.8) and setting

$$(\mathrm{i}\partial_t - 2\mathrm{i}(\alpha_1 - \bar{u})\partial_x) \log \frac{F^-}{\tilde{F}^-} - \partial_x^2 \log(F^-\tilde{F}^-) - \left(\partial_x \log \frac{F^-}{\tilde{F}^-}\right)^2 - \lambda_1 + \bar{u}^2 = 0,$$

$$(\mathrm{i}\partial_t - 2\mathrm{i}(\alpha_1 - \bar{u})\partial_x) \log \frac{G^+}{\tilde{G}^+} - \partial_x^2 \log(G^+\tilde{G}^+) - \left(\partial_x \log \frac{G^+}{\tilde{G}^+}\right)^2 - \tilde{\lambda}_1 + \bar{u}^2 = 0.$$

Subtracting the second of these equations from the first gives

$$\left(i\partial_{t} - 2i(\alpha_{1} - \bar{u})\partial_{x}\right)\left(\log\frac{F^{-}}{G^{+}} - \log\frac{\tilde{F}^{-}}{\tilde{G}^{+}}\right) - \left(\log\frac{F^{-}}{G^{+}} + \log\frac{\tilde{F}^{-}}{\tilde{G}^{+}}\right)_{xx} - \left(\log\frac{F^{-}}{G^{+}} - \log\frac{\tilde{F}^{-}}{\tilde{G}^{+}}\right)_{x}\left(\log(F^{-}G^{+}) - \log(\tilde{F}^{-}\tilde{G}^{+})\right)_{x} = \lambda_{1} - \tilde{\lambda}_{1}.$$
(5.13)

Multiplying by i and using the definitions (3.6), (5.3), and (5.6a) of u_{\pm} , \tilde{u}_{\pm} , U, \tilde{U} , and $\Lambda_1, \tilde{\Lambda}_1$, this becomes

$$(\mathrm{i}\partial_t - 2\mathrm{i}(\alpha_1 - \bar{u})\partial_x)(U - \tilde{U} - (\Lambda_1 - \tilde{\Lambda}_1))$$
$$-(U + \tilde{U})_{xx} + \mathrm{i}(U - \tilde{U})_x(u_+ - u_- - (\tilde{u}_+ - \tilde{u}_-)) = 0.$$

Recalling (5.8) and using Lemma 3.3, we find

$$v_{-} + \tilde{v}_{+} = \alpha_{1} - \beta_{2} e^{i(V - \tilde{V})}. \tag{5.14}$$

Lemma 5.4. The following identities hold:

$$\begin{cases} v_{+} = -P_{+}v + \frac{i}{2}\tilde{T}u - \frac{1}{2}(\bar{v} - \bar{u}), \\ v_{-} = P_{+}v - \frac{i}{2}\tilde{T}u + v - \frac{1}{2}(\bar{v} + \bar{u}), \end{cases} \qquad \begin{cases} \tilde{v}_{+} = -P_{+}\tilde{v} + \frac{i}{2}\tilde{T}\tilde{u} - \frac{1}{2}(\bar{v} - \bar{u}), \\ \tilde{v}_{-} = P_{+}\tilde{v} - \frac{i}{2}\tilde{T}\tilde{u} + \tilde{v} - \frac{1}{2}(\bar{v} + \bar{u}). \end{cases}$$
(5.15)

Proof. By Lemma 3.3,

$$Tv + \tilde{T}u - iv + i(\bar{v} - \bar{u}) = -2iv_+$$

and the expression for v_+ follows after simplification. The expression for v_- then follows because $v = \bar{v} + v_+ + v_-$. The expressions for \tilde{v}_{\pm} follow in the same way.

Utilizing Lemma 5.4, equation (5.14) can be rewritten as

$$P_{+}(v-\tilde{v}) - \frac{i}{2}\tilde{T}(u-\tilde{u}) + v = \bar{v} + \alpha_2 - \beta_2 e^{i(V-\tilde{V})}.$$
 (5.16)

With (5.8) and setting

$$\alpha_2 = -\bar{v} - \frac{1}{\epsilon}, \qquad \beta_2 = -\frac{1}{\epsilon} e^{i(\Lambda_2 - \tilde{\Lambda}_2)},$$

this becomes

$$v = -\frac{1 - e^Z}{\epsilon} + iP_+ Z_x + \frac{1}{2}\tilde{T}W_x,$$

which is (5.7c).

We next rewrite the t-parts (5.2d)-(5.2e) of the Bäcklund transformation. As before, we find that (5.13) holds except that F, \tilde{F} and G, \tilde{G} are now evaluated at $x + i\delta/2$ and $x - i\delta/2$, respectively, i.e.,

$$\left(i\partial_{t} - 2i(\alpha_{2} + \bar{v})\partial_{x}\right) \left(\log\frac{F^{+}}{G^{-}} - \log\frac{\tilde{F}^{+}}{\tilde{G}^{-}}\right) - \left(\log\frac{F^{+}}{G^{-}} + \log\frac{\tilde{F}^{+}}{\tilde{G}^{-}}\right)_{xx} - \left(\log\frac{F^{+}}{G^{-}} - \log\frac{\tilde{F}^{+}}{\tilde{G}^{-}}\right)_{x} \left(\log(F^{+}G^{-}) - \log(\tilde{F}^{+}\tilde{G}^{-})\right)_{x} = \lambda_{2} - \tilde{\lambda}_{2}.$$
(5.17)

Multiplying by i and using the definitions (3.6), (5.3), and (5.6b) of v_{\pm} , \tilde{v}_{\pm} , V, \tilde{V} , and Λ_2 , $\tilde{\Lambda}_2$ this becomes

$$(\mathrm{i}\partial_t - 2\mathrm{i}(\alpha_2 + \bar{v})\partial_x)(-V + \tilde{V} - \Lambda_2 - \tilde{\Lambda}_2) + (V + \tilde{V})_{xx} + \mathrm{i}(-V + \tilde{V})_x(-v_+ + v_- + \tilde{v}_+ - \tilde{v}_-) = 0.$$

Recalling (5.8) and using Lemma 3.3, we find

$$-Z_t + 2(\alpha_2 + \bar{v})Z_x + (V + \tilde{V})_{xx} + iZ_x (TV + \tilde{T}U - T\tilde{V} - \tilde{T}\tilde{U})_x = 0.$$

Equation (5.16) can be written as

6. Conservation laws

Theorem 4 (Conservation laws of the periodic non-chiral ILW equation). The periodic non-chiral ILW equation (1.1) with (1.2) has an infinite number of conservation laws

where W_n and Z_n can be computed recursively from the formal power series in ϵ

 (6.2a)

$$v = -\frac{1 - \exp\left(\sum_{n=1}^{\infty} Z_n \epsilon^n\right)}{\epsilon} + iP_+ \sum_{n=1}^{\infty} Z_{n,x} \epsilon^n + \frac{1}{2} \tilde{T} \sum_{n=1}^{\infty} W_{n,x} \epsilon^n,$$
 (6.2b)

with P_{\pm} as in (5.9). The first four conservation laws are

$$I_1 = \int_{-L/2}^{L/2} (u+v) \, \mathrm{d}x,\tag{6.3a}$$

$$I_2 = \int_{-L/2}^{L/2} \frac{1}{2} (u^2 - v^2) \, \mathrm{d}x,\tag{6.3b}$$

$$I_3 = \int_{-L/2}^{L/2} \left(\frac{1}{3} (u^3 + v^3) + \frac{1}{2} (uTu_x + vTv_x + u\tilde{T}v_x + v\tilde{T}u_x) \right) dx.$$
 (6.3c)

$$I_{4} = \int_{-L/2}^{L/2} \left(\frac{u^{4} - v^{4}}{4} + \frac{u_{x}^{2} - v_{x}^{2}}{8} + \frac{3}{8} \left((Tu_{x})^{2} - (Tv_{x})^{2} - (\tilde{T}u_{x})^{2} + (\tilde{T}v_{x})^{2} \right) + \frac{3}{4} \left(u^{2}Tu_{x} - v^{2}Tv_{x} \right) + \frac{3}{4} \left(u^{2}\tilde{T}v_{x} - v^{2}\tilde{T}u_{x} \right) \right) dx.$$

$$(6.3d)$$

Proof. Adding equations (5.7b) and (5.7d), we find

$$W_{t} + Z_{t} = -\frac{2}{\epsilon} (1 - e^{-W}) W_{x} - TW_{xx} - \tilde{T}Z_{xx} + W_{x}TW_{x} + W_{x}\tilde{T}Z_{x}$$

$$-\frac{2}{\epsilon} (1 - e^{Z}) Z_{x} + TZ_{xx} + \tilde{T}W_{xx} + Z_{x}TZ_{x} + Z_{x}\tilde{T}W_{x}.$$
(6.4)

Thus,

$$\frac{\mathrm{d}}{\mathrm{d}t} \int_{-L/2}^{L/2} (W+Z) \,\mathrm{d}x = \int_{\mathbb{R}} \left(W_x T W_x + W_x \tilde{T} Z_x + Z_x T Z_x + Z_x \tilde{T} W_x \right) \,\mathrm{d}x.$$

Using the anti-self-adjointness (B.2) of the operators T and \tilde{T} , the integral on the right-hand side vanishes. The remainder of the proof is identical to that of [7, Theorem 4] and hence omitted.

APPENDIX A. ELLIPTIC FUNCTIONS

Definition A.1 (Weierstrass functions). Consider a pair of complex numbers ω_1, ω_2 satisfying Im $(\omega_2/\omega_1) > 0$. Let $\Lambda := 2\omega_1\mathbb{Z} + 2\omega_2\mathbb{Z}$. Then, the Weierstrass σ -function with half-periods ω_1, ω_2 is defined as

$$\sigma(z|\omega_1, \omega_2) := z \prod_{\lambda \in \Lambda \setminus \{0\}} \left(\left(1 - \frac{z}{\lambda} \right) \exp\left(\frac{z}{\lambda} + \frac{z^2}{2\lambda^2} \right) \right), \tag{A.1}$$

the Weierstrass ζ -function is defined as

$$\zeta(z|\omega_1, \omega_2) := \partial_z \log \sigma(z|\omega_1, \omega_2), \tag{A.2}$$

and the Weierstrass \wp -function is defined as

$$\wp(z|\omega_1,\omega_2) := -\partial_z \zeta(z|\omega_1,\omega_2). \tag{A.3}$$

It is convenient to define minor modifications of the Weierstrass functions with enhanced periodicity properties.

Definition A.2 (Modified Weierstrass functions). The modified Weierstrass σ -functions are

$$\sigma_j(z|\omega_1, \omega_2) = e^{-\eta_j z^2/2\omega_j} \sigma(z|\omega_1, \omega_2), \qquad j = 1, 2, \tag{A.4}$$

the modified Weierstrass ζ -functions are

$$\zeta_j(z|\omega_1, \omega_2) = \partial_z \log \sigma_j(z|\omega_1, \omega_2) = \zeta(z|\omega_1, \omega_2) - \frac{\eta_j}{\omega_j} z, \qquad j = 1, 2, \tag{A.5}$$

and the modified Weierstrass \wp -functions are

$$\wp_j(z|\omega_1,\omega_2) = -\partial_z \zeta_j(z|\omega_1,\omega_2) = \wp(z|\omega_1,\omega_1) + \frac{\eta_j}{\omega_j}, \qquad j = 1, 2,$$
(A.6)

where $\eta_j := \zeta(\omega_j | \omega_1, \omega_2)$ for j = 1, 2.

Proposition A.3. The modified Weierstrass functions satisfy the following identities:

$$\sigma_j(z+2\omega_j) = -\sigma_j(z), \qquad j = 1, 2, \tag{A.7}$$

$$\zeta_j(z+2\omega_j) = \zeta_j(z), \qquad j = 1, 2, \tag{A.9}$$

$$\zeta_1(z+2\omega_2) = \zeta_1(z) - \frac{i\pi}{\omega_1}, \qquad \zeta_2(z+2\omega_1) = \zeta_2(z) + \frac{i\pi}{\omega_2},$$
(A.10)

$$\wp_i(z + 2\omega_i) = \wp_i(z), \qquad j, k = 1, 2. \tag{A.11}$$

Proof. (A.7) and (A.8). We write

$$\sigma_j(z+2\omega_k) = e^{-\eta_j(z+2\omega_k)^2/2\omega_j}\sigma(z+2\omega_k).$$

Using the identity [8, Eq. 23.2.15] $\sigma(z+2\omega_i)=-e^{-2\eta_i(z+\omega_i)}\sigma(z)$, we have

$$\sigma_{j}(z+2\omega_{k}) = -e^{-\eta_{j}(z+2\omega_{k})^{2}/2\omega_{j}}e^{2\eta_{k}(z+\omega_{k})}\sigma(z)$$

$$= -e^{-\eta_{j}z^{2}/2\omega_{j}}e^{-2\eta_{j}(\omega_{k}z+\omega_{k}^{2})/\omega_{j}}e^{2\eta_{k}(z+\omega_{k})}\sigma(z)$$

$$= -e^{2(z+\omega_{k})(\eta_{k}-\omega_{k}\eta_{j}/\omega_{j})}\sigma_{j}(z).$$

When k = j, we immediately obtain (A.7). Otherwise, we use the identity [8, Eq. 23.2.14] $\eta_1\omega_2 - \eta_2\omega_1 = i\pi/2$, so that

where

$$f_j(z) := \frac{\sigma_j''(z)}{\sigma_j(z)} = \frac{\sigma''(z)}{\sigma(z)} - \frac{\eta_j}{\omega_j} \left(2z\zeta_j(z) + \frac{\eta_j}{\omega_j} z^2 + 1 \right), \qquad j = 1, 2.$$
 (A.14)

Proof. (A.12). We recall the identity $\zeta(z)^2 = \wp(z) + (\sigma''/\sigma)(z)$. Using (A.5-A.6) to write $\zeta(z) = \zeta_j(z) + (\eta_j/\omega_j)z$ and $\wp(z) = \wp_j(z) - \eta_j/\omega_j$, we obtain the result after some algebra.

(A.13). We start from the identity $(\zeta(x) + \zeta(y) + \zeta(z))^2 = \wp(x) + \wp(y) + \wp(z)$, which is valid when x + y + z = 0. We consider the particular case $(\zeta(z - a) - \zeta(z - b) + \zeta(a - b))^2 = \wp(z - a) + \wp(z - b) + \wp(a - b)$ (where we have used the fact that ζ is an odd function). $$\zeta_{j}(x-a)\zeta_{j}(x-b) = (\zeta_{j}(z-a) - \zeta_{j}(z-b))\zeta_{j}(a-b) + \frac{1}{2}(\zeta_{j}(z-a)^{2} - \wp_{j}(z-a) + \zeta_{j}(z-b)^{2} - \wp_{j}(z-b) + \zeta_{j}(a-b)^{2} - \wp_{j}(a-b)) - \frac{3\eta_{j}}{2\omega_{j}}$$

$$= (\zeta_{j}(z-a) - \zeta_{j}(z-b))\zeta_{j}(a-b) + \frac{1}{2}(f_{j}(z-a) + f_{j}(z-b) + f_{j}(a-b)) - \frac{3\eta_{j}}{2\omega_{j}},$$

where we have used the previous result.

Appendix B. Properties of the T and \tilde{T} operators

In this section we collect and prove several identities for the T and \tilde{T} operators (1.2).

Proposition B.1 (Properties of T and \tilde{T} on the circle). The operators T and \tilde{T} defined in (1.2) have the following properties

$$\partial_x(Tf)(x) = (T\partial_x f)(x), \quad \partial_x(\tilde{T}f)(x) = (\tilde{T}\partial_x f)(x), \qquad x \in [-L/2, L/2),$$
 (B.1)

$$\int_{-L/2}^{L/2} f(Tg) \, \mathrm{d}x = -\int_{-L/2}^{L/2} (Tf)g \, \mathrm{d}x, \quad \int_{-L/2}^{L/2} f(\tilde{T}g) \, \mathrm{d}x = -\int_{-L/2}^{L/2} (\tilde{T}f)g \, \mathrm{d}x, \tag{B.2}$$

$$(\tilde{T}Tf)(x) = (T\tilde{T}f)(x), \qquad x \in [-L/2, L/2), \tag{B.3}$$

$$(\tilde{T}\tilde{T}f)(x) = (TTf)(x) + f(x) - \frac{2}{L} \int_{-L/2}^{L/2} f(x) dx, \qquad x \in [-L/2, L/2),$$
 (B.4)

$$T[1] = \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta_1(x' - x) \, \mathrm{d}x' = 0, \tag{B.5}$$

$$\tilde{T}[1] = \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta_1(x' - x + i\delta) \, dx' = -i, \tag{B.6}$$

$$\int_{-L/2}^{L/2} \zeta_1(x+a) \, \mathrm{d}x = \begin{cases} -\mathrm{i}\pi, & 0 < \text{Im } a < 2\delta, \\ +\mathrm{i}\pi, & -2\delta < \text{Im } a < 0. \end{cases}$$
(B.7)

The proofs of (B.1-B.4) are similar to those for the analogous properties of T and \tilde{T} on \mathbb{R} [7, Proposition A.1] and hence omitted. We prove (B.5-B.7).

Proof. (B.5) and (B.6). By the definition of ζ_1 ,

$$T[1] = \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta_1(x' - x) \, dx'$$

$$= \frac{1}{\pi} \int_{-L/2}^{L/2} \zeta(x' - x) \, dx' - \frac{2\eta_1}{L} \frac{1}{\pi} \int_{-L/2}^{L/2} (x' - x) \, dx'.$$
(B.8)

The first integral in (B.5) can be computed using the definition of the principal value integral and the standard elliptic identities [8] $\sigma(-z) = -\sigma(z)$, $\sigma(z + 2\omega_1) = -e^{-2\eta_1(z+\omega_1)}\sigma(z)$:

$$\frac{1}{\pi} \int_{-L/2}^{L/2} \zeta(x' - x) \, dx' = \frac{1}{\pi} \lim_{\epsilon \to 0^+} \left(\int_{-L/2}^{x - \epsilon} + \int_{x + \epsilon}^{L/2} \right) \zeta(x' - x) \, dx'
= \frac{1}{\pi} \lim_{\epsilon \to 0^+} \left(\log |\sigma(x' - x)| \Big|_{-L/2}^{x - \epsilon} + \log |\sigma(x' - x)| \Big|_{x + \epsilon}^{L/2} \right)$$

$$= \frac{1}{\pi} \log \left| \frac{\sigma(x - L/2)}{\sigma(x + L/2)} \right|$$
$$= -\frac{2\eta_1 x}{\pi}.$$

The second integral in (B.8) is found to be

$$\frac{2\eta_1}{L} \frac{1}{\pi} \int_{-L/2}^{L/2} (x' - x) \, \mathrm{d}x' = -\frac{2\eta_1 x}{\pi}.$$

Hence, the right-hand side of (B.5) vanishes.

The function f(z) = 1 satisfies the conditions of Lemma 3.2, hence (B.6) follows from (B.5) and (3.8).

(B.7). We consider the integral

$$\oint_{\Gamma} \zeta_1(z+\mathrm{i}\delta)\,\mathrm{d}z,$$

where Γ is a rectangular contour with vertices at $\pm L/2$ and $\pm L/2 + i(\operatorname{Im} a - \delta)$, oriented so the integral along the real axis is positively-oriented. When $0 < \operatorname{Im} a < 2\delta$, the contour encloses no poles, so we have, after cancelling vertical contributions by periodicity,

$$0 = \oint_{\Gamma} \zeta_1(z + i\delta) dz = \int_{-L/2}^{L/2} \zeta_1(x + i\delta) dx - \int_{-L/2 + i(\operatorname{Im} a - \delta)}^{L/2 + i(\operatorname{Im} a - \delta)} \zeta_1(z + i\delta) dz.$$

Changing variables in the second integral, we have

$$0 = \int_{-L/2}^{L/2} \zeta_1(x + i\delta) dx - \int_{-L/2}^{L/2} \zeta_1(x + i\operatorname{Im} a) dx.$$

Now using (B.6), we find

$$\int_{-L/2}^{L/2} \zeta_1(x + i \operatorname{Im} a) \, dx = -i\pi.$$
 (B.9)

The first case in (B.7) follows from the real translation invariance of (B.9). The proof of the second case in (B.7) is similar after accounting for the pole enclosed by Γ .
