# Singular limit in Hopf bifurcation for doubly diffusive convection equations II: bifurcation and stability

#### Abstract

A singular perturbation problem from the artificial compressible system to the incompressible system is considered for a doubly diffusive convection when a Hopf bifurcation from the motionless state occurs in the incompressible system. It is proved that the Hopf bifurcation also occurs in the artificial compressible system for small singular perturbation parameter, called the artificial Mach number. The time periodic solution branch of the artificial compressible system is shown to converge to the corresponding bifurcating branch of the incompressible system in the singular limit of vanishing artificial Mach number.


## 1 Introduction

This paper studies a singular limit problem for Hopf bifurcation in the artificial compressible system for thermal convection equations in the presence of the diffusion of solute concentration. The system of equations under consideration is written as

Here $\phi=\phi(x, t), \boldsymbol{w}={ }^{\top}\left(w^{1}(x, t), w^{2}(x, t)\right), \theta=\theta(x, t)$ and $\psi=\psi(x, t)$ denote the perturbation of the pressure, velocity field, temperature and solute concentration, respectively, at position $x \in \mathbb{R}^{2}$ and time $t \in \mathbb{R}$, from their values of the motionless state in a thermal convection; $\mathcal{R}_{1}, \mathcal{R}_{2}, \operatorname{Pr}$ and $d$ are non-dimensional positive parameters; $\mathcal{R}_{1}^{2}$ and $\mathcal{R}_{2}^{2}$ are the thermal and salinity Rayleigh numbers, respectively; $\operatorname{Pr}$ and $d$ are called the Prandtl and Lewis numbers, respectively. The parameter $\varepsilon>0$ is called the artificial Mach number.

The system (1.1)-(1.4) is considered on the two dimensional infinite layer $\left\{x=\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2} ; x_{1} \in \mathbb{R}, 0<x_{2}<1\right\}$ under the following boundary condition on the boundary $\left\{x_{2}=0,1\right\}$ :

and the periodic boundary condition in $x_{1}$ for $\phi, \boldsymbol{w}, \theta$ and $\psi$ with period $\frac{2 \pi}{\alpha}$, where $\alpha>0$. The system (1.1)-(1.4) is thus considered in the domain

under the boundary condition (1.5). Here $\mathbb{T}_{a}$ denotes $\mathbb{T}_{a}=\mathbb{R} / a \mathbb{Z}$. We write $u={ }^{\top}(\phi, \boldsymbol{w}, \theta, \psi)$ for the unknown functions of (1.1)-(1.4). Here and in what follows, the superscript ${ }^{\top}$. denotes the transposition.

When $\varepsilon=0$ one obtains the thermal convection equations for a viscous incompressible fluid under the Oberbeck-Boussinesq approximation. A rough explanation of the structure of (1.1)-(1.4) with $\varepsilon=0$ is as follows. The terms including $\mathcal{R}_{1}$ have a symmetric structure which may cause instabilities against the dissipativity by the Laplacians when $\mathcal{R}_{1}$ increases; the terms including $\mathcal{R}_{2}$ have a skew-symmetric structure which may cause oscillatory behavior. Indeed, when $\varepsilon=0$, it was proved in [1] that, for some range of $\mathcal{R}_{2}$, there exists a critical number $\mathcal{R}_{1, c}$ such that if $\mathcal{R}_{1}<\mathcal{R}_{1, c}$ then the motionless state $u=0$ is asymptotically stable, while if $\mathcal{R}_{1}>\mathcal{R}_{1, c}$ then $u=0$ is unstable and nontrivial time periodic solutions bifurcate from $u=0$.

On the other hand, when $\varepsilon>0$, the system (1.1)-(1.4) is a hyperbolicparabolic system and the limit $\varepsilon \rightarrow 0$ is a singular limit from a hyperbolicparabolic system to a parabolic system. One of mathematical questions
is thus whether the artificial compressible system (1.1)-(1.4) gives a good approximation of the incompressible system in the singular limit $\varepsilon \rightarrow 0$.

The aim of this paper is to consider whether the artificial compressible system approximates well the incompressible system when a Hopf bifurcation, i.e., a time periodic bifurcation, occurs in the incompressible system. In this paper we shall investigate the Hopf bifurcation problem of the singularly perturbed system (1.1)-(1.4) with $0<\varepsilon \ll 1$ for $\mathcal{R}_{1}$ near a critical value $\mathcal{R}_{1, c}$, where a Hopf bifurcation occurs from the motionless state $u=0$ in the incompressible system (1.1)-(1.4) with $\varepsilon=0$ for $\mathcal{R}_{1} \sim \mathcal{R}_{1, c}$ as was shown in [1].

The artificial compressible system (1.1)-(1.4) with $\varepsilon>0$ was introduced by Chorin $([2,3,4])$ and Temam ([17, [18]) to avoid the computational difficulties in the incompressible system due to the constraint div $\boldsymbol{w}=0$. By using the artificial compressible system (1.1)-(1.4) with small $\varepsilon>0$, Chorin [2, 3, 4] computed stationary convective bifurcating patterns near the onset of convection when $\mathcal{R}_{2}=0$, which suggests the artificial compressible system (1.1)-(1.4) would give a good approximation of the incompressible system. Temam ([17, [18, 19]) introduced the artificial compressible system with an additional stabilizing nonlinear term (in the context of (1.1)-(1.4), the corresponding stabilizing terms are to be $+\frac{1}{2}(\operatorname{div} \boldsymbol{w}) \boldsymbol{w},+\frac{1}{2}(\operatorname{div} \boldsymbol{w}) \theta$ and $+\frac{1}{2}(\operatorname{div} \boldsymbol{w}) \psi$ which are added on the left-hand side of (1.2), (1.3) and (1.4), respectively); and for such a system with stabilizing nonlinear term, the global in time solutions of the initial boundary value problem for the artificial compressible system on a two-dimensional bounded domain $D$ converge in the limit $\varepsilon \rightarrow 0$ to the one for the incompressible system on time interval $(0, T)$ for all $T>0$. Convergence result was also established in the framework of weak solutions on three-dimensional bounded domains. Donatelli [5, 6] and Donatelli and Marcati [7, 8] proved similar convergence results in the case of unbounded domains on any finite time interval by using the wave equation structure of the pressure and the dispersive estimates.

In this paper we shall show that a time periodic bifurcation occurs in (1.1)-(1.4) with $0<\varepsilon \ll 1$ for $\mathcal{R}_{1}$ near the criticality $\mathcal{R}_{1, c}$ and the bifurcating solution branch converges as $\varepsilon \rightarrow 0$ to the time priodic bifurcating solution branch of the incompressible system obtained in [1].

To prove these results, we shall employ the Lyapunov-Schmidt method in a time periodic function space $\mathcal{X}_{a}$. For this purpose, we need to investigate the spectral properties of the operator $\partial_{t}+L_{\mathcal{R}_{1}}^{\varepsilon}$ in $\mathcal{X}_{a}$ for $\mathcal{R}_{1}$ near the criticality $\mathcal{R}_{1, c}$, where $L_{\mathcal{R}_{1}}^{\varepsilon}$ denotes the linearized operator around $u=0$ for (1.1) $-(1.4)$,
which was studied in [11] in detail. Based on the spectral properties of the operator $\partial_{t}+L_{\mathcal{R}_{1}}^{\varepsilon}$, we shall show that (1.1)-(1.4) has a nontrivial bifurcating time periodic solution $u^{\varepsilon}$ for sufficiently small $\varepsilon>0$ and that $u^{\varepsilon}$ converges to the bifurcating time periodic solution of the incompressible system (1.1)(1.4) with $\varepsilon=0$ as $\varepsilon \rightarrow 0$.

One of the key points in the proof is to use the norms with $\varepsilon$-weights, which enables us to establish the uniform estimates in the nonlinear problem as well as in the linearized problem. Another key is the fact that the limiting solution of the incompressible system and the eigenfunctions for the critical eigenvalues of $L_{\mathcal{R}_{1}}^{\varepsilon}$ for $\mathcal{R}_{1} \sim \mathcal{R}_{1, c}$ are smooth, which compensate the loss of uniform estimates in $\varepsilon$. There is one more thing to be mentioned. At criticality $\mathcal{R}_{1}=\mathcal{R}_{1, c}^{\varepsilon}$, the linearized problem has nontrivial time periodic solutions and the bifurcating solutions of the nonlinear problem are obtained as a perturbation of a time periodic solution of the linearized problem. The period of the bifurcating solution of the nonlinear problem is also a perturbation of the period of the time periodic solution of the linearized problem. This perturbation of the period is transformed into the equation as a perturbation of the time derivative of the unknown. In the case of the incompressible problem (i.e., in a classical setting), this perturbation term can be regraded as a regular perturbation. In contrast to the classical case, in the case of the artificial compressible problem, this perturbation term is not a regular perturbation. To overcome this difficulty, we put it into the principal part of the linearized operator and establish uniform estimates for small $\varepsilon$.

In the proof, we make use of the two-dimensional aspect of the problem to estimate the nonlinearity uniformly in small $\varepsilon$. It is not straightforward to extend the argument to the three-dimensional problem.

We shall also show that the bifurcating time periodic solutions of (1.1)(1.4) for small $\varepsilon>0$ is stable under perturbations with the same symmetries as those of the time periodic solutions, if the corresponding bifurcating time periodic solutions of the incompressible system is stable. This, in particular, implies that, by using the artificial compressible system with small $\varepsilon>0$, one can numerically compute bifurcating time periodic solutions which are close to the bifurcating ones of the incompressible system near the onset of convection. See [12, 13, 20] for the stability of stationary bifurcating solutions.

This paper is organized as follows. In section 2 we introduce notation used in this paper. In section 3 we state the results on the Hopf bifurcation for the incompressible problem obtained in [1]. In section 4 we state the
result on the occurrence of the Hopf bifurcation in the artificial compressible system with small $\varepsilon$ and also the result on the singular limit $\varepsilon \rightarrow 0$ of the time periodic bifurcating solutions. In section 5 we summarize the results on the spectral properties of the linearized problem obtained in [11]. Section 6 is devoted to a proof of the existence and singular limit. In section 7 we state the result on the stability of the bifurcating solutions and give a proof of the stability.

## 2 Preliminaries

In this section we introduce notation used in this paper. Let $\Omega=\mathbb{T}_{\frac{2 \pi}{\alpha}} \times(0,1)$. We denote by $L^{p}(\Omega)$ the usual $L^{p}$ space on $\Omega$ with norm $\|\cdot\|_{p}$. We also denote by $\boldsymbol{L}^{p}(\Omega)$ the space of all $L^{p}$ vector fields on $\Omega$ with norm $\|\cdot\|_{p}$. The inner product of $L^{2}(\Omega)$ is denoted by $(\cdot, \cdot)_{L^{2}}$. We also denote by $(\cdot, \cdot)_{L^{2}}$ the inner product of $\boldsymbol{L}^{2}(\Omega)$.

The inner product and the norm of $\boldsymbol{L}^{2}(\Omega) \times L^{2}(\Omega) \times L^{2}(\Omega)$ are defined by

## 3 Hopf bifurcation in the incompressible system

In this section we summarize the results on the Hopf bifurcation for the incompressible system (1.1) obtained in [1] and introduce the associated pressure of the velocity field of the bifurcating time periodic solution.

Setting $\varepsilon=0$ in (1.1)-(1.4), we obtain the incompressible system:

The problem (3.1)-(3.2) then has a trivial stationary solution $u=0$ which corresponds to the the motionless state. See [1, 11] for the derivation of the non-dimensional perturbation equations (3.1).

The result on the Hopf bifurcation for (3.1)-(3.2) by Bona, Hsia, Ma and Wang [1] is summarized as follows. There are positive numbers $\mathcal{R}_{2 *}$ and $\mathcal{R}_{2}^{*}$ such that if $\mathcal{R}_{2} \in\left[\mathcal{R}_{2 *}, \mathcal{R}_{2}^{*}\right), \operatorname{Pr}>1$ and $0<d<1$, then there exists a critical number $\mathcal{R}_{1, c}$ such that the basic state $u=0$ is stable when $\mathcal{R}_{1}<\mathcal{R}_{1, c}$; and if $\mathcal{R}_{1}>\mathcal{R}_{1, c}$, then $u=0$ loses its stability and time periodic solutions of the incompressible problem (3.1)-(3.2) bifurcate from $u=0$.

To state the bifurcating result in [1] more precisely, we take $\eta=\mathcal{R}_{1}-\mathcal{R}_{1, c}$ as a bifurcation parameter. The linearized operator $\mathbb{L}_{\mathcal{R}_{1, c}+\eta}$ on $\mathbb{X}_{\sigma}$ is then
given by

We thus change the variable $t \mapsto(1+\omega) t$. The problem is then reduced to finding a nontrivial time periodic solution of period $\frac{2 \pi}{a}$ to the equation

We next introduce the associated pressure $\phi_{\delta}$ of the time periodic bifurcating solution $\boldsymbol{u}_{\delta}$ of (3.4). It is known [9, 16, 19] that there exists the associated pressure $\phi_{\delta} \in L^{2}\left(\mathbb{T}_{\frac{2 \pi}{a}} ; H_{*, \text { sym }}^{1}(\Omega)\right)$ of $\boldsymbol{u}_{\delta}=^{\top}\left(\boldsymbol{w}_{\delta}, \theta_{\delta}, \psi_{\delta}\right)$, namely, there exists a unique $\phi_{\delta} \in L^{2}\left(\mathbb{T}_{\frac{2 \pi}{a}} ; H_{*, s y m}^{1}(\Omega)\right)$ such that $u_{\delta}={ }^{\top}\left(\phi_{\delta}, \boldsymbol{u}_{\delta}\right) \in \mathcal{Y}_{a}$ is a time periodic solution of

To see the boundedness of $\left\{\Phi_{\delta}\right\}_{|\delta| \leq \delta_{0}}$, we first observe that $\boldsymbol{U}_{\delta}$ is a time periodic solution of

It then follows that $\left\{\Phi_{\delta}\right\}_{|\delta| \leq \delta_{0}}$ is bounded in $H^{1}\left(\mathbb{T}_{\frac{2 \pi}{a}} ; H_{*}^{1}(\Omega)\right)$.

In summary we have the following proposition.

## 4 Hopf bifurcation in the artificial compressible system

In this section we state the result on the occurrence of a Hopf bifurcation bifurcation in the artificial compressible system (1.1)-(1.4) under (1.5) and the result on the singular limit $\varepsilon \rightarrow 0$ for the time periodic bifurcating solutions.

We fix the parameters $\operatorname{Pr}, d$ and $\mathcal{R}_{2}$ in such a way that these parameters satisfies the assumption of Proposition 3.1.

The time periodic problem for the artificial compressible system (1.1)(1.5) is formulated as

As for the spectrum of the linearized operator $-L_{\mathcal{R}_{1}}^{\varepsilon}$ for $\mathcal{R}_{1}$ close to the criticality $\mathcal{R}_{1, c}$, we obtained the following result in [11]. (Cf., [14].)

Theorem 4.1 ([11]) (i) There exist positive constants $\Lambda_{1}, \varepsilon_{1}$ and $\eta_{1}$ such that for each $0<\varepsilon \leq \varepsilon_{1}$ there exists a critical value $\mathcal{R}_{1, c}^{\varepsilon}=\mathcal{R}_{1, c}+O\left(\varepsilon^{2}\right)$ such that if $|\eta| \leq \eta_{1}$ with $\eta=\mathcal{R}_{1}-\mathcal{R}_{1, c}^{\varepsilon}$, then

Here $a^{\varepsilon}$ is a constant satisfying $a^{\varepsilon}=a+O\left(\varepsilon^{2}\right)$.
The eigenspaces for $\lambda_{ \pm}^{\varepsilon}(0)$ are spanned by $u_{ \pm}^{\varepsilon}$, respectively, where $u_{ \pm}^{\varepsilon}$ satisfy $\overline{u_{-}^{\varepsilon}}=u_{+}^{\varepsilon}$ and $u_{ \pm}^{\varepsilon}=u_{ \pm}+O\left(\varepsilon^{2}\right)$.
(ii) For $j= \pm$, the eigenprojections $P_{j}^{\varepsilon}$ for $\lambda_{j}^{\varepsilon}(0)(j= \pm)$ satisfies

Here $u_{ \pm}$and $u_{ \pm}^{*}$ are functions defined in (3.6).

Furthermore, if $k \in \mathbb{Z}$ with $k \geq 0$ and $1 \leq p \leq 2$, there exists a positive constant $\tilde{\varepsilon}_{1}=\tilde{\varepsilon}_{1}(k, p, \Omega)$ such that

By Theorem 4.1, a Hopf bifurcation is expected to occur when $\mathcal{R}_{1}$ passes the critical value $\mathcal{R}_{1, c}^{\varepsilon}$. In fact, we have the following bifurcation result.

To fix the time interval, we change the variables $t$ and $u$ into $\tilde{t}$ and $\tilde{u}$, respectively, by $\frac{a^{\varepsilon}}{a} t=\tilde{t}$ and $u(x, t)=\tilde{u}(x, \tilde{t})$. Omitting the tildes $\sim$ of $\tilde{t}$ and $\tilde{u}$, we see from (4.1) that the problem is transformed into

We thus again change the variable $t \mapsto(1+\omega) t$. The problem is then reduced to finding a nontrivial time periodic solution of period $\frac{2 \pi}{a}$ of the following equation

The operators $\mathcal{P}_{ \pm}^{\varepsilon}$ are projections onto the spaces span $\left\{z_{ \pm}^{\varepsilon}\right\}$, respectively. As was shown in [11] (see Theorem 5.4 below), 0 is a semisimple eigenvalue of $B^{\varepsilon}$ and the eigenprojection for the eigenvalue 0 is given by

We state the result on the Hopf bifurcation for the artificial compressible system (1.1)-(1.4).

Theorem 4.2 (i) There exist positive numbers $\varepsilon_{2}$ and $\delta_{2}$ such that if $0<$ $\varepsilon \leq \varepsilon_{2}$, then there exists a nontrivial solution $u_{\delta}^{\varepsilon} \in \mathcal{Y}_{a}$ of (4.4) for $\eta=\eta_{\delta}^{\varepsilon}$ and $\omega=\omega_{\delta}^{\varepsilon}$, where

Here $z_{0}^{\varepsilon}=\operatorname{Re}\left(e^{i a t} u_{+}^{\varepsilon}\right)$ and $\left[U_{\delta}^{\varepsilon}\right]_{\varepsilon,+}=0$; and $\tilde{\eta}_{0}^{\varepsilon}$, $\tilde{\omega}_{0}^{\varepsilon}, \tilde{\eta}_{1}^{\varepsilon}(\delta)$, $\tilde{\omega}_{1}^{\varepsilon}(\delta)$ and $U_{\delta}^{\varepsilon}$ satisfy $\left|\tilde{\eta}_{0}^{\varepsilon}\right|+\left|\tilde{\omega}_{0}^{\varepsilon}\right| \leq C$ and $\left|\tilde{\eta}_{1}^{\varepsilon}(\delta)\right|+\left|\tilde{\omega}_{1}^{\varepsilon}(\delta)\right| \leq C$; and, furthermore, $U_{+}^{\varepsilon}$ satisfies $\partial_{t} U_{\delta}^{\varepsilon} \in \mathcal{Y}_{a}$ with $\left[\partial_{t} U_{\delta}^{\varepsilon}\right]_{+, \varepsilon}=0$ and $\left\|\left.\left\|U_{\delta}^{\varepsilon}\right\|\right|_{\varepsilon, \mathcal{Y}_{a}}+\right\|\left\|\partial_{t} U_{\delta}^{\varepsilon}\right\|_{\varepsilon, y_{a}} \leq C$ uniformly in $0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$.
(ii) Let $u_{\delta}=^{\top}\left(\phi_{\delta}, \boldsymbol{u}_{\delta}\right)={ }^{\top}\left(\delta\left(p_{0}+\delta \Phi_{\delta}\right), \delta\left(\boldsymbol{z}_{0}+\delta \boldsymbol{U}_{\delta}\right)\right)$ be the time periodic bifurcating solution of (3.5) for $\eta=\eta_{\delta}$ and $\omega=\omega_{\delta}$ given in Proposition 3.4. The stability of the bifurcating solution $u_{\delta}^{\varepsilon}$ is also an important question; we shall investigate it in section 7 .

To prove Theorem 4.2, we employ the spectral properties of $-B^{\varepsilon}$ which was investigated in [11]. Some of them will be summarized in section 5 which will then be used in sections 6 and 7 .

In what follows we assume that $\mathcal{R}_{1}$ is in the interval $\left[\frac{1}{2} \mathcal{R}_{1, c}, \frac{3}{2} \mathcal{R}_{1, c}\right]$.

## 5 Spectrum of $B^{\varepsilon}$

In this section we summarize the results on the spectrum of $B^{\varepsilon}$ obtained in [11.

We begin with the following lemma.

Lemma 5.1 ([11, Lemma 5.1]) Let $\beta$ and $T$ be positive constants. Suppose that $u_{0} \in X^{1}$ and let $F=^{\top}(f, \boldsymbol{g}, h, k) \in L^{2}(0, T ; X)$. Then there is a unique solution $u(t) \in L^{2}(0, T ; Y) \cap H^{1}(0, T ; X)$ of the problem

uniformly for $0 \leq t \leq T$ and $0<\varepsilon \leq \varepsilon_{1}$ and $\beta$. Furthermore, if $\beta \geq \beta_{1}$, then the estimate

We denote by $\mathscr{V}_{\omega}^{\varepsilon}(t)$ the restriction of the semigroup $e^{-\frac{a t}{a^{\varepsilon}(1+\omega)} L_{\mathcal{R}_{1, c}}^{\varepsilon}}$ to the space $X^{1}$ :

Furthermore, if $\operatorname{Re} \lambda>-\kappa_{1}$, then $\left(I-e^{\left.-\frac{2 \pi}{a} \lambda \mathscr{V}_{0}^{\varepsilon}\left(\frac{2 \pi}{a}\right)\right)} Q^{\varepsilon}\right.$ has a bounded inverse on $Q^{\varepsilon} X^{1}$ and its inverse $\left[\left(I-e^{-\frac{2 \pi}{a} \lambda \mathscr{V}_{0}^{\varepsilon}}\left(\frac{2 \pi}{a}\right)\right) Q^{\varepsilon}\right]^{-1}$ satisfies

The projection $\mathcal{P}^{\varepsilon}$ is an eigenprojection for the eigenvalue 0 and $\mathcal{Q}^{\varepsilon}$ is a projection on $R\left(B^{\varepsilon}\right)$ along $N\left(B^{\varepsilon}\right)$.
(iv) Let $F={ }^{\top}(f, \boldsymbol{F}) \in \mathcal{X}_{a}$. Then the equation

To prove the Hopf bifurcation in (4.4), Theorem 5.4 is insufficient; the term $\omega \partial_{t} u$ on the left-hand side of the $\mathcal{Q}^{\varepsilon}$ part of the equation (4.4) cannot be regarded as a perturbation of $B^{\varepsilon} u$. To overcome this we shall put the term $\omega \partial_{t}$ into the principal part, so we define the operator $B^{\varepsilon}(\omega)$ on $\mathcal{X}_{a}$ by

uniformly for $0<\varepsilon \leq \varepsilon_{1}$ and $|\omega| \leq \frac{1}{4}$.

## 6 Proof of Theorem 4.2

In this section we prove Theorem 4.2, i.e., we shall prove that a nontrivial solution branch of (4.4) bifurcates from $\{\eta, u\}=\{0,0\}$. In what follows, we will use the same letters $\varepsilon_{0}$ and $\delta_{0}$ for bounds of the ranges of $\varepsilon$ and $\delta$, even when they should be taken suitably smaller than those of the previous ones if no confusion will occur from the context.

### 6.1 Proof of Theorem 4.2 (i)

We look for a solution $u$ of (4.4) in the form

where $\delta$ is a small parameter; $z_{0}^{\varepsilon}=2 \operatorname{Re} z_{+}^{\varepsilon}$; and $U^{\varepsilon}$ is a real valued function in $\mathcal{Y}_{a}$ satisfying $\left[U^{\varepsilon}\right]_{+, \varepsilon}=0$.

We note that if $U$ is real valued, then $[U]_{-, \varepsilon}=\overline{[U]_{+, \varepsilon}}$. Therefore, the condition $[U]_{+, \varepsilon}=0$ automatically implies the condition $[U]_{-, \varepsilon}=0$, which in turn implies that $U=\mathcal{Q}^{\varepsilon} U \in R\left(B^{\varepsilon}\right)=\mathcal{Q}^{\varepsilon} \mathcal{X}_{a}$ by Theorem 5.4.

We first collect basic facts concerning $\mathcal{P}^{\varepsilon}$.
Lemma 6.1 (i) It holds that $\left[z_{0}^{\varepsilon}\right]_{+, \varepsilon}=1,\left[\partial_{t} z_{0}^{\varepsilon}\right]_{+, \varepsilon}=i a$ and $\mathcal{P}^{\varepsilon} z_{0}^{\varepsilon}=z_{0}^{\varepsilon}$.
(ii) It holds that $\mathcal{P}_{ \pm}^{\varepsilon} \partial_{t} \subset \partial_{t} \mathcal{P}_{ \pm}^{\varepsilon}= \pm i a \mathcal{P}_{ \pm}^{\varepsilon}$ and $\mathcal{P}^{\varepsilon} \partial_{t} \subset \partial_{t} \mathcal{P}^{\varepsilon}$.
(iii) If $u$ is real valued, then $\mathcal{P}^{\varepsilon} u=0$ is equivalent to $[u]_{+, \varepsilon}=0$ that is equivalent to $\operatorname{Re}[u]_{+, \varepsilon}=\operatorname{Im}[u]_{+, \varepsilon}=0$.

Lemma 6.1 can be proved by straightforward computations. We omit the proof.

The following estimates will be used to estimate nonlinear terms. We define the bilinear form $M(\cdot, \cdot)$ by

Lemma 6.2 The following inequalities hold for $u_{j}={ }^{\top}\left(\phi_{j}, \boldsymbol{u}_{j}\right) \in \mathcal{Y}_{a}(j=$ $1,2,3)$ uniformly in $0<\varepsilon \leq \varepsilon_{0}$ :

(iii) $\left\|\left|\left|M\left(z_{0}^{\varepsilon}, u\right)\right|\left\|_{\varepsilon, \mathcal{X}_{a}} \leq C\left|\|u \mid\|_{\varepsilon, y_{a}}\right.\right.\right.\right.$,
(iv) $\int_{0}^{\frac{2 \pi}{a}}\left|\left(\boldsymbol{N}\left(\boldsymbol{u}_{1}, \boldsymbol{u}_{2}\right), \boldsymbol{u}_{3}\right)\right| d t \leq C| |\left|u_{1}\right|\left\|\left._{\varepsilon, y_{a}}| |\left|u_{2}\right|\left|\|_{\varepsilon, y_{a}}\right|| | u_{3}| |\right|_{\varepsilon, y_{a}}\right.$,
(v) $\int_{0}^{\frac{2 \pi}{a}} \varepsilon^{2}\left\|\boldsymbol{N}\left(\boldsymbol{u}_{1}, \boldsymbol{u}_{2}\right)\right\|_{2}^{2} d t \leq C| | u_{1}\left|\left\|_{\varepsilon, \mathcal{y}_{a}}^{2}\left|\left\|u_{2} \mid\right\|_{\varepsilon, \mathcal{y}_{a}}^{2}\right.\right.\right.$.

We look for a solution $u$ in the form (6.1) of the equation (4.4) for $\eta=\delta^{2} \tilde{\eta}^{\varepsilon}$ and $\omega=\delta^{2} \tilde{\omega}^{\varepsilon}$. This scaling of $\eta$ and $\omega$ is due to the fact $\left[N\left(z_{0}^{\varepsilon}\right)\right]_{+, \varepsilon}=0$. We substitute $\{\eta, \omega, u\}=\left\{\delta^{2} \tilde{\eta}^{\varepsilon}, \delta^{2} \tilde{\omega}^{\varepsilon}, \delta\left(z_{0}^{\varepsilon}+\delta U^{\varepsilon}\right)\right\}$ into (4.4) and divide the resulting equation by $\delta^{2}$. We then obtain

We decompose (6.2) into its $\mathcal{P}^{\varepsilon}$ and $\mathcal{Q}^{\varepsilon}$ parts. Applying $\mathcal{P}^{\varepsilon}$ and $\mathcal{Q}^{\varepsilon}$ to (6.2) and noting that $\left[N\left(z_{0}^{\varepsilon}\right)\right]_{+, \varepsilon}=0$, we see from Lemma 6.1 that

a^{\varepsilon} \tilde{\omega}^{\varepsilon}+\tilde{\eta}^{\varepsilon} \operatorname{Im}\left[K z_{0}^{\varepsilon}\right]_{+, \varepsilon}+\delta \tilde{\eta}^{\varepsilon} \operatorname{Im}\left[K U^{\varepsilon}\right]_{+, \varepsilon}+\operatorname{Im}\left[M\left(z_{0}^{\varepsilon}, U^{\varepsilon}\right)+\delta N\left(U^{\varepsilon}\right)\right]_{+, \varepsilon}=0,  \tag{6.4}\\
B^{\varepsilon}\left(\delta^{2} \tilde{\omega}^{\varepsilon}\right) U^{\varepsilon}+\mathcal{Q}^{\varepsilon}\left(\delta \tilde{\eta}^{\varepsilon} K\left(z_{0}^{\varepsilon}+\delta U^{\varepsilon}\right)+N\left(z_{0}^{\varepsilon}+\delta U^{\varepsilon}\right)\right)=0 . \tag{6.5}
\end{gather*}

Here, as explained in section 55, we regard the term $\frac{a^{\varepsilon}}{a} \delta^{2} \tilde{\omega}^{\varepsilon} \partial_{t} U^{\varepsilon}$ in (6.5) as a part of the principal part of the equation (6.5).

We define the map $\mathcal{B}^{\varepsilon}(\omega): \mathbb{R} \times \mathbb{R} \times \mathcal{Q}^{\varepsilon} \mathcal{Y}_{a} \rightarrow \mathbb{R} \times \mathbb{R} \times \mathcal{Q}^{\varepsilon} \mathcal{X}_{a}$ by

\delta \tilde{\eta}^{\varepsilon} \operatorname{Re}\left[K U^{\varepsilon}\right]_{+, \varepsilon}+\delta \operatorname{Re}\left[N\left(U^{\varepsilon}\right)\right]_{+, \varepsilon} \\
\delta \tilde{\eta}^{\varepsilon} \operatorname{Im}\left[K U^{\varepsilon}\right]_{+, \varepsilon}+\delta \operatorname{Im}\left[N\left(U^{\varepsilon}\right)\right]_{+, \varepsilon} \\
\delta \tilde{\eta}^{\varepsilon} \mathcal{Q}^{\varepsilon} K\left(z_{0}^{\varepsilon}+\delta U^{\varepsilon}\right)+\mathcal{Q}^{\varepsilon} N\left(z_{0}^{\varepsilon}+\delta U^{\varepsilon}\right)
\end{array}\right)
$$

Let us suppose that $\left|\tilde{\eta}^{\varepsilon}\right| \leq 1$ and $\left|\tilde{\omega}^{\varepsilon}\right| \leq 1$. By Theorem 4.1 we see that $\operatorname{Re}\left[K z_{0}^{\varepsilon}\right]_{+, \varepsilon}=\operatorname{Re}\left(\boldsymbol{K} \boldsymbol{u}_{+}, \boldsymbol{u}_{+}^{*}\right)+O\left(\varepsilon^{2}\right)<0$ and $a^{\varepsilon}=a+O\left(\varepsilon^{2}\right)>0$ if $\varepsilon>0$ is sufficiently small. Furthermore, Lemma 5.5 implies that $B^{\varepsilon}\left(\delta^{2} \tilde{\omega}^{\varepsilon}\right): \mathcal{Q}^{\varepsilon} \mathcal{Y}_{a} \rightarrow$ $\mathcal{Q}^{\varepsilon} \mathcal{X}_{a}$ has a bounded inverse if $\varepsilon>0$ and $\delta$ are sufficiently small. As a result, $\mathcal{B}^{\varepsilon}\left(\delta^{2} \hat{\omega}^{\varepsilon}\right)$ has a bounded inverse if $0<\varepsilon \leq \varepsilon_{0}$ and $\delta^{2} \leq \frac{1}{4}$ for some small $\varepsilon_{0}>0$. Therefore, if $0<\varepsilon \leq \varepsilon_{0}$ and $|\delta| \leq \delta_{0}$ for some small $\varepsilon_{0}, \delta_{0}>0$, then (6.6) is rewritten as

\left(\mathcal{B}^{\varepsilon}(\omega)^{-1} \tilde{\mathcal{U}}\right)^{2}= & \frac{1}{a^{\varepsilon}} \tilde{\omega}-\frac{\operatorname{Im}\left[K z_{0}^{\varepsilon}\right]_{+, \varepsilon}}{a^{\varepsilon}}\left(\mathcal{B}^{\varepsilon}(\omega)^{-1} \tilde{\mathcal{U}}\right)^{1} \\
& -\frac{1}{a^{\varepsilon}} \operatorname{Im}\left[M\left(z_{0}^{\varepsilon}, B^{\varepsilon}(\omega)^{-1} U\right)\right]_{+, \varepsilon}, \\

To solve (6.6), we introduce a norm of $\mathbb{R} \times \mathbb{R} \times \mathcal{Y}_{a}$. We define the norm $\|\|\mathcal{U}\|\|_{\varepsilon, \mathbb{R} \times \mathbb{R} \times \mathcal{Y}_{a}}$ of $\mathcal{U}={ }^{\top}(\hat{\eta}, \hat{\omega}, U) \in \mathbb{R} \times \mathbb{R} \times \mathcal{Y}_{a}$ by

We also note that $\left|\left|\left|\partial_{t} U_{0}^{\varepsilon}\right|\right|\right|_{\varepsilon, \mathcal{Y}_{a}} \leq C| |\left|M\left(\partial_{t} z_{0}^{\varepsilon}, z_{0}^{\varepsilon}\right)\right| \|_{\varepsilon, \mathcal{X}_{a}} \leq C$ uniformly for $0<\varepsilon \leq \varepsilon_{0}$.

We now define ${ }^{\top}\left(\tilde{\eta}_{0}^{\varepsilon}, \tilde{\omega}_{0}^{\varepsilon}\right)$ by the solution of

a^{\varepsilon} \tilde{\omega}_{0}^{\varepsilon}+\tilde{\eta}_{0}^{\varepsilon} \operatorname{Im}\left[K z_{0}^{\varepsilon}\right]_{+, \varepsilon}+\operatorname{Im}\left[M\left(z_{0}^{\varepsilon}, U_{0}^{\varepsilon}\right)\right]_{+, \varepsilon}=0 \tag{6.10}
\end{gather*}

Using the estimate of $U_{0}^{\varepsilon}$, we have $\left|\tilde{\eta}_{0}^{\varepsilon}\right|+\left|\tilde{\omega}_{0}^{\varepsilon}\right| \leq C$ uniformly for $0<\varepsilon \leq \varepsilon_{0}$. We thus obtain $\mathcal{U}_{0}^{\varepsilon}={ }^{\top}\left(\tilde{\eta}_{0}, \tilde{\omega}_{0}, U_{0}^{\varepsilon}\right)$ which is the solution of

\end{equation*}

By Theorem 4.1, Lemmas 5.5 and 6.2, we see that $D_{1}<\infty$ and $\mathcal{U}_{0}^{\varepsilon}$ satisfies

We now define $\mathcal{U}_{n}^{\varepsilon}={ }^{\top}\left(\tilde{\eta}_{n}^{\varepsilon}, \tilde{\omega}_{n}^{\varepsilon}, U_{n}^{\varepsilon}\right)(n=1,2, \cdots)$ by

\mathcal{U}_{n}^{\varepsilon}=-\mathcal{B}^{\varepsilon}\left(\delta^{2} \tilde{\omega}_{n-1}^{\varepsilon}\right)^{-1} \mathcal{N}^{\varepsilon}\left(\delta ; \mathcal{U}_{n-1}^{\varepsilon}\right) \quad(n=1,2, \cdots)
$$

We shall prove that the sequence $\left\{\mathcal{U}_{n}^{\varepsilon}\right\}_{n=0}^{\infty}$ converges to a solution $\mathcal{U}^{\varepsilon}=$ ${ }^{\top}\left(\tilde{\eta}^{\varepsilon}, \tilde{\omega}^{\varepsilon}, U^{\varepsilon}\right)$ of (6.6) satisfying $\partial_{t} U^{\varepsilon} \in \mathcal{Q}^{\varepsilon} \mathcal{Y}_{a}$ with estimates for $\mathcal{U}^{\varepsilon}$ and $\partial_{t} U^{\varepsilon}$ uniformly in $0<\varepsilon \leq \varepsilon_{0}$ and $|\delta| \leq \delta_{0}$.

We claim that there exists a positive constant $\delta_{0}$ such that if $|\delta| \leq \delta_{0}$, then

Indeed, (6.12) can be proved by induction. We have already seen that (6.12) holds for $n=0$. Suppose that (6.12) holds with $n$ replaced by $n-1$ $(n \geq 1)$. We shall show that (6.12) also holds for $n$.

We take $\delta$ so that $|\delta| \leq 1$ and $D_{1} \delta^{2} \leq \frac{1}{4}$. Writing

Taking $\delta$ in such a way that $|\delta| \leq \min \left\{1, \frac{1}{4 D_{1}}, \frac{2}{3 C\left(1+3 D_{1}\right)}\right\}$, we have

### 6.3 Proof of Theorem 4.2 (iii)

We next prove Theorem 4.2 (iii), i.e., the uniqueness of time periodic solutions up to translations in the time variable $t$.

We introduce notation. We set $z_{0}^{\varepsilon, \tau}=2 \operatorname{Re}\left(e^{i a \tau} z_{+}^{\varepsilon}\right)$ and $\left(z_{0}^{\varepsilon *}\right)^{\tau}=2 \operatorname{Re}\left(e^{i a \tau} z_{+}^{\varepsilon *}\right)$ for a constant $\tau \in\left[-\frac{\pi}{a}, \frac{\pi}{a}\right)$ and define $[u]_{+, \varepsilon}^{(\tau)}$ by $[u]_{+, \varepsilon}^{(\tau)}=\left\langle u, e^{i a \tau} z_{+}^{\varepsilon *}\right\rangle_{\varepsilon}=$ $e^{-i a \tau}[u]_{+, \varepsilon}$. We note that $\mathcal{P}_{ \pm}^{\varepsilon}$ can be expressed as

We thus conclude that if $\left|\eta^{\varepsilon}\right|+\left|\left|\left|u^{\varepsilon}\right| \|_{\varepsilon, \nu_{a}} \leq r_{0},\left|\omega^{\varepsilon}\right| \leq \frac{1}{4}\right.\right.$ and $u^{\varepsilon}=U^{\varepsilon} \in R\left(B^{\varepsilon}\right)$, then $u^{\varepsilon}=0$.

Assume next that $u_{0}^{\varepsilon} \neq 0$ in (6.32). \leq C\{ & \varepsilon^{2}\left\|\phi_{1}\right\|_{L^{2}\left(\mathbb{T}_{\frac{2}{a}}^{a} ; L^{2}(\Omega)\right)}+\varepsilon^{2}\left\|\boldsymbol{u}_{2}\right\|_{L^{2}\left(\mathbb{T}_{\frac{\pi}{a}}^{a} ;\left(\boldsymbol{X}^{1}\right)^{*}\right)} \\

## $7 \quad$ Stability of bifurcating solutions

Throughout this section we denote $T_{a}=\frac{2 \pi}{a}$. In what follows, we will use the same letters $\varepsilon_{2}$ and $\delta_{2}$ for bounds of the ranges of $\varepsilon$ and $\delta$, even when they should be taken suitably smaller than those of the previous ones if no confusion will occur from the context.

We investigate the linearized problem around $u_{\delta}^{\varepsilon}(t)$. The linearized problem around $u_{\delta}^{\varepsilon}(t)$ then takes the form

By Theorem 4.2, we have $\left\|\hat{u}_{\delta}^{\varepsilon}\right\| \|_{\varepsilon, y_{a}} \leq C$ uniformly in $0<\varepsilon \leq \varepsilon_{1}$ and $|\delta| \leq \delta_{1}$. Based on this, we see, by a perturbation argument, that there are positve constants $\varepsilon_{2}$ and $\delta_{2}$ such that if $0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$, then the problem (7.1)-(7.2) has a unique solution $u \in \mathcal{Y}\left(s, s+T_{a}\right)$ and it satisfies the estimate

Let $\mathscr{U}_{\delta}^{\varepsilon}(t, s)$ be the solution operator for (7.1) -(7.2) with $F=0$ and let $\widetilde{\mathscr{U}_{\delta}^{\varepsilon}}(t, s)$ be the solution operator for (7.1)-(7.2) with $v=0$. The solution $u$ of (7.1)-(7.2) is then written as

uniformly for $s \in \mathbb{R}, 0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$.
Since the bifurcating solution $u_{\delta}^{\varepsilon}(t)=\delta\left(z_{0}^{\varepsilon}(t)+\delta U^{\varepsilon}(t)\right)$ is a time periodic function of period $T_{a}$, its stability is determined by the spectrum of $\mathscr{U}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)$. We shall investigate the spectrum of $\mathscr{U}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)$ as a perturbation of that of $\mathscr{V}_{\omega_{\delta}^{\varepsilon}}^{\varepsilon}\left(T_{a}\right)$. Here recall that $\mathscr{V}_{\omega_{\delta}^{\varepsilon}}^{\varepsilon}(t)=\left.e^{-\frac{a t}{a^{\varepsilon}\left(1+\omega_{\delta}^{\varepsilon}\right)} L_{\mathcal{R}_{1, c}^{\varepsilon}}^{\varepsilon}}\right|_{X^{1}}$. We shall prove the following result on the spectrum of $\mathscr{U}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)$ for $0<|\delta| \ll 1$.

Theorem 7.1 There exist positive constants $\varepsilon_{2}, \delta_{2}$ and $\Lambda_{2}$ such that if $0<$ $\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$, then

Here 1 and $e^{T_{a} \lambda_{\delta}^{\varepsilon}}$ are simple eigenvalues of $\mathscr{U}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)$ and $\lambda_{\delta}^{\varepsilon}$ satisfies

uniformly for $0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$. The eigenspace of the eigenvalue 1 is spanned by $\partial_{t} u_{\delta}^{\varepsilon}$.

To prove Theorem [7.1, we first show the following lemma.
Lemma 7.2 There exist positive constants $\Lambda_{2}$ and $r_{0}$ such that for all $0<$ $r \leq r_{0}$ there exists a positive constant $\delta_{2}=\delta_{2}(r)$ such that for $0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$, it holds that

To prove Lemma [7.2, we observe that $\mathscr{U}_{\delta}^{\varepsilon}(t, \tau)$ is written as

We thus introduce an operator $\mathscr{S}_{\omega, \delta}^{\varepsilon}$ on $\mathfrak{B}\left(X^{1}, \mathcal{Y}\left(0, T_{a}\right)\right)$ defined by

Lemma 7.3 (i) Let $|\omega| \leq \frac{1}{4}$. Then the operator $\mathscr{S}_{\omega, \delta}^{\varepsilon}$ is a bounded operator on $\mathfrak{B}\left(X^{1}, \mathcal{Y}\left(0, T_{a}\right)\right)$ and satisfies

(ii) There exists a positive constant $\delta_{2}$ such that if $|\delta| \leq \delta_{2}$, then $I-\delta \mathscr{S}_{\omega, \delta}^{\varepsilon}$ has the bounded inverse $\left(I-\delta \mathscr{S}_{\omega, \delta}^{\varepsilon}\right)^{-1} \in \mathfrak{B}\left(\mathfrak{B}\left(X^{1}, \mathcal{Y}\left(0, T_{a}\right)\right)\right)$ with estimate

\leq & \frac{1}{2}\left|\left\|\mathscr{S}_{\omega, \delta}^{\varepsilon} \mathscr{W} v\right\|\left\|_{\varepsilon, \mathcal{Y}\left(0, T_{a}\right)}+C\right\| \mathscr{W}\left\|_{\mathfrak{B}\left(X^{1}, \mathcal{Y}\left(0, T_{a}\right)\right)}\right\| v\right|\left\|\|_{\varepsilon, X^{1}}\right.
\end{aligned}

and hence,

uniformly for $0<\varepsilon \leq \varepsilon_{2},|\omega| \leq \frac{1}{4}$ and $|\delta| \leq \delta_{2}$. This implies that

and hence,

uniformly for $0<\varepsilon \leq \varepsilon_{2},|\omega| \leq \frac{1}{4}$ and $|\delta| \leq \delta_{2}$. It then follows that if $|\delta| \leq \frac{1}{2 C}$, then there exists $\left(I-\delta \mathscr{S}_{\omega, \delta}^{\varepsilon}\right)^{-1} \in \mathfrak{B}\left(\mathfrak{B}\left(X^{1}, \mathcal{Y}\left(0, T_{a}\right)\right)\right)$ with estimate $\left\|\left(I-\delta \mathscr{S}_{\omega, \delta}^{\varepsilon}\right)^{-1}\right\|_{\mathfrak{B}\left(\mathfrak{B}\left(X^{1}, \mathcal{Y}\left(0, T_{a}\right)\right)\right)} \leq 2$. This completes the proof.

We next give a proof of Lemma 7.2.
Proof of Lemma 7.2, Let $u(t)$ be a solution of (7.1)-(7.2) with $F=0$. Since $u(t)=\mathscr{U}_{\delta}^{\varepsilon}(t, \tau) v$ and $\partial_{t} u+\frac{a}{a^{\varepsilon}} L_{\omega_{\delta}^{\varepsilon}}^{\varepsilon} u=-\frac{a \delta}{a^{\varepsilon}\left(1+\omega_{\delta}^{\varepsilon}\right)} M_{\delta}^{\varepsilon}(t) u$, the solution operator $\mathscr{U}_{\delta}^{\varepsilon}(t, \tau)$ for (7.1) satisfies

We set $\mathscr{W}_{\delta}^{\varepsilon}(t, s)=\mathscr{U}_{\delta}^{\varepsilon}(t, s)-\mathscr{V}_{\omega_{\delta}^{\varepsilon}}^{\varepsilon}(t-s)$. It then follows that

=- & \frac{a \delta}{a^{\varepsilon}\left(1+\omega_{\delta}^{\varepsilon}\right)} \int_{\tau}^{t} \mathscr{V}_{\omega_{\delta}^{\varepsilon}}^{\varepsilon}(t-s) M_{\delta}^{\varepsilon}(s) \mathscr{V}_{\omega_{\delta}^{\delta}}^{\varepsilon}(s-\tau) v d s  \tag{7.7}\\
& -\frac{a \delta}{a^{\varepsilon}\left(1+\omega_{\delta}^{\varepsilon}\right)} \int_{\tau}^{t} \mathscr{V}_{\omega_{\delta}^{\varepsilon}}^{\varepsilon}(t-s) M_{\delta}^{\varepsilon}(s) \mathscr{W}_{\delta}^{\varepsilon}(s, \tau) v d s .
\end{align*}

We claim that

\left\|\mathscr { W } _ { \delta } ^ { \varepsilon } ( \cdot , 0 ) v \left|\left\|_{\varepsilon, \mathcal{Y}\left(0, T_{a}\right)} \leq 2|\delta|\right\|\left\|\mathscr{S}_{\omega_{\delta}^{\delta}, \delta}^{\varepsilon} \mathscr{V}_{\omega_{\delta}^{\varepsilon}}^{\varepsilon}(\cdot) v\left|\left\|_{\varepsilon, \mathcal{Y}\left(0, T_{a}\right)} \leq 2 C|\delta|\right\|\right| v \mid\right\|_{\varepsilon, X^{1}} .\right.\right.
$$

In particular, we have $\left\|\left|\mathscr{W}_{\delta}^{\varepsilon}\left(T_{a}, 0\right) v\left\|_{\varepsilon, X^{1}} \leq 2 C|\delta|\right\|\right| v \mid\right\|_{\varepsilon, X^{1}}$, which yields $\left\|\mathscr{W}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)\right\|_{\mathfrak{B}\left(X^{1}\right)} \leq 2 C|\delta|$ uniformly for $0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$. This proves (7.8).

We next consider the resolvent of $\mathscr{U}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)$. For a fixed positive constant $r$ we set

\end{aligned}
$$

for $\mu \in \Sigma_{r}$. Furthermore, it holds

for $\mu \in \Sigma_{r}$ uniformly in $0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$. This completes the proof.
We next investigate a part of $\sigma\left(\mathscr{U}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)\right)$ in $\{\mu \in \mathbb{C} ;|\mu-1|<r\}$. To specify it, we consider the spectrum of the linearized operator $B_{\delta}^{\varepsilon}$ around the bifurcating time periodic solution $u_{\delta}^{\varepsilon}$ of (4.3) which is given by

uniformly for $0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$.
To give a proof of Theorem [7.4, we introduce notation. We change the bases of $N\left(B_{0}^{\varepsilon}\right)$ from $\left\{z_{+}^{\varepsilon}, z_{-}^{\varepsilon}\right\}$ to $\left\{z_{0}^{\varepsilon}, z_{1}^{\varepsilon}\right\}$, where

uniformly for $0<\varepsilon \leq \varepsilon_{2},|\omega| \leq \frac{1}{4}$ and $\lambda$ with $\operatorname{Re} \lambda \geq-\frac{3}{4} \kappa_{1} T_{a}$ and $|\operatorname{Im} \lambda| \leq \frac{a}{2}$. We denote the solution operator for problem (7.10) by $\mathcal{S}^{\varepsilon}(\lambda, \omega)$, namely, the operator $\mathcal{S}^{\varepsilon}(\lambda, \omega): \tilde{\mathcal{Q}}^{\varepsilon} \mathcal{X}_{a} \rightarrow \tilde{\mathcal{Q}}^{\varepsilon} \mathcal{Y}_{a}$ is defined by

\left(\lambda+\tilde{\mathcal{Q}}^{\varepsilon} B_{\delta}^{\varepsilon}\right) U+\delta \tilde{\mathcal{Q}}^{\varepsilon} \sum_{j=0,1} \zeta_{j} M_{\delta}^{\varepsilon} z_{j}^{\varepsilon} & =\tilde{\mathcal{Q}}^{\varepsilon} F, \tag{7.14}
\end{align*}
$$

where $u=\zeta_{0} z_{0}^{\varepsilon}+\zeta_{1} z_{1}^{\varepsilon}+U$ with $\boldsymbol{\zeta}=^{\top}\left(\zeta_{0}, \zeta_{1}\right) \in \mathbb{C}^{2}$ and $U \in \tilde{Q}^{\varepsilon} \mathcal{Y}_{a}$. .
We shall reduce (7.12) -(7.14) to a two-dimensional problem by solving (7.14) for $U$ in terms of $\zeta_{j}(j=0,1)$ and $F$ and then substituting $U$ into (7.12) and (7.13). To this end, we next consider the problem

Proof. & \left.+\| \|_{\varepsilon, y_{a}}+\|\mid\| \hat{u}_{\delta}^{\varepsilon}\left\|_{\varepsilon, y_{a}}\right\| u \|_{\varepsilon, y_{a}}\right\}
\end{aligned}
$$

uniformly for $u \in \tilde{\mathcal{Q}}^{\varepsilon} \mathcal{Y}_{a}, 0<\varepsilon \leq \varepsilon_{2},|\delta| \leq \delta_{2}$ and $\operatorname{Re} \lambda \geq-\frac{3}{4} \kappa_{1} T_{a}$. This implies that there exists a positive constant $\delta_{2}$ such that if $|\delta| \leq \delta_{2}$, then $I+\delta \mathcal{S}^{\varepsilon}\left(\lambda, \omega_{\delta}^{\varepsilon}\right) \tilde{\mathcal{Q}}^{\varepsilon} M_{\delta}^{\varepsilon} \tilde{\mathcal{Q}}^{\varepsilon}$ has a bounded inverse $\left(I+\delta \mathcal{S}^{\varepsilon}\left(\lambda, \omega_{\delta}^{\varepsilon}\right) \tilde{\mathcal{Q}}^{\varepsilon} M_{\delta}^{\varepsilon} \tilde{\mathcal{Q}}^{\varepsilon}\right)^{-1}$ on $\tilde{\mathcal{Q}}^{\varepsilon} \mathcal{Y}_{a}$ with estimate

uniformly for $0<\varepsilon \leq \varepsilon_{2},|\delta| \leq \delta_{2}$ and $\operatorname{Re} \lambda \geq-\frac{3}{4} \kappa_{1} T_{a}$. It then follows that (7.15) has a unique solution $U=\left(I+\delta \mathcal{S}^{\varepsilon}\left(\lambda, \omega_{\delta}^{\varepsilon}\right) \tilde{\mathcal{Q}}^{\varepsilon} M_{\delta}^{\varepsilon} \tilde{\mathcal{Q}}^{\varepsilon}\right)^{-1} \mathcal{S}^{\varepsilon}\left(\lambda, \omega_{\delta}^{\varepsilon}\right) F \in$ $\tilde{\mathcal{Q}}^{\varepsilon} \mathcal{Y}_{a}$ and $U$ satisfies the estimate

uniformly for $0<\varepsilon \leq \varepsilon_{2},|\delta| \leq \delta_{2}, \operatorname{Re} \lambda \geq-\frac{3}{4} \kappa_{1} T_{a}$ and $|\operatorname{Im} \lambda| \leq \frac{a}{2}$. This completes the proof.

Let $0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$. For $\lambda$ satisfying $\operatorname{Re} \lambda \geq-\frac{3}{4} \kappa_{1} T_{a}$, we denote the solution operator for (7.15) by $\tilde{\mathcal{S}}_{\delta}^{\varepsilon}(\lambda)$.

In terms of $\tilde{\mathcal{S}}_{\delta}^{\varepsilon}(\lambda)$, (7.14) is written as

Therefore, we investigate zeros of $D_{\delta}^{\varepsilon}(\tilde{\lambda})$ in $\left\{\tilde{\lambda} \in \mathbb{C} ;|\tilde{\lambda}| \leq \tilde{c}_{0}\right\}$, where $\tilde{c}_{0}=\frac{c_{0}}{\delta_{2}}$. We shall prove the following proposition.

Proposition 7.8 There exists a positive constant $\delta_{2}$ such that if $0<\varepsilon \leq \varepsilon_{2}$ and $|\delta| \leq \delta_{2}$ then $\tilde{D}_{\delta}^{\varepsilon}(\tilde{\lambda})$ has two zeros $\tilde{\lambda}=0$ and $\tilde{\lambda}_{\delta}^{\varepsilon}$ in $\{\tilde{\lambda} \in \mathbb{C} ;|\tilde{\lambda}| \leq$ $\left.\tilde{c}_{0}\right\}$ and both zeros are of order 1 . Here $\tilde{\lambda}_{\delta}^{\varepsilon}$ satisfies $\tilde{\lambda}_{\delta}^{\varepsilon}=\tilde{\lambda}_{0}^{\varepsilon}+O(\delta), \tilde{\lambda}_{0}^{\varepsilon}=$ $2 \tilde{\eta}_{0}^{\varepsilon} \operatorname{Re}\left[K z_{0}^{\varepsilon}\right]_{+, \varepsilon}$.

It follows from Proposition 7.8 that

\tilde{\eta}_{\delta}^{\varepsilon} \llbracket K z_{0}^{\varepsilon} \rrbracket_{0, \varepsilon}+\delta \tilde{\eta}_{\delta}^{\varepsilon} \llbracket K U_{\delta}^{\varepsilon} \rrbracket_{0, \varepsilon}+\llbracket M\left(U_{\delta}^{\varepsilon}, z_{0}^{\varepsilon}\right) \rrbracket_{0, \varepsilon}+\frac{\delta}{2} \llbracket M\left(U_{\delta}^{\varepsilon}, U_{\delta}^{\varepsilon}\right) \rrbracket_{0, \varepsilon}=0
$$

and

$$
U_{\delta}^{\varepsilon}=-\mathcal{S}^{\varepsilon}\left(0, \omega_{\delta}^{\varepsilon}\right) \tilde{\mathcal{Q}}^{\varepsilon}\left\{\delta \tilde{\eta}_{\delta}^{\varepsilon} K\left(z_{0}^{\varepsilon}+\delta U_{\delta}^{\varepsilon}\right)+N\left(z_{0}^{\varepsilon}+\delta U_{\delta}^{\varepsilon}\right)\right\}
$$

Letting $\delta \rightarrow 0$, we obtain

$$
\begin{equation*}
\tilde{\eta}_{0}^{\varepsilon} \llbracket K z_{0}^{\varepsilon} \rrbracket_{0, \varepsilon}+\llbracket M\left(U_{0}^{\varepsilon}, z_{0}^{\varepsilon}\right) \rrbracket_{0, \varepsilon}=0 \tag{7.22}
\end{equation*}
$$

and

$$
\begin{equation*}
U_{0}^{\varepsilon}=-\frac{1}{2} \tilde{\mathcal{S}}_{0}^{\varepsilon}(0) \tilde{\mathcal{Q}}^{\varepsilon} M\left(z_{0}^{\varepsilon}, z_{0}^{\varepsilon}\right) \tag{7.23}
\end{equation*}
$$

We deduce from (7.22) and (7.23) that

$$
\gamma_{11,0}^{\varepsilon}(0)=-\llbracket M\left(z_{0}^{\varepsilon}, \tilde{\mathcal{S}}_{0}^{\varepsilon}(0) M\left(z_{0}^{\varepsilon}, z_{0}^{\varepsilon}\right)\right) \rrbracket_{0, \varepsilon}=-2 \tilde{\eta}_{0}^{\varepsilon} \llbracket K z_{0}^{\varepsilon} \rrbracket_{0, \varepsilon}=-\tilde{\lambda}_{0}^{\varepsilon}
$$

and hence,

$$
\Gamma_{0}^{\varepsilon}(0)=\left(\begin{array}{cc}
-\tilde{\lambda}_{0}^{\varepsilon} & 0 \\
\gamma_{0}^{\varepsilon}(0) & 0
\end{array}\right)
$$

This implies (7.20).
We take $\delta_{2}$ so small that $\tilde{c}_{0}=\frac{c_{0}}{\delta_{2}} \leq 2\left|\tilde{\lambda}_{0}^{\varepsilon}\right|$. By Proposition 7.6, we obtain

$$
\left|D_{\delta}^{\varepsilon}(\tilde{\lambda})-D_{0}^{\varepsilon}(\tilde{\lambda})\right| \leq c_{1}|\delta|
$$

for $0<\varepsilon \leq \varepsilon_{2},|\delta| \leq \delta_{2}$ and $|\tilde{\lambda}| \leq \tilde{c}_{0}$. Therefore, there exists a positive constant $\delta_{2}$ such that if $|\delta| \leq \delta_{2}$, then $\left|D_{0}^{\varepsilon}(\tilde{\lambda})\right|>\left|D_{\delta}^{\varepsilon}(\tilde{\lambda})-D_{0}^{\varepsilon}(\tilde{\lambda})\right|$ on $|\tilde{\lambda}|=\tilde{c}_{0}$. Applying the Rouché theorem, we find that $D_{\delta}^{\varepsilon}(\tilde{\lambda})$ has two zeros in $\{\tilde{\lambda} \in$ $\left.\mathbb{C} ;|\tilde{\lambda}| \leq \tilde{c}_{0}\right\}$; one of them is $\tilde{\lambda}=0$. Furthermore, we see that, by taking $\delta_{2}$ smaller if necessary, that there exists a positive constant $c_{3}$ such that if $|\delta| \leq$ $\delta_{2}$, then $\left|D_{0}^{\varepsilon}(\tilde{\lambda})\right|>\left|D_{\delta}^{\varepsilon}(\tilde{\lambda})-D_{0}^{\varepsilon}(\tilde{\lambda})\right|$ on $\left|\tilde{\lambda}-\tilde{\lambda}_{0}^{\varepsilon}\right|=c_{3}|\delta|$. The Rouché theorem then implies that $D_{\delta}^{\varepsilon}(\tilde{\lambda})$ has a zero $\tilde{\lambda}_{\delta}^{\varepsilon}$ of order 1 in $\left\{\tilde{\lambda} \in \mathbb{C} ;\left|\tilde{\lambda}-\tilde{\lambda}_{0}^{\varepsilon}\right|<c_{3}|\delta|\right\}$. This completes the proof.
Proof of Theorem 7.1 Let $\mu_{0}$ and $\mu_{1}$ be eigenvalues of $\mathscr{U}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)$ with $\left|\mu_{j}-1\right|<r(j=0,1)$. We know that one of $\mu_{j}$ 's, say $\mu_{0}$, is equal to 1 . On the other hand, as in the proof of Theorem [5.4, i.e., the proof of [11, Theorem 4.2], we see from (7.3) (7.5) that if $\mathrm{e}^{\frac{a}{a^{\varepsilon}} T_{a} \lambda} \in \rho\left(\mathscr{U}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)\right)$, then $\lambda \in \rho\left(-B_{\delta}^{\varepsilon}\right)$. Therefore, since $\sigma\left(\mathscr{U}_{\delta}^{\varepsilon}\left(T_{a}, 0\right)\right) \cap\{\mu ;|\mu-1|<r\}=\left\{\mu_{0}, \mu_{1}\right\}$, by Theorem 7.4, we conclude that $\mu_{0}=1, \mu_{1}=\mathrm{e}^{\frac{a}{a^{\varepsilon}} T_{a} \lambda_{\delta}^{\varepsilon}}$. This completes the proof.
