# SOME SINGULAR LEX-SEGMENTS 

ANDREW P. STAAL


#### Abstract

We study the component structures of some standard-graded Hilbert schemes closely related to a Hilbert scheme of curves studied by Gotzmann. In particular, we encounter examples of singular lex-segment points lying on two and three irreducible components. We find further singular lex-segment points at nearby Hilbert schemes. We conclude by showing that the analogous example at the Hilbert scheme of twisted cubics also has a singular lex-segment point.


## 1. Introduction

In [Sta20], we provide a classification of Hilbert schemes $\operatorname{Hilb}^{\mathrm{p}}\left(\mathbb{P}^{n}\right)$, parametrizing closed subschemes of projective space $\mathbb{P}^{n}$ with a specified Hilbert polynomial p , that have unique Borel-fixed points. These Hilbert schemes are smooth and our classification reveals the existence of natural probability distributions where smooth Hilbert schemes occur with probability greater than 0.5 . Based on our underlying "geography" of Hilbert schemes, further smooth examples are promptly found, leaving open the challenge of understanding whether all smooth Hilbert schemes fall into known classes. This is achieved by Skjelnes-Smith in [SS20], where our classification comprises two of the main classes of smooth Hilbert schemes.

Multigraded Hilbert schemes $\operatorname{Hilb}^{\mathrm{h}}(S)$, parametrizing homogeneous ideals in a multigraded polynomial ring $S$ with a specified Hilbert function h, generalize Hilbert schemes by using a broader notion of degree. Introduced in [HS04], these quasi-projective schemes include Hilbert schemes of points in affine space and toric Hilbert schemes, among other examples. Their geometry is not well-understood. All pathologies that occur for Hilbert schemes also occur for multigraded Hilbert schemes, but further complications arise: toric Hilbert schemes can be disconnected [San05] and lexicographic points do not exist for general multigradings.

A natural question is: To what extent does the classification of smooth Hilbert schemes extend to multigraded Hilbert schemes? For example, multigraded Hilbert schemes parametrizing admissible ideals in two variables are nonsingular [MS10]. A key fact used in these classifications is that lex-segment, or lex-most, ideals are smooth [RS97]. Thus, an important first step towards the general case is to understand the geometry of multigraded Hilbert schemes at lex-segment ideals, when they exist. In this paper, we study the component structures of some explicit standard-graded Hilbert schemes closely related to Hilbert schemes.

Let $S:=\mathbb{K}\left[x_{0}, x_{1}, \ldots, x_{n}\right]$, where $\mathbb{K}$ is a field of characteristic 0 . We prove the following.
Theorem 1.1. Let $M^{\mathrm{h}}=\bigcup_{i=0}^{s} M_{i}^{k_{i}}$ be the irreducible decomposition of the standard-graded Hilbert scheme $M^{\mathrm{h}}:=\operatorname{Hilb}^{\mathrm{h}}(S)$, where $M_{i}^{k_{i}}$ has dimension $k_{i}$. Let $I_{0}$ be the lex-segment ideal with Hilbert function h . In the following cases, let $\mathrm{h}_{i}$ be the Hilbert function of the saturated Borel-fixed ideal having Hilbert polynomial $\mathrm{p}(d)$ and regularity $\operatorname{reg}\left(I_{0}\right)-i$. We have

- for $n=3$ and Hilbert polynomial $\mathrm{p}(d)=4 d$ :
$-M^{\mathrm{h}_{1}}=M_{0}^{24} \cup M_{1}^{22}$ with $I_{0} \in M_{0}^{24} \cap M_{1}^{22}$,
$-M^{\mathrm{h}_{2}}=M_{0}^{28} \cup M_{1}^{25} \cup M_{2}^{23} \cup M_{3}^{16}$ with $I_{0} \in M_{0}^{28} \cap M_{1}^{25} \cap M_{2}^{23}$;
- for $n=3$ and Hilbert polynomial $\mathrm{p}(d)=4 d-1$ :
$-M^{\mathrm{h}_{1}}=M_{0}^{22} \cup M_{1}^{20}$ with $I_{0} \in M_{0}^{22} \cap M_{1}^{20}$;
- for $n=2$ and Hilbert polynomial $\mathbf{p}(d)=4$ :
- $M^{\mathrm{h}_{1}}=M_{0}^{8} \cup M_{1}^{8}$ with $I_{0} \in M_{0}^{8} \cap M_{1}^{8}$;
- for $n=3$ and Hilbert polynomial $\mathbf{p}(d)=3 d+1$ :
$-M^{\mathrm{h}_{1}}=M_{0}^{17} \cup M_{1}^{15} \cup M_{2}^{12}$ with $I_{0} \in M_{0}^{17} \cap M_{1}^{15}$.
In stark constrast to $\operatorname{Hilb}^{\mathrm{P}}\left(\mathbb{P}^{n}\right)$, these lex-segment points all lie in nonempty intersections of irreducible components. The examples we study are roughly organized, first, by admissible Hilbert polynomial according to the Macaulay tree [Sta20, §2] and, second, according to Hilbert functions that appear naturally when studying (classical) Hilbert schemes; cf. [Got08]. Irreducible components then emerge by considering ideals of fixed regularity.

A first example of a singular lex-segment ideal is given in [RS20]. Our examples broaden the class of known singular lex-segments and raise many interesting questions: Are all lexsegment points of this kind singular? Do they always lie in the largest numbers of irreducible components? Are these numbers of irreducible components containing lex-segment points unbounded when we vary the Hilbert schemes in natural ways? Does Murphy's Law hold at lex-segment points? Does the classification of smooth Hilbert schemes extend "up to" these examples with singular lex-segments?

In subsequent sections, we provide a more detailed analysis of the component structures of the standard-graded Hilbert schemes listed above, as well as pointing out some nonsingular standard-graded Hilbert schemes along the way.

Conventions. Throughout, $\mathbb{K}$ is a field of characteristic $0, \mathbb{N}$ denotes the nonnegative integers, and (after §2.1) $S:=\mathbb{K}\left[x_{0}, x_{1}, \ldots, x_{n}\right]$ is a standard $\mathbb{Z}$-graded polynomial ring over $\mathbb{K}$, endowed with the reverse lexicographic monomial ordering unless otherwise stated.

## 2. Background and Useful Tools

In this section, we highlight some basic facts and useful tools for studying Hilbert schemes.
2.1. Basic Facts. Let $R$ be a unital commutative ring and $S:=R\left[x_{0}, x_{1}, \ldots, x_{n}\right]$ be the polynomial ring over $R$. A multigrading on $S$ is a monoid homomorphism deg: $\mathbb{N}^{n+1} \rightarrow A$, where $A$ is an abelian group; the submonoid $A_{+}:=\operatorname{deg}\left(\mathbb{N}^{n+1}\right)$ is assumed to generate $A$ as a group. A multigrading determines a decomposition $S=\bigoplus_{d \in A} S_{d}$ into multigraded components $S_{d}:=\bigoplus_{\operatorname{deg}(u)=d} R x^{u}$, where $x^{u}:=x_{0}^{u_{0}} x_{1}^{u_{1}} \cdots x_{n}^{u_{n}}$. We use the standard grading deg: $\mathbb{N}^{n+1} \rightarrow \mathbb{Z},\left(u_{0}, u_{1}, \ldots, u_{n}\right) \mapsto u_{0}+u_{1}+\cdots+u_{n}$, but refer to some facts that apply more generally. A multigrading is positive if $S_{0}=R$ - the standard grading is positive. An ideal $I \subseteq S$ is admissible if it is homogeneous with respect to the multigrading and $S_{d} / I_{d}$ is a locally free $R$-module of finite rank, for all $d \in A$. When $S$ is positively multigraded, this is equivalent to $S / I$ being flat over $R$ [MS05, $\S 18.5]$. For an admissible ideal $I$, the Hilbert function $\mathrm{h}_{S / I}: A \rightarrow \mathbb{Z}$ of $S / I$ is defined by $\mathrm{h}_{S / I}(d):=\operatorname{rk}_{\mathbb{K}}\left(S_{d} / I_{d}\right)$, for all $d \in A$. It is common to refer to $\mathrm{h}_{S / I}$ as the Hilbert function of $I$ and use the notation $\mathrm{h}_{I}$, however, working with the standard grading, we refer to $\mathrm{h}_{I}(d):=\mathrm{h}_{S}(d)-\mathrm{h}_{S / I}(d)$ as the Hilbert function of $I$. Every
such standard-graded $I$ has a Hilbert polynomial $\mathrm{p}_{S / I}$, that is, a polynomial $\mathrm{p}_{S / I}$ with $\mathbb{Q}$-coefficients such that $\mathrm{h}_{S / I}(d)=\mathrm{p}_{S / I}(d)$ for $d \gg 0$; see [BH93, Theorem 4.1.3].

Admissible ideals are parametrized by multigraded Hilbert schemes, whose existence and fundamental properties are expounded by Haiman-Sturmfels in [HS04]. We collect some key facts about multigraded Hilbert schemes in the following theorem.

Theorem 2.1. Let $S$ be multigraded and $\mathrm{h}: A \rightarrow \mathbb{N}$ be a function supported on $A_{+}$.
(i) The admissible ideals in $S$ with Hilbert function $\mathrm{h}_{S / I}=\mathrm{h}$ are parametrized by a quasiprojective scheme $\operatorname{Hilb}^{\mathrm{h}}(S)$ called the multigraded Hilbert scheme.
(ii) If the multigrading on $S$ is positive, then $\operatorname{Hilb}^{\mathrm{h}}(S)$ is projective.
(iii) If $R=\mathbb{K}$ is a field, then the Zariski tangent space to $\operatorname{Hilb}^{h}(S)$ at a $\mathbb{K}$-point $I \subseteq S$ equals $\operatorname{Hom}_{S}(I, S / I)_{0}$, the degree-0 part of the multigraded $S$-module $\operatorname{Hom}_{S}(I, S / I)$.

Proof. See Section 1 of [HS04].
Example 2.2. Many common parameter spaces are multigraded Hilbert schemes.
(i) The Hilbert scheme $\operatorname{Hilb}^{\mathrm{p}}\left(\mathbb{P}^{n}\right)$ is isomorphic to the multigraded Hilbert scheme $\operatorname{Hilb}^{\mathrm{h}}(S)$, where $\mathrm{h}(d)=\mathrm{p}(d)$, for $d \geq d_{0}$, and $\mathrm{h}(d)=\binom{n+d}{n}$, for $d<d_{0}$ (meaning 0 when $d<0$ ); here $d_{0}$ is the Gotzmann number of p [HS04, Lemma 4.1].
(ii) If $A=0$ is trivial, then $\operatorname{Hilb}^{\mathrm{h}}(S)$ is the Hilbert scheme of $\mathrm{h}(0)$ points in $\mathbb{A}^{n+1}$.
(iii) Let the multigrading be positive with $A \cong \mathbb{Z}^{r}$ and set $\mathrm{h}(d)=1$, for $d \in A_{+}$, and $\mathrm{h}(d)=0$ otherwise. Then $\operatorname{Hilb}^{\mathrm{h}}(S)$ is the toric Hilbert scheme of Peeva-Stillman [PS02].

When $S$ is standard-graded and $I$ is admissible, we refer to $\operatorname{Hilb}^{\mathrm{h}_{I}}(S)$ to mean $\operatorname{Hilb}^{\mathrm{h}_{S / I}}(S)$. We also use the notation $M^{\mathrm{h}}:=\operatorname{Hilb}^{\mathrm{h}}(S)$, when $S$ is clear from context.

The saturation of an ideal $I \subseteq S$ is the ideal

$$
I^{s a t}:=\left(I: \mathfrak{m}^{\infty}\right)=\bigcup_{k \geq 1}\left\{f \in S \mid f \mathfrak{m}^{k} \subseteq I\right\},
$$

where $\mathfrak{m}:=\left\langle x_{0}, x_{1}, \ldots, x_{n}\right\rangle$ is the irrelevant ideal of $S$. The inclusion $I \subseteq I^{\text {sat }}$ always holds; if $S$ is standard-graded and $I$ is homogeneous, then $I^{\text {sat }}$ is homogeneous, $I_{d} \subseteq I_{d}^{\text {sat }}$ for all $d \in \mathbb{Z}$, and $I_{d}=I_{d}^{\text {sat }}$ for $d \gg 0$.
2.2. Initial Ideals. Let $S:=\mathbb{K}\left[x_{0}, x_{1}, \ldots, x_{n}\right]$ be standard-graded and let $>$ be a monomial ordering with $x_{0}>x_{1}>\cdots>x_{n}$; we assume a familiarity with monomial orderings and initial ideals, as provided in [CLO15]. The following result is often used in the study of the component structure of the Hilbert scheme.

Theorem 2.3. Given an ideal $I \subseteq S$ and a monomial ordering $>$ on $S$, there exists a family $J=\left\{J_{a}\right\} \subseteq S[a]$ of ideals such that
(i) $J_{1}=I$ and $J_{a} \cong I$ by a scaling of variables, for $a \neq 0$, and
(ii) $\lim _{a \rightarrow 0} J_{a}=\operatorname{in} I$.

Proof. See [Bay82, §2.12], [Ree92, Theorem 3], or [Eis95, §15.8].
Here in $I=\mathrm{in}_{>}(I) \subseteq S$ is the initial ideal of $I$ with respect to $>$. To study standard-graded Hilbert schemes, we assume $I$ is homogeneous and work directly with the family $J$ rather than with the flat family $\operatorname{Proj} S[a] / J \rightarrow \operatorname{Spec} \mathbb{K}[a] \cong \mathbb{A}_{\mathbb{K}}^{1}$. The theorem says that given any homogeneous ideal $I$, there is a morphism Spec $\mathbb{K}[a] \rightarrow \operatorname{Hilb}^{\mathrm{h}_{I}}(S)$ with fibre $I$ at $a=1$ and fibre $\operatorname{in}_{>}(I)$ at $a=0$. Consider the graded $S[a]$-module $\operatorname{Hom}_{S[a]}(J, S[a] / J)$, where $J \subseteq S[a]$
is homogeneous (and $\operatorname{deg} a=0$ ). Then $\operatorname{Hom}_{S[a]}(J, S[a] / J)_{0}$ is a $\mathbb{K}[a]$-module and another useful result is the following.

Lemma 2.4. The dimension of $\operatorname{Hom}_{S}\left(J_{a}, S / J_{a}\right)_{0}$ is upper semi-continuous on $\operatorname{Spec} \mathbb{K}[a]$.
Proof. By Theorem 2.1(iii), the $\mathbb{K}$-vector space $\operatorname{Hom}_{S}\left(J_{a}, S / J_{a}\right)_{0}$ is the Zariski tangent space $T_{J_{a}} M$ to the standard-graded Hilbert scheme $M:=\operatorname{Hilb}^{\mathrm{h}_{J_{0}}}(S)$ at the point $J_{a}$ and, more generally, the dimension of $T_{I} M$ is upper semi-continuous for $I$ in $M$ [GW10, §6.6].

In practice, these two results tell us that the initial ideal lies on the same component of the standard-graded Hilbert scheme as the ideal itself and that the dimension of the tangent space cannot decrease when specializing to the initial ideal.

The action of an element $\gamma \in \mathrm{GL}_{n+1}(\mathbb{K})$ on $S$ is defined by $\gamma \cdot x_{j}:=\sum_{i=0}^{n} \gamma_{i j} x_{i}$. The Borel-subgroup of $\mathrm{GL}_{n+1}(\mathbb{K})$ consists of the upper-triangular matrices. The generic initial ideal $\operatorname{gin} I=\operatorname{gin}_{>}(I) \subseteq S$ of a homogeneous ideal $I \subseteq S$ is the initial ideal of a generic change-of-coordinates of $I$. Specifically, we have the following.

Theorem 2.5 (Galligo). If $I \subseteq S$ is a homogeneous ideal, then there exists a Zariski open subset $U \subseteq \mathrm{GL}_{n+1}(\mathbb{K})$ such that in $\gamma I=$ in $\gamma^{\prime} I$, for all $\gamma, \gamma^{\prime} \in U$. Moreover, this common initial ideal, called gin I, is Borel-fixed.

A monomial ideal $I \subseteq S$ is strongly stable if, for all monomials $m \in I$, for all $x_{j}$ dividing $m$, and for all $i<j$, we have $x_{j}^{-1} m x_{i} \in I$. In characteristic 0 , this condition is equivalent to being Borel-fixed. (In positive characteristic, the condition is more involved.) The Borel partial ordering on the monomials of $S$ is the transitive closure of the following: for each monomial $m$, for all $x_{j}$ dividing $m$, and all $i<j$, the monomial $x_{j}^{-1} m x_{i}$ is larger than $m$.
Proof. The original is [Gal74], but we are interested in the generalization by Bayer-Stillman [BS87b, Proposition 1], [Eis95, §15.9].

Combining Galligo's theorem with the degeneration to the initial ideal shows that every irreducible component and intersection of irreducible components of a standard-graded Hilbert scheme $\operatorname{Hilb}^{\mathrm{h}}(S)$ contains a Borel-fixed point.

Example 2.6 (Lex-segment ideals). The most important Borel-fixed ideals are the lexsegment ideals. These are defined with respect to the lexicographic ordering, in which $x^{u}>x^{v}$ if $u_{i}>v_{i}$, where $i$ is minimal such that $u_{i} \neq v_{i}$. Given a homogeneous ideal $I \subseteq S$ with Hilbert function $\mathrm{h}=\mathrm{h}_{I}$, the lex-segment ideal with Hilbert function h is the ideal $L$ whose degree- $d$ component $L_{d}$ is spanned by the $\mathrm{h}(d)$ greatest monomials in lexicographic order; that $L$ is an ideal is a theorem of Macaulay [Mac27], [MS05, §2.4]. The corresponding nonsingular point $\operatorname{Proj} S / L \in \operatorname{Hilb}^{\mathrm{P}}\left(\mathbb{P}^{n}\right)$ is called the lexicographic point [RS97].

Another useful monomial ordering is the reverse lexicographic ordering, in which $x^{u}>x^{v}$ if $u_{j}<v_{j}$, where $j$ is maximal such that $u_{j} \neq v_{j}$. Despite the importance of lexicographic order, the reverse lexicographic ordering is optimized to computing Gröbner bases [BS87b]. We use the reverse lexicographic ordering unless specified otherwise.
2.3. Deformation Theory. Although nearly superfluous for gaining a basic understanding of the component structures described in the following sections, deformation theory offers a powerful experimental tool for probing the (analytically) local geometry of Hilbert schemes. This is done via the power series ansatz, which is implemented [Ilt12] in Macaulay2 [GS]. The power series ansatz is the procedure that lifts an ideal, degree-by-degree, over a ring
of deformation parameters (of dimension equal to that of the Zariski tangent space at the ideal in the Hilbert scheme or a local analogue). At each stage, corrections might need to be made to eliminate the obstructions to lifting the ideal. The implementation is described in [Ilt12], an introduction to the process is given in [Ste95], and a classic example done by hand is provided in [PS85, §5] (a detailed exposition in [Sta] summarizes the basics and follows concrete examples). The ansatz may not terminate, but when it does it provides a local view of the multigraded Hilbert scheme. As in the case of twisted cubics, it can also provide a local view of the Hilbert scheme, when the Comparison Theorem holds [PS85, §3].

Example 2.7. We demonstrate how to quickly produce a description of the local geometry of the scheme $\operatorname{Hilb}^{\mathrm{h}_{1}}(S)$ at the lex-segment ideal $I_{0}^{\prime}:=\left\langle x^{2}, x y, x z, x t^{2}, y^{4}, y^{3} z\right\rangle$ in $S:=\mathbb{K}[x, y, z, t]$ with $h_{1}=h_{I_{0}^{\prime}}=(0,0,3,10,22,40,65, \ldots)$; the component structure of this scheme is described in Theorem 5.1. Note that $I_{0}^{\prime}$ has Hilbert polynomial $\mathrm{p}_{S / I_{0}^{\prime}}(d)=3 d+1$.

The next line computes the dimension of the tangent space $T_{I_{0}^{\prime}} \operatorname{Hilb}^{\mathrm{h}_{1}}(S)$.

As explained in $\S 5$, we expect $I_{0}^{\prime}$ to lie in two irreducible components, of dimensions 17 and 15. To see this computationally, we proceed as follows.

We see by inspection that the ideal is as expected from Theorem 5.1, with primary decomposition $\left\langle u_{10}+u_{16}, u_{11}-u_{17}, u_{9}-2 u_{14}\right\rangle \cap\left\langle u_{18}\right\rangle \subset \mathbb{Q}\left[u_{1}, u_{2}, \ldots, u_{18}\right]$. The Macaulay2 commands to see this are as follows, first removing the variables $x, y, z, t$ from the ambient obstruction ring.

Hence, we see irreducible components of dimensions 17 and 15 meeting at the lex-segment ideal $I_{0}^{\prime}$. Similar analyses work at other points and on our examples in the coming sections.

## 3. Standard-graded Hilbert Schemes and an Example of Gotzmann

In [Got08], Gotzmann studies the Hilbert scheme $H:=\operatorname{Hilb}{ }^{4 d}\left(\mathbb{P}^{3}\right)$ via its regularity stratification, showing that $H=H_{A V} \cup H_{R S}$ consists of two irreducible components. The component $H_{A V}$ is 16 -dimensional and has general point defined by an arithmetically Cohen-Macaulay curve in $\mathbb{P}^{3}$. It is generically nonsingular [Ell75]. The lexicographic component $H_{R S}$ is 23dimensional, has general member defined by a degenerate quartic curve union two points, and is also generically nonsingular [RS97]. The components intersect transversally and are rational; this is easily seen using the power series ansatz [Ste95, §1], implemented in Macaulay2 [Ilt12].

We exhibit some interesting properties of standard-graded Hilbert schemes closely related to $H$. In particular, these standard-graded Hilbert schemes provide new examples of singular lex-segment ideals, lying in multiple irreducible components.
3.1. Setup and a First Example. To begin, we list the possible Hilbert functions of saturated ideals defining points of $H$. In fact, it suffices to list the Hilbert functions of saturated Borel-fixed ideals with Hilbert polynomial $\mathrm{p}(d)=4 d$. Letting $S:=\mathbb{K}[x, y, z, t]$ denote the homogeneous coordinate ring of $\mathbb{P}^{3}$, these are as follows:

I_{1}=\left\langle x^{2}, x y, x z, y^{5}, y^{4} z\right\rangle, & \mathrm{h}_{1}=(0,0,3,9,19,36,60, \ldots), \\
I_{2}=\left\langle x^{2}, x y, x z^{2}, y^{4}\right\rangle, & \mathrm{h}_{2}=(0,0,2,8,19,36,60, \ldots), \\
I_{3}=\left\langle x^{2}, x y, y^{3}\right\rangle, & \mathrm{h}_{3}=(0,0,2,8,19,36,60, \ldots),
\end{array}
$$

where $\mathrm{h}_{i}:=\mathrm{h}_{I_{i}}$ and $I_{i}$ has regularity $6-i$. The list of ideals can be derived using Reeves' algorithm [Ree92, MN14]. Suppose $X \subset \mathbb{P}^{3}$ is a closed subscheme with Hilbert polynomial
$4 d$ and let $I_{X} \subset S$ denote the saturated ideal of $X$, i.e. $I_{X}:=\bigoplus_{d \geq 0} H^{0}\left(\mathbb{P}^{3}, \mathcal{J}_{X}(d)\right)$ where $\mathcal{J}_{X}$ is the ideal sheaf of $X$. By Galligo's theorem, gin $I_{X}$ is Borel-fixed. Further, under the reverse lexicographic ordering, gin $I_{X}$ has regularity equal to that of $I_{X}$ [BS87a, §2] and is saturated [Gre10, Theorem 2.30], so is in the given list. In particular, the Hilbert function of $I_{X}$ equals that of gin $I_{X}$ and is listed.

The first standard-graded Hilbert scheme related to $H$ that we examine parametrizes all homogeneous ideals $J \subset S$ with Hilbert function $\mathrm{h}_{0}=(0,1,4,10,20,36,60, \ldots)$, i.e. equal to that of the lexicographic ideal $I_{0}$. We denote this scheme by $M^{\mathrm{h}_{0}}$ and prove the following.

Proposition 3.1. The scheme $M^{\mathrm{h}_{0}}$ is nonsingular and irreducible of dimension 21.
Proof. Let $J \subset S$ be a point of $M^{\mathrm{h}_{0}}$. Inspecting the Hilbert function, one finds $J=\langle\ell, f, g\rangle$ has generators $\ell \in S_{1}, f=\ell^{\prime} h \in S_{5}$, and $g=q h \in S_{6}$, where $\ell^{\prime} \in S_{1} \backslash \mathbb{K} \ell, h \in S_{4} \backslash S_{3} \ell$, and $q \in S_{2} \backslash S_{1}\left\langle\ell, \ell^{\prime}\right\rangle$ [Got08, §2.4]. Counting parameters shows this is a 21-dimensional family, of which $I_{0}$ is a member. On the other hand, gin $J$ is Borel-fixed with Hilbert function $\mathrm{h}_{0}$, which necessitates gin $J=I_{0}$ (see Lemma 3.3 below). The lex-segment point $I_{0}$ is nonsingular, as one verifies as in Example 2.7 that $\operatorname{dim}_{\mathbb{K}} T_{I_{0}} M^{\mathrm{h}_{0}}=\operatorname{dim}_{\mathbb{K}} \operatorname{Hom}_{S}\left(I_{0}, S / I_{0}\right)_{0}=21$. By upper semi-continuity of $\operatorname{dim}_{\mathbb{K}} T_{I} M^{\mathrm{h}_{0}}$, the point $J$ is also nonsingular.

This simple proof generalizes to standard-graded Hilbert schemes with unique lex-segment ideals that are nonsingular. That is, the following holds, for any $S:=\mathbb{K}\left[x_{0}, x_{1}, \ldots, x_{n}\right]$.

Proposition 3.2. Let $M:=\operatorname{Hilb}^{\mathrm{h}}(S)$ be a standard-graded Hilbert scheme. If $M$ has a unique Borel-fixed point $I \subseteq S$ and $I$ is nonsingular, then $M$ is nonsingular and irreducible.

Proof. For every $J \in M$, we have gin $J=I$ and so upper semi-continuity of the dimension of the tangent space proves the claim.
3.2. A Lex-Segment Ideal on Two Components. Next we study the standard-graded Hilbert scheme $M^{\mathrm{h}_{1}}$ parametrizing ideals of $S:=\mathbb{K}[x, y, z, t]$ with Hilbert function $\mathrm{h}_{1}$. First, we compile a list of Borel-fixed ideals with Hilbert function $h_{1}$. To do so, we use the following straight-forward fact.

Lemma 3.3. Suppose that $I \subset S$ is a non-saturated Borel-fixed ideal and d is a positive integer. Then $I^{\text {sat }}$ is Borel-fixed and $I_{d}$ is obtained from $I_{d}^{\text {sat }}$ by successively removing monomials that are minimal in Borel partial order.

Proof. Let $f \in I^{\text {sat }}$, so that all $m \in \mathfrak{m}^{k}$ satisfy $f m \in I$, for some $k>0$. If $x_{j} \mid f$ and $i<j$, then $\left(x_{j}^{-1} f x_{i}\right) m=x_{j}^{-1}(f m) x_{i} \in I$ implies $x_{j}^{-1} f x_{i} \in I^{s a t}$, i.e. $I^{s a t}$ is Borel-fixed. The containment $I_{d} \subseteq I_{d}^{\text {sat }}$ holds for all $I$ and $d$. Suppose that $\mathrm{h}_{I}(d)<\mathrm{h}_{I^{s a t}}(d)$, so that a monomial basis of $I_{d}$ is obtained from a monomial basis of $I_{d}^{\text {sat }}$ by removing monomials. No removed monomial is greater than a monomial of $I_{d}$, in the Borel partial order. As the set of removed monomials is finite, its elements can be enumerated by selecting a minimal one and repeating on those that remain.

Let $I$ be Borel-fixed with Hilbert function $\mathrm{h}_{1}=(0,0,3,9,19,36,60, \ldots)$. Then either $I^{\text {sat }}=I_{0}$ or $I^{\text {sat }}=I_{1}$, as $\mathrm{h}_{I}(2)=3>2=\mathrm{h}_{2}(2)=\mathrm{h}_{3}(2)$. Having $I^{\text {sat }}=I_{1}$ would imply $I=I_{1}$, so suppose that $I^{\text {sat }}=I_{0}$. Then $I$ is obtained from $I_{0}$ by removing a single monomial in each degree from 1 to 4 . There is a unique way to do this: remove $x, x t, x t^{2}$, and $x t^{3}$. In
other words, we obtain the list

$$
\begin{aligned}
& I_{0}^{\prime}=\left\langle x^{2}, x y, x z, x t^{4}, y^{5}, y^{4} z^{2}\right\rangle, \\
& I_{1}=\left\langle x^{2}, x y, x z, y^{5}, y^{4} z\right\rangle,
\end{aligned}
$$

of Borel-fixed ideals with Hilbert function $h_{1}$. The ideal $I_{0}^{\prime}$ is the lex-segment ideal for $h_{1}$.
Given this complete list of Borel-fixed ideals on $M^{\mathrm{h}_{1}}$, we study the component structure of the standard-graded Hilbert scheme $M^{\mathrm{h}_{1}}$. In particular, we discover a standard-graded lex-segment ideal contained in the intersection of the two irreducible components of $M^{\mathrm{h}_{1}}$.

Theorem 3.4. The scheme $M^{\mathrm{h}_{1}}$ consists of two irreducible components $M_{0}^{\mathrm{h}_{1}}$ and $M_{1}^{\mathrm{h}_{1}}$, where $\operatorname{dim} M_{0}^{\mathrm{h}_{1}}=24, \operatorname{dim} M_{1}^{\mathrm{h}_{1}}=22, I_{1} \in M_{1}^{\mathrm{h}_{1}} \backslash M_{0}^{\mathrm{h}_{1}}$, and $I_{0}^{\prime} \in M_{0}^{\mathrm{h}_{1}} \cap M_{1}^{\mathrm{h}_{1}}$.

Proof. Suppose that $J \in M^{\mathrm{h}_{1}}$ is a point with gin $J=I_{1}$. As $I_{1}$ is saturated, so is $J$ [Gre10, Theorem 2.30], and it follows that there is a bijective morphism $J \mapsto \operatorname{Proj} S / J$ between the family of such ideals and the regularity 5 locus $R_{5} \subset H$; the locus $R_{5}$ is 22-dimensional [Got08, $\S 2.3]$ and we denote by $M_{1}^{\mathrm{h}_{1}}$ the closure of the corresponding family in $M^{\mathrm{h}_{1}}$. Generically, the points of any irreducible component of $M_{1}^{h_{1}}$ specialize to $I_{1}$. On the other hand, repeating the steps in Example 2.7 shows that the obstruction ideal for $I_{1}$ is prime, meaning that $M^{\mathrm{h}_{1}}$ is, analytically locally at $I_{1}$, an irreducible 22 -dimensional quadratic singularity with $\operatorname{dim}_{\mathbb{K}} T_{I_{1}} M^{\mathrm{h}_{1}}=24$ [Ilt12]. That is, $I_{1}$ lies on a unique irreducible component of $M^{\mathrm{h}_{1}}$ and so $M_{1}^{\mathrm{h}_{1}}$ must be this component. Note that the ideal $K_{1}:=\left\langle x^{2}-x t, x y, x z, y^{4} z, y^{5}\right\rangle \in M_{1}^{\mathrm{h}_{1}}$ is nonsingular and specializes to $I_{1}$.

Now suppose $J \in M^{\mathrm{h}_{1}}$ has gin $J=I_{0}^{\prime}$, so that $J$ has regularity 6 and is non-saturated. Then $J^{s a t}$ is in $M^{\mathrm{h}_{0}}$, so that $J^{s a t}=\langle\ell, f, g\rangle$ is as described in Proposition 3.1. Comparing $J$ with $J^{\text {sat }}$ shows that $J=\left\langle\ell \ell_{1}, \ell \ell_{2}, \ell \ell_{3}, \ell \ell_{4}^{4}, f, g\right\rangle$, where $\ell_{1}, \ell_{2}, \ell_{3}, \ell_{4}$ is a basis for $S_{1}$. That is, the map $J \mapsto J^{s a t}$ is a bundle over $M^{\mathrm{h}_{0}}$ with fibres isomorphic to $G\left(3, S_{1}\right) \cong \mathbb{P}^{1}$. So these ideals form an irreducible, nonsingular, projective family of dimension $24=21+3$, which we denote by $M_{0}^{\mathrm{h}_{1}}$. The regularity 6 ideal $K_{0}:=\left\langle x^{2}-x t, x y, x z, x t^{4}, y^{5}, y^{4} z^{2}\right\rangle \in M_{0}^{\mathrm{h}_{1}}$ has $\operatorname{dim}_{\mathbb{K}} T_{K_{0}} M^{\mathrm{h}_{1}}=24$, showing that $M_{0}^{\mathrm{h}_{1}}$ is an irreducible component of $M^{\mathrm{h}_{1}}$. Moreover the regularity 5 ideal $\left\langle x^{2}, x y, x z, x t^{4}-y^{4} z, y^{5}\right\rangle=\left\langle x^{2}, x y, x z, x t^{4}-y^{4} z, y^{5}, y^{4} z^{2}\right\rangle$ specializes to $I_{0}^{\prime}$, showing that $I_{0}^{\prime}$ lies in $M_{0}^{\mathrm{h}_{1}} \cap M_{1}^{\mathrm{h}_{1}}$. In fact, the universal deformation space at $I_{0}^{\prime}$ can be computed in Macaulay2, explicitly showing that $M^{\mathrm{h}_{1}}$ is analytically locally a transverse intersection of two rational components, of dimensions 24 and 22 , at the point $I_{0}^{\prime}$ [Ilt12].

Finally, if $J \in M^{\mathrm{h}_{1}}$ is an arbitrary point, then gin $J$ must be either $I_{0}^{\prime}$ or $I_{1}$, so $J$ belongs to either $M_{0}^{\mathrm{h}_{1}}$ or $M_{1}^{\mathrm{h}_{1}}$.
3.3. A Lex-Segment Ideal on Three Components. The last standard-graded Hilbert scheme in this sequence is $M^{\mathrm{h}_{2}}$, where $\mathrm{h}_{2}=\mathrm{h}_{3}=(0,0,2,8,19,36,60, \ldots)$ is the Hilbert function of the ideals $I_{2}$ and $I_{3}$. Again, we begin with a list of its Borel-fixed ideals:

I_{0}^{\prime} & =\left\langle x^{2}, x y, x z^{2}, x z t^{2}, x t^{4}, y^{5}, y^{4} z^{2}\right\rangle \\
I_{1}^{\prime} & =\left\langle x^{2}, x y, x z^{2}, x z t^{2}, y^{5}, y^{4} z\right\rangle \\
I_{2} & =\left\langle x^{2}, x y, x z^{2}, y^{4}\right\rangle \\
I_{3} & =\left\langle x^{2}, x y, y^{3}\right\rangle
\end{aligned}
$$

derived from the saturated Borel-fixed ideals with Hilbert polynomial $4 d$ using Lemma 3.3.
3.3.1. In a neighbourhood of $I_{3}$. Let $J \in M^{\mathrm{h}_{2}}$ have gin $J=I_{3}$, so that $J$ is saturated, of regularity 3. Then $\operatorname{Proj} S / J$ lies in the regularity 3 locus $R_{3} \subset H$ [Got08, §2.1] and $J$ lies in the corresponding 16 -dimensional family of ideals, whose closure we denote $M_{3}^{\mathrm{h}_{2}}$. One checks that $\operatorname{dim}_{\mathbb{K}} T_{I_{3}} M^{\mathrm{h}_{2}}=\operatorname{dim}_{\mathbb{K}} \operatorname{Hom}_{S}\left(I_{3}, S / I_{3}\right)_{0}=16$, so $M_{3}^{\mathrm{h}_{2}}$ is an irreducible component of $M^{\mathrm{h}_{2}}$. Alternatively, one may observe that $I_{3}$ defines an arithmetically Cohen-Macaulay scheme [Har10, §8] that is nonsingular on $\operatorname{Hilb}^{4 d}\left(\mathbb{P}^{3}\right)$ [Ell75] and the Comparison Theorem [PS85, §3] holds at $I_{3}$. This component corresponds to Gotzmann's $H_{A V}$.
3.3.2. In a neighbourhood of $I_{2}$. Let $J \in M^{\mathrm{h}_{2}}$ have gin $J=I_{2}$, so that $J$ is saturated, of regularity 4. So $\operatorname{Proj} S / J$ is in the locus $R_{4} \subset H$ and $J \in M_{2}^{\mathrm{h}_{2}}$, where $M_{2}^{\mathrm{h}_{2}}$ denotes the closure of the 23 -dimensional family of ideals corresponding to $R_{4}$. As $R_{4}$ is irreducible, so is $M_{2}^{\mathrm{h}_{2}}$. The regularity 3 ideal $\left\langle x^{2}, x y, x z^{2}-y^{3}\right\rangle=\left\langle x^{2}, x y, x z^{2}-y^{3}, y^{4}\right\rangle$ specializes to $I_{2}$, revealing that $I_{2} \in M_{2}^{\mathrm{h}_{2}} \cap M_{3}^{\mathrm{h}_{2}}$. Notice that $K_{2}:=\left\langle x^{2}-x t, x y, x z^{2}, y^{4}\right\rangle$ belongs to $M_{2}^{\mathrm{h}_{2}}$ and has $\operatorname{dim}_{\mathbb{K}} T_{K_{2}} M^{\mathrm{h}_{2}}=23$, so is a nonsingular point. One can verify that $I_{2}$ satisfies the Comparison Theorem and its universal deformation space is a transverse intersection of a rational 16-dimensional and a rational 23-dimensional component [Ilt12].
3.3.3. In a neighbourhood of $I_{1}^{\prime}$. Let $J \in M^{\mathrm{h}_{2}}$ have gin $J=I_{1}^{\prime}$, so that $J$ is non-saturated, of regularity 5. As Proj $S / J \in R_{5} \subset H$, we have $J^{\text {sat }} \in M_{1}^{\mathrm{h}_{1}}$ from Theorem 3.4. Gotzmann shows that points of $R_{5}$ have saturated ideals of the form $\ell\left\langle\ell_{1}, \ell_{2}, \ell_{3}\right\rangle+\left\langle f_{1}, f_{2}\right\rangle$, where $\ell, \ell_{1}, \ell_{2}, \ell_{3}$ are linear, $\ell_{1}, \ell_{2}, \ell_{3}$ are linearly independent, and $f_{1}, f_{2} \in S_{5}$ (and satisfy further conditions). Let $\ell_{4}$ complete the basis of $S_{1}$. Then $J$ is obtained degree-by-degree from $J^{\text {sat }}$ by: first, choosing a plane in $J_{2}^{\text {sat }}=\mathbb{K}\left\langle\ell \ell_{1}, \ell \ell_{2}, \ell \ell_{3}\right\rangle$ (say $\mathbb{K}\left\langle\ell \ell_{1}, \ell \ell_{2}\right\rangle$, by a coordinate-change); second, choosing a line in $\mathbb{K}\left\langle\ell \ell_{3}^{2}, \ell \ell_{3} \ell_{4}\right\rangle$; and third, setting $J_{d}=J_{d}^{\text {sat }}$, for $d \geq 4$. This means the map $J \mapsto J^{\text {sat }}$ is a $\mathbb{P}^{1}$-bundle over a $\mathbb{P}^{2}$-bundle over the irreducible family $M_{1}^{\mathrm{h}_{1}}$, i.e. these ideals form an irreducible family of dimension $22+2+1=25$, whose closure in $M^{\mathrm{h}_{2}}$ we denote by $M_{1}^{\mathrm{h}_{2}}$. A nonsingular member of $M_{1}^{\mathrm{h}_{2}}$ specializing to $I_{1}^{\prime}$ is $K_{1}:=\left\langle x^{2}-x t, x y, x z^{2}, x z t^{2}, y^{5}, y^{4} z\right\rangle$. The regularity 4 ideal $\left\langle x^{2}, x y, x z^{2}, x z t^{2}-y^{4}\right\rangle=\left\langle x^{2}, x y, x z^{2}, x z t^{2}-y^{4}, y^{5}, y^{4} z\right\rangle$ specializes to $I_{1}^{\prime}$, showing that $I_{1}^{\prime} \in M_{2}^{\mathrm{h}_{2}}$. Hence, we have $I_{1}^{\prime} \in M_{1}^{\mathrm{h}_{2}} \cap M_{2}^{\mathrm{h}_{2}}$. In fact, the power series ansatz also explicitly shows that analytically locally $I_{1}^{\prime}$ lies in the intersection of a rational 23 -dimensional component and a rational 25 -dimensional component [Ilt12].
3.3.4. In a neighbourhood of $I_{0}^{\prime}$. Let $J \in M^{\mathrm{h}_{2}}$ have gin $J=I_{0}^{\prime}$, so that $J$ is non-saturated, of regularity 6 . As $\operatorname{Proj} S / J \in R_{6} \subset H$, we know that $J^{\text {sat }}=\left\langle\ell, \ell^{\prime} h, q h\right\rangle \in M^{\text {ho }_{0}}$ has the form described in Proposition 3.1. Comparing Hilbert functions shows that $J$ is obtained from $J^{\text {sat }}$ as follows: first, remove $\ell$; second, choose a plane in $J_{2}^{\text {sat }}=S_{1} \ell$ (say $\mathbb{K}\langle\ell x, \ell y\rangle$ up to a change-of-basis); third, as $\operatorname{dim}_{\mathbb{K}} S_{1} J_{2}=7$, choose a line in $J_{3}^{\text {sat }} \backslash S_{1} J_{2}=S_{2} \ell \backslash S_{1} J_{2}$ (say spanned by some $\left.\ell q^{\prime} \in \mathbb{K}\left\langle\ell z^{2}, \ell z t, \ell t^{2}\right\rangle\right)$; fourth, as $\operatorname{dim}_{\mathbb{K}} S_{1} J_{3}=18$, choose a line in $J_{4}^{\text {sat }} \backslash S_{1} J_{3}=S_{3} \ell \backslash S_{1} J_{3}$ (say spanned by some $\ell p \in \mathbb{K}\left\langle\ell z^{3}, \ell z^{2} t, \ell z t^{2}, \ell t^{3}\right\rangle \backslash \mathbb{K}\left\langle\ell q^{\prime} z, \ell q^{\prime} t\right\rangle$ ); finally, set $J_{d}=J_{d}^{\text {sat }}$, for $d \geq 5$. In other words, the map $J \mapsto J^{\text {sat }}$ is a $\mathbb{P}^{1}$-bundle over a $\mathbb{P}^{2}$-bundle over a $G\left(2, S_{1} \ell\right)$-bundle over $M^{\mathrm{h}_{0}}$. This shows that the family of such ideals is nonsingular, irreducible, projective, and of dimension $21+4+2+1=28$. Of course, the lex-segment ideal $I_{0}^{\prime}$ is one such ideal. Another such ideal is $K_{0}:=\left\langle x^{2}, x y-x t, x z^{2}, x z t^{2}, x t^{4}, y^{5}, y^{4} z^{2}\right\rangle$, which has $\operatorname{dim}_{\mathbb{K}} T_{K_{0}} M^{\mathrm{h}_{2}}=28$, so the family is an irreducible component, which we denote by $M_{0}^{\mathrm{h}_{2}}$.

Consider the nonsingular point $K_{2}:=\left\langle x^{2}-x t, x y, x z^{2}, y^{4}\right\rangle \in M_{2}^{h_{2}}$. The change-of-basis $\gamma: x \mapsto x+t, y \mapsto x+y, z \mapsto x, t \mapsto z$ transforms $K_{2}$ into the ideal

& \gamma K_{2}:=\left\langle x y+x z-x t+y t+z t-t^{2}, \quad x^{2}-x z+2 x t-z t+t^{2},\right. \\
& x z^{2}-2 x z t+z^{2} t+x t^{2}-2 z t^{2}+t^{3}, \\
& \left.\quad y^{4}-4 y^{3} t+6 y^{2} t^{2}-3 x z t^{2}+2 x t^{3}-4 y t^{3}-3 z t^{3}+3 t^{4}\right\rangle
\end{aligned}
$$

in $M_{2}^{\mathrm{h}_{2}}$ and the lexicographic initial ideal of $\gamma K_{2}$ is $I_{0}^{\prime}$, showing that $I_{0}^{\prime}$ also belongs to $M_{2}^{\mathrm{h}_{2}}$. Moreover, the ideal $\left\langle x^{2}, x y, x z^{2}, x z t^{2}, x t^{4}-y^{4} z, y^{5}\right\rangle=\left\langle x^{2}, x y, x z^{2}, x z t^{2}, x t^{4}-y^{4} z, y^{5}, y^{4} z^{2}\right\rangle$ has regularity 5 and specializes to $I_{0}^{\prime}$, showing that $I_{0}^{\prime} \in M_{1}^{\mathrm{h}_{2}}$. Hence, we have shown that $I_{0}^{\prime}$ lies in the triple intersection $M_{0}^{\mathrm{h}_{2}} \cap M_{1}^{\mathrm{h}_{2}} \cap M_{2}^{\mathrm{h}_{2}}$. To see that $I_{0}^{\prime} \notin M_{3}^{\mathrm{h}_{2}}$, note that any subfamily of $M_{3}^{\mathrm{h}_{2}}$ containing $I_{0}^{\prime}$ defines a flat family in $H_{A V}$ containing the lexicographic point Proj $S / I_{0}^{\prime}$; this is a contradiction by smoothness of Proj $S / I_{0}^{\prime}[\mathrm{RS} 97]$. The power series ansatz terminates for $I_{0}^{\prime}$, but the obstruction ideal is too complicated to directly obtain its primary decomposition. However, one quickly identifies a unique 28 -dimensional irreducible component and the residual scheme has dimension 25 , as expected from our description.

Theorem 3.5. The standard-graded Hilbert scheme $M^{\mathrm{h}_{2}}$ consists of four irreducible components, of dimensions 16, 23, 25, and 28. The lex-segment ideal with Hilbert function $\mathrm{h}_{2}$ lies in the intersection of the three highest-dimensional components.

Proof. If $J \in M^{\mathrm{h}_{2}}$, then gin $J$ is one of the aforementioned Borel-fixed ideals, so $J$ belongs to one of the identified components $M_{0}^{\mathrm{h}_{2}}, M_{1}^{\mathrm{h}_{2}}, M_{2}^{\mathrm{h}_{2}}$, or $M_{3}^{\mathrm{h}_{2}}$. Hence, the preceding paragraphs identify all irreducible components of $M^{h_{2}}$. (In particular, a nonsingular point is identified in each component.)

Remark 3.6. The incidence complex of $M=M^{\mathrm{h}_{2}}=\operatorname{Hilb}^{\mathrm{h}_{2}}(\mathbb{K}[x, y, z, t])$ is as follows. Here the upper index at a node displays the dimension of the corresponding irreducible component.


## 4. Nearby Examples

The analysis of the previous section can be performed on many examples. Here we do this at the nodes immediately preceding Gotzmann's example in the codimension 2 Hilbert tree.
4.1. An Example in the Plane. The Hilbert scheme $\operatorname{Hilb}^{4}\left(\mathbb{P}^{2}\right)$ has two Borel-fixed points, with saturated ideals in $S:=\mathbb{K}[x, y, z]$ and Hilbert functions as follows:

$$
\begin{array}{ll}
I_{0}=\left\langle x, y^{4}\right\rangle, & \mathrm{h}_{0}=(0,1,3,6,11,17, \ldots), \\
I_{1}=\left\langle x^{2}, x y, y^{3}\right\rangle, & \mathrm{h}_{1}=(0,0,2,6,11,17, \ldots),
\end{array}
$$

where $I_{i}$ has regularity $4-i$. The standard-graded Hilbert scheme $M^{\mathrm{h}_{0}}:=\operatorname{Hilb}^{\mathrm{h}_{0}}(S)$ is nonsingular and irreducible, of dimension 6 , comprised of ideals of the form $\langle\ell, f\rangle$ where $\ell \in S_{1}, f \in S_{4}$, and $\ell \nmid f$.

We study the standard-graded Hilbert scheme $M^{\mathrm{h}_{1}}:=\operatorname{Hilb}^{\mathrm{h}_{1}}(S)$. Its Borel-fixed points are

$$
\begin{aligned}
I_{0}^{\prime} & =\left\langle x^{2}, x y, x z^{2}, y^{4}\right\rangle \\
I_{1} & =\left\langle x^{2}, x y, y^{3}\right\rangle
\end{aligned}
$$

where $I_{0}^{\prime}$ is obtained from $I_{0}$ via Lemma 3.3. We prove the following result.
Theorem 4.1. The standard-graded Hilbert scheme $M^{\mathrm{h}_{1}}$ is a union of two 8-dimensional components $M_{0}^{\mathrm{h}_{1}}, M_{1}^{\mathrm{h}_{1}}$ with lex-segment ideal $I_{0}^{\prime} \in M_{0}^{\mathrm{h}_{1}} \cap M_{1}^{\mathrm{h}_{1}}$ and $I_{1} \in M_{1}^{\mathrm{h}_{1}} \backslash M_{0}^{\mathrm{h}_{1}}$.

Proof. Every $J \in M^{h_{1}}$ has $J_{2}=\mathbb{K}\left\langle q_{1}, q_{2}\right\rangle$ spanned by two quadrics. If $q_{1}, q_{2}$ do not share a common factor, then $J=\left\langle q_{1}, q_{2}\right\rangle$ is a complete intersection ideal and the Koszul complex shows that $J$ has regularity 3 ; moreover, $J$ is saturated and gin $J=I_{1}$. Conversely, suppose that $J$ has gin $J=I_{1}$, so that $J$ is saturated of regularity 3 , and suppose that $q_{1}, q_{2}$ do share a common factor, say $q_{1}=\ell \ell_{1}, q_{2}=\ell \ell_{2}$, where $\ell, \ell_{1}, \ell_{2} \in S_{1}$ and $\ell_{1}, \ell_{2}$ are linearly independent. Then there is a cubic generator $p \in J_{3} \backslash S_{1} J_{2}$ and we must have $\ell \nmid p$, as $J$ is saturated but $\ell \notin J$. This shows that $J=\left\langle\ell \ell_{1}, \ell \ell_{2}, p\right\rangle$ with $\ell \nmid p ;$ moreover, $\mathrm{h}_{1}(4)=11$ implies $p \in\left\langle\ell_{1}, \ell_{2}\right\rangle$. Let $M_{1}^{\mathrm{h}_{1}}$ denote the closure of the family of ideals $J$ with gin $J=I_{1}$. Then the subfamily of complete intersections has dimension 8 , while the family of ideals with a cubic generator has dimension 7 , so $M_{1}^{\mathrm{h}_{1}}$ has dimension 8 . In fact, we have $\operatorname{dim}_{\mathbb{K}} T_{I_{1}} M^{\mathrm{h}_{1}}=8$, so $I_{1}$ is a nonsingular point and $M_{1}^{\mathrm{h}_{1}}$ is an irreducible component of $M^{\mathrm{h}_{1}}$.

On the other hand, if $J$ has gin $J=I_{0}^{\prime}$, then $J$ is non-saturated, of regularity 4, and $J^{s a t} \in M^{\mathrm{h}_{0}}$ has the form $\langle\ell, f\rangle$ where $\ell \in S_{1}, f \in S_{4}$, and $\ell \nmid f$. To obtain $J$ from $J^{s a t}$, first, remove $\ell$, second, choose a plane $\mathbb{K}\left\langle\ell \ell_{1}, \ell \ell_{2}\right\rangle \subset J_{2}^{\text {sat }}=S_{1} \ell$, and third, set $J_{d}=J_{d}^{\text {sat }}$, for $d \geq 3$. This family is a $\mathbb{P}^{2}$-bundle over $M^{\mathrm{h}_{0}}$, giving an irreducible, nonsingular, projective family of dimension $6+2=8$, which we denote by $M_{0}^{\mathrm{h}_{1}}$. The ideal $K_{0}:=\left\langle x^{2}-x z, x y, x z^{2}, y^{4}\right\rangle$ is in $M_{0}^{\mathrm{h}_{1}}$, with $\operatorname{dim}_{\mathbb{K}} T_{K_{0}} M^{\mathrm{h}_{1}}=8$, so $M_{0}^{\mathrm{h}_{1}}$ is an irreducible component. Moreover, the ideal $\left\langle x^{2}, x y, x z^{2}-y^{3}\right\rangle=\left\langle x^{2}, x y, x z^{2}-y^{3}, y^{4}\right\rangle$ has regularity 3 (and is nonsingular on $M_{1}^{\mathrm{h}_{1}}$ ) but specializes to $I_{0}^{\prime}$. This shows that $I_{0}^{\prime} \in M_{0}^{\mathrm{h}_{1}} \cap M_{1}^{\mathrm{h}_{1}}$.

Any $J \in M^{\mathrm{h}_{1}}$ has gin $J=I_{0}^{\prime}$ or gin $J=I_{1}$, so $M^{\mathrm{h}_{1}}=M_{0}^{\mathrm{h}_{1}} \cup M_{1}^{\mathrm{h}_{1}}$. In fact, the power series ansatz at $I_{0}^{\prime}$ yields a transverse intersection of two 8-dimensional components.
4.2. Lifting to Degree Four Space Curves. The Hilbert scheme Hilb ${ }^{4 d-2}\left(\mathbb{P}^{3}\right)$ has a unique Borel-fixed point, so is nonsingular and irreducible [Sta20, Lemma 5.6]. If $h_{0}$ denotes its Hilbert function and $I_{0}$ its ideal, then every homogeneous ideal $J \subset S=\mathbb{K}[x, y, z, t]$ with Hilbert function $\mathrm{h}_{0}$ has gin $J=I_{0}$ and is saturated. By Proposition 3.2, the standard-graded Hilbert scheme $\operatorname{Hilb}^{h_{0}}(S)$ is nonsingular and irreducible; its dimension is 17 and its points are complete intersection ideals $\langle\ell, f\rangle$, for $\ell \in S_{1}$ and $f \in S_{4}$.

Moving towards Gotzmann's example, the Hilbert scheme $\operatorname{Hilb}^{4 d-1}\left(\mathbb{P}^{3}\right)$ has two Borel-fixed points, with saturated ideals in $S=\mathbb{K}[x, y, z, t]$ and Hilbert functions as follows:

$$
\begin{array}{ll}
I_{0}=\left\langle x, y^{5}, y^{4} z\right\rangle, & \mathrm{h}_{0}=(0,1,4,10,20,37,61, \ldots), \\
I_{1}=\left\langle x^{2}, x y, x z, y^{4}\right\rangle, & \mathrm{h}_{1}=(0,0,3,9,20,37,61, \ldots),
\end{array}
$$

where $I_{i}$ has regularity $5-i$. As in Proposition 3.1, the standard-graded Hilbert scheme $\operatorname{Hilb}^{h_{0}}(S)$ is nonsingular and irreducible; its dimension is 19 and its points have the form $\left\langle\ell, \ell_{1} g, \ell_{2} g\right\rangle$, where $\ell, \ell_{1}, \ell_{2} \in S_{1}$ are linearly independent and $g \in S_{4}$ such that $\ell \nmid g$.

So let us examine $M^{h_{1}}:=\operatorname{Hilb}^{h_{1}}(S)$. Its Borel-fixed ideals are

$$
\begin{aligned}
I_{0}^{\prime} & =\left\langle x^{2}, x y, x z, x t^{3}, y^{5}, y^{4} z\right\rangle \\
I_{1} & =\left\langle x^{2}, x y, x z, y^{4}\right\rangle
\end{aligned}
$$

where $I_{0}^{\prime}$ is obtained from $I_{0}$ via Lemma 3.3. We aim to prove the following.
Theorem 4.2. We have $M^{\mathrm{h}_{1}}=M_{0}^{\mathrm{h}_{1}} \cup M_{1}^{\mathrm{h}_{1}}$, where $M_{0}^{\mathrm{h}_{1}}$ is a 22-dimensional component, $M_{1}^{\mathrm{h}_{1}}$ is a 20-dimensional component, the lex-segment ideal $I_{0}^{\prime} \in M_{0}^{\mathrm{h}_{1}} \cap M_{1}^{\mathrm{h}_{1}}$, and $I_{1} \in M_{1}^{\mathrm{h}_{1}} \backslash M_{0}^{\mathrm{h}_{1}}$.
4.2.1. In a neighbourhood of $I_{1}$. Suppose that $J \in M^{\mathrm{h}_{1}}$ has $\operatorname{gin} J=I_{1}$, so that $J$ is saturated, of regularity 4 . We have $J_{2}=\mathbb{K}\left\langle q_{1}, q_{2}, q_{3}\right\rangle$, where the quadrics do not generate a complete intersection ideal, so at least two of the quadrics share a common factor, say $q_{1}=\ell \ell_{1}$ and $q_{2}=\ell \ell_{2}$ with $\ell_{1}, \ell_{2}$ linearly independent. But then $\operatorname{dim}_{\mathbb{K}} S_{1}\left\langle q_{1}, q_{2}\right\rangle \cap S_{1} q_{3}=2$, which is only possible if $\ell \mid q_{3}$ as well, so we set $q_{3}=\ell \ell_{3}$. We find that $\operatorname{dim}_{\mathbb{K}} S_{1} J_{2}=9$ and $\operatorname{dim}_{\mathbb{K}} S_{2} J_{2}=19$, so that $J_{3}=S_{1} J_{2}$ and there exists $g \in J_{4} \backslash S_{2} J_{2}$. If $\ell \mid g$, then without loss of generality $g=\ell \ell_{4}^{3}$, where $\ell_{1}, \ell_{2}, \ell_{3}, \ell_{4}$ is a basis of $S_{1}$, but then $J=J^{\text {sat }}$ implies $\ell \in J$, a contradiction. Thus, we have $J=\left\langle\ell \ell_{1}, \ell \ell_{2}, \ell \ell_{3}, g\right\rangle$ with $g \in S_{4}, \ell \nmid g$, and moreover $g \in\left\langle\ell_{1}, \ell_{2}, \ell_{3}\right\rangle$. A parameter count shows that this family has dimension 20; we denote its Zariski closure by $M_{1}^{\mathrm{h}_{1}}$. One verifies that $\operatorname{dim}_{\mathbb{K}} T_{I_{1}} M^{\mathrm{h}_{1}}=20$, so $M_{1}^{\mathrm{h}_{1}}$ is an irreducible component with nonsingular point $I_{1}$.
4.2.2. In a neighbourhood of $I_{0}^{\prime}$. If $J \in M^{\mathrm{h}_{1}}$ has $\operatorname{gin} J=I_{0}^{\prime}$, then $J$ is non-saturated, of regularity 5 . This means $J^{\text {sat }} \in M^{\mathrm{h}_{0}}$, so $J^{\text {sat }}=\left\langle\ell, \ell_{1}^{\prime} g, \ell_{2}^{\prime} g\right\rangle$, where $\ell, \ell_{1}^{\prime}, \ell_{2}^{\prime} \in S_{1}$ are linearly independent and $g \in S_{4}$ such that $\ell \nmid g$. We obtain $J$ from $J^{\text {sat }}$ degree-by-degree by, first, removing $\ell$, and second, choosing a hyperplane $\mathbb{K}\left\langle\ell \ell_{1}, \ell \ell_{2}, \ell \ell_{3}\right\rangle$ in $J_{2}^{\text {sat }}=S_{1} \ell$; we then have $J_{3}=S_{1} J_{2}$ and $J_{d}=J_{d}^{\text {sat }}$, for $d \geq 4$. This means the family of such ideals has the structure of a $\mathbb{P}^{3}$-bundle over $M^{\mathrm{h}_{0}}$, resulting in a nonsingular, irreducible, projective family of dimension $19+3=22$, which we denote by $M_{0}^{\mathrm{h}_{1}}$. The ideal $K_{0}=\left\langle x^{2}-x t, x y, x z, x t^{3}, y^{5}, y^{4} z\right\rangle$ belongs to $M_{0}^{\mathrm{h}_{1}}$ and has $\operatorname{dim}_{\mathbb{K}} T_{K_{0}} M=22$, so $M_{0}^{\mathrm{h}_{1}}$ is an irreducible component. Further, the regularity 4 ideal $\left\langle x^{2}, x y, x z, x t^{3}-y^{4}\right\rangle=\left\langle x^{2}, x y, x z, x t^{3}-y^{4}, y^{5}, y^{4} z\right\rangle \in M_{1}^{h_{1}}$ specializes to $I_{0}^{\prime}$, showing that the lex-segment ideal satisfies $I_{0}^{\prime} \in M_{0}^{\mathrm{h}_{1}} \cap M_{1}^{\mathrm{h}_{1}}$.
Proof of Theorem 4.2. If $J \in M^{h_{1}}$, then either gin $J=I_{0}^{\prime}$ or gin $J=I_{1}$, so $J$ belongs to one of the identified components. Note that the power series ansatz terminates at $I_{0}^{\prime}$, showing the transverse intersection of $M_{0}^{\mathrm{h}_{1}}$ and $M_{1}^{\mathrm{h}_{1}}$ [Ilt12].

## 5. Twisted Cubics

We conclude with an example that has been hiding in plain sight for some time.
5.1. A Singular Lex-Segment Ideal of Twisted Cubics. The Borel-fixed points on $\operatorname{Hilb}^{3 d+1}\left(\mathbb{P}^{3}\right)$ have saturated ideals in $S=\mathbb{K}[x, y, z, t]$ with Hilbert functions as follows:

$$
\begin{aligned}
& I_{0}=\left\langle x, y^{4}, y^{3} z\right\rangle, \\
& I_{1}=\left\langle x^{2}, x y, x z, y^{3}\right\rangle, \\
& I_{2}=\left\langle x^{2}, x y, y^{2}\right\rangle
\end{aligned}
$$

$$
\mathrm{h}_{0}=(0,1,4,10,22,40,65, \ldots)
$$

$$
\mathrm{h}_{1}=(0,0,3,10,22,40,65, \ldots)
$$

$$
\mathrm{h}_{2}=(0,0,3,10,22,40,65, \ldots)
$$

where $I_{i}$ has regularity $4-i$.

Similarly to previous instances, $M^{\mathrm{h}_{0}}:=\operatorname{Hilb}^{\mathrm{h}_{0}}(S)$ is a nonsingular and irreducible projective variety; its dimension is 14 and its points have the form $\left\langle\ell, \ell_{1} p, \ell_{2} p\right\rangle$, where $\ell, \ell_{1}, \ell_{2}$ are linearly independent, $p \in S_{3}$, and $\ell \nmid p$.

Next, as $\mathrm{h}_{1}=\mathrm{h}_{2}$, we study $M^{\mathrm{h}_{1}}:=\operatorname{Hilb}^{\mathrm{h}_{1}}(S)$. Its Borel-fixed points are the following:

$$
\begin{aligned}
I_{0}^{\prime} & =\left\langle x^{2}, x y, x z, x t^{2}, y^{4}, y^{3} z\right\rangle \\
I_{1} & =\left\langle x^{2}, x y, x z, y^{3}\right\rangle \\
I_{2} & =\left\langle x^{2}, x y, y^{2}\right\rangle
\end{aligned}
$$

where $I_{0}^{\prime}$ is obtained via Lemma 3.3. The analysis is analogous to that of previous examples.
5.1.1. In a neighbourhood of $I_{2}$. If $J \in M^{\mathrm{h}_{1}}$ has $\operatorname{gin} J=I_{2}$, then $J$ is saturated, of regularity 2 , and so $J=\left\langle q_{1}, q_{2}, q_{3}\right\rangle$ is generated by quadrics. This family parametrizes the twisted cubics. We denote its closure by $M_{2}^{\mathrm{h}_{2}}$ and note that $\operatorname{dim} M_{2}^{\mathrm{h}_{1}}=\operatorname{dim}_{\mathbb{K}} T_{I_{2}} M^{\mathrm{h}_{1}}=12$, so that $M_{2}^{\mathrm{h}_{1}}$ is an irreducible component with nonsingular point $I_{2}$.
5.1.2. In a neighbourhood of $I_{1}$. If $J \in M^{\mathrm{h}_{1}}$ has $\operatorname{gin} J=I_{1}$, then $J$ is saturated, of regularity 3 , and again we know that $J_{2}=\mathbb{K}\left\langle q_{1}, q_{2}, q_{3}\right\rangle$, where $q_{1}, q_{2}, q_{3}$ now share a common factor. So $q_{1}=\ell \ell_{1}, q_{2}=\ell \ell_{2}, q_{3}=\ell \ell_{3}$, for some linear $\ell$ and linearly independent $\ell_{1}, \ell_{2}, \ell_{3} \in S_{1}$. These quadrics generate a 9 -dimensional subspace of $S_{3}$, so there is an additional cubic generator, say $p \in J_{3}$. Then $\ell \nmid p$, because otherwise $J=J^{\text {sat }}$ implies $\ell \in J$; we further see that $\operatorname{dim}_{\mathbb{K}} S_{1} p \cap S_{2}\left\langle\ell \ell_{1}, \ell \ell_{2}, \ell \ell_{3}\right\rangle=1$, so $p \in\left\langle\ell_{1}, \ell_{2}, \ell_{3}\right\rangle$. This family is in bijection with a dense open subset of the lexicographic component of $\operatorname{Hilb}^{3 d+1}\left(\mathbb{P}^{3}\right)$, in other words, is an irreducible component of dimension 15 [PS85, Lemma 4]; we denote its closure by $M_{1}^{\mathrm{h}_{1}}$. The ideal $\left\langle x^{2}, x y, x z-y^{2}\right\rangle=\left\langle x^{2}, x y, x z-y^{2}, y^{3}\right\rangle$ specializes to $I_{1}$ but has regularity 2 , showing that $I_{1} \in M_{1}^{\mathrm{h}_{1}} \cap M_{2}^{\mathrm{h}_{1}}$. This is expected of course, as $I_{1}$ satisfies the Comparison Theorem and the well-known description of the component structure of $\operatorname{Hilb}^{3 d+1}\left(\mathbb{P}^{3}\right)$ hinges on the termination of the power series ansatz at $I_{1}$ [PS85, Lemma 6].
5.1.3. In a neighbourhood of $I_{0}^{\prime}$. If $J \in M^{\mathrm{h}_{1}}$ has $\operatorname{gin} J=I_{0}^{\prime}$, then $J$ is non-saturated, of regularity 4 , and $J^{s a t} \in M^{\mathrm{h}_{0}}$ equals $\left\langle\ell, \ell_{1}^{\prime} p, \ell_{2}^{\prime} p\right\rangle$, where $\ell, \ell_{1}^{\prime}, \ell_{2}^{\prime}$ are linearly independent, $p \in S_{3}$, and $\ell \nmid p$. We obtain $J$ from $J^{\text {sat }}$ by first, removing $\ell$, second, choosing a hyperplane $\mathbb{K}\left\langle\ell \ell_{1}, \ell \ell_{2}, \ell \ell_{3}\right\rangle \subset J_{2}^{\text {sat }}=S_{1} \ell$, and third, setting $J_{d}=J_{d}^{\text {sat }}$, for $d \geq 3$. The family of such ideals forms a $\mathbb{P}^{3}$-bundle over $M^{\mathrm{h}_{0}}$, defining an irreducible, nonsingular, projective family of dimension $14+3=17$, which we denote by $M_{0}^{h_{1}}$. The ideal $K_{0}=\left\langle x^{2}-x t, x y, x z, x t^{2}, y^{4}, y^{3} z\right\rangle$ is in $M_{0}^{\mathrm{h}_{1}}$ and has $\operatorname{dim}_{\mathbb{K}} T_{K_{0}} M^{\mathrm{h}_{1}}=17$, showing that $M_{0}^{\mathrm{h}_{1}}$ is an irreducible component of $M^{\mathrm{h}_{1}}$. Observe that the ideal $\left\langle x^{2}, x y, x z, x t^{2}-y^{3}\right\rangle=\left\langle x^{2}, x y, x z, x t^{2}-y^{3}, y^{3} z, y^{4}\right\rangle$ has regularity 3 and specializes to $I_{0}^{\prime}$, showing that $I_{0}^{\prime} \in M_{1}^{\mathrm{h}_{1}}$. Hence, the lex-segment ideal $I_{0}^{\prime}$ lies in the intersection $M_{0}^{\mathrm{h}_{1}} \cap M_{1}^{\mathrm{h}_{1}}$. In fact, Example 2.7 demonstrates that the power series ansatz terminates at $I_{0}^{\prime}$, showing that the universal deformation space is a transverse intersection of a rational 15 -dimensional component and a rational 17-dimensional component [Ilt12].

Theorem 5.1. We have $M^{\mathrm{h}_{1}}=M_{0}^{\mathrm{h}_{1}} \cup M_{1}^{\mathrm{h}_{1}} \cup M_{2}^{\mathrm{h}_{1}}$, where the irreducible components have dimensions $\operatorname{dim} M_{0}^{\mathrm{h}_{1}}=17$, $\operatorname{dim} M_{1}^{\mathrm{h}_{1}}=15$, and $\operatorname{dim} M_{2}^{\mathrm{h}_{1}}=12$, and the lex-segment ideal lies in $M_{0}^{\mathrm{h}_{1}} \cap M_{1}^{\mathrm{h}_{1}}$.
Proof. Any ideal $J$ with Hilbert function $\mathrm{h}_{1}$ must have gin $J$ equal to $I_{0}^{\prime}, I_{1}$, or $I_{2}$, and hence lies in one of the identified components. The preceding paragraphs derive the decomposition and show $I_{0}^{\prime} \in M_{0}^{\mathrm{h}_{1}} \cap M_{1}^{\mathrm{h}_{1}}$.

Remark 5.2. The incidence graph of $M=M^{\mathrm{h}_{1}}$ is as follows. The upper index at a node displays the dimension of the corresponding irreducible component.
