# ON THE FIXED POINT SPACES OF SOME COMPLETELY POSITIVE MAPS

#### Abstract

In this paper we generalize the results shown by Das and Peterson. Let $M$ be a $\mathrm{II}_{1}$-factor acting on $L^{2}(M)$. We consider certain unital normal completely positive maps on $B\left(L^{2}(M)\right)$ which are identity on $M$. We investigate their fixed point spaces and obtain a rigidity result. As an application, we show some results of subfactors.


## 1. Introduction

Let $M$ be a $\mathrm{II}_{1}$-factor acting on $H=L^{2}(M)$. Let $\left\{z_{n}\right\}_{n=1}^{\infty}$ be a sequence in $M$ such that $\left\{z_{n}\right\}_{n=1}^{\infty}$ is $*$-closed as a set and $\sum_{n=1}^{\infty} z_{n} z_{n}^{*}=\sum_{n=1}^{\infty} z_{n}^{*} z_{n}=1$. We define unital normal completely positive maps $\phi=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n} J$ and $\tilde{\phi}=\sum_{n=1}^{\infty} \operatorname{Ad} z_{n}^{*}$. In the paper [4], Das and Peterson investigate the fixed point space $B(H)^{\phi}$ and they showed the following interesting results. If $M$ is generated by $\left\{z_{n}\right\}_{n=1}^{\infty}$, then we have
(i) $M^{\prime} \cap B(H)^{\phi}=\mathbb{C}$.
(ii) $B(H)^{\phi} \cap B(H)^{\tilde{\phi}}=\mathbb{C}$.
(iii) If $\Phi$ is a normal unital completely positive map from $B(H)^{\phi}$ to $B(H)^{\phi}$ such that $\Phi=i d$ on $M$, then we have $\Phi=i d$ on $B(H)^{\phi}$.
(iv) If $M \neq B(H)^{\phi}$, then $B(H)^{\phi}$ is an AFD type III-factor.

The aim of this paper is to generalize these results without the assumption that $\left\{z_{n}\right\}_{n=1}^{\infty}$ generates $M$. Moreover we investigate the properties of the fixed point $\bigcap_{j=1}^{N} B(H)^{\phi_{j}}$. Consider the family of sequences

\mathfrak{S}=\left\{\left\{z_{n}\right\}_{n=1}^{\infty}: z_{n} \in M, \sum_{n=1}^{\infty} z_{n} z_{n}^{*}=\sum_{n=1}^{\infty} z_{n}^{*} z_{n}=1\right.
$$

for each $n$, there exists $k$ such that $\left.z_{n}^{*}=z_{k}\right\}$
and set $G=\left\{\phi=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n} J:\left\{z_{n}\right\}_{n=1}^{\infty} \in \mathfrak{S}\right\}$. Fix an element $\phi \in G$ with $\phi=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n} J$ and denote by $P$ the von Neumann algebra generated by $\left\{z_{n}\right\}_{n}$. Then we have the inclusions

$$
P \subseteq M \subseteq\left\langle M, e_{P}\right\rangle \subseteq B(H)^{\phi},
$$

where $e_{P}$ is the Jones projection onto $L^{2}(P)$ [6]. We will show the following.
(i) $M^{\prime} \cap B(H)^{\phi}=M^{\prime} \cap\left\langle M, e_{P}\right\rangle=J\left(P^{\prime} \cap M\right) J$ (Theorem 2.3).
(ii) If $P$ is a factor, then $e_{P}\left(B(H)^{\phi} \cap B(H)^{\tilde{\phi}}\right) e_{P}=\mathbb{C} e_{P}$. (Lemma 3.7.)
(iii) If $\Phi$ is a normal unital completely positive map from $B(H)^{\phi}$ to $B(H)^{\phi}$ such that $\Phi=i d$ on $\left\langle M, e_{P}\right\rangle$, then we have $\Phi=i d$ on $B(H)^{\phi}$ (Theorem 3.3.)
(iv) If $P$ is a non-AFD factor, then $B(H)^{\phi}$ is an AFD type III-factor. (Corollary 3.9.)
(v) Fix finite elements $\phi_{1}, \phi_{2}, \cdots, \phi_{N} \in G$ with $\phi_{i} \circ \phi_{j}=\phi_{j} \circ \phi_{i}$. Then there exists elements $z_{n}^{(j)} \in M$ such that $\phi_{j}=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n}^{(j)} J, \sum_{n=1}^{\infty} z_{n}^{(j)} z_{n}^{(j)^{*}}=$ $\sum_{n=1}^{\infty} z_{n}^{(j)^{*}} z_{n}^{(j)}=1$ and $z_{n}^{(j)^{*}}=z_{k}^{(j)}$ for some $k$. For any positive numbers $\left\{\lambda_{j}\right\}_{j=1}^{N}$ with $\sum_{j=1}^{N} \lambda_{j}=1$, we set $\phi=\sum_{j=1}^{N} \lambda_{j} \phi_{j}$. Then we have $\bigcap_{j=1}^{N} B(H)^{\phi_{j}}=B(H)^{\phi}$. (Proposition 3.4.)

For the proof, we basically follow the argument in [4] with some modifications. As an application, we investigate the inclusions $B(H)^{\phi^{k}} \subseteq B(H)^{\phi^{m k}}$. We determine the Jones index and obtain some properties for these inclusions.

## 2. BASIC PROPERTIES

Throughout this paper, let $M$ be a $\mathrm{II}_{1}$-factor with a unique tracial state $\tau$. We set $H=L^{2}(M, \tau)$ with a cyclic trace unit vector $\xi_{0}$. We consider the family of sequences

\mathfrak{S}=\left\{\left\{z_{n}\right\}_{n=1}^{\infty}: z_{n} \in M, \sum_{n=1}^{\infty} z_{n} z_{n}^{*}=\sum_{n=1}^{\infty} z_{n}^{*} z_{n}=1\right.
$$

$$
\text { for each } \left.n \text {, there exists } k \text { such that } z_{n}^{*}=z_{k}\right\}
$$

and set $G=\left\{\phi=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n} J:\left\{z_{n}\right\}_{n=1}^{\infty} \in \mathfrak{S}\right\}$. Then each element $\phi$ in $G$ is a unital normal completely positive map from $B(H)$ to $B(H)$ such that $\phi=i d$ on $M$. Here we remark that $G$ is not closed under composition. For each $\phi=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n} J \in G$, we set $\tilde{\phi}=\sum_{n=1}^{\infty} \operatorname{Ad} z_{n}^{*}$. Then $\tilde{\phi}$ is also a unital normal completely positive map.

Let $P$ be a von Neumann algebra generated by $\left\{z_{n}\right\}_{n=1}^{\infty}$ and let $e_{P}$ be the Jones projection onto $L^{2}(P, \tau)$. Consider the Jones basic extension

$$
P \subseteq M \subseteq\left\langle M, e_{P}\right\rangle=(J P J)^{\prime}
$$

Let $B(H)^{\phi}$ be the set of fixed points of $\phi$. Since $J e_{P} J=e_{P}$ and $e_{P} \in P^{\prime}$, we see that $\phi\left(e_{P}\right)=\sum_{n=1}^{\infty} J z_{n} J e_{P} J z_{n}^{*} J=e_{P} \sum_{n=1}^{\infty} J z_{n} z_{n}^{*} J=e_{P}$. Thus we have the inclusions

$$
P \subseteq M \subseteq\left\langle M, e_{P}\right\rangle \subseteq B(H)^{\phi}
$$

Let $\omega_{0}$ be the vector state of a trace vector $\xi_{0}$. Then it is easy to see that $\omega_{0} \circ \phi=\omega_{0} \circ \tilde{\phi}$ on $B(H)$.

Lemma 2.1. $\omega_{0}$ is faithful on $e_{P} B(H)^{\phi} e_{P}$.
Proof. Let $T \in B(H)^{\phi}$ be a positive element satisfying $\omega_{0}\left(e_{P} T e_{P}\right)=0$. Since $e_{P} T e_{P} \in B(H)^{\phi}$, we see that

$$
0=\omega_{0}\left(e_{P} T e_{P}\right)=\left\langle e_{P} T e_{P} \xi_{0}, \xi_{0}\right\rangle=\left\langle\phi^{n}\left(e_{P} T e_{P}\right) \xi_{0}, \xi_{0}\right\rangle=\sum\left\|T^{\frac{1}{2}} w \xi_{0}\right\|^{2}
$$

where $w$ is some word of $\left\{z_{n}\right\}_{n}$. Since the set $\left\{z_{n}\right\}_{n=1}^{\infty}$ is $*$-closed, the word $w$ runs through all $*$-words of $\left\{z_{n}\right\}_{n}$. Thus we conclude that $T^{\frac{1}{2}} e_{P}=0$ and hence $e_{P} T e_{P}=0$.

Lemma 2.2. If $T, T^{*} T \in B(H)^{\phi}$, then we have $T \in\left(\left\{J z_{n} J\right\}_{n=1}^{\infty}\right)^{\prime}=\left\langle M, e_{P}\right\rangle$. In particular, $\left\langle M, e_{P}\right\rangle$ is a maximum $*$-subalgebra of $B(H)^{\phi}$.

Similarly, if $T, T^{*} T \in B(H)^{\tilde{\phi}}$, then we have $T \in\left(\left\{z_{n}\right\}_{n=1}^{\infty}\right)^{\prime}$.
Proof. Assume that $T, T^{*} T \in B(H)^{\phi}$. We observe that for any $\xi \in H$,

\begin{aligned}
& \left\|\left(J z_{n}^{*} J T-T J z_{n}^{*} J\right) \xi\right\|^{2}=\left\langle\left(T^{*} J z_{n} J-J z_{n} J T^{*}\right)\left(J z_{n}^{*} J T-T J z_{n}^{*} J\right) \xi \cdot \xi\right\rangle \\
& =\left\langle\left(T^{*} J z_{n} z_{n}^{*} J T+J z_{n} J T^{*} T J z_{n}^{*} J-T^{*} J z_{n} J T J z_{n}^{*} J-J z_{n} J T^{*} J z_{n}^{*} J T\right) \xi, \xi\right\rangle
\end{aligned}
$$

Then we have

$$
\sum_{n=1}^{\infty}\left\|\left(J z_{n}^{*} J T-T J z_{n}^{*} J\right) \xi\right\|^{2}=\left\langle\left(T^{*} T+\phi\left(T^{*} T\right)-T^{*} \phi(T)-\phi\left(T^{*}\right) T\right) \xi, \xi\right\rangle=0
$$

Since the set $\left\{z_{n}\right\}_{n=1}^{\infty}$ is $*$-closed, we conclude that $T \in\left(\left\{J z_{n} J\right\}_{n=1}^{\infty}\right)^{\prime}=(J P J)^{\prime}=$ $\left\langle M, e_{P}\right\rangle$. Next we will show that $\left\langle M, e_{P}\right\rangle$ is a maximum $*$-subalgebra of $B(H)^{\phi}$. Let $A$ be a subset of $B(H)^{\phi}$ such that $A$ is a $*$-subalgebra of $B(H)$. Then for any $T \in A$, since $T, T^{*} T \in A \subseteq B(H)^{\phi}$, we have $T \in\left\langle M, e_{P}\right\rangle$. Therefore we conclude $A \subseteq\left\langle M, e_{P}\right\rangle$.

By the similar way, if $T, T^{*} T \in B(H)^{\tilde{\phi}}$, then we have

$$
\sum_{n=1}^{\infty}\left\|\left(z_{n} T-T z_{n}\right) \xi\right\|^{2}=\left\langle\left(T^{*} T+\tilde{\phi}\left(T^{*} T\right)-T^{*} \tilde{\phi}(T)-\tilde{\phi}\left(T^{*}\right) T\right) \xi, \xi\right\rangle=0
$$

and hence $T \in\left(\left\{z_{n}\right\}_{n=1}^{\infty}\right)^{\prime}$.
Theorem 2.3. $M^{\prime} \cap B(H)^{\phi}=M^{\prime} \cap\left\langle M, e_{P}\right\rangle=J\left(P^{\prime} \cap M\right) J$.
Proof. For any $x \in M$, we see that

$$
\begin{aligned}
\tau(\phi(J x J)) & =\sum_{n=1}^{\infty}\left\langle J z_{n} x z_{n}^{*} J \xi_{0}, \xi_{0}\right\rangle=\sum_{n=1}^{\infty} \tau\left(z_{n} x^{*} z_{n}^{*}\right) \\
& =\sum_{n=1}^{\infty} \tau\left(x^{*} z_{n}^{*} z_{n}\right)=\tau\left(x^{*}\right)=\tau(J x J) .
\end{aligned}
$$

Moreover we have $\phi\left(M^{\prime}\right) \subseteq M^{\prime}$. Thus $\phi$ is a unital normal completely positive map from $M^{\prime}$ to $M^{\prime}$ which preserves the faithful traicial state. Then by lemma 2.5 in [4] the fixed point space $\left(M^{\prime}\right)^{\phi}=M^{\prime} \cap B(H)^{\phi}$ is a $*$-algebra. Therefore $M^{\prime} \cap B(H)^{\phi}$ is a $*$-subalgebra of $B(H)^{\phi}$. Then by the previous lemma we have $M^{\prime} \cap B(H)^{\phi} \subseteq\left\langle M, e_{P}\right\rangle$.

## 3. RIGIDITY

For any $T \in B(H)$, we set

$$
E(T)=\lim _{n \rightarrow \omega} \frac{1}{n} \sum_{j=1}^{n} \phi^{j}(T), \quad \tilde{E}(T)=\lim _{n \rightarrow \omega} \frac{1}{n} \sum_{j=1}^{n} \tilde{\phi}^{j}(T)
$$

where the limits are taken with respect to the weak operator topology and $\omega$ is some free ultrafilter. Then $E$ is a conditional expectation from $B(H)$ onto $B(H)^{\phi}$ and $\tilde{E}$ is a conditional expectation from $B(H)$ onto $B(H)^{\tilde{\phi}}$. Then $B(H)^{\phi}$ is an AFD von Neumann algebra via the Choi-Effros product $S \circ T=E(S T)$. Here we remark that $S \circ z=S z$ and $z \circ S=z S$ for any $z \in\left\langle M, e_{P}\right\rangle$ because $\left\langle M, e_{P}\right\rangle$ is in the multiplicative domain of $\phi$ and $\phi=i d$ on $\left\langle M, e_{P}\right\rangle$. In particular $x \circ y=x y$ for any $x, y \in\left\langle M, e_{P}\right\rangle$. Similarly, $B(H)^{\tilde{\phi}}$ is an AFD von Neumann algebra via the Choi-Effros product $S \circ T=\tilde{E}(S T)$. (See [5].)

Proposition 3.1. If $P$ is a factor, then $B(H)^{\phi}$ is also a factor via the Choi-Effros product. If $P \subseteq M$ is irreducible, the inclusion $M \subseteq B(H)^{\phi}$ is also irreducible.

Proof. By theorem 2.3, we see that $Z\left(B(H)^{\phi}\right) \subseteq M^{\prime} \cap B(H)^{\phi}=M^{\prime} \cap\left\langle M, e_{P}\right\rangle$. Then we have $Z\left(B(H)^{\phi}\right) \subseteq\left(B(H)^{\phi}\right)^{\prime} \cap\left\langle M, e_{P}\right\rangle \subseteq Z\left(\left\langle M, e_{P}\right\rangle\right)=\mathbb{C}$.

Similarly, if $P^{\prime} \cap M=\mathbb{C}$, then we see that $M^{\prime} \cap B(H)^{\phi}=M^{\prime} \cap\left\langle M, e_{P}\right\rangle=$ $J\left(P^{\prime} \cap M\right) J=\mathbb{C}$.

Lemma 3.2. $e_{P}\left(B(H)^{\phi} \cap B(H)^{\tilde{\phi}}\right) e_{P} \subseteq\left\langle M, e_{P}\right\rangle \cap\left\langle M^{\prime}, e_{P}\right\rangle$.
Proof. Since $\tilde{\phi}\left(e_{P}\right)=e_{P}$ and $\phi \circ \tilde{\phi}=\tilde{\phi} \circ \phi, \tilde{\phi}$ preserves $e_{P} B(H)^{\phi} e_{P}$. For any $T \in e_{P} B(H)^{\phi} e_{P}$, we see that

$$
\omega_{0}(\tilde{\phi}(T))=\omega_{0}(\phi(T))=\omega_{0}(T)
$$

Then for any $S \in\left(e_{P} B(H)^{\phi} e_{P}\right)^{\tilde{\phi}}$, since $S^{*} \circ S=\tilde{\phi}\left(S^{*}\right) \circ \tilde{\phi}(S) \leq \tilde{\phi}\left(S^{*} \circ S\right)$, we have $\omega_{0}\left(S^{*} \circ S\right) \leq \omega_{0}\left(\tilde{\phi}\left(S^{*} \circ S\right)\right)=\omega_{0}\left(S^{*} \circ S\right)$. Here recall that $S^{*} \circ S=E\left(S^{*} S\right)$. Since by lemma $2.1 \omega_{0}$ is faithful on $\left(e_{P} B(H)^{\phi} e_{P}\right)^{\tilde{\tilde{}}} \subseteq e_{P} B(H)^{\phi} e_{P}$, we get $\tilde{\phi}\left(S^{*} \circ S\right)=$ $S^{*} \circ S$. Thus $\left(e_{P} B(H)^{\phi_{j}} e_{P}\right)^{\tilde{\phi}}$ is a von Neumann subalgebra of $B(H)^{\phi}$ via the Choi-Effross product.

Take any projection $p \in\left(e_{P} B(H)^{\phi} e_{P}\right)^{\tilde{\phi}}$. That is, $p \geq 0$ and $p \circ p=p$. We consider that $B(H)^{\phi}$ is a von Neumann subalgebra of $B(K)$. That is, the ChoiEffross producti is compatible with the usual product in $B(K)$. Since $\tilde{\phi}(p)=p$, for any $\xi \in K$ we see that

$$
\begin{aligned}
\sum_{n=1}^{\infty}\left\|p \circ z_{n} \circ(1-p) \xi\right\|^{2} & =\langle\tilde{\phi}(p) \circ(1-p) \xi,(1-p) \xi)\rangle \\
& =\langle p \circ(1-p) \xi,(1-p) \xi)\rangle=0
\end{aligned}
$$

and hence $p \circ z_{n}=z_{n} \circ p$. Since $p \circ z_{n}=p z_{n}$ and $z_{n} \circ p=z_{n} p$, we conclude $p \in\left\{z_{n}\right\}_{n}^{\prime}$. Therefore we have $\left(e_{P} B(H)^{\phi} e_{P}\right)^{\tilde{\phi}} \subseteq\left\{z_{n}\right\}_{n}^{\prime}$. Since $\left(e_{P} B(H)^{\phi} e_{P}\right)^{\tilde{\phi}}=$ $e_{P}\left(B(H)^{\phi} \cap B(H)^{\tilde{\phi}}\right) e_{P}$ and $\left\{z_{n}\right\}_{n}^{\prime}=P^{\prime}=\left\langle M^{\prime}, e_{P}\right\rangle$, we conclude that $e_{P}\left(B(H)^{\phi} \cap\right.$ $\left.B(H)^{\tilde{\phi}}\right) e_{P} \subseteq\left\langle M^{\prime}, e_{P}\right\rangle$.

Similarly we can show that $\left(e_{P} B(H)^{\tilde{\phi}} e_{P}\right)^{\phi} \subseteq\left\{J z_{n} J\right\}^{\prime}$. Since $\left(e_{P} B(H)^{\tilde{\phi}} e_{P}\right)^{\phi}=$ $e_{P}\left(B(H)^{\phi} \cap B(H)^{\tilde{\phi}}\right) e_{P}$ and $\left\{J z_{n} J\right\}_{n}^{\prime}=(J P J)^{\prime}=\left\langle M, e_{P}\right\rangle$, we conclude that $e_{P}\left(B(H)^{\phi} \cap B(H)^{\tilde{\phi}}\right) e_{P} \subseteq\left\langle M, e_{P}\right\rangle$.

Theorem 3.3. Let $\left\langle M, e_{P}\right\rangle \subseteq X \subseteq B(H)^{\phi}$ be a $\left\langle M, e_{P}\right\rangle-\left\langle M, e_{P}\right\rangle$ bimodule and let $\Phi$ be a unital normal linear map from $X$ to $B(H)^{\phi}$ such that $\Phi(x T y)=x \Phi(T) y$ for any $x, y \in\left\langle M, e_{P}\right\rangle$ and $T \in X$. Then $\Phi$ is identity on $X$.

Similarly, let $P e_{P}=e_{P}\left\langle M, e_{P}\right\rangle e_{P} \subseteq X \subseteq e_{P} B(H)^{\phi} e_{P}$ be a $P e_{P}-P e_{P}$ bimodule and let $\Phi$ be a unital normal linear map from $X$ to $e_{P} B(H)^{\phi} e_{P}$ such that $\Phi(x T y)=x \Phi(T) y$ for any $x, y \in P e_{P}$ and $T \in X$. Then $\Phi$ is identity on $X$.

Proof. We remark that by the assumptions $\Phi=i d$ on $\left\langle M, e_{P}\right\rangle$ and $\tilde{\phi} \circ \Phi=\Phi \circ \tilde{\phi}$. For any $T \in X$, we observe that

$$
\begin{aligned}
\left\langle\Phi(T) \xi_{0}, \xi_{0}\right\rangle & =\frac{1}{n} \sum_{j=1}^{n}\left\langle\phi^{j}(\Phi(T)) \xi_{0}, \xi_{0}\right\rangle=\frac{1}{n} \sum_{j=1}^{n}\left\langle\tilde{\phi}^{j}(\Phi(T)) \xi_{0}, \xi_{0}\right\rangle \\
& =\frac{1}{n} \sum_{j=1}^{n}\left\langle\Phi\left(\tilde{\phi}^{j}(T)\right) \xi_{0}, \xi_{0}\right\rangle=\left\langle\Phi(\tilde{E}(T)) \xi_{0}, \xi_{0}\right\rangle \\
& =\left\langle\Phi(\tilde{E}(T)) e_{P} \xi_{0}, e_{P} \xi_{0}\right\rangle=\left\langle\Phi\left(e_{P} \tilde{E}(T) e_{P}\right) \xi_{0}, \xi_{0}\right\rangle
\end{aligned}
$$

Since $T \in B(H)^{\phi}$ and $\phi \circ \tilde{\phi}=\tilde{\phi} \circ \phi$, we have $\tilde{E}(T) \in\left(B(H)^{\phi}\right)^{\tilde{\phi}}=B(H)^{\phi} \cap B(H)^{\tilde{\phi}}$. Then by the previous lemma we see that $e_{P} \tilde{E}(T) e_{P} \in e_{P}\left(B(H)^{\phi} \cap B(H)^{\tilde{\phi}}\right) e_{P} \subseteq$ $\left\langle M, e_{P}\right\rangle$. Since $\Phi=i d$ on $\left\langle M, e_{P}\right\rangle$, we have

$$
\left\langle\Phi(T) \xi_{0}, \xi_{0}\right\rangle=\left\langle e_{P} \tilde{E}(T) e_{P} \xi_{0}, \xi_{0}\right\rangle
$$

Since the identity map satisfies the same assumption as $\Phi$, we also have

$$
\left\langle T \xi_{0}, \xi_{0}\right\rangle=\left\langle e_{P} \tilde{E}(T) e_{P} \xi_{0}, \xi_{0}\right\rangle
$$

and hence

$$
\left\langle\Phi(T) \xi_{0}, \xi_{0}\right\rangle=\left\langle T \xi_{0}, \xi_{0}\right\rangle
$$

Since $X$ is a $\left\langle M, e_{P}\right\rangle-\left\langle M, e_{P}\right\rangle$ bimodule, for any $x, y \in M$ we have $y^{*} T x \in X$ and hence

$$
\left\langle\Phi(T) x \xi_{0}, y \xi_{0}\right\rangle=\left\langle\Phi\left(y^{*} T x\right) \xi_{0}, \xi_{0}\right\rangle=\left\langle y^{*} T x \xi_{0}, \xi_{0}\right\rangle=\left\langle T x \xi_{0}, y \xi_{0}\right\rangle
$$

Therefore we conclude $\Phi(T)=T$.
The rest of the statement can be shown by the same way.
Proposition 3.4. Fix finite elements $\phi_{1}, \phi_{2}, \cdots, \phi_{N} \in G$ such that $\phi_{i} \circ \phi_{j}=\phi_{j} \circ$ $\phi_{i}$. For any positive numbers $\left\{\lambda_{j}\right\}_{j=1}^{N}$ with $\sum_{j=1}^{N} \lambda_{j}=1$, we set $\phi=\sum_{j=1}^{N} \lambda_{j} \phi_{j}$. Then we have $\bigcap_{j=1}^{N} B(H)^{\phi_{j}}=B(H)^{\phi}$.

Proof. There exists elements $z_{n}^{(j)} \in M$ such that $\phi_{j}=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n}^{(j)} J, \sum_{n=1}^{\infty} z_{n}^{(j)} z_{n}^{(j)^{*}}=$ $\sum_{n=1}^{\infty} z_{n}^{(j)^{*}} z_{n}^{(j)}=1$ and $z_{n}^{(j)^{*}}=z_{k}^{(j)}$ for some $k$. Since $\phi=\sum_{n, j} \operatorname{Ad} J\left(\sqrt{\lambda_{j}} z_{n}^{(j)}\right) J$, we have $\phi \in G$. Let $P$ be a von Neumann algebra generated by $\left.\left\{\sqrt{\lambda_{j}} z_{n}^{(j)}\right)\right\}_{n, j}$. Then $P$ is generated by $\left\{z_{n}^{(j)}\right\}_{n, j}$. By theorem 3.3, the inclusion $\left\langle M, e_{P}\right\rangle \subseteq B(H)^{\phi}$ has the rigidity. Since $\left\langle M, e_{P}\right\rangle=(J P J)^{\prime}=\left\{J z_{n}^{(j)} J\right\}_{n, j}^{\prime} \subseteq \bigcap_{j=1}^{N} B(H)^{\phi_{j}}$, each map $\phi_{j}$ is identity on $\left\langle M, e_{P}\right\rangle$. Then since $\phi_{j}\left(B(H)^{\phi}\right) \subseteq B(H)^{\phi}$, by the rigidity $\phi_{j}$ is also identity on $B(H)^{\phi}$. Therefore we conclude that $\bigcap_{j=1}^{N} B(H)^{\phi_{j}}=B(H)^{\phi}$.

Proposition 3.5. Let $\phi=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n} J$ and $\psi=\sum_{n=1}^{\infty} \operatorname{Ad} J w_{n} J$ be elements in $G$ such that $z_{n} w_{m}=w_{m} z_{n}$. We furhter assume that $\sum_{j} z_{n_{j}}=1$ for some $n_{1}<n_{2}<\cdots$. Then we have $B(H)^{\phi} \cap B(H)^{\psi}=B(H)^{\phi \psi}$.

Proof. Let $Q$ be a von Neumann algebra generated by $\left\{z_{n} w_{m}\right\}_{n, m=1}^{\infty}$ and let $P$ be a von Neumann algebra generated by $\left\{z_{n}\right\}_{n=1}^{\infty} \cup\left\{w_{m}\right\}_{m=1}^{\infty}$. Then we have the following inclusions.

$$
\begin{array}{rll}
Q \subseteq P \subseteq M \subseteq & \subseteq\left\langle M, e_{Q}\right\rangle \\
\left.\cap M, e_{P}\right\rangle & \cap & \cap \\
B(H)^{\phi} \cap B(H)^{\psi} & \subseteq B(H)^{\phi \psi}
\end{array}
$$

We claim that $Q=P$. Since $\sum_{j} z_{n_{j}}=1$, we see that $w_{m}=\sum_{j} z_{n_{j}} w_{m} \in Q$. Then we have $Q \ni \sum_{m=1}^{\infty}\left(z_{n} w_{m}\right) w_{m}^{*}=z_{n}$ and hence $Q=P$. Then we also have $\left\langle M, e_{P}\right\rangle=\left\langle M, e_{Q}\right\rangle$. Since $\phi \psi \in G$, the inclusion $\left\langle M, e_{P}\right\rangle=\left\langle M, e_{Q}\right\rangle \subset B(H)^{\phi \psi}$ has the rigidity in the sense of theorem 3.3. Since $\phi\left(B(H)^{\phi \psi}\right) \subseteq B(H)^{\phi \psi}$ and $\phi=i d$ on $\left\langle M, e_{P}\right\rangle$, by the rigidity we get $\phi=i d$ on $B(H)^{\phi \psi}$. By the same reason we also obtain that $\psi=i d$ on $B(H)^{\phi \psi}$ and hence $B(H)^{\phi} \cap B(H)^{\psi}=B(H)^{\phi \psi}$.

In general, $B(H)^{\phi} \cap B(H)^{\psi} \neq B(H)^{\phi \psi}$ even if $\phi, \psi \in G$ and $\phi \circ \psi=\psi \circ \phi$. See corollary 4.12 .

Corollary 3.6. Let $\phi=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n} J$ and $\psi=\sum_{n=1}^{\infty} \operatorname{Ad} J w_{n} J$ be elements in $G$ such that $z_{n} w_{m}=w_{m} z_{n}$. Then we have $B(H)^{\phi^{2}} \cap B(H)^{\psi}=B(H)^{\phi^{2} \psi}$.

Proof. By the definition of $G$, for each $n$ there exists $k(n)$ such that $z_{n}^{*}=z_{k(n)}$. Since $\phi^{2}=\sum_{m, n=1}^{\infty} \operatorname{Ad} J z_{m} z_{n} J$ and $\sum_{n=1}^{\infty} z_{n} z_{k(n)}=\sum_{n=1}^{\infty} z_{n} z_{n}^{*}=1$, the pair $\phi^{2}$ and $\psi$ satisfy the assumptions in the previous proposition. Therefore we have $B(H)^{\phi^{2}} \cap B(H)^{\psi}=B(H)^{\phi^{2} \psi}$.

Lemma 3.7. If $P$ is a factor, then $e_{P}\left(B(H)^{\phi} \cap B(H)^{\tilde{\phi}}\right) e_{P}=\mathbb{C} e_{P}$.
Proof. By lemma 3.2, we have $e_{P}\left(B(H)^{\phi} \cap B(H)^{\tilde{\phi}}\right) e_{P} \subseteq e_{P}\left\langle M, e_{P}\right\rangle \cap\left\langle M^{\prime}, e_{P}\right\rangle e_{P}=$ $P e_{P} \cap J P J e_{P}=Z(P) e_{P}=\mathbb{C} e_{P}$.

Recall that if $P$ is a factor, then by Proposition $3.1 B(H)^{\phi}$ is also a factor.
Theorem 3.8. Assume that $P$ is a factor. If $B(H)^{\phi}$ is a finite factor, then $B(H)^{\phi}=\left\langle M, e_{P}\right\rangle$. If $B(H)^{\phi}$ is a $\mathrm{II}_{\infty}$-factor, then $e_{P} B(H)^{\phi} e_{P}=P e_{P}$.

Proof. If $B(H)^{\phi}$ is a finite factor, then there exists a trace-preserving conditional expectation $F$ from $B(H)^{\phi}$ onto $\left\langle M, e_{P}\right\rangle$. Then by theorem 3.3, we must have $F=i d$ and hence $B(H)^{\phi}=\left\langle M, e_{P}\right\rangle$.

If $B(H)^{\phi}$ is a $\mathrm{II}_{\infty}$-factor, then there exists a faithful normal semifinite tracial weight $T r$. For any positive element $T \in B(H)^{\phi}$ with $0<\operatorname{Tr}(T)<\infty$, we see that

$$
\operatorname{Tr}(T)=\frac{1}{n} \sum_{k=1}^{n} \operatorname{Tr}\left(\tilde{\phi}^{k}(T)\right) .
$$

Take an increasing sequence of finite projections $\left\{P_{j}\right\}_{j=1}^{\infty} \subseteq B(H)^{\phi}$ with $\lim _{j \rightarrow \infty} P_{j}=$ 1. Then we have

$$
\infty>\operatorname{Tr}(T)=\frac{1}{n} \sum_{k=1}^{n} \operatorname{Tr}\left(\tilde{\phi}^{k}(T)\right) \geq \frac{1}{n} \sum_{k=1}^{n} \operatorname{Tr}\left(\tilde{\phi}^{k}(T) P_{j}\right) .
$$

First tending $n \rightarrow \omega$, after that tending $j \rightarrow \infty$, we have

$$
\infty>\operatorname{Tr}(T) \geq \operatorname{Tr}(\tilde{E}(T)) \geq \operatorname{Tr}\left(e_{P} \tilde{E}(T) e_{P}\right)
$$

Since $T \in B(H)^{\phi}$, by the proof of theorem 3.3 we have

$$
\left\langle T \xi_{0}, \xi_{0}\right\rangle=\left\langle e_{P} \tilde{E}(T) e_{P} \xi_{0}, \xi_{0}\right\rangle
$$

Since $T r$ is semifinite, we can take $T$ with $e_{P} T e_{P} \neq 0$. Then since $\omega_{0}$ is faithful on $e_{P} B(H)^{\phi} e_{P}$, we get

$$
0 \neq \omega_{0}\left(e_{P} T e_{P}\right)=\left\langle T \xi_{0}, \xi_{0}\right\rangle=\left\langle e_{P} \tilde{E}(T) e_{P} \xi_{0}, \xi_{0}\right\rangle
$$

In particular we obtain $e_{P} \tilde{E}(T) e_{P} \neq 0$. Since by lemma 3.7

$$
e_{P} \tilde{E}(T) e_{P} \in e_{P}\left(B(H)^{\phi} \cap B(H)^{\tilde{\phi}}\right) e_{P}=\mathbb{C} e_{P}
$$

we have $e_{P} \tilde{E}(T) e_{P}=\lambda e_{P}$ for some number $\lambda>0$. Then we see that

$$
\infty>\operatorname{Tr}(T) \geq \operatorname{Tr}(\tilde{E}(T)) \geq \operatorname{Tr}\left(e_{P} \tilde{E}(T) e_{P}\right)=\lambda \operatorname{Tr}\left(e_{P}\right)
$$

This means that $e_{P}$ is a finite projection in $B(H)^{\phi}$ and hence $e_{P} B(H)^{\phi} e_{P}$ is a finite factor. Then there exists a trace-preserving conditional expectation from $e_{P} B(H)^{\phi} e_{P}$ onto $e_{P}\left\langle M, e_{P}\right\rangle e_{P}=P e_{P}$. Then by theorem 3.3, we conclude $e_{P} B(H)^{\phi} e_{P}=P e_{P}$.

Corollary 3.9. If $P$ is a non- $A F D$ factor, then $B(H)^{\phi}$ is an AFD type III-factor.
Proof. Since $P$ is non-AFD, $\left\langle M, e_{P}\right\rangle$ is also non-AFD. Then since $B(H)^{\phi}$ is AFD, we have $B(H)^{\phi} \neq\left\langle M, e_{P}\right\rangle$. Then by the previous theorem, $B(H)^{\phi}$ is a properly infinite factor. If $B(H)^{\phi}$ is a $\mathrm{II}_{\infty}$-factor, then $e_{P} B(H)^{\phi} e_{P}=P e_{P}$. However since $P e_{P}$ is non-AFD and $e_{P} B(H)^{\phi} e_{P}$ is AFD, this cannot occur and hence $B(H)^{\phi}$ is a type III-factor.

## 4. Some applications to subfactors

Let $\phi=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n} J \in G\left(z_{n} \in M\right)$ such that $\sum_{n=1}^{\infty} z_{n} z_{n}^{*}=\sum_{n=1}^{\infty} z_{n}^{*} z_{n}=1$ and for each $n$, there exists $k$ such that $z_{n}^{*}=z_{k}$. Let $P_{k}$ be a von Neumann algebra generated by $\left\{z_{n_{1}} z_{n_{2}} \cdots z_{n_{k}}\right\}_{n_{1}, n_{2}, \cdots, n_{k}=1}^{\infty}$. Let $e_{k}$ be the Jones projection onto $L^{2}\left(P_{k}, \tau\right)$. We remark that $\phi^{k}=\sum_{n_{1}, n_{2}, \cdots, n_{k}=1}^{\infty} \operatorname{Ad} J z_{n_{1}} z_{n_{2}} \cdots z_{n_{k}} J \in G$. Then we have the following inclusions.

$$
\begin{array}{r}
P_{m k} \subseteq P_{k} \subseteq M \subseteq\left\langle M, e_{k}\right\rangle \subseteq\left\langle M, e_{m k}\right\rangle \\
\cap \cap \cap^{\phi^{k}} \subseteq B(H)^{\phi^{m k}}
\end{array}
$$

We further assume that $P_{2}^{\prime} \cap P_{1}=\mathbb{C}$ and $P_{2} \neq P_{1}$.
Lemma 4.1. The inclusion $B(H)^{\phi^{k}} \subseteq B(H)^{\phi^{m k}}$ is isomorphic to an inclusion of von Neumann algebras as operator systems. That is, both $B(H)^{\phi^{k}}$ and $B(H)^{\phi^{m k}}$ have the same product as von Neumann algebras.

Proof. This is a consequence of the Bhat dilation [1, 3] and the Prunaru theorem [9]. By the Bhat dilation, we have a Hilbert space $K \supset H$ and a unital normal *endmorphism $\alpha$ on $B(K)$ such that $e_{H} \alpha^{n}(T) e_{H}=\phi^{n}(T)$ for any $T \in B(H)$, where $e_{H}$ is a projection onto $H$. Then by the Prunaru theorem, $e_{H} B(K)^{\alpha^{k}} e_{H}=B(H)^{\phi^{k}}$ and $e_{H} B(K)^{\alpha^{k}} e_{H} \subseteq e_{H} B(K)^{\alpha^{m k}} e_{H} \simeq B(K)^{\alpha^{k}} \subseteq B(K)^{\alpha^{m k}}$ as operator systems.

Lemma 4.2. The inclusion $B(H)^{\phi} \subseteq B(H)^{\phi^{2}}$ is irreducible.
Proof. By theorem 2.3, we have $M^{\prime} \cap B(H)^{\phi}=M^{\prime} \cap\left\langle M, e_{1}\right\rangle$ and $M^{\prime} \cap B(H)^{\phi^{2}}=$ $M^{\prime} \cap\left\langle M, e_{2}\right\rangle$. Then we have $B(H)^{\phi^{\prime}} \cap B(H)^{\phi^{2}}=B(H)^{\phi^{\prime}} \cap M^{\prime} \cap B(H)^{\phi^{2}}=$ $B(H)^{\phi^{\prime}} \cap M^{\prime} \cap\left\langle M, e_{2}\right\rangle \subseteq\left\langle M, e_{1}\right\rangle^{\prime} \cap\left\langle M, e_{2}\right\rangle=J P_{2}^{\prime} \cap P_{1} J=\mathbb{C}$.

Lemma 4.3. We set $F(T)=\frac{1}{2}(T+\phi(T))$. Then $F$ is a normal conditional expectation from $B(H)^{\phi^{2}}$ onto $B(H)^{\phi}$. Moreover $F\left(\left\langle M, e_{2}\right\rangle\right) \subseteq\left\langle M, e_{1}\right\rangle$.

Proof. The first statement is obvious. We will show that $F\left(\left\langle M, e_{2}\right\rangle\right) \subseteq\left\langle M, e_{1}\right\rangle$. For any $T \in\left\langle M, e_{2}\right\rangle=\left(\left\{J z_{n_{1}} z_{n_{2}} J\right\}_{n_{1}, n_{2}=1}^{\infty}\right)^{\prime}$, we see that
$J z_{k} J \phi(T)=\sum_{n=1}^{\infty} J z_{k} z_{n} J T J z_{n}^{*} J=\sum_{n=1}^{\infty} T\left(J z_{k} z_{n} J\right) J z_{n}^{*} J=T J z_{k} J \sum_{n=1}^{\infty} J z_{n} z_{n}^{*} J=T J z_{k} J$.
Since both $\left\langle M, e_{2}\right\rangle$ and $\left\{z_{n}\right\}_{n=1}^{\infty}$ are closed under the $*$-operation, we also have $J z_{k} J T=\phi(T) J z_{k} J$. Then we have $J z_{k} J F(T)=F(T) J z_{k} J$ and hence $F(T) \in$ $\left(\left\{J z_{n} J\right\}_{n=1}^{\infty}\right)^{\prime}=\left\langle M, e_{1}\right\rangle$

Recall that an irreducible subfactor has a unique normal conditional expectation if it exists. Since the inclusions $\left\langle M, e_{1}\right\rangle \subseteq\left\langle M, e_{2}\right\rangle$ and $B(H)^{\phi} \subseteq B(H)^{\phi^{2}}$ are irreducible, they have the unique conditional expectation $F$.

Proposition 4.4. $\left[P_{2}: P_{1}\right]=\left[B(H)^{\phi^{2}}: B(H)^{\phi}\right]=2$.
Proof. For any positive element $T \in B(H)^{\phi^{2}}$, we have $F(T)=\frac{1}{2}(T+\phi(T)) \geq \frac{1}{2} T$. Therefore by the Pimsner-Popa theorem [7, 8], both $\left[P_{2}: P_{1}\right]$ and $\left[B(H)^{\phi^{2}}\right.$ : $\left.B(H)^{\phi}\right]$ are equal to either 1 or 2 . Since $P_{1} \neq P_{2}$, we have $\left[P_{2}: P_{1}\right]=2$. We assume that $B(H)^{\phi^{2}}=B(H)^{\phi}$. By lemma $2.2,\left\langle M, e_{1}\right\rangle$ is a maximum $*$-subalgebra of $B(H)^{\phi}$ and $\left\langle M, e_{2}\right\rangle$ is a maximum $*$-subalgebra of $B(H)^{\phi^{2}}$. Therefore we get $\left\langle M, e_{1}\right\rangle=\left\langle M, e_{2}\right\rangle$ and hence $P_{1}=P_{2}$. Since $P_{1} \neq P_{2}$, we conclude that $B(H)^{\phi^{2}} \neq B(H)^{\phi}$ and $\left[B(H)^{\phi^{2}}: B(H)^{\phi}\right]=2$.

Proposition 4.5. Let $\left\{m_{i}\right\}_{i=1}^{n} \subset\left\langle M, e_{2}\right\rangle$ be a Pimsner-Popa basis of the inclusion $\left\langle M, e_{1}\right\rangle \subset\left\langle M, e_{2}\right\rangle$. That is, for any $x \in\left\langle M, e_{2}\right\rangle$, we have $x=\sum_{i=1}^{n} m_{i} F\left(m_{i}^{*} x\right)$. Then for any $T \in B(H)^{\phi^{2}}$, we also have $T=\sum_{i=1}^{n} m_{i} F\left(m_{i}^{*} T\right)$.

Proof. Let

$$
\Phi(T)=\frac{1}{2} \sum_{i . j=1}^{n} m_{i} F\left(m_{i}^{*} T m_{j}\right) m_{j}^{*} .
$$

Then $\Phi$ is a normal unital completely positive map on $B(H)^{\phi^{2}}$. Moreover for any $x \in\left\langle M, e_{2}\right\rangle$, we have

$$
\Phi(x)=\frac{1}{2} \sum_{j=1}^{n}\left\{\sum_{i=1}^{n} m_{i} F\left(m_{i}^{*} x m_{j}\right)\right\} m_{j}^{*}=\frac{1}{2} \sum_{j=1}^{n} x m_{j} m_{j}^{*}=x .
$$

Here we used the fact that $\sum_{i=1}^{n} m_{i} m_{i}^{*}=\left[\left\langle M, e_{2}\right\rangle:\left\langle M, e_{1}\right\rangle\right]=2$. Then by theorem 3.3, we have $\Phi=i d$ on $B(H)^{\phi^{2}}$. For any positive element $T \in B(H)^{\phi^{2}}$, since $\left(F\left(m_{i}^{*} T m_{j}\right)\right)_{i, j} \geq \frac{1}{2}\left(m_{i}^{*} T m_{j}\right)_{i, j}$, we observe that

$$
\begin{aligned}
T & =\Phi(T)=\frac{1}{2}\left(m_{1}, \cdots, m_{n}\right) \times\left(F\left(m_{i}^{*} T m_{j}\right)\right)_{i, j} \times\left(m_{1}, \cdots, m_{n}\right)^{*} \\
& \geq \frac{1}{2}\left(m_{1}, \cdots, m_{n}\right) \times \frac{1}{2}\left(m_{i}^{*} T m_{j}\right)_{i, j} \times\left(m_{1}, \cdots, m_{n}\right)^{*}=T
\end{aligned}
$$

Then we obtain

$$
\left\{\left(F\left(m_{i}^{*} T m_{j}\right)\right)_{i, j}-\frac{1}{2}\left(m_{i}^{*} T m_{j}\right)_{i, j}\right\} \times\left(m_{1}, \cdots, m_{n}\right)^{*}=(0, \cdots, 0)^{*}
$$

and hence

$$
\sum_{j=1}^{n} F\left(m_{i}^{*} T m_{j}\right) m_{j}^{*}=m_{i}^{*} T .
$$

Then for any element $S \in B(H)^{\phi^{2}}$,

$$
\sum_{j=1}^{n} F\left(m_{i}^{*} S m_{j}\right) m_{j}^{*}=m_{i}^{*} S
$$

By letting $S=F\left(m_{i}\right) T$, we have

$$
\sum_{j=1}^{n} F\left(m_{i}^{*} F\left(m_{i}\right) T m_{j}\right) m_{j}^{*}=m_{i}^{*} F\left(m_{i}\right) T
$$

and hence

$$
\sum_{j=1}^{n} F\left(\left\{\sum_{i=1}^{n} m_{i}^{*} F\left(m_{i}\right)\right\} T m_{j}\right) m_{j}^{*}=\left\{\sum_{i=1}^{n} m_{i}^{*} F\left(m_{i}\right)\right\} T .
$$

Let $e$ be the Jones projection of the subfactor $\left\langle M, e_{1}\right\rangle \subset\left\langle M, e_{2}\right\rangle$. Then there exists a Pimsner-Popa basis $\left\{n_{i}\right\}_{i} \subset\left\langle M, e_{2}\right\rangle$ of the inclusion $\left\langle M, e_{1}\right\rangle \subset\left\langle M, e_{2}\right\rangle$ such that $n_{1}=1$ and $(1-e) n_{i} e=0$ for $i \geq 2$. Since $F\left(n_{i}\right) e=e n_{i} e$, we have $F\left(n_{i}\right)=0$ for $i \geq 2$. By the above argument we have

$$
\sum_{j=1}^{m} F\left(\left\{\sum_{i=1}^{n} n_{i}^{*} F\left(n_{i}\right)\right\} T n_{j}\right) n_{j}^{*}=\left\{\sum_{i=1}^{m} n_{i}^{*} F\left(n_{i}\right)\right\} T .
$$

Then since $\sum_{i=1}^{n} n_{i}^{*} F\left(n_{i}\right)=1$, we obtain $\sum_{j=1}^{m} F\left(T n_{j}\right) n_{j}^{*}=T$. Since $m_{i}=$ $\sum_{j=1}^{m} n_{j} F\left(n_{j}^{*} m_{i}\right)$, we complute

$$
\begin{aligned}
\sum_{i=1}^{n} F\left(T m_{i}\right) m_{i}^{*} & =\sum_{i=1}^{n} \sum_{j, k=1}^{m} F\left(T n_{j}\right) F\left(n_{j}^{*} m_{i}\right) F\left(m_{i}^{*} n_{k}\right) n_{k}^{*} \\
& =\sum_{j, k=1}^{m} F\left(T n_{j}\right) F\left(n_{j}^{*} \sum_{i=1}^{n} m_{i} F\left(m_{i}^{*} n_{k}\right)\right) n_{k}^{*} \\
& =\sum_{j, k=1}^{m} F\left(T n_{j}\right) F\left(n_{j}^{*} n_{k}\right) n_{k}^{*}=\sum_{j=1}^{m} F\left(T n_{j}\right) n_{j}^{*}=T .
\end{aligned}
$$

Lemma 4.6. For any $k$, we have $P_{2 k}=P_{2}$ and $P_{2 k+1}=P_{1}$.
Proof. We have only to show that $P_{2} \subseteq P_{2 k}$ and $P_{1} \subseteq P_{2 k+1}$. We observe that

$$
P_{2} \ni z_{n_{1}} z_{n_{2}}=\sum_{p_{1}, \cdots, p_{k-1}=1}^{\infty} z_{n_{1}} z_{n_{2}}\left(z_{p_{1}} z_{p_{1}}{ }^{*}\right) \cdots\left(z_{p_{k-1}} z_{p_{k-1}}{ }^{*}\right) \in P_{2 k} .
$$

Thus we have $P_{2} \subseteq P_{2 k}$. Similarly we see that $P_{1} \subseteq P_{2 k+1}$.

Proposition 4.7. $B(H)^{\phi^{2 k}}=B(H)^{\phi^{2}}$ and $B(H)^{\phi^{2 k+1}}=B(H)^{\phi}$.
Proof. By the previous lemma, we have $P_{2 k}=P_{2}$. Then we have the inclusions

\begin{array}{r}
P_{2 k}=P_{2} \subseteq M \subseteq\left\langle M, e_{2}\right\rangle=\left\langle M, e_{2 k}\right\rangle \\
\cap \\
B(H)^{\phi^{2}} \subseteq B(H)^{\phi^{2 k}}
\end{array}
$$

We have a normal conditional expectation

$$
F(T)=\frac{1}{k}\left(T+\phi^{2}(T)+\cdots+\phi^{2(k-1)}\right)
$$

from $B(H)^{\phi^{2 k}}$ onto $B(H)^{\phi^{2}}$. Then by theorem 3.3, we have $F=i d$ and hence $B(H)^{\phi^{2 k}}=B(H)^{\phi^{2}}$. By the same way, we can see that $B(H)^{\phi^{2 k+1}}=B(H)^{\phi}$.

Next we consider two completely positive maps $\phi=\sum_{n=1}^{\infty} \operatorname{Ad} J z_{n} J \in G\left(z_{n} \in\right.$ $M)$ and $\psi=\sum_{m=1}^{\infty} \operatorname{Ad} J w_{m} J \in G\left(w_{m} \in M\right)$ such that $\sum_{n=1}^{\infty} z_{n} z_{n}^{*}=\sum_{n=1}^{\infty} z_{n}^{*} z_{n}=$ $\sum_{m=1}^{\infty} w_{m} w_{m}^{*}=\sum_{m=1}^{\infty} w_{m}^{*} w_{m}=1$ and both $\left\{z_{n}\right\}_{n=1}^{\infty}$ and $\left\{w_{m}\right\}_{m=1}^{\infty}$ are *-closed sets. We also assume that $z_{n} w_{m}=w_{m} z_{n}$ for any $n, m$. Thus we have $\phi \circ \psi=\psi \circ \phi$. Let $P_{1}$ and $P_{2}$ be von Neumann algebras generated by $\left\{z_{n}\right\}_{n=1}^{\infty}$ and $\left\{z_{n_{1}} z_{n_{2}}\right\}_{n_{1}, n_{2}=1}^{\infty}$ respectively. Similarly, let $Q_{1}$ and $Q_{2}$ be von Neumann algebras generated by $\left\{w_{m}\right\}_{m=1}^{\infty}$ and $\left\{w_{m_{1}} w_{m_{2}}\right\}_{m_{1}, m_{2}=1}^{\infty}$ respectively. We further assume that $P_{2}^{\prime} \cap P_{1}=$
$Q_{2}{ }^{\prime} \cap Q_{1}=\mathbb{C}, P_{2} \neq P_{1}$ and $Q_{2} \neq Q_{1}$. Let $e_{1}$ and $e_{2}$ be the Jones projection onto $L^{2}\left(P_{1} \vee Q_{1}, \tau\right)$ and $L^{2}\left(P_{2} \vee Q_{2}, \tau\right)$ respectively. We remark that $P_{1} \vee Q_{1} \simeq P_{1} \otimes Q_{1}$ and $P_{2} \vee Q_{2} \simeq P_{2} \otimes Q_{2}$. Then we have the following inclusions.

$$
\begin{aligned}
& P_{2} \vee Q_{2} \subseteq P_{1} \vee Q_{1} \subseteq M \subseteq \begin{array}{ll}
\left\langle M, e_{1}\right\rangle & \subseteq
\end{array} \quad\left\langle M, e_{2}\right\rangle \\
& \\
& B(H)^{\phi} \cap B(H)^{\psi}
\end{aligned} \subseteq
$$

Here we remark that by proposition 3.4 and corollary 3.6, we have $B(H)^{\phi} \cap$ $B(H)^{\psi}=B(H)^{\frac{1}{2}(\phi+\psi)}$ and $B(H)^{\phi^{2}} \cap B(H)^{\psi^{2}}=B(H)^{\phi^{2} \psi^{2}}$.

Lemma 4.8. The inclusions $B(H)^{\phi} \cap B(H)^{\psi} \subseteq B(H)^{\phi \psi} \subseteq B(H)^{\phi^{2} \psi^{2}}$ is isomorphic to inclusions of von Neumann algebras as operator systems.

Proof. Since $\phi \circ \psi=\psi \circ \phi, \phi$ and $\psi$ can be dilated simultaneously [2, 10]. Then by the Prunaru theorem [9], we are done.

Lemma 4.9. The inclusion $B(H)^{\phi} \cap B(H)^{\psi} \subseteq B(H)^{\phi^{2} \psi^{2}}$ is irreducible.
Proof. By theorem 2.3, we have $M^{\prime} \cap B(H)^{\phi^{2} \psi^{2}}=M^{\prime} \cap\left\langle M, e_{2}\right\rangle$. Then we have $\left(B(H)^{\phi} \cap B(H)^{\psi}\right)^{\prime} \cap B(H)^{\phi^{2} \psi^{2}}=\left(B(H)^{\phi} \cap B(H)^{\psi}\right)^{\prime} \cap M^{\prime} \cap B(H)^{\phi^{2} \psi^{2}}=\left(B(H)^{\phi} \cap\right.$ $\left.B(H)^{\psi}\right)^{\prime} \cap M^{\prime} \cap\left\langle M, e_{2}\right\rangle \subseteq\left\langle M, e_{1}\right\rangle^{\prime} \cap\left\langle M, e_{2}\right\rangle=J\left(P_{2} \vee Q_{2}\right)^{\prime} \cap\left(P_{1} \vee Q_{1}\right) J=\mathbb{C}$.

Lemma 4.10. We set $F(T)=\frac{1}{4}(T+\phi(T)+\psi(T)+\phi \circ \psi(T))$. Then $F$ is a normal conditional expectation from $B(H)^{\phi^{2} \psi^{2}}$ onto $B(H)^{\phi} \cap B(H)^{\psi}$. Moreover $F\left(\left\langle M, e_{2}\right\rangle\right) \subseteq\left\langle M, e_{1}\right\rangle$.

Proof. Since $B(H)^{\phi^{2}} \cap B(H)^{\psi^{2}}=B(H)^{\phi^{2} \psi^{2}}$, the first statement is obvious. We will show that $F\left(\left\langle M, e_{2}\right\rangle\right) \subseteq\left\langle M, e_{1}\right\rangle$. We remark that

$$
F(T)=\left(\frac{i d+\phi}{2}\right) \circ\left(\frac{i d+\psi}{2}\right)(T)=\left(\frac{i d+\psi}{2}\right) \circ\left(\frac{i d+\phi}{2}\right)(T)
$$

For any $T \in\left\langle M, e_{2}\right\rangle=\left(\left\{J z_{n_{1}} z_{n_{2}} J\right\}_{n_{1}, n_{2}=1}^{\infty}\right)^{\prime} \cap\left(\left\{J w_{m_{1}} w_{m_{2}} J\right\}_{m_{1}, m_{2}=1}^{\infty}\right)^{\prime}$, since $\left(\frac{i d+\psi}{2}\right)(T) \in$ $\left(\left\{J z_{n_{1}} z_{n_{2}} J\right\}_{n_{1}, n_{2}=1}^{\infty}\right)^{\prime}$, by the proof of lemma 4.3, we have $J z_{k} J F(T)=F(T) J z_{k} J$. Similarly we have $J w_{k} J F(T)=F(T) J w_{k} J$ and hence $F\left(\left\langle M, e_{2}\right\rangle\right) \subseteq\left\langle M, e_{1}\right\rangle$.

Proposition 4.11. $\left[P_{1} \vee Q_{1}: P_{2} \vee Q_{2}\right]=\left[B(H)^{\phi^{2} \psi^{2}}: B(H)^{\phi} \cap B(H)^{\psi}\right]=4$.
Proof. By proposition 4.4, we have $\left[P_{1}: P_{2}\right]=\left[Q_{1}: Q_{2}\right]=2$ and hence $\left[P_{1} \vee Q_{1}\right.$ : $\left.P_{2} \vee Q_{2}\right]=4$. For any positive element $T \in B(H)^{\phi^{2} \psi^{2}}$, since $F(T) \geq \frac{1}{4} T$, by the Pimsner-Popa theorem [7, 8] we have $\left[B(H)^{\phi^{2} \psi^{2}}: B(H)^{\phi} \cap B(H)^{\psi}\right] \leq 4$. On the other hand, for any positive element $x \in\left\langle M, e_{2}\right\rangle \subseteq B(H)^{\phi^{2} \psi^{2}}$, we have $F(x) \geq \frac{1}{\left[B(H)^{\left.\phi^{2} \psi^{2}: B(H)^{\phi} \cap B(H)^{\psi}\right]} x \text {. Since }\left[\left\langle M, e_{2}\right\rangle:\left\langle M, e_{2}\right\rangle\right]=\left[P_{1} \vee Q_{1}: ~ .: ~\right.\right.}$
$\left.P_{2} \vee Q_{2}\right]=4$, we have $\frac{1}{4} \geq \frac{1}{\left[B(H)^{\phi^{2} \psi^{2}}: B(H)^{\phi} \cap B(H)^{\psi}\right]}$ and hence $\left[B(H)^{\phi^{2} \psi^{2}}:\right.$ $\left.B(H)^{\phi} \cap B(H)^{\psi}\right] \geq 4$. Therefore we have $\left[B(H)^{\phi^{2} \psi^{2}}: B(H)^{\phi} \cap B(H)^{\psi}\right]=4$.

Corollary 4.12. $B(H)^{\phi} \cap B(H)^{\psi} \neq B(H)^{\phi \psi}$.
Proof. Let $F_{0}(T)=\frac{1}{2}(T+\phi \psi(T))$. Then $F_{0}$ is a normal conditional expectation from $B(H)^{\phi^{2} \psi^{2}}$ onto $B(H)^{\phi \psi}$. Then for any positive $T \in B(H)^{\phi^{2} \psi^{2}}$, we have $F_{0}(T) \geq \frac{1}{2} T$ and hence $\left[B(H)^{\phi^{2} \psi^{2}}: B(H)^{\phi \psi}\right] \leq 2$. Since $B(H)^{\phi} \cap B(H)^{\psi} \subseteq$ $B(H)^{\phi \psi} \subseteq B(H)^{\phi^{2} \psi^{2}}$ and $\left[B(H)^{\phi^{2} \psi^{2}}: B(H)^{\phi} \cap B(H)^{\psi}\right]=4$, we conclude $B(H)^{\phi} \cap$ $B(H)^{\psi} \neq B(H)^{\phi \psi}$.

Example. Let $\mathbb{F}_{2}$ be a free group with two generators $a$ and $b$. Let $A$ be a subgroup generated by $a b$ and $a b^{-1}$. Then $A$ consists of reduced words with even length. Set $M=L\left(\mathbb{F}_{2}\right), H=L^{2}\left(\mathbb{F}_{2}\right)$ and $\phi=\frac{1}{4}\left(\operatorname{Ad} J a J+\operatorname{Ad} J b J+\operatorname{Ad} J a^{-1} J+\right.$ $\left.\operatorname{Ad} J b^{-1} J\right) \in G$. In this case, $P_{1}=L\left(\mathbb{F}_{2}\right)=M$ and $P_{2}=L(A)$. Since $\left[\mathbb{F}_{2}: A\right]=2$, we have $\left[P_{1}: P_{2}\right]=2$ and $P_{2}^{\prime} \cap P_{1}=\mathbb{C}$. We have the following inclusions.

$$
P_{2} \subseteq P_{1}=\begin{array}{ccc}
M & \subseteq\left\langle M, e_{2}\right\rangle \\
& \cap & \cap \\
& B(H)^{\phi} & \subseteq B(H)^{\phi^{2}}
\end{array}
$$

Then the subfactor $B(H)^{\phi} \subseteq B(H)^{\phi^{2}}$ is AFD type III with index 2. The subfactors $M \subseteq\left\langle M, e_{2}\right\rangle$ and $B(H)^{\phi} \subseteq B(H)^{\phi^{2}}$ have a common Pimsner-Popa basis. Moreover two inclusions $M \subset B(H)^{\phi}$ and $\left\langle M, e_{2}\right\rangle \subset B(H)^{\phi^{2}}$ have the rigidity property in the sence of theorem 3.3.

Next we consider two unital normal completely positive maps $\phi \otimes i d$ and $i d \otimes \phi$ on $B(H \otimes H)$. Then by corollary 4.12, we have $B(H \otimes H)^{\phi \otimes i d} \cap B(H \otimes H)^{i d \otimes \phi} \neq$ $B(H \otimes H)^{\phi \otimes \phi}$.
