BOUNDING THE ZEROS OF POLYNOMIALS USING THE FROBENIUS COMPANION MATRIX PARTITIONED BY THE CARTESIAN DECOMPOSITION

ABSTRACT. In this work, some new inequalities for the numerical radius of block *n*-by-*n* matrices are presented. As an application, bounding of zeros of polynomials using the Frobenius companion matrix partitioned by the Cartesian decomposition method is proved and affirmed by several numerical examples showing that our approach of bounding zeros of polynomials could be very effective in comparison with the most famous and some recent results presented in the field.

1. INTRODUCTION

Let \mathscr{H} be a complex Hilbert space with an inner product $\langle \cdot, \cdot \rangle$ and $\mathscr{B}(\mathscr{H})$ be the C^* -algebra of all bounded linear operators from \mathscr{H} into itself. When $\mathscr{H} = \mathbb{C}^n$, we identify $\mathscr{B}(\mathscr{H})$ with the algebra \mathscr{M}_n of *n*-by-*n* complex matrices. For a bounded linear operator T on a Hilbert space \mathscr{H} , the numerical range W(T) is the image of the unit sphere of \mathscr{H} under the quadratic form $x \to \langle Tx, x \rangle$ associated with the operator. More precisely,

$$W(T) = \{ \langle Tx, x \rangle : x \in \mathscr{H}, ||x|| = 1 \}.$$

Also, the numerical radius is defined to be

$$w(T) = \sup\left\{ |\lambda| : \lambda \in W(T) \right\} = \sup_{\|x\|=1} |\langle Tx, x \rangle|.$$

The spectral radius of an operator T is defined to be

$$r(T) = \sup\{|\lambda| : \lambda \in \operatorname{sp}(T)\}.$$

We recall that, the usual operator norm of an operator T is defined to be

$$||T|| = \sup \{ ||Tx|| : x \in H, ||x|| = 1 \},\$$

Several numerical radius type inequalities improving and refining the inequality

$$\frac{1}{2} \|S\| \le w(S) \le \|S\| \qquad (S \in \mathscr{B}(\mathscr{H}))$$

have been recently obtained by many other authors see for example [3]–[6], and [11]. Four important facts concerning the numerical radius inequalities of $n \times n$ operator matrices are obtained by different authors which are grouped together, as follows:

Let $\mathbf{S} = [S_{ij}] \in \mathscr{B}(\bigoplus_{i=1}^{n} \mathscr{H}_i)$ such that $S_{ij} \in \mathscr{B}(\mathscr{H}_j, \mathscr{H}_i)$. Then

$$w\left(\mathbf{S}\right) \leq \begin{cases} w\left(\left[t_{kj}^{(1)}\right]\right), & \text{Hou \& Du in [11]} \\ w\left(\left[t_{kj}^{(2)}\right]\right), & \text{BaniDomi \& Kittaneh in [6]} \\ & w\left(\left[t_{kj}^{(3)}\right]\right), & \text{AbuOmar \& Kittaneh in [3]} \\ & w\left(\left[t_{kj}^{(4)}\right]\right), & \text{AbuOmar \& Kittaneh in [3]} \end{cases}$$

where

$$\begin{split} t_{kj}^{(1)} &= w\left([\|S_{kj}\|]\right); \qquad t_{kj}^{(2)} = \begin{cases} \frac{1}{2} \left(\|S_{kj}\| + \left\|S_{kj}^2\right\|^{1/2}\right), & k = j \\ \|S_{kj}\|, & k \neq j \end{cases}; \\ t_{kj}^{(3)} &= \begin{cases} w\left(S_{kj}\right), & k = j \\ \|S_{kj}\|, & k \neq j \end{cases}; \qquad t_{kj}^{(4)} = \begin{cases} w\left(T_{kj}\right), & k = j \\ w\left(T_{kj}\right), & k = j \\ w\left(T_{kj}\right), & k = j \end{cases}; \\ w\left(T_{kj}\right), & k = j \end{cases}; \end{split}$$

Clearly, the third and fourth bounds above are gentle refinements of the first and second bounds, and therefore both $w\left(\begin{bmatrix} t_{kj}^{(3)} \\ kj \end{bmatrix}\right)$ and $w\left(\begin{bmatrix} t_{kj}^{(4)} \\ kj \end{bmatrix}\right)$ gives better upper estimates for the numerical radius of $\mathbf{S} = [S_{ij}]$.

Let T_n be the tridiagonal Toeplitz matrix denoted by $T_n = \text{tridiag}(b, a, c)$; i.e.,

$$T_{n} := \begin{bmatrix} a & c & 0 & \cdots & 0 \\ b & a & c & \ddots & \vdots \\ 0 & b & \ddots & \ddots & 0 \\ \vdots & \ddots & \ddots & \ddots & c \\ 0 & \cdots & 0 & b & a \end{bmatrix}_{n \times n}, \qquad n \ge 2$$

It is well known that the eigenvalues of T_n are given by [18]:

$$\lambda_k = a + 2\sqrt{|bc|} \cos\left(\frac{k\pi}{n+1}\right), \qquad k = 1, 2, \cdots, n$$

and it have the polar form

$$\lambda_k = a + 2\sqrt{|bc|e^{i(\theta+\phi)/2}\cos\left(\frac{k\pi}{n+1}\right)}, \qquad k = 1, 2, \cdots, n$$

where $\theta = \arg(b)$ and $\phi = \arg(c)$. In case that, $bc \neq 0$, then T_n has n simple eigenvalues, all of them lie in the closed segment

$$S_{n,\lambda} = \left\{ a + t e^{i(\theta + \phi)/2} : t \in \mathbb{R}, |t| \le 2\sqrt{|bc|} \cos\left(\frac{\pi}{n+1}\right) \right\} \subset \mathbb{C}$$

The eigenvalues are located symmetrically with respect to a. Thus, the spectral radius of T_n is given by

(1.1)
$$r(T_n) = \max\left\{ \left| a + 2\sqrt{|bc|} e^{i(\theta+\phi)/2} \cos\left(\frac{\pi}{n+1}\right) \right|, \left| a + 2\sqrt{|bc|} e^{i(\theta+\phi)/2} \cos\left(\frac{n\pi}{n+1}\right) \right| \right\}$$

Moreover, if $bc \neq 0$, then the eigenvectors $x_k = [x_{1,n}, x_{2,n}, \cdots, x_{k,n}]^T$ associated with the eigenvalue λ_k of T_n are given in the form $x_{k,j} = \left(\frac{c}{b}\right)^{k/2} \sin\left(\frac{kj\pi}{n+1}\right), k, j = 1, 2, \cdots, n$. For comprehensive study about Toeplitz matrices the reader may refer to the interesting book [7].

The following result is of great interest in the next presented results [18].

Lemma 1. The tridiagonal Toeplitz matrix T_n = tridiag(b, a, c) is normal (i.e., $T_n^*T_n = T_nT_n^*$) if and only if |b| = |c|.

Lemma 2. Let \mathscr{H}_1 and \mathscr{H}_2 be Hilbert spaces, and $\mathbf{T} = \begin{bmatrix} A & B \\ C & D \end{bmatrix}$ be an operator matrix with $A \in \mathscr{B}(\mathscr{H}_1)$, $B \in \mathscr{B}(\mathscr{H}_2, \mathscr{H}_1)$, $C \in \mathscr{B}(\mathscr{H}_1, \mathscr{H}_2)$ and $D \in \mathscr{B}(\mathscr{H}_2)$. Then

$$\omega(\mathbf{T}) \le \frac{1}{2} \left(\omega(A) + \omega(D) + \sqrt{(\omega(A) - \omega(D))^2 + (\|B\| + \|C\|)^2} \right).$$

Lemma 3. If $S := [s_{kj}] \in \mathscr{M}_n(\mathbb{C})$, then

$$\omega(S) \le \omega([|s_{kj}|]) = \frac{1}{2}r([|s_{kj}| + [|s_{kj}|]])$$

Let $A \in \mathscr{B}(\mathscr{H})$, then

$$\left|\left\langle Ax,y\right\rangle\right|^{2} \leq \left\langle \left|A\right|^{2\alpha}x,x\right\rangle \left\langle \left|A^{*}\right|^{2(1-\alpha)}y,y\right\rangle, \qquad 0\leq\alpha\leq1$$

for any vectors $x, y \in \mathscr{H}$, where $|A| = (A^*A)^{1/2}$. This inequality is well-known as the mixed Schwarz inequality which was introduced in [13] and generalized later in [15].

The following result presents the Cartesian decomposition of the mixed Schwarz inequality [5].

Lemma 4. Let $A \in \mathscr{B}(\mathscr{H})$ with the Cartesian decomposition A = P + iQ. If f and g are nonnegative continuous functions on $[0, \infty)$ satisfying f(t)g(t) = t $(t \ge 0)$, then

$$\left|\left\langle Ax,y\right\rangle\right| \le \left\|f\left(\left|P\right|\right)x\right\| \left\|g\left(\left|P\right|\right)y\right\| + \left\|f\left(\left|Q\right|\right)x\right\| \left\|g\left(\left|Q\right|\right)y\right\|$$

for all $x, y \in \mathcal{H}$.

2. Numerical radius inequalities of $m \times m$ matrix operator

Theorem 1. Let $\mathbf{A} = [A_{kj}] \in \bigoplus_m \mathscr{M}_n(\mathbb{C})$ be an $m \times m$ operator such that $P_{kj} + iQ_{kj}$ is the corresponding Cartesian decomposition of A_{kj} . If f and g are nonnegative continuous functions on $[0, \infty)$ satisfying f(t)g(t) = t $(t \ge 0)$, then

(2.1)
$$w(\mathbf{A}) \le w^{1/2}([c_{kj}])$$

where

$$c_{kj} = m \cdot \begin{cases} w \left(P_{kk}^2 + Q_{kk}^2 \right), & j = k \\ \frac{1}{4} \left\| f^2 \left(|P_{kj}| \right) + g^2 \left(|P_{kj}| \right) + f^2 \left(|Q_{kj}| \right) + g^2 \left(|Q_{kj}| \right) \right\|^2, & j \neq k. \end{cases}$$

Proof. Let $x = \begin{bmatrix} x_1 & x_2 & \cdots & x_m \end{bmatrix}^T \in \bigoplus_{\ell=1}^m \mathscr{M}_n(\mathbb{C})$ with ||x|| = 1, then we have

$$\begin{split} & \frac{1}{m^2} |\langle \mathbf{A}x, x \rangle|^2 \\ &= \frac{1}{m^2} \left| \sum_{k,j=1}^m \langle A_{kj} x_j, x_k \rangle \right|^2 \\ &\leq \frac{1}{m} \sum_{k,j=1}^m |\langle A_{kj} x_j, x_k \rangle|^2 \qquad \text{(by Jensen's inequality)} \\ &= \frac{1}{m} \sum_{k=1}^m |\langle A_{kk} x_k, x_k \rangle|^2 + \frac{1}{m} \sum_{\substack{j=1\\ j \neq k}}^m |\langle A_{kj} x_j, x_k \rangle|^2 \\ &\leq \frac{1}{m} \sum_{k=1}^m \left(\langle P_{kk} x_k, x_k \rangle^2 + \langle Q_{kk} x_k, x_k \rangle^2 \right) \\ &+ \frac{1}{m} \sum_{\substack{j=1\\ j \neq k}}^m \left[\langle f^2 \left(|P_{kj}| \right) x_j, x_k \rangle^{\frac{1}{2}} \langle g^2 \left(|P_{kj}| \right) x_j, x_k \rangle^{\frac{1}{2}} \\ &+ \langle f^2 \left(|Q_{kj}| \right) x_j, x_k \rangle^{\frac{1}{2}} \langle g^2 \left(|Q_{kj}| \right) x_j, x_k \rangle^{\frac{1}{2}} \right]^2 \\ &\leq \frac{1}{m} \sum_{k=1}^m \left(\| P_{kk} x_k \|^2 + \| Q_{kk} x_k \|^2 \right) \\ &+ \frac{1}{4m} \sum_{\substack{j=1\\ j \neq k}}^m \left\{ \langle \left[f^2 \left(|P_{kj}| \right) + g^2 \left(|P_{kj}| \right) \right] x_j, x_k \rangle + \langle \left[f^2 \left(|Q_{kj}| \right) + g^2 \left(|Q_{kj}| \right) \right] x_j, x_k \rangle \right\}^2 \end{split}$$

$$= \frac{1}{m} \sum_{k=1}^{m} \left\| P_{kk}^{2} + Q_{kk}^{2} \right\| \left\| x_{k} \right\|^{2} + \frac{1}{4m} \sum_{\substack{j=1\\j \neq k}}^{m} \left\| f^{2} \left(|P_{kj}| \right) + g^{2} \left(|P_{kj}| \right) + f^{2} \left(|Q_{kj}| \right) + g^{2} \left(|Q_{kj}| \right) \right\| \left\| x_{j} \right\| \left\| x_{k} \right\| = \langle [c_{kj}] \, y, y \rangle$$

where $y = (\|x_1\| \|\|x_2\| \cdots \|\|x_m\|)^T$. Taking the supremum over $x \in \bigoplus_m \mathscr{M}_n$, we obtain the desired result. \Box

Particularly, we are interested in the following 2×2 cases:

Corollary 1. If
$$\mathbf{A} = \begin{bmatrix} A_{11} & A_{12} \\ A_{21} & A_{22} \end{bmatrix}$$
 in $\mathcal{M}_n \bigoplus \mathcal{M}_n$, then
(2.2) $\omega \left(\begin{bmatrix} A_{11} & A_{12} \\ A_{21} & A_{22} \end{bmatrix} \right) \leq \sqrt{\omega \left(P_{11}^2 + Q_{11}^2 \right) + \omega \left(P_{22}^2 + Q_{22}^2 \right) + \sqrt{\left(\omega \left(P_{11}^2 + Q_{11}^2 \right) - \omega \left(P_{22}^2 + Q_{22}^2 \right) \right)^2 + N^2}}$
where $N = \| |P_{12}| + |Q_{12}| \| + \| |P_{21}| + |Q_{21}| \|$.

Proof. From Theorem 1, we have

$$\begin{split} &\omega\left(\left[\begin{array}{cc}A_{11} & A_{12}\\A_{21} & A_{22}\end{array}\right]\right)\\ &\leq \sqrt{2} \cdot \omega^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) & |||P_{12}|+|Q_{12}|||\\|||P_{21}|+|Q_{21}||| & \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\end{array}\right]\right)\\ &= \sqrt{2} \cdot r^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) & \frac{|||P_{12}|+|Q_{12}|||+|||P_{21}|+|Q_{21}|||}{2} \\ \frac{|||P_{12}|+|Q_{12}|||+|||P_{21}|+|Q_{21}|||}{2} & \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\end{array}\right]\right)\\ &= \sqrt{\omega}\left(P_{11}^{2}+Q_{11}^{2}\right) + \omega\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(\omega\left(P_{11}^{2}+Q_{11}^{2}\right) - \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\right)^{2} + N^{2}} \\ &= \sqrt{2} \cdot r^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) + \omega\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(\omega\left(P_{11}^{2}+Q_{11}^{2}\right) - \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\right)^{2} + N^{2}} \\ &= \sqrt{2} \cdot r^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) + \omega\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(\omega\left(P_{11}^{2}+Q_{11}^{2}\right) - \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\right)^{2} + N^{2}} \\ &= \sqrt{2} \cdot r^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) + \omega\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(\omega\left(P_{11}^{2}+Q_{11}^{2}\right) - \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\right)^{2} + N^{2}} \\ &= \sqrt{2} \cdot r^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) + \omega\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(\omega\left(P_{11}^{2}+Q_{11}^{2}\right) - \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\right)^{2} + N^{2}} \\ &= \sqrt{2} \cdot r^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) + \omega\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(\omega\left(P_{11}^{2}+Q_{11}^{2}\right) - \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\right)^{2} + N^{2}} \\ &= \sqrt{2} \cdot r^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) + \omega\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(\omega\left(P_{11}^{2}+Q_{11}^{2}\right) - \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\right)^{2} + N^{2}} \\ &= \sqrt{2} \cdot r^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) + \omega\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(\omega\left(P_{11}^{2}+Q_{11}^{2}\right) - \omega\left(P_{22}^{2}+Q_{22}^{2}\right)\right)^{2} + N^{2}} \\ &= \sqrt{2} \cdot r^{\frac{1}{2}}\left(\left[\begin{array}{cc}\omega\left(P_{11}^{2}+Q_{11}^{2}\right) + \omega\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(\omega\left(P_{11}^{2}+Q_{11}^{2}\right) - \omega\left(P_{22}^{2}+Q_{22}^{2}\right)} + \sqrt{\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(P_{22}^{2}+Q_{22}^{2}\right)} + \sqrt{\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt{\left(P_{22}^{2}+Q_{22}^{2}\right) + \sqrt$$

which proves the result.

Corollary 2. If
$$\mathbf{A} = \begin{bmatrix} A_{11} & 0 \\ 0 & A_{22} \end{bmatrix}$$
 in $\mathcal{M}_n \bigoplus \mathcal{M}_n$, then

$$\omega \left(\begin{bmatrix} A_{11} & 0 \\ 0 & A_{22} \end{bmatrix} \right) \le \max \left(\omega \left(P_{11}^2 + Q_{11}^2 \right), \omega \left(P_{22}^2 + Q_{22}^2 \right) \right)$$

where $P_{kk} + iQ_{kk}$ is the Cartesian decomposition of A_{kk} .

 $Proof. \text{ Setting } A_{12} = 0 = A_{21} \text{ in Corollary 1 and use the fact that } \omega \left(\left[\begin{array}{cc} A & 0 \\ 0 & D \end{array} \right] \right) \leq \max \left(\omega \left(A \right), \omega \left(D \right) \right), [10]. \quad \Box$

3. Applications for bounding zeros of polynomials

One of the most interesting and useful application of the numerical radius inequalities is to bound zeros of complex polynomials using a suitable partition of the well-known Frobenius companion matrix. Let

(3.1)
$$p(z) = z^{n} + a_{n}z^{n-1} + \dots + a_{2}z + a_{1}z^{n-1} + \dots + a_{n}z^{n-1} + \dots +$$

be any polynomial with $a_1 \neq 0$. The general corresponding companion matrix is defined as:

(3.2)
$$C(p) := \begin{bmatrix} -a_n & -a_{n-1} & \cdots & -a_2 & -a_1 \\ 1 & 0 & \cdots & 0 & 0 \\ 0 & 1 & \cdots & 0 & 0 \\ \vdots & \vdots & \ddots & \vdots & \vdots \\ 0 & 0 & \cdots & 1 & 0 \end{bmatrix}.$$

It is well known that the eigenvalues of C(p) are exactly the zeros of p(z), see [12, p. 316].

Based on some numerical radius estimations of C(p), several authors paid a serious attention to find various upper bounds of the zeros of p(z), some famous upper bounds are listed as follow: If λ is a zero of p, then

(1) Cauchy [12], obtained the following upper bound

(3.3)
$$|\lambda| \le 1 + \max\{|a_k| : k = 1, 2, \dots, n\}$$

(2) Carmichael and Mason [12], provided the following estimate

(3.4)
$$|\lambda| \le \sqrt{1 + \sum_{k=1}^{n} |a_k|^2}.$$

(3) Montel [12], proved the following estimate

(3.5)
$$|\lambda| \le \max\left\{1, \sum_{k=1}^{n} |a_k|\right\}.$$

(4) Fujii and Kubo [9] have shown that

(3.6)
$$|\lambda| \le \cos\left(\frac{\pi}{n+1}\right) + \frac{1}{2}\left(|a_n| + \sum_{k=1}^n |a_k|^2\right).$$

(5) Abdurakhmanov [1], provided the following estimate

(3.7)
$$|\lambda| \le \frac{1}{2} \left(|a_n| + \cos\left(\frac{\pi}{n}\right) + \sqrt{\left(|a_n| - \cos\left(\frac{\pi}{n}\right)\right)^2 + \left(1 + \sum_{k=1}^{n-1} |a_k|^2\right)^2} \right).$$

It seems that Paul and Bag [17], didn't notice Abdurakhmanov result; where they provided the same estimate.

(6) Linden [16], provided the following estimate

(3.8)
$$|\lambda| \le \frac{|a_n|}{n} + \sqrt{\frac{n-1}{n} \left(n-1 + \sum_{k=1}^n |a_k|^2 - \frac{|a_n|^2}{n}\right)}.$$

(7) Kittaneh [15], improved Abdurakhmanov estimate by proving that

(3.9)
$$|\lambda| \le \frac{1}{2} \left(|a_n| + \cos\left(\frac{\pi}{n}\right) + \sqrt{\left(|a_n| - \cos\left(\frac{\pi}{n}\right) \right)^2 + \left(|a_{n-1}| - 1 \right)^2 + \sum_{j=1}^{n-2} |a_j|^2} \right).$$

(8) Abu-Omar and Kittaneh [2], introduced the following estimate

(3.10)
$$|\lambda| \le \frac{1}{2} \left(\frac{|a_n| + \alpha}{2} + \cos\left(\frac{\pi}{n+1}\right) + \sqrt{\left(\frac{|a_n| + \alpha}{2} - \cos\left(\frac{\pi}{n+1}\right)\right)^2 + 4\beta} \right).$$
where $\alpha = \sqrt{\sum_{k=1}^n |a_k|^2}$ and $\beta = \sqrt{\sum_{k=1}^{n-1} |a_k|^2}.$

(9) Al-Dolat et al., provided the estimate

(3.11)
$$|\lambda| \le \frac{1}{2} \left(|a_n| + 2\cos\left(\frac{\pi}{n}\right) + \sqrt{t^2 |a_n|^2 + \sum_{k=1}^{n-1} |a_k|^2} + \sqrt{1 + (1-t)^2 |a_n|^2} \right)$$

for $t \in [0, 1]$. In fact, the upper bound above should be rewritten under taking 'min' over $t \in [0, 1]$, which gives the best value for this estimate.

To best of our knowledge, there is no single known method have been used in literature bounding the zeros of polynomial p(z) using the Frobenius companion matrix partitioned by the Cartesian decomposition method.


To apply the numerical radius inequalities established in the previous section to C(p), we note that, we have a little partition challenge in applying our obtained results because the main diagonal in the presented results require to have a square sub-matrices. So that, the usual well-known methods of partitioning the companion matrix C(p) in our presented results are useless, this is illustrated clearly in the presented inequalities in the previous section, See for example in (2.2).

Our proposed approach is to consider the degree p(z) in (3.1) to be even with fixed integer n such that $a_1 \neq 0$. To this end consider the even polynomial

(3.12)
$$q(z) = z^{2n} + a_{2n}z^{2n-1} + \dots + a_2z + a_1, \qquad n \ge 2, \ a_1 \ne 0.$$

Let

(3.13)



be the corresponding companion matrix, partitioned as what it is. Constructing the Cartesian decomposition of C(q), we have

Hence,

$$C(q) := \operatorname{Re}\left(C(q)\right) + i\operatorname{Im}\left(C(q)\right).$$

Moreover, it is easy to observe that $A_{kj} = P_{kj} + iQ_{kj}$ for k, j = 1, 2. This observation may not hold true in general for operator matrices; i.e., the Cartesian decomposition of operator matrices is not equal to the Cartesian decomposition of their sub-matrices. However, since we construct a special type of partition of C(q), it seems we have such equality holds true only for this construction.

It's not easy to apply (2.2) for general entries, since it has the norms $||P_{11}| + |Q_{11}||$ and $||P_{22}| + |Q_{22}||$; which are difficult to evaluate for general $n \times n$ matrices. In fact, it will be more easy as long as we have numeric entries with specific n as explored in the presented examples below.

Table 1 illustrates that our upper bound of any zero of $q(z) = z^6 + \frac{5}{4}z^5 + \frac{4}{3}z^4 + z^3 + 2z^2 + 3z + 4$, obtained by (2.2) is much better among all given upper bounds listed in Table 1.

We remark that, the same approach can be applied for polynomials of odd degrees having their absolute terms zero; e.g., in (3.12) assume that n is odd ≥ 5 and $a_1 = 0$. Then, p(z) can be written as

$$p(z) = z \left(z^{n-1} + a_n z^{n-2} + \dots + a_2 \right) = z p_1(z),$$

where $p_1(z)$ is an even polynomial of degree ≥ 4 . Since z = 0 is a zero for p, then trivially it must belongs to the disk containing the zeros of p_1 . Hence, in this case we have $\omega(C(p)) = \omega(C(p_1))$. We left the details to the interested reader.

4. Numerical radius of real and Imaginary parts of C(q)

Let $T \in \mathscr{M}_n(\mathbb{C})$ with the Cartesian decomposition T = P + iQ. Then

$$W(T) \subseteq W(P) + W(Q).$$

Hence,

$$\sigma(T) \subseteq [\lambda_{\min}(P), \lambda_{\max}(P)] \times [\lambda_{\min}(Q), \lambda_{\max}(Q)]$$

In case of the companion matrix C(q), it follows that all the zeros of p(z) in (3.1) are located in the rectangle

(4.1) $\left[\lambda_{\min}\left(\operatorname{Re}\left[C\left(q\right)\right]\right),\lambda_{\max}\left(\operatorname{Re}\left[C\left(q\right)\right]\right)\right]\times\left[\lambda_{\min}\left(\operatorname{Im}\left[C\left(q\right)\right]\right),\lambda_{\max}\left(\operatorname{Im}\left[C\left(q\right)\right]\right)\right].$

In [15], Kittaneh provided an explicit formula for the characteristic polynomial of $\operatorname{Re}[C(q)]$, which given as:

$$p_{\text{Real}}(z) := (z + \text{Re}(a_n)) \prod_{j=1}^{n-1} \left(z - \cos\left(\frac{j\pi}{n}\right) \right) - \sum_{j=1}^{n-1} \left(\prod_{k \neq j}^{n-1} \left(z - \cos\left(\frac{k\pi}{n}\right) \right) \right) |v_j|^2,$$

where

$$v_j = \frac{1}{\sqrt{2n}} \left[(1 - \overline{a}_{n-1}) \sin\left(\frac{j\pi}{n}\right) - \sum_{k=2}^{n-1} \overline{a}_{n-k} \sin\left(\frac{kj\pi}{n}\right) \right].$$

In the same work [15], an explicit rectangle that contains the rectangle (4.1), and thus it contains all the zeros of p, is obtained in the following result.

Theorem 2. [15, Kittaneh] If z is any zero of p, then z belongs to the rectangle $[-c, c] \times [-d, d]$, where

$$c = \frac{1}{2} \left[|\operatorname{Re}(c_n)| + \cos\left(\frac{\pi}{n}\right) + \sqrt{\left(|\operatorname{Re}(c_n)| - \cos\left(\frac{\pi}{n}\right)\right)^2 + |c_{n-1} - 1|^2 + \sum_{k=1}^{n-2} |c_k|^2} \right]$$

and

$$d = \frac{1}{2} \left[|\operatorname{Im}(c_n)| + \cos\left(\frac{\pi}{n}\right) + \sqrt{\left(|\operatorname{Im}(c_n)| - \cos\left(\frac{\pi}{n}\right)\right)^2 + |c_{n-1} - 1|^2 + \sum_{k=1}^{n-2} |c_k|^2} \right].$$

Based on the results obtained in this work, in what follows, we provide another possible rectangle. In order to establish our result, we need the following lemma [8].

Lemma 5. Let
$$A, B, C, D \in \mathscr{B}(\mathscr{H})$$
 and $T = \begin{bmatrix} A & B \\ C & D \end{bmatrix}$. Then

$$\omega(T) \leq \frac{1}{2} \left(\omega(A) + \omega(D) + \sqrt{(\omega(A) - \omega(D))^2 + (\omega(B + C) + \omega(B - C))^2} \right).$$

Now, we are in position to give our explicit rectangle that contains the rectangle (4.1), and thus it contains all the zeros of p.

Theorem 3. Let q(z) be any even complex polynomial whose degree ≥ 4 . If z is any zero of q, then z belongs to the rectangle $[-s,s] \times [-t,t]$, where

$$s := \frac{1}{4} \left(|\operatorname{Re}(a_{2n})| + \cos\left(\frac{\pi}{n}\right) + F \right) + \frac{1}{2} \cos\left(\frac{\pi}{n+1}\right) + \frac{1}{2} \sqrt{\left(\frac{1}{2} \left(|\operatorname{Re}(a_{2n})| + \cos\left(\frac{\pi}{n}\right) + F \right) - \cos\left(\frac{\pi}{n+1}\right) \right)^2 + \left(\frac{|\operatorname{Re}(a_n)| + G + |\operatorname{Im}(a_n)| + H}{2} \right)^2},$$

and

$$t := \frac{1}{4} \left(|\operatorname{Im} (a_{2n})| + \cos\left(\frac{\pi}{n}\right) + J \right) + \frac{1}{2} \cos\left(\frac{\pi}{n+1}\right) + \frac{1}{2} \left(\frac{1}{2} \left(|\operatorname{Im} (a_{2n})| + \cos\left(\frac{\pi}{n}\right) + J \right) - \cos\left(\frac{\pi}{n+1}\right) \right)^2 + \left(\frac{|\operatorname{Re} (a_n)| + G + |\operatorname{Im} (a_n)| + H}{2}\right)^2,$$

where

$$F := \sqrt{\left(\left| \operatorname{Re}\left(a_{2n}\right) \right| - \cos\left(\frac{\pi}{n}\right) \right)^2 + \left|1 - a_{2n-1}\right|^2 + \sum_{k=n+1}^{2n-2} |a_k|^2},$$
$$G := \sqrt{\left| \operatorname{Re}\left(a_n\right) \right|^2 + \left|1 - a_1\right|^2 + \sum_{k=2}^{n-1} |a_k|^2},$$
$$H := \sqrt{\left| \operatorname{Im}\left(a_n\right) \right|^2 + \left|1 + a_1\right|^2 + \sum_{k=2}^{n-1} |a_k|^2},$$

and

$$J := \sqrt{\left(\left|\operatorname{Im}(a_{2n})\right| - \cos\left(\frac{\pi}{n}\right)\right)^2 + \left|1 + a_{2n-1}\right|^2 + \sum_{k=n+1}^{2n-2} \left|a_k\right|^2}.$$

Proof. Employing Lemma 5, on the real part of C(q) (3.14); which is obtained in the previous section, by setting $A = P_{11}$, $B = P_{12}$, $C = P_{21}$ and $D = P_{22}$, it's enough to show that

(4.2)
$$\omega \left(\operatorname{Re}\left[C\left(q\right)\right] \right) \leq \frac{1}{2} \left(\omega \left(P_{11}\right) + \omega \left(P_{22}\right) + \sqrt{\left(\omega \left(P_{11}\right) - \omega \left(P_{22}\right)\right)^{2} + \left(\omega \left(P_{12} + P_{21}\right) + \omega \left(P_{12} - P_{21}\right)\right)^{2} \right)} \right).$$

Let us simplify that, indeed we have

which is can be written as

$$P_{11} = \begin{bmatrix} -\operatorname{Re}\left(a_{2n}\right) & u^* \\ u & T_{n-1} \end{bmatrix}$$

where $x := \left[\frac{-\overline{a_{2n-1}+1}}{2}, \cdots, \frac{-\overline{a_{n+2}}}{2}, \frac{-\overline{a_{n+1}}}{2}\right]$. Thus, be employing Lemmas 2 & 3, we have

$$(4.3) \qquad \omega \left(P_{11}\right) = \omega \left(\begin{bmatrix} |\operatorname{Re} \left(a_{2n}\right)| & x^{*} \\ x & T_{n-1} \end{bmatrix} \right) \\ \leq \omega \left(\begin{bmatrix} \omega \left(|\operatorname{Re} \left(a_{2n}\right)|\right) & ||x|| \\ ||x|| & \omega \left(T_{n-1}\right) \end{bmatrix} \right) \\ = r \left(\begin{bmatrix} \omega \left(|\operatorname{Re} \left(a_{2n}\right)|\right) & ||x|| \\ ||x|| & \omega \left(T_{n-1}\right) \end{bmatrix} \right) \\ = \frac{1}{2} \left(|\operatorname{Re} \left(a_{2n}\right)| + \cos \left(\frac{\pi}{n}\right) + \sqrt{\left(|\operatorname{Re} \left(a_{2n}\right)| - \cos \left(\frac{\pi}{n}\right)\right)^{2} + 4 ||x||^{2}} \right) \\ = \frac{1}{2} \left(|\operatorname{Re} \left(a_{2n}\right)| + \cos \left(\frac{\pi}{n}\right) + \sqrt{\left(|\operatorname{Re} \left(a_{2n}\right)| - \cos \left(\frac{\pi}{n}\right)\right)^{2} + |1 - a_{2n-1}|^{2} + \sum_{k=n+1}^{2n-2} |a_{k}|^{2}} \right).$$

On the other hand, we have

$$P_{12} + P_{21} = \begin{bmatrix} \frac{-a_n}{2} & \frac{-a_{n-1}}{2} & \cdots & \frac{-a_2}{2} & \frac{-a_1}{2} \\ 0 & 0 & \cdots & 0 & 0 \\ 0 & 0 & \cdots & 0 & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots & \vdots \\ \frac{1}{2} & 0 & \cdots & 0 & 0 \end{bmatrix} + \begin{bmatrix} \frac{-a_n}{2} & 0 & \cdots & 0 & \frac{1}{2} \\ \frac{-a_{n-1}}{2} & 0 & \cdots & 0 \\ \vdots & 0 & \ddots & \cdots & 0 \\ \frac{-a_2}{2} & \vdots & \cdots & \cdots & \vdots \\ \frac{-a_1}{2} & 0 & \cdots & 0 & 0 \end{bmatrix}$$
$$= \begin{bmatrix} \frac{-a_n + \overline{a_n}}{2} & -\frac{a_{n-1}}{2} & \cdots & -\frac{a_2}{2} & -\frac{a_1}{2} + \frac{1}{2} \\ \frac{-a_{n-1}}{2} & 0 & \cdots & 0 & 0 \\ \vdots & \vdots & \ddots & \cdots & 0 \\ \frac{-a_{n-1}}{2} & 0 & \cdots & \cdots & \vdots \\ \frac{-a_2}{2} & 0 & \cdots & 0 & 0 \end{bmatrix}_{n \times n}$$

Let $v := \left[\frac{-\overline{a_{n-1}}}{2}, \cdots, \frac{-\overline{a_2}}{2}, \frac{-\overline{a_1}+1}{2}\right]^T$. So that, by Lemmas 2 & 3, we have

(4.4)

$$\omega \left(P_{12} + P_{21}\right) = \omega \left(\begin{bmatrix} |\operatorname{Re}(a_n)| & v^* \\ v & 0 \end{bmatrix} \right) \\
\leq \omega \left(\begin{bmatrix} w \left(|\operatorname{Re}(a_n)|\right) & ||v|| \\ ||v|| & 0 \end{bmatrix} \right) \\
= r \left(\begin{bmatrix} w \left(|\operatorname{Re}(a_n)|\right) & ||y|| \\ ||y|| & 0 \end{bmatrix} \right) \\
= \frac{1}{2} \left(|\operatorname{Re}(a_n)| + \sqrt{|\operatorname{Re}(a_n)|^2 + 4||v||^2} \right) \\
= \frac{1}{2} \left(|\operatorname{Re}(a_n)| + \sqrt{|\operatorname{Re}(a_n)|^2 + |1 - a_1|^2 + \sum_{k=2}^{n-1} |a_k|^2} \right).$$

Similarly, we have

$$P_{12} - P_{21} = \begin{bmatrix} -\frac{a_n - \overline{a_n}}{2} & -\frac{a_{n-1}}{2} & \cdots & -\frac{a_2}{2} & -\frac{a_1}{2} - \frac{1}{2} \\ \hline \frac{a_{n-1}}{2} & 0 & 0 & \cdots & 0 \\ \vdots & \vdots & \ddots & \cdots & 0 \\ \vdots & & \vdots & \ddots & \cdots & 0 \\ \hline \frac{a_2}{2} & 0 & \cdots & \cdots & \vdots \\ \hline \frac{a_1}{2} + \frac{1}{2} & 0 & 0 & \cdots & 0 \end{bmatrix}_{n \times n}$$

Let $u := \left[\frac{\overline{a_{n-1}}}{2}, \cdots, \frac{\overline{a_2}}{2}, \frac{\overline{a_1}+1}{2}\right]^T$. So that, by Lemmas 2 & 3, we have

(4.5)
$$\omega \left(P_{12} - P_{21}\right) = \omega \left(\begin{bmatrix} |-i\operatorname{Im}(a_n)| & u^* \\ u & 0 \end{bmatrix} \right) \\ \leq \omega \left(\begin{bmatrix} w \left(|\operatorname{Im}(a_n)|\right) & ||u|| \\ ||u|| & 0 \end{bmatrix} \right) \\ = r \left(\begin{bmatrix} w \left(|\operatorname{Im}(a_n)|\right) & ||u|| \\ ||u|| & 0 \end{bmatrix} \right) \\ = \frac{1}{2} \left(|\operatorname{Im}(a_n)| + \sqrt{|\operatorname{Im}(a_n)|^2 + 4||u||^2} \right) \\ = \frac{1}{2} \left(|\operatorname{Im}(a_n)| + \sqrt{|\operatorname{Im}(a_n)|^2 + |1 + a_1|^2 + \sum_{k=2}^{n-1} |a_k|^2} \right).$$

Also, by (1.1) and Lemma 1, we have

(4.6)
$$\omega(P_{22}) = \cos\left(\frac{\pi}{n+1}\right).$$

Combining all above inequalities and equalities (4.3)-(4.6) in (4.2) we get the required result in Theorem 3. Following the same steps for ω (Re [C(q)]), therefore the proof of Theorem 3 is established.

The following example illustrated in Table 2, shows that our estimated rectangle given in Theorem 3 might be better than that one given in Theorem 2.

Example 1. Consider $q(z) = z^6 + 2iz^5 + 4iz^4 + \frac{1}{4}z + \frac{1}{16}$, then the real and imaginary parts of the zeros of q, are bounded as obtained in Table 2.

Remark 1. Several particular cases of Theorem 3 which are of great interest could be deduced. Among others, we note the following cases:

- $a_{2n} = a_n = 0$, $a_{2n-1} = \pm 1$ and $a_1 = 1$.
- $a_{2n} = a_n = 0$, $a_{2n-1} = \pm 1$ and $a_k = 0$ for all $k = 2, 3, \dots, n-1$. In particular, take $a_1 = 1$.
- $a_{2n} = a_n = 0$, $a_{2n-1} = \pm 1$ and $a_k = 0$ for all $k = n + 1, n + 2, \dots, 2n 2$. In particular, take $a_1 = 1$.

Theorem 4. Under the assumption of Theorem 3. Then

(4.7)
$$\omega\left(C\left(q\right)\right) \leq \frac{1}{2}\left(L + \cos\left(\frac{\pi}{n+1}\right) + \sqrt{\left(L - \cos\left(\frac{\pi}{n+1}\right)\right)^2 + \left(D_1 + D_2\right)^2}\right).$$

where

$$L := \frac{1}{2} \left(\sqrt{\sum_{k=n+2}^{2n} |a_k|^2} + \sqrt{\sum_{k=n+2}^{2n} |a_k|^2 + (|a_{n+1}| + 1)^2} \right),$$
$$D_1 = \frac{1}{2} \left(|a_n| + \sqrt{|a_n|^2 + |1 - a_1|^2 + \sum_{k=2}^{n-1} |a_k|^2} \right),$$

and

$$D_2 = \frac{1}{2} \left(|a_n| + \sqrt{|a_n|^2 + |1 + a_1|^2 + \sum_{k=2}^{n-1} |a_k|^2} \right),$$

Proof. Applying (4.2) to C(q) given in (3.13) by setting $A = A_{11}$, $B = A_{12}$, $C = A_{21}$ and $D = A_{22}$. So that, we get

$$\omega(C(q)) \leq \frac{1}{2} \left(\omega(A_{11}) + \omega(A_{22}) + \sqrt{(\omega(A_{11}) - \omega(A_{22}))^2 + (\omega(A_{12} + A_{21}) + \omega(A_{12} - A_{21}))^2} \right).$$

Let us observe that

&\leq \omega \left(\begin{bmatrix} \|d\| & |a_{n+1}| \\ \|I\| & \|0\| \end{bmatrix} \right) \\
&= r \left(\begin{bmatrix} \|d\| & \frac{|a_{n+1}|+1}{2} \\ \frac{|a_{n+1}|+1}{2} & 0 \end{bmatrix} \right) \\
&= \frac{1}{2} \left(\sqrt{\sum_{k=n+2}^{2n} |a_k|^2} + \sqrt{\sum_{k=n+2}^{2n} |a_k|^2 + (|a_{n+1}|+1)^2} \right).
\end{aligned}$$

Now, let $b := [-a_{n-1}, \dots, -a_2, 1 - a_1]$. So that, by Lemma 3, we have

$$A_{12} + A_{21} = \begin{bmatrix} -a_n & -a_{n-1} & \cdots & -a_2 & 1 - a_1 \\ \hline 0 & 0 & 0 & \cdots & 0 \\ \vdots & \vdots & \ddots & \cdots & 0 \\ 0 & 0 & \cdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & 0 \end{bmatrix}_{n \times n}$$

and so

(4.10)

$$\begin{aligned}
\omega \left(A_{12} + A_{21}\right) &= \omega \left(\begin{bmatrix} |-a_n| & b \\ 0 & 0 \end{bmatrix} \right) \leq \omega \left(\begin{bmatrix} w \left(|a_n|\right) & \|b\| \\ 0 & 0 \end{bmatrix} \right) \\
&= r \left(\begin{bmatrix} w \left(|a_n|\right) & \frac{1}{2} \|b\| \\ \frac{1}{2} \|b\| & 0 \end{bmatrix} \right) \\
&= \frac{1}{2} \left(|a_n| + \sqrt{|a_n|^2 + \|b\|^2} \right) \\
&= \frac{1}{2} \left(|a_n| + \sqrt{|a_n|^2 + |1 - a_1|^2 + \sum_{k=2}^{n-1} |a_k|^2} \right)
\end{aligned}$$

Similarly, let $z := [a_{n-1}, \cdots, a_2, 1 + a_1]$. So that, by Lemma 3, we have

$$A_{12} - A_{21} = \begin{bmatrix} a_n & a_{n-1} & \cdots & a_2 & 1+a_1 \\ \hline 0 & 0 & 0 & \cdots & 0 \\ \vdots & \vdots & \ddots & \cdots & 0 \\ 0 & 0 & \cdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & 0 \end{bmatrix}_{n \times n}$$

So that

(4.11)

$$\begin{split} \omega \left(A_{12} - A_{21} \right) &= \omega \left(\begin{bmatrix} |a_n| & b \\ 0 & 0 \end{bmatrix} \right) \leq \omega \left(\begin{bmatrix} w \left(|a_n| \right) & \|z\| \\ 0 & 0 \end{bmatrix} \right) \\ &= r \left(\begin{bmatrix} w \left(|a_n| \right) & \frac{1}{2} \|z\| \\ \frac{1}{2} \|z\| & 0 \end{bmatrix} \right) \\ &= \frac{1}{2} \left(|a_n| + \sqrt{|a_n|^2 + |z|^2} \right) \\ &= \frac{1}{2} \left(|a_n| + \sqrt{|a_n|^2 + |1 + a_1|^2 + \sum_{k=2}^{n-1} |a_k|^2} \right) \end{split}$$

Also, since $\omega (A_{12} - A_{21}) = \cos \left(\frac{\pi}{n+1}\right)$, then by substituting (4.9)–(4.11) in (4.8) we get the required result in (4.7).

The following example illustrates that our upper bound given in Theorem 4 is better than some famous and recent upper bounds obtained in the literature. Any zero of $q(z) = z^6 + \frac{1}{2}z^5 + \frac{1}{16}z^2 + 1$, is bounded by any values given in

Table 3 and shows that our presented results could be much better than all compared upper bounds listed in Table 2.

Corollary 3. Under the assumptions of Theorem 4. If $a_k = 0$ for all $k = 2, 3, \dots, n$ and $a_1 = 1$ (or $a_1 = -1$), then we have

(4.12)
$$\omega\left(C\left(q\right)\right) \leq \frac{1}{2}\left(L + \cos\left(\frac{\pi}{n+1}\right) + \sqrt{\left(L - \cos\left(\frac{\pi}{n+1}\right)\right)^2 + 1}\right).$$

where L is defined in Theorem $\frac{4}{4}$.

Proof. From (4.2) we have $\omega (A_{12} + A_{21}) = 0$ and $\omega (A_{12} - A_{21}) = 1$, if $a_1 = 1$. Thus, we have

$$\left(\omega \left(A_{12} + A_{21}\right) + \omega \left(A_{12} - A_{21}\right)\right)^2 = 1$$

Also, we always have $\omega(A_{22}) = \cos\left(\frac{\pi}{n+1}\right)$. Employing (4.2) we get the desired result in (4.12).

Remark 2. It is convenient to note that (4.7) can be rewritten as

$$\omega(C(q)) \le \frac{1}{2} \left(\omega(A_{11}) + \cos\left(\frac{\pi}{n+1}\right) + \sqrt{\left(\omega(A_{11}) - \cos\left(\frac{\pi}{n+1}\right)\right)^2 + \left(D_1 + D_2\right)^2} \right)$$

Moreover, if $a_{n+1} \neq 0$ in Theorem 4, one can replace the upper bound of $\omega(A_{11})$ by any other upper bound established in literature. Indeed, it could be chosen as minimum as possible, and this improves our result in (4.7).

We end this work by giving a new upper bound for the numerical radius of the companion matrix that represents the polynomial $g(z) = z^n + c_n z^{n-1} + c_{n-1} z^{n-2} + \cdots + c_2 z + c_1$ (with $c_1 \neq 0$), of any degree ≥ 2 .

Our upper bound is exactly the number L defined in Theorem 4. Naming, $c_n = a_{2n}, c_{n-1} = a_{2n-1}, \cdots, c_2 = a_{n+2}, c_1 = a_{n+1}$. If c_k 's are all reals such that $|c_k| < 1$ and $|c_{k+1}| > |c_k|$ ($\forall k = 1, 2, \cdots, n-1$). Then, we have

(4.13)
$$\omega(C(g)) \leq \frac{1}{2} \left(\sqrt{\sum_{k=2}^{n} |c_k|^2} + \sqrt{\sum_{k=2}^{n} |c_k|^2 + (|c_1| + 1)^2} \right) := \mathbf{MW}.$$

provided that $\sum_{k=2}^{n} |c_k| \ge \frac{2}{3}$. Otherwise, the result still valid even we don't have these assumption(s); i.e., if $|c_k| \ge 1$ for some $k \ne 1$, then (4.13) it remains always true for both real and complex coefficients. The analysis of the proof is mentioned in the proof of Theorem 4, as stated for $\omega(A_{11})$, under the assumption that $c_1 = a_{n+1} \ne 0$.

5. Observations, Discussion and Conclusion regarding MW

Consider $f(z) = z^6 + \frac{1}{4}z^5 + \frac{1}{9}z^4 + \frac{1}{16}z^3 + \frac{1}{25}z^2 + \frac{1}{36}z + \frac{1}{49}$, we find that the largest zero has modulus = **0.5447544053**. Table 4 shows that our result **MW** is pretty close to the exact modulus and it is much better than all other upper bounds.

Another example shows the efficiency of our result (4.13), consider $g(z) = z^6 + \frac{1}{3}z^4 + \frac{1}{4}z^3 + \frac{1}{9}z^2 + \frac{1}{100}$, we find that the largest zero has modulus = **0.7419983061**. Table 5 shows that our result **MW** is very close to the exact modulus.

After long considerations and investigations, for almost all cases of c_k 's (with $|c_k| < 1$), we find that (4.13) is very effective as long as $|c_k| < 1$, besides the other mentioned assumptions. The following example explains why we chose the presented conditions in (4.13), and thus it solidifies and supports the reason of our selection. Let

$$h_1(z) = z^6 + \frac{1}{6}z^4 + \frac{1}{5}z^2 + \frac{1}{4}$$

The real coefficients of h_1 don't respect our conditions in (4.13). So that, we find that the largest zero has modulus = 0.8120242973, but the upper bound in (4.13) = 0.7685824855; which gives an incorrect upper bound, which means that (4.13) doesn't apply arbitrary for any c_k 's unless we have some restriction(s). To ensure the correctness; and after long extrapolation by testing many cases; we established the investigated assumptions in (4.13) for all polynomials with real coefficients.

In this regard, we should note that the assumptions about c_k 's whenever $|c_k| < 1$; are sufficient only for real coefficients. However, if some of c_k 's are complex, then it is not true that we cannot apply (4.13). For example, the polynomial

$$h_2(z) = z^6 + \left(\frac{1}{4} + i\frac{1}{4}\right)z^5 + \frac{i}{9}z^4 + \frac{i}{16}z^3 + \frac{1}{25}z^2 + \frac{1}{36}z + \frac{1}{49},$$

refuting three assumptions of (4.13). Namely, we have some of c_k 's are complex, with $\sum_{k=2}^{n} |c_k| = 0.5949422794 \le \frac{2}{3}$, and $|c_3| < |c_2|$. At the same time, we find that the largest zero has modulus = 0.6408240287. But the upper bound

in (4.13) = 0.7337440145, which means that (4.13) still can be applied under another conditions as long as $|c_k| < 1$. We are not able to determine the sufficient condition for complex coefficients in the case that $|c_k| < 1$.

Furthermore, the polynomial

$$h_3(z) = z^6 + \frac{1}{4}z^4 + \frac{1}{3}z^2 + \frac{1}{4},$$

is a good example showing that the conditions $|c_{k+1}| < |c_k|$ and $\sum_{k=2}^{n} |c_k| = 0.58333333333 \le \frac{2}{3}$, are not necessary but they are sufficient. In other words, the restricted conditions in (4.13) do not mean that there are no other examples that violate these conditions. Indeed, the largest zero of h_3 has modulus = 0.8310538215, however the upper bound in (4.13) = 0.8671411790. Therefore, (4.13) can be applied even we don't have our restrictions.

In this matter, we would say our restricted assumptions in (4.13) are very sufficient and hold correctly over all reals as long as we have the mentioned assumptions in (4.13); but they are not necessary, in general. We left the study of sufficiency and necessity conditions in the case that $|c_k| < 1$ as an open problem to the interested reader. When some of $|c_k| > 1$, $k \neq 1$, (4.13) is always valid, regardless; what types of the coefficients we have, or their arrangement, or their sum. Last but not least, the upper bound (4.13) shows a very impact efficiency especially in the case that all of $|c_k|$'s are < 1.
