## Poisson cohomology of plane Poisson structures with isolated singularities revisited

Continuing a work of Ph . Monnier, we determine the Gerstenhaber algebra structure over the Poisson cohomology groups for a large class of Poisson structures with isolated singularities over the plane. It reveals that there exists a GAGA type phenomenon. We give an explicit description via generators and relations for the case of simple singularities.

## I. INTRODUCTION

The Poisson cohomology of Poisson manifolds (and of Poisson algebras) was introduced by A. Lichnerowicz ${ }^{9}$. J. Huebschmann studied this cohomology theory from the viewpoint of Lie-Rinehart algebras ${ }^{4-6}$. While Poisson cohomology is ubiquitous in Poisson geometry, their computation is in general very difficult. It has been shown that for symplectic manifolds, Poisson cohomology is naturally isomorphic to de Rham cohomology ${ }^{9}$. Cohomology of regular Poisson manifolds was investigated by P. Xu ${ }^{16}$, and V. Ginzburg and A. Weinstein studied cohomology of Poisson-Lie groups ${ }^{3}$.

In this paper, we are interested into cohomology of Poisson structures over the plane. C. Roger and P. Vanhaecke ${ }^{13}$ computed the Poisson cohomology of plane homogeneous Poisson structures. Inspired by an idea of I. Vaisman ${ }^{15}$, N. Nakanishi ${ }^{12}$ computed the cohomology of plane quadratic Poisson structures classified by Z.-J. Liu and P. Xu ${ }^{10}$. V. I. Arnold ${ }^{1}$ classified all plane Poisson structures with simple singularities in 1987 and Ph. Monnier ${ }^{11}$ computed the (germfied) Poisson cohomology of a large class of plane Poisson structures with isolated singularities including Arnold's list. This work carries further Ph. Monnier's work ${ }^{11}$ by computing the Gerstenhaber algebra structure over the Poisson cohomology groups for these plane Poisson structures with isolated singularities.

Let us give the setup of this paper. Throughout, $\mathbb{K}$ will denote the field $\mathbb{R}$ or $\mathbb{C}$. We will consider the Poisson cohomology of a Poisson algebra $\mathscr{F}$, where $\mathscr{F}$, unless otherwise stated, will always denote one of the following algebras of function germs:

- $\mathbb{K}\{x, y\}$ the algebra of analytic functions near the origin,
- $\mathbb{K}[[x, y]]$ the algebra of formal power series,
- (only when $\mathbb{K}=\mathbb{R}) C_{o}^{\infty}\left(\mathbb{R}^{2}\right)$ the algebra of smooth function germs at the origin.

Let $\omega_{1}, \omega_{2}$ be two positive integers, $W=\omega_{1} x \frac{\partial}{\partial x}+\omega_{2} y \frac{\partial}{\partial y}$ the Euler vector field. If a polynomial $f$ satisfies $W f=\mathrm{d} f$, with $\mathrm{d} \in \mathbb{Z}$, then $f$ is weight-homogeneous of degree d with respect to $\left(\omega_{1}, \omega_{2}\right)$. Denote by $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}$ the space of weight-homogenous polynomials of degree $\mathrm{d}-\omega_{1}-\omega_{2}$ together with the zero polynomial, and write $H_{f}=\frac{\partial f}{\partial y} \frac{\partial}{\partial x}-\frac{\partial f}{\partial x} \frac{\partial}{\partial y}$ for the Hamiltonian derivation associated to $f \in \mathscr{F}$. Recall that a polynomial $f$ is of finite codimension if the Milnor algebra $\mathscr{M}_{f}:=\mathscr{F} / I_{f}$ with $I_{f}=\left(\frac{\partial f}{\partial x}, \frac{\partial f}{\partial y}\right)$ is finite-dimensional. Note that this implies that the origin is an isolated singularity.

From now on, we fix $\left(\omega_{1}, \omega_{2}\right)$ and all weight-homogenous stuff will be taken with respect to $\left(\omega_{1}, \omega_{2}\right)$.
Let $f$ be a weight-homogenous polynomial of degree d (with respect to $\left(\omega_{1}, \omega_{2}\right)$ ). Let $h$ be a weight-homogenous polynomial of degree $\mathrm{d}-\omega_{1}-\omega_{2}$ or the zero polynomial. Suppose, moreover, that $f$ has finite codimension.

We shall consider the Poisson structure

$$
\Pi=f(1+h) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}
$$

and if $h=0$, write $\Pi_{0}:=\Pi=f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$. Our goal is to study the Poisson cohomology of this Poisson structure $\Pi$ for the algebras in the above list. For $i \geq 0$, let us denote the $i$-th Poisson cohomology group by $\mathrm{HP}_{\Pi}^{i}(\mathscr{F})$ or just $\mathrm{HP}_{\Pi}^{i}$. Ph . Monnier computed these Poisson cohomology groups.

Theorem I. 1 (Ph. Monnier ${ }^{11}$ ). We have

$$

\operatorname{HP}_{\Pi}^{0}=\mathbb{K} 1 \\
\operatorname{HP}_{\Pi}^{1}=\mathbb{K}(1+h) H_{f} \oplus \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}(1+h) W \\
\operatorname{HP}_{\Pi}^{2}=\mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \oplus \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}, \\
\mathrm{HP}_{\Pi}^{i}=0, \text { for } i \geq 3 .
\end{array}\right.
$$

Therefore, he actually showed that the dimensions of Poisson cohomology groups do not depend on the underlying algebras of function germs. This is a kind of GAGA type results ${ }^{14}$.

Poisson cohomology groups are not just abelian groups, in fact they have a much nicer structure: the so-called Gerstenhaber algebra structure ${ }^{7,8,17}$; that is, it is a graded commutative algebra via the wedge product, it has the Schouten-Nijenhuis bracket so that it becomes a graded Lie algebra, and these structures are compatible.

A natural question is whether Ph. Monnier's GAGA type result actually gives isomorphisms of Gerstenhaber algebras. The answer is Yes, which is the content of the following result:

Theorem I. 2 (Theorem IV.10). There exist isomorphisms of Gerstenhaber algebras

$$
\mathrm{HP}_{\Pi}^{*}(\mathbb{C}\{x, y\}) \cong \mathrm{HP}_{\Pi}^{*}(\mathbb{C}[[x, y]]) \text { and } \mathrm{HP}_{\Pi}^{*}\left(C_{0}^{\infty}\left(\mathbb{R}^{2}\right)\right) \cong \mathrm{HP}_{\Pi}^{*}(\mathbb{R}\{x, y\}) \cong \mathrm{HP}_{\Pi}^{*}(\mathbb{R}[[x, y]])
$$

If $h=0$, one can also add the polynomial algebra $\mathbb{K}[x, y]$ into the statement.

We prove the above result by checking the difficult computation of Ph . Monnier ${ }^{11}$ carefully. Moreover, we are able to describe almost completely the Gerstenhaber algebra structure over the Poisson cohomology ring $\mathrm{HP}_{\Pi}^{*}$.

Theorem I.3. (a) (Proposition IV.1) The wedge products $\wedge: \mathrm{HP}_{\Pi}^{0} \times \mathrm{HP}_{\Pi}^{i} \rightarrow \mathrm{HP}_{\Pi}^{i}, i=0,1,2$ are just the scalar product of $\mathbb{K}$-vector spaces; the map $\wedge: \mathrm{HP}_{\Pi}^{1} \times \mathrm{HP}_{\Pi}^{1} \rightarrow \mathrm{HP}_{\Pi}^{2}$ can be nonzero, but its only nonzero component is given by

$$
\mathbb{K}(1+h) H_{f} \times \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}(1+h) W \rightarrow \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}, \quad\left((1+h) H_{f}, g(1+h) W\right) \mapsto \mathrm{d} \cdot g f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}
$$

for $g \in \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}$; all other wedge products vanish.
(b) (Theorem IV.2) We have an isomorphism of graded algebras

$$
\mathrm{HP}_{\Pi}^{*} \cong \mathbb{K}\left\langle u, v_{1} \cdots, v_{r}\right\rangle /\left(u^{2}, v_{1}^{2}, \cdots, v_{r}^{2}, u v_{i}+v_{i} u, v_{i} v_{j}, 1 \leq i, j \leq r\right) \times_{\mathbb{K}} \mathbb{K}\left[w_{1}\right] /\left(w_{1}^{2}\right) \times_{\mathbb{K}} \cdots \times_{\mathbb{K}} \mathbb{K}\left[w_{c}\right] /\left(w_{c}^{2}\right),
$$

$$
\text { with }|u|=\left|v_{1}\right|=\cdots=\left|v_{r}\right|=1,\left|w_{1}\right|=\cdots=\left|w_{c}\right|=2 \text {, where } r=\operatorname{dim}\left(\mathscr{M}_{f}\right), c=\operatorname{dim}\left(\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}\right)
$$

(c) (Subsection IV B) If $h=0$, then all brackets vanish, except possibly the component

& {[-,-]_{\mathbf{S N}}: \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} W \times \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \rightarrow \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} .} \\
& \text { of }[-,-]_{\mathbf{S N}}: \mathrm{HP}_{\Pi_{0}}^{1} \times \mathrm{HP}_{\Pi_{0}}^{2} \rightarrow \mathrm{HP}_{\Pi_{0}}^{2} .
\end{aligned}
$$

(d) (Remark IV.9) If $h \neq 0$, then all brackets vanish, except possibly the component of $[-,-]_{\mathbf{S N}}: \mathrm{HP}_{\Pi}^{1} \times \mathrm{HP}_{\Pi}^{2} \rightarrow \mathrm{HP}_{\Pi}^{2}$ given by

$$
[-,-]_{\mathbf{S N}}: \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}(1+h) W \times \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \rightarrow \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \oplus \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} .
$$

When the isolated singularity is a simple singularity, we succeed in determining completely the Gerstenhaber algebra structure over the Poisson cohomology ring $\mathrm{HP}_{\Pi}^{*}$ in terms of generators and relations; see Table III in Section V H. Our calculation relies heavily on the classification of plane Poisson structures with simple singularities due to V. I. Arnold ${ }^{1}$

This paper is organised as follows. The second section contains some basic definitions and facts about Poisson algebras and Poisson cohomology and we also remind the classification of plane Poisson structures with simple singularities due to V. I. Arnold. The result of Ph. Monnier about Poisson cohomology groups is recalled in the third section. We consider the Gertstenhaber algebra structure continuing the computation of Ph . Monnier in the fourth section. The last section contains explicit results for simple singularities.

## II. PRELIMINARIES

For basic definitions and facts about Poisson cohomology, the reader is referred to Ref. 8.
A Poisson algebra is an associative $\mathbb{K}$-algebra $R$ endowed with a Lie bracket $\pi=\{$,$\} satisfying a compatibility condition.$
For $p \geq 0$, a skew-symmetric multilinear map $P \in \operatorname{Hom}_{\mathbb{K}}\left(\wedge_{\mathbb{K}}^{p} R, R\right)$ is a $p$-polyvector field if it is a derivation in each argument. Denote by $\mathfrak{X}^{p}(R)$ the space of $p$-polyvector fields.

Let us introduce the wedge product and the Schouten-Nijenhuis bracket over polyvector fields.
Definition II.1. Let $F \in \mathfrak{X}^{p}(R)$ and $G \in \mathfrak{X}^{q}(R)$ with $p, q \geq 0$. Define the wedge product $F \wedge G \in \mathfrak{X}^{p+q}(R)$ as follows:

$$
F \wedge G\left(a_{1} \wedge \cdots \wedge a_{p+q}\right)=\sum_{\sigma \in S_{p, q}} \operatorname{sgn}(\sigma) F\left(a_{\sigma(1)} \wedge \cdots \wedge a_{\sigma(p)}\right) G\left(a_{\sigma(p+1)} \wedge \cdots \wedge a_{\sigma(p+q)}\right)
$$

where $a_{1}, \cdots, a_{p+q} \in R$ and $S_{p, q}$ is the set of $(p, q)$-shuffles, that is,

$$
S_{p, q}=\left\{\sigma \in S_{p+q} \mid \sigma(1)<\cdots<\sigma(p), \sigma(p+1)<\cdots<\sigma(p+q)\right\}
$$

Define the Schouten-Nijenhuis bracket $[F, G]_{\mathbf{S N}} \in \mathfrak{X}^{p+q-1}(R)$ as follows: for $a_{1}, \cdots, a_{p+q-1} \in R$,

$$
\begin{aligned}
{[F, G]_{\mathbf{S N}}\left(a_{1} \wedge \cdots \wedge a_{p+q-1}\right)=} & \sum_{\sigma \in S_{q, p-1}} \operatorname{sgn}(\sigma) F\left(G\left(a_{\sigma(1)} \wedge \cdots \wedge a_{\sigma(q)}\right) \wedge a_{\sigma(q+1)} \wedge \cdots \wedge a_{\sigma(p+q)}\right) \\
& -(-1)^{(p-1)(q-1)} \sum_{\sigma \in S_{p, q-1}} \operatorname{sgn}(\sigma) G\left(F\left(a_{\sigma(1)} \wedge \cdots \wedge a_{\sigma(p)}\right) \wedge a_{\sigma(p+1)} \wedge \cdots \wedge a_{\sigma(p+q)}\right) .
\end{aligned}
$$

Since $\pi$ is a Lie bracket, $\delta^{p}=[-, \pi]: \mathfrak{X}^{p} \rightarrow \mathfrak{X}^{p+1}, p \geq 0$ squares to zero, so $\left(\mathfrak{X}^{*}(R), \delta^{*}\right)$ becomes a cochain complex, called the Poisson cochain complex of $R$. For $p \geq 0$, the $p$-th Poisson cohomology group of the Poisson algebra $R$ is defined to be

$$
\operatorname{HP}^{p}(R):=\operatorname{Ker}\left(\delta^{p}\right) / \operatorname{Im}\left(\delta^{p-1}\right)
$$

We write $\operatorname{HP}^{*}(R):=\bigoplus_{p \in \mathbb{N}} \mathrm{HP}^{p}(R)$. It is easy to see that the wedge product and the Schouten-Nijenhuis bracket descend to cohomology groups. The following result is folklore; see for example, Ref. 8 Proposition 4.9.

Theorem II.2. Let $(R, \pi)$ be a Poisson algebra. Then $\left(\operatorname{HP}^{*}(R), \wedge,[,]_{\mathbf{S N}}\right)$ is a Gerstenhaber algebra, that is,
(a) $\left(\mathrm{HP}^{*}(R), \wedge\right)$ is a graded commutative graded algebra,
(b) $\left(\operatorname{HP}^{*}(R)[1],[,]_{\mathbf{S N}}\right)$ is a graded Lie algebra,
(c) the above two structures are compatible, that is,

$$
[F \wedge G, H]_{\mathbf{S N}}=[F, H]_{\mathbf{S N}} \wedge G+(-1)^{(r-1) p} F \wedge[G, H]_{\mathbf{S N}}
$$

for $F \in \operatorname{HP}^{p}(R)$ and $H \in \operatorname{HP}^{r}(R)$.
Next we recall the classification of plane Poisson structures with simple singularities due to V.I. Arnold ${ }^{1}$. For unexplained notations and results about singularity theory, we refer the reader to Ref. 2.

For plane Poisson structures with simple singularities at the origin, V.I. Arnold proved the following classification result.
Theorem II. 3 (V.I.Arnold ${ }^{1}$ ). Let $f$ be a simple function germ at the origin of the plane. The Poisson structure germ $\Pi=f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ is equivalent to, up to a multiplicative constant, $g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$, where $g$ is given in the second column of Table I:

Note that in this table, when $\mathbb{K}=\mathbb{C}$, the symbol $\pm$ disappears.

## III. POISSON COHOMOLOGY GROUPS

This section contains a summary of the paper of Ph . Monnier ${ }^{11}$ and we also explain how to compute cohomology classes concretely.

We want to investigate the Poisson cohomology groups of $\Pi=f(1+h) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ and $\Pi_{0}=f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ where $f$ is a weighthomogeneous polynomial of degree $\mathrm{d}>0$ which is a germ at the origin of finite codimension c and $h$ is a weight-homogeneous polynomial of degree $d-\omega_{1}-\omega_{2}$ (only when $d-\omega_{1}-\omega_{2}>0$ ) or the zero polynomial. By Arnold's classification Theorem II.3, we see that the "most interesting" Poisson structures are of this type.

We choose a priori a monomial basis of $\mathscr{M}_{f}=\mathscr{F} / I_{f}$, say, $u_{1}, \cdots, u_{c}$ with $c=\operatorname{dim}\left(\mathscr{M}_{f}\right)$. For the existence of such a monomial basis, we refer the reader to Ref. 2. Note $\max \left(\operatorname{deg}\left(u_{i}\right), 1 \leq i \leq c\right)=2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$. The choice of a monomial basis of $\mathscr{M}_{f}$ gives in fact a direct sum decomposition $\mathscr{F}=\mathscr{M}_{f} \oplus I_{f}$. We choose a basis $e_{1}, \cdots, e_{r}$ of $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}$ with $r=\operatorname{dim}\left(\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}\right)$.

It is easy to see that the space $\mathrm{HP}_{\Pi_{0}}^{0}$ and $\mathrm{HP}_{\Pi}^{0}$ are always equal to $\mathbb{K} \cdot 1$.
The following useful lemma is implicit in Ref. 11, whose easy proof is left to the reader.
Lemma III.1. Let $X$ be a weight-homogeneous vector field in the sense that $[W, X]_{\mathbf{S N}}=r X$ for some $r \in \mathbb{Z}$.
(a) Let $Z=\frac{1}{\mathrm{~d}}(X(h)-\operatorname{div}(X) h) W+h X$. Then $\operatorname{div}(Z)=\frac{\operatorname{deg}(X)}{\mathrm{d}}(X(h)-\operatorname{div}(X))+2 X(h)$ and $X(f h)-\operatorname{div}(X) f h=Z(f)$.
(b) If $\operatorname{deg}(X) \neq \mathrm{d}-\omega_{1}-\omega_{2}$, denote $Y=X+\frac{\operatorname{div}(X)}{\mathrm{d}-\omega_{1}-\omega_{2}-\operatorname{deg}(X)} W$, then $X(f)=Y(f)-\operatorname{div}(Y) f$.

(c) If $\operatorname{deg}(X) \neq 0$, write $Y=h X-\frac{2}{\operatorname{deg}(X)} X(h) W$, then $\operatorname{deg}(Y)=\operatorname{deg}(X)+\mathrm{d}-\omega_{1}-\omega_{2}$ and

$$
X(f h)-\operatorname{div}(X) f h=Y(f)-\operatorname{div}(Y) f
$$

With the same proof, Theorems 4.5 and 4.9 of Ref. 11 hold even for $\mathbb{K}[x, y]$, the polynomial ring in two variables.
Theorem III. 2 (Ref. 11 Theorems 4.5 and 4.9 ). Let $\mathscr{F}$ be either $\mathbb{K}[x, y]$ or one of the algebras listed in the Introduction. We have

$$
\mathrm{HP}_{\Pi_{0}}^{1}=\mathbb{K} H_{f} \oplus \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} W \text { and } \mathrm{HP}_{\Pi_{0}}^{2}=\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \oplus \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} .
$$

Let us include some details about how to compute the class of $g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ in $\mathrm{HP}_{\Pi_{0}}^{2}$ for a weight-homogeneous polynomial $g \in \mathscr{F}$.
Proposition III.3. Let $g \in \mathscr{F}$ be a weight-homogeneous polynomial. Write $g=\sum_{i=1}^{c} \lambda_{i} u_{i}+\xi \in \mathscr{M}_{f} \oplus I_{f}=\mathscr{F}$ with $\lambda_{i} \in \mathbb{K}$ where $\xi=X(f) \in I_{f}$ for a vector field $X$.
(a) If $\operatorname{deg}(g) \neq 2 \mathrm{~d}-\omega_{1}-\omega_{2}$, then $g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\sum_{i=1}^{c} \lambda_{i} u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi_{0}}^{2}$.
(b) If $\operatorname{deg}(\xi)=2 \mathrm{~d}-\omega_{1}-\omega_{2}$, then $g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\operatorname{div}(X) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi_{0}}^{2}$.

Proof Observe three facts: if $\operatorname{deg}(g)>2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=\max \left(u_{i}, 1 \leq i \leq c\right)$, then all $\lambda_{i}$ vanish; if $\operatorname{deg}(g) \leq 2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, those $u_{i}$ with nonzero $\lambda_{i}$ are of degree equal to that of $g$; the degree of $\xi$ is equal to $\operatorname{deg}(g)$.

If $\operatorname{deg}(\xi) \neq 2 \mathrm{~d}-\omega_{1}-\omega_{2}$, by Lemma 4.4 of Ref. $11, \xi \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ is necessarily a 2-coboundary. By Lemma III.1(b), let $Y=X+\frac{\operatorname{div}(X)}{2 \mathrm{~d}-\omega_{1}-\omega_{2}-\operatorname{deg}(g)} W$, then $\xi=X(f)=Y(f)-\operatorname{div}(Y) f$. Hence

$$
g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\sum_{i=1}^{c} \lambda_{i} u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}+(Y(f)-\operatorname{div}(Y) f) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\sum_{i=1}^{c} \lambda_{i} u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}+\delta_{\Pi_{0}}^{1}(f)=\sum_{i=1}^{c} \lambda_{i} u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi_{0}}^{2} .
$$

If $\operatorname{deg}(g)=\operatorname{deg}(\xi)=2 \mathrm{~d}-\omega_{1}-\omega_{2}>2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, then all $\lambda_{i}=0$. So $g=\xi=\operatorname{div}(X) f+(X(f)-\operatorname{div}(X) f)$ and

$$
g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\operatorname{div}(X) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi_{0}}^{2} .
$$

Compared with the result for the Poisson structure $\Pi_{0}$, computation of Ph. Monnier for $\Pi$ cannot carry over $\mathbb{K}[x, y]$.
Theorem III. 4 (Ref. 11 Theorems 4.6 and 4.11). We have

$$
\mathrm{HP}_{\Pi}^{1}=\mathbb{K}(1+h) H_{f} \oplus \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}(1+h) W \text { and } \mathrm{HP}_{\Pi}^{2}=\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \oplus \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} .
$$

We will explain how to compute the class of $g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ in $\mathrm{HP}_{\Pi}^{2}$ for $g$ a weight-homogeneous polynomial. We need a small lemma which refines Lemma 4.10 of Ref. 11.
Lemma III.5. Let Z be a weight-homogeneous vector field.
(a) If $\operatorname{deg}(Z)>0$, then $(Z(f h)-\operatorname{div}(Z) f h) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$.
(b) If $\operatorname{deg}(Z)=0$, then $(Z(f h)-\operatorname{div}(Z) f h) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=2 Z(h) f \in \mathrm{HP}_{\Pi}^{2}$.

Proof First denote $g^{\prime}=Z(f h)-\operatorname{div}(Z) f h$. By Theorem III.2, write

$$
\frac{g^{\prime}}{1+h} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\sum_{i=1}^{c} \mu_{i} u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}+Q f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \operatorname{HP}_{\Pi_{0}}^{2}
$$

with $\mu_{i} \in \mathbb{K}, Q \in \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}$. In fact, it is shown in the proof of Lemma 4.10 of Ref. 11 that all $\mu_{i}$ vanish.
Let $g^{\prime \prime}$ be the component of $\frac{g^{\prime}}{1+h}$ of degree $2 \mathrm{~d}-\omega_{1}-\omega_{2}$, then following Proposition III.3, $Q=\operatorname{div}\left(Z^{\prime}\right)$ with $g^{\prime \prime}=Z^{\prime}(f)$, where by Lemma III.1(a), $Z^{\prime}=\frac{1}{\mathrm{~d}}(Z(h)-\operatorname{div}(Z) h) W+h Z$.

Express $\frac{g^{\prime}}{1+h}=g^{\prime}-g^{\prime} h+g^{\prime} h^{2}+\cdots$. If $\operatorname{deg}(Z)>0$, then $\operatorname{deg}\left(g^{\prime}\right)>2 \mathrm{~d}-\omega_{1}-\omega_{2}$ and $\frac{g^{\prime}}{1+h}$ has all its components of degree strictly bigger than $2 \mathrm{~d}-\omega_{1}-\omega_{2}$, and we obtain that $g^{\prime \prime}=0$ and $Q=0$. Hence, $g^{\prime} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$. If $\operatorname{deg}(Z)=0$, then $\operatorname{deg}\left(g^{\prime}\right)=2 \mathrm{~d}-\omega_{1}-\omega_{2}$ and $\frac{g^{\prime}}{1+h}$ has all its components of degree strictly bigger than $2 \mathrm{~d}-\omega_{1}-\omega_{2}$ except $g^{\prime}$, and we obtain that $g^{\prime \prime}=g^{\prime}$ and $Q=\operatorname{div}\left(Z^{\prime}\right)=2 Z(h)$. Hence, $g^{\prime} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=2 Z(h) f \in \mathrm{HP}_{\Pi}^{2}$.

Poisson cohomology of plane Poisson structures with isolated singularities revisited

The following result is very useful in practical computation.
Proposition III.6. Let $g \in \mathscr{F}$ be a weight-homogeneous polynomial. Write $g=\sum_{i=1}^{c} \lambda_{i} u_{i}+\xi \in \mathscr{M}_{f} \oplus I_{f}=\mathscr{F}$ with $\lambda_{i} \in \mathbb{K}$ and $\xi=X(f) \in I_{f}$ for a vector field $X$.

If $\operatorname{deg}(g)$ is not in the form of $\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$ with $k \geq-1$, then

$$
g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\sum_{i=1}^{c} \lambda_{i} u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2}
$$

Suppose that there exists an integer $k \geq-1$ such that $\operatorname{deg}(g)=\mathrm{d}-\mathrm{k}\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$.

- If $k=-1$, i.e. $\operatorname{deg}(g)=2 \mathrm{~d}-\omega_{1}-\omega_{2}$, then

$$
g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\operatorname{div}(X) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2}
$$

- If $k>-1$, define vector fields $X_{i}, 0 \leq i \leq k$ as follows: put $X_{0}=X+\frac{\operatorname{div}(X)}{\mathrm{d}-\omega_{1}-\omega_{2}-\operatorname{deg}(X)}$ W and for $i=1, \cdots, k$, define recursively $X_{i}=h X_{i-1}-\frac{2}{\operatorname{deg}\left(X_{i-1}\right)} X_{i-1}(h) W$. Then

$$
g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\sum_{i=1}^{c} \lambda_{i} u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}-2 X_{k}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2} .
$$

Proof Suppose that $\operatorname{deg}(g)=\operatorname{deg}(\xi)=2 \mathrm{~d}-\omega_{1}-\omega_{2}=\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$ with $k=-1$. As

$$
\delta_{\Pi}^{1}(X)=(X(f)-\operatorname{div}(X) f) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}+(X(f h)-\operatorname{div}(X) f h) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y},
$$

we have

$$
\xi \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\operatorname{div}(X) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}-(X(f h)-\operatorname{div}(X) f h) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2} .
$$

Since $\operatorname{deg}(X)=\mathrm{d}-\omega_{1}-\omega_{2}>0$, by Lemma III. 5 (a), $(X(f h)-\operatorname{div}(X) f h) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$.
Suppose that $\operatorname{deg}(g)=\operatorname{deg}(\xi) \neq 2 \mathrm{~d}-\omega_{1}-\omega_{2}$. Let $X_{0}=X+\frac{\operatorname{div}(X)}{2 \mathrm{~d}-\omega_{1}-\omega_{2}-\operatorname{deg}(g)} W$. Then by Lemma III.1(b), $\xi=X(f)=$ $X_{0}(f)-\operatorname{div}\left(X_{0}\right) f$ and as in the previous paragraph, we need to consider the class of $\left(X_{0}(f h)-\operatorname{div}\left(X_{0}\right) f h\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ in $\mathrm{HP}_{\Pi}^{2}$.

By Lemma III. 5 (a), if $\operatorname{deg}\left(X_{0}\right)>0$ or $\operatorname{deg}(g)=\operatorname{deg}(\xi)>2 \mathrm{~d}-\omega_{1}-\omega_{2}=d-(-1) \cdot\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$, we have

$$
\left(X_{0}(f h)-\operatorname{div}\left(X_{0}\right) f h\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2} \text { and } \xi \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}
$$

If $\operatorname{deg}\left(X_{0}\right)=0$, that is $\operatorname{deg}(g)=\operatorname{deg}(\xi)=\mathrm{d}-0 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, then by Lemma III. 5 (b),

$$
\left(X_{0}(f h)-\operatorname{div}\left(X_{0}\right) f h\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=2 X_{0}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2} .
$$

Hence, $\xi \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 X_{0}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2}$.
If $\operatorname{deg}\left(X_{0}\right)<0$, that is, $\operatorname{deg}(g)=\operatorname{deg}(\xi)<\mathrm{d}-0 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, by Lemma III. 1 (c), define $X_{1}=h X_{0}-\frac{2}{\operatorname{deg}\left(X_{0}\right)} X_{0}(h) W$, then $\operatorname{deg}\left(X_{1}\right)=\operatorname{deg}\left(X_{0}\right)+\mathrm{d}-\omega_{1}-\omega_{2}$ and $X_{0}(f h)-\operatorname{div}\left(X_{0}\right) f h=X_{1}(f)-\operatorname{div}\left(X_{1}\right) f$. As above, by Lemma III. 5 (a), if $\operatorname{deg}\left(X_{1}\right)>0$, that is, $\mathrm{d}-0 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)>\operatorname{deg}(g)>\mathrm{d}-1 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, we obtain that

$$
\left(X_{1}(f h)-\operatorname{div}\left(X_{1}\right) f h\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \operatorname{HP}_{\Pi}^{2}, \text { and } \xi \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}
$$

If $\operatorname{deg}\left(X_{1}\right)=0$, by Lemma III. 5 (b), $\left(X_{1}(f h)-\operatorname{div}\left(X_{1}\right) f h\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=2 X_{1}(h) \in \operatorname{HP}_{\Pi}^{2}$ and $\xi \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 X_{1}(h) f \in \mathrm{HP}_{\Pi}^{2}$. If $\operatorname{deg}\left(X_{1}\right)<0$, i.e. $\operatorname{deg}(g)<\mathrm{d}-1 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, by Lemma III.1 (c), define $X_{2}=h X_{1}-\frac{2}{\operatorname{deg}\left(X_{2}\right)} X_{2}(h) W$ and we can continue as above.

Let $k$ be the first integer such that $\operatorname{deg}\left(X_{k}\right) \geq 0$. Then for $0 \leq i \leq k-1, \operatorname{deg}\left(X_{i}\right)<0$, we see that

$$
\left.\xi \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-\left(X_{k}(f h)-\operatorname{div}\left(X_{k}\right) f h\right)\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2}
$$

We distinguish two cases. When $\operatorname{deg}\left(X_{k}\right)>0$, by Lemma III. 5 (a), $\left.\xi \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-\left(X_{k}(f h)-\operatorname{div}\left(X_{k}\right) f h\right)\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$. If $\operatorname{deg}\left(X_{k}\right)=0$, i.e. $\operatorname{deg}(g)=\mathrm{d}-k \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, by Lemma III. 5 (b), $\left.\left(X_{k}(f h)-\operatorname{div}\left(X_{k}\right) f h\right)\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=2 X_{k}(h) \in \mathrm{HP}_{\Pi}^{2}$, and

$$
\left.\xi \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-\left(X_{k}(f h)-\operatorname{div}\left(X_{k}\right) f h\right)\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 X_{k}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2}
$$

## IV. WEDGE PRODUCTS AND SCHOUTEN-NIJENHUIS BRACKETS ON POISSON COHOMOLOGY

## A. Wedge products

Proposition IV.1. The wedge products $\wedge: \mathrm{HP}_{\Pi}^{0} \times \mathrm{HP}_{\Pi}^{i} \rightarrow \mathrm{HP}_{\Pi}^{i}, i=0,1,2$ are just the scalar product of $\mathbb{K}$-vector spaces; the map $\wedge: \mathrm{HP}_{\Pi}^{1} \times \mathrm{HP}_{\Pi}^{1} \rightarrow \mathrm{HP}_{\Pi}^{2}$ can be nonzero, but its only nonzero component is given by

$$
\mathbb{K}(1+h) H_{f} \times \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}(1+h) W \rightarrow \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}, \quad\left((1+h) H_{f}, g(1+h) W\right) \mapsto \mathrm{d} \cdot g f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}
$$

for $g \in \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}$; all other wedge products vanish.

Proof Since $\mathrm{HP}_{\Pi}^{0}=\mathbb{K} 1$, the maps $\wedge: \mathrm{HP}_{\Pi}^{0} \times \mathrm{HP}_{\Pi}^{i} \rightarrow \mathrm{HP}_{\Pi}^{i}, i=0,1,2$ are just the scalar product of $\mathbb{K}$-vector spaces.
It is easy to see that $(1+h) H_{f} \wedge(1+h) g W=\mathrm{d}(1+h)^{2} g f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$. Since $\operatorname{deg}(h g f)=3 \mathrm{~d}-2 \omega_{1}-2 \omega_{2}, \operatorname{deg}\left(h^{2} g f\right)=4 \mathrm{~d}-$ $3 \omega_{1}-3 \omega_{2}$ can not be written as $\mathrm{d}-k \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$ with $k \geq-1$ and are both greater than $2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, by Proposition III.6, $\mathrm{d}\left(2 h+h^{2}\right) g f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$. We obtain $\mathrm{d}(1+h)^{2} g f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\mathrm{d} g f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$.

The other statements are easy to show.

We can determine the algebra structure over $\mathrm{HP}_{\Pi}^{*}$ in terms of generators and relations. To this end, we need a notation. Given two augmented $\mathbb{K}$-algebra $A$ and $B$, i.e. $\mathbb{K}$-algebras equipped with a $\mathbb{K}$-algebra homomorphism to $\mathbb{K}$, the algebra $A \times_{\mathbb{K}} B$ is the fiber product in the category of augmented $\mathbb{K}$-algebras.


Theorem IV.2. We have an isomorphism of graded algebras

$$
\mathrm{HP}_{\Pi}^{*} \cong \mathbb{K}\left\langle u, v_{1} \cdots, v_{r}\right\rangle /\left(u^{2}, v_{1}^{2}, \cdots, v_{r}^{2}, u v_{i}+v_{i} u, v_{i} v_{j}, 1 \leq i, j \leq r\right) \times_{\mathbb{K}} \mathbb{K}\left[w_{1}\right] /\left(w_{1}^{2}\right) \times_{\mathbb{K}} \cdots \times_{\mathbb{K}} \mathbb{K}\left[w_{c}\right] /\left(w_{c}^{2}\right),
$$

with $|u|=\left|v_{1}\right|=\cdots=\left|v_{r}\right|=1,\left|w_{1}\right|=\cdots=\left|w_{c}\right|=2$. Here $|u|$ denotes the cohomological degree of $u$.
Proof Denote $u=(1+h) H_{f}, v_{i}=(1+h) e_{i} W, 1 \leq i \leq r, w_{j}=u_{j} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}, 1 \leq j \leq c$. By the preceding proposition, we obtain the result.

## B. Schouten-Nijenhuis brackets on $\mathrm{HP}_{\Pi_{0}}^{*}$

By dimension reason and as $\mathrm{HP}_{\Pi_{0}}^{0}=\mathbb{K}$, we only need to compute $[,]_{\mathbf{S N}}: \mathrm{HP}_{\Pi_{0}}^{1} \times \mathrm{HP}_{\Pi_{0}}^{1} \rightarrow \mathrm{HP}_{\Pi_{0}}^{1}$ and $[,]_{\mathbf{S N}}: \mathrm{HP}_{\Pi_{0}}^{1} \times \mathrm{HP}_{\Pi_{0}}^{2} \rightarrow$ $\mathrm{HP}_{\Pi_{0}}^{2}$. We need two formulae in the sequel: for all $f, g \in \mathscr{F}$,

$$
\begin{equation*}
\left[f \frac{\partial}{\partial x}, g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=\left(f \frac{\partial g}{\partial x}-g \frac{\partial f}{\partial x}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}, \quad\left[f \frac{\partial}{\partial y}, g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=\left(f \frac{\partial g}{\partial y}-g \frac{\partial f}{\partial y}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} . \tag{1}
\end{equation*}
$$

Lemma IV.3. The map $[,]_{\mathbf{S N}}: \mathrm{HP}_{\Pi_{0}}^{1} \times \mathrm{HP}_{\Pi_{0}}^{1} \rightarrow \mathrm{HP}_{\Pi_{0}}^{1}$ vanishes.
Proof We will deal with the most difficult case $\left[H_{f}, e_{i} W\right]_{\mathbf{S N}}, 1 \leq i \leq r$, the other cases being easy.
We have $\left[H_{f}, e_{i} W\right]_{\mathbf{S N}}=-\mathrm{d} f H_{e_{i}}$. Since $\operatorname{deg}\left(\mathrm{d} f H_{e_{i}}\right)=2 \mathrm{~d}-2 \omega_{1}-2 \omega_{2}>\mathrm{d}-\omega_{1}-\omega_{2}$, by 11 Lemma 4.4, $\mathrm{d} f H_{e_{i}}=0 \in \mathrm{HP}_{\Pi_{0}}^{1}$.

Proposition IV.4. All brackets in $[,]_{\mathbf{S N}}: \mathrm{HP}_{\Pi_{0}}^{1} \times \mathrm{HP}_{\Pi_{0}}^{2} \rightarrow \mathrm{HP}_{\Pi_{0}}^{2}$ vanish except possibly the component

$$
[-,-]_{\mathbf{S N}}: \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} W \times \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \rightarrow \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}
$$

Proof We need to show the following statements:
(a) For $1 \leq i \leq c,\left[u, w_{i}\right]_{\mathbf{S N}}=\left[H_{f}, u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=0 \in \mathrm{HP}_{\Pi_{0}}^{2}$;
(b) For $1 \leq i \leq r,\left[H_{f}, e_{i} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=0 \in \mathrm{HP}_{\Pi_{0}}^{2}$;
(c) For $1 \leq i, j \leq r,\left[e_{i} W, e_{j} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=0 \in \mathrm{HP}_{\Pi_{0}}^{2}$.

In fact, as $\operatorname{div}\left(H_{u_{i}}\right)=0$,

$$
\left[u, w_{i}\right]_{\mathbf{S N}}=\left[H_{f}, u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=-H_{u_{i}}(f) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-\left(H_{u_{i}}(f)-\operatorname{div}\left(H_{u_{i}}\right) f\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-\delta^{1}\left(H_{u_{i}}\right)
$$

so $\left[H_{f}, u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=0 \in \mathrm{HP}_{\Pi_{0}}^{2}$. The other two statements follow from $w_{i}=e_{i} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\frac{1}{d} u \wedge v_{i}$ and Theorem II. 2 (c).
Using (1), it is not difficult to see that $\left[e_{i} W, u_{j} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=\left(\operatorname{deg}\left(u_{j}\right)-d\right) e_{i} u_{j} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$. We can write $\left(\operatorname{deg}\left(u_{j}\right)-d\right) e_{i} u_{j}=$ $\sum_{k} \lambda_{k} u_{k}+\xi \in M_{f} \oplus I_{f}=\mathscr{F}$ with $\lambda_{k} \in \mathbb{K}$ and $\xi \in I_{f}$. If $\mathrm{d}-\omega_{1}-\omega_{2}+\operatorname{deg}\left(u_{j}\right)=\operatorname{deg}(\xi)=2 \mathrm{~d}-\omega_{1}-\omega_{2}$ and thus $\operatorname{deg}\left(u_{j}\right)=d$, but then $\left(\operatorname{deg}\left(u_{j}\right)-d\right) e_{i} u_{j}=0$ and so $\xi=0 \in \operatorname{HP}_{\Pi_{0}}^{2}$. If $\operatorname{deg}\left(u_{j}\right) \neq d$, by Proposition III.3,

$$
\left[e_{i} W, u_{j} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=\sum_{k} \lambda_{k} u_{k} \in \mathrm{HP}_{\Pi_{0}}^{2}
$$

Of course only those $u_{k}$ with $\operatorname{deg}\left(u_{k}\right)=\operatorname{deg}\left(u_{j}\right)+\mathrm{d}-\omega_{1}-\omega_{2}$ could occur.

## C. Schouten-Nijenhuis brackets on $\mathrm{HP}_{\Pi}^{*}$

Remember that in this case, we always assume $\mathrm{d}-\omega_{1}-\omega_{2}>0$.
By dimension reason and as $\mathrm{HP}_{\Pi}^{0}=\mathbb{K}$, we only need to consider $[,]_{\mathbf{S N}}: \mathrm{HP}_{\Pi}^{1} \times \mathrm{HP}_{\Pi}^{1} \rightarrow \mathrm{HP}_{\Pi}^{1}$ and $[,]_{\mathbf{S N}}: \mathrm{HP}_{\Pi}^{1} \times \mathrm{HP}_{\Pi}^{2} \rightarrow \mathrm{HP}_{\Pi}^{2}$.
Lemma IV.5. The map $[,]_{\mathbf{s N}}: \mathrm{HP}_{\Pi}^{1} \times \mathrm{HP}_{\Pi}^{1} \rightarrow \mathrm{HP}_{\Pi}^{1}$ vanishes.
Proof We will deal with the most difficult case $\left[u, v_{i}\right]_{\mathbf{S N}}, 1 \leq i \leq r$, the other cases being easy.
A direct computation shows that

$$
\left[u, v_{i}\right]_{\mathbf{S N}}=\left[(1+h) H_{f},(1+h) e_{i} W\right]_{\mathbf{S N}}=-\mathrm{d}(1+h) f H_{e_{i}(1+h)}
$$

Since the degrees of $\mathrm{d} f H_{e_{i}}$ and $\mathrm{d} f H_{e_{i} h}$ are all strictly larger than $\mathrm{d}-\omega_{1}-\omega_{2}$, by Ref. 11 Lemma 4.4, $\mathrm{d} f H_{e_{i}(1+h)}=0 \in \mathrm{HP}_{\Pi_{0}}^{1}$. By (the proof of) Theorem 4.6 of Ref. 11,

$$
\mathrm{d}(1+h) f H_{e_{i}(1+h)} \in B_{\Pi}^{1} \Leftrightarrow \frac{\mathrm{~d}(1+h) f}{1+h} H_{e_{i}(1+h)}=\mathrm{d} f H_{e_{i}(1+h)} \in B_{\Pi_{0}}^{1}
$$

Hence $\left[(1+h) H_{f},(1+h) e_{i} W\right]_{\mathbf{S N}}=0 \in \mathrm{HP}_{\Pi}^{1}$.

## Lemma IV.6. We have

(a) For $1 \leq i \leq r,\left[u, e_{i} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=\left[(1+h) H_{f}, e_{i} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=0 \in \mathrm{HP}_{\Pi}^{2}$.
(b) For $1 \leq i, j \leq r,\left[v_{i}, e_{j} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=\left[(1+h) e_{i} W, e_{j} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=0 \in \mathrm{HP}_{\Pi}^{2}$.

Proof The statements follow from Theorem II. 2 (c) and the previous lemma, as $e_{i} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\frac{1}{d} u \wedge v_{i}$.

Lemma IV.7. For all $1 \leq i \leq c,\left[u, w_{i}\right]_{\mathbf{S N}}=\left[(1+h) H_{f}, u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=0 \in \mathrm{HP}_{\Pi}^{2}$.
Proof Using (1), it is not difficult to see that

$$
\begin{aligned}
{\left[(1+h) H_{f}, u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}} } & =\left(-(1+h) H_{u_{i}}(f)+u_{i} H_{h}(f)\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \\
& =-\delta^{1}\left(H_{u_{i}}\right)+\left(-f H_{h}\left(u_{i}\right)+u_{i} H_{h}(f)\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \\
& =X(f) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \bmod B_{\Pi}^{2},
\end{aligned}
$$

where $X=-\frac{1}{d} H_{h}\left(u_{i}\right) W+u_{i} H_{h}$. Notice that $\operatorname{div}(X)=\frac{\omega_{1}+\omega_{2}-\operatorname{deg}\left(u_{i}\right)}{d} H_{h}\left(u_{i}\right)$.
As in Proposition III.6, denote $g=X(f) \in I_{f}$. Then $\operatorname{deg}(g)=2 \mathrm{~d}-2 \omega_{1}-2 \omega_{2}+\operatorname{deg}\left(u_{i}\right)$. It is equal to $\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$ with $k \geq-1$ if and only if $\operatorname{deg}\left(u_{i}\right)=\mathrm{d}-(k+2)\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$.

If $\operatorname{deg}(g)$ is not of the form $\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$ with $k \geq-1$. By Proposition III.6, $g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$.
Now suppose that $\operatorname{deg}(g)=\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$ with $k \geq-1$.
Let $k=-1$, i.e. $\operatorname{deg} u_{i}=\omega_{1}+\omega_{2}$ and $\operatorname{deg}(g)=2 \mathrm{~d}-\omega_{1}-\omega_{2}$. Then $\operatorname{div}(\mathrm{X})=0$ and

$$
g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=X(f) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\operatorname{div}(X) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}
$$

Let $k=0$. Then $\operatorname{deg}\left(u_{i}\right)=2 \omega_{1}+2 \omega_{2}-d$. Let $X_{0}=X+\frac{\operatorname{div}(X)}{\mathrm{d}-\omega_{1}-\omega_{2}-\operatorname{deg}(X)} W=u_{i} H_{h}$. Then $X(f)=X_{0}(f)-\operatorname{div}\left(X_{0}\right) f$. Remark that $X_{0}(h)=0$ and $X_{0}(f h)-\operatorname{div}\left(X_{0}\right) f h=h X(f)$. Hence,

$$
g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 X_{0}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \operatorname{HP}_{\Pi}^{2}
$$

Suppose that $k \geq 1$. Let $X_{1}=h X_{0}-\frac{2}{\operatorname{deg}\left(X_{0}\right)} X_{0}(h) W=h X_{0}$.
If $k=1$, then $\operatorname{deg}\left(u_{i}\right)=-2 d+3 \omega_{1}+3 \omega_{2}$ and

$$
g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 X_{1}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 h X_{0}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}
$$

By induction, $X_{i}=h^{i} X_{0}$ for $1 \leq i \leq k$ and

$$
g \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 X_{k}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 h^{k} X_{0}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}
$$

Lemma IV.8. For $1 \leq i \leq r$ and $1 \leq j \leq c$, we have

$$
\left[v_{i}, w_{j}\right]=\left[(1+h) e_{i} W, u_{j} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=\left(\left(\operatorname{deg} u_{j}-d\right) e_{i} u_{j}+\left(\operatorname{deg} u_{j}-2 d+\omega_{1}+\omega_{2}\right) h e_{i} u_{j}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}
$$

By Proposition III.6, there exists an algorithm to compute its class in $\mathrm{HP}_{\Pi}^{2}$.

Poisson cohomology of plane Poisson structures with isolated singularities revisited
Proof Using (1), we have

$$
\left[(1+h) e_{i} W, u_{j} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]_{\mathbf{S N}}=\left(\left(\operatorname{deg} u_{j}-d\right) e_{i} u_{j}+\left(\operatorname{deg} u_{j}-2 d+\omega_{1}+\omega_{2}\right) h e_{i} u_{j}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} .
$$

We will use Proposition III. 6 to compute its cohomology class in $\mathrm{HP}_{\Pi}^{2}$.
Let $g_{1}=\left(\operatorname{deg} u_{j}-d\right) e_{i} u_{j}$ and $g_{2}=\left(\operatorname{deg} u_{j}-2 d+\omega_{1}+\omega_{2}\right) h e_{i} u_{j}$. Notice that $\operatorname{deg}\left(g_{1}\right)=\mathrm{d}-\omega_{1}-\omega_{2}+\operatorname{deg}\left(u_{j}\right), \operatorname{deg}\left(g_{2}\right)=$ $2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)+\operatorname{deg}\left(u_{j}\right)$, and $\operatorname{deg}\left(u_{j}\right)=\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$ if and only if $\operatorname{deg}\left(g_{1}\right)=\mathrm{d}-(k-1)\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$ if and only if $\operatorname{deg}\left(g_{2}\right)=\mathrm{d}-(k-2)\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$.

Write $g_{1}=\sum_{s=1}^{c} \lambda_{s} u_{s}+Y(f)$ and $g_{2}=\sum_{s=1}^{c} \mu_{s} u_{s}+Z(f)$ for $\lambda_{s}, \mu_{s} \in \mathbb{K}$ and two vector fields $Y, Z$.
If there does not exist $k \geq 0$ such that $\operatorname{deg}\left(u_{j}\right)=\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, then

$$
\left[v_{1}, w_{j}\right]_{\mathbf{S N}}=\sum_{s=1}^{c}\left(\lambda_{s}+\mu_{s}\right) w_{s} \in \mathrm{HP}_{\Pi}^{2}
$$

Suppose there exists $k \geq 0$ such that $\operatorname{deg}\left(u_{j}\right)=\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$. Then $\operatorname{deg}\left(g_{1}\right)=\mathrm{d}-(k-1)\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$ and $\operatorname{deg}\left(g_{2}\right)=$ $\mathrm{d}-(k-2)\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$. We distinguish three cases: $k=0, k=1, k \geq 2$.

Let $k=0$. Then $k-1=-1, k-2=-2<-1$. We see

$$
\left[v_{1}, w_{j}\right]_{\mathbf{S N}}=\sum_{s=1}^{c} \mu_{s} w_{s}+\operatorname{div}(Y) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2}
$$

Let $k=1$. Then $k-1=0, k-2=-1$. Define as in Proposition III.6, $Y_{0}=Y+\frac{\operatorname{div}(Y)}{\mathrm{d}-\operatorname{deg}\left(u_{j}\right)} W$. We have

$$
\left[v_{1}, w_{j}\right]_{\mathbf{S N}}=\sum_{s=1}^{c} \lambda_{s} w_{s}+\left(-2 Y_{0}(h)+\operatorname{div}(Z)\right) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2} .
$$

Let $k \geq 2$. Then $k-1 \geq 1, k-2 \geq 0$. Define

$$
\begin{gathered}
Y_{t}=h Y_{t-1}-\frac{2}{\operatorname{deg}\left(Y_{t-1}\right)} Y_{t-1}(h) W, t=1, \cdots, k-1, \\
Z_{0}=Z+\frac{\operatorname{div}(Z)}{\mathrm{d}-\omega_{1}-\omega_{2}-\operatorname{deg}(Z)} W=Z+\frac{\operatorname{div}(Z)}{\omega_{1}+\omega_{2}-\operatorname{deg}\left(u_{j}\right)} W
\end{gathered}
$$

and

$$
Z_{t}=h Z_{t-1}-\frac{2}{\operatorname{deg}\left(Z_{t-1}\right)} Z_{t-1}(h) W, t=1, \cdots, k-2
$$

We obtain

$$
\left[v_{1}, w_{j}\right] \mathbf{S N}=\sum_{s=1}^{c}\left(\lambda_{s}+\mu_{s}\right) w_{s}-2\left(Y_{k-1}(h)+Z_{k-2}(h)\right) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2}
$$

Remark IV.9. All brackets vanish except

$$
[-,-]_{\mathbf{S N}}: \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}(1+h) W \times \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \rightarrow \mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \oplus \mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} .
$$

which is given by (the proof of) Lemma IV.8.
Since our computation in this section does not depend on the function algebra $\mathscr{F}$, we have obtained the following GAGA type result:

Theorem IV.10. There exist isomorphisms of Gerstenhaber algebras

$$
\operatorname{HP}_{\Pi}^{*}(\mathbb{C}\{x, y\}) \cong \operatorname{HP}_{\Pi}^{*}(\mathbb{C}[[x, y]]) \text { and } \operatorname{HP}_{\Pi}^{*}\left(C_{0}^{\infty}\left(\mathbb{R}^{2}\right)\right) \cong \operatorname{HP}_{\Pi}^{*}(\mathbb{R}\{x, y\}) \cong \operatorname{HP}_{\Pi}^{*}(\mathbb{R}[[x, y]])
$$

If $h=0$, one can also add the polynomial algebra in two variables into the statement.

Poisson cohomology of plane Poisson structures with isolated singularities revisited

## V. SIMPLE SINGULARITIES

For simple singularities, following the classification of V.I. Arnold ${ }^{1}$, we can determine the Gerstenhaber algebra structure over the Poisson cohomology of plane Poisson structures with simple singularities.

## A. Type $A_{2 p}: x^{2}+y^{2 p+1}, p \geq 1$

In this type $A_{2 p}, \Pi_{0}=f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}, f=x^{2}+y^{2 p+1}, \omega_{1}=2 p+1, \omega_{2}=2, d=4 p, \mathrm{~d}-\omega_{1}-\omega_{2}=2 p$. We have $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}=\mathscr{P}_{2 p}=$ $\mathbb{K} y^{2 p}, r=1, e_{1}=y^{2 p}$. We also have $\mathscr{M}_{f} \cong \mathbb{K}[y] /\left(y^{2 p}\right)$, so $c=2 p$ and choose $u_{i}=y^{i-1}, i=1, \cdots, 2 p$. Let

$$
u=H_{f}=(2 p+1) y^{2 p} \frac{\partial}{\partial x}-2 x \frac{\partial}{\partial y}, v_{1}=e_{1} W=y^{2 p}\left((2 p+1) x \frac{\partial}{\partial x}+2 y \frac{\partial}{\partial y}\right)
$$

which spans $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} W$, and $w_{i}=u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=y^{i-1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ with $1 \leq i \leq 2 p$, which form a basis of $\mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$.
By Theorem IV. 2 and Proposition IV.4, we have the following result:
Proposition V.1. Let $\Pi_{0}=\left(x^{2}+y^{2 p+1}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ be Type $A_{2 p}, p \geq 1$. We have an isomorphism of Gerstenhaber algebras

$$
\operatorname{HP}_{\Pi_{0}}^{*} \cong \wedge_{\mathbb{K}}\left(u, v_{1}\right) \times_{\mathbb{K}} \mathbb{K}\left[w_{1}\right] /\left(w_{1}^{2}\right) \times_{\mathbb{K}} \cdots \times_{\mathbb{K}} \mathbb{K}\left[w_{2 p}\right] /\left(w_{2 p}^{2}\right),
$$

with $|u|=1,\left|w_{1}\right|=\cdots=\left|w_{2 p}\right|=2$, where the brackets are all zero.

## B. Type $A_{2 p-1}^{ \pm}:\left(x^{2} \pm y^{2 p}\right)\left(1+\lambda y^{p-1}\right), p \geq 1$

In this type $A_{2 p-1}^{ \pm}, \Pi=f(1+h) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ with $f=x^{2} \pm y^{2 p}, h=\lambda y^{p-1}, \omega_{1}=p, \omega_{2}=1, d=2 p, \mathrm{~d}-\omega_{1}-\omega_{2}=p-1$. We have $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}=\mathscr{P}_{p-1}=\mathbb{K} y^{p-1}, r=1, e_{1}=y^{p-1}$. We also have $\mathscr{M}_{f} \cong \mathbb{K}[y] /\left(y^{2 p-1}\right)$, so $c=2 p-1$ and choose $u_{i}=y^{i-1}, i=$ $1, \cdots, 2 p-1$. As in Theorem IV.2, let

u=(1+h) H_{f}=\left(1+\lambda y^{p-1}\right)\left( \pm 2 p y^{2 p-1} \frac{\partial}{\partial x}-2 x \frac{\partial}{\partial y}\right), v_{1}=e_{1}(1+h) W=y^{p-1}\left(1+\lambda y^{p-1}\right)\left(p x \frac{\partial}{\partial x}+y \frac{\partial}{\partial y}\right)
$$

and $w_{i}=u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=y^{i-1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}, 1 \leq i \leq 2 p-1$. We have an isomorphism of graded algebras

\mathrm{HP}_{\Pi}^{*} \cong \wedge_{\mathbb{K}}\left(u, v_{1}\right) \times_{\mathbb{K}} \mathbb{K}\left[w_{1}\right] /\left(w_{1}^{2}\right) \times_{\mathbb{K}} \cdots \times_{\mathbb{K}} \mathbb{K}\left[w_{2 p-1}\right] /\left(w_{2 p-1}^{2}\right)
$$

Notice that by Proposition IV.1, $u \wedge v_{1}=2 p e_{1} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \in \mathrm{HP}_{\Pi}^{2}$.
Let us first consider the case $p=1$. In this case, $\mathrm{d}-\omega_{1}-\omega_{2}=0$ and we are in the situation of $\Pi_{0}=\left(x^{2} \pm y^{2}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$. By Subsection IV B, the only nonzero bracket is $\left[v_{1}, w_{1}\right]_{\mathbf{S N}}=\left[W, \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}\right]=-2 w_{1}$.

Suppose now that $p>1$. By Subsection IV C, we need to consider $\left[v_{1}, w_{j}\right]_{\mathbf{S N}}, j=1, \cdots, 2 p-1$. By Lemma IV.8, for $1 \leq$ $j \leq 2 p-1,\left[v_{1}, w_{j}\right]_{\mathbf{S N}}=\left((j-2 p-1) y^{p+j-2}+(j-3 p) \lambda y^{2 p+j-3}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$. As in Lemma IV.8, let $g_{1}=(j-2 p-1) y^{p+j-2}, g_{2}=$ $(j-3 p) \lambda y^{2 p+j-3}$. Then $\operatorname{deg}\left(g_{1}\right)=p+j-2$ and $\operatorname{deg}\left(g_{2}\right)=2 p+j-3$. We consider $k \in \mathbb{Z}$ such that $\operatorname{deg}\left(g_{1}\right)=\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\right.$ $\left.\omega_{2}\right)=2 p-k(p-1)$, then $\operatorname{deg}\left(g_{2}\right)=\mathrm{d}-(k-1)\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)=2 p-(k-1)(p-1)$ and $\operatorname{deg}\left(u_{j}\right)=\mathrm{d}-(k+1)\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)=$ $2 p-(k+1)(p-1)$. The restrictions are $0 \leq \operatorname{deg}\left(u_{j}\right) \leq 2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=2 p-2$ and the degrees of $g_{1}, g_{2}$ are all nonnegative. It is easy to see that all the possibilities are listed in Table II:

Case $k=1, p=2$. In this case, $j=3, u_{3}=y^{2}, g_{1}=-2 y^{3}, g_{2}=-3 \lambda y^{4}$. We have $g_{2}=Z(f) \in I_{f}$. with $Z=\mp \frac{3}{4} \lambda y \frac{\partial}{\partial y}$ and $\operatorname{div}(Z)=\mp \frac{3}{4} \lambda$. Since $\operatorname{deg}\left(g_{2}\right)=2 p=\mathrm{d}-0 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, by Proposition III.6, put

As $p=2$, $\operatorname{deg}\left(g_{1}\right)=p+1>2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=2 p-2$, then $g_{1}=-2 y^{3}=Y(f) \in I_{f}$ with $Y=\mp \frac{1}{2} \frac{\partial}{\partial y}$. Then $\operatorname{div}(Y)=0$. Since $\operatorname{deg}\left(g_{1}\right)=\mathrm{d}-1 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, by Proposition III.6, write $Y_{0}=Y+\frac{\operatorname{div}(Y)}{\mathrm{d}-\omega_{1}-\omega_{2}-\operatorname{deg}(Y)} W=Y=\mp \frac{1}{2} \frac{\partial}{\partial y}$ and $Y_{1}=h Y_{0}-$ $\frac{2}{\operatorname{deg}\left(Y_{0}\right)} Y_{0}(h) W=\mp \lambda\left(2 x \frac{\partial}{\partial x}+\frac{3}{2} y \frac{\partial}{\partial y}\right)$. Then $g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 Y_{1}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}= \pm \frac{3}{4} \lambda{ }^{2} u \wedge v_{1} \in \operatorname{HP}_{\Pi}^{2}$.

We have shown that if $k=1$ and $p=2,\left[v_{1}, w_{3}\right]_{\mathbf{S N}}= \pm \frac{3}{2} \lambda^{2} u \wedge v_{1} \in \mathrm{HP}_{\Pi}^{2}$.
Case $k=2, p=2$. In this case, $j=2, u_{2}=y, g_{1}=-3 y^{2}=-3 u_{3}, g_{2}=-4 \lambda y^{3}$. Then $g_{2}=Z(f) \in I_{f}$ with $Z=\mp \lambda \frac{\partial}{\partial y}$ and $\operatorname{div}(Z)=0$. Since $\operatorname{deg}\left(g_{2}\right)=d-1 \cdot\left(d-\omega_{1}-\omega_{2}\right)$, by Proposition III.6, put $Z_{0}=\mp \lambda \frac{\partial}{\partial y}$ and $Z_{1}=\mp \lambda^{2}\left(4 x \frac{\partial}{\partial x}+3 y \frac{\partial}{\partial y}\right)$. We have

We obtain $\left[v_{1}, w_{2}\right]_{\mathbf{S N}}=-3 w_{3} \pm \frac{3}{2} \lambda^{3} u \wedge v_{1} \in \mathrm{HP}_{\Pi}^{2}$.
Case $k=3, p=2$. In this case, $j=1, g_{1}=-4 y=-4 u_{2}, g_{2}=-5 \lambda y^{2}=-5 \lambda u_{3}$. We obtain $\left[v_{1}, w_{1}\right]_{\mathbf{S N}}=-4 w_{2}-5 \lambda w_{3} \in \mathrm{HP}_{\Pi}^{2}$.
Case $k=0, p=3$. In this case, $j=5, u_{j}=y^{4}, g_{1}=-2 y^{6}, g_{2}=-4 \lambda y^{8}$. Then $g_{1}=Y(f), g_{2}=Z(f) \in I_{f}$ with $Y=\mp \frac{1}{3} y \frac{\partial}{\partial y}$ and $Z=\mp \frac{2}{3} \lambda y^{3} \frac{\partial}{\partial y}$ and $\operatorname{div}(Y)=\mp \frac{1}{3}, \operatorname{div}(Z)=\mp 2 \lambda y^{2}$. Let $Y_{0}=\mp \frac{1}{2}\left(x \frac{\partial}{\partial x}+y \frac{\partial}{\partial y}\right)$. Since $\operatorname{deg}\left(g_{1}\right)=2 p=\mathrm{d}-0 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$ and $\operatorname{deg}\left(g_{2}\right)=3 p-1=\mathrm{d}-(-1) \cdot\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$, by Proposition III.6,

So $\left[v_{1}, w_{5}\right]_{\mathbf{S N}}=\left(-2 Y_{0}(h) f+\operatorname{div}(Z) f\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$.
Case $k=1, p=3$. In this case, $j=3, u_{3}=y^{2}, g_{1}=-4 y^{4}, g_{2}=-6 \lambda y^{6}$.
We have $g_{2}=Z(f) \in I_{f}$. with $Z=\mp \lambda y \frac{\partial}{\partial y}$ and $\operatorname{div}(Z)=\mp \lambda$. Since $\operatorname{deg}\left(g_{2}\right)=2 p=\mathrm{d}-0 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, by Proposition III.6, put $Z_{0}=\mp \frac{3}{2} \lambda\left(x \frac{\partial}{\partial x}+y \frac{\partial}{\partial y}\right)$ and $g_{2} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 Z_{0}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}= \pm 6 \lambda^{2} y^{2} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}= \pm 6 \lambda^{2} y^{2} e_{1} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}= \pm \lambda^{2} u \wedge v_{1} \in \operatorname{HP}_{\Pi}^{2}$. Since $p=3$, deg $\left(g_{1}\right)=p+1 \leq 2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=2 p-2$, then $g_{1}=-4 y^{4}=-4 u_{5} \in \mathscr{M}_{f}$. So $g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-4 u_{5} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=$ $-4 w_{5} \in \mathrm{HP}_{\Pi}^{2}$.

We have shown that if $k=1$ and $p=3,\left[v_{1}, w_{3}\right]_{\mathbf{S N}}=-4 w_{5} \pm \lambda^{2} u \wedge v_{1} \in \mathrm{HP}_{\Pi}^{2}$.
Case $k=2, p=3$. In this case, $j=1, g_{1}=-6 y^{2}=-6 u_{3}, g_{2}=-8 \lambda y^{4}=-8 \lambda u_{5}$. We obtain $\left[v_{1}, w_{1}\right]_{\mathbf{S N}}=-6 w_{3}-8 \lambda w_{5} \in$ $\mathrm{HP}_{\Pi}^{2}$.

Case $k=0, p>3$. In this case, $j=p+2, u_{j}=y^{p+1}, g_{1}=(1-p) y^{2 p}, g_{2}=2(1-p) \lambda y^{3 p-1}$. Then $g_{1}=Y(f), g_{2}=Z(f) \in$ $I_{f}$ with $Y= \pm \frac{1-p}{2 p} y \frac{\partial}{\partial y}$ and $Z= \pm \frac{1-p}{p} \lambda y^{p} \frac{\partial}{\partial y}$ and $\operatorname{div}(Y)= \pm \frac{1-p}{2 p}, \operatorname{div}(Z)= \pm \lambda(1-p) y^{p-1}$. Let $Y_{0}=\mp \frac{1}{2}\left(x \frac{\partial}{\partial x}+y \frac{\partial}{\partial y}\right)$. Since $\operatorname{deg}\left(g_{1}\right)=2 p=\mathrm{d}-0 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$ and $\operatorname{deg}\left(g_{2}\right)=3 p-1=\mathrm{d}-(-1) \cdot\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$, by Proposition III.6,

with $|u|=\left|v_{1}\right|=1,\left|w_{1}\right|=\cdots=\left|w_{p-1}\right|=\left|w_{p}^{\prime}\right|=\cdots=\left|w_{2 p-1}^{\prime}\right|=2$ and the nontrivial brackets are given by

Define $w_{2}^{\prime}=-4 w_{2}-5 \lambda w_{3}, w_{3}^{\prime}=\left[v_{1}, w_{2}^{\prime}\right]_{\mathbf{S N}}=12 w_{3} \mp \frac{27}{2} \lambda^{3} u \wedge v_{1}$. Then $\left[v_{1}, w_{3}^{\prime}\right]_{\mathbf{S N}}= \pm 18 \lambda^{2} u \wedge v_{1}$. If $\lambda \neq 0$, put $u^{\prime}= \pm 18 \lambda^{2} u$, otherwise, do not change $u$, then we have the desired result.

For $j=2, g_{1}=-5 y^{3}=-5 u_{4}$ and $g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-5 w_{4} \in \mathrm{HP}_{\Pi}^{2} . g_{2}=-7 \lambda y^{5}=$ $Z(f) \in I_{f}$, so $g_{2} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$. We obtain $\left[v_{1}, w_{2}\right]_{\mathbf{S N}}=-5 w_{4} \in \mathrm{HP}_{\Pi}^{2}$. For $j=4, g_{1}=-3 y^{6}, g_{2}=-5 \lambda y^{7} \in I_{f}$, so $\left[v_{1}, w_{4}\right]_{\mathbf{S N}}=$ $0 \in \mathrm{HP}_{\Pi}^{2}$.

Put $w_{3}^{\prime}=-6 w_{3}-8 \lambda w_{5}, w_{4}^{\prime}=-5 w_{4}, w_{5}^{\prime}=24 w_{5} \mp 6 \lambda^{2} u \wedge v_{1}$, then the result follows.

For $j=p+1$ or $p+3 \leq j \leq 2 p-1, g_{1}=(j-2 p-1) y^{p+j-2}, g_{2}=(j-3 p) \lambda y^{2 p+j-3} \in I_{f}$. So by Proposition III.6,

Put $w_{p}^{\prime}=-2 p w_{p}+(1-3 p) \lambda w_{2 p-1}, w_{p+1}^{\prime}=(1-2 p) w_{p+1}, w_{p+2}^{\prime}=2(1-p) w_{p+2} \pm \frac{3(p-1)}{2 p} \lambda^{2} u \wedge v_{1}$ and $w_{j}^{\prime}=(j-3 p) w_{j}, j=$ $p+3, \cdots, 2 p-2$ and $w_{2 p-1}^{\prime}=2 p(2 p+1) w_{2 p-1}$, then we obtain the desired result.

In this case, $f=x^{2} y \pm y^{2 p-1}, h=\lambda x+\mu y^{p-1}, \omega_{1}=p-1, \omega_{2}=1, d=2 p-1$ and $\mathrm{d}-\omega_{1}-\omega_{2}=p-1$. A basis of $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}=$ $\mathscr{P}_{p-1}$ is given by $\left\{e_{1}:=y^{p-1}, e_{2}:=x\right\}$ and $r=2$. Since $I_{f}=\left(\frac{\partial f}{\partial x}, \frac{\partial f}{\partial y}\right)=\left(2 x y, x^{2} \pm(2 p-1) y^{2 p-2}\right)$, then $c=2 p$ and a monomial basis of $\mathscr{M}_{f}=\mathscr{F} / I_{f}$ can be chosen as

u_{1}:=1, u_{2}:=y, u_{3}:=y^{2}, \cdots, u_{2 p-2}:=y^{2 p-3}, u_{2 p-1}:=y^{2 p-2}, u_{2 p}=x
$$

whose degrees are respectively $0,1, \cdots, 2 p-2, p-1$.
Let $u=(1+h) H_{f}=\left(1+\lambda x+\mu y^{p-1}\right)\left(\left(x^{2} \pm(2 p-1) y^{2 p-2}\right) \frac{\partial}{\partial x}-2 x y \frac{\partial}{\partial y}\right), v_{1}=(1+h) e_{1} W=\left(1+\lambda x+\mu y^{p-1}\right) y^{p-1}((p-$ 1) $\left.x \frac{\partial}{\partial x}+y \frac{\partial}{\partial y}\right)$ and $v_{2}=(1+h) e_{2} W=\left(1+\lambda x+\mu y^{p-1}\right) x\left((p-1) x \frac{\partial}{\partial x}+y \frac{\partial}{\partial y}\right)$. A basis of $\mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ is given by $u_{1} \frac{\partial}{\partial x} \wedge$ $\frac{\partial}{\partial y}, \cdots, u_{2 p} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$, and $e_{1} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}, e_{2} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ form a basis of $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$. Denote $w_{j}=u_{j} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}, j=1, \cdots, 2 p$.

By Theorem IV.2, we have an isomorphism of graded algebras

\mathrm{HP}_{\Pi}^{*} \cong \mathbb{K}\left\langle u, v_{1}, v_{2}\right\rangle /\left(u^{2}, v_{1}^{2}, v_{2}^{2}, u v_{1}+v_{1} u, u v_{2}+v_{2} u, v_{1} v_{2}\right) \times_{\mathbb{K}} \mathbb{K}\left[w_{1}\right] /\left(w_{1}^{2}\right) \times_{\mathbb{K}} \cdots \times_{\mathbb{K}} \mathbb{K}\left[w_{2 p}\right] /\left(w_{2 p}^{2}\right)
$$

By Subsection IV C, to compute the bracket, we need to consider $\left[v_{i}, w_{j}\right]{ }_{\mathbf{S N}}, i=1,2, j=1, \cdots, 2 p$.

## 1. $\left[v_{1}, w_{j}\right]$

By Lemma IV.8, for $1 \leq j \leq 2 p$,

& =\left(\left(\operatorname{deg}\left(u_{j}\right)-2 p+1\right) y^{p-1} u_{j}+\left(\operatorname{deg}\left(u_{j}\right)-3 p+2\right)\left(\lambda x+\mu y^{p-1}\right) y^{p-1} u_{j}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}
\end{aligned}
$$

As in Lemma IV.8, let $g_{1}=\left(\operatorname{deg}\left(u_{j}\right)-2 p+1\right) y^{p-1} u_{j}$ and $g_{2}=\left(\operatorname{deg}\left(u_{j}\right)-3 p+2\right)\left(\lambda x+\mu y^{p-1}\right) y^{p-1} u_{j}$.
It is easy to see that $\operatorname{deg}\left(g_{1}\right)=p-1+\operatorname{deg}\left(u_{j}\right)=\mathrm{d}-k \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=2 p-1-k(p-1)$ with $k \geq-1$ if and only if $k=0,1$ or ( $k=2$ and $p=2$ ).

Let $k=0$. Then $\operatorname{deg}\left(u_{j}\right)=p, u_{j}=y^{p}, j=p+1, g_{1}=(1-p) y^{2 p-1}$. Since $\operatorname{deg}\left(g_{1}\right)=2 p-1>2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=2 p-2$, $g_{1} \in I_{f}$ and $g_{1}=Y(f)$ with $Y= \pm \frac{p-1}{2(2 p-1)}\left(x \frac{\partial}{\partial x}-2 y \frac{\partial}{\partial y}\right)$. Let $Y_{0}=\mp \frac{1}{2} y \frac{\partial}{\partial y}$. By Proposition III.6, we obtain that

g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 Y_{0}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}= \pm \mu(p-1) y^{p-1} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}= \pm \frac{p-1}{2 p-1} \mu u \wedge v_{1} \in \operatorname{HP}_{\Pi}^{2}
$$

Let $k=1$. Then $\operatorname{deg}\left(u_{j}\right)=1$. If $p>2$, then $u_{j}=y, j=2, g_{1}=2(1-p) y^{p}=2(1-p) u_{p+1}$. By Proposition III.6, we see that

g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=2(1-p) w_{p+1} \in \mathrm{HP}_{\Pi}^{2}
$$

If $p=2$, then either $u_{j}=y, j=2, g_{1}=-2 y^{2}=-2 u_{3}$, or $u_{j}=x, j=4, g_{1}=-2 x y$. In the first case, by Proposition III. 6 , we see

g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 u_{3} \in \mathrm{HP}_{\Pi}^{2}
$$

in the second case, $g_{1}=Y(f)$ with $Y=-\frac{\partial}{\partial x}$. Let $Y_{0}=-\frac{\partial}{\partial x}$ and $Y_{1}=-(3 \lambda x+\mu y) \frac{\partial}{\partial x}-2 \lambda y \frac{\partial}{\partial y}$. By Proposition III.6,

g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 Y_{1}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=6 \lambda(\lambda x+\mu y) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=2 \lambda\left(\mu u \wedge v_{1}+\lambda u \wedge v_{2}\right) \in \operatorname{HP}_{\Pi}^{2} .
$$

Let $k=2$. Then $p=2, \operatorname{deg}\left(u_{j}\right)=0, u_{j}=1, j=1, g_{1}=-3 y=-3 u_{2}$. By Proposition III.6, we see that

g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-3 w_{2} \in \mathrm{HP}_{\Pi}^{2}
$$

Suppose that there is no $k \geq-1$ such that $\operatorname{deg}\left(g_{1}\right)=p-1+\operatorname{deg}\left(u_{j}\right)=\mathrm{d}-k \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=2 p-1-k(p-1)$. Then $p>2$ and $j \neq p+1,2$. If $j=1$ or $3 \leq j \leq p$, then $g_{1}=(j-2 p) y^{p+j-2}=(j-2 p) u_{p+j-1}$ and by Proposition III.6,

g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=(j-2 p) w_{p+j-1} \in \mathrm{HP}_{\Pi}^{2}
$$

if $p+2 \leq j \leq 2 p-1$, then $g_{1}=(j-2 p) y^{p+j-2} \in I_{f}$, by Proposition III.6,

g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}
$$

because $p+j-2>2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=2 p-2$ and $g_{1} \in I_{f} ;$ if $j=2 p$, then $g_{1}=-p x y^{p-1} \in I_{f}$ and by Proposition III.6,

$$
g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}
$$

We have proved the following: If $p=2$,

g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}= \begin{cases}-3 w_{2}, & j=1 \\ -2 w_{3}, & j=2 \\ \pm \frac{1}{3} \mu u \wedge v_{1}, & j=3 \\ 2 \lambda\left(\mu u \wedge v_{1}+\lambda u \wedge v_{2}\right), & j=4\end{cases}
$$

if $p>2$,

g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}= \begin{cases}(1-2 p) w_{p}, & j=1 \\ 2(1-p) w_{p+1}, & j=2 \\ (j-2 p) w_{p+j-1}, & 3 \leq j \leq p \\ \pm \frac{p-1}{2 p-1} \mu u \wedge v_{1}, & j=p+1 \\ 0 & p+1 \leq j \leq 2 p\end{cases}
$$

Now consider $g_{2}=\left(\operatorname{deg}\left(u_{j}\right)-3 p+2\right)\left(\lambda x+\mu y^{p-1}\right) y^{p-1} u_{j}$. It is easy to see that $\operatorname{deg}\left(g_{2}\right)=2(p-1)+\operatorname{deg}\left(u_{j}\right)=\mathrm{d}-\ell \cdot(\mathrm{d}-$ $\left.\omega_{1}-\omega_{2}\right)=2 p-1-\ell(p-1)$ with $\ell \geq-1$ if and only if $\ell=-1,0,1$ and $\ell=1$ only when $p=2$.

Let $\ell=1$. Then $p=2$ and $\operatorname{deg}\left(u_{j}\right)=0, u_{j}=1, j=1$. We see $g_{2}=-4(\lambda x+\mu y) y=-4 \mu u_{3}+Z(f)$ with $Z=-2 \lambda \frac{\partial}{\partial x}$. Let $Z_{0}=-2 \lambda \frac{\partial}{\partial x}$ and $Z_{1}=\left(-6 \lambda^{2} x-2 \lambda \mu y\right) \frac{\partial}{\partial x}-4 \lambda^{2} y \frac{\partial}{\partial y}$. Then

g_{2} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-4 \mu w_{3}-2 Z_{1}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-4 \mu w_{3}+4 \lambda^{2} \mu u \wedge v_{1}+4 \lambda^{3} u \wedge v_{2} \in \mathrm{HP}_{\Pi}^{2}
$$

Let $\ell=0$. Then $\operatorname{deg}\left(u_{j}\right)=1$. There are two cases: either $u_{j}=y, j=2, g_{2}=3(1-p)\left(\lambda x+\mu y^{p-1}\right) y^{p}$, or $p=2, j=4, u_{j}=$ $x, g_{2}=3(1-p)(\lambda x+\mu y) x y$.

In the first case, since $\operatorname{deg}\left(g_{2}\right)=2 p-1>2\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=2 p-2, g_{2} \in I_{f}$ and $g_{2}=Z(f)$ with

Z=\left(\frac{3}{2}(1-p) \lambda y^{p-1} \pm \frac{3(p-1)}{2(2 p-1)} \mu x\right) \frac{\partial}{\partial x} \mp \frac{3(p-1)}{2 p-1} \mu y \frac{\partial}{\partial y} .

Let $Z_{0}=\frac{3}{2}(1-p) \lambda y^{p-1} \frac{\partial}{\partial x} \mp \frac{3}{2} \mu y \frac{\partial}{\partial y}$. We obtain that

g_{2} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 Z_{0}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\frac{3(p-1)}{2 p-1}\left(\lambda^{2} \pm \mu^{2}\right) u \wedge v_{1} \in \mathrm{HP}_{\Pi}^{2}
$$

In the second case, $p=2, j=4, u_{j}=x, g_{2}=-3(\lambda x+\mu y) x y$. The space $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}=\mathscr{P}_{2 p-1}$ is one-dimensional with $e_{1}=x$ as a basis. Since $I_{f}=\left\langle\frac{\partial f}{\partial x}, \frac{\partial f}{\partial y}\right\rangle=\left\langle 2 x y, x^{2}+2 p y^{2 p-1}\right\rangle$, we can take $\left\{u_{1}=1, \cdots, u_{2 p}=y^{2 p-1}, u_{2 p+1}=x,\right\}$ as a monomial basis of $\mathscr{M}_{f}=\mathscr{F}\left(\mathbb{K}^{2}\right) / I_{f}$, whose degrees are respectively $0,2, \cdots, 2(2 p-$ 1), $2 p-1$. Let

which is a basis of $\mathrm{HP}_{\Pi}^{1}$, and $w_{i}=u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ for $1 \leq i \leq 2 p+1$ which form a basis of $\mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$. We have an isomorphism of graded algebras $\mathrm{HP}_{\Pi}^{*} \cong \wedge_{\mathbb{K}}\left(u, v_{1}\right) \times_{\mathbb{K}} \mathbb{K}\left[w_{1}\right] /\left(w_{1}^{2}\right) \times_{\mathbb{K}} \cdots \times_{\mathbb{K}} \mathbb{K}\left[w_{2 p+1}\right] /\left(w_{2 p+1}^{2}\right)$. Notice that by Proposition IV.1, $u \wedge v_{1}=$ $4 p e_{1} f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$.

By Subsection IV C, to compute the bracket, we need to consider $\left[v_{1}, w_{j}\right]_{\mathbf{S N}}, j=1, \cdots, 2 p+1$.
By Lemma IV.8, for $1 \leq j \leq 2 p-1, \quad\left[v_{1}, w_{j}\right]_{\mathbf{S N}}=\left(\left(\operatorname{deg}\left(u_{j}\right)-4 p\right) x u_{j}+\left(\operatorname{deg}\left(u_{j}\right)-6 p+1\right) \lambda x^{2} u_{j}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y} \quad$ Let $g_{1}=$ $\left(\operatorname{deg}\left(u_{j}\right)-4 p\right) x u_{j}$ and $g_{2}=\left(\operatorname{deg}\left(u_{j}\right)-6 p+1\right) \lambda x^{2} u_{j}$. It is easy to see that $\operatorname{deg}\left(g_{1}\right)=2 p-1+\operatorname{deg}\left(u_{j}\right)=\mathrm{d}-k \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=$ $4 p-k(2 p-1)$ with $k \geq-1$ if and only if $k=0$ or 1 .

Let $k=0$. Then $\operatorname{deg}\left(u_{j}\right)=2 p+1$, but there is no $u_{j}$ such that $\operatorname{deg}\left(u_{j}\right)=2 p+1$. So this case is also impossible.
Let $k=1$. Then $\operatorname{deg}\left(u_{j}\right)=2, u_{j}=y, j=2, g_{1}=(2-4 p) x y$. We see that $g_{1}=Y(f)$ with $Y=(1-2 p) \frac{\partial}{\partial x}$. Let $Y_{0}=(1-2 p) \frac{\partial}{\partial x}$, and $Y_{1}=3 \lambda(1-2 p) x \frac{\partial}{\partial x}-4 \lambda y \frac{\partial}{\partial y}$. We obtain that $g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 Y_{1}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\frac{3(2 p-1)}{2 p} \lambda^{2} u \wedge v_{1} \in \mathrm{HP}_{\Pi}^{2}$.

Suppose that there is no $k \geq-1$ such that $\operatorname{deg}\left(g_{1}\right)=\mathrm{d}-k \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=2 p-1-k(p-1)$. Then $j \neq 2$. If $j=1$, $g_{1}=-4 p x=-4 p u_{2 p+1}$, so $g_{1} \frac{\bar{\partial}}{\partial x} \wedge \frac{\partial}{\partial y}=-4 p w_{2 p+1} \in \mathrm{HP}_{\Pi}^{2}$; if $3 \leq j \leq 2 p, g_{1}=(2 j-2-4 p) x y^{j-1} \in I_{f}$, so $g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$; if $j=2 p+1$, then $g_{1}=-(1+2 p) x^{2}=2 p(1+2 p) u_{2 p} \bmod I_{f}$, so $g_{1} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=2 p(1+2 p) w_{2 p} \in \operatorname{HP}_{\Pi}^{2}$.

Poisson cohomology of plane Poisson structures with isolated singularities revisited

It is easy to see that $\operatorname{deg}\left(g_{2}\right)=4 p-2+\operatorname{deg}\left(u_{j}\right)=\mathrm{d}-\ell \cdot\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)=4 p-\ell(2 p-1)$ with $\ell \geq-1$ if and only if $\ell=0$ or -1 .

Let $\ell=-1$. Then $\operatorname{deg}\left(u_{j}\right)=2 p+1$, but there is no $u_{j}$ such that $\operatorname{deg}\left(u_{j}\right)=2 p+1$. So this case is impossible.
Let $\ell=0$. Then $\operatorname{deg}\left(u_{j}\right)=2, u_{j}=y, j=2, g_{2}=3(1-2 p) \lambda x^{2} y$. We see that $g_{2}=Z(f)$ with $Z=\frac{3}{2} \lambda(1-2 p) x \frac{\partial}{\partial x}$. Let $Z_{0}=-3 \lambda\left((2 p-1) x \frac{\partial}{\partial x}+y \frac{\partial}{\partial y}\right)$, and we obtain that $g_{2} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=-2 Z_{0}(h) f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=\frac{3(2 p-1)}{2 p} \lambda^{2} u \wedge v_{1} \in \mathrm{HP}_{\Pi}^{2}$.

Suppose that there is no $\ell \geq-1$ such that $\operatorname{deg}\left(g_{2}\right)=\mathrm{d}-\ell \cdot\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)=4 p-\ell(2 p-1)$. Then $j \neq 2$. If $j=1, g_{2}=$ $(1-6 p) \lambda x^{2}=2 p(6 p-1) \lambda u_{2 p} \bmod I_{f}$, so $g_{2} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=2 \lambda p(6 p-1) w_{2 p} \in \mathrm{HP}_{\Pi}^{2}$; if $3 \leq j \leq 2 p, g_{2}=(2 j-6 p-1) x y^{j-1} \in I_{f}$, so $g_{2} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$; if $j=2 p+1$, then $g_{1}=-4 p \lambda x^{3} \in I_{f}$, so $g_{2} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}=0 \in \mathrm{HP}_{\Pi}^{2}$.

We obtain

When $\lambda \neq 0$, let $w_{2 p+1}^{\prime}=2 \lambda p(6 p-1) w_{2 p}-4 p w_{2 p+1}, w_{2 p}^{\prime}=2 p(1+2 p) w_{2 p}$, and we need to put moreover $u^{\prime}=\frac{3(2 p-1)}{p} \lambda^{2} u$, then $\left[v_{1}, w_{2}\right]=u^{\prime} \wedge v_{1}$.

## E. Type $E_{6}: x^{3}+y^{4}$

In this type $E_{6}, \Pi=\Pi_{0}=f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ with $f=x^{3}+y^{4}, \omega_{1}=4, \omega_{2}=3, d=12, \mathrm{~d}-\omega_{1}-\omega_{2}=5$. We have $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}=\mathscr{P}_{5}=0$ and $\mathscr{M}_{f} \cong \mathbb{K}[x, y] /\left(x^{2}, y^{3}\right)$, so $c=6$ and choose a basis of $\mathscr{M}_{f}$ as $\left\{u_{1}=1, u_{2}=y, u_{3}=x, u_{4}=y^{2}, u_{5}=x y, u_{6}=x y^{2}\right\}$, whose degrees are respectively $0,3,4,6,7,10$. Let $u=H_{f}=4 y^{3} \frac{\partial}{\partial x}-3 x^{2} \frac{\partial}{\partial y}$, and $w_{i}=u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ with $1 \leq i \leq 6$, which form a basis of $\mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$.

By Theorem IV. 2 and Subsection IV B, we obtain the following result:
Proposition V.5. Let $\Pi_{0}=\left(x^{3}+y^{4}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ be Type $E_{6}$. We have an isomorphism of Gerstenhaber algebras

We have $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}=\mathscr{P}_{4}=\mathbb{K} y^{2}$, and $r=$ $1, e_{1}=y^{2}$. We also have $\mathscr{M}_{f} \cong \mathbb{K}[x, y] /\left(3 x^{2}+y^{3}, x y^{2}\right)$, so $c=7$ and choose a monomial basis of $\mathscr{M}_{f}: u_{1}=1, u_{2}=y, u_{3}=x, u_{4}=$ $y^{2}, u_{5}=x y, u_{6}=y^{3}, u_{7}=y^{4}$ whose degrees are respectively $0,2,3,4,5,6,8$.

As in Theorem IV.2, denote $u=(1+h) H_{f}=\left(1+\lambda y^{2}\right)\left(3 x y^{2} \frac{\partial}{\partial x}-\left(3 x^{2}+y^{3}\right) \frac{\partial}{\partial y}\right)$, and $v_{1}=e_{1}(1+h) W=y^{2}\left(1+\lambda y^{2}\right)\left(3 x \frac{\partial}{\partial x}+\right.$ $2 y \frac{\partial}{\partial y}$ ) which spans $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}(1+h) W$, and $w_{i}=u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ with $1 \leq i \leq 7$, which form a basis of $\mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$. We have an isomorphism of graded algebras

By Lemma IV.8, for $1 \leq j \leq 7, \quad\left[v_{1}, w_{j}\right]_{\mathbf{S N}}=\left(\left(\operatorname{deg}\left(u_{j}\right)-9\right) y^{2} u_{j}+\left(\operatorname{deg}\left(u_{j}\right)-13\right) \lambda y^{4} u_{j}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ As in Lemma IV.8, let $g_{1}=$ $\left(\operatorname{deg}\left(u_{j}\right)-9\right) y^{2} u_{j}, g_{2}=\left(\operatorname{deg}\left(u_{j}\right)-13\right) \lambda y^{4} u_{j}$. Then $\operatorname{deg}\left(g_{1}\right)=\operatorname{deg}\left(u_{j}\right)+4, \operatorname{deg}\left(g_{2}\right)=\operatorname{deg}\left(u_{j}\right)+8$.

We consider $k \in \mathbb{Z}$ such that $\operatorname{deg}\left(g_{1}\right)=\mathrm{d}-k\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)=9-4 k$, and in this case, $\operatorname{deg}\left(u_{j}\right)=9-4(k+1)$ and $\operatorname{deg}\left(g_{2}\right)=$ $9-4(k+1)$. The restrictions are $\operatorname{deg}\left(u_{j}\right) \in\{0,2,3,4,5,6,8\}$, and the degrees of $g_{1}, g_{2}$ are all nonnegative. It is easy to see that $k=0$ and in this case, $\operatorname{deg}\left(u_{j}\right)=5, j=5, u_{j}=x y, g_{1}=-4 x y^{3}, g_{2}=-8 \lambda x y^{5}$.

We see that $g_{1}=Y(f) \in I_{f}$ with $Y=-\frac{4}{3} y \frac{\partial}{\partial y}$ and $\operatorname{div}(Y)=-\frac{4}{3}$. Since $\operatorname{deg}\left(g_{1}\right)=9=\mathrm{d}-0 \cdot\left(\mathrm{~d}-\omega_{1}-\omega_{2}\right)$, by Proposition III.6, let $Y_{0}=-x \frac{\partial}{\partial x}-2 y \frac{\partial}{\partial y}$. Then

Since $\operatorname{deg}\left(g_{2}\right)=13=\mathrm{d}-(-1) \cdot\left(\mathrm{d}-\omega_{1}-\omega_{2}\right)$, and $g_{2}=Z(f) \in I_{f}$ with $Z=-\frac{8}{3} \lambda y^{3} \frac{\partial}{\partial y}$ and $\operatorname{div}(Z)=-8 \lambda y^{2}$, by Proposition III.6,

In this type $E_{8}, \Pi=\Pi_{0}=f \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$, with $f=x^{3}+y^{5}, \omega_{1}=5, \omega_{2}=3, d=15, \mathrm{~d}-\omega_{1}-\omega_{2}=7$. We have $\mathscr{P}_{\mathrm{d}-\omega_{1}-\omega_{2}}=\mathscr{P}_{7}=0$ and $\mathscr{M}_{f} \cong \mathbb{K}[x, y] /\left(x^{2}, y^{4}\right)$, so $c=8$ and choose a basis of $\mathscr{M}_{f}$ as $u_{1}=1, u_{2}=y, u_{3}=x, u_{4}=y^{2}, u_{5}=x y, u_{6}=y^{3}, u_{7}=x y^{2}, u_{8}=$ $x y^{3}$. Let $u=H_{f}=5 y^{4} \frac{\partial}{\partial x}-3 x^{2} \frac{\partial}{\partial y}$, and $w_{i}=u_{i} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ with $1 \leq i \leq 8$, which form a basis of $\mathscr{M}_{f} \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$. We have the following result:

Poisson cohomology of plane Poisson structures with isolated singularities revisited
Proposition V.7. Let $\Pi_{0}=\left(x^{3}+y^{5}\right) \frac{\partial}{\partial x} \wedge \frac{\partial}{\partial y}$ be Type $E_{8}$. We have an isomorphism of Gerstenhaber algebras
