# Introducing prior information in Weighted Likelihood Bootstrap with applications to model misspecification

#### Abstract

We propose Posterior Bootstrap, a set of algorithms extending Weighted Likelihood Bootstrap, to properly incorporate prior information and address the problem of model misspecification in Bayesian inference. We consider two approaches to incorporating prior knowledge: the first is based on penalization of the Weighted Likelihood Bootstrap objective function, and the second uses pseudo-samples from the prior predictive distribution. We also propose methodology for hierarchical models, which was not previously known for methods based on Weighted Likelihood Bootstrap. Edgeworth expansions guide the development of our methodology and allow us to provide greater insight on properties of Weighted Likelihood Bootstrap than were previously known. Our experiments confirm the theoretical results and show a reduction in the impact of model misspecification against Bayesian inference in the misspecified setting.


## 1 Introduction

### 1.1 Model misspecification and robust inference in Bayesian statistics

Bayesian inference relies on an assumption that the true data-generating mechanism is known. However, in practice the models only provide an approximate reflection of the reality, so model misspecification is a frequent concern [De Blasi and Walker, 2013, Walker, 2013, Lyddon et al., 2019]. Throughout the paper we write $x_{1}, \ldots, x_{n} \sim f(x \mid \theta)$ to denote that $x_{1}, \ldots, x_{n}$ are independent and identically distributed according to a distribution with density $f(x \mid \theta)$. We consider a generic parametric Bayesian model for parameter of interest $\theta \in \mathbb{R}^{d}$

x_{1}, \ldots, x_{n} \sim f(x \mid \theta), \quad \theta \sim \pi(\theta), \quad \theta \in \Theta \tag{1}
\end{equation*}

with prior $\pi$ and likelihood function $f$.
Misspecification of model (1) occurs when data is generated from a distribution $P^{*}$ with density $p^{*}$, which is not equal to $f(x \mid \theta)$ for any $\theta \in \Theta$. In this case under regularity conditions the Bayesian posterior asymptotically concentrates around the pseudo-true parameter $\theta^{*}$ minimizing $D_{K L}\left(p^{*}| | f\right)$, the KullbackLeibler divergence between $f(\cdot \mid \theta), \theta \in \Theta$, and $p^{*}$ [Berk, 1966, 1970, Bunke and Milhaud, 1998]. Applying standard Bayesian inference to misspecified models leads to misleading uncertainty estimates [Kleijn and Van der Vaart, 2012], so there has been increasing interest in robust inference schemes [Grünwald and van Ommen, 2017, Jewson et al., 2018, Hong and Martin, 2020].

One method that has gained a lot of popularity replaces the likelihood $f(x \mid \theta)$ by a power likelihood $f(x \mid \theta)^{\eta}$ for a parameter $\eta>0$ [Jiang and Tanner, 2008, Grünwald, 2012, Bissiri et al., 2016, Grünwald and van Ommen, 2017]. The interpretation of $\eta$ is that it represents the learning rate, or the analyst's trust in the model. For $\eta<1$ the data have less influence than in the standard Bayesian inference, while using $\eta>1$ places more trust in the likelihood.

Resampling schemes are another tool for addressing Bayesian model misspecification [Waddell et al., 2002, Douady et al., 2003]. The BayesBag algorithm [Bühlmann, 2014, Huggins and Miller, 2019, 2020] combines samples from posteriors on bootstrapped data sets. Asymptotic theory for BayesBag was proved by Huggins and Miller [2019].

Another group of robust inference methods is based on Weighted Likelihood Bootstrap [Newton, 1991, Newton and Raftery, 1994, Lyddon et al., 2019], and this is also a starting point for our approach.

[^0]In this paper we develop Posterior Bootstrap, a set of scalable algorithms for performing principled inference in Bayesian models under possible model misspecification. We extend Weighted Likelihood Bootstrap to incorporate prior information. Several approaches to this task have been recently proposed in the literature [Lyddon et al., 2018, Fong et al., 2019, Newton et al., 2020], to our knowledge however, this is the first attempt to analyse theoretically the impact of various ways of incorporating the prior. Edgeworth expansions show that prior beliefs about the parameter of interest are properly represented in the inference in a similar way to standard Bayesian inference, and guide our choice of hyperparameters of the algorithms. Moreover, we propose a robust inference scheme for hierarchical models, which has not been done so far for methods based on Weighted Likelihood Bootstrap or power posteriors.

### 1.2 Properties of Weighted Likelihood Bootstrap

Weighted Likelihood Bootstrap was originally proposed as a method for sampling approximately from a posterior distribution. Samples are drawn by independently optimizing the weighted log likelihood

\underset{\theta}{\arg \max }\left\{\sum_{i=1}^{n} w_{i} \log f\left(x_{i} \mid \theta\right)\right\}, \quad w_{1}, \ldots, w_{n} \sim \operatorname{Exp}(1) \tag{2}
\end{equation*}

Combined with an adjustment by the Sequential Importance Resampling algorithm [Gordon et al., 1993, Doucet et al., 2000], which could correct for the fact that Weighted Likelihood Bootstrap is approximate, it was an alternative to then emerging Markov chain Monte Carlo methods. A key advantage of this algorithm is that it allows to perform computations fully in parallel, therefore a recent resurgence of interest in this method [Newton et al., 2020, Lyddon et al., 2019, Ng and Newton, 2020, Nie and Ročková, 2020] can partly be explained by developments in parallel computing. Even though Weighted Likelihood Bootstrap appeared in the Bayesian literature, it does not incorporate a prior. A similar idea, called perturbing the minimand, was developed independently in the frequentist literature [Jin et al., 2001]. The analogy between these two methods was noticed by Parzen and Lipsitz [2007]. Some of the frequentist approaches consider adding a lasso-type regularization term [Minnier et al., 2011, Das et al., 2019], which from the Bayesian point of view could be interpreted as adding a prior.

Asymptotic results for the Weighted Likelihood Bootstrap were proved by Newton [1991] under a correctly specified model and extended by Lyddon et al. [2019] to the misspecified case. Let the maximum likelihood estimator $\hat{\theta}$ be $\arg \max _{\theta \in \Theta} \sum_{i=1}^{n} f\left(x_{i} \mid \theta\right)$, and let $\tilde{\theta}$ be a draw from the Weighted Likelihood Bootstrap algorithm based on observations $x_{1}, \ldots, x_{n}$. Theorem 1 of Lyddon et al. [2019] states that for any measurable set $A$ under standard regularity conditions

\operatorname{pr}\left\{n^{1 / 2}(\tilde{\theta}-\hat{\theta}) \in A \mid x_{1: n}\right\} \rightarrow \operatorname{pr}(Z \in A), \quad Z \sim N\left\{0, J\left(\theta^{*}\right)^{-1} I\left(\theta^{*}\right) J\left(\theta^{*}\right)^{-1}\right\} \tag{3}
\end{equation*}
$$

where

$$
\begin{equation*}
I(\theta)=E_{p^{*}}\left[\left\{\nabla_{\theta} \log f(X \mid \theta)\right\}\left\{\nabla_{\theta} \log f(X \mid \theta)\right\}^{T}\right], \quad J(\theta)=-E_{p^{*}}\left[D_{\theta}^{2}\{\log f(X \mid \theta)\}\right], \tag{4}
\end{equation*}
$$

and $\theta^{*}$ is the unique pseudo-true parameter minimizing $D_{K L}\left(p^{*} \| f\right)$. The asymptotic covariance matrix in (3) is the so-called sandwich covariance matrix known from the frequentist literature on model misspecification [Huber, 1967] as an asymptotic covariance matrix of the maximum likelihood estimator under a potentially misspecified model.

We let $\Pi\left(\cdot \mid x_{1: n}\right)$ be the Bayesian posterior distribution given observations $x_{1}, \ldots, x_{n}$ under model (1), and by $\pi\left(\cdot \mid x_{1: n}\right)$ we denote its density. Recall that the Bernstein-von Mises theorem for misspecified Bayesian models [Kleijn and Van der Vaart, 2012] states that

\Pi\left\{n^{1 / 2}(\theta-\hat{\theta}) \in A \mid x_{1: n}\right\} \rightarrow \operatorname{pr}\left(Z^{\prime} \in A\right), \quad Z^{\prime} \sim N\left\{0, J\left(\theta^{*}\right)^{-1}\right\} \tag{5}
\end{equation*}

Convergence in (5) holds in total variation, while Lyddon et al. [2019] considered convergence in distribution. We show however in Corollary 1 that convergence in (3) also holds in total variation. Note that under both standard Bayesian inference and Weighted Likelihood Bootstrap the asymptotic distribution is concentrated around the same mean, but with potentially different covariance matrices. Comparing (3) and (5), we conclude that for misspecified models under Weighted Likelihood Bootstrap credible sets are valid confidence sets in the frequentist sense, which is not the case for standard Bayesian posteriors [Kleijn and Van der Vaart, 2012]. For correctly specified models, the covariance matrices in (3) and (5) are equal.

Results obtained by Fushiki [2005, 2010] explain why Weighted Likelihood Bootstrap corrects for model misspecification in comparison with standard Bayesian inference. In particular, these two articles analyse the risk function

\end{equation*}

where $\hat{p}\left(\cdot \mid x_{1: n}\right)$ is the predictive distribution given data $x_{1: n}$ under a given method of inference. Proposition 1 below is a direct corollary of Theorem 1 of Fushiki [2010] and Theorems 1 and 3 of Fushiki [2005], see also Lyddon et al. [2018].

Proposition 1. Consider model (1) and assume that $\theta^{*} \in \Theta$ minimizing $D_{K L}\left(p^{*} \| f\right)$ is unique. Suppose that $I\left(\theta^{*}\right)$ and $J\left(\theta^{*}\right)$ are positive definite, and that $I\left(\theta^{*}\right) \neq J\left(\theta^{*}\right)$. Then the predictive distribution based on Weighted Likelihood Bootstrap asymptotically provides better prediction than the Bayesian predictive distribution, that is, the value of the empirical risk (6) is asymptotically smaller.

In view of the robust inference methods discussed in Section 1.1, a natural question to ask is whether the result stated in Proposition 1 can be extended from standard Bayesian inference to power posteriors. Theorem 1 below shows that the answer is negative since under certain conditions power posteriors yield an asymptotically smaller risk than Weighted Likelihood Bootstrap.
Theorem 1. Consider model (1) and let $\lambda_{1}, \ldots, \lambda_{d}$ denote the eigenvalues of $J\left(\theta^{*}\right)^{-1 / 2} I\left(\theta^{*}\right) J\left(\theta^{*}\right)^{-1 / 2}$, where $\theta^{*} \in \Theta$ is the unique pseudo-true parameter. Assume that we perform inference on $\theta$ using a power posterior $\pi_{\eta}$ with some $\eta>0$. Suppose that the eigenvalues satisfy either $1<\lambda_{1}, \ldots, \lambda_{d}<\eta^{-1}$, or $\eta^{-1}<\lambda_{1}, \ldots, \lambda_{d}<1$. Then the risk given by (6) associated with the predictive distribution under Weighted Likelihood Bootstrap is larger than the risk associated with the predictive distribution under power posterior $\pi_{\eta}$.

For prediction problems, Theorem 1 shows that in certain scenarios power posteriors with an appropriate choice of power $\eta$ outperform Weighted Likelihood Bootstrap. We present the proof in Supplementary Material A.

### 1.3 Edgeworth expansions

In order to develop appropriate methodology for incorporating prior information into Weighted Likelihood Bootstrap, we first need to specify what tools can be used for measuring the impact of the prior on the draws $\tilde{\theta}$ from the resulting algorithm. To this end, we examine the way the prior influences the posterior in standard Bayesian inference. Recall that by the Bernstein-von Mises theorem the prior asymptotically does not influence the first order approximation, which necessitates considering higher order approximations to the posterior.

In classical asymptotic theory of parametric inference the Edgeworth expansion of a density function is a well-established tool of analysing higher order approximations. For details we refer the reader to Bhattacharya and Ghosh [1978], Ghosh [1994], Hall [2013]. Note that the Gaussian approximation appearing in the central limit theorem is associated with an absolute error approximation of the order $O\left(n^{-1 / 2}\right)$, and the Edgeworth expansion should be seen as a natural extension of this approximation, up to the order $O\left(n^{-k / 2}\right)$ for an arbitrary natural number $k$. The coefficients of this expansion are expressed in terms of cumulants of the density of interest.

Letting $\ell(x, \theta)=\log f(x \mid \theta)$, we use

I_{n}=\frac{1}{n} \sum_{j=1}^{n} \nabla_{\theta} \ell\left(x_{j}, \hat{\theta}\right) \nabla_{\theta} \ell\left(x_{j}, \hat{\theta}\right)^{T}, \quad J_{n}=-\frac{1}{n} \sum_{j=1}^{n} D_{\theta}^{2} \ell\left(x_{j}, \hat{\theta}\right)
$$

as empirical estimates of $I\left(\theta^{*}\right)$ and $J\left(\theta^{*}\right)$ respectively. Let $\phi$ denote the density of a $d$-variate standard normal distribution. Recall that in case of well-specified models the Laplace approximation of the posterior density of $I_{n}^{1 / 2} n^{1 / 2}(\theta-\hat{\theta})$ is

\begin{equation*}
\phi(y)\left[1+I\left(\theta^{*}\right)^{-1 / 2} \frac{\left\{\nabla_{\theta} \log \pi\left(\theta^{*}\right)\right\}^{T} y}{n^{1 / 2}}+I\left(\theta^{*}\right)^{-3 / 2} \frac{\sum_{p, q, r=1}^{d} c_{p q r} y_{p} y_{q} y_{r}}{6 n^{1 / 2}}\right]+o\left(n^{-1 / 2}\right) \tag{7}
\end{equation*}
$$

for $y=\left(y_{1}, \ldots, y_{d}\right) \in \mathbb{R}^{d}$, and $c_{p q r}$ is $E\left\{\partial^{3} \ell(\theta, x) / \partial \theta_{p} \partial \theta_{q} \partial \theta_{r}\right\}$ evaluated at $\theta^{*}$. Since in Bayesian posteriors the impact of the prior appears in the second order Edgeworth expansion, we will keep this
as our primary requirement. That is, we demand that the prior information appears in the second order Edgeworth expansion obtained for Posterior Bootstrap. Ideally, for well-specified models our method would incorporate the prior knowledge in the same way it is done in Bayesian inference, that is, through the same prior-dependent expression in the second order expansion. The reason for this is that in case of well-specified models the Bayesian posterior offers optimal information about the parameter given the data and the prior distribution [Bernardo and Smith, 2009]. Alternatively, as explained in Bissiri et al. [2016], the posterior $\Pi\left(\theta \mid x_{1: n}\right)$ is the only probability measure minimizing the expected loss under the negative log likelihood loss function, which is an appropriate loss function to be used in the well-specified case, and hence provides a valid and coherent update of beliefs about $\theta$.

On the other hand, in case of misspecified models the first order expansions of Posterior Bootstrap and of the Bayesian posterior are different, as seen in (3) and (5), which is what allows Posterior Bootstrap to correct for model misspecification.

## 2 Posterior Bootstrap via penalization on the weighted loglikelihood

### 2.1 Methodology for non-hierarchical models

We now present Algorithm 1, our Posterior Bootstrap method via prior penalization for model (1). The algorithm has only one parameter $w_{0}$ representing the strength of the penalization imposed on the weighted $\log$ likelihood with the prior distribution. For $w_{0}=0$, Algorithm 1 recovers Weighted Likelihood Bootstrap.

In the basic version of the algorithm we assume that $w_{0}$ is a non-negative real number. In this case Algorithm 1 resembles the Weighted Bayesian Bootstrap [Newton et al., 2020]. Instead of a fixed parameter $w_{0}$, Newton et al. [2020] use a random variable $\lambda \operatorname{Exp}(1)$ for a regularization constant $\lambda$, typically selected via cross-validation. If we additionally assume that the prior $\pi(\theta)$ factorizes with respect to all coordinates of $\theta=\left(\theta_{1}, \ldots, \theta_{d}\right)$ as

\begin{equation*}
\pi(\theta)=\prod_{k=1}^{d} \pi_{k}\left(\theta_{k}\right) \tag{8}
\end{equation*}
$$

we then treat $w_{0}$ as a $d$-dimensional vector $\left(w_{0,1}, \ldots, w_{0, d}\right)$ with non-negative entries, rather than a real value. For simplicity of notation the penalization term $w_{0}^{T} \log \pi(\theta)$ in of Algorithm 1 denotes $w_{0}^{T} \log \pi(\theta)=$ $\sum_{k=1}^{d} w_{0, k} \log \pi_{k}\left(\theta_{k}\right)$. We defer a discussion about appropriate choice of $w_{0}$ to Section 2.3. We let $P^{B, p}$ be the distribution of $\tilde{\theta}$ drawn from Algorithm 1 and by $p^{B, p}$ we denote its density.
Remark 1. Algorithm 1 can be extended to the setting of [Bissiri et al., 2016, Lyddon et al., 2019], where the negative log likelihood $-\log f(x \mid \theta)$ is replaced with an arbitrary loss function. The asymptotic results will then be analogous to those stated in Section 2.2 under the same regularity conditions.

### 2.2 Asymptotic results for Algorithm 1

In this section we provide the Edgeworth expansion of the output of Algorithm 1, which generalizes the results obtained by Lyddon et al. [2019] to the penalized version, and strengthens them to the second order expansion.

In what follows, if there is ambiguity, we write $E_{z}$ to denote expectation with respect to $z$. We consider the following set of assumptions.

Assumption 1. (Log likelihood). The $\log$ likelihood function $\ell(x, \theta)=\log f(x \mid \theta)$ is measurable and bounded from above, with $E_{p^{*}}|\ell(X, \theta)|<\infty$ for all $\theta \in \Theta$.

Assumption 2. (Identifiability). There exists a unique maximizing parameter value

$$
\theta^{*}=\underset{\theta \in \Theta}{\arg \max } E_{p^{*}}\{\ell(X, \theta)\},
$$

and further for all $\delta>0$ there exists an $\epsilon>0$ such that

$$
\lim _{n \rightarrow \infty} P^{*}\left[\sup _{\left\|\theta-\theta^{*}\right\| \geq \delta} \frac{1}{n} \sum_{i=1}^{n}\left\{\ell\left(X_{i}, \theta\right)-\ell\left(X_{i}, \theta^{*}\right)\right\} \leq-\epsilon\right]=1,
$$

where $P^{*}$ is the data-generating distribution.
Assumption 3. (Smoothness of the log likelihood function). There is an open ball $B$ containing $\theta^{*}$ such that $\ell(\theta, x)$ is three times continuously differentiable with respect to $\theta \in B$ almost surely on $x$ with respect to $P^{*}$. We additionally impose certain moment conditions on the partial derivatives. For details see Supplementary Material B.1.
Assumption 4. (Positive definiteness of information matrices and linear independence of partial derivatives). For $B$ like in Assumption 3, the matrices $I(\theta)$ and $J(\theta)$ defined in (4) are positive definite for $\theta \in B$ with all elements finite. Besides, the first and second partial derivatives

\left\{\frac{\partial \ell(x, \theta)}{\partial \theta_{p}}, \frac{\partial^{2} \ell(x, \theta)}{\partial \theta_{r} \partial \theta_{s}}\right\}, \quad 1 \leq p \leq d, 1 \leq r \leq s \leq d
$$

are linearly independent as functions of $x$ at $\theta^{*}$.
Assumption 5. (Distribution of weights). The weights $w_{1: n}=\left(w_{1}, \ldots, w_{n}\right)$ are independent and identically distributed according to a continuous distribution $W$ having all moments and such that $E(W)=1$ and $\operatorname{var}(W)=1$.

Assumptions $1-3$, as well as positive definiteness of information matrices in Assumption 4 are direct analogues of regularity conditions considered in Lyddon et al. [2019]. Linear independence of partial derivatives expressed in Assumption 4 is a common assumption for obtaining Edgeworth expansions of the maximum likelihood estimator. Assumptions 1 and 2 ensure that as $n \rightarrow \infty$, with probability going to 1 distribution $P^{B, p}\left(\cdot \mid x_{1: n}\right)$ concentrates around $\theta^{*}$. Assumptions 3 and 4 are used to show the validity of the Edgeworth expansion. Since the algorithms we present in the paper rely on the Weighted Likelihood Bootstrap formulation (2), by default the weights follow the exponential distribution $\operatorname{Exp}(1)$, thus satisfying Assumption 5, we allow however for other distributions of weights. We will use the above conditions throughout the paper to prove our theoretical results for various versions of Posterior Bootstrap.

In the case of Algorithm 1, we require the following smoothness assumption on $\pi(\theta)$ in the neighbourhood of $\theta^{*}$.

Assumption 6. (Smoothness of $\log$ prior density). The function $\log \pi(\theta)$ is measurable, upper-bounded on $\Theta$, and three times continuously differentiable at $\theta^{*}$.

We denote by $w_{0} \cdot \nabla_{\theta} \log \pi\left(\theta^{*}\right)$ a vector with $p$ th entry $w_{0, p} \pi^{\prime}\left(\theta_{p}^{*}\right) / \pi\left(\theta_{p}^{*}\right)$ if $w_{0} \in \mathbb{R}^{d}$ and $w_{0} \pi^{\prime}\left(\theta_{p}^{*}\right) / \pi\left(\theta_{p}^{*}\right)$ when $w_{0} \in R$. When $\theta \in \mathbb{R}$, we adopt the following notation:

\mu_{3}=E_{p^{*}}\left\{D_{\theta}^{3} \ell\left(X, \theta^{*}\right)\right\}, \quad A_{3}=E_{p^{*}}\left\{\nabla_{\theta} \ell\left(X, \theta^{*}\right)\right\}^{3}, \quad L_{1,2}=E_{p^{*}}\left\{D_{\theta}^{2} \ell\left(X, \theta^{*}\right) \nabla_{\theta} \ell\left(X, \theta^{*}\right)\right\} \tag{9}
\end{equation*}
$$

We denote by $\gamma=E\left\{(W-1)^{3}\right\}$ the third central moment of $W$, so $\gamma=2$ when $W \sim \operatorname{Exp}(1)$.
Theorem 2. Consider model (1) with a parameter of interest $\theta \in \mathbb{R}^{d}$ and suppose Assumptions 1 - 6 hold. As $n \rightarrow \infty$, with probability going to 1 the Edgeworth expansion of the density of $I_{n}^{-1 / 2} J_{n} n^{1 / 2}(\tilde{\theta}-\hat{\theta})$ for $\tilde{\theta}$ drawn from Algorithm 1 is

\phi(y)\left[1+I\left(\theta^{*}\right)^{-1 / 2} \frac{\left\{w_{0} \cdot \nabla_{\theta} \log \pi\left(\theta^{*}\right)\right\}^{T} y}{n^{1 / 2}}+\frac{P_{3, n}(y)}{n^{1 / 2}}\right]+o\left(n^{-1 / 2}\right) \tag{10}
\end{equation*}
$$

where $P_{3, n}(y)$ is an order three polynomial independent from the prior. When $d=1$, formula (10) has the following more explicit form

$$
\begin{equation*}
\phi(y)\left\{1+\kappa_{1, n} y+\kappa_{3, n} \frac{y^{3}-3 y}{6}\right\}+o\left(n^{-1 / 2}\right) \tag{11}
\end{equation*}
$$

where

$$
\begin{aligned}
\kappa_{1, n} & =\frac{w_{0} \nabla_{\theta} \log \pi\left(\theta^{*}\right)}{n^{1 / 2} I\left(\theta^{*}\right)^{1 / 2}}+\frac{\mu_{3}}{2 n^{1 / 2}} \frac{I\left(\theta^{*}\right)^{1 / 2}}{J\left(\theta^{*}\right)^{2}}+\frac{L_{1,2}}{n^{1 / 2} I\left(\theta^{*}\right)^{1 / 2} J\left(\theta^{*}\right)}, \\
\kappa_{3, n} & =\frac{\gamma A_{3}}{n^{1 / 2} I\left(\theta^{*}\right)^{3 / 2}}+\frac{3 \mu_{3}}{n^{1 / 2}} \frac{I\left(\theta^{*}\right)^{1 / 2}}{J\left(\theta^{*}\right)^{2}}+\frac{6 L_{1,2}}{n^{1 / 2} I\left(\theta^{*}\right)^{1 / 2} J\left(\theta^{*}\right)}
\end{aligned}
$$

Additionally, if the model is well-specified and $\gamma=2$, formula (11) becomes

$$
\begin{equation*}
\phi(y)\left[1+\frac{w_{0} \nabla_{\theta} \log \pi\left(\theta^{*}\right) y}{n^{1 / 2} I\left(\theta^{*}\right)^{1 / 2}}-\frac{\left(A_{3}+\mu_{3}\right) y}{3 n^{1 / 2} I\left(\theta^{*}\right)^{3 / 2}}+\frac{\mu_{3} y^{3}}{6 n^{1 / 2} I\left(\theta^{*}\right)^{3 / 2}}\right]+o\left(n^{-1 / 2}\right) . \tag{12}
\end{equation*}
$$

The sketch of the proof of Theorem 2 is as follows. We first expand $\sqrt{n}(\tilde{\theta}-\hat{\theta})$ as a function of $\sum_{i=1}^{d} b\left(x_{i}, \hat{\theta}\right)$, where $b\left(x_{i}, \hat{\theta}\right)$ is a vector containing derivatives of $\ell\left(x_{i}, \theta\right)$ with respect to $\theta$. We then obtain the Edgeworth expansion of $\sum_{i=1}^{d} b\left(x_{i}, \hat{\theta}\right)$ as a random variable in $w_{1: n}$. Results from Chapter 2 of Ghosh [1994] are used to justify that (11) is indeed a valid Edgeworth expansion, that is, that the incurred error is of order $o\left(n^{-1 / 2}\right)$. For the full proof with all calculations we refer the reader to the Supplementary Material B. We also provide an Edgeworth expansion for the related method by Newton et al. [2020] in Supplementary Material B.6.

To derive formula (12) from (11), recall that for well-specified models we have $I\left(\theta^{*}\right)=J\left(\theta^{*}\right)$ and by one of the Bartlett identities [Bartlett, 1953a,b]

-L_{1,2}=\frac{\mu_{3}+A_{3}}{3} \tag{13}
\end{equation*}
$$

If additionally $\gamma=2$, we can simplify the formulas for $\kappa_{3, n}$ and $\kappa_{1, n}$ to

$$
\begin{aligned}
\kappa_{3, n} & =\frac{2 A_{3}}{n^{1 / 2} I\left(\theta^{*}\right)^{3 / 2}}+\frac{6 \mu_{3}}{2 n^{1 / 2} I\left(\theta^{*}\right)^{3 / 2}}-\frac{2 \mu_{3}+2 A_{3}}{n^{1 / 2} I\left(\theta^{*}\right)^{3 / 2}}=\frac{\mu_{3}}{n^{1 / 2} I\left(\theta^{*}\right)^{3 / 2}}, \\
\kappa_{1, n} & =\frac{w_{0} \nabla_{\theta} \log \pi\left(\theta^{*}\right)}{n^{1 / 2} I\left(\theta^{*}\right)^{1 / 2}}+\frac{\mu_{3}}{6 n^{1 / 2} I\left(\theta^{*}\right)^{3 / 2}}-\frac{A_{3}}{3 n^{1 / 2} I\left(\theta^{*}\right)^{3 / 2}} .
\end{aligned}
$$

For well-specified models, it is insightful to compare the Edgeworth expansions obtained for Posterior Bootstrap (10) with the Laplace approximations for Bayesian posteriors (7). Note that for $w_{0}=1$ the term corresponding to the prior, that is $n^{-1 / 2} I\left(\theta^{*}\right)^{-1 / 2} \nabla_{\theta} \log \pi\left(\theta^{*}\right)$ appears in the same way in both formulas. Firstly, this suggests using $w_{0}=1$ if the analyst believes the model is well-specified, which should in fact be intuitive given that for $w_{0}=1$

$$
E_{w_{1: n}}\left\{\sum_{i=1}^{n} w_{i} \log f\left(x_{i} \mid \theta\right)+w_{0} \log \pi(\theta)\right\}=\log \pi\left(\theta \mid x_{1: n}\right)+\mathrm{c}
$$

where the term $c$ does not depend on $\theta$. This also has implications when the analyst wants to choose between two prior distributions $\pi_{1}(\theta)$ and $\pi_{2}(\theta)$. For $w_{0}=0$ we then have

$$
\pi_{1}\left(\theta \mid x_{1: n}\right)-\pi_{2}\left(\theta \mid x_{1: n}\right)=p_{\pi_{1}}^{B, p}\left(\theta \mid x_{1: n}\right)-p_{\pi_{2}}^{B, p}\left(\theta \mid x_{1: n}\right)+o\left(n^{-1 / 2}\right)
$$

where $p_{\pi}^{B, p}$ denotes a density $p^{B, p}$ under prior $\pi$. This facilitates understanding the impact of the prior and suggests making decisions about the choice of the prior following the guidelines developed for Bayesian inference.

At the same time it should be noted that in general the Posterior Bootstrap method does not yield second order correctness to Bayesian posteriors for well specified models. This is due to the additional term $-n^{-1 / 2} I\left(\theta^{*}\right)^{-3 / 2}\left(A_{3}+\mu_{3}\right) / 3$ in formula (12), which is only equal to 0 in special cases. Further details about the consequences of this result are presented in Proposition 2.

Proposition 2. Consider model (1) with a one-dimensional parameter $\theta$. Suppose $\tilde{\theta}$ is drawn from Weighted Likelihood Bootstrap, that is, from Algorithm 1 with $w_{0}=0$. If the model is well-specified, then the Edgeworth expansion of $I(\hat{\theta})^{1 / 2} n^{1 / 2}(\tilde{\theta}-\hat{\theta})$ is second order correct to the corresponding expansion for Bayesian posterior utilizing Jeffreys prior on $\theta$.

Proof. Suppose that $\pi(\theta)$ is a Jeffreys prior, that is $\pi(\theta) \propto\{I(\theta)\}^{1 / 2}$. Then

$$
\nabla_{\theta} \log \pi\left(\theta^{*}\right)=\frac{I\left(\theta^{*}\right)^{-1 / 2} I\left(\theta^{*}\right)^{\prime}}{2 I\left(\theta^{*}\right)^{1 / 2}}=\frac{I\left(\theta^{*}\right)^{\prime}}{2 I\left(\theta^{*}\right)}=\frac{2 L_{1,2}\left(\theta^{*}\right)}{2 I\left(\theta^{*}\right)}=-\frac{A_{3}+\mu_{3}}{3 I\left(\theta^{*}\right)^{3 / 2}},
$$

where the last equality follows from the Bartlett identity (13). Comparing formula (12) for $w_{0}=0$ and (7) completes the proof.

The above result has an interesting and at the same time intuitive interpretation from the point of view of properties of Jeffreys priors. Recall that Jeffreys priors are designed to be non-informative and represent ignorance about the parameter of interest. Weighted Likelihood Bootstrap can be characterized by an analogous property, as it does not incorporate any prior information about the parameter. In fact the question of second order equivalence between Weighted Likelihood Bootstrap and Bayesian posteriors with Jeffreys priors was initially raised in Section 4 of Newton and Raftery [1994]. Due to an omission in the Taylor expansion, the authors obtained an incomplete Edgeworth expansion, which lead to incorrect conclusions about second order correctness.

We present below Corollary 1 which can be directly inferred from the existence of Edgeworth expansions.
Corollary 1. Consider model (1) and suppose $\tilde{\theta}$ is drawn from Algorithm 1. Then, under conditions of Theorem 2, $n^{1 / 2}(\tilde{\theta}-\hat{\theta})$ converges to the normal distribution $N\left\{0, J\left(\theta^{*}\right)^{-1} I\left(\theta^{*}\right) J\left(\theta^{*}\right)^{-1}\right\}$ in total variation for any choice of $w_{0}$.

Corollary 1 applied to $w_{0}=0$ generalizes Theorem 1 of Lyddon et al. [2019], and the convergence expressed in (5) can be stated in total variation, as it is typically done for the Bernstein-von Mises type results.

### 2.3 Choice of $w_{0}$ in Algorithm 1

We start by providing some intuition why, if the user simply sets $w_{0}=1$ under misspecification, their prior beliefs on the parameter may not be appropriately reflected in the inference. To this end, we consider a one-dimensional toy model

$$
\begin{equation*}
x_{1}, \ldots, x_{n} \sim N(\theta, 1), \quad \theta \sim \mathrm{N}\left(\mu_{0}, \sigma_{0}^{2}\right) \tag{14}
\end{equation*}
$$

Suppose model (14) is misspecified and in fact $x_{1}, \ldots, x_{n} \sim N\left(0, \sigma^{2}\right)$ for $\sigma \neq 1$. The correct model would then be

$$
\begin{equation*}
x_{1}, \ldots, x_{n} \sim N\left(\theta, \sigma^{2}\right), \quad \theta \sim \mathrm{N}\left(\mu_{0}, \sigma_{0}^{2}\right) \tag{15}
\end{equation*}
$$

Drawing a sample from Algorithm 1 is equivalent to computing

$$
\begin{equation*}
\underset{\theta}{\arg \max }\left\{\sum_{i=1}^{n} \frac{-w_{i}\left(x_{i}-\theta\right)^{2}}{2}-\frac{w_{0}\left(\theta-\mu_{0}\right)^{2}}{2 \sigma_{0}^{2}}\right\}=\underset{\theta}{\arg \max }\left\{\sum_{i=1}^{n} \frac{-w_{i}\left(x_{i}-\theta\right)^{2}}{2 \sigma^{2}}-\frac{w_{0}\left(\theta-\mu_{0}\right)^{2}}{2 \sigma_{0}^{2} \sigma^{2}}\right\} \tag{16}
\end{equation*}
$$

If the user knew the true data generating mechanism they would instead compute

$$
\begin{equation*}
\underset{\theta}{\arg \max }\left\{\sum_{i=1}^{n}-\frac{w_{i}\left(x_{i}-\theta\right)^{2}}{2 \sigma^{2}}-\frac{\left(\theta-\mu_{0}\right)^{2}}{2 \sigma_{0}^{2}}\right\} \tag{17}
\end{equation*}
$$

Equation (16) is equivalent to (17) if $w_{0}=\sigma^{2}$. In fact drawing samples according to (16) with $w_{0}=1$ would be equivalent to using the correct likelihood but having the prior belief encoded by $\theta \sim N\left(\mu_{0}, \sigma^{2} \sigma_{0}^{2}\right)$ rather than $\theta \sim N\left(\mu_{0}, \sigma_{0}^{2}\right)$.

We now make a connection between the above observation and the Edgeworth expansion obtained in Theorem 2, which will further guide our choice of $w_{0} .$. Let $J\left(\theta^{*}\right)$ and $I\left(\theta^{*}\right)$ be the information matrices for model (14) at $\theta^{*}$, that is $J\left(\theta^{*}\right)=1$ and $I\left(\theta^{*}\right)=\sigma^{2}$. Let $I_{\text {true }}\left(\theta^{*}\right)$ be the information matrix at $\theta^{*}$ under the correct model (15). We thus have $I_{\text {true }}\left(\theta^{*}\right)=\sigma^{-2}$. In the second order expansion of the Bayesian posterior of $\sigma^{-1} n^{1 / 2}(\theta-\hat{\theta})$ under the correct model, as shown in (7), the prior-dependent term is

$$
n^{-1 / 2} I_{\text {true }}\left(\theta^{*}\right)^{-1 / 2} \pi^{\prime}\left(\theta^{*}\right) / \pi\left(\theta^{*}\right)=n^{-1 / 2} \sigma \pi^{\prime}\left(\theta^{*}\right) / \pi\left(\theta^{*}\right)
$$

On the other hand, since $I\left(\theta^{*}\right)^{-1 / 2} J\left(\theta^{*}\right)=\sigma^{-1}$, by Theorem 2 we get that under model (14) and Algorithm 1 with $w_{0}=\sigma^{2}$, the prior-dependent term in the second order Edgeworth expansion of $\sigma^{-1} n^{1 / 2}(\tilde{\theta}-\hat{\theta})$ is

$$
n^{-1 / 2} I\left(\theta^{*}\right)^{-1 / 2} w_{0} \pi^{\prime}\left(\theta^{*}\right) / \pi\left(\theta^{*}\right)=n^{-1 / 2} \sigma \pi^{\prime}\left(\theta^{*}\right) / \pi\left(\theta^{*}\right)
$$

To summarize, in this special case the prior-dependent term in the Edgeworth expansion of Posterior Bootstrap under the misspecified model is the same as the prior-dependent term in Bayesian inference under the correct model.

The example described above as well as the fact that Posterior Bootstrap corrects the covariance matrix of the asymptotic distribution motivates the following methodology of setting $w_{0}$, for potentially multivariate models. Suppose the prior $\pi$ satisfies (8) so that $w_{0}$ can be treated as a $d$-dimensional vector. The goal is to match the prior-dependent terms in Edgeworth expansion for Algorithm 1 and in the Laplace approximation for the Bayesian posterior with a corrected scaling $I\left(\theta^{*}\right)^{-1 / 2} J\left(\theta^{*}\right)$, rather than $I\left(\theta^{*}\right)^{1 / 2}$. Thus we want to set $w_{0}$ so that for all $y \in \mathbb{R}^{d}$ it satisfies

$$
I\left(\theta^{*}\right)^{-1 / 2}\left(\begin{array}{c}
w_{0,1} \frac{\pi^{\prime}\left(\theta_{1}^{*}\right)}{\pi\left(\theta_{1}^{*}\right)} y_{1} \\
\vdots \\
w_{0, d} \frac{\pi^{\prime}\left(\theta_{d}^{*}\right)}{\pi\left(\theta_{d}^{*}\right)} y_{d}
\end{array}\right)=\left\{I\left(\theta^{*}\right)^{-1 / 2} J\left(\theta^{*}\right)\right\}^{-1}\left(\begin{array}{c}
\frac{\pi^{\prime}\left(\theta_{1}^{*}\right)}{\pi\left(\theta_{1}^{*}\right)} y_{1} \\
\vdots \\
\frac{\pi^{\prime}\left(\theta_{d}^{*}\right)}{\pi\left(\theta_{d}^{*}\right)} y_{d}
\end{array}\right)
$$

which is equivalent to

$$
D\left(w_{0}\right)\left(\begin{array}{c}
\frac{\pi^{\prime}\left(\theta_{1}^{*}\right)}{\pi\left(\theta_{1}^{*}\right)} y_{1}  \tag{18}\\
\vdots \\
\frac{\pi^{\prime}\left(\theta_{d}^{*}\right)}{\pi\left(\theta_{d}^{*}\right)} y_{d}
\end{array}\right)=I\left(\theta^{*}\right)^{1 / 2} J\left(\theta^{*}\right)^{-1} I\left(\theta^{*}\right)^{1 / 2}\left(\begin{array}{c}
\frac{\pi^{\prime}\left(\theta_{1}^{*}\right)}{\pi\left(\theta_{1}^{*}\right)} y_{1} \\
\vdots \\
\frac{\pi^{\prime}\left(\theta_{d}^{*}\right)}{\pi\left(\theta_{d}^{*}\right)} y_{d}
\end{array}\right)
$$

where $D\left(w_{0}\right)$ is a diagonal matrix with entries $w_{0,1}, \ldots, w_{0, d}$ on the diagonal. Note that for well-specified models formula (18) above would imply that $w_{0}=(1, \ldots, 1)$, as expected. When $I\left(\theta^{*}\right)^{1 / 2} J\left(\theta^{*}\right)^{-1} I\left(\theta^{*}\right)^{1 / 2}$ is not diagonal, it is impossible to set $w_{0}$ so that (18) is satisfied for all $y \in \mathbb{R}^{d}$. We therefore set $w_{0}$ as

$$
w_{0}^{*}=\underset{w_{0}}{\arg \min }\left\|D\left(w_{0}\right)-I\left(\theta^{*}\right)^{1 / 2} J\left(\theta^{*}\right)^{-1} I\left(\theta^{*}\right)^{1 / 2}\right\|_{F}=\operatorname{diag}\left\{I\left(\theta^{*}\right)^{1 / 2} J\left(\theta^{*}\right)^{-1} I\left(\theta^{*}\right)^{1 / 2}\right\}
$$

where $\|\cdot\|_{F}$ denotes the Frobenius norm. In practice, we approximate this formula with

$$
\begin{equation*}
w_{0}^{*}=\operatorname{diag}\left(I_{n}^{1 / 2} J_{n}^{-1} I_{n}^{1 / 2}\right) \tag{19}
\end{equation*}
$$

which ensures that all elements of $w_{0}$ are non-negative as required. If the prior does not factorize, then we must constrain the diagonal elements of $D\left(w_{0}\right)$ in (18) to be equal, so instead we propose to set $w_{0}$ as

$$
\begin{equation*}
\bar{w}_{0}^{*}=\frac{1}{d} \operatorname{tr}\left(I_{n}^{1 / 2} J_{n}^{-1} I_{n}^{1 / 2}\right) \tag{20}
\end{equation*}
$$

In the case of factorizing priors, we advocate using formula (19) rather than (20) as it allows for capturing different kinds of misspecification, such as overdispersion or underdispersion, in different coordinates. If parameter $\theta$ is one-dimensional, the formulae for $w_{0}^{*}$ and $\bar{w}_{0}^{*}$ coincide.

An alternative strategy would be performing cross-validation, which could be particularly useful for prediction problems. The above approach, however, offers an automatic and principled way of setting $w_{0}$ so that the prior information is appropriately incorporated in the inference. This method has also a natural extension to hierarchical models as we demonstrate in Section 3.

## 3 Extending Posterior Bootstrap to hierarchical models

### 3.1 Fixed number of groups $K$

We consider the following potentially misspecified hierarchical model.

$$
\begin{array}{rlrl}
x_{k, 1}, \ldots x_{k, n_{k}} & \sim f_{k}\left(x_{k, i} \mid \theta_{k}\right), & & k=1, \ldots, K, \\
\theta_{k} & \sim g_{k}\left(\theta_{k} \mid \lambda\right), & k=1, \ldots, K,  \tag{21}\\
\lambda & \sim p(\lambda) . & &
\end{array}
$$

Each group $k$ has a sample size $n_{k}$ for $k=1, \ldots, K$. We define $x_{1: K, 1: n_{k}}$ as a vector of all observations $x_{k, j}$ for $j=1, \ldots, n_{k}$ and $k=1, \ldots, K$. The marginal prior on $\theta=\left(\theta_{1}, \ldots, \theta_{K}\right)$ is

$$
\begin{equation*}
\tilde{\pi}(\theta)=\int\left\{\prod_{k=1}^{K} g_{k}\left(\theta_{k} \mid \lambda\right) p(\lambda)\right\} \mathrm{d} \lambda \tag{22}
\end{equation*}
$$

If the integral in (22) is tractable, then Algorithm 1 can be applied to model (21), with the joint prior $\tilde{\pi}(\theta)$ on $\theta$.

When this integral cannot be computed, we propose instead to use Algorithm 2, our Posterior Bootstrap method for hierarchical models. We let $P^{H B, p}\left(\cdot \mid x_{1: K, 1: n_{k}}\right)$ denote the distribution of $\left(\tilde{\theta}_{1}, \ldots, \tilde{\theta}_{K}, \tilde{\lambda}\right)$ under Algorithm 2 and by $p^{H B, p}\left(\cdot \mid x_{1: K, 1: n_{k}}\right)$ we denote its density. The prior information in Algorithm 2 is introduced via penalization, in the spirit of Algorithm 1 . For each $k=1, \ldots, K$ parameter $w_{0,[k]}$ plays for data $x_{k, 1}, \ldots, x_{k, n_{k}}$ the role of $w_{0}$ used in Algorithm 1. The fact that the penalization term depends on $\bar{\lambda}$, which is kept the same across groups, induces correlation between $\theta_{1}, \ldots, \theta_{K}$, in a similar way to what happens under standard Bayesian inference.

It is worth emphasizing here an additional advantage of using Algorithm 2 for model (21), even if the integral in (22) is tractable. Since the prior $\tilde{\pi}$ does not factorize, Algorithm 1 would need to be used with $w_{0}$ treated as a real number, whereas Algorithm 2 makes use of the conditional independence structure between $\theta_{1}, \ldots, \theta_{K}$ and allows the user to set $w_{0,[k]}$ separately for each group. Arguments outlined in Section 2.3 show that this approach accounts better for potential misspecification of $f_{1}, \ldots, f_{K}$.

We let $\theta_{k}^{*}=\arg \max _{\theta} E_{p_{k}^{*}}\left\{\log f_{k}(X \mid \theta)\right\}$, where $x_{k, 1}, \ldots, x_{k, n_{k}}$ are generated from $P_{k}^{*}$. We treat here $\theta_{1}^{*}, \ldots, \theta_{K}^{*}$ as deterministic values, see Section 3.2 for a scenario where $\theta_{1}^{*}, \ldots, \theta_{K}^{*}$ are themselves random variables. Firstly, as a direct consequence of Theorem 2, we get the first order approximation for the asymptotic distribution of $\tilde{\theta}_{k}$. For any measurable set $A \subseteq \Theta$ we have

$$
P^{H B, p}\left\{n^{1 / 2}\left(\tilde{\theta}_{k}-\hat{\theta}_{k}\right) \in A \mid x_{1: K, 1: n_{k}}\right\} \rightarrow \operatorname{pr}(Z \in A), \quad Z \sim N\left\{0, J_{k}\left(\theta_{k}^{*}\right)^{-1} I_{k}\left(\theta_{k}^{*}\right) J_{k}\left(\theta_{k}^{*}\right)^{-1}\right\}
$$

where $I_{k}$ and $J_{k}$ are given by (4), computed for $f_{k}$.
We explain below why $\bar{\lambda}$ in Algorithm 2 is drawn from the posterior $p\left(\lambda \mid \hat{\theta}_{1}, \ldots, \hat{\theta}_{K}\right)$ rather then from the prior $p(\lambda)$, even though the latter may seem more intuitive. To this end, let us analyse the impact of the prior on the second order Edgeworth expansion on $\theta_{k}$. By construction of Algorithm 2 and by Theorem 2, if $n_{1}, \ldots, n_{k}$ are large, the prior-dependent term is

$$
\begin{equation*}
I_{k}\left(\theta_{k}^{*}\right)^{-1 / 2} n_{k}^{-1 / 2} w_{0,[k]}^{T} \int \nabla_{\theta_{k}}\left\{\log g_{k}\left(\theta_{k}^{*} \mid \lambda\right)\right\} p\left(\lambda \mid \theta_{1}^{*}, \ldots, \theta_{K}^{*}\right) \mathrm{d} \lambda \tag{23}
\end{equation*}
$$

On the other hand, since in fact the prior on $\theta$ has a form (22), we would want the prior impact term to
be given by $I_{k}\left(\theta_{k}^{*}\right)^{-1 / 2} n_{k}^{-1 / 2} w_{0,[k]}^{T} \nabla_{\theta_{k}}\left\{\log \tilde{\pi}\left(\theta^{*}\right)\right\}$. We observe that

$$
\begin{aligned}
\nabla_{\theta_{k}} \log \tilde{\pi}(\theta) & =\frac{\nabla_{\theta_{k}}\left\{\int \prod_{j=1}^{K} g_{k}\left(\theta_{j} \mid \lambda\right) p(\lambda) \mathrm{d} \lambda\right\}}{\int \prod_{j=1}^{K} g_{k}\left(\theta_{j} \mid \lambda\right) p(\lambda) \mathrm{d} \lambda} \\
& =\frac{\int\left\{\nabla_{\theta_{k}} g_{k}\left(\theta_{k} \mid \lambda\right) \prod_{j=1, j \neq k}^{K} g_{k}\left(\theta_{j} \mid \lambda\right) p(\lambda)\right\} \mathrm{d} \lambda}{\int \prod_{j=1}^{K} g_{k}\left(\theta_{j} \mid \lambda\right) p(\lambda) \mathrm{d} \lambda} \\
& =\int\left\{\frac{\nabla_{\theta_{k}} g_{k}\left(\theta_{k} \mid \lambda\right)}{g_{k}\left(\theta_{k} \mid \lambda\right)} \frac{\prod_{j=1}^{K} g_{k}\left(\theta_{j} \mid \lambda\right) p(\lambda)}{\int \prod_{j=1}^{K} g_{k}\left(\theta_{j} \mid \lambda\right) p(\lambda) \mathrm{d} \lambda}\right\} \mathrm{d} \lambda \\
& =\int \nabla_{\theta_{k}}\left\{\log g_{k}\left(\theta_{k} \mid \lambda\right)\right\} p\left(\lambda \mid \theta_{1}, \ldots, \theta_{K}\right) \mathrm{d} \lambda
\end{aligned}
$$

so $I_{k}\left(\theta_{k}^{*}\right)^{-1 / 2} n_{k}^{-1 / 2} w_{0,[k]}^{T} \nabla_{\theta_{k}} \log \tilde{\pi}\left(\theta^{*}\right)$ is indeed equal to (23). We therefore conclude that if model (21) is well-specified, the impact of the prior plays asymptotically the same role as in case of Bayesian inference. Furthermore, this reasoning justifies setting $w_{0,[1]}, \ldots, w_{0,[K]}$ using rules outlined in Section 2.3 for $w_{0}$ in Algorithm 1.

When presenting Algorithm 2, we assumed implicitly that the user can sample from the posterior $p\left(\lambda \mid \theta_{1}, \ldots, \theta_{K}\right)$. In conjugate examples one can draw $\lambda$ directly, otherwise it would be necessary to employ a Markov chain Monte Carlo sampler for this step. We let $n=\min _{k=1, \ldots, K} n_{k}$. Proposition 3 demonstrates the asymptotic properties of $\tilde{\lambda}$ drawn from Algorithm 2, covering both the well-specified and misspecified cases. It shows that as $n \rightarrow \infty$, the distribution on $\tilde{\lambda}$ will tend to the same distribution as the Bayesian posterior on $\lambda$. A similar result was proved by Petrone et al. [2014] for marginal maximum likelihood estimators.
Proposition 3. Consider model (21) with a fixed number of groups $K$ and suppose $\tilde{\lambda}$ is drawn from Algorithm 2. Suppose that Assumptions $1-4$ hold for each likelihood function $f_{k}$ and that Assumption 6 is satisfied for $g_{k}$, for $k=1, \ldots, K$. Assume also that for each $\lambda$ the density $p(\lambda \mid \theta)$ is a continuous function of $\theta$ and that $p(\lambda \mid \theta)$ is jointly bounded as a function of $\theta$ and $\lambda$. Then as $n \rightarrow \infty$, we have the following convergence of densities

$$
\begin{equation*}
p^{H B, p}\left(\tilde{\lambda} \mid x_{1: K, 1: n_{k}}\right) \rightarrow p\left(\tilde{\lambda} \mid \theta^{*}\right) \tag{24}
\end{equation*}
$$

with probability going to 1 with respect to $x_{1: K, 1: n_{k}}$.
We present the proof in Supplementary Material C.1.

### 3.2 Number of groups $K$ going to infinity

We consider model (21) with $f_{k}(\cdot \mid \theta)=f(\cdot \mid \theta)$ and $g_{k}(\cdot \mid \lambda)=g(\cdot \mid \lambda)$ for all $\theta, \lambda$ and $k=1, \ldots, K$. An alternative to sampling $\lambda$ using Markov chain Monte Carlo would be performing another round of Posterior Bootstrap, where $\tilde{\theta}_{1}, \ldots, \tilde{\theta}_{K}$ is used as data. The caveat is, however, that since only asymptotic results are known for Posterior Bootstrap, for a fixed $K$ this strategy would lack a theoretical underpinning. We assume instead that the number of classes, now denoted by $K_{n}$, as well as the number of observations $n_{k}$ in each class, go to infinity. The penalization strategy then yields

$$
\begin{equation*}
\tilde{\lambda}=\underset{\lambda}{\arg \max }\left\{\sum_{k=1}^{K_{n}} v_{k} \log g\left(\tilde{\theta}_{k} \mid \lambda\right)+w_{g}^{T} \log p(\lambda)\right\}, \quad v_{1}, \ldots, v_{K_{n}} \sim \operatorname{Exp}(1) . \tag{25}
\end{equation*}
$$

The parameter $w_{g}$ is set according to methods described in Section 2.3 for $w_{0}$, that is, formula (19) or (20) for matrices $I_{g}$ and $J_{g}$, which we define explicitly in (27). We present the full resulting algorithm in Supplementary Material C.2, and we let $P^{H B, p p}\left(\cdot \mid x_{1: K, 1: n_{k}}\right)$ denote the distribution of $\left(\tilde{\theta}_{1}, \ldots, \tilde{\theta}_{K_{n}}, \tilde{\lambda}\right)$ under this algorithm.

We now describe the assumed data-generating mechanism of $x_{1: K_{n}, 1: n_{k}}$ under this scenario. Let $Q^{*}$ be a distribution on a space of distributions on $\mathbb{R}^{s}$ where $s$ is the dimension of a single observation $x_{k, i}$ for $k=1, \ldots, K_{n}, i=1, \ldots, n_{k}$. We have

$$
\begin{align*}
x_{k, 1}, \ldots x_{k, n_{k}} & \sim P_{k}^{*}, \quad k=1, \ldots, K_{n} \\
P_{1}^{*}, \ldots, P_{K_{n}} & \sim Q^{*} . \tag{26}
\end{align*}
$$

We use our standard notation for pseudo-true parameters $\theta_{k}^{*}$, that is, $\theta_{k}^{*}=\arg \max _{\theta_{k}} E_{p_{k}^{*}}\left\{\log f\left(x \mid \theta_{k}\right)\right\}$. Therefore, $\theta_{1}^{*}, \ldots, \theta_{K}^{*}$ are independent and identically distributed with respect to $Q^{*}$. We additionally define $\lambda^{*}=\arg \max _{\lambda} E_{Q^{*}}\left\{\log g\left(\Theta^{*} \mid \lambda\right)\right\}$ and $\hat{\lambda}_{\theta^{*}}=\arg \max _{\lambda}\left\{\sum_{k=1}^{K_{n}} \log g\left(\theta_{k}^{*} \mid \lambda\right)\right\}$. The information matrices for $\lambda$ are

$$
\begin{equation*}
I_{g}(\lambda)=E_{Q^{*}}\left[\left\{\nabla_{\lambda} \log g\left(\Theta^{*} \mid \lambda\right)\right\}\left\{\nabla_{\lambda} \log g\left(\Theta^{*} \mid \lambda\right)\right\}^{T}\right], \quad J_{g}(\lambda)=-E_{Q^{*}}\left[D_{\lambda}^{2}\left\{\log g\left(\Theta^{*} \mid \lambda\right)\right\}\right] \tag{27}
\end{equation*}
$$

Theorem 3 shows that if $\tilde{\lambda}$ is drawn from (25) and the rate at which $K_{n}$ goes to infinity is slow enough compared with the rate at which $n \rightarrow \infty$, the distribution of $\tilde{\lambda}$ is asymptotically normal with the sandwich covariance matrix.

Theorem 3. Suppose that the data generating mechanism follows (26) and assume that $K_{n} \rightarrow \infty$ as $n \rightarrow \infty$ at a rate such $K_{n}=o\left(n^{1 / 2} / \log n\right)$, where $n=\min _{k=1, \ldots, K_{n}} n_{k}$. Assume also that $\tilde{\lambda}$ is drawn from (25). Then under regularity conditions stated explicitly in Supplementary Material C. 2 we have

$$
P^{H B, p p}\left\{K_{n}^{1 / 2}\left(\tilde{\lambda}-\hat{\lambda}_{\theta^{*}}\right) \in A \mid x_{1: K_{n}, 1: n_{k}}\right\} \rightarrow \operatorname{pr}(Z \in A), \quad Z \sim N\left\{0, J_{g}\left(\lambda^{*}\right)^{-1} I_{g}\left(\lambda^{*}\right) J_{g}\left(\lambda^{*}\right)^{-1}\right\}
$$

with probability going to 1 with respect to $x_{1: K_{n}, 1: n_{k}}$ as $n \rightarrow \infty$, for matrices $I_{g}$ and $J_{g}$ defined in (27).
The regularity conditions used in Theorem 3 are analogues of Assumptions $1-6$ for functions $\log f(x \mid \theta)$ and $\log g(\theta \mid \lambda)$. We additionally require $\log g(\theta \mid \lambda)$ to be sufficiently smooth both with respect to $\lambda$ and $\theta$. The proof of Theorem 3 is reported in Supplementary Material C.2.

Careful examination of the proofs of Proposition 3 and Theorem 3 shows that the same results would hold if we replaced $\tilde{\lambda}$ with $\bar{\lambda}$. If the parameter of interest is $\lambda$, we however advocate using $\tilde{\lambda}$ for inference, as it gives more accurate results. We illustrate the difference between $\bar{\lambda}$ and $\tilde{\lambda}$ on a synthetic dataset in Supplementary Material D.3. On the other hand, if only parameters $\theta_{1}, \ldots, \theta_{K}$ are of interest, the user can skip the step of drawing $\tilde{\lambda}$.

To summarize, we have developed an algorithm for model (21) that demonstrates good asymptotic properties, both for inference on $\theta_{1}, \ldots, \theta_{K}$ and on $\lambda$, while being robust to misspecification. Furthermore, even when the model is well-specified, the fact that Algorithm 2 can be fully parallelized makes it an attractive alternative to Metropolis-within-Gibbs samplers typically used for (21).

## 4 Posterior Bootstrap via pseudo-samples from the prior predictive

### 4.1 Methodology

Using Algorithm 1 is possible for most standard priors, however, for certain distributions combining them with Algorithm 1 would have adverse consequences for the inference, or could even be impossible from a computational point of view. Firstly, formulation of Algorithm 1 necessitates that evaluating $\log \pi(\theta)$ is possible for every $\theta$, which is not the case, for example for the original spike-and-slab prior [Mitchell and Beauchamp, 1988]. Moreover, there is a widely used group of priors that are infinite on the boundary on the set, for example the Gamma distribution $\Gamma(\alpha, \beta)$ with $\alpha<1$, Dirichlet prior $\mathcal{D}\left(\alpha_{1}, \cdots, \alpha_{k}\right)$ with some of the $\alpha_{j}<1$ as advocated for instance by Rousseau and Mengersen [2011] for mixture models. For these priors Algorithm 1 would always return the boundary of the set, regardless of the data.

To overcome these drawbacks, we consider another version of Posterior Bootstrap, proposed originally by Fong et al. [2019]. We summarize it in Algorithm 3. The prior information is incorporated into the algorithms via drawing so-called pseudo-samples from the prior predictive.

To obtain the Edgeworth expansion of Algorithm 3, we no longer need Assumption 6 to hold so replace it with a milder condition. To this end we define the prior predictive density as $f_{\pi}(x)=\int f(x \mid \theta) \pi(\theta) \mathrm{d} \theta$.
Assumption 7. The quantity $\alpha_{\theta, \pi}=\int \nabla_{\theta}\{\log f(x \mid \theta)\} f_{\pi}(x) \mathrm{d} x$ is continuous as a function of $\theta \in B$.
Theorem 4. Consider model (1) with a parameter of interest $\theta \in \mathbb{R}^{d}$ and suppose Assumptions $1-5,7$ hold. As $n \rightarrow \infty$ with probability going to 1 the Edgeworth expansion of the density of $I_{n}^{-1 / 2} J_{n} n^{1 / 2}(\tilde{\theta}-\hat{\theta})$ for $\tilde{\theta}$ drawn from Algorithm 3 is given by:

$$
\begin{equation*}
\phi(y)\left\{1+I\left(\theta^{*}\right)^{-1 / 2} \frac{\left(c \alpha_{\theta^{*}, \pi}\right)^{T} y}{n^{1 / 2}}+\frac{P_{3, n}(y)}{n^{1 / 2}}\right\}+o\left(n^{-1 / 2}\right) \tag{28}
\end{equation*}
$$

for a constant $\alpha_{\theta^{*}, \pi}$ defined like in Assumption 7 for $\theta=\theta^{*}$, and for $P_{3, n}$ defined in Theorem 2.

The proof of Theorem 4 follows analogous steps to the proof of Theorem 2, for details see Supplementary Material B.5.

Since the prior information enters into the second order Edgeworth expansion via an intractable constant $\alpha_{\theta^{*}, \pi}$, in this case the impact of the prior has a slightly more cumbersome interpretation than in case of Algorithm 1. However, to shed some light on possible interpretations of this constant, note that $\alpha_{\theta^{*}, \pi}$ is an integral of $\nabla_{\theta}\left\{\log f\left(x \mid \theta^{*}\right)\right\}$ with respect to the prior predictive $\int f(x \mid \theta) \pi(\theta) \mathrm{d} \theta$ and can also be written as

$$
\alpha_{\theta^{*}, \pi}=\int\left[\nabla_{\theta}\left\{\log f\left(x \mid \theta^{*}\right)\right\}\left\{f_{\pi}(x)-f\left(x \mid \theta^{*}\right)\right\}\right] \mathrm{d} x .
$$

since $\int \nabla_{\theta}\left\{\log f\left(x \mid \theta^{*}\right)\right\} f\left(x \mid \theta^{*}\right) d x=0$. Therefore $\alpha_{\theta^{*}, \pi}$ measures the difference between the prior predictive and the predictive distribution under $\theta^{*}$.

The form of $\alpha_{\theta^{*}, \pi}$ makes it difficult to provide detailed general guidelines on the appropriate choice of $c$. For well-specified models $c$ should be interpreted as the effective sample size of the prior, which we make explicit in Section 4.2 for conjugate priors in exponential families. Importantly, as opposed to the choice of $w_{0}$ in Algorithm 1, the optimal choice of $c$ depends both on the likelihood and the prior. Parameter $T$ does not appear in the second order Edgeworth expansion and we do not expect it to have much effect on the results.

Remark 2. Posterior Bootstrap via pseudo-samples can also be used for hierarchical models (21) within Algorithm 2. The procedure would involve drawing $\bar{\lambda}$ from $p\left(\lambda \mid \hat{\theta}_{1}, \ldots, \hat{\theta}_{K}\right)$, then drawing pseudo-samples given $\bar{\lambda}$ to finally compute $\tilde{\theta}_{1}, \ldots, \tilde{\theta}_{K}$. Using the same value of $\bar{\lambda}$ across all $K$ groups induces correlation between $\tilde{\theta}_{1}, \ldots, \tilde{\theta}_{K}$. Inference on $\tilde{\lambda}$ given $\tilde{\theta}_{1}, \ldots \tilde{\theta}_{K}$ can then be performed using methods described in Section 3.2, and its theoretical properties would be analogous to those presented in Proposition 3 and Theorem 3.

As mentioned in Section 1.2, another method of incorporating prior information is Algorithm 1 of Lyddon et al. [2018]. It is similar to Algorithm 3, but instead of drawing $\bar{\theta}$ from the prior $\pi(\theta), \bar{\theta}$ is drawn from the Bayesian posterior $\pi\left(\theta \mid x_{1: n}\right)$. Nevertheless, it turns out that the impact of the prior in that algorithm is negligible, as the prior information does not enter into the second order Edgeworth expansion.

To see this, note that the second order Edgeworth expansion for Algorithm 1 of Lyddon et al. [2018] can be obtained using analogous calculations to those required to prove Theorem 4. The expansion would thus be given by (28), where instead of the constant $\alpha_{\theta^{*}, \pi}$ we have

$$
\beta_{\theta^{*}, \pi}=\int \nabla_{\theta}\left\{\log f\left(x \mid \theta^{*}\right)\right\}\left\{\int f(x \mid \theta) \pi\left(\theta \mid x_{1: n}\right) \mathrm{d} \theta\right\} \mathrm{d} x .
$$

Since the posterior $\pi\left(\theta \mid x_{1: n}\right)$ concentrates around $\theta^{*}$ as $n \rightarrow \infty$, we have $\beta_{\theta^{*}, \pi}=o_{P}(1)$ and therefore the prior information does not enter into the second order Edgeworth expansion. Details are provided in Supplementary Material B.6.

### 4.2 Choice of $c$ in Algorithm 3

We consider a special case of regular exponential families in a canonical form

$$
f(x \mid \theta)=h(x) \exp \left\{T(x)^{T} \theta-A(\theta)\right\} .
$$

The corresponding conjugate prior on $\theta$ is

$$
\begin{equation*}
\pi(\theta)=\pi\left(\theta \mid \tau, n_{0}\right)=H\left(\tau, n_{0}\right) \exp \left\{\tau^{T} \theta-n_{0} A(\theta)\right\} \tag{29}
\end{equation*}
$$

for some hyperparameters $\tau$ and $n_{0}$. The resulting posterior follows $\pi\left(\theta \mid \tau+\sum_{i=1}^{n} T\left(x_{i}\right), n_{0}+n\right)$. We can therefore interpret $n_{0}$ as the number of pseudo-samples quantifying the amount of information in the prior, called also effective sample size.

In this special case we can compute the expression $c \alpha_{\theta^{*}, \pi}$ appearing in the Edgeworth expansion for Algorithm 3. We have

$$
\alpha_{\theta^{*}, \pi}=\int\left\{T(x)-\nabla_{\theta} A\left(\theta^{*}\right)\right\} \int f(x \mid \theta) \pi(\theta) \mathrm{d} \theta d x=\int \nabla_{\theta} A(\theta) \pi(\theta) \mathrm{d} \theta-\nabla_{\theta} A\left(\theta^{*}\right) .
$$

where the last equality follows from the property of exponential families that $E_{\theta}\{T(X)\}=\nabla_{\theta} A(\theta)$. Since $\int \nabla_{\theta} \pi(\theta) \mathrm{d} \theta=0$, see Diaconis and Ylvisaker [1979], we get that

$$
\tau-n_{0} \int \nabla_{\theta} A(\theta) \pi(\theta) \mathrm{d} \theta=\int\left\{\tau-n_{0} \nabla_{\theta} A(\theta)\right\} \pi(\theta) \mathrm{d} \theta=\int \nabla_{\theta} \pi(\theta) \mathrm{d} \theta=0
$$

Then $\alpha_{\theta^{*}, \pi}=\tau / n_{0}-\nabla_{\theta} A\left(\theta^{*}\right)$. Recall that when we instead use Algorithm 1, the corresponding term in the Edgeworth expansion is given by $w_{0}^{T} \nabla_{\theta} \log \pi\left(\theta^{*}\right)$, which in case of the prior (29) is equal to $w_{0}^{T}\left\{\tau-n_{0} A\left(\theta^{*}\right)\right\}$. Therefore in this special case setting $c=n_{0}$ in Algorithm 3 yields the same second order Edgeworth expansion as setting $w_{0}=1$ in Algorithm 1. The above reasoning confirms our intuition that for well-specified models we should set $c$ representing the weight of the prior included via pseudosamples to be equal to the effective sample size of that prior.

In fact using Posterior Bootstrap for well-specified exponential models with conjugate priors seems rather contrived, as one can in this case sample directly from the Bayesian posterior. However, under the misspecified scenario Posterior Bootstrap is more robust than Bayesian inference. In that case we propose to set the optimal $c$ as

$$
\begin{equation*}
c^{*}=\bar{w}_{0}^{*} n_{0} \tag{30}
\end{equation*}
$$

for $\bar{w}_{0}^{*}$ defined in (20).

## 5 Illustrations

### 5.1 Toy examples

We first analyse the following toy model

$$
\begin{equation*}
x_{1}, \ldots, x_{n} \sim N(\theta, 1), \quad \theta \sim \operatorname{Gamma}(5,3) \tag{31}
\end{equation*}
$$

We consider three different scenarios by generating $x_{1}, \ldots, x_{n} \sim N\left(10, \sigma^{2}\right)$ for $n=200$ with $\sigma^{2}=1$, $\sigma^{2}=2.8$ or $\sigma^{2}=0.6$. The correct model would then be

$$
\begin{equation*}
x_{1}, \ldots, x_{n} \sim N\left(\theta, \sigma^{2}\right), \quad \theta \sim \operatorname{Gamma}(5,3) \tag{32}
\end{equation*}
$$

Recall from Section 2.3 that $w_{0}^{*}$ would in this case be equal to $\sigma^{2}$. We ran Algorithm 1 for this model with different values of $w_{0}$ and measured the Kolmogorov-Smirnov dissimilarity between the empirical distribution of the obtained samples, and samples from the Bayesian posterior applied to the correct model. In this special case making such a comparison is justified since $\theta$ has the same interpretation of being the mean under both models, and the difference between these models lies only in the uncertainty around the mean. As shown in Figure 1, we indeed observe the shortest distance for $w_{0}=w_{0}^{*}$. For additional plots and comparisons with other methods we refer the reader to Supplementary Material D.1.

We now analyse another toy example, with a misspecified model

$$
\begin{equation*}
x_{1}, \ldots, x_{n} \sim N\left(\theta, \Sigma_{1}\right), \quad \theta \sim N\left(\mu_{0}, \Sigma_{0}\right) \tag{33}
\end{equation*}
$$

whereas correct model is

$$
\begin{equation*}

We set

0.7 & 0.6 \\
0.6 & 3
\end{array}\right]
$$

so that the example is characterized by overdispersion of one coordinate, and underdispersion of the other. Moreover, following the discussion in Section 2.3, in this example correlation between variables makes it impossible for (18) to hold. In our experiment the data $x_{1}, \ldots, x_{n}$ for $n=200$ is generated from $N\left\{(0,0), \Sigma_{2}\right\}$. In Figure 2 we compare three versions of Posterior Bootstrap for model (33) with standard Bayesian posterior and two methods of robust Bayesian inference: BayesBag [Huggins and Miller, 2019] and power posteriors with the optimal power $\eta^{*}$ as proposed by Lyddon et al. [2019]. The plots show that Algorithm 1 outperforms other methods on this example returning samples that are closer to the Bayesian posterior under the correct model (34). We notice that the power posterior approach governed by a single parameter $\eta$ is unable to capture overdispersion of one coordinate and underdispersion of the other, whereas BayesBag with the choice of hyperparameters advocated in Section 2.2.1 of Huggins and Miller [2019] tends to slightly overestimate the uncertainty. We also conclude that treating $w_{0}$ as a two-dimensional vector rather than a single value helps to better incorporate the prior information.

We present an additional toy example for a hierarchical model in Supplementary Material D.2.

### 5.2 Overdispersed and underdispersed Poisson regression

A common approach for modelling count data is the Poisson regression:

with a prior distribution on the vector of coefficients $\beta$. The above model assumes that $E\left(Y_{i} \mid x_{i}\right)=$ $\operatorname{var}\left(Y_{i} \mid x_{i}\right)$. In practice this assumption may be violated and the data exhibits either overdispersion or underdispersion relative to model (35). In case of the former an alternative is using the negative binomial regression model, for the latter however no simple alternative is known.

The COM-Poisson regression [Shmueli et al., 2005, Sellers and Shmueli, 2010] was proposed as a generalization of the Poisson model, which can handle different levels of dispersion, including underdispersion. Since the COM-Poisson likelihood [Conway and Maxwell, 1962] has an intractable constant,

Bayesian inference with the COM-Poisson regression requires non-standard and computationally costly Monte Carlo methods, based on a rejection sampler used within the exchange algorithm [Møller et al., 2006, Murray et al., 2012], as proposed by Chanialidis et al. [2018] and Benson and Friel [2021]. Another issue with this approach is interpretability since in the COM-Poisson model it is no longer true that $E\left(Y_{i} \mid x_{i}\right)=\beta_{0}+\beta_{1} x_{1, i}+\cdots+\beta_{p} x_{p, i}$.

An alternative could be to use Algorithm 1, which preserves the usual interpretability of parameter $\beta$, while being able to handle both underdispersion and overdispersion. The fact that Algorithm 1 can be fully parallelized and does not require tuning gives it a significant computational advantage over complex Monte Carlo methods proposed for the COM-Poisson regression. We illustrate the overdispersed Poisson regression with the Articles example from the Rchoice package [Sarrias, 2016] in R, which studies the number of articles published during scientists' Ph.D. studies. We preprocess the data following Chanialidis et al. [2018], who analysed the same example. For underdispersed Poisson models, we use as an illustration the cottonbolls example from the mpcmp package [Fung et al., 2020], modelling number of bolls produced by the cotton plants. Figure 3 shows that Algorithm 1 corrects both for overdispersion and underdispersion. Power posteriors also perform well on these examples, however in general this approach is less flexible in accounting for misspecification than Posterior Bootstrap.

### 5.3 Dirichlet allocation model for opioid crisis data

We illustrate Posterior Bootstrap for hierarchical models, as well as the use of pseudosamples on a Dirichlet allocation model [Glynn et al., 2019] of deaths caused by drug overdoses in the United States [Ahmad et al., 2021]. The data comprise 139 observations, where each observation is the numbers of deaths due to each of six drug types in a given state and year. Our primary interest lies in $\lambda=\left(\lambda_{1}, \ldots, \lambda_{6}\right)$, which describes the expected proportion of deaths in each category. For each coordinate of $\lambda$, we assume a $\mathrm{N}\left(0, \tau^{2}\right)$ prior truncated to the positive half-line, denoted $\mathrm{TN}\left(0, \tau^{2}\right)$ below. For $m_{k}=\left(m_{k, 1}, \ldots, m_{k, 6}\right)$, where $m_{k, l}$ is the deaths by drug type $l$ in state-year $k$, we write the model:

m_{k} & \sim \operatorname{Multinomial}\left(\theta_{k}, n_{k}\right), & & k=1, \ldots, 139 \\
\theta_{k} & \sim \operatorname{Dirichlet}(\lambda), & & k=1, \ldots, 139  \tag{36}\\
\lambda_{l} & \sim \operatorname{TN}\left(0, \tau^{2}\right), & & l=1, \ldots, 6 .
\end{align*}
$$

By comparing $I_{g}$ and $J_{g}$ as defined in (27), we suspect that the Dirichlet model for $\theta_{k}$ given $\lambda$ is misspecified. This, as well as the fact that the number of classes $K=139$ is large motivates using (25)

for inference on $\lambda$. As for the inference on $\theta_{k}$, following the discussion in Section 4.1 we cannot use the penalization-based approach, due to the $\operatorname{Dirichlet}(\lambda)$ prior possibly with some components smaller than 1. We therefore follow the strategy based on pseudo-samples, and conjugacy of the model motivates setting $c$ according to (30). We present the full resulting algorithm in Supplementary Material D.3.

Figure 4 displays the posterior distribution on parameter $\lambda$ in (36) using Posterior Bootstrap and Bayesian inference performed with Metropolis-within-Gibbs Markov chain Monte Carlo. As $\tau$ decreases, the truncated normal prior concentrates on zero and we observe a shift in distributions under both methods, which confirms that our method incorporates the prior in a similar way to Bayesian inference. The results for the two methods are different, and we expect this to be due to model misspecification. In Supplementary Material D. 3 we present an analogous analysis on a synthetic dataset generated from model (36) and show that the results delivered by these methods are then the same. In addition to correcting for model misspecification, Posterior Bootstrap runs in parallel with virtually no tuning and without the requirement for convergence diagnostics in Markov chain Monte Carlo-based inference.

## 6 Limitations of methods based on Weighted Likelihood Bootstrap

In previous sections we focused on positive aspects and properties of Weighted Likelihood Bootstrap and its extensions, such as its computational advantages and its capability to correct the uncertainty in case of model misspecification. The aim of this section is to answer some frequently asked questions about limitations of Weighted Likelihood Bootstrap and its extensions.

There are numerous situations when Posterior Bootstrap cannot be used for computational reasons, whereas standard Bayesian modelling combined with some Markov chain Monte Carlo methods prove to be successful. Firstly, by construction of the algorithms it is implicitly assumed that one can numerically find a maximum of the randomized likelihood function, which is typically done using gradient-based methods. However, if the parameter of interest live in a discrete space, or a mix of discrete and continuous state spaces, this will not be possible. There exists a vast literature on Gibbs samplers that deal effectively with such models, for example [Richardson and Green, 1997, Titsias and Yau, 2017, Zanella, 2020]. Secondly, the Posterior Bootstrap algorithms cannot be used in case of intractable likelihoods, that is, when the likelihood has a form $f(x \mid \theta) / Z(\theta)$ for some unknown function $Z(\theta)$. Again, several Markov chain Monte Carlo methods have been proposed for target distributions of that type, for example [Møller

et al., 2006, Andrieu and Roberts, 2009, Murray et al., 2012, Deligiannidis et al., 2018, Middleton et al., 2020].

We would also like to note a limitation related specifically to Algorithm 3. Recall that the guidance on setting parameter $c$ is well-understood only for conjugate models due to its link with the effective sample size of the prior. Our intuition, confirmed by simulations, is that in non-conjugate scenarios choosing $c$ may be problematic. Pseudo-samples drawn from the prior predictive are often outliers with respect to the original dataset, and this phenomenon is particularly pronounced for vague priors. Therefore assigning too large importance to the pseudo-samples leads to unstable results and consequently distorts the inference. Another issue is that a one-dimensional parameter $c$ controls the impact of the prior on all coordinates, as we showed in Theorem 4.

There have been attempts in the Bayesian literature to extend the notion of the effective sample size beyond the conjugate scenario, and quantify the amount of information in the prior relative to the assumed sampling distribution, for example Morita et al. [2008, 2012], Neuenschwander et al. [2020]. Developing the appropriate methodology for the choice of $c$ in general models, potentially based on the approaches cited above, as well as supporting it with theoretical results, is an interesting future work direction.

Even though Posterior Bootstrap methods can alleviate the consequences of model misspecification, this approach is not always optimal. In particular, as we showed in Theorem 1, in certain cases power posteriors are provably better in terms of prediction. Furthermore, it is important to emphasize that Posterior Bootstrap, as well as power posteriors and BayesBag described in Section 1.1, rely on correcting automatically the uncertainty around parameters, while preserving the same asymptotic mean. There are cases when the user has some prior knowledge about the nature of misspecification and has more trust in certain parts of the model than others. The cut model approach, also called modular inference, relies on cutting feedback, or the information flow, from the part of the model which we put less trust in to the one we trust more. This way of tackling misspecification allows the user to make better use of their understanding of the model than when applying more automatic approaches listed earlier. Bayesian literature on the cut model approach includes [Liu et al., 2009, Plummer, 2015, Jacob et al., 2017, Carmona and Nicholls, 2020].

## A Proof of Theorem 1

Proof. Let $\hat{p}_{\hat{\theta}}, \hat{p}_{B}$ and $\hat{p}_{\pi_{\eta}}$ denote the predictive distributions under $\hat{\theta}$, Efron's bootstrap [Efron, 1979] and power posterior $\pi_{\eta}$ respectively.

Firstly, note that for the risk associated with $\hat{p}_{B}$, we can use directly the formula given by Fushiki [2005] as follows:

\end{aligned}
$$

To obtain an analogous formula for the risk associated with $\hat{p}_{\pi_{\eta}}$, we can use Lemma 5 of Shimodaira [2000] with

where the last equality holds because the expectation of the score function at $\theta^{*}$ is 0 . We therefore have

Recall that $\lambda_{1}, \ldots, \lambda_{d}$ denote the eigenvalues of $J^{-1 / 2}\left(\theta^{*}\right) I\left(\theta^{*}\right) J^{-1 / 2}\left(\theta^{*}\right)$. By modifying calculations from Section 2 of Fushiki [2005] we get

& -\frac{1}{2 n}\left[\eta^{-1} \operatorname{tr}\left\{I\left(\theta^{*}\right) J^{-1}\left(\theta^{*}\right)\right\}-\eta^{-1} d\right]+o(1 / n) \\
= & \frac{1}{2 n} \operatorname{tr}\left[\left\{J^{-1 / 2}\left(\theta^{*}\right) I\left(\theta^{*}\right) J^{-1 / 2}\left(\theta^{*}\right)\right\}^{2}\right]-\frac{\left(1+\eta^{-1}\right)}{2 n} \operatorname{tr}\left\{J^{-1 / 2}\left(\theta^{*}\right) I\left(\theta^{*}\right) J^{-1 / 2}\left(\theta^{*}\right)\right\} \\
& +\frac{\eta^{-1} d}{2 n}+o(1 / n) \\
= & \frac{1}{2 n} \sum_{i=1}^{d}\left\{\lambda_{i}^{2}-\left(1+\eta^{-1}\right) \lambda_{i}+\eta^{-1}\right\}+o(1 / n) \\
= & \frac{1}{2 n} \sum_{i=1}^{d}\left(\lambda_{i}-1\right)\left(\lambda_{i}-\eta^{-1}\right)+o(1 / n)
\end{aligned}
$$

Finally, we use Theorem 1 of Fushiki [2010] which captures the relationship between the risk associated with Weighted Likelihood Bootstrap and the risk associated with Efron's bootstrap, that is

where $\hat{p}_{\text {WLB }}$ denotes the predictive distribution under Weighted Likelihood Bootstrap. Therefore also

We finally observe that the expression $\sum_{i=1}^{d}\left(\lambda_{i}-1\right)\left(\lambda_{i}-\eta^{-1}\right)$ is negative when all eigenvalues are between 1 and $\eta^{-1}$. This completes the proof.

## B Proofs of theoretical results presented in Sections 2 and 4

## B. 1 Summary and Assumption 3

The proofs of Theorems 2 and 4 require similar reasoning and calculations. We therefore present below a detailed version of the proof of Theorem 2 and refer to it when proving Theorem 4. The plan of action is as follows. We start by obtaining an expansion for $n^{1 / 2}(\tilde{\theta}-\hat{\theta})$. Then applying Lemma 1 , we show that the Edgeworth expansion of this expression is indeed valid. Finally, we compute the coefficients of the Edgeworth expansion using the formula provided in Chapter 2 of Ghosh [1994]. We start by presenting the full version of Assumption 3 and introducing the notation used in the proofs.

Assumption 3. (Smoothness of the log likelihood function).(Smoothness of the log likelihood function). There is an open ball $B$ containing $\theta^{*}$ such that $\ell(x, \theta)$ is three times continuously differentiable with respect to $\theta \in B$ almost surely on $x$. Furthermore, there exist measurable functions $G_{1}, G_{2}$ and $G_{3}$ such that for $\theta \in B$

## B. 2 Notation

We will adopt the following notation. Suppose $C \in \mathbb{R}^{d \times d \times d}$ and $v$ is a vector in $\mathbb{R}^{d}$. Then $v^{3} \in \mathbb{R}^{d \times d \times d}$ and the element $i j k$ of $v^{3}$ is given by

## B. 3 Auxiliary results

Our main tools for obtaining the Edgeworth expansion from the Taylor expansion are the two formulas below. The first one links the characteristic function of a variable $Y \in \mathbb{R}^{d}$ with its density, that is if $\left|\psi_{Y}(t)\right|<\infty$,

Finally, for $1 \leq q, r, s \leq d$, for pairwise different indices $q, r, s$ we obtain the following equality

Our proof of existence of valid Edgeworth expansions will rely on Lemma 1 below. Before stating the result, we introduce some additional notation. Let $a_{j}=\left(a_{j, 1}, \ldots, a_{j, d}\right) \in \mathbb{R}^{d}$ and define $\bar{a}_{2, n} \in \mathbb{R}^{d \times d}$ as

Hence element $(q, r)$ of $\bar{a}_{2, n}$ is equal to $\frac{1}{n} \sum_{j=1}^{n} a_{j, q} a_{j, r}$. Similarly, let $\bar{a}_{3, n} \in \mathbb{R}^{d \times d \times d}$ be such that element $(q, r, s)$ of $\bar{a}_{3, n}$ is given by $\frac{1}{n} \sum_{j=1}^{n} a_{j, q} a_{j, r} a_{j, s}$. Furthermore, we let $b_{j}=\bar{a}_{2, n}^{-1 / 2} a_{j}$, and similarly set $\bar{b}_{3, n} \in \mathbb{R}^{d \times d \times d}$ so that element $(q, r, s)$ of $\bar{b}_{3, n}$ is given by $\frac{1}{n} \sum_{j=1}^{n} b_{j, q} b_{j, r} b_{j, s}$, where $b_{j, q}$ denotes element $q$ of $b_{j}$. Note that $a_{j}$ and $b_{j}$ may depend on $n$.
Lemma 1. We consider $\mathbb{R}$-valued independent random variables $Z_{1}, \ldots, Z_{n}$ distributed according to some continuous distribution $Z$ having all moments and satisfying $E(Z)=1$ and $\operatorname{var}(Z)=1$. Let $\left(a_{j}\right)_{j=1}^{n} \in \mathbb{R}^{d}$, be a sequence of vectors in $\mathbb{R}^{d}$, possibly depending on $n$ and satisfying conditions a) - c) below.

Assume that there exists a sequence $\epsilon_{n}=o(1)$ such that
a) There exist $A_{2} \in \mathbb{R}^{d \times d}, A_{2} \succ 0$ and $A_{3} \in \mathbb{R}^{d \times d \times d}$ such that $\left\|\bar{a}_{2, n}-A_{2}\right\| \leq \epsilon_{n}$ and $\left\|\bar{a}_{3, n}-A_{3}\right\| \leq \epsilon_{n}$ for $n \geq 1$.
b) We have $\sup _{n} \frac{1}{n} \sum_{j=1}^{n}\left\|a_{j}\right\|^{4}<\infty$.
c) For any $n \geq 1$ we have $\sup _{j \leq n}\left\|a_{j}\right\| \leq \epsilon_{n} n^{1 / 2}$.

Then $S_{n}$ defined as

S_{n}=\frac{\bar{a}_{2, n}^{-1 / 2}}{n^{1 / 2}} \sum_{j=1}^{n} a_{j} Z_{j}
$$

has a valid Edgeworth expansion. Moreover the expansion of the characteristic function $\psi_{S_{n}}$ of $S_{n}$ up to the term o $\left(n^{-1 / 2}\right)$ is given by

\psi_{S_{n}}(t)=\exp \left(-\frac{t^{T} t}{2}\right)\left(1+i^{3} \gamma \frac{\sum_{1 \leq q, r, s \leq d} B_{q, r, s} t_{q} t_{r} t_{s}}{6 n^{1 / 2}}\right)+o\left(n^{-1 / 2}\right)
$$

where $\gamma=E\left(Z^{3}\right)$ and $B=\lim _{n \rightarrow \infty} \bar{b}_{3, n}$.
Proof. Before proceeding with the proof, observe that the limit $\lim _{n \rightarrow \infty} \bar{b}_{3, n}$ exists by definition of $b_{j}$ and assumption a), thus $B$ is well-defined with all elements finite.

The characteristic function of $S_{n}$ is given by:

\psi_{S_{n}}(t)=E\left\{\exp \left(i t^{T} S_{n}\right)\right\}=E\left[\exp \left\{i t^{T}\left(\frac{\bar{a}_{2, n}^{-1 / 2}}{n^{1 / 2}} \sum_{j=1}^{n} a_{j} Z_{j}\right)\right\}\right]=\prod_{j=1}^{n} \psi_{Z}\left(\frac{t^{T} b_{j}}{n^{1 / 2}}\right),
$$

where $\psi_{Z}$ is the characteristic function of $Z$. Using the fact that $E(Z)=0$ and $E\left(Z^{2}\right)=1$ we have

\psi_{Z}\left(\frac{t^{T} b_{j}}{n^{1 / 2}}\right) & =E\left\{\exp \left(i \frac{t^{T} b_{j}}{n^{1 / 2}} Z\right)\right\} \\
& =E\left\{1+\frac{i\left(t^{T} b_{j}\right) Z}{n^{1 / 2}}+\frac{i^{2}\left(t^{T} b_{j}\right)^{2} Z^{2}}{2 n}+\frac{i^{3}\left(t^{T} b_{j}\right)^{3} Z^{3}}{6 n^{3 / 2}}\right\}+O\left(\frac{\left\|b_{j}\right\|^{4} E Z^{4}}{n^{2}}\right) \\
& =1-\frac{\left(t^{T} b_{j}\right)^{2}}{2 n}+\frac{i^{3}\left(t^{T} b_{j}\right)^{3} \gamma}{6 n^{3 / 2}}+O\left(\frac{\left\|b_{j}\right\|^{4} E Z^{4}}{n^{2}}\right) \\
& =1-\frac{\left(t^{T} b_{j}\right)^{2}}{2 n}+\frac{i^{3}\left(t^{T} b_{j}\right)^{3} \gamma}{6 n^{3 / 2}}+O\left(\frac{\left\|b_{j}\right\|^{4}}{n^{2}}\right)
\end{aligned}
$$

since $E\left(Z^{4}\right)<\infty$.
Note that the definition of $b_{j}$ yields the following simple equality:

& =t^{T} \bar{a}_{2, n}^{-1 / 2}\left(\frac{1}{n} \sum_{j=1}^{n} a_{j} a_{j}^{T}\right) \bar{a}_{2, n}^{-1 / 2} t=t^{T} t . \tag{42}
\end{align*}
$$

Therefore

\prod_{j=1}^{n} \psi_{Z}\left(\frac{t^{T} b_{j}}{n^{1 / 2}}\right) & =\exp \left[\sum_{j=1}^{n} \log \left\{1-\frac{\left(t^{T} b_{j}\right)^{2}}{2 n}+\frac{i^{3}\left(t^{T} b_{j}\right)^{3} \gamma}{6 n^{3 / 2}}+O\left(\frac{\left\|b_{j}\right\|^{4}}{n^{2}}\right)\right\}\right] \\
& =\exp \left(\sum_{j=1}^{n}\left[-\frac{\left(t^{T} b_{j}\right)^{2}}{2 n}+\frac{i^{3}\left(t^{T} b_{j}\right)^{3} \gamma}{6 n^{3 / 2}}+O\left(\frac{\left\|b_{j}\right\|^{4}}{n^{2}}\right)+O\left\{\frac{\left(t^{T} b_{j}\right)^{4}}{4 n^{2}}\right\}\right]\right) \\
& =\exp \left\{-\frac{t^{T} t}{2}+\frac{i^{3} \sum_{j=1}^{n}\left(t^{T} b_{j}\right)^{3} \gamma}{6 n^{3 / 2}}+O\left(n^{-1}\right)\right\} \\
& =\exp \left(-\frac{t^{T} t}{2}\right)\left(1+i^{3} \gamma \frac{\sum_{1 \leq q, r, s \leq d} B_{q, r, s} t_{q} t_{r} t_{s}}{6 n^{1 / 2}}\right)+o\left(n^{-1 / 2}\right)
\end{aligned}
$$

The second equality above comes from the Taylor expansion of $\log (1-x)$ around $x=0$ and the fact that for some constant $c$ and any $n$ we have $\sup _{j \leq n}\left\|b_{j}\right\| \leq c \epsilon_{n} n^{1 / 2}$ so that $\sup _{j \leq n}\left\|b_{j}\right\|^{2} / n=o(1)$, which follows from convergence of $\bar{a}_{2, n}$ to $A_{2}$ and assumption c). The third equality above results from (42) and the fact that $\sup _{n} \sum_{j=1}^{n}\left\|b_{j}\right\|^{4} / n<\infty$ by convergence of $\bar{a}_{2, n}$ to $A_{2}$ and assumption b). The last equality comes from $\left\|\bar{b}_{3, n}-B\right\|=o(1)$. Applying formulas (37) as well as (39), (40) and (41) we get the Edgeworth expansion up to $o\left(n^{-1 / 2}\right)$.

## B. 4 Proof of Theorem 2

## Taylor expansion

We begin the proof by writing the Taylor expansion as follows. Let

$$

and consequently

\left\{-\frac{1}{n} D_{\theta}^{2} L_{n}(\hat{\theta})\right\} n^{1 / 2}(\tilde{\theta}-\hat{\theta})=\frac{\nabla_{\theta} L_{n}(\hat{\theta})}{n^{1 / 2}}+\frac{D_{\theta}^{3} L_{n}(\hat{\theta})(\tilde{\theta}-\hat{\theta})^{2}}{2 n^{1 / 2}}+o_{P}\left(\|\tilde{\theta}-\hat{\theta}\|^{2}\right) \tag{43}
\end{equation*}
$$

We now use Assumptions 1 and 2 to state that $(\tilde{\theta}-\hat{\theta})=o_{P}(1)$. We use the following notation

S_{1, w, n} & =\frac{\sum_{j=1}^{n}\left(w_{j}-1\right) \nabla_{\theta} \ell\left(x_{j}, \hat{\theta}\right)}{n^{1 / 2}}, & S_{2, w, n} & =\frac{\sum_{j=1}^{n}\left(w_{j}-1\right)\left\{-D_{\theta}^{2} \ell\left(x_{j}, \hat{\theta}\right)\right\}}{n^{1 / 2}}, \\
J_{w, n} & =-\frac{1}{n} \sum_{j=1}^{n} w_{j} D_{\theta}^{2} \ell\left(x_{j}, \hat{\theta}\right), & \mu_{3, w, n} & =\frac{1}{n} \sum_{j=1}^{n} w_{j} D_{\theta}^{3} \ell\left(x_{j}, \hat{\theta}\right), \\
\mu_{3, n} & =\frac{1}{n} \sum_{j=1}^{n} D_{\theta}^{3} \ell\left(x_{j}, \hat{\theta}\right), & E_{p^{*}}\left\{D_{\theta}^{3} \ell\left(X, \theta^{*}\right)\right\}, \\
A_{3, n} & =\frac{1}{n} \sum_{j=1}^{n}\left\{\nabla_{\theta} \ell\left(x_{j}, \hat{\theta}\right)\right\}^{3}, & A_{3} & =E_{p^{*}}\left\{\nabla_{\theta} \ell\left(X, \theta^{*}\right)\right\}^{3}, \\
\tilde{L}_{1,2, n} & =\frac{1}{n} \sum_{j=1}^{n} D_{\theta}^{2} \ell\left(x_{j}, \hat{\theta}\right) J_{n}^{-1} \nabla_{\theta} \ell\left(x_{j}, \hat{\theta}\right), & \tilde{L}_{1,2} & =E_{p^{*}}\left\{D_{\theta}^{2} \ell\left(X, \theta^{*}\right) J\left(\theta^{*}\right)^{-1} \nabla_{\theta} \ell\left(X, \theta^{*}\right)\right\} .
\end{array}
$$

We observe that since $\left\|J_{n}-J(\hat{\theta})\right\|=o_{P}(1)$ and $\left\|I_{n}-I(\hat{\theta})\right\|=o_{P}(1)$, then by Assumption 4 matrices $I_{n}, J_{n}$ as well as $J_{w, n}$ are positive definite and hence invertible for large $n$. Furthermore, Assumption 3 ensures that $A_{3}, \tilde{L}_{1,2}$ and $\mu_{3}$ are finite. In passing, $A_{3}$ and $\mu_{3}$ are defined above for an arbitrary dimension $d$, they are however consistent with the one-dimensional definitions presented in (9).

Note also that since $\sum_{j=1}^{n} \nabla_{\theta} \ell\left(x_{i}, \hat{\theta}\right)=0$, then $S_{1, w, n}=n^{-1 / 2}\left\{\sum_{j=1}^{n} w_{j} \nabla_{\theta} \ell\left(x_{i}, \hat{\theta}\right)\right\}$. We can therefore rewrite (43) as

n^{1 / 2}(\tilde{\theta}-\hat{\theta})=J_{w, n}^{-1}\left\{S_{1, w, n}+\frac{w_{0} \cdot \nabla_{\theta} \log \pi(\hat{\theta})}{n^{1 / 2}}\right\}+J_{w, n}^{-1} \frac{\mu_{3, w, n}(\tilde{\theta}-\hat{\theta})^{2}}{2 n^{1 / 2}}+o_{P}\left(\|\tilde{\theta}-\hat{\theta}\|^{2}\right) \tag{44}
\end{equation*}
$$

Let I denote the $d \times d$ identity matrix. We have $J_{w, n}=J_{n}+S_{2, w, n} / n^{1 / 2}$, and so

J_{w, n}^{-1} & =\left\{J_{n}\left(\mathbf{I}+J_{n}^{-1} S_{2, w, n} / n^{1 / 2}\right)\right\}^{-1} \\
& =\left(\mathbf{I}+J_{n}^{-1} S_{2, w, n} / n^{1 / 2}\right)^{-1} J_{n}^{-1} \\
& =\left\{\mathbf{I}-J_{n}^{-1} S_{2, w, n} / n^{1 / 2}+o\left(n^{-1 / 2}\right)\right\} J_{n}^{-1}  \tag{45}\\
& =J_{n}^{-1}-J_{n}^{-1} S_{2, w, n} J_{n}^{-1} / n^{1 / 2}+o\left(n^{-1 / 2}\right) \\
& =J_{n}^{-1}\left(\mathbf{I}-S_{2, w, n} J_{n}^{-1} / n^{1 / 2}\right)+o\left(n^{-1 / 2}\right)
\end{align*}
$$

where the third equality comes from the Taylor expansion of $1 /(1+x)$ at $x=0$.
The first order approximation of $n^{1 / 2}(\tilde{\theta}-\hat{\theta})$ is thus given by

= & J_{n}^{-1}\left\{S_{1, w, n}+\frac{w_{0} \cdot \nabla_{\theta} \log \pi(\hat{\theta})}{n^{1 / 2}}-\frac{S_{2, w, n} J_{n}^{-1} S_{1, w, n}}{n^{1 / 2}}\right\} \\
& +J_{n}^{-1} \frac{\mu_{3}\left(J_{n}^{-1} S_{1, w, n}\right)^{2}}{2 n^{1 / 2}}+o\left(n^{-1 / 2}\right)
\end{aligned}
$$

where the last equality results from $J_{w, n}=J_{n}+S_{2, w, n} / n^{1 / 2}$ and $\mu_{3, w, n}=\mu_{3}+o_{P}(1)$. We finally get

+I_{n}^{-1 / 2} \frac{\mu_{3}\left(J_{n}^{-1} S_{1, w, n}\right)^{2}}{2 n^{1 / 2}}+o\left(n^{-1 / 2}\right)
\end{gather*}
$$

We will use the above result to obtain the Edgeworth expansion.

## Edgeworth expansion - multidimensional case

Proof. Our proof will rely mainly on results from Chapter 2 of Ghosh [1994]. Firstly, we apply Lemma 1 to

Z_{j}=w_{j}-1 \quad \text { and } \quad a_{j}=\left\{\frac{\partial \ell\left(x_{j}, \hat{\theta}\right)}{\partial \theta_{p}}, \frac{\partial^{2} \ell\left(x_{j}, \hat{\theta}\right)}{\partial \theta_{r} \partial \theta_{s}}\right\}, \quad 1 \leq p \leq d, 1 \leq r \leq s \leq d
$$

that is, $a_{j}$ is a vector of all first and second partial derivatives of $\ell\left(x_{j}, \hat{\theta}\right)$, to get that ( $S_{1, w, n}, S_{2, w, n}$ ) has a joint valid Edgeworth expansion. We justify below briefly why the conditions of Lemma 1 are satisfied. Observe that the assumptions about $Z_{j}$ hold by Assumption 5. Conditions b) and c), as well as convergence to $A_{2}$ and $A_{3}$ in condition a) of Lemma 1 , hold with probability 1 with respect to the observations $x_{1}, \ldots, x_{n}$ by Assumption 3, and the strong law of large numbers. We also have $A_{2} \succ 0$ as required in condition a) by Assumption 4.

Now let $X_{n}$ denote the right hand side of equation (47). Since conditioning on the observations $x_{1}, \ldots, x_{n}$ the variable $X_{n}$ is a polynomial of $\left(S_{1, w, n}, S_{2, w, n}\right)$, it also has a valid Edgeworth expansion, and we can apply the theory outlined in Chapter 2 of Ghosh [1994] to obtain the coefficients of this expansion.

By equation 2.7 of Ghosh [1994] the characteristic function of $X_{n}$ satisfies

\psi_{X_{n}}=\exp \left(-\frac{t^{T} t}{2}\right)\left\{1+\kappa_{1, n}(i t)+\frac{\kappa_{3, n}(i t)^{3}}{6}\right\}+o\left(n^{-1 / 2}\right) \tag{48}
\end{equation*}
$$

where $\kappa_{1, n}$ and $\kappa_{3, n}$ are the first and the third cumulant, respectively, calculated up to $o\left(n^{-1 / 2}\right)$.
We also define $Z_{n}:=\left(Z_{n, 1}, \ldots, Z_{n, d}\right)$ where

Z_{n, q}:=\frac{1}{n} \sum_{j=1}^{n} \nabla \ell\left(x_{j}, \hat{\theta}\right)^{T} J_{n}^{-1} \mu_{3, q} J_{n}^{-1} \nabla \ell\left(x_{j}, \hat{\theta}\right), \quad q=1, \ldots, d,
$$

and $\mu_{3, q} \in \mathbb{R}^{p \times p}$ is a matrix such that element $[r, s]$ of $\mu_{3, q}$ is equal to element $[q, r, s]$ of $\mu_{3}$. In an analogous way we define $Z=\left(Z_{1}, \ldots, Z_{d}\right)$, where

Z_{q}=E_{p^{*}}\left\{\nabla \ell\left(X, \theta^{*}\right)^{T} J\left(\theta^{*}\right)^{-1} \mu_{3, q} J\left(\theta^{*}\right)^{-1} \nabla \ell\left(X, \theta^{*}\right)\right\}, \quad q=1, \ldots, d .
$$

We observe that by Assumption $3 Z_{q}$ is finite for each $q=1, \ldots, d$. We obtain

E\left(X_{n}\right)=I_{n}^{-1 / 2}\left\{\frac{w_{0} \cdot \nabla_{\theta} \log \pi(\hat{\theta})}{n^{1 / 2}}+\frac{Z_{n}}{2 n^{1 / 2}}+\frac{\tilde{L}_{1,2, n}}{n^{1 / 2}}+o\left(n^{-1 / 2}\right)\right\}
$$

Therefore we can write

\kappa_{1, n}=I\left(\theta^{*}\right)^{-1 / 2}\left(\frac{w_{0} \cdot \nabla_{\theta} \log \pi\left(\theta^{*}\right)}{n^{1 / 2}}+\frac{Z}{2 n^{1 / 2}}+\frac{\tilde{L}_{1,2}}{n^{1 / 2}}\right) .
$$

Recall $E\left(X_{n}-E X_{n}\right)^{3}=\kappa_{3, n}+o\left(n^{-1 / 2}\right)$. Since the term $n^{-1 / 2}\left\{w_{0}^{T} \nabla_{\theta} \log \pi(\hat{\theta})\right\}$ cancels in the expression $X_{n}-E X_{n}$, we get that $\kappa_{3, n}$ does not depend on the prior. Finally, using formula (48), and equations (39), (40) and (41) we conclude with the general form of the Edgeworth expansion

where $P_{3, n}(y)$ is an order three polynomial independent from the prior. This completes the proof of equation (10).

## Edgeworth expansion - one-dimensional case

Proof. When $d=1$, we can obtain a more explicit form of the Edgeworth expansion. In particular, $\kappa_{1, n}$ becomes

$$

for $L_{1,2}$ defined in (9). We additionally define

L_{1,2, n}=\frac{1}{n} \sum_{j=1}^{n} D_{\theta}^{2} \ell\left(x_{j}, \theta^{*}\right) \nabla_{\theta} \ell\left(x_{j}, \theta^{*}\right)
$$

We then get

& -3 E\left\{\frac{S_{1, w, n}^{2}}{I_{n}}\left(\frac{L_{1,2, n}}{n^{1 / 2} I_{n}^{1 / 2} J_{n}}+\frac{S_{1, w, n} S_{2, w, n}}{n^{1 / 2} I_{n}^{1 / 2} J_{n}}\right)\right\}+o\left(n^{-1 / 2}\right) .

E\left(X_{n}-E X_{n}\right)^{3}=\frac{\gamma A_{3, n}}{n^{1 / 2} I_{n}^{3 / 2}} & +\left(\frac{9 \mu_{3}}{2 n^{1 / 2}} \frac{I_{n}^{2}}{I_{n}^{3 / 2} J_{n}^{2}}-\frac{3 \mu_{3}}{2 n^{1 / 2}} \frac{I_{n}^{2}}{I_{n}^{3 / 2} J_{n}^{2}}\right) \\
& -\left(\frac{3 I_{n} L_{1,2, n}}{n^{1 / 2} I_{n}^{3 / 2} J_{n}}-\frac{9 I_{n} L_{1,2, n}}{n^{1 / 2} I_{n}^{3 / 2} J_{n}}\right)+o\left(n^{-1 / 2}\right)
\end{aligned}

We get the following value of $\kappa_{3, n}$

and finally equations (38) and (37) yield the Edgeworth expansion of the density

Proof. Analogous steps that we took to obtain the Edgeworth expansion for Algorithm 1 will lead us to the result for Algorithm 3. When considering the Taylor expansion, instead of equation (47) we get

Notice that $n^{-1 / 2} \sum_{j=n+1}^{n+T} w_{j} \nabla_{\theta} \ell\left(x_{j}, \hat{\theta}\right)$ is independent from $\left(S_{1, w, n}, S_{2, w, n}\right)$ conditionally on the data, and has a valid Edgeworth expansion, therefore there exists a valid joint expansion of

for the prior predictive $f_{\pi}(x)$ defined in Section 4. By Assumption 7 we have

as $n \rightarrow \infty$, which leads to the following formula for $\tilde{\kappa}_{1, n}$

are independent, we get that the third cumulant does not depend on the prior. We therefore get $\tilde{\kappa}_{3, n}=$ $\kappa_{3, n}$ for $\kappa_{3, n}$ defined in the proof of Theorem 2. This completes the proof.

## B. 6 Edgeworth expansions for other methods based on Weighted Likelihood Bootstrap

Our results obtained in Theorem 2 and 4 can easily be extended to obtain Edgeworth expansions for other methods based on Weighted Likelihood Bootstrap, in particular Newton [1991] and Lyddon et al. [2018].

We start by discussing the method proposed by Newton et al. [2020] presented in Algorithm 4. The regularization parameter $\lambda$ plays a similar role to $w_{0}$ in Algorithm 1 if $w_{0} \in \mathbb{R}$, it is however multiplied by a random variable $\tilde{w}$ drawn from the exponential distribution. When the prior factorizes, Newton
et al. [2020] alternatively propose to assign a different random weight $\tilde{w}_{i} \sim \operatorname{Exp}(1)$ to each coordinate $i=1, \ldots, d$. The penalization term would then be given by

\sum_{i=1}^{d} \lambda \tilde{w}_{i} \log \pi_{i}\left(\theta_{i}\right)
$$

Note that since the regularization parameter stays fixed for all coordinates, this approach is of different nature to the way we proposed to set $w_{0}$ in Section 2.3. In our case the idea is to assign potentially different regularization parameters to different coordinates, accounting for situations when overdispersion or underdispersion is more severe for some coordinates than others.

Assuming that $\tilde{w}$ is a one-dimensional variable drawn from $\operatorname{Exp}(1)$, we will show that Algorithm 1 and Algorithm 4 have the same Edgeworth expansion as long as $w_{0}=\lambda$. To this end, we use very similar arguments to those used in the proof of Theorem 2. Firstly, note that the Taylor expansion of $I_{n}^{-1 / 2} J_{n} n^{1 / 2}(\tilde{\theta}-\hat{\theta})$ for $\tilde{\theta}$ drawn from Algorithm 4 is given by

I_{n}^{-1 / 2}\left(S_{1, w, n}+\frac{\lambda \tilde{w} \nabla_{\theta} \log \pi(\hat{\theta})}{n^{1 / 2}}-\frac{S_{2, w, n} J_{n}^{-1} S_{1, w, n}}{n^{1 / 2}}\right)+I_{n}^{-1 / 2} \frac{\mu_{3}\left(J_{n}^{-1} S_{1, w, n}\right)^{2}}{2 n^{1 / 2}}
$$

Repeating the arguments used in the proofs and Theorems 2 and 4 we conclude that

has a valid Edgeworth expansion. Since $E \lambda \tilde{w}=\lambda$, then the corresponding cumulants $\kappa_{1, n}$ and $\kappa_{3, n}$ are the same as in the proof of Theorem 2 for $\lambda=w_{0}$.

As for the method proposed by Lyddon et al. [2018], which we present in Algorithm 5, its second order Edgeworth expansion was discussed in Section 4. To make the statement more precise, let $\tilde{\theta}$ be drawn from Algorithm 5, and $\theta$ be drawn from standard Weighted Likelihood Bootstrap [Newton and Raftery, 1994]. Then up to the term of order $o\left(n^{-1 / 2}\right)$ the Edgeworth expansion of $I_{n}^{-1 / 2} J_{n} n^{1 / 2}(\tilde{\theta}-\hat{\theta})$ is the same as the Edgeworth expansion $I_{n}^{-1 / 2} J_{n} n^{1 / 2}(\theta-\hat{\theta})$, for any choice of fixed parameters $c$ and $T$.

To prove the above statement, we follow the steps from the proof of Theorem 4 in Supplementary Material B.5. However, instead of the calculation in (50), in case of Algorithm 5 we have

& =c \int \nabla_{\theta}\{\log f(x \mid \bar{\theta})\}\left\{\int f(x \mid \theta) \pi\left(\theta \mid x_{1: n}\right) \mathrm{d} \theta\right\} \mathrm{d} x=o_{P}(1)
\end{aligned}
$$

The last equality follows from the fact that the posterior concentrates around the maximum likelihood estimator as $n \rightarrow \infty$.

## C Proofs of theoretical results presented in Section 3

## C. 1 Proof of Proposition 3

Proof. Fix $\epsilon>0$. Recall that we denote by $P^{H B, p}\left(\cdot \mid x_{1: K, 1: n_{k}}\right)$ the distribution of samples drawn from Algorithm 2. Let $p^{H B, p}\left(\cdot \mid x_{1: K, 1: n_{k}}\right)$ denote its corresponding density. Let $\tilde{\theta}=\left(\tilde{\theta}_{1}, \ldots, \tilde{\theta}_{K}\right)$ and $\theta^{*}=$ $\left(\theta_{1}^{*}, \ldots, \theta_{K}^{*}\right)$, and let $p(\lambda \mid \tilde{\theta})$ be the Bayesian posterior of $\lambda$ given $\tilde{\theta}$ in model 21. We have

\begin{align*}
p^{H B, p}\left(\tilde{\lambda} \mid x_{1: K, 1: n_{k}}\right) & =\int p(\tilde{\lambda} \mid \tilde{\theta}) p^{H B, p}\left(\tilde{\theta} \mid x_{1: K, 1: n_{k}}\right) \mathrm{d} \tilde{\theta} \\
& =\int_{A_{\varepsilon}} p(\tilde{\lambda} \mid \tilde{\theta}) p^{H B, p}\left(\tilde{\theta} \mid x_{1: K, 1: n_{k}}\right) \mathrm{d} \tilde{\theta}+\int_{A_{\varepsilon}^{c}} p(\tilde{\lambda} \mid \tilde{\theta}) p^{H B, p}\left(\tilde{\theta} \mid x_{1: K, 1: n_{k}}\right) \mathrm{d} \tilde{\theta} \tag{51}
\end{align*}
$$

where $A_{\epsilon}=\left\{\tilde{\theta}:\left\|\tilde{\theta}-\theta^{*}\right\| \leq \epsilon\right\}$. Since $\tilde{\theta}$ under $P^{H B, p}$ converges weakly to $\delta_{\theta^{*}}$, then by the continuity assumption for any $\lambda$ the first integral in (51) converges to $p\left(\tilde{\lambda} \mid \theta^{*}\right)$. Since $\sup _{\lambda \in \Lambda, \theta \in \Theta} p(\lambda \mid \theta)<\infty$, the second integral converges to 0 . Finally we get that $p^{H B, p}(\tilde{\lambda} \mid \tilde{\theta}) \rightarrow p\left(\tilde{\lambda} \mid \theta^{*}\right)$ as $n \rightarrow \infty$. By similar arguments the Bayesian posterior $p\left(\lambda \mid x_{1: K, 1: n_{k}}\right)$ has the same limiting distribution.

## C. 2 Additional information for Section 3.2 and proof of Theorem 3

Recall that in Section 3.2 we considered the following hierarchical model

There is an open ball $B$ containing $\lambda_{\theta^{*}}^{*}$ such that $\ell_{g}(\theta, \lambda)$ is three times continuously differentiable with respect to $\lambda \in B$ for almost all $\theta \in \Theta$. Furthermore, there exist measurable functions $G_{1}, G_{2}$ and $G_{3}$ such that for $\lambda \in B$

\end{aligned}

Assumption 13. (Smoothness of $\ell_{g}$ with respect to $\theta$ ). For any $\lambda \in \Lambda$, the function $\ell_{g}(\theta, \lambda)$ is measurable as a function of $\theta$, and three times continuously differentiable with respect to $\theta$. Besides, $\ell_{g}(\theta, \lambda)$ is jointly bounded as a function of $\lambda \in \Lambda, \theta \in \Theta$. Furthermore, there exist $L_{1}, L_{2}, L_{3}>0$ such that for any $\lambda \in \Lambda$ and any $\theta_{1}, \theta_{2} \in \Theta$

Assumption 14. (Smoothness of $\ell$ ). The function $\ell(x, \theta)$ is three times continuously differentiable with respect to $\theta \in \Theta$ almost surely on $x$. We assume that there exist measurable functions $H_{1}, H_{2}$ and $H_{3}$ such that for $\theta \in \Theta$

\left|\frac{\partial^{3} \ell(x, \theta)}{\partial \theta_{j} \partial \theta_{l} \partial \theta_{m}}\right| & \leq H_{3}(x) \quad E_{Q^{*}}\left[\max _{1 \leq k \leq K_{n}} E_{p_{k^{*}}}\left\{H_{3}(X)\right\}\right]<\infty
\end{aligned}
$$

Assumption 15. (Positive definiteness of information matrices for $\lambda$ ). The matrices $I_{g}(\lambda)$ and $J_{g}(\lambda)$ defined in (27) are positive definite for $\lambda \in B$ with all elements finite.
Assumption 16. (Positive definiteness of information matrices for $\theta$ and linear independence of partial derivatives). The matrices $I(\theta)$ and $J(\theta)$ defined in (4) are positive definite for $\theta \in \Theta$ with all elements finite. Furthermore, $\operatorname{det} J(\theta)$ and $\operatorname{det} I(\theta)$ are bounded away from 0 on any compact subset of $\Theta$. Besides, the first and second partial derivatives

are linearly independent as functions of $x$ at any $\theta \in \Theta$.

Assumption 17. (Smoothness of $\log$ prior density). The function $\log p(\lambda)$ is measurable, upper-bounded on $\lambda$, and three times continuously differentiable at $\lambda^{*}$.

The strategy of the proof is as follows. We first prove consistency of $\tilde{\lambda}$, and then its asymptotic normality. The key element in establishing consistency of $\tilde{\lambda}$ is obtaining the upper bound on the rate of convergence of $\tilde{\theta}_{k}$ to $\theta_{k}^{*}$. We obtain this upper bound in Lemma 2, which relies largely on the multivariate Berry-Esseen theorem with explicit constants, proved by Raič [2019].

Lemma 2. Let $\epsilon_{n}$ be a deterministic sequence depending on $n$ such that $\epsilon_{n}=o(1)$ and

where the supremum in the above equation is taken over all measurable convex sets $A$. Let $Z$ follow the
standard $d$-variate normal distribution and note that by (52) we have

= & \sup _{A \subseteq \Theta} \left\lvert\, P^{H B, p p}\left\{\left.I_{n}^{-1 / 2} \frac{\sum_{j=1}^{n}\left(w_{j}-1\right) \nabla_{\theta} \ell\left(x_{i}, \hat{\theta}\right)+w_{0} \cdot \nabla_{\theta} \log g(\hat{\theta} \mid \bar{\lambda})}{n^{1 / 2}} \in A \right\rvert\, x\right\}\right. \\
& \left.\quad-\operatorname{pr}\left\{Z+I_{n}^{-1 / 2} \frac{w_{0} \cdot \nabla_{\theta} \log g(\hat{\theta} \mid \bar{\lambda})}{n^{1 / 2}} \in A\right\} \right\rvert\, \\
= & \sup _{A \subseteq \Theta}\left|P^{H B, p p}\left\{\left.I_{n}^{-1 / 2} \frac{\sum_{j=1}^{n}\left(w_{j}-1\right) \nabla_{\theta} \ell\left(x_{i}, \hat{\theta}\right)}{n^{1 / 2}} \in A \right\rvert\, x\right\}-\operatorname{pr}(Z \in A)\right|
\end{aligned}
$$

To obtain the upper bound on the last expression above, we now apply Theorem 1.1 of Raič [2019] to the expression

= & \frac{2 c_{0}}{n^{1 / 2}} \frac{1}{n} \sum_{j=1}^{n}\left\|I_{n}^{-1 / 2} \nabla_{\theta} \ell\left(x_{i}, \hat{\theta}\right)\right\|^{3} .
\end{aligned}

Note that by Assumption 14 we have

where $\tilde{J}_{n}(\check{\theta})=n^{-1} D_{\theta}^{2} L_{n}(\check{\theta})$. For $Z_{n}$ following the normal distribution $N\left\{0, \tilde{J}_{n}(\check{\theta})^{-1} I\left(\theta^{*}\right) \tilde{J}_{n}(\check{\theta})^{-1}\right\}$ we have

& +2 \operatorname{pr}\left(\left\|Z_{n}\right\|>\epsilon_{n} n^{1 / 2} / 2\right) .
\end{aligned}
$$

Let $Z^{\prime}$ follow the $d$-variate standard normal distribution. Then for measurable convex sets $A \subseteq \Theta$ we have

= & \sup _{A \subseteq \Theta}\left|\operatorname{pr}\left\{I\left(\theta^{*}\right)^{-1 / 2} \tilde{J}_{n}(\check{\theta}) n^{1 / 2}\left(\hat{\theta}-\theta^{*}\right) \in A\right\}-\operatorname{pr}\left(I\left(\theta^{*}\right)^{-1 / 2} \tilde{J}_{n}(\check{\theta}) Z_{n} \in A\right)\right| \\
= & \sup _{A \subseteq \Theta}\left|\operatorname{pr}\left\{I\left(\theta^{*}\right)^{-1 / 2} n^{-1 / 2} \sum_{j=1}^{n} \nabla_{\theta} \ell\left(x_{i}, \theta^{*}\right) \in A\right\}-\operatorname{pr}\left(Z^{\prime} \in A\right)\right| \\
\leq & \frac{2 c_{0}}{n^{1 / 2}} \frac{1}{n} \sum_{j=1}^{n} E_{p_{k}^{*}}\left\{\left\|I\left(\theta^{*}\right)^{-1 / 2} \nabla_{\theta} \ell\left(x_{i}, \theta^{*}\right)\right\|^{3}\right\} \\
\leq & \frac{2 c_{0}}{n^{1 / 2}} E_{p_{k}^{*}}\left\{\left\|I\left(\theta^{*}\right)^{-1 / 2} \nabla_{\theta} \ell\left(X, \theta^{*}\right)\right\|^{3}\right\},
\end{aligned}
$$

where the second last equality is again obtained by applying Theorem 1.1 of Raič [2019]. We observe that $E_{p_{k}^{*}}\left\{\left\|I\left(\theta^{*}\right)^{-1 / 2} \nabla_{\theta} \ell\left(X, \theta^{*}\right)\right\|^{3}\right\}$ is bounded by a constant independent from $\theta^{*}$ by Assumption 14. To bound $\operatorname{pr}\left(\left\|Z_{n}\right\|>\epsilon_{n} n^{1 / 2} / 2\right)$ by $o\left(n^{-1 / 2}\right)$, we again use property (54) of the tail of the normal distribution, and equation (56).

Finally, since the constants appearing in the proof do not depend on $k$, we get that

&=\frac{1}{K_{n}} \sum_{k=1}^{K_{n}} v_{k}\left\{\ell_{g}\left(\theta_{k}^{*}, \tilde{\lambda}\right)-\ell_{g}\left(\tilde{\theta}_{k}, \tilde{\lambda}\right)\right\}+\frac{1}{K_{n}} \sum_{k=1}^{K_{n}} v_{k}\left\{\ell_{g}\left(\tilde{\theta}_{k}, \tilde{\lambda}\right)-\ell_{g}\left(\tilde{\theta}_{k}, \lambda^{*}\right)\right\}  \tag{57}\\
& \quad+\frac{1}{K_{n}} \sum_{k=1}^{K_{n}} v_{k}\left\{\ell_{g}\left(\tilde{\theta}_{k}, \lambda^{*}\right)-\ell_{g}\left(\theta_{k}^{*}, \lambda^{*}\right)\right\} \tag{58}
\end{align*}
$$

By Assumption 13 on $\Omega_{n}$ we have

$$
\frac{1}{K_{n}} \sum_{k=1}^{K_{n}}\left\{\ell_{g}\left(\theta_{k}^{*}, \tilde{\lambda}\right)-\ell_{g}\left(\tilde{\theta}_{k}, \tilde{\lambda}\right)\right\}>-\epsilon / 3, \quad \frac{1}{K_{n}} \sum_{k=1}^{K_{n}}\left\{\ell_{g}\left(\tilde{\theta}_{k}, \lambda^{*}\right)-\ell_{g}\left(\theta_{k}^{*}, \lambda^{*}\right)\right\}>-\epsilon / 3
$$

Thus by Theorem 13 of Appendix A of Newton [1991] the first and the last expression in equations (57) - (58) are greater than $-\epsilon / 3$ with probability going to 1 . As for the second expression, by definition of $\tilde{\lambda}$

Thus, by Assumption 17 for large enough $K_{n}$ we have

\frac{1}{K_{n}} \sum_{k=1}^{K_{n}} v_{k}\left\{\ell_{g}\left(\tilde{\theta}_{k}, \tilde{\lambda}\right)-\ell_{g}\left(\tilde{\theta}_{k}, \lambda^{*}\right)\right\} \geq-\epsilon / 3
$$

To summarize, the above reasoning and Assumption 10 yield $\left\|\tilde{\lambda}-\lambda^{*}\right\|<\delta$ with probability going to 1 , which completes the proof of consistency. Additionally, by Assumption 10 we also have $\left\|\lambda^{*}-\hat{\lambda}_{\theta^{*}}\right\|=o_{P}(1)$, so in particular $\left\|\tilde{\lambda}-\hat{\lambda}_{\theta^{*}}\right\|=o_{P}(1)$. This property is useful in the proof of asymptotic normality, which we present below.

We define $L_{K_{n}}(\lambda)=\sum_{k=1}^{K_{n}} v_{k} \ell_{g}\left(\tilde{\theta}_{k}, \lambda\right)+w_{g}^{T} \log p(\lambda)$. We can write $L_{K_{n}}(\lambda)$ as

L_{K_{n}}(\lambda)=\sum_{k=1}^{K_{n}} v_{k} \ell_{g}\left(\theta_{k}^{*}, \lambda\right)+w_{g}^{T} \log p(\lambda)+h_{K_{n}}(\lambda)

where

h_{K_{n}}(\lambda)=\sum_{k=1}^{K_{n}} v_{k}\left\{\ell_{g}\left(\tilde{\theta}_{k}, \lambda\right)-\ell_{g}\left(\theta_{k}^{*}, \lambda\right)\right\} .
$$

We get the following expansion

0=\nabla_{\lambda} L_{K_{n}}(\tilde{\lambda})=\nabla_{\lambda} L_{K_{n}}\left(\hat{\lambda}_{\theta^{*}}\right)+D_{\lambda}^{2} L_{K_{n}}(\check{\lambda})\left(\tilde{\lambda}-\hat{\lambda}_{\theta^{*}}\right)
$$

for some $\check{\lambda}$ between $\tilde{\lambda}$ and $\hat{\lambda}_{\theta^{*}}$, which gives

Since $\sum_{k=1}^{K_{n}} \nabla_{\lambda} \ell_{g}\left(\theta_{k}^{*}, \hat{\lambda}_{\theta^{*}}\right)=0$, we have

\frac{\nabla_{\lambda} L_{K_{n}}\left(\hat{\lambda}_{\theta^{*}}\right)}{K_{n}^{1 / 2}}=\frac{1}{K_{n}^{1 / 2}} \sum_{k=1}^{K_{n}}\left(v_{k}-1\right) \nabla_{\lambda} \ell_{g}\left(\theta_{k}^{*}, \hat{\lambda}_{\theta^{*}}\right)+\frac{1}{K_{n}^{1 / 2}}\left\{w_{g} \cdot \nabla_{\lambda} \log p\left(\hat{\lambda}_{\theta^{*}}\right)+\nabla_{\lambda} h_{K_{n}}\left(\hat{\lambda}_{\theta^{*}}\right)\right\}
$$

What is more,

$$
\begin{equation*}
-\frac{D_{\lambda}^{2} L_{K_{n}}(\check{\lambda})}{K_{n}}=-\frac{1}{K_{n}} \sum_{k=1}^{K_{n}} v_{k} D_{\lambda}^{2} \ell_{g}\left(\theta_{k}^{*}, \check{\lambda}\right)-\frac{1}{K_{n}}\left[D_{\lambda}^{2}\left\{w_{g}^{T} \log p(\check{\lambda})\right\}+D_{\lambda}^{2} h_{K_{n}}(\check{\lambda})\right] \tag{60}
\end{equation*}
$$

By Assumptions 13 and 17 we have on $\Omega_{n}$

$$
\begin{equation*}
\frac{1}{K_{n}^{1 / 2}}\left\{w_{g}^{T} \nabla_{\lambda} \log p\left(\hat{\lambda}_{\theta^{*}}\right)+\nabla_{\lambda} h_{K_{n}}\left(\hat{\lambda}_{\theta^{*}}\right)\right\}=O_{P}\left(K_{n}^{-1 / 2}\right)+O_{P}\left(K_{n}^{1 / 2} \epsilon_{n}\right)=o_{P}(1) \tag{61}
\end{equation*}
$$

where the last equality holds since we assumed that $K_{n} \epsilon_{n}=o(1)$, and the probability is considered with respect to $v_{1: K_{n}}$. We similarly have in (60)

By consistency of $\tilde{\lambda}$ and Theorem 13 of Appendix A of Newton [1991] we get that

converges to $J_{g}\left(\lambda^{*}\right)$ in probability. Therefore by $(62)-K_{n}^{-1} D_{\lambda}^{2} L_{K_{n}}(\check{\lambda})$ also converges to $J_{g}\left(\lambda^{*}\right)$ in probability. Finally we use the central limit theorem, equation (61) and Slutsky's theorem to show that (59) converges in distribution to $N\left\{0, J_{g}\left(\lambda^{*}\right)^{-1} I_{g}\left(\lambda^{*}\right) J_{g}\left(\lambda^{*}\right)^{-1}\right\}$ as required.

## D Illustrations - further details

## D. 1 Additional information for Section 5.1

Throughout the paper the Kolmogorov-Smirnov dissimilarity is computed using the KS.diss function from the provenance package [Vermeesch et al., 2016] in R, while the Bhattacharyya distance is computed using the bhattacharyya.dist function from the fpc package [Hennig and Imports, 2015]. All our computations for the BayesBag algorithm are based on 50 bootstrapped datasets.

In Figures $5-7$ we present additional results for model (31). Figure 5 confirms, using another measure of distance, our conclusion drawn from Figure 1 that it is optimal to set $w_{0}=\sigma^{2}$, which coincides with formula (19). In Figures 6 and 7 we present also comparisons with BayesBag. For each experiment the size of the bootstrapped datasets was set according to the guidelines for the Gaussian location model provided in Section 2.2.1 of Huggins and Miller [2019]. According to results presented in Figure 6, both Posterior Bootstrap and BayesBag capture well the uncertainty around the parameter, and under misspecification perform better than standard Bayesian inference. Figure 7 shows that our method outperforms BayesBag, which in turn performs better than Weighted Likelihood Bootstrap. We do not make comparisons with power posteriors, as we did for model (33). The reason for this is that in this example using power posteriors with parameter $\eta$ set to $\eta^{*}$ proposed by Lyddon et al. [2019] is equivalent with drawing samples from the Bayesian posterior for the correct model.

## D. 2 Toy example of a hierarchical model

We consider the following hierarchical model with parameters $\lambda, \theta_{1}, \theta_{2}, \theta_{3}$ :

x_{k, 1}, \ldots, x_{k, n_{k}} & \sim \operatorname{Poisson}\left(\theta_{k}\right), & & k=1,2,3, \\
\theta_{1}, \ldots, \theta_{3} & \sim \operatorname{Gamma}(\alpha, \lambda), & k=1,2,3  \tag{63}\\
\lambda & \sim \operatorname{Gamma}\left(\alpha_{0}, \beta_{0}\right) . & &
\end{array}
$$

We consider two scenarios. In the first one data $x_{k, 1}, \ldots, x_{k, n_{k}}$ is generated from the Poisson $\left(\theta_{k}\right)$ distribution with $\theta_{1}=1, \theta_{2}=2$ and $\theta_{3}=4$, so we have a well-specified model. In the second scenario the correct model is

$$
\begin{array}{rlrl}
x_{k, 1}, \ldots, x_{k, n_{k}} & \sim \operatorname{NB}\left(\theta_{k}, 0.7\right), & & k=1,2,3 \\
\theta_{1}, \ldots, \theta_{3} & \sim \operatorname{Gamma}(\alpha, \lambda), & k=1,2,3  \tag{64}\\
\lambda & \sim \operatorname{Gamma}\left(\alpha_{0}, \beta_{0}\right) . & &
\end{array}
$$

where $\operatorname{NB}\left(\theta_{k}, \omega\right)$ denotes the negative binomial distribution with mean $\theta_{k}$ and size $\omega$. Recall that variance of the $\mathrm{NB}(\theta, \omega)$ distribution is $\theta+\theta^{2} / \omega$, so the negative binomial is often used for modelling overdispersed Poisson data. In the second scenario we generate $x_{k, 1}, \ldots, x_{k, n_{k}}$ from $\operatorname{NB}\left(\theta_{k}, 0.7\right)$, for $\theta_{1}=1, \theta_{2}=2$ and $\theta_{3}=4$. In both scenarios we set $\alpha_{0}=9, \beta_{0}=3$ and $\alpha=2$, and the number of data points in each class is $n_{1}=n_{2}=n_{3}=100$. In this misspecified scenario we compare results obtained with different versions of Posterior Bootstrap performed on model (63) with the Bayesian posterior for model (64).


Figure 8: Bhattacharryya distance between samples from the Bayesian posterior for the correct model and samples obtained using Algorithm 2 for a range of values of $w_{0}$. We set the same value of $w_{0}$ for each class, that is, we use $w_{0,[1]}=w_{0,[2]}=w_{0,[3]}=w_{0}$, for $w_{0}$ displayed on the $x$-axis of the plot. We consider two scenarios: well-specified (top panel), where (63) is the correct model, and misspecified (bottom panel), for which (64) is the correct model. In case of the misspecified model we also include the results for Algorithm 2 with $w_{0}^{*}=\left(w_{0,[1]}^{*}, w_{0,[2]}^{*}, w_{0,[3]}^{*}\right)$. Each experiment was repeated on 100 simulated datasets for $N=2000$.

We tested Algorithm 2 on this example for a range of values of $w_{0}$ and the results of these experiments are presented in Figure 8. As expected, in the well-specified case it is optimal to set $w_{0}$ to 1 for each class, whereas in the overdispersed Poisson case setting $w_{0}$ according to (19) for each class yields results that are closest to the posterior under the correct model.

For a fixed value of $\lambda$ model (63) is conjugate with the effective sample size of the prior equal to $\lambda$. This motivates testing Posterior Bootstrap with pseudo-samples within Algorithm 2, as mentioned in Remark 2. We expect to obtain best results setting parameter $c$ according to (30) as

c=\left(c_{1}, c_{2}, c_{3}\right)=\bar{\lambda}\left(w_{0,[1]}^{*}, w_{0,[2]}^{*}, w_{0,[3]}^{*}\right), \tag{65}

which is confirmed by the results of our experiments shown in Figure 9. The pseudo-samples approach appears to have a slight advantage over the penalization-based approach on this example, as shown in Figure 10. In particular, both methods perform well when it comes to inference on $\lambda$, as shown in Figure 11. Both Posterior Bootstrap approaches give significantly better results than standard Bayesian inference in the misspecified case, as shown in the right panel of Figure 10.

## D. 3 Additional information on the Dirichlet allocation model

We used Algorithm 7 to obtain results described in Section 5.3. By $g(\theta \mid \lambda)$ we denote here the density of the Dirichlet distribution with parameter $\lambda$. We let $f\left(x_{k, i} \mid \theta\right)$ denote the probability mass function of a Multinomial $(\theta, 1)$ distribution, where $x_{k, i}=p$ for $p \in\{1, \ldots, 6\}$ denotes that the reason of death for person $i$ in group $k$ was overdosing drug of type $p$, for $k=1, \ldots, K$ and $i=1, \ldots, n_{k}$.

We additionally tested Algorithm 7 on a synthetic dataset generated from model (36)with $\lambda=$ $(12,12,12,10,10,10), K=300$ and $n_{k}=1000$ for $k=1, \ldots, K$. Figure 12 shows that Bayesian inference and Algorithm 7 return very similar results, which suggests the difference between the two methods in Figure 4 is caused by model misspecification. In the same figure we plotted kernel density estimates of $\bar{\lambda}$. We notice that despite the fact that asymptotically $\bar{\lambda}$ and $\tilde{\lambda}$ have the same distributions, for this example $\tilde{\lambda}$ performs much better. We also observe that, as expected, using more concentrated priors causes a shift towards 0 in posterior distributions.
