Kolmogorov widths of a finite-dimensional balls intersection

Introduction 1

When studying the problem of estimating the widths of Sobolev weight classes with restrictions on derivatives in various L_p -metrics [1], the question arose about the widths of intersections of two finite-dimensional balls. Their order estimates were obtained in [2]. Here we generalize this result to the intersection of an arbitrary family of balls.

Let X be a normed space, $M \subset X$, $n \in \mathbb{Z}_+$. We denote by $\mathcal{L}_n(X)$ the family of subspaces in X of dimension at most n. The Kolmogorov n-width of the set M in the space X is defined as follows:

$$d_n(M, X) = \inf_{L \in \mathcal{L}_n(X)} \sup_{x \in M} \inf_{y \in L} ||x - y||.$$

Given $N \in \mathbb{N}$, $1 \leqslant p \leqslant \infty$, we denote by l_p^N the space \mathbb{R}^N with the norm

$$\|(x_1, \ldots, x_N)\|_p = \begin{cases} \left(\sum_{i=1}^N |x_i|^p\right)^{1/p}, & \text{if } 1 \leq p < \infty, \\ \max_{1 \leq i \leq N} |x_i|, & \text{if } p = \infty. \end{cases}$$

by a logarithmic multiplier. For details, see [12].

By B_p^N we denote the unit ball in the space l_p^N . Let A be a non-empty set, $1 \leq p_\alpha \leq \infty$, $\nu_\alpha > 0$ for every $\alpha \in A$ and $p_\alpha \neq p_\beta$ for $\alpha \neq \beta$, and let

$$M = \bigcap_{\alpha \in A} \nu_{\alpha} B_{p_{\alpha}}^{N}. \tag{1}$$

In this paper we obtain order estimates of the widths $d_n(M, l_q^N)$ for $n \leq N/2$. The explicit values of $d_n(B_p^N, l_q^N)$ were obtained by Pietsch and Stesin [3,4] for $p \geqslant q$, and by Kolmogorov, Petrov, Smirnov [5] and Stechkin [6] for p = 1, q = 2. For $p < q < \infty$, Gluskin [9, 10] obtained order estimates of $d_n(B_p^N, l_q^N)$. The case $q=\infty$ was investigated by Kashin [7,8], Gluskin and Garnaev [11]; for $p \ge 2$, order estimates were obtained, and for $1 \leq p < 2$, the upper and the lower estimates differ Galeev [13] obtained order estimates for $d_n(M, l_q^{2n})$, where M is defined by (1), $A \subset \mathbb{R}$, $\nu_{\alpha} = (2n)^{-\alpha}$. This result was applied for estimating the widths of intersections of some function classes [13, 14].

Given $\alpha, \beta \in A$, we set

$$\varkappa_{\alpha,\beta} = \begin{cases} \left(\frac{\nu_{\beta}}{\nu_{\alpha}}\right)^{\frac{p_{\alpha}p_{\beta}}{p_{\alpha}-p_{\beta}}}, & \text{if } \alpha \neq \beta, \\ 1, & \text{if } \alpha = \beta. \end{cases}$$
 (2)

Then

$$\nu_{\alpha} \varkappa_{\alpha,\beta}^{-1/p_{\alpha}} = \nu_{\beta} \varkappa_{\alpha,\beta}^{-1/p_{\beta}}.$$
 (3)

Notice that $\varkappa_{\alpha,\beta} = \varkappa_{\beta,\alpha}$. Suppose that

$$1 \leqslant \varkappa_{\alpha,\beta} \leqslant N, \quad \alpha, \beta \in A$$
 (4)

(in §3 it will be shown how to reduce the general case to this case). Then $\{\nu_{\alpha} : \alpha \in A\}$ is bounded and separated from zero.

Now we formulate the main result of this paper. First we give notation for order equalities and inequalities.

Let X, Y be sets, and let $f_1, f_2 : X \times Y \to \mathbb{R}_+$. We write $f_1(x, y) \lesssim f_2(x, y)$ (or $f_2(x, y) \gtrsim f_1(x, y)$) if for any $y \in Y$ there exists c(y) > 0 such that $f_1(x, y) \leqslant c(y)f_2(x, y)$ for every $x \in X$; $f_1(x, y) \underset{y}{\approx} f_2(x, y)$ if $f_1(x, y) \lesssim f_2(x, y)$ and $f_2(x, y) \lesssim f_1(x, y)$.

We denote

$$K = \{(\nu_{\alpha}, 1/p_{\alpha})\}_{\alpha \in A}. \tag{5}$$

Theorem 1. Let $n, N \in \mathbb{N}$, $n \leq N/2$, and let M be defined by (1). Suppose that (4) holds.

1. Let $p_{\alpha} \geqslant q$ for every $\alpha \in A$. Then

$$d_n(M, l_q^N) \asymp \inf_{\alpha \in A} \nu_\alpha N^{1/q - 1/p_\alpha}. \tag{6}$$

2. Let $q \leq 2$, $p_{\alpha} \leq q$ for any $\alpha \in A$. Then

$$d_n(M, l_q^N) \asymp \inf_{\alpha \in A} \nu_{\alpha}. \tag{7}$$

3. Let $q \leq 2$, $A_1 = \{\alpha \in A : p_{\alpha} > q\} \neq \emptyset$, $A_2 = \{\alpha \in A : p_{\alpha} < q\} \neq \emptyset$, $A'_1 = \{\alpha \in A : p_{\alpha} \geqslant q\}$, $A'_2 = \{\alpha \in A : p_{\alpha} \leqslant q\}$. Then

$$d_n(M, l_q^N) \asymp \inf\{\nu_\alpha \varkappa_{\alpha, \beta}^{1/q - 1/p_\alpha} : \alpha \in A_1', \beta \in A_2'\}.$$
 (8)

4. Let $2 < q < \infty$, and let $p_{\alpha} \leq 2$ for every $\alpha \in A$. Then

$$d_n(M, l_q^N) \approx \inf_{q} \nu_\alpha \min\{1, n^{-1/2} N^{1/q}\}.$$
 (9)

5. Let $2 < q < \infty$, $A'_1 = \{\alpha \in A : p_\alpha \geqslant q\}$, $A'_2 = \{\alpha \in A : 2 \leqslant p_\alpha \leqslant q\}$, $A'_3 = \{\alpha \in A : p_\alpha \leqslant 2\}$. Suppose that $A \not\subset A'_1$, $A \not\subset A'_3$. Let K be defined by (5). Then

$$d_n(M, l_q^N) \underset{q}{\asymp} \Phi(n, N, q, K) :=$$

$$= \min\{\Phi_1(n, N, q, K), \Phi_2(n, N, q, K), \Phi_3(n, N, q, K)\},$$
(10)

where

$$\Phi_1(n, N, q, K) = \inf\{\nu_{\alpha} \varkappa_{\alpha, \beta}^{1/q - 1/p_{\alpha}} : \alpha \in A_1', \beta \in A_2' \cup A_3'\},$$
 (11)

$$\Phi_2(n, N, q, K) = \inf \left\{ \nu_\alpha(\min\{1, n^{-1/2} N^{1/q}\})^{\frac{1/p_\alpha - 1/q}{1/2 - 1/q}}, \alpha \in A_2' \right\},$$
 (12)

$$\Phi_3(n, N, q, K) = \min\{\nu_{\alpha} \varkappa_{\alpha, \beta}^{1/2 - 1/p_{\alpha}} \min\{1, n^{-1/2} N^{1/q}\}: \alpha \in A_1' \cup A_2', \beta \in A_3'\}$$
(13)

(the infimum of the empty set is $+\infty$).

Remark 1. If $p_{\alpha} = q$, we have

$$\nu_{\alpha}\varkappa_{\alpha,\beta}^{1/q-1/p_{\alpha}} = \nu_{\alpha} = \nu_{\alpha}(\min\{1, n^{-1/2}N^{1/q}\})^{\frac{1/p_{\alpha}-1/q}{1/2-1/q}};$$

if $p_{\beta} = q$, then

$$\nu_{\alpha} \varkappa_{\alpha,\beta}^{1/q-1/p_{\alpha}} \stackrel{\text{(3)}}{=} \nu_{\beta} \varkappa_{\alpha,\beta}^{1/q-1/p_{\beta}} = \nu_{\beta} = \nu_{\beta} \left(\min\{1, \, n^{-1/2} N^{1/q}\} \right)^{\frac{1/p_{\beta}-1/q}{1/2-1/q}}.$$

If $p_{\alpha} = 2$, we have

$$\nu_{\alpha}(\min\{1, n^{-1/2}N^{1/q}\})^{\frac{1/p_{\alpha}-1/q}{1/2-1/q}} =$$

$$= \nu_{\alpha}\min\{1, n^{-1/2}N^{1/q}\} = \nu_{\alpha}\varkappa_{\alpha,\beta}^{1/2-1/p_{\alpha}}\min\{1, n^{-1/2}N^{1/q}\};$$

if $p_{\beta} = 2$, then

$$\nu_{\alpha} \varkappa_{\alpha,\beta}^{1/2 - 1/p_{\alpha}} \min\{1, n^{-1/2} N^{1/q}\} \stackrel{(3)}{=} \nu_{\beta} \varkappa_{\alpha,\beta}^{1/2 - 1/p_{\beta}} \min\{1, n^{-1/2} N^{1/q}\} =$$

$$= \nu_{\beta} \min\{1, n^{-1/2} N^{1/q}\} = \nu_{\beta} (\min\{1, n^{-1/2} N^{1/q}\})^{\frac{1/p_{\beta} - 1/q}{1/2 - 1/q}}.$$

Theorem 2. Let $n, N \in \mathbb{N}$, $n \leq N-1$, let M be defined by (1), $p_{\alpha} \geq 2$ for every $\alpha \in A$. Suppose that (4) holds. Then

$$d_n(M, l_\infty^N) \asymp \inf \left\{ \nu_\alpha \min \left(1, \, n^{-1} \log \frac{2N}{n} \right)^{1/p_\alpha} : \, \alpha \in A \right\}.$$
 (14)

Proof of the main results 2

First we formulate some well-known results.

Theorem A. [10] Let $1 \leq p \leq q < \infty$, $0 \leq n \leq N/2$.

1. Let
$$1 \leqslant q \leqslant 2$$
. Then $d_n(B_p^N, l_q^N) \underset{p,q}{\asymp} 1$.

2. Let
$$2 < q < \infty$$
, $\lambda_{pq} = \min \left\{ 1, \frac{1/p - 1/q}{1/2 - 1/q} \right\}$. Then

$$d_n(B_p^N, l_q^N) \underset{p,q}{\approx} \min\{1, n^{-1/2}N^{1/q}\}^{\lambda_{pq}}.$$

Theorem B. [3,4] Let $1 \leq q \leq p \leq \infty$, $0 \leq n \leq N$. Then

$$d_n(B_p^N, l_q^N) = (N - n)^{1/q - 1/p}. (15)$$

Theorem C. [11] Let $p \ge 2$, $n \le N-1$. Then

$$d_n(B_p^N, l_\infty^N) \simeq \min\{1, n^{-1/p} \log^{1/p} (1 + N/n)\}.$$
 (16)

Given $k \in \{1, ..., N\}$, we define the set $V_k \subset \mathbb{R}^N$ by

$$V_k = \operatorname{conv} \{ (\varepsilon_1 \hat{x}_{\sigma(1)}, \dots, \varepsilon_N \hat{x}_{\sigma(N)}) : \varepsilon_j = \pm 1, \ 1 \leqslant j \leqslant N, \ \sigma \in S_N \},$$

where $\hat{x}_j = 1$ for $1 \leqslant j \leqslant k$, $\hat{x}_j = 0$ for $k+1 \leqslant j \leqslant N$, S_N is the group of permutations of N elements. Notice that $V_1 = B_1^N$, $V_N = B_\infty^N$. For $2 \leqslant q < \infty$, the lower estimates for $d_n(V_k, l_q^N)$ were obtained by Gluskin [9].

Theorem D. [9] Let $2 \le q < \infty$, $1 \le k \le N$, $n \le \min\{N^{\frac{2}{q}}k^{1-\frac{2}{q}}, N/2\}$. Then

$$d_n(V_k, l_q^N) \gtrsim_q k^{1/q}. \tag{17}$$

Let $2 \leqslant q < \infty$, $1 \leqslant k \leqslant N$, $N^{\frac{2}{q}} k^{1-\frac{2}{q}} \leqslant n \leqslant N/2$. Then

$$d_n(V_k, l_q^N) \gtrsim_q k^{1/2} n^{-1/2} N^{1/q}.$$
 (18)

The following result was obtained by Gluskin [15] (the constant in the order inequality depends on q), and by Malykhin and Rjutin [16] (the constant does not depend on q). In [15, p. 39] it was noticed that Galeev obtained the equality $d_n(V_k, l_1^N) = \min\{k, N-n\}.$

Theorem E. [15,16]. Let $1 \le q \le 2$, $n \le N/2$. Then

$$d_n(V_k, l_a^N) \gtrsim k^{1/q}. (19)$$

The following result was obtained by Konyagin, Malykhin and Rjutin [17].

Theorem F. [17]. Let $n \leq N-1$, $1 \leq k \leq N$. Then there is an absolute constant $C \geqslant 1$ such that for $k \geqslant Cn \log^{-1} \frac{2N}{n}$

$$d_n(V_k, l_\infty^N) \geqslant 1/2.$$

Proof of Theorem 1. Let K be defined by (5). From (4) it follows that K is bounded and $\inf_{\alpha \in A} \nu_{\alpha} > 0$. We show that it suffices to consider the case of a compact K. Indeed, let $K = \{(\nu_{\alpha}, 1/p_{\alpha}) : \alpha \in A'\}$ be the closure of K. For α , $\beta \in A'$ we define the numbers $\varkappa_{\alpha,\beta}$ by (2). We prove that

- 1. $M = \bigcap_{\alpha \in A'} \nu_{\alpha} B_{n_{\alpha}}^{N}$
- 2. on the right-hand sides of (6)–(13) the set A can be replaced by A', and the minimum is attained.

Let $\nu_{\alpha_k} \underset{k \to \infty}{\longrightarrow} \nu_{\alpha}$, $1/p_{\alpha_k} \underset{k \to \infty}{\longrightarrow} 1/p_{\alpha}$. Then $\cap_{k \in \mathbb{N}} \nu_{\alpha_k} B_{p_{\alpha_k}}^N \subset \nu_{\alpha} B_{p_{\alpha}}^N$. This implies the

Let
$$(\nu_{\alpha_k}, 1/p_{\alpha_k}) \underset{k \to \infty}{\longrightarrow} (\nu_{\alpha}, 1/p_{\alpha}), (\nu_{\beta_k}, 1/p_{\beta_k}) \underset{k \to \infty}{\longrightarrow} (\nu_{\beta}, 1/p_{\beta}), \alpha \neq \beta$$
. Then

$$\varkappa_{\alpha_k, \beta_k} \underset{k \to \infty}{\to} \varkappa_{\alpha, \beta}.$$
(20)

In particular, $1 \leqslant \varkappa_{\alpha,\beta} \leqslant N$ for all $\alpha, \beta \in A'$.

It is clear that if $(\nu_{\alpha_k}, 1/p_{\alpha_k}) \underset{k \to \infty}{\to} (\nu_{\alpha_k}, 1/p_{\alpha_k})$, then $\nu_{\alpha_k} \underset{k \to \infty}{\to} \nu_{\alpha_k}, \nu_{\alpha_k} N^{1/q-1/p_{\alpha_k}} \underset{k \to \infty}{\to}$ $\nu_{\alpha} N^{1/q-1/p_{\alpha}}$; if, in addition, q > 2, then

$$\nu_{\alpha_k}(\min\{1, n^{-1/2}N^{1/q}\})^{\frac{1/p\alpha_k-1/q}{1/2-1/q}} \underset{k\to\infty}{\to} \nu_{\alpha}(\min\{1, n^{-1/2}N^{1/q}\})^{\frac{1/p\alpha-1/q}{1/2-1/q}}.$$

Let $(\nu_{\alpha_k}, 1/p_{\alpha_k}) \xrightarrow[k \to \infty]{} (\nu_{\alpha}, 1/p_{\alpha}), (\nu_{\beta_k}, 1/p_{\beta_k}) \xrightarrow[k \to \infty]{} (\nu_{\beta}, 1/p_{\beta}), p_{\alpha_k} \geqslant s, p_{\beta_k} \leqslant s$ for every k. We show that $\nu_{\alpha_k} \varkappa_{\alpha_k, \beta_k}^{1/s - 1/p_{\alpha_k}} \xrightarrow[k \to \infty]{} \nu_{\alpha} \varkappa_{\alpha, \beta}^{1/s - 1/p_{\alpha}}$. If $\alpha \neq \beta$, it follows from (20). If $\alpha = \beta$, then $p_{\alpha} = p_{\beta} = s, \varkappa_{\alpha, \beta} = 1, 1 \leqslant \varkappa_{\alpha_k, \beta_k}^{1/s - 1/p_{\alpha_k}} \leqslant N^{1/s - 1/p_{\alpha_k}} \xrightarrow[k \to \infty]{} 1$.

(20). If
$$\alpha = \beta$$
, then $p_{\alpha} = p_{\beta} = s$, $\varkappa_{\alpha,\beta} = 1$, $1 \leqslant \varkappa_{\alpha_{k},\beta_{k}}^{1/s-1/p_{\alpha_{k}}} \leqslant N^{1/s-1/p_{\alpha_{k}}} \xrightarrow[k \to \infty]{} 1$

This completes the proof of the second assertion.

In what follows we suppose that K is compact.

Let $p_{\beta} \leqslant s \leqslant p_{\alpha}$. Then $\frac{1}{s} = \frac{1-\lambda}{p_{\beta}} + \frac{\lambda}{p_{\alpha}}$ for some $\lambda \in [0, 1]$. From Hölder's inequality or from [13, Theorem 2] it follows that

$$B_{p_{\alpha}}^{N} \cap \varkappa_{\alpha,\beta}^{1/p_{\beta}-1/p_{\alpha}} B_{p_{\beta}}^{N} \subset \varkappa_{\alpha,\beta}^{(1-\lambda)(1/p_{\beta}-1/p_{\alpha})} B_{s}^{N} = \varkappa_{\alpha,\beta}^{1/s-1/p_{\alpha}} B_{s}^{N}. \tag{21}$$

Now we prove (6)–(10).

Case 1. The upper estimate holds, since for every $\alpha \in A$

$$d_n(M, l_q^N) \leq \nu_\alpha d_n(B_{p_\alpha}^N, l_q^N) \stackrel{(15)}{=} \nu_\alpha (N-n)^{1/q-1/p_\alpha} \leq \nu_\alpha N^{1/q-1/p_\alpha}.$$

Let us prove the lower estimate. Let

$$\nu_{\alpha_*} N^{1/q - 1/p_{\alpha_*}} = \min_{\alpha \in A} \nu_{\alpha} N^{1/q - 1/p_{\alpha}}.$$
 (22)

We prove that

$$\nu_{\alpha_*} N^{-1/p_{\alpha_*}} B_{\infty}^N \subset M. \tag{23}$$

It suffices to check that $\nu_{\alpha_*} N^{1/p_{\alpha}-1/p_{\alpha_*}} \leq \nu_{\alpha}$ for all $\alpha \in A$. Indeed, this inequality holds, since $\nu_{\alpha_*} N^{1/q-1/p_{\alpha_*}} \leq \nu_{\alpha} N^{1/q-1/p_{\alpha}}$ by (22).

Hence,

$$d_n(M,\,l_q^N) \overset{(23)}{\geqslant} \nu_{\alpha_*} N^{-1/p_{\alpha_*}} d_n(B_\infty^N,\,l_q^N) \overset{(15)}{=} \nu_{\alpha_*} N^{-1/p_{\alpha_*}} (N-n)^{1/q} \gtrsim \nu_{\alpha_*} N^{1/q-1/p_{\alpha_*}} d_n(B_\infty^N,\,l_q^N) \overset{(15)}{=} \nu_{\alpha_*} N^{-1/p_{\alpha_*}} d_n(B_\infty^N,\,l_q^N) \overset{(15)}{=} \nu_{$$

(recall that $n \leq N/2$).

Cases 2 and 4. Let $\nu_{\alpha_*} = \min_{\alpha \in A} \nu_{\alpha}$. Then $\nu_{\alpha_*} B_1^N \subset M \subset \nu_{\alpha_*} B_{\min\{q,2\}}^N$. It remains to apply Theorem A.

Case 3. Let us prove the upper estimate. Let $\alpha \in A_1'$, $\beta \in A_2'$. Then

$$\nu_{\alpha}B_{p_{\alpha}}^{N} \cap \nu_{\beta}B_{p_{\beta}}^{N} \stackrel{(3)}{=} \nu_{\alpha}(B_{p_{\alpha}}^{N} \cap \varkappa_{\alpha,\beta}^{1/p_{\beta}-1/p_{\alpha}}B_{p_{\beta}}^{N}) \stackrel{(21)}{\subset} \nu_{\alpha}\varkappa_{\alpha,\beta}^{1/q-1/p_{\alpha}}B_{q}^{N}.$$

Hence,

$$d_n(M, l_q^N) \leqslant \nu_\alpha \varkappa_{\alpha, \beta}^{1/q - 1/p_\alpha} d_n(B_q^N, l_q^N) = \nu_\alpha \varkappa_{\alpha, \beta}^{1/q - 1/p_\alpha}$$

It remains to take the minimum over $\alpha \in A'_1$, $\beta \in A'_2$.

Now we obtain the lower estimate. Let

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}} = \min_{\alpha \in A_1', \beta \in A_2'} \nu_{\alpha} \varkappa_{\alpha,\beta}^{1/q-1/p_{\alpha}}.$$
 (24)

First we consider the case $p_{\alpha_*} > q$, $p_{\beta_*} < q$.

Let $k = [\varkappa_{\alpha_*,\beta_*}]$. By (4), we have $1 \leq k \leq N$. We prove that

$$\nu_{\alpha_*} k^{-1/p_{\alpha_*}} V_k \subset 2M. \tag{25}$$

It suffices to check that

$$\nu_{\alpha_*} \mathcal{L}_{\alpha_*,\beta_*}^{1/p_{\gamma}-1/p_{\alpha_*}} \leqslant \nu_{\gamma}, \quad \gamma \in A \tag{26}$$

(then $\nu_{\alpha_*} k^{1/p_{\gamma}-1/p_{\alpha_*}} \leqslant 2\nu_{\gamma}$ for all $\gamma \in A$, and (25) holds).

Let $\gamma \in A_2'$. We have

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}} \stackrel{(24)}{\leqslant} \nu_{\alpha_*} \varkappa_{\alpha_*,\gamma}^{1/q-1/p_{\alpha_*}};$$

since $p_{\alpha_*} > q$, the inequality $\varkappa_{\alpha_*,\beta_*} \leqslant \varkappa_{\alpha_*,\gamma}$ holds. By the conditions $p_{\alpha_*} > q \geqslant p_{\gamma}$, we get $\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/p_{\gamma}-1/p_{\alpha_*}} \leqslant \nu_{\alpha_*} \varkappa_{\alpha_*,\gamma}^{1/p_{\gamma}-1/p_{\alpha_*}} \stackrel{\text{(3)}}{=} \nu_{\gamma}$.

Let $\gamma \in A_1'$. We have

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}} \stackrel{(24)}{\leqslant} \nu_{\gamma} \varkappa_{\gamma,\beta_*}^{1/q-1/p_{\gamma}}.$$

By (3), it is equivalent to

$$\nu_{\beta_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\beta_*}} \leqslant \nu_{\beta_*} \varkappa_{\gamma,\beta_*}^{1/q-1/p_{\beta_*}}.$$

Since $p_{\beta_*} < q$, this implies that $\varkappa_{\alpha_*,\beta_*} \geqslant \varkappa_{\gamma,\beta_*}$. By the conditions $p_{\beta_*} < q \leqslant p_{\gamma}$, we get

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/p_\gamma - 1/p_{\alpha_*}} \stackrel{\text{(3)}}{=} \nu_{\beta_*} \varkappa_{\alpha_*,\beta_*}^{1/p_\gamma - 1/p_{\beta_*}} \leqslant \nu_{\beta_*} \varkappa_{\gamma,\beta_*}^{1/p_\gamma - 1/p_{\beta_*}} \stackrel{\text{(3)}}{=} \nu_{\gamma}.$$

This concludes the proof of (26). Hence,

$$d_n(M, l_q^N) \overset{(25)}{\gtrsim} d_n(\nu_{\alpha_*} k^{-1/p_{\alpha_*}} V_k, l_q^N) \overset{(19)}{\gtrsim} \nu_{\alpha_*} k^{1/q - 1/p_{\alpha_*}} \simeq \nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/q - 1/p_{\alpha_*}}.$$

Let now $p_{\alpha_*} = q$. Then $\nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/q - 1/p_{\alpha_*}} = \nu_{\alpha_*}$. First we consider the case $\inf\{p_\alpha: \alpha \in A_1\} > q$. We take $\alpha_0 \in A_1$ such that

$$\varkappa_{\alpha_0,\alpha_*} = \max_{\gamma \in A_1} \varkappa_{\gamma,\alpha_*} \tag{27}$$

(the maximum is attained, since $\{(\nu_{\gamma}, 1/p_{\gamma}): \gamma \in A_1\}$ is compact and we can apply

We have

$$p_{\alpha_0} > q. \tag{28}$$

Let $k = [\varkappa_{\alpha_0,\alpha_*}]$. By (4), we have $1 \leq k \leq N$. We check that

$$\nu_{\alpha_0} k^{-1/p_{\alpha_0}} V_k \subset 2M. \tag{29}$$

It suffices to prove that

$$\nu_{\alpha_0} \varkappa_{\alpha_0,\alpha_*}^{1/p_{\gamma}-1/p_{\alpha_0}} \leqslant \nu_{\gamma}, \quad \gamma \in A.$$
(30)

Let $\gamma \in A_2'$. Then

$$\nu_{\alpha_0} \varkappa_{\alpha_0,\alpha_*}^{1/q-1/p_{\alpha_0}} = \nu_{\alpha_0} \varkappa_{\alpha_0,\alpha_*}^{1/p_{\alpha_*}-1/p_{\alpha_0}} \overset{(3)}{=} \nu_{\alpha_*} \overset{(24)}{\leqslant} \nu_{\alpha_0} \varkappa_{\alpha_0,\gamma}^{1/q-1/p_{\alpha_0}};$$

this together with (28) yields that $\varkappa_{\alpha_0,\alpha_*} \leqslant \varkappa_{\alpha_0,\gamma}$. Since $p_{\gamma} \leqslant q < p_{\alpha_0}$, we have

$$\nu_{\alpha_0}\varkappa_{\alpha_0,\alpha_*}^{1/p_\gamma-1/p_{\alpha_0}}\leqslant \nu_{\alpha_0}\varkappa_{\alpha_0,\gamma}^{1/p_\gamma-1/p_{\alpha_0}}\stackrel{(3)}{=}\nu_\gamma.$$

Let $\gamma \in A_1$. By (3), the inequality (30) is equivalent to

$$\nu_{\alpha_*} \varkappa_{\alpha_0,\alpha_*}^{1/p_{\gamma}-1/p_{\alpha_*}} \leqslant \nu_{\alpha_*} \varkappa_{\gamma,\alpha_*}^{1/p_{\gamma}-1/p_{\alpha_*}}.$$

Since $p_{\gamma} > q = p_{\alpha_*}$, it is equivalent to $\varkappa_{\alpha_0,\alpha_*} \geqslant \varkappa_{\gamma,\alpha_*}$. The last inequality follows from (27).

This completes the proof of (30). Hence,

$$d_n(M, l_q^N) \overset{(29)}{\gtrsim} \nu_{\alpha_0} k^{-1/p_{\alpha_0}} d_n(V_k, l_q^N) \overset{(19)}{\gtrsim} \nu_{\alpha_0} \varkappa_{\alpha_0, \alpha_*}^{1/q - 1/p_{\alpha_0}} \overset{(3)}{=} \nu_{\alpha_*} \varkappa_{\alpha_0, \alpha_*}^{1/q - 1/p_{\alpha_*}} = \nu_{\alpha_*}. \tag{31}$$

Now let $\inf\{p_{\alpha}: \alpha \in A_1\} = q$. For $\delta > 0$ we set

$$A^{\delta} = A_2' \cup \{ \alpha \in A_1 : 1/q - 1/p_{\alpha} \geqslant \delta \}, \tag{32}$$

 $M_{\delta} = \bigcap_{\alpha \in A^{\delta}} \nu_{\alpha} B_{p_{\alpha}}^{N}$. By (31), we have

$$d_n(M_\delta, l_q^N) \gtrsim \nu_{\alpha_*}.$$

We prove that for small $\delta > 0$ the inclusion $M_{\delta} \subset 2M$ holds. It suffices to take

$$0 < \delta \leqslant \frac{\ln 2}{\ln N} \tag{33}$$

and to check that

$$2 \cap_{\alpha \in A \setminus A^{\delta}} \nu_{\alpha} B_{p_{\alpha}}^{N} \supset \nu_{\alpha_{*}} B_{q}^{N}. \tag{34}$$

Notice that $p_{\alpha} > q$ for $\alpha \in A \backslash A^{\delta}$. Hence (34) holds if $2\nu_{\alpha} \geqslant \nu_{\alpha_*}$ for all $\alpha \in A \backslash A^{\delta}$. We have

$$\nu_{\alpha_*}/\nu_{\alpha} \stackrel{(3)}{=} \varkappa_{\alpha,\alpha_*}^{1/p_{\alpha_*}-1/p_{\alpha}} \stackrel{(4)}{\leqslant} N^{1/q-1/p_{\alpha}} \stackrel{(32)}{\leqslant} N^{\delta} \stackrel{(33)}{\leqslant} 2;$$

this implies (34) and completes the proof of the lower estimate of $d_n(M, l_q^N)$ for $p_{\alpha_*} = q$.

Let now $p_{\beta_*} = q$. Then $\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}} \stackrel{(3)}{=} \nu_{\beta_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\beta_*}} = \nu_{\beta_*}$. Hence, $d_n(M, l_q^N) \gtrsim \nu_{\beta_*}$.

Case 5. We prove the upper estimate. Let $\alpha \in A_2'$. By Theorem A,

$$d_n(M, l_q^N) \leqslant d_n(\nu_\alpha B_{p_\alpha}^N, l_q^N) \lesssim \nu_\alpha (\min\{1, n^{-1/2} N^{1/q}\})^{\frac{1/p_\alpha - 1/q}{1/2 - 1/q}}.$$

Let $\alpha \in A_1'$, $\beta \in A_2' \cup A_3'$. Then

$$M \subset \nu_{\alpha} B_{p_{\alpha}}^{N} \cap \nu_{\beta} B_{p_{\beta}}^{N} \overset{(3),(21)}{\subset} \nu_{\alpha} \varkappa_{\alpha,\beta}^{1/q-1/p_{\alpha}} B_{q}^{N};$$

hence,

$$d_n(M, l_q^N) \leqslant \nu_\alpha \varkappa_{\alpha, \beta}^{1/q - 1/p_\alpha} d_n(B_q^N, l_q^N) = \nu_\alpha \varkappa_{\alpha, \beta}^{1/q - 1/p_\alpha}.$$

Let $\alpha \in A'_1 \cup A'_2$, $\beta \in A'_3$. Then

$$M \subset \nu_{\alpha} B_{p_{\alpha}}^{N} \cap \nu_{\beta} B_{p_{\beta}}^{N} \stackrel{(3),(21)}{\subset} \nu_{\alpha} \varkappa_{\alpha,\beta}^{1/2-1/p_{\alpha}} B_{2}^{N};$$

by Theorem A,

$$d_n(M, l_q^N) \leqslant d_n(\nu_\alpha \varkappa_{\alpha, \beta}^{1/2 - 1/p_\alpha} B_2^N, l_q^N) \lesssim \nu_\alpha \varkappa_{\alpha, \beta}^{1/2 - 1/p_\alpha} \min\{1, n^{-1/2} N^{1/q}\}.$$

Now we prove the lower estimate. We denote $A_1 = \{\alpha \in A : p_\alpha > q\}, A_2 = \{\alpha \in A : 2 < p_\alpha < q\}, A_3 = \{\alpha \in A : p_\alpha < 2\}.$

1. Let

$$\Phi(n, N, q, K) = \nu_{\alpha_*}(\min\{1, n^{-1/2}N^{1/q}\})^{\frac{1/p_{\alpha_*} - 1/q}{1/2 - 1/q}}, \quad \alpha_* \in A_2';$$
 (35)

in addition, we suppose that $p_{\alpha_*} \neq q$ if $A_1 \neq \emptyset$, and $p_{\alpha_*} \neq 2$ if $A_3 \neq \emptyset$.

We set

$$l = (\max\{1, n^{1/2}N^{-1/q}\})^{\frac{1}{1/2-1/q}}, \quad k = \lceil l \rceil.$$
(36)

Notice that $1 \leq l \leq N$ and $1 \leq k \leq N$. We prove that

$$\nu_{\alpha_*} k^{-1/p_{\alpha_*}} V_k \subset 2M. \tag{37}$$

It suffices to check that

$$\nu_{\alpha_*} l^{1/p_{\gamma} - 1/p_{\alpha_*}} \leqslant \nu_{\gamma}, \quad \gamma \in A.$$

If $\gamma \in A'_2$, it follows from the inequality

$$\nu_{\alpha_*}(\min\{1, n^{-1/2}N^{1/q}\})^{\frac{1/p_{\alpha_*}-1/q}{1/2-1/q}} \overset{(10),(12),(35)}{\leqslant} \nu_{\gamma}(\min\{1, n^{-1/2}N^{1/q}\})^{\frac{1/p_{\gamma}-1/q}{1/2-1/q}}.$$

Let $\gamma \in A_1$ (hence, $A_1 \neq \emptyset$; by our assumption, we have $p_{\alpha_*} < q$). Then

$$\nu_{\alpha_*}(\min\{1, n^{-1/2}N^{1/q}\})^{\frac{1/p_{\alpha_*}-1/q}{1/2-1/q}} \overset{(10),(11),(35)}{\leqslant} \nu_{\gamma} \varkappa_{\gamma,\alpha_*}^{1/q-1/p_{\gamma}} \overset{(3)}{=} \nu_{\alpha_*} \varkappa_{\gamma,\alpha_*}^{1/q-1/p_{\alpha_*}}.$$

Hence, $l^{1/q-1/p_{\alpha_*}} \leqslant \varkappa_{\gamma,\alpha_*}^{1/q-1/p_{\alpha_*}}$, and $l \geqslant \varkappa_{\gamma,\alpha_*}$. Since $p_{\gamma} > q > p_{\alpha_*}$, we have

$$\nu_{\alpha_*} l^{1/p_{\gamma}-1/p_{\alpha_*}} \leqslant \nu_{\alpha_*} \varkappa_{\gamma,\alpha_*}^{1/p_{\gamma}-1/p_{\alpha_*}} \overset{(3)}{=} \nu_{\gamma}.$$

Let $\gamma \in A_3$ (hence, $A_3 \neq \emptyset$; by our assumption, we have $p_{\alpha_*} > 2$). Then

$$\nu_{\alpha_*}(\min\{1, n^{-1/2}N^{1/q}\})^{\frac{1/p_{\alpha_*}-1/q}{1/2-1/q}} \overset{(10),(13),(35)}{\leqslant} \nu_{\alpha_*} \varkappa_{\alpha_*,\gamma}^{1/2-1/p_{\alpha_*}} \min\{1, n^{-1/2}N^{1/q}\}.$$

Therefore, $l^{1/2-1/p_{\alpha_*}} \leqslant \varkappa_{\alpha_*,\gamma}^{1/2-1/p_{\alpha_*}}$. Hence, $l \leqslant \varkappa_{\alpha_*,\gamma}$; since $p_{\gamma} < 2 < p_{\alpha_*}$, we have

$$\nu_{\alpha_*} l^{1/p_{\gamma} - 1/p_{\alpha_*}} \leqslant \nu_{\alpha_*} \varkappa_{\alpha_*, \gamma}^{1/p_{\gamma} - 1/p_{\alpha_*}} \stackrel{(3)}{=} \nu_{\gamma}.$$

This concludes the proof of (37). Notice that $n \stackrel{(36)}{\leqslant} N^{2/q} k^{1-2/q}$. Hence,

$$d_{n}(M, l_{q}^{N}) \overset{(37)}{\gtrsim} d_{n}(\nu_{\alpha_{*}} k^{-1/p_{\alpha_{*}}} V_{k}, l_{q}^{N}) \overset{(17)}{\underset{q}{\gtrsim}} \nu_{\alpha_{*}} k^{1/q - 1/p_{\alpha_{*}}} \overset{(36)}{\gtrsim}$$
$$\gtrsim \nu_{\alpha_{*}} (\min\{1, n^{-1/2} N^{1/q}\})^{\frac{1/p_{\alpha_{*}} - 1/q}{1/2 - 1/q}}.$$

$$\Phi(n, N, q, K) = \nu_{\alpha_*}, \quad p_{\alpha_*} = q, \quad A_1 \neq \varnothing. \tag{38}$$

First we suppose that

$$\sup\{p_{\alpha}: \ \alpha \in A_2 \cup A_3'\} < q. \tag{39}$$

We take $\alpha_0 \in A_2 \cup A_3'$ such that

$$\varkappa_{\alpha_*,\alpha_0} = \min_{\gamma \in A_2 \cup A_3'} \varkappa_{\alpha_*,\gamma} \tag{40}$$

(by (39), the minimum is attained and $p_{\alpha_0} < q$). Let $k = \lceil \varkappa_{\alpha_*,\alpha_0} \rceil$. From (4) it follows that $1 \leq k \leq N$. We prove that

$$\nu_{\alpha_0} k^{-1/p_{\alpha_0}} V_k \subset 2M. \tag{41}$$

It suffices to check the inequality

$$\nu_{\alpha_0} \varkappa_{\alpha_*,\alpha_0}^{1/p_{\gamma}-1/p_{\alpha_0}} \leqslant \nu_{\gamma}, \quad \gamma \in A.$$
(42)

Let $\gamma \in A_2 \cup A_3'$. From (40) it follows that $\varkappa_{\alpha_*,\alpha_0} \leqslant \varkappa_{\alpha_*,\gamma}$. Since $p_{\alpha_*} = q > p_{\gamma}$, we get $\nu_{\alpha_*} \varkappa_{\alpha_*,\alpha_0}^{1/p_{\gamma}-1/p_{\alpha_*}} \leqslant \nu_{\alpha_*} \varkappa_{\alpha_*,\gamma}^{1/p_{\gamma}-1/p_{\alpha_*}}$. By (3), this inequality is equivalent to (42).

Let $\gamma \in A_1'$. By (3), the inequality (42) is equivalent to $\nu_{\alpha_0} \varkappa_{\alpha_*,\alpha_0}^{1/p_\gamma - 1/p_{\alpha_0}} \leqslant \nu_{\alpha_0} \varkappa_{\gamma,\alpha_0}^{1/p_\gamma - 1/p_{\alpha_0}}$. Since $p_{\alpha_0} < p_\gamma$, it is equivalent to

$$\varkappa_{\alpha_*,\alpha_0} \geqslant \varkappa_{\gamma,\alpha_0}.$$
(43)

Let us prove this inequality. If $p_{\gamma} = q$, then $\gamma = \alpha_*$. Let $p_{\gamma} > q$. We have

$$\nu_{\alpha_*} \overset{(10),(11),(38)}{\leqslant} \nu_{\gamma} \varkappa_{\gamma,\alpha_0}^{1/q-1/p_{\gamma}};$$

by (3), it is equivalent to $\nu_{\alpha_0} \varkappa_{\alpha_*,\alpha_0}^{1/p_{\alpha_*}-1/p_{\alpha_0}} \leqslant \nu_{\alpha_0} \varkappa_{\gamma,\alpha_0}^{1/q-1/p_{\alpha_0}} = \nu_{\alpha_0} \varkappa_{\gamma,\alpha_0}^{1/p_{\alpha_*}-1/p_{\alpha_0}}$. Since $p_{\alpha_0} < q = p_{\alpha_*}$, we get (43).

This completes the proof of (41).

Now we check that

$$n \leqslant N^{2/q} \varkappa_{\alpha_*,\alpha_0}^{1-2/q}. \tag{44}$$

It suffices to consider $n \geqslant N^{2/q}$.

If $\alpha_0 \in A_2$, (44) follows from

$$\nu_{\alpha_*} \overset{(10),(12),(38)}{\leqslant} \nu_{\alpha_0} \big(n^{-1/2} N^{1/q} \big)^{\frac{1/p_{\alpha_0}-1/q}{1/2-1/q}} \overset{(3)}{=} \nu_{\alpha_*} \varkappa_{\alpha_*,\alpha_0}^{1/p_{\alpha_0}-1/p_{\alpha_*}} \big(n^{-1/2} N^{1/q} \big)^{\frac{1/p_{\alpha_0}-1/q}{1/2-1/q}}.$$

If $\alpha_0 \in A_3'$, (44) follows from

$$\nu_{\alpha_*} \overset{(10),(13),(38)}{\leqslant} \nu_{\alpha_*} \varkappa_{\alpha_*,\alpha_0}^{1/2-1/p_{\alpha_*}} n^{-1/2} N^{1/q}.$$

Hence,

$$d_n(M, l_q^N) \overset{(17),(41),(44)}{\underset{q}{\gtrsim}} \nu_{\alpha_0} k^{1/q-1/p_{\alpha_0}} \simeq \nu_{\alpha_0} \varkappa_{\alpha_*,\alpha_0}^{1/p_{\alpha_*}-1/p_{\alpha_0}} \overset{(3)}{=} \nu_{\alpha_*}. \tag{45}$$

Let now

$$\sup\{p_{\alpha}: \ \alpha \in A_2 \cup A_3'\} = q.$$

We set

$$A^{\delta} = A_1' \cup \{ \alpha \in A_2 \cup A_3' : 1/p_{\alpha} - 1/q \geqslant \delta \}, \tag{46}$$

 $M_{\delta} = \bigcap_{\alpha \in A^{\delta}} \nu_{\alpha} B_{p_{\alpha}}^{N}$. By (45),

$$d_n(M_\delta, l_q^N) \gtrsim_q \nu_{\alpha_*}.$$

We prove that if

$$0 < \delta \leqslant \frac{\ln 2}{\ln N},\tag{47}$$

then $M_{\delta} \subset 2M$. It suffices to check that

$$2 \cap_{\alpha \in A \setminus A^{\delta}} \nu_{\alpha} B_{p_{\alpha}}^{N} \supset \nu_{\alpha_{*}} B_{q}^{N}. \tag{48}$$

Since $p_{\alpha} < q$ for all $\alpha \in A \backslash A^{\delta}$, (48) holds if

$$\nu_{\alpha_*} \leqslant 2\nu_{\alpha} \cdot N^{1/q - 1/p_{\alpha}}, \quad \alpha \in A \backslash A^{\delta}.$$
 (49)

We have $\nu_{\alpha} \stackrel{(3)}{=} \nu_{\alpha_*} \varkappa_{\alpha_*,\alpha}^{1/p_{\alpha}-1/p_{\alpha_*}} \stackrel{(4),(46)}{\geqslant} \nu_{\alpha_*}$. This together with (46) and (47) yields (49).

3. Let

$$\Phi(n, N, q, K) = \nu_{\alpha_*} n^{-1/2} N^{1/q}, \quad p_{\alpha_*} = 2, \quad A_3 \neq \varnothing,$$
(50)

and let $n \geqslant N^{2/q}$.

First we consider the case

$$\inf\{p_{\alpha}: \ \alpha \in A_1' \cup A_2\} > 2. \tag{51}$$

We take $\alpha_0 \in A_1' \cup A_2$ such that

$$\varkappa_{\alpha_0,\alpha_*} = \max_{\gamma \in A_1' \cup A_2} \varkappa_{\gamma,\alpha_*} \tag{52}$$

(by (51), the maximum is attained and $p_{\alpha_0} > 2$). Let $k = \lfloor \varkappa_{\alpha_0, \alpha_*} \rfloor$.

We check that

$$\nu_{\alpha_0} k^{-1/p_{\alpha_0}} V_k \subset 2M. \tag{53}$$

It suffices to prove the inequality

$$\nu_{\alpha_0} \chi_{\alpha_0, \alpha_*}^{1/p_{\gamma} - 1/p_{\alpha_0}} \leqslant \nu_{\gamma}, \quad \gamma \in A. \tag{54}$$

If $\gamma \in A_3'$, then

this together with the condition $p_{\alpha_0} > 2$ yields that $\varkappa_{\alpha_0,\gamma} \geqslant \varkappa_{\alpha_0,\alpha_*}$. Since $p_{\gamma} \leqslant 2 < p_{\alpha_0}$, we have

$$\nu_{\alpha_0}\varkappa_{\alpha_0,\alpha_*}^{1/p_\gamma-1/p_{\alpha_0}}\leqslant\nu_{\alpha_0}\varkappa_{\alpha_0,\gamma}^{1/p_\gamma-1/p_{\alpha_0}}\stackrel{(3)}{=}\nu_\gamma.$$

If $\gamma \in A'_1 \cup A_2$, then by (3) inequality (54) is equivalent to $\nu_{\alpha_*} \varkappa_{\alpha_0,\alpha_*}^{1/p_{\gamma}-1/p_{\alpha_*}} \leq \nu_{\alpha_*} \varkappa_{\gamma,\alpha_*}^{1/p_{\gamma}-1/p_{\alpha_*}}$; since $p_{\gamma} > p_{\alpha_*}$, it is equivalent to $\varkappa_{\alpha_0,\alpha_*} \geqslant \varkappa_{\gamma,\alpha_*}$; the last inequality holds by (52).

This completes the proof of (53).

Let us prove that

$$n \geqslant N^{2/q} \varkappa_{\alpha_0, \alpha_*}^{1 - 2/q}. \tag{55}$$

For $\alpha_0 \in A'_1$, it follows from

$$\nu_{\alpha_*} n^{-1/2} N^{1/q} \overset{(10),(11),(50)}{\leqslant} \nu_{\alpha_0} \varkappa_{\alpha_0,\alpha_*}^{1/q-1/p_{\alpha_0}} \overset{(3)}{=} \nu_{\alpha_*} \varkappa_{\alpha_0,\alpha_*}^{1/q-1/p_{\alpha_*}} = \nu_{\alpha_*} \varkappa_{\alpha_0,\alpha_*}^{1/q-1/2},$$

for $\alpha_0 \in A_2$, it follows from

$$\nu_{\alpha_*} n^{-1/2} N^{1/q} \overset{(10),(12),(50)}{\leqslant} \nu_{\alpha_0} (n^{-1/2} N^{1/q})^{\frac{1/p_{\alpha_0}-1/q}{1/2-1/q}} \overset{(3)}{=} \nu_{\alpha_*} \varkappa_{\alpha_0,\alpha_*}^{1/p_{\alpha_0}-1/p_{\alpha_*}} (n^{-1/2} N^{1/q})^{\frac{1/p_{\alpha_0}-1/q}{1/2-1/q}}.$$

Hence, we get

$$d_n(M, l_q^N) \overset{(53)}{\gtrsim} d_n(\nu_{\alpha_0} k^{-1/p_{\alpha_0}} V_k, l_q^N) \overset{(18),(55)}{\underset{q}{\gtrsim}}$$

$$\gtrsim \nu_{\alpha_0} \varkappa_{\alpha_0,\alpha_*}^{1/2-1/p_{\alpha_0}} n^{-1/2} N^{1/q} \stackrel{(3)}{=} \nu_{\alpha_*} n^{-1/2} N^{1/q}.$$

If $\inf\{p_{\alpha}: \alpha \in A'_1 \cup A_2\} = 2$, we argue as in the previous cases and obtain the desired estimate.

4. Let

$$\Phi(n, N, q, K) = \nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/q - 1/p_{\alpha_*}}, \quad \alpha_* \in A_1', \quad \beta_* \in A_2' \cup A_3'.$$
 (56)

Notice that if $p_{\alpha_*} = q$, the right-hand side of (56) is equal to ν_{α_*} ; if $p_{\beta_*} = q$, we get by (3) $\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}} = \nu_{\beta_*}$; thus, we have arrived at the case already considered. Further we suppose that $p_{\alpha_*} > q$, $p_{\beta_*} < q$.

Let $k = \lceil \varkappa_{\alpha_*, \beta_*} \rceil$.

We prove that

$$\nu_{\alpha_*} k^{-1/p_{\alpha_*}} V_k \subset 2M. \tag{57}$$

It suffices to check that

$$\nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/p_{\gamma} - 1/p_{\alpha_*}} \leqslant \nu_{\gamma}, \quad \gamma \in A.$$
 (58)

Let $\gamma \in A_1'$. We have $\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}} \overset{(10),(11),(56)}{\leqslant} \nu_{\gamma} \varkappa_{\gamma,\beta_*}^{1/q-1/p_{\gamma}}$; by (3), it is equivalint to $\nu_{\beta_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\beta_*}} \leqslant \nu_{\beta_*} \varkappa_{\gamma,\beta_*}^{1/q-1/p_{\beta_*}}$; since $p_{\beta_*} < q$, we have $\varkappa_{\alpha_*,\beta_*} \geqslant \varkappa_{\gamma,\beta_*}$. This together with $p_{\gamma} \geqslant q > p_{\beta_*}$ implies that

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/p_{\gamma}-1/p_{\alpha_*}} \stackrel{(3)}{=} \nu_{\beta_*} \varkappa_{\alpha_*,\beta_*}^{1/p_{\gamma}-1/p_{\beta_*}} \leqslant \nu_{\beta_*} \varkappa_{\gamma,\beta_*}^{1/p_{\gamma}-1/p_{\beta_*}} \stackrel{(3)}{=} \nu_{\gamma}.$$

Let $\gamma \in A_2' \cup A_3'$. We have

$$\nu_{\alpha_*}\varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}} \overset{(10),(11),(56)}{\leqslant} \nu_{\alpha_*}\varkappa_{\alpha_*,\gamma}^{1/q-1/p_{\alpha_*}};$$

hence, $\varkappa_{\alpha_*,\beta_*} \leqslant \varkappa_{\alpha_*,\gamma}$ by the condition $p_{\alpha_*} > q$. Since $p_{\gamma} \leqslant q < p_{\alpha_*}$, we have

$$\nu_{\alpha_*}\varkappa_{\alpha_*,\beta_*}^{1/p_\gamma-1/p_{\alpha_*}}\leqslant \nu_{\alpha_*}\varkappa_{\alpha_*,\gamma}^{1/p_\gamma-1/p_{\alpha_*}}\stackrel{(3)}{=}\nu_\gamma.$$

This concludes the proof of (58).

Now we check the inequality

$$n \leqslant N^{2/q} \varkappa_{\alpha_*, \beta_*}^{1-2/q}. \tag{59}$$

It suffices to consider $n \ge N^{2/q}$.

If $\beta_* \in A_2$, then (59) follows from

$$\nu_{\beta_*}\varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\beta_*}} \overset{(3)}{=} \nu_{\alpha_*}\varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}} \overset{(10),(12),(56)}{\leqslant} \nu_{\beta_*} (n^{-1/2}N^{1/q})^{\frac{1/p_{\beta_*}-1/q}{1/2-1/q}}.$$

If $\beta_* \in A_3'$, then (59) follows from

$$\nu_{\alpha_*}\varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}} \overset{(10),(13),(56)}{\leqslant} \nu_{\alpha_*}\varkappa_{\alpha_*,\beta_*}^{1/2-1/p_{\alpha_*}} n^{-1/2} N^{1/q}.$$

Hence,

$$d_{n}(M, l_{q}^{N}) \overset{(57)}{\gtrsim} d_{n}(\nu_{\alpha_{*}} k^{-1/p_{\alpha_{*}}} V_{k}, l_{q}^{N}) \overset{(17),(59)}{\gtrsim}$$
$$\gtrsim \nu_{\alpha_{*}} k^{1/q - 1/p_{\alpha_{*}}} \gtrsim \nu_{\alpha_{*}} \varkappa_{\alpha_{*},\beta_{*}}^{1/q - 1/p_{\alpha_{*}}}.$$

5. Let

$$\Phi(n, N, q, K) = \nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/2 - 1/p_{\alpha_*}} n^{-1/2} N^{1/q}, \quad \alpha_* \in A_1' \cup A_2', \quad \beta_* \in A_3', \quad (60)$$

and let $n \ge N^{2/q}$. Notice that if $p_{\alpha_*} = 2$, the right-hand side of (60) equals to $\nu_{\alpha_*} n^{-1/2} N^{1/q}$; if $p_{\beta_*} = 2$, we have $\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/2-1/p_{\alpha_*}} n^{-1/2} N^{1/q} \stackrel{\text{(3)}}{=} \nu_{\beta_*} n^{-1/2} N^{1/q}$. Thus, we have arrived at the case already considered.

Further we suppose that $p_{\alpha_*} > 2$, $p_{\beta_*} < 2$.

Let
$$k = \lfloor \varkappa_{\alpha_*, \beta_*} \rfloor$$
.

We show that

$$\nu_{\alpha_*} k^{-1/p_{\alpha_*}} V_k \subset 2M. \tag{61}$$

It suffices to check that

$$\nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/p_{\gamma} - 1/p_{\alpha_*}} \leqslant \nu_{\gamma}, \quad \gamma \in A. \tag{62}$$

If $\gamma \in A'_1 \cup A'_2$, we have

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/2 - 1/p_{\alpha_*}} n^{-1/2} N^{1/q} \overset{(10),(13),(60)}{\leqslant} \nu_{\gamma} \varkappa_{\gamma,\beta_*}^{1/2 - 1/p_{\gamma}} n^{-1/2} N^{1/q};$$

this together with (3) yields that $\nu_{\beta_*} \varkappa_{\alpha_*,\beta_*}^{1/2-1/p_{\beta_*}} \leqslant \nu_{\beta_*} \varkappa_{\gamma,\beta_*}^{1/2-1/p_{\beta_*}}$. Since $p_{\beta_*} < 2$, it implies that $\varkappa_{\alpha_*,\beta_*} \geqslant \varkappa_{\gamma,\beta_*}$. Hence, by $p_{\gamma} \geqslant 2 > p_{\beta_*}$ we get

$$\nu_{\alpha_*}\varkappa_{\alpha_*,\beta_*}^{1/p_\gamma-1/p_{\alpha_*}}\stackrel{(3)}{=}\nu_{\beta_*}\varkappa_{\alpha_*,\beta_*}^{1/p_\gamma-1/p_{\beta_*}}\leqslant\nu_{\beta_*}\varkappa_{\gamma,\beta_*}^{1/p_\gamma-1/p_{\beta_*}}\stackrel{(3)}{=}\nu_\gamma.$$

If $\gamma \in A_3'$, we have

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/2-1/p_{\alpha_*}} n^{-1/2} N^{1/q} \overset{(10),(13),(60)}{\leqslant} \nu_{\alpha_*} \varkappa_{\alpha_*,\gamma}^{1/2-1/p_{\alpha_*}} n^{-1/2} N^{1/q}.$$

Since $p_{\alpha_*} > 2$, it yields that $\varkappa_{\alpha_*,\beta_*} \leqslant \varkappa_{\alpha_*,\gamma}$. Recall that $p_{\alpha_*} > 2 \geqslant p_{\gamma}$. Hence,

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/p_{\gamma}-1/p_{\alpha_*}} \leqslant \nu_{\alpha_*} \varkappa_{\alpha_*,\gamma}^{1/p_{\gamma}-1/p_{\alpha_*}} \stackrel{(3)}{=} \nu_{\gamma}.$$

This completes the proof of (62).

Now we show that

$$n \geqslant \varkappa_{\alpha_*, \beta_*}^{1-2/q} N^{2/q}. \tag{63}$$

If $\alpha_* \in A_1'$, then (63) follows from

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/2-1/p_{\alpha_*}} n^{-1/2} N^{1/q} \overset{(10),(11),(60)}{\leq} \nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/q-1/p_{\alpha_*}}.$$

If $\alpha_* \in A_2$, then (63) follows from

$$\nu_{\alpha_*} \varkappa_{\alpha_*,\beta_*}^{1/2-1/p_{\alpha_*}} n^{-1/2} N^{1/q} \overset{(10),(12),(60)}{\leqslant} \nu_{\alpha_*} (n^{-1/2} N^{1/q})^{\frac{1/p_{\alpha_*}-1/q}{1/2-1/q}}.$$

Hence,

$$d_{n}(M, l_{q}^{N}) \overset{(61)}{\gtrsim} d_{n}(\nu_{\alpha_{*}} k^{-1/p_{\alpha_{*}}} V_{k}, l_{q}^{N}) \overset{(18),(63)}{\underset{q}{\gtrsim}}$$

$$\gtrsim \nu_{\alpha_{*}} k^{1/2 - 1/p_{\alpha_{*}}} n^{-1/2} N^{1/q} \simeq \nu_{\alpha_{*}} \varkappa_{\alpha_{*},\beta_{*}}^{1/2 - 1/p_{\alpha_{*}}} n^{-1/2} N^{1/q}.$$

- 6. Let $n \leqslant N^{2/q}$, $\Phi(n, N, q, K) = \nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/2-1/p_{\alpha_*}}$, $\alpha_* \in A_1' \cup A_2$, $\beta_* \in A_3$. If $\alpha_* \in A_1'$, it follows from (10), (11) that $\nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/2-1/p_{\alpha_*}} \leqslant \nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/q-1/p_{\alpha_*}}$; therefore, $\varkappa_{\alpha_*, \beta_*} \leqslant 1$. By (4), we get $\varkappa_{\alpha_*, \beta_*} = 1$ and $\Phi(n, N, q, K) = \nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/q-1/p_{\alpha_*}}$. We have arrived at the case already considered. If $\alpha_* \in A_2$, it follows from (10), (12) that $\nu_{\alpha_*} \varkappa_{\alpha_*, \beta_*}^{1/2-1/p_{\alpha_*}} \leqslant \nu_{\alpha_*}$. Hence, $\varkappa_{\alpha_*, \beta_*} \stackrel{\text{(4)}}{=} 1$ and $\Phi(n, N, q, K) = \nu_{\alpha_*}$. We have arrived at the case already considered.
- 7. Let $n \leq N^{2/q}$, $p_{\alpha_*} = 2$, $\Phi(n, N, q, K) = \nu_{\alpha_*}$. We prove that $\nu_{\alpha_*} \leq \nu_{\alpha}$ for all $\alpha \in A$. If $\alpha \in A_2$, it follows from (10), (12). If $\alpha \in A'_3$, then $\nu_{\alpha} \stackrel{\text{(3)}}{=} \nu_{\alpha_*} \varkappa_{\alpha_*,\alpha}^{1/p_{\alpha}-1/p_{\alpha_*}} \stackrel{\text{(4)}}{\geq} \nu_{\alpha_*}$. If $\alpha \in A'_1$, then $\nu_{\alpha_*} \leq \nu_{\alpha} \varkappa_{\alpha,\alpha_*}^{1/q-1/p_{\alpha}}$ by (10), (11). Applying (3), we get $\nu_{\alpha_*} \leq \nu_{\alpha_*} \varkappa_{\alpha,\alpha_*}^{1/q-1/p_{\alpha_*}}$, or $\varkappa_{\alpha,\alpha_*} \leq 1$. By (4), we have $\varkappa_{\alpha,\alpha_*} = 1$ and $\nu_{\alpha_*} = \nu_{\alpha}$. Hence, $M \supset \nu_{\alpha_*} B_1^N$, and by Theorem A

$$d_n(M, l_q^N) \geqslant \nu_{\alpha_*} d_n(B_1^N, l_q^N) \gtrsim \nu_{\alpha_*}.$$

This completes the proof.

Proof of Theorem 2. The upper estimate follows from Theorem C.

Let us prove the lower estimate. As in Theorem 1, we may assume that the set K is compact and the minimum in the right-hand side of (14) is attained at some $\alpha_* \in A$. Then

$$\nu_{\alpha_*} \left\lceil n \log^{-1} \frac{2N}{n} \right\rceil^{-1/p_{\alpha_*}} \leqslant \nu_{\alpha} \left\lceil n \log^{-1} \frac{2N}{n} \right\rceil^{-1/p_{\alpha}}, \quad \alpha \in A.$$
 (64)

Let C > 0 be the constant from Theorem F, $k_* = \min \left\{ \left\lceil C n \log^{-1} \frac{2N}{n} \right\rceil, N \right\}$. Notice that if $k_* = N$, then $n \approx N$, $d_n(V_{k_*}, l_\infty^N) = d_n(B_\infty^N, l_\infty^N) = 1$.

We have

$$d_n(\nu_{\alpha_*} k_*^{-1/p_{\alpha_*}} V_{k_*}, l_{\infty}^N) \geqslant \nu_{\alpha_*} k_*^{-1/p_{\alpha_*}} / 2 \gtrsim \nu_{\alpha_*} \min \left\{ 1, n^{-1} \log \frac{2N}{n} \right\}^{1/p_{\alpha_*}}.$$

By (64), there is an absolute constant $C_1 > 0$ such that $\nu_{\alpha_*} k_*^{-1/p_{\alpha_*}} V_{k_*} \subset C_1 M$. This concludes the proof.

3 The case of arbitrary ν_{α} .

Notice that if $\inf_{\alpha \in A} \nu_{\alpha} = 0$, then $\bigcap_{\alpha \in A} \nu_{\alpha} B_{p_{\alpha}}^{N} = \{0\}$. Therefore, further we assume that $\inf_{\alpha \in A} \nu_{\alpha} > 0$.

We set $Z = \{1/p_{\alpha} : \alpha \in A\} \subset [0, 1]$; for $z = 1/p_{\alpha}$ we set $\nu(z) = \nu_{\alpha}$. Then $M = \bigcap_{z \in Z} \nu(z) B_{1/z}^N$, and (4) is equivalent to

$$1 \leqslant \frac{\nu(z)}{\nu(w)} \leqslant N^{z-w}, \quad z, w \in \mathbb{Z}, \quad z \geqslant w.$$

Let $\nu:Z\to (0,\infty)$ be an arbitrary function, and let $\inf_{z\in Z}\nu(z)>0$. We construct the function $\nu_{**}:Z\to (0,\infty)$ such that

$$1 \leqslant \frac{\nu_{**}(z)}{\nu_{**}(w)} \leqslant N^{z-w}, \quad z, \ w \in Z, \quad z \geqslant w,$$
 (65)

$$M = \bigcap_{z \in Z} \nu_{**}(z) B_{1/z}^{N}. \tag{66}$$

Let

$$\nu_*(z) = \inf\{\nu(w) : w \geqslant z\}, \quad z \in Z.$$

Then $\nu_*(z) \leqslant \nu(z)$ and the function ν_* is non-decreasing. We show that

$$M = \bigcap_{z \in Z} \nu_*(z) B_{1/z}^N. \tag{67}$$

Since $\nu_*(z) \leqslant \nu(z)$ for all $z \in Z$, it suffices to check that

$$\nu_*(w)B_{1/w}^N \supset \cap_{z \in Z} \nu(z)B_{1/z}^N, \quad w \in Z.$$
 (68)

Let $w_n \geqslant w$, $\nu(w_n) \underset{n \to \infty}{\longrightarrow} \nu_*(w)$. Then

$$\nu_*(w)B_{1/w}^N \supset \bigcap_{n \in \mathbb{N}} \nu(w_n)B_{1/w}^N \supset \bigcap_{n \in \mathbb{N}} \nu(w_n)B_{1/w_n}^N,$$

which implies (68).

Now we set

$$\nu_{**}(z) = \inf\{\nu_{*}(w) \cdot N^{z-w} : w \leq z\}.$$

Notice that

$$\nu_{**}(z) \leqslant \nu_{*}(z), \quad z \in Z. \tag{69}$$

We show that ν_{**} is a non-decreasing function. Indeed, let $z_1 \leq z_2$. If $w \leq z_1$, then $\nu_*(w) \cdot N^{z_1-w} \leq \nu_*(w) \cdot N^{z_2-w}$; hence, $\nu_{**}(z_1) \leq \inf\{\nu_*(w) \cdot N^{z_2-w} : w \leq z_1\}$. If $z_1 \leq w \leq z_2$, by the monotonicity of the function ν_* we get

$$\nu_*(w) \cdot N^{z_2 - w} \geqslant \nu_*(z_1) \geqslant \nu_{**}(z_1).$$

Therefore, $\nu_{**}(z_2) \geqslant \nu_{**}(z_1)$.

Now we prove that

$$\frac{\nu_{**}(z_2)}{\nu_{**}(z_1)} \leqslant N^{z_2 - z_1}, \quad z_1, \ z_2 \in Z, \quad z_1 \leqslant z_2. \tag{70}$$

This yields (65). For every $w \leq z_1$ we have

$$\nu_{**}(z_2) \leqslant \nu_{*}(w) \cdot N^{z_2-w} = \nu_{*}(w) \cdot N^{z_1-w} \cdot N^{z_2-z_1};$$

taking infimum over $w \leq z_1$, we get (70).

Now we show that

$$\bigcap_{z \in Z} \nu_{**}(z) B_{1/z}^N = \bigcap_{z \in Z} \nu_*(z) B_{1/z}^N. \tag{71}$$

By (69), it suffices to check that for every $w \in Z$

$$\nu_{**}(w)B_{1/w}^N \supset \bigcap_{z \in Z} \nu_*(z)B_{1/z}^N. \tag{72}$$

Let $w_n \leq w$, $\nu_*(w_n) \cdot N^{w-w_n} \underset{n \to \infty}{\longrightarrow} \nu_{**}(w)$. Then

$$\nu_{**}(w)B_{1/w}^{N} \supset \bigcap_{n \in \mathbb{N}} \nu_{*}(w_{n})N^{w-w_{n}}B_{1/w}^{N} \supset \bigcap_{n \in \mathbb{N}} \nu_{*}(w_{n})B_{1/w_{n}}^{N}$$

Hence, we obtain (72).

Now, (67) and (71) imply (66).
