DOUBLY COMMUTING MIXED INVARIANT SUBSPACES IN THE POLYDISC

ABSTRACT. We obtain a complete characterization for doubly commuting mixed invariant subspaces of the Hardy space over the unit polydisc. We say a closed subspace \mathcal{Q} of $H^2(\mathbb{D}^n)$ is mixed invariant if $M_{z_j}(\mathcal{Q}) \subseteq \mathcal{Q}$ for $1 \leq j \leq k$ and $M^*_{z_j}(\mathcal{Q}) \subseteq \mathcal{Q}$, $k+1 \leq j \leq n$ for some integer $k \in \{1, 2, \ldots, n-1\}$. We prove that a mixed invariant subspace \mathcal{Q} of $H^2(\mathbb{D}^n)$ is doubly commuting if and only if

$$\mathcal{Q} = \Theta H^2(\mathbb{D}^k) \otimes \mathcal{Q}_{\theta_1} \otimes \cdots \otimes \mathcal{Q}_{\theta_{n-k}},$$

where $\Theta \in H^{\infty}(\mathbb{D}^k)$ is some inner function and \mathcal{Q}_{θ_j} is either a Jordan block $H^2(\mathbb{D}) \ominus \theta_j H^2(\mathbb{D})$ for some inner function θ_j or the Hardy space $H^2(\mathbb{D})$. Furthermore, an explicit representation for the commutant of an *n*-tuple of doubly commuting shifts as well as a representation for the commutant of a doubly commuting tuple of shifts and co-shifts are obtained. Finally, we discuss some concrete examples of *mixed invariant* subspaces.

1. INTRODUCTION

The celebrated Beurling theorem (see [4]) gives the structure of shift invariant subspaces in the Hardy space $H^2(\mathbb{D})$ over the unit disc: A non-zero closed subspace \mathcal{S} of $H^2(\mathbb{D})$ is invariant for M_z if and only if there exists an inner function $\theta \in H^\infty(\mathbb{D})$ such that

$$\mathcal{S} = \theta H^2(\mathbb{D}).$$

In particular, we can represent \mathcal{S} as

$$\mathcal{S} = \bigoplus_{m=0}^{\infty} z^m (\mathcal{S} \ominus z\mathcal{S}).$$

A proper closed subspace \mathcal{Q} of $H^2(\mathbb{D})$ is said to be a Jordan block of $H^2(\mathbb{D})$ if \mathcal{Q} is M_z^* -invariant. Now \mathcal{Q} is M_z^* -invariant if and only if \mathcal{Q}^{\perp} is M_z -invariant. Thus by Beurling's theorem, there exists an inner function $\theta \in H^{\infty}(\mathbb{D})$ such that $\mathcal{Q}^{\perp} = \theta H^2(\mathbb{D})$. Therefore the Jordan block of $H^2(\mathbb{D})$ is determined by θ and is given by $\mathcal{Q}_{\theta} = H^2(\mathbb{D}) \ominus \theta H^2(\mathbb{D})$.

Now we are going to define Jordan block of the Hardy space over the unit polydisc. It is well known that the *n*-tuple of multiplication operators $(M_{z_1}, \ldots, M_{z_n})$ on the Hardy space $H^2(\mathbb{D}^n)$, n > 1 over the unit polydisc is doubly commuting. A proper closed subspace \mathcal{Q} of $H^2(\mathbb{D}^n)$ is said to be a Jordan block of $H^2(\mathbb{D}^n)$, n > 1 if \mathcal{Q} is invariant under the adjoint of $(M_{z_1}, \ldots, M_{z_n})$ and the *n*-tuple $(P_{\mathcal{Q}}M_{z_1}|_{\mathcal{Q}}, \ldots, P_{\mathcal{Q}}M_{z_n}|_{\mathcal{Q}})$ is doubly commuting. Firstly,

Douglas and Yang (see [9], [10]) started the study of Jordan block of the Hardy space $H^2(\mathbb{D}^2)$ over the bidisc. After that, Izuchi, Nakazi and Seto [20] classified the Jordan block of $H^2(\mathbb{D}^2)$. Recently, J. Sarkar [25] has given a complete characterization of the Jordan block of $H^2(\mathbb{D}^n)$: A subspace \mathcal{Q} of $H^2(\mathbb{D}^n)$ is a Jordan block if and only if $\mathcal{Q} = \mathcal{Q}_{\theta_1} \otimes \cdots \otimes \mathcal{Q}_{\theta_n}$, where \mathcal{Q}_{θ_i} is a Jordan block of $H^2(\mathbb{D})$.

The structure of joint invariant subspaces in the Hardy space $H^2(\mathbb{D}^2)$ over the bidisc and in general the Hardy space over the polydisc $H^2(\mathbb{D}^n)$, n > 1 is very complex. That is because of the subtleties of theory of holomorphic functions in several variables as well as the difficulty associated with the structure of *n*-tuples, n > 1, of commuting isometries on Hilbert spaces. There are several mathematicians like Agrawal, Clark, and Douglas [1], Ahern and Clark [2], Guo [11, 12], Guo, Sun, Zheng and Zhong [13], Rudin [26], Izuchi [15], Mandrekar [23] etc. (also see [17, 16, 18, 6] and the references therein) have studied the structure of joint invariant subspaces. The four operators $R_{z_1}, R_{z_2}, C_{z_1}$, and C_{z_2} play an important role in finding the structure of (joint) invariant subspace \mathcal{S} of $H^2(\mathbb{D}^2)$, where $R_{z_1} = M_{z_1}|_{\mathcal{S}}$ and $R_{z_2} = M_{z_2}|_{\mathcal{S}}$, $C_{z_1} = P_{\mathcal{S}^{\perp}} M_{z_1}|_{\mathcal{S}^{\perp}}$, and $C_{z_2} = P_{\mathcal{S}^{\perp}} M_{z_2}|_{\mathcal{S}^{\perp}}$. For example, Mandrekar [23] showed that if the commutator $[R_{z_1}, R_{z_2}^*] = 0$, then $\mathcal{S} = \varphi H^2(\mathbb{D}^2)$ for some inner function $\varphi \in H^\infty(\mathbb{D}^2)$. Again if $[C_{z_1}, C_{z_2}^*] = 0$ or rank $[C_{z_1}, C_{z_2}^*] = 1$, then the structure of \mathcal{S} is known (see [20]). But for $\operatorname{rank}[C_{z_1}, C_{z_2}^*] > 1$, the structure of \mathcal{S} is not known. Motivated by the above fact, Izuchi et. al. (see [19]) firstly introduced the concept of mixed invariant subspaces of $H^2(\mathbb{D}^2)$: A closed subspace \mathcal{S} of $H^2(\mathbb{D}^2)$ is said to be *mixed invariant* if $M_{z_1}(\mathcal{S}) \subseteq \mathcal{S}$ and $M^*_{z_2}(\mathcal{S}) \subseteq \mathcal{S}$. Clearly, if \mathcal{S} is joint $(M_{z_1}, M_{z_2}^*)$ invariant, then $\mathcal{S}^{\perp} = H^2(\mathbb{D}^2) \ominus \mathcal{S}$ is again a joint $(\overline{M}_{z_1}^*, M_{z_2})$ invariant. Thus a natural question arises in the setting of the Hardy space over the unit polydisc:

What is the structure of doubly commuting mixed invariant subspaces of $H^2(\mathbb{D}^n)$, n > 1? More precisely, if a proper closed subspace \mathcal{Q} of $H^2(\mathbb{D}^n)$ for n > 1 is invariant under $(M_{z_1}, \ldots, M_{z_k}, M^*_{z_{k+1}}, \ldots, M^*_{z_n})$ and the *n*-tuple $(P_{\mathcal{Q}}M_{z_1}|_{\mathcal{Q}}, \ldots, P_{\mathcal{Q}}M_{z_n}|_{\mathcal{Q}})$ is doubly commuting, then what is the explicit structure of \mathcal{Q} ?

In this paper we will give a complete characterization of *doubly commuting mixed invariant* subspaces of $H^2(\mathbb{D}^n)$, n > 1. We also find an explicit representation for the commutant of an *n*-tuple of doubly commuting shifts. Moreover, a representation of a large class of bounded operators which intertwine with some doubly commuting shifts and co-shifts on the Hardy space over the polydisc is obtained.

This paper is organized as follows: In Section 2 we give some basic definitions and results on the Hardy space over the polydisc. In Section 3, we find an explicit representation for the commutant of an *n*-tuple of doubly commuting shifts and also a representation for the commutant of a doubly commuting tuple of shifts and co-shifts on the Hardy space over the polydisc. In Section 4, we completely classify *doubly commuting mixed invariant* subspaces of the Hardy spaces over the polydisc. Finally, we discuss some applications in Section 5.

2. Preliminaries

For $n \geq 1$, let $\mathbb{D}^n = \mathbb{D} \times \cdots \times \mathbb{D}$ be the open unit polydisc in \mathbb{C}^n . Throughout the paper we use the notation \boldsymbol{z} for the *n*-tuple (z_1, \ldots, z_n) in \mathbb{C}^n . Also for any multi-index $\boldsymbol{k} = (k_1, \ldots, k_n) \in \mathbb{Z}_+^n$ and $\boldsymbol{z} \in \mathbb{C}^n$, we write $\boldsymbol{z}^{\boldsymbol{k}} = z_1^{k_1} \cdots z_n^{k_n}$. Let \mathcal{H} and \mathcal{K} be two separable

complex Hilbert spaces. The set of all bounded linear operators from \mathcal{H} to \mathcal{K} is denoted by $\mathcal{B}(\mathcal{H},\mathcal{K})$. If $\mathcal{H} = \mathcal{K}$, then we shall denote it by $\mathcal{B}(\mathcal{H})$ instead of $\mathcal{B}(\mathcal{H},\mathcal{H})$. A contraction T on \mathcal{H} (that is, $||Th|| \leq ||h||$ for all $h \in \mathcal{H}$) is said to be a pure contraction if $T^{*m} \to 0$ as $m \to \infty$ in the strong operator topology. Also an isometry V on \mathcal{H} (that is, $V^*V = I_{\mathcal{H}}$) is said to be pure or shift if $V^{*m} \to 0$ as $m \to \infty$ in the strong operator topology (see [14], [24]).

The Hardy space $H^2(\mathbb{D}^n)$ over the polydisc \mathbb{D}^n is the Hilbert space of all holomorphic functions f on \mathbb{D}^n such that

$$||f||_{H^2(\mathbb{D}^n)} = \left(\sup_{0 \le r < 1} \int_{\mathbb{T}^n} |f(re^{i\theta_1}, \dots, re^{i\theta_n})|^2 \ d\theta\right)^{\frac{1}{2}} < \infty,$$

where $d\theta$ is the normalized Lebesgue measure on the *n*-dimensional torus \mathbb{T}^n , the distinguished boundary of \mathbb{D}^n . It is a well known and important reproducing kernel Hilbert space corresponding to the Szegö kernel \mathbb{S}_n on \mathbb{D}^n , where

$$\mathbb{S}_n(\boldsymbol{z}, \boldsymbol{w}) = \prod_{j=1}^n (1 - z_j \bar{w}_j)^{-1} \qquad (\boldsymbol{z}, \boldsymbol{w} \in \mathbb{D}^n).$$

Then one can see that

$$\mathbb{S}_n^{-1}(\boldsymbol{z}, \boldsymbol{w}) = \sum_{0 \le |\boldsymbol{k}| \le n} (-1)^{|\boldsymbol{k}|} \boldsymbol{z}^{\boldsymbol{k}} \bar{\boldsymbol{w}}^{\boldsymbol{k}},$$

where $|\mathbf{k}| = \sum_{j=1}^{n} k_j$ and $0 \le k_j \le 1$ for all $j = 1, \dots, n$.

We can extend this definition to a Hilbert space valued Hardy space also. Let \mathcal{E} be a Hilbert space, and the \mathcal{E} -valued Hardy space over \mathbb{D}^n be denoted by $H^2_{\mathcal{E}}(\mathbb{D}^n)$. Then $H^2_{\mathcal{E}}(\mathbb{D}^n)$ is the \mathcal{E} -valued reproducing kernel Hilbert space with the $\mathcal{B}(\mathcal{E})$ -valued kernel function

$$(\boldsymbol{z}, \boldsymbol{w}) \mapsto \mathbb{S}_n(\boldsymbol{z}, \boldsymbol{w}) I_{\mathcal{E}} \qquad (\boldsymbol{z}, \boldsymbol{w} \in \mathbb{D}^n).$$

In the sequel, we shall identify the vector valued Hardy space $H^2_{\mathcal{E}}(\mathbb{D}^n)$ with $H^2(\mathbb{D}^n) \otimes \mathcal{E}$ by the help of the canonical unitary $U: H^2_{\mathcal{E}}(\mathbb{D}^n) \to H^2(\mathbb{D}^n) \otimes \mathcal{E}$ defined by

$$U(\boldsymbol{z}^{\boldsymbol{k}}\eta) = \boldsymbol{z}^{\boldsymbol{k}} \otimes \eta \qquad (\boldsymbol{k} \in \mathbb{Z}^n_+, \eta \in \mathcal{E}).$$

One can easily observe that the Hardy space $H^2(\mathbb{D}^n)$, n > 1 over the unit polydisc can be identified via the unitary map $U: H^2(\mathbb{D}^n) \to H^2(\mathbb{D}) \otimes \cdots \otimes H^2(\mathbb{D})$, where

$$U(z_1^{k_1}z_2^{k_2}\cdots z_n^{k_n})=z^{k_1}\otimes z^{k_2}\otimes \cdots \otimes z^{k_n},$$

with the *n*-fold Hilbert space tensor product of the Hardy space $H^2(\mathbb{D})$ on the unit disc. Also we can realize $H^2(\mathbb{D}) \otimes \cdots \otimes H^2(\mathbb{D})$ as the vector-valued Hardy space $H^2_{H^2(\mathbb{D}^{n-1})}(\mathbb{D})$ over the unit disc. This identification will be helpful to understand the structure of invariant subspaces of $H^2(\mathbb{D}^n)$.

Let $(M_{z_1}, \ldots, M_{z_n})$ denote the *n*-tuple of multiplication operators on $H^2_{\mathcal{E}}(\mathbb{D}^n)$ by the coordinate functions $\{z_j\}_{j=1}^n$, that is,

$$(M_{z_j}f)(\boldsymbol{w}) = w_j f(\boldsymbol{w}),$$

for all $f \in H^2_{\mathcal{E}}(\mathbb{D}^n)$, $\boldsymbol{w} \in \mathbb{D}^n$ and j = 1, ..., n. It is easy to see that $(M_{z_1}, ..., M_{z_n})$ is an *n*-tuple of *doubly commuting* shifts on $H^2_{\mathcal{E}}(\mathbb{D}^n)$. Evidently, the shift M_{z_i} on $H^2_{\mathcal{E}}(\mathbb{D}^n)$ can be

identified with $M_{z_j} \otimes I_{\mathcal{E}}$ on $H^2(\mathbb{D}^n) \otimes \mathcal{E}$ for $j = 1, \ldots, n$. This canonical identification will be used throughout the paper. We recall that a closed subspace \mathcal{S} of $H^2_{\mathcal{E}}(\mathbb{D}^n)$ is called an invariant subspace for $(M_{z_1}, \ldots, M_{z_n})$ if $M_{z_j}(\mathcal{S}) \subseteq \mathcal{S}$ for all $j = 1, \ldots, n$. Let I be any nonempty and proper subset of $\{1, 2, \ldots, n\}$. We say a closed subspace \mathcal{Q} of $H^2(\mathbb{D}^n)$ is mixed invariant if $M_{z_j}(\mathcal{Q}) \subseteq \mathcal{Q}$ for $j \in I$, and $M^*_{z_j}(\mathcal{Q}) \subseteq \mathcal{Q}$ for $j \in I^c$. Without loss of generality, we say that \mathcal{Q} is mixed invariant under the multiplication operators $(M_{z_1}, \ldots, M_{z_n})$ if $M_{z_j}(\mathcal{Q}) \subseteq \mathcal{Q}$ for $1 \leq j \leq k$ and $M^*_{z_j}(\mathcal{Q}) \subseteq \mathcal{Q}$, $k + 1 \leq j \leq n$ for some integer $k \in \{1, \ldots, n-1\}$. In addition, \mathcal{Q} is said to be doubly commuting mixed invariant if the n-tuple $(P_{\mathcal{Q}}M_{z_1}|_{\mathcal{Q}}, \ldots, P_{\mathcal{Q}}M_{z_n}|_{\mathcal{Q}})$ is doubly commuting. We denote $H^{\infty}_{\mathcal{B}(\mathcal{E})}(\mathbb{D})$ as the Banach algebra of all $\mathcal{B}(\mathcal{E})$ -valued bounded analytic functions on the open unit disc \mathbb{D} (see [24]).

3. Commutant of a doubly commuting shifts

In this section we obtain an explicit representation of the commutant of an *n*-tuple of doubly commuting shifts. We also find a representation of a large class of bounded operators which intertwine with shifts and adjoint of shifts, that is, co-shifts. As a by-product we give some examples of *mixed invariant* subspaces in the Hardy space over the polydisc.

Let m, n be positive integers. For the sake of simplicity we denote $H^2(\mathbb{D}^m)$ by H_m . Here we use a similar technique used in our earlier paper (see [21]). We firstly denote z_j as the coordinate function on $H^2(\mathbb{D}^n)$ for j = 1, ..., n and w_i as the coordinate function on H_m for i = 1, ..., m. We then identify the Hardy space $H^2(\mathbb{D}^{n+m})$ as H_m -valued Hardy space $H^2_{H_m}(\mathbb{D}^n)$ over \mathbb{D}^n via canonical unitary. With this identification the multiplication operators $(M_{z_1}, ..., M_{z_n}, ..., M_{z_{n+m}})$ on $H^2(\mathbb{D}^{n+m})$ can be represented by $(M_{z_1}, ..., M_{z_n}, M_{\kappa_1}, ..., M_{\kappa_m})$ on $H^2_{H_m}(\mathbb{D}^n)$, where κ_i is defined by

$$\kappa_i(\boldsymbol{z}) = M_{w_i},$$

for all $\boldsymbol{z} \in \mathbb{D}^n$. It is evident that $\kappa_i \in H^{\infty}_{\mathcal{B}(H_m)}(\mathbb{D}^n)$ is a constant function and the multiplication operator M_{κ_i} on $H^2_{H_m}(\mathbb{D}^n)$ is defined by

$$M_{\kappa_i}f = \kappa_i f \qquad (f \in H^2_{H_m}(\mathbb{D}^n)),$$

is a shift on $H^2_{H_m}(\mathbb{D}^n)$ for all $i = 1, \ldots, m$.

We now identify $H^2(\mathbb{D}^{n+m})$ with $H^2(\mathbb{D}^n) \otimes H_m$ by the canonical unitary map $\hat{U} : H^2(\mathbb{D}^{n+m}) \to H^2(\mathbb{D}^n) \otimes H_m$ defined by

$$\hat{U}(z_1^{k_1}\cdots z_n^{k_n}\cdots z_{n+m}^{k_{n+m}}) = (z_1^{k_1}\cdots z_n^{k_n}) \otimes (w_1^{k_{n+1}}\cdots w_m^{k_{n+m}}),$$

for all $k_1, \ldots, k_{n+m} \ge 0$. Then one can easily see that

$$\hat{U}M_{z_j} = (M_{z_j} \otimes I_{H_m})\hat{U} \qquad (j = 1, \dots, n)$$

and

$$\hat{U}M_{z_{n+i}} = (I_{H^2(\mathbb{D}^n)} \otimes K_i)\hat{U} \qquad (i = 1, \dots, m),$$

where $K_i = M_{w_i}$. Thus the (n + m)-tuples $(M_{z_1}, \ldots, M_{z_n}, \ldots, M_{z_{n+m}})$ on $H^2(\mathbb{D}^{n+m})$ and $(M_{z_1} \otimes I_{H_m}, \ldots, M_{z_n} \otimes I_{H_m}, I_{H^2(\mathbb{D}^n)} \otimes K_1, \ldots, I_{H^2(\mathbb{D}^n)} \otimes K_m)$ on $H^2(\mathbb{D}^n) \otimes H_m$ are unitarily equivalent.

We now define a unitary map $\tilde{U}: H^2(\mathbb{D}^n) \otimes H_m \to H^2_{H_m}(\mathbb{D}^n)$

 $\tilde{U}(z_1^{k_1}\cdots z_n^{k_n}\otimes f)=z_1^{k_1}\cdots z_n^{k_n}f,$

for all $k_j \ge 0$ and $f \in H_m$. Then

$$\tilde{U}(M_{z_j} \otimes I_{H_m}) = M_{z_j}\tilde{U} \qquad (j = 1, \dots, n).$$

For $\kappa_i \in H^{\infty}_{\mathcal{B}(H_m)}(\mathbb{D}^n)$, and each operator $M_{\kappa_i} : H^2_{H_m}(\mathbb{D}^n) \to H^2_{H_m}(\mathbb{D}^n)$ defined by

$$(M_{\kappa_i}(z_1^{k_1}\cdots z_n^{k_n}f))(\boldsymbol{x})=x_1^{k_1}\cdots x_n^{k_n}(K_if),$$

for all $k_j \ge 0$, $f \in H_m$ and $\boldsymbol{x} = (x_1, \ldots, x_n) \in \mathbb{D}^n$, is a shift on $H^2_{H_m}(\mathbb{D}^n)$. It also follows that

$$U(I_{H^2(\mathbb{D}^n)} \otimes K_i) = M_{\kappa_i} U.$$

Therefore by setting $U = \tilde{U}\hat{U}$, we see that $U : H^2(\mathbb{D}^{n+m}) \to H^2_{H_m}(\mathbb{D}^n)$ is a unitary operator satisfying

$$UM_{z_i} = M_{z_i}U_i$$

and

$$UM_{z_{n+i}} = M_{\kappa_i}U,$$

for all j = 1, ..., n and i = 1, ..., m.

To summarize this, we have the following:

Theorem 3.1. Let m, n be positive integers and $H^2(\mathbb{D}^{n+m})$ be the Hardy space over the unit polydisc \mathbb{D}^{n+m} . Then the (n+m)-tuples of multiplication operators $(M_{z_1}, \ldots, M_{z_n}, \ldots, M_{z_{n+m}})$ on $H^2(\mathbb{D}^{n+m})$ and $(M_{z_1}, \ldots, M_{z_n}, M_{\kappa_1}, \ldots, M_{\kappa_m})$ on $H^2_{H_m}(\mathbb{D}^n)$ are unitarily equivalent, where $\kappa_i \in H^{\infty}_{\mathcal{B}(H_m)}(\mathbb{D}^n)$ is the constant function defined by

$$\kappa_i(\boldsymbol{z}) = M_{w_i} \in \mathcal{B}(H_m),$$

for all $\boldsymbol{z} \in \mathbb{D}^n$ and $i = 1, \ldots, m$.

We now return to the representation of the commutant for a tuple of doubly commuting shifts. Let *n* be a fixed positive integer. Recall that for $\boldsymbol{z} = (z_1, \ldots, z_n) \in \mathbb{C}^n$ and for any multi-index $\boldsymbol{k} = (k_1, \ldots, k_n) \in \mathbb{Z}_+^n$, we write $\boldsymbol{z}^{\boldsymbol{k}} = z_1^{k_1} \cdots z_n^{k_n}$. Also for an *n*-tuple of commuting shifts $V = (V_1, \ldots, V_n)$, $V^{\boldsymbol{k}}$ denotes $V_1^{k_1} \ldots V_n^{k_n}$. It is also well known (see [7]) that if $V = (V_1, \ldots, V_n)$ is an *n*-tuple of doubly commuting shifts on a Hilbert space \mathcal{H} , then

$$\mathcal{H} = \bigoplus_{k \in \mathbb{Z}^n_+} V^k \mathcal{W}_{+}$$

where $\mathcal{W} = \bigcap_{j=1}^n Ker(V_j^*)$. We now define a map $\Pi : \mathcal{H} \to H^2_{\mathcal{W}}(\mathbb{D}^n)$ by

(3.1) $\Pi(V_1^{k_1}\cdots V_n^{k_n}\eta) = z_1^{k_1}\cdots z_n^{k_n}\eta \qquad (k_j \ge 0, \eta \in \mathcal{W}).$

Then Π is clearly a unitary. Moreover,

$$\Pi V_j = M_{z_j} \Pi \quad \text{for } j = 1, \dots, n$$

It is well known that if a bounded operator $X \in \mathcal{B}(H^2_{\mathcal{E}}(\mathbb{D}^n))$ commutes with the multiplication operators $(M_{z_1}, \ldots, M_{z_n})$ on $H^2_{\mathcal{E}}(\mathbb{D}^n)$, i.e., $XM_{z_j} = M_{z_j}X$ for all $1 \leq j \leq n$, then $X = M_{\Theta}$ for some $\Theta \in H^{\infty}_{\mathcal{B}(\mathcal{E})}(\mathbb{D}^n)$ (see [3]). These are called analytic Toeplitz operators which is an

important class of operators. Also the commutant of $V = (V_1, \ldots, V_n)$ on \mathcal{H} can be represented as the commutant of $(M_{z_1}, \ldots, M_{z_n})$ on $H^2_{\mathcal{W}}(\mathbb{D}^n)$. Hence the commutant of $V = (V_1, \ldots, V_n)$ on \mathcal{H} can be written as the form M_{Φ} on $H^2_{\mathcal{W}}(\mathbb{D}^n)$, where $\Phi \in H^{\infty}_{\mathcal{B}(\mathcal{W})}(\mathbb{D}^n)$. The question is what is the explicit representation of Φ ? Here we have the following result.

Lemma 3.2. Let \mathcal{H} be a Hilbert space and $V = (V_1, \ldots, V_n)$ be an n-tuple of doubly commuting shifts on \mathcal{H} . Let $T \in \mathcal{B}(\mathcal{H})$ and let Π be the above unitary defined in (3.1). Then

 $TV_j = V_j T$ for all $j = 1, \ldots, n$

if and only if $\Pi T \Pi^* = M_{\Phi}$ for some $\Phi \in H^{\infty}_{\mathcal{B}(\mathcal{W})}(\mathbb{D}^n)$ and

$$\Phi(\boldsymbol{z}) = P_{\mathcal{W}}(I_{\mathcal{H}} - z_1 V_1^*)^{-1} \dots (I_{\mathcal{H}} - z_n V_n^*)^{-1} T \mid_{\mathcal{W}},$$

where $\boldsymbol{z} = (z_1, \ldots, z_n) \in \mathbb{D}^n, \ \mathcal{W} = \bigcap_{j=1}^n Ker(V_j^*).$

Proof. Let $h \in \mathcal{H}$. Then h can be written as

$$h = \sum_{k} V^{k} \eta_{k},$$

for some $\eta_{k} \in \mathcal{W}$, $k = (k_{1}, \ldots, k_{n}) \in \mathbb{Z}_{+}^{n}$ (as $\mathcal{H} = \bigoplus_{k \in \mathbb{Z}_{+}^{n}} V^{k} \mathcal{W}$). Applying $P_{\mathcal{W}} V^{*m}$ to both sides and since $\mathcal{W} = \bigcap_{j=1}^{n} Ker(V_{j}^{*})$, we have $\eta_{m} = P_{\mathcal{W}} V^{*m} h$ for all $m = (m_{1}, \ldots, m_{n}) \in \mathbb{Z}_{+}^{n}$. Therefore, for any $h \in \mathcal{H}$,

(3.2)
$$h = \sum_{k} V^{k} P_{\mathcal{W}} V^{*k} h$$

Now let $TV_j = V_jT$ for all j = 1, ..., n. Then there exists a bounded analytic function $\Phi \in H^{\infty}_{\mathcal{B}(\mathcal{W})}(\mathbb{D}^n)$ such that $\Pi T \Pi^* = M_{\Phi}$. For each $\boldsymbol{w} = (w_1, ..., w_n) \in \mathbb{D}^n$ and $\eta \in \mathcal{W}$ we have

$$\Phi(\boldsymbol{w})\eta = (M_{\Phi}\eta)(\boldsymbol{w})$$
$$= (\Pi T\Pi^*\eta)(\boldsymbol{w})$$
$$= (\Pi T\eta)(\boldsymbol{w}),$$

as $\Pi^* \eta = \eta$. Using (3.2), we have

$$T\eta = \sum_{k} V^{k} P_{\mathcal{W}} V^{*k} T\eta,$$

it follows that

$$\Phi(\boldsymbol{w})\eta = (\Pi \left[\sum_{\boldsymbol{k}} V^{\boldsymbol{k}} P_{\mathcal{W}} V^{*\boldsymbol{k}} T\eta\right])(\boldsymbol{w})$$

$$= \left[\sum_{\boldsymbol{k}} M_{\boldsymbol{z}}^{\boldsymbol{k}} P_{\mathcal{W}} V^{*\boldsymbol{k}} T\eta\right](\boldsymbol{w})$$

$$= \left[\sum_{\boldsymbol{k}} \boldsymbol{w}^{\boldsymbol{k}} P_{\mathcal{W}} V^{*\boldsymbol{k}} T\eta\right]$$

$$= P_{\mathcal{W}} \left[\sum_{\boldsymbol{k}} \boldsymbol{w}^{\boldsymbol{k}} V^{*\boldsymbol{k}} T\eta\right]$$

$$= P_{\mathcal{W}} (I_{\mathcal{H}} - w_1 V_1^*)^{-1} \cdots (I_{\mathcal{H}} - w_n V_n^*)^{-1} T\eta.$$

Therefore

$$\Phi(\boldsymbol{z}) = P_{\mathcal{W}}(I_{\mathcal{H}} - z_1 V_1^*)^{-1} \cdots (I_{\mathcal{H}} - z_n V_n^*)^{-1} T|_{\mathcal{W}} \qquad (\boldsymbol{z} \in \mathbb{D}^n),$$

as required. We omit the sufficient part as it holds trivially.

This completes the proof.

REMARK 3.1. In the proof we have used the standard projection formula $I_{\mathcal{H}} = \text{SOT} - \sum_{k} V^{k} P_{\mathcal{W}} V^{*k}$.

Note that the function Φ defined in Lemma 3.2 is well defined and a $\mathcal{B}(\mathcal{W})$ -valued holomorphic function in the unit polydisc \mathbb{D}^n as $||w_j V_j^*|| = |w_j| ||V_j|| < 1$ for all $w_j \in \mathbb{D}$. Now if T commutes with a shift V_1 , then from the above result, we have the representation

 $\Phi(z) = P_{\mathcal{W}}(I_{\mathcal{H}} - zV_1^*)^{-1}T|_{\mathcal{W}} \qquad (z \in \mathbb{D}, \mathcal{W} = Ker(V_1^*))$

which was obtained in our previous paper [22].

We are now in a position to find the explicit representation of the commutant of a tuple of doubly commuting shifts and co-shifts.

Theorem 3.3. Let T be a bounded linear operator on $H^2_{H_m}(\mathbb{D}^n)$. Then T satisfies

$$TM_{z_j} = M_{z_j}T$$
 for $j = 1, \ldots, n$

and

$$TM_{\kappa_i}^* = M_{\kappa_i}^*T$$
 for $i = 1, ..., m$
if and only if $T = M_{\Phi}$, where $\Phi \in H_{\mathcal{B}(H_m)}^{\infty}(\mathbb{D}^n)$ and

$$\Phi(\boldsymbol{z}) = \sum_{\boldsymbol{k} \in \mathbb{Z}_+^n} M_{\Theta_{\boldsymbol{k}}}^* \boldsymbol{z}^{\boldsymbol{k}},$$

and

$$\Theta_{\boldsymbol{k}}(\boldsymbol{w}) = \sum_{\boldsymbol{l} \in \mathbb{Z}_{+}^{m}} \langle M_{\boldsymbol{z}}^{\boldsymbol{k}} \boldsymbol{1}, T \boldsymbol{w}^{\boldsymbol{l}} \rangle_{H^{2}_{H_{m}}(\mathbb{D}^{n})} \boldsymbol{w}^{\boldsymbol{l}}$$

for all $\boldsymbol{z} = (z_1, \ldots, z_n) \in \mathbb{D}^n$, $\boldsymbol{w} = (w_1, \ldots, w_m) \in \mathbb{D}^m$.

Proof. Suppose that T is a bounded linear operator on $H^2_{H_m}(\mathbb{D}^n)$ satisfying

 $TM_{z_j} = M_{z_j}T$ for $j = 1, \dots, n$

and

$$TM_{\kappa_i}^* = M_{\kappa_i}^*T$$
 for $i = 1, \dots, m_i$

From the first identity, we have $T = M_{\Phi}$, where $\Phi \in H^{\infty}_{\mathcal{B}(H_m)}(\mathbb{D}^n)$. Let

$$\Phi(\boldsymbol{z}) = \sum_{\boldsymbol{k}} T_{\boldsymbol{k}} \boldsymbol{z}^{\boldsymbol{k}} \quad (\boldsymbol{z} \in \mathbb{D}^n, \ T_{\boldsymbol{k}} \in \mathcal{B}(H_m)).$$

Now $H^2_{H_m}(\mathbb{D}^n) = \overline{\operatorname{span}}\{\boldsymbol{z}^{\boldsymbol{k}}\boldsymbol{w}^{\boldsymbol{l}}: \boldsymbol{k} \in \mathbb{Z}^n_+, \ \boldsymbol{l} \in \mathbb{Z}^m_+\}$. Since T satisfies

$$TM_{\kappa_i}^* = M_{\kappa_i}^*T \quad \text{for } i = 1, \dots, m,$$

we have

$$TM_{\kappa_i}^*(\boldsymbol{w}^r) = TM_{\kappa_i}^*(\boldsymbol{w}^r \boldsymbol{z}^0) = (\sum_{\boldsymbol{k}} T_{\boldsymbol{k}} \boldsymbol{z}^{\boldsymbol{k}}) M_{w_i}^*(\boldsymbol{w}^r)$$
$$= \sum_{\boldsymbol{k}} (T_{\boldsymbol{k}} M_{w_i}^*(\boldsymbol{w}^r)) \boldsymbol{z}^{\boldsymbol{k}}$$

and

$$M_{\kappa_i}^*T(\boldsymbol{w}^r) = M_{\kappa_i}^*(\sum_{\boldsymbol{k}} T_{\boldsymbol{k}} \boldsymbol{z}^{\boldsymbol{k}})(\boldsymbol{w}^r) = \sum_{\boldsymbol{k}} (M_{w_i}^* T_{\boldsymbol{k}}(\boldsymbol{w}^r)) \boldsymbol{z}^{\boldsymbol{k}}.$$

From the above we have,

$$T_{\boldsymbol{k}}M_{w_i}^*(\boldsymbol{w^r}) = M_{w_i}^*T_{\boldsymbol{k}}(\boldsymbol{w^r})$$

for all $\boldsymbol{w} = (w_1, \dots, w_m) \in \mathbb{D}^m$ and $\boldsymbol{k} \in \mathbb{Z}_+^n$. Therefore

$$T_{k}M_{w_{i}}^{*} = M_{w_{i}}^{*}T_{k}$$
 i.e., $M_{w_{i}}T_{k}^{*} = T_{k}^{*}M_{w_{i}}$

for all $i = 1, \ldots, m$. Hence $T_{k}^{*} = M_{\Theta_{k}}$ for some $\Theta_{k} \in H^{\infty}(\mathbb{D}^{m})$ for all k. Therefore

$$\Phi(\boldsymbol{z}) = \sum_{\boldsymbol{k}} M^*_{\Theta_{\boldsymbol{k}}} \boldsymbol{z}^{\boldsymbol{k}} \quad (\boldsymbol{z} \in \mathbb{D}^n).$$

Now we will find $\Theta_{\mathbf{k}} \in H^{\infty}(\mathbb{D}^m)$ explicitly: We know in view of Lemma 3.2 that

$$\Phi(\boldsymbol{z}) = \sum_{\boldsymbol{k}} (P_{H_m} M_{\boldsymbol{z}}^{*\boldsymbol{k}} T \mid_{H_m}) \boldsymbol{z}^{\boldsymbol{k}}.$$

Hence

$$M_{\Theta_k}^* = P_{H_m} M_{\boldsymbol{z}}^{*\boldsymbol{k}} T \mid_{H_m},$$

for all \boldsymbol{k} . We shall now calculate each $\Theta_{\boldsymbol{k}} \in H^{\infty}(\mathbb{D}^m)$. Suppose $\Theta_{\boldsymbol{k}}(\boldsymbol{w}) = \sum_{\boldsymbol{l}} a_{\boldsymbol{l}} \boldsymbol{w}^{\boldsymbol{l}}$. Then

$$\langle (\sum_{\boldsymbol{l}} a_{\boldsymbol{l}} \boldsymbol{w}^{\boldsymbol{l}}) \mathbf{1}, \boldsymbol{w}^{\boldsymbol{r}} \rangle_{H^{2}(\mathbb{D}^{m})} = \langle M_{\Theta_{\boldsymbol{k}}} \mathbf{1}, \boldsymbol{w}^{\boldsymbol{r}} \rangle_{H^{2}(\mathbb{D}^{m})}$$

$$= \langle \mathbf{1}, M_{\Theta_{\boldsymbol{k}}}^{*} \boldsymbol{w}^{\boldsymbol{r}} \rangle_{H^{2}(\mathbb{D}^{m})}$$

$$= \langle \mathbf{1}, P_{H_{m}} M_{\boldsymbol{z}}^{*k} T \boldsymbol{w}^{\boldsymbol{r}} \rangle_{H^{2}(\mathbb{D}^{m})}$$

$$= \langle M_{\boldsymbol{z}}^{k} \mathbf{1}, T \boldsymbol{w}^{\boldsymbol{r}} \rangle_{H^{2}_{H_{m}}(\mathbb{D}^{n})}.$$

Since $\langle \boldsymbol{w}^{\boldsymbol{l}}, \boldsymbol{w}^{\boldsymbol{r}} \rangle = 0$ for $\boldsymbol{l} \neq \boldsymbol{r}$ and $\boldsymbol{w}^0 = \boldsymbol{1}$, a constant function on $H^2(\mathbb{D}^m)$, from the above we have $a_{\boldsymbol{r}} = \langle M_{\boldsymbol{z}}^{\boldsymbol{k}} \boldsymbol{1}, T \boldsymbol{w}^{\boldsymbol{r}} \rangle_{H^2_{H_m}(\mathbb{D}^n)}$ for all $\boldsymbol{r} \in \mathbb{Z}_+^m$. Thus

$$\Phi(\boldsymbol{z}) = \sum_{\boldsymbol{k}} M^*_{\Theta_{\boldsymbol{k}}} \boldsymbol{z}^{\boldsymbol{k}} \quad (\boldsymbol{z} \in \mathbb{D}^n).$$

where

$$\Theta_{\boldsymbol{k}}(\boldsymbol{w}) = \sum_{\boldsymbol{l}} \langle M_{\boldsymbol{z}}^{\boldsymbol{k}} \boldsymbol{1}, T \boldsymbol{w}^{\boldsymbol{l}} \rangle_{H^{2}_{H_{m}}(\mathbb{D}^{n})} \boldsymbol{w}^{\boldsymbol{l}}.$$

The converse follows easily. This finishes the proof.

We know that if $T \in \mathcal{B}(H^2(\mathbb{D}))$ such that $TM_z = M_zT$, then $\overline{ran}(T)$ is an M_z -invariant subspace of $H^2(\mathbb{D})$. In other words, for any $\varphi \in H^{\infty}(\mathbb{D})$, $\overline{ran}(M_{\varphi})$ is an M_z -invariant subspace of $H^2(\mathbb{D})$. Similarly let $T \in \mathcal{B}(H^2(\mathbb{D}^{n+m}))$. Suppose that

$$TM_{z_j} = M_{z_j}T$$
 and $TM^*_{z_{n+i}} = M^*_{z_{n+i}}T$,

for j = 1, ..., n and i = 1, ..., m. Then $\overline{ran}(T)$ is invariant under $(M_{z_1}, ..., M_{z_n}, M^*_{z_{n+1}}, ..., M^*_{z_{n+m}})$ on $H^2(\mathbb{D}^{n+m})$. Thus from the above theorem, we can readily find some examples of *mixed invariant* subspaces.

COROLLARY 3.2. Let $T \in \mathcal{B}(H^2_{H_m}(\mathbb{D}^n))$. Then $\overline{ran}(T)$ is a mixed invariant subspace under $(M_{z_1}, \ldots, M_{z_n}, M^*_{\kappa_1}, \ldots, M^*_{\kappa_m})$ if $T = M_{\Phi}$, where $\Phi \in H^{\infty}_{\mathcal{B}(H_m)}(\mathbb{D}^n)$ is given by

$$\Phi(\boldsymbol{z}) = \sum_{\boldsymbol{k} \in \mathbb{Z}_+^n} M_{\Theta_{\boldsymbol{k}}}^* \boldsymbol{z}^{\boldsymbol{k}},$$

and

$$\Theta_{\boldsymbol{k}}(\boldsymbol{w}) = \sum_{\boldsymbol{l} \in \mathbb{Z}_{+}^{m}} \langle M_{\boldsymbol{z}}^{\boldsymbol{k}} \boldsymbol{1}, T \boldsymbol{w}^{\boldsymbol{l}} \rangle_{H^{2}_{H_{m}}(\mathbb{D}^{n})} \boldsymbol{w}^{\boldsymbol{l}}$$

for all $\boldsymbol{z} = (z_1, \ldots, z_n) \in \mathbb{D}^n$ and $\boldsymbol{w} = (w_1, \ldots, w_m) \in \mathbb{D}^m$.

4. Doubly commuting mixed invariant subspaces

In this section we obtain an explicit representation of *doubly commuting mixed invariant* subspaces. We start with a known result (see ([21]) for more details).

Lemma 4.1. Let \mathcal{F} and \mathcal{E} be Hilbert spaces and $M_{\Phi} : H^2_{\mathcal{F}}(\mathbb{D}^n) \to H^2_{\mathcal{E}}(\mathbb{D}^n)$ be an isometric multiplier. Then dim $(\mathcal{F}) \leq \dim(\mathcal{E})$.

The following result is required to prove our main results. The idea of the proof comes from a paper of Douglas and Foias [8]. This result may be known to the experts but here our proof is direct and it is useful as an independent result.

Lemma 4.2. Let $\mathcal{Q} \subseteq H^2_{\mathcal{E}}(\mathbb{D}^n)$ be an $M^*_{z_j}$ -invariant subspace for all $j = 1, 2, \cdots, n$ and $T : \mathcal{Q} \to H^2(\mathbb{D}^n)$ be an isometry such that $TM^*_{z_j}|_{\mathcal{Q}} = M^*_{z_j}T$ for all $j = 1, 2, \cdots, n$. Then there exists a one dimensional Hilbert space $\tilde{\mathcal{E}}$, a subspace of \mathcal{E} such that $\mathcal{Q} \subseteq H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^n)$ and a constant unitary multiplier $M_{\Theta} : H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^n) \to H^2(\mathbb{D}^n)$ such that $T = M_{\Theta}|_{\mathcal{Q}}$.

Proof. Since \mathcal{Q} is an $M^*_{z_i}$ -invariant subspace for all $j = 1, 2, \cdots, n$, the space

$$\mathcal{M} = \overline{span} \{ \boldsymbol{z}^{\boldsymbol{k}} \mathcal{Q} : \boldsymbol{k} \in \mathbb{Z}_{+}^n \}$$

is M_{z_j} -reducing subspace of $H^2_{\mathcal{E}}(\mathbb{D}^n)$ for all $j = 1, 2, \cdots, n$. We know that any $(M_{z_1}, M_{z_2}, \ldots, M_{z_n})$ reducing subspace of $H^2_{\mathcal{E}}(\mathbb{D}^n)$ is of the form $H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^n)$ for some closed subspace $\tilde{\mathcal{E}}$ of \mathcal{E} . Thus $\mathcal{M} = H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^n)$. Firstly, our aim is to extend the operator $T : \mathcal{Q} \to H^2(\mathbb{D}^n)$ to $\tilde{T} : H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^n) \to$ $H^2(\mathbb{D}^n)$ such that \tilde{T} is an isometry and $M^*_{z_j}\tilde{T} = \tilde{T}M^*_{z_j}$ for all $j = 1, 2, \cdots, n$.

It is easy to see that the set $\{\boldsymbol{z}^{\boldsymbol{k}}\eta: \boldsymbol{k}\in\mathbb{Z}^n_+, \eta\in\mathcal{Q}\}$ is a total set in $H^2_{\tilde{\varepsilon}}(\mathbb{D}^n)$. Consider

$$\mathcal{L} = \operatorname{span} \{ \boldsymbol{z}^{\boldsymbol{k}} \eta : \boldsymbol{k} \in \mathbb{Z}_{+}^{n}, \eta \in \mathcal{Q} \}.$$

Let F be a finite set in \mathbb{Z}^n_+ . We define \tilde{T} on \mathcal{L} as

$$\tilde{T}(\sum_{\boldsymbol{k}\in F}\alpha_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}\eta_{\boldsymbol{k}}) = \sum_{\boldsymbol{k}\in F}\alpha_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}T\eta_{\boldsymbol{k}},$$

where $\alpha_{k} \in \mathbb{C}$ and $\eta_{k} \in \mathcal{Q}$. We shall firstly show that the map \tilde{T} is well defined on \mathcal{L} . To do that we consider the following.

Let F_1, F_2 be two finite sets in \mathbb{Z}^n_+ , and $\eta_k, \zeta_m \in \mathcal{Q}$. Then

(4.1)
$$< \sum_{\boldsymbol{k}\in F_1} \alpha_{\boldsymbol{k}} \boldsymbol{z}^{\boldsymbol{k}} T \eta_{\boldsymbol{k}}, \sum_{\boldsymbol{m}\in F_2} \beta_{\boldsymbol{m}} \boldsymbol{z}^{\boldsymbol{m}} T \zeta_{\boldsymbol{m}} > = \sum_{\boldsymbol{k}\in F_1} \sum_{\boldsymbol{m}\in F_2} \alpha_{\boldsymbol{k}} \bar{\beta_{\boldsymbol{m}}} < \boldsymbol{z}^{\boldsymbol{k}} T \eta_{\boldsymbol{k}}, \boldsymbol{z}^{\boldsymbol{m}} T \zeta_{\boldsymbol{m}} > .$$

Now for each fixed $\mathbf{k} \in F_1$ and $\mathbf{m} \in F_2$, let $\mathbf{k} = (k_1, \ldots, k_n)$ and $\mathbf{m} = (m_1, \ldots, m_n)$. Consider $I = \{j \in \{1, \cdots, n\} : k_j \ge m_j\}$. Using the fact that $(M_{z_1}, \ldots, M_{z_n})$ is a tuple of doubly

commuting isometries and T is an isometry, we obtain

$$< \mathbf{z}^{k} T \eta_{k}, \mathbf{z}^{m} T \zeta_{m} > = < \prod_{j=1}^{n} M_{z_{j}}^{k_{j}} T \eta_{k}, \prod_{j=1}^{n} M_{z_{j}}^{m_{j}} T \zeta_{m} >$$

$$= < \prod_{j \in I} M_{z_{j}}^{k_{j}-m_{j}} T \eta_{k}, \prod_{j \in I^{c}} M_{z_{j}}^{m_{j}-k_{j}} T \zeta_{m} >$$

$$= < \prod_{j \in I^{c}} M_{z_{j}}^{*(m_{j}-k_{j})} T \eta_{k}, \prod_{j \in I} M_{z_{j}}^{*(k_{j}-m_{j})} T \zeta_{m} >$$

$$= < T \prod_{j \in I^{c}} M_{z_{j}}^{*(m_{j}-k_{j})} \eta_{k}, T \prod_{j \in I} M_{z_{j}}^{*(k_{j}-m_{j})} \zeta_{m} >$$

$$= < \prod_{j \in I^{c}} M_{z_{j}}^{*(m_{j}-k_{j})} \eta_{k}, \prod_{j \in I} M_{z_{j}}^{*(k_{j}-m_{j})} \zeta_{m} >$$

$$= < \prod_{j \in I} M_{z_{j}}^{(k_{j}-m_{j})} \eta_{k}, \prod_{j \in I} M_{z_{j}}^{(m_{j}-k_{j})} \zeta_{m} >$$

$$= < \prod_{j \in I} z_{j}^{m_{j}} \prod_{j \in I^{c}} z_{j}^{k_{j}} (\prod_{j \in I} z_{j}^{(k_{j}-m_{j})}) \eta_{k}, \prod_{j \in I} z_{j}^{m_{j}} \prod_{j \in I^{c}} z_{j}^{(m_{j}-k_{j})}) \zeta_{m} >$$

$$= < \mathbf{z}^{k} \eta_{k}, \mathbf{z}^{m} \zeta_{m} > .$$

Thus from the above equation (4.1), we have

$$<\sum_{\boldsymbol{k}\in F_1}\alpha_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}T\eta_{\boldsymbol{k}},\sum_{\boldsymbol{m}\in F_2}\beta_{\boldsymbol{m}}\boldsymbol{z}^{\boldsymbol{m}}T\zeta_{\boldsymbol{m}}>=<\sum_{\boldsymbol{k}\in F_1}\alpha_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}\eta_{\boldsymbol{k}},\sum_{\boldsymbol{m}\in F_2}\beta_{\boldsymbol{m}}\boldsymbol{z}^{\boldsymbol{m}}\zeta_{\boldsymbol{m}}>.$$

In particular for any finite set F in \mathbb{Z}^n_+ , we have

(4.2)
$$\|\sum_{\boldsymbol{k}\in F}\alpha_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}T\eta_{\boldsymbol{k}}\|^{2} = \|\sum_{\boldsymbol{k}\in F}\alpha_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}\eta_{\boldsymbol{k}}\|^{2}$$

Suppose that

$$\sum_{\boldsymbol{k}\in F_1} \alpha_{\boldsymbol{k}} \boldsymbol{z}^{\boldsymbol{k}} \eta_{\boldsymbol{k}} = \sum_{\boldsymbol{m}\in F_2} \beta_{\boldsymbol{m}} \boldsymbol{z}^{\boldsymbol{m}} \zeta_{\boldsymbol{m}}$$

Then from the above equality (4.2), it is easy to see that

$$\|\sum_{\boldsymbol{k}\in F_1}\alpha_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}T\eta_{\boldsymbol{k}}-\sum_{\boldsymbol{m}\in F_2}\beta_{\boldsymbol{m}}\boldsymbol{z}^{\boldsymbol{m}}T\zeta_{\boldsymbol{m}}\|^2=\|\sum_{\boldsymbol{k}\in F_1}\alpha_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}\eta_{\boldsymbol{k}}-\sum_{\boldsymbol{m}\in F_2}\beta_{\boldsymbol{m}}\boldsymbol{z}^{\boldsymbol{m}}\zeta_{\boldsymbol{m}}\|^2=0.$$

Therefore

$$\sum_{\boldsymbol{k}\in F_1} \alpha_{\boldsymbol{k}} \boldsymbol{z}^{\boldsymbol{k}} T \eta_{\boldsymbol{k}} = \sum_{\boldsymbol{m}\in F_2} \beta_{\boldsymbol{m}} \boldsymbol{z}^{\boldsymbol{m}} T \zeta_{\boldsymbol{m}}.$$

Hence from the definition of $\tilde{T},$ we have

$$\tilde{T}(\sum_{\boldsymbol{k}\in F_1}\alpha_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}\eta_{\boldsymbol{k}})=\tilde{T}(\sum_{\boldsymbol{m}\in F_2}\beta_{\boldsymbol{m}}\boldsymbol{z}^{\boldsymbol{m}}\zeta_{\boldsymbol{m}}).$$

This proves that \tilde{T} is well defined on \mathcal{L} . From equation (4.2), we can conclude that \tilde{T} is a bounded as well as norm preserving linear operator on \mathcal{L} .

Now $\mathbf{k} = (k_1, \ldots, k_n) \in \mathbb{Z}_+^n$, $\eta \in \mathcal{Q}$, and for each $j = 1, 2, \cdots, n$, we have

$$\begin{split} \tilde{T}M_{z_{j}}(\boldsymbol{z}^{\boldsymbol{k}}\eta) &= \tilde{T}(z_{1}^{k_{1}}\cdots z_{j}^{k_{j}+1}\cdots z_{n}^{k_{n}}\eta) = (z_{1}^{k_{1}}\cdots z_{j}^{k_{j}+1}\cdots z_{n}^{k_{n}})T\eta = z_{j}\boldsymbol{z}^{\boldsymbol{k}}T\eta = M_{z_{j}}\tilde{T}(\boldsymbol{z}^{\boldsymbol{k}}\eta).\\ \text{Also if } k_{j} &\geq 1, \text{ then}\\ \tilde{T}M_{z_{j}}^{*}(\boldsymbol{z}^{\boldsymbol{k}}\eta) &= \tilde{T}(z_{1}^{k_{1}}\cdots z_{j}^{k_{j}-1}\cdots z_{n}^{k_{n}}\eta) = (z_{1}^{k_{1}}\cdots z_{j}^{k_{j}-1}\cdots z_{n}^{k_{n}})T\eta = M_{z_{j}}^{*}(\boldsymbol{z}^{\boldsymbol{k}}T\eta) = M_{z_{j}}^{*}\tilde{T}(\boldsymbol{z}^{\boldsymbol{k}}\eta).\\ \text{If } k_{j} &= 0, \text{ then}\\ \tilde{T}M_{z_{j}}^{*}(\boldsymbol{z}^{\boldsymbol{k}}\eta) &= \tilde{T}(z_{1}^{k_{1}}\cdots z_{j-1}^{k_{j+1}}z_{j+1}^{k_{j+1}}\cdots z_{n}^{k_{n}}M_{z_{j}}^{*}\eta) = z_{1}^{k_{1}}\cdots z_{j-1}^{k_{j-1}}z_{j+1}^{k_{j+1}}\cdots z_{n}^{k_{n}}(TM_{z_{j}}^{*}\eta)\\ &= z_{1}^{k_{1}}\cdots z_{j-1}^{k_{j-1}}z_{j+1}^{k_{j+1}}\cdots z_{n}^{k_{n}}(M_{z_{j}}^{*}T\eta)\\ &= M_{z_{j}}^{*}(\boldsymbol{z}^{\boldsymbol{k}}T\eta)\\ &= M_{z_{j}}^{*}(\boldsymbol{z}^{\boldsymbol{k}}\eta). \end{split}$$

The above fact implies that

$$\tilde{T}M_{z_j} = M_{z_j}\tilde{T}$$
 and $\tilde{T}M^*_{z_j}|_{\mathcal{L}} = M^*_{z_j}\tilde{T}$

for all $j = 1, 2, \dots, n$. Now the norm preserving operator \tilde{T} on \mathcal{L} can be extended uniquely by continuity (again denoted by same \tilde{T}) to the closure of \mathcal{L} (i.e. $\bar{\mathcal{L}} = H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^n)$) such that

$$\tilde{T}M_{z_j} = M_{z_j}\tilde{T}$$
 and $\tilde{T}M_{z_j}^* = M_{z_j}^*\tilde{T}$

for all $j = 1, 2, \dots, n$. This implies that \tilde{T} is a constant isometric multiplier from $H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^n)$ to $H^2(\mathbb{D}^n)$. Therefore from Lemma 4.1, we have $\dim(\tilde{\mathcal{E}}) = 1$. Hence $\tilde{T} = M_{\Theta}$, where $\Theta(\boldsymbol{z}) = \Theta(0)$ is a unitary from $\tilde{\mathcal{E}}$ to \mathbb{C} for $\boldsymbol{z} \in \mathbb{D}^n$. Also

$$T = T|_{\mathcal{Q}} = M_{\Theta}|_{\mathcal{Q}}.$$

This finishes the proof.

Theorem 4.3. Let $k \in \{1, 2, ..., n-1\}$ be a fixed integer. Let $S = \Theta H^2(\mathbb{D}^k) \otimes \mathcal{Q}_{\theta_1} \otimes \cdots \otimes \mathcal{Q}_{\theta_{n-k}}$ be a joint $(M_{z_1}, ..., M_{z_k}, M^*_{z_{k+1}}, ..., M^*_{z_n})$ invariant subspace of $H^2(\mathbb{D}^n)$, where $\Theta \in H^\infty(\mathbb{D}^k)$ is some inner function and \mathcal{Q}_{θ_j} is either a Jordan block or the Hardy space $H^2(\mathbb{D})$. Let

$$V_j = P_{\mathcal{S}} M_{z_j} |_{\mathcal{S}} \text{ for } 1 \le j \le n.$$

Then (V_1, \dots, V_n) is a doubly commuting tuple, where V_j is a pure isometry for $1 \leq j \leq k$ and V_j is a pure contraction for $k + 1 \leq j \leq n$.

Proof. Suppose $S = \Theta H^2(\mathbb{D}^k) \otimes \mathcal{Q}_{\theta_1} \otimes \cdots \otimes \mathcal{Q}_{\theta_n-k} \subseteq H^2(\mathbb{D}^n)$ is a joint $(M_{z_1}, \ldots, M_{z_k}, M^*_{z_{k+1}}, \ldots, M^*_{z_n})$ invariant subspace, where $\Theta \in H^\infty(\mathbb{D}^k)$ is some inner function and \mathcal{Q}_{θ_j} is either a Jordan block or the Hardy space $H^2(\mathbb{D})$. Clearly, $V_j = P_S M_{z_j}|_S = M_{z_j}|_S$ for $1 \leq j \leq k$ is a pure isometry and $V_j = P_S M_{z_j}|_S$ for $k+1 \leq j \leq n$ is a pure contraction.

Now $\Theta H^2(\mathbb{D}^k)$ is a doubly commuting invariant subspace for $(M_{z_1}, \ldots, M_{z_k})$. Therefore $V_i V_j = V_j V_i$ and $V_i V_j^* = V_j^* V_i$ for $1 \leq i < j \leq k$. Again $\mathcal{Q}_{\theta_1} \otimes \cdots \otimes \mathcal{Q}_{\theta_{n-k}}$ is a doubly

commuting invariant subspace for $(M^*_{z_{k+1}}, \ldots, M^*_{z_n})$. Thus $V_i V_j = V_j V_i$ and $V_i V_j^* = V_j^* V_i$ for $k+1 \leq i < j \leq n$. Also

$$V_i V_j^* = M_{z_i} M_{z_j}^* |_{\mathcal{S}} = M_{z_j}^* M_{z_i} |_{\mathcal{S}} = V_j^* V_i$$

for $1 \le i \le k$ and for $k+1 \le j \le n$.

To prove $V_iV_j = V_jV_i$ for $1 \le i \le k$ and for $k + 1 \le j \le n$, we use the standard result of the tensor product of Hilbert spaces: Let $\mathcal{H}_1, \mathcal{H}_2 \subseteq \mathcal{H}$ and $h_1, h_2 \in \mathcal{H}$. Then

$$P_{\mathcal{H}_{1}\otimes\mathcal{H}_{2}}(h_{1}\otimes h_{2}) = P_{\mathcal{H}_{1}}h_{1}\otimes P_{\mathcal{H}_{2}}h_{2}.$$
Let $f \in \Theta H^{2}(\mathbb{D}^{k})$ and $g_{l} \in \mathcal{Q}_{\theta_{l}}$ for $l = 1, \ldots, n - k$. Then
$$V_{i}V_{k+l}(f \otimes g_{1} \otimes \cdots \otimes g_{l} \otimes \cdots \otimes g_{n-k})$$

$$= V_{i}P_{\Theta H^{2}(\mathbb{D}^{k})\otimes\mathcal{Q}_{\theta_{1}}\otimes\cdots\otimes\mathcal{Q}_{\theta_{n-k}}}(f \otimes g_{1} \otimes \cdots \otimes M_{z}g_{l} \otimes \cdots \otimes g_{n-k})$$

$$= V_{i}(f \otimes P_{\mathcal{Q}_{\theta_{1}}\otimes\cdots\otimes\mathcal{Q}_{\theta_{n-k}}}(g_{1} \otimes \cdots \otimes zg_{l} \otimes \cdots \otimes g_{n-k}))$$

$$= M_{z_{i}}(f \otimes g_{1} \otimes \cdots \otimes P_{\mathcal{Q}_{\theta_{l}}}zg_{l} \otimes \cdots \otimes g_{n-k})$$

$$= z_{i}f \otimes g_{1} \otimes \cdots \otimes P_{\mathcal{Q}_{\theta_{l}}}zg_{l} \otimes \cdots \otimes g_{n-k}$$

$$= P_{\Theta H^{2}(\mathbb{D}^{k})\otimes\mathcal{Q}_{\theta_{1}}\otimes\cdots\otimes\mathcal{Q}_{\theta_{n-k}}}(z_{i}f \otimes g_{1} \otimes \cdots \otimes zg_{l} \otimes \cdots \otimes g_{n-k})$$

$$= V_{k+l}V_{i}(f \otimes g_{1} \otimes \cdots \otimes g_{l} \otimes \cdots \otimes g_{n-k}).$$

This completes the proof.

We record the following known result on the analytic model for a doubly commuting *n*-tuple of operators (see [5]). Let $T = (T_1, \ldots, T_n)$ be a doubly commuting pure *n*-tuple of operators on \mathcal{H} . Define the defect operator for the *n*-tuple T as

$$D_{T^*} = (\prod_{j=1}^n (I_{\mathcal{H}} - T_j T_j^*))^{\frac{1}{2}}.$$

and

$$\mathcal{D}_{T^*} = \overline{ran}(D_{T^*}).$$

Theorem 4.4. Let $T = (T_1, \ldots, T_n)$ be a doubly commuting pure n-tuple of operators on \mathcal{H} . Then $(M_{z_1}, \ldots, M_{z_n})$ on $H^2_{\mathcal{D}_{T^*}}(\mathbb{D}^n)$ is the minimal isometric dilation of T. That is there exists a joint $(M^*_{z_1}, \ldots, M^*_{z_n})$ invariant subspace \mathcal{Q} of $H^2_{\mathcal{D}_{T^*}}(\mathbb{D}^n)$ such that

 $T_j \cong P_Q M_{z_j} \mid_Q \quad (for \ all \ j = 1, \dots, n)$

and

$$H^2_{\mathcal{D}_{T^*}}(\mathbb{D}^n) = \overline{span}\{\boldsymbol{z}^{\boldsymbol{k}}\mathcal{Q}: \boldsymbol{k} \in \mathbb{Z}^n_+\}$$

Using the above theorem, we characterize a doubly commuting tuple of shifts and pure contractions.

Lemma 4.5. Let $k \in \{1, 2, ..., n-1\}$ be a fixed integer. Let $(T_1, ..., T_k, T_{k+1}, ..., T_n)$ be an *n*-tuple of doubly commuting operators on \mathcal{H} such that T_j is shift for $1 \leq j \leq k$ and T_j is a pure contraction for $k+1 \leq j \leq n$. Then $(T_1, ..., T_k, T_{k+1}, ..., T_n)$ on \mathcal{H} is unitarily equalent

to $(M_{z_1}, \ldots, M_{z_k}, I_{H^2(\mathbb{D}^k)} \otimes \tau_1, \ldots, I_{H^2(\mathbb{D}^k)} \otimes \tau_{n-k})$ on $H^2_{\mathcal{W}}(\mathbb{D}^k)$, where $\mathcal{W} = \bigcap_{j=1}^k Ker(T_j^*)$ and τ_j is a pure contraction on \mathcal{W} for $1 \leq j \leq n-k$.

Proof. Consider the map $\Pi: \mathcal{H} \to H^2_{\mathcal{W}}(\mathbb{D}^k)$ defined by

$$\Pi(\prod_{j=1}^k T_j^{m_j}\eta) = \prod_{j=1}^k z_j^{m_j}\eta$$

where $\eta \in \mathcal{W}$ and $m_j \in \mathbb{Z}_+$. Then clearly Π is unitary and $\Pi T_j = M_{z_j} \Pi$ for $1 \leq j \leq k$. Now we know that if $C \in \mathcal{B}(H^2_{\mathcal{W}}(\mathbb{D}^k))$ such that $M_{z_j}C = CM_{z_j}$ and $M^*_{z_j}C = CM^*_{z_j}$ for $1 \leq j \leq k$, then $C = M_{\tau} = I_{H^2(\mathbb{D}^k)} \otimes \tau$, where $\tau \in \mathcal{B}(\mathcal{W})$. Moreover, if C is pure then τ is pure. Thus

$$\Pi T_{k+j}\Pi^* = I_{H^2(\mathbb{D}^k)} \otimes \tau_j,$$

where $\tau_j \in \mathcal{B}(\mathcal{W})$ is a pure contraction for $1 \leq j \leq n-k$. Since $T_{k+i}T_{k+j} = T_{k+j}T_{k+i}$ and $T_{k+i}^*T_{k+j} = T_{k+j}T_{k+i}^*$, it readily follows that

$$\tau_i \tau_j = \tau_j \tau_i$$
 and $\tau_i^* \tau_j = \tau_j \tau_i^*$

for $1 \le i < j \le n - k$.

Now we are in a position to state our main result.

Theorem 4.6. Let S be a closed subspace of $H^2(\mathbb{D}^n)$ and $k \in \{1, \ldots, n-1\}$ be a fixed integer. Let S be a joint $(M_{z_1}, \ldots, M_{z_k}, M^*_{z_{k+1}}, \ldots, M^*_{z_n})$ invariant subspace and

$$V_j = P_{\mathcal{S}} M_{z_j}|_{\mathcal{S}} \quad for \ j = 1, \dots, n.$$

If (V_1, \ldots, V_n) is doubly commuting, then $S = \Theta H^2(\mathbb{D}^k) \otimes \mathcal{Q}_{\theta_1} \otimes \cdots \otimes \mathcal{Q}_{\theta_{n-k}}$ for some $\Theta \in H^\infty(\mathbb{D}^k)$ inner function and \mathcal{Q}_{θ_j} either a Jordan block or the Hardy space $H^2(\mathbb{D})$ for $j = 1, \ldots, n-k$.

Proof. Since S is a joint $(M_{z_1}, \ldots, M_{z_k}, M^*_{z_{k+1}}, \ldots, M^*_{z_n})$ invariant subspace of $H^2(\mathbb{D}^n)$,

$$V_j = P_{\mathcal{S}} M_{z_j} |_{\mathcal{S}} = M_{z_j} |_{\mathcal{S}}$$

for $j = 1, \ldots, k$ is shift and

$$V_j = P_{\mathcal{S}} M_{z_j} |_{\mathcal{S}}$$

for j = k + 1, ..., n is a pure contraction. Hence by the above Lemma 4.5, there exists a unitary $\Pi : S \to H^2_{\mathcal{W}}(\mathbb{D}^k)$ defined by

$$\Pi(\prod_{j=1}^{k} V_j^{m_j} \eta) = \prod_{j=1}^{k} z_j^{m_j} \eta \qquad (\eta \in \mathcal{W})$$

such that

$$\Pi V_j = M_{z_j} \Pi \quad \text{for } j = 1, \dots, k$$

$$\Pi V_{k+i} = (I_{H^2(\mathbb{D}^k)} \otimes \tau_i) \Pi \quad \text{for } i = 1, \dots, n-k$$

where $\mathcal{W} = \bigcap_{j=1}^{k} Ker(V_j^*)$ and τ_i is a pure contraction on \mathcal{W} with

$$\tau_i \tau_j = \tau_j \tau_i$$
 and $\tau_i^* \tau_j = \tau_j \tau_i^*$

for $1 \leq i < j \leq n-k$. Now from Theorem 4.4, we have $\tau^* = (\tau_1^*, \ldots, \tau_{n-k}^*)$ on \mathcal{W} is unitarily equivalent to $(M_{w_1}^*|_{\mathcal{Q}}, \ldots, M_{w_{n-k}}^*|_{\mathcal{Q}})$, where \mathcal{Q} is a joint $(M_{w_1}^*, \ldots, M_{w_{n-k}}^*)$ invariant subspace of $H^2_{\mathcal{D}_{\tau^*}}(\mathbb{D}^{n-k})$ and $\mathcal{D}_{\tau^*} = \overline{ran}(\prod_{i=1}^{n-k}(I_{\mathcal{W}} - \tau_i\tau_i^*))^{\frac{1}{2}}$. Let $U: \mathcal{W} \to \mathcal{Q} \subseteq H^2_{\mathcal{D}_{\tau^*}}(\mathbb{D}^{n-k})$ be a unitary such that

 $U\tau_i^* = M_{w_i}^*|_{\mathcal{Q}} U \quad \text{for } i = 1, \dots, n-k.$

Thus we have a unitary map $I_{H^2(\mathbb{D}^k)} \otimes U^* : H^2(\mathbb{D}^k) \otimes \mathcal{Q} \to H^2(\mathbb{D}^k) \otimes \mathcal{W}$ such that

$$(I_{H^2(\mathbb{D}^k)} \otimes U^*)(M_{z_j} \otimes I_{\mathcal{Q}}) = (M_{z_j} \otimes I_{\mathcal{W}})(I_{H^2(\mathbb{D}^k)} \otimes U^*)$$

and

$$(I_{H^2(\mathbb{D}^k)} \otimes U^*)(I_{H^2(\mathbb{D}^k)} \otimes M_{w_i}^*|_{\mathcal{Q}}) = (I_{H^2(\mathbb{D}^k)} \otimes \tau_i^*)(I_{H^2(\mathbb{D}^k)} \otimes U^*)$$

for j = 1, ..., k and i = 1, ..., n - k.

Let $\iota: \mathcal{S} \to H^2(\mathbb{D}^k) \otimes H^2(\mathbb{D}^{n-k})$ be the inclusion map. Therefore we have an operator

$$\widetilde{\Pi} = \iota \circ \Pi^* \circ (I_{H^2(\mathbb{D}^k)} \otimes U^*) : H^2(\mathbb{D}^k) \otimes \mathcal{Q} \to H^2(\mathbb{D}^k) \otimes H^2(\mathbb{D}^{n-k})$$

which is an isometry as each one is so and also satisfying

$$\widetilde{\Pi}(M_{z_j} \otimes I_{\mathcal{Q}}) = (M_{z_j} \otimes I_{\mathcal{W}})\widetilde{\Pi} \quad \text{for } j = 1, \dots, k$$

and

$$\tilde{\Pi}(I_{H^2(\mathbb{D}^k)} \otimes M^*_{w_i}|_{\mathcal{Q}}) = (I_{H^2(\mathbb{D}^k)} \otimes M^*_{w_i})\tilde{\Pi} \quad \text{for } i = 1, \dots, n-k.$$

Then from the first equality, we have Π is an inner multiplier, say,

$$\Pi = M_{\Phi}$$

for some $\Phi \in H^{\infty}_{\mathcal{B}(\mathcal{Q}, H^2(\mathbb{D}^{n-k}))}(\mathbb{D}^k)$. Again the other equality gives

$$\Phi(e^{it})M_{w_j}^*|_{\mathcal{Q}} = M_{w_j}^*\Phi(e^{it}), \quad j = 1, \dots, n-k.$$

for all $t \in \mathbb{R}^k$ and $e^{it} = e^{it_1} \cdots e^{it_k}$. Since $\Phi(e^{it})$ is isometry almost everywhere (a.e.) with respect to the Lebesgue measure on the k-dimensional torus \mathbb{T}^k , from the above Lemma 4.2,

$$\Phi(e^{it}): \mathcal{Q} \to H^2(\mathbb{D}^{n-k}) \quad (e^{it} \in \mathbb{T}^k \text{ a.e.})$$

is the restriction of a constant isometric multiplier from $H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^{n-k})$ to $H^2(\mathbb{D}^{n-k})$, where $\tilde{\mathcal{E}}$ is a one-dimensional space. Since $\tilde{\mathcal{E}}$ and \mathbb{C} are one dimensional spaces, the space of all constant multipliers in $H^{\infty}_{\mathcal{B}(\tilde{\mathcal{E}},\mathbb{C})}(\mathbb{D}^{n-k})$ is also one dimensional. Hence there exists a unitary multiplier $M_X: H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^{n-k}) \to H^2(\mathbb{D}^{n-k})$ such that

$$\Phi(e^{it}) = \Theta(e^{it})M_X|_{\mathcal{Q}} \quad (\text{ a.e. on } \mathbb{T}^k)$$

for some scalar $\Theta(e^{it})$. Since Φ is analytic, Θ is also analytic on \mathbb{D}^k . Also $|\Theta(e^{it})| = 1$ as $M_X|_{\mathcal{Q}}$ and $\Phi(e^{it})$ are isometries a.e. on \mathbb{T}^k . Hence $\Theta \in H^{\infty}(\mathbb{D}^k)$ is an inner function. Thus the inner multiplier $M_{\Phi}: H^2_{\mathcal{Q}}(\mathbb{D}^k) \to H^2_{H^2(\mathbb{D}^{n-k})}(\mathbb{D}^k)$ factors as $M_{\Theta} \otimes M_X|_{\mathcal{Q}}$ from $H^2(\mathbb{D}^k) \otimes \mathcal{Q}$ to $H^2(\mathbb{D}^k) \otimes H^2(\mathbb{D}^{n-k})$. Therefore

$$\mathcal{S} = ran(M_{\Phi}) = M_{\Phi}H_{\mathcal{Q}}^2 = \Theta H^2(\mathbb{D}^k) \otimes M_X(\mathcal{Q}).$$

Since $M_X : H^2_{\tilde{\mathcal{E}}}(\mathbb{D}^{n-k}) \to H^2(\mathbb{D}^{n-k})$ is a constant unitary, it intertwines with $M^*_{w_i}$ for $i = 1, \ldots, n-k$. Hence $M_X(\mathcal{Q})$ is a closed doubly commuting invariant subspace of $H^2(\mathbb{D}^{n-k})$. Therefore from the result [25], $M_X(\mathcal{Q})$ is of the form

$$M_X(\mathcal{Q}) = \mathcal{Q}_{\theta_1} \otimes \cdots \otimes \mathcal{Q}_{\theta n-k}$$

where \mathcal{Q}_{θ_j} is either a Jordan block or the Hardy space $H^2(\mathbb{D}), j = 1, \ldots, n-k$. Thus

$$\mathcal{S} = \Theta H^2(\mathbb{D}^k) \otimes \mathcal{Q}_{\theta_1} \otimes \cdots \otimes \mathcal{Q}_{\theta_{n-k}}.$$

This finishes the proof.

5. Some Applications

In this section we give some concrete examples of *mixed invariant* subspaces.

Let \mathbb{T} be the unit circle and $K(\cdot, z)$ be the Szegö kernel on $H^2(\mathbb{D})$. We consider the examples of *mixed invariant* subspaces in the Hardy space $H^2(\mathbb{D}^2)$ over the bidisc for the sake of simplicity. We can identify $H^2(\mathbb{D}^2)$ as $H^2(\mathbb{D}) \otimes H^2(\mathbb{D})$. Let $(\alpha_n) \subset \mathbb{D}$ be a sequence such that $\sum_{n=0}^{\infty} 1 - |\alpha_n|^2 < \infty$. Consider for $N \in \mathbb{N}$,

$$Q_N = \operatorname{span}\{K(\cdot, \alpha_1), \ldots, K(\cdot, \alpha_N)\}$$

and

$$\mathcal{S}_N = H^2(\mathbb{D}) \otimes \mathcal{Q}_N.$$

Then clearly \mathcal{S}_N is invariant under $(M_z \otimes I_{H^2(\mathbb{D})}, I_{H^2(\mathbb{D})} \otimes M_z^*)$. Also

$$(\mathcal{S}_N \ominus z_1 \mathcal{S}_N) = (\mathcal{S}_N \ominus (M_z \otimes I_{H^2(\mathbb{D})}) \mathcal{S}_N) = (H^2(\mathbb{D}) \ominus z H^2(\mathbb{D})) \otimes \mathcal{Q}_N = \mathbb{C} \otimes \mathcal{Q}_N.$$

Thus \mathcal{S}_N is an example of a mixed invariant subspace with $\dim(\mathcal{S}_N \ominus z_1 \mathcal{S}_N) = N$ for each $N \in \mathbb{N}$. Moreover, if we take

$$\mathcal{Q} = \overline{span}\{K(\cdot, \alpha_i) : i \in \mathbb{N}\},\$$

then $S = H^2(\mathbb{D}) \otimes \mathcal{Q}$ is a mixed invariant subspace with dim $(S \ominus z_1 S) = \infty$. Note that here \mathcal{Q} is a proper subspace of $H^2(\mathbb{D})$ as $\prod_{j=1}^{\infty} \frac{z-\alpha_j}{1-\overline{\alpha_j}z} \in \mathcal{Q}^{\perp} = H^2(\mathbb{D}) \ominus \mathcal{Q}$.

In particular, we have an explicit representation of the Beurling-Lax-Halmos's inner function Θ and the mixed invariant subspace S of $H^2(\mathbb{D}^n)$, where $S \ominus z_1 S$ is one dimensional.

Theorem 5.1. Let $S \subseteq H^2_{H_n}(\mathbb{D})$ be a closed subspace, and let $\mathcal{W} = S \ominus zS$. Suppose S is invariant under $(M_z, M^*_{\kappa_1}, \ldots, M^*_{\kappa_n})$. Then dim $(\mathcal{W}) = 1$ if and only if

$$\mathcal{S} = \Theta H^2(\mathbb{D}),$$

where $\Theta \in H^{\infty}_{\mathcal{B}(\mathbb{C},H_n)}(\mathbb{D})$ is an inner multiplier given by

$$\Theta(z) = \psi(z) K(\cdot, (\overline{\varphi_1(z)}, \dots, \overline{\varphi_n(z)})) \qquad (z \in \mathbb{D}),$$

 $\varphi_j, \psi \in H^{\infty}(\mathbb{D}) \text{ and } |\varphi_j(z)| < 1 \text{ for all } z \in \mathbb{D} \text{ and }$

$$|\psi(e^{i\theta})|^2 = \prod_{j=1}^n (1 - |\varphi_j(e^{i\theta})|^2) \text{ a.e. on } \mathbb{T}.$$

Proof. Suppose that S is a closed subspace of $H^2_{H_n}(\mathbb{D})$ which is invariant under $(M_z, M^*_{\kappa_1}, \ldots, M^*_{\kappa_n})$. Consider

$$V = M_z|_{\mathcal{S}}$$
 and
 $V_j = P_{\mathcal{S}} M_{\kappa_j}|_{\mathcal{S}}$ for $j = 1, \dots, n$

Since V is a shift and V_j^* commute with V, the tuple $(V, V_1^*, \ldots, V_n^*)$ on \mathcal{S} is unitarily equivalent to $(M_z, M_{\varphi_1}, \ldots, M_{\varphi_n})$ on $H^2_{\mathcal{W}}(\mathbb{D})$, where $\mathcal{W} = \mathcal{S} \ominus z\mathcal{S}$ and from Remark 3.1,

$$\varphi_j(w) = P_{\mathcal{W}}(I_{\mathcal{S}} - wV^*)^{-1}V_j^*|_{\mathcal{W}} \quad (w \in \mathbb{D}, \ j = 1, \dots, n).$$

Since S is joint invariant under $(M_z, M_{\kappa_1}^*, \ldots, M_{\kappa_n}^*)$ and dim $(\mathcal{W}) = 1$, using the result ([21], Theorem 3.2), we have an isometry

$$M_{\Theta}: H^2(\mathbb{D}) \to H^2_{H_n}(\mathbb{D})$$
 such that $\mathcal{S} = \Theta H^2(\mathbb{D}),$

where $\Theta \in H^{\infty}_{\mathcal{B}(\mathbb{C},H_n)}(\mathbb{D})$ is an inner multiplier and $M^*_{\kappa_j}M_{\Theta} = M_{\Theta}M_{\varphi_j}$ for some $\varphi_j \in H^{\infty}(\mathbb{D})$ for $1 \leq j \leq n$. Therefore, for each $z \in \mathbb{D}$

$$M_{z_j}^*\Theta(z) = \Theta(z)\varphi_j(z) = \varphi_j(z)\Theta(z)$$

for $1 \leq j \leq n$. This implies $\Theta(z) \cdot 1 = \Theta(z) \in H^2(\mathbb{D}^n)$ is an eigenvector for the operator $M^*_{z_j}$ with eigenvalue $\varphi_j(z)$. Hence $|\varphi_j(z)| < 1$ for $z \in \mathbb{D}$, $1 \leq j \leq n$. That means for each $z \in \mathbb{D}$

$$\Theta(z) \in \ker(M_{z_j} - \overline{\varphi_j(z)}I_{H^2(\mathbb{D}^n)})^* \quad \text{for all } 1 \le j \le n.$$

This implies $\Theta(z) \in \operatorname{span}\{K(\cdot, (\overline{\varphi_1(z)}, \dots, \overline{\varphi_n(z)})\},$ where

$$K(\cdot, (\overline{\varphi_1(z)}, \dots, \overline{\varphi_n(z)})(\boldsymbol{w}) = \prod_{j=1}^n \frac{1}{1 - \varphi_j(z)w_j} \qquad (\boldsymbol{w} \in \mathbb{D}^n).$$

Therefore

$$\Theta(z) = \psi(z)K(\cdot, (\overline{\varphi_1(z)}, \dots, \overline{\varphi_n(z)}) \text{ for some } \psi.$$

Using the fact that

$$\|K(\cdot, (\overline{\varphi_1(z)}, \dots, \overline{\varphi_n(z)})\|^2 = \frac{1}{\prod_{j=1}^n (1 - |\varphi_j(z)|^2)},$$

we have from the above identity

$$|\psi(z)|^2 = ||\Theta(z)||^2 \prod_{j=1}^n (1 - |\varphi_j(z)|^2).$$

It is easy to see that $\psi \in H^{\infty}(\mathbb{D})$ as $|\psi(z)| \leq ||\Theta(z)|| \leq 1$ for $z \in \mathbb{D}$. Since $\Theta \in H^{\infty}_{\mathcal{B}(\mathbb{C},H_n)}(\mathbb{D})$ is an inner multiplier, by taking the radial limit, we have

$$|\psi(e^{i\theta})|^2 = \prod_{j=1}^n (1 - |\varphi_j(e^{i\theta})|^2)$$
 a.e. on \mathbb{T} .

Also

$$\mathcal{S} = \Theta H^2(\mathbb{D})$$

where

$$\Theta(z) = \psi(z)K(\cdot, (\overline{\varphi_1(z)}, \dots, \overline{\varphi_n(z)})) \qquad (z \in \mathbb{D}).$$

The converse follows easily.

This completes the proof.

The above result is a generalization of the result on the Hardy space $H^2(\mathbb{D}^2)$ over the bidisc by Izuchi et al. (see Theorem 3.2, [19]).
