# THE BRAUER GROUP OF A VALUATION RING

#### Abstract

Let $V$ be a valuation ring and $K$ be its field of fraction. We show that the canonical map $\operatorname{Br}(V) \rightarrow \operatorname{Br}(K)$ is injective.


## 1. Introduction

In recent years, it has been observed by various authors that a valuation ring (not necessarily Noetherian) behaves almost like regular ring in many situations. One can see [8] for some $K$-theoretic evidence. In this article, we give some evidence for Brauer groups. The Brauer group $\operatorname{Br}(R)$ of a commutative ring $R$ consists of Morita equivalence classes of Azumaya algebras over $R$ (see [1], [10]). The group operation on $\operatorname{Br}(R)$ is $\otimes_{R}$. An element of $\operatorname{Br}(R)$ is represented by a class $[A]$, where $A$ is an Azumaya algebra over $R$.

A classical result of Auslander and Goldman says that for a regular noetherian domain $R$ with the field of fraction $K$, the canonical map $\operatorname{Br}(R) \rightarrow \operatorname{Br}(K)$ sending $[A]$ to $\left[A \otimes_{R} K\right]$ is injective (see Theorem 7.2 of [1]). We observe that the same is true for valuation rings (see below Theorem 1.1). A subring $V$ of a field $K$ is said to be valuation ring if for each nonzero element $a \in K$, either $a \in V$ or $a^{-1} \in V$. Clearly, $K$ itself a valuation ring and we call it a trivial valuation ring of $K$. If $V \neq K$ then we say that $V$ is a nontrivial valuation ring of $K$. Every valuation ring is a local normal domain. If $\mathfrak{p}$ is a prime ideal of a valuation ring $V$ then the quotient $V / \mathfrak{p}$ and the localization $V_{\mathfrak{p}}$ both are valuation rings. The rank of a valuation ring is equal to its krull dimension. Here is our main result.

Theorem 1.1. Let $V$ be a valuation ring with the field of fraction $K$. Then the canonical map $\operatorname{Br}(V) \rightarrow \operatorname{Br}(K)$ is injective.

## 2. One dimensional case

In this section, we prove Theorem 1.1 in the case when $V$ is a one dimensional valuation ring with the field of fraction $K$. Throughout this section, let $V$ be a one dimensional valuation ring with the field of fraction $K$ and $f: \operatorname{Spec}(K) \rightarrow \operatorname{Spec}(V)$ be the map of schemes induced by the inclusion $V \hookrightarrow K$. Given a ring $R, R^{\times}$always denotes the group of units.

The Leray spectral sequence of the map $f: \operatorname{Spec}(K) \rightarrow \operatorname{Spec}(V)$ gives

$$
\begin{align*}
0 \rightarrow H_{e t}^{1}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K}\right) \rightarrow & H_{e t}^{1}\left(\operatorname{Spec}(K), \mathbb{G}_{m, K}\right) \rightarrow H_{e t}^{0}\left(\operatorname{Spec}(V), R^{1} f_{*} \mathbb{G}_{m, K}\right) \\
& \rightarrow H_{e t}^{2}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K}\right) \rightarrow H_{e t}^{2}\left(\operatorname{Spec}(K), \mathbb{G}_{m, K}\right) \tag{2.1}
\end{align*}
$$

where $\mathbb{G}_{m}$ denotes the étale unit sheaf. We know $H_{e t}^{1}\left(\operatorname{Spec}(K), \mathbb{G}_{m, K}\right) \cong \operatorname{Pic}(K)=0$ and $H_{e t}^{2}\left(\operatorname{Spec}(K), \mathbb{G}_{m, K}\right) \cong \operatorname{Br}(K)$. The stalk of $R^{1} f_{*} \mathbb{G}_{m, K}$ at a geometric point $\bar{v}$ is $H_{e t}^{1}\left(\operatorname{Spec}\left(K_{\bar{v}}\right), \mathbb{G}_{m, K_{\bar{v}}}\right) \cong \operatorname{Pic}\left(K_{\bar{v}}\right)$ where $K_{\bar{v}}=K \otimes_{V} \mathcal{O}_{V, \bar{v}}$. Since $\operatorname{dim}(V)=1, \mathcal{O}_{V, \bar{v}}$ is either $K^{\text {sep }}$ or $V^{\text {sh }}$, where $K^{\text {sep }}$ is any separable closure of $K$. Moreover, $V^{\text {sh }}$ is a normal domain of dimension one (see [12, Tag 07QL]). Thus, $K_{\bar{v}}$ is either $K^{\text {sep }}$ or the field of fraction of $V^{s h}$. Therefore, $R^{1} f_{*} \mathbb{G}_{m, K}=0$. By (2.1) we get

$$
\begin{equation*}
H_{e t}^{1}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K}\right)=0 \text { and } 0 \rightarrow H_{e t}^{2}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K}\right) \rightarrow \operatorname{Br}(K) \tag{2.2}
\end{equation*}
$$

Now, the long exact sequence associated to the exact sequence

$$
1 \rightarrow \mathbb{G}_{m, V} \rightarrow f_{*} \mathbb{G}_{m, K} \rightarrow f_{*} \mathbb{G}_{m, K} / \mathbb{G}_{m, V} \rightarrow 1
$$

of étale sheaves on $\operatorname{Spec}(V)$ implies (using (2.2) and an wellknown fact that the Picard group of a local ring is trivial)

$$
\begin{equation*}
H_{e t}^{0}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K} / \mathbb{G}_{m, V}\right) \cong K^{\times} / V^{\times} \tag{2.3}
\end{equation*}
$$

and

$$
\begin{equation*}
0 \rightarrow H_{e t}^{1}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K} / \mathbb{G}_{m, V}\right) \rightarrow H_{e t}^{2}\left(\operatorname{Spec}(V), \mathbb{G}_{m, V}\right) \rightarrow H_{e t}^{2}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K}\right) \tag{2.4}
\end{equation*}
$$

Our first goal is to prove the following result:
Theorem 2.1. Let $V$ be a one dimensional valuation ring with the field of fraction $K$. Let $f: \operatorname{Spec}(K) \rightarrow \operatorname{Spec}(V)$ be the map of schemes induced by the inclusion $V \hookrightarrow K$. Then $H_{e t}^{1}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K} / \mathbb{G}_{m, V}\right)=0$.

We need some preparations to prove Theorem [2.1. Let us begin with a definition.
Let $S$ be any scheme. The support of an abelian sheaf $\mathcal{F}$ on $S_{e t}$ is the set of points $s \in S$ such that $\mathcal{F}_{\bar{s}} \neq 0$ for any geometric point $\bar{s}$ lying over $s$. It is denoted by $\operatorname{Supp}(\mathcal{F})$.

Lemma 2.2. Suppose $V, K$ and $f$ are as in Theorem 2.1. Let $\mathfrak{m}$ denote the unique maximal ideal of $V$. Then $\operatorname{Supp}\left(f_{*} \mathbb{G}_{m, K} / \mathbb{G}_{m, V}\right)$ is $\operatorname{Spec}(V / \mathfrak{m})$.

Proof. Write $\mathcal{I}$ for the étale sheaf $f_{*} \mathbb{G}_{m, K} / \mathbb{G}_{m, V}$. The stalk of $\mathcal{I}$ at a geometric point $\bar{v}$ is $\mathcal{I}_{\bar{v}}=\left(K \otimes_{V} \mathcal{O}_{V, \bar{v}} \times / \mathcal{O}_{V, \bar{v}}^{\times}\right.$. Since $\operatorname{dim} V=1, \operatorname{Spec}(V)=\{\xi, \mathfrak{m}\}$ where $\xi$ is the generic point of $\operatorname{Spec}(V)$. Then $\mathcal{I}_{\bar{\xi}}=0$ and $\mathcal{I}_{\overline{\mathfrak{m}}}=K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}$, where $K\left(V^{s h}\right)$ denotes the field of fraction of $V^{s h}$. Note that $K\left(V^{s h}\right)^{\times} \neq\left(V^{s h}\right)^{\times}$because $V^{s h}$ is a one dimensional local domain. Thus, the support of $\mathcal{I}$ is $\operatorname{Spec}(V / \mathfrak{m})$.

Let $k$ denote the residue field $V / \mathfrak{m}$. We have a closed immersion $i: \operatorname{Spec}(k) \rightarrow$ $\operatorname{Spec}(V)$. Write $\mathcal{I}$ for $f_{*} \mathbb{G}_{m, K} / \mathbb{G}_{m, V}$ as before. By Lemma 2.2, $\operatorname{Supp}(\mathcal{I})=\operatorname{Spec}(k)$. Then Proposition 58.46.4 of [12, Tag 04E1] implies that $i_{*}\left(i^{-1} \mathcal{I}\right) \cong \mathcal{I}$. Here $i^{-1} \mathcal{I}$ is a sheaf on $(\operatorname{Spec}(k))_{e t}$. Set $\mathcal{I}^{\prime}=i^{-1} \mathcal{I}$. Since $i_{*}$ is an exact functor, $R^{q} i_{*} \mathcal{I}^{\prime}=0$ for all $q>0$. The spectral sequence

$$
H_{e t}^{p}\left(\operatorname{Spec}(V), R^{q} i_{*} \mathcal{I}^{\prime}\right) \Rightarrow H_{e t}^{p+q}\left(\operatorname{Spec}(k), \mathcal{I}^{\prime}\right)
$$

gives the following:
Lemma 2.3. With the above notations, there is an isomorphism of groups

$$
H_{e t}^{j}(\operatorname{Spec}(V), \mathcal{I}) \cong H_{e t}^{j}\left(\operatorname{Spec}(k), i^{-1} \mathcal{I}\right) \text { for all } j \geq 0
$$

The absolute Galois group of $k$ is $\operatorname{Gal}\left(k^{\text {sep }} / k\right)$ and is denoted by $G_{k}$. Here $k^{\text {sep }}$ is the separable closure of $k$ in the algebraically closed field $\bar{k}$. Note that $\left(i^{-1} \mathcal{I}\right)_{\overline{\mathrm{m}}}=\mathcal{I}_{\overline{\mathrm{m}}}=$ $K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}$. Moreover, $K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}$is a $G_{k}$-module (see [12, Tag 03QW]). So, we can consider its Galois cohomology group $H^{j}\left(G_{k}, K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right)$for $j \geq 0$. Some details related to Galois cohomology can be found in [6] and [11]. Given a $G$-module $M$, the invariant subgroup $M^{G}=\{x \in M \mid g \cdot x=x$ for all $g \in G\}$. Here $G$ is any group. Now, Lemma 58.58.2 of [12, Tag 03QQ] implies the following:

Lemma 2.4. With the above notations, we have
(1) $H_{e t}^{0}\left(\operatorname{Spec}(k), i^{-1} \mathcal{I}\right)=\left(K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right)^{G_{k}}$,
(2) $H_{e t}^{j}\left(\operatorname{Spec}(k), i^{-1} \mathcal{I}\right)=H^{j}\left(G_{k}, K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right)$for $j>0$.

By combining the above two lemmas, we obtain

$$
\begin{gather*}
H_{e t}^{0}(\operatorname{Spec}(V), \mathcal{I}) \cong H_{e t}^{0}\left(\operatorname{Spec}(k), i^{-1} \mathcal{I}\right)=\left(K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right)^{G_{k}}  \tag{2.5}\\
H_{e t}^{j}(\operatorname{Spec}(V), \mathcal{I}) \cong H_{e t}^{j}\left(\operatorname{Spec}(k), i^{-1} \mathcal{I}\right)=H^{j}\left(G_{k}, K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right) \text {for } j>0 .
\end{gather*}
$$

We are now ready to prove Theorem [2.1,
Proof of Theorem 2.1: The strict henselization $V^{s h}$ of $V$ is also a one dimensional valuation ring (see Lemma 15.118.5 of [12, Tag 0ASF]). Recall $K\left(V^{s h}\right)$ is the field of fraction of $V^{s h}$. Then, we have $K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times} \cong K^{\times} / V^{\times} \cong\left(K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right)^{G_{k}}$, where the first isomorphism by Lemma 15.118.5 of [12, Tag 0ASF] and the second
isomorphism follows from (2.3) and (2.5). Hence, $G_{k}$ acts trivially on $K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}$. By (2.6), we also have $H_{e t}^{1}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K} / \mathbb{G}_{m, V}\right) \cong H^{1}\left(G_{k}, K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right)$. So, it is enough to show that $H^{1}\left(G_{k}, K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right)=0$. Since $\operatorname{dim} V^{s h}=1$, the value group $K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}$is isomorphic to a non-trivial additive subgroup of $\mathbb{R}$ (see chapter VI, section 4.5, Proposition 8 of [3]). In fact, $K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}$is a torsion free $\mathbb{Z}\left[G_{k}\right]$-module. As $G_{k}$ is a profinite group (see Proposition 4.1.3 of [6]), $G_{k}=\underset{\leftarrow}{\lim } \operatorname{Gal}(L / k)$, where the limit over all finite Galois subextensions $L / k$ of $k^{\text {sep }} / k$. Thus,

$$
H^{1}\left(G_{k}, K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right) \cong \underset{\longrightarrow}{\lim } H^{1}\left(\operatorname{Gal}(L / k), K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right) .
$$

There are natural surjections $G_{k} \rightarrow \operatorname{Gal}(L / k)$ for all finite Galois subextensions $L / k$ of $k^{s e p} / k$ (see Corollary 4.1.4 of [6]). Hence, all $\operatorname{Gal}(L / k)$ acts trivially on $K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}$. In this situation, we know (see Exercise 6.1.5 of [13])

$$
H^{1}\left(\operatorname{Gal}(L / k), K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right) \cong \operatorname{Hom}_{\text {Groups }}\left(\operatorname{Gal}(L / k), K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right)
$$

where $\operatorname{Hom}_{\text {Groups }}(-,-)$ denotes the hom set in the category of groups. Since $\operatorname{Gal}(L / k)$ is a finite group, $\operatorname{Hom}_{\text {Groups }}\left(\operatorname{Gal}(L / k), K\left(V^{s h}\right)^{\times} /\left(V^{s h}\right)^{\times}\right)=0$. Hence the result.

Corollary 2.5. Let $V$ be a one dimensional valuation ring with the field of fraction $K$. Then the following are true:
(1) $H_{e t}^{2}\left(\operatorname{Spec}(V), \mathbb{G}_{m, V}\right)$ is a torsion group.
(2) $\operatorname{Br}(V) \cong H_{e t}^{2}\left(\operatorname{Spec}(V), \mathbb{G}_{m, V}\right)$.
(3) the canonical map $\operatorname{Br}(V) \rightarrow \operatorname{Br}(K)$ is injective.

Proof. (1) The Brauer group of a field always a torsion group (see Corollary 2.8.5 of [6]). Thus, $H_{e t}^{2}\left(\operatorname{Spec}(V), f_{*} \mathbb{G}_{m, K}\right)$ is a torsion group by (2.2). Hence the result by Theorem 2.1 and (2.4).
(2) By a theorem of Gabber (see [4]), $\operatorname{Br}(R) \cong\left(H_{e t}^{2}\left(\operatorname{Spec}(R), \mathbb{G}_{m, R}\right)\right)_{t o r}$ for any commutative ring $R$. We get the assertion by (1).
(3) This is now immediate from Theorem [2.1, (2.2) and (2.4).

## 3. GENERAL CASE

In this section, we prove the general case of Theorem 1.1. We also discuss some consequences of Theorem 1.1.

Proof of Theorem 1.1: We may assume that $V \neq K$. Note that $K=\bigcup K_{i}$, where $K_{i}$ is a finitely generated subfield of $K$. Then $V$ can be wriiten as filtered limit of $V_{i}$, where $V_{i}=V \cap K_{i}$ is a valuation ring of $K_{i}$ with finite rank (see Lemma 2.22 of [2]). Since Br commutes with filtered limit, we may also assume that $V$ is a valuation ring of finite rank $d>0$. We use induction on $d$. If $d=1$ then the result is true by Corollary 2.5(3). Suppose that the result is true for all valuation rings of rank less than $d$. Let
$V$ be a valuation ring of rank $d$ with the field of fraction $K$. Let $\mathfrak{p}$ be a nonzero, nonmaximal prime ideal of $V$. Note that $\operatorname{Spec}\left(V_{\mathfrak{p}}\right)$ is open in $\operatorname{Spec}(V)$. Moreover, $V_{\mathfrak{p}}$ and $V / \mathfrak{p}$ both are valuation rings with the field of fractions $K$ and $k(\mathfrak{p})=V_{\mathfrak{p}} / \mathfrak{p} V_{\mathfrak{p}}$. We also have $1 \leq \operatorname{dim}\left(V_{\mathfrak{p}}\right)<d$ and $1 \leq \operatorname{dim}(V / \mathfrak{p})<d$. Since $V$ is a valuation ring, the following square (see Proposition 2.8 of [2])

is Milnor. By Corollary 2.5 of [9], we get an exact sequence

$$
0 \rightarrow \operatorname{Br}(V) \rightarrow \operatorname{Br}\left(V_{\mathfrak{p}}\right) \times \operatorname{Br}(V / \mathfrak{p}) \rightarrow \operatorname{Br}(k(\mathfrak{p}))
$$

Now consider the following commutative diagram

where the second vertical map is injective by the induction hypothesis. Hence the result.

Corollary 3.1. Let $V$ be a valuation ring with the field of fraction $K$. Let $\mathfrak{p}, \mathfrak{q} \in \operatorname{Spec}(V)$. Then either $\operatorname{Br}\left(V_{\mathfrak{p}}\right) \hookrightarrow \operatorname{Br}\left(V_{\mathfrak{q}}\right)$ or $\operatorname{Br}\left(V_{\mathfrak{q}}\right) \hookrightarrow \operatorname{Br}\left(V_{\mathfrak{p}}\right)$. In particular, $\operatorname{Br}(V) \hookrightarrow \operatorname{Br}\left(V_{\mathfrak{p}}\right)$ for all $\mathfrak{p} \in \operatorname{Spec}(V)$.

Proof. Since $V$ is a valuation ring, either $\mathfrak{p} \subseteq \mathfrak{q}$ or $\mathfrak{q} \subseteq \mathfrak{p}$. Note that the both $V_{\mathfrak{p}}$ and $V_{\mathfrak{q}}$ are valuation rings with the field of fraction $K$. The assertion now clear from Theorem 1.1. For the second part, consider $\mathfrak{p} \subseteq \mathfrak{m}$, where $\mathfrak{m}$ is the unique maximal ideal.

Remark 3.2. For a valuation ring $V$, we have exactly one chain of prime ideals, say

$$
(0) \subseteq \mathfrak{p} \subseteq \cdots \subseteq \mathfrak{q} \subseteq \mathfrak{m}
$$

By Corollary 3.1. we get

$$
\operatorname{Br}(V) \hookrightarrow \operatorname{Br}\left(V_{\mathfrak{q}}\right) \hookrightarrow \cdots \hookrightarrow \operatorname{Br}\left(V_{\mathfrak{p}}\right) \hookrightarrow \operatorname{Br}(K) .
$$

In particular, $\operatorname{Br}(V)=\bigcap_{\mathfrak{p} \in \operatorname{Spec}(V)} \operatorname{Br}\left(V_{\mathfrak{p}}\right)$.
Remark 3.3. Kestutis Česnavičius inform me in [7] that a stronger version of Theorem 1.1 is also true over valuation rings. More explicitly, for a valuation ring $V$ with the field of fraction $K$, the canonical map $H_{e t}^{2}\left(\operatorname{Spec}(V), \mathbb{G}_{m, V}\right) \rightarrow H_{e t}^{2}\left(\operatorname{Spec}(K), \mathbb{G}_{m, K}\right)$ is injective.
