# Well-posedness of martingale problem for SBM with interacting branching

#### Abstract

In this paper a martingale problem for super-Brownian motion with interactive branching is derived. The uniqueness of the solution to the martingale problem is obtained by using the pathwise uniqueness of the solution to a corresponding system of SPDEs with proper boundary conditions. The existence of the solution to the martingale problem and the Hölder continuity of the density process are also studied.


Keywords. super-Brownian motion; interacting branching; function-valued process; stochastic partial differential equation.

## 1 Introduction and main results

Let $M(\mathbb{R})$ be the collection of all finite Borel measures on $\mathbb{R}$. Let $C_{b}^{n}(\mathbb{R})$ be the collection of all bounded continuous functions on $\mathbb{R}$ with bounded derivatives up to $n$th order. We consider a $M(\mathbb{R})$-valued process $\left(X_{t}\right)_{t \geq 0}$ satisfying the following martingale problem (MP): for $\phi \in C_{b}^{2}(\mathbb{R})$, the process

M_{t}(\phi) \equiv\left\langle X_{t}, \phi\right\rangle-\left\langle X_{0}, \phi\right\rangle-\int_{0}^{t}\left\langle X_{s}, \frac{1}{2} \phi^{\prime \prime}\right\rangle d s \tag{1.1}
\end{equation*}
$$

is a continuous martingale with

$$
\begin{equation*}
\langle M(\phi)\rangle_{t}=\int_{0}^{t}\left\langle X_{s}, \gamma\left(\mu_{s}, \cdot\right) \phi^{2}\right\rangle d s \tag{1.2}
\end{equation*}
$$

[^0]where $\gamma$ is the interacting branching rate depending on the density process. The notation $\langle\nu, \phi\rangle$ denotes the integral of the function $\phi$ with respect to the measure $\nu$. In this paper we assume $X_{0}(d x)=\mu_{0}(x) d x$ with $\mu_{0} \in L^{2}(\mathbb{R})$, where $L^{2}(\mathbb{R})$ is the space of functions $f$ such that $\int_{\mathbb{R}} f(x)^{2} d x<\infty$. When $\gamma$ is a constant, the process $\left(X_{t}\right)_{t \geq 0}$ is a super-Brownian motion. In this case the well-posedness of the MP (1.1, (1.2) was established by the nonlinear partial differential equation satisfied by its log-Laplace transform. Moreover, a new approach for the well-posedness of the MP was suggested by Xiong [21], in which a relationship between the super-Brownian motion and a stochastic partial differential equation (SPDE) satisfied by its corresponding distribution-function-valued process was established. The weak uniqueness of the solution to the MP (1.1, (1.2) was also obtained by the strong uniqueness of the solution to the corresponding SPDE in 21]. See He et. al [9] for the case of super-Lévy process.

While the superprocesses with interaction are more natural since the branching and spatial motion for many species depend on the processes themselves. When the spatial motion is interactive, the well-posedness of the martingale problem was studied by Donnelley and Kurtz [4], see also Perkins [15, Theorem V.5.1] and Li et. al [12]. Uniqueness for the historical superprocesses with certain interaction was investigated by Perkins [15]. Furthermore, the superprocesses with interactive immigration were studied by [2, 7, 17], see also Li [11, Section 10]. The well-posedness of the martingale problem for the interactive immigration process was solved by Mytnik and Xiong [14]. See also [22] for the well-posedness of the martingale problem for a superprocess with location-dependent branching, interactive immigration mechanism and spatial motion.

However, the hard case for the superprocess with interactive branching was rarely investigated. We are interested in the case of $\gamma\left(\mu_{s}, x\right)=\gamma\left(\mu_{s}(x)\right)$, i.e., the interactive branching mechanism depending on the density process $\left(\mu_{t}(x)\right)_{t \geq 0, x \in \mathbb{R}}$. However, in this case the well-posedness of the MP (1.1, 1.2) is still an open problem. The weak uniqueness of the solution to the MP (1.1, 1.2) is very difficult to prove. As a first step, throughout this paper we assume $\gamma$ satisfies the following condition:

Condition 1.1. Fixed integer $n \geq 0$. For $-\infty=a_{0}<a_{1}<\cdots<a_{n}<a_{n+1}=\infty$, let

\gamma\left(\mu_{s}, x\right)= \begin{cases}g_{i}^{2}\left(\mu_{s}\left(a_{i+1}\right)\right), & a_{i} \leq x<a_{i+1}, i=0, \cdots, n-1 \\ g_{n}^{2}\left(\int_{a_{n}}^{\infty} \mu_{s}(y) d y\right), & a_{n} \leq x<\infty\end{cases}
$$

where $g_{i}, i=0, \cdots, n$ are positive continuous bounded functions from $\mathbb{R}_{+}$to $\mathbb{R}_{+}$.
The existence and Hölder continuity of the density process $\left(\mu_{t}(x)\right)_{t \geq 0, x \in \mathbb{R}}$ are investigated in this paper, which satisfies the following SPDE:

$$
\begin{equation*}
\frac{\partial}{\partial t} \mu_{t}(x)=\frac{1}{2} \Delta \mu_{t}(x)+\sqrt{\mu_{t}(x) \gamma\left(\mu_{t}, x\right)} \dot{W}(t, x), \tag{1.3}
\end{equation*}
$$

where $\Delta$ denotes the one-dimensional Laplacian operator and $\{W(t, x): t \geq 0, x \in \mathbb{R}\}$ is a time-space Gaussian white noise based on the Lebesgue measure and the dot denotes the derivative in distribution sense. The existence of the solution to the MP (1.1, (1.2) is given by showing the existence of the solution to (1.3). Moreover, we show the weak
uniqueness of the solution to the MP (1.1, 1.2) in Theorem 1.4. The main idea is to relate the MP with a system of SPDEs, which is satisfied by a sequence of corresponding function-valued processes on intervals. The weak uniqueness of solution to the MP follows from the pathwise uniqueness of the solution to the system of SPDEs, see Section 3. Throughout this paper we always assume that all random variables defined on the same filtered probability space $\left(\Omega, \mathscr{F}, \mathscr{F}_{t}, \mathbb{P}\right)$. Let $\mathbb{E}$ denote the corresponding expectation.

The main results of this paper without special explanation are stated as below.
Theorem 1.2. (Existence) There exists a $M(\mathbb{R})$-valued continuous process $\left(X_{t}\right)_{t \geq 0}$ satisfying the MP (1.1, 1.2). Moreover, $X_{t}(d x)$ is absolutely continuous respect to $d x$ with density $\mu_{t}(x)$ satisfying (1.3).

Theorem 1.3. (Joint Hölder continuity) Suppose that $\left(\mu_{t}(x)\right)_{t \geq 0, x \in \mathbb{R}}$ satisfies (1.3) and $\mu_{0}$ is Hölder continuous with exponent $0<\lambda<\frac{1}{2}$. Then $[0, T] \times \mathbb{R} \ni(t, x) \rightarrow \mu_{t}(x)$ is Hölder continuous with exponent $\lambda_{1} / 2$ in time variable and with exponent $\lambda_{2}$ in space variable, where $\lambda_{1}, \lambda_{2} \in(0,1 / 2)$. Namely, there exists a random variable $K \geq 0$ only depending on $\lambda_{1}$ and $\lambda_{2}$ such that

$$
\left|\mu_{t}(x)-\mu_{r}(y)\right| \leq K\left(|t-r|^{\lambda_{1} / 2}+|x-y|^{\lambda_{2}}\right), \quad t, r \in[0, T], x, y \in \mathbb{R}
$$

Theorem 1.4. (Uniqueness) Assume $g_{n}$ is $\beta$-Hölder continuous with $\frac{1}{2} \leq \beta \leq 1$, i.e.,

$$
\begin{equation*}
\left|g_{n}(x)-g_{n}(y)\right| \leq K|x-y|^{\beta}, \quad x, y \geq 0 \tag{1.4}
\end{equation*}
$$

for some constant $K$. Then the weak uniqueness of the solution to the MP (1.1, (1.2) holds.
Remark 1.5. Taking $n=0$ in Condition 1.1, the branching rate depends on the total mass process, i.e., the quadratic variation process of the martingale defined by (1.1) is

\begin{equation*}
\langle M(\phi)\rangle_{t}=\int_{0}^{t} \gamma\left(\left\langle X_{s}, 1\right\rangle\right)\left\langle X_{s}, \phi^{2}\right\rangle d s \tag{1.5}
\end{equation*}
$$

The well-posedness of the MP (1.1, 1.5) is a corollary of Theorem 1.2 and 1.4 .
We introduce some notation. Let $\mathcal{X}_{0}$ be the Hilbert space consisting of all functions $f$ such that

\|f\|_{0}^{2}:=\int_{\mathbb{R}} f(x)^{2} e^{-|x|} d x<\infty
$$

We denote the corresponding inner product by $\langle\cdot, \cdot\rangle_{0}$. Let $\mathscr{B}(\mathbb{R})$ (resp. $\left.\mathscr{B}\left(a_{1}, a_{2}\right)\right)$ denote the Borel $\sigma$-algebra on $\mathbb{R}$ (resp. $\left.\left(a_{1}, a_{2}\right)\right)$. Let $B(\mathbb{R})^{+}$(resp. $\left.C_{b}(\mathbb{R})^{+}\right)$be the collection of all bounded positive (resp. bounded positive continuous) functions on $\mathbb{R}$. Let $B\left[a_{1}, a_{2}\right]$ be the Banach space of bounded measurable functions on $\left[a_{1}, a_{2}\right]$. For $f, g \in B\left[a_{1}, a_{2}\right]$ let $\langle f, g\rangle=\int_{a_{1}}^{a_{2}} f(x) g(x) \mathrm{d} x$. Define $C_{b}\left[a_{1}, a_{2}\right]$ be the set of bounded continuous functions on [ $a_{1}, a_{2}$ ]. For any integer $n \geq 0$, let $C_{b}^{n}\left[a_{1}, a_{2}\right]$ be the subset of $C_{b}\left[a_{1}, a_{2}\right]$ of functions with bounded continuous derivatives up to the $n$th order. Let $C_{c}^{n}\left(a_{1}, a_{2}\right)$ denote the subset of $C_{b}^{n}\left[a_{1}, a_{2}\right]$ of functions with compact supports in $\left(a_{1}, a_{2}\right)$.

The rest of the paper is organized as follows. In Section 2, we give the proofs of Theorem 1.2 and 1.3. The weak uniqueness of the solution to the MP (1.1, (1.2), i.e., the proof of Theorem [1.4, is given in Section 3. Throughout the paper we use $\nabla$ to be the first order spatial differential operator, use $K$ to denote a non-negative constant whose value may change from line to line. In the integrals, we make convention that, for $a \leq b \in \mathbb{R}$,

\int_{a}^{b}=\int_{(a, b]} \quad \text { and } \quad \int_{a}^{\infty}=\int_{(a, \infty)}
$$

## 2 Proofs of Theorem 1.2 and 1.3

In this section, we give the proofs of Theorem 1.2 and 1.3 . The existence of the solution to MP (1.1, 1.2) is obtained by the existence of the corresponding density process. Moreover, the Hölder continuity of density process $\left(\mu_{t}(x)\right)_{t \geq 0, x \in \mathbb{R}}$ is given by a standard argument.

Lemma 2.1. The martingale defined in (1.1 1.2) induces a ( $\mathscr{F}_{t}$ )-martingale measure $\left\{M_{t}(B): t \geq 0, B \in \mathscr{B}(\mathbb{R})\right\}$ satisfying

$$
M_{t}(\phi)=\int_{0}^{t} \int_{\mathbb{R}} \phi(x) M(d s, d x), \quad t \geq 0, \phi \in C_{b}^{2}(\mathbb{R})
$$

where $M(d s, d x)$ is an orthogonal martingale measure on $\mathbb{R}_{+} \times \mathbb{R}$ with covariance measure $d s \int_{\mathbb{R}}\left[\gamma\left(X_{s}, z\right) \delta_{z}(d x) \delta_{z}(d y)\right] X_{s}(d z)$.

Proof. Notice that $\gamma$ is bounded by Condition 1.1. By the MP (1.1, 1.2), one can see that $\mathbb{E}\left[\left\langle X_{t}, 1\right\rangle\right]=\left\langle X_{0}, 1\right\rangle<\infty$. For each $n \geq 1$ we define the measure $\Gamma_{n} \in M(\mathbb{R})$ by

$$
\Gamma_{n}(\phi)=\mathbb{E}\left[\int_{0}^{n} d s \int_{\mathbb{R}} \gamma\left(\mu_{s}, x\right) \phi(x) X_{s}(d x)\right]
$$

with $\phi \in B(\mathbb{R})^{+}$. Then $\Gamma_{n}(\phi) \leq K \int_{0}^{n} \mathbb{E}\left[\left\langle X_{s}, 1\right\rangle\right] d s$ is bounded for each $n \geq 1$. The rest proof follows by changing $c(z)=\gamma\left(\mu_{s}, z\right)$ and $H(z, \mathrm{~d} \nu)=0$ in the proof of Li [11, Theorem 7.25]. We omit it here.

Let $T_{t}(x, d y)$ be the semigroup generated by $\Delta / 2$, which is absolutely continuous with respect to Lebesgue measure $\mathrm{d} y$ with density $p_{t}(x, y)$ satisfying

$$
p_{t}(x, y)=p_{t}(x-y)=\frac{1}{\sqrt{2 \pi t}} \mathrm{e}^{-|x-y|^{2} /(2 t)}
$$

Lemma 2.2. Suppose that $\left(\mu_{t}(x)\right)_{t \geq 0, x \in \mathbb{R}}$ is a solution to (1.3) with $\mu_{0} \in L^{2}(\mathbb{R})$. Then for every $t \geq 0$, we have $\mathbb{E}\left[\left\langle\mu_{t}, 1\right\rangle\right]<\infty$.

Proof. By (1.3) we have

$$
\left\langle\mu_{t}, 1\right\rangle=\left\langle\mu_{0}, 1\right\rangle+\int_{0}^{t} \int_{\mathbb{R}} \sqrt{\mu_{s}(x) \gamma\left(\mu_{s}, x\right)} W(d s, d x)
$$

Notice that $\sqrt{x} \leq x+1$ for any $x \geq 0$. By Hölder's inequality one can check that

$$
\begin{aligned}
\mathbb{E}\left[\left\langle\mu_{t}, 1\right\rangle\right] & \leq\left\langle\mu_{0}, 1\right\rangle+\mathbb{E}\left|\int_{0}^{t} \int_{\mathbb{R}} \sqrt{\mu_{s}(x) \gamma\left(\mu_{s}, x\right)} W(d s, d x)\right| \\
& \leq\left\langle\mu_{0}, 1\right\rangle+K\left[\mathbb{E}\left(\int_{0}^{t} \int_{\mathbb{R}} \mu_{s}(x) d s d x\right)\right]^{1 / 2} \\
& \leq K+K \int_{0}^{t} \mathbb{E}\left[\left\langle\mu_{s}, 1\right\rangle\right] d s .
\end{aligned}
$$

The result follows by Gronwall's inequality.
Similar with Li [11, Theorem 7.26, Theorem 7.28], we have the following result.
Proposition 2.3. Suppose that $\left(X_{t}\right)_{t \geq 0}$ is a solution to the MP (1.1, 1.2). Then for each $t \geq 0$ the random measure $X_{t}(d x)$ is absolutely continuous respect to $d x$ with density $\mu_{t}(x)$ satisfying (1.3). Conversely, assume that $\left(\mu_{t}(x)\right)_{t \geq 0, x \in \mathbb{R}}$ is a solution to (1.3) with $\mu_{0} \in L^{2}(\mathbb{R})$. Then $\left(X_{t}\right)_{t \geq 0}$ satisfies the MP (1.1, 1.2).

Proof. Suppose that $\left(X_{t}\right)_{t \geq 0}$ satisfies the MP (1.1, 1.2). By Lemma 2.1 and the proof of [11, Theorem 7.26], we have

$$
\left\langle X_{t}, \phi\right\rangle=\left\langle X_{0}, T_{t} \phi\right\rangle+\int_{0}^{t} \int_{\mathbb{R}} T_{t-s} \phi(x) M(d s, d x),
$$

where $M(d s, d x)$ is an orthogonal martingale measure defined in Lemma 2.1. Recall that $\gamma$ is bounded by Condition 1.1. Let $\phi \in C_{b}(\mathbb{R})^{+}$and set $p_{t}(x, z)=0$ for all $t \leq 0$. For any $n \geq 1$ we have

$$
\begin{aligned}
& \mathbb{E}\left[\int_{\mathbb{R}} \phi(z) d z \int_{0}^{n} \int_{\mathbb{R}} p_{t-s}(x-z)^{2} \gamma\left(\mu_{s}, x\right) X_{s}(d x) d s\right] \\
& \quad \leq K \mathbb{E}\left[\int_{\mathbb{R}} \phi(z) d z \int_{0}^{t} \int_{\mathbb{R}} p_{t-s}(x-z)^{2} X_{s}(d x) d s\right] \\
& \quad \leq K \sup _{z \in \mathbb{R}} \phi(z) \int_{0}^{t} \frac{\mathbb{E}\left[\left\langle X_{s}, 1\right\rangle\right]}{\sqrt{2 \pi(t-s)}} \mathrm{d} s=K \sup _{z \in \mathbb{R}} \phi(z) \sqrt{t}<\infty .
\end{aligned}
$$

Then by stochastic Fubini's theorem (e.g., see Li [11, Theorem 7.24]), we get $\left\langle X_{t}, \phi\right\rangle=$ $\int_{\mathbb{R}} \mu_{t}(x) \phi(x) d x$ with

$$
\mu_{t}(x)=\int_{\mathbb{R}} p_{t}(x-z) \mu_{0}(z) \mathrm{d} z+\int_{0}^{t} \int_{\mathbb{R}} p_{t-s}(x-z) M(d s, d z) .
$$

By El Karoui and Méléard [5, Theorem III-6], on some extension of the probability space one can define a white noise $W(d s, d z)$ on $\mathbb{R}_{+} \times \mathbb{R}$ based on $d s d z$ such that the following holds:

$$
\begin{equation*}
\mu_{t}(x)=\left\langle\mu_{0}, p_{t}(x-\cdot)\right\rangle+\int_{0}^{t} \int_{\mathbb{R}} \sqrt{\mu_{s}(z) \gamma\left(\mu_{s}, z\right)} p_{t-s}(x-z) W(d s, d z) \tag{2.1}
\end{equation*}
$$

which implies (1.3).

Conversely, suppose that $\mu_{t}(x)$ satisfies (1.3) with $\mu_{0} \in L^{2}(\mathbb{R})$ and denote $X_{t}(d x)=$ $\mu_{t}(x) d x$. It follows from Lemma 2.2 that $X_{t} \in M(\mathbb{R})$ almost surely for every $t \geq 0$. For any $\phi \in C_{b}^{2}(\mathbb{R})$ one can check that

$$
\begin{aligned}
\left\langle X_{t}, \phi\right\rangle= & \int_{\mathbb{R}} \mu_{t}(x) \phi(x) d x \\
= & \int_{\mathbb{R}} \mu_{0}(x) \phi(x) d x+\frac{1}{2} \int_{0}^{t} \int_{\mathbb{R}} \mu_{s}(x) \phi^{\prime \prime}(x) d x d s \\
& +\int_{0}^{t} \int_{\mathbb{R}} \phi(x) \sqrt{\mu_{s}(x) \gamma\left(\mu_{s}, x\right)} W(d s, d x) \\
= & \left\langle X_{0}, \phi\right\rangle+\frac{1}{2} \int_{0}^{t}\left\langle X_{s}, \phi^{\prime \prime}\right\rangle d s+M_{t}(\phi)
\end{aligned}
$$

with $\langle M(\phi)\rangle_{t}$ satisfying (1.2), which completes the proof.
Now we show the existence of the solution to (1.3). For any $T>0$, let $m \geq 1$ and $t_{k}=k T / m$ with $k=0,1, \cdots, m$. Define a sequence of approximation by

\begin{equation*}
\mu_{t}^{m}(x)=\mu_{0}(x)+\frac{1}{2} \int_{0}^{t} \Delta \mu_{s}^{m}(x) d s+\sum_{k=1}^{m} \sqrt{\gamma\left(\mu_{t_{k-1}}^{m}, x\right)} \int_{t_{k-1} \wedge t}^{t_{k} \wedge t} G_{m}\left(\mu_{s}^{m}(x)\right) \dot{W}(s, x) d s \tag{2.2}
\end{equation*}
$$

where

$$
G_{m}(x)=\int_{\mathbb{R}} p_{m^{-1}}(x-y)(\sqrt{|y|} \wedge m) d y
$$

is a Lipschitz function on $[0, \infty)$ for fixed $m \geq 1$ and $\lim _{m \rightarrow \infty} G_{m}(x)=\sqrt{x}$ for all $x \geq 0$. For all $m \geq 1$ and $x \geq 0$, one can check that there is a constant $K>0$ such that

$$
\begin{align*}
G_{m}(x) & \leq \int_{\mathbb{R}} p_{m^{-1}}(x-y)(1+|y|) d y=1+\mathbb{E}\left[\left|B_{m^{-1}}^{x}\right|\right] \leq 1+\left[\mathbb{E}\left(\left|B_{m^{-1}}^{x}\right|^{2}\right)\right]^{1 / 2} \\
& \leq 1+\left(1+x^{2}\right)^{1 / 2} \leq K(x+1) \tag{2.3}
\end{align*}
$$

where $\left(B_{t}^{x}\right)_{t \geq 0}$ is a Brownian motion with initial value $x$. For any $k=1, \cdots, m$, conditioned on $\mathscr{F}_{t_{k-1}}$, it is well known that there is a strong unique non-negative solution $\left\{\mu_{t}^{m}(x): t \in\left[t_{k-1}, t_{k}\right), x \in \mathbb{R}\right\}$ to

$$
\mu_{t}^{m}(x)=\mu_{t_{k-1}}^{m}(x)+\frac{1}{2} \int_{t_{k-1}}^{t} \Delta \mu_{s}^{m}(x) d s+\sqrt{\gamma\left(\mu_{t_{k-1}}^{m}, x\right)} \int_{t_{k-1}}^{t} G_{m}\left(\mu_{s}^{m}(x)\right) \dot{W}(s, x) d s
$$

see [1, Theorem 5.1]. Therefore, the process $\left(\mu_{t}^{m}(x)\right)_{t \geq 0, x \in \mathbb{R}}$ is the unique strong solution to (2.2).

Let $J(x)=\int_{\mathbb{R}} e^{-|y|} \rho(x-y) d y$, where $\rho$ is the mollifier given by $\rho(x)=C \exp \{-1 /(1-$ $\left.\left.x^{2}\right)\right\} 1_{\{|x|<1\}}$, and $C$ is a constant such that $\int_{\mathbb{R}} \rho(x) d x=1$. Then for any $n \geq 1$, there are constants $c_{n}$ and $C_{n}$ such that

$$
\begin{equation*}
c_{n} e^{-|x|} \leq J^{(n)}(x) \leq C_{n} e^{-|x|}, \quad \forall x \in \mathbb{R} \tag{2.4}
\end{equation*}
$$

see (2.1) of Mitoma [13]. We may and will replace $e^{-|x|}$ by $J(x)$ in the definition of the space $\mathcal{X}_{0}$, and define $\langle f, g\rangle_{0}=\int_{\mathbb{R}} f(x) g(x) J(x) d x$ for any $f, g \in C_{b}^{2}(\mathbb{R})$.

Lemma 2.4. Assume that $\mu_{0}$ satisfies $\int_{\mathbb{R}} \mu_{0}(x)^{2 p} J(x) d x<\infty$ for some $p \geq 1$. Then for every $T>0$, we have

$$
\sup _{0 \leq t \leq T, m \geq 1} \mathbb{E}\left[\int_{\mathbb{R}} \mu_{t}^{m}(x)^{2 p} J(x) d x\right]<\infty
$$

Proof. Using the convolution form, the solution $\mu_{t}^{m}(x)$ to (2.2) can be represented as

$$
\begin{align*}
\mu_{t}^{m}(x)= & \left\langle\mu_{0}, p_{t}(x-\cdot)\right\rangle \\
& +\sum_{k=1}^{m} \int_{t_{k-1} \wedge t}^{t_{k} \wedge t} \int_{\mathbb{R}} \sqrt{\gamma\left(\mu_{t_{k-1}}^{m}, z\right)} G_{m}\left(\mu_{s}^{m}(z)\right) p_{t-s}(x-z) W(d s, d z) . \tag{2.5}
\end{align*}
$$

By Hölder's inequality we have

& \quad \leq K \int_{0}^{t} \frac{1}{\sqrt{2 \pi(t-s)}} d s\left|\int_{\mathbb{R}} \mu_{s}^{m}(z)^{2} p_{t-s}(x-z) d z\right|^{p} \cdot\left|\int_{0}^{t} \frac{1}{\sqrt{2 \pi(t-s)}} d s\right|^{p / q} \\
& \quad \leq K \int_{0}^{t} \frac{1}{\sqrt{2 \pi(t-s)}} d s \int_{\mathbb{R}} \mu_{s}^{m}(z)^{2 p} p_{t-s}(x-z) d z
\end{aligned}
$$

with $1 / p+1 / q=1$ and $p, q \geq 1$. By the above inequality, (2.3) and Burkholder-DavisGundy's inequality one can see that

& \mathbb{E}\left[\int_{\mathbb{R}} J(x) d x\left|\sum_{k=1}^{m} \int_{t_{k-1} \wedge t}^{t_{k} \wedge t} \int_{\mathbb{R}} \sqrt{\gamma\left(\mu_{t_{k-1}}^{m}, z\right)} G_{m}\left(\mu_{s}^{m}(z)\right) p_{t-s}(x-z) W(d s, d z)\right|^{2 p}\right] \\
& \leq K \mathbb{E}\left[\int_{\mathbb{R}} J(x) d x\left|\int_{0}^{t} \int_{\mathbb{R}} G_{m}\left(\mu_{s}^{m}(z)\right)^{2} p_{t-s}(x-z)^{2} d s d z\right|^{p}\right] \\
& \leq K \mathbb{E}\left[\int_{\mathbb{R}} J(x) d x\left|\int_{0}^{t} d s \int_{\mathbb{R}}\left(\mu_{s}^{m}(z)^{2}+1\right) p_{t-s}(x-z)^{2} d z\right|^{p}\right] \\
& \leq K+K \mathbb{E}\left[\int_{0}^{t} \frac{1}{\sqrt{2 \pi(t-s)}} d s \int_{\mathbb{R}} J(x) d x \int_{\mathbb{R}} \mu_{s}^{m}(z)^{2 p} p_{t-s}(x-z) d z\right] \\
& \leq K+K \mathbb{E}\left[\int_{0}^{t} \frac{1}{\sqrt{2 \pi(t-s)}} d s \int_{\mathbb{R}} \mu_{s}^{m}(z)^{2 p} d z \int_{\mathbb{R}} J(u+z) p_{t-s}(u) d u\right] \\
& \leq K+K \int_{0}^{t} \frac{1}{\sqrt{t-s}} \mathbb{E}\left[\int_{\mathbb{R}} \mu_{s}^{m}(z)^{2 p} J(z) d z\right] d s .

\end{aligned}
$$

Combining the above inequality, we have

We proceed to proving the tightness of $\left(\mu_{.}^{m}\right)$ in $C([0, T] \times \mathbb{R})$. Denote

By [16, Lemma III4.5], for any $0<s<r<t \leq T$ and $\delta \in(0,1 / 4)$, there is a constant $K=K(T)>0$ such that

\leq & K(t-r)^{\delta} \int_{0}^{r}(r-s)^{-3 \delta / 2} d s\left(\int_{\mathbb{R}}\left[p_{r-s}(x-z)^{4-2 \delta}+p_{t-s}(x-z)^{4-2 \delta}\right] e^{|z|} d z\right)^{1 / 2} \\
& \cdot \mathbb{E}\left[\left(\int_{\mathbb{R}}\left|\mu_{s}^{m}(z)\right|^{2 p} J(z) d z\right)^{1 / 2}\right] \\
\leq & K(t-r)^{\delta}\left[\int_{0}^{r}(r-s)^{-(3+4 \delta) / 4} d s+\int_{0}^{r}(r-s)^{-3 \delta / 2}(t-s)^{-(3-2 \delta) / 4} d s\right] \\
\leq & K(t-r)^{\delta} .
\end{aligned}

By Hölder's inequality, it implies that

\leq & K(t-r)^{\delta+(p-1) / 2}+K(t-r)^{p / 2} \tag{2.8}
\end{align*}

Similarly, by Hölder's inequality and Lemma 2.4 one can see that

& \quad \leq K \int_{r}^{t}(t-s)^{-3 / 4} d s=K(t-r)^{1 / 4}
\end{aligned}
$$

which implies that

& +K(t-r)^{p / 2} \\
\leq & K(t-r)^{1 / 4+(p-1) / 2}+K(t-r)^{p / 2} \tag{2.9}
\end{align*}
$$

The result follows.
Similar with above, we have the following result.

Lemma 2.6. Assume that $\mu_{0}$ satisfies $\int_{\mathbb{R}} \mu_{0}(x)^{2 p} J(x) d x<\infty$ for some $p \geq 1$. For fixed $0<\beta<1$, there is a constant $K$ such that

By Kolmogorov's criteria (see [10, Corollary 16.9]), Lemma 2.5 and Lemma [2.6, for each fixed $T, K>0$, the sequence of laws of $\left\{\mu_{t}^{m}(x):(t, x) \in[0, T] \times[-K, K]\right\}$ on $C([0, T] \times[-K, K])$ is tight, and hence, has a convergent subsequence. By the standard diagonlization argument, there exists a subsequence $\left(\mu_{t}^{m_{k}}, W_{t}^{m_{k}}\right)$ which converges to ( $\mu_{t}, W_{t}$ ) in law on $C([0, T] \times[-K, K])$ for each $K$ and $T$. Therefore, $\left(\mu_{t}^{m_{k}}, W_{t}^{n_{k}}\right)_{t \geq 0}$ converges in law as $k \rightarrow \infty$. Applying Skorokhod's representation (e.g. [6, Theorem 1.8]), on another probability space, there are continuous processes $\left(\hat{\mu}_{t}^{m_{k}}, \hat{W}_{t}^{m_{k}}\right)_{t \geq 0}$ and $\left(\hat{\mu}_{t}, \hat{W}_{t}\right)_{t \geq 0}$ with the same distribution as $\left(\mu_{t}^{m_{k}}, W_{t}^{m_{k}}\right)$ and $\left(\mu_{t}, W_{t}\right)$, respectively. Moreover,

since $\mu_{0}(x) \in L^{2}(\mathbb{R})$. Then by the above and dominated convergence theorem, we have

& \quad \leq K \mathbb{E}\left[\int_{0}^{t} \int_{\mathbb{R}} \hat{\mu}_{s}(z) J(z) d s d z\right] \leq K\left\{\mathbb{E}\left[\int_{0}^{t} \int_{\mathbb{R}} \hat{\mu}_{s}(z)^{2} J(z) d s d z\right]\right\}^{1 / 2}<\infty .
\end{aligned}
$$

It thus follows from [23, Lemma 2.4] that

That completes the existence of solution to (1.3). By Proposition 2.3 one can see that $X_{t}(d x)=\mu_{t}(x) d x$ satisfies the MP (1.1, (1.2), which implies the conclusion.

Proof of Theorem 1.3. Assume that $\left(\mu_{t}(x)\right)_{t \geq 0, x \in \mathbb{R}}$ is a solution to SPDE (1.3). Then it also satisfies (2.1) by Proposition [2.3. For any $0<r \leq t$ and $p \geq 1$, we have

& +K \mathbb{E}\left[\left|\int_{0}^{r} \int_{\mathbb{R}}\left[p_{r-s}(x-z)-p_{t-s}(x-z)\right] \sqrt{\mu_{s}(z)} W(d s, d z)\right|^{2 p}\right] \\
= & K\left(I_{1}+I_{2}+I_{3}\right)
\end{aligned}
$$

Recall that $\mu_{0}$ is Hölder continuous with exponent $\lambda<\frac{1}{2}$. Similar with the proof of [8, Theorem 1.1], by Hölder's inequality one can see that

& \leq K \int_{\mathbb{R}}|x|^{2 p \lambda} \frac{1}{\sqrt{2 \pi(t-r)}} e^{-\frac{x^{2}}{2(t-r)}} d x \leq K(t-r)^{\lambda p},
\end{aligned}
$$

where $\left(B_{t}\right)_{t \geq 0}$ is a standard Brownian motion. Moreover, similar with (2.8) and (2.9) one can see that

I_{3} \leq K \mathbb{E}\left[\left|\int_{0}^{r} \int_{\mathbb{R}}\left[p_{r-s}(x-z)-p_{t-s}(x-z)\right]^{2} \mu_{s}(z) d s d z\right|^{p}\right] \leq K(t-r)^{\delta+(p-1) / 2}
$$

with $\delta \in(0,1 / 4)$. Then there exists $\alpha \in(0,1)$ such that

## 3 Proof of Theorem 1.4

In this section we show the weak uniqueness of the solution to the MP (1.1, 1.2) under Condition 1.1. The main idea of uniqueness is to relate the MP (1.1, (1.2) with a system of SPDEs, which is satisfied by a sequence of corresponding function-valued processes $\left(u_{t}^{i}\right)_{t \geq 0}, i=0,1, \cdots, n$. The weak uniqueness of the solution to the MP (1.1, (1.2) follows from the pathwise uniqueness of the solution to the system of SPDEs.

For a solution $\left(X_{t}\right)_{t \geq 0}$ to the MP (1.1, 1.2), we define the function-valued processes as

In Proposition 3.1 we show that (3.1) is a solution to the following system of SPDEs:

\\
x \in\left[a_{i}, a_{i+1}\right), i=0, \cdots, n-1 ; \\
u_{t}^{n}(x)=u_{0}^{n}(x)+\int_{0}^{t} \frac{1}{2} \Delta u_{s}^{n}(x) d s+\int_{0}^{t} \int_{0}^{u_{s}^{n}(x)} g_{n}\left(u_{s}^{n}(\infty)\right) W_{n}(d s, d z), \\
x \in\left[a_{n}, \infty\right) . \\
u^{i}\left(a_{i}\right)=0, \quad i=0,1, \cdots, n, \\
\nabla u_{t}^{i-1}\left(a_{i}\right)=\nabla u_{t}^{i}\left(a_{i}\right), \quad i=1, \cdots, n

where $u_{s}^{n}(\infty):=\lim _{x \rightarrow \infty} u_{s}^{n}(x)$ and $W_{i}(\mathrm{~d} s, \mathrm{~d} z), i=0, \cdots, n$ are independent time-space white noises on $\mathbb{R}_{+} \times \mathbb{R}_{+}$with intensity $\mathrm{d} s \mathrm{~d} z$. The pathwise uniqueness of the solution to the above system of SPDEs is obtained in Proposition 3.3.

The system of SPDEs (3.2, 3.3) can be understood in the following form: for any $\phi_{i} \in C_{b}^{2}\left[a_{i}, a_{i+1}\right]$ with $\phi_{i}\left(a_{i}\right)=\phi_{i}^{\prime}\left(a_{i+1}\right)=0, i=0,1, \cdots, n-1$, and $\phi_{n} \in C_{b}^{2}\left[a_{n}, \infty\right)$ with $\phi_{n}\left(a_{n}\right)=\phi_{n}(\infty)=0\left(\right.$ given $\phi_{n}(\infty):=\lim _{x \rightarrow \infty} \phi_{n}(x)$ ), we have

& +\int_{0}^{t} \int_{0}^{\infty} \int_{a_{i}}^{a_{i+1}} 1_{\left\{z \leq u_{s}^{i}(x)\right\}} \phi_{i}(x) d x g_{i}\left(\nabla u_{s}^{i}\left(a_{i+1}\right)\right) W_{i}(d s, d z) \\
\left\langle u_{t}^{n}, \phi_{n}\right\rangle= & \left\langle u_{0}^{n}, \phi_{n}\right\rangle+\frac{1}{2} \int_{0}^{t}\left\langle u_{s}^{n}, \phi_{n}^{\prime \prime}\right\rangle d s \\
& +\int_{0}^{t} \int_{0}^{\infty} \int_{a_{n}}^{\infty} 1_{\left\{z \leq u_{s}^{n}(x)\right\}} \phi_{n}(x) d x g_{n}\left(u_{s}^{n}(\infty)\right) W_{n}(d s, d z)
\end{align*}\right.
$$

Proposition 3.1. Suppose that $\left(X_{t}\right)_{t \geq 0}$ is a solution to the MP (1.1, 1.2). Then $\left\{u_{t}^{i}\right.$ : $\left.t \geq 0, x \in\left[a_{i}, a_{i+1}\right)\right\}, i=0,1, \cdots, n$ defined as (3.1), solves the group of SPDEs (3.2 3.3) with boundary condition (3.4).

Proof. For any $\phi_{i} \in C_{c}^{3}\left(a_{i}, a_{i+1}\right)$ with $i=0,1, \cdots, n-1$, by integration by parts, we have

is a continuous martingale. By Lemma 2.1 we have

& =\int_{0}^{t} g_{i}\left(\nabla u_{s}^{i}\left(a_{i+1}\right)\right)^{2} d s \int_{0}^{u_{s}^{i}\left(a_{i+1}\right)} \phi_{i}\left(u_{s}^{i}(y)^{-1}\right)^{2} d y \\
& =\int_{0}^{t} \int_{0}^{\infty}\left(\int_{a_{i}}^{a_{i+1}} 1_{\left\{y \leq u_{s}^{i}(x)\right\}} \phi_{i}^{\prime}(x) d x\right)^{2} g_{i}\left(\nabla u_{s}^{i}\left(a_{i+1}\right)\right)^{2} d s d y
\end{aligned}
$$

where $u_{s}^{i}(y)^{-1}$ denotes the generalized inverse of the nondecreasing function $u_{s}^{i}$, that is,

& =\int_{0}^{t} \int_{0}^{\infty}\left(\int_{a_{n}}^{\infty} 1_{\left\{y \leq u_{s}^{n}(x)\right\}} \phi_{n}^{\prime}(x) d x\right)^{2} g_{n}\left(u_{s}^{n}(\infty)\right)^{2} d s d y
\end{aligned}

Similar with Lemma [2.1, the family $\left\{-M_{t}\left(\phi_{i}\right): t \geq 0, \phi_{i} \in C_{c}^{3}\left(a_{i}, a_{i+1}\right)\right\}$ determines a martingale measure $\left\{M_{t}(B): t \geq 0, B \in \mathscr{B}\left(a_{i}, a_{i+1}\right)\right\}$. Moreover, for $\phi_{i} \in C_{c}^{3}\left(a_{i}, a_{i+1}\right)$ and $\phi_{j} \in C_{c}^{3}\left(a_{j}, a_{j+1}\right)$ with $i \neq j$, we have

& =\int_{0}^{t} \mathrm{~d} s \int_{\mathbb{R}} \gamma\left(X_{s}, z\right) \phi_{i}(z) \phi_{j}(z) X_{s}(d z)=0 .
\end{aligned}
$$

By El Karoui and Méléard [5, Theorem III-7, Corollary III-8], on some extension of the probability space on can define a sequence independent Gaussian white noise $W_{i}(d s, d u), i=$ $0, \cdots, n$ on $(0, \infty)^{2}$ based on $d s d u$ such that

& =\int_{a_{i}}^{a_{i+1}} \phi_{i}^{\prime}(x) d x \int_{0}^{t} \int_{0}^{u_{s}^{i}(x)} g_{i}\left(\nabla u_{s}^{i}\left(a_{i+1}\right)\right) W_{i}(d s, d z) \tag{3.9}
\end{align*}
$$

for any $\phi_{i} \in C_{c}^{3}\left(a_{i}, a_{i+1}\right), i=0, \cdots, n-1$, and

-M_{t}\left(\phi_{n}\right)=\int_{a_{n}}^{\infty} \phi_{n}^{\prime}(x) d x \int_{0}^{t} \int_{0}^{u_{s}^{n}(x)} g_{n}\left(u_{s}^{n}(\infty)\right) W_{n}(d s, d z)
$$

for any $\phi_{n} \in C_{c}^{3}\left(a_{n}, \infty\right)$. Then (3.5) and (3.6) follow from the approximation method and Lemma 4.2 in Appendix.

for any $x \geq a_{n}$. By a change of variable, we have

\left\langle u_{0}^{n}, q_{t}^{x}\right\rangle & =\int_{a_{n}}^{\infty} u_{0}^{n}(y)\left[p_{t}\left(x+a_{n}-y\right)-p_{t}\left(x-a_{n}+y\right)\right] d y \\
& =\int_{-\infty}^{x} u_{0}^{n}\left(x+a_{n}-z\right) p_{t}(z) d z-\int_{x}^{\infty} u_{0}^{n}\left(z-x+a_{n}\right) p_{t}(z) d z \\
& \rightarrow u_{0}^{n}(\infty) \int_{-\infty}^{\infty} p_{t}(z) d z=u_{0}^{n}(\infty)
\end{aligned}
$$

and

$$
\int_{a_{n}}^{\infty} 1_{\left\{z \leq u_{s}^{n}(y)\right\}} q_{t-s}^{x}(y) d y \rightarrow 1_{\left\{z \leq u_{s}^{n}(\infty)\right\}}
$$

as $x \rightarrow \infty$, which ends the proof.

Proposition 3.3. (Pathwise uniqueness) Suppose that $\left(u_{t}\right)_{t \geq 0}$ and $\left(\tilde{u}_{t}\right)_{t \geq 0}$ are two solutions to (3.2, (3.3) satisfying the boundary conditions (3.4). If $u_{0}(x)=\tilde{u}_{0}(x)$ for all $x \in \mathbb{R}$, then $\mathbb{P}\left\{u_{t}(x)=\tilde{u}_{t}(x)\right.$ for all $t \geq 0$ and $\left.x \in \mathbb{R}\right\}=1$.

Proof. The pathwise uniqueness of the solution to (3.10) holds by [3, Theorem 2.1]. Moreover, the pathwise uniqueness of the solution $\left\{u_{t}^{n}(x): t \geq 0, x \in\left[a_{n}, \infty\right)\right\}$ holds for (3.3) by [24, Theorem 1.4]. That implies the strong uniqueness of $\left(\nabla u_{t}^{n}\left(a_{n}\right)\right)_{t \geq 0}$. By the proof of [24, Theorem 1.4] and induction method, one can get the pathwise uniqueness of the solution to (3.2) for $i=0,1, \cdots, n-1$. The proof ends here.

Proof of Theorem 1.4 The result is a direct conclusion of Proposition 3.3,

## 4 Appendix

In this section we give some results about the process $\left(u_{t}(x)\right)_{t \geq 0, x \in[0,1]}$ satisfying the following SPDE:

where $g$ is a positive continuous bounded function from $\mathbb{R}_{+}$to $\mathbb{R}_{+}$, and $W(d s, d z)$ is a time-space Gaussian white noise with density $d s d z$. Let $\Phi \in C_{c}^{2}(0,1)$ satisfies $0 \leq \Phi \leq 2$ and $\int_{0}^{1} \Phi(x) \mathrm{d} x=1$. For $k \geq 1$ and $x \in[0,1]$ let

h_{k}(x):=\int_{0}^{k x} \Phi(z) \mathrm{d} z \cdot \int_{x^{k}}^{1} \Phi(z) \mathrm{d} z . \tag{4.1}
\end{equation*}
$$

Then $h_{k} \in C_{c}^{2}(0,1)$ for all $k \geq 1$.
Lemma 4.1. Suppose that $f \in C[0,1]$ with $f^{\prime}(1)$ and $f^{\prime}(0)$ exist. Then

& =\int_{0}^{1} f(y / k) \Phi(y)\left[\int_{(y / k)^{k}}^{1} \Phi(z) d z\right] d y-\int_{0}^{1} f\left(y^{1 / k}\right) \Phi(y)\left[\int_{0}^{k y^{1 / k}} \Phi(z) d z\right] d y
\end{aligned}
$$

converges to $f(0)-f(1)$, which gives the first assertion.

In the following we prove the second assertion. Observe that

By change of variables and dominated convergence again, as $k \rightarrow \infty$,

& \rightarrow f^{\prime}(0) \int_{0}^{1} y \Phi^{\prime}(y) d y=-f^{\prime}(0) \tag{4.3}
\end{align*}

\int_{0}^{1}[f(x)-f(1)] M_{2, k}(x) d x & =\int_{0}^{1} \frac{f\left(y^{1 / k}\right)-f(1)}{y^{1 / k}-1} k\left(y^{1 / k}-1\right) \Phi\left(y^{1 / k}\right) \Phi(y) d y \\
& \rightarrow 0 \tag{4.4}
\end{align*}
$$

Similarly, as $k \rightarrow \infty$,

\begin{align*}
& \int_{0}^{1}[f(x)-f(1)] M_{3, k}(x) d x \\
& =\int_{0}^{1} \frac{f\left(y^{1 / k}\right)-f(1)}{y^{1 / k}-1} k\left(y^{1 / k}-1\right)\left[k^{-1}(k-1) y^{-1 / k} \Phi(y)\right. \\
& \left.\quad+y^{(k-1) / k} \Phi^{\prime}(y)\right] \cdot\left[\int_{0}^{k y^{1 / k}} \Phi(z) d z\right] d y \\
& \quad \rightarrow f^{\prime}(1) \int_{0}^{1} \ln y\left[\Phi(y)+y \Phi^{\prime}(y)\right] d y=-f^{\prime}(1) . \tag{4.5}
\end{align*}
$$

Applying integration by parts and the fact $0 \leq \Phi \leq 2$ and $\operatorname{supp}(\Phi) \subset(0,1)$,

& =k \int_{0}^{1} \Phi\left(k y^{1 / k}\right) \Phi(y) d y=k \int_{0}^{k^{-k}} \Phi\left(k y^{1 / k}\right) \Phi(y) d y \leq 4 k^{1-k}
\end{aligned}

and

\int_{0}^{1} M_{3, k}(x) d x & =-\int_{0}^{1}\left(\int_{x^{k}}^{1} \Phi(z) d z\right)^{\prime \prime} \cdot\left(\int_{0}^{k x} \Phi(z) d z\right) d x \\
& =\int_{0}^{1} M_{2, k}(x) d x \leq 4 k^{1-k}
\end{aligned}

Then for each $\phi \in C_{b}^{2}[0,1]$,

\left\langle u_{t}, \phi\right\rangle= & \left\langle u_{0}, \phi\right\rangle+\frac{1}{2} \int_{0}^{t}\left[\left\langle u_{s}, \phi^{\prime \prime}\right\rangle+F_{s}(\phi)\right] d s \\
& +\int_{0}^{t} \int_{0}^{\infty} g\left(\nabla u_{s}(1)\right)\left[\int_{0}^{1} 1_{\left\{z \leq u_{s}(x)\right\}} \phi(x) \mathrm{d} x\right] W(d s, d z), \tag{4.7}
\end{align*}
$$

where

$$
\begin{equation*}
F_{s}(\phi):=\left[\phi(1) \nabla u_{s}(1)-\phi(0) \nabla u_{s}(0)\right]-\left[u_{s}(1) \phi^{\prime}(1)-u_{s}(0) \phi^{\prime}(0)\right] . \tag{4.8}
\end{equation*}

Proof. Recall $h_{k}$ in (4.1). For $m \geq 1$ define stopping time $\tau_{m}$ by

& +\int_{0}^{t \wedge \tau_{m}} \int_{0}^{\infty} g\left(\nabla u_{s}(1)\right)\left[\int_{0}^{1} 1_{\left\{z \leq u_{s}(x)\right\}} \phi(x) d x\right] W(d s, d z)
\end{aligned}
$$

Letting $m \rightarrow \infty$ the result holds.
