# INITIAL DEGENERATIONS OF SPINOR VARIETIES

#### Abstract

We construct closed immersions from initial degenerations of the spinor variety $\mathrm{S}_{n}$ to inverse limits of strata associated to even $\Delta$-matroids. As an application, we prove that these initial degenerations are smooth and irreducible for $n \leq 5$ and identify the $\log$ canonical model of the Chow quotient of $\mathrm{S}_{5}$ by the action of the diagonal torus of GL(5). ## 1. Introduction

The pure spinor variety, denoted $S_{n}^{ \pm}$, parameterizes totally isotropic subspaces of a $2 n$ dimensional vector space $V$ equipped with a symmetric, nondegenerate quadratic form of Witt index $n$. From the representation-theoretic viewpoint, $\mathrm{S}_{n}^{ \pm}$is the Lie-type D analog of the Grassmannian. The Wick embedding, similar to the Plücker embedding, realizes $S_{n}^{ \pm}$as a closed subvariety of $\mathbb{P}\left(\wedge^{*} E\right)$, where $E$ is some fixed totally isotropic subspace of $V$. The exterior algebra of $E$ splits as a direct sum of its even and odd parts, i.e., $\wedge^{*} E=$ $\wedge^{\mathrm{ev}} E \oplus \wedge^{\text {odd }} E$, and $\mathrm{S}_{n}^{ \pm}$has two (projectively equivalent) irreducible components $\mathrm{S}_{n}$ and $\mathrm{S}_{n}^{-}$, one contained in $\mathbb{P}\left(\wedge^{\text {ev }} E\right)$ and the other in $\mathbb{P}\left(\wedge^{\text {odd }} E\right)$. Our convention is that $\mathrm{S}_{n} \subset$ $\mathbb{P}\left(\wedge^{\epsilon(n)} E\right)$ where $\epsilon(n)$ is the parity of $n$.

We investigate the initial degenerations of $\mathrm{S}_{n}^{\circ}$-the open dense cell of $\mathrm{S}_{n}$ given by the nonvanishing of all Wick coordinates with $\epsilon(n)$ parity-via their relation to isotropical linear spaces in the sense of Rincón [23]. This work is an extension to the Lie-type D setting of [7] where the author investigates the initial degenerations of the Grassmannian via their relation to tropical linear spaces. Specifically, a vector in the tropical Grassmannian records an initial degeneration and a tropical linear space, and the latter records a diagram of matroid strata parameterized by a regular matroidal subdivision of the hypersimplex. The main result in loc. cit. produces a closed immersion from the initial degeneration into the inverse limit of this diagram. This result has a number of applications to $\operatorname{Gr}_{0}(d, n)$-the open dense cell of $\operatorname{Gr}(d, n)$ given by the nonvanishing of all Plücker coordinates-especially $\mathrm{Gr}_{0}(3,7)$. Specifically, the initial degenerations of $\mathrm{Gr}_{0}(3,7)$ are smooth and irreducible, the tropicalization of $\mathrm{Gr}_{0}(3,7)$ with respect to the Plücker embedding is faithful, and the Chow quotient of $\operatorname{Gr}(3,7)$ by the diagonal torus of $\operatorname{PGL}(7)$ is the $\log$ canonical compactification of the moduli space of 7 lines in $\mathbb{P}^{2}$ in linear general position, partially resolving a conjecture of Hacking, Keel, and Tevelev [17, Conjecture 1.6]. As Grassmannians and matroids are Lie-type A partial flag varieties and Coxeter matroids, respectively, we expect that many of the results in [7] extend to a broader class of partial flag varieties. In this paper, we confirm this expectation in the Lie-type D setting.

There are numerous formulations of Lie-type D Coxeter matroids [3, 4, 5]; we use the language of $\Delta$-matroids. Given $w$ in $\mathrm{TS}_{n}^{\circ}:=\operatorname{Trop}\left(\mathrm{S}_{n}^{\circ}\right)$, we may form an initial degeneration $\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ}$ and an isotropical linear space; the latter encodes a regular subdivision $\Delta_{w}$ of the $\Delta$-hypersimplex $\Delta(n)$ into $\Delta$-matroid polytopes [23]. The collection of totally isotropic subspaces realizing a $\Delta$-matroid $M$ forms a locally-closed subscheme $S_{M} \subset \mathrm{~S}_{n}^{ \pm}$. If $Q$ is a $\Delta$-matroid polytope and $Q^{\prime}$ is a face, then $Q^{\prime}$ is also a $\Delta$-matroid polytope (by the Gelfand-Serganova theorem [3, Theorem 6.3.1]), and there is a morphism $\mathrm{S}_{M_{Q}} \rightarrow \mathrm{~S}_{M_{Q^{\prime}}}$ where, e.g., $M_{Q}$ denotes the $\Delta$-matroid of $Q$. These morphisms determine a diagram of type $\Delta_{w}$, hence we may form the inverse limit $\lim _{\varrho \in \Delta_{w}} S_{M_{Q}}$.

Theorem 1.1. There is a closed immersion $\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ} \hookrightarrow \lim _{\varrho \in \Delta_{w}} \mathrm{~S}_{M_{Q}}$.
We give a geometric interpretation of this closed immersion in $\$ 5$; here is a summary. To define a morphism in ${ }_{w} \mathrm{~S}_{n}^{\circ} \rightarrow \lim _{\longleftarrow}{ }_{Q \in \Delta_{w}} \mathrm{~S}_{M_{Q}}$, we must define a morphism in ${ }_{w} \mathrm{~S}_{n}^{\circ} \rightarrow \mathrm{S}_{M_{Q}}$ for each $Q \in \Delta_{w}$ (and these morphisms must be compatible with the face morphisms). Let $\mathbb{K}=\mathbf{k}\left(\left(t^{\mathbb{R}}\right)\right)$, equip it with its usual $t$-adic valuation, and let $x$ be a k-point of $\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ}$. There is a $\mathbb{K}$-point $q$ of $\mathbb{S}_{n}^{\circ}$ whose exploded tropicalization is $x$ [22]. Let $F_{q} \subset \mathbb{K}^{2 n}$ be the totally isotropic subspace with Wick vector $q$, and $F_{q}^{\circ}=F_{q} \cap\left(\mathbb{K}^{*}\right)^{2 n}$. If $v$ is in the cell of $\operatorname{Trop}\left(F_{q}^{\circ}\right)$ dual to $Q \in \Delta_{w}$, then $\overline{\operatorname{in}_{v} F_{q}^{\circ}}$ is a totally isotropic subspace of $\mathbf{k}^{n}$ that realizes $M_{Q}$. The map $\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ} \rightarrow \mathrm{S}_{M_{Q}}$ takes $x$ to (the Wick vector of) $\overline{\mathrm{in}_{v} F_{q}^{\circ}}$.

Working with the full poset $\Delta_{w}$ is impractical due to its size. Nevertheless, the inverse limit $\lim _{Q \in \Delta_{w}} S_{M_{Q}}$ depends only on the adjacency graph $\Gamma_{w}$ of $\Delta_{w}$. The vertices of $\Gamma_{w}$ correspond to the codimension 0 cells, and two vertices are connected by an edge whenever their corresponding cells intersect along a facet. In \$6, we show how this encodes a diagram of $\Delta$-matroid strata, form the inverse limit $\lim _{\Gamma_{w}} \mathrm{~S}_{M_{Q}}$, and deduce

$$
\lim _{\lim _{w}} S_{M_{Q}} \cong \lim _{\Gamma_{w}} S_{M_{Q}} .
$$

The analogous statement in the Grassmannian setting is due to Cueto [7, Appendix C]. We develop various techniques for evaluating these inverse limits, which we use, together with Theorem 1.1, to prove the following theorem.

Theorem 1.2. The initial degenerations of $\mathrm{S}_{n}^{\circ}$ are smooth and irreducible for $n \leq 5$.
We conclude by studying the birational geometry of $S_{n} / / H$, the Chow quotient of $S_{n}$ by the maximal torus $H$ of the orthogonal group, for $n \leq 5$. There is an ordered basis of $V$ so that the matrix of the quadratic form is

$$
Q=\left[\begin{array}{ll}
0 & I  \tag{1.1}\\
I & 0
\end{array}\right]
$$

The orthogonal group $\mathrm{O}(2 n)$ (with respect to the symmetric form $Q$ ) and its maximal torus $H$ are
$\mathrm{O}(2 n)=\left\{X \in \mathrm{GL}(2 n): X^{T} Q X=Q\right\} \quad$ and $\quad H=\left\{\left[\begin{array}{cc}h^{-1} & 0 \\ 0 & h\end{array}\right]: h \in \mathrm{GL}(n)\right.$ is diagonal $\}$.
Any totally isotropic subspace is the row-span of a full-rank $n \times 2 n$ matrix of the form $[A \mid B]$ where $A B^{T}$ is skew-symmetric [3, Lemma 3.4.1]. The action $H \curvearrowright \mathrm{~S}_{n}$ is given by
right multiplication:

$$
[A \mid B]\left[\begin{array}{cc}
h^{-1} & 0  \tag{1.2}\\
0 & h
\end{array}\right]=\left[A h^{-1} \mid B h\right]
$$

Let us describe how to realize $\mathrm{S}_{n} / / H$ as a compactification of $\mathrm{S}_{n}^{\circ} / H$ inside of a toric variety. We may realize $H$ as a subtorus of the dense torus $T$ of $\mathbb{P}\left(\wedge^{\epsilon(n)} E\right)$, and the scaling action of $T$ on $\mathbb{P}\left(\wedge^{\epsilon(n)} E\right)$ restricts to the action of $H$ on $S_{n}$ from above. The Wick embedding induces an embedding of Chow quotients $\mathrm{S}_{n} / / H \hookrightarrow \mathbb{P}\left(\wedge^{\epsilon(n)} E\right) / / H$. By [15], $\mathbb{P}\left(\wedge^{\epsilon(n)} E\right) / / H$ is the toric variety of the secondary fan of $\Delta(n) / L_{\mathbb{R}}$, where $L$ is the cocharacter lattice of $H$ and $L_{\mathbb{R}}=L \otimes_{\mathbb{Z}} \mathbb{R}$. The locus of matroidal subdivisions is the $\Delta$-Dressian $\operatorname{Dr}(n)$, and we denote by $\Sigma_{n}$ the secondary fan of $\operatorname{Dr}(n)$. The Chow quotient $S_{n} / / H$ is the closure of $\mathrm{S}_{n}^{\circ} / H$ in the toric variety $X\left(\Sigma_{n} / L_{\mathbb{R}}\right)$.

As a consequence of Theorem 1.2, for $n \leq 5, S_{n}^{\circ} / H$ is schön in the sense of Tevelev [25], and $S_{n} / / H$ is a schön compactification of $S_{n}^{\circ} / H$. By general results of Hacking, Keel, and Tevelev in [11], determining the log canonical model of $S_{n} / / H$ amounts to finding a suitable fan structure of $\operatorname{Trop}\left(\mathrm{S}_{n}^{\circ}\right)$ (which equals $\operatorname{Dr}(n)$ by [23, Theorem 4.5]). We show that $S_{n} / / H$ is $\log$ canonical for $n=4$, see Proposition 7.6. For $n=5$, there is a coarser fan $\Sigma_{5}^{\prime}$ supported on $\operatorname{Dr}(5)$; denote by $Y$ the closure of $S_{5}^{\circ} / H$ in $X\left(\Sigma_{5}^{\prime} / L_{\mathbb{R}}\right)$.

Theorem 1.3. The Chow quotient $S_{5} / / H$ is smooth and has a simple normal crossings boundary. The $\log$ canonical model of $\mathrm{S}_{5} / / H$ is $Y$ and the refinement $\Sigma_{5} \rightarrow \Sigma_{5}^{\prime}$ induces a $\log$ crepant resolution $\mathrm{S}_{5} / / H \rightarrow Y$.

Computations and data availability. The software package gfan [14] was used to compute the tropicalization of $S_{5}^{\circ}$ in $\$ 7$, and the $\Delta$-matroid subdivisions in Appendix $A$ were computed using polymake [9]. Also, sage is used to verify Lemma 7.10, No computation takes more than a few seconds on a standard desktop computer. The code may be found at the following website.

Conventions. Let $\mathbf{k}$ be an algebraically closed field of characteristic 0 . Let $[n]=\{0,1, \ldots, n-$ $1\},[n]^{*}=\left\{0^{*}, 1^{*}, \ldots,(n-1)^{*}\right\}$, and $J=[n] \sqcup\left[n^{*}\right]$. Given a set $X$, let $\binom{X}{d}$ the set of all $d$-element subsets of $X$. We use juxtaposition of elements to denote small subsets of $J$, e.g., $i j=\{i, j\}, i j k=\{i, j, k\}$, etc. So, given $\lambda \subset[n]$, we write $\lambda \cup i=\lambda \cup\{i\}, \lambda \backslash i=\lambda \backslash\{i\}$, and $\lambda \Delta i=\lambda \Delta\{i\}$, etc.

## 2. THE PURE SPINOR VARIETY

In this section, we recall the construction of the spinor variety following the conventions in [21, 23]. Let $V=\mathbf{k}^{2 n}$ and $Q$ the quadratic form from (1.1). An $n$-dimensional vector subspace $F \subset V$ is totally isotropic if $x^{T} Q y=0$ for all $x, y \in F$. The pure spinor variety is

$$
\mathrm{S}_{n}^{ \pm}=\{F \subset V: F \text { is an } n \text { dimensional totally isotropic subspace of } V\} .
$$

This space has two irreducible components $\mathrm{S}_{n}$ and $\mathrm{S}_{n}^{-}$, which may be distinguished in the following way. Given $\mu \subset[n]$, set

$$
\bar{\mu}=\mu \cup\left\{i^{*} \in[n]^{*}: i \notin \mu\right\} .
$$

Note that $|\bar{\mu}|=n$ for any $\mu$. Given any $d$-dimensional subspace $F$ of a $m$-dimensional vector space and $\lambda \in\left(\begin{array}{c}{\left[\begin{array}{c}m \\ d\end{array}\right) \text {, let } p_{\lambda}(F) \text { be the } \lambda \text {-th Plücker coordinate of } F \text {. The varieties } S_{n}, ~(1)}\end{array}\right.$ and $\mathrm{S}_{n}^{-}$are

$$
\mathbb{S}_{n}=\left\{F \in \mathbb{S}_{n}^{ \pm}: p_{\bar{\mu}}=0 \text { if } n-|\mu| \text { is odd }\right\}, \quad \mathbb{S}_{n}^{-}=\left\{F \in \mathbb{S}_{n}^{ \pm}: p_{\bar{\mu}}=0 \text { if } n-|\mu| \text { is even }\right\} .
$$

Moreover, this characterization describes $\mathrm{S}_{n}$ as a closed subvariety of the Grassmannian $\operatorname{Gr}(n, 2 n) \subset \mathbb{P}\left(\wedge^{d} V\right)$. Nonetheless, $\mathrm{S}_{n}$ embeds into a smaller projective space, as we now describe.

Denote by $E(n)$ the set of subsets $\lambda$ of $[n]$ such that $n-|\lambda|$ is even. The Wick embedding realizes $\mathrm{S}_{n}$ as a closed subvariety of $\mathbb{P}\left(\mathbf{k}^{E(n)}\right)$; we recall the definition of this map on the open dense affine chart

$$
\begin{equation*}
\mathcal{U}=\left\{F \in \mathbb{S}_{n}: p_{[n]}(F) \neq 0\right\} . \tag{2.1}
\end{equation*}
$$

the Wick embedding looks similar on other affine charts obtained by replacing [ $n$ ] by $\bar{\mu}$ for any $\mu \subset[n]$ (such a subset is called a transversal, see \$5).

In terms of matrices, if $F \in \mathcal{U}$, then $F$ is the row span of the $n \times 2 n$ matrix $\left[I_{n} \mid X\right]$ where $X$ is skew-symmetric. Given $\lambda \subset[n]$, let $X[\lambda]$ denote the skew-symmetric matrix obtained from the rows and columns of $X$ indexed by $\lambda$. Let $q_{\lambda}(F)=\operatorname{Pf}(X[[n] \backslash \lambda])$ where Pf denotes the Pfaffian of a skew-symmetric matrix. Note that $q_{\lambda}(F)=0$ if $n-|\lambda|$ is odd. The Wick embedding restricted to $\mathcal{U}$ is

$$
\mathcal{U} \rightarrow \mathbb{P}\left(\mathbf{k}^{E(n)}\right) \quad F \mapsto\left[q_{\lambda}(F) \mid \lambda \in E(n)\right] .
$$

Thus, $S_{n}$ is the closure of $\mathcal{U}$ in $\mathbb{P}\left(\mathbf{k}^{E(n)}\right)$.
Denote by $\mathbf{k}\left[q_{\lambda}\right]$ the polynomial ring $\mathbf{k}\left[q_{\lambda} \mid \lambda \in E(n)\right]$. The homogeneous ideal $I_{n} \subset$ $\mathbf{k}\left[q_{\lambda}\right]$ of $S_{n}$ is generated by the quadrics

$$
\begin{equation*}
P(\mu, v)=\sum_{i \in v \backslash \mu}(-1)^{\operatorname{sgn}(i ; \mu, v)} q_{\mu \cup i} q_{\nu \backslash i}+\sum_{j \in \mu \backslash v}(-1)^{\operatorname{sgn}(j ; v, \mu)} q_{\mu \backslash i \backslash} q_{v \cup j} \tag{2.2}
\end{equation*}
$$

where $n-|\mu|$ and $n-|v|$ are odd and $|\mu \Delta v| \geq 4$; otherwise $P(\mu, v)=0$. In particular, a monomial $q_{\eta} q_{\lambda}$ cannot appear in both sums in the above expression (this is be important in the proofs of Propositions 3.1 and 4.2). Here, $\operatorname{sgn}(i ; \mu, v)$ equals $(-1)^{\ell}$ where $\ell$ is the number of elements $j \in v$ with $i<j$ plus the number of elements $j^{\prime} \in \mu$ such that $i>j^{\prime}$.

We end this section by considering the first few examples. When $n=1,2$, or $3, \mathrm{~S}_{n}=$ $\mathbb{P}\left(\mathbf{k}^{E(n)}\right)$. The first interesting case is $n=4$, where

$$
I_{4}=\left\langle q_{\varnothing} q_{0123}-q_{01} q_{23}+q_{02} q_{13}-q_{03} q_{12}\right\rangle \subset \mathbf{k}\left[q_{\varnothing}, q_{01}, q_{02}, q_{12}, q_{03}, q_{13}, q_{23}, q_{0123}\right]
$$

When $n=5, I_{5}$ is the ideal of

$$
\mathbf{k}\left[q_{0}, q_{1}, q_{2}, q_{3}, q_{4}, q_{012}, q_{013}, q_{023}, q_{123}, q_{014}, q_{024}, q_{124}, q_{034}, q_{134}, q_{234}, q_{01234}\right]
$$

generated by the quadrics

$$
\begin{array}{ll}
q_{0} q_{123}-q_{1} q_{023}+q_{2} q_{013}-q_{3} q_{012}, & q_{0} q_{124}-q_{1} q_{024}+q_{2} q_{014}-q_{4} q_{012}, \\
q_{0} q_{134}-q_{1} q_{034}+q_{3} q_{014}-q_{4} q_{013,} & q_{0} q_{234}-q_{2} q_{034}+q_{3} q_{024}-q_{4} q_{023} \\
q_{1} q_{234}-q_{2} q_{134}+q_{3} q_{124}-q_{4} q_{123}, & q_{0} q_{01234}-q_{012} q_{034}+q_{013} q_{024}-q_{023} q_{014} \\
q_{1} q_{01234}-q_{012} q_{134}+q_{013} q_{124}-q_{014} q_{123}, & q_{2} q_{01234}-q_{012} q_{234}+q_{023} q_{124}-q_{024} q_{123} \\

## 3. Polytopes and strata of $\Delta$-matroids

A $\Delta$-matroid on $[n]$ is characterized by a nonempty collection $\mathcal{B}(M)$ of subsets of $[n]$ satisfying the symmetric exchange axiom, i.e., for all $\mu, v \in \mathcal{B}(M)$ and $i \in \mu \Delta v$ there is a $j \in \mu \Delta v$, such that $\mu \Delta i j \in \mathcal{B}(M)$. Elements of $\mathcal{B}(M)$ are called bases of $M$. A $\Delta$-matroid is even if $|\mu \Delta v|$ is even for all $\mu, v \in \mathcal{B}(M)$.
3.1. $\Delta$-matroid polytopes. Let $e_{1}, \ldots, e_{n}$ be the standard basis of $\mathbb{R}^{n}$, and given $\lambda=$ $\left\{\lambda_{1}, \ldots, \lambda_{k}\right\}$, let $e_{\lambda}=e_{\lambda_{1}}+\cdots+e_{\lambda_{k}}$. Write $\langle u, v\rangle$ for the standard inner product of the vectors $u, v \in \mathbb{R}^{n}$. The polytope of a $\Delta$-matroid $M$ is

$$
Q_{M}=\operatorname{conv}\left\{e_{\lambda}: \lambda \in \mathcal{B}(M)\right\}
$$

An (even) $\Delta$-matroid polytope is any polytope of the form $Q_{M}$ for some (even) $\Delta$-matroid M.

The faces of a polytope $Q \subset \mathbb{R}^{n}$ are all of the form

$$
\text { face }_{u} Q=\{x \in Q:\langle u, x\rangle \leq\langle u, y\rangle \text { for all } y \in Q\} \quad \text { where } u \in \mathbb{R}^{n} .
$$

Because the status of being an even $\Delta$-matroid polytope is determined by its edges (a consequence of the Gelfand-Serganova theorem, see [23, Theorem 3.5] for a version adapted to $\Delta$-matroids), a face of an even $\Delta$-matroid polytope is an even $\Delta$-matroid polytope. Denote by $M_{u}$ the even $\Delta$-matroid such that $Q_{M_{u}}=$ face $_{u} Q_{M}$; this is the analog of the initial matroid defined in [1]. The bases of $M_{u}$ are

$$
\begin{equation*}
\mathcal{B}\left(M_{u}\right)=\left\{\lambda \in \mathcal{B}(M):\left\langle u, e_{\lambda}\right\rangle \leq\left\langle u, e_{\lambda^{\prime}}\right\rangle \text { for all } \lambda^{\prime} \in \mathcal{B}(M)\right\} . \tag{3.1}
\end{equation*}
$$

3.2. $\Delta$-matroid strata. Given a totally isotropic subspace $F$ of $V$, its $\Delta$-matroid, denoted by $M(F)$, is defined by

$$
\begin{equation*}
\mathcal{B}(M(F))=\left\{\lambda \subset[n]: p_{\bar{\lambda}}(F) \neq 0\right\} . \tag{3.2}
\end{equation*}
$$

This $\Delta$-matroid is necessarily even. A $\Delta$-matroid is realizable if it is the $\Delta$-matroid of a totally isotropic subspace of some $V$. Let $\mathrm{S}_{M} \subset \mathrm{~S}_{n}^{ \pm}$be the locus of isotropic subspaces that realize $M$. We describe $S_{M}$ as a scheme in the following way. Define

- $B_{M}=\mathbf{k}\left[q_{\lambda}: \lambda \in \mathcal{B}(M)\right] ;$
- $I_{M}=\left(\left\langle q_{\lambda}: \lambda \in E(n) \backslash \mathcal{B}(M)\right\rangle+I_{n}\right) \cap B_{M}$;
- $S_{M}$ the multiplicative semigroup generated by $q_{\lambda}$ for $\lambda \in \mathcal{B}(M)$.

Then $S_{M}=T_{M} \cap \operatorname{Proj}\left(B_{M} / I_{M}\right)$ where $T_{M}$ is the dense torus of $\operatorname{Proj}\left(B_{M}\right)$. Frequently it is easier to work with $\operatorname{Spec}\left(R_{M}\right) \cong \mathrm{S}_{M} \times \mathrm{G}_{m}$, where $R_{M}=S_{M}^{-1} B_{M} / I_{M}$. The ideal $I_{M}$ is generated by the quadrics

$$
\begin{equation*}
P_{M}(\mu, v)=\sum_{i \in v \backslash \mu}(-1)^{\operatorname{sgn}(i ; \mu, v)} q_{\mu \cup i} q_{\nu \backslash i}+\sum_{j \in \mu \backslash v}(-1)^{\operatorname{sgn}(j ; v, \mu)} q_{\mu \backslash i} q_{v \cup j} \tag{3.3}
\end{equation*}
$$

such that $\mu \cup i, \mu \backslash j, v \backslash i, v \cup j$ are all bases of $M$; compare this with Equation (2.2).
Similar to the Grassmannian case, the face inclusion $Q_{M_{u}} \subset Q_{M}$ induces a morphism of strata $\mathrm{S}_{M} \rightarrow \mathrm{~S}_{M_{u}}$, as we see in the following proposition.

Proposition 3.1. Suppose $M$ is a $\mathbf{k}$-realizable even $\Delta$-matroid and $u \in \mathbb{R}^{n}$. Then the inclusion $B_{M_{u}} \subset B_{M}$ induces a morphism of strata $\varphi_{M, M_{u}}: S_{M} \rightarrow S_{M_{u}}$. These morphisms satisfy $\varphi_{M, M}=$ $\operatorname{id}_{S_{M}}$ and $\varphi_{M,\left(M_{u}\right)_{v}}=\varphi_{M_{u},\left(M_{u}\right)_{v}} \circ \varphi_{M, M_{u}}$.

Proof. It suffices to show that the extension of $I_{M_{u}} \subset B_{M_{u}}$ to $B_{M}$ is contained in $I_{M}$. Using the quadric generators from (3.3), we must show that $P_{M_{u}}(\mu, v)=0$ or $P_{M_{u}}(\mu, v)=$ $P_{M}(\mu, v)$. Suppose $P_{M_{u}}(\mu, v) \neq 0$. Then there is an $i_{0} \in v \backslash \mu$ such that $\mu \cup i_{0}$ and $v \backslash i_{0}$ are bases of $M_{u}$, or there is a $j_{0} \in \mu \backslash v$ such that $\mu \backslash j_{0}$ and $v \cup j_{0}$ are bases of $M_{u}$. The two situations are symmetric, so we only consider the first one. By (3.1), we have $\left\langle u, e_{\mu \cup i_{0}}\right\rangle=\left\langle u, e_{\nu \backslash i_{0}}\right\rangle \leq\left\langle u, e_{\lambda}\right\rangle$ for all $\lambda \in \mathcal{B}(M)$. We must show that, for all $i \in v \backslash \mu$, (resp. $j \in \mu \backslash v$ ), $\mu \cup i$ and $v \backslash i$ are bases of $M$ if and only if they are bases of $M_{u}$ (resp. $\mu \backslash j$ and $v \cup j$ are bases of $M$ if and only if they are bases of $\left.M_{u}\right)$. Because $\mathcal{B}\left(M_{u}\right) \subset \mathcal{B}(M)$, we need only show the "only if" directions. Suppose $\mu \cup i$ and $v \backslash i$ are bases of $M$. Then

$$
\left\langle u, e_{\mu}\right\rangle+\left\langle u, e_{i_{0}}\right\rangle \leq\left\langle u, e_{\mu}\right\rangle+\left\langle u, e_{i}\right\rangle, \quad \text { and } \quad\left\langle u, e_{v}\right\rangle-\left\langle u, e_{i_{0}}\right\rangle \leq\left\langle u, e_{v}\right\rangle-\left\langle u, e_{i}\right\rangle
$$

so $\left\langle u, e_{i}\right\rangle=\left\langle u, e_{i_{0}}\right\rangle$. Therefore $\left\langle u, e_{\mu \cup i_{0}}\right\rangle=\left\langle u, e_{\mu \cup i}\right\rangle$ and $\left\langle u, e_{\nu \backslash i_{0}}\right\rangle=\left\langle u, e_{\nu \backslash i}\right\rangle$, that is, $\mu \cup i$ and $v \backslash i$ are bases of $M_{u}$. Now suppose $\mu \backslash j$ and $v \cup j$ are bases of $M$. Then

$$
\left\langle u, e_{\mu}\right\rangle+\left\langle u, e_{i_{0}}\right\rangle \leq\left\langle u, e_{\mu}\right\rangle-\left\langle u, e_{j}\right\rangle, \quad \text { and } \quad\left\langle u, e_{v}\right\rangle-\left\langle u, e_{i_{0}}\right\rangle \leq\left\langle u, e_{v}\right\rangle+\left\langle u, e_{j}\right\rangle,
$$

so $\left\langle u, e_{j}\right\rangle=-\left\langle u, e_{i_{0}}\right\rangle$. Therefore $\left\langle u, e_{\mu \cup i_{0}}\right\rangle=\left\langle u, e_{\mu \backslash j}\right\rangle$ and $\left\langle u, e_{\nu \backslash i_{0}}\right\rangle=\left\langle u, e_{v \cup j}\right\rangle$, that is, $\mu \backslash j$ and $v \cup j$ are bases of $M_{u}$, as required. That these morphisms satisfy the requisite functorial properties is clear.
3.3. Symmetries of $\Delta$-matroids. Given a set $X$, denote by $\mathfrak{S}_{X}$ the symmetric group on $X$; if $X=[n]$, we write $\mathfrak{S}_{n}:=\mathfrak{S}_{[n]}$. For $\tau \in \mathfrak{S}_{n}$, let $s_{\tau} \in \mathfrak{S}_{E(n)}$ be the permutation

$$
s_{\tau}: E(n) \rightarrow E(n) \quad \lambda \mapsto\{\tau(i): i \in \lambda\} .
$$

If $\mu \subset[n]$ has an even number of elements, we have a permutation of $E(n)$ given by

$$
t_{\mu}: E(n) \rightarrow E(n) \quad \lambda \mapsto \mu \Delta \lambda
$$

Let $G_{n}=\left\{t_{\mu}: \mu \subset[n],|\mu|\right.$ even $\} \subset \mathfrak{S}_{E(n)}$; this is a group isomorphic to $\left(\mathfrak{S}_{2}\right)^{n-1}$. Following [6, VI.4.8], the type- $D_{n}$ Weyl group, denoted by $W\left(D_{n}\right)$, is

$$
\left.W\left(D_{n}\right)=\left\langle s_{\tau}, t_{\mu}: \tau \in \mathfrak{S}_{n}, \mu \subset[n],\right| \mu \mid \text { even }\right\rangle \leq \mathfrak{S}_{E(n)}
$$

The subgroup $G_{n}$ of $W\left(D_{n}\right)$ is normal since

$$
s_{\tau} t_{\mu} s_{\tau}^{-1}=t_{s_{\tau}(\mu)}
$$

From this, we see that $W\left(D_{n}\right) \cong \mathfrak{S}_{n} \ltimes\left(\mathfrak{S}_{2}\right)^{n-1}$ and $\left|W\left(D_{n}\right)\right|=n!2^{n-1}$.
The action of $W\left(D_{n}\right)$ on $E(n)$ induces an action on the set of subsets of $E(n)$. Thus $W\left(D_{n}\right)$ acts on the set of even $\Delta$-matroids via its action on the bases sets. For example, given an even $\Delta$-matroid $M$ and an even-sized subset $\lambda \subset[n]$, the twist of $M$ by $\lambda$ is the even $\Delta$-matroid with bases $\mathcal{B}(M \Delta \lambda)=\{\mu \Delta \lambda: \mu \in \mathcal{B}(M)\}$; this is just the action of $t_{\lambda} \in W\left(D_{n}\right)$ on $\mathcal{B}(M) \in \mathcal{P}(E(n))$.

## 4. Limits of Spinor strata

4.1. The tropical spinor variety. We recall tropicalization of embedded varieties from the initial degenerations viewpoint; for details see [20, §§2.4-5]. Let $\mathbb{K}$ be a field with valuation val, uniformizing parameter $t$, and residue field $\mathbf{k}$ (e.g., $\mathbb{K}=\mathbf{k}\left(\left(t^{\mathbb{R}}\right)\right)$ ). The valuation plays a significant role in $\$ 5$; the reader interested only in $\mathrm{S}_{n}$ may assume that the valuation is trivial. Let $\mathbb{P}^{a}=\operatorname{Proj}\left(\mathbb{K}\left[x_{0}, \ldots, x_{a}\right]\right), T \subset \mathbb{P}^{a}$ the dense torus, and $N$ the cocharacter lattice of $T$. Via the coordinates on $\mathbb{P}^{a}$, we identify $N$ with $\mathbb{Z}^{a+1} / \mathbb{Z} \cdot(1, \ldots, 1)$. Let
$X \subset \mathbb{P}^{a}$ be a closed irreducible subvariety not contained in any coordinate hyperplane, $I \subset \mathbb{K}\left[x_{0}, \ldots, x_{a}\right]$ its homogeneous ideal, and $X^{\circ}=X \cap T$. If $z=\left(z_{0}, \ldots, z_{a}\right) \in \mathbb{Z}^{a+1}$, we write $x^{z}=x^{z_{0}} \cdots x^{z_{a}}$. Given $w \in N_{\mathbb{R}}:=N \otimes_{\mathbb{Z}} \mathbb{R}$, the $w$-initial form of $f \in \mathbb{K}\left[x_{0}, \ldots, x_{a}\right]$ is

$$
\operatorname{in}_{w} f=\sum_{\langle w, u\rangle+\operatorname{val}\left(c_{u}\right)=W} \overline{t^{-\operatorname{val}\left(c_{u}\right)} c_{u}} x^{u} \in \mathbf{k}\left[x_{0}, \ldots, x_{a}\right]
$$

where $f=\sum c_{u} x^{u}$ and $W=\min \left\{\langle w, u\rangle+\operatorname{val}\left(c_{u}\right): c_{u} \neq 0\right\}$. The initial ideal of $I$ is the homogeneous ideal

$$
\mathrm{in}_{w} I=\left\{\mathrm{in}_{w} f: f \in I\right\} \subset \mathbf{k}\left[x_{0}, \ldots, x_{a}\right]
$$

The tropicalization of $X^{\circ}$ is

$$
\text { Trop } X^{\circ}=\left\{w \in N_{\mathbb{R}}: \operatorname{in}_{w} I_{0} \neq\langle 1\rangle\right\}
$$

This set is the support of a rational polyhedral complex $\Sigma_{\mathrm{Gr}}$, called the Gröbner complex, where $w, w^{\prime}$ belong to the same relatively open cell of $\Sigma_{\mathrm{Gr}}$ if and only if $\mathrm{in}_{w} I=\mathrm{in}_{w^{\prime}} I$. If $\mathbb{K}=\mathbf{k}$, then $\Sigma_{G r}$ is a polyhedral fan. The initial degeneration of $X^{\circ}$ (with respect to $w \in \operatorname{Trop} X^{\circ}$ ) is the scheme

$$
\mathrm{in}_{w} X^{\circ}=T \cap \operatorname{Proj}\left(\mathbf{k}\left[x_{0}, \ldots, x_{a}\right] / \mathrm{in}_{w} I\right)
$$

Frequently, it is easier to work with

$$
\operatorname{Spec}\left(\mathbf{k}\left[x_{0}^{ \pm}, \ldots, x_{a}^{ \pm}\right] / \operatorname{in}_{w} I \cdot \mathbf{k}\left[x_{0}^{ \pm}, \ldots, x_{a}^{ \pm}\right]\right)
$$

which is isomorphic to $\mathrm{in}_{w} X^{\circ} \times \mathrm{G}_{m}$. We remark that $\mathrm{in}_{w} X^{\circ}$ depends on the cone of $\Sigma_{\mathrm{Gr}}$ that contains $w$ in its relative interior, but there may exist $w, w^{\prime}$ belonging to different locally closed cones such that $\mathrm{in}_{w} X^{\circ}=\mathrm{in}_{w^{\prime}} X^{\circ}$. When this happens, $\mathrm{in}_{w} I$ and $\mathrm{in}_{w^{\prime}} I$ differ by primary components contained in $\left\langle x_{0}, \ldots, x_{a}\right\rangle$.

We now specialize to the spinor variety. Let $n \geq 3$ and $\mathrm{S}_{n}^{\circ}$ denote the intersection of $\mathrm{S}_{n}$ with the dense torus in $\mathbb{P}\left(\mathbf{k}^{E(n)}\right)$. Note that $\mathrm{S}_{n}^{\circ}=\mathrm{S}_{M}$ where $M$ is the uniform even $\Delta$-matroid, i.e., $\mathcal{B}(M)=E(n)$. Viewing $S_{M}$ as a closed subvariety of the algebraic torus $\mathbb{G}_{m}^{\mathcal{B}(M)} / \mathbb{G}_{m}$, we may form

$$
\mathrm{TS}_{M}:=\operatorname{Trop}\left(\mathrm{S}_{M}\right), \quad \text { and } \quad \mathrm{TS}_{n}^{\circ}:=\operatorname{Trop}\left(\mathrm{S}_{n}^{\circ}\right)
$$

Label the coordinates of $N_{\mathbb{R}} \cong \mathbb{R}^{E(n)} / \mathbb{R} \cdot(1, \ldots, 1)$ by $f_{\lambda}$ for $\lambda \in E(n)$. The tropicalization $\mathrm{TS}_{n}^{\circ}$ is the support of a $\binom{n}{2}$-dimensional polyhedral fan.

Consider the $L \cong \mathbb{Z}^{n}$-grading $\operatorname{deg}_{L}\left(q_{\lambda}\right)=\sum_{i \in \lambda} e_{i}$. The following proposition is clear from the quadric generators of $I_{n}(2.2)$.
Proposition 4.1. The ideal $I_{n}$ is homogeneous with respect to the L-grading.
Therefore, $\mathrm{TS}_{n}^{\circ}$ has a $n$-dimensional lineality space $L_{\mathbb{R}} \subset N_{\mathbb{R}}$ where

$$
\begin{equation*}
L=\left\langle\sum_{\lambda \ni i} f_{\lambda}, \sum_{\lambda \ngtr i} f_{\lambda}: 0 \leq i \leq n-1\right\rangle \subset N . \tag{4.1}
\end{equation*}
$$

Note that $L$ is a saturated subgroup of $N$, so $N / L$ is torsion-free. Let us describe $\mathrm{TS}_{n}^{\circ}$ for small values of $n$. To simplify our description of $\mathrm{TS}_{n}^{\circ}$, we list the $W\left(D_{n}\right)$-orbits of the cones, where $W\left(D_{n}\right)$ acts on $\mathrm{TS}_{n}^{\circ}$ by

$$
s_{\tau} \cdot f_{\lambda}=f_{s_{\tau}(\lambda)}, \quad t_{\mu} \cdot f_{\lambda}=f_{t_{\mu}(\lambda)}
$$

When $n=3, \mathrm{TS}_{3}^{\circ}=L_{\mathbb{R}}=N_{\mathbb{R}}$. Next, consider the case $n=4$. The saturated subgroup $L \subset N$ is spanned by

$$
\begin{array}{cccc}
f_{01}+f_{02}+f_{03}+f_{0123}, & f_{01}+f_{12}+f_{13}+f_{0123}, & f_{02}+f_{12}+f_{23}+f_{0123}, & f_{03}+f_{13}+f_{23}+f_{0123}, \\
f_{\varnothing}+f_{01}+f_{02}+f_{12}, & f_{\varnothing}+f_{01}+f_{03}+f_{13}, & f_{\varnothing}+f_{02}+f_{03}+f_{23}, & f_{\varnothing}+f_{12}+f_{13}+f_{23} .
\end{array}
$$

There are 4 rays, which have primitive vectors (modulo $L_{\mathbb{R}}$ )

$$
\begin{equation*}
r_{0}=f_{\varnothing}+f_{0123}, r_{1}=f_{01}+f_{23}, r_{2}=f_{02}+f_{13}, r_{3}=f_{03}+f_{12} \tag{4.2}
\end{equation*}
$$

and 6 maximal cones, one corresponding to each pair of rays. Up to $W\left(D_{4}\right)$-symmetry, there is only one ray and one maximal cone. The space $\mathrm{TS}_{5}^{\circ}$ is described in $\$ 7$. In summary, it has a 5 dimensional lineality space, and $f$-vector (resp. $W\left(D_{5}\right)$-symmetric $f$-vector):

$$
f\left(\mathrm{TS}_{5}^{\circ}\right)=(1,36,280,960,1540,912), \quad \text { resp. } \quad f\left(\mathrm{TS}_{5}^{\circ} \quad \bmod W\left(D_{5}\right)\right)=(1,2,3,5,5,4)
$$

4.2. Subdivisions of $\Delta$-matroid polytopes. Given a polytope $Q \subset \mathbb{R}^{n}$ with vertices $v_{0}, \ldots, v_{k}$ and $w \in \mathbb{R}^{k+1}$, the lifted polytope is

$$
Q^{w}=\operatorname{conv}\left\{\left(v_{i}, w_{i}\right): 0 \leq i \leq k\right\} \subset \mathbb{R}^{n} \times \mathbb{R}
$$

Any lower face of $Q^{w}$ is of the form face ${ }_{\mathbf{u}} Q^{w}$ where $\mathbf{u}=(u, 1) \in \mathbb{R}^{n} \times \mathbb{R}$. The lower faces of $Q^{w}$ project onto $Q$, forming a polyhedral complex whose support is $Q$. This is called the regular subdivision of $Q$ induced by $w$. The adjacency graph of this subdivision is the graph with vertex $v_{Q_{i}}$ for each maximal cell $Q_{i}$ and an edge between $v_{Q_{i}}$ and $v_{Q_{j}}$ whenever $Q_{i}$ and $Q_{j}$ share a common facet. The secondary fan $\Sigma_{S}(Q)$ of $Q$ is the complete fan in $\mathbb{R}^{k+1}$ where $w$ and $w^{\prime}$ belong to the relative interior of the same cone if and only if they induce the same regular subdivision on $Q$ [10, §7.C].

Given an even $\Delta$-matroid $M$ and $w \in \mathbb{R}^{\mathcal{B}(M)}$, we write $\Delta_{M, w}$ for the regular subdivision of $Q_{M}$ induced by $w$. This subdivision is matroidal, or $\Delta_{M, w}$ is a matroid subdivision, if each $Q \in \Delta_{M, w}$ is an even $\Delta$-matroid polytope. The $\Delta$-Dressian of $M$ is the subfan of $\Sigma_{S}\left(Q_{M}\right)$ defined by

$$
\operatorname{Dr}_{M}=\left\{w \in \mathbb{R}^{\mathcal{B}(M)}: \Delta_{M, w} \text { is matroidal }\right\} .
$$

When $\mathcal{B}(M)=E(n)$, we write $Q_{M}=\Delta(n), \operatorname{Dr}_{M}=\operatorname{Dr}(n)$, and $\Sigma_{S}\left(Q_{M}\right)=\Sigma_{n}$.
Suppose $\Delta_{M, w}$ is matroidal. Given $u \in \mathbb{R}^{n}$, let $M_{u}^{w}$ be the matroid of the polytope in $\Delta_{M, w}$ determined by face $e_{\mathbf{u}}\left(Q_{M}^{w}\right)$. The bases of $M_{u}^{w}$ are

$$
\begin{equation*}
\mathcal{B}\left(M_{u}^{w}\right)=\left\{\lambda \in \mathcal{B}(M): w_{\lambda}+\left\langle u, e_{\lambda}\right\rangle \leq w_{\lambda^{\prime}}+\left\langle u, e_{\lambda^{\prime}}\right\rangle \text { for all } \lambda^{\prime} \in \mathcal{B}(M)\right\} . \tag{4.3}
\end{equation*}
$$

If $w \in \mathrm{TS}_{M}$, then $\Delta_{M, w}$ is matroidal [23, Theorem 5.4]. In fact, for $n \leq 5$, there is an equality of fans $\mathrm{TS}_{n}^{\circ}=\operatorname{Dr}(n)$, and for $n \geq 7, \operatorname{Dr}(n)$ is strictly larger than $\mathrm{TS}_{n}^{\circ}$ by [loc. cit. Theorem 4.5].
4.3. Finite limits of strata. We consider the following partial order of $\Delta$-matroids: $M^{\prime} \leq$ $M$ means that $Q_{M^{\prime}}$ is a face of $Q_{M}$, and $M^{\prime} \lessdot M$ means that $Q_{M^{\prime}}$ is a facet of $Q_{M}$. We may view, for $w \in \operatorname{Dr}_{M}$, the polyhedral complex $\Delta_{M, w}$ as a finite poset, and hence we may form the inverse limit

$$
\begin{equation*}
\mathrm{S}_{M, w}:=\lim _{Q \in \Delta_{M, v}} \mathrm{~S}_{M_{\mathrm{Q}}} \tag{4.4}
\end{equation*}
$$

If $\mathcal{B}(M)=E(n)$, then we write $S_{w}$ for this limit. Finite inverse limits exist in the category of affine $\mathbf{k}$-schemes because this category has a terminal object and pullbacks [2, Proposition 5.21]. In fact, since Spec is left-adjoint to the global sections functor, it takes direct limits to inverse limits, so the affine coordinate ring of $S_{M, w}$ is the direct limit of the affine coordinate rings of the $S_{M}$ 's.

Proposition 4.2. For any $w \in \mathrm{TS}_{M}$ and $u \in \mathbb{R}^{n}$, the inclusion $B_{M_{u}} \subset B_{M}$ induces a morphism $\psi_{M, M_{u}^{w}}: \mathrm{in}_{w} \mathrm{~S}_{M} \rightarrow \mathrm{~S}_{M_{u}^{w}}$.
Proof. We must show that the extension of $I_{M_{u}^{w}}$ to $B_{M}$ is contained in $\mathrm{in}_{w} I_{M}$. We use the quadric generators listed in Equation (3.3). We must show that $P_{M_{u}^{w}}(\mu, v)=0$ or $P_{M_{u}^{w}}(\mu, v)=\operatorname{in}_{w} P_{M}(\mu, v)$.

Suppose $P_{M_{i}^{w v}}(\mu, v) \neq 0$. Then either there is an $i_{0} \in v \backslash \mu$ such that $\mu \cup i_{0}$ and $v \backslash i_{0}$ are bases of $M_{u}^{w}$, or there is a $j_{0} \in \mu \backslash v$ such that $\mu \backslash j_{0}$ and $v \cup j_{0}$ are bases of $M_{u}^{w}$. The two situations are symmetric, so it suffices to consider the first one. We must show that $q_{\mu \cup i} q_{\nu \backslash i}$ is a monomial of $\mathrm{in}_{w} P_{M}(\mu, v)$ if and only if $\mu \cup i$ and $v \backslash i$ are bases of $M_{u}^{w}$ (resp. $q_{\mu \backslash j} q_{v \cup j}$ is a monomial of $\operatorname{in}_{w} P_{M}(\mu, v)$ if and only if $\mu \backslash j$ and $v \cup j$ are bases of $\left.M_{u}^{w}\right)$.

Let $v_{\lambda}=w_{\lambda}+\left\langle u, e_{\lambda}\right\rangle$. Observe that, for any $i, j \in v \backslash \mu$,

$$
\begin{equation*}
v_{\mu \cup j}+v_{v \backslash j}-v_{\mu \cup i}-v_{v \backslash i}=w_{\mu \cup j}+w_{v \backslash j}-w_{\mu \cup i}-w_{v \backslash i} . \tag{4.5}
\end{equation*}
$$

Recall from the discussion after Equation (2.2) that, since $|\mu \Delta \nu| \geq 4$, a monomial $q_{\eta} q_{\lambda}$ cannot appear in both sums in Equation (3.3), i.e., we need not be concerned with cancellations between the two sums. Let $q_{\mu \cup i} q_{\nu \backslash i}$ be a monomial in $P_{M}(\mu, v)$. The term $q_{\mu \cup i} q_{v \backslash i}$ is a monomial of $\mathrm{in}_{w} P_{M}(\mu, v)$ if and only if

$$
\begin{aligned}
& w_{\mu \cup i}+w_{v \backslash i} \leq w_{\mu \cup i^{\prime}}+w_{\nu \backslash i^{\prime}} \quad \text { and } \\
& w_{\mu \cup i}+w_{v \backslash i} \leq w_{\mu \backslash j^{\prime}}+w_{v \cup j^{\prime}}
\end{aligned}
$$

for all $i^{\prime}, j^{\prime}$, if and only if

$$
\begin{aligned}
& v_{\mu \cup i}+v_{v \backslash i} \leq v_{\mu \cup i^{\prime}}+v_{v \backslash i^{\prime}} \quad \text { and } \\
& v_{\mu \cup i}+v_{v \backslash i} \leq v_{\mu \backslash j^{\prime}}+v_{v \cup j^{\prime}}
\end{aligned}
$$

for all $i^{\prime}, j^{\prime}$, if and only if $v_{\mu \cup i}+v_{v \backslash i}=v_{\mu \cup i_{0}}+v_{v \backslash i_{0}}$, if and only if $\mu \cup i$ and $v \backslash i$ are bases of $M_{u}^{w}$. A similar argument shows that, if $q_{\mu \backslash j} q_{v \cup j}$ is a monomial of $P_{M}(\mu, v)$, then $q_{\mu \backslash j} q_{v \cup j}$ is a monomial of $\mathrm{in}_{w} P_{M}(\mu, v)$ if and only if $\mu \backslash j$ and $v \cup j$ are bases of $M_{u}^{w}$.

Theorem 4.3. For any $w \in \mathrm{TS}_{M}$ the morphisms $\psi_{M, M_{u}^{w}}$ induce a closed immersion

$$
\psi_{M, w}: \mathrm{in}_{w} \mathrm{~S}_{M} \hookrightarrow \mathrm{~S}_{M, w}
$$

Proof. Clearly $\varphi_{M_{u}^{w},\left(M_{u}^{\Psi u}\right)_{v}} \circ \psi_{M, M_{u}^{w}}=\psi_{M,\left(M_{u}^{w}\right)_{v}}$, so $\psi_{M, w}$ is defined by the universal property of inverse limits. For each $q_{\lambda}$ for $\lambda \in \mathcal{B}(M)$, there is a $Q \in \Delta_{M, w}$ such that $\lambda \in \mathcal{B}\left(M_{Q}\right)$, in which case

$$
\psi_{M, w}^{\#}\left(q_{\lambda}\right)=\psi_{M, M_{Q}}^{\#}\left(q_{\lambda}\right)=q_{\lambda} .
$$

So the morphism $\psi_{M, w}^{\#}: \underset{Q \in \Delta_{M, w}}{ } R_{M_{Q}} \rightarrow S_{M}^{-1} B_{M} / \mathrm{in}_{w} I_{M}$ is surjective, and therefore $\psi_{M, w}$ is a closed immersion.

## 5. SYMMETRIC MATROIDS AND INITIAL DEGENERATIONS OF TOTALLY ISOTROPIC SUBSPACES

In this section, we provide the geometric description of Theorem 4.3 as described in the introduction. This requires a notion of circuits for $\Delta$-matroids, which are better understood in the language of symmetric matroids. The reader interested in the applications of Theorem 4.3 may skip to the next section.

Let $J=[n] \sqcup[n]^{*}$. Define an involution $J \rightarrow J$ by $i \mapsto i^{*}$ and $\left(i^{*}\right)^{*}=i$ for $i \in[n]$. Given $\lambda \subset J$, let $\lambda^{*}=\left\{i^{*}: i \in \lambda\right\}$. The subset $\lambda$ is admissible if $\lambda \cap \lambda^{*}=\varnothing$, and is a transversal if, additionally, $|\lambda|=n$. A symmetric matroid $M$ is determined by a nonempty set of transversals $\mathcal{B}(M)$ satisfying the symmetric exchange axiom: for every $\mu, v \in \mathcal{B}(M)$ and $i \in \mu \Delta v$, there is a $j \in \mu \Delta v$ such that $\mu \Delta i i^{*} j j^{*} \in \mathcal{B}(M)$ (compare this to the symmetric exchange axiom used to define $\Delta$-matroids). An element of $\mathcal{B}(M)$ is called a basis of $M$.

Symmetric matroids go by many different names in the literature, see [3, §4] and the references therein. The data of a symmetric matroid on $J$ is also equivalent to the data of a $\Delta$-matroid on $[n]$. Given a $\Delta$-matroid $M$, its associated symmetric matroid $\bar{M}$ is defined by

$$
\mathcal{B}(\bar{M})=\{\bar{\mu}: \mu \in \mathcal{B}(M)\} .
$$

Conversely, given a symmetric matroid $M$, its associated $\Delta$-matroid $\underline{M}$ is defined by

$$
\mathcal{B}(\underline{M})=\{\lambda \cap[n]: \lambda \in \mathcal{B}(M)\} .
$$

Let $M$ be a symmetric matroid on $J$. A subset of $J$ is independent if it is contained in a basis, and dependent otherwise. A circuit is an admissible minimal dependent subset, and the set of all circuits of $M$ is denoted by $\mathcal{C}(M)$. We use a similar notation for ordinary matroids, i.e., if $M$ is an ordinary matroid, then we denote by $\mathcal{B}(M)$ the bases of $M$ and the circuits of $M$ by $\mathcal{C}(M)$.

Let $F$ be a totally isotropic subspace of $V$. The symmetric matroid of $F$ is $\overline{M(F)}$ where $M(F)$ is the $\Delta$-matroid of $F$ defined in (3.2). Explicitly,

$$
\mathcal{B}(\overline{M(F)})=\left\{\lambda \subset J: \lambda \text { is a transversal and } p_{\lambda}(F) \neq 0\right\}
$$

The (ordinary) matroid of $F$, denoted by $M_{\mathrm{A}}(F)$, is given by

$$
\mathcal{B}\left(M_{\mathrm{A}}(F)\right)=\left\{\lambda \subset J: p_{\lambda}(F) \neq 0\right\} .
$$

That is, the bases of $\overline{M(F)}$ are just the bases of $M_{\mathrm{A}}(F)$ that are admissible.
Given an $m \times n$ matrix $X$ and subsets $\mu \subset[m], v \subset[n]$, denote by $X[\mu, v]$ the submatrix of $X$ whose rows are indexed by $\mu$ and columns are indexed by $\nu$. We abbreviate $X[\mu, \mu]$ by $X[\mu]$.

Lemma 5.1. Let $X$ be a skew-symmetric $n \times n$ matrix and let $\lambda$ be a subset of $[n]$ with $k$ elements. Then, for distinct $i, j \in[n]$, we have

$$
\operatorname{det}(X[\lambda \backslash i, \lambda \backslash j])= \begin{cases} \pm \operatorname{Pf}(X[\lambda \backslash i]) \operatorname{Pf}(X[\lambda \backslash j]) & \text { if } k \text { is odd } \\ \pm \operatorname{Pf}(X[\lambda]) \operatorname{Pf}(X[\lambda \backslash i j]) & \text { if } k \text { is even. } .\end{cases}
$$

Additionally, $\operatorname{det}(X[\nu, \mu])= \pm \operatorname{det}(X[\mu, v])$.
Proof. This was originally proved by Cayley, see [18, p. 11] and the references therein.

Lemma 5.2. Let $X$ be a skew-symmetric $n \times n$ matrix and let $F$ be the totally isotropic subspace given by the row span of $W:=[I \mid X]$. Let $\tau \in \mathcal{B}(\overline{M(F)})$ such that $|[n] \backslash \tau|$ is even. Then, for $i \in \tau$ and $j \notin \tau$, we have

$$
\operatorname{det}(W[[n], \tau \Delta i j])= \pm \operatorname{Pf}(X[[n] \backslash \tau]) \operatorname{Pf}\left(X\left[[n] \backslash\left(\tau \Delta i i^{*} j j^{*}\right)\right]\right)
$$

Remark 5.3. In terms of Plücker and Wick coordinates, this proposition says that

$$
p_{\tau \Delta i j}(F)= \pm q_{\tau \cap[n]}(F) q_{\left(\tau \Delta i i^{*} j j^{*}\right) \cap[n]}(F)
$$

Proof. First, observe that if $i=j^{*}$, then $\operatorname{det}(W[[n], \tau \Delta i j])$ and $\operatorname{Pf}\left(X\left[[n] \backslash\left(\tau \Delta i i^{*} j j^{*}\right)\right]\right)$ equal 0 . Therefore, we assume that $i \neq j^{*}$. For brevity, let $v=[n] \backslash \tau$. Before considering the four cases, depending on whether $i$ or $j$ lie in $[n]$ or $[n]^{*}$, we record some useful formulas:
(1) $\operatorname{det}(W[[n], \sigma])= \pm \operatorname{det}\left(X\left[[n] \backslash \sigma,[n] \cap \sigma^{*}\right]\right)$ for any $\sigma \subset J$ of size $n$.
(2) $[n] \backslash(\tau \Delta i j)=v \cup\left([n] \cap i i^{*}\right) \backslash j j^{*}$
(3) $[n] \cap(\tau \Delta i j)^{*}=v \cup\left([n] \cap j j^{*}\right) \backslash i i^{*}$

If $i, j \in[n]$, then $i \notin v, j \in v$. The above formulas and Lemma 5.1 applied to $\lambda=v \cup i$ yield

$$
\operatorname{det}(W[[n], \tau \Delta i j])= \pm \operatorname{det}(X[v \Delta i j, v])= \pm \operatorname{Pf}(X[v]) \operatorname{Pf}(X[v \Delta i j])
$$

If $i, j \in[n]^{*}$, then $i^{*} \in v, j^{*} \notin v$ and we have

$$
\left.\left.\operatorname{det}(W[[n], \tau \Delta i j])= \pm \operatorname{det}\left(X\left[v, v \Delta i^{*} j^{*}\right)\right]\right)= \pm \operatorname{Pf}(X[v]) \operatorname{Pf}\left(X\left[v \Delta i^{*} j^{*}\right)\right]\right)
$$

If $i \in[n]$ and $j \in[n]^{*}$, then $i \notin v, j^{*} \notin v$ and we have

$$
\operatorname{det}(W[[n], \tau \Delta i j])= \pm \operatorname{det}\left(X\left[v \cup i, v \cup j^{*}\right]\right)= \pm \operatorname{Pf}(X[v]) \operatorname{Pf}\left(X\left[v \cup i j^{*}\right]\right)
$$

If $i \in[n]^{*}$ and $j \in[n]$, then $i^{*} \in v, j \in v$ and we have

$$
\operatorname{det}(W[[n], \tau \Delta i j])= \pm \operatorname{det}\left(X\left[v \backslash j, v \backslash i^{*}\right]\right)= \pm \operatorname{Pf}(X[v]) \operatorname{Pf}\left(X\left[v \backslash i^{*} j\right]\right)
$$

In each of these cases, we get the desired result.
If $\tau \in \mathcal{B}\left(M_{\mathrm{A}}(F)\right)$ and $j \in J \backslash \tau$, then $\tau \cup j$ contains a unique circuit $\gamma(\tau, j)$ of $M_{\mathrm{A}}(F)$ given by

$$
\begin{equation*}
\gamma(\tau, j)=\left\{i \in \tau: \tau \Delta i j \in \mathcal{B}\left(M_{\mathrm{A}}(F)\right)\right\} \cup\{j\} \tag{5.1}
\end{equation*}
$$

Similarly, if $\tau \in \mathcal{B}(\overline{M(F)})$ and $j \in J \backslash \tau$, then $\tau \cup j$ contains a unique circuit $\bar{\gamma}(\tau, j)$ of $\overline{M(F)}$ given by

$$
\begin{equation*}
\bar{\gamma}(\tau, j)=\left\{i \in \tau: \tau \Delta i i^{*} j j^{*} \in \mathcal{B}(\overline{M(F)})\right\} \cup\{j\} \tag{5.2}
\end{equation*}
$$

Every circuit of $M_{\mathrm{A}}(F)$, resp. $\overline{M(F)}$, is of the form $\gamma(\tau, j)$, resp. $\bar{\gamma}(\tau, j)$.
Lemma 5.4. If $\tau \in \mathcal{B}(\overline{M(F)})$ and $j \in J \backslash \tau$, then

$$
\gamma(\tau, j)=\bar{\gamma}(\tau, j)
$$

Proof. Without loss of generality, assume that $[n] \in \mathcal{B}(\overline{M(F)})$. Note that $n-|\tau \cap[n]|$ is even and $q_{\tau \cap[n]}(F) \neq 0$. By Lemma 5.2, we have that $i \in \gamma(\tau, j) \backslash j$ if and only if $p_{\tau \Delta i j}(F) \neq 0$, if and only if $q_{\left(\tau \Delta i i^{*} j j^{*}\right) \cap[n]}(F) \neq 0$, if and only if $\tau \Delta i i^{*} j j^{*} \in \mathcal{B}(\overline{M(F)})$, if and only if $i \in \bar{\gamma}(\tau, j) \backslash j$.

The set $\gamma(\tau, j)=\bar{\gamma}(\tau, j)$, is called the fundamental circuit of the pair $(\tau, j)$.
Fix a Plücker vector $p(F)$ and a Wick vector $q(F)$ for $F$; assume that these are compatible in the sense that $p_{\lambda}(F)=q_{\lambda \cap[n]}(F)=1$ for some $\lambda \in \mathcal{B}(\overline{M(F)})$. View $F$ as a subscheme of $\operatorname{Spec}\left(\mathbf{k}\left[y_{i}, y_{i^{*}}\right]\right)$ where $\mathbf{k}\left[y_{i}, y_{i^{*}}\right]=\mathbf{k}\left[y_{i}, y_{i^{*}}: i=1, \ldots, n\right]$, and let $I_{F}$ be the ideal of $F$. For $\tau \in \mathcal{B}\left(M_{\mathrm{A}}(F)\right)$ and $j \in J \backslash \tau$, there is, up to scaling, a unique linear form in $I_{F}$ with support $\gamma=\gamma(\tau, j)$. It is given by

$$
\ell_{\gamma}(F)=(-1)^{\operatorname{sg}(j, j ; \tau)} p_{\tau}(F) y_{j}+\sum_{i \in \tau}(-1)^{\operatorname{sg}(i, j ; \tau)} p_{\tau \Delta i j}(F) \cdot y_{i} .
$$

where sg is some sign function that is not important for us. Now suppose $\tau \in \mathcal{B}(\overline{M(F)})$ and $j \in J \backslash \tau$. Then $\ell_{\gamma}(F)$ is a scalar multiple of the form

$$
m_{\gamma}(F)=(-1)^{\operatorname{sg}^{\prime}(j, j ; \tau)} q_{\tau \cap[n]}(F) y_{j}+\sum_{i \in \tau}(-1)^{\operatorname{sg}^{\prime}(i, j, \tau)} q_{\left(\tau \Delta i i^{*} * j^{*}\right) \cap[n]}(F) \cdot y_{i}
$$

where $\mathrm{sg}^{\prime}$ is some other sign function that is not important for us. Indeed, $\ell_{\gamma}=q_{\tau \cap[n]} m_{\gamma}$ by Lemma 5.2. Also note that $\operatorname{supp}\left(\ell_{\gamma}(F)\right)=\operatorname{supp}\left(m_{\gamma}(F)\right)=\gamma$ by (5.1), (5.2) and Lemma 5.4, where supp denotes the support of a linear form.

Proposition 5.5. The ideal of $F$ is generated by these linear forms, i.e.,

$$
I_{F}=\left\langle\ell_{\gamma}(F): \gamma \in \mathcal{C}\left(M_{\mathrm{A}}(F)\right)\right\rangle=\left\langle m_{\gamma}(F): \gamma \in \mathcal{C}(\overline{M(F)})\right\rangle .
$$

Moreover, $\left\{\ell_{\gamma}(F): \gamma \in \mathcal{C}\left(M_{\mathrm{A}}(F)\right\}\right.$ is a universal Gröbner basis for $I_{F}$.
Proof. The first equality and the last statement follows from [20, Lemma 4.1.4]. Now consider the last equality. Each $m_{\gamma}(F)$ lies in $I_{F}$ because $m_{\gamma}(F)$ is a multiple of $\ell_{\gamma}(F)$. Fix $\tau \in \mathcal{B}(\overline{M(F)})$. The set $\left\{m_{\gamma(\tau, j)}(F): j \notin \tau\right\}$ is a basis for the null space of $F$, and hence we get the second equality.

We end this section by making precise the geometric characterization of Theorem 4.3 presented in the introduction. Let $M$ be an even $\Delta$-matroid, $x$ be a k-point of $\mathrm{in}_{w} \mathrm{~S}_{M}$, and $\mathbb{K}=\mathbf{k}\left(\left(t^{\mathbb{R}}\right)\right)$. By surjectivity of exploded tropicalization [22], there is a $\mathbb{K}$-point $q$ of $S_{M}$ such that $\mathfrak{T r o p}(q)=x$. Let $F_{q} \subset \operatorname{Spec}\left(\mathbb{K}\left[y_{i}, y_{i^{*}}\right]\right)$ be the totally isotropic subspace with Wick vector $q$, and $F_{q}^{\circ}$ the intersection of $F_{q}$ with the dense torus $\operatorname{Spec}\left(\mathbb{K}\left[y_{i}^{ \pm}, y_{i^{*}}^{ \pm}\right]\right)$. By Proposition $\left[5.6\right.$ below, if $(-u, u) \in \operatorname{Trop}\left(F_{q}^{\circ}\right)$ then $\overline{i n}_{(-u, u)} F_{q}^{\circ}$ is totally isotropic, and a realization of $M_{u}^{w}$. Therefore, the map $\operatorname{in}_{w} S_{M} \rightarrow S_{M_{u}^{w}}$ takes $x$ to (the Wick vector of) $\mathrm{in}_{(-u, u)} F_{q}^{\circ}$.

Proposition 5.6. Suppose $(-u, u) \in \operatorname{Trop}\left(F_{q}^{\circ}\right)$. The closure of $\mathrm{in}_{(-u, u)} F_{q}^{\circ}$ in $\mathbf{k}^{2 n}$ is totally isotropic, and realizes the $\Delta$-matroid $M_{u}^{w}$.

Proof. By Proposition 4.2, the vector $\bar{x}=\left(x_{\mu}: \mu \in \mathcal{B}\left(M_{u}^{w}\right)\right) \times 0 \in \mathbf{k}^{\mathcal{B}\left(M_{u}^{w}\right)} \times \mathbf{k}^{E(n) \backslash \mathcal{B}\left(M_{u}^{w}\right)}$ lies in $S_{M_{u}^{w}}$. That is, $\bar{x}$ is the Wick vector of a totally isotropic subspace $F_{\bar{x}}$ realizing $S_{M_{u}^{w}}$. We claim that $\overline{\mathrm{in}_{(-u, u)} F_{q}^{o}}=F_{\bar{x}}$. Let $I_{F_{q}}$ be the ideal of $F_{q}$ in $\mathbb{K}\left[y_{i}, y_{i^{*}}\right]$ and $I_{F_{\bar{x}}}$ the ideal of $F_{\bar{x}}$ in $\mathbf{k}\left[y_{i}, y_{i^{*}}\right]$. The linear forms $\ell_{\gamma}\left(F_{q}\right)$ form a universal Gröbner basis for $I_{F_{q}}$, so

$$
\operatorname{in}_{(-u, u)} I_{F_{q}}=\left\langle\operatorname{in}_{(-u, u)} \ell_{\gamma}\left(F_{q}\right): \gamma \in \mathcal{C}\left(M_{\mathrm{A}}\left(F_{q}\right)\right)\right\rangle \subset \mathbf{k}\left[y_{i}, y_{i^{*}}\right]
$$

Because $I_{F_{\bar{x}}}$ and $\operatorname{in}_{(-u, u)} I_{F_{q}}$ define $n$-dimensional linear subschemes of $\operatorname{Spec}\left(\mathbf{k}\left[y_{i}, y_{i^{*}}\right]\right)$, it suffices to show $I_{F_{\bar{x}}} \subset \operatorname{in}_{(-u, u)} I_{F_{q}}$. Given $\tau \in \mathcal{B}\left(\overline{M_{u}^{w}}\right)$ and $j \in J \backslash \tau$, let $\gamma$ be the fundamental circuit of $(\tau, j)$ in $\bar{M}$, and $\gamma^{\prime}$ the fundamental circuit of $(\tau, j)$ in $\overline{M_{u}^{w}}$. That is,

$$
\begin{aligned}
\gamma & =\left\{i \in \tau: \tau \Delta i i^{*} j j^{*} \in \mathcal{B}(\bar{M})\right\} \cup\{j\}, \\
\gamma^{\prime} & =\left\{i \in \tau: \tau \Delta i i^{*} j j^{*} \in \mathcal{B}(\bar{M}) \text { and }\left\langle u, e_{\left(\tau \Delta i i^{*} j j^{*}\right) \cap[n]}\right\rangle+w_{\left(\tau \Delta i i^{*} j j^{*}\right) \cap[n]} \text { is minimal }\right\} \cup\{j\}
\end{aligned}
$$

We have

$$
\operatorname{in}_{(-u, u)} m_{\gamma}\left(F_{q}\right)=(-1)^{\operatorname{sg}^{\prime}(j, j ; \tau)} x_{\tau \cap[n]} y_{j}\left(F_{q}\right)+\sum_{i \in \gamma^{\prime \prime}}(-1)^{\operatorname{sg}^{\prime}(i, j, \tau)} x_{\left(\tau \Delta i i^{*} j^{*}\right) \cap[n]}\left(F_{q}\right) \cdot y_{i}
$$

where

$$
\gamma^{\prime \prime}=\left\{i \in \tau \backslash j: \tau \Delta i i^{*} j j^{*} \in \mathcal{B}(\bar{M}) \text { and }\left\langle(-u, u), e_{i}\right\rangle+w_{\left(\tau \Delta i i^{*} j j^{*}\right) \cap[n]} \text { is minimal }\right\} .
$$

By the equality

$$
\left\langle u, e_{\left(\tau \Delta i i^{*} j j^{*}\right) \cap[n]}\right\rangle-\left\langle(-u, u), e_{i}\right\rangle=\left\langle u, e_{\left(\tau \Delta j j^{*}\right) \cap[n]}\right\rangle
$$

we see that $\operatorname{supp}\left(\operatorname{in}_{(-u, u)} m_{\gamma}\left(F_{q}\right)\right)=\gamma^{\prime \prime} \cup j=\gamma^{\prime}$, and therefore $\operatorname{in}_{(-u, u)} m_{\gamma}\left(F_{q}\right)=m_{\gamma^{\prime}}\left(F_{\bar{x}}\right)$. By Proposition 5.5 and because every circuit $\gamma^{\prime}$ of $\overline{M_{u}^{w}}$ is a fundamental circuit of some pair $(\tau, j)$, we see that $I_{F_{\bar{x}}} \subset \operatorname{in}_{(-u, u)} I_{F_{q}}$, as required.

## 6. Affine coordinates for strata

6.1. Affine coordinates. Throughout this subsection, we fix an even $\Delta$-matroid $M$ on $[n]$ that has $[n]$ as a basis. This means that $S_{M}$ is contained in open cell $\mathcal{U}$ from (2.1), so every $F \in S_{M}(\mathbf{k})$ is the row span of a $\mathbf{k}$-valued $n \times 2 n$ matrix of the form $\left[I_{n} \mid X_{F}\right]$ where $X_{F}$ is skew-symmetric. Let $X$ be the skew-symmetric matrix of variables

$$
X=\left[\begin{array}{ccccc}
0 & x_{01} & x_{02} & \cdots & x_{0, n-1} \\
-x_{01} & 0 & x_{12} & \cdots & x_{1, n-1} \\
-x_{02} & -x_{12} & 0 & \cdots & x_{2, n-1} \\
\cdots & \cdots & \cdots & \cdots & \cdots \\
-x_{0, n-1} & -x_{1, n-1} & -x_{2, n-1} & \cdots & 0
\end{array}\right]
$$

As before, let $X[\lambda]$ denote the submatrix of $X$ whose rows and columns are indexed by $\lambda$, and $\operatorname{Pf}(X[\lambda])$ the Pfaffian of $X[\lambda]$. Define
$-B_{M}^{x}=\mathbf{k}\left[x_{i j}:[n] \backslash i j \in \mathcal{B}(M)\right] ;$

- $I_{M}^{x}=\langle\operatorname{Pf}(X[[n] \backslash \lambda]): \lambda \in E(n) \backslash \mathcal{B}(M)\rangle \cap B_{M}^{x}$;
- $S_{M}^{x}$ the multiplicative semigroup generated by $\{\pi(\operatorname{Pf}(X[[n] \backslash \lambda])): \lambda \in \mathcal{B}(M)\}$ where $\pi: \mathbf{k}\left[x_{i j}\right] \rightarrow \mathbf{k}\left[x_{i j}\right] /\left\langle x_{i j}:[n] \backslash\{i j\} \in E(n) \backslash \mathcal{B}(M)\right\rangle \cong B_{M}^{x}$ is the quotient map.
The coordinate ring of $S_{M}$ is isomorphic to

$$
R_{M}^{x}=\left(S_{M}^{x}\right)^{-1} B_{M}^{x} / I_{M}^{x} .
$$

Proposition 6.1. Suppose [ $n$ ] is a basis of both $M$ and $M_{u}$. The induced morphism $\varphi_{M, M_{u}}^{\#}$ : $R_{M_{u}}^{x} \rightarrow R_{M}^{x}$ is given by $\varphi_{M, M_{u}}^{\#}\left(x_{i j}\right)=x_{i j}$.

Proof. Set

$$
\tilde{R}_{M}=S_{M}^{-1} \mathbf{k}\left[q_{\lambda} / q_{[n]} \mid \lambda \in \mathcal{B}(M)\right] / I_{M}
$$

The map $q_{\lambda} / q_{[n]} \mapsto \operatorname{Pf}_{\lambda}(X)$ determines an isomorphism $\theta_{M}: \tilde{R}_{M} \rightarrow R_{M}^{x}$. By Proposition 3.1, the morphism $\varphi_{M, M_{u}}: \mathrm{S}_{M} \rightarrow \mathrm{~S}_{M_{u}}$ induces the ring homomorphism $\psi: \tilde{R}_{M_{u}} \rightarrow \tilde{R}_{M}$ given by $\psi\left(q_{\lambda} / q_{[n]}\right)=q_{\lambda} / q_{[n]}$. The induced map $\varphi_{M, M_{u}}^{\#}$ is equal to $\theta_{M_{u}} \circ \psi \circ \theta_{M}^{-1}$, which takes $x_{i j}$ to $x_{i j}$, as required.

We illustrate the affine coordinates construction with the following example, which we use in the proof of Theorem6.12.
Example 6.2. Suppose $K$ is the even $\Delta$-matroid on [5] with

$$
\mathcal{B}(K)=\{0,1,012,013,014,034,134,01234\}
$$

Then

$$
B_{K}^{x}=\mathbf{k}\left[x_{02}, x_{12}, x_{23}, x_{24}, x_{34}\right], \quad I_{K}^{x}=\langle 0\rangle, \quad \text { and } \quad S_{K}^{x}=\left\langle x_{02}, x_{12}, x_{23}, x_{24}, x_{34}\right\rangle_{\text {semigp }}
$$

and hence $R_{K}^{x}=\mathbf{k}\left[x_{02}^{ \pm}, x_{12}^{ \pm}, x_{23}^{ \pm}, x_{24}^{ \pm}, x_{34}^{ \pm}\right]$. This shows that $\mathrm{S}_{K} \cong \mathbb{G}_{m}^{5}$. The polytope $Q_{K}$ has two facets not contained in $\partial \Delta(5)$ which are defined by the vectors $u=(1,1,-1,1,-1)$ and $v=(1,1,-1,-1,1)$. The initial $\Delta$-matroids $K_{u}$ and $K_{v}$ have bases

$$
\mathcal{B}\left(K_{u}\right)=\{0,1,012,014,034,134,01234\} \quad \mathcal{B}\left(K_{v}\right)=\{0,1,012,013,034,134,01234\} .
$$

The coordinate rings of $\mathrm{S}_{K_{u}}$ and $\mathrm{S}_{K_{v}}$ are

$$
R_{K_{u}}^{x}=\mathbf{k}\left[x_{02}^{ \pm}, x_{12}^{ \pm}, x_{23}^{ \pm}, x_{34}^{ \pm}\right], \quad R_{K_{v}}^{x}=\mathbf{k}\left[x_{02}^{ \pm}, x_{12}^{ \pm}, x_{24}^{ \pm}, x_{34}^{ \pm}\right] .
$$

Therefore, $\mathrm{S}_{K_{u}}$ and $\mathrm{S}_{K_{v}}$ are isomorphic to $\mathrm{G}_{m}^{4}$, The morphisms

$$
\varphi_{K, K_{u}}: \mathrm{S}_{K} \rightarrow \mathrm{~S}_{K_{u}} \quad \varphi_{K, K_{v}}: \mathrm{S}_{K} \rightarrow \mathrm{~S}_{K_{v}}
$$

may be identified with coordinate projections of tori; in particular, they are smooth and surjective with connected fibers.
Lemma 6.3. The morphism $\left(\varphi_{K, K_{u}}, \varphi_{K_{u}, K_{v}}\right): \mathrm{S}_{K} \rightarrow \mathrm{~S}_{K_{u}} \times \mathrm{S}_{K_{v}}$ is a closed immersion.
Proof. The induced map on coordinate rings is

$$
\varphi_{K, K_{u}}^{\#} \otimes \varphi_{K_{,} K_{v}}^{\#}: R_{K_{u}}^{x} \otimes_{\mathbf{k}} R_{K_{v}}^{x} \rightarrow R_{K}^{x}
$$

which is surjective; see the explicit description of these maps above.
6.2. Inverse limits over a graph. In this subsection we show that, to compute the inverse limit $\mathrm{S}_{M, w}$ in (4.4), we do not need the full poset $\Delta_{M, w}$, just those cells of codimension 0 and 1. In other words, we show that $S_{M, w}$ may be computed as a limit over a diagram recorded by the adjacency graph $\Gamma_{M, w}$. We begin by recalling this general construction, see [7, Appendix A] for details.

Let $\mathcal{C}$ be a category that has finite limits; by [2, Proposition 5.21], it is necessary and sufficient that $\mathcal{C}$ has fiber products and a terminal object. Let $G$ be a connected graph, possibly with loops or multiple edges. We view each edge as a pair of half-edges. Define a quiver $Q(G)$ in the following way. The set of vertices of $Q(G)$ is $V(G) \cup E(G)$; write $q_{v}$ (resp. $q_{e}$ ) for the vertex of $Q(V)$ corresponding to the vertex $v$ (resp. edge $e$ ). For each half-edge $h \in e$ adjacent to $v$, there is an arrow $q_{v} \rightarrow q_{e}$. Viewing $Q(G)$ as a category in the usual way, a diagram of type $Q(G)$ in $\mathcal{C}$ is a functor $X: Q(G) \rightarrow \mathcal{C}$.

Let $\Gamma_{M, w}$ be the adjacency graph of a matroid subdivision $\Delta_{M, w}$. Let $M_{v}$, resp. $M_{e}$, denote the $\Delta$-matroid corresponding to the vertex $v$, resp. edge $e$, of $\Gamma_{M, w}$, and $\varphi_{M_{v}, M_{e}}$ : $\mathrm{S}_{M_{v}} \rightarrow \mathrm{~S}_{M_{e}}$ whenever $e$ is incident to $v$. The data of $\mathrm{S}_{M_{v}}, \mathrm{~S}_{M_{e}}$, and $\varphi_{M_{v}, M_{e}}$ defines a diagram of type $Q\left(\Gamma_{M, w}\right)$ in $\mathbf{k}$-sch.

Let $\left(\Delta_{M, w}\right)^{\text {top }}$ be the set of top-dimensional cells of $\Delta_{M, w}$, and $A$ be a nonempty subset of $\left(\Delta_{M, w}\right)^{\text {top }}$. We isolate some properties of $A$ that allows for different ways to study limits of spinor strata over full subgraphs $\Gamma_{M, w}[A]:=\Gamma_{M, w}\left[\left\{v_{Q}: Q \in A\right\}\right]$ of the adjacency graph $\Gamma_{M, w}$ and their relation to initial degenerations of spinor varieties.

- The subset $A$ is basis-covering if

$$
\bigcup_{Q \in A} \mathcal{B}\left(M_{Q}\right)=\mathcal{B}(M)
$$

- The subset $A$ is basis-intersecting

$$
\bigcap_{Q \in A} \mathcal{B}\left(M_{Q}\right) \neq \varnothing
$$

- The subset $A$ is basis-connecting if, for each $\beta \in \bigcup_{Q \in A} \mathcal{B}\left(M_{Q}\right)$, the induced subgraph

$$
\Gamma_{M, w}\left[\left\{v_{Q}: Q \in A \text { and } \beta \in \mathcal{B}\left(M_{Q}\right)\right\}\right]
$$

is connected.
Proposition 6.4. For any even $\Delta$-matroid $M$ and $w \in \operatorname{Dr}_{M}$, the set $\left(\Delta_{M, w}\right)^{\text {top }}$ is basis-covering and basis-connecting. Moreover,

$$
\mathrm{S}_{M, w} \cong \lim _{\Gamma_{M, w}} \mathrm{~S}_{M_{Q}} .
$$

Proof. The analog of this proposition for limits of thin Schubert cells in the Grassmannian follows from [7, Propositions C.11-12]. The proof in the spinor strata case is analogous.

Next, we show how to compute the coordinate ring of inverse limits over the graphs $\Gamma_{M, w}$. First, in Wick coordinates, define

- $B=\mathbf{k}\left[q_{\lambda}: \lambda \in \bigcup_{Q \in A} \mathcal{B}\left(M_{Q}\right)\right] ;$
- $I=\sum_{Q \in A} I_{M_{Q}} \cdot B$;
- $S$ is the multiplicative semigroup generated by $\left\{q_{\lambda}: Q \in A\right.$ and $\left.\lambda \in \mathcal{B}\left(M_{Q}\right)\right\}$. Set $R(A)=S^{-1} B / I$.

For affine coordinates, we must assume $A$ is basis-intersecting, say $\lambda$ lies in the intersection of all bases sets. After twisting each $M_{Q}$ by $[n] \backslash \lambda$, we may assume that $\lambda=[n]$. Define

- $B^{x}=\mathbf{k}\left[x_{i j}:[n] \backslash i j \in \bigcup_{Q \in A} \mathcal{B}\left(M_{Q}\right)\right] ;$
- $I^{x}=\sum_{Q \in A} I_{M_{Q}}^{x} \cdot B^{x}$;
- $S^{x}$ is the multiplicative semigroup generated by

$$
\left\{\pi_{Q}(\operatorname{Pf}(X[\lambda])): Q \in A \text { and }[n] \backslash \lambda \in \mathcal{B}\left(M_{Q}\right)\right\}
$$

where $\pi_{Q}$ is the composition

$$
\mathbf{k}\left[x_{i j}\right] \rightarrow \mathbf{k}\left[x_{i j}\right] /\left\langle x_{i j}:[n] \backslash i j \notin \mathcal{B}\left(M_{Q}\right)\right\rangle \cong B_{M_{Q}}^{x} \subset B^{x} .
$$

Set $R^{x}(A)=\left(S^{x}\right)^{-1} B^{x} / I^{x}$.
Proposition 6.5. If $A$ is basis-connecting, then

$$
\underset{\Gamma_{M, w}[A]}{\lim _{M}} R_{M_{Q}} \cong R(A) .
$$

If, in addition, $[n] \in \mathcal{B}\left(M_{Q}\right)$ for all $Q \in A$ (so $A$ is basis-intersecting), then

$$
\underset{\Gamma_{M, w}[A]}{\lim _{M_{Q}}} R^{x} \cong R^{x}(A)
$$

Proof. We prove the second statement, the first one is similar, see also [7, Proposition 3.7]. Let $\hat{A}$ denote the set of all $Q \in \Delta_{M, w}$ such that either $v_{Q} \in V\left(\Gamma_{M, w}[A]\right)$ or $e_{Q} \in E\left(\Gamma_{M, w}[A]\right)$. For each $Q \in \hat{A}$, we have a ring homomorphism $R_{M_{Q}}^{x} \rightarrow R^{x}(A)$ defined by $x_{i j} \mapsto x_{i j}$. These piece together to give a ring homomorphism $\Psi: \underset{\Gamma_{M, w}[A]}{ } R_{M_{Q}}^{x} \rightarrow R^{x}(A)$. We define a ring homomorphism $\Theta$ that is an inverse to $\Psi$.

If $[n] \backslash i j \in \mathcal{B}\left(M_{Q}\right)$ for some $Q \in A$ then set $\Theta\left(x_{i j}\right)=\varphi_{M_{Q}}^{\#}\left(x_{i j}\right)$. Suppose $Q^{\prime} \in A$ is another cell such that $[n] \backslash i j \in \mathcal{B}\left(M_{Q^{\prime}}\right)$. If $Q^{\prime \prime}:=Q \cap Q^{\prime}$ lies in $\hat{A}$, then $\varphi_{M_{Q}}^{\#}\left(x_{i j}\right)=$ $\varphi_{M_{Q^{\prime \prime}}}^{\#}\left(x_{i j}\right)=\varphi_{M_{Q^{\prime}}}^{\#}\left(x_{i j}\right)$. Because $A$ is basis-connecting, there is a sequence $Q=Q_{0}, Q_{1}, \ldots, Q_{k}=$ $Q^{\prime}$ such that, for each $\ell$, we have $[n] \backslash i j \in \mathcal{B}\left(M_{Q_{\ell}}\right)$ and $Q_{\ell} \cap Q_{\ell+1}$ is a facet of $Q_{\ell}$ and $Q_{\ell+1}$. Then

$$
\varphi_{M_{Q}}^{\#}\left(x_{i j}\right)=\varphi_{M_{Q_{0} \cap Q_{1}}}^{\#}\left(x_{i j}\right)=\varphi_{M_{Q_{1}}}^{\#}\left(x_{i j}\right)=\cdots=\varphi_{M_{Q^{\prime}}}^{\#}\left(x_{i j}\right)
$$

so $\Theta: B^{x} \rightarrow{\underset{\longrightarrow}{l, w}[A]}^{\lim _{M_{Q}}^{x}}$ is well defined. Also, $\Theta(z)$ is invertible for any $z \in S^{x}$. Finally, we need to show that $I^{x} \subset \operatorname{ker}(\Theta)$. It suffices to show that $\Theta(z f)=0$ for $z \in\left(S^{x}\right)^{-1} B^{x}$ and $f \in I_{M_{Q}}^{x}$ for some $Q \in A$, which follows from the fact that $\Theta(a f)=\Theta(a) \varphi_{M_{Q}}^{\#}(f)=0$. Therefore, $\Theta$ induces a ring homomorphism $\Theta: R^{x}(A) \rightarrow \lim _{\Gamma_{M, w}[A]} R_{M_{Q^{\prime}}}^{x}$, which is clearly an inverse to $\Psi$.

Being basis-covering implies that the morphism $\operatorname{in}_{w} S_{M} \rightarrow \lim _{\Gamma_{\Gamma_{M, w}[A]}} S_{M_{Q}}$ is a closed immersion.

Proposition 6.6. If $A \subset\left(\Delta_{M, w}\right)^{\text {top }}$ is basis-covering, then the morphisms $\mathrm{in}_{w} \mathrm{~S}_{M} \rightarrow \mathrm{~S}_{M_{Q}}$ induce a closed immersion $\mathrm{in}_{w} \mathrm{~S}_{M} \hookrightarrow \lim _{\Gamma_{M, v}[A]} \mathrm{S}_{M_{\mathrm{Q}}}$.
Proof. The morphism $\operatorname{in}_{w} S_{M} \hookrightarrow \lim _{\Gamma_{M, w}[A]} S_{M_{Q}}$ is defined by the universal property of inverse limits, and the induced morphism on coordinate rings is surjective because every basis of $M$ is a basis of some $\mathcal{B}\left(M_{Q}\right)$ for $Q \in A$.
Proposition 6.7. If $A \subset\left(\Delta_{w}\right)^{\text {top }}$ is basis-covering, basis-intersecting, and basis-connecting, then $\lim _{\Gamma_{w}[A]} \mathrm{S}_{M_{Q}}$ is isomorphic to an open dense subvariety of $\mathbb{A}^{\binom{n}{2}}$. In particular, $\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ} \cong$ $\varliminf_{\mathrm{lim}_{\Gamma_{w}}[A]} S_{M_{Q}}$ and these are smooth and irreducible of dimension $\binom{n}{2}$.
Proof. Being basis-intersecting and basis-connecting implies that $\lim _{\Gamma_{w}[A]} S_{M_{Q}}$ is isomorphic to a locally-closed subvariety of $\mathbb{A}^{\binom{n}{2}}$ by Proposition 6.5; in particular, the dimension of $\lim _{\Gamma_{w}[A]} S_{M_{Q}}$ is at most $\binom{n}{2}$. Because $A$ is basis-covering, there is a closed immersion
$\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ} \hookrightarrow \lim _{\Gamma_{w}[A]} \mathrm{S}_{M_{Q}}$ by Proposition 6.6, and the dimension of $\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ}$ is $\binom{n}{2}$ since this is a flat degeneration of $S_{n}^{\circ}$. Therefore, the dimension of $\lim _{\Gamma_{w}[A]} S_{M_{Q}}$ is exactly $\binom{n}{2}$, so $\varliminf_{\lim _{W_{w}}[A]} S_{M_{Q}}$ is an open subvariety of $\mathbb{A}^{\binom{n}{2}}$. The last statement follows from the fact that a closed immersion between integral affine schemes of the same dimension is an isomorphism, see [7, Proposition A.8].

Corollary 6.8. If $\left(\Delta_{w}\right)^{\text {top }}$ is basis-intersecting, then $\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ} \cong \mathrm{S}_{w}$. Furthermore, they are smooth and irreducible varieties of dimension $\binom{n}{2}$.

Proof. By Proposition 6.4, $\left(\Delta_{w}\right)^{\text {top }}$ is already basis-covering and basis-connecting. The corollary now follows from Proposition 6.7.

Example 6.9. Up to $W\left(D_{4}\right)$-symmetry, there are only 3 matroid subdivisions of $\Delta(4)$. One is the trivial subdivision, and the adjacency graphs for the other two are recorded in Table 6.1. From this data, and Corollary 6.8, we conclude that $\mathrm{in}_{w} \mathrm{~S}_{4}^{\circ}$ is smooth and irreducible for all $w \in \mathrm{TS}_{4}^{\circ}$.

Table 6.1. Matroidal subdivisions of $\Delta(4)$; the rays $r_{i}$ are listed in (4.2)

Proposition 6.10. Suppose that there is a $Q \in\left(\Delta_{w}\right)^{\text {top }}$ such that $v_{Q}$ is adjacent to exactly 2 vertices $v_{Q_{1}}, v_{Q_{2}}$ which are themselves adjacent, and $A=\left(\Delta_{w}\right)^{\text {top }} \backslash\{Q\}$ is basis-covering. Then $A$ is basis-connecting. If $A$ is also basis-intersecting, then $\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ}$ is smooth and irreducible.

Proof. First, we show that $A$ is basis-connecting. Let $\beta \in E(n)$ and

$$
\begin{aligned}
& H_{\beta}=\Gamma_{w}\left[\left\{v_{Q^{\prime}}: Q^{\prime} \in\left(\Delta_{w}\right)^{\text {top }} \text { and } \beta \in \mathcal{B}\left(M_{Q^{\prime}}\right)\right\}\right] \\
& H_{\beta}^{\prime}=\Gamma_{w}\left[\left\{v_{Q^{\prime}}: Q^{\prime} \in A \text { and } \beta \in \mathcal{B}\left(M_{Q^{\prime}}\right)\right\}\right] .
\end{aligned}
$$

By Proposition 6.4, $H_{\beta}$ is connected. If $\beta \notin \mathcal{B}\left(M_{Q}\right)$, then $H_{\beta}^{\prime}=H_{\beta}$ and hence connected. Suppose $\beta \in \mathcal{B}\left(M_{Q}\right)$. By hypothesis, there is an edge between $v_{Q_{1}}$ and $v_{Q_{2}}$. If $v_{Q_{1}}, v_{Q_{2}} \in$ $V\left(H_{\beta}^{\prime}\right)$, then there is still an edge of $H_{\beta}^{\prime}$ between $v_{Q_{1}}, v_{Q_{2}}$, and hence $H_{\beta}^{\prime}$ is connected. Otherwise, either $v_{Q_{1}}$ or $v_{Q_{2}}$ is in $V\left(H_{\beta}^{\prime}\right)$ since $H_{\beta}$ is connected. This means that $v_{Q}$ is a leaf-vertex of $H_{\beta}$, so $H_{\beta}^{\prime}$ is connected. Therefore, $A$ is basis-connected. The last statement now follows from Proposition 6.7.

Lemma 6.11. Suppose we have a pullback diagram of finite-dimensional affine schemes

where $f: X \rightarrow Z$ is a closed immersion, $W$ is irreducible, and $W \times_{Z} X$ has the same dimension as $W$. Then $W \times_{Z} X \cong W$.

Proof. The morphism $f^{\prime}: W \times_{Z} X \rightarrow W$ is a closed immersion because closed immersions are preserved by arbitrary base change [12, Exercise II.3.11(a)], so $f^{\prime}$ is an isomorphism by [7. Proposition A.8].

Theorem 6.12. For $n \leq 5$, the initial degenerations of $\mathrm{S}_{n}^{\circ}$ are smooth and irreducible.
Proof. For $n=1,2,3, S_{n}=\mathbb{P}\left(\mathbf{k}^{E(n)}\right)$, so the initial degenerations of $S_{n}^{\circ}$ are clearly smooth and irreducible. The $n=4$ case is handled in Example 6.9, but we can also see this directly because $I_{4}$ is a principal ideal. Up to $W\left(D_{4}\right)$-symmetry, there are only 3 cones of $\mathrm{TS}_{4}^{\circ}$. Representative weight vectors are

$$
w_{0}=0, \quad w_{1}=f_{03}+f_{12}, \quad w_{2}=f_{02}+f_{12}+f_{03}+f_{13}
$$

The initial ideals are

$$
\begin{aligned}
& \mathrm{in}_{w_{0}} I_{4}=\left\langle q_{\varnothing} q_{0123}-q_{01} q_{23}+q_{02} q_{13}-q_{03} q_{12}\right\rangle, \\
& \mathrm{in}_{w_{1}} I_{4}=\left\langle q_{\varnothing} q_{0123}-q_{01} q_{23}+q_{02} q_{13}\right\rangle, \\
& \mathrm{in}_{w_{2}} I_{4}=\left\langle q_{\varnothing} q_{0123}-q_{01} q_{23}\right\rangle .
\end{aligned}
$$

These define smooth and irreducible varieties in the dense torus of $\mathbb{P}\left(\mathbf{k}^{E(4)}\right) \cong \mathbb{P}^{7}$.
Now consider $n=5$. The subdivisions are listed in Appendix A. If $\Delta_{w}$ is the subdivision $1,2,3,5,8,11,13$, or 16 , then $\mathrm{in}_{w} \mathrm{~S}_{5}^{\circ}$ is smooth and irreducible by Proposition 6.4. Next, suppose $\Delta_{w}$ is one of the subdivisions $0,4,6,7,9,12,14,17$, or 18 . Observe that, for each of these subdivisions, $\{0\}$ is a basis of $M_{Q}$ for all but one $Q \in\left(\Delta_{w}\right)^{\text {top }}$; the matroids missing $\{0\}$ are $M_{0}, M_{4}, M_{5}, M_{4}, M_{3}, M_{9}, M_{4}, M_{11}, M_{4}$, respectively. For each of these subdivisions, $v_{Q_{M_{i}}}$ has exactly two adjacent vertices, which are themselves adjacent. So $\mathrm{in}_{w} \mathrm{~S}_{5}^{\circ}$ is smooth and irreducible by Proposition 6.10. The only subdivisions left are 10 and 15.

Consider subdivision 10 in Table A.4. Denote the $i$-th vertex by $v_{i}$, its polytope by $Q_{i}$, and its $\Delta$-matroid by $M_{i}$. For the edge between $v_{i}$ and $v_{j}$, denote by $Q_{i j}$ the corresponding polytope, and $M_{i j}$ its $\Delta$-matroid. The set $A=\left\{Q_{0}, Q_{1}, Q_{2}, Q_{3}, Q_{4}\right\}$ is basis-connecting. Also, we see that $I_{M_{i}}^{x}=\langle 0\rangle$ for $i=1,3,4$ and $I_{M_{i}}^{x}=\left\langle x_{02} x_{13}-x_{03} x_{12}\right\rangle$ for $i=0,2$. Therefore, the coordinate ring of $\lim _{H} S_{M}$, where $H=\Gamma_{w}\left[v_{0}, v_{1}, v_{2}, v_{3}, v_{4}\right]$, is isomorphic to

$$
R^{x}(A)=\left(S^{x}\right)^{-1} \mathbf{k}\left[x_{i j}^{ \pm} \mid 0 \leq i<j \leq 4\right] /\left(x_{02} x_{13}-x_{03} x_{12}\right)
$$

where $S^{x}$ is some finitely-generated multiplicative semigroup. Because we can solve for, e.g., $x_{02}$, we see that $\lim _{\overleftarrow{ }} \mathrm{S}_{M}$ is isomorphic to an open subvariety of $\mathbb{G}_{m}^{9}$. Therefore, $\lim _{H} \mathrm{~S}_{M}$ is smooth and irreducible of dimension 9. Next, consider the pair $\left(Q_{5}, Q_{25}\right)$.

Twist $M_{5}$ and $M_{25}$ by 1234 to get the $\Delta$-matroids $N$ and $N^{\prime}$ with bases

$$
\begin{aligned}
\mathcal{B}(N) & =\{1,2,3,012,013,123,124,134,234,01234\} \\
\mathcal{B}\left(N^{\prime}\right) & =\{1,2,3,012,013,124,134,234,01234\}
\end{aligned}
$$

The rings of $R_{N}^{x}$ and $R_{N^{\prime}}^{x}$ are

$$
R_{N}^{x}=\left(S_{N}^{x}\right)^{-1} \mathbf{k}\left[x_{01}^{ \pm}, x_{02}^{ \pm}, x_{03}^{ \pm}, x_{04}^{ \pm}, x_{24}^{ \pm}, x_{34}^{ \pm}\right], \quad R_{N^{\prime}}^{x}=\left(S_{N^{\prime}}^{x}\right)^{-1} \mathbf{k}\left[x_{01}^{ \pm}, x_{02}^{ \pm}, x_{03}^{ \pm}, x_{24}^{ \pm}, x_{34}^{ \pm}\right]
$$

and the $\operatorname{map} \varphi_{N, N^{\prime}}^{\#}: R_{N^{\prime}}^{x} \rightarrow R_{N}^{x}$ is given by $x_{i j} \mapsto x_{i j}$, so $\varphi_{N, N^{\prime}}: \mathrm{S}_{N} \rightarrow \mathrm{~S}_{N^{\prime}}$ is smooth and dominant with connected fibers. Set $H^{\prime}=\Gamma_{w}\left[v_{0}, \ldots, v_{5}\right]$. By [7, Proposition A.5], we have an isomorphism

$$
\underset{H^{\prime}}{\lim _{M}} S_{M} \cong \underset{H}{\lim _{\leftrightarrows}} S_{M} \times_{S_{N^{\prime}}} S_{N}
$$

which is smooth and irreducible [7, Proposition A.2.3] of dimension 10 [12, Proposition III.9.5]. Next, observe that $M_{6}$ is equivalent to the $\Delta$-matroid $K$ from Example 6.2, Thus $\lim _{\Gamma_{w}} \mathrm{~S}_{M}$ fits into the pullback diagram


The dimension of $\lim _{\Gamma_{w}} S_{M}$ is at least 10 by Theorem 4.3 and the fact that $\mathrm{in}_{w} \mathrm{~S}_{5}^{\circ}$ a flat degeneration of $S_{5}^{\circ}$, which is 10-dimensional. We conclude that $\lim _{\Gamma_{w}} S_{M}$ is smooth an irreducible of dimension 10 by Lemma 6.11, and therefore so is in ${ }_{w} \mathrm{~S}_{5}^{\circ}$.

Finally, we consider subdivision 15. We retain the notation convention for the vertices, polytopes, and $\Delta$-matroids. The set $A=\left\{Q_{0}, \ldots, Q_{8}\right\}$ is basis-connected, so we may compute its coordinate ring using Proposition 6.5. We see that $I_{M_{i}}^{x}=\langle 0\rangle$ for $i=0,1,2,3,5,7,8$ and $I_{M_{i}}^{x}=\left\langle x_{02} x_{13}-x_{03} x_{12}\right\rangle$ for $i=4,6$. By Proposition 6.5 the coordinate ring of $\lim _{H} \mathrm{~S}_{M_{i}}$, where $H=\Gamma_{w}\left[v_{0}, \ldots, v_{8}\right]$, is

$$
R^{x}(A) \cong S^{-1} \mathbf{k}\left[x_{i j}^{ \pm}: 0 \leq i<j \leq 4\right] /\left(x_{02} x_{13}-x_{03} x_{12}\right)
$$

where $S$ is some finitely-generated multiplicative semigroup. As in the previous case, we deduce that $\lim _{H} S_{M_{i}}$ is isomorphic to an open subvariety of $\mathbb{G}_{m}^{9}$, and therefore smooth and irreducible of dimension 9.

Next, consider the pair $\left(Q_{9}, Q_{69}\right)$. Twist $M_{9}$ and $M_{69}$ by 1234 to get the $\Delta$-matroids $N$ and $N^{\prime}$ with bases

$$
\begin{aligned}
\mathcal{B}(N) & =\{1,2,3,012,013,123,134,234,01234\} \\
\mathcal{B}\left(N^{\prime}\right) & =\{1,2,3,012,013,134,234,01234\}
\end{aligned}
$$

The rings of $R_{N}^{x}$ and $R_{N^{\prime}}^{x}$ are

$$
R_{N}^{x}=\mathbf{k}\left[x_{01}^{ \pm}, x_{02}^{ \pm}, x_{04}^{ \pm}, x_{24}^{ \pm}, x_{34}^{ \pm}\right], \quad R_{N^{\prime}}^{x}=\mathbf{k}\left[x_{01}^{ \pm}, x_{02}^{ \pm}, x_{24}^{ \pm}, x_{34}^{ \pm}\right]
$$

and the map $\varphi_{N, N^{\prime}}^{\#}: R_{N^{\prime}}^{x} \rightarrow R_{N}^{x}$ is given by $x_{i j} \mapsto x_{i j}$, so $\varphi_{N, N^{\prime}}: \mathrm{S}_{N} \rightarrow \mathrm{~S}_{N^{\prime}}$ is smooth and dominant with connected fibers. Set $H^{\prime}=\Gamma_{w}\left[v_{0}, \ldots, v_{9}\right]$. By [7, Proposition A.5], we have
an isomorphism

$$
{\underset{H}{H^{\prime}}}_{\lim } S_{M} \cong \underset{H}{\lim _{H}} S_{M} \times_{S_{N^{\prime}}} S_{N}
$$

which is smooth and irreducible of dimension 10 (similar to the previous case). Finally, $\Delta$-matroids $M_{10}$ and $M_{11}$ are equivalent to the matroid $K$ from Example 6.2, and by an argument similar to the previous case, we conclude that $\mathrm{in}_{w} \mathrm{~S}_{5}^{\circ}$ is smooth and irreducible.

## 7. LOG CANONICAL MODEL OF $\mathrm{S}_{5} / / H$

7.1. Schön compactifications. Throughout this section, we use the following notation for fans and toric varieties that is consistent with [8]. Given a finite rank lattice $N$, let $T_{N}$ be its torus, and given a torus $T$ let $N_{T}$ be its cocharacter lattice. If $\tau$ is a rational polyhedral cone, let $N_{\tau}$ be the saturated sublattice of $N$ generated by $\tau \cap N$, let $N(\tau)=N / N_{\tau}$, and let $\operatorname{Star}(\tau)$ be the star of $\tau$, viewed as a fan in $N(\tau)_{\mathbb{R}}$. If $\Sigma$ is a rational polyhedral fan in $N_{\mathbb{R}}$, denote by $|\Sigma|$ its support. If $\Sigma$ is also pointed, denote by $X(\Sigma)$ its toric variety.

Suppose $Y^{\circ}$ is a closed subvariety of an algebraic torus $T$. The closure $Y$ of $Y^{\circ}$ in a $T$-toric variety $X(\Sigma)$ is a tropical, resp. schön, compactification if the multiplication map $Y \times T \rightarrow X(\Sigma)$ is flat, resp. smooth, and surjective; in either case $|\Sigma|=\operatorname{Trop}\left(Y^{\circ}\right)$ [25]. The variety $Y^{\circ}$ is schön if it admits a schön compactification, equivalently, if in ${ }_{w} Y^{\circ}$ is smooth for each $w \in \operatorname{Trop}\left(Y^{\circ}\right)$ [13, Proposition 3.9]. If $Y^{\circ}$ is schön, then the closure of $Y^{\circ}$ inside any toric variety $X(\Sigma)$ with $|\Sigma|=\operatorname{Trop}\left(Y^{\circ}\right)$ is a schön compactification [19, Theorem 1.5].

A rational pointed polyhedral fan $\Sigma$ in $N_{\mathbb{R}}$ is strictly simplicial if, for each cone $\tau$ of $\Sigma$, its rays can be extended to an integral basis of $\Sigma$. The following proposition is well known to the experts, but for convenience we sketch a proof here.

Proposition 7.1. Suppose $Y^{\circ}$ is schön and $\Sigma$ is a strictly simplicial fan with support $\operatorname{Trop}\left(Y^{\circ}\right)$. Then the closure $Y$ of $Y^{\circ}$ in $X(\Sigma)$ is smooth and its boundary $B=Y \backslash Y^{\circ}$ is a simple normal crossings divisor.

Proof. As stated earlier, $Y$ is a schön compactification of $Y^{\circ}$, so the multiplication map $Y \times T \rightarrow X(\Sigma)$ is smooth and surjective. Because $\Sigma$ is strictly simplicial, the toric variety $X(\Sigma)$ is smooth and its toric boundary is a simple normal crossings divisor. So $Y \times T$ is smooth, and therefore so is $Y$. Moreover, since the toric boundary of $X(\Sigma)$ pulls back to $B \times T$ under the smooth and surjective multiplication map, we have that $B \times T$, and therefore $B$, is a simple normal crossings divisor by [24, Lemma 0CBQ].

Let $Y$ be a schön compactification of $Y^{\circ}$ with ambient toric variety $X(\Sigma)$, and set $B=$ $Y \backslash Y^{\circ}$. Then $B$ is divisorial and $Y$ has toroidal singularities [25, Theorem 1.4]. Given a cone $\tau$ of $\Sigma$, denote by $Y_{\tau}$ the intersection of $Y$ with the stratum of $X(\Sigma)$ corresponding to $\tau$. The following proposition gives a sufficient condition for $K_{Y}+B$ to be ample, compare to [19, Theorem 4.9] and [7, Theorem 1.3].

Proposition 7.2. If $\mathrm{in}_{w} Y^{\circ}$ is smooth and irreducible for all $w \in \operatorname{Trop}\left(Y^{\circ}\right)$, and $|\operatorname{Star}(\tau)|$ is not preserved by a rational subspace of $N(\tau)_{\mathbb{R}}$ for all $\tau \in \Sigma$, then $K_{Y}+B$ is ample (where $\left.B=Y \backslash Y^{\circ}\right)$.

Proof. Because $Y$ has toroidal singularities, the divisor $K_{Y}+B$ is ample if and only if each irreducible stratum is $\log$ minimal [11, Theorem 9.1]. The stratum $Y_{\tau}$ is irreducible because the initial degenerations of $Y^{\circ}$ are irreducible, and $\mathrm{in}_{w} Y^{\circ} \cong Y_{\tau} \times T_{N_{\tau}}$ for any $w$ in the relative interior of $\tau$ [13, Lemma 3.6]. Therefore, the irreducible strata of $Y$ are exactly $Y_{\tau}$ for $\tau \in \Sigma$.

Given $\tau \in \Sigma$, the stratum $Y_{\tau}$ is schön because $Y$ is a schön compactification. Therefore, $Y_{\tau}$ is log minimal if and only if it is not preserved by a nontrivial subtorus $T_{N(\tau)}$ [11, Theorem 3.1], which occurs if and only if $\operatorname{Trop}\left(Y_{\tau}\right)$ is not invariant under translation by a rational subspace of $N(\tau)_{\mathbb{R}}$ [16, Lemma 5.2]. The proposition now follows from the fact that $\operatorname{Trop}\left(Y_{\tau}\right)=|\operatorname{Star}(\tau)|$ [20, Lemma 3.3.6].

We use the following lemma, which is essentially [7, Lemma 7.2], to determine whether $|\operatorname{Star}(\tau)|$ is preserved under translation by a subspace.
Lemma 7.3. Suppose $\Sigma$ is a fan with lineality space $L_{\mathbb{R}}$, and let $\tau \neq L_{\mathbb{R}}$ be a nonmaximal cone of $\Sigma$. If there is a collection $A_{\tau}$ of maximal cones such that

$$
\begin{equation*}
\bigcap_{\sigma \in A_{\tau}}\left(N_{\sigma}\right)_{\mathbb{R}}=\left(N_{\tau}\right)_{\mathbb{R}} \tag{7.1}
\end{equation*}
$$

then $|\operatorname{Star}(\tau)|$ is not preserved under translation by any subspace of $N(\tau)_{\mathbb{R}}$.
7.2. The Chow quotient of $\mathbb{S}_{n}$. As before, let $N=\mathbb{Z}^{E(n)} / \mathbb{Z} \cdot(1, \ldots, 1)$ be the cocharacter lattice of the dense torus $T_{N}$ of $\mathbb{P}\left(\mathbf{k}^{E(n)}\right)$, and let $L \leq N$ be the saturated subgroup from Equation (4.1). This is the cocharacter lattice of an $n$-dimensional subtorus $T_{L} \cong H$ of $T_{N}$, and the scaling action of $T_{N} \curvearrowright \mathbb{P}\left(\mathbf{k}^{E(n)}\right)$ restricted to $\mathrm{S}_{n}$ is the action $H \curvearrowright \mathrm{~S}_{n}$ from Equation (1.2). Therefore, there is an embedding of Chow quotients $S_{n} / / H \hookrightarrow \mathbb{P}\left(\mathbf{k}^{E(n)}\right) / / H$. By [15], $\mathbb{P}\left(\mathbf{k}^{E(n)}\right) / / H$ is the toric variety of the secondary fan of $\Delta(n)$. Denote by $\Sigma_{n}$ restriction of this fan to $\operatorname{Dr}(n)$, which has $L_{\mathbb{R}}$ in its lineality space. Thus $\operatorname{Dr}(n) / L_{\mathbb{R}}$ is the underlying set of the fan $\Sigma_{n} / L_{\mathbb{R}}$, and because $\mathrm{TS}_{n}^{\circ} \subset \operatorname{Dr}(n)$, the Chow quotient $\mathrm{S}_{n} / / H$ is the closure of $S_{n}^{\circ} / H$ in $X\left(\Sigma_{n} / L_{\mathbb{R}}\right)$.

Remark 7.4. Each point of the affine variety $S_{n}^{\circ}$ is $H$-stable in the sense of geometric invariant theory since, for each $x \in \mathbb{S}_{n}^{\circ}$, the stabilizer is $\left\{ \pm I_{n}\right\}$, which is finite, and the orbit $H \cdot x=\left(T_{L} \cdot x\right) \cap \mathrm{S}_{n}^{\circ}$ is closed in $\mathrm{S}_{n}^{\circ}$. Therefore, $\mathrm{S}_{n}^{\circ} / H$ is a geometric quotient by standard results in GIT.

Lemma 7.5. For $n \leq 5$, the initial degenerations of $\mathrm{S}_{n}^{\circ} / H$ are smooth and irreducible; in particular, $\mathrm{S}_{n}^{\circ} / \mathrm{H}$ is schön.
Note that $S_{n}^{\circ}$ is schön by Theorem 6.12,
Proof. Compare to [7, Lemma 7.1]. Let $w \in \mathrm{TS}_{n}$ and $\bar{w}$ the projection of $w$ to $N_{\mathbb{R}} / L_{\mathbb{R}}$. Then $\mathrm{in}_{w} \mathrm{~S}_{n}^{\circ} \cong H \times \mathrm{in}_{\bar{w}}\left(\mathrm{~S}_{n}^{\circ} / H\right)$. Therefore, for $n \leq 5$, the initial degenerations of $\mathrm{S}_{n}^{\circ} / H$ are smooth and irreducible by Theorem6.12.
In particular, for $n \leq 5$, the Chow quotient $S_{n} / / H$ is a schön compactification of $S_{n}^{\circ} / H$. When $n=1,2,3$, the spinor variety is $\mathrm{S}_{n}=\mathbb{P}\left(\mathbf{k}^{E(n)}\right)$ and $\mathrm{S}_{n} / / H$ is a projective toric variety. The first interesting case is $n=4$.
Proposition 7.6. The $\log$ canonical divisor $K_{S_{4} / / H}+B_{4}$ is ample, and therefore $S_{4} / / H$ is $\log$ canonical.

Proof. The secondary fan of $\mathrm{TS}_{4}^{\circ}$ is described in $\$ 4.1$, By Proposition 7.2 and Lemma 7.5, we need to show that $|\operatorname{Star}(\tau)|$ is not invariant under translation by any rational subspace of $N(\tau)_{\mathbb{R}}$. It suffices to consider the nonmaximal cones $\tau \in \Sigma_{4}$. Up to $W\left(D_{4}\right)$-symmetry, there is only one cone, e.g., $\tau=\mathbb{R}_{\geq 0}\left\langle f_{03}+f_{12}\right\rangle+L_{\mathbb{R}}$. There are 3 maximal cones containing $\tau$ :

$$
\begin{gathered}
\sigma_{0}=\mathbb{R}_{\geq 0}\left\langle f_{\varnothing}+f_{0123}, f_{03}+f_{12}\right\rangle+L_{\mathbb{R}}, \quad \sigma_{1}=\mathbb{R}_{\geq 0}\left\langle f_{01}+f_{23}, f_{03}+f_{12}\right\rangle+L_{\mathbb{R}}, \\
\sigma_{2}=\mathbb{R}_{\geq 0}\left\langle f_{02}+f_{13}, f_{03}+f_{12}\right\rangle+L_{\mathbb{R}} .
\end{gathered}
$$

Given $v \in N_{\mathbb{R}}$, denote by $v^{*}$ the linear functional given by $u \mapsto\langle u, v\rangle$. The subspace $\left(N_{\sigma_{i}}\right)_{\mathbb{R}}$ is the kernel of $v_{i}^{*}$ where

$$
v_{0}=f_{01}-f_{02}-f_{13}+f_{23}, v_{1}=f_{\varnothing}-f_{02}-f_{13}+f_{0123}, v_{2}=f_{\varnothing}-f_{01}-f_{23}+f_{0123}
$$

Because $\operatorname{span}\left\{v_{0}, v_{1}, v_{2}\right\}$ is 2-dimensional, the intersection in Equation (7.1) holds for $A_{\tau}=\left\{\sigma_{0}, \sigma_{1}, \sigma_{2}\right\}$, and hence $|\operatorname{Star}(\tau)|$ is not invariant under translation by any rational subspace of $N(\tau)_{\mathbb{R}}$ by Lemma 7.3.

The rest of this section is devoted to the $n=5$ case. Recall that $\mathrm{TS}_{5}^{\circ}=\operatorname{Dr}(5)$, and the Gröbner fan of $\mathrm{TS}_{5}^{\circ}$ equals $\Sigma_{5}$. Here is an explicit description of $\Sigma_{5}$, adapted from a gfan computation. By $\$ 4.1$, the lineality space of $\Sigma_{5}$ is the 5 -dimensional subspace $L_{\mathbb{R}}$ where $L \subset N$ is the saturated subgroup generated by

$$
\ell_{i}=\sum_{\lambda \ni i} f_{\lambda}, \quad m_{i}=\sum_{\lambda \ngtr i} f_{\lambda} \quad \text { for } \quad 0 \leq i \leq 4 .
$$

This fan has 36 rays, which have primitive vectors (modulo $L_{\mathbb{R}}$ ):

$$

Notice that, e.g., $r_{25}$ and $r_{35}$ belong to the same $W\left(D_{5}\right)$-orbit modulo $L$ because

t_{02} \cdot r_{25}-r_{35}=m_{1}
$$

The cones of $\Sigma_{5}$ partition into $20 W\left(D_{5}\right)$-orbits, which we denote by $\mathcal{O}_{i}$ for $-1 \leq i \leq 18$. Orbit representatives are listed in Table7.1.

The space $\mathrm{TS}_{5}^{\circ}$ is supported on a slightly coarser fan $\Sigma_{5}^{\prime}$, which we now describe.
Lemma 7.7. Each $\tau \in \mathcal{O}_{11}$ has exactly two cones in its star, and these belong to the orbit $\mathcal{O}_{18}$. Similarly, each $\sigma \in \mathcal{O}_{18}$ has only one face in $\mathcal{O}_{11}$.

That is, the cones in $\mathcal{O}_{18}$ partition in pairs, one pair $\left(\sigma_{\tau}, \sigma_{\tau^{\prime}}\right)$ for each $\tau \in \mathcal{O}_{11}$. For example, if $\tau=\mathbb{R}_{\geq 0}\left\langle r_{3}, r_{4}, r_{6}, r_{9}\right\rangle+L_{\mathbb{R}}$, then

$$
\begin{equation*}
\sigma_{\tau}=\mathbb{R}_{\geq 0}\left\langle r_{3}, r_{4}, r_{6}, r_{9}, r_{25}\right\rangle+L_{\mathbb{R}} \quad \sigma_{\tau}^{\prime}=\mathbb{R}_{\geq 0}\left\langle r_{3}, r_{4}, r_{6}, r_{9}, r_{26}\right\rangle+L_{\mathbb{R}} . \tag{7.2}
\end{equation*}
$$

Proof. For the first part, it suffices to show that the star of $\tau=\mathbb{R}_{\geq 0}\left\langle r_{3}, r_{4}, r_{6}, r_{9}\right\rangle+L_{\mathbb{R}}$ consists of exactly $\sigma_{\tau}$ and $\sigma_{\tau}^{\prime}$ from Equation (7.2). That $\operatorname{Star}(\tau)$ contains no cones from the orbits $\mathcal{O}_{15}, \mathcal{O}_{16}, \mathcal{O}_{17}$ follows from the fact that, for

$$
S_{15}=\left\{f_{4}, f_{023}, f_{123}, f_{014}\right\}, S_{16}=\left\{f_{3}, f_{4}, f_{012}, f_{023}, f_{014}\right\}, S_{17}=\left\{f_{3}, f_{4}, f_{012}, f_{013}\right\}
$$

there is no even subset $\mu$ such that $t_{\mu} \cdot S_{m}$ contains some $\left\{f_{k}, f_{\ell}, f_{i j k}, f_{i j \ell}\right\}$ for some distinct $i, j, k, \ell$, see $\$ 3.3$. Now, the $W\left(D_{5}\right)$-stabilizer of $S_{18}=\left\{f_{3}, f_{4}, f_{013}, f_{014}\right\}$ is

$$
\operatorname{Stab}_{W\left(D_{5}\right)}\left(S_{18}\right)=\left\langle s_{(01)}, s_{(34)}, t_{01}, t_{34}, s_{(03)(14)} t_{03}\right\rangle
$$

The $\operatorname{Stab}_{W\left(D_{5}\right)}\left(S_{18}\right)$-orbit of $r_{25}=f_{2}+f_{3}+f_{4}+f_{234}$ modulo $L_{\mathbb{R}}$ is $\left\{r_{25}, r_{26}\right\}$, and therefore the only cones in the star of $\tau$ are $\sigma_{\tau}$ and $\sigma_{\tau}^{\prime}$, as required.

For the second statement, it suffices to consider the cone $\sigma=\mathbb{R}_{>0}\left\langle r_{3}, r_{4}, r_{6}, r_{9}, r_{25}\right\rangle+$ $L_{\mathbb{R}}$. Every facet of $\sigma$ other than $\mathbb{R}_{\geq 0}\left\langle r_{3}, r_{4}, r_{6}, r_{9}\right\rangle+L_{\mathbb{R}}$ has one ray in the $W\left(D_{5}\right)$-orbit of $\mathbb{R}_{\geq 0} r_{25}+L_{\mathbb{R}}$, and therefore is not in $\mathcal{O}_{11}$.

Lemma 7.8. For any $\tau \in \mathcal{O}_{11}$, we have that $\sigma_{\tau} \cup \sigma_{\tau}^{\prime}$ is the convex polyhedral cone spanned by the rays of $\sigma_{\tau}$ and $\sigma_{\tau}^{\prime}$. Furthermore, each face of this cone is contained in $\mathcal{O}_{j}$ for some $j \neq 11,18$.
Proof. By symmetry, it suffices to show that

$$
\sigma_{\tau} \cup \sigma_{\tau}^{\prime}=\mathbb{R}_{\geq 0}\left\langle r_{3}, r_{4}, r_{6}, r_{9}, r_{25}, r_{26}\right\rangle+L_{\mathbb{R}}
$$

where $\tau=\mathbb{R}_{\geq 0}\left\langle r_{3}, r_{4}, r_{6}, r_{9}\right\rangle+L_{\mathbb{R}}$. Because the cones $\sigma_{\tau} / L_{\mathbb{R}}$ and $\sigma_{\tau}^{\prime} / L_{\mathbb{R}}$ are simplicial, we must show that

$$
\left(\mathbb{R}_{\geq 0}\left\langle r_{25}, r_{26}\right\rangle\right) \cap \tau \neq L_{\mathbb{R}}
$$

Indeed, consider the vector $w=f_{3}+f_{4}+f_{013}+f_{014}$. We may express $w$ as

$$
w=r_{3}+r_{4}+r_{6}+r_{9}=r_{25}+r_{26}+\frac{1}{2}\left(\ell_{0}+\ell_{1}-\ell_{2}-\ell_{3}+m_{4}\right)
$$

This shows that $w$ lies in $\left(\mathbb{R}_{\geq 0}\left\langle r_{25}, r_{26}\right\rangle\right) \cap \tau$ but not in $L_{\mathbb{R}}$, as required. The last statement follows from Lemma 7.7.

The fan $\Sigma_{5}^{\prime}$ is obtained by gluing $\sigma_{\tau}$ and $\sigma_{\tau}^{\prime}$ along $\tau$, for each $\tau \in \mathcal{O}_{11}$. Explicitly, let $\mathcal{O}_{18}^{\prime}=\left\{\sigma_{\tau} \cup \sigma_{\tau}^{\prime}: \tau \in \mathcal{O}_{11}\right\}$. Define $\Sigma_{5}^{\prime}$ by

$$
\Sigma_{5}^{\prime}=\left\{\tau: \tau \in \mathcal{O}_{i} \text { for } i \neq 11,18, \text { or } \tau \in \mathcal{O}_{18}^{\prime}\right\}
$$

Lemma 7.9. The collection of cones $\Sigma_{5}^{\prime}$ is a fan whose support is $\mathrm{TS}_{5}^{\circ}$, and $\Sigma_{5}$ is a refinement of $\Sigma_{5}^{\prime}$.
Proof. It is clear that $\mathrm{TS}_{5}^{\circ}$ is the union of the cones in $\Sigma_{5}^{\prime}$ and each cone of $\Sigma_{5}$ is contained in a cone of $\Sigma_{5}^{\prime}$. Therefore, it suffices to show that $\Sigma_{5}^{\prime}$ is a fan. That is, we must show that every face of a cone in $\Sigma_{5}^{\prime}$ is in $\Sigma_{5}^{\prime}$, and the intersection of any two cones in $\Sigma_{5}^{\prime}$ is a face of both of them.

Suppose $\sigma \in \Sigma_{5}^{\prime}$, and $\sigma^{\prime}$ is a face of $\sigma$. If $\sigma \in \mathcal{O}_{i}$ for some $i \neq 11,18$, then $\sigma^{\prime}$ is in $\mathcal{O}_{j}$ for some $j \neq 11,18$ by Lemma 7.7 and because $\Sigma_{5}$ is a fan; in particular $\sigma^{\prime} \in \Sigma_{5}^{\prime}$. If $\sigma \in \mathcal{O}_{18}^{\prime}$ then $\sigma^{\prime} \in \mathcal{O}_{j}$ for some $j \neq 11,18$ by Lemma 7.8.

Suppose $\sigma_{1}, \sigma_{2} \in \Sigma_{5}^{\prime}$ and let $\sigma_{3}=\sigma_{1} \cap \sigma_{2}$. If $\sigma_{1} \in \mathcal{O}_{i}$ and $\sigma_{2} \in \mathcal{O}_{j}$ for some $i, j \neq 11,18$, then $\sigma_{3} \in \mathcal{O}_{k}$ for some $k \neq 11,18$ because $\Sigma_{5}$ is a fan and Lemma 7.7. Now suppose $\sigma_{2} \in$ $\mathcal{O}_{18}^{\prime}$, by symmetry it suffices to consider $\sigma_{2}=\sigma_{\tau} \cup \sigma_{\tau}^{\prime}$ from Equation (7.2). If $r_{25}, r_{26} \in \sigma_{1}$, then $\sigma_{1}$ meets the relative interior of $\sigma_{\tau}$ and $\sigma_{\tau}^{\prime}$ by Lemma 7.8, and hence $\sigma_{1}=\sigma_{2}=\sigma_{3}$ because $\Sigma_{5}$ is a fan. If $r_{25} \in \sigma_{1}$ but $r_{26} \notin \sigma_{1}$, then $\sigma_{3}$ is a face of $\sigma_{\tau}$ not contained in $\tau$, and therefore is a face of $\sigma_{1}$ and $\sigma_{2}$. Finally, if that $r_{25}, r_{26} \notin \sigma_{1}$, then $\sigma_{3}$ is a face of $\sigma_{1}$ and $\tau$, but it cannot equal $\tau$ by Lemma 7.7. Therefore, $\sigma_{3}$ is also a face of $\sigma_{2}$, as required.

Let $Y$ denote the closure of $S_{5}^{\circ} / H$ in the toric variety $X\left(\Sigma_{5}^{\prime} / L_{\mathbb{R}}\right)$.
Lemma 7.10. For each $\tau \in \Sigma_{5}^{\prime} / L_{\mathbb{R}}$, the space $|\operatorname{Star}(\tau)|$ is not preserved under translation by any rational subspace of $N(\tau)_{\mathbb{R}}$.
Proof. By Lemma 7.3, we must find a collection of maximal cones $A_{\tau}$ satisfying Equation (7.1). We need only check one cone, e.g., $\tau_{i}$, from each non-maximal $W\left(D_{5}\right)$-orbit $\mathcal{O}_{i}$. Sets $A_{\tau_{i}}$ that satisfy (7.1) are listed in Table 7.1.

Equation (7.1) may be verified for $A_{\tau}$ in the following way. For each $\sigma \in A_{\tau}$, let $R_{\sigma \tau}$ be the matrix whose rows consist of the rays of $\sigma$ together with the vectors $\ell_{0}, \ldots, \ell_{4}, m_{0}, \ldots, m_{4}$ spanning the lineality space. Let $S_{\sigma \tau}$ be a matrix such that rowsp $R_{\sigma \tau}=\operatorname{ker} S_{\sigma \tau}$. Now let $S_{\tau}$ be the matrix whose (block) rows are the $S_{\sigma \tau}$. The kernel of $S_{\tau}$ is $\bigcap_{\sigma \in A_{\tau}}\left(N_{\sigma}\right)_{\mathbb{R}}$. Thus, to establish (7.1) for $A_{\tau}$, one must show that $\operatorname{rank}\left(S_{\tau}\right)=\operatorname{codim}_{\mathbb{R}^{E(5)}}(\tau)$, which is a routine verification.

Proof of Theorem 1.3. By Lemma 7.5, the initial degenerations of $S_{5}^{\circ} / \mathrm{H}$ are smooth and irreducible, so $S_{5} / / H$ and $Y$ are schön compactifications of $S_{5}^{\circ} / H$. Each $Y_{\tau}$ for $\tau \in \Sigma_{5}^{\prime}$ is not preserved by a rational subspace of $N(\tau)_{\mathbb{R}}$ by Lemma 7.10. Therefore, $K_{Y}+B$ is ample by Proposition 7.2, so $Y$ is the $\log$ canonical model of $\mathrm{S}_{5} / / \mathrm{H}$.

Now consider the last statement. One readily verifies that the fan $\Sigma_{5} / L_{\mathbb{R}}$ is strictly simplicial as defined in the beginning of this section. So $\mathrm{S}_{5} / / H$ is smooth with simple normal crossings boundary by Proposition 7.1. The morphism $S_{5} / / H \rightarrow Y$ is $\log$ crepant by [25, Theorem 1.4].
