# MODULES ATTACHED TO EXTENSION BUNDLES

#### Abstract

In this article we study modules over wild canonical algebras which correspond to extension bundles 9 over weighted projective lines. We prove that all modules attached to extension bundles can be established by matrices with coefficients related to the relations of the considered algebra.

Moreover, we expand the concept of extension bundles over weighted projective lines with three weights to general weight type and establish similar results in this situation. Finally, we present a method to compute matrices for all modules attached to extension bundles using cokernels of maps between direct sums of line bundles.


## 1. Introduction

One of the problems of representation theory of finite-dimensional algebras is the classification of indecomposable modules over a given algebra. Depending on the complexity of this issue we distinguish algebras of finite, tame and wild representation type. In the case of wild algebras the structure of the module category is rich enough that it is impossible to describe all indecomposable modules, however in this situation sometimes it is possible to describe subclasses of indecomposable modules.

In this paper we study an important class of modules, namely the so called extension modules for wild canonical algebras. Canonical algebras were introduced by C. M. Ringel in 1984 [14], for a definition we refer to Section 2.

In the case of domestic canonical algebras D. Kussin and the second author [11] described matrices for all indecomposable modules provided the characteristic of the field is different from 2. In the case of characteristic 2 matrices for the indecomposables were given in [8].

In the situation of tubular canonical algebras in [13], extending methods of [15, it was shown that the exceptional modules can be exhibited by matrices having as coefficients only 0,1 and -1 in the cases $(3,3,3),(2,4,4),(2,3,6)$ and 0,1 , $-1, \lambda, \lambda-1$ in the case $(2,2,2,2)$, where $\lambda$ is the parameter appearing in the relations for the considered algebra. Based on this result in 1 an algorithm and a computer program were developed to determine a description of all exceptional modules over tubular canonical algebras. Further in [3) and [2] the problem of homogeneous modules over tubular canonical modules was studied, in particular explicit matrices for modules of integral slope were given.

For canonical algebras of wild type it was proved by the authors in [7 that "almost all" exceptional modules can be described by matrices having coefficients $\lambda_{i}-\lambda_{j}$, where the $\lambda_{i}$ are the parameters of the canonical algebra.

[^0]In 5 W . Geigle and H. Lenzing investigated weighted projective lines to give a geometric approach to canonical algebras. More precisely, they showed that the category of coherent sheaves $\operatorname{coh}(\mathbb{X})$ over a weighted projective line $\mathbb{X}$ admits a tilting bundle $T$ which induces an equivalence of the bounded derived categories $D^{b}(\operatorname{coh}(\mathbb{X})) \cong D^{b}(\bmod (\Lambda))$, where $\Lambda=\operatorname{End}_{\Lambda}(T)$ is a canonical algebra.

In 2013 D. Kussin, H. Lenzing and second author in 9 introduced the concept of extension bundles over weighted projective lines with three weights, which is important in the study of nilpotent operators with invariant subspaces (see also [10]). It was proved there, in particular, that each indecomposable vector bundle of rank two is exceptional and appears as the middle term of an exact sequence, where the other terms are line bundles with good homological properties, see Section 3,

The aim of this article is to study modules attached to such extension bundles in the case of canonical algebras of wild type. Those modules are called extension modules. The paper contains the following results.

1. We prove that all extension modules over a wild canonical algebra $\Lambda$ with three arms, can be described by matrices with entries 0,1 and -1 . This is an improvement for those modules of the result from [7. We will use the fact that the category of vector bundles vect $(\mathbb{X})$ over a weighted projective line $\mathbb{X}$ is a Frobenius category with the line bundles as the indecomposable projective-injective objects. The main tool in the proof is the fact that a vector bundle associated to a module has a line bundle, associated to a module, as a direct summand of its projective cover.
2. We extend the concept of extension bundles from [9] to the case of an arbitrary number of weights. If this number is greater than 3 , then not every indecomposable vector bundle of rank two is exceptional. We present a useful characterization of exceptional modules of rank two as extension bundles with data $(L, \vec{x})$, where $L$ is a line bundle and $\vec{x}$ is an element of the grading group of a specific form. We also establish the projective covers and the injective hulls of those bundles.
3. We show that all extension modules for a wild canonical algebra with an arbitrary number of arms can be established by matrices with coefficients $0, \lambda_{i},-\lambda_{i}$ where the $\lambda_{i}$ are the parameters of the canonical algebra.
4. We compute matrix representation for each extension module over a canonical algebra of arbitrary type. Since the method using Schofield induction for exceptional modules (see [15, [6]) is not constructive we can not proceed as in the case for tubular canonical algebras [13. Therefore here we present another idea. We show that each extension module appears as a cokernel of a map between direct sums of line bundles and we describe a method to calculate matrices for these cokernels.

## 2. Notations and basic concepts

Let $k$ be an algebraically closed field. We recall the concept of a weighted projective line in the sense of W . Geigle and H- Lenzing [5]. Let $\mathbb{L}=\mathbb{L}(p)$ be the rank one abelian group with generators $\vec{x}_{1}, \ldots, \vec{x}_{t}$ and relations $p_{1} \vec{x}_{1}=\cdots p_{t} \vec{x}_{t}:=$ $\vec{c}$, where the $p_{i}$ are integers greater than or equal to 2 . These numbers are called weights. The element $\vec{c}$ is called the canonical element. Recall that $\mathbb{L}$ is an ordered group with $\mathbb{L}_{+}=\sum_{i=1}^{t} \mathbb{N} \vec{x}_{i}$ as its set of non-negative elements. Moreover, each element $\vec{y}$ of $\mathbb{L}$ can be written in normal form $\vec{y}=a \vec{c}+\sum_{i=1}^{t} a_{i} \vec{x}_{i}$ with $a \in \mathbb{Z}$ and $0 \leq a_{i}<p_{i}$. The polynomial algebra $k\left[x_{1}, \ldots, x_{t}\right]$ is $\mathbb{L}$-graded, where the degree of
$x_{i}$ is $\vec{x}_{i}$. Since the polynomials $f_{i}=x_{i}^{p_{i}}-x_{1}^{p_{1}}-\lambda_{i} x_{2}^{p_{2}}$ for $i=3, \ldots t$ are homogeneous, the quotient algebra $S=k\left[x_{1}, \ldots, x_{t}\right] /\left\langle f_{i} \mid i=3, \ldots, t\right\rangle$ is also $\mathbb{L}$-graded. Here the $\lambda_{i}$ are pairwise distinct non-zero elements of $k$, they are called the parameters. A weighted projective line $\mathbb{X}$ is the projective spectrum of the $\mathbb{L}$-graded algebra $S$. Therefore $\mathbb{X}$ depends on a weight sequence $\underline{p}=\left(p_{1}, \ldots, p_{t}\right)$ and a sequence of parameters $\underline{\lambda}=\left(\lambda_{3}, \ldots, \lambda_{t}\right)$. We can assume that $\lambda_{3}=1$. The category of coherent sheaves over $\mathbb{X}$ will be denoted by $\operatorname{coh}(\mathbb{X})$. Each indecomposable sheaf in $\operatorname{coh}(\mathbb{X})$ is a locally free sheaf, called a vector bundle, or a sheaf of finite length. Denote by $\operatorname{vect}(\mathbb{X})\left(\right.$ resp. $\left.\operatorname{coh}_{0}(\mathbb{X})\right)$ the subcategory of $\operatorname{coh}(\mathbb{X})$ consisting of all vector bundles (resp. finite length sheaves) on $\mathbb{X}$.

The category $\operatorname{coh}(\mathbb{X})$ is a Hom-finite, abelian $k$-category. Moreover, it is hereditary that is $\operatorname{Ext}_{\mathbb{X}}^{i}(-,-)=0$ for $i \geq 2$ and has Serre duality in the form $\operatorname{Ext}_{\mathbb{X}}^{1}(F, G) \cong D \operatorname{Hom}_{\mathbb{X}}\left(G, \tau_{\mathbb{X}} F\right)$, where the Auslander-Reiten translation $\tau_{\mathbb{X}}$ is given by the shift $F \mapsto F(\vec{\omega})$, where $\vec{\omega}:=(t-2) \vec{c}-\sum_{i=1}^{t} \vec{x}_{i}$ denotes the dualizing element. It is well known that each line bundle has the form $\mathcal{O}(\vec{x})$ where $\mathcal{O}$ is the structure sheaf of $\mathbb{X}$ and where $\vec{x} \in \mathbb{L}$. Furthermore we have isomorphisms $\operatorname{Hom}_{\mathbb{X}}(\mathcal{O}(\vec{x}), \mathcal{O}(\vec{y})) \cong S_{\vec{y}-\vec{x}}$, where $S_{\vec{z}}$ denotes the grading component of $S$ associated to $\vec{z} \in \mathbb{L}$.

One of the main results proved in [5] is the fact that in $\operatorname{coh}(\mathbb{X})$ there is a tilting object, which is a direct sum of line bundles $T=\bigoplus_{0 \leq \vec{x} \leq \vec{c}} \mathcal{O}(\vec{x})$, such that the right derived functor of the functor $\operatorname{Hom}_{\mathbb{X}}(T,-)$ induces an equivalence of bounded derived category $\mathcal{D}^{b}(\operatorname{coh}(\mathbb{X})) \xrightarrow{\cong} \mathcal{D}^{b}(\bmod (\Lambda))$, where $\Lambda=\operatorname{End}_{\mathbb{X}}(T)$ is a canonical algebra, called the canonical algebra associated to the weighted projective line $\mathbb{X}$.

Originally, canonical algebras $\Lambda$ were introduced by C. M. Ringel [14] as path algebras of quivers $Q$ :

with canonical relations

$$
\alpha_{p_{i}}^{(i)} \ldots \alpha_{2}^{(i)} \alpha_{1}^{(i)}=\alpha_{p_{1}}^{(1)} \ldots \alpha_{2}^{(1)} \alpha_{1}^{(1)}+\lambda_{i} \alpha_{p_{2}}^{(2)} \ldots \alpha_{2}^{(2)} \alpha_{1}^{(2)} \quad \text { for } \quad i=3,4, \ldots, t,
$$

where the $\lambda_{i}$ are parameters from $\underline{\lambda}$ and $p_{i}$ are weights from $\underline{p}$ as before. We call $t$ the number of arms of $\Lambda$. Concerning the complexity of the module category over $\Lambda$ there are three types of canonical algebras, domestic, tubular and wild ones. Recall that $\Lambda$ is of domestic (respectively tubular, wild) type if the Euler characteristic $\chi_{\Lambda}=(2-t)+\sum_{i=1}^{t} 1 / p_{i}$ is positive (respectively zero, negative).

Denote by $Q_{0}$ the set of vertices and by $Q_{1}$ the set of arrows of the quiver $Q$. Then each finitely generated right module over $\Lambda$ is given by finite dimensional vector spaces $M_{i}$ for each vertex $i$ of $Q_{0}$ and by linear maps $M_{\alpha}: M_{j} \rightarrow M_{i}$ for each arrows $\alpha: i \rightarrow j$ of $Q_{1}$ such that the canonical relations are satisfied. We will usually identify linear maps with matrices. The category of finite generated right modules we denote by $\bmod (\Lambda)$.

For coherent sheaves there are well known invariants the rank, the degree and the determinant, which are given by linear forms on the Grothendieck group rk, deg : $K_{0}(\mathbb{X}) \longrightarrow \mathbb{Z}$ and det $: K_{0}(\mathbb{X}) \longrightarrow \mathbb{L}(\underline{p})$. Since $K_{0}(\mathbb{X}) \simeq K_{0}(\Lambda)$ we have also the concept of the rank, the degree and the determinants for $\Lambda$-modules In particular the rank of a $\Lambda$-module is defined by the formula $\operatorname{rkM}:=\operatorname{dim}_{k} M_{0}-\operatorname{dim}_{k} M_{\vec{c}}$. We denote by $\bmod _{+}(\Lambda)\left(\right.$ respectively $\left.\bmod _{-}(\Lambda), \bmod _{0}(\Lambda)\right)$ the full subcategory consisting of all $\Lambda$-modules, whose indecomposable summands in the decomposition into a direct sum have positive (respectively negative or zero) rank. Further, by $\operatorname{coh}_{+}(\mathbb{X})($ resp. coh_$(\mathbb{X}))$ we denote the full subcategory of all vector bundles $X$ on $\mathbb{X}$, such that the functor $\operatorname{Ext}_{\mathbb{X}}^{1}(T, X)=0$ (resp. $\left.\operatorname{Hom}_{\mathbb{X}}(T, X)=0\right)$. Under the equivalence $\mathcal{D}^{b}(\operatorname{coh}(\mathbb{X})) \xrightarrow{\cong} \mathcal{D}^{b}(\bmod (\Lambda))$

- $\operatorname{coh}_{+}(\mathbb{X})$ corresponds to $\bmod _{+}(\Lambda)$ by means of $E \mapsto \operatorname{Hom}_{\mathbb{X}}(T, E)$,
- $\operatorname{coh}_{0}(\mathbb{X})$ corresponds to $\bmod _{0}(\Lambda)$ by means of $E \mapsto \operatorname{Hom}_{\mathbb{X}}(T, E)$,
- coh- $(\mathbb{X})[1]$ corresponds to $\bmod _{-}(\Lambda)$ by means of $E[1] \mapsto \operatorname{Ext}_{\mathbb{X}}^{1}(T, E)$, where [1] denotes the suspension functor of the triangulated category $D^{b}(\operatorname{coh}(\mathbb{X}))$.
We say in these cases that the $\operatorname{module}^{\operatorname{Hom}_{\mathbb{X}}}(T, E)$ (respectively $\operatorname{Ext}_{\mathbb{X}}(T, E)$ is attached to $E$. For simplicity we will often identify a sheaf $E$ in $\operatorname{coh}_{+}(\mathbb{X})$ or $\operatorname{coh}_{0}(\mathbb{X})$ with the corresponded $\Lambda$-module $\operatorname{Hom}_{\mathbb{X}}(T, E)$.

Remark 2.1. Recall from [4, Theorem 9.1.1] that the standard duality $\operatorname{Hom}_{\Lambda}(-, k)$ defines an equivalence of the categories $\bmod (\Lambda)$ and $\bmod \left(\Lambda^{o p}\right)$. Under this equivalence $\bmod _{-}(\Lambda)$ corresponds to $\bmod _{+}\left(\Lambda^{o p}\right)$. Since $\Lambda \simeq \Lambda^{o p}$ in many considerations it is sufficient to consider $\Lambda$-modules of positive rank and of rank zero. In particular, modules of negative rank can be obtained from those of positive rank by reversing the arrows and transposing the matrices.

Recall that a coherent sheaf $E$ over $\mathbb{X}$ is called exceptional if $\operatorname{End} \mathbb{X}(E)=k$ and $\operatorname{Ext}_{\mathbb{X}}^{1}(E, E)=0$. A pair $(X, Y)$ in $\operatorname{coh}(\mathbb{X})$ is called an exceptional pair if $X, Y$ are exceptional and $\operatorname{Hom}_{\mathbb{X}}(Y, X)=0=\operatorname{Ext}_{\mathbb{X}}^{1}(Y, X)$. Furthermore, an exceptional pair is orthogonal if addition $\operatorname{Hom}_{\mathbb{X}}(X, Y)=0$. Finally, a $\Lambda$-module $M$ is called exceptional if $\operatorname{End}_{\Lambda}(M)=k$ and $\operatorname{Ext}_{\Lambda}^{i}(M, M)=0$ for $i \geq 1$.

## 3. Extension bundles for weighted projective Lines with three WEIGHTS

Let $\mathbb{X}$ be a weighted projective line of a triple type $\left(p_{1}, p_{2}, p_{3}\right)$. The concept of extension bundles was introduced in [9] in the study of stable vector bundle categories. In particular it was shown that stable vector bundle categories of weighted projective lines of triple type admit tilting objects, being direct sums of extension bundles, such that their endomorphism algebras form cuboids.

From [9, Theorem 4.2.] each indecomposable vector bundle $E$ can be obtained as the middle term of a non-split exact sequence

$$
\eta_{L, \vec{x}}: \quad 0 \longrightarrow L(\vec{\omega}) \longrightarrow E \longrightarrow L(\vec{x}) \longrightarrow 0
$$

for some line bundle $L$ and some element $\vec{x}$ of $\mathbb{L}$ such that $0 \leq \vec{x} \leq \vec{\delta}$, where $\vec{\delta}:=\vec{c}+2 \vec{\omega}$ is the dominant element. Because in this case the vector space $\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega}))$ is one-dimensional the bundle $E$ is uniquely determined up to isomorphism. It is called the extension bundle given by the pair $(L, \vec{x})$. It is easy to check, that the pair $(L(\vec{x}), L(\vec{\omega}))$ is exceptional and orthogonal. Therefore, if $L(\vec{x})$ and $L(\vec{\omega})$ are $\Lambda$-modules, both in $\bmod _{+}(\Lambda)$ or in $\bmod _{-}(\Lambda)$, then they can
be described by $0, \pm \lambda_{i}$ matrices, as rank one modules (see [13]) and it follows that $E$ also can be described by matrices with the same coefficients (see Proposition 7.1 and the remark after its proof in [7).

We recall that the category vect $(\mathbb{X})$ of vector bundles over $\mathbb{X}$ is a Frobenius category such that the indecomposable projective-injective objects are exactly the line bundles 9, Def. 3.1]. Moreover each vector bundle has a projective cover and an injective hull.
Lemma 3.1. Let $E$ be a non-zero vector bundle on a weighted projective line $\mathbb{X}$ of type $\left(p_{1}, p_{2}, p_{3}\right)$ with projective cover $\mathfrak{P}(E)$. If $\operatorname{Ext} \frac{1}{\mathbb{X}}(T, E)=0$ for the canonical bundle $T$, then there is a line bundle $L$ in the decomposition $\mathfrak{P}(E)$ into a direct sum of line bundles, such that $\operatorname{Ext} \frac{1}{\mathbb{X}}(T, L)=0$.
Proof. Assume that $\operatorname{Ext} \frac{1}{\mathbb{X}}(T, E)=0$. Then $\operatorname{Hom}_{\mathbb{X}}(T, E) \neq 0$ because $T$ is a tilting bundle and $E$ is non-zero. Therefore there is an element $\vec{x}$, such that $0 \leq \vec{x} \leq \vec{c}$ and $\operatorname{Hom}_{\mathbb{X}}(\mathcal{O}(\vec{x}), E) \neq 0$. Each non-zero morphism $f: \mathcal{O}(\vec{x}) \longrightarrow E$ factors through $\pi_{E}: \mathfrak{P}(E) \longrightarrow E$, so there is morphism $0 \neq \alpha: \mathcal{O}(\vec{x}) \longrightarrow \mathfrak{P}(E)$ such that $\pi_{E} \circ \alpha=f$. Hence there is a direct summand $L=\mathcal{O}(\vec{y})$ of $\mathfrak{P}(E)$ such that $\operatorname{Hom}_{\mathbb{X}}(\mathcal{O}(\vec{x}), \mathcal{O}(\vec{y})) \neq 0$.

We will show that $L$ has the desired property. Writing $\vec{y}$ in normal form $\vec{y}=$ $\alpha \vec{c}+\alpha_{1} \vec{x}_{1}+\alpha_{2} \vec{x}_{2}+\alpha_{3} \vec{x}_{3}$, with $0 \leq \alpha_{i} \leq p_{i}-1$, we obtain $\alpha \geq 0$ and

$$
(\triangle) \vec{c}+\vec{\omega}-\vec{y}=(2-\alpha) \vec{c}-\sum_{i=1}^{3}\left(\alpha_{i}+1\right) \vec{x}_{i}<0
$$

Assume that $\operatorname{Ext} \frac{1}{\mathbf{X}}(T, \mathcal{O}(\vec{y})) \neq 0$ and let $\vec{z}$ satisfy $\operatorname{Ext} \frac{1}{\mathrm{X}}(\mathcal{O}(\vec{z}), \mathcal{O}(\vec{y})) \neq 0$ and $0 \leq \vec{z} \leq \vec{c}$. Using Serre duality we obtain $\vec{z}+\vec{\omega}-\vec{y} \geq 0$. Therefore

$$
\vec{c}+\vec{\omega}-\vec{y}=\underbrace{(\vec{c}-\vec{z})}_{\geq 0}+\underbrace{(\vec{z}+\vec{\omega}-\vec{y})}_{\geq 0} \geq 0,
$$

a contradiction with $(\triangle)$. Thus $\operatorname{Ext}_{\mathbb{X}}^{1}(T, \mathcal{O}(\vec{y}))=0$
In the following lemma we prove that each extension bundle defined by a short exact sequence $\eta_{L, \vec{x}}$ appears in addition as an extension bundle for three different pairs ( $L, \vec{x}$ ).
Lemma 3.2. Let $\mathbb{X}$ be a weighted projective line of type $\left(p_{1}, p_{2}, p_{3}\right)$ and let $E$ be an extension bundle given by a pair $(L, \vec{x})$, where $\vec{x}=l_{1} \vec{x}_{1}+l_{2} \vec{x}_{2}+l_{3} \vec{x}_{3}$. Then $E$ is also an extension bundle determined by the following pairs:

$$
\left(L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right)(-\vec{\omega}), \quad l_{i} \vec{x}_{i}+\sum_{j \neq i}\left(p_{j}-l_{j}-2\right) \vec{x}_{j}\right) \quad \text { for } \quad i=1,2,3,
$$

where $L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right)$ are direct summands of $\mathfrak{P}(E)$. In particular, for each $i \in\{1,2,3\}$, there is an exact short sequence

$$
0 \longrightarrow L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right) \longrightarrow E \longrightarrow L\left(\left(1+l_{i}\right) \vec{x}_{i}+\vec{\omega}\right) \longrightarrow 0 .
$$

Proof. The projective cover of $E$ has the form $\mathfrak{P}(E)=L(\vec{\omega}) \oplus \bigoplus_{i=1}^{3} L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right)$, [9, Theorem 4.6.]. Then there are exact sequences

$$
\eta_{i}: \quad 0 \longrightarrow L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right) \longrightarrow E \longrightarrow \widehat{L}_{i} \longrightarrow 0, \quad \text { for } \quad i=1,2,3,
$$

where from [9, Proposition 3.8] the sheaf $\widehat{L}_{i}$ is a line bundle, for $i=1,2,3$. By comparison of the determinants we obtain that $\widehat{L}_{i}=L\left(\left(1+l_{i}\right) \vec{x}_{i}+\vec{\omega}\right)$ is a direct
summand of the injective hull of $E$. Therefore the sequence $\eta_{i}$ can be presented as follows

$$
0 \longrightarrow L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}-\vec{\omega}\right)(\vec{\omega}) \longrightarrow E \longrightarrow L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}-\vec{\omega}\right)\left(\vec{y}_{i}\right) \longrightarrow 0
$$

where $\vec{y}_{i}=\left(1+l_{i}\right) \vec{x}_{i}+2 \vec{\omega}-\vec{x}=l_{i} \vec{x}_{i}+\sum_{j \neq i}\left(p_{j}-l_{j}-2\right) \vec{x}_{j}$. Since $0 \leq l_{j} \leq p_{j}-2$ we have $0 \leq p_{j}-l_{j}-2 \leq p_{j}-2$, and consequently $0 \leq \vec{y}_{i} \leq \vec{\delta}$.

Theorem 1. Let $\Lambda$ be a canonical algebra with three arms. Then each indecomposable $\Lambda$-module of rank two can be described by matrices having coefficients 0 , $1,-1$.

Proof. Let $M$ be a $\Lambda$-module of rank 2, attached to an indecomposable vector bundle $E$ over the weighted projective line $\mathbb{X}$ associated to $\Lambda$. Then $M$ is in $\bmod _{+}(\Lambda)$. We will show that there is an exact sequence

$$
\eta: \quad 0 \longrightarrow A \longrightarrow E \longrightarrow B \longrightarrow 0
$$

where $A, B \in \bmod _{+}(\Lambda)$ and $(B, A)$ is an orthogonal exceptional pair in $\operatorname{coh}(\mathbb{X})$. Then the result follows from [7, Proposition 7.1].

From [9, Theorem 4.2] the vector bundle $E$ appears as an extension bundle given by a pair $(L, \vec{x})$, this means that there is a short exact sequence

$$
\eta_{L, \vec{x}}: \quad 0 \longrightarrow L(\vec{\omega}) \longrightarrow E \longrightarrow L(\vec{x}) \longrightarrow 0
$$

where $(L(\vec{x}), L(\vec{\omega}))$ is an orthogonal exceptional pair. Since the vector bundle $E$ is attached to the $\Lambda$-module $M$ we have $\operatorname{Ext}_{\mathbb{X}}^{1}(T, E)=0$. Applying the functor $\operatorname{Hom}_{\mathbb{X}}(T,-)$ to the sequence $\eta_{L, \vec{x}}$ we obtain that $\operatorname{Ext}_{\mathbb{X}}^{1}(T, L(\vec{x}))=0$, thus $L(\vec{x})$ is in $\bmod _{+}(\Lambda)$. If in addition $\operatorname{Ext}_{\mathbb{X}}^{1}(T, L(\vec{\omega}))=0$ we are done. Otherwise we will replace the exact sequence $\eta_{L, \vec{x}}$ by another one.

To do so we recall that $L(\vec{\omega})$ is a direct summand of the projective cover $\mathfrak{P}(E)$ and from Lemma 3.1 there is a line bundle $\widehat{L}$, which is a direct summand of $\mathfrak{P}(E)$ and satisfies $\operatorname{Ext}_{\mathbb{X}}^{1}(T, \widehat{L})=0$ thus $\widehat{L}$ is in $\operatorname{coh}_{+}(\mathbb{X})=\bmod _{+}(\Lambda)$. From [9, Theorem 4.6] the line bundle $\widehat{L}$ has the form $L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right)$ for some $i \in\{1,2,3\}$. Thus using Lemma 3.2 we get an exact sequence

$$
0 \longrightarrow L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right) \longrightarrow E \longrightarrow L\left(\left(1+l_{i}\right) \vec{x}_{i}+\vec{\omega}\right) \longrightarrow 0 .
$$

Applying the functor $\operatorname{Hom}_{\mathbb{X}}(T,-)$ to the sequence above we conclude that $\operatorname{Ext}_{\mathbb{X}}^{1}\left(E, L\left(\left(1+l_{i}\right) \vec{x}_{i}+\vec{\omega}\right)=0\right.$ and therefore $L\left(\left(1+l_{i}\right) \vec{x}_{i}+\vec{\omega}\right)$ is in $\bmod _{+}(\Lambda)$. Moreover it is easily checked that $\left(L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right), L\left(\left(1+l_{i}\right) \vec{x}_{i}+\vec{\omega}\right)\right)$ form an orthogonal exceptional pair in $\operatorname{coh}(\mathbb{X})$. Thus we get an exact sequence $\eta$ of the desired form and the theorem is proved.

Remark 3.3. Using Remark 2.1 we get the same result for exceptional modules of rank - 2 from $\bmod _{-}(\Lambda)$.

## 4. EXtension bundles in the case of $t$ numbers of weights

In this section we will deal with a weighted projective line $\mathbb{X}$ of the type $\left(p_{1}, \ldots, p_{t}\right)$ where $t$ is greater than of equal to 3 .
Theorem 2. Let $\mathbb{X}$ be a weighted projective line of a type $\left(p_{1}, \ldots, p_{t}\right)$. Then each indecomposable vector bundle of rank two occurs as the middle term of a non-split exact sequence

$$
\eta: \quad 0 \longrightarrow L(\vec{\omega}) \xrightarrow{i} E \xrightarrow{\pi} L(\vec{x}) \longrightarrow 0,
$$

where $0 \leq \vec{x} \leq \vec{\delta}:=2 \vec{\omega}+\vec{c}=(t-3) \vec{c}+\sum_{i=1}^{t}\left(p_{i}-2\right) \vec{x}_{i}$. Moreover the following conditions are equivalent:
(i) The vector bundle $E$ is exceptional.
(ii) The pair $(L(\vec{x}), L(\vec{\omega}))$ is an orthogonal exceptional pair with $\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega}))=$ $k$.
(iii) $\vec{x}=\sum_{i=1}^{t} l_{i} \vec{x}_{i}$ with $0 \leq l_{i} \leq p_{i}-1$ and there are exactly $t-3$ numbers $l_{i}$ equal to $p_{i}-1$.
(iv) $\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{x}))=0, \operatorname{Hom}_{\mathbb{X}}(E, L(\vec{\omega}))=0=\operatorname{Ext}_{\mathbb{X}}^{1}(E, L(\vec{\omega}))$ and $\operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), E)=0=\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), E)$.

Proof. The proof of the existence of the sequence $\eta$ is almost the same as in the case of a triple weight type, we refer the reader to [9, Theorem 4.2].
$(i) \Rightarrow(i i)$. Assume that $E$ is exceptional and $0 \leq \vec{x} \leq \vec{\delta}$. Then $\vec{x}$ can be written in normal form $\vec{x}=l \vec{c}+\sum_{i=1}^{t} l_{i} \vec{x}_{i}$, with $l \geq 0$ and $0 \leq l_{i} \leq p_{i}-1$ and $\vec{x} \leq \vec{\delta}$. Because $\vec{x}-\vec{\omega} \leq \vec{\delta}-\vec{\omega}=\vec{\omega}-\vec{c}<0$ we have $\operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), L(\vec{x})) \cong S_{\vec{x}-\vec{\omega}}=0$. Similarly, the vector space $\operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), L(\vec{\omega}))$ also vanishes. From Serre duality we get

$$
\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega})) \cong \operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), L(\vec{x}+\vec{\omega})) \cong S_{\vec{x}} \cong k^{l+1}
$$

Now, we have $[E]=[L(\vec{\omega})]+[L(\vec{x})]$ in the Grothendieck group $K_{0}(\mathbb{X})$ and applying the Euler form $\langle-,-\rangle_{\mathbb{X}}: K_{0}(\mathbb{X}) \times K_{0}(\mathbb{X}) \longrightarrow \mathbb{Z}$ we obtain

$$
\begin{aligned}
1 & =\langle[E],[E]\rangle_{\mathbb{X}}=\langle[L(\vec{\omega})]+[L(\vec{x})],[L(\vec{\omega})]+[L(\vec{x})]\rangle_{\mathbb{X}} \\
& =2+\operatorname{dim}_{k} \operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), L(\vec{x}))-\operatorname{dim}_{k} \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{x})) \\
& +\operatorname{dim}_{k} \operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), L(\vec{\omega}))-\operatorname{dim}_{k} \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega})) \\
& =2-(l+1)-\operatorname{dim}_{k} \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{x}))
\end{aligned}
$$

Therefore $-l=\operatorname{dim}_{k} \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{x}))$ and it follows that $l \geq 0$. Consequently $\operatorname{dim}_{k} \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{x}))=0$ and $\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega}))=k$.
$(i i) \Rightarrow(i i i)$. Assume that $(L(\vec{x}), L(\vec{\omega}))$ is an orthogonal exceptional pair, such that $\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega})) \cong k$. The element $\vec{x}$ can be written in normal form $\vec{x}=$ $l \vec{c}+\sum_{i=1}^{t} l_{i} \vec{x}_{i}$, with $l \geq 0$ and $0 \leq l_{i} \leq p_{i}-1$. From Serre duality we obtain that $\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega})) \cong k^{l+1}$. Hence $l=0$. Moreover

$$
0=\operatorname{dim}_{k} \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{x})) \cong D \operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), L(2 \vec{\omega})) \cong S_{2 \vec{\omega}-\vec{x}}
$$

where $2 \vec{\omega}-\vec{x}=(t-4) \vec{c}+\sum_{i=1}^{t}\left(p_{i}-2-l_{i}\right) \vec{x}_{i}<0$. Therefore at least $t-3$ numbers $l_{i}$ have to be equal to $p_{i}-1$. Furthermore, because $\vec{x} \leq \vec{\delta}$ at most $t-3$ numbers $l_{i}$ can be equal to $p_{i}-1$. This implies that exactly $t-3$ numbers $l_{i}$ are equal to $p_{i}-1$.
(iii) $\Rightarrow(i v)$. Assume that the element $\vec{x}$ has normal form $\sum_{i=1}^{t} l_{i} \vec{x}_{i}$ with $0 \leq$ $l_{i} \leq p_{i}-1$ and there are exactly $t-3$ numbers $l_{i}$ equal $p_{i}-1$. Therefore by Serre duality we get

$$
\begin{aligned}
& \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{x})) \cong D \operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), L(2 \vec{\omega})) \cong S_{2 \vec{\omega}-\vec{x}}=0 \\
& \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega})) \cong D \operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), L(\vec{x}+\vec{\omega})) \cong S_{\vec{x}} \cong k
\end{aligned}
$$

Applying the functor $\operatorname{Hom}_{\mathbb{X}}(L(\vec{x}),-)$ to $\eta$ we get an exact sequence

$$
\begin{aligned}
0 & \underbrace{\operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), L(\vec{\omega}))}_{=0} \longrightarrow \operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), E) \longrightarrow \underbrace{\operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), L(\vec{x}))}_{\cong k} \longrightarrow \\
& \stackrel{\delta}{\cong} \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega}))}_{\cong k} \longrightarrow \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), E) \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{x}))}_{=0} \longrightarrow 0 .
\end{aligned}
$$

Now, $\delta\left(\mathbb{1}_{L(\vec{x})}\right)=\eta \neq 0$ because $\eta$ does not split and consequently $\delta$ is isomorphism. Therefore

$$
\operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), F)=0=\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), F) .
$$

The long exact sequence $\operatorname{Hom}_{\mathbb{X}}(\eta, L(\vec{\omega}))$ has the form

$$
\begin{aligned}
0 & \longrightarrow \underbrace{\operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), L(\overrightarrow{\vec{\omega}}))}_{=0, \text { because } \vec{\omega}-\vec{x}<0} \xrightarrow{-\circ \pi} \operatorname{Hom}_{\mathbb{X}}(E, L(\vec{\omega})) \xrightarrow{\text {-oi }} \underbrace{\operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), L(\vec{\omega}))}_{\cong k} \longrightarrow \\
& \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega}))}_{\cong k} \longrightarrow \operatorname{Ext}_{\mathbb{X}}^{1}(E, L(\vec{\omega})) \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{\omega}))}_{=0} \longrightarrow 0 .
\end{aligned}
$$

Let $u: E \longrightarrow L(\vec{\omega})$ be a non-zero morphism. Then $u \circ i: L(\vec{\omega}) \longrightarrow L(\vec{\omega})$ is the zero map. Indeed, if $u \circ i$ is non-zero, it is an isomorphism and so $\eta$ splits which is impossible. Hence $u \in \operatorname{ker}(-\circ i)=\operatorname{Im}(-\circ \pi)=0$, because $\operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), L(\vec{\omega}))=0$. Then $\operatorname{Hom}_{\mathbb{X}}(E, L(\vec{\omega}))=0$ and by comparing dimensions in the sequence $\operatorname{Hom}_{\mathbb{X}}(\eta, L(\vec{\omega}))$ we obtain that $\operatorname{Ext}_{\mathbb{X}}^{1}(E, L(\vec{\omega}))=0$.
$(i v) \Rightarrow(i)$. Assume that the vector spaces $\operatorname{Ext} t_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{x})), \operatorname{Hom}_{\mathbb{X}}(E, L(\vec{\omega}))$, $\operatorname{Ext}_{\mathbb{X}}^{1}(E, L(\vec{\omega})), \operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), E)$ and $\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), E)$ vanish. We apply the functor $\operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}),-)$ to $\eta$ and obtain a long exact sequence

$$
\begin{aligned}
0 & \longrightarrow \underbrace{\operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), L(\vec{\omega}))}_{\cong k} \longrightarrow \operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), E) \longrightarrow \underbrace{\operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), L(\vec{x}))}_{=0} \longrightarrow \\
& \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{\omega}))}_{=0} \longrightarrow \operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), E) \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), L(\vec{x}))}_{=0} \longrightarrow 0 .
\end{aligned}
$$

Hence $\operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), E) \cong k$ and $\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), E)=0$. Finally, we apply the functor $\operatorname{Hom}_{\mathbb{X}}(-, E)$ to $\eta$ and obtain a long exact sequence

$$
\begin{aligned}
0 & \longrightarrow \underbrace{\operatorname{Hom}_{\mathbb{X}}(L(\vec{x}), E)}_{=0} \longrightarrow \operatorname{Hom}_{\mathbb{X}}(E, E) \longrightarrow \underbrace{\operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), E)}_{\cong k} \longrightarrow \\
& \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), E)}_{=0} \longrightarrow \operatorname{Ext}_{\mathbb{X}}^{1}(E, E) \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{\omega}), E)}_{=0} \longrightarrow 0 .
\end{aligned}
$$

Therefore $\operatorname{Hom}_{\mathbb{X}}(E, E)=k$ and $\operatorname{Ext}_{\mathbb{X}}^{1}(E, E)=0$, so the vector bundle $E$ is exceptional.

For an exceptional bundle $E$ the non-split sequence $\eta$ uniquely determines $E$, and in this case we will say that the extension bundle is given by the pair $(L, \vec{x})$ and we will denote it by $E_{L}\langle\vec{x}\rangle$.

Theorem 3. Let $E$ be an indecomposable vector bundle over $\mathbb{X}$ such that there is a short exact sequence

$$
\eta: \quad 0 \longrightarrow L(\vec{\omega}) \xrightarrow{i} E \xrightarrow{\pi} L(\vec{x}) \longrightarrow 0,
$$

where $\vec{x}=\sum_{i=1}^{t} l_{i} \vec{x}_{i}$, with $0 \leq l_{i} \leq p_{i}-1$ and $0 \leq \vec{x} \leq \vec{\delta}$. Moreover, let $I=\left\{i \mid l_{i} \neq\right.$ $\left.p_{i}-1\right\}$. Then

$$
\begin{aligned}
& \mathfrak{P}\left(E_{L}\langle\vec{x}\rangle\right)=L(\vec{\omega}) \oplus \bigoplus_{j \in I} L\left(\vec{x}-\left(1+l_{j}\right) \vec{x}_{j}\right) \\
& \Im\left(E_{L}\langle\vec{x}\rangle\right)=L(\vec{x}) \oplus \bigoplus_{j \in I} L\left(\left(1+l_{j}\right) \vec{x}_{j}+\vec{\omega}\right)
\end{aligned}
$$

Further, the line bundle summands of $\mathfrak{P}\left(E_{L}\langle\vec{x}\rangle\right)$ (resp. $\mathfrak{I}\left(E_{L}\langle\vec{x}\rangle\right)$ ) are mutually $\operatorname{Hom}_{\mathbb{X}}$-orthogonal.
Proof. Observe that the condition $0 \leq \vec{x} \leq \vec{\delta}$ implies that $\# I \geq 3$. We will consider the case of injective hulls, the arguments for projective covers are dual.

From Serre duality we obtain that $\operatorname{Ext}_{\mathbb{X}}^{1}\left(L(\vec{x}), L\left(\vec{\omega}+\left(1+l_{j}\right) \vec{x}_{j}\right)\right)=0$ for $j \in I$. Hence, applying the functor $\operatorname{Hom}_{\mathbb{X}}\left(-, L\left(\vec{\omega}+\left(1+l_{j}\right) \vec{x}_{j}\right)\right)$ for $j \in I$ to $\eta$ we see that there are morphisms $\widetilde{x_{j}^{l_{j}+1}}: E \longrightarrow L\left(\vec{\omega}+\left(1+l_{j}\right) \vec{x}_{j}\right)$ such that $\widetilde{x_{j}^{l_{j}+1}} \circ i=x_{j}^{l_{j}+1}$ where $x_{j}^{l_{j}+1}: L(\vec{\omega}) \longrightarrow L\left(\vec{\omega}+\left(1+l_{j}\right) \vec{x}_{i}\right)$. We will show that $j_{E}=\left(\pi,\left(\widetilde{x_{j}^{l_{j}+1}}\right)_{j \in I}\right)$ : $E \longrightarrow L(\vec{x}) \oplus \bigoplus_{j \in I} L\left(\vec{\omega}+\left(1+l_{j}\right) \vec{x}_{j}\right)$ is an injective hull of the bundle $E$. For this we will prove that each morphism $E \longrightarrow L^{\prime}$ where $L^{\prime}$ is a line bundle, factors through $L(\vec{x}) \oplus \bigoplus_{j \in I} L\left(\vec{\omega}+\left(1+l_{j}\right) \vec{x}_{j}\right)$. For simplicity we can write $L^{\prime}$ as $L(\vec{\omega}+\vec{z})$ for same $\vec{z} \in \mathbb{L}$. Remark, that for $j \notin I$ the space $\operatorname{Ext}_{\mathbb{X}}^{1}\left(L(\vec{x}), L\left(\vec{\omega}+\left(1+l_{j}\right) \vec{x}_{j}\right)\right) \neq 0$, and there are no maps $\widetilde{x_{j}^{l_{j}+1}}$ for $j \notin I$.

First, we show that

$$
(\star) \quad \operatorname{Hom}_{\mathbb{X}}(E, L(\vec{\omega}+\vec{z}))=0 \quad \text { for } \quad 0 \leq \vec{z} \leq \vec{x} .
$$

Indeed, let $\vec{z}=\sum_{j=1}^{t} a_{j} \vec{x}_{j}$ be an element of $\mathbb{L}$ with $0 \leq a_{j} \leq l_{j}$ for all $j$ and let $z=x_{1}^{a_{1}} x_{2}^{a_{2}} \cdots x_{t}^{a_{t}}$ be a morphism form $L(\vec{\omega})$ to $L(\vec{\omega}+\vec{z})$. Applying the functor $\operatorname{Hom}_{\mathbb{X}}(E,-)$ to the sequence $0 \longrightarrow L(\vec{\omega}) \xrightarrow{z} L(\vec{\omega}+\vec{z}) \longrightarrow S \longrightarrow 0$ we obtain that $\operatorname{Ext}_{\mathbb{X}}^{1}(E, L(\vec{\omega}))=0$. Next, applying the functor $\operatorname{Hom}_{\mathbb{X}}(-, L(\vec{\omega}+\vec{z}))$ to $\eta$ we obtain a long exact sequence

$$
\begin{aligned}
& 0 \longrightarrow \operatorname{Hom}_{\mathbb{X}}(E, L(\vec{\omega}+\vec{z})) \longrightarrow \underbrace{\operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), L(\vec{\omega}+\vec{z}))}_{\cong k} \longrightarrow \\
& \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(L(\vec{x}), L(\vec{\omega}+\vec{z}))}_{\cong k} \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(E, L(\vec{\omega}+\vec{z}))}_{=0} \longrightarrow \cdots
\end{aligned}
$$

By comparing dimensions we get $\operatorname{Hom}_{\mathbb{X}}(E, L(\vec{\omega}+\vec{z}))=0$.
Let $h: E \longrightarrow L(\vec{\omega}+\vec{z})$ be a non-zero morphism for some $z \in \mathbb{L}$. Because $\eta$ is a non-split exact sequence, the map $h \circ i: L(\vec{\omega}) \xrightarrow{i} E \xrightarrow{h} L(\vec{\omega}+\vec{z})$ is a nonisomorphism. If $h \circ i$ is the zero map, then $h$ factors through by $\pi$ and we are done. Suppose now that $h \circ i \neq 0$. Then $\vec{z} \geq 0$, because $\operatorname{Hom}_{\mathbb{X}}(L(\vec{\omega}), L(\vec{\omega}+\vec{z})) \neq 0$. Moreover, from property ( $\star$ ) we have $\vec{z} \not \leq \vec{x}$, and so $\vec{x}-\vec{z} \nsupseteq 0$. Now, we prove that there are maps $h_{j}: L\left(\left(l_{j}+1\right) \vec{x}_{j}+\vec{\omega}\right) \longrightarrow L(\vec{\omega}+\vec{z})$ for $j \in I$ such that $h \circ i=$ $\sum_{j \in I} h_{j} \circ x_{j}^{l_{j}+1}$. Since $z \geq 0$ and $\vec{x}-\vec{z} \nsupseteq 0$, after standard calculation in the group $\mathbb{L}(\underline{p})$, we see that there is an index $j_{0} \in I$ such that $\vec{z}-\left(l_{j_{0}}+1\right) \vec{x}_{j_{0}} \geq 0$. Therefore
there is a map $h_{j_{0}}: L\left(\left(l_{j_{0}}+1\right) \vec{x}_{j_{0}}+\vec{\omega}\right) \longrightarrow L(\vec{\omega}+\vec{z})$ such that $h \circ i=h_{j_{0}} \circ x_{j_{0}}^{l_{j_{0}}+1}$. Further we define $h_{j}=0$ for $j \neq j_{0}$.

Then we have
$\left.\left(h-\sum_{j \in I} h_{j} \circ \widetilde{x_{j}^{l_{j}+1}}\right) \circ i=h \circ i-\sum_{j \in I} h_{j} \circ \widetilde{\left(x_{j}^{l_{j}+1}\right.} \circ i\right)=h \circ i-\sum_{j \in I} h_{j} \circ x_{j}^{l_{j}+1}=0$,
and we conclude that $h-\sum_{j \in I} h_{j} \circ \widetilde{x_{j}^{l_{j}+1}} \in \operatorname{ker}(-\circ i)=\operatorname{Im}(-\circ \pi)$. Thus there is a map $g: L(\vec{x}) \longrightarrow L(\vec{\omega}+\vec{z})$ such that $g \circ \pi=h-\sum_{j \in I} h_{j} \circ \widetilde{x_{j}^{l_{j}+1}}$ and hence $h=g \circ \pi+\sum_{j \in I} h_{j} \circ \widetilde{x_{j}^{l_{j}+1}}$.

The $\operatorname{Hom}_{\mathbb{X}}$-orthogonality is easy to check. The minimality for the map $j_{E}$ : $E \longrightarrow L(\vec{x}) \oplus \bigoplus_{j \in I} L\left(\left(l_{j}+1\right) \vec{x}_{j}+\vec{\omega}\right)$ follows then from the Hom $\mathbb{X}$ - orthogonality of the line bundles $L(\vec{x})$ and $L\left(\left(l_{j}+1\right) \vec{x}_{j}+\vec{\omega}\right)$ for $j \in I$.
Remark 4.1. In [9] it was shown that in the case of weight type $(2, a, b)$ the suspension functor [1] in the stable vector bundle category vect $(\mathbb{X})$ coincides with the shift functor by $\vec{x}_{1}$. Therefore there is a short exact sequence

$$
0 \longrightarrow \mathfrak{P}(E)\left(-\vec{x}_{1}\right) \longrightarrow E \longrightarrow \mathfrak{P}(E) \longrightarrow 0
$$

for each indecomposable bundle $E$. Hence in this case we have $\operatorname{rkP}(E)=2 \operatorname{rk} E$. From the theorem above we see that in the case of $t$ weights with $t>3$ there is an indecomposable, not exceptional rank two bundle such that $\operatorname{rkP}(E)>4=2 \mathrm{rk} E$.

For example in the case $(2,2,2,3)$ the projective cover of an indecomposable bundle of the data $\left(L, \vec{x}_{4}\right)$ has rank 5 . Therefore in the case $\left(2, p_{2}, p_{3}, \cdots, p_{t}\right)$ and $t>3$ the suspension functor cannot be realized by a shift with an element from $\mathbb{L}$.

In the same way as Lemma 3.1 and Lemma 3.2. the section 3, we can prove the following two lemmata.
Lemma 4.2. Let $E$ be a non-zero vector bundle over $\mathbb{X}$ of a type $\left(p_{1}, p_{2}, \ldots, p_{t}\right)$ with a projective cover $\mathfrak{P}(E)$. If $\operatorname{Ext}_{\mathbb{X}}^{1}(T, E)=0$ for the canonical bundle $T$, then there is a line bundle $L$ in the decomposition $\mathfrak{P}(E)$ into a direct sum of line bundles such that $\operatorname{Ext}_{\mathbb{X}}^{1}(T, L)=0$.

From Theorem 2 each extension bundle can be given by a line bundle $L$ and an element $\vec{x}=\sum_{i \in I} l_{i} \vec{x}_{i}+\sum_{i \notin I}\left(p_{i}-1\right) \vec{x}_{i} \in \mathbb{L}$ for some $I \subset\{1,2, \ldots, t\}$ with $\# I=3$.
Lemma 4.3. Let $\mathbb{X}$ be a weighted projective line of type $\left(p_{1}, p_{2}, \ldots, p_{t}\right)$ and let $E$ be an extension bundle given by a pair $(L, \vec{x})$, where $\vec{x}=\sum_{i \in I} l_{i} \vec{x}_{i}+\sum_{i \notin I}\left(p_{i}-1\right) \vec{x}_{i}$. Denote by $\widehat{L}_{i}$ the direct summand $L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right)$ of $\mathfrak{P}(E)$.
(i) There is an exact sequence

$$
0 \longrightarrow \widehat{L}_{i} \longrightarrow E \longrightarrow L\left(\left(1+l_{j}\right) x_{j}+\vec{\omega}\right) \longrightarrow 0
$$

where $L\left(\left(1+l_{j}\right) x_{j}+\vec{\omega}\right)$ is a direct summand od $\mathfrak{I}(E)$.
(ii) The extension bundle $E$ can be determined by the following pairs

$$
\left(L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right)(-\vec{\omega}), \quad 2 \vec{\omega}+2\left(1+l_{i}\right) \vec{x}_{i}-\vec{x}\right) \quad \text { for } \quad i \in I
$$

(iii) The element $2 \vec{\omega}+2\left(1+l_{i}\right) \vec{x}_{i}-\vec{x}$ in normal form has exactly $t-3$ coefficients equal to $p_{i}-1$ for $i \notin I$.

Proof. The statements (i) and (ii) are proved in the same way as in the case of three weights. The part (iii) follows from calculations in the group $\mathbb{L}$ and is left to the reader.

The next result is a generalization of Theorem 1 and can be proved analogously using Lemma 4.2 and Lemma 4.3.

Theorem 4. Let $\Lambda=\Lambda(\underline{p}, \underline{\lambda})$ be a canonical algebra with $t$ arms. Then each exceptional $\Lambda$-module of rank two can be described by matrices having entries 0 , $\lambda_{i}$ and $-\lambda_{i}$.

## 5. EXCEPTIONAL COKERNELS

In this section we will deal with cokernels of maps of the form

$$
\begin{equation*}
\left[x_{i}^{b_{i}}\right]_{i \in I}: \mathcal{O}(\vec{y}) \longrightarrow \bigoplus_{i \in I} \mathcal{O}\left(\vec{y}+b_{i} \vec{x}_{i}\right) \tag{1}
\end{equation*}
$$

where $I \subset\{1,2, \ldots, t\}, 0<b_{i}<p_{i}-1$ for $i \in I$ and $\vec{y} \in \mathbb{L}_{+}$. We will prove that such cokernels are exceptional modules. Moreover every exceptional module of rank two, can be obtain in this way. Finally, by the cokernel construction, we compute matrices for each exceptional module of rank two.

Lemma 5.1. Consider an exact sequence

$$
(\star) \quad 0 \longrightarrow F \xrightarrow{f} G \xrightarrow{\pi} E \longrightarrow 0
$$

in $\operatorname{coh}(\mathbb{X})$ such that the following conditions are satisfied.
C1. $F$ is exceptional,
C2. $\operatorname{Hom}_{\mathbb{X}}(G, F)=0=\operatorname{Ext}_{\mathbb{X}}^{1}(G, F)$,
C3. $\operatorname{Ext}_{\mathbb{X}}^{1}(G, G)=0$,
C 4 . The map $-\circ f: \operatorname{End}_{\mathbb{X}}(G) \longrightarrow \operatorname{Hom}_{\mathbb{X}}(F, G)$ is an isomorphism.
Then the following properties holds:
(i) $\operatorname{Ext}_{\mathbb{X}}^{1}(E, F) \cong k$ and $\operatorname{Hom}_{\mathbb{X}}(E, G)=0=\operatorname{Ext}_{\mathbb{X}}^{1}(E, G)$,
(ii) $E$ is exceptional,
(iii) Up to an isomorphism $E$ does not depend on the map $f$.

Proof. (i), Applying the functor $\operatorname{Hom}_{\mathbb{X}}(-, F)$ to the exact sequence $(\star)$ we obtain a long exact sequence

$$
\cdots \longrightarrow \underbrace{\operatorname{Hom}_{\mathbb{X}}(G, F)}_{=0} \longrightarrow \operatorname{End}_{\mathbb{X}}(F) \longrightarrow \operatorname{Ext}_{\mathbb{X}}^{1}(E, F) \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(G, F)}_{=0} \longrightarrow \cdots
$$

Therefore $\operatorname{Ext}_{\mathbb{X}}^{1}(E, F) \cong \operatorname{End}_{\mathbb{X}}(F) \cong k$.
Furthermore, applying the functor $\operatorname{Hom}_{\mathbb{X}}(-, G)$ to $(\star)$ we obtain a long exact sequence

$$
\begin{aligned}
& 0 \longrightarrow \operatorname{Hom}_{\mathbb{X}}(E, G) \xrightarrow{-\circ \pi} \operatorname{End}_{\mathbb{X}}(G) \xrightarrow{-\circ f} \operatorname{Hom}_{\mathbb{X}}(F, G) \xrightarrow{\delta} \operatorname{Ext}_{\mathbb{X}}^{1}(E, G) \longrightarrow \\
& \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(G, G)}_{=0} \longrightarrow \operatorname{Ext}_{\mathbb{X}}^{1}(F, G) \longrightarrow 0 .
\end{aligned}
$$

Because $-\circ f$ is an isomorphism we get $\operatorname{Hom}_{\mathbb{X}}(E, G)=0$ and $\operatorname{Ext}_{\mathbb{X}}^{1}(E, G)=0$
(ii). Applying the functor $\operatorname{Hom}_{\mathbb{X}}(E,-)$ to the exact sequence $(\star)$ we have a long exact sequence

$$
\begin{aligned}
0 & \longrightarrow \operatorname{Hom}_{\mathbb{X}}(E, F) \longrightarrow \overbrace{\operatorname{Hom}_{\mathbb{X}}(E, G)}^{=0} \longrightarrow \operatorname{End}_{\mathbb{X}}(E) \longrightarrow \\
& \longrightarrow \operatorname{Ext}_{\mathbb{X}}^{1}(E, F) \longrightarrow \underbrace{\operatorname{Ext}_{\mathbb{X}}^{1}(E, G)}_{=0} \longrightarrow \operatorname{Ext}_{\mathbb{X}}^{1}(E, E) \longrightarrow 0 .
\end{aligned}
$$

We conclude that $\operatorname{Ext}_{\mathbb{X}}^{1}(E, E)=0$, and using (i) also that $\operatorname{End}_{\mathbb{X}}(E) \cong \operatorname{Ext}_{\mathbb{X}}^{1}(E, F) \cong$ $k$.
(iii). Suppose that we have exact sequences

$$
0 \longrightarrow F \xrightarrow{f} G \longrightarrow E \longrightarrow 0 \quad \text { and } \quad 0 \longrightarrow F \xrightarrow{\widehat{f}} G \longrightarrow \widehat{E} \longrightarrow 0
$$

Then we have $[E]=[G]-[F]=[\widehat{E}]$ in the Grothendieck group $\mathrm{K}_{0}(\mathbb{X})$. From (ii) we know that the sheaves $E$ and $\widehat{E}$ are exceptional. We infer from [12, Proposition 4.4.1] that $E \cong \widehat{E}$.

We will study the following cases of maps satisfying conditions C1. C4. of the previous proposition.
a. A map $\left[x_{1}^{b_{1}}, \ldots, x_{t}^{b_{t}}\right]^{T}: \mathcal{O} \longrightarrow \bigoplus_{i=1}^{t} \mathcal{O}\left(b_{i} \vec{x}_{i}\right)$, where $1 \leq b_{i} \leq p_{i}-1$.
b. For $J \subseteq\{1, \ldots, t\}$ we consider $\left[x_{i}^{b_{i}}\right]_{i \in J}: \mathcal{O} \longrightarrow \bigoplus_{i \in J} \mathcal{O}\left(b_{i} \vec{x}_{i}\right)$, where $1 \leq$ $b_{i} \leq p_{i}-1$ for $i=1, \ldots, t$.
c. If $f: F \longrightarrow G$ satisfies the conditions C1.-C4. then for each $\vec{x} \in \mathbb{L}$ the map $f(\vec{x}): F(\vec{x}) \longrightarrow G(\vec{x})$ also satisfies these conditions.

Note that if $G$ is in $\bmod _{+}(\Lambda)$ in the sequence $(\star)$, then $E$ is also in $\bmod _{+}(\Lambda)$. Therefore in the cases $\mathbf{a}$. and $\mathbf{b}$. above the cokernels are exceptional $\Lambda$-modules.

Let $\mathbb{X}=\mathbb{X}\left(p_{1}, p_{2}, \ldots, p_{t}\right)$ be a weighted projective line and let $b_{i}, i=1, \ldots, t$ are natural number such that $1 \leq b_{i} \leq p_{i}-1$. Denote $I=\left\{i: b_{i}<p_{i}-1\right\}$ and assume that $\# I=3$.

Proposition 5.2. The cokernel $E$ of the exact sequence

$$
(\star) \quad 0 \longrightarrow L \xrightarrow{f=\left[x_{i}^{b_{i}}\right]} i_{i \in I} \bigoplus_{i \in I} L\left(b_{i} \vec{x}_{i}\right) \xrightarrow{\pi} E \longrightarrow 0
$$

is an extension bundle with data

$$
\left(L\left(b_{i_{0}} x_{i_{0}}-\vec{\omega}\right), \quad \vec{\omega}+\sum_{i \in I} b_{i} \vec{x}_{i}-2 b_{i_{0}} \vec{x}_{i_{0}}\right) \quad \text { for each } \quad i_{0} \in I .
$$

Moreover for each $i_{0} \in I$ the line bundle $L\left(b_{i_{0}} \vec{x}_{i_{0}}\right)$ is a direct summand of the projective cover $\mathfrak{P}(E)$.

Proof. From Lemma 5.1 we conclude

$$
\operatorname{Hom}_{\mathbb{X}}\left(E, L\left(b_{i_{0}} \vec{x}_{i_{0}}\right)\right)=0=\operatorname{Ext} \frac{1}{\mathbb{X}}\left(E, L\left(b_{i_{0}} \vec{x}_{i_{0}}\right)\right) \quad \text { for each } \quad i_{0} \in I .
$$

Applying the functor $\operatorname{Hom}_{\mathbb{X}}\left(L\left(b_{i_{0}} \vec{x}_{i_{0}}\right),-\right)$ to $(\star)$ we obtain a long exact sequence

$$
\begin{aligned}
0 & \longrightarrow \overbrace{\operatorname{Hom}_{\mathbb{X}}\left(L\left(b_{i_{0}} \vec{x}_{i_{0}}\right), L\right)}^{=0} \longrightarrow \operatorname{Hom}_{\mathbb{X}}\left(L\left(b_{i_{0}} \vec{x}_{i_{0}}\right), \bigoplus_{i=1}^{3} L\left(b_{i} \vec{x}_{i}\right)\right) \longrightarrow \\
& \longrightarrow \operatorname{Hom}_{\mathbb{X}}\left(L\left(b_{i_{0}} \vec{x}_{i_{0}}\right), E\right) \longrightarrow \underbrace{\operatorname{Ext} \frac{1}{\mathbb{X}}\left(L\left(b_{i_{0}} \vec{x}_{i_{0}}\right), L\right)}_{=0} \longrightarrow \cdots .
\end{aligned}
$$

Therefore $\operatorname{Hom}_{\mathbb{X}}\left(L\left(b_{i_{0}} \vec{x}_{i_{0}}\right), E\right) \cong \operatorname{Hom}_{\mathbb{X}}\left(L\left(b_{i_{0}} \vec{x}_{i_{0}}\right), \bigoplus_{i=1}^{3} L\left(b_{i} \vec{x}_{i}\right)\right) \cong k$. We denote $\pi=\left[\pi_{i}\right]_{i \in I}$. Then each sequence

$$
\eta_{i}: \quad 0 \longrightarrow L\left(b_{i} \vec{x}_{i}\right) \xrightarrow{\pi_{i}} E \longrightarrow C_{i} \longrightarrow 0 \quad \text { for } \quad i \in I
$$

satisfies the conditions C1.C3. from Lemma 5.1 Because End $(E) \cong k \cong$ $\operatorname{Hom}_{\mathbb{X}}\left(L\left(b_{i} \vec{x}_{i}\right), E\right)$, the map $-\circ \pi_{i}: \operatorname{End}_{\mathbb{X}}(E) \longrightarrow \operatorname{Hom}_{\mathbb{X}}\left(L\left(b_{i} \vec{x}_{i}\right), E\right)$ is an isomorphism or is zero. Further, since $\pi \neq 0$, at least one map $-\circ \pi_{i}$ is an isomorphism.

Assume that $-\circ \pi_{j_{0}}$ is an isomorphism. Then from Lemma 5.1 the term $C_{j_{0}}$ of $\eta_{j_{0}}$ is exceptional, therefore it is a line bundle. Moreover $\operatorname{det} C_{j_{0}}=\operatorname{det} E-$ $\operatorname{det} L\left(b_{j_{0}} \vec{x}_{j_{0}}\right)=\operatorname{det} L+\sum_{i \in I, i \neq j_{0}} b_{i} \vec{x}_{i}$, and it follows that $C_{j_{0}} \cong L\left(\sum_{i \in I, i \neq j_{0}} b_{i} \vec{x}_{i}\right)$. The exact sequence $\eta_{j_{0}}$ can be written in the following form

$$
0 \longrightarrow L\left(b_{j_{0}} \vec{x}_{j_{0}}-\vec{\omega}\right)(\vec{\omega}) \longrightarrow E \longrightarrow L\left(b_{j_{0}} \vec{x}_{j_{0}}-\vec{\omega}\right)(\vec{x}) \longrightarrow 0,
$$

where

$$
\begin{aligned}
\vec{x} & =\vec{\omega}-b_{j_{0}} \vec{x}_{j_{0}}+\sum_{i \in I, i \neq j_{0}} b_{i} \vec{x}_{i} \\
& =\left(p_{j_{0}}-b_{j_{0}}-1\right) \vec{x}_{j_{0}}+\sum_{i \in I, i \neq j_{0}}\left(b_{i}-1\right) \vec{x}_{i}+\sum_{j \notin I}\left(p_{j}-1\right) \vec{x}_{j} .
\end{aligned}
$$

Then the element $\vec{x}$ satisfies the inequality $0 \leq \vec{x} \leq \vec{\delta}$, and consequently $E$ is an extension bundle with the data $\left(L\left(b_{j_{0}} x_{j_{0}}-\vec{\omega}\right), \vec{x}\right)$.

Moreover, from Theorem 3, the line bundles $L\left(b_{i} \vec{x}_{i}\right)$ for $i \in I, i \neq j$ are direct summands of the projective cover of the vector bundle $E$. Thus, from Lemma 4.3 the bundle $E$ is an extension bundle with the data $\left(L\left(b_{i_{0}} x_{i_{0}}-\vec{\omega}\right), \vec{\omega}+\sum_{i \in I} b_{i} \vec{x}_{i}-\right.$ $\left.2 b_{i_{0}} \vec{x}_{i_{0}}\right)$ for each $i_{0} \in I$.
Proposition 5.3. Let $E=E_{L}\langle\vec{x}\rangle$ be an extension bundle with $\vec{x}=\sum_{i \in I} l_{i} \vec{x}_{i}+$ $\sum_{j \notin I}\left(p_{j}-1\right) \vec{x}_{j}$ and $\# I=3$. Then $E$ is the cokernel in the following exact sequence

$$
0 \longrightarrow L(\vec{x}-\vec{c}) \stackrel{\left[x_{i}^{p_{i}-l_{i}-1}\right]}{\longrightarrow}{ }_{i \in I} \bigoplus_{i \in I} L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right) \longrightarrow E \longrightarrow 0
$$

Moreover, the line bundles $L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right)$ are direct summands of $\mathfrak{P}(E)$ and $L(\vec{x}-\vec{c})$ is direct summand of $\Im(E)(-\vec{c})$.

Proof. Consider the map $\left[x_{i}^{p_{i}-l_{i}-1}\right]_{i \in I}: L(\vec{x}-\vec{c}) \longrightarrow \bigoplus_{i \in I} L\left(\vec{x}-\left(1+l_{i}\right) \vec{x}_{i}\right)$. This map is a monomorphism and from the Proposition 5.2 the cokernel of the map $\left[x_{i}^{p_{i}-l_{i}-1}\right]_{i \in I}$ is the extension bundle with data $(L, \vec{x})$. Hence coker $\left[x_{i}^{p_{i}-l_{i}-1}\right]_{i \in I} \cong$
$E_{L}\langle\vec{x}\rangle$. The second claim follows from the form of the projective cover and the injective hull of the extension bundle $E_{L}\langle\vec{x}\rangle$.
Lemma 5.4. A line bundle $L$ is in $\bmod _{+}(\Lambda)$ if and only if $\operatorname{det} L \geq 0$.
Proof. Assume first that $L$ is in $\bmod _{+}(\Lambda)$, ie. Ext $\mathbb{1}_{\mathbb{X}}(T, L)=0$. Then $\operatorname{Hom}_{\mathbb{X}}(T, L) \neq$ 0 , so there is an element $\vec{x} \in \mathbb{L}$ such that $0 \leq \vec{x} \leq \vec{c}$ and $\operatorname{Hom}_{\mathbb{X}}(\mathcal{O}(\vec{x}), L) \neq 0$. Therefore $\operatorname{det} L-\vec{x} \geq 0$, so $\operatorname{det} L=\underbrace{\operatorname{det} L-\vec{x}}_{\geq 0}+\underbrace{\vec{x}}_{\geq 0} \geq 0$.

Now, assume that $\operatorname{det} L=n \vec{c}+\sum_{i=1}^{t} a_{i} \vec{x}_{i} \geq 0$. Let $\vec{x} \in \mathbb{L}$ satisfy that $0 \leq$ $\vec{x} \leq \vec{c}$. Then $\vec{x}+\vec{\omega}-\operatorname{det} L=\vec{x}+\sum_{i=1}^{t}\left(p_{i}-a_{i}-1\right) \vec{x}_{i}-(n+2) \vec{c} \nsupseteq 0$. Therefore $\operatorname{Ext}_{\mathbb{X}}^{1}(\mathcal{O}(\vec{x}), L) \cong D \operatorname{Hom}_{\mathbb{X}}(L, \mathcal{O}(\vec{x}+\vec{\omega}))=0$, and consequently the line bundle $L$ is in $\bmod _{+}(\Lambda)$.
Proposition 5.5. Let $E$ be an extension bundle.
(i) For each direct summand $\widehat{L}$ of $\mathfrak{I}(E)$ there is a short exact sequence

$$
\eta_{\widehat{L}}: \quad 0 \longrightarrow \widehat{L}(-\vec{c}) \longrightarrow \bigoplus_{i=1}^{3} L_{i} \longrightarrow E \longrightarrow 0
$$

where the $L_{i}$ are pairwise distinct direct summands of projective cover $\mathfrak{P}(E)$.
(ii) If $E$ is a $\Lambda$-module from $\bmod _{+}(\Lambda)$, then for at least one direct summand $\widehat{L}$ of $\mathfrak{I}(E)$ the line bundle $\widehat{L}(-\vec{c})$ is in $\bmod _{+}(\Lambda)$ and $\eta_{\widehat{L}}$ is a sequence of $\Lambda$-modules.

Proof. The statement (i) is a consequence of Lemma 4.3 and Proposition 5.3,
(ii). Since $E$ is an extension bundle there is an exact sequence

$$
0 \longrightarrow L(\vec{\omega}) \longrightarrow E \longrightarrow L(\vec{x}) \longrightarrow 0

of $\Lambda$-modules, where $\vec{x}=\sum_{i \in I} l_{i} \vec{x}_{i}+\sum_{j \notin I}\left(p_{j}-1\right) \vec{x}_{j}$ with $\# I=3$ and $0 \leq l_{i} \leq$ $p_{i}-2$. Recall form Lemma 5.4 that $\operatorname{det} L(\vec{\omega}) \geq 0$ and $\operatorname{det} L(\vec{x}) \geq 0$.

The direct summands of the injective hull $\mathfrak{I}(E)$ are as follows

If the line bundle $L(\vec{x}-\vec{c})$ is in $\bmod _{+}(\Lambda)$, we put $\widehat{L}=L(\vec{x})$ and the claim holds. Assume now that $L(\vec{x}-\vec{c})$ does not belong to $\bmod _{+}(\Lambda)$, then $\operatorname{det} L(\vec{x}-\vec{c}) \nsupseteq 0$. We write $\operatorname{det} L$ in normal form $\operatorname{det} L=n \vec{c}+\sum_{i=1}^{t} a_{i} \vec{x}_{i}$ and define two numbers $m$ and $m_{I}$ as follows

Then we can write $\operatorname{det} L(\vec{x})$ in normal form

& =\left(n+m+m_{I}\right) \vec{c}+\sum_{i \in I} b_{i} \vec{x}_{i}+\sum_{i \notin I} c_{i} \vec{x}_{i} \geq 0,
\end{aligned}

where

Since

\operatorname{det} L(\vec{x}-\vec{c})=\left(n+m+m_{I}-1\right) \vec{c}+\sum_{i \in I} b_{i} \vec{x}_{i}+\sum_{i \notin I} c_{i} \vec{x}_{i} \nsupseteq 0,
$$

we have $n+m+m_{I}=0$, hence $(\star) n+m=-m_{I}$. Similarly we compute the determinant for the line bundle $L(\vec{\omega})$. We have

\operatorname{det} L(\vec{\omega})=n \vec{c}+\sum_{i=1}^{t} a_{i} \vec{x}_{i}+(t-2) \vec{c}-\sum_{i=1}^{t} \vec{x}_{i}=(n+t-2) \vec{c}+\sum_{i=1}^{t}\left(a_{i}-1\right) \vec{x}_{i},
$$

where $\sum_{i=1}^{t}\left(a_{i}-1\right) \vec{x}_{i}=-(t-3-m) \vec{c}+\sum_{i \in I}\left(a_{i}-1\right) \vec{x}_{i}+\sum_{i \notin I} b_{i} \vec{x}_{i}$. We denote by $d_{i}$ the number $p_{i}-1$ if $a_{i}=0$ or $a_{i}-1$ if $a_{i}>0$. Then

\operatorname{det} L(\vec{\omega}) & =(n+m+1) \vec{c}+\sum_{i \in I}\left(a_{i}-1\right) \vec{x}_{i}+\sum_{i \notin I} d_{i} \vec{x}_{i} \\
& =\left(1-m_{I}\right) \vec{c}+\sum_{i \in I}\left(a_{i}-1\right) \vec{x}_{i}+\sum_{i \notin I} d_{i} \vec{x}_{i} \geq 0 .
\end{aligned}
$$

Therefore $m_{I}$ is equal to 0 or 1 . Moreover if $m_{I}=1$ then $a_{i}>0$ for all $i \in I$, and if $m_{I}=0$, then at most one of the numbers $a_{i}$ for $i \in I$ is 0 .

In the case $m_{I}=1$ there is an index $i_{0} \in I$ such that $a_{i_{0}}+l_{i_{0}} \geq p_{i_{0}}$ Then

\operatorname{det} L\left(\vec{\omega}+\left(1+l_{i_{0}}\right) \vec{x}_{i_{0}}-\vec{c}\right) & =-\vec{c}+\sum_{i \in I}\left(a_{i}-1\right) \vec{x}_{i}+\left(1+l_{i_{0}}\right) \vec{x}_{i_{0}}+\sum_{i \notin I} d_{i} \vec{x}_{i} \\
& =\left(a_{i_{0}}+l_{i_{0}}-p_{i_{0}}\right) \vec{x}_{i_{0}}+\sum_{i \in I, i \neq i_{0}} \underbrace{\left(a_{i}-1\right)}_{\geq 0} \vec{x}_{i}+\sum_{i \notin I} d_{i} \vec{x}_{i} \geq 0 .
\end{aligned}
$$

Therefore $L\left(\vec{\omega}+\left(1+l_{i_{0}}\right) \vec{x}_{i_{0}}-\vec{c}\right)$ is in $\bmod _{+}(\Lambda)$ and we put $\widehat{L}=L\left(\vec{\omega}+\left(1+l_{i_{0}}\right) \vec{x}_{i_{0}}\right)$.
In the case that $m_{I}=0$ if $a_{i}>0$ for all $i \in I$ then each line bundle $L(\vec{\omega}+$ $\left.\left(1+l_{i}\right) \vec{x}_{i}-\vec{c}\right)$ is in $\bmod _{+}(\Lambda)$ and each of those line bundles gives us the claim. If $a_{i_{0}}=0$ for some $i_{0} \in I$, then only $L\left(\vec{\omega}+\left(1+l_{i_{0}}\right) \vec{x}_{i_{0}}-\vec{c}\right)$ is in $\bmod _{+}(\Lambda)$ and we put $\widehat{L}=L\left(\vec{\omega}+\left(1+l_{i_{0}}\right) \vec{x}_{i_{0}}\right)$.

As a conclusion of the previous proposition, we obtain an improvement of Lemma 3.1.

Corollary 1. If an extension bundle $E$ is a $\Lambda$-module, then at least three direct summands of $\mathfrak{P}(E)$ are also $\Lambda$-modules.

Recall that we work with a map of the form

then we distinguish the following 8 cases:

$\mathbf{B}_{2} a_{i_{2}}+b_{i_{2}} \geq p_{i_{2}}$ and $a_{j}+b_{j}<p_{j}$ for $j \in I-\left\{i_{2}\right\}$,
$\mathbf{B}_{3} a_{i_{3}}+b_{i_{3}} \geq p_{i_{3}}$ and $a_{j}+b_{j}<p_{j}$ for $j \in I-\left\{i_{3}\right\}$,
$\mathbf{C}_{1} a_{i_{1}}+b_{i_{1}}<p_{i_{1}}$ and $a_{j}+b_{j} \geq p_{j}$ for $j \in I-\left\{i_{1}\right\}$,
$\mathrm{C}_{2} a_{i_{2}}+b_{i_{2}}<p_{i_{2}}$ and $a_{j}+b_{j} \geq p_{j}$ for $j \in I-\left\{i_{2}\right\}$,
$\mathbf{C}_{3} a_{i_{3}}+b_{i_{3}}<p_{i_{3}}$ and $a_{j}+b_{j} \geq p_{j}$ for $j \in I-\left\{i_{3}\right\}$,
D $a_{i}+b_{i} \geq p_{i}$ for all $i \in I$.
In the following lemma we proof that it is sufficient to study the cases $\mathbf{A}$ or $\mathbf{B}_{3}$.
Lemma 5.6. Each extension module can be obtained as a cokernel of the map $f_{\vec{y}}^{b_{i_{1}}, b_{i_{2}}, b_{i_{3}}}$ in the case $\boldsymbol{A}$ or $\overline{\boldsymbol{B}_{3}}$.
Proof. We proof that the cokernels in the cases $\mathbf{B}_{1}, \mathbf{B}_{2}$ and $\mathbf{D}$ are isomorphic to cokernels of the case $\mathbf{B}_{3}$. Moreover the cokernels in the cases $, \mathbf{C}_{1}, \mathbf{C}_{2}$ and $\mathbf{C}_{3}$ are isomorphic to cokernels of the case $\mathbf{A}$.

Let $E$ be an extension module in the case $\mathbf{B}_{2}$, thus $E$ is the cokernel of a map

From Lemma 5.2, applied to $i_{1}$, we infer that $E$ is an extension bundle $E_{L}\langle\vec{x}\rangle$ with data $(L, \vec{x})$ such that

\vec{x} & =\vec{\omega}+b_{i_{1}} \vec{x}_{1}+b_{i_{2}} \vec{x}_{i_{2}}-b_{i_{3}} \vec{x}_{i_{3}}
\end{aligned}
$$

Consider the map

d_{i_{1}}=b_{i_{1}}, \quad d_{i_{2}}=p_{i_{2}}-b_{i_{2}}, \quad d_{i_{3}}=p_{i_{3}}-b_{i_{3}}
$$

and

\begin{aligned}
\vec{z} & =\vec{y}+b_{i_{2}} \vec{x}_{i_{2}}+b_{i_{3}} \vec{x}_{i_{3}}-\vec{c}= \\
& =n \vec{c}+\left(a_{i_{2}}+b_{i_{2}}-p_{i_{2}}\right) \vec{x}_{i_{2}}+\left(a_{i_{3}}+b_{i_{3}}\right) \vec{x}_{i_{3}}+\sum_{j \neq i_{2}, i_{3}} a_{j} \vec{x}_{j} .
\end{aligned}

Then from Lemma 5.2, applied to $i_{2}$, we conclude that the cokernel of the map $f_{\vec{z}}^{d_{i_{1}}, d_{i_{3}}, d_{i_{3}}}$ is an extension bundle with data $(\widehat{L}, \widehat{\vec{x}})$, such that

& =\vec{\omega}+b_{i_{1}} \vec{x}_{i_{1}}+b_{i_{2}} \vec{x}_{i_{2}}-b_{i_{3}} \vec{x}_{i_{3}} .
\end{aligned}

Therefore, the cokernels of the maps $f_{\vec{y}}^{b_{i_{1}}, b_{i_{3}}, b_{i_{3}}}$ and $f_{\vec{z}}^{d_{i_{1}}, d_{i_{3}}, d_{i_{3}}}$ are isomorphic. Furthermore we have that

hence $E$ is isomorphic to an extension module in the case of $\mathbf{B}_{3}$.
For the other cases, we use the same kind of arguments. We only put in a table the choice of $d_{i_{1}}, d_{i_{2}}, d_{i_{3}}$ and $\vec{z}$. For simplicity, in the case $a_{i}+b_{i} \geq p_{i}$, we denote $a_{i}+b_{i}-p_{i}$ by $c_{i}$.

5.1. The cokernel construction. We consider an exact sequence of $\Lambda$-modules

$$

by vector spaces and matrices and also the morphism $f=\left(f_{\vec{x}}\right)_{\vec{x} \in Q_{0}}$ are known. Here $Q_{0}$ and $Q_{1}$ denote the set of vertices and arrows of the quiver of the canonical algebra, respectively.

We will construct a representation $\left(\left\{N_{\vec{x}}\right\}_{\vec{x} \in Q_{0}},\left\{N_{\alpha}\right\}_{\alpha \in Q_{1}}\right)$ for $N$. The vector space $N_{\vec{x}}$ is the cokernel of the linear map $f_{\vec{x}}$, and $g_{\vec{x}}$ the reduction modulo $\operatorname{Im} f_{\vec{x}}$. Let $v_{1}, \ldots, v_{m}$ be a basis of $M_{\vec{x}}$ and let $\operatorname{dim}_{k} \operatorname{Im} f_{\vec{x}}=l$. We have that $M_{\vec{x}}=$ $\operatorname{Im} f_{\vec{x}} \oplus k v_{1} \oplus \cdots \oplus k v_{m-l}$ and that the set $v_{1}+\operatorname{Im} f_{\vec{x}}, \ldots, v_{m-l}+\operatorname{Im} f_{\vec{x}}$ is a basis of the linear space $N_{\vec{x}}=M_{\vec{x}} / \operatorname{Im} f_{\vec{x}}$. Moreover, for $j \in\{1, \ldots, l\}$, we have $v_{m-l+j}=$ $f_{\vec{x}}\left(w_{j}\right)+a_{1, j} v_{1}+\cdots+a_{m-l, j} v_{m-l}$ for some $a_{i, j} \in k$ i $w_{j} \in L_{\vec{x}}$. Then

| :--- | :--- |, $\begin{aligned} & \text { where } A=\left[a_{i, j}\right] \in M_{m-l, l}(k) .\end{aligned}$

Next we will determine the maps $N_{\alpha}$ for $\alpha \in Q_{1}$. Let $\alpha: \vec{x} \longrightarrow \vec{y}$ be an arrow of the quiver of the algebra $\Lambda$. Then the following diagram

can be uniquely completed to a commutative diagram by the map $N_{\alpha}: N_{\vec{y}} \rightarrow N_{\vec{x}}$, $v+\operatorname{Im} f_{\vec{y}} \longmapsto M_{\alpha}(v)+\operatorname{Im} f_{\vec{x}}$.

It is easily checked that the maps $N_{\alpha}$ satisfy the canonical relations.
5.2. Construction of modules of type A. Let $I \subset\{1,2, \ldots, t\}$ with $\# I=3$, and let $\underline{b}=\left(b_{i}\right)_{i \in I}$ with $1 \leq b_{i} \leq p_{i}-1$. For $I$ and $\underline{b}$ we consider an exact sequence of vector bundles

0 \longrightarrow L \stackrel{\left[x_{i}^{b_{i}}\right]_{i \in I}}{\longrightarrow} \bigoplus_{i \in I} L\left(b_{i} \vec{x}_{i}\right) \xrightarrow{g} \operatorname{coker}\left[x_{i}^{b_{i}}\right]_{i \in I}=: E \longrightarrow 0
$$

where $L$ is a line bundl, with $\operatorname{det} L=n \vec{c}+\sum_{i \in I} a_{i} \vec{x}_{i} \geq 0$ and $a_{i}+b_{i}<p_{i}$ for $i \in I$.
We denote by $I_{n}$ the identity matrix of size $n$ and by $X_{n+m \times n}, Y_{n+m \times n}, Z_{n}(\lambda)$ the following matrices

The $\Lambda$-module attached to the line bundle $L$ has the following shape:

where $\mathbb{1}$ is the identity map (see [13, Proposition 3.4]). If $a_{i}=0$ for some $i \geq 3$, then $L_{\alpha_{1}^{(i)}}=L_{\alpha_{a_{i}+1}^{(i)}}=Z_{n+1}\left(\lambda_{i}\right) \cdot X_{n+1 \times n}$.

The modules $L\left(b_{i} \vec{x}_{i}\right)$ for $i \in I$ have a similar shape, with the difference that in the $i-$ th arm, the jump of dimension is realized for the arrow $\alpha_{a_{i}+b_{i}+1}^{(i)}$.

First we compute matrices of maps $x_{i}^{b_{i}}: L \longrightarrow L\left(b_{i} \vec{x}_{i}\right)$ for each $i \in I$. The map $x_{i}^{b_{i}}$ has the following matrices:

for some $\mu_{i} \in k$, where $i \neq 2$ and $j \neq i$. Here the captions above the frames mean the vertices of the quiver and the matrices in the frames the matrives for them. Moreover, in the case $i=2$ we need to switch from $X_{n+1 \times n}$ to $Y_{n+1 \times n}$. Therefore the map $\left[x_{i}^{b_{i}}\right]_{i \in I}$ depends on the three scalars $\mu_{i_{1}}, \mu_{i_{2}}$ and $\mu_{i_{3}}$. From Lemma 5.1 (iii), we can put $\mu_{i_{1}}=1=\mu_{i_{2}}$ and $\mu_{i_{3}}=-1$.

The second step is the computation of the map $g: \bigoplus_{i \in I} L\left(b_{i} \vec{x}_{i}\right) \longrightarrow E$. For this purpose we will use the following lemma from linear algebra, where for simplicity, we will use notation $B_{b \times a}$ for a matrix $B \in M_{b \times a}(k)$.
Lemma 5.7. Let $0 \longrightarrow V \xrightarrow{f} W \xrightarrow{-} \operatorname{coker}(f) \longrightarrow 0$ be an exact sequence of linear maps, where $\operatorname{dim} V=a$, $\operatorname{dim} W=a+b+c$ and ${ }^{-}$is the reduction modulo $\operatorname{Im}(f)$.

Proof. (i) Let $v_{1}, \ldots, v_{a}$ be a basis of $V$, and let $w_{1}^{1}, \ldots, w_{b}^{1}, w_{1}^{2}, \ldots, w_{c}^{2}, w_{1}^{3}, \ldots$, $w_{a}^{3}$ be a basis of $W$. Furthermore, we choose $\overline{w_{1}^{1}}, \ldots, \overline{w_{b}^{1}}, \overline{w_{1}^{2}}, \ldots, \overline{w_{c}^{2}}$ as a basis of $\operatorname{coker}(f)$. Then the equalities

$$
\overline{w_{i}^{3}}=\overline{w_{i}^{3}+f\left(w_{i}^{3}\right)}=\overline{B w_{i}^{3}+C w_{i}^{3}}, \quad \text { for } \quad i=1,2, \ldots, a
$$

implies the claim.
(ii) We choose $v_{1}, \ldots, v_{a}$ as a basis of $V$, and $w_{1}^{1}, \ldots, w_{a}^{1}, w_{1}^{2}, \ldots, w_{b}^{2}, w_{1}^{3}, \ldots$, $w_{c}^{3}$ as a basis of $W$. Further, we choose $\overline{w_{1}^{2}}, \ldots, \overline{w_{b}^{2}}, \overline{w_{1}^{3}}, \ldots, \overline{w_{c}^{3}}$ as a basis of coker $(f)$. Then

$$
\overline{w_{i}^{1}}=\overline{w_{i}^{1}-f\left(w_{i}^{1}\right)}=\overline{-B w_{i}^{1}+C w_{i}^{1}}, \quad \text { for } \quad i=1,2, \ldots, a
$$

so the claim holds.

By using the lemma above we obtain a matrix representation of the map $g=$ $\left(g_{\vec{x}}\right): \bigoplus_{i \in I} L\left(b_{i} \vec{x}_{i}\right) \longrightarrow E$. Recall that $I=\left\{i_{1}, i_{2}, i_{3}\right\}$ is given in ascending order. Then

to a commutative diagram, for each arrow $\alpha: \vec{x} \longrightarrow \vec{y}$. Since the maps $G_{\alpha}$ are monomorphism, each of these squares can be complete only in one way. If for some arrow $\alpha: \vec{x} \longrightarrow \vec{y}$, the maps $L\left(b_{i} \vec{x}_{i}\right)_{\alpha}$ are identities for each $i \in I$ and $g_{\vec{x}}=g_{\vec{y}}$, then $E_{\alpha}$ is the identity map. Therefore we need only to determine matrices for the
following arrows:

Moreover, if $a_{i}=0$, then the arrow $\alpha_{1}^{(i)}$ coincides with the arrow $\alpha_{a_{i}+1}^{(i)}$, and in this case in the place of $\alpha_{1}^{(i)}$ we put the composition of the above matrices $E_{\alpha_{1}^{(i)}}$ and $E_{\alpha_{a_{i}+1}^{(i)}}$.
5.3. The modules of the type $\mathbf{B}_{3}$. This case is similar to the previous computation. We will point out the differences using the same notations as before. In the case of type $B_{3}$ we assume that

a_{i_{3}}+b_{i_{3}} \geq p_{i_{3}} \quad \text { and } \quad a_{i}+b_{i}<p_{i} \quad \text { for } \quad i=i_{1}, i_{2} .

Let $c_{i_{3}}:=a_{i_{3}}+b_{i_{3}}-p_{i_{3}}$, then $0 \leq c_{i_{3}}<a_{i_{3}}$.

The maps $x_{i}^{b_{i}}: \mathcal{O}(\vec{y}) \longrightarrow \mathcal{O}\left(\vec{y}+b_{i} \vec{x}_{i}\right)$ for $i=i_{1}$ or $i=i_{2}$ are the same as before. The map $x_{i_{3}}^{b_{i_{3}}}: \mathcal{O}(\vec{y}) \longrightarrow \mathcal{O}\left(\vec{y}+b_{i_{3}} \vec{x}_{i_{3}}\right)$ has the form $\mu_{i_{3}} \cdot\left(h_{\vec{x}}\right)_{0 \leq \vec{x} \leq c}$, where for $j \neq i_{3}$ we have

In the case of the second arm we need to switch from the matrices $X_{* \times * *}$ to $Y_{* \times *}$. Moreover, if $a_{i}=0$, then the arrow $\alpha_{1}^{(i)}$ coincide with the arrow $\alpha_{a_{i}+1}^{(i)}$, in this case in the place of $\alpha_{1}^{(i)}$ we put composition of matrices $E_{\alpha_{1}^{(i)}}$ and $E_{\alpha_{a_{i}+1}^{(i)}}$.

## 6. Exceptional modules of the higher rank

In this paper we have focused on the case of $\Lambda$-modules of rank two. We remark that the presented construction of them by cokernels can be applied also for exceptional modules of higher rank. For this we have to consider exact sequences of the form

$$
0 \longrightarrow L \xrightarrow{f} \oplus_{j \in J} L\left(b_{i} \vec{x}_{i}\right) \longrightarrow E \longrightarrow 0,
$$

for $J \subset\{1,2, \ldots, t\}$. In this case the cokernel $E$ is exceptional of rank $|J|-1$. Therefore here we obtain exceptional modules of rank from 2, to $t-1$. It is an open question whether in this way we get all exceptional modules of rank $r$, for $3 \leq r \leq t$.
