EQUIVALENT VERSION OF HUPPERT'S CONJECTURE FOR K_3 -GROUPS

ABSTRACT. For a character χ of a finite group G the number $\operatorname{cod}(\chi) = |G : \operatorname{Ker}(\chi)|/\chi(1)$ is called the codegree of χ . In this note, we verify the equivalent version of Huppert's conjecture for K_3 -groups.

1. INTRODUCTION

Throughout this paper, G will be a finite group and cd(G) will be the set of the degrees of the complex irreducible characters of G. The number $cod(\chi) = |G : ker(\chi)|/\chi(1)$ is called the codegree of χ . Also the set of codegrees of the irreducible characters of Gis denoted by cod(G). This definition for codegrees first appeared in [16], where the authors use a graph-theoretic approach to compare the structure of a group with its set of codegrees. In [4, 5, 6, 17] some properties of the codegrees of irreducible characters of finite groups have been studied.

In 1990, Huppert proposed the following conjecture:

Huppert's Conjecture. Let *H* be any finite non-abelian simple group and *G* a finite group such that cd(G) = cd(H). Then, $G \cong H \times A$, where *A* is abelian.

Many people were devoted to the study of this problem. An analogues of Huppert's conjecture can be proposed and studied for any set of integers related to a finite group. For instance, a dual version of Huppert's conjecture for the set of conjugacy class sizes is considered. For more results see [1, 2, 3]. In this paper, we are concerned with the following conjecture, inspired by Huppert's conjecture:

Conjucture: Let G be a finite group and H a non-abelian simple group. If cod(G) = cod(H), then $G \cong H$.

This conjecture first proposed in [7], where the authors verified the above conjecture for all projective special linear groups of degree 2. In this article by using the same method in [7], we verify this conjecture for K_3 -groups. Also we recall that Huppert's conjecture is true for K_3 -groups (see [12]).

We refer to [13] for the notation of character theory of finite groups. If $L \leq G$ and $\theta \in \operatorname{Irr}(L)$, then we write $\operatorname{Irr}(G \mid \theta) = \{\chi \in \operatorname{Irr}(G) \mid [\chi_L, \theta] \neq 0\}$. Moreover, $\operatorname{Irr}(G \mid L) = \operatorname{Irr}(G) - \operatorname{Irr}(G/L)$.

2. Preliminaries

In this section we give some results which will be used later in our proofs.

Proposition 2.1. [15, Lemma 2] Let S be a non-abelian finite simple group. Then there exists $1_s \neq \theta \in \text{Irr}(S)$ that extends to Aut(S).

Proposition 2.2. [8, Lemma 5] Let N be a minimal normal subgroup of G such that $N = S_1 \times S_2 \times \cdots \times S_t$, where $S_i \cong S$ is a non-abelian simple group. If $\theta \in \operatorname{Irr}(S)$ extends to Aut(S) then $\theta \times \theta \times \cdots \times \theta \in \operatorname{Irr}(N)$ extends to G.

Proposition 2.3. [15, Theorem C] Let G be a nonabelian finite simple group. Then either $|cd(G)| \ge 8$ or one of the following cases holds.

(i): |cd(G)| = 4 and $G = PSL(2, 2^{f})$, where $f \ge 2$. (ii): |cd(G)| = 5 and G = PSL(2, q), where $q = p^{f}$, $p \ne 2$ and $p^{f} > 5$. (iii): |cd(G)| = 6 and G = PSL(3, 4) or $G/N = {}^{2}B_{2}(2^{2f+1})$, where $f \ge 1$. (iv): |cd(G)| = 7 and G = PSL(3, 3), A_{7} , M_{11} or J_{1} .

Remark. By [10] we see that $cod(U_3(3)) = \{1, 2^4.3^2.7, 2^5.3^3, 2^4.3^3, 2^5.3^2, 2^5.7, 2^3.3^3, 3^3.7\}.$ Also $cod(U_4(2)) = \{1, 2^6.3^4, 2^5.3^3.5, 2^5.3^4, 2^6.3^3, 2^4.3^4, 2^3.3^3.5, 2^5.3^3, 2^3.3^4, 2^6.3^2, 2^4.3^3, 3^4.5, 2^6.5\}.$

By [16, Lemma 2.1] we have the following result.

Proposition 2.4. Let $\chi \in Irr(G)$.

- (i) For any N ≤G with N ≤ ker(χ), χ may be viewed as an irreducible character of G/N. The codegree cod(χ) of χ is the same whenever χ is seen as an irreducible character of G or G/N. Furthermore, cod(χ) is independent of the choice of such N.
- (ii) If M is a subnormal subgroup of G and φ is an irreducible constituent of χ_M , then $\operatorname{cod}(\varphi)$ divides $\operatorname{cod}(\chi)$.

3. MAIN RESULTS

We recall that if G is a finite simple K_3 -group, then G is isomorphic to one of the following groups:

$A_5, A_6, L_2(7), L_2(8), L_2(17), L_3(3), U_3(3), U_4(2).$

Also by [7], we see that the conjecture is true for $A_5, A_6, L_2(7), L_2(8), L_2(17), L_3(3)$. Thus in this section we just verify the conjecture for $U_3(3)$ and $U_4(2)$.

Theorem 3.1. Suppose that G is a group and $cod(G) = cod(U_3(3))$. If N is a maximal normal subgroup of G then $G/N \cong U_3(3)$.

Proof. By our assumption G/N is a simple group. If G/N is abelian then $G' \leq N$ and so $G \neq G'$. Now by Proposition 2.4, $\operatorname{cod}(G/G') \subseteq \operatorname{cod}(G)$ and so $\operatorname{cod}(G)$ contains a prime power, a contradiction. Thus we may suppose that G/N is nonabelian simple group. If $|\operatorname{cd}(G/N)| \geq 8$ then by $\operatorname{cod}(G/N) \subseteq \operatorname{cod}(G)$ and $\operatorname{cod}(G) = \operatorname{cod}(U_3(3))$ we see that $|\operatorname{cod}(G/N)| = |\operatorname{cod}(U_3(3))| = 8$. Thus $|\operatorname{cd}(G/N)| = |\operatorname{cd}(U_3(3))|$ and by Huppert's conjecture $G/N \cong U_3(3)$. Thus we may suppose that $|\operatorname{cd}(G/N)| < 8$ and we find contradiction. Now by Proposition 2.3, we considering the following cases.

Case 1. |cd(G/N)| = 4 and $G/N \cong PSL(2, 2^{f})$, where $f \ge 2$.

By [19], we know that $\operatorname{cod}(\operatorname{PSL}(2,2^{\mathrm{f}})) = \{1, q(q-1), q(q+1), q^2+1\}$, where $q = 2^{f}$ and $\operatorname{cod}(U_3(3)) = \{1, 2^4.3^2.7, 2^5.3^3, 2^4.3^3, 2^5.3^2, 2^5.7, 2^3.3^3, 3^3.7\}$. It is easy to see that $\operatorname{cod}(\operatorname{PSL}(2,2^{\mathrm{f}})) \not\subseteq \operatorname{cod}(U_3(3))$, a contradiction.

Case 2. $|\operatorname{cd}(G/N)| = 5$ and $G/N \cong \operatorname{PSL}(2,q)$, where $q = p^f$, $p \neq 2$ and q > 5. By [19], we know that $\operatorname{cod}(\operatorname{PSL}(2,q)) = \{1, q(q-1)/2, q(q+1)/2, (q^2-1)/2, q(q-\epsilon(q))\}$, where $\epsilon(q) = (-1)^{(q-1)/2}$. It is easy to see that $\operatorname{cod}(\operatorname{PSL}(2,p^f)) \not\subseteq \operatorname{cod}(U_3(3))$, a contradiction.

Case 3. |cd(G/N)| = 6 and G/N = PSL(3, 4) or $G/N = {}^{2}B_{2}(2^{2f+1})$, where $f \ge 1$. First suppose that G/N = PSL(3, 4). We know that $cd(PSL(3, 4)) = \{1, 20, 35, 45, 63, 64\}$ and so $cod(PSL(3, 4)) = \{1, 2^{4}.3^{2}.7, 2^{6}.3^{2}, 2^{6}.7, 2^{6}.5, 3^{2}.5.7\}$. Now $2^{6}.5 \in cod(PSL(3, 4))$ and so $2^{6}.5 \notin cod(U_{3}(3))$, a contradiction. Thus we may suppose $G/N = {}^{2}B_{2}(2^{2f+1})$, where $q^{2} = 2^{2f+1}$, $r = 2^{f+1}$ and $f \ge 1$. We know that $cd({}^{2}B_{2}(2^{2f+1})) = \{1, q^{4}, q^{4} + 1, (q^{2} - r + 1)(q^{2} - 1), (q^{2} + r + 1)(q^{2} - 1), r(q^{2} - 1)/2\}$ and so $cod({}^{2}B_{2}(2^{2f+1})) = \{1, (q^{4} + 1)(q^{2} - 1), q^{4}(q^{2} - 1), \frac{q^{4}(q^{4}+1)}{q^{2} + r + 1}, \frac{q^{4}(q^{4}+1)}{q^{2} + r + 1}\}$. Now with the simple check we can see that $cod({}^{2}B_{2}(2^{2f+1})) \notin cod(U_{3}(3))$, a contradiction. **Case 4.** |cd(G/N)| = 7 and $G/N = PSL(3, 3), A_{7}, M_{11}$ or J_{1} . We know that $cd(PSL(3, 3)) = \{1, 12, 13, 16, 26, 27, 39\}$ and so $cod(PSL(3, 3)) = \{1, 2^{2}.3^{2}.13, 2^{4}.3^{3}, 3^{3}.13, 2^{3}.3^{3}.2^{4}.13, 2^{4}.3^{2}\}$. Now it is easy to see that $cod(PSL(3, 3)) \notin cod(U_{3}(3))$. Also if $G/N \cong A_{7}$ then $cd(A_{7}) = \{1, 6, 10, 14, 15, 21, 35\}$ and so $cod(A_{7}) = \{1, 2^{2}.3.5.7, 2^{2}.3^{2}.7, 2^{2}.3^{2}.5.2^{3}.3.7, 2^{3}.3.5, 2^{3}.3^{2}\}$. Again we see that $cod(A_{7}) \notin cod(U_{3}(3))$. If $G/N \cong M_{11}$ then $cd(M_{11}) = \{1, 10, 11, 16, 44, 45, 55\}$. If $\chi(1) = 16$ then $cod(\chi(1)) = 3^{2}.5.11$ and so $3^{2}.5.11 \in cod(U_{3}(3))$, a contradiction. Fially if $G/N \cong J_{1}$ then $cd(J_{1}) = \{1, 56, 76, 77, 120, 133, 209\}$. If $\chi(1) = 56$ then $cod(\chi(1)) = 3.5.11.19$ and so $3.5.11.19 \in cod(U_{3}(3))$, a contradiction.

Lemma 3.2. Suppose that G is a simple group which is isomorphic to alternating group A_n $(n \ge 5)$ or sporadic group. Then $4 \le |cod(G)| \le 12$ if and oly if G is isomorphic to one of the following groups.

$$A_5, A_6, A_7, A_8, M_{11}, M_{12}, M_{22}, M_{23}, J_1.$$

Proof. We use the classification of finite simple groups. For the sporadic groups by [10], with the simple check we see that G is isomorphic to M_{11} or M_{12} or M_{22} or M_{23} or J_1 . For A_n where $5 \leq n \leq 13$, by [10] we see that $G \cong A_5$ or A_6 or A_7 or A_8 . Thus we may assume that $n \geq 14$. Now the characters corresponding to the non-self-associated partitions (n - 1, 1), (n - 2, 2), (n - 2, 1, 1), (n - 3, 3), (n - 3, 2, 1), (n - 3, 1, 1, 1), (n - 4, 4), (n - 4, 3, 1), (n - 4, 2, 2), (n - 4, 1, 1, 1, 1), (n - 5, 5), (n - 5, 4, 1), (n - 5, 3, 2) have distinct degrees n - 1, $\frac{n(n-3)}{2}$, $\frac{(n-1)(n-2)}{2}$,

$$\frac{n(n-1)(n-5)}{6}, \frac{n(n-2)(n-4)}{3}, \frac{(n-1)(n-2)(n-3)}{6}, \frac{n(n-1)(n-2)(n-3)}{24}, \frac{n(n-1)(n-2)(n-7)}{24}, \frac{n(n-1)(n-3)(n-6)}{8}, \frac{n(n-1)(n-4)(n-5)}{12}, \frac{n(n-1)(n-4)(n-5)}{24}, \frac{n(n-1)(n-2)(n-7)}{24}, \frac{n(n-1)(n-2)(n-7)}{24}.$$

Theorem 3.3. Suppose that G is a group and $cod(G) = cod(U_4(2))$. If N is a maximal normal subgroup of G then $G/N \cong U_4(2)$.

Proof. By our assumption G/N is a nonabelian simple group and so $|cd(G/N)| \ge 4$. We know that $cod(G/N) \subseteq cod(G)$ and $cod(G) = cod(U_4(2))$ and so $4 \le |cod(G/N)| \le 13$. if |cod(G/N)| = 13 then $|cd(G/N)| = |cd(U_4(2))|$ and by Huppert's conjecture $G/N \cong U_4(2)$. Thus we may suppose that $4 \le |cd(G/N)| \le 12$.

If G/N is alternating group A_n or sporadic group then by Lemma 3.2 G/N is isomorphic to A_5 or A_6 or A_7 or A_8 or M_{11} or M_{12} or M_{22} or M_{23} or J_1 . By [10] we see $\operatorname{cod}(G/N) \not\subseteq \operatorname{cod}(U_4(2))$, a contradiction. In what follows, we assume that G/N is a simple group of Lie type.

Exceptional groups of Lie type. Let G/N be one of the groups ${}^{3}D_{4}(q)$, $G_{2}(q)$, $F_{4}(q)$, ${}^{2}B_{2}(q^{2})(q^{2} = 2^{2f+1})$, $E_{6}(q)$, ${}^{2}E_{6}(q)$, $E_{7}(q)$, $E_{8}(q)$, ${}^{2}G_{2}(q)(q = 3^{2f+1})$ and ${}^{2}F_{4}(q)(q = 2^{2f+1})$. According to [9, Section 13.9], we see that $|cod(G/N)| \ge 14$, where G/N is isomorphic to $F_{4}(q)$, $E_{6}(q)$, ${}^{2}E_{6}(q)$, $E_{7}(q)$, $E_{8}(q)$ or ${}^{2}F_{4}(q)$. Thus we may suppose that G/N is isomorphic to ${}^{3}D_{4}(q)$, $G_{2}(q)$, ${}^{2}B_{2}(q^{2})$ or ${}^{2}G_{2}(q)$.

Also by [11] We see that $|\operatorname{cod}(G/N)| \geq 14$, where G/N is isomorphic to ${}^{3}D_{4}(q)$. If $G/N = {}^{2}B_{2}(2^{2f+1}), f \geq 1$, where $q^{2} = 2^{2f+1}$, and $f \geq 1$, then $|\operatorname{cd}(G/N)| = 6$. Now with the simple check we can see that $\operatorname{cod}({}^{2}B_{2}(2^{2f+1})) \not\subseteq \operatorname{cod}(U_{4}(2))$, a contradiction. Also if G/N is isomorphic to $G_{2}(q)$ then by [9, Section 13.9] we see that $\operatorname{cod}(\phi) = \frac{6q^{5}(q^{4}+q^{2}+1)(q-1)^{2}}{q^{2}+q+1}$. Now we see that $\operatorname{cod}(\phi) \notin \operatorname{cod}(U_{4}(2))$, a contradiction. Finally if G is isomorphic to ${}^{2}G_{2}(q)$, then by [18] we see that $\operatorname{cod}(\delta) = q^{3}(q+1)$. No we see that $\operatorname{cod}(\delta) \notin \operatorname{cod}(U_{4}(2))$, a contradiction.

Type A_n : Linear groups. Therefore $G/N \cong L_{n+1}(q)$, where q is a prime power of p and $n \ge 1$. If n = 1 then $G/N \cong L_2(q)$. If $q = 2^f$ where $f \ge 2$ then it is easy to see that $\operatorname{cod}(\operatorname{PSL}(2,q)) \not\subseteq \operatorname{cod}(U_4(2))$. If $q = p^f$, where $p \ne 2$ and q > 5, then again it is easy to see that $\operatorname{cod}(\operatorname{PSL}(2,q)) \not\subseteq \operatorname{cod}(U_4(2))$, a contradiction. Thus we may suppose $n \ge 2$, then G/N has a character of degree $\frac{q(q^n-1)}{q-1}$, say χ . Now $\operatorname{cod}(\chi) = q^{\frac{n^2+n-2}{2}} \prod_{i=1}^n \frac{(q^{i+1}-1)(q-1)}{(n+1,q-1)(q^n-1)}$ and $\operatorname{cod}(\chi) \notin \operatorname{cod}(U_4(2))$, a contradiction.

Type ²A_n: Unitary groups. Therefore $G/N \cong U_{n+1}(q)$, where $n \ge 2$. Now by [14], G/N has a character of degree $\frac{q(q^n-(-1)^n)}{q+1}$, say χ . Now $\operatorname{cod}(\chi) = q^{\frac{n^2+n-2}{2}} \prod_{i=1}^n \frac{(q^{i+1}-(-1)^{i+1})(q+1)}{(n+1,q+1)(q^n-(-1)^n)}$ and $\operatorname{cod}(\chi) \notin \operatorname{cod}(U_4(2))$, a contradiction.

Type ° ° ° B_n or C_n : Odd dimensional orthogonal groups and Symplectic groups. Therefore $G/N \cong S_{2n}(q)$ or $O_{2n+1}(q)$, where $n \ge 2$. If n = 2 then by [9, Section 13.8], G/N has a unipotent character of $\frac{q(q+1)^2}{2}$, say χ . Now $\operatorname{cod}(\chi) = \frac{2q^3(q-1)^2(q^2+1)}{(2,q-1)}$ and $\operatorname{cod}(\chi) \notin \operatorname{cod}(U_4(2))$, where $q \ne 3$, a contradiction. If q = 3 then $G/N \cong U_4(2)$, as wanted. Also if n > 2 then by [9, Section 13.8] G/N has a steinberg character of degree

 q^{n^2} , say θ . Now $\operatorname{cod}(\theta) = \frac{\prod_{i=1}^n (q^{2i}-1)}{(2,q-1)}$ and $\operatorname{cod}(\chi) \notin \operatorname{cod}(U_4(2))$, a contradiction. Type D_n : Even dimensional orthogonal groups. Therefore $G/N \cong O_{2n}^+(q)$, where $n \ge 2$. If n = 2 then $G/N \cong \operatorname{L}_2(q) \times \operatorname{L}_2(q)$. Suppose that $q = 2^f$. Then $\operatorname{cod}(\theta) = q^2(q^2 - 1)$, where $f \ge 2$ and $\theta \in \operatorname{Irr}(\operatorname{L}_2(q) \times \operatorname{L}_2(q))$. Now suppose that $q = p^f$, where $p \ne 2$ and $p^f > 5$. Then $\operatorname{cod}(\theta) = \frac{q^2(q^2-1)}{4}$, where $\theta \in \operatorname{Irr}(\operatorname{L}_2(q) \times \operatorname{L}_2(q))$. In each case we see that $\operatorname{cod}(\theta) \notin \operatorname{cod}(U_4(2))$, a contradiction.

Also if n = 3 then $G/N \cong L_4(q)$ which is isomorphic to type A_3 . Thus we may suppose that $n \ge 4$. Now by [14], G/N has an irreducible character of degree $\frac{q(q^{n-2}+1)(q^n-1)}{q^{2}-1}$, say ϕ . Now $\operatorname{cod}(\phi) = \frac{q^{n^2-n-1}\prod_{i=1}^{n-1}(q^{2i}-1)(q^{2}-1)}{(4,q^n-1)(q^{n-2}+1)}$ and $\operatorname{cod}(\phi) \notin \operatorname{cod}(U_4(2))$, a contradiction. *Type* 2D_n : Even dimensional orthogonal groups. Therefore $G/N \cong O_{2n}^-(q)$, where $n \ge 2$. If n = 2 then $G/N \cong L_2(q^2)$ which is isomorphic to type A_1 . Also if n = 3 then $G/N \cong U_4(q)$ which is isomorphic to type 2A_3 . Thus we may suppose that $n \ge 4$. Now by [14], G/N has an irreducible character of degree $\frac{q(q^{n-2}-1)(q^n+1)}{q^{2}-1}$, say σ . Now $\operatorname{cod}(\sigma) = \frac{q^{n^2-n-1}\prod_{i=1}^{n-1}(q^{2i}-1)(q^2-1)}{(4,q^n+1)(q^{n-2}-1)}$ and $\operatorname{cod}(\sigma) \notin \operatorname{cod}(U_4(2))$, a contradiction.

Theorem 3.4. Suppose that G is a finite group and $cod(G) = cod(U_3(3))$ or $cod(G) = cod(U_4(2))$. Then $G \cong U_3(3)$ or $G \cong U_4(2)$.

Proof. Suppose that N is the maximal normal subgroup of G. By Theorem 3.1 and Theorem 3.3, $G/N \cong U_3(3)$ or $G/N \cong U_4(2)$. We show that N = 1. Suppose to the contrary that G is a counterexample with minimal order. Thus there is no groups with order less than G, say H, such that has a maximal normal subgroup, say M, such that $H/M \cong U_3(3)$ or $U_4(2)$ and $M \neq 1$. Assume that $H \trianglelefteq G$, where $H \neq 1$ and H < N. Now $G/N \cong (G/H)/(N/H)$ and so $\operatorname{cod}(G/N) \subseteq \operatorname{cod}(G/H) \subseteq \operatorname{cod}(G)$. Thus cod(G/H) = cod(G) and so by minimality of G we get a contradiction. Thus N is also a minimal normal subgroup of G. If N is not abelian then $N \cong T \times T \times \cdots T = T^n$, where T is a non-abelian simple group. By Propositions 2.1, 2.2, there exits $1_N \neq \phi \in$ $\operatorname{Irr}(N)$ which extends to some irreducible character of G, say θ . We have $\ker(\theta) N \triangleleft G$ and by the maximality of N we have that either $\ker(\theta)N = N$ or $\ker(\theta)N = G$. If $\ker(\theta)N = N$ then $\ker(\theta) \subseteq N$. Since N is a minimal normal subgroup we have either ker(θ) = 1 or ker(θ) = N. We know that $\theta_N \neq 1$ and so we ker(θ) = 1 or $G = \ker(\theta) \times N$. If $\ker(\theta) = 1$ then $\operatorname{cod}(\theta) = |G|/\theta(1)$. Since $\theta(1) \mid |N|$, it implies that $|N| = m\theta(1)$ for some positive integer m. Thus $|G|/|N| = |G|/m\theta(1)$ and so $m|G|/|N| = |G|/\theta(1)$. Therefore $|G|/|N| + |G|/\theta(1) = cod(\theta)$. We know that $\operatorname{cod}(\theta) \in \operatorname{cod}(G)$ and $\operatorname{cod}(G) = \operatorname{cod}(U_3(3))$ or $\operatorname{cod}(G) = \operatorname{cod}(U_4(2))$. We know that $|G/N| = |U_3(3)| = 2^5 \cdot 3^3 \cdot 7$ and $|G/N| = |U_4(2)| = 2^6 \cdot 3^4 \cdot 5$. Now we get contradition easily. Thus we may suppose that $G = \ker(\theta) \times N$. Since N is the minimal normal subgroup of G, it follows that ker(θ) is the maximal normal subgroup of G. Now by Theorem 3.1 and Theorem 3.3 we see that $G/\ker(\theta) \cong U_3(3)$ or $G/\ker(\theta) \cong U_4(2)$. Also we have $N \cong G/\ker(\theta)$. Therefore $N \cong \ker(\theta) \cong G/\ker(\theta)$. We know that

 $\operatorname{cod}(G/\ker(\theta)) \subseteq \operatorname{cod}(G)$ and $\theta \in \operatorname{Irr}(G/\ker(\theta))$. Now $\operatorname{cod}(\theta) = |G|/\theta(1) = |N|^2/\theta(1)$. Since $\theta(1) \mid |N|$ and $\operatorname{cod}(\theta) \in \operatorname{cod}(G)$ we have a contradiction. Thus N is an abelian group. We know that $N \leq C_G(N)$ and $C_G(N) \leq G$. Now since N is the maximal normal subgroup of G we conclude that $N = C_G(N)$ or $C_G(N) = G$. If $C_G(N) = G$ then $N \leq Z(G)$. On the other hand if G' < G then by $\operatorname{cod}(G/G') \subseteq \operatorname{cod}(G)$, where $G \cong U_3(3)$ or $U_4(2)$, we see that cod(G) contains a prime, a contradiction. Thus G is perfect and $N \cap G' = N$. Thus N < G' and so $N < Z(G) \cap G'$. Now since $G/N \cong U_3(3)$ or $U_4(2)$ we see that G is a central extension of $U_3(3)$ or $U_4(2)$. Also by [10], we know that $\operatorname{Mult}(U_3(3)) = 1$ and $\operatorname{Mult}(U_4(2)) \cong \mathbb{Z}_2$. Thus $G \cong U_3(3)$ or $G \cong U_4(2)$ or $G \cong 2.U_4(2)$. Also by [10], we know that $cd(2.U_4(2)) = \{1, 4, 20, 36, 60, 64, 80\}$ and we have a contradiction. Thus $G \cong U_3(3)$ or $G \cong U_4(2)$ and the assertion is hold. Therefore we may assume that $N = C_G(N)$. Now suppose that $\theta \in \operatorname{Irr}(G|N)$. We show that θ is faithful. If ker $(\theta) \neq 1$ then we know that $N \leq \ker(\theta) N \leq G$ and so by our assumption about N we see that either $N = \ker(\theta)N$ or $\ker(\theta)N = G$. First suppose that $\ker(\theta)N = G$. Now $\ker(\theta) \cap N \subseteq N$ and by our assumption about N we see that $\ker(\theta) \cap N = 1$ or $\ker(\theta) \cap N = N$. If $\ker(\theta) \cap N = N$ then $N \subseteq \ker(\theta) \subseteq G$, a contradiction. Thus ker(θ) $\cap N = 1$. Thus $G = \text{ker}(\theta) \times N$. Now by considering G = G' we get a contradiction. Therefore ker $(\theta) < N$ and so by the minimality of N we have $\ker(\theta) = N$, a contradiction. Thus θ is faithful for each $\theta \in \operatorname{Irr}(G|N)$ as asserted. Now we show that if $1_N \neq \lambda \in \operatorname{Irr}(N)$ then we have $|I_G(\lambda)|/\theta(1) \in \operatorname{cod}(G)$ for all $\theta \in \operatorname{Irr}(I_G(\lambda)|\lambda)$. By [13, Theorem 6.11], we see that $\theta^G \in \operatorname{Irr}(G)$ for all $\theta \in$ $\operatorname{Irr}(I_G(\lambda)|\lambda)$. If $N \leq \ker(\theta)$ then for each $n \in N$ we have $\theta(n) = \theta(1)$ and by [13, Theorem 6.2] we have $\theta_N(1) = et\theta(1)$ where $t = |G : I_G(\theta)|$ and e divides |G : H|. Now it is easy to see that for each $n \in N$ we have $\lambda(n) = \lambda(1)$, a contradiction. Thus we have $N \not\leq \ker(\theta)$ and $\theta \in \operatorname{Irr}(G|N)$. Now as we showed that we see that $\ker(\theta^G) = 1$. Thus we have $\operatorname{cod}(\theta^G) \in \operatorname{cod}(G)$, as desired. We have $\operatorname{cod}(G/N) = \operatorname{cod}(G)$ and $|I_G(\lambda)|/\theta(1) \in \operatorname{cod}(G)$. Therefore $|I_G(\lambda)||N|/|N|\theta(1) \in \operatorname{cod}(G)$. By [13, Theorem 6.15] we have $\theta(1) \mid |I_G(\lambda)/N|$. Thus |N| divides the codegree of some irreducible character of G/N, and so |N| | |G/N|.

We know that $C_G(N) = N$ and so $|G/N| | |\operatorname{Aut}(N)|$. Also we know that N is an elementary abelian r-group. If $G/N \cong U_3(3)$ then $r \in \{2, 3, 7\}$. Thus $|\operatorname{Aut}(N)|$ divides $|\operatorname{GL}(5,2)|$ or $|\operatorname{GL}(3,3)|$ or $|\mathbb{Z}_6|$. Now since |N| | |G/N| we have a contradiction. Also if $G \cong U_4(2)$ then $r \in \{2,3,5\}$. If $|N| | 2^5$ or $|N| | 3^3$ or |N| = 5 then $|\operatorname{Aut}(N)|$ divides $|\operatorname{GL}(5,2)|$ or $|\operatorname{GL}(3,3)|$ or $|\mathbb{Z}_4|$, a contradiction. Thus we may suppose that $|N| = 2^6$ or $|N| = 3^4$. If $|N| = 2^6$ then $\operatorname{Aut}(N) \cong \operatorname{GL}(6,2)$. Now it is easy to see that $\operatorname{cd}(U_4(2) \nsubseteq \operatorname{cd}(\operatorname{GL}(6,2)))$, a contradiction. Also if $|N| = 3^4$ then $\operatorname{Aut}(N) \cong \operatorname{GL}(4,3)$ and again $\operatorname{cd}(U_4(2)) \nsubseteq \operatorname{cd}(\operatorname{GL}(4,3))$, a contradiction.
