# EQUIVALENT VERSION OF HUPPERT'S CONJECTURE FOR $K_{3}$-GROUPS

#### Abstract

For a character $\chi$ of a finite group $G$ the number $\operatorname{cod}(\chi)=|G: \operatorname{Ker}(\chi)| / \chi(1)$ is called the codegree of $\chi$. In this note, we verify the equivalent version of Huppert's conjecture for $K_{3}$-groups.


## 1. Introduction

Throughout this paper, $G$ will be a finite group and $\operatorname{cd}(G)$ will be the set of the degrees of the complex irreducible characters of $G$. The number $\operatorname{cod}(\chi)=|G: \operatorname{ker}(\chi)| / \chi(1)$ is called the codegree of $\chi$. Also the set of codegrees of the irreducible characters of $G$ is denoted by $\operatorname{cod}(G)$. This definition for codegrees first appeared in [16], where the authors use a graph-theoretic approach to compare the structure of a group with its set of codegrees. In $[4,5,6,17]$ some properties of the codegrees of irreducible characters of finite groups have been studied.

In 1990, Huppert proposed the following conjecture:
Huppert's Conjecture. Let $H$ be any finite non-abelian simple group and $G$ a finite group such that $\operatorname{cd}(G)=\operatorname{cd}(H)$. Then, $G \cong H \times A$, where $A$ is abelian.

Many people were devoted to the study of this problem. An analogues of Huppert's conjecture can be proposed and studied for any set of integers related to a finite group. For instance, a dual version of Huppert's conjecture for the set of conjugacy class sizes is considered. For more results see $[1,2,3]$. In this paper, we are concerned with the following conjecture, inspired by Huppert's conjecture:
Conjucture: Let $G$ be a finite group and $H$ a non-abelian simple group. If $\operatorname{cod}(G)=$ $\operatorname{cod}(H)$, then $G \cong H$.
This conjecture first proposed in [7], where the authors verified the above conjecture for all projective special linear groups of degree 2. In this article by using the same method in [7], we verify this conjecture for $K_{3}$-groups. Also we recall that Huppert's conjecture is true for $K_{3}$-groups (see [12]).

We refer to [13] for the notation of character theory of finite groups. If $L \leqslant G$ and $\theta \in \operatorname{Irr}(L)$, then we write $\operatorname{Irr}(G \mid \theta)=\left\{\chi \in \operatorname{Irr}(G) \mid\left[\chi_{L}, \theta\right] \neq 0\right\}$. Moreover, $\operatorname{Irr}(G \mid L)=\operatorname{Irr}(G)-\operatorname{Irr}(G / L)$.

## 2. Preliminaries

In this section we give some results which will be used later in our proofs.
Proposition 2.1. [15, Lemma 2] Let $S$ be a non-abelian finite simple group. Then there exists $1_{s} \neq \theta \in \operatorname{Irr}(S)$ that extends to $\operatorname{Aut}(S)$.
Proposition 2.2. [8, Lemma 5] Let $N$ be a minimal normal subgroup of $G$ such that $N=S_{1} \times S_{2} \times \cdots \times S_{t}$, where $S_{i} \cong S$ is a non-abelian simple group. If $\theta \in \operatorname{Irr}(S)$ extends to Aut(S) then $\theta \times \theta \times \cdots \times \theta \in \operatorname{Irr}(N)$ extends to $G$.

Proposition 2.3. [15, Theorem C] Let $G$ be a nonabelian finite simple group. Then either $|c d(G)| \geq 8$ or one of the following cases holds.
(i): $|\operatorname{cd}(G)|=4$ and $G=\operatorname{PSL}\left(2,2^{\mathrm{f}}\right)$, where $f \geq 2$.
(ii): $|\operatorname{cd}(G)|=5$ and $G=\operatorname{PSL}(2, \mathrm{q})$, where $q=p^{f}, p \neq 2$ and $p^{f}>5$.
(iii): $|\operatorname{cd}(G)|=6$ and $G=\operatorname{PSL}(3,4)$ or $G / N={ }^{2} B_{2}\left(2^{2 f+1}\right)$, where $f \geq 1$.
(iv): $|\operatorname{cd}(G)|=7$ and $G=\operatorname{PSL}(3,3), A_{7}, M_{11}$ or $J_{1}$.

Remark. By [10] we see that $\operatorname{cod}\left(U_{3}(3)\right)=\left\{1,2^{4} .3^{2} .7,2^{5} .3^{3}, 2^{4} .3^{3}, 2^{5} .3^{2}, 2^{5} .7,2^{3} .3^{3}, 3^{3} .7\right\}$.
Also $\operatorname{cod}\left(U_{4}(2)\right)=\left\{1,2^{6} .3^{4}, 2^{5} .3^{3} .5,2^{5} .3^{4}, 2^{6} .3^{3}, 2^{4} .3^{4}, 2^{3} .3^{3} .5,2^{5} .3^{3}, 2^{3} .3^{4}, 2^{6} .3^{2}, 2^{4} .3^{3}, 3^{4} .5,2^{6} .5\right\}$.
By [16, Lemma 2.1] we have the following result.

Proposition 2.4. Let $\chi \in \operatorname{Irr}(G)$.
(i) For any $N \unlhd G$ with $N \leq \operatorname{ker}(\chi)$, $\chi$ may be viewed as an irreducible character of $G / N$. The codegree $\operatorname{cod}(\chi)$ of $\chi$ is the same whenever $\chi$ is seen as an irreducible character of $G$ or $G / N$. Furthermore, $\operatorname{cod}(\chi)$ is independent of the choice of such $N$.
(ii) If $M$ is a subnormal subgroup of $G$ and $\varphi$ is an irreducible constituent of $\chi_{M}$, then $\operatorname{cod}(\varphi)$ divides $\operatorname{cod}(\chi)$.

## 3. MAIN RESULTS

We recall that if $G$ is a finite simple $K_{3}$-group, then $G$ is isomorphic to one of the following groups:

A_{5}, A_{6}, \mathrm{~L}_{2}(7), \mathrm{L}_{2}(8), \mathrm{L}_{2}(17), \mathrm{L}_{3}(3), \mathrm{U}_{3}(3), \mathrm{U}_{4}(2)
$$

Also by [7], we see that the conjecture is true for $A_{5}, A_{6}, \mathrm{~L}_{2}(7), \mathrm{L}_{2}(8), \mathrm{L}_{2}(17), \mathrm{L}_{3}(3)$. Thus in this section we just verify the conjecture for $\mathrm{U}_{3}(3)$ and $\mathrm{U}_{4}(2)$.
Theorem 3.1. Suppose that $G$ is a group and $\operatorname{cod}(G)=\operatorname{cod}\left(U_{3}(3)\right)$. If $N$ is a maximal normal subgroup of $G$ then $G / N \cong U_{3}(3)$.

Proof. By our assumption $G / N$ is a simple group. If $G / N$ is abelian then $G^{\prime} \leq N$ and so $G \neq G^{\prime}$. Now by Proposition 2.4, $\operatorname{cod}\left(G / G^{\prime}\right) \subseteq \operatorname{cod}(G)$ and so $\operatorname{cod}(G)$ contains a prime power, a contradiction. Thus we may suppose that $G / N$ is nonabelian simple group. If $|\operatorname{cd}(G / N)| \geq 8$ then by $\operatorname{cod}(G / N) \subseteq \operatorname{cod}(G)$ and $\operatorname{cod}(G)=\operatorname{cod}\left(U_{3}(3)\right)$ we see
that $|\operatorname{cod}(G / N)|=\left|\operatorname{cod}\left(U_{3}(3)\right)\right|=8$. Thus $|\operatorname{cd}(G / N)|=\left|\operatorname{cd}\left(U_{3}(3)\right)\right|$ and by Huppert's conjecture $G / N \cong U_{3}(3)$. Thus we may suppose that $|\operatorname{cd}(G / N)|<8$ and we find contradiction. Now by Proposition 2.3, we considering the following cases.
Case 1. $|\operatorname{cd}(G / N)|=4$ and $G / N \cong \operatorname{PSL}\left(2,2^{\mathrm{f}}\right)$, where $f \geq 2$.
By [19], we know that $\operatorname{cod}\left(\operatorname{PSL}\left(2,2^{\mathrm{f}}\right)\right)=\left\{1, q(q-1), q(q+1), q^{2}+1\right\}$, where $q=2^{f}$ and $\operatorname{cod}\left(U_{3}(3)\right)=\left\{1,2^{4} .3^{2} .7,2^{5} .3^{3}, 2^{4} .3^{3}, 2^{5} .3^{2}, 2^{5} .7,2^{3} .3^{3}, 3^{3} .7\right\}$. It is easy to see that $\operatorname{cod}\left(\operatorname{PSL}\left(2,2^{\mathrm{f}}\right)\right) \nsubseteq \operatorname{cod}\left(U_{3}(3)\right)$, a contradiction.
Case 2. $|\operatorname{cd}(G / N)|=5$ and $G / N \cong \operatorname{PSL}(2, \mathrm{q})$, where $q=p^{f}, p \neq 2$ and $q>5$.
By [19], we know that $\operatorname{cod}(\operatorname{PSL}(2, q))=\left\{1, q(q-1) / 2, q(q+1) / 2,\left(q^{2}-1\right) / 2, q(q-\epsilon(q))\right\}$, where $\epsilon(q)=(-1)^{(q-1) / 2}$. It is easy to see that $\operatorname{cod}\left(\operatorname{PSL}\left(2, \mathrm{p}^{\mathrm{f}}\right)\right) \nsubseteq \operatorname{cod}\left(U_{3}(3)\right)$, a contradiction.
Case 3. $|\operatorname{cd}(G / N)|=6$ and $G / N=\operatorname{PSL}(3,4)$ or $G / N={ }^{2} B_{2}\left(2^{2 f+1}\right)$, where $f \geq 1$.
First suppose that $G / N=\operatorname{PSL}(3,4)$. We know that $\operatorname{cd}(\operatorname{PSL}(3,4))=\{1,20,35,45,63,64\}$ and so $\operatorname{cod}(\operatorname{PSL}(3,4))=\left\{1,2^{4} .3^{2} .7,2^{6} .3^{2}, 2^{6} .7,2^{6} .5,3^{2} .5 .7\right\}$. Now $2^{6} .5 \in \operatorname{cod}(\operatorname{PSL}(3,4))$ and so $2^{6} .5 \notin \operatorname{cod}\left(U_{3}(3)\right)$, a contradiction. Thus we may suppose $G / N={ }^{2} B_{2}\left(2^{2 f+1}\right)$, where $q^{2}=2^{2 f+1}, r=2^{f+1}$ and $f \geq 1$. We know that $\operatorname{cd}\left({ }^{2} B_{2}\left(2^{2 f+1}\right)\right)=\left\{1, q^{4}, q^{4}+\right.$ $\left.1,\left(q^{2}-r+1\right)\left(q^{2}-1\right),\left(q^{2}+r+1\right)\left(q^{2}-1\right), r\left(q^{2}-1\right) / 2\right\}$ and so $\operatorname{cod}\left({ }^{2} B_{2}\left(2^{2 f+1}\right)\right)=$ $\left\{1,\left(q^{4}+1\right)\left(q^{2}-1\right), q^{4}\left(q^{2}-1\right), \frac{q^{4}\left(q^{4}+1\right)}{q^{2}-r+1}, \frac{q^{4}\left(q^{4}+1\right)}{q^{2}+r+1}, \frac{2 q^{4}\left(q^{4}+1\right)}{r}\right\}$. Now with the simple check we can see that $\operatorname{cod}\left({ }^{2} B_{2}\left(2^{2 f+1}\right)\right) \nsubseteq \operatorname{cod}\left(U_{3}(3)\right)$, a contradiction.
Case 4. $|\operatorname{cd}(G / N)|=7$ and $G / N=\operatorname{PSL}(3,3), A_{7}, M_{11}$ or $J_{1}$.
We know that $\operatorname{cd}(\operatorname{PSL}(3,3))=\{1,12,13,16,26,27,39\}$ and so $\operatorname{cod}(\operatorname{PSL}(3,3))=\left\{1,2^{2} .3^{2} .13\right.$, $\left.2^{4} .3^{3}, 3^{3} .13,2^{3} .3^{3}, 2^{4} .13,2^{4} .3^{2}\right\}$. Now it is easy to see that $\operatorname{cod}(\operatorname{PSL}(3,3)) \nsubseteq \operatorname{cod}\left(U_{3}(3)\right)$.
Also if $G / N \cong A_{7}$ then $\operatorname{cd}\left(A_{7}\right)=\{1,6,10,14,15,21,35\}$ and so $\operatorname{cod}\left(A_{7}\right)=\left\{1,2^{2} .3 .5 .7,2^{2} .3^{2} .7\right.$, $\left.2^{2} .3^{2} .5,2^{3} .3 .7,2^{3} .3 .5,2^{3} .3^{2}\right\}$. Again we see that $\operatorname{cod}\left(A_{7}\right) \nsubseteq \operatorname{cod}\left(U_{3}(3)\right)$. If $G / N \cong M_{11}$ then $\operatorname{cd}\left(M_{11}\right)=\{1,10,11,16,44,45,55\}$. If $\chi(1)=16$ then $\operatorname{cod}(\chi(1))=3^{2} .5 .11$ and so $3^{2} .5 .11 \in \operatorname{cod}\left(U_{3}(3)\right)$, a contradiction. Fially if $G / N \cong J_{1}$ then $\operatorname{cd}\left(J_{1}\right)=$ $\{1,56,76,77,120,133,209\}$. If $\chi(1)=56$ then $\operatorname{cod}(\chi(1))=3.5 .11 .19$ and so 3.5.11.19 $\in$ $\operatorname{cod}\left(U_{3}(3)\right)$, a contradiction.

Lemma 3.2. Suppose that $G$ is a simple group which is isomorphic to alternating group $A_{n}(n \geq 5)$ or sporadic group. Then $4 \leq|\operatorname{cod}(G)| \leq 12$ if and oly if $G$ is isomorphic to one of the following groups.

A_{5}, A_{6}, A_{7}, A_{8}, M_{11}, M_{12}, M_{22}, M_{23}, J_{1}
$$

Proof. We use the classification of finite simple groups. For the sporadic groups by [10], with the simple check we see that $G$ is isomorphic to $M_{11}$ or $M_{12}$ or $M_{22}$ or $M_{23}$ or $J_{1}$. For $A_{n}$ where $5 \leq n \leq 13$, by [10] we see that $G \cong A_{5}$ or $A_{6}$ or $A_{7}$ or $A_{8}$. Thus we may assume that $n \geq 14$. Now the characters corresponding to the non-self-associated partitions $(n-1,1),(n-2,2),(n-2,1,1),(n-3,3)$, $(n-3,2,1),(n-3,1,1,1),(n-4,4),(n-4,3,1),(n-4,2,2),(n-4,1,1,1,1)$, $(n-5,5),(n-5,4,1),(n-5,3,2)$ have distinct degrees $n-1, \frac{n(n-3)}{2}, \frac{(n-1)(n-2)}{2}$,

& \frac{n(n-1)(n-5)}{6}, \frac{n(n-2)(n-4)}{3}, \frac{(n-1)(n-2)(n-3)}{6}, \frac{n(n-1)(n-2)(n-7)}{24}, \frac{n(n-1)(n-3)(n-6)}{8}, \frac{n(n-1)(n-4)(n-5)}{12} \\
& \frac{(n-1)(n-2)(n-3)(n-4)}{24}, \frac{n(n-1)(n-2)(n-3)(n-9)}{120}, \frac{n(n-1)(n-2)(n-4)(n-8)}{24}, \frac{n(n-1)(n-2)(n-5)(n-7)}{24}
\end{aligned}

Theorem 3.3. Suppose that $G$ is a group and $\operatorname{cod}(G)=\operatorname{cod}\left(U_{4}(2)\right)$. If $N$ is a maximal normal subgroup of $G$ then $G / N \cong U_{4}(2)$.

Proof. By our assumption $G / N$ is a nonabelian simple group and so $|\operatorname{cd}(G / N)| \geq 4$. We know that $\operatorname{cod}(G / N) \subseteq \operatorname{cod}(G)$ and $\operatorname{cod}(G)=\operatorname{cod}\left(U_{4}(2)\right)$ and so $4 \leq|\operatorname{cod}(G / N)| \leq 13$. if $|\operatorname{cod}(G / N)|=13$ then $|\operatorname{cd}(G / N)|=\left|\operatorname{cd}\left(U_{4}(2)\right)\right|$ and by Huppert's conjecture $G / N \cong$ $U_{4}(2)$. Thus we may suppose that $4 \leq|\operatorname{cd}(G / N)| \leq 12$.

If $G / N$ is alternating group $A_{n}$ or sporadic group then by Lemma 3.2 $G / N$ is isomorphic to $A_{5}$ or $A_{6}$ or $A_{7}$ or $A_{8}$ or $M_{11}$ or $M_{12}$ or $M_{22}$ or $M_{23}$ or $J_{1}$. By [10] we see $\operatorname{cod}(G / N) \nsubseteq \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction. In what follows, we assume that $G / N$ is a simple group of Lie type.
Exceptional groups of Lie type. Let $G / N$ be one of the groups ${ }^{3} D_{4}(q), G_{2}(q), F_{4}(q)$, ${ }^{2} B_{2}\left(q^{2}\right)\left(q^{2}=2^{2 f+1}\right), E_{6}(q),{ }^{2} E_{6}(q), E_{7}(q), E_{8}(q),{ }^{2} G_{2}(q)\left(q=3^{2 f+1}\right)$ and ${ }^{2} F_{4}(q)(q=$ $\left.2^{2 f+1}\right)$. According to $[9$, Section 13.9], we see that $|\operatorname{cod}(G / N)| \geq 14$, where $G / N$ is isomorphic to $F_{4}(q), E_{6}(q),{ }^{2} E_{6}(q), E_{7}(q), E_{8}(q)$ or ${ }^{2} F_{4}(q)$. Thus we may suppose that $G / N$ is isomorphic to ${ }^{3} D_{4}(q), G_{2}(q),{ }^{2} B_{2}\left(q^{2}\right)$ or ${ }^{2} G_{2}(q)$.

Also by [11] We see that $|\operatorname{cod}(G / N)| \geq 14$, where $G / N$ is isomorphic to ${ }^{3} D_{4}(q)$. If $G / N={ }^{2} B_{2}\left(2^{2 f+1}\right), f \geq 1$, where $q^{2}=2^{2 f+1}$, and $f \geq 1$, then $|\operatorname{cd}(G / N)|=6$. Now with the simple check we can see that $\operatorname{cod}\left({ }^{2} B_{2}\left(2^{2 f+1}\right)\right) \nsubseteq \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction. Also if $G / N$ is isomorphic to $G_{2}(q)$ then by [9, Section 13.9] we see that $G$ has cuspidal character of degree $\frac{q(q+1)^{2}\left(q^{2}+q+1\right)}{6}$, say $\phi$. Now it is easy to see that $\operatorname{cod}(\phi)=\frac{6 q^{5}\left(q^{4}+q^{2}+1\right)(q-1)^{2}}{q^{2}+q+1}$. Now we see that $\operatorname{cod}(\phi) \notin \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction. Finally if $G$ is isomorphic to ${ }^{2} G_{2}(q)$, then by [18] we see that $G / N$ has character of degree $(q-1)\left(q^{2}-q+1\right)$, say $\delta$. Now it is easy to see that $\operatorname{cod}(\delta)=q^{3}(q+1)$. No we see that $\operatorname{cod}(\delta) \notin \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction.
Type $A_{n}$ : Linear groups. Therefore $G / N \cong L_{n+1}(q)$, where $q$ is a prime power of $p$ and $n \geq 1$. If $n=1$ then $G / N \cong L_{2}(q)$. If $q=2^{f}$ where $f \geq 2$ then it is easy to see that $\operatorname{cod}(\operatorname{PSL}(2, q)) \nsubseteq \operatorname{cod}\left(U_{4}(2)\right)$. If $q=p^{f}$, where $p \neq 2$ and $q>5$, then again it is easy to see that $\operatorname{cod}(\operatorname{PSL}(2, \mathrm{q})) \nsubseteq \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction. Thus we may suppose $n \geq 2$, then $G / N$ has a character of degree $\frac{q\left(q^{n}-1\right)}{q-1}$, say $\chi$. Now $\operatorname{cod}(\chi)=q^{\frac{n^{2}+n-2}{2}} \Pi_{i=1}^{n} \frac{\left(q^{i+1}-1\right)(q-1)}{(n+1, q-1)\left(q^{n}-1\right)}$ and $\operatorname{cod}(\chi) \notin \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction.
Type ${ }^{2} A_{n}$ : Unitary groups.Therefore $G / N \cong U_{n+1}(q)$, where $n \geq 2$. Now by [14], $G / N$ has a character of degree $\frac{q\left(q^{n}-(-1)^{n}\right)}{q+1}$, say $\chi$. Now $\operatorname{cod}(\chi)=q^{\frac{n^{2}+n-2}{2}} \Pi_{i=1}^{n} \frac{\left(q^{i+1}-(-1)^{i+1}\right)(q+1)}{(n+1, q+1)\left(q^{n}-(-1)^{n}\right)}$ and $\operatorname{cod}(\chi) \notin \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction.
Type ${ }^{\circ}{ }^{\circ} B_{n}$ or $C_{n}$ : Odd dimensional orthogonal groups and Symplectic groups. Therefore $G / N \cong S_{2 n}(q)$ or $O_{2 n+1}(q)$, where $n \geq 2$. If $n=2$ then by [9, Section 13.8], $G / N$ has a unipotent character of $\frac{q(q+1)^{2}}{2}$, say $\chi$. Now $\operatorname{cod}(\chi)=\frac{2 q^{3}(q-1)^{2}\left(q^{2}+1\right)}{(2, q-1)}$ and $\operatorname{cod}(\chi) \notin \operatorname{cod}\left(U_{4}(2)\right)$, where $q \neq 3$, a contradiction. If $q=3$ then $G / N \cong U_{4}(2)$, as wanted. Also if $n>2$ then by [ 9 , Section 13.8] $G / N$ has a steinberg character of degree
$q^{n^{2}}$, say $\theta$. Now $\operatorname{cod}(\theta)=\frac{\Pi_{i=1}^{n}\left(q^{2 i}-1\right)}{(2, q-1)}$ and $\operatorname{cod}(\chi) \notin \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction.
Type $D_{n}$ : Even dimensional orthogonal groups. Therefore $G / N \cong O_{2 n}^{+}(q)$, where $n \geq 2$. If $n=2$ then $G / N \cong \mathrm{~L}_{2}(\mathrm{q}) \times \mathrm{L}_{2}(\mathrm{q})$. Suppose that $q=2^{f}$. Then $\operatorname{cod}(\theta)=q^{2}\left(q^{2}-1\right)$, where $f \geq 2$ and $\theta \in \operatorname{Irr}\left(\mathrm{L}_{2}(\mathrm{q}) \times \mathrm{L}_{2}(\mathrm{q})\right)$. Now suppose that $q=p^{f}$, where $p \neq 2$ and $p^{f}>5$. Then $\operatorname{cod}(\theta)=\frac{q^{2}\left(q^{2}-1\right)}{4}$, where $\theta \in \operatorname{Irr}\left(\mathrm{L}_{2}(\mathrm{q}) \times \mathrm{L}_{2}(\mathrm{q})\right)$. In each case we see that $\operatorname{cod}(\theta) \notin \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction.

Also if $n=3$ then $G / N \cong L_{4}(q)$ which is isomorphic to type $A_{3}$. Thus we may suppose that $n \geq 4$. Now by [14], $G / N$ has an irreducible character of degree $\frac{q\left(q^{n-2}+1\right)\left(q^{n}-1\right)}{q^{2}-1}$, say $\phi$. Now $\operatorname{cod}(\phi)=\frac{q^{n^{2}-n-1} \Pi_{i=1}^{n-1}\left(q^{2 i}-1\right)\left(q^{2}-1\right)}{\left(4, q^{n}-1\right)\left(q^{n-2}+1\right)}$ and $\operatorname{cod}(\phi) \notin \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction. Type ${ }^{2} D_{n}$ : Even dimensional orthogonal groups. Therefore $G / N \cong O_{2 n}^{-}(q)$, where $n \geq 2$. If $n=2$ then $G / N \cong \mathrm{~L}_{2}\left(\mathrm{q}^{2}\right)$ which is isomorphic to type $A_{1}$. Also if $n=3$ then $G / N \cong U_{4}(q)$ which is isomorphic to type ${ }^{2} A_{3}$. Thus we may suppose that $n \geq 4$. Now by [14], $G / N$ has an irreducible character of degree $\frac{q\left(q^{n-2}-1\right)\left(q^{n}+1\right)}{q^{2}-1}$, say $\sigma$. Now $\operatorname{cod}(\sigma)=\frac{q^{n^{2}-n-1} \Pi_{i=1}^{n-1}\left(q^{2 i}-1\right)\left(q^{2}-1\right)}{\left(4, q^{n}+1\right)\left(q^{n-2}-1\right)}$ and $\operatorname{cod}(\sigma) \notin \operatorname{cod}\left(U_{4}(2)\right)$, a contradiction.

Theorem 3.4. Suppose that $G$ is a finite group and $\operatorname{cod}(G)=\operatorname{cod}\left(U_{3}(3)\right)$ or $\operatorname{cod}(G)=$ $\operatorname{cod}\left(U_{4}(2)\right)$. Then $G \cong U_{3}(3)$ or $G \cong U_{4}(2)$.

Proof. Suppose that $N$ is the maximal normal subgroup of $G$. By Theorem 3.1 and Theorem 3.3, $G / N \cong U_{3}(3)$ or $G / N \cong U_{4}(2)$. We show that $N=1$. Suppose to the contrary that $G$ is a counterexample with minimal order. Thus there is no groups with order less than $G$, say $H$, such that has a maximal normal subgroup, say $M$, such that $H / M \cong U_{3}(3)$ or $U_{4}(2)$ and $M \neq 1$. Assume that $H \unlhd G$, where $H \neq 1$ and $H<N$. Now $G / N \cong(G / H) /(N / H)$ and so $\operatorname{cod}(\mathrm{G} / \mathrm{N}) \subseteq \operatorname{cod}(\mathrm{G} / \mathrm{H}) \subseteq \operatorname{cod}(\mathrm{G})$. Thus $\operatorname{cod}(\mathrm{G} / \mathrm{H})=\operatorname{cod}(\mathrm{G})$ and so by minimality of $G$ we get a contradiction. Thus $N$ is also a minimal normal subgroup of $G$. If $N$ is not abelian then $N \cong T \times T \times \cdots T=T^{n}$, where $T$ is a non-abelian simple group. By Propositions 2.1, 2.2, there exits $1_{N} \neq \phi \in$ $\operatorname{Irr}(N)$ which extends to some irreducible character of $G$, say $\theta$. We have $\operatorname{ker}(\theta) N \unlhd G$ and by the maximality of $N$ we have that either $\operatorname{ker}(\theta) N=N$ or $\operatorname{ker}(\theta) N=G$. If $\operatorname{ker}(\theta) N=N$ then $\operatorname{ker}(\theta) \subseteq N$. Since $N$ is a minimal normal subgroup we have either $\operatorname{ker}(\theta)=1$ or $\operatorname{ker}(\theta)=N$. We know that $\theta_{N} \neq 1$ and so we $\operatorname{ker}(\theta)=1$ or $G=\operatorname{ker}(\theta) \times N$. If $\operatorname{ker}(\theta)=1$ then $\operatorname{cod}(\theta)=|G| / \theta(1)$. Since $\theta(1)||N|$, it implies that $|N|=m \theta(1)$ for some positive integer $m$. Thus $|G| /|N|=|G| / m \theta(1)$ and so $m|G| /|N|=|G| / \theta(1)$. Therefore $|G| /|N|| | G \mid / \theta(1)=\operatorname{cod}(\theta)$. We know that $\operatorname{cod}(\theta) \in \operatorname{cod}(G)$ and $\operatorname{cod}(G)=\operatorname{cod}\left(U_{3}(3)\right)$ or $\operatorname{cod}(G)=\operatorname{cod}\left(U_{4}(2)\right)$. We know that $|G / N|=\left|U_{3}(3)\right|=2^{5} .3^{3} .7$ and $|G / N|=\left|U_{4}(2)\right|=2^{6} .3^{4} .5$. Now we get contradition easily. Thus we may suppose that $G=\operatorname{ker}(\theta) \times N$. Since $N$ is the minimal normal subgroup of $G$, it follows that $\operatorname{ker}(\theta)$ is the maximal normal subgroup of $G$. Now by Theorem 3.1 and Theorem 3.3 we see that $G / \operatorname{ker}(\theta) \cong U_{3}(3)$ or $G / \operatorname{ker}(\theta) \cong U_{4}(2)$. Also we have $N \cong G / \operatorname{ker}(\theta)$. Therefore $N \cong \operatorname{ker}(\theta) \cong G / \operatorname{ker}(\theta)$. We know that
$\operatorname{cod}(G / \operatorname{ker}(\theta)) \subseteq \operatorname{cod}(G)$ and $\theta \in \operatorname{Irr}(G / \operatorname{ker}(\theta))$. Now $\operatorname{cod}(\theta)=|G| / \theta(1)=|N|^{2} / \theta(1)$. Since $\theta(1)||N|$ and $\operatorname{cod}(\theta) \in \operatorname{cod}(G)$ we have a contradiction. Thus $N$ is an abelian group. We know that $N \leq C_{G}(N)$ and $C_{G}(N) \unlhd G$. Now since $N$ is the maximal normal subgroup of $G$ we conclude that $N=C_{G}(N)$ or $C_{G}(N)=G$. If $C_{G}(N)=G$ then $N \leq Z(G)$. On the other hand if $G^{\prime}<G$ then by $\operatorname{cod}\left(G / G^{\prime}\right) \subseteq \operatorname{cod}(G)$, where $G \cong U_{3}(3)$ or $U_{4}(2)$, we see that $\operatorname{cod}(G)$ contains a prime, a contradiction. Thus $G$ is perfect and $N \cap G^{\prime}=N$. Thus $N \leq G^{\prime}$ and so $N \leq Z(G) \cap G^{\prime}$. Now since $G / N \cong U_{3}(3)$ or $U_{4}(2)$ we see thet $G$ is a central extension of $U_{3}(3)$ or $U_{4}(2)$. Also by [10], we know that $\operatorname{Mult}\left(U_{3}(3)\right)=1$ and $\operatorname{Mult}\left(U_{4}(2)\right) \cong \mathbb{Z}_{2}$. Thus $G \cong U_{3}(3)$ or $G \cong U_{4}(2)$ or $G \cong 2 \cdot U_{4}(2)$. Also by [10], we know that $\operatorname{cd}\left(2 \cdot U_{4}(2)\right)=\{1,4,20,36,60,64,80\}$ and we have a contradiction. Thus $G \cong U_{3}(3)$ or $G \cong U_{4}(2)$ and the assertion is hold. Therefore we may assume that $N=C_{G}(N)$. Now suppose that $\theta \in \operatorname{Irr}(G \mid N)$. We show that $\theta$ is faithful. If $\operatorname{ker}(\theta) \neq 1$ then we know that $N \unlhd \operatorname{ker}(\theta) N \unlhd G$ and so by our assumption about $N$ we see that either $N=\operatorname{ker}(\theta) N$ or $\operatorname{ker}(\theta) N=G$. First suppose that $\operatorname{ker}(\theta) N=G$. Now $\operatorname{ker}(\theta) \cap N \subseteq N$ and by our assumption about $N$ we see that $\operatorname{ker}(\theta) \cap N=1$ or $\operatorname{ker}(\theta) \cap N=N$. If $\operatorname{ker}(\theta) \cap N=N$ then $N \subseteq \operatorname{ker}(\theta) \subseteq G$, a contradiction. Thus $\operatorname{ker}(\theta) \cap N=1$. Thus $G=\operatorname{ker}(\theta) \times N$. Now by considering $G=G^{\prime}$ we get a contradiction. Therefore $\operatorname{ker}(\theta) \leq N$ and so by the minimality of $N$ we have $\operatorname{ker}(\theta)=N$, a contradiction. Thus $\theta$ is faithful for each $\theta \in \operatorname{Irr}(G \mid N)$ as asserted. Now we show that if $1_{N} \neq \lambda \in \operatorname{Irr}(N)$ then we have $\left|I_{G}(\lambda)\right| / \theta(1) \in \operatorname{cod}(\mathrm{G})$ for all $\theta \in \operatorname{Irr}\left(I_{G}(\lambda) \mid \lambda\right)$. By [13, Theorem 6.11], we see that $\theta^{G} \in \operatorname{Irr}(G)$ for all $\theta \in$ $\operatorname{Irr}\left(I_{G}(\lambda) \mid \lambda\right)$. If $N \leq \operatorname{ker}(\theta)$ then for each $n \in N$ we have $\theta(n)=\theta(1)$ and by [13, Theorem 6.2] we have $\theta_{N}(1)=\operatorname{et} \theta(1)$ where $t=\left|G: I_{G}(\theta)\right|$ and $e$ divides $|G: H|$. Now it is easy to see that for each $n \in N$ we have $\lambda(n)=\lambda(1)$, a contradiction. Thus we have $N \not \leq \operatorname{ker}(\theta)$ and $\theta \in \operatorname{Irr}(G \mid N)$. Now as we showed that we see that $\operatorname{ker}\left(\theta^{G}\right)=1$. Thus we have $\operatorname{cod}\left(\theta^{G}\right) \in \operatorname{cod}(G)$, as desired. We have $\operatorname{cod}(G / N)=\operatorname{cod}(G)$ and $\left|I_{G}(\lambda)\right| / \theta(1) \in \operatorname{cod}(G)$. Therefore $\left|I_{G}(\lambda)\right||N| /|N| \theta(1) \in \operatorname{cod}(G)$. By [13, Theorem 6.15] we have $\theta(1)\left|\left|I_{G}(\lambda) / N\right|\right.$. Thus $| N \mid$ divides the codegree of some irreducible character of $G / N$, and so $|N|||G / N|$.

We know that $C_{G}(N)=N$ and so $|G / N|||\operatorname{Aut}(N)|$. Also we know that $N$ is an elementary abelian $r$-group. If $G / N \cong U_{3}(3)$ then $r \in\{2,3,7\}$. Thus $|\operatorname{Aut}(N)|$ divides $|\mathrm{GL}(5,2)|$ or $|\mathrm{GL}(3,3)|$ or $\left|\mathbb{Z}_{6}\right|$. Now since $|N|||G / N|$ we have a contradiction. Also if $G \cong U_{4}(2)$ then $r \in\{2,3,5\}$. If $|N| \mid 2^{5}$ or $|N| \mid 3^{3}$ or $|N|=5$ then $|\operatorname{Aut}(N)|$ divides $|\mathrm{GL}(5,2)|$ or $|\mathrm{GL}(3,3)|$ or $\left|\mathbb{Z}_{4}\right|$, a contradiction. Thus we may suppose that $|N|=2^{6}$ or $|N|=3^{4}$. If $|N|=2^{6}$ then $\operatorname{Aut}(\mathrm{N}) \cong \mathrm{GL}(6,2)$. Now it is easy to see that $\operatorname{cd}\left(U_{4}(2) \nsubseteq \operatorname{cd}(\mathrm{GL}(6,2))\right.$, a contradiction. Also if $|N|=3^{4}$ then $\operatorname{Aut}(\mathrm{N}) \cong \mathrm{GL}(4,3)$ and again $\operatorname{cd}\left(U_{4}(2)\right) \nsubseteq \operatorname{cd}(\mathrm{GL}(4,3))$, a contradiction.
