# 3-Coloring on Regular, Planar, and Ordered Hamiltonian Graphs

#### Abstract

We prove that 3-Coloring remains NP-hard on 4- and 5-regular planar Hamiltonian graphs, strengthening the results of Dailey [Disc. Math.'80] and Fleischner and Sabidussi [J. Graph. Theor.'02]. Moreover, we prove that 3-Coloring remains NP-hard on $p$-regular Hamiltonian graphs for every $p \geq 6$ and $p$-ordered regular Hamiltonian graphs for every $p \geq 3$.


Keywords. Hamiltonian cycle, NP-hardness, 2-factor, Hamiltonian-ordered

## 1 Introduction

We study the computational complexity of the following classic NP-complete problem [11] on Hamiltonian graphs (graphs admitting a cycle that visits every vertex exactly once) that are additionally restricted to be planar, regular, and ordered.

Problem 1. 3-Coloring (3-Col)
Input: An undirected graph $G=(V, E)$.
Question: Is $G 3$-colorable?
Figure 1 gives an overview of our results. Dailey [5] proved that 3-Coloring is NP-complete on 4- and 5 -regular planar graphs, and Fleischner and Sabidussi [8] proved that 3-Coloring is NP-complete and on 4-regular Hamiltonian graphs. We strengthen these two results by proving that 3 -Coloring is NP-hard on 4 - and 5 -regular planar Hamiltonian graphs (Section 3). Note that 3 -Coloring is polynomial-time solvable on graphs of maximum degree three [3]. Moreover, we prove that 3 -Coloring is NP-hard on $p$-regular Hamiltonian graphs for every $p \geq 6$ (Section 4). Finally, we prove that 3-Coloring is NP-hard on $p$-ordered regular Hamiltonian graphs for every $p \geq 3$, which implies NP-hardness on regular ( $p-1$ )-connected Hamiltonian graphs (Section 5). All our NP-hardness results still hold true if a Hamiltonian cycle is additionally provided as part of the input (recall that computing a Hamiltonian cycle is NP-complete in general [11]).

Related Work. In our previous work [4], we proved that Feedback Vertex Set remains NP-complete on 4- and 5-regular planar Hamiltonian graphs, p-regular Hamiltonian graphs for every $p \in \mathbb{N}_{\geq 6}$, and $p$-Hamiltonian-ordered graphs for every $p \in \mathbb{N}_{\geq 3}$. Several classic graph problems are studied on planar regular graphs. For instance, Independent Set and Dominating SET are proven to be NP-complete on planar 3-regular graphs [12, 14]. Moreover, Independent SET is proven to be NP-hard on 3- and 4-regular Hamiltonian graphs [9]. p-Hamiltonian-ordered graphs were introduced by Ng and Schultz [16].

## 2 Preliminaries

We denote by $\mathbb{N}$ and $\mathbb{N}_{0}$ the natural numbers excluding and including zero, respectively. We denote by $\mathbb{N}_{\geq p}$ with $p \in \mathbb{N}$ the set $\mathbb{N}_{0} \backslash\{0, \ldots, p-1\}$.

Graph Theory. We use basic notations from graph theory [6]. We call graph $G=(V, E)$ even if $|V|$ is even, and odd otherwise. The neighborhood $N_{G}(v)$ of a vertex $v \in V$ in $G$ is the vertex set $\{w \in V \mid\{v, w\} \in E\}$. The degree of a vertex $v$ is $\left|N_{G}(v)\right|$. A graph is ( $k$-)regular if every vertex has the same degree $(k)$. A cycle is a 2 -regular connected graph. We represent a cycle also by a tuple, that is, the cycle $C=\left(v_{0}, \ldots, v_{n-1}, v_{0}\right)$ is the cycle with vertex set $\left\{v_{0}, \ldots, v_{n-1}\right\}$ and edge set $\left\{\left\{v_{i}, v_{i+1} \bmod n\right\} \mid i \in\{0, \ldots, n-1\}\right\}$. Let $v, w$ be two distinct vertices in $G=(V, E)$. The graph obtained by identifying $v$ with $w$ has vertex set $(V \backslash\{v, w\}) \cup\{v w\}$, where $v w$ is a new vertex, and edge set $(E \backslash\{e \in E \mid\{v, w\} \cap e \neq \emptyset\}) \cup\left\{\{v w, x\} \mid x \in\left(N_{G}(v) \cup N_{G}(w)\right) \backslash\{v, w\}\right\}$. A graph is planar if it can be drawn on the two-dimensional plane with no two edges crossing except at their endpoints. A graph is $p$-(Hamiltonian-)ordered, $p \in \mathbb{N}_{\geq 3}$ if for each $p$-tuple $\left(v_{1}, \ldots, v_{p}\right)$ of vertices there exists a (Hamiltonian) cycle that visits the vertices $x_{1}, \ldots, x_{p}$ in this order.

A $k$-coloring of $G=(V, E)$ is a function $f: V \rightarrow\{1, \ldots, k\}$. A $k$-coloring $f$ of $G$ is valid if for every $\{v, w\} \in E$ it holds that $f(v) \neq f(w)$. Graph $G$ is $k$-colorable if there is a valid $k$ -

coloring of $G$. For $\emptyset \neq V^{\prime} \subset V$, a $k$-coloring $f^{\prime}: V^{\prime} \rightarrow\{1, \ldots, k\}$ is called partial. A partial $k$-coloring $f^{\prime}: V^{\prime} \rightarrow\{1, \ldots, k\}$ is called extendable if there is a partial $k$-coloring $g: V \backslash V^{\prime} \rightarrow$ $\{1, \ldots, k\}$ such that the $k$-coloring $f: V \rightarrow\{1, \ldots, k\}$ with $f(v)=f^{\prime}(v)$ if $v \in V^{\prime}$, and $f(v)=$ $g(v)$ if $v \in V \backslash V^{\prime}$, is valid.

## 3 Planar Regular Hamiltonian Graphs

In this section, we prove that 3-Coloring is NP-hard on 4- and 5-regular planar Hamiltonian graphs with a Hamiltonian cycle provided. Note that no planar $p$-regular graph with $p \geq 6$ exists.

### 3.1 4-regular planar Hamiltonian

We prove the following.
Theorem 1. 3-Coloring on 4-regular planar Hamiltonian graphs is NP-hard, even if a Hamiltonian cycle is provided.

Following the idea of Fleischner and Sabidussi [8], we first compute a 2 -factor in polynomial time. A 2-factor of a graph $G$ is a set $\left\{Q_{1}, \ldots, Q_{t}\right\}, t \in \mathbb{N}$, of cycles such that $V(G)=\bigcup_{i \in\{1, \ldots, t\}} V\left(Q_{i}\right)$. Then, we iteratively "merge" two cycles from the 2-factor via one of the graphs $H$ and $S$ (see Figure 2). By this, in each repetition, we reduce the number of cycles in the 2 -factor while preserving a 2 -factor. Finally, we obtain a Hamiltonian cycle.

Each of the graphs $H$ and $S$, contains two disjoint subgraphs isomorph to the graph $L$ (see Figure 2(a)). We have the following important property of $L$.

Observation 1. Graph $L$ is 3-colorable and for every valid 3-coloring $f: V(L) \rightarrow\{1,2,3\}$, it holds that $f(x) \neq f(y), f(x)=f\left(y_{1}\right)$, and $f(x) \cup f\left(x_{1}\right) \cup f\left(y_{2}\right)=\{1,2,3\}$.

Proof. An extendable partial 3-coloring of $L$ is depicted in Figure 2(a). Let $f: V(L) \rightarrow\{1,2,3\}$ be an arbitrary valid 3-coloring of $L$. We have that $f(x) \notin\left\{f\left(x_{1}\right), f\left(x_{2}\right)\right\}$, and hence $f(z)=f(x)$.

Since $f(z) \notin\left\{f\left(y_{2}\right), f\left(y_{3}\right)\right\}$, we have that $f\left(y_{1}\right)=f(x)$ and hence $f(y) \neq f(x)$. Since $f\left(x_{2}\right) \neq$ $f\left(y_{3}\right)$, we have $f\left(x_{1}\right) \neq f\left(y_{2}\right)$ and thus $f(x) \cup f\left(x_{1}\right) \cup f\left(y_{2}\right)=\{1,2,3\}$.

We have the following important properties on $H$ and $S$.
Lemma 1. Graph $X \in\{H, S\}$ is 3-colorable and for every valid 3-coloring $f: V(X) \rightarrow\{1,2,3\}$, it holds that $f(x) \neq f(y), f\left(x^{\prime}\right) \neq f\left(y^{\prime}\right)$, and $f(x) \neq f\left(x^{\prime}\right)$.

Proof. We distinguish whether $X=H$ or $X=S$.
Case 1: $X=H$. An extendable partial 3-coloring of $X$ is depicted Figure 2(b). Let $f: V(X) \rightarrow$ $\{1,2,3\}$ be a valid 3-coloring of $X$. Due to Observation 1, we know that $f(x) \neq f(y)$ and $f\left(x^{\prime}\right) \neq$ $f\left(y^{\prime}\right)$. Moreover, we know that $f(x)=f\left(y_{1}\right)$ and $f\left(x^{\prime}\right)=f\left(y_{1}^{\prime}\right)$, and since $\left\{y_{1}, y_{1}^{\prime}\right\} \in E(X)$, it follows that $f(x) \neq f\left(x^{\prime}\right)$.

Case 2: $X=S$. An extendable partial 3-coloring of $X$ is depicted Figure 2(c). Let $f: V(X) \rightarrow$ $\{1,2,3\}$ be a valid 3-coloring of $X$. Due to Observation 1, we know that $f(x) \neq f(y)$ and $f\left(x^{\prime}\right) \neq$ $f\left(y^{\prime}\right)$. Moreover, we know that $f\left(x^{\prime}\right) \cup f\left(x_{1}^{\prime}\right) \cup f\left(y_{2}^{\prime}\right)=\{1,2,3\}$. Since $\left\{y_{1}, x_{1}^{\prime}, y_{2}^{\prime}\right\} \subseteq N_{X}(z)$, it follows that $f\left(y_{1}\right) \neq f\left(x^{\prime}\right)$. Since $f(x)=f\left(y_{1}\right)$, we thus have that $f(x) \neq f\left(x^{\prime}\right)$.

Definition 1 (Insertion). Let $G$ be a graph and $\left(v^{\prime}, v, u, u^{\prime}\right) \in V(G)^{4}$ be a quadruple with $\left\{v^{\prime}, v\right\}$, $\{v, u\},\left\{u, u^{\prime}\right\} \in E(G)$. An $X$-insertion at $\left(v^{\prime}, v, u, u^{\prime}\right)$ with $X \in\{H, S\}$ results in the graph obtained from $G$ by deleting the edges $\left\{v^{\prime}, v\right\},\{v, u\}$, and $\left\{u, u^{\prime}\right\}$, adding a copy of $X$ to $G$, and identifying $y^{\prime}$ with $v^{\prime}, x^{\prime}$ with $v, x$ with $u$, and $y$ with $u^{\prime}$.

Construction 1. Let $G$ be a connected planar 4 -regular graph, and let $\mathcal{Q}$ be a 2 -factor of $G$ with $|\mathcal{Q}|>1$. Then there are two distinct cycles $Q_{i}, Q_{j} \in \mathcal{Q}$ with two adjacent vertices $u$ and $v$ with $u \in V\left(Q_{i}\right)$ and $v \in V\left(Q_{j}\right)$. We distinguish two cases (see Figure 3 for an illustration).

Case 1: There are two edges $\left\{u^{\prime}, u\right\} \in E\left(Q_{i}\right)$ and $\left\{v, v^{\prime}\right\} \in E\left(Q_{j}\right)$ sharing the same face (see Figure 3(a)). Make an $H$-insertion at ( $\left.v^{\prime}, v, u, u^{\prime}\right)$.

Case 2: There are no two edges $e \in E\left(Q_{i}\right)$ and $e^{\prime} \in E\left(Q_{j}\right)$ with $u \in e$ and $v \in e^{\prime}$ sharing the same face (see Figure $3(\mathrm{~b})$ ). Since $u$ and $v$ are of degree four, there are two edges $\left\{u, u^{\prime}\right\} \in$ $E\left(Q_{i}\right)$ and $\left\{v, v^{\prime}\right\} \in E\left(Q_{j}\right)$ such that each share a face with $e$. Make an $S$-insertion at $\left(v^{\prime}, v, u, u^{\prime}\right)$.

Lemma 1 implies the following.
Observation 2. Let $G^{\prime}$ be the graph obtained from a graph $G$ using Construction 1. Then, $G$ is 3-colorable if and only if $G^{\prime}$ is 3-colorable.

Garey et al. [10, Theorems 2.1-2.3] proved that 3-Coloring is NP-hard on connected planar graphs of maximum vertex degree four. Dailey [5] proved that 3-Coloring remains NP-hard on connected 4-regular planar graphs. We are set to prove the main result of this section.

Proof of Theorem 1. Let $(G)$ with $G=(V, E)$ be an instance of 3-CoL on connected 4-regular planar graphs. Compute a 2 -factor $\mathcal{Q}$ of $G$ in polynomial time [8, 15]. If $\mathcal{Q}=\left\{Q_{1}\right\}$, then return $\left(G, Q_{1}\right)$. Otherwise, apply Construction 1 iteratively. In each iteration $i \geq 1$, we obtain an equivalent instance (Observation 2) and a 2-factor, say $\mathcal{Q}^{\prime}$, with $\left|\mathcal{Q}^{\prime}\right|=|\mathcal{Q}|-i$. Thus, after at most $n / 3$ steps [8], we obtain a graph $G^{\prime}$ and a Hamiltonian cycle $\mathcal{C}$ of $G^{\prime}$. Finally, return the instance ( $G^{\prime}, \mathcal{C}$ ).

In the next section, we prove that 3-Coloring is NP-hard on 5-regular planar Hamiltonian graphs. For this, we need an even input graph as we will connect disjoint pairs of vertices with some gadget. Building on Theorem 1, we prove that we can further turn a 4-regular planar Hamiltonian graph into an even 4-regular planar Hamiltonian graph.

Proposition 1. 3-Coloring is NP-hard on even 4-regular planar Hamiltonian graphs, even if a Hamiltonian cycle is given.

To prove Proposition 1, we will add a disjoint copy of the input graph to itself and connect the two graphs using two copies of the graph $W$ (see Figure 4(a)). The graph $W$ is inspired by a graph of Dailey [5, Fig. 3]. It is not difficult to see that following holds true for graph $W$.

Observation 3. Graph $W$ is 3-colorable, for every valid 3-coloring $f: V(W) \rightarrow\{1,2,3\}$, it holds true that $f(x)=f\left(x_{0}\right)=f\left(y_{0}\right)=f(y)$, and for every $c \in\{1,2,3\}$, there is a valid 3-coloring with $f(x)=c$.

Construction 2. Let $(G, C)$ be an instance of 3-Col on 4-regular planar Hamiltonian graphs with graph $G=(V, E)$ and Hamiltonian cycle $\mathcal{C}$. Construct a graph $G^{*}$ and a Hamiltonian cycle $H^{*}$ of $G^{*}$ as follows (see Figure 4 for an illustration). Take $G$ and a disjoint copy $G^{\prime}$ of $G$. Let $e=\{u, v\}$ be an edge in $\mathcal{C}$ of $G$, and let $e^{\prime}=\left\{u^{\prime}, v^{\prime}\right\}$ its copy in $G^{\prime}$. Let $G$ be embedded such that such that $e$ is incident with the outer face [1]. Let $G^{\prime}$ have the same embedding as $G$ but mirrored along the $y$-axis (see Figure 4(b); we assume such an embedding from now on). Connect the graphs $G$ and $G^{\prime}$ through the vertices $u, u^{\prime}, v, v^{\prime}$ as follows (see Figure 4(c)).

Add a copy of the graph $W$, and identify $x$ with $u$ (call the vertex again $u$ ) and $y$ with $u^{\prime}$ (call the vertex again $u^{\prime}$ ) and rename $x_{0}$ by $u_{0}$ and $y_{0}$ by $u_{0}^{\prime}$. Let $v, u_{1}, u_{2}, u_{3}$ be the neighbors of $u$ in clockwise order. Remove the edges $\left\{u, u_{2}\right\}$ and $\left\{u, u_{3}\right\}$, and add the edges $\left\{u_{0}, u_{2}\right\}$ and $\left\{u_{0}, u_{3}\right\}$. Let $v^{\prime}, u_{1}^{\prime}, u_{2}^{\prime}, u_{3}^{\prime}$ be the neighbors of $u^{\prime}$ in counter-clockwise order. Remove the edges $\left\{u^{\prime}, u_{2}^{\prime}\right\}$ and $\left\{u^{\prime}, u_{3}^{\prime}\right\}$, and add the edges $\left\{u_{0}^{\prime}, u_{2}^{\prime}\right\}$ and $\left\{u_{0}^{\prime}, u_{3}^{\prime}\right\}$.

Add another copy of the graph $W$, and identify $y$ with $v$ (call the vertex again $v$ ) and $x$ with $v^{\prime}$ (call the vertex again $v^{\prime}$ ) and rename $y_{0}$ by $v_{0}$ and $x_{0}$ by $v_{0}^{\prime}$. Let $u, v_{1}, v_{2}, v_{3}$ be the neighbors of $v$ in counter-clockwise order. Remove the edges $\left\{v, v_{2}\right\}$ and $\left\{v, v_{3}\right\}$, and add the

edges $\left\{v_{0}, v_{2}\right\}$ and $\left\{v_{0}, v_{3}\right\}$. Let $u^{\prime}, v_{1}^{\prime}, v_{2}^{\prime}, v_{3}^{\prime}$ be the neighbors of $v^{\prime}$ in clockwise order. Remove the edges $\left\{v^{\prime}, v_{2}^{\prime}\right\}$ and $\left\{v^{\prime}, v_{3}^{\prime}\right\}$, and add the edges $\left\{v_{0}^{\prime}, v_{2}^{\prime}\right\}$ and $\left\{v_{0}^{\prime}, v_{3}^{\prime}\right\}$.

We can merge $\mathcal{C}$ and $\mathcal{C}^{\prime}$ through the two added $W^{\prime}$ 's as depicted in Figure 4(c) to a Hamiltonian cycle $\mathcal{C}^{*}$ of $G^{*}$.

Proof of Proposition 1. Let $(G, C)$ be an instance of the NP-hard (Theorem 1) 3-CoL on 4regular planar Hamiltonian graphs with graph $G=(V, E)$ and Hamiltonian cycle $\mathcal{C}$. If $G$ is even, then we return $(G, \mathcal{C})$. Assume that $G$ is odd. Construct the graph $G^{*}$ with Hamilton cycle $H^{*}$ from $G$ using Construction 2. Clearly, $G^{*}$ is Hamiltonian, 4-regular, planar, and even (note that $\left|V\left(G^{*}\right)\right|=2|V(G)|+26$ ). Finally, due to Observation 3, we have that $G$ is 3-colorable if and only if $G^{*}$ is 3 -colorable.

### 3.2 5-regular planar Hamiltonian

In this section, we prove that 3-Coloring is also NP-hard on 5-regular planar Hamiltonian graphs with provided Hamiltonian cycle.

Theorem 2. 3-Coloring on 5-regular planar Hamiltonian graphs is NP-hard, even if a Hamiltonian cycle is given.

We will use multiple copies of the graph $D$ (see Figure 5) to turn a planar 4-regular Hamiltonian graph into a planar 5 -regular Hamiltonian graph. The graph $D$ is inspired by a graph of Dailey [5, Fig. 4]. We have the following.

Observation 4. Graph $D$ is 3-colorable and for every distinct $c, c^{\prime} \in\{1,2,3\}$, there is a valid 3-coloring $f: V(D) \rightarrow\{1,2,3\}$ with $f(x)=c$ and $f(y)=c^{\prime}$.

We will perform a series of $D$-insertions defined as follows.
Definition 2 ( $D$-insertion). Let $G$ be a graph and $\{v, u\} \in E(G)$. A $D$-insertion at $\{v, u\}$ results in the graph obtained from $G$ by adding a copy of $D$ to $G$, and identifying $x$ with $v$ and $y$ with $u$.

Proof of Theorem 2. Let $(G, \mathcal{C})$ be an instance of the NP-hard (Proposition 1) 3-Col on even 4regular planar Hamiltonian graphs with graph $G=(V, E)$ and Hamiltonian cycle $\mathcal{C}=\left(v_{1}, \ldots, v_{n}\right)$ of $G$. Construct a graph $G^{\prime}$ with Hamiltonian cycle $\mathcal{C}^{\prime}$ as follows (see Figure 6 for an illustration). For each $i \in\{1, \ldots, n / 2\}$, make a $D$-insertion at $\left\{v_{2 i-1}, v_{2 i}\right\}$. For $\mathcal{C}^{\prime}$, replace each edge $\left\{v_{2 i-1}, v_{2 i}\right\}$ by the $x-y$ Hamiltonian path through the $D$ inserted at $\left\{v_{2 i-1}, v_{2 i}\right\}$. Note that $G^{\prime}$ is 5-regular and planar. Finally, due to Observation 4, $G^{\prime}$ is 3 -colorable if and only if $G$ is 3 -colorable.

## 4 Regular Hamiltonian Graphs

In this section, we prove that 3-Coloring remains NP-hard on $p$-regular Hamiltonian graphs for every $p \in \mathbb{N}_{\geq 4}$.
Theorem 3. For every $p \in \mathbb{N}_{\geq 4}$, 3-Coloring on p-regular Hamiltonian graphs is NP-hard, even if a Hamiltonian cycle is provided.

Proof. We prove the statement via induction. Due to Theorems 1 and 2, we know that 3-Col is NP-hard on $p$-regular Hamiltonian graphs for $p \in\{4,5\}$. Assume that the statement is true for $p^{\prime} \in\{3,4, \ldots, p\}, p \in \mathbb{N}_{\geq 4}$. Let $(G, \mathcal{C})$ be an instance of the NP-hard (by induction) 3-CoL on $p$-regular Hamiltonian graphs with graph $G=(V, E)$ and Hamiltonian cycle $\mathcal{C}=\left(v_{0}, \ldots, v_{n-1}\right)$ of $G$, where $n=|V|$. We construct a graph $G^{*}$ from $G$ as follows (see Figure 7). Add a disjoint copy $G^{\prime}=\left(V^{\prime}, E^{\prime}\right)$ of $G$ to $G$. Denote the vertices of $G^{\prime}$ by $v_{0}^{\prime}, \ldots, v_{n-1}^{\prime}$, and the copy of $\mathcal{C}$ in $G^{\prime}$ by $\mathcal{C}^{\prime}$. Finally, add the edge set $\left\{\left\{v_{i}, v_{i+1 \bmod n}^{\prime}\right\} \mid i \in\{0, \ldots, n-1\}\right\}$. Observe that $G^{*}$ admits the following Hamiltonian cycle $\mathcal{C}^{*}=\left(v_{n-1}, v_{0}^{\prime}, v_{n-1}^{\prime}, \ldots, v_{1}^{\prime}, v_{0}, v_{1}, \ldots, v_{n-2}, v_{n-1}\right)$. Clearly, $G^{*}$ is $(p+1)$-regular. Moreover, since $G \subseteq G^{*}$, every valid 3 -coloring of $G^{*}$ induces a valid 3-coloring of $G$. We claim that if $G$ is 3 -colorable, then $G^{*}$ is 3 -colorable.

Let $f: V(G) \rightarrow\{1,2,3\}$ be a valid 3 -coloring of $G$. We claim that $f^{*}: V\left(G^{*}\right) \rightarrow\{1,2,3\}$ with $f^{*}\left(v_{i}\right)=f\left(v_{i}\right)$ and $f^{*}\left(v_{i}^{\prime}\right)=f\left(v_{i}\right)$ for all $i \in\{0, \ldots, n-1\}$ is a valid 3 -coloring of $G^{*}$. Clearly, for every $Z \in\left\{V, V^{\prime}\right\}$ and for every $\{v, w\} \in E\left(G^{*}\right) \cap\binom{Z}{2}$, we have $f^{*}(v) \neq f^{*}(w)$. Moreover, for each $i \in\{0, \ldots, n-1\}$, we have that $f^{*}\left(v_{i}\right) \neq f^{*}\left(v_{(i+1) \bmod n}\right)=f^{*}\left(v_{(i+1) \bmod n}^{\prime}\right)$, and thus each edge $\left\{v_{i}, v_{(i+1) \bmod n}^{\prime}\right\}$ has differently colored endpoints. It follows that $f^{*}$ is a valid 3 -coloring of $G^{*}$.

## 5 Ordered and Connected Hamiltonian Graphs

In this section, we prove 3-Coloring to remain NP-hard on $p$-ordered Hamiltonian graphs for every $p \geq 3$.

Theorem 4. 3-Coloring is NP-hard on p-ordered regular Hamiltonian graphs for every $p \in$ $\mathbb{N}_{\geq 3}$, even if a Hamiltonian cycle is given.

Every Hamiltonian graph is 3 -Hamiltonian-ordered and hence 3-ordered Hamiltonian. Starting from here, we will inductively prove Theorem 4. In each inductive step, we will construct a graph of connectivity high enough and employ the following.

Fact 1 ([2, 7]). If $G$ is $22 p$-connected graph for some $p \in \mathbb{N}_{\geq 3}$, then $G$ is $p$-ordered.

Construction 3 ( $q$-complete graph). Let $G=(V, E)$ and let $q \in \mathbb{N}$. Construct the $q$-complete graph $C_{q}(G)=\left(V_{q}, E_{q}\right)$ as follows (see Figure 8 for an illustration). Let $V_{q}:=V^{1} \uplus \cdots \uplus V^{q}$ where $V^{i}:=\left\{v^{i} \mid v \in V\right\}$ for all $i \in\{1, \ldots, q\}$. Let $E_{q}:=\bigcup_{i, j \in\{1, \ldots, q\}}\left\{\left\{u^{i}, v^{j}\right\} \mid\{u, v\} \in E\right\}$. $\diamond$

By construction, we have the following.
Observation 5. Let $q \in \mathbb{N}$. Then, $G$ is 3-colorable if and only if $C_{q}(G)$ is 3-colorable.
Moreover, the $q$-complete graph preserves Hamiltonicity.
Lemma 2. Let $q \in \mathbb{N}$. If $G$ admits a Hamiltonian cycle, then $C_{q}(G)$ admits a Hamiltonian cycle computable in polynomial time.

Proof. Let $\mathcal{C}=\left(v_{0}, \ldots, v_{n-1}, v_{0}\right)$ be a Hamiltonian cycle of $G$. Then

$$
\mathcal{C}_{q}:=\left(v_{0}^{1}, \ldots, v_{n-1}^{1}, v_{0}^{2}, \ldots, v_{n-1}^{2}, v_{0}^{3}, \ldots, \ldots, v_{n-1}^{q}, v_{0}^{1}\right)
$$

is a Hamiltonian cycle in $C_{q}(G)$.
Now we argue about the connectivity.
Lemma 3. Let $q \in \mathbb{N}$. If $G$ is $p$-ordered for some $p \in \mathbb{N}_{\geq 3}$, then $C_{q}(G)$ is $q(p-1)$-connected.
Proof. Let $G$ be $p$-ordered for some $p \in \mathbb{N}_{\geq 3}$. Let $v, w \in V$ be two arbitrary vertices of $G$ and let $x, y \in\{1, \ldots, q\}$ be arbitrary. Since $G$ is $p$-ordered, $G$ is $(p-1)$-connected [16], and thus there are $p-1$ mutually internally vertex-disjoint $v$ - $w$ paths $P_{1}, \ldots, P_{p-1}$. For all $i \in\{1, \ldots, p-1\}$ and $j \in\{1, \ldots, q\}$, let $P_{i}^{j}$ denote the copy of path $P_{i}$ in $G^{j}=\left(V^{J}, E^{j}\right)$. In each path $P_{i}^{j}$, replace $v^{j}$ with $v^{x}$ and $w^{j}$ with $w^{y}$. By this, we obtain $q(p-1)$ mutually internally vertexdisjoint $v^{x}-w^{x}$-paths. It follows that $C_{p}(G)$ is $q(p-1)$-connected [13].

We are set to prove the main result of this section.
Proof of Theorem 4. We prove the statement via induction on $p \in \mathbb{N}_{\geq 3}$. We know that 3-CoL is NP-hard on 3 -ordered regular Hamiltonian graphs with a Hamiltonian cycle provided. Let the statement hold true for all $p^{\prime} \in\{1, \ldots, p\}, p \in \mathbb{N}_{\geq 3}$. Let $(G, \mathcal{C})$ be an instance of the NPhard (by induction) 3 -CoL on $p$-ordered regular Hamiltonian graphs with Hamiltonian cycle $\mathcal{C}$. Let $q:=\lceil 22(p+1) /(p-1)\rceil$. Compute graph $G^{\prime}:=C_{q}(G)$ using Construction 3 in polynomial time. Clearly, $G^{\prime}$ is regular. Due to Observation 5, we know that $G$ is 3-colorable if and only if $G^{\prime}$ is 3 -colorable. Due to Lemma 2, $G^{\prime}$ is Hamiltonian and we can compute a Hamiltonian cycle $\mathcal{C}^{\prime}$ of $G^{\prime}$ in polynomial time. Finally, due to Lemma $3, G^{\prime}$ is $q(p-1) \geq 22(p+1)$-connected, and hence due to Fact $1, G^{\prime}$ is $(p+1)$-ordered.

## 6 Conclusion

3-Coloring remains NP-hard when requiring a Hamiltonian input graph and a witnessing Hamiltonian cycle in the input, even if the input graph is already restricted to 4- or 5-regular planar, to $p$-regular for any $p \geq 6$, or to $p$-ordered regular for any $p \geq 3$ graphs. We close with the following.

Question 1. Is 3-Coloring NP-hard on $p$-Hamiltonian-ordered graphs for every $p \geq 4$ ?
