# EQUIVARIANT APPROACH TO WEIGHTED PROJECTIVE CURVES

#### Abstract

We investigate group actions on the category of coherent sheaves over weighted projective lines. We show that the equivariant category with respect to certain finite group action is equivalent to the category of coherent sheaves over a weighted projective curve, where the genus of the underlying smooth projective curve and the weight data are given by explicit formulas. Moreover, we obtain a trichotomy result for all such equivariant relations.

This equivariant approach provides an effective way to investigate smooth projective curves via weighted projective lines. As an application, we give a description for the category of coherent sheaves over a hyperelliptic curve of arbitrary genus. Links to smooth projective curves of genus 2 and also to Arnold's exceptional unimodal singularities are also established.


## 1. Introduction

Weighted projective lines and their coherent sheaves categories are introduced by Geigle and Lenzing in [21], in order to give a geometric realization of canonical algebras in the sense of Ringel [42]. In [31] Lenzing showed that any weighted projective line (with little exceptions) can be viewed as an orbifold quotient of a compact Riemann surface with respect to a finite group action, and its category of coherent sheaves is equivalent to the category of equivariant sheaves on the associated Riemann surface. Accordingly, the study of weighted projective lines has a high contact surface with many mathematical subjects. Among the many related subjects we mention Lie theory [10, 13, 16, 44], automorphic forms [15, 25, $35,38,45]$, orbifolds [36, 37, 39, 43], and singularities [19, 22, 23, 27, 28, 30]. This latter aspect, in particular, includes the aspects of Arnold's strange duality [19, 20] and homological mirror symmetry [18, 47].

Let $\mathbf{k}$ be an algebraically closed field of characteristic zero. Let $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ denote the weighted projective line of weight type $\mathbf{p}=\left(p_{1}, p_{2}, \cdots, p_{t}\right)$ and parameter sequence $\boldsymbol{\lambda}=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{t}\right)$, where $p_{i}$ 's are integers at least 2 , and $\lambda_{i}$ 's are pairwise distinct points on the projective line $\mathbb{P}_{\mathbf{k}}^{1}$, normalized as $\lambda_{1}=\infty, \lambda_{2}=0$ and $\lambda_{3}=1$. According to the sign of the Euler characteristic, the weighted projective lines are divided into domestic, tubular and wild types. We recall that the Picard group of $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is naturally isomorphic to the rank-one abelian group $\mathbb{L}(\mathbf{p})$ on generators $\vec{x}_{1}, \vec{x}_{2}, \cdots, \vec{x}_{t}$ subject to the relations $p_{1} \vec{x}_{1}=p_{2} \vec{x}_{2}=\cdots=p_{t} \vec{x}_{t}:=\vec{c}$, where $\vec{c}$ is called the canonical element and $\vec{\omega}:=(t-2) \vec{c}-\sum_{i=1}^{t} \vec{x}_{i}$ is called the dualizing element of $\mathbb{L}(\mathbf{p})$.

Due to the work of Lenzing and Meltzer [33], the $\operatorname{group} \operatorname{Aut}\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ of automorphisms on the category of coherent sheaves over $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ has an explicit

[^0]description (see (4.3) below), which contains two fundamental parts: the geometric automorphisms $\operatorname{Aut}\left(\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ and the degree-shift automorphisms $\mathbb{L}(\mathbf{p})$.

The geometric automorphisms consist of automorphisms of $\mathbb{P}_{\mathbf{k}}^{1}$ that preserve weights, hence $\operatorname{Aut}\left(\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ is of finite when $t \geq 3$; in particular, it is trivial if $p_{i}$ 's are pairwise distinct. The associated geometric action on the category $\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ always fixes the structure sheaf and permute almost all the ordinary simple sheaves, while the degree-shift action always moves the structure sheaf and fix all the ordinary simple sheaves. On the other hand, the geometric action always yields weighted projective lines as quotient stacks, while the degree-shift action will achieve covering curves, including elliptic curves and other weighted projective curves (see Theorem 1.1 below).

In this paper we will focus on the degree-shift actions. Denote by $t \mathbb{L}(\mathbf{p})$ the torsion subgroup of $\mathbb{L}(\mathbf{p})$. For any subgroup $H$ of $t \mathbb{L}(\mathbf{p})$, the associated equivariant category will be denoted by $\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)^{H}$. The equivariantization with respect to certain $H$ has been considered in literature. In [4], the authors used $H=\mathbb{Z} \vec{\omega}$ to establish the relationship between tubular weighted projective lines and elliptic curves; compare [3, 21, 29, 40]. Explicit equivariant relations between distinct tubular weighted projective lines are established in [2] via $H=\mathbb{Z}(2 \vec{\omega})$ or $\mathbb{Z}(3 \vec{\omega})$. The authors in [5] introduced the notion of Cylic/Klein type for $H$ to characterize the equivariant relations between weighted projective lines of arbitrary types. In this paper, we will consider equivariantization with respect to arbitrary subgroup $H$ of $t \mathbb{L}(\mathbf{p})$. The main result is as follows:

Theorem 1.1. Let $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ be a weighted projective line and $H$ be a finite subgroup of $\mathbb{L}(\mathbf{p})$. Then

\begin{equation*}
\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)^{H} \xrightarrow{\sim} \operatorname{coh}-\mathbf{Y} \tag{1.1}
\end{equation*}
$$

for some weighted projective curve $\mathbf{Y}=\mathbb{Y}(\mathbf{q} ; \boldsymbol{\mu})$. More precisely,
(1) $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of domestic type if and only if $\mathbf{Y}$ is a weighted projective line of domestic type;
(2) $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of tubular type if and only if $\mathbf{Y}$ is a weighted projective line of tubular type or a smooth elliptic curve, according to $H \nsupseteq \mathbb{Z} \vec{\omega}$ or $H \supseteq \mathbb{Z} \vec{\omega}$ respectively;
(3) $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of wild type if and only if for all the other $\mathbf{Y}$ 's.

Moreover, such equivalences (1.1) for $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ being domestic type or tubular type are classified in Tables 1 and 2, where $\mathbb{E}(\lambda)$ is the smooth elliptic curve determined by the equation $y^{2} z=x(x-z)(x-\lambda z)$, $\omega$ satisfies $\omega^{2}-\omega+1=0, \Gamma(\lambda)=$ $\left\{\lambda, \frac{1}{\lambda}, 1-\lambda, \frac{1}{1-\lambda}, \frac{\lambda}{\lambda-1}, \frac{\lambda-1}{\lambda}\right\}$ and $i, j, k, l$ are pairwise distinct integers.

The classification result above relies on the following explicit formulas on the weight data $\mathbf{q}$ of the weighted projective curve $\mathbf{Y}=\mathbb{Y}(\mathbf{q} ; \boldsymbol{\mu})$ and the genus $g_{\mathbb{Y}}$ of the underlying smooth projective curve $\mathbb{Y}$.

Proposition 1.2. Keep the notations in Theorem 1.1. Let $\mathbf{p}=\left(p_{1}, p_{2}, \cdots, p_{t}\right)$. Assume $|H|=n$ and $H$ has a set of generators $\vec{y}_{i}=\sum_{j=1}^{t} a_{i j} \vec{x}_{j}+a_{i} \vec{c}$ for $1 \leq i \leq s$. Denote by g.c.d. $\left(a_{1 j}, a_{2 j}, \cdots, a_{s j}, p_{j}\right)=d_{j}$ and set $n_{j}=\frac{n d_{j}}{p_{j}}$ for each $1 \leq j \leq t$. Then

$$
g_{\mathbb{Y}}=\frac{n}{2} \sum_{j=1}^{t}\left(1-\frac{d_{j}}{p_{j}}\right)-n+1 \quad \text { and } \quad \mathbf{q}=(\underbrace{d_{1}, \cdots, d_{1}}_{n_{1} \text { times }}, \underbrace{d_{2}, \cdots, d_{2}}_{n_{2} \text { times }}, \cdots, \underbrace{d_{t}, \cdots, d_{t}}_{n_{t} \text { times }}) .
$$

The equivalence (1.1) provides a new way to investigate the category of coherent sheaves over smooth projective curves via weighted projective lines.

For any integer $g>0$, let $a_{1}, a_{2}, \cdots, a_{g}$ be pairwise distinct elements in $\mathbf{k} \backslash\{0,1\}$. Let $\mathbf{E}_{g}$ be the hyperelliptic curve of genus $g$ determined by the following equation:

$$
z^{2}=\left(y^{2}-x^{2}\right)\left(y^{2}-a_{1} x^{2}\right) \cdots\left(y^{2}-a_{g} x^{2}\right) .
$$

Proposition 1.3. (Proposition 5.5) Keep the notations as above. Let $\mathbf{p}=(2, \cdots, 2)$ ( $g+3$ times) and $\boldsymbol{\lambda}=\left(\infty, 0,1, a_{1}, \cdots, a_{g}\right)$. Then there exists an equivalence

$$
\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p}, \boldsymbol{\lambda})\right)^{H} \xrightarrow{\sim} \operatorname{coh}-\mathbf{E}_{g},
$$

where $H=\left\langle\vec{x}_{1}-\vec{x}_{2}, \delta_{g, \text { even }} \vec{x}_{2}+\sum_{i=3}^{g+3}(-1)^{i} \vec{x}_{i}\right\rangle \leq \mathbb{L}(\mathbf{p})$.
Moreover, we also classify the equivariant relations (1.1) for the following cases:
(i) $\mathbf{Y}$ is a smooth projective curve of genus 2 ; (see Table 3);
(ii) $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ 's are corresponding to Arnold's 14 exceptional unimodal singularities; (see Table 4).
The paper is organized as follows. In Section 2, we recall the definition of a group action on a category, where a kind of group action on a length category is discussed. We recall the axiomatic description for the category of coherent sheaves over a weighted projective curve in Section 3, and show that the axioms are preserved under certain group actions. In the main part Section 4, we investigate the group action on the category of coherent sheaves over weighted projective lines, and prove Theorem 1.1 and Proposition 1.2. Several applications to smooth projective curves of higher genus are given in the last Section 5 .

## 2. Group action on a category

In this section, we recall the definition of a group action on an abelian category. Moreover, an action on a tube is discussed in Proposition 2.1, which plays an important role in this paper.
2.1. Group action. In this section we recall the notions of a finite group action on a small abelian category; for more details we refer to $[8,11,17,41]$. Throughout the paper we always denote by $\mathcal{A}$ a small $\mathbf{k}$-linear abelian category.

Let $G$ be an arbitrary finite group. A k-linear action of $G$ on $\mathcal{A}$ consists of the date $\left\{F_{g}, \varepsilon_{g, h} \mid g, h \in G\right\}$, where each $F_{g}: \mathcal{A} \rightarrow \mathcal{A}$ is a $\mathbf{k}$-linear auto-equivalence and each $\varepsilon_{g, h}: F_{g} F_{h} \rightarrow F_{g h}$ is a natural isomorphism such that a 2-cocycle condition holds, that is, $\varepsilon_{g h, k} \circ \varepsilon_{g, h} F_{k}=\varepsilon_{g, h k} \circ F_{g} \varepsilon_{h, k}$ for all $g, h, k \in G$.

Let $\left\{F_{g}, \varepsilon_{g, h} \mid g, h \in G\right\}$ be a k-linear $G$-action on $\mathcal{A}$. A $G$-equivariant object in $\mathcal{A}$ is a pair $(X, \alpha)$, where $X$ is an object in $\mathcal{A}$ and $\alpha$ assigns for each $g \in G$ an isomorphism $\alpha_{g}: X \rightarrow F_{g} X$ subject to the relations

$$
\alpha_{g g^{\prime}}=\left(\varepsilon_{g, g^{\prime}}\right)_{X} \circ F_{g}\left(\alpha_{g^{\prime}}\right) \circ \alpha_{g} .
$$

A morphism $f:(X, \alpha) \rightarrow(Y, \beta)$ between two $G$-equivariant objects is a morphism $f: X \rightarrow Y$ in $\mathcal{A}$ such that $\beta_{g} \circ f=F_{g}(f) \circ \alpha_{g}$ for all $g \in G$. This gives rise to the equivariant category $\mathcal{A}^{G}$ of $G$-equivariant objects, which is again abelian. The process forming the equivariant category $\mathcal{A}^{G}$ is known as the equivariantization of $\mathcal{A}$ with respect to the group action.

We recall that the forgetful functor $U: \mathcal{A}^{G} \rightarrow \mathcal{A}$ is defined by $U(X, \alpha)=X$ and $U(f)=f$ for any $f:(X, \alpha) \rightarrow(Y, \beta)$. The induction functor $F$ is defined as follows: for an object $X$ in $\mathcal{A}$, set $F(X)=\left(\bigoplus_{h \in G} F_{h}(X), \varepsilon\right)$, where for each $g \in G$, the isomorphism $\varepsilon_{g}: \bigoplus_{h \in G} F_{h}(X) \rightarrow F_{g}\left(\bigoplus_{h \in G} F_{h}(X)\right)$ is diagonally induced by the isomorphism $\left(\varepsilon_{g, g^{-1} h}\right)_{X}^{-1}: F_{h}(X) \rightarrow F_{g}\left(F_{g^{-1} h}(X)\right)$. For each morphism $\theta: X \rightarrow Y$ in $\mathcal{A}, F(\theta)=\oplus_{h \in G} F_{h}(\theta): F(X) \rightarrow F(Y)$.

According to Proposition 4.12, Corollary 4.13 and Lemma 4.14 in [49], we know that both of the functors $F$ and $U$ are faithful and exact, and $(F, U),(U, F)$ form adjoint pairs; compare [41, Theorem 3.2].

A given $\mathbf{k}$-linear action $\left\{F_{g}, \varepsilon_{g, h} \mid g, h \in G\right\}$ is strict provided that each $F_{g}$ is an automorphism and each isomorphism $\varepsilon_{g, h}$ is the identity. Therefore, a strict action
coincides with a group homomorphism from $G$ to the $\mathbf{k}$-linear automorphism group of $\mathcal{A}$. In this paper, we always assume the group action is strict.
2.2. Serre duality. A Hom-finite $\mathbf{k}$-linear abelian category $\mathcal{A}$ is said to satisfy Serre duality if there exists an equivalence $\tau: \mathcal{A} \rightarrow \mathcal{A}$ with functorial k-linear isomorphisms

$$
\begin{equation*}
D \operatorname{Ext}_{\mathcal{A}}^{1}(X, Y) \cong \operatorname{Hom}_{\mathcal{A}}(Y, \tau X) \tag{2.1}
\end{equation*}
$$

for all $X, Y$ in $\mathcal{A}$, where $D=\operatorname{Hom}_{\mathbf{k}}(-, \mathbf{k})$ denotes the standard $\mathbf{k}$-duality. The self-equivalence functor $\tau$ is called Serre functor or Auslander-Reiten translation. Note that a Serre functor is k-linear and essentially unique provided it exists, this follows from Yoneda's lemma; see [6, Remark 2.4].
2.3. Length category and uniserial category. We recall from [9] basic facts on the length categories and uniserial categories.

Let $\mathcal{A}$ be an abelian category. An object $X$ of $\mathcal{A}$ has finite length if there exists a finite chain of subobjects $0=X_{0} \subseteq X_{1} \subseteq \cdots \subseteq X_{n-1} \subseteq X_{n}=X$ such that each quotient $X_{i} / X_{i-1}$ is a simple object. Such a chain is called a composition series of $X$. A composition series is not necessarily unique but its length is an invariant of $X$ by the Jordan-Hölder theorem; it is called the length of $X$ and is denoted by $l(X)$. Note that an object has finite length if and only if it is both artinian and noetherian (i.e. it satisfies the descending chain condition and ascending chain condition on subobjects, respectively).

According to the Krull-Remak-Schmidt theorem, every object of finite length decomposes essentially uniquely into a finite direct sum of indecomposable objects with local endomorphism rings. The objects of finite length form a (Serre) subcategory of $\mathcal{A}$ which is denote by $\mathcal{A}_{0}$. The abelian category $\mathcal{A}$ is called a length category if $\mathcal{A}=\mathcal{A}_{0}$.

Let $\mathcal{A}$ be a length category. An object $X$ is uniserial if it has a unique composition series. Note that any non-zero uniserial object is indecomposable. Moreover, subobjects and quotient objects of uniserial objects are uniserial. The length category $\mathcal{A}$ is called uniserial category provided that each indecomposable object is uniserial.
2.4. Group action on a tube. For any integer $p \geq 1$, denote by $\left(\mathcal{T}_{p}, \tau\right)$ (or just simplified $\mathcal{T}_{p}$ ) the stable tube of rank $p$, that is, the Auslander-Reiten quiver of $\mathcal{T}_{p}$ is of form $\mathbb{Z}_{\infty} /\left(\tau^{p}\right)$; see [46]. We consider a finite abelian group acting on $\mathcal{T}_{p}$.

Proposition 2.1. Let $G$ be a finite abelian group acting on a tube $\left(\mathcal{T}_{p}, \tau\right)$, i.e., there exists a group homomorphism $\varphi: G \rightarrow \operatorname{Aut}\left(\mathcal{T}_{p}\right)$. Assume $|G|=n$ and $\operatorname{Im}(\varphi)=\left\langle\tau^{k}\right\rangle$ for some minimal $1 \leq k \leq n$. Then we have an equivalence

$$
\begin{equation*}
\mathcal{T}_{p}^{G} \cong \underbrace{\mathcal{T}_{k} \times \cdots \times \mathcal{T}_{k}}_{\frac{n k}{p} \text { times }} \tag{2.2}
\end{equation*}
$$

Proof. Let $Q=\left(Q_{0}, Q_{1}\right)$ be a cyclic quiver with vertex set $Q_{0}=\overline{\mathbb{Z}}_{p}:=\{1,2, \cdots, p\}$ and arrow set $Q_{1}=\left\{\alpha_{i}: i \rightarrow i-1 \mid i \in Q_{0}\right\}$. Denote by rep $\mathbf{k}_{\mathbf{k}}^{\text {nil }} Q$ the category of nilpotent representations of $Q$ over $\mathbf{k}$. Then there is an equivalence

$$
\begin{equation*}
\operatorname{rep}_{\mathbf{k}}^{\text {nil }} Q \cong \mathcal{T}_{p} \tag{2.3}
\end{equation*}
$$

Hence, the group homomorphism $\varphi: G \rightarrow \operatorname{Aut}\left(\mathcal{T}_{p}\right)$ induces a group action of $G$ on $\operatorname{rep}_{\mathbf{k}}^{\text {nil }} Q$, which satisfies $g\left(\alpha_{i}\right)=\alpha_{g(i)}$ for any $g \in G$ and $i \in Q_{0}$.

Obviously, there is an induced $G$-action on the set $Q_{0}$. Denote by $O_{i}$ the $G$-orbit of $i \in Q_{0}$, and let $I$ be a set of representatives of the distinct orbit classes. Then we have $\left|O_{i}\right|=\frac{p}{k}$ and $Q_{0}=\bigcup_{i \in I} O_{i}$.

Denote by $G_{i}$ the stablizer group of $i \in Q_{0}$. Then we have $\left|G_{i}\right|=\frac{n k}{p}$. Since $G$ is abelian, $G_{i}$ has $\frac{n k}{p}$-many irreducible representations $\rho_{i u}$ 's for $0 \leq u \leq \frac{n k}{p}-1$ (each $\rho_{i u}$ has dimension 1), where we assume $\rho_{i 0}$ is the trivial representation.

We construct a quiver $Q_{G}=\left(Q_{G, 0}, Q_{G, 1}\right)$ as follows: the set of vertices

$$
Q_{G, 0}:=\bigcup_{i \in I}\{i\} \times \operatorname{irr}\left(G_{i}\right)
$$

the number of arrows from the vertices $\left(i, \rho_{i u}\right)$ to $\left(j, \rho_{j v}\right)$ equals to

$$
\left|\operatorname{Arr}\left(\left(i, \rho_{i u}\right),\left(j, \rho_{j v}\right)\right)\right|:= \begin{cases}1 & \text { if } u=v \text { and } j=i-1 \\ 0 & \text { if else } .\end{cases}
$$

It is easy to see that $Q_{G}$ is $\frac{n k}{p}$-copies of cyclic quivers with $k$ vertices. Hence

$$
\begin{equation*}
\operatorname{rep}_{\mathbf{k}}^{\mathrm{nil}} Q_{G} \cong \mathcal{T}_{k} \times \cdots \times \mathcal{T}_{k} \quad\left(\frac{n k}{p} \text { times }\right) \tag{2.4}
\end{equation*}
$$

Let $M_{i j}$ be the $\mathbf{k}$-vector space spanned by the arrows in $Q$ from $i$ to $j$, that is, $M_{i j}=\mathbf{k} \alpha_{i}$ for $j=i-1$ and zero otherwise. We may regard $M_{i j}$ as a $\mathbf{k}\left[G_{i} \cap G_{j}\right]-$ module by restricting the action of $G$. Recall that $g\left(\alpha_{i}\right)=\alpha_{g(i)}$ for any $g \in G$ and $i \in Q_{0}$. We have $M_{i j} \cong \rho_{i 0}$ for $j=i-1$ and zero otherwise. Hence,

$$
\operatorname{dim}_{\mathbf{k}} \operatorname{Hom}_{\mathbf{k}\left[G_{i} \cap G_{j}\right]}\left(\rho_{i u}, \rho_{j v} \otimes_{\mathbf{k}} M_{i j}\right)=\left|\operatorname{Arr}\left(\left(i, \rho_{i u}\right),\left(j, \rho_{j v}\right)\right)\right| .
$$

Denote by $(\mathbf{k} Q) G$ the skew group algebra of $\mathbf{k} Q$ by $G$. Combining with [12, Theorem 1] and [8, Example 2.6], we obtain

$$
(\bmod \mathbf{k} Q)^{G} \xrightarrow{\sim} \bmod ((\mathbf{k} Q) G) \xrightarrow{\sim} \bmod \mathbf{k} Q_{G} .
$$

It follows that

$$
\left(\operatorname{rep}_{\mathbf{k}} Q\right)^{G} \cong \operatorname{rep}_{\mathbf{k}} Q_{G}
$$

By considering their nilpotent counterparts, combing with (2.3) and (2.4), we obtain (2.2).

## 3. Weighted projective curves

A weighted projective curve or WPC for short, is a pair $\mathbf{X}=(\mathbb{X}, \omega)$ consisting of a smooth projective curve $\mathbb{X}$ and a function $\omega: \mathbb{X} \rightarrow \mathbb{N}_{\geq 1}$ such that $\omega(x)>1$ for only finitely many points. The points $\lambda_{1}, \lambda_{2}, \cdots, \lambda_{t}$ with $\omega\left(\lambda_{i}\right)>1$ are called weighted points, the other ones are called ordinary points, and $p_{i}=\omega\left(\lambda_{i}\right)(1 \leq i \leq t)$ are called the weights of $\mathbf{X}$. We often write $\mathbf{X}=\mathbb{X}(\mathbf{p} ; \boldsymbol{\lambda})$, where $\mathbf{p}=\left(p_{1}, p_{2}, \cdots, p_{t}\right)$ and $\boldsymbol{\lambda}=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{t}\right)$.

The orbifold Euler characteristic of $\mathbf{X}$ is

$$
\chi_{\mathbf{X}}:=\chi_{\mathbb{X}}-\sum_{i=1}^{t}\left(1-\frac{1}{p_{i}}\right),
$$

where $\chi_{\mathbb{X}}=2\left(1-g_{\mathbb{X}}\right)$ and $g_{\mathbb{X}}=\operatorname{dim}_{\mathbf{k}} \operatorname{Ext}^{1}\left(\mathcal{O}_{\mathbb{X}}, \mathcal{O}_{\mathbb{X}}\right)$.
The category of coherent sheaves coh- $\mathbf{X}$ is obtained from coh- $\mathbb{X}$ (the category of algebraic coherent sheaves on $\mathbb{X}$ ) by iteratively applying for each weighted point $\lambda_{i}$ the so-called $p_{i}$-cycle construction; see [28].
3.1. Axiomatic description of coh- $\mathbf{X}$ for WPCs. The category coh- $\mathbf{X}$ has an axiomatic description as below; see [26, 34].
(H1) $\mathcal{A}$ is a connected abelian $\mathbf{k}$-linear noetherian category;
(H2) $\mathcal{A}$ is Ext-finite, that is, all morphism and extensions spaces in $\mathcal{A}$ are finite dimensional $\mathbf{k}$-vector spaces;
(H 3) $\mathcal{A}$ satisfies Serre duality $D \operatorname{Ext}_{\mathcal{A}}^{1}(X, Y) \cong \operatorname{Hom}_{\mathcal{A}}(Y, \tau X)$, where $\tau$ is a selfequivalence of $\mathcal{A}$;
(H 4) $\mathcal{A}$ contains an object of infinite length;
(H5) each object in the quotient category $\mathcal{A} / \mathcal{A}_{0}$ has finite length;
(H6) $\mathcal{A}$ has infinitely many points.
Here, we recall from [34, Proposition 1.1] that under the assumption (H1) (H 5), the length subcategory $\mathcal{A}_{0}$ of $\mathcal{A}$ has the form $\coprod_{x \in C} \mathcal{U}_{x}$, where the members of $C$ are called points of $\mathcal{A}$, and each $\mathcal{U}_{x}$ is a connected uniserial length category of finite $\tau$-period. More precisely, each $\mathcal{U}_{x}$ is a tube $\mathcal{T}_{\omega(x)}$.

Proposition 3.1. [26] A small category is equivalent to a category of coherent sheaves on a weighted projective curve if and only if it satisfies $(\mathrm{H} 1)-(\mathrm{H} 6)$.
3.2. Group action preserves axioms for WPC. In this subsection, we show that the axioms (H1) - (H6) for WPC's are preserved under certain group actions. Therefore, the equivariantization with respect to certain group actions preserves the categories of coherent sheaves over weighted projective curves.

Theorem 3.2. Let $\mathbf{X}$ be a weighted projective curve and $G$ be a finite subgroup of Aut(coh-X). Then

$$
(\operatorname{coh}-\mathbf{X})^{G} \xrightarrow{\sim} \operatorname{coh}-\mathbf{Y}
$$

for some weighted projective curve $\mathbf{Y}$.
Proof. We denote by $\mathcal{A}:=$ coh- $\mathbf{X}$ throughout the proof. By Proposition 3.1, we know that $\mathcal{A}$ satisfies (H1)-(H6), and remain to prove so does $\mathcal{A}^{G}$.

In order to prove $\mathcal{A}^{G}$ satisfies (H1), the only non-trivial thing is to show that each object $(X, \alpha)$ in $\mathcal{A}^{G}$ is noetherian. For this we let

$$
\left(X^{1}, \alpha^{1}\right) \subseteq\left(X^{2}, \alpha^{2}\right) \subseteq \cdots \subseteq\left(X^{n}, \alpha^{n}\right) \subseteq \cdots
$$

be an ascending chain of subobjects of $(X, \alpha)$ in $\mathcal{A}^{G}$. Since the forgetful functor $U: \mathcal{A}^{G} \rightarrow \mathcal{A}$ is exact, we obtain an ascending chain $X^{1} \subseteq X^{2} \subseteq \cdots \subseteq X^{n} \subseteq \cdots$ of subobjects of $X$ in $\mathcal{A}$. By assumption $X$ is noetherian in $\mathcal{A}$, hence there exists some integer $m$, such that $X^{i}=X^{i+1}$ for any $i \geq m$. By the exactness of $U$ again we obtain $\left(X^{i}, \alpha^{i}\right)=\left(X^{i+1}, \alpha^{i+1}\right)$ for any $i \geq m$. That is, $(X, \alpha)$ is noetherian.

Recall that the forgetful functor $U: \mathcal{A}^{G} \rightarrow \mathcal{A}$ is faithful. We have

$$
\operatorname{Hom}_{\mathcal{A}^{G}}((X, \alpha),(Y, \beta)) \subseteq \operatorname{Hom}_{\mathcal{A}}(U(X, \alpha), U(Y, \beta))=\operatorname{Hom}_{\mathcal{A}}(X, Y)
$$

Then $\mathcal{A}$ is Hom-finite implies so is $\mathcal{A}^{G}$. Moreover, it follows from [6, Theorem 3.6] that $\mathcal{A}^{G}$ has Serre duality of the following form for any $(X, \alpha),(Y, \beta) \in \mathcal{A}^{G}$ :

$$
D \operatorname{Ext}_{\mathcal{A}^{G}}^{1}((X, \alpha),(Y, \beta)) \cong \operatorname{Hom}_{\mathcal{A}^{G}}\left((Y, \beta), \tau^{G}(X, \alpha)\right),
$$

where $\tau^{G}$ is an autoequivalence of $\mathcal{A}^{G}$. Then by [9, Proposition 1.8.1], $\mathcal{A}^{G}$ is hereditary, and then the Ext-finiteness follows. Thus $\mathcal{A}^{G}$ satisfies (H2) and (H3).

By assumption $\mathcal{A}$ contains a strict descending chain

$$
X_{1} \supset X_{2} \supset \cdots \supset X_{n} \cdots
$$

Since the induction functor $F: \mathcal{A} \rightarrow \mathcal{A}^{G}$ is exact, we obtain a descending chain

$$
\begin{equation*}
F\left(X_{1}\right) \supseteq F\left(X_{2}\right) \supseteq \cdots \supseteq F\left(X_{n}\right) \cdots \tag{3.1}
\end{equation*}
$$

We claim that the chain (3.1) is not stationary, which proves (H4). For contradiction, we assume there exists some $m \geq 1$, such that $F\left(X_{i}\right)=F\left(X_{i+1}\right)$ for any $i \geq m$. Then $U F\left(X_{i}\right)=U F\left(X_{i+1}\right)$, which follows that $X_{i}=X_{i+1}$, a contradiction.

We have shown that $\mathcal{A}^{G}$ satisfies (H 1) - (H 4). By using [34, Proposition 4.9], we know that $\mathcal{A}^{G}$ satisfies (H5) automatically.

Finally, we prove that $\mathcal{A}^{G}$ satisfies (H6). By assumption $G$ is a finite subgroup of $\operatorname{Aut}(\mathcal{A})$, hence each $g \in G$ defines an automorphism of $\mathcal{A}$, which restricts to an automorphism of $\mathcal{A}_{0}$. Recall that $\mathcal{A}_{0}=\coprod_{x \in C} \mathcal{U}_{x}$. Hence each $g \in G$ induces a
permutation of $C$. Since $G$ is finite, it follows that $\mathcal{A}^{G}$ has infinitely many points. This finishes the proof.

## 4. Weighted projective lines and proof of the main results

This section is devoted to proving Theorem 1.1 and Proposition 1.2. For these we need to recall the category of coherent sheaves over weighted projective lines in more details, including the structure of its automorphism group.
4.1. The string group $\mathbb{L}(\mathbf{p})$. Let $t \geq 0$ be an integer. Let $\mathbf{p}=\left(p_{1}, p_{2}, \cdots, p_{t}\right)$ be a sequence of integers with each $p_{i} \geq 2$. The string group $\mathbb{L}(\mathbf{p})$ of type $\mathbf{p}$ is an abelian group (written additively) on generators $\vec{x}_{1}, \vec{x}_{2}, \cdots, \vec{x}_{t}$, subject to the relations $p_{1} \vec{x}_{1}=p_{2} \vec{x}_{2}=\cdots=p_{t} \vec{x}_{t}$, where this common element is denoted by $\vec{c}$ and called the canonical element of $\mathbb{L}(\mathbf{p})$. The string group $\mathbb{L}(\mathbf{p})$ has rank one, where $\vec{c}$ has infinite order. There is an isomorphism of abelian groups

$$
\begin{equation*}
\mathbb{L}(\mathbf{p}) / \mathbb{Z} \vec{c} \xrightarrow{\sim} \prod_{i=1}^{t} \mathbb{Z} / p_{i} \mathbb{Z} \tag{4.1}
\end{equation*}
$$

sending $\vec{x}_{i}+\mathbb{Z} \vec{c}$ to the vector $(0, \cdots, 0, \overline{1}, 0, \cdots, 0)$ with $\overline{1}$ on the $i$-th component. Using (4.1), each element $\vec{x}$ in $\mathbb{L}(\mathbf{p})$ can be uniquely written in its normal form

$$
\begin{equation*}
\vec{x}=\sum_{i=1}^{t} l_{i} \vec{x}_{i}+l \vec{c} \tag{4.2}
\end{equation*}
$$

where $0 \leq l_{i} \leq p_{i}-1$ for $1 \leq i \leq t$ and $l \in \mathbb{Z}$.
The torsion subgroup $t \mathbb{L}(\mathbf{p})$ of $\mathbb{L}(\mathbf{p})$ consists of all the torsion elements $\vec{x}$ in $\mathbb{L}(\mathbf{p})$, i.e., $n \vec{x}=0$ for some nonzero integer $n$. Denote by $p=$ l.c.m. $\left(p_{1}, p_{2}, \cdots, p_{t}\right)$. There is a surjective group homomorphism $\delta: \mathbb{L}(\mathbf{p}) \rightarrow \mathbb{Z}$ given by $\delta\left(\vec{x}_{i}\right)=\frac{p}{p_{i}}$ for $1 \leq i \leq t$. The following description of the torsion group $t \mathbb{L}(\mathbf{p})$ plays an important role in this paper.

Lemma 4.1. Let $\mathbf{p}=\left(p_{1}, \cdots, p_{t}\right)$. Denote by $p=$ l.c.m. $\left(p_{1}, \cdots, p_{t}\right)$ and $d_{i j}=$ g.c.d. $\left(p_{i}, p_{j}\right)$ for any $1 \leq i \neq j \leq t$. Then the following hold:
(1) $\vec{x} \in t \mathbb{L}(\mathbf{p})$ if and only if $p \vec{x}=0$;
(2) there is an exact sequence $0 \rightarrow t \mathbb{L}(\mathbf{p}) \rightarrow \mathbb{L}(\mathbf{p}) \xrightarrow{\delta} \mathbb{Z} \rightarrow 0$;
(3) $|t \mathbb{L}(\mathbf{p})|=\frac{p_{1} p_{2} \cdots p_{t}}{p}$;
(4) $t \mathbb{L}(\mathbf{p})=\left\langle\left.\frac{p_{i}}{d_{i j}} \vec{x}_{i}-\frac{p_{j}}{d_{i j}} \vec{x}_{j} \right\rvert\, 1 \leq i<j \leq t\right\rangle$.

Proof. (1) and (2) are taken from [21, 1.2]. Consequently, there is an induced exact sequence

$$
0 \rightarrow t \mathbb{L}(\mathbf{p}) \rightarrow \mathbb{L}(\mathbf{p}) / \mathbb{Z} \vec{c} \stackrel{\delta}{\rightarrow} \mathbb{Z} / p \mathbb{Z} \rightarrow 0
$$

hence (3) follows from (4.1) immediately; compare [7].
In the following we prove (4). Denote by $H=\left\langle\left.\frac{p_{i}}{d_{i j}} \vec{x}_{i}-\frac{p_{j}}{d_{i j}} \vec{x}_{j} \right\rvert\, 1 \leq i<j \leq t\right\rangle$. It is obvious that $H \subseteq t \mathbb{L}(\mathbf{p})$. We will show $t \mathbb{L}(\mathbf{p}) \subseteq H$ by induction on $t$. If $t \leq 2$, it is trivial. We assume that $t>2$ from now on. Let $\mathbf{p}^{\prime}=\left(p_{1}, \cdots, p_{t-1}\right)$. We denote by $p^{\prime}=$ l.c.m. $\left(p_{1}, \cdots, p_{t-1}\right)$ and $d=$ g.c.d. $\left(p_{t}, p^{\prime}\right)$. Then clearly we have $p=\frac{p^{\prime} p_{t}}{d}$.

For any $\vec{x} \in t \mathbb{L}(\mathbf{p})$, we can write $\vec{x}=a \vec{x}_{t}+\vec{y}$ with $\vec{y} \in \mathbb{L}\left(\mathbf{p}^{\prime}\right)$. If $a=0$, then $\vec{x}=\vec{y} \in t \mathbb{L}\left(\mathbf{p}^{\prime}\right) \subseteq H$ by induction, we are done. We assume $1 \leq a \leq p_{t}-1$ in the following. By (1),

$$
0=p \vec{x}=\frac{p^{\prime} p_{t}}{d} \vec{x}=\frac{a p^{\prime} p_{t}}{d} \vec{x}_{t}+\frac{p^{\prime} p_{t}}{d} \vec{y}=\frac{a p^{\prime}}{d} \vec{c}+\frac{p_{t}}{d}\left(p^{\prime} \vec{y}\right) .
$$

Since $p^{\prime} \vec{y} \in \mathbb{Z} \vec{c}$, we have $\frac{p_{t}}{d} \left\lvert\, \frac{a p^{\prime}}{d}\right.$. Note that g.c.d. $\left(\frac{p_{t}}{d}, \frac{p^{\prime}}{d}\right)=1$, hence $\left.\frac{p_{t}}{d} \right\rvert\, a$, i.e., $p_{t} \mid d a$.

Write $d=\Pi_{j \in J} q_{j}^{l_{j}}$, where $q_{j}$ 's are pairwise distinct primes. For any $1 \leq i \leq t-1$, let $J_{i}=\left\{j \in J\left|q_{j}^{l_{j}}\right| p_{i}\right.$, and $q_{j}^{l_{j}} \nmid p_{k}$ for any $\left.k<i\right\}$ and take $d_{i}=\Pi_{j \in J_{i}} q_{j}^{l_{j}}$. Then $d_{i} \mid p_{i}$ and g.c.d. $\left(d_{i}, d_{j}\right)=1$ for $1 \leq i \neq j \leq t-1$, and $d=d_{1} d_{2} \cdots d_{t-1}$.

Since g.c.d. $\left(d_{i}, d_{j}\right)=1$, we have g.c.d. $\left(\frac{d}{d_{1}}, \frac{d}{d_{2}}, \cdots, \frac{d}{d_{t-1}}\right)=1$. It follows that there exist $u_{i}(1 \leq i \leq t-1)$ such that $\sum_{i=1}^{t-1} u_{i} \frac{d}{d_{i}}=1$. Let $\vec{y}_{0}=\sum_{i=1}^{t-1} u_{i} \frac{p_{i}}{d_{i}} \vec{x}_{i}$, then

$$
\vec{y}_{0}-\frac{p_{t}}{d} \vec{x}_{t}=\sum_{i=1}^{t-1} u_{i} \frac{p_{i}}{d_{i}} \vec{x}_{i}-\sum_{i=1}^{t-1} \frac{u_{i} d}{d_{i}} \cdot \frac{p_{t}}{d} \vec{x}_{t}=\sum_{i=1}^{t-1} \frac{u_{i} d_{i t}}{d_{i}}\left(\frac{p_{i}}{d_{i t}} \vec{x}_{i}-\frac{p_{t}}{d_{i t}} \vec{x}_{t}\right) \in H .
$$

Observe that $\vec{x}=-\frac{d a}{p_{t}}\left(\vec{y}_{0}-\frac{p_{t}}{d} \vec{x}_{t}\right)+\vec{z}$, where $\vec{z}=\vec{y}+\frac{d a}{p_{t}} \vec{y}_{0}$ (recall that $\left.p_{t} \mid d a\right)$. Therefore, $\vec{x} \in t \mathbb{L}(\mathbf{p})$ implies $\vec{z} \in t \mathbb{L}\left(\mathbf{p}^{\prime}\right)$. Then by induction we get $\vec{z} \in H$, which implies $\vec{x} \in H$. This finishes the proof.
4.2. Weighted projective lines. Let $\boldsymbol{\lambda}=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{t}\right)$ be a sequence of pairwise distinct points on the projective line $\mathbb{P}_{\mathbf{k}}^{1}$. Such a sequence can be normalized such that $\lambda_{1}=\infty, \lambda_{2}=0$ and $\lambda_{3}=1$. A weighted projective line $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ of weight type $\mathbf{p}$ and parameter sequence $\boldsymbol{\lambda}$ is obtained from $\mathbb{P}_{\mathbf{k}}^{1}$ by attaching the weight $p_{i}$ to each point $\lambda_{i}$ for $1 \leq i \leq t$. We will always assume $\boldsymbol{\lambda}$ is normalized in this paper unless stated otherwise, and simply write $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})=\mathbb{P}_{\mathbf{k}}^{\mathbf{1}}(\mathbf{p})$ for $t \leq 3$.

The homogeneous coordinate algebra $S(\mathbf{p} ; \boldsymbol{\lambda})$ of the weighted projective line $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is given by $\mathbf{k}\left[X_{1}, X_{2}, \cdots, X_{t}\right] / I$, where the ideal $I$ is generated by $X_{i}^{p_{i}}-$ $\left(X_{2}^{p_{2}}-\lambda_{i} X_{1}^{p_{1}}\right)$ for $3 \leq i \leq t$. We write $x_{i}=X_{i}+I$ in $S(\mathbf{p} ; \boldsymbol{\lambda})$. The algebra $S(\mathbf{p} ; \boldsymbol{\lambda})$ is $\mathbb{L}(\mathbf{p})$-graded by means of $\operatorname{deg}\left(x_{i}\right)=\vec{x}_{i}$.

We recall a more convenient description of the category coh- $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ of coherent sheaves over $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ via graded $S(\mathbf{p} ; \boldsymbol{\lambda})$-modules. Denote by $\bmod ^{\mathbb{L}(\mathbf{p})}-S(\mathbf{p} ; \boldsymbol{\lambda})$ the abelian category of finitely generated $\mathbb{L}(\mathbf{p})$-graded $S(\mathbf{p} ; \boldsymbol{\lambda})$-modules, and by $\bmod _{0}^{\mathbb{L}(\mathbf{p})}-S(\mathbf{p} ; \boldsymbol{\lambda})$ its Serre subcategory formed by finite dimensional modules. We denote the quotient abelian category by

$$
\operatorname{qmod}^{\mathbb{L}(\mathbf{p})}-S(\mathbf{p} ; \boldsymbol{\lambda}):=\frac{\bmod ^{\mathbb{L}(\mathbf{p})}-S(\mathbf{p} ; \boldsymbol{\lambda})}{\bmod _{0}^{\mathbb{L}(\mathbf{p})}-S(\mathbf{p} ; \boldsymbol{\lambda})}
$$

By [21, Theorem 1.8] the sheafification functor yields an equivalence

$$
\operatorname{qmod}^{\mathbb{L}(\mathbf{p})}-S(\mathbf{p} ; \boldsymbol{\lambda}) \xrightarrow{\sim} \operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda}) .
$$

From now on we will identify these two categories.
The Euler characteristic of a weighted projective line $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is defined as

$$
\chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}=2-\sum_{i=1}^{t}\left(1-\frac{1}{p_{i}}\right)=-\frac{\delta(\vec{\omega})}{p},
$$

where $\vec{\omega}=(t-2) \vec{c}-\sum_{i=1}^{t} \vec{x}_{i}$ is the dualizing element of $\mathbb{L}(\mathbf{p})$. The weighted projective line $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is called of domestic, tubular or wild type provided that $\chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}>0, \chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}=0$ or $\chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}<0$, respectively. More precisely, we have the following trichotomy according to the weight type $\mathbf{p}$ (up to permutation of weights):
(i) domestic type: ()$,\left(p_{1}\right),\left(p_{1}, p_{2}\right),\left(2,2, p_{3}\right),(2,3,3),(2,3,4)$ and $(2,3,5)$;
(ii) tubular type: $(2,2,2,2),(3,3,3),(4,4,2)$ and $(6,3,2)$;
(iii) wild type: all the other cases.
4.3. Automorphism group for weighted projective lines. The automorphism group $\operatorname{Aut}\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ of the category coh- $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ consists of isomorphism classes of $\mathbf{k}$-linear self-equivalences on coh- $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$. Let $\operatorname{Aut}\left(\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ be the subgroup of $\operatorname{Aut}\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ of automorphisms fixing the structure sheaf. By [33, Proposition
3.1] $\operatorname{Aut}\left(\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ is isomorphic to the subgroup of $\operatorname{PSL}(2, \mathbf{k})$ of automorphisms of $\mathbb{P}_{\mathbf{k}}^{1}$ preserving weights. If $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ has $t \geq 3$ exceptional points, $\operatorname{Aut}\left(\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ is finite since it is isomorphic to a subgroup of a direct product of some symmetric group by [33, Corollary 3.2]. In particular, if the weights $p_{1}, \cdots, p_{t}$ are pairwise distinct, then $\operatorname{Aut}\left(\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ is trivial.

We have the following description of the automorphism group Aut $\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ for a weighted projective line.

Proposition 4.2. [33, Theorem 3.4] There is a split-exact sequence

$$
\begin{equation*}
1 \rightarrow \mathbb{L}(\mathbf{p}) \rightarrow \operatorname{Aut}\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right) \rightarrow \operatorname{Aut}\left(\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right) \rightarrow 1 \tag{4.3}
\end{equation*}
$$

In particular,

$$
\operatorname{Aut}\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)=\mathbb{L}(\mathbf{p}) \rtimes \operatorname{Aut}\left(\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)
$$

The automorphisms from $\operatorname{Aut}\left(\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)$ or $\mathbb{L}(\mathbf{p})$ are called geometric automorphisms or degree-shift automorphisms respectively in this paper.
4.4. Proof of Theorem 1.1. According to Theorem 3.2, we know that $\mathbf{Y}$ is a weighted projective curve. In the following we assume $\mathbf{Y}=\mathbb{Y}(\mathbf{q} ; \boldsymbol{\mu})$ with $\mathbf{q}=$ $\left(q_{1}, q_{2}, \cdots, q_{t^{\prime}}\right)$.

Let $H^{*}$ be the character group of $H$. Since $H$ is commutative, by [3, Theorem 4.6] there exists an $H^{*}$-action on coh- $\mathbf{Y}$ with an equivalence

$$
(\operatorname{coh}-\mathbf{Y})^{H^{*}} \xrightarrow{\sim} \operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda}) .
$$

Moreover, by the definition of $H^{*}$-action on coh- $\mathbf{Y}$ (see [3, Section 4.3]), we know that $H^{*}$ fixes the structure sheaf of $\mathbf{Y}$, hence $H^{*}$ acts on the curve $\mathbf{Y}$ with a quotient stack $\mathbf{Y} / H^{*} \cong \mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$. Then by Theorem 2 and (2.3) in [31],

$$
\begin{equation*}
\left|H^{*}\right| \cdot \chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}=\chi_{\mathbf{Y}}=\chi_{\mathbb{Y}}-\sum_{i=1}^{t^{\prime}}\left(1-\frac{1}{q_{i}}\right)=2\left(1-g_{\mathbb{Y}}\right)-\sum_{i=1}^{t^{\prime}}\left(1-\frac{1}{q_{i}}\right) . \tag{4.4}
\end{equation*}
$$

Therefore, $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of domestic type, i.e., $\chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}>0$, if and only if $g_{\mathbb{Y}}=0$ and $\sum_{i=1}^{t^{\prime}}\left(1-\frac{1}{q_{i}}\right)<2$, or equivalently, $\mathbf{Y}$ is a weighted projective line of domestic type. $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of tubular type, i.e., $\chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}=0$, if and only if one of the following holds:

$$
\text { (i) } g_{\mathbb{Y}}=0 \text { and } \sum_{i=1}^{t^{\prime}}\left(1-\frac{1}{q_{i}}\right)=2 ; \quad \text { (ii) } g_{\mathbb{Y}}=1 \text { and } \sum_{i=1}^{t^{\prime}}\left(1-\frac{1}{q_{i}}\right)=0 .
$$

Hence $\mathbf{Y}$ is a weighted projective line of tubular type or a smooth elliptic curve respectively. $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of wild type if and only if $\chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}<0$, if and only if one of the following holds:

$$
\text { (i) } g_{\mathbb{Y}}=0 \text { and } \sum_{i=1}^{t^{\prime}}\left(1-\frac{1}{q_{i}}\right)>2 ; \quad \text { (ii) } g_{\mathbb{Y}}=1 \text { and } \sum_{i=1}^{t^{\prime}}\left(1-\frac{1}{q_{i}}\right)>0 ; \quad \text { (iii) } g_{\mathbb{Y}} \geq 2 .
$$

That is, $\mathbf{Y}$ is a weighted projective line of wild type, or a (non-trivial) weighted elliptic curve, or a weighted projective curve with $g_{\mathbb{Y}} \geq 2$ respectively. This proves the trichotomy result of Theorem 1.1.

Now we will classify all the curves $\mathbf{Y}=\mathbb{Y}(\mathbf{q} ; \boldsymbol{\mu})$ when $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of domestic type or of tubular type. By explicit description on the torsion group $t \mathbb{L}(\mathbf{p})$ in Lemma 4.1, we can obtain all the possibilities of $H \leq t \mathbb{L}(\mathbf{p})$ as listed in Tables 1 and 2. By using Proposition 1.2 we can obtain the data $g_{\mathbb{Y}}$ and $\mathbf{q}$ for each $H$. This already finishes the classification of $\mathbf{Y}$ 's when $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of domestic type, since domestic
weighted projective lines are determined by their weight data $\mathbf{p}$ (by normalization assumption on parameters $\boldsymbol{\lambda}$ ); compare with [5, Table 1].

If $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of tubular type, we still need to deal with the parameter $\boldsymbol{\mu}$ for $\mathbf{Y}=\mathbb{Y}(\mathbf{q} ; \boldsymbol{\mu})$. In this case, it is easy to check case by case that any finite subgroup $H$ of $\mathbb{L}(\mathbf{p})$ satisfies $H \supseteq \mathbb{Z} \vec{\omega}$ or $H$ is of Cyclic type or Klein type in the sense of [5]. According to the trichotomy result above and [5, Proposition 3.8], we know that $\mathbf{Y}=\mathbb{Y}(\mathbf{q} ; \boldsymbol{\mu})$ is an smooth elliptic curve for the first case, and $\mathbf{Y}$ is a weighted projective line of tubular type for the remaining two cases, where the parameter data has been determined by [5, Table 3].

For $H=\mathbb{Z} \vec{\omega}$, the parameter of $\mathbf{Y}=\mathbb{Y}(\mathbf{q} ; \boldsymbol{\mu})$ has been calculated by [4, Section 7]. To finish the proof we remain to determine $\boldsymbol{\mu}$ when $(\mathbf{p}, H)$ are given by the following:

$$
\begin{array}{ll}
\text { (i) }\left((2,2,2,2),\left\langle\vec{x}_{1}-\vec{x}_{2}, \vec{x}_{3}-\vec{x}_{4}\right\rangle\right), & \text { (ii) }((2,2,2,2), t \mathbb{L}(2,2,2,2)), \\
\text { (iii) }((4,4,2), t \mathbb{L}(4,4,2)), & \text { (iv) }((3,3,3), t \mathbb{L}(3,3,3)) .
\end{array}
$$

In the following we only consider the case (iv), since the other cases can be treated similarly.

Let $\mathbf{p}=(3,3,3)$ and $S(\mathbf{p})=\mathbf{k}\left[X_{1}, X_{2}, X_{3}\right] /(f)$, where $f=X_{1}^{3}-X_{2}^{3}+X_{3}^{3}$. Let $x_{i}=X_{i}+(f)$ in $S(\mathbf{p})$ for $i=1,2,3$. Recall that $S(\mathbf{p})$ is an $\mathbb{L}(\mathbf{p})$-graded algebra with $\operatorname{deg}\left(x_{i}\right)=\vec{x}_{i}$ for $i=1,2,3$. Note that $\mathbb{L}(\mathbf{p})=\mathbb{Z} \vec{x}_{1} \oplus t \mathbb{L}(\mathbf{p})$. Hence $\mathbb{L}(\mathbf{p}) / t \mathbb{L}(\mathbf{p}) \cong \mathbb{Z}$. We define a $\mathbb{Z}$-graded algebra $\overline{S(\mathbf{p})}$ as follows: as an ungraded algebra $\overline{S(\mathbf{p})}=S(\mathbf{p})$, while its homogeneous component is given by $\overline{S(\mathbf{p})}_{n}=\oplus_{\vec{y} \in t \mathbb{L}(\mathbf{p})} S(\mathbf{p})_{n \vec{x}_{1}+\vec{y}}$ for each $n \in \mathbb{Z}$. By [4, Proposition 5.2] we have an equivalence of categories

$$
\left(\bmod ^{\mathbb{L}(\mathbf{p})} S(\mathbf{p})\right)^{t \mathbb{L}(\mathbf{p})} \xrightarrow{\sim} \bmod ^{\mathbb{Z}} \overline{S(\mathbf{p})},
$$

which restricts to an equivalence $\left(\bmod _{0}^{\mathbb{L}(\mathbf{p})} S(\mathbf{p})\right)^{t \mathbb{L}(\mathbf{p})} \xrightarrow{\sim} \bmod _{0}^{\mathbb{Z}} \overline{S(\mathbf{p})}$ of full subcategories consisting of finite dimensional modules. Applying [4, Corollary 4.4] we have an equivalence of categories

$$
\begin{equation*}
\left(\operatorname{qmod}^{\mathbb{L}(\mathbf{p})} S(\mathbf{p})\right)^{t \mathbb{L}(\mathbf{p})} \xrightarrow{\sim} \operatorname{qmod}^{\mathbb{Z}} \overline{S(\mathbf{p})} . \tag{4.5}
\end{equation*}
$$

That is,

$$
\begin{equation*}
\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)^{t \mathbb{L}(\mathbf{p})} \xrightarrow{\sim} \text { coh- } \mathbf{E}, \tag{4.6}
\end{equation*}
$$

where $\mathbf{E}$ is an elliptic curve defined by the Fermat equation $x_{1}^{3}-x_{2}^{3}+x_{3}^{3}=0$.
It is well-known that the elliptic curve $\mathbf{E}$ has the normal form $y^{2}-y=x^{3}-7$ (c.f. [24, Example 2.5 in Section 1]), hence the $j$-invariant $j(\mathbf{E})=\mathbf{0}$. By assumption, $\omega^{2}-\omega+1=0$. We know that

$$
j(\mathbb{E}(\omega))=\frac{2^{8}\left(\omega^{2}-\omega+1\right)^{3}}{\omega^{2}(\omega-1)^{2}}=0
$$

It follows from $[24$, Proposition 1.5 in Section 4$]$ that $\mathbf{E} \cong \mathbb{E}(\mu)$ for any $\mu \in \Gamma(\omega)$. This finishes the proof.
4.5. Proof of Proposition 1.2. Let $\operatorname{coh}_{0}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})=\coprod_{x \in \mathbb{P}_{\mathbf{k}}^{1}} \mathcal{U}_{x}$, where each $\mathcal{U}_{\lambda_{i}}$ for $1 \leq i \leq t$ is a stable tube $\mathcal{T}_{p_{i}}$ of rank $p_{i}$, and other $\mathcal{U}_{x}$ 's are stable tubes of rank 1 . Note that the degree-shift action of $H$ on $\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ restricts to an $H$-action on $\mathcal{U}_{x}$ for each $x \in \mathbb{P}_{\mathbf{k}}^{1}$. That is, there exists a group homomorphism $\varphi_{x}: H \rightarrow \operatorname{Aut}\left(\mathcal{U}_{x}\right)$ for any $x$. For each exceptional point $\lambda_{j} \in \mathbb{P}_{\mathbf{k}}^{1}$, since g.c.d. $\left(a_{1 j}, a_{2 j}, \cdots, a_{s j}, p_{j}\right)=d_{j}$, we know that $d_{j}$ is the minimal positive integer such that $\operatorname{Im}\left(\varphi_{\lambda_{j}}\right)=\left\langle\tau^{d_{j}}\right\rangle$. Then by Proposition 2.1 we have an equivalence

$$
\left(\mathcal{U}_{\lambda_{j}}\right)^{H} \cong \underbrace{\mathcal{T}_{d_{j}} \times \cdots \times \mathcal{T}_{d_{j}}}_{n_{j} \text { times }} .
$$

Similarly, for any $x \notin\left\{\lambda_{1}, \lambda_{2}, \cdots, \lambda_{t}\right\},\left(\mathcal{U}_{x}\right)^{H}$ is equivalent to a product of stable tubes of rank 1. Hence

$$
\mathbf{q}=(\underbrace{d_{1}, \cdots, d_{1}}_{n_{1} \text { times }}, \underbrace{d_{2}, \cdots, d_{2}}_{n_{2} \text { times }}, \cdots, \underbrace{d_{t}, \cdots, d_{t}}_{n_{t} \text { times }}) .
$$

According to [31, Theorem 2], we obtain

$$
\chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}=\frac{\chi_{\mathbf{Y}}}{\left|H^{*}\right|}
$$

Recall that $\chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}=2-\sum_{j=1}^{t}\left(1-\frac{1}{p_{j}}\right)$. Moreover, by [31, (2.3)], we have

$$
\chi_{\mathbf{Y}}=2\left(1-g_{\mathbb{Y}}\right)-\sum_{j=1}^{t}\left(1-\frac{1}{d_{j}}\right) n_{j}=2\left(1-g_{\mathbb{Y}}\right)-n \sum_{j=1}^{t} \frac{d_{j}-1}{p_{j}} .
$$

It follows that

$$
g_{\mathbb{Y}}=\frac{n}{2} \sum_{j=1}^{t}\left(1-\frac{d_{j}}{p_{j}}\right)-n+1
$$

This finishes the proof of Proposition 1.2.

## 5. Applications

The equivalence (1.1) provides a new approach to investigate the category of coherent sheaves of weighted projective curves via that of weighted projective lines. In this section, we give some applications of (1.1) to hyperelliptic curves of arbitrary genus and smooth projective curves of genus two. Moreover, we also establish links to Arnold's exceptional unimodal singularities.
5.1. Weighted projective lines and smooth projective curves. The following result is an immediate consequence of Proposition 1.2, which gives a necessary and sufficient condition for $\mathbf{Y}$ being a smooth projective curve.
Corollary 5.1. Keep the notations and assumptions in Proposition 1.2. Then the following are equivalent:
(1) $\mathbf{Y}$ is a smooth projective curve;
(2) g.c.d. $\left(a_{1 j}, a_{2 j}, \cdots, a_{s j}, p_{j}\right)=1$ for each $1 \leq j \leq t$.

Proof. By Proposition 1.2, $\mathbf{Y}$ is a smooth projective curve if and only if $d_{j}=1$ for $1 \leq j \leq t$, if and only if g.c.d. $\left(a_{1 j}, a_{2 j}, \cdots, a_{s j}, p_{j}\right)=1$ for each $1 \leq j \leq t$.

Let $q$ be a prime number. For $a, r \in \mathbb{N}$, we introduce the notation $q^{a} \| r$ by means of $q^{a} \mid r$ but $q^{a+1} \nmid r$. For $\mathbf{p}=\left(p_{1}, p_{2}, \cdots, p_{t}\right)$, let $q^{b_{i}} \| p_{i}$ for each $1 \leq i \leq t$ and define

$$
\operatorname{index}_{q}(\mathbf{p}):=\left|\left\{i \mid b_{i}=\max \left\{b_{1}, \cdots, b_{t}\right\}\right\}\right|
$$

Obviously, if $q$ is not a factor of $p_{i}$ for any $1 \leq i \leq t$, then each $b_{i}=0$, hence $\operatorname{index}_{q}(\mathbf{p})=t$.

Proposition 5.2. Keep the notations and assumptions in Proposition 1.2. Then the following are equivalent:
(1) there exists $H \leq t \mathbb{L}(\mathbf{p})$ such that $\mathbf{Y}$ is a smooth projective curve;
(2) for each prime number $q$, $\operatorname{index}_{q}(\mathbf{p}) \geq 2$.

Proof. First, we assume the statement (1) is satisfied. Assume there exists a prime number $q$ such that $\operatorname{index}_{q}(\mathbf{p})=1$, i.e. there exists $k$ such that $b_{k}>b_{i}$ for each $i \neq k$. Denote $p=$ l.c.m. $\left(p_{1}, p_{2}, \cdots, p_{t}\right)$. Hence

$$
\begin{equation*}
q \nmid \frac{p}{p_{k}} \text { and } q \left\lvert\, \frac{p}{p_{i}}\right. \text { for each } i \neq k \text {. } \tag{5.1}
\end{equation*}
$$

For any $0 \neq \vec{y}=\sum_{i=1}^{t} a_{i} \vec{x}_{i}+a_{0} \vec{c} \in t \mathbb{L}(\mathbf{p})$ with $0 \leq a_{i}<p_{i}$, then $p \vec{y}=$ $\sum_{i=1}^{t} p a_{i} \vec{x}_{i}+p a_{0} \vec{c}=0$. Hence, $\sum_{i=1}^{t} \frac{a_{i} p^{2}}{p_{i}}+a_{0} p^{2}=0$. Let $q^{b} \| p$, thus by (5.1), $q^{b+1} \left\lvert\, \frac{a_{i} p^{2}}{p_{i}}\right.$ for each $i \neq k$ and $q^{b+1} \mid a_{0} p^{2}$. It follows that $q^{b+1} \left\lvert\, \frac{a_{k} p^{2}}{p_{k}}\right.$. Since $q^{b} \| p$ and $q \nmid \frac{p}{p_{k}}$, we have $q \mid a_{k}$.

Therefore, for any subgroup $H$ of $t \mathbb{L}(\mathbf{p})$ generated by $\vec{y}_{i}=\sum_{j=1}^{t} a_{i j} \vec{x}_{j}+a_{i} \vec{c}$ for $1 \leq i \leq s$, we have $q \mid$ g.c.d. $\left(a_{1 k}, a_{2 k}, \cdots, a_{s k}, p_{k}\right)$. This contradicts Corollary 5.1. Thus for each prime number $q$, index $_{q}(\mathbf{p}) \geq 2$.

Conversely, we assume (2) is satisfied. Fix $1 \leq j \leq t$, write $p_{j}=\prod_{i=1}^{m} q_{i}^{d_{i}}$, where $q_{i}$ 's are pairwise distinct primes. For any $1 \leq i \leq m$, since index $q_{q_{i}}(\mathbf{p}) \geq 2$, there exists some $k \neq j$ such that $q_{i}^{d_{i}} \mid p_{k}$. Set $\vec{y}_{i}=\frac{p_{j}}{q_{i}^{i}} \vec{x}_{j}-\frac{p_{k}}{q_{i}^{d_{i}}} \vec{x}_{k}$ and $a_{i j}=\frac{p_{j}}{q_{i}^{d_{i}}}$. Then $\vec{y}_{i} \in t \mathbb{L}(\mathbf{p})$ and $q_{i} \nmid a_{i j}$. It follows that g.c.d. $\left(a_{1 j}, a_{2 j}, \cdots, a_{m j}, p_{j}\right)=1$. By Corollary 5.1, there exists $H=t \mathbb{L}(\mathbf{p})$ such that $\mathbf{Y}$ is a smooth projective curve. This finishes the proof.

Example 5.3. Let $\mathbf{p}=(2,6,12)$. Then $2\|2,2\| 6,2^{2} \| 12$, hence index $_{2}(\mathbf{p})=1$. According to Proposition 5.2, there does not exist a subgroup $H \leq \mathbb{L}(\mathbf{p})$, such that

$$
\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)^{H} \xrightarrow{\sim} \operatorname{coh}-\mathbb{Y}
$$

for some smooth projective curve $\mathbb{Y}$.
Example 5.4. Let $\mathbf{p}=(4,6,12)$. Then $4=2^{2}, 6=2 \cdot 3,12=2^{2} \cdot 3$, hence $\operatorname{index}_{2}(\mathbf{p})=2$ and $\operatorname{index}_{3}(\mathbf{p})=2$. By Proposition 5.2, there exists $H \leq t \mathbb{L}(\mathbf{p})$ such that

$$
\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)^{H} \xrightarrow{\sim} \operatorname{coh}-\mathbb{Y}
$$

for some smooth projective curve $\mathbb{Y}$. In fact, we can take $H=t \mathbb{L}(\mathbf{p})$, then $\mathbb{Y}$ is a smooth projective curve of genus 7 by Proposition 1.2.
5.2. Relation to hyperelliptic curves of arbitrary genus. For any $g>0$, let $a_{1}, a_{2}, \cdots, a_{g}$ be pairwise distinct elements in $\mathbf{k} \backslash\{0,1\}$. Let $\mathbf{E}_{g}$ be the hyperelliptic curve of genus $g$ determined by the following equation:

$$
z^{2}=\left(y^{2}-x^{2}\right)\left(y^{2}-a_{1} x^{2}\right) \cdots\left(y^{2}-a_{g} x^{2}\right) .
$$

Proposition 5.5. Keep the notations as above. Let $\mathbf{p}=(\underbrace{2, \cdots, 2}_{g+3 \text { times }})$ and $\boldsymbol{\lambda}=$ $\left\{\infty, 0,1, a_{1}, \cdots, a_{g}\right\}$. Then there exists an equivalence

$$
\begin{equation*}
\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)^{H} \xrightarrow{\sim} \operatorname{coh}-\mathbf{E}_{g}, \tag{5.2}
\end{equation*}
$$

where $H=\left\langle\vec{x}_{1}-\vec{x}_{2}, \delta_{g, \text { even }} \vec{x}_{2}+\sum_{i=3}^{g+3}(-1)^{i} \vec{x}_{i}\right\rangle$.
Proof. Denote by $a_{0}=1$. Let $S=\mathbf{k}\left[X_{1}, X_{2}, \cdots, X_{g+3}\right] / I$, where $I=\left(X_{i}^{2}-X_{2}^{2}+\right.$ $\left.a_{i-3} X_{1}^{2} \mid i=3,4, \cdots, g+3\right)$. Denote by $x_{j}=X_{j}+I$ for $1 \leq j \leq g+3$. Then $S$ is an $\mathbb{L}(\mathbf{p})$-graded algebra with $\operatorname{deg}\left(x_{j}\right)=\vec{x}_{j}$ for any $j$. Let $H^{\prime}=\left\langle\vec{x}_{1}, \vec{x}_{2}, \sum_{i=3}^{t} \vec{x}_{i}\right\rangle$. By easy calculation we obtain that the restriction subalgebra $S_{H^{\prime}}$ is isomorphic to

$$
\mathbf{k}[u, v, w] /\left(w^{2}-\left(v^{2}-u^{2}\right)\left(v^{2}-a_{1} u^{2}\right) \cdots\left(v^{2}-a_{g} u^{2}\right)\right),
$$

which can be viewed as an $H^{\prime}$-graded algebra by defining $\operatorname{deg}(u)=\vec{x}_{1}, \operatorname{deg}(v)=$ $\vec{x}_{2}, \operatorname{deg}(w)=\sum_{i=3}^{t} \vec{x}_{i}$. Since $H^{\prime}$ is effective in the sense of [4, Definition 6.5], by [4, Proposition 6.6] we have

$$
\begin{equation*}
\operatorname{qmod}^{\mathbb{L}(\mathbf{p})} S \xrightarrow{\sim} \operatorname{qmod}^{H^{\prime}} S_{H^{\prime}} \tag{5.3}
\end{equation*}
$$

Observe that $H^{\prime}=\mathbb{Z} \vec{x}_{1} \oplus H$, hence $H^{\prime} / H \cong \mathbb{Z}$. We define a $\mathbb{Z}$-graded algebra $\overline{S_{H^{\prime}}}$ as follows: as an ungraded algebra $\overline{S_{H^{\prime}}}=S_{H^{\prime}}$, while its homogeneous component
is given by $\left(\overline{S_{H^{\prime}}}\right)_{n}=\oplus_{\vec{h} \in H}\left(S_{H^{\prime}}\right)_{n \vec{x}_{1}+\vec{h}}$ for each $n \in \mathbb{Z}$. By [4, Proposition 5.2] we have an equivalence of categories

$$
\left(\bmod ^{H^{\prime}} S_{H^{\prime}}\right)^{H} \xrightarrow{\sim} \bmod ^{\mathbb{Z}} \overline{S_{H^{\prime}}}
$$

which restricts to an equivalence $\left(\bmod _{0}^{H^{\prime}} S_{H^{\prime}}\right)^{H} \xrightarrow{\sim} \bmod _{0}^{\mathbb{Z}} \overline{S_{H^{\prime}}}$ of full subcategories consisting of finite dimensional modules. Applying [4, Corollary 4.4] we have an equivalence of categories

$$
\begin{equation*}
\left(\operatorname{qmod}^{H^{\prime}} S_{H^{\prime}}\right)^{H} \xrightarrow{\sim} \operatorname{qmod}^{\mathbb{Z}} \overline{S_{H^{\prime}}} \tag{5.4}
\end{equation*}
$$

Combining with (5.3) and (5.4) we have

$$
\left(\operatorname{qmod}^{\mathbb{L}(\mathbf{p})} S\right)^{H} \xrightarrow{\sim} \operatorname{qmod}^{\mathbb{Z}} \overline{S_{H^{\prime}}} .
$$

This proves (5.2).
5.3. Relation to smooth projective curves of genus 2. Recall that $\mathbf{p}=$ $\left(p_{1}, p_{2}, \cdots, p_{t}\right)$ and $\mathbb{L}(\mathbf{p})=\mathbb{Z} \vec{x}_{1} \oplus \cdots \oplus \mathbb{Z} \vec{x}_{t} /\left(p_{1} \vec{x}_{1}=p_{2} \vec{x}_{2}=\cdots=p_{t} \vec{x}_{t}:=\vec{c}\right)$. Let $\sigma$ be a permutation on $\{1,2, \cdots, t\}$ and $\mathbf{p}^{\sigma}:=\left(p_{\sigma(1)}, p_{\sigma(2)}, \cdots, p_{\sigma(t)}\right)$. Denote by $\mathbb{L}\left(\mathbf{p}^{\sigma}\right):=\mathbb{Z} \vec{y}_{1} \oplus \cdots \oplus \mathbb{Z} \vec{y}_{t} /\left(p_{\sigma(1)} \vec{y}_{1}=p_{\sigma(2)} \vec{y}_{2}=\cdots=p_{\sigma(t)} \vec{y}_{t}\right)$. Then there is a natural permutation isomorphism

$$
\pi_{\sigma}: \mathbb{L}(\mathbf{p}) \rightarrow \mathbb{L}\left(\mathbf{p}^{\sigma}\right) ; \vec{x}_{i} \mapsto \vec{y}_{\sigma^{-1}(i)} \text { for } 1 \leq i \leq t
$$

Proposition 5.6. Let $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ be a weighted projective line and $H$ be a finite subgroup of $\mathbb{L}(\mathbf{p})$. Assume

$$
\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)^{H} \xrightarrow{\sim} \operatorname{coh}-\mathbb{Y}
$$

for some smooth projective curve $\mathbb{Y}$ of genus 2. Then all the possibilities for $(\mathbf{p}, H)$ are classified in Table 3 (up to permutation isomorphisms).

Proof. Let $\mathbf{p}=\left(p_{1}, \cdots, p_{t}\right)$ and denote by $|H|=n$. Up to permutation isomorphisms we can assume $2 \leq p_{1} \leq p_{2} \leq \cdots \leq p_{t}$ without loss of generality. Since $\mathbb{Y}$ is smooth, by Corollary 5.1 and Proposition 1.2 we have $\frac{n}{p_{t}}=n_{t} \geq 1$, i.e. $p_{t} \leq n$.

According to [31, Theorem 2], we have

$$
2-\sum_{i=1}^{t}\left(1-\frac{1}{p_{i}}\right)=\chi_{\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})}=\frac{\chi_{\mathbb{Y}}}{n}=\frac{2\left(1-g_{\mathbb{Y}}\right)}{n}=-\frac{2}{n} .
$$

It follows that

$$
\begin{equation*}
t-2=\sum_{i=1}^{t} \frac{1}{p_{i}}+\frac{2}{n} \leq \frac{t+2}{p_{1}} . \tag{5.5}
\end{equation*}
$$

Then $p_{1} \geq 2$ implies $t \leq 6$. Moreover, by Theorem 1.1 we know that $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})$ is of wild type, hence $t \geq 3$.

For $t=6$, by (5.5) we have $4=\sum_{i=1}^{6} \frac{1}{p_{i}}+\frac{2}{n} \leq \frac{8}{p_{1}} \leq 4$, which forces $\mathbf{p}=$ $(2,2,2,2,2,2)$ and $n=2$. Assume $H=\langle\vec{y}\rangle$ with normal form $\vec{y}=\sum_{i=1}^{6} a_{i} \vec{x}_{i}+a \vec{c}$.
According to Corollary 5.1, we have g.c.d. $\left(a_{i}, p_{i}\right)=1$ for $1 \leq i \leq 6$, hence $a_{i}=1$ for any $i$. Now $n=2$ implies $a=-3$, that is, $H=\left\langle\sum_{i=1}^{6} \vec{x}_{i}-3 \vec{c}\right\rangle$.

For $t=5$, (5.5) reads $3=\sum_{i=1}^{5} \frac{1}{p_{i}}+\frac{2}{n} \leq \frac{7}{p_{1}}$. By similar arguments as above, we get $p_{i}=2$ for $1 \leq i \leq 4$ and $p_{5} \leq 3$. If $p_{5}=3$, we have $\operatorname{index}_{3}(\mathbf{p})=1$, contradicting to Proposition 5.2, hence $p_{5}=2$ and then $n=4$ follows. Note that each torsion element in $t \mathbb{L}(2,2,2,2,2)$ has order 2 . Hence $H$ has the form $H=\left\langle\vec{y}_{1}, \vec{y}_{2}\right\rangle$ with normal forms $\vec{y}_{k}=\sum_{i=1}^{5} a_{k i} \vec{x}_{i}+a_{k} \vec{c}$ for $k=1,2$. According to Corollary 5.1, we have g.c.d. $\left(a_{1 i}, a_{2 i}, p_{i}\right)=1$ for $1 \leq i \leq 5$, hence $\left(a_{1 i}, a_{2 i}\right) \neq(0,0)$ for any $i$. By the explicit description of torsion group $t \mathbb{L}(2,2,2,2,2)$, we obtain that $H=\left\langle\sum_{i=1}^{4} \vec{x}_{i}-2 \vec{c}, \vec{x}_{4}+\vec{x}_{5}-\vec{c}\right\rangle$, up to permutation isomorphisms.

For $t=4$, by (5.5) we have $2=\sum_{i=1}^{4} \frac{1}{p_{i}}+\frac{2}{n} \leq \frac{6}{p_{1}}$, hence $p_{1}=2$ or 3 . Combining with Proposition 5.2, by using $\operatorname{index}_{q}(\mathbf{p}) \geq 2$ for all prime number $q$, we obtain that there are only the following three cases for $\mathbf{p}$ :

$$
(i)(2,2,3,3), \quad(i i)(2,2,4,4), \quad(i i i)(3,3,3,3)
$$

It is easy to calculate that $n=6,4,3$ respectively. Now by using Corollary 5.1, we can derive the forms of $H$ as follows respectively:
$(i) t \mathbb{L}(2,2,3,3),($ ii $)\left\langle\vec{x}_{1}+\vec{x}_{2}+\vec{x}_{3}+3 \vec{x}_{4}-2 \vec{c}\right\rangle,(i i i)\left\langle\vec{x}_{1}+\vec{x}_{2}+2 \vec{x}_{3}+2 \vec{x}_{4}-2 \vec{c}\right\rangle$.
For $t=3$, (5.5) reads $1=\sum_{i=1}^{3} \frac{1}{p_{i}}+\frac{2}{n} \leq \frac{5}{p_{1}}$, hence $p_{1} \leq 5$. Combining with Proposition 5.2, by using $\operatorname{index}_{q}(\mathbf{p}) \geq 2$ for all prime number $q$, we obtain that there are only the following five cases for $\mathbf{p}$ :
(i) $(2,5,10)$,
(ii) $(2,6,6)$,
(iii) $(2,8,8)$,
(iv) $(3,6,6)$,
$(v)(5,5,5)$.

It is easy to see that $n=10,12,8,6,5$ respectively. According to Corollary 5.1, we can derive the forms of $H$ as follows respectively:
(i) $t \mathbb{L}(2,5,10)$,
(ii) $t \mathbb{L}(2,6,6)$,
(iii) $\left\langle\vec{x}_{1}+\vec{x}_{2}+3 \vec{x}_{3}-\vec{c}\right\rangle$,
(iv) $\left\langle\vec{x}_{1}+5 \vec{x}_{2}+5 \vec{x}_{3}-2 \vec{c}\right\rangle, \quad(v)\left\langle\vec{x}_{1}+\vec{x}_{2}+3 \vec{x}_{3}-\vec{c}\right\rangle$.

To sum up, we obtain Table 3.
5.4. Relation to Arnold's exceptional unimodal singularities. Arnold's exceptional unimodal singularities arise in the theory of singularities of differentiable maps [1], which are related to the mirror symmetry of K3 surfaces (see e.g. [14]), and have close relationship to automorphic forms and Fuchsian singularities (see e.g. $[27,32,15,18,48]$ ). There are 14 kinds of weighted projective lines associated to Arnold's 14 exceptional unimodal singularities. For these 14 cases, we have the following result.

Proposition 5.7. Let $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p})$ 's be the 14 weighted projective lines associated to Arnold's 14 exceptional unimodal singularities. Let $H$ be a finite subgroup of $\mathbb{L}(\mathbf{p})$. Then all the equivalences of the form

$$
\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p})\right)^{H} \xrightarrow{\sim} \operatorname{coh}-\mathbf{Y}
$$

are classified in Table 4 (up to permutation isomorphisms).

Proof. The weight types $\mathbf{p}$ 's of the weighted projective lines $\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p})$ 's associated to Arnold's 14 exceptional unimodal singularities are well-known; see e.g. [48, Table

1]. For such a weight type $\mathbf{p}$, it is easy to calculate the subgroup $H$ of $t \mathbb{L}(\mathbf{p})$ by the explicit description of the torsion group $t \mathbb{L}(\mathbf{p})$ in Lemma 4.1. Then for each $H$, by Theorem 1.1 we have an equivalence

$$
\begin{equation*}
\left(\operatorname{coh}-\mathbb{P}_{\mathbf{k}}^{1}(\mathbf{p} ; \boldsymbol{\lambda})\right)^{H} \xrightarrow{\sim} \operatorname{coh}-\mathbf{Y} \tag{5.6}
\end{equation*}
$$

for some weighted projective curve $\mathbf{Y}=\mathbb{Y}(\mathbf{q} ; \boldsymbol{\mu})$, where the weight type $\mathbf{q}$ and the genus $g_{\mathbb{Y}}$ can be calculated by Proposition 1.2. This finishes the proof.
