# CLASSIFICATION OF LEVI-SPHERICAL SCHUBERT VARIETIES 

YIBO GAO, REUVEN HODGES, AND ALEXANDER YONG


#### Abstract

A Schubert variety in the complete flag manifold $G L_{n} / B$ is Levi-spherical if the action of a Borel subgroup in a Levi subgroup of a standard parabolic has a dense orbit. We give a combinatorial classification of these Schubert varieties. This establishes a conjecture of the latter two authors, and a new formulation in terms of standard Coxeter elements. Our proof uses the theory of key polynomials (type $A$ Demazure module characters).


## 1. Introduction

This is a sequel to [HY20a], which studies Schubert varieties that are spherical for the action of a Levi subgroup. That paper defines the notion of a spherical element of a Coxeter group. For symmetric groups, it was conjectured [HY20a, Conjecture 3.2] that these elements characterize Levi-spherical Schubert varieties in the complete flag manifold $G L_{n} / B$. We prove this conjecture using a new, concise formulation of spherical elements in terms of standard Coxeter elements. This provides the first (proved) combinatorial characterizations of said geometric property for these Schubert varieties.
1.1. Main idea. Let $G=G L_{n}$. Its Weyl group $W \cong \mathfrak{S}_{n}$ consists of permutations of $[n]:=\{1,2, \ldots, n\}$. Thus $W$ is generated, as a Coxeter group, by the simple transpositions $S=\left\{s_{i}=(i i+1): 1 \leq i \leq n-1\right\}$. The set of left descents is

$$
J(w)=\left\{j \in[n-1]: w^{-1}(j)>w^{-1}(j+1)\right\}
$$

$(j \in J(w)$ if $j+1$ appears to the left of $j$ in $w$ 's one-line notation).
Let $\ell(w)$ denote the Coxeter length of $w$. For $w \in \mathfrak{S}_{n}$,

$$
\ell(w)=\#\{1 \leq i<j \leq n: w(i)>w(j)\}
$$

counts inversions of $w$.
A parabolic subgroup $W_{I}$ of $W$ is the subgroup generated by a subset $I \subset S$. A standard Coxeter element $c \in W_{I}$ is any product of the elements of $I$ listed in some order. Let $w_{0}(I)$ be the longest element of $W_{I}$.

Definition 1.1. Let $w \in W$ and fix $I \subseteq J(w)$. Then $w$ is $I$-spherical if $w_{0}(I) w$ is a standard Coxeter element for some parabolic subgroup $W_{I}$ of $W$.

Let $\operatorname{Red}(w)$ be the set of reduced expressions $w=s_{i_{1}} \cdots s_{i_{\ell(w)}}$. Let $D:=[n-1]-I=\left\{d_{1}<\right.$ $\left.d_{2}<\ldots<d_{k}\right\} ; d_{0}:=0, d_{k+1}:=n$. In [HY20a], another definition of $I$-spherical was given.

Definition 1.2 ([HY20a, Definition 3.1]). Let $w \in \mathfrak{S}_{n}$ and $I \subseteq J(w)$. Then $w$ is $I$-spherical if $R=s_{i_{1}} s_{i_{2}} \cdots s_{i_{\ell(w)}} \in \operatorname{Red}(w)$ exists such that
(S.1) $s_{d_{i}}$ appears at most once in $R$; and

(S.2) $\#\left\{m: d_{t-1}<i_{m}<d_{t}\right\}<\left({ }^{d_{t}-d_{t-1}+1}{ }_{2}\right)$ for $1 \leq t \leq k+1$.

Our starting point is the following result:
Theorem 1.3. Definitions 1.1] and 1.2 are equivalent.
1.2. Schubert geometry and the main result. Let $\operatorname{Flags}\left(\mathbb{C}^{n}\right)$ be the variety of complete flags $\langle 0\rangle \subset F_{1} \subset F_{2} \subset \cdots \subset F_{n-1} \subset \mathbb{C}^{n}$, where $F_{i}$ is a subspace of dimension $i$. The group $G L_{n}$ of invertible $n \times n$ matrices over $\mathbb{C}$ acts transitively on Flags $\left(\mathbb{C}^{n}\right)$ by change of basis. The standard flag is defined by $F_{i}=\operatorname{span}\left(\vec{e}_{1}, \vec{e}_{2}, \ldots, \vec{e}_{i}\right)$ where $\vec{e}_{i}$ is the $i$-th standard basis vector. The stabilizer of this flag is $B \subset G L_{n}$, the Borel subgroup of upper triangular invertible matrices. Hence Flags $\left(\mathbb{C}^{n}\right) \cong G L_{n} / B . B$ acts on $G L_{n} / B$ with finitely many orbits; these are the Schubert cells $X_{w}^{\circ}=B w B / B \cong \mathbb{C}^{\ell(w)}$ indexed by $w \in \mathfrak{S}_{n}$ (viewed as a permutation matrix). Their closures $X_{w}:=\overline{X_{w}^{\circ}}$ are the Schubert varieties; these are of interest in algebraic geometry and representation theory. A standard reference is [F97].

For $I \subseteq J(w)$, let $L_{I} \subseteq G L_{n}$ be the Levi subgroup of invertible block diagonal matrices

$$
L_{I} \cong G L_{d_{1}-d_{0}} \times G L_{d_{2}-d_{1}} \times \cdots \times G L_{d_{k}-d_{k-1}} \times G L_{d_{k+1}-d_{k}} .
$$

As explained in, e.g., HY20a, Section 1.2], $L_{I}$ acts on $X_{w}$.
Definition 1.4. $X_{w}$ is $L_{I}$-spherical if $X_{w}$ has a dense orbit of a Borel subgroup of $L_{I}$. If in addition, $I=J(w), X_{w}$ is maximally spherical.

Our main result is a classification of $L_{I}$-spherical Schubert varieties:
Theorem 1.5 ([HY20al, Conjecture 3.2]). Let $w \in \mathfrak{S}_{n}$ and $I \subseteq J(w) . X_{w} \subseteq G L_{n} / B$ is $L_{I^{-}}$ spherical if and only if $w$ is I-spherical.

Theorems 1.3 and 1.5 were used in C. Gaetz's [G21], which proves [HY20a, Conjecture 3.8]. Consequently, this gives a pattern avoidance criterion for maximally spherical Schubert varieties [G21, Theorem 1.4, Corollary 1.5]. We refer to [HY20a] for further references and background.
1.3. Organization. In Section 2 we prove Theorem 1.3; in the process, we establish a root-system uniform result (Proposition [2.6) that shows Definition 1.1] and Definition 2.1 from [HY20a] (a generalization of Definition 1.2) are, in some sense, "close". Section 3 introduces some notation and terminology about symmetric groups, Bruhat order, and a certain poset $\mathcal{S}_{I, \gamma}$ that we define. In Section 4 we recall notions about key polynomials, split-symmetry, and multiplicity-freeness from [HY20a]. This connects the Coxeter combinatorics to the geometry. Thereby, Theorem 1.5 is equivalent to Theorem 4.8 , the form we prove. In Section 5 we introduce a subposet $\mathcal{P}_{c \lambda, \gamma}$ of $\mathcal{S}_{I, \gamma}$ whose main feature is the "Diamond property" (Theorem [5.3). Assuming this property, we also prove the " $\Rightarrow$ " direction of Theorem 4.8. The central observation is that $\mathcal{P}_{c \lambda, \gamma}$ is poset isomorphic to an interval in the Bruhat order of a Young subgroup (Proposition 5.7). This permits us to reduce " $\Rightarrow$ " to basics about the Möbius function of Bruhat order [D77]. Theorem 5.3] is proved in Section 6. Finally, the " $\kappa$ " direction of Theorem 4.8 is established in Section 7 .

## 2. Proof of Theorem 1.3

We first derive some results valid for any finite crystallographic root system $\Phi$. Let the positive roots be $\Phi^{+}$, with simple roots $\Delta=\left\{\alpha_{1}, \ldots, \alpha_{r}\right\}$. Let $W$ be its finite Weyl
group with corresponding simple generators $S=\left\{s_{1}, s_{2}, \ldots, s_{r}\right\}$, where we have fixed a bijection of $[r]:=\{1,2, \ldots, r\}$ with the nodes of the Dynkin diagram $\mathcal{G}$. Let $\operatorname{Red}(w)$ be the set of the reduced expressions $w=s_{i_{1}} \cdots s_{i_{k}}$, where $k=\ell(w)$ is the Coxeter length of $w$. The left descents of $w$ are

$$
J(w)=\left\{j \in[r]: \ell\left(s_{j} w\right)<\ell(w)\right\} .
$$

For $I \in 2^{[r]}$, let $\mathcal{G}_{I}$ be the induced subdiagram of $\mathcal{G}$. Write

$$
\begin{equation*}
\mathcal{G}_{I}=\bigcup_{z=1}^{m} \mathcal{C}^{(z)} \tag{1}
\end{equation*}
$$

as its decomposition into connected components. Let $w_{0}^{(z)}$ be the longest element of the parabolic subgroup $W_{I^{(z)}}$ generated by $I^{(z)}=\left\{s_{j}: j \in \mathcal{C}^{(z)}\right\}$. The generalization of Definition 1.2 to general-type was given as follows:
Definition 2.1. Let $w \in W$ and fix $I \subset J(w)$. Then $w$ is $I$-spherical if there exists $R=$ $s_{i_{1}} \cdots s_{i_{\ell(w)}} \in \operatorname{Red}(w)$ such that

- $\#\left\{t \mid i_{t}=j\right\} \leq 1$ for all $j \in[r]-I$, and
- \#\{t|i $\left.i_{t} \in \mathcal{C}^{(z)}\right\} \leq \ell\left(w_{0}^{(z)}\right)+\# \operatorname{vertices}\left(\mathcal{C}^{(z)}\right)$ for $1 \leq z \leq m$.

Such an $R$ is called an $I$-witness.
Definition 1.1 makes sense in the general context as well. However, that notion differs from Definition 2.1 in type $D_{4}$ and $F_{4}$ (this reduces confidence in the general-type classification conjecture for Levi-spherical Schubert varieties [HY20a, Conjecture 1.9]). We plan to study this further in future work.

We now develop some preliminary results.
Lemma 2.2. Let $w \in W$ and fix $I \subset J(w)$. Let $R=s_{i_{1}} \cdots s_{i_{\ell(w)}}$ and $R^{\prime}=s_{j_{1}} \cdots s_{j_{\ell(w)}} \in \operatorname{Red}(w)$ be such that each $s_{t}, t \in[r]-I$, appears at most once in $R$, and at most once in $R^{\prime}$. Then for each $1 \leq z \leq m$,

$$
\#\left\{t \mid i_{t} \in \mathcal{C}^{(z)}\right\}=\#\left\{t \mid j_{t} \in \mathcal{C}^{(z)}\right\}
$$

Proof. We may assume without loss of generality that $\Phi$ is irreducible. Furthermore, we may assume without loss of generality that each $s_{i} \in S$ is used in any (equivalently, all) $R^{\prime \prime} \in \operatorname{Red}(w)$, since otherwise we work individually on the root systems associated to each irreducible component of $\Delta \backslash\left\{\alpha_{i}\right\}$.

We induct on $m \geq 1$. In the base case $m=1$, then

$$
\#\left\{t \mid i_{t} \in \mathcal{C}^{(1)}\right\}=\ell(w)-(r-\# I)
$$

is independent of any choice of $R^{\prime \prime}$, so we are done.
For the induction step, consider a fixed $\mathcal{C} \in\left\{\mathcal{C}^{(1)}, \ldots, \mathcal{C}^{(m)}\right\}$. Fix some $t_{0} \in[r]-I$ such that not all of $\mathcal{C}^{(1)}, \ldots, \mathcal{C}^{(m)}$ lie in the same connected component of (the Dynkin diagram of) $S \backslash\left\{t_{0}\right\}$. Such $t_{0}$ can be chosen because $m \geq 2$ and that the Dynkin diagram for $W$ is a tree. Let $J_{1}, J_{2}, \ldots, J_{p}$ be the connected components of $S \backslash\left\{t_{0}\right\}$ and assume $\mathcal{C} \subset J_{1}$.

Note that generators in different $J_{i}$ 's commute with each other. For the reduced word $R$, we can regroup it as $w_{J_{1}} \cdots w_{J_{p}} s_{t_{0}} u_{J_{1}} \cdots u_{J_{p}}$ where $w_{J_{i}}, u_{J_{i}} \in W_{J_{i}}$, the parabolic subgroup generated by $J_{i}$. We can rearrange it as

$$
w=\left(w_{J_{2}} \cdots w_{J_{p}}\right)\left(w_{J_{1}} s_{t_{0}} u_{J_{1}}\right)\left(u_{J_{2}} \cdots u_{J_{p}}\right) .
$$

Similarly, for $R^{\prime}$ we obtain

$$
\begin{aligned}
w & =w_{J_{1}}^{\prime} \cdots w_{J_{p}}^{\prime} s_{t_{0}} u_{J_{1}}^{\prime} \cdots u_{J_{p}}^{\prime} \\
& =\left(w_{J_{2}}^{\prime} \cdots w_{J_{p}}^{\prime}\right)\left(w_{J_{1}}^{\prime} s_{t_{0}} u_{J_{1}}^{\prime}\right)\left(u_{J_{2}}^{\prime} \cdots u_{J_{p}}^{\prime}\right) .
\end{aligned}
$$

Since $w_{J_{1}} s_{t_{0}} u_{J_{1}}$ does not contain any simple generators associated to $K=J_{2} \cup \cdots \cup J_{p}$, it is the unique minimal double coset representative of $W_{K} w W_{K}$. This implies that $w_{J_{1}} s_{t_{0}} u_{J_{1}}=$ $w_{J_{1}}^{\prime} s_{t_{0}} u_{J_{1}}^{\prime}$, where we obtained the same Weyl group element from different reduced decompositions.

Now apply the induction hypothesis by replacing $S$ by $J_{1} \cup\left\{t_{0}\right\}, I$ by $I \cap J_{1} \cup\left\{t_{0}\right\}, w$ by the minimal length coset representative of $W_{K} w W_{K}, R$ (and $R^{\prime}$ ) by the subword of $R$ (and $R^{\prime}$ ) that equals $w_{J_{1}} s_{t_{0}} u_{J_{1}}=w_{J_{1}}^{\prime} s_{t_{0}} u_{J_{1}}^{\prime}$, and leaving $\mathcal{C}$ unchanged.

For each $\alpha \in \Phi^{+}$, define its support to be

$$
\operatorname{Supp}(\alpha)=\left\{\alpha_{i} \in \Delta \mid \alpha-\alpha_{i} \text { is a nonnegative linear combination of } \Delta\right\}
$$

Also, for each positive root $\alpha=\sum_{i=1}^{r} c_{i} \alpha_{i}$, written as a nonnegative linear combination of $\Delta$, define its height to be ht $(\alpha)=\sum_{i=1}^{r} c_{i}$. The next folklore result is well-known, but we do not know a precise reference with proof. We include one here:
Lemma 2.3. For each $\alpha \in \Phi^{+}, \operatorname{Supp}(\alpha)$ is a connected subgraph in the Dynkin diagram.
Proof. We use induction on $\operatorname{ht}(\alpha)$. The base case $\operatorname{ht}(\alpha)=1$, i.e., $\alpha \in \Delta$, is clear.
In the induction step, for each $\alpha \in \Phi^{+} \backslash \Delta$, there exists $i \in[r]$ such that $\alpha^{\prime}:=s_{i} \alpha=$ $\alpha-k \alpha_{i} \in \Phi^{+}$for some positive integer $k$. We know that $\operatorname{ht}\left(\alpha^{\prime}\right)<\operatorname{ht}(\alpha)$ so $\operatorname{Supp}\left(\alpha^{\prime}\right)$ is connected by induction hypothesis. At the same time, $\operatorname{Supp}(\alpha)=\operatorname{Supp}\left(\alpha^{\prime}\right) \cup\left\{\alpha_{i}\right\}$. If $\alpha_{i} \in \operatorname{Supp}\left(\alpha^{\prime}\right)$, then $\operatorname{Supp}(\alpha)=\operatorname{Supp}\left(\alpha^{\prime}\right)$ is connected. Thus, we assume $\alpha_{i} \notin \operatorname{Supp}\left(\alpha^{\prime}\right)$. Let $\langle-,-\rangle$ denote the standard inner product on the ambient vector space containing our root system. We have

$$
\alpha=s_{i} \alpha^{\prime}=\alpha^{\prime}-\frac{2\left\langle\alpha^{\prime}, \alpha_{i}\right\rangle}{\left\langle\alpha_{i}, \alpha_{i}\right\rangle} \alpha_{i} \neq \alpha^{\prime} .
$$

As $\left\langle\alpha^{\prime}, \alpha_{i}\right\rangle \neq 0$, there exists some $\alpha_{j} \in \operatorname{Supp}\left(\alpha^{\prime}\right)$ such that $\left\langle\alpha_{j}, \alpha_{i}\right\rangle \neq 0$, meaning that the node $j$ is connected to the node $i$ in the Dynkin diagram. Therefore, $\operatorname{Supp}(\alpha)=\operatorname{Supp}\left(\alpha^{\prime}\right) \cup$ $\left\{\alpha_{i}\right\}$ is connected.
Lemma 2.4. Suppose that we have an equality of reduced words $s_{i_{1}} s_{i_{2}} \cdots s_{i_{k-1}}=s_{i_{2}} s_{i_{3}} \cdots s_{i_{k}}$. Then $\#\left\{t \mid i_{t}=j\right\} \geq 2$ for all $j$ on the path (excluding $i_{1}$ and $i_{k}$ ) between $i_{1}$ and $i_{k}$ in $\mathcal{G}$.

Proof. Let $w=s_{i_{1}} s_{i_{2}} \cdots s_{i_{k-1}}=s_{i_{2}} s_{i_{3}} \cdots s_{i_{k}}$. As $s_{i_{2}} \cdots s_{i_{k}}$ is reduced, $\alpha_{i_{k}}$ is a right inversion of $w$, where $\alpha_{i_{k}}$ is the simple root corresponding to $s_{i_{k}}$, i.e., $\alpha_{i_{k}} \in \Phi^{+}$and $w \alpha_{i_{k}} \in \Phi^{-}$. Let $-\beta=w \alpha_{i_{k}}$ so $\beta \in \Phi^{+}$. We have that

$$
\beta=-s_{i_{2}} \cdots s_{i_{k}} \alpha_{i_{k}}=-s_{i_{2}} \cdots s_{i_{k-1}}\left(-\alpha_{i_{k}}\right)=s_{i_{2}} \cdots s_{i_{k-1}} \alpha_{i_{k}} .
$$

This means that $s_{i_{1}} \beta=w \alpha_{i_{k}}=-\beta$ so $\beta=\alpha_{i_{1}}$.
Note that since $s_{i_{j}} \cdots s_{i_{k}}$ is reduced and has $\alpha_{i_{k}}$ as its right descent, we know

$$
s_{i_{j}} \cdots s_{i_{k-1}} s_{i_{k}} \alpha_{i_{k}} \in \Phi^{-}, s_{i_{j}} \cdots s_{i_{k-1}} \alpha_{i_{k}} \in \Phi^{+}
$$

Consider the sequence of positive roots

$$
\alpha_{i_{k}}, s_{i_{k-1}} \alpha_{i_{k}}, \ldots, s_{i_{2}} \cdots s_{i_{k-1}} \alpha_{i_{k}}=\alpha_{i_{1}}
$$

By definition, $s_{\alpha}(x)=x-\frac{2\langle x, \alpha\rangle}{\langle\alpha, \alpha\rangle} \alpha$. Hence the symmetric difference

$$
\operatorname{Supp}\left(s_{i_{t}} \cdots s_{i_{k-1}} \alpha_{i_{k}}\right) \Delta \operatorname{Supp}\left(s_{i_{t+1}} \cdots s_{i_{k-1}} \alpha_{i_{k}}\right) \subseteq\left\{\alpha_{i_{t}}\right\}, \text { for } t=k-1, \ldots, 2
$$

Recall that for each $\alpha \in \Phi^{+}$, its support $\operatorname{Supp}(\alpha)$ is connected in the Dynkin diagram (Lemma 2.3). Fix any $j$ on the path between $i_{1}$ and $i_{k}$ in the Dynkin diagram. As a result, there exists some $p$ such that $\alpha_{j} \in \operatorname{Supp}\left(s_{i_{p}} \cdots s_{i_{k-1}} \alpha_{i_{k}}\right)$. Thus, there must be some $s_{j}$ among $s_{i_{p}}, \ldots, s_{i_{k-1}}$ so that a positive multiple of $\alpha_{j}$ can be added from $\alpha_{i_{k}}$, and there must be some $s_{j}$ among $s_{i_{2}}, \ldots, s_{i_{p-1}}$ so that a positive multiple of $\alpha_{j}$ can be subtracted to obtain $\alpha_{i_{1}}$.

We use this textbook result:
Proposition 2.5 (Deletion property [BB05, Proposition 1.4.7]). Let $w=s_{i_{1}} \cdots s_{i_{\ell}}$ be a reduced word. Then for a left descent $s_{i_{0}}$ of $w$, i.e. $\ell\left(s_{i_{0}} w\right)=\ell(w)-1$, we have another reduced word $w=s_{i_{0}} s_{i_{1}} \cdots \widehat{s_{i_{j}}} \cdots s_{i_{\ell}}$, where $\widehat{s_{i_{j}}}$ means the deletion of $s_{i_{j}}$.

The culmination of the above root-system uniform arguments is this next proposition, which says that Definition 2.1 is, in general, "close" to Definition 1.1.
Proposition 2.6. If $w \in W$ is I-spherical (in the sense of Definition [2.1), then there exists an $I$-witness $R$ of $w$ of the form $R=R^{\prime} R^{\prime \prime}$ where $R^{\prime} \in \operatorname{Red}\left(w_{0}(I)\right)$ and $R^{\prime \prime} \in \operatorname{Red}\left(w_{0}(I) w\right)$.

Proof. Let $R^{(0)}=s_{i_{1}} \cdots s_{i_{\ell}}$ be an $I$-witness of $w$. Pick any $R^{\prime}=s_{k_{1}} \cdots s_{k_{\ell^{\prime}}} \in \operatorname{Red}\left(w_{0}(I)\right)$. We gradually modify $R^{(0)}$, so that at each step it remains an $I$-witness, until it is of the desired form. For each $j=\ell^{\prime}, \ldots, 1$, add $s_{k_{j}}$ to the start of $R$. By the deletion property (Proposition 2.5), some $s_{i_{j^{\prime}}}$ is deleted resulting in $R^{(1)} \in \operatorname{Red}(w)$. By Lemma 2.4, $k_{j}$ and $i_{j^{\prime}}$ must be in the same $\mathcal{C}^{(z)}$ since otherwise, some $s_{i}$ with $i \notin I$ on the path from $k_{j}$ to $i_{j^{\prime}}$ in the Dynkin diagram is used at least twice in $R^{(0)}$, contradicting that $R^{(0)}$ is an $I$-witness. Thus, in $R^{(1)}, \#\left\{t \mid i_{t} \in \mathcal{C}^{(z)}\right\}$ remains unchanged for each $z$. Repeating this, $k_{\ell^{\prime}}$ many times, we obtain an $I$-witness $R^{\left(k_{\ell^{\prime}}\right)}=R^{\prime} R^{\prime \prime}$, as claimed.

Henceforth, we assume that $W=\mathfrak{S}_{n}$. Recall that $w \in \mathfrak{S}_{n}$ contains the pattern $u \in \mathfrak{S}_{k}$ if there exists $i_{1}<i_{2}<\ldots<i_{k}$ such that $w\left(i_{1}\right), w\left(i_{2}\right), \ldots, w\left(i_{k}\right)$ is in the same relative order as $u(1), u(2), \ldots, u(k)$. Furthermore $w$ avoids $u$ if no such indices exist.

We need the following proposition relating pattern avoidance and standard Coxeter elements. A more general statement for finite Weyl groups can be found in [GH20].

Proposition 2.7 ([T07]). A permutation $w \in \mathfrak{S}_{n}$ is a product of distinct generators, i.e., a standard Coxeter element in some parabolic subgroup, if and only if $w$ avoids 321 and 3412.

Conclusion of the proof of Theorem 1.3. If $w \in \mathfrak{S}_{n}$ satisfies the Definition 1.1 then it clearly satisfies Definition 1.2 ,

Conversely, suppose $w \in \mathfrak{S}_{n}$ satisfies Definition 1.2. We now show that it satisfies Definition 1.1. Recall $D=[n]-I=\left\{d_{1}<d_{2}<\ldots<d_{k}\right\} ; d_{0}=0, d_{k+1}=n$. Let

$$
A_{i}=\left\{d_{i-1}+1, \ldots, d_{i}\right\} \text { for } i=1, \ldots, k+1
$$

Assume $w$ is $I$-spherical with some $I$-witness. By Proposition 2.6 and Definition 1.2, we can write $w=w_{0}(I) u$ such that there is a reduced word $R^{\prime \prime}=s_{i_{1}} \cdots s_{i_{\ell(u)}}$ of $u$ such that

- $s_{d_{i}}$ appears at most once in $R^{\prime \prime}$; and
- \#\{m| $\left.d_{t-1}<i_{m}<d_{t}\right\}<\binom{d_{t}-d_{t-1}+1}{2}-\binom{d_{t}-d_{t-1}}{2}=d_{t}-d_{t-1}$ for $1 \leq t \leq k+1$.

By Proposition 2.7, it suffices to show that $u=w_{0}(I) \cdot w$ avoids 321 and 3412, or equivalently, $u^{-1}$ avoids 321 and 3412. Since Proposition 2.6 implies $\ell(w)=\ell\left(w_{0}(I)\right)+\ell(u)$, $u=w_{0}(I) \cdot w$ does not have left descents in $I$. In other words, $u^{-1}$ is increasing on the indices $A_{i}$ for $1 \leq i \leq k+1$.

Think about $R^{\prime \prime}$ as successive multiplications of $u^{-1}$ on the right by simple transpositions of $R^{\prime \prime}$ (read right to left) until one reaches id (for example, if $u^{-1}=2413, R^{\prime \prime}=s_{1} s_{3} s_{2}$ represents $2 \underline{413} \rightarrow 2 \underline{433} \rightarrow \underline{2134} \rightarrow 1234$ ). Since $s_{d_{i}}$ appears at most once in $R^{\prime \prime}$, we know $\left|\left\{u^{-1}(1), u^{-1}(2), \ldots, u^{-1}\left(d_{i}\right)\right\} \backslash\left[d_{i}\right]\right| \leq 1$. Moreover, if this cardinality is $1, s_{d_{i}}$ swaps $\max \left\{u^{-1}(1), \ldots, u^{-1}\left(d_{i}\right)\right\}$ at index $d_{i}$ with $\min \left\{u^{-1}\left(d_{i}+1\right), \ldots, u^{-1}(n)\right\}$ at index $d_{i}+1$.

First suppose $u^{-1}$ contains 3412 at indices $k_{1}<k_{2}<k_{3}<k_{4}$. Then any reduced expression of $u^{-1}$ contains at least two copies of $s_{j}$ for $k_{2} \leq j<k_{3}$. Since $u^{-1}\left(k_{2}\right)>u^{-1}\left(k_{3}\right), k_{2}$ and $k_{3}$ lie in different $A_{i}$ 's. This means that there exists some $k_{2} \leq j<k_{3}$ with $j \notin I$ such that $s_{j}$ is used at least twice in $R^{\prime \prime}$, a contradiction.

If $u^{-1}$ contains 321 at indices $k_{1}<k_{2}<k_{3}$ with $k_{i} \in A_{t_{i}}$, then $t_{1}<t_{2}<t_{3}$. We concentrate on the block $A_{t_{2}}$ and will show that simple transpositions in $A_{t_{2}}$ are used at least $d_{t_{2}}-d_{t_{2}-1}$ times in $R^{\prime \prime}$. A visualization of $u^{-1}$ is shown in Figure 1 ,


FIGURE 1. An example of a permutation $u^{-1}$ containing 321 in the proof of Theorem 1.3
Recall that $s_{d_{t_{2}-1}}$ exchanges the maximum value in indices $A_{1} \cup \cdots \cup A_{t_{2}-1}$ with the minimum value in indices $A_{t_{2}} \cup \cdots \cup A_{k+1}$. Since $u^{-1}\left(k_{2}\right)>u^{-1}\left(k_{3}\right)$, the value $u^{-1}\left(k_{2}\right)$ is not the minimum among $u^{-1}\left(A_{t_{2}} \cup \cdots \cup A_{k+1}\right)$ and thus cannot arrive left of index $d_{t_{2}-1}+1$ during this $s_{d_{t_{2}-1}}$ swap. Similarly, since $u^{-1}\left(k_{2}\right)<u^{-1}\left(k_{1}\right)$, the value $u^{-1}\left(k_{2}\right)$ cannot go to the right of index $d_{t_{2}}-1$. As a result, the value of $u^{-1}\left(k_{2}\right)$ occurs among $u^{-1}\left(A_{t_{2}}\right)$ as we are using $R^{\prime \prime}$ to transform $u^{-1}$ into id.

In order to put $u^{-1}\left(k_{1}\right), u^{-1}\left(k_{2}\right), u^{-1}\left(k_{3}\right)$ into the correct order, both the values $u^{-1}\left(k_{1}\right)$ and $u^{-1}\left(k_{3}\right)$ must enter $A_{t_{2}}$ and exchange with $u^{-1}\left(k_{2}\right)$. In particular, all of the simple transpositions $s_{j}, j=d_{t_{2}-1}+1, \ldots, d_{t_{2}}-1$ must be used in order to exchange $u^{-1}\left(k_{1}\right)$ with $u^{-1}\left(k_{3}\right)$. Moreover, certain $s_{j}$ need to be applied twice: if $u^{-1}\left(k_{1}\right)$ switches with $u^{-1}\left(k_{2}\right)$ at transposition $s_{j}$ before $u^{-1}\left(k_{2}\right)$ switches with $u^{-1}\left(k_{3}\right)$, then $s_{j}$ must be used again; and if $u^{-1}\left(k_{3}\right)$ switches with $u^{-1}\left(k_{2}\right)$ first at $s_{j}$, then $s_{j}$ must be used again as well to eventually switch $u^{-1}\left(k_{2}\right)$ and $u^{-1}\left(k_{1}\right)$. Either way, in this case, the total number of times that $s_{j}$, $j=d_{t_{2}-1}+1, \ldots, d_{t_{2}}-1$, is used is at least $d_{t_{2}}-d_{t_{2}-1}$.

## 3. Bruhat order of Young subgroups and the poset $\mathcal{S}_{I, \gamma}$

The symmetric group $\mathfrak{S}_{n}$ has the poset structure of (strong) Bruhat order $<_{\text {Bruhat }}$. It is convenient for us to use the "upside down" version. That is, the covering relations are $u<_{\text {Bruhat }} u s_{i j}$ where $\ell(u)-1=\ell\left(u s_{i j}\right)$ and $s_{i j}=(i j)$ is a transposition. Hence, under this choice of convention, the longest length permutation $w_{0}=n n-1 \ldots 321$ is the unique minimum, and the identity permutation is the unique maximum.

A sequence of non-negative integers $\alpha=\left(\alpha_{1}, \alpha_{2}, \ldots, \alpha_{n}\right)$ is a weak composition. Let Comp ${ }_{n}$ be the set of all such compositions. Let $\mathrm{Par}_{t}$ be the set of partitions with at most $t$ nonzero-parts. A split-partition is

$$
\left(\lambda^{1}, \ldots, \lambda^{k}\right) \in \operatorname{Par}_{D}:=\operatorname{Par}_{d_{1}-d_{0}} \times \cdots \times \operatorname{Par}_{d_{k+1}-d_{k}}
$$

Fix $\gamma \in \operatorname{Par}_{D}$, where $D=[n-1]-I$ (as in Section 11), which we will identify (in the obvious way) with an element of Comp ${ }_{n}$.

Definition 3.1. $i, j \in[n]$ are in the same block (with respect to $D=[n]-I$ ) if there exists $t \in[0, k]$ such that $d_{t}+1 \leq i, j \leq d_{t+1}$.

Let $\delta_{t}=(t, t-1, \ldots, 3,2,1)$. Given $\gamma$, pick $\Delta:=\Delta_{\gamma} \in \mathbb{Z}_{\geq 0}^{n}$ to be any fixed but arbitrary strictly decreasing vector such that:

- In the $i$-th block (of size $d_{i}-d_{i-1}$ ), the components of $\Delta$ are of the form $\left(f_{i}, f_{i}, \ldots, f_{i}\right)+$ $\delta_{d_{i}-d_{i-1}}$ where $f_{i}$ is some positive integer depending on $i$.
- $\gamma+\Delta$ is a vector with distinct components.

Let $\widehat{\mathfrak{S}}_{n}$ be permutations on the (distinct) entries of $\gamma+\Delta$. Clearly there is an isomorphism of Bruhat orders between that of $\mathfrak{S}_{n}$ and $\widehat{\mathfrak{S}}_{n}$ that sends $w_{0}$ to $\Delta+\gamma$. We will therefore mildly abuse notation and use $<_{\text {Bruhat }}$ for either order, as the context will be clear. Let

$$
\Omega:\left(\mathfrak{S}_{n},<_{\text {Bruhat }}\right) \rightarrow\left(\widehat{\mathfrak{S}}_{n},<_{\text {Bruhat }}\right)
$$

be this poset isomorphism.
Now, let

$$
\tilde{\mathcal{S}}_{I, \gamma}=\widehat{\mathfrak{S}}_{d_{1}-d_{0}} \times \widehat{\mathfrak{S}}_{d_{2}-d_{1}} \times \cdots \times \widehat{\mathfrak{S}}_{d_{k+1}-d_{k}}
$$

be the Young subgroup of $\widehat{\mathfrak{S}}_{n}$, where $\widehat{\mathfrak{S}}_{d_{i+1}-d_{i}}$ is the permutation group on the labels of $\Delta+\gamma$ in the $i$-th block. Thus, strong Bruhat order $<_{\text {Bruhat }}$ on $\widehat{\mathfrak{S}}_{n}$ restricts to $\tilde{\mathcal{S}}_{I, \gamma}$.
Definition 3.2. Given $\tilde{\beta} \in \tilde{\mathcal{S}}_{I, \gamma}$ (thought of as a vector in $\mathbb{Z}_{\geq 0}^{n}$ ), let

$$
\Phi(w)=\tilde{\beta}-\Delta .
$$

Let $\mathcal{S}_{I, \gamma}:=\operatorname{Im} \Phi \subset \operatorname{Comp}_{n}$. For $x, y \in \mathcal{S}_{I, \gamma}$ define $x<_{\text {Bruhat }} y$ if $\Phi^{-1}(x)<_{\text {Bruhat }} \Phi^{-1}(y)$.
Proposition 3.3. $\left(\mathcal{S}_{I, \gamma},<_{\text {Bruhat }}\right) \cong\left(\tilde{\mathcal{S}}_{I, \gamma},<_{\text {Bruhat }}\right) \cong\left(\mathfrak{S}_{d_{1}-d_{0}} \times \cdots \times \mathfrak{S}_{d_{k+1}-d_{k}},<_{\text {Bruhat }}\right)$.
Proof. $\Phi$ is injective and hence a bijection onto its image. It is a poset map by construction. This proves the first isomorphism. The second isomorphism is induced from $\Omega$.
Definition 3.4. If $\beta=\left(\beta_{1}, \ldots, \beta_{n}\right) \in \operatorname{Comp}_{n}$ and $i<j \in[n-1]$, define $t_{i j}:$ Comp $_{n} \rightarrow$ Comp $_{n}$ by

$$
\begin{equation*}
t_{i j}\left(\ldots, \beta_{i}, \ldots, \beta_{j}, \ldots\right)=\left(\ldots, \beta_{j}-(j-i), \ldots, \beta_{i}+(j-i), \ldots\right) \tag{2}
\end{equation*}
$$

Also let $t_{i}:=t_{i+1}$.

The next lemma asserts that the role of $t_{i j}$ 's in $\mathcal{S}_{I, \gamma}$ is the same as that of the $s_{i j}=(i j)$ in $\mathfrak{S}_{n}$. In particular, the $t_{i}$ 's are analogous to the simple transpositions.

Lemma 3.5. For $i<j$ in the same block, this diagram commutes:


Proof. Let $\tilde{\beta} \in \tilde{\mathcal{S}}_{I, \gamma}$. By definition of $\Delta$, there is some number $f$ such that $\Delta_{k}=f-k$ for $i \leq k \leq j$. We have

$$
\begin{aligned}
t_{i j} \Phi \tilde{\beta} & =t_{i j}\left(\ldots, \tilde{\beta}_{i}-f+i, \ldots, \tilde{\beta}_{k}-f+k, \ldots, \tilde{\beta}_{j}-f+j, \ldots\right) \\
& =\left(\ldots, \tilde{\beta}_{j}-f+j-(j-i), \ldots, \tilde{\beta}_{k}-f+k, \ldots, \tilde{\beta}_{i}-f+i+(j-i), \ldots\right) \\
& =\left(\ldots, \tilde{\beta}_{j}-f+i, \ldots, \tilde{\beta}_{k}-f+k, \ldots, \tilde{\beta}_{i}-f+j, \ldots\right) \\
& =\Phi\left(\ldots, \tilde{\beta}_{j}, \ldots, \tilde{\beta}_{k}, \ldots, \tilde{\beta}_{i}, \ldots\right)=\Phi s_{i j} \tilde{\beta}
\end{aligned}
$$

as desired.
Example 3.6. Let $n=3, I=\{1,2\}$ with a single block, $\gamma=443$ and $\Delta=321$. Figure 2 shows the poset $\tilde{\mathcal{S}}_{I, \gamma}$ and $\mathcal{S}_{I, \gamma}$ with the actions of $s_{i j}{ }^{\prime}$ 's and $t_{i j}$ 's respectively.


Figure 2. Example of the poset $\tilde{\mathcal{S}}_{I, \gamma}$ (left) and $\mathcal{S}_{I, \gamma}$ (right)

Remark 3.7. Having formally defined $\left(\mathcal{S}_{I, \gamma},<_{\text {Bruhat }}\right)$ above, in the remainder of the paper, one can think of this poset as generated from $\gamma$ via the action of $t_{i j}$ 's, including just the $t_{i}$ 's.
Definition 3.8. For $\beta \in \mathcal{S}_{I, \gamma}$, let $\theta(\beta)$ be the rank of $\beta$, i.e., there exists a saturated chain

$$
\beta=\beta^{(\theta)} \gtrdot_{\text {Bruhat }} \beta^{(\theta-1)} \gtrdot_{\text {Bruhat }} \cdots \gtrdot_{\text {Bruhat }} \beta^{(0)}=\gamma
$$

of length $\theta=\theta(\beta)$ from $\beta$ to the minimum $\gamma$ in $\mathcal{S}_{I, \gamma}$. Also define the sign of $\beta$ to be $\operatorname{sgn}(\beta):=(-1)^{\theta(\beta)}$.

These facts follow immediately from the usual Bruhat orders and the isomorphism $\Phi$.
Lemma 3.9. For $\beta \in \mathcal{S}_{I, \gamma}$ and $i, j$ in the same block,
(i) $\beta_{i}>\beta_{j}-(j-i)$ if and only if $\beta<$ Bruhat $t_{i j} \beta$; in particular, $\beta_{i}-i \neq \beta_{j}-j$ for $i \neq j$;
(ii) $\operatorname{sgn}\left(t_{i j} \beta\right)=-\operatorname{sgn}(\beta)$;

## 4. POLYNOMIALS AND SPHERICALITY

4.1. Key polynomials. Let Pol $:=\mathbb{Z}\left[x_{1}, x_{2}, \ldots, x_{n}\right]$ be the polynomial ring in the indeterminates $x_{1}, x_{2}, \ldots, x_{n}$. For $\alpha=\left(\alpha_{1}, \alpha_{2}, \ldots, \alpha_{n}\right) \in$ Comp $_{n}$, the key polynomial $\kappa_{\alpha}$ is defined as follows. If $\alpha$ is weakly decreasing, then $\kappa_{\alpha}:=\prod_{i} x_{i}^{\alpha_{i}}$. Otherwise, suppose $\alpha_{i}>\alpha_{i+1}$. Let

$$
\pi_{i}: \mathrm{Pol} \rightarrow \mathrm{Pol}, \quad f \mapsto \frac{x_{i} f\left(\ldots, x_{i}, x_{i+1}, \ldots\right)-x_{i+1} f\left(\ldots, x_{i+1}, x_{i}, \ldots\right)}{x_{i}-x_{i+1}},
$$

and

$$
\kappa_{\alpha}=\pi_{i}\left(\kappa_{\widehat{\alpha}}\right) \text { where } \widehat{\alpha}:=\left(\alpha_{1}, \ldots, \alpha_{i+1}, \alpha_{i}, \ldots\right)
$$

We need facts about the operators $\pi_{i}$; our reference is [L13]. The operators $\pi_{i}$ satisfy the relations

$$
\begin{aligned}
\pi_{i} \pi_{j} & =\pi_{j} \pi_{i} \quad(\text { for }|i-j|>1) \\
\pi_{i} \pi_{i+1} \pi_{i} & =\pi_{i+1} \pi_{i} \pi_{i+1} \\
\pi_{i}^{2} & =\pi_{i}
\end{aligned}
$$

Recall that the Demazure product on $\mathfrak{S}_{n}$ is defined by

$$
w * s_{i}= \begin{cases}w s_{i} & \text { if } \ell\left(w s_{i}\right)=\ell(w)+1 \\ 0 & \text { otherwise }\end{cases}
$$

This product is associative. Then $R=\left(s_{i_{1}}, \cdots, s_{i_{\ell}}\right)$ is a Hecke word of $w$ if $w=s_{i_{1}} * s_{i_{2}} *$ $\cdots * s_{i_{\ell}}$.

For any $w \in \mathfrak{S}_{n}$ one unambiguously defines

$$
\pi_{w}:=\pi_{i_{1}} \pi_{i_{2}} \cdots \pi_{i_{\ell}}
$$

where $R=\left(s_{i_{1}}, \ldots, s_{i_{\ell}}\right)$ is any Hecke word of $w$.
Now suppose $\lambda=\left(\lambda_{1} \geq \lambda_{2} \geq \ldots \geq \lambda_{n}\right)$ is a partition, and $w \in \mathfrak{S}_{n}$. Define

$$
\kappa_{w \lambda}:=\kappa_{\lambda_{w^{-1}(1)}, \ldots, \lambda_{w^{-1}(n)}} .
$$

With this choice of convention, we have

$$
\begin{equation*}
\kappa_{w \lambda}=\pi_{w} \kappa_{\lambda} . \tag{4}
\end{equation*}
$$

Below, we do not assume $\ell(w)=\ell\left(w_{0}(I)\right)+\ell(c)$ :
Lemma 4.1. If $w=w_{0}(I) c$ where $c$ is a standard Coxeter element, then $\kappa_{w \lambda}=\pi_{w_{0}(I)} \kappa_{c \lambda}$.
Proof. By two applications of (4), and the definition of $\pi_{w}$

$$
\kappa_{w \lambda}=\kappa_{w_{0}(I) c \lambda}=\pi_{w_{0}(I) c}\left(\kappa_{\lambda}\right)=\pi_{w_{0}(I)} \pi_{c}\left(\kappa_{\lambda}\right)=\pi_{w_{0}(I)} \kappa_{c \lambda} .
$$

For any $\alpha \in \mathrm{Comp}_{n}$, let

$$
a_{\alpha_{1}+n-1, \alpha_{2}+n-2, \ldots, \alpha_{n}}:=\operatorname{det}\left(x_{j}^{\lambda_{i}+n-i}\right)_{1 \leq i, j \leq n} .
$$

In particular,

$$
\Delta_{n}:=a_{n-1, n-2, \ldots, 0}=\prod_{1 \leq j<k \leq n}\left(x_{j}-x_{k}\right)
$$

is the Vandermonde determinant. Define a generalized Schur polynomial $s_{\alpha}$ by

$$
\begin{equation*}
s_{\alpha}\left(x_{1}, \ldots, x_{n}\right):=a_{\alpha_{1}+n-1, \alpha_{2}+n-2, \ldots, \alpha_{n}} / a_{n-1, n-2, \ldots, 1,0} . \tag{5}
\end{equation*}
$$

This is well-known, and clear from (5) and the row-swap property of determinants:
Lemma 4.2. $s_{t_{i} \alpha}\left(x_{1}, \ldots, x_{n}\right)=-s_{\alpha}\left(x_{1}, \ldots, x_{n}\right)$. Thus, if $\alpha_{i+1}=\alpha_{i}+1$ then $s_{\alpha}\left(x_{1}, \ldots, x_{n}\right)=0$.
A result we need is a characterization of the monomials $x^{\beta}$ that appear (with nonzero coefficient) in $\kappa_{\alpha}$. Graphically represent the weak composition $\alpha$ as a skyline $D(\alpha)$ of boxes where column $i$ (from the left) is a tower of $\alpha_{i}$ boxes. For example, if $\alpha=(3,0,4,1,0,2)$ then the associated skyline is


Define $\operatorname{Tab}(\alpha)$ to be fillings of $D(\alpha)$ with $\mathbb{N}:=\{1,2,3, \ldots\}$ such that:

- no label appears twice in a row (row distinct); and
- the labels in column $i$ are at most $i$ (flagged).

The weight of $T \in \operatorname{Tab}(\alpha)$ is the vector $\operatorname{wt}(T)=\left(c_{1}, c_{2}, \ldots\right)$ where $c_{i}=\#\{i \in T\}$. The following result is implicit in [ARY18, ARY19, ARY21] and explicit in [FGPS20].
Theorem 4.3. $\left[x^{\beta}\right] \kappa_{\alpha} \neq 0$ if and only if there exists $T \in \operatorname{Tab}(\alpha)$ with content $\beta$.
Proof. We explicate the argument alluded to in ARY18, ARY19, ARY21]; we refer to these papers for definitions. This argument differs from the one in [FGPS20]. In [ARY21], it is shown that a lattice point $\beta$ appears in the Schubitope associated to $D(\alpha)$ (rotated 90degrees clockwise) if and only if there exists $T \in \operatorname{Tab}(\alpha)$ with content $\beta$. In [FMS18], it is proved that these lattice points correspond exactly to the monomials of $\kappa_{\alpha}$.

A consequence of Theorem 4.3 that we will use is
Corollary 4.4. Let $\alpha, \beta \in \operatorname{Comp}_{n}$ and assume $\left[x^{\beta}\right] \kappa_{\alpha}>0$. Suppose $i<j$ and $\beta_{j}-\beta_{i}=t \in \mathbb{Z}_{>0}$. For $1 \leq s \leq t$, let $\beta^{\prime}:=\left(\ldots, \beta_{i}+s, \ldots, \beta_{j}-s, \ldots\right)$. Then $\left[\beta^{\prime}\right] \kappa_{\alpha}>0$.

Proof. By Theorem 4.3 there exists $T \in \operatorname{Tab}(\alpha)$ of content $\beta$. By definition, there are $\beta_{j}$ distinct rows where $T$ has a label $j$, and there are $\beta_{i}$ distinct rows where $T$ has a label $i$. Since $\beta_{j}-\beta_{i}=t$, there exist $s$ rows where $T$ contains a $j$ but not an $i$. Define $T^{\prime}$ by replacing $j$ by $i$ in those $s$ rows. Since $i<j$, we conclude $T^{\prime} \in \operatorname{Tab}\left(\beta^{\prime}\right)$ and hence (by Theorem4.3), $\left[\beta^{\prime}\right] \kappa_{\alpha}>0$, as claimed.

Given $\alpha$, define the set of Kohnert diagrams $\operatorname{Koh}(\alpha)$ iteratively. To start $D(\alpha) \in \operatorname{Koh}(\alpha)$. If $D \in \operatorname{Koh}(\alpha)$, consider the top-most box in any column. Let $D^{\prime}$ be the result of moving that box left, in the same row, to the rightmost location that is not occupied (if it exists); this operation is a Kohnert move. Now include $D^{\prime} \in \operatorname{Koh}(\alpha)$, as well. We emphasize that $\operatorname{Koh}(\alpha)$ is a finite set (rather than multiset), hence if a diagram $D$ is obtained by two different sequences of Kohnert moves starting from $D(\alpha)$, then $D$ only counts once in $\operatorname{Koh}(\alpha)$.

Given $D \in \operatorname{Koh}(\alpha)$, let

$$
\operatorname{Kohwt}(D)=\prod_{i=1}^{n} x_{i}^{\# \mathrm{boxes} \text { of } D \text { in column } i}
$$

Theorem 4.5 (Kohnert's rule [K90]). $\kappa_{\alpha}=\sum_{D \in \operatorname{Koh}(\alpha)} \operatorname{Kohwt}(D)$.
Define dominance order on $\alpha, \beta \in \operatorname{Comp}_{n}$ such that $|\alpha|:=\sum_{i=1}^{n} \alpha_{i}=\sum_{i=1}^{n} \beta_{i}:=|\beta|$ by $\alpha \leq_{\operatorname{dom}} \beta$ if for every $1 \leq t \leq n$ we have $\sum_{i=1}^{t} \alpha_{i} \leq \sum_{i=1}^{t} \beta_{i}$.
Corollary 4.6. Let $\alpha, \beta \in \operatorname{Comp}_{n}$ with $\left[x^{\beta}\right] \kappa_{\alpha}>0$. Then $\beta \geq \operatorname{dom} \alpha$.
4.2. Split-symmetry. We recall some notions from [HY20a, Section 4]. Suppose

$$
d_{0}:=0<d_{1}<d_{2}<\ldots<d_{k}<d_{k+1}:=n
$$

and $D=\left\{d_{1}, \ldots, d_{k}\right\}$. Let $\Pi_{D}$ be the subring of Pol consisting of the polynomials that are separately symmetric in $X_{i}:=\left\{x_{d_{i-1}+1}, \ldots, x_{d_{i}}\right\}$ for $1 \leq i \leq k+1$. If $f \in \Pi_{D}, f$ is D-split-symmetric.

The ring $\Pi_{D}$ has a basis of $D$-Schur polynomials

$$
s_{\lambda^{1}, \ldots, \lambda^{k}}:=s_{\lambda^{1}}\left(X_{1}\right) s_{\lambda^{2}}\left(X_{2}\right) \cdots s_{\lambda^{k}}\left(X_{k}\right)
$$

where

$$
\left(\lambda^{1}, \ldots, \lambda^{k}\right) \in \operatorname{Par}_{D}:=\operatorname{Par}_{d_{1}-d_{0}} \times \cdots \times \operatorname{Par}_{d_{k+1}-d_{k}}
$$

and $\mathrm{Par}_{t}$ is the set of partitions with at most $t$ nonzero-parts. See [HY20a, Definition 4.3, Corollary 4.4]. Thus, for any $f \in \Pi_{D}$ there is a unique expression

$$
f=\sum_{\left(\lambda^{1}, \ldots, \lambda^{k}\right) \in \operatorname{Par}_{D}} c_{\lambda^{1}, \ldots, \lambda^{k}} s_{\lambda^{1}, \ldots, \lambda^{k}}
$$

If $c_{\lambda^{1}, \ldots, \lambda^{k}} \in\{0,1\}$ for all $\left(\lambda^{1}, \ldots, \lambda^{k}\right) \in \operatorname{Par}_{D}, f$ is called $D$-multiplicity-free.
This fact allows us to study Levi-sphericality using key polynomials:
Theorem 4.7 ([HY20a, Theorem 4.13]). Let $\lambda \in \operatorname{Par}_{n}$, and $w \in \mathfrak{S}_{n}$. Suppose $I \subseteq J(w)$ and $D=[n-1]-I . X_{w}$ is $L_{I}$-spherical if and only if $\kappa_{w \lambda}$ is $D$-multiplicity-free for all $\lambda \in \operatorname{Par}_{n}$.

In view of Theorem 4.7, the following is equivalent to Theorem 1.5 ,
Theorem 4.8. Let $D=[n-1]-I$. w is $I$-spherical if and only if $\kappa_{w \lambda}$ is $D$-multiplicity-free for all $\lambda \in \operatorname{Par}_{n}$.

Our goal is therefore to prove Theorem 4.8, To do this, we will use the lemma below.
Lemma 4.9. Let $\beta \in$ Comp $_{n}$, then

$$
\pi_{w_{0}(I)}\left(x_{1}^{\beta_{1}} \cdots x_{n}^{\beta_{n}}\right) \in\left\{0, \operatorname{sgn}(\beta) s_{\alpha^{1}, \ldots, \alpha^{k}}\right\}
$$

where $\left(\alpha^{1}, \ldots, \alpha^{k}\right) \in \operatorname{Par}_{D}$.
Proof. First, consider the special case that $w_{0}(I)=w_{0}$. By [L13, Proposition 1.5.1],

$$
\pi_{w_{0}}(f)=\frac{1}{\Delta_{n}} x^{\rho} \sum_{w \in \mathfrak{S}_{n}}(-1)^{\ell(w)} w(f) .
$$

Hence by (5), $\pi_{w_{0}}\left(x^{\beta}\right)=s_{\beta}$. Rearrange $\beta$ to be weakly decreasing by application of the operators $t_{1}, t_{2}, \ldots$ and swapping two adjacent entries where the left entry is strictly smaller than the other one. This can always be achieved unless during this process one arrives at a composition $\kappa$ where $\kappa_{i+1}=\kappa_{i}+1$. In that case, Lemma 4.2 asserts $s_{\beta}=0$. Otherwise we arrive at $\alpha \in \operatorname{Par}_{n}$ and Lemma 4.2 combined with Definition 3.8 shows $s_{\beta}=\operatorname{sgn}(\beta) s_{\alpha}$.

In the general case, $w_{0}(I)$ is by definition the long element of the Young subgroup $\mathfrak{S}_{d_{1}-d_{0}} \times \cdots \times \mathfrak{S}_{d_{k+1}-d_{k}}$ of $\mathfrak{S}_{n}$. Hence $w_{0}(I)=w_{0}^{(1)} w_{0}^{(2)} \ldots, w_{0}^{(k+1)}$ where $w_{0}^{(i)}$ is the long element of $\mathfrak{S}_{d_{i}-d_{i-1}}=$ the parabolic subgroup of $\mathfrak{S}_{n}$ generated by $s_{d_{i-1}+1}, s_{d_{i-1}+2}, \ldots, s_{d_{i}-1}$. Hence, it follows that

$$
\begin{equation*}
\pi_{w_{0}(I)}=\pi_{w_{0}^{(1)}} \pi_{w_{0}^{(2)}} \cdots \pi_{w_{0}^{(k+1)}} \tag{6}
\end{equation*}
$$

and the factors commute. Thus, the general case follows from (6) and the special case.

## 5. The subposet $\mathcal{P}_{u \lambda, \gamma}$ of $\mathcal{S}_{I, \gamma}$ and the Proof of Theorem $4.8(\Rightarrow)$

Lemma 5.1. $\mathcal{S}_{I, \gamma}$ (as a set) contains all $\beta \in \mathrm{Comp}_{n}$ such that $\pi_{w_{0}(I)} x^{\beta}= \pm s_{\gamma}$.
Proof. Suppose $\beta \in$ Comp $_{n}$ satisfies $\pi_{w_{0}(I)} x^{\beta}= \pm s_{\gamma}(\neq 0)$. As in the proof of Lemma 4.9 by successive applying the operators $t_{1}, t_{2}, \ldots(i \in I)$ to $\beta$, we either arrive at some $\gamma^{\prime} \in \operatorname{Par}_{D}$ or a $\kappa \in$ Comp $_{n}$ with $\kappa_{i+1}=\kappa_{i}+1$ where $i, i+1$ are in the same block. In the latter case we conclude, by the (proof of) Lemma 4.9 that $\pi_{w_{0}(I)} x^{\beta}=0$, a contradiction. Otherwise we find $\pm s_{\gamma}=s_{\gamma^{\prime}}$, which can only happen if $\gamma=\gamma^{\prime}$. Thus, we have found a sequence of $t_{i}$ 's connecting $\beta$ to $\gamma$. The result then follows from Lemma 3.5 and the definition of $\mathcal{S}_{I, \gamma}$.

We need a subposet of $\mathcal{S}_{I, \gamma}$ attached to the following datum:

- $w=w_{0}(I) u \in \mathfrak{S}_{n}$ where $I \subset J(w)$ and $\ell(w)=\ell\left(w_{0}(I)\right)+\ell(u)$.
- $\alpha=u \lambda$ for some $\lambda \in \operatorname{Par}_{n}$.
- $\gamma \in \operatorname{Par}_{D}$ where $D=[n]-I=\left\{d_{1}<d_{2}<\ldots<d_{k}\right\}$.

Definition 5.2. $\mathcal{P}_{\alpha, \gamma}$ is the subposet of $\mathcal{S}_{I, \gamma}$ induced by those $\beta \in \mathcal{S}_{I, \gamma}$ such that $\left[x^{\beta}\right] \kappa_{\alpha} \neq 0$.
The next result holds for $u=c$, a standard Coxeter element for a parabolic subgroup.
Theorem 5.3 (Diamond property). Let $\beta \in \mathcal{P}_{c \lambda, \gamma}$. Let $i<j$ in the same block and $p<q$ in the same block with $(i, j) \neq(p, q)$. If both $t_{i j} \beta$ and $t_{p q} \beta$ are in $\mathcal{P}_{c \lambda, \gamma}$ and cover $\beta$, then there exists $\beta^{\prime} \in \mathcal{P}_{c \lambda, \gamma}$ such that $t_{i j} \beta, t_{p q} \beta<\beta^{\prime}$.

We defer the proof of Theorem 5.3 until Section 6. We complete this section by using Theorem 5.3 to prove the " $\Rightarrow$ " direction of Theorem 1.5,

The following result is immediate from the Diamond Property (Theorem5.3) and Newman's diamond lemma [N42].
Lemma 5.4. $\mathcal{P}_{c \lambda, \gamma}$ has a unique maximum.
Lemma 5.5. Suppose $\beta \in \mathcal{P}_{\alpha, \gamma}, \beta_{i}<\beta_{j}-(j-i)$ for some $i<j$ in the same block. Then $t_{i j} \beta \in \mathcal{P}_{\alpha, \gamma}$.

Proof. By Lemma 5.1 $\mathcal{S}_{I, \gamma}$ consists of all $\beta$ such that $\pi_{w_{0}(I)} x^{\beta}= \pm s_{\gamma}$. Let $\beta^{\prime}:=t_{i j} \beta$. Thus, $\beta_{i}^{\prime}=\beta_{j}-(j-i), \beta_{j}^{\prime}=\beta_{i}+(j-i)$, and $\beta_{k}^{\prime}=\beta_{k}$ if $k \neq i, j$. The hypothesis that $\beta_{i}<\beta_{j}-(j-i)$ means $\beta_{i}<\beta_{i}^{\prime}$ and $\beta_{j}^{\prime}<\beta_{j}$ and $\beta_{j}^{\prime}-\beta_{i}^{\prime}=(j-i) \in \mathbb{Z}_{>0}$. Hence by Corollary 4.4, $\left[x^{\beta^{\prime}}\right] \kappa_{\alpha}>0$. Therefore, it follows that $\beta^{\prime}=t_{i j} \beta \in \mathcal{P}_{\alpha, \gamma}$, as desired.
Lemma 5.6. Let $\mathfrak{S}:=\mathfrak{S}_{d_{1}-d_{0}} \times \cdots \times \mathfrak{S}_{d_{k+1}-d_{k}}$ be a Young subgroup of $\mathfrak{S}_{n}$. Suppose $[u, v] \subset \mathfrak{S}$ is an interval. Then

$$
\sum_{u \leq w \leq v}(-1)^{\ell(u w)}= \begin{cases}1 & \text { if } u=v  \tag{7}\\ 0 & \text { otherwise }\end{cases}
$$

Proof. For a (locally) finite poset $P$ let $\mu_{P}: P \times P \rightarrow \mathbb{R}$ be its Möbius function. This is defined recursively by $\mu_{P}(x, x)=1$ and $\mu_{P}(x, z)=-\sum_{x \leq_{P} z<_{P} y} \mu_{P}(x, z)$. When $P=$ $\mathfrak{S}=\mathfrak{S}_{n}$, the lemma holds since $(-1)^{\ell(u w)}$ is the Möbius function for $\mathfrak{S}_{n}$ under Bruhat order [D77].

For the general case, recall [S12, Proposition 3.8.2], which states that if $P$ and $Q$ be locally finite posets, and $P \times Q$ is their direct product, if $(s, t) \leq\left(s^{\prime}, t^{\prime}\right)$ in $P \times Q$ then the Möbius functions of $P \times Q, P$, and $Q$ are related by

$$
\begin{equation*}
\mu_{P \times Q}\left((s, t),\left(s^{\prime}, t^{\prime}\right)\right)=\mu_{P}\left(s, s^{\prime}\right) \mu_{Q}\left(t, t^{\prime}\right) . \tag{8}
\end{equation*}
$$

Elements of $\mathfrak{S}$ are uniquely factorizable as $w=p^{(1)} p^{(2)} \cdots p^{(k+1)}$ where $p^{(i)}$ is an element of the parabolic subgroup $\mathfrak{S}_{d_{i}-d_{i-1}}$ of $\mathfrak{S}_{n}$ generated by $s_{d_{i-1}+1}, s_{d_{i-1}+2}, \ldots, s_{d_{i}-1}$. Similarly, let $u=q^{(1)} q^{(2)} \cdots q^{(k+1)}$ be the factorization of $u \in \mathfrak{S}$, and $u \leq_{\text {Bruhat }} w$. By iterating application of (8) $k$-many times,

$$
\mu_{\mathfrak{S}}(u, w)=\prod_{i=1}^{k+1} \mu_{\mathfrak{S}_{d_{i}-d_{i-1}}}\left(q^{(i)}, p^{(i)}\right)=(-1)^{\sum_{i=1}^{k+1} \ell\left(q^{(i)} p^{(i)}\right)}=(-1)^{\ell(w u)}
$$

and the result follows.
Proposition 5.7. ( $\mathcal{P}_{c \lambda, \gamma},<_{\text {Bruhat }}$ ) is isomorphic (as posets) to an interval in $\left(\mathfrak{S}_{d_{1}-d_{0}} \times \cdots \times\right.$ $\left.\mathfrak{S}_{d_{k+1}-d_{k}},<_{\text {Bruhat }}\right)$.

Assuming the proof of Theorem5.3(given in the next section), we are ready to present: Proof of Proposition 5.7 and Theorem 4.8 ( $\Rightarrow$ ): Let

$$
\Gamma:\left(\mathcal{S}_{I, \gamma},<_{\text {Bruhat }}\right) \rightarrow\left(\mathfrak{S}_{d_{1}-d_{0}} \times \cdots \times \mathfrak{S}_{d_{k+1}-d_{k}},<_{\text {Bruhat }}\right)
$$

denote the isomorphism of posets from Proposition 3.3.
Let $\beta_{\text {max }}$ be the unique maximum of $\mathcal{P}_{c \lambda, \gamma} \subseteq \mathcal{S}_{I, \gamma}$, guaranteed to exist by Lemma5.4. The unique minimum is $\gamma$. It follows from Lemma 5.5 that

$$
\Gamma\left(\mathcal{P}_{c \lambda, \gamma}\right)=\left[\Gamma(\gamma), \Gamma\left(\beta_{\max }\right)\right] \subseteq\left(\mathfrak{S}_{d_{1}-d_{0}} \times \cdots \times \mathfrak{S}_{d_{k+1}-d_{k}},<_{\text {Bruhat }}\right)
$$

This is the assertion of Proposition 5.7,
If $\operatorname{sgn}(\beta)$ is the sign associated to $\beta$, then this maps to $(-1)^{\ell\left(w_{\beta}\right)}$, which agrees with the Möbius function on $\mathfrak{S}$. Now apply (7) to conclude $s_{\gamma}$ appears in the $D$-split expansion of $\kappa_{w \lambda}=\pi_{w_{0}(I)} \kappa_{c \lambda}$ with coefficient zero or one, completing the proof of Theorem4.8.

Example 5.8. Let $w=765432918$ and $\lambda=987654321$. Hence $J(w)=\{1,2,3,4,5,6,8\}$; let $I=\{2,3,4,5,6\} \subseteq J(w)$. Thus $w_{0}(I)=176543289$ and we can factor $w=w_{0}(I) c$ where $c$ is the standard Coxeter element $c=234567918=s_{8} s_{1} s_{2} s_{3} s_{4} s_{5} s_{6} s_{7}$. Now, $c^{-1}=812345697$ and $w^{-1}=865432197$. Therefore $\alpha=c \lambda=298765413$, whereas $w \lambda=245678913$.

Since $D=[9]-I=\{1,7,8,9\}$, we have that $\kappa_{w \lambda}=\kappa_{245678913} \in \Pi_{D}$ is separately symmetric in the sets of indeterminates $\left\{x_{1}\right\},\left\{x_{2}, x_{3}, x_{4}, x_{5}, x_{6}, x_{7}\right\},\left\{x_{8}\right\},\left\{x_{9}\right\}$.

Since $c$ is a standard Coxeter element, by [HY20a, Theorem 4.13(II)], we have that $\kappa_{c \lambda}$ is [ $n-1$ ]-multiplicity-free. Consider the term $x^{928765422}$ appearing in $\kappa_{c \lambda}$. Now

$$
\pi_{w_{0}(I)}\left(x^{928765422}\right)=s_{9,287654,2,2}=-s_{9,73 \underline{3} 654,2,2}=s_{9,764654,2,2}=-s_{9,765554,2,2},
$$

where we have underlined the swaps.

The list of monomials $x^{\beta}$ of $\kappa_{c \lambda}$ such that $\pi_{w_{0}(I)}\left(x^{\beta}\right)= \pm s_{9,765554,2,2}$, together with the signs they contribute are:

$$
\begin{gathered}
{[9,7,6,5,5,5,4,2,2] 1,[9,7,4,7,5,5,4,2,2]-1,[9,7,6,4,6,5,4,2,2]-1,} \\
{[9,5,8,4,6,5,4,2,2] 1,[9,7,3,7,6,5,4,2,2] 1,[9,5,8,5,5,5,4,2,2]-1} \\
{[9,2,8,7,6,5,4,2,2]-1,[9,3,8,7,5,5,4,2,2] 1 .}
\end{gathered}
$$

These elements form a poset $\mathcal{P}_{c \lambda, \gamma=9,765554,2,2}$ shown in Figure 3 isomorphic to an interval [id, $s_{2} s_{3} s_{4}$ ] in Bruhat order, consistent with Proposition 5.7.


Figure 3. The poset $\mathcal{P}_{c \lambda, \gamma}$ for $c=234567918, \lambda=987654321, \gamma=976555422$, $I=\{2,3,4,5,6\}$ with some edges labeled

Indeed the coefficients sum to zero, in agreement with the above discussion about the Möbius function.

## 6. Proof of the Diamond property (Theorem 5.3)

Throughout this section we fix a decomposition $w=w_{0}(I) c$ where $c$ is a standard Coxeter element of some parabolic such that $\ell(w)=\ell\left(w_{0}(I)\right)+\ell(c)$, and $\lambda \in \operatorname{Par}_{n}$.
Lemma 6.1. Let $w=w_{0}(I) u \in \mathfrak{S}_{n}$ with $\ell(w)=\ell\left(w_{0}(I)\right)+\ell(u)$. If $i \in I$, then $(u \lambda)_{i} \geq(u \lambda)_{i+1}$.
Proof. The length additivity of $w_{0}(I)$ and $u$ implies $J(u) \cap J\left(w_{0}(I)\right)=J(u) \cap I=\emptyset$. Thus $u^{-1}(i)<u^{-1}(i+1)$, and since $\lambda$ is a partition, $(u \lambda)_{i}=\lambda_{u^{-1}(i)} \geq \lambda_{u^{-1}(i+1)}=(u \lambda)_{i+1}$.

We will use the following notion from [HY20a]:
Definition 6.2 (Composition patterns). Let Comp $:=\bigcup_{n=1}^{\infty}$ Comp $_{n}$. For $\alpha=\left(\alpha_{1}, \ldots, \alpha_{\ell}\right), \beta=$ $\left(\beta_{1}, \ldots, \beta_{k}\right) \in$ Comp, $\alpha$ contains the composition pattern $\beta$ if there exists integers $j_{1}<j_{2}<$ $\cdots<j_{k}$ that satisfy:

- $\left(\alpha_{j_{1}}, \ldots, \alpha_{j_{k}}\right)$ is order isomorphic to $\beta\left(\alpha_{j_{s}} \leq \alpha_{j_{t}}\right.$ if and only if $\left.\beta_{s} \leq \beta_{t}\right)$,
- $\left|\alpha_{j_{s}}-\alpha_{j_{t}}\right| \geq\left|\beta_{s}-\beta_{t}\right|$.

If $\alpha$ does not contain $\beta$, then $\alpha$ avoids $\beta$.
Lemma 6.3. $c \lambda$ avoids $012,1032,0011,0021,1022$.
Proof. Since $c$ is a standard Coxeter element in a parabolic subgroup, $X_{c} \subseteq G L_{n} / B$ is a toric variety [K13]. Hence, by [HY20a, Theorem 4.13(II)], $\kappa_{c \lambda}$ is [ $\left.n-1\right]$-multiplicity-free for all $\lambda \in \operatorname{Par}_{n}$. In [HY20b], it is shown that $\kappa_{\alpha}$ is [ $n-1$ ]-multiplicity free if and only if $\alpha$ avoids $012,1032,0022,0021,1022$. Thus, since $\kappa_{c \lambda}$ is $[n-1]$-multiplicity-free, $c \lambda$ avoids $012,1032,0022,0021,1022$.

To seek a contradiction, suppose that $c \lambda$ contains the pattern 0011. Let $j_{1}<j_{2}<j_{3}<j_{4}$ be the integers such that $(c \lambda)_{j_{1}},(c \lambda)_{j_{2}},(c \lambda)_{j_{3}},(c \lambda)_{j_{4}}$ contains the composition pattern 0011. Let $\tilde{\lambda} \in \operatorname{Par}_{n}$ be obtained from $\lambda$ by replacing all part lengths equal to $(c \lambda)_{j_{3}}$ by $(c \lambda)_{j_{3}}+1$. Then $c \tilde{\lambda}$ contains the pattern 0022. We conclude, via [HY20b], that $\kappa_{c \tilde{\lambda}}$ is not $[n-1]$ -multiplicity-free. By [HY20a, Theorem 4.13(II)], this implies $X_{c}$ is not a toric variety, a contradiction. Thus $c \lambda$ must also avoid the pattern 0011.

Definition 6.4. Let leftmin $\operatorname{lin}_{\alpha}(i)=\min \left\{\alpha_{j}: j \leq i\right\}$ and $\operatorname{rightmax}_{\alpha}(i)=\max \left\{\alpha_{j}: j \geq i\right\}$.
Lemma 6.5. Let $1 \leq i, j \leq n$ and $F \in \operatorname{Tab}(c \lambda)$. Then
(i) $(\mathrm{wt}(F))_{k} \geq \operatorname{leftmin}_{c \lambda}(i)$ for $1 \leq k \leq i$.
(ii) $(\operatorname{wt}(F))_{k} \leq \operatorname{rightmax}_{c \lambda}(j)$ for $j \leq k \leq n$.
(iii) If $i<j$ are in the same block and $\operatorname{leftmin}_{c \lambda}(i)=(c \lambda)_{i}$ and $\operatorname{rightmax}_{c \lambda}(j)=(c \lambda)_{j}$, then $(\mathrm{wt}(F))_{i}=(c \lambda)_{i}$ and $(\mathrm{wt}(F))_{j}=(c \lambda)_{j}$.

Proof. (i): By Definition 6.4 for $1 \leq k \leq i,(c \lambda)_{k} \geq \operatorname{leftmin}_{c \lambda}(i)$. By induction, and the definition of flagged fillings, $F(k, r)=k$ for $1 \leq k \leq i$ and $1 \leq r \leq \operatorname{leftmin}_{c \lambda}(i)$. Thus $(\mathrm{wt}(F))_{k} \geq \operatorname{leftmin}_{c \lambda}(i)$ for $1 \leq k \leq i$.
(ii): Once again we apply Definition 6.4, concluding rightmax ${ }_{c \lambda}(k) \leq \operatorname{rightmax}_{c \lambda}(j)$ for $j \leq k \leq n$. By the definition of flagged fillings a value $k$ can only appear once in a fixed row, and only in columns greater than or equal to $k$. Hence, $(w t(F))_{k} \leq \operatorname{rightmax}_{c \lambda}(k) \leq$ $\operatorname{rightmax}_{c \lambda}(j)$.
(iii): If $i, j$ are in the same block, then Lemma 6.1, applied inductively, implies $(c \lambda)_{k} \geq$ $(c \lambda)_{j}$ for $i \leq k \leq j$. This, combined with leftmin ${ }_{c \lambda}(i)=(c \lambda)_{i}$, implies that leftmin ${ }_{c \lambda}(j)=$ $(c \lambda)_{j}$. Applying (i) and (ii) to $j$ yields $(w t(F))_{j} \geq(c \lambda)_{j}$ and $(w t(F))_{j} \leq(c \lambda)_{j}$. Hence $(\mathrm{wt}(F))_{j}=(c \lambda)_{j}$.

Additionally, $(c \lambda)_{k} \geq(c \lambda)_{j}$ for $i \leq k \leq j$ combined with $\operatorname{rightmax}_{c \lambda}(j)=(c \lambda)_{j}$ gives rightmax $_{c \lambda}(i)=(c \lambda)_{i}$. Applying (i) and (ii) to $i$ again yields the desired equality.

Lemma 6.6. Let $i \leq j$ with $(c \lambda)_{k} \geq(c \lambda)_{k+1}$ for $i \leq k<j$. Let $m$ be the maximum value such that $i \leq m \leq j$ and $(c \lambda)_{m} \geq \operatorname{leftmin}_{c \lambda}(i)$. Then

|\{(d, r) \in D(c \lambda): d \leq m\}|=m \text { for } 1 \leq r \leq \operatorname{leftmin}_{c \lambda}(i)
$$

This implies that for all $F \in \operatorname{Tab}(c \lambda)$,

F(d, r)=d \text { for } 1 \leq r \leq \operatorname{leftmin}_{c \lambda}(i) \text { and } 1 \leq d \leq m .
$$

Proof. This first claim follows from the definition of leftmin $\min _{c \lambda}(i)$. The latter then follows from inductively applying the flagged and row distinct properties of $F$.

Definition 6.7. If $i<j$ with $(c \lambda)_{k} \geq(c \lambda)_{k+1}$ for $i \leq k<j$, leftmin ${ }_{c \lambda}(i)<(c \lambda)_{i}$, and $\operatorname{rightmax}_{c \lambda}(j)>(c \lambda)_{j}$, then we say the pair $(i, j)$ is interweaved. For such an $(i, j)$, define

\operatorname{center}_{c \lambda}(i, j)=\max \left\{k: i \leq k \leq j \text { and }(c \lambda)_{k} \geq \operatorname{rightmax}_{c \lambda}(j)\right\}
$$

$\operatorname{Notice~center~}_{c \lambda}(i, j) \neq-\infty$ since $(c \lambda)_{i} \geq \operatorname{rightmax}_{c \lambda}(j)$ (otherwise, we have leftmin ${ }_{c \lambda}(i)<$ $(c \lambda)_{i}<\operatorname{rightmax}_{c \lambda}(j)$ which says $c \lambda$ contains a 012-pattern, contradicting Lemma6.3,
Lemma 6.8. Let $i<j$ with $(c \lambda)_{k} \geq(c \lambda)_{k+1}$ for $i \leq k<j$. Then
(i) If leftmin ${ }_{c \lambda}(i)=(c \lambda)_{i}$ and rightmax ${ }_{c \lambda}(j)>(c \lambda)_{j}$, then

|\{(d, r) \in D(c \lambda): d>i\}| \leq 1 \text { for } r>(c \lambda)_{i}
$$

(ii) If $\operatorname{leftmin}{ }_{c \lambda}(i)<(c \lambda)_{i}$ and rightmax ${ }_{c \lambda}(j)=(c \lambda)_{j}$, then

$$
|\{(d, r) \in D(c \lambda): d \leq j\}| \geq j-1 \text { for } \text { leftmin }_{c \lambda}(i)<r \leq(c \lambda)_{j}
$$

(iii) If leftmin $\operatorname{cin}_{c \lambda}(i)<(c \lambda)_{i}$ and $\operatorname{rightmax}_{c \lambda}(j)>(c \lambda)_{j}$, then
$\left|\left\{(d, r) \in D(c \lambda): d \geq \operatorname{center}_{c \lambda}(i, j)\right\}\right|=1$ for leftmin $\operatorname{lin}_{c \lambda}(i)<r \leq \operatorname{rightmax}_{c \lambda}(j)$,
and
$\left|\left\{(d, r) \in D(c \lambda): d \leq \operatorname{center}_{c \lambda}(i, j)\right\}\right|=\operatorname{center}_{c \lambda}(i, j)-1$ for $\operatorname{leftmin}_{c \lambda}(i)<r \leq \operatorname{rightmax}_{c \lambda}(j)$.
Proof. (i): Let $r>(c \lambda)_{i}$. If $j<d_{1}<d_{2}$, then $c \lambda$ contains the pattern $\left((c \lambda)_{i},(c \lambda)_{j},(c \lambda)_{d_{1}}\right.$, $\left.(c \lambda)_{d_{2}}\right)$. Suppose that $\left(d_{1}, r\right),\left(d_{2}, r\right) \in D(c \lambda)$. This implies $(c \lambda)_{d_{1}},(c \lambda)_{d_{2}} \geq(c \lambda)_{i}$. This, combined with $(c \lambda)_{i} \geq(c \lambda)_{j}$, implies $\left((c \lambda)_{i},(c \lambda)_{j},(c \lambda)_{d_{1}},(c \lambda)_{d_{2}}\right)$ contains 012, 1032, 0021, 0011, or 1022. This contradicts Lemma 6.3, Thus

|\{(d, r) \in D(c \lambda): d>j\}| \leq 1 \text { for } r>(c \lambda)_{i} .
$$

Further, since $r>(c \lambda)_{i} \geq(c \lambda)_{k}$ for $i \leq k \leq j$,

$$
|\{(d, r) \in D(c \lambda): d>i\}| \leq 1 \text { for } r>(c \lambda)_{i}
$$

(ii): Let leftmin ${ }_{c \lambda}(i)<r \leq(c \lambda)_{j}$. If $d_{1}<d_{2}<i$, then $c \lambda$ contains the pattern $\left((c \lambda)_{d_{1}}\right.$, $\left.(c \lambda)_{d_{2}},(c \lambda)_{i},(c \lambda)_{j}\right)$. Suppose that $\left(d_{1}, r\right),\left(d_{2}, r\right) \notin D(c \lambda)$. This implies $(c \lambda)_{d_{1}},(c \lambda)_{d_{2}} \leq(c \lambda)_{j}$. This, combined with $(c \lambda)_{i} \geq(c \lambda)_{j}$, implies $\left((c \lambda)_{d_{1}},(c \lambda)_{d_{2}},(c \lambda)_{i},(c \lambda)_{j}\right)$ contains 012, 1032, 0021,0011 , or 1022. This contradicts Lemma 6.3. Thus

|\{(d, r) \in D(c \lambda): d \leq i\}| \geq i-1 \text { for } \operatorname{leftmin}_{c \lambda}(i)<r \leq(c \lambda)_{j}
$$

Further, since $r \leq(c \lambda)_{j} \leq(c \lambda)_{k}$ for $i \leq k \leq j$,

|\{(d, r) \in D(c \lambda): d \leq j\}| \geq j-1 \text { for leftmin }{ }_{c \lambda}(i)<r \leq(c \lambda)_{j}
$$

(iii): Let $x$ be an integer such that $x<i$ and $(c \lambda)_{x}=\operatorname{leftmin}_{c \lambda}(i)$, and $y$ be an integer such that $y>j$ and $(c \lambda)_{y}=\operatorname{rightmax}_{c \lambda}(j)$.

Our claim holds vacuously if $(c \lambda)_{x} \geq(c \lambda)_{y}$. Hence, for the rest of the proof we assume $(c \lambda)_{x}<(c \lambda)_{y}$. Now $c \lambda$ contains the pattern $\left((c \lambda)_{x},(c \lambda)_{i},(c \lambda)_{j},(c \lambda)_{y}\right)$ and by Lemma 6.3 this pattern avoids 012 . This, combined with $(c \lambda)_{j}<(c \lambda)_{y}$, implies

It further implies, when combined with $(c \lambda)_{x}<(c \lambda)_{i}$, that

Let $(c \lambda)_{x}<r \leq(c \lambda)_{y}$. Let center ${ }_{c \lambda}(i, j)<d_{1}<d_{2}$. Suppose, to obtain a contradiction, that $\left(d_{1}, r\right),\left(d_{1}, r\right) \in D(c \lambda)$. Then

If $d_{1} \leq j$, then the definition of $\operatorname{center}_{c \lambda}(i, j)$ implies $(c \lambda)_{d_{1}}<(c \lambda)_{y}$. This implies $c \lambda$ contains the pattern $\left((c \lambda)_{x},(c \lambda)_{d_{1}},(c \lambda)_{y}\right)$ which is a 012 pattern. This contradicts Lemma 6.3, Otherwise, if $j<d_{1}<d_{2}$, then $c \lambda$ contains the pattern $\left((c \lambda)_{x},(c \lambda)_{j},(c \lambda)_{d_{1}},(c \lambda)_{d_{2}}\right)$. By (9) and (11), this pattern contains $012,1032,0021,0011$, or 1022 . This contradicts Lemma 6.3, Thus

Let $(c \lambda)_{x}<r \leq(c \lambda)_{y}$. Let $d_{1}<d_{2}<\operatorname{center}_{c \lambda}(i, j)$. Suppose, to obtain a contradiction, that $\left(d_{1}, r\right),\left(d_{2}, r\right) \notin D(c \lambda)$. Thus

If $d_{2} \geq i$, then $(c \lambda)_{d_{2}} \geq(c \lambda)_{j}$ and the definition of center ${ }_{c \lambda}(i, j)$ implies $(c \lambda)_{d_{2}} \geq(c \lambda)_{y}$. This contradicts (13). Otherwise, if $d_{1}<d_{2}<i$, then $c \lambda$ contains $\left((c \lambda)_{d_{1}},(c \lambda)_{d_{2}},(c \lambda)_{i},(c \lambda)_{y}\right)$. By (10) and (13), this pattern contains $012,1032,0021,0011$, or 1022. This contradicts Lemma 6.3. We conclude $\left|\left\{(d, r) \in D(c \lambda): d \leq \operatorname{center}_{c \lambda}(i, j)\right\}\right| \geq \operatorname{center}_{c \lambda}(i, j)-1$. Since $(c \lambda)_{x}<r$, we can strengthen this inequality to

Proposition 6.9. Let $\beta \in \mathcal{P}_{c \lambda, \gamma}, i<j$ in the same block, and $\beta_{i}>\beta_{j}-(j-i)$. Then $t_{i, j} \beta \in \mathcal{P}_{c \lambda, \gamma}$ if and only if
(1) $\operatorname{leftmin}_{c \lambda}(i) \leq \beta_{j}-(j-i)$;
(2) $\operatorname{rightmax}_{c \lambda}(j) \geq \beta_{i}+(j-i)$; and
(3) if $(i, j)$ is interweaved, then

$$
\beta_{1}+\cdots+\beta_{i-1}+\left(\beta_{j}-(j-i)\right)+\beta_{i+1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)} \geq(c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)} .
$$

Proof. $(\Rightarrow)$ We prove the contrapositive. That is, we assume that leftmin ${ }_{c \lambda}(i)>\beta_{j}-(j-i)$, $\operatorname{rightmax}_{c \lambda}(j)<\beta_{i}+(j-i)$, or $(i, j)$ is interweaved with $\beta_{1}+\cdots+\beta_{i-1}+\left(\beta_{j}-(j-i)\right)+$ $\beta_{i+1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}<(c \lambda)_{1}+\cdots(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}$. Let $\tau=t_{i, j} \beta$ and suppose, to seek a contradiction, that $F \in \operatorname{Tab}(c \lambda)$ with $\tau=\mathrm{wt}(F)$.
Case leftmin $\operatorname{ch}_{c \lambda}(i)>\beta_{j}-(j-i)$ : By the case hypothesis, leftmin ${ }_{c \lambda}(i)>\tau_{i}=(w t(F))_{i}$. This contradicts Lemma 6.5(i).
Case rightmax ${ }_{c \lambda}(i)<\beta_{j}+(j-i)$ : By the case hypothesis, $\operatorname{rightmax}_{c \lambda}(i)<\tau_{j}=(\operatorname{wt}(F))_{j}$. This contradicts Lemma6.5(ii).
Case $(i, j)$ is interweaved with $\beta_{1}+\cdots+\beta_{i-1}+\left(\beta_{j}-(j-i)\right)+\beta_{i+1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}<$ $(c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}$ : The case hypothesis implies that $c \lambda \not \mathbb{Z d o m} \tau$. This contradicts Corollary 4.6 .
$(\Leftarrow)$ Since $\left[x^{\beta}\right] \kappa_{c \lambda} \neq 0$, we know there exists an $F \in \operatorname{Tab}(c \lambda)$ with $\mathrm{wt}(F)=\beta$. There are four cases to consider.
Case leftmin ${ }_{c \lambda}(i)=(c \lambda)_{i}$ and $\operatorname{rightmax}_{c \lambda}(j)=(c \lambda)_{j}$ : By Lemma 6.5(iii), $\beta_{i}=(c \lambda)_{i}$ and $\beta_{j}=$ $(c \lambda)_{j}$. Thus

$$
\begin{equation*}
(c \lambda)_{i}=\operatorname{leftmin}_{c \lambda}(i) \leq \beta_{j}-(j-i)=(c \lambda)_{j}-(j-i), \tag{14}
\end{equation*}
$$

where the first equality is the case hypothesis, the inequality is the proposition hypothesis. Thus $j>i$ implies that $(c \lambda)_{i}<(c \lambda)_{j}$. This is a contradiction of Lemma6.1, and hence this case cannot occur.

Case $\operatorname{leftmin}_{c \lambda}(i)=(c \lambda)_{i}$ and $\operatorname{rightmax}_{c \lambda}(j)>(c \lambda)_{j}$ : By Lemma 6.6, $F(d, r)=d$ for all $1 \leq$ $d \leq i$ and $r \leq(c \lambda)_{i}$. Hence, there is an $i$ in every row $r \leq(c \lambda)_{i}$ of $F$, and

$$
\begin{equation*}
\beta_{i} \geq(c \lambda)_{i} \tag{15}
\end{equation*}
$$

The flagged property of $F$, combined with Lemma 6.8(i), implies that either $i$ or $j$, but not both, are in row $r>(c \lambda)_{i}$ of $F$. By the definition of $F$ and (15), there are exactly $\beta_{i}-$ $(c \lambda)_{i} \geq 0$ such rows containing only $i$, but not $j$. By the case and proposition hypotheses,

\beta_{i}-(c \lambda)_{i}=\beta_{i}-\operatorname{leftmin}_{c \lambda}(i) \geq \beta_{i}-\left(\beta_{j}-(j-i)\right)>0
$$

Setting $v:=\beta_{i}-\left(\beta_{j}-(j-i)\right)$ we can choose $v$ rows $r_{1}, \ldots, r_{v}>(c \lambda)_{i}$ in $F$ that contain $i$ and not $j$.

The filling $G$ is obtained from $F$ by changing the $i$ in rows $r_{1}, \ldots, r_{v}$ to a $j$. By construction, $G$ is row distinct. For $i \leq k \leq j$, the boxes $\left(k, r_{1}\right), \ldots\left(k, r_{v}\right) \notin D(c \lambda)$ since $r_{1}, \ldots, r_{v}>(c \lambda)_{i} \geq(c \lambda)_{k}$. Hence the flagged property of $F$ implies that the $i$ in these rows of $F$ must appear in a column strictly greater than $j$. Thus the $j$ in these rows of $G$ appears in a column greater than $j$, and $G$ is flagged.

Let $\tau=\operatorname{wt}(G)$. Then $\tau_{i}=\beta_{i}-v=\beta_{i}-\left(\beta_{i}-\left(\beta_{j}-(j-i)\right)\right)=\beta_{j}-(j-i), \tau_{j}=\beta_{j}+v=$ $\beta_{j}+\left(\beta_{i}-\left(\beta_{j}-(j-i)\right)\right)=\beta_{i}+(j-i)$. Otherwise, $\tau_{k}=\beta_{k}$ for $r \neq i, j$. Thus $\tau=t_{i, j} \beta$. We conclude that $t_{i, j} \beta$ is an exponent vector of $\kappa_{c \lambda}$.
Case leftmin ${ }_{c \lambda}(i)<(c \lambda)_{i}$ and rightmax ${ }_{c \lambda}(j)=(c \lambda)_{j}$ : The row distinct and flagged properties of $F$, combined with Lemma 6.6 and Lemma 6.8(ii), imply that at least one of $i$ or $j$ are in row $r$ of $F$ for $1 \leq r \leq(c \lambda)_{j}$. By the case and proposition hypotheses, $\beta_{j}<\beta_{i}+(j-i) \leq$ $\operatorname{rightmax}_{c \lambda}(j)=(c \lambda)_{j}$.

Hence, there are at least $(c \lambda)_{j}-\beta_{j}$ rows $r$, with $1 \leq r \leq(c \lambda)_{j}$, of $F$ that contain $i$ but not $j$. Setting $v:=\beta_{i}+(j-i)-\beta_{j} \leq(c \lambda)_{j}-\beta_{j}$, we choose $v$ rows in $F, r_{1}, \ldots, r_{v} \leq(c \lambda)_{j}$, that contain $i$ but not $j$. By Lemma 6.8 (ii) and the flagged property of $F$, for each $e \in$ $\left\{r_{1}, \ldots, r_{v}\right\}$ there is exactly one $d_{e} \leq j$ such that $\left(d_{e}, e\right) \notin D(c \lambda)$. It follows, by the definition of $e$ and the flagged property of $F$, that the content of row $e$ in the first $j$ columns of $F$ is equal to $\{1, \ldots, j-1\}$. We use this fact to define the filling $G$.

The filling $G$ is obtained from $F$ via the following rule. Let $1 \leq e \leq \lambda_{1}$, then
(i) $e \notin\left\{r_{1}, \ldots, r_{v}\right\}$ : The $e$-th row of $G$ equals the $e$-th row of $F$.
(ii) $e \in\left\{r_{1}, \ldots, r_{v}\right\}$ : The $e$-th row of $G$ is defined by filling each of the values in $[j] \backslash\{i\}$ in the minimal column possible. Explicitly, $G(d, e)=d$ for $d<d_{e}, G(d, e)=d-1$ for $d_{e}<d \leq i, G(d, e)=d$ for $i<r<j$. Then, set $G(j, e)=j$, and for any column greater than $j$ the entries in row $e$ of $F$ and $G$ coincide.

Clearly $G$ is row distinct; for $e \in\left\{r_{1}, \ldots, r_{v}\right\}$, the content of row $e$ of $G$ is equal to the content of row $e$ of $F$ with the unique $i$ replaced by $j$. It is equally easy to verify that each of (i)-(ii) leaves the respective column in $G$ satisfying the flagged constraint. Let $\tau=\mathrm{wt}(G)$. Then $\tau_{i}=\beta_{i}-v=\beta_{i}-\left(\beta_{i}+(j-i)-\beta_{j}\right)=\beta_{j}-(j-i), \tau_{j}=\beta_{j}+v=$ $\beta_{j}+\left(\beta_{i}+(j-i)-\beta_{j}\right)=\beta_{i}+(j-i)$. Otherwise, $\tau_{k}=\beta_{k}$ for $k \neq i, j$. Thus $\tau=t_{i, j} \beta$. We conclude that $t_{i, j} \beta$ is an exponent vector of $\kappa_{c \lambda}$.

Case leftmin $\operatorname{ch}_{c \lambda}(i)<(c \lambda)_{i}$ and $\operatorname{rightmax}_{c \lambda}(j)>(c \lambda)_{j}$ : Let $x$ be an integer such that $x<i$ and $(c \lambda)_{x}=\operatorname{leftmin}_{c \lambda}(i)$, and $y$ be an integer such that $y>j$ and $(c \lambda)_{y}=\operatorname{rightmax}_{c \lambda}(j)$. Suppose, for sake of contradiction, that $(c \lambda)_{x} \geq(c \lambda)_{y}$. Then, by Lemma6.5(i), $\beta_{i} \geq(c \lambda)_{x} \geq$ $(c \lambda)_{y}=\operatorname{rightmax}_{c \lambda}(j)$. Thus, $\beta_{i}+(j-i)>\operatorname{rightmax}_{c \lambda}(j)$, which contradicts the hypothesis (2). Thus,

(c \lambda)_{x}<(c \lambda)_{y} \tag{16}
\end{equation*}
$$

Corollary 4.6implies $\beta_{1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)} \geq(c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}$. Now

\mid\left\{(d, r) \in D(c \lambda): d>\operatorname{center}_{c \lambda}(i, j), 1 \leq r \leq(c \lambda)_{y}, \text { and } F(d, r) \leq \operatorname{center}_{c \lambda}(i, j)\right\} \mid= \\
\beta_{1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}\right) \tag{17}
\end{array}
$$

Then our hypothesis $\beta_{1}+\cdots+\beta_{i-1}+\left(\beta_{j}-(j-i)\right)+\beta_{i+1}+\cdots+\beta_{\text {center }_{c \lambda}(i, j)} \geq(c \lambda)_{1}+$ $\cdots+(c \lambda)_{\text {center }_{c \lambda}(i, j)}$ is equivalent to $\beta_{1}+\cdots+\beta_{\text {center }_{c \lambda}(i, j)}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{\text {center }_{c \lambda}(i, j)}\right) \geq$ $\beta_{i}-\left(\beta_{j}-(j-i)\right)$. Applying this to (17) yields

\mid\left\{(d, r) \in D(c \lambda): d>\operatorname{center}_{c \lambda}(i, j), 1 \leq r \leq(c \lambda)_{y}, \text { and } F(d, r) \leq \operatorname{center}_{c \lambda}(i, j)\right\} \mid \geq \\
\beta_{i}-\left(\beta_{j}-(j-i)\right) . \tag{18}
\end{array}
$$

We can further refine (18). By the definition of $\operatorname{center}_{c \lambda}(i, j)$, (16), and Lemma6.1, $(c \lambda)_{d} \geq$ $(c \lambda)_{x}$ for all $i \leq d \leq \operatorname{center}_{c \lambda}(i, j)$. By Lemma 6.6, $F(d, r)=d$ for all $d \leq \operatorname{center}_{c \lambda}(i, j)$ and $r \leq(c \lambda)_{x}$. Thus, the row distinct property of $F$ transforms (18) into

\geq \beta_{i}-\left(\beta_{j}-(j-i)\right) .
\end{array}
$$

By Lemma 6.8(iii), the rows $(c \lambda)_{x}<r \leq c \lambda \leq(c \lambda)_{y}$ have center $_{c \lambda}(i, j)$ boxes in $D(c \lambda)$. By (19), we can pick $v:=\beta_{i}-\left(\beta_{j}-(j-i)\right)$ of these rows, where the center ${ }_{c \lambda}(i, j)$ many boxes of $D(c \lambda)$ are filled using precisely the labels $1,2, \ldots$, center $_{c \lambda}(i, j)$. By Lemma 6.8(iii), for each $e \in\left\{r_{1}, \ldots, r_{v}\right\}$ there is exactly one $d_{e} \leq \operatorname{center}_{c \lambda}(i, j)$ such that $\left(d_{e}, e\right) \notin D(c \lambda)$.

The filling $G$ is obtained from $F$ via the following rule. Let $1 \leq e \leq \lambda_{1}$.
(i) $e \notin\left\{r_{1}, \ldots, r_{v}\right\}$ : The $e$-th row of $G$ equals the $e$-th row of $F$.
(ii) The $e$-th row of $G$ is defined by filling each of the values in [center $\left.{ }_{c \lambda}(i, j)-1\right] \backslash\{i\}$ in the minimal column possible. Explicitly, $G(d, e)=d$ for $d<d_{e}, G(d, e)=d-1$ for $d_{e}<d \leq i, G(d, e)=d$ for $i<d \leq \operatorname{center}_{c \lambda}(i, j)$. Then set the value of the unique box in a column greater than center $_{c \lambda}(i, j)$ to be $j$.

Clearly $G$ is row distinct; for $e \in\left\{r_{1}, \ldots, r_{v}\right\}$, the content of row $e$ of $G$ is equal to the content of row $e$ of $F$ with the unique $i$ replaced by $j$. It is an easy check to verify that each of (i)-(ii) leaves the respective row in $G$ satisfying the flagged constraint. Let $\tau=\mathrm{wt}(G)$. Then $\tau_{i}=\beta_{i}-v=\beta_{i}-\left(\beta_{i}-\left(\beta_{j}-(j-i)\right)\right)=\beta_{j}-(j-i), \tau_{j}=\beta_{j}+v=\beta_{j}+\left(\beta_{i}-\left(\beta_{j}-(j-i)\right)\right)=$ $\beta_{i}+(j-i)$. Otherwise, $\tau_{k}=\beta_{k}$ for $k \neq i, j$. Thus $\tau=t_{i} \beta$. We conclude that $t_{i} \beta$ is an exponent vector of $\kappa_{c \lambda}$.

Lemma 6.10. Let $i \in[n-1]$ and $\beta \in \mathcal{P}_{c \lambda, \gamma}$. Then $\max \left\{\operatorname{rightmax}_{c \lambda}(i+1)-\operatorname{leftmin}_{c \lambda}(i), 0\right\} \geq \beta_{1}+\cdots+\beta_{i}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{i}\right)$.

Proof. Since $\left[x^{\beta}\right] \kappa_{c \lambda} \neq 0$, there exists an $F \in \operatorname{Tab}(c \lambda)$ with $\operatorname{wt}(F)=\beta$. Now,

\begin{equation*}
\mid\{(d, r) \in D(c \lambda): d>i \text { and } F(d, r) \leq i\} \mid=\beta_{1}+\cdots+\beta_{i}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{i}\right) \tag{20}
\end{equation*}
$$

We first prove this lemma for $i \in[n-1]$ with $(c \lambda)_{i} \geq(c \lambda)_{i+1}$. Let $r \leq \operatorname{leftmin}_{c \lambda}(i)$. Lemma 6.6 implies that $F\left(d_{1}, r\right)=d_{1}$ for $d_{1} \leq i$ and $r \leq \operatorname{leftmin}_{c \lambda}(i)$. Since $F$ is row distinct this implies

\mid\{(d, r) \in D(c \lambda): d>i \text { and } F(d, r) \leq i\} \mid=0 \text { for } 1 \leq r \leq \operatorname{leftmin}_{c \lambda}(i) \tag{21}
\end{equation*}

Suppose leftmin $\operatorname{cin}_{c \lambda}(i) \geq \operatorname{rightmax}_{c \lambda}(i+1)$. Then there exist no $(d, r) \in D(c \lambda)$ such that $d>i$ and $r>\operatorname{leftmin}_{c \lambda}(i)$. This, combined with (20) and (21), implies $\beta_{1}+\cdots+\beta_{i}-$ $\left((c \lambda)_{1}+\cdots+(c \lambda)_{i}\right)=0$. Thus our result trivially holds.

For the rest of the proof we assume leftmin $\operatorname{cin}_{c \lambda}(i)<\operatorname{rightmax}_{c \lambda}(i+1)$.
Case leftmin ${ }_{c \lambda}(i)=(c \lambda)_{i}$ and rightmax $_{c \lambda}(i+1)=(c \lambda)_{i+1}$ : By our assumption $(c \lambda)_{i} \geq(c \lambda)_{i+1}$ and the case hypothesis, $\operatorname{leftmin}_{c \lambda}(i)=(c \lambda)_{i} \geq(c \lambda)_{i+1}=\operatorname{rightmax}_{c \lambda}(i+1)$. Thus, since we are assuming leftmin ${ }_{c \lambda}(i)<\operatorname{rightmax}_{c \lambda}(i+1)$, this case does not occur.
Case leftmin $\operatorname{ch}^{\prime}(i)=(c \lambda)_{i}$ and $\operatorname{rightmax}_{c \lambda}(i+1)>(c \lambda)_{i+1}$ : We have that leftmin ${ }_{c \lambda}(i)=(c \lambda)_{i}$ paired with (21), and combined with Lemma 6.8(i) implies

$$
\mid\{(d, r) \in D(c \lambda): d>i \text { and } F(d, r) \leq i\} \mid \leq \operatorname{rightmax}_{c \lambda}(i+1)-\operatorname{leftmin}_{c \lambda}(i)
$$

Then (20) gives the required inequality.
Case leftmin ${ }_{c \lambda}(i)<(c \lambda)_{i}$ and $\operatorname{rightmax}_{c \lambda}(i+1)=(c \lambda)_{i+1}$ : Lemma6.6(ii) says

$$
|\{(d, r) \in D(c \lambda): d \leq i+1\}| \geq i \text { for leftmin }{ }_{c \lambda}(i)<r \leq(c \lambda)_{i+1},
$$

which implies

$$
\begin{equation*}
|\{(d, r) \in D(c \lambda): d \leq i\}| \geq i-1 \text { for leftmin }{ }_{c \lambda}(i)<r \leq(c \lambda)_{i+1} . \tag{22}
\end{equation*}
$$

Since $\operatorname{rightmax}_{c \lambda}(i+1)=(c \lambda)_{i+1}$, there exist no $(d, r) \in D(c \lambda)$ such that $d>i$ and $r>$ $(c \lambda)_{i+1}$. This, combined with (21), and the row distinct property of $F$ paired with (22), implies that

$$
\mid\{(d, r) \in D(c \lambda): d>i \text { and } F(d, r) \leq i\} \mid \leq \operatorname{rightmax}_{c \lambda}(i+1)-\operatorname{leftmin}_{c \lambda}(i)
$$

Applying (20) concludes the proof in this case.
Case leftmin ${ }_{c \lambda}(i)<(c \lambda)_{k}$ and rightmax ${ }_{c \lambda}(i+1)>(c \lambda)_{i+1}$ : There exist no $(d, r) \in D(c \lambda)$ such that $d>i$ and $r>\operatorname{rightmax}_{c \lambda}(i+1)$. We apply Lemma6.8(iii), noting that center ${ }_{c \lambda}(i, i+1)=$ $i$, and (21) to imply that

$$
\mid\{(d, r) \in D(c \lambda): d>i \text { and } F(d, r) \leq i\} \mid \leq \operatorname{rightmax}_{c \lambda}(i+1)-\operatorname{leftmin}_{c \lambda}(i) .
$$

Once again we conclude after applying (20).
This completes the proof for $i$ such that $(c \lambda)_{i} \geq(c \lambda)_{i+1}$. Otherwise, $i \in[n-1]$ with $(c \lambda)_{i}<(c \lambda)_{i+1}$. If $i=1$ or $i=n-1$ the proof is straightforward. Otherwise, let $x<i<$ $i+1<y$. Then

(c \lambda)_{i+1} \geq(c \lambda)_{y} \tag{23}
\end{equation*}
$$

and $(c \lambda)_{x} \geq(c \lambda)_{i}$ by Lemma 6.3 (012-avoidance). If $(c \lambda)_{x}<(c \lambda)_{y}$, then $c \lambda$ contains the composition pattern 012, 1032, 0021, 0011, or 1022. This contradicts Lemma 6.3. Thus $(c \lambda)_{x} \geq(c \lambda)_{y}$ for all $x<i$. This implies leftmin ${ }_{c \lambda}(i-1) \geq(c \lambda)_{y}$ for all $i+1<y$. We conclude leftmin $_{c \lambda}(i-1) \geq \operatorname{rightmax}_{c \lambda}(i+2)$. By Lemma6.6(the second displayed equation, where we have applied it to $i-1$ ) and the row distinct property of $F$, this implies

\mid\left\{(d, r) \in D(c \lambda): d>i, 1 \leq r \leq \operatorname{rightmax}_{c \lambda}(i+2), \text { and } F(d, r) \leq i-1\right\} \mid=0 . \tag{24}
\end{equation*}

Then leftmin ${ }_{c \lambda}(i)=(c \lambda)_{i}$ by Lemma 6.3 (012-avoidance) and, combined with Lemma 6.6 applied to $i$, this implies

$$
\begin{equation*}
\mid\left\{(d, r) \in D(c \lambda): d>i, 1 \leq r \leq \operatorname{leftmin}_{c \lambda}(i), \text { and } F(d, r) \leq i\right\} \mid=0 \tag{25}
\end{equation*}
$$

Now

$$
\begin{aligned}
\mid\{(d, r) \in D(c \lambda): d>i \text { and } F(d, r) \leq i\} \mid & \leq(c \lambda)_{i+1}-\operatorname{leftmin}_{c \lambda}(i) \\
& =\operatorname{rightmax}_{c \lambda}(i+1)-\operatorname{leftmin}_{c \lambda}(i) .
\end{aligned}
$$

The inequality comes by studying the intervals $\left[1, \operatorname{leftmin}_{c \lambda}(i)\right]$, $\left(\operatorname{leftmin}{ }_{c \lambda}(i)\right.$, rightmax ${ }_{c \lambda}(i+$ $2)]$, and (rightmax $\left.{ }_{c \lambda}(i+2),(c \lambda)_{i+1}\right]$. Respectively, we use (25), and (24) paired with the row distinct property of $F$, for the first two intervals. For the third interval, we use the fact that there is at most one column, namely $y=i+1$, such that $y>d$ and $(c \lambda)_{y}>\operatorname{rightmax}_{c \lambda}(i+2)$. The equality follows from (23).
Lemma 6.11. Let $i<p<j<q$ be in the same block and $\beta \in \mathcal{P}_{c \lambda, \gamma}$. If $(i, j)$ and $(p, q)$ are interweaved, $\beta<_{\text {Bruhat }} t_{i, j} \beta$, and $\beta<_{\text {Bruhat }} t_{p, q} \beta$, then $t_{i, j} \beta \notin \mathcal{P}_{c \lambda, \gamma}$ or $t_{p, q} \beta \notin \mathcal{P}_{c \lambda, \gamma}$.

Proof. If $(i, j)$ and $(p, q)$ are interweaved, then it is straightforward that center ${ }_{c \lambda}(i, j)=$ center $_{c \lambda}(p, q)$. Lemma 6.1 and the definition of $\operatorname{center}_{c \lambda}(i, j)$ implies

$$
(c \lambda)_{k}=\operatorname{rightmax}_{c \lambda}(k) \text { for } i \leq k \leq \operatorname{center}_{c \lambda}(p, q),
$$

which in turn implies, via Lemma6.5(ii), that

$$
\begin{equation*}
\beta_{k}-(c \lambda)_{k} \leq 0 \text { for } i \leq k \leq \operatorname{center}_{c \lambda}(p, q) \tag{26}
\end{equation*}
$$

In a similar fashion, the definition of $\operatorname{center}_{c \lambda}(i, j)$ and Lemma6.3(012-avoidance) implies $(c \lambda)_{k}=\operatorname{leftmin}_{c \lambda}(k)$ for $\operatorname{center}_{c \lambda}(p, q)<k \leq q$. Hence, Lemma6.5(i) says

$$
\begin{equation*}
\beta_{k}-(c \lambda)_{k} \geq 0 \text { for }^{\operatorname{center}}{ }_{c \lambda}(p, q)<k \leq q \tag{27}
\end{equation*}
$$

Suppose that $t_{i, j} \beta, t_{p, q} \beta \in \mathcal{P}_{c \lambda, \gamma}$. Let $C:=\beta_{1}+\cdots+\beta_{\text {center }_{c \lambda}(i, j)}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}\right)$. Then,

$$
\begin{align*}
\operatorname{rightmax}_{c \lambda}(q)-(c \lambda)_{q} & =\operatorname{rightmax}_{c \lambda}(q+1)-\operatorname{leftmin}_{c \lambda}(q) \\
& \geq C+\left(\beta_{\text {center }_{c \lambda}(i, j)+1}+\cdots+\beta_{q}\right)-\left((c \lambda)_{\operatorname{center}_{c \lambda}(i, j)+1}+\cdots(c \lambda)_{q}\right)  \tag{28}\\
& \geq C+\left(\beta_{j}-(c \lambda)_{j}\right)+\left(\beta_{q}-(c \lambda)_{q}\right),
\end{align*}
$$

where the equality follows from the interweaving assumption combined with Lemma 6.3 (012-avoidance), the first inequality comes from Lemma 6.10 applied to $\beta$, and the final inequality follows from (27).

Proposition 6.9(3) says
$\beta_{1}+\cdots+\beta_{i-1}+\left(\beta_{j}-(j-i)\right)+\beta_{i+1}+\cdots+\beta_{\text {center }_{c \lambda}(i, j)} \geq(c \lambda)_{1}+\cdots+(c \lambda)_{\text {center }_{c \lambda}(i, j)}$,
(30) $\beta_{1}+\cdots+\beta_{p-1}+\left(\beta_{q}-(q-p)\right)+\beta_{p+1}+\cdots+\beta_{\text {center }_{c \lambda}(i, j)} \geq(c \lambda)_{1}+\cdots+(c \lambda)_{\text {center }_{c \lambda}(i, j)}$.

Let $D:=\left(\beta_{i+1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}\right)-\left((c \lambda)_{i+1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}\right)$. Reformulating (29) yields

$$
\begin{align*}
0 & \leq\left(\beta_{1}+\cdots+\beta_{i-1}\right)-\left((c \lambda)_{1}+\cdots+(c \lambda)_{i-1}\right)+\left(\beta_{j}-(j-i)-(c \lambda)_{i}\right)+D \\
& \leq(c \lambda)_{i}-\operatorname{leftmin}_{c \lambda}(i)+\left(\beta_{j}-(j-i)-(c \lambda)_{i}\right)+D \\
& =(c \lambda)_{i}-\operatorname{leftmin}_{c \lambda}(i)+\left((c \lambda)_{j}+\left(\beta_{j}-(c \lambda)_{j}\right)-(j-i)-(c \lambda)_{i}\right)+D  \tag{31}\\
& =\left((c \lambda)_{j}-\operatorname{leftmin}_{c \lambda}(i)\right)+\left(\beta_{j}-(c \lambda)_{j}\right)-(j-i)+D \\
& \leq\left(\beta_{j}-(c \lambda)_{j}\right)-(j-i)+D,
\end{align*}
$$

where the second inequality is via Lemma 6.10 applied to $\beta$ (note $(c \lambda)_{i}=\operatorname{rightmax}_{c \lambda}(i)$ here), and the final inequality follows from Lemma 6.3(012-avoidance).

Let $E:=\left(\beta_{p+1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}\right)-\left((c \lambda)_{p+1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}\right)$. Reformulating (30),

$$
\begin{aligned}
0 & \leq\left(\beta_{1}+\cdots+\beta_{p-1}\right)-\left((c \lambda)_{1}+\cdots+(c \lambda)_{p-1}\right)+\left(\beta_{q}-(q-p)-(c \lambda)_{p}\right)+E \\
& \leq\left(\beta_{1}+\cdots+\beta_{i}\right)-\left((c \lambda)_{1}+\cdots+(c \lambda)_{i}\right)+\left(\beta_{q}-(q-p)-(c \lambda)_{p}\right)+E \\
& \leq\left(\beta_{1}+\cdots+\beta_{i}\right)-\left((c \lambda)_{1}+\cdots+(c \lambda)_{i}\right)+\left(\beta_{q}-(q-p)-(c \lambda)_{p}\right) \\
& \leq\left(\beta_{1}+\cdots+\beta_{i}\right)-\left((c \lambda)_{1}+\cdots+(c \lambda)_{i}\right)+\left(\beta_{q}-(q-p)-\operatorname{rightmax}_{c \lambda}(q)\right) \\
& =\left(\beta_{1}+\cdots+\beta_{i}\right)-\left((c \lambda)_{1}+\cdots+(c \lambda)_{i}\right)+\left((c \lambda)_{q}+\left(\beta_{q}-(c \lambda)_{q}\right)-(q-p)-\operatorname{rightmax}_{c \lambda}(q) .\right.
\end{aligned}
$$

where the second and third inequality are by (26), the fourth inequality is by Lemma 6.3 (012-avoidance).

Adding (31) and (32) we have

0 \leq C+\left(\beta_{j}-(c \lambda)_{j}\right)+\left(\beta_{q}-(c \lambda)_{q}\right)-(j-i)-(q-p)+\left((c \lambda)_{q}-\operatorname{rightmax}_{c \lambda}(q)\right) \tag{33}
\end{equation*}
$$

which can be reformulated into

$$
\begin{align*}
\operatorname{rightmax}_{c \lambda}(q)-(c \lambda)_{q} & \leq C+\left(\beta_{j}-(c \lambda)_{j}\right)+\left(\beta_{q}-(c \lambda)_{q}\right)-(j-i)-(q-p) \\
& <C+\left(\beta_{j}-(c \lambda)_{j}\right)+\left(\beta_{q}-(c \lambda)_{q}\right) \tag{34}
\end{align*}
$$

This, combined with (28), gives our desired contradiction. We conclude that $t_{i, j} \beta \notin \mathcal{P}_{c \lambda, \gamma}$ or $t_{p, q} \beta \notin \mathcal{P}_{c \lambda, \gamma}$.

Conclusion of the proof of Theorem 5.3. Without loss of generality assume $(i, j)<(p, q)$ in lexicographic order. Both $\tau:=t_{i, j} \beta$ and $\phi:=t_{p, q} \beta$ cover $\beta$, thus

\beta_{p}>\beta_{q}-(q-p) & =\phi_{p} \tag{36}
\end{align*}
$$

By Proposition 6.9, we have

\beta_{i}+(j-i) \leq \operatorname{rightmax}_{c \lambda}(j),  \tag{37}\\
\beta_{p}+(q-p) \leq \operatorname{rightmax}_{c \lambda}(q),  \tag{38}\\
\beta_{j}-(j-i) \geq \operatorname{leftmin}_{c \lambda}(i)  \tag{39}\\
\beta_{q}-(q-p) \geq \operatorname{leftmin}_{c \lambda}(p) . \tag{40}
\end{gather*}
$$

Moreover, for the same reason, if $(i, j)$ is interweaved, then

$$
\begin{equation*}
\beta_{1}+\cdots+\beta_{i-1}+\beta_{j}-(j-i)+\beta_{i+1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)} \geq(c \lambda)_{1}+\cdots+(c \lambda)_{\text {center }_{c \lambda}(i, j)} . \tag{41}
\end{equation*}
$$

If $(p, q)$ is interweaved, then
(42) $\beta_{1}+\cdots+\beta_{p-1}+\beta_{q}-(q-p)+\beta_{p+1}+\cdots+\beta_{\text {center }_{c \lambda}(p, q)} \geq(c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(p, q)}$.

We now consider five cases depending on the overlap in the values $(i, j)$ and $(p, q)$. In what follows, we will make repeated use of Lemma 3.9(i), which characterizes the covering relation in $\left(\mathcal{S}_{\gamma, I},<_{\text {Bruhat }}\right)$.
Case 1.1 ( $i$ and $p$ in the same block, $i=p, j<q$ ): Suppose, for contradiction, that $\beta_{j}-(j-i)=$ $\beta_{q}-(q-p)$. Then, since $i=p$, this equality is equivalent to $\beta_{j}=\beta_{q}-(q-j)$. The contradicts Lemma3.9(i), and hence $\beta_{j}-(j-i) \neq \beta_{q}-(q-p)$.

Subcase 1.1.1 $\beta_{j}-(j-i)>\beta_{q}-(q-p)$ : By the subcase hypothesis, $t_{i, j} \beta<_{\text {Bruhat }} t_{p, q} t_{i, j} \beta$. Then $t_{p, q} t_{i, j} \beta<_{\text {Bruhat }} t_{j, q} t_{p, q} t_{i, j} \beta$ by (35). Combining, we have $t_{i, j} \beta<_{\text {Bruhat }} t_{j, q} t_{p, q} t_{i, j} \beta=t_{p, q} \beta$. This contradicts the hypothesis that $t_{p, q} \beta$ covers $\beta$. Hence this subcase cannot occur.
Subcase 1.1.2 $\beta_{j}-(j-i)<\beta_{q}-(q-p)$ : We will show that $t_{i, j} \phi \in \mathcal{P}_{c \lambda, \gamma}$. By the subcase hypothesis, the definition of $\phi$, and $i=p$,

$$
\begin{equation*}
\phi_{i}=\phi_{p}=\beta_{q}-(q-p) \geq \beta_{j}-(j-i-1)=\phi_{j}-(j-i-1) \tag{43}
\end{equation*}
$$

By (36), (37), and $i=p$ we have

\begin{equation*}
\phi_{i}+(j-i)=\beta_{q}-(q-p)+(j-i)<\beta_{p}+(j-i)=\beta_{i}+(j-i) \leq \operatorname{rightmax}_{c \lambda}(j) \tag{44}
\end{equation*}
$$

Since $\phi_{j}=\beta_{j}$, by (39),

$$
\begin{equation*}
\phi_{j}-(j-i)=\beta_{j}-(j-i) \geq \operatorname{leftmin}_{c \lambda}(i) \tag{45}
\end{equation*}
$$

Finally, $\phi_{r}=\beta_{r}$ for $r \neq p, q$. If $(i, j)$ is interweaved, then (41) and $i=p$ combined with the previous sentence implies

$$
\begin{align*}
\phi_{1}+\cdots+\phi_{i-1}+\phi_{j}-(j-i)+\phi_{i+1}+\cdots+\phi_{\operatorname{center}_{c \lambda}(i, j)} & =\beta_{1}+\cdots+\beta_{i-1}+\beta_{j}-(j-i) \\
& +\beta_{i+1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}  \tag{46}\\
\geq & (c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)} .
\end{align*}
$$

The hypotheses of Proposition 6.9 are satisfied for for $t_{i, j} \phi$ by (43), (44), (45), and (46). Hence, $t_{i, j} \phi \in \mathcal{P}_{c \lambda, \gamma}$.

By (43), $\phi<t_{i, j} \phi$. By (36), $\beta_{i}+(j-i)=\beta_{p}+(j-i)>\beta_{q}-(q-p)+(j-i)=\beta_{q}-(q-j)$, and hence $\tau=t_{i, j} \beta<_{\text {Bruhat }} t_{j, q} t_{i, j} \beta=t_{i, j} \phi$.
Case 1.2 ( $i$ and $p$ in the same block, $i<p, j=p$ ): In this case,

$$
\begin{gather*}
\tau_{p}=\beta_{i}+(j-i)>\beta_{j} \geq \beta_{q}-(q-p-1)=\tau_{q}-(q-p-1)  \tag{47}\\
\phi_{i}=\beta_{i} \geq \beta_{j}-(j-i-1) \geq \beta_{q}-(q-p)-(j-i-1)=\phi_{j}-(j-i-1) . \tag{48}
\end{gather*}
$$

Before breaking into subcases we first prove that $\phi<_{\text {Bruhat }} t_{i, j} \phi, t_{p, q} \tau$, and $\tau<_{\text {Bruhat }}$ $t_{i, j} \phi, t_{p, q} \tau$. First, $\phi<_{\text {Bruhat }} t_{i, j} \phi$ and $\tau \ll_{\text {Bruhat }} t_{p, q} \tau$ follow from (48) and (47). Then, (35) implies

$$
\phi_{i}=\beta_{i}>\beta_{j}-(j-i)=\beta_{j}+(q-j)+(q-i)=\phi_{q}-(q-i),
$$

and hence $\phi<_{\text {Bruhat }} t_{i, q} \phi=t_{p, q} \tau$. Finally, by (36),

\tau_{i}=\beta_{j}-(j-i)>\beta_{q}-(q-j)-(j-i)=\tau_{q}-(q-i)
$$

and thus $\tau<_{\text {Bruhat }} t_{i, q} \tau=t_{i, j} \phi$. Hence, in all the following subcases, it remains to show that at least one of $t_{i, j} \phi$ or $t_{p, q} \tau$ are in $\mathcal{P}_{c \lambda, \gamma}$.
Subcase 1.2.1 $\operatorname{leftmin}_{c \lambda}(i)=(c \lambda)_{i}$ and $\operatorname{rightmax}_{c \lambda}(j)>(c \lambda)_{j}$ : By Lemma 6.1, the subcase hypothesis implies

\operatorname{leftmin}_{c \lambda}(k)=(c \lambda)_{k} \text { for } i \leq k \leq q \tag{49}
\end{equation*}
$$

By Lemma 6.5(i) this implies

$$

\beta_{k} \geq(c \lambda)_{k} \text { for } i \leq k \leq q . \tag{50}
\end{equation*}
$$

In this subcase, (39) and (40) become

& \beta_{j}-(j-i) \geq(c \lambda)_{i}=(c \lambda)_{j}+\left((c \lambda)_{i}-(c \lambda)_{j}\right)  \tag{51}\\
& \beta_{q}-(q-p) \geq(c \lambda)_{p}=(c \lambda)_{q}+\left((c \lambda)_{p}-(c \lambda)_{q}\right) \tag{52}
\end{align*}
$$

Thus

$$
\begin{align*}
\operatorname{rightmax}_{c \lambda}(q)-(c \lambda)_{q}= & \operatorname{rightmax}_{c \lambda}(q+1)-\operatorname{leftmin}_{c \lambda}(q) \\
\geq & \beta_{1}+\cdots+\beta_{q}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{q}\right) \\
= & \left(\sum_{t=1}^{i-1} \beta_{t}-(c \lambda)_{t}\right)+\left[\beta_{i}-(c \lambda)_{i}\right]+\left(\sum_{t=i+1, t \neq p}^{q-1} \beta_{t}-(c \lambda)_{t}\right)  \tag{53}\\
& \quad+\left[\beta_{p}-(c \lambda)_{p}\right]+\left[\beta_{q}-(c \lambda)_{q}\right] \\
\geq & {\left[\beta_{i}-(c \lambda)_{i}\right]+\left[\beta_{p}-(c \lambda)_{p}\right]+\left[\beta_{q}-(c \lambda)_{q}\right] } \\
\geq & {\left[\beta_{i}-\left(c \lambda_{i}\right)\right]+\left[(j-i)+\left((c \lambda)_{i}-(c \lambda)_{j}\right)\right]+\left[(q-p)+\left((c \lambda)_{p}-(c \lambda)_{q}\right)\right] } \\
= & \beta_{i}+(q-i)-(c \lambda)_{q},
\end{align*}
$$

where the first equality follows from the subcase hypotheses and (49), the first inequality from Lemma 6.10 with rightmax ${ }_{c \lambda}(q+1)-\operatorname{leftmin}_{c \lambda}(q) \geq 0$, the second inequality by Corollary 4.6 , and (50), and third inequality is by (51), (52), and the final equality by $p=j$. Rewriting (53), we arrive at $\operatorname{rightmax}_{c \lambda}(q) \geq \beta_{i}+(q-i)=\tau_{p}+(q-p)$. Further, by (40), $\tau_{q}-(q-p)=\beta_{q}-(q-p) \geq \operatorname{leftmin}_{c \lambda}(p)$. The hypotheses of Proposition6.9 are satisfied for $t_{p, q} \tau$ by the preceding two sentences, the subcase hypothesis, and (47). Hence, $t_{p, q} \tau \in \mathcal{P}_{c \lambda, \gamma}$ (notice $(p, q)$ cannot be interweaved since $j=p$ and $c \lambda$ is 012 -avoiding by Lemma6.3). Subcase 1.2.2 $\operatorname{leftmin}_{c \lambda}(i)<(c \lambda)_{i}$ and $\operatorname{rightmax}_{c \lambda}(j)=(c \lambda)_{j}$ : By the subcase hypotheses, $\operatorname{rightmax}_{c \lambda}(k)=(c \lambda)_{k}$ for $i \leq k \leq j$,
and hence by Lemma 6.5(ii)

$$
\begin{equation*}
\beta_{k} \leq(c \lambda)_{k} \text { for } i \leq k \leq j \tag{55}
\end{equation*}
$$

In this subcase, (37) becomes

$$
\begin{equation*}
\beta_{i}+(j-i) \leq(c \lambda)_{j}=(c \lambda)_{i}+\left((c \lambda)_{j}-(c \lambda)_{i}\right) \tag{56}
\end{equation*}
$$

By Corollary 4.6 applied to $\phi=t_{p, q} \beta$,

$$
\begin{equation*}
\beta_{1}+\cdot+\beta_{i-1}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{i-1}\right) \geq-\left(\left(\beta_{i}+\cdots+\beta_{j-1}+\left(\beta_{q}-(q-p)\right)-\left((c \lambda)_{i}+\cdot+(c \lambda)_{j}\right)\right) .\right. \tag{57}
\end{equation*}
$$

We conclude

$$
\begin{aligned}
(c \lambda)_{i}-\operatorname{leftmin}_{c \lambda}(i) & =\operatorname{rightmax}_{c \lambda}(i)-\operatorname{leftmin}_{c \lambda}(i-1) \\
& \geq \beta_{1}+\cdots+\beta_{i-1}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{i-1}\right) \\
& \geq-\left(\left(\beta_{i}+\cdots+\beta_{j-1}+\left(\beta_{q}-(q-p)\right)-\left((c \lambda)_{i}+\cdots+(c \lambda)_{j}\right)\right)\right. \\
& =-\left(\sum_{t=i+1}^{j-1} \beta_{t}-(c \lambda)_{t}\right)-\left[\beta_{i}-(c \lambda)_{i}\right]-\left[\beta_{q}-(q-p)-(c \lambda)_{j}\right] \\
& \geq-\left[\beta_{i}-(c \lambda)_{i}\right]-\left[\beta_{q}-(q-p)-(c \lambda)_{j}\right] \\
& \geq-\left[-(j-i)+\left((c \lambda)_{j}-(c \lambda)_{i}\right)\right]-\left[\left(\beta_{q}-(q-p)-(c \lambda)_{j}\right]\right. \\
& =(q-i)-\left(\beta_{q}-(c \lambda)_{i}\right) ;
\end{aligned}
$$

the first equality follows by the subcase hypotheses, the first inequality from Lemma 6.10 with rightmax ${ }_{c \lambda}(i)-\operatorname{leftmin}_{c \lambda}(i-1) \geq 0$, the second inequality by (57), the third inequality by (55), the fourth by (56), and the final equality by $p=j$. Now (58) is equivalent to

$$
\operatorname{leftmin}_{c \lambda}(i) \leq \beta_{q}-(q-i)=\phi_{j}-(j-i)
$$

Further, by (37),

$$
\phi_{i}+(j-i)=\beta_{i}+(j-i) \geq \operatorname{rightmax}_{c \lambda}(j) .
$$

The hypotheses of Proposition 6.9 are satisfied for for $t_{i, j} \phi$ by the preceding two sentences, the subcase hypothesis, and (48). Hence, $t_{i, j} \phi \in \mathcal{P}_{c \lambda, \gamma}$.
Subcase 1.2.3 $\operatorname{leftmin}_{c \lambda}(i)<(c \lambda)_{i}, \operatorname{rightmax}_{c \lambda}(j)>(c \lambda)_{j}$ : In this subcase, leftmin ${ }_{c \lambda}(j)=(c \lambda)_{j}$, since leftmin ${ }_{c \lambda}(j)<(c \lambda)_{j}$ would imply that $c \lambda$ contains 012 . Thus, since $(i, j)$ is interweaved, $\operatorname{center}_{c \lambda}(i, j)<j$ and Lemma 6.1implies

$$
\begin{equation*}
\operatorname{leftmin}_{c \lambda}(k)=(c \lambda)_{k} \text { for center }{ }_{c \lambda}(i, j)<k \leq q \tag{59}
\end{equation*}
$$

Corollary 4.6, applied to $\beta$ and $\tau$, respectively, implies

$$
\left(\beta_{1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}\right)-\left((c \lambda)_{1}+\cdots+(c \lambda)_{\text {center }_{c \lambda}(i, j)}\right) \geq 0
$$

and
$\left(\beta_{1}+\cdots+\beta_{i-1}+\beta_{j}-(j-i)+\beta_{i+1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}\right)-\left((c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}\right) \geq 0$.
These two inequalities, combined with $\beta_{i}>\beta_{j}-(j-i)$, yield

\left(\beta_{1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}\right)-\left((c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}\right) \geq \beta_{i}-\left(\beta_{j}-(j-i)\right) \tag{60}
\end{equation*}
$$

Thus

$$
\begin{align*}
\operatorname{rightmax}_{c \lambda}(q)-(c \lambda)_{q}= & \operatorname{rightmax}_{c \lambda}(q+1)-\operatorname{leftmin}_{c \lambda}(q) \\
\geq & \beta_{1}+\cdots+\beta_{\operatorname{center}_{c \lambda}(i, j)}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}\right) \\
& +\left(\beta_{\operatorname{center}_{c \lambda}(i, j)+1}-(c \lambda)_{\text {center }_{c \lambda}(i, j)+1}\right)+\cdots+\left(\beta_{j-1}-(c \lambda)_{j-1}\right) \\
& +\left(\beta_{q}-(q-p)-(c \lambda)_{j}\right)+\left(\beta_{j+1}-(c \lambda)_{j+1}\right)+\cdots+\left(\beta_{q-1}-(c \lambda)_{q-1}\right) \\
& +\left(\beta_{j}+(q-p)-(c \lambda)_{q}\right)  \tag{61}\\
\geq & \beta_{1}+\cdots+\beta_{\text {center }_{c \lambda}(i, j)}-\left((c \lambda)_{1}+\cdots+(c \lambda)_{\operatorname{center}_{c \lambda}(i, j)}\right) \\
& +\left(\beta_{j}+(q-p)-(c \lambda)_{q}\right) \\
\geq & \beta_{i}-\left(\beta_{j}-(j-i)\right)+\left(\beta_{j}+(q-p)-(c \lambda)_{q}\right) \\
= & \beta_{i}+(q-i)-(c \lambda)_{q},
\end{align*}
$$

where the first equality follows from the subcase hypotheses, the second inequality from Lemma 6.10 with rightmax ${ }_{c \lambda}(q+1)-\operatorname{leftmin}_{c \lambda}(q) \geq 0$ applied to $\tau$, the third from (59) and Lemma 6.5(i), the fourth by (60), and the final by $p=j$. Hence, (61) implies rightmax ${ }_{c \lambda}(q) \geq$ $\beta_{i}+(q-i)=\tau_{i}+(q-p)$. By (40), leftmin ${ }_{c \lambda}(p) \leq \beta_{q}-(q-p)=\tau_{q}-(q-p)$. We conclude by Proposition6.9 applied to $t_{p, q} \tau$ that $t_{p, q} \tau \in \mathcal{P}_{c \lambda, \gamma}$ (notice $(p, q)$ cannot be interweaved since $j=p$ and $c \lambda$ is 012-avoiding by Lemma6.3.3).
Case 1.3 ( $i$ and $p$ in the same block, $i<p, j=q$ ): Lemma3.9(i) implies $\beta_{i} \neq \beta_{p}-(p-i)$.
Subcase 1.3.1 $\beta_{i}>\beta_{p}-(p-i)$ : It is easily checked that $t_{p, q} \beta \ll_{\text {Bruhat }} t_{i, p} t_{p, q} \beta \ll_{\text {Bruhat }}$ $t_{p, q} t_{i, p} t_{p, q} \beta=t_{i, j} \beta$. Hence $t_{i, j} \beta$ is not a cover of $\beta$ and this subcase cannot occur.
Subcase 1.3.2 $\beta_{i}<\beta_{p}-(p-i)$ : By the subcase hypothesis, the definition of $\tau$, and $j=q$,

$$
\begin{equation*}
\tau_{p}=\beta_{p}>\beta_{i}+(p-i)=\beta_{i}+(j-i)-(q-p)=\tau_{j}-(q-p)=\tau_{q}-(q-p) \tag{62}
\end{equation*}
$$

By (35), (40), and $j=q$ we have

\begin{equation*}
\tau_{q}-(q-p)=\tau_{j}-(q-p)=\beta_{i}+(j-i)-(q-p)>\beta_{j}-(q-p)=\beta_{q}+(q-p) \geq \operatorname{leftmin}_{c \lambda}(q) \tag{63}
\end{equation*}
$$

Since $\tau_{p}=\beta_{p}$, by (38),

$$
\begin{equation*}
\tau_{p}+(q-p)=\beta_{p}+(q-p) \leq \operatorname{rightmax}_{c \lambda}(q) \tag{64}
\end{equation*}
$$

Finally, $\tau_{r}=\beta_{r}$ for $r \neq i, j$. If $(p, q)$ is interweaved, then (42) and $j=q$ combined with the previous sentence implies

$$
\left.\begin{array}{l}
\tau_{1}+\cdots+\tau_{p-1}+\tau_{q}-(q-p)+ \\
\tau_{p+1}+\cdots+\tau_{\text {center }_{c \lambda}(p, q)}
\end{array}=\beta_{1}+\cdots+\beta_{i-1}+\beta_{j}-(j-i)+\beta_{i+1}+\cdots, \beta_{\operatorname{center}_{c \lambda}(i, j)}\right)
$$

The hypotheses of Proposition 6.9 are satisfied for $t_{p q} \tau$ by (62), (63), (64), and (65). Hence, $t_{p, q} \tau \in \mathcal{P}_{c \lambda, \gamma}$.

We conclude by (43) that $\tau<_{\text {Bruhat }} t_{p, q} \tau$. By (35), $\phi_{i}=\beta_{i}>\beta_{j}-(j-i)=\beta_{q}-(q-p)-$ $(p-i)=\phi_{p}-(p-i)$, and hence $\phi=t_{p, q} \beta<_{\text {Bruhat }} t_{i, p} t_{p, q} \beta=t_{p, q} \tau$.
Case 1.4 ( $i<p<j<q$ are all disjoint): In this case $\tau, \phi<_{\text {Bruhat }} t_{i, j} t_{p, q} \beta=t_{p, q} t_{i, j} \beta$. By Lemma 6.11, at least one of $(i, j)$ or $(p, q)$ is not interweaved. If $(i, j)$ is not interweaved then it follows from applying Proposition 6.9 to $t_{i, j} \beta \in \mathcal{P}_{c \lambda, \gamma}$ that $t_{i, j} t_{p, q} \beta$ satisfies the hypotheses of Proposition 6.9. Similarly, if $(p, q)$ is not interweaved, $t_{p, q} t_{i, j} \beta$ is shown to satisfy the hypotheses of Proposition 6.9.
Case 1.5 ( $i<j<p<q$ are all disjoint): Once again $\tau, \phi<_{\text {Bruhat }} t_{i, j} t_{p, q} \beta=t_{p, q} t_{i, j} \beta$. It is easy to check that $t_{i, j} t_{p, q} \beta$ satisfies the hypotheses of Proposition 6.9.

## 7. Proof of Theorem $4.8(\Leftarrow)$

Let us restate the " $\Leftarrow$ " direction of Theorem4.8.
Proposition 7.1. Let $w \in \mathfrak{S}_{n}, I \subset J(w)$ and $D=[n-1]-I$ where $w$ is not $I$-spherical. There exists $\lambda \in \operatorname{Par}_{D}$ such that $\kappa_{w \lambda}$ is not D-multiplicity-free.

Proof. Let $u=w_{0}(I) \cdot w$. Since $w$ is not $I$-spherical, by Definition 1.1, $u$ is not a product of distinct generators. By Proposition [2.7, $u$ contains 321 or 3412 . We divide our analysis into cases based on the patterns contained in $u$. For $\mu \in \operatorname{Comp}_{n}$ write $\left.\mu\right|_{D}=\left(\mu^{1}, \ldots, \mu^{k}\right)$ to denote the splitting of $\mu$ into blocks of sizes $d_{1}-d_{0}, \ldots, d_{k+1}-d_{k}=n-d_{k}$. Note that $\left.\mu\right|_{D} \in \operatorname{Par}_{D}$ if it is weakly decreasing in each block.
Case 1 ( $u$ contains the pattern 321): Choose the partition $\lambda$ whose parts are in $\{2,1,0\}$ so that $u \lambda$ contains the values $0,1,2$ at indices $p^{\prime}<q<r^{\prime}$. Choose the pattern 012 so that $r^{\prime}-p^{\prime}$ is minimized. Also choose the minimum $p \leq p^{\prime}$ such that $u \lambda$ contains only 0 's at indices $p, \ldots, p^{\prime}$ and choose the maximum $r \geq r^{\prime}$ such that $u \lambda$ contains only $2^{\prime}$ s at indices $r^{\prime}, \ldots, r$. An example of a skyline diagram of $u \lambda$ is shown in Figure 4. Here, $(u \lambda)_{p^{\prime}}=0,(u \lambda)_{q}=1$,


Figure 4. A skyline diagram for $u \lambda$ that contains 012
$(u \lambda)_{r^{\prime}}=2$. In the interval $\left[p^{\prime}+1, q\right], u \lambda$ can take on $1^{\prime}$ s or $2^{\prime} s$, and all the 2 's are left of the 1's by minimality of $r^{\prime}-p^{\prime}$. Similarly, in the interval $\left[q, r^{\prime}-1\right], u \lambda$ takes on values 1 's followed by 0 's. Thus, in the interval $\left[p^{\prime}+1, r^{\prime}-1\right]$, say $u \lambda$ takes on $k_{2} \geq 0$ many 2 's, then $k_{1} \geq 1$ many 1 's and then $k_{0} \geq 0$ many 0 's, and $(u \lambda)_{q}=1$.

Since $I \subset J(w), D=[n-1]-I, w \lambda$ is weakly increasing in each block so $u \lambda$ is weakly decreasing in each block, i.e., $\left.(u \lambda)\right|_{D} \in \operatorname{Par}_{D}$. The argument that follows only uses this property of $D$.

Consider the following composition

$$
\gamma=\left(\gamma^{1}, \ldots, \gamma^{k}\right)=\left.\left(u \lambda+\vec{e}_{p}-\vec{e}_{r}\right)\right|_{D}
$$

It is easily checked that if $(u \lambda)_{i} \geq(u \lambda)_{i+1}$, then $\gamma_{i} \geq \gamma_{i+1}$ by our choice of $p$ and $r$. Thus each $\gamma^{i}$ is indeed a partition, meaning that $\gamma \in \operatorname{Par}_{D}$.

Recall the poset $\mathcal{P}_{u \lambda, \gamma}$ (Section 5) contains all vectors $\beta$ such that the monomial $x^{\beta}$ appears in the expansion of $\kappa_{u \lambda}$ and $\pi_{w_{0}(I)} x^{\beta}= \pm s_{\gamma}$ (see Lemma5.1). By Lemma 5.5, $\mathcal{P}_{u \lambda, \gamma}$ is an order ideal in $\mathcal{S}_{I, \gamma}$. Also each element $\beta$ can be generated from $\gamma$ via the moves $t_{i j}$ 's.
Claim 7.2. $\mathcal{P}_{u \lambda, \gamma}$ has height at most 1 . Moreover it has at most $k_{1}-1$ many $\beta$ such that $\theta(\beta)=1$.
Proof of Claim 7.2. Since all part sizes of $u \lambda$ belong in $\{0,1,2\}$, it is straightforward from Lemma3.9(i) that the only $t_{i j}$ 's that increase the rank of $\beta$ are

$$
t_{i}:(\ldots, 1,1, \ldots) \mapsto(\ldots, 0,2, \ldots)
$$

for $i$ and $i+1$ in the same block. The number of nonzero values in the composition decreases by one when we apply such a move. Let $\#_{\neq 0} \beta$ be the number of nonzero values in $\beta$. By Kohnert's rule (Theorem 4.5), $\#_{\neq 0} \beta \geq \#_{\neq 0} u \lambda$ for $\left[x^{\beta}\right] \kappa_{u \lambda}>0$. At the same time, $\#_{\neq 0} \gamma=\#_{\neq 0} u \lambda+1$, meaning that for all $\beta \in \mathcal{P}_{u \lambda, \gamma}, \beta$ can be obtained from $\gamma$ via at most one such move $t_{i}$.

Next, let $\beta=t_{i} \gamma \in \mathcal{P}_{u \lambda, \gamma}$. Since $\beta \geq \operatorname{dom} u \lambda$, by Corollary 4.6, we necessarily have $p^{\prime}<i<r^{\prime}$ so $i$ is one of $r^{\prime}+k_{2}+1, \ldots, r^{\prime}+k_{2}+k_{1}-1$ such that $i$ and $i+1$ are in the same block. Thus, there are at most $k_{1}-1$ choices for $i$.

Claim 7.3. If $\beta \in \mathcal{P}_{u \lambda, \gamma}$ and $\theta(\beta)=1$ then $\left[x^{\beta}\right] \kappa_{u \lambda}=1$.
Proof of Claim 7.3. For each such $\beta=t_{i} \gamma$, there is exactly one corresponding Kohnert diagram, as we need to move the top box in column $r$ of $u \lambda$ to column $i+1$, and the single box in column $i$ of $u \lambda$ to column $p$. An example of such Kohnert diagrams corresponding to the example in Figure 4 is shown in Figure 5 .


FIGURE 5. Kohnert diagrams with weight $x^{\beta}=x^{t_{i j} \gamma}$ where $\beta \in \mathcal{P}_{u \lambda, \gamma}$

Claim 7.4. $\left[x^{\gamma}\right] \kappa_{u \lambda}=k_{1}+1$.

Proof of Claim 7.4; The $D \in \operatorname{Koh}(u \lambda)$ such that $\operatorname{Kohwt}(D)=\gamma$ are obtained by either

- moving the top box of column $r$ in $u \lambda$ moved to column $p$; or
- moving the unique box in the column $z \in\left\{p^{\prime}+k_{2}+1, \ldots, p^{\prime}+k_{2}+k_{1}\right\}$ to column $p$ followed by moving the top box in column $r$ to column $z$.
These Kohnert diagrams corresponding to the example shown in Figure 4 are shown in Figure 6.


Figure 6. Kohnert diagrams with weight $x^{\gamma}$
Hence, by Claims 7.2, 7.3, 7.4,

$$
\left[s_{\gamma}\right] \kappa_{w \lambda}=\sum_{\beta \in \mathcal{P}_{u \lambda, \gamma}} \operatorname{sgn}(\beta)\left[x^{\beta}\right] \kappa_{u \lambda} \geq\left(k_{1}+1\right)-\left(k_{1}-1\right)=2
$$

so $\kappa_{w \lambda}$ is not $D$-multiplicity-free.
Case 2 ( $u$ avoids the pattern 321 but $u$ contains the pattern 3412): Pick $\lambda \in \operatorname{Par}_{n}$ to consist of values in $\{3,2,1,0\}$ so that $u \lambda$ contains the values $1,0,3,2$ at indices $p^{\prime}<q^{\prime}<r^{\prime}<z^{\prime}$ so that $z^{\prime}-p^{\prime}$ is minizied. Analogous to Case 1 , choose the minimum $p \leq p^{\prime}$ such that $u \lambda$ contains only $1^{\prime}$ s in the interval $\left[p, p^{\prime}\right]$ and choose the maximum $z \geq z^{\prime}$ such that $u \lambda$ contains only $2^{\prime}$ s on $\left[z^{\prime}, z\right]$. Let $q>p$ be the minimum index such that $(u \lambda)_{q}=0$ and let $r<z$ be the maximum index such that $(u \lambda)_{r}=3$. Since $u$ avoids $321, u \lambda$ avoids 012 , and together with the minimality of $z^{\prime}-p^{\prime}$, we see that $(u \lambda)_{p^{\prime}+1}, \ldots,(u \lambda)_{z^{\prime}-1}$ can only take on values in $\{0,3\}$. An example of a skyline diagram of $u \lambda$ is shown in Figure 7


Figure 7. A skyline diagram for $u \lambda$ that contains 1032 and avoids 012 (possibly $z=z^{\prime}$ )

Similar to Case 1, let

$$
\gamma=\left(\gamma^{1}, \ldots, \gamma^{k}\right)=\left.\left(u \lambda+\vec{e}_{p}+\vec{e}_{q}-\vec{e}_{r}-\vec{e}_{z}\right)\right|_{D} \in \operatorname{Par}_{D}
$$

Claim 7.5. $\mathcal{P}_{u \lambda, \gamma}=\{\gamma\}$.
Proof of Claim 7.5. By Proposition 3.3, Lemma 3.5, and Lemma 5.5, it suffices to show that there does not exist $i, i+1$ in the same block such that $\beta=t_{i} \gamma \in \mathcal{P}_{u \lambda, \gamma}$. If such a $t_{i}$ exists, then $\left[x^{\beta}\right] \kappa_{u \lambda}$ and so $\beta \geq_{\operatorname{dom}} u \lambda$, Corollary 4.6. Also we must have $p \leq i<z$ since $\gamma$ and $u \lambda$ only differ in that interval. Let $\beta_{\leq j}:=\left(\beta_{1}, \ldots, \beta_{j}\right)$ and recall that $\#_{\neq 0} \beta$ is the number of nonzero entries in $\beta$. By Kohnert's rule, Theorem 4.5, for $\beta \in \mathcal{P}_{u \lambda, \gamma}, \#_{\neq 0} \beta_{\leq j} \geq \#_{\neq 0}(u \lambda)_{\leq j}$ for all $j$. Consider the following cases:

- $p=i<q, t_{i}: \gamma=(\ldots, 2,1, \ldots) \mapsto(\ldots, 0,3, \ldots), \#_{\neq 0} \beta_{\leq i}<\# \neq 0(u \lambda)_{\leq i}$;
- $p<i<q, t_{i}: \gamma=(\ldots, 1,1, \ldots) \mapsto(\ldots, 0,2, \ldots), \#_{\neq 0} \beta_{\leq i}<\#_{\neq 0}(u \lambda)_{\leq i}$;
- $q \leq i<r, t_{i}: \gamma=(\ldots, 1,0, \ldots) \mapsto(\ldots,-1,2, \ldots)$ or $\left(\ldots, 3, \beta_{i+1}, \ldots\right) \mapsto\left(\ldots, \beta_{i+1}-\right.$ $1,4, \ldots)$, with impossible part sizes;
- $r \leq i<z, t_{i}: \gamma=(\ldots, 2,2, \ldots) \mapsto(\ldots, 1,3, \ldots)$ or $(\ldots, 2,1, \ldots) \mapsto(\ldots, 0,3, \ldots)$, where the newly generated part of size 3 cannot be obtained by Kohnert's rule, Theorem 4.5, since $u \lambda, \gamma$ and $\beta$ only differ on the interval $[p, z]$, that is $\beta \notin \mathcal{P}_{u \lambda, \gamma}, \mathrm{a}$ contradiction.

As a result, no such $t_{i}$ exists.
Claim 7.6. $\left[x^{\gamma}\right] \kappa_{u \lambda}=2$.
Proof of Claim 7.6. The $D \in \operatorname{Koh}(u \lambda)$ such that $\operatorname{Kohwt}(D)=\gamma$ are obtained from $u \lambda$ by

- moving the top box of column $r$ to column $p$ and moving the top box of column $z$ to column $q$; or
- moving the top box of column $r$ to column $q$ and moving the top box of column $z$ to column $p$;
as shown in Figure 8 .
Therefore, by Claim 7.5 and Claim[7.6, $\left[s_{\lambda}\right] \kappa_{w \lambda}=\left[x^{\gamma}\right] \kappa_{u \lambda}=2$, as desired.
