# Zinbiel 2-algebras

#### Abstract

The notions of Zinbiel 2-algebras and 2-term $Z_{\infty}$-algebras are introduced and studied. It is proved that the category of Zinbiel 2-algebras and the category of 2term $Z_{\infty}$-algebras are equivalent. Relationship between Zinbiel 2-algebras and dendriform 2 -algebras are found.

## 1 Introduction

The notion of $L_{\infty}$-algebras which generalizes Lie algebras first appeared in deformation theory and then in closed string field theory. The algebraic theory of Lie 2-algebras was studied by Baez and Crans in [1]. It is showed that a Lie 2-algebra can be seen as a categorification of a Lie algebra, where the underling vector space is replaced by 2 -vector space and the Jacobi identity is replaced by a nature transformation which satisfies some coherence law. They proved that the category of Lie 2-algebras and the category of 2-term $L_{\infty}$-algebras are equivalent.

On the other hand, the study of Zinbiel algebras was initiated by Loday [2]. Under the Koszul duality the operad of Zinbiel algebras is dual to the operad of Leibniz algebras. Now a natural question arise, does there exist a categorification of a Zinbiel algebra? In this paper, we give a positive answer to this question.

[^0]The key point is that a Zinbiel 2-algebra is actually a Zinbiel algebra in the category of 2 -vector spaces, where the condition is replaced by some nature transformation. We also introduced the concept of 2-term $Z_{\infty}$-algebras, and proved that the category of Zinbiel 2-algebras and the category of 2-term $Z_{\infty}$-algebras are equivalent.

The second aim of this paper is to category the relation between Zinbiel algebras and dendriform algebras. We introduce the notion of Zinbiel 2-algebra, and establish the following commutative diagram:


The main results and organization of this paper are as follows. In Section 2, we recall some facts about Zinbiel algebras. In Section 3, we introduce the notion of Zinbiel 2algebras and 2-term $Z_{\infty}$-algebras. It is proved that there is an equivalence between the category of Zinbiel 2-algebras and the category of 2-term $Z_{\infty}$-algebras. In Section 4, we investigate some special cases of Zinbiel 2-algebras, such as skeletal and strict ones. In Section 5, we found that Zinbiel 2-algebras give rise to dendriform 2-algebras and associative 2-algebras.

## 2 Preliminaries

In this section, we will recall some facts and definitions about Zinbiel algebras.
Definition 2.1. A Zinbiel algebra is a vector space $Z$ together with a multiplication •: $Z \times Z \rightarrow Z$ satisfying the following Zinbiel identity:

\begin{equation*}
(x \cdot y) \cdot z=x \cdot(y \cdot z)+x \cdot(z \cdot y) \tag{1}
\end{equation*}
$$

for all $x, y, z \in Z$.
Example 2.2. Let $(Z, \cdot)$ be a Zinbiel algebra with multiplication $\cdot: Z \times Z \rightarrow Z$. Define the symmetrized product by

$$
x y:=\frac{1}{2}(x \cdot y+y \cdot x),
$$

for all $x, y \in A$. Then under the symmetrized product, $Z$ becomes an associative and commutative algebra.

A homomorphism between two Zinbiel algebras $(Z, \cdot)$ and $\left(Z^{\prime}, .^{\prime}\right)$ is a linear map $\varphi$ : $Z \rightarrow Z^{\prime}$ such that

$$
\varphi(x \cdot y)=\varphi(x) \cdot^{\prime} \varphi(y)
$$

for all $x, y \in Z$.
Let $Z$ be a Zinbiel algebra and $V$ is a vector space, a bimodule of $Z$ over the vector space $V$ is a pair of bilinear maps $\triangleright: Z \times V \rightarrow V$ and $\triangleleft: V \times Z \rightarrow V$ such that the following conditions hold:

$$
\begin{equation*}
(x \cdot y) \triangleright v=x \triangleright(y \triangleright v+v \triangleleft y), \tag{2}
\end{equation*}
$$

$$
\begin{align*}
& (v \triangleleft x) \triangleleft y=v \triangleleft(x \cdot y+y \cdot x),  \tag{3}\\
& (x \triangleright v) \triangleleft y=x \triangleright(v \triangleleft y+y \triangleright v), \tag{4}
\end{align*}
$$

for all $x, y, z \in Z, u \in V$.
Example 2.3. Let $Z$ be a 2-dimension vector space with $\left\{e_{1}, e_{2}\right\}$ a base. We defined the multiplications by

$$
e_{1} \cdot e_{1}=e_{2}, \quad e_{1} \cdot e_{2}=e_{2} \cdot e_{1}=0, \quad e_{2} \cdot e_{2}=0
$$

Then $(Z, \cdot)$ is a 2-dimension Zinbiel algebra.
Let $Z$ be a Zinbiel algebra and let $V$ be a $Z$-bimodule. Recall that the low dimensional cohomology is defined as following, see [4].

The cochain complex is

$$
C^{n}(Z, V)=\operatorname{Hom}_{K}\left(Z^{\otimes n}, V\right)
$$

For $1 \leq i \leq 3$, the coboundary operator

$$
d^{i}: C^{i}(Z, V) \rightarrow C^{i+1}(Z, V)
$$

is defined by

$$
\begin{aligned}
\left(d^{1} \omega\right)(x, y)= & x \triangleright \omega(y)-\omega(x \cdot y)+\omega(x) \triangleleft y, \\
\left(d^{2} \omega\right)(x, y, z)= & x \triangleright(\omega(y, z)+\omega(z, y))-\omega(x \cdot y, z)+\omega(x, y \cdot z+z \cdot y)-\omega(x, y) \triangleleft z, \\
\left(d^{3} \omega\right)(x, y, z, t)= & x \triangleright\{\omega(y, z, t)-\omega(z, t, y)+\omega(z, y, t)-\omega(t, z, y)\} \\
& -\omega(x \cdot y, z, t)+\omega(x, y \cdot z+z \cdot y, t) \\
& -\omega(x, y, z \cdot t+t \cdot z)+\omega(x, y, z) \triangleleft t .
\end{aligned}
$$

It is easy to check directly that $d^{i+1} d^{i}=0$ for $i=1,2$, and so $\left(C^{*}(Z, V), d\right), 1 \leq * \leq 4$, is a cochain complex, which is usually abbreviated to $C^{*}(Z, V)$. For $n=2,3$, we get the cohomology group $\mathbf{H}^{n}(Z, V)=Z^{n}(Z, V) / B^{n}(Z, V)$ where $Z^{n}(Z, V)$ is the space of cocycles and $B^{n}(Z, V)$ is the space of coboundaries.

## 3 Zinbiel 2-algebras and 2-term $Z_{\infty}$-algebras

In this section, we introduced the concept of Zinbiel 2-algebras and 2-term $Z_{\infty}$-algebras. It is proved that the category of Zinbiel 2-algebras and the category of 2-term $Z_{\infty}$-algebras are equivalent.

Recall that we denote the category of vector spaces by Vect. A 2-vector space is a category in Vect. Thus, a 2 -vector space $\mathcal{V}$ is a category with a vector space of objects $\mathcal{V}_{0}$ and a vector space of morphisms $\mathcal{V}_{1}$, such that the source and target maps $s, t: \mathcal{V}_{1} \rightarrow \mathcal{V}_{0}$, the identity-assigning map $i: \mathcal{V}_{0} \rightarrow \mathcal{V}_{1}$, and the composition map $: \mathcal{V}_{1} \times \mathcal{V}_{0} \mathcal{V}_{1} \rightarrow \mathcal{V}_{1}$ are all linear maps. We write a morphism $f$ from source $x$ to target $y$ by $f: x \rightarrow y$, i.e. $s(f)=x$ and $t(f)=y$. We also write $i(x)$ as $1_{x}$.

It is well known that 2 -vector spaces are in one-to-one correspondence with 2 -term complexes of vector spaces. A 2-term complex of vector spaces is a pair of vector space with a differential between them: $\mathcal{C}_{1} \xrightarrow{\mathrm{~d}} \mathcal{C}_{0}$. The correspondence is given as follows. Given a 2-vector space $\mathcal{V}$, then $\operatorname{Ker}(s) \xrightarrow{t} \mathcal{V}_{0}$ is a 2-term complex. Conversely, any 2term complex of vector spaces $\mathcal{V}_{1} \xrightarrow{\mathrm{~d}} \mathcal{V}_{0}$ gives rise to a 2 -vector space of which the set of objects is $\mathcal{C}_{0}$, the set of morphisms is $\mathcal{C}_{0} \oplus \mathcal{C}_{1}$, the source map $s$ is given by $s(x, h)=x$, and the target map $t$ is given by $t(x, h)=x+d h$, where $x \in \mathcal{V}_{0}, h \in \mathcal{V}_{1}$. The 2-vector space associated to the 2 -term complex of vector spaces is denoted by $\mathcal{V}_{1} \xrightarrow{\mathrm{~d}} \mathcal{V}_{0}$ by $\mathcal{V}$ :

$$
\mathcal{V}=\begin{gather*}
\mathcal{V}_{1}:=\mathcal{C}_{0} \oplus \mathcal{C}_{1}  \tag{5}\\
\mathrm{~s} \downarrow \downarrow \mathrm{t} \\
\mathcal{V}_{0}:=\mathcal{C}_{0}
\end{gather*}
$$

Definition 3.1. A Zinbiel 2-algebra consists of a 2-vector space $\mathcal{Z}$ equipped with a bilinear functor, $\cdot: \mathcal{Z} \times \mathcal{Z} \rightarrow \mathcal{Z}$ and a natural isomorphism, the Zinbielator,

$$
J_{x, y, z}:(x \cdot y) \cdot z \rightarrow x \cdot(y \cdot z)+x \cdot(z \cdot y)
$$

such that the following Zinbielator identity is satisfied

$$
\begin{align*}
& \left(x \cdot J_{y, z, t}+x \cdot J_{z, y, t}+1+1\right)\left(J_{x, y \cdot z, t}+J_{x, z \cdot y, t}\right) J_{x, y, z} \cdot t \\
= & \left(1+1+x \cdot J_{z, t, y}+x \cdot J_{t, z, y}\right)\left(J_{x, y, z \cdot t}+J_{x, y, t \cdot z}\right) J_{x \cdot y, z, t} \tag{6}
\end{align*}
$$

In terms of a commutative diagram, we see that it relates two ways of using the Zinbielator to rewrite the expression $((x \cdot y) \cdot z) \cdot t$ :

where $P$ is given by

$$
\begin{aligned}
P= & x \cdot(y \cdot(z \cdot t))+x \cdot(y \cdot(t \cdot z)) \\
& +x \cdot(z \cdot(y \cdot t))+x \cdot(z \cdot(t \cdot y)) \\
& +x \cdot(t \cdot(y \cdot z))+x \cdot(t \cdot(z \cdot y)) .
\end{aligned}
$$

Definition 3.2. Given Zinbiel 2-algebras ( $\mathcal{Z}, \cdot)$ and $\left(\mathcal{Z}^{\prime}, \cdot^{\prime}\right)$, a Zinbiel 2-algebra homomorphism $F: \mathcal{Z} \longrightarrow \mathcal{Z}^{\prime}$ consists of:

- a functor $\left(F_{0}, F_{1}\right)$ from the underlying 2-vector space of $\mathcal{Z}$ to that of $\mathcal{Z}^{\prime}$.
- a natural transformation

$$
F_{2}(x, y): F_{0}(x) \cdot^{\prime} F_{0}(y) \longrightarrow F_{0}(x \cdot y)
$$

such that the following diagram commutes:


The identity homomorphism $\operatorname{id}_{\mathcal{Z}}: \mathcal{Z} \longrightarrow \mathcal{Z}$ has the identity functor as its underlying functor, together with an identity natural transformation as $\left(\mathrm{id}_{\mathcal{Z}}\right)_{2}$. Let $\mathcal{Z}, \mathcal{Z}^{\prime}$ and $\mathcal{Z}^{\prime \prime}$ be Zinbiel 2-algebras, the composition of a pair of Zinbiel 2-algebra morphisms $F: \mathcal{Z} \longrightarrow \mathcal{Z}^{\prime}$ and $G: \mathcal{Z}^{\prime} \longrightarrow \mathcal{Z}^{\prime \prime}$, which we denote by $G \cdot F$, is given by letting the functor $((G$. $\left.F)_{0},(G \cdot F)_{1}\right)$ be the usual composition of $\left(G_{0}, G_{1}\right)$ and $\left(F_{0}, F_{1}\right)$, and letting $(G \cdot F)_{2}$ be the following composite:


It is easy to see that there is a category Z2Alg with Zinbiel 2-algebras as objects and Zinbiel 2-algebra homomorphisms as morphisms.

Definition 3.3. A 2-term $Z_{\infty}$-algebra $\mathcal{V}=\mathcal{V}_{0} \oplus \mathcal{V}_{1}$ is a complex consisting of the following data:

- two vector spaces $\mathcal{V}_{0}$ and $\mathcal{V}_{1}$ together with a linear map $l_{1}=d: \mathcal{V}_{1} \rightarrow \mathcal{V}_{0}$,
- a bilinear map $l_{2}: \mathcal{V}_{i} \times \mathcal{V}_{j} \rightarrow \mathcal{V}_{i+j}$, where $0 \leq i+j \leq 1$,
- a trilinear map $l_{3}: \mathcal{V}_{0} \times \mathcal{V}_{0} \times \mathcal{V}_{0} \rightarrow \mathcal{V}_{1}$.

These maps satisfy the following conditions: for all $x, y, z, t \in \mathcal{V}_{0}$ and $h, k \in \mathcal{V}_{1}$,
(a) $l_{2}(h, k)=0$,
(b1) $\mathrm{d}\left(l_{2}(x, h)\right)=l_{2}(x, \mathrm{~d} h)$,
(b2) $\mathrm{d}\left(l_{2}(h, x)\right)=l_{2}(\mathrm{~d} h, x)$,
(c) $l_{2}(\mathrm{~d} h, k)=l_{2}(h, \mathrm{~d} k)$,
(d) $\mathrm{d}\left(l_{3}(x, y, z)\right)=l_{2}\left(x, l_{2}(y, z)\right)+l_{2}\left(x, l_{2}(z, y)\right)-l_{2}\left(l_{2}(x, y), z\right)$,
(e1) $l_{3}(x, y, \mathrm{~d} h)=l_{2}\left(x, l_{2}(y, h)\right)-l_{2}\left(x, l_{2}(y, h)\right)-l_{2}\left(x, l_{2}(h, y)\right)$,
(e2) $l_{3}(x, \mathrm{~d} h, z)=l_{2}\left(l_{2}(x, h), z\right)-l_{2}\left(x, l_{2}(h, z)\right)-l_{2}\left(x, l_{2}(z, h)\right)$,
(e3) $l_{3}(\mathrm{~d} h, y, z)=l_{2}\left(l_{2}(h, y), z\right)-l_{2}\left(h, l_{2}(y, z)\right)-l_{2}\left(h, l_{2}(z, y)\right)$,
(f) $l_{2}\left(x, l_{3}(y, z, t)\right)+l_{2}\left(x, l_{3}(z, y, t)\right)+l_{3}\left(x, l_{2}(y, z)+l_{2}(z, y), t\right)+l_{2}\left(l_{3}(x, y, z), t\right)$
$-l_{2}\left(x, l_{3}(z, t, y)\right)-l_{2}\left(x, l_{3}(t, z, y)\right)-l_{3}\left(x, y, l_{2}(z, t)+l_{2}(t, z)\right)-l_{3}(x \cdot y, z, t)=0$.
Definition 3.4. Let $\left(\mathcal{V} ; \mathrm{d}, l_{2}, l_{3}\right)$ and $\left(\mathcal{V}^{\prime} ; \mathrm{d}^{\prime}, l_{2}^{\prime}, l_{3}^{\prime}\right)$ be two 2-term $Z_{\infty^{-}}$-algebras. $A Z_{\infty^{-}}$ homomorphisms $f$ from $\mathcal{V}$ to $\mathcal{V}^{\prime}$ consists of linear maps $f_{0}: \mathcal{V}_{0} \rightarrow \mathcal{V}_{0}^{\prime}, f_{1}: \mathcal{V}_{1} \rightarrow \mathcal{V}_{1}^{\prime}$ and $f_{2}: \mathcal{V}_{0} \times \mathcal{V}_{0} \rightarrow \mathcal{V}_{1}^{\prime}$, such that the following equalities hold for all $x, y, z \in \mathcal{V}_{0}, a \in \mathcal{V}_{1}$,
(i) $f_{0} \mathrm{~d}=\mathrm{d}^{\prime} f_{1}$,
(ii) $f_{0} l_{2}(x, y)-l_{2}^{\prime}\left(f_{0}(x), f_{0}(y)\right)=\mathrm{d}^{\prime} f_{2}(x, y)$,
(iii) $\left.f_{1} l_{2}(x, a)-l_{2}^{\prime} f_{0}(x), f_{1}(a)\right)=f_{2}(x, \mathrm{~d} a)$,
(iv) $f_{1}\left(l_{3}(x, y, z)\right)-l_{3}^{\prime}\left(f_{0}(x), f_{0}(y), f_{0}(z)\right)=f_{2}\left(x, l_{2}(y, z)\right)-f_{2}\left(l_{2}(x, y), z\right)-f_{2}\left(y, l_{2}(x, z)\right)$ $+l_{2}^{\prime}\left(f_{0}(x), f_{2}(y, z)\right)-l_{2}^{\prime}\left(f_{2}(x, y), f_{0}(z)\right)-l_{2}^{\prime}\left(f_{0}(y), f_{2}(x, z)\right)$.

If $f_{2}=0$, the $Z_{\infty}$-homomorphism $f$ is called a strict $Z_{\infty}$-homomorphism.
Let $f: \mathcal{V} \rightarrow \mathcal{V}^{\prime}$ and $g: \mathcal{V}^{\prime} \rightarrow \mathcal{V}^{\prime \prime}$ be two $Z_{\infty}$-homomorphisms, then their composition $g \cdot f: \mathcal{V} \rightarrow \mathcal{V}^{\prime \prime}$ is a $Z_{\infty}$-homomorphism defined as $(g \cdot f)_{0}=g_{0} \cdot f_{0},(g \cdot f)_{1}=g_{1} \cdot f_{1}$ and

$$
(g \cdot f)_{2}(x, y)=g_{2}\left(f_{0}(x), f_{0}(y)\right)+g_{1}\left(f_{2}(x, y)\right)
$$

The identity $Z_{\infty}$-homomorphism $1_{\mathcal{V}}: \mathcal{V} \rightarrow \mathcal{V}$ has the identity chain map together with $\left(1_{\mathcal{V}}\right)_{2}=0$. There is a category $2 \mathrm{TermZ}_{\infty}$ with 2-term $Z_{\infty}$-algebras as objects and $Z_{\infty}$-homomorphisms as morphisms.

Now we establish the equivalence between the category of Zinbiel 2-algebras and 2term $Z_{\infty^{-}}$-algebras.

Theorem 3.5. The categories $\mathbf{2 T e r m}_{\infty}$ and $\mathbf{Z} \mathbf{2 A l g}$ are equivalent.
Proof. We give a sketch of the proof. First, we show how to construct a Zinbiel 2-algebra from a 2-term $Z_{\infty}$-algebra.

Let $\mathcal{V}=\left(\mathcal{V}_{1} \xrightarrow{\mathrm{~d}} \mathcal{V}_{0}, l_{2}, l_{3}\right)$ be a 2-term $Z_{\infty}$-algebra, we introduce a bilinear functor on the 2-vector space $\mathcal{Z}=\left(\mathcal{V}_{0} \oplus \mathcal{V}_{1} \rightrightarrows \mathcal{V}_{0}\right)$ given by (5), that is $Z$ has vector spaces of objects and morphisms $\mathcal{Z}_{0}=\mathcal{V}_{0}, \mathcal{Z}_{1}=\mathcal{V}_{0} \oplus \mathcal{V}_{1}$ and a morphisms $f: x \rightarrow y$ in $\mathcal{Z}_{1}$ by $f=(x, h)$ where homogenous elements $x \in \mathcal{V}_{0}$ and $h \in \mathcal{V}_{1}$ have the same degree. The source, target, and identity-assigning maps in $L$ are given by

$$
s(f)=s(x, h)=x
$$

$$
\begin{aligned}
t(f) & =t(x, h)=x+d h \\
i(x) & =(x, 0)
\end{aligned}
$$

and we have $t(f)-s(f)=d h$.
Now we define product on $\mathcal{Z}$ by

$$
(x, h) \cdot(y, k)=l_{2}(x, y)+l_{2}(x, k)+l_{2}(h, y)+l_{2}(d h, k) .
$$

It is straightforward to see that it is a bilinear functor.
Now we define the Zinbielator as following

$$
J_{x, y, z}:=\left((x \cdot y) \cdot z, l_{3}(x, y, z)\right)
$$

Then by Condition $(g)$, we have $J_{x, y, z}$ is a morphism from source $(x \cdot y) \cdot z$ to target $x \cdot(y \cdot z)+x \cdot(z \cdot)$. One show that $J_{x, y, z}$ is natural isomorphism and satisfying Zinbielator identity (6) in Definition 3.1. Thus from a 2-term $Z_{\infty}$-algebra, we can obtain a Zinbiel 2-algebra.

For any $Z_{\infty}$-homomorphism $f=\left(f_{0}, f_{1}, f_{2}\right)$ form $\mathcal{V}$ to $\mathcal{V}^{\prime}$, we construct a Zinbiel 2-algebra morphism $F=T(f)$ from $L=T(\mathcal{V})$ to $L^{\prime}=T\left(\mathcal{V}^{\prime}\right)$ as follows:

Let $F_{0}=f_{0}, F_{1}=f_{0} \oplus f_{1}$, and $F_{2}$ be given by

$$
F_{2}(x, y)=\left(f_{0}(x) \cdot f_{0}(y), f_{2}(x, y)\right)
$$

Then $F_{2}(x, y)$ is a bilinear natural isomorphism from $F_{0}(x) \cdot F_{0}(y)$ to $F_{0}(x \cdot y)$, and $F=$ $\left(F_{0}, F_{1}, F_{2}\right)$ is a Zinbiel 2-algebra homomorphism from $\mathcal{Z}$ to $\mathcal{Z}^{\prime}$. One can also deduce that $T$ preserves the identity $Z_{\infty}$-homomorphisms and the composition of $Z_{\infty}$-homomorphisms. Thus, $T$ constructed above is a functor from $\mathbf{2 T e r m} \mathbf{Z}_{\infty}$ to $\mathbf{Z} \mathbf{2 A l g}$.

Conversely, given a Zinbiel 2-algebra $\mathcal{Z}$, we define $l_{2}$ and $l_{3}$ on the 2-term complex $\mathcal{Z}_{1} \supseteq \operatorname{ker}(s)=\mathcal{V}_{1} \xrightarrow{\mathrm{~d}} \mathcal{V}_{0}=\mathcal{Z}_{0}$ by

- $\mathrm{d} h=t(h)$ for $h \in \mathcal{V}_{1} \subseteq \mathcal{Z}_{1}$.
- $l_{2}(x, y)=x \cdot y$ for $x, y \in \mathcal{V}_{0}=\mathcal{Z}_{0}$.
- $l_{2}(x, h)=\left[1_{x}, h\right]$ for $x \in \mathcal{V}_{0}=\mathcal{Z}_{0}$ and $h \in \mathcal{V}_{1} \subseteq \mathcal{Z}_{1}$.
- $l_{2}(h, k)=0$ for $h, k \in \mathcal{V}_{1} \subseteq \mathcal{Z}_{1}$.
- $l_{3}(x, y, z)=p_{1} J_{x, y, z}$ for $x, y, z \in \mathcal{V}_{0}=Z_{0}$, where $p_{1}: Z_{1}=\mathcal{V}_{0} \oplus \mathcal{V}_{1} \longrightarrow \mathcal{V}_{1}$ is the projection.
Then one can verify that $\left(\mathcal{V}_{1} \xrightarrow{\mathrm{~d}} \mathcal{V}_{0}, l_{2}, l_{3}\right)$ is a 2 -term $Z_{\infty}$-algebra.
Let $F=\left(F_{0}, F_{1}, F_{2}\right): \mathcal{Z} \longrightarrow \mathcal{Z}^{\prime}$ be a Zinbiel 2-algebra homomorphism, and $S(\mathcal{Z})=$ $\mathcal{V}, S\left(\mathcal{Z}^{\prime}\right)=\mathcal{V}^{\prime}$. Define $S(F)=f=\left(f_{0}, f_{1}, f_{2}\right)$ as follows. Let $f_{0}=F_{0}, f_{1}=\left.F_{1}\right|_{V_{1}=\operatorname{Ker}(s)}$ and define $f_{2}$ by

$$
f_{2}(x, y)=F_{2}(x, y)-i\left(s\left(F_{2}(x, y)\right)\right) .
$$

It is not hard to deduce that $f$ is a 2 -term $Z_{\infty}$-algebra homomorphism. Furthermore, $S$ also preserves the identity morphisms and the composition of morphisms. Thus, $S$ is a functor from Z2Alg to $\mathbf{2 T e r m Z}{ }_{\infty}$.

We left it to the reader to show that there are natural isomorphisms $\alpha: T \cdot S \Longrightarrow 1_{\mathbf{Z 2 A l g}}$ and $\beta: S \cdot T \Longrightarrow 1_{\mathbf{2 T e r m Z}_{\infty}}$.

## 4 Construction of Zinbiel 2-algebras

In this section, special cases and concrete examples of Zinbiel 2-algebras are given. This include Zinbiel algebras with 3-cocyles, crossed module of Zinbiel algebras.

### 4.1 Skeletal Zinbiel 2-algebras

A 2-term $Z_{\infty}$-algebra is called skeletal if $d=0$. In this case, from conditions $(a)$ and $(g)$, we have $\mathcal{V}_{0}$ is a Zinbiel algebra. Conditions (b) and (h) imply that $\mathcal{V}_{1}$ is a representation of $\mathcal{V}_{0}$ by the action defined by $x \triangleright h:=l_{2}(x, h), h \triangleleft x:=l_{2}(h, x)$. Now condition $(i)$ can be described in terms of a 3-cocycle condition in the Zinbiel algebra cohomology of $\mathcal{V}_{0}$ with values in $\mathcal{V}_{1}$.

Proposition 4.1. Skeletal 2-term $Z_{\infty}$-algebras are in one-to-one correspondence with quadruples $\left(Z, V, l_{3}\right)$ where $Z$ is a Zinbiel algebra, $V$ is a bimodule of $Z$ and $l_{3}$ is a 3cocycle on $Z$ with values in $V$.

### 4.2 Crossed modules of Zinbiel algebras

Another kind of 2-term $Z_{\infty}$-algebra is called strict if $l_{3}=0$. This kind of Zinbiel 2algebras can be described in terms of crossed modules of Zinbiel algebras.

Definition 4.2. Let $\left(Z, \cdot{ }_{Z}\right)$ and $\left(H, \cdot_{H}\right)$ be two Zinbiel algebras. A crossed module of Zinbiel algebras is a homomorphism of Zinbiel algebras $\varphi: H \rightarrow Z$ together with an action of $Z$ on $H$, denoted by $\triangleright: Z \times H \rightarrow H,(x, h) \mapsto x \triangleright h$ and $\triangleleft: H \times Z \rightarrow H,(h, x) \mapsto h \triangleleft x$, such that

$$
\varphi(x \triangleright h)=x \cdot z \varphi(h), \quad \varphi(h \triangleleft x)=\varphi(h) \cdot{ }_{Z} x, \quad \varphi(h) \triangleright k=h \cdot{ }_{H} k=h \triangleleft \varphi(k),
$$

for all $h, k \in H, x \in Z$.
Proposition 4.3. There is an one-to-one correspondence between strict 2-term $Z_{\infty^{-}}$ algebras and crossed modules of Zinbiel algebras.

Proof. Let $\mathcal{V}_{1} \xrightarrow{\mathrm{~d}} \mathcal{V}_{0}$ be a 2 -term $Z_{\infty}$-algebra with $l_{3}=0$. We construct Zinbiel algebras on $Z=\mathcal{V}_{0}$ and $H=\mathcal{V}_{1}$ as follows. The product on $Z$ and $H$ are defined by

$$
\begin{aligned}
& h \cdot{ }_{H} k:=l_{2}(\mathrm{~d} h, k)=l_{2}(h, \mathrm{~d} k), \quad \forall h, k \in H=\mathcal{V}_{1} ; \\
& x \cdot Z y:=l_{2}(x, y), \quad \forall x, y \in Z=\mathcal{V}_{0} .
\end{aligned}
$$

By conditions in Definition 3.3, it is easy to see that ${ }^{Z}$ satisfies the Zinbiel identity, and we have

$$
\begin{aligned}
& \left(h \cdot_{H} k\right) \cdot{ }_{H} g-h \cdot{ }_{H}\left(k \cdot{ }_{H} g\right)-h \cdot_{H}\left(g \cdot{ }_{H} k\right) \\
= & l_{2}(\mathrm{~d} h, k) \cdot{ }_{H} g-h \cdot{ }_{H} l_{2}(k, \mathrm{~d} g)-h \cdot_{H} l_{2}(\mathrm{~d} g, k) \\
= & \left.l_{2}\left(l_{2}(\mathrm{~d} h, k), \mathrm{d} g\right)\right)-l_{2}\left(l_{2}\left(\mathrm{~d} h, l_{2}(k, \mathrm{~d} g)\right)-l_{2}\left(l_{2}\left(\mathrm{~d} h, l_{2}(\mathrm{~d} g, k)\right)\right.\right. \\
= & 0 .
\end{aligned}
$$

Thus $\left(H,{ }_{H}\right)$ is a Zinbiel algebra. Now let $\varphi=\mathrm{d}$, then we have

$$
\varphi\left(h \cdot{ }_{H} k\right)=\mathrm{d}\left(l_{2}(d h, k)\right)=l_{2}(\mathrm{~d} h, \mathrm{~d} k)=\varphi(h) \cdot z \varphi(k),
$$

which implies that $\varphi$ is a homomorphism of Zinbiel algebras from $H$ to $Z$.
Now define the action map of $Z \times H \rightarrow H$ by

$$
x \triangleright h:=l_{2}(x, h), \quad h \triangleleft x:=l_{2}(h, x) \in H,
$$

then it is easy to check that

$$
\begin{aligned}
& \varphi(x \triangleright h)=\mathrm{d}\left(l_{2}(x, h)\right)=l_{2}(x, \mathrm{~d} h)=x \cdot z \varphi(h), \\
& \varphi(h \triangleleft x)=\mathrm{d}\left(l_{2}(h, x)\right)=l_{2}(\mathrm{~d} h, x)=\varphi(h) \cdot z x, \\
& \varphi(h) \cdot k=l_{2}(\mathrm{~d} h, k)=h \cdot{ }_{H} k .
\end{aligned}
$$

Therefore we obtain a crossed module of Zinbiel algebras.
Conversely, a crossed module of Zinbiel algebras gives rise to a 2-term $Z_{\infty}$-algebra with $\mathrm{d}=\varphi, \mathcal{V}_{0}=Z$ and $\mathcal{V}_{1}=H$, where the brackets are given by

$$
\begin{aligned}
l_{2}(x, y) & :=x \cdot z y ; \\
l_{2}(x, h) & :=x \triangleright h, \quad l_{2}(h, x):=h \triangleleft x \\
l_{2}(h, k) & :=0 .
\end{aligned}
$$

The crossed module conditions give various conditions for 2-term $Z_{\infty}$-algebras with $l_{3}=$ 0 .

### 4.3 Crossed module extensions of Zinbiel algebras

In this section we will study crossed module extensions of Zinbiel algebras and show that they are related to the some elements of cohomology group.

Definition 4.4. Let $Z$ be a Zinbiel algebra and $M$ be a bimodule of $Z$. A crossed module extension of $Z$ by $M$ is a short exact sequence

$$
\begin{equation*}
0 \longrightarrow M \xrightarrow{i} V \xrightarrow{\partial} S \xrightarrow{\pi} Z \longrightarrow \tag{7}
\end{equation*}
$$

such that $\partial: V \rightarrow S$ is a crossed module and $M \cong \operatorname{Ker} \partial, T \cong \operatorname{coKer} \partial$.
Definition 4.5. Two crossed module extensions of Zinbiel algebras $\partial: V \rightarrow S$ and $\partial^{\prime}: V^{\prime} \rightarrow S^{\prime}$ are equivalent, if there exists a Zinbiel algebras homomorphism $\alpha: V \rightarrow V^{\prime}$ and $\beta: S \rightarrow S^{\prime}$ such that the following diagram commutes


The set of equivalent classes of extensions of $Z$ by $M$ is denoted by $\operatorname{CExt}(Z, M)$.

Given a crossed module $\partial: V \rightarrow S$, we consider $Z=\operatorname{coKer}(\partial)$ and $M=\operatorname{Ker}(\partial)$ in the category of vector spaces. The Zinbiel algebra structure of $S$ induces a Zinbiel algebra structure on $Z$ and the $Z$-bimodule structure on $V$ induces a $Z$-bimodule structure on $M$. Thus we obtained a crossed module extension.

The following Theorem 4.6 shows that crossed module extensions are naturally associated with the elements of third cohomology group.

Theorem 4.6. Let $Z$ be a Zinbiel algebra and $M$ be a bimodule of $Z$. Then there is a canonical map:

$$
\xi: \mathbf{C E x t}(Z, M) \rightarrow \mathbf{H}^{\mathbf{3}}(Z, M)
$$

Proof. We define $\xi: \operatorname{CExt}(Z, M) \rightarrow \mathbf{H}^{\mathbf{3}}(Z, M)$ as follows. Given a crossed module extension of $T$ by $M$ and choose linear sections $s: Z \rightarrow S$ such that $\pi s=1$ and $q: \operatorname{Im}(\partial) \rightarrow V, \partial q=1$. For $x, y \in Z$, we have

$$
\pi(s(x) \cdot s(y)-s(x \cdot y))=\pi s(x) \cdot \pi s(y)-\pi s(x \cdot y)=x \cdot y-x \cdot y=0
$$

and thus $s(x) \cdot s(y)-s(x \cdot y) \in \operatorname{Im}(\partial)$. Take $g(x, y)=q(s(x) \cdot s(y)-s(x \cdot y)) \in V$ and define

$$
\begin{aligned}
& \theta_{\mathcal{E}}(x, y, z) \\
= & x \triangleright(g(y, z)+g(z, y))-g(x \cdot y, z)+g(x, y \cdot z+z \cdot y)-g(x, y) \triangleleft z \\
= & s(x) \cdot(g(y, z)+g(z, y))-g(x \cdot y, z)+g(x, y \cdot z+z \cdot y)-g(x, y) \cdot s(z) .
\end{aligned}
$$

Since $\partial$ is a map of crossed modules, it follows that

$$
\begin{aligned}
& \partial\left(\theta_{\mathcal{E}}(x, y, z)\right) \\
= & \partial\{x \triangleright(g(y, z)+g(z, y))-\partial g(x \cdot y, z)+\partial g(x, y \cdot z+z \cdot y)-\partial g(x, y) \triangleleft z\} \\
= & s(x) \cdot(s(y) \cdot s(z)-s(y \cdot z)+(s(z) \cdot s(y)-s(z \cdot y)) \\
& -(s(x \cdot y) \cdot s(z)+s((x \cdot y) \cdot z) \\
& +s(x) \cdot s(y \cdot z+z \cdot y)-s(x \cdot(y \cdot z+z \cdot y)) \\
& -(s(x) \cdot s(y)) \cdot s(z)+s(x \cdot y) \cdot s(z) \\
= & 0 .
\end{aligned}
$$

Thus $\theta_{\mathcal{E}}(x, y, z) \in M=\operatorname{ker}(\partial)$ and the map $\theta_{\mathcal{E}}: Z^{\otimes 3} \rightarrow M$ is well defined. One can checks that $d^{3}\left(\theta_{\mathcal{E}}\right)=0$. Thus we have defined a linear map $\theta_{\mathcal{E}}: Z^{\otimes 3} \rightarrow M$ which is a cocycle with respect to the coboundary operator $d^{3}$. We define $\xi: \mathbf{C E x t}(Z, M) \rightarrow \mathbf{H}^{3}(Z, M)$ by taking $\xi(\mathcal{E})$ to be the class of $\theta_{\mathcal{E}}$ in $\mathbf{H}^{3}(Z, M)$.

Next, we have to check that the class of $\theta_{\mathcal{E}}$ in $\mathbf{H}^{3}(Z, M)$ does not depend on the sections $s$ and $q$. We show first that the class of $\theta_{\mathcal{E}}$ does not depend on the section $s$. Suppose $\bar{s}: Z \rightarrow S$ is another section of $\pi$ and let $\bar{\theta}_{\mathcal{E}}$ be the map defined using $\bar{s}$ instead of $s$. Since $s$ and $\bar{s}$ are both sections of $\pi$ there exists a linear map $h: Z \rightarrow V$ with $s-\bar{s}=\partial h$. Observe that

$$
s(x) \cdot g(y, z)-\bar{s}(x) \cdot \bar{g}(y, z)
$$

$$
\begin{aligned}
& =(s(x)-\bar{s}(x)) \cdot g(y, z)+\bar{s}(x) \cdot(g-\bar{g})(y, z) \\
& =\partial h(x) \cdot q(s(y) \cdot s(z)-s(y \cdot z))+\bar{s}(x) \cdot(g-\bar{g})(y, z) \\
& =h(x) \cdot(s(y) \cdot s(z)-s(y \cdot z))+\bar{s}(x) \cdot(g-\bar{g})(y, z) .
\end{aligned}
$$

We obtain

$$
\begin{aligned}
& \left(\theta_{\mathcal{E}}-\bar{\theta}_{\mathcal{E}}\right)(x, y, z) \\
= & h(x) \cdot(s(y) \cdot s(z)-s(y \cdot z))+\bar{s}(x) \cdot(g-\bar{g})(y, z) \\
& +h(x) \cdot(s(z) \cdot s(y)-s(z \cdot y))+\bar{s}(x) \cdot(g-\bar{g})(z, y) \\
& -(g-\bar{g})(x \cdot y, z)+(g-\bar{g})(x, y \cdot z+z \cdot y) \\
& -(s(x) \cdot s(y)-s(x \cdot y)) \cdot h(z)-(g-\bar{g})(x, y) \cdot \bar{s}(z)
\end{aligned}
$$

where $g(x, y)=q(s(x) \cdot s(y)-s(x \cdot y))$ and $\bar{g}(x, y)=q(\bar{s}(x) \cdot \bar{s}(y)-\bar{s}(x \cdot y))$. We define a $\operatorname{map} b: Z^{\otimes 2} \rightarrow V$ as follows.

$$
b(x, y)=s(x) \cdot h(y)-h(x \cdot y)+h(x) \cdot s(y)-h(x) \cdot \partial h(y)
$$

Then a easy calculation shows that $\partial b=\partial(g-\bar{g})$, thus $(g-\bar{g}-b)$ is a map from $Z^{\otimes 2}$ to $M$. Now we can replace $(g-\bar{g})$ by $b$ without changing the equality in $\mathbf{H}^{3}(Z, M)$ since the difference is the coboundary $d^{2}(g-\bar{g}-b)$. After replacing $(g-\bar{g})$ by $b$, since $\partial: V \rightarrow A$ is a crossed module, we obtain the equality $\left(\theta_{\mathcal{E}}-\bar{\theta}_{\mathcal{E}}\right)(x, y, z)=0$ in $\mathbf{H}^{3}(Z, M)$. This proves that the class of $\theta_{\mathcal{E}}$ does not depend on the section $s$.

At last, consider two equivalent crossed module extensions


Let $s: Z \rightarrow A$ and $q: \operatorname{Im}(\partial) \rightarrow V$ be sections of $\pi$ and $\partial$ and let $s^{\prime}: Z \rightarrow A^{\prime}$ and $q^{\prime}: \operatorname{Im}\left(\partial^{\prime}\right) \rightarrow V^{\prime}$ be sections of $\pi^{\prime}$ and $\partial^{\prime}$. Then

$$
\begin{aligned}
& \theta_{\mathcal{E}}(x, y, z) \\
= & s(x) \cdot(g(y, z)+g(z, y))-g(x \cdot y, z)+g(x, y \cdot z+z \cdot y)-g(x, y) \cdot s(z) \\
= & s(x) \cdot q(s(y) \cdot s(z)-s(y \cdot z))+s(x) \cdot q(s(z) \cdot s(y)-s(z \cdot y)) \\
& -q(s(x \cdot y) \cdot s(z)-s((x \cdot y) \cdot z)) \\
& +q(s(x) \cdot s(y \cdot z+z \cdot y)-s(x \cdot(y \cdot z+z \cdot y)) \\
& -q(s(x) \cdot s(y)-s(x \cdot y)) \cdot s(z) .
\end{aligned}
$$

Since $\pi^{\prime} \beta s=1$ then $\beta s$ is another section for $\pi^{\prime}$ and therefore we can now replace $s^{\prime}$ by $\beta s$ and we obtain the following equality in $\mathbf{H}^{3}(Z, M)$.

$$
\begin{aligned}
& \left(\theta_{\mathcal{E}}-\theta_{\mathcal{E}^{\prime}}\right)(x, y, z) \\
= & \beta s(x)\left(\left(\alpha q-q^{\prime} \beta\right)(s(y) \cdot s(z)-s(y \cdot z))\right) \\
& +\beta s(x)\left(\left(\alpha q-q^{\prime} \beta\right)(s(z) \cdot s(y)-s(z \cdot y))\right) \\
& -\left(\alpha q-q^{\prime} \beta\right)(s(x \cdot y) \cdot s(z)-s((x \cdot y) \cdot z) \\
& +\left(\alpha q-q^{\prime} \beta\right)(s(x) \cdot s(y \cdot z+z \cdot y)-s(x \cdot(y \cdot z+z \cdot y)) \\
& -\left(\alpha q-q^{\prime} \beta\right)(s(x) \cdot s(y)-s(x \cdot y)) \cdot \beta s(z)
\end{aligned}
$$

Thus $\left(\theta_{\mathcal{E}}-\theta_{\mathcal{E}^{\prime}}\right)(x, y, z)=d^{2} \phi(x, y, z)$, where $\phi: \otimes^{2} Z \rightarrow M$ is defined by

$$
\phi(x, y)=\left(\alpha q-q^{\prime} \beta\right)(s(x) \cdot s(y)-s(x \cdot y))
$$

This proves that $\theta_{\mathcal{E}}=\theta_{\mathcal{E}^{\prime}}$ in $\mathbf{H}^{3}(Z, M)$ and that the class of $\theta_{\mathcal{E}}$ in $\mathbf{H}^{3}(Z, M)$ does not depend on the sections $s$ and $q$. Therefore the map $\xi: \mathbf{C E x t}(Z, M) \rightarrow \mathbf{H}^{\mathbf{3}}(Z, M)$ is well defined.

## 5 Relation with dendriform 2-algebras

Definition 5.1. A 2-term $A_{\infty}$-algebra $\mathcal{A}=\mathcal{A}_{0} \oplus \mathcal{A}_{1}$ is a complex consisting of the following data:

- two vector spaces $\mathcal{A}_{0}$ and $\mathcal{A}_{1}$ together with a linear map $m_{1}=\mathrm{d}: \mathcal{A}_{1} \rightarrow \mathcal{A}_{0}$,
- a bilinear map $m_{2}: \mathcal{A}_{i} \times \mathcal{A}_{j} \rightarrow \mathcal{A}_{i+j}$, where $0 \leq i+j \leq 1$,
- a trilinear map $m_{3}: \mathcal{A}_{0} \times \mathcal{A}_{0} \times \mathcal{A}_{0} \rightarrow \mathcal{A}_{1}$.

These maps satisfy the following conditions: for all $x, y, z, t \in \mathcal{A}_{0}$ and $h, k \in \mathcal{A}_{1}$,
(a) $m_{2}(h, k)=0$,
(b1) $\mathrm{d}\left(m_{2}(x, h)\right)=m_{2}(x, \mathrm{~d} h)$,
(b2) $\mathrm{d}\left(m_{2}(h, x)\right)=m_{2}(\mathrm{~d} h, x)$,
(c) $m_{2}(\mathrm{~d} h, k)=m_{2}(h, \mathrm{~d} k)$,
(d) $\mathrm{d}\left(m_{3}(x, y, z)\right)=m_{2}\left(x, m_{2}(y, z)\right)-m_{2}\left(m_{2}(x, y), z\right)$,
(e1) $m_{3}(x, y, \mathrm{~d} h)=m_{2}\left(x, m_{2}(y, h)\right)-m_{2}\left(x, m_{2}(y, h)\right)$,
(e2) $m_{3}(x, \mathrm{~d} h, z)=m_{2}\left(m_{2}(x, h), z\right)-m_{2}\left(x, m_{2}(h, z)\right)$,
$(e 2) m_{3}(\mathrm{~d} h, y, z)=m_{2}\left(m_{2}(h, y), z\right)-m_{2}\left(h, m_{2}(y, z)\right)$,
(f) $m_{2}\left(x, m_{3}(y, z, t)\right)-m_{3}\left(m_{2}(x, y), z, t\right)+m_{3}\left(x, m_{2}(y, z), t\right)-m_{3}\left(y, z, m_{2}(x, t)\right)$ $+m_{2}\left(m_{3}(x, y, z), t\right)=0$.

A 2-term $A_{\infty}$-algebra is called 2-term $C_{\infty}$-algebras if $m_{2}$ and $m_{3}$ are commutative maps.
Definition 5.2. A 2-term Dend $_{\infty}$-algebra $\mathcal{D}=\mathcal{D}_{0} \oplus \mathcal{D}_{1}$ consists of the following data

- a chain complex $\mu_{1}=\mathrm{d}: \mathcal{D}_{1} \xrightarrow{\mathrm{~d}} \mathcal{D}_{0}$,
- bilinear maps $\mu_{2}: \mathbb{K}\left[C_{2}\right] \otimes\left(\mathcal{D}_{i} \otimes \mathcal{D}_{j}\right) \rightarrow \mathcal{D}_{i+j}$,
- a trilinear maps $\mu_{3}: \mathbb{K}\left[C_{3}\right] \otimes\left(\mathcal{D}_{0} \otimes \mathcal{D}_{0} \otimes \mathcal{D}_{0}\right) \rightarrow \mathcal{D}_{1}$
such that the following identities are hold:
(i) $\mu_{2}([r] ; m, n)=0$,
(ii) $\mathrm{d} \mu_{2}([r] ; a, m)=\mu_{2}([r] ; a, \mathrm{~d} m)$,
(iii) $\mathrm{d} \mu_{2}([r] ; m, a)=\mu_{2}([r] ; \mathrm{d} m, a)$,
(iv) $\mu_{2}([r] ; \mathrm{d} m, n)=\mu_{2}([r] ; m, \mathrm{~d} n)$,
(v) $\left(\mu_{2} \circ_{1} \mu_{2}-\mu_{2} \circ_{2} \mu_{2}\right)([s] ; a, b, c)=d \mu_{3}([s] ; a, b, c)$,
(vi1) $\left(\mu_{2} \circ_{1} \mu_{2}-\mu_{2} \circ_{2} \mu_{2}\right)([s] ; a, b, m)=\mu_{3}([s] ; a, b, \mathrm{~d} m)$,
(vi2) $\left(\mu_{2} \circ_{1} \mu_{2}-\mu_{2} \circ_{2} \mu_{2}\right)([s] ; a, m, c)=\mu_{3}([s] ; a, \mathrm{~d} m, c)$,
(vi3) $\left(\mu_{2} \circ_{1} \mu_{2}-\mu_{2} \circ_{2} \mu_{2}\right)([s] ; m, b, c)=\mu_{3}([s] ; \mathrm{d} m, b, c)$,
(vii) $\left(\mu_{3} \circ_{1} \mu_{2}-\mu_{3} \circ_{2} \mu_{2}+\mu_{3} \circ_{3} \mu_{2}\right)([t] ; a, b, c, e)=\left(\mu_{2} \circ_{1} \mu_{3}+\mu_{2} \circ_{2} \mu_{3}\right)([t] ; a, b, c, e)$,
for all $a, b, c, e \in \mathcal{A}_{0} ; m, n \in \mathcal{A}_{1} ;[r] \in C_{2} ;[s] \in C_{3}$ and $[t] \in C_{4}$.
In the above definition, we define two maps $\mu_{2}: \mathbb{K}\left[C_{2}\right] \otimes\left(A_{i} \otimes A_{j}\right) \rightarrow A_{i+j}$ by

$$
\mu_{2}([r] ; a, m)=\left\{\begin{array}{lll}
a \prec m & \text { if } & {[r]=[1]} \\
a \succ m & \text { if } & {[r]=[2]}
\end{array}\right.
$$

for $a \in A_{i}, m \in A_{j}$. Other maps related to $[s] \in C_{3}$ and $[t] \in C_{4}$ are defined similarly. For details, see [3].
Proposition 5.3. From a 2-term $Z_{\infty}$-algebra $\mathcal{V}=\mathcal{V}_{0} \oplus \mathcal{V}_{1}$, we can obtain a 2-term $C_{\infty}$-algebras by

$$
\begin{aligned}
m_{1}= & l_{1} \\
m_{2}(x, y)= & \frac{1}{2}\left(l_{2}(x, y)+l_{2}(y, x)\right) \\
m_{2}(x, h)= & \frac{1}{2}\left(l_{2}(x, h)+l_{2}(h, x)\right) \\
m_{3}(x, y, z)= & \frac{1}{6}\left(l_{3}(x, y, z)+l_{3}(y, z, x)\right. \\
& +l_{3}(z, x, y)+\left(l_{3}(y, x, z)+l_{3}(z, y, x)+l_{3}(x, z, y)\right)
\end{aligned}
$$

This 2-term $C_{\infty}$-algebras is called a symmetrization of the Zinbiel 2-algebra $\mathcal{V}$.
Proposition 5.4. From a 2-term $Z_{\infty}$-algebra $\mathcal{V}=\mathcal{V}_{0} \oplus \mathcal{V}_{1}$, we can obtain a 2-term Dend $_{\infty}$-algebras by

$$
\begin{aligned}
\mu_{1} & =l_{1}, \\
\mu_{2}([1], x, y) & =l_{2}(x, y), \quad \mu_{2}([2], x, y)=l_{2}(y, x), \\
\mu_{2}([1], x, h) & =l_{2}(x, h), \quad \mu_{2}([2], x, h)=l_{2}(h, x), \\
\mu_{3}([1], x, y, z) & =l_{3}(x, y, z), \quad \mu_{3}([2], x, y, z)=l_{3}(y, z, x) \\
\mu_{3}([3], x, y, z) & =l_{3}(z, x, y) .
\end{aligned}
$$

Let $\mathcal{A}$ be an associate 2-algebra. A Rota-Baxter operator on it is given by linear maps $R_{0}: \mathcal{A}_{0} \rightarrow \mathcal{A}_{0}$ and $R_{1}: \mathcal{A}_{1} \rightarrow \mathcal{A}_{1}$ satisfying:

$$
\begin{aligned}
m_{2}\left(R_{0}\left(x_{1}\right), R_{0}\left(x_{2}\right)\right)= & R_{0}\left(m_{2}\left(x_{1}, R_{0}\left(x_{2}\right)\right)+m_{2}\left(R_{0}\left(x_{1}\right), x_{2}\right)\right), \\
m_{2}\left(R_{1}\left(x_{1}\right), R_{1}(h)\right)= & R_{0}\left(m_{2}\left(x_{1}, R_{1}(h)\right)+m_{2}\left(R_{0}\left(x_{1}\right), h\right)\right), \\
m_{2}\left(R_{1}(h), R_{0}\left(x_{1}\right)\right)= & R_{0}\left(m_{2}\left(h, R_{0}\left(x_{1}\right)\right)+m_{2}\left(R_{1}(h), x_{1}\right)\right), \\
m_{3}\left(R_{0}\left(x_{1}\right), R_{0}\left(x_{2}\right), R_{0}\left(x_{3}\right)\right)= & R_{0}\left(m_{3}\left(x_{1}, R_{0}\left(x_{2}\right), R_{0}\left(x_{3}\right)\right)\right. \\
& \left.+m_{3}\left(R_{0}\left(x_{1}\right), x_{2}, R_{0}\left(x_{3}\right)\right)+m_{3}\left(R_{0}\left(x_{1}\right), R_{0}\left(x_{2}\right), x_{3}\right)\right) .
\end{aligned}
$$

Proposition 5.5. Let $\mathcal{A}$ be an 2-term $C_{\infty}$-algebras and $\left(R_{0}, R_{1}\right)$ be a Rota-Baxter operator on it. Then $\mathcal{A}$ is a 2-term $Z_{\infty}$-algebra, where

$$
\begin{aligned}
l_{2}\left(x_{1}, x_{2}\right)= & m_{2}\left(x_{1}, R_{0}\left(x_{2}\right)\right)+m_{2}\left(R_{0}\left(x_{1}\right), x_{2}\right), \\
l_{2}\left(x_{1}, h\right)= & m_{2}\left(x_{1}, R_{0}(h)\right)+m_{2}\left(R_{0}\left(x_{1}\right), h\right), \\
l_{2}\left(h, x_{1}\right)= & m_{2}\left(h, R_{0}\left(x_{1}\right)\right)+m_{2}\left(R_{1}(h), x_{1}\right), \\
l_{3}\left(x_{1}, x_{2}, x_{3}\right)= & m_{3}\left(x_{1}, R_{0}\left(x_{2}\right), R_{0}\left(x_{3}\right)\right) \\
& +m_{3}\left(R_{0}\left(x_{1}\right), x_{2}, R_{0}\left(x_{3}\right)\right)+m_{3}\left(R_{0}\left(x_{1}\right), R_{0}\left(x_{2}\right), x_{3}\right) .
\end{aligned}
$$
