# BOUNDEDNESS OF PRECOMPACT SETS OF METRIC MEASURE SPACES

### DAISUKE KAZUKAWA AND TAKUMI YOKOTA

ABSTRACT. We give a detailed proof to Gromov's statement that precompact sets of metric measure spaces are bounded with respect to the box distance and the Lipschitz order.

#### 1. Introduction

A metric measure space, or an mm-space for short, is a triple  $X = (X, d_X, \mu_X)$ , where  $\mu_X$  is a Borel probability measure on a complete separable metric space  $(X, d_X)$ . Among other things, Gromov [G] introduced a distance function  $\square$ , called the box distance, and a partial order  $\prec$ , called the Lipschitz order, on the set  $\mathcal{X}$  of all (isomorphism classes of) mm-spaces. Our main reference is Shioya's book [S].

For mm-spaces X and Y, we say that X dominates Y and write  $Y \prec X$  if there exists a 1-Lipschitz map  $f: X \to Y$  with  $f_*\mu_X = \mu_Y$ , e.g. [S, Definition 2.10].

The purpose of this note is to give a detailed proof of the following statement, which was only sketched in [G].

**Theorem 1** (Gromov [G,  $3\frac{1}{2}$ .15.(f)]). If  $\mathcal{Y} \subset \mathcal{X}$  is a precompact set in  $(\mathcal{X}, \square)$ , then there exists an mm-space X with  $Y \prec X$  for any  $Y \in \mathcal{Y}$ .

In Theorem 1, the product of spaces in  $\mathcal{Y}$  does the job if  $\mathcal{Y}$  is a finite set, cf. [S, Proposition 4.57], but we do not know such a simple construction of X in general.

Example 2. Let  $K \in \mathbb{R}$ ,  $N \in \mathbb{N}$ , and D > 0. The set  $\mathcal{X}_{\leq N}^D$  of finite mm-spaces with cardinality  $\leq N$  and diameter  $\leq D$  is a typical example of  $\square$ -compact sets, e.g. [S, Theorem 4.27]. The set  $\mathcal{M}(K, N, D)$  of closed Riemannian manifolds with Ricci curvature  $\geq K$ , dimension  $\leq N$ , and diameter  $\leq D$  is a measured GH precompact and hence  $\square$ -precompact, cf. [S, Remarks 4.32, 4.34]. Here and hereafter, GH stands for Gromov-Hausdorff.

We remark that the *pyramid* 

(3) 
$$\mathcal{P}_X := \{ Y \in \mathcal{X} : Y \prec X \}$$

associated with an mm-space X is a compact set in  $(\mathcal{X}, \square)$ , e.g. [S, Chapter 6], and the converse of Theorem 1 also holds, cf. Corollary 28.

For metric spaces X and Y, we write  $Y \prec X$  if there exists a 1-Lipschitz surjection  $f: X \to Y$ . The following is a byproduct of this work and a GH analog of Theorem 1.

**Proposition 4.** If a set  $\mathcal{Y}$  of compact metric spaces is GH-precompact, then there exists a compact metric space X with  $Y \prec X$  for any  $Y \in \mathcal{Y}$ .

After some preparations in Section 2, we present a proof of Theorem 1 in Section 3. Our proof is a slight modification of Gromov's sketch in [G]. In Section 4, we prove Proposition 4.

In our argument, we do not pay careful attention to distinguish an mm-space and an element of  $\mathcal{X}$  and consider an element x of a product  $\prod_{\lambda \in \Lambda} X_{\lambda}$  of a family  $\{X_{\lambda}\}_{{\lambda} \in \Lambda}$  of sets as a map  $x: \Lambda \to \bigcup_{{\lambda} \in \Lambda} X_{\lambda}$  with  $x({\lambda}) \in X_{\lambda}$  for any  ${\lambda} \in \Lambda$ .

## 2. Preliminaries

In this section, we recall some definitions and facts from [S]. A reader who is familiar with it can safely skip this section. We will use the notations in [S] such as

$$U_{\varepsilon}(A) := \{ x \in X : d_X(x, A) < \varepsilon \}$$

for a subset  $A \subset X$  of a metric space  $(X, d_X)$  and  $\varepsilon > 0$ .

**Definition 5** (e.g. [S, Definition 4.21]). Let X and Y be mm-spaces and  $\varepsilon > 0$ . We call a Borel map  $f: X \to Y$  an  $\varepsilon$ -mm-isomorphism if there exists a Borel set  $\tilde{X} \subset X$ , called a non-exceptional domain, with

- (1)  $\mu_X(\tilde{X}) \ge 1 \varepsilon$ ,
- (2)  $|d_X(x,x') d_Y(f(x),f(x'))| \le \varepsilon$  for any  $x,x' \in \tilde{X}$ , and
- (3)  $d_P(f_*\mu_X, \mu_Y) \le \varepsilon$ ,

where  $d_P$  denotes the Prohorov distance between Borel probability measures on  $(X, d_X)$ .

The definition of the box distance  $\square$  can be found in e.g. [S, Definition 4.4]. We know that  $(\mathcal{X}, \square)$  is a complete metric space, e.g. [S, Theorems 4.10, 4.14]. We need the following rather than its precise definition.

**Lemma 6** (e.g. [S, Lemma 4.22]). Let X and Y be mm-spaces and  $\varepsilon > 0$ .

- (1) If there exists an  $\varepsilon$ -mm-isomorphism  $f: X \to Y$ , then  $\square(X,Y) \leq 3\varepsilon$ .
- (2) If  $\square(X,Y) < \varepsilon$ , then there exists a  $3\varepsilon$ -mm-isomorphism  $f: X \to Y$ .

We summarize a lemma in [S] as follows.

**Lemma 7** (e.g. [S, Lemma 4.28]). Let  $\mathcal{Y} \subset \mathcal{X}$ . Then  $\mathcal{Y}$  is  $\square$ -precompact if and only if there exists  $\Delta = \Delta(\varepsilon) < \infty$  for any  $\varepsilon > 0$  such that any  $Y \in \mathcal{Y}$  admits a set  $\mathcal{K}_Y$  of Borel sets of Y with

$$\#\mathcal{K}_Y \leq \Delta$$
,  $\max_{K \in \mathcal{K}_Y} \operatorname{diam} K \leq \varepsilon$ ,  $\operatorname{diam} \bigcup \mathcal{K}_Y \leq \Delta$ , and  $\mu_Y(\bigcup \mathcal{K}_Y) \geq 1 - \varepsilon$ .

**Definition 8** ([S, Definitions 6.3, 6.4]). A *pyramid* is a non-empty closed set  $\mathcal{P}$  in  $(\mathcal{X}, \square)$  with the following properties:

- (1) If  $X \in \mathcal{P}$  and  $Y \in \mathcal{X}$  satisfy  $Y \prec X$ , then  $Y \in \mathcal{P}$ .
- (2) If  $X, Y \in \mathcal{P}$ , then there exists  $Z \in \mathcal{P}$  with  $X, Y \prec Z$ .

We say that a sequence  $\{\mathcal{P}_n\}_{n=1}^{\infty}$  of pyramids converges weakly to a pyramid  $\mathcal{P}$  if

- (1)  $\lim_{n\to\infty} \Box(X, \mathcal{P}_n) = 0$  for any  $X \in \mathcal{P}$  and
- (2)  $\liminf_{n\to\infty} \Box(Y, \mathcal{P}_n) > 0$  for any  $Y \in \mathcal{X} \setminus \mathcal{P}$ .

A typical example of pyramids is  $\mathcal{P}_X$  associated with an mm-space X in (3). The only fact that we need is that the sequence  $\{\mathcal{P}_{X_n}\}_{n=1}^{\infty}$  of pyramids converges weakly to  $\mathcal{P}_Y$  if a sequence  $\{X_n\}_{n=1}^{\infty}$  of mm-spaces converges to an mm-space Y in  $(\mathcal{X}, \square)$ , e.g. [S, Propositions 5.5, 6.13].

## 3. Proof of Theorem 1

In this section, we make some preparations and present a proof of Theorem 1.

**Definition 9.** Let  $C, D \ge 0$ . We say that a map  $f: X \to Y$  between metric spaces X and Y is (C, D)-Lipschitz if it satisfies

$$d_Y(f(x), f(x')) \le Cd_X(x, x') + D$$

for any  $x, x' \in X$ . A (C, 0)-Lipschitz map is simply called a C-Lipschitz map.

**Lemma 10** (cf. [S, Lemma 4.19]). Let X be an mm-space and  $\varepsilon, \varepsilon' > 0$ . If a set A of disjoint Borel sets of X and a Borel probability measure  $\nu$  on X satisfy

$$\sup_{A \in \mathcal{A}} \operatorname{diam} A \leq \varepsilon, \qquad \mu_X(C) \leq \varepsilon, \qquad \sum_{A \in \mathcal{A}} |\mu_X(A) - \nu(A)| \leq \varepsilon',$$

where  $C := X \setminus \bigcup A$ , then  $d_P(\mu_X, \nu) \leq \varepsilon + \varepsilon'$ .

*Proof.* Take any Borel set B of X and let  $\mathcal{A}' := \{A \in \mathcal{A} : A \cap B \neq \emptyset\}$  and  $\overline{\varepsilon} := \varepsilon + \varepsilon'$ . Then we have

$$\mu_X(B) \le \sum_{A \in \mathcal{A}'} \mu_X(A) + \mu_X(C) \le \sum_{A \in \mathcal{A}'} \nu(A) + \overline{\varepsilon} \le \nu(U_{\overline{\varepsilon}}(B)) + \overline{\varepsilon}$$

and obtain  $d_P(\mu_X, \nu) \leq \overline{\varepsilon}$ .

In applying Lemma 10, we note that  $1 - \varepsilon \le \nu(A)/\mu_X(A) \le 1 + \varepsilon$  for any  $A \in \mathcal{A}$  implies

$$\sum_{A \in \mathcal{A}} |\mu_X(A) - \nu(A)| \le \varepsilon \sum_{A \in \mathcal{A}} \mu_X(A) \le \varepsilon.$$

**Definition 11** (cf. [N]). Let X, Y be mm-spaces,  $\mathcal{Y} \subset \mathcal{X}$  a subset, and  $\varepsilon > 0$ .

We write  $\mathcal{Y} \prec X$  if  $Y \prec X$  for any  $Y \in \mathcal{Y}$ .

We write  $Y \prec_{\varepsilon} X$  if there exist a Borel set  $X \subset X$ , called a non-exceptional domain, and a Borel map  $f: X \to Y$  with

- (1)  $\mu_X(\tilde{X}) \geq 1 \varepsilon$ ,
- (2)  $d_Y(f(x), f(x')) \le d_X(x, x') + \varepsilon$  for any  $x, x' \in \tilde{X}$ , and
- (3)  $d_P(f_*\mu_X, \mu_Y) \leq \varepsilon$ .

We write  $\mathcal{Y} \prec_{\varepsilon,0} X$  if the condition  $Y \prec_{\varepsilon} X$  holds with  $\tilde{X} = X$  for any  $Y \in \mathcal{Y}$ .

**Lemma 12.** Let Y be an mm-space and  $\varepsilon > 0$ . Suppose that A is a finite set of disjoint Borel sets of Y with

diam 
$$A < \varepsilon$$
,  $\mu_Y(\partial A) = 0$ , and  $\mu_Y(A) > 0$  for any  $A \in \mathcal{A}$ .

Then there exists an open neighborhood  $\mathcal{O} = \mathcal{O}(Y, \mathcal{A}, \varepsilon) \subset \mathcal{X}$  of Y in  $(\mathcal{X}, \square)$  for which any  $Z \in \mathcal{O}$  admits a Borel map  $\Phi : Y \to Z$  and a finite set  $\mathcal{A}_Z$  of disjoint Borel sets of Z with

- (1)  $|d_Y(y, y') d_Z(\Phi(y), \Phi(y'))| < 3\varepsilon$  for any  $y, y' \in U$ , where  $U := \bigcup A$ ,
- (2) diam  $A < \varepsilon$ ,  $\mu_Z(A) > 0$ ,  $\Phi^{-1}(A) \cap U \in \mathcal{A}$ , and

$$1 - \varepsilon < \frac{\Phi_* \mu_Y(A)}{\mu_Z(A)} < 1 + \varepsilon \text{ for any } A \in \mathcal{A}_Z, \text{ and }$$

(3)  $\Phi(U) \subset U_Z$ , where  $U_Z := \bigcup A_Z$ .

Proof. If such a neighborhood  $\mathcal{O}(Y, \mathcal{A}, \varepsilon)$  does not exist, there exists a sequence  $\{Z_n\}_{n=1}^{\infty}$  of mm-spaces with  $\square(Z_n, Y) \to 0$  as  $n \to \infty$  for which  $Z_n$  does not admit such  $\mathcal{A}_{Z_n}$ . Then there exists an  $\varepsilon_n$ -mm-isomorphism  $\Psi_n : Z_n \to Y$  with a non-exceptional domain  $\tilde{Z}_n \subset Z_n$  for each n with  $\varepsilon_n \to 0$  as  $n \to \infty$  by Lemma 6. We define

$$\mathcal{A}_{Z_n} := \{ \Psi_n^{-1}(A) \cap \tilde{Z}_n : A \in \mathcal{A} \} \quad \text{and} \quad U_{Z_n} := \bigcup \mathcal{A}_{Z_n}.$$

Note that  $\operatorname{diam}(\Psi_n^{-1}(A) \cap \tilde{Z}_n) \leq \operatorname{diam} A + \varepsilon_n < \varepsilon$  for any  $A \in \mathcal{A}$  and large n. Since  $(\Psi_n)_*\mu_{Z_n}$  weakly converges to  $\mu_Y$ , the Portmanteau theorem implies

(13) 
$$\lim_{n \to \infty} \mu_{Z_n}(\Psi_n^{-1}(A) \cap \tilde{Z}_n) = \lim_{n \to \infty} (\Psi_n)_* \mu_{Z_n}(A) = \mu_Y(A) > 0$$

and we choose a point  $\operatorname{pt}_{A,n} \in \Psi_n^{-1}(A) \cap \tilde{Z}_n$  for each  $A \in \mathcal{A}$ . We also note that

$$\lim_{n \to \infty} \mu_{Z_n}(U_{Z_n}) = \lim_{n \to \infty} \mu_{Z_n}(\Psi_n^{-1}(U)) = \lim_{n \to \infty} (\Psi_n)_* \mu_{Z_n}(U) = \mu_Y(U)$$

and choose some  $z_n \in Z_n$  if  $\mu_Y(U) = 1$  and  $z_n \in Z_n \setminus U_{Z_n}$  if  $\mu_Y(U) < 1$ . Define a map  $\Phi_n : Y \to Z_n$  as

$$\Phi_n(y) := \left\{ \begin{array}{ll} \operatorname{pt}_{A,n} & \text{if } y \in A, \\ z_n & \text{if } y \in Y \setminus U. \end{array} \right.$$

Then we have  $\Phi_n(U) \subset U_{Z_n}$  and

$$|d_{Y}(y, y') - d_{Z_{n}}(\Phi_{n}(y), \Phi_{n}(y'))| = |d_{Y}(y, y') - d_{Z_{n}}(\operatorname{pt}_{A, n}, \operatorname{pt}_{A', n})|$$

$$\leq |d_{Y}(y, y') - d_{Y}(\Psi_{n}(\operatorname{pt}_{A, n}), \Psi_{n}(\operatorname{pt}_{A', n}))| + \varepsilon_{n}$$

$$\leq d_{Y}(y, \Psi_{n}(\operatorname{pt}_{A, n})) + d_{Y}(y', \Psi_{n}(\operatorname{pt}_{A', n})) + \varepsilon_{n} < 3\varepsilon$$

for any  $y \in A$  and any  $y' \in A'$  with  $A, A' \in A$ .

Moreover we have  $\mu_Y(\Phi_n^{-1}(\Psi_n^{-1}(A) \cap \tilde{Z}_n)) = \mu_Y(A)$  and Equation (13) implies

$$\lim_{n \to \infty} \frac{(\Phi_n)_* \mu_Y(\Psi_n^{-1}(A) \cap \tilde{Z}_n)}{\mu_{Z_n}(\Psi_n^{-1}(A) \cap \tilde{Z}_n)} = \frac{\mu_Y(A)}{\mu_Y(A)} = 1$$

for every  $A \in \mathcal{A}$ . These contradict the assumption and finish the proof.

Corollary 14. Let Y be an mm-space and  $\varepsilon > 0$ . Suppose that  $\mathcal{A}$  is as in Lemma 12. Then there exists an open neighborhood  $\mathcal{O} = \mathcal{O}(Y, \mathcal{A}, \varepsilon) \subset \mathcal{X}$  of Y in  $(\mathcal{X}, \square)$  with the following properties: If X is an mm-space and  $h: X \to Y$  is a Borel map with  $h(X) \subset U := \bigcup \mathcal{A}$ , then any  $Z \in \mathcal{O}$  admits a Borel map  $h_Z: X \to Z$  and a finite set  $\mathcal{A}_Z$  of disjoint Borel sets of Z with

- (1) diam  $A < \varepsilon$  and  $\mu_Z(A) > 0$  for any  $A \in \mathcal{A}_Z$ ,
- (2)  $|d_Y(h(x), h(x')) d_Z(h_Z(x), h_Z(x'))| < 3\varepsilon \text{ for any } x, x' \in h^{-1}(U),$
- (3)  $h_Z(X) \subset U_Z$ , where  $U_Z := \bigcup A_Z$ , and
- (4) there is a bijection  $A_Z \to A$ ;  $A \mapsto A_Y$  for which any  $A \in A_Z$  satisfies

$$(h_Z)_*\mu_X(A) = h_*\mu_X(A_Y)$$
 and  $1 - \varepsilon < \frac{\mu_Y(A_Y)}{\mu_Z(A)} < 1 + \varepsilon.$ 

*Proof.* Let  $\mathcal{O} = \mathcal{O}(Y, \mathcal{A}, \varepsilon)$  be as in Lemma 12. For  $Z \in \mathcal{O}$ , let  $\Phi : Y \to Z$  and  $\mathcal{A}_Z$  be also as in Lemma 12 and define  $h_Z := \Phi \circ h : X \to Z$ .

If  $x, x' \in X$  and  $y = h(x), y' = h(x') \in U$ , we have

$$|d_Y(h(x), h(x')) - d_Z(h_Z(x), h_Z(x'))| = |d_Y(y, y') - d_Z(\Phi(y), \Phi(y'))| < 3\varepsilon.$$

For any  $A \in \mathcal{A}_Z$ , the set  $A_Y := \Phi^{-1}(A) \cap U \in \mathcal{A}$  satisfies

$$(h_Z)_*\mu_X(A) = \mu_X(h^{-1}(\Phi^{-1}(A))) = h_*\mu_X(A_Y)$$
 and  $\frac{\mu_Y(A_Y)}{\mu_Z(A)} = \frac{\Phi_*\mu_Y(A)}{\mu_Z(A)}$ .

Thus  $h_Z$  has the desired properties by Lemma 12.

We use the following in the first step of our proof of Theorem 1.

**Lemma 15.** Let  $\mathcal{Y} \subset \mathcal{X}$  be a finite set and  $\mathcal{A}_Y$  a non-empty finite set of disjoint Borel sets of  $Y \in \mathcal{Y}$  with  $\mu_Y(A) > 0$  for any  $A \in \mathcal{A}_Y$  and  $U_Y := \bigcup \mathcal{A}_Y \subset Y$ . Then there exist a finite mm-space X and 1-Lipschitz maps  $f_Y : X \to Y$  with

$$f_Y(X) \subset U_Y$$
 and  $(f_Y)_*\mu_X(A) = \frac{\mu_Y(A)}{\mu_Y(U_Y)}$ 

for any  $Y \in \mathcal{Y}$  and  $A \in \mathcal{A}_Y$ .

*Proof.* We choose  $\operatorname{pt}_A \in A$  for each  $A \in \bigcup_{Y \in \mathcal{Y}} A_Y$  and define  $X := \prod_{Y \in \mathcal{Y}} A_Y$ ,

$$d_X(x,x') := \max_{Y \in \mathcal{Y}} d_Y(\operatorname{pt}_{x(Y)},\operatorname{pt}_{x'(Y)}), \quad \text{ and } \quad \mu_X(\{x\}) := \prod_{Y \in \mathcal{Y}} \frac{\mu_Y(x(Y))}{\mu_Y(U_Y)}$$

for  $x, x' \in X$ . Then  $X = (X, d_X, \mu_X)$  is a finite mm-space and the map

$$f_Y: X \to Y, \quad f_Y(x) = \operatorname{pt}_{x(Y)}$$

is 1-Lipschitz and satisfies

$$(f_Y)_*\mu_X(A) = \mu_X(f_Y^{-1}(A)) = \mu_X(f_Y^{-1}(\operatorname{pt}_A)) = \frac{\mu_Y(A)}{\mu_Y(U_Y)}$$

for any  $Y \in \mathcal{Y}$  and  $A \in \mathcal{A}_Y$ . This finishes the proof.

Although we do not use the following in our argument, we record it for possible future applications.

Corollary 16. If  $\mathcal{Y} \subset \mathcal{X}$  is precompact in  $(\mathcal{X}, \square)$  and  $\varepsilon > 0$ , then there exists a finite mm-space X with  $\mathcal{Y} \prec_{\varepsilon,0} X$ .

*Proof.* Since any mm-space X satisfies  $\mathcal{Y} \prec_{\varepsilon,0} X$  if  $\varepsilon \geq 1$ , we may assume that  $\varepsilon < 1$ . For each  $Y \in \overline{\mathcal{Y}}$ , we take a finite set  $\mathcal{A}_Y$  of disjoint Borel sets of Y with

diam 
$$A < \varepsilon$$
,  $\mu_Y(\partial A) = 0$ ,  $\mu_Y(A) > 0$  for any  $A \in \mathcal{A}_Y$  and  $\mu_Y(U_Y) > (1 + \varepsilon)^{-1}$ ,

where  $U_Y := \bigcup \mathcal{A}_Y$ , cf. [OY, Lemma 42]. Since  $\mathcal{Y}$  is  $\square$ -precompact, Corollary 14 implies that there exists a finite subset  $\mathcal{Y}' \subset \overline{\mathcal{Y}}$  with  $\mathcal{Y} \subset \bigcup_{Y \in \mathcal{Y}'} \mathcal{O}(Y, \mathcal{A}_Y, \varepsilon)$  and Lemma 15 states that there exist a finite mm-space X and 1-Lipschitz maps  $f_Y : X \to Y$  with

$$f_Y(X) \subset U_Y$$
 and  $\frac{(f_Y)_*\mu_X(A)}{\mu_Y(A)} = \frac{1}{\mu_Y(U_Y)}$ 

for any  $Y \in \mathcal{Y}'$  and  $A \in \mathcal{A}_Y$ . We note that  $\mu_Y(U_Y) > (1 + \varepsilon)^{-1} > 1 - \varepsilon$ .

For any  $Z \in \mathcal{O}(Y, \mathcal{A}_Y, \varepsilon)$  with some  $Y \in \mathcal{Y}'$ , Corollary 14 implies that there exists a map  $f_Z : X \to Z$  with

$$d_Z(f_Z(x), f_Z(x')) \le d_Y(f_Y(x), f_Y(x')) + 3\varepsilon \le d_X(x, x') + 3\varepsilon$$

for any  $x, x' \in X$  and, if we replace  $A_Z$  with the one in Corollary 14, we have  $(1+\varepsilon)^2 < 1+3\varepsilon$ ,

$$1 - \varepsilon < \frac{(f_Z)_* \mu_X(A)}{\mu_Z(A)} = \frac{(f_Y)_* \mu_X(A_Y)}{\mu_Y(A_Y)} \frac{\mu_Y(A_Y)}{\mu_Z(A)} = \frac{1}{\mu_Y(U_Y)} \frac{\mu_Y(A_Y)}{\mu_Z(A)} < 1 + 3\varepsilon$$

for any  $A \in \mathcal{A}_Z$ , and  $\mu_Z(U_Z) > (1 - \varepsilon)\mu_Y(U_Y) > 1 - 2\varepsilon$ .

Then Lemma 10 yields  $d_P(\mu_Y, (f_Y)_*\mu_X) \leq 5\varepsilon$  for any  $Y \in \mathcal{Y}$ . Thus  $\mathcal{Y} \prec_{5\varepsilon,0} X$  and this finishes the proof.

The following two lemmas are the key technical lemmas in our proof of Theorem 1.

**Lemma 17.** Let X be a finite mm-space,  $\mathcal{Y} \subset \mathcal{X}$  a finite subset, and  $\varepsilon, \varepsilon' > 0$ . Suppose that any  $Y \in \mathcal{Y}$  admits a map  $f_Y : X \to Y$  and finite sets  $\mathcal{A}_Y$  and  $\mathcal{A}'_Y$  of disjoint Borel sets of Y with

- (1)  $d_Y(f_Y(x), f_Y(x')) \le d_X(x, x') + \varepsilon$  for any  $x, x' \in X$ ,
- (2)  $f_Y(X) \subset U_Y$ , where  $U_Y := \bigcup A_Y$ ,
- (3) diam  $A \leq \varepsilon$  and  $(f_Y)_*\mu_X(A) = \mu_Y(A)/\mu_Y(U_Y)$  for any  $A \in \mathcal{A}_Y$ ,
- (4)  $\mu_Y(Y \setminus U_Y') < (\varepsilon'/(1+\varepsilon')) \min\{\mu_Y(A) : A \in \mathcal{A}_Y\}, \text{ where } U_Y' := \bigcup \mathcal{A}_Y',$
- (5)  $\mu_Y(B) > 0$  for any  $B \in \mathcal{A}'_Y$ , and
- (6)  $B \subset A \text{ or } A \cap B = \emptyset \text{ if } A \in \mathcal{A}_Y \text{ and } B \in \mathcal{A}'_Y.$

Then there exists a finite mm-space X' with  $\square(X,X') \leq 9\varepsilon$  for which any  $Y \in \mathcal{Y}$  admits a 1-Lipschitz map  $g_Y: X' \to Y$  with  $g_Y(X) \subset U_Y \cap U_Y'$  and

(18) 
$$1 \le \mu_Y(U_Y) \frac{(g_Y)_* \mu_{X'}(B)}{\mu_Y(B)} < 1 + \varepsilon' \text{ for any } B \in \mathcal{A}_Y' \text{ with } B \subset U_Y.$$

*Proof.* For any  $x \in X$  and  $Y \in \mathcal{Y}$ , there exists a unique  $A_{Y,x} \in \mathcal{A}_Y$  with  $f_Y(x) \in A_{Y,x}$ . We put

$$\mathcal{A}'(A) := \{ B \in \mathcal{A}'_{Y} : B \subset A \}$$

for a subset  $A \subset Y$  and define

$$X'_x := \prod_{Y \in \mathcal{Y}} \mathcal{A}'(A_{Y,x}) \text{ for } x \in X \quad \text{ and } \quad X' := \bigsqcup_{x \in X} X'_x.$$

We choose a point  $\operatorname{pt}_B \in B$  for each  $B \in \bigcup_{Y \in \mathcal{Y}} \mathcal{A}'_Y$  and define

$$d_{X'}(\varphi, \varphi') := \max \left\{ \max_{Y \in \mathcal{Y}} d_Y(\operatorname{pt}_{\varphi(Y)}, \operatorname{pt}_{\varphi'(Y)}), d_X(x, x') \right\},$$
  
$$\mu_{X'}(\{\varphi\}) := \mu_X(\{x\}) \frac{\prod_{Y \in \mathcal{Y}} \mu_Y(\varphi(Y))}{\prod_{Y \in \mathcal{Y}} \mu_Y(\bigcup \mathcal{A}'(A_{Y,x}))}$$

for  $\varphi \in X'_x$  and  $\varphi' \in X'_{x'}$  with  $x, x' \in X$ . Then  $X' = (X', d_{X'}, \mu_{X'})$  is a finite mm-space, because  $\mu_{X'}(X'_x) = \mu_X(\{x\})$  for any  $x \in X$  and

$$\mu_{X'}(X') = \sum_{x \in X} \mu_{X'}(X'_x) = \sum_{x \in X} \mu_X(\{x\}) = 1.$$

For any  $Y \in \mathcal{Y}$ , the map  $g_Y : X' \to Y$  defined by  $g_Y(\varphi) = \operatorname{pt}_{\varphi(Y)}$  is 1-Lipschitz and satisfies  $g_Y(X) \subset U_Y \cap U_Y'$ .

The natural map  $\pi: X' \to X$  defined by  $\pi(\varphi) = x$  if  $x \in X$  and  $\varphi \in X'_x$  satisfies  $\pi_*\mu_{X'} = \mu_X$ . For any  $Y \in \mathcal{Y}, \varphi \in X'_x$ , and  $\varphi' \in X'_{x'}$  with  $x, x' \in X'$ , we also have

$$d_Y(\operatorname{pt}_{\varphi(Y)}, \operatorname{pt}_{\varphi'(Y)}) \le d_Y(\operatorname{pt}_{\varphi(Y)}, f_Y(x)) + d_Y(f_Y(x), f_Y(x')) + d_Y(f_Y(x'), \operatorname{pt}_{\varphi'(Y)})$$

$$< d_X(x, x') + 3\varepsilon$$

and hence

(19) 
$$d_X(x, x') \le d_{X'}(\pi(x), \pi(x')) = d_{X'}(\varphi, \varphi') \le d_X(x, x') + 3\varepsilon.$$

Thus Lemma 6 yields  $\square(X, X') \leq 9\varepsilon$ .

Finally, we have

$$\mu_Y(A) - \mu_Y(\bigcup \mathcal{A}'(A)) = \mu_Y(A \setminus U_Y') \le \mu_Y(Y \setminus U_Y') < \frac{\varepsilon'}{1 + \varepsilon'} \mu_Y(A),$$

and

$$(g_Y)_*\mu_{X'}(B) = \mu_{X'}(g_Y^{-1}(B)) = \mu_X(f_Y^{-1}(A)) \frac{\mu_Y(B)}{\mu_Y(\bigcup \mathcal{A}'(A))} = \frac{\mu_Y(A)}{\mu_Y(U_Y)} \frac{\mu_Y(B)}{\mu_Y(\bigcup \mathcal{A}'(A))}$$

for any  $A \in \mathcal{A}_Y$  and  $B \in \mathcal{A}'(A)$ . Thus Inequality (18) follows. This completes the proof of Lemma 17.

**Lemma 20.** Let X be a finite mm-space,  $\mathcal{Y} \subset \mathcal{X}$  a finite subset, and  $\varepsilon, \varepsilon' > 0$  with  $\varepsilon < 1$ . Suppose that any  $Y \in \mathcal{Y}$  admits a map  $g_Y : X \to Y$  and a finite set  $\mathcal{A}_Y$  of disjoint Borel sets of Y with

- (1)  $g_Y(X) \subset U_Y$ , where  $U_Y := \bigcup A_Y$ ,
- (2)  $d_Y(g_Y(x), g_Y(x')) \leq d_X(x, x') + \varepsilon'$  for any  $x, x' \in X$ , and
- (3)  $\mu_Y(A) > 0$  and  $(g_Y)_*\mu_X(A) \leq (1+\varepsilon)\mu_Y(A)$  for any  $A \in \mathcal{A}_Y$ .

Then there exists a finite mm-space X' with  $\square(X, X') \leq 3\varepsilon$  for which any  $Y \in \mathcal{Y}$  admits a map  $f_Y : X' \to Y$  with

- (4)  $f_Y(X') \subset U_Y$ ,
- (5)  $d_Y(f_Y(x), f_Y(x')) \leq d_{X'}(x, x') + \varepsilon'$  for any  $x, x' \in X'$ , and
- (6)  $(f_Y)_*\mu_{X'}(A) = \mu_Y(A)/\mu_Y(U_Y)$  for any  $A \in A_Y$ .

*Proof.* We fix  $x_0 \in X$  and choose some  $\operatorname{pt}_A \in A$  for each  $A \in \mathcal{A}_Y$  with

$$g_Y(x_0) \in Y'$$
, where  $Y' := \{ \operatorname{pt}_A : A \in \mathcal{A}_Y \}$  for any  $Y \in \mathcal{Y}$ .

Then we define a probability measure  $\mu_{Y'}$  on Y' by

$$\mu_{Y'}(\{\operatorname{pt}_A\}) := \frac{1}{\varepsilon} \left( \frac{\mu_Y(A)}{\mu_Y(U_Y)} - (1 - \varepsilon)(g_Y)_* \mu_X(A) \right)$$

for  $A \in \mathcal{A}_Y$  and note that

$$\mu_{Y'}(\{\operatorname{pt}_A\}) \ge \frac{1}{\varepsilon} (1 - (1 - \varepsilon)(1 + \varepsilon))\mu_Y(A) = \varepsilon \mu_Y(A) > 0$$

for any  $A \in \mathcal{A}_Y$  and  $\mu_{Y'}(Y') = 1$ . Thus  $(Y', d_Y, \mu_{Y'})$  is a finite mm-space. We equip  $X'' := \prod_{Y \in \mathcal{Y}} Y'$  with the  $\ell_{\infty}$ -product distance  $d_{X''}$  and define

$$d_{X'}(x,x') = d_{X'}(x',x) := \begin{cases} d_Z(x,x') & \text{if } x,x' \in Z = X \text{ or } X'', \\ d_X(x,x_0) + \operatorname{diam} X'' & \text{if } x \in X \text{ and } x' \in X''. \end{cases}$$

Then we define a probability measure  $\mu_{X'}$  on  $X' := X \sqcup X''$  by

$$\mu_{X'}|_{X} = (1 - \varepsilon)\mu_{X}$$
 and  $\mu_{X'}|_{X''} = \varepsilon \bigotimes_{Y \in \mathcal{Y}} \mu_{Y'}$ 

to make X' an mm-space.

The inclusion  $\iota: X \hookrightarrow X'$  is an  $\varepsilon$ -mm-isomorphism because it is isometric,

$$\iota_*\mu_X(B) = \mu_X(B \cap X) \le (1 - \varepsilon)\mu_X(B \cap X) + \varepsilon \le \mu_{X'}(B) + \varepsilon$$

for any Borel set  $B \subset X'$ , and hence  $d_P(\iota_*\mu_X, \mu_{X'}) \leq \varepsilon$ . Thus Lemma 6 yields  $\square(X, X') \leq 3\varepsilon$ . We fix  $Y \in \mathcal{Y}$  and define a map  $f = f_Y : X' \to Y$  by  $f|_X = g_Y$  and  $f|_{X''} = \operatorname{pr}_{Y'}$ , where  $\operatorname{pr}_{Y'} : X'' \to Y'$  is the projection. In order to check Condition (5), we only have to verify it for  $x \in X$  and  $x' \in X''$  and actually have

$$d_Y(f(x), f(x')) = d_Y(g_Y(x), \operatorname{pr}_Y(x'))$$

$$\leq d_Y(g_Y(x), g_Y(x_0)) + d_Y(g_Y(x_0), \operatorname{pr}_Y(x'))$$

$$\leq d_X(x, x_0) + \varepsilon' + \operatorname{diam} X'' = d_{X'}(x, x') + \varepsilon'.$$

We also have  $f(X') \subset U_Y$  and

$$f_*\mu_{X'}(A) = (1 - \varepsilon)(g_Y)_*\mu_X(A) + \varepsilon\mu_{Y'}(\operatorname{pr}_{Y'}^{-1}(A)) = \frac{\mu_Y(A)}{\mu_Y(U_Y)}$$

for any  $A \in \mathcal{A}_Y$ . This completes the proof of Lemma 20.

We use the following in the final step of our proof of Theorem 1.

**Lemma 21** (cf. [S, Lemma 4.39]). Let  $\{\varepsilon_n\}_{n=1}^{\infty}$  be a sequence of positive numbers with  $\varepsilon_n \to 0$  as  $n \to \infty$ . If sequences  $\{X_n\}_{n=1}^{\infty}$  and  $\{Y_n\}_{n=1}^{\infty}$  of mm-spaces  $\square$ -converge to mm-spaces X and Y respectively and  $Y_n \prec_{\varepsilon_n} X_n$  for any n, then  $Y \prec X$ .

While Lemma 21 follows from Lemma 6 and [S, Lemma 4.39], cf. [N], it also follows from Proposition 23 below.

**Definition 22.** For pyramids  $\mathcal{P}$ ,  $\mathcal{Q}$  and  $\varepsilon > 0$ , we write  $\mathcal{Q} \prec_{\varepsilon} \mathcal{P}$  if any  $Y \in \mathcal{Q}$  admits  $X \in \mathcal{P}$  with  $Y \prec_{\varepsilon} X$ .

**Proposition 23.** Let  $\{\varepsilon_n\}_{n=1}^{\infty}$  be a sequence of positive numbers with  $\varepsilon_n \to 0$  as  $n \to \infty$ . If sequences  $\{\mathcal{P}_n\}_{n=1}^{\infty}$  and  $\{\mathcal{Q}_n\}_{n=1}^{\infty}$  of pyramids converge weakly to pyramids  $\mathcal{P}$  and  $\mathcal{Q}$  respectively and  $\mathcal{Q}_n \prec_{\varepsilon_n} \mathcal{P}_n$  for any n, then  $\mathcal{Q} \subset \mathcal{P}$ .

To prove Proposition 23, we use the following.

**Lemma 24** ([K, Lemma 4.6]). If X and Y are mm-spaces with  $Y \prec_{\varepsilon} X$  for some  $\varepsilon > 0$ , then there exists an mm-space Z with  $Z \prec X$  and  $\Box(Y, Z) \leq 4\varepsilon$ .

Proof of Proposition 23. Let  $Y \in \mathcal{Q}$ . Then a sequence  $\{Y_n\}_{n=1}^{\infty}$  of mm-spaces with  $Y_n \in \mathcal{Q}_n$  for any  $n \in \mathbb{N}$   $\square$ -converges to Y. By assumption, there exists  $X_n \in \mathcal{P}_n$  with  $Y_n \prec_{\varepsilon_n} X_n$  for each  $n \in \mathbb{N}$ . By Lemma 24, for each  $n \in \mathbb{N}$ , there exists an mm-space  $Z_n$  with  $Z_n \prec X_n$  and  $\square(Y_n, Z_n) \leq 4\varepsilon_n$ . Note that  $Z_n \in \mathcal{P}_n$  for each  $n \in \mathbb{N}$  and  $\{Z_n\}_{n=1}^{\infty}$   $\square$ -converges to Y. Thus the weak convergence of  $\{\mathcal{P}_n\}_{n=1}^{\infty}$  implies  $Y \in \mathcal{P}$ . This means that  $\mathcal{Q} \subset \mathcal{P}$ .

Corollary 25 (cf. [S, Proposition 2.11]). If pyramids  $\mathcal{P}$  and  $\mathcal{Q}$  satisfy  $\mathcal{P} \prec_{\varepsilon} \mathcal{Q}$  and  $\mathcal{Q} \prec_{\varepsilon} \mathcal{P}$  for any  $\varepsilon > 0$ , then  $\mathcal{P} = \mathcal{Q}$ .

*Proof.* We have 
$$\mathcal{P} \subset \mathcal{Q}$$
 and  $\mathcal{Q} \subset \mathcal{P}$  by Proposition 23 and hence  $\mathcal{P} = \mathcal{Q}$ .

Now we are in a position to prove Theorem 1.

Proof of Theorem 1. We suppose that  $\mathcal{Y} \subset \mathcal{X}$  is precompact in  $(\mathcal{X}, \square)$  and fix a decreasing sequence  $\{\varepsilon_n\}_{n=1}^{\infty}$  of positive numbers  $\varepsilon_n > 0$  with  $\varepsilon_1 < 1$  and  $\sum_{n \in \mathbb{N}} \varepsilon_n < \infty$ .

For each  $n \in \mathbb{N}$ , we take a finite set  $\mathcal{A}_{Y,n}$  of Borel sets of  $Y \in \overline{\mathcal{Y}}$  and a finite subset  $\mathcal{Y}_n \subset \overline{\mathcal{Y}}$  with

- (1) diam  $A < \varepsilon_n$ ,  $\mu_Y(A) > 0$ , and  $\mu_Y(\partial A) = 0$  for any  $A \in \mathcal{A}_{Y,n}$ ,
- (2)  $\mathcal{O}_{Y,n} := \mathcal{O}(Y, \mathcal{A}_{Y,n}, \varepsilon_n)$  is as in Corollary 14 for  $Y \in \mathcal{Y}_n$  and  $\bigcup_{Y \in \mathcal{Y}_n} \mathcal{O}_{Y,n} = \mathcal{Y}$ ,
- (3)  $\mathcal{A}_{Z,n}$  is as in Corollary 14 if  $Y \in \mathcal{Y}_n$  and  $Z \in \mathcal{O}_{Y,n}$ ,
- (4)  $B \subset A$  or  $A \cap B = \emptyset$  if  $Y \in \mathcal{Y}_{n+1}$ ,  $A \in \mathcal{A}_{Y,n}$ , and  $B \in \mathcal{A}_{Y,n+1}$ ,
- (5)  $\mu_Y(Y \setminus \bigcup \mathcal{A}_{Y,n+1}) < (\underline{\varepsilon_{n+1}/(1+\varepsilon_{n+1})}) \min\{\mu_Y(A) : A \in \mathcal{A}_{Y,n}\} \text{ for any } Y \in \mathcal{Y}_{n+1},$
- (6)  $\mathcal{Y}_n \subset \mathcal{Y}_{n+1}$ , and  $\mathcal{Y} \subset \bigcup_{n=1}^{\infty} \mathcal{Y}_n$ ,
- cf. [OY, Lemma 42].

We note that  $U_{Y,n} := \bigcup \mathcal{A}_{Y,n} \subset Y$  satisfies  $\mu_Y(U_{Y,n}) > (1+\varepsilon_n)^{-1} > 1-\varepsilon_n$  for any  $Y \in \mathcal{Y}_n$ .

Claim 26. For any  $n \in \mathbb{N}$ , there exist a finite mm-space  $X_n$  with  $\square(X_n, X_{n+1}) \leq 48\varepsilon_n$  and  $(1, 3\varepsilon_n)$ -Lipschitz maps  $f_{Y,n}: X_n \to Y$  in the sense of Definition 9 satisfying

(27) 
$$f_{Y,n}(X_n) \subset U_{Y,n} \quad and \quad (f_{Y,n})_* \mu_{X_n}(A) = \frac{\mu_Y(A)}{\mu_Y(U_{Y,n})}$$

for any  $Y \in \mathcal{Y}_{n+1}$  and  $A \in \mathcal{A}_{Y,n}$ .

*Proof.* We start by using Lemma 15 to obtain a finite mm-space  $X_1$  and 1-Lipschitz maps  $f_{Y,1}: X_1 \to Y$  satisfying (27) with n=1 for any  $Y \in \mathcal{Y}_2$ . Then we suppose that we have a finite mm-space  $X_k$  and  $(1, 3\varepsilon_k)$ -Lipschitz maps  $f_{Y,k}: X_k \to Y$  satisfying (27) with  $n=k \in \mathbb{N}$  for any  $Y \in \mathcal{Y}_{k+1}$  and  $A \in \mathcal{A}_{Y,k}$ .

We use Lemma 17 to obtain a finite mm-space  $X'_k$  with  $\square(X_k, X'_k) \leq 27\varepsilon_k$  and 1-Lipschitz maps  $g_{Y,k}: X'_k: \to Y$  with

$$g_{Y,k}(X'_k) \subset U_{Y,k+1}$$
 and  $\mu_Y(U_{Y,k}) \frac{(g_{Y,k})_* \mu_{X'_k}(B)}{\mu_Y(B)} < 1 + \varepsilon_{k+1}$ 

for any  $Y \in \mathcal{Y}_{k+1}$  and  $B \in \mathcal{A}_{Y,k+1}$ .

Then we use Corollary 14 to obtain  $(1, 3\varepsilon_{k+1})$ -Lipschitz maps  $g_{Z,k}: X'_k \to Z$  with

$$g_{Z,k}(X'_k) \subset U_{Z,k+1}$$
 and  $\frac{(g_{Z,k})_* \mu_{X'_k}(B)}{\mu_Z(B)} < (1 + \varepsilon_k)^3 < 1 + 7\varepsilon_k$ 

for any  $Z \in \overline{\mathcal{Y}} \setminus \mathcal{Y}_{k+1}$  and  $B \in \mathcal{A}_{Z,k+1}$ .

Finally, we use Lemma 20 to obtain a finite mm-space  $X_{k+1}$  with  $\square(X'_k, X_{k+1}) \leq 21\varepsilon_k$  and  $(1, 3\varepsilon_{k+1})$ -Lipschitz maps  $f_{Y,k+1}: X_{k+1} \to Y$  satisfying (27) with n = k+1 for any  $Y \in \mathcal{Y}_{k+2}$  and  $A \in \mathcal{A}_{Y,k+1}$ .

Then

$$\square(X_k, X_{k+1}) \le \square(X_k, X_k') + \square(X_k', X_{k+1}) \le 48\varepsilon_k$$

and Claim 26 is verified.

We obtained a sequence  $\{X_n\}_{n=1}^{\infty}$  of mm-spaces and maps  $f_{Y,n}: X_n \to Y$  as in Claim 26. Lemma 10 yields  $\mathcal{Y}_{n+1} \prec_{3\varepsilon_n,0} X_n$  for any  $n \in \mathbb{N}$ . Since  $\sum_{n \in \mathbb{N}} \square(X_n,X_{n+1}) < \infty$ , the sequence  $\{X_n\}_{n=1}^{\infty}$  is Cauchy and converges to some mm-space X in  $(\mathcal{X},\square)$ . Then  $\mathcal{Y} \prec X$  by Lemma 21. Now our proof of Theorem 1 is complete.

Corollary 28. For any subset  $\mathcal{Y} \subset \mathcal{X}$ , the following are equivalent.

- (1) There exists an mm-space X with  $\mathcal{Y} \prec X$ .
- (2) For any  $\varepsilon > 0$ , there exists an mm-space X with  $Y \prec_{\varepsilon} X$  for any  $Y \in \mathcal{Y}$ .
- (3)  $\mathcal{Y}$  is  $\square$ -precompact.

*Proof.* The implication  $(1) \Rightarrow (2)$  is trivial and we proved the implication  $(3) \Rightarrow (1)$  in Theorem 1. We shall prove the implication  $(2) \Rightarrow (3)$ .

For  $\varepsilon > 0$ , we let X be as in (2) and take a finite set K of Borel sets of X with

$$\max_{K \in \mathcal{K}} \operatorname{diam} K \leq \varepsilon \quad \text{and} \quad \mu_X(\bigcup \mathcal{K}) \geq 1 - \varepsilon.$$

By assumption, any  $Y \in \mathcal{Y}$  admits a Borel map  $f_Y : X \to Y$  and a Borel set  $\tilde{X}_Y \subset X$  with

- (1)  $\mu_X(\tilde{X}_Y) \ge 1 \varepsilon$ ,
- (2)  $d_Y(f_Y(x), f_Y(x')) \le d_X(x, x') + \varepsilon$  for any  $x, x' \in \tilde{X}_Y$ , and
- (3)  $d_P((f_Y)_*\mu_X, \mu_Y) \leq \varepsilon$ .

We note that the set  $\mathcal{K}_Y := \{U_{\varepsilon}(f_Y(K \cap \tilde{X}_Y)) : K \in \mathcal{K}\}$  satisfies

$$\#\mathcal{K}_Y \le \#\mathcal{K}$$
, diam  $K < 4\varepsilon$ , diam  $\mathcal{K}_Y < \operatorname{diam} \mathcal{K} + 3\varepsilon < \infty$ ,

and

$$\mu_Y(\bigcup \mathcal{K}_Y) = \mu_Y(U_{\varepsilon}(f_Y(U_Y))) \ge (f_Y)_*\mu_X(\overline{f_Y(U_Y)}) - \varepsilon \ge \mu_X(U_Y) - \varepsilon \ge 1 - 3\varepsilon$$

for any  $Y \in \mathcal{Y}$  and  $K \in \mathcal{K}_Y$ , where  $U_Y := \bigcup \mathcal{K} \cap \tilde{X}_Y$ . Therefore Lemma 7 implies that  $\mathcal{Y}$  is  $\square$ -precompact and this finishes the proof.

### 4. Proof of Proposition 4

In this section, we make some preparations and prove Proposition 4. The facts which we need here also are found in [S] and the references therein.

**Definition 29** (e.g. [S, Definition 3.10]). For metric spaces X and Y and  $\varepsilon > 0$ , we call a map  $f: X \to Y$  an  $\varepsilon$ -isometry if it satisfies

- (1)  $|d_Y(f(x), f(x')) d_X(x, x')| \le \varepsilon$  for any  $x, x' \in X$  and
- (2)  $d_Y(y, f(X)) \le \varepsilon$  for any  $y \in Y$ .

We know that the Gromov–Hausdorff distance  $d_{GH}$  is complete on the set of all (isometry classes of) compact metric spaces, e.g. [S, Lemma 3.9]. We need the following rather than its precise definition.

**Lemma 30** (e.g. [S, Lemma 3.11]). Let X and Y be compact metric spaces and  $\varepsilon > 0$ .

- (1) If  $d_{GH}(X,Y) < \varepsilon$ , then there exists a  $2\varepsilon$ -isometry  $f: X \to Y$ .
- (2) If there exists an  $\varepsilon$ -isometry  $f: X \to Y$ , then  $d_{GH}(X,Y) < 2\varepsilon$ .

**Definition 31.** Let X be a compact metric space and  $\varepsilon > 0$ .

For a compact metric space Y, we write  $Y \prec_{\varepsilon} X$  if there exists a map  $f: X \to Y$  with

- (1)  $d_Y(f(x), f(x')) \le d_X(x, x') + \varepsilon$  for any  $x, x' \in X$  and
- (2)  $d_Y(y, f(X)) \le \varepsilon$  for any  $y \in Y$ .

For a family  $\mathcal{Y}$  of compact metric spaces, we write  $\mathcal{Y} \prec_{\varepsilon} X$  if  $Y \prec_{\varepsilon} X$  for any  $Y \in \mathcal{Y}$ .

The following is an analog of Lemma 17.

**Lemma 32.** Let  $\mathcal{Y}$  be a GH-precompact family of compact metric spaces and  $\varepsilon, \varepsilon' > 0$ . If a finite metric space X satisfies  $\mathcal{Y} \prec_{\varepsilon} X$ , then there exists a finite metric space X' with  $d_{GH}(X, X') < 6\varepsilon$  and  $\mathcal{Y} \prec_{\varepsilon'} X'$ .

*Proof.* Since there is nothing to prove if  $\varepsilon \leq \varepsilon'$ , we may assume that  $\varepsilon' < \varepsilon$ . We suppose that  $\mathcal{Y} \prec_{\varepsilon} X$  and fix a map  $f_Y : X \to Y$  as in Definition 31 and a finite subset  $N_Y \subset Y$  with  $U_{\varepsilon'}(N_Y) = Y$  for each  $Y \in \mathcal{Y}$ . Since  $\mathcal{Y}$  is GH-precompact, there exists a finite subset  $\mathcal{Y}' \subset \mathcal{Y}$  with  $d_{GH}(Y, \mathcal{Y}') < \varepsilon'$  for any  $Y \in \mathcal{Y}$ .

For each  $x \in X$  and  $Y \in \mathcal{Y}'$ , we put

$$N_Y(x) := \{ y \in N_Y : d(f_Y(x), y) \le \varepsilon \} \ne \emptyset.$$

We define

$$X'_x := \prod_{Y \in \mathcal{Y}'} N_Y(x) \text{ for } x \in X, \qquad X' := \bigsqcup_{x \in X} X'_x,$$

and

$$d_{X'}(\varphi, \varphi') := \max \left\{ \max_{Y \in \mathcal{Y}'} d_Y(\varphi(Y), \varphi'(Y)), d_X(x, x') \right\}$$

for  $\varphi \in X'_x$  and  $\varphi' \in X'_{x'}$  with  $x, x' \in X$ . Then  $(X', d_{X'})$  is a finite metric space.

The natural surjection  $\pi: X' \to X$  defined by  $\pi(\varphi) = x$  if  $x \in X$  and  $\varphi \in X'_x$  satisfy

$$d_X(x,x') \le d_Y(\varphi(Y),\varphi'(Y)) \le d_Y(f_Y(x),f_Y(x')) + 2\varepsilon \le d_X(x,x') + 3\varepsilon$$

and Inequality (19) for any  $\varphi \in X'_x$  and  $\varphi' \in X'_{x'}$  with  $x, x' \in X$  and  $Y \in \mathcal{Y}'$ . This means that  $\pi$  is a  $3\varepsilon$ -isometry and Lemma 30 yields  $d_{GH}(X, X') < 6\varepsilon$ .

We fix  $Y \in \mathcal{Y}'$  and consider the map

$$g: X' \to Y, \qquad g(\varphi) = \varphi(Y).$$

Then we have

$$d_Y(g(\varphi), g(\varphi')) = d_Y(\varphi(Y), \varphi'(Y)) \le d_{X'}(\varphi, \varphi')$$

for any  $\varphi, \varphi' \in X'$ . If  $y \in Y$ , there exist  $y' \in N_Y$  with  $d_Y(y, y') < \varepsilon'$  and  $x \in X$  with  $d_Y(y', f_Y(x)) \le \varepsilon$ . This means that  $y' \in N_Y(x)$  and there exists  $\varphi \in X'_x \subset X'$  with  $g(\varphi) = y'$  and hence

$$d_Y(y, g(X')) \le d_Y(y, y') < \varepsilon'.$$

These imply that  $\mathcal{Y}' \prec_{\varepsilon'} X'$ .

Then  $\mathcal{Y} \prec_{5\varepsilon'} X'$  by Lemma 30. This completes the proof of Lemma 32.

The following is an analog of Lemma 21, cf. [S, Lemma 5.33].

**Lemma 33.** Let  $\{\varepsilon_n\}_{n=1}^{\infty}$  be a sequence of positive numbers with  $\varepsilon_n \to 0$  as  $n \to \infty$ . If sequences  $\{X_n\}_{n=1}^{\infty}$  and  $\{Y_n\}_{n=1}^{\infty}$  of compact metric spaces GH-converge to compact metric spaces X and Y respectively and  $Y_n \prec_{\varepsilon_n} X_n$  for any n, then  $Y \prec X$ .

Proof. Let  $f_n: X_n \to Y_n$  be as in Definition 31 with  $\varepsilon = \varepsilon_n$ . Lemma 30 states that there exist  $\delta_n$ -isometries  $\Phi_n: X \to X_n$  and  $\Psi_n: Y_n \to Y$  with  $\delta_n \to 0$  as  $n \to \infty$ . We put  $g_n := \Psi_n \circ f_n \circ \Phi_n: X \to Y$  and take countable dense sets  $D \subset X$  and  $E \subset Y$  and  $x_{y,n} \in X$  with

$$d_Y(g_n(x_{y,n}), y) \leq 2\varepsilon_n + 4\delta_n$$
 for each  $y \in E$  and  $n$ .

By a diagonal argument, we take a subsequence  $\{g_{n(k)}\}_{k=1}^{\infty}$  of  $\{g_n\}_{n=1}^{\infty}$  for which  $\{g_{n(k)}(x)\}_{k=1}^n$  converges to some  $y_x \in Y$  for any  $x \in D$  and  $\{x_{y,n(k)}\}_{k=1}^n$  converges to some  $x_y \in X$  for any  $y \in E$ . Then there exists a unique 1-Lipschitz map  $f: X \to Y$  with  $f(x) = y_x$  for any  $x \in D$ .

If  $y \in Y$ ,  $\varepsilon > 0$ , and k is large enough, there exists  $x \in D$  with  $d_X(x_y, x) < \varepsilon$  and

$$d_Y(f(x_y), y) \le d_Y(f(x_y), f(x)) + d_Y(f(x), g_{n(k)}(x)) + d_Y(g_{n(k)}(x), g_{n(k)}(x_{y,n(k)})) + d_Y(g_{n(k)}(x_{y,n(k)}), y) < 2d_X(x_y, x) + d_X(x_y, x_{y,n(k)}) + \varepsilon < 4\varepsilon.$$

This implies that  $f(x_y) = y$  and f is surjective. This finishes the proof.

Now we are ready to prove Proposition 4.

Proof of Proposition 4. We suppose that  $\mathcal{Y}$  is a GH-precompact family of compact metric spaces and fix a sequence  $\{\varepsilon_n\}_{n=1}^{\infty}$  of positive numbers  $\varepsilon_n > 0$  with  $\sum_{n \in \mathbb{N}} \varepsilon_n < \infty$ . Any compact metric space  $X_0$  satisfies  $\mathcal{Y} \prec_{\varepsilon_0} X_0$  with  $\varepsilon_0 := \sup_{Y \in \mathcal{Y}} \operatorname{diam} Y < \infty$ . We use Lemma 32 to find compact metric spaces  $X_n$  with  $\mathcal{Y} \prec_{\varepsilon_n} X_n$  and  $d_{GH}(X_n, X_{n+1}) < 6\varepsilon_n$  for any  $n \in \mathbb{N}$ . Since  $\{X_n\}_{n=1}^{\infty}$  is Cauchy, it GH-converges to some compact metric space X. Then  $\mathcal{Y} \prec X$  by Lemma 33 and this finishes the proof.

The following is an analog of Corollary 28.

Corollary 34. For any family  $\mathcal{Y}$  of compact metric spaces, the following are equivalent.

- (1) There exists a compact metric space X with  $\mathcal{Y} \prec X$ .
- (2) For any  $\varepsilon > 0$ , there exists a compact metric space X with  $\mathcal{Y} \prec_{\varepsilon} X$ .
- (3)  $\mathcal{Y}$  is GH-precompact.

*Proof.* The implications  $(1) \Rightarrow (2)$  is trivial and we proved the implication  $(3) \Rightarrow (1)$  in Proposition 4. We shall prove the implication  $(2) \Rightarrow (3)$ .

For  $\varepsilon > 0$ , we let X be as in (2) and take a finite subset  $N \subset X$  with

$$d_X(x, x') > \varepsilon$$
 and  $d_X(x'', N) \le \varepsilon$ 

for any  $x, x' \in N$  with  $x \neq x'$  and any  $x'' \in X$ . By assumption, any  $Y \in \mathcal{Y}$  admits a map  $f_Y : X \to Y$  as in Definition 31 and we put  $N_Y := f_Y(N) \subset Y$ . Then we have

diam 
$$Y \le \text{diam } X + 3\varepsilon$$
,  $\#N_Y \le \#N < \infty$ , and  $d_Y(y, N_Y) \le 2\varepsilon$ 

for any  $Y \in \mathcal{Y}$  and  $y \in Y$ . Therefore  $\mathcal{Y}$  is GH-precompact by e.g. [S, Lemma 3.12] and this finishes the proof.

Remark 35. We wonder if there is any relation between Theorem 1 and Proposition 4.

A compact metric space  $\mathcal{L}_1(X)$  is associated with an mm-space X, e.g. [S, Definition 4.43]. If  $\mathcal{Y} \subset \mathcal{X}$  is a  $\square$ -precompact set, then  $\{\mathcal{L}_1(Y) : Y \in \mathcal{Y}\}$  is GH-precompact, cf. [S, Proposition 5.5, Lemma 7.7].

A pyramid  $\mathcal{P}$  is said to be *concentrated* if  $\{\mathcal{L}_1(X): X \in \mathcal{P}\}$  is GH-precompact, e.g. [S, Definition 7.9]. If  $X_n := S^1 \times \cdots \times S^n$  is the product of the unit spheres  $S^n$  in  $\mathbb{R}^{n+1}$ , then

 $\overline{\bigcup_{n=1}^{\infty} \mathcal{P}_{X_n}}$  is a concentrated pyramid which is not  $\square$ -precompact, e.g. [S, Corollary 7.10], cf. [OY, Remark 13].
