# HOMOGENEOUS QUANTUM SYMMETRIES OF FINITE SPACES OVER THE CIRCLE GROUP

#### Abstract

Suppose $D$ is a finite dimensional C*-algebra carrying a continous action $\bar{\Pi}$ of the circle group $\mathbb{T}$. We study the quantum symmetry group of $D$, taking $\bar{\Pi}$ into account. We show that they are braided compact quantum groups $\mathbb{G}$ over $\mathbb{T}$. Here, the $R$-matrix, $\mathbb{Z} \times \mathbb{Z} \ni(m, n) \rightarrow \zeta^{-m \cdot n} \in \mathbb{T}$, for a fixed $\zeta \in \mathbb{T}$, governs the braided structure. In particular, if $\bar{\Pi}$ is trivial, $\zeta=1$ or $D$ is commutative, then $\mathbb{G}$ coincides with Wang's quantum group of automorphisms of $D$. Moreover, we show that the bosonisation of $\mathbb{G}$ corresponds to the quantum symmetry group of the crossed product $\mathrm{C}^{*}$-algebra $D \rtimes \mathbb{Z}$, where the $\mathbb{Z}$-action is generated by $\bar{\Pi}_{\zeta^{-1}}$.


## 1. Introduction

In the realm of compact quantum groups of Woronowicz [23, 24, the inception of the theory of quantum symmetry groups of classical and quantum space goes back to the seminal paper of Wang [22]. In that article, Wang studied quantum symmetry groups of finite sets and finite dimensional noncommutative $\mathrm{C}^{*}$-algebras or finite quantum spaces equipped with a reference state. They are extended to several discrete structures by Banica, Bichon and several others ( [1, 2, 7, 11, 21] and the references therein). On the other hand, Goswami [8] introduced the continuous counterpart, namely, the quantum isometry group for spectral triples. He and his collaborators studied it extensively [3, 5, 2, 10]. Goswami's work motivated Banica and Skalski to develop a general framework of quantum symmetry groups based on orthogonal filtrations of unital $\mathrm{C}^{*}$-algebras (4).

Semidirect product construction of groups is a fundamental way of extending some homogeneous symmetries to inhomogeneous symmetries of a physical system. This perspective suggests that, within the framework of the noncommutative geometry, semidirect product construction for quantum groups might be a natural way to obtain inhomogeneous symmetries of quantum spaces or $\mathrm{C}^{*}$-algebras from their homogeneous symmetries. Several interesting examples of unital $\mathrm{C}^{*}$-algebras $D$ naturally carry a continuous action $\gamma$ of the circle group $\mathbb{T}$, that preserves a distinguished faithful state, say $\phi$, on $D$. Fix $\zeta \in \mathbb{T}$. We view the circle group $\mathbb{T}$ a quasitriangular quantum group with respect to the $R$-matrix R , which is a bicharacter on $\mathbb{Z}$, defined by

\mathrm{R}(l, m)=\zeta^{-l m}, \quad \text { for all } l, m \in \mathbb{Z} \tag{1.1}
\end{equation*}

The quantum symmetries of compact type of $D$ encoding and respecting the information of the action $\gamma$ are the $\mathbb{T}$-homogeneous compact quantum symmetries of the system $(D, \gamma, \phi)$. If such an object exists, it becomes a braided compact quantum

[^0]group $\mathbb{G}$ over $\mathbb{T}$ (see [17] Definition 6.1]). The $\mathbb{T}$-action $\gamma$ and the above $R$-matrix govern the braided structure of $\mathbb{G}$. Moreover, we expect to capture the inhomogeneous compact quantum symmetries of $(D, \gamma, \phi)$ in terms of the bosonisation of $\mathbb{G}$ (see [17, Theorem 6.4]).

This article aims to support the above model for finite dimensional C*-algebras $D$ carrying an action of $\mathbb{T}$. If $D$ is commutative with $\operatorname{dim}(D)=n$ for some natural number $n$, then it is generated by $n$ many commuting projections $p_{1}, \cdots p_{n}$ satisfying $\sum_{i=1}^{n} p_{i}=1$. If $\gamma$ is a continuous action of $\mathbb{T}$ on $D$ then $\gamma_{z}\left(p_{i}\right)$ is self adjoint and $\gamma_{z}\left(p_{i}\right)=\gamma_{z}\left(p_{i}\right)^{2}$ for all $z \in \mathbb{T}$ and $1 \leq i \leq n$. This forces $\gamma$ to become trivial. Therefore, the quantum symmetry group of $D$ corresponds to Wang's quantum permutation group [22, Theorem 3.1]. So, we consider $D$ to be noncommutative, that is, $D$ is isomorphic to a finite direct sum of matrix algebras.

In particular, let $D=\mathrm{M}_{n}(\mathbb{C})$ for a fixed number $n$. The matrix algebra $\mathrm{M}_{n}(\mathbb{C})$ is the universal C ${ }^{*}$-algebra generated by $\left\{E_{i j}\right\}_{1 \leq i, j \leq n}$ subject to the following conditions:

Let $d_{1} \leq d_{2} \leq \cdots \leq d_{n}$ be integers. Then it is easy to verify that $\Pi$, defined by

is a continuous action of $\mathbb{T}$ on $\mathrm{M}_{n}(\mathbb{C})$. Let $\phi$ be the canonical normalised trace on $\mathrm{M}_{n}(\mathbb{C})$, that is, $\phi\left(E_{i j}\right)=\frac{1}{n} \cdot \delta_{i, j}$ for all $1 \leq i, j \leq n$. The action $\Pi$ of $\mathbb{T}$ on $\mathrm{M}_{n}(\mathbb{C})$ preserves $\phi$, that is, $\phi \circ \Pi_{z}(\cdot)=\phi(\cdot) 1$.

Consider the braided tensor product $\boxtimes_{\zeta}$ of unital $\mathrm{C}^{*}$-algebras with $\mathbb{T}$-action discussed in Section 2.2. The braided compact quantum symmetries of the triple $\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ are $\phi$ preserving actions $\eta: \mathrm{M}_{n}(\mathbb{C}) \rightarrow \mathrm{M}_{n}(\mathbb{C}) \boxtimes_{\zeta} B$ of braided compact quantum groups $\mathbb{G}=\left(B, \beta, \Delta_{B}\right)$ over $\mathbb{T}$ on $\left(\mathrm{M}_{n}(\mathbb{C}), \Pi\right)$ in the sense of the Definitions 3.1 and 3.16, respectively. In fact, $\eta$ is uniquely determined by its matrix coefficients $\left\{b_{k l}^{i j}\right\}_{1 \leq i, j, k, l \leq n} \subseteq B$ :

\eta\left(E_{i j}\right)=\sum_{k, l=1}^{n} E_{k l} \boxtimes_{\zeta} b_{i j}^{k l}, \quad \text { for all } 1 \leq i, j \leq n \tag{1.4}
\end{equation*}

We construct a braided compact quantum group, denoted by $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$, in Theorem 3.4. Subsequently, we observe in Proposition 3.18 that it acts faithfully on $\left(\mathrm{M}_{n}(\mathbb{C}), \Pi\right)$ and preserves $\phi$.

According to [17, Section 6], every braided compact quantum group over $\mathbb{T}$ uniquely corresponds to an ordinary compact quantum group. In the purely algebraic setting, this was discovered by Radford [18] and extensively studied by Majid [13] under the name bosonisation. In Section 4] we construct the bosonisation of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$, denoted by $\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right)$.

In Proposition 5.1, we observe that $\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right)$ acts on $\mathrm{M}_{n}(\mathbb{C}) \boxtimes_{\zeta}$ $\mathrm{C}(\mathbb{T})$, extending the (braided) action of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ on $\left(\mathrm{M}_{n}(\mathbb{C}), \Pi\right)$ and the action of $\mathbb{T}$ on $C(\mathbb{T})$ by translation. Then we use it to prove the universal property of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ in Theorem 5.4.

The $R$-matrix (1.1) induces an action of $\mathbb{Z}$ on $\mathrm{M}_{n}(\mathbb{C})$ generated by $\Pi_{\zeta^{-1}}$. Then the associated crossed product $\mathrm{M}_{n}(\mathbb{C}) \rtimes \mathbb{Z}$ becomes isomorphic to $\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} \mathrm{M}_{n}(\mathbb{C})$. Consider the orthogonal filtrations $\widetilde{\mathrm{M}_{n}(\mathbb{C})}$ and $\widetilde{\mathrm{C}(\mathbb{T})}$ of $\mathrm{M}_{n}(\mathbb{C})$ and $\mathrm{C}(\mathbb{T})$ given in Example 5.15 and Example 5.16, respectively. Then we apply [6, Proposition 4.9] to construct an orthogonal filtration of $\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} \mathrm{M}_{n}(\mathbb{C})$. Consequently, in Proposition 5.19, we prove that the corresponding quantum symmetry group of $\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} \mathrm{M}_{n}(\mathbb{C})$ is isomorphic to $\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right)$. This is the universal property of the bosonisation of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$. Furthermore, combining
it with [6, Theorem 5.1] we also observe $\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right) \cong \mathfrak{D}_{\mathrm{V}}$ in Corollary 5.20 where $\mathfrak{D}_{\mathrm{V}}$ is the Drinfeld's double of the quantum symmetry groups $\operatorname{QISO}(\widetilde{\mathrm{C}(\mathbb{T})})$ and $\operatorname{QISO}\left(\widetilde{\mathrm{M}_{n}(\mathbb{C})}\right)$ with respect to some bicharacter V suitably chosen.

Within the scope of this article, the bosonisation picture has significant advantages over the Drinfeld's double, both computationally and conceptually. Indeed, the concrete computation of the bosonisation of a braided compact quantum group over $\mathbb{T}$ is more straightforward than the computation of Drinfeld's double. Secondly, in Remark 5.21, we observe that $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ is the homogeneous quantum symmetry group of the $\mathrm{C}^{*}$-dynamical system $\left(\mathrm{M}_{n}(\mathbb{C}), \mathbb{Z}, \Pi_{\zeta^{-1}}\right)$ obtained from $\left(\mathrm{M}_{n}(\mathbb{C}), \Pi\right)$. At the same time, its bosonisation (semidirect product) corresponds to the inhomogeneous (extending $\mathbb{T}$-homogeneous) quantum symmetry group of the same system. Conceptually, this approach is more natural while computing the quantum symmetry of the given the $\mathrm{C}^{*}$-dynamical system $\left(\mathrm{M}_{n}(\mathbb{C}), \mathbb{Z}, \Pi_{\zeta^{-1}}\right)$.

Finally, in Section 6, we employ these analyses to study similar results for the direct sum of matrix algebras. As a byproduct, we observe in Remark 6.10 that a finite classical space, that is, $D \cong \mathbb{C}^{m}$ for any natural number $m$, has no braided quantum symmetries (over $\mathbb{T}$ ), as expected.

## 2. Preliminaries

All Hilbert spaces and $\mathrm{C}^{*}$-algebras (which are not explicitly multiplier algebras) are assumed to be separable. For any subsets $X, Y$ of a given unital $\mathrm{C}^{*}$-algebra $D$, the norm closure of $\{x y \mid x \in X, y \in Y\} \subseteq D$ is denoted by $X Y$. We use $\otimes$ for both the tensor product of Hilbert spaces and the minimal tensor product of $\mathrm{C}^{*}$-algebras, which is well understood from the context.
2.1. Compact quantum groups and their actions. A compact quantum group is a pair $\mathbb{G}=\left(A, \Delta_{A}\right)$ consisting of a unital $\mathrm{C}^{*}$-algebra $A$ and a unital *-homomorphism $\Delta_{A}: A \rightarrow A \otimes A$ such that
(1) $\Delta_{A}$ is coassociative: $\left(\operatorname{id}_{A} \otimes \Delta_{A}\right) \circ \Delta_{A}=\left(\Delta_{A} \otimes \operatorname{id}_{A}\right) \circ \Delta_{A}$;
(2) $\Delta_{A}$ satisfies the cancellation conditions: $\Delta_{A}(A)\left(1_{A} \otimes A\right)=A \otimes A=$ $\Delta_{A}(A)\left(A \otimes 1_{A}\right)$.
Let $D$ be a unital $\mathrm{C}^{*}$-algebra. An action of a compact quantum group $\mathbb{G}=\left(A, \Delta_{A}\right)$ on $D$ is a unital *-homomorphism $\gamma: D \rightarrow D \otimes A$ such that
(1) $\gamma$ satisfies the action equation, that is, $\left(\operatorname{id}_{D} \otimes \Delta_{A}\right) \circ \gamma=\left(\gamma \otimes \mathrm{id}_{A}\right) \circ \gamma$;
(2) $\gamma$ satisfies the Podleś condition: $\gamma(D)\left(1_{D} \otimes A\right)=D \otimes A$.

Suppose $\tau: D \rightarrow \mathbb{C}$ be a state. Then $\gamma$ is said to be $\tau$-preserving if $\left(\tau \otimes \mathrm{id}_{A}\right) \gamma(d)=$ $\tau(d) \cdot 1_{A}$ for all $d \in D$. In fact, $\gamma$ is injective whenever $\tau$ is faithful.

Example 2.1. Represent $\mathrm{C}(\mathbb{T})$ on $L^{2}(\mathbb{T})$ faithfully by pointwise multiplication. Let $z \in$ $\mathrm{C}(\mathbb{T})$ be the unitary operator of pointwise multiplication with the identity function on $\mathbb{T}$. Then $\Delta_{\mathrm{C}(\mathbb{T})}(z)=z \otimes z$ defines the comultiplication map on $\mathrm{C}(\mathbb{T})$. The pair $\left(\mathrm{C}(\mathbb{T}), \Delta_{\mathrm{C}(\mathbb{T})}\right)$ is $\mathbb{T}$ viewed as a compact quantum group. Suppose $D$ is a unital $\mathrm{C}^{*}$-algebra and $\gamma: \mathbb{T} \rightarrow \operatorname{Aut}(D)$ is a continuous action. An element $d \in D$ is a homogeneous element of degree $\operatorname{deg}(d) \in \mathbb{Z}$ if $\gamma_{z}(d)=z^{\operatorname{deg}(d)} \cdot d$ for all $z \in \mathbb{T}$. Equivalently, $\gamma(d)=d \otimes z^{\operatorname{deg}(d)}$ while $\gamma$ is viewed as an action of $\left(\mathrm{C}(\mathbb{T}), \Delta_{\mathrm{C}(\mathbb{T})}\right)$ on $D$.
2.2. Braided tensor product of $\mathbf{C}^{*}$-algebras. Let $\mathcal{L}_{1}$ and $\mathcal{L}_{2}$ be separable Hilbert spaces. Let $\pi_{i}: \mathbb{T} \rightarrow \mathcal{U}\left(\mathcal{L}_{i}\right)$ be continuous representations for $i=1,2$. Suppose, $\left\{\lambda_{m}^{i}\right\}_{m \in \mathbb{N}}$ is an orthonormal basis of $\mathcal{L}_{i}$ consisting of the eigenvectors for $\pi^{i}$, that is $\left(\pi_{i}\right)_{z}\left(\lambda_{m}^{i}\right)=z^{l_{m}^{i}} \lambda_{m}^{i}$ for some $l_{m}^{i} \in \mathbb{N}$, for $i=1,2$.

By [17] Equation (3.2) \& Proposition 3.2], the braiding unitary $\left.{ }^{\mathcal{L}_{1}}\right\rangle^{\mathcal{L}_{2}}: \mathcal{L}_{1} \otimes \mathcal{L}_{2} \rightarrow$ $\mathcal{L}_{2} \otimes \mathcal{L}_{1}$ and its inverse ${ }^{\mathcal{L}_{2}}{ }^{\mathcal{L}_{1}}: \mathcal{L}_{2} \otimes \mathcal{L}_{1} \rightarrow \mathcal{L}_{1} \otimes \mathcal{L}_{2}$ associated to the R-matrix (1.1) are defined on the basis elements by

Consider the category $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$ consisting of unital $\mathrm{C}^{*}$-algebras with a continuous action of $\mathbb{T}$ as objects and $\mathbb{T}$-equivariant unital *-homomorphisms as arrows.

Let $\left(D_{i}, \gamma_{i}\right)$ are objects of $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$ and $\psi_{i}: D_{i} \hookrightarrow \mathbb{B}\left(\mathcal{L}_{i}\right)$ be faithful $\mathbb{T}$-equivariant representations of $\left(D_{i}, \gamma_{i}\right)$, respectively, for $i=1,2$. For any homogeneous elements $d_{i} \in D_{i}$ we have

for all $z \in \mathbb{T}$ and $i=1,2$.
A unital ${ }^{*}$-homomorphism $f: D_{1} \rightarrow D_{2}$ is an arrow $D_{1} \rightarrow D_{2}$ in $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$ if it is $\mathbb{T}$-equivariant: $f \circ\left(\gamma_{1}\right)_{z}=\left(\gamma_{1}\right)_{z} \circ f$ for all $z \in \mathbb{T}$. The set of arrows $D_{1} \rightarrow D_{2}$ in $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$ is denoted by $\operatorname{Mor}^{\mathbb{T}}\left(D_{1}, D_{2}\right)$.

The $R$-matrix (1.1) defines the braided tensor product $D_{1} \boxtimes_{\zeta} D_{2}=j_{1}\left(D_{1}\right) j_{2}\left(D_{2}\right)$, where $j_{i}: D_{i} \rightarrow D_{1} \boxtimes_{\zeta} D_{2}$ are the canonical embeddings, for $i=1,2$. The concrete descriptions of these maps are given by

for all $d_{i} \in D_{i}$, where $i=1,2$. In particular, if $d_{i} \in D_{i}$ are the homogeneous elements, then the commutation relation between the elementary tensor factors $j_{1}\left(d_{1}\right):=$ $d_{1} \boxtimes_{\zeta} 1_{D_{2}}$ and $j_{2}\left(d_{2}\right):=1_{D_{1}} \boxtimes_{\zeta} d_{2}$ is given by

The braided tensor product $D_{1} \boxtimes_{\zeta} D_{2}$ carries the continuous diagonal action $\left(\gamma_{1} \bowtie\right.$ $\left.\gamma_{2}\right)_{z}\left(d_{1} \boxtimes_{\zeta} d_{2}\right):=\left(\gamma_{1}\right)_{z}\left(d_{1}\right) \boxtimes_{\zeta}\left(\gamma_{2}\right)_{z}\left(d_{2}\right)$ for all $z \in \mathbb{T}$. Thus $\left(D_{1} \boxtimes_{\zeta} D_{2}, \alpha \bowtie \beta\right)$ is an object of $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$. Furthermore, $\left(\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T}), \boxtimes_{\zeta}\right)$ is a monoidal category with $\mathbb{C}$ along with the trivial action of $\mathbb{T}$ as monoidal unit. We refer to [16, 17] for more details of this construction. In particular, $\boxtimes_{1}$ coincides with the minimal tensor product $\otimes$ of $\mathrm{C}^{*}$-algebras. Also, $A \boxtimes_{\zeta} B \cong A \otimes B$ if either $\alpha$ or $\beta$ is trivial.

Suppose $(B, \beta)$ and $(D, \gamma)$ are objects of the category $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$. By virtue of [17, Proposition 3.6], there exists an injective unital ${ }^{*}$-homomorphism $\Psi^{D, B}: \mathrm{C}(\mathbb{T}) \boxtimes_{\zeta}$ $D \boxtimes_{\zeta} B \rightarrow\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D\right) \otimes\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} B\right)$. For $a \in \mathrm{C}(\mathbb{T}), d \in D, b \in B$ it is defined by

\begin{align*}
& \Psi^{D, B}\left(j_{1}(a)\right)=\left(j_{1} \otimes j_{1}\right) \Delta_{\mathrm{C}(\mathbb{T})}(a), \quad \Psi^{D, B}\left(j_{2}(b)\right)=\left(j_{2} \otimes j_{1}\right) \gamma(d),  \tag{2.6}\\
& \Psi^{D, B}\left(j_{3}(b)\right)=1_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D} \otimes j_{2}(b) .
\end{align*}
$$

Here we view the action $\beta$ as a unital ${ }^{*}$-homomorphism $\beta: B \rightarrow B \otimes \mathrm{C}(\mathbb{T})$. These maps will play crucial roles in Sections 4 and 5

## 3. Action of braided quantum groups on matrix algebras

Fix $\zeta \in \mathbb{T}$ and recall the monoidal category $\left(\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T}), \boxtimes_{\zeta}\right)$ from the previous section.
Definition 3.1 (compare with [17, Definition 6.1]). A triple $\mathbb{G}=\left(A, \alpha, \Delta_{A}\right)$ is a braided compact quantum group in $\left(\mathfrak{C}^{*} \mathfrak{a l g}, \boxtimes_{\zeta}\right)$ if $(A, \alpha)$ is an object of $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$ and $\Delta_{A} \in \operatorname{Mor}^{\mathbb{T}}\left(A, A \boxtimes_{\zeta} A\right)$ such that
(1) $\Delta_{A}$ is coassociative

$$
\begin{equation*}
\left(\Delta_{A} \boxtimes_{\zeta} \operatorname{id}_{A}\right) \circ \Delta_{A}=\left(\operatorname{id}_{A} \boxtimes_{\zeta} \Delta_{A}\right) \circ \Delta_{A} \tag{3.2}
\end{equation*}
$$

(2) $\Delta_{A}$ satisfies the cancellation conditions:

$$
\begin{equation*}
\Delta_{A}(A)\left(1_{A} \boxtimes_{\zeta} A\right)=A \boxtimes_{\zeta} A=\Delta_{A}(A)\left(A \boxtimes_{\zeta} 1_{A}\right) \tag{3.3}
\end{equation*}
$$

Then we say $\mathbb{G}=\left(A, \alpha, \Delta_{A}\right)$ is a braided compact quantum group over $\mathbb{T}$. We refer to [12, 14 for genuine examples of braided compact quantum groups over $\mathbb{T}$. Indeed, $\mathbb{G}$ is an ordinary compact quantum group if either $\zeta=1$ or the action $\alpha$ is trivial.

Theorem 3.4. For a given natural number $n$, let $d_{1} \leq d_{2} \leq \cdots \leq d_{n}$ be integers. Let $A$ be the universal $\mathrm{C}^{*}$-algebra generated by $\left(u_{k l}^{i j}\right)_{1 \leq i, j, k, l \leq n}$ subject to the following relations:

$$
\begin{align*}
& \sum_{t=1}^{n}\left(\zeta^{d_{t}\left(d_{k}-d_{i}+d_{t}-d_{s}\right)} u_{k s}^{i t}\right) \cdot\left(\zeta^{d_{j}\left(d_{m}-d_{t}+d_{j}-d_{l}\right)} u_{m l}^{t j}\right)  \tag{3.5}\\
& =\delta_{s, m} \cdot\left(\zeta^{d_{j}\left(d_{k}-d_{i}+d_{j}-d_{l}\right.} u_{k l}^{i j}\right), \quad \text { for all } 1 \leq i, j, k, l, m, n \leq n ; \\
& \sum_{t=1}^{n}\left(\zeta^{d_{s}\left(d_{k}-d_{i}+d_{s}-d_{t}\right)} u_{k t}^{i s}\right) \cdot\left(\zeta^{d_{j}\left(d_{t}-d_{m}+d_{j}-d_{l}\right)} u_{t l}^{m j}\right)  \tag{3.6}\\
& =\delta_{s, m} \cdot\left(\zeta^{d_{j}\left(d_{k}-d_{i}+d_{j}-d_{l}\right)} u_{k l}^{i j}\right), \quad \text { for all } 1 \leq i, j, k, l, m, n \leq n ; \\
& u_{k l}^{i j *}=\zeta^{\left(d_{i}-d_{j}\right)\left(d_{l}-d_{j}+d_{i}-d_{k}\right)}\left(u_{l k}^{j i}\right), \quad \text { for all } 1 \leq i, j, k, l \leq n ;  \tag{3.7}\\
& \sum_{r=1}^{n} u_{r r}^{i j}=\delta_{i, j}, \quad \text { for all } 1 \leq i, j \leq n ;  \tag{3.8}\\
& \sum_{r=1}^{n} u_{k l}^{r r}=\delta_{k, l}, \quad \text { for all } 1 \leq i, j \leq n . \tag{3.9}
\end{align*}
$$

There exists a unique continuous action $\alpha$ of $\mathbb{T}$ on $A$ satisfying

$$
\begin{equation*}
\alpha_{z}\left(u_{k l}^{i j}\right)=z^{d_{k}-d_{i}+d_{j}-d_{l}} u_{k l}^{i j}, \quad \text { for all } z \in \mathbb{T} ; \tag{3.10}
\end{equation*}
$$

Thus, $(A, \alpha)$ is an object of $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$. There exists a unique $\Delta_{A} \in \operatorname{Mor}^{\mathbb{T}}\left(A, A \boxtimes_{\zeta} A\right)$ such that

$$
\begin{equation*}
\Delta_{A}\left(u_{k l}^{i j}\right)=\sum_{r, s=1}^{n} u_{r s}^{i j} \boxtimes_{\zeta} u_{k l}^{r s}, \quad 1 \leq i, j, k, l \leq n . \tag{3.11}
\end{equation*}
$$

Moreover, $\Delta_{A}$ satisfies (3.2)-(3.3). Then $\left(A, \alpha, \Delta_{A}\right)$ is a braided compact quantum group over $\mathbb{T}$ denoted by $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$.

Proof. Let $W=\mathbb{C}^{n}$ and $\rho$ is a unitary representation of $\mathbb{T}$ on $W$. Let $\left\{e_{1}, e_{2}, \cdots, e_{n}\right\}$ be the eigenbasis for $\rho$ such that $\rho_{z}\left(e_{i}\right)=z^{d_{i}} e_{i}$ for all $1 \leq i \leq n$.

We identify $\operatorname{End}(W)$ with $\mathrm{M}_{n}(\mathbb{C})$ with respect to this ordered basis. Then $\mathrm{M}_{n}(\mathbb{C})$ is generated by the rank one matrices $\left\{E_{i j}\right\}_{1 \leq i, j \leq n}$, defined by $E_{i j} e_{k}=\delta_{j, k} e_{i}$ for all $1 \leq k \leq n$. In fact, $\rho$ induces the action $\Pi$ in (1.3) of $\mathbb{T}$ on $\mathrm{M}_{n}(\mathbb{C})$.

Similarly, we identify $\operatorname{End}\left(\mathrm{M}_{n}(\mathbb{C})\right) \cong \mathrm{M}_{n}(\mathbb{C}) \otimes \mathrm{M}_{n}(\mathbb{C})^{*} \cong \mathrm{M}_{n}(\mathbb{C}) \otimes \mathrm{M}_{n}(\mathbb{C})$. Subsequently, $\Pi$ induces a continuous action $\widetilde{\Pi}$ of $\mathbb{T}$ on $\operatorname{End}\left(\mathrm{M}_{n}(\mathbb{C})\right)$. On the basis vectors $E_{i j} \otimes E_{k l}$ it acts in the following way:

$$
\begin{equation*}
\widetilde{\Pi}_{z}\left(E_{i j} \otimes E_{k l}\right):=z^{d_{i}-d_{j}-d_{k}+d_{l}} E_{i j} \otimes E_{k l} \quad \text { for all } z \in \mathbb{T} . \tag{3.12}
\end{equation*}
$$

Suppose $\mathcal{A}$ is the universal unital ${ }^{*}$-algebra generated by $u_{k l}^{i j}$ for $1 \leq i, j \leq n$ satisfying (3.10)-(3.9). Define $u \in \mathrm{M}_{n}(\mathbb{C}) \otimes \mathrm{M}_{n}(\mathbb{C}) \otimes \mathcal{A}$ by

$$
\begin{equation*}
u=\sum_{i, j, k, l=1}^{n} E_{i k} \otimes E_{j l} \otimes u_{k l}^{i j} . \tag{3.13}
\end{equation*}
$$

Since $\zeta \in \mathbb{T}$, we can rewrite (3.5) using the formula (3.10) in the following compact form:

$$
\begin{equation*}
\sum_{t=1}^{n} \alpha_{\zeta^{d_{t}}}\left(u_{k s}^{i t}\right) \cdot \alpha_{\zeta^{d_{j}}}\left(u_{m l}^{t j}\right)=\delta_{s, m} \cdot \alpha_{\zeta^{d_{j}}}\left(u_{k l}^{i j}\right), \quad \text { for all } 1 \leq i, j, k, l, m, n \leq n \tag{3.14}
\end{equation*}
$$

Then we use conditions (3.7), (3.14), (3.8) and the fact $\sum_{k=1}^{n} E_{k k}=1_{\mathrm{M}_{n}(\mathbb{C})}$ to show $u^{*} u=1_{\mathrm{M}_{n}(\mathbb{C}) \otimes \mathrm{M}_{n}(\mathbb{C})} \otimes 1_{\mathcal{A}}$ :

\begin{aligned}
& \left(\sum_{i, j k, l=1}^{n} E_{i k} \otimes E_{j l} \otimes u_{k l}^{i j}\right)^{*}\left(\sum_{p, q, r, s=1}^{n} E_{p r} \otimes E_{q s} \otimes u_{r s}^{p q}\right) \\
& =\left(\sum_{i, j k, l=1}^{n} E_{k i} \otimes E_{l j} \otimes u_{k l}^{i j *}\right)\left(\sum_{p, q, r, s=1}^{n} E_{p r} \otimes E_{q s} \otimes u_{r s}^{p q}\right) \\
& =\sum_{i, j, k, l, p, q, r, s=1}^{n} \delta_{i, p} \delta_{j, q} E_{k r} \otimes E_{l s} \otimes \alpha_{\zeta^{d_{i}-d_{j}}}\left(u_{l k}^{j i}\right) u_{r s}^{p q} \\
& =\sum_{i, j, k, l, r, s=1}^{n} E_{k r} \otimes E_{l s} \otimes \alpha_{\zeta^{d_{i}-d_{j}}}\left(u_{l k}^{j i}\right) u_{r s}^{i j} \\
& =\sum_{i, j, k, l, r, s=1}^{n} \zeta^{d_{j}\left(d_{k}-d_{l}+d_{s}-d_{r}\right)} E_{k r} \otimes E_{l s} \otimes \alpha_{\zeta^{d_{i}}}\left(u_{l k}^{j j}\right) \alpha_{\zeta^{d_{j}}}\left(u_{r s}^{i j}\right) \\
& =\sum_{j, k, l, r, s=1}^{n} \delta_{k, r} \cdot \zeta^{d_{j}\left(d_{k}-d_{l}+d_{s}-d_{r}\right)} E_{k r} \otimes E_{l s} \otimes \alpha_{\zeta^{d_{j}}}\left(u_{l s}^{j j}\right) \\
& =\sum_{j, k, l, r, s=1}^{n} \delta_{k, r} \cdot \zeta^{d_{j}\left(d_{k}-d_{r}\right)} E_{k r} \otimes E_{l s} \otimes u_{l s}^{j j} \\
& =\sum_{j, k, l, s=1}^{n} E_{k k} \otimes E_{l s} \otimes u_{l s}^{j j}=\sum_{j, l, s=1}^{n} 1_{\mathrm{M}_{n}(\mathbb{C})} \otimes E_{l s} \otimes u_{l s}^{j j} \\
& =1_{\mathrm{M}_{n}(\mathbb{C}) \otimes \mathrm{M}_{n}(\mathbb{C})} \otimes 1_{\mathcal{A}} .
\end{aligned}
$$

Similarly, we can verify that $u u^{*}=1_{\mathrm{M}_{n}(\mathbb{C}) \otimes \mathrm{M}_{n}(\mathbb{C})} \otimes 1_{\mathcal{A}}$. So, any $\mathrm{C}^{*}$-seminorm $\|\cdot\|$ on $\mathcal{A}$ will satisfy $\left\|u_{k l}^{i j}\right\| \leq 1$ for all $1 \leq i, j \leq n$ and $A$ is the completion of $\mathcal{A}$ with respect to the largest $\mathrm{C}^{*}$-seminorm on $\mathcal{A}$.

Also, it is easy to verify that for all $z \in \mathbb{T}$ the elements $\left(\alpha_{z}\left(u_{k l}^{i j}\right)\right)_{1 \leq i, j, k, l \leq n}$ in (3.10) satisfy the relations (3.5)-(3.9). This ensures the existence and uniqueness of the action $\alpha$ of $\mathbb{T}$ on $A$.

Now we consider the diagonal action $\alpha \bowtie \alpha$ of $\mathbb{T}$ on $A \boxtimes_{\zeta} A:(\alpha \bowtie \alpha)_{z}\left(u_{r s}^{i j} \boxtimes_{\zeta}\right.$ $\left.u_{k l}^{r s}\right)=\alpha_{z}\left(u_{r s}^{i j}\right) \boxtimes_{\zeta} \alpha_{z}\left(u_{k l}^{r s}\right)=\zeta^{d_{i}-d_{j}+d_{k}-d_{l}}\left(u_{r s}^{i j} \boxtimes_{\zeta} u_{k l}^{r s}\right)$ for all $1 \leq r, s \leq n$. This shows that $\Delta_{A}\left(u_{k l}^{i j}\right)$ is also a homogeneous element of $A \boxtimes_{\zeta} A$ with degree $d_{i}-d_{j}+d_{k}-d_{l}$. Hence $\Delta_{A}$ is $\mathbb{T}$-equivariant on the generators of $A$. Next, we recall the commutation relation (2.5) and (3.14) to verify the latter for $\Delta_{A}\left(u_{k l}^{i j}\right)$ :

& \sum_{t=1}^{n}(\alpha \bowtie \alpha)_{\zeta^{d_{t}}}\left(\Delta_{A}\left(u_{k s}^{i t}\right)\right) \cdot(\alpha \bowtie \alpha)_{\zeta^{d_{j}}}\left(\Delta_{A}\left(u_{m l}^{t j}\right)\right) \\
& =\sum_{t, p, q, x, y=1}^{n}\left(\alpha_{\zeta^{d_{t}}}\left(u_{p q}^{i t}\right) \boxtimes_{\zeta} \alpha_{\zeta^{d_{t}}}\left(u_{k s}^{p q}\right)\right)\left(\alpha_{\zeta^{d_{j}}}\left(u_{x y}^{t j}\right) \boxtimes_{\zeta} \alpha_{\zeta^{d_{j}}}\left(u_{m l}^{x y}\right)\right) \\
& =\sum_{t, p, q, x, y=1}^{n} \zeta^{\left(d_{k}-d_{p}+d_{q}-d_{s}\right)\left(d_{x}-d_{t}+d_{j}-d_{y}\right)} \cdot \alpha_{\zeta^{d_{t}}}\left(u_{p q}^{i t}\right) \alpha_{\zeta^{d_{j}}}\left(u_{x y}^{t j}\right) \boxtimes_{\zeta} \alpha_{\zeta^{d_{t}}}\left(u_{k s}^{p q}\right) \alpha_{\zeta^{d_{j}}}\left(u_{m l}^{x y}\right)
\end{aligned}
$$

$$
\begin{aligned}
& =\sum_{p, x, y=1}^{n} \zeta^{\left(d_{k}-d_{p}+d_{x}-d_{s}\right)\left(d_{x}-d_{t}+d_{j}-d_{y}\right)} \cdot \alpha_{\zeta^{d_{j}}}\left(u_{p y}^{i j}\right) \boxtimes_{\zeta} \alpha_{\zeta^{d_{t}}}\left(u_{k s}^{p x}\right) \alpha_{\zeta^{d_{j}}}\left(u_{m l}^{x y}\right) \\
& =\sum_{p, x, y=1}^{n} \zeta^{\left(d_{k}-d_{p}-d_{s}+d_{m}+d_{y}-d_{l}\right)\left(d_{j}-d_{y}\right)} \cdot \alpha_{\zeta^{d_{j}}}\left(u_{p y}^{i j}\right) \boxtimes_{\zeta} \alpha_{\zeta^{d_{x}}}\left(u_{k s}^{p x}\right) \alpha_{\zeta^{d_{y}}}\left(u_{m l}^{x y}\right) \\
& =\sum_{p, y=1}^{n} \zeta^{\left(d_{k}-d_{p}-d_{s}+d_{m}+d_{y}-d_{l}\right)\left(d_{j}-d_{y}\right)} \cdot \delta_{s, m} \cdot \alpha_{\zeta^{d_{j}}}\left(u_{p y}^{i j}\right) \boxtimes_{\zeta} \alpha_{\zeta^{d_{y}}}\left(u_{k l}^{p y}\right) \\
& =\sum_{p, y=1}^{n} \zeta^{\left(d_{m}-d_{s}\right)\left(d_{j}-d_{y}\right)} \cdot \delta_{s, m} \cdot \alpha_{\zeta^{d_{j}}}\left(u_{p y}^{i j}\right) \boxtimes_{\zeta} \alpha_{\zeta^{d_{j}}}\left(u_{k l}^{p y}\right)=\delta_{s, m} \cdot(\alpha \bowtie \alpha)_{\zeta^{d_{j}}}\left(u_{k l}^{i j}\right) .
\end{aligned}
$$

Similarly, we can verify that (3.6)-(3.9) for $\left\{\Delta_{A}\left(u_{k l}^{i j}\right)\right\}_{i, j, k, l,=1}^{n}$. Then, by the universal property of $A, \Delta_{A}$ extends to a unique $\mathbb{T}$-equivariant unital ${ }^{*}$-homomorphism $\Delta_{A}: A \rightarrow A \boxtimes_{\zeta} A$. The coassociativity for $\Delta_{A}$ is a routine check.

In order to verify the cancellation conditions (3.3) for $\Delta_{A}$, we are going to employ the argument same as in [12, Section 4]. Consider the set $S:=\left\{a \in A \mid a \boxtimes_{\zeta} 1_{A} \in\right.$ $\left.\Delta_{A}(A)\left(1 \boxtimes_{\zeta} A\right)\right\}$. Recall the canonical inclusions $j_{1}, j_{2}: A \rightrightarrows A \boxtimes_{\zeta} A$. Then we observe that

$$
\begin{equation*}
\left(\operatorname{id}_{\mathrm{M}_{n^{2}}(\mathbb{C})} \otimes \Delta_{A}\right) u=\left(\left(\mathrm{id}_{\mathrm{M}_{n^{2}}(\mathbb{C})} \otimes j_{1}\right) u\right)\left(\left(\mathrm{id}_{\mathrm{M}_{n^{2}}(\mathbb{C})} \otimes j_{2}\right) u\right) \tag{3.15}
\end{equation*}
$$

Since $u$ is unitary, we have $u_{k l}^{i j}, u_{k l}^{i j *} \in S$ for all $1 \leq i, j, k, l \leq n$. By virtue of [12, Proposition 3.1], for any two homogeneous elements $x, y \in S$ we have

$$
\begin{aligned}
j_{1}(x y)=j_{1}(x) j_{1}(y) \in \Delta_{A}(A) j_{2}(A) j_{1}(y) & =\Delta_{A}(A) j_{1}(y) j_{2}(A) \\
& \subseteq \Delta_{A}(A) \Delta_{A}(A) j_{2}(A) j_{2}(A) \\
& =\Delta_{A}(A) j_{2}(A)
\end{aligned}
$$

So, $x y \in S$. Therefore, all the monomials in $u_{k l}^{i j}$ and $u_{k l}^{i j *}$ belongs to $S$. Then $S$ is dense in $A$. Consequently, $A \boxtimes_{\zeta} A=j_{1}(A) j_{2}(A) \subseteq \Delta_{A}(A) j_{2}(A) \subseteq A \boxtimes_{\zeta} A$. Similarly, we can show $\Delta_{A}(A) j_{1}(A)=A \boxtimes_{\zeta} A$ by proving that $\left\{a \in A \mid j_{2}(a) \in j_{1}(A) \Delta_{A}(A)\right\}$ is dense in $A$.

Definition 3.16. An action of a braided compact quantum group $\mathbb{G}=\left(B, \beta, \Delta_{B}\right)$ over $\mathbb{T}$ on an object $(D, \gamma)$ of $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$ is an element $\eta \in \operatorname{Mor}^{\mathbb{T}}\left(D, D \boxtimes_{\zeta} B\right)$ such that
(1) $\eta$ is a comodule structure:

$$
\begin{equation*}
\left(\operatorname{id}_{D} \boxtimes_{\zeta} \Delta_{B}\right) \circ \eta=\left(\eta \boxtimes_{\zeta} \operatorname{id}_{B}\right) \circ \eta \tag{3.17}
\end{equation*}
$$

(2) $\eta$ satisfies the Podleśs condition: $\eta(D)\left(1_{D} \boxtimes_{\zeta} B\right)=D \boxtimes_{\zeta} B$.

Also, $\eta$ is said to preserve a state $f \in \operatorname{Mor}^{\mathbb{T}}(D, \mathbb{C})$ if $\left(f \boxtimes_{\zeta} \operatorname{id}_{A}\right) \eta(d)=f(d) 1_{B}$ for all $d \in D$.

Consider faithful covariant representations of $(D, \gamma)$ and $(B, \beta)$ on some separable Hilbert spaces $\mathcal{L}_{1}$ and $\mathcal{L}_{2}$ carrying $\mathbb{T}$-actions, respectively. Then $\eta$ defines a faithful representation $\eta: D \rightarrow D \boxtimes_{\zeta} B \subseteq \mathbb{B}\left(\mathcal{L}_{1} \otimes \mathcal{L}_{2}\right)$.

The action $\eta$ is called faithful if the norm closure of the linear span of $\{(\omega \otimes$ $\left.\left.\operatorname{id}_{\mathbb{B}\left(\mathcal{L}_{2}\right)}\right) \eta(d) \mid \omega \in \mathbb{B}\left(\mathcal{L}_{1}\right)_{*}\right\} \subseteq \mathbb{B}\left(\mathcal{L}_{2}\right)$ coincides with image of $B$ inside $\mathbb{B}\left(\mathcal{L}_{2}\right)$.

If $\eta$ preserves a faithful state $f$ on $D$, then $\eta$ is injective.
Proposition 3.18. The map $\eta: \mathrm{M}_{n}(\mathbb{C}) \rightarrow \mathrm{M}_{n}(\mathbb{C}) \boxtimes_{\zeta} A$ defined by

$$
\eta\left(E_{i j}\right)=\sum_{k, l=1}^{n} E_{k l} \boxtimes_{\zeta} u_{i j}^{k l} \quad \text { for all } 1 \leq i, j \leq n,
$$

is a faithful action of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ on $\left(\mathrm{M}_{n}(\mathbb{C}), \Pi\right)$ and preserves $\phi$.

Proof. It is easy to verify that $\eta$ is $\mathbb{T}$-equivariant, $\eta\left(E_{i j}^{*}\right)=\eta\left(E_{i j}\right)^{*}$ and $\sum_{i=1}^{n} \eta\left(E_{i i}\right)=$ $1_{\mathrm{M}_{n}(\mathbb{C})} \boxtimes_{\zeta} 1_{A}$ for all $1 \leq i, j \leq n$. Also, using the relation (3.9) and the fact $\phi$ is $\mathbb{T}$-equivariant, we easily verify that $\eta$ preserves $\phi$.

To verify that $\eta$ is multiplicative, first we recall the commutation relation (2.5) and the condition (3.14). Then for any $1 \leq i, j, k, l \leq n$ we compute

& \eta\left(E_{i j}\right) \eta\left(E_{k l}\right)=\sum_{r, s, x, y=1}^{n}\left(E_{r s} \boxtimes_{\zeta} u_{i j}^{r s}\right)\left(E_{x y} \boxtimes_{\zeta} u_{k l}^{x y}\right) \\
& =\sum_{r, s, y=1}^{n} \zeta^{\left(d_{s}-d_{y}\right)\left(d_{i}-d_{r}+d_{s}-d_{j}\right)}\left(E_{r y} \boxtimes_{\zeta} u_{i j}^{r s} u_{k l}^{s y}\right) \\
& =\sum_{r, s, y=1}^{n} \zeta^{d_{y}\left(d_{r}-d_{y}-d_{i}+d_{j}-d_{k}+d_{l}\right)} E_{r y} \boxtimes_{\zeta}\left(\alpha_{\zeta^{d_{s}}}\left(u_{i j}^{r s}\right)\left(\alpha_{\zeta^{d_{y}}}\left(u_{k l}^{s y}\right)\right)\right. \\
& =\delta_{j, k} \sum_{r, y=1}^{n} \zeta^{d_{y}\left(d_{r}-d_{y}-d_{i}+d_{l}\right)} E_{r y} \boxtimes_{\zeta} \alpha_{\zeta^{d_{y}}}\left(u_{i l}^{r y}\right)=\delta_{j, k} \cdot \eta\left(E_{i l}\right) .
\end{aligned}
$$

Thus $\eta: \mathrm{M}_{n}(\mathbb{C}) \rightarrow \mathrm{M}_{n}(\mathbb{C}) \boxtimes_{\zeta} A$ is a well-defined unital ${ }^{*}$-homomorphism. Verification of Definition 3.16 (1) is a routine check. Finally, consider the set $S:=\{M \in$ $\left.\mathrm{M}_{n}(\mathbb{C}) \mid M \boxtimes_{\zeta} 1_{A} \in \eta\left(\mathrm{M}_{n}(\mathbb{C})\right)\left(1_{\mathrm{M}_{n}(\mathbb{C})} \boxtimes_{\zeta} A\right)\right\}$. Since $u$ is unitary, in particular, we have $\sum_{r, s=1}^{n} u_{r s}^{i j} u_{k l}^{r s *}=\delta_{i, k} \cdot \delta_{j, s} \cdot 1_{A}$ for all $1 \leq i, j, k, l \leq n$. This condition implies

$$
\begin{aligned}
\sum_{r, s=1}^{n} \eta\left(E_{r s}\right)\left(1 \boxtimes_{\zeta} u_{k l}^{r s *}\right)=\sum_{i, j, r, s=1}^{n} E_{i j} \boxtimes_{\zeta}\left(u_{r s}^{i j} u_{k l}^{r s *}\right) & =\sum_{i, j=1}^{n} \delta_{i, k} \cdot \delta_{j, l} \cdot\left(E_{i j} \boxtimes_{\zeta} 1_{A}\right) \\
& =E_{k l} \boxtimes_{\zeta} 1_{A}
\end{aligned}
$$

for all $1 \leq k, l \leq n$. So $E_{k l}, E_{k l}^{*} \in S$. Then using arguments similar to the proof of the first equality in (3.3) as in Theorem 3.4 we can verify Definition 3.16 (2).

Let us consider faithful covariant representations of $\left(\mathrm{M}_{n}(\mathbb{C}), \Pi\right)$ and $(A, \alpha)$ on some Hilbert spaces $\mathcal{L}_{1}$ and $\mathcal{L}_{2}$, respectively. Then we fix an orthonormal basis $\left\{\lambda_{r}^{i}\right\}_{r \in \mathbb{N}}$ consisting of eigenvectors for the representation of $\mathbb{T}$ on $\mathcal{L}_{i}$, for $i=1,2$. We fix $i, j \in\{1, \cdots, n\}$. Then we use (2.2)-(2.4) and compute

\eta\left(E_{i j}\right)\left(\lambda_{r}^{1} \otimes \lambda_{s}^{2}\right)=\sum_{k, l=1}^{n} \zeta_{r}^{l_{r}^{1} \operatorname{deg}\left(u_{i j}^{k l}\right)}\left(E_{k l} \lambda_{r}^{1} \otimes u_{i j}^{k l} \lambda_{s}^{2}\right), \quad \text { where } r, s \in \mathbb{N} .
$$

Next we fix $a, b \in\{1, \cdots, n\}$. Define $f:\{1, \cdots, n\} \rightarrow \mathbb{C}$ by $f(y)=\zeta^{-\operatorname{deg}\left(E_{b y}\right) \operatorname{deg}\left(u_{i j}^{a b}\right)}$. For any $\xi_{1}, \xi_{2} \in \mathcal{L}_{1}$, the vector functionals $\omega_{\xi_{1}, \xi_{2}}$ are defined by $\omega_{\xi_{1}, \xi_{2}}(T)=$ $\left\langle\xi_{1}, T\left(\xi_{2}\right)\right\rangle$ for all $T \in \mathbb{B}\left(\mathcal{L}_{1}\right)$. For a fixed $r \in \mathbb{N}$, define $\omega:=\sum_{y=1}^{n} f(y) \omega_{E_{a y} \lambda_{r}^{1}, E_{b y} \lambda_{r}^{1}}$. A simple computation using the last equation gives

\left(\left(\omega \otimes \operatorname{id}_{\mathbb{B}\left(\mathcal{L}_{2}\right)}\right) \eta\left(E_{i j}\right)\right) \lambda_{s}^{2}=\left\langle\sum_{y=1}^{n} \lambda_{r}^{1}, E_{y y} \lambda_{r}^{1}\right\rangle \zeta^{l_{r}^{1} \operatorname{deg}\left(u_{i j}^{a b}\right)} u_{i j}^{a b} \lambda_{s}^{2}=\zeta^{l_{r}^{1} \operatorname{deg}\left(u_{i j}^{a b}\right)} u_{i j}^{a b} \lambda_{s}^{2}
$$

## 4. The bosonisation

The bosonisation of a braided compact quantum group over $\mathbb{T}$ is an ordinary compact quantum group together with an idempotent quantum group homomorphism ("projection") with image $\left(\mathrm{C}(\mathbb{T}), \Delta_{\mathrm{C}(\mathbb{T})}\right)$. Conversely, every compact quantum group with projection having $\left(\mathrm{C}(\mathbb{T}), \Delta_{\mathrm{C}(\mathbb{T})}\right)$ as image is the bosonisation of a braided compact quantum group over $\mathbb{T}$ [17, Theorem 6.4]. We construct the bosonisation of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ in the following theorem.

Theorem 4.1. Suppose $\left(C, \Delta_{C}\right)$ is the bosonisation of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$. Then $C$ is isomorphic to the universal $\mathrm{C}^{*}$-algebra generated by the elements $z$ and $u_{i j}^{k l}$ for $1 \leq$ $i, j, k, l \leq n$ subject to the relations $z^{*} z=z z^{*}=1$, (3.5)-(3.9) and $z u_{k l}^{i j} z^{*}=$ $\zeta^{d_{i}-d_{k}+d_{l}-d_{j}} u_{k l}^{i j}$. The comultiplication map $\Delta_{C}$ is given by

\begin{equation*}
\Delta_{C}(z)=z \otimes z, \quad \Delta_{C}\left(u_{k l}^{i j}\right)=\sum_{r, s=1}^{n} u_{r s}^{i j} \otimes z^{d_{r}-d_{i}+d_{j}-d_{s}} u_{k l}^{r s} \tag{4.2}
\end{equation*}
$$

In particular, $C \cong A \rtimes \mathbb{Z}$, where $\alpha_{\zeta^{-1}}$ generates the action of $\mathbb{Z}$ on $A$. We denote $\left(C, \Delta_{C}\right)$ by $\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right)$.
Proof. Let $\mathcal{L}$ be a separable Hilbert space with a continuous representation $\pi$ of $\mathbb{T}$. Suppose $\left\{\lambda_{m}\right\}_{m \in \mathbb{N}}$ is an orthonormal basis of $\mathcal{L}$ consisting of the eigenvectors for the $\mathbb{T}$-action, that is, $\pi_{z}\left(\lambda_{m}\right)=z^{l_{m}} \lambda_{m}$ for some $l_{m} \in \mathbb{N}$. The braiding uni$\operatorname{tary} \mathcal{L}_{\chi^{L^{2}}(\mathbb{T})}: \mathcal{L} \otimes L^{2}(\mathbb{T}) \rightarrow L^{2}(\mathbb{T}) \otimes \mathcal{L}$ and its inverse ${ }^{L^{2}(\mathbb{T})>{ }^{\mathcal{L}}}: L^{2}(\mathbb{T}) \otimes \mathcal{L} \rightarrow \mathcal{L} \otimes L^{2}(\mathbb{T})$ are similar to (2.2). On the basis vectors they are defined by

\mathcal{L}_{\chi^{L^{2}}(\mathbb{T})}\left(\lambda_{m} \otimes z^{r}\right)=\zeta^{r l_{m}}\left(z^{r} \otimes \lambda_{m}\right), \quad L^{2}(\mathbb{T}) ソ^{\mathcal{L}}\left(z^{r} \otimes \lambda_{m}\right)=\zeta^{-r l_{m}}\left(\lambda_{m} \otimes z^{r}\right) .
$$

These are the same braiding unitaries in [17, Section 6]. Here $A$ is viewed as a $\mathbb{T}$-Yetter-Drinfeld $C^{*}$-algebra with respect to the $\mathbb{T}$-action $\alpha$ and the $\mathbb{Z}$-action generated by $\alpha_{\zeta^{-1}}$. The $\mathbb{Z}$-action is the composition of $\alpha$ with the group homomorphism induced by the R-matrix (1.1), $\mathbb{Z} \rightarrow \mathbb{T}, n \rightarrow \zeta^{-n}$ as observed in (19, Appendix A].

Consider a faithful $\mathbb{T}$-equivariant representation $A \hookrightarrow \mathbb{B}(\mathcal{L})$. Then (2.3) and (2.4) give

\pi_{z}\left(u_{k l}^{i j} \lambda_{m}\right)=z^{d_{k}-d_{i}+d_{j}-d_{l}+l_{m}} u_{k l}^{i j} \lambda_{m}, \quad \pi_{z}\left(u_{k l}^{i j *} \lambda_{m}\right)=z^{d_{i}-d_{k}+d_{l}-d_{j}+l_{m}} u_{k l}^{i j *} \lambda_{m}
$$

Therefore, the underlying $\mathrm{C}^{*}$-algebra $C$ is the braided tensor product:

In fact, $C$ is generated by $z \boxtimes_{\zeta} 1_{A}=z \otimes 1$ and $1_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} u_{k l}^{i j}=\mathcal{L}_{\chi} L^{2}(\mathbb{T}) \cdot\left(u_{k l}^{i j} \otimes\right.$ $\left.1_{\mathbb{B}\left(L^{2}(\mathbb{T})\right)}\right) \cdot L^{2}\left(\mathbb{T}>^{\mathcal{L}}\right.$. The latter operator acts on $L^{2}(\mathbb{T}) \otimes \mathcal{L}$ by

$$
\mathcal{L}_{\chi^{L^{2}}(\mathbb{T})} \cdot\left(u_{k l}^{i j} \otimes 1_{\mathbb{B}\left(L^{2}(\mathbb{T})\right)}\right) \cdot L^{2}(\mathbb{T}) \ngtr \mathcal{L}\left(z^{r} \otimes \lambda_{m}\right)=\zeta^{r\left(d_{k}-d_{i}+d_{l}-d_{j}\right)}\left(z^{r} \otimes u_{k l}^{i j} \lambda_{m}\right),
$$

and consequently we get the commutation relation 2.5

\left(z \boxtimes_{\zeta} 1_{A}\right)\left(1_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} u_{k l}^{i j}\right)\left(z^{*} \boxtimes_{\zeta} 1_{A}\right)=\zeta^{-\left(d_{k}-d_{i}+d_{j}-d_{l}\right)}\left(1_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} u_{k l}^{i j}\right)=1_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} \alpha_{\zeta^{-1}}\left(u_{k l}^{i j}\right) .
$$

The above equation shows that the unitaries $z^{r} \boxtimes_{\zeta} 1_{A}$ and the faithful representation $A \hookrightarrow \mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} A \subseteq \mathbb{B}\left(L^{2}(\mathbb{T}) \otimes \mathcal{L}\right)$ form a covariant representation for the $\mathbb{Z}$-action on $A$ generated by $\alpha_{\zeta^{-1}}$. Moreover, it is unitarily equivalent to the regular representation that defines the reduced crossed product for the $\mathbb{Z}$-action on $A$ generated by $\alpha_{\zeta^{-1}}$. So, $C=\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} A \cong A \rtimes \mathbb{Z}$. Then, $C$ is the universal $\mathrm{C}^{*}$-algebra generated by a unitary $z$ and $\left\{u_{k l}^{i j}\right\}_{1 \leq i, j, k, l \leq n}$ subject to the relations (3.5)-(3.9) and the commutation relation

$$
z u_{k l}^{i j}=\zeta^{d_{i}-d_{k}+d_{l}-d_{j}} u_{k l}^{i j} z .
$$

The comultiplication map $\Delta_{C}: C \rightarrow C \otimes C$ is defined by $\Delta_{C}=\Psi^{A, A} \circ\left(\operatorname{id}_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} \Delta_{A}\right)$, where $\Psi^{A, A}: \mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} A \boxtimes_{\zeta} A \rightarrow\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} A\right) \otimes\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} A\right)=C \otimes C$ is given by (2.6) for $B=D=A$ and $\beta=\gamma=\alpha$. Using $\Delta_{\mathrm{C}(\mathbb{T})}(z)=z \otimes z$ and (3.11), we compute

\Delta_{C}\left(j_{1}(z)\right) & =\left(j_{1} \otimes j_{1}\right) \Delta_{\mathrm{C}(\mathbb{T})}(z)=j_{1}(z) \otimes j_{1}(z) \\
\Delta_{C}\left(j_{2}\left(u_{k l}^{i j}\right)\right) & =\Psi^{A, A}\left(\sum_{r, s=1}^{n} j_{2}\left(u_{r s}^{i j}\right) j_{3}\left(u_{k l}^{r s}\right)\right)
\end{aligned}
$$

$$
\begin{aligned}
& =\sum_{r, s=1}^{n}\left(j_{2}\left(u_{r s}^{i j}\right) \otimes j_{1}\left(z^{d_{r}-d_{i}+d_{j}-d_{s}}\right)\right) \cdot\left(1_{C} \otimes j_{2}\left(u_{k l}^{r s}\right)\right) \\
& =\sum_{r, s=1}^{n} j_{2}\left(u_{r s}^{i j}\right) \otimes j_{1}\left(z^{d_{r}-d_{i}+d_{j}-d_{s}}\right) j_{2}\left(u_{k l}^{r s}\right)
\end{aligned}
$$

After dropping the inclusion maps $j_{1}$ and $j_{2}$ from our notation above we get the formulas for $\Delta_{C}$.

## 5. The universal property of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ and its bosonisation

Let $(D, \gamma)$ be an object of the category $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$. Let $\mathbb{G}=\left(B, \beta, \Delta_{B}\right)$ be a braided compact quantum group over $\mathbb{T}$ and let $\left(C^{\prime}, \Delta_{C^{\prime}}\right)$ be its bosonisation. Suppose $\eta \in \operatorname{Mor}^{\mathbb{T}}\left(D, D \boxtimes_{\zeta} B\right)$ is an action of $\mathbb{G}$ on $D$. Then $C^{\prime}=\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} B$ and the comultiplication map $\Delta_{C^{\prime}}=\Psi^{B, B} \circ\left(\mathrm{id}_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} \Delta_{B}\right)$, where $\Psi^{B, B}$ is given by (2.6) for $(D, \gamma)=(B, \beta)$.
Proposition 5.1. Define $\widetilde{\eta}: \mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D \rightarrow\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D\right) \otimes\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} B\right)=\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta}\right.$ $D) \otimes C^{\prime}$ by $\widetilde{\eta}=\Psi^{D, B} \circ\left(\mathrm{id}_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} \eta\right)$, where $\Psi^{D, B}$ is given by (2.6). Then $\widetilde{\eta}$ is an action of the ordinary compact quantum group $\left(C^{\prime}, \Delta_{C^{\prime}}\right)$ on $\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D$.

Proof. Since $\Psi^{D, B}$ and $\eta$ are injective, so is $\widetilde{\eta}$. Next, we consider $(D, \gamma),\left(B \boxtimes_{\zeta}\right.$ $B, \beta \bowtie \beta)$ and $\left(D \boxtimes_{\zeta} B, \gamma \bowtie \beta\right),(B, \beta)$ in (2.6). Then we get the following injective unital ${ }^{*}$-homomorphisms:

& \Psi^{D, B \boxtimes_{\zeta} B}: \mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D \boxtimes_{\zeta}\left(B \boxtimes_{\zeta} B\right) \rightarrow\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D\right) \otimes\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} B \boxtimes_{\zeta} B\right), \\
& \Psi^{D \boxtimes \zeta B, B}: \mathrm{C}(\mathbb{T}) \boxtimes_{\zeta}\left(D \boxtimes_{\zeta} B\right) \boxtimes_{\zeta} B \rightarrow\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D \boxtimes_{\zeta} B\right) \otimes\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} B\right),
\end{aligned}
$$

satisfying

$$
\begin{array}{ll}
\Psi^{D, B \boxtimes \zeta B} j_{1}(a)=\left(j_{1} \otimes j_{1}\right) \Delta_{\mathrm{C}(\mathbb{T})}(a), & \Psi^{D \boxtimes \zeta B, B} j_{1}(a)=\left(j_{1} \otimes j_{1}\right) \Delta_{\mathrm{C}(\mathbb{T})}(a), \\
\Psi^{D, B \boxtimes \zeta B} j_{2}(d)=\left(j_{2} \otimes j_{1}\right) \gamma(d), & \Psi^{D \boxtimes \zeta B, B} j_{2}(d)=\left(j_{2} \otimes j_{1}\right) \gamma(d), \\
\Psi^{D, B \boxtimes \zeta B} j_{3}(b)=1_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D} \otimes j_{2}(b), & \Psi^{D \boxtimes \zeta B, B} j_{3}(b)=\left(j_{3} \otimes j_{1}\right) \beta(b), \\
\Psi^{D, B \boxtimes \zeta B} j_{4}(b)=1_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D} \otimes j_{3}(b), & \Psi^{D \boxtimes \zeta B, B} j_{4}(b)=1_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D \boxtimes_{\zeta} B} \otimes j_{2}(b),
\end{array}
$$

for all $a \in \mathrm{C}(\mathbb{T}), b \in B$ and $d \in D$. Using these maps and the equivariance of $\Delta_{B}$ with respect to the $\mathbb{T}$-actions $\beta$ and $\beta \bowtie \beta$ on $B$ and $B \boxtimes_{\zeta} B$, we obtain the following identities:

\left(\left(\mathrm{id}_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} \eta\right) \otimes \mathrm{id}_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} B}\right) \circ \Psi^{D, B} & =\Psi^{D \boxtimes_{\zeta} B, B} \circ\left(\mathrm{id}_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} \eta \boxtimes_{\zeta} \operatorname{id}_{B}\right) . \tag{5.2}
\end{align*}
$$

Using the condition $\left(\gamma \otimes \mathrm{id}_{\mathrm{C}(\mathbb{T})}\right) \circ \gamma=\left(\operatorname{id}_{D} \otimes \Delta_{\mathrm{C}(\mathbb{T})}\right) \circ \gamma$ we can verify the following equation $\left(\mathrm{id}_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D} \otimes \Psi^{B, B}\right) \circ \Psi^{D, B \boxtimes_{\zeta} B} \circ j_{l}=\left(\Psi^{D, B} \otimes \operatorname{id}_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} B}\right) \circ \Psi^{D \boxtimes_{\zeta} B, B} \circ j_{l}$ for $l=1,2,3,4$. Combining it with (5.2) and using (3.16) we get

\left(\widetilde{\eta} \otimes \mathrm{id}_{C^{\prime}}\right) \circ \tilde{\eta} \circ j_{l}=\left(\mathrm{id}_{\mathrm{C}(\mathbb{T}) \boxtimes_{\varsigma} D} \otimes \Delta_{C^{\prime}}\right) \circ \widetilde{\eta} \circ j_{l} \quad \text { for } l=1,2 .
$$

Recall the (braided) Podleś condition Definition 3.16(2) for $\eta$, the (ordinary) Podleś condition $\gamma(D)\left(1_{D} \otimes \mathrm{C}(\mathbb{T})=D \otimes \mathrm{C}(\mathbb{T})\right.$ for $\gamma$ and the cancellation condition $\Delta_{\mathrm{C}(\mathbb{T})}(\mathrm{C}(\mathbb{T})(1 \otimes$ $\mathrm{C}(\mathbb{T}))=\mathrm{C}(\mathbb{T}) \otimes \mathrm{C}(\mathbb{T})$ for $\Delta_{\mathrm{C}(\mathbb{T})}$. Using them we verify the Podleś condition for $\widetilde{\eta}$ :

& =\left(\Psi^{D, B}\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} \eta(D)\right)\right)\left(1_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D} \otimes j_{2}(B) j_{1}(\mathrm{C}(\mathbb{T}))\right) \\
& =\left(\Psi^{D, B}\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta}\left(\eta(D) j_{2}(B)\right)\right)\left(1_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D} \otimes j_{1}(\mathrm{C}(\mathbb{T}))\right)\right. \\
& =\left(\Psi^{D, B}\left(\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D \boxtimes_{\zeta} B\right)\right)\left(1_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D} \otimes j_{1}(\mathrm{C}(\mathbb{T}))\right)
\end{aligned}
$$

$$
\begin{aligned}
& =\left(\left(j_{1} \otimes j_{1}\right) \Delta_{\mathrm{C}(\mathbb{T})}(\mathrm{C}(\mathbb{T}))\right)\left(\left(j_{2} \otimes j_{1}\right) \gamma(D)\right)\left(1_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D} \otimes j_{2}(B) j_{1}(\mathrm{C}(\mathbb{T}))\right) \\
& =\left(\left(j_{1} \otimes j_{1}\right) \Delta_{\mathrm{C}(\mathbb{T})}(\mathrm{C}(\mathbb{T}))\right)\left(\left(j_{2} \otimes j_{1}\right)(\gamma(D)(1 \otimes \mathrm{C}(\mathbb{T})))\left(1_{\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D} \otimes j_{2}(B)\right)\right. \\
& =\left(\left(j_{1} \otimes j_{1}\right)\left(\Delta_{\mathrm{C}(\mathbb{T})}(\mathrm{C}(\mathbb{T}))\left(1_{\mathrm{C}(\mathbb{T})} \otimes \mathrm{C}(\mathbb{T})\right)\right)\left(j_{2}(D) \otimes j_{2}(B)\right)\right. \\
& =j_{1}(\mathrm{C}(\mathbb{T})) j_{2}(D) \otimes j_{1}(\mathrm{C}(\mathbb{T})) j_{2}(B)=\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} D \otimes C^{\prime} .
\end{aligned}
$$

### 5.1. Universal property of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$.

Definition 5.3. Let $\mathbb{G}_{1}=\left(B_{1}, \beta_{1}, \Delta_{B_{1}}\right)$ and $\mathbb{G}_{2}=\left(B_{2}, \beta_{2}, \Delta_{B_{2}}\right)$ be braided compact quantum groups over $\mathbb{T}$. A braided compact quantum groups homomorphism $f: \mathbb{G}_{1} \rightarrow \mathbb{G}_{2}$ is an element $f \in \operatorname{Mor}^{\mathbb{T}}\left(B_{1}, B_{2}\right)$ such that $\left(f \boxtimes_{\zeta} f\right) \circ \Delta_{B_{1}}=\Delta_{B_{2}} \circ f$.

Let $D$ be a unital $C^{*}$-algebra carrying an action $\gamma$ of $\mathbb{T}$. Suppose $\gamma$ preserves a faithful state $\phi$ on $D$. Let $\mathcal{C}^{\mathbb{T}}(D, \gamma, \phi)$ be the category with the pairs ( $\mathbb{G}, \eta$ ) consisting of a braided compact quantum groups $\mathbb{G}$ over $\mathbb{T}$ and $\eta$ is a $\phi$ preserving action of $\mathbb{G}$ on $(D, \gamma)$ as objects. An arrow between two objects $\left(\mathbb{G}_{1}, \eta_{1}\right)$ and $\left(\mathbb{G}_{2}, \eta_{2}\right)$ is a braided compact quantum group homomrphism $f: \mathbb{G}_{1} \rightarrow \mathbb{G}_{2}$ such that $\left(\mathrm{id}_{\mathrm{M}_{n}(\mathbb{C})} \boxtimes_{\zeta} f\right) \circ \eta_{1}=\eta_{2} \circ f$.

Theorem 5.4. $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ is the universal, initial object of the category $\mathcal{C}^{\mathbb{T}}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$.

Let $\mathbb{G}=\left(B, \beta, \Delta_{B}\right)$ be a braided compact quantum group over $\mathbb{T}$ and let $\eta: \mathrm{M}_{n}(\mathbb{C}) \rightarrow \mathrm{M}_{n}(\mathbb{C}) \boxtimes_{\zeta} B$ be an action of $\mathbb{G}$ on $\mathrm{M}_{n}(\mathbb{C})$. Since $\left\{E_{i j}\right\}_{i, j=1}^{n}$ is basis of $\mathrm{M}_{n}(\mathbb{C}), \eta$ is uniquely determined by its matrix coefficients $\left\{b_{i j}^{k l}\right\}_{1 \leq i, j, k, l \leq n} \subseteq B$ given by (1.4).

Now $\eta$ is $\mathbb{T}$-equivariant for the actions $\Pi$ and $\Pi \bowtie \beta$, and $E_{i j} \in \mathrm{M}_{n}(\mathbb{C})$ is a homogeneous element of degree $d_{i}-d_{j}$. Then $\eta\left(E_{i j}\right) \in \mathrm{M}_{n}(\mathbb{C}) \boxtimes_{\zeta} B$ must also be a homogeneous element of degree $d_{i}-d_{j}$. Therefore, each term on the right hand side of (1.4) appearing under summation must also be a homogeneous element of degree $d_{i}-d_{j}$. Equivalently,
$z^{d_{i}-d_{j}}\left(E_{k l} \boxtimes_{\zeta} b_{i j}^{k l}\right)=(\Pi \bowtie \beta)_{z}\left(E_{k l} \boxtimes_{\zeta} b_{i j}^{k l}\right)=\Pi_{z}\left(E_{k l}\right) \boxtimes_{\zeta} \beta_{z}\left(b_{i j}^{k l}\right)=z^{d_{k}-d_{l}} E_{k l} \boxtimes_{\zeta} \beta_{z}\left(b_{i j}^{k l}\right)$
Therefore, the restriction of $\beta$ on the elements $\left\{b_{k l}^{i j}\right\}_{i, j, k, l=1}^{n} \subseteq B$ is given by

$$
\begin{equation*}
\beta_{z}\left(b_{k l}^{i j}\right)=z^{d_{k}-d_{i}+d_{j}-d_{l}} b_{k l}^{i j}, \quad \text { for all } z \in \mathbb{T} . \tag{5.5}
\end{equation*}
$$

Next we determine the restriction of $\Delta_{B}$ on $\left\{b_{k l}^{i j}\right\}_{i, j, k, l=1}^{n}$. Let $\mathcal{L}^{\prime}$ be a separable Hilbert space with a continuous representation $\pi^{\prime}$ of $\mathbb{T}$. Suppose $\left\{\lambda_{m}^{\prime}\right\}_{m \in \mathbb{N}}$ is an orthonormal basis of eigenvectors for the $\mathbb{T}$-action: $\pi_{z}^{\prime}\left(\lambda_{m}\right)=z^{l_{m}^{\prime}} \lambda_{m}^{\prime}$ for some $l_{m}^{\prime} \in$ $\mathbb{N}$. Let $B \hookrightarrow \mathbb{B}(\mathcal{L})$ be a faithful, $\mathbb{T}$-equivariant representation.

Also, recall the $n$-dimensional vector space $W$ with the basis $\left\{e_{1}, e_{2}, \cdots, e_{n}\right\}$ equipped with $\mathbb{T}$-action $\rho$ considered in the proof of the Theorem 3.4. Then $E_{i j} e_{k}=$ $\delta_{j, k} e_{i}$ for all $1 \leq i, j, k \leq n$ is a faithful and $\mathbb{T}$-equivariant representation of $\mathrm{M}_{n}(\mathbb{C})$ on $W$.

The braiding unitary $\mathcal{L}^{\prime} \chi^{W}: \mathcal{L}^{\prime} \otimes W \rightarrow W \otimes \mathcal{L}^{\prime}$ and its inverse ${ }^{W} \times \mathcal{L}^{\prime}: W \otimes \mathcal{L}^{\prime} \rightarrow$ $\mathcal{L}^{\prime} \otimes W$ are similar to (2.2). On the basis vectors they are defined by

\begin{equation*}
\mathcal{L}^{\prime} \chi^{W}\left(\lambda_{m}^{\prime} \otimes e_{i}\right)=\zeta^{d_{i} l_{m}^{\prime}} \cdot\left(e_{i} \otimes \lambda_{m}^{\prime}\right), \quad W^{W} \mathcal{L}^{\mathcal{L}^{\prime}}\left(e_{i} \otimes \lambda_{m}^{\prime}\right)=\zeta^{-d_{i} l_{m}^{\prime}} \cdot\left(\lambda_{m}^{\prime} \otimes e_{i}\right) . \tag{5.6}
\end{equation*}
$$

The elementary braided tensors of $\mathrm{M}_{n}(\mathbb{C}) \boxtimes_{\zeta} B$ are defined by

a \boxtimes 1_{B}=a \otimes 1_{\mathbb{B}\left(\mathcal{L}^{\prime}\right)}, \quad 1_{\mathrm{M}_{n}(\mathbb{C})} \boxtimes b={\mathcal{\mathcal { L } ^ { \prime }} \chi^{W}\left(b \otimes 1_{\mathbb{B}(W)}\right)^{W} \text { 人 }^{\mathcal{L}^{\prime}} .} .
$$

In particular, we note that

$$
\left(1_{\mathrm{M}_{n}(\mathbb{C})} \boxtimes_{\zeta} b_{k l}^{i j}\right)\left(e_{k} \otimes \lambda_{m}^{\prime}\right)=\zeta^{-d_{k} l_{m}^{\prime}} \cdot \mathcal{L}^{\prime} \chi^{W}\left(b_{k l}^{i j} \lambda_{m}^{\prime} \otimes e_{k}\right)=\zeta^{d_{k}\left(d_{k}-d_{i}+d_{j}-d_{l}\right)} e_{k} \otimes b_{k l}^{i j} \lambda_{m}^{\prime},
$$

for all $1 \leq k \leq n$ and $m \in \mathbb{N}$. It also gives us the expected commutation relation (2.5):

\end{equation*}

The second condition in Definition 3.16 implies

\sum_{k, l, r, s=1}^{n} E_{r s} \boxtimes b_{k l}^{r s} \boxtimes b_{i j}^{k l}=\left(\alpha \boxtimes \mathrm{id}_{B}\right) \alpha\left(E_{i j}\right)=\sum_{r, s=1}^{n} E_{r s} \boxtimes \Delta_{B}\left(b_{i j}^{r s}\right) .

Next we compute the action of the first and the third terms appearing in the above equation on the basis vectors of $W \otimes \mathcal{L}^{\prime} \otimes \mathcal{L}^{\prime}$. For all $1 \leq p \leq n$ and $x, y \in \mathbb{N}$, we compute

$$

and

\left(\sum_{k, l, r, s=1}^{n} E_{r s} \boxtimes \Delta_{B}\left(b_{i j}^{r s}\right)\right)\left(e_{p} \otimes \lambda_{x}^{\prime} \otimes \lambda_{y}^{\prime}\right)=\sum_{r=1}^{n} \zeta^{d_{p}\left(d_{i}-d_{r}-d_{p}-d_{j}\right)} e_{r} \otimes \Delta_{B}\left(b_{i j}^{r p}\right)\left(\lambda_{x}^{\prime} \otimes \lambda_{y}^{\prime}\right)
$$

Thus we obtain the restriction of $\Delta_{B}$ on $\left\{b_{k l}^{i j}\right\}_{i, j, k, l=1}^{n} \subseteq B$ given by

\begin{equation*}
\Delta_{B}\left(b_{k l}^{i j}\right)=\sum_{r, s=1}^{n} b_{r s}^{i j} \boxtimes_{\zeta} b_{k l}^{r s} \tag{5.8}
\end{equation*}
$$

Proof of Theorem 5.4. Suppose $\mathbb{G}=\left(B, \beta, \Delta_{B}\right)$ is an object of $\mathcal{C}^{\mathbb{T}}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$. Denote the action of $\mathbb{G}$ on $\mathrm{M}_{n}(\mathbb{C})$ by $\eta: \mathrm{M}_{n}(\mathbb{C}) \rightarrow \mathrm{M}_{n}(\mathbb{C}) \boxtimes B$. Then $\eta$ satisfies the following condition:

\begin{equation*}
\left(\phi \boxtimes \operatorname{id}_{B}\right) \eta(M)=\phi(M) 1_{B}, \quad \text { for all } M \in \mathrm{M}_{n}(\mathbb{C}) \tag{5.9}
\end{equation*}
$$

Suppose $\mathbb{H}=\left(C^{\prime}, \Delta_{C^{\prime}}\right)$ is the bosonisation of $\mathbb{G}=\left(B, \beta, \Delta_{B}\right)$ and $\widetilde{\eta}$ be the corresponding action of $\mathbb{H}$ on $\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} \mathrm{M}_{n}(\mathbb{C})$, in Proposition 5.1 for $\left(\mathrm{M}_{n}(\mathbb{C}), \Pi\right)$. On the elementary braided tensors $z^{r} \boxtimes_{\zeta} E_{i j}$ it is defined by

$$
\begin{equation*}
\widetilde{\eta}\left(z^{r} \boxtimes_{\zeta} E_{i j}\right)=\sum_{k, l=1}^{n}\left(z^{r} \boxtimes_{\zeta} E_{k l}\right) \otimes\left(z^{d_{k}-d_{l}+r} \boxtimes_{\zeta} b_{i j}^{k l}\right), \quad \text { for all } r \in \mathbb{Z}, 1 \leq i, j \leq n \tag{5.10}
\end{equation*}
$$

where $\left\{b_{i j}^{k l}\right\}_{i, j, k, l=1}^{n}$ are the matrix elements of $\eta$ given by (1.4). Also, Theorem4.1 gives us the following commutation relation in $D=j_{1}(\mathrm{C}(\mathbb{T})) j_{2}(B)=\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} B$ :

\left(z \boxtimes_{\zeta} 1_{B}\right)\left(1_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} b_{k l}^{i j}\right)\left(z \boxtimes_{\zeta} 1_{B}\right)^{*}=\zeta^{-\left(d_{k}-d_{i}+d_{j}-d_{l}\right)} \cdot\left(1_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} b_{k l}^{i j}\right) \tag{5.11}
\end{equation*}
$$

for all $1 \leq i, j, k, l \leq n$. The restriction of $\widetilde{\eta}$ on $\mathrm{M}_{n}(\mathbb{C})$ becomes

$$
\begin{equation*}
\widetilde{\eta}\left(1_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} E_{i j}\right)=\sum_{k, l=1}^{n}\left(1_{\mathrm{C}(\mathbb{T})} \boxtimes_{\zeta} E_{k l}\right) \otimes\left(z^{d_{k}-d_{l}} \boxtimes_{\zeta} b_{i j}^{k l}\right), \quad \text { for all } 1 \leq i, j \leq n . \tag{5.12}
\end{equation*}
$$

Then we can verify that $\left.\widetilde{\eta}\right|_{\mathrm{M}_{n}(\mathbb{C})}$ defines an action of $\mathbb{H}$ on $\mathrm{M}_{n}(\mathbb{C})$ and preserves $\phi$. So, the matrix elements $\left\{z^{d_{i}-d_{j}} \boxtimes_{\zeta} b_{l k}^{i j}\right\}_{i, j, k, l=1}^{n}$ of $\left.\widetilde{\eta}\right|_{\mathrm{M}_{n}(\mathbb{C})}$ must satisfy the relations (3.5)-(3.9) with $\zeta=1$ by [22, Theorem 4.1]. Subsequently, using (5.11) we can easily show that $\left\{b_{k l}^{i j}\right\}_{i, j, k, l=1}^{n}$ satisfy the relations (3.5)-(3.9) in Theorem 3.4 Then the universal property of $A$ gives a unique ${ }^{*}$-homomorphism $f: A \rightarrow B$ such that $f\left(u_{k l}^{i j}\right)=b_{k l}^{i j}$ for all $i, j, k, l \in\{1, \cdots, n\}$. Clearly, $f$ is $\mathbb{T}$-equivariant and satisfies $\left(f \boxtimes_{\zeta} f\right) \circ \Delta_{A}=\Delta_{B} \circ f$; hence $f: \operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right) \rightarrow \mathbb{G}$ is a braided compact quantum group homomorphism.

### 5.2. Bosonisation as the inhomogeneous quantum symmetry group.

Definition 5.13 ([4, Definition 2.1]). Let $D$ be a unital $\mathrm{C}^{*}$-algebra and let $\tau_{D}$ be a faithful state on $D$. An orthogonal filtration for the pair $\left(D, \tau_{D}\right)$ is a sequence of finite dimensional subspaces $\left\{D_{i}\right\}_{i \in \mathcal{I}}$ of $D$, where $\mathcal{I}$ is the index set with a distinguished element 0 such that $D_{0}=\mathbb{C} \cdot 1_{D}, \operatorname{Span}\left(\cup_{i \in \mathcal{I}} D_{i}\right)$ is dense in $D$ and $\tau_{D}\left(a^{*} b\right)=0$ if $a \in D_{i}, b \in D_{j}$ and $i \neq j$. We denote the triple $\left(D, \tau_{D},\left\{D_{i}\right\}_{i \in \mathcal{I})}\right)$ by $\widetilde{D}$.

Let $\mathbb{H}=\left(Q, \Delta_{Q}\right)$ is a compact quantum group and let $\widetilde{D}$ be an orthogonal filtration of $D$. An action $\eta: D \rightarrow D \otimes Q$ is said to be filtration preserving if $\eta\left(D_{i}\right) \subseteq$ $D_{i} \otimes_{\text {alg }} Q$ for all $i \in \mathcal{I}$. Let $\mathcal{C}(\widetilde{D})$ be the category with objects as pairs $(\mathbb{H}, \eta)$, where $\mathbb{H}$ is a compact quantum group, $\eta$ is a filtration preserving action of $\mathbb{H}$ on $D$, and arrows are morphisms of compact quantum groups intertwining the respective actions. In 4] it was also observed that if $(\mathbb{H}, \varrho)$ is an object of $\mathcal{C}(\widetilde{D})$, then $\varrho$ preserves $\tau_{D}$.

Theorem 5.14 (4, Theorem 2.7]). There exists a universal initial object in the category $\mathcal{C}(\widetilde{D})$, called the quantum symmetry group of the filtration $\widetilde{D}$ and denoted by $\operatorname{QISO}(\widetilde{D})$.
Example 5.15. Define $\mathrm{M}_{n}(\mathbb{C})_{0}=\operatorname{Span}\left\{1_{\mathrm{M}_{n}(\mathbb{C})}\right\}$ and $\mathrm{M}_{n}(\mathbb{C})_{1}=\operatorname{Span}\left\{E_{i j} \mid 1 \leq\right.$ $i, j \leq n$ and $i \neq j\}$. Then $\widetilde{\mathrm{M}_{n}(\mathbb{C})}=\left(\mathrm{M}_{n}(\mathbb{C}), \phi,\left\{\mathrm{M}_{n}(\mathbb{C})_{i}\right\}_{i=0,1}\right)$ is an orthogonal filtration. Let $\mathbb{H}=\left(Q, \Delta_{Q}\right)$ be a compact quantum group and let $\varrho: \mathrm{M}_{n}(\mathbb{C}) \rightarrow$ $\mathrm{M}_{n}(\mathbb{C}) \otimes Q$ be an action of $\mathbb{G}$ on $\mathrm{M}_{n}(\mathbb{C})$. Then $\varrho$ is uniquely determined by the set elements $\left\{q_{i j}^{k l}\right\}_{1 \leq i, j, k, l \leq n} \subseteq Q$ such that

$$
\varrho\left(E_{i j}\right)=\sum_{k, l=1}^{n} E_{k l} \otimes q_{i j}^{k l}, \quad \text { for all } 1 \leq i, j \leq n .
$$

If $\varrho$ preserves the orthogonal filtration $\widetilde{\mathrm{M}_{n}(\mathbb{C})}$ then $\varrho$ preserves the trace $\phi$. Conversely, if we assume that $\varrho$ preserves the canonical trace $\phi$, then $\sum_{i=1}^{n} q_{i i}^{k l}=$ $\delta_{k, l}$ for all $1 \leq k, l \leq n$. Thus $\varrho$ preserves the orthogonal filtration $\mathrm{M}_{n}(\mathbb{C})$. Hence, $\operatorname{QISO}\left(\widetilde{\mathrm{M}_{n}(\mathbb{C})}\right)$ coincides with Wang's $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \phi\right)$ in [22, Theorem 4.1].
Example 5.16. Let $z$ be the unitary generator of $\mathrm{C}(\mathbb{T})$. Then the continuous linear extension of the map $z^{r} \rightarrow \delta_{r, 0}$ for all $r \in \mathbb{Z}$ is the canonical trace $\tau_{\mathrm{C}(\mathbb{T})}$ on $\mathrm{C}(\mathbb{T}) \cong$ $\mathrm{C}_{\mathrm{r}}^{*}(\mathbb{Z})$ and the subspaces $\mathrm{C}(\mathbb{T})_{i}:=\operatorname{Span}\left\{z^{i}\right\}$ for all $i \in \mathbb{Z}$ form an orthogonal filtration for $\left(\mathrm{C}(\mathbb{T}), \tau_{\mathrm{C}(\mathbb{T})}\right)$. Let $\mathbb{H}=\left(Q, \Delta_{Q}\right)$ be a compact quantum group and let $\varrho: \mathrm{C}(\mathbb{T}) \rightarrow \mathrm{C}(\mathbb{T}) \otimes Q$ be an action of $\mathbb{G}$ on $\mathrm{C}(\mathbb{T})$. Suppose, $(\mathbb{H}, \varrho)$ is an object of the category $\mathcal{C}(\widetilde{\mathrm{C}(\mathbb{T})})$. Then $\varrho\left(z^{r}\right)=z^{r} \otimes q_{r}$, where $q_{r} \in Q$ for all $r \in \mathbb{Z}$. Since, $\varrho$ is $\mathrm{a}^{*}$-homomorphism then $q_{0}=1_{Q}, q_{1}$ is unitary and $q_{r}=q_{1}^{r}$ for all $r \in \mathbb{Z}$. Moreover, $\Delta_{Q}\left(q_{1}\right)=q_{1} \otimes q_{1}$. Thus $\operatorname{QISO}(\widetilde{\mathrm{C}(\mathbb{T})}) \cong\left(\mathrm{C}(\mathbb{T}), \Delta_{\mathrm{C}(\mathbb{T})}\right)$.
Example 5.17. The braided tensor product $\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} \mathrm{M}_{n}(\mathbb{C})$ is isomorphic to the (reduced) crossed product $\mathrm{M}_{n}(\mathbb{C}) \rtimes \mathbb{Z}$ for the $\mathbb{Z}$-action on $\mathrm{M}_{n}(\mathbb{C})$ generated by $\Pi_{\zeta^{-1}}$. Thus $\mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} \mathrm{M}_{n}(\mathbb{C})$ is the universal $\mathrm{C}^{*}$-algebra generated by a unitary $v$ and $\left\{E_{i j}\right\}_{i, j=1}^{n}$ subject to the relations (1.2) and the commutation relation

$$
\begin{equation*}
v E_{i j} v^{*}=\zeta^{d_{i}-d_{j}} E_{i j} \tag{5.18}
\end{equation*}
$$

Composing $\phi$ with the conditional expectation $\mathrm{M}_{n}(\mathbb{C}) \rtimes \mathbb{Z} \rightarrow \mathrm{M}_{n}(\mathbb{C})$ gives a state $\tau$ on $\mathrm{M}_{n}(\mathbb{C}) \rtimes \mathbb{Z}$. Therefore, $\tau$ is the continuous linear extension of the map $v^{r} E_{i j} \rightarrow$ $\frac{1}{n} \delta_{r, 0} \cdot \delta_{i, j}$. By [6, Proposition $4.9 \&$ Lemma 6.1] the triple $\mathrm{M}_{n} \widetilde{(\mathbb{C}) \rtimes} \not \mathbb{Z}:=\left(\mathrm{M}_{n}(\mathbb{C}) \rtimes\right.$ $\left.\mathbb{Z}, \tau,\left\{v^{r} \cdot 1_{\mathrm{M}_{n}(\mathbb{C})}\right\}_{r \in \mathbb{Z}} \cup\left\{v^{s} \cdot E_{i j}\right\}_{s \in \mathbb{Z}, 1 \leq i, j \leq n ; i \neq j}\right)$ is an orthogonal filtration.

Recall the bosonisation $\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right)=\left(C, \Delta_{C}\right)$ constructed in Theorem4.1 Then we apply Proposition5.1]to the canonical action $\eta$ of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ on $\left(\mathrm{M}_{n}(\mathbb{C}), \Pi\right)$ in Proposition 3.18. The resulting action $\widetilde{\eta}: \mathrm{M}_{n}(\mathbb{C}) \rtimes \mathbb{Z} \rightarrow \mathrm{M}_{n}(\mathbb{C}) \rtimes$ $\mathbb{Z} \otimes C$ of $\left(C, \Delta_{C}\right)$ on $\mathrm{M}_{n}(\mathbb{C}) \rtimes \mathbb{Z}$ is defined by

$$
\widetilde{\eta}(v)=v \otimes z, \quad \widetilde{\eta}\left(E_{i j}\right)=\sum_{k, l=1}^{n} E_{k l} \otimes z^{d_{k}-d_{l}} u_{i j}^{k l}
$$

Since $\widetilde{\eta}$ preserves the filtration $\mathrm{M}_{n} \widetilde{(\mathbb{C}) \rtimes} \mathbb{Z}$ the pair $\left(\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right), \widetilde{\eta}\right)$ is

Proposition 5.19. $\operatorname{QISO}\left(\mathrm{M}_{n} \widetilde{(\mathbb{C}) \rtimes} \mathbb{Z}\right) \cong \operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right)$.
Proof. Let $\mathbb{H}=\left(Q, \Delta_{Q}\right)$ be a compact quantum group. Suppose $(\mathbb{H}, \varrho)$ is an object of $\mathcal{C}\left(\mathrm{M}_{n} \widehat{(\mathbb{C}) \rtimes} \mathbb{Z}\right)$. Then $\varrho$ preserves the filtration described above. There exists a unitary $u \in Q$ such that $\varrho\left(v^{r}\right)=v^{r} \otimes u^{r}$ and $\Delta_{Q}\left(u^{r}\right)=u^{r} \otimes u^{r}$ for all $r \in \mathbb{Z}$. On the other hand, the restriction of $\varrho$ on $E_{i j}$ is given by $\varrho\left(E_{i j}\right)=\sum_{k, l=1}^{n} E_{k l} \otimes q_{i j}^{k l}$, where $q_{i j}^{k l} \in Q$ for all $1 \leq i, j, k, l \leq n$. Since $\varrho$ preserves $\tau$, the restriction $\left.\varrho\right|_{\mathrm{M}_{n}(\mathbb{C})}$ preserves $\phi$. By [22, Theorem 4.1], the elements $q_{k l}^{i j}$ staisfy (3.5)-(3.9) with $\zeta=1$ and

$$
\Delta_{Q}\left(q_{i j}^{k l}\right)=\sum_{r, s=1}^{n} q_{r s}^{k l} \otimes q_{i j}^{r s}, \quad \text { for all } 1 \leq i, j, k, l \leq n
$$

Using the commutation relation (5.18) and the condition that $\widetilde{\eta}$ is a *-homomorphism we compute

$$
\zeta^{d_{i}-d_{j}} \varrho\left(E_{i j}\right)=\varrho\left(v E_{i j} v^{*}\right)=\sum_{k, l=1}^{n} v E_{k l} v^{*} \otimes u q_{i j}^{k l} u^{*}=\sum_{k, l=1}^{n} E_{k l} \otimes \zeta^{d_{k}-d_{l}} u q_{i j}^{k l} u^{*}
$$

This implies $u q_{i j}^{k l} u^{*}=\zeta^{d_{k}-d_{i}+d_{j}-d_{l}} q_{i j}^{k l}$ for all $1 \leq i, j, k, l \leq n$. Therefore, $\operatorname{QISO}\left(\widetilde{\mathrm{M}_{n}(\mathbb{C})}\right) \cong\left(\mathcal{Q}, \Delta_{\mathcal{Q}}\right)$, where $\mathcal{Q}$ is the universal $\mathrm{C}^{*}$-algebra generated by the elements $u,\left\{q_{i j}^{k l}\right\}_{i, j, k, l=1}^{n}$ and $\Delta_{\mathcal{Q}}$ is the restriction of $\Delta_{Q}$ to $\mathcal{Q}$. Then it is a routine check that $\mathcal{Q}$ is also generated by elements $u$ and $w_{i j}^{k l}:=u^{d_{l}-d_{k}} q_{i j}^{k l}$ for all $1 \leq i, j, k, l \leq n$ such that $u$ is unitary, $\left\{w_{i j}^{k l}\right\}$ satisfy the relations (3.5)(3.9) and $u w_{i j}^{k l} u^{*}=\zeta^{d_{k}-d_{i}+d_{j}-d_{l}} w_{i j}^{k l}$. Moreover, $\Delta_{\mathcal{Q}}\left(w_{i j}^{k l}\right)=\sum_{r, s=1}^{n} w_{r s}^{k l} \otimes$ $u^{d_{r}-d_{k}+d_{l}-d_{s}} w_{i j}^{r s}$ for all $1 \leq i, j, k, l \leq n$. Thus $\left(\mathcal{Q}, \Delta_{\mathcal{Q}}\right)$ is the bosonisation $\left(C, \Delta_{C}\right)$ of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ in Theorem 4.1.

The action $\Pi\left(E_{i j}\right)=E_{i j} \otimes z^{d_{i}-d_{j}}$ of $\mathbb{T}$ on $\mathrm{M}_{n}(\mathbb{C})$ preserves $\phi$, it also preserves $\widetilde{\mathrm{M}_{n}(\mathbb{C})}$ in Example 5.15. Thus $\left(\left(\mathrm{C}(\mathbb{T}), \Delta_{\mathrm{C}(\mathbb{T})}\right), \Pi\right)$ is an object of $\left.\mathcal{C}\left(\widetilde{\mathrm{M}_{n}(\mathbb{C}}\right)\right)$. Hence, there exists a unique compact quantum group homomorphism $f: \operatorname{QISO}\left(\widetilde{\mathrm{M}_{n}(\mathbb{C})}\right) \rightarrow \mathrm{C}(\mathbb{T})$ such that $f\left(q_{i j}^{k l}\right)=\delta_{k, i} \cdot \delta_{j, l} \cdot z^{d_{i}-d_{j}}$, where $\left\{q_{k l}^{i j}\right\}_{1 \leq i, j, k, l \leq n}$ is a generating set of Wang's $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \phi\right)$.

Now we view the $R$-matrix in (1.1) as a unitary element of the multiplier algebra of $\mathrm{C}_{0}(\mathbb{Z}) \otimes \mathrm{C}_{0}(\mathbb{Z})$. Then $\mathrm{V}:=\left(\mathrm{id}_{\mathrm{C}_{0}(\mathbb{Z})} \otimes \hat{f}\right) \mathrm{R}$ is a bicharacter, where $\hat{f}$ is the dual quantum group homomorphism from $\mathrm{C}_{0}(\mathbb{Z})$ to the dual of $\left.\operatorname{QISO} \widetilde{\left(\mathrm{M}_{n}\right.}(\mathbb{C})\right)$ (see [15, Section $3 \& 4])$. By [6, Theorem 5.1], QISO $\left(\mathrm{M}_{n} \widetilde{(\mathbb{C}) \rtimes} \mathbb{Z}\right) \cong \mathfrak{D}_{\mathrm{V}}$, where $\mathfrak{D}_{\mathrm{V}}$ is the generalised Drinfeld's double of $\operatorname{QISO}\left(\widetilde{\mathrm{M}_{n}(\mathbb{C})}\right)$ and $\operatorname{QISO}(\widetilde{\mathrm{C}(\mathbb{T})})$ (see [20]). Combining it with Proposition 5.19 we obtain the following corollary.

Corollary 5.20. $\mathfrak{D}_{\mathrm{V}} \cong \operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right)$.

Remark 5.21. For $i, j, k, l \in\{1, \cdots, n\}$, the elements $w_{i j}^{k l}$ generate the copy of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ inside $\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right)$, whereas the elements $q_{i j}^{k l}=$ $u^{d_{k}-d_{l}} w_{i j}^{k l}$ generate the copy of $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \phi\right)$ inside $\mathfrak{D}_{\mathrm{V}}$.

Then $q_{i j}^{k l}=u^{d_{k}-d_{l}} w_{i j}^{k l} \in C$ is a homogeneous element of degree $\left(d_{k}-d_{l}\right)+\left(d_{k}-\right.$ $d_{i}+d_{j}-d_{l}$ ) for the diagonal action $\Delta_{\mathrm{C}(\mathbb{T})} \bowtie \alpha$. Similarly, an element $v^{r} E_{i j} \in$ $\mathrm{M}_{n}(\mathbb{C}) \rtimes \mathbb{Z} \cong \mathrm{C}(\mathbb{T}) \boxtimes_{\zeta} \mathrm{M}_{n}(\mathbb{C})$ is homogeneous of degree $r+d_{i}-d_{j}$ for the diagonal action $\Delta_{\mathrm{C}(\mathbb{T})} \bowtie \Pi$.

The restriction of the action $\varrho$ on the factors $C(\mathbb{T})$ and $M_{n}(\mathbb{C})$ in the above Proposition 5.19 is precisely the action of $\mathfrak{D}_{\mathrm{V}}=\left(\mathcal{Q}, \Delta_{\mathcal{Q}}\right)$ on those factors (see [6, Theorem 3.5]). The latter one is given by

$$
\left.\varrho\right|_{\mathrm{M}_{n}(\mathbb{C})}\left(E_{i j}\right)=\sum_{k, l=1}^{n} E_{k l} \otimes q_{i j}^{k l}=\sum_{k, l=1}^{n} E_{k l} \otimes u^{d_{k}-d_{l}} w_{i j}^{k l} .
$$

However, $\left.\varrho\right|_{\mathrm{M}_{n}(\mathbb{C})}$ is not $\mathbb{T}$-equivariant for the actions $\Pi$ and $\Delta_{\mathrm{C}(\mathbb{T})} \bowtie \alpha$. This happens because $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \phi\right)$ fails to capture $\mathbb{T}$-homomgeneous compact quantum symmetries of the dynamical system $\left(\mathrm{M}_{n}(\mathbb{C}), \mathbb{Z}, \Pi_{\zeta^{-1}}\right)$.

On the other hand, if we realise $\varrho$ as an action of $\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right.$ on $\mathrm{M}_{n}(\mathbb{C}) \rtimes \mathbb{Z}$, then it coincides with $\eta$ in Proposition 5.1. Consequently, $\left.\varrho\right|_{\mathrm{M}_{n}(\mathbb{C})}$ gets identified with $\eta$ in Proposition 3.18. In this sense, $\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)$ is the $\mathbb{T}$-homogeneous quantum symmetry group of the $\mathrm{C}^{*}$-dynamical system $\left(\mathrm{M}_{n}(\mathbb{C}), \mathbb{Z}, \Pi_{\zeta^{-1}}\right)$ and $\operatorname{Bos}\left(\operatorname{Aut}\left(\mathrm{M}_{n}(\mathbb{C}), \Pi, \phi\right)\right)$ is the inhomogeneous quantum symmetry group of the same system.

## 6. Towards the direct sum of matrix algebras

For a fixed $m \in \mathbb{N}$, let $n_{1}, n_{2}, \cdots, n_{m} \in \mathbb{N}$. Then $D=\oplus_{x=1}^{m} \mathrm{M}_{n_{x}}(\mathbb{C})$ is the universal C ${ }^{*}$-algebra generated by $\left\{E_{i j, x}\right\}_{1 \leq i, j \leq n_{x}, 1 \leq x \leq m}$ subject to the following conditions:

$$
\begin{equation*}
E_{i j, x} E_{k l, y}=\delta_{j, k} \cdot \delta_{x, y} E_{i l, x}, \quad E_{i j, x}^{*}=E_{j i, x}, \quad \sum_{x=1}^{m} \sum_{i=1}^{n_{x}} E_{i i, x}=1 . \tag{6.1}
\end{equation*}
$$

For each $x \in\{1, \cdots, m\}$, we fix $d_{1}^{x} \leq d_{2}^{x} \leq \cdots \leq d_{n_{x}}^{x} \in \mathbb{Z}$ and define an action $\Pi^{x}$ of $\mathbb{T}$ on the $x^{\text {th }}$ component of $D$ by $\Pi_{z}^{x}\left(E_{i j, p}\right):=z^{d_{i}^{x}-d_{j}^{x}} E_{i j, x}$ for $z \in \mathbb{T}$. Extending them, we obtain the following $\mathbb{T}$-action on $D: \bar{\Pi}_{z}\left(\oplus_{x=1}^{m} M_{p}\right)=\oplus_{x=1}^{m} \Pi_{z}^{x}\left(M_{x}\right)$ for all $M_{x} \in \mathrm{M}_{n_{x}}(\mathbb{C})$, and $z \in \mathbb{T}$. The map $\phi\left(E_{i j, x}\right):=\delta_{i, j}$ is a positive linear functional on $D$ and $\bar{\Pi}$ preserves $\phi$.
Theorem 6.2. Consider the monoidal category $\left(\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T}), \boxtimes_{\zeta}\right)$ for a fixed $\zeta \in \mathbb{T}$. Let A be the universal $\mathrm{C}^{*}$-algebra with generators $u_{k l, x y}^{i j}$ for $1 \leq i, j \leq n_{x}, 1 \leq k, l \leq$ $n_{y}, 1 \leq x, y \leq m$ and the following relations:

$$
\begin{align*}
& \sum_{t=1}^{n_{x}}\left(\zeta^{d_{t}^{x}\left(d_{k}^{y}-d_{i}^{x}+d_{t}^{x}-d_{s}^{y}\right)} u_{k s, x y}^{i t}\right) \cdot\left(\zeta^{d_{j}^{x}\left(d_{m}^{w}-d_{t}^{x}+d_{j}^{x}-d_{l}^{w}\right)} u_{m l, x w}^{t j}\right) \\
& =\delta_{y, w} \cdot \delta_{s, m} \cdot\left(\zeta^{d_{j}^{x}}\left(d_{k}^{y}-d_{i}^{x}+d_{j}^{x}-d_{l}^{y} u_{k l, x y}^{i j}\right),\right.  \tag{6.3}\\
& \text { for all } 1 \leq k, s \leq n_{y}, 1 \leq m, l \leq n_{w}, 1 \leq i, j \leq n_{x}, 1 \leq x, y, w \leq m ; \\
& \sum_{t=1}^{n_{x}}\left(\zeta^{d_{s}^{y}\left(d_{k}^{x}-d_{i}^{y}+d_{s}^{y}-d_{t}^{x}\right)} u_{k t, y x}^{i s}\right) \cdot\left(\zeta^{d_{j}^{w}\left(d_{t}^{x}-d_{m}^{w}+d_{j}^{w}-d_{l}^{x}\right)} u_{t l, w x}^{m j}\right) \\
& =\delta_{y, w} \cdot \delta_{s, m} \cdot\left(\zeta^{d_{j}^{y}\left(d_{k}^{x}-d_{i}^{y}+d_{j}^{y}-d_{l}^{x}\right)} u_{k l, y x}^{i j}\right),  \tag{6.4}\\
& \text { for all } 1 \leq i, s \leq n_{y}, 1 \leq m, j \leq n_{w}, 1 \leq k, l \leq n_{x}, 1 \leq x, y, w \leq m ; \\
& u_{k l, x y}^{i j} *=\zeta^{\left(d_{i}^{x}-d_{j}^{x}\right)\left(d_{l}^{y}-d_{j}^{x}+d_{i}^{x}-d_{k}^{y}\right)}\left(u_{l k, x y}^{j i}\right), \tag{6.5}
\end{align*}
$$

for all $1 \leq i, j \leq n_{x}, 1 \leq k, l \leq n_{y}, 1 \leq x, y \leq m ;$

$$
\begin{align*}
& \sum_{y=1}^{m} \sum_{r=1}^{n_{y}} u_{r r, x y}^{i j}=\delta_{i, j}, \quad \text { for all } 1 \leq i, j \leq n_{x}, 1 \leq x \leq m  \tag{6.6}\\
& \sum_{x=1}^{m} \sum_{r=1}^{n_{x}} u_{k l, x y}^{r r}=\delta_{k, l}, \quad \text { for all } 1 \leq k, l \leq n_{y}, 1 \leq y \leq m \tag{6.7}
\end{align*}
$$

There exists a unique continuous action $\alpha$ of $\mathbb{T}$ on $A$ satisfying

$$
\begin{equation*}
\alpha_{z}\left(u_{k l, x y}^{i j}\right)=z^{d_{k}^{y}-d_{i}^{x}+d_{j}^{x}-d_{l}^{y}} u_{k l, x y}^{i j}, \quad \text { for all } z \in \mathbb{T} . \tag{6.8}
\end{equation*}
$$

Thus $(A, \alpha)$ is an object of $\mathfrak{C}^{*} \mathfrak{a l g}(\mathbb{T})$. Moreover, there exists a unique $\Delta_{A} \in$ $\operatorname{Mor}^{\mathbb{T}}\left(A, A \boxtimes_{\zeta} A\right)$ such that $\left(A, \alpha, \Delta_{A}\right)$ is a braided compact quantum group over $\mathbb{T}$. We denote it by $\operatorname{Aut}(D, \bar{\Pi}, \phi)$. The map $\eta: D \rightarrow D \boxtimes_{\zeta} A$, defined by

$$
\eta\left(E_{i j, x}\right)=\sum_{y=1}^{m} \sum_{r, s=1}^{n_{y}} E_{r s, y} \boxtimes_{\zeta} u_{i j, y x}^{r s}
$$

extends to a faithful $\phi$-preserving action of $\operatorname{Aut}(D, \bar{\Pi}, \phi)$ on $(D, \bar{\Pi})$.
Proof. We will essentially use the same methods as in Section 3 to prove this result. Let $\mathcal{A}$ be the ${ }^{*}$-algebra generated by the elements $u_{k l, x y}^{i j}$ satisfying (6.3)-(6.7). We identify $\operatorname{End}(D)$ with $V:=\oplus_{x, y=1}^{m} \operatorname{End}\left(\mathrm{M}_{n_{x} \times n_{y}}(\mathbb{C})\right)$ via the vector space isomorphism $E_{i j, x} \otimes E_{k l, y} \rightarrow E_{i k} \otimes E_{j l} \otimes E_{x y}$. The $\mathbb{T}$-action $\bar{\Pi}$ on $D$ induces a $\mathbb{T}$ action on $V$ defined by $E_{i k} \otimes E_{j l} \otimes E_{x y} \mapsto z^{d_{i}^{x}-d_{k}^{y}-d_{j}^{x}+d_{l}^{y}} E_{i k} \otimes E_{j l} \otimes E_{x y}$ for all $z \in \mathbb{T}$. Define $u \in V \otimes \mathcal{A}$ by

$$
u=\sum_{x, y=1}^{m} \sum_{k, l=1}^{n_{y}} \sum_{i, j=1}^{n_{x}} E_{i k} \otimes E_{j l} \otimes E_{x y} \otimes u_{k l, x y}^{i j}
$$

Using the relations (6.3)- (6.7), we can show that $u$ is unitary, and $A$ is the completion of $\mathcal{A}$ with respect to the largest $\mathrm{C}^{*}$-seminorm on $\mathcal{A}$. Similarly, we can show that $\alpha$ in (6.8) defines a continuous action of $\mathbb{T}$ on $A$, the following formulae define $\Delta_{A}$ :

$$
\begin{equation*}
\Delta_{A}\left(u_{k l, x y}^{i j}\right)=\sum_{w=1}^{m} \sum_{r, s=1}^{n_{w}} u_{r s, x w}^{i j} \boxtimes_{\zeta} u_{k l, w y}^{r s}, \quad 1 \leq i, j, k, l \leq n \tag{6.9}
\end{equation*}
$$

such that $\operatorname{Aut}(D, \bar{\Pi}, \phi)=\left(A, \alpha, \Delta_{A}\right)$ is a braided compact quantum group over $\mathbb{T}$, and $\eta$ defines a faithful $\phi$-preserving action of $\operatorname{Aut}(D, \bar{\Pi}, \phi)$ on $(D, \bar{\Pi})$.

Remark 6.10. In particular, if $m=1$ then the Theorem 6.2 above reduces to Theorem 3.4 On the other hand, if $n_{x}=1$ for $1 \leq x \leq m$, then $D \cong \mathbb{C}^{m}$ and the action $\bar{\Pi}$ is trivial. Define $a_{x y}=u_{11, x y}^{11}$ for all $1 \leq x, y \leq m$. Indeed, $A$ is generated by the entires of the matrix $u=\left(a_{x y}\right)$ and the relations (6.3)-(6.7) show that $\operatorname{Aut}(D, \bar{\Pi}, \phi)$ becomes isomorphic to the Wang's quantum permutation group of $m$ points.

Following Example 5.15, we observe that $\widetilde{D}=\left(D, \phi,\left\{D_{0}\right\} \cup\left\{D_{1, x}\right\}_{x=1}^{m}\right)$ is an orthogonal filtration for $(D, \phi)$, where $D_{0}=\operatorname{Span}\left\{1_{D}\right\}$ and $D_{1, x}=\operatorname{Span}\left\{E_{i j, x} \mid\right.$ $1 \leq i, j \leq n_{x}$ and $\left.i \neq j\right\}$. Combining it with Example (5.16) and we construct an orthogonal filtration $\widehat{D \rtimes \mathbb{Z}}$ on the crossed product $D \rtimes \mathbb{Z}$, for the action of $\mathbb{Z}$ on $D$ generated by $\bar{\Pi}_{\zeta^{-1}}$, as in Example 5.16. Then by the arguments analogous to those of Section 4 and Section 5 we have the following theorem.

Theorem 6.11. Consider the categories $\mathcal{C}^{\mathbb{T}}(D, \bar{\Pi}, \phi)$ and $\mathcal{C}(\widetilde{D \rtimes \mathbb{Z}})$. Then the following statements hold true.
(1) $\operatorname{Aut}(D, \bar{\Pi}, \phi)$ is the universal initial object of the category $\mathcal{C}^{\mathbb{T}}(D, \bar{\Pi}, \phi)$;
(2) Suppose $\left(C, \Delta_{C}\right)$ is the bosonisation of $\operatorname{Aut}(D, \bar{\Pi}, \phi)$. Then $C$ is the universal $\mathrm{C}^{*}$-algebra generated by the elements $z$ and $u_{k l, x y}^{i j}$ for $1 \leq i, j \leq$ $n_{x}, 1 \leq k, l \leq n_{y}, 1 \leq x, y \leq m$ subject to the relations $z^{*} z=z z^{*}=1$, (6.3) -(6.7), and $z u_{k l, x y}^{i j} z^{*}=\zeta^{d_{i}^{x}-d_{k}^{y}-d_{l}^{y}+d_{j}^{x}} u_{k l, x y}^{i j}$. The comultiplication map $\Delta_{C}: C \rightarrow C \otimes C$ is given by

$$
\Delta_{C}(z)=z \otimes z, \quad \Delta_{C}\left(u_{k l, x y}^{i j}\right)=\sum_{w=1}^{m} \sum_{r, s=1}^{n_{w}} u_{r s, x w}^{i j} \otimes z^{d_{r}^{w}-d_{i}^{x}+d_{j}^{x}-d_{s}^{w}} u_{k l, w y}^{r s}
$$

We denote $\left(C, \Delta_{C}\right)$ by $\operatorname{Bos}(\operatorname{Aut}(D, \bar{\Pi}, \phi))$.
(3) $\operatorname{Aut}(D, \bar{\Pi}, \phi) \rtimes \mathbb{Z}$ is the universal, initial object of the category $\mathcal{C}(\widetilde{D \rtimes \mathbb{Z}})$, that is, $\operatorname{QISO}(\widetilde{D \rtimes \mathbb{Z}}) \cong \operatorname{Bos}(\operatorname{Aut}(D, \bar{\Pi}, \phi))$.
