# Associativity of fusion products of $C_{1}$-cofinite $\mathbb{N}$-gradable modules of vertex operator algebra

#### Abstract

We prove an associative law of the fusion products $\boxtimes$ of $C_{1}$-cofinite $\mathbb{N}$-gradable modules for a vertex operator algebra $V$. To be more precise, for $C_{1}$-cofinite $\mathbb{N}$ gradable $V$-modules $A, B, C$ and their fusion products $\left(A \boxtimes B, \mathcal{Y}^{A B}\right), \quad((A \boxtimes B) \boxtimes$ $\left.C, \mathcal{Y}^{(A B) C}\right),\left(B \boxtimes C, \mathcal{Y}^{B C}\right),\left(A \boxtimes(B \boxtimes C), \mathcal{Y}^{A(B C)}\right)$ with logarithmic intertwining operators $\mathcal{Y}^{A B}, \ldots, \mathcal{Y}^{A(B C)}$ satisfying the universal properties for $\mathbb{N}$-gradable modules, we prove that four-point correlation functions $\left\langle\theta, \mathcal{Y}^{A(B C)}(v, x) \mathcal{Y}^{B C}(u, y) w\right\rangle$ and $\left\langle\theta^{\prime}, \mathcal{Y}^{(A B) C}\left(\mathcal{Y}^{A B}(v, x-y) u, y\right) w\right\rangle$ are locally normally convergent over $\left\{(x, y) \in \mathbb{C}^{2} \mid\right.$ $0<|x-y|<|y|<|x|\}$. We then take their respective principal branches $$
\widetilde{F}\left(\left\langle\theta, \mathcal{Y}^{A(B C)}(v, x) \mathcal{Y}^{B C}(u, y) w\right\rangle\right) \text { and } \widetilde{F}\left(\left\langle\theta, \mathcal{Y}^{(A B) C}\left(\mathcal{Y}^{A B)}(v, x-y) u, y\right) w\right\rangle\right)
$$ on $\mathcal{D}^{2}=\left\{(x, y) \in \mathbb{C}^{2}|0<|x-y|<|y|<|x|\right.$, and $x, y, x-y \notin \mathbb{R} \leq 0\}$ and then show that there is an isomorphism $\phi_{[A B] C}:(A \boxtimes B) \boxtimes C \rightarrow A \boxtimes(B \boxtimes C)$ such that

on $\mathcal{D}^{2}$ for $\theta \in(A \boxtimes(B \boxtimes C))^{\vee}, v \in A, u \in B$, and $w \in C$, where $W^{\vee}$ denotes the contragredient module of $W$ and $\phi_{[A B] C}^{*}$ denotes the dual of $\phi_{[A B] C}$. We also prove the pentagon identity.

## 1 Introduction

As a counterpart of a tensor product of two modules in the VOA theory, Huang and Lepowsky [4] have introduced a concept of fusion products $\boxtimes_{p(x)}$. Huang [3] has also shown that four-point correlation functions for three $C_{1}$-cofinite $\mathbb{N}$-gradable modules satisfy differential equations with regular singularity and then as an application, he has proved an associative law of fusion products under some conditions, where a $V$-module $W$ is called to be " $C_{1}$-cofinite" if $\operatorname{dim} V / C_{1}(W)<\infty$ for $C_{1}(W):=\operatorname{span}_{\mathbb{C}}\left\{\alpha_{-1} w \in W \mid\right.$ $w \in W, \alpha \in V, \operatorname{wt}(\alpha) \geq 1\}$ and a $V$-module $W$ is called $\mathbb{N}$-gradable if $W$ has a decomposition $W=\oplus_{m \in \mathbb{N}} W_{(m)}$ satisfying $\alpha_{k} W_{(m)} \subseteq W_{(m+\mathrm{wt}(\alpha)-k-1)}$ for $\alpha \in V$ and $k \in \mathbb{Z}$. From now on, $\mathcal{N C}_{1}$ denotes the set of all $C_{1}$-cofinite $\mathbb{N}$-gradable $V$-modules. Before we explain our results, let us show basic knowledge for $C_{1}$-cofinite $\mathbb{N}$-gradable modules. If

[^0]$W=\oplus_{m \in \mathbb{N}} W_{(m)} \in \mathcal{N C}_{1}$ is indecomposable, then as we will show in $\S 2$, $\operatorname{dim} W_{(m)}<\infty$ for all $m$ and there is $d=d(W) \in \mathbb{C}$ such that $W=\oplus_{m \in \mathbb{N}} W_{d+m}$ with $W_{d} \neq 0$ and $\operatorname{dim} W_{d+m}<\infty$, where $W_{s}$ denotes a generalized eigenspace of $L(0)$ with eigenvalue $s$. In particular, $W^{\vee}=\oplus_{m \in \mathbb{N}} \operatorname{Hom}\left(W_{(m)}, \mathbb{C}\right) \cong \oplus_{d \in \mathbb{C}} \operatorname{Hom}\left(W_{d}, \mathbb{C}\right)$. An element $w \in W_{s}$ is called homogeneous and denoted by $\operatorname{wt}(w)=s$. Clearly, $W_{(m)}=W_{d+m}$ defines an $\mathbb{N}$-grading on $W$. We always choose this grading for indecomposable modules $A, B, C$ which come out later. We write $\operatorname{gr}(w)=m$ for $w \in W_{(m)}$ and call it the grade of $w$.

For $A, B \in \mathcal{N C}_{1}$, as the author has shown in [6], a pair $\left(A \boxtimes B, \mathcal{Y}^{A B}\right)$ of a $V$-module $A \boxtimes$ $B$ and a logarithmic intertwining operator $\mathcal{Y}^{A B} \in I\binom{A \boxtimes B}{A B}$ satisfying the universal property for $\mathbb{N}$-gradable modules (see $\S 2$ ) is always uniquely well-defined up to isomorphism and $A \boxtimes$ $B$ is also in $\mathcal{N C}_{1}$ and $\mathcal{Y}^{A B}$ is also a logarithmic intertwining operator. Let $A, B, C \in \mathcal{N C}_{1}$ and assume to be $\mathbb{N}$-graded. Since $A \boxtimes B, B \boxtimes C \in \mathcal{N C}_{1}$, we also have $\left((A \boxtimes B) \boxtimes C, \mathcal{Y}^{(A B) C}\right)$ and $\left(A \boxtimes(B \boxtimes C), \mathcal{Y}^{A(B C)}\right)$ and we denote these logarithmic intertwining operators by

\mathcal{Y}^{(A B) C}(\delta, y) & =\sum_{k=0}^{K_{4}} \mathcal{Y}_{h}^{(A B) C}(\delta, y) \log ^{h}(y),
\end{array}

for $v \in A, u \in B, \delta \in A \boxtimes B$ with formal $\mathbb{C}$-power series $\mathcal{Y}_{h}^{A(B C)}(v, x)$ of $x$ with coefficients in $\operatorname{Hom}(B \boxtimes C, A \boxtimes(B \boxtimes C))$, etc. To simplify the notation, we use notation $K^{2}=$ $\left\{(h, k) \in \mathbb{N}^{2} \mid h \leq K_{1}, k \leq K_{2}\right\}, K^{\prime 2}=\left\{(h, k) \in \mathbb{N}^{2} \mid h \leq K_{3}, k \leq K_{4}\right\}$ and we often denote $A \boxtimes(B \boxtimes C)$ and $(A \boxtimes B) \boxtimes C$ by $A(B C)$ and $(A B) C$, respectively. Then for $\theta \in(A(B C))^{\vee}, \theta^{\prime} \in((A B) C)^{\vee}$, we define two four-point correlation functions and the coefficients of $\log ^{h}(x) \log ^{k}(y)$ and $\log ^{h}(x-y) \log ^{k}(y)$ in them as follows:

F_{h, k}^{(A B) C}\left(\theta^{\prime}, v, u, w ; x-y, y\right) & :=\left\langle\theta^{\prime}, \mathcal{Y}_{h}^{(A B) C}\left(\mathcal{Y}_{k}^{A B}(v, x-y) u, y\right) w\right\rangle .

Set $\Omega=(A(B C))^{\vee} \times A \times B \times C$ (and $\left.\Omega^{\prime}=((A B) C)^{\vee} \times A \times B \times C\right)$. We use $\vec{\xi}$ (and $\vec{\xi}^{\prime}$ ) to denote a quadruple $(\theta, v, u, w) \in \Omega$ (and $\left.\left(\theta^{\prime}, v, u, w\right) \in \Omega^{\prime}\right)$ so that $F_{h, k}^{A(B C)}(\vec{\xi} ; x, y)$ denotes $F_{h, k}^{A(B C)}(\theta, v, u, w ; x, y)$ and so on. For $\alpha \in V$, we use notation $\alpha_{n}^{[i]}$ to denote the action of $\alpha_{n}$ on the $i$-th coordinate of $\Omega$, e.g. $\alpha_{n}^{[2]} \vec{\xi}=\left(\theta, \alpha_{n} v, u, w\right)$. For $\vec{\xi}=(\theta, v, u, w) \in \Omega$, define $\operatorname{gr}^{234}(\vec{\xi})=\operatorname{gr}(v)+\operatorname{gr}(u)+\operatorname{gr}(w)$ and the total grade $\operatorname{gr}(\vec{\xi})=\operatorname{gr}(\theta)+\operatorname{gr}^{234}(\vec{\xi})$.

The main purpose in this paper is to show the associative law of fusion products (Theorem 4.1) for $A, B, C \in \mathcal{N C}_{1}$. We may assume that $A, B, C$ are indecomposable. As a proof, we will construct a surjective homomorphism $\phi_{[A B] C}:(A \boxtimes B) \boxtimes C \rightarrow A \boxtimes(B \boxtimes C)$ by starting from $F^{A(B C)}(\vec{\xi} ; x, y)$. The reverse homomorphism is given by starting from $F^{(A B) C}\left(\vec{\xi}^{\prime} ; x, y\right)$ with the similar argument. Our proofs are based on Huang's ideas in [3]. The differences from [3] are that we will treat formal $\mathbb{C}$-power series $F_{h, k}^{A(B C)}(\vec{\xi} ; x, y)$ and show that their modified versions satisfy two Fuchsian systems on discs by fixing one variable $y=y_{0} \notin \mathbb{R}^{\leq 0}$ or $x=x_{0} \notin \mathbb{R}^{\leq 0}$. Furthermore, in order to expand $F^{A(B C)}\left(\vec{\xi} ; x, y_{0}\right)$ in a $\mathbb{C}$-formal power series of $\left(x-y_{0}\right)$ with logarithm functions $\log ^{h}\left(x-y_{0}\right)$ as a component
of a solution of Fuchsian system, we restrict the variable $x$ into a domain $\mathcal{D}_{\left(x, y_{0}\right)}^{2}=\{x \in \mathbb{C} \mid$ $0<\left|x-y_{0}\right|<\left|y_{0}\right|<|x|$, and $\left.x, y_{0}, x-y_{0} \notin \mathbb{R}^{\leq 0}\right\}$ and take a principal branch $\widetilde{F}^{A(B C)}\left(\vec{\xi} ; x, y_{0}\right)$ of $F^{A(B C)}\left(\vec{\xi} ; x, y_{0}\right)$. A key result we get from our Fuchsian system is that there is a finite set $\Delta \subseteq \mathbb{C}$ such that the powers of $\left(x-y_{0}\right)$ in these expansions are all in $\Delta-\operatorname{gr}(v)-\operatorname{gr}(u)+\mathbb{N}$ for any $\vec{\xi}$, which supports an existence of an $\mathbb{N}$-gradable $V$-module isomorphic to $A \boxtimes B$.

In order to get Fuchsian systems, we consider finite spaces. Let $P_{W}$ denote a complement of $C_{1}(W)$ in $W$ and let $\tilde{P}_{W}$ be a finite dimensional subspace of $W$ containing $P_{W}$ and spanned by homogeneous elements. For $N \in \mathbb{N}$, we define $W_{(\leq N)}^{\vee}=\oplus_{m=0}^{N} \operatorname{Hom}\left(W_{(m)}, \mathbb{C}\right)$ and set $\Omega_{N}=\left\{(\theta, v, u, w) \in(A(B C))_{(\leq N)}^{\vee} \times A \times B \times C\right\}$. Choose bases $J_{\tilde{P}_{A}}=\left\{v^{i} \mid\right.$ $\left.i \in \mathcal{P}_{A}\right\}, J_{\tilde{P}_{B}}=\left\{u^{j} \mid j \in \mathcal{P}_{B}\right\}, J_{\tilde{P}_{C}}=\left\{w^{q} \mid q \in \mathcal{P}_{C}\right\}, J_{N}=\left\{\theta^{p} \mid p \in \mathcal{P}_{N}\right\}$, of $\tilde{P}_{A}, \tilde{P}_{B}, \tilde{P}_{C},(A(B C))_{(\leq N)}^{\vee}$ consisting of homogeneous elements and define $\mathcal{J}_{N, \tilde{P}_{A}, \tilde{P}_{B}, \tilde{P}_{C}}=$ $J_{N} \times J_{\tilde{P}_{A}} \times J_{\tilde{P}_{B}} \times J_{\tilde{P}_{C}}$, which is a finite set. We simply denote it by $\mathcal{J}_{N}$ and denote $\mathcal{J}_{N, P_{A}, P_{B}, P_{C}}$ by $\mathcal{J}_{N}^{0}$. We always assume $\mathcal{J}_{N}^{0} \subseteq \mathcal{J}_{N}$. We similarly define $\Omega_{N}^{\prime}$ and finite sets $\mathcal{J}_{N}^{\prime}$ and $\mathcal{J}^{\prime}{ }_{N}^{\prime 0}$ for $((A B) C)^{\vee}$. Set

Then we will obtain the following reduction theorem.
Theorem 3.1 for $G^{A(B C)} \quad$ For $\vec{\xi}=(\theta, v, u, w) \in \Omega_{N}, \alpha \in V$, and $x_{0} \neq 0 \neq y_{0}$, (1) $G_{h, k}^{A(B C): y}\left(\vec{\xi} ; x_{0}, y\right)$ is a linear combination of $\left\{G_{h, k}^{A(B C): y}\left(\vec{\mu} ; x_{0}, y\right) \mid \vec{\mu} \in \mathcal{J}_{N}^{0}\right\}$ with coefficients in $\mathbb{C}\left[\iota_{x_{0}, y}\left\{\left(x_{0}-y\right)^{-1}\right\}\right][y] \subseteq \mathbb{C}[[y]]$ and
(2) $G_{h, k}^{A(B C): x-y}\left(\vec{\xi} ; x, y_{0}\right)$ is a linear combination of $\left\{G_{h, k}^{A(B C): x-y}\left(\vec{\mu} ; x, y_{0}\right) \mid \vec{\mu} \in \mathcal{J}_{N}^{0}\right\}$ with coefficients in $\mathbb{C}\left[x, \iota_{y_{0}, x-y_{0}}\left\{x^{-1}\right\}\right]\left[x-y_{0}\right] \subseteq \mathbb{C}\left[\left[x-y_{0}\right]\right]$.
Furthermore, for the residue classes of coefficients modulo $\mathbb{C}\left[\left[x-y_{0}\right]\right]\left(x-y_{0}\right)$, we have:

Using $L(-1)$-derivative properties: $F^{A(B C)}\left(L(-1)^{[3]} \vec{\xi} ; x, y\right)=\frac{\partial}{\partial y} F^{A(B C)}(\vec{\xi} ; x, y)$ and $F^{A(B C)}\left(L(-1)^{[2]} \vec{\xi} ; x, y\right)=\frac{\partial}{\partial x} F^{A(B C)}(\vec{\xi} ; x, y)$, we will show that there are $\lambda_{\vec{\mu}, p, q}^{34, \vec{\xi}, h, k}\left(x_{0}, y\right) \in$ $\mathbb{C}\left[\iota_{x_{0}, y}\left\{\left(x_{0}-y\right)^{-1}\right\}\right][y]$ and $\lambda_{\vec{\mu}, p, q}^{23, \vec{\xi}, h, k}\left(x, y_{0}\right) \in \mathbb{C}\left[x, \iota_{y_{0}, x-y_{0}}\left\{x^{-1}\right\}\right]\left[x-y_{0}\right]$ such that

as formal $\mathbb{C}$-power series. Set $r=\left|\mathcal{J}_{N}\right|\left|K^{2}\right|$ and define matrix-valued functions $\Lambda^{23}\left(x, y_{0}\right)=\left(\lambda_{\vec{\mu}, p, q}^{23, \vec{\xi}, h, k}\left(x, y_{0}\right)\right)_{(\vec{\xi}, h, k),(\vec{\mu}, p, q) \in \mathcal{J}_{N} \times K^{2}} \in M_{r \times r}\left(\mathcal{O}\left(\mathbb{D}_{\left|y_{0}\right|}\left(y_{0}\right)\right)\right)$ and
$\Lambda^{34}\left(x_{0}, y\right)=\left(\lambda_{\vec{\mu}, p, q}^{34, \vec{\xi}, h, k}\left(x_{0}, y\right)\right)_{(\vec{\xi}, h, k),\left(\vec{\mu}, p, q \notin \mathcal{J}_{N} \times K^{2}\right.} \in M_{r \times r}\left(\mathcal{O}\left(\mathbb{D}_{\left|x_{0}\right|}(0)\right)\right)$. Here and hereafter
$\mathbb{D}_{R}\left(z_{0}\right)=\left\{z \in \mathbb{C}| | z-z_{0} \mid<R\right\}$ and $\mathcal{O}(U)$ denotes the set of holomorphic functions on $U$. We note $\lambda_{\vec{\mu}, p, q}^{23, \vec{\xi}, h, k}=0=\lambda_{\vec{\mu}, p, q}^{34, \vec{\xi}, h, k}$ if $\vec{\mu} \notin \mathcal{J}_{N}^{0}$. Then we get:

Theorem 3.2 [Differential systems] Fix $x_{0} \neq 0$ and $N \in \mathbb{N}$. Then a vector valued function $G^{y}\left(x_{0}, y\right):=\left(G_{h, k}^{A(B C): y}\left(\vec{\xi} ; x_{0}, y\right)\right)_{\vec{\xi} \in \mathcal{J}_{N},(h, k) \in K^{2}}$ satisfies a Fuchsian system

over $\mathbb{D}_{\left|x_{0}\right|}(0)$ with polar locus $\{0\}$. Similarly, for a fixed $0 \neq y_{0} \in \mathbb{C}$ and $N \in \mathbb{N}$, a vector valued function $G^{x-y}\left(x, y_{0}\right):=\left(G_{h, k}^{A(B C): x-y}\left(\vec{\xi} ; x, y_{0}\right)\right)_{\vec{\xi} \in \mathcal{J}_{N},(h, k) \in K^{2}}$ satisfies a Fuchsian system

\frac{d}{d x} G^{x-y}\left(x, y_{0}\right)=\frac{\Lambda^{23}\left(x, y_{0}\right)}{x-y_{0}} G^{x-y}\left(x, y_{0}\right) \tag{D2}
\end{equation*}
$$

over $\mathbb{D}_{\left|y_{0}\right|}\left(y_{0}\right)$ with polar locus $\left\{y_{0}\right\}$. Furthermore, the sets of nonzero eigenvalues (without multiplicities) of the constant matrices $\Lambda^{34}\left(x_{0}, 0\right)$ of $(D 1)$ and $\Lambda^{23}\left(y_{0}, y_{0}\right)$ of (D2) are determined by only the choices of the bases $J_{P_{A}}$ and $J_{P_{B}}$ of $P_{A}$ and $P_{B}$.

We also have similar results for $\bar{G}^{y}\left(x_{0}, y\right)=\left(G_{h, k}^{(A B) C: y}\left(\vec{\xi}^{\prime} ; x_{0}, y\right)\right)_{\vec{\xi}^{\prime} \in \mathcal{J}_{N}^{\prime},(h, k) \in K^{\prime 2}}$ and $\bar{G}^{x-y}\left(x, y_{0}\right)=\left(G_{h, k}^{(A B) C: x-y}\left(\vec{\xi}^{\prime}, x, y_{0}\right)\right)_{\vec{\xi}^{\prime} \in \mathcal{J}_{N}^{\prime},(h, k) \in K^{\prime 2}}$.

As a corollary of $(D 1)$ for $G^{A(B C)}$ and $(D 2)$ for $G^{(A B) C}$, we will obtain the following:
Corollary 3.3 $F_{h, k}^{A(B C)}(\vec{\xi} ; x, y)$ and $F_{h, k}^{(A B) C}(\vec{\xi} ; x-y, y)$ are locally normally convergent on $\left\{(x, y) \in \mathbb{C}^{2}|0<|y|<|x|\}\right.$ and $\left\{(x, y) \in \mathbb{C}^{2}|0<|x-y|<|y|\}\right.$, respectively.

Set $\mathcal{D}^{2}=\left\{(x, y) \in \mathbb{C}^{2}\left|0<|x-y|<|y|<|x|\right.\right.$ and $\left.x, y, x-y \notin \mathbb{R}^{\leq 0}\right\}$. Let $y_{0} \notin \mathbb{R}^{\leq 0}$ and we take a principal branch $\widetilde{G}_{h, k}^{A(B C): x-y}\left(\vec{\xi} ; x, y_{0}\right)$ of $G_{h, k}^{A(B C): x-y}\left(\vec{\xi} ; x, y_{0}\right)$ on a small domain $\mathcal{D}_{\left(x, y_{0}\right)}^{2}=\left\{x \in \mathbb{C} \mid\left(x, y_{0}\right) \in \mathcal{D}^{2}\right\}$. As we will explain in Proposition 2.9 in $\S 2$, there is a finite subset $\Delta^{\prime}=\left\{d_{1}, \ldots, d_{p}\right\} \subseteq \mathbb{C}$ which depends only on the choice of $J_{P_{A}}$ and $J_{P_{B}}$ such that all components of solutions of the Fuchsian system (D2) with polar locus $\left\{y_{0}\right\}$ are written as

$$
\sum_{d \in \Delta^{\prime}} \sum_{m \in \mathbb{N}} \sum_{t=0}^{K} r_{d+m, t}\left(x-y_{0}\right)^{d+m} \log ^{t}\left(x-y_{0}\right)
$$

with $r_{d+m, t} \in \mathbb{C}$ at $\mathbb{D}_{\left|y_{0}\right|}\left(y_{0}\right)=\left\{x \in \mathbb{C}\left|0<\left|x-y_{0}\right|<\left|y_{0}\right|\right\}\right.$. Since this is true for every $y=y_{0} \notin \mathbb{R}^{\leq 0}$ and $\vec{\xi}$, there is $r_{d+m, t}^{h, k}(\vec{\xi}, y) \in \mathbb{C}$ and $K(\vec{\xi}) \in \mathbb{N}$ such that

$$
\widetilde{G}_{h, k}^{A(B C): x-y}(\vec{\xi} ; x, y)=\sum_{d \in \Delta^{\prime}} \sum_{m \in \mathbb{N}} \sum_{t=0}^{K(\vec{\xi})} r_{d+m, t}^{h, k}(\vec{\xi}, y)(x-y)^{d+m} \log ^{t}(x-y)
$$

Multiplying it by $(x-y)^{-\operatorname{gr}^{234}(\xi)} \log ^{h}(x) \log ^{k}(y)$ for $h, k$ and taking a sum of them and replacing $\log (x)$ by $\sum_{j=0}^{\infty} \frac{(-1)^{j}}{j+1}\left(\frac{x-y}{y}\right)^{j+1}+\log (y)$, we obtain an expansion of a principal branch
$\widetilde{F}\left(\left\langle\theta, \mathcal{Y}^{A(B C)}(v, x) \mathcal{Y}^{B C}(u, y) w\right\rangle\right)$ of $F^{A(B C)}(\vec{\xi} ; x, y)$ on $\mathcal{D}^{2}$. We denote it by $\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)$. Since $\operatorname{dim} P_{C}<\infty$, setting $\Delta=\Delta^{\prime}!-\max \left\{\operatorname{gr}(w) \mid w \in P_{C}\right\}$, we can write

$$
\begin{equation*}
\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\sum_{t=0}^{K(\vec{\xi})} \sum_{-s-1 \in \Delta+\mathbb{N}-\operatorname{gr}(v)-\operatorname{gr}(u)} g_{s, t}(\vec{\xi} ; y)(x-y)^{-s-1} \log ^{t}(x-y) \tag{4.5}
\end{equation*}
$$

for $\vec{\xi}=(\theta, v, u, w) \in \Omega$ with $w \in P_{C}$ on $\mathcal{D}^{2}$. Although our argument is depending on the choice $\mathcal{J}_{N}$, we will show that (4.5) holds for every $\vec{\xi} \in \Omega$ with the same $\Delta$.

Since $g_{s, t}(\vec{\xi} ; y)$ is multi-linear on $\vec{\xi} \in(A(B C))^{\vee} \times A \times B \times C$, we will view it as a map $A \times B \rightarrow \operatorname{Hom}(C, A(B C)) \otimes \mathcal{O}\left(\mathbb{C} \backslash \mathbb{R}^{\leq 0}\right)$, in other words, using formal operators $\mathcal{Y}^{3}$ and $\mathcal{Y}^{4}$, we can rewrite RHS of (4.5) into $\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle$ such that

$$
\begin{equation*}
\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle \tag{4.9}
\end{equation*}
$$

on $\mathcal{D}^{2}$ for $\vec{\xi} \in \Omega$. In $\S 4$, using these notation, we will prove that $\mathcal{Y}^{3}$ and $\mathcal{Y}^{4}$ are logarithmic surjective intertwining operators, which implies the existence of surjective homomorphism $(A \boxtimes B) \boxtimes C \rightarrow A \boxtimes(B \boxtimes C)$ and then we will get the main theorem (Theorem 4.1).

We will also prove another axiom of monoidal category called pentagon axiom in $\S 5$.

## 2 Notation and preliminary results

### 2.1 Differential systems

We quote the following statements from [2]. For the proofs, see [2]. See also [5].
Definition 2.1 A meromorphic system of linear differential equations is a differential equation of the form $\frac{d}{d z} Y=A Y$, where $A \in M_{r \times r}(\mathcal{M}(U))$ is a square matrix whose coefficients are meromorphic functions over some complex domain $U \subseteq \mathbb{C}$ (open, nonempty).

- A singularity of such a meromorphic system is a point in $U$ corresponding to a pole of (at least one of the coefficients of) $A$.
- For technical reasons, one usually fixes a discrete subset $\Sigma \subseteq U$, and speaks of meromorphic systems $\frac{d}{d z} Y=A Y$ over $U$ with polar locus $\Sigma$ if the "true polar locus" (i.e., the set of poles of $A$ ) is contained in $\Sigma$.
- A meromorphic system $\frac{d}{d z} Y=\frac{A}{z-z_{0}} Y$ with a holomorphic matrix function $A$ of size $r \times r$ defined on $U$ is called a Fuchsian system and its singularity at $z=z_{0}$ is called a Fuchsian singularity.

Definition 2.2 Let $\frac{d}{d z} Y=A Y$ be a meromorphic system of rank $r$ over $U \subseteq \mathbb{C}$. Let $U^{\prime} \subseteq U$ be open. A fundamental solution of $\frac{d}{d z} Y=A Y$ over $U^{\prime}$ is a matrix-valued meromorphic function $\Phi \in M_{r \times r}\left(\mathcal{M}\left(U^{\prime}\right)\right)$ such that

$$
\frac{d}{d z} \Phi(z)=A(z) \Phi(z) \quad \forall z \in U^{\prime}
$$

and moreover

$$
\operatorname{det}(\Phi)(z) \neq 0 \quad \forall z \in U^{\prime}
$$

From now on, let $z_{0} \in U$ and let $A=\sum_{k \geq 0}\left(z-z_{0}\right)^{k} A_{k}$ with $A_{k} \in M_{r \times r}(\mathbb{C})$ and we will consider

$$
\begin{equation*}
\frac{d}{d z} Y=\frac{A}{z-z_{0}} Y \tag{2.1}
\end{equation*}
$$

which we will call Fuchsian system. Set $\mathbb{D}_{R}\left(z_{0}\right)=\left\{z \in \mathbb{C}| | z-z_{0} \mid<R\right\}$. If $A=A_{0} \in$ $M_{r \times r}(\mathbb{C})$ and $z_{0} \in U$, then

$$
\begin{equation*}
\frac{d}{d z} Y=\frac{A_{0}}{z-z_{0}} Y \tag{2.2}
\end{equation*}
$$

is called Euler system. In this case, there is $G \in G L_{r}(\mathbb{C})$ such that $G A_{0} G^{-1}$ has a Jordan standard form and $\frac{d}{d z}(G Y)=G \frac{d}{d z} Y=\frac{G A_{0} G^{-1}}{z-z_{0}}(G Y)$.

Lemma 2.3 If an Euler system (2.2) has a Jordan cell $A_{0}=J_{r}(a)$, that is, $Y=$ ${ }^{t}\left(f_{1}, \ldots, f_{r}\right)$ satisfies $\left(z-z_{0}\right) \frac{d}{d z} f_{i}=a f_{i}+f_{i+1}$ for $i=1, \ldots, r$ with $f_{r+1}=0$, then $\Phi=\left\{\left(z-z_{0}\right)^{a} \times{ }^{t}\left(\log ^{s}\left(z-z_{0}\right), \ldots, \log \left(z-z_{0}\right), 1,0, \cdots, 0\right) \mid s=0, \ldots, r-1\right\}$ is a fundamental solution, where ${ }^{t}(\cdots)$ denotes the transpose of $(\cdots)$.

Therefore, in generally, all components of solutions of Euler system (2.2) are written as

$$
\begin{equation*}
f(z)=\sum_{i=1}^{r} \sum_{t=0}^{r} r_{i, t}\left(z-z_{0}\right)^{d_{i}} \log ^{t}\left(z-z_{0}\right) \tag{2.3}
\end{equation*}
$$

with $r_{i, t} \in \mathbb{C}$ and eigenvalues $d_{i}$ of $A_{0}$. We also note that if $\frac{d}{d z} Y=\frac{A}{z-z_{0}} Y$, then

$$
\begin{equation*}
\frac{d}{d z}\left(\left(z-z_{0}\right)^{d} Y\right)=\frac{\left(A+d E_{r}\right)}{z-z_{0}}\left(\left(z-z_{0}\right)^{d} Y\right) \tag{2.4}
\end{equation*}
$$

where $E_{r}$ is the identity matrix of size $r$.

Definition 2.4 Let $\frac{d}{d z} Y=A Y$ be a meromorphic system over $U$ with polar locus $\Sigma$.

- A holomorphic gauge transformation over $U^{\prime} \subseteq U$ is the change of variable $Y=\Delta Z$, yielding a meromorphic system $\frac{d}{d z} Z=B Z$ over $U^{\prime}$ with polar locus $\Sigma \cap U^{\prime}$, where $\Delta \in G L_{r}\left(\mathcal{O}\left(U^{\prime}\right)\right)$, i.e. $\Delta$ is a holomorphic matrix function over $U^{\prime}$ with non-vanishing determinant.
- A meromorphic gauge transformation over $U^{\prime} \subseteq U$ is the change of variable $Y=\Delta Z$, yielding a meromorphic system $\frac{d}{d z} Z=B Z$ over $U^{\prime}$ with polar locus $Z \cap U^{\prime}$, where $\Delta \in G L_{r}\left(\mathcal{M}\left(U^{\prime}\right)\right)$, i.e. $\Delta$ is a meromorphic matrix function over $U^{\prime}$ whose determinant is not identically zero on any connected component of $U^{\prime}$, such that moreover, $\left.\Delta\right|_{U^{\prime} \backslash \Sigma} \in M_{r \times r}\left(\mathcal{O}\left(U^{\prime} \backslash \Sigma\right)\right)$ and $\left.\Delta^{-1}\right|_{U^{\prime} \backslash \Sigma} \in M_{r \times r}\left(\mathcal{O}\left(U^{\prime} \backslash \Sigma\right)\right)$.
- As usual, two meromorphic systems over $U$ with polar locus $\Sigma$ are said to be holomorphically (resp. meromorphically) gauge equivalent, if they are related via a global holomorphic (resp. meromorphic) gauge transformation.

Definition 2.5 (Definition 3.6 in [2]) A Fuchsian system $\frac{d}{d z} Y=\frac{B}{z} Y$ of rank $r$ over $\mathbb{D}$, with polar locus $\{0\}$, is said to be of Levelt normal form if $B=\sum_{k \geq 0} B_{k} z^{k}$ such that for any $k \in \mathbb{N}$, the matrix $B_{k} \in M_{r, r}(\mathbb{C})$ satisfies ad $\left(B_{0, s}\right)\left(B_{k}\right)=k B_{k}$, where $B_{0}=B_{0, s}+B_{0, n}$ is the Dunford decomposition of $B_{0}$ into semisimple part $B_{0, s}$ and nilpotent part $B_{0, n}$ with $B_{0, s} B_{0, n}=B_{0, n} B_{0, s}$.

Lemma 2.6 The eigenvalues of $B(1)=\sum_{k=0}^{\infty} B_{k}$ are equal to the eigenvalues of $B_{0}$.
[Proof] We may assume that $B_{0, s}$ is a diagonal matrix $\left(\lambda_{1}, \ldots, \lambda_{r}\right)$ and $B_{0, n}$ is an upper triangular matrix. Furthermore, we may assume $\Re\left(\lambda_{1}\right) \geq \cdots \geq \Re\left(\lambda_{r}\right)$. Then since $\operatorname{ad}\left(B_{0, s}\right) E_{i, j}=\left(\lambda_{i}-\lambda_{j}\right) E_{i, j}, \operatorname{ad}\left(B_{0, s}\right) B_{k}=k B_{k}$ means that $B_{k}$ are strictly upper triangular and $B(1)=\sum_{k=0}^{\infty} B_{k}$ is an upper triangular matrix with diagonal entries $\left\{\lambda_{1}, \ldots, \lambda_{r}\right\}$.

Theorem 2.7 (Theorem 3.8 in [2]) Let $\frac{d}{d z} Y=\frac{A}{z} Y$ be a Fuchsian system over $\mathbb{D}$. This system is holomorphically gauge equivalent to some Fuchsian system $\frac{d}{d z} \widehat{Y}=\frac{B}{z} \widehat{Y}$ of Levelt normal form over $\mathbb{D}$.

Remark 2.1 Under the setting of Theorem 2.7, the set of eigenvalues of $B(0)$ coincides with the set of eigenvalues of $A(0)$ counted with multiplicity.

Theorem 2.8 (Lemma 3.7 in [2]) Let $B_{0, s} \in M_{r \times r}(\mathbb{C})$ be semisimple. Then there exists the unique semisimple matrix $L$ such that $L$ commutes with $B_{0, s}$ and has only integer eigenvalues and any eigenvalues $\mu$ of $B_{0, s}-L$ satisfies $\Re(\mu) \in[0,1[$. Moreover, if $\frac{d}{d z} Y=\frac{B}{z} Y$ is a Fuchsian system of Level normal form with $B(0)=B_{0, s}+B_{0, n}$ as above, then $B=z^{L} B(1) z^{-L}$.

Remark 2.2 As mentioned in the proof of Corollary 3.9 in [2], under the assumption in Theorem 2.8, $\tilde{Y}:=z^{-L} Y$ satisfies an Euler system $\frac{d}{d z} \tilde{Y}=\frac{B(1)-L}{z} \tilde{Y}$.

Using the these results, we get the following result.
Proposition 2.9 Let $\frac{d}{d z} Z=\frac{B}{z} Z$ be a Fuchsian system with $B \in M_{r \times r}(\mathcal{O}(U))$ and let $\left\{d_{1}, \cdots, d_{r}\right\}$ be the set of eigenvalues of the constant matrix $B_{0}$. Choose $\ell_{i} \in \mathbb{Z}$ so that $0 \leq d_{i}-\ell_{i}<1$. Then all components of solutions of $\frac{d}{d z} Z=\frac{B}{z} Z$ are written as

$$
\begin{equation*}
\sum_{j=1}^{r} \sum_{i=1}^{r} \sum_{m \in \mathbb{N}} \sum_{t=0}^{r} r_{i, m, t}^{j} z^{d_{j}-\ell_{j}+\ell_{i}+m} \log ^{t}(z) \tag{2.5}
\end{equation*}
$$

with $r_{i, m, t}^{j} \in \mathbb{C}$.
[Proof] If $\frac{d}{d z} Z=\frac{A}{z} Z$ and $\frac{d}{d z} Y=\frac{B}{z} Y$ are holomorphically equivalent, then all components of solutions of one are linear combinations of components of solutions of the other with coefficients in $\mathbb{C}[[z]]$ and so if all components of solutions of $\frac{d}{d z} Z=\frac{A}{z} Z$ satisfy (2.5), then those of solutions of $\frac{d}{d z} Y=\frac{B}{z} Y$ also satisfy (2.5). Therefore, we may assume that $\frac{d}{d z} Z=\frac{B}{z} Z$ is a Fuchsian system of Levelt normal form over $\mathbb{D}$ by Theorem 2.7. Furthermore we may assume that $B_{0, s}=\operatorname{diag}\left(d_{1}, \ldots, d_{r}\right)$ satisfying $\Re\left(d_{1}\right) \geq$ $\cdots \geq \Re\left(d_{r}\right)$ and $B_{0, n}$ is an upper triangular matrix. In this case, $L$ in Theorem 2.8
is a diagonal matrix $\operatorname{diag}\left(\ell_{1}, \ldots, \ell_{r}\right)$. Then by Theorem 2.8 and Remark 2.1, we have $B=z^{L} B(1) z^{-L}$ and $\tilde{Y}:=z^{-L} Y$ satisfies an Euler system $\frac{d}{d z} \tilde{Y}=\frac{B(1)-L}{z} \tilde{Y}$. By Lemma 2.6, $B(1)$ is an upper triangular matrix with diagonal entries $\left\{d_{1}, \ldots, d_{r}\right\}$ and the eigenvalues of $B(1)-L$ are $d_{1}-\ell_{1}, \ldots, d_{r}-\ell_{r}$. Hence all components of a solution $\tilde{Y}$ are written as $\sum_{j=1}^{r} \sum_{t \in \mathbb{N}} r_{t}^{j} z^{d_{j}-\ell_{j}} \log ^{t}(z)$ by Lemma 2.3. In this case, since $Y=z^{L} \tilde{Y}$, all components of solutions of $\frac{d}{d z} Y=\frac{B}{z} Y$ are written as $\sum_{i, j=1}^{r} \sum_{t \in \mathbb{N}} r_{i, t}^{j} z^{d_{j}-\ell_{j}+\ell_{i}} \log ^{t}(z)$, as we desired.

Regarding the radius of convergence of such a solution, we quote the following theorem.
Theorem 2.10 (Theorem 1.6 [2]) Let $A=\sum_{k \in \mathbb{N}} A_{k}\left(z-z_{0}\right)^{k}$ with $A_{k} \in M_{r \times r}(\mathbb{C})$ be a matrix power series with radius of convergence $R>0$. Let $Y=\sum_{k=0}^{\infty} Y_{k}\left(z-z_{0}\right)^{k}$ with $Y_{k} \in M_{r \times r}(\mathbb{C})$ be a formal power series satisfying $\frac{d}{d z} Y=\frac{A}{z-z_{0}} Y$. Then the radius of convergence of $Y$ is at least $R$.

### 2.2 Intertwining operators among $C_{1}$-cofinite modules

Let $A, B, C$ be $V$-modules. Let $I\binom{C}{A}$ denote the set of logarithmic intertwining operators of type $\binom{C}{A B}$. We introduce a generalized concept of (logarithmic) intertwining operators. For a nonempty domain $U \subseteq \mathbb{C} \backslash\{0\}$, we define a local intertwining operator $\mathcal{Y}$ of type $\binom{C}{A B}$ on $U$ as a linear map $A \otimes B \rightarrow C \otimes \mathcal{O}(U)$, we denote it by $\langle\theta, \mathcal{Y}(v, z) u\rangle$ for $v \in A, u \in B, \theta \in C^{\vee}$ and $z \in U$, satisfying
(I 1) [commutativity] $\left\langle\theta, \alpha_{m} \mathcal{Y}(v, z) u-\mathcal{Y}(v, z) \alpha_{m} u\right\rangle=\sum_{j=0}^{\infty}\binom{m}{j}\left\langle\theta, \mathcal{Y}\left(\alpha_{j} v, z\right) u\right\rangle z^{m-j}$,
(I 2) [associativity]
$\left\langle\theta, \mathcal{Y}\left(\alpha_{m} v, z\right) u\right\rangle=\sum_{j=0}^{\infty}\binom{m}{j}(-1)^{j}\left\langle\theta,\left\{\alpha_{m-j} z^{j} \mathcal{Y}(v, z) u-(-1)^{m} \mathcal{Y}(v, z) \alpha_{j} z^{m-j} u\right\}\right\rangle$, and (I 3) $\left[L(-1)\right.$-derivative property] $\langle\theta, \mathcal{Y}(L(-1) v, z) u\rangle=\frac{d}{d z}\langle\theta, \mathcal{Y}(v, z) u\rangle$ for $\alpha \in V$ and $m \in \mathbb{Z}$, where $\left\langle\theta, \alpha_{m} \mathcal{Y}(v, z) u\right\rangle$ denotes $\left\langle\left(\alpha_{m}\right)^{*} \theta, \mathcal{Y}(v, z) u\right\rangle$ with a contragredient operator $\left(\alpha_{m}\right)^{*}$ of $\alpha_{m}$.

An aim in this subsection is to show that every local intertwining operator for $A, B, C \in$ $\mathcal{N C}_{1}$ on a domain $U$ is a branch of a logarithmic intertwining operator on $U$.

Let $W \in \mathcal{N C}_{1}$. Since $C_{1}(W)=\operatorname{Span}_{\mathbb{C}}\left\{\alpha_{-1}\left(P_{W}+C_{1}(W)\right) \mid \alpha \in V_{\geq 1}\right\}$, we have:
Lemma 2.11 $W=\operatorname{Span}_{\mathbb{C}}\left\{\alpha_{-1}^{1} \cdots \alpha_{-1}^{k} w \mid w \in P_{W}, \alpha^{j} \in V_{\geq 1}, k \geq 0\right\}$. In particular, $W$ is a finitely generated $V$-module.

Therefore, there are finitely many $d_{1}, \ldots, d_{t} \in \mathbb{C}$ such that $W=\oplus_{j=1}^{t} \oplus_{n \in \mathbb{N}} W_{d_{j}+n}$ and $\operatorname{dim} W_{s}<\infty$ for $s \in \mathbb{C}$, where $W_{s}$ denotes a generalized eigenspace in $W$ of $L(0)$ with eigenvalue $s$. In particular, if $W$ is indecomposable, then $W=\oplus_{m \in \mathbb{N}} W_{d+m}$ for some $d \in \mathbb{C}$ and $W_{d} \neq 0$. We use the notation $\mathrm{wt}(w)=s$ for $w \in W_{s}$ and $\mathrm{wt}\left(\alpha_{n}\right)=\mathrm{wt}(\alpha)-n-1$ for $\alpha \in V$. Define $\operatorname{wt}() 1 \in \operatorname{End}_{\mathbb{C}}(W)$ by $(\operatorname{wt}() 1) w=\operatorname{wt}(w) w$ for $w \in W$. Since $W_{(m)} \subseteq$ $\operatorname{Span}_{\mathbb{C}}\left\{\alpha_{-1}^{1} \cdots \alpha_{-1}^{k} w \mid w \in P_{W}, \alpha^{j} \in V_{\geq 1}, \sum_{j=1}^{k} \operatorname{wt}\left(\alpha^{j}\right) \leq m\right\}$, we obtain:

Lemma 2.12 For $m \in \mathbb{N}$, there is $\mu(m) \in \mathbb{N}$ such that $\operatorname{dim} W_{(m)} \leq \mu(m) \times \operatorname{dim} P_{W}$. Moreover, the restricted dual $W^{\vee}=\oplus_{m \in \mathbb{N}} \operatorname{Hom}\left(W_{(m)}, \mathbb{C}\right)$ of an $\mathbb{N}$-graded module $W=$ $\oplus W_{(m)} \in \mathcal{N C}_{1}$ is isomorphic to the contragredient module $\oplus_{s \in \mathbb{C}} \operatorname{Hom}\left(W_{s}, \mathbb{C}\right)$ of $W=$ $\oplus_{s \in \mathbb{C}} W_{s}$. In particular, $W^{\vee}$ does not depend on the choice of an $\mathbb{N}$-grading on $W$.

Since $\mathrm{wt}\left(\alpha_{n} w\right)=\mathrm{wt}(w)+\mathrm{wt}(\alpha)-n-1$ and $L(0) \alpha_{n} w=(\mathrm{wt}(\alpha)-n-1) \alpha_{n} w+\alpha_{n} L(0) w=$ $\left(\mathrm{wt}\left(\alpha_{n} w\right) \alpha_{n} w+\alpha_{n}(L(0)-\mathrm{wt}(w)) w\right.$, we get:
Lemma 2.13 $L(0)-\mathrm{wt}() 1$ is a $V$-homomorphism. If $W \in \mathcal{N C}_{1}$, then there is $K \in \mathbb{N}$ such that $(L(0)-\mathrm{wt}() 1)^{K} W=0$ and $(L(0)-\mathrm{wt}() 1)^{K} W^{\vee}=0$.
[Proof] As we have just proved, $L(0)-\mathrm{wt}() 1$ is a $V$-homomorphism. Since $\operatorname{dim} P_{W}<\infty$, there is $n \in \mathbb{N}$ such that $P_{W} \subseteq \oplus_{i=0}^{n} W_{(i)}$, which is $L(0)$-wt ()1-invariant and $\operatorname{dim} \oplus_{i=0}^{n} W_{(i)}<$ $\infty$. Hence $(L(0)-\mathrm{wt}() 1)^{K}\left(\oplus_{i=0}^{n} W_{(i)}\right)=0$ for some $K$. Since $W$ is generated from $P_{W}$ by the actions of $V$, we have $(L(0)-\mathrm{wt}() 1)^{K} W=0$. From $\left\langle(L(0)-\mathrm{wt}() 1)^{K} W^{\vee}, W\right\rangle=$ $\left\langle W^{\vee},(L(0)-\mathrm{wt}() 1)^{K} W\right\rangle=0$, we also obtain $(L(0)-\mathrm{wt}() 1)^{K} W^{\vee}=0$.

Lemma 2.14 Let $A, B, C \in \mathcal{N C}_{1}$ and let $\mathcal{Y}$ be a local intertwining operator of type $\binom{C}{A B}$ on a domain $U$ with a form $\langle\theta, \mathcal{Y}(v, z) u\rangle=\sum_{h=0}^{K(\theta, v, u)}\left\langle\theta, \mathcal{Y}_{h}(v, z) u\right\rangle \log ^{h}(z)$ with $\mathbb{C}$-formal power series $\mathcal{Y}_{h}(v, z) u$ and $K(\theta, v, u) \in \mathbb{N}$. Then there is $K \in \mathbb{N}$ such that $K(\theta, v, u) \leq K$.
[Proof] Since

\sum_{h=0}^{K(\theta, v, u)}\left\langle\theta, \mathcal{Y}_{h}(L(-1) v, z) u\right\rangle \log ^{h}(z)=\frac{\partial}{\partial z}\left\{\sum_{h=0}^{K(\theta, v, u)}\left\langle\theta, \mathcal{Y}_{h}(v, z) u\right\rangle \log ^{h}(z)\right\}
$$

we have $\mathcal{Y}_{k+1}(v, z) u=\mathcal{Y}_{k}(L(-1) v, z) u-\frac{\partial}{\partial z}\left(\mathcal{Y}_{k}(v, z) u\right) \times \frac{z}{k+1}$. We also get

&\langle\theta, \mathrm{wt}\left.() 1\left(\mathcal{Y}_{k}(v, x) u\right)\right\rangle=\left\langle\theta, \mathrm{wt}() 1\left(\sum_{m} v_{m, k} u z^{-m-1}\right)\right\rangle \\
& \quad=(\operatorname{gr}(u)+\operatorname{gr}(v))\left\langle\theta, \sum_{m} v_{m, k} u z^{-m-1}\right\rangle+\left\langle\theta, \sum_{m}(-m-1) v_{m, k} u z^{-m-1}\right\rangle \\
& \quad=(\operatorname{gr}(v)+\operatorname{gr}(u))\left\langle\theta, \mathcal{Y}_{k}(v, z) u\right\rangle+\frac{\partial}{\partial z}\left\langle\theta, \mathcal{Y}_{k}(v, z) u\right\rangle z .
\end{aligned}
$$

Using the notation $\Xi=L(0)-\mathrm{wt}() 1$ and $(X+Y+Z)^{\ell}=\sum_{i, j, p \in \mathbb{N}} \lambda_{i, j, p}^{\ell} X^{i} Y^{j} Z^{p}$, we obtain

& =\left\langle\theta, \Xi \mathcal{Y}_{k}(v, x) u\right\rangle+\left\langle\theta, \mathcal{Y}_{k}(v, x) \Xi u\right\rangle+\left\langle\theta, \mathcal{Y}_{k}(\Xi v, x) u\right\rangle \\
& =\cdots=\sum_{\{i, j, p \in \mathbb{N} \mid i+j+p=\ell \leq k\}} \lambda_{i, j, p}^{\ell}\left\langle\theta, \Xi^{i}\left(\mathcal{Y}_{k+1-\ell}\left(\Xi^{j} v, z\right) \Xi^{p} u\right\rangle .\right.
\end{aligned}
$$

Since there is $\bar{K} \in \mathbb{N}$ such that $(\Xi)^{\bar{K}} A=(\Xi)^{\bar{K}} B=(\Xi)^{\bar{K}} C=0$ by Lemma 2.13, we have $\left\langle\theta, \mathcal{Y}_{k}(v, z) u\right\rangle=0$ for $k \geq 3 \bar{K}$, that is, we can take $K(\theta, v, u) \leq 3 \bar{K}$ for any $\theta, v, u$.

We will use the following theorem after the proof of Theorem 4.1.
Theorem 2.15 Let $A, B, C \in \mathcal{N C}_{1}$ and $N \in \mathbb{N}$. For a local intertwining operator $\mathcal{Y}$ of
 such that $\langle\theta, \mathcal{Y}(v, z) u\rangle$ has the following expression:

for any $\theta \in C_{(\leq N)}^{\vee}, v \in A, u \in B$, where $v_{s, t} \in \underset{\sim}{\operatorname{Hom}}(B, C)$ for $v \in V$ and we take $a$ principal branch of $z^{-s}$ and $\log (z)$. Furthermore, $\widetilde{\mathcal{Y}}(v, z)=\sum_{t=0}^{K} \sum_{s \in \mathbb{C}} v_{s, t} z^{-1} \log ^{t}(z) \in$ $I\binom{C}{A B}$. Namely, $\mathcal{Y}$ is a branch of a logarithmic intertwining operator $\widetilde{\mathcal{Y}}$ on $U$.
[Proof] Set $S(\theta, v, u ; z)=\langle\theta, \mathcal{Y}(v, z) u\rangle$. Choose $N \in \mathbb{N}$ so that $\operatorname{gr}(\theta) \leq N$. Let $Q_{N}=\left\{\theta^{p}: p \in \mathcal{Q}_{N}\right\}, J_{A}=\left\{v^{i} \mid i \in \mathcal{P}_{A}\right\}, J_{B}=\left\{u^{j} \mid j \in \mathcal{P}_{B}\right\}$ be bases of $C_{(\leq N)}^{\vee}, P_{A}, P_{B}$, respectively. From (I 1) and (I 2), for $\alpha \in V_{\geq 1}$, we have

& S\left(\theta, v, \alpha_{-1} u ; z\right)=S\left(\left(\alpha_{-1}\right)^{*} \theta, v, u ; z\right)-\sum_{j=0}^{\infty}(-1)^{j} S\left(\theta, \alpha_{j} v, u ; z\right) z^{-1-j} .
\end{aligned}

Define $\operatorname{gr}^{-}(\theta, v, u)=\operatorname{gr}(v)+\operatorname{gr}(u)-\operatorname{gr}(\theta)$ and the total grade $\operatorname{gr}^{+}(\theta, v, u)=\operatorname{gr}(v)+\operatorname{gr}(u)+$ $\operatorname{gr}(\theta)$ and set $T(\theta, v, u ; z)=F(\theta, v, u ; z) z^{\mathrm{gr}^{-}(\theta, v, u)}$. Then we obtain

& T\left(\theta, v, \alpha_{-1} u ; z\right)=T\left(\left(\alpha_{-1}\right)^{*} \theta, v, u ; z\right)-\sum_{j=0}^{\infty}(-1)^{j} T\left(\theta, \alpha_{j} v, u ; z\right) . \tag{2.6}
\end{align*}

Comment 1 (1) The coefficients are all constants.
(2) The total grades of triples in RHS of (2.6) are less than the total grade $\operatorname{gr}(\theta)+\operatorname{gr}(v)+$ $\operatorname{gr}(u)+\operatorname{gr}(\alpha)$ of LHS of (2.6). Hence for $(\theta, v, u)$ with $\operatorname{gr}(\theta) \leq N$, by iterating the expansion (2.6) as long as we have elements of $C_{1}(A)$ or $C_{1}(B)$ in the second and third coordinates, we finally obtain that $T(\theta, v, u ; z)$ is a linear combination of $\left\{T\left(\theta^{p}, v^{i}, u^{j} ; z\right) \mid(p, i, j) \in\right.$ $\left.\mathcal{Q}_{N} \times \mathcal{P}_{A} \times \mathcal{P}_{B}\right\}$ with constant coefficients.
By the direct calculation, we also have

& \quad=S(\theta, L(-1) v, u ; z) z^{\mathrm{gr}^{-}(\theta, v, u)}+\left(\operatorname{gr}^{-}(\theta, v, u)\right) S(\theta, v, u ; z) z^{\operatorname{gr}^{-}(\theta, v, u)-1} \\
& \quad=T(\theta, L(-1) v, u ; z) z^{-1}+\left(\operatorname{gr}^{-}(\theta, v, u)\right) G(\theta, v, u ; z) z^{-1}
\end{aligned}
$$

Therefore, for a vector valued function $Z=\left(T\left(\theta^{p}, v^{i}, u^{j} ; z\right)\right)_{(p, i, j) \in \mathcal{Q}_{N} \times \mathcal{P}_{A} \times \mathcal{P}_{B}}$ of size $s$, there is a matrix $A_{0} \in M_{s \times s}(\mathbb{C})$ such that

where $s=\left|\mathcal{Q}_{N}\right| \times\left|\mathcal{P}_{A}\right| \times\left|\mathcal{P}_{B}\right|$, that is, $Z$ satisfies an Euler system (2.7) and $T(\theta, v, u ; z)$ is a component of a solution of $(2.7)$ for $(\theta, v, u) \in Q_{N} \times J_{A} \times J_{B}$. By Lemma 2.3, all components of solutions $T(\theta, v, u ; z)$ of $(2.7)$ on $\mathbb{C} \backslash\{0\}$ are linear combinations of $\left\{z^{s} \log ^{t}(z) \mid s \in \mathbb{C}, t \in \mathbb{N}\right\}$. Namely, for each $N, v, u$ with $N \geq \operatorname{gr}(\theta)$, there is a finite set $\Delta_{N} \subseteq \mathbb{C}$ and $K(N, v, u) \in \mathbb{N}$ such that

with $v_{-s_{j}-1, t} \in \operatorname{Hom}(B, C)$. Since $A$ and $B$ are generated from $P_{A}$ and $P_{B}$ as $V$-modules, respectively, we know that Eq.(2.8) holds for any $\theta \in C^{\vee}, v \in A, u \in B$ and $z \in U$ by using (2.6). Although our argument depends on the choice of $N \geq \operatorname{gr}(\theta)$, we note that there is $K$ such that $K(N, v, u) \leq K$ by Lemma 2.4. Therefore it is easy to check that $\widetilde{\mathcal{Y}}(v, z)=\sum_{t=0}^{K} \sum_{s \in \mathbb{C}} v_{s, t} z^{-s-1} \log ^{t}(z)$ is a logarithmic intertwining operator of type $\binom{C}{A}$ and $\mathcal{Y}$ is a branch of it on $U$.
[Fusion product] In this paper, for $\mathbb{N}$-gradable $V$-modules $A$ and $B$, a fusion product $\left(A \boxtimes B, \mathcal{Y}^{A B}\right)$ is defined to be a pair of an $\mathbb{N}$-gradable $V$-module $A \boxtimes B$ and $\mathcal{Y}^{A B} \in I\binom{A \boxtimes B}{A B}$ satisfying the universal property for $\mathbb{N}$-gradable modules, that is, for any $\mathbb{N}$-gradable $V$ module $C$ and $\mathcal{Y} \in I\binom{C}{A B}$, there is the unique isomorphism $\phi: A \boxtimes B \rightarrow C$ such that $\phi\left(\mathcal{Y}^{A B}(v, z) u\right)=\mathcal{Y}(v, z) u$ for $v \in A$ and $u \in B$.

Comment 2 (1) The coefficients are in $\mathbb{C}\left[x^{ \pm 1}, y^{ \pm 1}, \tau_{x, y}\left\{(x-y)^{ \pm 1}\right\}, \tau_{y, x-y}\left\{x^{ \pm 1}\right\}\right]$. Hence the same equations also hold for coefficients of logarithm functions.

Hence the corresponding coefficients in $(m A)$ and $(m B)$ are same on a domain $\left\{(x, y) \in \mathbb{C}^{2} \mid\right.$ $0<|x-y|<|y|<|x|\}$.

## 3 The proof of theorems 3.1, 3.2 and Corollary 3.3

### 3.1 Theorem 3.1 (Reduction to small weight subspaces)

We recall Lemma 2.11. See Table 1 for Borcherds identities $(2 A) \sim(4 A)$ for $n=-1$.
Comment 3 Since $\operatorname{gr}\left(\left(\alpha_{-1-j}\right)^{*} \theta\right)<\operatorname{gr}(\theta)$, we have $\left(\alpha_{-1-j}\right)^{*} \theta \in(A(B C))_{(<N)}^{\vee}$ for $\alpha \in$ $V_{\geq 1}$ and $j \in \mathbb{N}$. Since $\operatorname{gr}\left(\alpha_{j} w\right)=\operatorname{gr}\left(\alpha_{-1} w\right)-j-1$ for $j \in \mathbb{N}$, the total grades of quadruples of each term in RHS are less than the total grade of quadruples in LHS, that is, $\operatorname{gr}\left(\left(\left(\alpha_{-1-j}\right)^{*}\right)^{[1]} \vec{\xi}\right), \operatorname{gr}\left(\alpha_{j}^{[k]} \vec{\xi}\right)<\operatorname{gr}\left(\alpha_{-1}^{[i]} \vec{\xi}\right)$. Therefore by iterating these reductions as long as we have an element of $C_{1}(A), C_{1}(B)$ or $C_{1}(C)$ in the second, third or fourth coordinates of quadruples, we finally get an expression of $F_{h, k}^{A(B C)}(\vec{\xi} ; x, y)$ as a linear combination of

Comment 4 Since Borcherds identities for $F_{h, k}^{A(B C)}$ and $F_{h, k}^{(A B) C}$ have the same coefficients except the way of expansions, we can get Borcherds identities $(2 B) \sim(4 B)$ by viewing $F(\vec{\xi})$ as $F_{h, k}^{(A B) C}(\vec{\xi} ; x, y)$ and expanding all coefficients by $\iota_{y, x-y}$.

Comment 5 In the case of $D \times(x-y)^{q}$, negative powers appear only on $x$ or $y$. In the case of $D \times y^{q}$, negative powers occur only on $(x-y)$ or $x$. We hence consider

This completes the proof of Theorem 3.1.

### 3.2 Proof of Theorem 3.2 (Differential systems)

We will prove the Fuchsian systems (D1) and (D2) for $G_{h, k}^{A(B C): y}$ and $G_{h, k}^{A(B C): x-y}$. The proofs for the other cases are similar. From the $L(-1)$-derivative property of intertwining operators, as $\mathbb{C}$-formal power series with logarithmic terms, for $\vec{\xi}=(\theta, v, u, w) \in \Omega$ and $\overrightarrow{\xi^{\prime}}=\left(\theta^{\prime}, v, u, w\right) \in \Omega^{\prime}$, we have

for some $\lambda_{\vec{\mu}, p, q}^{34: \vec{\xi}, h, k}\left(x_{0}, y\right) \in \mathbb{C}\left[x_{0}, x_{0}^{-1}, \iota_{x_{0}, y}\left\{\left(x_{0}-y\right)^{-1}\right\}\right][y] \subseteq \mathbb{C}[[y]]$. Define

then $\frac{d}{d y} G^{y}\left(x_{0}, y\right)=\frac{1}{y} \Lambda^{34}\left(x_{0}, y\right) G^{y}\left(x_{0}, y\right)$, which is a Fuchsian system over $\mathbb{D}_{\left|x_{0}\right|}\left(x_{0}\right)$. We note $\lambda_{\vec{\mu}, p, q}^{34, \vec{\xi}, h, k}=0$ if $\vec{\mu} \notin \mathcal{J}_{N}^{0}$. Similarly, from Remark 2.3 (2.12), we have:

We next investigate the set of eigenvalues of constant matrices. Since $\lambda_{\vec{\mu} ; p, q}^{23: \vec{\xi}, h, k}=0$ for $\vec{\mu} \notin \mathcal{J}_{N}^{0}$, the set of nonzero eigenvalues of the constant matrix $\Lambda^{23 ; x-y}\left(y_{0}, y_{0}\right)$ for $\mathcal{J}_{N}$ is equal to that for $\mathcal{J}_{N}^{0}$. So we may assume $\mathcal{J}_{N}=\mathcal{J}_{N}^{0}$. From (3.2), we know

Furthermore, on each step of the reduction of $G_{h, k}^{A(B C): x-y}\left(L(-1)^{[2]} \vec{\xi} ; x, y_{0}\right)$ into a linear combination of $\left\{G_{h, k}^{A(B C): x-y}\left(\vec{\mu} ; x, y_{0}\right) \mid \vec{\mu} \in \mathcal{J}_{N}^{0}\right\}$, the coefficients at the first term with $\left(\alpha_{j}\right)^{*[1]} \vec{\xi}$ and at the 4th term with $\alpha_{j}^{[4]} \vec{\xi}$ are contained in $\mathbb{C}\left[\left[x-y_{0}\right]\right]\left(x-y_{0}\right)$ by Theorem 3.1. In other words, modulo $\mathbb{C}\left[\left[x-y_{0}\right]\right]\left(x-y_{0}\right)$, the process of these reductions are independent from the choice of $(\theta, w)$ and we don't change the subscripts $h, k$. Therefore, for $\vec{\xi}=(\theta, v, u, w), \vec{\mu}=(\tilde{\theta}, \tilde{v}, \tilde{u}, \tilde{w}) \in \mathcal{J}_{N}$, there are $\lambda_{(\tilde{v}, \tilde{u})}^{(v, u)}\left(h, k ; x, y_{0}\right) \in \mathbb{C}$ such that

\lambda_{(\tilde{\theta}, \tilde{v}, \tilde{u}, \tilde{u}, p, q, q}^{23,(\theta, v, u, w), h, k}\left(x, y_{0}\right) \equiv \delta_{h, p} \delta_{k, q} \delta_{\theta, \tilde{\theta}} \delta_{w, \tilde{w}} \lambda_{(\tilde{v}, \tilde{u})}^{(v, u)}\left(h, k ; x, y_{0}\right) \quad\left(\bmod \mathbb{C}\left[\left[x-y_{0}\right]\right]\left(x-y_{0}\right)\right) \tag{3.3}
\end{equation*}
$$

which means that the set of eigenvalues (without counting multiplicities) of the constant matrix $\Lambda^{23, x-y}\left(y_{0}, y_{0}\right)$ is determined by only the choice of $J_{P_{A}}$ and $J_{P_{B}}$.

### 3.3 Corollary 3.3 (Local normal convergence)

Let $S^{1}$ be an indecomposable direct summand of $B \boxtimes C$ and $T^{1}$ an indecomposable direct summand of $A \boxtimes S^{1}$. We note that $A \boxtimes(B \boxtimes C)$ is a direct sum of such $T^{1}$ 's. We may choose $\theta \in\left(T^{1}\right)^{\vee}$. Set $p_{1}=d\left(T^{1}\right)-d(A)-d\left(S^{1}\right)-1$ and $p_{2}=d\left(S^{1}\right)-d(B)-d(C)+1$. Then there are $\lambda_{m}^{h, k}(\vec{\xi}) \in \mathbb{C}$ such that

G_{h, k}^{A(B C): y}(\vec{\xi} ; x, y)=\left\langle\theta, \mathcal{Y}_{h}^{1}(v, x) \mathcal{Y}_{k}^{2}(u, y) w\right\rangle y^{\mathrm{gr}^{234}(\vec{\xi})}=\sum_{m=0}^{\infty} \lambda_{m}^{h, k}(\vec{\xi}) x^{p_{1}} y^{p_{2}}(y / x)^{m}
$$

where $\mathcal{Y}_{h}^{1}(v, z) \delta=\pi_{T^{1}}\left(\mathcal{Y}_{h}^{A(B C)}(v, z) \delta\right)$ and $\mathcal{Y}_{k}^{2}(u, z) w=\pi_{S^{1}}\left(\mathcal{Y}_{k}^{B C}(u, z) w\right)$ for $\delta \in S^{1}$ and $\pi_{P}$ denotes the projection to $P$.

Therefore, in order to prove its convergence on a domain $\left\{(x, y) \in \mathbb{C}^{2}|0<|y|<|x|\}\right.$, it is enough to check the case where $x=1$ and $0<|y|<1$. In other words, it is enough to treat a one-variable vector valued function $Z=\left(G_{h, k}^{A(B C): y}(\vec{\xi} ; 1, y)\right)_{\vec{\xi} \in \mathcal{J}_{N},(h, k) \in K^{2}}$ satisfying a Fuchsian system $\frac{d}{d y} Z=\frac{\left(\lambda_{\vec{\mu}, p, p, q}^{\vec{F}, k}(1, y)\right.}{y} Z$ with polar locus $\{0\}$, where $\lambda_{\vec{\mu}, p, q}^{\vec{\xi}, h, k}(1, y) \in$ $\mathbb{C}\left[(1-y)^{-1}, y\right]$ by Theorem 3.1. Since $(1-y)^{-1}$ and $y$ have radius of convergence at least 1, so does $\lambda_{\vec{\mu}, p, q, q}^{\vec{\xi}, h, k}(1, y)-\delta_{(\vec{\xi}, h, k),(\vec{\mu}, p, q)}$. Therefore, from Theorem 2.10, the radius of convergence of $G_{h, k}^{A(B C): y}(\vec{\xi} ; 1, y)$ (and also that of $F_{h, k}^{A(B C)}(\vec{\xi} ; x, y)$ ) are at least 1 for $\vec{\xi} \in \Omega$. In a similar way, by using $(D 2)$ for $G^{(A B) C}\left(\vec{\xi}^{\prime} ; x, y_{0}\right)$, we can show that $F^{(A B) C}\left(\vec{\xi}^{\prime} ; x, y\right)$ is locally normally convergent on a domain $\left\{(x, y) \in \mathbb{C}^{2}|0<|x-y|<|y|\}\right.$.

This completes the proof of Corollary 3.3.

## 4 Associativity

Set $\mathcal{D}^{2}=\left\{(x, y) \in \mathbb{C}^{2}\left|0<|x-y|<|y|<|x|\right.\right.$, and $\left.x, y, x-y \notin \mathbb{R}^{\leq 0}\right\}$. In this section, we will prove the following main theorem.

Theorem 4.1 On $\mathcal{D}^{2}$, we choose a principal branch $\widetilde{F}\left(\left\langle\theta, \mathcal{Y}^{A(B C)}(v, x) \mathcal{Y}^{B C}(u, y) w\right\rangle\right)$ of $\left\langle\theta, \mathcal{Y}^{A(B C)}(v, x) \mathcal{Y}^{B C}(u, y) w\right\rangle$ by taking the values of $\log (x), \log (y)$ which satisfy $-\pi<$ $\Im(\log (x)), \Im(\log (y))<\pi$ and viewing $x^{d_{1}} y^{d_{2}}$ as $e^{d_{1} \log (x)+d_{2} \log (y)}$. Similarly
$\widetilde{F}\left(\left\langle\theta^{\prime}, \mathcal{Y}^{(A B) C}\left(\mathcal{Y}^{A B}(v, x-y) u, y\right) w\right\rangle\right)$ is a branch of $\left\langle\theta^{\prime}, \mathcal{Y}^{(A B) C}\left(\mathcal{Y}^{A B}(v, x-y) u, y\right) w\right\rangle$ by taking the values of $\log (y), \log (x-y)$ which satisfy $-\pi<\Im(\log (y)), \Im(\log (x-y))<\pi$ and considering $y_{1}^{d}(x-y)^{d_{2}}=e^{d_{1} \log (y)+d_{2} \log (x-y)}$. Then there is an isomorphism $\phi_{[A B] C}$ : $(A \boxtimes B) \boxtimes C \rightarrow A \boxtimes(B \boxtimes C)$ such that

$$
\widetilde{F}\left(\left\langle\theta, \mathcal{Y}^{A(B C)}(v, x) \mathcal{Y}^{B C}(y, u) w\right\rangle\right)=\widetilde{F}\left(\left\langle\phi_{[A B] C}^{*}(\theta), \mathcal{Y}^{(A B) C}\left(\mathcal{Y}^{A B}(v, x-y) u, y\right) w\right)\right\rangle
$$

on $\mathcal{D}^{2}$ for any $\theta \in((A \boxtimes B) \boxtimes C)^{\vee}$, $v \in A, u \in B, w \in C$, where $\phi_{[A B] C}^{*}$ denotes the dual of $\phi_{[A B] C}$.

### 4.1 Equation (4.9)

We may still assume $\theta \in\left(T^{1}\right)^{\vee}$. Hence there are $p_{1}, p_{2} \in \mathbb{C}$ such that

G_{h, k}^{A(B C): x-y}(\vec{\xi} ; x, y)=\left\langle\theta, \mathcal{Y}_{h}^{A(B C)}(v, x) \mathcal{Y}_{k}^{B C}(u, y) w\right\rangle(x-y)^{\operatorname{gr}^{234}(\vec{\xi})} \in \mathbb{C}[[y / x]] x^{p_{1}} y^{p_{2}}
$$

is absolutely convergent on $\left\{(x, y) \in \mathbb{C}^{2}|0<|y|<|x|\}\right.$. We also recall the definition $\mathcal{J}_{N}$ which is the set of quadruples of basis of $(A(B C))_{N}^{\vee}, \tilde{P}_{A}, \tilde{P}_{B}$, and $\tilde{P}_{C}$. We choose a branch $\widetilde{G}_{h, k}^{A(B C): x-y}(\vec{\xi} ; x, y)$ of $G_{h, k}^{A(B C): x-y}(\vec{\xi} ; x, y)$ on $\mathcal{D}^{2}$ by taking values of $\log (x), \log (y)$ which satisfy $-\pi<\Im(\log (x)), \Im(\log (y))<\pi$ and viewing $x^{p_{1}+m} y^{p_{2}+n}$ as $e^{\left(p_{1}+m\right) \log (x)+\left(p_{2}+n\right) \log (y)}=$ $e^{p_{1} \log (x)+p_{2} \log (y)} x^{m} y^{n}$ for $m, n \in \mathbb{Z}$. Then by Theorem 3.2, for $y_{0} \notin \mathbb{R} \leq 0$, a vector valued function

$$
G^{x-y}\left(x, y_{0}\right)=\left(\widetilde{G}_{h, k}^{A(B C): x-y}\left(\vec{\xi} ; x, y_{0}\right)\right)_{\vec{\xi} \in \mathcal{J}_{N},(h, k) \in K^{2}}
$$

satisfies a Fuchsian system (D2) for $\vec{\xi} \in \mathcal{J}_{N}$. Furthermore, the set of nonzero eigenvalues of the constant matrix $\Lambda^{23: x-y}\left(y_{0}, y_{0}\right)$ depends only on the choice of bases $J_{P_{A}}$ and $J_{P_{B}}$. Therefore, by Proposition [2.9, there is a finite subset $\Delta^{\prime} \subseteq \mathbb{C}$ such that all components of solutions of ( $D 2$ ) are written as

$$
\sum_{t=0}^{K} \sum_{d \in \Delta^{\prime}} \sum_{m \in \mathbb{N}} r_{d, m, t}\left(x-y_{0}\right)^{d+m} \log ^{t}\left(x-y_{0}\right)
$$

with $r_{d, m, t} \in \mathbb{C}$. We note that we have also taken a branch of $\left(x-y_{0}\right)^{d+m} \log ^{j}\left(x-y_{0}\right)$ on $\mathcal{D}_{\left(x, y_{0}\right)}^{2}$ by the same way. Since this holds for $\widetilde{G}_{h, k}^{A(B C): x-y}\left(\vec{\xi} ; x, y_{0}\right)$ with $\vec{\xi} \in \mathcal{J}_{N}$ and $y=y_{0} \notin \mathbb{R}^{\leq 0}$, there are $r_{s, t}^{h, k}(\vec{\xi} ; y) \in \mathbb{C}$ and $K(\vec{\xi}) \in \mathbb{N}$ such that we can write

$$
\begin{equation*}
\widetilde{G}_{h, k}^{A(B C): x-y}(\vec{\xi} ; x, y)=\sum_{s \in \Delta^{\prime}+\mathbb{N}} \sum_{t=0}^{K(\vec{\xi})} r_{s, t}^{h, k}(\vec{\xi} ; y)(x-y)^{s} \log ^{t}(x-y) \tag{4.1}
\end{equation*}
$$

on $\mathcal{D}^{2}$. Multiplying (4.1) by $\log ^{h}(x) \log ^{k}(y)(x-y)^{-\mathrm{gr}^{234}(\vec{\xi})}$ for all $(h, k) \in K^{2}$ and taking the sum of all of them, we obtain an equality:

\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\sum_{h, k} \sum_{s \in \Delta^{\prime}+\mathbb{N}} \sum_{j=0}^{K(\xi)} r_{d, j}^{h, k}(\vec{\xi} ; y) \log ^{k}(y) \log ^{h}(x)(x-y)^{s-\operatorname{gr}^{234}(\vec{\xi})} \log ^{j}(x-y) \tag{4.2}
\end{equation*}
$$

for a branch $\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)$ of $F^{A(B C)}(\vec{\xi} ; x, y)$ on $\mathcal{D}^{2}$. About the derivations, we use $\frac{\partial x}{\partial(x-y)}=1$ and $\frac{\partial y}{\partial(x-y)}=0$. Since $\frac{\partial \log (x)}{\partial x}=\frac{1}{x}=\frac{1}{y+(x-y)}=\frac{1}{y} \sum_{j=0}^{\infty}(-1)^{j}\left(\frac{x-y}{y}\right)^{j}$ and $\frac{\partial \log (x)}{\partial y}=0$, we define

$$
\begin{equation*}
p(x, y):=\sum_{j=0}^{\infty} \frac{(-1)^{j}}{j+1}\left(\frac{x-y}{y}\right)^{j+1}+\log (y) \tag{4.3}
\end{equation*}
$$

which satisfies the same property with $\log (x)$ in a neighborhood of $y \notin \mathbb{R}^{\leq 0}$. We replace $\log (x)$ in (4.2) by $p(x, y)$. Since the powers of $(x-y)$ in $p(x, y)$ are non-negative, we can write

\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\sum_{t=0}^{K(\vec{\xi})} \sum_{s \in \mathrm{gr}^{234}(\vec{\xi})-\Delta^{\prime}-\mathbb{N}-1} g_{s, t}(\vec{\xi} ; y)(x-y)^{-s-1} \log ^{t}(x-y) \tag{4.4}
\end{equation*}
$$

with $g_{s, t}(\vec{\xi} ; y) \in \mathbb{C}$ for $\vec{\xi} \in \mathcal{J}_{N}$. Since $\operatorname{dim} P_{C}<\infty$, using $\Delta=\left\{d-\max \left\{\operatorname{gr}(w): w \in P_{C}\right\} \mid\right.$ $\left.d \in \Delta^{\prime}\right\}$, we can rewrite (4.4) into

\begin{equation*}
\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\sum_{t=0}^{K(\vec{\xi})} \sum_{s \in \operatorname{gr}(v)+\operatorname{gr}(u)-\Delta-\mathbb{N}-1} g_{s, t}(\vec{\xi} ; y)(x-y)^{-s-1} \log ^{t}(x-y) \tag{4.5}
\end{equation*}
$$

for $\vec{\xi}=(\theta, v, u, w) \in \Omega$ with $w \in P_{C}$.
Lemma 4.2 (4.5) holds for all $\vec{\xi} \in \Omega$.
[Proof] Suppose false and let $\vec{\xi}=\left(\theta, v, u, w^{\prime}\right)$ be a counterexample. Subject to counterexample, we choose $w^{\prime}$ with the smallest grade. Since (4.5) holds for elements with $w$ in $P_{C}$, we may assume $w^{\prime}=\alpha_{-1} w$ with $\alpha \in V_{\geq 0}$ and $g_{s, t}\left(\theta, v, u, \alpha_{-1} w ; y\right) \neq 0$ for some $s \notin \mathrm{wt}(v)+\mathrm{wt}(u)-1-\Delta-\mathbb{N}$. In this case, by Borcherds identities, we obtain

& \widetilde{F}^{A(B C)}\left(\alpha_{-1}^{[4]} \vec{\xi} ; x, y\right)=\widetilde{F}^{A(B C)}\left(\left(\alpha_{-1}\right)^{*[1]} \vec{\xi} ; x, y\right)-\sum_{j=0}^{\infty}(-1)^{j} \widetilde{F}^{A(B C)}\left(\alpha_{j}^{[2]} \vec{\xi} ; x, y\right) x^{-j-1} \\
& \quad-\sum_{j=0}^{\infty}(-1)^{j} \widetilde{F}^{A(B C)}\left(\alpha_{j}^{[3]} \vec{\xi} ; x, y\right) y^{-j-1} \\
& =\widetilde{F}^{A(B C)}\left(\left(\alpha_{-1}\right)^{*[1]} \vec{\xi} ; x, y\right)-\sum_{j=0}^{\infty}\binom{-1}{j} \widetilde{F}^{A(B C)}\left(\alpha_{j}^{[2]} \vec{\xi} ; x, y\right) x^{-j-1} \\
& \quad-\sum_{j=0}^{\infty}\binom{-1}{j} y^{-j-1}\left\{\sum _ { i \in \mathbb { N } } ( \begin{array} { l } 
{ j } \\
{ i }
\end{array} ) ( - 1 ) ^ { i } \widetilde { F } ^ { A ( B C ) } \left(\left(\alpha_{j-i}^{*}[1] \vec{\xi} ; x, y\right) y^{i}\right.\right. \\
& \left.\quad-\sum_{i \in \mathbb{N}}\binom{j}{i} \widetilde{F}^{A(B C)}\left(\alpha_{i}^{[2]} \vec{\xi} ; x, y\right)(x-y)^{j-i}-\sum_{i \in \mathbb{N}}\binom{j}{i}(-1)^{i+j+1} \widetilde{F}^{A(B C)}\left(\alpha_{i}^{[4]} \vec{\xi} ; x, y\right) y^{j-i}\right\} \\
& =\widetilde{F}^{A(B C)}\left(\left(\alpha_{-1}\right)^{*[1]} \vec{\xi} ; x, y\right)-\sum_{j, i \in \mathbb{N}}\binom{j}{i}(-1)^{i+j} y^{i-j-1} \widetilde{F}^{A(B C)}\left(\left(\alpha_{j-i}\right)^{* 1]} \vec{\xi} ; x, y\right) \\
& \quad+\sum_{j=0}^{\infty} \sum_{i \in \mathbb{N}}\binom{j}{i}(-1)^{i+1} \widetilde{F}^{A(B C)}\left(\alpha_{i}^{[4]} \vec{\xi} ; x, y\right) y^{-1},
\end{aligned}
$$

by (2.9). However, since $\operatorname{gr}\left(\alpha_{j} w\right)<\operatorname{gr}\left(\alpha_{-1} w\right)=\operatorname{gr}\left(w^{\prime}\right)$ for $j \geq 0$ and the 2nd and 3rd components of $\left(\alpha_{j}\right)^{[i]} \vec{\xi}$ in RHS of the last equation are $v$ and $u$, none of the terms in RHS of the last equation have nonzero coefficients of $(x-y)^{-s-1} \log ^{t}(x-y)$ by the minimality of $\operatorname{gr}\left(w^{\prime}\right)$, which is a contradiction.

Since $g_{s, t}(\vec{\xi} ; y)$ is multi-linear on $\vec{\xi} \in \Omega_{N}=(A(B C))_{(\leq N)}^{\vee} \times A \times B \times C$, we split $\vec{\xi}=(\theta, v, u, w)$ into $\{v, u\}$ and $\{\theta, w\}$. In other words, using a formal operator $\widetilde{\mathcal{Y}}_{s, t}^{3} \in$ $\operatorname{Hom}\left(A \otimes B, \operatorname{Hom}\left(C, A(B C) \otimes O\left(\mathbb{C} \backslash \mathbb{R}^{\leq 0}\right)\right)\right)$, we can write

\begin{equation*}
\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\sum_{t=0}^{K(\vec{\xi})} \sum_{s \in \operatorname{gr}(v)+\operatorname{gr}(u)-\Delta-\mathbb{N}-1}\left\langle\theta, \widetilde{\mathcal{Y}}_{s, t}^{3}(v, u ; y) w\right\rangle(x-y)^{-s-1} \log ^{t}(x-y) \tag{4.6}
\end{equation*}
$$

for each $(x, y) \in \mathcal{D}^{2}$. Namely, $\left\langle\theta, \widetilde{\mathcal{Y}}_{s, t}^{3}(v, u ; y) w\right\rangle=\mathrm{Cf}_{s, t}\left(\tilde{F}^{A(B C)}(\vec{\xi} ; x, y) ; y\right)$, where $\mathrm{Cf}_{s, t}(f(x, y) ; y)$ denotes a coefficient $\lambda_{s, t}(y)$ of $(x-y)^{-s-1} \log ^{t}(x-y)$ in $f(x, y)=\sum_{t \in \mathbb{N}} \sum_{s \in \mathbb{C}} \lambda_{s, t}(y)(x-y)^{-s-1} \log ^{t}(x-y)$.

We introduce a formal vector space $A \otimes_{s, t} B$, which is isomorphic to $A \otimes B$ as a vector space and its isomorphism is given by $v \otimes v \mapsto v \otimes_{s, t} u$ for $s, t$. Set $A \otimes_{\infty} B=$ $\oplus_{(s, t) \in \mathbb{C} \times \mathbb{N}}\left(A \otimes_{s, t} B\right)$ and define a formal operator $\widetilde{\mathcal{Y}}^{4}$ of type $\left(\begin{array}{c}A \otimes_{\infty} B \\ A\end{array}\right.$ $\sum_{s \in \mathbb{C}} \sum_{t \in \mathbb{N}} v \otimes_{s, t} u(x-y)^{-s-1} \log ^{t}(x-y)$. We also define another formal operator $\widetilde{\mathcal{Y}}^{3}$ : $\left(A \otimes_{\infty} B\right) \times C \rightarrow A(B C) \otimes \mathcal{O}\left(\mathcal{D}_{(x, y)}^{2}\right)$ by $\left\langle\theta, \widetilde{\mathcal{Y}}^{3}\left(v \otimes_{s, t} u, y\right) w\right\rangle=\left\langle\theta, \widetilde{\mathcal{Y}}_{s, t}^{3}(v, u ; y) w\right\rangle(x-$ $y)^{-s-1} \log ^{t}(x-y)$. Then we can rewrite Eq. (4.6) into

\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\left\langle\theta, \widetilde{\mathcal{Y}}^{3}\left(\widetilde{\mathcal{Y}}^{4}(v, x-y) u, y\right) w\right\rangle . \tag{4.7}
\end{equation*}
$$

As it is well-known, $V\left[z, z^{-1}\right]$ has a Lie algebra structure by

\left[\alpha z^{m}, \beta z^{n}\right]=\sum_{j \in \mathbb{N}}\binom{m}{j}\left(\alpha_{j} \beta\right) z^{n+m-j} .
$$

Lemma 4.3 Define the action of $V\left[z, z^{-1}\right]$ on $A \otimes_{\infty} B$ by $\left(\alpha z^{m}\right)\left(v \otimes_{s, t} u\right)=v \otimes_{s, t} \alpha_{m} u+$ $\sum_{j=0}^{\infty}\binom{m}{j}\left(\alpha_{j} v \otimes_{s+m-j, t} u\right)$ for $\alpha z^{m} \in V\left[z, z^{-1}\right]$. Then $A \otimes_{\infty} B$ is a $V\left[z, z^{-1}\right]-m o d u l e$.
[Proof] To simplify the notation, we will omit the index $t$ from $v \otimes_{s, t} u$. We also denote the action of $\alpha z^{m}$ by $\alpha_{[m]}$. Then for $\alpha, \beta \in V$, we obtain

& \alpha_{[m]} \beta_{[n]}\left(v \otimes_{s} u\right)=\alpha_{[m]}\left(\sum_{j=0}^{\infty}\binom{n}{j}\left(\beta_{j} v\right) \otimes_{n+s-j} u\right)+\alpha_{[m]}\left(v \otimes_{s}\left(\beta_{n} u\right)\right) \\
& \quad=\sum_{i=0}^{\infty} \sum_{j=0}^{\infty}\binom{m}{i}\binom{n}{j}\left(\alpha_{i} \beta_{j} v\right) \otimes_{m+n+s-i-j} u+\sum_{j=0}^{\infty}\binom{n}{j}\left(\beta_{j} v\right) \otimes_{n+s-j}\left(\alpha_{m} u\right) \\
& \quad+\sum_{i=0}^{\infty}\binom{m}{i}\left(\alpha_{i} v\right) \otimes_{m+s-i}\left(\beta_{n} u\right)+v \otimes_{s}\left(\alpha_{m} \beta_{n} u\right) .
\end{aligned}
$$

We hence get:

= & \sum_{i=0}^{\infty} \sum_{j=0}^{\infty}\binom{m}{i}\binom{n}{j}\left(\alpha_{i} \beta_{j} v\right) \otimes_{m+n+s-i-j} u+\sum_{j=0}^{\infty}\binom{n}{j}\left(\beta_{j} v\right) \otimes_{n+s-j}\left(\alpha_{m} u\right) \\
& +\sum_{i=0}^{\infty}\binom{m}{i}\left(\alpha_{i} v\right) \otimes_{m+s-i}\left(\beta_{n} u\right)+v \otimes_{s}\left(\alpha_{m} \beta_{n} u\right) \\

& -\sum_{j=0}^{\infty}\left(\begin{array}{c}
n \\
j \\
j
\end{array}\right)\left(\beta_{j} v\right) \otimes_{n+s-j}\left(\alpha_{m} u\right)-v \otimes_{s}\left(\beta_{n} \alpha_{m} u\right)  \tag{4.8}\\
= & \sum_{i=0}^{\infty} \sum_{j=0}^{\infty}\binom{m}{i}\binom{n}{j}\left(\left[\alpha_{i}, \beta_{j}\right] v\right) \otimes_{m+n+s-i-j} u+v \otimes_{s}\left(\left[\alpha_{m}, \beta_{n}\right] u\right) \\
= & \sum_{i=0}^{\infty} \sum_{j=0}^{\infty}\binom{m}{i}\binom{n}{j}\left(\left[\alpha_{i}, \beta_{j}\right] v\right) \otimes_{m+n+s-i-j} u+v \otimes_{s}\left(\left[\alpha_{m}, \beta_{n}\right] u\right) \\
= & \sum_{i=0}^{\infty} \sum_{j=0}^{\infty}\binom{m}{i}\binom{n}{j}\left(\sum_{p=0}^{\infty}\binom{i}{p}\left(\alpha_{p} \beta\right)_{i+j-p} v\right) \otimes_{m+n+s-i-j} u+v \otimes_{s}\left(\left[\alpha_{m}, \beta_{n}\right] u\right) .
\end{align*}

On the other hand, we have:

& \quad=\sum_{i=0}^{\infty} \sum_{j=0}^{\infty}\binom{m}{i}\binom{n}{j}\left(\sum_{p=0}^{\infty}\binom{i}{p}\left(\alpha_{p} \beta\right)_{i+j-p} v\right) \otimes_{m+n+s-i-j} u+\left[v \otimes_{s}\left(\left[\alpha_{m}, \beta_{n}\right] u\right),\right.
\end{aligned}

which coincides with the last terms in (4.8). Therefore $A \otimes_{\infty} B$ is a $V\left[z, z^{-1}\right]$-module.
$A \otimes_{\infty} B$ is not a $V$-module. We choose a better one.
Definition 4.4 Let $\Gamma$ be the kernel of $\widetilde{\mathcal{Y}}^{3}$, that is,

\Gamma=\left\{\gamma \in A \otimes_{\infty} B \mid\left\langle\theta, \widetilde{\mathcal{Y}}^{3}(\gamma, y) w\right\rangle=0 \text { for all } \theta \in(A(B C))^{\vee}, w \in C \text { and } y \notin \mathbb{R}^{\leq 0}\right\} .
$$

In other words, $\sum_{i=1}^{n} v^{i} \otimes_{s_{i}, t_{i}} u^{i} \in \Gamma$ if and only if $\sum_{i=1}^{n} \operatorname{Cf}_{s_{i}, t_{i}}\left(\widetilde{F}^{A(B C)}\left(\theta, v^{i}, u^{i}, w ; x, y\right) ; y\right)=$ 0 for any $\theta \in(A(B C))^{\vee}$ and $w \in C$. Clearly, $\Gamma_{\tilde{\nabla}}$ is a subspace of $A \otimes_{\infty} B$. Define $A \tilde{\boxtimes} B=\left(A \otimes_{\infty} B\right) / \Gamma$. We denote $v \otimes_{s, t} u+\Gamma$ in $A \tilde{\otimes} B$ by $\left[v \otimes_{s, t} u\right]$ or $\left[v_{s, t} u\right]$.

Lemma 4.5 $\widetilde{\mathcal{Y}}^{3}$ satisfies associativity (I 2) and $\Gamma$ is $V\left[z, z^{-1}\right]$-invariant.
[Proof] By the definition of the action of $V\left[z, z^{-1}\right]$, we get:

& \quad=\mathrm{Cf}_{s, t}\left(\widetilde{F}^{A(B C)}\left(\theta, v, \alpha_{n} u, w ; x, y\right) ; y\right)+\sum_{i=0}^{\infty}\binom{n}{i} \mathrm{Cf}_{s+n-i, t}\left(\widetilde{F}^{A(B C)}\left(\theta, \alpha_{j} v, u, w ; x, y\right) ; y\right) .
\end{aligned}
$$

Since $\widetilde{F}^{A(B C)}$ satisfies Borcherds identity (3B), we also have:

& \left.\left.\quad-\sum_{j=0}^{\infty}\binom{n}{j} \widetilde{F}^{A(B C)}\left(\alpha_{j}^{[2]} \vec{\xi} ; x, y\right)(x-y)^{n-j}-\sum_{j=0}^{\infty}\binom{n}{j} \widetilde{F}^{A(B C)}\left(\alpha_{j}^{[4]} \vec{\xi} ; x, y\right)(-y)^{n-j}\right) ; y\right) \\
& \left.=\sum_{j=0}^{\infty}(-1)^{j} \mathrm{Cf}_{s, t}\left(\widetilde{F}^{A(B C)}\left(\left(\left(\alpha_{n-j}\right)^{*}\right)\right)^{[1]} \vec{\xi} ; x, y\right) ; y\right) y^{j} \\
& \quad-\sum_{j=0}^{\infty}\binom{n}{j} \mathrm{Cf}_{s+n-j, t}\left(\widetilde{F}^{A(B C)}\left(\alpha_{j}^{[2]} \vec{\xi} ; x, y\right) ; y\right) \\
& \quad-\sum_{j=0}^{\infty}\binom{n}{j}(-1)^{j+n} \mathrm{Cf}_{s, t}\left(\widetilde{F}^{A(B C)}\left(\alpha_{j}^{[4]} \vec{\xi} ; x, y\right) ; y\right) y^{n-j} .
\end{aligned}
$$

Therefore, we obtain (I 2) for $\widetilde{\mathcal{Y}}^{3}$, that is,

& \quad-\sum_{j=0}^{\infty}\binom{n}{j}(-1)^{j+n}\left\langle\theta, \widetilde{\mathcal{Y}}^{3}\left(v \otimes_{s, t} u, y\right) \alpha_{j} w\right\rangle y^{n-j} .
\end{aligned}
$$

We next show that $\Gamma$ is $V\left[z, z^{-1}\right]$-invariant. If $\gamma=\sum_{i=1}^{r} v^{i} \otimes_{s_{i}, t_{i}} u^{i} \in \Gamma$, then we have

& =\sum_{j=0}^{\infty}\binom{n}{j}(-1)^{j}\left\langle\left(\alpha_{n-j}\right)^{*} \theta, \widetilde{\mathcal{Y}}^{3}(\gamma, y) w\right\rangle y^{j}-\sum_{j=0}^{\infty}\binom{n}{j}(-1)^{j+n}\left\langle\theta, \widetilde{\mathcal{Y}}^{3}(\gamma, y) \alpha_{j} w\right\rangle y^{n-j}=0
\end{aligned}
$$

for any $\theta$ and $w$, which means $\alpha_{n} \gamma \in \Gamma$ for any $\alpha z^{n}=\alpha_{n}$. Hence $\Gamma$ is $V\left[z, z^{-1}\right]$-invariant.
Clearly, we can define formal operators $\mathcal{Y}^{3}$ of type $\binom{A(B C)}{A \tilde{\otimes} B C}$ and $\mathcal{Y}^{4}$ of type $\binom{A \tilde{\otimes} B}{A B}$ by $\mathcal{Y}^{4}(v, z) u=\left[\widetilde{\mathcal{Y}}^{4}(v, z) u\right]=\sum_{s, t}\left[v \otimes_{s, t} u\right] z^{-s-1} \log ^{t}(z)$ and $\left\langle\theta, \mathcal{Y}^{3}\left(\left[v_{s, t} u\right], z\right) w\right\rangle=\left\langle\theta, \widetilde{\mathcal{Y}}^{3}\left(v \otimes_{s, t}\right.\right.$ $u, z) w\rangle$ for $\vec{\xi} \in \Omega$. Then we have

for $\vec{\xi} \in \Omega$. We use $F^{34}(\vec{\xi} ; x, y)$ to denote $\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle$.
Theorem $4.6\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle$ satisfies the Borcherds identities $(1 B) \sim(4 B)$.
[Proof] As we mentioned in Comment 2, the coefficients of $F^{A(B C)}(\vec{\mu} ; x, y)$ in the expansion of $F^{A(B C)}\left(\alpha_{a}^{[i]} \vec{\xi} ; x, y\right)$ by Borcherds identities are all $\mathbb{C}\left[x^{ \pm 1}, y^{ \pm 1},(x-y)^{ \pm 1}\right]$, that is, integer powers of $x, y$ and $x-y$. Hence branches $\widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)$ of them on $\mathcal{D}^{2}$ also satisfy the Borcherds identities $(1 A) \sim(4 A)$. By Eq. (4.9), $F^{34}(\vec{\xi} ; x, y)$ also satisfies the Borcherds identities $(1 A) \sim(4 A)$ on $\mathcal{D}^{2}$. Since the corresponding coefficients in $(1 A) \sim(4 A)$ and $(1 B) \sim(4 B)$ are same on $\mathcal{D}^{2}$, we have the desired identities.

Proposition $4.7 \mathcal{Y}^{3}$ and $\mathcal{Y}^{4}$ satisfy $L(-1)$-derivative properties.
[Proof] We note that we are considering the derivations satisfying $\frac{\partial}{\partial(x-y)} y=0=$ $\frac{\partial}{\partial y}(x-y)$ and $\frac{\partial}{\partial y} y=1=\frac{\partial}{\partial(x-y)}(x-y)$. By the choice of $p(x, y)$ in (4.4), we get

& \quad=\frac{d}{d(x-y)} \widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\frac{\partial}{\partial(x-y)}\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle .
\end{aligned}
$$

We fix $v \in A$. Since the above holds for every $\theta \in(A(B C))^{\vee}, u \in B, w \in C$, the above implies $L(-1)$-derivative property of $\mathcal{Y}^{4}: \mathcal{Y}^{4}(L(-1) v, x-y)=\frac{d}{d(x-y)} \mathcal{Y}^{4}(v, x-y)$. Using $F^{34}\left(L(-1)^{[3]} \vec{\xi} ; x, y\right)=\frac{d}{d y} \widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\frac{\partial}{\partial y} F^{34}(\vec{\xi} ; x, y)$, we obtain

& \quad=\frac{\partial}{\partial x} \widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)+\frac{\partial}{\partial y} \widetilde{F}^{A(B C)}(\vec{\xi} ; x, y)=\left(\frac{\partial}{\partial x}+\frac{\partial}{\partial y}\right) \widetilde{F}^{A(B C)}(\vec{\xi} ; x, y) .
\end{aligned}
$$

Since $\left(\frac{\partial}{\partial y}+\frac{\partial}{\partial x}\right)(x-y)=0$ and $\left(\frac{\partial}{\partial y}+\frac{\partial}{\partial x}\right) y=1$, we also get

\left.\left\langle\theta, \mathcal{Y}^{3}\left(L(-1) \mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle=\frac{\partial}{\partial y} \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle
$$

under the assumption $\frac{\partial(x-y)}{\partial y}=0$, which proves $L(-1)$-derivative property of $\mathcal{Y}^{3}$.
As a corollary of the above and the existence of a finite set $\Delta$ in (4.5), we have:
Corollary 4.8 $L(-1)\left[v_{s, t} u\right]=-s\left[v_{s-1, t} u\right]+(t+1)\left[v_{s-1, t+1} u\right]$ and $\operatorname{wt}\left(\left[v_{s, t} u\right]\right)=\operatorname{wt}(v)+$ $\operatorname{wt}(u)-s-1$. The weights of elements in $A \tilde{\boxtimes} B$ are contained in $\Delta+\mathbb{N}$ and so $A \tilde{ष} B$ is $\mathbb{N}$-gradable. In particular, $\alpha_{n}\left[v_{s, t} u\right]=0$ for $n \gg 0$ for $\alpha \in V$.

Although Borcherds identities are given from (I 1) and (I 2), we will show the reverse.
Proposition $4.9 \mathcal{Y}^{3}$ and $\mathcal{Y}^{4}$ satisfy (I 1) and (I 2).
[Proof] We have already proved (I 2) for $\mathcal{Y}^{3}$. By the action of $V$ on $A \otimes_{\infty} B$, we have:

& \quad=\left\langle\theta, \widetilde{\mathcal{Y}}^{3}\left(\widetilde{\mathcal{Y}}^{4}(v, x-y) \alpha_{n} u, y\right) w\right\rangle+\sum_{j=0}^{\infty}\binom{n}{j}\left\langle\theta, \widetilde{\mathcal{Y}}^{3}\left(\widetilde{\mathcal{Y}}^{4}\left(\alpha_{j} v, x-y\right) u, y\right) w\right\rangle(x-y)^{n-j}
\end{aligned}
$$

for all $\theta$ and $w$, which implies (I 1) for $\mathcal{Y}^{4}$. From Borcherds identity (2B), we obtain:

& \quad-\sum_{j=0}^{\infty}\binom{n}{j}(-1)^{n+j}\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) \alpha_{j} w\right\rangle x^{n-j} \\
& \quad-\sum_{j=0}^{\infty}\binom{n}{j}(-1)^{n+j}\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) \alpha_{j} u, y\right) w\right\rangle(x-y)^{n-j} .
\end{aligned}
$$

On the other hand, from the associativity (I 2) for $\mathcal{Y}^{3}$, we have

& \sum_{j=0}^{\infty}\binom{n}{j}(-1)^{j}\left\langle\theta, \mathcal{Y}^{3}\left(\alpha_{n-j} \mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle(x-y)^{j} \\
& \quad=\sum_{i, j \in \mathbb{N}}\binom{n}{j}\binom{n-j}{i}(-1)^{i+j}\left\langle\theta, \alpha_{n-i-j} \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle(x-y)^{j} y^{i} \\
& \quad-\sum_{i, j \in \mathbb{N}}\binom{n}{j}(-1)^{i+n}\binom{n-j}{i}\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) \alpha_{j} w\right\rangle(x-y)^{j} y^{n-j-i} .
\end{aligned}
$$

Since $\sum_{j=0}^{\ell}\binom{n}{j}\binom{n-j}{\ell-j}(x-y)^{j} y^{\ell-j}=\binom{n}{\ell} x^{\ell}$ for $\ell \in \mathbb{N}$ and $\sum_{j}\binom{n}{j}\binom{n-j}{i}(-1)^{i+n}(x-y)^{j} y^{n-j-i}=$ $\binom{n}{i}(-1)^{n-i} x^{n^{i}}$ by (2.9), we obtain (I 2) for $\mathcal{Y}^{4}$. Commutativity (I 1) for $\mathcal{Y}^{3}$ is a direct consequence of Borcherds identity (B1) and the definition of action of $V$ on $A \tilde{\boxtimes} B$.

### 4.2 Recovery of $V$-modules and intertwining operators

Theorem $4.10 A \hat{\boxtimes} B$ is an $\mathbb{N}$-gradable $V$-module.
[Proof] We have proved that $A \tilde{\boxtimes} B$ is an $\mathbb{N}$-gradable $V\left[z, z^{-1}\right]$-module in Corollary 4.8. In particular, the action of $V$ on $A \tilde{\boxtimes} B$ satisfies commutativity. Therefore, the remaining thing is to prove associativity of the action of $V$. In particular, it is enough to show

\begin{align*}
& \left.\left\langle\theta, \mathcal{Y}^{3}\left(\alpha_{-1} \beta\right)_{[-1]} \gamma, y\right) w\right\rangle \\
& \left.\quad=\left\langle\theta, \mathcal{Y}^{3}\left(\alpha_{[-1]} \beta_{[-1]} \gamma, y\right) w\right\rangle+\sum_{j=0}^{\infty}\left\langle\theta,\left(\alpha_{[-2-j]} \beta_{[j]}+\beta_{[-2-j]} \alpha_{[j]}\right) \gamma, y\right) w\right\rangle \tag{4.10}
\end{align*}
$$

for $\gamma \in A \tilde{\boxtimes} B, w \in C, \theta \in(A(B C))^{\vee}$. We will develop the action of $V$ into a triple $(A(B C))^{\vee} \times A \tilde{\boxtimes} B \times C$ by using (I 1) and (I 2). The rule is simple, that is, we shift $\alpha_{<0}$ and $\beta_{<0}$ to the left and $\alpha_{\geq 0}$ and $\beta_{\geq 0}$ to the right. Finally, the actions of $V$ on $A \tilde{\boxtimes} B$ and $C$ are given by $\alpha_{\geq 0}$ or $\beta_{\geq 0}$. We use notation $P(X(\alpha, \beta))$ to denote $X(\alpha, \beta)+$ $X(\beta, \alpha)$ for any form $X$ of $\alpha_{i}$ and $\beta_{j}$. For example, $\left.P\left(\left\langle\theta, \mathcal{Y}^{3}\left(\alpha_{[-2-j]} \beta_{[j]}\right) \gamma, y\right) w\right\rangle\right)$ denotes $\left.\left\langle\theta, \mathcal{Y}^{3}\left(\alpha_{[-2-j]} \beta_{[j]}+\beta_{[-2-j]} \alpha_{[j]}\right) \gamma, y\right) w\right\rangle$. Then by (I 2) and associativity of the action of $V$ on $A(B C)$ and $C$, we have:

& =\sum_{i, j \in \mathbb{N}}\left\langle\theta,\left\{\alpha_{-1-j} \beta_{-1-j+i}+\beta_{-2-j-i} \alpha_{i}\right\} \mathcal{Y}^{3}(\gamma, y) w\right\rangle y^{j} \\
& \quad+\sum_{i, j \in \mathbb{N}}\left\langle\theta, \mathcal{Y}^{3}(\gamma, y)\left\{\alpha_{-1-i} \beta_{j+i}+\beta_{-1+j-i} \alpha_{i}\right\} w\right\rangle y^{-1-j} \\
& =\sum_{\ell, i \in \mathbb{N}}\left\langle\theta, \alpha_{-1-i} \beta_{-1-\ell} \mathcal{Y}^{3}(\gamma, y) w\right\rangle y^{\ell+i}+\sum_{\ell, j \in \mathbb{N}}\left\langle\theta, \alpha_{-2-j-\ell} \beta_{\ell} \mathcal{Y}^{3}(\gamma, y) w\right\rangle y^{j} \\
& +\sum_{i, j \in \mathbb{N}}\left\langle\theta, \beta_{-2-i-j} \alpha_{i} \mathcal{Y}^{3}(\gamma, y) w\right\rangle y^{j}+\sum_{i, j \in \mathbb{N}}\left\langle\theta, \mathcal{Y}^{3}(\gamma, y) \alpha_{-1-i} \beta_{i+j} w\right\rangle y^{-1-j} \\
& +\sum_{i, j \in \mathbb{N}}\left\langle\theta, \mathcal{Y}^{3}(\gamma, y) \beta_{-1-\ell} \alpha_{\ell+j} w\right\rangle y^{-1-j}+\sum_{\ell, i \in \mathbb{N}}\left\langle\theta, \mathcal{Y}^{3}(\gamma, y) \beta_{\ell} \alpha_{i} w\right\rangle y^{-2-\ell-i} \\
& =\sum_{\ell, i \in \mathbb{N}}\left\langle, \alpha_{-1-i} \beta_{-1-\ell} \mathcal{Y}^{3}(\gamma, y) w\right\rangle y^{\ell+i}+P\left(\sum_{i, j \in \mathbb{N}}\left\langle\theta, \beta_{-2-i-j}\left[\alpha_{i}, \mathcal{Y}^{3}(\gamma, y)\right] w\right\rangle y^{j}\right) \\
& +P\left(\sum_{i, j \in \mathbb{N}}\left\langle\theta, \beta_{-2-i-j} \mathcal{Y}^{3}(\gamma, y) \alpha_{i} w\right\rangle y^{j}\right)-P\left(\sum_{i, j \in \mathbb{N}}\left\langle\theta,\left[\alpha_{-1-i}, \mathcal{Y}^{3}(\gamma, y)\right] \beta_{i+j} w\right\rangle y^{-1-j}\right) \\
& +P\left(\sum_{i, j \in \mathbb{N}}\left\langle\theta, \alpha_{-1-i} \mathcal{Y}^{3}(\gamma, y) \beta_{i+j} w\right\rangle y^{-1-j}\right)+\sum_{\ell, i \in \mathbb{N}}\left\langle\theta, \mathcal{Y}^{3}(\gamma, y) \beta_{\ell} \alpha_{i} w\right\rangle y^{-2-\ell-i} .

Since there are many subscripts, in order to count the coefficients of terms in summations, we use monomials. For example, we denote $\left\langle\theta, \beta_{a} \mathcal{Y}^{3}\left(\left[v_{s} u\right], y\right) \alpha_{b} w\right\rangle y^{c}$ by $X^{a} Y^{b} Z^{c}$. Then since $i, j \in \mathbb{N}$, keeping the non-negative powers of $Y$, the following equation

& \sum_{i, j \in \mathbb{N}} X^{-2-i-j} Y^{i} Z^{j}+\sum_{i, j \in \mathbb{N}} X^{-1-i} Y^{i+j} Z^{-1-j} \\
& \quad=\iota_{X, Y}\left\{(X-Y)^{-1}\right\} \iota_{X, Z}\left\{(X-Z)^{-1}\right\}+\iota_{X, Y}\left\{(X-Y)^{-1}\right\} \iota_{Z, Y}\left\{(Z-Y)^{-1}\right\} \\
& \quad=\iota_{X, Z}\left\{(X-Z)^{-1}\right\} \iota_{X, Y}\left\{(X-Y)^{-1}\right\} \iota_{Z, Y}\left\{(Z-Y)^{-1}\right\}(X-Y) \\
& \quad=\iota_{X, Z}\left\{(X-Z)^{-1}\right\} \iota_{Z, Y}\left\{(Z-Y)^{-1}\right\} \\
& \quad=\sum_{i, j \in \mathbb{N}} X^{-1-i} Y^{j} Z^{i-j-1}
\end{aligned}

implies

& \sum_{i, j \in \mathbb{N}}\left\langle\theta, \beta_{-2-i-j} \mathcal{Y}^{3}(\gamma, y) \alpha_{i} w\right\rangle y^{j}+\sum_{i, j \in \mathbb{N}}\left\langle\theta, \beta_{-1-i} \mathcal{Y}^{3}(\gamma, y) \alpha_{i+j} w\right\rangle y^{-1-j} \\
& \quad=\sum_{i, j \in \mathbb{N}}\left\langle\theta, \beta_{-1-i} \mathcal{Y}^{3}(\gamma, y) \alpha_{j} w\right\rangle y^{-1-j+i} .
\end{aligned}
$$

Furthermore, from

& \left\langle\theta, \mathcal{Y}^{3}\left(\alpha_{[-1]} \beta_{[-1]}\left[v_{s} u\right], y\right) w\right\rangle \\
& =\sum_{i, j \in \mathbb{N}}\left\langle\theta, \alpha_{-1-j} \beta_{-1-i} \mathcal{Y}^{3}(\gamma, y) w\right\rangle y^{i+j}+\sum_{i, j \in \mathbb{N}}\left\langle\theta, \alpha_{-1-j} \mathcal{Y}^{3}(\gamma, y) \beta_{i} w\right\rangle y^{j-i-1} \\
& \quad+\sum_{i, j \in \mathbb{N}}\left\langle\theta, \beta_{-1-i} \mathcal{Y}^{3}(\gamma, y) \alpha_{j} w\right\rangle y^{-j-1+i}+\sum_{i, j \in \mathbb{N}}\left\langle\theta, \mathcal{Y}^{3}(\gamma, y) \beta_{j} \alpha_{i} w\right\rangle y^{-2-i-j},
\end{aligned}

we get
LHS of (4.10) - $\left\langle\theta, \mathcal{Y}^{3}\left(\alpha_{[-1]} \beta_{[-1]}\left[v_{s} u\right], y\right) w\right\rangle$
$=P\left(\sum_{i, j \in \mathbb{N}}\left\langle\theta, \beta_{-2-i-j}\left[\alpha_{i}, \mathcal{Y}^{3}(\gamma, y)\right] w\right\rangle y^{j}\right)-P\left(\sum_{i, j \in \mathbb{N}}\left\langle\theta,\left[\alpha_{-1-i}, \mathcal{Y}^{3}(\gamma, y)\right] \beta_{i+j} w\right\rangle y^{-1-j}\right)$
$=P\left(\sum_{i, j, k \in \mathbb{N}}\binom{i}{k}\left\langle\theta, \beta_{-2-i-j} \mathcal{Y}^{3}\left(\alpha_{[k]} \gamma, y\right) w\right\rangle y^{j+i-k}\right)$
$-P\left(\sum_{i, j, k \in \mathbb{N}}\binom{-1-i}{k}\left\langle\theta, \mathcal{Y}^{3}\left(\alpha_{[k]} \gamma, y\right) \beta_{i+j} w\right\rangle y^{-2-j-i-k}\right)$.
On the other hand, we obtain

= & P\left(\sum_{i, j \in \mathbb{N}}\binom{-2-i}{j}(-1)^{j}\left\langle\theta, \alpha_{-2-i-j} \mathcal{Y}^{3}\left(\beta_{[i]} \gamma, y\right) w\right\rangle y^{j}\right) \\
& -P\left(\sum_{i, j \in \mathbb{N}}\binom{-2-i}{j}(-1)^{j-2-i}\left\langle\theta, \mathcal{Y}^{3}\left(\beta_{[i]} \gamma, y\right) \alpha_{j} w\right\rangle y^{-2-i-j}\right) .
\end{aligned}

which coincides with the above, since we obtain

\end{aligned}

from

& \sum_{i, j, k \in \mathbb{N}}\binom{i}{k} X^{-2-i-j} Y^{k} Z^{j+i-k}=\sum_{i, j \in \mathbb{N}} X^{-2-i-j} Z^{j}(Z+Y)^{i} \\
& \quad=X^{-1-i}(Z+Y)^{i} \iota_{X, Z}\left\{(X-Z)^{-1}\right\}=\iota_{X, Z, Y}\left\{(X-Z-Y)^{-1}(X-Z)^{-1}\right\} \\
& \quad=\sum_{i \in \mathbb{N}} \iota_{X, Z}\left\{(X-Z)^{-2-i}\right\} Y^{i}=\sum_{i, j \in \mathbb{N}}\binom{-2-i}{j}(-1)^{j} X^{-2-i-j} Y^{i} Z^{j},
\end{aligned}

where we denote $\left\langle\theta, \alpha_{a} \mathcal{Y}^{3}\left(\beta_{[b]} \gamma, y\right) w\right\rangle y^{c}$ by $X^{a} Y^{b} Z^{c}$ and $b \in \mathbb{N}$ and we also have

\begin{aligned}
& P\left(\sum_{i, j \in \mathbb{N}}\binom{-2-i}{j}(-1)^{j-2-i}\left\langle\theta, \mathcal{Y}^{3}\left(\beta_{[i]} \gamma, y\right) \alpha_{j} w\right\rangle y^{-2-i-j}\right) \\
& \quad=P\left(\sum_{i, j \in \mathbb{N}}\binom{-2-i}{j}(-1)^{j-2-i}\left\langle\theta, \mathcal{Y}^{3}\left(\beta_{[i]} \gamma, y\right) \alpha_{j} w\right\rangle y^{-2-i-j}\right)
\end{aligned}
$$

from

$$
\begin{aligned}
& \sum_{i, j, k \in \mathbb{N}}\binom{-1-i}{k} X^{k} Y^{i+j} Z^{-2-i-j-k}=\sum_{i \in \mathbb{N}}(Z+X)^{-1-i} \sum_{j \in \mathbb{N}} Y^{i} Z^{-1-j} Y^{j} \\
& \quad=\iota_{Z-Y, X}\left\{(Z-Y+X)^{-1}\right\} \iota_{Z, Y}\left\{(Z-Y)^{-1}\right\}=\sum_{i \in \mathbb{N}}(-1)^{i} \iota_{Z, Y}\left\{(Z-Y)^{-2-i}\right\} X^{i} \\
& \quad=\sum_{i, j \in \mathbb{N}}\binom{(-2-i}{j}(-1)^{-2-i+j} X^{i} Y^{j} Z^{-2-i+j},
\end{aligned}
$$

where we replace $\left\langle\theta, \mathcal{Y}^{3}\left(\beta_{[a]} \gamma, y\right) \alpha_{b} w\right\rangle y^{c}$ with $X^{a} Y^{b} Z^{c}$ and $a, b \in \mathbb{N}$.
This completes the proof of Theorem 4.10.
We now start the proof of Theorem 4.1. Since $A \tilde{\boxtimes} B$ is an $\mathbb{N}$-gradable modules, by Theorem 2.15, $\mathcal{Y}^{3}$ and $\mathcal{Y}^{4}$ are branches of some logarithmic intertwining operators of type $\binom{A(B C)}{A \tilde{\otimes} B C}$ and $\binom{A \tilde{\otimes} B}{A}$ on $\mathcal{D}^{2}$. By the construction of $\mathcal{Y}^{3}, \mathcal{Y}^{4}$, for any $\theta \in(A(B C))^{\vee}$, there are $v \in A, u \in B, w \in C$ such that $\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle \neq 0$, that is, the set of coefficients of $(x-y)^{r} y^{s} \log ^{h}(x-y) \log ^{k}(y)$ in $\left\{\mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w \mid v \in A, u \in B, w \in\right.$ $C\}$ spans $A(B C)$. From the universal properties of fusion products $\left(A \boxtimes B, \mathcal{Y}^{A B}\right)$ and $\left((A \tilde{\boxtimes} B) \boxtimes C, \mathcal{Y}^{(A \dot{\otimes} B) \boxtimes C}\right)$ and $\left((A \boxtimes B) \boxtimes C, \mathcal{Y}^{(A B) C}\right)$, there is a surjective $V$-homomorphism $\phi_{[A B] C}:(A \boxtimes B) \boxtimes C \rightarrow A \boxtimes(B \boxtimes C)$ such that

\left\langle\theta, \phi_{[A B] C}\left(\mathcal{Y}^{(A B) C}\left(\mathcal{Y}^{A B}(v, x-y) u, y\right) w\right\rangle\right. & =\left\langle\theta, \mathcal{Y}^{3}\left(\mathcal{Y}^{4}(v, x-y) u, y\right) w\right\rangle \\
& =\left\langle\theta, \mathcal{Y}^{A(B C)}(v, x) \mathcal{Y}^{B C}(u, y) w\right\rangle
\end{aligned}
$$

on $\mathcal{D}^{2}$ for any $v \in A, u \in B, w \in C$ and $\theta \in(A(B C))^{\vee}$. Similarly, by starting from $\left\langle\theta^{\prime}, \mathcal{Y}^{(A B) C}\left(\mathcal{Y}^{(A B)}(v, x-y) u, y\right) w\right\rangle$, we also have a surjective homomorphism $\phi_{A[B C]}:(A \boxtimes$ $B) \boxtimes C \rightarrow A \boxtimes(B \boxtimes C)$ satisfying

$$
\left\langle\theta^{\prime}, \phi_{A[B C]}\left(\mathcal{Y}^{A(B C)}(v, x) \mathcal{Y}^{B C}(u, y) w\right)\right\rangle=\left\langle\theta^{\prime}, \mathcal{Y}^{(A B) C}\left(\mathcal{Y}^{A B}(v, x-y) u, y\right) w\right\rangle
$$

on $\mathcal{D}^{2}$ for all $v, u, w, \theta^{\prime}$. From the construction, it is easy to see that $\phi_{A[B C]} \circ \phi_{[A B] C}=1$ and $\phi_{[A B] C} \circ \phi_{A[B C]}=1$.

This completes the proof of the associativity law of fusion products.

Corollary 4.11 If $V^{\vee} \cong V$ and $A$ and $A^{\vee}$ are both $C_{1}$-cofinite $\mathbb{N}$-gradable modules, then for any non-zero $C_{1}$-cofinite $\mathbb{N}$-gradable $V$-module $B, A \boxtimes B$ and $B \boxtimes A$ are not zero.
[Proof] There is a surjective intertwining operator of type $\binom{V^{\vee}}{A A^{\vee}}$ which comes from the $V$-module structure on $A$ by skew-symmetry and duality. Hence $B \cong B \boxtimes V$ is a homomorphism image of $B \boxtimes\left(A \boxtimes A^{\vee}\right) \cong(B \boxtimes A) \boxtimes A^{\vee}$. Therefore, $(B \boxtimes A) \boxtimes A^{\vee} \neq 0$ and $B \boxtimes A \neq 0$. Similarly, we get $A \boxtimes B \neq 0$.

## 5 Pentagon axiom

Theorem 5.1 (Pentagon axiom) For $C_{1}$-cofinite $\mathbb{N}$-gradable modules $A, B, C, D$, by using the above isomorphisms $\phi_{[* * *}$, we have the following commutative diagram.


## [Proof]

We consider a domain $\mathcal{D}^{3}=\left\{(x, y, z) \in \mathbb{C}^{3}| | x|>|y|>|z|>|x-z|>|y-z|>|x-y|>\right.$ 0 , and $\left.x, y, z, x-y, y-z, x-z \notin \mathbb{R}^{\leq 0}\right\}$. We note $(7,6,4) \in \mathcal{D}^{3} \neq \emptyset$. Simplify the notation, we omit the notation $\boxtimes$. Let $\theta \in(A(B(C D)))^{\vee}, v \in A, u \in B, w \in C, d \in D$ and let $\vec{\xi}$ denote a quadruple $(v, u, w, d) \in A \times B \times C \times D$. We fix all intertwining operators for fusion products, say $\mathcal{Y}^{A B}, \mathcal{Y}^{B C}, \mathcal{Y}^{C D}, \mathcal{Y}^{B(C D)}, \mathcal{Y}^{(B C) D}, \mathcal{Y}^{A(B(C D))}, \ldots$, and consider their five-point correlation functions:

$$
\begin{align*}
& F^{A(B(C D))}\left(\theta^{1}, \vec{\xi} ; x, y, z\right)=\left\langle\theta^{1}, \mathcal{Y}^{A(B(C D))}(v, x) \mathcal{Y}^{B(C D)}(u, y) \mathcal{Y}^{C D}(w, z) d\right\rangle, \\
& F^{A((B C) D)}\left(\theta^{2}, \vec{\xi} ; x, y-z, z\right)=\left\langle\theta^{2}, \mathcal{Y}^{A((B C) D)}(v, x) \mathcal{Y}^{(B C) D}\left(\mathcal{Y}^{B C}(u, y-z) c, z\right) d\right\rangle, \\
& F^{(A(B C)) D}\left(\theta^{3}, \vec{\xi} ; x-z, y-z, z\right)=\left\langle\theta^{3}, \mathcal{Y}^{(A(B C)) D}\left(\mathcal{Y}^{(A(B C)}(v, x-z) \mathcal{Y}^{B C}(u, y-z) w, z\right) d\right\rangle, \\
& F^{((A B) C) D}\left(\theta^{4}, \vec{\xi} ; x-y, y-z, z\right)=\left\langle\theta^{4}, \mathcal{Y}^{((A B) C) D}\left(\mathcal{Y}^{(A B) C}\left(\mathcal{Y}^{A B}(v, x-y) u, y-z\right) w, z\right) d\right\rangle \text {, and } \\
& F^{(A B)(C D)}\left(\theta^{5}, \vec{\xi} ; x-y, y, z\right)=\left\langle\theta^{5}, \mathcal{Y}^{(A B)(C D)}\left(\mathcal{Y}^{A B}(v, x-y) u, y\right) \mathcal{Y}^{C D}(w, z) d\right\rangle \tag{5.1}
\end{align*}
$$

for $\theta^{1} \in(A(B(C D)))^{\vee}, \theta^{2} \in(A((B C) D))^{\vee}, \theta^{3} \in((A(B C)) D)^{\vee}, \theta^{4} \in(((A B) C) D)^{\vee}, \theta^{5} \in$ $((A B)(C D))^{\vee}$. By the same way as we did for four-point correlation functions, it is not difficult to see that these five-point correlation functions are all locally normal convergent
on $\left\{(x, y, z) \in \mathbb{C}^{3}| | x|>|y|>|z|>|x-z|>|y-z|>|x-y|>0\}\right.$. We next choose their principle branches

$$
\widetilde{F}^{A(B(C D))}\left(\theta^{1}, \vec{\xi} ; x, y, z\right), \widetilde{F}^{A((B C) D)}\left(\theta^{2}, \vec{\xi} ; x, y-z, z\right), \ldots, \widetilde{F}^{(A B)(C D)}\left(\theta^{5}, \vec{\xi} ; x-y, y, z\right)
$$

on $\mathcal{D}^{3}$ by taking the values of $\log (x), \log (y), \log (z), \log (x-y), \log (x-z), \log (y-z)$ which satisfy $-\pi<\Im(\log (x)), \Im(\log (y)), \Im(\log (z)), \Im(\log (x-y)), \Im(\log (x-z)), \Im(\log (y-z))<\pi$ and viewing $x^{a}, y^{b}, z^{c},(x-y)^{d},(x-z)^{e},(y-z)^{f}$ as $e^{a \log (x)}$, $e^{b \log (y)}, e^{c \log (z)}, e^{d \log (x-y)}$, $e^{e \log (x-z)}, e^{f \log (y-z)}$, respectively.

From our construction of isomorphisms $\phi_{[*, *] *}$, by Theorem 4.1, we have equations:

$$
\begin{aligned}
& \widetilde{F}^{A(B(C D))}\left(\theta^{1}, \vec{\xi} ; x, y, z\right)=\widetilde{F}^{A((B C) D)}\left(\left(1_{A} \times \phi_{[B C] D}^{*}\right)\left(\theta^{1}\right), \vec{\xi} ; x, y-z, z\right), \\
& \widetilde{F}^{A((B C) D)}\left(\theta^{2}, \vec{\xi} ; x, y-z, z\right)=\widetilde{F}^{(A(B C)) D}\left(\phi_{[A(B C)] D}^{*}\left(\theta^{2}\right), \vec{\xi} ; x-z, y-z, z\right), \\
& \widetilde{F}^{(A(B C)) D}\left(\theta^{3}, \vec{\xi} ; x-z, y-z, z\right)=\widetilde{F}^{((A B) C) D}\left(\left(\phi_{[A B] C}^{*} \times 1_{D}\right)\left(\theta^{3}\right), \vec{\xi} ; x-y, y-z, z\right), \\
& \widetilde{F}^{A(B(C D))}\left(\theta^{1}, \vec{\xi} ; x, y, z\right)=\widetilde{F}^{(A B)(C D)}\left(\phi_{[A B](C D)}^{*}\left(\theta^{1}\right), \vec{\xi} ; x-y, y, z\right), \text { and } \\
& \widetilde{F}^{(A B)(C D))}\left(\theta^{5}, \vec{\xi} ; x-y, y, z\right)=\widetilde{F}^{((A B) C) D}\left(\phi_{[(A B) C] D}^{*}\left(\theta^{5}\right), \vec{\xi} ; x-y, y, z\right),
\end{aligned}
$$

on $\mathcal{D}^{3}$ at least, where $\phi^{*}: U^{\vee} \rightarrow W^{\vee}$ denotes the dual of $\phi: W \rightarrow U$. We hence have

$$
\begin{aligned}
& \widetilde{F}_{F}^{((A B) C) D}\left(\left(\phi_{[A B] C}^{*} \otimes 1_{D}\right)\left(\phi_{[A(B C)] D}^{*}\left(\left(1_{A} \otimes \phi_{[B C] D}^{*}\right)\left(\theta^{1}\right)\right)\right), \vec{\xi} ; x-y, y-z, z\right) \\
& \quad=\widetilde{F}^{A(B(C D))}\left(\theta^{1}, \vec{\xi} ; x, y, z\right)=\widetilde{F}^{((A B) C) D}\left(\phi_{[(A B) C] D}^{*}\left(\phi_{[A B](C D)}^{*}\left(\theta^{1}\right)\right), \vec{\xi} ; x-y, y-z, z\right)
\end{aligned}
$$

for all $\theta^{1} \in(A(B(C D)))^{\vee}$ and $\vec{\xi}$. As a consequence, we obtain $1_{A} \otimes \phi_{[B C] D} \circ \phi_{[A(B C)] D} \circ$ $\phi_{[A B] C} \otimes 1_{D}=\phi_{[A B](C D)} \circ \phi_{[(A B) C] D}$, which implies the commutativity of the diagram.

This completes the proof of Theorem 5.1.
