STRONG DIFFUSION APPROXIMATION IN AVERAGING WITH DYNAMICAL SYSTEMS FAST MOTIONS

ABSTRACT. The paper deals with the fast-slow motions setups in the continuous time $\frac{dX^\varepsilon(t)}{dt} = \frac{1}{\varepsilon} \Sigma(X^\varepsilon(t)) \xi(t/\varepsilon^2)) + b(X^\varepsilon(t), \, \xi(t/\varepsilon^2), \, t \in [0,T] \text{ and the discrete time } X^\varepsilon((n+1)\varepsilon^2) = X^\varepsilon(n\varepsilon^2) + \varepsilon \Sigma(X^\varepsilon(n\varepsilon^2)) \xi(n) + \varepsilon^2 b(X^\varepsilon(n\varepsilon^2), \xi(n)), \\ n = 0,1,..., [T/\varepsilon^2] \text{ where } \Sigma \text{ and } b \text{ are smooth matrix and vector functions and } \xi \text{ is a stationary vector stochastic process with weakly dependent terms and such that } E\xi(0) = 0. \text{ The assumptions imposed on the process } \xi \text{ allow applications to a wide class of observables } g \text{ in the dynamical systems setup so that } \xi \text{ can be taken in the form } \xi(t) = g(F^t\xi(0)) \text{ or } \xi(n) = g(F^n\xi(0)) \text{ where } F \text{ is either a flow or a diffeomorphism with some hyperbolicity and } g \text{ is a vector function. In this paper we show that both } X^\varepsilon \text{ and a family of diffusions } \Xi^\varepsilon \text{ can be redefined on a common sufficiently rich probability space so that } E \sup_{0 \le t \le T} |X^\varepsilon(t) - \Xi^\varepsilon(t)|^p \le C\varepsilon^\delta, \, p \ge 1 \text{ for some } C, \delta > 0 \text{ and all } \varepsilon > 0, \text{ where all } \Xi^\varepsilon, \varepsilon > 0 \text{ have the same diffusion coefficients but underlying Brownian motions may change with } \varepsilon.$

1. Introduction

Let X^{ε} be the solution of a system of ordinary differential equations having the form

(1.1)
$$\frac{dX^{\varepsilon}(t)}{dt} = \frac{1}{\varepsilon} \Sigma(X^{\varepsilon}(t)) \xi(t/\varepsilon^{2}) + b(X^{\varepsilon}(t), \, \xi(t/\varepsilon^{2})), \, t \in [0, T]$$

where $\Sigma(x)$ and $b(x, \xi(s))$ are Lipschitz continuous matrix and vector fields on \mathbb{R}^d and ξ is a stationary process which is viewed as a fast motion while X^{ε} is considered as a slow motion. Assume also that for s = 0 (and so for all s),

$$(1.2) E\xi(s) \equiv 0.$$

It was shown in a series of papers [20], [30] and [4] that X^{ε} (considered in a more general form) converges weakly as $\varepsilon \to 0$ to a diffusion process provided ξ is sufficiently fast mixing with respect to σ -algebras generated by ξ itself. It turns out that the latter condition is quite restrictive when ξ is generated by a dynamical system, i.e. when $\xi(t) = g \circ F^t$ where g is a vector function and F^t is a

flow (continuous time dynamical system) preserving certain measure which makes ξ a stationary process. In order to derive weak convergence of X^{ε} to a diffusion for ξ generated by a sufficiently large class of dynamical systems other approaches were developed recently based mainly on the rough paths theory (see [23], [11] and references there). All above mentioned results can be obtained both in the continuous time setup (1.1) and in the discrete time setup given by the following recurrence relation

$$(1.3) X^{\varepsilon}((n+1)\varepsilon^{2}) = X^{\varepsilon}(n\varepsilon^{2}) + \varepsilon \Sigma(X^{\varepsilon}(n\varepsilon^{2}))\xi(n) + \varepsilon^{2}b(X^{\varepsilon}(n\varepsilon^{2}), \xi(n))$$

where $0 \le n < [T/\varepsilon^2]$ and $\xi(n)$, $n \ge 0$ is a stationary sequence of random vectors. Observe that the above results can be viewed as a substantial generalization of the functional central limit theorem since when $\Sigma(x)$ does not depend on x and $b \equiv 0$ the process X^{ε} weakly converges to the Brownian motion (with a covariance matrix).

Another, completely different, line of research dealt with extension of limit theorems for sums of random variables from convergence in distribution or weak convergence to strong approximations or strong invariance principles results. This was done first for independent random variables and martingales in [32] and extended to weakly dependent random variables in [31], dealing in both cases with the one dimensional case since their proofs were based on the martingale approximation and the Skorokhod embedding theorem. The latter does not work, in general, in the multidimensional case (see [29]) and another method was developed in [7] to tackle the case of sums $S_n = \xi_1 + \cdots + \xi_n$ of weakly dependent random vectors. We observe that until recently (see [27] where the general case was treated) all papers dealing with strong approximations in the multidimensional case starting with [7] (see [12] and references there) considered weak dependence or mixing with respect to σ -algebras generated by random vector summands $\xi(n)$, $n \geq 0$ themselves which is quite restrictive in applications to dynamical systems. Only in the one dimensional case, which is based on the martingale approximation and the Skorokhod embedding, [31] considers a more general weak dependence setup which allowed to extend strong approximation theorems to dynamical systems in [13] but only for one dimensional observables.

Recently, strong L^p diffusion approximations appeared in the first time for slow motions X^{ε} from (1.1) and (1.3) in [22]. The results there are valid in the multidimensional case but only assuming weak dependence of the processes $\xi(t)$, $t \geq 0$ in (1.1) and $\xi(n)$, $n \geq 0$ in (1.3) with respect to the σ -algebras generated by these random variables (vectors) themselves which, as mentioned above, allows applications to rather restricted class of observables in the dynamical systems setup. The purpose of this paper is to extend L^p diffusion approximations results assuming more general weak dependence conditions which turns out to lead to substantial difficulties and will be achieved here only in certain situations. Such extension allows applications to a larger and natural class of vector observables in the dynamical systems setup. We stress that our goal is to obtain for each parameter value certain L^p bounds on errors of diffusion approximations which is somewhat different from eventual almost sure bounds derived usually in the papers on strong approximations which dealt before only with sums of random variables (or vectors), and so the limiting process there was always the Brownian motion (with covariances).

2. Preliminaries and main results

2.1. **Discrete time case.** We start with the discrete time setup which consists of a complete probability space (Ω, \mathcal{F}, P) , a stationary sequence of random vectors $\xi(n), -\infty < n < \infty$ and a two parameter family of countably generated σ -algebras $\mathcal{F}_{m,n} \subset \mathcal{F}, -\infty \leq m \leq n \leq \infty$ such that $\mathcal{F}_{mn} \subset \mathcal{F}_{m'n'} \subset \mathcal{F}$ if $m' \leq m \leq n \leq n'$ where $\mathcal{F}_{m\infty} = \bigcup_{n: n \geq m} \mathcal{F}_{mn}$ and $\mathcal{F}_{-\infty n} = \bigcup_{m: m \leq n} \mathcal{F}_{mn}$. We will measure the dependence between σ -algebras \mathcal{G} and \mathcal{H} by the ϕ -coefficient defined by

(2.1)
$$\phi(\mathcal{G}, \mathcal{H}) = \sup\{\left|\frac{P(\Gamma \cap \Delta)}{P(\Gamma)} - P(\Delta)\right| : P(\Gamma) \neq 0, \ \Gamma \in \mathcal{G}, \ \Delta \in \mathcal{H}\}$$
$$= \frac{1}{2} \sup\{\|E(g|\mathcal{G}) - Eg\|_{\infty} : g \text{ is } \mathcal{H}\text{-measurable and } \|g\|_{\infty} = 1\}$$

(see [6]) where $\|\cdot\|_{\infty}$ is the L^{∞} -norm. For each $n\geq 0$ we set also

(2.2)
$$\phi(n) = \sup_{m} \phi(\mathcal{F}_{-\infty,m}, \mathcal{F}_{m+n,\infty}).$$

If $\phi(n) \to 0$ as $n \to \infty$ then the probability measure P is called ϕ -mixing with respect to the family $\{\mathcal{F}_{mn}\}$. Unlike [22], in order to ensure more applicability of our results to dynamical systems, we do not assume that $\xi(n)$ is \mathcal{F}_{nn} -measurable and instead we will work with the approximation coefficient

(2.3)
$$\rho(n) = \sup_{m} \|\xi(m) - E(\xi(m)|\mathcal{F}_{m-n,m+n})\|_{\infty}.$$

To save notations we will still write \mathcal{F}_{mn} , $\phi(n)$ and $\rho(n)$ for $\mathcal{F}_{[m][n]}$, $\phi([n])$ and $\rho([n])$, respectively, if m and n are not integers (or $\pm \infty$), where $[\cdot]$ denotes the integral part.

We will deal with the recurrence relation (1.3) where we set $X_N = X^{1/\sqrt{N}}$ so that (1.3) takes the form

$$(2.4) \ X_N(n+1/N) = X_N(n/N) + \frac{1}{\sqrt{N}} \Sigma(X_N(n/N))\xi(n) + \frac{1}{N} b(X_N(n/N), \xi(n))$$

and this definition is extended to all $t \in [0, T]$ by setting $X_N(t) = X_N(n/N)$ whenever $n/N \le t < (n+1)/N$. We will assume that $\Sigma(x)$ and $b(x, \cdot)$ are twice and once differentiable in the first variable, respectively, and b is Lipschitz continuous in the second variable. To avoid excessive technicalities these coefficients are supposed to satisfy the following uniform bounds

(2.5)
$$E\xi(0) = 0, \|\xi(0)\|_{\infty} \le L, \sup_{x \in \mathbb{R}^d} \max(|\Sigma(x)|, |\nabla_x \Sigma(x)|, |\nabla_x^2 \Sigma(x)|) \le L,$$

$$(2.6) \quad \sup_{x,y\in\mathbb{R}^d} \max\left(|b(x,y)|,\, |\nabla_x b(x,y)|\right) \leq L \text{ and } |b(x,y)-b(x,z)| \leq L|y-z|.$$

for some constant $1 \le L < \infty$ and all $x, y, z \in \mathbb{R}^d$, where $\Sigma = (\Sigma_{ij}, 1 \le i, j \le d)$ and $b = (b_1, ..., b_d)$ are d-dimensional matrices and vectors and we take the Euclidean norms.

Set

$$a_{jk}(x, m, n) = \sum_{i,l=1}^{d} \Sigma_{ji}(x) \varsigma_{il}(n-m) \Sigma_{lk}(x)$$

where $\zeta_{il}(n-m) = E(\xi_i(m)\xi_l(n)) = E(\xi_i(0)\xi_l(n-m))$. We will see that under the conditions of the theorem below there exist limits

(2.7)
$$\varsigma_{ij} = \lim_{k \to \infty} \frac{1}{k} \sum_{m=0}^{k} \sum_{n=0}^{k} \varsigma_{ij}(n-m),$$

where $\varsigma = (\varsigma_{ij})$, and so, for j, k = 1, ..., d,

(2.8)
$$a_{jk}(x) = \lim_{n \to \infty} \frac{1}{n} \sum_{k=0}^{n} \sum_{l=0}^{n} a_{jk}(x, k, l) = \sum_{i,l=1}^{d} \Sigma_{ji}(x) \varsigma_{il} \Sigma_{lk}(x).$$

The matrix $A(x) = (a_{jk}(x)) = \Sigma(x)\varsigma\Sigma^*(x)$ is twice differentiable if $\Sigma(x)$ is. Since ς is symmetric and nonnegatively definite, there exists $\varsigma^{1/2}$ such that $\varsigma^{1/2}\varsigma^{1/2} = \varsigma$. Set $\sigma(x) = \Sigma(x)\varsigma^{1/2}$,

$$c_{i}(x, m, n) = \sum_{j,k,l=1}^{d} \frac{\partial \Sigma_{ij}(x)}{\partial x_{k}} \varsigma_{jl}(n-m) \Sigma_{kl}(x)$$

and

(2.9)
$$c_i(x) = \sum_{j,k,l=1}^d \frac{\partial \Sigma_{ij}(x)}{\partial x_k} \hat{\varsigma}_{jl} \Sigma_{kl}(x), \ i = 1, ..., d$$

where

(2.10)
$$\hat{\varsigma}_{jl} = \lim_{k \to \infty} \frac{1}{k} \sum_{n=0}^{k} \sum_{m=-k}^{n-1} \varsigma_{jl}(n-m) = \sum_{m=1}^{\infty} E(\xi_j(m)\xi_l(0))$$

and the latter limit will be shown to exist under our conditions. It turns out that σ , $b(x) = Eb(x, \xi(m))$ and c(x) are Lipschitz continuous, and so there exists a unique solution Ξ of the stochastic differential equation

(2.11)
$$d\Xi(t) = \sigma(\Xi(t))dW(t) + (b(\Xi(t)) + c(\Xi(t)))dt$$

where W is the standard d-dimensional Brownian motion. When a non negatively definite symmetric matrix A(x) is fixed then any solution of (2.11) with any matrix σ satisfying $A(x) = \sigma(x)\sigma^*(x)$ has the same path distribution since this leads to the same Kolmogorov equation and to the same martingale problem (see [33]).

2.1. **Theorem.** Suppose that (1.2) is satisfied, X_N is defined by (2.4) with b and Σ satisfying (2.5) and (2.6). Assume that $\Sigma^{-1}(x) = (\hat{\Sigma}_{ij}(x))$ exists,

$$\sup_{x} |\Sigma^{-1}(x)| \le L,$$

(2.13)
$$\frac{\partial \hat{\Sigma}_{ij}(x)}{\partial x_k} = \frac{\partial \hat{\Sigma}_{ik}(x)}{\partial x_j} \text{ for all } i, j, k = 1, ..., d$$

(which is automatically satisfied if d = 1), and

(2.14)
$$\phi(n), \, \rho(n) \le C_0 n^{-4}$$

for some constant $C_0 > 0$ and all $n \ge 1$. Then for each $N \ge 1$ the slow motion X and the diffusion Ξ having the same initial condition $X_N(0) = \Xi_N(0)$ can be redefined preserving their distributions on the same sufficiently rich probability space,

which contains also an i.i.d. sequence of uniformly distributed random variables, so that for any integers $N, M \ge 1$ and T > 0,

(2.15)
$$E \sup_{0 \le t \le T} |X_N(t) - \Xi_N(t)|^{2M} \le C(M, T) N^{-\delta},$$

where δ , C(M,T) > 0 do not depend on N and they can be explicitly recovered from the proof. Here $\Xi = \Xi_N$ depends on N in the strong but not in the weak sense, i.e. the coefficients in (2.11) do not depend on N but for each N in order to satisfy (2.15) we may have to choose an appropriate Brownian motion $W = W_N$ which can be obtained from a universal Brownian motion W by rescaling $W_N(t) = N^{-1/2}W(Nt)$. In particular, the Prokhorov distance between the distributions of X_N and of Ξ_N is bounded by $(C(M,T)N^{-\delta})^{1/3}$.

The conditions of Theorem 2.1 enable us in Section 3 to reduce the setup to the situation where Σ in (2.4) is the identity matrix. This allows to replace the process $\xi(n)$ by a process $\xi^{m_N}(n) = E(\xi(n)|\mathcal{F}_{n-m_N,n+m_N})$ with an appropriate $m_N \to \infty$ as $N \to \infty$ which, in turn, enables us to use the ϕ -mixing effectively. After the replacement of $\xi(n)$ by $\xi^{m_N}(n)$ we rely on the strong approximation theorem and arrive at the required estimate comparing several auxiliary processes.

2.2. **Remark.** The reduction of the setup of Theorem 2.1 to the situation where Σ is the the identity map allows to obtain an almost sure version of the result, namely, to show that as $N \to \infty$ almost surely,

$$\sup_{0 \le t \le T} |X_N(t) - \Xi_N(t)| = O(N^{-\hat{\delta}})$$

for some $\hat{\delta} > 0$ independent of N.

Important classes of processes satisfying our conditions come from dynamical systems. Let F be a C^2 Axiom A diffeomorphism (in particular, Anosov) in a neighborhood of an attractor or let F be an expanding C^2 endomorphism of a Riemannian manifold Ω (see [5]), g be a either Hölder continuous vector functions or vector functions which are constant on elements of a Markov partition and let $\xi(n) = \xi(n,\omega) = g(F^n\omega)$. Here the probability space is (Ω, \mathcal{B}, P) where P is a Gibbs invariant measure corresponding to some Hölder continuous function and \mathcal{B} is the Borel σ -field. Let ζ be a finite Markov partition for F then we can take \mathcal{F}_{kl} to be the finite σ -algebra generated by the partition $\bigcap_{i=k}^l F^i \zeta$. In fact, we can take here not only Hölder continuous g's but also indicators of sets from \mathcal{F}_{kl} . The conditions of Theorem 2.1 allow all such functions since the dependence of Hölder continuous functions on m-tails, i.e. on events measurable with respect to $\mathcal{F}_{-\infty,-m}$ or $\mathcal{F}_{m,\infty}$, decays exponentially fast in m and the condition (2.14) is even weaker than that. A related class of dynamical systems corresponds to F being a topologically mixing subshift of finite type which means that F is the left shift on a subspace Ω of the space of one (or two) sided sequences $\omega = (\omega_i, i \geq 0), \omega_i = 1, ..., l_0$ such that $\omega \in \Omega$ if $\pi_{\omega_i \omega_{i+1}} = 1$ for all $i \geq 0$ where $\Pi = (\pi_{ij})$ is an $l_0 \times l_0$ matrix with 0 and 1 entries and such that Π^n for some n is a matrix with positive entries. Again, we have to take in this case q to be Hölder continuous bounded functions on the sequence space above, P to be a Gibbs invariant measure corresponding to some Hölder continuous function and to define \mathcal{F}_{kl} as the finite σ -algebra generated by cylinder sets with fixed coordinates having numbers from k to l. The exponentially fast ψ -mixing, which is stronger than ϕ -mixing required here, is well known in the above cases

- (see [5]). Among other dynamical systems with exponentially fast ψ -mixing we can mention also the Gauss map $Fx = \{1/x\}$ (where $\{\cdot\}$ denotes the fractional part) of the unit interval with respect to the Gauss measure G and more general transformations generated by f-expansions (see [17]). Gibbs-Markov maps which are known to be exponentially fast ϕ -mixing (see, for instance, [26]) can be taken as F in Theorem 2.1(i) with $\xi(n) = g \circ F^n$ as above.
- 2.2. Continuous time case. Here we start with a complete probability space (Ω, \mathcal{F}, P) , a P-preserving invertible transformation $\vartheta: \Omega \to \Omega$ and a two parameter family of countably generated σ -algebras $\mathcal{F}_{m,n} \subset \mathcal{F}, -\infty \leq m \leq n \leq \infty$ such that $\mathcal{F}_{mn} \subset \mathcal{F}_{m'n'} \subset \mathcal{F}$ if $m' \leq m \leq n \leq n'$ where $\mathcal{F}_{m\infty} = \bigcup_{n: n \geq m} \mathcal{F}_{mn}$ and $\mathcal{F}_{-\infty n} = \bigcup_{m: m \leq n} \mathcal{F}_{mn}$. The setup includes also a (roof or ceiling) function $\tau: \Omega \to (0, \infty)$ such that for some $\hat{L} > 0$,

$$(2.16) \qquad \qquad \hat{L}^{-1} \le \tau \le \hat{L}.$$

Next, we consider the probability space $(\hat{\Omega}, \hat{\mathcal{F}}, \hat{P})$ such that $\hat{\Omega} = \{\hat{\omega} = (\omega, t) : \omega \in \Omega, 0 \leq t \leq \tau(\omega)\}, (\omega, \tau(\omega)) = (\vartheta\omega, 0)\}, \hat{\mathcal{F}}$ is the restriction to $\hat{\Omega}$ of $\mathcal{F} \times \mathcal{B}_{[0,\hat{L}]}$, where $\mathcal{B}_{[0,\hat{L}]}$ is the Borel σ -algebra on $[0,\hat{L}]$ completed by the Lebesgue zero sets, and for any $\Gamma \in \hat{\mathcal{F}}$,

$$\hat{P}(\Gamma) = \bar{\tau}^{-1} \int_{\Gamma} \mathbb{I}_{\Gamma}(\omega, t) dP(\omega) dt \text{ where } \bar{\tau} = \int \tau dP = E\tau$$

and E denotes the expectation on the space (Ω, \mathcal{F}, P) .

Finally, we introduce a vector valued stochastic process $\xi(t) = \xi(t,(\omega,s)), -\infty < t < \infty, 0 \le s \le \tau(\omega)$ on $\hat{\Omega}$ satisfying

$$\xi(t,(\omega,s)) = \xi(t+s,(\omega,0)) = \xi(0,(\omega,t+s)) \text{ if } 0 \le t+s < \tau(\omega) \text{ and}$$

$$\xi(t,(\omega,s)) = \xi(0,(\vartheta^k\omega,u)) \text{ if } t+s = u + \sum_{i=0}^k \tau(\vartheta^i\omega) \text{ and } 0 \le u < \tau(\vartheta^k\omega).$$

This construction is called in dynamical systems a suspension and it is a standard fact that ξ is a stationary process on the probability space $(\hat{\Omega}, \hat{\mathcal{F}}, \hat{P})$ and in what follows we will write also $\xi(t, \omega)$ for $\xi(t, (\omega, 0))$.

We will assume that $X^{\varepsilon}(t) = X^{\varepsilon}(t,\omega)$ from (1.1) considered as a process on (Ω, \mathcal{F}, P) solves the equation

(2.17)
$$\frac{dX^{\varepsilon}(t)}{dt} = \frac{1}{\varepsilon} \Sigma(X^{\varepsilon}(t)) \xi(t/\varepsilon^{2}) + b(X^{\varepsilon}(t), \xi(t/\varepsilon^{2})), \ t \in [0, T]$$

where the matrix function Σ and the process ξ satisfy (2.5). Set

(2.18)
$$\eta(\omega) = \int_0^{\tau(\omega)} \xi(s,\omega) ds, \quad \hat{b}(x,\omega) = \int_0^{\tau(\omega)} b(x,\xi(s,\omega)) ds \text{ and }$$

$$\rho(n) = \sup_m \max \left(\|\tau \circ \vartheta^m - E(\tau \circ \vartheta^m | \mathcal{F}_{m-n,m+n}) \|_{\infty}, \right.$$

$$\|\eta \circ \vartheta^m - E(\eta \circ \vartheta^m | \mathcal{F}_{m-n,m+n}) \|_{\infty},$$

$$\sup_x \|\hat{b}(x,\cdot) \circ \vartheta^m - E(\hat{b}(x,\cdot) \circ \vartheta^m | \mathcal{F}_{m-n,m+n}) \|_{\infty} \right).$$

Since we will assume that $b(x,\zeta)$ is Lipschitz continuous in the first variable the last \sup_x is still measurable. Observe also that $\eta(k)=\eta\circ\vartheta^k$ and $\hat{b}(x,\cdot)\circ\vartheta^k$, $k\in\mathbb{Z}$ are stationary sequences of random vectors.

Next, we consider a diffusion process Ξ solving the stochastic differential equation (2.11) with $\sigma^2(x) = A(x) = (a_{jk}(x))_{j,k=1,...,d}$, $b(x) = E\hat{b}(x,\cdot)$,

(2.19)
$$a_{jk}(x) = \sum_{i,l=1}^{d} \Sigma_{ji}(x) \varsigma_{il} \Sigma_{lk}(x), \ \varsigma_{ij} = \lim_{n \to \infty} \frac{1}{n} \sum_{k,l=0}^{n} E(\eta_i(k) \eta_j(l))$$

and

(2.20)
$$c_{i}(x) = \sum_{j,k,l=1}^{d} \frac{\partial \Sigma_{ij}(x)}{\partial x_{k}} \left(\hat{\varsigma}_{jl} + \frac{1}{2} E(\eta_{j}(0) \eta_{l}(0)) \right) \Sigma_{kl}(x),$$
$$\hat{\varsigma}_{ij} = \lim_{n \to \infty} \frac{1}{n} \sum_{k=0}^{n} \sum_{l=-n}^{k-1} E(\eta_{i}(k) \eta_{j}(l)) = \sum_{m=1}^{\infty} E(\eta_{i}(m) \eta_{j}(0)).$$

Notice the difference in the definitions of c(x) in (2.9) and in (2.20) which is due to the fact that c(x) is defined here in terms of the process η and not ξ . The following result is a continuous time version of Theorem 2.1(i).

2.3. **Theorem.** Assume that $E\eta = E \int_0^\tau \xi(t) dt = 0$, ξ and Σ satisfy the bound from (2.5) and (2.12)–(2.14) (with ρ from (2.18)) holds true, as well. Then the limits in (2.19) and (2.20) exist and for each $\varepsilon > 0$ the slow motion X^{ε} and the diffusion $\Xi = \Xi^{\varepsilon}$ defined by (2.11) which have the same initial conditions $X^{\varepsilon}(0) = \Xi^{\varepsilon}(0)$ can be redefined preserving their (joint) distributions on the same sufficiently rich probability space, which contains also an i.i.d. sequence of uniformly distributed random variables so that for any integer $M \geq 1$ and numbers $\varepsilon, T > 0$,

(2.21)
$$E \sup_{0 \le t \le T} |X^{\varepsilon}(t) - \Xi^{\varepsilon}(t/\bar{\tau})|^{2M} \le C(M, T)\varepsilon^{\delta}$$

where δ , C(M,T) > 0 do not depend on ε . Here $\Xi = \Xi^{\varepsilon}$ depends on ε in the strong but not in the weak sense, i.e. the coefficients in (2.11) do not depend on ε but for each ε in order to satisfy (2.21) we may have to choose an appropriate Brownian motion $W = W_{\varepsilon}$ which can be obtained from a universal Brownian motion W by rescaling $W_{\varepsilon}(t) = \varepsilon W(\varepsilon^{-2}t)$. In particular, the Prokhorov distance between the distributions of X^{ε} and of Ξ^{ε} is bounded by $(C(M,T)\varepsilon^{\delta})^{1/3}$.

The strategy of the proof of Theorem 2.3 consists of three steps. First, we transform (2.17) to another equation where Σ is the identity matrix. Secondly, we consider a related discrete time setup which is treated by means of Theorem 2.1. Thirdly, we see that the difference between this discrete and the original continuous time processes is small.

The main application to dynamical systems we have here in mind is a C^2 Axiom A flow F^t near an attractor which using Markov partitions can be represented as a suspension over an exponentially fast ψ -mixing transformation so that we can take $\xi(t) = g \circ F^t$ for a Hölder continuous function g and the probability P being a Gibbs invariant measure constructed by a Hölder continuous potential on the base of the Markov partition (see, for instance, [8]). We observe that Prokhorov distance estimates between the distributions of X^{ε} and Ξ^{ε} in the one dimensional case for the (discrete time) suspension setup similar to Theorem 2.3 were obtained recently in [1].

3. Preliminary estimates

3.1. **General lemmas.** First, we will formulate three general results which will be used throughout this paper. The following lemma is well known (see, for instance, Corollary to Lemma 2.1 in [20] or Lemma 1.3.10 in [18]).

3.1. **Lemma.** Let $H(x,\omega)$ be a bounded measurable function on the space $(\mathbb{R}^d \times \Omega, \mathcal{B} \times \mathcal{F})$, where \mathcal{B} is the Borel σ -algebra, such that for each $x \in \mathbb{R}^d$ the function $H(x,\cdot)$ is measurable with respect to a σ -algebra $\mathcal{G} \subset \mathcal{F}$. Let V be an \mathbb{R}^d -valued random vector measurable with respect to another σ -algebra $\mathcal{H} \subset \mathcal{F}$. Then with probability one,

$$(3.1) |E(H(V,\omega)|\mathcal{H}) - h(V)| \le 2\phi(\mathcal{G},\mathcal{H})||H||_{\infty}$$

where $h(x) = EH(x, \cdot)$ and the ϕ -dependence coefficient was defined in (2.1). In particular (which is essentially an equivalent statement), let $H(x_1, x_2), x_i \in \mathbb{R}^{d_i}, i = 1, 2$ be a bounded Borel function and V_i be \mathbb{R}^{d_i} -valued \mathcal{G}_i -measurable random vectors, i = 1, 2 where $\mathcal{G}_1, \mathcal{G}_2 \subset \mathcal{F}$ are sub σ -algebras. Then with probability one,

$$|E(H(V_1, V_2)|\mathcal{G}_1) - h(V_1)| \le 2\phi(\mathcal{G}_1, \mathcal{G}_2) ||H||_{\infty}.$$

We will employ several times the following general moment estimate which appeared as Lemma 3.2.5 in [18] for random variables and was extended to random vectors in Lemma 3.4 from [22].

3.2. **Lemma.** Let (Ω, \mathcal{F}, P) be a probability space, \mathcal{G}_j , $j \geq 1$ be a filtration of σ -algebras and η_j , $j \geq 1$ be a sequence of random d-dimensional vectors such that η_j is \mathcal{G}_j -measurable, $j = 1, 2, \ldots$ Suppose that for some integer $M \geq 1$,

$$A_{2M} = \sup_{i \ge 1} \sum_{j \ge i} ||E(\eta_j|\mathcal{G}_i)||_{2M} < \infty$$

where $\|\eta\|_p = (E|\eta|^p)^{1/p}$ and $|\eta|$ is the Euclidean norm of a (random) vector η . Then for any integer n > 1,

(3.2)
$$E\left|\sum_{j=1}^{n} \eta_{j}\right|^{2M} \leq 3(2M)! d^{M} A_{2M}^{2M} n^{M}.$$

In order to obtain uniform moment estimates required by Theorem 2.1 we will need the following general estimate which appeared as Lemma 3.7 in [22].

3.3. **Lemma.** Let $\eta_1, \eta_2, ..., \eta_N$ be random d-dimensional vectors and $\mathcal{H}_1 \subset \mathcal{H}_2 \subset ... \subset \mathcal{H}_N$ be a filtration of σ -algebras such that η_m is \mathcal{H}_m -measurable for each m = 1, 2, ..., N. Assume also that $E|\eta_m|^q < \infty$ for some q > 1 and each m = 1, ..., N. Set $S_m = \sum_{j=1}^m \eta_j$. Then

$$(3.3) E \max_{1 \le m \le N} |S_m|^q \le 2^{q-1} \left(\left(\frac{q}{q-1} \right)^q E |S_N|^q + E \max_{1 \le m \le N-1} \left| \sum_{j=m+1}^N E(\eta_j |\mathcal{H}_m)|^q \right).$$

- 3.2. Limits, transformations and approximations. The following result deals with the coefficients c(x) and $a_{jk}(x)$ introduced in Section 2 and establishes their properties.
- 3.4. **Lemma.** Under the conditions of Theorem 2.1 the limits (2.7) and (2.10) exist and

(3.4)
$$\hat{\varsigma}_{ij} + \hat{\varsigma}_{ji} = \varsigma_{ij} - E(\xi_i(0)\xi_j(0)).$$

Moreover, uniformly in m for all $m, n \geq 0$,

$$|n\hat{\varsigma}_{ij} - \sum_{k=m}^{m+n} \sum_{l=m-n}^{k-1} \hat{\varsigma}_{ij}(k-l)| \le 2L \sum_{k=0}^{n} \sum_{l=n+k}^{\infty} (L\phi([l/3]) + \rho([l/3]) + L\rho^2([l/3]))$$

and

$$|n\varsigma_{jk}(x) - \sum_{i=m}^{m+n} \sum_{l=m}^{m+n} \varsigma_{jk}(l-i)| \le 2L \sum_{i=0}^{n} \sum_{l=n+i}^{\infty} (L\phi([l/3]) + \rho([l/3]) + L\rho^{2}([l/3])).$$

Finally, c(x) and $b(x) = Eb(x, \xi(0))$ are once and $a_{jk}(x)$ is twice differentiable for j, k = 1, ..., d and for all $x \in \mathbb{R}^d$,

$$|b(x)| \le L$$
, $|\nabla_x b(x)| \le L$, $\max(|c(x)|, |a_{ik}(x)|) \le \hat{L}$

$$= 2L^{3} \sum_{l=0}^{\infty} (L\phi(l) + \rho(l) + L\rho^{2}(l)), \max(|\nabla_{x}c(x)|, |\nabla_{x}a_{jk}(x)|, |\nabla_{x}^{2}a_{jk}(x)|) \le 8\hat{L}$$

where L is the same as in (2.5) and (2.6).

Proof. By (2.3), (2.5), (2.6) and Lemma 3.1,

$$\begin{split} |E(\xi_{j}(l)\xi_{k}(m))| &\leq 2L\rho(|m-l|/3) \\ + |E(E(\xi_{j}(l)|\mathcal{F}_{l-\frac{1}{3}|m-l|,l+\frac{1}{3}|m-l|})E(\xi_{k}(m)|\mathcal{F}_{m-\frac{1}{3}|m-l|,n+\frac{1}{3}|m-l|}))| \\ &\leq 2L(L\phi(|m-l|/3) + \rho(|m-l|/3)). \end{split}$$

By (1.2), (2.3) and (2.6),

and so by (2.3), (2.5), (2.6) and Lemma 3.1,

The existence of the limits (2.7) and (2.10) follow easily from here. The bounds on derivatives of a_{jk} , b and c follow from (2.5), (2.6), (2.7), (2.8), (2.9) and (2.10).

Finally, we write

$$- \sum_{m=0}^{k} \sum_{n=-k}^{-1} E(\xi_i(m)\xi_j(n)) - \sum_{n=0}^{k} \sum_{m=-k}^{-1} E(\xi_i(m)\xi_j(n))$$

and (3.4) follows since by (2.14) and the estimates above

$$\lim_{k \to \infty} \frac{1}{k} \sum_{m=0}^{k} \sum_{n=-k}^{-1} E(\xi_i(m)\xi_j(n)) = \lim_{k \to \infty} \frac{1}{k} \sum_{n=0}^{k} \sum_{m=-k}^{-1} E(\xi_i(m)\xi_j(n)) = 0,$$

completing the proof of this lemma.

Next, under the assumption of Theorem 2.1 we will transform X_N given by (2.4) into a more convenient form to deal with. Let $r: \mathbb{R}^d \to \mathbb{R}^d$, $r(x) = (r_1(x), ..., r_d(x))$ be a map with its Jacobi matrix (differential) given by

which exists in view of (2.13) (see, for instance, Section 8.10 in [14]). Since r is a local diffeomorphism by (2.12), it follows from (2.5) and the classical Hadamard theorem (see, for instance, Theorem 5.1.5 in [2]) that r is a diffeomorphism.

For $x, \zeta \in \mathbb{R}^d$ and i = 1, ..., d set $q(x, \zeta) = (q_1(x, \zeta), ..., q_d(x, \zeta))$ with

$$(3.6) \quad q_{i}(x,\zeta) = \frac{1}{2}(Hr_{i}(x)\Sigma(x)\zeta,\Sigma(x)\zeta) = \frac{1}{2}\sum_{k,l=1}^{d} \frac{\partial^{2}r_{i}(x)}{\partial x_{k}\partial x_{l}}(\Sigma(x)\zeta)_{k}(\Sigma(x)\zeta)_{l}$$

$$= \frac{1}{2}\sum_{k,l,m,n=1}^{d} \frac{\partial \hat{\Sigma}_{ik}(x)}{\partial x_{l}}\Sigma_{km}(x)\Sigma_{ln}(x)\zeta_{m}\zeta_{n}$$

$$= -\frac{1}{2}\sum_{k,l,m,n=1}^{d} \hat{\Sigma}_{ik}(x)\frac{\partial \Sigma_{km}(x)}{\partial x_{l}}\Sigma_{ln}(x)\zeta_{m}\zeta_{n}$$

where H denotes the Hessian and we used that

(3.7)
$$\sum_{k=1}^{d} \left(\frac{\partial \hat{\Sigma}_{ik}(x)}{\partial x_l} \Sigma_{km}(x) + \hat{\Sigma}_{ik}(x) \frac{\partial \Sigma_{km}(x)}{\partial x_l} \right)$$
$$= \frac{\partial}{\partial x_l} \left(\sum_{k=1}^{d} \hat{\Sigma}_{ik}(x) \Sigma_{km}(x) \right) = \frac{\partial}{\partial x_l} (\delta_{im}) = 0.$$

Now introduce $Y_N(t)$, $t \in [0,T]$ defined by the recurrence relation

$$\begin{split} (3.8) & Y_N(\frac{n+1}{N}) = Y_N(n/N) + N^{-1/2}\xi(n) \\ & + N^{-1} \left(\Sigma^{-1}(r^{-1}(Y_N(n/N))b(r^{-1}(Y_N(n/N)),\xi(n)) + q(r^{-1}(Y_N(n/N)),\xi(n)) \right) \\ \text{with } Y_N(0) = r(X_N(0)) \text{ and } Y_N(t) = Y_N(n/N) \text{ whenever } n/N \leq t < \frac{n+1}{N}. \end{split}$$

3.5. Lemma. Set $Z_N(t) = r(X_N(t))$. Then

(3.9)
$$\sup_{0 \le t \le T} |Z_N(t) - Y_N(t)| \le C_1 N^{-1/2}$$

where $C_1 > 0$ does not depend on $N \ge 1$.

Proof. By (3.4) and the Taylor formula

$$+ N^{-1}q(X_{N}(n/N), \xi(n)) + N^{-3/2}\eta_{N}(X_{N}(n/N), X_{N}(\frac{n+1}{N}), \xi(n))$$

$$= N^{-1/2}\xi(n) + N^{-1}\left(\Sigma^{-1}(r^{-1}(Z_{N}(n/N)))b(r^{-1}(Z_{N}(n/N)), \xi(n)) + q(r^{-1}(Z_{N}(n/N)), \xi(n))\right) + N^{-3/2}\eta_{N}(X_{N}(n/N), X_{N}(\frac{n+1}{N}), \xi(n))$$

where η_N is uniformly bounded vector function in view of (2.5) and (2.12), i.e.

(3.11)
$$\sup_{N \ge 1, x, y, \zeta \in \mathbb{R}^d} |\eta_N(x, y, \zeta)| \le C_2$$

for some $C_2 > 0$ which can be estimated explicitly using (2.5) and (2.12).

Next observe that by (2.5), (2.6), (2.13) and (3.5) there exists a constant $L_2 > 0$ (which also can be estimated explicitly from the data of Section 2) such that for all $x, y, \zeta, \eta \in \mathbb{R}^d$ with $|\zeta|, |\eta| \leq L$,

$$\begin{aligned} (3.12) \quad & |\Sigma^{-1}(r^{-1}(x))b(r^{-1}(x),\zeta) - \Sigma^{-1}(r^{-1}(y))b(r^{-1}(y),\zeta)| \leq L_{2}|x-y|, \\ & |\Sigma^{-1}(r^{-1}(x))b(r^{-1}(x),\zeta) - \Sigma^{-1}(r^{-1}(x))b(r^{-1}(x),\eta)| \leq L_{2}|\zeta-\eta|, \\ & |q(r^{-1}(x),\zeta) - q(r^{-1}(y),\zeta)| \leq L_{2}|x-y|, \ |q(r^{-1}(x),\zeta) - q(r^{-1}(x),\eta)| \\ & \leq L_{2}|\zeta-\eta|, \ |\Sigma^{-1}(r^{-1}(x))b(r^{-1}(x),\zeta)| \leq L_{2} \ \text{and} \ |q(r^{-1}(x),\zeta)| \leq L_{2}. \end{aligned}$$

This together with (3.7) and (3.9)–(3.11) yields

Proof. By the Itô formula (see, for instance, Section 7.3 in [21]),

Now set u(x) = Dr(x)c(x). Then by (2.9), (2.10), (2.13) and (3.7),

$$= -\sum_{k,j,l,m=1}^{d} \frac{\partial \hat{\Sigma}_{ij}(x)}{\partial x_{l}} \Sigma_{jk}(x) \hat{\varsigma}_{km} \Sigma_{lm}(x) = -\sum_{k,j,l,m=1}^{d} \frac{\partial \hat{\Sigma}_{il}(x)}{\partial x_{j}} \Sigma_{jk}(x) \hat{\varsigma}_{km} \Sigma_{lm}(x)$$

$$= \sum_{k,j,l,m=1}^{d} \hat{\Sigma}_{il}(x) \Sigma_{jk}(x) \hat{\varsigma}_{km} \frac{\partial \Sigma_{lm}(x)}{\partial x_{j}} = \sum_{k,j,l,m=1}^{d} \hat{\Sigma}_{ij}(x) \frac{\partial \Sigma_{jk}(x)}{\partial x_{l}} \hat{\varsigma}_{mk} \Sigma_{lm}(x).$$

This together with (3.4) yields

Finally, (3.15) follows from here and (3.16).

The transformation appearing in Lemmas 3.5 and 3.6 was employed previously in [16] though full details were provided there only in the one dimensional case. Lemmas 3.5 and 3.6 show that for the proof of Theorem 2.1 it suffices to estimate $E \sup_{0 \le t \le T} |Y_N(t) - \Psi(t)|^{2M}$ which will yield the estimate in (2.15) in view of (2.12) and (3.5). This allows to deal only with the case when X_N is given by (2.4) with $\Sigma(x)$ being a constant matrix. In order to use the ϕ -dependence coefficient effectively it will be convenient to consider the processes $Y_N^{(m)}$, $m \ge 1$ defined for n = 0, 1, ..., [TN] - 1 by the recurrence relation

$$(3.18) Y_N^{(m)}(\frac{n+1}{N}) = Y_N^{(m)}(n/N) + N^{-1/2}\xi^{(m)}(n) + N^{-1}(\hat{b}(r^{-1}(Y_N^{(m)}(n/N)), \xi^{(m)}(n)) + q(r^{-1}(Y_N^{(m)}(n/N)), \xi^{(m)}(n)))$$

where $Y_N^{(m)} = Y_N(0)$, $\xi^{(m)}(n) = E(\xi(n)|\mathcal{F}_{n-m,n+m})$, $\hat{b}(x,\zeta) = \Sigma^{-1}(x)b(x,\zeta)$ and we set $Y_N^{(m)}(t) = Y_N^{(m)}(n/N)$ when $n/N \le t < \frac{n+1}{N}$.

3.7. **Lemma.** For all $m, N \geq 1$,

(3.19)
$$\max_{0 \le n \le |TN|} |Y_N(n/N) - Y_N^{(m)}(n/N)| \le (1 + 2L_2)N^{1/2}\rho(m)e^{2L_2}.$$

Proof. It follows by (3.12) that

$$\le N^{-1/2} n (1 + 2N^{-1/2} L_2) \rho(m) + 2L_2N^{-1} \sum_{k=1}^{n-1} |Y_N(k/N) - Y_N^{(m)}(k/N)|,$$

and so by the discrete Gronwall inequality (see [10]) the estimate (3.19) follows. \Box

 where $1/2 < \kappa < 2/3$ with $0 < \iota < 1$, $n_k = n_k(N) = 3km_N$, $k = 0, 1, ..., [\frac{TN}{3m_N}]$, $Y_{N,k} = Y_N^{(m_N)}(n_k/N)$, $\mathfrak{b}(x,\xi) = \hat{b}(r^{-1}x,\xi) + q(r^{-1}x,\xi)$,

$$\alpha_{N,k} = \sum_{l=n_k}^{n_{k+1}-1} \xi^{(m_N)}(l), \ \beta_{N,k}(x) = \sum_{l=n_k}^{n_{k+1}-1} \mathfrak{b}(x, \xi^{(m_N)}(l))$$

and $\beta_{N,k} = \beta_{N,k}(Y_{N,k-1}).$

Introduce the process

$$\check{Y}_N(n/N) = Y_N^{(m_N)}(0) + \sum_{l=0}^{[n/3m_N]} (N^{-1/2}\alpha_{N,l} + N^{-1}\beta_{N,l}).$$

3.8. **Lemma.** For all $N \ge n > k \ge 0$ and T > 0,

$$\begin{split} Y_N^{(m_N)}(\frac{n_{i+1}}{N}) - Y_N^{(m_N)}(\frac{n_i}{N}) &= N^{-1/2} \sum_{l=n_i}^{n_{i+1}-1} \left(\xi^{(m_N)}(l) + N^{-1/2} \mathfrak{b}(Y_N^{(m_N)}(l/N), \, \xi^{(m_N)}(l))\right) = N^{-1/2} \alpha_{N,i} + N^{-1}(\beta_{N,i} + R_i^{(N)}) \end{split}$$

where relying on (3.12) we estimate $|\mathfrak{b}|$ and the Lipschitz constant of \mathfrak{b} by L_2 and obtain

$$\begin{split} |R_i^{(N)}| &\leq \sum_{l=n_i}^{n_{i+1}-1} |\mathfrak{b}(Y_N^{(m_N)}(l/N),\,\xi^{(m_N)}(l)) - \mathfrak{b}(Y_{N,i-1},\,\xi^{(m_N)}(l))| \\ &\leq L_2 \sum_{l=n_i}^{n_{i+1}-1} |Y_N^{(m_N)}(l/N) - Y_{N,i-1}| \\ &\leq 2N^{-1/2} L_2 \sum_{l=n_i}^{n_{i+1}-1} \sum_{j=n_{i-1}}^{l-1} (j-n_{i-1}) \leq 84L_2 N^{(1-3\kappa/2)}. \end{split}$$

Now, summing in i from $\left[\frac{k}{3m_N}\right]$ to $\left[\frac{n}{3m_N}\right]$ and taking into account that

$$|Y_N^{(m_N)}(n/N) - Y_N^{(m_N)}([\frac{n}{m_N}]m_N)| + |Y_N^{(m_N)}(k/N) - Y_N^{(m_N)}([\frac{k}{m_N}]m_N)|$$

$$\leq 6(L + 2L_2)TN^{-\kappa/2},$$

we obtain (3.20).

- 3.3. Moment and characteristic functions estimates. We will need next the following moment estimate.
- 3.9. **Lemma.** For any $n, M \ge 1$,

(3.21)
$$E\left|\sum_{k=0}^{n-1} \xi(k)\right|^{2M} \le C_3(M)n^M$$

where $C_3(M) > 0$ can be recovered from the proof and it does not depend on n.

Proof. First, we write

$$\left|\sum_{k=0}^{n-1} \xi(k)\right|^{2M} \le d^{2M-1} \sum_{i=1}^{d} \left|\sum_{k=0}^{n-1} \xi_i(k)\right|^{2M}.$$

Set $\zeta_{mr}^{(i)} = E(\xi_i(m)|\mathcal{F}_{m-r,m+r})$. Then by the martingale convergence theorem for the Doob martingale with probability one

(3.22)
$$\xi_i(m) = \lim_{n \to \infty} \zeta_{n2^n}^{(i)} = \zeta_{m1}^{(i)} + \sum_{r=1}^{\infty} (\zeta_{m2^r}^{(i)} - \zeta_{m2^{r-1}}^{(i)}).$$

By (2.3) and (2.6),

$$\|\zeta_{m,2^r}^{(i)} - \xi(m)\|_{\infty} \le 2L\rho(2^r),$$

and so

$$\|\zeta_{m,2^r}^{(i)} - \zeta_{m,2^{r-1}}^{(i)}\|_{\infty} \le 2L(\rho(2^r) + \rho(2^{r-1}))$$

implying that the series (3.22) converges in L^{∞}

Set

$$S_n^{(i)} = \sum_{m=1}^n \xi_i(m), \ S_{n0}^{(i)} = \sum_{m=1}^n \zeta_{m1}^{(i)} \ \text{and} \ S_{nr}^{(i)} = \sum_{m=1}^n (\zeta_{m2^r}^{(i)} - \zeta_{m2^{r-1}}^{(i)}).$$

Put $\mathcal{G}_m^{(r)} = \mathcal{F}_{-\infty,m+2^r}$ and observe that $\zeta_{m2^r}^{(i)}$ is $\mathcal{G}_m^{(r)}$ -measurable. By (2.1) and (2.2) for any $m \geq k+2^{r+1} \geq 2^{r+1}$,

$$|E(\zeta_{m2^r}^{(i)} - \zeta_{m2^{r-1}}^{(i)}|\mathcal{G}_k^{(r)})| \le 2\phi(m - k - 2^{r+1}) \|\zeta_{m2^r}^{(i)} - \zeta_{m2^{r-1}}^{(i)}\|_{\infty}.$$

For $k \le m < k + 2^{r+1}$ we just use the trivial estimate

$$|E(\zeta_{m2^r}^{(i)} - \zeta_{m2^{r-1}}^{(i)}|\mathcal{G}_k^{(r)})| \le \|\zeta_{m2^r}^{(i)} - \zeta_{m2^{r-1}}^{(i)}\|_{\infty}.$$

By (2.1) and (2.2) we have also that for m > k + 2,

$$|E(\zeta_m^{(i)}|\mathcal{G}_k^{(0)})| \le 2L\phi(m-k-2)$$

Combining the above estimates and taking into account (2.5) we obtain that

$$A_{2M}^{(0)} = \sup_{k \ge 1} \sum_{m > k} \|E(\zeta_{m1}^{(i)}|\mathcal{G}_k^{(0)})\|_{2M} \le 2L(1 + \sum_{l=0}^{\infty} \phi(l))$$

and for $r \geq 1$,

$$A_{2M}^{(r)} = \sup_{k \ge 1} \sum_{m > k} \| E(\zeta_{m2^r}^{(i)} - \zeta_{m2^{r-1}}^{(i)} | \mathcal{G}_k^{(r)}) \|_{2M} \le 8\rho(2^{r-1})(2^r + \sum_{l=0}^{\infty} \phi(l))$$

where $\|\cdot\|_p$ is the L^p -norm.

Now, applying Lemma 3.2 it follows that

$$E(S_{mr}^{(i)})^{2M} \le 3(2M)!(A_{2M}^{(r)})^{2M}n^{M}$$

Hence, by the Minkowski (triangle) inequality

$$||S_n^{(i)}||_{2M} \le \sum_{r=0}^{\infty} ||S_{nr}^{(i)}||_{2M} \le (3(2M)!)^{1/2M} \sqrt{n} \sum_{r=0}^{\infty} A_{2M}^{(r)}$$

and rising both parts of this inequality to 2M-th power we obtain (3.21).

Next, for each $n \geq 1$ and $x \in \mathbb{R}^d$ introduce the characteristic function

$$f_n(x, w) = E \exp(i\langle w, n^{-1/2} \sum_{k=0}^{n-1} \xi(k) \rangle), \ w \in \mathbb{R}^d$$

where $\langle \cdot, \cdot \rangle$ denotes the inner product. We will need the following estimate.

3.10. **Lemma.** For any n > 1 and $x \in \mathbb{R}^d$,

$$(3.23) |f_n(x,w) - \exp(-\frac{1}{2}\langle \varsigma w, w \rangle)| \le C_4 n^{-\wp}$$

for all $w \in \mathbb{R}^d$ with $|w| \le n^{\wp/2}$ where the matrix ς is given by (2.7) and we can take $\wp \le \frac{1}{20}$ and a constant $C_4 > 0$ independent of n can be recovered from the proof.

Proof. The left hand side of (3.23) does not exceed 2 and for n < 16 we estimate it by $2(16)^{\wp}n^{-\wp}$ which is at least 2. So, in what follows, we will assume that $n \ge 16$. Since $\xi(k)$ is not supposed to be measurable with respect to \mathcal{F}_{kk} and we have to rely instead on approximation estimates (2.14)), it is not possible to reduce (3.23) directly to one of standard results such as Theorem 3.23 in [12], and so we will provide a proof here which employs the standard block-gap technique.

Set $\nu(n) = [n[n^{3/4} + n^{1/4}]^{-1}], q_k(n) = k[n^{3/4} + n^{1/4}], r_k(n) = q_{k-1}(n) + n^{3/4}$ for $k = 1, 2, ..., \nu(n)$ with $q_0(n) = 0$. Next, we introduce for $k = 1, ..., \nu(n)$,

$$y_k = y_k(n) = \sum_{q_{k-1}(n) \le l < r_k(n)} \xi(l), \ z_k = z_k(n) = \sum_{r_k(n) \le l < q_k(n)} \xi(l)$$

and $z_{\nu(n)+1} = \sum_{q_{\nu(n)-1} \le l < n} \xi(l).$

Then by Lemma 3.9,

(3.24)
$$E|\sum_{1 \le k \le \nu(n)+1} z_k|^2 \le 2\nu(n) \sum_{1 \le k \le \nu(n)} E|z_k|^2 + 2E|z_{\nu(n)+1}|^2$$
$$\le 2C_3(1)((\nu(n))^2 n^{1/4} + n^{3/4}) \le 4C_3(1)n^{3/4}.$$

This together with the Cauchy-Schwarz inequality yields,

$$(3.25) |f_n(x,w) - E \exp(i\langle w, n^{-1/2} \sum_{1 \le k \le \nu(n)} y_k \rangle)|$$

$$\le E |\exp(i\langle w, n^{-1/2} \sum_{1 \le k \le \nu(n)+1} z_k \rangle) - 1| \le n^{-1/2} E \langle w, \sum_{1 \le k \le \nu(n)+1} z_k \rangle$$

$$\le n^{-1/2} |w| E |\sum_{1 \le k \le \nu(n)+1} z_k| \le 2\sqrt{C_3(1)} |w| n^{-1/8}$$

where we use that for any real a, b,

$$|e^{i(a+b)} - e^{ib}| = |e^{ia} - 1| \le |a|.$$

We will obtain (3.23) from (3.25) by estimating

$$(3.26) |E\exp(i\sum_{1\leq k\leq \nu(n)}\eta_k) - \exp(-\frac{1}{2}\langle\varsigma w, w\rangle)| \leq I_1 + I_2$$

where

$$\begin{split} \eta_k &= \langle w, n^{-1/2} y_k \rangle, \ \ I_1 = |E \exp(i \sum_{1 \leq k \leq \nu(n)} \eta_k) - \prod_{1 \leq k \leq \nu(n)} E e^{i \eta_k}| \\ \text{and} \ \ I_2 &= |\prod_{1 \leq k \leq \nu(n)} E e^{i \eta_k} - \exp(-\frac{1}{2} \langle \varsigma w, w \rangle)|. \end{split}$$

First, we write

(3.27)
$$I_{1} \leq \sum_{m=2}^{\nu(n)} \left(|\prod_{m+1 \leq k \leq \nu(n)} E e^{i\eta_{k}} | \right. \\ \times \left| E \exp\left(i \sum_{1 \leq k \leq m} \eta_{k}\right) - E \exp\left(i \sum_{1 \leq k \leq m-1} \eta_{k}\right) E e^{i\eta_{m}} | \right) \\ \leq \sum_{m=2}^{\nu(n)} \left| E \exp\left(i \sum_{1 \leq k \leq m} \eta_{k}\right) - E \exp\left(i \sum_{1 \leq k \leq m-1} \eta_{k}\right) E e^{i\eta_{m}} | \right.$$

where $\prod_{\nu(n)+1 \le k \le \nu(n)} = 1$. Next, using the approximation coefficient ρ and the inequality $|e^{ia} - e^{ib}| \le |a - b|$, valid for any real a and b, we obtain

$$(3.28) |e^{i\eta_m} - \exp(iE(\eta_m | \mathcal{F}_{q_{m-1}(n) - n^{1/4}/3,\infty})))| \le n^{1/2} |w| \rho(n^{1/4}/3)$$

and

(3.29)
$$\left| \exp(i \sum_{1 \le k \le m-1} \eta_k) - \exp(i E(\sum_{1 \le k \le m-1} \eta_k | \mathcal{F}_{-\infty, r_{m-1}(n) + n^{1/4}/3})) \right|$$

 $< n^{-1/2} |w| (m-1) \rho(n^{1/4}/3).$

Hence, by (3.28), (3.29) and Lemma 3.1,

$$(3.30) \quad |E \exp(i \sum_{1 \le k \le m} \eta_k) - E \exp(i \sum_{1 \le k \le m-1} \eta_k) E e^{i\eta_m}|$$

$$\le |E(\exp(i \sum_{1 \le k \le m} \eta_k) - \exp(iE(\sum_{1 \le k \le m-1} \eta_k) \mathcal{F}_{-\infty, r_{m-1}(n) + n^{1/4}/3})$$

$$+ \exp(iE(\eta_m | \mathcal{F}_{q_{m-1}(n) - n^{1/4}/3, \infty})))|$$

$$+ |E(\exp(iE(\sum_{1 \le k \le m-1} \eta_k | \mathcal{F}_{-\infty, r_{m-1}(n) + n^{1/4}/3})$$

$$+ \exp(iE(\eta_m | \mathcal{F}_{q_{m-1}(n) - n^{1/4}/3, \infty})))$$

$$- E \exp(iE(\sum_{1 \le k \le m-1} \eta_k | \mathcal{F}_{-\infty, r_{m-1}(n) + n^{1/4}/3}))$$

$$\times E \exp(iE(\eta_m | \mathcal{F}_{q_{m-1}(n) - n^{1/4}/3, \infty}))|$$

$$+ E |\exp(iE(\sum_{1 \le k \le m} \eta_k) - \exp(iE(\sum_{1 \le k \le m-1} \eta_k | \mathcal{F}_{-\infty, r_{m-1}(n) + n^{1/4}/3}))|$$

$$+ E |e^{i\eta_m} - E \exp(iE(\eta_m | \mathcal{F}_{q_{m-1}(n) - n^{1/4}/3, \infty}))|$$

$$\le \phi(n^{1/4}/3) + 4n^{1/4} |w| m \rho(n^{1/4}/3).$$

This together with (3.27) yields that

$$(3.31) I_1 \le n^{1/4} (\phi(n^{1/4}/3) + 4n^{1/2}|w|\rho(n^{1/4}/3)).$$

In order to estimate I_2 we observe that

$$\left| \prod_{1 \le j \le l} a_j - \prod_{1 \le j \le l} b_j \right| \le \sum_{1 \le j \le l} |a_j - b_j|$$

whenever $0 \le |a_i|, |b_i| \le 1, j = 1, ..., l$, and so

(3.32)
$$I_{2} \leq \sum_{1 \leq k \leq \nu(n)} |Ee^{i\eta_{k}} - \exp(-\frac{1}{2\nu(n)} \langle \varsigma w, w \rangle)|$$
$$\leq \frac{1}{2} \sum_{1 \leq k \leq \nu(n)} |E\eta_{k}^{2} - \frac{1}{\nu(n)} \langle \varsigma w, w \rangle|$$
$$+ \sum_{1 \leq k \leq \nu(n)} E|\eta_{k}|^{3} + \frac{1}{4\nu(n)} |\langle \varsigma w, w \rangle|^{2}$$

where we use (1.2) and that for any real a,

$$|e^{ia} - 1 - ia + \frac{a^2}{2}| \le |a|^3$$
 and $|e^{-a} - 1 + a| \le a^2$ if $a \ge 0$.

Now,

$$E\eta_k^2 = n^{-1}E(\sum_{j=1}^d w_j \sum_{l=q_{k-1}(n)}^{r_k(n)} \xi_j(l))^2$$

= $n^{-1}\sum_{j,l=1}^d w_j w_l \sum_{i=q_{k-1}(n)}^{r_k(n)} \sum_{m=q_{k-1}(n)}^{r_k(n)} \varsigma_{jl}(m-i).$

Hence, by Lemma 3.4,

$$(3.33) |E\eta_k^2 - n^{-1/4} \langle \varsigma w, w \rangle| \le 6Ld|w|^2 n^{-1} \sum_{l=0}^{n^{3/4}} \sum_{m=n^{3/4}+l}^{\infty} (L\phi(m) + \rho(m)).$$

By the estimate of $\varsigma_{ik}(m-l)$ in Lemma 3.4 we have also

$$\begin{aligned} & |(\frac{1}{\nu(n)} - n^{-1/4}) \langle \varsigma w, w \rangle| \\ & \leq 12 L d(L \sum_{l=0}^{\infty} \phi(l) + \sum_{l=0}^{\infty} \rho(l)) |w|^2 ([\frac{n}{n^{3/4} + n^{1/4}}]^{-1} - n^{-1/4}). \end{aligned}$$

Since we assume that $n \geq 16$,

$$(3.35) \qquad \left[\frac{n}{n^{3/4} + n^{1/4}}\right]^{-1} - n^{-1/4} \le \left(\frac{n}{n^{3/4} + n^{1/4}} - 1\right)^{-1} - n^{-1/4}$$
$$= n^{-1/2} \frac{1 + n^{-1/4} + n^{-1/2}}{1 - n^{-1/4} - n^{-3/4}} \le 8n^{-1/2}.$$

By Lemma 3.9, Hölder inequality and the stationarity of the process ξ ,

$$(3.36) E|\eta_k|^3 \le n^{-3/2}|w|^3 \left(E\left(\sum_{l=q_{k-1}(n)}^{r_k(n)} \xi(l)\right)^4\right)^{3/4} \le C_3^{3/4}(2)n^{-3/8}|w|^3.$$

Again, by the estimate of $\varsigma_{jk}(m-l)$ in Lemma 3.4,

(3.37)
$$\frac{1}{\nu(n)} \langle \varsigma w, w \rangle \le 64L dn^{-1/4} |w|^2 \sum_{l=0}^{\infty} (L\phi(l) + \rho(l)).$$

Now, collecting (3.32)–(3.37) we obtain that

(3.38)
$$I_{2} \leq 3Ld|w|^{2}n^{-3/4} \sum_{l=0}^{n^{3/4}} \sum_{m=n^{3/4}+l}^{\infty} (L\phi(m) + \rho(m)) + 112Ld|w|^{2}n^{-1/4} \sum_{l=0}^{\infty} (L\phi(l) + \rho(l)) + C_{3}^{3/4}(2)n^{-1/8}|w|^{3}.$$

Finally, (3.24), (3.25), (3.31) and (3.38) yield (3.23) completing the proof.

Next, we split each time interval $[n_{k-1}, n_k]$ into a block and a gap before it in the following way. Set $l_k = l_k(N) = n_{k-1}(N) + 3[m_N^{1/4}]$,

$$\begin{split} Q_{N,k} &= \sum_{j=l_k}^{n_k-1} \xi^{(m_N^{1/4})}(j), \, R_{N,k}^{(1)} = \sum_{j=l_k}^{n_k-1} (\xi^{(m_N)}(j) - \xi^{(m_N^{1/4})}(j)), \\ R_{N,k}^{(2)} &= \sum_{j=n_{k-1}}^{l_k-1} \xi^{(m_N)}(j) \text{ and } Q_{N,k}(n) = \sum_{k=1}^{k_N(n)} Q_{N,k} \end{split}$$

where $k_N(t) = \max\{k : n_k \le t\}$. Then

$$(3.39) \qquad |\sum_{0 \le k \le k_N(n)} \alpha_{N,k} - Q_{N,k}(n)| \le |R_N^{(1)}(n)| + |R_N^{(2)}(n)|$$

where $\alpha_{N,k}$ was defined before Lemma 3.8 and

$$R_N^{(i)}(n) = |\sum_{1 \le k \le k_N(n)} R_{N,k}^{(i)}|, \ i = 1, 2.$$

It turns out that the contributions of ${\cal R}_N^{(1)}$ and ${\cal R}_N^{(2)}$ are negligible for our purposes as the following lemma shows.

3.11. **Lemma.** For all $N, M \geq 1$,

$$(3.40) E \max_{0 \le n \le T_N} (R_N^{(1)}(n) + R_N^{(2)}(n))^{2M} \le C_5(M) N^{M(3+\kappa)/4}$$

where $C_5(M) > 0$ does not depend on N and it can be recovered from the proof.

Proof. Set $\eta_k^{(i)} = R_{N,k}^{(i)}$, i = 1, 2 and $\mathcal{G}_k = \mathcal{F}_{-\infty,n_k}$. Without loss of generality assume that $N \geq 3^{\frac{8}{3(1-\kappa)}}$, and so $3m_N^{1/4} \leq m_N$. Then $\eta_k^{(1)}$ is \mathcal{G}_{k+1} -measurable and $\eta_k^{(2)}$ is \mathcal{G}_k -measurable. By (2.3), (2.5), (2.6), (2.14) and by Lemma 3.1 we conclude that for $k \geq l+2$,

$$|E(\eta_k^{(1)}|\mathcal{G}_l)| \le 2\phi(n_{k-1} - n_{k-2} - 2m_N) \|\eta_k^{(1)}\|_{\infty}$$

$$\le 12Lm_N \rho(m_N^{1/4})\phi(m_N) \le 12LC_0^2 N^{-5(1-\kappa)/2})$$

and

$$|E(\eta_{l}^{(2)}|\mathcal{G}_{l})| \le 6Lm_{N}^{1/4}\phi(m_{N}) \le 6LC_{0}N^{-17(1-\kappa)/8}.$$

When k = l - 1, k = l or k = l + 1 we will just use the trivial estimates

$$|E(\eta_k^{(1)}|\mathcal{G}_l)| \le 6Lm_N \rho(m_N^{1/4}) = 6LC_0 \text{ and } |E(\eta_k^{(2)}|\mathcal{G}_l)| \le 3Lm_N^{1/4} = 3LN^{(1-\kappa)/8}.$$

Hence,

$$A_{2M}^{(1)} = \max_{1 \le l \le k_N(TN)} \sum_{l \le k \le k_N(TN)} ||E(\eta_k^{(1)}|\mathcal{G}_l)||_{2M}$$

$$\le 6LC_0(2C_0N^{-2+3\kappa} + 3)$$

and

$$A_{2M}^{(2)} = \max_{1 \le l \le k_N(TN)} \sum_{l \le k \le k_N(TN)} ||E(\eta_k^{(2)}|\mathcal{G}_l)||_{2M}$$

$$\le 6L(C_0 N^{-(5-9\kappa)/4} + N^{(1-\kappa)/8}).$$

By Lemmas 3.2 and 3.3 we obtain (3.40) from here (cf. Lemma 4.1 in [21]).

Next, we will need the following corollary of Lemma 3.10.

3.12. **Lemma.** For any $N \ge 1$ and $k \le TN^{(1+\kappa)/2}$, with probability one,

(3.41)
$$|E(\exp(i\langle w, (n_k - l_k)^{-1/2}Q_{N,k}\rangle))|\mathcal{F}_{-\infty,n_{k-1} + m_N^{1/4}}) - g(w)|$$

$$\leq C_4(n_k - l_k)^{-\wp} + C_0(LN^{-2(1-\kappa)} + 2N^{-(1-\kappa)/2}) \leq C_6(n_k - l_k)^{-\wp}$$

for all $w \in \mathbb{R}^d$ with $|w| \leq (n_k - l_k)^{\wp/2}$ where $g_x(w) = \exp(-\frac{1}{2}\langle \varsigma w, w \rangle)$, $C_6 = C_4 + 2C_0(1+3L)$ and $\wp = \frac{1}{20}$.

Proof. Set $F(w) = E \exp(i\langle w, (n_k - l_k)^{-1/2} Q_{N,k} \rangle)$. Then by Lemma 3.1,

$$|E(\exp(i\langle w, (n_k - l_k)^{-1/2}Q_{N,k}\rangle)|\mathcal{F}_{-\infty,n_{k-1} + m_N^{1/4}}) - F(w)|$$

$$\leq 2\phi(m_N^{1/4}) \leq 2\phi(N^{(1-\kappa)/8}).$$

Since $|e^{i(a+b)} - e^{ib}| \le |a|$ we obtain from (2.3) and (2.6) that for all $x \in \mathbb{R}^d$,

$$|F(w) - f_{n_k - l_k}(w)| \le L m_N^{1/2} \rho(m_N),$$

where $f_n(w)$ is the same as in Lemma 3.10, and (3.41) follows from (2.14) and Lemma 3.10.

4. Strong approximations

Our strong approximations will be based on the following result which appears as Theorem 4.6 of [12]. As usual, we will denote by $\sigma\{\cdot\}$ a σ -algebra generated by random variables or vectors appearing inside the braces and we write $\mathcal{G} \vee \mathcal{H}$ for the minimal σ -algebra containing both σ -algebras \mathcal{G} and \mathcal{H} .

4.1. **Theorem.** Let $\{V_m, m \geq 1\}$ be a sequence of random vectors with values in \mathbb{R}^d defined on some probability space (Ω, \mathcal{F}, P) and such that V_m is measurable with respect to \mathcal{G}_m , m = 1, 2, ... where \mathcal{G}_m , $m \geq 1$ is a filtration of sub- σ -algebras of \mathcal{F} . Assume that the probability space is rich enough so that there exists on it a sequence of uniformly distributed on [0,1] independent random variables U_m , $m \geq 1$ independent of $\vee_{m \geq 0} \mathcal{G}_m$. For each $m \geq 1$, let G_m be a probability distribution on \mathbb{R}^d with the characteristic function

$$g_m(w) = \int_{\mathbb{R}^d} \exp(i\langle w, x \rangle) G_m(dx), \ w \in \mathbb{R}^d.$$

Suppose that for some non-negative numbers ν_m , δ_m and $K_m \geq 10^8 d$,

$$(4.1) E|E(\exp(i\langle w, V_m \rangle)|\mathcal{G}_{m-1}) - g_m(w)| \le \nu_m$$

for all w with $|w| \leq K_m$, and that

(4.2)
$$G_m(\{x: |x| \ge \frac{1}{2}K_m\}) < \delta_m.$$

Then there exists a sequence $\{W_m, m \geq 1\}$ of \mathbb{R}^d -valued independent random vectors defined on (Ω, \mathcal{F}, P) such that W_m is $\sigma\{V_m, U_m\}$ -measurable, W_m is independent of $\sigma\{U_1, ..., U_{m-1}\} \vee \mathcal{G}_{m-1}$ (and so also of $W_1, ..., W_{m-1}$) and

$$(4.3) P\{|V_m - W_m| \ge \varrho_m\} \le \varrho_m$$

where $\varrho_m = 16K_m^{-1}\log K_m + 2\nu_m^{1/2}K_m^d + 2\delta_m^{1/2}$. In particular, the Prokhorov distance between the distributions $\mathcal{L}(V_m)$ and $\mathcal{L}(W_m)$ of V_m and W_m , respectively, does not exceed ϱ_m .

In order to apply this theorem we set $V_m = (n_m - l_m)^{-1/2}Q_{N,m}$, $\mathcal{G}_m = \sigma\{V_1,...,V_m\} \subset \mathcal{F}_{-\infty,n_m+m_N^{1/4}}$ and $g_m = g$ defined in Lemma 3.12, so that $G_m = G$ is the mean zero d-dimensional Gaussian distribution with the covariance matrix ς and the characteristic function g. By Lemma 3.12 for $|w| < K_m$,

$$(4.4) E \left| E\left(\exp(i\langle w, V_m \rangle) | \mathcal{G}_{m-1}\right) - g_m(w) \right| \le C_6(n_m - l_m)^{-\wp}$$

where we take $K_m = (n_m - l_m)^{\wp/4d} \leq (n_m - l_m)^{\wp/2}$, $\wp = \frac{1}{20}$ and recall that $n_m - l_m = 3m_N - 3[m_N^{1/4}]$. Theorem 4.1 requires that $K_m \geq 10^8 d$ which will hold true in our case if $N \geq N_0 = N_0(\kappa, \wp) = (10^{256d/\wp} d^{32d/\wp})^{1/(1-\kappa)}$.

Next, let Ψ be a mean zero Gaussian random variable with the covariance matrix ς . Then by estimates of Lemma 3.4 and the Chebyshev inequality,

(4.5)
$$G(\{y \in \mathbb{R}^d : |y| \ge \frac{1}{2}(n_m - l_m)^{\frac{\wp}{4d}}\})$$

$$\le P\{|\Psi| \ge \frac{1}{2}(n_m - l_m)^{\frac{\wp}{4d}}\} \le 4L^2d(n_m - l_m)^{-\frac{\wp}{2d}}$$

$$= 4L^2d3^{-\wp/2d}n^{-\wp(1-\kappa)/16d}(N^{3(1-\kappa)/8} - 1)^{-\wp/2d}.$$

Now, Theorem 4.1 provides us with independent random vectors $\{W_m, m \geq 1\}$ having the mean zero Gaussian distribution with the covariance matrix ς and such that

$$(4.6) \ \varrho_m = \varrho_m(N) = 4\frac{\varrho}{d}(n_m - l_m)^{-\wp/4d} \log(n_m - l_m) + 2C_6^{1/2}(n_m - l_m)^{-\wp/4d} + 2L\sqrt{d}3^{-\wp/4d}N^{-\wp(1-\kappa)/32d}(N^{3(1-\kappa)/8} - 1)^{-\wp/4d} < C_7N^{-\wp(1-\kappa)/8d}$$

where $C_7 > 0$ does not depend on $N \ge 1$.

As a crucial corollary of Theorem 4.1 we will obtain next a uniform L^{2M} -bound on the difference between the sums of $(n_k - l_k)^{1/2} V_k$'s and of $(n_k - l_k)^{1/2} W_k$'s. Set

$$I(n) = \sum_{k: n_k \le n} (n_k - l_k)^{1/2} (V_k - W_k).$$

4.2. **Lemma.** For any integers $N \geq N_0(\kappa, \wp)$ and $M \geq 1$,

(4.7)
$$E \max_{0 \le n \le NT} |I(n)|^{2M} \le C_8(M) N^{M - \frac{\varphi}{20d}(1-\kappa)}$$

where $\wp = \frac{1}{20}$, $0 < \kappa < \frac{\iota}{4+\iota}$ and $C_8(M) > 0$ does not depend on N.

Proof. The proof of (4.7) will rely on Lemmas 3.2 and 3.3, and so we will have to estimate the conditional expectations appearing there taking into account that V_k is $\mathcal{G}_k \subset \mathcal{F}_{-\infty,n_k+m_N^{1/4}}$ -measurable and W_k is $\mathcal{G}_k \vee \sigma\{U_1,...,U_k\}$ -measurable. Let $k > j \geq 1$. Since W_k is independent of $\mathcal{G}_{k-1} \vee \sigma\{U_1,...,U_{k-1}\}$ we obtain that

(4.8)
$$E(W_k | \mathcal{G}_i \vee \sigma\{U_1, ..., U_i\}) = EW_k = 0.$$

Next, since V_k is independent of $\sigma\{U_1, ..., U_j\}$ and the latter σ -algebra is independent of \mathcal{G}_j we obtain that (see, for instance, [9], p. 323),

(4.9)
$$E(V_k|\mathcal{G}_i \vee \sigma\{U_1, ..., U_i\}) = E(E(V_k|\mathcal{G}_{i\vee(k-2)})|\mathcal{G}_i).$$

By Lemma 3.1,

(4.10)
$$|E(V_k|\mathcal{G}_{j\vee(k-2)})|$$

$$= (n_k - l_k)^{-1/2} |\sum_{i=l_k}^{n_k - 1} E\xi^{(m_N^{1/4})}(i)|\mathcal{F}_{-\infty, n_j\vee n_{k-2} + m_N^{1/4}})|$$

$$\leq L(n_k - l_k)^{-1/2} \sum_{i=l_k}^{n_k - 1} (\phi(i - n_j \vee n_{k-2} - 2m_N^{1/4}) + \rho(m_N^{1/4})).$$

Now, in order to bound A_{2M} from Lemma 3.2 it remains to consider the case k=n, i.e. to estimate $||V_k-W_k||_{2M}$ and then to combine it with (4.8)–(4.10). By the Cauchy–Schwarz inequality for any $n \geq 1$,

(4.11)
$$E|V_{k} - W_{k}|^{2M} = E(|V_{k} - W_{k}|^{2M} \mathbb{I}_{|V_{k} - W_{k}| \leq \varrho_{k}})$$

$$+ E(|V_{k} - W_{k}|^{2M} \mathbb{I}_{|V_{k} - W_{k}| > \varrho_{k}})$$

$$\leq \varrho_{k}^{2M} + (E|V_{k} - W_{k}|^{4M})^{1/2} (P\{|V_{k} - W_{k}| > \varrho_{k}\}^{\frac{1}{2}}$$

$$\leq \varrho_{k}^{2M} + \varrho_{k}^{\frac{1}{2}} 2^{2M} ((E|V_{k}|^{4M})^{1/2} + (E|W_{k}|^{4M})^{1/2}).$$

By Lemmas 3.1 and 3.9,

$$(4.12) (E|V_k|^{4M})^{1/2} \le (C_3(2M) + 2\phi(m_N))L^{4M}(n_k - l_k)^{2M})^{1/2}.$$

Since W_k is a mean zero d-dimensional Gaussian random vector with the covariance matrix ς we obtain that

(4.13)
$$E|W_k|^{4M} = \leq |\varsigma^{1/2}|^{4M} ((4M)!)^{d/2}.$$

Finally, combining (4.8)–(4.13) with Lemmas 3.2 and 3.3 we derive (4.7) completing the proof (cf. Lemma 4.4 in [22]).

Next, let W(t), $t \geq 0$ be a standard d-dimensional Brownian motion. Then the sequences of random vectors $\tilde{W}_k^{\varepsilon} = \varsigma^{1/2}(W(n_k) - W(l_k))$ and $(n_k - l_k)^{1/2}W_k$, $k \leq k_N(TN)$ have the same distributions. Hence, by Lemma A1 from [7] the sequences $\xi(k)$ and W_k , $k \geq 1$ can be redefined without changing their joint distributions on a richer probability space where there exists a standard d-dimensional Brownian motion W(t) such that the pairs (V_k, W_k) and $(V_k, (n_k - l_k)^{-1/2} \varsigma^{1/2}(W(n_k) - W(l_k)))$, $k \leq k_N(TN)$, constructed by means of the redefined processes, have the same joint distributions. Thus we can assume from now on that

$$W_k = (n_k - l_k)^{-1/2} \varsigma^{1/2} (W(n_k) - W(l_k)))$$

and that these W_k 's satisfy properties asserted in Theorem 4.1, so that Lemma 4.2 holds true for them, as well.

Next, using the Brownian motion W(t), $t \ge 0$ constructed above we consider the new Brownian motion $W_N(t) = N^{-1/2}W(tN)$ and introduce the diffusion process $\Psi_N(t)$, $t \ge 0$ solving the stochastic differential equation (3.15) which we write now with W_N as,

$$d\Psi_N(t) = \varsigma^{1/2} dW_N(t) + \mathfrak{b}(\Psi_N(t)) dt, \ \Psi_N(0) = x_0$$

where $\mathfrak{b}(x) = E\mathfrak{b}(x,\xi(0))$. Now, we introduce the auxiliary process $\hat{\Psi}_N$ with coefficients frozen at times n_k/N , $k \leq k_N(TN)$,

$$\hat{\Psi}_N(t) = x_0 + W_N(n_{k_N(tN)}/N)) + N^{-1} \sum_{1 \le k \le k_N(tN)} \mathfrak{b}(\Psi_N(n_{k-2}/N))(n_k - n_{k-1})$$

where $n_{-1} = n_0 = 0$ and $k_N(s)$ was defined before Lemma 3.11, and estimate its deviation from Ψ_N .

4.3. **Lemma.** For all integers $M, N \geq 1$,

$$(4.14) E \max_{0 \le k \le k_N(TN)} |\Psi_N(n_k/N) - \hat{\Psi}_N(n_k/N)|^{2M} \le C_9(M) N^{-M(2+\kappa)/2}$$

where $C_9(M) > 0$ does not depend on N.

Proof. It follows from (3.12) that \mathfrak{b} has the Lipschitz constant $2L_2$, and taking into account also the Cauchy–Schwarz inequality we have that

$$E \max_{0 \le k \le k_N(TN)} |\Psi_N(n_k/N) - \hat{\Psi}_N(n_k/N)|^{2M}$$

$$\le 2^{2M} L_2^{2M} N^{-(2M-1)} \sum_{0 \le k \le k_N(TN)} \int_{n_{k-1}/N}^{n_k/N} E|\Psi_n(t) - \Psi_N(n_{k-2}/N)|^{2M} dt.$$

Now, for $n_{k-1}/N \le t \le n_k/N$,

$$\begin{split} E|\Psi_N(t) - \Psi_N(n_{k-2}/N)|^{2M} \\ & \leq 2^{M-1} (|\varsigma^{1/2}|^{2M} E|W_N(t) - W_N(n_{k-2}/N)|^{2M} + E|\int_{n_{k-2}/N}^{n_k/N} \mathfrak{b}(\Psi_N(s)) ds|^{2M}) \\ & \leq 2^{2M-1} (\frac{6m_N}{N})^M (d^{2M}(2M)! |\varsigma^{1/2}|^{2M} + L_2^{2M} (\frac{6m_N}{N})^M) \end{split}$$

and
$$(4.14)$$
 follows.

Next, we define

$$\hat{Y}_N(t) = x_0 + \sum_{0 \le k \le k_N(tN)} \left(N^{-1/2} \alpha_{N,k} + N^{-1} \mathfrak{b}(Y_{N,k-1}) (n_{k+1} - n_k) \right)$$

where $\alpha_{N,k}$ is the same as in Lemma 3.8. In order to use the estimate of Lemma 3.8 we will need first to compare \hat{Y}_N with the sum appearing there.

4.4. **Lemma.** For all $N \geq 1$,

(4.15)
$$E \sup_{0 \le t \le T} |\hat{Y}_N(t) - \breve{Y}_N(t)|^{2M} \le C_{10}(M) N^{-\frac{M}{2}\min(\frac{1}{2}, 5 - 7\kappa)}$$

where \check{Y}_N is the same as in Lemma 3.8 and $C_{10}(M) > 0$ does not depend on N.

Proof. The left hand side of (4.15) equals $N^{-2M}E\sup_{0 \le t \le T} |J(t)|^{2M}$ where

$$J(t) = \sum_{0 \le k < k_N(tN)} (\mathfrak{b}(Y_{N,k-1})(n_{k+1} - n_k) - \beta_{N,k}).$$

Now, by (2.1), (2.3), (3.12) and Lemma 3.1 for any $k \ge l + 1$,

$$(4.16) \qquad |E(\mathfrak{b}(Y_{N,k-1})(n_{k+1} - n_k) - \beta_{N,k})|\mathcal{F}_{-\infty,n_l+m_N})|$$

$$= |E(\sum_{j=n_k}^{n_{k+1}} E(\mathfrak{b}(Y_{N,k-1}) - \mathfrak{b}(Y_{N,k-1}, \xi(j)) + \mathfrak{b}(Y_{N,k-1}, \xi(j))$$

$$-\mathfrak{b}(Y_{N,k-1}, \xi^{(m_N)}(j))|\mathcal{F}_{-\infty,n_{k-1}+m_N})|\mathcal{F}_{-\infty,n_l+m_N})|$$

$$\leq LN^{(1-\kappa)/2}(4\phi(N^{(1-\kappa)/2}) + \rho(N^{(1-\kappa)/2})).$$

When l = k + 1 then $\mathfrak{b}(Y_{N,k-1})(n_{k+1} - n_k) - \beta_{N,k}$ is $\mathcal{F}_{-\infty,n_l}$ -measurable and we estimate the left hand side of (4.16) then and when l = k just by $2LN^{(1-\kappa)/2}$. Thus, relying on Lemmas 3.2, 3.3 and 3.9 we obtain

$$(4.17) E \sup_{0 \le t \le T} |J(t)|^{2M} \le \tilde{C}(M) N^{M(3-\kappa)/2} (1 + N^{M(1+\kappa)} (\phi(N^{(1-\kappa)/2}) + \rho(N^{(1-\kappa)/2}))^{2M}$$

for some
$$\tilde{C}(M) > 0$$
 independent of N .

Next, denote

$$\tilde{\Psi}_N(t) = x_0 + \varsigma^{1/2} W_N(n_{k_N(tN)}/N) + N^{-1} \sum_{0 \le k < k_N(tN)} \mathfrak{b}(Y_{N,k-1})(n_{k+1} - n_k).$$

Then

$$(4.18) E \sup_{0 \le s \le T} |\hat{Y}_N(s) - \hat{\Psi}^{\varepsilon}(s)|^{2M} \le 2^{2M-1} (E \max_{0 \le k < k_N(TN)} |\hat{Y}_N(n_k/N) - \tilde{\Psi}_N(n_k/N)|^{2M} + E \max_{0 \le k < k_N(TN)} |\tilde{\Psi}_N(n_k/N) - \hat{\Psi}_N(n_k/N)|^{2M}).$$

By Lemmas 3.3, 3.11 and 4.2 for any $N \geq N_0(\kappa, \wp)$,

$$(4.19) E \max_{0 \le k \le n} |\hat{Y}_N(n_k/N) - \tilde{\Psi}_N(n_k/N)|^{2M}$$

$$\le 2^{2M-1} N^{-M} \left(E \sup_{0 \le t \le T} |I(t)|^{2M} + E \max_{1 \le n \le N} (|R_N^{(1)}(n)| + |R_N^{(2)}(n)|)^{2M} \right)$$

$$\le C_{11}(M) \left(N^{-\frac{\mathcal{P}}{20d}(1-\kappa)} + N^{-M(1-\kappa)/4} \right)$$

where $C_{11}(M) > 0$ does not depend on n and N.

In order to estimate the second term in the right hand side of (4.18) introduce the σ -algebras $\mathcal{Q}_s = \mathcal{F}_{-\infty,s+m_N} \vee \sigma\{W(u), 0 \leq u \leq s\}$ and observe that by our construction for each k the increment $W(n_{k+1}) - W(l_{k+1})$ is independent of $\mathcal{Q}_{n_{k-1}}$. On the other hand, for any $k \geq n$ both $Y_{N,k}$ and $\Psi_N(n_k/N)$ are \mathcal{Q}_{n_k} -measurable. Observe that

$$(4.20) E \max_{0 \le k \le k_N(TN)} |\tilde{\Psi}_N(n_k/N) - \hat{\Psi}_N(n_k/N)|^{2M}$$

$$\le 2^{2M-1} (E \max_{0 \le k \le k_N(TN)} |\mathcal{I}_1(n_k)|^{2M} + E \max_{0 \le k \le k_N(TN)} |\mathcal{I}_2(n_k)|^{2M})$$

where

$$\mathcal{I}_1(n_k) = N^{-1} \sum_{0 < l < k-1} (\mathfrak{b}(Y_N(n_{l-1}/N)) - \mathfrak{b}(\Xi_N(n_{l-1}/N)))(n_{l+1} - n_l)$$

and

$$\mathcal{I}_2(n_k) = \sum_{0 \le j \le k-1} \varsigma^{1/2} (W_N(l_{j+1}/N) - W_N(n_j/N)).$$

By the estimates of Lemma 3.4 and the Lipschitz continuity of ${\mathfrak b}$ we have

$$(4.21) |\mathcal{I}_2(n_k)|^{2M} \le C_{13}(M) \frac{m_N}{NT} \sum_{0 \le l \le k-1} |Y_N^{(m_N)}(n_{l-1}/N) - \Psi_N(n_{l-1}/N)|^{2M}$$

for some $C_{13} > 0$ which does not depend on N or k. Since $\mathcal{I}_2(n_k)$ can be viewed as a stochastic integral we can rely on the corresponding martingale moment inequalities (see Section 1.7 in [25]) which yields that

$$(4.22) E \max_{0 \le j \le k} |\mathcal{I}_2(n_j)|^{2M} \le \left(\frac{2M}{2M-1}\right)^{2M} E |\mathcal{I}_2(n_k)|^{2M} \le C_{14} N^{-3(1-\kappa)/8}$$

for some $C_{14}(M) > 0$ independent of N.

Now denote

$$G_k = E \max_{0 \le l \le k} |Y_N^{(m_N)}(n_l/N) - \Psi_N(n_l/N)|^{2M}.$$

Then we obtain from (4.14), (4.15) and (4.18)–(4.22) that for $n \leq k_N(TN)$ and $N \geq N_0(\kappa, \wp)$,

$$G_n \le (2^{2M} C_{11}(M) + 3^{2M} C_{14}(M)) N^{-\frac{\wp}{20d}(1-\kappa)} + 2^{2M-1} (C_{12}(M) + C_{13}(M)) \frac{m_N}{NT} \sum_{0 \le k \le n-1} G_k.$$

By the discrete (time) Gronwall inequality (see, for instance, [10]).

$$(4.23) G_{k_N(TN)} \le (2^{2M} C_{11}(M) + 3^{2M} C_{14}(M)) N^{-\frac{\wp}{20d}(1-\kappa)} \exp((2^{2M} + 3^{2M})(C_{12}(M) + C_{13}(M)))$$

and Theorem 2.1 follows taking into account (2.6), (3.5) and Lemmas 3.5–3.7. (cf. Section 4.4 in [22]).

5. Continuous time case

We start with a diffeomorphism $r: \mathbb{R}^d \to \mathbb{R}^d$ satisfying (3.5) and set $Z^{\varepsilon}(t) = r(X^{\varepsilon}(t))$. Then

(5.1)
$$\frac{dZ^{\varepsilon}(t)}{dt} = Dr(X^{\varepsilon}(t))\frac{dX^{\varepsilon}(t)}{dt} = \frac{1}{\varepsilon}\xi(t/\varepsilon^{2}) + \mathfrak{b}(Z^{\varepsilon}(t), \xi(t/\varepsilon^{2}))$$

where $\mathfrak{b}(z,\zeta) = Dr(r^{-1}(z))b(r^{-1}(z),\zeta)$. Taking into account Lemma 3.4 we see that the limits in (2.19) and (2.20) exist and we can define the diffusion Ξ by (2.11). In view of the definition of c(x) in (2.20) the computations of Lemma 3.6 yield that the process $\Psi(t) = r(\Xi(t))$ solves the stochastic differential equation

(5.2)
$$d\Psi(t) = \varsigma^{1/2} dW(t) + \mathfrak{b}(\Psi(t)) dt$$

where $\mathfrak{b}(z) = E\mathfrak{b}(z, \eta(0))$. Hence, in order to prove (2.21) it suffices to show that for each $\varepsilon > 0$ both Z^{ε} and $\Psi = \Psi^{\varepsilon}$ can be redefined on (Ω, \mathcal{F}, P) preserving their distributions so that for any $\varepsilon, T > 0$ and an integer $M \ge 1$,

(5.3)
$$E \sup_{0 \le t \le T} |Z^{\varepsilon}(t) - \Psi(t/\bar{\tau})|^{2M} \le C_1(M, T) \varepsilon^{\delta_1}$$

for some δ_1 , $C_1(M,T) > 0$ independent of ε .

Changing the time $s = t/\varepsilon^2$ we can write (5.4)

$$Z^{\varepsilon}(s\varepsilon^{2}) = Z^{\varepsilon}(s\varepsilon^{2}, \omega) = Z^{\varepsilon}(0, \omega) + \varepsilon \int_{0}^{s} \xi(u, \omega) du + \varepsilon^{2} \int_{0}^{s} \mathfrak{b}(Z^{\varepsilon}(u\varepsilon^{2}, \omega), \xi(u, \omega)) du.$$

Set $\Theta_n(\omega) = \sum_{j=0}^{n-1} \tau \circ \theta^j(\omega)$, $\Theta_0(\omega) = 0$. Introduce the discrete time processes $Y^{\varepsilon}(m\varepsilon^2,\omega) = Y^{\varepsilon}(m\varepsilon^2,(\omega,0))$ by the recurrence relation $Y^{\varepsilon}(0,\omega) = Z^{\varepsilon}(0,\omega) = Z^{\varepsilon}(0,(\omega,0))$ and for $n \geq 0$,

$$(5.5) Y^{\varepsilon}((n+1)\varepsilon^{2},\omega) = Y^{\varepsilon}(n\varepsilon^{2},\omega) + \varepsilon \int_{\Theta_{n}(\omega)}^{\Theta_{n+1}(\omega)} \xi(u,\omega) du$$

$$+ \varepsilon^{2} \int_{\Theta_{n}(\omega)}^{\Theta_{n+1}(\omega)} \mathfrak{b}(Y^{\varepsilon}(n\varepsilon^{2},\omega), \xi(u,\omega)) du$$

$$= Y^{\varepsilon}(n\varepsilon^{2},\omega) + \varepsilon \eta \circ \vartheta^{n}(\omega) + \varepsilon^{2} \hat{\mathfrak{b}}(Y^{\varepsilon}(n\varepsilon^{2},\omega),\cdot) \circ \vartheta^{n}$$

where $\hat{\mathfrak{b}}(z,\omega) = Dr(r^{-1}(z))\hat{b}(r^{-1}(z),\omega)$.

5.1. **Lemma.** For all $\varepsilon > 0$, $\omega \in \Omega$ and an integer $N \ge 1$, (5.6)

$$\max_{0 \le n < N} \sup_{\Theta_n(\omega) \le s < \Theta_{n+1}(\omega)} |Z^{\varepsilon}(s\varepsilon^2, \omega) - Y^{\varepsilon}(n\varepsilon^2, \omega)| \le \varepsilon (1+\varepsilon) L \hat{L} \exp(L^3(L^2+1)\hat{L}N\varepsilon^2).$$

Proof. Set

$$Q(n,\omega) = \sup_{\Theta_n(\omega) \le s < \Theta_{n+1}(\omega)} |Z^{\varepsilon}(s\varepsilon^2,\omega) - Y^{\varepsilon}(n\varepsilon^2,\omega)|.$$

Then by (2.5), (2.6), (2.12), (3.5) and the definition of \mathfrak{b} ,

$$(5.7) Q(n+1,\omega) \le L^3(L^2+1)\varepsilon^2 \sum_{k=0}^n Q(k,\omega)\tau \circ \vartheta^k(\omega) + \varepsilon L\tau \circ \vartheta^n(\omega)(1+\varepsilon)$$

since $|\mathfrak{b}(z,\omega)-\mathfrak{b}(y,\omega)| \leq L^3(L^2+1)|z-y|$. Then by (2.16) and the discrete Gronwall inequality we see that for all integers $n \geq 1$,

$$Q(n,\omega) \le \varepsilon(1+\varepsilon)L\hat{L}\exp(L^3(L^2+1)\hat{L}n\varepsilon^2)$$

and
$$(5.6)$$
 follows.

Next, observe that we can apply Theorem 2.1 to the process Y^{ε} . Indeed, though we have here the terms $\hat{\mathfrak{b}}(z,\cdot)\circ\vartheta^n$ which are slightly more general than $\hat{\mathfrak{b}}(z,\eta\circ\vartheta^n)$ appearing in the setup of Theorem 2.1 but, in fact, we used there only the appropriate decay of the approximation coefficient ρ together with the Lipschitz continuity of coefficients in the second variable given by (2.6) which is replaced here by the coefficient ρ in (2.18) playing the same role (with no need in additional Lipschitz continuity) and the proof proceeds in the same way. Moreover, if (Ω, \mathcal{F}, P) is Lebesgue (or standard probability) space then we can always represent $\hat{\mathfrak{b}}(z,\cdot)\circ\vartheta^n$ in the form $\hat{\mathfrak{b}}(z,\zeta\circ\vartheta^n)$, where $\zeta(n)=\zeta\circ\vartheta^n$ is a real valued stationary process, and considering the two component stationary process $(\eta\circ\vartheta^n,\zeta\circ\vartheta^n)_{n\in\mathbb{Z}}$ we come back to the setup of Theorem 2.1. Observe also that though in Theorem 2.1 we considered only subsequences $\varepsilon=\varepsilon_N=1/N$ the assertion remains true for all small $\varepsilon>0$. Indeed, let $(N_\varepsilon+1)^{-1}\leq \varepsilon^2< N_\varepsilon^{-1}$. Then

$$\begin{split} |Y^{\varepsilon}(n\varepsilon^2) - Y^{N_{\varepsilon}^{-1/2}}(nN_{\varepsilon}^{-1})| &\leq |\varepsilon - N_{\varepsilon}^{-1/2}| \sum_{k=0}^{n-1} \eta \circ \vartheta^k| \\ + \varepsilon^2 L^3(L^2 + 1) \sum_{k=0}^{n-1} |Y^{\varepsilon}(k\varepsilon^2) - Y^{N_{\varepsilon}^{-1/2}}(kN_{\varepsilon}^{-1})| + L^2 T \varepsilon^{-2} |\varepsilon^2 - N_{\varepsilon}^{-1}|. \end{split}$$

By the discrete Gronwall inequality

$$\max_{0 \leq n \leq T/\varepsilon^2} |Y^\varepsilon(n\varepsilon^2) - Y^{N_\varepsilon^{-1/2}}(nN_\varepsilon^{-1})| \leq \tilde{C}(\frac{\varepsilon^3}{\sqrt{1-\varepsilon^2}} \max_{0 \leq n \leq T/\varepsilon^2} |\sum_{k=0}^{n-1} \eta \circ \vartheta^k| + \frac{\varepsilon^2}{1-\varepsilon^2}).$$

where $\tilde{C} > 0$ does not depend on ε . Applying Lemmas 3.1–3.3 to the right hand side here (similarly to Lemmas 3.9, 4.4 and Lemma 5.2 below) we obtain that

$$E \max_{0 \le n \le T/\varepsilon^2} |Y^{\varepsilon}(n\varepsilon^2) - Y^{N_{\varepsilon}^{-1/2}}(nN_{\varepsilon}^{-1})|^{2M} \le \tilde{\tilde{C}} \frac{\varepsilon^{2M}}{(1 - \varepsilon^2)^M},$$

for some $\tilde{C} > 0$ independent of ε , showing that we can apply Theorem 2.1 for all $\varepsilon > 0$ when X^{ε} is in the form (1.3) and not only when the parameters restricted to the sequence $\varepsilon_N = 1/\sqrt{N}$ provided, of course, other conditions of this assertion

Applying Theorem 2.1 we obtain that both Y^{ε} and the diffusion $\Psi = \Psi^{\varepsilon}$ can be redefined on (Ω, \mathcal{F}, P) without changing their distributions so that for any $\varepsilon > 0$ and an integer $M \geq 1$,

(5.8)
$$\sup_{0 \le t \le T/\bar{\tau}} |Y^{\varepsilon}(t) - \Psi^{\varepsilon}(t)|^{2M} \le C_2(M, T) \varepsilon^{\delta_2}$$

for some δ_2 , $C_2(M,T) > 0$ independent of ε where we set $Y^{\varepsilon}(t) = Y^{\varepsilon}(n\varepsilon^2)$ if $n\varepsilon^2 \le t < (n+1)\varepsilon^2$.

Now we have

(5.9)
$$\sup_{0 \le t \le T} |Z^{\varepsilon}(t) - \Psi^{\varepsilon}(t/\bar{\tau})|^{2M} \le 3^{2M-1} (E \sup_{0 \le t \le T} |I_1^{\varepsilon}(t)|^{2M} + E \sup_{0 \le t \le T} |I_2^{\varepsilon}(t)|^{2M} + E \sup_{0 \le t \le T} |I_3^{\varepsilon}(t)|^{2M})$$

where

$$I_1^\varepsilon(t) = Y^\varepsilon(t/\bar{\tau}) - \Psi^\varepsilon(t/\bar{\tau}), \ I_2^\varepsilon(t) = \sup_{\Theta_{[t/\varepsilon^2\bar{\tau}]}(\omega) \leq s < \Theta_{[t/\varepsilon^2\bar{\tau}]}(\omega) + 1} |Y^\varepsilon(t/\bar{\tau},\omega) - Z^\varepsilon(s\varepsilon^2,\omega)|$$

and

(5.10)

$$\widehat{I_3^{\varepsilon}(t)} = \sup_{\Theta_{[t/\varepsilon^2\bar{\tau}]}(\omega) \leq s < \Theta_{[t/\varepsilon^2\bar{\tau}]}(\omega) + 1} |Z^{\varepsilon}(t,\omega) - Z^{\varepsilon}(s\varepsilon^2,\omega)| \leq \varepsilon L\bar{\tau}(1+\varepsilon L) + \sup_{0 \leq t \leq T} |I_4^{\varepsilon}(t)|$$

where

$$I_4^{\varepsilon}(t) = Z^{\varepsilon}(t,\omega) - Z^{\varepsilon}(\varepsilon^2 \Theta_{[t/\varepsilon^2 \bar{\tau}]}(\omega), \omega).$$

The first and the second terms of (5.9) are estimated by (5.8) and (5.7), respectively, and so in view of (5.10) in order to derive (5.3) it remains to prove the following result.

5.2. **Lemma.** For $\varepsilon > 0$ and an integer $M \geq 1$,

(5.11)
$$E \sup_{0 \le t \le T} |I_4^{\varepsilon}(t)|^{2M} \le C_3(M, T) \varepsilon^{\delta_3}$$

for some δ_3 , $C_3(M,T) > 0$ which do not depend on ε .

Proof. Set

$$n(t,\omega) = \max\{k : \Theta_k(\omega) \le t\}, \ \Gamma(t,q) = \{\omega : |n(t,\omega) - [t/\bar{\tau}]| > q\}$$

and $\Delta(k,q) = \{\omega : |\Theta_k(\omega) - \bar{\tau}k| > q\}.$ Then by (2.5) and (2.16),
$$|I^{\varepsilon}(t)| \le \varepsilon L \hat{I}(1 + I^{\varepsilon}(t) + \bar{\tau}) + \varepsilon I^{\varepsilon}([t/\varepsilon^2\bar{\tau}]) + \varepsilon^2 L^2 L(t)$$

$$(5.12) \qquad |I_4^\varepsilon(t)| \leq \varepsilon L \hat{L}(1+J_1^\varepsilon(t)+\bar{\tau}) + \varepsilon J_2^\varepsilon([t/\varepsilon^2\bar{\tau}]) + \varepsilon^2 L^2 J_3(t)$$

where

(5.13)

$$J_1^{\varepsilon}(t) = \mathbb{I}_{\Gamma(t/\varepsilon^2, \varepsilon^{-3/2})} |\Theta_{[t/\varepsilon^2 \bar{\tau}]} - t/\varepsilon^2| \leq \mathbb{I}_{\Delta([t/\varepsilon^2 \bar{\tau}], \varepsilon^{-3/2} - \hat{L} - 2\hat{L}^{-1})} |\Theta_{[t/\varepsilon^2 \bar{\tau}]} - \bar{\tau}[t/\varepsilon^2 \bar{\tau}]|,$$

(5.14)
$$J_2(m) = \max_{0 \le n \le \varepsilon^{-3/2}} |\sum_{k: |k-m| \le n} \eta \circ \vartheta^k|$$

and

$$J_3^{\varepsilon}(t) = |\Theta_{[t/\varepsilon^2\bar{\tau}]} - t/\varepsilon^2| \le |\Theta_{[t/\varepsilon^2\bar{\tau}]} - \bar{\tau}[t/\varepsilon^2\bar{\tau}]| + \bar{\tau}.$$

By (2.5), (2.16), (2.18) and Lemma 3.1 for any $l \ge 1$,

(5.16)
$$|E(\tau \circ \vartheta^{k+l} - \bar{\tau}|\mathcal{F}_{-\infty,k})|$$

$$\leq |E(\tau \circ \vartheta^{k+l} - E(\tau \circ \vartheta^{k+l}|\mathcal{F}_{k+l-[l/3],k+l+[l/3]})|\mathcal{F}_{-\infty,k})|$$

$$+|E(E(\tau \circ \vartheta^{k+l}|\mathcal{F}_{k+l-[l/3],k+l+[l/3]}) - \bar{\tau}|\mathcal{F}_{-\infty,k})| \leq \rho([l/3]) + 2\hat{L}\phi([l/3])$$

and similarly,

$$|E(\eta \circ \vartheta^{k+l} | \mathcal{F}_{-\infty,k})| \le \rho([l/3]) + 2L\bar{\tau}\phi([l/3]).$$

This together with (2.14) and Lemmas 3.2 and 3.3 yields that for any $n, N \ge 1$,

(5.17)
$$E \max_{0 \le k \le n} |\Theta_k - k\bar{\tau}|^{2N} \le C_4(N) n^N$$

and

(5.18)
$$E \max_{0 \le k \le n} |\sum_{j=0}^{n} \eta \circ \vartheta^{j}|^{2N} \le C_4(N) n^N$$

for some $C_4(N) > 0$ independent of n.

Hence, for any $N \geq 1$,

(5.19)
$$E \sup_{0 < t < T} |J_3^{\varepsilon}(t)|^{2N} \le 2^{2N-1} (C_4(N)[T/\varepsilon^2 \bar{\tau}]^N + \bar{\tau}^N)$$

and by the stationarity of the sequence $\eta \circ \vartheta^k$, $k \in \mathbb{Z}$,

(5.20)
$$E \sup_{0 \le t \le T} (J_2^{\varepsilon}([t/\varepsilon^2 \bar{\tau}]))^{2N} \le E \max_{0 \le m \le T/\varepsilon^2 \bar{\tau}} (J_2^{\varepsilon}(m))^{2N}$$
$$\le \frac{T}{\varepsilon^2 \bar{\tau}} E(J_2^{\varepsilon}(0))^{2N} \le C_4(N) 2^N T \bar{\tau}^{-1} \varepsilon^{-(2+\frac{3}{2}N)}$$

and by the Cauchy-Schwarz inequality,

$$E \sup_{0 \le t \le T} (J_3^{\varepsilon}(t))^{2N} \le E \max_{0 \le n \le T/\varepsilon^2 \bar{\tau}} (\mathbb{I}_{\Delta(n,\varepsilon^{-3/2} - \hat{L} - 2\hat{L}^{-1})} |\Theta_n - \bar{\tau}n|^{2N})$$

$$\le \sum_{0 \le n \le T/\varepsilon^2 \bar{\tau}} E(\mathbb{I}_{\Delta(n,\varepsilon^{-3/2} - \hat{L} - 2\hat{L}^{-1})} |\Theta_n - \bar{\tau}n|^{2N})$$

$$\le \sum_{0 \le n \le T/\varepsilon^2 \bar{\tau}} \left(P(\Delta(n,\varepsilon^{-3/2} - \hat{L} - 2\hat{L}^{-1})) E|\Theta_n - \bar{\tau}n|^{4N} \right)^{1/2}$$

By (5.17) and the Chebyshev inequality for any $K \geq 1$,

$$P(\Delta(n, \varepsilon^{-3/2} - \hat{L} - 2\hat{L}^{-1})) \le (\varepsilon^{-3/2} - \hat{L} - 2\hat{L}^{-1})^{-2K} (T/\bar{\tau})^K \varepsilon^{-2K},$$

and so

(5.21)
$$E \sup_{0 \le t \le T} (J_1^{\varepsilon}(t))^{2N} \le C_5(K, N, T) \varepsilon^{\frac{1}{2}K - 2N - 2}$$

for some $C_5(K, N, T) > 0$ independent of $\varepsilon > 0$. Finally, we obtain (5.11) from (5.12)–(5.15) and (5.19)–(5.21) taking N = M and K > 4(M-1), completing the proof of both Lemma 5.2 and Theorem 2.3.
