# STRONG DIFFUSION APPROXIMATION IN AVERAGING WITH DYNAMICAL SYSTEMS FAST MOTIONS

#### Abstract

The paper deals with the fast-slow motions setups in the continuous time $\left.\frac{d X^{\varepsilon}(t)}{d t}=\frac{1}{\varepsilon} \Sigma\left(X^{\varepsilon}(t)\right) \xi\left(t / \varepsilon^{2}\right)\right)+b\left(X^{\varepsilon}(t), \xi\left(t / \varepsilon^{2}\right), t \in[0, T]\right.$ and the discrete time $X^{\varepsilon}\left((n+1) \varepsilon^{2}\right)=X^{\varepsilon}\left(n \varepsilon^{2}\right)+\varepsilon \Sigma\left(X^{\varepsilon}\left(n \varepsilon^{2}\right)\right) \xi(n)+\varepsilon^{2} b\left(X^{\varepsilon}\left(n \varepsilon^{2}\right), \xi(n)\right)$, $n=0,1, \ldots,\left[T / \varepsilon^{2}\right]$ where $\Sigma$ and $b$ are smooth matrix and vector functions and $\xi$ is a stationary vector stochastic process with weakly dependent terms and such that $E \xi(0)=0$. The assumptions imposed on the process $\xi$ allow applications to a wide class of observables $g$ in the dynamical systems setup so that $\xi$ can be taken in the form $\xi(t)=g\left(F^{t} \xi(0)\right)$ or $\xi(n)=g\left(F^{n} \xi(0)\right)$ where $F$ is either a flow or a diffeomorphism with some hyperbolicity and $g$ is a vector function. In this paper we show that both $X^{\varepsilon}$ and a family of diffusions $\Xi^{\varepsilon}$ can be redefined on a common sufficiently rich probability space so that $E \sup _{0<t<T}\left|X^{\varepsilon}(t)-\Xi^{\varepsilon}(t)\right|^{p} \leq C \varepsilon^{\delta}, p \geq 1$ for some $C, \delta>0$ and all $\varepsilon>0$, where all $\bar{\Xi}^{\varepsilon}, \varepsilon>0$ have the same diffusion coefficients but underlying Brownian motions may change with $\varepsilon$.


## 1. Introduction

Let $X^{\varepsilon}$ be the solution of a system of ordinary differential equations having the form

\frac{d X^{\varepsilon}(t)}{d t}=\frac{1}{\varepsilon} \Sigma\left(X^{\varepsilon}(t)\right) \xi\left(t / \varepsilon^{2}\right)+b\left(X^{\varepsilon}(t), \xi\left(t / \varepsilon^{2}\right)\right), t \in[0, T] \tag{1.1}
\end{equation*}
$$

where $\Sigma(x)$ and $b(x, \xi(s))$ are Lipschitz continuous matrix and vector fields on $\mathbb{R}^{d}$ and $\xi$ is a stationary process which is viewed as a fast motion while $X^{\varepsilon}$ is considered as a slow motion. Assume also that for $s=0$ (and so for all $s$ ),

E \xi(s) \equiv 0 \tag{1.2}
\end{equation*}

It was shown in a series of papers [20, 30] and [4] that $X^{\varepsilon}$ (considered in a more general form) converges weakly as $\varepsilon \rightarrow 0$ to a diffusion process provided $\xi$ is sufficiently fast mixing with respect to $\sigma$-algebras generated by $\xi$ itself. It turns out that the latter condition is quite restrictive when $\xi$ is generated by a dynamical system, i.e. when $\xi(t)=g \circ F^{t}$ where $g$ is a vector function and $F^{t}$ is a

[^0]flow (continuous time dynamical system) preserving certain measure which makes $\xi$ a stationary process. In order to derive weak convergence of $X^{\varepsilon}$ to a diffusion for $\xi$ generated by a sufficiently large class of dynamical systems other approaches were developed recently based mainly on the rough paths theory (see [23], [11] and references there). All above mentioned results can be obtained both in the continuous time setup (1.1) and in the discrete time setup given by the following recurrence relation

\end{equation*}

where $0 \leq n<\left[T / \varepsilon^{2}\right]$ and $\xi(n), n \geq 0$ is a stationary sequence of random vectors. Observe that the above results can be viewed as a substantial generalization of the functional central limit theorem since when $\Sigma(x)$ does not depend on $x$ and $b \equiv 0$ the process $X^{\varepsilon}$ weakly converges to the Brownian motion (with a covariance matrix).

Another, completely different, line of research dealt with extension of limit theorems for sums of random variables from convergence in distribution or weak convergence to strong approximations or strong invariance principles results. This was done first for independent random variables and martingales in [32 and extended to weakly dependent random variables in [31, dealing in both cases with the one dimensional case since their proofs were based on the martingale approximation and the Skorokhod embedding theorem. The latter does not work, in general, in the multidimensional case (see [29]) and another method was developed in [7] to tackle the case of sums $S_{n}=\xi_{1}+\cdots+\xi_{n}$ of weakly dependent random vectors. We observe that until recently (see [27] where the general case was treated) all papers dealing with strong approximations in the multidimensional case starting with 7 (see [12] and references there) considered weak dependence or mixing with respect to $\sigma$-algebras generated by random vector summands $\xi(n), n \geq 0$ themselves which is quite restrictive in applications to dynamical systems. Only in the one dimensional case, which is based on the martingale approximation and the Skorokhod embedding, 31 considers a more general weak dependence setup which allowed to extend strong approximation theorems to dynamical systems in 13 but only for one dimensional observables.

Recently, strong $L^{p}$ diffusion approximations appeared in the first time for slow motions $X^{\varepsilon}$ from (1.1) and (1.3) in [22]. The results there are valid in the multidimensional case but only assuming weak dependence of the processes $\xi(t), t \geq 0$ in (1.1) and $\xi(n), n \geq 0$ in (1.3) with respect to the $\sigma$-algebras generated by these random variables (vectors) themselves which, as mentioned above, allows applications to rather restricted class of observables in the dynamical systems setup. The purpose of this paper is to extend $L^{p}$ diffusion approximations results assuming more general weak dependence conditions which turns out to lead to substantial difficulties and will be achieved here only in certain situations. Such extension allows applications to a larger and natural class of vector observables in the dynamical systems setup. We stress that our goal is to obtain for each parameter value certain $L^{p}$ bounds on errors of diffusion approximations which is somewhat different from eventual almost sure bounds derived usually in the papers on strong approximations which dealt before only with sums of random variables (or vectors), and so the limiting process there was always the Brownian motion (with covariances).

## 2. Preliminaries and main Results

2.1. Discrete time case. We start with the discrete time setup which consists of a complete probability space $(\Omega, \mathcal{F}, P)$, a stationary sequence of random vectors $\xi(n),-\infty<n<\infty$ and a two parameter family of countably generated $\sigma$-algebras $\mathcal{F}_{m, n} \subset \mathcal{F},-\infty \leq m \leq n \leq \infty$ such that $\mathcal{F}_{m n} \subset \mathcal{F}_{m^{\prime} n^{\prime}} \subset \mathcal{F}$ if $m^{\prime} \leq m \leq n \leq n^{\prime}$ where $\mathcal{F}_{m \infty}=\cup_{n: n \geq m} \mathcal{F}_{m n}$ and $\mathcal{F}_{-\infty n}=\cup_{m: m \leq n} \mathcal{F}_{m n}$. We will measure the dependence between $\bar{\sigma}$-algebras $\mathcal{G}$ and $\mathcal{H}$ by the $\phi$-coefficient defined by

\phi(\mathcal{G}, \mathcal{H})=\sup \left\{\left|\frac{P(\Gamma \cap \Delta)}{P(\Gamma)}-P(\Delta)\right|: P(\Gamma) \neq 0, \Gamma \in \mathcal{G}, \Delta \in \mathcal{H}\right\}  \tag{2.1}\\
=\frac{1}{2} \sup \left\{\|E(g \mid \mathcal{G})-E g\|_{\infty}: g \text { is } \mathcal{H} \text {-measurable and }\|g\|_{\infty}=1\right\}
\end{gather*}
$$

(see [6]) where $\|\cdot\|_{\infty}$ is the $L^{\infty}$-norm. For each $n \geq 0$ we set also

\begin{equation*}
\phi(n)=\sup _{m} \phi\left(\mathcal{F}_{-\infty, m}, \mathcal{F}_{m+n, \infty}\right) . \tag{2.2}
\end{equation*}

If $\phi(n) \rightarrow 0$ as $n \rightarrow \infty$ then the probability measure $P$ is called $\phi$-mixing with respect to the family $\left\{\mathcal{F}_{m n}\right\}$. Unlike [22], in order to ensure more applicability of our results to dynamical systems, we do not assume that $\xi(n)$ is $\mathcal{F}_{n n}$-measurable and instead we will work with the approximation coefficient

\rho(n)=\sup _{m}\left\|\xi(m)-E\left(\xi(m) \mid \mathcal{F}_{m-n, m+n}\right)\right\|_{\infty} \tag{2.3}
\end{equation*}
$$

To save notations we will still write $\mathcal{F}_{m n}, \phi(n)$ and $\rho(n)$ for $\mathcal{F}_{[m][n]}, \phi([n])$ and $\rho([n])$, respectively, if $m$ and $n$ are not integers (or $\pm \infty$ ), where [.] denotes the integral part.

We will deal with the recurrence relation (1.3) where we set $X_{N}=X^{1 / \sqrt{N}}$ so that (1.3) takes the form

X_{N}(n+1 / N)=X_{N}(n / N)+\frac{1}{\sqrt{N}} \Sigma\left(X_{N}(n / N)\right) \xi(n)+\frac{1}{N} b\left(X_{N}(n / N), \xi(n)\right) \tag{2.4}
\end{equation*}
$$

and this definition is extended to all $t \in[0, T]$ by setting $X_{N}(t)=X_{N}(n / N)$ whenever $n / N \leq t<(n+1) / N$. We will assume that $\Sigma(x)$ and $b(x, \cdot)$ are twice and once differentiable in the first variable, respectively, and $b$ is Lipschitz continuous in the second variable. To avoid excessive technicalities these coefficients are supposed to satisfy the following uniform bounds

& E \xi(0)=0,\|\xi(0)\|_{\infty} \leq L, \sup _{x \in \mathbb{R}^{d}} \max \left(|\Sigma(x)|,\left|\nabla_{x} \Sigma(x)\right|,\left|\nabla_{x}^{2} \Sigma(x)\right|\right) \leq L  \tag{2.5}\\
& \sup _{x, y \in \mathbb{R}^{d}} \max \left(|b(x, y)|,\left|\nabla_{x} b(x, y)\right|\right) \leq L \text { and }|b(x, y)-b(x, z)| \leq L|y-z| \tag{2.6}
\end{align*}
$$

for some constant $1 \leq L<\infty$ and all $x, y, z \in \mathbb{R}^{d}$, where $\Sigma=\left(\Sigma_{i j}, 1 \leq i, j \leq d\right)$ and $b=\left(b_{1}, \ldots, b_{d}\right)$ are $d$-dimensional matrices and vectors and we take the Euclidean norms.

Set

$$
a_{j k}(x, m, n)=\sum_{i, l=1}^{d} \Sigma_{j i}(x) \varsigma_{i l}(n-m) \Sigma_{l k}(x)
$$

where $\varsigma_{i l}(n-m)=E\left(\xi_{i}(m) \xi_{l}(n)\right)=E\left(\xi_{i}(0) \xi_{l}(n-m)\right)$. We will see that under the conditions of the theorem below there exist limits

\varsigma_{i j}=\lim _{k \rightarrow \infty} \frac{1}{k} \sum_{m=0}^{k} \sum_{n=0}^{k} \varsigma_{i j}(n-m) \tag{2.7}

where $\varsigma=\left(\varsigma_{i j}\right)$, and so, for $j, k=1, \ldots, d$,

a_{j k}(x)=\lim _{n \rightarrow \infty} \frac{1}{n} \sum_{k=0}^{n} \sum_{l=0}^{n} a_{j k}(x, k, l)=\sum_{i, l=1}^{d} \Sigma_{j i}(x) \varsigma_{i l} \Sigma_{l k}(x) . \tag{2.8}
\end{equation*}

The matrix $A(x)=\left(a_{j k}(x)\right)=\Sigma(x) \varsigma \Sigma^{*}(x)$ is twice differentiable if $\Sigma(x)$ is. Since $\varsigma$ is symmetric and nonnegatively definite, there exists $\varsigma^{1 / 2}$ such that $\varsigma^{1 / 2} \varsigma^{1 / 2}=\varsigma$. Set $\sigma(x)=\Sigma(x) \varsigma^{1 / 2}$,

c_{i}(x, m, n)=\sum_{j, k, l=1}^{d} \frac{\partial \Sigma_{i j}(x)}{\partial x_{k}} \varsigma_{j l}(n-m) \Sigma_{k l}(x)
$$

and

$$
\begin{equation*}
c_{i}(x)=\sum_{j, k, l=1}^{d} \frac{\partial \Sigma_{i j}(x)}{\partial x_{k}} \hat{\varsigma}_{j l} \Sigma_{k l}(x), i=1, \ldots, d \tag{2.9}
\end{equation*}
$$

where

$$
\begin{equation*}
\hat{\varsigma}_{j l}=\lim _{k \rightarrow \infty} \frac{1}{k} \sum_{n=0}^{k} \sum_{m=-k}^{n-1} \varsigma_{j l}(n-m)=\sum_{m=1}^{\infty} E\left(\xi_{j}(m) \xi_{l}(0)\right) \tag{2.10}
\end{equation*}
$$

and the latter limit will be shown to exist under our conditions. It turns out that $\sigma$, $b(x)=E b(x, \xi(m))$ and $c(x)$ are Lipschitz continuous, and so there exists a unique solution $\Xi$ of the stochastic differential equation

$$
\begin{equation*}
d \Xi(t)=\sigma(\Xi(t)) d W(t)+(b(\Xi(t))+c(\Xi(t))) d t \tag{2.11}
\end{equation*}
$$

where $W$ is the standard $d$-dimensional Brownian motion. When a non negatively definite symmetric matrix $A(x)$ is fixed then any solution of (2.11) with any matrix $\sigma$ satisfying $A(x)=\sigma(x) \sigma^{*}(x)$ has the same path distribution since this leads to the same Kolmogorov equation and to the same martingale problem (see [33]).
2.1. Theorem. Suppose that (1.2) is satisfied, $X_{N}$ is defined by (2.4) with $b$ and $\Sigma$ satisfying (2.5) and (2.6). Assume that $\Sigma^{-1}(x)=\left(\hat{\Sigma}_{i j}(x)\right)$ exists,

\frac{\partial \hat{\Sigma}_{i j}(x)}{\partial x_{k}}=\frac{\partial \hat{\Sigma}_{i k}(x)}{\partial x_{j}} \text { for all } i, j, k=1, \ldots, d \tag{2.13}
\end{gather*}

(which is automatically satisfied if $d=1$ ), and

$$
\begin{equation*}
\phi(n), \rho(n) \leq C_{0} n^{-4} \tag{2.14}
\end{equation*}
$$

for some constant $C_{0}>0$ and all $n \geq 1$. Then for each $N \geq 1$ the slow motion $X$ and the diffusion $\Xi$ having the same initial condition $X_{N}(0)=\Xi_{N}(0)$ can be redefined preserving their distributions on the same sufficiently rich probability space,
which contains also an i.i.d. sequence of uniformly distributed random variables, so that for any integers $N, M \geq 1$ and $T>0$,

E \sup _{0 \leq t \leq T}\left|X_{N}(t)-\Xi_{N}(t)\right|^{2 M} \leq C(M, T) N^{-\delta} \tag{2.15}
\end{equation*}
$$

where $\delta, C(M, T)>0$ do not depend on $N$ and they can be explicitly recovered from the proof. Here $\Xi=\Xi_{N}$ depends on $N$ in the strong but not in the weak sense, i.e. the coefficients in (2.11) do not depend on $N$ but for each $N$ in order to satisfy (2.15) we may have to choose an appropriate Brownian motion $W=W_{N}$ which can be obtained from a universal Brownian motion $\mathcal{W}$ by rescaling $W_{N}(t)=$ $N^{-1 / 2} \mathcal{W}(N t)$. In particular, the Prokhorov distance between the distributions of $X_{N}$ and of $\Xi_{N}$ is bounded by $\left(C(M, T) N^{-\delta}\right)^{1 / 3}$.

The conditions of Theorem 2.1 enable us in Section 3 to reduce the setup to the situation where $\Sigma$ in (2.4) is the identity matrix. This allows to replace the process $\xi(n)$ by a process $\xi^{m_{N}}(n)=E\left(\xi(n) \mid \mathcal{F}_{n-m_{N}, n+m_{N}}\right)$ with an appropriate $m_{N} \rightarrow \infty$ as $N \rightarrow \infty$ which, in turn, enables us to use the $\phi$-mixing effectively. After the replacement of $\xi(n)$ by $\xi^{m_{N}}(n)$ we rely on the strong approximation theorem and arrive at the required estimate comparing several auxiliary processes.
2.2. Remark. The reduction of the setup of Theorem 2.1 to the situation where $\Sigma$ is the the identity map allows to obtain an almost sure version of the result, namely, to show that as $N \rightarrow \infty$ almost surely,

\sup _{0 \leq t \leq T}\left|X_{N}(t)-\Xi_{N}(t)\right|=O\left(N^{-\hat{\delta}}\right)
$$

for some $\hat{\delta}>0$ independent of $N$.
Important classes of processes satisfying our conditions come from dynamical systems. Let $F$ be a $C^{2}$ Axiom A diffeomorphism (in particular, Anosov) in a neighborhood of an attractor or let $F$ be an expanding $C^{2}$ endomorphism of a Riemannian manifold $\Omega$ (see [5), $g$ be a either Hölder continuous vector functions or vector functions which are constant on elements of a Markov partition and let $\xi(n)=\xi(n, \omega)=g\left(F^{n} \omega\right)$. Here the probability space is $(\Omega, \mathcal{B}, P)$ where $P$ is a Gibbs invariant measure corresponding to some Hölder continuous function and $\mathcal{B}$ is the Borel $\sigma$-field. Let $\zeta$ be a finite Markov partition for $F$ then we can take $\mathcal{F}_{k l}$ to be the finite $\sigma$-algebra generated by the partition $\cap_{i=k}^{l} F^{i} \zeta$. In fact, we can take here not only Hölder continuous $g$ 's but also indicators of sets from $\mathcal{F}_{k l}$. The conditions of Theorem 2.1 allow all such functions since the dependence of Hölder continuous functions on $m$-tails, i.e. on events measurable with respect to $\mathcal{F}_{-\infty,-m}$ or $\mathcal{F}_{m, \infty}$, decays exponentially fast in $m$ and the condition (2.14) is even weaker than that. A related class of dynamical systems corresponds to $F$ being a topologically mixing subshift of finite type which means that $F$ is the left shift on a subspace $\Omega$ of the space of one (or two) sided sequences $\omega=\left(\omega_{i}, i \geq 0\right), \omega_{i}=1, \ldots, l_{0}$ such that $\omega \in \Omega$ if $\pi_{\omega_{i} \omega_{i+1}}=1$ for all $i \geq 0$ where $\Pi=\left(\pi_{i j}\right)$ is an $l_{0} \times l_{0}$ matrix with 0 and 1 entries and such that $\Pi^{n}$ for some $n$ is a matrix with positive entries. Again, we have to take in this case $g$ to be Hölder continuous bounded functions on the sequence space above, $P$ to be a Gibbs invariant measure corresponding to some Hölder continuous function and to define $\mathcal{F}_{k l}$ as the finite $\sigma$-algebra generated by cylinder sets with fixed coordinates having numbers from $k$ to $l$. The exponentially fast $\psi$-mixing, which is stronger than $\phi$-mixing required here, is well known in the above cases
(see [5]). Among other dynamical systems with exponentially fast $\psi$-mixing we can mention also the Gauss map $F x=\{1 / x\}$ (where $\{\cdot\}$ denotes the fractional part) of the unit interval with respect to the Gauss measure $G$ and more general transformations generated by $f$-expansions (see [17]). Gibbs-Markov maps which are known to be exponentially fast $\phi$-mixing (see, for instance, [26]) can be taken as $F$ in Theorem 2.1(i) with $\xi(n)=g \circ F^{n}$ as above.
2.2. Continuous time case. Here we start with a complete probability space $(\Omega, \mathcal{F}, P)$, a $P$-preserving invertible transformation $\vartheta: \Omega \rightarrow \Omega$ and a two parameter family of countably generated $\sigma$-algebras $\mathcal{F}_{m, n} \subset \mathcal{F},-\infty \leq m \leq n \leq \infty$ such that $\mathcal{F}_{m n} \subset \mathcal{F}_{m^{\prime} n^{\prime}} \subset \mathcal{F}$ if $m^{\prime} \leq m \leq n \leq n^{\prime}$ where $\mathcal{F}_{m \infty}=\cup_{n: n \geq m} \mathcal{F}_{m n}$ and $\mathcal{F}_{-\infty n}=$ $\cup_{m: m \leq n} \mathcal{F}_{m n}$. The setup includes also a (roof or ceiling) function $\tau: \Omega \rightarrow(0, \infty)$ such that for some $\hat{L}>0$,

\hat{L}^{-1} \leq \tau \leq \hat{L} \tag{2.16}
\end{equation*}

Next, we consider the probability space $(\hat{\Omega}, \hat{\mathcal{F}}, \hat{P})$ such that $\hat{\Omega}=\{\hat{\omega}=(\omega, t): \omega \in$ $\Omega, 0 \leq t \leq \tau(\omega)\},(\omega, \tau(\omega))=(\vartheta \omega, 0)\}, \hat{\mathcal{F}}$ is the restriction to $\hat{\Omega}$ of $\mathcal{F} \times \mathcal{B}_{[0, \hat{L}]}$, where $\mathcal{B}_{[0, \hat{L}]}$ is the Borel $\sigma$-algebra on $[0, \hat{L}]$ completed by the Lebesgue zero sets, and for any $\Gamma \in \hat{\mathcal{F}}$,

\hat{P}(\Gamma)=\bar{\tau}^{-1} \int_{\Gamma} \mathbb{I}_{\Gamma}(\omega, t) d P(\omega) d t \text { where } \bar{\tau}=\int \tau d P=E \tau
$$

and $E$ denotes the expectation on the space $(\Omega, \mathcal{F}, P)$.
Finally, we introduce a vector valued stochastic process $\xi(t)=\xi(t,(\omega, s)),-\infty<$ $t<\infty, 0 \leq s \leq \tau(\omega)$ on $\hat{\Omega}$ satisfying

\begin{gathered}
\xi(t,(\omega, s))=\xi(t+s,(\omega, 0))=\xi(0,(\omega, t+s)) \text { if } 0 \leq t+s<\tau(\omega) \text { and } \\
\xi(t,(\omega, s))=\xi\left(0,\left(\vartheta^{k} \omega, u\right)\right) \text { if } t+s=u+\sum_{j=0}^{k} \tau\left(\vartheta^{j} \omega\right) \text { and } 0 \leq u<\tau\left(\vartheta^{k} \omega\right) .
\end{gathered}
$$

This construction is called in dynamical systems a suspension and it is a standard fact that $\xi$ is a stationary process on the probability space $(\hat{\Omega}, \hat{\mathcal{F}}, \hat{P})$ and in what follows we will write also $\xi(t, \omega)$ for $\xi(t,(\omega, 0))$.

We will assume that $X^{\varepsilon}(t)=X^{\varepsilon}(t, \omega)$ from (1.1) considered as a process on $(\Omega, \mathcal{F}, P)$ solves the equation

where the matrix function $\Sigma$ and the process $\xi$ satisfy (2.5). Set

Since we will assume that $b(x, \zeta)$ is Lipschitz continuous in the first variable the last $\sup _{x}$ is still measurable. Observe also that $\eta(k)=\eta \circ \vartheta^{k}$ and $\hat{b}(x, \cdot) \circ \vartheta^{k}, k \in \mathbb{Z}$ are stationary sequences of random vectors.

Next, we consider a diffusion process $\Xi$ solving the stochastic differential equation (2.11) with $\sigma^{2}(x)=A(x)=\left(a_{j k}(x)\right)_{j, k=1, \ldots, d}, b(x)=E \hat{b}(x, \cdot)$,

Notice the difference in the definitions of $c(x)$ in (2.9) and in (2.20) which is due to the fact that $c(x)$ is defined here in terms of the process $\eta$ and not $\xi$. The following result is a continuous time version of Theorem [2.1(i).
2.3. Theorem. Assume that $E \eta=E \int_{0}^{\tau} \xi(t) d t=0, \xi$ and $\Sigma$ satisfy the bound from (2.5) and (2.12)-(2.14) (with $\rho$ from (2.18)) holds true, as well. Then the limits in (2.19) and (2.20) exist and for each $\varepsilon>0$ the slow motion $X^{\varepsilon}$ and the diffusion $\Xi=\Xi^{\varepsilon}$ defined by (2.11) which have the same initial conditions $X^{\varepsilon}(0)=\Xi^{\varepsilon}(0)$ can be redefined preserving their (joint) distributions on the same sufficiently rich probability space, which contains also an i.i.d. sequence of uniformly distributed random variables so that for any integer $M \geq 1$ and numbers $\varepsilon, T>0$,

Here $\Xi=\Xi^{\varepsilon}$ depends on $\varepsilon$ in the strong but not in the weak sense, i.e. the coefficients in (2.11) do not depend on $\varepsilon$ but for each $\varepsilon$ in order to satisfy (2.21) we may have to choose an appropriate Brownian motion $W=W_{\varepsilon}$ which can be obtained from a universal Brownian motion $\mathcal{W}$ by rescaling $W_{\varepsilon}(t)=\varepsilon \mathcal{W}\left(\varepsilon^{-2} t\right)$. In particular, the Prokhorov distance between the distributions of $X^{\varepsilon}$ and of $\Xi^{\varepsilon}$ is bounded by $\left(C(M, T) \varepsilon^{\delta}\right)^{1 / 3}$.

The strategy of the proof of Theorem [2.3 consists of three steps. First, we transform (2.17) to another equation where $\Sigma$ is the identity matrix. Secondly, we consider a related discrete time setup which is treated by means of Theorem [2.1] Thirdly, we see that the difference between this discrete and the original continuous time processes is small.

The main application to dynamical systems we have here in mind is a $C^{2}$ Axiom A flow $F^{t}$ near an attractor which using Markov partitions can be represented as a suspension over an exponentially fast $\psi$-mixing transformation so that we can take $\xi(t)=g \circ F^{t}$ for a Hölder continuous function $g$ and the probability $P$ being a Gibbs invariant measure constructed by a Hölder continuous potential on the base of the Markov partition (see, for instance, [8]). We observe that Prokhorov distance estimates between the distributions of $X^{\varepsilon}$ and $\Xi^{\varepsilon}$ in the one dimensional case for the (discrete time) suspension setup similar to Theorem 2.3 were obtained recently in 11.

## 3. Preliminary estimates

3.1. General lemmas. First, we will formulate three general results which will be used throughout this paper. The following lemma is well known (see, for instance, Corollary to Lemma 2.1 in [20] or Lemma 1.3.10 in [18]).
3.1. Lemma. Let $H(x, \omega)$ be a bounded measurable function on the space $\left(\mathbb{R}^{d} \times\right.$ $\Omega, \mathcal{B} \times \mathcal{F})$, where $\mathcal{B}$ is the Borel $\sigma$-algebra, such that for each $x \in \mathbb{R}^{d}$ the function $H(x, \cdot)$ is measurable with respect to a $\sigma$-algebra $\mathcal{G} \subset \mathcal{F}$. Let $V$ be an $\mathbb{R}^{d}$-valued random vector measurable with respect to another $\sigma$-algebra $\mathcal{H} \subset \mathcal{F}$. Then with probability one,

Then with probability one,

## 4. Strong approximations

Our strong approximations will be based on the following result which appears as Theorem 4.6 of [12]. As usual, we will denote by $\sigma\{\cdot\}$ a $\sigma$-algebra generated by random variables or vectors appearing inside the braces and we write $\mathcal{G} \vee \mathcal{H}$ for the minimal $\sigma$-algebra containing both $\sigma$-algebras $\mathcal{G}$ and $\mathcal{H}$.
4.1. Theorem. Let $\left\{V_{m}, m \geq 1\right\}$ be a sequence of random vectors with values in $\mathbb{R}^{d}$ defined on some probability space $(\Omega, \mathcal{F}, P)$ and such that $V_{m}$ is measurable with respect to $\mathcal{G}_{m}, m=1,2, \ldots$ where $\mathcal{G}_{m}, m \geq 1$ is a filtration of sub- $\sigma$-algebras of $\mathcal{F}$. Assume that the probability space is rich enough so that there exists on it a sequence of uniformly distributed on $[0,1]$ independent random variables $U_{m}, m \geq 1$ independent of $\vee_{m \geq 0} \mathcal{G}_{m}$. For each $m \geq 1$, let $G_{m}$ be a probability distribution on $\mathbb{R}^{d}$ with the characteristic function

Suppose that for some non-negative numbers $\nu_{m}, \delta_{m}$ and $K_{m} \geq 10^{8} d$,

Then there exists a sequence $\left\{W_{m}, m \geq 1\right\}$ of $\mathbb{R}^{d}$-valued independent random vectors defined on $(\Omega, \mathcal{F}, P)$ such that $W_{m}$ is $\sigma\left\{V_{m}, U_{m}\right\}$-measurable, $W_{m}$ is independent of $\sigma\left\{U_{1}, \ldots, U_{m-1}\right\} \vee \mathcal{G}_{m-1}$ (and so also of $W_{1}, \ldots, W_{m-1}$ ) and

\end{equation*}

where $\varrho_{m}=16 K_{m}^{-1} \log K_{m}+2 \nu_{m}^{1 / 2} K_{m}^{d}+2 \delta_{m}^{1 / 2}$. In particular, the Prokhorov distance between the distributions $\mathcal{L}\left(V_{m}\right)$ and $\mathcal{L}\left(W_{m}\right)$ of $V_{m}$ and $W_{m}$, respectively, does not exceed $\varrho_{m}$.

In order to apply this theorem we set $V_{m}=\left(n_{m}-l_{m}\right)^{-1 / 2} Q_{N, m}, \mathcal{G}_{m}=$ $\sigma\left\{V_{1}, \ldots, V_{m}\right\} \subset \mathcal{F}_{-\infty, n_{m}+m_{N}^{1 / 4}}$ and $g_{m}=g$ defined in Lemma 3.12, so that $G_{m}=G$ is the mean zero $d$-dimensional Gaussian distribution with the covariance matrix $\varsigma$ and the characteristic function $g$. By Lemma 3.12 for $|w| \leq K_{m}$,

where we take $K_{m}=\left(n_{m}-l_{m}\right)^{\wp / 4 d} \leq\left(n_{m}-l_{m}\right)^{\wp / 2}, \wp=\frac{1}{20}$ and recall that $n_{m}-l_{m}=3 m_{N}-3\left[m_{N}^{1 / 4}\right]$. Theorem4.1 requires that $K_{m} \geq 10^{8} d$ which will hold true in our case if $N \geq N_{0}=N_{0}(\kappa, \wp)=\left(10^{256 d / \wp} d^{32 d / \wp}\right)^{1 /(1-\kappa)}$.

Next, let $\Psi$ be a mean zero Gaussian random variable with the covariance matrix $\varsigma$. Then by estimates of Lemma 3.4 and the Chebyshev inequality,

& =4 L^{2} d 3^{-\wp / 2 d} n^{-\wp(1-\kappa) / 16 d}\left(N^{3(1-\kappa) / 8}-1\right)^{-\wp / 2 d} .
\end{align*}

Now, Theorem 4.1 provides us with independent random vectors $\left\{W_{m}, m \geq 1\right\}$ having the mean zero Gaussian distribution with the covariance matrix $\varsigma$ and such that

\end{align*}

where $C_{7}>0$ does not depend on $N \geq 1$.
As a crucial corollary of Theorem4.1 we will obtain next a uniform $L^{2 M}$-bound on the difference between the sums of $\left(n_{k}-l_{k}\right)^{1 / 2} V_{k}$ 's and of $\left(n_{k}-l_{k}\right)^{1 / 2} W_{k}$ 's. Set

The proof of (4.7) will rely on Lemmas 3.2 and 3.3, and so we will have to estimate the conditional expectations appearing there taking into account that $V_{k}$ is $\mathcal{G}_{k} \subset \mathcal{F}_{-\infty, n_{k}+m_{N}^{1 / 4}-m e a s u r a b l e ~ a n d ~} W_{k}$ is $\mathcal{G}_{k} \vee \sigma\left\{U_{1}, \ldots, U_{k}\right\}$-measurable. Let $k>j \geq 1$. Since $W_{k}$ is independent of $\mathcal{G}_{k-1} \vee \sigma\left\{U_{1}, \ldots, U_{k-1}\right\}$ we obtain that

& \leq \varrho_{k}^{2 M}+\varrho_{k}^{\frac{1}{2}} 2^{2 M}\left(\left(E\left|V_{k}\right|^{4 M}\right)^{1 / 2}+\left(E\left|W_{k}\right|^{4 M}\right)^{1 / 2}\right)
\end{align*}

Finally, combining (4.8)-(4.13) with Lemmas 3.2 and 3.3 we derive (4.7) completing the proof (cf. Lemma 4.4 in [22]).

Next, let $W(t), t \geq 0$ be a standard $d$-dimensional Brownian motion. Then the sequences of random vectors $\tilde{W}_{k}^{\varepsilon}=\varsigma^{1 / 2}\left(W\left(n_{k}\right)-W\left(l_{k}\right)\right)$ and $\left(n_{k}-l_{k}\right)^{1 / 2} W_{k}, k \leq$ $k_{N}(T N)$ have the same distributions. Hence, by Lemma A1 from [7] the sequences $\xi(k)$ and $W_{k}, k \geq 1$ can be redefined without changing their joint distributions on a richer probability space where there exists a standard $d$-dimensional Brownian motion $W(t)$ such that the pairs $\left(V_{k}, W_{k}\right)$ and $\left(V_{k},\left(n_{k}-l_{k}\right)^{-1 / 2} \varsigma^{1 / 2}\left(W\left(n_{k}\right)-W\left(l_{k}\right)\right)\right)$, $k \leq k_{N}(T N)$, constructed by means of the redefined processes, have the same joint distributions. Thus we can assume from now on that

and that these $W_{k}$ 's satisfy properties asserted in Theorem 4.1, so that Lemma 4.2 holds true for them, as well.

Next, using the Brownian motion $W(t), t \geq 0$ constructed above we consider the new Brownian motion $W_{N}(t)=N^{-1 / 2} W(t N)$ and introduce the diffusion process $\Psi_{N}(t), t \geq 0$ solving the stochastic differential equation (3.15) which we write now with $W_{N}$ as,

where $\mathfrak{b}(x)=E \mathfrak{b}(x, \xi(0))$. Now, we introduce the auxiliary process $\hat{\Psi}_{N}$ with coefficients frozen at times $n_{k} / N, k \leq k_{N}(T N)$,

where $n_{-1}=n_{0}=0$ and $k_{N}(s)$ was defined before Lemma 3.11, and estimate its deviation from $\Psi_{N}$.

\leq 2^{2 M-1}\left(\frac{6 m_{N}}{N}\right)^{M}\left(d^{2 M}(2 M)!\left|\varsigma^{1 / 2}\right|^{2 M}+L_{2}^{2 M}\left(\frac{6 m_{N}}{N}\right)^{M}\right)
\end{gathered}
$$

and (4.14) follows.
Next, we define

where $\alpha_{N, k}$ is the same as in Lemma 3.8. In order to use the estimate of Lemma 3.8 we will need first to compare $\hat{Y}_{N}$ with the sum appearing there.

\left.\left.-\mathfrak{b}\left(Y_{N, k-1}, \xi^{\left(m_{N}\right)}(j)\right) \mid \mathcal{F}_{-\infty, n_{k-1}+m_{N}}\right) \mid \mathcal{F}_{-\infty, n_{l}+m_{N}}\right) \mid \\
\leq L N^{(1-\kappa) / 2}\left(4 \phi\left(N^{(1-\kappa) / 2}\right)+\rho\left(N^{(1-k) / 2}\right)\right) .

When $l=k+1$ then $\mathfrak{b}\left(Y_{N, k-1}\right)\left(n_{k+1}-n_{k}\right)-\beta_{N, k}$ is $\mathcal{F}_{-\infty, n_{l}}$-measurable and we estimate the left hand side of (4.16) then and when $l=k$ just by $2 L N^{(1-\kappa) / 2}$. Thus, relying on Lemmas $3.2,3.3$ and 3.9 we obtain

& \left.-\left.\tilde{\Psi}_{N}\left(n_{k} / N\right)\right|^{2 M}+E \max _{0 \leq k<k_{N}(T N)}\left|\tilde{\Psi}_{N}\left(n_{k} / N\right)-\hat{\Psi}_{N}\left(n_{k} / N\right)\right|^{2 M}\right) .
\end{align*}

By Lemmas 3.3 3.11 and 4.2 for any $N \geq N_{0}(\kappa, \wp)$,

& \leq C_{11}(M)\left(N^{-\frac{\sigma}{20 d}(1-\kappa)}+N^{-M(1-\kappa) / 4}\right)
\end{align*}

where $C_{11}(M)>0$ does not depend on $n$ and $N$.
In order to estimate the second term in the right hand side of (4.18) introduce the $\sigma$-algebras $\mathcal{Q}_{s}=\mathcal{F}_{-\infty, s+m_{N}} \vee \sigma\{W(u), 0 \leq u \leq s\}$ and observe that by our construction for each $k$ the increment $W\left(n_{k+1}\right)-W\left(l_{k+1}\right)$ is independent of $\mathcal{Q}_{n_{k-1}}$. On the other hand, for any $k \geq n$ both $Y_{N, k}$ and $\Psi_{N}\left(n_{k} / N\right)$ are $\mathcal{Q}_{n_{k}}$-measurable. Observe that

$$

and

\mathcal{I}_{2}\left(n_{k}\right)=\sum_{0 \leq j \leq k-1} \varsigma^{1 / 2}\left(W_{N}\left(l_{j+1} / N\right)-W_{N}\left(n_{j} / N\right)\right) .

By the estimates of Lemma 3.4 and the Lipschitz continuity of $\mathfrak{b}$ we have

## 5. Continuous time case

We start with a diffeomorphism $r: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ satisfying (3.5) and set $Z^{\varepsilon}(t)=$ $r\left(X^{\varepsilon}(t)\right)$. Then

where $\mathfrak{b}(z, \zeta)=\operatorname{Dr}\left(r^{-1}(z)\right) b\left(r^{-1}(z), \zeta\right)$. Taking into account Lemma 3.4 we see that the limits in (2.19) and (2.20) exist and we can define the diffusion $\Xi$ by (2.11). In view of the definition of $c(x)$ in (2.20) the computations of Lemma 3.6 yield that the process $\Psi(t)=r(\Xi(t))$ solves the stochastic differential equation

where $\mathfrak{b}(z)=E \mathfrak{b}(z, \eta(0))$. Hence, in order to prove (2.21) it suffices to show that for each $\varepsilon>0$ both $Z^{\varepsilon}$ and $\Psi=\Psi^{\varepsilon}$ can be redefined on $(\Omega, \mathcal{F}, P)$ preserving their distributions so that for any $\varepsilon, T>0$ and an integer $M \geq 1$,

for some $\delta_{1}, C_{1}(M, T)>0$ independent of $\varepsilon$.
Changing the time $s=t / \varepsilon^{2}$ we can write
$Z^{\varepsilon}\left(s \varepsilon^{2}\right)=Z^{\varepsilon}\left(s \varepsilon^{2}, \omega\right)=Z^{\varepsilon}(0, \omega)+\varepsilon \int_{0}^{s} \xi(u, \omega) d u+\varepsilon^{2} \int_{0}^{s} \mathfrak{b}\left(Z^{\varepsilon}\left(u \varepsilon^{2}, \omega\right), \xi(u, \omega)\right) d u$.
Set $\Theta_{n}(\omega)=\sum_{j=0}^{n-1} \tau \circ \theta^{j}(\omega), \Theta_{0}(\omega)=0$. Introduce the discrete time processes $Y^{\varepsilon}\left(m \varepsilon^{2}, \omega\right)=Y^{\varepsilon}\left(m \varepsilon^{2},(\omega, 0)\right)$ by the recurrence relation $Y^{\varepsilon}(0, \omega)=Z^{\varepsilon}(0, \omega)=$ $Z^{\varepsilon}(0,(\omega, 0))$ and for $n \geq 0$,

& \quad+\varepsilon^{2} \int_{\Theta_{n}(\omega)}^{\Theta_{n+1}(\omega)} \mathfrak{b}\left(Y^{\varepsilon}\left(n \varepsilon^{2}, \omega\right), \xi(u, \omega)\right) d u \\
& =Y^{\varepsilon}\left(n \varepsilon^{2}, \omega\right)+\varepsilon \eta \circ \vartheta^{n}(\omega)+\varepsilon^{2} \hat{\mathfrak{b}}\left(Y^{\varepsilon}\left(n \varepsilon^{2}, \omega\right), \cdot\right) \circ \vartheta^{n}
\end{align*}
$$

where $\hat{\mathfrak{b}}(z, \omega)=\operatorname{Dr}\left(r^{-1}(z)\right) \hat{b}\left(r^{-1}(z), \omega\right)$.
5.1. Lemma. For all $\varepsilon>0, \omega \in \Omega$ and an integer $N \geq 1$,

since $|\mathfrak{b}(z, \omega)-\mathfrak{b}(y, \omega)| \leq L^{3}\left(L^{2}+1\right)|z-y|$. Then by (2.16) and the discrete Gronwall inequality we see that for all integers $n \geq 1$,

Next, observe that we can apply Theorem 2.1 to the process $Y^{\varepsilon}$. Indeed, though we have here the terms $\hat{\mathfrak{b}}(z, \cdot) \circ \vartheta^{n}$ which are slightly more general than $\hat{\mathfrak{b}}(z, \eta \circ$ $\vartheta^{n}$ ) appearing in the setup of Theorem 2.1 but, in fact, we used there only the appropriate decay of the approximation coefficient $\rho$ together with the Lipschitz continuity of coefficients in the second variable given by (2.6) which is replaced here by the coefficient $\rho$ in (2.18) playing the same role (with no need in additional Lipschitz continuity) and the proof proceeds in the same way. Moreover, if $(\Omega, \mathcal{F}, P)$ is Lebesgue (or standard probability) space then we can always represent $\hat{\mathfrak{b}}(z, \cdot) \circ \vartheta^{n}$ in the form $\hat{\mathfrak{b}}\left(z, \zeta \circ \vartheta^{n}\right)$, where $\zeta(n)=\zeta \circ \vartheta^{n}$ is a real valued stationary process, and considering the two component stationary process $\left(\eta \circ \vartheta^{n}, \zeta \circ \vartheta^{n}\right)_{n \in \mathbb{Z}}$ we come back to the setup of Theorem 2.1. Observe also that though in Theorem 2.1 we considered only subsequences $\varepsilon=\varepsilon_{N}=1 / N$ the assertion remains true for all small $\varepsilon>0$. Indeed, let $\left(N_{\varepsilon}+1\right)^{-1} \leq \varepsilon^{2}<N_{\varepsilon}^{-1}$. Then

\end{gathered}

By the discrete Gronwall inequality
$\max _{0 \leq n \leq T / \varepsilon^{2}}\left|Y^{\varepsilon}\left(n \varepsilon^{2}\right)-Y^{N_{\varepsilon}^{-1 / 2}}\left(n N_{\varepsilon}^{-1}\right)\right| \leq \tilde{C}\left(\frac{\varepsilon^{3}}{\sqrt{1-\varepsilon^{2}}} \max _{0 \leq n \leq T / \varepsilon^{2}}\left|\sum_{k=0}^{n-1} \eta \circ \vartheta^{k}\right|+\frac{\varepsilon^{2}}{1-\varepsilon^{2}}\right)$.
where $\tilde{C}>0$ does not depend on $\varepsilon$. Applying Lemmas 3.1 3.3 to the right hand side here (similarly to Lemmas $3.9,4.4$ and Lemma 5.2 below) we obtain that

E \max _{0 \leq n \leq T / \varepsilon^{2}}\left|Y^{\varepsilon}\left(n \varepsilon^{2}\right)-Y^{N_{\varepsilon}^{-1 / 2}}\left(n N_{\varepsilon}^{-1}\right)\right|^{2 M} \leq \tilde{\tilde{C}} \frac{\varepsilon^{2 M}}{\left(1-\varepsilon^{2}\right)^{M}}
$$

for some $\tilde{C}>0$ independent of $\varepsilon$, showing that we can apply Theorem 2.1 for all $\varepsilon>0$ when $X^{\varepsilon}$ is in the form (1.3) and not only when the parameters restricted to the sequence $\varepsilon_{N}=1 / \sqrt{N}$ provided, of course, other conditions of this assertion are met.

Applying Theorem 2.1 we obtain that both $Y^{\varepsilon}$ and the diffusion $\Psi=\Psi^{\varepsilon}$ can be redefined on $(\Omega, \mathcal{F}, P)$ without changing their distributions so that for any $\varepsilon>0$ and an integer $M \geq 1$,

$$
\begin{equation*}
\sup _{0 \leq t \leq T / \bar{\tau}}\left|Y^{\varepsilon}(t)-\Psi^{\varepsilon}(t)\right|^{2 M} \leq C_{2}(M, T) \varepsilon^{\delta_{2}} \tag{5.8}
\end{equation*}
$$

for some $\delta_{2}, C_{2}(M, T)>0$ independent of $\varepsilon$ where we set $Y^{\varepsilon}(t)=Y^{\varepsilon}\left(n \varepsilon^{2}\right)$ if $n \varepsilon^{2} \leq t<(n+1) \varepsilon^{2}$.

Now we have

$$
\begin{align*}
\sup _{0 \leq t \leq T}\left|Z^{\varepsilon}(t)-\Psi^{\varepsilon}(t / \bar{\tau})\right|^{2 M} & \leq 3^{2 M-1}\left(E \sup _{0 \leq t \leq T}\left|I_{1}^{\varepsilon}(t)\right|^{2 M}\right.  \tag{5.9}\\
+E \sup _{0 \leq t \leq T}\left|I_{2}^{\varepsilon}(t)\right|^{2 M} & \left.+E \sup _{0 \leq t \leq T}\left|I_{3}^{\varepsilon}(t)\right|^{2 M}\right)
\end{align*}
$$

where
$I_{1}^{\varepsilon}(t)=Y^{\varepsilon}(t / \bar{\tau})-\Psi^{\varepsilon}(t / \bar{\tau}), I_{2}^{\varepsilon}(t)=\sup _{\Theta_{\left[t / \varepsilon^{2} \bar{\tau}\right]}(\omega) \leq s<\Theta_{\left[t / \varepsilon^{2} \bar{\tau}\right]}(\omega)+1}\left|Y^{\varepsilon}(t / \bar{\tau}, \omega)-Z^{\varepsilon}\left(s \varepsilon^{2}, \omega\right)\right|$
and
(5.10)
$I_{3}^{\varepsilon}(t)=\sup _{\Theta_{\left[t / \varepsilon^{2} \bar{\tau}\right]}(\omega) \leq s<\Theta_{\left[t / \varepsilon^{2} \bar{\tau}\right]}(\omega)+1}\left|Z^{\varepsilon}(t, \omega)-Z^{\varepsilon}\left(s \varepsilon^{2}, \omega\right)\right| \leq \varepsilon L \bar{\tau}(1+\varepsilon L)+\sup _{0 \leq t \leq T}\left|I_{4}^{\varepsilon}(t)\right|$
where

$$
I_{4}^{\varepsilon}(t)=Z^{\varepsilon}(t, \omega)-Z^{\varepsilon}\left(\varepsilon^{2} \Theta_{\left[t / \varepsilon^{2} \bar{\tau}\right]}(\omega), \omega\right)
$$

The first and the second terms of (5.9) are estimated by (5.8) and (5.7), respectively, and so in view of (5.10) in order to derive (5.3) it remains to prove the following result.
5.2. Lemma. For $\varepsilon>0$ and an integer $M \geq 1$,

$$
\begin{equation*}
E \sup _{0 \leq t \leq T}\left|I_{4}^{\varepsilon}(t)\right|^{2 M} \leq C_{3}(M, T) \varepsilon^{\delta_{3}} \tag{5.11}
\end{equation*}
$$

for some $\delta_{3}, C_{3}(M, T)>0$ which do not depend on $\varepsilon$.
Proof. Set

$$
n(t, \omega)=\max \left\{k: \Theta_{k}(\omega) \leq t\right\}, \Gamma(t, q)=\{\omega:|n(t, \omega)-[t / \bar{\tau}]|>q\}
$$

and $\Delta(k, q)=\left\{\omega:\left|\Theta_{k}(\omega)-\bar{\tau} k\right|>q\right\}$. Then by (2.5) and (2.16),

$$
\begin{equation*}
\left|I_{4}^{\varepsilon}(t)\right| \leq \varepsilon L \hat{L}\left(1+J_{1}^{\varepsilon}(t)+\bar{\tau}\right)+\varepsilon J_{2}^{\varepsilon}\left(\left[t / \varepsilon^{2} \bar{\tau}\right]\right)+\varepsilon^{2} L^{2} J_{3}(t) \tag{5.12}
\end{equation*}
$$

where
(5.13)
$J_{1}^{\varepsilon}(t)=\mathbb{I}_{\Gamma\left(t / \varepsilon^{2}, \varepsilon^{-3 / 2}\right)}\left|\Theta_{\left[t / \varepsilon^{2} \bar{\tau}\right]}-t / \varepsilon^{2}\right| \leq \mathbb{I}_{\Delta\left(\left[t / \varepsilon^{2} \bar{\tau}\right], \varepsilon^{-3 / 2}-\hat{L}-2 \hat{L}^{-1}\right)}\left|\Theta_{\left[t / \varepsilon^{2} \bar{\tau}\right]}-\bar{\tau}\left[t / \varepsilon^{2} \bar{\tau}\right]\right|$,

$$
\begin{equation*}
J_{2}(m)=\max _{0 \leq n \leq \varepsilon^{-3 / 2}}\left|\sum_{k:|k-m| \leq n} \eta \circ \vartheta^{k}\right| \tag{5.14}
\end{equation*}
$$

and

$$
\begin{equation*}
J_{3}^{\varepsilon}(t)=\left|\Theta_{\left[t / \varepsilon^{2} \bar{\tau}\right]}-t / \varepsilon^{2}\right| \leq\left|\Theta_{\left[t / \varepsilon^{2} \bar{\tau}\right]}-\bar{\tau}\left[t / \varepsilon^{2} \bar{\tau}\right]\right|+\bar{\tau} \tag{5.15}
\end{equation*}
$$

By (2.5), (2.16), (2.18) and Lemma 3.1 for any $l \geq 1$,

$$
\begin{gather*}
\left|E\left(\tau \circ \vartheta^{k+l}-\bar{\tau} \mid \mathcal{F}_{-\infty, k}\right)\right|  \tag{5.16}\\
\leq\left|E\left(\tau \circ \vartheta^{k+l}-E\left(\tau \circ \vartheta^{k+l} \mid \mathcal{F}_{k+l-[l / 3], k+l+[l / 3]}\right) \mid \mathcal{F}_{-\infty, k}\right)\right| \\
+\left|E\left(E\left(\tau \circ \vartheta^{k+l} \mid \mathcal{F}_{k+l-[l / 3], k+l+[l / 3]}\right)-\bar{\tau} \mid \mathcal{F}_{-\infty, k}\right)\right| \leq \rho([l / 3])+2 \hat{L} \phi([l / 3])
\end{gather*}
$$

and similarly,

$$
\left|E\left(\eta \circ \vartheta^{k+l} \mid \mathcal{F}_{-\infty, k}\right)\right| \leq \rho([l / 3])+2 L \bar{\tau} \phi([l / 3])
$$

This together with (2.14) and Lemmas 3.2 and 3.3 yields that for any $n, N \geq 1$,

$$
\begin{equation*}
E \max _{0 \leq k \leq n}\left|\Theta_{k}-k \bar{\tau}\right|^{2 N} \leq C_{4}(N) n^{N} \tag{5.17}
\end{equation*}
$$

and

$$
\begin{equation*}
E \max _{0 \leq k \leq n}\left|\sum_{j=0}^{n} \eta \circ \vartheta^{j}\right|^{2 N} \leq C_{4}(N) n^{N} \tag{5.18}
\end{equation*}
$$

for some $C_{4}(N)>0$ independent of $n$.
Hence, for any $N \geq 1$,

$$
\begin{equation*}
E \sup _{0 \leq t \leq T}\left|J_{3}^{\varepsilon}(t)\right|^{2 N} \leq 2^{2 N-1}\left(C_{4}(N)\left[T / \varepsilon^{2} \bar{\tau}\right]^{N}+\bar{\tau}^{N}\right) \tag{5.19}
\end{equation*}
$$

and by the stationarity of the sequence $\eta \circ \vartheta^{k}, k \in \mathbb{Z}$,

$$
\begin{gather*}
E \sup _{0 \leq t \leq T}\left(J_{2}^{\varepsilon}\left(\left[t / \varepsilon^{2} \bar{\tau}\right]\right)\right)^{2 N} \leq E \max _{0 \leq m \leq T / \varepsilon^{2} \bar{\tau}\left(J_{2}^{\varepsilon}(m)\right)^{2 N}}  \tag{5.20}\\
\quad \leq \frac{T}{\varepsilon^{2} \bar{\tau}} E\left(J_{2}^{\varepsilon}(0)\right)^{2 N} \leq C_{4}(N) 2^{N} T \bar{\tau}^{-1} \varepsilon^{-\left(2+\frac{3}{2} N\right)}
\end{gather*}
$$

and by the Cauchy-Schwarz inequality,

$$
\begin{gathered}
E \sup _{0 \leq t \leq T}\left(J_{3}^{\varepsilon}(t)\right)^{2 N} \leq E \max _{0 \leq n \leq T / \varepsilon^{2} \bar{\tau}\left(\mathbb{I}_{\Delta\left(n, \varepsilon^{-3 / 2}-\hat{L}-2 \hat{L}^{-1}\right)}\left|\Theta_{n}-\bar{\tau} n\right|^{2 N}\right)} \quad \leq \sum_{0 \leq n \leq T / \varepsilon^{2} \bar{\tau}} E\left(\mathbb{I}_{\Delta\left(n, \varepsilon^{-3 / 2}-\hat{L}-2 \hat{L}^{-1}\right)}\left|\Theta_{n}-\bar{\tau} n\right|^{2 N}\right) \\
\leq \sum_{0 \leq n \leq T / \varepsilon^{2} \bar{\tau}}\left(P\left(\Delta\left(n, \varepsilon^{-3 / 2}-\hat{L}-2 \hat{L}^{-1}\right)\right) E\left|\Theta_{n}-\bar{\tau} n\right|^{4 N}\right)^{1 / 2}
\end{gathered}
$$

By (5.17) and the Chebyshev inequality for any $K \geq 1$,

$$
P\left(\Delta\left(n, \varepsilon^{-3 / 2}-\hat{L}-2 \hat{L}^{-1}\right)\right) \leq\left(\varepsilon^{-3 / 2}-\hat{L}-2 \hat{L}^{-1}\right)^{-2 K}(T / \bar{\tau})^{K} \varepsilon^{-2 K}
$$

and so

$$
\begin{equation*}
E \sup _{0 \leq t \leq T}\left(J_{1}^{\varepsilon}(t)\right)^{2 N} \leq C_{5}(K, N, T) \varepsilon^{\frac{1}{2} K-2 N-2} \tag{5.21}
\end{equation*}
$$

for some $C_{5}(K, N, T)>0$ independent of $\varepsilon>0$. Finally, we obtain (5.11) from (5.12)-(5.15) and (5.19)-(5.21) taking $N=M$ and $K>4(M-1)$, completing the proof of both Lemma 5.2 and Theorem 2.3
