# THE $L_{p}$ GAUSS IMAGE PROBLEM

#### Abstract

In this paper we study the $L_{p}$ Gauss image problem, which is a generalization of the $L_{p}$ Aleksandrov problem and the Gauss image problem in convex geometry. We obtain the existence result for the $L_{p}$ Gauss image problem in two cases (i) $p>0$ or (ii) $p<0$ with the given even measures.


Keywords: the $L_{p}$ Gauss image problem, Surface area measure, Curvature measure, Existence of solution, Blaskchke selection theorem.

## 1. Introduction

Let $\mathcal{K}_{0}^{n}$ denote the set of convex bodies in $\mathbb{R}^{n}$ which contains the origin in its interior. For $K \in \mathcal{K}_{0}^{n}$, its support function, $h_{K}$, is defined by

$$
h_{K}(x):=\max _{y \in K}\langle y, x\rangle, \quad \forall x \in \mathbb{S}^{n-1},
$$

where $\langle y, x\rangle$ is the standard inner product of $x$ and $y$ in $\mathbb{R}^{n}$.
Suppose $K, L \in \mathcal{K}_{0}^{n}$ and $t \geq 0$, the Minkowski combination, $K+t L \in \mathcal{K}_{0}^{n}$, is given by

$$
h_{K+t L}=h_{K}+t h_{L}
$$

for negative $t, K+t L$ can be defined if $|t|$ is sufficient small. Aleksandrov's variational formula shows that

$$
\left.\frac{d}{d t} V(K+t L)\right|_{t=0}=\int_{\mathbb{S}^{n-1}} h_{L}(x) d S(K, x), \quad \forall L \in \mathcal{K}_{0}^{n}
$$

where $V(\cdot)$ denotes the volume functional and $S(K, \cdot)$ is the surface area measure.
A nature extension is $L_{p}$ Minkowski sum, which was first defined by Firey in case $p \geq 1$. Suppose $K, L \in \mathcal{K}_{0}^{n}$ and $t \geq 0$, the $L_{p}$ Minkowski combination, $K+{ }_{p} t \cdot L \in \mathcal{K}_{0}^{n}$, is defined by

$$
h_{K+{ }_{p} t \cdot L}^{p}=h_{K}^{p}+t h_{L}^{p} .
$$

In the early 1900 's, $K+{ }_{p} t \cdot L$ can be defined for negative $t$ if $|t|$ is sufficient small. Lutwak [36] showed the variational formula

$$
\left.\frac{d}{d t} V\left(K+{ }_{p} t \cdot L\right)\right|_{t=0}=\frac{1}{p} \int_{\substack{\mathbb{S}^{n-1} \\ 1}} h_{L}^{p}(x) d S_{p}(K, x), \quad \forall L \in \mathcal{K}_{0}^{n}
$$

where $S_{p}(K, \cdot)$ is the $L_{p}$ surface area measure, satisfying

$$
\begin{equation*}
d S_{p}(K, \cdot)=h_{K}^{1-p} d S(K, \cdot) \tag{1.1}
\end{equation*}
$$

Thus by (1.1), the $L_{p}$ surface area measure can be defined for any $p \in \mathbb{R}$.
Suppose $K \in \mathcal{K}_{0}^{n}$, $K^{*}$ stands for the polar body of $K$, which is given by

$$
\begin{equation*}
K^{*}=\bigcap_{y \in K}\left\{x \in \mathbb{R}^{n}:\langle x, y\rangle \leq 1\right\} \tag{1.2}
\end{equation*}
$$

By combining the concept of $L_{p}$ Minkowski combination with that of polarity, we obtain another kind of combination, the $L_{p}$ harmonic combination, $K \hat{+}_{p} t \cdot L \in \mathcal{K}_{0}^{n}$, is defined by

$$
K \hat{+_{p}} t \cdot L=\left(K^{*}+_{p} t \cdot L^{*}\right)^{*}
$$

Huang, Lutwak, Yang and Zhang [25] considered the entropy functional

$$
\begin{equation*}
\mathcal{E}(K)=-\int_{\mathbb{S}^{n-1}} \log h_{K}(x) d x \tag{1.3}
\end{equation*}
$$

and got the variational formula

$$
\left.\frac{d}{d t} \mathcal{E}\left(K \hat{+}_{p} t \cdot L\right)\right|_{t=0}=\frac{1}{p} \int_{\mathbb{S}^{n-1}} \rho_{L}^{-p}(u) d J_{p}(K, u), \quad \forall L \in \mathcal{K}_{0}^{n}
$$

where $\rho_{L}$ is the radial function of $L$, given by

$$
\rho_{L}(u):=\max \{t>0: t u \in L\}, \quad \forall u \in \mathbb{S}^{n-1}
$$

They proved the $L_{p}$ integral curvature $J_{p}(K, \cdot)$ satisfies

$$
\begin{equation*}
d J_{p}(K, \cdot)=\rho_{K}^{p} d J(K, \cdot) \tag{1.4}
\end{equation*}
$$

where $J(K, \cdot)$ is the Aleksandrov integral curvature.
For any Borel measurable subset $\omega \subset \mathbb{S}^{n-1}$, the radial Gauss image of $\omega$, $\boldsymbol{\alpha}_{K}(\omega)$, is given by

$$
\boldsymbol{\alpha}_{K}(\omega)=\left\{x \in \mathbb{S}^{n-1}:\left\langle\rho_{K}(u) u, x\right\rangle=h_{K}(x) \text { for some } u \in \omega\right\}
$$

Then $J(K, \cdot)$ is the spherical Lebesgue measure of the radial Gauss image $\boldsymbol{\alpha}_{K}$, that is,

$$
\begin{equation*}
J(K, \omega)=\mathcal{H}^{n-1}\left(\boldsymbol{\alpha}_{K}(\omega)\right) \tag{1.5}
\end{equation*}
$$

Recently, Boroczky, Lutwak, Yang, Zhang and Zhao [5] proposed the Gauss image measure $\lambda(K, \omega)$, which is a generalization of the Aleskandrov integral measure. We state it more precisely below.
Definition 1.1. Let $\lambda$ be a Borel measure on $\mathbb{S}^{n-1}$, and $K \in \mathcal{K}_{0}^{n}$. Then the Gauss image measure of $\lambda$ via $K$ is defined by

$$
\begin{equation*}
\lambda(K, \omega)=\lambda\left(\boldsymbol{\alpha}_{K}(\omega)\right) \tag{1.6}
\end{equation*}
$$

where $\omega$ is a Lebesgue measurable subset of $\mathbb{S}^{n-1}$.

Based on (1.3), (1.5) and (1.6), it is nature to consider the functional

$$
\begin{equation*}
G(K)=-\int_{\mathbb{S}^{n-1}} \log h_{K}(x) d \lambda(x) \tag{1.7}
\end{equation*}
$$

And its variational formulas is

$$
\left.\frac{d}{d t} G\left(K \hat{+}_{p} t \cdot L\right)\right|_{t=0}=\frac{1}{p} \int_{\mathbb{S}^{n-1}} \rho_{L}^{-p}(u) d \lambda_{p}(K, u), \quad \forall L \in \mathcal{K}_{0}^{n}
$$

where $\lambda_{p}(K, \cdot)$ is the $L_{p}$ Gauss image measure, satisfying

$$
\begin{equation*}
d \lambda_{p}(K, \cdot)=\rho_{K}^{p} d \lambda(K, \cdot) \tag{1.8}
\end{equation*}
$$

It is clear that $\lambda_{0}(K, \cdot)=\lambda(K, \cdot)$, and (1.8) becomes (1.4) if $\lambda(K, \cdot)$ is $J(K, \cdot)$. Therefore, the $L_{p}$ Aleksandrov measure and the Gauss image measure are special cases of the $L_{p}$ Gauss image measure.

The $L_{p}$ Gauss image problem. For a fixed $p \in \mathbb{R}$, suppose $\lambda$ and $\mu$ are two Borel measures defined on the Borel measurable subsets of $\mathbb{S}^{n-1}$. What are the necessary and sufficient conditions, on $\lambda$ and $\mu$, such that there exists a convex body $K$,

$$
\mu=\lambda_{p}(K, \cdot)
$$

on the Borel subsets of $\mathbb{S}^{n-1}$ ? And if such a body exists, to what extent is it unique?
When $\lambda$ is spherical Lebesgue measure, the $L_{p}$ Gauss image problem is just the $L_{p}$ Aleksandrov problem, see [1, 2, 3, 25]. The $L_{0}$ Gauss image problem is just the Gauss image problem which was first mentioned in [5], and the existence of smooth solution for the Gauss image problem was in [14]. It is necessary to contrast the $L_{p}$ Gauss image problem with the various Minkowski problems and dual Minkowski problems that have been extensively studied, see [8, 11, 15, 16, 27, 29, 30, 34, 35, 36, [37, 38, 40, 44, 45] for the $L_{p}$-Minkowski problem, [7, 21, 23, 24, 32, 42, 43] for the dual Minkowski problem, [6, 9, 10, 25, 26, 31, 39] for the $L_{p}$ dual Minkowski problem, [4, 20, 22, 28] for the Orlicz Minkowski problem, [12, 13, 18, 19, 33] for the dual Orlicz Minkowski problem, [17] for the Orlicz Aleskandrov problem.

The existence result for the $L_{p}$ Gauss image problem when $p>0$ will be presented in the followong. The idea goes back as for as [25].

Theorem 1.2. Suppose $p>0$. If $\lambda$ and $\mu$ are two finite Borel measures on $\mathbb{S}^{n-1}$ which satisfy
(1) $\lambda$ is absolutely continuous with respect to spherical Lebesgue measure;
(2) $\lambda(A)>0$ for any nonempty open set $A \subset \mathbb{S}^{n-1}$;
(3) $\mu$ is not concentrated in any closed hemisphere of $\mathbb{S}^{n-1}$.

Then there exists a convex body $K$ such that $\mu=\lambda_{p}(K, \cdot)$.
If the given measures are even, the third condition in Theorem 1.2 is naturally satisfied, and we can get the existence result for $p<0$.

Theorem 1.3. Suppose $p<0$. If $\lambda$ and $\mu$ are two finite, even Borel measures on $\mathbb{S}^{n-1}$ which satisfy
(1) $\lambda$ is absolutely continuous with respect to spherical Lebesgue measure;
(2) $\lambda(A)>0$ for any nonempty open set $A \subset \mathbb{S}^{n-1}$;
(3) $\mu$ is vanishes on great sub-spheres of $\mathbb{S}^{n-1}$.

Then there exists an origin-symmetric convex body $K$ such that $\mu=\lambda_{p}(K, \cdot)$.
In particular, when $\mu$ has a density, say $f$, and $\lambda$ has a density, say $g$, the $L_{p}$ Gauss image problem asks: Under what conditions on the two given functions $f, g: \mathbb{S}^{n-1} \rightarrow$ $[0, \infty)$, does there exist a solution $h: \mathbb{S}^{n-1} \rightarrow(0, \infty)$, that is the support function of a convex body $K^{*}$, to the Monge-Ampère equation

$$
\begin{equation*}
g\left(\frac{\nabla h+h x}{|\nabla h+h x|}\right) \frac{h^{1-p}}{\left(|\nabla h|^{2}+h^{2}\right)^{\frac{n}{2}}} \operatorname{det}\left(\nabla^{2} h+h I\right)=f(x) \quad \text { on } \quad \mathbb{S}^{n-1} \tag{1.9}
\end{equation*}
$$

Remark 1.4. The weak solution of the equation (1.9) for $g \equiv 1$ was solved by Huang, Lutwak, Yang and Zhang [25].

It is worth pointing out that if $\lambda$ and $\mu$ have densities, the weak solution of the equation (1.9) can be obtained according to Theorem 1.2 and Theorem 1.3.

Remark 1.5. Assume $g>0$.
(1) For $p>0$, if for any hemisphere $\Theta$,

$$
\int_{\Theta} f(x) d x>0
$$

then the equation (1.9) has a strictly positive solution.
(2) For $p<0$, if $f$ and $g$ are even functions, and if

$$
\int_{\mathbb{S}^{n}-1} f(x) d x>0
$$

then the equation (1.9) has a strictly positive even solution.
This paper is organized as follows. In section 2, we give some basic knowledge about convex body. In section 3, The $L_{p}$ Gauss image measure will be given, based on the radial Gauss image. In section 4, the variational formulas will be obtained and in the last section, Theorem 1.2 and Theorem 1.3 will be proved.

## 2. Preliminaries

In this section, some notions and facts will be set up, the details can be found in [41].

Let $K$ be a convex body in $\mathbb{R}^{n}$, which means $K$ is a compact, convex subset in $\mathbb{R}^{n}$ with non-empty interior. And $\mathcal{K}^{n}=\left\{K: K\right.$ is a convex body in $\left.\mathbb{R}^{n}\right\}, \mathcal{K}_{e}^{n}=\{K \in$ $\mathcal{K}^{n}: K$ is origin-symmetric $\}$.

Suppose $K \in \mathcal{K}_{0}^{n}$, recall $h_{K}$ and $\rho_{K}$ denote the support function and the radial function of $K$, respectively,

$$
\begin{equation*}
h_{K}(x):=\max _{y \in K}\langle y, x\rangle, \quad \forall x \in \mathbb{S}^{n-1} \tag{2.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\rho_{K}(u):=\max \{t>0: t u \in K\}, \quad \forall u \in \mathbb{S}^{n-1} \tag{2.2}
\end{equation*}
$$

Note that

$$
\begin{equation*}
\partial K=\left\{\rho_{K}(u) u: u \in \mathbb{S}^{n-1}\right\} \tag{2.3}
\end{equation*}
$$

By (2.1), (2.2) and (2.3), the support function $h_{K}$ and the radial function $\rho_{K}$ have the following relationship:

$$
h_{K}(x)=\max _{u \in \mathbb{S}^{n-1}}\langle u, x\rangle \rho_{K}(u), \quad x \in \mathbb{S}^{n-1}
$$

and

$$
\rho_{K}(u)=\max _{x \in \mathbb{S}^{n-1}}\langle u, x\rangle / h_{K}(x), \quad u \in \mathbb{S}^{n-1}
$$

The definition of polar body, i.e.(1.2), shows that

$$
\begin{equation*}
\rho_{K}=1 / h_{K^{*}}, \quad h_{K}=1 / \rho_{K^{*}} . \tag{2.4}
\end{equation*}
$$

From (2.4), it is clear that

$$
\begin{equation*}
K^{* *}=K \tag{2.5}
\end{equation*}
$$

Let $\Omega \subset \mathbb{S}^{n-1}$ be a closed set that is not contained in any closed hemisphere of $\mathbb{S}^{n-1}$. And $h, \rho: \Omega \rightarrow(0, \infty)$ are continuous functions. The Wulff shape determined by $h$, is denoted by

$$
[h]=\bigcap_{x \in \Omega}\left\{y \in \mathbb{R}^{n}: x \cdot y \leq h(x)\right\},
$$

and the convex hull $\langle\rho\rangle$ generated by $\rho$, is denoted by

$$
\langle\rho\rangle=\operatorname{conv}\{\rho(u) u: u \in \Omega\} .
$$

And a useful fact is that, see [24],

$$
\begin{equation*}
[h]^{*}=\langle 1 / h\rangle . \tag{2.6}
\end{equation*}
$$

If $h_{K}$ is the support function of a convex body $K$, then

$$
\left[h_{K}\right]=K
$$

and if $\rho_{K}$ is the radial function of a convex body $K$, then

$$
\begin{equation*}
\left\langle\rho_{K}\right\rangle=K \tag{2.7}
\end{equation*}
$$

Assume $h_{t}: \Omega \rightarrow(0, \infty)$ is a continuous function defined for $t \in(-\delta, \delta)$ by

$$
\begin{equation*}
\log h_{t}(x)=\log h(x)+t f(x)+o(t, x) \tag{2.8}
\end{equation*}
$$

where $f: \Omega \rightarrow \mathbb{R}$ is continuous, $\delta>0$ and $o(t, \cdot):(-\delta, \delta) \times \mathbb{S}^{n-1} \rightarrow \mathbb{R}$ is continuous and for $x \in \Omega, \lim _{t \rightarrow 0} \frac{o(t, x)}{t}=0$. We shall write $\left[h_{t}\right]$ as $[h, f, t]$. And if $h$ is the support function of a convex body $K$, write $\left[h_{t}\right]$ as $[K, f, t]$.

Suppose $\rho_{t}: \Omega \rightarrow(0, \infty)$ is a continuous function defined for $t \in(-\delta, \delta)$ by

$$
\begin{equation*}
\log \rho_{t}(u)=\log \rho(u)+t g(u)+o(t, u) \tag{2.9}
\end{equation*}
$$

where $g: \Omega \rightarrow \mathbb{R}$ is continuous and $o(t, \cdot):(-\delta, \delta) \times \mathbb{S}^{n-1} \rightarrow \mathbb{R}$ is continuous and for $u \in \Omega, \lim _{t \rightarrow 0} \frac{o(t, u)}{t}=0$. We shall write $\left\langle\rho_{t}\right\rangle$ as $\langle\rho, g, t\rangle$. And if $\rho$ is the radial function of a convex body $K$, write $\left\langle\rho_{t}\right\rangle$ as $\langle K, g, t\rangle$.

The $L_{p}$ Minkowski sum is the key role in the $L_{p}$ Brunn-Minkowski theory. For fixed $p \in \mathbb{R}$, suppose $K, L \in \mathcal{K}_{0}^{n}$ and $a, b \geq 0$, the $L_{p}$ Minkowski combination, $a \cdot K+{ }_{p} b \cdot L \in \mathcal{K}_{0}^{n}$, is defined by the Wulff shape

$$
a \cdot K+_{p} b \cdot L=\left[\left(a h_{K}^{p}+b h_{L}^{p}\right)^{\frac{1}{p}}\right], \quad p \neq 0,
$$

and for $p=0$,

$$
a \cdot K+{ }_{0} b \cdot L=\left[h_{K}^{a} h_{L}^{b}\right] .
$$

The Wulff shape allows us to consider the case $a$ or $b$ is negative, with strictly positive $a h_{K}^{p}+b h_{L}^{p}$. The $L_{p}$ harmonic combination, $a \cdot K \hat{+}_{p} b \cdot L \in \mathcal{K}_{0}^{n}$, is defined by

$$
a \cdot K \hat{+}_{p} b \cdot L=\left(a \cdot K^{*}+_{p} b \cdot L^{*}\right)^{*} .
$$

If $\mu$ is a fixed non-zero finite Borel measure on $\mathbb{S}^{n-1}$, then we define

$$
\begin{equation*}
\|f: \mu\|_{p}=\left(\frac{1}{|\mu|} \int_{\mathbb{S}^{n-1}} f^{p} d \mu\right)^{\frac{1}{p}}, \quad p \neq 0 \tag{2.10}
\end{equation*}
$$

and

$$
\begin{equation*}
\|f: \mu\|_{0}=\exp \left(\frac{1}{|\mu|} \int_{\mathbb{S}^{n-1}} \log f d \mu\right), \quad \forall f \in C^{+}\left(\mathbb{S}^{n-1}\right) \tag{2.11}
\end{equation*}
$$

For any $x_{0} \in \mathbb{S}^{n-1}$ and $0<\delta<1, \omega_{\delta}\left(x_{0}\right)$ and $\omega_{\delta}^{\prime}\left(x_{0}\right)$ are defined by

$$
\begin{gather*}
\omega_{\delta}\left(x_{0}\right)=\left\{u \in \mathbb{S}^{n-1}:\left\langle u, x_{0}\right\rangle \geq \delta\right\}  \tag{2.12}\\
\omega_{\delta}^{\prime}\left(x_{0}\right)=\left\{u \in \mathbb{S}^{n-1}:\left|\left\langle u, x_{0}\right\rangle\right| \geq \delta\right\} . \tag{2.13}
\end{gather*}
$$

It is obvious that

$$
\omega_{\delta}^{\prime}\left(x_{0}\right)=\omega_{\delta}\left(x_{0}\right) \cup \omega_{\delta}\left(-x_{0}\right)
$$

And $x_{0}^{\perp}$ denotes the hyperplane whose normal is $x_{0}$ and the origin $0 \in x_{0}^{\perp}$.
Definition 2.1. Suppose $K, L \in \mathcal{K}_{0}^{n}$, their Hausdorff metric is given by

$$
d(K, L)=\max \left\{\sup _{x \in K} \operatorname{dist}(x, L), \sup _{y \in L} \operatorname{dist}(K, y)\right\} .
$$

where $\operatorname{dist}(x, L)=\inf _{y \in L} \operatorname{dist}(x, y)$ and $\operatorname{dist}(x, y)$ is the distance of $x$ and $y$ in $\mathbb{R}^{n}$. We say $K_{i} \rightarrow K_{0}$, which means $d\left(K_{i}, K_{0}\right) \rightarrow 0$ as $i \rightarrow \infty$.

It is important to recall the following Lemma in [25].
Lemma 2.2. Suppose $0<\delta<1, K_{i}$ is a sequence of convex bodies in $\mathcal{K}_{0}^{n}$, and if for some $x_{0} \in \mathbb{S}^{n-1}$,

$$
\lim _{i \rightarrow \infty} h_{K_{i}}\left(x_{0}\right)=0
$$

then

$$
\lim _{i \rightarrow \infty} \rho_{K_{i}}(u)=0, \quad \forall u \in \omega_{\delta}\left(x_{0}\right)
$$

## 3. $L_{p}$ Gauss image problem

In this section, we review some of the standard facts on the radial Gauss map $\alpha_{K}$ and reverse radial Gauss map $\alpha_{K}^{*}$.

Suppose $K \in \mathcal{K}_{0}^{n}$ and $x \in \mathbb{S}^{n-1}$, the supporting hyperplane of $K$ in direction $x$ is given by

$$
H_{K}(x)=\left\{y \in \mathbb{R}^{n}:\langle x, y\rangle=h_{K}(x)\right\}
$$

and $x$ is called the normal vector of $K$ at $y$.
For $\sigma \subset \partial K$, the spherical image of $\sigma, \boldsymbol{\nu}_{K}(\sigma): \partial K \rightarrow \mathbb{S}^{n-1}$, is defined by

$$
\boldsymbol{\nu}_{K}(\sigma)=\left\{x \in \mathbb{S}^{n-1}: y \in H_{K}(x) \text { for some } y \in \sigma\right\}
$$

Let $\sigma_{K} \subset \partial K$ be the set consisting of $y \in \partial K$, for which the set $\boldsymbol{\nu}_{K}(\{y\})$ contains more than a single element. Define the spherical image map

$$
\nu_{K}: \partial K \backslash \sigma_{K} \rightarrow \mathbb{S}^{n-1}
$$

such that $\nu_{K}(y)$ is the unique element of $\boldsymbol{\nu}_{K}(\{y\})$.
For $\eta \subset \mathbb{S}^{n-1}$, the reverse spherical image of $\eta, \mathbf{y}_{K}(\eta): \mathbb{S}^{n-1} \rightarrow \partial K$, is defined by

$$
\mathbf{y}_{K}(\eta)=\left\{y \in \partial K: y \in H_{K}(x) \text { for some } x \in \eta\right\}
$$

The set $\eta_{K}$ is made up of $x \in \mathbb{S}^{n-1}$, for which the set $\mathbf{y}_{K}(\{x\})$ contains more than a single element. Define the reverse spherical image map

$$
y_{K}: \mathbb{S}^{n-1} \backslash \eta_{K} \rightarrow \partial K
$$

such that $y_{K}(x)$ is the unique element of $\mathbf{y}_{K}(\{x\})$. It is well known that $\mathcal{H}^{n-1}\left(\sigma_{K}\right)=$ $\mathcal{H}^{n-1}\left(\eta_{K}\right)=0$ and $\nu_{K}, y_{K}$ are continuous functions, the details can be found in 41].

Suppose $K \in \mathcal{K}_{0}^{n}$, the radial map of $K, r_{K}: \mathbb{S}^{n-1} \rightarrow \partial K$, is defined by

$$
r_{K}(u)=\rho_{K}(u) u
$$

its reverse map $r_{K}^{-1}: \partial K \rightarrow \mathbb{S}^{n-1}$ is given by

$$
r_{K}^{-1}(y)=\frac{y}{|y|}
$$

With the above preparation, we can define the radial Gauss image and reverse radial Gauss image. Specifically, let $\omega$ and $\eta$ be subsets of $\mathbb{S}^{n-1}$, the radial Gauss image of $\omega, \boldsymbol{\alpha}_{K}(\omega)$, is defined by

$$
\boldsymbol{\alpha}_{K}(\omega)=\left\{x \in \mathbb{S}^{n-1}: \rho_{K}(u) u \in H_{K}(x) \text { for some } u \in \omega\right\}
$$

and the reverse radial Gauss image of $\eta, \boldsymbol{\alpha}_{K}^{*}(\eta)$, is defined by

$$
\boldsymbol{\alpha}_{K}^{*}(\eta)=\left\{u \in \mathbb{S}^{n-1}: \rho_{K}(u) u \in H_{K}(x) \text { for some } x \in \eta\right\} .
$$

Assume $K \in \mathcal{K}_{0}^{n}$, the radial Gauss map of $K, \alpha_{K}: \mathbb{S}^{n-1} \backslash \omega_{K} \rightarrow \mathbb{S}^{n-1}$, is given by

$$
\alpha_{K}=\nu_{K}\left(r_{K}\right)
$$

where $\omega_{K}=r_{K}^{-1}\left(\sigma_{K}\right)$, and the reverse radial Gauss map of $K, \alpha_{K}^{*}: \mathbb{S}^{n-1} \backslash \eta_{K} \rightarrow \mathbb{S}^{n-1}$, is given by

$$
\alpha_{K}^{*}=r_{K}^{-1}\left(y_{K}\right)
$$

It was shown in [24] that the reverse radial Gauss image of $K$ and the radial Gauss image of $K^{*}$ are identical, that is

$$
\boldsymbol{\alpha}_{K^{*}}=\boldsymbol{\alpha}_{K}^{*}
$$

And the definitions of $\boldsymbol{\alpha}_{K}$ and $\boldsymbol{\alpha}_{K}^{*}$ yield that

$$
\boldsymbol{\alpha}_{t K}=\boldsymbol{\alpha}_{K}, \quad \boldsymbol{\alpha}_{t K}^{*}=\boldsymbol{\alpha}_{K}^{*}, \quad \forall t>0
$$

Recall the Gauss image measure $\lambda(K, \cdot)$ of $\lambda$ via $K$ is defined by

$$
\lambda(K, \omega)=\lambda\left(\boldsymbol{\alpha}_{K}(\omega)\right)
$$

When $\lambda$ is a Borel measure which is absolutely continuous with respect to the spherical Lebusgus measure, the Gauss image measure is a Borel measure. The integral representation of $\lambda(K, \cdot)$ can be found in 5].
Lemma 3.1. Assume $\lambda$ is a Borel measure which is absolutely continuous with respect to spherical Lebesgue measure and $K \in \mathcal{K}_{0}^{n}$, then

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}} f(u) d \lambda(K, u)=\int_{\mathbb{S}^{n-1}} f\left(\alpha_{K}^{*}(x)\right) d \lambda(x), \quad \forall f \in C\left(\mathbb{S}^{n-1}\right) \tag{3.1}
\end{equation*}
$$

Proof. Note that for any $\omega \subset \mathbb{S}^{n-1}$ and $x \in \mathbb{S}^{n-1} \backslash \omega_{K}$,

$$
\alpha_{K}^{*}(x) \in \omega \Leftrightarrow x \in \boldsymbol{\alpha}_{K}(\omega)
$$

which implies that

$$
\begin{equation*}
\chi_{\omega}\left(\alpha_{K}^{*}(x)\right)=\chi_{\boldsymbol{\alpha}_{K}(\omega)}(x) \tag{3.2}
\end{equation*}
$$

We first show (3.1) holds for simple function

$$
\varphi=\sum_{i} c_{i} \chi_{\omega_{i}}
$$

where $c_{i} \in \mathbb{R}$ and $\chi_{\omega_{i}}$ is the characteristic function of Borel subset $\omega_{i} \subset \mathbb{S}^{n-1}$.

Since $\lambda$ is absolutely continuous with respect to spherical Lebesgue measure, (3.2) shows that

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}} \chi_{\omega}\left(\alpha_{K}^{*}(x)\right) d \lambda(x)=\int_{\mathbb{S}^{n-1}} \chi_{\alpha_{K}(\omega)}(x) d \lambda(x) \tag{3.3}
\end{equation*}
$$

then (1.6) and (3.3) mean

$$
\begin{aligned}
\int_{\mathbb{S}^{n-1}} \varphi(u) d \lambda(K, u) & =\int_{\mathbb{S}^{n-1}} \sum_{i} c_{i} \chi_{\omega_{i}}(u) d \lambda(K, u) \\
& =\sum_{i} c_{i} \lambda\left(K, \omega_{i}\right) \\
& =\sum_{i} c_{i} \lambda\left(\boldsymbol{\alpha}_{K}\left(\omega_{i}\right)\right) \\
& =\int_{\mathbb{S}^{n-1}} \sum_{i} c_{i} \chi_{\boldsymbol{\alpha}_{K}\left(\omega_{i}\right)}(x) d \lambda(x) \\
& =\int_{\mathbb{S}^{n}-1} \sum_{i} c_{i} \chi_{\omega}\left(\alpha_{K}^{*}(x)\right) d \lambda(x) \\
& =\int_{\mathbb{S}^{n-1}} \varphi\left(\alpha_{K}^{*}(x)\right) d \lambda(x)
\end{aligned}
$$

Let $f: \mathbb{S}^{n-1} \rightarrow \mathbb{R}$ be a continuous function, then there exists a sequence of simple functions $\left\{\varphi_{k}\right\}$ such that $\varphi_{k} \rightarrow f$ as $k \rightarrow \infty$. By the dominated convergence theorem, it holds

$$
\int_{\mathbb{S}^{n-1}} f(u) d \lambda(K, u)=\int_{\mathbb{S}^{n-1}} f\left(\alpha_{K}^{*}(x)\right) d \lambda(x)
$$

This finishes the proof.
Inspired by [25], we define the $L_{p}$ Gauss image measure $\lambda_{p}(K, \cdot)$ of $K \in \mathcal{K}_{0}^{n}$ : fixed $p \in \mathbb{R}, \lambda_{p}(K, \cdot)$ is a Borel measure and satisfies

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}} f(u) d \lambda_{p}(K, u)=\int_{\mathbb{S}^{n-1}} f\left(\alpha_{K}^{*}(x)\right) \rho_{K}^{p}\left(\alpha_{K}^{*}(x)\right) d \lambda(x), \quad \forall f \in C\left(\mathbb{S}^{n-1}\right) \tag{3.4}
\end{equation*}
$$

By (3.1) and (3.4), it is easy to see

$$
d \lambda_{p}(K, \cdot)=\rho_{K}^{p} d \lambda(K, \cdot)
$$

It is worth to point out the Gauss image measure as a functional from $\mathcal{K}_{0}^{n}$ to the space of Borel measures on $\mathbb{S}^{n-1}$ is weakly convergent with respect to the Hausdorff metric, see Lemma 3.4 in [5].

Lemma 3.2. Assume $\lambda$ is a Borel measure which is absolutely continuous with respect to spherical Lebesgue measure, and $K_{0}, K_{1}, \cdots \in \mathcal{K}_{0}^{n}$ such that $K_{i} \rightarrow K_{0}$ as $i \rightarrow \infty$, then $\lambda\left(K_{i}, \cdot\right) \rightharpoonup \lambda\left(K_{0}, \cdot\right)$.

## 4. Variational formulas for entropy of convex bodies

In this section, variational formulas for the general entropy of convex bodies will be given. Recall the general entropy

$$
G(K)=-\int_{\mathbb{S}^{n}-1} \log h_{K}(x) d \lambda(x)
$$

and the dual general entropy, defined by

$$
\begin{equation*}
E(K)=\int_{\mathbb{S}^{n}-1} \log \rho_{K}(u) d \lambda(u) \tag{4.1}
\end{equation*}
$$

it is clear that for any $K \in \mathcal{K}_{0}^{n}$,

$$
\begin{equation*}
E\left(K^{*}\right)=G(K) \tag{4.2}
\end{equation*}
$$

As will be shown, the following Lemma in [24] turns out to be a critical property.
Lemma 4.1. Let $\Omega \subset \mathbb{S}^{n-1}$ be a closed set that is not contained in any closed hemisphere of $\mathbb{S}^{n-1}$. If $\rho_{t}$ is a logarithmic family of convex hulls of $\left\langle\rho_{0}, g, t\right\rangle$, then

$$
\lim _{t \rightarrow 0} \frac{\log h_{\left\langle\rho_{t}\right\rangle}(x)-\log h_{\left\langle\rho_{0}\right\rangle}(x)}{t}=g\left(\alpha_{\left\langle\rho_{0}\right\rangle}^{*}(x)\right), \quad \forall x \in \mathbb{S}^{n-1} \backslash \omega_{\left\langle\rho_{0}\right\rangle} .
$$

Furthermore, there exist $\delta>0$ and $M>0$, such that

$$
\left|\log h_{\left\langle\rho_{t}\right\rangle}(x)-\log h_{\left\langle\rho_{0}\right\rangle}(x)\right| \leq M|t|, \quad \forall(x, t) \in \mathbb{S}^{n-1} \times(-\delta, \delta)
$$

It is sufficient to make the following Lemma together with Lemma 3.1 and Lemma 4.1.

Lemma 4.2. Assume $\lambda$ is a Borel measure which is absolutely continuous with respect to spherical Lebesgue measure. Let $K \in \mathcal{K}_{0}^{n}$ and $f, g: \mathbb{S}^{n-1} \rightarrow \mathbb{R}$ be two continuous functions, if $\rho_{t}$ is given by (2.9), then

$$
\begin{equation*}
\left.\frac{d}{d t} G\left(\left\langle\rho_{t}\right\rangle\right)\right|_{t=0}=-\int_{\mathbb{S}^{n}-1} g(u) d \lambda(K, u) \tag{4.3}
\end{equation*}
$$

and if $h_{t}$ is given by (2.8), then

$$
\begin{equation*}
\left.\frac{d}{d t} E\left(\left[h_{t}\right]\right)\right|_{t=0}=\int_{\mathbb{S}^{n}-1} f(x) d \lambda\left(K^{*}, x\right) \tag{4.4}
\end{equation*}
$$

It remains to prove the variational formulas applying the Lemma 4.2 in this section.
Lemma 4.3. Assume $\lambda$ is a Borel measure which is absolutely continuous with respect to spherical Lebesgue measure and $K, L \in \mathcal{K}_{0}^{n}$. Thus for $p \neq 0$,

$$
\begin{equation*}
\left.\frac{d}{d t} G\left(K \hat{+}_{p} t \cdot L\right)\right|_{t=0}=\frac{1}{p} \int_{\mathbb{S}^{n-1}} \rho_{L}^{-p}(u) d \lambda_{p}(K, u), \tag{4.5}
\end{equation*}
$$

and for $p=0$,

$$
\begin{equation*}
\left.\frac{d}{d t} G\left(K \hat{+}_{0} t \cdot L\right)\right|_{t=0}=-\int_{\mathbb{S}^{n}-1} \log \rho_{L}(u) d \lambda(K, u) \tag{4.6}
\end{equation*}
$$

Proof. For $p \neq 0$, let

$$
h_{t}=\left(h_{K}^{p}+t h_{L}^{p}\right)^{\frac{1}{p}},
$$

and choose $\delta>0$ such that

$$
\log h_{t}=\log h_{K}+\frac{1}{p}\left(\frac{h_{L}}{h_{K}}\right)^{p} t+o_{p}(t, \cdot)
$$

where $o_{p}:(-\delta, \delta) \times \mathbb{S}^{n-1} \rightarrow \mathbb{R}$ is continuous and satisfies

$$
\lim _{t \rightarrow 0} \frac{o_{p}(t, x)}{t}=0, \quad \forall x \in \mathbb{S}^{n-1}
$$

Choosing

$$
f=\frac{1}{p}\left(\frac{h_{L}}{h_{K}}\right)^{p},
$$

we have

$$
K+_{p} t \cdot L=\left[h_{t}\right]=[K, f, t] .
$$

Then (4.4) amounts to the fact that

$$
\left.\frac{d}{d t} E\left(K+{ }_{p} t \cdot L\right)\right|_{t=0}=\frac{1}{p} \int_{\mathbb{S}^{n}-1}\left(\frac{h_{L}}{h_{K}}\right)^{p}(x) d \lambda\left(K^{*}, x\right)
$$

Replace $K, L$ by $K^{*}, L^{*}$ yields

$$
\begin{equation*}
\left.\frac{d}{d t} E\left(K^{*}+{ }_{p} t \cdot L^{*}\right)\right|_{t=0}=\frac{1}{p} \int_{\mathbb{S}^{n-1}}\left(\frac{h_{L^{*}}}{h_{K^{*}}}\right)^{p}(u) d \lambda\left(K^{* *}, u\right) \tag{4.7}
\end{equation*}
$$

Based on (2.4), (2.5) and (4.7), we can assert that

$$
\begin{equation*}
\left.\frac{d}{d t} E\left(K^{*}+{ }_{p} t \cdot L^{*}\right)\right|_{t=0}=\frac{1}{p} \int_{\mathbb{S}^{n-1}}\left(\frac{\rho_{K}}{\rho_{L}}\right)^{p}(u) d \lambda(K, u) \tag{4.8}
\end{equation*}
$$

Thus (4.5) can be obtained by (1.8), (4.2) and (4.8).
We now turn to the case $p=0$. Set $h_{t}=h_{K} h_{L}^{t}$, thus we get

$$
\log h_{t}=\log h_{K}+t \log h_{L} .
$$

Since the proof for the case $p=0$ is similar in spirit to the case $p \neq 0$, we omit the detials here.

## 5. Existence of solutions to the $L_{p}$ Gauss image problem

For given Borel measures $\lambda$ and $\mu$, and $p \neq 0$, define the functional $\Phi_{\lambda, \mu, p}$ : $C^{+}\left(\mathbb{S}^{n-1}\right) \rightarrow \mathbb{R}$, for any $f \in C^{+}\left(\mathbb{S}^{n-1}\right)$,

$$
\begin{align*}
\Phi_{\lambda, \mu, p}(f) & =-\frac{1}{|\lambda|} \int_{\mathbb{S}^{n-1}} \log h_{\langle f\rangle}(x) d \lambda(x)-\frac{1}{p} \log \left(\frac{1}{|\mu|} \int_{\mathbb{S}^{n-1}} f^{-p}(u) d \mu(u)\right)  \tag{5.1}\\
& =G(\langle f\rangle) /|\lambda|+\log | | f:\left.\mu\right|_{-p} .
\end{align*}
$$

It is easy to check that $\Phi_{\lambda, \mu, p}(f)$ is homogeneous of degree 0 , that is

$$
\begin{equation*}
\Phi_{\lambda, \mu, p}(t f)=\Phi_{\lambda, \mu, p}(f), \quad \forall t>0, f \in C^{+}\left(\mathbb{S}^{n-1}\right) \tag{5.2}
\end{equation*}
$$

The maximization problem is:

$$
\begin{equation*}
\sup \left\{\Phi_{\lambda, \mu, p}(f): f \in C^{+}\left(\mathbb{S}^{n-1}\right)\right\} \tag{5.3}
\end{equation*}
$$

The following Lemma shows that the solution of maximization problem (5.3) must be radial function of a convex body $K$.

Lemma 5.1. Suppose $p \neq 0$, then a convex body $K \in \mathcal{K}_{0}^{n}$ is a solution of the maximization problem

$$
\sup \left\{\Phi_{\lambda, \mu, p}\left(\rho_{K}\right): K \in \mathcal{K}_{0}^{n}\right\}
$$

if and only if $\rho_{K}$ is a solution of the maximization problem

$$
\sup \left\{\Phi_{\lambda, \mu, p}(f): f \in C^{+}\left(\mathbb{S}^{n-1}\right)\right\} .
$$

Proof. The convex hull is given by

$$
\langle f\rangle=\operatorname{conv}\left\{f(u) u: u \in \mathbb{S}^{n-1}\right\}, \quad \forall f \in C^{+}\left(\mathbb{S}^{n-1}\right)
$$

then it is easily seen that

$$
\rho_{\langle f\rangle} \geq f
$$

which implies that

$$
\begin{equation*}
\left\|\rho_{\langle f\rangle}: \mu\right\|_{-p} \geq\|f: \mu\|_{-p} . \tag{5.4}
\end{equation*}
$$

By (2.7), that is

$$
\left\langle\rho_{\langle f\rangle}\right\rangle=\langle f\rangle,
$$

hence

$$
\begin{equation*}
G\left(\left\langle\rho_{\langle f\rangle}\right\rangle\right)=G(\langle f\rangle) . \tag{5.5}
\end{equation*}
$$

Applying (5.4) and (5.5) we conclude that

$$
\Phi_{\lambda, \mu, p}(f) \leq \Phi_{\lambda, \mu, p}\left(\rho_{\langle f\rangle}\right)
$$

We have divided the proof into a sequence of Lemmas.

### 5.1. The proof of Theorem 1.2.

In this subsection, we deal with the case $p>0$.
Lemma 5.2. Under the assumptions of Theorem 1.2. there exists a convex body $K_{0} \in \mathcal{K}_{0}^{n}$ such that

$$
\sup \left\{\Phi_{\lambda, \mu, p}\left(\rho_{K}\right): K \in \mathcal{K}_{0}^{n}\right\}=\Phi_{\lambda, \mu, p}\left(\rho_{K_{0}}\right)
$$

Proof. Let

$$
\mathcal{K}=\left\{K \in \mathcal{K}_{0}^{n}: \int_{\mathbb{S}^{n-1}} h_{K}^{p} d \mu=|\lambda|\right\} .
$$

Define the function $\varphi: \mathbb{S}^{n-1} \rightarrow \mathbb{R}$, for $x \in \mathbb{S}^{n-1}$,

$$
\varphi(x)=\int_{\mathbb{S}^{n}-1}(\langle x, u\rangle)_{+}^{p} d \mu(u)
$$

Assume $\varphi$ attains its minimum at some vectors $x_{\mu}$, thus

$$
\int_{\mathbb{S}^{n-1}}(\langle x, u\rangle)_{+}^{p} d \mu(u) \geq \int_{\mathbb{S}^{n}-1}\left(\left\langle x_{\mu}, u\right\rangle\right)_{+}^{p} d \mu(u)>0
$$

the strict inequality holds because $\mu$ is not concentrated in any closed hemisphere of $\mathbb{S}^{n-1}$.

Now we claim that $\mathcal{K}$ is bounded. In fact, for any $K \in \mathcal{K}$. Assume $\rho_{K}$ attains its maximum at some $x_{K} \in \mathbb{S}^{n-1}$, by the definition of the support function, it is clear that

$$
\rho_{K}\left(x_{K}\right)\left(\left\langle x_{K}, u\right\rangle\right)_{+} \leq h_{K}(u), \quad \forall u \in \mathbb{S}^{n-1}
$$

Then

$$
\rho_{K}^{p}\left(x_{K}\right) \int_{\mathbb{S}^{n}-1}\left(\left\langle x_{K}, u\right\rangle\right)_{+}^{p} d \mu(u) \leq \int_{\mathbb{S}^{n-1}} h_{K}^{p}(u) d \mu(u)=|\lambda|,
$$

which implies that

$$
\rho_{K}\left(x_{K}\right) \leq|\lambda|^{\frac{1}{p}}\left(\int_{\mathbb{S}^{n-1}}\left(\left\langle x_{\mu}, u\right\rangle\right)_{+}^{p} d \mu(u)\right)^{-\frac{1}{p}}=c(\lambda, \mu, p)
$$

Therefore, $\mathcal{K}$ is bounded.
By (5.2), $\Phi_{\lambda, \mu, p}\left(\rho_{K}\right)$ is homogeneous of degree 0 , it is feasible to choose a maximizing sequence $K_{i}$ for $\Phi_{\lambda, \mu, p}\left(\rho_{K}\right)$ such that $K_{i}^{*} \in \mathcal{K}$. By Blaskchke selection theorem, the sequence $K_{i}^{*}$ has a subsequence, still denoted by $K_{i}^{*}$, such that $K_{i}^{*} \rightarrow K_{0}^{*}$ for some $K_{0}^{*}$.

We prove $K_{0}^{*} \in \mathcal{K}_{0}^{n}$ by contradiction. Or we can assume $K_{0}^{*} \subset u_{0}^{\perp}$ for some $u_{0} \in \mathbb{S}^{n-1}$, then

$$
\lim _{i \rightarrow \infty} h_{K_{i}^{*}}\left(u_{0}\right)=h_{K_{0}^{*}}\left(u_{0}\right)=0 .
$$

By Lemma 2.2, there exists $0<\delta<1$ such that

$$
\begin{equation*}
\lim _{i \rightarrow \infty} \rho_{K_{i}^{*}}(x) \rightarrow 0, \quad \forall x \in \omega_{\delta}\left(u_{0}\right) \tag{5.6}
\end{equation*}
$$

Then

$$
\begin{align*}
G\left(K_{i}\right) & =E\left(K_{i}^{*}\right)  \tag{5.7}\\
& =\int_{\mathbb{S}^{n-1}} \log \rho_{K_{i}^{*}}(x) d \lambda(x) \\
& \leq \int_{\omega_{\delta}\left(u_{0}\right)} \log \rho_{K_{i}^{*}}(x) d \lambda(x)+\int_{\mathbb{S}^{n-1} \backslash \omega_{\delta}\left(u_{0}\right)} \log c(\lambda, \mu, p) d \lambda(x) \\
& \leq \int_{\omega_{\delta}\left(u_{0}\right)} \log \rho_{K_{i}^{*}}(x) d \lambda(x)+\log c(\lambda, \mu, p) \lambda\left(\mathbb{S}^{n-1} \backslash \omega_{\delta}\left(u_{0}\right)\right)
\end{align*}
$$

From (5.6), (5.7) and the condition $\lambda\left(\omega_{\delta}\left(u_{0}\right)\right)$ is positive, it follows that

$$
G\left(K_{i}\right) \rightarrow-\infty \quad \text { as } \quad i \rightarrow \infty
$$

thus

$$
\Phi_{\lambda, \mu, p}\left(\rho_{K_{i}}\right) \rightarrow-\infty \quad \text { as } \quad i \rightarrow \infty .
$$

But it is easy to know that for $r=(|\lambda| /|\mu|)^{\frac{1}{p}}, r B \in \mathcal{K}$, and

$$
\Phi_{\lambda, \mu, p}\left(K_{i}\right)>\Phi_{\lambda, \mu, p}(r B)=\Phi_{\lambda, \mu, p}(B)=0,
$$

which is a contradiction. Then $K_{0}^{*} \in \mathcal{K}_{0}^{n}$, the proof is complete.
Lemma 5.3. Under the assumptions of Theorem 1.2, if $K$ is a solution of the maximization problem

$$
\begin{equation*}
\sup \left\{\Phi_{\lambda, \mu, p}\left(\rho_{K}\right): K \in \mathcal{K}_{0}^{n}\right\} \tag{5.8}
\end{equation*}
$$

under the restriction

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}} \rho_{K}^{-p} d \mu=|\lambda| \tag{5.9}
\end{equation*}
$$

then

$$
\mu=\lambda_{p}(K, \cdot) .
$$

Proof. By Lemma 5.1 and $K$ is a maximizer of (5.8),

$$
\Phi_{\lambda, \mu, p}\left(\rho_{K}\right)=\sup \left\{\Phi_{\lambda, \mu, p}\left(\rho_{L}\right): L \in \mathcal{K}_{0}^{n}\right\}=\sup \left\{\Phi_{\lambda, \mu, p}(f): f \in C^{+}\left(\mathbb{S}^{n-1}\right)\right\} .
$$

Define

$$
\begin{equation*}
\rho_{t}=\rho_{K} e^{t g}, \quad \forall g \in C^{+}\left(\mathbb{S}^{n-1}\right) \tag{5.10}
\end{equation*}
$$

then $t=0$ must be the maximum point of $\Phi_{\lambda, \mu, p}\left(\rho_{t}\right)$, that is

$$
\begin{equation*}
\left.\frac{d}{d t} \Phi_{\lambda, \mu, p}\left(\rho_{t}\right)\right|_{t=0}=0 \tag{5.11}
\end{equation*}
$$

By (5.10),

$$
\log \rho_{t}=\log \rho_{K}+t g
$$

then Lemma 4.2 shows that

$$
\begin{equation*}
\left.\frac{d}{d t} G\left(\left\langle\rho_{t}\right\rangle\right)\right|_{t=0}=-\int_{\mathbb{S}^{n-1}} g(u) d \lambda(K, u) \tag{5.12}
\end{equation*}
$$

For $|s|<1$, the inequality

$$
\begin{equation*}
\left|e^{s}-1-s\right| \leq e s^{2} \tag{5.13}
\end{equation*}
$$

holds. Choosing $s=-p t g(u)$, (5.13) shows that for $|t|<\frac{1}{|p| \max _{u \in \mathrm{~s}^{n-1}} g(u)}$,

$$
\left|e^{-p t g(u)}-1+p t g(u)\right| \leq e p^{2} g^{2}(u)|t|^{2}, \quad \forall u \in \mathbb{S}^{n-1}
$$

which implies

$$
\left|\frac{e^{-t p g(u)}-1}{t}+p g(u)\right| \leq e p^{2} g^{2}(u)|t|, \quad \forall u \in \mathbb{S}^{n-1}
$$

Then

$$
\lim _{t \rightarrow 0} \frac{\rho_{t}^{-p}(u)-\rho_{0}^{-p}(u)}{t}=\lim _{t \rightarrow 0} \frac{e^{-t p g(u)}-1}{t} \rho_{K}^{-p}(u)=-p g(u) \rho_{K}^{-p}(u), \quad \forall u \in \mathbb{S}^{n-1}
$$

By (5.9), we get

$$
\begin{align*}
|\lambda| \frac{d}{d t} \log \left|\left|\rho_{t}: \mu\right|_{-p}\right|_{t=0} & =\left.\int_{\mathbb{S}^{n-1}} \rho_{K}^{-p}(u) d \mu(u) \cdot \frac{d}{d t} \log \left\|\rho_{t}: \mu\right\|_{-p}\right|_{t=0}  \tag{5.14}\\
& =-\frac{1}{p} \int_{\mathbb{S}^{n-1}} \lim _{t \rightarrow 0} \frac{\rho_{t}^{-p}(u)-\rho_{0}^{-p}(u)}{t} d \mu(u) \\
& =\int_{\mathbb{S}^{n-1}} \rho_{K}^{-p}(u) g(u) d \mu(u)
\end{align*}
$$

Therefore, (5.11), (5.12), (5.14) and the definition of $\Phi_{\lambda, \mu, p}$ show that

$$
\int_{\mathbb{S}^{n}-1} \rho_{K}^{-p}(u) g(u) d \mu(u)=\int_{\mathbb{S}^{n-1}} g(u) d \lambda(K, u) .
$$

Thus $\rho_{K}(u)^{-p} d \mu(u)=d \lambda(K, u)$, which completes the proof in view of (1.8).
The proof of Theorem 1.2, By Lemma 5.2 , there exists a convex body $K_{0} \in \mathcal{K}_{0}^{n}$ such that

$$
\sup \left\{\Phi_{\lambda, \mu, p}\left(\rho_{K}\right): K \in \mathcal{K}_{0}^{n}\right\}=\Phi_{\lambda, \mu, p}\left(\rho_{K_{0}}\right)
$$

By Lemma 5.3, $K_{0}$ satisfies that

$$
\mu=\lambda_{p}\left(K_{0}, \cdot\right)
$$

### 5.2. The proof of Theorem 1.3.

This subsection is intended to provide a detailed proof of Theorem 1.3.
Lemma 5.4. Under the assumptions of Theorem 1.3, there exists an origin-symmetric convex body $K_{0}$ such that

$$
\sup \left\{\Phi_{\lambda, \mu, p}\left(\rho_{K}\right): K \in \mathcal{K}_{e}^{n}\right\}=\Phi_{\lambda, \mu, p}\left(\rho_{K_{0}}\right)
$$

Proof. Let

$$
\mathcal{K}=\left\{K \in \mathcal{K}_{e}^{n}: \int_{\mathbb{S}^{n-1}} \log h_{K}(x) d \lambda(x)=0\right\}
$$

Since $\Phi_{\lambda, \mu, p}$ is homogeneous of degree 0 , the maximization problem is equivalent to

$$
\sup \left\{\log \left\|\rho_{K}: \mu\right\|_{-p}: K \in \mathcal{K}\right\}
$$

Now we claim that $\mathcal{K}$ is bounded. In fact, for any $K \in \mathcal{K}$. Assume $\rho_{K}$ attains its maximum at some $u_{K} \in \mathbb{S}^{n-1}$, by the definition of the support function and $K \in \mathcal{K}_{e}^{n}$, it is clear that

$$
\rho_{K}\left(u_{K}\right)\left|\left\langle u_{K}, x\right\rangle\right| \leq h_{K}(x), \quad \forall x \in \mathbb{S}^{n-1}
$$

which implies

$$
\rho_{K}\left(u_{K}\right)|\lambda|+\int_{\mathbb{S}^{n-1}} \log \left|\left\langle u_{K}, x\right\rangle\right| d \lambda(x) \leq \int_{\mathbb{S}^{n-1}} \log h_{K}(x) d \lambda(x)=0 .
$$

Then

$$
\rho_{K}\left(u_{K}\right) \leq-|\lambda|^{-1} \int_{\mathbb{S}^{n}-1} \log \left|\left\langle u_{K}, x\right\rangle\right| d \lambda(x)=R
$$

Therefore, $\mathcal{K}$ is bounded.
By (5.2), $\Phi_{\lambda, \mu, p}\left(\rho_{K}\right)$ is homogeneous of degree 0 , it is feasible to choose a maximizing sequence $K_{i}$ for $\Phi_{\lambda, \mu, p}\left(\rho_{K}\right)$ such that $K_{i} \in \mathcal{K}$. By Blaskchke selection theorem, the sequence $K_{i}$ has a subsequence, still denoted by $K_{i}$, such that $K_{i} \rightarrow K_{0}$ for some $K_{0}$.

We prove $K_{0} \in \mathcal{K}_{e}^{n}$ by contradiction. Otherwise, assume $K_{0} \subset x_{0}^{\perp}$ for some $x_{0} \in$ $\mathbb{S}^{n-1}$, then

$$
\lim _{i \rightarrow \infty} h_{K_{i}}\left(x_{0}\right)=h_{K_{0}}\left(x_{0}\right)=0 .
$$

By Lemma 2.2, there exists $0<\delta<1$ such that

$$
\lim _{i \rightarrow \infty} \rho_{K_{i}}(u) \rightarrow 0, \quad \forall u \in \omega_{\delta}^{\prime}\left(x_{0}\right)
$$

Therefore,

$$
\begin{aligned}
\int_{\mathbb{S}^{n-1}} \rho_{K_{i}}^{-p}(u) d \mu(u) & =\int_{\omega_{\delta}^{\prime}\left(x_{0}\right)} \rho_{K_{i}}^{-p}(u) d \mu(u)+\int_{\mathbb{S}^{n-1} \backslash \omega_{\delta}^{\prime}\left(x_{0}\right)} \rho_{K_{i}}^{-p}(u) d \mu(u) \\
& \leq \int_{\omega_{\delta}^{\prime}\left(x_{0}\right)} \rho_{K_{i}}^{-p}(u) d \mu(u)+R^{-p} \mu\left(\mathbb{S}^{n-1} \backslash \omega_{\delta}^{\prime}\left(x_{0}\right)\right)
\end{aligned}
$$

Since $\mu$ vanishes on any great sub-sphere of $\mathbb{S}^{n-1}$, then $\mu\left(\mathbb{S}^{n-1} \cap x_{0}^{\perp}\right)=0$. Choose $1>\delta_{1}>\delta_{2}>\cdots>\delta_{j} \rightarrow 0$, it is clear that

$$
\mathbb{S}^{n-1} \backslash \omega_{\delta_{1}}^{\prime}\left(x_{0}\right) \supset \mathbb{S}^{n-1} \backslash \omega_{\delta_{2}}^{\prime}\left(x_{0}\right) \supset \cdots
$$

with

$$
\bigcap_{j=1}^{\infty}\left(\mathbb{S}^{n-1} \backslash \omega_{\delta_{j}}^{\prime}\left(x_{0}\right)\right)=\mathbb{S}^{n-1} \cap x_{0}^{\perp}
$$

Therefore

$$
\lim _{j \rightarrow \infty} \mu\left(\mathbb{S}^{n-1} \backslash \omega_{\delta_{j}}^{\prime}\left(x_{0}\right)\right)=\mu\left(\mathbb{S}^{n-1} \cap x_{0}^{\perp}\right)=0
$$

For any given $\epsilon>0$, there exists a positive integer $j_{0}$, such that

$$
R^{-p} \mu\left(\mathbb{S}^{n-1} \backslash \omega_{\delta_{j_{0}}}^{\prime}\left(x_{0}\right)\right)<\frac{\epsilon}{2}
$$

Since $\rho_{K_{i}} \rightarrow 0$ uniformly on $\omega_{\delta_{j_{0}}}^{\prime}\left(x_{0}\right)$ and $\mu$ is a finite measure, there exists a positive integer $N$, such that

$$
\int_{\omega_{\delta_{j_{0}}}^{\prime}\left(x_{0}\right)} \rho_{K_{i}}^{-p}(u) d \mu(u)<\frac{\epsilon}{2}, \quad \forall i>N
$$

Therefore,

$$
\int_{\mathbb{S}^{n-1}} \rho_{K_{i}}^{-p}(u) d \mu(u) \rightarrow 0 \quad \text { as } \quad i \rightarrow \infty
$$

So

$$
\Phi_{\lambda, \mu, p}\left(\rho_{K_{i}}\right)=\log \left\|\rho_{K_{i}}: \mu\right\|_{-p} \rightarrow-\infty \quad \text { as } \quad i \rightarrow \infty
$$

But $K_{i}$ is a maximizing sequence for $\Phi_{\lambda, \mu, p}$, then for sufficiently large $i$, one can see

$$
\Phi_{\lambda, \mu, p}\left(\rho_{K_{i}}\right)>\Phi_{\lambda, \mu, p}\left(\rho_{B}\right)=0
$$

That is a contradiction. Then $K \in \mathcal{K}_{e}^{n}$, the proof is complete.
Lemma 5.5. Under the assumptions of Theorem 1.3, if $K$ is a solution of the maximization problem

$$
\sup \left\{\Phi_{\lambda, \mu, p}\left(\rho_{K}\right): K \in \mathcal{K}_{e}^{n}\right\}
$$

under the restriction

$$
\int_{\mathbb{S}^{n-1}} \rho_{K}^{-p} d \mu=|\lambda|
$$

then

$$
\mu=\lambda_{p}(K, \cdot)
$$

Proof. The proof of this Lemma is the same as that of Lemma 5.3.

The proof of Theorem 1.3. By Lemma 5.4, there exists a convex body $K_{0} \in \mathcal{K}_{e}^{n}$ such that

$$
\sup \left\{\Phi_{\lambda, \mu, p}\left(\rho_{K}\right): K \in \mathcal{K}_{e}^{n}\right\}=\Phi_{\lambda, \mu, p}\left(\rho_{K_{0}}\right) .
$$

By Lemma 5.5, $K_{0}$ satisfies that

$$
\mu=\lambda_{p}\left(K_{0}, \cdot\right)
$$
